Asymptotic analysis of a linear isotropic elastic composite reinforced by a thin layer of periodically distributed isotropic parallel stiff fibres.

Abstract We present some mathematical convergence results using a two-scale method for a linear elastic isotropic medium containing one layer of parallel periodically distributed heterogeneities located in the interior of the whole domain around a plane surface Σ . The aim of this paper is to study the situation when the rigidity of the linearly isotropic elastic fibres is $1/\varepsilon^m$ the rigidity of the surrounding linearly isotropic elastic material. We use a two-scale convergence method adapted to the geometry of the problem (layer of fibres). In the models obtained Σ behaves for $m = 1$ as a "material surface" without membrane energy in the direction of the plane orthogonal to the direction of the fibres. For $m = 3$ the "material surface" has no bending energy in the direction orthogonal to the fibres.

1 Introduction

Due to its importance for many applied problems, the study of boundary value problems where the domain and/or the coefficients have a large number of heterogeneities has attracted the interest of many researchers of the mathematical, of the physical and of the engineering communities. Hence the corresponding literature is huge. When the heterogeneities (inclusions, holes, layers, fibres) are periodically

distributed in *all the volume* (the ratio between a characteristic size of the period and a characteristic size of the whole structure being traditionally denoted ε) and (still with respect to the whole structure) the characteristic size of the heterogeneities is a power of ε , in order to obtain numerically efficient (i.e. precise and not too much computationally expensive) simplified models, it is now classical to use an homogenization method. An advantage of the homogenization methods is that they have been developed and fully mathematically justified for many different geometrical and/or mechanical situations (in particular when also the ratio between the mechanical characteristics of the heterogeneities and of the surrounding material can depend on ε), see, e.g., [10], [32], [21], [30], [31], [7], [16], and also [14,27,33] in the context of nonlinear elasticity.

Another situation of interest for the engineering community arises when there exists *only one layer* of heterogeneity located in the interior of the whole domain. This is for instance the situation when two bodies of different (or equal) nature are pasted together using *an homogeneous thin layer* "centred" around a surface Σ and whose transversal depth has a ratio to the whole structure generally denoted ε . In this case many numerically efficient simplified models have been constructed and mathematically fully justified for various mechanical and /or geometrical circumstances; see, e.g., [17], [20], [11], [13], and also [14,27,33] in the context of nonlinear elasticity.

Still another situation arises when *the heterogeneities are periodically distributed in a thin layer* "centred" around a surface Σ . In some cases of inclusions one can use matched asymptotic expansion methods (see, e.g., [29], [1], [26], ...). The aim of this paper is to study the situation when the heterogeneities in the layer "centred" around a surface Σ are linearly elastic isotropic *parallel* fibres periodically distributed and whose rigidity is higher with respect of the rigidity of the surrounding linearly elastic material.

In Section 2 we describe the problem and we state the main results; in Section 3 we introduce the notion of two-scale convergence with respect to a family of measures m_ε essentially connected with the total volume of the fibres. This is a variant of the two-scale convergence introduced by Nguetseng [28] and developed by G. Allaire in [2]. In Section 4 we prove the a priori estimates and we identify the limits obtained with the two-scale method; these results are fundamental for the proof of the weak convergence (Section 5.1) and the strong convergence (Section 5.2).

Notations. In the sequel, $\{\mathbf{e}_1, \mathbf{e}_2, \mathbf{e}_3\}$ stands for the canonical basis of \mathbb{R}^3 . Points in \mathbb{R}^3 or in \mathbb{Z}^3 and real-valued functions are represented by symbols beginning by a light-face minuscule (example $x, i, \det \mathbf{A} \dots$), vectors and vector-valued functions by symbols beginning by a boldface minuscule (examples: $\mathbf{x}, \mathbf{x}_S, \mathbf{i}, \mathbf{u}, \mathbf{f}, \mathbf{g}, \operatorname{div} \Psi, \dots$). Matrices and matrix-valued functions are represented by symbols beginning by a capital boldface with the following exceptions: $\nabla \mathbf{u}$ (displacement gradient), $\mathbf{e}(\mathbf{u})$ (linearised strain tensor). We denote by u_i or $(\mathbf{u})_i$ the components of a vector \mathbf{u} and by A_{ij} or $(\mathbf{A})_{ij}$ those of a matrix \mathbf{A} (that is $\mathbf{u} = \sum_{i=1}^3 u_i \mathbf{e}_i = \sum_{i=1}^3 (\mathbf{u})_i \mathbf{e}_i$; $\mathbf{A} = \sum_{i,j=1}^3 A_{ij} \mathbf{e}_i \otimes \mathbf{e}_j = \sum_{i,j=1}^3 (\mathbf{A})_{ij} \mathbf{e}_i \otimes \mathbf{e}_j$). ${}^t \mathbf{A}$ denotes the transposed matrix of \mathbf{A} . We do not employ the usual repeated index convention for summation. We denote by $\mathbf{A}:\mathbf{B} = \sum_{i,j=1}^3 A_{ij} B_{ij}$ the inner product of two matrices, by \mathbb{S}^N the set of all real symmetric matrices of order N , and by \mathbf{I}_N the $N \times N$ identity matrix. The symbols \mathcal{L}^N and \mathcal{H}^k represent, respectively, the Lebesgue outer measure on \mathbb{R}^N and the k -dimensional Hausdorff outer measure on \mathbb{R}^N . For any $x = (x_1, x_2, x_3) \in \mathbb{R}^3$, we set $x' = (x_1, x_2)$. Given an open subset A of \mathbb{R}^2 we note $\int_A \mathbf{f} dy$ the mean value of \mathbf{f} on A . Given an open subset Ω of \mathbb{R}^3 and a 2-dimensional Lipschitz sub-manifold Σ of $\overline{\Omega}$, the trace on Σ of an element φ of $H^1(\Omega; \mathbb{R}^k)$ is denoted by $\gamma_\Sigma(\varphi)$ (resp. $\gamma_\Sigma(\varphi)$ if $k=1$), or occasionally by the same symbol φ when ambiguity is not possible. If A is a subset of Ω , the symbol $\mathbb{1}_A$ represents the characteristic function of A . The letter C denotes different constants whose precise values may vary.

2 Description of the problem and statement of the result

Let $\Omega := (-L, L)^3$, let S be a bounded Lipschitz domain of \mathbb{R}^2 satisfying

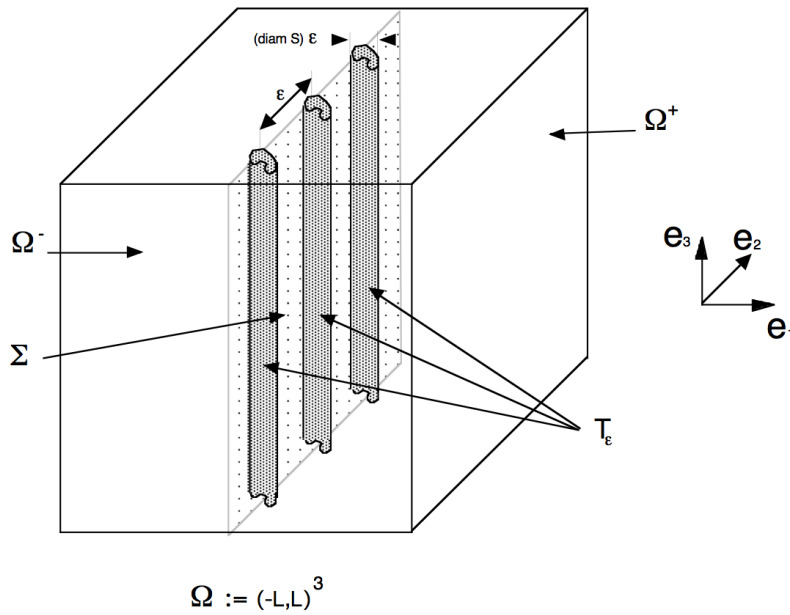


Fig. 1 The layer of fibres

$$D \subset S \subset \overline{S} \subset Y, \quad Y := \left(-\frac{1}{2}, \frac{1}{2}\right)^2, \quad \int_S \mathbf{y} dy = 0, \quad (1)$$

for some open disk D of \mathbb{R}^2 centred at the origin and let $T := S \times (-L, L)$. For $\varepsilon > 0$ we set (see fig. 1):

$$\begin{aligned} Y_\varepsilon^i &:= \varepsilon((0, i) + Y), & I_\varepsilon &:= \{i \in \mathbb{Z}, Y_\varepsilon^i \times (-L, L) \subset \Omega\} \\ S_\varepsilon^i &:= \varepsilon((0, i) + S), & T_\varepsilon^i &= S_\varepsilon^i \times (-L, L), & T_\varepsilon &= \bigcup_{i \in I_\varepsilon} T_\varepsilon^i, \end{aligned} \quad (2)$$

$$i^{\min} := \min I_\varepsilon, \quad i^{\max} := \max I_\varepsilon,$$

$$\Sigma := \Omega \cap \{0\} \times \mathbb{R}^2, \quad \Sigma^\varepsilon := \Sigma \cap T_\varepsilon = \left\{x \in \Sigma, \quad \varepsilon i^{\min} - \frac{\varepsilon}{2} < x_2 < \varepsilon i^{\max} + \frac{\varepsilon}{2}\right\}, \quad (3)$$

$$\Omega^- := \Omega \cap ((-\infty, 0) \times \mathbb{R}^2), \quad \Omega^+ := \Omega \cap ((0, +\infty) \times \mathbb{R}^2).$$

Let us remark that

$$\mathcal{L}^3(T_\varepsilon) \simeq \varepsilon |S| |\Sigma| \quad \text{as } \varepsilon \rightarrow 0, \quad (4)$$

where, for simplicity, $|S|$ (resp. $|\Sigma|$) denotes the area, that is the two-dimensional Hausdorff measure of S (resp. Σ). Hence from a geometrical point of view there are two natural length scales: the first is a global one (i.e. the 3D-diameter of Ω) the other one is a local one connected with the heterogeneities (the diameter of the cross section of every fiber). The ratio between these two scales will be denoted by ε . More precisely, the parameter ε is a non-dimensional parameter characterizing the geometrical distribution of the heterogeneities in the structure since, at the same time, it characterizes the ratio between the diameter of the cross section of the fibres and the diameter of Ω and the ratio between the diameter of the cross section of the fibres and the length in the transversal direction \mathbf{e}_2 of the planar set Σ supporting the heterogeneities.

We consider the case of a linear isotropic elastic structure occupying the set Ω reinforced by the linear isotropic elastic parallel fibres T_ε^i of very high stiffness surrounded by a matrix of constant stiffness. More precisely we assume that the Young's modulus E_ε depends on ε as follows :

$$\begin{cases} E_\varepsilon(x) = \frac{1}{\varepsilon^m} E_T & \text{if } x \in T_\varepsilon, \\ E_\varepsilon(x) = E & \text{if } x \in \Omega \setminus T_\varepsilon, \end{cases} \quad (5)$$

with $m > 0$. Instead the Poisson's coefficient denoted by ν_ε is independent from ε :

$$\begin{cases} \nu_\varepsilon(x) = \nu_1 & \text{if } x \in T_\varepsilon, \\ \nu_\varepsilon(x) = \nu & \text{if } x \in \Omega \setminus T_\varepsilon. \end{cases} \quad (6)$$

We also assume that they satisfy the usual conditions $E, E_T > 0$ and $0 < \nu, \nu_1 < \frac{1}{2}$. Let us stress that, with this choice, the parameter ε characterizes at the same time the geometrical distribution of the heterogeneities in the structure and the ratio between the rigidity of the heterogeneities and the rigidity

of the structure. We are concerned with the behaviour for $\varepsilon \rightarrow 0$ of the following elasticity problem where we have taken for simplicity homogeneous Dirichlet boundary data:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_\varepsilon = \mathbf{f} & \text{in } \Omega, \\ \mathbf{u}_\varepsilon \in H_0^1(\Omega; \mathbb{R}^3), \quad \mathbf{f} \in L^2(\Omega; \mathbb{R}^3), \\ \boldsymbol{\sigma}_\varepsilon = \frac{E_\varepsilon}{1+\nu_\varepsilon} \left(\frac{\nu_\varepsilon}{1-2\nu_\varepsilon} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right), \quad \mathbf{e}(\mathbf{u}_\varepsilon) = \frac{1}{2}(\nabla\mathbf{u}_\varepsilon + {}^t\nabla\mathbf{u}_\varepsilon). \end{cases} \quad (7)$$

The limit problem we derive in Theorem 1 depends on the value of m .

Case 0 < m < 1. The limit problem reads:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_0 = \mathbf{f} & \text{in } \Omega, \\ \boldsymbol{\sigma}_0 = \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right), \\ \mathbf{u} \in \mathcal{D}_m, \end{cases} \quad (8)$$

where

$$\mathcal{D}_m = H_0^1(\Omega; \mathbb{R}^3). \quad (9)$$

Case $m = 1$. The limit problem reads:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_0 = \mathbf{f} & \text{in } \Omega^+ \cup \Omega^-, \\ \boldsymbol{\sigma}_0 = \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right), \\ (\boldsymbol{\sigma}_0^+ - \boldsymbol{\sigma}_0^-)\mathbf{e}_1 + |S|E_T \frac{\partial^2 \gamma_\Sigma(u_3)}{\partial x_3^2} \mathbf{e}_3 = 0 & \text{on } \Sigma, \\ \mathbf{u} \in \mathcal{D}_1, \end{cases} \quad (10)$$

where $\boldsymbol{\sigma}_0^-$ (resp. $\boldsymbol{\sigma}_0^+$) denotes the restriction of $\boldsymbol{\sigma}_0$ to Ω^- (resp. Ω^+) and

$$\mathcal{D}_1 = \left\{ \mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3); \frac{\partial \gamma_\Sigma(u_3)}{\partial x_3} \in L^2(\Sigma), \quad \gamma_\Sigma(u_3) = 0 \text{ on } \partial\Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L; L\}\} \right\}. \quad (11)$$

Note that the effective superficial density of forces exerted by the fibres on the matrix along Σ , given by

$$(\boldsymbol{\sigma}_0^+ - \boldsymbol{\sigma}_0^-)\mathbf{e}_1 = -|S|E_T \frac{\partial^2 \gamma_\Sigma(u_3)}{\partial x_3^2} \mathbf{e}_3,$$

is parallel to the fibres.

Case 1 < m < 3. The limit problem reads:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_0 = \mathbf{f} & \text{in } \Omega^+ \cup \Omega^-, \\ \boldsymbol{\sigma}_0 = \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right), \\ \mathbf{u} \in \mathcal{D}_m, \end{cases} \quad (12)$$

where

$$\mathcal{D}_m = \{ \mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3); \quad \gamma_\Sigma(u_3) = 0 \}. \quad (13)$$

Case $m = 3$. The limit problem reads:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_0 = \mathbf{f} & \text{in } \Omega^+ \cup \Omega^-, \\ \boldsymbol{\sigma}_0 = \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right), \\ (\boldsymbol{\sigma}_0^- - \boldsymbol{\sigma}_0^+) \mathbf{e}_1 + |S|E_T \sum_{\alpha,\beta=1}^2 J_{\alpha\beta} \frac{\partial^4 \gamma_\Sigma(u_\beta)}{\partial x_3^4} \mathbf{e}_\alpha = 0 & \text{on } \Sigma, \\ \mathbf{u} \in \mathcal{D}_3, \end{cases} \quad (14)$$

where

$$J_{\alpha\beta} := \int_S y_\alpha y_\beta dy, \quad (15)$$

and

$$\mathcal{D}_3 = \left\{ \mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3); \begin{cases} \gamma_\Sigma(u_3) = 0, \quad \frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2}, \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2} \in L^2(\Sigma), \\ \gamma_\Sigma(u_\alpha) = \frac{\partial \gamma_\Sigma(u_\alpha)}{\partial x_3} = 0 \text{ on } \Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L; L\}\} \quad \forall \alpha \in \{1, 2\} \end{cases} \right\}. \quad (16)$$

Unlike the case $m = 1$, the effective superficial density of forces exerted by the fibres on the matrix along Σ , given by

$$\mathbf{h} = (\boldsymbol{\sigma}_0^+ - \boldsymbol{\sigma}_0^-) \mathbf{e}_1 = |S|E_T \sum_{\alpha,\beta=1}^2 J_{\alpha\beta} \frac{\partial^4 \gamma_\Sigma(u_\beta)}{\partial x_3^4} \mathbf{e}_\alpha,$$

is orthogonal to the direction of the fibres.

Case $m > 3$. The limit problem reads:

$$\begin{cases} -\operatorname{div}\boldsymbol{\sigma}_0 = \mathbf{f} & \text{in } \Omega^+ \cup \Omega^-, \\ \boldsymbol{\sigma}_0 = \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right), \\ \mathbf{u} \in \mathcal{D}_m, \end{cases} \quad (17)$$

where

$$\mathcal{D}_m = \{ \mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3); \quad \boldsymbol{\gamma}_\Sigma(\mathbf{u}) = 0 \}. \quad (18)$$

Theorem 1 *Assume (5) and (6), then for $\varepsilon \rightarrow 0$ the solution \mathbf{u}_ε of (7) strongly converges in $H_0^1(\Omega; \mathbb{R}^3)$ to the unique solution \mathbf{u} of (8) if $0 < m < 1$, of (10) if $m = 1$, of (12) if $1 < m < 3$, of (14) if $m = 3$, and of (17) if $m > 3$.*

Remark 1 For every $m > 0$ the limit problem does not depend on the value ν_1 of the Poisson's coefficient of the material of the fibres.

The problem (7) has a unique solution \mathbf{u}_ε that realizes the minimum in $H_0^1(\Omega, \mathbb{R}^3)$ of the functional

$$\mathcal{F}_{\varepsilon,m}(\mathbf{v}) := \frac{1}{2} a_{\varepsilon,m}(\mathbf{v}, \mathbf{v}) - \int_\Omega \mathbf{f} \cdot \mathbf{v} dx,$$

with

$$\frac{1}{2} a_{\varepsilon,m}(\mathbf{v}, \mathbf{v}) := \frac{1}{2} a_\varepsilon(\mathbf{v}, \mathbf{v}) + \frac{1}{2\varepsilon^m} a_{\varepsilon,T}(\mathbf{v}, \mathbf{v}), \quad (19)$$

where $a_\varepsilon(\cdot, \cdot)$ and $a_{\varepsilon, T}(\cdot, \cdot)$ are the symmetric bilinear forms on $H_0^1(\Omega, \mathbb{R}^3) \times H_0^1(\Omega, \mathbb{R}^3)$ given by :

$$\begin{aligned} a_\varepsilon(\mathbf{v}, \boldsymbol{\phi}) &= \int_{\Omega \setminus T_\varepsilon} \left\{ \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{v})) \mathbf{I} + \mathbf{e}(\mathbf{v}) \right) : \mathbf{e}(\boldsymbol{\phi}) \right\} dx, \\ a_{\varepsilon, T}(\mathbf{v}, \boldsymbol{\phi}) &= \int_{T_\varepsilon} \left\{ \frac{E_T}{1+\nu_1} \left(\frac{\nu_1}{1-2\nu_1} \operatorname{tr}(\mathbf{e}(\mathbf{v})) \mathbf{I} + \mathbf{e}(\mathbf{v}) \right) : \mathbf{e}(\boldsymbol{\phi}) \right\} dx. \end{aligned} \quad (20)$$

Let us point out that the limit problems have a unique solution $\mathbf{u} \in \mathcal{D}_m$ that realizes the minimum in \mathcal{D}_m of the functional \mathcal{F}_m defined on \mathcal{D}_m by

$$\mathcal{F}_m(\mathbf{v}) := \frac{1}{2} a_m(\mathbf{v}, \mathbf{v}) - \int_{\Omega} \mathbf{f} \cdot \mathbf{v}, \quad (21)$$

where $a_m(\cdot, \cdot)$ is the bilinear form on $\mathcal{D}_m \times \mathcal{D}_m$ given by:

$$\begin{aligned} a_0(\mathbf{v}, \boldsymbol{\phi}) &:= \int_{\Omega} \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{v})) \mathbf{I} + \mathbf{e}(\mathbf{v}) \right) : \mathbf{e}(\boldsymbol{\phi}) dx, \\ a_1(\mathbf{v}, \boldsymbol{\phi}) &:= a_0(\mathbf{v}, \boldsymbol{\phi}) + |S| E_T \int_{\Sigma} \frac{\partial \gamma_{\Sigma}(v_3)}{\partial x_3} \frac{\partial \gamma_{\Sigma}(\phi_3)}{\partial x_3} d\mathcal{H}^2, \\ a_3(\mathbf{v}, \boldsymbol{\phi}) &:= a_0(\mathbf{v}, \boldsymbol{\phi}) + |S| E_T \sum_{\alpha, \beta=1}^2 \int_{\Sigma} J_{\alpha\beta} \frac{\partial^2 \gamma_{\Sigma}(v_\alpha)}{\partial x_3^2} \frac{\partial^2 \gamma_{\Sigma}(\phi_\beta)}{\partial x_3^2} d\mathcal{H}^2(x), \\ a_m(\mathbf{v}, \boldsymbol{\phi}) &:= a_0(\mathbf{v}, \boldsymbol{\phi}) \quad \text{if } m \in (0, +\infty) \setminus \{1; 3\}. \end{aligned} \quad (22)$$

The proof of Theorem 1 is structured as follows:

- i) In Sect.3, we introduce a two-scale convergence method adapted to the particular geometry of our problem (layer of fibres) and we prove some useful properties of this method.
- ii) In Sect.4, we study the behaviour when $\varepsilon \rightarrow 0$ of the solution (\mathbf{u}_ε) of (7). The most delicate task resides in the study of the behaviour of (\mathbf{u}_ε) in the fibres and here we use the properties of the two-scale method introduced in Sect.3
- iii) In Sect.5.1, we multiply (7) by an appropriate sequence of oscillating test fields $(\boldsymbol{\phi}_\varepsilon)$ and, by passing to the limit as $\varepsilon \rightarrow 0$ in accordance with the convergences established in ii), we obtain a variational formulation of the limit problem satisfied by \mathbf{u} .
- iv) We prove in Sect.5.2 the strong convergence using the linearity of the problem.

3 Two-scale convergence with respect to (m_ε)

As a mean to particularize the oscillatory behaviour of the displacement in the fibres, we consider a variant of the two-scale convergence introduced by G. Nguetseng in [28]. This seminal idea has been further developed by G. Allaire in [2] (see also a more general presentation in [22]) and extended in various ways (e.g. for the two-scale convergence with respect to a sequence of measures see [8], [23], [36],...). Here the two-scale convergence is adapted to the geometry of the problem i.e. that the heterogeneities are a layer of fibres.

Let us at first introduce the following shortened notation for \mathbb{R} -valued functions of $L^1(\Omega)$ (the analogous notation will also be used for \mathbb{R}^k -valued functions):

$$\int f(x) dm_\varepsilon := \frac{1}{\varepsilon |S|} \int_{T_\varepsilon} f(x_1, x_2, x_3) dx_1 dx_2 dx_3 = \frac{1}{\varepsilon |S|} \sum_{i \in I_\varepsilon} \int_{-L}^L dx_3 \int_{S_\varepsilon^i} f(x_1, x_2, x_3) dx_1 dx_2, \quad (23)$$

where $|S|$ denotes the two-dimensional Lebesgue measure of S . Notice that by (4) there holds

$$\int dm_\varepsilon \simeq |S|. \quad (24)$$

In the study of the behaviour when $\varepsilon \rightarrow 0$ of the solution (\mathbf{u}_ε) of (7) a delicate task resides in the study of the behaviour of the fibres. For this we use the operator $\mathbf{v}_\varepsilon : L^2(\Omega) \rightarrow L^2(\Omega)$ defined by

$$\mathbf{v}_\varepsilon(\varphi)(x) := \sum_{i \in I_\varepsilon} \left(\int_{S_\varepsilon^i} \varphi(s, x_3) d\mathcal{H}^2(s) \right) \mathbb{1}_{Y_\varepsilon^i}(x_1, x_2) \quad (25)$$

(in the case of \mathbb{R}^k -valued functions the analogous definition will be used). We also define the \mathbb{R}^2 -valued function (see (2))

$$y_\varepsilon(x') = y_\varepsilon(x_1, x_2) := \sum_{i \in I_\varepsilon} (x_1 \mathbf{e}_1 + (x_2 - \varepsilon i) \mathbf{e}_2) \mathbb{1}_{Y_\varepsilon^i}(x_1, x_2). \quad (26)$$

A sequence (\mathbf{f}_ε) in $L^2(\Omega; \mathbb{R}^k)$ will be said *to two-scale converge with respect to (m_ε) to some $\mathbf{f}_0 \in L^2(\Sigma \times S; \mathbb{R}^k)$* (notation: $\mathbf{f}_\varepsilon \xrightarrow{m_\varepsilon} \mathbf{f}_0$) if for all $\boldsymbol{\psi} \in C(\overline{\Omega \times S}; \mathbb{R}^k)$

$$\lim_{\varepsilon \rightarrow 0} \int \mathbf{f}_\varepsilon(x) \cdot \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon(x) = \frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0(x_2, x_3; y_1, y_2) \cdot \boldsymbol{\psi}(0, x_2, x_3; y_1, y_2) d\mathcal{H}^2(x) dy, \quad (27)$$

where $y_\varepsilon(x')$ is given by (26) and $|S|$ denotes the two-dimensional Lebesgue measure of S . Similar notions have been considered in [8], [23], [36]. As shown in the next proposition, the two-scale convergence with respect to (m_ε) enjoys a compactness property for sequences satisfying an uniform bound of the type $\sup_{\varepsilon > 0} \int |\mathbf{f}_\varepsilon|^2 dm_\varepsilon \leq C$.

Proposition 1 (i) *There holds*

$$\lim_{\varepsilon \rightarrow 0} \int \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon(x) = \frac{1}{|S|} \int_{\Sigma \times S} \boldsymbol{\psi}(x, y) d\mathcal{H}^2(x) dy \quad \forall \boldsymbol{\psi} \in C(\overline{\Omega \times S}; \mathbb{R}^k). \quad (28)$$

(ii) *Let (\mathbf{f}_ε) be a sequence in $L^2(\Omega; \mathbb{R}^k)$ such that $\sup_{\varepsilon > 0} \int |\mathbf{f}_\varepsilon|^2 dm_\varepsilon < +\infty$. Then, the sequence (\mathbf{f}_ε) two-scale converges with respect to (m_ε) , up to a subsequence, to some $\mathbf{f}_0 \in L^2(\Sigma \times S; \mathbb{R}^k)$.*

(iii) *Let (\mathbf{f}_ε) be a sequence in $L^2(\Omega; \mathbb{R}^k)$ such that $\sup_{\varepsilon > 0} \int |\mathbf{f}_\varepsilon|^2 dm_\varepsilon < +\infty$ and that (\mathbf{f}_ε) two-scale converges with respect to (m_ε) to $\mathbf{f}_0 \in L^2(\Sigma \times S; \mathbb{R}^k)$. Then:*

- the sequence $(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))$ two-scale converges with respect to (m_ε) to $\frac{1}{|S|} \int_S \mathbf{f}_0(x, y) dy$;*
- the sequence of traces $(\boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)))$ is well defined and weakly converges in $L^2(\Sigma; \mathbb{R}^k)$ to $\frac{1}{|S|} \int_S \mathbf{f}_0(x, y) dy$;*
- if \mathbf{f}_ε takes constant values for a.e. $x_3 \in (-L, L)$ on each set $Y_\varepsilon^i \times \{x_3\}$, and vanishes elsewhere, then the sequence of traces $(\boldsymbol{\gamma}_\Sigma(\mathbf{f}_\varepsilon))$ is well defined, $\mathbf{f}_\varepsilon = \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)$, $\mathbf{f}_0(x, y) = \int_S \mathbf{f}_0(x, y') dy'$ a.e. on $\Sigma \times S$, and $(\boldsymbol{\gamma}_\Sigma(\mathbf{f}_\varepsilon))$ weakly converges in $L^2(\Sigma; \mathbb{R}^k)$, up to a subsequence, to $\frac{1}{|S|} \int_S \mathbf{f}_0(x, y) dy$.*

Proof.¹ In analogy to [3, 27, 33, 35] (and in the spirit of the periodic unfolding method [15]), denoting by $[s]$ the integer part of a real s , we define the transformation $S_\varepsilon : \Sigma^\varepsilon \times S \rightarrow T_\varepsilon$ as follows

$$S_\varepsilon(x, y) := (\varepsilon y_1, \varepsilon[x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3). \quad (29)$$

For arbitrary $f \in L^1(T_\varepsilon)$ the function $(f \circ S_\varepsilon)(x, y) \in L^1(\Sigma^\varepsilon \times S)$. Its extension by zero to $\Sigma \times S$ will be indicated $f_\varepsilon \circ S_\varepsilon \mathbb{1}_{\Sigma^\varepsilon \times S}$ or simply $(f \circ S_\varepsilon)$ when there are no ambiguities. By the following isometry property

$$\int f dm_\varepsilon := \frac{1}{\varepsilon |S|} \int_{T_\varepsilon} f dx = \frac{1}{|S|} \int_{\Sigma^\varepsilon \times S} (f \circ S_\varepsilon)(x, y) d\mathcal{H}^2(x) dy, \quad (30)$$

any sequence $f_\varepsilon \in L^2(T_\varepsilon)$ with $\sup_{\varepsilon > 0} \int |f_\varepsilon|^2 dm_\varepsilon < +\infty$ yields a subsequence with

$$f_\varepsilon \circ S_\varepsilon \mathbb{1}_{\Sigma^\varepsilon \times S} \rightharpoonup f_0 \quad \text{weakly in } L^2(\Sigma \times S). \quad (31)$$

If $\psi \in C(\overline{\Omega} \times \overline{S})$ and $\psi_\varepsilon(x) := \psi\left(x, \frac{y_\varepsilon(x')}{\varepsilon}\right)$ then

$$\psi_\varepsilon \circ S_\varepsilon \mathbb{1}_{\Sigma^\varepsilon \times S}(x, y) = \psi(\varepsilon y_1, \varepsilon[x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3, y) \mathbb{1}_{\Sigma^\varepsilon \times S}(x, y) \quad (32)$$

is uniformly bounded in $\Sigma \times S$ and converges uniformly to ψ on $\Sigma^{\varepsilon_0} \times S$ for each fixed $\varepsilon_0 > 0$, therefore, since $\mathcal{H}^2(\Sigma \setminus \Sigma^\varepsilon) \rightarrow 0$,

$$\psi_\varepsilon \circ S_\varepsilon \mathbb{1}_{\Sigma^\varepsilon \times S} \rightarrow \psi \quad \text{strongly in } L^p(\Sigma \times S), \quad \forall p \in [1, +\infty[. \quad (33)$$

Assertion (i) (resp. (ii)) follows from (30) and (33) (resp. (30), (31) and (33)). Moreover, the combination of (30), (31) and (33) shows that

$$\left[\mathbf{f}_\varepsilon \xrightarrow{m_\varepsilon} \mathbf{f}_0 \right] \Leftrightarrow \left[\mathbf{f}_\varepsilon \circ S_\varepsilon \mathbb{1}_{\Sigma^\varepsilon \times S} \rightharpoonup \mathbf{f}_0 \quad \text{weakly in } L^2(\Sigma \times S) \right]. \quad (34)$$

In order to prove the assertions (iii) we note at first that

$$\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(x) \mathbb{1}_{T_\varepsilon}(x) = \left(\frac{1}{|S|} \int_S \mathbf{f}_\varepsilon(\varepsilon y_1, \varepsilon[x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3) dy \right) \mathbb{1}_{T_\varepsilon}(x),$$

and we deduce from (30) and (32) that

$$\int \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(x) \cdot \boldsymbol{\psi}\left(x, \frac{y_\varepsilon(x')}{\varepsilon}\right) dm_\varepsilon = \frac{1}{|S|} \int_{\Sigma^\varepsilon \times S} \mathbf{f}_\varepsilon(\varepsilon y_1, [x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3) \tilde{\boldsymbol{\psi}}_\varepsilon(x) d\mathcal{H}^2(x) dy, \quad (35)$$

where $\tilde{\boldsymbol{\psi}}_\varepsilon(x) := \frac{1}{|S|} \int_S \boldsymbol{\psi}(\varepsilon y_1, \varepsilon[x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3, y) dy$. By the uniform continuity of $\boldsymbol{\psi}$, we have

$$\begin{aligned} \left| \tilde{\boldsymbol{\psi}}_\varepsilon(x) - \bar{\boldsymbol{\psi}}(\varepsilon y_1, [x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3) \right| \mathbb{1}_{\Sigma^\varepsilon \times S} &\leq C\varepsilon, \\ \bar{\boldsymbol{\psi}}(x) &:= \frac{1}{|S|} \int_S \boldsymbol{\psi}(x, y) d\mathcal{H}^2(y). \end{aligned} \quad (36)$$

Testing the two-scale convergence with respect to (m_ε) of (\mathbf{f}_ε) to \mathbf{f}_0 with the test function $\bar{\boldsymbol{\psi}}(x)$, taking (34) into account, we infer from (35) and (36) that

$$\begin{aligned} &\lim_{\varepsilon \rightarrow 0} \int \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(x) \cdot \boldsymbol{\psi}\left(x, \frac{y_\varepsilon(x')}{\varepsilon}\right) dm_\varepsilon \\ &= \lim_{\varepsilon \rightarrow 0} \frac{1}{|S|} \int_{\Sigma^\varepsilon \times S} \mathbf{f}_\varepsilon(\varepsilon y_1, [x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3) \bar{\boldsymbol{\psi}}(\varepsilon y_1, [x_2/\varepsilon + 1/2] + \varepsilon y_2, x_3) dy d\mathcal{H}^2(x) \\ &= \frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0(x, y) \cdot \bar{\boldsymbol{\psi}}(x) d\mathcal{H}^2(x) dy = \frac{1}{|S|} \int_{\Sigma \times S} \left(\frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0(x, y) d\mathcal{H}^2(y) \right) \cdot \boldsymbol{\psi}(x, y) d\mathcal{H}^2(x) dy. \end{aligned} \quad (37)$$

Assertion (iii) a) is proved. For each $(x_2, x_3) \in \Sigma$ the mapping $x_1 \rightarrow \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(x_1, x_2, x_3)$ is constant on the set $(-\varepsilon, \varepsilon) \times (x_2, x_3)$, and so in particular equal to $\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(0, x_2, x_3)$. Hence the field $\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)(0, x_2, x_3)$ is a well defined element of $L^2(\Sigma; \mathbb{R}^k)$ which will also be denoted by $\boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))$, using for simplicity the same notation as for the trace operator from $H^1(\Omega; \mathbb{R}^k)$ to $L^2(\Sigma; \mathbb{R}^k)$. One can easily check that $\int_\Sigma |\boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))|^2 d\mathcal{H}^2 = \int |\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)|^2 dm_\varepsilon \leq \int |\mathbf{f}_\varepsilon|^2 dm_\varepsilon$, hence $\boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))$ is bounded in $L^2(\Sigma; \mathbb{R}^k)$. Given $\boldsymbol{\varphi} \in C(\overline{\Omega}; \mathbb{R}^k)$, a straightforward computation yields

$$\int_\Sigma \boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \boldsymbol{\varphi}(0, x_2, x_3) d\mathcal{H}^2 = \int \mathbf{f}_\varepsilon \cdot \widehat{\boldsymbol{\varphi}}_\varepsilon dm_\varepsilon, \quad \widehat{\boldsymbol{\varphi}}_\varepsilon(x) := \sum_{i \in I_\varepsilon} \left(\int_{\varepsilon i - \frac{\varepsilon}{2}}^{\varepsilon i + \frac{\varepsilon}{2}} \boldsymbol{\varphi}(0, t, x_3) dt \right) \mathbb{1}_{S_\varepsilon^i}(x'). \quad (38)$$

Noticing that, by the uniform continuity of $\boldsymbol{\varphi}$ on $\overline{\Omega}$, there holds $\sup_{x \in T_\varepsilon} |\boldsymbol{\varphi}(x) - \widehat{\boldsymbol{\varphi}}_\varepsilon(x)| \leq C\varepsilon$, we deduce from the two-scale convergence with respect to (m_ε) of (\mathbf{f}_ε) to \mathbf{f}_0 that

$$\begin{aligned} \lim_{\varepsilon \rightarrow 0} \int_\Sigma \boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \boldsymbol{\varphi}(x) d\mathcal{H}^2 &= \lim_{\varepsilon \rightarrow 0} \int \mathbf{f}_\varepsilon \cdot \boldsymbol{\varphi} dm_\varepsilon = \frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0(x, y) \boldsymbol{\varphi}(x) d\mathcal{H}^2(x) dy \\ &= \int_\Sigma \left(\int_S \mathbf{f}_0(x, y) dy \right) \cdot \boldsymbol{\varphi} d\mathcal{H}^2. \end{aligned}$$

Assertion (iii) b) is proved. The proof of Assertion (iii) c) is straightforward. \square

The next proposition states a lower semicontinuity property related to the two-scale convergence with respect to (m_ε) when dealing with convex integrands.

Proposition 2 *Let (\mathbf{f}_ε) be a sequence in $L^2(\Omega; \mathbb{R}^k)$ such that (\mathbf{f}_ε) two-scale converges to \mathbf{f}_0 with respect to (m_ε) , and let $j : \mathbb{R}^k \rightarrow \mathbb{R}$ be a convex function. Then*

$$\liminf_{\varepsilon \rightarrow 0} \int j(\mathbf{f}_\varepsilon) dm_\varepsilon \geq \frac{1}{|S|} \int_{\Sigma \times S} j(\mathbf{f}_0) d\mathcal{H}^2 \otimes d\mathcal{L}^2. \quad (39)$$

Proof. Let us fix $\boldsymbol{\psi} \in C(\overline{\Omega \times S}; \mathbb{R}^k)$. Denoting by j^* the Fenchel transform of j , by applying Fenchel inequality and then (28) to the function $j^*(\boldsymbol{\psi}) \in C(\overline{\Omega \times S})$, we get

$$\begin{aligned} \liminf_{\varepsilon \rightarrow 0} \int j(\mathbf{f}_\varepsilon) dm_\varepsilon(x) &\geq \lim_{\varepsilon \rightarrow 0} \int \mathbf{f}_\varepsilon \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) - j^* \left(\boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) dm_\varepsilon(x) \\ &= \frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0 \boldsymbol{\psi} - j^*(\boldsymbol{\psi}) d\mathcal{H}^2(x) dy. \end{aligned} \quad (40)$$

Taking the supremum of the right-hand side of (40) when $\boldsymbol{\psi}$ varies in $C(\overline{\Omega \times S}; \mathbb{R}^k)$, using a classical localization argument and the convexity assumption on j , we get

$$\begin{aligned} \liminf_{\varepsilon \rightarrow 0} \int j(\mathbf{f}_\varepsilon) dm_\varepsilon(x) &\geq \sup_{\boldsymbol{\psi} \in C(\overline{\Omega \times S}; \mathbb{R}^k)} \frac{1}{|S|} \int_{\Sigma \times S} \mathbf{f}_0 \boldsymbol{\psi} - j^*(\boldsymbol{\psi}) d\mathcal{H}^2(x) dy \\ &= \frac{1}{|S|} \int_{\Sigma \times S} \sup_{\boldsymbol{\psi} \in \mathbb{R}^k} \{ \mathbf{f}_0 \boldsymbol{\psi} - j^*(\boldsymbol{\psi}) \} d\mathcal{H}^2(x) dy \\ &= \frac{1}{|S|} \int_{\Sigma \times S} j^{**}(\mathbf{f}_0) d\mathcal{H}^2(x) dy = \frac{1}{|S|} \int_{\Sigma \times S} j(\mathbf{f}_0) d\mathcal{H}^2(x) dy. \end{aligned} \quad \square$$

The estimates established in the next lemma will be employed to study the link between the two-scale limit with respect to (m_ε) of a bounded sequence in $H^1(\Omega; \mathbb{R}^k)$ and the strong limit of its traces in $L^2(\Sigma; \mathbb{R}^k)$. Also, they will take a crucial part in the proof of the apriori estimates established in Proposition 4. In what follows, for each $\boldsymbol{\varphi} \in H^1(\Omega; \mathbb{R}^3)$, we denote by $\widehat{\boldsymbol{\varphi}}$ and $\overline{\boldsymbol{\varphi}}_\varepsilon$ the elements of $H^1(\Omega; \mathbb{R}^3)$ defined by

$$\begin{aligned} \overline{\boldsymbol{\varphi}}_\varepsilon(x) &:= \int_{(-\frac{\varepsilon}{2}, \frac{\varepsilon}{2})} \boldsymbol{\varphi}(s_1, x_2, x_3) ds_1, \\ \widehat{\boldsymbol{\varphi}}(x) &:= \boldsymbol{\varphi}(0, x_2, x_3). \end{aligned} \quad (41)$$

Lemma 1 *There exists a constant C such that, for all $\boldsymbol{\varphi} \in H^1(\Omega; \mathbb{R}^3)$, see (3),*

$$\begin{aligned} \int_{\Sigma_\varepsilon} |\boldsymbol{\gamma}_\Sigma(\mathbf{v}_\varepsilon(\boldsymbol{\varphi})) - \boldsymbol{\gamma}_\Sigma(\boldsymbol{\varphi})|^2 d\mathcal{H}^2 &\leq C\varepsilon \int_{-\varepsilon/2}^{\varepsilon/2} \int_\Sigma |\nabla \boldsymbol{\varphi}|^2 dx, \\ \int |\boldsymbol{\varphi} - \mathbf{v}_\varepsilon(\boldsymbol{\varphi})|^2 dm_\varepsilon &\leq C\varepsilon^2 \int |\nabla \boldsymbol{\varphi}|^2 dm_\varepsilon, \\ \int |\boldsymbol{\varphi} - \widehat{\boldsymbol{\varphi}}|^2 dm_\varepsilon &\leq C\varepsilon \int_{\Sigma_\varepsilon} |\nabla \boldsymbol{\varphi}|^2 dx, \end{aligned} \quad (42)$$

and

$$\begin{aligned} \int |\widehat{\boldsymbol{\varphi}}|^2 dm_\varepsilon &\leq C \int_\Sigma |\boldsymbol{\gamma}_\Sigma(\boldsymbol{\varphi})|^2 d\mathcal{H}^2, \\ \int_\Sigma \left| \frac{\partial \boldsymbol{\gamma}_\Sigma(\mathbf{v}_{\varepsilon 3}(\boldsymbol{\varphi}))}{\partial x_3} \right|^2 d\mathcal{H}^2 &\leq C \int |\mathbf{e}(\boldsymbol{\varphi})|^2 dm_\varepsilon. \end{aligned} \quad (43)$$

Moreover for all $\varphi \in L^2(\Omega; \mathbb{R}^3)$ and $k \in \{1, 2, 3\}$

$$\int_{\Sigma} |\gamma_{\Sigma}(\mathbf{v}_{\varepsilon k}(\varphi))|^2 d\mathcal{H}^2 = \int |\mathbf{v}_{\varepsilon k}(\varphi)|^2 dm_{\varepsilon}. \quad (44)$$

Proof. We use the following estimate, whose proof is postponed to the end:

$$\int_{\frac{-1}{2}}^{\frac{1}{2}} \left| \int_S \psi ds - \psi(0, y_2) \right|^2 dy_2 \leq C \int_Y |\nabla \psi|^2 dy_1 dy_2 \quad \forall \psi \in H^1(Y; \mathbb{R}^3). \quad (45)$$

By making suitable changes of variables in (45), we infer that for all $i \in I_{\varepsilon}$, there holds

$$\int_{\varepsilon(i-1/2)}^{\varepsilon(i+1/2)} \left| \int_{S_{\varepsilon}^i} \psi ds - \psi(0, x_2) \right|^2 dx_2 \leq C\varepsilon \int_{Y_{\varepsilon}^i} |\nabla \psi|^2 dx_1 dx_2 \quad \forall \psi \in H^1(Y_{\varepsilon}^i; \mathbb{R}^3). \quad (46)$$

Fixing $\varphi \in H^1(\Omega; \mathbb{R}^3)$ and applying (46) for a.e. $x_3 \in (-L, L)$ to $\psi(x_1, x_2) := \varphi(x_1, x_2, x_3)$, then integrating with respect to x_3 over $(-L, L)$ and summing over $i \in I_{\varepsilon}$, we infer

$$\int_{\Sigma_{\varepsilon}} |\gamma_{\Sigma}(\mathbf{v}_{\varepsilon}(\varphi)) - \gamma_{\Sigma}(\varphi)|^2 d\mathcal{H}^2 \leq C\varepsilon \int_{-\varepsilon/2}^{\varepsilon/2} \int_{\Sigma} |\nabla \varphi|^2 dx.$$

The proof of the first line of (42) is achieved.

Let us prove the second line of (42). By making suitable changes of variables in the classical Poincaré-Wirtinger inequality

$$\int_S \left| \psi - \int_S \psi \right|^2 dy \leq C \int_S |\nabla \psi|^2 dy \quad \forall \psi \in H^1(S; \mathbb{R}^2),$$

we infer

$$\int_{S_{\varepsilon}^i} \left| \psi - \int_{S_{\varepsilon}^i} \psi \right|^2 dx' \leq C\varepsilon^2 \int_{S_{\varepsilon}^i} |\nabla \psi|^2 dx' \quad \forall i \in I_{\varepsilon}, \forall \psi \in H^1(S_{\varepsilon}^i; \mathbb{R}^2). \quad (47)$$

By applying (47) for a.e. $x_3 \in (-L, L)$ to $\psi(x_1, x_2) = \varphi(x_1, x_2, x_3)$, integrating with respect to x_3 over $(-L, L)$ and summing with respect to i over I_{ε} , we deduce the second line of (42).

By Jensen's inequality we have

$$\begin{aligned} \int |\varphi - \widehat{\varphi}|^2 dm_{\varepsilon} &\leq \frac{C}{\varepsilon} \int_{\Sigma_{\varepsilon}} |\varphi - \widehat{\varphi}|^2 dx \leq \frac{C}{\varepsilon} \int_{(-\frac{\varepsilon}{2}, \frac{\varepsilon}{2})} dx_1 \int_{\Sigma} |\varphi(x_1, x_2, x_3) - \varphi(0, x_2, x_3)|^2 dx_2 dx_3 \\ &\leq \int_{\Sigma} \left| \int_{(-\frac{\varepsilon}{2}, \frac{\varepsilon}{2})} \left| \frac{\partial \varphi}{\partial x_1}(t_1, x_2, x_3) \right| dt_1 \right|^2 dx_2 dx_3 \\ &\leq C\varepsilon \int_{\Sigma_{\varepsilon}} |\nabla \varphi|^2 dx, \end{aligned}$$

which proves the third line of (42).

By (25) and Jensen's inequality, there holds

$$\begin{aligned}
\int_{\Sigma} \left| \frac{\partial \gamma_{\Sigma}(\mathbf{v}_{\varepsilon 3}(\boldsymbol{\varphi}))}{\partial x_3} \right|^2 d\mathcal{H}^2 &= \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \int_{\varepsilon(i-\frac{1}{2})}^{\varepsilon(i+\frac{1}{2})} dx_2 \left| \int_{S_{\varepsilon}^i} \frac{\partial \varphi_3}{\partial x_3}(s_1, s_2, x_3) ds_1 ds_2 \right|^2 \\
&\leq \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \int_{\varepsilon(i-\frac{1}{2})}^{\varepsilon(i+\frac{1}{2})} dx_2 \int_{S_{\varepsilon}^i} \left| \frac{\partial \varphi_3}{\partial x_3} \right|^2 (s_1, s_2, x_3) ds_1 ds_2 \\
&= \varepsilon \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \int_{S_{\varepsilon}^i} \left| \frac{\partial \varphi_3}{\partial x_3} \right|^2 (s_1, s_2, x_3) ds_1 ds_2 \\
&= \frac{1}{\varepsilon |S|} \int_{T_{\varepsilon}} \left| \frac{\partial \varphi_3}{\partial x_3} \right|^2 dx \leq C \int |\mathbf{e}(\boldsymbol{\varphi})|^2 dm_{\varepsilon},
\end{aligned}$$

yielding the second line of (43). Moreover, we have

$$\int |\widehat{\boldsymbol{\varphi}}|^2 dm_{\varepsilon} = \frac{1}{\varepsilon |S|} \int_{T_{\varepsilon}} |\boldsymbol{\varphi}(0, x_2, x_3)|^2 dx \leq \frac{1}{\varepsilon |S|} \int_{(-\frac{\varepsilon}{2}, \frac{\varepsilon}{2}) \times \Sigma} |\boldsymbol{\varphi}(0, x_2, x_3)|^2 dx = \frac{1}{|S|} \int_{\Sigma} |\gamma_{\Sigma}(\boldsymbol{\varphi})|^2 d\mathcal{H}^2.$$

The estimates (43) are proved. The estimate (44) results from the next computation, holding for $k \in \{1, 2, 3\}$:

$$\begin{aligned}
\int_{\Sigma} |\gamma_{\Sigma}(\mathbf{v}_{\varepsilon k}(\boldsymbol{\varphi}))|^2 d\mathcal{H}^2 &= \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \int_{\varepsilon(i-\frac{1}{2})}^{\varepsilon(i+\frac{1}{2})} dx_2 \left| \int_{S_{\varepsilon}^i} \varphi_k(s, x_3) d\mathcal{H}^2(s) \right|^2 \\
&= \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \varepsilon \left| \int_{S_{\varepsilon}^i} \varphi_k(s, x_3) d\mathcal{H}^2(s) \right|^2 \\
&= \sum_{i \in I_{\varepsilon}} \int_{-L}^L dx_3 \varepsilon \frac{1}{|S_{\varepsilon}^i|} \int_{S_{\varepsilon}^i} \left| \int_{S_{\varepsilon}^i} \varphi_k(s, x_3) d\mathcal{H}^2(s) \right|^2 dx_1 dx_2 \\
&= \frac{1}{\varepsilon |S|} \int_{T_{\varepsilon}} |\mathbf{v}_{\varepsilon k}(\boldsymbol{\varphi})|^2 dx = \int |\mathbf{v}_{\varepsilon k}(\boldsymbol{\varphi})|^2 dm_{\varepsilon}.
\end{aligned} \tag{48}$$

□

Proof of (45). If the first line of (45) is not satisfied, there exists $(\boldsymbol{\psi}_n) \subset H^1(Y; \mathbb{R}^3)$ such that

$$\int_{(-\frac{1}{2}, \frac{1}{2})} \left| \int_S \boldsymbol{\psi}_n ds - \boldsymbol{\psi}_n(0, y_2) \right|^2 dy_2 = 1, \quad \int_Y |\nabla \boldsymbol{\psi}_n|^2 dy_1 dy_2 \leq \frac{1}{n}. \tag{49}$$

After possibly subtracting a constant vector to $\boldsymbol{\psi}_n$, we can assume that

$$\int_S \boldsymbol{\psi}_n dy = 0. \tag{50}$$

From the Poincaré-Wirtinger inequality

$$\int_Y \left| \boldsymbol{\psi} - \int_S \boldsymbol{\psi} ds \right|^2 dy \leq C \int_Y |\nabla \boldsymbol{\psi}|^2 dy \quad \forall \boldsymbol{\psi} \in H^1(Y; \mathbb{R}^3),$$

we deduce that $(\boldsymbol{\psi}_n)$ is bounded in $H^1(Y; \mathbb{R}^3)$ and weakly converges, thanks to (50) and up to a subsequence (still denoted by $\boldsymbol{\psi}_n$), to 0. By the continuity of the trace application from $H^1(Y; \mathbb{R}^3)$ weak to $L^2(\{0\} \times (-\frac{1}{2}, \frac{1}{2}); \mathbb{R}^3)$ strong, the trace $\boldsymbol{\psi}_n(0, y_2)$ converges strongly to 0 in $L^2(\{0\} \times (-\frac{1}{2}, \frac{1}{2}); \mathbb{R}^3)$. This is in contradiction with the fact that by (49) and (50), the norm in $L^2(\{0\} \times (-\frac{1}{2}, \frac{1}{2}); \mathbb{R}^3)$ of $\boldsymbol{\psi}_n(0, y_2)$ is equal to 1. □

We are now in a position to investigate the link between the two-scale limit with respect to (m_{ε}) of a bounded sequence in $H^1(\Omega; \mathbb{R}^k)$ and the strong limit of its traces in $L^2(\Sigma; \mathbb{R}^k)$.

Proposition 3 Assume that (\mathbf{f}_ε) weakly converges in $H^1(\Omega; \mathbb{R}^k)$ to some $\mathbf{f} \in H^1(\Omega; \mathbb{R}^k)$. Then, (\mathbf{f}_ε) two-scale converges with respect to (m_ε) to the field $\mathbf{f}_0 \in L^2(\Sigma \times S; \mathbb{R}^k)$ defined by

$$\mathbf{f}_0(x, y) := \gamma_\Sigma(\mathbf{f})(x) \quad \text{for } \mathcal{H}^2 \otimes \mathcal{L}^2\text{-a.e. } (x, y) \in \Sigma \times S. \quad (51)$$

In addition, the sequence $(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))$ defined by (25) two-scale converges with respect to (m_ε) to \mathbf{f}_0 . Furthermore, the sequence $(\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)))$ strongly converges in $L^2(\Sigma; \mathbb{R}^k)$ to $\gamma_\Sigma(\mathbf{f})$.

Proof. By the first line of (42), we have

$$\begin{aligned} & \int_\Sigma |\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) - \gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2 \\ & \leq C \int_{\Sigma_\varepsilon} |\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) - \gamma_\Sigma(\mathbf{f}_\varepsilon)|^2 d\mathcal{H}^2 + C \int_{\Sigma_\varepsilon} |\gamma_\Sigma(\mathbf{f}_\varepsilon) - \gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2 + C \int_{\Sigma \setminus \Sigma_\varepsilon} |\gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2 \\ & \leq C\varepsilon \int_{-\varepsilon/2}^{\varepsilon/2} \int_\Sigma |\nabla \mathbf{f}_\varepsilon|^2 dx + C \int_\Sigma |\gamma_\Sigma(\mathbf{f}_\varepsilon) - \gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2 + C \int_{\Sigma \setminus \Sigma_\varepsilon} |\gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2. \end{aligned} \quad (52)$$

Since (\mathbf{f}_ε) weakly converges to \mathbf{f} in $H^1(\Omega; \mathbb{R}^k)$, the sequence $(\gamma_\Sigma(\mathbf{f}_\varepsilon))$ strongly converges to $\gamma_\Sigma(\mathbf{f})$ in $L^2(\Sigma; \mathbb{R}^k)$. Since the sequence $(|\gamma_\Sigma(\mathbf{f})|^2 \mathbb{1}_{\Sigma \setminus \Sigma_\varepsilon})$ is dominated by $|\gamma_\Sigma(\mathbf{f})|^2 \in L^1(\Sigma)$ and \mathcal{H}^2 -a.e. converges to 0 on Σ , by the Dominated Convergence Theorem, there holds: $\lim_{\varepsilon \rightarrow 0} \int_{\Sigma \setminus \Sigma_\varepsilon} |\gamma_\Sigma(\mathbf{f})|^2 d\mathcal{H}^2 = 0$. It then follows from (52) that the sequence $(\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)))$ strongly converges in $L^2(\Sigma; \mathbb{R}^k)$ to $\gamma_\Sigma(\mathbf{f})$. Given $\psi \in C(\overline{\Omega \times S}; \mathbb{R}^k)$, we consider the fields $\overline{\psi}_\varepsilon^\Sigma \in L^\infty(\Sigma; \mathbb{R}^k)$ and $\overline{\psi}^\Sigma \in C(\overline{\Sigma}; \mathbb{R}^k)$ defined by

$$\begin{aligned} \overline{\psi}_\varepsilon^\Sigma(x_2, x_3) & := \sum_{i \in I_\varepsilon} \left(\int_{S_\varepsilon^i} \psi \left(s_1, s_2, x_3, \frac{y_\varepsilon(s)}{\varepsilon} \right) ds_1 ds_2 \right) \mathbb{1}_{(\varepsilon i - \frac{\varepsilon}{2}, \varepsilon i + \frac{\varepsilon}{2})}(x_2), \\ \overline{\psi}^\Sigma(x_2, x_3) & := \int_S \psi(0, x_2, x_3, y) dy. \end{aligned} \quad (53)$$

By the change of variables formula, there holds (see (26))

$$\overline{\psi}_\varepsilon^\Sigma(x_2, x_3) = \int_{S_\varepsilon^i} \psi \left(0, x_2, x_3, \frac{y_\varepsilon(s)}{\varepsilon} \right) ds \quad \forall i \in I_\varepsilon.$$

Therefore, for all $(x_2, x_3) \in (\varepsilon i - \frac{\varepsilon}{2}, \varepsilon i + \frac{\varepsilon}{2}) \times (-L, L)$ we have

$$\left| \overline{\psi}_\varepsilon^\Sigma(x_2, x_3) - \overline{\psi}^\Sigma(x_2, x_3) \right| \leq \sup_{(s, y) \in S_\varepsilon^i \times S} |\psi(0, x_2, x_3, y) - \psi(s, x_3, y)|.$$

By (53) we have

$$\left\| \overline{\psi}_\varepsilon^\Sigma \right\|_{L^\infty(\Sigma; \mathbb{R}^k)} \leq \|\psi\|_{L^\infty(\Omega \times S; \mathbb{R}^k)},$$

hence the sequence $(\overline{\psi}_\varepsilon^\Sigma)$ is bounded in $L^\infty(\Sigma; \mathbb{R}^k)$. On the other hand, one can check by using the uniform continuity of ψ on $\overline{\Omega \times S}$, that the sequence $(\overline{\psi}_\varepsilon^\Sigma)$ uniformly converges to $\overline{\psi}^\Sigma$ on each compact subset of Σ . We deduce that

$$\overline{\psi}_\varepsilon^\Sigma \rightarrow \overline{\psi}^\Sigma \quad \text{strongly in } L^q(\Sigma; \mathbb{R}^k) \quad \forall q \in [1, +\infty). \quad (54)$$

By (25) and (53) there holds

$$\begin{aligned} \int \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon) \cdot \psi \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon & = \frac{1}{\varepsilon |S|} \sum_{i \in I_\varepsilon} \int_{-L}^L dx_3 \int_{S_\varepsilon^i} \left(\int_{S_\varepsilon^i} \mathbf{f}_\varepsilon(s_1, s_2, x_3) ds \right) \cdot \psi \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dx_1 dx_2 \\ & = \frac{1}{\varepsilon |S|} \sum_{i \in I_\varepsilon} \int_{-L}^L dx_3 \left(\int_{S_\varepsilon^i} \mathbf{f}_\varepsilon(s_1, s_2, x_3) ds \right) \cdot \int_{S_\varepsilon^i} \psi \left(s_1, s_2, x_3, \frac{y_\varepsilon(s)}{\varepsilon} \right) ds \\ & = \sum_{i \in I_\varepsilon} \int_{(\varepsilon i - \frac{\varepsilon}{2}, \varepsilon i + \frac{\varepsilon}{2}) \times (-L, L)} \gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \overline{\psi}_\varepsilon^\Sigma d\mathcal{H}^2 = \int_\Sigma \gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \overline{\psi}_\varepsilon^\Sigma d\mathcal{H}^2. \end{aligned} \quad (55)$$

By passing to the limit as $\varepsilon \rightarrow 0$, thanks to the strong convergences of $(\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)))$ to $\gamma_\Sigma(\mathbf{f})$ in $L^2(\Sigma; \mathbb{R}^k)$ and of $(\bar{\boldsymbol{\psi}}_\varepsilon^\Sigma)$ to $\bar{\boldsymbol{\psi}}^\Sigma$ in $L^2(\Sigma; \mathbb{R}^k)$ (see (54)), we get

$$\lim_{\varepsilon \rightarrow 0} \int \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon) \cdot \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon = \int_\Sigma \gamma_\Sigma(\mathbf{f}) \cdot \bar{\boldsymbol{\psi}}^\Sigma d\mathcal{H}^2. \quad (56)$$

On the other hand, by (53) there holds

$$\int_\Sigma \gamma_\Sigma(\mathbf{f}) \cdot \bar{\boldsymbol{\psi}}^\Sigma d\mathcal{H}^2 = \frac{1}{|S|} \int_{\Sigma \times S} \gamma_\Sigma(\mathbf{f})(x) \cdot \boldsymbol{\psi}(x, y) d\mathcal{H}^2(x) dy. \quad (57)$$

By the arbitrary choice of $\boldsymbol{\psi}$, we infer from (56) and (57) that the sequence $(\mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon))$ two-scale converges with respect to (m_ε) to the field $\mathbf{f}_0 \in L^2(\Sigma; \mathbb{R}^k)$ defined by (51).

The proof of the first statement is achieved provided we show that (\mathbf{f}_ε) two-scale converges to \mathbf{f}_0 with respect to (m_ε) . To that aim, let us fix $\boldsymbol{\psi} \in C(\overline{\Omega \times S}; \mathbb{R}^k)$. By (25), Hölder's inequality and Jensen's inequality, we have

$$\begin{aligned} \left| \int (\mathbf{f}_\varepsilon - \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon \right|^2 &\leq C \int |\mathbf{f}_\varepsilon - \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)|^2 dm_\varepsilon \\ &\leq C \frac{1}{\varepsilon |S|} \sum_{i \in I_\varepsilon} \int_{-L}^L dx_3 \int_{S_\varepsilon^i} \left| \mathbf{f}_\varepsilon - \int_{S_\varepsilon^i} \mathbf{f}_\varepsilon(s_1, s_2, x_3) ds \right|^2 dx_1 dx_2. \end{aligned} \quad (58)$$

By making suitable changes of variables in the following Poincaré-Wirtinger inequality

$$\int_S \left| \varphi - \int_S \varphi ds \right|^2 dx \leq C \int_S |\nabla \varphi|^2 dx \quad \forall \varphi \in H^1(S; \mathbb{R}^k),$$

we deduce that for a. e. $x_3 \in (-L, L)$, there holds

$$\int_{S_\varepsilon^i} \left| \mathbf{f}_\varepsilon - \int_{S_\varepsilon^i} \mathbf{f}_\varepsilon(s_1, s_2, x_3) ds \right|^2 dx_1 dx_2 \leq C \varepsilon^2 \int_{S_\varepsilon^i} |\nabla \mathbf{f}_\varepsilon(x_1, x_2, x_3)|^2 dx_1 dx_2. \quad (59)$$

Joining (58) and (59), we infer

$$\left| \int (\mathbf{f}_\varepsilon - \mathbf{v}_\varepsilon(\mathbf{f}_\varepsilon)) \cdot \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon \right|^2 \leq C \varepsilon \int_{T_\varepsilon} |\nabla \mathbf{f}_\varepsilon|^2 dx. \quad (60)$$

We deduce from (56), (57) and (60) that

$$\lim_{\varepsilon \rightarrow 0} \int \mathbf{f}_\varepsilon \cdot \boldsymbol{\psi} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon = \frac{1}{|S|} \int_{\Sigma \times S} \gamma_\Sigma(\mathbf{f})(x) \cdot \boldsymbol{\psi}(x, y) d\mathcal{H}^2(x) dy.$$

Therefore, by the arbitrary choice of $\boldsymbol{\psi}$, the sequence (\mathbf{f}_ε) two-scale converges with respect to (m_ε) to \mathbf{f}_0 . \square

4 A priori estimates, identification relations

The following section is mainly devoted to the study of the asymptotic behaviour of the solution (\mathbf{u}_ε) of (7) and of the sequences $(\mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon)m_\varepsilon)$ and $(\mathbf{u}_\varepsilon m_\varepsilon)$. The main results of this section are stated in Proposition 4. Their proofs rely on some basic inequalities established in the previous section in Lemma 1 and also on those established in the next lemma.

Lemma 2 *The following estimates hold for all $i \in I_\varepsilon$:*

$$\begin{aligned} \int_{T_\varepsilon^i} |\varepsilon\varphi_1|^2 + |\varepsilon\varphi_2|^2 + |\varphi_3|^2 dx &\leq C \int_{T_\varepsilon^i} |\mathbf{e}(\boldsymbol{\varphi})|^2 dx & \forall \boldsymbol{\varphi} \in H_0^1(\Omega; \mathbb{R}^3), \\ \int_{T_\varepsilon^i} |\varepsilon\mathbf{v}_{\varepsilon 1}(\boldsymbol{\varphi})|^2 + |\varepsilon\mathbf{v}_{\varepsilon 2}(\boldsymbol{\varphi})|^2 + |\mathbf{v}_{\varepsilon 3}(\boldsymbol{\varphi})|^2 dx &\leq C \int_{T_\varepsilon^i} |\mathbf{e}(\boldsymbol{\varphi})|^2 dx & \forall \boldsymbol{\varphi} \in H_0^1(\Omega; \mathbb{R}^3). \end{aligned} \quad (61)$$

Proof. We consider the set

$$V := \{\boldsymbol{\psi} \in H^1(T, \mathbb{R}^3), \boldsymbol{\psi} = 0 \text{ on } S \times \{-L\}\}.$$

The space V is a closed linear subset of $H^1(T, \mathbb{R}^3)$ satisfying $V \cap \mathcal{R} = \{0\}$, where \mathcal{R} denotes the space of rigid displacements, therefore by Korn inequality there holds

$$\int_T |\boldsymbol{\psi}|^2 dz \leq C \int_T |\mathbf{e}(\boldsymbol{\psi})|^2 dz \quad \forall \boldsymbol{\psi} \in V. \quad (62)$$

Let us fix $\boldsymbol{\varphi} \in H_0^1(\Omega; \mathbb{R}^3)$. By applying (62) to the field $\boldsymbol{\psi}$ defined by $\psi_\alpha(z_1, z_2, z_3) := \varphi_\alpha(\varepsilon(z_1 - (\mathbf{y}_\varepsilon^i(z))_1), \varepsilon(z_2 - (\mathbf{y}_\varepsilon^i(z))_2), z_3)$ for $\alpha \in \{1, 2\}$ and $\psi_3(z) := \frac{1}{\varepsilon}\varphi_3(\varepsilon(z_1 - (\mathbf{y}_\varepsilon^i(z))_1), \varepsilon(z_2 - (\mathbf{y}_\varepsilon^i(z))_2), z_3)$, and then by making a suitable change of variable, we get

$$\int_{T_\varepsilon^i} |\varepsilon\varphi_1|^2 + |\varepsilon\varphi_2|^2 + |\varphi_3|^2 dx \leq C \int_{T_\varepsilon^i} |\mathbf{e}(\boldsymbol{\varphi})|^2 dx. \quad (63)$$

On the other hand, it easily follows from (25), Fubini Theorem and Jensen's inequality that

$$\int_{T_\varepsilon^i} |\varepsilon\mathbf{v}_{\varepsilon 1}(\boldsymbol{\varphi})|^2 + |\varepsilon\mathbf{v}_{\varepsilon 2}(\boldsymbol{\varphi})|^2 + |\mathbf{v}_{\varepsilon 3}(\boldsymbol{\varphi})|^2 dx \leq C \int_{T_\varepsilon^i} |\varepsilon\varphi_1|^2 + |\varepsilon\varphi_2|^2 + |\varphi_3|^2 dx. \quad (64)$$

The estimates (61) result from (63) and (64). \square

The next proposition specifies the asymptotic behavior of the solution \mathbf{u}_ε of (7) and of some associated auxiliary sequences. The strong relative compactness of (\mathbf{u}_ε) in $H_0^1(\Omega; \mathbb{R}^3)$ is established at the end of the paper in Section 5.2.

Proposition 4 *Let \mathbf{u}_ε be the solution of (7) and let $\mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon)$ be defined by (25). Then:*

(i) *the next estimates hold true*

$$\begin{aligned} \|\mathbf{u}_\varepsilon\|_{H_0^1(\Omega; \mathbb{R}^3)}^2 &\leq C, \quad \int |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dm_\varepsilon \leq C\varepsilon^{m-1}, \quad \int \{|\mathbf{u}_\varepsilon|^2 + |\mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon)|^2\} dm_\varepsilon \leq C, \\ \int \{&|u_{\varepsilon 1}|^2 + |u_{\varepsilon 2}|^2 + \left|\frac{u_{\varepsilon 3}}{\varepsilon}\right|^2 + |\mathbf{v}_{\varepsilon 1}(\mathbf{u}_\varepsilon)|^2 + |\mathbf{v}_{\varepsilon 2}(\mathbf{u}_\varepsilon)|^2 + \left|\frac{\mathbf{v}_{\varepsilon 3}(\mathbf{u}_\varepsilon)}{\varepsilon}\right|^2\} dm_\varepsilon \leq C\varepsilon^{m-3}, \\ \int |\mathbf{u}_\varepsilon - \mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon)|^2 dm_\varepsilon &\leq C\varepsilon, \quad \int_\Sigma |\gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon))|^2 d\mathcal{H}^2 \leq C. \end{aligned} \quad (65)$$

(ii) *If $m \geq 1$, the next convergences take place, up to a subsequence, for some $\mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3)$, $\mathbf{u}_0, \mathbf{v}_0 \in L^2(\Sigma \times S; \mathbb{R}^3)$, $\boldsymbol{\Xi}_0 \in L^2(\Sigma \times S; \mathbb{S}^3)$:*

$$\begin{aligned} \mathbf{u}_\varepsilon &\rightharpoonup \mathbf{u} && \text{weakly in } H_0^1(\Omega; \mathbb{R}^3), \\ \gamma_\Sigma(\mathbf{u}_\varepsilon) &\rightarrow \gamma_\Sigma(\mathbf{u}), \quad \gamma_\Sigma(\mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon)) \rightarrow \gamma_\Sigma(\mathbf{u}) && \text{strongly in } L^2(\Sigma; \mathbb{R}^3), \\ \mathbf{u}_\varepsilon \xrightarrow{m_\varepsilon} \mathbf{u}_0, \quad \mathbf{v}_\varepsilon(\mathbf{u}_\varepsilon) \xrightarrow{m_\varepsilon} \mathbf{v}_0, \quad \mathbf{e}(\mathbf{u}_\varepsilon) \xrightarrow{m_\varepsilon} \boldsymbol{\Xi}_0 && \text{two-scale with respect to } (m_\varepsilon), \end{aligned} \quad (66)$$

where the symbol $\xrightarrow{m_\varepsilon}$ is defined by (27) and the following identification relations hold true:

$$\mathbf{v}_0(x, y) = \mathbf{u}_0(x, y) = \gamma_\Sigma(\mathbf{u})(x) \quad \text{for } \mathcal{H}^2 \otimes \mathcal{L}^2\text{-a.e. } (x, y) \in \Sigma \times S, \quad (67)$$

$$\begin{aligned} \frac{\partial \gamma_\Sigma(u_3)}{\partial x_3} &\in L^2(\Sigma), \quad \gamma_\Sigma(u_3) = 0 \quad \text{on } \{x \in \Sigma, x_3 \in \{-L, L\}\}, \\ \frac{\partial \gamma_\Sigma(u_3)}{\partial x_3}(x) &= (\mathbf{\Xi}_0)_{33}(x, y) \quad \text{for } \mathcal{H}^2 \otimes \mathcal{L}^2\text{-a.e. } (x, y) \in \Sigma \times S, \end{aligned} \quad (68)$$

$$\gamma_\Sigma(u_3) = 0 \quad \text{if } m > 1. \quad (69)$$

(iii) If $m \geq 3$, then besides (66), the next convergences take place up to a subsequence, for some $w_0 \in L^2(\Sigma \times S)$, $\mathbf{Y}_0 \in L^2(\Sigma \times S; \mathbb{S}^3)$, $w \in L^2(\Sigma)$:

$$\begin{aligned} \frac{u_{\varepsilon 3}}{\varepsilon} \xrightarrow{m_\varepsilon} w_0, \quad \frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_\varepsilon) \xrightarrow{m_\varepsilon} \mathbf{Y}_0 \quad \text{two-scale with respect to } (m_\varepsilon), \\ \frac{\gamma_\Sigma(\mathbf{v}_{\varepsilon 3}(\mathbf{u}_\varepsilon))}{\varepsilon} \rightharpoonup w \quad \text{weakly in } L^2(\Sigma). \end{aligned} \quad (70)$$

Moreover there holds

$$\begin{aligned} \gamma_\Sigma(u_3) = 0, \quad \frac{\partial^2 \gamma_\Sigma(\mathbf{u})}{\partial x_3^2} &\in L^2(\Sigma; \mathbb{R}^3), \quad \gamma_\Sigma(\mathbf{u}) = \frac{\partial \gamma_\Sigma(\mathbf{u})}{\partial x_3} = 0 \quad \text{on } \partial \Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L, L\}\}, \\ w_0(x, y) = w(x) - \sum_{\alpha=1}^2 \frac{\partial \gamma_\Sigma(u_\alpha)}{\partial x_3}(x) y_\alpha, \quad \text{in } \Sigma \times S, \quad \frac{\partial w}{\partial x_3} &\in L^2(\Sigma), \\ \mathbf{Y}_{033} = \frac{\partial w}{\partial x_3} - \frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2} y_1 - \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2} y_2. \end{aligned} \quad (71)$$

Furthermore,

$$\gamma_\Sigma(\mathbf{u}) = 0 \quad \text{if } m > 3. \quad (72)$$

(iv) We have $\mathbf{u} \in \mathcal{D}_m$, where \mathcal{D}_m is given by (9), (11), (16), or (13), in accordance with the choice of m .

Proof. (i) We multiply (7) by \mathbf{u}_ε , integrate by parts over Ω , and use Cauchy Schwarz inequality to find

$$\int_\Omega \boldsymbol{\sigma}_\varepsilon : \mathbf{e}(\mathbf{u}_\varepsilon) dx = \int_\Omega \mathbf{f} \cdot \mathbf{u}_\varepsilon \leq \left(\int_\Omega |\mathbf{f}|^2 dx \right)^{\frac{1}{2}} \left(\int_\Omega |\mathbf{u}_\varepsilon|^2 dx \right)^{\frac{1}{2}}. \quad (73)$$

By applying Poincaré and Korn inequalities in $H_0^1(\Omega; \mathbb{R}^3)$, we get

$$\begin{aligned} \int_\Omega |\mathbf{u}_\varepsilon|^2 dx &\leq C \int_\Omega |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dx \leq C \int_{\Omega \setminus T_\varepsilon} |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dx + \frac{C}{\varepsilon^m} \int_{T_\varepsilon} |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dx \\ &\leq C \int_\Omega \boldsymbol{\sigma}_\varepsilon : \mathbf{e}(\mathbf{u}_\varepsilon) dx. \end{aligned} \quad (74)$$

We infer from (73) and (74) that

$$|\mathbf{u}_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)}^2 \leq C, \quad \int |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dm_\varepsilon \leq C \varepsilon^{m-1}. \quad (75)$$

By the third line of (42), the first line of (43), (74), and the continuity of the trace application from $H^1(\Omega; \mathbb{R}^3)$ to $L^2(\Omega; \mathbb{R}^3)$, there holds

$$\begin{aligned} \int |\mathbf{u}_\varepsilon|^2 dm_\varepsilon &\leq C \int |\mathbf{u}_\varepsilon - \widehat{\mathbf{u}}_\varepsilon|^2 dm_\varepsilon + C \int |\widehat{\mathbf{u}}_\varepsilon|^2 dm_\varepsilon \\ &\leq C \varepsilon \int_{\Sigma_\varepsilon} |\nabla \mathbf{u}_\varepsilon|^2 dx + C \int_\Sigma |\gamma_\Sigma(\mathbf{u}_\varepsilon)|^2 d\mathcal{H}^2 \leq C |\mathbf{u}_\varepsilon|_{H^1(\Omega; \mathbb{R}^3)}^2 \leq C. \end{aligned} \quad (76)$$

We deduce from (61) and (75) that

$$\int \{|u_{\varepsilon 1}|^2 + |u_{\varepsilon 2}|^2 + \left|\frac{u_{\varepsilon 3}}{\varepsilon}\right|^2\} dm_{\varepsilon} \leq \frac{C}{\varepsilon^2} \int |\mathbf{e}(\mathbf{u}_{\varepsilon})|^2 dm_{\varepsilon} = C\varepsilon^{m-3} \quad (77)$$

and that

$$\int \{|v_{\varepsilon 1}(\mathbf{u}_{\varepsilon})|^2 + |v_{\varepsilon 2}(\mathbf{u}_{\varepsilon})|^2 + \left|\frac{v_{\varepsilon 3}(\mathbf{u}_{\varepsilon})}{\varepsilon}\right|^2\} dm_{\varepsilon} \leq \frac{C}{\varepsilon^2} \int |\mathbf{e}(\mathbf{u}_{\varepsilon})|^2 dm_{\varepsilon} = C\varepsilon^{m-3}. \quad (78)$$

By (42) and (75), we have

$$\int |\mathbf{u}_{\varepsilon} - \mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon})|^2 dm_{\varepsilon} \leq C\varepsilon \int_{-\varepsilon/2}^{\varepsilon/2} \int_{\Sigma} |\nabla \mathbf{u}_{\varepsilon}|^2 dx \leq C\varepsilon |\mathbf{u}_{\varepsilon}|_{H_0^1(\Omega; \mathbb{R}^3)}^2 \leq C\varepsilon. \quad (79)$$

By the first line of (42), (74), (75), (79), and by the continuity of the trace application from $H^1(\Omega; \mathbb{R}^3)$ to $L^2(\Omega; \mathbb{R}^3)$, there holds

$$\begin{aligned} \int_{\Sigma} |\gamma_{\Sigma}(\mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon}))|^2 d\mathcal{H}^2 &= \int_{\Sigma^{\varepsilon}} |\gamma_{\Sigma}(\mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon}))|^2 d\mathcal{H}^2 \\ &\leq C \int_{\Sigma^{\varepsilon}} |\gamma_{\Sigma}(\mathbf{u}_{\varepsilon}) - \gamma_{\Sigma}(\mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon}))|^2 d\mathcal{H}^2 + C \int_{\Sigma} |\gamma_{\Sigma}(\mathbf{u}_{\varepsilon})|^2 d\mathcal{H}^2 \\ &\leq C\varepsilon + C|\mathbf{u}_{\varepsilon}|_{H^1(\Omega; \mathbb{R}^3)}^2 \leq C. \end{aligned} \quad (80)$$

Collecting (75)-(80), the estimates (65) are proved. \square

(ii) By (65), the sequence $(\mathbf{u}_{\varepsilon})$ is bounded in $H_0^1(\Omega; \mathbb{R}^3)$ hence weakly converges, up to a subsequence, to some $\mathbf{u} \in H_0^1(\Omega; \mathbb{R}^3)$. From the compactness of the trace operator from $H_0^1(\Omega; \mathbb{R}^3)$ to $L^2(\Sigma; \mathbb{R}^3)$, we deduce that the sequence $(\gamma_{\Sigma}(\mathbf{u}_{\varepsilon}))$ strongly converges to $\gamma_{\Sigma}(\mathbf{u})$ in $L^2(\Sigma; \mathbb{R}^3)$, and from Proposition 3 that the sequence $(\gamma_{\Sigma}(\mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon})))$ strongly converges to $\gamma_{\Sigma}(\mathbf{u})$ in $L^2(\Sigma; \mathbb{R}^3)$. The convergences stated up to a subsequence in the last line of (66) result from Proposition 1 (ii) and from the fact that by (65), the estimate $\sup_{\varepsilon>0} \int |\mathbf{f}_{\varepsilon}|^2 dm_{\varepsilon} < +\infty$ takes place for $\mathbf{f}_{\varepsilon} \in \{\mathbf{u}_{\varepsilon}, \mathbf{v}_{\varepsilon}(\mathbf{u}_{\varepsilon}), \mathbf{e}(\mathbf{u}_{\varepsilon})\}$. Assertion (67) is a consequence of (66) and Proposition 3. Let us fix $\psi \in C^{\infty}(\bar{\Omega}; \mathcal{D}(S))$. Since $u_{\varepsilon} \in H_0^1(\Omega; \mathbb{R}^3)$, we have

$$\int \frac{\partial u_{\varepsilon 3}}{\partial x_3} \psi \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon} = - \int u_{\varepsilon 3} \frac{\partial \psi}{\partial x_3} \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon}.$$

By passing to the limit as $\varepsilon \rightarrow 0$, thanks to the two-scale convergences with respect to (m_{ε}) of $(\mathbf{e}(\mathbf{u}_{\varepsilon}))$ to $\mathbf{\Xi}_0$ and of $(\mathbf{u}_{\varepsilon})$ to $\gamma_{\Sigma}(\mathbf{u})$ (see (66), (67)), we infer

$$\frac{1}{|S|} \int_{\Sigma \times S} (\mathbf{\Xi}_0)_{33}(x, y) \psi(x, y) d\mathcal{H}^2(x) dy = - \frac{1}{|S|} \int_{\Sigma \times S} \gamma_{\Sigma}(u_3)(x) \frac{\partial \psi}{\partial x_3}(x, y) d\mathcal{H}^2(x) dy. \quad (81)$$

Since this equality is satisfied in particular for all $\psi \in \mathcal{D}(\Omega \times S)$, we deduce

$$\frac{\partial \gamma_{\Sigma}(u_3)}{\partial x_3}(x) = (\mathbf{\Xi}_0)_{33}(x, y) \quad \text{for } \mathcal{H}^2 \otimes \mathcal{L}^2\text{-a.e. } (x, y) \in \Sigma \times S. \quad (82)$$

As $\mathbf{\Xi}_0 \in L^2(\Sigma \times S; \mathbb{S}^3)$, we infer that $\frac{\partial \gamma_{\Sigma}(u_3)}{\partial x_3} \in L^2(\Sigma)$. Choosing then $\psi \in C^{\infty}(\bar{\Omega}; \mathcal{D}(S))$ and integrating (81) by parts with respect to x_3 , taking (82) into account, we obtain

$$\int_{\{x \in \Sigma, x_3 \in \{-L, L\}\} \times S} \gamma_{\Sigma}(u_3)(x) \psi(x, y) d\mathcal{H}^1(x) dy = 0,$$

yielding, by the arbitrary choice of ψ ,

$$\gamma_{\Sigma}(u_3) = 0 \quad \text{on } \{x \in \Sigma, x_3 \in \{-L, L\}\}.$$

Assertion (68) is proved. Assertion (69) follows from the second line of (65) and the second line of (66). \square

(iii) If $m \geq 3$, then by (65) we have

$$\sup_{\varepsilon>0} \int \left| \frac{\mathbf{v}_{\varepsilon 3}(\mathbf{u}_{\varepsilon})}{\varepsilon} \right|^2 dm_{\varepsilon} < +\infty, \quad \sup_{\varepsilon>0} \int \left| \frac{u_{\varepsilon 3}}{\varepsilon} \right|^2 dm_{\varepsilon} < +\infty, \quad \sup_{\varepsilon>0} \int \left| \frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_{\varepsilon}) \right|^2 dm_{\varepsilon} < +\infty.$$

The convergences stated, up to a subsequence, in the first line of (70), then follow from Proposition 1 (ii). As regards those stated in the second line of (70), they result from the fact that by (44) and by the second line of (65), there holds

$$\int_{\Sigma} \left| \frac{\gamma_{\Sigma}(\mathbf{v}_{\varepsilon 3}(\mathbf{u}_{\varepsilon}))}{\varepsilon} \right|^2 d\mathcal{H}^2 \leq C \left(\int \left| \frac{\mathbf{v}_{\varepsilon 3}(\mathbf{u}_{\varepsilon})}{\varepsilon} \right|^2 dm_{\varepsilon} \right) \leq C.$$

We deduce from the two-scale convergence of $\left(\frac{u_{\varepsilon 3}}{\varepsilon}\right)$ to w_0 with respect to (m_{ε}) that $(u_{\varepsilon 3})$ two-scale converges to 0 with respect to (m_{ε}) . It follows then from Proposition 3 that

$$\gamma_{\Sigma}(u_3) = 0. \quad (83)$$

To prove (71), we fix a test field $\Psi \in C^{\infty}(\overline{\Omega}, \mathcal{D}(S; \mathbb{S}^3))$ such that $\Psi_{\alpha\beta} = 0$ for all $(\alpha, \beta) \in \{1, 2\}^2$. By integration by parts, we have:

$$\begin{aligned} \varepsilon \int_{T_{\varepsilon}} \frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_{\varepsilon})(x) : \Psi \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon} &= \sum_{i=1}^3 -\varepsilon \int_{T_{\varepsilon}} \frac{u_{\varepsilon 3}(x)}{\varepsilon} \frac{\partial \Psi_{3i}}{\partial x_i} \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon} \\ &- \sum_{\alpha=1}^2 \int_{T_{\varepsilon}} u_{\varepsilon \alpha}(x) \frac{\partial \Psi_{\alpha 3}}{\partial x_3} \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon} - \sum_{\alpha=1}^2 \int_{T_{\varepsilon}} \frac{u_{\varepsilon 3}(x)}{\varepsilon} \frac{\partial \Psi_{3\alpha}}{\partial y_{\alpha}} \left(x, \frac{y_{\varepsilon}(x')}{\varepsilon} \right) dm_{\varepsilon}. \end{aligned} \quad (84)$$

By passing to the limit as $\varepsilon \rightarrow 0$, thanks to the two-scale convergences stated in (70), we obtain

$$\sum_{\alpha=1}^2 - \iint_{\Sigma \times S} \gamma_{\Sigma}(u_{\alpha})(x) \frac{\partial \Psi_{\alpha 3}}{\partial x_3}(x, y) d\mathcal{H}^2(x) dy - \iint_{\Sigma \times S} w_0(x, y) \frac{\partial \Psi_{3\alpha}}{\partial y_{\alpha}}(x, y) d\mathcal{H}^2(x) dy = 0. \quad (85)$$

Fixing $\alpha \in \{1, 2\}$ and choosing Ψ such that $\Psi_{ij} = 0$ if $\{i, j\} \neq \{\alpha, 3\}$, we get

$$- \iint_{\Sigma \times S} \gamma_{\Sigma}(u_{\alpha})(x) \frac{\partial \Psi_{\alpha 3}}{\partial x_3}(x, y) d\mathcal{H}^2(x) dy - \iint_{\Sigma \times S} w_0(x, y) \frac{\partial \Psi_{3\alpha}}{\partial y_{\alpha}}(x, y) d\mathcal{H}^2(x) dy = 0. \quad (86)$$

Choosing at first arbitrary fields $\Psi_{\alpha 3}$ in $\mathcal{D}(\Omega; \mathcal{D}(S))$, we deduce that

$$\frac{\partial w_0}{\partial y_{\alpha}}(x, y) = - \frac{\partial \gamma_{\Sigma}(u_{\alpha})}{\partial x_3}(x) \quad \text{in } \mathcal{D}'(\Sigma \times S), \quad (87)$$

hence w_0 , as a distribution on $\Sigma \times S$, can be written for a suitable $c \in \mathcal{D}'(\Sigma)$ under the following form:

$$w_0(x, y) = -y_1 \frac{\partial \gamma_{\Sigma}(u_1)}{\partial x_3}(x) - y_2 \frac{\partial \gamma_{\Sigma}(u_2)}{\partial x_3}(x) + c(x). \quad (88)$$

As w_0 belongs to $L^2(\Sigma \times S)$, we infer

$$c \in L^2(\Sigma), \quad \frac{\partial \gamma_{\Sigma}(u_{\alpha})}{\partial x_3} \in L^2(\Sigma) \quad (\alpha \in \{1, 2\}),$$

and (87) holds a.e. on $\Sigma \times S$. We then deduce from Proposition 1 (iii) b), (70) and (88) that

$$w(x) = \int_S w_0(x, y) dy = c(x). \quad (89)$$

Next, we multiply (84) by $\frac{1}{\varepsilon}$ and choose a field Ψ such that $\Psi_{ij} = 0$ if $(i, j) \neq (3, 3)$. Passing to the limit as $\varepsilon \rightarrow 0$, taking into account the two-scale convergences with respect to (m_ε) of $\frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_\varepsilon)$ to \mathbf{Y}_0 and of $\frac{u_{\varepsilon 3}}{\varepsilon}$ to w_0 given by (88) and (89), we obtain

$$\begin{aligned} & \iint_{\Sigma \times S} \mathcal{R}_{033}(x, y) \Psi_{33}(x, y) d\mathcal{H}^2(x) dy \\ &= - \iint_{\Sigma \times S} \left(-y_1 \frac{\partial \gamma_\Sigma(u_1)}{\partial x_3}(x) - y_2 \frac{\partial \gamma_\Sigma(u_2)}{\partial x_3}(x) + w(x) \right) \frac{\partial \Psi_{33}}{\partial x_3}(x, y) d\mathcal{H}^2(x) dy. \end{aligned} \quad (90)$$

Choosing at first an arbitrary $\Psi_{33} \in \mathcal{D}(\Omega; \mathcal{D}(S))$, we conclude that

$$\begin{aligned} \frac{\partial w}{\partial x_3} &\in L^2(\Sigma), \quad \frac{\partial^2 \gamma_\Sigma(\mathbf{u})}{\partial x_3^2} \in L^2(\Sigma; \mathbb{R}^3), \\ (\mathbf{Y}_0)_{33} &= \frac{\partial w}{\partial x_3}(x) - \sum_{\alpha=1}^2 \frac{\partial^2 \gamma_\Sigma(u_\alpha)}{\partial x_3^2}(x) y_\alpha, \quad \text{in } \Sigma \times S, \end{aligned} \quad (91)$$

then, choosing an arbitrary $\Psi_{33} \in C^\infty(\overline{\Omega}; \mathcal{D}(S))$ in (90) and integrating by parts, we obtain

$$0 = \iint_{\partial \Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L, L\}\} \times S} \left(-y_1 \frac{\partial \gamma_\Sigma(u_1)}{\partial x_3}(x) - y_2 \frac{\partial \gamma_\Sigma(u_2)}{\partial x_3}(x) + w(x) \right) \Psi_{33}(x, y) d\mathcal{H}^1(x) dy, \quad (92)$$

yielding

$$\begin{aligned} w &= 0 \quad \text{on } \partial \Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L, L\}\}, \\ \frac{\partial \gamma_\Sigma(\mathbf{u})}{\partial x_3} &= 0 \quad \text{on } \partial \Sigma \cap \{x \in \mathbb{R}^3, x_3 \in \{-L, L\}\}. \end{aligned} \quad (93)$$

Assertion (71) is proved.

Finally, if $m > 3$, then by the second line of (65) the sequence $(\int |\mathbf{u}_\varepsilon|^2 dm_\varepsilon)$ converges to 0. We deduce from Proposition 2 (applied to $j(\cdot) := |\cdot|^2$) that $\mathbf{u}_0 = 0$. The assertion (72) then results from (67). \square

(iv) Assertion (iv) follows from (66), (71), and (72).

5 Proof of Theorem 1

5.1 Weak convergence

Let us briefly outline the proof of Theorem 1. In the spirit of Tartar's method [34], we will multiply (7) by an appropriate sequence of oscillating test fields (ϕ_ε) and, by passing to the limit as $\varepsilon \rightarrow 0$ in accordance with the convergences established in proposition 4, obtain a variational formulation of the limit problem satisfied by \mathbf{u} . The test field ϕ_ε is constructed in terms of some fixed $\phi \in \mathcal{D}(\Omega; \mathbb{R}^3)$ such that $\phi \in \mathcal{D}_m$ (see (9), (11), (16), (18)). We fix a smooth domain S' of \mathbb{R}^2 such that

$$\overline{S} \subset S' \subset \overline{S'} \subset Y, \quad (94)$$

and a function $\varrho \in \mathcal{D}(Y)$ such that

$$\varrho = 0 \quad \text{in } Y \setminus S', \quad \varrho = 1 \quad \text{in } S, \quad 0 \leq \varrho \leq 1.$$

The function ϱ_ε defined on $\overline{\Omega}$ by (see (26))

$$\varrho_\varepsilon(x) := \sum_{i \in I_\varepsilon} \varrho \left(\frac{y_\varepsilon(x')}{\varepsilon} \right) \mathbf{1}_{Y_\varepsilon^i}(x'),$$

satisfies

$$\varrho_\varepsilon \in C^\infty(\overline{\Omega}), \quad \varrho_\varepsilon = 0 \quad \text{in } \Omega \setminus T'_\varepsilon, \quad \varrho_\varepsilon = 1 \quad \text{in } T_\varepsilon, \quad |\nabla \varrho_\varepsilon| \leq \frac{C}{\varepsilon}, \quad (95)$$

where T'_ε is defined by substituting S' for S in (2). The test field will then be defined by

$$\boldsymbol{\phi}_\varepsilon := (1 - \varrho_\varepsilon)\boldsymbol{\phi} + \varrho_\varepsilon\boldsymbol{\chi}_\varepsilon, \quad (96)$$

in terms of $\boldsymbol{\chi}_\varepsilon$ given by (102), (110) (assuming $\phi_3 = 0$ if $1 < m < 3$), or (120), depending on the choice of m .

We multiply equation (7) by $\boldsymbol{\phi}_\varepsilon$ and integrate it by parts over Ω . We get (see (19)):

$$a_{\varepsilon,m}(\mathbf{u}_\varepsilon, \boldsymbol{\phi}_\varepsilon) = \int_{\Omega} \mathbf{f} \cdot \boldsymbol{\phi}_\varepsilon dx. \quad (97)$$

It is easy to check that

$$\lim_{\varepsilon \rightarrow 0} \int_{\Omega} \mathbf{f} \cdot \boldsymbol{\phi}_\varepsilon dx = \int_{\Omega} \mathbf{f} \cdot \boldsymbol{\phi} dx. \quad (98)$$

In order to compute the limit of the left hand side of (97), we split it into a sum of three terms:

$$\begin{aligned} a_{\varepsilon,m}(\mathbf{u}_\varepsilon, \boldsymbol{\phi}_\varepsilon) &= I_{1\varepsilon} + I_{2\varepsilon} + I_{3\varepsilon}; \quad I_{1\varepsilon} = \int_{\Omega \setminus T'_\varepsilon} \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}(\boldsymbol{\phi}) dx, \\ I_{2\varepsilon} &= \int_{T'_\varepsilon \setminus T_\varepsilon} \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}(\boldsymbol{\phi}_\varepsilon) dx, \\ I_{3\varepsilon} &= \frac{|S|}{\varepsilon^{m-1}} \int \frac{E_T}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}(\boldsymbol{\chi}_\varepsilon) dm_\varepsilon. \end{aligned} \quad (99)$$

After possibly extracting a subsequence, we can assume that the convergences stated in Proposition 4 take place. In particular, the sequence $\frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right)$ converges weakly to $\frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right)$ in $L^2(\Omega, \mathbb{S}^3)$. On the other hand, since $|T'_\varepsilon| \rightarrow 0$, the sequence $\mathbf{e}(\boldsymbol{\phi})\mathbf{1}_{\Omega \setminus T'_\varepsilon}$ converges strongly in $L^2(\Omega, \mathbb{S}^3)$ to $\mathbf{e}(\boldsymbol{\phi})$. We infer

$$\lim_{\varepsilon \rightarrow 0} I_{1\varepsilon} = a_0(\mathbf{u}, \boldsymbol{\phi}) = \int_{\Omega} \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}))\mathbf{I} + \mathbf{e}(\mathbf{u}) \right) : \mathbf{e}(\boldsymbol{\phi}) dx. \quad (100)$$

The $\boldsymbol{\chi}_\varepsilon$ will be chosen such that

$$|\boldsymbol{\phi} - \boldsymbol{\chi}_\varepsilon|_{L^\infty(T'_\varepsilon)} \leq C\varepsilon, \quad |\mathbf{e}(\boldsymbol{\phi} - \boldsymbol{\chi}_\varepsilon)|_{L^\infty(T'_\varepsilon)} |\mathbf{e}(\boldsymbol{\phi}_\varepsilon)| \leq C,$$

(see (102), (110), (120)) therefore by (95) and (96) we have

$$|\mathbf{e}(\boldsymbol{\phi}_\varepsilon)| \leq C \quad \text{in } T'_\varepsilon \setminus T_\varepsilon,$$

hence by Cauchy-Schwartz inequality, there holds

$$\begin{aligned} \limsup_{\varepsilon \rightarrow 0} I_{2\varepsilon} &\leq \limsup_{\varepsilon \rightarrow 0} \int_{T'_\varepsilon \setminus T_\varepsilon} \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}(\boldsymbol{\phi}_\varepsilon) dx \\ &\leq \limsup_{\varepsilon \rightarrow 0} C |T'_\varepsilon \setminus T_\varepsilon|^{\frac{1}{2}} \left(\int_{T'_\varepsilon \setminus T_\varepsilon} \left| \frac{E}{1+\nu} \left(\frac{\nu}{1-2\nu} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon))\mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) \right|^2 dx \right)^{\frac{1}{2}} \\ &\leq C \limsup_{\varepsilon \rightarrow 0} C |T'_\varepsilon \setminus T_\varepsilon|^{\frac{1}{2}} = 0. \end{aligned} \quad (101)$$

We distinguish then different cases.

Case $m = 1$. We set (see (25) and Remark 2 below)

$$\boldsymbol{\chi}_\varepsilon := \mathbf{v}_\varepsilon(\boldsymbol{\phi}) - \varepsilon \begin{pmatrix} 0 \\ 0 \\ \frac{\partial \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3} \frac{y_{\varepsilon 1}(x')}{\varepsilon} + \frac{\partial \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3} \frac{y_{\varepsilon 2}(x')}{\varepsilon} \end{pmatrix} + \varepsilon \mathbf{q} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right), \quad (102)$$

where $\mathbf{y}_\varepsilon(x)$ is given by (26) and

$$\mathbf{q}(x, y) := \begin{pmatrix} -\nu_1 \frac{\partial \mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi})}{\partial x_3} y_1 \\ -\nu_1 \frac{\partial \mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi})}{\partial x_3} y_2 \\ 0 \end{pmatrix}. \quad (103)$$

By (25) and (103) there holds in T_ε :

$$\mathbf{e}(\boldsymbol{\chi}_\varepsilon) = \frac{\partial \mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi})}{\partial x_3} \begin{pmatrix} -\nu_1 & 0 & 0 \\ 0 & -\nu_1 & 0 \\ 0 & 0 & 1 \end{pmatrix} + \varepsilon \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right), \quad (104)$$

hence, by (7) and (99)

$$I_{3\varepsilon} = |S| E_T \int \frac{\partial u_{\varepsilon 3}}{\partial x_3} \frac{\partial \mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi})}{\partial x_3} dm_\varepsilon + |S| \varepsilon \int \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon)) \mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon. \quad (105)$$

By Proposition 4, we have

$$\begin{aligned} & \left| \varepsilon \int \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon)) \mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) : \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) dm_\varepsilon \right| \\ & \leq C \varepsilon \int \left| \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\mathbf{u}_\varepsilon)) \mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon) \right) \right| dm_\varepsilon \\ & \leq C \varepsilon \int |\mathbf{e}(\mathbf{u}_\varepsilon)| dm_\varepsilon \leq C \varepsilon \sqrt{\int |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dm_\varepsilon} \leq C \varepsilon. \end{aligned} \quad (106)$$

By passing to the limit as $\varepsilon \rightarrow 0$ in (105), taking into account Proposition 4, (106) and the uniform convergence of $\left(\frac{\partial \mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi})}{\partial x_3} \right)$ to $\frac{\partial \phi_3}{\partial x_3}$ on T_ε , we obtain

$$\lim_{\varepsilon \rightarrow 0} I_{3\varepsilon} = |S| E_T \int_\Sigma \frac{\partial \gamma_\Sigma(u_3)}{\partial x_3} \frac{\partial \phi_3}{\partial x_3} d\mathcal{H}^2. \quad (107)$$

We deduce from (99), (100), (101), and (107) that

$$\lim_{\varepsilon \rightarrow 0} a_{\varepsilon, m}(\mathbf{u}_\varepsilon, \boldsymbol{\phi}_\varepsilon) = a_1(\mathbf{u}, \boldsymbol{\phi}), \quad (108)$$

where $a_1(\cdot, \cdot)$ is the bilinear form on $\mathcal{D}_1 \times \mathcal{D}_1$ defined by (22). Joining (98) and (108), we obtain

$$a_1(\mathbf{u}, \boldsymbol{\phi}) = \int_\Omega \mathbf{f} \cdot \boldsymbol{\phi} dx \quad \forall \boldsymbol{\phi} \in \mathcal{D}(\Omega; \mathbb{R}^3). \quad (109)$$

This variational formulation is equivalent to (10). \square

Case $m = 3$. We choose $\phi_3 = 0$ and set (see Remark 2)

$$\boldsymbol{\chi}_\varepsilon(x) = \begin{pmatrix} \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})(x) \\ \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})(x) \\ 0 \end{pmatrix} + \varepsilon \begin{pmatrix} 0 \\ 0 \\ -\frac{\partial \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3} \frac{y_\varepsilon(x')_1}{\varepsilon} - \frac{\partial \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3} \frac{y_\varepsilon(x')_2}{\varepsilon} \end{pmatrix} + \varepsilon^2 \mathbf{q} \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right), \quad (110)$$

where

$$\mathbf{q}(x, y) = \nu_1 \begin{pmatrix} \frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_1^2 - y_2^2}{2} + \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} y_1 y_2 \\ \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_2^2 - y_1^2}{2} + \frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} y_1 y_2 \\ 0 \end{pmatrix}.$$

We have in T_ε

$$\mathbf{e}(\boldsymbol{\chi}_\varepsilon) = \varepsilon \left(\frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_1}{\varepsilon} + \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_2}{\varepsilon} \right) \begin{pmatrix} \nu_1 & 0 & 0 \\ 0 & \nu_1 & 0 \\ 0 & 0 & -1 \end{pmatrix} + \varepsilon^2 \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right), \quad (111)$$

hence,

$$\begin{aligned} \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\boldsymbol{\chi}_\varepsilon)) \mathbf{I} + \mathbf{e}(\boldsymbol{\chi}_\varepsilon) \right) &= -\varepsilon \left(\frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_1}{\varepsilon} + \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_2}{\varepsilon} \right) E_T(\mathbf{e}_3 \otimes \mathbf{e}_3) \\ &\quad + \varepsilon^2 \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr} \left(\mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) \mathbf{I} + \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right). \end{aligned}$$

Taking (20) into account, we infer

$$\begin{aligned} \frac{1}{\varepsilon^m} a_T(\mathbf{u}_\varepsilon, \boldsymbol{\chi}_\varepsilon) &= \frac{1}{\varepsilon^3} a_T(\boldsymbol{\chi}_\varepsilon, \mathbf{u}_\varepsilon) = \frac{1}{\varepsilon^3} \int_{T_\varepsilon} \left\{ \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\boldsymbol{\chi}_\varepsilon)) \mathbf{I} + \mathbf{e}(\boldsymbol{\chi}_\varepsilon) \right) : \mathbf{e}(\mathbf{u}_\varepsilon) \right\} dx \\ &= \frac{1}{\varepsilon^3} \int \varepsilon |S| \left\{ \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr}(\mathbf{e}(\boldsymbol{\chi}_\varepsilon)) \mathbf{I} + \mathbf{e}(\boldsymbol{\chi}_\varepsilon) \right) : \mathbf{e}(\mathbf{u}_\varepsilon) \right\} dm_\varepsilon \\ &= \int -|S| E_T \left(\frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_1}{\varepsilon} + \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_\varepsilon(x')_2}{\varepsilon} \right) \left(\frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right) dm_\varepsilon \\ &\quad + \int |S| \mathbf{e}(\mathbf{u}_\varepsilon) : \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr} \left(\mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) \mathbf{I} + \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) dm_\varepsilon. \end{aligned} \quad (112)$$

Let us remark that $\mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right)$ is uniformly bounded on T_ε and so we have, by the estimate (65) established in Proposition 4,

$$\begin{aligned} &\left| \int \mathbf{e}(\mathbf{u}_\varepsilon) : \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \operatorname{tr} \left(\mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) \mathbf{I} + \mathbf{e}_x(\mathbf{q}) \left(x, \frac{y_\varepsilon(x')}{\varepsilon} \right) \right) dm_\varepsilon \right| \\ &\leq C \int |\mathbf{e}(\mathbf{u}_\varepsilon)| dm_\varepsilon \leq C \sqrt{\int |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dm_\varepsilon} \leq C \sqrt{\varepsilon^{m-1}} \leq C\varepsilon \rightarrow 0. \end{aligned} \quad (113)$$

By (25) and by the uniform continuity of $\boldsymbol{\phi}$ on $\overline{\Omega}$, the next estimate takes place:

$$\left| \frac{\partial^2 \mathbf{v}_{\varepsilon \alpha}(\boldsymbol{\phi})}{\partial x_3^2} - \frac{\partial^2 \phi_\alpha}{\partial x_3^2} \right|_{L^\infty(T_\varepsilon)} \leq C\varepsilon \quad \forall \alpha \in \{1, 2\}.$$

Since, on the other hand, by Proposition 4 there holds $\int \left| \frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right|^2 dm_\varepsilon \leq C$, taking (24) into account, we deduce that

$$\begin{aligned} &\left| \int \left(\left(\frac{\partial^2 \mathbf{v}_{\varepsilon 1}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_{\varepsilon 1}(x')}{\varepsilon} + \frac{\partial^2 \mathbf{v}_{\varepsilon 2}(\boldsymbol{\phi})}{\partial x_3^2} \frac{y_{\varepsilon 2}(x')}{\varepsilon} \right) - \left(\frac{\partial^2 \phi_1}{\partial x_3^2} \frac{y_{\varepsilon 1}(x')}{\varepsilon} + \frac{\partial^2 \phi_2}{\partial x_3^2} \frac{y_{\varepsilon 2}(x')}{\varepsilon} \right) \right) \left(\frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right) dm_\varepsilon \right| \\ &\leq C\varepsilon \int \left| \frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right| dm_\varepsilon \leq C\varepsilon \left(\int \left| \frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right|^2 dm_\varepsilon \right)^{\frac{1}{2}} (m_\varepsilon(\Omega))^{\frac{1}{2}} \leq C\varepsilon. \end{aligned} \quad (114)$$

By Proposition 4 (see the first line of (70) and the last line of (71)), the sequence $\left(\frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3}\right)$ two-scale converges with respect to (m_ε) to $\frac{\partial w}{\partial x_3}(x) - \frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2}(x)y_1 - \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2}(x)y_2$. Therefore, by (1), (15), and (27), we have

$$\begin{aligned} & \lim_{\varepsilon \rightarrow 0} \int \left(\frac{\partial^2 \phi_1 y_{\varepsilon 1}(x')}{\partial x_3^2} \frac{1}{\varepsilon} + \frac{\partial^2 \phi_2 y_{\varepsilon 2}(x')}{\partial x_3^2} \frac{1}{\varepsilon} \right) \left(\frac{1}{\varepsilon} \frac{\partial u_{\varepsilon 3}}{\partial x_3} \right) dm_\varepsilon \\ &= \frac{1}{|S|} \iint_{\Sigma \times S} -|S| \frac{E_T}{2} \left(\frac{\partial^2 \phi_1}{\partial x_3^2} y_1 + \frac{\partial^2 \phi_2}{\partial x_3^2} y_2 \right) \left(\frac{\partial w}{\partial x_3}(x) - \frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2}(x)y_1 - \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2}(x)y_2 \right) d\mathcal{H}^2(x) dy \quad (115) \\ &= |S| E_T \sum_{\alpha, \beta=1}^2 \int_\Sigma J_{\alpha\beta} \frac{\partial^2 \phi_\alpha}{\partial x_3^2} \frac{\partial^2 \gamma_\Sigma(u_\beta)}{\partial x_3^2} d\mathcal{H}^2(x). \end{aligned}$$

We deduce from (112), (113), (114), and (115) that

$$\lim_{\varepsilon \rightarrow 0} I_{3\varepsilon} = |S| E_T \sum_{\alpha, \beta=1}^2 \int_\Sigma J_{\alpha\beta} \frac{\partial^2 \phi_\alpha}{\partial x_3^2} \frac{\partial^2 \gamma_\Sigma(u_\beta)}{\partial x_3^2} d\mathcal{H}^2(x). \quad (116)$$

By passing to the limit as $\varepsilon \rightarrow 0$ in (97), taking (98), (100), (101), and (116) into account, we obtain the variational formulation

$$a_0(\mathbf{u}, \boldsymbol{\phi}) + |S| |E_T| \sum_{\alpha, \beta=1}^2 \int_\Sigma J_{\alpha\beta} \frac{\partial^2 \phi_\alpha}{\partial x_3^2} \frac{\partial^2 \gamma_\Sigma(u_\beta)}{\partial x_3^2} d\mathcal{H}^2(x) = \int_\Omega \mathbf{f} \cdot \boldsymbol{\phi} dx, \quad (117)$$

equivalent to (14). \square

Other cases.

If $0 < m < 1$, we simply set $\boldsymbol{\chi}_\varepsilon = \boldsymbol{\phi}$ (thus $\boldsymbol{\phi}_\varepsilon = \boldsymbol{\phi}$). Noticing that by and (65), we have

$$\int_{T_\varepsilon} |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dx \leq C \varepsilon^m, \quad (118)$$

we infer

$$\begin{aligned} \limsup_{\varepsilon \rightarrow 0} |I_{3\varepsilon}| &= \limsup_{\varepsilon \rightarrow 0} \frac{1}{\varepsilon^m} |a_T(\mathbf{u}_\varepsilon, \boldsymbol{\phi})| \\ &\leq \limsup_{\varepsilon \rightarrow 0} \frac{C}{\varepsilon^m} \left(\int_{T_\varepsilon} |\mathbf{e}(\mathbf{u}_\varepsilon)|^2 dx \right)^{\frac{1}{2}} |T_\varepsilon|^{\frac{1}{2}} \\ &\leq \limsup_{\varepsilon \rightarrow 0} C \varepsilon^{\frac{1-m}{2}} = 0. \end{aligned} \quad (119)$$

Joining (100), (101), (119), we obtain the variational formulation

$$a_0(\mathbf{u}, \boldsymbol{\phi}) = \int_\Omega \mathbf{f} \cdot \boldsymbol{\phi} dx,$$

equivalent to (8).

If $1 < m < 3$, then by Proposition 4 we have $u_3 = 0$ on Σ . We define $\boldsymbol{\chi}_\varepsilon$ by (102), setting $\phi_3 = 0$. Since $\mathbf{v}_{\varepsilon 3}(\boldsymbol{\phi}) = 0$, we deduce from (99) and (104) that

$$\lim_{\varepsilon \rightarrow 0} I_{3\varepsilon} = 0.$$

The variational formulation obtained by passing to the limit in (97) as $\varepsilon \rightarrow 0$ is given by substituting 0 for u_3 and 0 for ϕ_3 in (109).

If $m > 3$, then by Proposition 4 we have $\mathbf{u} = 0$ on Σ , and we set simply

$$\boldsymbol{\chi}_\varepsilon = 0. \quad (120)$$

\square

Remark 2 The field χ_ε is constructed in such a way that the behavior of the couple $(\chi_\varepsilon, \mathbf{e}(\chi_\varepsilon))$ should mimic that of $(\mathbf{u}_\varepsilon, \mathbf{e}(\mathbf{u}_\varepsilon))$ in the fibres, studied in Proposition 4.

In the case $m = 1$, the convergences (66) indicate that $\mathbf{e}(\mathbf{u}_\varepsilon) \simeq \Xi_0 \left(x, \frac{y_\varepsilon(x)}{\varepsilon} \right)$ in T_ε . This, joined with the relations (67) and (68), and by virtue of a minimization principle, suggests that the following approximation is likely to hold in T_ε

$$\mathbf{e}(\mathbf{u}_\varepsilon) \simeq \frac{\partial u_3}{\partial x_3}(x) \mathbf{e}_3 \otimes \mathbf{e}_3 + \mathbf{M} \left(\frac{\partial u_3}{\partial x_3}(x) \right) \quad \text{in } T_\varepsilon, \quad (121)$$

where $\mathbf{M}(a)$ is the solution of

$$\min_{\mathbf{M} \in \mathbb{S}^3, M_{33}=0} g(\mathbf{M} + a\mathbf{e}_3 \otimes \mathbf{e}_3), \quad g(\mathbf{A}) := \frac{E_T}{2(1+\nu_1)} \left(\frac{\nu_1}{1-2\nu_1} (\text{tr } \mathbf{A})^2 + \mathbf{A} : \mathbf{A} \right),$$

given by

$$\mathbf{M}(a) = \begin{pmatrix} -\nu_1 a \\ -\nu_1 a \\ 0 \end{pmatrix}.$$

Accordingly, the field χ_ε we are looking for should satisfy

$$\chi_\varepsilon \simeq \phi \quad \text{and} \quad \mathbf{e}(\chi_\varepsilon) \simeq \frac{\partial \phi_3}{\partial x_3}(x) \mathbf{e}_3 \otimes \mathbf{e}_3 + \mathbf{M} \left(\frac{\partial \phi_3}{\partial x_3}(x) \right) \quad \text{in } T_\varepsilon.$$

These estimates are verified by χ_ε defined by (102), (103).

In the case $m = 3$, the convergences (70) indicate that $\frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_\varepsilon) \simeq \mathbf{R}_0 \left(x, \frac{y_\varepsilon(x)}{\varepsilon} \right)$ in T_ε . The identification relations (71) can be improved, and further investigations show that in the linear isotropic case considered in this paper, there holds

$$\mathbf{R}_0(x, y) \simeq \left(-\frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2} y_1 - \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2} y_2 \right) \mathbf{e}_3 \otimes \mathbf{e}_3 + \mathbf{e}_y \left(\mathbf{q} \left(\frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2}, \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2}, y \right) \right), \quad (122)$$

where $\mathbf{q}(a_1, a_2, \cdot)$ is the solution of

$$\min_{\mathbf{q} \in H^1(S; \mathbb{R}^3)} \int_S g(\mathbf{e}_y \mathbf{q} + (-a_1 y_1 - a_2 y_2) \mathbf{e}_3 \otimes \mathbf{e}_3) dy, \quad g(\mathbf{A}) := \frac{E_T}{2(1+\nu_1)} \left(\frac{\nu_1}{1-2\nu_1} (\text{tr } \mathbf{A})^2 + \mathbf{A} : \mathbf{A} \right),$$

given by

$$\mathbf{q}(a_1, a_2, y) = \nu_1 \begin{pmatrix} a_1 \frac{y_1^2 - y_2^2}{2} + a_2 y_1 y_2 \\ a_2 \frac{y_2^2 - y_1^2}{2} + a_1 y_1 y_2 \\ 0 \end{pmatrix}.$$

Accordingly, the field χ_ε we are looking for should satisfy

$$\chi_{\varepsilon 3} \simeq 0 \quad \text{and} \quad \frac{1}{\varepsilon} \mathbf{e}(\chi_\varepsilon) \simeq \left(-\frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2} \frac{y_{\varepsilon 1}}{\varepsilon} - \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2} \frac{y_{\varepsilon 2}}{\varepsilon} \right) \mathbf{e}_3 \otimes \mathbf{e}_3 + \mathbf{e}_y \left(\mathbf{q} \left(\frac{\partial^2 \gamma_\Sigma(u_1)}{\partial x_3^2}, \frac{\partial^2 \gamma_\Sigma(u_2)}{\partial x_3^2}, \frac{y_\varepsilon}{\varepsilon} \right) \right).$$

These estimates are verified by χ_ε defined by (110).

5.2 Strong convergence

To fix the ideas, we assume $m = 1$ (the other cases are similar). The space \mathcal{D}_1 defined by (11), equipped with the inner product $a_1(\cdot, \cdot)$ defined by (22), is a Hilbert space in which $\mathcal{D}(\Omega; \mathbb{R}^3)$ is dense. Hence, fixing $\eta > 0$, we can choose $\phi \in \mathcal{D}(\Omega; \mathbb{R}^3)$ such that

$$a_1(\mathbf{u} - \phi, \mathbf{u} - \phi) < \eta, \quad (123)$$

and consider ϕ_ε defined by (96). There holds (see (19))

$$\begin{aligned} |\mathbf{u}_\varepsilon - \phi_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)}^2 &\leq C a_{\varepsilon, m}(\mathbf{u}_\varepsilon - \phi_\varepsilon, \mathbf{u}_\varepsilon - \phi_\varepsilon) \\ &= C \left(\underbrace{a_{\varepsilon, m}(\mathbf{u}_\varepsilon, \mathbf{u}_\varepsilon)}_{J_{1\varepsilon}} - 2 \underbrace{a_{\varepsilon, m}(\mathbf{u}_\varepsilon, \phi_\varepsilon)}_{J_{2\varepsilon}} + \underbrace{a_{\varepsilon, m}(\phi_\varepsilon, \phi_\varepsilon)}_{J_{3\varepsilon}} \right). \end{aligned} \quad (124)$$

Since \mathbf{u}_ε is the solution of (7), we have $J_{1\varepsilon} = \int_\Omega \mathbf{f} \cdot \mathbf{u}_\varepsilon dx$. We then deduce from the weak convergence of \mathbf{u}_ε to \mathbf{u} in $H_0^1(\Omega; \mathbb{R}^3)$ established in Proposition 4, that

$$\lim_{\varepsilon \rightarrow 0} J_{1\varepsilon} = \int_\Omega \mathbf{f} \cdot \mathbf{u} dx = a_1(\mathbf{u}, \mathbf{u}). \quad (125)$$

By (108), there holds

$$\lim_{\varepsilon \rightarrow 0} J_{2\varepsilon} = a_1(\mathbf{u}, \phi). \quad (126)$$

A straightforward computation yields

$$\lim_{\varepsilon \rightarrow 0} J_{3\varepsilon} = a_1(\phi, \phi). \quad (127)$$

Collecting (123), (124), (125), (126), and (127), we obtain

$$\limsup_{\varepsilon \rightarrow 0} |\mathbf{u}_\varepsilon - \phi_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)}^2 \leq C a_1(\mathbf{u} - \phi, \mathbf{u} - \phi) \leq C\eta. \quad (128)$$

It is easy to check that

$$\begin{aligned} \limsup_{\varepsilon \rightarrow 0} |\phi - \phi_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)} &= 0, \\ |\mathbf{u} - \phi|_{H_0^1(\Omega; \mathbb{R}^3)}^2 &\leq C a_1(\mathbf{u} - \phi, \mathbf{u} - \phi) \leq C\eta. \end{aligned} \quad (129)$$

We infer from (131) and (129) that

$$\begin{aligned} \limsup_{\varepsilon \rightarrow 0} |\mathbf{u} - \mathbf{u}_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)} &\leq \limsup_{\varepsilon \rightarrow 0} |\mathbf{u} - \phi|_{H_0^1(\Omega; \mathbb{R}^3)} + |\phi - \phi_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)} + |\phi_\varepsilon - \mathbf{u}_\varepsilon|_{H_0^1(\Omega; \mathbb{R}^3)} \\ &\leq C\sqrt{\eta}. \end{aligned} \quad (130)$$

By the arbitrary choice of η , the strong convergence of (\mathbf{u}_ε) to \mathbf{u} in $H_0^1(\Omega; \mathbb{R}^3)$ is proved. \square

Remark 3 In view of (124-127), we established indeed that

$$\limsup_{\varepsilon \rightarrow 0} a_{\varepsilon, m}(\mathbf{u}_\varepsilon - \phi_\varepsilon, \mathbf{u}_\varepsilon - \phi_\varepsilon) \leq C a_1(\mathbf{u} - \phi, \mathbf{u} - \phi), \quad (131)$$

for all field ϕ that can be used in the construction of the sequence of oscillating test fields (ϕ_ε) (defined by (96)). Looking back at the proof of the weak convergence, we notice that the proof remains unchanged if we only assume, instead of $\phi \in \mathcal{D}(\Omega; \mathbb{R}^3)$, that ϕ satisfies

$$\phi \in C(\overline{\Omega}; \mathbb{R}^3) \cap C^1(\overline{\Omega}^+; \mathbb{R}^3) \cap C^1(\overline{\Omega}^-; \mathbb{R}^3); \quad \frac{\partial \phi}{\partial x_3} \in C(\overline{\Omega}; \mathbb{R}^3); \quad \phi = 0 \quad \text{on } \partial\Omega, \quad (132)$$

and

$$\frac{\partial^2 \phi_\alpha}{\partial x_3^2} \in C(\overline{\Omega}; \mathbb{R}^3) \quad \text{for } \alpha \in \{1, 2\} \quad \text{if } m = 3. \quad (133)$$

Due to the discontinuity of $\sigma_0 \mathbf{e}_1$ across Σ (see (10), (12)), we can not expect the derivative with respect to x_1 of the solution \mathbf{u} of the limit problem to be continuous on $\overline{\Omega}$. However, for a sufficiently regular datum \mathbf{f} , we can expect that

$$\mathbf{u} \text{ satisfies (132) and (133).} \quad (134)$$

Under (134), we can substitute \mathbf{u} for ϕ in the definition of ϕ_ε . Let us denote by $\tilde{\mathbf{u}}_\varepsilon$ the field obtained in this way (to avoid the confusion with the solution \mathbf{u}_ε of the elasticity problem (7)). We then deduce from (131) that

$$\limsup_{\varepsilon \rightarrow 0} a_{\varepsilon, m}(\mathbf{u}_\varepsilon - \tilde{\mathbf{u}}_\varepsilon, \mathbf{u}_\varepsilon - \tilde{\mathbf{u}}_\varepsilon) = 0.$$

In particular, by the definition (19) of $a_{\varepsilon, m}$, we get, since $\tilde{\mathbf{u}}_\varepsilon = \tilde{\chi}_\varepsilon$ on T_ε , denoting by $\tilde{\chi}_\varepsilon$ the field deduced by substituting \mathbf{u} for ϕ in (102), (110):

$$\limsup_{\varepsilon \rightarrow 0} \frac{1}{\varepsilon^m} \int_{T_\varepsilon} \left\{ \frac{E_T}{1 + \nu_1} \left(\frac{\nu_1}{1 - 2\nu_1} \text{tr}(\mathbf{e}(\mathbf{u}_\varepsilon - \tilde{\chi}_\varepsilon)) \mathbf{I} + \mathbf{e}(\mathbf{u}_\varepsilon - \tilde{\chi}_\varepsilon) \right) : \mathbf{e}(\mathbf{u}_\varepsilon - \tilde{\chi}_\varepsilon) \right\} dx = 0.$$

This implies, since $|T_\varepsilon| \simeq \varepsilon$, that

$$\limsup_{\varepsilon \rightarrow 0} \frac{1}{\varepsilon^{m-1}} \int_{T_\varepsilon} |\mathbf{e}(\mathbf{u}_\varepsilon - \tilde{\chi}_\varepsilon)|^2 dx = 0. \quad (135)$$

If $m = 1$, it follows from (104) that

$$\limsup_{\varepsilon \rightarrow 0} \int_{T_\varepsilon} \left| \mathbf{e}(\mathbf{u}_\varepsilon) - \frac{\partial u_3}{\partial x_3} \begin{pmatrix} -\nu_1 & 0 & 0 \\ 0 & -\nu_1 & 0 \\ 0 & 0 & 1 \end{pmatrix} \right|^2 dx = 0,$$

justifying (121).

If $m = 3$, we deduce from (111) and (135) that

$$\limsup_{\varepsilon \rightarrow 0} \int_{T_\varepsilon} \left| \frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_\varepsilon) - \left(\frac{\partial^2 u_1}{\partial x_3^2} \frac{y_\varepsilon(x')_1}{\varepsilon} + \frac{\partial^2 u_2}{\partial x_3^2} \frac{y_\varepsilon(x')_2}{\varepsilon} \right) \begin{pmatrix} \nu_1 & 0 & 0 \\ 0 & \nu_1 & 0 \\ 0 & 0 & -1 \end{pmatrix} \right|^2 dx = 0,$$

which shows that

$$\frac{1}{\varepsilon} \mathbf{e}(\mathbf{u}_\varepsilon) \simeq \left(\frac{\partial^2 u_1}{\partial x_3^2} \frac{y_\varepsilon(x')_1}{\varepsilon} + \frac{\partial^2 u_2}{\partial x_3^2} \frac{y_\varepsilon(x')_2}{\varepsilon} \right) \begin{pmatrix} \nu_1 & 0 & 0 \\ 0 & \nu_1 & 0 \\ 0 & 0 & -1 \end{pmatrix} \quad \text{in } T_\varepsilon,$$

in agreement with (122).

6 Concluding remarks and open problems

1. The comparison of the results of Theorem 1 with some of the results obtained in [11], [12] and [13] for the case of an homogeneous layer is interesting: indeed in these cases Σ behaves as a "material surface" of plate-like type with membrane Kirchhoff-Love energy for $m = 1$ and with bending energy for $m = 3$. In the present case Theorem 1 means that Σ always behaves as a "material surface". For $m = 1$ the "material surface" is *without membrane energy* in the direction of the plane Σ orthogonal to the direction of the fibres. For $m = 3$ the "material surface" Σ is *without bending energy* in the direction orthogonal to the fibres. In the papers [12] and [13] it is also considered the more general situation of a surface Σ and of a shell-like inclusion; the results obtained in this situation suggest to study the case of fibres that

are tubular neighbourhoods of a family of lines of principal curvature of the surface Σ .

2. Here we have considered the case of isotropic materials and of fibres with "constant" section. In this case the study of asymptotic theory of slender beams gives models where *torsion and traction are uncoupled*. The case of anisotropic materials and/or fibres whose section "varies with ε " deserves special attention. Indeed in this case asymptotic theory of slender beams *can present coupling phenomena between torsion and traction* (see, e.g., [18], [24], [25]), or *non-local effects* (as in homogenization, see, e.g., [18], [25], [4], [9]). A research in this direction is actually done by the first author (M. B.).

3. The transmission conditions on Σ imply that some "singular behaviour" can appear there and at $\partial\Sigma \cap \partial\Omega$; these "singular behaviours" could be analysed for instance with the methods of [19].
