# Closed-forms of Kirchhoff elastic rods shape and sensitivity in the planar case

#### Abstract

In this report we give closed-forms of Kirchhoff 3-D elastic rods curvature in terms of elliptic functions and, by treating planar rods as a special case, we show we can also obtain closed-forms of planar rods shape, sensitivity and total elastic energy.


## 1 General case of 3-D rods

Consider an inextensible, non-shearable and unit length linearly elastic rod. The shape of the rod traces a curve that we will describe by the mapping $q:[0,1] \rightarrow S E(3)$. The position along the rod is parametrized by $t \in[0,1]$ and we will name "base" and "tip" of the rod its extremity at $t=0$ and $t=1$ respectively. Let the mappings $u_{1}(t), u_{2}(t), u_{3}(t)$ such that $u_{i}:[0,1] \rightarrow \mathbb{R}$ be axial and bending rod strains respectively, and $c_{1}, c_{2}, c_{3}$ be the constants that reflect its elasticity properties. As in [3], we say the elastic rod is in static equilibrium in the sense of Kirchhoff if it locally minimizes the elastic energy defined by

$$
\begin{equation*}
E_{e l}=\frac{1}{2} \int_{0}^{1} \sum_{i=1}^{3} c_{i} u_{i}^{2} d t \tag{1.1}
\end{equation*}
$$

Without loss of generality, we will also assume that the base of the rod is held fixed at the origin, i.e. $q(0)=e$ where $e$ is the identity element of $S E(3)$. Under these assumptions, we will denote by $\mathcal{B}$ the set of positions that the other extremity of the $\operatorname{rod} q(1)$ can reach. As shown in [2], the problem of static equilibrium of such rods can be formulated as an optimal control problem by

\text { subject to } & \dot{q}=q\left(\sum_{i=1}^{3} u_{i} X_{i}+X_{4}\right)  \tag{1.2}\\
& q(0)=e, \quad q(1)=b
\end{array}
$$

for some $b \in \mathcal{B}$ and where

$$
\begin{array}{lll}
X_{1} & =\left[\begin{array}{cccc}
0 & 0 & 0 & 0 \\
0 & 0 & -1 & 0 \\
0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right] & X_{2}=\left[\begin{array}{cccc}
0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 \\
-1 & 0 & 0 & 0 \\
0 & 0 & 0
\end{array}\right]
\end{array} X_{3}=\left[\begin{array}{cccc}
0 & -1 & 0 & 0 \\
1 & 0 & 0 & 0 \\
0 & 0 & 0 & 0 \\
0 & 0 & 0 & 0
\end{array}\right] .
$$

is a basis for $\mathfrak{s e}(3)$, the Lie algebra of $S E(3)$. Note that when solving this optimal control problem, the rod tip position $b$ is not an input.

[^0]In these conditions, the Maximum Principle states that solutions to this optimal control problem are the projections of extremal curves defined on the cotangent bundle $T^{*} S E(3)$ onto $S E(3)$. Thanks to the Lie Group structure of $S E(3)$, the Hamiltonian can be reduced on the dual of the Lie algebra $\mathfrak{s e}(3)^{*}$ and the corresponding (time-varying) Hamiltonian vector fields $\mu:[0,1] \rightarrow \mathfrak{s e}(3)^{*}$ can be expressed by

\dot{\mu_{2}}=\mu_{6}+\frac{\mu_{1} \mu_{3}}{c_{1}}-\frac{\mu_{1} \mu_{3}}{c_{3}} \\
\dot{\mu_{3}}=-\mu_{5}+\frac{\mu_{1} \mu_{2}}{c_{2}}-\frac{\mu_{1} \mu_{2}}{c_{1}} \\
\dot{\mu_{4}}=\frac{\mu_{3} \mu_{5}}{c_{3}}-\frac{\mu_{2} \mu_{6}}{c_{2}} \\
\dot{\mu_{5}}=\frac{\mu_{1} \mu_{6}}{c_{1}}-\frac{\mu_{3} \mu_{4}}{c_{3}} \\
\dot{\mu_{6}}=\frac{\mu_{2} \mu_{4}}{c_{2}}-\frac{\mu_{1} \mu_{5}}{c_{1}}
\end{array}\right.
$$

Let $\mathcal{A}$ be the set homeomorphic to $\mathbb{R}^{6}$ and $a \in \mathcal{A}$ such that $a_{i} \triangleq \mu_{i}(0), i \in\{1, \ldots, 6\}$. It has been shown in [2] that coordinates in $\mathcal{A}$ offer a global parameterization to the set of static equilibrium configuration for the rod. In other words, we can describe configurations of quasi-static 3 -D elastic rods using the 6-dimensional configuration space $\mathcal{A}$.

Assuming isotropy and normalized elasticity constants such that $c_{i}=1$ for $i \in\{1,2,3\}$, we have from (1.3) $\dot{\mu_{1}}=0$. Then $\mu_{1}$ is a constant of motion with $\mu_{1}=a_{1}$ and

\dot{\mu_{2}}=\mu_{6}  \tag{1.4}\\
\dot{\mu_{3}}=-\mu_{5} \\
\dot{\mu_{4}}=\mu_{3} \mu_{5}-\mu_{2} \mu_{6} \\
\dot{\mu_{5}}=a_{1} \mu_{6}-\mu_{3} \mu_{4} \\
\dot{\mu_{6}}=\mu_{2} \mu_{4}-a_{1} \mu_{5}
\end{array}\right.
$$

The signed curvature $\kappa$ and the torsion $\tau$ of the curve can be expressed in terms of $\mu_{i}, i \in$ $\{1, \ldots, 6\}$ by

$$
\kappa^{2}=\mu_{2}^{2}+\mu_{3}^{2} \quad \tau=\mu_{1}-\frac{\mu_{2} \mu_{5}+\mu_{3} \mu_{6}}{\mu_{2}^{2}+\mu_{3}^{2}}
$$

and, as mentioned in [2], the differential system (1.4) is equivalent to

2 \ddot{\kappa}+\kappa^{3}-2 \kappa\left(\tau-\lambda_{1}\right)^{2}=\lambda_{2} \kappa \\
\kappa^{2}\left(\tau-\lambda_{1}\right)=\lambda_{3} \tag{1.5b}
\end{array}
$$

where the constants of integration are given by

$$

\lambda_{1} \triangleq \frac{a_{1}}{2} \\
\lambda_{2} \triangleq a_{2}^{2}+a_{3}^{2}+2 a_{4}-\frac{a_{1}^{2}}{2} \\
\lambda_{3} \triangleq \frac{a_{1}}{2}\left(a_{2}^{2}+a_{3}^{2}\right)-\left(a_{2} a_{5}+a_{3} a_{6}\right)
\end{array}\right.
$$

Substituting (1.5b) into (1.5a) and integrating, we obtain

$$
\begin{equation*}
\dot{\kappa}^{2}+\frac{1}{4} \kappa^{4}+\lambda_{3}^{2} \kappa^{-2}-\frac{\lambda_{2}}{2} \kappa^{2}=\lambda_{4} \tag{1.6}
\end{equation*}
$$

where the constant of integration $\lambda_{4}$ is given by

\lambda_{4} \triangleq a_{5}^{2}+a_{6}^{2}-\frac{1}{4}\left(a_{2}^{2}+a_{3}^{2}\right)^{2}+\frac{1}{2}\left(a_{2}^{2}+a_{3}^{2}\right)\left(a_{1}^{2}+2 a_{4}\right)-a_{1}\left(a_{2} a_{5}+a_{3} a_{6}\right)
$$

By making the change of variable $v=\kappa^{2}$, (1.6) transforms to

$$
\begin{equation*}
\dot{v}^{2}+v^{3}-2 \lambda_{2} v^{2}-4 \lambda_{4} v+4 \lambda_{3}^{2}=0 \tag{1.7}
\end{equation*}
$$



Figure 1: Plot of the cubic polynomial $P(v)$ with respect to the squared curvature $v$. Hatched regions correspond to impossible values illustrating that the only valid range for $v$ is given by $\alpha_{2}$ and $\alpha_{3}$, the zeros of $P(v)$.

As already stated in [4], this equation is in the form $\dot{v}^{2}=P(v)$ with P is the cubic polynomial

$$
\begin{equation*}
P(v) \triangleq-v^{3}+2 \lambda_{2} v^{2}+4 \lambda_{4} v-4 \lambda_{3}^{2} . \tag{1.8}
\end{equation*}
$$

Let $-\alpha_{1}, \alpha_{2}, \alpha_{3}$ be the zeros of the polynomial $P(v)$ such that

$$
\begin{equation*}
-\alpha_{1} \leqslant 0 \leqslant \alpha_{2} \leqslant \alpha_{3} \tag{1.9}
\end{equation*}
$$

As $P( \pm \infty)=\mp \infty$ and $P(0)=-4 \lambda_{3}^{2} \leqslant 0, P(v)$ is in the form illustrated in figure 1 .
Also, we have $v \geqslant 0$ and $P(v) \geqslant 0$ as they are both squares, so $v \in\left[\alpha_{2}, \alpha_{3}\right]$.
The polynomial $P(v)$ can be rewritten for its zeros by

$$
P(v)=-\left(v+\alpha_{1}\right)\left(v-\alpha_{2}\right)\left(v-\alpha_{3}\right)
$$

We can express the polynomial zeros $-\alpha_{1}, \alpha_{2}, \alpha_{3}$ from the constants of integrations $\lambda_{i}$ by

$$
\begin{align*}
\alpha_{1}-\alpha_{2}-\alpha_{3} & =-2 \lambda_{2} \\
\alpha_{1} \alpha_{2}+\alpha_{1} \alpha_{3}-\alpha_{2} \alpha_{3} & =4 \lambda_{4}  \tag{1.10}\\
\alpha_{1} \alpha_{2} \alpha_{3} & =4 \lambda_{3}^{2}
\end{align*}
$$

The squared curvature $v$ can be expressed in terms of elliptic functions by

$$
\begin{equation*}
v(t)=\alpha_{3}\left(1-n \operatorname{sn}^{2}(r(t+\varphi) \mid m)\right) \tag{1.11}
\end{equation*}
$$

the parameter $m$, the characteristic $n$ and $r$ can be expressed from the polynomial zeros by

$$
\begin{equation*}
m=\frac{\alpha_{3}-\alpha_{2}}{\alpha_{3}+\alpha_{1}} \quad n=\frac{\alpha_{3}-\alpha_{2}}{\alpha_{3}} \quad r=\frac{1}{2} \sqrt{\alpha_{3}+\alpha_{1}} \tag{1.12}
\end{equation*}
$$

and the phase $\varphi$ can be retrieved from (1.11) for $t=0$ and using that $y(0)=a_{2}^{2}+a_{3}^{2}$. Note that from (1.9), we have $0 \leqslant m \leqslant n \leqslant 1$.

As outlined in [3], it has been shown the Hamiltonian vector fields in (1.4) is integrable and can be expressed in the following form

\mu_{2}=\kappa \sin \psi  \tag{1.13}\\
\mu_{3}=\kappa \cos \psi \\
\mu_{4}=\frac{1}{2}\left(\lambda_{2}+\frac{a_{1}^{2}}{2}-v\right) \\
\mu_{5}=\gamma \sin \vartheta \\
\mu_{6}=\gamma \cos \vartheta
\end{array}\right.
$$

where

$$
\psi(t)=\lambda_{1} t-\frac{\lambda_{3}}{\alpha_{3} r}(\Pi(n, \operatorname{am}(r(t+\varphi) \mid m) \mid m)-\Pi(n, \operatorname{am}(r \varphi \mid m) \mid m))+\psi(0)
$$

with $\Pi(n, u \mid m)$ the elliptic integral of the third kind and $\operatorname{am}(u \mid m)$ is the Jacobi amplitude.
Using (1.4), polar coordinates of $\mu_{5}$ and $\mu_{6}$ in (1.13) can be expressed in terms of the curvature $\kappa$ and the angle $\psi$ and their respective derivatives by

$$
\left\{\begin{array}{l}
\mu_{5}=-\dot{\kappa} \cos \psi-\kappa \dot{\psi} \sin \psi  \tag{1.14}\\
\mu_{6}=\dot{\kappa} \sin \psi+\kappa \dot{\psi} \cos \psi
\end{array}\right.
$$

The form (1.14) is preferable for computational cost motivations, thus explicit formulation of polar coordinates $\gamma$ and $\vartheta$ are not detailed in this report.

## 2 Planar case

Although neither the curve $q(t)$ nor the rod sensitivity $\frac{\partial q(t)}{\partial a}$ can be explicitly expressed in the general 3-D case, we will show in this section that closed forms can be obtained in the planar case which can be treated as a particular case of the previously presented model.

### 2.1 Curvature and internal wrenches

Considering only planar curves $q(t)$ in the $x y$-plane with $q=(0,0, \theta, x, y, 0)^{T}$, Hamiltonian vector fields defined in (1.3) simplify to

\left\{\begin{array}{l}
\dot{\mu_{1}}=0  \tag{2.1}\\
\dot{\mu_{2}}=0 \\
\dot{\mu_{3}}=-\mu_{5} \\
\dot{\mu_{4}}=\mu_{3} \mu_{5} \\
\dot{\mu_{5}}=-\mu_{3} \mu_{4} \\
\dot{\mu_{6}}=0
\end{array}\right.
$$

Closed-forms of rod internal wrenches $\mu(t)$ defined in (??) reduce to

$$
\left\{\begin{array}{l}
\mu_{1}=0  \tag{2.2}\\
\mu_{2}=0 \\
\mu_{3}=\kappa \\
\mu_{4}=-\frac{1}{2}\left(\kappa^{2}+\lambda_{2}\right) \\
\mu_{5}=-\dot{\kappa} \\
\mu_{6}=0
\end{array}\right.
$$

And constants of integration defined in (1) simplify to

$$
\left\{\begin{array}{l}
\lambda_{1}=0 \\
\lambda_{2}=a_{3}^{2}+2 a_{4} \\
\lambda_{3}=0 \\
\lambda_{4}=a_{5}^{2}-a_{3}^{2}\left(\frac{1}{4} a_{3}^{2}+a_{4}\right)
\end{array}\right.
$$

We retrieve the same results as we would have obtain by applying the same problem formulation on the Lie Group $S E(2)$ rather than $S E(3)$. Therefore, in the rest of this section we will restrict to solutions of (1.2) that are similar to trajectories on $S E(2)$, which are generated by the subset of initial conditions $\left\{a \in \mathcal{A}:\left(a_{1}, a_{2}, a_{6}\right)=(0,0,0)\right\}$.

In the following equations, when referring to an elliptic function pq, we will simplify the notation $\mathrm{pq}(u \mid m)$ to $\mathrm{pq} u$. Also, let us define

\Gamma(t) \triangleq r(t+\varphi)
$$

and the following constants of motion that be needed in the following developments

$$
\begin{aligned}
\varepsilon & \triangleq \operatorname{sgn}\left(a_{3}\right) \\
\Gamma_{0} & \triangleq \Gamma(0) \\
\delta & \triangleq \lambda_{2}^{2}+4 \lambda_{4} \\
\varpi & \triangleq \sqrt{\frac{1}{n}\left(1-\frac{a_{3}^{2}}{\alpha_{3}}\right)}
\end{aligned}
$$

A general expression for the phase $\varphi$ in the planar case would be

$$
\varphi=\operatorname{sgn}\left(a_{3} a_{5}\right) r^{-1} \operatorname{arcsn}(\varpi \mid m)
$$

where arcsn is the inverse of the Jacobi elliptic function sn.

### 2.1.1 Expression of the curvature

In the planar case, as $\lambda_{3}=0$, the polynomial $P(v)$ simplifies to

$$
P(v)=-v^{3}+2 \lambda_{2} v^{2}+4 \lambda_{4} v
$$

so $P(v)$ has one trivial zero at $v=0$.
From (1.9), we can distinguish three cases as outlined in [4] and [5]:

- Case I: $\lambda_{4}>0$

Using (1.10), we have that

$$
\lambda_{1}\left(\lambda_{2}+\lambda_{3}\right)>\lambda_{2} \lambda_{3} .
$$

This imposes the choice for the zeros to

$$
\left\{\begin{array}{l}
\alpha_{1}=-\lambda_{2}+\sqrt{\delta} \\
\alpha_{2}=0 \\
\alpha_{3}=\lambda_{2}+\sqrt{\delta}
\end{array}\right.
$$

From (1.12) we get $n=1$, so the squared curvature formula in (1.11) simplifies to

$$
\begin{aligned}
v(t) & =\alpha_{3}\left(1-\mathrm{sn}^{2} \Gamma(t)\right) \\
& =\alpha_{3} \mathrm{cn}^{2} \Gamma(t) .
\end{aligned}
$$

Then the signed curvature is given by

$$
\begin{equation*}
\kappa(t)=\varepsilon \sqrt{\alpha_{3}} \operatorname{cn} \Gamma(t) . \tag{2.3}
\end{equation*}
$$

The curvature $\kappa(t)$ oscillates between $\sqrt{\alpha_{3}}$ and $-\sqrt{\alpha_{3}}$ and the resulting curve $q(t)$ is called a "wavelike" elastica.

- Case II: $\lambda_{4}<0$ Using (1.10), we have

$$
\lambda_{1}\left(\lambda_{2}+\lambda_{3}\right)<\lambda_{2} \lambda_{3}
$$

This imposes the choice for the zeros to

$$
\left\{\begin{array}{l}
\alpha_{1}=0 \\
\alpha_{2}=\lambda_{2}-\sqrt{\delta} \\
\alpha_{3}=\lambda_{2}+\sqrt{\delta}
\end{array}\right.
$$

From (1.12) we get $n=m$, so the squared curvature formula in (1.11) simplifies to

$$
\begin{aligned}
v(t) & =\alpha_{3}\left(1-m \operatorname{sn}^{2} \Gamma(t)\right) \\
& =\alpha_{3} \mathrm{dn}^{2} \Gamma(t)
\end{aligned}
$$

Then the signed curvature is given by

$$
\begin{equation*}
\kappa(t)=\varepsilon \sqrt{\alpha_{3}} \operatorname{dn} \Gamma(t) \tag{2.4}
\end{equation*}
$$

The curvature $\kappa(t)$ is non-vanishing and the resulting curve $q(t)$ is called a "orbit-like" elastica.

- Case III: $\lambda_{4}=0$ This borderline case implies the polynomial $P(v)$ reduces to

$$
P(v)=-v^{3}+2 \lambda_{2} v^{2}
$$

which has a double zero.
Using first equation of (1.10), only one choice is possible for the zeros $\alpha_{i}$ :

$$
\left\{\begin{array}{l}
\alpha_{1}=\alpha_{2}=0 \\
\alpha_{3}=\left|2 \lambda_{2}\right|
\end{array}\right.
$$

which leads to the signed curvature

$$
\begin{equation*}
\kappa(t)=\varepsilon \sqrt{\alpha_{3}} \operatorname{sech} \Gamma(t) \tag{2.5}
\end{equation*}
$$

This corresponds to the borderline case where the curvature is non-periodic.

### 2.1.2 Reduction to a unique formulation of the curvature

These cases can be reduced to a single formulation of the curvature by allowing the parameter $m$ to be any positive or null real and applying the Jacobi's real transformation (see [1] $\S 16.11$ ). By relaxing the constraint on the zeros $\alpha_{i}$ given in (1.9), and keeping only one fixed choice on the zeros that we will denote by $\alpha^{\prime}$ such that

$$
\left\{\begin{array}{l}
\alpha_{1}^{\prime}=0 \\
\alpha_{2}^{\prime}=\lambda_{2}-\sqrt{\delta} \\
\alpha_{3}^{\prime}=\lambda_{2}+\sqrt{\delta}
\end{array}\right.
$$

In this form, $\alpha_{3}^{\prime}$ is positive as $\sqrt{\delta}>\left|\lambda_{2}\right|$ but $\alpha_{2}^{\prime}$ can now be negative. Note that we still have $\alpha_{3}^{\prime} \geqslant \alpha_{2}^{\prime}$.

Using same forms as in (1.12), the elliptic parameter $m^{\prime}$ and $r^{\prime}$ by

$$
m^{\prime}=\frac{\alpha_{3}^{\prime}-\alpha_{2}^{\prime}}{\alpha_{3}^{\prime}} \quad r^{\prime}=\frac{1}{2} \sqrt{\alpha_{3}^{\prime}}
$$

but as mentioned before, the new elliptic parameter $m^{\prime}$ is only constrained to in $[0, \infty)$. Then, the signed curvature can be expressed by a unique expression by

$$
\begin{equation*}
\kappa(t)=\varepsilon \sqrt{\alpha_{3}^{\prime}} \operatorname{dn}\left(\left.\frac{\sqrt{\alpha_{3}^{\prime}}}{2}(t+\phi) \right\rvert\, m^{\prime}\right) \tag{2.6}
\end{equation*}
$$

When $m^{\prime}>1$, the Jacobi's real transformation can be applied to reduce to a parameter $m$ such that $0 \leqslant m \leqslant 1$ and we retrieve the previously described cases.

### 2.1.3 Explicit formulation of rod total elastic energy

Recall from (1.1) the total elastic energy of the rod is given by

$$
\begin{aligned}
E_{e l} & =\frac{1}{2} \int_{0}^{1} u_{3}(t)^{2} d t \\
& =\frac{1}{2} \int_{0}^{1} \kappa(t)^{2} d t
\end{aligned}
$$

Using the unique formulation of the curvature $\kappa(t)$ given in (2.6) can be integrated to give an explicit formulation in terms of the elliptic integral of the second kind by

$$
E_{e l}=\alpha_{3}^{\prime} \mathrm{E}\left(\left.\frac{\sqrt{\alpha_{3}^{\prime}}}{2}(t+\phi) \right\rvert\, m^{\prime}\right)
$$

### 2.2 Integration of the curve $q(t)$

From the differential system defined in (1.2), it follows that

$$
\dot{\theta}=u_{3}=\kappa \quad \dot{x}=\cos \theta \quad \dot{y}=\cos \theta .
$$

Using (2.2), the integration of the curvature is given by

$$
\begin{align*}
\cos \theta(t) & =\beta_{1}(0) \beta_{1}(t)+4 \beta_{2}(0) \beta_{2}(t)  \tag{2.7a}\\
\sin \theta(t) & =2 \varepsilon\left(\beta_{1}(0) \beta_{2}(t)-\beta_{2}(0) \beta_{1}(t)\right)  \tag{2.7b}\\
x(t) & =\beta_{1}(0) \int \beta_{1}(t)+4 \beta_{2}(0) \int \beta_{2}(t)  \tag{2.7c}\\
y(t) & =2 \varepsilon\left(\beta_{1}(0) \int \beta_{2}(t)-\beta_{2}(0) \int \beta_{1}(t)\right) . \tag{2.7~d}
\end{align*}
$$

The functions $\beta_{1}(t)$ and $\beta_{2}(t)$ can be explicitly given using Jacobi elliptic functions and the elliptic integral of second kind $\mathrm{E}(u \mid m)$ in the three cases previously described as follows

- Case I: $\lambda_{4}>0$

Integrating the curvature in (2.3) (see [1] §16.24) leads to

$$

& \frac{\partial \mathrm{E}(z \mid m)}{\partial z}=\sqrt{1-m \sin ^{2} z} \\
& \frac{\partial \mathrm{E}(z \mid m)}{\partial m}=\frac{\mathrm{E}(z \mid m)-\mathrm{F}(z \mid m)}{2 m}
\end{aligned}
$$

Noting the simplification

$$
\begin{aligned}
\frac{\partial \mathrm{E}(\operatorname{am} \Gamma(t))}{\partial \mathrm{am} \Gamma(t)} & =\sqrt{1-m \sin ^{2}(\operatorname{am\Gamma } \Gamma(t))} \\
& =\sqrt{1-\mathrm{sn}^{2} \Gamma(t)} \\
& =\operatorname{dn} \Gamma(t)
\end{aligned}
$$

and that

$$
\mathrm{F}(\operatorname{am} \Gamma(t))=\Gamma(t)
$$

we finally have all the expressions to compute the derivative of $\mathrm{E}(\mathrm{am} \Gamma(t))$ with respect to $a$ by applying the chain rule

$$
\begin{aligned}
\frac{\partial \mathrm{E}(\operatorname{am} \Gamma(t))}{\partial a} & =\frac{\partial \mathrm{E}(\mathrm{am} \Gamma(t))}{\partial \mathrm{am} \Gamma(t)} \frac{\partial \mathrm{am} \Gamma(t)}{\partial a}+\frac{\partial \mathrm{E}(\mathrm{am} \Gamma(t))}{\partial m} \frac{\partial m}{\partial a} \\
& =\operatorname{dn}^{2} \Gamma(t)\left(\frac{\partial \Gamma(t)}{\partial a}+\frac{\mathrm{E}(\mathrm{am} \Gamma(t))-\operatorname{cd} \Gamma(t) \operatorname{sn} \Gamma(t)}{2(m-1)} \frac{\partial m}{\partial a}\right)
\end{aligned}
$$

Then, most of these forms simplify in the three previously introduced cases and we can give the explicit forms of the derivatives of functions $\beta_{1}(t)$ and $\beta_{2}(t)$ (and their respective integrals) with respect to $a$ :

- Case I: $\lambda_{4}>0$

From (2.8) and (2.9), we get

$$
\begin{aligned}
\frac{\partial \beta_{1}(t)}{\partial a} & =4 \operatorname{dn} \Gamma(t) \frac{\partial \operatorname{dn} \Gamma(t)}{\partial a} \\
\frac{\partial \beta_{2}(t)}{\partial a} & =\operatorname{dn} \Gamma(t) \frac{\partial \operatorname{sn} \Gamma(t)}{\partial a}+\operatorname{sn} \Gamma(t) \frac{\partial \mathrm{dn} \Gamma(t)}{\partial a} \\
\frac{\partial \int \beta_{1}(t)}{\partial a} & =\frac{2}{r}\left(\left(\frac{\partial \mathrm{E}(\Gamma(t))}{\partial a}-\frac{\partial \mathrm{E}\left(\Gamma_{0}\right)}{\partial a}\right)-\frac{1}{r}\left(\mathrm{E}(\Gamma(t))-\mathrm{E}\left(\Gamma_{0}\right)\right) \frac{\partial r}{\partial a}\right) \\
\frac{\partial \int \beta_{2}(t)}{\partial a} & =\frac{1}{r}\left(\frac{1}{r}\left(\operatorname{cn} \Gamma(t)-\operatorname{cn} \Gamma_{0}\right) \frac{\partial r}{\partial a}-\left(\frac{\partial \operatorname{cn} \Gamma(t)}{\partial a}-\frac{\partial \mathrm{cn} \Gamma_{0}}{\partial a}\right)\right)
\end{aligned}
$$

- Case II: $\lambda_{4}<0$

From (2.10) and (2.11), we get

$$
\begin{aligned}
\frac{\partial \beta_{1}(t)}{\partial a}= & -4 \operatorname{sn} \Gamma(t) \frac{\partial \operatorname{sn} \Gamma(t)}{\partial a} \\
\frac{\partial \beta_{2}(t)}{\partial a}= & \operatorname{cn} \Gamma(t) \frac{\partial \operatorname{sn} \Gamma(t)}{\partial a}+\operatorname{sn} \Gamma(t) \frac{\partial \mathrm{cn} \Gamma(t)}{\partial a} \\
\frac{\partial \int \beta_{1}(t)}{\partial a}= & \frac{1}{m}\left(\frac{t(1-m)}{m} \frac{\partial m}{\partial a}+\frac{2}{r}\left(\mathrm{E}(\operatorname{am} \Gamma(t))-\mathrm{E}\left(\operatorname{am} \Gamma_{0}\right)\right)\left(\frac{1}{r} \frac{\partial r}{\partial a}-\frac{1}{m} \frac{\partial m}{\partial a}\right)\right. \\
& \left.+\frac{2}{r}\left(\frac{\partial \mathrm{E}(\Gamma(t))}{\partial a}-\frac{\partial \mathrm{E}\left(\Gamma_{0}\right)}{\partial a}\right)\right) \\
\frac{\partial \int \beta_{2}(t)}{\partial a}= & \frac{1}{r m}\left(\left(\operatorname{dn} \Gamma(t)-\operatorname{dn} \Gamma_{0}\right)\left(\frac{1}{m} \frac{\partial m}{\partial a}+\frac{1}{r} \frac{\partial r}{\partial a}\right)-\left(\frac{\partial \operatorname{dn} \Gamma(t)}{\partial a}-\frac{\partial \operatorname{dn} \Gamma_{0}}{\partial a}\right)\right)
\end{aligned}
$$

- Case III: $\lambda_{4}=0$

From (2.12) and (2.13), we get

$$
\begin{aligned}
\frac{\partial \beta_{1}(t)}{\partial a} & =-2 \operatorname{sech}^{2} \Gamma(t) \tanh \Gamma(t) \\
\frac{\partial \beta_{2}(t)}{\partial a} & =\operatorname{sech} \Gamma(t)\left(1-2 \tanh ^{2} \Gamma(t)\right) \\
\frac{\partial \int \beta_{1}(t)}{\partial a} & =\frac{2}{r}\left(\frac{1}{r} \frac{\partial r}{\partial a}\left(\tanh \Gamma(t)-\tanh \Gamma_{0}\right)-\left(\tanh ^{2} \Gamma(t)-\tanh ^{2} \Gamma_{0}\right)\right) \\
\frac{\partial \int \beta_{2}(t)}{\partial a} & =\frac{1}{r}\left(\tanh \Gamma(t) \operatorname{sech} \Gamma(t)-\tanh \Gamma_{0} \operatorname{sech} \Gamma_{0}-\frac{1}{r}\left(\operatorname{sech} \Gamma(t)-\operatorname{sech} \Gamma_{0}\right)\right)
\end{aligned}
$$
