# GOLDMAN ALGEBRA, OPERS AND THE SWAPPING ALGEBRA 

FRANÇOIS LABOURIE


#### Abstract

We define a Poisson Algebra called the swapping algebra using the intersection of curves in the disk. We interpret a subalgebra of the fraction algebra of the swapping algebra - called the algebra of multifractions - as an algebra of functions on the space of cross ratios and thus as an algebra of functions on the Hitchin component as well as on the space of $\mathrm{SL}_{n}(\mathbb{R})$-opers with trivial holonomy. We relate this Poisson algebra to the Atiyah-Bott-Goldman symplectic structure and to the Drinfel'd-Sokolov reduction. We also prove an extension of Wolpert formula.


## 1. Introduction

The purpose of this article is threefold. We first introduce the swapping algebra which is a Poisson algebra generated - as a commutative algebra - by pairs of points on the circle. Then we relate this construction to two well known Poisson structures:

- the Poisson structure of the character variety of representations of a surface group in $\mathrm{PSL}_{n}(\mathbb{R})$ discovered by Atiyah, Bott and Goldman [1, 6, 7]
- the Poisson structure of the space of $\mathrm{PSL}_{n}(\mathbb{R})$-opers introduced by Dickey, Gel'fand and Magri and described in a geometrical way by Drinfel'd and Sokolov [18, 4, 3].
One way to interpret heuristically these relations is to say that the swapping algebra embodies the notion of a "Poisson structure" for the space of all cross ratios, space that contains both the space of opers and the "universal (in genus) Hitchin component". As a byproduct of the methods of this paper, we also produce a generalisation of the Wolpert formula which computes the brackets of length functions for the Hitchin component.

We now explain more precisely the content of this article.
1.1. The swapping algebra. Our first result is the construction of the swapping algebra. To avoid cumbersome expressions, we shall denote most of the time the ordered pair $(X, x)$ of points of the circle by the concatenated symbol $X x$. We recall in Paragraph 2.1 the definition and properties of the linking number $[X x, Y y]$ of the two pairs $(X, x)$ and $(Y, y)$. If P is a subset of the circle, we denote by $\mathcal{L}(\mathrm{P})$ the commutative associative algebra generated by pairs of points of P with the relations $X X=0$, for all $X$ in P . Our starting result is the following

Theorem 1. [Swapping Bracket] For every number $\alpha$, there exists a unique Poisson bracket on $\mathcal{L}(\mathrm{P})$ such that the bracket of two generators is

$$
\{X x, Y y\}_{\alpha}=[X x, Y y](X y . Y x+\alpha \cdot X x . Y y) .
$$

The swapping algebra is the algebra $\mathcal{L}_{\alpha}(\mathrm{P})$ endowed with the Poisson bracket $\{,\}_{\alpha}$. This theorem is proved in Section 2. The goal of this paper is to relate this swapping algebra to other Poisson algebras.

One should note that this bracket can be used to express very simply some results of Wolpert and in particular the variation of the length of curve transverse to a shear [26, 25].
1.2. Cross ratios and the multi fraction algebra. We shall concentrate on the interpretation of an offshoot of the swapping algebra. We denote by $\mathcal{Q}_{\alpha}(\mathrm{P})$ the algebra of fractions of $\mathcal{L}_{\alpha}(\mathrm{P})$ equipped with the induced Poisson structure. The multi fraction algebra $\mathcal{B}(\mathrm{P})$ is the vector subspace of $\mathcal{Q}_{\alpha}(\mathrm{P})$ generated by the elementary multi fractions:

$$
[\mathrm{X}, \mathrm{x} ; \sigma]:=\frac{\prod_{i=1}^{i=n} X_{i} x_{\sigma(i)}}{\prod_{i=1}^{i=n} X_{i} x_{i}},
$$

where $\mathrm{X}=\left(X_{1}, \ldots, X_{n}\right)$ and $\mathrm{x}=\left(x_{1}, \ldots, x_{n}\right)$ are $n t$-uples of points of P and $\sigma$ is a permutation of $\{1, \ldots, n\}$. Then we have the easy proposition

Proposition 2. The multi fraction algebra is a Poisson subalgebra of $\mathcal{Q}_{\alpha}(\mathrm{P})$. The induced Poisson structure does not depend on $\alpha$. Finally
$\mathcal{B}(\mathrm{P})$ is generated as a commutative algebra by the cross fractions:

$$
[X, Y, x, y]:=\frac{X x \cdot Y y}{Y x \cdot X y}
$$

In particular, it follows that the multi fraction algebra is naturally mapped to the commutative algebra of functions on cross ratios (See Section 3). Thus the existence of a Poisson structure on the multi fraction algebra can be interpreted as that of a Poisson structure on the space of cross ratios.
1.3. The multi fraction algebra as a "universal" Goldman algebra. We then relate the multi fraction algebra to the Goldman algebra. Let $\Gamma$ be the fundamental group of a surface $S$ and P be the subset of $\partial_{\infty} \Gamma$ consisting of fixed points of elements of $\Gamma$. The Hitchin component $\mathrm{H}(n, S)$ of the character variety of representations of $\Gamma$ in $\mathrm{PSL}_{n}(\mathbb{R})$ was interpreted in [14] as a space of cross ratios. Thus every multi fraction in $\mathcal{B}(P)$ gives a smooth function on the Hitchin component (see Proposition 4.2.4 for details). Thus we have a restriction

$$
\mathrm{I}_{S}: \mathcal{B}(\mathrm{P}) \rightarrow C^{\infty}(\mathrm{H}(n, S))
$$

This mapping is not a Poisson morphism, nevertheless it becomes so when we take sequences of well chosen finite index subgroups. More precisely, we define and prove, as an immediate consequence of one of the main result of Niblo in [19], the existence of vanishing sequences of finite index subgroups $\left\{\Gamma_{n}\right\}_{n \in \mathbb{N}}$ of $\Gamma$; these sequences are essentially such that every geodesic becomes eventually simple and for which the intersection of two geodesics becomes eventually minimal (See Paragraph 6.2.1 and Appendix 11 for precisions).

Then denoting by $\{,\}_{W}$ the swapping bracket and $\{,\}_{S_{n}}$ the Goldman bracket for $S_{n}:=\tilde{S} / \Gamma_{n}$ coming from the Atiyah-Bott-Goldman symplectic form on the character variety, we prove in Section 9

## Theorem 3. [Goldman bracket for vanishing sequences ]

Let $\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ be a vanishing sequence of subgroups of $\pi_{1}(S)$. Let $\mathrm{P} \subset \partial_{\infty} \pi_{1}(S)$ be the set of end points of geodesics. Let $b_{0}$ and $b_{1}$ be two multi fractions in $\mathcal{B}(\mathrm{P})$. Then we have,

$$
\begin{equation*}
\lim _{n \rightarrow \infty}\left\{b_{0}, b_{1}\right\}_{S_{n}}=\left\{b_{0}, b_{1}\right\}_{W} \tag{1}
\end{equation*}
$$

The statement of this theorem actually requires some preliminaries in defining properly the meaning of Assertion (1). In a way, this result tells us that the swapping bracket is the Goldman bracket on the universal solenoid.

The proof relies on the description of special multi fractions called elementary functions (see Paragraph 4.2) as limits of the well studied functions on the character variety known as Wilson loops.

Another result is a precise asymptotic formula, on a fixed surface this time, relating the Goldman and the swapping brackets. Let $\Gamma$ be as above. Let $\gamma \in \Gamma$. Let finally $y \in \mathrm{P}$, and $\gamma^{+}, \gamma^{-}$be respectively the attractive and repulsive fixed points of $\gamma$ in $\partial_{\infty}(\Gamma)$. Let us define the following formal series of cross fractions

$$
\hat{\ell}_{\gamma}(y)=\log \left(\frac{\gamma^{+} \gamma^{-1}(y) \cdot \gamma^{-} \gamma(y)}{\gamma^{+} \gamma(y) \cdot \gamma^{-} \gamma^{-1}(y)}\right)
$$

In [14], we show that the period function $\left.\ell_{\gamma}:=I_{S}\left(\hat{\ell}_{\gamma}(y)\right)\right)$ - seen as a function on the character variety - is independent on $y$ and is a function of the eigenvalues of the monodromy of $\gamma$. These period functions coincide with the length functions for the classical Teichmüller Theory - that is $n=2$.

We now have
Theorem 4. [Bracket of length functions] Let $\gamma$ and $\eta$ be homotopy classes of curves which as simple curves have at most one intersection point, then we have

$$
\lim _{n \rightarrow \infty} \mathrm{I}_{S}\left(\left\{\hat{\ell}_{\gamma^{n}}(y), \hat{\ell}_{\eta^{n}}(y)\right\}_{W}\right)=\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}
$$

As a tool of the proof of this result we prove the following extension of the Wolpert formula [26, 25].

Theorem 5. [Generalised Wolpert Formula] Let $\gamma$ and $\eta$ be two homotopy classes of curves which as simple curves have exactly one intersection point. Then the Goldman bracket of the two length functions $\ell_{\gamma}$ and $\ell_{\eta}$ is

$$
\begin{equation*}
\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}(\mathbf{b})=\iota(\gamma, \eta) \sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon \cdot \varepsilon^{\prime} \cdot \mathbf{b}\left(\gamma^{\varepsilon}, \eta^{\varepsilon^{\prime}}, \gamma^{-\varepsilon}, \eta^{-\varepsilon^{\prime}}\right) . \tag{2}
\end{equation*}
$$

1.4. The multi fraction algebra and $\operatorname{PSL}_{n}(\mathbb{R})$-opers. We finally relate the multi fraction algebra to opers. We recall in Section 10 the definition of real opers and their interpretation as maps to the projective space $\mathbb{P}\left(\mathbb{R}^{n}\right)$ and its dual. In particular, opers with trivial holonomy can be embedded in the space of smooth cross ratios. The Drinfel'd-Sokolov reduction allows us to define the Poisson bracket of pairs of acceptable obervables, a subclass of functions on the spaces of opers. We then show that this Poisson bracket coincide with the swapping bracket

## Theorem 6. [Swapping Bracket and opers]

Let $\left(X_{0}, x_{0}, Y_{0}, y_{0}, X_{1}, x_{1}, Y_{1}, y_{1}\right)$ be pairwise distinct points on the circle $\mathbb{T}$. Then the cross fractions $\left[X_{0}, x_{0}, Y_{0}, y_{0}\right]$ and $\left[X_{1}, x_{1}, Y_{1}, y_{1}\right]$ defines a pair of acceptable observables whose Poisson bracket with respect to the Drinfel'd-Sokolov reduction coincide with their Poisson bracket in the multi fraction algebra.

## 2. The swapping Bracket

In this section, we first recall the properties and definition of the linking number of two ordered pairs of points. We then construct the swapping algebra and prove Theorem 1 which relies on an identity involving the linking numbers of six points.
2.1. Linking number for pairs of points. We recall that if ( $X, x, Y, y$ ) is a quadruple of points on the real line the linking number of $(X, x)$ and $(Y, y)$ is

$$
\begin{align*}
{[X x, Y y]:=} & \frac{1}{2}(\operatorname{Sign}(X-x) \operatorname{Sign}(X-y) \operatorname{Sign}(y-x) \\
& -\operatorname{Sign}(X-x) \operatorname{Sign}(X-Y) \operatorname{Sign}(Y-x)), \tag{3}
\end{align*}
$$

where $\operatorname{Sign}(x)=-1,0,1$ whenever $x<0, x=0$ and $x>0$ respectively. By definition, the linking number is invariant by orientation preserving homeomorphisms of the real line.
(1) When the four points are pairwise distinct, this linking number is also the total linking number of the curve joining $X$ to $x$ with the curve joining $Y$ to $y$ in the upper half plane.
(2) The equality cases are as follows:
(a) For all points $(X, Y, y)$ on the circle

$$
\begin{equation*}
[X X, Y y]=0=[X y, X y] \tag{4}
\end{equation*}
$$

(b) If, up to cyclic permutation, $(X, Y, x)$ are pairwise points and oriented, then

$$
\begin{equation*}
[X x, Y x]=1 / 2 \tag{5}
\end{equation*}
$$

The first observation shows that we can define the linking number of a quadruple of points on the oriented circle $S^{1}$ by choosing a point $x_{0}$ disjoint from the quadruple and defining the linking number as the linking number of thequadruple in $S^{1} \backslash\left\{x_{0}\right\} \sim \mathbb{R}$. The linking number so defined does not depend on the choice of $x_{0}$ and is invariant under orientation preserving homeomorphisms.
2.1.1. Properties of the linking number. We abstract the useful property (for us) of the linking number of pairs of points in the following definition. Let $P$ be any set.

Definition 2.1.1. A linking number on pair of points of P is a map from $\mathrm{P}^{4}$ to a commutative ring

$$
(X, x, Y, y) \rightarrow[X x, Y y]
$$

so that for all points $X, x, Y, y, Z, z$

$$
\begin{align*}
& {[X x, Y y]+[Y y, X x]=0, \quad \text { First antisymmetry, }}  \tag{6}\\
& {[X x, Y y]+[X x, y Y]=0, \quad \text { SECOND Antisymmetry, }} \tag{7}
\end{align*}
$$

$$
\begin{equation*}
[z y, X Y]+[z y, Y Z]+[z y, Z X]=0, \quad \text { Cocycle identity, } \tag{8}
\end{equation*}
$$

and moreover if $(X, x, Y, y)$ are all pairwise distinct then

$$
\begin{equation*}
[X x, Y y] \cdot[X y, Y x]=0, \quad \text { LINKING NUMBER ALTERNATIVE. } \tag{9}
\end{equation*}
$$

We illustrate the cocycle identity and the alternative for the standard linking number in Figure (1)

Then we prove
Proposition 2.1.2. The canonical linking number on pair of points of the circle is a linking number in the sense of the previous definition.


Figure 1. linking number for pairs of points on the circle

Proof. The first two symmetries are checked from the definition. When $\{x, y\} \cap\{X, Y, Z\}=\emptyset$, then Equation (8) follows from the geometric definition of the linking number. It remains to check different cases of equality. We can assume that $(X, Y, Z)$ are pairwise distincts: otherwise the equality follows from the two previous ones and (4).

- if $x=y$, the equation is true by (4).
- Assume that up to cyclic permutations of $(X, Y, Z)$ we have $x=X$ and $y \notin\{X, Y, Z\}$, then the equality follows from the following remark. Let $z, t$ be points close enough to $x$ so that $(z, x, t)$ is oriented then when $A=Y$ or $A=Z$, we have

$$
[x y, x A]=\frac{1}{2}([z y, x A]+[t y, x A]) .
$$

- Assume finally that $(x, y)=(X, Y)$, the the equality reduces to

$$
[X Y, Z X]+[X Y, Y Z]=0
$$

which is true, by Equation (5) and the fact that $(X, Y, Z)$ has the opposite orientation of $(Y, X, Z)$.
Equation (9) follows from the geometric definition of linking number.

A linking number satisfies more complicated relations. Namely
Proposition 2.1.3. Let $(X, x, Z, z, Y, y)$ be 6 points on the set P equipped wih an inersection [,], then

$$
\begin{equation*}
[X y, Z z]+[Y x, Z z]=[X x, Z z]+[Y y, Z z] \tag{10}
\end{equation*}
$$

Moreover, if

$$
\{X, x\} \cap\{Y, y\} \cap\{Z, z\}=\emptyset,
$$

then

$$
\begin{align*}
& {[X x, Y y][X y, Z z]+[Z z, X x][Z x, Y y]+[Y y, Z z][Y z, X x]=0}  \tag{11}\\
& {[X x, Y y][Y x, Z z]+[Z z, X x][X z, Y y]+[Y y, Z z][Z y, X x]=0} \tag{12}
\end{align*}
$$

## Remarks:

(1) We remark that the hypothesis on the configuration of points is necessary: if $X, x, Y, Z$ are pairwise distinct, then $F(X, x, Y, x, Z, x) \neq$ 0 in the case of the standard linking number on pair of points on the circle.
(2) A simple way to prove this proposition is to use a mathematical computing software, we give below a mathematical proof.

Proof. Formula (10) follows at once from the cocycle identity (8). We now prove Formulas (11) and (12). Let us define
$F(X, x, Y, y, Z, z):=[X x, Y y][X y, Z z]+[Z z, X x][Z x, Y y]+[Y y, Z z][Y z, X x]$,
$G(X, x, Y, y, Z, z):=[X x, Y y][Y x, Z z]+[Z z, X x][X z, Y y]+[Y y, Z z][Z y, X x]$.
We first prove some symmetries of $F$ and $G$.
Our first observation is that, using (6), we get that

$$
\begin{equation*}
F(X, x, Y, y, Z, z)=-G(Y, y, X, x, Z, z) \tag{13}
\end{equation*}
$$

Thus we only need to prove that $F=0$.
STEP 1: The expression $F$ is invariant under all permutations of the pairs $(X, x),(Y, y)$ and $(Z, z)$

Using Equations (10) and (6), we obtain that

$$
\begin{aligned}
F(X, x, Y, y, Z, z)+ & G(X, x, Y, y, Z, z) \\
= & {[X x, Y y][Y y, Z z]+[X x, Y y][X x, Z z] } \\
& +[Z z, X x][Z z, Y y]+[Z z, X x][X x, Y y] \\
& +[Y y, Z z][Y y, X x]+[Y y, Z z][Z z, X x] \\
& =0 .
\end{aligned}
$$

Hence, by Equation (13).

$$
\begin{equation*}
F(X, x, Y, y, Z, z)=F(Y, y, X, x, Z, z) \tag{14}
\end{equation*}
$$

By construction $F$ is invariant by cyclic permutations and thus from the previous equation $F$ is invariant by all permutations of the pairs $(X, x),(Y, y)$ and $(Z, z)$.
STEP 2: The expression $F$ satisfies a cocycle equation

$$
\begin{equation*}
F(X, x, Y, y, Z, z)+F(x, t, Y, y, Z, z)=F(X, t, Y, y, Z, z) \tag{15}
\end{equation*}
$$

We also have the symmetries

$$
\begin{align*}
F(X, x, Y, y, Z, z) & =-F(x, X, Y, y, Z, z) \\
& =-F(X, x, y, Y, Z, z) \\
& =-F(X, x, Y, y, z, Z) . \tag{16}
\end{align*}
$$

The Symmetries (16) follow at once from the Cocycle (15) and the fact that $F(X, X, Y, y, Z, z)=0$.

Let us prove a cocycle equation for $F$. We shall only use the cocycle Equation (8) and the previous symmetries for the linking number. By definition,

$$
\begin{aligned}
F(X, x, Y, y, Z, z)+ & F(x, t, Y, y, Z, z) \\
= & {[X x, Y y][X y, Z z]+[x t, Y y][x y, Z z] } \\
& +[Z z, X x][Z x, Y y]+[Z z, x t][Z t, Y y] \\
& +[Y y, Z z][Y z, X x]+[Y y, Z z][Y z, x t] .
\end{aligned}
$$

Using Equation (8) to expand the first and regrouping the fifth and sixth terms of the righthand side, we get

$$
\begin{aligned}
F(X, x, Y, y, Z, z)+ & F(x, t, Y, y, Z, z) \\
= & {[X t, Y y][X y, Z z]+[t x, Y y][X y, Z z]+[x t, Y y][x y, Z z] } \\
& +[Z z, X x][Z x, Y y]+[Z z, x t][Z t, Y y] \\
& +[Y y, Z z][Y z, X t] .
\end{aligned}
$$

Using Equation (8) for regrouping the second and third term of the righthand side and rearranging, we get

$$
\begin{aligned}
F(X, x, Y, y, Z, z)+ & F(x, t, Y, y, Z, z) \\
= & {[X t, Y y][X y, Z z] } \\
& +[Z z, X x][Z x, Y y]+[Z z, X x][x t, Y y]+[Z z, x t][Z t, Y y] \\
& +[Y y, Z z][Y z, X t] \\
= & F(X, t, Y, y, Z, z)
\end{aligned}
$$

Using Equation (8) to regroup the second and third term, then the fourth, of the right hand side, we finally get

$$
\begin{aligned}
F(X, x, Y, y, Z, z)+ & F(x, t, Y, y, Z, z) \\
= & {[X t, Y y][X y, Z z] } \\
& +[Z z, X t][Z t, Y y] \\
& +[Y y, Z z][Y z, X t] \\
= & F(X, t, Y, y, Z, z) .
\end{aligned}
$$

STEP 4: If $(X, x, Y, y)$ are pairwse distinct, then

$$
\begin{align*}
& F(X, x, Y, y, Y, x)=0  \tag{17}\\
& F(X, x, X, x, Y, y)=0 \tag{18}
\end{align*}
$$

For Equation (17), it follows from the Alternative (9) and the cocycle Equation (8) that

$$
\begin{aligned}
& F(X, x, Y, y, Y, x) \\
& \quad=[X x, Y y][X y, Y x]+([Y x, X x][Y x, Y y]+[Y y, Y x][Y x, X x]) \\
& \quad=0
\end{aligned}
$$

This proves Formula (17). Similarly, using the cocycle Formula for $F$ (15) for the first equality, symmetries for the second and our previous Formula (17) ( for $(X, x, y, Y)$ ) for the last, we get

$$
\begin{aligned}
& F(X, x, X, x, Y, y) \\
& \quad=F(X, x, X, y, Y, y)+F(X, x, y, x, Y, y) \\
& \quad=F(X, x, y, x, y, Y)=F(X, x, y, Y, y, x) \\
& \quad=0 .
\end{aligned}
$$

STEP 4: If $(X, x, Y, y, Z)$ are pairwse distinct, then

$$
\begin{equation*}
F(X, x, Y, y, Z, x)=0 \tag{19}
\end{equation*}
$$

Using the cocycle equation (15) for $F$ and the previous step, we get

$$
\begin{aligned}
& F(X, x, Y, y, Z, x) \\
& \quad=F(X, x, Y, Z, Z, x)+F(X, x, Z, y, Z, x) \\
& \quad=-F(X, x, Z, Y, Z, x)=0
\end{aligned}
$$

FINAL STEP: If $(X, x, Y, y, Z, z)$ are pairwse distinct, then

$$
\begin{equation*}
F(X, x, Y, y, Z, z)=0 \tag{20}
\end{equation*}
$$

Indeed, we have using the cocycle Equation for $F$ (15) for the first equality, symmetries for the second, on the previous step for the last, we get

$$
\begin{aligned}
& F(X, x, Y, y, Z, z) \\
& \quad=F(X, x, Y, y, Z, Y)+F(X, x, Y, y, Y, z) \\
& \quad=F(y, Y, x, X, Z, Y)-F(y, Y, x, X, y, z, Y) \\
& \quad=0
\end{aligned}
$$

This concludes the proof
2.2. The swapping algebra. Let $P$ be a set and [,] be a linking number with values in an integral domain $A$. We represent a pair $(X, x)$ of points of P by the expression $X x$. We consider the free associative commutative algebra $\mathcal{L}(\mathrm{P})$ generated over $A$ by pair of points on P , together with the relation $X x=0$.

Let $\alpha$ be any element in $A$. We define the swapping bracket of two pairs of points as the following element of $\mathcal{L}(\mathrm{P})$

$$
\begin{equation*}
\{X x, Y y\}_{\alpha}:=[X x, Y y](\alpha \cdot X x \cdot Y y+X y \cdot Y x) . \tag{21}
\end{equation*}
$$

We extend the swapping bracket tp the whole algebra $\mathcal{L}(P)$ using the Leibniz Rule and call the resulting algebra $\mathcal{L}_{\alpha}(\mathrm{P})$ the swapping algebra.

Theorem 2.2.1. The swapping bracket satisfies the Jacobi identity. Hence, the swapping algebra $\mathcal{L}_{\alpha}(\mathrm{P})$ is a Poisson algebra.

Proof. All we need to check is the Jacobi identity

$$
\left\{\{X x, X y\}_{\alpha}, X z\right\}_{\alpha}+\left\{\{X y, X z\}_{\alpha}, X x\right\}_{\alpha}+\left\{\{X z, X x\}_{\alpha}, X y\right\}_{\alpha}=0
$$

for the generators of the algebra.
We make preliminary computations, omitting the subscript $\alpha$ in the bracket. The triple bracket $\{\{A, B\}, C\}$ is a polynomial of degree 2 in $\alpha$ and we wish to compute its coefficients. By definition, using the Leibniz rule for the second equality, we have

$$
\begin{align*}
\{\{X x, Y y\}, Z z\}= & {[X x, Y y](\alpha\{X x . Y y, Z z\}+\{X y \cdot Y x, Z z\}) } \\
= & \alpha[X x, Y y](\{X x, Z z\} \cdot Y y+\{Y y, Z z\} \cdot X x) \\
& +[X x, Y y](\{X y, Z z\} \cdot Y x+\{Y x, Z z\} \cdot X y) . \tag{22}
\end{align*}
$$

Now we compute two expressions appearing in the right hand side of the previous equation. We have

$$
\begin{align*}
\{X x, Z z\} \cdot Y y+ & \{Y y, Z z\} \cdot X x \\
= & \alpha([X x, Z z]+[Y y, Z z]) X x \cdot Y y \cdot Z z \\
& +([X x, Z z] X z \cdot Y y \cdot Z x+[Y y, Z z] X x \cdot Y z \cdot Z y) . \tag{23}
\end{align*}
$$

Similarly

$$
\begin{align*}
\{X y, Z z\} . Y x+ & \{Y x, Z z\} \cdot X y \\
= & \alpha([X y, Z z]+[Y x, Z z]) X y \cdot Y x \cdot Z z \\
& +[X y, Z z] X z \cdot Y x \cdot Z y+[Y x, Z z] X y \cdot Y z \cdot Z x . \tag{24}
\end{align*}
$$

It follows from Equations (23) and (24) that the coefficient of $\alpha^{2}$ in the triple bracket (22) is

$$
\begin{equation*}
P_{2}:=([X x, Y y][X x, Z z]+[X x, Y y][Y y, Z z]) X x . Y y . Z z \tag{25}
\end{equation*}
$$

The coefficient of $\alpha$ in the triple bracket (22) is

$$
\begin{align*}
P_{1}:== & {[X x, Y y][X x, Z z] X z . Y y \cdot Z x+[X x, Y y][Y y, Z z] X x . Y z . Z y } \\
& +([X x, Y y][X y, Z z]+[X x, Y y][Y x, Z z]) X y \cdot Y x . Z z . \tag{26}
\end{align*}
$$

Finally the constant coefficient is

$$
\begin{equation*}
P_{0}:=[X x, Y y][X y, Z z] X z . Y x \cdot Z y+[X x, Y y][Y x, Z z] X y \cdot Y z . Z x, \tag{27}
\end{equation*}
$$

so that

$$
\begin{equation*}
\{\{X x, Y y\}, Z z\}=\alpha^{2} P_{2}+\alpha \cdot P_{1}+P_{0} \tag{28}
\end{equation*}
$$

In order to check the Jacobi identity, we have to consider the sum $S_{2}, S_{1}$ and $S_{0}$ over cyclic permutations of ( $X x, Y y, Z z$ ) of the three terms $P_{2}, P_{1}$ and $P_{0}$. We consider successivley these three coefficients.
Term of degree 0: We first have

$$
\begin{equation*}
S_{0}=F(X, x, Y, y, Z, z)(X z \cdot Y x \cdot Z y-X y \cdot Y z \cdot Z x) \tag{29}
\end{equation*}
$$

Indeed, we have

$$
S_{0}=A \cdot X z \cdot Y x \cdot Z y+B \cdot X y \cdot Y z \cdot Z x
$$

where

$$
\begin{aligned}
& A=[X x, Y y][X y, Z z]+[Z z, X x][Z x, Y y]+[Y y, Z z][Y z, X x]=F(X, x, Y, y, Z, z), \\
& B=[X x, Y y][Y x, Z z]+[Z z, X x][X z, Y y]+[Y y, Z z][Z y, X x]=G(X, x, Y, y, Z, z) .
\end{aligned}
$$

Now Equation (29) follows from Equation (13).

It follows from Proposition ?? that if

$$
\{X, x\} \cap\{Y, y\} \cap\{Z, z\}=\emptyset,
$$

then $F=0$, hence $S_{0}=0$.
Up to cyclic permutations, we just have to consider two cases
(1) If $x=y=z$ or $X=Y=Z$ then

$$
X z . Y x . Z y-X y . Y z . Z x=0,
$$

hence $S_{0}=0$,
(2) If $x=y=Z$ or $X=Y=z$ or the other cases obtained by cyclic permutations, since $a a=0$, we have

$$
X z . Y x . Z y=X y \cdot Y z . Z x=0
$$

Thus $S_{0}=0$.
We have completed the proof that $S_{0}=0$.
Term of degree 1. Next, we write

$$
\begin{aligned}
P_{1}= & A_{1}(X, x, Y, y, Z, z) X x \cdot Y z \cdot Z y \\
& +A_{2}(X, x, Y, y, Z, z) X z \cdot Y y \cdot Z x \\
& +A_{3}(X, x, Y, y, Z, z) X y \cdot Y x \cdot Z z
\end{aligned}
$$

Thus

$$
S_{1}=A_{x} \cdot X x \cdot Y z \cdot Z x+A_{y} \cdot X z \cdot Y y \cdot Z x \cdot+A_{z} \cdot X y \cdot Y x \cdot Z z,
$$

where

$$
\begin{aligned}
A_{z}= & A_{3}(X, x, Y, y, Z, z)+A_{2}(Y, y, Z, z, X, x)+A_{1}(Z, z, X, x, Y, y) \\
= & {[X x, Y y][X y, Z z]+[X x, Y y][Y x, Z z] } \\
& +[Y y, Z z][Y y, X x]+[Z z, X x][X x, Y y] \\
= & {[X x, Y y]([X y, Z z]+[Y x, Z z]-[Y y, Z z]-[X x, Z z]) . }
\end{aligned}
$$

By Equation (10), $A_{z}=0$. Therefore, $A_{y}=A_{z}=A_{x}=0$ by cyclic permutations. We have completed the proof that $S_{1}=0$.
Term of degree 2. Finally, $S_{2}=C . X x . Y y . Z z$, where

$$
\begin{aligned}
C= & {[X x, Y y][X x, Z z]+[X x, Y y][Y y, Z z] } \\
& +[Y y, Z z][Y y, X x]+[Y y, Z z][Z z, X x] \\
& +[Z z, X x][Z z, Y y]+[Z z, X x][X x, Y y] .
\end{aligned}
$$

Then $C=0$ by the antisymmetry of the linking number. Thus $S_{2}=0$.

This concludes the proof of the Jacobi identity. Indeed

$$
\begin{aligned}
\left\{\{X x, Y y\}_{\alpha}, Z z\right\}_{\alpha}+\left\{\{Y y, Z z\}_{\alpha}, X x\right\}_{\alpha}+ & \left\{\{Z z, X x\}_{\alpha}, Y y\right\}_{\alpha} \\
& =\alpha^{2} S_{2}+\alpha S_{1}+S_{0} \\
& =0 .
\end{aligned}
$$

2.3. The multi fraction algebra. The swapping algebra is very easy to define. However, in the sequel we shall need to consider other Poisson algebras built out of the swapping algebra and that will be more precisely subalgebras of the fraction algebra of $\mathcal{L}(\mathrm{P})$. We introduce in this paragraph cross fractions, multi fractions and the multi fraction algebra.
2.3.1. Cross fractions and multi fractions. Since $\mathcal{L}_{\alpha}(\mathrm{P})$ is an integral domain (with respect to the commutative product) we can consider its algebra of fractions $\mathcal{Q}_{\alpha}(\mathrm{P})$.

Let $(X, Y, x, y)=: Q$ be a quadruple of points of P so that $x \neq Y$ and $y \neq X$. The cross fraction determined by $Q$ is the element of $\mathcal{Q}_{\alpha}(\mathrm{P})$ defined by

$$
[X ; Y ; x ; y]:=\frac{X x \cdot Y y}{X y \cdot Y x}
$$

More generally, let $\mathrm{X}:=\left(X_{1}, \ldots, X_{n}\right)$ and $\mathrm{x}:=\left(x_{1}, \ldots x_{n}\right)$ are two tuples of elements of P so that $x_{i} \neq X_{i}$ for all $i$, let $\sigma$ be a permutation of $\{1, \ldots, n\}$ then the elementary multi fraction - defined over P defined by this data is

$$
[\mathrm{X}, \mathrm{x} ; \sigma]:=\frac{\prod_{i=1}^{i=n} X_{i} x_{\sigma(i)}}{\prod_{i=1}^{i=n} X_{i} x_{i}}
$$

2.3.2. The multi fraction algebra. Let now $\mathcal{B}(\mathrm{P})$ be the vector space generated by elementary multi fractions and let us call any element of $\mathcal{B}(\mathrm{P})$ a multi fraction. We have the following proposition

Proposition 2.3.1. The vector space $\mathcal{B}(\mathrm{P})$ is a Poisson subalgebra of $\mathcal{Q}_{\alpha}(\mathrm{P})$. Moreover it is generated as a Poisson algebra by cross fractions. Finally the swapping bracket $\{,\}_{\alpha}$ when restricted to $\mathcal{B}(\mathrm{P})$ does not depend on $\alpha$.

From now on, we call the Poisson algebra $\mathcal{B}(\mathrm{P})$ the algebra of multi fractions.

Proof. The proposition follows from the following immediate observations:

- every elementary multi fraction is a product of cross fractions,
- if $A$ and $B$ are two cross fractions then $\{A, B\}_{\alpha}$ is a multi fraction and does not depend on $\alpha$.


## 3. Cross ratios and cross fractions

In this section, we interpret cross fractions, and in general multi fractions, as functions on the space of cross ratios.
3.1. Cross ratios. Recall that a cross ratio on a set $\mathbf{P}$ is a map $\mathbf{b}$ from

$$
\mathrm{P}^{4 *}:=\{(X, Y, x, y) \in \mathrm{P} \mid y \neq X, x \neq Y\}
$$

to a field $\mathbb{K}$ which satisfies some algebraic rules. Roughly speaking, these rules encode two conditions which constitute a normalisation, and two multiplicative cocycle identities which hold for some of the variables:

$$
\begin{aligned}
\text { Normalisation: } \mathbf{b}(X, Y, x, y) & =0 \Leftrightarrow x=X, \text { or } Y=y, \\
\text { Normalisation: } \mathbf{b}(X, Y, x, y) & =1 \Leftrightarrow x=y, \text { or } y=Y, \\
\text { Cocycle identity: } \mathbf{b}(X, Y, x, y) & =\mathbf{b}(X, Y, x, z) \mathbf{b}(X, Y, z, y), \\
\text { Cocycle identity: } \mathbf{b}(X, Y, x, y) & =\mathbf{b}(X, Z, x, y) \mathbf{b}(Z, W, x, y) .
\end{aligned}
$$

## Remarks:

- We change our convention from our previous articles [13, 14] in order to be coherent with the projective cross ratio: let b be a cross ratio with respect to the definition above, let $b(X, x, Y, y):=\mathbf{b}(X, Y, x, y)$, then $b$ is a cross ratio using our older convention.
- In the case $P$ has a Hölder structure and $\mathbb{K}=\mathbb{R}$, we assume furthermore assume that $\mathbf{b}$ is Hölder.
- Assume $\Gamma$ acts on $P$. Let be a $\Gamma$ invariant cross ratio. Let $\gamma^{+}$ and $\gamma^{-}$be two points of P fixed by an element $\gamma$ of $\Gamma$, then the following quantity

$$
\mathbf{b}\left(\gamma^{-}, \gamma y, \gamma^{+}, y\right)
$$

does not depends on the choice of $y$. In particular let $S$ be a closed connected oriented surface of genus greater than 2 , let P be $\partial_{\infty} \pi_{1}(S)$ equipped with the action of $\pi_{1}(S)$. Let $\gamma^{+}$and $\gamma^{-}$ be repectively the attractive and repulsive fixed point of a non trivial element $\gamma$ of $\Gamma$ and $\mathbf{b}$ a $\pi_{1}(S)$-invariant cross ratio, then

$$
\ell_{\mathbf{b}}(\gamma):=|\log | \mathbf{b}\left(\gamma^{-}, \gamma y, \gamma^{+}, y\right)| |
$$

is called the period of $\gamma$.
We finally denote by $\mathbb{B}(P)$ the set of cross ratios on $P$.
These definitions are closely related to those given by Otal in [20, 21], those discussed from various perspectives by Ledrappier in [17] and those of Bourdon in [2] in the context of $\operatorname{CAT}(-1)$-spaces.
3.2. Multi fractions as functions. To every cross fraction $[X ; Y ; x ; y]$, we associate a function, denoted by $\overline{[X ; Y ; x ; y]}$, on $\mathbb{B}(\mathrm{P})$ by the following formula

$$
\overline{[X ; Y ; x ; y]}(\mathbf{b})=\mathbf{b}(X, Y, x, y)
$$

The following proposition follows at once form the definition of cross ratio

Proposition 3.2.1. The map $[X ; Y ; x ; y] \rightarrow \overline{[X ; Y ; x ; y]}$ extends uniquely to a morphism of commutative associative algebras from $\mathcal{B}(\mathrm{P})$ to the algebra of functions on $\mathbb{B}(\mathrm{P})$.

In the sequel, we shall use an identical notation for a multi fraction and its image in the space of functions on $\mathbb{B}(P)$. So far, we did not consider any topological structure on $\mathbb{B}(P)$.
3.3. Multi fractions and Hitchin components. In [13], we identified the Hitchin component with a space of cross ratios satisfying certain identities. Let us recall notations and definitions
3.3.1. Hitchin component. Let $S$ be a closed oriented connected surface with genus at least two.

Definition 3.3.1. [Fuchsian and Hitchin homomorphisms] An $n$-Fuchsian homomorphism from $\pi_{1}(S)$ to $\mathrm{PSL}_{n}(\mathbb{R})$ is a homomorphism $\rho$ which factorises as $\rho=\iota \circ \rho_{0}$, where $\rho_{0}$ is a discrete faithful homomorphism with values in $\mathrm{PSL}_{2}(\mathbb{R})$ and $\iota$ is an irreducible homomorphism from $\mathrm{PSL}_{2}(\mathbb{R})$ to $\mathrm{PSL}_{n}(\mathbb{R})$.

An $n$-Hitchin homomorphism from $\pi_{1}(S)$ to $\mathrm{PSL}_{n}(\mathbb{R})$ is a homomorphism which may be deformed into an n-Fuchsian homomorphism

The Hitchin component $\mathrm{H}(n, S)$ is the space of Hitchin homomorphisms up conjugacy by an exterior automorphisms of $\mathrm{PSL}_{n}(\mathbb{R})$. By construction $\mathrm{H}(n, S)$ is identified with a connected component of the character variety. It is a result by Hitchin [12] that $\mathrm{H}(n, S)$ is homeomorphic to the interior of a ball of dimension $(3 g-2) n$.

As a corollary of the main result of [13], we have
Theorem 3.3.2. If $\rho$ is Hitchin, if $\gamma$ is a non trivial element of $\pi_{1}(S)$ then $\rho(\gamma)$ has $n$ distinct real eigenvalues of the same sign.

This allows us to define the width of a non trivial element $\gamma$ of $\pi_{1}(S)$ with respect to a Hitchin representation $\rho$ as

$$
\operatorname{width}_{\rho}(\gamma):=\log \left(\left|\frac{\lambda_{\max }(\rho(\gamma))}{\lambda_{\min }(\rho(\gamma))}\right|\right)
$$

where $\lambda_{\max }(\rho(\gamma))$ and $\lambda_{\min }(\rho(\gamma))$ are the eigenvalues of respectively maximum and minimum absolute values of the element $\rho(\gamma)$.
3.3.2. Rank $n$ cross ratios. For every integer $p$, let $\partial_{\infty} \pi_{1}(S)_{*}^{p}$ be the set of pairs

$$
(\mathrm{X}, \mathrm{x})=\left(\left(X_{0}, X_{1}, \ldots, X_{p}\right),\left(x_{0}, x_{1}, \ldots, x_{p}\right)\right),
$$

of $(p+1)$-tuples of points in $\partial_{\infty} \pi_{1}(S)$ such that $X_{j} \neq X_{i} \neq x_{0}$ and $x_{j} \neq x_{i} \neq X_{0}$, whenever $j>i>0$. Let $\chi^{n}(\mathrm{X}, \mathrm{x})$ be the multi fraction defined by

$$
\chi(\mathrm{X}, \mathrm{x}):=\operatorname{det}_{i, j>0}\left(\left[X_{i} ; X_{0} ; x_{j} ; x_{0}\right]\right) .
$$

A cross ratio $\mathbf{b}$ has rank $n$ if

- $\chi^{n}(\mathrm{X}, \mathrm{x})(\mathbf{b}) \neq 0$, for all $(\mathrm{X}, \mathrm{x})$ in $\partial_{\infty} \pi_{1}(S)_{*}^{n}$,
- $\chi^{n+1}(\mathrm{X}, \mathrm{x})(\mathbf{b})=0$, for all $(\mathrm{X}, \mathrm{x})$ in $\partial_{\infty} \pi_{1}(S)_{*}^{n+1}$.

The main result of [15] - which used a result by Guichard [11] - is the following.

Theorem 3.3.3. There exists a bijection $\phi$ from the set of $n$-Hitchin representations to the set of $\pi_{1}(S)$-invariant rank $n$ cross ratios, such that if $\mathbf{b}=\phi(\rho)$ then
(1) for any nontrivial element $\gamma$ of $\pi_{1}(S)$

$$
\ell_{\mathbf{b}}(\gamma)=\operatorname{width}_{\rho}(\gamma),
$$

where $\ell_{\mathbf{b}}(\gamma)$ is the period of $\gamma$ is given with respect to $\mathbf{b}=\phi(\rho)$, and width $_{\rho}(\gamma)$ is the width of $\gamma$ with respect to $\rho$.
(2) Moreover, if $\gamma_{1}$ and $\gamma_{2}$ are two non trivial elements of $\pi_{1}(S)$, if $e_{i}$, (respectively $E_{i}$ ) is an eigenvector of $\rho\left(\gamma_{i}\right)$ of maximal eigenvalue (respectively eigenvector of $\rho^{*}\left(\gamma_{i}\right)$ of minimum eigenvalue) then

$$
\begin{equation*}
\mathbf{b}\left(\gamma_{1}^{+}, \gamma_{2}^{+}, \gamma_{2}^{-}, \gamma_{1}^{-}\right)=\frac{\left\langle E_{2}, e_{1}\right\rangle\left\langle E_{1}, e_{2}\right\rangle}{\left\langle E_{1}, e_{1}\right\rangle\left\langle E_{2}, e_{2}\right\rangle} \tag{30}
\end{equation*}
$$

4. Wilson loops, multi fractions and length functions

In this section, we shall relate Wilson loops - which are regular functions on the character variety - to multi fractions. We in particular introduce elementary functions which are limits of Wilson loops, prove that they generate the multi fraction algebra and that they are smooth functions on the Hitchin component.

We also introduce length functions in Paragraph 4.4.
4.1. Wilson loops. Let $\gamma$ be an element of $\pi_{1}(S)$ and $\rho$ be an element of $\mathrm{H}(n, S)$. The Wilson loop associated to $\gamma$ is the function $\mathrm{W}(\gamma)$ on $\mathrm{H}(n, S)$ defined by

$$
\mathbf{W}(\gamma)(\rho)=\operatorname{tr}(\rho(\gamma))
$$

We leave the reader check that this is indeed a well defined function.
Let us introduce the following definition.
Definition 4.1.1. [Class of AN ELEmENT] Let $\gamma$ is a non trivial element of $\Gamma$, the class $[\gamma]$ of $\gamma$ is the oriented pair $\left(\gamma^{+}, \gamma^{-}\right)$.

Recall that $[\gamma]=[\eta]$ if and only if there exist positive integers $m$ and $n$ so that $\gamma^{m}=\eta^{n}$.
4.1.1. Asymptotics of Wilson loops. Let $\rho$ be a Hitchin representation. Recall that for any $\gamma$ in $\pi_{1}(S)$ we can write

$$
\rho(\gamma)=\sum_{1 \leqslant i \leqslant n} \lambda_{i}(\gamma) p_{i}(\gamma),
$$

where $p_{i}(\gamma)$ is a projector of trace 1 , and $\lambda_{i}(\gamma)$ are real numbers so that

$$
0<\left|\lambda_{n}(\gamma)\right|<\ldots<\left|\lambda_{1}(\gamma)\right| .
$$

Let us denote $\dot{\rho}(\gamma)=p_{1}(\gamma)$
Definition 4.1.2. [GIRTH AND WIDTH] Let the girth of $\rho$ be

$$
\begin{equation*}
\operatorname{gh}(\rho):=\sup \left\{\left.\left|\frac{\lambda_{k}(\gamma)}{\lambda_{j}(\gamma)}\right| \right\rvert\, k>j, \quad \gamma \in \rho\left(\pi_{1}(S)\right) \backslash\{\operatorname{Id}\}\right\} \tag{31}
\end{equation*}
$$

and the width to be

$$
\begin{equation*}
\operatorname{wh}(\rho):=\sup \left\{\left|\frac{\lambda_{j}(\gamma)}{\lambda_{k}(\gamma)}\right| \quad \gamma \in \rho\left(\pi_{1}(S)\right) \backslash\{\operatorname{Id}\}\right\} \tag{32}
\end{equation*}
$$

We have the following proposition
Proposition 4.1.3. Let $C$ be a compact subset of $\mathrm{H}(n, S)$ then

$$
\sup \{\operatorname{gh}(\rho) \mid \rho \in C\}<1
$$

Moreover there exists a constant $W$, we have

\sup \{\operatorname{wh}(\rho) \mid \rho \in C\}<W
$$

Proof. This follows from the Anosov property. See also Sambarino ([?]) for details.

We choose an auxiliary norm, denoted $\|$,$\| on \mathbb{R}^{n}$. We define $[A]$ to be the set of eigenvectors of a purely loxodromic matrix $A$, and observe that $\left[A^{n}\right]=[A]$. Then we have

Proposition 4.1.4. For any $\gamma$ in $\rho\left(\pi_{1}(S)\right)$, and $p \in \mathbb{N}$ we have

$$
\begin{equation*}
\left\|\frac{\rho\left(\gamma^{p}\right)}{\mathrm{W}\left(\gamma^{p}\right)(\rho)}-\dot{\rho}(\gamma)\right\| \leqslant \operatorname{gh}(\rho)^{p} K([\rho(\gamma)]) \tag{33}
\end{equation*}
$$

where $K([\rho(\gamma)])$ only depends on $[\rho(\gamma)]$.

Proof. We can indeed write any real diagonalisable matrix with positive eigenvalues $A$ as

where $\mathrm{p}_{i}$ are projectors. Thus

\left\|\frac{\mathrm{A}^{p}}{\operatorname{tr}\left(\mathrm{~A}^{p}\right)}-\mathrm{p}_{1}\right\| & \leqslant \frac{1}{\sum_{i=1}^{i=n} \lambda_{i}^{p}}\left\|\sum_{i=2}^{i=n} \lambda_{i}^{p} \mathrm{p}_{i}-\left(\sum_{i=2}^{i=n} \lambda_{i}^{p}\right) \mathrm{p}_{1}\right\| \\
& \leqslant\left(\frac{\lambda_{2}}{\lambda_{1}}\right)^{p}\left(n\left\|\mathrm{p}_{1}\right\|+\sum_{i=2}^{i=n}\left\|\mathrm{p}_{2}\right\|\right) \tag{34}
\end{align*}
$$

Thus the inequality follows by taking

$$
K([\mathrm{~A}])=n\left\|\mathrm{p}_{1}\right\|+\sum_{i=2}^{i=n}\left\|\mathrm{p}_{2}\right\| .
$$

We begin with the following proposition.
Proposition 4.1.5. Let $\gamma_{1}, \ldots, \gamma_{k}$ be non trivial elements of $\pi_{1}(S)$. Then the sequence

\left\{\frac{\mathbf{W}\left(\gamma_{1}^{p} \ldots \gamma_{k}^{p}\right)}{\mathbf{W}\left(\gamma_{1}^{p}\right) \ldots \mathbf{W}\left(\gamma_{k}^{p}\right)}\right\}_{p \in \mathbb{N}}
$$

converges uniformly on every compact of $\mathrm{H}(n, S)$ when $p$ goes to infinity to a multi fraction. More precisely,

$$
\lim _{p \rightarrow \infty}\left(\frac{\mathrm{~W}\left(\gamma_{1}^{p} \ldots \gamma_{k}^{p}\right)}{\mathrm{W}\left(\gamma_{1}^{p}\right) \ldots \mathrm{W}\left(\gamma_{k}^{p}\right)}\right)=\frac{\prod_{i=1}^{i=k} \gamma_{i+1}^{+} \gamma_{i}^{-}}{\prod_{i=1}^{i=k} \gamma_{i}^{+} \gamma_{i}^{-}}=\left[\mathrm{G}^{+}, \mathrm{G}^{-} ; \tau\right],
$$

where $\mathrm{G}^{ \pm}=\left(\gamma_{1}^{ \pm}, \ldots, \gamma_{k}^{ \pm}\right)$and $\tau(i)=i-1$, using the convention that $k+1=1$.

Proof. We first observe that if $e_{i}$, (respectively $E_{i}$ ) is an eigenvector of $\rho\left(\gamma_{i}\right)$ of maximal eigenvalue (respectively eigenvector of $\rho^{*}\left(\gamma_{i}\right)$ of minimum eigenvalue) so that $\left\langle E_{i}, e_{i}\right\rangle=1$ then

$$
\operatorname{tr}\left(\dot{\rho}\left(\gamma_{1}\right) \ldots \dot{\rho}\left(\gamma_{k}\right)\right)=\prod_{i}\left\langle E_{i}, e_{i+1}\right\rangle
$$

By Equation (30),

$$
\prod_{i}\left\langle E_{i}, e_{i+1}\right\rangle=\left(\frac{\prod_{i=1}^{i=p} \gamma_{i+1}^{+} \gamma_{i}^{-}}{\prod_{i=1}^{i=k} \gamma_{i}^{+} \gamma_{i}^{-}}\right)(\rho)
$$

It thus follows that

$$
\operatorname{tr}\left(\dot{\rho}\left(\gamma_{1}\right) \ldots \dot{\rho}\left(\gamma_{k}\right)\right)=\left[\mathrm{G}^{+}, \mathrm{G}^{-} ; \tau\right]
$$

Then the result follows at once from Propositions 4.1.4 and 4.1.3.
4.2. Elementary functions. Proposition 4.1.5 leads us to the following definition.

Definition 4.2.1. The multi fraction

\end{equation*}

is an elementary function of order $p$
By the previous proposition and its proof, we have the following equalities

\mathrm{T}\left(\gamma_{1}, \ldots, \gamma_{p}\right) & =\lim _{n \rightarrow \infty} \frac{\mathrm{~W}\left(\gamma_{1}^{n} \ldots \gamma_{p}^{n}\right)}{\mathrm{W}\left(\gamma_{1}^{n}\right) \ldots \mathrm{W}\left(\gamma_{p}^{n}\right)}  \tag{36}\\
\mathrm{T}\left(\gamma_{1}, \ldots, \gamma_{p}\right) & =\operatorname{tr}\left(\dot{\rho}\left(\gamma_{1}\right) \ldots \dot{\rho}\left(\gamma_{p}\right)\right) \tag{37}
\end{align*}
$$

The following formal properties of elementary functions are then easily checked.

Proposition 4.2.2. The following properties of elementary functions hold
(1) Cyclic invariance: for every cyclic permutation $\sigma$ of $\{1, \ldots, p\}$ we have

(2) Class invariance: if $\left[\eta_{i}\right]=\left[\gamma_{i}\right]$ then

\mathrm{T}\left(\gamma_{1}, \ldots \gamma_{p}\right)=\mathrm{T}\left(\eta_{1}, \ldots, \eta_{p}\right)
$$

(3) if $\left[\gamma_{p}\right]=\left[\gamma_{p-1}\right]$ then

$$
\mathbf{T}\left(\gamma_{1}, \ldots \gamma_{p}\right)=\mathbf{T}\left(\gamma_{1}, \ldots \gamma_{p-1}\right)
$$

(4) if $\left[\gamma_{p}\right]=\left[\gamma_{p-1}^{-1}\right]$ then

$$
\mathbf{T}\left(\gamma_{1}, \ldots \gamma_{p}\right)=0
$$

(5) Relations Assume that $\left[\gamma_{i}\right] \neq\left[\gamma_{i+1}\right]$ then

$$
\mathbf{T}\left(\gamma_{1}, \ldots, \gamma_{p}\right)=\frac{\mathbf{T}\left(\gamma_{1}, \gamma_{2}\right) \mathrm{T}\left(\gamma_{1}, \gamma_{p}\right) \mathrm{T}\left(\gamma_{2}, \gamma_{3}, \ldots, \gamma_{p}\right)}{\mathrm{T}\left(\gamma_{p}, \gamma_{2}, \gamma_{1}\right)}
$$

We deduce from the last statement the following corollary
Corollary 4.2.3. Let P be the set of fixed points in $\partial_{\infty} \pi_{1}(S)$ of non trivial elements of $\pi_{1}(S)$. Then every restriction of an elementary multi fraction over $\mathbf{P}$ is a quotient of product of elementary functions of order 2 and 3.

Proof. Let us consider $a, b, c, d$ be four non trivial elements of $\pi_{1}(S)$, then we have

$$
\begin{equation*}
\frac{\mathrm{T}(a, b, c) . \mathrm{T}(c, d)}{\mathrm{T}(a, d, c) \mathrm{T}(c, b)}=\left[b^{+} ; d^{+} ; a^{-} ; c^{-}\right] . \tag{38}
\end{equation*}
$$

The result follows.
Recall that in this section we choose P to be the set of fixed points of non trivial elements of $\pi_{1}(S)$. We now prove,

Proposition 4.2.4. Every multi fraction - defined over P - is a smooth function on $\mathrm{H}(n, S)$.

Proof. Let $\operatorname{Hom}(n, S)$ be the space of Hitchin homomorphisms. Let $\pi$ be the submersion

\pi: \operatorname{Hom}(n, S) \rightarrow \mathrm{H}(n, S)=\operatorname{Hom}(n, S) / \operatorname{Aut}\left(\mathrm{PSL}_{n}(\mathbb{R})\right)
$$

For every loxodromic element $A$ in $\mathrm{PSL}_{n}(\mathbb{R})$ let $p_{A}$ be the projection on the eigenspace of maximal eigenvalue with respect to the other
eigenspaces. The map $A \rightarrow p_{A}$ is smooth. It follows that for any elements $\gamma_{1}, \ldots, \gamma_{k}$ in $\pi_{1}(S)$ the map from $\operatorname{Hom}(n, S)$ to $\mathbb{R}$ defined by

$$
\Psi: \rho \rightarrow \operatorname{tr}\left(p_{\rho\left(\gamma_{1}\right)} \ldots p_{\rho\left(\gamma_{k}\right)}\right)
$$

is smooth. We conclude by observing that $\Psi$ is $\operatorname{Aut}\left(\operatorname{PSL}_{n}(\mathbb{R})\right)$-invariant and that by Equation (37)

$$
\Psi=\mathbf{T}\left(\gamma_{1}, \ldots, \gamma_{k}\right) \circ \pi .
$$

Thus every elementary function is smooth and by the previous result every multi fraction is smooth.
4.3. The swapping bracket of elementary functions. For the sequel, we shall need to compute the swapping brackets of elementary functions. This is given by the following proposition whose proof follows by an immediate application of the definition. We first say that two nontrivial elements $\gamma$ and $\eta$ in $\pi_{1}(S)$ are coprime if for all non zero integers $m$ and $n, \gamma^{n} \neq \eta^{m}$.

Proposition 4.3.1. Let $\gamma_{0}, \ldots, \gamma_{p}$, respectively $\eta_{0}, \ldots, \eta_{q}$ be elements of $\pi_{1}(S) \backslash\{1\}$ such that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are pairwise coprime. Let

$$
\begin{align*}
\mathrm{a}_{i, j} & :=\left[\gamma_{i}^{+} \gamma_{i}^{-}, \eta_{j}^{+} \eta_{j}^{-}\right] \\
\mathrm{b}_{i, j} & :=\left[\gamma_{i+1}^{+} \gamma_{i}^{-}, \eta_{j+1}^{+} \eta_{j}^{-}\right] \\
\mathrm{c}_{i, j} & :=\left[\gamma_{i}^{+} \gamma_{i}^{-}, \eta_{j+1}^{+} \eta_{j}^{-}\right] \\
\mathrm{d}_{i, j} & :=\left[\gamma_{i+1}^{+} \gamma_{i}^{-}, \eta_{j}^{+} \eta_{j}^{-}\right] \\
\mathrm{T}_{\gamma} & :=\mathrm{T}\left(\gamma_{0}, \ldots, \gamma_{p}\right) \\
\mathrm{T}_{\eta} & :=\mathrm{T}\left(\eta_{0}, \ldots, \eta_{q}\right) \tag{39}
\end{align*}
$$

Then

$$
\begin{align*}
\frac{\left\{\mathrm{T}_{\gamma}, \mathrm{T}_{\eta}\right\}}{\mathrm{T}_{\gamma} \cdot \mathrm{T}_{\eta}} & =\sum_{\substack{0 \leqslant i \leqslant q, 0 \leqslant j \leqslant q^{\prime}}}\left(\mathrm{a}_{i, j} \mathrm{~T}\left(\gamma_{i}, \eta_{j}\right)+\mathrm{b}_{i, j} \frac{\mathrm{~T}\left(\eta_{j+1}, \eta_{j}, \gamma_{i+1}, \gamma_{i}\right)}{\mathrm{T}\left(\eta_{j}, \eta_{j+1}\right) \mathrm{T}\left(\gamma_{i}, \gamma_{i+1}\right)}\right) \\
& -\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(\mathrm{c}_{i, j} \frac{\mathrm{~T}\left(\gamma_{i}, \eta_{j+1}, \eta_{j}\right)}{\mathrm{T}\left(\eta_{j}, \eta_{j+1}\right)}+\mathrm{d}_{i, j} \frac{\mathrm{~T}\left(\eta_{j}, \gamma_{i+1}, \gamma_{i}\right)}{\mathrm{T}\left(\gamma_{i}, \gamma_{i+1}\right)}\right) . \tag{40}
\end{align*}
$$

Proof. Using "logarithmic derivatives", we have

\frac{\left\{\mathrm{T}_{\gamma}, \mathrm{T}_{\eta}\right\}}{\mathrm{T}_{\gamma} \cdot \mathrm{T}_{\eta}} & =\sum_{\substack{0 \leqslant i \leqslant p, 0 \leqslant j \leqslant q}}\left(\left(\frac{\left\{\gamma_{i+1}^{+} \gamma_{i}^{-}, \eta_{j+1}^{+} \eta_{j}^{-}\right\}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}}+\frac{\left\{\gamma_{i}^{+} \gamma_{i}^{-}, \eta_{j}^{+} \eta_{j}^{-}\right\}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}}\right)\right. \\
& \left.-\left(\frac{\left\{\gamma_{i}^{+} \gamma_{i}^{-}, \eta_{j+1}^{+} \eta_{j}^{-}\right\}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}}+\frac{\left\{\gamma_{i+1}^{+} \gamma_{i}^{-}, \eta_{j}^{+} \eta_{j}^{-}\right\}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}}\right)\right) \\
& =\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(\mathrm{b}_{i, j} \frac{\gamma_{i+1}^{+} \eta_{j}^{-} \cdot \eta_{j+1}^{+} \gamma_{i}^{-}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}}+\mathrm{a}_{i, j} \frac{\gamma_{i}^{+} \eta_{j}^{-} \cdot \eta_{j}^{+} \gamma_{i}^{-}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}}\right. \\
& \left.-\mathrm{d}_{i, j} \frac{\gamma_{i+1}^{+} \eta_{j}^{-} \cdot \eta_{j}^{+} \gamma_{i}^{-}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}}-\mathrm{c}_{i, j} \frac{\gamma_{i}^{+} \eta_{j}^{-} \cdot \eta_{j+1}^{+} \gamma_{i}^{-}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}}\right) .
\end{aligned}
$$

From the definition of elementary functions (35), we get that

\frac{\mathrm{T}\left(\eta_{j+1}, \eta_{j}, \gamma_{i+1}, \gamma_{i}\right)}{\mathrm{T}\left(\eta_{j}, \eta_{j+1}\right) \mathrm{T}\left(\gamma_{i}, \gamma_{i+1}\right)} & =\frac{\gamma_{i+1}^{+} \eta_{j}^{-} \cdot \eta_{j+1}^{+} \gamma_{i}^{-}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}}, \\
\mathrm{T}\left(\gamma_{i}, \eta_{j}\right) & =\frac{\gamma_{i}^{+} \eta_{j}^{-} \cdot \eta_{j}^{+} \gamma_{i}^{-}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}}, \\
\frac{\mathrm{T}\left(\eta_{j}, \gamma_{i+1}, \gamma_{i}\right)}{\mathrm{T}\left(\gamma_{i}, \gamma_{i+1}\right)} & =\frac{\gamma_{i+1}^{+} \eta_{j}^{-} \cdot \eta_{j}^{+} \gamma_{i}^{-}}{\gamma_{i+1}^{+} \gamma_{i}^{-} \cdot \eta_{j}^{+} \eta_{j}^{-}} \\
\frac{\mathrm{T}\left(\gamma_{i}, \eta_{j+1}, \eta_{j}\right)}{\mathrm{T}\left(\eta_{j}, \eta_{j+1}\right)} & =\frac{\gamma_{i}^{+} \eta_{j}^{-} \cdot \eta_{j+1}^{+} \gamma_{i}^{-}}{\gamma_{i}^{+} \gamma_{i}^{-} \cdot \eta_{j+1}^{+} \eta_{j}^{-}} .
\end{aligned}
$$

This concludes the proof of the proposition
4.4. Length functions. We introduce in this paragraph length functions.
4.4.1. Length functions from the point of view of the multi fraction algebra. For any $y \in \partial_{\infty} \pi_{1}(S)$, let us introduce the following cross fraction,

$$
p_{\beta}(y)=\frac{\beta^{+} \beta^{-1}(y) \cdot \beta^{-} \beta(y)}{\beta^{+} \beta(y) \cdot \beta^{-} \beta^{-1}(y)} .
$$

We have, for any $\beta$ in $\pi_{1}(S)$

p_{\beta}(y)-p_{\beta}(z)=F_{y, z}-\left(\beta^{2}\right)^{*} F_{y, z}
$$

where

$$
F_{y, z}=\frac{\beta^{+} \beta^{-1} y \cdot \beta^{-} \beta^{-1}(z)}{\left.\beta^{+} \beta^{-1}(z) \cdot \beta^{-} \beta^{-1}(y)\right)}
$$

In particular, the restriction of $p_{\beta}(y)$ to the space of $\pi_{1}(S)$-invariant cross ratios is independent on the choice of $y$.

For the sake of simplicity, we introduce the following formal series of multi fractions and call it a length function.

$$
\hat{\ell}_{\beta}(y):=\log \left(p_{\beta}(y)\right)
$$

extending the bracket by the "log derivative" formulas

$$
\begin{equation*}
\left\{\hat{\ell}_{\beta}(y), q\right\}:=\frac{\left\{p_{\beta}(y), q\right\}}{p_{\beta}(y)}, \quad\left\{\hat{\ell}_{\beta}(y), \hat{\ell}_{\gamma}(z)\right\}:=\frac{\left\{p_{\beta}(y), p_{\gamma}(z)\right\}}{p_{\beta}(y) \cdot p_{\gamma}(z)} . \tag{41}
\end{equation*}
$$

Observe that $\mathrm{I}_{S}\left(\hat{\ell}_{\beta^{n}}(y)\right)=n \cdot \mathrm{I}_{S}\left(\hat{\ell}_{\beta}(y)\right)$.
4.4.2. Length functions and the character variety. We can further relate these objects with the period and length defined in Paragraph 3.1.

Let

$$
\mathrm{I}_{S}: \mathcal{B}\left(\partial_{\infty} \pi_{1}(S)\right) \rightarrow C^{\infty}(\mathrm{H}(n, S))
$$

denote the restriction of functions from $\mathbb{B}\left(\partial_{\infty} \pi_{1}(S)\right)$ to $\mathcal{H}(n)$.
We have that

$$
\log \mathrm{I}_{S}\left(\hat{\ell}_{\beta}(y)=\ell_{\beta},\right.
$$

where

$$
\ell_{\beta}(\rho)=\ell_{b}(\beta)
$$

where $\ell_{b}$ is the period of $\beta$ which respect to the cross ratio associated to $\rho$ (see Section 3.1).

## 5. The Goldman algebra

In this section, we first recall the construction of the Atiyah-BottGoldman symplectic form on the character variety. We then explain the construction of the Goldman algebra which allows to compute the bracket of Wilson loops in terms of a Lie bracket on the vector space generated by free homotopy classes of loops.
5.1. The Atiyah-Bott-Goldman symplectic form. In [1], Atiyah and Bott introduced a symplectic struture on the character variety of representations of closed surface groups in compact Lie group, generalizing Poincaré duality. This was later generalised by Goldman for non compact groups in $[7,6]$ and connected to the Weil-Petersson Kähler form. If identify the tangent space of $\mathrm{H}(n, S)$ at $\rho$ with $H_{\rho}^{1}(\mathfrak{g})$, where $\mathfrak{g}$ is the Lie algebra of $\operatorname{PSL}_{n}(\mathbb{R})$ then the symplectic form is given

$$
\begin{equation*}
\omega_{S}([A],[B])=\int_{V} \operatorname{tr}(A \wedge B) \tag{42}
\end{equation*}
$$

where $A$ and $B$ are de Rham representatives of the classes $[A]$ and $[B]$. We denote by $\{,\}_{S}$ the associated Poisson bracket, called the Atiyah-Bott-Goldman (ABG) Poisson bracket in the sequel, and $\mathcal{A}(S)$ the Poisson algebra of functions on $\mathrm{H}(n, S)$. In the next paragraph, we show how to compute the Atiyah-Bott-Goldman bracket in the case of $\mathrm{PSL}_{n}(\mathbb{R})$ for the Wilson loops we introduced in the previous section.
5.2. Wilson loops and the Goldman algebra. We describe in this paragraph the Goldman algebra and how it helps computing the ABGPoisson bracket. Let $\mathcal{C}$ be the set of free homotopy class of closed curves on an oriented surface $S$. Let $\mathbb{Q}[\mathcal{C}]$ be the vector space generated by $\mathcal{C}$ over $\mathbb{Q}$. We extend linearly Wilson loops so that the map $\gamma \mapsto w_{\gamma}$ is now a linear map from $\mathbb{Q}[\mathcal{C}]$ to $C^{\infty}(\mathrm{H}(n, S))$.

Goldman introduced in [7] a Lie bracket on $\mathbb{Q}[\mathcal{C}]$. We define it for two elements $\gamma_{1}$ and $\gamma_{2}$ of $\mathcal{C} \subset \subset Q[\mathcal{C}]$ and then extend it to $Q[\mathcal{C}]$ linearly. We choose two curves representating of $\gamma_{1}$ and $\gamma_{2}$, which we denote the same way.

If $\gamma_{1}$ and $\gamma_{2}$ are two curves from $S^{1}$ to $S$, an intersection point is a pair $(a, b)$ in $S^{1} \times S^{1}$ so that $\gamma_{1}(a)=\gamma_{2}(b)$. By a slight abuse of language, we usually identify an intersection point $(a, b)$ with its image $x=\gamma_{1}(a)=\gamma_{2}(b)$. We further assume that $\gamma_{1}$ and $\gamma_{2}$ have transverse intersection points.

For every intersection point $x$, let $\iota_{x}$ be the local linking number number at $x$, let $\gamma_{1} *_{x} \gamma_{2}$ be the free homotopy class of the curve obtained by composing $\gamma_{1}$ and $\gamma_{2}$ in $\pi_{1}(S, x)$ and finally let

$$
\iota\left(\gamma_{1}, \gamma_{2}\right):=\sum_{x \in \gamma_{1} \cap \gamma_{2}} \iota_{x},
$$

be the gobal linking number.
Definition 5.2.1. The Goldman bracket of $\gamma_{1}$ and $\gamma_{2}$ is the element of $\mathbb{Q}[\mathcal{C}]$ defined by

$$
\begin{equation*}
\left\{\gamma_{1}, \gamma_{2}\right\}=\sum_{x \in \gamma_{1} \cap \gamma_{2}} \iota_{x} \cdot \gamma_{1} *_{x} \gamma_{2} \tag{43}
\end{equation*}
$$

We illustrate in Picture 2, the Goldman bracket of two curves. Goldman proved [7] that this bracket does not depend on the choice of representatives and is a Lie bracket. Moreover this bracket is related to the ABG-Poisson bracket as follows.

Theorem 5.2.2. [Goldman] Let $\gamma_{1}$ and $\gamma_{2}$ be two loops on $S$. Then the $A B G$-Poisson bracket of the two corresponding Wilson loops in


Figure 2. $\{b, a\}=\alpha-\beta$
$\mathrm{H}(n, S)$ is

$$
\begin{equation*}
\left\{\mathbf{W}\left(\gamma_{1}\right), \mathbf{W}\left(\gamma_{2}\right)\right\}_{S}=\mathbf{W}\left(\left\{\gamma_{1}, \gamma_{2}\right\}\right)-\frac{\iota\left(\gamma_{1}, \gamma_{2}\right)}{n} \mathbf{W}\left(\gamma_{1}\right) \cdot \mathbf{W}\left(\gamma_{2}\right) \tag{44}
\end{equation*}
$$

We just stated Goldman theorem for the case of $\mathrm{H}(n, S)$, but the theorem has a formulation in the general case of character varieties for semi-simple groups.

## 6. Vanishing sequences and the main results

In this section, we first recall the definition of the length functions on the character varieties, introduce the notion of a vanishing sequence of finite index subgroups of a surface group and state our main results relating the swapping algebra to the Goldman algebra. All these results will be proved in Section 9.

Let as usual

$$
\mathrm{I}_{S}: \mathcal{B}\left(\partial_{\infty} \pi_{1}(S)\right) \rightarrow C^{\infty}(\mathrm{H}(n, S))
$$

denote the restriction of functions from $\mathbb{B}\left(\partial_{\infty} \pi_{1}(S)\right)$ to $\mathcal{H}(n)$.
6.1. Poisson brackets of length functions. We explain in this section our results concerning length functions (See Paragraph 4.4 for the notation and definition). Our first result relates the Goldman and the swapping Poisson bracket.

Theorem 6.1.1. Let $\gamma$ and $\eta$ be two geodesics with at most one intersection point, then we have

$$
\lim _{n \rightarrow \infty} \mathrm{I}_{S}\left(\left\{\hat{\ell}_{\gamma^{n}}(y), \hat{\ell}_{\eta^{n}}(y)\right\}\right)=\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}
$$

In the course of the proof of this result, we prove the following result of independent interest which is an extension of Wolpert Formula [26, 25]
Theorem 6.1.2. [Generalised Wolpert Formula].
Let $\gamma$ and $\eta$ two closed geodesics with a unique intersection point then the Goldman bracket of the two length functions $\ell_{\gamma}$ and $\ell_{\eta}$ seen as functions on the Hitchin component is

$$
\begin{equation*}
\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}=\iota(\gamma, \eta) \sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon . \varepsilon^{\prime} \cdot \mathrm{T}\left(\gamma^{\varepsilon} \cdot \eta^{\varepsilon^{\prime}}\right) \tag{45}
\end{equation*}
$$

where we recall that

$$
\mathrm{T}(\xi, \zeta)(\rho)=\mathbf{b}_{\rho}\left(\xi^{+}, \zeta^{+}, \zeta^{-}, \xi^{-}\right)
$$

We prove these two results in Paragraph 9.2
6.2. Poisson brackets of multi fractions. We now relate in general the swapping bracket and the Goldman bracket. Our result can be described by saying that the swapping bracket is an inverse limit (with respect to sequences of covering) of the Goldman bracket, or in other words that the swapping racket is a universal (in genus) Goldman bracket.
6.2.1. Vanishing sequences. Let $S$ be a compact hyperbolic surface that is equipped with a hyperbolic metric. Let $\Gamma:=\pi_{1}(S)$, let $\tilde{S}$ be the universal cover of $S$ so that $S=\pi_{1}(S)$. For any $\gamma$ in $\pi_{1}(S)$, we denote by $\tilde{\gamma}$ its axis in $\tilde{S}$ and $\langle\gamma\rangle$ the cyclic subgroup that it generates. Recall that we say that two elements $\gamma$ and $\eta$ of $\Gamma$ are coprime if $\langle\gamma\rangle \cap\langle\eta\rangle=\{1\}$.

Let $\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ be a sequence of nested finite index subgroups of $\Gamma_{0}:=$ $\Gamma$. Then let $S_{n}:=\tilde{S} / \Gamma_{n}$. For any $\gamma \in \Gamma$ let $\langle\gamma\rangle_{n}:=\langle\gamma\rangle \cap \Gamma_{n}$. Finally, let $\pi_{n}$ be the projection from $\tilde{S}$ to $S_{n}$ and let $\tilde{\gamma}_{n}:=\pi_{n}(\tilde{\gamma})$.

Definition 6.2.1. Let $\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ be a sequence of nested finite index normal subgroups of $\Gamma_{0}:=\Gamma$. We say that $\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ is a vanishing sequence if for all $\gamma$ and $\eta$ in $\Gamma$ in $\Gamma$, for any set $H$ invariant by left multiplication by $\gamma$ and right multiplication by $\eta$ whose projection in $\langle\eta\rangle \backslash \Gamma /\langle\gamma\rangle$ is finite, there exists $n_{0}$, such that for all $n>n_{0}, H \subset$ $\Gamma_{n} \cap\langle\eta\rangle .\langle\gamma\rangle$.

We shall use freely the following immediate consequence
Proposition 6.2.2. For any $\eta$ and $\gamma$ in $\Gamma$, for any finite subset $H_{0}$ of $\Gamma$ so that $H_{0} \cap\langle\eta\rangle .\langle\gamma\rangle=\emptyset$, there exists $p_{0}$ so that for all $p>p_{0}$, then

$$
H \cap\left(\langle\eta\rangle . \Gamma_{p} \cdot\langle\gamma\rangle\right)=\emptyset
$$

We prove in Appendix 11 that vanishing sequences exist. This is an immediate consequence of of result by Niblo [19].
6.2.2. Sequences of subgroups and limits. Let P be the subset of $\partial_{\infty} \pi_{1}(S)$ given by the end points of periodic geodesics. Let G be the set of pairs of points $\gamma=\left(\gamma^{-}, \gamma^{+}\right)$in P which correspond to fixed points of by an element of the group $\partial_{\infty}\left(\pi_{1}(S)\right.$. Observe that given any finite index subgroup $\Gamma$ of $\pi_{1}(S)$, the set G is in bijection with the set of primitive elements of $\Gamma$.

In the sequel, we shall freely identify elements of $G$ with primitive elements in any finite index subgroup of $\Gamma$

We associate to a sequence $\sigma=\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ of finite index subgroups of $\pi_{1}(S)$ the inverse limit $S_{\sigma}$ of $\left\{S_{m}:=\tilde{S} / \Gamma_{m}\right\}_{m \in \mathbb{N}}$, where $\tilde{S}$ is the universal cover of $S$.

Observe that we have a map I from $\mathcal{B}(\mathrm{P})$ to $\mathcal{A}\left(S_{\sigma}\right)$ which by definition is the projective limit of $\left\{\mathcal{A}\left(S_{m}\right)\right\}_{m \in \mathbb{N}}$.
Definition 6.2.3. Let $\left\{g_{m}\right\}_{m \in \mathbb{N}}$ be a sequence of functions, so that $g_{m} \in \mathcal{A}\left(S_{m}\right)$, we say that $\left\{g_{m}\right\}_{m \in \mathbb{N}}$ converges to the function $h$ in $\mathcal{A}\left(S_{\sigma}\right)$ and write

$$
\lim _{m \rightarrow \infty} g_{m}=h
$$

if for all $p$

$$
\lim _{n \rightarrow \infty} \mathrm{I}_{S_{p}}\left(g_{n}\right)=\mathbf{I}_{S_{p}}(h),
$$

where $I_{S_{p}}$ is the restriction with value in $\mathcal{A}\left(S_{p}\right)$.
6.2.3. Poisson brackets of multi fractions. The following result explains that the algebra of multi fractions is an inverse limit of Goldman algebras with respect to vanishing sequences .

Theorem 6.2.4. Let $\left\{\Gamma_{m}\right\}_{m \in \mathbb{N}}$ be a vanishing sequence of subgroups of $\pi_{1}(S)$. Let $\mathrm{P} \subset \partial_{\infty} \pi_{1}(S)$ be the set of end points of geodesics. Let $b_{0}$ and $b_{1}$ be two multi fractions in $\mathcal{B}(\mathrm{P})$. Then we have

$$
\lim _{n \rightarrow \infty}\left\{\mathrm{I}\left(b_{0}\right), \mathrm{I}\left(b_{1}\right)\right\}_{S_{n}}=\mathrm{I}\left(\left\{b_{0}, b_{1}\right\}_{W}\right) .
$$

We prove this result in Paragraph 9.1.

## 7. Product formulas and bouquet in good position

In this section, we wish to describe the Goldman bracket of curves which are compositions of many arcs. We shall call such a description a product formula and produce several instances of such formulas. This section is part of the technical core of this article.

The first formula - see Proposition 7.2.1 - deals with a rather general situation computing the Goldman bracket of curves which are compositions of many arcs. Then, considering repetition, and using special collection of arcs called bouquets in good positions - see Definition 7.3.2 - we prove a refinement of the product formula in Proposition 7.3.3. Proposition 7.3.3 is the first key result of this section.

Finally, in Proposition 7.5.2, we explain under which topological condition we can find bouquet in good position and compute the various intersection numbers involved in Proposition 7.3.3. Proposition 7.5.2 is the second key result of this section.
7.1. An alternative formulation of the Goldman bracket. We first need to give an alternative description of the Goldman bracket.

Let $\bar{\gamma}_{1}$ and $\bar{\gamma}_{2}$ be two arcs passing through a base point $x_{0}$. For any point $x$ in $\bar{\gamma}_{i}$, let $a_{i}(x)$ be the path along $\gamma_{i}$ joining $x_{0}$ to $x$.

Definition 7.1.1. [Intersection loops] Following these notations, for any $x \in \bar{\gamma}_{1} \cap \bar{\gamma}_{2}$, the homotopy class

$$
c_{x}\left(\bar{\gamma}_{1}, \bar{\gamma}_{2}\right):=a_{1}(x) \cdot a_{2}(x)^{-1} \in \pi_{1}\left(S, x_{0}\right)
$$

is called an intersection loop at $x$. - see Picture 3.


Figure 3. Intersection loop
The goal of this paragraph is the following proposition
Proposition 7.1.2. Let $\gamma_{1}$ and $\gamma_{2}$ be two free homotopy classes of loops represented by curves $\bar{\gamma}_{1}$ and $\bar{\gamma}_{2}$ passing though $x_{0}$. Then, the Goldman bracket in $\mathbb{Q}[\mathcal{C}]$ of the associated loops is given using intersection loops by

$$
\begin{equation*}
\left.\left\{\gamma_{1}, \gamma_{2}\right)\right\}_{S}=\sum_{x \in \gamma_{1} \cap \gamma_{2}} \iota(x) \bar{\gamma}_{1} \cdot c_{x} \cdot \bar{\gamma}_{2} \cdot c_{x}^{-1} \tag{46}
\end{equation*}
$$

This proposition is an immediate consequence of the following
Proposition 7.1.3. Let $\gamma_{1}$ and $\gamma_{2}$ be two loops passing though $x_{0}$. Then for every $x \in \gamma_{1} \cap \gamma_{2}$, we have

$$
\gamma_{1} *_{x} \gamma_{2}=\gamma_{1} \cdot c_{x}\left(\gamma_{1}, \gamma_{2}\right) \gamma_{2} \cdot c_{x}\left(\gamma_{1}, \gamma_{2}\right)^{-1}
$$

as free homotopy classes of curves
Proof. Let as before $a_{i}$ the arc along $\gamma_{i}$ joining $x_{0}$ to $x$ and $c_{x}=a_{1} \cdot a_{2}^{-1}$, then

$$
\begin{aligned}
\gamma_{1} *_{x} \gamma_{2} & =a_{1}^{-1} \gamma_{1} a_{1} a_{2}^{-1} \gamma_{2} a_{2} \\
& =a_{1}^{-1} \gamma_{1} c_{x} \gamma_{2} a_{2} \\
& =a_{1}^{-1} \gamma_{1} c_{x} \gamma_{2} c_{x}^{-1} a_{1}
\end{aligned}
$$

Thus $\gamma_{1} *_{x} \gamma_{2}$ is freely homotopic to $\gamma_{1} c_{x} \gamma_{2} c_{x}^{-1}$
7.2. The product formula. We need to express Goldman bracket of Wilson loop of curves consisting of many arcs. We work with the following data, see Figure 4 for a partial drawing,

- Let $\xi_{0}, \ldots, \xi_{q}$ and $\zeta_{0}, \ldots, \zeta_{q^{\prime}}$ be two tuples of arcs so that $A=$ $\xi_{0} \ldots \xi_{q}$ and $B=\zeta_{0} \ldots \zeta_{q}$ are closed curves.
- Assume furthermore that for all pairs $(i, j), \xi_{i}$ and $\zeta_{j}$ have transverse intersections and do not intersect at their end points.
- Let $u_{i}$ - respectively $v_{i}$ - be arcs joining a base point $x_{0}$ to the origin of $\xi_{i}$ - respectively $\zeta_{i}$.
Let us introduce the following notation
- for every $x \in \xi_{i} \cap \zeta_{j}$, let $c_{x}^{i, j}:=c_{x}\left(u_{i} \xi_{i}, v_{j} \zeta_{j}\right)$,
- for any $\xi \in \pi_{1}(S)$, let $I_{i, j}(\xi):=\sum_{x \in \xi_{i} \cap \xi_{j} \mid \xi=c_{x}^{i, j}} \iota(x)$,
- let us denote $A_{i}:=u_{i} \xi_{i} \xi_{i+1} \ldots \xi_{i-1} u_{i}^{-1}$ and $B_{j}:=v_{j} \zeta_{j} \zeta_{j+1} \ldots \zeta_{j-1} v_{j}^{-1}$.


## Proposition 7.2.1. [Product Formula] Using the notation and

 assumptions described above, we have the following equality in $\mathbb{Q}[\mathcal{C}]$,$$
\begin{align*}
\{A, B\} & =\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(\sum_{x \in \xi_{i} \cap \zeta_{j}} \iota(x) A_{i} \cdot c_{x}^{i, j} \cdot B_{j}\left(c_{x}^{i, j}\right)^{-1}\right)  \tag{47}\\
& =\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(\sum_{\xi \in \pi_{1}(S)} I_{i, j}(\xi) A_{i} \cdot \xi \cdot B_{j} \xi^{-1}\right) \tag{48}
\end{align*}
$$

We first prove a preliminary proposition and postpone the proof of Proposition 7.2.1 until the next paragraph.


Figure 4. Arcs $\xi_{i}$ and $u_{i}$
7.2.1. A preliminary case. We first study the following simple situation

- Let $\xi$ and $\eta$ be two closed curves. Assume that $\xi=\xi_{1} \cdot \xi_{2}$ and $\zeta=\zeta_{1} \cdot \zeta_{2}$. Assume that of all $i, j, \xi_{i}$ and $\zeta_{j}$ are closed curves with transverse intersections that do not intersect at their origin.
- Let $u_{i}$ and $v_{j}$ be arcs from $x_{0}$ to $\xi_{i}$ and $\eta_{j}$ respectively.
- Let $\tilde{\xi}_{i}:=u_{i} \xi_{i} u_{i}^{-1}, \tilde{\zeta}_{j}:=v_{j} \zeta_{j} v_{j}^{-1}$ and $c_{x}^{i, j}:=c_{x}\left(\tilde{\xi}_{i}, \tilde{\zeta}_{j}\right) \in \pi_{1}\left(S, x_{0}\right)$ for $x \in \xi_{i} \cap \zeta_{j}$.

Proposition 7.2.2. We have the following equality in $\mathbb{Q}[\mathcal{C}]$,

$$
\begin{equation*}
\sum_{x \in \xi \cap \zeta} \iota(x) \xi *{ }_{x} \zeta=\sum_{\substack{x \in \xi_{i} \cap \zeta_{j} \\ 1 \leqslant i, j \leqslant 2}} \iota(x) \tilde{\xi}_{i} \cdot \tilde{\xi}_{i+1} \cdot c_{x}^{i, j} \cdot \tilde{\zeta}_{j} \cdot \tilde{\zeta}_{j+1} \cdot\left(c_{x}^{i, j}\right)^{-1} \tag{49}
\end{equation*}
$$

Proof. First, we observe that for any two pairs of curves $\left(\xi_{1}, \xi_{2}\right)$ and $\left(\zeta_{1}, \zeta_{2}\right)$ we have

$$
\left(\xi_{1} \cdot \xi_{2}\right) \cap\left(\zeta_{1} \cdot \zeta_{2}\right)=\bigsqcup_{i, j}\left(\xi_{i} \cap \zeta_{j}\right)
$$

Let us denote

$$
c_{x}:=c_{x}\left(\tilde{\xi}_{1} \cdot \tilde{\xi}_{2}, \tilde{\zeta}_{1} \cdot \tilde{\zeta}_{2}\right)
$$

We then have

$$
\begin{aligned}
& x \in \xi_{1} \cap \zeta_{1} \Longrightarrow \\
& c_{x}=c_{x}^{1,1} \\
& x \in \xi_{2} \cap \zeta_{1} \Longrightarrow \\
& c_{x}=\tilde{\xi}_{1} \cdot c_{x}^{2,1} \\
& x \in \xi_{1} \cap \zeta_{2} \Longrightarrow \\
& c_{x}=c_{x}^{1,2} \cdot \tilde{\zeta}_{1}^{-1} \\
& x \in \xi_{2} \cap \zeta_{2} \Longrightarrow \\
& c_{x}=\tilde{\xi}_{1} \cdot c_{x}^{2,2} \cdot \tilde{\zeta}_{1}^{-1}
\end{aligned}
$$

Thus in all cases, if $x \in \xi_{i} \cap \zeta_{j}$ we have the following equality of free homotopy classes

$$
\tilde{\xi}_{1} \tilde{\xi}_{2} c_{x} \tilde{\zeta}_{1} \tilde{\zeta}_{2}=\tilde{\xi}_{i} \tilde{\xi}_{i+1} \cdot c_{x}^{i, j} \cdot \tilde{\zeta}_{j} \cdot \tilde{\zeta}_{j+1} \cdot\left(c_{x}^{i, j}\right)^{-1}
$$

Thus we obtain the product formula.

$$
\begin{align*}
& \sum_{x \in\left(\xi_{1} \xi_{2}\right) \cap\left(\zeta_{1} \zeta_{2}\right)} \iota(x) \\
&\left(\tilde{\xi}_{1} \cdot \tilde{\zeta}_{2} \cdot c_{x} \cdot \tilde{\zeta}_{1} \cdot \tilde{\zeta}_{2} \cdot c_{x}^{-1}\right)  \tag{50}\\
&= \sum_{i, j}\left(\sum_{x \in \xi_{i} \cap \zeta_{j}} \iota(x)\left(\tilde{\xi}_{i} \tilde{\xi}_{i+1} \cdot c_{x}^{i, j} \cdot \tilde{\zeta}_{j} \cdot \tilde{\zeta}_{j+1} \cdot\left(c_{x}^{i, j}\right)^{-1}\right)\right)
\end{align*}
$$

This concludes the proof
7.2.2. Proof of Proposition 7.2.1. Obviously Formula (48) is an immediate consequence of Formula (47), so we concentrate on the latter.

First, we observe that the product formula when $\xi_{i}$ and $\zeta_{j}$ are closed curves follows by induction from Proposition 7.2.2.

Let us now make the following observation. Let $a, \xi$ and $\zeta$ be three arcs, transverse to a curve $\kappa$. Assume that $\xi \cdot a \cdot a^{-1} . \zeta$ is a closed curve, then we have the following equalities in $\mathbb{Q}[\mathcal{C}]$

$$
\begin{align*}
\xi \cdot a \cdot a^{-1} \zeta & =\xi \cdot \zeta,  \tag{51}\\
\sum_{x \in(\xi \cdot \zeta) \cap \kappa} \iota(x) \xi \cdot \zeta \cdot c_{x} \kappa \cdot c_{x}^{-1} & =\sum_{x \in\left(\xi \cdot a \cdot a^{-1} \cdot \zeta\right) \cap \kappa} \iota(x) \xi \cdot a \cdot a^{-1} \cdot \zeta \cdot c_{x} \kappa \cdot c_{x}^{-1} .
\end{align*}
$$

The first equality is obvious. For the second we notice that every intersection point of $a$ with $\kappa$ appears twice with a different sign.

We can now extend the product formula to arcs: we choose auxiliary $\operatorname{arcs} \alpha_{i}$ joining $x_{0}$ to the initial point of $\xi_{i}$, similarly auxiliary arcs $\beta_{i}$ joining $x_{0}$ to the initial point of $\zeta_{i}$ and replace $\xi_{i}$ by the closed curves $\hat{\xi}_{i}=\alpha_{i} \xi_{i} \alpha_{i+1}^{-1}$ and $\hat{\zeta}_{i}=\beta_{i} \zeta_{i} \beta_{i+1}^{-1}$ respectively. From Assertion (51), since the product formula holds for the closed curves $\hat{\zeta}_{j}$ and $\hat{\xi}_{i}$, it holds for the $\operatorname{arcs} \zeta_{j}$ and $\xi_{i}$.
7.3. Bouquets in good position and the product formula. We shall need a special case of the product formula when we allow some repetitions in the arcs.

### 7.3.1. Bouquets in good position.

Definition 7.3.1. [Flowers And bouquets]
(1) A flower based at $\left(x_{0}, \ldots, x_{q}\right)$ is a collection of arcs

$$
\mathcal{S}:=\left(\left(g_{0}, \ldots, g_{q}\right),\left(\alpha_{0}, \ldots, \alpha_{q}\right)\right),
$$

such that

- $g_{i}$ are closed curves based at $x_{i}$ representing primitive elements in the fundamental group,
- $\alpha_{i}$ are arcs, called connecting arcs, joining $x_{i}$ to $x_{i+1}$.
(2) $A$ bouquet is a triple

$$
\mathcal{C}=\left(\mathcal{S}_{0}, \mathcal{S}_{1}, V\right)
$$

where $\mathcal{S}_{1}$ and $\mathcal{S}_{0}$ are flowers based at $\left(x_{0}, \ldots, x_{q}\right)$ and $\left(y_{0}, \ldots, y_{q^{\prime}}\right)$ respectively and $V$ is an arc joining $x_{0}$ and $y_{0}$.
(3) We finally say that the bouquet $\mathcal{C}$ represents $\left(\left(\gamma_{0}, \ldots, \gamma_{q}\right),\left(\eta_{0}, \ldots, \eta_{q^{\prime}}\right)\right)$, where $\gamma_{i}$ and $\eta_{j}$ are the elements of $\pi_{1}\left(S, x_{0}\right)$ defined by $\gamma_{i}=$ $U_{i} g_{i} U_{i}^{-1}$ and $\eta_{j}=V_{j} h_{j} V_{j}^{-1}$, where $U_{i}:=\alpha_{0} \ldots \alpha_{i-1}$ and $V_{j}:=$ V. $\beta_{0} \ldots \beta_{j-1}$,

We shall also need bouquets which have special configuration: let

$$
\mathcal{C}=\left(\left(\left(g_{0}, \ldots, g_{q}\right),\left(\alpha_{0}, \ldots, \alpha_{q}\right)\right),\left(\left(h_{0}, \ldots, h_{q^{\prime}}\right),\left(\beta_{0}, \ldots, \beta_{q}\right)\right), V\right)
$$

be a bouquet of flowers based respectively at $\left(x_{0}, \ldots, x_{q}\right)$ and $\left(y_{0}, \ldots, y_{q^{\prime}}\right)$.
Definition 7.3.2. [GOOD POSITION] We say
(1) $\mathcal{C}$ is in a good position if

- the arcs $\alpha_{i}$ and $g_{i}$ intersect transversally the arcs $\beta_{j}$ and $h_{j}$ at points different than $x_{i}$ and $y_{j}$ for all $i, j$,
- the closed curves $\alpha_{0} \ldots \alpha_{q}$ and $\beta_{0} \ldots \beta_{q^{\prime}}$ are homotopic to zero.
(2) $\mathcal{C}$ is in a homotopically good position if it is in a good position and if the following intersection loops are homotopically trivial

$$
\begin{align*}
& c_{x}\left(U_{i} \cdot \alpha_{i}, V_{j} \cdot \beta_{j}\right), \text { for } x \in \alpha_{i} \cap \beta_{j} \\
& c_{x}\left(U_{i} \cdot \alpha_{i}, V_{j} \cdot h_{j}\right), \text { for } x \in \alpha_{i} \cap h_{j} \\
& c_{x}\left(U_{i} \cdot g_{i}, V_{j} \cdot \beta_{j}\right), \text { for } x \in g_{i} \cap \beta_{j}, \tag{52}
\end{align*}
$$

where $U_{i}:=\alpha_{0} \ldots \alpha_{i-1}$ and $V_{j}:=V . \beta_{0} \ldots \beta_{i-1}$.
In Figure 5, we have represented two flowers, one in blue, the other in red where the connecting $\operatorname{arcs} \alpha_{i}$ and $\beta_{i}$ are dotted. In this figure all intersection loops corresponding to the four yellow transverse intersection points are drawn in the orange contractible region. Thus the bouquet is in a homotopically good position.


Figure 5. Bouquet in good position
7.3.2. Product formula for bouquets. Let $\mathcal{C}$ be a bouquet as above in good position. Let us consider the closed curves

$$
\begin{aligned}
\mathbf{F}_{i}^{(p, m)} & :=U_{i} \cdot g_{i}^{n} \cdot\left(\alpha_{i} \cdot g_{i+1}^{p} \alpha_{i+1} \ldots g_{i-1}^{p} \alpha_{i-1}\right) g_{i}^{p-n} U_{i}^{-1} \\
\mathbf{G}_{i}^{(p, m)} & :=V_{i} \cdot h_{i}^{n} \cdot\left(\beta_{i} \cdot h_{i+1}^{p} \beta_{i+1} \ldots h_{i-1}^{p} \beta_{i-1}\right) h_{i}^{p-n} V_{i}^{-1}
\end{aligned}
$$

To simplify notation, let us write $\mathbf{F}^{(p)}:=\mathbf{F}_{0}^{(p, 0)}$ and $\mathbf{G}^{(p)}:=\mathbf{G}_{0}^{(p)}$.
Let us denote
$H_{i, j}:=\left\{c_{x}\left(U_{i} . g_{i}, V_{j} . h_{j}\right) \mid x \in g_{i} \cap h_{j}, c_{x}\left(U_{i} . g_{i}, V_{j} . h_{j}\right)\right.$ is homotopically trivial $\}$, $C_{i, j}:=\left\{c_{x}\left(U_{i} . g_{i}, V_{j} . h_{j}\right) \mid x \in g_{i} \cap h_{j}, c_{x}\left(U_{i} . g_{i}, V_{j} . h_{j}\right)\right.$ not homotopically trivial $\}$,
Let finally

$$
\begin{array}{rlrl}
\mathrm{f}_{i, j}(\mathcal{C}) & =\sum_{\xi \in H_{i, j}} I_{i, j}(\xi), & \mathrm{m}_{i, j}(\mathcal{C}):=\iota\left(g_{i}, \beta_{j}\right), \\
\mathrm{n}_{i, j}(\mathcal{C}):=\iota\left(\alpha_{i}, h_{j}\right), & \mathrm{q}_{i, j}(\mathcal{C}):=\iota\left(\alpha_{i}, \beta_{j}\right), \tag{53}
\end{array}
$$

where we recall that for any $\xi \in \pi_{1}(S)$, we denote

$$
I_{i, j}(\xi)=\sum_{x \in g_{i} \cap h_{j} \mid c_{x}\left(U_{i} \cdot g_{i}, V_{j}, h_{j}\right)=\xi} \iota(x) .
$$

We can rewrite the product formula.

Proposition 7.3.3. [Product Formula in good position] Assuming the bouquet $\mathcal{C}$ is in a homotopically good position and using the above notation, we have the following equality in $\mathbb{Q}[\mathcal{C}]$,

$$
\begin{align*}
\left\{\mathbf{F}^{(p)}, \mathbf{G}^{(p)}\right\}= & \sum_{\substack{0 \leqslant \leqslant \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(\sum_{\substack{1 \leqslant m^{\prime} \leqslant p \\
1 \leqslant m \leqslant p}} \mathrm{f}_{i, j}(\mathcal{C})\left(\mathbf{F}_{i}^{\left.\left(p, m^{\prime}\right)\right)} \mathbf{G}_{j}^{(p, m)}\right)+\sum_{1 \leqslant m \leqslant p} \mathrm{~m}_{i, j}(\mathcal{C})\left(\mathbf{F}_{i}^{(p, m))} \mathbf{G}_{j}^{(p, 0)}\right)\right. \\
& \left.+\sum_{1 \leqslant m^{\prime} \leqslant p} \mathrm{n}_{i, j}(\mathcal{C})\left(\mathbf{F}_{i}^{(p, 0)} \mathbf{G}_{j}^{\left(p, m^{\prime}\right)}\right)+\mathrm{q}_{i, j}(\mathcal{C})\left(\mathbf{F}_{i}^{(p, 0)} \mathbf{G}_{j}^{(p, 0)}\right)\right) \\
& +\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}} \sum_{\xi \in C_{i, j}} I_{i, j}(\xi)\left(\sum_{\substack{1 \leqslant m^{\prime} \leqslant p \\
1 \leqslant m \leqslant p}}\left(\mathbf{F}_{i}^{\left(p, m^{\prime}\right)} \xi \mathbf{G}_{j}^{(p, m)} \xi^{-1}\right)\right) \tag{54}
\end{align*}
$$

Proof. This will be just another way to write the product formula. We consider the arcs $\xi_{i}$ defined by

- $\xi_{i}:=g_{j}$ if $i=j .(p+1)+n$ with $1 \leqslant n \leqslant p$,
- $\xi_{i}:=\alpha_{j}$ if $i=j(p+1)$.

Similarly, we consider the arcs $\zeta_{i}$

- $\zeta_{i}:=h_{j}$ if $i=j \cdot(p+1)+n$ with $1 \leqslant n \leqslant p$,
- $\zeta_{i}:=\beta_{j}$ if $i=j .(p+1)$.

Let now finally consider the following arcs,

- $u_{i}:=U_{j}=\alpha_{0} \ldots \alpha_{j}$, if $i=j .(p+1)+n$ with $1 \leqslant n \leqslant p$,
- $v_{i}:=V_{j}=V . \beta_{0} \ldots \beta_{j}$, if $i=j .(p+1)+n$ with $1 \leqslant n \leqslant p$,
so that $u_{i}$, respectively $v_{i}$, goes from $x_{0}$ to $x_{j}$, respectively $x_{0}$ to $y_{j}$.
We now apply Formulae (47) and (54) for the $\operatorname{arcs} \xi_{i}, u_{i}, \zeta_{j}, v_{j}$. Observe that using the notation of Paragraph 7.2, we have

\mathbf{F}^{(p)}=A, \quad \mathbf{G}^{(p)}=B
$$

We now have to identify the term in the righthand sides of Formulae (47) and (54), and in particular understand the arcs $A_{i}, B_{j}, c_{x}^{i, j}$ that appears in the righthand side of Formula (54). By definition

A_{i}=u_{i} \xi_{i} \xi_{i+1} \ldots \xi_{i-1} u_{i}^{-1}
$$

Thus if $i=j(p+1)+m$ with $0 \leqslant m \leqslant p$

A_{i}=\mathbf{F}_{j}^{(p, m)}
$$

and by a similar argument

$$
B_{i}=\mathbf{G}_{j}^{(p, m)}
$$

By definition if $x \in \xi_{i} \cap \zeta_{j}$,

$$
c_{x}^{i, j}=c_{x}\left(u_{i} \xi_{i}, v_{j} \zeta_{j}\right)
$$

We now observe that,
(1) if $i=j .(p+1)$, then $u_{i} \xi_{i}=U_{j} . g_{j}$,
(2) if $i=j \cdot(p+1)+n$ with $1 \leqslant m \leqslant p$, then $u_{i} \xi_{i}=U_{j} \cdot \alpha_{j}$,
and similary
(1) if $i=j .(p+1)$, then $v_{i} \zeta_{i}=V_{j} . h_{j}$,
(2) if $i=j .(p+1)+n$ with $1 \leqslant m \leqslant p$, then $v_{i} \zeta_{i}=V_{j} \cdot \beta_{j}$,

Then the special Product Formula (54) is a consequence of the Product Formula (47): indeed, thanks to the "homotopically good position" hypothesis, many of the intersection loops $c_{x}^{i, j}$ are homotopically trivial.
7.4. Bouquets and covering. Let $\pi: S_{1} \rightarrow S_{0}$ be a finite covering. Let

$$
\mathcal{C}=\left(\left(\left(g_{0}, \ldots, g_{q}\right),\left(\alpha_{0}, \ldots, \alpha_{q}\right)\right),\left(\left(h_{0}, \ldots, h_{q^{\prime}}\right),\left(\beta_{0}, \ldots, \beta_{q}\right)\right), V\right)
$$

be a bouquet of flowers in $S_{0}$ based respectively at $\left(x_{0}, \ldots, x_{q}\right)$ and $\left(y_{0}, \ldots, y_{q^{\prime}}\right)$.

Let $\hat{x}_{0}$ be a lift of $x_{0}$ in $S_{1}$.
Definition 7.4.1. The bouquet of flowers in $S_{1}$

$$
\widehat{\mathcal{C}}=\left(\left(\left(\hat{g}_{0}, \ldots, \hat{g}_{q}\right),\left(\hat{\alpha}_{0}, \ldots, \hat{\alpha}_{q}\right)\right),\left(\left(\hat{h}_{0}, \ldots, \hat{h}_{q^{\prime}}\right),\left(\hat{\beta}_{0}, \ldots, \hat{\beta}_{q}\right)\right), \hat{V}\right)
$$

is the lift of $\mathcal{C}$ through $\hat{x}_{0}$ if,

- all arcs $\hat{V}, \hat{\alpha}_{i}$ and $\hat{\beta}_{i}$ are lifts of the arcs $V, \alpha_{i}$ and $\beta_{i}$.
- $\hat{g}_{0}$ is based at $\hat{x}_{0}$.
- the closed curves $\hat{g}_{i}$ and $\hat{h}_{j}$ are the primitive lifts of the curves $g_{i}$ and $h_{j}$, in other words the primitive curves which are lift of positive powers of the curves $g_{i}$ and $h_{j}$.

Observe that the lift of a bouquet in homotopically good position is in homotopically good position.
7.5. Finding bouquets in good position. Let $S$ be a closed hyperbolic surface and $\tilde{S}$ its universal cover. Let $G=\left(\gamma_{0}, \ldots, \gamma_{q}\right)$ and $F=\left(\eta_{0}, \ldots, \eta_{q^{\prime}}\right)$ be two tuples of primitive elements of $\pi_{1}(S)$ such that for all $i,\left(\gamma_{i}, \gamma_{i+1}\right)$, are pairwise coprime as well as $\left(\eta_{i}, \eta_{i+1}\right)$, where the index $i$ lives in $\mathbb{Z} / q \mathbb{Z}$ and $\mathbb{Z} / q^{\prime} \mathbb{Z}$ respectively. Recall that we denote by $\tilde{\zeta}$ the axis of the element $\zeta \in \pi_{1}(S)$.

Definition 7.5.1. We say $G$ and $F$ satisfy the Good Position Hypothesis if there exists a metric ball $B$ in $\tilde{S}$ such that
(1) for all $i$ and $j$ so that $\gamma_{i}$ and $\eta_{j}$ are coprime,

$$
\begin{equation*}
\tilde{\gamma}_{i} \cap \tilde{\eta}_{j} \subset B \tag{55}
\end{equation*}
$$

(2) for all $\xi \in \pi_{1}(S) \backslash\{1\}$ we have

$$
\begin{equation*}
B \cap \xi(B)=\emptyset \tag{56}
\end{equation*}
$$

(3) for all $\zeta \in\left\{\gamma_{0}, \ldots, \gamma_{q}, \eta_{0}, \ldots, \eta_{q^{\prime}}\right\}$, for all $\xi \in \pi_{1}(S) \backslash\langle\zeta\rangle$ we have

$$
\begin{equation*}
B \cap \xi(\tilde{\zeta})=\emptyset \tag{57}
\end{equation*}
$$

(4) for all $\zeta \in\left\{\gamma_{0}, \ldots, \gamma_{q}, \eta_{0}, \ldots, \eta_{q^{\prime}}\right\}$, for all $\xi \in \pi_{1}(S) \backslash\langle\zeta\rangle$ we have

$$
\begin{equation*}
\tilde{\zeta} \cap \xi(\tilde{\zeta})=\emptyset . \tag{58}
\end{equation*}
$$

In other words, the closed geodesic corresponding to $\zeta$ is embedded.

Then, we have the following result
Proposition 7.5.2. With the notation above, assume that $G, F$ and $\pi_{1}(S)$ satisfy the Good Position Hypothesis, then there exist two bouquets $\mathcal{C}_{L}$ and $\mathcal{C}_{L}$ in $S$ in a homotopically good position, both representing $(G, F)$ such that furthermore

$$
\begin{align*}
\frac{1}{2}\left(\mathrm{f}_{i, j}\left(\mathcal{C}_{L}\right)+\mathrm{f}_{i, j}\left(\mathcal{C}_{R}\right)\right) & =\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right],  \tag{59}\\
\frac{1}{2}\left(\mathrm{n}_{i, j}\left(\mathcal{C}_{L}\right)+\mathrm{n}_{i, j}\left(\mathcal{C}_{R}\right)\right) & =\left[\gamma_{i}^{-} \gamma_{i+1}^{-}, \eta_{j}^{-} \eta_{j}^{+}\right],  \tag{60}\\
\frac{1}{2}\left(\mathrm{~m}_{i, j}\left(\mathcal{C}_{L}\right)+\mathrm{m}_{i, j}\left(\mathcal{C}_{R}\right)\right) & =\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j+1}^{-}\right],  \tag{61}\\
\frac{1}{2}\left(\mathrm{q}_{i, j}\left(\mathcal{C}_{L}\right)+\mathrm{q}_{i, j}\left(\mathcal{C}_{R}\right)\right) & =\left[\gamma_{i}^{-} \gamma_{i+1}^{-}, \eta_{j}^{-} \eta_{j+1}^{-}\right] . \tag{62}
\end{align*}
$$

Proof. Let $G$ and $F$ be as above and $B$ be a metric ball in $\tilde{S}$ satisfying the assumptions (55), (56) and (57). We subdivide the proof in several steps. WE denote by $\pi$ the projection from $\tilde{S}$ to $S$.
Step 1: Construction of the bouquet in good position
Let $\tilde{\gamma}_{i}$ be the axis of $\gamma_{i}$, let $\varepsilon$ be some constant that we shall choose later to be very small and $\tilde{\eta}_{j}^{\varepsilon}$ be a curve (with constant geodesic curvature) at distance $\varepsilon$ of the axis $\tilde{\eta}_{j}$ of $\eta_{j}$ (Notice that we have too such curves, for the moment we choose arbitrarily one of them). We choose $\varepsilon$ small enough so that Assertions (55) and (57) still hold when $\tilde{\eta}_{j}$ are replaced by $\tilde{\eta}_{j}^{\varepsilon}$.

For every $i$, let $x_{i} \in \tilde{\gamma}_{i} \cap B$ so that

$$
\tilde{\gamma}_{i} \cap B \subset\left[x_{i}, \gamma_{i}^{+}[\right.
$$

similarly, let $y_{j} \in \tilde{\eta}_{j}^{\varepsilon}$ so that

$$
\tilde{\eta}_{i}^{\varepsilon} \cap B \subset\left[y_{i}, \eta_{i}^{+}\left[_{\varepsilon},\right.\right.
$$

where $[a, b]_{\varepsilon}$ denote an arc joining $a$ to $b$ along a curve at a distance $\varepsilon$ to a geodesic (see Figure 6).


Figure 6. Finding a bouquet in good position
We now consider geodesics $\operatorname{arcs} \tilde{\alpha}_{i}, \tilde{\beta}_{j}$ and $\tilde{V}$ in $\tilde{S}$ joining respectively $x_{i}$ to $x_{i+1}, y_{j}$ to $y_{j+1}$ and $x_{0}$ to $y_{0}$. We furthermore choose $B$ (and $\varepsilon$ ) so that all the $\operatorname{arcs} \tilde{\alpha}_{i}, \tilde{\eta}_{j}^{\varepsilon} \tilde{\gamma}_{j}$ and $\tilde{\beta}_{j}$ are transverse. In particular, if

$$
\begin{align*}
\alpha_{i}=\pi\left(\tilde{\alpha}_{i}\right), & \beta_{i}=\pi\left(\tilde{\beta}_{i}\right), V=\pi(\tilde{V}), \\
\left.\tilde{g}_{i}=\left[x_{i}, \gamma\left(x_{i}\right)\right]\right), & \tilde{h}_{j}=\left[y_{j}, \eta_{j}\left(y_{j}\right)\right]_{\varepsilon}, \\
g_{i}=\pi\left(\left[x_{i}, \gamma\left(x_{i}\right)\right]\right), & h_{j}=\pi\left(\left[y_{j}, \eta_{j}\left(y_{j}\right)\right]_{\varepsilon}\right), \tag{63}
\end{align*}
$$

then

$$
\mathcal{C}=\left(\left(\left(g_{0}, \ldots, g_{q}\right),\left(\alpha_{0}, \ldots, \alpha_{q}\right)\right),\left(\left(h_{0}, \ldots, h_{q^{\prime}}\right),\left(\beta_{0}, \ldots, \beta_{q^{\prime}}\right)\right), V\right)
$$

is in good position. Observe furthermore that $\mathcal{C}$ represents $(G, F)$.

## Step 2: homotopically good position

Let us now prove that $\mathcal{C}$ is in a homotopically good position. Let as usual

$$
\begin{equation*}
U_{i}=\alpha_{0} \ldots \alpha_{i-1}, \quad V_{j}=V \cdot \beta_{0} \ldots \beta_{j-1}, \tag{64}
\end{equation*}
$$

and

$$
\begin{equation*}
\tilde{U}_{i}=\tilde{\alpha}_{0} \ldots \tilde{\alpha}_{i-1}, \quad \tilde{V}_{j}=\tilde{V} \cdot \tilde{\beta}_{0} \ldots \tilde{\beta}_{j-1} . \tag{65}
\end{equation*}
$$

Then $\tilde{U}_{i}$ and $\tilde{V}_{j}$ are the lifts of $U_{i}$ and $V_{j}$ respectively starting from $x_{0}$ and $y_{0}$ an ending respectively in $x_{i}$ and $y_{j}$.

Observe that all the $\operatorname{arcs} \tilde{\alpha}_{k}, \tilde{\beta}_{l}$ and $\tilde{V}$ lie in $B$. and thus so do the paths $\tilde{U}_{i}$ and $\tilde{V}_{j}$.

Let $W_{i}$ be equal to $\alpha_{i}$ or $g_{i}$. Let $\widehat{W}_{j}$ be equal to $\beta_{j}$ or $h_{j}$. Let us fix from now $x \in W_{i} \cap \widehat{W}_{j}$.

Let us introduce some notation,

- Let $a$ be the path along $W_{i}$ from $\pi\left(x_{i}\right)$ to $x$, and $\widehat{a}$ be the path along $\widehat{W}_{j}$ from $\pi\left(y_{j}\right)$ point to $x$.
- Let $b$ and $\widehat{b}$ the lifts of $a$ and $\widehat{a}$ in $\tilde{S}$ starting respectively from $x_{i}$ and $x_{j}$,
- Let finally $z$ and $\widehat{z}$ be the endpoints of $b$ and $\widehat{b}$ and $\zeta \in \pi_{1}(S)$ so that $z=\zeta(\widehat{z})$.
By construction $\zeta$ is conjugated to the intersection loop $c_{x}\left(U_{i} W_{i}, U_{j} \widehat{W}_{j}\right)$.
Let us now consider the various possibility about the position of $z$ and $\widehat{z}$.
(1) $W_{i}=\alpha_{i}$, then $b \subset \tilde{\alpha}_{i}$ and thus $z$ belongs to $B$.
(2) $W_{i}=g_{i}$, then $z \in\left[x_{i}, \gamma_{i}\left(x_{i}\right)\left[\subset\left[x_{i}, \gamma_{i}^{+}[\right.\right.\right.$,
(3) $\widehat{W}_{j}=\beta_{j}$, then, symmetrically, $\widehat{z}=\zeta(z)$ belongs to $B$.
(4) $\widehat{W}_{j}=h_{i}$, then, symmetrically, $\widehat{z} \in\left[y_{j}, \eta_{j}^{\varepsilon}\left(x_{j}\right){ }_{\varepsilon} \subset\left[y_{i}, \eta_{j}^{+}[\varepsilon\right.\right.$ (where the intervals are subsets of $\tilde{\eta}_{j}^{\varepsilon}$ ).
Our goal is now to prove that $\zeta=1$ unless, maybe, $W_{i}=g_{i}$ and $\widehat{W}_{j}=h_{j}$.
(1) $W_{i}=\alpha_{i}$ and $\widehat{W}_{j}=\beta_{j}$ then by Assertions (1) and (3) above, both $z$ and $\zeta(z)$ belong to $B$, and thus by Assertion (56), $\zeta=1$.
(2) $W_{i}=\alpha_{i}$ and $\widehat{W}_{j}=h_{j}$, then by Assertions (1) and (4), $\zeta(z) \in \tilde{\eta}_{j}^{\varepsilon}$ and $z \in B$. Thus $\zeta^{-1}\left(\tilde{\eta}_{i}^{\varepsilon}\right) \cap B \neq \emptyset$. Then by Hypothesis (57), $\zeta \in\left\langle\eta_{j}\right\rangle$. In particular $z \in B \cap \tilde{\eta}_{j}^{\varepsilon}$ and thus we have

$$
\begin{equation*}
z \in\left[y_{j}, \eta_{j}\left(y_{j}\right){ }_{\varepsilon},\right. \tag{66}
\end{equation*}
$$

Recall that from Assertion (4)

$$
\begin{equation*}
\zeta(z)=\widehat{z} \in\left[y_{j}, \eta_{i}\left(y_{j}\right){ }_{\varepsilon} .\right. \tag{67}
\end{equation*}
$$

Since $\eta_{j}$ is primitive and $\zeta \in\left\langle\eta_{j}\right\rangle$, we obtain from Assertions (66) and (67) that $\zeta=1$.
(3) A symmetric argument proves that when $W_{i}=g_{i}$ and $\widehat{W}_{j}=\beta_{j}$, then $\zeta=1$
This finishes the proof that $\mathcal{C}$ is in a homotopically good position.

STEP 3: COMPUTATION OF THE INTERSECTION NUMBERS
Recall that for each (oriented) axis $\tilde{\eta}_{j}$ we had two choices of curves at distance $\varepsilon$. Let us denote by $\tilde{\eta}_{j}^{L}$ - respectively $\tilde{\eta}_{j}^{R}$ - the curve on the left -respectively on the right- to $\tilde{\eta}_{j}$. Let then $\mathcal{C}^{L}$ and $\mathcal{C}^{R}$ the corresponding collections of arcs.

We have proved that both $\mathcal{C}^{L}$ and $\mathcal{C}^{R}$ are in homotopically good position. Let us now compute the intersection numbers. We will do that step by step.

We shall repeat the following observation several time: let $g$ and $h$ be two curves in $S$ passing through a point $x_{0}$, intersecting transversally a finite number of points $x_{1}, \ldots x_{n}$. Let $\tilde{g}$ and $\tilde{h}$ the lift of these curves in $\tilde{S}$ passing through a point $\tilde{x}_{0}$. Then there the projection realizes a bijection between the set of theses $x_{i}$ whose intersection loop is trivial, and the intersections points of $\tilde{g}$ and $\tilde{h}$.

In particular

$$
\begin{equation*}
\sum_{x \in g \cap h \mid c_{x}(g, h)=1} \iota(x)=\sum_{z \in \tilde{g} \cap \tilde{h}} \iota(z) \tag{68}
\end{equation*}
$$

Proof of Equation (59): If $\gamma_{i}$ and $\eta_{j}$ are coprime, by Formula (68)and since two geodesics have at most one intersection point, we have that

$$
\mathrm{f}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right] .
$$

If $\gamma_{i}$ and $\eta_{j}$ are not coprime, since $g_{i}$ is embeded by Assumption (58), it follows that

$$
\iota\left(g_{i}, h_{j}\right)=0=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right] .
$$

Thus in both cases

$$
\mathrm{f}_{\mathrm{i}, \mathrm{j}}\left(\mathcal{C}^{L}\right)=\mathrm{f}_{\mathrm{i}, \mathrm{j}}\left(\mathcal{C}^{R}\right)=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right] .
$$

Proof of Equation (60): Since all the corresponding intersection loops are trivial, we see that

$$
\iota\left(g_{i}, \beta_{j}\right)=\iota\left(\tilde{\gamma}_{i}, \tilde{\beta}_{j}\right)
$$

We know that $\tilde{\beta}_{j} \subset B$. To simplify, let us first consider the case when $\gamma_{i}$ and $\eta_{k}$ are coprime for $k=j, j+1$. Then $\tilde{\gamma}_{i} \cap \tilde{\eta}_{k}^{\varepsilon} \subset B$ and thus

$$
\left.\left.\iota\left(\tilde{\gamma}_{i},\right] \eta_{k}^{-}, y_{k}\right]_{\varepsilon}\right)=0 .
$$

It follows then that

$$
\left.\left.\iota\left(g_{i}, \beta_{j}\right)=\iota\left(\tilde{\gamma}_{i},\right] \eta_{j}^{-}, y_{j}\right] \cup \tilde{\beta}_{j} \cup\right] y_{j+1}, \eta_{j+1}^{-}[)=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j+1}^{-}\right] .
$$

We illustrate that situation in Figure 7a


Figure 7. Intersection computations

Let us move to the remaining cases. The purpose of taking the "left and right perturbations" of $\tilde{\eta}_{j}$ is to take care of the situation when $\eta_{j}$ (or $\eta_{j+1}$ ) and $\gamma_{i}$ are not coprime. So let us assume now that $\tilde{\eta}_{j}=\tilde{\gamma}_{i}$ (the case when $\tilde{\eta}_{j+1}=\tilde{\gamma}_{i}$ is symmetric).

Then in this case assume that $\eta_{j+1}^{-}$is on the left of $\tilde{\eta}_{j}$ and $\tilde{\gamma}_{i}$ has the same orientation as $\tilde{\eta}_{j}$ (the other cases being symmetric). It then follows that

$$
\begin{align*}
\mathrm{m}_{i, j}\left(\mathcal{C}^{L}\right) & =\iota\left(\tilde{\gamma}_{i}, \tilde{\beta}_{j}^{L}\right)  \tag{69}\\
\mathrm{m}_{i, j}\left(\mathcal{C}^{R}\right) & =\iota\left(\tilde{\gamma}_{i}, \tilde{\beta}_{j}^{R}\right) \tag{70}
\end{align*}=1 .
$$

It follows that

$$
\frac{1}{2}\left(\mathrm{~m}_{i, j}\left(\mathcal{C}^{L}\right)+\mathrm{m}_{i, j}\left(\mathcal{C}^{R}\right)\right)=\frac{1}{2}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j+1}^{-}\right] .
$$

We illustrate that case in Figure 7b. This finishes the proof of Equation (60).

Proof of Equation (61) and (62): The proof follows from the same ideas as the previous ones.

## 8. Asymptotics

This section is the main computational core of this article. Our goal is to compute asymptotic product formulas, namely understand the behavior of the special product formula when the repetition in the arcs becomes infinite. This allows us to describe the limit of certain Wilson loops as elementary functions - see Proposition 8.2.5.

The goal of this section is to obtain Corollary 8.3.2 which is an asymptotic product formula for the Goldman bracket of elementary functions.

We first need some facts about vanishing sequences
8.1. Properties of vanishing sequences. In this paragraph, we shall be given a vanishing sequence $\left\{\Gamma_{p}\right\}_{p \in \mathbb{N}}$ of finite index subgroups of $\pi_{1}(S)$. We need some notation and definition

- Let $\mathrm{gh}_{p}$ be the function defined on $\mathrm{H}(n, S)$ by

$$
\operatorname{gh}_{p}(\rho)=\operatorname{gh}\left(\left.\rho\right|_{\Gamma_{p}}\right) .
$$

- For any positive integer $p$ and primitive element $\xi$ in $\Gamma_{0}$, let $\xi(p)$ be the positive integer so that

$$
\left\langle\xi^{\xi(p)}\right\rangle=\langle\xi\rangle \cap \Gamma_{p} .
$$

We write $\xi_{p}=\xi^{\xi(p)}$ and we denote the associated closed geodesic by $\tilde{\xi}_{p}$.

Definition 8.1.1. [ $N$-NICE COVERING] Let $\gamma$ and $\eta$ be primitive coprime elements of $\Gamma_{0}=\pi_{1}(S)$. Let $N$ be a positive integer. We say that $\Gamma_{p}$ is $N$-nice with respect to $\gamma$ and $\eta$, if the intersection loop $c_{x}\left(\tilde{\gamma}_{p}, \tilde{\eta}_{p}\right)$ is either trivial or satisfies

$$
\pi_{p}\left(c_{x}\left(\tilde{\gamma}_{p}, \tilde{\eta}_{p}\right)\right)=\gamma^{k_{1}} \cdot \eta^{-k_{2}}
$$

where $k_{1}$ and $k_{2}$ satisfy

$$
\gamma(p)-N>k_{1}>N \text { and } \eta(p)-N>k_{2}>N .
$$

We need the following properties of vanishing sequences which we summarize in the next proposition.

Proposition 8.1.2. Let $\left\{\Gamma_{p}\right\}_{p \in \mathbb{N}}$ be a vanishing sequence of finite index subgroups of $\pi_{1}(S)$. Then
(1) when $p$ goes to infinity, $\mathrm{gh}_{p}$ converge uniformly to 0 on every compact of $\mathrm{H}(n, S)$,
(2) for any primitive coprime elements $\gamma$ and $\eta$, there exists $p_{0}$ so that for every $p>p_{0}, \Gamma_{p}$ is $N$-nice with respect to $\gamma$ and $\eta$.
(3) Let $G=\left(\gamma_{0}, \ldots, \gamma_{p}\right)$ and $F=\left(\eta_{0}, \ldots, \eta_{q}\right)$ be tuples of primitive elements of $\pi_{1}(S) \backslash\{1\}$ such that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are pairwise coprime. Then for $p$ large enough, $G$ and $F$ satisfy the Good Position Hypothesis \%.5.1 as elements of $\pi_{1}\left(S_{p}\right)$.
8.1.1. Proof of Proposition 8.1.2. Proposition 8.1.2 is the concatenation of Propositions 8.1.3, 8.1.5 and 8.1.6. Proposition 8.1.4 is an intermediate step in proving Proposition 8.1.6. We fix in this paragraph a vanishing sequence $\left\{\Gamma_{p}\right\}_{p \in \mathbb{N}}$.

Remember that we identify primitive elements in $\pi_{1}(S)$ and in any of its finite index subgroup.

Proposition 8.1.3. When $p$ goes to infinity, $\mathrm{gh}_{p}$ converge uniformly to 0 on every compact of $\mathrm{H}(n, S)$.

Proof. For all positive number $K$ and compact $C$, let

$$
S_{K}:=\left\{\gamma \in \pi_{1}(S) \backslash\{\operatorname{Id}\} \mid \exists \rho \in C, \quad \text { width }(\rho(\gamma))<K\right\}
$$

Then the set of conjugacy classes in $S_{K}$ is a finite set. Let $S_{K}^{0}$ be a finite set in $\pi_{1}(S)$ of representatives of the conjugacy classes of $S_{K}$. From the definition of vanishing sequences, it follows that there exists $n_{0}$ that that for all $p>p_{0}$, we have

$$
S_{K}^{0} \cap \Gamma_{p}=\emptyset .
$$

Since $\Gamma_{p}$ is normal, it follows that

$$
S_{K} \cap \Gamma_{p}=\emptyset .
$$

Then by definition, the girth of any representation in $C$ restricted to $\Gamma_{n}$ is greater than $K$. Thus the family of functions $\mathrm{gh}_{p}$ converges uniformly to zero, when $p$ goes to $\infty$.

The following proposition is well known.
Proposition 8.1.4. Let $\gamma$ be an element of $\Gamma_{0}$. Then there exists $p_{0}$ such that for all $p>p_{0}$, the geodesics $\tilde{\gamma}_{p}$ is simple.

Proof. Let

$$
\hat{A}_{\gamma}:=\left\{\xi \in \Gamma_{0} \mid \xi(\tilde{\gamma}) \cap \tilde{\gamma} \neq \emptyset .\right\} \subset \Gamma_{0} /\langle\gamma\rangle .
$$

Observe that $A_{\gamma}$ invariant by right multiplication by $\gamma$ and that its projection in $\Gamma_{0} /\left\langle\gamma\right.$ is a finite set. Thus there exists $p_{0}$ so that for every $p>p_{0}$,

$$
A_{\gamma} \cap \Gamma_{p} \subset\langle\gamma\rangle
$$

This implies that the projection of $\tilde{\gamma}$ in $S_{p}$ is a simple closed geodesic, indeed the existence of a self intersection point implies the existence of an element $\xi$ in $\Gamma_{p}$ so that $\xi(\tilde{\gamma}) \cap \tilde{\gamma} \neq \emptyset$.

We finally need.

Proposition 8.1.5. Let $\gamma$ and $\eta$ two coprime primitive elements of $\Gamma_{0}=\pi_{1}(S)$. Let $N$ be a positive integer.

Then there exists $p_{0}$ such that for all $p>p_{0}, \Gamma_{p}$ is $N$-nice with respect to $\gamma$ and $\eta$.

Proof. We assume using the previous proposition that $\tilde{\gamma}_{p}$ and $\tilde{\eta}_{p}$ are simple.
Step 1 We shall prove the following assertion
For any $N>0$, there exists $p_{0}$ such that for any $p>p_{0}$, for any integers $k$ such that $0<k \leqslant N$ and for any $m$ then

$$
\gamma^{k} \eta^{m} \notin \Gamma_{p} \text { and } \gamma^{m} \eta^{-k} \notin \Gamma_{p} .
$$

This is an immediate application of Proposition 6.2.2. Let $H:=\left\{\gamma^{k} \mid\right.$ $0<k \leqslant N$. Since $\gamma$ and $\eta$ are coprime then $H \cap\langle\eta\rangle=\emptyset$. Using Proposition, 6.2.2, we get that they exists $p_{0}$ so that for all $p>p_{0}$,

$$
H \cap\left(\Gamma_{p} \cdot\langle\eta\rangle\right)=\emptyset .
$$

In other words, for all $n$ and $k$ so that $0<k \leqslant N$,

$$
\gamma^{k} \cdot \eta^{n} \notin \Gamma_{p} .
$$

A symmetric argument concludes the proof.
Step 2 We now prove.
If $x \in \gamma_{p} \cap \eta_{p}$, then there exists positive integers $k_{1}$ and $k_{2}$ such that the intersection loop $c_{p}(x):=c_{x}\left(\tilde{\gamma}_{p}, \tilde{\eta}_{p}\right)$ satisfies

$$
\pi_{p}\left(c_{p}(x)\right)=\gamma^{k_{2}} \cdot \eta^{-k_{1}}
$$

where the equality is as homotopy classes in $S_{0}$
We can as well assume (using the first step and a shift in $p$ ) that the projection of the axis of $\gamma$ and $\eta$ are simple geodesics in $S_{0}$. Let also

$$
A_{p}:=\left\{\xi \in \Gamma_{p} \mid \xi(\tilde{\eta}) \cap \tilde{\gamma} \neq \emptyset\right\} \subset \Gamma_{p}
$$

Observe that $A_{p}$ is invariant by left multiplication by $\gamma$ and right multiplication by $\eta$. Let $\hat{A}_{p}$ be the projection of $A_{p}$ in $\left\langle\eta_{p}\right\rangle \backslash \Gamma_{p} /\left\langle\eta_{p}\right\rangle$. Observe also that we have a bijection from $\hat{A}_{p}$ to

$$
I_{p}:=\pi_{p}(\tilde{\gamma}) \cap \pi_{p}(\tilde{\eta}) \subset S_{p}
$$

given by

$$
\langle\gamma\rangle . \xi \cdot\langle\eta\rangle \rightarrow \pi_{p}(\xi(\tilde{\eta}) \cap \tilde{\gamma})
$$

In particular $\hat{A}_{p}$ is finite since $I_{p}$ is finite. Moreover, if $x$ in $I_{p}$ comes in this procedure from an element $a$ in $A_{p}$, then $a$ represents the intersection loop of $x$.

Since $\hat{A}_{0}$ is finite, using the double coset separability property, there exists $p_{0}$ such that for all $p>p_{0}$, we have

$$
A_{0} \cap \Gamma_{p} \subset\langle\gamma\rangle\langle\eta\rangle,
$$

Since $A_{p} \subset A_{0} \cap \Gamma_{p}$, It follows that the projection in $S_{0}$ of any intersection loop $c_{x}\left(\gamma_{p}, \eta_{p}\right)$ is homotopic to $\gamma^{n} \cdot \eta^{-m}$ with $n$ and $m$ positive integers.

Conclusion of the proof The Proposition follows at once from the two steps of the proof.

Proposition 8.1.6. Let $G=\left(\gamma_{0}, \ldots, \gamma_{p}\right)$ and $F=\left(\eta_{0}, \ldots, \eta_{q}\right)$ be tuples of primitive elements of $\pi_{1}(S) \backslash\{1\}$ such that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are pairwise coprime. Then for $p$ large enough, $G$ and $F$ satisfy the Good Position Hypothesis 7.5 .1 as elements of $\pi_{1}\left(S_{p}\right)$.

Proof. Let us check the three conditions of the Good Position Hypothesis. Let $G=\left(\gamma_{0}, \ldots, \gamma_{p}\right)$ and $F=\left(\eta_{0}, \ldots, \eta_{q}\right)$ be primitive elements of $\pi_{1}(S) \backslash\{1\}$ such that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are pairwise coprime.
(1) Let $B \subset \tilde{S}$ be ball containing all the intersections $\tilde{\gamma}_{i} \cap \tilde{\eta}_{j}$ when $\gamma_{i}$ and $\eta_{j}$ are coprime. Thus Condition (1) of the Good Position Hypothesis is satisfied.
(2) Let

$$
F:=\left\{\xi \in \pi_{1}(S) \mid B \cap \xi(B) \neq \emptyset\right\} .
$$

The set $F$ is finite. Thus, by Proposition 6.2.2 (applied to $\gamma=\eta=\mathrm{Id}$ ), there exists $p_{0}$, such that for all $p>p_{0}$, we have

$$
F \cap \Gamma_{p}=\{\operatorname{Id}\} .
$$

Thus Condition (2) of the Good Position Hypothesis is satisfied.
(3) Next, for every $\zeta \in\left\{\gamma_{0}, \ldots \gamma_{p}, \eta_{0}, \ldots, \eta_{q}\right\}$ the set

$$
H_{\zeta}:=\{\xi \in \Gamma /\langle\zeta\rangle \mid \xi(\tilde{\zeta}) \cap B \neq \emptyset\}
$$

finite. Thus by Proposition 6.2.2 (applied to $\gamma=\mathrm{Id}, \eta=\zeta$ ), there exists $p_{0}$, such that for all $p>p_{0}$, we have

$$
H_{\zeta}\langle\zeta\rangle \cap \Gamma_{p}=\langle\zeta\rangle .
$$

Thus Condition (3) of the Good Position Hypothesis is satisfied.
(4) Finally Condition (4) of the Good Position Hypothesis is satisfied for $p$ large enough by Proposition 8.1.4.
8.2. Asymptotic product formula for Wilson loops. In all this paragraph, we shall be be given a finite index subgroup $\Gamma_{k}$ of $\Gamma_{0}=$ $\pi_{1}(S)$, corresponding to a covering $S_{k} \rightarrow S_{0}=S$. Then, if $\rho$ is a Hitchin representation of $\pi_{1}(S)$ in $\mathrm{PSL}_{n}(\mathbb{R}), \rho_{k}$ will denote the restriction of $\rho$ to $\Gamma_{k}$.

Let $\left(\gamma_{0}, \ldots, \gamma_{q}\right)$ and $\left(\eta_{0}, \ldots, \eta_{q^{\prime}}\right)$ be two tuples of primitive elements of $\pi_{1}(S)$. We assume that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are all pairwise coprime.

Let then $\hat{\gamma}_{i}$ and $\hat{\eta}_{i}$ be the representatives of $\gamma_{i}$ and $\eta_{i}$ in $\Gamma_{k}$, and

$$
\begin{equation*}
\mathbf{F}^{(p)}=\hat{\gamma}_{1}^{p} \ldots \hat{\gamma}_{q}^{p}, \quad \mathbf{G}^{(p)}=\hat{\eta}_{1}^{p} \ldots \hat{\eta}_{q^{\prime}}^{p} . \tag{71}
\end{equation*}
$$

We want to understand the asymptotics when $p$ goes to infinity of the following function

$$
B_{p}^{k}\left(\gamma_{0}, \ldots, \gamma_{q} ; \eta_{0}, \ldots, \eta_{q^{\prime}}\right): \mathrm{H}\left(n, S_{k}\right) \rightarrow \mathbb{R},
$$

defined by

$$
\begin{equation*}
B_{p}^{k}\left(\gamma_{0}, \ldots, \gamma_{q} ; \eta_{0}, \ldots, \eta_{q^{\prime}}\right):=\frac{\mathrm{W}\left(\left\{\mathbf{G}^{(p)}, \mathbf{F}^{(p)}\right\}_{S_{k}}\right)}{\mathrm{W}\left(\mathbf{G}^{(p)}\right) \mathrm{W}\left(\mathbf{F}^{(p)}\right)} \tag{72}
\end{equation*}
$$

Let then

$$
\begin{array}{rr}
\mathrm{f}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right], & \mathrm{n}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i+1}^{-}, \eta_{j}^{-} \eta_{j}^{+}\right], \\
\mathrm{m}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j+1}^{-}\right], & \mathrm{q}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i+1}^{-}, \eta_{j}^{-} \eta_{j+1}^{-}\right] . \tag{73}
\end{array}
$$

The following paragraph is devoted to the proof of the following Proposition

Proposition 8.2.1. [ASYMPTOTIC PRODUCT FORMULA] For every compact set $U$ in $\mathrm{H}(n, S)$, for every positive integer $N$, then for $k$ large enough, we have for every $\rho$ in $U$

$$
\begin{gather*}
B_{p}^{k}\left(\gamma_{0}, \ldots, \gamma_{q}, \eta_{0}, \ldots, \eta_{q^{\prime}}\right)(\rho)=\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}}\left(p . \mathrm{f}_{i, j}+(p-1)^{2} \mathrm{f}_{i, j} \mathrm{~T}\left(\gamma_{i}, \eta_{j}\right)\right. \\
+(p-1)\left(\frac{\mathrm{T}\left(\gamma_{i+1}, \gamma_{i}, \eta_{j}\right)}{\mathrm{T}\left(\gamma_{i}, \gamma_{i+1}\right)}\left(\mathrm{n}_{i, j}+\mathrm{f}_{i+1, j}\right)+\frac{\mathrm{T}\left(\gamma_{i}, \eta_{j+1}, \eta_{j}\right)}{\mathrm{T}\left(\eta_{j}, \eta_{j+1}\right)}\left(\mathrm{m}_{i, j}+\mathrm{f}_{i, j+1}\right)\right) \\

p^{2} \mathrm{R}_{i, j} \mathrm{~T}\left(\gamma_{i}, \eta_{j}\right)+K\left(\mathrm{gh}_{k}(\rho)+\mathrm{gh}_{0}(\rho)^{N}\right), \tag{74}
\end{gather*}
$$

where

- $K$ is bounded on $U$,
- $\operatorname{gh}(\rho)$ is the girth of $\rho$ as defined in Definition 4.1.2
- the integers $\mathrm{f}_{i, j}, \mathrm{~m}_{i, j}, \mathrm{n}_{i, j}$ and $\mathrm{q}_{i, j}$ are defined in Equations (73).
- $\mathrm{R}_{i, j}$ is an integer that only depends on $\gamma_{i}$ and $\eta_{j}$.

We will use bouquets to express this asymptotics using our product formula for bouquets.
8.2.1. Preliminary asymptotics. Let $\rho$ be a representation of $\Gamma_{0}=$ $\pi_{1}(S)$. For any $k$, let $\rho_{k}:=\left.\rho\right|_{\Gamma_{k}}$. Let $\gamma_{0}, \ldots, \gamma_{q}$ and $\eta_{0}, \ldots, \eta_{q^{\prime}}$ be primitive elements of $\Gamma_{0}$ and $\widehat{\gamma}_{0}, \ldots, \widehat{\gamma}_{q}$ and $\widehat{\eta}_{0}, \ldots, \widehat{\eta}_{q^{\prime}}$ be the corresponding elements in $\Gamma_{k}$, so that

We assume that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are all pairwise coprime. We shall use the notation of Paragraph 7.3.2.
Proposition 8.2.4. Assume that $G$ and $F$ and $\Gamma_{k}$ satisfy the Good Position Hypothesis. Assume also that $\Gamma_{k}$ is $N$-nice for all pairs $\left(\gamma_{i}, \eta_{j}\right)$. Let $C$ be a bouquet in a good position representing $G$ and $F$.

8.3. Asymptotics of brackets of multifractions. The setting of this paragraph is the same as the previous one: we shall be be given a finite index subgroup $\Gamma_{k}$ of $\Gamma_{0}=\pi_{1}(S)$, corresponding to a covering $S_{k} \rightarrow S_{0}=S$. Then, if $\rho$ will be a Hitchin representation of $\pi_{1}(S)$ in $\operatorname{PSL}_{n}(\mathbb{R}), \rho_{k}$ will denote the restriction of $\rho$ to $\Gamma_{k}$.

Let $G=\left(\gamma_{0}, \ldots, \gamma_{q}\right)$ and $F=\left(\eta_{0}, \ldots, \eta_{q^{\prime}}\right)$ be two tuples of primitive elements of $\pi_{1}(S)$. We assume that $\left(\gamma_{i}, \gamma_{i+1}\right)$ as well as $\left(\eta_{j}, \eta_{j+1}\right)$ are all pairwise coprime. Observe that there exists $M \in \mathbb{N}$ so that for all $i$ and $j, \hat{\gamma}:=\gamma_{i}^{M}$ and $\hat{\eta}:=\eta_{j}^{M}$ belong to $\Gamma_{k}$.

\frac{\left\{\mathrm{W}\left(\gamma_{0}^{p} \ldots \gamma_{q}^{p}\right), \mathrm{W}\left(\eta_{0}^{p} \ldots \eta_{q^{\prime}}^{p}\right)\right\}_{S}}{\mathrm{~W}\left(\gamma_{0}^{p} \ldots \gamma_{q}^{p}\right) \mathrm{W}\left(\eta_{0}^{p} \ldots \eta_{q^{\prime}}^{p}\right)}=B_{p}(F, G)-\frac{1}{n} \iota\left(\gamma_{0}^{p} \ldots \gamma_{q}^{p}, \eta_{0}^{p} \ldots \eta_{q^{\prime}}^{p}\right)
$$

The proposition now follows from the fact that

$$
\iota(a . b, c)=\iota(a, c)+\iota(b, c)
$$

and thus

$$
\begin{align*}
& \iota\left(\gamma_{0}^{p} \ldots \gamma_{q}^{p}, \eta_{0}^{p} \ldots \eta_{q^{\prime}}^{p}\right)= \\
& \quad \sum_{0 \leqslant i \leqslant q} \iota\left(\gamma_{i}, \eta_{0}^{p} \ldots \eta_{q^{\prime}}^{p}\right)+\sum_{0 \leqslant j \leqslant q^{\prime}} \iota\left(\gamma_{0}^{p} \ldots \gamma_{q}^{p}, \eta_{j}\right)-\sum_{\substack{0 \leqslant i \leqslant q \\
0 \leqslant j \leqslant q^{\prime}}} \iota\left(\gamma_{i}^{p}, \eta_{j}^{p}\right) . \tag{111}
\end{align*}
$$

9. Goldman and swapping algebras: proofs of the main RESULTS

We finally prove the results stated in Section 6. In the course of the proof, we prove the generalized Wolpert formula in Theorem 9.2.1.
9.1. Poisson brackets of elementary functions and the proof of Theorem 6.2.4. By Corollary 4.2.3, the algebra $\mathcal{B}(P)$ of multi fractions is generated by elementary functions. Thus it is enough to prove the theorem when $b_{0}$ and $b_{1}$ are elementary functions.

Let $G=\left(\gamma_{0}, \ldots, \gamma_{p}\right)$ and $F=\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)$ be primitive elements of $\pi_{1}(S)$. We assume that for all $i$ and $j, \gamma_{i}$ and $\gamma_{i+1}$ are coprime, as well as $\eta_{i}$ and $\eta_{i+1}$.

Let $b_{0}=\mathbf{T}\left(\gamma_{0}, \ldots, \gamma_{q}\right)$ and $b_{1}=\mathbf{T}\left(\eta_{0}, \ldots, \eta_{q}^{\prime}\right)$.
By Proposition 8.1.6, we can assume that $G$ and $F$ satisfy the Good Position Hypothesis for $S_{k}$ when $k>k_{0}$ for some $n_{0}$. Let $N$ be a positive integer, we can further assume that $S_{k} \mapsto S_{0}$ is $N$-nice for all pairs $\left(\gamma_{i}, \eta_{j}\right)$ by Proposition 8.1.5 for $k \geqslant k_{0}$ and $k_{0}$ large enough.

Recall also, using the notation of Proposition 4.3.1, that

$$
\begin{align*}
& \mathrm{f}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right] \quad=\mathrm{a}_{i, j} \\
& \mathrm{q}_{i, j}+\mathrm{n}_{i, j+1}+\mathrm{m}_{i+1, j}+\mathrm{f}_{i+1, j+1}=\left[\gamma_{i}^{-} \gamma_{i+1}^{+}, \eta_{j}^{-} \eta_{j+1}^{+}\right]=\mathrm{b}_{i, j}, \\
& \mathrm{f}_{i, j+1}+\mathrm{m}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i}^{+}, \eta_{j}^{-} \eta_{j+1}^{+}\right]=\mathrm{c}_{i, j} \\
& \mathrm{f}_{i+1, j}+\mathrm{n}_{i, j}=\left[\gamma_{i}^{-} \gamma_{i+1}^{+}, \eta_{j}^{-} \eta_{j}^{+}\right]=\mathrm{d}_{i, j} . \tag{112}
\end{align*}
$$

Thus Corollary 8.3.2 and the computation of the swapping bracket in Proposition 4.3.1 yield

$$
\begin{align*}
& \frac{\left\{\mathbf{T}\left(\gamma_{0}, \ldots \gamma_{q}\right), \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)\right\}_{S_{k}}}{\mathrm{~T}\left(\gamma_{0}, \ldots \gamma_{q}\right) \cdot \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)} \\
& \quad=\frac{\left\{\mathrm{T}\left(\gamma_{0}, \ldots \gamma_{q}\right), \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)\right\}_{W}}{\mathrm{~T}\left(\gamma_{0}, \ldots \gamma_{q}\right) \cdot \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)}+K \cdot\left(\operatorname{gh}_{k}(\rho)+\operatorname{gh}(\rho)^{N}\right) \tag{113}
\end{align*}
$$

where $K$ is a bounded function that only depends on the eigenvectors of $\rho\left(\gamma_{i}\right)$ and $\rho\left(\eta_{j}\right)$. In particular, there exists a real number $K_{0}$ and a compact neighborhood $C$ of $\rho_{0}$ so that the previous equality holds with $K \leqslant K_{0}$ and $\rho$ in $C$.

Let $\varepsilon$ be a positive real number. By the last assertion in Proposition 8.1.3, we may furthermore choose $k_{0}$ so that if $k>k_{0}$,

$$
\operatorname{gh}_{k}(\rho) \leqslant \frac{\varepsilon}{2 K_{0}} .
$$

Since $\sup \{\operatorname{gh}(\rho) \mid \rho \in C\}<1$, we may further choose $N$ - and thus $k_{0}$ - so that for all $\rho$ in $C$,

\operatorname{gh}(\rho)^{N} \leqslant \frac{\varepsilon}{2 K_{0}}
$$

It follows that for all $\rho$ in $C$, for all $k \geqslant k_{0}$, we have

\begin{equation*}
\left|\frac{\left\{\mathrm{T}\left(\gamma_{0}, \ldots \gamma_{q}\right), \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)\right\}_{S_{k}}}{\mathrm{~T}\left(\gamma_{0}, \ldots \gamma_{q}\right) \cdot \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)}-\frac{\left\{\mathrm{T}\left(\gamma_{0}, \ldots \gamma_{q}\right), \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)\right\}_{W}}{\mathrm{~T}\left(\gamma_{0}, \ldots \gamma_{q}\right) \cdot \mathrm{T}\left(\eta_{0}, \ldots \eta_{q^{\prime}}\right)}\right| \leqslant \varepsilon \tag{114}
\end{equation*}
$$

This concludes the proof of Theorem 6.2.4.
9.2. Poisson brackets of length functions. We shall first prove a result of independent interest, namely the value of the Goldman bracket of two length functions of geodesics having exactly one intersection point.

Given a Hitchin representation $\rho$ in $\mathrm{PSL}_{n}(\mathbb{R})$, or alternatively a rank$n$ cross ratio $\mathbf{b}_{\rho}$, the period - or length - of a conjugacy class $\gamma$ in $\pi_{1}(S)$, is given by

$$
\begin{equation*}
\ell_{\gamma}=\log \left(\frac{\lambda_{\max }(\rho(\gamma))}{\lambda_{\min }(\rho(\gamma))}\right)=\log \left(\mathbf{b}_{\rho}\left(\gamma^{-}, \gamma^{+}, y, \gamma(y)\right)\right) \tag{115}
\end{equation*}
$$

for any $y \in \partial_{\infty} \pi_{1}(S)$ different from $\gamma^{+}$and $\gamma^{-}$and where $\lambda_{\max }(A)$ and $\lambda_{\min }(A)$ denotes respectively the eigenvalue with the greatest and smallest modulus of the endomorphism $A$.
9.2.1. A generalised Wolpert Formula. We have the following extension of Wolpert Formula:

Theorem 9.2.1. [Generalised Wolpert Formula] Let $\gamma$ and $\eta$ two closed geodesic with a unique intersection point then the Goldman bracket of the two length functions $\ell_{\gamma}$ and $\ell_{\eta}$ seen as functions on the Hitchin component is

$$
\begin{equation*}
\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}=\iota(\gamma, \eta) \sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon \cdot \varepsilon^{\prime} \cdot \mathrm{T}\left(\gamma^{\varepsilon} \cdot \eta^{\varepsilon^{\prime}}\right), \tag{116}
\end{equation*}
$$

where we recall that

$$
\mathrm{T}(\xi, \zeta)(\rho)=\mathbf{b}_{\rho}\left(\xi^{+}, \zeta^{+}, \zeta^{-}, \xi^{-}\right)
$$

Proof. Let us first remark that

$$
\begin{equation*}
\ell_{\gamma}=\lim _{n \rightarrow+\infty} \frac{1}{p} \log \left(\operatorname{tr}\left(\rho\left(\gamma^{p}\right)\right) \operatorname{tr}\left(\rho\left(\gamma^{-p}\right)\right)\right) . \tag{117}
\end{equation*}
$$

Thus assuming that $\gamma$ and $\eta$ have a unique intersection point $x$, whose intersection number is $\iota(\gamma, \eta)$, the Product Formula (54) gives us if $\varepsilon_{i} \in\{-1,1\}$,

$$
\begin{equation*}
\left\{\gamma^{\varepsilon \cdot p}, \eta^{\varepsilon^{\prime} \cdot p}\right\}=\varepsilon \cdot \varepsilon^{\prime} \cdot p^{2} \cdot \iota(\gamma, \eta) \gamma^{\varepsilon \cdot p} \cdot \eta^{\varepsilon^{\prime} \cdot p} . \tag{118}
\end{equation*}
$$

It follows that

$$
\begin{aligned}
& \left\{\log \left(\mathrm{W}\left(\gamma^{p}\right) \mathrm{W}\left(\gamma^{-p}\right)\right), \log \left(\mathrm{W}\left(\eta^{p}\right) \mathrm{W}\left(\eta^{-p}\right)\right)\right\}_{S} \\
& =\sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon \cdot \varepsilon^{\prime} \cdot \iota(\gamma, \eta) \frac{\left\{\mathrm{W}\left(\gamma^{\varepsilon \cdot p}\right), \mathrm{W}\left(\eta^{\varepsilon^{\prime} \cdot p}\right)\right\}_{S}}{\mathrm{~W}\left(\gamma^{\varepsilon \cdot p}\right) \cdot \mathrm{W}\left(\eta^{\varepsilon^{\prime} \cdot p}\right)} \\
& =\sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} p^{2} \cdot \varepsilon \cdot \varepsilon^{\prime} \cdot \iota(\gamma, \eta) \frac{\mathrm{W}\left(\gamma^{\varepsilon \cdot p} \cdot \eta^{\varepsilon^{\prime} \cdot p}\right)}{\mathrm{W}\left(\gamma^{\varepsilon \cdot p}\right) \cdot \mathrm{W}\left(\eta^{\varepsilon^{\prime} \cdot p}\right)}+\frac{1}{n} \iota(\gamma, \eta) \sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon\left(\mathrm{z}^{\prime} 19\right)
\end{aligned}
$$

Thus

$$
\begin{align*}
& \lim _{p \rightarrow \infty}\left(\left\{\frac{1}{p} \log \left(\mathrm{~W}\left(\gamma^{p}\right) \mathrm{W}\left(\gamma^{-p}\right)\right), \frac{1}{p} \log \left(\mathrm{~W}\left(\eta^{p}\right) \mathrm{W}\left(\eta^{-p}\right)\right)\right\}_{S}\right) \\
& =\sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon \cdot \varepsilon^{\prime} \cdot \iota(\gamma, \eta) \lim _{p \rightarrow \infty}\left(\frac{\mathrm{~W}\left(\gamma^{\varepsilon \cdot p} \cdot \eta^{\varepsilon^{\prime} \cdot p}\right)}{\mathrm{W}\left(\gamma^{\varepsilon \cdot p}\right) \cdot \mathrm{W}\left(\eta^{\varepsilon^{\prime} \cdot p}\right)}\right) \\
& =\sum_{\varepsilon, \varepsilon^{\prime} \in\{-1,1\}} \varepsilon \cdot \varepsilon^{\prime} \cdot \iota(\gamma, \eta) \mathrm{T}\left(\gamma^{\varepsilon} \cdot \eta^{\varepsilon^{\prime}}\right) . \tag{120}
\end{align*}
$$

This concludes the proof of the theorem.
9.2.2. Proof of Theorem 6.1.1. Recall that we want to prove the following result.

Theorem 9.2.2. Let $\gamma$ and $\eta$ be two geodesics with at most one intersection point, then we have

$$
\lim _{n \rightarrow \infty} \mathrm{I}_{S}\left(\left\{\hat{\ell}_{\gamma^{n}}(y), \hat{\ell}_{\eta^{n}}(y)\right\}\right)=\left\{\ell_{\gamma}, \ell_{\eta}\right\}_{S}
$$

Proof. This will be a consequence of the generalized Wolpert Formula. By definition,

$$
\hat{\ell}_{\gamma}(y)=\log \left(\mathbf{b}\left(\gamma^{+}, \gamma^{-}, \gamma^{-1}(y), \gamma(y)\right)\right) .
$$

Thus

$$
\begin{equation*}
\left\{\hat{\ell}_{\alpha}(y), \hat{\ell}_{\beta}(y)\right\}=\sum_{\substack{u, u^{\prime} \in\{-1,1\} \\ v, v^{\prime} \in\{-1,1\}}} u \cdot u^{\prime} \frac{\left\{\alpha^{v} \alpha^{-u v}(y), \beta^{v^{\prime}} \beta^{-u^{\prime} v^{\prime}}(y)\right\}}{\left(\alpha^{v} \alpha^{-u v}(y)\right) \cdot\left(\beta^{v^{\prime}} \beta^{-u^{\prime} v^{\prime}}(y)\right)} . \tag{121}
\end{equation*}
$$

But,

$$
\begin{align*}
& \left\{\alpha^{v} \alpha^{-u v \cdot} \cdot(y), \beta^{v^{\prime}} \beta^{-u^{\prime} v^{\prime} \cdot} \cdot(y)\right\} \\
& \quad=\left[\left(\alpha^{v} \alpha^{-u v \cdot} \cdot(y)\right),\left(\beta^{v^{\prime}} \beta^{-u^{\prime} v^{\prime} \cdot} \cdot(y)\right)\right] \alpha^{v} \beta^{-u^{\prime} v^{\prime}} \cdot(y) \cdot \beta^{v^{\prime}} \alpha^{-u v \cdot} \cdot(y) . \tag{122}
\end{align*}
$$

We remark that for $n$ large enough, for all $u, v, u^{\prime}, v^{\prime}$, we have

\begin{align*}
{\left[\left(\gamma^{v} \gamma^{v . n}(y)\right),\left(\eta^{v^{\prime}} \eta^{-u^{\prime} v^{\prime} . n}(y)\right)\right] } & =0 \\
{\left[\left(\gamma^{v} \gamma^{-u v . n}(y)\right),\left(\eta^{v^{\prime}} \eta^{v^{\prime} . n}(y)\right)\right] } & =0 \\
{\left[\left(\gamma^{v} \gamma^{-v . n}(y)\right),\left(\beta^{v^{\prime}} \eta^{-v . n}(y)\right)\right] } & =v v^{\prime}\left[\gamma^{+} \gamma^{-}, \eta^{+} \eta^{-}\right] . \tag{123}
\end{align*}
$$

Combining the remark in Equation (123), with (122) and (121), we have that for $n$ large enough,

$$
\begin{equation*}
\left\{\hat{\ell}_{\gamma^{n}}(y), \hat{\ell}_{\eta}\left(y^{n}\right)\right\}=\left[\gamma^{+} \gamma^{-}, \eta^{+} \eta^{-}\right] \sum_{v, v^{\prime} \in\{-1,1\}} v \cdot v^{\prime} \frac{\gamma^{v} \eta^{-v^{\prime} \cdot n}(y) \cdot \eta^{v^{\prime}} \gamma^{-v}(y)}{\left(\gamma^{v} \gamma^{-v \cdot n}(y)\right) \cdot\left(\eta^{v^{\prime}} \eta^{-v^{\prime} n}(y)\right)} \tag{124}
\end{equation*}
$$

Thus, taking the limit when $n$ goes to $\infty$ yields

$$
\begin{align*}
\lim _{n \rightarrow \infty}\left(I_{S}\left\{\hat{\ell}_{\gamma^{n}}(y), \hat{\ell}_{\eta}\left(y^{n}\right)\right\}\right) & =\left[\gamma^{+} \gamma^{-}, \eta^{+} \eta^{-}\right] \sum_{v, v^{\prime} \in\{-1,1\}} v \cdot v^{\prime} \frac{\gamma^{v} \eta^{-v^{\prime}} \cdot \eta^{v^{\prime}} \gamma^{-v}}{\gamma^{v} \gamma^{-v} \cdot \eta^{v^{\prime}} \eta^{-v^{\prime}}} \\
& =\left[\gamma^{+} \gamma^{-}, \eta^{+} \eta^{-}\right] \sum_{v, v^{\prime} \in\{-1,1\}} v \cdot v^{\prime} \cdot \mathbf{T}\left(\gamma^{v}, \eta^{v^{\prime}}\right) \tag{125}
\end{align*}
$$

The result now follows from this last equation and the generalised Wolpert formula (116).

## 10. Drinfel'd-Sokolov reduction

The purpose of this section is to prove Theorem 10.7.2 which explain the relation of the multi fraction algebra with the Poisson structure on $\mathrm{PSL}_{n}(\mathbb{R})$-opers.

We spend the first three paragraphs explaining the Poisson structure on $\mathrm{PSL}_{n}(\mathbb{R})$-opers using the Drinfel'd-Skolov reduction of the Poisson structure on connections on the circle. Although this is a classical construction (see [3], [23] and [10] and the original reference [4]), we take some time explaining the main steps in differential geometric terms, expanding the sketch of the construction given by Graeme Segal in [22].

Finally, we relate the swapping algebra and this Poisson structure in Theorem 10.7.2.
10.1. Opers and non slipping connections. In this paragraph, we recall the definition $\mathrm{PSL}_{n}(\mathbb{R})$-opers and show that they can be interpreted as class of equivalence of "non slipping" connections on a bundle with a flag structure.
10.1.1. Opers.

Definition 10.1.1. [OPERS] $A \mathrm{PSL}_{n}(\mathbb{R})$-oper is a $n^{\text {th }}$-order linear differential operator on the circle $\mathbb{T}=\mathbb{R} / \mathbb{Z}$ of the form

$$
\begin{equation*}
D: \psi \mapsto \frac{\mathrm{d}^{n} \psi}{\mathrm{~d} t^{n}}+q_{2} \frac{\mathrm{~d}^{n-2} \psi}{\mathrm{~d} t^{n-2}}+\ldots+q_{n} \psi \tag{126}
\end{equation*}
$$

where $q_{i}$ are functions.
Observe that this definition of an oper requires the choice of a parametrisation of the circle. Otherwise the $q_{i}$ would rather be $i$-order differentials.

We denote by $\mathrm{X}_{n}(\mathbb{T})$ the space of $\mathrm{PSL}_{n}(\mathbb{R})$-opers on $\mathbb{T}$. Every oper has a natural holonomy which reflect the fact that the solutions may not be periodic. We consider the space $\mathrm{X}_{n}(\mathbb{T})^{0}$ of opers with trivial holonomy, that is those opers $D$ for which all solutions of $D \psi=0$ are periodic. A Poisson structure on $X_{n}(\mathbb{T})$, whose symplectic leaves are opers with the same holonomy, was discovered in the context of integrable systems and Korteweg-de Vries equations - for a precise account of the history, see Dickey [3]. Later, Drinfeld-Solokolov interpreted that structure in a more differential geometric way in [4] and we shall now retrace the steps of that construction.
10.1.2. Non slipping connections. Let $K$ be the line bundle of $(-1 / 2)$ densities over $\mathbb{T}$ and $P:=J^{n-1}\left(K^{n-1}\right)$ be the rank $n$ vector bundle of $(n-1)$ jets of sections of the bundles of $(-(n-1) / 2)$-densities.

Let $F_{p}$ be the vector subbundle of $P$ defined by

$$
F_{p}:=\left\{j^{n-1} \sigma \mid j^{n-p-1} \sigma=0\right\} .
$$

The family $\left\{F_{p}\right\}_{1 \leqslant p \leqslant n}$ is a filtration of $P$ : we have $F_{n}=P, F_{p-1} \subset F_{p}$ and $\operatorname{dim}\left(F_{p}\right)=p$.

The vector bundle also carries a natural volume form $P$, since $\operatorname{det}(P)$ is isomorphic to $\mathbb{R}$. Finally, $F_{p} / F_{p-1}=K^{2 p}$.

We say a family of sections $\left\{e_{1}, \ldots, e_{n}\right\}$ of $P$ is a basis for the filtration if for every interger $p$ no greater than $n$, for every $x \in S^{1}$, $\left\{e_{1}(x), \ldots, e_{p}(x)\right\}$ is a basis of the fiber of $F_{p}$ at $x$.
Definition 10.1.2. [NON-SLIPPING CONNECTIONS] A connection $\nabla$ on $P$ is non slipping if it satisfies the following conditions

- $\nabla F_{p} \subset F_{p+1}$ for all $p$,
- If $\alpha_{p}$ is the projection from $F_{p+1}$ to $F_{p+1} / F_{p}$, then the map

$$
(X, u) \rightarrow \alpha_{p}\left(\nabla_{X}(u)\right)
$$

considered as a linear map from $K^{2} \otimes F_{p} / F_{p-1}=K^{2(p+1)}$ to $F_{p+1} / F_{p-1}=K^{2(p+1)}$ is the identity.

We denote by $\mathrm{D}_{0}$ the space of non-slipping connections on $P$. The first classical proposition is that

Proposition 10.1.3. Let $\nabla$ be a non slipping connection, then there exists a unique basis $\left\{e_{1}, \ldots, e_{n}\right\}$ of determinant 1 for the filtration so that

$$
\begin{align*}
\nabla_{\partial_{t}} e_{i} & =-e_{i+1}, \text { for } i \leqslant n-1, \\
\nabla_{\partial_{t}} e_{n} & \in F_{n-1}, \tag{127}
\end{align*}
$$

where $\partial_{t}$ is the canonical vector field on $\mathbb{T}$.
Observe here that the basis depends on the choice of a parametrisation of the circle. From this proposition, it follows that we can associate to a non slipping connection $\nabla$ the differential operator $D=D^{\nabla}$ so that

$$
\nabla_{\partial_{t}}^{*}\left(\sum_{i=1}^{i=n} \frac{\mathrm{~d}^{i-1} \psi}{\mathrm{~d} t^{i-1}} \omega_{i}\right)=(D \psi) \omega_{n}
$$

where $\nabla^{*}$ is the dual connection and $\left\{e_{i}\right\}_{1 \leqslant i \leqslant n}$ is the dual basis to the basis $\left\{e_{i}\right\}_{1 \leqslant i \leqslant n}$ associated to $\nabla$ in the previous proposition. One easily check that

$$
D \psi=\frac{\mathrm{d}^{n} \psi}{\mathrm{~d} t^{n}}+q_{2} \frac{\mathrm{~d}^{n-2} \psi}{\mathrm{~d} t^{n-2}}+\ldots+q_{n} \psi
$$

where the functions $q_{i}$ are given by $q_{i}=\omega_{n-j+1}\left(\nabla_{\partial_{t}} e_{n}\right)$.
We define
(1) the flag gauge group as the group N of linear automorphism of the bundle $P$ defined by

$$
\mathrm{N}:=\left\{A \in \Omega^{0}(\mathbb{T}, \operatorname{End}(P)),\left|A\left(F_{p}\right)=F_{p}, A\right|_{F_{p} / F_{p-1}}=\operatorname{Id}\right\}
$$

(2) the Lie algebra $\mathfrak{n}$ of the flag gauge group as

$$
\mathfrak{n}:=\left\{A \in \Omega^{0}(\mathbb{T}, \operatorname{End}(P)) \mid A\left(F_{p}\right) \subset F_{p-1}\right\} .
$$

We now have
Proposition 10.1.4. The map $\nabla \mapsto D^{\nabla}$ realise an identification between $\mathrm{D}_{0} / \mathrm{N}$ and $\mathrm{X}_{n}(\mathbb{T})$ and this identification preserves the holonomy.

It is interesting now to observe that the definition of an oper as an element of $\mathrm{D}_{0} / \mathrm{N}$ does not depend of a parametrisation.

Proof. Let $\nabla$ be a non slipping connection $\left\{e_{i}\right\}$ the basis obtained by the previous proposition and $\nabla^{\prime}=n . \nabla$ be a connection in the N -orbit of $\nabla$. By definition of $\mathrm{N}, \nabla^{\prime} e_{i}=\nabla e_{i}+u_{i}$, with $u_{i} \in F_{i-1}$. The result follows
10.2. The Poisson structure on the space of connections. The purpose of Drinfel'd-Sokolov reduction is to identify the space of opers $\mathrm{X}_{n}(\mathbb{T})=\mathrm{D}_{0} / \mathrm{N}$ as a symplectic quotient of the space of all connexions on $\mathbb{T}$ by the group N .

Again, we shall paraphrase Segal, and define in this paragraph, as a first step of the construction of Drinfel'd-Sokolov reduction, the classical construction of the Poisson structure on the space of connections.

In general, when we deal with a Fréchet space of sections of a bundle, we have to specify functionals that we deemed observables and for which we can compute a Poisson bracket. This is done by specifying a subspace of cotangent vectors and describing the Poisson tensor on that subspace. Observables are then functionals whose differentials belong to that specific subset. However, the Poisson bracket can be extended to more general pair of observables. Rather than describing a general formalism - for which we could refer to [3] - we explain the construction in the case of connections.
10.2.1. Connexions and central extensions. Let $G$ be the Gauge group of the vector bundle $P$. The choice of a trivialisation of $P$ give rise an isomorphism of G with the loop group of $\mathrm{PSL}_{n}(\mathbb{R})$. Then, we introduce the following definitions
(1) the Lie algebra $\mathfrak{g}$ of G is $\Omega^{0}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)$ where $\operatorname{End}_{0}(P)$ stands for the vector space of trace free endormorphisms of $P$, this Lie algebra is equipped naturally with a coadjoint action of G,
(2) the dual Lie agebra $\mathfrak{g}^{\circ}$ of G is $\Omega^{1}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)$,
(3) the duality is given by the non degenerate bilinear mapping from $\mathfrak{g} \times \mathfrak{g}^{\circ}$ defined by

$$
\begin{equation*}
\langle\alpha, \beta\rangle=\int_{\mathbb{T}} \operatorname{tr}(\alpha . \beta) . \tag{128}
\end{equation*}
$$

Let us choose a connection $\nabla$ on $P$. Let $\Omega_{\nabla}$ be the 2-cocycle on $\mathfrak{g}$ given by the following formula

$$
\Omega_{\nabla}(\xi, \eta)=\int_{\mathbb{T}} \operatorname{tr}(\xi \nabla \eta)
$$

If $\nabla$ and $\nabla^{\prime}$ are two connections on $P$, then

$$
\Omega_{\nabla}(\xi, \eta)-\Omega_{\nabla^{\prime}}(\xi, \eta)=\alpha([\xi, \eta]),
$$

where

$$
\alpha(\chi)=\int_{\mathbb{T}} \operatorname{tr}\left(\left(\nabla-\nabla^{\prime}\right) \cdot \chi\right) .
$$

In particular the cohomology class of the cocycle $\Omega_{\nabla}$ does not depend on the choice of $\nabla$. Let $\widehat{\mathrm{G}}$ - whose Lie algebra is $\widehat{\mathfrak{g}}$ - be the central extension of $G$ corresponding of to this cocycle, so that

$$
0 \rightarrow \mathbb{R} \rightarrow \widehat{\mathfrak{g}} \xrightarrow{\frac{\pi}{\rightarrow}} \mathfrak{g}
$$

As we noticed, every connection defines a splitting of this sequence, that is a way to write $\widehat{\mathfrak{g}}$ as $\mathbb{R} \oplus \mathfrak{g}$.

Dually, we consider the vector space $\widehat{\mathfrak{g}}^{\circ}$ defined by the exact sequence

$$
0 \xrightarrow{i} \mathfrak{g}^{\circ} \rightarrow \widehat{\mathfrak{g}}^{\circ} \rightarrow \mathbb{R}
$$

with the duality with $\widehat{\mathfrak{g}}$ so that $\langle\gamma, i(\beta)\rangle=\langle\pi(\gamma), \beta\rangle$
It follows that the space of $\mathcal{D}$ all $\mathrm{PSL}_{n}(\mathbb{R})$ connexions on $P$ can be embedded in the space of these splittings which is identified with the affine hyperplane $D$ in $\widehat{\mathfrak{g}}^{\circ}$ defined by

$$
\mathrm{D}:=\left\{\beta \in \widehat{\mathfrak{g}}^{\circ} \mid\langle Z, \beta\rangle=1\right\},
$$

where $Z \in \widehat{\mathfrak{g}}$ the generator of the center. The hyperplane D has $\mathfrak{g}^{\circ}$ as a tangent space. Observe that the embedding $\mathcal{D} \rightarrow \mathrm{D}$ is equivariant under the affine action of $\Omega^{1}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)=\mathfrak{g}^{\circ} \subset \widehat{\mathfrak{g}}^{\circ}$ as well as the coadjoint action of G itself. In particular, the above embeding is surjective and we now identify D as the space of all $\mathrm{PSL}_{n}(\mathbb{R})$-connections on $P$. The coadjoint orbits of G on D are those connexions with the same holonomy.
10.2.2. The Poisson structure. Since we are working in infinite dimension, we are only going to define the Poisson tensor on certain "cotangent vectors" to $D$. In our context we consider the set $D^{\circ}:=\mathfrak{g}=$ $\Omega^{0}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)$ of cotangent vectors where the duality is given by Formula (128). Using these notation, the Poisson structure is described in the following way

## Definition 10.2.1. [Poisson structure for connections]

- The Hamiltonian mapping from $\mathrm{D}^{\circ}$ to D at a connection $\nabla$ is

$$
H: \alpha \mapsto \mathrm{d}^{\nabla} \alpha
$$

- The Poisson tensor on $\mathrm{D}^{\circ}$ at a connection $\nabla$ is

$$
\Pi_{\nabla}(\alpha, \beta):=\langle\alpha, H(\beta)\rangle=\int_{\mathbb{T}} \operatorname{tr}\left(\alpha \cdot \mathrm{d}^{\nabla} \beta\right) .
$$

- We say a functional $F$ is an observable if its differential $\mathrm{d}_{\nabla} F$ belongs to $\mathrm{D}^{\circ}$ for all $\nabla$. The Poisson bracket of two observables is

$$
\{f, g\}:=\Pi(\mathrm{d} f, \mathrm{~d} g)=\langle\mathrm{d} f, H(\mathrm{~d} g)\rangle .
$$

## Remarks:

(1) The Poisson bracket can be defined for more general pair of functionals than observables. Observe first that the differential of functionals on a Frechet space of sections of bundles - for instance connections - are distributions. Thus we can define the Poisson bracket of a general differentiable functional with an observable. For the purpose of this paper, we shall say that two functionals $f$ and $g$ form an acceptable pair of observables if their derivatives $\mathrm{d} f$ and $\mathrm{d} g$ are distributions with disjoint singular support, or equivalently if they can be written as

$$
\begin{aligned}
\mathrm{d} f & =F+f_{0} \\
\mathrm{~d} g & =G+g_{0},
\end{aligned}
$$

where $F$ and $G$ have disjoint support and $f_{0}, g_{0}$ are observables in the previous meaning. In this case, their Poisson bracket is defined as

$$
\{f, g\}(\nabla)=\Pi\left(f_{0}, g_{0}\right)+\left\langle F, H\left(g_{0}\right)\right\rangle-\left\langle G, H\left(f_{0}\right)\right\rangle
$$

This Poisson bracket agrees with regularising procedures.
(2) We further observe that if $D_{\nabla}$ is the space of connections with the same holonomy as $\nabla$ - that is the codajoint orbit of $\nabla-$ then the tangent space of $D_{\nabla}$ at $\nabla$ is the vector space of exact 1 -forms $\mathrm{d}^{\nabla}\left(\Omega^{0}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)\right)$, and moreover the Poisson tensor on $\mathrm{D}_{\nabla}$ is dual to the symplectic form $\omega$ defined by

$$
\omega\left(\mathrm{d}^{\nabla} \alpha, \mathrm{d}^{\nabla} \beta\right):=\int_{\mathbb{T}} \operatorname{tr}\left(\alpha \cdot \mathrm{d}^{\nabla} \beta\right) .
$$

Thus the symplectic leaves of this Poisson structure are connections with the same holonomy. One can furthermore check that this formalism agrees with what we expect from coadjoint orbits.
10.3. Drinfel'd-Sokolov reduction. We now describe the Drinfel'dSokolov reduction. In the first paragraph we describe more precisely the group that we are going to work with in order to perform the reduction.
10.3.1. Dual Lie algebras. Let $\mathfrak{n}$ be the Lie algebra of N as defined above. Let $\mathfrak{u}$ be the subspace of $\mathfrak{g}^{\circ}$ given by

$$
\mathfrak{u}:=\left\{A \in \Omega^{1}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right) \mid A\left(F_{p}\right) \subset F_{p}\right\} .
$$

We observe

Proposition 10.3.1. We have

$$
\mathfrak{u}=\left\{A \in \widehat{\mathfrak{g}}^{\circ} \mid\langle\alpha, A\rangle=0, \quad \forall \alpha \in \mathfrak{n}\right\}
$$

Thus if

$$
\mathfrak{n}^{\circ}:=\Omega^{1}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right) / \mathfrak{u}
$$

we have a duality $\mathfrak{n}^{\circ} \times \mathfrak{n} \rightarrow \mathbb{R}$ given by the map

$$
\langle\alpha, \beta\rangle:=\int_{\mathbb{T}} \operatorname{tr}(\alpha \beta) .
$$

We now give another description of $\mathfrak{n}^{\circ}$ more suitable for our purpose. Let us first consider the natural projections

$$
\begin{array}{ll}
\pi_{p}^{+}: \operatorname{Hom}\left(F_{p}, E / F_{p}\right) & \rightarrow \operatorname{Hom}\left(F_{p}, E / F_{p+1}\right) \\
\pi_{p}^{-}: \operatorname{Hom}\left(F_{p}, E / F_{p}\right) & \rightarrow \operatorname{Hom}\left(F_{p-1}, E / F_{p}\right) \tag{129}
\end{array}
$$

Let
$M:=\left\{\left(u_{1}, \ldots, u_{n-1}\right) \in \bigoplus_{p=1}^{p=n-1} \operatorname{Hom}\left(F_{p}, E / F_{p}\right) \mid \pi_{p}^{+}\left(u_{p}\right)=\pi_{p+1}^{-}\left(u_{p+1}\right)\right\}$.
We leave the reader check the following
Proposition 10.3.2. The map defined from $\mathfrak{n}^{\circ}$ to $\Omega^{1}(\mathbb{T}, M)$ by

$$
A \rightarrow\left(\left.A\right|_{F_{1}}, \ldots,\left.A\right|_{F_{n-1}}\right)
$$

is an isomorphism.
10.3.2. Drinfel'd-Sokolov reduction. If $\nabla$ is a connection, we define the slippage - denoted $\sigma(\nabla)$ - of $\nabla$ as the element of $\Omega^{1}(\mathbb{T}, M)=\mathfrak{n}^{\circ}$ given by

$$
\left(u_{1}, \ldots, u_{p}\right),
$$

where $u_{p}(X, v)=\alpha_{p}\left(\nabla_{X} v\right)$ and $\alpha_{p}$ is the projection from $E$ to $E / F_{p}$.
We are now going to define a canonical section of $\Omega^{1}(\mathbb{T}, M)$. We have a natural embedding

$$
i_{p}: \operatorname{Hom}\left(F_{p} / F_{p-1}, F_{p+1} / F_{p}\right) \rightarrow \operatorname{Hom}\left(F_{p}, F / F_{p}\right)
$$

Now oberve that

$$
\Omega^{1}\left(\mathbb{T}, \operatorname{Hom}\left(F_{p} / F_{p-1}, F_{p+1} / F_{p}\right)\right)=\left(K^{2}\right)^{*} \otimes\left(K^{2 p}\right)^{*} \otimes K^{2(p+1)}
$$

Thus, let

$$
\mathbf{I}_{p}:=i_{p}(\mathrm{Id}) \in\left(K^{2}\right)^{*} \otimes\left(K^{2 p}\right)^{*} \otimes K^{2(p+1)} .
$$

Finally, we set

$$
\mathbf{I}:=\left(\mathbf{I}_{1}, \ldots, \mathbf{I}_{n-1}\right)
$$

and we observe that $\mathbf{I}$ is invariant under the coadjoint action of $\mathbf{N}$.

Theorem 10.3.3. [Drinfel'd-Sokolov reduction] The map $\sigma$ is a moment map for the action of N . Moreover $\mathrm{D}_{0}=\mu^{-1}(\mathbf{I})$ and we thus obtain a Poisson structure on $\mathrm{X}_{n}(\mathbb{T})$.

As a particular case of symplectic reduction, we briefly explain the construction of the Poisson bracket in our context of opers and non slipping connections. If $f$ and $g$ are two functionals on the space of opers, they are observables if their pull back $F$ and $G$ on the space of non slipping connections are observables and then their Poisson bracket is $\{f, g\}(D):=\{F, G\}(\nabla)$ where $D$ is the oper associated with $\nabla$.

### 10.4. Opers and Frenet curves.

10.4.1. Curves associated to $\mathrm{PSL}_{n}(\mathbb{R})$-opers. We recall that every oper $D$ give rise to a curve from $\mathbb{R}$ to $\mathbb{P}\left(\mathbb{R}^{n}\right)$ equivariant under the holonomy that is a curve

$$
\xi: \mathbb{R} \rightarrow \mathbb{P}\left(\mathbb{R}^{n}\right),
$$

such that $\xi(t+1)=H(\xi(t))$ where $H$ is the holonomy. The construction runs as follows: the curve $\xi$ is given in projective coordinates by

$$
\xi:=\left[v_{1}, \ldots, v_{n}\right],
$$

where $\left\{v_{1}, \ldots, v_{n}\right\}$ are $n$-independent solutions of the equation $D \psi=0$. The curve $\xi$ is well defined up to the action of $\mathrm{PSL}_{n}(\mathbb{R})$. We call $\xi$ the curve associated to the oper.
10.4.2. Hitchin opers. Let us say an oper is Hitchin if it has trivial holonomy and can be deformed through opers with trivial holonomy to the trivial oper $\psi \mapsto \frac{\mathrm{d}^{n} \psi}{\mathrm{~d} t^{n}}$. Let us denote by $\mathrm{X}_{n}^{0}(\mathbb{T})$ the space of Hitchin opers which by the previous section inherits a Poisson structure.
10.4.3. Frenet curves. We say a curve $\xi$ from $\mathbb{T}$ to $\mathbb{P}\left(\mathbb{R}^{n}\right)$ is Frenet if there exists a curve $\left(\xi^{1}, \xi^{2}, \ldots, \xi^{n-1}\right)$ defined on $\mathbb{T}$, called the osculating flag curve, with values in the flag variety such that for every $x$ in $\mathbb{T}$, $\xi(x)=\xi^{1}(x)$, and moreover

- For every pairwise distinct points $\left(x_{1}, \ldots, x_{l}\right)$ in $\mathbb{T}$ and positive integers $\left(n_{1}, \ldots, n_{l}\right)$ such that

$$
\sum_{i=1}^{i=l} n_{i} \leqslant n
$$

then the sum

$$
\xi^{n_{i}}\left(x_{i}\right)+\ldots+\xi^{n_{l}}\left(x_{l}\right)
$$

is direct.

- For every $x$ in $\mathbb{T}$ and positive integers $\left(n_{1}, \ldots, n_{l}\right)$ such that

$$
p=\sum_{i=1}^{i=l} n_{i} \leqslant n
$$

then

$$
\lim _{\substack{\left(y_{1}, \ldots, y_{l}\right) \rightarrow x, y_{i} \text { all distinct }}}\left(\bigoplus_{i=1}^{i=l} \xi^{n_{i}}\left(y_{i}\right)\right)=\xi^{p}(x) .
$$

We call $\xi^{*}:=\xi^{n-1}$ the osculating hyperplane.
Since the trivial connection is non slipping with respect to the filtration given by osculating flags, we have the following obvious remark see also [5] Section 9.12.

Proposition 10.4.1. Every smooth Frenet curve comes from a $\mathrm{PSL}_{n}(\mathbb{R})$ oper with trivial holonomy.

Conversely, we now prove
Proposition 10.4.2. The curve associated to a Hitchin oper is Frenet.
Proof. Let us first introduce some notation and definitions. A weighted $p$-tuple $X$ is a pair consisting of a $p$-tuple of pairwise distinct points $\left(x_{1}, \ldots, x_{p}\right)$ in $\mathbb{T}$ - called the support - and a $p$-tuple of positive integers $\left(j_{1}, \ldots, j_{p}\right)$ so that $\sum_{1 \leqslant k \leqslant p} j_{k}=n$. If $\eta$ is a curve defined on a subinterval $I$ of $\mathbb{T}$ with values in $\mathbb{R}^{n} \backslash\{0\}$, let

$$
\hat{\eta}^{(p)}(x):=\eta(x) \wedge \dot{\eta}(x) \wedge \ldots \wedge \eta^{(p-1)}(x) \in \Lambda^{p}\left(\mathbb{R}^{n}\right)
$$

Moreover, if $X$ is a weighted $p$-tuple as above with support in $I$, let

$$
\hat{\eta}(X):=\bigwedge_{1 \leqslant k \leqslant p} \hat{\eta}^{\left(j^{k}\right)}\left(x^{k}\right) \in \Lambda^{n}\left(\mathbb{R}^{n}\right)=\mathbb{R}
$$

Say finally that a weighted $p$-tuple is degenerate with respect to $\eta$ if $\hat{\eta}(X)=0$. Observe finally that being degenerate only depends on the projection of $\eta$ as a curve with values in $\mathbb{P}\left(\mathbb{R}^{n}\right)$ and thus makes sense for curves with values in $\mathbb{P}\left(\mathbb{R}^{n}\right)$. By definition, a curve $\xi$ with values in $\mathbb{P}\left(\mathbb{R}^{n}\right)$ is Frenet if it admits no degenerate weighted $p$-tuple.

Let us work by contradiction and assume that there exists a Hitchin oper so that the associated curve is not Frenet. Let $m$ be the smallest integer so that there exists a curve $\xi$ associated to an Hitchin oper which admits a degenerate $m$-tuple.

Lett $\mathrm{O}_{m}$ be the set of Hitchin opers whose associate curve admits a degenerate $m$-tuple. By our standing assumption, $\mathrm{O}_{m}$ is non empty, and moreover the trivial oper - which corresponds to the Veronese
embedding - does not belong to $\mathrm{O}_{m}$. Thus the contradiction will follow from the following discussion by the connexity of $X_{n}^{0}(\mathbb{T})$ where we prove that $\mathrm{O}_{m}$ is both open and closed.

Step 1: The set $\mathrm{O}_{m}$ is open in $\mathrm{X}_{n}^{0}(\mathbb{T})$.
Let

$$
X=\left(\left(x^{1}, \ldots, x^{m}\right),\left(i_{1}, \ldots, i_{m}\right)\right)
$$

be a degenerate $m$-tuple for the curve $\xi$ associated to the oper $D$. Without loss of generality, we can assume that $i_{1}$ is the greatest integer all all integers $j$ so that $\left(\left(x^{1}, \ldots, x^{m}\right),(j, \ldots)\right)$ is degenerate. Let now $\eta$ be a lift (with values in $\mathbb{R}^{n} \backslash\{0\}$ of $\xi$ on an interval containing the support of $X$. Let us consider the function $f_{D}$ defined on a neighbourhood of $x^{1}$ by

$$
f_{D}: y \mapsto \hat{\eta}(X(y))
$$

where $X(y):=\left(\left(y, x^{2}, \ldots, x^{m}\right),\left(i_{1}, \ldots, i_{m}\right)\right)$. We first prove that $\dot{f}_{D}\left(x^{1}\right) \neq$ 0 . A computation yields

$$
\dot{f}_{D}\left(x^{1}\right)=\left(\hat{\eta}^{\left(i_{1}-2\right)}\left(x_{1}\right) \wedge \eta^{\left(i_{1}\right)}\left(x_{1}\right)\right) \wedge\left(\bigwedge_{2 \leqslant j \leqslant m} \hat{\eta}^{i_{j}}\left(x_{j}\right)\right)
$$

Let us recall the following elementary fact of linear algebra. let $u, v$ and $e_{1} \ldots, e_{k}$ are vectors in $\mathbb{R}^{n}$ so that

$$
\begin{array}{r}
u \wedge v \wedge e_{1} \wedge \ldots \wedge e_{k-1} \neq 0 \\
u \wedge e_{1} \wedge \ldots \wedge e_{k}=0 \tag{131}
\end{array}
$$

then

$$
\begin{equation*}
v \wedge e_{1} \wedge \ldots \wedge e_{k} \neq 0 \tag{132}
\end{equation*}
$$

Indeed, by Assertion (131), $u$ belongs to the hyperplane $H$ generated by $\left(e_{1}, \ldots, e_{k}\right)$. If Assertion (132) does not hold, then $v$ also belongs to to $H$. Thus the vector space plane generated by ( $u, v, e_{1}, \ldots, e_{k-1}$ ) also would lie in $H$, thus contradicting Assertion (130).

We know that by maximality of $i_{1}, \hat{\eta}(Y) \neq 0$, where

$$
Y=\left(\left(x^{1}, \ldots, x^{m}\right),\left(i_{1}+1, i_{2}-1, \ldots, i_{m}\right)\right) \neq 0
$$

Since $f_{D}\left(x^{1}\right)=0$, the previous remark, with $u=\eta^{\left(i_{1}-1\right)}, v=\eta^{\left(i_{1}\right)}$ yields that $\dot{f}_{D}\left(x^{1}\right) \neq 0$.

By transversality, it then that for $D^{\prime}$ close to $D$ there exist $z$ close to $x^{1}$ so that $f_{D^{\prime}}(z)=0$ and thus $D^{\prime} \in \mathrm{O}_{m}$.
STEP 2: The set $\mathrm{O}_{m}$ is closed in $\mathrm{X}_{n}^{0}(\mathbb{T})$.

Let $\left\{\xi_{n}^{1}\right\}_{n \in \mathbb{N}}$ be a sequence of curves associated to a converging sequence of opers in $\mathrm{O}_{m}$ converging to an oper $D$ associated to the curve $\xi$. Let

$$
\left\{X_{n}=\left(\left(x_{n}^{1}, \ldots, x_{n}^{m}\right),\left(j_{n}^{1}, \ldots, j_{n}^{m}\right)\right)\right\}_{n \in \mathbb{N}} .
$$

be the corresponding sequence of degenerate $m$-tuples. We can extract a subsequence so that for every $i$, the sequence $\left\{j_{n}^{i}\right\}_{n \in \mathbb{N}}$ is constant and equal to $j^{i}$. After permutation of $\{1, \ldots, p\}$ and extracting a further subsequence, we can assume that there exists a $p$-tuple, with $p \leqslant m$,

$$
Y=\left(\left(y^{1}, \ldots, y^{p}\right),\left(i^{1}, \ldots, i^{p}\right)\right),
$$

integers $k_{1}, \ldots, k_{p}$ so that
(1) $1=k_{1} \leqslant \ldots \leqslant k_{p}=m$
(2) for all $i$, with $k_{u} \leqslant i<k_{u+1}$,

$$
\lim _{n \rightarrow \infty}\left(x_{n}^{i}\right)=y^{u}
$$

(3) for all $v$, with $1 \leqslant v \leqslant p$,

$$
i^{v}=\sum_{k_{v} \leqslant u<k_{v+1}} j^{u} .
$$

As an application of the Taylor formula, we have

$$
\hat{\eta}^{(p)}(x) \wedge \hat{\eta}^{(k)}(y)=(x-y)^{p . k} \hat{\eta}^{p+k}(x)+o\left((x-y)^{k}\right)
$$

it follows that for all $u$

$$
\lim _{n \rightarrow \infty}\left(\left(\prod_{v=k_{u}}^{k_{u+1}-1} \frac{1}{\left(x_{n}^{v}-y^{u}\right)^{N_{v}}}\right) \bigwedge_{v=k_{u}}^{k_{u+1}-1} \hat{\eta}^{\left(i^{v}\right)}\left(x_{n}^{v}\right)\right)=\hat{\eta}^{\left(i_{u}\right)}\left(y^{u}\right)
$$

where $N_{v}=i^{v}\left(\sum_{w=k_{u}}^{v-1} i^{w}\right)$. In particular, $Y$ is degenerate for $\xi$. Thus $p=m$ by minimality and $D \in \mathrm{O}_{m}$.

Finally, let us say a Frenet curve is Hitchin if it can be deformed through Frenet curves to the Veronese embedding. Then we obtain a consequence of the two previous propositions the following statement which seems to belong to the folklore but for which we could not find a proper reference.

Theorem 10.4.3. The map which associates to an $\mathrm{PSL}_{n}(\mathbb{R})$-oper its associated curve is a homeomorphism from the space of Hitchin opers to the space of Hitchin Frenet curves.
10.5. Cross ratios and opers. Let $\xi$ be a Frenet curve and $\xi^{*}$ be its associated osculating hyperplane curve. The weak cross ratio associated to this pair of curves is the function on

\mathbb{T}^{4 *}:=\left\{(x, y, z, t) \in \mathbb{T}^{4} \mid z \neq y, x \neq t\right\}
$$

defined by

$$
\begin{equation*}
\mathbf{b}_{\xi, \xi^{*}}(x, y, z, t)=\frac{\left\langle\widehat{\xi}(x) \mid \widehat{\xi}^{*}(y)\right\rangle\left\langle\widehat{\xi}(z) \mid \widehat{\xi}^{*}(t)\right\rangle}{\left\langle\widehat{\xi}(z) \mid \widehat{\xi}^{*}(y)\right\rangle\left\langle\widehat{\xi}(x) \mid \widehat{\xi}^{*}(t)\right\rangle}, \tag{133}
\end{equation*}
$$

where for every $u$, we choose an arbitrary nonzero vector $\widehat{\xi}(u)$ and $\widehat{\xi}^{*}(u)$ respectively in $\xi(u)$ and $\xi^{*}(u)$. This weak cross ratio only depends on the oper $D$ and we shall denote it by $\mathbf{b}_{D}$.
10.5.1. Coordinate functions. Let as in Section 10.1.2, $K$ be the line bundle of ( $-1 / 2$ )-densities over $\mathbb{T}$ and $P:=J^{n-1}\left(K^{n-1}\right)$ be the rank $n$ vector bundle of $(n-1)$ jets of sections of the bundle of $(-(n-1) / 2)$ densities. We choose once and for all a trivialisation of $P$ given by $n$ fibrewise independent sections $\sigma_{1}, \ldots, \sigma_{n}$ of $P$ so that $F_{p}$ is generated by $\sigma_{1}, \ldots, \sigma_{p}$.

Let $\nabla$ be a connection on $P$. Let $I$ be an interval in $\mathbb{R}$ with extremities $Y$ and $y$. We pull back $\nabla, P$ and $\sigma_{i}$ on $\mathbb{R}$ using the projection

$$
\pi: \mathbb{R} \rightarrow \mathbb{R} / \mathbb{Z}=\mathbb{T}
$$

We denote the pulled back objects by the same symbol. For any $y \in \mathbb{R}$, let $\sigma_{y}$ the $\nabla$-parallel section of $P$ on $I$ characterised by $\sigma_{y}(y)=\sigma_{1}(y)$. Similarly let $\sigma_{Y}^{*}$ be the $\nabla^{*}$ parallel section on $I$ of $P^{*}$ characterised by $\sigma_{Y}^{*}(Y)=\sigma_{n}^{*}(Y)$ where $\left(\sigma_{1}^{*}, \ldots, \sigma_{n}^{*}\right)$ is the dual basis to $\left(\sigma_{1}, \ldots, \sigma_{n}\right)$.

Then the function $t \mapsto\left\langle\sigma_{Y}^{*}(t), \sigma_{y}(t)\right\rangle$ is constant on $I$.
Definition 10.5.1. [Coordinate function] The coordinate function associated to the points $Y$ and $y$ and the trivialization of $P$, is the function

$$
F_{Y, y}: \nabla \mapsto F_{Y, y}(\nabla)=\left\langle\sigma_{Y}^{*}(t), \sigma_{y}(t)\right\rangle,
$$

defined on the space of connections on $P$.
We shall write $\sigma_{Y}^{*} \otimes \sigma_{y}=: \mathrm{p}^{Y, y}=\mathrm{p}^{Y, y}(\nabla) \in \Omega^{0}\left(\mathbb{R}, \operatorname{End}_{0}(P)\right)$ so that

$$
\begin{equation*}
F_{Y, y}(\nabla)=\operatorname{tr}\left(\mathrm{p}^{Y, y}\right) \tag{134}
\end{equation*}
$$

We then have
Proposition 10.5.2. Assume that $\nabla$ has trivial holonomy. Then the coordinate function $F_{Y, y}$ only depends on the projections of $Y$ and $y$ in $\mathbb{T}$. Moreover there exists a section $\mathbf{p}^{Y_{0}, y_{0}} \in \Omega^{0}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)$, so that $\mathrm{p}^{Y, y}$ is the pull back of $\mathrm{p}^{Y_{0}, y_{0}}$.

Proof. Let $Y_{0}$ and $y_{0}$ the projections of $Y$ and $y$, since $\nabla$ has trivial holonomy, we may find parallel sections $\eta_{y_{0}}$ and $\eta_{Y_{0}}^{*}$, so that $\eta_{y_{0}}\left(y_{0}\right)=$ $\sigma_{1}\left(y_{0}\right)$ and $\eta_{Y_{0}}^{*}\left(Y_{0}\right)=\sigma_{1}\left(Y_{0}\right)$. Then, $\sigma_{y}=\pi^{*}\left(\eta_{y_{0}}\right)$ and $\sigma_{Y}^{*}=\pi^{*}\left(\eta_{y_{0}}\right)$. Thus $F_{Y, y}(\nabla)=\left\langle\eta_{Y_{0}}^{*}(t), \eta_{y_{0}}(t)\right\rangle$. The first part of result follows. For the second part, we take $\mathrm{p}^{Y_{0}, y_{0}}=\eta_{Y_{0}}^{*} \otimes \eta_{y_{0}}$.
10.5.2. Differential of coordinate functions. Our aim in that paragraph is to compute the differential of $F_{Y, y}$, where $Y, y$ belong to an interval $I$.

Proposition 10.5.3. Let $\nabla$ be a connection. Let $y_{0}$ be a point in $\mathbb{R} \backslash I$. Let $\alpha$ be an element of $\Omega^{1}\left(\mathbb{T}, \operatorname{End}_{0}(P)\right)$. Then

$$
\begin{equation*}
\left\langle\mathrm{d}_{\nabla} F_{Y, y}, \alpha\right\rangle=\int_{\mathbb{R}} \psi^{Y, y, y_{0}} \operatorname{tr}\left(\mathrm{p}^{Y, y} \pi^{*}(\alpha)\right), \tag{135}
\end{equation*}
$$

where $\psi^{Y, y, y_{0}}(s):=\left[y_{0} s, Y y\right]$.
We can observe that the right hand side of Equation (135) does not depend on the choice of $y_{0} \in \mathbb{R} \backslash I$. Indeed, by the cocycle identity, $\psi^{Y, y, x}-\psi^{Y, y, z}$ is constant and equal to $[x z, Y y]=0$, if $x, z \notin I$.

Proof. Let $\beta$ de a primitive of $\pi^{*} \alpha$ on $I$ such that $\beta(y)=0$. Let $t \mapsto \nabla^{t}$ be a one parameter smooth family of connections with $\nabla^{0}=\nabla$ so that

\left.\frac{\mathrm{d}}{\mathrm{~d} t}\right|_{t=0} \nabla^{t}=\alpha
$$

Let $G^{t}$ be the family of sections of $\operatorname{End}(P)$ so that $G^{t}(z)=$ Id and $\left(G^{t}\right)^{*} \nabla=\nabla^{t}$. Then by construction

$$
\left.\frac{\mathrm{d}}{\mathrm{~d} t}\right|_{t=0} G^{t}=\beta
$$

Moreover

$$
F_{Y, y}\left(\nabla^{t}\right)=\left\langle\sigma_{n}^{*}(Y), G^{t}\left(\sigma_{y}(Y)\right)\right\rangle .
$$

Thus

$$
\begin{equation*}
\left\langle\mathrm{d}_{\nabla} F_{Y, y}, \alpha\right\rangle=\left\langle\sigma_{Y}^{*}(Y), \beta(Y) \sigma_{y}(Y)\right\rangle . \tag{136}
\end{equation*}
$$

Let $c(t)$ is a curve with value in $I$ so that $c(0)=y$ and $c(1)=Y$. Let

$$
f(t)=\left\langle\sigma_{Y}^{*}(c(t)), \beta(c(t)) \sigma_{y}^{*}(c(t))\right\rangle .
$$

Then

$$
\begin{align*}
\left\langle\mathrm{d}_{\nabla} F_{Y, y}, \alpha\right\rangle & =f(1)-f(0) \\
& =\int_{0}^{1} \dot{f}(s) \mathrm{d} s \tag{137}
\end{align*}
$$

Since $\sigma_{Y}^{*}$ and $\sigma_{y}$ are parallel,

$$
\dot{f}(s)=\sigma_{Y}^{*}(c(s)), \pi^{*}\left(\alpha(\dot{c}(s)) \cdot \sigma_{y}(c(s))\right\rangle
$$

and we have, letting $J$ be the nerval whose endpoints are $Y$ and $y$

$$
\begin{align*}
\left\langle\mathrm{d}_{\nabla} F_{Y, y}, \alpha\right\rangle & =\operatorname{Sign}(Y-y) \int_{J}\left\langle\sigma_{Y}^{*}, \pi^{*}(\alpha) \cdot \sigma_{y}\right\rangle \\
& =\operatorname{Sign}(Y-y) \int_{J} \operatorname{tr}\left(\mathrm{p}^{Y, y} \cdot \pi^{*}(\alpha)\right) \tag{138}
\end{align*}
$$

We deduce the result from Equation (138) and the fact that if for any $y_{0} \notin I$, we have

$$
\operatorname{Sign}(Y-y) \int_{J} \gamma=\int_{\mathbb{R}} \psi^{Y, y, y_{0}} \gamma
$$

10.6. Poisson brackets on the space of connections. Since $F_{X, x}$ is not an observable in the sense of Paragraph 10.2.2, we first need to regularise these functions
10.6.1. Regularisation. Let $\mu$ and $\nu$ two $C^{\infty}$ measures compactly supported in a bounded interval $] a, b[$ of $\mathbb{R}$. Let us consider the function

$$
F_{\mu, \nu}:=\int_{\mathbb{R}^{2}} F_{X, x} \mathrm{~d} \mu \cdot \mathrm{~d} \nu(X, x)
$$

We consider this function defined on the space of connections over the bundle $P \rightarrow \mathbb{T}$. We obviously have

Proposition 10.6.1. Let $\left\{\left(\mu_{n}, \nu_{n}\right)\right\}_{n \in \mathbb{N}}$ be two sequence of measures weakly converging to $(\mu, \nu)$, then $\left\{F_{\mu_{n}, \nu_{n}}\right\}_{n \in \mathbb{N}}$ converges uniformly on every compact to $F_{\mu, \nu}$.

We say the sequence $\left\{\left(\mu_{n}, \nu_{n}\right)\right\}_{n \in \mathbb{N}}$ is regularising for the pair $(X, x)$ if $\mu_{n}, \nu_{n}$ are smooths measures weakly converging to the Dirac measures supported at $X$ and $x$ respectively.
10.6.2. Poisson brackets of regularisation. We now have

Proposition 10.6.2. For any pair of smooth measures $(\mu, \nu)$ with compact support, $F_{\mu, \nu}$ is an obervable. Let $(\mu, \nu)$ and $(\bar{\mu}, \bar{\nu})$ be two pairs of $C^{\infty}$ measures on $\mathbb{R}$. Then the Poisson bracket $\left\{F_{\mu, \nu}, F_{\bar{\mu}, \bar{\nu}}\right\}$ is equal to

$$
\begin{equation*}
\sum_{m \in \mathbb{Z}} \int_{\mathbb{R}^{4}}[m(Y) m(y), X x]\left(F_{X, y} F_{Y, x}-\frac{1}{n^{2}} F_{X, x} F_{Y, y}\right) \mathrm{d} \Lambda(X, x, Y, y) \tag{139}
\end{equation*}
$$

where $m(u)=u+m$ and $\Lambda=\mu \otimes \nu \otimes \bar{\mu} \otimes \bar{\nu}$. In particular if all measures are supported on $[0,1]$, then the bracket $\left\{F_{\mu, \nu}, F_{\bar{\mu}, \bar{\nu}}\right\}$ is equal to

$$
\begin{equation*}
\int_{[0,1]^{4}}[Y y, X x]\left(F_{X, y} F_{Y, x}-\frac{1}{n^{2}} F_{X, x} F_{Y, y}\right) \mathrm{d} \Lambda(X, x, Y, y) . \tag{140}
\end{equation*}
$$

Proof. By Proposition 10.5.3, we have that if $a$ des not belong to the union $K$ of the supports of $\mu$ and $\nu$

$$
\left\langle\mathrm{d} F_{\mu, \nu}, \alpha\right\rangle=\int_{\mathbb{R}^{2}} \psi^{X, x, a} \operatorname{tr}\left(\mathrm{p}^{X, x} \pi^{*} \alpha\right) \mathrm{d} \mu \cdot \mathrm{~d} \nu(X, x) .
$$

Let us denote by $\mathrm{C}_{0}:=\mathrm{C}-\frac{1}{n} \operatorname{tr}(\mathrm{C}) \mathrm{Id}$ the trace free part of the endormorphism C. For any $s$ in $\mathbb{R}$, let

$$
\begin{equation*}
\Lambda_{\mu, \nu}(s):=\int_{\mathbb{R}^{2}} \psi^{X, x, a}(s) \mathfrak{p}_{0}^{X, x}(s) \mathrm{d} \mu \cdot \mathrm{~d} \nu(X, x) . \tag{141}
\end{equation*}
$$

Observe that $\Lambda_{\mu, \nu} \in \Omega^{0}\left(\mathbb{R}, \operatorname{End}_{0}(P)\right)$ and the the support of $\Lambda_{\mu, \nu}$ is included in $K$. Let us trivialise $P$ using the connection $\nabla$. Then let

$$
G_{\mu, \nu}(s):=\sum_{m \in \mathbb{Z}} \Lambda_{\mu, \nu}(s+m) .
$$

Then $G_{\mu, \nu}(s)$ is periodic and thus of the form $\pi^{*} \beta$, with $\beta \in \Omega^{0}(\mathbb{T}, P)$. Moreover

$$
\begin{align*}
\int_{\mathbb{T}} \operatorname{tr}(\beta \cdot \alpha) & =\int_{0}^{1} \operatorname{tr}\left(\pi^{*} \beta \cdot \pi^{*} \alpha\right) \\
& =\int_{\mathbb{R}} \operatorname{tr}\left(\Lambda_{\mu, \nu} \cdot \pi^{*} \alpha\right) \\
& =\left\langle\mathrm{d} F_{\mu, \nu}, \alpha\right\rangle . \tag{142}
\end{align*}
$$

It follows by Equation (142), that

$$
\begin{equation*}
\mathrm{d} F_{\mu, \nu}(s)=\beta \in \mathfrak{g}=\mathrm{D}^{0} \tag{143}
\end{equation*}
$$

In particular, according to Definition 10.2.1, $F_{\mu, \nu}$ is an observable. From Equation (141), we have

\begin{aligned}
\Lambda_{\mu, \nu}(s)= & -\int_{-\infty}^{s} \int_{s}^{\infty} \mathrm{p}_{0}^{X, x}(s) \mathrm{d} \mu \cdot \mathrm{~d} \nu(X, x) \\
& +\int_{s}^{\infty} \int_{-\infty}^{s} \mathrm{p}_{0}^{X, x}(s) \mathrm{d} \mu \cdot \mathrm{~d} \nu(X, x)
\end{aligned}
$$

For any smooth measure probality measure $\xi$ let us write $\mathrm{d} \xi=\dot{\xi} \mathrm{d} \lambda$ where $\lambda$ is the Lebesque measure. Then, since $\mathrm{p}^{X, x}$ is parrallel, we
have

$$
\begin{aligned}
\nabla_{\partial_{t}} \Lambda_{\mu, \nu}(s)= & -\dot{\mu}(s) \int_{s}^{\infty} \mathbf{p}_{0}^{s, x}(s) \mathrm{d} \nu(x)+\dot{\nu}(s) \int_{-\infty}^{s} \mathrm{p}_{0}^{X, s}(s) \mathrm{d} \mu(X) \\
& -\dot{\mu}(s) \int_{-\infty}^{s} \mathbf{p}_{0}^{s, x}(s) \mathrm{d} \nu(x)+\dot{\nu}(s) \int_{s}^{\infty} \mathrm{p}_{0}^{X, s}(s) \mathrm{d} \mu(X) \\
= & \dot{\nu}(s) \int_{\mathbb{R}} \mathbf{p}_{0}^{X, s} \mathrm{~d} \mu(X)-\dot{\mu}(s) \int_{\mathbb{R}} \mathrm{p}_{0}^{s, x} \mathrm{~d} \nu(x) .
\end{aligned}
$$

It follows that

$$
\begin{align*}
& \operatorname{tr}\left(\Lambda_{\mu, \nu}(s+m) \nabla_{\partial_{t}} \Lambda_{\bar{\mu}, \bar{\nu}}(s)\right) \\
= & \dot{\bar{\nu}}(s) \int_{\mathbb{R}^{3}} \psi^{X, x, a}(s+m) \operatorname{tr}\left(\mathfrak{p}_{0}^{Y, s} \mathrm{p}_{0}^{X, x}\right) \mathrm{d} \mu \cdot \mathrm{~d} \nu \cdot \mathrm{~d} \bar{\mu}(X, x, Y) \\
- & \dot{\bar{\mu}}(s) \int_{\mathbb{R}^{3}} \psi^{X, x, a}(s+m) \operatorname{tr}\left(\mathfrak{p}_{0}^{s, y} \mathbf{p}_{0}^{X, x}\right) \mathrm{d} \mu \cdot \mathrm{~d} \nu \cdot \mathrm{~d} \bar{\nu}(X, x, y) \tag{144}
\end{align*}
$$

We can now compute the Poisson bracket as defined in Definition 10.2.1:

$$
\begin{align*}
\left\{F_{\mu, \nu}, F_{\bar{\mu}, \bar{\nu}}\right\} & =\int_{\mathbb{R}} \operatorname{tr}\left(\Lambda_{\mu, \nu}(s) \pi^{*}\left(\nabla_{\partial_{t}} \mathrm{~d} F_{\bar{\mu}, \bar{\nu}}(s)\right)\right) \mathrm{d} \lambda(s) \\
& =\sum_{m \in \mathbb{Z}} \int_{\mathbb{R}} \operatorname{tr}\left(\Lambda_{\mu, \nu}(s) \nabla_{\partial_{t}} \Lambda_{\bar{\mu}, \bar{\nu}}(s+m)\right) \mathrm{d} \lambda(s) \\
& =\sum_{m \in \mathbb{Z}} \int_{\mathbb{R}} \operatorname{tr}\left(\Lambda_{\mu, \nu}(s+m) \nabla_{\partial_{t}} \Lambda_{\bar{\mu}, \bar{\nu}}(s)\right) \mathrm{d} \lambda(s) \tag{145}
\end{align*}
$$

Using Equation (144), we get that

= & \sum_{m \in \mathbb{Z}} \int_{\mathbb{R}^{4}} \psi^{X, \nu, a}(s+m) \operatorname{tr}\left(\mathrm{p}_{\bar{\mu}, \bar{\nu}}^{Y, s} \mathrm{p}_{0}^{X, x}\right) \mathrm{d} \Lambda(X, x, Y, s)  \tag{146}\\
- & \sum_{m \in \mathbb{Z}} \int_{\mathbb{R}^{4}} \psi^{X, x, a}(s+m) \operatorname{tr}\left(\mathrm{p}_{0}^{s, y} \mathrm{p}_{0}^{X, x}\right) \mathrm{d} \Lambda(X, x, s, y) \tag{147}
\end{align*}
$$

Using the dummy changes of variables $s=y$ on Line (146) and $s=Y$ on Line (147), we finally get

$$
\begin{align*}
& \left\{F_{\mu, \nu}, F_{\bar{\mu}, \bar{\nu}}\right\} \\
& =\sum_{m \in \mathbb{Z}} \int_{\mathbb{R}^{4}}\left(\psi^{X, x, a}(y+m)-\psi^{X, x, a}(Y+m)\right) \operatorname{tr}\left(\mathrm{p}_{0}^{Y, y} \mathrm{p}_{0}^{X, x}\right) \mathrm{d} \lambda(X, x, Y, y) \\
& =\sum_{m \in \mathbb{Z}} \int_{\mathbb{R}^{4}}[(Y+m)(y+m), X x] \operatorname{tr}\left(\mathrm{p}_{0}^{Y, y} \mathrm{p}_{0}^{X, x}\right) \mathrm{d} \Lambda(X, x, Y, y) \tag{148}
\end{align*}
$$

We conclude the proof of the proposition by remarking that

$$
\operatorname{tr}\left(\mathrm{p}^{X, x} \mathrm{p}^{Y, y}\right)=\operatorname{tr}\left(\mathrm{p}^{X, y}\right) \operatorname{tr}\left(\mathrm{p}^{Y, x}\right),
$$

and thus

\begin{equation*}
\operatorname{tr}\left(\mathrm{p}_{0}^{X, x} \mathrm{p}_{0}^{Y, y}\right)=\operatorname{tr}\left(\mathrm{p}^{X, y}\right) \operatorname{tr}\left(\mathrm{p}^{Y, x}\right)-\frac{1}{n^{2}} \operatorname{tr}\left(\mathrm{p}^{X, x}\right) \operatorname{tr}\left(\mathrm{p}^{Y, y}\right) . \tag{149}
\end{equation*}
$$

Combining Equations (148) and (149) yields the result.
As corollaries, we obtain
Corollary 10.6.3. Let $\left(\mu_{u}, \nu_{n}\right)$ and $\left(\bar{\mu}_{n}, \bar{\nu}_{n}\right)$ be regularising sequences for $(X, x)$ and $(Y, y)$ respectively. Assume that $\{X, x, Y, y\} \subset] 0,1[$, then

$$
\lim _{n \rightarrow \infty}\left(\left\{F_{\mu_{n}, \nu_{n}}, F_{\bar{\mu}_{n}, \bar{\nu}_{n}}\right\}\right)=[Y y, X x]\left(F_{X, y} F_{Y, x}-\frac{1}{n^{2}} F_{X, x} F_{Y, y}\right) .
$$

Corollary 10.6.4. Let $(X, x, Y, y)$ be a quadruple of pairwise distinct points. Then $\left(F_{X, x}, F_{Y, y}\right)$ is a pair of acceptable observables. Moreover,

$$
\left\{F_{X, x}, F_{Y, y}\right\}=[Y y, X x]\left(F_{X, y} F_{Y, x}-\frac{1}{n^{2}} F_{X, x} F_{Y, y}\right) .
$$

This last corollary interprets the swapping algebra as an algebra of "observables" on the space of connections.
10.7. Drinfel'd-Sokolov reduction and the multi fraction algebra. We intruced in Paragraph 10.5.1 functions of connections depending on the choice of a trivialisation of $P$. We now introduce functions that only depend on the associated oper and do not rely on the choice of the trivialisation of $P$.

We first relate crossatios with our previously defined coordinate functions.
10.7.1. Cross ratios. The following proposition follows at once from the definitions.

Proposition 10.7.1. Let $D$ a Hitchin oper associated to connection $\nabla$ with trivial holonomy. Let $X, x, Y, y$ be a quadruple of pairwise distinct points of $\mathbb{T}$. Let $\tilde{X}, \tilde{x}, \tilde{Y}, \tilde{y}$ be lifts of $X, x, Y, y$ in $\mathbb{R}$, then

$$
\mathbf{b}_{D}(X, x, Y, y)=\frac{F_{\tilde{X}, \tilde{y}}(\nabla) \cdot F_{\tilde{Y}, \tilde{x}}(\nabla)}{F_{\tilde{X}, \tilde{x}}(\nabla) \cdot F_{\tilde{Y}, \tilde{y}}(\nabla)}
$$

10.7.2. The main Theorem. We can now prove our main theorem which relates the Poisson structure on the space of opers and the multi fraction algebra.

Theorem 10.7.2. Let $\left(X_{0}, x_{0}, Y_{0}, y_{0}, X_{1}, x_{1}, Y_{1}, y_{1}\right)$ be pairwise distinct points. Then the cross fractions $\left[X_{0} ; x_{0} ; Y_{0} ; y_{0}\right]$ and $\left[X_{1} ; x_{1} ; Y_{1} ; y_{1}\right]$ defines a pair of acceptable observables whose Poisson bracket with respect to the Drinfel'd-Sokolov reduction coincide with their Poisson bracket in the multi fraction algebra.

Proof. This is an immediate consequence of Proposition 10.7.1 and Corollary 10.6.4, as well as the definition of the Poisson structure coming from the symplectic reduction in Theorem 10.3.3.

## 11. Appendix: existence of Vanishing sequences

We prove the existence of vanishing sequences.
Definition 11.0.3. [SEPARABILITY in groups] Let $G$ be a group. The group $G$ is said to be subgroup separable, if given any finitely generated subgroup $H$ in $G$, given any $g \in G$ and $h \notin H g$, there exists a finite index subgroup $G_{0}$ in $G$ such that if $\pi$ is the projection of $G$ onto $G / G_{0}$, then

$$
\pi(h) \notin \pi(H g) .
$$

Let $G$ be a group. The group $G$ is said to be double coset separable, if given any finitely generated subgroups $H$ and $K$ in $G$, given any $g \in G$ and $h \notin H g K$, there exists a finite index subgroup $G_{0}$ in $G$ such that if $\pi$ is the projection of $G$ onto $G / G_{0}$, then

$$
\pi(h) \notin \pi(H g K) .
$$

Observe that a double coset separable group is then subgroup separable and residually finite. G. Niblo proved in [19]

Theorem 11.0.4. A surface group is double coset separable.
As an immediate consequence, since $\pi_{1}(S)$ is countable, we have
Corollary 11.0.5. Vanishing sequences exist.
