# A Remark on the Stability of Peakons for the Degasperis-Procesi Equation

#### Abstract

In this paper, we present a new argument (see Lemma 3.4) that allows us to simplify the proof of stability of peakons established in Lin and Liu (2009) (Theorem 1.1).


## 1 Introduction

In this paper, we consider the Degasperis-Procesi equation (DP)

$$
\begin{equation*}
u_{t}-u_{t x x}+4 u u_{x}=3 u_{x} u_{x x}+u u_{x x x}, \quad(t, x) \in \mathbb{R}_{+} \times \mathbb{R} \tag{1.1}
\end{equation*}
$$

with $u(0)=u_{0} \in L^{2}(\mathbb{R})$ and $\left(1-\partial_{x}^{2}\right) u_{0} \in \mathcal{M}^{+}(\mathbb{R})$.
The DP equation is completely integrable (see [3]) and has been proved to be physically relevant for water waves (see [1]). It possesses, among others, the following conservation laws

$$
\begin{equation*}
E(u)=\int_{\mathbb{R}} y v=\int_{\mathbb{R}}\left(4 v^{2}+5 v_{x}^{2}+v_{x x}^{2}\right), \quad F(u)=\int_{\mathbb{R}} u^{3}=\int_{\mathbb{R}}\left(-v_{x x}^{3}+12 v v_{x x}^{2}-48 v^{2} v_{x x}+64 v^{3}\right), \tag{1.2}
\end{equation*}
$$

where $y=\left(1-\partial_{x}^{2}\right) u$ and $v=\left(4-\partial_{x}^{2}\right)^{-1} u$. One can notice that the conservation law $E(\cdot)$ is equivalent to $\|\cdot\|_{L^{2}(\mathbb{R})}^{2}$. Indeed, using integration by parts (we assume that $u( \pm \infty)=v( \pm \infty)=v_{x}( \pm \infty)=0$ ), it holds

$$
\begin{equation*}
\|u\|_{L^{2}(\mathbb{R})}^{2}=\int_{\mathbb{R}} u^{2}=\int_{\mathbb{R}}\left(4 v-v_{x x}\right)^{2}=\int_{\mathbb{R}}\left(16 v^{2}+8 v_{x}^{2}+v_{x x}^{2}\right) \sim E(u) . \tag{1.3}
\end{equation*}
$$

In the sequel we will denote

$$
\begin{equation*}
\|u\|_{\mathcal{H}}=\sqrt{E(u)} . \tag{1.4}
\end{equation*}
$$

Applying $\left(1-\partial_{x}^{2}\right)^{-1}(\cdot)$ to (1.1), we obtain

$$
\begin{equation*}
u_{t}+\frac{1}{2} \partial_{x} u^{2}+\frac{3}{2}\left(1-\partial_{x}^{2}\right)^{-1} \partial_{x} u^{2}=0, \quad(t, x) \in \mathbb{R}_{+} \times \mathbb{R} \tag{1.5}
\end{equation*}
$$

In this form, the DP equation admits explicit solitary waves called peakons (see [3]) that are defined by

$$
\begin{equation*}
u(t, x)=\varphi_{c}(x-c t)=c \varphi(x-c t)=c e^{-|x-c t|}, \quad c \in \mathbb{R}^{*}, \quad(t, x) \in \mathbb{R}_{+} \times \mathbb{R} \tag{1.6}
\end{equation*}
$$

Our goal is to simplify the proof given in [7] of the stability of a single peakon for the DP equation. Recall that the proof of the stability for the Camassa-Holm equation (CH) in [2] follows from two integral relations between two conservation laws of $\mathrm{CH}, \max _{\mathbb{R}} u$ and functions related to $u$. In [7] the proof is more complicated, since all the local maxima and minima of $v=\left(4-\partial_{x}^{2}\right)^{-1} u$ are involved in the relations. In this paper we present a simplification of this proof, where only the maximum of $v$ is involved in the relations. Our proof is thus closer to the proof for CH in [2]. The main idea is the following: since $u$ is $L^{2}$-close to the peakon $\varphi_{c}(\cdot-\xi)$, for some $\xi \in \mathbb{R}$, and $\left(1-\partial_{x}^{2}\right) u \in \mathcal{M}^{+}(\mathbb{R})$, it is easy to check that $u$ is actually $C^{0}$-close to the peakon, and thus $v$ is $C^{2}$-close to the smooth-peakon:

$$
\begin{equation*}
\rho_{c}(x-\xi)=\left(4-\partial_{x}^{2}\right)^{-1} \varphi_{c}(x-\xi)=\frac{c}{3} e^{-|x-\xi|}-\frac{c}{6} e^{-2|x-\xi|}, \quad x \in \mathbb{R} . \tag{1.7}
\end{equation*}
$$

First, since $\rho_{c}, \rho_{c}^{\prime}$ and $\rho_{c}^{\prime \prime}$ are very small with respect to the amplitude $c$ outside of the interval $\Theta_{0}=$ $[-6.7,6.7]$, we can restrict ourself to study $v$ on $\Theta_{\xi}=[\xi-6.7, \xi+6.7]$. Now we observe that $\rho_{c}^{\prime \prime}$ has strictly negative values in the interval $\mathcal{V}_{0}=[-\ln \sqrt{2}, \ln \sqrt{2}]$, with $\rho_{c}^{\prime}$ strictly positive on $[-6.7,-\ln \sqrt{2}]$ and $\rho_{c}^{\prime}$ strictly negative on $[\ln \sqrt{2}, 6.7]$. This forces $v_{x}$ to change sign only one time on $\Theta_{\xi}$, and thus $v$ has only one local extremum (which is a maximum) on $\Theta_{\xi}$. This fact will considerably simplify the proof of the stability.

## 2 Preliminaries

In this section, we briefly recall the global well-posedness results for the Cauchy problem of the DP equation (see [5] and [8]), and its consequences. For $I$ a finite or infinite time interval of $\mathbb{R}_{+}$, we denote by $\mathcal{X}(I)$ the function space ${ }^{1}$

\mathcal{X}(I)=\left\{u \in C\left(I ; H^{1}(\mathbb{R})\right) \cap L^{\infty}\left(I ; W^{1,1}(\mathbb{R})\right), u_{x} \in L^{\infty}(I ; B V(\mathbb{R}))\right\} \tag{2.1}
\end{equation*}
$$

Theorem 2.1 (Global Weak Solution; See [5] and [8]). Assume that $u_{0} \in L^{2}(\mathbb{R})$ with $y_{0}=\left(1-\partial_{x}^{2}\right) u_{0} \in$ $\mathcal{M}^{+}(\mathbb{R})$. Then the DP equation has a unique global weak solution $u \in \mathcal{X}\left(\mathbb{R}_{+}\right)$such that

$$
\begin{equation*}
y(t, \cdot)=\left(1-\partial_{x}^{2}\right) u(t, \cdot) \in \mathcal{M}^{+}(\mathbb{R}), \quad \forall t \in \mathbb{R}_{+} \tag{2.2}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|u_{x}(t, x)\right| \leq u(t, x), \quad \forall(t, x) \in \mathbb{R}_{+} \times \mathbb{R} \tag{2.3}
\end{equation*}
$$

Moreover $E(\cdot)$ and $F(\cdot)$ are conserved by the flow.
Remark 2.1 (Control of $L^{\infty}$ Norm by $L^{2}$ Norm). (2.3) and the well-known Sobolev embedding of $H^{1}(\mathbb{R})$ into $L^{\infty}(\mathbb{R})$ lead to

$$
\begin{equation*}
\|u\|_{L^{\infty}(\mathbb{R})} \leq \frac{1}{\sqrt{2}}\|u\|_{H^{1}(\mathbb{R})} \leq\|u\|_{L^{2}(\mathbb{R})} \tag{2.4}
\end{equation*}
$$

## 3 Stability of peakons

In this section, we present our simplification of the proof of stability of peakons for the DP equation.
Theorem 3.1 (Stability of Peakons). Let $u \in \mathcal{X}([0, T[)$, with $0<T \leq+\infty$, be a solution of the DP equation and $\varphi_{c}$ be the peakon defined in (1.6), traveling to the right at the speed $c>0$. There exist $C>0$ and $\varepsilon_{0}>0$ only depending on the speed $c$, such that if

$$
\begin{equation*}
y_{0}=\left(1-\partial_{x}^{2}\right) u_{0} \in \mathcal{M}^{+}(\mathbb{R}) \tag{3.1}
\end{equation*}
$$

\[

$$
\begin{equation*}
\left\|u_{0}-\varphi_{c}\right\|_{\mathcal{H}} \leq \varepsilon^{2}, \text { with } 0<\varepsilon<\varepsilon_{0} \tag{3.2}
\end{equation*}
$$

\]

then

$$
\begin{equation*}
\left\|u(t, \cdot)-\varphi_{c}(\cdot-\xi(t))\right\|_{\mathcal{H}} \leq C \sqrt{\varepsilon}, \quad \forall t \in[0, T[ \tag{3.3}
\end{equation*}
$$

where $\xi(t) \in \mathbb{R}$ is the only point where the function $v(t, \cdot)=\left(4-\partial_{x}^{2}\right)^{-1} u(t, \cdot)$ attains its maximum.
We first recall that $E(u) \sim E\left(\varphi_{c}\right)$ and $F(u) \sim F\left(\varphi_{c}\right)$ in $\mathbb{R}$, if $u \sim \varphi_{c}$ in $L^{2}(\mathbb{R})$, with $y \in \mathcal{M}^{+}(\mathbb{R})$ (see for instance [7] or [6]).

Lemma 3.1 (Control of Distances Between Energies; See [6]). Let $u \in L^{2}(\mathbb{R})$ with $y=\left(1-\partial_{x}^{2}\right) u \in$ $\mathcal{M}^{+}(\mathbb{R})$. If $\left\|u-\varphi_{c}\right\|_{\mathcal{H}} \leq \varepsilon^{2}$, then

$$
\begin{equation*}
\left|E(u)-E\left(\varphi_{c}\right)\right| \leq O\left(\varepsilon^{2}\right) \tag{3.4}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|F(u)-F\left(\varphi_{c}\right)\right| \leq O\left(\varepsilon^{2}\right) \tag{3.5}
\end{equation*}
$$

where $O(\cdot)$ only depends on the speed $c$.
To prove Theorem 3.1, by the conservation of $E(\cdot), F(\cdot)$ and the continuity of the map $t \mapsto u(t)$ from $\left[0, T\left[\right.\right.$ to $\mathcal{H}$ (since $\mathcal{H} \simeq L^{2}$ ), it suffices to prove that for any function $u \in L^{2}(\mathbb{R})$ satisfying $y=\left(1-\partial_{x}^{2}\right) u \in$ $\mathcal{M}^{+}(\mathbb{R}),(3.4)$ and (3.5), if

$$
\begin{equation*}
\inf _{z \in \mathbb{R}}\left\|u-\varphi_{c}(\cdot-z)\right\|_{\mathcal{H}} \leq \varepsilon^{1 / 4} \tag{3.6}
\end{equation*}
$$

then

$$
\begin{equation*}
\left\|u-\varphi_{c}(\cdot-\xi)\right\|_{\mathcal{H}} \leq C \sqrt{\varepsilon} \tag{3.7}
\end{equation*}
$$

where $\xi \in \mathbb{R}$ is the only point of maximum of $v$.
Let us present some important properties of smooth-peakons, defined in (1.7), which will play a crucial role in the proof of Theorem 3.1. The smooth-peakon $\rho_{c}$ belongs to $H^{3}(\mathbb{R}) \hookrightarrow C^{2}(\mathbb{R})$ (by the Sobolev embedding) since $\varphi_{c}$ belongs to $H^{1}(\mathbb{R})$ (defined in (1.6)). It is a positive even function, which admits a single maximum $c / 6$ at point 0 , and decays at infinity to 0 (see Fig. 1a). Its derivative $\rho_{c}^{\prime}$ belongs to $H^{2}(\mathbb{R}) \hookrightarrow C^{1}(\mathbb{R})$, it is an odd function, which vanishes only at the origin and has negative values on $[0,+\infty[$. It admits a a single minimum $-c / 12$ at point $\ln 2$ and tends at infinity to 0 (see Fig. 1b). Its second derivative $\rho_{c}^{\prime \prime}$ belongs to $H^{1}(\mathbb{R}) \hookrightarrow C^{0}(\mathbb{R})$, it is an even function, which vanishes at $\pm \ln 2$, takes positive values on $]-\infty,-\ln 2[\cup] \ln 2,+\infty[$ and negative values on $[-\ln 2, \ln 2]$. It admits a single minimum $-c / 3$ at point 0 and two maxima $c / 24$ at points $\pm \ln 4$, and decays at infinity to 0 (see Fig. 1c).

Next, we will need the following estimates.
Lemma $3.2\left(C^{0}, C^{1}\right.$ and $C^{2}$ Approximations). Let $u \in L^{2}(\mathbb{R})$ with $y=\left(1-\partial_{x}^{2}\right) u \in \mathcal{M}^{+}(\mathbb{R})$. If $\left\|u-\varphi_{c}\right\|_{\mathcal{H}} \leq \varepsilon^{1 / 4}$, then

$$
\begin{equation*}
\left\|u-\varphi_{c}\right\|_{C^{0}(\mathbb{R})}+\left\|v-\rho_{c}\right\|_{C^{2}(\mathbb{R})} \leq O\left(\varepsilon^{1 / 8}\right) \tag{3.8}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|v-\rho_{c}\right\|_{C^{1}(\mathbb{R})} \leq O\left(\varepsilon^{1 / 4}\right) \tag{3.9}
\end{equation*}
$$

Proof. Let us begin with the second estimate. From the definition of $E(\cdot)$ and $\mathcal{H}$ (see respectively (1.2) and (1.4)), one can see that $\|u\|_{\mathcal{H}}$ is equivalent to $\|v\|_{H^{2}(\mathbb{R})}$, since $\|v\|_{H^{2}(\mathbb{R})} \leq\|u\|_{\mathcal{H}} \leq 5\|v\|_{H^{2}(\mathbb{R})}$. Then, assumption $u$ is $\mathcal{H}$-close to $\varphi_{c}$ implies that $v$ is $H^{2}$-close to $\rho_{c}$. Now, using the Sobolev embedding of $H^{2}(\mathbb{R})$ into $C^{1}(\mathbb{R})$, we deduce (3.9).

For the first estimate, note that the assumption $y=\left(1-\partial_{x}^{2}\right) u \geq 0$ implies that $u=\left(1-\partial_{x}^{2}\right)^{-1} y \geq 0$ and satisfies $\left|u_{x}\right| \leq u$ on $\mathbb{R}$ (see (2.3)). Then, applying triangular inequality, and using that $\left|\varphi_{c}^{\prime}\right|=\varphi_{c}$ on
$\mathbb{R}$ and (2.4), we have

$$
\begin{aligned}
\left\|u-\varphi_{c}\right\|_{H^{1}(\mathbb{R})} & \leq\|u\|_{H^{1}(\mathbb{R})}+\left\|\varphi_{c}\right\|_{H^{1}(\mathbb{R})} \\
& \leq 2\|u\|_{L^{2}(\mathbb{R})}+2\left\|\varphi_{c}\right\|_{L^{2}(\mathbb{R})} \\
& \leq 2\left\|u-\varphi_{c}\right\|_{L^{2}(\mathbb{R})}+4\left\|\varphi_{c}\right\|_{L^{2}(\mathbb{R})} \\
& \leq O\left(\varepsilon^{1 / 4}\right)+O(1)
\end{aligned}
$$

where $\left\|\varphi_{c}\right\|_{L^{2}(\mathbb{R})}=c$. Therefore, applying the Gagliardo-Nirenberg inequality and using that $\left\|u-\varphi_{c}\right\|_{\mathcal{H}} \leq$ $\varepsilon^{1 / 4}$ (with $\mathcal{H} \simeq L^{2}$ ), we obtain

$$
\begin{aligned}
\left\|u-\varphi_{c}\right\|_{C^{0}(\mathbb{R})} & \leq\left\|u-\varphi_{c}\right\|_{L^{2}(\mathbb{R})}^{1 / 2}\left\|u-\varphi_{c}\right\|_{H^{1}(\mathbb{R})}^{1 / 2} \\
& \leq O\left(\varepsilon^{1 / 8}\right)\left(O\left(\varepsilon^{1 / 8}\right)+O(1)\right) \\
& \leq O\left(\varepsilon^{1 / 8}\right)
\end{aligned}
$$

Finally to estimate the second term of the left-hand side of (3.8), we first notice that the continuity of $\left(4-\partial_{x}^{2}\right)^{-1}(\cdot)$ from $H^{s}(\mathbb{R})$ to $H^{s+2}(\mathbb{R})$ and the above estimates ensure that $\left\|v-\rho_{c}\right\|_{H^{3}}=O(1)$ and $\left\|v-\rho_{c}\right\|_{H^{2}}=O\left(\varepsilon^{1 / 4}\right)$. These last estimates combined with the Gagliardo-Nirenberg inequality yield the result as above.

The following lemma specifies the distance to minimize for stability.
Lemma 3.3 (Quadratic Identity; See [7]). For any $u \in L^{2}(\mathbb{R})$ and $\xi \in \mathbb{R}$, it holds

$$
\begin{equation*}
E(u)-E\left(\varphi_{c}\right)=\left\|u-\varphi_{c}(\cdot-\xi)\right\|_{\mathcal{H}}^{2}+4 c\left(v(\xi)-\frac{c}{6}\right) \tag{3.10}
\end{equation*}
$$

where $v=\left(4-\partial_{x}^{2}\right)^{-1} u$ and $\rho_{c}(0)=c / 6$.
Proof. We follow the idea of Constantin and Strauss with the CH equation (see [2], Lemma 1). We compute

$$
\begin{align*}
E\left(u-\varphi_{c}(\cdot-\xi)\right) & =E(u)+E\left(\varphi_{c}\right)-2\left\langle\left(1-\partial_{x}^{2}\right) \varphi_{c}(\cdot-\xi),\left(4-\partial_{x}^{2}\right)^{-1} u\right\rangle_{H^{-1}, H^{1}} \\
& =E(u)+E\left(\varphi_{c}\right)-2\left\langle\left(1-\partial_{x}^{2}\right) \varphi_{c}(\cdot-\xi), v\right\rangle_{H^{-1}, H^{1}} \tag{3.11}
\end{align*}
$$

where $\langle\cdot, \cdot\rangle_{H^{-1}, H^{1}}$ denotes the duality bracket $H^{-1}(\mathbb{R}), H^{1}(\mathbb{R})$. Now, using the definition of $\varphi_{c}^{\prime}(\cdot-\xi)$ and integration by parts, we have

$$
\begin{align*}
\left\langle\left(1-\partial_{x}^{2}\right) \varphi_{c}(\cdot-\xi), v\right\rangle_{H^{-1}, H^{1}} & =\int_{\mathbb{R}} v \varphi_{c}(\cdot-\xi)+\int_{\mathbb{R}} v_{x} \varphi_{c}^{\prime}(\cdot-\xi) \\
& =\int_{\mathbb{R}} v \varphi_{c}(\cdot-\xi)+\int_{-\infty}^{\xi} v_{x} \varphi_{c}(\cdot-\xi)-\int_{\xi}^{+\infty} v_{x} \varphi_{c}(\cdot-\xi) \\
& =2 c v(\xi) \tag{3.12}
\end{align*}
$$

Recalling that the energy of peakons is given by

$$
\begin{align*}
E\left(\varphi_{c}\right) & =\left\langle\left(1-\partial_{x}^{2}\right) \varphi_{c},\left(4-\partial_{x}^{2}\right)^{-1} \varphi_{c}\right\rangle_{H^{-1}, H^{1}}=\int_{\mathbb{R}} \rho_{c} \varphi_{c}+\int_{\mathbb{R}} \rho_{c}^{\prime} \varphi_{c}^{\prime} \\
& =\int_{\mathbb{R}} \rho_{c} \varphi_{c}+\int_{-\infty}^{0} \rho_{c}^{\prime} \varphi_{c}-\int_{0}^{+\infty} \rho_{c}^{\prime} \varphi_{c}=2 c \rho_{c}(0)=\frac{c^{2}}{3} \tag{3.13}
\end{align*}
$$

we obtain the lemma.
Now we will study carefully the local extrema of $v=\left(4-\partial_{x}^{2}\right)^{-1} u$. Let $u \in L^{2}(\mathbb{R})$ with $y=\left(1-\partial_{x}^{2}\right) u \in$ $\mathcal{M}^{+}(\mathbb{R})$, and assume that (3.6) holds for some $z \in \mathbb{R}$. We consider the interval in which the mass of

smooth-peakons is concentrated, and the interval in which the mass of second derivative of smoothpeakons is strictly negative. In the sequel of this paper, the notation $\alpha \simeq \beta$ means that $0.9 \times \beta \leq \alpha \leq$ $1.1 \times \beta$. We set, for any $z \in \mathbb{R}$,

$$
\begin{equation*}
\Theta_{z}=[z-6.7, z+6.7], \quad \text { where } 6.7 \simeq \ln \left(\frac{20}{20-\sqrt{399}}\right) \tag{3.14}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{V}_{z}=[z-\ln \sqrt{2}, z+\ln \sqrt{2}] \tag{3.15}
\end{equation*}
$$

One can clearly see that $\mathcal{V}_{0}$ is a subset of $\Theta_{0}$ (since $\left.20 /(20-\sqrt{399})>\sqrt{2}\right)$. We chose the values $\pm 6.7$ such that $\rho_{c}( \pm 6.7) \simeq c / 2400 \simeq 4.1 \times 10^{-4} c$ as in [6]. Also, we have $\rho_{c}^{\prime}(-6.7)=-\rho_{c}^{\prime}(6.7) \simeq 4.1 \times 10^{-4} c$ and $\rho_{c}^{\prime \prime}( \pm 6.7) \simeq 4.1 \times 10^{-4} c$. Then $\rho_{c}, \rho_{c}^{\prime}$ and $\rho_{c}^{\prime \prime}$ are very small with respect to the amplitude $c$ on $\mathbb{R} \backslash \Theta_{0}$.

We claim the following result.
Lemma 3.4 (Uniqueness of the Local Maximum). Let $u \in L^{2}(\mathbb{R})$ with $y=\left(1-\partial_{x}^{2}\right) u \in \mathcal{M}^{+}(\mathbb{R})$, that satisfies (3.6) for some $z \in \mathbb{R}$. There exists $\varepsilon_{0}>0$ only depending on the speed $c$, such that if $0<\varepsilon<\varepsilon_{0}$,
then the function $v=\left(4-\partial_{x}^{2}\right)^{-1} u$ admits a unique local extremum on $\Theta_{z}$. This extremum is a maximum, and it holds

$$
\begin{align*}
& v(x) \leq \frac{c}{300}, \quad \forall x \in \mathbb{R} \backslash \Theta_{z},  \tag{3.16}\\
& u(x) \leq \frac{c}{300}, \quad \forall x \in \mathbb{R} \backslash \Theta_{z} . \tag{3.17}
\end{align*}
$$

Proof. The key is to study the impact of the assumption $y \in \mathcal{M}^{+}(\mathbb{R})$ on $v$. First, let us show that $\left|v_{x}\right| \leq 2 v$ on $\mathbb{R}$. We recall that from the assumption $y \geq 0$, we have $u \geq 0$ and $v \geq 0$ on $\mathbb{R}$. According to the definition of $v$, we have for all $x \in \mathbb{R}$,

$$
v(x)=\frac{e^{-2 x}}{4} \int_{-\infty}^{x} e^{2 x^{\prime}} u\left(x^{\prime}\right) d x^{\prime}+\frac{e^{2 x}}{4} \int_{x}^{+\infty} e^{-2 x^{\prime}} u\left(x^{\prime}\right) d x^{\prime}
$$

and

$$
v_{x}(x)=-\frac{e^{-2 x}}{2} \int_{-\infty}^{x} e^{2 x^{\prime}} u\left(x^{\prime}\right) d x^{\prime}+\frac{e^{2 x}}{2} \int_{x}^{+\infty} e^{-2 x^{\prime}} u\left(x^{\prime}\right) d x^{\prime}
$$

which yields

$$
\begin{equation*}
\left|v_{x}(x)\right| \leq 2 v(x), \quad \forall x \in \mathbb{R} \tag{3.18}
\end{equation*}
$$

Second, let us show that $u \leq 6 v$ on $\mathbb{R}$. Using the Fourier transform, one can check that

$$
\begin{align*}
\left(1-\partial_{x}^{2}\right)^{-1}\left(4-\partial_{x}^{2}\right)^{-1}(\cdot) & =\mathcal{F}^{-1}\left[\frac{1}{3\left(1+\omega^{2}\right)}-\frac{1}{3\left(4+\omega^{2}\right)}\right](\cdot) \\
& =\frac{1}{3}\left(1-\partial_{x}^{2}\right)^{-1}(\cdot)-\frac{1}{3}\left(4-\partial_{x}^{2}\right)^{-1}(\cdot) \tag{3.19}
\end{align*}
$$

and one can rewrite $v$ as

$$
\begin{equation*}
v=\left(4-\partial_{x}^{2}\right)^{-1}\left(1-\partial_{x}^{2}\right)^{-1} y=\frac{1}{3}\left(1-\partial_{x}^{2}\right)^{-1} y-\frac{1}{3}\left(4-\partial_{x}^{2}\right)^{-1} y \tag{3.20}
\end{equation*}
$$

Then for all $x \in \mathbb{R}$,

$$
\begin{align*}
u(x)-6 v(x) & =-\left(1-\partial_{x}^{2}\right)^{-1} y(x)+2\left(4-\partial_{x}^{2}\right)^{-1} y(x) \\
& =-\frac{1}{2} \int_{\mathbb{R}} e^{-\left|x-x^{\prime}\right|} y\left(x^{\prime}\right) d x^{\prime}+\frac{1}{2} \int_{\mathbb{R}} e^{-2\left|x-x^{\prime}\right|} y\left(x^{\prime}\right) d x^{\prime} \\
& \leq 0 \tag{3.21}
\end{align*}
$$

since $e^{-2|\cdot|} \leq e^{-|\cdot|}$ on $\mathbb{R}$.
We are now ready to prove the uniqueness of local maxima in $\Theta_{z}$. Let us first study the sign of $v_{x x}$ on $\mathcal{V}_{z}$. One can easy check that for all $x \in \mathcal{V}_{0}$,

$$
\begin{equation*}
\rho_{c}^{\prime \prime}(x) \leq \frac{\sqrt{2}-2}{6} c . \tag{3.22}
\end{equation*}
$$

Then, combining (3.8) and (3.22), taking $0<\varepsilon<\varepsilon_{0}$ with $\varepsilon_{0} \ll 1$, we have for all $x \in \mathcal{V}_{z}$,

$$
v_{x x}(x) \leq \frac{\sqrt{2}-2}{6} c+O\left(\varepsilon^{1 / 4}\right) \leq \frac{\sqrt{2}-2}{600} c<0
$$

which implies that $v_{x}$ is strictly decreasing on $\mathcal{V}_{z}$. Let us study the sign of $v_{x}$ on $\Theta_{z} \backslash \mathcal{V}_{z}$. One can easily check that

$$
\begin{equation*}
\rho_{c}^{\prime}(-\ln \sqrt{2})=\frac{\sqrt{2}-1}{6} c \text { and } \rho_{c}^{\prime}(\ln \sqrt{2})=-\frac{\sqrt{2}-1}{6} c \tag{3.23}
\end{equation*}
$$

and that $\rho_{c}^{\prime}(x) \geq 10^{-4} c$ for all $x \in[-6.7,-\ln \sqrt{2}]$. Then using (3.9) and taking $0<\varepsilon<\varepsilon_{0}$ with $\varepsilon_{0} \ll 1$, we have $v_{x}(x) \geq 4 \times 10^{-5} c>0$ for all $x \in[z-6.7, z-\ln \sqrt{2}]$. Proceeding in the same way, we obtain $v_{x}(x) \leq-4 \times 10^{-5} c<0$ for all $x \in[z+\ln \sqrt{2}, z+6.7]$. Since $v_{x}$ is strictly decreasing on $\mathcal{V}_{z}$ and changes sign, $v_{x}$ vanishes once on $\mathcal{V}_{z}$ and thus on $\Theta_{z}$. Hence, $v$ admits a single local extremum on $\Theta_{z}$, which is a maximum since $v_{x x}<0$ on $\mathcal{V}_{z}$.

Now, using that $\rho_{c}$ is increasing on $\mathbb{R}^{-},(3.9)$ and taking $0<\varepsilon<\varepsilon_{0}$ with $\varepsilon_{0} \ll 1$, it holds for all $x \in]-\infty, z-6.7[$,

$$
v(x)=\rho_{c}(x-z)+O\left(\varepsilon^{1 / 4}\right) \leq \frac{c}{2400}+O\left(\varepsilon^{1 / 4}\right) \leq \frac{c}{300} .
$$

Proceeding in the same way for $x \in] z+6.7,+\infty[$, we obtain (3.16).
Combining (3.8), (3.21) and proceeding as for the estimate (3.16), we get (3.17). Note that $\varphi_{c}( \pm 6.7) \simeq$ $1.2 \times 10^{-3} c$. This completes the proof of the lemma.

Under the assumptions of Lemma 3.4, $v$ has got a unique point of global maximum on $\mathbb{R}$. In the sequel of this section, we will denote by $\xi$ this point of global maximum and we set $M=v(\xi)=\max _{x \in \mathbb{R}} v(x)$. The next two lemmas can be directly deduced from the similar lemmas established in [7] (see also [6]).

Lemma 3.5 (Connection Between $E(\cdot)$ and $M^{2}$; See [7]). Let $u \in L^{2}(\mathbb{R})$ and $v=\left(4-\partial_{x}^{2}\right)^{-1} u \in H^{2}(\mathbb{R})$. Define the function $g$ by

$$
g(x)= \begin{cases}2 v+v_{x x}-3 v_{x}, & x<\xi  \tag{3.24}\\ 2 v+v_{x x}+3 v_{x}, & x>\xi\end{cases}
$$

Then it holds

$$
\begin{equation*}
\int_{\mathbb{R}} g^{2}(x) d x=E(u)-12 M^{2} \tag{3.25}
\end{equation*}
$$

Lemma 3.6 (Connection Between $F(\cdot)$ and $M^{3}$; See [7]). Let $u \in L^{2}(\mathbb{R})$ and $v=\left(4-\partial_{x}^{2}\right)^{-1} u \in H^{2}(\mathbb{R})$. Define the function $h$ by

$$
h(x)= \begin{cases}-v_{x x}-6 v_{x}+16 v, & x<\xi  \tag{3.26}\\ -v_{x x}+6 v_{x}+16 v, & x>\xi\end{cases}
$$

Then it holds

$$
\begin{equation*}
\int_{\mathbb{R}} h(x) g^{2}(x) d x=F(u)-144 M^{3} \tag{3.27}
\end{equation*}
$$

Sketch of proof. The proof of Lemmas 3.5-3.6 follows by direct computation, using integration by parts, with $v_{x}(\xi)=0$ and $v( \pm \infty)=v_{x}( \pm \infty)=v_{x x}( \pm \infty)=0$. See [7] (also [6]) to undersand the technique.

We can now connect the conservation laws.
Lemma 3.7 (Connection Between $E(\cdot)$ and $F(\cdot))$. Let $u \in L^{2}(\mathbb{R})$, with $y=\left(1-\partial_{x}^{2}\right) u \in \mathcal{M}^{+}(\mathbb{R})$, that satisfies (3.6) for some $z \in \mathbb{R}$. There exists $\varepsilon_{0}>0$ only depending on the speed $c$, such that if $0<\varepsilon<\varepsilon_{0}$, then it holds

$$
\begin{equation*}
M^{3}-\frac{1}{4} E(u) M+\frac{1}{72} F(u) \leq 0 \tag{3.28}
\end{equation*}
$$

Proof. The key is to show that $h \leq 18 M$ on $\mathbb{R}$. Note that by (3.9) we know that $18 M \geq c / 4$ and that Lemma 3.4 ensures that $\xi \in \Theta_{z}$ for $\varepsilon_{0}$ small enough. Let us set $\lambda=z-6.7, \mu=z+6.7$, and rewrite the function $h$ as

$$
h(x)=\left\{\begin{array}{l}
-v_{x x}-6 v_{x}+16 v, \quad x<\lambda \\
u-6 v_{x}+12 v, \quad \lambda<x<\xi \\
u+6 v_{x}+12 v, \quad \xi<x<\mu \\
-v_{x x}+6 v_{x}+16 v, \quad x>\mu
\end{array}\right.
$$

If $x \in \mathbb{R} \backslash \Theta_{z}$, using that $v_{x x}=4 v-u,(3.16)$ and (3.17), it holds

$$
h \leq\left|v_{x x}\right|+6\left|v_{x}\right|+16 v \leq u+32 v \leq \frac{c}{9} \leq 18 M
$$

If $\lambda<x<\xi$, then $v_{x} \geq 0$, and using that $u \leq 6 v$ on $\mathbb{R}$, we have

$$
h=u-6 v_{x}+12 v \leq 18 v
$$

If $\xi<x<\mu$, then $v_{x} \leq 0$, and similarly using that $u \leq 6 v$ on $\mathbb{R}$, we get

$$
h=u+6 v_{x}+12 v \leq 18 v
$$

Therefore, it holds

$$
\begin{equation*}
h(x) \leq 18 \max _{x \in \mathbb{R}} v(x)=18 M, \quad \forall x \in \mathbb{R} \tag{3.29}
\end{equation*}
$$

Now, combining (3.25), (3.27) and (3.29), we get

$$
F(u)-144 M^{3}=\int_{\mathbb{R}} h(x) g^{2}(x) d x \leq\|h\|_{L^{\infty}(\mathbb{R})} \int_{\mathbb{R}} g^{2}(x) d x \leq 18 M\left(E(u)-12 M^{2}\right),
$$

and we obtain the lemma.
Proof of Theorem 3.1. We argue as El Dika and Molinet in [4]. As noticed after the statement of the theorem, it suffices to prove (3.7) assuming that $u \in L^{2}(\mathbb{R})$ satisfies (3.1), (3.2) and (3.6). We recall that $M=v(\xi)=\max _{x \in \mathbb{R}} v(x)$ and we set $\delta=c / 6-M$. We first remark that if $\delta \leq 0$, combining (3.4) and (3.10), it holds

$$
\left\|u-\varphi_{c}(\cdot-\xi)\right\|_{\mathcal{H}} \leq\left|E\left(u_{0}\right)-E\left(\varphi_{c}\right)\right|^{1 / 2} \leq O(\varepsilon)
$$

that yields the desired result. Now suppose that $\delta>0$, that is the maximum of the function $v$ is less than the maximum of $\rho_{c}$. Combining (3.4), (3.5) and (3.28), we get

$$
M^{3}-\frac{1}{4} E\left(\varphi_{c}\right) M+\frac{1}{72} F\left(\varphi_{c}\right) \leq O\left(\varepsilon^{2}\right)
$$

Using that $E\left(\varphi_{c}\right)=c^{2} / 3$ and $F\left(\varphi_{c}\right)=2 c^{3} / 3$, our inequality becomes

$$
\left(M-\frac{c}{6}\right)^{2}\left(M+\frac{c}{3}\right) \leq O\left(\varepsilon^{2}\right)
$$

Next, substituting $M$ by $c / 6-\delta$ and using that $[M+c / 3]^{-1}<3 / c$, we obtain

$$
\begin{equation*}
\delta^{2} \leq O\left(\varepsilon^{2}\right) \Rightarrow \delta \leq O(\varepsilon) \tag{3.30}
\end{equation*}
$$

Finally, combining (3.4), (3.10) and (3.30), we infer that

$$
\left\|u-\varphi_{c}(\cdot-\xi)\right\|_{\mathcal{H}} \leq C \sqrt{\varepsilon}
$$

where $C>0$ only depends on the speed $c$. This completes the proof of the stability of peakons.
