# A new bijection relating $q$-Eulerian polynomials

#### Abstract

On the set of permutations of a finite set, we construct a bijection which maps the 3 -vector of statistics (maj - exc, des, exc) to a 3 -vector ( $\mathrm{maj}_{2}, \widetilde{\operatorname{des}_{2}}, \operatorname{inv}_{2}$ ) associated with the $q$-Eulerian polynomials introduced by Shareshian and Wachs in Chromatic quasisymmetric functions, arXiv:1405.4269(2014).


Keywords: $q$-Eulerian polynomials, descents, ascents, major index, exceedances, inversions.

## Notations

For all pair of integers $(n, m)$ such that $n<m$, the set $\{n, n+1, \ldots, m\}$ is indifferently denoted by $[n, m],] n-1, m],[n, m+1[$ or $] n-1, m+1[$.

The set of positive integers $\{1,2,3, \ldots\}$ is denoted by $\mathbb{N}_{>0}$.
5 For all integer $n \in \mathbb{N}_{>0}$, we denote by $[n]$ the set $[1, n]$ and by $\mathfrak{S}_{n}$ the set of the permutations of $[n]$. By abuse of notation, we assimilate every $\sigma \in \mathfrak{S}_{n}$ with the word $\sigma(1) \sigma(2) \ldots \sigma(n)$.

If a set $S=\left\{n_{1}, n_{2}, \ldots, n_{k}\right\}$ of integers is such that $n_{1}<n_{2}<\ldots<n_{k}$, we sometimes use the notation $S=\left\{n_{1}<n_{2}<\ldots<n_{k}\right\}$.

## 1. Introduction

Let $n$ be a positive integer and $\sigma \in \mathfrak{S}_{n}$. A descent (respectively exceedance point) of $\sigma$ is an integer $i \in[n-1]$ such that $\sigma(i)>\sigma(i+1)($ resp. $\sigma(i)>i)$. The set of descents (resp. exceedance points) of $\sigma$ is denoted by $\operatorname{DES}(\sigma)$ (resp. $\operatorname{EXC}(\sigma))$ and its cardinal by $\operatorname{des}(\sigma)$ (resp. $\operatorname{exc}(\sigma))$. The integers $\sigma(i)$ with

It is due to MacMahon Mac15 and Riordan Rio58 that

where $A_{n}(t)$ is the $n$-th Eulerian polynomial Eul55. A statistic equidistributed with des or exc is said to be Eulerian. The statistic ides defined by $\operatorname{ides}(\sigma)=$ $\operatorname{des}\left(\sigma^{-1}\right)$ obviously is Eulerian.

The major index of a permutation $\sigma \in \mathfrak{S}_{n}$ is defined as

$$
\operatorname{maj}(\sigma)=\sum_{i \in \operatorname{DES}(\sigma)} i
$$

It is also due to MacMahon that

$$
\sum_{\sigma \in \mathfrak{S}_{n}} q^{\operatorname{maj}(\sigma)}=\prod_{i=1}^{n} \frac{1-q^{i}}{1-q}
$$

A statistic equidistributed with maj is said to be Mahonian. Among Mahonian - statistics is the statistic inv, defined by $\operatorname{inv}(\sigma)=|\operatorname{INV}(\sigma)|$ where $\operatorname{INV}(\sigma)$ is the set of inversions of a permutation $\sigma \in \mathfrak{S}_{n}$, i.e. the pairs of integers $(i, j) \in[n]^{2}$ such that $i<j$ and $\sigma(i)>\sigma(j)$.

In [SW14], the authors consider analogous versions of the above statistics : let $\sigma \in \mathfrak{S}_{n}$, the set of 2 -descents (respectively 2 -inversions) of $\sigma$ is defined as

$$
\operatorname{DES}_{2}(\sigma)=\{i \in[n-1], \sigma(i)>\sigma(i+1)+1\}
$$

(resp.

$$
\left.\operatorname{INV}_{2}(\sigma)=\{1 \leq i<j \leq n, \sigma(i)=\sigma(j)+1\}\right)
$$

and its cardinal is denoted by $\operatorname{des}_{2}(\sigma)\left(\operatorname{resp} . \operatorname{inv}_{2}(\sigma)\right)$.

It is easy to see that $\operatorname{inv}_{2}(\sigma)=\operatorname{ides}(\sigma)$. The 2-major index of $\sigma$ is defined as

$$
\operatorname{maj}_{2}(\sigma)=\sum_{i \in \operatorname{DES}_{2}(\sigma)} i .
$$

By using quasisymmetric function techniques, the authors of [SW14 proved the equality

$$
\begin{equation*}
\sum_{\sigma \in \mathfrak{S}_{n}} x^{\operatorname{maj}_{2}(\sigma)} y^{\operatorname{inv}_{2}(\sigma)}=\sum_{\sigma \in \mathfrak{G}_{n}} x^{\operatorname{maj}(\sigma)-\operatorname{exc}(\sigma)} y^{\operatorname{exc}(\sigma)} . \tag{1}
\end{equation*}
$$

Similarly, by using the same quasisymmetric function method as in [SW14], the authors of HL12 proved the equality

$$
\begin{equation*}
\sum_{\sigma \in \mathfrak{S}_{n}} x^{\operatorname{amaj}_{2}(\sigma)} y^{\widetilde{\operatorname{asc}_{2}}(\sigma)} z^{\operatorname{ides}(\sigma)}=\sum_{\sigma \in \mathfrak{S}_{n}} x^{\operatorname{maj}(\sigma)-\operatorname{exc}(\sigma)} y^{\operatorname{des}(\sigma)} z^{\operatorname{exc}(\sigma)} \tag{2}
\end{equation*}
$$

where $\operatorname{asc}_{2}(\sigma)$ is the number of 2-ascents of a permutation $\sigma \in \mathfrak{S}_{n}$, i.e. the elements of the set $\mathrm{ASC}_{2}(\sigma)=\{i \in[n-1], \sigma(i)<\sigma(i+1)+1\}$, which rises the statistic amaj ${ }_{2}$ defined by

$$
\operatorname{amaj}_{2}(\sigma)=\sum_{i \in \mathrm{ASC}_{2}(\sigma)} i,
$$

and where

$$
\widetilde{\operatorname{asc}_{2}}(\sigma)= \begin{cases}\operatorname{asc}_{2}(\sigma) & \text { if } \sigma(1)=1 \\ \operatorname{asc}_{2}(\sigma)+1 & \text { if } \sigma(1) \neq 1\end{cases}
$$

Definition 1.1. Let $\sigma \in \mathfrak{S}_{n}$. We consider the smallest 2-descent $d_{2}(\sigma)$ of $\sigma$ such that $\sigma(i)=i$ for all $i \in\left[d_{2}(\sigma)-1\right]$ (if there is no such 2-descent, we define $d_{2}(\sigma)$ as 0 and $\sigma(0)$ as $\left.n+1\right)$.

Now, let $d_{2}^{\prime}(\sigma)>d_{2}(\sigma)$ be the smallest 2-descent of $\sigma$ greater than $d_{2}(\sigma)$ (if there is no such 2-descent, we define $d_{2}^{\prime}(\sigma)$ as $\left.n\right)$.

We define an inductive property $\mathcal{P}\left(d_{2}(\sigma)\right)$ by :

1. $\sigma\left(d_{2}(\sigma)\right)<\sigma(i)$ for all $(i, j) \in \operatorname{INV}_{2}(\sigma)$ such that $d_{2}(\sigma)<i<d_{2}^{\prime}(\sigma)$;
2. if $\left(d_{2}^{\prime}(\sigma), j\right) \in \operatorname{INV}_{2}(\sigma)$ for some $j$, then either $\sigma\left(d_{2}(\sigma)\right)<\sigma\left(d_{2}^{\prime}(\sigma)\right)$, or $d_{2}^{\prime}(\sigma)$ has the property $\mathcal{P}\left(d_{2}^{\prime}(\sigma)\right)$ (where the role of $d_{2}(\sigma)$ is played by $d_{2}^{\prime}(\sigma)$ and that of $d_{2}^{\prime}(\sigma)$ by $d_{2}^{\prime \prime}(\sigma)$ where $d_{2}^{\prime \prime}(\sigma)>d_{2}^{\prime}(\sigma)$ is the smallest 2-descent of $\sigma$ greater than $d_{2}^{\prime}(\sigma)$, defined as $n$ if there is no such 2-descent).

This property is well-defined because $(n, j) \notin \operatorname{INV}_{2}(\sigma)$ for all $j \in[n]$.
Finally, we define a statistic $\widetilde{\operatorname{des}_{2}}$ by :

\widetilde{\operatorname{des}_{2}}(\sigma)= \begin{cases}\operatorname{des}_{2}(\sigma) & \text { if the property } \mathcal{P}\left(d_{2}(\sigma)\right) \text { is true } \\ \operatorname{des}_{2}(\sigma)+1 & \text { otherwise }\end{cases}
$$

In the present paper, we prove the following theorem.
Theorem 1.2. There exists a bijection $\varphi: \mathfrak{S}_{n} \rightarrow \mathfrak{S}_{n}$ such that

$$
\left(\operatorname{maj}_{2}(\sigma), \widetilde{\operatorname{des}_{2}}(\sigma), \operatorname{inv}_{2}(\sigma)\right)=(\operatorname{maj}(\varphi(\sigma))-\operatorname{exc}(\varphi(\sigma)), \operatorname{des}(\varphi(\sigma)), \operatorname{exc}(\varphi(\sigma)))
$$

As a straight corollary of Theorem 1.2 we obtain the equality

$$
\begin{equation*}
\sum_{\sigma \in \mathfrak{S}_{n}} x^{\operatorname{maj}_{2}(\sigma)} y^{\widetilde{\operatorname{des}_{2}}(\sigma)} z^{\operatorname{inv}_{2}(\sigma)}=\sum_{\sigma \in \mathfrak{S}_{n}} x^{\operatorname{maj}(\sigma)-\operatorname{exc}(\sigma)} y^{\operatorname{des}(\sigma)} z^{\operatorname{exc}(\sigma)} \tag{3}
\end{equation*}
$$

which implies Equality (1).
The rest of this paper is organised as follows.

In Section 4, we prove that $\varphi$ is bijective by constructing $\varphi^{-1}$.

## 2. Graphical representations

### 2.1. Linear graph

Let $\sigma \in \mathfrak{S}_{n}$. The linear graph of $\sigma$ is a graph whose vertices are (from left to right) the integers $\sigma(1), \sigma(2), \ldots, \sigma(n)$ aligned in a row, where every $\sigma(k)$ (for $\left.k \in \operatorname{DES}_{2}(\sigma)\right)$ is boxed, and where an arc of circle is drawn from $\sigma(i)$ to $\sigma(j)$ for every $(i, j) \in \operatorname{INV}_{2}(\sigma)$.

For example, the permutation $\sigma=34251 \in \mathfrak{S}_{5}$ (such that $\left.\left(\operatorname{maj}_{2}(\sigma), \widetilde{\operatorname{des}_{2}}(\sigma), \operatorname{inv}_{2}(\sigma)\right)=(6,3,2)\right)$ has the linear graph depicted in Figure 1


Figure 1: Linear graph of $\sigma=34251 \in \mathfrak{S}_{5}$.

### 2.2. Planar graph

Let $\tau \in \mathfrak{S}_{n}$. The planar graph of $\tau$ is a graph whose vertices are the integers $1,2, \ldots, n$, organized in ascending and descending slopes (the height of each vertex doesn't matter) such that the $i$-th vertex (from left to right) is the integer $\tau(i)$, and where every vertex $\tau(i)$ with $i \in \operatorname{EXC}(\tau)$ is encircled.

For example, the permutation $\tau=32541 \in \mathfrak{S}_{5}$ (such that $(\operatorname{maj}(\tau)-\operatorname{exc}(\tau), \operatorname{des}(\tau), \operatorname{exc}(\tau))=(6,3,2))$ has the planar graph depicted in Figure 2.


Figure 2: Planar graph of $\tau=32541 \in \mathfrak{S}_{5}$.

## 3. Definition of the map $\varphi$ of Theorem 1.2

Let $\sigma \in \mathfrak{S}_{n}$. We set $(r, s)=\left(\operatorname{des}_{2}(\sigma), \operatorname{inv}_{2}(\sigma)\right)$, and

$$
\begin{aligned}
\operatorname{DES}_{2}(\sigma) & =\left\{d_{2}^{k}(\sigma), k \in[r]\right\} \\
\operatorname{INV}_{2}(\sigma) & =\left\{\left(i_{l}(\sigma), j_{l}(\sigma)\right), l \in[s]\right\}
\end{aligned}
$$

${ }^{65}$ with $d_{2}^{k}(\sigma)<d_{2}^{k+1}(\sigma)$ for all $k$ and $i_{l}(\sigma)<i_{l+1}(\sigma)$ for all $l$.
We intend to define $\varphi(\sigma)$ by constructing its planar graph. To do so, we first construct (in Subsection 3.1) a graph $\mathcal{G}(\sigma)$ made of $n$ circles or dots organized in ascending or descending slopes such that two consecutive vertices are necessarily in a same descending slope if the first vertex is a circle and the second vertex
integers $1,2, \ldots, n$ in such a way that, if $y_{i}$ is the label of the $i$-th vertex $v_{i}(\sigma)$ (from left to right) of $\mathcal{G}(\sigma)$ for all $i \in[n]$, then :

1. $y_{i}<y_{i+1}$ if and only if $v_{i}$ and $v_{i+1}$ are in a same ascending slope;
2. $y_{i}>i$ if and only if $v_{i}$ is a circle.

The permutation $\tau=\varphi(\sigma)$ will then be defined as $y_{1} y_{2} \ldots y_{n}$, i.e. the permutation whose planar graph is the labelled graph $\mathcal{G}(\sigma)$.

With precision, we will obtain

$$
\tau(\operatorname{EXC}(\tau))=\left\{j_{k}(\sigma), k \in[s]\right\}
$$

(in particular $\operatorname{exc}(\tau)=s=\operatorname{inv}_{2}(\sigma)$ ), and

$$
\operatorname{DES}(\tau)=\left\{\begin{array}{l}
\left\{d^{k}(\sigma), k \in[1, r]\right\} \text { if } \widetilde{\operatorname{des}_{2}}(\sigma)=r \\
\left\{d^{k}(\sigma), k \in[0, r]\right\} \text { if } \widetilde{\operatorname{des}_{2}(\sigma)}=r+1
\end{array}\right.
$$

for integers $0 \leq d^{0}(\sigma)<d^{1}(\sigma)<\ldots<d^{r}(\sigma) \leq n$ (with $d^{0}(\sigma)=0 \Leftrightarrow \widetilde{\operatorname{des}_{2}}(\sigma)=$ $\left.\operatorname{des}_{2}(\sigma)\right)$ defined by

$$
d^{k}(\sigma)=d_{2}^{k}(\sigma)+c_{k}(\sigma)
$$

(with $d_{2}^{0}(\sigma):=0$ ) where $\left(c_{k}(\sigma)\right)_{k \in[0, r]}$ is a sequence defined in Subsection 3.1 such that $\sum_{k} c_{k}(\sigma)=\operatorname{inv}_{2}(\sigma)=\operatorname{exc}(\tau)$. Thus, we will obtain $\operatorname{des}(\tau)=\widetilde{\operatorname{des}_{2}}(\sigma)$ and $\operatorname{maj}(\tau)=\operatorname{maj}_{2}(\sigma)+\operatorname{exc}(\tau)$.

### 3.1. Construction of the unlabelled graph $\mathcal{G}(\sigma)$

We set $\left(d_{2}^{0}(\sigma), \sigma\left(d_{2}^{0}(\sigma)\right)\right)=(0, n+1)$ and $\left(d_{2}^{r+1}(\sigma), \sigma(n+1)\right)=(n, 0)$.
For all $k \in[r]$, we define the top $t_{k}(\sigma)$ of the 2 -descent $d_{2}^{k}(\sigma)$ as

$$
\begin{equation*}
t_{k}(\sigma)=\min \left\{d_{2}^{l}(\sigma), 1 \leq l \leq k, d_{2}^{l}(\sigma)=d_{2}^{k}(\sigma)-(k-l)\right\} \tag{4}
\end{equation*}
$$

in other words $t_{k}(\sigma)$ is the smallest 2-descent $d_{2}^{l}(\sigma)$ such that the 2-descents $d_{2}^{l}(\sigma), d_{2}^{l+1}(\sigma), \ldots, d_{2}^{k}(\sigma)$ are consecutive integers.

The following algorithm provides a sequence $\left(c_{k}^{0}(\sigma)\right)_{k \in[0, r]}$ of nonnegative integers.

Algorithm 3.1. Let $I_{r}(\sigma)=\operatorname{INV}_{2}(\sigma)$. For $k$ from $r=\operatorname{des}_{2}(\sigma)$ down to 0 , we consider the set $S_{k}(\sigma)$ of sequences $\left(i_{k_{1}}(\sigma), i_{k_{2}}(\sigma), \ldots, i_{k_{m}}(\sigma)\right)$ such that :

1. $\left(i_{k_{p}}(\sigma), j_{k_{p}}(\sigma)\right) \in I_{k}(\sigma)$ for all $p \in[m]$;
2. $t_{k}(\sigma) \leq i_{k_{1}}(\sigma)<i_{k_{2}}(\sigma)<\ldots<i_{k_{m}}(\sigma)$;
3. $\sigma\left(i_{k_{1}}(\sigma)\right)<\sigma\left(i_{k_{2}}(\sigma)\right)<\ldots<\sigma\left(i_{k_{m}}(\sigma)\right)$.

The length of such a sequence is defined as $l=\sum_{p=1}^{m} n_{p}$ where $n_{p}$ is the number of consecutive 2-inversions whose beginning is $i_{k_{p}}$, i.e. the maximal number $n_{p}$ of 2-inversions $\left(i_{k_{p}^{1}}(\sigma), j_{k_{p}^{1}}(\sigma)\right),\left(i_{k_{p}^{2}}(\sigma), j_{k_{p}^{2}}(\sigma)\right), \ldots,\left(i_{k_{p}^{n_{p}}}(\sigma), j_{k_{p}^{n_{p}}}(\sigma)\right)$ such that
95 $k_{p}^{1}=k_{p}$ and $j_{k_{p}^{i}}(\sigma)=i_{k_{p}^{i+1}}(\sigma)$ for all $i$. If $I_{k}(\sigma) \neq \emptyset$, we consider the sequence $\left(i_{k_{1}^{\max }}(\sigma), i_{k_{2}^{\max }}(\sigma), \ldots, i_{k_{m}^{\max }}(\sigma)\right) \in I_{k}(\sigma)$ whose length $l^{\max }=\sum_{p=1}^{m} n_{p}^{\max }$ is maximal and whose elements $i_{k_{1}^{\max }}(\sigma), i_{k_{2}^{\max }}(\sigma), \ldots, i_{k_{m}^{\max }}(\sigma)$ also are maximal (as integers). Then,

- if $I_{k}(\sigma) \neq \emptyset$, we set $c_{k}^{0}(\sigma)=l^{\text {max }}$ and

$$
I_{k-1}(\sigma)=I_{k}(\sigma) \backslash\left(\cup_{p=1}^{m}\left\{\left(i_{k_{i}^{\max }}(\sigma), j_{k_{i}^{\max }}(\sigma)\right), i \in\left[n_{p}^{\max }\right]\right\}\right) ;
$$

- else we set $c_{k}^{0}(\sigma)=0$ and $I_{k-1}(\sigma)=I_{k}(\sigma)$.

Example 3.2. Consider the permutation $\sigma=549321867 \in \mathfrak{S}_{9}$, with $\operatorname{DES}_{2}(\sigma)=$ $\{3,7\}$ and $I_{2}(\sigma)=\operatorname{INV}_{2}(\sigma)=\{(1,2),(2,4),(3,7),(4,5),(5,6),(7,9)\}$. In Figure 3 are depicted the $\operatorname{des}_{2}(\sigma)+1=3$ steps $k \in\{2,1,0\}$ (at each step, the 2 -inversions of the maximal sequence are drawed in red then erased at the following step) :


Figure 3: Computation of $\left(c_{k}^{0}(\sigma)\right)_{k \in\left[0, \operatorname{des}_{2}(\sigma)\right]}$ for $\sigma=549321867 \in \mathfrak{S}_{9}$. will mean $I_{-1}(\sigma)=\emptyset\left(\right.$ recall that $d_{2}^{0}(\sigma)$ has been defined as 0$)$.
$\star$ If $k=\operatorname{des}_{2}(\sigma)=r$, the goal is to prove that $c_{r}^{0}(\sigma)<n-d_{2}^{r}(\sigma)$. Suppose there exists a sequence $\left(i_{k_{1}}(\sigma), i_{k_{2}}(\sigma), \ldots, i_{k_{m}}(\sigma)\right)$ of length $c_{r}^{0}(\sigma) \geq n-d_{2}^{r}(\sigma)$ with $t_{r}(\sigma) \leq i_{k_{1}}(\sigma)<i_{k_{2}}(\sigma)<\ldots<i_{k_{m}}(\sigma)$. In particular, there exist ${ }^{125} c_{r}^{0}(\sigma) \geq n-d_{2}^{r}(\sigma)$ 2-inversions $(i, j)$ such that $d_{2}^{r}(\sigma)<j$, which forces $c_{r}^{0}(\sigma)$ to equal $n-d_{2}^{r}(\sigma)$ and every $j>d_{2}^{r}(\sigma)$ to be the arrival of a 2-inversion $(i, j)$ such that $t_{r}(\sigma) \leq i$. In particular, this is true for $j=d_{2}^{r}(\sigma)+1$, which is absurd because $\sigma(i) \geq \sigma\left(d_{2}^{r}(\sigma)\right)>\sigma\left(d_{2}^{r}(\sigma)+1\right)+1$ for all $i \in\left[t_{r}(\sigma), d_{2}^{r}(\sigma)\right]$. Therefore $c_{r}^{0}(\sigma)<n-d_{2}^{r}(\sigma)$. Also, it is easy to see that every $i>d_{2}^{r}(\sigma)$ that is the beginning of a 2-inversion $(i, j)$ necessarily appears in the maximal sequence $\left(i_{k_{1}^{\max }}(\sigma), i_{k_{2}^{\max }}(\sigma), \ldots, i_{k_{m}^{\max }}(\sigma)\right)$ whose length defines $c_{r}^{0}(\sigma)$, hence $(i, j) \notin I_{r-1}(\sigma)$.
$\star$ Now, suppose that $c_{k}^{0}(\sigma) \leq d_{2}^{k+1}(\sigma)-d_{2}^{k}(\sigma)$ for some $k \in\left[\operatorname{des}_{2}(\sigma)\right]$ with
equality only if $c_{k+1}^{0}(\sigma)>0$, and that no 2-inversion $(i, j)$ with $d_{2}^{k}(\sigma)<i$ belongs to $I_{k-1}(\sigma)$.

If $t_{k-1}(\sigma)=t_{k}(\sigma)$ (i.e., if $\left.d_{2}^{k-1}(\sigma)=d_{2}^{k}(\sigma)-1\right)$, since $I_{k-1}(\sigma)$ does not contain any 2 -inversion $(i, j)$ with $d_{2}^{k}(\sigma)<i$, then $c_{k-1}^{0}(\sigma) \leq 1=d_{2}^{k}(\sigma)-$ $d_{2}^{k-1}(\sigma)$. Moreover, if $c_{k-1}^{0}(\sigma)=1$, then there exists a 2 -inversion $(i, j) \in$ $I_{k-1}(\sigma) \subset I_{k}(\sigma)$ such that $i \in\left[t_{k-1}(\sigma), d_{2}^{k}(\sigma)\right]$. Consequently (i) was a legit sequence for the computation of $c_{k}^{0}(\sigma)$ at the previous step (because $t_{k}(\sigma)=$ $\left.t_{k-1}(\sigma)\right)$, which implies $c_{k}^{0}(\sigma)$ equals at least the length of $(i)$. In particular $c_{k}^{0}(\sigma)>0$.

Else, consider a sequence $\left(i_{k_{1}}(\sigma), i_{k_{2}}(\sigma), \ldots, i_{k_{m}}(\sigma)\right)$ that fits the three conditions of Algorithm 3.1 at the step $k-1$. In particular $t_{k-1}(\sigma) \leq i_{k_{1}}(\sigma)$. Also $i_{k_{m}}(\sigma) \leq d_{2}^{k}(\sigma)$ by hypothesis. Since $\sigma\left(i_{k_{p}}(\sigma)\right)<\sigma\left(i_{k_{p+1}}(\sigma)\right)$ for all $p$, and since $\sigma\left(t_{k-1}(\sigma)\right)>\sigma\left(t_{k-1}(\sigma)+1\right)>\ldots>\sigma\left(d_{2}^{k-1}(\sigma)\right)>\sigma\left(d_{2}^{k-1}(\sigma)+1\right)$, then only one element of the set $\left[t_{k-1}(\sigma), d_{2}^{k-1}(\sigma)+1\right]$ may equal $i_{k_{p}}(\sigma)$ for some $p \in[m]$. Thus, the length $l$ of the sequence verifies $l \leq d_{2}^{k}(\sigma)-d_{2}^{k-1}(\sigma)$, with equality only if $i_{k_{m}}(\sigma)=d_{2}^{k}(\sigma)$ (which implies $c_{k}^{0}(\sigma)>0$ as in the previous paragraph). In particular, this is true for $l=c_{k-1}^{0}(\sigma)$.

Finally, as for $k=\operatorname{des}_{2}(\sigma)$, every $i \in\left[d_{2}^{k-1}(\sigma)+1, d_{2}^{k}(\sigma)\right]$ that is the beginning of a 2-inversion $(i, j)$ necessarily appears in the maximal sequence $\left(i_{k_{1}^{\max }}(\sigma), i_{k_{2}^{\max }}(\sigma), \ldots, i_{k_{m}^{\max }}(\sigma)\right)$ whose length defines $c_{k-1}^{0}(\sigma)$, hence $(i, j) \notin$ $I_{k-2}(\sigma)$.

So the lemma is true by induction.

Definition 3.4. We define a graph $\mathcal{G}^{0}(\sigma)$ made of circles and dots organised in ascending or descending slopes, by plotting :

- for all $k \in[0, r]$, an ascending slope of $c_{k}^{0}(\sigma)$ circles such that the first circle has abscissa $d_{2}^{k}(\sigma)+1$ and the last circle has abscissa $d_{2}^{k}(\sigma)+c_{k}^{0}(\sigma)$ (if $c_{k}^{0}(\sigma)=0$, we plot nothing). All the abscissas are distinct because

$$
d_{2}^{0}(\sigma)+c_{0}<d_{2}^{1}(\sigma)+c_{1}<\ldots<d_{2}^{r}(\sigma)+c_{r}
$$

in view of Lemma 3.3 ,

- dots at the remaining $n-s=n-\operatorname{inv}_{2}(\sigma)$ abscissas from 1 to $n$, in ascending and descending slopes with respect to the descents and ascents of the word $\omega(\sigma)$ defined by

$$
\begin{equation*}
\omega(\sigma)=\sigma\left(u_{1}(\sigma)\right) \sigma\left(u_{2}(\sigma)\right) \ldots \sigma\left(u_{n-s}(\sigma)\right) \tag{5}
\end{equation*}
$$

where

$$
\left\{u_{1}(\sigma)<u_{2}(\sigma)<\ldots<u_{n-s}(\sigma)\right\}:=\mathfrak{S}_{n} \backslash\left\{i_{1}(\sigma)<i_{2}(\sigma)<\ldots<i_{s}(\sigma)\right\}
$$

Example 3.5. The permutation $\sigma_{0}=425736981 \in \mathfrak{S}_{9}$ (with $\operatorname{DES}_{2}\left(\sigma_{0}\right)=$ $\{1,4,8\}$ and $\left.\operatorname{INV}_{2}\left(\sigma_{0}\right)=\{(1,5),(2,9),(4,6),(7,8)\}\right)$, which yields the sequence $\left(c_{k}^{0}\left(\sigma_{0}\right)\right)_{k \in[0,3]}=(1,1,2,0)$ (see Figure 4 where all the 2 -inversions involved in the computation of a same $c_{k}^{0}\left(\sigma_{0}\right)$ are drawed in a same color) and the word $\omega\left(\sigma_{0}\right)=53681$, provides the unlabelled graph $\mathcal{G}^{0}\left(\sigma_{0}\right)$ depicted in Figure 5 .

The following lemma is easy.
Lemma 3.6. For all $i \in[n]$, if the $i$-th vertex (from left to right) $v_{i}^{0}(\sigma)$ of $\mathcal{G}^{0}(\sigma)$ is a dot and if $i$ is a descent of $\mathcal{G}^{0}(\sigma)$ (i.e., if $v_{i}^{0}(\sigma)$ and $v_{i+1}^{0}(\sigma)$ are two dots in a same descending slope) whereas $i \notin D E S_{2}(\sigma)$, let $k_{i}$ such that

$$
d_{2}^{k_{i}}(\sigma)+c_{k_{i}}^{0}(\sigma)<i<d_{2}^{k_{i}+1}(\sigma)
$$

Then :

1. $u_{p}(\sigma)$ is the greatest integer $u<d_{2}^{k_{i}+1}(\sigma)$ that is not the beginning of a 2-inversion of $\sigma$;
2. $u_{p+1}(\sigma)$ is the smallest integer $u>d_{2}^{k_{i}+1}(\sigma)$ that is not a 2-descent or the beginning of a 2-inversion of $\sigma$;
3. $c_{k}^{0}(\sigma)>0$ for all $k$ such that $d_{2}^{k_{i}+1}(\sigma) \leq d_{2}^{k}(\sigma) \leq u_{p+1}(\sigma)$.

In particular $c_{k_{i}+1}^{0}(\sigma)>0$.
Lemma 3.6 motivates the following definition.
Definition 3.7. For $i$ from 1 to $n-1$, let $k_{i} \in[0, r]$ such that

$$
d_{2}^{k_{i}}(\sigma)+c_{k_{i}}^{0}(\sigma)<i<d_{2}^{k_{i}+1}(\sigma)
$$

If $i$ fits the conditions of Lemma3.6. then we define a sequence $\left(c_{k}^{i}(\sigma)\right)_{k \in[0, r]}$ by

$$
\begin{aligned}
c_{k_{i}}^{i}(\sigma) & =c_{k_{i}}^{i-1}(\sigma)+1 \\
c_{k_{i}+1}^{i}(\sigma) & =c_{k_{i}+1}^{i-1}(\sigma)-1 \\
c_{k}^{i}(\sigma) & =c_{k}^{i-1}(\sigma) \text { for all } k \notin\left\{k_{i}, k_{i}+1\right\} .
\end{aligned}
$$

Else, we define $\left(c_{k}^{i}(\sigma)\right)_{k \in[0, r]}$ as $\left(c_{k}^{i-1}(\sigma)\right)_{k \in[0, r]}$.
The final sequence $\left(c_{k}^{n}(\sigma)\right)_{k \in[0, r]}$ is denoted by

$$
\left(c_{k}(\sigma)\right)_{k \in[0, r]}
$$

${ }_{175}$ By construction, and from Lemma 3.3. the sequence $\left(c_{k}(\sigma)\right)_{k \in[0, r]}$ has the same properties as $\left(c_{k}^{0}(\sigma)\right)_{k \in[0, r]}$ detailed in Lemma 3.3 .

Consequently, we may define an unlabelled graph

$$
\mathcal{G}(\sigma)
$$

by replacing $\left(c_{k}^{0}(\sigma)\right)_{k \in[0, r]}$ with $\left(c_{k}(\sigma)\right)_{k \in[0, r]}$ in Definition 3.4.


Figure 6: Graph $\mathcal{G}\left(\sigma_{0}\right)$.

Example 3.8. In the graph $\mathcal{G}^{0}(\sigma)$ depicted in Figure 5 where $\sigma_{0}=425736981 \in$ $\mathfrak{S}_{9}$, we can see that the dot $v_{3}^{0}\left(\sigma_{0}\right)$ is a descent whereas $3 \notin \mathrm{DES}_{2}\left(\sigma_{0}\right)$, hence, from the sequence $\left(c_{k}^{0}\left(\sigma_{0}\right)\right)_{k \in[0,3]}=(1,1,2,0)$, we compute $\left(c_{k}\left(\sigma_{0}\right)\right)_{k \in[0,3]}=$ $(1,2,1,0)$ and we obtain the graph $\mathcal{G}\left(\sigma_{0}\right)$ depicted in Figure 6 .

Let $v_{1}(\sigma), v_{2}(\sigma), \ldots, v_{n}(\sigma)$ be the $n$ vertices of $\mathcal{G}(\sigma)$ from left to right.
By construction, the descents of the unlabelled graph $\mathcal{G}(\sigma)$ (i.e., the integers $i \in[n-1]$ such that $v_{i}(\sigma)$ and $v_{i+1}(\sigma)$ are in a same descending slope) are the integers

$$
d^{k}(\sigma)=d_{2}^{k}(\sigma)+c_{k}(\sigma)
$$

for all $k \in[0, r]$.
3.2. Labelling of the graph $\mathcal{G}(\sigma)$

### 3.2.1. Labelling of the circles

We intend to label the circles of $\mathcal{G}(\sigma)$ with the integers

$$
j_{1}(\sigma), j_{2}(\sigma), \ldots, j_{s}(\sigma)
$$

Algorithm 3.9. For all $i \in[n]$, if the vertex $v_{i}(\sigma)$ is a circle (hence $i<n$ ), we label it first with the set

$$
[i+1, n] \cap\left\{j_{1}(\sigma), j_{2}(\sigma), \ldots, j_{s}(\sigma)\right\}
$$

Afterwards, if a circle $v_{i}(\sigma)$ is found in a descending slope such that there exists a quantity of $a$ circles above $v_{i}(\sigma)$, and in an ascending slope such that there exists a quantity of $b$ circles above $v_{i}(\sigma)$, then we remove the $a+b$ greatest integers from the current label of $v_{i}(\sigma)$ (this set necessarily had at least $a+b+1$
elements) and the smallest integer from every of the $a+b$ labels of the $a+b$ circles above $v_{i}(\sigma)$ in the two related slopes. At the end of this step, if an integer $j_{k}(\sigma)$ appears in only one label of a circle $v_{i}(\sigma)$, then we replace the label of $v_{i}(\sigma)$ with $j_{k}(\sigma)$.

Finally, we replace every label that is still a set by the unique integer it may contain with respect to the order of the elements in the sequence

$$
\left(j_{1}(\sigma), j_{2}(\sigma), \ldots, j_{s}(\sigma)\right)
$$

(from left to right).
Example 3.10. For $\sigma_{0}=425736981$ (see Figure 4) whose graph $\mathcal{G}\left(\sigma_{0}\right)$ is depicted in Figure6, we have $s=\operatorname{inv}_{2}(\sigma)=4$ and $\left\{j_{1}\left(\sigma_{0}\right), j_{2}\left(\sigma_{0}\right), j_{3}\left(\sigma_{0}\right), j_{4}\left(\sigma_{0}\right)\right\}=$ $\{5,6,8,9\}$, which provides first the graph labelled by sets depicted in Figure 7 . Afterwards, since the circle $v_{2}\left(\sigma_{0}\right)$ is in a descending slope with $a=1$ circle above it (the vertex $v_{1}\left(\sigma_{0}\right)$ ) and in an ascending slope with also $b=1$ circle above it (the vertex $v_{3}\left(\sigma_{0}\right)$ ), then we remove the $a+b=2$ integers 8 and 9 from its label, which becomes $\{5,6\}$, and we remove 5 from the labels of $v_{1}\left(\sigma_{0}\right)$ and $v_{3}\left(\sigma_{0}\right)$. Also, since the label of $v_{2}\left(\sigma_{0}\right)$ is the only set that contains 5 , then we label $v_{2}\left(\sigma_{0}\right)$ with 5 (see Figure 8). Finally, the sequence $\left(j_{1}\left(\sigma_{0}\right), j_{2}\left(\sigma_{0}\right), j_{3}\left(\sigma_{0}\right), j_{4}\left(\sigma_{0}\right)\right)=(5,9,6,8)$ gives the order (from left to right) of apparition of the remaining integers $6,8,9$ (see Figure 9 ).

### 3.2.2. Labelling of the dots

Let

$$
\left.\left.\left\{p_{1}(\sigma)<p_{2}(\sigma)<\ldots<p_{n-s}(\sigma)\right\}=[n] \backslash \bigsqcup_{k=0}^{r}\right] d_{2}^{k}(\sigma), d^{k}(\sigma)\right]
$$

We intend to label the dots $\left\{v_{p_{i}(\sigma)}(\sigma), i \in[n-s]\right\}$ of $\mathcal{G}(\sigma)$ with the elements of

$$
\left\{1=e_{1}(\sigma)<e_{2}(\sigma)<\ldots<e_{n-s}(\sigma)\right\}=[n] \backslash\left\{j_{1}(\sigma), j_{2}(\sigma), \ldots, j_{s}(\sigma)\right\}
$$

Algorithm 3.11. 1. For all $k \in[n-s]$, we label first the dot $v_{p_{k}(\sigma)}(\sigma)$ with the set

$$
\left[\min \left(p_{k}(\sigma), u_{k}(\sigma)\right)\right] \cap\left([n] \backslash\left\{j_{1}(\sigma), j_{2}(\sigma), \ldots, j_{s}(\sigma)\right\}\right)
$$

where $u_{1}(\sigma), u_{2}(\sigma), \ldots, u_{n-s}(\sigma)$ are the integers introduced in (5).
2. Afterwards, similarly as for the labelling of the circles, if a dot $v_{i}(\sigma)$ is found in a descending slope such that $a$ dots are above $v_{i}(\sigma)$, and in an ascending slope such that $b$ dots are above $v_{i}(\sigma)$, then we remove the $a+b$ greatest integers from the current label of $v_{i}(\sigma)$ and the smallest integer from every of the $a+b$ labels of the dots above $v_{i}(\sigma)$ in the two related slopes. At the end of this step, if an integer $l$ appears in only one label of a dot $v_{i}(\sigma)$, then we replace the label of $v_{i}(\sigma)$ with $l$.
3. Finally, for $k$ from 1 to $n-s$, let

$$
\begin{equation*}
w_{1}^{k}(\sigma)<w_{2}^{k}(\sigma)<\ldots<w_{q_{k}(\sigma)}^{k}(\sigma) \tag{6}
\end{equation*}
$$

such that

$$
\left\{p_{w_{i}^{k}(\sigma)}(\sigma), i\right\}=\left\{p_{i}(\sigma), e_{k}(\sigma) \text { appear in the label of } p_{i}(\sigma)\right\}
$$

and let $i(k) \in\left[q_{k}(\sigma)\right]$ such that

$$
\sigma\left(u_{w_{i(k)}^{k}(\sigma)}(\sigma)\right)=\min \left\{\sigma\left(u_{w_{i}^{k}(\sigma)}(\sigma)\right), i \in\left[q_{k}(\sigma)\right]\right\}
$$

Then, we replace the label of the dot $p_{w_{i(k)}^{k}(\sigma)}(\sigma)$ with the integer $e_{k}(\sigma)$ and we erase $e_{k}(\sigma)$ from any other label (and if an integer $l$ appears in only one label of a dot $v_{i}(\sigma)$, then we replace the label of $v_{i}(\sigma)$ with $\left.l\right)$.

Example 3.12. For $\sigma_{0}=425736981$ whose graph $\mathcal{G}\left(\sigma_{0}\right)$ has its circles labelled in Figure 9 , the sequence $\left(u_{1}\left(\sigma_{0}\right), u_{2}\left(\sigma_{0}\right), u_{3}\left(\sigma_{0}\right), u_{4}\left(\sigma_{0}\right), u_{5}\left(\sigma_{0}\right)\right)=(3,5,6,8,9)$ provides first the graph labelled by sets depicted in Figure 10 . The rest of the algorithm goes from $k=1$ to $n-s=9-4=5$.

- $k=1$ : in Figure 10, the integer $e_{1}\left(\sigma_{0}\right)=1$ appears in the labels of the $\operatorname{dots} v_{p_{1}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{4}\left(\sigma_{0}\right), v_{p_{2}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{6}\left(\sigma_{0}\right)$ and $v_{p_{5}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{9}\left(\sigma_{0}\right)$, so, from

$$
\left(\sigma_{0}\left(u_{1}\left(\sigma_{0}\right)\right), \sigma_{0}\left(u_{2}\left(\sigma_{0}\right)\right), \sigma_{0}\left(u_{5}\left(\sigma_{0}\right)\right)=(5,3,1)\right.
$$

we label the $\operatorname{dot} v_{p_{5}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{9}\left(\sigma_{0}\right)$ with the integer $e_{1}\left(\sigma_{0}\right)=1$ and we erase 1 from any other label, and since the integer 4 now only appears in the label of the dot $v_{7}\left(\sigma_{0}\right)$, then we label $v_{7}\left(\sigma_{0}\right)$ with 4 (see Figure 11 .

- $k=2$ : in Figure 11, the integer $e_{2}\left(\sigma_{0}\right)=2$ appears in the labels of the $\operatorname{dots} v_{p_{1}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{4}\left(\sigma_{0}\right)$ and $v_{p_{2}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{6}\left(\sigma_{0}\right)$ so, from

$$
\left(\sigma_{0}\left(u_{1}\left(\sigma_{0}\right)\right), \sigma_{0}\left(u_{2}\left(\sigma_{0}\right)\right)\right)=(5,3)
$$

we label the dot $v_{p_{2}\left(\sigma_{0}\right)}\left(\sigma_{0}\right)=v_{6}\left(\sigma_{0}\right)$ with the integer $e_{2}\left(\sigma_{0}\right)=2$ and we erase 2 from any other label, which provides the graph labelled by integers depicted in Figure 12

- The three steps $k=3,4,5$ change nothing because every dot of $\mathcal{G}\left(\sigma_{0}\right)$ is already labelled by an integer at the end of the previous step.

So the final version of the labelled graph $\mathcal{G}\left(\sigma_{0}\right)$ is the one depicted in Figure 12

### 3.3. Definition of $\varphi(\sigma)$

By construction of the labelled graph $\mathcal{G}(\sigma)$, the word $y_{1} y_{2} \ldots y_{n}$ (where the integer $y_{i}$ is the label of the vertex $v_{i}(\sigma)$ for all $i$ ) obviously is a permutation of the set $[n]$, whose planar graph is $\mathcal{G}(\sigma)$.

We define $\varphi(\sigma) \in \mathfrak{S}_{n}$ as this permutation.
For the example $\sigma_{0}=425736981 \in \mathfrak{S}_{9}$ whose labelled graph $\mathcal{G}\left(\sigma_{0}\right)$ is depicted in Figure 12 , we obtain $\varphi\left(\sigma_{0}\right)=956382471 \in \mathfrak{S}_{9}$.

In general, by construction of $\tau=\varphi(\sigma) \in \mathfrak{S}_{n}$, we have

$$
\begin{equation*}
\tau(\operatorname{EXC}(\tau))=\left\{j_{k}(\sigma), k \in\left[\operatorname{inv}_{2}(\sigma)\right]\right\} \tag{7}
\end{equation*}
$$

and

$$
\operatorname{DES}(\tau)= \begin{cases}\left\{d^{k}(\sigma), k \in\left[1, \operatorname{des}_{2}(\sigma)\right]\right\} & \text { if } c_{0}(\sigma)=0\left(\Leftrightarrow d^{0}(\sigma)=0\right)  \tag{8}\\ \left\{d^{k}(\sigma), k \in\left[0, \operatorname{des}_{2}(\sigma)\right]\right\} & \text { otherwise }\end{cases}
$$

Equality (7) provides

$$
\operatorname{exc}(\tau)=\operatorname{inv}_{2}(\sigma)
$$

By $d^{k}(\sigma)=d_{2}^{k}(\sigma)+c_{k}(\sigma)$ for all $k$, Equality (8) provides

$$
\operatorname{maj}(\tau)=\operatorname{maj}_{2}(\sigma)+\sum_{k \geq 0} c_{k}(\sigma)
$$

and by definition of $\left(c_{k}(\sigma)\right)_{k}$ and Lemma 3.3 we have $\sum_{k \geq 0} c_{k}(\sigma)=\sum_{k \geq 0} c_{k}^{0}(\sigma)=$ $\operatorname{inv}_{2}(\sigma)=\operatorname{exc}(\tau)$ hence

$$
\operatorname{maj}(\tau)-\operatorname{exc}(\tau)=\operatorname{maj}_{2}(\sigma)
$$

Finally, it is easy to see that $\widetilde{\operatorname{des}_{2}}(\sigma)=\operatorname{des}_{2}(\sigma)$ if and only if $c_{0}(\sigma)=0$, so Equality (8) also provides

$$
\operatorname{des}(\tau)=\widetilde{\operatorname{des}_{2}}(\sigma)
$$

As a conclusion, we obtain

$$
(\operatorname{maj}(\tau)-\operatorname{exc}(\tau), \operatorname{des}(\tau), \operatorname{exc}(\tau))=\left(\operatorname{maj}_{2}(\sigma), \widetilde{\operatorname{des}_{2}}(\sigma), \operatorname{inv}_{2}(\sigma)\right)
$$

as required by Theorem 1.2 .

## 4. Construction of $\varphi^{-1}$

To end the proof of Theorem 1.2, it remains to show that $\varphi: \mathfrak{S}_{n} \rightarrow \mathfrak{S}_{n}$ is surjective. Let $\tau \in \mathfrak{S}_{n}$. We introduce integers $r \geq 0, s=\operatorname{exc}(\tau)$, and

$$
0 \leq d^{0, \tau}<d^{1, \tau}<\ldots<d^{r, \tau}<n
$$

such that

$$
\begin{aligned}
\operatorname{DES}(\tau) & =\left\{d^{k, \tau}, k \in[0, r]\right\} \cap \mathbb{N}_{>0} \\
d^{0, \tau} & =0 \Leftrightarrow \tau(1)=1
\end{aligned}
$$

In particular $\operatorname{des}(\tau)= \begin{cases}r & \text { if } \tau(1)=1, \\ r+1 & \text { otherwise }\end{cases}$
For all $k \in[0, r]$, we define

$$
\begin{aligned}
c_{k}^{\tau} & \left.=\operatorname{EXC}(\tau) \cap] d^{k-1, \tau}, d^{k, \tau}\right]\left(\text { with } d^{-1, \tau}:=0\right) \\
d_{2}^{k, \tau} & =d^{k, \tau}-c_{k}^{\tau}
\end{aligned}
$$

We have

$$
0=d_{2}^{0, \tau}<d_{2}^{1, \tau}<\ldots<d_{2}^{r, \tau}<n
$$

and similarly as Formula 4, we define

$$
\begin{equation*}
t_{k}^{\tau}=\min \left\{d_{2}^{l, \tau}, 1 \leq l \leq k, d_{2}^{l, \tau}=d_{2}^{k, \tau}-(k-l)\right\} \tag{9}
\end{equation*}
$$

for all $k \in[r]$.
We intend to construct a graph $\mathcal{H}(\tau)$ which is the linear graph of permutation $\sigma \in \mathfrak{S}_{n}$ such that $\varphi(\sigma)=\tau$.

### 4.1. Skeleton of the graph $\mathcal{H}(\tau)$

We consider a graph $\mathcal{H}(\tau)$ whose vertices $v_{1}^{\tau}, v_{2}^{\tau}, \ldots, v_{n}^{\tau}$ (from left to right) are $n$ dots, aligned in a row, among which we box the $d_{2}^{k, \tau}$-th vertex $v_{d_{2}^{k, \tau}}^{\tau}$ for all $k \in[r]$. We also draw the end of an arc of circle above every vertex $v_{j}^{\tau}$ such that $j=\tau(i)$ for some $i \in \operatorname{EXC}(\tau)$.

For the example $\tau_{0}=956382471 \in \mathfrak{S}_{9}$ (whose planar graph is depicted in Figure 12), we have $r=\operatorname{des}\left(\tau_{0}\right)-1=3$ and

$$
\begin{aligned}
\left(c_{k}^{\tau_{0}}\right)_{k \in[0,3]} & =(1,2,1,0) \\
\left(d_{2}^{k, \tau_{0}}\right)_{k \in[0,3]} & =(1-1,3-2,5-1,8-0)=(0,1,4,8) \\
\tau_{0}\left(\operatorname{EXC}\left(\tau_{0}\right)\right) & =\{5,6,8,9\}
\end{aligned}
$$

and we obtain the graph $\mathcal{H}\left(\tau_{0}\right)$ depicted in Figure 13 .


Figure 13: Incomplete graph $\mathcal{H}\left(\tau_{0}\right)$.

 and $d^{k}(\sigma)$ (respectively $\left.c_{\sigma}(\sigma), d^{k}(\sigma), t(\sigma)\right)$ equals $d^{k, \tau}\left(\right.$ resp $\left.c^{\tau} d^{k, \tau}, \tau \tau\right)$ for all $k \in[0, r]$ and $\left\{j_{l}(\sigma), l \in\left[\operatorname{inv}_{2}(\sigma)\right]\right\}=\tau(\operatorname{EXC}(\tau))$. Consequently, the linear graph of $\sigma$ necessarily have the same skeleton as that of $\mathcal{H}(\tau)$.The following lemma is easy.
${ }_{255}$ Lemma 4.1. If $\tau=\varphi(\sigma)$ for some $\sigma \in \mathfrak{S}_{n}$, then:

1. If $j=\tau(l)$ with $l \in E X C(\tau)$ such that $\left.l \in] d_{2}^{k, \tau}, d^{k, \tau}\right]$, and if $(i, j) \in$ $I N V_{2}(\sigma)$, then $t_{k}^{\tau} \leq i$.
2. A pair $(i, i+1)$ cannot be a 2-inversion of $\sigma$ if $i \in D E S_{2}(\sigma)$ ( $\Leftrightarrow$ if the vertex $v_{i}^{\tau}$ of $\mathcal{H}(\tau)$ is boxed).
3. For all pair $\left(l, l^{\prime}\right) \in E X C(\tau)^{2}$, if the labels of the two circles $v_{l}(\sigma)$ and $v_{l^{\prime}}(\sigma)$ can be exchanged without modifying the skeleton of $\mathcal{G}(\sigma)$, let $i$ and $i^{\prime}$ such that $(i, l) \in I N V_{2}(\sigma)$ and $\left(i^{\prime}, l^{\prime}\right) \in I N V_{2}(\sigma)$, then $i<i^{\prime} \Leftrightarrow l<l^{\prime}$.

Consequently, in order to construct the linear graph of a permutation $\sigma \in \mathfrak{S}_{n}$ such that $\tau=\varphi(\sigma)$ from $\mathcal{H}(\tau)$, it is necessary to extend the arcs of circles of $\mathcal{H}(\tau)$ to reflect the three facts of Lemma 4.1. When a vertex is necessarily the beginning of an arc of circle, we draw the beginning of an arc of circle above it.

When there is only one vertex $v_{i}^{\tau}$ that can be the beginning of an arc of circle, we complete the latter by making it start from $v_{i}^{\tau}$.

Example 4.2. For $\tau_{0}=956382471 \in \mathfrak{S}_{9}$, the graph $\mathcal{H}\left(\tau_{0}\right)$ becomes as depicted in Figure 14 Note that the arc of circle ending at $v_{6}^{\tau_{0}}$ cannot begin at $v_{5}^{\tau_{0}}$ because


Figure 14: Incomplete graph $\mathcal{H}\left(\tau_{0}\right)$.
otherwise, from the third point of Lemma 4.1 and since $(6,8)=\left(\tau_{0}(l), \tau_{0}\left(l^{\prime}\right)\right)$ with $3=l<l^{\prime}=5$, it would force the arc of circle ending at $v_{8}^{\tau_{0}}$ to begin at $v_{i^{\prime}}^{\tau_{0}}$ with $6 \leq i^{\prime}$, which is absurd because a permutation $\sigma \in \mathfrak{S}_{9}$ whose linear graph would be of the kind $\mathcal{H}\left(\tau_{0}\right)$ would have $c_{2}(\sigma)=2 \neq 1=c_{2}^{\tau_{0}}$. Also, still in view of the third point of Lemma 4.1, and since $\tau_{0}^{-1}(9)<\tau^{-1}(6)$, the arc of circle ending at $v_{9}^{\tau_{0}}$ must start before the arc of circle ending at $v_{6}^{\tau_{0}}$, hence the configuration of $\mathcal{H}\left(\tau_{0}\right)$ in Figure 14 .

The following two facts are obvious.
Facts 4.3. If $\tau=\varphi(\sigma)$ for some $\sigma \in \mathfrak{S}_{n}$, then :

1. A vertex $v_{i}^{\tau}$ of $\mathcal{H}(\tau)$ is boxed if and only if $i \in \operatorname{DES}_{2}(\sigma)$. In that case, in particular $i$ is a descent of $\sigma$.
2. If a pair $(i, i+1)$ is not a 2 -descent of $\sigma$ and if $v_{i}^{\tau}$ is not boxed, then $i$ is an ascent of $\sigma$, i.e. $\sigma(i)<\sigma(i+1)$.

To reflect Facts 4.3 we draw an ascending arrow (respectively a descending arrow) between the vertices $v_{i}^{\tau}$ and $v_{i+1}^{\tau}$ of $\mathcal{H}(\tau)$ whenever it is known that $\sigma(i)<\sigma(i+1)($ resp. $\sigma(i)>\sigma(i+1))$ for all $\sigma \in \mathfrak{S}_{n}$ such that $\varphi(\sigma)=\tau$.

For the example $\tau_{0}=956382471 \in \mathfrak{S}_{9}$, the graph $\mathcal{H}\left(\tau_{0}\right)$ becomes as depicted in Figure 15. Note that it is not known yet if there is an ascending or descending arrow between $v_{7}^{\tau_{0}}$ and $v_{8}^{\tau_{0}}$.


Figure 15: Incomplete graph $\mathcal{H}\left(\tau_{0}\right)$.

### 4.2. Completion and labelling of $\mathcal{H}(\tau)$

The following lemma is analogous to the third point of Lemma 4.1 for the dots instead of the circles and follows straightly from the definition of $\varphi(\sigma)$ for all $\sigma \in \mathfrak{S}_{n}$.

Lemma 4.4. Let $\sigma \in \mathfrak{S}_{n}$ such that $\varphi(\sigma)=\tau$. For all pair $\left(l, l^{\prime}\right) \in([n] \backslash E X C(\tau))^{2}$, if the labels of the two dots $v_{l}(\sigma)$ and $v_{l^{\prime}}(\sigma)$ can be exchanged without modifying the skeleton of $\mathcal{G}(\sigma)$, let $k$ and $k^{\prime}$ such that $l=p_{k}(\sigma)$ and $l^{\prime}=p_{k^{\prime}}(\sigma)$, then $\tau(l)<\tau\left(l^{\prime}\right) \Leftrightarrow \sigma\left(u_{k}(\sigma)\right)<\sigma\left(u_{k^{\prime}}(\sigma)\right)$.

Now, the ascending and descending arrows between the vertices of $\mathcal{H}(\tau)$ introduced earlier, and Lemma 4.4, induce a partial order on the set $\left\{v_{i}^{\tau}, i \in[n]\right\}$ :

Definition 4.5. We define a partial order $\succ$ on $\left\{v_{i}^{\tau}, i \in[n]\right\}$ by :

- $v_{i}^{\tau} \prec v_{i+1}^{\tau}$ (resp. $v_{i}^{\tau} \succ v_{i+1}^{\tau}$ ) if there exists an ascending (resp. descending) arrow between $v_{i}^{\tau}$ and $v_{i+1}^{\tau}$;
- $v_{i}^{\tau} \succ v_{j}^{\tau}$ (with $i<j$ ) if there exists an arc of circle from $v_{i}^{\tau}$ to $v_{j}^{\tau}$;
- if two vertices $v_{i}^{\tau}$ and $v_{j}^{\tau}$ are known to be respectively the $k$-th and $k^{\prime}$-th vertices of $\mathcal{H}(\tau)$ that cannot be the beginning of a complete arc of circle, let $l$ and $l^{\prime}$ be respectively the $k$-th and $k^{\prime}$-th non-exceedance point of $\tau$ (from left to right), if $\left(l, l^{\prime}\right)$ fits the conditions of Lemma 4.4 then we set $v_{i}^{\tau} \prec v_{j}^{\tau}\left(\right.$ resp. $\left.v_{i}^{\tau} \succ v_{j}^{\tau}\right)$ if $\tau(l)<\tau\left(l^{\prime}\right)\left(\right.$ resp. $\left.\tau(l)>\tau\left(l^{\prime}\right)\right)$.

Example 4.6. For the example $\tau_{0}=956382471$, according to the first point of Definition 4.5, the arrows of Figure 15 provide

$$
v_{1}^{\tau_{0}} \succ v_{2}^{\tau_{0}} \prec v_{3}^{\tau_{0}} \prec v_{4}^{\tau_{0}} \succ v_{5}^{\tau_{0}} \prec v_{6}^{\tau_{0}} \prec v_{7}^{\tau_{0}}
$$

and

$$
v_{8}^{\tau_{0}} \succ v_{9}^{\tau_{0}} .
$$

Definition 4.7. A vertex $v_{i}^{\tau}$ of $\mathcal{H}(\tau)$ is said to be minimal on a subset $S \subset[n]$
if $v_{i}^{\tau} \nsucc v_{j}^{\tau}$ for all $j \in S$.

Let

$$
1=e_{1}^{\tau}<e_{2}^{\tau}<\ldots<e_{n-s}^{\tau}
$$

be the non-exceedance values of $\tau$ (i.e., the labels of the dots of the planar graph of $\tau)$.

Algorithm 4.8. Let $S=[n]$ and $l=1$. While the vertices $\left\{v_{i}^{\tau}, i \in[n]\right\}$ have not all been labelled with the elements of $[n]$, apply the following algorithm.

1. If there exists a unique minimal vertex $v_{i}^{\tau}$ of $\tau$ on $S$, we label it with $l$, then we set $l:=l+1$ and $S:=S \backslash\left\{v_{i}^{\tau}\right\}$. Afterwards,
(a) If $v_{i}^{\tau}$ is the ending of an arc of circle starting from a vertex $v_{j}^{\tau}$, then we label $v_{j}^{\tau}$ with the integer $l$ and we set $l:=l+1$ and $S:=S \backslash\left\{v_{j}^{\tau}\right\}$.
(b) If $v_{i}^{\tau}$ is the arrival of an incomplete arc of circle (in particular $i=\tau(l)$ for some $l \in \operatorname{EXC}(\tau))$, we intend to complete the arc by making it start from a vertex $v_{j}^{\tau}$ for some integer $j \in\left[t_{k}^{\tau}, j[\right.$ (where $l \in$ $\left.] d_{2}^{k, \tau}, d^{k, \tau}\right]$ ) in view of the first point of Lemma 4.1. We choose $v_{j}^{\tau}$ as the rightest minimal vertex on $\left[t_{k}^{\tau}, j[\cap S\right.$ from which it may start in view of the third point of Lemma 4.1, and we label this vertex $v_{j}^{\tau}$ with the integer $l$. Then we set $l:=l+1$ and $S:=S \backslash\left\{v_{j}^{\tau}\right\}$.

Now, if there exists an arc of circle from $v_{j}^{\tau}$ (for some $j$ ) to $v_{i}^{\tau}$, we apply steps (a), (b) and (c) to the vertex $v_{j}^{\tau}$ in place of $v_{i}^{\tau}$.
2. Otherwise, let $k \geq 0$ be the number of vertices $v_{i}^{\tau}$ that have already been labelled and that are not the beginning of an arc of circles. Let

$$
l_{1}<l_{2}<\ldots<l_{q}
$$

be the integers $l \in[n]$ such that $l \geq \tau(j) \geq e_{k+1}^{\tau}$ and such that we can exchange the labels of dots $\tau(l)$ and $e_{k+1}^{\tau}$ in the planar graph of $\tau$ without
modifying the skeleton of the graph. It is easy to see that $q$ is precisely the number of minimal vertices of $\tau$ on $S$. Let $l_{i_{k+1}}=\tau^{-1}\left(e_{k+1}^{\tau}\right)$ and let $v_{j}^{\tau}$ be the $i_{k+1}$-th minimal vertex (from left to right) on $S$. We label $v_{j}^{\tau}$ with $l$, then we set $l:=l+1$ and $S:=S \backslash\left\{v_{j}^{\tau}\right\}$, and we apply steps 1.(a), (b) and (c) to $v_{j}^{\tau}$ instead of $v_{i}^{\tau}$.

By construction, the labelled graph $\mathcal{H}(\tau)$ is the linear graph of a permutation $\sigma \in \mathfrak{S}_{n}$ such that

$$
\operatorname{DES}_{2}(\sigma)=\left\{d_{2}^{k, \tau}, k \in[r]\right\}
$$

and

$$
\left\{j_{l}(\sigma), l \in\left[\operatorname{inv}_{2}(\sigma)\right]\right\}=\tau(\operatorname{EXC}(\tau))
$$

Example 4.9. Consider $\tau_{0}=956382471 \in \mathfrak{S}_{9}$ whose unlabelled and incomplete graph $\mathcal{H}\left(\tau_{0}\right)$ is depicted in Figure 15

- As stated in Example 4.6, the minimal vertices of $\tau_{0}$ on $S=$ [9] are $\left(v_{2}^{\tau_{0}}, v_{5}^{\tau_{0}}, v_{9}^{\tau_{0}}\right)$. Following step 2 of Algorithm 4.8, $k=0$ and the integers $l \in[9]$ such that $\tau_{0}(l) \geq e_{k+1}^{\tau_{0}}=1$ and such that the labels of dots $\tau_{0}(l)$ can be exchanged with 1 in the planar graph of $\tau_{0}$ (see Figure 12 ) are $\left(l_{1}, l_{2}, l_{3}\right)=(4,6,9)$. By $\tau_{0}^{-1}(1)=9=l_{3}$, we label the third minimal vertex on [9], i.e. the vertex $v_{9}^{\tau_{0}}$, with the integer $l=1$.

Afterwards, following step 1.(b), since $v_{9}^{\tau_{0}}$ is the arrival of an incomplete arc of circle starting from a vertex $v_{j}^{\tau_{0}}$ with $1=t_{1}^{\tau_{0}} \leq j$, and with $j<5$ because that arc of circle must begin before the arc of circle ending at $v_{6}^{\tau_{0}}$ in view of Fact 3 of Lemma 4.1, we complete that arc of circle by making it start from the unique minimal vertex $v_{j}^{\tau_{0}}$ on $[1,5[$, i.e. $j=2$, and we label $v_{2}^{\tau_{0}}$ with the integer $l=2$ (see Figure 16). Note that as from now we know that the arc of circle ending at $v_{5}^{\tau_{0}}$ necessarily begins at $v_{1}^{\tau_{0}}$, because otherwise $v_{1}^{\tau_{0}}$, being the beginning of an arc of circle, would be the beginning of the arc of circle ending at $v_{6}^{\tau_{0}}$, which is absurd in view of Fact 3 of Lemma 4.1 because $\tau_{0}^{-1}(9)<\tau^{-1}(6)$, so we complete that arc of circle by making it start from $v_{1}^{\tau_{0}}$, which has been depicted in Figure 16


Figure 16: Beginning of the labelling of $\mathcal{H}\left(\tau_{0}\right)$.

We now have $S=[9] \backslash\{2,9\}$ and $l=3$.

- From Figure 16, the minimal vertices on $S=[9] \backslash\{2,9\}$ are $\left(v_{3}^{\tau_{0}}, v_{5}^{\tau_{0}}\right)$. Following step 2 of Algorithm 4.8, $k=1$ and the integers $l \in[9]$ such that $l \tau_{0}(l) \geq e_{k+1}^{\tau_{0}}=2$ and such that the labels of dots $\tau_{0}(l)$ can be exchanged with 2 in the planar graph of $\tau_{0}$ (see Figure 12) are $\left(l_{1}, l_{2}\right)=(4,6)$. By $\tau_{0}^{-1}(2)=6=l_{2}$, we label the second minimal vertex on $S$, i.e. the vertex $v_{5}^{\tau_{0}}$, with the integer $l=3$.

Afterwards, following step 1.(a), since $v_{5}^{\tau_{0}}$ is the arrival of the arc of circle starting from the vertex $v_{1}^{\tau_{0}}$, we label $v_{1}^{\tau_{0}}$ with the integer $l=4$ (see Figure 17.


Figure 17: Beginning of the labelling of $\mathcal{H}\left(\tau_{0}\right)$.

We now have $S=[9] \backslash\{1,2,5,9\}$ and $l=5$.

- From Figure 17, the minimal vertices on $S=\{3,4,6,7,8\}$ are $\left(v_{3}^{\tau_{0}}, v_{6}^{\tau_{0}}\right)$. Following step 2 of Algorithm 4.8, $k=2$ and the integers $l \in[9]$ such that $l \tau_{0}(l) \geq e_{k+1}^{\tau_{0}}=3$ and such that the labels of dots $\tau_{0}(l)$ can be exchanged with 3 in the planar graph of $\tau_{0}$ (see Figure 12) are $\left(l_{1}, l_{2}\right)=(4,7)$. By $\tau_{0}^{-1}(3)=4=l_{1}$, we label the first minimal vertex on $S$, i.e. the vertex $v_{3}^{\tau_{0}}$, with the integer $l=5$ (see Figure 18). Note that as from now we know that the arc of circle ending at $v_{6}^{\tau_{0}}$ necessarily begins at $v_{4}^{\tau_{0}}$ since
it it is the only vertex left it may start from. Consequently, the arc of circle ending at $v_{8}^{\tau_{0}}$ necessarily starts from $v_{7}^{\tau_{0}}$ (otherwise it would start from $v_{6}^{\tau_{0}}$, which is prevented by Definition 4.5 because we cannot have $\left.v_{8}^{\tau_{0}} \prec v_{6}^{\tau_{0}} \prec v_{7}^{\tau_{0}} \prec v_{8}^{\tau_{0}}\right)$. The two latter remarks are taken into account in Figure 18 .


Figure 18: Beginning of the labelling of $\mathcal{H}\left(\tau_{0}\right)$.

We now have $S=\{4,6,7,8\}$ and $l=6$.

- From Figure 18, there is only one minimal vertex on $S=\{4,6,7,8\}$, i.e. the vertex $v_{6}^{\tau_{0}}$. Following step 1 of Algorithm 4.8, we label $v_{6}^{\tau_{0}}$ with $l=6$. Afterwards, following step 1.(a), since $v_{6}^{\tau_{0}}$ is the arrival of the arc of circle starting from the vertex $v_{4}^{\tau_{0}}$, we label $v_{4}^{\tau_{0}}$ with the integer $l=7$ (see Figure 19.


Figure 19: Beginning of the labelling of $\mathcal{H}\left(\tau_{0}\right)$.

We now have $S=\{7,8\}$ and $l=8$.

- From Figure 19, there is only one minimal vertex on $S=\{7,8\}$, i.e. the vertex $v_{6}^{\tau_{0}}$. Following step 1 of Algorithm 4.8, we label $v_{6}^{\tau_{0}}$ with $l=8$.

Afterwards, following step 1.(a), since $v_{8}^{\tau_{0}}$ is the arrival of the arc of circle starting from the vertex $v_{7}^{\tau_{0}}$, we label $v_{7}^{\tau_{0}}$ with the integer $l=9$ (see Figure 20.


Figure 20: Labelled graph $\mathcal{H}\left(\tau_{0}\right)$.

As a conclusion, the graph $\mathcal{H}\left(\tau_{0}\right)$ is the linear graph of the permutation ${ }_{390} \sigma_{0}=425736981 \in \mathfrak{S}_{9}$, which is mapped to $\tau_{0}$ by $\varphi$.

Proposition 4.10. We have $\varphi(\sigma)=\tau$, hence $\varphi$ is bijective.
Proof. By construction, for all $k \in\left[0, \operatorname{des}_{2}(\sigma)\right]=[0, r]$,

$$
\begin{aligned}
& d_{2}^{k}(\sigma)=d^{k, \tau}-c_{k}^{\tau}, \\
& c_{k}(\sigma)=c_{k}^{\tau} \\
& d^{k}(\sigma)=d_{2}^{k}(\sigma)+c_{k}(\sigma)=d_{2}^{k, \tau}+c_{k}^{\tau}=d^{k, \tau},
\end{aligned}
$$

so $\mathcal{G}(\sigma)$ has the same skeleton as the planar graph of $\tau$, i.e. $\operatorname{DES}(\varphi(\sigma))=$ $\operatorname{DES}(\tau)$ and $\operatorname{EXC}(\varphi(\sigma))=\operatorname{EXC}(\tau)$.

The labels of the circles of $\mathcal{G}(\sigma)$ are the elements of

$$
\left\{j_{l}(\sigma), l \in[s]\right\}=\tau(\operatorname{EXC}(\tau)),
$$

and by construction of $\sigma$, every pair $\left(l, l^{\prime}\right) \in \operatorname{EXC}(\tau)^{2}$ such that we can exchange the labels $\tau(l)$ and $\tau\left(l^{\prime}\right)$ in the planar graph of $\tau$ is such that

$$
i<i^{\prime} \Leftrightarrow l<l^{\prime}
$$

where $(i, \tau(l))$ and $\left(i, \tau\left(l^{\prime}\right)\right)$ are the two corresponding 2 -inversions of $\sigma$. Conse${ }_{395}$ quently, by definition of $\varphi(\sigma)$, the labels of the circles of $\mathcal{G}(\sigma)$ appear in the same order as in the planar graph of $\tau($ i.e. $\varphi(\sigma)(i)=\tau(i)$ for all $i \in \operatorname{EXC}(\varphi(\sigma))=$ $\operatorname{EXC}(\tau))$.

As a consequence, the dots of $\mathcal{G}(\sigma)$ and the planar graph of $\tau$ are labelled by the elements

$$
1=e_{1}(\sigma)=e_{1}^{\tau}<e_{2}(\sigma)=e_{2}^{\tau}<\ldots<e_{n-s}(\sigma)=e_{n-s}^{\tau} .
$$

As for the labels of the circles, to show that the above integers appear in the same order among the labels of $\mathcal{G}(\sigma)$ and the planar graph of $\tau$, it suffices to prove that

$$
\varphi(\sigma)^{-1}\left(e_{i}^{\tau}\right)<\varphi(\sigma)^{-1}\left(e_{j}^{\tau}\right) \Leftrightarrow \tau^{-1}\left(e_{i}^{\tau}\right)<\tau^{-1}\left(e_{j}^{\tau}\right)
$$

for all pair $(i, j)$ such that we can exchange the labels $e_{i}^{\tau}$ and $e_{j}^{\tau}$ in the planar graph of $\tau$ (hence in $\mathcal{G}(\sigma)$ since the two graphs have the same skeleton). This is guaranteed by Definition 4.5 because the vertices $v_{i}^{\tau}$ that are not the beginning of an arc of circle correspond with the labels of the dots of the planar graph of $\tau$.

As a conclusion, the planar graph of $\tau$ is in fact $\mathcal{G}(\sigma)$, i.e. $\tau=\varphi(\sigma)$.

## 5. Open problem

 $\mathfrak{S}_{n} \rightarrow \mathfrak{S}_{n}$ that maps $\left(\mathrm{maj}_{2}, \widetilde{\operatorname{des}_{2}}, \operatorname{inv}_{2}\right)$ to (amaj $2, \widetilde{\operatorname{asc}_{2}}$, ides $)$.Recall that ides $=\operatorname{des}_{2}$ and that for a permutation $\sigma \in \mathfrak{S}_{n}$, the equality $\widetilde{\operatorname{des}_{2}}(\sigma)=\operatorname{des}_{2}(\sigma)$ is equivalent to $\varphi(\sigma)(1)=1$, which is similar to the equivalence $\widetilde{\operatorname{asc}_{2}}(\tau)=\operatorname{asc}_{2}(\tau) \Leftrightarrow \tau(1)=1$ for all $\tau \in \mathfrak{S}_{n}$.

Note that if $\mathrm{DES}_{2}(\sigma)=\bigsqcup_{p=1}^{r}\left[i_{p}, j_{p}\right]$ with $j_{p}+1<i_{p+1}$ for all $p$, the permutation $\pi=\rho_{1} \circ \rho_{2} \circ \ldots \circ \rho_{r} \circ \sigma$, where $\rho_{p}$ is the $\left(j_{p}-i_{p}+2\right)$-cycle

$$
\left(\begin{array}{cccccc}
i_{p} & i_{p}+1 & i_{p}+2 & \ldots & j_{p} & j_{p}+1 \\
\sigma\left(j_{p}+1\right) & \sigma\left(j_{p}\right) & \sigma\left(j_{p}-1\right) & \ldots & \sigma\left(i_{p}+1\right) & \sigma\left(i_{p}\right)
\end{array}\right)
$$

for all $p$, is such that $\operatorname{DES}_{2}(\sigma) \subset \operatorname{ASC}_{2}(\pi)$ and $\operatorname{INV}_{2}(\sigma)=\operatorname{INV}_{2}(\pi)$. One can try to get rid of the eventual unwanted 2-ascents $i \in \operatorname{ASC}_{2}(\pi) \backslash \mathrm{DES}_{2}(\sigma)$ by composing $\pi$ with adequate permutations.
