Limit theorems for stationary increments Lévy driven moving averages

Abstract

In this paper we present some new limit theorems for power variation of kth order increments of stationary increments Lévy driven moving averages. In this infill sampling setting, the asymptotic theory gives very surprising results, which (partially) have no counterpart in the theory of discrete moving averages. More specifically, we will show that the first order limit theorems and the mode of convergence strongly depend on the interplay between the given order of the increments, the considered power $p > 0$, the Blumenthal–Getoor index $\beta \in (0, 2)$ of the driving pure jump Lévy process L and the behaviour of the kernel function g at 0 determined by the power α . First order asymptotic theory essentially comprise three cases: stable convergence towards a certain infinitely divisible distribution, an ergodic type limit theorem and convergence in probability towards an integrated random process. We also prove the second order limit theorem connected to the ergodic type result. When the driving Lévy process L is a symmetric β -stable process we obtain two different limits: a central limit theorem and convergence in distribution towards a $(1 - \alpha)\beta$ -stable random variable.

Keywords: Power variation, limit theorems, moving averages, fractional processes, stable convergence, high frequency data.

1 Introduction and main results

In the recent years there has been an increasing interest in limit theory for power variations of stochastic processes. Power variation functionals and related statistics play a major role in analyzing the fine properties of the underlying model, in stochastic integration concepts and statistical inference. In the last decade asymptotic theory for power variations of

various classes of stochastic processes has been intensively investigated in the literature. We refer e.g. to $[6, 26, 27, 33]$ $[6, 26, 27, 33]$ $[6, 26, 27, 33]$ $[6, 26, 27, 33]$ for limit theory for power variations of Itô semimartingales, to [\[4,](#page-51-1) [5,](#page-51-2) [18,](#page-52-2) [23,](#page-52-3) [32\]](#page-53-1) for the asymptotic results in the framework of fractional Brownian motion and related processes, and to [\[17,](#page-52-4) [41\]](#page-53-2) for investigations of power variation of the Rosenblatt process.

In this paper we study the power variation of *stationary increments Lévy driven moving* averages. More specifically, we consider an infinitely divisible process with stationary increments $(X_t)_{t>0}$, defined on a probability space $(\Omega, \mathcal{F}, \mathbb{P})$, given as

$$
X_t = \int_{-\infty}^t \left\{ g(t-s) - g_0(-s) \right\} dL_s,
$$
\n(1.1)

where $L = (L_t)_{t \in \mathbb{R}}$ is a symmetric Lévy process on R with $L_0 = 0$, that is, for all $u \in \mathbb{R}$, $(L_{t+u} - L_u)_{t\geq 0}$ is a Lévy process indexed by \mathbb{R}_+ which distribution is invariant under multiplication with -1 . Furthermore, g and g_0 are deterministic functions from R into R vanishing on $(-\infty, 0)$. In the further discussion we will need the notion of *Blumenthal–* Getoor index of L, which is defined via

$$
\beta := \inf \left\{ r \ge 0 : \int_{-1}^{1} |x|^r \, \nu(dx) < \infty \right\} \in [0, 2],\tag{1.2}
$$

where ν denotes the Lévy measure of L. When $g_0 = 0$, process X is a moving average, and in this case X is a stationary process. If $g(s) = g_0(s) = s_+^{\alpha}$, X is a so called fractional Lévy process. In particular, when L is a β-stable Lévy motion with $\beta \in (0, 2)$, X is called a linear fractional stable motion and it is self-similar with index $H = \alpha + 1/\beta$; see e.g. [\[36\]](#page-53-3) (since in this case the stability index and the Blumenthal–Getoor index coincide, they are both denoted by β).

Probabilistic analysis of stationary increments Lévy driven moving averages such as semimartingale property, fine scale structure and integration concepts, have been investigated in several papers. We refer to the work of [\[8,](#page-51-3) [9,](#page-51-4) [10,](#page-51-5) [11,](#page-51-6) [29\]](#page-52-5) among many others. However, only few results on the power variations of such processes are presently available, exceptions to this are [\[9,](#page-51-4) Theorem 5.1] and [\[21,](#page-52-6) Theorem 2]; see Remark [2.4](#page-11-0) for a closer discussion of a result from [\[9,](#page-51-4) Theorem 5.1]. These two results are concerned with certain power variation of fractional Lévy process and have some overlad with our Theorem $1.1(ii)$ for the linear fractional stable motion, but we apply different proofs. The aim of this paper is to derive a rather complete picture of the first order asymptotic theory for power variation of the process X , and, in some cases, the associated second order limit theory. We will see that the type of convergence and the limiting random variables/distributions are quite surprising and novel in the literature. Apart from pure probabilistic interest, limit theory for power variations of stationary increments Lévy driven moving averages give rise to a variety of statistical methods (e.g. identification and estimation of the unknown parameters α and β) and it provides a first step towards asymptotic theory for power variation of stochastic processes, which contain X as a building block. In this context let us mention stochastic integrals with respect to X and Lévy semi-stationary processes, which have been introduced in [\[3\]](#page-51-7).

To describe our main results we need to introduce some notation and a set of assumptions. In this work we consider the kth order increments $\Delta_{i,k}^n X$ of X, $k \in \mathbb{N}$, that are defined by

$$
\Delta_{i,k}^n X := \sum_{j=0}^k (-1)^j \binom{k}{j} X_{(i-j)/n}, \qquad i \ge k.
$$

For instance, we have that $\Delta_{i,1}^n X = X_{\frac{i}{n}} - X_{\frac{i-1}{n}}$ and $\Delta_{i,2}^n X = X_{\frac{i}{n}} - 2X_{\frac{i-1}{n}} + X_{\frac{i-2}{n}}$. Our main functional is the power variation computed on the basis of $\stackrel{n}{k}$ th order filters:

$$
V(p;k)_n := \sum_{i=k}^n |\Delta_{i,k}^n X|^p, \qquad p > 0.
$$
 (1.3)

Now, we introduce the following set of assumptions on q and ν :

Assumption (A): The function $q: \mathbb{R} \to \mathbb{R}$ satisfies

$$
g(t) \sim c_0 t^{\alpha}
$$
 as $t \downarrow 0$ for some $\alpha > 0$ and $c_0 \neq 0$, (1.4)

where $g(t) \sim f(t)$ as $t \downarrow 0$ means that $\lim_{t \downarrow 0} g(t)/f(t) = 1$. For some $\theta \in (0,2]$, $\limsup_{t\to\infty}\nu(x:|x|\geq t)t^{\theta}<\infty$ and $g-g_0$ is a bounded function in $L^{\theta}(\mathbb{R}_{+})$. Furthermore, g is k-times continuous differentiable on $(0, \infty)$ and there exists a $\delta > 0$ such that $|g^{(k)}(t)| \leq K t^{\alpha-k}$ for all $t \in (0,\delta), g^{(k)} \in L^{\theta}((\delta,\infty))$ and $|g^{(k)}|$ is decreasing on (δ,∞) . **Assumption (A-log):** In addition to (A) suppose that $\int_{\delta}^{\infty} |g^{(k)}(s)|^{\theta} \log(1/|g^{(k)}(s)|) ds <$ ∞.

Assumption (A) ensures that the process X is well-defined, cf. Section [2.4.](#page-10-0) When L is a β-stable Lévy process, we always choose $\theta = \beta$ in assumption (A). Before we introduce the main results, we need some more notation. Let $h_k : \mathbb{R} \to \mathbb{R}$ be given by

$$
h_k(x) = \sum_{j=0}^k (-1)^j {k \choose j} (x-j)_+^{\alpha}, \qquad x \in \mathbb{R},
$$
\n(1.5)

where $y_+ = \max\{y, 0\}$ for all $y \in \mathbb{R}$. Let $\mathbb{F} = (\mathcal{F}_t)_{t>0}$ be the filtration generated by $(L_t)_{t\geq0}$, $(T_m)_{m\geq1}$ be a sequence of F-stopping times that exhaust the jumps of $(L_t)_{t\geq0}$, that is, $\{T_m(\omega) : m \geq 1\} \cap \mathbb{R}_+ = \{t \geq 0 : \Delta L_t(\omega) \neq 0\}$ and $T_m(\omega) \neq T_n(\omega)$ for all $m \neq n$ with $T_m(\omega) < \infty$. Let $(U_m)_{m\geq 1}$ be independent and uniform [0, 1]-distributed random variables, defined on an extension $(\Omega', \mathcal{F}', \mathbb{P}')$ of the original probability space, which are independent of F.

The following two theorems summarize the first and second order limit theory for the power variation $V(p; k)_n$. We would like to emphasize part (i) of Theorem [1.1](#page-3-0) and part (i) of Theorem [1.2,](#page-4-0) which are truly remarkable probabilistic results. We refer to [\[1,](#page-51-8) [35\]](#page-53-4) and to Section [4](#page-15-0) for the definition of $\mathcal{F}\text{-stable}$ convergence which will be denoted $\frac{\mathcal{L}-s}{\rightarrow}$.

Theorem 1.1 (First order asymptotics.). Suppose (A) is satisfied and assume that the Blumenthal–Getoor index satisfies $\beta < 2$. We obtain the following three cases:

(i) Suppose that (A-log) holds if $\theta = 1$. If $\alpha < k - 1/p$ and $p > \beta$ we obtain the F-stable convergence

$$
n^{\alpha p}V(p;k)_n \stackrel{\mathcal{L}-s}{\longrightarrow} |c_0|^p \sum_{m:T_m \in [0,1]} |\Delta L_{T_m}|^p V_m \quad where \quad V_m = \sum_{l=0}^{\infty} |h_k(l+U_m)|^p. \tag{1.6}
$$

(ii) Suppose that L is a symmetric β-stable Lévy process with scale parameter $\sigma > 0$. If $\alpha < k - 1/\beta$ and $p < \beta$ then it holds

$$
n^{-1+p(\alpha+1/\beta)}V(p;k)_n \stackrel{\mathbb{P}}{\longrightarrow} m_p
$$

where $m_p = |c_0|^p \sigma^p (\int_{\mathbb{R}} |h_k(x)|^{\beta} dx)^{p/\beta} \mathbb{E}[|Z|^p]$ and Z is a symmetric β -stable random variable with scale parameter 1.

(iii) Suppose that $p \geq 1$. If $p = \theta$ suppose in addition that (A-log) holds. For all $\alpha >$ $k-1/(\beta \vee p)$ we deduce

$$
n^{-1+pk}V(p;k)_n \xrightarrow{\mathbb{P}} \int_0^1 |F_u|^p du \tag{1.7}
$$

where $(F_u)_{u \in \mathbb{R}}$ is a measurable process satisfying

$$
F_u = \int_{-\infty}^u g^{(k)}(u-s) dL_s \quad a.s. \text{ for all } u \in \mathbb{R} \quad and \quad \int_0^1 |F_u|^p du < \infty \quad a.s.
$$

We remark that, except the critical cases where $p = \beta$, $\alpha = k - 1/p$ and $\alpha = k - 1/\beta$, Theorem [1.1](#page-3-0) covers all possible choices of $\alpha > 0, \beta \in [0, 2)$ and $p \ge 1$. We also note that the limiting random variable in [\(1.6\)](#page-4-1) is infinitely divisible, see Section [2.4](#page-10-0) for more details. In addition, we note that there is no convergence in probability in [\(1.6\)](#page-4-1) due to the fact that the random variables V_m , $m \geq 1$, are independent of L and the properties of stable convergence. To be used in the next theorem we recall that a totally right skewed ρ -stable random variable S with $\rho > 1$, mean zero and scale parameter $\eta > 0$ has characteristic function given by

$$
\mathbb{E}[e^{i\theta S}] = \exp\Big(-\eta^{\rho}|\theta|^{\rho}\big(1 - i\text{sign}(\theta)\tan(\pi\rho/2)\big)\Big), \qquad \theta \in \mathbb{R}.
$$

For part (ii) of Theorem [1.1,](#page-3-0) which we will refer to as the ergodic case, we also show the second order asymptotic results.

Theorem 1.2 (Second order assymptotics). Suppose that assumption (A) is satisfied and L is a symmetric β -stable Lévy process with scale parameter $\sigma > 0$. Let $f : [0, \infty) \mapsto \mathbb{R}$ be given by $f(t) = g(t)/t^{\alpha}$ for $t > 0$ and $f(0) = c_0$, and assume that f is k-times continuous right differentiable at 0. For the below case (i) assume, in addition, that $|g'(t)| \leq K t^{\alpha-1}$ for all $t > 0$.

(i) If $k = 1$, $\alpha < 1 - 1/\beta$ and $p < \beta/2$, then it holds that

$$
n^{1-\frac{1}{(1-\alpha)\beta}}\left(n^{-1+p(\alpha+1/\beta)}V(p;k)_n-m_p\right)\stackrel{d}{\longrightarrow}S,
$$

where S is a totally right skewed $(1-\alpha)\beta$ -stable random variable with mean zero and scale parameter $\tilde{\sigma}$, which is defined in Remark 2.5(i).

(ii) If $k \geq 2$, $\alpha < k - 2/\beta$ and $p < \beta/2$ we deduce that

$$
\sqrt{n}\left(n^{-1+p(\alpha+1/\beta)}V(p;k)_n - m_p\right) \stackrel{d}{\longrightarrow} \mathcal{N}(0,\eta^2),\tag{1.8}
$$

where the quantity η^2 is defined in Remark 2.5(ii).

This paper is structured as follows. Section [2](#page-5-0) presents some remarks about the nature and applicability of the main results, and it also includes a discussion about related problems. Section [3](#page-14-0) introduces some preliminaries. We state the proof of Theorem [1.1](#page-3-0) in Section [4,](#page-15-0) while the proof of Theorem [1.2](#page-4-0) is demonstrated in Section [5.](#page-30-0) Some technical lemmas are deferred to the Appendix.

2 Related results, remarks and extensions

In this section we will give a review of related asymptotic results in the literature, present some intuition behind our limit theory and discuss possible extensions.

2.1 Fine properties of stationary increments Lévy driven moving averages

In this subsection we will discuss the probabilistic properties of the process X defined at [\(1.1\)](#page-2-0), such as semimartingale property and small scale behaviour, and their consequences for the limit theory. For simplicity suppose that L is a symmetric β -stable Lévy process.

Suppose, in addition, that g' satisfies the lower bound $Kt^{\alpha-1} \le |g'(t)|$ for all $t \in (0,1)$ and a constant $K > 0$. By [\[8,](#page-51-3) Example 4.9] it follows that X is a semimartingale if and only if $\alpha > 1-1/\beta$, which is exactly condition (iii) in Theorem [1.1](#page-3-0) when $k = 1$ and $p < \beta$.

To better understand the limit theory stated in Theorem [1.1\(](#page-3-0)ii) and Theorem [1.2,](#page-4-0) which both refer to the ergodic case, we need to study the small scale behaviour of the stationary increments Lévy driven moving averages X . We intuitively deduce the following approximation for the increments of X for a small $\Delta > 0$:

$$
X_{t+\Delta} - X_t = \int_{\mathbb{R}} \{g(t+\Delta-s) - g(t-s)\} dL_s
$$

\n
$$
\approx \int_{t+\Delta-\epsilon}^{t+\Delta} \{g(t+\Delta-s) - g(t-s)\} dL_s
$$

\n
$$
\approx c_0 \int_{t+\Delta-\epsilon}^{t+\Delta} \{ (t+\Delta-s)_+^{\alpha} - (t-s)_+^{\alpha} \} dL_s
$$

\n
$$
\approx c_0 \int_{\mathbb{R}} \{ (t+\Delta-s)_+^{\alpha} - (t-s)_+^{\alpha} \} dL_s = \widetilde{X}_{t+\Delta} - \widetilde{X}_t,
$$

where

$$
\widetilde{X}_t := c_0 \int_{\mathbb{R}} \{ (t - s)_+^{\alpha} - (-s)_+^{\alpha} \} dL_s,
$$
\n(2.1)

and $\epsilon > 0$ is an arbitrary small real number with $\epsilon \gg \Delta$. In the classical terminology X is called the *tangent process of X*. The formal proof of this first order approximation, which will be demonstrated in Section [4,](#page-15-0) relies on assumption (A) and the fact that, under conditions of Theorem [1.1\(](#page-3-0)ii), the weight $g(t + \Delta - s) - g(t - s)$ attains asymptotically highest values when $s \approx t$, since g' explodes at 0. Recall that the process X is the linear fractional stable motion. In particular, under the assumptions of Theorem $1.1(i)$, it is a linear fractional stable motion with β -stable marginals and self-similarity index $H = \alpha + 1/\beta$. Thus, one may transfer the first order asymptotic theory for power variation of X to the corresponding results for power variation of X . However, the law of large numbers for power variation of \overline{X} is easier to handle than the original statistic due to selfsimilarity property of X , which allows to transform the original triangular observation scheme into a usual one when studying distributional properties. Then, the standard ergodic limit theory becomes applicable. Indeed, this is exactly the method of proof of Theorem [1.1\(](#page-3-0)ii). We remark however that it is much more technical to use the relationship between X and X for the proof of the second order asymptotic theory in Theorem [1.2.](#page-4-0) In fact, we use a more direct approach to show the results of Theorem [1.2.](#page-4-0)

2.2 Limit theory in the Gaussian case

Throughout this subsection we recall the asymptotic theory for power variation of fractional Brownian motion $(B_t^H)_{t\geq 0}$ with Hurst parameter $H \in (0,1)$ and relate it to our limit theory. The main demonstrated results have been established in the classical work [\[15,](#page-52-7) [40\]](#page-53-5). We write $V(B^H, p; k)_n$ to denote the power variation statistics defined at [\(1.3\)](#page-3-1) associated with the fractional Brownian motion $(B_t^H)_{t\geq0}$.

First of all, we observe the law of large numbers

$$
n^{-1+pH}V(B^H, p; k)_n \xrightarrow{\mathbb{P}} m_p := \mathbb{E}[|n^H \Delta_{i,k}^n B^H|^p],
$$

which follows from the ergodic theorem (note that m_p is independent of n due to selfsimilarity property of B^H). The associated weak limit theory depends on the interplay between the correlation kernel of the fractional Brownian noise and the Hermite

rank of the function $h(x) = |x|^p - m_p$. Recall that the correlation kernel $\rho_k(j) =$ $\text{corr}(n^H \Delta_{k,k}^n B^H, n^H \Delta_{k+j,k}^n B^H)$ of kth order differences of the fractional Brownian motion satisfies that

$$
|\rho_k(j)| \le K j^{2H-2k} \qquad \text{for } j \ge 1,
$$

for some $K > 0$. The Hermite expansion of the function h is defined as

$$
h(x) = |x|^p - m_p = \sum_{l=2}^{\infty} \lambda_l H_l(x),
$$

where $(H_l)_{l\geq 0}$ are Hermite polynomials, i.e.

$$
H_0(x) = 1
$$
 and $H_l(x) = (-1)^l \exp(x^2/2) \frac{d^l}{dx^l} \{-\exp(x^2/2)\}\$ for $l \ge 1$.

The Hermite rank of h is the smallest index l with $\lambda_l \neq 0$, which is 2 in our case. The condition for the validity of a central limit theorem associated to a standardized version of $V(B^H, p; k)_n$ is then

$$
\sum_{j=1}^{\infty} \rho_k^2(j) < \infty,
$$

where the power 2 indicates the Hermite rank of h . The latter is obviously fulfilled for any $k \geq 2$ and also for $k = 1$ if $H \in (0, 3/4)$. The next result is a famous statement from [\[15,](#page-52-7) [40\]](#page-53-5). The Gaussian limit case is usually referred to as Breuer–Major central limit theorem.

Theorem 2.1. The following assertions hold:

(i) Assume that $k \geq 2$ or $k = 1$ and $H \in (0, 3/4)$. Then the central limit theorem holds

$$
\sqrt{n}\left(n^{-1+pH}V(B^H,p;k)_n - m_p\right) \stackrel{d}{\longrightarrow} \mathcal{N}(0,v_p),
$$

where $v_p = \sum_{l=2}^{\infty} l! \lambda_l^2$ $\left(1+2\sum_{j=1}^{\infty}\rho_k^l(j)\right).$

(ii) When $k = 1$ and $H = 3/4$ we have

$$
\frac{\sqrt{n}}{\log n} \left(n^{-1+pH} V(B^H, p; k)_n - m_p \right) \stackrel{d}{\longrightarrow} \mathcal{N}(0, \tilde{v}_p),
$$

where $\tilde{v}_p = 4\lambda_2 \lim_{n \to \infty} \frac{1}{\log n}$ $\frac{1}{\log n} \sum_{j=1}^{n-1} \frac{n-k}{n}$ $\frac{-k}{n} \rho_1^2(j)$.

(iii) When $k = 1$ and $H \in (3/4, 1)$ it holds that

$$
n^{2-2H} \left(n^{-1+pH} V(B^H, p; k)_n - m_p \right) \stackrel{d}{\longrightarrow} Z,
$$

where Z is a Rosenblatt random variable.

The results of Theorem [2.1](#page-7-0) has been extended to the case of general stationary increments Gaussian processes in [\[23\]](#page-52-3). Asymptotic theory for power variation of stochastic integrals with respect to Gaussian processes has been intensively studied in [\[4,](#page-51-1) [5,](#page-51-2) [19\]](#page-52-8). We also refer to the interesting work [\[41\]](#page-53-2) for a study of quadratic variation of the Rosenblatt process.

Summarizing the asymptotic theory in the Gaussian case, we can conclude that the limiting behaviour in the framework of stationary increments Lévy driven moving averages is quite different. Not surprisingly, the quite stunning results of Theorem [1.1\(](#page-3-0)i) and Theorem [1.2\(](#page-4-0)i) do not appear in the Gaussian setting (the convergence of the type [\(1.7\)](#page-4-2) may very well appear for differentiable Gaussian processes).

2.3 Limit theorems for discrete moving averages

Asymptotic theory for statistics of discrete moving averages has been a subject of a deep investigation during the last thirty years. Indeed, the variety of different limiting distributions, which may appear under certain conditions on the innovations and weight coefficients, is quite astonishing. In a functional framework they include Brownian motion, mth order Hermite processes, stable Lévy processes with various stability indexes and fractional Brownian motion. We refer to the work [\[2,](#page-51-9) [24,](#page-52-9) [25,](#page-52-10) [30,](#page-52-11) [38,](#page-53-6) [39\]](#page-53-7) among many others. The limit theory is much more diverse and still not completely understood in contrast to the Gaussian case discussed in the previous subsection. For this reason, we will rather concentrate on some asymptotic results related to our set of conditions.

Let us consider a discrete moving average $(Z_i)_{i\in\mathbb{Z}}$ of the form

$$
Z_i = \sum_{j=1}^{\infty} b_j \zeta_{i-j},
$$

where $(\zeta_i)_{i\in\mathbb{Z}}$ is a sequence of i.i.d. random variables with mean 0 and variance 1, and $(b_i)_{i\geq 1}$ are non-random coefficients. The innovation ζ_1 is assumed to satisfy: There exists $K, \delta > 0$ such that for all $u \in \mathbb{R}$, $|\mathbb{E}[e^{iu\zeta_1}]| \leq K(1+|u|)^{-\delta}$. For simplicity of exposition and comparison we assume that the distribution of ζ_1 is symmetric. Now, we briefly review the results of [\[39\]](#page-53-7). The assumptions on the decay of the coefficients $(b_j)_{j\geq 1}$ and the tail behaviour of the innovations are as follows:

$$
b_j \sim k_0 j^{-\gamma}
$$
 as $j \to \infty$, $\mathbb{P}(|\zeta_1| > x) \sim qx^{-\beta}$ as $x \to \infty$,

for some $\gamma \in (1/2, 1), \beta \in (2, 4)$ and $k_0, q \neq 0$. Surgailis [\[39\]](#page-53-7) studies the asymptotic behaviour of the statistic

$$
S_n = \sum_{i=1}^n h(Z_i),
$$

where $h : \mathbb{R} \to \mathbb{R}$ is a *bounded* measurable function with $\mathbb{E}[h(Z_1)] = 0$. In this framework the most important ingredient is the *Appell rank* of the function h (cf. [\[2\]](#page-51-9)). It is defined

$$
k^\star:=\min_{k\geq 1}\{h_\infty^{(k)}(0)\neq 0\}\qquad\text{with}\qquad h_\infty(x):=\mathbb E[h(Z_1+x)].
$$

The Appell rank is similar in spirit with the Hermite rank introduced in the previous section, but it is much harder to prove limit theorems for the statistic S_n for an arbitrary Appell rank k^* . The main problem is that, in contrast to Hermite expansion, the expansion with respect to Appell polynomials typically does not exist. Furthermore, the decomposition of S_n becomes more complex when k^* increases. For this reason only the cases $k^* = 1, 2, 3$ are usually treated in the literature in the framework of heavy tailed innovations. In particular, [\[39\]](#page-53-7) investigates the cases $k^* = 2, 3$.

At this stage we compare the introduced setting of discrete moving average with our framework of [\(1.1\)](#page-2-0). For the sake of exposition, we will rather consider the tangent process X defined at [\(2.1\)](#page-6-0) driven by a symmetric β -stable Lévy motion L. We immediately see that our assumption on β , namely $\beta \in (0, 2)$, does not satisfy the tail behaviour condition on the innovations introduced above (in particular, $\mathbb{E}[L_t^2] = \infty$). As for the weight coefficients, our kernel function satisfies that

$$
c_0((x+1)^{\alpha}-x^{\alpha}) \sim \alpha c_0 x^{\alpha-1}
$$
 as $x \to \infty$.

Thus, the connection to the setting of discrete moving averages is given via $k_0 = \alpha c_0$ and $\gamma = 1 - \alpha$ (indeed, it holds that $1 - \alpha \in (1/2, 1)$ under conditions of Theorem [1.1\(](#page-3-0)ii)). In our framework, the function h is given via $h(x) = |x|^p - m_p$, where the quantity m_p has been defined in Theorem [1.1\(](#page-3-0)ii), which is obviously not bounded. Since h is an even function and L is symmetric, we readily deduce that $k^* = 2$.

Now, we summarize the asymptotic theory from [\[39\]](#page-53-7) for the statistic S_n in the case of Appell rank $k^* = 2$ $(2 < \beta < 8/3)$:

- (i) $1/2 < \gamma < (\beta + \sqrt{\beta^2 2\beta})/2\beta$: convergence rate $n^{2-2\gamma}$, Rosenblatt limit.
- (ii) $(\beta + \sqrt{\beta^2 2\beta})/2\beta < \gamma < 2/\beta$: convergence rate $n^{1/\gamma\beta}$, $\gamma\beta$ -stable limit.
- (iii) $2/\beta < \gamma < 1$: convergence rate $n^{1/2}$, normal limit.

Although the results of [\[39\]](#page-53-7) are not directly applicable (recall that in our setting $\beta \in (0, 2)$) and h is unbounded), Theorem [1.2\(](#page-4-0)i) corresponds to case (ii) of [\[39\]](#page-53-7). Indeed, we apply a similar proof strategy to show the weak convergence. However, strong modifications due to unboundedness of h , triangular nature of summands in (1.3) , stochastic integrals instead of sums, and the different set of conditions are required.

Remark 2.2. Case (ii) of [\[39\]](#page-53-7) is a quite remarkable result, since a $\gamma\beta$ -stable distribution appears in the limit although the summands of S_n are bounded (in particular, all moments of S_n exist). In particular, the rate of convergence $n^{1/\gamma\beta}$ does not correspond to the variance of S_n . \square

Remark 2.3. The symmetry condition on the Lévy process L is assumed for sake of assumption simplification. Most asymptotic results of this paper would not change if we

as

dropped this condition. However, the Appell rank of the function $h(x) = |x|^p - m_p$ might be 1 when L is not symmetric and this does change the result of Theorem [1.2\(](#page-4-0)i). More specifically, the limiting distribution turns out to be β -stable (see e.g. [\[30\]](#page-52-11) for the discrete case). We dispense with the exact exposition of this case. \Box

2.4 Further remarks and possible extensions

We start by commenting on the set of conditions introduced in assumption (A) . First of all, it follows by [\[34,](#page-53-8) Theorem 7] that the process X , defined in [\(1.1\)](#page-2-0), is well-defined if and only if for all $t \geq 0$,

$$
\int_{-t}^{\infty} \int_{\mathbb{R}} \left(\left| f_t(s)x \right|^2 \wedge 1 \right) \nu(dx) \, ds < \infty,\tag{2.2}
$$

where $f_t(s) = g(t+s) - g_0(s)$. By adding and subtracting g to f_t it follows by assumption (A) and the mean value theorem that $f_t \in L^{\theta}(\mathbb{R}_+)$ and f_t is bounded. For all $\epsilon > 0$, assumption (A) implies that

$$
\int_{\mathbb{R}} (|yx|^2 \wedge 1) \nu(dx) \le K \Big(\mathbb{1}_{\{|y| \le 1\}} |y|^{\theta} + \mathbb{1}_{\{|y| > 1\}} |y|^{\beta + \epsilon} \Big),
$$

which shows [\(2.2\)](#page-10-1) since $f_t \in L^{\theta}(\mathbb{R}_+)$ is bounded. We remark that for $\theta' < \theta$ it holds

$$
\limsup_{t \to \infty} \nu(x: |x| \ge t) t^{\theta} < \infty \quad \implies \quad \limsup_{t \to \infty} \nu(x: |x| \ge t) t^{\theta'} < \infty.
$$

On the other hand, the assumption $g^{(k)} \in L^{\theta'}((\delta, \infty))$ is stronger than $g^{(k)} \in L^{\theta}((\delta, \infty)),$ which creates a certain balance between these two conditions. Finally, we note that the assumption (A-log) will be used only for the case $\theta = 1$ (resp. $\theta = p$) in part (i) (resp. part (iii)) of Theorem [1.1.](#page-3-0)

More importantly, the conditions of assumption (A) guarantee that the quantity

$$
\int_{-\infty}^{t-\epsilon} g^{(k)}(t-s) dL_s, \qquad \epsilon > 0,
$$

is well-defined (typically, the above integral is not well-defined for $\epsilon = 0$). The latter is crucial for the proof of Theorem [1.1\(](#page-3-0)i). We recall that the condition $p \geq 1$ is imposed in Theorem [1.1\(](#page-3-0)iii). We think that this condition might not be necessary, but the results of [\[14\]](#page-52-12) applied in our proofs require $p \geq 1$. However, when the index α further satisfies $\alpha > k$, then the stochastic process F at [\(1.7\)](#page-4-2) is continuous and condition $p \ge 1$ is not needed in Theorem [1.1\(](#page-3-0)iii).

The conditions $\alpha \in (0, k-1/p)$ and $p > \beta$ of Theorem [1.1\(](#page-3-0)i) seem to be sharp. Indeed, since $|h_k(x)| \leq Kx^{\alpha-k}$ for large x, we obtain from [\(1.6\)](#page-4-1) that

$$
\sup_{m\geq 1} V_m < \infty
$$

when $\alpha \in (0, k - 1/p)$. On the other hand $\sum_{m:T_m \in [0,1]} |\Delta L_{T_m}|^p < \infty$ for $p > \beta$, which follows from the definition of the Blumenthal–Getoor index at [\(1.2\)](#page-2-1). Notice that under assumption $\alpha \in (0, k-1/2)$ the case $p = 2$, which corresponds to quadratic variation, always falls under Theorem $1.1(i)$. We remark that the distribution of the limiting variable in [\(1.6\)](#page-4-1) does not depend on the chosen sequence $(T_m)_{m\geq 1}$ of stopping times which exhausts the jump times of L . Furthermore, the limiting random variable Z in (1.6) is infinitely divisible with Lévy measure $(\nu \otimes \eta) \circ ((y, v) \mapsto |c_0y|^p v)^{-1}$, where η denotes the law of V_1 . In fact, Z has characteristic function given by

$$
\mathbb{E}[\exp(i\theta Z)] = \exp\Big(\int_{\mathbb{R}_0\times\mathbb{R}} (e^{i\theta |c_0y|^p v} - 1) \nu(dy) \eta(dv)\Big).
$$

To show this, let Λ be the Poisson random measure given by $\Lambda = \sum_{m=1}^{\infty} \delta_{(T_m, \Delta L_{T_m})}$ on $[0,1] \times \mathbb{R}_0$ which has intensity measure $\lambda \otimes \nu$. Here $\mathbb{R}_0 := \mathbb{R} \setminus \{0\}$ and λ denotes the Lebesgue measure on [0, 1]. Set $\Theta = \sum_{m=1}^{\infty} \delta_{(T_m,\Delta L_{T_m},V_m)}$. Then Θ is a Poisson random measure with intensity measure $\lambda \otimes \nu \otimes \eta$, due to [\[37,](#page-53-9) Theorem 36], and hence the above claims follows from the stochastic integral representation

$$
Z = \int_{[0,1] \times \mathbb{R}_0 \times \mathbb{R}} \left(|c_0 y|^p v \right) \Theta(ds, dy, dv).
$$

As for Theorem [1.1\(](#page-3-0)iii), we remark that for values of α close to $k - 1/p$ or $k - 1/\beta$, the function $g^{(k)}$ explodes at 0. This leads to unboundedness of the process F defined in Theorem [1.1\(](#page-3-0)iii). Nevertheless, the limiting random variable in (1.7) is still finite.

We recall that L is assumed to be a symmetric β -stable Lévy process in Theorems [1.1\(](#page-3-0)ii) and [1.2.](#page-4-0) This assumption can be relaxed following the discussion of tangent processes in Section [2.1.](#page-5-1) Indeed, only the small scale behaviour of the driving Lévy process L should matter for the statement of the aforementioned results. When the small jumps of L are in the domain of attraction of a symmetric β -stable Lévy process, e.g. its Lévy measure satisfies the decomposition

$$
\nu(dx) = \left(\text{const} \cdot |x|^{-1-\beta} + \varphi(x)\right) dx
$$

with $\varphi(x) = o(|x|^{-1-\beta})$ for $x \to 0$, the statements of Theorems [1.1\(](#page-3-0)ii) and [1.2](#page-4-0) should remain valid under possibly further assumptions on the function φ . Such processes include for instance tempered or truncated symmetric β -stable Lévy processes.

Remark 2.4. Theorem 5.1 of [\[9\]](#page-51-4) studies the first order asymptotic of the power variation of some fractional fields $(X_t)_{t\in\mathbb{R}^d}$. In the case $d = 1$, they considers fractional Lévy processes $(X_t)_{t\in\mathbb{R}}$ of the form

$$
X_t = \int_{\mathbb{R}} \left\{ |t - s|^{H - 1/2} - |s|^{H - 1/2} \right\} dL_s \tag{2.3}
$$

where L is a truncated β -stable Lévy process. This setting is close to fit into the framework of the present paper [\(1.1\)](#page-2-0) with $\alpha = H - 1/2$ except for the fact that the stochastic integral (2.3) is over the hole real line. However, the proof of Theorem [1.1\(](#page-3-0)i) still holds for X in (2.3) with obvious modifications of h_k and V_m in [\(1.5\)](#page-3-2) and [\(1.6\)](#page-4-1), respectively. Notice also that [\[9\]](#page-51-4) considers the power variation along the subsequence $2ⁿ$, which corresponds to dyadic partitions, and their setting includes second order increments. For $p < \beta$, Theorem 5.1 of [\[9\]](#page-51-4) claims that $2^{n\alpha p}V(p; 2)_{2^n} \to C$ a.s. where C is a positive constant, which in the notation of [\[9\]](#page-51-4) corresponds to the case $\alpha < \beta < 2$. However, this contradicts Theorem [1.1\(](#page-3-0)i) together with the remark following it, namely that, convergence in probability can not take place under the conditions of Theorem [1.1\(](#page-3-0)i) not even trough a subsequence. The main part of the proof of the cited result, [\[9,](#page-51-4) Theorem 5.1], consists in proving that $\mathbb{E}[2^{n\alpha p}V(p;2)_{2^n}] \rightarrow$ C (see p. 372, l. 11), and this result agrees with our Theorem [1.1\(](#page-3-0)i). However, in the last three lines of their proof (p. 372, l. 12–15) it is argued how $\mathbb{E}[2^{n\alpha p}V(p;2)_{2^n}] \to C$ implies that $2^{n\alpha p}V(p;2)_{2^n} \rightarrow C$ a.s. The argument relies on the statement from [\[9\]](#page-51-4): " $S_n(y) =$ $\mathbb{E}[S_n(y)](1 + o_{(a.s.)}(1))^n$, where the stochastic process $S_n(y)$ is the empirical characteristic function of normalised increments defined on [\[9,](#page-51-4) p. 367]. This statement is only shown for each fixed y (see [\[9,](#page-51-4) Lemma 5.2]), but to use it to carry out the proof, it is crucial to know the dependence of the $o_{(a.s.)}(1)$ -term in y. In fact, it is not even enough to have boundedness in y of the $o_{(a.s.)}(1)$ -term. \Box

Let us further explain the various conditions of Theorems [1.1\(](#page-3-0)ii) and [1.2.](#page-4-0) The condition $p < \beta$ obviously ensures the existence of moments m_p , while assumption $p < \beta/2$ ensures the existence of variance of the statistic $V(p; k)_n$. The validity range of the central limit theorem $(\alpha \in (0, k-2/\beta))$ in [\(1.8\)](#page-5-2) is smaller than the validity range of the law of large numbers in Theorem [1.1\(](#page-3-0)ii) $(\alpha \in (0, k-1/\beta))$. It is not clear which limit distribution appears in case of $\alpha \in (k-2/\beta, k-1/\beta)$. There are also two critical cases that correspond to $\alpha = k - 1/p$ in Theorem [1.1\(](#page-3-0)i) and $\alpha = k - 1/\beta$ in Theorem 1.1(ii). We think that additional logarithmic rates will appear in these cases, but the precise proofs are a subject of future research.

Remark 2.5. (i) To define the constant $\tilde{\sigma}$ appearing in Theorem [1.2\(](#page-4-0)i) we set

$$
\kappa = \frac{\alpha^{1/(1-\alpha)}}{1-\alpha} \int_0^\infty \Phi(y) y^{-1-1/(1-\alpha)} dy,
$$

where $\Phi(y) := \mathbb{E}[|\tilde{X}_1 + y|^p - |\tilde{X}_1|^p], y \in \mathbb{R}$, and \tilde{X}_t is a linear fractional stable motion defined in [\(2.1\)](#page-6-0) with $c_0 = 1$ and L being a standard symmetric β -stable Lévy process. In addition, set

$$
\tau_{\rho} = \frac{\rho - 1}{\Gamma(2 - \rho)|\cos(\pi \rho/2)|}, \qquad \text{for all } \rho \in (1, 2), \tag{2.4}
$$

where Γ denotes the gamma function. Then,

$$
\tilde{\sigma} = |c_0|^p \sigma^p \left(\frac{\tau_\beta}{\tau_{(1-\alpha)\beta}}\right)^{\frac{1}{(1-\alpha)\beta}} \kappa.
$$

The function $\Phi(y)$ can be computed explicitly, see [\(5.4\)](#page-30-1). This representation shows, in particular, that $\Phi(y) > 0$ for all $y > 0$, and hence the limiting variable S in Theorem [1.2\(](#page-4-0)i) is not degenerate, because $\tilde{\sigma} > 0$.

(ii) The constant η^2 in Theorem [1.2\(](#page-4-0)ii) is given by

$$
\eta^2 = |c_0 \sigma|^{2p} \Big(\theta(0) + 2 \sum_{i=1}^{\infty} \theta(i) \Big), \quad \theta(i) = a_p^{-2} \int_{\mathbb{R}^2} \frac{1}{|s_1 s_2|^{1+p}} \psi_i(s_1, s_2) \, ds_1 \, ds_2, \quad (2.5)
$$

$$
\psi_i(s_1, s_2) = \exp\left(-\int_{\mathbb{R}} |s_1 h_k(x) - s_2 h_k(x+i)|^{\beta} dx\right)
$$

$$
-\exp\left(-\int_{\mathbb{R}} |s_1 h_k(x)|^{\beta} + |s_2 h_k(x+i)|^{\beta} dx\right),
$$

where the function h_k is defined at [\(1.5\)](#page-3-2) and $a_p := \int_{\mathbb{R}} (1 - \exp(iu)) |u|^{-1-p} du$.

Remark 2.6. Let us explain the somewhat complex form of the variance η^2 in [\(2.5\)](#page-12-0). A major problem of proving Theorems $1.2(i)$ is that the covariance structure of stationary summands of $V(p;k)_n$ can not be computed directly. However, the identity

$$
|x|^p = a_p^{-1} \int_{\mathbb{R}} (1 - \exp(iux)) |u|^{-1-p} du \qquad \text{for } p \in (0, 1), \tag{2.6}
$$

which can be shown by substitution $y = ux$ (a_p is defined in Remark 2.5(ii)), turns out to be a useful instrument. Indeed, for any deterministic function $\varphi : \mathbb{R} \to \mathbb{R}$ satisfying $\varphi \in L^{\beta}(\mathbb{R})$, it holds that

$$
\mathbb{E}\left[\exp\left(iu\int_{\mathbb{R}}\varphi(s)\,dL_s\right)\right]=\exp\left(-\sigma^{\beta}|u|^{\beta}\int_{\mathbb{R}}|\varphi(s)|^{\beta}\,ds\right),\tag{2.7}
$$

where $\sigma > 0$ is the scale parameter of L. These two identities are used to compute the variance of the statistic $V(p; k)_n$ and they are both reflected in the formula for the quantity $\theta(i)$ in [\(2.5\)](#page-12-0). \Box

Remark 2.7. A key to the proof of Theorem [1.2\(](#page-4-0)ii) is a quite technical Lemma [6.3,](#page-47-0) which gives an upper bound for the covariances of the summands of $V(p;k)_n$. We do believe that the obtained decay rates, which are explicitly derived in the proofs of Lemma [6.2](#page-45-0) and [6.3,](#page-47-0) are essentially sharp (possibly up to a log rate) and they might be of independent interest. Our estimation method is based upon the identities [\(2.6\)](#page-13-0) and [\(2.7\)](#page-13-1). From this perspective it differs from the typical proofs of asymptotic normality in the framework of discrete moving average (cf. [\[24,](#page-52-9) [25,](#page-52-10) [39\]](#page-53-7)). We also remark that their conditions, translated to continuous time Lévy moving averages, are not satisfied in our setting. \Box

The asymptotic theory of this paper has a variety of potential applications and ex-tensions. Let us first remark that Theorem [1.1](#page-3-0) uniquely identifies the parameters α and β. Notice that the convergence rates of Theorem [1.1\(](#page-3-0)i)–(iii) are all different under the corresponding conditions. Indeed, it holds that

$$
p(\alpha + 1/\beta) - 1 < \alpha p < pk - 1,
$$

since in case (i) we have $\alpha < k-1/p$ and in case (ii) we have $p < \beta$. Hence, computing the statistic $V(p; k)$ _n at log scale for a continuous range of powers p identifies the parameters α and β . More specifically, Theorem [1.1\(](#page-3-0)ii) can be applied directly to estimate the parameter $\alpha + 1/\beta$. Indeed, we immediately obtain the convergence in probability

$$
\frac{\sum_{i=1}^{[n/2]} |X_{\frac{2i}{n}} - X_{\frac{2(i-1)}{n}}|^p}{\sum_{i=1}^n |X_{\frac{i}{n}} - X_{\frac{i-1}{n}}|^p} \xrightarrow{\mathbb{P}} 2^{p(\alpha+1/\beta)-1}
$$

 \Box

under conditions of Theorem [1.1\(](#page-3-0)ii). Thus, a consistent estimator of α (resp. β) can be constructed given the knowledge of β (resp. α) and the validity of conditions $\alpha \in$ $(0, 1 - 1/\beta)$ and $p < \beta$ (similar techniques remain valid for an arbitrary $k \ge 1$). We refer to a recent work [\[22\]](#page-52-13), which applies log statistics of linear fractional stable motion to estimate parameters α and β .

The results of Theorems [1.1](#page-3-0) and [1.2](#page-4-0) can be extended in various directions. One may prove functional convergence for a partial sums formulation of the statistic $V(p; k)_n$ (the reformulation of asymptotic results is then rather obvious). For instance, we immediately obtain uniform convergence in probability in Theorem [1.1\(](#page-3-0)ii) and (iii), because the limits are continuous in time and the statistic is increasing in time. It is likely to deduce the weak convergence towards a Brownian motion, resp. symmetric $(1-\alpha)\beta$ -stable Lévy process, in Theorem [1.2\(](#page-4-0)ii), resp. (i) (cf. e.g. [\[39\]](#page-53-7) for functional limit theorems in the discrete case). The case of Theorem [1.1\(](#page-3-0)i) might be more complicated to handle.

In another direction the limit theory may well be extended to integrals with respect to stationary increments Lévy moving averages (see e.g. $[21]$ for some related results) or to the so called ambit processes, which include an additional multiplicative random input in the definition of the model (1.1) (see [\[7\]](#page-51-10) for the definition, properties and applications of ambit processes). In this context the Bernstein's blocking technique is usually used to extend Theorems [1.1](#page-3-0) and [1.2](#page-4-0) to a more complex setting.

3 Preliminaries

Throughout the following sections all positive constants will be denoted by K , although they may change from line to line. Also the notation might change from subsection to subsection, but the meaning will be clear from the context. Throughout all the next sections we assume, without loss of generality, that $c_0 = \delta = \sigma = 1$. Recall that $g(t) =$ $g_0(t) = 0$ for all $t < 0$ by assumption.

For a sequences of random variables $(Y_n)_{n\in\mathbb{N}}$ defined on the probability space $(\Omega, \mathcal{F}, \mathbb{P})$ we write $Y_n \stackrel{\mathcal{L}-s}{\longrightarrow} Y$ if Y_n converges \mathcal{F} -stably in law to Y, i.e. Y is a random variable defined on an extension of $(\Omega, \mathcal{F}, \mathbb{P})$ such that for all \mathcal{F} -measurable random variables U we have the joint convergence in law $(Y_n, U) \stackrel{d}{\longrightarrow} (Y, U)$. In particular, $Y_n \stackrel{\mathcal{L}-s}{\longrightarrow} Y$ implies $Y_n \stackrel{d}{\longrightarrow} Y$. For $A \in \mathcal{F}$ we will say that $Y_n \stackrel{\mathcal{L}-s}{\longrightarrow} Y$ on A , if $Y_n \stackrel{\mathcal{L}-s}{\longrightarrow} Y$ under $\mathbb{P}_{|A}$, where $\mathbb{P}_{|A}$ denotes the conditionally probability measure $B \mapsto \mathbb{P}(B \cap A)/\mathbb{P}(A)$, when $\mathbb{P}(A) > 0$. We refer to the work [\[1,](#page-51-8) [35\]](#page-53-4) for a detailed exposition of stable convergence. In addition, $\stackrel{\mathbb{P}}{\longrightarrow}$ will denote convergence in probability. We will write $V(Y, p; k)_n = \sum_{i=k}^n |\Delta_{i,k}^n Y|^p$ when we want to stress that the power variation is built from a process Y . On the other hand, when k and p are fixed we will sometimes write $V(Y)_n = V(Y, p; k)_n$ to simplify the notation.

For all $n, i \in \mathbb{N}$ set

$$
g_{i,n}(x) = \sum_{j=0}^{k} (-1)^j {k \choose j} g((i-j)/n-x), \qquad (3.8)
$$

$$
h_{i,n}(x) = \sum_{j=0}^{k} (-1)^j {k \choose j} ((i-j)/n-x)_+^{\alpha}, \qquad (3.9)
$$

$$
g_n(x) = n^{\alpha} g(x/n), \qquad x \in \mathbb{R}.
$$
\n(3.10)

In addition, for each function $\phi \colon \mathbb{R} \to \mathbb{R}$ define $D^k \phi \colon \mathbb{R} \to \mathbb{R}$ by

$$
D^{k}\phi(x) = \sum_{j=0}^{k} (-1)^{j} {k \choose j} \phi(x-j), \qquad x \in \mathbb{R}.
$$
 (3.11)

In this notation the function h_k , defined in [\(1.5\)](#page-3-2), is given by $h_k = D^k \phi$ with $\phi: x \mapsto x_+^{\alpha}$.

Lemma 3.1. Assume that g satisfies condition (A) . Then we obtain the following estimates

$$
|g_{i,n}(x)| \le K(i/n - x)^{\alpha}, \qquad x \in [(i-k)/n, i/n], \tag{3.12}
$$

$$
|g_{i,n}(x)| \le Kn^{-k}((i-k)/n-x)^{\alpha-k}, \qquad x \in (i/n-1, (i-k)/n), \tag{3.13}
$$

$$
|g_{i,n}(x)| \le Kn^{-k} \left(\mathbb{1}_{[(i-k)/n-1,i/n-1]}(x) + g^{(k)}((i-k)/n-x) \mathbb{1}_{(-\infty,(i-k)/n-1)}(x) \right), (3.14)
$$

 $x \in (-\infty, i/n-1].$

The same estimates trivially hold for the function $h_{i,n}$.

Proof. The inequality (3.12) follows directly from condition (1.4) of (A) . The second inequality (3.13) is a straightforward consequence of Taylor expansion of order k and the condition $|g^{(k)}(t)| \leq K t^{\alpha-k}$ for $t \in (0,1)$. The third inequality [\(3.14\)](#page-15-3) follows again through Taylor expansion and the fact that the function $g^{(k)}$ is decreasing on $(1, \infty)$.

4 Proof of Theorem [1.1](#page-3-0)

In this section we will prove the assertions of Theorem [1.1.](#page-3-0)

4.1 Proof of Theorem [1.1\(](#page-3-0)i)

The proof of Theorem $1.1(i)$ is divided into the following three steps. In Step (i) we show Theorem [1.1\(](#page-3-0)i) for the compound Poisson case, which stands for the treatment of big jumps of L. Step (ii) consists of an approximating lemma, which proves that the small jumps of L are asymptotically negligible. Step (iii) combines the previous results to obtain the general theorem.

Before proceeding with the proof we will need the following preliminary lemma. Let ${x \in x - |x| \in [0,1)}$ denote the fractional part of $x \in \mathbb{R}$. The lemma below seems to be essentially known (cf. [\[20,](#page-52-14) [42\]](#page-53-10)), however, we have not been able to find this particular formulation. Therefore it is stated below for completeness.

Lemma 4.1. For $d \geq 1$ let $V = (V_1, \ldots, V_d)$ be an absolutely continuous random vector in \mathbb{R}^d with a density $v : \mathbb{R}^d \to \mathbb{R}_+$. Suppose that there exists an open convex set $A \subseteq \mathbb{R}^d$ such that v is continuous differentiable on A and vanish outside A. Then, as $n \to \infty$,

$$
(\{nV_1\},\ldots,\{nV_d\}) \stackrel{\mathcal{L}-s}{\longrightarrow} U = (U_1,\ldots,U_d)
$$

where U_1, \ldots, U_d are independent $\mathcal{U}([0,1])$ -distributed random variables which are independent of F.

Proof. For $x = (x_1, \ldots, x_d) \in \mathbb{R}^k$ let $\{x\} = (\{x_1\}, \ldots, \{x_d\})$ be the fractional parts of its components. Let $f : \mathbb{R}^d \times \mathbb{R}^d \to \mathbb{R}$ be a C^1 -function which vanish outside some closed ball in $A \times \mathbb{R}^d$. We claim that for all $\rho > 0$ there exists a constant $K > 0$ such that

$$
D_{\rho} := \Big| \int_{\mathbb{R}^d} f(x, \{x/\rho\}) v(x) dx - \int_{\mathbb{R}^k} \Big(\int_{[0,1]^d} f(x, u) du \Big) v(x) dx \Big| \le K\rho. \tag{4.1}
$$

Indeed, by [\(4.1\)](#page-16-0) used for $\rho = 1/n$ we obtain that

$$
\mathbb{E}[f(V,\{nV\})] \to \mathbb{E}[f(V,U)] \quad \text{as } n \to \infty,
$$
\n(4.2)

with $U = (U_1, \ldots, U_d)$ given in the lemma. Moreover, due to [\[1,](#page-51-8) Proposition 2(D")], [\(4.2\)](#page-16-1) implies the stable convergence $\{nV\} \stackrel{\mathcal{L}-s}{\longrightarrow} U$ as $n \to \infty$, and the proof is complete. Thus, it only remains to prove the inequality [\(4.1\)](#page-16-0). At this stage we use a similar technique as in [\[20,](#page-52-14) Lemma 6.1].

Define $\phi(x, u) := f(x, u)v(x)$. Then it holds by substitution that

$$
\int_{\mathbb{R}^d} f(x, \{x/\rho\}) v(x) dx = \sum_{j \in \mathbb{Z}^d} \int_{(0,1]^d} \rho^d \phi(\rho j + \rho u, u) du
$$

and

$$
\int_{\mathbb{R}^d} \Big(\int_{[0,1]^d} f(x, u) \, du \Big) v(x) \, dx = \sum_{j \in \mathbb{Z}^d} \int_{[0,1]^d} \Big(\int_{(\rho j, \rho(j+1)]} \phi(x, u) \, dx \Big) \, du.
$$

Hence, we conclude that

$$
D_{\rho} \leq \sum_{j \in \mathbb{Z}^d} \int_{(0,1]^d} \Big| \int_{(\rho j, \rho(j+1)]} \phi(x, u) dx - \rho^d \phi(\rho j + \rho u, u) \Big| du
$$

$$
\leq \sum_{j \in \mathbb{Z}^d} \int_{(0,1]^d} \int_{(\rho j, \rho(j+1)]} \Big| \phi(x, u) - \phi(\rho j + \rho u, u) \Big| dx du.
$$

By mean value theorem there exists a positive constant K and a compact set $B \subseteq \mathbb{R}^d \times \mathbb{R}^d$ such that for all $j \in \mathbb{Z}^d$, $x \in (\rho j, \rho(j+1)]$ and $u \in (0, 1]^d$ we have

$$
\left|\phi(x,u) - \phi(\rho j + \rho u, u)\right| \le K\rho \mathbb{1}_B(x, u).
$$

Thus, $D_{\rho} \leq K\rho \int_{(0,1]^d} \int_{\mathbb{R}^d} \mathbb{1}_B(x, u) dx du$, which shows [\(4.1\)](#page-16-0).

Step (i): The compound Poisson case. Let $L = (L_t)_{t \in \mathbb{R}}$ be a compound Poisson process and let $0 \leq T_1 < T_2 < \ldots$ denote the jump times of the Lévy process $(L_t)_{t>0}$ chosen in increasing order. Consider a fixed $\epsilon > 0$ and let $n \in \mathbb{N}$ satisfy $\varepsilon > n^{-1}$. We define

$$
\Omega_{\varepsilon} := \left\{ \omega \in \Omega : \text{for all } k \ge 1 \text{ with } T_k(\omega) \in [0, 1] \text{ we have } |T_k(\omega) - T_{k-1}(\omega)| > \varepsilon/2 \text{ and } \Delta L_s = 0 \text{ for all } s \in [-\epsilon, 0] \right\}.
$$

Notice that $\Omega_{\varepsilon} \uparrow \Omega$ as $\varepsilon \downarrow 0$. Now, we decompose for $i = k, \ldots, n$

$$
\Delta_{i,k}^n X = M_{i,n,\varepsilon} + R_{i,n,\varepsilon},
$$

where

$$
M_{i,n,\varepsilon} = \int_{\frac{i}{n}-\varepsilon/2}^{\frac{i}{n}} g_{i,n}(s) dL_s, \qquad R_{i,n,\varepsilon} = \int_{-\infty}^{\frac{i}{n}-\varepsilon/2} g_{i,n}(s) dL_s,
$$

and the function $g_{i,n}$ is introduced in [\(3.8\)](#page-15-4). The term $M_{i,n,\varepsilon}$ represents the dominating quantity, while $R_{i,n,\varepsilon}$ turns out to be negligible.

The dominating term: We claim that on Ω_{ϵ} and as $n \to \infty$,

$$
n^{\alpha p} \sum_{i=k}^{n} |M_{i,n,\epsilon}|^p \stackrel{\mathcal{L}-s}{\longrightarrow} Z \quad \text{where} \quad Z = \sum_{m:\,T_m \in (0,1]} |\Delta L_{T_m}|^p V_m, \tag{4.3}
$$

where V_m , $m \geq 1$, are defined in [\(1.6\)](#page-4-1). To show [\(4.3\)](#page-17-0) let $i_m = i_m(\omega, n)$ denote the (random) index such that $T_m \in ((i_m - 1)/n, i_m/n]$. The following representation will be crucial: On Ω_{ε} we have that

$$
n^{\alpha p} \sum_{i=k}^{n} |M_{i,n,\varepsilon}|^p = V_{n,\varepsilon} \qquad \text{with}
$$
\n
$$
V_{n,\varepsilon} = n^{\alpha p} \sum_{m:\,T_m \in (0,1]} |\Delta L_{T_m}|^p \left(\sum_{l=0}^{[\varepsilon n/2] + v_m} |g_{i_m+l,n}(T_m)|^p \right)
$$
\n(4.4)

where the random index $v_m = v_m(\omega, n, \epsilon)$ are given by $v_m = 0$ if $(\epsilon n/2 + i_m)/n - \epsilon/2 < T_m$ and $v_m = -1$ else. Indeed, on Ω_{ϵ} and for each $i = k, \ldots, n, L$ has at most one jump in $(i/n - \epsilon/2, i/n]$. For each $m \in \mathbb{N}$ with $T_m \in (0, 1]$ we have $T_m \in (i/n - \epsilon/2, i/n]$ if and only if $i \in \{i_m, \ldots, [\epsilon n/2] + i_m + v_m\}$ (recall that $\epsilon > n^{-1}$). Thus,

$$
\sum_{i \in \{k,\dots,n\} : T_m \in (i/n - \epsilon/2, i/n]} |M_{i,n,\varepsilon}|^p = |\Delta L_{T_m}|^p \left(\sum_{l=0}^{[\varepsilon n/2] + v_m} |g_{i_m + l, n}(T_m)|^p \right) \tag{4.5}
$$

 \Box

$$
V_{n,\epsilon} \xrightarrow{\mathcal{L}-s} Z \qquad \text{as } n \to \infty.
$$

For $d \geq 1$ it is well-known that the random vector (T_1, \ldots, T_d) is absolutely continuous with a C¹-density on the open convex set $A := \{(x_1, \ldots, x_d) \in \mathbb{R}^d : 0 < x_1 < x_2 < \cdots < x_d\}$ which is vanishing outside A , and thus, by Lemma [4.1](#page-16-2) we have

$$
(\{nT_m\})_{m \le d} \xrightarrow{\mathcal{L}-s} (U_m)_{m \le d} \qquad \text{as } n \to \infty \tag{4.6}
$$

where $(U_i)_{i\in\mathbb{N}}$ are i.i.d. $\mathcal{U}([0,1])$ -distributed random variables. By [\(1.4\)](#page-3-3) we may write $g(x) = x^{\alpha}_+ f(x)$ where $f : \mathbb{R} \to \mathbb{R}$ satisfies $f(x) \to 1$ as $x \downarrow 0$. By definition of i_m we have that ${nT_m} = i_m - nT_m$ and therefore for all $l = 0, 1, 2, \dots$ and $j = 0, \dots, k$,

$$
n^{\alpha}g\left(\frac{l+i_m-j}{n} - T_m\right) = n^{\alpha}\left(\frac{l+i_m-j}{n} - T_m\right)_{+}^{\alpha}f\left(\frac{l+i_m-j}{n} - T_m\right)
$$

= $\left(l-j+(i_m-nT_m)\right)_{+}^{\alpha}f\left(\frac{l-j}{n} + n^{-1}(i_m-nT_m)\right)$
= $\left(l-j+\left\{nT_m\right\}\right)_{+}^{\alpha}f\left(\frac{l-j}{n} + n^{-1}\left\{nT_m\right\}\right),$

which by [\(4.6\)](#page-18-0) and $f(x) \to 1$ as $x \downarrow 0$ shows that

$$
\left\{ n^{\alpha} g \left(\frac{l + i_m - j}{n} - T_m \right) \right\}_{l,m \le d} \xrightarrow{\mathcal{L} - s} \left\{ \left(l - j + U_m \right)_{+}^{\alpha} \right\}_{l,m \le d} \quad \text{as } n \to \infty. \tag{4.7}
$$

Eq. [\(4.7\)](#page-18-1) implies that

$$
\left\{n^{\alpha}g_{i_{m}+l,n}(T_{m})\right\}_{l,m\le d} \xrightarrow{\mathcal{L}-s} \left\{h_{k}(l+U_{m})\right\}_{l,m\le d},\tag{4.8}
$$

with h_k being defined at [\(1.5\)](#page-3-2). Due to the *F*-stable convergence in [\(4.8\)](#page-18-2) we obtain by the continuous mapping theorem that for each fixed $d\geq 1$ and as $n\to\infty,$

$$
V_{n,\epsilon,d} := n^{\alpha p} \sum_{m:\,m \leq d,\,T_m \in [0,1]} |\Delta L_{T_m}|^p \left(\sum_{l=0}^{\lfloor \epsilon d/2 \rfloor + v_m} |\Delta_{i_m+l,k}^n g(T_m)|^p \right)
$$

$$
\xrightarrow{\mathcal{L}-s} Z_d = \sum_{m:\,m \leq d,\,T_m \in [0,1]} |\Delta L_{T_m}|^p \left(\sum_{l=0}^{\lfloor \epsilon d/2 \rfloor + v_m} |h_k(l+U_m)|^p \right).
$$

Moreover, for $\omega \in \Omega$ we have as $d \to \infty$,

$$
Z_d(\omega) \uparrow Z(\omega).
$$

Recall that $|h_k(x)| \leq K(x-k)^{\alpha-k}$ for $x > k+1$, which implies that $Z < \infty$ a.s. since $p(\alpha - k) < -1$. For all $l \in \mathbb{N}$ with $k \leq l \leq n$, we have

$$
n^{\alpha p}|g_{i_m+l,n}(T_m)|^p \le K|l-k|^{(\alpha-k)p},\tag{4.9}
$$

due to [\(3.13\)](#page-15-2) of Lemma [3.1.](#page-15-5) For all $d \geq 0$ set $C_d = \sum_{m > d: T_m \in [0,1]} |\Delta L_{T_m}|^p$ and note that $C_d \rightarrow 0$ a.s. as $d \rightarrow \infty$ since L is a compound Poisson process. By [\(4.9\)](#page-18-3) we have

$$
|V_{n,\epsilon} - V_{n,\epsilon,d}| \le K\Big(C_d + C_0 \sum_{l = [\epsilon d/2]-1}^{\infty} |l - k|^{p(\alpha - k)}\Big) \to 0 \quad \text{as } d \to \infty
$$

since $p(\alpha - k) < -1$. Due to the fact that $n^{\alpha p} \sum_{i=k}^{n} |M_{i,n,\varepsilon}|^p = V_{n,\varepsilon}$ a.s. on Ω_{ε} and $V_{n,\epsilon} \stackrel{\mathcal{L}-s}{\longrightarrow} Z$, it follows that $n^{\alpha p} \sum_{i=k}^{n} |M_{i,n,\epsilon}|^p \stackrel{\mathcal{L}-s}{\longrightarrow} Z$ on Ω_{ϵ} , since $\Omega_{\epsilon} \in \mathcal{F}$. This proves $(4.3).$ $(4.3).$

The rest term: In the following we will show that

$$
n^{\alpha p} \sum_{i=k}^{n} |R_{i,n,\epsilon}|^p \stackrel{\mathbb{P}}{\longrightarrow} 0 \quad \text{as } n \to \infty.
$$
 (4.10)

The fact that the random variables in [\(4.10\)](#page-19-0) are usually not integrable makes the proof of [\(4.10\)](#page-19-0) considerable more complicated. Similar as in [\(3.14\)](#page-15-3) of Lemma [3.1](#page-15-5) we have that

$$
n^{k}|g_{i,n}(s)|1_{\{s\leq i/n-\epsilon\}} \leq K\left(1_{\{s\in[-1,1]\}}+\mathbb{1}_{\{s<-1\}}|g^{(k)}(-s)|\right) =:\psi(s)
$$

where $K = K_{\epsilon}$. We will use the function ψ several times in the proof of [\(4.10\)](#page-19-0), which will be divided into the two special cases $\theta \in (0, 1]$ and $\theta \in (1, 2]$.

Suppose first that $\theta \in (0,1]$. To show (4.10) it suffices to show that

$$
\sup_{n \in \mathbb{N}, i \in \{k, \dots, n\}} n^k |R_{i, n, \epsilon}| < \infty \qquad \text{a.s.} \tag{4.11}
$$

since $\alpha < k - 1/p$. To show [\(4.11\)](#page-19-1) we will first prove that

$$
\int_{\mathbb{R}} \int_{\mathbb{R}} \left(|\psi(s)x| \wedge 1 \right) \nu(dx) \, ds < \infty. \tag{4.12}
$$

Choose \tilde{K} such that $\psi(x) \leq \tilde{K}$ for all $x \in \mathbb{R}$. For $u \in [-\tilde{K}, \tilde{K}]$ we have that

$$
\int_{\mathbb{R}} \left(|ux| \wedge 1 \right) \nu(dx) \le K \int_{1}^{\infty} \left(|xu| \wedge 1 \right) x^{-1-\theta} dx
$$
\n
$$
\le \begin{cases} K|u|^{\theta} & \theta \in (0,1) \\ K|u|^{\theta} \log(1/u) & \theta = 1, \end{cases} \tag{4.13}
$$

where we have used that $\theta \leq 1$. By [\(4.13\)](#page-19-2) applied to $u = \psi(s)$ and assumption (A) it follows that (4.12) is satisfied. Since L is a symmetric compound Poisson process we can find a Poisson random measure μ with compensator $\lambda \otimes \nu$ such that for all $-\infty < u < t$ $\infty, L_t - L_u = \int_{(u,t] \times \mathbb{R}} x \,\mu(ds, dx)$. Due to [\[28,](#page-52-15) Theorem 10.15], [\(4.12\)](#page-19-3) ensures the existence of the stochastic integral $\int_{\mathbb{R}\times\mathbb{R}}|\psi(s)x|\,\mu(ds,dx)$. Moreover, $\int_{\mathbb{R}\times\mathbb{R}}|\psi(s)x|\,\mu(ds,dx)$ can be regarded as an ω by ω integral with respect to the measure μ_{ω} . Now, we have that

$$
|n^k R_{i,n,\epsilon}| \le \int_{(-\infty,i/n-\epsilon] \times \mathbb{R}} |n^k g_{i,n}(s)x| \,\mu(ds,dx) \le \int_{\mathbb{R} \times \mathbb{R}} |\psi(s)x| \,\mu(ds,dx) < \infty, \quad (4.14)
$$

which shows (4.11) , since the right-hand side of (4.14) does not depend on i and n.

Suppose that $\theta \in (1, 2]$. Similarly as before it suffices to show that

$$
\sup_{n \in \mathbb{N}, i \in \{k, ..., n\}} \frac{n^k |R_{i, n, \epsilon}|}{(\log n)^{1/q}} < \infty \qquad \text{a.s.} \tag{4.15}
$$

where $q > 1$ denotes the conjugated number to $\theta > 1$ determined by $1/\theta + 1/q = 1$. In the following we will show [\(4.15\)](#page-20-0) using the majorizing measure techniques developed in [\[31\]](#page-53-11). In fact, our arguments are closely related to their Section 4.2. Set $T = \{(i, n): n \geq k, i =$ k, \ldots, n . For $(i, n) \in T$ we have

$$
\frac{n^k |R_{i,n,\epsilon}|}{(\log n)^{1/q}} = \Big| \int_{\mathbb{R}} \zeta_{i,n}(s) dL_s \Big|, \qquad \zeta_{i,n}(s) := \frac{n^k}{(\log n)^{1/q}} g_{i,n}(s) \mathbb{1}_{\{s \le i/n - \epsilon\}}.
$$

For $t = (i, n) \in T$ we will sometimes write $\zeta_t(s)$ for $\zeta_{i,n}(s)$. Let $\tau: T \times T \to \mathbb{R}_+$ denote the metric given by

$$
\tau((i,n),(j,m)) = \begin{cases} \log(n-k+1)^{-1/q} + \log(m-k+1)^{-1/q} & (i,n) \neq (j,l) \\ 0 & (i,n) = (j,l). \end{cases}
$$

Moreover, let m be the probability measure on T given by $m(\{(i,n)\}) = Kn^{-3}$ for a suitable constant $K > 0$. Set $B_{\tau}(t, r) = \{s \in T : \tau(s,t) \leq r\}$ for $t \in T$, $r > 0$, $D =$ $\sup\{\tau(s,t): s,t \in T\}$ and

$$
I_q(m, \tau; D) = \sup_{t \in T} \int_0^D \left(\log \frac{1}{m(B_\tau(t, r))} \right)^{1/q} dr.
$$

In the following we will show that m is a so-called majorizing measure, which means that $I_q(m, \tau, D) < \infty$. For $r < (\log(n - k + 1))^{-1/q}$ we have $B_\tau((i, n), r) = \{(i, n)\}.$ Therefore, $m(B_{\tau}((i, n), r)) = Kn^{-3}$ and

$$
\int_0^{(\log(n-k+1))^{-1/q}} \left(\log \frac{1}{m(B_\tau((i,n),r))} \right)^{1/q} dr = \int_0^{(\log(n-k+1))^{-1/q}} \left(3 \log n + \log K \right)^{1/q} dr. \tag{4.16}
$$

For all $r \geq (\log(n-k+1))^{-1/q}, (k,k) \in B_{\tau}((i,n),r)$ and hence $m(B_{\tau}((i,n),r)) \geq$ $m({(k,k)} = K(k+1)^{-3}$. Therefore,

$$
\int_{(\log(n-k+1))^{-1/q}}^D \left(\log \frac{1}{m(B_\tau((i,n),r))} \right)^{1/q} dr \tag{4.17}
$$
\n
$$
\leq \int_{(\log(n-k+1))^{-1/q}}^D \left(3 \log(k+1) + \log K \right)^{1/q} dr.
$$

By [\(4.16\)](#page-20-1) and [\(4.17\)](#page-20-2) it follows that $I_q(m, \tau, D) < \infty$. For $(i, n) \neq (j, l)$ we have that

$$
\frac{|\zeta_{i,n}(s) - \zeta_{j,l}(s)|}{\tau((i,n),(j,l))} \le n^k |g_{i,n}(s)| \mathbb{1}_{\{s \le i/n - \epsilon\}} + l^k |g_{j,l}(s)| \mathbb{1}_{\{s \le j/l - \epsilon\}} \le K\psi(s). \tag{4.18}
$$

Fix $t_0 \in T$ and consider the following Lipschitz type norm of ζ ,

$$
\|\zeta\|_{\tau}(s) = D^{-1}|\zeta_{t_0}(s)| + \sup_{\substack{t_1, t_2 \in T:\\ \tau(t_1, t_2) \neq 0}} \frac{|\zeta_{t_1}(s) - \zeta_{t_2}(s)|}{\tau(t_1, t_2)}.
$$

By [\(4.18\)](#page-20-3) it follows that $\|\zeta\|_{\tau}(s) \leq K\psi(s)$ and hence

$$
\int_{\mathbb{R}} \|\zeta\|_{\tau}^{\theta}(s) ds \le K \left(2 + \int_{1}^{\infty} |g^{(k)}(s)|^{\theta} ds \right) < \infty.
$$
 (4.19)

By [\[31,](#page-53-11) Theorem 3.1, Eq. (3.11)] together with $I_q(m, \tau, D) < \infty$ and [\(4.19\)](#page-21-0) we deduce [\(4.15\)](#page-20-0), which completes the proof of [\(4.10\)](#page-19-0).

End of the proof: Recall the decomposition $\Delta_{i,n}^n X = M_{i,n,\epsilon} + R_{i,n,\epsilon}$ in [\(4.1\)](#page-16-1). Eq. [\(4.3\)](#page-17-0), [\(4.10\)](#page-19-0) and an application of Minkowski inequality yield that

$$
n^{\alpha p} V(p;k)_n \xrightarrow{\mathcal{L}-s} Z \qquad \text{on } \Omega_{\epsilon} \text{ as } n \to \infty. \tag{4.20}
$$

Since $\Omega_{\epsilon} \uparrow \Omega$ as $\epsilon \to 0$, [\(4.20\)](#page-21-1) implies that

$$
n^{\alpha p}V(p;k)_n \xrightarrow{\mathcal{L}-s} Z.
$$

We have now completed the proof for a particular choice of stopping times $(T_m)_{m>1}$, however, the result remains valid for any choice of F-stopping times, since the distribution of Z is invariant with respect to reordering of stopping times. \Box

Step (ii): An approximation. To prove Theorem [1.1\(](#page-3-0)i) in the general case we need the following approximation result. Consider a general symmetric Lévy process $L = (L_t)_{t \in \mathbb{R}}$ as in Theorem [1.1\(](#page-3-0)i) and let N be the corresponding Poisson random measure $N(A) := \frac{\mu}{k!} t$: $(t, \Delta L_t) \in A$ for all measurable $A \subseteq \mathbb{R} \times (\mathbb{R} \setminus \{0\})$. By our assumptions (in particular, by symmetry), the process $X(j)$ given by

$$
X_t(j) = \int_{(-\infty,t] \times [-\frac{1}{j},\frac{1}{j}]} \left\{ (g(t-s) - g_0(-s))x \right\} N(ds,dx) \tag{4.21}
$$

is well-defined. The following estimate on the processes $X(j)$ will be crucial:

Lemma 4.2. Suppose that $\alpha < k - 1/p$ and $\beta < p$. Then

$$
\lim_{j \to \infty} \limsup_{n \to \infty} \mathbb{P}\big(n^{\alpha p} V(X(j))_n > \epsilon\big) = 0 \quad \text{for all } \epsilon > 0.
$$

Proof. By Markov's inequality and the stationary increments of $X(j)$ we have that

\mathbb{P}(n^{\alpha p}V(X(j))_n > \epsilon) \leq \epsilon^{-1}n^{\alpha p}\sum_{i=k}^n \mathbb{E}[\Delta_{i,k}^n X(j)|^p] \leq \epsilon^{-1}n^{\alpha p+1}\mathbb{E}[\Delta_{k,k}^n X(j)|^p].
$$

Hence it is enough to show that

$$
\lim_{j \to \infty} \limsup_{n \to \infty} \mathbb{E}[|Y_{n,j}|^p] = 0 \quad \text{with} \quad Y_{n,j} := n^{\alpha+1/p} \Delta_{k,k}^n X(j). \tag{4.22}
$$

To show [\(4.22\)](#page-21-2) it sufficers to show

$$
\lim_{j \to \infty} \limsup_{n \to \infty} \xi_{n,j} = 0 \quad \text{where} \quad \xi_{n,j} = \int_{|x| \le 1/j} \chi_n(x) \nu(dx) \text{ and}
$$
\n
$$
\chi_n(x) = \int_{-\infty}^{k/n} \left(|n^{\alpha+1/p} g_{k,n}(s) x|^p 1_{\{|n^{\alpha+1/p} g_{k,n}(s) x| \ge 1\}} \right)
$$
\n
$$
+ |n^{\alpha+1/p} g_{k,n}(s) x|^2 1_{\{|n^{\alpha+1/p} g_{k,n}(s) x| \le 1\}} ds,
$$

which follows from the representation

$$
Y_{n,j} = \int_{\left(-\infty, k/n\right] \times \left[-\frac{1}{j}, \frac{1}{j}\right]} \left(n^{\alpha+1/p} g_{k,n}(s)x\right) N(ds, dx),
$$

and by [\[34,](#page-53-8) Theorem 3.3 and the remarks above it]. Suppose for the moment that there exists a finite constant $K > 0$ such that

$$
\chi_n(x) \le K(|x|^p + x^2) \qquad \text{for all } x \in [-1, 1]. \tag{4.23}
$$

Then,

$$
\limsup_{j \to \infty} \left\{ \limsup_{n \to \infty} \xi_{n,j} \right\} \le K \limsup_{j \to \infty} \int_{|x| \le 1/j} (|x|^p + x^2) \nu(dx) = 0
$$

since $p > \beta$. Hence it suffices to show the estimate [\(4.23\)](#page-22-0), which we will do in the following.

Let $\Phi_p: \mathbb{R} \to \mathbb{R}_+$ denote the function $\Phi_p(y) = |y|^2 \mathbb{1}_{\{|y| \leq 1\}} + |y|^p \mathbb{1}_{\{|y| > 1\}}$. We split χ_n into the following three terms which need different treatments

\chi_n(x) = \int_{-k/n}^{k/n} \Phi_p\left(n^{\alpha+1/p} g_{k,n}(s)x\right) ds + \int_{-1}^{-k/n} \Phi_p\left(n^{\alpha+1/p} g_{k,n}(s)x\right) ds + \int_{-\infty}^{-1} \Phi_p\left(n^{\alpha+1/p} g_{k,n}(s)x\right) ds =: I_{1,n}(x) + I_{2,n}(x) + I_{3,n}(x).
$$

Estimation of $I_{1,n}$: By [\(3.12\)](#page-15-1) of Lemma [3.1](#page-15-5) we have that

$$
|g_{k,n}(s)| \le K(k/n - s)^{\alpha}, \qquad s \in [-k/n, k/n]. \tag{4.24}
$$

Since Φ_p is increasing on \mathbb{R}_+ , [\(4.24\)](#page-22-1) implies that

$$
I_{1,n}(x) \le K \int_0^{2k/n} \Phi_p\left(x n^{\alpha+1/p} s^{\alpha}\right) ds. \tag{4.25}
$$

By basic calculus it follows that

$$
\int_{0}^{2k/n} |x n^{\alpha+1/p} s^{\alpha}|^{2} \mathbb{1}_{\{|x n^{\alpha+1/p} s^{\alpha}| \le 1\}} ds
$$

\n
$$
\le K \Big(\mathbb{1}_{\{|x| \le (2k)^{-\alpha} n^{-1/p}\}} x^{2} n^{2/p-1} + \mathbb{1}_{\{|x| > (2k)^{-\alpha} n^{-1/p}\}} |x|^{-1/\alpha} n^{-1-1/(\alpha p)} \Big)
$$

\n
$$
\le K (|x|^p + x^2).
$$
\n(4.26)

$$
\int_0^{2k/n} |x n^{\alpha+1/p} s^{\alpha}|^p 1_{\{|x n^{\alpha+1/p} s^{\alpha}|>1\}} ds \le \int_0^{2k/n} |x n^{\alpha+1/p} s^{\alpha}|^p ds \le K|x|^p. \tag{4.27}
$$

Combining [\(4.25\)](#page-22-2), [\(4.26\)](#page-22-3) and [\(4.27\)](#page-23-0) show the estimiate $I_{1,n}(x) \le K(|x|^p + x^2)$. *Estimation of* $I_{2,n}$: By [\(3.13\)](#page-15-2) of Lemma [3.1](#page-15-5) it holds that

|g_{k,n}(s)| \le Kn^{-k} |s|^{\alpha - k}, \qquad s \in (-1, -k/n). \tag{4.28}
$$

Again, due to the fact that Φ_p is increasing on \mathbb{R}_+ , [\(4.28\)](#page-23-1) implies that

I_{2,n}(x) \le K \int_{k/n}^{1} \Phi_p(xn^{\alpha+1/p-k} s^{\alpha-k}) ds.

 (4.29)

For $\alpha \neq k - 1/2$ we have

$$
\int_{k/n}^{1} |x n^{\alpha+1/p-k} s^{\alpha-k}|^{2} \mathbb{1}_{\{|x n^{\alpha+1/p-k} s^{\alpha-k}| \le 1\}} ds
$$
\n
$$
\le K \Big(x^{2} n^{2(\alpha+1/p-k)} + \mathbb{1}_{\{|x| \le n^{-1/p} k^{-(\alpha-k)}\}} |x|^{2} n^{2/p-1}
$$
\n
$$
+ \mathbb{1}_{\{|x| > n^{-1/p} k^{-(\alpha-k)}\}} |x|^{1/(k-\alpha)} n^{1/(p(k-\alpha))-1} \Big)
$$
\n
$$
\le K \Big(x^{2} + |x|^{p} \Big) \tag{4.30}
$$

where we have used that $\alpha < k - 1/p$. For $\alpha = k - 1/2$ we have

$$
\int_{k/n}^{1} |x n^{\alpha+1/p-k} s^{\alpha-k}|^2 1_{\{|x n^{\alpha+1/p-k} s^{\alpha-k}| \le 1\}} ds
$$

$$
\le x^2 n^{2(\alpha+1/p-k)} \int_{k/n}^{1} s^{-1} ds = x^2 n^{2(\alpha+1/p-k)} \log(n/k) \le K x^2,
$$
 (4.31)

where we again have used $\alpha < k - 1/p$ in the last inequality. Moreover,

$$
\int_{k/n}^{1} |x n^{\alpha+1/p-k} s^{\alpha-k} |^{p} \mathbb{1}_{\{|x n^{\alpha+1/p-k} s^{\alpha-k}|>1\}} ds
$$
\n
$$
\leq K |x|^{p} n^{p(\alpha+1/p-k)} \left(1 + (1/n)^{p(\alpha-k)+1}\right) \leq K |x|^{p}.
$$
\n(4.32)

By [\(4.29\)](#page-23-2), [\(4.30\)](#page-23-3), [\(4.31\)](#page-23-4) and [\(4.32\)](#page-23-5) we obtain the estimate $I_{2,n}(x) \le K(|x|^p + x^2)$. *Estimation of* $I_{3,n}$: For $s < -1$ we have that $|g_{k,n}(s)| \leq Kn^{-k}|g^{(k)}(-k/n - s)|$, by [\(3.14\)](#page-15-3) of Lemma [3.1,](#page-15-5) and hence

$$
I_{3,n}(x) \le K \int_1^\infty \Phi_p(n^{\alpha+1/p-k} g^{(k)}(s)) ds.
$$
 (4.33)

We have that

$$
\int_{1}^{\infty} |x n^{\alpha+1/p-k} g^{(k)}(s)|^{2} \mathbb{1}_{\{|x n^{\alpha+1/p-k} g^{(k)}(s)| \le 1\}} ds \le x^{2} n^{2(\alpha+1/p-k)} \int_{1}^{\infty} |g^{(k)}(s)|^{2} ds. \tag{4.34}
$$

Since $|g^{(k)}|$ is decreasing on $(1,\infty)$ and $g^{(k)} \in L^{\theta}((1,\infty))$ for some $\theta \leq 2$, the integral on the right-hand side of [\(4.34\)](#page-23-6) is finite. For $x \in [-1, 1]$ we have

$$
\int_{1}^{\infty} |x n^{\alpha+1/p-k} g^{(k)}(s)|^{p} \mathbb{1}_{\{|x n^{\alpha+1/p-k} g^{(k)}(s)|>1\}} ds
$$

$$
\leq |x|^{p} n^{p(\alpha+1/p-k)} \int_{1}^{\infty} |g^{(k)}(s)|^{p} \mathbb{1}_{\{|g^{(k)}(s)|>1\}} ds.
$$
 (4.35)

From our assumptions it follows that the integral in [\(4.35\)](#page-24-0) is finite. By [\(4.33\)](#page-23-7), [\(4.34\)](#page-23-6) and [\(4.35\)](#page-24-0) we have that $I_{n,3}(x) \leq K(|x|^p + x^2)$ for all $x \in [-1,1]$, which completes the proof of [\(4.23\)](#page-22-0) and therefore also the proof of the lemma.

Step (iii): The general case. In the following we will prove Theorem [1.1\(](#page-3-0)i) in the general case by combining the above Steps (i) and (ii).

Proof of Theorem [1.1\(](#page-3-0)i). Let $(T_m)_{m>1}$ be a sequence of F-stopping times that exhaust the jumps of $(L_t)_{t\geq0}$. For each $j \in \mathbb{N}$ let $\hat{L}(j)$ be the Lévy process given by

$$
\hat{L}_t(j) - \hat{L}_u(j) = \sum_{u \in (s,t]} \Delta L_u \mathbb{1}_{\{|\Delta L_u| > \frac{1}{j}\}}, \qquad s < t,
$$

and set

$$
\hat{X}_t(j) = \int_{-\infty}^t \left(g(t-s) - g_0(-s) \right) d\hat{L}_s(j).
$$

Moreover, set

$$
T_{m,j} = \begin{cases} T_m & \text{if } |\Delta L_{T_m}| > \frac{1}{j} \\ \infty & \text{else,} \end{cases}
$$

and note that $(T_{m,j})_{m\geq 1}$ is a sequence of F-stopping times that exhausts the jumps of $(\hat{L}_t(j))_{t\geq 0}$. Since $\hat{L}(j)$ is a compound Poisson process, Step 1 shows that

$$
n^{\alpha p} V(\hat{X}(j))_n \xrightarrow{\mathcal{L}-s} Z_j := \sum_{m: T_{m,j} \in [0,1]} |\Delta \hat{L}_{T_{m,j}}(j)|^p V_m \quad \text{as } n \to \infty,
$$
 (4.36)

where V_m , $m \geq 1$, are defined in [\(1.6\)](#page-4-1). By definition of $T_{m,j}$ and monotone convergence we have as $j \to \infty$,

$$
Z_j = \sum_{m: T_m \in [0,1]} |\Delta L_{T_m}|^p V_m \mathbb{1}_{\{|\Delta L_{T_m}| > \frac{1}{j}|\}} \xrightarrow{a.s.} \sum_{m: T_m \in [0,1]} |\Delta L_{T_m}|^p V_m =: Z. \tag{4.37}
$$

Suppose first that $p \geq 1$ and decompose

$$
(n^{\alpha p}V(X)_n)^{1/p} = (n^{\alpha p}V(\hat{X}(j))_n)^{1/p} + ((n^{\alpha p}V(X)_n)^{1/p} - (n^{\alpha p}V(\hat{X}(j))_n)^{1/p})
$$

=: $Y_{n,j} + U_{n,j}$.

Eq. [\(4.36\)](#page-24-1) and [\(4.37\)](#page-24-2) show

Y_{n,j} \xrightarrow[n \to \infty]{\mathcal{L}-s} Z_j^{1/p} \quad \text{and} \quad Z_j^{1/p} \xrightarrow[j \to \infty]{\mathbb{P}} Z^{1/p}.
$$
 (4.38)

Note that $X - \hat{X}(i) = X(i)$, where $X(i)$ is defined in [\(4.21\)](#page-21-3). For all $\epsilon > 0$ we have by Minkowski's inequality

$$
\limsup_{j \to \infty} \limsup_{n \to \infty} \mathbb{P}(|U_{n,j}| > \epsilon) \le \limsup_{j \to \infty} \limsup_{n \to \infty} \mathbb{P}(n^{\alpha p} V(X(j))_n > \epsilon^p) = 0 \quad (4.39)
$$

where the last equality follows by Lemma [4.2.](#page-21-4) By a standard argument, see e.g. [\[13,](#page-51-11) Theorem 3.2, [\(4.38\)](#page-24-3) and [\(4.39\)](#page-25-0) implies that $(n^{\alpha p}V(X)_n)^{1/p} \stackrel{\mathcal{L}-s}{\longrightarrow} Z^{1/p}$ which completes the proof of Theorem [1.1\(](#page-3-0)i) when $p \ge 1$. For $p < 1$, Theorem 1.1(i) follows by [\(4.36\)](#page-24-1), (4.37), the inequality $|V(X)_p - V(\hat{X}(i))_p| \le V(X(i))_p$ and [13, Theorem 3.2]. [\(4.37\)](#page-24-2), the inequality $|V(X)_n - V(\hat{X}(j))_n| \leq V(X(j))_n$ and [\[13,](#page-51-11) Theorem 3.2].

4.2 Proof of Theorem [1.1\(](#page-3-0)ii)

Suppose that $\alpha < k - 1/\beta$, $p < \beta$ and L is a symmetric β -stable Lévy proces. In the proof of Theorem [1.1\(](#page-3-0)ii) we will use the process $V = (V_t)_{t\geq 0}$ given by

$$
V_t = \int_{-\infty}^t h_k(t-s) dL_s \tag{4.40}
$$

to approximate the scaled version of k-order increments of X. For $\alpha < 1-1/\beta$, Y is the korder increments of a linear fractional stable motion. For $\alpha > 1-1/\beta$ the linear fractional stable motion is not well-defined, but Y is well-defined since the function h_k is locally bounded and satisfies $|h_k(x)| \leq Kx^{\alpha-k}$ for $x \geq k+1$, which implies that $h_k \in L^{\beta}(\mathbb{R})$.

Proof of Theorem [1.1\(](#page-3-0)ii). By self-similarity of L of index $1/\beta$ we have for all $n \in \mathbb{N}$,

$$
\{n^{\alpha+1/\beta}\Delta_{i,k}^n X : i = k, \dots, n\} \stackrel{d}{=} \{V_{i,n} : i = k, \dots, n\}
$$
\n(4.41)

where

$$
V_{i,n} = \int_{-\infty}^{i} D^k g_n(i-s) dL_s,
$$

 g_n and D^k are defined at [\(3.10\)](#page-15-6) and [\(3.11\)](#page-15-7), and $\stackrel{d}{=}$ means equality in distribution. In the following we will show that $V_{k,n}$ and V_k are close in L^p when n is large, where process V is given by [\(4.40\)](#page-25-1). For $s \in \mathbb{R}$ let $\psi_n(s) = g_n(s) - s_+^{\alpha}$. Since $p < \beta$,

$$
\mathbb{E}[|V_{k,n} - Y_k|^p] = K \left(\int_0^\infty |D^k \psi_n(s)|^\beta \, ds \right)^{p/\beta}.
$$
\n(4.42)

To show that the right-hand side of [\(4.42\)](#page-25-2) converge to zero we note that

$$
\int_{n+k}^{\infty} |D^k g_n(s)|^{\beta} ds \le Kn^{\beta(\alpha-k)} \int_{n+k}^{\infty} |g^{(k)}((s-k)/n)|^{\beta} ds \tag{4.43}
$$

$$
=Kn^{\beta(\alpha-k)+1}\int_1^\infty|g^{(k)}(s)|^\beta ds\to 0\qquad\text{as }n\to\infty.
$$
 (4.44)

Recall that for $\phi: s \mapsto s_+^{\alpha}$ we have $D^k \phi = h_k \in L^{\beta}(\mathbb{R})$, which together with $(4.43)-(4.44)$ $(4.43)-(4.44)$ show that

\int_{n+k}^{\infty} |D^k \psi_n(s)|^{\beta} ds \le K \Big(\int_{n+k}^{\infty} |D^k g_n(s)|^{\beta} ds + \int_{n+k}^{\infty} |D^k s_+^{\alpha}|^{\beta} ds \Big) \xrightarrow[n \to \infty]{} 0. \tag{4.45}
$$

 \Box

By [\(3.13\)](#page-15-2) of Lemma [3.1](#page-15-5) it holds that

$$
|D^k g_n(s)| \le K(s-k)^{\alpha-k}
$$

for $s \in (k+1, n)$. Therefore, for $s \in (0, n]$ we have

$$
|D^k \psi_n(s)| \le K \left(\mathbb{1}_{\{s \le k+1\}} + \mathbb{1}_{\{s > k+1\}} (s-k)^{\alpha-k} \right),\tag{4.46}
$$

where the function on the right-hand side of (4.46) is in $L^{\beta}(\mathbb{R}_{+})$. For fixed $s \geq 0$, $\psi_n(s) \to 0$ as $n \to \infty$ by assumption [\(1.4\)](#page-3-3), and hence $D^k \psi_n(s) \to 0$ as $n \to \infty$, which by [\(4.46\)](#page-26-0) and the dominated convergence theorem show that

$$
\int_0^n |D^k \psi_n(s)|^\beta ds \to 0. \tag{4.47}
$$

By [\(4.42\)](#page-25-2), [\(4.45\)](#page-25-5) and [\(4.47\)](#page-26-1) we have $\mathbb{E}[|V_{k,n} - V_k|^p] \to 0$ as $n \to \infty$, and hence

$$
\mathbb{E}\Big[\frac{1}{n}\sum_{i=k}^{n}|V_{i,n}-Y_j|^p\Big] = \frac{1}{n}\sum_{i=k}^{n}\mathbb{E}[|V_{i,n}-Y_i|^p] \le \mathbb{E}[|V_{k,n}-Y_k|^p] \to 0 \tag{4.48}
$$

as $n \to \infty$. Moreover, $(V_t)_{t \in \mathbb{R}}$ is mixing since it is a symmetric stable moving average, see e.g. [\[16\]](#page-52-16). This implies, in particular, that the discrete time stationary sequence $\{Y_i\}_{i\in\mathbb{Z}}$ is mixing and hence ergodic. According to Birkhoff's ergodic theorem

$$
\frac{1}{n}\sum_{i=k}^{n}|V_i|^p \xrightarrow{\text{a.s.}} \mathbb{E}[|V_k|^p] = m_p \in (0,\infty) \quad \text{as } n \to \infty,
$$
\n(4.49)

where m_p has been defined in Theorem [1.1\(](#page-3-0)ii). The equality $m_p = \mathbb{E}[|V_k|^p]$ follows by [\[36,](#page-53-3) Property 1.2.17 and 3.2.2]. By [\(4.48\)](#page-26-2), Minkowski's inequality and [\(4.49\)](#page-26-3),

$$
\frac{1}{n}\sum_{i=k}^{n}|V_{i,n}|^p \stackrel{\mathbb{P}}{\longrightarrow} m_p \quad \text{as } n \to \infty,
$$

which by [\(4.41\)](#page-25-6) shows that

$$
n^{-1+p(\alpha+1/\beta)}V(X)_n = \frac{1}{n}\sum_{i=k}^n |n^{\alpha+1/\beta}\Delta_{i,k}^nX|^p \stackrel{d}{=} \frac{1}{n}\sum_{i=k}^n |V_{i,k}|^p \stackrel{\mathbb{P}}{\longrightarrow} m_p
$$

as $n \to \infty$. This completes the proof of Theorem [1.1\(](#page-3-0)ii).

4.3 Proof of Theorem [1.1\(](#page-3-0)iii)

We will derive Theorem [1.1\(](#page-3-0)iii) from the two lemmas below. For $k \in \mathbb{N}$ and $p \in [1,\infty)$ let $W^{k,p}$ denote the Wiener space of functions $\zeta: [0,1] \to \mathbb{R}$ which are k-times absolutely continuous with $\zeta^{(k)} \in L^p([0,1])$ where $\zeta^{(k)}(t) = \partial^k \zeta(t) / \partial t^k$ λ -a.s. First we will show that, under the conditions in Theorem [1.1\(](#page-3-0)iii), $X \in W^{k,p}$ a.s.

Lemma 4.3. Suppose that $p \neq \theta$, $p \geq 1$ and (A). If $\alpha > k - 1/(p \vee \beta)$ then

$$
X \in W^{k,p} \text{ a.s.} \qquad \text{and} \qquad \frac{\partial^k}{\partial t^k} X_t = \int_{-\infty}^t g^{(k)}(t-s) dL_s \qquad \lambda \otimes \mathbb{P}\text{-a.s.} \tag{4.50}
$$

Eq. [\(4.50\)](#page-27-0) remains valid for $p = \theta$ if, in addition, (A-log) holds.

Proof. We will not need the assumption (1.4) on g in the proof. For notation simplicity we only consider the case $k = 1$, since the general case follows by similar arguments. To prove (4.50) it is sufficient to show that the three conditions (5.3) , (5.4) and (5.6) from [\[14,](#page-52-12) Theorem 5.1 are satisfied (this result uses the condition $p \geq 1$). In fact, the representation (4.50) of $(\partial/\partial t)X_t$ follows by the equation below (5.10) in [\[14\]](#page-52-12). In our setting the function $\dot{\sigma}$ defined in [\[14,](#page-52-12) Eq. (5.5)] is constant and hence (5.3), (5.4) and (5.6) in [\[14\]](#page-52-12) simplifies to

$$
\int_{\mathbb{R}} \nu\left(\left(\frac{1}{\|g'\|_{L^p([s, 1+s])}}, \infty \right) \right) ds < \infty,\tag{4.51}
$$

$$
\int_0^\infty \int_{\mathbb{R}} \left(|x g'(s)|^2 \wedge 1 \right) \nu(dx) \, ds < \infty,\tag{4.52}
$$

$$
\int_0^1 \int_{\mathbb{R}} |g'(t+s)|^p \left(\int_{r/|g'(t+s)|}^{1/\|g'\|_{L^p([s,1+s])}} x^p \nu(dx) \right) ds \, dt < \infty \tag{4.53}
$$

for all $r > 0$. When the lower bound in the inner integral in (4.53) exceed the upper bound the integral is set to zero. Since $\alpha > 1 - 1/\beta$ we may choose $\epsilon > 0$ such that $(\alpha - 1)(\beta + \epsilon) > -1$. To show [\(4.51\)](#page-27-2) we use the estimates

$$
||g'||_{L^p([s,1+s])} \leq K\Big(\mathbb{1}_{\{s \in [-1,1]\}} + \mathbb{1}_{\{s > 1\}}|g'(s)|\Big), \qquad s \in \mathbb{R},
$$

and

$$
\nu((u,\infty))\leq \begin{cases} Ku^{-\theta} & u\geq 1\\ Ku^{-\beta-\epsilon} & u\in (0,1], \end{cases}
$$

which both follows from assumption (A) . Hence, we deduce

$$
\int_{\mathbb{R}}\nu\Big(\Big(\frac{1}{\|g'\|_{L^p([s,1+s])}},\infty\Big)\Big)\,ds
$$
\n
$$
\leq \int_{-1}^1\nu\Big(\Big(\frac{1}{K},\infty\Big)\Big)\,ds + \int_1^\infty\nu\Big(\Big(\frac{1}{K|g'(s)|},\infty\Big)\Big)\,ds
$$
\n
$$
\leq 2\nu\Big(\Big(\frac{1}{K},\infty\Big)\Big) + K \int_1^\infty\Big(|g'(s)|^\theta 1_{\{K|g'(s)|\leq 1\}} + |g'(s)|^{\beta+\epsilon} 1_{\{K|g'(s)|>1\}}\Big)\,ds < \infty
$$

which shows [\(4.51\)](#page-27-2) (recall that $|g'|$ is decreasing on $(1,\infty)$). To show [\(4.52\)](#page-27-3) we will use the following two estimates:

$$
\int_0^1 \left(|s^{\alpha - 1}x|^2 \wedge 1 \right) ds \le \begin{cases} K \left(\mathbb{1}_{\{|x| \le 1\}} |x|^{1/(1-\alpha)} + \mathbb{1}_{\{|x| > 1\}} \right) & \alpha < 1/2 \\ K \left(\mathbb{1}_{\{|x| \le 1\}} x^2 \log(1/x) + \mathbb{1}_{\{|x| > 1\}} \right) & \alpha = 1/2 \\ K \left(\mathbb{1}_{\{|x| \le 1\}} x^2 + \mathbb{1}_{\{|x| > 1\}} \right) & \alpha > 1/2, \end{cases} \tag{4.54}
$$

and

$$
\int_{\{|x|>1\}} \left(|x g'(s)|^2 \wedge 1 \right) \nu(dx) \le K \int_1^\infty \left(|x g'(s)|^2 \wedge 1 \right) x^{-1-\theta} dx \le K |g'(s)|^\theta. \tag{4.55}
$$

For $\alpha < 1/2$ we have

$$
\int_{0}^{\infty} \int_{\mathbb{R}} \left(|x g'(s)|^{2} \wedge 1 \right) \nu(dx) ds
$$

\n
$$
\leq K \Biggl\{ \int_{\mathbb{R}} \int_{0}^{1} \left(|x s^{\alpha-1}|^{2} \wedge 1 \right) ds \nu(dx) + \int_{1}^{\infty} \int_{\{|x| \leq 1\}} \left(|x g'(s)|^{2} \wedge 1 \right) \nu(dx) ds
$$

\n
$$
+ \int_{1}^{\infty} \int_{\{|x| > 1\}} \left(|x g'(s)|^{2} \wedge 1 \right) \nu(dx) ds \Biggr\}
$$

\n
$$
\leq K \Biggl\{ \int_{\mathbb{R}} \left(\mathbb{1}_{\{|x| \leq 1\}} |x|^{1/(1-\alpha)} + \mathbb{1}_{\{|x| > 1\}} \right) \nu(dx) + \left(\int_{1}^{\infty} |g'(s)|^{2} ds \right) \left(\int_{\{|x| \leq 1\}} x^{2} \nu(dx) \right) + \int_{1}^{\infty} |g'(s)|^{2} ds \Biggr\} < \infty,
$$

where the first inequality follows by assumption (A), the second inequality follows by [\(4.54\)](#page-27-4) and [\(4.55\)](#page-28-0), and the last inequality is due to the fact that $1/(1 - \alpha) > \beta$ and $g' \in L^{\theta}((1,\infty)) \cap L^2((1,\infty))$. This shows [\(4.52\)](#page-27-3). The two remaining cases $\alpha = 1/2$ and $\alpha > 1/2$ follow similarly.

Now, we will prove that [\(4.53\)](#page-27-1) holds. Since $|g'|$ is decreasing on $(1, \infty)$ we have for all $t \in [0,1]$ that

$$
\int_{1}^{\infty} |g'(t+s)|^{p} \Big(\int_{r/|g'(t+s)|}^{1/||g'||_{L^{p}([s,1+s])}} x^{p} \nu(dx) \Big) ds
$$
\n
$$
\leq \int_{1}^{\infty} |g'(s)|^{p} \Big(\int_{r/|g'(1+s)|}^{1/|g'(s)|} x^{p} \nu(dx) \Big) ds
$$
\n
$$
\leq \frac{K}{p-\theta} \int_{1}^{\infty} |g'(s)|^{p} \Big(|g'(s)|^{\theta-p} - |g'(s+1)/r|^{\theta-p} \Big) 1_{\{r/|g'(1+s)| \leq 1/|g'(s)|\}} ds. \quad (4.56)
$$

For $p > \theta$, [\(4.56\)](#page-28-1) is less than or equal to

$$
\frac{K}{p-\theta}\int_1^\infty |g'(s)|^\theta\,ds < \infty,
$$

and for $p < \theta$, [\(4.56\)](#page-28-1) is less than or equal to

$$
\frac{Kr^{p-\theta}}{\theta-p}\int_1^{\infty}|g'(s)|^p|g'(s+1)|^{\theta-p}\,ds\leq \frac{Kr^{p-\theta}}{\theta-p}\int_1^{\infty}|g'(s)|^{\theta}\,ds<\infty,
$$

where the first inequality is due to the fact that $|g'|$ is decreasing on $(1,\infty)$. Hence we have shown that

$$
\int_0^1 \int_1^\infty |g'(t+s)|^p \left(\int_{r/|g'(t+s)|}^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) \right) ds \, dt < \infty \tag{4.57}
$$

for $p \neq \theta$. Suppose that $p > \beta$. For $t \in [0,1]$ and $s \in [-1,1]$ we have

$$
\int_{r/|g'(t+s)|}^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) \le \int_1^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) + \int_{r/|g'(t+s)|}^1 x^p \nu(dx)
$$

$$
\le K \left(||g'||_{L^p([s,1+s])}^{\theta-p} + 1 \right)
$$

and hence

$$
\int_0^1 \int_{-1}^1 |g'(t+s)|^p \left(\int_{r/|g'(t+s)|}^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) \right) ds dt \tag{4.58}
$$

$$
\leq K\Big(\int_{-1}^1 \|g'\|_{L^p([s,s+1])}^{\theta} ds + \int_{-1}^1 \|g'\|_{L^p([s,1+s])}^p ds\Big) < \infty.
$$
 (4.59)

Suppose that $p \leq \beta$. For $t \in [0,1]$ and $s \in [-1,1]$ we have

$$
\int_{r/|g'(t+s)|}^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) \le K\left(||g'||_{L^p([s,1+s])}^{\theta-p} + |g'(t+s)|^{\beta+\epsilon-p}\right)
$$

and hence

$$
\int_0^1 \int_{-1}^1 |g'(t+s)|^p \left(\int_{r/|g'(t+s)|}^{1/||g'||_{L^p([s,1+s])}} x^p \nu(dx) \right) ds dt \tag{4.60}
$$

$$
\leq K\Big(\int_{-1}^{1} \|g'\|_{L^{p}([s,s+1])}^{\theta} ds + \int_{-1}^{1} \|g'\|_{L^{\beta+\epsilon}([s,1+s])}^{\beta+\epsilon} ds\Big) < \infty
$$
\n(4.61)

since $(\alpha - 1)(\beta + \epsilon) > -1$. Thus, [\(4.53\)](#page-27-1) follows by [\(4.57\)](#page-28-2), [\(4.58\)](#page-29-0)–[\(4.59\)](#page-29-1) and [\(4.60\)](#page-29-2)–[\(4.61\)](#page-29-3).

For $p = \theta$ the above proof goes through except for [\(4.57\)](#page-28-2), where we need the additional assumption (A-log). This completes the proof. \Box

Lemma 4.4. For all $\zeta \in W^{k,p}$ we have as $n \to \infty$,

$$
n^{-1+pk}V(\zeta,p;k)_n \to \int_0^1 |\zeta^{(k)}(s)|^p ds. \tag{4.62}
$$

Proof. First we will assume that $\zeta \in C^{k+1}(\mathbb{R})$ and afterwards we will prove the lemma by approximation. Successive applications of Taylor's theorem gives

$$
\Delta_{i,k}^n \zeta = \zeta^{(k)} \left(\frac{i-k}{n} \right) \frac{1}{n^k} + a_{i,n}, \qquad n \in \mathbb{N}, \ k \le i \le n
$$

where $a_{i,n} \in \mathbb{R}$ satisfies

$$
|a_{i,n}| \le Kn^{-k-1}, \qquad n \in \mathbb{N}, \ k \le i \le n.
$$

By Minkowski's inequality,

$$
\left| \left(n^{kp-1} V(\zeta)_n \right)^{1/p} - \left(n^{kp-1} \sum_{j=k}^n \left| \zeta^{(k)} \left(\frac{i-k}{n} \right) \frac{1}{n^k} \right|^p \right)^{1/p} \right|
$$

$$
\leq \left(n^{pk-1} \sum_{j=k}^n |a_{i,n}|^p \right)^{1/p} \leq Kn^{-1-1/p} \to 0.
$$

 \Box

By continuity of $\zeta^{(k)}$ we have

$$
n^{kp-1} \sum_{i=k}^{n} \left| \zeta^{(k)} \left(\frac{i-k}{n} \right) \frac{1}{n^k} \right|^p \to \int_0^1 |\zeta^{(k)}(s)|^p ds
$$

as $n \to \infty$, which shows [\(4.62\)](#page-29-4).

The statement of the lemma for a general $\zeta \in W^{k,p}$ follows by approximating ζ through a sequence of $C^{k+1}(\mathbb{R})$ -functions and Minkowski's inequality. This completes the proof.

Proof of Theorem [1.1\(](#page-3-0)iii). The Lemmas [4.3](#page-27-5) and [4.4](#page-29-5) yield Theorem 1.1(iii).

5 Proof of Theorem [1.2](#page-4-0)

We recall the definition of m_p in Theorem [1.1\(](#page-3-0)ii) and of $g_{i,n}$ introduced at [\(3.8\)](#page-15-4). Throughout this section the driving Lévy motion L is a symmetric β -stable Lévy process with scale parameter 1.

5.1 Proof of Theorem [1.2\(](#page-4-0)i)

Throughout the following subsection we assume that the conditions of Theorem [1.2\(](#page-4-0)i) hold, in particular, $k = 1$. For all $n \ge 1$ and $r \ge 0$ set

$$
\phi_r^n(s) = Dg_n(r-s) = n^{\alpha} \left(g\left(\frac{r-s}{n}\right) - g\left(\frac{r-1-s}{n}\right) \right),\tag{5.1}
$$

$$
Y_r^n = \int_{-\infty}^r \phi_r^n(s) dL_s, \qquad V_r^n = |Y_r^n|^p - \mathbb{E}[|Y_r^n|^p].
$$

Due to self-similarity of L of order $1/\beta$ we have for all $n \in \mathbb{N}$ that

$$
n^{1-\frac{1}{(1-\alpha)\beta}}\left(n^{-1+p(\alpha+1/\beta)}V(p;1)_n - m_p\right) \stackrel{d}{=} S_n + r_n
$$

where

$$
S_n = n^{1/(\alpha - 1)\beta} \sum_{r=1}^n V_r^n \quad \text{and} \quad r_n = n^{1 - \frac{1}{(1 - \alpha)\beta}} (\mathbb{E}[|Y_1^n|^p] - m_p). \tag{5.2}
$$

We will show Theorem [1.2\(](#page-4-0)i) by showing that $r_n \to 0$ and $S_n \stackrel{d}{\longrightarrow} S$, where S is the limit introduced in Theorem [1.2\(](#page-4-0)i). The convergence $S_n \stackrel{d}{\longrightarrow} S$ follows by the following Steps 1–3, whereas $r_n \to 0$ follows by Step 4.

The following estimates will be useful for us. Let W denote a symmetric β -stable random variable with scale parameter $\rho \in (0,\infty)$ and set

$$
\Phi_{\rho}(x) = \mathbb{E}[|W+x|^p] - \mathbb{E}[|W|^p], \qquad x \in \mathbb{R}.
$$
\n(5.3)

Using the representation [\(2.6\)](#page-13-0) it follows that

$$
\Phi_{\rho}(x) = a_p^{-1} \int_{\mathbb{R}} \left(1 - \cos(ux) \right) e^{-\rho^{\beta} |u|^{\beta}} |u|^{-1-p} du. \tag{5.4}
$$

Let $\epsilon > 0$ be a fixed strictly positive number. From [\(5.4\)](#page-30-1), we deduce that H_{ρ} is two times continuous differentiable, and

$$
|\Phi''_{\rho}(x)| = a_p^{-1} \Big| \int_{\mathbb{R}} \cos(ux) |u|^{1-p} e^{-\rho^{\beta} |u|^{\beta}} du \Big| \le a_p^{-1} \int_{\mathbb{R}} |u|^{1-p} e^{-\rho^{\beta} |u|^{\beta}} du,
$$

which implies that there exists a finite constant K_{ϵ} such that for all $\rho \geq \epsilon$ and all $x \in \mathbb{R}$

$$
|\Phi_{\rho}''(x)| \le K_{\epsilon}.\tag{5.5}
$$

By [\(5.4\)](#page-30-1) we also deduce the following estimate by several applications of the mean-value theorem

$$
|\Phi_{\rho}(x) - \Phi_{\rho}(y)| \le K_{\epsilon} \Big(\big(|x| \wedge 1 + |y| \wedge 1\big)|x - y| \mathbb{1}_{\{|x - y| \le 1\}} + |x - y|^p \mathbb{1}_{\{|x - y| > 1\}} \Big) \tag{5.6}
$$

which holds for all $\rho \geq \epsilon$ and all $x, y \in \mathbb{R}$. Eq. [\(5.6\)](#page-31-0) used on $y = 0$ yields that

$$
|\Phi_{\rho}(x)| \le K_{\epsilon}(|x|^p \wedge |x|^2),\tag{5.7}
$$

which, in particular, implies that

$$
|\Phi_{\rho}(x)| \le K_{\epsilon} |x|^l \qquad \text{for all } l \in (p, \beta). \tag{5.8}
$$

Moreover, for all $r \in (p, 2]$ and $\rho_1, \rho_2 \geq \epsilon$ we deduce by [\(5.4\)](#page-30-1) that

$$
|\Phi_{\rho_1}(x) - \Phi_{\rho_2}(x)| \le K_{\epsilon} |\rho_1^{\beta} - \rho_2^{\beta}| |x|^r \quad \text{for all } x \in \mathbb{R}.
$$
 (5.9)

We will also need the following estimate:

Lemma 5.1. For all $\kappa, \tau \in L^{\beta}([0,1])$ with $\|\kappa\|_{L^{\beta}([0,1])}, \|\tau\|_{L^{\beta}([0,1])} \leq 1$ set $U = \int_0^1 \kappa(s) dL_s$ and $V = \int_0^1 \tau(s) dL_s$. Moreover, let Φ_ρ be given by [\(5.3\)](#page-30-2). For all $r \in (1, \beta)$ and $\epsilon > 0$ we have

$$
\|\Phi_{\rho}(U) - \Phi_{\rho}(V)\|_{L^{r}} \tag{5.10}
$$
\n
$$
\leq K_{\rho}\left\{ \left(\|\kappa\|_{L^{\beta}([0,1])}^{\beta/r-1-\epsilon} + \|\tau\|_{L^{\beta}([0,1])}^{\beta/r-1-\epsilon} \right) \|\kappa-\tau\|_{L^{\beta}([0,1])} + \|\kappa-\tau\|_{L^{\beta}([0,1])}^{\beta/r} \right\}.
$$

Proof. Let $q \in (r, \beta)$. Using [\(5.6\)](#page-31-0), Minkowski inequality and Hölder inequality on q and $q' := rq/(q - r)$, which satisfies the equality $1/r = 1/q + 1/q'$, we obtain

$$
\|\Phi_{\rho}(U) - \Phi_{\rho}(V)\|_{L^{r}}\leq K_{\rho}\Big(\Big\{\||U| \wedge 1\|_{L^{q'}} + \||V| \wedge 1\|_{L^{q'}}\Big\}\|U - V\|_{L^{q}} + \||U - V|^{p}\mathbb{1}_{\{|U - V| \geq 1\}}\|_{L^{r}}\Big). (5.11)
$$

Since $q - r < 1 < r$ we have $q' > q$, and hence

$$
\||V| \wedge 1\|_{L^{q'}} \leq \mathbb{E}[|V|^q]^{\frac{q-r}{qr}} \leq K \|\tau\|_{L^\beta([0,1])}^{q/r-1}.
$$

A similar estimate holds for U. Let W be a standard symmetric β -stable random variable. For all $b \in (0,1]$ and all $v < \beta$ we have the estimate

$$
\mathbb{E}[|bW|^v \mathbb{1}_{\{|bW|\ge 1\}}] \le Kb^\beta,\tag{5.12}
$$

which follows from the fact that W has a density η satisfying $\eta(x) \leq K(1+|x|)^{-1-\beta}$, $x \in \mathbb{R}$, see e.g. [\[43,](#page-53-12) Theorem 1.1], and hence by substitution

$$
\mathbb{E}[|bW|^v \mathbb{1}_{\{|bW|\geq 1\}}] = \int_{\mathbb{R}} |bx|^v \mathbb{1}_{\{|bx|\geq 1\}} \eta(x) dx
$$

$$
\leq Kb^{-1} \int_{\mathbb{R}} |x|^v \mathbb{1}_{\{|x|\geq 1\}} |b^{-1}x|^{-1-\beta} dx = Kb^{\beta}.
$$

By applying [\(5.12\)](#page-31-1) with $v = pr$ on the last term in [\(5.11\)](#page-31-2) we obtain the desired estimate $(5.10).$ $(5.10).$ □

Recall the definition of ϕ_j^n in [\(5.1\)](#page-30-3), and set

$$
\phi_j(u) = (j - u)_+^{\alpha} - (j - u - 1)_+^{\alpha}.
$$
\n(5.13)

From Lemma [3.1](#page-15-5) we obtain the estimates

$$
\|\phi_j^n\|_{L^{\beta}([0,1])} \le Kj^{\alpha-1}, \qquad \|\phi_j\|_{L^{\beta}([0,1])} \le Kj^{\alpha-1}, \tag{5.14}
$$

which will be used repeatedly throughout the proof. Set, moreover,

$$
\rho_j^n = \|\phi_1^n\|_{L^{\beta}(\mathbb{R}\setminus[-j,-j+1])}, \qquad \rho_0 = \|\phi_1\|_{L^{\beta}(\mathbb{R})}, \qquad U_{r,m}^n = \int_m^{m+1} \phi_r^n(u) \, dL_u,
$$

and for all $r \in \mathbb{R}$ set

$$
\mathcal{G}_r = \sigma(L_s - L_u : s, u \le r) \quad \text{and} \quad \mathcal{G}_r^1 = \sigma(L_s - L_u : r \le s, u \le r + 1).
$$

We note that $(\mathcal{G}_r^1)_{r\geq 0}$ is not a filtration. We are now ready to prove the first approximation of $(S_n)_{n\geq 1}$ in (5.2) .

Step 1. Set

$$
S'_n := n^{1/(\alpha - 1)\beta} \sum_{r=1}^n Z_r^n, \qquad Z_r^n := \sum_{j=1}^\infty \mathbb{E}[V_r^n | \mathcal{G}_{r-j}^1]. \tag{5.15}
$$

In the following we will show that

$$
S_n - S'_n \xrightarrow{\mathbb{P}} 0. \tag{5.16}
$$

Before showing [\(5.16\)](#page-32-0) let us show that the infinite series Z_r^n , defined in [\(5.15\)](#page-32-1), converges absolutely a.s. To this end fix n and r and set $\theta_j := \mathbb{E}[V_r^n | \mathcal{G}_{r-j}^1], j \ge 1$. Notice that $\theta_j = \Phi_{\rho_j^n}(U_{r,r-j}^n) - \mathbb{E}[\Phi_{\rho_j^n}(U_{r,r-j}^n)]$. Since $\rho_j^n \to \|\phi_1^n\|_{L^\beta(\mathbb{R})}$ as $j \to \infty$, we have for all $n \ge 1$ large enough that there exists $j_0 = j_0(n)$ such that $\{\rho_j^n : j \ge j_0\}$ is bounded away from zero, which combined with [\(5.8\)](#page-31-4) and [\(5.14\)](#page-32-2) implies that for all $l \in (p, \beta)$

$$
\mathbb{E}[\left|\theta_{j}\right|] \leq 2\mathbb{E}[\left|\Phi_{\rho_{j}^{n}}(U_{r,r-j}^{n})\right|] \leq K\mathbb{E}[\left|U_{r,r-j}^{n}\right|^{l}] \leq Kj^{(\alpha-1)l}.
$$
\n(5.17)

Since the right-hand side of [\(5.17\)](#page-32-3) is summable in j for all l close enough to β by the assumption $\alpha < 1 - 1/\beta$, it follows that $\sum_{j=1}^{\infty} \theta_j$ converge absolutely a.s.

In the following we will show [\(5.16\)](#page-32-0) by showing that V_r^n is suitably close to Z_r^n , and to this aim we will use the following telescoping sum decomposition of V_r^n

$$
V_r^n = \sum_{j=1}^{\infty} \left(\mathbb{E}[V_r^n | \mathcal{G}_{r-j+1}] - \mathbb{E}[V_r^n | \mathcal{G}_{r-j}] \right),\tag{5.18}
$$

which follows from the fact that $\lim_{j\to\infty} \mathbb{E}[V_r^n | \mathcal{G}_{r-j}] = \mathbb{E}[V_r^n] = 0$ a.s. Such decompositions go back to [\[24\]](#page-52-9) in the discrete time moving average setting. By definition of S'_n and [\(5.18\)](#page-33-0) we have

$$
S_n - S'_n = n^{1/(\alpha - 1)\beta} \sum_{r=1}^n R_r^n, \qquad R_r^n := \sum_{j=1}^\infty \zeta_{r,j}^n,\tag{5.19}
$$

$$
\zeta_{r,j}^n := \mathbb{E}[V_r^n | \mathcal{G}_{r-j+1}] - \mathbb{E}[V_r^n | \mathcal{G}_{r-j}] - \mathbb{E}[V_r^n | \mathcal{G}_{r-j}^1].
$$
\n(5.20)

We now use a telescoping sum decomposition of $\zeta_{r,j}^n$

$$
\zeta_{r,j}^n = \sum_{l=j}^{\infty} \vartheta_{r,j,l}^n, \qquad \vartheta_{r,j,l}^n := \mathbb{E}[\zeta_{r,j}^n | \mathcal{G}_{r-j}^1 \vee \mathcal{G}_{r-l}] - \mathbb{E}[\zeta_{r,j}^n | \mathcal{G}_{r-j}^1 \vee \mathcal{G}_{r-l-1}], \qquad (5.21)
$$

which follows from the fact that $\lim_{l\to\infty} \mathbb{E}[\zeta_{r,j}^n | \mathcal{G}_{r-j}^1 \vee \mathcal{G}_{r-l}] = \mathbb{E}[\zeta_{r,j}^n | \mathcal{G}_{r-j}^1] = 0$ a.s. The next lemma gives a moment estimate for $\vartheta_{r,j,l}^n$.

Lemma 5.2. Let $\vartheta_{r,j,l}^n$ be defined in [\(5.21\)](#page-33-1) and $\gamma \in [1,\beta)$. Then there exists $N \geq 1$ such that $\mathbb{E}[|\vartheta_{r,j,l}^n|^{\gamma}] \leq K_{\gamma}j^{(\alpha-1)\gamma}l^{(\alpha-1)\gamma}$ for all $n \geq N, r \leq n, j \geq 1$ and $l \geq j$.

Proof. For fixed $n, j, l, \{ \vartheta_{r,j,l}^n : r \geq 1 \}$ is a stationary sequence, and hence we may and do assume that $r = 1$. Furthermore, we may and do assume that $l \geq j \vee 2$, since the case $l = j = 1$ can be covered by choosing a new constant K_{γ} . By definition of $\vartheta_{1,j,l}^n$ we obtain the representation

$$
\vartheta_{1,j,l}^{n} = \mathbb{E}[|Y_{1}^{n}|^{p}|\mathcal{G}_{1-j}^{1} \vee \mathcal{G}_{1-l}] - \mathbb{E}[|Y_{1}^{n}|^{p}|\mathcal{G}_{1-l}] - \mathbb{E}[|Y_{1}^{n}|^{p}|\mathcal{G}_{1-j}^{1} \vee \mathcal{G}_{-l}] + \mathbb{E}[|Y_{1}^{n}|^{p}|\mathcal{G}_{-l}].
$$
 (5.22)

Set $\rho_{j,l}^n = ||\phi_1^n||_{L^{\beta}([1-l,1-j]\cup[2-j,1])}$. For large enough $N \geq 1$ there exists $\epsilon > 0$ such that $\rho_{j,l}^n \geq \epsilon$ for all $n \geq N, j \geq 1, l \geq j \vee 2$ (we have $\rho_{j,l}^n = 0$ for $l = 1$). Hence by [\(5.5\)](#page-31-5) there exists a finite constant K such that

$$
|\Phi_{\rho_{j,l}^n}''(x)| \le K \qquad \text{for all } n \ge N, \, j \ge 1, \, l \ge j \vee 2, \, x \in \mathbb{R}.\tag{5.23}
$$

Let

$$
A_l^n = \int_{-\infty}^{-l} \phi_1^n(s) \, dL_s, \qquad B_j^n = \int_{1-j}^{2-j} \phi_1^n(s) \, dL_s,
$$

and $(\tilde{B}_{l+1}^n, \tilde{B}_j^n)$ denote a random vector which is independent of L and which equals (B_{l+1}^n, B_j^n) in law. Let moreover $\mathbb{\tilde{E}}$ denote expectation with respect to $(\tilde{B}_{l+1}^n, \tilde{B}_j^n)$ only. From [\(5.22\)](#page-33-2) we deduce that

$$
\vartheta_{1,j,l}^{n} = \tilde{\mathbb{E}} \Big[\Phi_{\rho_{j,l}^{n}} (A_{l}^{n} + B_{l+1}^{n} + B_{j}^{n}) - \Phi_{\rho_{j,l}^{n}} (A_{l}^{n} + \tilde{B}_{l+1}^{n} + B_{j}^{n})
$$

$$
- \Phi_{\rho_{j,l}^{n}} (A_{l}^{n} + B_{l+1}^{n} + \tilde{B}_{j}^{n}) + \Phi_{\rho_{j,l}^{n}} (A_{l}^{n} + \tilde{B}_{l+1}^{n} + \tilde{B}_{j}^{n}) \Big]
$$

$$
= \tilde{\mathbb{E}} \Big[\int_{\tilde{B}_{j}^{n}}^{B_{j}^{n}} \int_{\tilde{B}_{l+1}^{n}}^{B_{l+1}^{n}} \Phi_{\rho_{j,l}^{n}}^{"}(A_{l}^{n} + u_{1} + u_{2}) du_{1} du_{2} \Big],
$$

where \int_y^x denotes $-\int_x^y$ if $x < y$. Hence by [\(5.23\)](#page-33-3) we have

$$
|\vartheta_{r,j,l}^n|^\gamma\leq K\Big(|B_{l+1}^nB_j^n|^\gamma+|B_j^n|^\gamma\mathbb{E}[|B_{l+1}^n|^\gamma]+\mathbb{E}[|B_j^n|^\gamma]|B_{l+1}^n|^\gamma+\mathbb{E}[|B_j^n|^\gamma]\mathbb{E}[|B_{l+1}^n|^\gamma]\Big),
$$

and by independence of B_{l+1}^n and B_j^n for all $l \geq j$ we have

$$
\mathbb{E}[|\vartheta_{r,j,l}^n|^\gamma] \leq K \mathbb{E}[|B^n_j|^\gamma]\mathbb{E}[|B^n_{l+1}|^\gamma] \leq K \|\phi_j^n\|_{L^\beta([0,1])}^\gamma \|\phi_{l+1}^n\|_{L^\beta([0,1])}^\gamma.
$$

Hence, [\(5.14\)](#page-32-2) completes the proof.

For all $m < -j$, the sequence $V_k := \vartheta_{r,j,-k}^n$, for $k = m, \ldots, -j$, is a martingale difference in the filtration $\tilde{\mathcal{G}}_k := \mathcal{G}^1_{r-j} \vee \mathcal{G}^1_{r+k}, k = m, \ldots, -j$. Hence by the von Bahr-Esseen inequality (see e.g. [\[38,](#page-53-6) Lemma 4.2]) we obtain for all $\gamma \in [1, \beta)$

$$
\mathbb{E}[|\zeta_{r,j}^n|^{\gamma}] \le 2 \sum_{l=j}^{\infty} \mathbb{E}[|\vartheta_{r,j,l}^n|^{\gamma}]. \tag{5.24}
$$

According to Lemma [5.2,](#page-33-4) we have the estimate $\mathbb{E}[|\vartheta_{r,j,l}^n|^{\gamma}] \leq Kj^{(\alpha-1)\gamma}l^{(\alpha-1)\gamma}$, which together with [\(5.24\)](#page-34-0) implies that

$$
\mathbb{E}[|\zeta_{r,j}^n|^{\gamma}] \le K j^{(\alpha-1)\gamma} \sum_{l=j}^{\infty} l^{(\alpha-1)\gamma} \le K j^{2(\alpha-1)\gamma+1}.
$$
 (5.25)

Eq. [\(5.25\)](#page-34-1) used on $\gamma = 1$ yields that series $R_r^n = \sum_{j=1}^{\infty} \zeta_{r,j}^n$ converges absolutely a.s. Thus, by rearranging the terms in (5.19) – (5.20) using the substitution $s = r - j$, we have

$$
S_n - S'_n = n^{1/(\alpha - 1)\beta} \sum_{s = -\infty}^{n-1} M_s^n \quad \text{with} \quad M_s^n := \sum_{r = 1 \vee (s+1)}^n \zeta_{r,r-s}^n.
$$

Recalling the definition of $\zeta_{r,j}^n$ in [\(5.20\)](#page-33-6), we note that $\mathbb{E}[\zeta_{r,r-s}^n|\mathcal{G}_s] = 0$ for all s and r, showing that that $\{M_s^n : s \in (-\infty, n) \cap \mathbb{Z}\}\$ are martingale differences. Using again von

 \Box

Bahr–Esseen inequality([\[38,](#page-53-6) Lemma 4.2]) we deduce that

$$
\mathbb{E}[|S_n - S'_n|^{r'}] \le Kn^{r' / (\alpha - 1)\beta} \sum_{s < n} \mathbb{E}[|M_{n,s}|^{r'}]
$$
\n
$$
\le Kn^{r' / (\alpha - 1)\beta} \sum_{s < n} \left(\sum_{r = 1 \vee (s+1)}^n \mathbb{E}[|\zeta_{r,r-s}^n|^{r'}|^{1/r'} \right)^{r'}
$$
\n
$$
\le Kn^{r' / (\alpha - 1)\beta} \sum_{s < n} \left(\sum_{r = 1 \vee (s+1)}^n (r - s)^{1/r' + 2(\alpha - 1)} \right)^{r'} =: A_n.
$$

It now remains to prove that $A_n \to 0$, and to do this we distinguish two cases (recall that $1 < r' < \beta$ close enough to β). Split $A_n = \sum_{-n < s < n} + \sum_{s < -n} =: A'_n + A''_n$ and assume for the moment that $1/\beta + 2(\alpha - 1) < -1$ holds. Since the inner sum is summable (for r' close enough to β) we immediately see that $A'_n \leq Kn^{r'/(\alpha-1)\beta+1}$. Since $\beta > 1$ and $\alpha \in (0, 1 - 1/\beta)$ we deduce that $A'_n \to 0$. On the other hand, a direct computation shows that

$$
A_n'' \le Kn^{r'/(\alpha-1)\beta+3+2r'(\alpha-1)},
$$

and since $\beta(\alpha-1) < -1$, we readily obtain that $A''_n \to 0$. Now, assume that $1/\beta+2(\alpha-1) \ge$ −1. Then

A'_n \le Kn^{r'/(a-1)\beta + 2 + r' + 2r'(a-1)}.
$$

Since $1/\beta + 2(\alpha - 1) \ge -1$, which is equivalent to $1 + 2\beta(\alpha - 1) \ge -\beta$, we obtain for r' close enough to β

A'_n \le Kn^{1/(\alpha - 1) + 1} \to 0.
$$

The convergence $A''_n \to 0$ is shown as above.

Next we will show that S'_n can be approximated by a rescaled sum of certain i.i.d. random variables \tilde{Z}_r , $r \geq 1$.

Step 2. Set $W_{r,j} := \int_r^{r+1} \phi_j(u) dL_u$ and

\tilde{S}_n := n^{1/(\alpha-1)\beta} \sum_{r=1}^n \tilde{Z}_r, \qquad \tilde{Z}_r := \sum_{j=1}^\infty \left\{ \Phi_{\rho_0}(W_{j+r,r}) - \mathbb{E}[\Phi_{\rho_0}(W_{j+r,r})] \right\},
$$

where ρ_0 has been defined at [\(5.13\)](#page-32-4). We will show that

$$
S'_n - \tilde{S}_n \stackrel{\mathbb{P}}{\longrightarrow} 0.
$$

The series \tilde{Z}_r converges absolutely a.s. according to the same arguments as used in Step 1. Recall from Step 1 that $\mathbb{E}[V_r^n|\mathcal{G}_{r-j}^1] = \Phi_{\rho_j^n}(U_{r,r-j}^n) - \mathbb{E}[\Phi_{\rho_j^n}(U_{r,r-j}^n)]$ and the series S'_n

converges absolutely a.s. By rearranging the terms in S'_n by the substitution $s = r - j$, we obtain the decomposition $S'_n - S''_n = R_n^1 - R_n^2 + R_n^3$, where

R_n^1 := n^{1/(\alpha-1)\beta} \sum_{s<0} \left(\sum_{j=1-s}^{n-s} \left\{ \Phi_{\rho_j^n}(U_{j+s,s}^n) - \mathbb{E}[\Phi_{\rho_j^n}(U_{j+s,s}^n)] \right\} \right),
$$

\n
$$
R_n^2 := n^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} \left(\sum_{j>n-s} \left\{ \Phi_{\rho_0}(W_{j+s,s}) - \mathbb{E}[\Phi_{\rho_0}(W_{j+s,s})] \right\} \right),
$$

\n
$$
R_n^3 :=
$$

\n
$$
n^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} \left(\sum_{j=1}^{n-s} \left\{ \Phi_{\rho_j^n}(U_{j+s,s}^n) - \mathbb{E}[\Phi_{\rho_j^n}(U_{j+s,s}^n)] - (\Phi_{\rho_0}(W_{j+s,s}) - \mathbb{E}[\Phi_{\rho_0}(W_{j+s,s})]) \right\} \right).
$$

Now, we will show that all terms converge to 0 in probability. We start with the term R_n^2 . For any $l \in (p, \beta)$ with $l(\alpha - 1) < -1$, we have deduce by [\(5.8\)](#page-31-4) and [\(5.14\)](#page-32-2)

$$
\mathbb{E}[|R_n^2|] \le 2n^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} \sum_{j>n-s} \mathbb{E}[|\Phi_{\rho_0}(W_{j+s,s})|]
$$

$$
\le Kn^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} \sum_{j>n-s} j^{l(\alpha-1)} \le Kn^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} s^{l(\alpha-1)+1} \le Kn^{1/(\alpha-1)\beta + l(\alpha-1)+2}.
$$

Choosing l arbitrary close to β , and taking into account that

$$
2 + \beta(\alpha - 1) < \frac{1}{1 - \alpha)\beta},
$$

where the latter comes from the fact that $2 - x < 1/x$ for any $x > 1$, we conclude that R_n^2 $\stackrel{\mathbb{P}}{\longrightarrow} 0.$

In a similarly way we prove R_n^1 $\stackrel{\mathbb{P}}{\longrightarrow}$ 0 in the following. By our assumptions we may choose $N \geq 1$ such that $\{\rho_j^n : n \geq N, j \geq 1\}$ is bounded away from zero. For any $l \in (p, \beta)$ with $l(\alpha - 1) < -1$ and $n \ge N$ we have by [\(5.8\)](#page-31-4) and [\(5.14\)](#page-32-2) that

$$
\mathbb{E}[|R_n^1|] \le 2n^{1/(\alpha-1)\beta} \sum_{s<0} \sum_{j=1-s}^{n-s} \mathbb{E}[|\Phi_{\rho_j^n}(U_{j+s,s}^n)|] \le Kn^{1/(\alpha-1)\beta} \sum_{s<0} \sum_{j=1-s}^{n-s} j^{(\alpha-1)l}
$$

$$
\le Kn^{1/(\alpha-1)\beta} \sum_{s<0} \left\{ (1-s)^{(\alpha-1)l+1} - (n-s)^{(\alpha-1)l+1} \right\}
$$

$$
\le Kn^{1/(\alpha-1)\beta} \sum_{u=1}^n u^{(\alpha-1)l+1} \le Kn^{1/(\alpha-1)\beta + (\alpha-1)l+2}.
$$
 (5.26)

The estimate [\(5.26\)](#page-36-0) implies R_n^1 $\stackrel{\mathbb{P}}{\longrightarrow} 0$ as above.

37

Next we will show that R_n^3 $\stackrel{\mathbb{P}}{\longrightarrow}$ 0. We start with the following simple estimate

$$
\mathbb{E}[|R_n^3|] \le 2n^{1/(\alpha-1)\beta} \sum_{s=0}^{n-1} \sum_{j=1}^{n-s} \mathbb{E}\Big[\Big|\Phi_{\rho_j^n}(U_{j+s,s}^n) - \Phi_{\rho_0}(V_{j+s,s})\Big|\Big] \le 2n^{1/(\alpha-1)\beta+1} \sum_{j=1}^n \mathbb{E}\Big[\Big|\Phi_{\rho_j^n}(U_{j,0}^n) - \Phi_{\rho_0}(V_{j,0})\Big|\Big].
$$
 (5.27)

Next we decompose

$$
\Phi_{\rho_j^n}(U_{j,0}^n) - \Phi_{\rho_0}(V_{j,0}) = C_j^n + Q_j^n \tag{5.28}
$$

where

$$
Q_j^n = \Phi_{\rho_j^n}(U_{j,0}^n) - \Phi_{\rho_0}(U_{j,0}^n) \quad \text{and} \quad C_j^n = \Phi_{\rho_0}(U_{j,0}^n) - \Phi_{\rho_0}(V_{j,0}).
$$

We have that

$$
U_{j,0}^n - W_{j,0} = \int_0^1 \zeta_j^n(u) \, dL_u \quad \text{where} \quad \zeta_j^n(u) := \phi_j^n(u) - \phi_j(u).
$$

In the following we will prove and use the estimate

$$
\|\zeta_j^n\|_{L^{\beta}[0,1]} \le Kn^{-1}j^{\alpha}.\tag{5.29}
$$

Recall that $g(s) = s^{\alpha} f(s)$ for $s \ge 0$. The estimate [\(5.29\)](#page-37-0) follows by the decompose

\zeta^n_j = \hat{\zeta}^n_j + \bar{\zeta}^n_j
$$

with

\hat{\zeta}_j^n(u) = [f((j - u)/n) - f(0)]\phi_j(u), \n\bar{\zeta}_j^n(u) = [f((j - u)/n) - f((j - u - 1)/n)](j - u - 1)^{\alpha}_+,
$$

the triangle inequality and continuous right differentiability of f at zero. Fix $\epsilon > 0$. By Lemma [5.1](#page-31-6) used on $r = 1$, [\(5.14\)](#page-32-2) and [\(5.29\)](#page-37-0) we have

$$
\sum_{j=1}^{n} \mathbb{E}[|C_j^n|] \le K \sum_{j=1}^{n} \left(j^{(\alpha-1)(\beta-1-\epsilon)} n^{-1} j^{\alpha} + n^{-\beta} j^{\alpha \beta} \right) \le Kn^{(\alpha-1)(\beta-\epsilon)+1} \to 0 \quad (5.30)
$$

for ϵ small enough. By substitution, Lemma 6.1(i) and [\(5.14\)](#page-32-2),

$$
\left| |\rho_j^n|^{\beta} - |\rho_0|^{\beta} \right| \le \left| ||\phi_1^n||_{L^{\beta}(\mathbb{R})} - ||\phi_1||_{L^{\beta}(\mathbb{R})} \right| + ||\phi_1^n||_{L^{\beta}([-j, -j+1])}
$$

\n
$$
\le K \left(n^{\alpha \beta + 1} \right| ||g_{0,n}||_{L^{\beta}(\mathbb{R})}^{\beta} - ||h_{0,n}||_{L^{\beta}(\mathbb{R})}^{\beta} \right| + j^{\alpha - 1} \le K \left(n^{(\alpha - 1)\beta + 1} + j^{\alpha - 1} \right). \quad (5.31)
$$

For any $r \in (p, \beta)$ such that $(\alpha - 1)r < -1$ we have by [\(5.9\)](#page-31-7), [\(5.14\)](#page-32-2) and [\(5.31\)](#page-37-1) that

$$
\mathbb{E}[|Q_j^n|] = \mathbb{E}[|\Phi_{\rho_j^n}(U_{j,0}^n) - \Phi_{\rho_0}(U_{j,0}^n)|] \le K \left| |\rho_j^n|^{\beta} - |\rho|^\beta \right| \mathbb{E}[|U_{j,0}^n|^r]
$$

$$
\le K \left| |\rho_j^n|^{\beta} - |\rho|^\beta \right| \|\phi_j^n\|_{L^\beta([0,1])}^r \le K \left(n^{(\alpha-1)\beta+1} j^{(\alpha-1)r} + j^{(\alpha-1)(1+r)} \right),
$$

which implies that

$$
\sum_{j=1}^{n} \mathbb{E}[|Q_j^n|] \le K\left(n^{(\alpha-1)\beta+1} + n^{(\alpha-1)(1+r)+1}\right) \le Kn^{(\alpha-1)\beta+1}.
$$
 (5.32)

The equations [\(5.27\)](#page-37-2), [\(5.28\)](#page-37-3), [\(5.30\)](#page-37-4) and [\(5.32\)](#page-38-0) show that

$$
\mathbb{E}[|R_n^3|] \le Kn^{1/(\alpha-1)\beta + (\alpha-1)\beta + 2},
$$

which implies that R_n^3 $\stackrel{\mathbb{P}}{\longrightarrow} 0$ as above, and the proof is complete.

We are now ready to complete the proof of $S_n \xrightarrow{d} S$.

Step 3. We will show that $\tilde{S}_n \stackrel{d}{\longrightarrow} S$. Since the random variables $(\tilde{Z}_r)_{r\geq 0}$ are independent and identically distributed with mean zero, it is enough to show that

$$
\lim_{x \to \infty} x^{(1-\alpha)\beta} \mathbb{P}(\tilde{Z}_0 > x) = \gamma \qquad \text{and} \qquad \lim_{x \to \infty} x^{(1-\alpha)\beta} \mathbb{P}(\tilde{Z}_0 < -x) = 0 \tag{5.33}
$$

cf. [\[36,](#page-53-3) Theorem 1.8.1]. The constant γ is defined in [\(5.37\)](#page-39-0) below. To show [\(5.33\)](#page-38-1) let us define the function $\overline{\Phi}: \mathbb{R} \to \mathbb{R}_+$ via

$$
\overline{\Phi}(x) := \sum_{j=1}^{\infty} \Phi_{\rho_0}(a_j x) \quad \text{where} \quad a_j := j^{\alpha} - (j-1)^{\alpha}.
$$

Note that [\(5.4\)](#page-30-1) implies that $\Phi_{\rho_0}(x) \ge 0$ and hence Φ is positive. Moreover, by [\(5.8\)](#page-31-4) and for $l \in (p, \beta)$ with $(1 - \alpha)l < -1$ we have

$$
|\overline{\Phi}(x)| \le K|x|^{l} \sum_{j=1}^{\infty} a_j^{\beta} \le K|x|^{l} \sum_{j=1}^{\infty} j^{\beta(\alpha-1)} < \infty,\tag{5.34}
$$

which shows that $\overline{\Phi}$ is finite. Eq. [\(5.34\)](#page-38-2) shows moreover that $\mathbb{E}[\overline{\Phi}(L_1)] < \infty$, and hence we can define a random variable \mathcal{Q}_0 via

$$
Q_0 = \overline{\Phi}(L_1) - \mathbb{E}[\overline{\Phi}(L_1)] = \sum_{j=1}^{\infty} (\Phi_{\rho_0}(a_j L_1) - \mathbb{E}[\Phi_{\rho_0}(a_j L_1)]),
$$

where the last sum converge absolutely a.s. Since $Q_0 \ge -\mathbb{E}[\overline{\Phi}(L_1)]$, we have that

$$
\lim_{x \to \infty} x^{(1-\alpha)\beta} \mathbb{P}(Q_0 < -x) = 0.
$$
\n(5.35)

By the substitution $t = (x/u)^{1/(1-\alpha)}$ we have that

$$
x^{1/(\alpha-1)}\overline{\Phi}(x) = x^{1/(\alpha-1)} \int_0^\infty \Phi_{\rho_0}(a_{1+[t]}x) dt
$$

= $(1-\alpha)^{-1} \int_0^\infty \Phi_{\rho_0}(a_{1+[(x/u)^{1/(1-\alpha)}]}x)u^{-1+1/(\alpha-1)} du$
 $\to (1-\alpha)^{-1} \int_0^\infty \Phi_{\rho_0}(\alpha u)u^{-1+1/(\alpha-1)} du = \kappa \quad \text{as } x \to \infty,$ (5.36)

 \Box

where we have used Lebesgue's dominated convergence theorem and the estimate [\(5.7\)](#page-31-8) on Φ_{ρ_0} , and the constant κ coincides with the definition in Remark 2.5. The connection between the tail behaviour of a symmetric ρ -stable random variable S_{ρ} , $\rho \in (1,2)$, and its scale parameter $\bar{\sigma}$ is given via

$$
\mathbb{P}(S_{\rho} > x) \sim \tau_{\rho} \bar{\sigma}^{\rho} x^{-\rho} / 2 \quad \text{as } x \to \infty,
$$

where the function τ_{ρ} has been defined in [\(2.4\)](#page-12-1) (see e.g. [\[36,](#page-53-3) Eq. (1.2.10)]). Hence, $\mathbb{P}(|L_1| > x) \sim \tau_{\beta} x^{-\beta}$ as $x \to \infty$, and we readily deduce by [\(5.36\)](#page-38-3) that

$$
\mathbb{P}(Q_0 > x) \sim \gamma x^{(1-\alpha)\beta} \quad \text{with} \quad \gamma = \tau_\beta \kappa^{(1-\alpha)\beta}.
$$
 (5.37)

Next we will show that for some $r > (1 - \alpha)\beta$ we have

$$
\mathbb{P}(|\tilde{Z}_0 - Q_0| > x) \le Kx^{-r} \qquad \text{for all } x \ge 1,\tag{5.38}
$$

which implies [\(5.33\)](#page-38-1), cf. [\(5.35\)](#page-38-4) and [\(5.37\)](#page-39-0). To show [\(5.38\)](#page-39-1) it is sufficient to find $r > (1-\alpha)\beta$ such that

$$
\mathbb{E}[|\tilde{Z}_0 - Q_0|^r] < \infty
$$

by Markov's inequality. Furthermore, by Minkowski inequality and the definitions of Q_0 and \tilde{Z}_0 it sufficers to show that

$$
\sum_{j=1}^{\infty} \|\Phi_{\rho_0}(W_{j,0}) - \Phi_{\rho_0}(a_j L_1)\|_{L^r} < \infty
$$
\n(5.39)

(recall that $r \ge 1$). We choose an r satisfying $(1 - \alpha)\beta < r < \beta$, which is always possible since we have $\alpha \in (0,1)$ under our assumptions. We note that $\phi_j(0) = a_j$, and hence obtain the estimates

$$
\|\phi_j - a_j\|_{L^{\beta}([0,1])} \le Kj^{\alpha - 2}, \qquad j \ge 1. \tag{5.40}
$$

For all $\epsilon > 0$ we have by Lemma [5.1,](#page-31-6) [\(5.14\)](#page-32-2) and [\(5.40\)](#page-39-2) that

$$
\|\Phi_{\rho_0}(W_{j,0}) - \Phi_{\rho_0}(a_j L_1)\|_{L^r} \le K\Big(j^{(\alpha-1)(\beta/r-\epsilon)-1} + j^{(\alpha-2)\beta/r}\Big)
$$

which shows [\(5.39\)](#page-39-3), by choosing $\epsilon = \beta/(2r)$ and noticing that $(\alpha - 2)\beta/r < \alpha - 2 < -1$. \Box

In the last step we will show that $r_n = n^{1 - \frac{1}{(1-\alpha)\beta}} (\mathbb{E}[|Y_1^n|^p] - m_p) \to 0$.

Step 4. Let $g_{0,n}$ and $h_{0,n}$ be defined as in [\(3.8\)](#page-15-4), and η_p be the absolute p-moment of a standard symmetric β -stable random variable. By Lemma 6.1(i)

$$
|r_n| = \eta_p n^{1 - \frac{1}{(1-\alpha)\beta}} n^{(\alpha+1/\beta)p} ||g_{0,n}||_{L^\beta}^\beta - ||h_{0,n}||_{L^\beta}^\beta|
$$

$$
\leq K n^{1 - \frac{1}{(1-\alpha)\beta} + (\alpha+1/\beta)p - \beta} \leq K n^{2 - \frac{1}{(1-\alpha)\beta} + (\alpha-1)\beta}
$$
 (5.41)

where the last inequality follows from the fact that $p < \beta$. Eq. [\(5.41\)](#page-39-4) implies that $r_n \to 0$, which completes the proof. \Box

5.2 Proof of Theorem [1.2\(](#page-4-0)ii)

We use the following decomposition:

$$
\sqrt{n}\left(n^{-1+p(\alpha+1/\beta)}V(p;k)_n - m_p\right) = Y_n^{(1)} + Y_n^{(2)}
$$

with

$$
Y_n^{(1)} := \sqrt{n} \left(n^{-1 + p(\alpha + 1/\beta)} V(p; k)_n - m_p^n \right), \qquad Y_n^{(2)} := \sqrt{n} (m_p^n - m_p).
$$

We will prove that $Y_n^{(2)} \to 0$ and

$$
Y_n^{(1)} = \frac{1}{\sqrt{n}} \sum_{i=k}^n Y_i^n \xrightarrow{d} \mathcal{N}(0, \eta^2), \quad \text{where} \quad Y_i^n = n^{p(\alpha+1/\beta)} \Big(|\Delta_{i,k}^n X|^p - \mathbb{E}[\Delta_{i,k}^n X|^p] \Big)
$$

and η^2 is defined at [\(2.5\)](#page-12-0). The proof of the latter relies on the short memory approximation of the random variables Y_i^n . Recalling the representation $\Delta_{i,k}^n X = \int_{\mathbb{R}} g_{i,n}(s) dL_s$, we introduce the random variables

$$
\Delta_{i,k}^{n,m}X:=\int_{\mathbb{R}}g_{i,n}(s)\mathbb{1}_{[(i-m)/n,(i+m)/n]}(s)\,dL_s.
$$

We will proceed by showing the convergence in distribution

$$
Y_{n,m}^{(1)} = \frac{1}{\sqrt{n}} \sum_{i=k}^{n} Y_i^{n,m} \stackrel{d}{\longrightarrow} \mathcal{N}(0, \eta_m^2) \quad \text{as } n \to \infty,
$$
 (5.42)

where $Y_i^{n,m} = n^{p(\alpha+1/\beta)} \Big(|\Delta_{i,k}^{n,m} X|^p - \mathbb{E}[|\Delta_{i,k}^{n,m} X|^p] \Big)$ and η_m^2 are positive constants. Next, we show that $\eta_m^2 \to \eta^2$ as $m \to \infty$. In the last step we prove that

$$
\lim_{m \to \infty} \limsup_{n \to \infty} \mathbb{E}[|Y_{n,m}^{(1)} - Y_n^{(1)}|^2] = 0.
$$
\n(5.43)

Step (i). To show [\(5.42\)](#page-40-0) we note that for fixed $n, m \geq 1$, ${Y_i^{n,m}}$ $i^{n,m}$: $i = k, \ldots, n$ are mdependent random variables. By stationarity and m-dependence of ${Y_i^{n,m}}$ $i^{n,m}: i = k, \ldots, n\}$ we have

$$
\text{var}(Y_{n,m}^{(1)}) = \frac{n-k}{n}\theta_n^m(0) + 2n^{-1}\sum_{i=1}^m (n-k-i)\theta_n^m(i) \tag{5.44}
$$

with $\theta_n^m(i) = \text{cov}(Y_k^{n,m})$ $\zeta_k^{n,m}, Y_{k+i}^{n,m}$). Set

$$
V_i^m = \int_{\mathbb{R}} h_k(i-s) \mathbb{1}_{[(i-m)/n,(i+m)/n]}(s) dL_s \quad \text{and} \quad Y_i^m = |V_i^m|^p - \mathbb{E}[|V_i^m|^p].
$$

By the the line above [\(4.48\)](#page-26-2) we deduce that for all $d \geq 1$ and as $n \to \infty$, $(Y_i^{n,m})$ $\binom{n,m}{i}$ $\binom{d}{i=1}$ $\stackrel{d}{\longrightarrow}$ $(Y_i^m)_{i=1}^d$. For any $q > 0$ with $pq < \beta$, the estimates of the proof of Theorem [1.1\(](#page-3-0)ii) show that

$$
\mathbb{E}[|Y_i^{n,m}|^q] \le K,\tag{5.45}
$$

and by the assumption $p < \beta/2$ we may choose $q > 2$. Hence, with $\theta^m(i) := \text{cov}(V_k^m, V_{k+i}^m)$, it follows that $\theta_n^m(i) \to \theta^m(i)$ as $n \to \infty$, which by [\(5.44\)](#page-40-1) implies that

$$
\text{var}(Y_{n,m}^{(1)}) \to \theta_n^m(0) + 2\sum_{i=1}^m \theta^m(i) =: \eta_m^2 \qquad \text{as } n \to \infty. \tag{5.46}
$$

By [\(5.45\)](#page-40-2) and [\(5.46\)](#page-41-0), the convergence [\(5.42\)](#page-40-0) follows by the main theorem in [\[12\]](#page-51-12) since the sequences $\{Y_i^{n,m}$ $i^{n,m}$: $i = k, ..., n$ are m-dependent for all $n \geq 1$. \Box *Step (ii)*. To show that $\eta_m^2 \to \eta^2$ as $m \to \infty$ we set

$$
V_i = \int_{\mathbb{R}} h_k(i-s) dL_s, \qquad Y_i = |V_i|^p - \mathbb{E}[|V_i|^p], \qquad \theta(i) = \text{cov}(Y_k, Y_{k+i}).
$$

By the definition of $\theta^m(i)$ and the continuity of the stochastic integrals (cf. [\[34\]](#page-53-8)) we have that $\theta^m(i) \to \theta(i)$ as $m \to \infty$. Applying the formulas [\(2.6\)](#page-13-0) and [\(2.7\)](#page-13-1) we obtain the expression

$$
\theta^{m}(i) = a_{p}^{-2} \int_{\mathbb{R}^{2}} \frac{1}{|s_{1}s_{2}|^{1+p}} \psi_{i}^{m}(s_{1}, s_{2}) ds_{1} ds_{2}, \quad \text{where}
$$

$$
\psi_{i}^{m}(s_{1}, s_{2}) = \exp\left(-\int_{\mathbb{R}} |s_{1}h_{k}^{m}(x) - s_{2}h_{k}^{m}(x+i)|^{\beta} dx\right)
$$

$$
-\exp\left(-\int_{\mathbb{R}} |s_{1}h_{k}^{m}(x)|^{\beta} + |s_{2}h_{k}^{m}(x+i)|^{\beta} dx\right)
$$

and $h_k^m(x) = h_k(x) \mathbb{1}_{[-m,m]}(x)$. The functions $u = h_k^m$ satisfies the estimate [\(6.7\)](#page-45-1) for all $n \geq 1$ since $|h_k^m(x)| \leq K|x|^{\alpha}$ for $x \in [0, k+1]$ and $|h_k^m(x)| \leq K|x|^{\alpha-k}$ for $x > k+1$. Since u does not depend on $n \geq 1$ we obtain, by letting $n \to \infty$ in the estimate of Lemma [6.3\(](#page-47-0)ii), that there exists some $r > 1$ such that

$$
|\theta^m(l)| \le Kl^{-r} \qquad \text{for all } m \ge 1, l \ge 0.
$$

Hence, by dominated convergence we have as $m \to \infty$,

$$
\eta_m^2 = \theta^m(0) + 2 \sum_{i=1}^m \theta^m(i) \to \theta(0) + 2 \sum_{i=1}^\infty \theta(i) = \eta^2.
$$

Step (iii). In this step we prove (5.43) . By stationarity we have that

$$
\mathbb{E}[|Y_{n,m}^{(1)} - Y_n^{(1)}|^2] \le 2 \sum_{i=0}^{n-k} \overline{\theta}_n^m(i) \tag{5.47}
$$

where $\overline{\theta}_n^m$ $\mathcal{L}_n^m(i) = \text{cov}(Y_k^{n,m} - Y_k^n, Y_{k+i}^{n,m} - Y_{k+i}^n)$. We introduce the notation

$$
f_n^m(x) := 1_{[-m,m]}(x)D^k g_n(x), \qquad f_n(x) := D^k g_n(x), \qquad \overline{f}_n^m = f_n^m - f_n
$$

where the functions g_n are defined at [\(3.8\)](#page-15-4). By [\(2.6\)](#page-13-0) and [\(2.7\)](#page-13-1) we have

$$
\overline{\theta}_{n}^{m}(i) = a_{p}^{-2} \int_{\mathbb{R}^{2}} \frac{1}{|s_{1}s_{2}|^{1+p}} \overline{\psi}_{i}^{n,m}(s_{1}, s_{2}) ds_{1} ds_{2},
$$

$$
\overline{\psi}_{i}^{n,m}(s_{1}, s_{2}) = \exp\left(-\int_{\mathbb{R}} |s_{1}\overline{f}_{n}^{m}(x) - s_{2}\overline{f}_{n}^{m}(x+i)|^{\beta} dx\right)
$$

$$
-\exp\left(-\int_{\mathbb{R}} |s_{1}\overline{f}_{n}^{m}(x)|^{\beta} + |s_{2}\overline{f}_{n}^{m}(x+i)|^{\beta} dx\right)
$$

By Lemma [3.1](#page-15-5) it follows that $u = \overline{f}_n^m$ $\binom{m}{n}$ satisfies [\(6.7\)](#page-45-1). Since u in addition vanishes on $[0, m]$, Lemma [6.3\(](#page-47-0)iii) and [\(5.47\)](#page-41-1) implies that there exists $r > 0$ such that

$$
\limsup_{n \to \infty} \mathbb{E}[|Y_{n,m}^{(1)} - Y_n^{(1)}|^2] \le Km^{-r}
$$

which shows (5.43) .

Steps (i)–(iii) implies that $Y_n^{(1)} \longrightarrow \mathcal{N}(0, \eta^2)$, and the convergence $Y_n^{(2)} = \sqrt{n} (m_p^n$ m_p) \rightarrow 0 follows by Step (iv) below.

Step (iv) . Following the same arguments as in Step 4 of the previous subsection, we readily deduce that

$$
|Y_n^{(2)}| \le Kn^{\alpha\beta + 3/2} \left| \|g_{0,n}\|_{L^\beta(\mathbb{R})}^\beta - \|h_{0,n}\|_{L^\beta(\mathbb{R})}^\beta \right|.
$$

Applying Lemma 6.1(ii) immediately shows that $Y_n^{(2)} \to 0$ as $n \to \infty$.

6 Appendix

In this section we present some technical results that are used in various proof steps. Recall the definition of the functions $g_{i,n}$ and $h_{i,n}$ in [\(3.8\)](#page-15-4) and [\(3.9\)](#page-15-8). Recall that $f : \mathbb{R}_+ \to \mathbb{R}$ is given by $f(x) = g(x)x^{-\alpha}$ for all $x > 0$, and $f(0) = 1$. We may and do extend f to a function $f : \mathbb{R} \to \mathbb{R}$ (also denoted f) which is differentiable on \mathbb{R} .

Lemma 6.1. (i) Assume that the conditions of Theorem [1.2\(](#page-4-0)i) hold. Then,

$$
\left| \|g_{0,n}\|^{\beta}_{L^{\beta}(\mathbb{R})} - \|h_{0,n}\|^{\beta}_{L^{\beta}(\mathbb{R})} \right| \leq Kn^{-\beta}.
$$

(ii) Assume that the conditions of Theorem [1.2\(](#page-4-0)ii) hold. Then

$$
\left| \|g_{0,n}\|^\beta_{L^\beta(\mathbb{R})} - \|h_{0,n}\|^\beta_{L^\beta(\mathbb{R})} \right| \le Kn^{-\alpha\beta - 2}.
$$

Proof. We recall that $g(x) = x_+^{\alpha} f(x)$ and $f(0) = 1$. We start by proving part (ii) of the lemma.

Recall that $k \ge 2$ and $\alpha \in (0, k - 2/\beta)$. By Lemma [3.1](#page-15-5) and condition $\alpha < k - 1/\beta$ it holds for all $n \geq 1$ that

$$
A_n := \int_{-\infty}^{-1} |h_{0,n}(x)|^{\beta} dx \le Kn^{-k\beta} \int_{1}^{\infty} x^{(\alpha - k)\beta} dx \le Kn^{-k\beta}.
$$
 (6.1)

 \Box

 \Box

The same estimate holds for the function $g_{0,n}$. On the other hand, we have that

$$
B_n := \left| \int_{-\frac{2k}{n}}^0 |g_{0,n}(x)|^\beta \, dx - \int_{-\frac{2k}{n}}^0 |h_{0,n}(x)|^\beta \, dx \right| \le Kn^{-\alpha\beta - 2},\tag{6.2}
$$

which follows by the estimate $||x|^{\beta} - |y|^{\beta}| \leq K \max\{|x|^{\beta-1}, |y|^{\beta-1}\}|x - y|$ for all $x, y > 0$, and that for all $x \in [-\frac{2k}{n}, 0]$ we have by differentiability of f at zero that

$$
|g_{0,n}(x) - h_{0,n}(x)| = \Big|\sum_{j=0}^k (-1)^j {k \choose j} \{f(-j/n - x) - 1\}(-j/n - x)^\alpha + \Big| \le Kn^{-1} |h_{0,n}(x)|,
$$

together with the estimate [\(3.12\)](#page-15-1) from Lemma [3.1](#page-15-5) on $h_{0,n}$ and $g_{0,n}$. Recalling that $g(x)$ = $x^{\alpha}_{+}f(x)$ and using kth order Taylor expansion of f at x, we deduce the following identity

$$
g_{0,n}(x) = \sum_{j=0}^{k} (-1)^{j} {k \choose j} g(-j/n - x)
$$

=
$$
\sum_{j=0}^{k} (-1)^{j} {k \choose j} (-j/n - x)^{\alpha} \left(\sum_{l=0}^{k-1} \frac{f^{(l)}(-x)}{l!} (-j/n)^{l} + \frac{f^{(k)}(\xi_{j,x})}{k!} (-j/n)^{k} \right)
$$

=
$$
\sum_{l=0}^{k-1} \frac{f^{(l)}(-x)}{l!} \left(\sum_{j=0}^{k} (-1)^{j} {k \choose j} (-j/n)^{l} (-j/n - x)^{\alpha} \right)
$$

+
$$
\left(\sum_{j=0}^{k} \frac{f^{(k)}(\xi_{j,x})}{k!} (-1)^{j} {k \choose j} (-j/n)^{k} (-j/n - x)^{\alpha} \right),
$$

where $\xi_{j,x}$ is a certain intermediate point. Now, by rearranging terms we can find coefficients $\lambda_0, \dots, \lambda_k$ and $\tilde{\lambda}_0, \dots, \tilde{\lambda}_k$ (which are in fact bounded functions in x) such that

$$
g_{0,n}(x) = \sum_{l=0}^{k} \lambda_l(x) n^{-l} \left(\sum_{j=l}^{k} (-1)^j \binom{k}{j} j(j-1) \cdots (j-l+1) (-j/n - x)^{\alpha} \right)
$$

=
$$
\sum_{l=0}^{k} \tilde{\lambda}_l(x) n^{-l} \left(\sum_{j=l}^{k} (-1)^j \binom{k-l}{j-l} (-j/n - x)^{\alpha} \right) =: \sum_{l=0}^{k} r_{l,n}(x).
$$

At this stage we remark that the term $r_{l,n}(x)$ involves $(k - l)$ th order differences of the function $(-x)_{+}^{\alpha}$ (at scale n^{-1} and with a certain shift) and $\lambda_0(x) = \tilde{\lambda}_0(x) = f(-x)$. Now, observe that

$$
C_n := \int_{-1}^{-\frac{2k}{n}} \left| |g_{0,n}(x)|^{\beta} - |h_{0,n}(x)|^{\beta} \right| dx
$$

$$
\leq K \int_{-1}^{-\frac{k}{n}} \max\{|g_{0,n}(x)|^{\beta-1}, |h_{0,n}(x)|^{\beta-1}\}|g_{0,n}(x) - h_{0,n}(x)| dx.
$$

Since $r_{0,n} = fh_{0,n}$, it holds that

$$
|r_{0,n}(x) - h_{0,n}(x)| \le Kn^{-k} x^{\alpha - k + 1}.
$$

Recalling that $\alpha \in (0, k - 2/\beta)$ and using the substitution $x = n^{-1}y$, we deduce that

$$
\int_{-1}^{-\frac{2k}{n}} \max\{|g_{0,n}(x)|^{\beta-1}, |h_{0,n}(x)|^{\beta-1}\}|r_{0,n}(x) - h_{0,n}(x)| dx \le Kn^{-\alpha\beta - 2}.
$$
 (6.3)

For $1 \leq l \leq k$, we readily obtain the approximation

$$
\int_{-1}^{-\frac{2k}{n}} \max\{|g_{0,n}(x)|^{\beta-1}, |h_{0,n}(x)|^{\beta-1}\}|r_{l,n}(x)| dx \leq Kn^{-l-1-\alpha\beta} \int_{k}^{n} y^{(\alpha-k)\beta+l} dy
$$

using again the substitution $x = n^{-1}y$. It holds that

$$
\int_{k}^{n} y^{(\alpha-k)\beta+l} dy \leq \begin{cases} K & (\alpha-k)\beta + l < -1\\ K \log(n) n^{(\alpha-k)\beta+l+1} & (\alpha-k)\beta + l \geq -1. \end{cases} \tag{6.4}
$$

.

By [\(6.3\)](#page-44-0) and [\(6.4\)](#page-44-1) we conclude that

$$
C_n \le K\left(n^{-\alpha\beta - 2} + \log(n)n^{-k\beta}\right)
$$

Since $\alpha\beta + 2 < k\beta$ due to the assumption $\alpha \in (0, k - 2/\beta)$, part (ii) readily follows from [\(6.1\)](#page-42-0) and [\(6.2\)](#page-43-0).

Now, we proceed with part (i), which is in fact easier. Recall that $k = 1$ and $\alpha \in$ $(0, 1 - 1/\beta)$, which implies that $\beta \in (1, 2)$. As in [\(6.1\)](#page-42-0) and [\(6.2\)](#page-43-0) it holds that

$$
A_n = \int_{-\infty}^{-1} |h_{0,n}(x)|^{\beta} dx \le Kn^{-\beta} \int_{1}^{\infty} x^{(\alpha-1)\beta} dx \le Kn^{-\beta}
$$
 (6.5)

(the same estimate holds for the function $g_{0,n}$) and

$$
B_n = \left| \int_{-\frac{2}{n}}^0 |g_{0,n}(x)|^\beta \, dx - \int_{-\frac{2}{n}}^0 |h_{0,n}(x)|^\beta \, dx \right| \le Kn^{-\alpha\beta - 2}.\tag{6.6}
$$

Finally, applying the methods of (6.3) – (6.4) , we deduce the inequality

$$
\left| \int_{-1}^{-\frac{2}{n}} |g_{0,n}(x)|^{\beta} dx - \int_{-1}^{-\frac{2}{n}} |h_{0,n}(x)|^{\beta} dx \right|
$$

\n
$$
\leq K \Big(\int_{-1}^{-\frac{2}{n}} |h_{0,n}(x)|^{\beta} x dx + n^{-1} \int_{-1}^{-\frac{2}{n}} |h_{0,n}(x)|^{\beta-1} x^{\alpha} dx \Big)
$$

\n
$$
\leq Kn^{-\beta}.
$$

Now, note that $\alpha\beta + 2 > \beta$ since $\alpha > 0$ and $\beta \in (1, 2)$. We obtain the assertion of part (i) by (6.5) and (6.6). by [\(6.5\)](#page-44-2) and [\(6.6\)](#page-44-3).

Now, we introduce an auxiliary continuous function $u = u_n : \mathbb{R}_+ \mapsto \mathbb{R}$, which satisfies the inequality

$$
|u(x)| \le K\left(|x|^{\alpha} \mathbb{1}_{[0,k+1]}(x) + |x|^{\alpha-k} \mathbb{1}_{[k+1,n]}(x) \right. \\ \left. + n^{\alpha-k} (\mathbb{1}_{[n,n+k]}(x) + v((x-k)/n) \mathbb{1}_{(n+k,\infty)}(x)) \right), \tag{6.7}
$$

where $v \in L^{\beta}((1,\infty)) \cap C((1,\infty))$ is a decreasing function. The next lemma presents some approximations for certain integrals of u.

Lemma 6.2. Suppose that u is a function satisfying [\(6.7\)](#page-45-1), $q \in [0, \beta/2)$, $k \ge 2$, $\alpha < k-2/\beta$ and set

$$
I_{l,n,q} := \int_0^\infty |u(x+l)|^{\beta-q} |u(x)|^q dx.
$$

(i) There exists $r = r_{\alpha,\beta,q,k} > 1$ such that for all $n \geq 1, l = 0, \ldots, n$ we have

$$
I_{l,n,q} \le K(l^{-r} + n^{-r}).\tag{6.8}
$$

(ii) There exists $r = r_{\alpha,\beta,q,k} > 0$ such that for all $m \geq 0$ and all functions u satisfying (6.7) and vanishing on $[0, m]$ we have

$$
\limsup_{n \to \infty} \sum_{l=0}^{n-1} I_{l,n,q} \le Km^{-r}.
$$
\n(6.9)

Proof. (i) To show the estimate [\(6.8\)](#page-45-2) we decompose $I_{l,n,q}$ into four terms as follows. First applying the estimate at [\(6.7\)](#page-45-1) we deduce that

$$
\int_0^{k+1} |u(x+l)|^{\beta-q} |u(x)|^q dx \leq K l^{(\alpha-k)(\beta-q)}.
$$

On the other hand, we obtain that

$$
\int_{k+1}^{n} |u(x+l)|^{\beta-q} |u(x)|^q \mathbb{1}_{\{x+l < n\}} dx
$$
\n
$$
\leq K l^{(\alpha-k)\beta} \int_{k+1}^{n} \left(\frac{x}{l} + 1\right)^{(\alpha-k)(\beta-q)} \left(\frac{x}{l}\right)^{(\alpha-k)q} dx
$$
\n
$$
\leq K l^{(\alpha-k)\beta+1} \int_{(k+1)/l}^{\infty} (y+1)^{(\alpha-k)(\beta-q)} y^{(\alpha-k)q} dy
$$
\n
$$
\leq K \max \{ \log(l) l^{(\alpha-k)\beta+1}, l^{(\alpha-k)(\beta-q)} \}.
$$

For the last approximation we used the fact that $(\alpha - k)\beta < -1$, which insures the integrability at infinity, while for the integrability near 0 we distinguished the cases (α −

 $k)q > -1$ and $(\alpha - k)q \leq -1$. Observing that the function v introduced at [\(6.7\)](#page-45-1) is continuous and hence bounded on compact sets, we conclude that

$$
\int_{k+1}^{n} |u(x+l)|^{\beta-q} |u(x)|^q 1_{\{x+l>n\}} dx \le Kn^{(\alpha-k)(\beta-q)} \int_{k}^{n} x^{(\alpha-k)q} dx
$$

\n
$$
\le K \begin{cases} \log(n)n^{(\alpha-k)\beta+1} & (\alpha-k)q \ge -1 \\ n^{(\alpha-k)(\beta-q)} & (\alpha-k)q < -1. \end{cases}
$$

Finally, for the last term we have that

$$
\int_n^{\infty} |u(x+l)|^{\beta-q}|u(x)|^q dx \le Kn^{(\alpha-k)\beta} \left(1+\int_n^{\infty} v(x/n)^{\beta} dx\right) \le Kn^{(\alpha-k)\beta+1},
$$

where we used that the function v is decreasing on $(1, \infty)$ and $v \in L^{\beta}((1, \infty))$. By noticing that max $\{(\alpha - k)\beta + 1, (\alpha - k)(\beta - q)\} < -1$, we obtain [\(6.8\)](#page-45-2) by a combination of the above four estimates.

(ii) To show [\(6.9\)](#page-45-3) suppose that the function u, in addition, vanish on $[0, m]$. By the decomposition and estimates use in (i) above we have

$$
\limsup_{n \to \infty} \sum_{l=0}^{n-1} I_{l,n,q} \le \limsup_{n \to \infty} \sum_{l=0}^{n} \tilde{I}_{l,n,q}
$$

where

$$
\tilde{I}_{l,n,q} := \int_m^n |u(x+l)|^{\beta-q} |u(x)|^q 1\!\!1_{\{x+l < n\}} dx.
$$

For all $l \leq m$,

$$
\tilde{I}_{l,n,q}^m \le K l^{(\alpha-k)\beta+1} \int_{m/l}^{\infty} (y+1)^{(\alpha-k)(\beta-q)} y^{(\alpha-k)q} dy \le K m^{(\alpha-k)\beta+1}
$$

and hence

$$
\limsup_{n\to\infty}\sum_{l=0}^n \tilde{I}_{l,n,q}\leq K\Big(m^{(\alpha-k)\beta+1}+\sum_{l=m+1}^\infty\max\{\log(l)l^{(\alpha-k)\beta+1},l^{(\alpha-k)(\beta-q)}\}\Big),
$$

showing [\(6.9\)](#page-45-3).

Now, we present one of the main results, which provides estimates for various covariance functions. Assume that a given function $u = u_n$ satisfies [\(6.7\)](#page-45-1) and define

$$
\theta_n(l) = a_p^{-2} \int_{\mathbb{R}^2} \frac{1}{|s_1 s_2|^{1+p}} \psi_l(s_1, s_2) ds_1 ds_2, \quad \text{where} \quad (6.10)
$$

$$
\psi_l(s_1, s_2) = \exp\left(-\int_{\mathbb{R}} |s_1 u(x) - s_2 u(x+l)|^{\beta} dx\right)
$$

$$
-\exp\left(-\int_{\mathbb{R}} |s_1 u(x)|^{\beta} + |s_2 u(x+l)|^{\beta} dx\right).
$$

 \Box

Lemma 6.3. Suppose that u is a function satisfying [\(6.7\)](#page-45-1) and $\theta_n(l)$ is defined in [\(6.10\)](#page-46-0).

(i) Assume that $k = 1$ and $\alpha < 1 - 1/\beta$. Then, for any $l \ge 1$, we obtain

$$
|\theta_n(l)| \le K l^{(\alpha - 1)\beta + 1}
$$

.

(ii) Suppose that $k \geq 2$ and $\alpha < k - 2/\beta$. There exists $r = r_{\alpha,\beta,q,k} > 1$ such that for all $n \geq 1, l = 0, \ldots, n$ we have

$$
\theta_n(l) \le K(l^{-r} + n^{-r}).
$$

(iii) Suppose that $k \geq 2$ and $\alpha < k - 2/\beta$. There exists $r = r_{\alpha,\beta,q,k} > 0$ such that for all $m \geq 0$ and all functions u satisfying [\(6.7\)](#page-45-1) and vanishing on $[0, m]$

$$
\limsup_{n \to \infty} \sum_{l=0}^{n-1} \theta_n(l) \leq K m^{-r}.
$$

Proof. (a) We decompose the first integral via $\int_{\mathbb{R}^2} = \int_{[-1,1]^2} + \int_{\mathbb{R}^2 \setminus [-1,1]^2}$. In this part we will analyze the second integral. We need the following identity to deal with large s_1, s_2 :

$$
\psi_l(s_1, s_2) = \exp\left(-(|s_1|^{\beta} + |s_2|^{\beta}) \int_{\mathbb{R}} |u(x)|^{\beta} dx\right)
$$

$$
\times \sum_{r \geq 1} \frac{1}{r!} \left(\int_{\mathbb{R}} |s_1 u(x) - s_2 u(x+l)|^{\beta} dx - \int_{\mathbb{R}} |s_1 u(x)|^{\beta} + |s_2 u(x+l)|^{\beta} dx\right)^r.
$$

We will make much use of the inequality

$$
\Big||x-y|^\beta-|x|^\beta-|y|^\beta\Big|\leq \begin{cases}K\left(\min\{|x|,|y|\}^\beta+\min\{|x|,|y|\}\max\{|x|,|y|\}^{\beta-1}\right) & \beta>1\\K\min\{|x|,|y|\}^\beta & \beta\leq 1.\end{cases}
$$

We start with the case $\beta \leq 1$. According to Lemma [6.2,](#page-45-0) for each $K > 0$ we can find $l_0, n_0 \in \mathbb{N}$ such that for all $l \geq l_0, n \geq n_0$ we have that $K' := I_{l,n,0} < K$. For such l and n we have

$$
\theta(l)_1^{\beta \le 1} := \int_{\mathbb{R}^2 \setminus [-1,1]^2} \frac{|\psi_l(s_1, s_2)|}{|s_1 s_2|^{1+p}} ds_1 ds_2
$$
\n
$$
\le K \int_{\mathbb{R}^2 \setminus [-1,1]^2} \frac{1}{|s_1 s_2|^{1+p}} \exp(-K(|s_1|^{\beta} + |s_2|^{\beta})) \sum_{r \ge 1} \frac{1}{r!} |s_2|^{\beta r} I_{l,n,0}^r ds_1 ds_2
$$
\n
$$
\le K I_{l,n,0} \int_{\mathbb{R}^2 \setminus [-1,1]^2} \frac{1}{|s_1 s_2|^{1+p}} \exp(-K|s_1|^{\beta} + (K' - K)|s_2|^{\beta}) ds_1 ds_2,
$$
\n(6.11)

where the latter integral is finite since $K' < K$. For $l < l_0$, we trivially have that

$$
|\theta_n(l)| < K,\tag{6.12}
$$

where we use that $|\psi_l(s_1, s_2)| < 2$ by definition. Let us now consider the case $\beta > 1$. Applying exactly the same arguments as for $\beta \leq 1$, we deduce for l large enough

$$
\theta(l)_1^{\beta > 1} \le K \int_{\mathbb{R}^2 \setminus [-1,1]^2} \frac{\left(-K(|s_1|^{\beta} + |s_2|^{\beta})\right)}{|s_1 s_2|^{1+p}} \times \sum_{r \ge 1} \frac{1}{r!} \left(|s_1|^{\beta - 1} |s_2| I_{l,n,\beta - 1} + |s_2|^{\beta} I_{l,n,0}\right)^r ds_1 ds_2
$$

$$
\le K(I_{l,n,\beta - 1} + I_{l,n,0}). \tag{6.13}
$$

This estimate completes the first part of the proof.

(b) Given the boundedness of the exponential function on compact intervals and symmetry arguments, we are left with discussing the quantity

$$
\theta(l)_2 := \int_{[0,1]^2} \frac{1}{|s_1s_2|^{1+p}} \Big(\int_{\mathbb{R}} \Big| |s_1u(x)-s_2u(x+l)|^{\beta} - |s_1u(x)|^{\beta} - |s_2u(x+l)|^{\beta} \Big| dx \Big) ds_1 ds_2.
$$

This requires a much deeper analysis. Clearly, we obtain the inequality

$$
\theta(l)_2 \le K(\theta(l)_{2.1} + \theta(l)_{2.2})
$$

with

$$
\theta(l)_{2.1} = \int_{[0,1]^2} \frac{1}{|s_1 s_2|^{1+p}} \left(\int_0^\infty \min\{|s_1 u(x)|^\beta, |s_2 u(x+l)|^\beta\} dx \right) ds_1 ds_2
$$

$$
\theta(l)_{2.2} = \int_{[0,1]^2} \frac{1}{|s_1 s_2|^{1+p}} \left(\int_0^\infty \min\{|s_1 u(x)|, |s_2 u(x+l)|\} \right)
$$

$$
\times \max\{|s_1 u(x)|^{\beta-1}, |s_2 u(x+l)|^{\beta-1}\} dx \right) ds_1 ds_2
$$

where the term $\theta(l)_{2,2}$ appears only in case $\beta > 1$. We start by handling the quantity $\theta(l)_{2,1}$. Set $a_k(x, l) := |u(x + l)|/|u(x)| \in \mathbb{R} \cup {\infty}$ for $x > 0$, and recall the convention $\int_{\infty}^{a} = 0$ for any $a \in \mathbb{R} \cup \{\pm \infty\}$. Notice that we can rearrange the involved integrals due to positivity of the integrand. Hence, we deduce

$$
\theta(l)_{2.1} = \theta(l)_{2.1.1} + \theta(l)_{2.1.2}
$$

with

$$
\theta(l)_{2.1.1} = \int_{[0,1]^2} (s_1 s_2)^{-1-p} \left(\int_0^\infty |s_1 u(x)|^\beta \mathbb{1}_{\{s_1 \le s_2 a_k(x,l)\}} dx \right) ds_1 ds_2
$$

=
$$
\int_0^\infty |u(x)|^\beta \left(\int_0^1 s_2^{-1-p} \int_0^{\min\{1, s_2 a_k(x,l)\}} s_1^{-1-p+\beta} ds_1 ds_2 \right) dx. \tag{6.14}
$$

Next we will estimate the parenthesis in [\(6.14\)](#page-48-0) as follows

$$
\int_{0}^{1} s_{2}^{-1-p} \int_{0}^{\min\{1,s_{2}a_{k}(x,l)\}} s_{1}^{-1-p+\beta} ds_{1} ds_{2}
$$
\n
$$
\leq K \int_{0}^{1} s_{2}^{-1-p} \Big(\mathbb{1}_{\{s_{2}a_{k}(x,l)\leq 1\}} \int_{0}^{s_{2}a_{k}(x,l)} s_{1}^{-1-p+\beta} ds_{1} + \mathbb{1}_{\{s_{2}a_{k}(x,l)\geq 1\}} \int_{0}^{1} s_{1}^{-1-p+\beta} ds_{1} \Big) ds_{2}
$$
\n
$$
\leq K \int_{0}^{1} s_{2}^{-1-p} \Big(\mathbb{1}_{\{s_{2}a_{k}(x,l)\leq 1\}} (s_{2}a_{k}(x,l))^{-p+\beta} + \mathbb{1}_{\{s_{2}a_{k}(x,l)\geq 1\}} \Big) ds_{2}
$$
\n
$$
\leq K \Big(\int_{0}^{\min\{1,a_{k}(x,l)^{-1}\}} a_{k}(x,l)^{\beta-p} s_{2}^{-1-2p+\beta} ds_{2} + \mathbb{1}_{\{a_{k}(x,l)^{-1}\leq 1\}} \int_{a_{k}(x,l)^{-1}}^{1} s_{2}^{-1-p} ds_{2} \Big)
$$
\n
$$
\leq K \Big(a_{k}(x,l)^{\beta-p} \big(\mathbb{1}_{\{a_{k}(x,l)^{-1}\leq 1\}} a_{k}(x,l)^{-(\beta-2p)} + \mathbb{1}_{\{a_{k}(x,l)^{-1}\geq 1\}} \big(1 + a_{k}(x,l)^{p} \big) \Big)
$$
\n
$$
\leq K \Big(\mathbb{1}_{\{|u_{k}(x+l)|\geq u_{k}(x)\}} \Big(2 \Big| \frac{u_{k}(x+l)}{u_{k}(x)} \Big|^{p} + 1 \Big) + \mathbb{1}_{\{|u_{k}(x+l)|\leq u_{k}(x)\}} \Big| \frac{u_{k}(x+l)}{u_{k}(x,l)} \Big|^{ \beta-p} \Big).
$$

Hence,

$$
\theta(l)_{2.1.1} \le K(I_{l,n,0} + I_{l,n,p}).\tag{6.15}
$$

We have

$$
\theta(l)_{2.1.2} = \int_{[0,1]^2} (s_1 s_2)^{-1-p} \left(\int_0^\infty |s_2 u(x+l)|^\beta \mathbb{1}_{\{s_2 \le s_1 a_k(x,l)^{-1}\}} dx \right) ds_1 ds_2
$$

=
$$
\int_0^\infty |u(x+l)|^\beta \left(\int_0^1 s_1^{-1-p} \int_0^{\min\{1, s_1 a_k(x,l)^{-1}\}} s_2^{-1-p+\beta} ds_2 ds_1 \right) dx, \quad (6.16)
$$

and the parenthesis in [\(6.16\)](#page-49-0) is estimated as follows

$$
\int_{0}^{1} s_{1}^{-1-p} \int_{0}^{\min\{1, s_{1} a_{k}(x, l)^{-1}\}} s_{2}^{-1-p+\beta} ds_{2} ds_{1}
$$
\n
$$
\leq K \Big(\int_{0}^{1} \mathbb{1}_{\{s_{1} \leq a_{k}(x, l)\}} s_{1}^{-1-p} (s_{1} a_{k}(x, l)^{-1})^{-p+\beta} ds_{1} + \int_{0}^{1} \mathbb{1}_{\{s_{1} \geq a_{k}(x, l)\}} s_{1}^{-1-p} ds_{1} \Big)
$$
\n
$$
\leq K \Big(a_{k}(x, l)^{p-\beta} \int_{0}^{\min\{1, a_{k}(x, l)\}} s_{1}^{-1-2p+\beta} ds_{1} + \mathbb{1}_{\{a_{k}(x, l) \leq 1\}} \int_{a_{k}(x, l)}^{1} s_{1}^{-1-p} ds_{1} \Big)
$$
\n
$$
\leq K \Big(a_{k}(x, l)^{p-\beta} \mathbb{1}_{\{a_{k}(x, l) \geq 1\}} + 2a_{k}(x, l)^{-p} \mathbb{1}_{\{a_{k}(x, l) \leq 1\}} \Big),
$$

which shows

$$
\theta(l)_{2.1.2} \le K(I_{l,n,0} + I_{l,n,p}).\tag{6.17}
$$

We also have $\theta(l)_{2.2} = \theta(l)_{2.2.1} + \theta(l)_{2.2.2}$ with

$$
\theta(l)_{2.2.1} = \int_{[0,1]^2} s_1^{-1-p} s_2^{-1-p} \Big(\int_0^\infty \mathbb{1}_{\{s_1 \le s_2 a_k(x,l)\}} s_1 |u(x)| s_2^{\beta-1} |u(x+l)|^{\beta-1} dx \Big) ds_1 ds_2
$$

\n
$$
\le \int_0^\infty u(x) u(x+l)^{\beta-1} \Big(\int_0^1 s_2^{\beta-2+p} \int_0^{s_2 a_k(x,l)} s_1^{-p} ds_1 ds_2 \Big) dx
$$

\n
$$
\le K \int_0^\infty |u(x)| |u(x+l)|^{\beta-1} \Big(\int_0^1 s_2^{\beta-2+p} (s_2 a_k(x,l))^{1-p} ds_2 \Big) dx
$$

\n
$$
\le K \int_0^\infty |u(x)| |u(x+l)|^{\beta-1} \Big(a_k(x,l)^{1-p} \int_0^1 s_2^{\beta-1} ds_2 \Big) dx
$$

\n
$$
\le K \int_0^\infty |u(x)|^p |u(x+l)|^{\beta-p} dx \le K I_{l,n,p}, \tag{6.18}
$$

and

$$
\theta(l)_{2.2.2} = \int_{[0,1]^2} s_1^{-1-p} s_2^{-1-p} \int_0^\infty \mathbb{1}_{\{s_2 \le s_1 a_k(x,l)^{-1}\}} s_1^{\beta-1} |u(x)|^{\beta-1} s_2 |u(x+l)| dx ds_1 ds_2
$$

=
$$
\int_0^\infty |u(x)|^{\beta-1} |u(x+l)| \Big[\int_0^1 s_1^{-2-p+\beta} \Big(\mathbb{1}_{\{s_1 a_k(x,l)^{-1} \le l\}} \int_0^{s_1 a_k(x,l)^{-1}} s_2^{-p} ds_2 + \mathbb{1}_{\{s_1 a_k(x,l)^{-1} \ge l\}} \int_0^1 s_2^{-p} ds_2 \Big) ds_1 \Big] dx.
$$

(6.19)

The bracket in [\(6.19\)](#page-50-0) is estimated as follows

$$
\int_{0}^{1} s_{1}^{-2-p+\beta} \left(\mathbb{1}_{\{s_{1}a_{k}(x,l)^{-1} \leq 1\}} \int_{0}^{s_{1}a_{k}(x,l)^{-1}} s_{2}^{-p} ds_{2} + \mathbb{1}_{\{s_{1}a_{k}(x,l)^{-1} \geq 1\}} \int_{0}^{1} s_{2}^{-p} ds_{2} \right) ds_{1}
$$
\n
$$
\leq K \int_{0}^{1} s_{1}^{-2-p+\beta} \mathbb{1}_{\{s_{1}a_{k}(x,l)^{-1} \leq 1\}} s_{1}^{1-p} a_{k}(x,l)^{p-1} ds_{1} + \mathbb{1}_{\{a_{k}(x,l) < 1\}} \int_{a_{k}(x,l)}^{1} s_{1}^{-2-p+\beta} ds_{1} \right)
$$
\n
$$
\leq K a_{k}(x,l)^{p-1} \int_{0}^{\min\{1,a_{k}(x,l)\}} s_{1}^{-1-2p+\beta} ds_{1} + \mathbb{1}_{\{a_{k}(x,l) \leq 1\}} a_{k}(x,l)^{-1-p+\beta} ds_{1} \right)
$$
\n
$$
\leq K \left(a_{k}(x,l)^{p-1} \mathbb{1}_{\{a_{k}(x,l) \geq 1\}} + a_{k}(x,l)^{-1-p+\beta} \mathbb{1}_{\{a_{k}(x,l) \leq 1\}} \right),
$$

which shows

$$
\theta(l)_{2.2.2} \le K \left(I_{l,n,0} + I_{l,n,p} \right). \tag{6.20}
$$

Combining the estimates [\(6.11\)](#page-47-1), [\(6.12\)](#page-47-2), [\(6.13\)](#page-48-1), [\(6.15\)](#page-49-1), [\(6.17\)](#page-49-2), [\(6.18\)](#page-50-1) and [\(6.20\)](#page-50-2), and applying now Lemma $6.2(i)$ –(ii) we obtain the desired assertion. \Box
