# FIXED POINTS OF IMPLICIT CONTRACTION MAPPINGS

1. In this note, the notion of "implicit contraction mapping" of a complete metric space into itself is introduced and some fixed point theorems for such a class of mappings are presented.

Let $R$ be the real axis, $R_{+}$the positive half-axis, $D=R_{+}^{0}$ the strict positive half-axis (i.e. $R_{+}=[0, \infty[, D=] 0, \infty[), S \neq \emptyset$ an arbitrary set and $\emptyset \neq P \subset S$ an arbitrary fixed subset.

Definition 1.1. A function $f: D \times D \times R_{+} \times R_{+} \times R_{+} \times R_{+} \rightarrow S$ will be said to have property $(P)$, if it satisfies
A. Global conditions:
a.1) $t, u>0, v, w, p, q \geq 0 \Longrightarrow$
$f(t, u, v, w, p, q)=f(t, u, w, v, p, q)=f(t, u, v, w, q, p)$
a.2) $u, v>0,0 \leq p \leq u+v, f(u, v, v, u, p, 0) \in P \Longrightarrow u \leq v$
a.3) $w>0 \Longrightarrow f(w, w, 0,0, w, w) \in S \backslash P$
B. Local conditions: $\forall r>0, \exists a(r) \in] 0, r[$ such that
b.1) $u, v \in[r, r+a(r)[, u \leq v, 0 \leq p \leq u+v \Longrightarrow f(u, v, v, u, p, 0) \in S \backslash P$
b.2) $t, p, q \in] r-a(r), r+a(r)[, u \in[r, r+a(r)[, v, w \in] 0, a(r)[\Longrightarrow$ $f(t, u, v, w, p, q) \in S \backslash P$
b.3) $t, p \in] r-a(r), r+a(r)[, u, v, q \in] 0, a(r)[\Longrightarrow f(t, u, v, r, p, q) \in S \backslash P$.

Definition 1.2. Let $f: D \times D \times R_{+} \times R_{+} \times R_{+} \times R_{+} \rightarrow S$ be a given function and let $(X, d)$ be a complete metric space. A mapping $T: X \rightarrow X$ will be called an implicit contraction mapping (abbreviated: i. c. m.) with respect to $f$, if
(1.1) $f(d(T x, T y), d(x, y), d(x, T x), d(y, T y), d(x, T y), d(y, T x)) \in P$ for all $x, y \in X, T x \neq T y$.

Our main result can be stated as follows.
Theorem 1.1. Suppose that $T: X \rightarrow X$ satisfies
(1.2) $T$ is an i. c. $m$. with respect to $f$
(1.3) $f$ has the property $(P)$.

Then, the following conclusions hold:
(1.4) $T$ has a unique fixed point $z \in X$
(1.5) $T^{n} x \rightarrow z$ as $n \rightarrow \infty, \forall x \in X$.

Proof. First, we prove the uniqueness of the fixed point of $T$. Let $u, v \in X$ be such that $u=T u, v=T v, u \neq v$. From (1.1) and a.3) we obtain
(1.6) $P \ni f(d(u, v), d(u, v), 0,0, d(u, v), d(u, v)) \in S \backslash P$,
a contradiction. Therefore, $u=v$; i.e., the fixed point of $T$ is unique. Now we prove the existence. Take any $x \in X$ and consider the sequence $\left\{T^{n} x ; n \geq 0\right\}$. If $T^{n} x=T^{n+1} x$ for some $n$, then the conclusion follows. Assume that $T^{n} x \neq$ $T^{n+1} x, \forall n \geq 0$. From (1.1) we have, $\forall n \geq 1$

$$
\begin{aligned}
& (1.7) \quad f\left(d\left(T^{n} x, T^{n+1} x\right), d\left(T^{n-1} x, T^{n} x\right), d\left(T^{n-1} x, T^{n} x\right)\right. \\
& \left.d\left(T^{n} x, T^{n+1} x\right), d\left(T^{n-1} x, T^{n+1} x\right), 0\right) \in P
\end{aligned}
$$

and, on the other hand
(1.8) $d\left(T^{n-1} x, T^{n+1} x\right) \leq d\left(T^{n-1} x, T^{n} x\right)+d\left(T^{n} x, T^{n+1} x\right)$.

From (1.7), (1.8) and a.2) we obtain, $\forall n \geq 1$ :
(1.9) $d\left(T^{n} x, T^{n+1} x\right) \leq d\left(T^{n-1} x, T^{n} x\right)$;
i.e., the sequence $\left\{d\left(T^{n} x, T^{n+1} x\right) ; n \geq 0\right\}$ decreases.

Let $r=\lim _{n \rightarrow \infty} d\left(T^{n} x, T^{n+1} x\right)$ and assume that $r>0$. One can find some rank $n(r) \geq 1$, such that

$$
\text { (1.10) } n \geq n(r) \Longrightarrow d\left(T^{n-1} x, T^{n} x\right) \in[r, r+a(r)[\text {. }
$$

Taking into account (1.8), (1.9), (1.10) and b.1) we have, $\forall n \geq n(r)$

$$
\begin{aligned}
& (1.11) f\left(d\left(T^{n} x, T^{n+1} x\right), d\left(T^{n-1} x, T^{n} x\right), d\left(T^{n-1} x, T^{n} x\right),\right. \\
& \left.d\left(T^{n} x, T^{n+1} x\right), d\left(T^{n-1} x, T^{n+1} x\right), 0\right) \in S \backslash P
\end{aligned}
$$

which contradicts (1.7) for $n \geq n(r)$. Therefore $r=0$.
Suppose that $\left\{T^{n} x ; n \geq 0\right\}$ is not a Cauchy sequence. Then there exist $\varepsilon>0$ and two sequences of natural numbers $\{m(j) ; j \geq 1\}$ and $\{n(j) ; j \geq 1\}$, $m(j)<n(j), \forall j \geq 1, m(j) \rightarrow \infty$ as $j \rightarrow \infty$ such that

$$
d\left(T^{m(j)} x, T^{n(j)} x\right) \geq \varepsilon, \text { while } d\left(T^{m(j)} x, T^{n(j)-1} x\right)<\varepsilon, \forall j \geq 1
$$

For the sake of simplicity, we shall write $m, n$, instead of $m(j), n(j)$, respectively. Now, since $d\left(T^{k} x, T^{k+1} x\right) \rightarrow 0$ as $k \rightarrow \infty$, we can find $j(\varepsilon) \geq 1$, such that

$$
\begin{aligned}
& (1.12) 0<d\left(T^{n-1} x, T^{n} x\right) \leq d\left(T^{m} x, T^{m+1} x\right)< \\
& (1 / 3) a(\varepsilon)<a(\varepsilon)<\varepsilon, \forall j \geq j(\varepsilon)
\end{aligned}
$$

On the other hand, from the triangle inequality we have, $\forall j \geq 1$

$$
\begin{aligned}
& (1.13) d\left(T^{m} x, T^{n} x\right)-d\left(T^{m} x, T^{m+1} x\right)-d\left(T^{n} x, T^{n+1} x\right) \leq \\
& d\left(T^{m+1} x, T^{n+1} x\right) \leq \\
& d\left(T^{m} x, T^{n} x\right)+d\left(T^{m} x, T^{m+1} x\right)+d\left(T^{n} x, T^{n+1} x\right), \\
& (1.14) d\left(T^{m} x, T^{n} x\right) \leq d\left(T^{m} x, T^{n-1} x\right)+d\left(T^{n-1} x, T^{n} x\right), \\
& (1.15) d\left(T^{m} x, T^{n} x\right)-d\left(T^{n} x, T^{n+1} x\right) \leq d\left(T^{m} x, T^{n+1} x\right) \leq \\
& d\left(T^{m} x, T^{n} x\right)+d\left(T^{n} x, T^{n+1} x\right), \\
& (1.16) d\left(T^{m} x, T^{n} x\right)-d\left(T^{m} x, T^{m+1} x\right) \leq d\left(T^{n} x, T^{m+1} x\right) \leq \\
& d\left(T^{m} x, T^{n} x\right)+d\left(T^{m} x, T^{m+1} x\right) .
\end{aligned}
$$

From (1.12)-(1.16) it easily follows, $\forall j \geq j(\varepsilon)$

$$
\begin{aligned}
& \text { (1.17) } d\left(T^{m+1} x, T^{n+1} x\right), d\left(T^{m} x, T^{n+1} x\right), d\left(T^{n} x, T^{m+1} x\right) \in \\
& ] \varepsilon-a(\varepsilon), \varepsilon+a(\varepsilon)\left[, \quad d\left(T^{m} x, T^{n} x\right) \in[\varepsilon, \varepsilon+a(\varepsilon)[.\right.
\end{aligned}
$$

Now, (1.1), (1.12), (1.17) and b.2) give us, for $j \geq j(\varepsilon)$
(1.18) $P \ni f\left(d\left(T^{m+1} x, T^{n+1} x\right), d\left(T^{m} x, T^{n} x\right), d\left(T^{m} x, T^{m+1} x\right)\right.$,
$\left.d\left(T^{n} x, T^{n+1} x\right), d\left(T^{m} x, T^{n+1} x\right), d\left(T^{n} x, T^{m+1} x\right)\right) \in S \backslash P$,
a contradiction. Therefore, $\left\{T^{n} x ; n \geq 0\right\}$ is a Cauchy sequence.
Since $(X, d)$ is complete, $T^{n} x \rightarrow z$, for some $z \in X$. We have two possibilities:
i) There exists a sequence of natural numbers $\{k(n) ; n \geq 0\}, k(n) \rightarrow \infty$ as $n \rightarrow \infty$, such that $T^{k(n)} x=z$. Then, $T^{k(n)+1} x=T z$. Letting $n$ tends to $\infty$ and using the fact that $\left\{T^{k(n)+1} x ; n \geq 0\right\}$ is a subsequence of $\left\{T^{n} x ; n \geq 0\right\}$, we get $z=T z$.
ii) There exists $n_{0} \in N$ such that $n \geq n_{0} \Longrightarrow T^{n} x \neq z$. Suppose that $z \neq T z$; then $r:=d(z, T z)>0$. We can find $n(r) \in N$ such that, $\forall n \geq n(r)$
(1.19) $0<d\left(T^{n} x, T^{n+1} x\right), d\left(T^{n} x, z\right)<(1 / 3) a(r)<a(r)<r$.

On the other hand, from the triangle inequality we have, $\forall n \geq 1$
(1.20) $r-d\left(T^{n} x, z\right) \leq d\left(T^{n} x, T z\right) \leq r+d\left(T^{n} x, z\right)$.

From (1.19), (1.20) we obtain, $\forall n \geq n(r)$
(1.21) $\left.d\left(T^{n} x, T z\right) \in\right] r-a(r), r+a(r)[$.

Now, (1.1), (1.19), (1.21) and b.3) give us, for $n \geq n(r)$
(1.22) $P \ni f\left(d\left(T^{n+1} x, T z\right), d\left(T^{n} x, z\right), d\left(T^{n} x, T^{n+1} x\right)\right.$,
$\left.r, d\left(T^{n} x, T z\right), d\left(z, T^{n+1} x\right)\right) \in S \backslash P$,
a contradiction. Therefore, $z=T z$, which completes the proof.
Q. E. D.
2. In this paragraph, we give some corollaries of the preceding main result. Let $R_{+}, D, S, P$ be defined as before.

Definition 2.1. A function $f: D \times D \times R_{+} \times R_{+} \rightarrow S$ will be said to have property $(P)$, if it satisfies
A. Global conditions:
a.1) $t, u>0, v, w \geq 0 \Longrightarrow f(t, u, v, w)=f(t, u, w, v)$,
a.2) $u, v>0, f(u, v, v, u) \in P \Longrightarrow u \leq v$,
a.3) $w>0 \Longrightarrow f(w, w, 0,0) \in S \backslash P$
B. Local conditions: $\forall r>0, \exists a(r) \in] 0, r[$ such that
b.1) $u, v \in[r, r+a(r)[, u \leq v \Longrightarrow f(u, v, v, u) \in S \backslash P$,
b.2) $t \in] r-a(r), r+a(r)[, u \in[r, r+a(r)[, v, w \in] 0, a(r)[\Longrightarrow$ $f(t, u, v, w) \in S \backslash P$,
b.3) $t \in] r-a(r), r+a(r)[, u, v \in] 0, a(r)[\Longrightarrow f(t, u, v, r) \in S \backslash P$.

Definition 2.2. Let $f: D \times D \times R_{+} \times R_{+}$be a given function. A mapping $T: X \rightarrow X$ will be called an i. c. $m$. with respect to $f$, if
(2.1) $f(d(T x, T y), d(x, y), d(x, T x), d(y, T y)) \in P$, $\forall x, y \in X, T x \neq T y$.

Theorem 2.1. Suppose that $T: X \rightarrow X$ satisfies
(2.2) $T$ is an i. c. m. with respect to $f$
(2.3) $f$ has the property ( $P$ ).

Then, the following conclusions hold:
(2.4) $T$ has a unique fixed point $z \in X$
(2.5) $T^{n} x \rightarrow z$ as $n \rightarrow \infty, \forall x \in X$.

Proof. Clearly, the preceding theorem is applicable.
Q. E. D.

Definition 2.3. A function $f: D \times D \rightarrow S$ will be said to have property $(P)$, if it satisfies
A. Global conditions
a.1) $u, v>0, f(u, v) \in P \Longrightarrow u \leq v$,
a.2) $w>0 \Longrightarrow f(w, w) \in S \backslash P$
B. Local conditions: $\forall r>0, \exists a(r) \in] 0, r[$ such that
b.1) $u, v \in[r, r+a(r)[, u \leq v \Longrightarrow f(u, v) \in S \backslash P$,
b.2) $t \in] r-a(r), r+a(r)[, u \in[r, r+a(r)[\Longrightarrow f(t, u) \in S \backslash P$,
b.3) $t \in] r-a(r), r+a(r)[, u \in] 0, a(r)[\Longrightarrow f(t, u) \in S \backslash P$.

Definition 2.4. Let $f: D \times D \rightarrow S$ be a given function. A mapping $T: X \rightarrow X$ will be called an i. c. $m$. with respect to $f$, if
(2.6) $f(d(T x, T y), d(x, y)) \in P, \forall x, y \in X, T x \neq T y$.

Theorem 2.2. Suppose that $T: X \rightarrow X$ satisfies
(2.7) $T$ is an i. c. m. with respect to $f$
(2.8) $f$ has the property ( $P$ ).

Then, the following conclusions hold:
(2.9) $T$ has a unique fixed point $z \in X$,
(2.10) $T^{n} x \rightarrow z$ as $n \rightarrow \infty, \forall x \in X$.

Proof. See the preceding result.

Remark. The main result is a partial extension of a result due to Hardy and Rogers [1]. Theorem 2.1 extends some results of Reich [3, 4], Rus [5, 6] and of the author [7, 8]; and Theorem 2.2 represents an extension of a result due to Boyd and Wong [2].
