# Presentations: from Kac-Moody groups to profinite and back

#### Abstract

We go back and forth between, on the one hand, presentations of arithmetic and KacMoody groups and, on the other hand, presentations of profinite groups, deducing along the way new results on both.

## Introduction

In recent years several papers have been dedicated to showing that finite simple groups or arithmetic groups have presentations with bounded number of generators and relations [KL06], [GKKL07], [GKKL08], [GKKL11], [Cap13]. This paper is about such quantitative results for some classes of profinite groups.

More precisely, we will give essentially optimal bounds on the size of the presentations of maximal compact subgroups and of maximal pro- $p$ subgroups of simple Chevalley groups over local fields. These results can be also expressed as bounds on 2-cohomology groups - see below.

Let $\mathbf{G}$ be a simple, simply connected, Chevalley group scheme of Lie rank $l$ and let $q$ be a power $p^{a}$ for some prime $p$ and some exponent $a \geqslant 1$. The non-Archimedean Lie group $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ acts simplicially on its Bruhat-Tits building [Tit79]. In this action, each facet stabilizer is an extension of a finite group of Lie type by a pro-p group. Combining this with a non-positive curvature argument implies that maximal pro-p subgroups in $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ are all conjugate to one another [Rém04, 1.C.2] (while this is not the case for maximal compact subgroups); we henceforth call pro-p Sylow subgroup a maximal pro-p subgroup of $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$. If $P$ is such a subgroup then, up to conjugating it, we can assume that we have $P<\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)<\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$. The group $\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)$ is a special maximal compact subgroup.

Theorem 0.1. There exists a constant $C>0$ such that for any simple, simply connected, Chevalley group $\mathbf{G}$ of rank $\geqslant 2$ and for any prime power $q=p^{a} \geqslant 4$, the group $G=\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)$ admits a profinite presentation $\Sigma(G)$, with $D_{\Sigma(G)}$ generators and $R_{\Sigma(G)}$ relations, satisfying

$$
D_{\Sigma(G)}+R_{\Sigma(G)} \leqslant C .
$$

For a group $X$, let $d(X)$ (respectively $r(X)$ ) denotes the minimal number of generators (respectively relations) of $X$ in its profinite or discrete presentation (depending on whether $X$ is a profinite or a discrete group). Then Theorem 0.1 implies that in particular

$$
d(G)+r(G) \leqslant C
$$

Theorem 0.1 is proved by combining the results of [Cap13] on bounded presentations of the discrete Kac-Moody group $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$, with the fact that it has the congruence subgroup property. It is important at this point to note that the above uniformness statement is not true globally, that is for abstract presentations of arithmetic groups obtained by replacing the local rings $\mathbf{F}_{q}[[t]]$ by rings of integers of global fields (see $\S 3$ below).

Now, $P$ as above is a subgroup of index $q^{O\left(l^{2}\right)}$ of $\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)$, from which one deduces, using the Reidemeister-Schreier theorem, that $P$ has a presentation $\Sigma(P)$ satisfying

$$
D_{\Sigma(P)}+R_{\Sigma(P)} \leqslant q^{O\left(l^{2}\right)}
$$

By different methods, we obtain a presentation of the pro- $p$ group $P$ with much better bounds. A word of explanation is needed here. Let $r_{p}(P)$ be the minimal number of relations needed to define $P$ as a pro-p group. In [Lub01, Corollary 5.5] it is shown that we have:

$$
r(P)=\max \left\{d(P), r_{p}(P)\right\}
$$

Theorem 0.2. Let $\mathbf{G}$ be a simple, simply connected, Chevalley group scheme of rank l. Let $P$ be a Sylow pro-p-subgroup of $G=\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ where $q=p^{a}$. Then at least for $l \geqslant 3, p \geqslant 3$
and $q \geqslant 16$, we obtain that $d(P)=a(l+1)$, so in particular $d(P)$ is linear in a and in $l$. On the other hand, $r_{p}(P)=r(P)$ is bounded from below and from above by polynomials of degree 2 in a and in $l$; these polynomials do not depend on $p$.

The precise formula on the number of generators is deduced from the Kac-Moody theory [CR14, Corollary 2.5]. The lower bound on the number of relations is derived from the GolodShafarevich inequality while the upper bound is again deduced from the theory of Kac-Moody groups. More precisely, a discrete Kac-Moody group $\Gamma_{0}$ is chosen carefully so that $P$ is equal to the pro- $p$ completion of a well-understood subgroup $\Gamma$ of $\Gamma_{0}$. The presentation of $\Gamma$ in the discrete category serves also as a presentation for $P$ in the pro- $p$ category.

The method of the proof enables us to go also backward and to deduce from the GolodShafarevich inequality that the stated presentation of $\Gamma$ is essentially optimal (see Corollary 2.6).

Recall that for a profinite group the number of relations is expressed by the dimensions of the 2nd cohomology groups of various modules [Lub01, Corollary 5.5, 5.6]. It gets a particular nice form for a pro- $p$ group $P$, where $r_{p}(P)=\operatorname{dim}_{\mathbf{Z} / p \mathbf{Z}} \mathrm{H}^{2}(P, \mathbf{Z} / p \mathbf{Z})$. Thus combining Theorems 0.1 and 0.2 we obtain

Corollary 0.3. Let $\mathbf{G}$ be a simple, simply connected, Chevalley group scheme of rank l. Let $P$ be a Sylow pro-p-subgroup in $G=\mathbf{G}\left(\mathbf{F}_{q} \llbracket t \rrbracket\right)$ with $q=p^{a}$. Then the following conditions hold:

1. If $l \geqslant 2$ and $q \geqslant 4$, then $\operatorname{dim}_{\mathbf{F}_{s}} \mathrm{H}^{2}(G, M) \leqslant C \cdot \operatorname{dim}_{\mathbf{F}_{s}} M$ for every simple $\mathbf{F}_{s} \llbracket G \rrbracket$-module $M$ and every prime $s$.
2. If $l \geqslant 3, p \geqslant 3$ and $q \geqslant 16$, then $\operatorname{dim}_{\mathbf{Z} / p \mathbf{Z}} \mathrm{H}^{2}(P, \mathbf{Z} / p \mathbf{Z})$ is bounded from below and from above by polynomials of degree 2 in a and in l; these polynomials do not depend on $p$.

Theorems 0.1 and 0.2 suggest that similar results are valid also in characteristic 0 , but our methods are not that efficient there (see $\S 3$ ). There are two main differences between the characteristic zero case and the positive characteristic case.

The first one is that in characteristic $p$ all local fields are obtained as completions of one global field $\mathbf{F}_{p}(t)$, while in characteristic 0 , there is no such global field. In our method of proof, which goes from global to local, this difference is crucial: we prove a uniform result for all groups defined over a given global field $k$ (Theorem 3.1), but there is no uniform result over all global fields (see Remark 3.4). Our uniform result for local fields in characteristic $p$ uses substantially the fact that they all are completions of one global field.

Secondly, the pro- $p$ Sylow subgroup of $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ is the pro- $p$ completion of a suitable Kac-Moody group (see Lemma 2.1 below for the exact result) and we are making a crucial use of this fact. No such result is known to us in characteristic 0 .

Still one has good reasons to believe that results like Theorem 0.1 and Theorem 0.2 are valid also in characteristic 0. In Section 3, we sketch few partial results in this direction.

The structure of the paper is as follows. Section 1 deals with uniformly bounded profinite presentations of maximal compact subgroups of non-archimedean Chevalley groups in characteristic $p$. Section 2 investigates more carefully the maximal pro- $p$ subgroups of these groups. Section 3 goes back to the questions of $\S 1$ in the characteristic 0 case. The proof for the global case is given in $\S 4$ and uses K-theory.

## 1 Presentations of $\mathbf{F}_{q}[[t]]$-points of split simple groups

Let $q=p^{a}$ with $p$ a prime and $a \geqslant 1$. Let $\mathbf{G}$ be a simple, simply connected, Chevalley group. In this section we are interested in controlling presentations of the virtually pro- $p$ groups $\mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right)$ for arbitrary exponent $e \geqslant 1$. The general idea of this section is that $\mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right)$ appears as a factor of the profinite completion of $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ and that a presentation of the latter discrete group naturally gives a profinite presentation of this completion.

Therefore, in the first half of the argument we are only interested in $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$. Usually, the main viewpoint on the group $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ is as an $S$-arithmetic group [Mar91]. It provides a lot of information (cf. [PR94]), but another possibility is to see it as a (split) Kac-Moody group of affine type. This gives additional information of combinatorial nature. Indeed, this group acts on a product of two twin buildings [Rém02, 12.6.3] and using the action on a single building, we can deduce from this a suitable amalgamation theorem for $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$. We use here a combination of the two viewpoints.

### 1.1 Bounded presentation for affine Kac-Moody groups over finite fields

To begin with, let us recall that by [Cap13, Theorem 2.1] there exists a so-called bounded family of presentations for affine Kac-Moody groups (with the exception of $\widetilde{A}_{1}$ and $* \widetilde{A}_{1}$ ). In particular, we have:

Theorem 1.1 ([Cap13]). There exists a constant $C>0$ such that for any simple, simply connected, Chevalley group scheme $\mathbf{G}$ of rank $\geqslant 2$ and for any prime power $q \geqslant 4$, the group $G=\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ admits a presentation $\Sigma(G)$ with $D_{\Sigma(G)}$ generators and $R_{\Sigma(G)}$ relations satisfying

$$
D_{\Sigma(G)}+R_{\Sigma(G)} \leqslant C .
$$

### 1.2 Bounded presentation for profinite Chevalley groups in characteristic $p$

We can now turn to completion processes. The following proposition provides a relationship between presentations of $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ and of $\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)$; it is a quantitative version of a method already used in [Lub05].

Proposition 1.2. Assume that the rank of the simple, simply connected, Chevalley group $\mathbf{G}$ is $\geqslant 2$ and that the arithmetic group $\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ has a presentation with $d$ generators and $r$ relations. Then for any $e \geqslant 1$, the group $\mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right)$ has a profinite presentation with $d$ generators and $r+1$ relations.

Proof. Set $A=\mathbf{F}_{q}\left[t, t^{-1}\right]$ and denote by $\widehat{A}$ the profinite completion of this ring. Let $\mathcal{P}$ be the set of monic irreducible polynomials in $\mathbf{F}_{q}[t]$ and $\mathcal{P}_{e}$ those of degree $e$. The prime ideals in $A=\mathbf{F}_{q}[t]\left[\frac{1}{t}\right]$ are parametrized by $\mathcal{P} \backslash\{t\}$, so by the Chinese remainder theorem, we have

$$
\widehat{A} \cong \prod_{f \in \mathcal{P} \backslash\{t\}} \widehat{A}^{f}
$$

where $\widehat{A}^{f}=\lim _{n \geqslant 1} A /\left(f^{n}\right)$ is isomorphic to $\mathbf{F}_{q^{\operatorname{deg}(f)}}[[x]]$. Using $\mathcal{P}=\bigsqcup_{e \geqslant 1} \mathcal{P}_{e}$, we see therefore that

$$
\widehat{A} \cong\left(\mathbf{F}_{q}[[t]]\right)^{q-1} \times \prod_{e \geqslant 2}\left(\mathbf{F}_{q^{e}}[[t]]\right)^{\# \mathcal{P}_{e}}
$$

We set $S=\{0 ; \infty\}$. The group $\mathbf{G}(A)$ is thus an $S$-arithmetic group. We denote by $\widehat{\mathbf{G ( A )}}$ its profinite completion and by $\overline{\mathbf{G}(A)}$ its $S$-congruence completion. The canonical map
$\pi: \widehat{\mathbf{G}(A)} \rightarrow \overline{\mathbf{G}(A)}$ is a continuous group homomorphism restricting to the identity map of the dense subgroup $\mathbf{G}(A)$; as a consequence, $\pi$ is surjective. Since there is no place of $\mathbf{F}_{q}(t)$ at which $\mathbf{G}$ is anisotropic and since $\mathbf{G}$ is simply connected, strong approximation [Pra77] implies that the $S$-congruence completion $\overline{\mathbf{G}(A)}$ is described by means of the $S$-adèles $\mathbf{A}_{S}$ of $\mathbf{F}_{q}(t)$. One therefore deduces:

$$
\overline{\mathbf{G}(A)} \cong \mathbf{G}(\widehat{A}) \cong \mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)^{q-1} \times \prod_{e \geqslant 2} \mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right)^{\# \mathcal{P}_{e}}
$$

Since $G$ has rank $\geqslant 2$, the answer to the congruence subgroup problem is positive for $\mathbf{G}(A)$ (see [Rag76], [PR83]), meaning that the map $\pi$ is also injective. In other words, we have $\widehat{\mathbf{G}(A)} \cong \mathbf{G}(\widehat{A})$. This implies that for any fixed $e \geqslant 1$, one can write $\widehat{\mathbf{G}(A)}$ as a product:

$$
\widehat{\mathbf{G}(A)}=\mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right) \times M
$$

where $M$ is a product of infinitely many groups of the form $\mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right)$ with finite multiplicity for each exponent $s \geqslant 1$.

By our group-theoretic hypothesis, the abstract group $\mathbf{G}(A)$ has a presentation with $d$ generators and $r$ relations, therefore so does $\widehat{\mathbf{G}(A)}$ as a profinite group. Now, notice that $M$, as a normal subgroup of $\widehat{\mathbf{G}(A)}$, is generated by one element! Indeed, every factor of $M$, say $\mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right)$, admits a semi-direct product decomposition $\mathbf{G}\left(\mathbf{F}_{q^{s}}\right) \ltimes Q$ where $Q$ is a pro- $p$ group [RR06, 1.C]; it follows for instance from [CR14, Corollary 2.5] that $Q$ is finitely generated as a pro- $p$ group. The semi-direct decomposition implies that $\mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right)$ has a unique maximal normal subgroup. Indeed, let $\pi: \mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right) \rightarrow S$ be a quotient map to a simple group. The group $Q$ is normal in $\mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right)$, therefore $\pi(Q)$ is a normal $p$-group in $S$, hence is trivial. This implies that $\pi$ factorizes through the $\operatorname{map} \mathbf{G}\left(\mathbf{F}_{q^{s}}[[t]]\right) \rightarrow \mathbf{G}\left(\mathbf{F}_{q^{s}}\right)$.

Pick then $g \in M$ such that each one of its coordinates is outside that maximal normal subgroup; it is not difficult to see that the normal closure $\langle\langle g\rangle\rangle_{M}$ of $g$ in $M$ is $M$ itself. Thus we get a profinite presentation for $\mathbf{G}\left(\mathbf{F}_{q^{e}}[[t]]\right)=\frac{\widehat{\mathbf{G}(A)}}{\{1\} \times\langle\langle g\rangle\rangle_{M}}$ which has $d$ generators and $r+1$ relations.

Proof of Theorem 0.1. This statement is now a consequence of the combination of Theorem 1.1 and Proposition 1.2.

Remark 1.3. In Theorem 0.1 we assume that $l \geqslant 2$. We believe it is also true for $l=1$, i.e., for $\mathrm{SL}_{2}\left(\mathbf{F}_{q}[[t]]\right)$.

## 2 Sylow pro-p-subgroups of Chevalley groups over $\mathbf{F}_{q}((t))$

The other type of compact subgroups we consider in this paper is given by the maximal pro- $p$ subgroups of $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$. To prove Theorem 0.2 we will use again Kac-Moody theory, but in a different way than in Theorem 0.1.

The idea is to see the pro- $p$ group we are interested in as the full pro- $p$ completion of a suitable arithmetic group, which can itself be seen as a subgroup of a Kac-Moody group over a finite field. Again we use the fact that a presentation for a discrete group naturally leads to a profinite or pro-p presentation of the corresponding completion.

### 2.1 The pro- $p$ completions

Let $q=p^{a}(a \geqslant 1)$ and $\mathbf{G}$ be a simple simply connected Chevalley group scheme of rank $l \geqslant 3$. Take $A=\mathbf{F}_{q}[t]$ and consider $\Gamma_{0}:=\mathbf{G}(A)$. Suppose further that $I=(f(t))$ is an ideal of $A$ generated by an irreducible polynomial $f(t)$ and $B$ is the completion of $A$ with respect to $I$. Let $P$ be a pro- $p$-Sylow subgroup of $\mathbf{G}(B)$. Then $P$ is an open maximal pro- $p$ subgroup of $\mathbf{G}(B)$. Now consider a very special case: $f(t)=t$, so $\left.B \cong \mathbf{F}_{q}[t t]\right]$. Set $\Gamma=\Gamma_{0} \cap P=\mathbf{G}(A) \cap P$.

Lemma 2.1. The group $P$ is the pro-p completion of $\Gamma$.
Proof. By the affirmative solution of the CSP (the congruence subgroup problem) for $\Gamma_{0}$, its profinite completion $\widehat{\mathbf{G ( A )}}$ is equal to $\prod_{Y} \mathbf{G}(Y)$, where $Y$ runs over all the completions of $A$ (one of which is $B$ ). As $\Gamma$ is of finite index in $\Gamma_{0}$, the profinite completion of $\Gamma$ can be easily read from that of $\Gamma_{0}: \widehat{\Gamma}=\prod_{Y \neq B} \mathbf{G}(Y) \times P$ when this time $Y$ runs over all of the completions of $A$ except for $B$. The completion $B$ contributes the factor $P$. Now, the pro- $p$ completion of a group is equal (by abstract nonsense) to the maximal pro-p quotient of its profinite completion. But for $Y \neq B$, the group $\mathbf{G}(Y)$ has no non-trivial $p$-quotients and so the maximal pro- $p$ quotient of $\widehat{\Gamma}$ is only $P$. This finishes the proof.

In what follows, we sum up the lemma by writing $P=\Gamma_{\hat{p}}$ (i.e. $\Gamma_{\hat{p}}$ henceforth denotes the pro- $p$ completion of a discrete group $\Gamma$ ).

### 2.2 Presentations of Sylow p-subgroups of $\mathrm{SL}_{3}\left(\mathbf{F}_{q}\right)$ and $\operatorname{Sp}_{4}\left(\mathbf{F}_{q}\right)$

As a preparation for proving Theorem 0.2 , we will now produce presentations of Sylow $p$-subgroups of $\mathrm{SL}_{3}\left(\mathbf{F}_{q}\right)$ (i.e., $A_{2}(q)$ ) and $\mathrm{Sp}_{4}\left(\mathbf{F}_{q}\right)$ (i.e., $C_{2}(q)$ ), with $q=p^{a}$. We single out these $p$-groups because, as we will see in the next section, they will turn out to be building blocks of $\Gamma$ from Lemma 2.1.

In what follows we will need the following well known result attributed to P. Hall.
Lemma 2.2. Let $G$ be a group that is an extension of $H$ by $N$

$$
1 \rightarrow N \rightarrow G \rightarrow H \rightarrow 1
$$

Suppose that $N$ has a finite presentation $N=\left\langle n_{1}, \ldots, n_{r} \mid R_{1}\left(n_{1}, \ldots, n_{r}\right), \ldots, R_{k}\left(n_{1}, \ldots, n_{r}\right)\right\rangle$ and $H$ has a finite presentation $H=\left\langle h_{1}, \ldots, h_{s} \mid W_{1}\left(h_{1}, \ldots, h_{s}\right), \ldots, W_{l}\left(h_{1}, \ldots, h_{s}\right)\right\rangle$. Then $G$ has the following finite presentation

$$
\begin{aligned}
& \qquad G=\left\langle n_{1}, \ldots, n_{r}, g_{1}, \ldots, g_{s}\right| R_{1}\left(n_{1}, \ldots n_{r}\right), \ldots, R_{k}\left(n_{1}, \ldots, n_{r}\right), g_{i} n_{j} g_{i}^{-1}=V_{i j}\left(n_{1}, \ldots, n_{r}\right) \\
& \left.\qquad g_{i}^{-1} n_{j} g_{i}=U_{i j}\left(n_{1}, \ldots, n_{r}\right), 1 \leqslant i \leqslant s, 1 \leqslant j \leqslant r, W_{i}\left(g_{1}, \ldots, g_{s}\right)=\widetilde{W}_{i}\left(n_{1}, \ldots, n_{r}\right), 1 \leqslant i \leqslant l\right\rangle \\
& \text { where } \pi\left(g_{i}\right)=h_{i}, 1 \leqslant i \leqslant s \text {, for the natural projection } \pi: G \rightarrow H \text { and relations } U_{i j}, V_{i j} \text { and } \\
& \widetilde{W}_{i} \text { are the obvious suspects. }
\end{aligned}
$$

### 2.2.1 Sylow $p$-subgroup of $\operatorname{SL}_{3}\left(\mathbf{F}_{q}\right)$

Suppose now that $S$ is a Sylow $p$-subgroup of the finite group $\operatorname{SL}_{3}\left(\mathbf{F}_{q}\right)$ where $q=p^{a}$ for $a \geqslant 1$. By [BD01, Th. 2], the group $S$ has the following minimal presentation on $2 a$ generators and with $2\left(a^{2}+a\right)$ relations.

There are elements $s_{1}\left(v_{k}\right), s_{2}\left(v_{k}\right) \in S, 1 \leqslant k \leqslant a$, that generate $S$ and are subject to the following relations:

1. $\left(s_{i}\left(v_{k}\right)\right)^{p}=1$ for $i=1,2$ and $1 \leqslant k \leqslant a$,
2. $\left[s_{i}\left(v_{k}\right), s_{i}\left(v_{k^{\prime}}\right)\right]=1$ for $i=1,2$ and $1 \leqslant k<k^{\prime} \leqslant a$,
3. $\left[s_{1}\left(v_{1}\right),\left[s_{1}\left(v_{k}\right), s_{2}\left(v_{1}\right)\right]\right]=\left[s_{2}\left(v_{1}\right),\left[s_{1}\left(v_{k}\right), s_{2}\left(v_{1}\right)\right]\right]=1$ for $1 \leqslant k \leqslant a$,
4. $\left[s_{1}\left(v_{k}\right)^{-1}, s_{2}\left(v_{k^{\prime}}\right)^{-1}\right]=\prod_{1 \leqslant r \leqslant a}\left[s_{1}\left(v_{r}\right), s_{2}\left(v_{1}\right)\right]^{c\left(k, k^{\prime}, r\right)}$ with some fixed $c\left(k, k^{\prime}, 1\right), \ldots, c\left(k, k^{\prime}, a\right) \in \mathbf{Z}$, for $1 \leqslant k \leqslant a$ and $2 \leqslant k^{\prime} \leqslant a$.

Notice that under a natural identification of $S$ with the unipotent radical of the standard Borel subgroup of $\operatorname{SL}_{3}\left(\mathbf{F}_{q}\right)$ (where the simple roots of $A_{2}$ are denoted by $\alpha_{1}$ and $\alpha_{2}$ ), we may choose $s_{1}\left(v_{k}\right)$ and $s_{2}\left(v_{k}\right)$ to correspond to $x_{\alpha_{1}}\left(v_{k}\right)$ and $x_{\alpha_{2}}\left(v_{k}\right), 1 \leqslant k \leqslant a$, where $v_{1}, \ldots, v_{a}$ are chosen to be some generators of $\mathbf{F}_{q}$, with $v_{1}=1$.

### 2.2.2 Sylow $p$-subgroup of $\operatorname{Sp}_{4}\left(\mathbf{F}_{q}\right)$

Let $S$ be a Sylow $p$-subgroup of $\operatorname{Sp}_{4}\left(\mathbf{F}_{q}\right)$ with $p$ odd.
On the one hand, as $\operatorname{Sp}_{4}\left(\mathbf{F}_{q}\right)$ is identified with the universal version of the group $C_{2}(q)$, it has a natural Steinberg presentation [GLS98, Theorem 1.12.1] and thus so does $S$. Unfortunately, this presentation of $S$ has $4(q-1)$ generators and $16(q-1)^{2}$ relations.

On the other hand, as $p \geqslant 3$, [GLS98, Th. 3.3.1] implies that in fact $S$ has a minimal set of generators $\left\{x_{\alpha}\left(v_{i}\right), x_{\beta}\left(v_{i}\right) \mid 1 \leqslant i \leqslant a\right\}$ where $v_{1}=1$ and $v_{i}(2 \leqslant i \leqslant a)$ generate $\mathbf{F}_{q}$ (here $\alpha$ and $\beta$ are simple roots of $C_{2}$, with $\alpha$ being a short root and $\beta$ a long one). In particular, $S$ is a group of order $p^{4 a}$ with $d(S)=2 a$. We may now apply [LS94, Prop. 3.4.1] to conclude that $S$ has a presentation with $2 a$ generators and $8 a^{2}$ relations. However shorter presentations of $S$ exist and would give more precise estimates for us.

We will now produce a presentation of $S$ on $2 a$ generators and with $\frac{7 a^{2}+17 a}{2}$ relations. The reader who is not concerned with this difference is welcome to skip the rest of this subsection.

Notice that $S$ is a semidirect product of its normal subgroup $S_{0}$ of order $q^{3}$ and its subgroup $S_{1}$ of order $q$. The former one is generated by $x_{\alpha}\left(v_{i}\right)$ and $x_{\alpha+\beta}\left(v_{i}\right)$ (for $1 \leqslant i \leqslant a$ ) and is isomorphic to a Sylow $p$-subgroup of $\operatorname{SL}_{3}\left(\mathbf{F}_{q}\right)$. The latter one is a root subgroup of $S$ generated by $x_{\beta}\left(v_{i}\right)$ (for $1 \leqslant i \leqslant a$ ). To present $S$, we are going to use the presentation of $S_{0}$ obtained in the previous subsection, then take a presentation of $S_{1}$ and finally use P. Hall's lemma (Lemma 2.2 above) to "glue" those two presentations together in order to obtain a presentation of $S$. We will then show that some of the relations (in this newly obtained presentation) are redundant and can be obtained as a consequence of other relations.

We begin by recording a combined list of generators and relations for a presentation of $S_{0}$ (given in 2.2.1) and for a presentation of $S_{1} \cong\left(\mathbf{F}_{q},+\right.$ ):
Generators: $x_{\alpha}\left(v_{k}\right), x_{\alpha+\beta}\left(v_{k}\right)$ and $x_{\beta}\left(v_{k}\right)$ with $1 \leqslant k \leqslant a$.

## Relations:

1. For $1 \leqslant k \leqslant a$,
(a) $\left(x_{\alpha}\left(v_{k}\right)\right)^{p}=1,\left(x_{\beta}\left(v_{k}\right)\right)^{p}=1$, and
(b) $\left(x_{\alpha+\beta}\left(v_{k}\right)\right)^{p}=1$,
2. $\left[x_{\alpha}\left(v_{k}\right), x_{\alpha}\left(v_{k^{\prime}}\right)\right]=1$ for $1 \leqslant k<k^{\prime} \leqslant a$,
3. $\left[x_{\beta}\left(v_{k}\right), x_{\beta}\left(v_{k^{\prime}}\right)\right]=1$ for $1 \leqslant k<k^{\prime} \leqslant a$,
4. $\left[x_{\alpha+\beta}\left(v_{k}\right), x_{\alpha+\beta}\left(v_{k^{\prime}}\right)\right]=1$ for $1 \leqslant k<k^{\prime} \leqslant a$,
5. $\left[x_{\alpha}\left(v_{1}\right),\left[x_{\alpha}\left(v_{k}\right), x_{\alpha+\beta}\left(v_{1}\right)\right]\right]=\left[x_{\alpha+\beta}\left(v_{1}\right),\left[x_{\alpha}\left(v_{k}\right), x_{\alpha+\beta}\left(v_{1}\right)\right]\right]=1$ for $1 \leqslant k \leqslant a$,
6. $\left[x_{\alpha}\left(v_{k}\right)^{-1}, x_{\alpha+\beta}\left(v_{k^{\prime}}\right)^{-1}\right]=\prod_{1 \leqslant r \leqslant a}\left[x_{\alpha}\left(v_{r}\right), x_{\alpha+\beta}\left(v_{1}\right)\right]^{c\left(k, k^{\prime}, r\right)}$ with some fixed $c\left(k, k^{\prime}, 1\right), \ldots, c\left(k, k^{\prime}, a\right) \in \mathbf{Z}$, for $1 \leqslant k \leqslant a$ and $2 \leqslant k^{\prime} \leqslant a$.

We are now going to list a few more relations that we will need in the future.
7. $x_{2 \alpha+\beta}\left(v_{i}\right)=\left[x_{\alpha}\left(\frac{1}{2} v_{i}\right), x_{\alpha+\beta}\left(v_{1}\right)\right]$ for $1 \leqslant i \leqslant a$,
8. $x_{\alpha}\left(\frac{1}{2} v_{i}\right)=\Pi_{j=1}^{a} x_{\alpha}\left(v_{j}\right)^{m_{j}}$ for all $1 \leqslant i \leqslant a$ with some $m_{j} \in \mathbf{Z}, 1 \leqslant j \leqslant a$,
9. $\left[x_{\alpha+\beta}\left(v_{1}\right), x_{\beta}\left(v_{i}\right)\right]=1$ for $1 \leqslant i \leqslant a$,
10. $\left[x_{\alpha+\beta}\left(v_{i}\right), x_{\beta}\left(v_{1}\right)\right]=1$ for $1 \leqslant i \leqslant a$,
11. $x_{2 \alpha+\beta}\left(v_{i}^{2}\right)^{-1}=\Pi_{k=1}^{a} x_{2 \alpha+\beta}\left(v_{k}\right)^{r_{k}}$ for all $1 \leqslant i \leqslant a$ where $r_{k} \in \mathbf{Z}$,
12. $\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right]=x_{\alpha+\beta}\left(v_{i}\right) x_{2 \alpha+\beta}\left(v_{i}^{2}\right)$ for $1 \leqslant i \leqslant a$.

We now use P. Hall's lemma that requires the following additional relations to hold:
(A) $x_{\beta}\left(v_{i}\right) x_{\alpha}\left(v_{j}\right) x_{\beta}\left(v_{i}\right)^{-1}=R_{i j}$ which is equivalent to $\left[x_{\beta}\left(v_{i}\right), x_{\alpha}\left(v_{j}\right)\right]=x_{\alpha+\beta}\left(v_{i} v_{j}\right) x_{2 \alpha+\beta}\left(v_{i} v_{j}^{2}\right)$ for $1 \leqslant i, j \leqslant a$,
(B) $x_{\beta}\left(v_{i}\right)^{-1} x_{\alpha}\left(v_{j}\right) x_{\beta}\left(v_{i}\right)=R_{i j}^{\prime}$ which is equivalent to $\left[x_{\alpha}\left(v_{j}\right)^{-1}, x_{\beta}\left(v_{i}\right)^{-1}\right]=x_{\alpha+\beta}\left(v_{i} v_{j}\right) x_{2 \alpha+\beta}\left(v_{i} v_{j}^{2}\right)^{-1}$ for $1 \leqslant i, j \leqslant a$,
(C) $x_{\beta}\left(v_{i}\right) x_{\alpha+\beta}\left(v_{j}\right) x_{\beta}\left(v_{i}\right)^{-1}=x_{\alpha+\beta}\left(v_{j}\right)$ for $1 \leqslant i, j \leqslant a$,
(D) $x_{\beta}\left(v_{i}\right)^{-1} x_{\alpha+\beta}\left(v_{j}\right) x_{\beta}\left(v_{i}\right)=x_{\alpha+\beta}\left(v_{j}\right)$ for $1 \leqslant i, j \leqslant a$.

By Lemma 2.2, the group $S$ has a presentation with $3 a$ generators (listed above) and in which the relations are given by (1)-(6) and (A)-(D). Notice that (7)-(12) must hold in $S$. We will now show that (A), (C) and (D) follow from (1)-(12) and (B). Furthermore, notice that (7), (11) and (12) imply that for $1 \leqslant j \leqslant a$, we have:

$$
x_{\alpha+\beta}\left(v_{i}\right)=\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right] \prod_{k=1}^{a}\left[\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{1}\right)\right], x_{\alpha}\left(\frac{1}{2} v_{k}\right)\right]^{-r_{k}}
$$

where for each $k$, the element $x_{\alpha}\left(\frac{1}{2} v_{k}\right)$ is expressed in terms of $x_{\alpha}\left(v_{i}\right)$ 's and $x_{\beta}\left(v_{i}\right)$ 's, $1 \leqslant i \leqslant a$, as in (8). In particular, we may remove $x_{\alpha+\beta}\left(v_{i}\right), 1 \leqslant i \leqslant a$, from the list of generators. Now counting the number of relations in (1)-(12) and (B), we obtain a presentation of $S$ on $2 a$ generators and the promised number of relations.

Claim 2.3. The following relations follow from the relations (1)-(12) and (B):

1. $\left[x_{\beta}\left(v_{j}\right), x_{2 \alpha+\beta}\left(v_{i}\right)\right]=1$ for all $1 \leqslant i, j \leqslant a$.
2. $\left.\left[\left[x_{\alpha}\left(v_{i}\right), x_{\beta}\left(v_{1}\right)\right], x_{\beta}\left(v_{j}\right)\right]\right]=1$ for $1 \leqslant i, j \leqslant a$.
3. $\left[x_{\alpha+\beta}\left(v_{i}\right), x_{\beta}\left(v_{j}\right)\right]=1$ for $1 \leqslant i, j \leqslant a$, i.e., relations $(C)$ and $(D)$.
4. relations $(A)$.

Proof. 1. Using (7) we observe that we have $\left[x_{2 \alpha+\beta}\left(v_{i}\right), x_{\beta}\left(v_{j}\right)\right]=\left[\left[x_{\alpha}\left(\frac{1}{2} v_{i}\right), x_{\alpha+\beta}\left(v_{1}\right)\right], x_{\beta}\left(v_{j}\right)\right]$ for $1 \leqslant i, j, \leqslant a$. Recall now the Hall-Witt identity formulated for our definition of the commutators:

$$
\left[\left[y, x^{-1}\right], z^{-1}\right]^{y^{-1}}\left[\left[z, y^{-1}\right], x^{-1}\right]^{z^{-1}}\left[\left[x, z^{-1}\right], y^{-1}\right]^{x^{-1}}=1
$$

Let us apply it with $y=x_{\alpha}\left(\frac{1}{2} v_{i}\right), x=x_{\alpha+\beta}\left(v_{1}\right)^{-1}$ and $z=x_{\beta}\left(v_{j}\right)^{-1}$. First notice that $\left[\left[x, z^{-1}\right], y^{-1}\right]=\left[\left[x_{\alpha+\beta}\left(v_{1}\right)^{-1}, x_{\beta}\left(v_{j}\right)\right], x_{\alpha}\left(\frac{1}{2} v_{i}\right)^{-1}\right]=\left[1, x_{\alpha}\left(\frac{1}{2} v_{i}\right)^{-1}\right]=1$ because of (9). Now, $\left[\left[z, y^{-1}\right], x^{-1}\right]=\left[\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(\frac{1}{2} v_{i}\right)^{-1}\right], x_{\alpha+\beta}\left(v_{1}\right)\right]=\left[\left[x_{\beta}\left(v_{j}\right)^{-1}, \Pi_{k=1}^{a} x_{\alpha}\left(v_{k}\right)^{-m_{k}}\right], x_{\alpha+\beta}\left(v_{1}\right)\right]$ by (8). Let us look more closely at $\left[x_{\beta}\left(v_{j}\right)^{-1}, \Pi_{k=1}^{a} x_{\alpha}\left(v_{k}\right)^{-m_{k}}\right]$. Using repeatedly the commutator relation $[a, b c]=[a, b][a, c]^{b}$ together with $(B)$ and the fact that the subgroup $H_{0}:=$ $\left\langle x_{\alpha+\beta}\left(v_{i}\right), x_{2 \alpha+\beta}\left(v_{i}\right), 1 \leqslant i \leqslant a\right\rangle$ of $S_{0}$ is normal in $S$, we see that $\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(\frac{1}{2} v_{i}\right)^{-1}\right] \in H_{0}$ for all $1 \leqslant i, j \leqslant a$. Now relations in $S_{0}$ tell us that $H_{0}$ is abelian and as $x_{\alpha+\beta}\left(v_{1}\right) \in H_{0}$, we conclude that $\left[\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(\frac{1}{2} v_{i}\right)^{-1}\right], x_{\alpha+\beta}\left(v_{1}\right)\right]=1$. At last the Hall-Witt identity gives us that $\left[\left[x_{\alpha}\left(\frac{1}{2} v_{i}\right), x_{\alpha+\beta}\left(v_{1}\right)\right], x_{\beta}\left(v_{j}\right)\right]=1$ for $1 \leqslant i, j \leqslant a$, which implies the desired result.
2. Our proof follows a similar one in [BD01]. We have that
$x_{\beta}\left(v_{j}\right)\left[x_{\alpha}\left(v_{i}\right), x_{\beta}\left(v_{1}\right)\right]=x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{j}\right) x_{\beta}\left(v_{j}\right)^{-1} x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{j}\right) x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{1}\right) x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{1}\right)^{-1}=$ $=x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{j}\right)\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(v_{i}\right)^{-1}\right] x_{\beta}\left(v_{1}\right) x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{1}\right)^{-1}$.

Since $\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(v_{i}\right)^{-1}\right]=\left[x_{\alpha}\left(v_{i}\right)^{-1}, x_{\beta}\left(v_{j}\right)^{-1}\right]^{-1}$, using relations $(B)$ together with part 1 and relations (10), we observe that $\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(v_{i}\right)^{-1}\right] x_{\beta}\left(v_{1}\right)=x_{\beta}\left(v_{1}\right)\left[x_{\beta}\left(v_{j}\right)^{-1}, x_{\alpha}\left(v_{i}\right)^{-1}\right]$. As furthermore, $x_{\beta}\left(v_{1}\right)$ commutes with $x_{\beta}\left(v_{j}\right)$, we have that
$x_{\beta}\left(v_{j}\right)\left[x_{\alpha}\left(v_{i}\right), x_{\beta}\left(v_{1}\right)\right]=x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{1}\right) x_{\beta}\left(v_{j}\right) x_{\beta}\left(v_{j}\right)^{-1} x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{j}\right) x_{\alpha}\left(v_{i}\right) x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{1}\right)^{-1}=$ $x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{1}\right) x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{j}\right) x_{\beta}\left(v_{1}\right)^{-1}=x_{\alpha}\left(v_{i}\right) x_{\beta}\left(v_{1}\right) x_{\alpha}\left(v_{i}\right)^{-1} x_{\beta}\left(v_{1}\right)^{-1} x_{\beta}\left(v_{j}\right)=\left[x_{\alpha}\left(v_{i}\right), x_{\beta}\left(v_{1}\right)\right] x_{\beta}\left(v_{j}\right)$
3. From (12) and (11) we have

$$
x_{\alpha+\beta}\left(v_{i}\right)=\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right] x_{2 \alpha+\beta}\left(v_{i}^{2}\right)^{-1}=\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right] \Pi_{k=1}^{a} x_{2 \alpha+\beta}\left(v_{k}\right)^{r_{k}}
$$

As $[a, b c]=[a, b][a, c]^{b},\left[x_{\beta}\left(v_{j}\right), x_{\alpha+\beta}\left(v_{i}\right)\right]=\left[x_{\beta}\left(v_{j}\right),\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right] \Pi_{k=1}^{a} x_{2 \alpha+\beta}\left(v_{k}\right)^{r_{k}}\right]=$ $=\left[x_{\beta}\left(v_{j}\right),\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right]\right]\left[x_{\beta}\left(v_{j}\right), \Pi_{k=1}^{a} x_{2 \alpha+\beta}\left(v_{k}\right)^{r_{k}}\right]^{\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right]}$.

Using part 2 , we see that $\left[x_{\beta}\left(v_{j}\right),\left[x_{\beta}\left(v_{1}\right), x_{\alpha}\left(v_{i}\right)\right]\right]=1$, and from part 1 it follows that the commutator $\left[x_{\beta}\left(v_{j}\right), \Pi_{k=1}^{a} x_{2 \alpha+\beta}\left(v_{k}\right)^{r_{k}}\right]=1$. This gives $(\mathrm{C})$. Now notice that $(D)$ is an immediate consequence of $(C)$.
4. Finally we observe that relations $(B)$ together with parts 1 and 3 imply that $x_{\beta}\left(v_{i}\right)^{-1}$ commutes with $\left[x_{\alpha}\left(v_{j}\right)^{-1}, x_{\beta}\left(v_{i}\right)^{-1}\right]$. Therefore by [BD01, Lemma 2] we have:

$$
\left[x_{\alpha}\left(v_{j}\right)^{-1}, x_{\beta}\left(v_{i}\right)\right]=\left[x_{\alpha}\left(v_{j}\right)^{-1}, x_{\beta}\left(v_{i}\right)^{-1}\right]^{-1}
$$

which in turn (using the relations in $S_{0}$ ) implies relations $(A)$.

### 2.3 Kac-Moody groups: presentation of $\Gamma=U_{+}$

Recall that $\bar{G}=\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ can be thought of as a topological Kac-Moody group. Since the rank of it as a Chevalley group is $l$, its Kac-Moody rank is $l+1$. Then $\mathbf{G}\left(\mathbf{F}_{q}[[t]]\right)$ can be naturally identified with a maximal parahoric subgroup and $P$ with the pro-unipotent radical $\bar{U}_{+}$of the standard Iwahori subgroup $\bar{B}_{+}$. Thus $P=\bar{U}_{+}$is the closure of $U_{+}$in $\bar{G}$ where $U_{+}$
is the subgroup of the corresponding minimal Kac-Moody group $\widetilde{G}=\mathbf{G}\left(\mathbf{F}_{q}\left[t, t^{-1}\right]\right)$ generated by the positive real root subgroups of $\widetilde{G}$ [RR06, Theorem 1.C].

In the notation of $\S 2.1$, we apply Lemma 2.1 with $\Gamma=U_{+}$: this tells us that $P$ is the pro- $p$ completion of the group $U_{+}$which, in what follows, is better understood than $P$ thanks to a combination of $\S 2.2$ and of Kac-Moody arguments which we explain in the rest of the subsection. We will then deduce a presentation of $P$ from a presentation of $\Gamma=U_{+}$because $P=\Gamma_{\hat{p}}$.

Let us go first a bit deeper into Kac-Moody theory. Let $A$ be the generalized Cartan matrix of $\widetilde{G}$ and $\pi=\left\{\alpha_{0}, \alpha_{1}, \ldots, \alpha_{l}\right\}$ be the set of its fundamental roots. Corollary 1.2 of [DM07] implies that if $A$ is 3 -spherical and $q \geqslant 16$, then $U_{+}$is an amalgamated product of the system $\left\{X_{\alpha_{i}}\right\} \cup\left\{X_{\alpha_{i}, \alpha_{j}}\right\}, 0 \leqslant i, j \leqslant l$, where each $X_{\alpha_{i}}=\left\langle x_{\alpha_{i}}(c) \mid c \in \mathbf{F}_{q}\right\rangle \cong\left(\mathbf{F}_{q},+\right)$ is a fundamental root subgroup of $\widetilde{G}$ and $X_{\alpha_{i}, \alpha_{j}}=\left\langle X_{\alpha_{i}}, X_{\alpha_{j}} \mid R_{i, j}\right\rangle$ where $R_{i, j}$ comes from the rank 2 subsystem with fundamental roots $\alpha_{i}$ and $\alpha_{j}$. To simplify things, let us denote $X_{i}:=X_{\alpha_{i}}$ and $X_{i, j}:=X_{\alpha_{i}, \alpha_{j}}$ (in particular, remark that $X_{i, j}=X_{j, i}$ for all $0 \leqslant i, j \leqslant l$ ). Thus in fact, $U_{+}$is a group generated by the elements of the root subgroups $X_{i}$ 's for $i=0,1, \ldots, l$ and presented by the relations between those generators that hold in $X_{i, j}$ for $0 \leqslant i, j \leqslant l$ (we may let $X_{i, i}:=X_{i}$ ).

Recall that the 3 -spherical condition means that every rank 3 subdiagram of the Dynkin diagram of the ambient group is of finite type. As $\widetilde{G}$ is (what is called in Kac-Moody theory) an untwisted affine group, from the list of Dynkin diagrams of $\widetilde{G}$ (cf. [Car05, Appendix]), we see that $l \geqslant 3$.

Let us now discuss the tools we will need to obtain an explicit presentation of $U_{+}$. Let $v_{1}, \ldots, v_{a}$ be generators of $\mathbf{F}_{q}$ with $v_{1}=1$. It is obvious that for each $i$,

$$
\left.\left\langle\left\{x_{\alpha_{i}}\left(v_{k}\right)\right\}_{1 \leqslant k \leqslant a}\right| x_{\alpha_{i}}\left(v_{k}\right)^{p}=1,\left[x_{\alpha_{i}}\left(v_{k}\right), x_{\alpha_{i}}\left(v_{k^{\prime}}\right)\right]=1 \text { for } 1 \leqslant k<k^{\prime} \leqslant a\right\rangle
$$

is a presentation of $X_{i}$. Therefore $U_{+}$is generated by elements $\left\{x_{\alpha_{i}}\left(v_{k}\right)\right\}_{1 \leqslant k \leqslant a, 0 \leqslant i \leqslant l}$ and the following $a(l+1)+\frac{1}{2} a(a-1)(l+1)=\frac{a(a+1)(l+1)}{2}$ relations must hold:

1. $x_{\alpha_{i}}\left(v_{k}\right)^{p}=1$ for $1 \leqslant k \leqslant a$ and $0 \leqslant i \leqslant l$.
2. $\left[x_{\alpha_{i}}\left(v_{k}\right), x_{\alpha_{i}}\left(v_{k^{\prime}}\right)\right]=1$ for $1 \leqslant k<k^{\prime} \leqslant a$ and $0 \leqslant i \leqslant l$.

The remaining relations will come from the subsystems $X_{i, j}$ for $0 \leqslant i \neq j \leqslant l$. Clearly, those depend on the type of $X_{i, j}$ which is determined by the type of root system generated by $\alpha_{i}$ and $\alpha_{j}$. Let us discuss those case-by-case.
Suppose first that $X_{i, j}$ is of type $A_{1} \times A_{1}$. Then $X_{i, j} \cong X_{i} \times X_{j}$ and we would need the following additional relations to describe $X_{i, j}$ in this case:
3. $\left[x_{i}\left(v_{k}\right), x_{j}\left(v_{k^{\prime}}\right)\right]=1$ for $1 \leqslant k, k^{\prime} \leqslant a$. Thus for every subsystem $X_{i, j}$ of type $A_{1} \times A_{1}$, we will have $a^{2}$ additional relations.

If $X_{i, j}$ is of type $A_{2}$, then $X_{i, j}$ is isomorphic to a Sylow $p$-subgroup of $\operatorname{SL}_{3}\left(\mathbf{F}_{q}\right)$, and so using the results of $\S 2.2 .1$, we notice that we need the following additional relations:
4. $\left[x_{i}\left(v_{1}\right),\left[x_{i}\left(v_{k}\right), x_{j}\left(v_{1}\right)\right]\right]=\left[x_{j}\left(v_{1}\right),\left[x_{i}\left(v_{k}\right), x_{j}\left(v_{1}\right)\right]\right]=1$ for $1 \leqslant k \leqslant a$, and
5. $\left[x_{i}\left(v_{k}\right)^{-1}, x_{j}\left(v_{k^{\prime}}\right)^{-1}\right]=\prod_{1 \leqslant r \leqslant a}\left[x_{i}\left(v_{r}\right), x_{j}\left(v_{1}\right)\right]^{c\left(k, k^{\prime}, r\right)}$ with some fixed $c\left(k, k^{\prime}, 1\right), \ldots, c\left(k, k^{\prime}, a\right)$ in $\mathbf{Z}$ for $1 \leqslant k, k^{\prime} \leqslant a$ and $k^{\prime} \neq 1$.
Thus for every subsystem $X_{i, j}$ of type $A_{2}$, we will have $2 a+a(a-1)=a(a+1)$ additional relations.
6. Finally, if $X_{i, j}$ is of type $C_{2}$, then $X_{i, j}$ is isomorphic to a Sylow $p$-subgroup of $\operatorname{Sp}_{4}\left(\mathbf{F}_{q}\right)$, and so we may use the results of $\S 2.2 .2$ telling us that we need

$$
\frac{7 a^{2}+17 a}{2}-2 a-a(a-1)=\frac{5 a^{2}+15 a}{2}
$$

additional relations. These relations are relations (1b), (4)-(12) and (B) listed explicitly in $\S 2.2 .2$.

Finally, notice that all of the above relations are products of $p$-powers and commutators. This observation implies that

$$
U_{+} /\left[U_{+}, U_{+}\right] U_{+}^{p} \cong \mathbf{F}_{p}^{a(l+1)}
$$

(see also Corollary 2.5 of [CR14]).
We can now summarise:
Proposition 2.4. The following holds:

1. $U_{+} /\left[U_{+}, U_{+}\right] U_{+}^{p} \cong \mathbf{F}_{p}^{a(l+1)}$, and so $d\left(U_{+}\right)=a(l+1)$.
2. The group $U_{+}$has a presentation $\left\langle\left\{x_{i}\left(v_{k}\right)\right\}_{0 \leqslant i \leqslant l, 1 \leqslant k \leqslant a} \mid R\right\rangle$ such that $R$ are as described in (1)-(6) above.
3. 

$$
\begin{gathered}
\left.r\left(U_{+}\right) \leqslant \frac{a(a+1)(l+1)}{2}+\mid\left\{X_{i, j} \mid X_{i, j} \text { is of type } A_{1} \times A_{1}\right\} \right\rvert\, \cdot a^{2} \\
+\mid\left\{X_{i, j} \mid X_{i, j} \text { is of type } A_{2}\right\}|\cdot a(a+1)+|\left\{X_{i, j} \mid X_{i, j} \text { is of type } C_{2}\right\} \left\lvert\, \cdot \frac{5 a^{2}+15 a}{2} .\right.
\end{gathered}
$$

### 2.4 Case-by-case evaluation of $r_{p}(P)$

We may now evaluate $r\left(U_{+}\right)$in each case using Proposition 2.4. We then record the datum and the outcomes of the calculations in Table 1.

### 2.5 Conclusion

The number of generators of $P=\Gamma_{\hat{p}}$ in its presentation coming from $\Gamma$ is $a(l+1)$. This is in fact a presentation with a minimal number of generators (by Prop. 2.1(1) - see also [CR14, Cor. 2.5]). Moreover the generators can be chosen to be $x_{0}\left(v_{k}\right), \ldots, x_{l}\left(v_{k}\right), 1 \leqslant k \leqslant a$. Our discussion gives us that $P$ has a presentation $\left\langle x_{0}\left(v_{k}\right), \ldots, x_{l}\left(v_{k}\right), 1 \leqslant k \leqslant a \mid R\right\rangle$ with $|R| \leqslant C a^{2}(l+1)^{2}$ (with $C$ an appropriate constant as calculated in the previous subsection). Now the results of [LS94] (Proposition 5.4 and the discussion following Proposition 5.5) imply:

$$
\frac{a^{2}(l+1)^{2}}{4} \leqslant r(P),
$$

which is a Golod-Shafarevich type inequality. Combining those two gives us the desired result, which using Table 1, we sum up here:

Theorem 2.5. Let $\mathbf{G}\left(\mathbf{F}_{q}((t))\right)$ be a simple, simply connected, Chevalley group of rank l over a field $\mathbf{F}_{q}((t))$ with $q=p^{a} \geqslant 16$, and let $P$ be its Sylow pro-p-subgroup. Then

$$
\frac{a^{2}(l+1)^{2}}{4} \leqslant r(P)
$$

and the following upper bounds hold:

1. If $G$ has type $A_{l}, l \geqslant 3$ and $p \geqslant 2$, then $r(P) \leqslant \frac{a^{2}(l+1)^{2}+3 a(l+1)}{2}$.
2. For type $B_{l}, l \geqslant 3$ and $p \geqslant 3$, then $r(P) \leqslant \frac{a^{2}(l+1)^{2}+3 a(l+1)+3 a^{2}+11 a}{2}$.
3. For type $C_{l}, l \geqslant 3$ and $p \geqslant 3$, then $r(P) \leqslant \frac{a^{2}(l+1)^{2}+3 a(l+1)+6 a^{2}+24 a}{2}$.
4. For type $D_{l}, l \geqslant 4$ and $p \geqslant 2$, then $r(P) \leqslant \frac{a^{2}(l+1)^{2}+3 a(l+1)-2 a}{2}$.
5. For type $E_{l}, l \in\{6,7,8\}$ and $p \geqslant 2$, then $r(P) \leqslant \frac{a^{2}(l+1)^{2}+3 a(l+1)-2 a}{2}$.
6. For type $F_{4}$ and $p \geqslant 3$, then $r(P) \leqslant 14 a^{2}+13 a$.

### 2.6 Back to $U_{+}$

The equality $P=\Gamma_{\hat{p}}=\left(U_{+}\right)_{\hat{p}}$ was used in the previous subsections to derive an upper bound on the number of relations needed to present $P$ as a pro- $p$ group. But it can be also used to deduce a lower bound on the number of relations needed to present $\Gamma=U_{+}$in the discrete category.

Corollary 2.6. For $\Gamma=U_{+}$we have:

$$
d(\Gamma)=a(l+1) \quad \text { and } \quad \frac{a^{2}(l+1)^{2}}{4} \leqslant r(\Gamma) \leqslant 7.25 \cdot \frac{a^{2}(l+1)^{2}}{4}
$$

Proof. The result on $d(\Gamma)$ was shown above (Proposition 2.4) and so is the upper bound on $r(\Gamma)$ (in fact, slightly better bounds are given in Theorem 2.5). The lower bound is deduced from the fact that $r(\Gamma) \geqslant r_{p}\left(\Gamma_{\hat{p}}\right)=r_{p}(P)$ and the Golod-Shafarevich inequality applied to $P$ as in Theorem 2.5.

Remark 2.7. The last corollary is slightly surprising: usually the Steinberg type presentations of groups are far from being optimal. In our case the Steinberg-like presentations are essentially optimal.

## 3 The characteristic 0 case

Some results like Theorems 0.1 and 0.2 can be proved also in characteristic 0 . But our results in this case are weaker than the above theorems.

In this section let $k$ be a number field, $\mathcal{O}$ its ring of integers and $V$ the set of its finite valuations. For $v \in V$, let $k_{v}$ be the completion of $k$ with respect to $v$, and $\mathcal{O}_{v}$ the closure of $\mathcal{O}$ in $k_{v}$. For such a $v$, denote by $\mathbf{F}_{p_{v}}$ the finite residue field of $k$. Let $\mathbf{G}$ be a simple simply connected Chevalley group scheme of arbitrary rank $l \geqslant 1$, let $G=\mathbf{G}\left(\mathcal{O}_{v}\right)$ and let $P$ be a Sylow pro- $p_{v}$ subgroup of $G$. Here is what we can prove in this situation.

Theorem 3.1. There exists a constant $C_{1}=C_{1}(k)$ such that for every $v \in V$ and every $\mathbf{G}$ and $G$ as above, $G=\mathbf{G}\left(\mathcal{O}_{v}\right)$ has a presentation $\Sigma(G)$, with $D_{\Sigma(G)}$ generators and $R_{\Sigma(G)}$ relations, satisfying

$$
D_{\Sigma(G)}+R_{\Sigma(G)} \leqslant C_{1} .
$$

Theorem 3.2. With the notations as above, assume that $p_{v}>2$ if $\mathbf{G}$ is $B_{l}, C_{l}$ or $F_{4}$ and that $p_{v}>3$ if $\mathbf{G}=G_{2}$. Then $P$ is generated by at least $a_{v} l$ and at most $a_{v}(l+1)$ generators. Moreover, there exist absolute constants $C_{2} \geqslant 0$ and $C_{3} \geqslant 0$ such that:

- the group $P$ has a presentation with $a_{v}(l+1)$ generators and at most $C_{2} a_{v}^{2} l^{4}$ relations;
- any presentation of $P$ needs at least $C_{3} a_{v}^{2} l^{2}$ relations.

Theorem 3.1 can be deduced from the following result.
Theorem 3.3. There exists a constant $C_{4}=C_{4}(k)$ such that $\Lambda=\mathbf{G}(\mathcal{O})$ has a presentation $\Sigma_{\Lambda}$, with $D_{\Sigma_{\Lambda}}$ generators and $R_{\Sigma_{\Lambda}}$ relations, satisfying

$$
D_{\Sigma_{\Lambda}}+R_{\Sigma_{\Lambda}} \leqslant C_{4} .
$$

Let us make the following remark.
Remark 3.4. 1. We believe that the lower bound in Theorem 3.2 above is sharp.
2. We do not know if the constant $C_{1}(k)$ in Theorem 3.1 really depends on $k$.
3. On the other hand, $C_{4}$ does depend on $k$, or at least on the degree $[k: \mathbf{Q}]$. To see this, let $k_{i}$ be a sequence of number fields with $\left[k_{i}: \mathbf{Q}\right]=n_{i} \rightarrow \infty$ such that there exists a rational prime $p$ which splits completely in all the $k_{i}$ 's. Then by the Strong Approximation Theorem, the group $\mathbf{G}(\mathcal{O})$ is mapped onto $G\left(\mathbf{F}_{p}\right)^{n_{i}}$ and since $d\left(\mathbf{G}\left(\mathbf{F}_{p}\right)^{n_{i}}\right)$ grows logarithmically with $n_{i}$ [Wie'74], $d(\mathbf{G}(\mathcal{O}))$ grows to infinity with $[k: \mathbf{Q}]$.
Such a sequence of fields exists. For example, denote by $\left\{p_{i}\right\}_{i \in \mathbf{N}}$ the sequence of odd primes which congruent to $2=3^{2}$ modulo $7: p_{1}=23, p_{2}=37$, etc. and then set $k_{0}=\mathbf{Q}$ and then $k_{i+1}=k_{i}\left(\sqrt{p_{i+1}}\right)$. The polynomial $x^{2}-p_{i+1}$ is irreducible over $k_{i}$, but reducible over $\mathbf{F}_{7}$. Hence, if $\mathcal{O}_{i}$ denotes the ring of integers of $k_{i}$, we should have $\mathcal{O}_{i} / 7 \mathcal{O}_{i}=(\mathbf{Z} / 7 \mathbf{Z})^{2^{i}}$.

Let us postpone the proof of Theorem 3.3 until Section 4. Instead now we show how it implies Theorem 3.1.

Proof of Theorem 3.1. Let us first assume that $\mathbf{G}$ is of rank $\geqslant 2$. Then the group $\mathbf{G}(\mathcal{O})$ has the congruence subgroup property in the sense that $\widehat{\mathbf{G ( O )}} \rightarrow \mathbf{G}(\widehat{\mathcal{O}})$ is onto with a cyclic kernel (see [Rag76], [PR83]). The presentation of $\mathbf{G}(\mathcal{O})$, promised in Theorem 3.3, gives a profinite presentation of $\widehat{\mathbf{G ( O )}}$ and so, with one additional relation used to kill the cyclic kernel if needed, it serves as a presentation of $\mathbf{G}(\widehat{\mathcal{O}})$. As in the proof of Proposition 1.2, since $\mathbf{G}(\widehat{\mathcal{O}})=\mathbf{G}\left(\mathcal{O}_{v}\right) \times M$ where $M$ is normally generated by one element, Theorem 3.1 is proved with $C_{1} \leqslant C_{4}+2$.

The remaining case is when $\mathbf{G}=\mathrm{SL}_{2}$. In this situation, we pick a prime $v_{0}$ of $\mathcal{O}$ and work with the arithmetic group $\mathrm{SL}_{2}\left(\mathcal{O}\left[\frac{1}{v_{0}}\right]\right)$ which enjoys the congruence subgroup property: we can
then use the surjective map with trivial kernel $\mathrm{SL}_{2}\left(\widehat{\mathcal{O}\left[\frac{1}{v_{0}}\right]}\right) \rightarrow \mathrm{SL}_{2}\left(\widehat{\left.\mathcal{O}\left[\frac{1}{v_{0}}\right]\right)}=\prod_{v \neq v_{0}} \mathrm{SL}_{2}\left(\mathcal{O}_{v}\right)\right.$ as before, in order to see that the family $\left\{\mathbf{G}\left(\mathcal{O}_{v}\right)\right\}_{v \neq v_{0}}$ is boundedly presented. At last, the single remaining group $\mathrm{SL}_{2}\left(\mathcal{O}_{v_{0}}\right)$ does not cause any problem since it is analytic over $k_{v_{0}}$ and therefore finitely presented.

Let us now prove Theorem 3.2.
Proof of Theorem 3.2. The group $P$ is an extension of the Sylow $p_{v}$-subgroup $U$ of $\mathbf{G}\left(\mathbf{F}_{p_{v}^{a_{v}}}\right)$ by the first congruence subgroup $\operatorname{Ker}\left(\mathbf{G}\left(\mathcal{O}_{v}\right) \rightarrow \mathbf{G}\left(\mathbf{F}_{p_{v} a_{v}}\right)\right)$ of $\mathbf{G}\left(\mathcal{O}_{v}\right)$. This group, say $N$, is a uniform powerful group whose Frattini subgroup $\Phi(N)$ is equal to the second congruence subgroup of $\mathbf{G}\left(\mathcal{O}_{v}\right)$. In fact $N / \Phi(N)$ can be identified with $\operatorname{Lie}(\mathbf{G})\left(\mathbf{F}_{\left.p_{v}{ }^{a_{v}}\right)}\right.$ and $\mathbf{G}\left(\mathcal{O}_{v}\right) / N \cong \mathbf{G}\left(\mathbf{F}_{p_{v}^{a_{v}}}\right)$ acts on $N / \Phi(N)$ by the natural adjoint action of $\mathbf{G}\left(\mathbf{F}_{p_{v}^{a_{v}}}\right)$ on its Lie algebra $\operatorname{Lie}(\mathbf{G})\left(\mathbf{F}_{p_{v}}^{a_{v}}\right)$ [Wei84, Lemma 5.2]. It follows that $d(P)$ is equal to $d(P / \Phi(N))$ and $P / \Phi(N)$ is an extension of $\operatorname{Lie}(\mathbf{G})\left(\mathbf{F}_{p_{v}}^{a_{v}}\right)$ by $U$.

Now if $\widetilde{P}$ is the corresponding Sylow pro-p subgroup in the group $\left.\mathbf{G}\left(\mathbf{F}_{p_{v}}{ }_{v}[t]\right]\right)$ over the characteristic $p$ ring $\left.\mathbf{F}_{p_{v}^{a_{v}}}[t t]\right]$, then $\widetilde{P}$ is the split extension of $U$ with $\widetilde{N}$, where $\widetilde{N}$ is the first congruence subgroup there, i.e., $\widetilde{N}=\operatorname{Ker}\left(\mathbf{G}\left(\mathbf{F}_{p_{v}{ }_{v}}[[t]]\right) \rightarrow \mathbf{G}\left(\mathbf{F}_{p_{v}^{a_{v}}}\right)\right)$. Also there, the Frattini subgroup $\Phi(\widetilde{N})$ of $\widetilde{N}$ is the second congruence subgroup of $\mathbf{G}\left(\mathbf{F}_{p_{v}}[[t]]\right)$ and we have $d(\widetilde{P})=d(\widetilde{P} / \Phi(\widetilde{N}))$. In this situation $\widetilde{P} / \Phi(\widetilde{N})$ is also an extension of $\operatorname{Lie}(\mathbf{G})\left(\mathbf{F}_{p_{v} a_{v}}\right)$ by $U$ (via the adjoint action), but this time the extension splits.

We deduce therefore that

$$
d(P)=d(P / \Phi(N)) \leqslant d(\widetilde{P} / \Phi(\widetilde{N}))=d(\widetilde{P})
$$

In $\S 2$, using the Kac-Moody methods, we showed that $d(\widetilde{P})=a_{v}(l+1)$ for $l \geqslant 3$. But in fact, as was shown in [CR14, Corollary 2.5], this result is true for all $l$ as long as $p>2$ for $\mathbf{G}$ being $B_{l}, C_{l}$ or $F_{4}$ and $p>3$ for $\mathbf{G}=G_{2}$. Hence, $d(P) \leqslant a_{v}(l+1)$. On the other hand, as $P$ surjects onto $U$, we have $d(P) \geqslant d(U)=a_{v} l$.

Observe that $N$ is a powerful uniform group on $a_{v} \cdot \operatorname{dim}(\mathbf{G})$ generators and hence can be presented by $C^{\prime} a_{v}^{2} \operatorname{dim}(\mathbf{G})^{2}$ relations [DDMS, Theorem 4.35]. The group $U$ has a presentation with $a_{v} l$ generators and at most $C^{\prime \prime} a_{v}^{2} l^{2}$ relations. Indeed, $U$ is a Sylow $p$-subgroup of $\mathbf{G}\left(\mathbf{F}_{p_{v}{ }^{a}}\right)$. But the latter group is a special case of Kac-Moody group, namely a Chevalley group over a finite field. Thus in particular, $U=U_{+}$for this class of groups and so if $l \geqslant 3$, Proposition 2.4 holds for $U$ implying the desired estimate. If $l \leqslant 2$, then $U$ is a group on $l a_{v}$ generators and of order $p_{v}^{a_{v} m}$ with $m \leqslant 6$ by [GLS98, Theorem 3.3.1]. Now [LS94, Proposition 3.4.1] implies that $U$ has a presentation on those generators with at most $12 a_{v}^{2}$ relations. Thus for all $l$, $U$ has a presentation with $a_{v} l$ generators and at most $C^{\prime \prime} a_{v}^{2} l^{2}$ relations. Now we may use P. Hall's lemma to glue together the presentations of $N$ and $U$ to obtain a presentation of $P$. As a result we conclude that $P$ has a presentation with at most $a_{v}(l+1)$ generators and at most $C_{3} a_{v}^{2} l^{4}$ relations, as claimed.

The lower bound on the number of relations now follows from the Golod-Shafarevich inequality [LS94].

## 4 Characteristic 0: the global case

In this section, we prove Theorem 3.3. The proof follows the line of [Cap13] where Theorem 1.1 is proved. Some results from $K$-theory are needed along the way.

### 4.1 Definitions and facts from $K$-theory

In what follows, $\Phi$ is a reduced, irreducible root system and $R$ a commutative unit ring. We denote by $\operatorname{St}_{\Phi}(R)$ the Steinberg group of type $\Phi$ over $R$, which is a group defined by a presentation based on the root subgroups and commutator relation between them.

If $G_{\Phi}$ is the simply connected Chevalley group scheme of type $\Phi$, there is a natural group homomorphism $\operatorname{St}_{\Phi}(R) \rightarrow G_{\Phi}(R)$ whose image is precisely the subgroup $E_{\Phi}(R)$ generated by the root groups $U_{a}(R), a \in \Phi$, with respect to the standard maximal split torus. By the very definition of the low-degree $K$-groups of a root system and a ring, we have an exact sequence:

$$
(\dagger) \quad 1 \rightarrow \mathrm{~K}_{2}(\Phi, R) \rightarrow \operatorname{St}_{\Phi}(R) \rightarrow G_{\Phi}(R) \rightarrow \mathrm{K}_{1}(\Phi, R) \rightarrow 1,
$$

where (the image of) $\mathrm{K}_{2}(\Phi, R)$ is central in $\mathrm{St}_{\Phi}(R)$. Roughly speaking, $\mathrm{K}_{1}(\Phi, R)$ measures the failure for $G_{\Phi}(R)$ to be generated by its unipotent elements. When $\mathrm{K}_{1}(\Phi, R)$ is trivial, the group $\operatorname{St}_{\Phi}(R)$ is a central extension of the Chevalley group $G_{\Phi}(R)$.

In the proof below, an important argument is the fact that the Steinberg version of a celebrated theorem of Curtis and Tits holds over rings. This result was announced almost 40 years ago by R.K. Dennis and M.R. Stein [DS74, Th. B]. Our reference is D. Allcock's recent paper [All13] which contains a vast generalization of Curtis-Tits amalgamation theorem to Steinberg groups associated to some classes of Kac-Moody groups.
Theorem 4.1. Let $\Phi$ be a reduced irreducible root system of rank $l \geqslant 2$ with $\Pi=\left\{\alpha_{1}, \ldots, \alpha_{l}\right\}$ a system of simple roots in $\Phi$. For each pair of integers $\{i ; j\}$ with $1 \leqslant i, j \leqslant l$, denote by $\Phi_{i j}$ the subsystem of $\Phi$ spanned by $\alpha_{i}$ and $\alpha_{j}$. Let $R$ be a commutative ring with 1 , and define $\Sigma(\Phi, R)$ to be the group with generators $x_{\alpha}(t)$ for $\alpha \in \bigcup \Phi_{i j}$ and $t \in R$ subject to the relations:

1. $x_{\alpha}(s) x_{\alpha}(t)=x_{\alpha}(s+t), \alpha \in \bigcup \Phi_{i j}, s, t \in R$,
2. $\left[x_{\alpha}(s), x_{\beta}(t)\right]=\prod x_{a \alpha+b \beta}\left(N_{\alpha \beta a b} s^{a} t^{b}\right)$
for all $\alpha, \beta \in \Phi_{i j}$ for some $1 \leqslant i, j \leqslant l$ such that $\alpha+\beta \neq 0$, where the product and the integers $N_{\alpha \beta a b}$ are as in (R2) of [Ste71, 3.7]. Then $\Sigma(\Phi, R) \cong \operatorname{St}_{\Phi}(R)$.

### 4.2 Proof of Theorem 3.3

The proof of Theorem 3.3 is now as follows.
Step I: The groups $G_{\Phi}(\mathcal{O})$ are all arithmetic groups and hence are finitely presented [Rag68]. So in particular the groups $G_{\Phi}(\mathcal{O})$, for $\Phi$ of rank $l \leqslant 5$, are all presented by at most $C_{4}^{\prime}(k)$ generators and relations.

Step II: Recal that $\operatorname{Sym}(n)$ and $\operatorname{Alt}(n)$ have presentations with a bounded number of generators and relations independent of $n$ [GKKL07]. This was used (together with the fact that $\mathrm{SL}_{4}(\mathbf{Z})$ is finitely presented) in [GKKL11] to show that the groups $\mathrm{SL}_{n}(\mathbf{Z})$, for $n \geqslant 6$, are boundedly presented. The proof works word to word to show that $\operatorname{St}_{A_{l}}(\mathcal{O})$ are boundedly presented for $l \geqslant 6$.

Step III: We now show that every Dynkin diagram $\Phi$ of rank at least 6 can be covered by three subdiagrams $\Phi_{i}$ (for $i=1,2,3$ ) such that:

1. Each $\Phi_{i}$ has at most two connected components, and every connected component is either of type $A_{l}$ (for $l \geqslant 2$ ) or of rank at most 5,
2. Every two nodes of $\Phi$ belong to at least one of the $\Phi_{i}$ 's, and
3. Each intersection $\Phi_{i} \cap \Phi_{j}$ (for $i \neq j$ ) has at most two components, each either empty or of type $A_{l}($ for $l \geqslant 2), B_{3}$ or $C_{3}$.

Let us list explicitly $\Phi_{i}, i=1,2,3$, in each particular case:

- For $B_{l}, l \geqslant 6$, take $\Phi_{1}=A_{l-1}, \Phi_{2}=B_{3} \sqcup A_{l-4}$ and $\Phi_{3}=\varnothing$,
- For $C_{l}, l \geqslant 6$, take $\Phi_{1}=A_{l-1}, \Phi_{2}=C_{3} \sqcup A_{l-4}$ and $\Phi_{3}=\varnothing$,
- For $D_{l}, l \geqslant 6$, take $\Phi_{1}=A_{l-1}, \Phi_{2}=A_{l-1}$ (different from $\Phi_{1}$ ) and $\Phi_{3}=A_{3}$ (the one containing the "fork"),
- For $E_{l}, l \in\{6,7,8\}$, take $\Phi_{1}=A_{l-1}, \Phi_{2}=A_{4}$ (the one containing one of the end-nodes and the vertex missed by $\Phi_{1}$ ) and $\Phi_{3}=A_{l-2}$ (the one containing the other end-node and containing the vertex missed by $\Phi_{1}$ ).

Step IV: Given $\Phi=\bigcup_{i=1}^{3} \Phi_{i}$ as in the previous step, the Curtis-Tits Theorem guarantees that a presentation for $\operatorname{St}_{\Phi}(\mathcal{O})$ is obtained by taking the union of the presentation of $\mathrm{St}_{\Phi_{i}}(\mathcal{O})$ and gluing them along the intersections. As we have arranged that all the $\mathrm{St}_{\Phi_{i}}(\mathcal{O})$ as well as their intersections have bounded presentations, the same now applies to $\mathrm{St}_{\Phi}(\mathcal{O})$.

Step V: We now use the stability results to deduce that by adding a bounded number of relations to the presentation of $\operatorname{St}_{\Phi}(\mathcal{O})$, we obtain a bounded presentation for $G_{\Phi}(\mathcal{O})$ as promised, where the bound depends on $\mathcal{O}$ only.
First of all notice that by the results of Mennicke, Bass-Milnor-Serre and Matsumoto (cf. Theorem 7.4 of [Spl86]), the group $\mathrm{K}_{1}(\Phi, \mathcal{O})$ is trivial when $l \geqslant 2$, and therefore definitely in our case.

Thus in view of $(\dagger)$ and the result just obtained in Step IV, to finish our proof it remains to show that for all $\Phi$ of rank at least 6 , the corresponding family of groups $\left\{K_{2}(\Phi, \mathcal{O})\right\}_{\Phi}$ is boundedly generated.
To do that, let us recall the stability results of Dennis, Van der Kallen and Stein that are summarised in [Spl86, Theorem 7.5] and in the example following it. Applied to our situation they imply that for $l \geqslant 6$ and $\Phi_{l}=A_{l}, B_{l}, C_{l}$ or $D_{l}$, the maps

$$
K_{2}\left(\Phi_{6}, \mathcal{O}\right) \rightarrow K_{2}\left(\Phi_{l}, \mathcal{O}\right)
$$

are surjective as well as for $l=6,7,8$, are the maps

$$
K_{2}\left(A_{6}, \mathcal{O}\right) \rightarrow K_{2}\left(E_{l}, \mathcal{O}\right) .
$$

It follows that $K_{2}\left(\Phi_{l}, \mathcal{O}\right), l \geqslant 6$, is boundedly generated provided we can show that $K_{2}\left(\Phi_{6}, \mathcal{O}\right)$ are finitely generated. But this follows immediately as $\operatorname{St}_{\Phi_{6}}(\mathcal{O})$ is boundedly presented (as we showed in the previous step) while $G_{\Phi_{6}}(\mathcal{O})$ is finitely presented (as an arithmetic group): this implies that $K_{2}\left(\Phi_{6}, \mathcal{O}\right)$ is finitely generated as a normal subgroup; being central, it is also finitely generated as a group.

Remark 4.2. As pointed out above in Remark 3.4, the constant $C_{4}(k)$ in Theorem 3.3 does depend on $k$. In fact we observed there that there exist sequences of fields $k_{i}$ with $\left|k_{i}: \mathbf{Q}\right| \rightarrow \infty$ such that $C_{4}\left(k_{i}\right) \geqslant c_{0} \log \left|k_{i}: \mathbf{Q}\right|$ for some absolute constant $c_{0}$. One can carefully analyse the proof of Theorem 3.3 to deduce that $C_{4}(k) \leqslant C_{0}|k: \mathbf{Q}|^{2}$ (when $l \geqslant 6$ ).
