# PSEUDOFINITE $\widetilde{\mathfrak{M}}_{c}$-GROUPS

#### Abstract

A pseudofinite group satisfying the uniform chain condition on centralizers up to finite index has a big finite-by-abelian subgroup.


## Introduction

We generalize the results of Elwes, Jaligot, MacPherson and Ryten [1, 2, about pseudofinite superstable groups of small rank to the pseudofinite context, possibly of infinite rankl

## 1. Rank

Definition 1. A dimension on a theory $T$ is a function dim from the collection of all interpretable subsets of a monster model to $\mathbb{R}^{\geq 0} \cup\{\infty\}$ satisfying

- Invariance: If $a \equiv a^{\prime}$ then $\operatorname{dim}(\varphi(x, a))=\operatorname{dim}\left(\varphi\left(x, a^{\prime}\right)\right)$.
- Algebraicity: If $X$ is finite, then $\operatorname{dim}(X)=0$.
- Union: $\operatorname{dim}(X \cup Y)=\max \{\operatorname{dim}(X), \operatorname{dim}(Y)\}$.
- Fibration: If $f: X \rightarrow Y$ is a interpretable surjection whose fibres have constant dimension $r$, then $\operatorname{dim}(X)=\operatorname{dim}(Y)+r$.
For a partial type $\pi$ we put $\operatorname{dim}(\pi)=\inf \{\operatorname{dim}(\varphi): \pi \vdash \varphi\}$. We write $\operatorname{dim}(a / B)$ for $\operatorname{dim}(\operatorname{tp}(a / B))$.

It follows that $X \subseteq Y$ implies $\operatorname{dim}(X) \leq \operatorname{dim}(Y)$, and $\operatorname{dim}(X \times Y)=\operatorname{dim}(X)+$ $\operatorname{dim}(Y)$. Moreover, any partial type $\pi$ can be completed to a complete type $p$ with $\operatorname{dim}(\pi)=\operatorname{dim}(p)$.

Definition 2. A dimension is additive if it satisfies

- Additivity: $\operatorname{dim}(a, b / C)=\operatorname{dim}(a / b, C)+\operatorname{dim}(b / C)$.

Remark 3. Additivity is clearly equivalent to fibration for type-definable maps.

(1) coarse pseudofinite dimension (in the expansion by cardinality comparison quantifiers, in order to ensure invariance);
(2) Lascar rank, $S U$-rank or b-rank, possibly localised at some $\emptyset$-invariant family of types;
(3) for any ordinal $\alpha$, the coefficient of $\omega^{\alpha}$ in one of the ordinal-valued ranks in (2) above.

In any of the examples, we put $\operatorname{dim}(X)=\infty$ if $\operatorname{dim}(X)>n$ for all $n<\omega$.
Note that additivity in the above examples follows from the Lascar inequalities for the corresponding rank in examples (2) and (3) and from [3] in example (1).

Definition 4. Let $G$ be a type-definable group with an additive dimension, and suppose $0<\operatorname{dim}(G)<\infty$. A partial type $\pi(x)$ implying $x \in G$ is wide if $\operatorname{dim}(\pi)=$ $\operatorname{dim}(X)$. It is broad if $\operatorname{dim}(\pi)>0$. An element $g \in G$ is wide/broad over some parameters $A$ if $\operatorname{tp}(g / A)$ is. We say that $\pi$ is negligible if $\operatorname{dim}(\pi)=0$.

Lemma 5. An additive dimension is invariant under definable bijections.
Proof: Let $f$ be an $A$-definable bijection, and $a \in \operatorname{dom}(f)$. Then $\operatorname{dim}(f(a) / A, a)=0$ and $\operatorname{dim}(a / A, f(a))=0$, whence

$$
\operatorname{dim}(a / A)=\operatorname{dim}(a, f(a) / A)=\operatorname{dim}(f(a) / A)
$$

Definition 6. If $\operatorname{dim}(a / A)<\infty$, we say that $a \downarrow^{\mathrm{d}}{ }_{A} B$ if $\operatorname{dim}(a / A)=\operatorname{dim}(A B)$.
It follows that $\downarrow^{\mathrm{d}}$ satisfies transitivity. Moreover, for any partial type $\pi$ there is a comple type $p \supseteq \pi$ (over any set of parameters containing $\operatorname{dom}(\pi)$ ) with $\operatorname{dim}(p)=$ $\operatorname{dim}(\pi)$, so $\downarrow^{\text {d }}$ satisfies extension.

Lemma 7 (Symmetry). Let dim be an additive dimension. If $\operatorname{dim}(a / A)<\infty$ and $\operatorname{dim}(b / A)<\infty$, then $a \downarrow_{A}^{d} b$ if and only if $b \downarrow_{A}^{d} a$, if and only if $\operatorname{dim}(a, b / A)=$ $\operatorname{dim}(a / A)+\operatorname{dim}(b / A)$.

Proof: Obvious.
Lemma 8. Let $G$ be a type-definable group with an additive dimension, and suppose $0<\operatorname{dim}(G)<\infty$. If $g$ is wide over $A$ and $h$ is wide over $A, g$, then $g h$ and $h g$ are wide over $A, g$ and over $A, h$.

Proof: As dimension is invariant under definable bijections

$$
\operatorname{dim}(g h / A, g)=\operatorname{dim}(h / A, g)=\operatorname{dim}(G)
$$

The other statements follow similarly, possibly using symmetry.

## 2. Big AbELIAN SUBGROUPS

Proposition 9. Let $G$ be a pseudofinite group, and dim an additive dimension on $G$. Then there is an element $g \in G \backslash\{1\}$ such that $\operatorname{dim}\left(C_{G}(g)\right) \geq \frac{1}{3} \operatorname{dim}(G)$.

Proof: Suppose first that $G$ has no involution. If $G \equiv \prod_{I} G_{i} / \mathcal{U}$ for some family $\left(G_{i}\right)_{I}$ of finite groups and some non-principal ultrafilter $\mathcal{U}$, then $G_{i}$ has no involution for almost all $i \in I$, and is soluble by the Feit-Thompson theorem. So there is $g_{i} \in G_{i} \backslash\{1\}$ such that $\left\langle g_{i}^{G_{i}}\right\rangle$ is commutative. Put $g=\left[g_{i}\right]_{I} \in G \backslash\{1\}$. Then $\left\langle g^{G}\right\rangle$ is commutative and $g^{G} \subseteq C_{G}(g)$. As $g^{G}$ is in definable bijection with $G / C_{G}(g)$, we have

$$
\operatorname{dim}\left(C_{G}(g)\right) \geq \operatorname{dim}\left(g^{G}\right)=\operatorname{dim}\left(G / C_{G}(g)\right)=\operatorname{dim}(G)-\operatorname{dim}\left(C_{G}(g)\right)
$$

In particular $\operatorname{dim}\left(C_{G}(g)\right) \geq \frac{1}{2} \operatorname{dim}(G)$.
Now let $i \in G$ be an involution and suppose $\operatorname{dim}\left(C_{G}(i)\right)<\frac{1}{3} \operatorname{dim}(G)$. Then

$$
\operatorname{dim}\left(i^{G}\right)=\operatorname{dim}\left(G / C_{G}(i)\right)=\operatorname{dim}(G)-\operatorname{dim}\left(C_{G}(i)\right)>\frac{2}{3} \operatorname{dim}(G)
$$

and there is $j=i^{g} \in i^{G}$ with $\operatorname{dim}(j) \geq \frac{2}{3} \operatorname{dim}(G)$. Note that

$$
\operatorname{dim}\left(C_{G}(j)\right)=\operatorname{dim}\left(C_{G}(i)^{g}\right)=\operatorname{dim}\left(C_{G}(i)\right)<\frac{1}{3} \operatorname{dim}(G)
$$

Then

$$
\operatorname{dim}\left(j^{G} j\right)=\operatorname{dim}\left(G / C_{G}(j)\right)=\operatorname{dim}(G)-\operatorname{dim}\left(C_{G}(j)\right)>\frac{2}{3} \operatorname{dim}(G)
$$

and there is $h=j^{g^{\prime}} j \in j^{G} j$ with $\operatorname{dim}(h / j) \geq \frac{2}{3} \operatorname{dim}(G)$. Note that $h$ is inverted by $j$. By additivity,

$$
\operatorname{dim}(j / h)=\operatorname{dim}(j, h)-\operatorname{dim}(h) \geq \operatorname{dim}(h / j)+\operatorname{dim}(j)-\operatorname{dim}(G)>\frac{1}{3} \operatorname{dim}(G)
$$

If $H=\left\{x \in G: h^{x}=h^{ \pm 1}\right\}$, then $H$ is an $h$-definable subgroup of $G$, and $C_{G}(h)$ has index two in $H$. Since $j \in H$, we have

$$
\operatorname{dim}\left(C_{G}(h)\right)=\operatorname{dim}(H) \geq \operatorname{dim}(j / h)>\frac{1}{3} \operatorname{dim}(G)
$$

Theorem 10. Let $G$ be a pseudofinite $\widetilde{\mathfrak{M}}_{c}$-group, and $\operatorname{dim}$ an additive dimension on $G$. Then $G$ has a definable broad finite-by-abelian subgroup $Z$. More precisely, $Z=\tilde{Z}(C)$ where $C$ is a minimal broad centralizer (up to finite index) of a finite tuple.

Proof: By the $\widetilde{\mathfrak{M}}_{c}$ condition, there is a broad centralizer $C$ of some finite tuple, such that $\left.C_{C}(g)\right)$ is not broad for any $g \in C \backslash \tilde{Z}(C)$. Put $Z=\tilde{Z}(C)$, a definable finite-byabelian normal subgroup of $C$. If $Z$ is broad, we are done. Otherwise $\operatorname{dim}(Z)=0$, and

$$
\operatorname{dim}(C / Z)=\operatorname{dim}(C)-\operatorname{dim}(Z)=\operatorname{dim}(C)
$$

For $g \in C \backslash Z$ we have $\operatorname{dim}\left(C_{C}(g)\right)=0$, whence for $\bar{g}=g Z$ we have

$$
\begin{aligned}
\operatorname{dim}\left(\bar{g}^{C / Z}\right) & =\operatorname{dim}\left(g^{C} Z / Z\right) \geq \operatorname{dim}\left(g^{C}\right)-\operatorname{dim}(Z) \\
& =\operatorname{dim}(C)-\operatorname{dim}\left(C_{C}(g)\right)-\operatorname{dim}(Z)=\operatorname{dim}(C / Z)
\end{aligned}
$$

Hence for all $\bar{g} \in(C / Z) \backslash\{\overline{1}\}$ we have

$$
\operatorname{dim}\left(C_{C / Z}(\bar{g})\right)=\operatorname{dim}(C / Z)-\operatorname{dim}\left(\bar{g}^{C / Z}\right)=0
$$

As $C$ and $Z$ are definable, $C / Z$ is again pseudofinite, contradicting Proposition 9 ,
Theorem 10 holds in particular for any pseudofinite $\widetilde{\mathfrak{M}}_{c}$-group with the pseudofinite counting measure. Note that the broad finite-by-abelian subgroup is defined in the pure group, using centralizers and almost centres. Moreover, the $\widetilde{\mathfrak{M}}_{c}$-condition is just used in $G$, not in the section $C / Z$.

Corollary 11. A superrosy pseudofinite group with $U^{b}(G) \geq \omega^{\alpha}$ has a definable finite-by-abelian subgroup $A$ with $U^{p}(A) \geq \omega^{\alpha}$.

Proof: A superrosy group is $\widetilde{\mathfrak{M}}_{c}$. If $\alpha$ is minimal with $U^{\mathrm{p}}(G)<\omega^{\alpha+1}$ and we put

$$
\operatorname{dim}(X) \geq n \quad \text { if } \quad U^{\mathrm{p}}(X) \geq \omega^{\alpha} \cdot n
$$

then $\operatorname{dim}$ is an additive dimension with $0<\operatorname{dim}(G)<\infty$. The assertion now follows from Theorem 10.

Corollary 12. For any $d, d^{\prime}<\omega$ there is $n=n\left(d, d^{\prime}\right)$ such that if $G$ is a finite group without elements $\left(g_{i}: i \leq d^{\prime}\right)$ such that

$$
\left|C_{G}\left(g_{i}: i<j\right): C_{G}\left(g_{i}: i \leq j\right)\right| \geq d
$$

for all $j \leq d^{\prime}$, then $G$ has a subgroup $A$ with $\left|A^{\prime}\right| \leq n$ and $n|A|^{n} \geq|G|$.
Proof: If the assertion were false, then given $d, d^{\prime}$, there were a sequence ( $G_{i}: i<\omega$ ) of finite groups satisfying the condition, such that $G_{i}$ has no subgroup $A_{i}$ with $\left|A_{i}^{\prime}\right| \leq i$ and $i\left|A_{i}\right|^{i} \geq\left|G_{i}\right|$. But any non-principal ultraproduct $G=\prod G_{n} / \mathcal{U}$ is a pseudofinite $\widetilde{\mathfrak{M}}_{c}$-group, and has a definable subgroup $A$ with $A^{\prime}$ finite and $\operatorname{dim}(A) \geq \frac{1}{n} \operatorname{dim}(G)$ for some $n<\omega$. Unravelling the definition of the pseudofinite counting measure (and possibly increasing $n$ ) we get $\left|A_{i}^{\prime}\right| \leq n$ and $n \cdot\left|A_{i}\right|^{n} \geq\left|G_{i}\right|$ for almost all $i<\omega$, a contradiction for $i \geq n$.

## 3. Pseudofinite $\widetilde{\mathfrak{M}}_{c}$-GRoups of dimension 2

Theorem 13. Let $G$ be a pseudofinite $\widetilde{\mathfrak{M}}_{c}$-group, and $\operatorname{dim}$ an additive integer-valued dimension on $G$. If $\operatorname{dim}(G)=2$, then $G$ has a broad definable finite-by-abelian subgroup $N$ whose normalizer is wide.

Proof: Note that since dim is integer-valued, a broad subgroup has dimension at least 1. By Corollay 11, if $C$ is a minimal broad centralizer (up to finite index), then $A=\tilde{Z}(C)$ is broad and finite-by-abelian.
If $A$ is commensurate with $A^{g}$ for all $g \in G$, then commensurativity is uniform by compactness. So by Schlichting's Theorem there is a normal subgroup $N$ commensurate with $A$. But then $\tilde{Z}(N)$ contains $A \cap N$, has finite index in $N$ and is broad; since it is characteristic in $N$, it is normal in $G$ and we are done.
Suppose $g \in \tilde{N}_{G}(H)$ is such that $A$ is not commensurable with $A^{g}$. Then clearly $C$ cannot be commensurable with $C^{g}$, and

$$
\operatorname{dim}\left(A \cap A^{g}\right) \leq \operatorname{dim}\left(C \cap C^{g}\right)=0
$$

Hence
$\operatorname{dim}\left(A A^{g}\right) \geq \operatorname{dim}\left(A A^{g} /\left(A \cap A^{g}\right)\right)=\operatorname{dim}\left(A /\left(A \cap A^{g}\right)+\operatorname{dim}\left(A^{g} /\left(A \cap A^{g}\right)\right)=2 \operatorname{dim}(A)\right.$.
As $A$ is $\operatorname{broad}$ and $\operatorname{dim}(G)=2$, we have $\operatorname{dim}(A)=1$.
Choose some $d$-independent wide $a, b_{0}, c_{0}$ in $A$ over $g$. Then $\operatorname{dim}\left(a^{g} b_{0} / g, c_{0}\right)=2$, and

$$
2 \geq \operatorname{dim}\left(c_{0} a^{g} b_{0} / g\right) \geq \operatorname{dim}\left(c_{0} a^{g} b_{0} / g, c_{0}\right)=\operatorname{dim}\left(a^{g} b_{0} / g, c_{0}\right)=\operatorname{dim}\left(a^{g} b_{0} / g\right)=2
$$

and $c_{0} \downarrow_{g}^{\mathrm{d}} c_{0} a^{g} b_{0}$. Thus $c_{0}$ is wide in $A$ over $g, c_{0} a^{g} b c_{0}$. Similarly, $b_{0}$ is wide in $A$ over $g, c_{0} a^{g} b c_{0}$.
Choose $d, b_{1}, c_{1} \equiv_{c_{0} a^{g} b_{0}, g} a, b_{0}, c_{0}$ with $d, b_{1}, c_{1} \downarrow_{c_{0} a^{g} b_{0}, g}^{\mathrm{d}} a, b_{0}, c_{0}$. Then $c_{0} a^{g} b_{0}=c_{1} d^{g} b_{1}$, whence

$$
a^{g} b=c d^{g}
$$

where $c=c_{0}^{-1} c_{1}$ and $b=b_{0} b_{1}^{-1}$. Moreover,

$$
\operatorname{dim}(b / a, g) \geq \operatorname{dim}\left(b_{0} b_{1}^{-1} / a, b_{0}, c_{0}, g\right) \geq \operatorname{dim}\left(b_{1} / a, b_{0}, c_{0}, g\right)=\operatorname{dim}\left(b_{1} / c_{0} a^{g} b_{0}, g\right)=1
$$

so $b$ is wide in $A$ over $g, a$. Similarly, $c$ is wide in $A$ over $g, d$.
Let $x$ and $y$ be two d-independent wide elements of $C_{A}(a, b, c, d)$ over $a, b, c, d, g$. Then they are d-independent wide in $A$, and for $z=x g y$ we have

$$
\operatorname{dim}(z / a, b, c, d, g)=2
$$

so $z$ is wide in $G$ over $g, a, b, c, d$. Moreover

$$
a^{z} b=a^{x g y} b=a^{g y} b^{y}=\left(a^{g} b\right)^{y}=\left(c d^{g}\right)^{y}=c^{y} d^{g y}=c d^{x g y}=c d^{z}
$$

Choose $z^{\prime} \in G$ with $z^{\prime} \equiv_{a, b, c, d} z$ and $z^{\prime} \downarrow_{a, b, c, d}^{\mathrm{d}} z$, and put $r=z^{\prime-1} z$. Then $r$ is wide in $G$ over $g, a, b, c, d, z$, and

$$
a^{z} b^{r}=a^{z^{\prime} r} b^{r}=\left(a^{z^{\prime}} b\right)^{r}=\left(c d^{z^{\prime}}\right)^{r}=c^{r} d^{z^{\prime} r}=c^{r} d^{z}
$$

Hence

$$
c^{-1} a^{z} b=d^{z}=c^{-r} a^{z} b^{r}
$$

Putting $b^{\prime}=b b^{-r}$ and $c^{\prime}=c c^{-r}$, we obtain

$$
a^{z} b^{\prime}=c^{\prime} a^{z}
$$

where $a$ is wide in $A$. As $r \downarrow_{g, a, b, c, d}^{\mathrm{d}} z$ we have

$$
\operatorname{dim}\left(z / a, b^{\prime}, c^{\prime}\right) \geq \operatorname{dim}(z / a, b, c, d, r)=\operatorname{dim}(z / a, b, c, d)=2,
$$

and $z$ is wide in $G$ over $a, b^{\prime}, c^{\prime}$. If $z^{\prime \prime} \equiv_{a, b^{\prime}, c^{\prime}} z$ with $z^{\prime \prime} \downarrow_{a, b^{\prime}, c^{\prime}}^{\mathrm{d}} z$, then $a^{z^{\prime \prime}} b^{\prime}=c^{\prime} a^{z^{\prime \prime}}$, whence

$$
b^{\prime a^{z}}=c^{\prime}=b^{\prime a^{z^{\prime \prime}}}
$$

and $a^{z} a^{-z^{\prime \prime}}=a^{\prime z}$ commutes with $b^{\prime}$, where $a^{\prime}=a a^{-z^{\prime \prime} z^{-1}}$.
Claim. $\operatorname{dim}\left(b^{\prime}\right) \geq 1, \operatorname{dim}\left(a^{\prime} / b^{\prime}\right) \geq 1, \operatorname{dim}\left(z / a^{\prime}, b^{\prime}\right) \geq 2$ and $\operatorname{dim}\left(a^{\prime z} / b^{\prime}\right) \geq 1$.
Proof of Claim: If $\operatorname{dim}\left(b^{\prime} / b\right)=0$, then $\operatorname{dim}\left(r / b, b^{\prime}\right)=\operatorname{dim}(r / b)=2$. Choose $r^{\prime} \equiv_{b, b^{\prime}} r$ with $r^{\prime} \downarrow_{b, b^{\prime}}^{\mathrm{d}}$. So $b^{r}=b^{\prime-1} b=b^{r^{\prime}}$ and $r^{\prime} r^{-1} \in C_{G}(b)$. Since $r^{\prime} r^{-1}$ is wide in $G$ over $b$, so is $C_{G}(b)$, and it has finite index in $G$ by minimality. Thus $b \in \tilde{Z}(G)$ and $\operatorname{dim} \tilde{Z}(G) \geq 1$, so we can take $N=\tilde{Z}(G)$. Thus we may assume $\operatorname{dim}\left(b^{\prime}\right) \geq$ $\operatorname{dim}\left(b^{\prime} / b\right) \geq 1$.
Next, note that $z$ and $z^{\prime \prime} z^{-1}$ are wide and $d$-independent over $a, b^{\prime}, c^{\prime}$ by Lemma 8, An argument similar to the first paragraph yields $\operatorname{dim}\left(a^{\prime} / b^{\prime}\right) \geq \operatorname{dim}\left(a^{\prime} / a, b^{\prime}, z^{\prime \prime} z^{-1}\right) \geq 1$ and $\operatorname{dim}\left(a^{\prime z} / b^{\prime}\right) \geq 1$.
To finish, note that $\operatorname{dim}\left(C_{G}\left(b^{\prime}\right)\right) \geq \operatorname{dim}\left(a^{\prime z} / b^{\prime}\right) \geq 1$. If $\operatorname{dim}\left(C_{G}\left(b^{\prime}\right)\right)=2$, then $b^{\prime} \in \tilde{Z}(G)$ and $\operatorname{dim}(\tilde{Z}(G)) \geq \operatorname{dim}\left(b^{\prime}\right) \geq 1$, so we are done again. Otherwise $\operatorname{dim}\left(C_{G}\left(b^{\prime}\right)\right)=1$. By the $\widetilde{\mathfrak{M}}_{c}$-condition there is a broad centralizer $D \leq C_{G}\left(b^{\prime}\right)$ of some finite tuple, minimal up to finite index, and $\operatorname{dim}(D)=\operatorname{dim}\left(C_{G}\left(b^{\prime}\right)\right)=1$, whence $\operatorname{dim}\left(C_{G}\left(b^{\prime}\right) / D\right)=0$. Choose $z^{*} \in G$ with $z^{*} \equiv_{a^{\prime}, b^{\prime}} z$ and $z^{*} \downarrow_{a^{\prime}, b^{\prime}}^{\mathrm{d}} z$, and put $h=z^{*-1} z$. Then $a^{\prime z^{*}} \in C_{G}\left(b^{\prime}\right)$, so $a^{\prime z} \in C_{G}\left(b^{\prime}, b^{\prime h}\right)$. Moreover, $h$ is wide in $G$ over $a^{\prime}, b^{\prime}$ and $d$-independent of $z$, so

$$
\operatorname{dim}\left(C_{G}\left(b^{\prime}, b^{\prime h}\right)\right) \geq \operatorname{dim}\left(a^{\prime z} / b^{\prime}, h\right)=\operatorname{dim}\left(a^{\prime z} / b^{\prime}\right) \geq 1
$$

and $\operatorname{dim}\left(C_{G}\left(b^{\prime}\right) / C_{G}\left(b^{\prime}, b^{h}\right)\right)=0$. It follows that

$$
\begin{aligned}
\operatorname{dim}\left(D / D \cap D^{h}\right) & =\operatorname{dim}\left(D /\left(D \cap C_{G}\left(b^{\prime h}\right)\right)\right)+\operatorname{dim}\left(\left(D \cap C_{G}\left(b^{\prime h}\right)\right) /\left(D \cap D^{h}\right)\right) \\
& \leq \operatorname{dim}\left(C_{G}\left(b^{\prime}\right) / C_{G}\left(b^{\prime}, b^{\prime h}\right)\right)+\operatorname{dim}\left(C_{G}\left(b^{\prime h}\right) / D^{h}\right)=0
\end{aligned}
$$

whence $\operatorname{dim}\left(D \cap D^{h}\right)=1$, and $D^{h}$ is commensurable with $D$ by minimality. Thus

$$
\operatorname{dim}\left(\tilde{N}_{G}(D)\right) \geq \operatorname{dim}\left(h / b^{\prime}\right)=2
$$

and $\tilde{N}_{G}(D)$ is wide in $G$. Since $D$ is finite-by-abelian by Corollary 11, we finish as before, using Schlichting's Theorem.

Corollary 14. Let $G$ be a pseudofinite group whose definable sections are $\widetilde{\mathfrak{M}}_{c}$, and $\operatorname{dim}$ an additive integer-valued dimension on $G$. If $\operatorname{dim}(G)=2$, then $G$ has a definable wide soluble subgroup.

Proof: By Theorem [13, there is a definable finite-by-abelian group $N$ such that $N_{G}(N)$ is wide. Replacing $N$ by $C_{N}\left(N^{\prime}\right)$, we may assume that $N$ is (finite central)-by-abelian. If $\operatorname{dim}(N)=2$ we are done. Otherwise $\operatorname{dim}\left(N_{G}(N) / N\right)=1$; by Corollary 11 there is a definable finite-by-abelian subgroup $S / N$ with $\operatorname{dim}(S / N)=1$. As above we may assume that $S / N$ is (finite central)-by-abelian, so $S$ is soluble. Moreover,

$$
\operatorname{dim}(S)=\operatorname{dim}(N)+\operatorname{dim}(S / N)=1+1=2
$$

so $S$ is wide in $G$.
Corollary 15. A pseudofinite superrosy group $G$ with $\omega^{\alpha} \cdot 2 \leq U^{p}(G)<\omega^{\alpha} \cdot 3$ has a definable soluble subgroup $S$ with $U^{p}(S) \geq \omega^{\alpha} \cdot 2$.

Proof: Superrosiness implies that all definabel sections of $G$ are $\widetilde{\mathfrak{M}}_{c}$. We put

$$
\operatorname{dim}(X)=n \quad \Leftrightarrow \quad \omega^{\alpha} \cdot n \leq U^{\mathrm{p}}(X)<\omega^{\alpha} \cdot(n+1) .
$$

This defines an additive dimension with $\operatorname{dim}(G)=2$. The result now follows from Corollary 14.
