# Identification of the twisting function for the dynamic Schrödinger operator in a quantum waveguide

Abstract

## 1 Introduction

### 1.1 Statement and origin of the problem

The problem. Let $\omega$ be a bounded open subset of $\mathbb{R}^{2}$ with $\mathrm{C}^{2}$-boundary. Furthermore we assume that $\omega$ contains the origin of $\mathbb{R}^{2}$. Set $\Omega:=\omega \times \mathbb{R}$. For $x:=\left(x_{1}, x_{2}, x_{3}\right) \in \Omega$ we write $x:=\left(x_{\tau}, x_{3}\right)$ with $x_{\tau}:=\left(x_{1}, x_{2}\right)$. Put

$$
\nabla_{\tau}:=\left(\partial_{1}, \partial_{2}\right)^{T}, \Delta_{\tau}:=\partial_{1}^{2}+\partial_{2}^{2}, \partial_{\varphi}:=x_{1} \partial_{2}-x_{2} \partial_{1} .
$$

We assume that $\theta=\theta\left(x_{3}\right) \in C^{1}(\mathbb{R})$ and denote by $\dot{\theta}$ the derivative of $\theta$ wrt to $x_{3}$. Define $H_{\dot{\theta}}$ as the self-adjoint operator in $\mathrm{L}^{2}(\Omega)$

$$
\begin{equation*}
H_{\dot{\theta}}:=-\Delta_{\tau}-\left(\dot{\theta}\left(x_{3}\right) \partial_{\varphi}+\partial_{3}\right)^{2} . \tag{1.1}
\end{equation*}
$$

with Dirichlet boundary conditions on $\Gamma:=\partial \Omega$.
Given $T>0, q_{0} \in$ and $h \in$, we then consider the Schrödinger equation

$$
\begin{cases}-\imath q^{\prime}(t, x)+H_{\dot{\theta}} q(t, x)=0, & (t, x) \in(0, T) \times \Omega  \tag{1.2}\\ q(t, x)=h(t, x), & (t, x) \in(0, T) \times \Gamma \\ q(0, x)=q_{0}(x) & x \in \Omega,\end{cases}
$$

where the $q^{\prime}$ stands for $\frac{\partial q}{\partial t}$.
Twisted waveguide. Define the twisted domain

$$
\Omega_{\theta}:=\left\{r_{\theta}\left(x_{3}\right)(x), x \in \Omega\right\},
$$

where

$$
r_{\theta}=r_{\theta}\left(x_{3}\right):=\left(\begin{array}{ccc}
\cos \theta\left(x_{3}\right) & \sin \theta\left(x_{3}\right) & 0 \\
-\sin \theta\left(x_{3}\right) & \cos \theta\left(x_{3}\right) & 0 \\
0 & 0 & 1
\end{array}\right)
$$

and introduce the transform

$$
\left(\mathcal{U}_{\theta} \psi\right)(x):=\psi\left(r_{\theta}(x)\right), x \in \Omega, \psi \in \mathrm{~L}^{2}\left(\Omega_{\theta}\right)
$$

which is unitary from $\mathrm{L}^{2}\left(\Omega_{\theta}\right)$ onto $\mathrm{L}^{2}(\Omega)$. Then we have $H_{\dot{\theta}}=\mathcal{U}_{\theta}(-\Delta) \mathcal{U}_{\theta}^{*}$ where $\Delta$ denotes the Laplacian operator in $\mathrm{L}^{2}\left(\Omega_{\theta}\right)$. Moreover if $q$ is the solution to (1.2) then $u:=\mathcal{U}_{\theta}^{*} q$ obeys the system

$$
\begin{cases}-\imath u^{\prime}(t, x)-\Delta u(t, x)=0, & (t, x) \in(0, T) \times \Omega_{\theta} \\ u(t, x)=\left(\mathcal{U}_{\theta}^{*} h(t, .)\right)(x), & (t, x) \in(0, T) \times \partial \Omega_{\theta} \\ u(0, x)=\left(\mathcal{U}_{\theta}^{*} q_{0}\right)(x), & x \in \Omega_{\theta}\end{cases}
$$

Hence (1.2) describes, modulo a unitary transform, the quantum motion of a ${ }^{1}$ charged particle in the twisted waveguide $\Omega_{\theta}$.
In this paper we examine the inverse problem of determining the second derivative $\ddot{\theta}$ of the twisting function $\theta$ from some suitable localized, either interior or boundary, measurement of the solution $q$ to (1.2).

### 1.2 Main results

Set $I_{d}:=(-d, d)$ and $\Omega(d):=\omega \times I_{d}$ for all $d>0$. For $\ell>0$ and $\varepsilon>0$ we define the set of admissible twistings as

$$
\Theta_{\ell, \varepsilon}=\left\{\theta \in \mathrm{C}_{0}^{2}(\mathbb{R}), \dot{\theta} \in \mathrm{C}_{0}\left(I_{\ell}\right) \text { and }\|\dot{\theta}\|_{\mathrm{C}^{1}\left(I_{\ell}\right)} \leq \varepsilon\right\} .
$$

The first result establishes Lipschitz stability in the inverse problem of identifying $\ddot{\theta}$ from the measurement of $q$ and its time derivative $q^{\prime}$ in $\Omega_{0, L}:=\omega_{0} \times I_{L}$ for some $L>\ell$. This claim is valid for any arbitrarily small $\omega_{0}$ with positive $\mathbb{R}^{2}$-Lebesgue measure such that

$$
\begin{equation*}
(0,0) \notin \omega_{0} \tag{1.3}
\end{equation*}
$$

and

$$
\begin{equation*}
\partial \omega_{0} \cap \partial \omega=\emptyset . \tag{1.4}
\end{equation*}
$$

Theorem 1.1. Let $T>0, \ell>0$, $\omega$ and $\Omega$ be the same as in $\S 1.1$. Let $\omega_{0}$ fulfill (1.3)-(1.4) and pick $\tilde{q}_{0} \in \mathrm{H}^{2}(\Omega) \cap \mathrm{H}_{0}^{1}(\Omega)$ in such a way that

$$
\begin{equation*}
\exists \mathfrak{q}>0,\left|\partial_{\varphi} \tilde{q}_{0}(x)\right| \geq \mathfrak{q}, \text { a.e. } x \in \Omega_{0}:=\omega_{0} \times \mathbb{R} \tag{1.5}
\end{equation*}
$$

Let $q_{0} \in \mathrm{H}^{2}(\Omega) \cap \mathrm{H}_{0}^{1}(\Omega)$, let $\theta$ (resp. $\tilde{\theta}$ ) belong to $\Theta_{\varepsilon}$ and note $q$ (resp. $\tilde{q}$ ) the solution to (1.2) (resp. to (1.2) where $\tilde{\theta}$ and $\tilde{q}_{0}$ are substituted for $\theta$ and $q_{0}$ ). Then, for every $L>\ell$ there exists a constant $C>0$, depending only on $L, T, \ell, \varepsilon$ and $\omega_{0}$, such that

$$
\|\ddot{\theta}-\ddot{\ddot{\theta}}\|_{\mathrm{L}^{2}\left(I_{\ell}\right)}^{2} \leq C\left(\left\|q^{\prime}-\tilde{q}^{\prime}\right\|_{\mathrm{L}^{2}\left(0, T ; \mathrm{H}^{1}\left(\Omega_{0}(L)\right)\right)}^{2}+\left\|q_{0}-\tilde{q}_{0}\right\|_{\mathrm{H}^{2}\left(\Omega_{0}\right)}^{2}\right) .
$$

In contrast with Theorem 1.1 only boundary, instead of volume internal measurement of the solution are required for the following result to hold.

[^0]Theorem 1.2. Let $T>0, L>0, \omega$ and $\Omega$ be the same as in $\S 1.1$. Pick $\tilde{q}_{0} \in \mathrm{H}^{2}(\Omega)$ obeying (1.5) for some open subset $\omega_{0} \subsetneq \omega$ fulfilling $\left(C_{2}\right)$. Let $\theta_{\tilde{\tilde{O}}}$ (resp. $\tilde{\theta}$ ) belong to $\Theta_{\varepsilon}$ and note $q$ (resp. $\tilde{q}$ ) the solution to (1.2) (resp. to (1.2) where $\tilde{\theta}$ and $\tilde{q}_{0}$ are substituted for $\theta$ and $\left.q_{0}\right)$. Then there is a constant $C^{\prime}>0$, depending only on $T, L, \omega_{0}$ and $\ell$, such that

$$
\|\ddot{\theta}-\ddot{\tilde{\theta}}\|_{\mathrm{L}^{2}\left(I_{L}\right)}^{2} \leq C^{\prime}\left(\left\|\partial_{\nu}^{\left(g_{0}\right)}\left(q^{\prime}-\tilde{q}^{\prime}\right)\right\|_{\mathrm{L}^{2}\left(0, T ; \mathrm{L}^{2}\left(\Gamma_{0}\right)\right)}^{2}+\left\|q_{0}-\tilde{q}_{0}\right\|_{\mathrm{H}^{2}(\Omega)}^{2}\right) .
$$

### 1.3 Outline

The derivation of Theorems 1.1 and 1.2 is based on a global Carleman estimate for the operator $H_{\dot{\theta}}$. A Carleman inequality for the dynamic Schrödinger operator defined in a compact manifold $\mathcal{M} \subset \mathbb{R}^{n}, n \geq 2$, with smooth metric $g$, is established in Proposition 2.1 in $\S 2$. Its proof being quite lengthy it is postponed to Appendix A. The inverse problem of determining the twisting function (actually the second derivative of the twisting function) is addressed in $\S 3$, which contains the proofs of Theorems 1.1-1.2.

## 2 Carleman inequality for heterogeneous Schrödinger operators

Let $n \geq 2$ and $\mathcal{M}$ be a $n$-dimensional domain with smooth boundary $\partial \mathcal{M}$ and smooth metric $g$. This section is devoted to establishing a Carleman estimate for the dynamic Schrödinger operator

$$
\begin{equation*}
B:=\imath \partial_{t}+\Delta_{g} \tag{2.6}
\end{equation*}
$$

acting in $\mathrm{L}^{2}\left(\mathcal{M}_{T}\right)$ where $\mathcal{M}_{T}:=(-T, T) \times \mathcal{M}$. Here $\Delta_{g}$ denotes the Laplace-Beltrami operator associated to the smooth metric $g$. In local coordinates, it is given by

$$
\begin{equation*}
\Delta_{g}:=\frac{1}{\sqrt{\operatorname{det} g}} \sum_{j, k=1}^{n} \partial_{j}\left(\sqrt{\operatorname{det} g} g^{j k} \partial_{k}\right) \tag{2.7}
\end{equation*}
$$

where $g^{-1}:=\left(g^{j k}\right)_{1 \leq j, k \leq n}$ is the inverse of $g:=\left(g_{j k}\right)_{1 \leq j, k \leq n}$.
We notice from (1.1) that $H_{\dot{\theta}}$ coincides with $\Delta_{g}$ in the particular case where $n=3$ and

$$
g=\left(\begin{array}{ccc}
1+\dot{\theta}^{2} x_{2}^{2} & -\dot{\theta}^{2} x_{1} x_{2} & -\dot{\theta} x_{2}  \tag{2.8}\\
-\dot{\theta}^{2} x_{1} x_{2} & 1+\dot{\theta}^{2} x_{1}^{2} & \dot{\theta} x_{1} \\
-\dot{\theta} x_{2} & \dot{\theta} x_{1} & 1
\end{array}\right) .
$$

### 2.1 Notations

For each $x \in \mathcal{M}$ we define the inner product

$$
\begin{equation*}
g(X, Y)=\langle X, Y\rangle_{g}:=\sum_{j, k=1}^{n} g_{j, k}(x) \alpha_{j} \beta_{k}, X=\left(\alpha_{j}\right)_{1 \leq j \leq n}, Y=\left(\beta_{j}\right)_{1 \leq j \leq n} \in \mathbb{C}^{n} \tag{2.9}
\end{equation*}
$$

and the norm $|X|_{g}:=\langle X, \bar{X}\rangle_{g}{ }^{1 / 2}$.

### 2.2 Carleman estimate

Assume that there exists $\vartheta \in \mathrm{C}^{4}\left(\mathcal{M} ; \mathbb{R}_{+}^{*}\right)$ such that

$$
\begin{equation*}
\mathbb{D}^{2} \vartheta(\xi, \xi)(x)+\left|\left\langle\nabla_{g} \vartheta(x), \xi\right\rangle_{g}\right|^{2}>0, x \in \mathcal{M}, \xi \in \mathbb{R}^{n} \backslash\{0\}, \tag{2.10}
\end{equation*}
$$

where $\nabla_{g} \vartheta:=g^{-1} \nabla \vartheta$ and $\mathbb{D}^{2}$ is the Hessian of $\vartheta$ wrt the metric $g$, and suppose that $\vartheta$ has no critical points on $\mathcal{M}$,

$$
\begin{equation*}
\min _{x \in \bar{\Omega}}\left|\nabla_{g} \vartheta(x)\right|_{g}^{2}>0 . \tag{2.11}
\end{equation*}
$$

For further reference let us notice that:
(i) First, (2.10) may be rephrased into the following equivalent statement

$$
\begin{equation*}
\mathbb{D}^{2} \vartheta(\xi, \bar{\xi})(x)+\left|\left\langle\nabla_{g} \vartheta(x), \xi\right\rangle_{g}\right|^{2}>0, x \in \mathcal{M}, \xi \in \mathbb{C}^{n} \backslash\{0\}, \tag{2.12}
\end{equation*}
$$

since $\mathbb{D}^{2} \vartheta(\xi, \bar{\xi})=\mathbb{D}^{2} \vartheta\left(\xi_{R}, \xi_{R}\right)+\mathbb{D}^{2} \vartheta\left(\xi_{I}, \xi_{I}\right)$ where $\xi_{R}:=\operatorname{Re}(\xi)$ and $\xi_{I}:=\operatorname{Im}(\xi)$;
(ii) Second, (2.11) yields the existence of some constant $\beta>0$ satisfying

$$
\begin{equation*}
\min _{x \in \mathcal{M}}\left|\nabla_{g} \vartheta(x)\right|_{g}^{2} \geq \beta . \tag{2.13}
\end{equation*}
$$

Moreover we impose on $\vartheta$ the following condition

$$
\begin{equation*}
\vartheta(x) \geq \frac{2}{3} \sup _{x \in \mathcal{M}} \vartheta(x), x \in \mathcal{M}, \tag{2.14}
\end{equation*}
$$

which can be fulfilled by substituting $\vartheta+C$ for $\vartheta$, for any sufficiently large real number $C$.

Further define

$$
\begin{equation*}
\psi(t, x):=\frac{\mathrm{e}^{\gamma \vartheta(x)}}{(T-t)(T+t)}, \eta(t, x):=\frac{\mathrm{e}^{2 \gamma\|\vartheta\|_{\infty}}-\mathrm{e}^{\gamma \vartheta(x)}}{(T-t)(T+t)},(x, t) \in \mathcal{M}_{T}, \tag{2.15}
\end{equation*}
$$

and introduce $M:=\mathrm{e}^{-s \eta} B \mathrm{e}^{s \eta}=M_{1}+M_{2}$, where

$$
\begin{align*}
& M_{1}:=\imath \partial_{t}+\Delta_{g}+s^{2}\left|\nabla_{g} \eta\right|_{g}^{2}  \tag{2.16}\\
& M_{2}:=\imath s \partial_{t} \eta+2 s \nabla \eta \cdot \nabla_{g}+s\left(\Delta_{g} \eta\right) . \tag{2.17}
\end{align*}
$$

Next we consider a subboundary $\Gamma_{0} \subset \partial \mathcal{M}$ satisfying

$$
\begin{equation*}
\left\{x \in \Gamma,\left\langle\nabla_{g} \vartheta(x), \nu(x)\right\rangle_{g} \geq 0\right\} \subset \Gamma_{0}, \tag{2.18}
\end{equation*}
$$

where $\nu$ denotes the outward unit normal to $\partial \mathcal{M}$ wrt the metric $g$. Finally we define $\partial_{\nu} w:=\nabla_{g} w \cdot \nu$ on $\Sigma_{0}:=(-T, T) \times \Gamma_{0}$.

Proposition 2.1. Assume (2.10)-(2.11) and (2.18). Let $\psi, \eta$ be given by (2.15), and $M_{j}, j=1,2$, be defined by (2.16)-(2.17). Then there exist $s_{0}>0$ and $C_{0}=$ $C_{0}\left(\mathcal{M}, T,\|g\|_{\mathrm{C}^{2}(\mathcal{M})}\right)>0$ such that the following Carleman estimate

$$
\begin{aligned}
& I(w):=s\left\|\mathrm{e}^{-s \eta} \psi^{1 / 2} \nabla_{g} w\right\|_{\mathrm{L}^{2}\left(\mathcal{M}_{T}\right)^{n}}^{2}+s^{3}\left\|\mathrm{e}^{-s \eta} \psi^{3 / 2} w\right\|_{\mathrm{L}^{2}\left(\mathcal{M}_{T}\right)}^{2}+\sum_{j=1,2}\left\|M_{j} e^{-s \eta} w\right\|_{\mathrm{L}^{2}\left(\mathcal{M}_{T}\right)}^{2} \\
\leq & C_{0}\left(\left\|\mathrm{e}^{-s \eta} B w\right\|_{\mathrm{L}^{2}\left(\mathcal{M}_{T}\right)}^{2}+s\left\|\mathrm{e}^{-s \eta} \psi \partial_{\nu} w\right\|_{\mathrm{L}^{2}\left(\Sigma_{0}\right)}^{2}\right)
\end{aligned}
$$

holds true for every $s \geq s_{0}$ whenever $w \in \mathrm{~L}^{2}\left(-T, T ; \mathrm{H}_{0}^{1}(\mathcal{M})\right)$ and $B w \in \mathrm{~L}^{2}\left(\mathcal{M}_{T}\right)$.

### 2.3 Twisted waveguide

For $L \in(\ell,+\infty)$ fixed, set $r:=(\ell+L) / 2$ and let $\mathcal{M}$ be any smooth bounded open subset of $\Omega(L)$ containing $\Omega(r)$ :

$$
\Omega(\ell) \subset \Omega(r) \subset \mathcal{M} \subset \Omega(L)
$$

Pick $a=\left(a_{1}, a_{2}, a_{3}\right) \in \mathbb{R}^{3} \backslash \mathcal{M}$ such that

$$
\begin{equation*}
d_{3}=a_{3}-L>0 \tag{2.19}
\end{equation*}
$$

and put

$$
\begin{equation*}
\vartheta(x)=|x-a|^{2}, x \in \mathcal{M} . \tag{2.20}
\end{equation*}
$$

For further reference we notice from (2.15) and (2.19)-(2.20) that $\eta_{0}=\eta(0,$.$) fulfills$

$$
\begin{equation*}
\eta_{0}^{\prime}(x)=2 \frac{\left(a_{3}-x_{3}\right) \mathrm{e}^{|x-a|^{2}}}{T^{2}} \geq \frac{2 d_{3}}{T^{2}}, x \in \mathcal{M} \tag{2.21}
\end{equation*}
$$

Moreover, in the framework of Theorem 1.2 we shall impose in addition to (2.19) that $a_{\tau}=\left(a_{1}, a_{2}\right) \in \mathbb{R}^{2} \backslash \bar{\omega}$ be taken far enough from $\omega$ in such a way that

$$
\begin{equation*}
d_{\tau}=\operatorname{dist}\left(a_{\tau}, \omega\right)=\inf _{x_{\tau} \in \omega}\left|x_{\tau}-a_{\tau}\right| \tag{2.22}
\end{equation*}
$$

is so large relative to $L$ and $d_{3}$ that

$$
\begin{equation*}
\omega \cap B\left(a_{\tau}, d_{\tau}+\frac{4 L\left(L+d_{3}\right)}{d_{\tau}}\right) \subsetneq \omega . \tag{2.23}
\end{equation*}
$$

By [1][Lemma 4.1] we have $4 \mathbb{D}^{2} \vartheta\left(g^{-1} \xi, g^{-1} \xi\right)=\{\mathfrak{g},\{\mathfrak{g}, \vartheta\}\}(x, \xi)$, where $\mathfrak{g}(x, \xi):=$ $\sum_{j, k=1}^{n} g^{j, k}(x) \xi_{j} \xi_{j}$ for $x \in \mathcal{M}$ and $\xi \in \mathbb{R}^{n}$. This, combined with (2.8) and the fact that $g^{j k}=\delta_{j k}+\dot{\theta}\left(x_{3}\right) b^{j k}, 1 \leq j, k \leq 3$, yields

$$
\mathbb{D}^{2} \vartheta\left(g^{-1} \xi, g^{-1} \xi\right)=\operatorname{Hess}(\vartheta)(\xi, \xi)+\mathcal{O}\left(\|\dot{\theta}\|_{\mathrm{C}^{1}\left(I_{L}\right)}|\xi|^{2}\right),
$$

where $\operatorname{Hess}(\vartheta)$ denotes the Hessian of $\vartheta$ wrt the Euclidian metric. Therefore we have

$$
\mathbb{D}^{2} \vartheta\left(g^{-1} \xi, g^{-1} \xi\right)=2|\xi|^{2}+\mathcal{O}\left(\|\dot{\theta}\|_{\mathrm{C}^{1}\left(I_{\ell}\right)}|\xi|^{2}\right), \xi \in \mathbb{R}^{n}
$$

by an elementary calculation, whence $\mathbb{D}^{2} \vartheta(\xi, \xi) \geq C|\xi|^{2}$ for all $\xi \in \mathbb{R}^{n}$ and some constant $C>0$, upon taking $\|\dot{\theta}\|_{\mathrm{C}^{1}\left(I_{\ell}\right)}$ sufficiently small. Namely, there exists $\varepsilon>0$, depending only on $\omega, \ell$ and $a$ such that (2.10) holds true for every $\theta \in \Theta_{\ell, \varepsilon}$.

## 3 Inverse problem

In this section we investigate the inverse problem of identifying $\ddot{\theta}$ from partial knowledge of the solution $q$ to (1.2). We shall prove that $\ddot{\theta}$ can be determined uniquely and stably from some suitable localized, either interior or boundary, measurement of $q$, as stated in Theorem 1.1 and Theorem 1.2. In both cases the method used in the derivation of the corresponding stability estimate preliminarily requires that the problem under study be centered around $t=0$, then appropriately "linearized" and differentiated w.r.t. the time variable $t$.

### 3.1 Time symmetrization and the linearized problem

Time symmetrization. Following the idea of [2] we extend (1.2) to negative values of the time variable $t$ in order to center the problem around $t=0$. Indeed, for any real valued initial data $q_{0}$, the solution $q$ to (1.2) extended to $Q:=(-T, T) \times \Omega$ by setting

$$
\begin{equation*}
q(t, x):=\overline{q(-t, x)} \text { for a.e. }(t, x) \in \mathbb{R}_{-}^{*} \times \Omega \text {, } \tag{3.24}
\end{equation*}
$$

is easily seen to be solution to the system

$$
\begin{cases}-\imath q^{\prime}(t, x)+H_{\dot{\theta}} q(t, x)=0, & (t, x) \in Q  \tag{3.25}\\ q(t, x)=h(t, x), & (t, x) \in \Sigma:=(-T, T) \times \Gamma \\ q(0, x)=q_{0}(x), & x \in \Omega,\end{cases}
$$

provided we have preliminarily set

$$
h(t, x):=\overline{h(-t, x)} \text { for a.e. }(t, x) \in \mathbb{R}_{-}^{*} \times \Gamma .
$$

The "linearized" problem. Let $\tilde{q}$ denote the solution to (3.25) where $\theta$ and $q_{0}$ are replaced by $\tilde{\theta}$ and $\tilde{q}_{0}$, a straightforward computation shows that $y:=q-\tilde{q}$ satisfies the "linearized" system

$$

The next step of the proof involves splitting $\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}(\Omega(\ell))}^{2}$ into the sum $\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega_{0}(\ell)\right)}^{2}+$ $\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega(\ell) \backslash \Omega_{0}(\ell)\right)}^{2}$, where the subset $\Omega_{0}(\ell)=\omega_{0} \times I_{\ell}$ is chosen in accordance with the following statement.

Lemma 3.3. Assume (2.22)-(2.23). Then there exist two proper open subsets of $\omega$, $\omega_{1} \subsetneq \omega_{0}$, with positive $\mathbb{R}^{2}$-Lebesgue measure, satisfying:

m_{1}=\sup _{x \in \Omega_{1}(\ell)} \eta_{0}(x)<m_{0}=\inf _{x \in \Omega(\ell) \backslash \Omega_{0}(\ell)} \eta_{0}(x) .

Proof. For $\epsilon=2 L\left(L+d_{3}\right) / d_{\tau}$, where $d_{\tau}$ is the same as in (2.22), we put

\end{equation*}

Further, as $\left|x_{\tau}-a_{\tau}\right|^{2}+d_{3}^{2} \leq \vartheta(x) \leq\left|x_{\tau}-a_{\tau}\right|^{2}+\left(2 L+d_{3}\right)^{2}$ for all $x=\left(x_{\tau}, x_{3}\right) \in \Omega(\ell)$, by (2.19)-(2.20), it follows from (3.44) that

\vartheta(x) \geq \vartheta\left(x^{\prime}\right)+R\left(x_{\tau}^{\prime}\right), x \in \Omega_{1}(\ell), x^{\prime}=\left(x_{\tau}^{\prime}, x_{3}^{\prime}\right) \in \Omega(\ell) \backslash \Omega_{0}(\ell), \tag{3.45}
\end{equation*}
$$

where $R\left(x_{\tau}^{\prime}\right)=2 \epsilon\left(\left|x_{\tau}^{\prime}-a_{\tau}\right|-d_{\tau}\right)+\epsilon^{2}$. Since $\left|x_{\tau}^{\prime}-a_{\tau}\right| \geq d_{\tau}$ from (2.22), then $R\left(x_{\tau}^{\prime}\right) \geq \epsilon^{2}$ and

\vartheta(x) \geq \vartheta\left(x^{\prime}\right)+\epsilon^{2}, x \in \Omega_{1}(\ell), x^{\prime} \in \Omega(\ell) \backslash \Omega_{0}(\ell)
$$

This entails $\inf _{x \in \Omega_{1}(\ell)} \vartheta(x)>\sup _{x \in \Omega(\ell) \backslash \Omega_{0}(\ell)} \vartheta(x)$, hence the result by (2.15).
Since $\left\|\mathrm{e}^{-s \eta_{0}} \partial_{\varphi} \tilde{q}_{0} \dot{\alpha}\right\|_{\mathrm{L}^{2}(\Omega(\ell))} \geq \mathfrak{q}\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega_{0}(\ell)\right)}$ by (1.5), we deduce from (3.43) that

\left(\mathfrak{q}-C_{4}^{\prime} \mathrm{s}^{-3 / 2}\right)\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega_{0}(\ell)\right)}^{2} \leq C_{4}^{\prime}\left(\mathrm{obs}+s^{-3 / 2}\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega \backslash \Omega_{0}(\ell)\right)}^{2}\right) .
$$

Therefore we have

\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega_{1}(\ell)\right)}^{2} \leq C_{5}^{\prime}\left(\mathrm{obs}+s^{-3 / 2}\left\|\mathrm{e}^{-s \eta_{0}} \dot{\alpha}\right\|_{\mathrm{L}^{2}\left(\Omega(\ell) \backslash \Omega_{0}(\ell)\right)}^{2}\right), \tag{3.46}
\end{equation*}
$$

for some $C_{5}^{\prime}=C_{5}^{\prime}()>0$ and all $s$ large enough. Here $\Omega_{1}(\ell)$ is the same as in Lemma 3.3 so (3.46) yields

\begin{equation*}
\mathrm{e}^{-s m_{1}}\left(\operatorname{mes}\left(\omega_{1}\right)-s^{-3 / 2} \mathrm{e}^{-s\left(m_{0}-m_{1}\right)} \operatorname{mes}(\omega)\right)\|\dot{\alpha}\|_{\mathrm{L}^{2}\left(I_{\ell}\right)}^{2} \leq C_{5}^{\prime} \text { obs, } \tag{3.47}
\end{equation*}
$$

under the above prescribed conditions on $s$. Finally, by recalling (3.42) and noticing that

\text { obs } \leq C_{6}^{\prime}\left(\left\|\partial_{\nu} z\right\|_{\mathrm{L}^{2}\left(\Sigma_{0}(r)\right)}^{2}+\|z\|_{\mathrm{L}^{2}\left(-T, T ; \mathrm{H}^{1}(\Omega(\ell, r))\right)}+\|y(0, .)\|_{\mathrm{H}^{2}(\Omega(r))}^{2}\right),
$$

where $C_{6}^{\prime}=C_{6}^{\prime}()>0$, the desired result follows directly from this, (3.47) and Lemma 3.3 upon taking $s$ sufficiently large.

For $X$ and $f$ in $\mathrm{H}^{1}(\mathcal{M})$ we have the following Green formula

\int_{\mathcal{M}} \operatorname{div}_{g}(X) f \mathrm{dv}_{g}=-\int_{\mathcal{M}}\left\langle X, \nabla_{g} f\right\rangle_{g} \mathrm{dv}_{g}+\int_{\partial \mathcal{M}} X \cdot \nu f \mathrm{~d} \omega_{g}, \tag{4.49}
\end{equation*}
$$

which yields

\int_{\mathcal{M}}\left(\Delta_{g} w\right) f \mathrm{dv}_{g}=-\int_{\mathcal{M}}\left\langle\nabla_{g} w, \nabla_{g} f\right\rangle_{g} \mathrm{dv}_{g}+\int_{\partial \mathcal{M}}\left(\partial_{\nu} w\right) f \mathrm{~d} \omega_{g}, \tag{4.50}
\end{equation*}
$$

whenever $f \in \mathrm{H}^{1}(\mathcal{M})$ and $w \in \mathrm{H}^{2}(\mathcal{M})$.

### 4.2 Completion of the proof

In light of (2.16)-(2.17) we shall first compute each term in the rhs of the following identity

& =-s \operatorname{Re}\left(\int_{\mathcal{M}_{T}} w\left(\eta^{\prime \prime} \bar{w}+\eta^{\prime} \overline{w^{\prime}}\right) \mathrm{dv}_{g} \mathrm{~d} t\right)=-s \operatorname{Re}\left(\int_{\mathcal{M}_{T}} \eta^{\prime \prime}|w|^{2} \mathrm{~d} v_{g} \mathrm{~d} t\right)-I_{1,1},
\end{aligned}
$$

where we used the fact that $w( \pm T)=0$. Hence

I_{1,2} & :=2 s \operatorname{Re}\left(\int_{\mathcal{M}_{T}} \imath\left\langle\nabla_{g} \eta, \nabla_{g} \bar{w}\right\rangle_{g} w^{\prime} \mathrm{dv}_{g} \mathrm{~d} t\right)=-2 s \operatorname{Im}\left(\int_{\mathcal{M}_{T}}\left\langle\nabla_{g} \eta, \nabla_{g} \bar{w}\right\rangle_{g} w^{\prime} \mathrm{d} v_{g} \mathrm{~d} t\right) \\
& =2 s \operatorname{Im}\left(\int_{\mathcal{M}_{T}}\left(\left\langle\nabla_{g} \eta^{\prime}, \nabla_{g} \bar{w}\right\rangle_{g}+\left\langle\nabla_{g} \eta, \nabla_{g} \overline{w^{\prime}}\right\rangle_{g}\right) w \mathrm{dv}_{g} \mathrm{~d} t\right), \tag{4.53}
\end{align*}
$$

with, in addition,
$\int_{\mathcal{M}}\left\langle\nabla_{g} \eta, \nabla_{g} \overline{w^{\prime}}\right\rangle_{g} w \operatorname{dv}_{g}=-\int_{\mathcal{M}} \operatorname{div}_{g}\left(\left(\nabla_{g} \eta\right) w\right) \overline{w^{\prime}} \mathrm{dv}_{g}=-\int_{\mathcal{M}}\left(\left(\Delta_{g} \eta\right) w+\overline{\left.\left\langle\nabla_{g} \eta, \nabla_{g} \bar{w}\right\rangle_{g}\right) w^{\prime}} \operatorname{dv}_{g}\right.$, by taking into account that $w^{\prime}$ vanishes on $\partial \mathcal{M}$. Therefore, it follows from this and (4.53) that

from where we get that

I_{1,2}=s \gamma \operatorname{Im}\left(\int_{\mathcal{M}_{T}}\left(\psi\left(\Delta_{g} \vartheta+\gamma\left|\nabla_{g} \vartheta\right|_{g}^{2}\right) \overline{w^{\prime}}-\psi^{\prime}\left\langle\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right\rangle_{g}\right) w \mathrm{dv}_{g} \mathrm{~d} t\right) . \tag{4.54}
\end{equation*}
$$

Further we have

I_{1,3}:=s \operatorname{Re}\left(\int_{\mathcal{M}_{T}} \imath w^{\prime}\left(\Delta_{g} \eta\right) \bar{w} \mathrm{dv}_{g} \mathrm{~d} t\right)=-s \gamma \operatorname{Im}\left(\int_{\mathcal{M}_{T}} \psi\left(\Delta_{g} \vartheta+\gamma\left|\nabla_{g} \vartheta\right|_{g}^{2}\right) w \overline{w^{\prime}} \mathrm{dv}{ }_{g} \mathrm{~d} t\right), \tag{4.55}
\end{equation*}
$$

and $I_{2,1}:=\operatorname{Re}\left(\int_{\mathcal{M}_{T}}\left(\Delta_{g} w\right)\left(-\imath s \eta^{\prime} \bar{w}\right) \mathrm{dv}_{g} \mathrm{~d} t\right)=s \operatorname{Im}\left(\int_{\mathcal{M}_{T}}\left(\Delta_{g} w\right) \eta^{\prime} \bar{w} \mathrm{~d} v_{g} \mathrm{~d} t\right)$, where

\int_{\mathcal{M}}\left(\Delta_{g} w\right) \eta^{\prime} \bar{w} \mathrm{dv}_{g}=-\int_{\mathcal{M}} \overline{\left\langle\nabla_{g} \eta^{\prime}, \nabla_{g} \bar{w}\right\rangle_{g} w} \mathrm{dv}_{g}-\int_{\mathcal{M}} \eta^{\prime}\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g} \mathrm{dv}_{g},
$$

since $w=0$ on $\partial \mathcal{M}$, so we find that

= & -\gamma \psi\left\langle\nabla_{g} w, \nabla_{g}\left\langle\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right\rangle_{g}\right\rangle_{g}-\gamma^{2} \psi\left|\left\langle\nabla_{g} \vartheta, \nabla_{g} w\right\rangle_{g}\right|^{2} . \tag{4.60}
\end{align*}

Further, as $\left\langle\nabla_{g} w, \nabla_{g}\left\langle\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right\rangle_{g}\right\rangle_{g}=\nabla_{g} w\left(\left\langle\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right\rangle_{g}\right)$, we have

= & \mathbb{D}^{2} \vartheta\left(\nabla_{g} w, \nabla_{g} \bar{w}\right)+\mathbb{D}^{2} \bar{w}\left(\nabla_{g} w, \nabla_{g} \vartheta\right),
\end{aligned}
$$

so (4.58)-(4.60) yields

& +2 s \gamma^{2} \int_{\mathcal{M}_{T}} \psi\left|\left\langle\nabla_{g} \vartheta, \nabla_{g} w\right\rangle_{g}\right|^{2} \mathrm{dv}_{g} \mathrm{~d} t-2 s \gamma \int_{\partial \mathcal{M}_{T}} \psi(\nabla \vartheta \cdot \nu)\left|\partial_{\nu} w\right|^{2} \mathrm{~d} \omega_{g} \mathrm{~d} t .(4.61)
\end{aligned}
$$

The next step involves noticing that $\left\langle\nabla_{g} \eta, \nabla_{g}\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g}\right\rangle_{g}=\nabla_{g} \eta\left(\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g}\right)$ is equal to $\left\langle\mathbb{D}_{\nabla_{g} \eta} \nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g}+\left\langle\nabla_{g} w, \mathbb{D}_{\nabla_{g} \eta} \nabla_{g} \bar{w}\right\rangle_{g}$, in such a way that we have

& \left\langle\nabla_{g} \eta, \nabla_{g}\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g}\right\rangle_{g}=\mathbb{D}^{2} w\left(\nabla_{g} \eta, \nabla_{g} \bar{w}\right)+\mathbb{D}^{2} \bar{w}\left(\nabla_{g} \eta, \nabla_{g} w\right) \\
= & -\gamma \psi\left(\mathbb{D}^{2} w\left(\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right)+\mathbb{D}^{2} \bar{w}\left(\nabla_{g} \vartheta, \nabla_{g} w\right)\right)=-2 \gamma \psi \operatorname{Re}\left(\mathbb{D}^{2} \bar{w}\left(\nabla_{g} \vartheta, \nabla_{g} w\right)\right),
\end{aligned}
$$

and consequently

= & -\int_{\mathcal{M}}\left(\Delta_{g} \eta\right)\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g} \mathrm{dv}_{g}+\int_{\partial \mathcal{M}}(\nabla \eta \cdot \nu)\left|\partial_{\nu} \omega\right|^{2} \mathrm{~d} \omega_{g} \\
= & -\gamma \int_{\mathcal{M}} \psi\left(\Delta_{g} \vartheta+\gamma\left|\nabla_{g} \vartheta\right|_{g}^{2}\right)\left\langle\nabla_{g} w, \nabla_{g} \bar{w}\right\rangle_{g} \mathrm{dv}_{g}+\gamma \int_{\partial \mathcal{M}} \psi(\nabla \vartheta \cdot \nu)\left|\partial_{\nu} \omega\right|^{2} \mathrm{~d} \omega_{g},
\end{aligned}
$$

by recalling that $\nabla_{g} w \cdot \tau=0$ on $\partial \mathcal{M}$. From this and (4.61) then follows that

& +2 s \gamma^{2} \int_{\mathcal{M}_{T}} \psi\left|\left\langle\nabla_{g} \vartheta, \nabla_{g} w\right\rangle_{g}\right|^{2} \mathrm{dv}_{g} \mathrm{~d} t-s \gamma \int_{\partial \mathcal{M}_{T}} \psi(\nabla \vartheta \cdot \nu)\left|\partial_{\nu} w\right|^{2} \mathrm{~d} \omega_{g} \mathrm{~d} t \tag{4.62}

The strategy now is to re-express each of the two last terms in the rhs of (4.63). To do that we substitute $\left.\left.(1 / 2)\left\langle\nabla_{g} \vartheta, \nabla_{g}\right| w\right|^{2}\right\rangle_{g}$ for $\operatorname{Re}\left(\left\langle\nabla_{g} \vartheta, \nabla_{g} \bar{w}\right\rangle_{g} w\right)$ in the last integral and apply (4.49), getting

by Young inequality and

for some constant $C=C(T)>0$, depending only on $T$, by (2.14), we deduce from (4.71) that

+ & s \gamma \int_{\mathcal{M}_{T}} \psi \mathbb{D}^{2} \vartheta\left(\nabla_{g} w, \nabla_{g} \bar{w}\right) \mathrm{dv}_{g} \mathrm{~d} t+s^{3} \gamma^{4} \int_{\mathcal{M}_{T}} \psi^{3}|w|^{2} \mathrm{dv}_{g} \mathrm{~d} t \\
\leq & C\left(\int_{\mathcal{M}_{T}}|M w|^{2} \mathrm{dv}_{g} \mathrm{~d} t+2 s \gamma \int_{\partial \mathcal{M}_{T}} \psi(\nabla \vartheta \cdot \nu)\left|\partial_{\nu} w\right|^{2} \mathrm{~d} \omega_{g} \mathrm{~d} t\right. \\
+ & \left.s \gamma \int_{\mathcal{M}_{T}}\left|\left\langle\nabla_{g} \vartheta, \nabla_{g} w\right\rangle_{g}\right|_{g}^{2} \mathrm{dv}_{g} \mathrm{~d} t+s^{3} \gamma^{3} \int_{\mathcal{M}_{T}} \psi^{3}|w|^{2} \mathrm{dv}_{g} \mathrm{~d} t+s \gamma^{4} \int_{\mathcal{M}_{T}} \psi|w|^{2} \mathrm{dv}_{g} \mathrm{~d} t\right),

for every $s \geq 1$ and $\gamma \geq 1$, the constant $C=C(T, \beta)$ depending only on $T$ and $\beta$. This easily entails

+ & s \gamma \int_{\mathcal{M}_{T}} \psi \mathbb{D}^{2} \vartheta\left(\nabla_{g} w, \nabla_{g} \bar{w}\right) \mathrm{dv}_{g} \mathrm{~d} t+s^{3} \gamma^{4} \int_{\mathcal{M}_{T}} \psi^{3}|w|^{2} \mathrm{dv}_{g} \mathrm{~d} t \\
\leq & C\left(\int_{\mathcal{M}_{T}}|M w|^{2} \mathrm{dv}_{g} \mathrm{~d} t+s \gamma \int_{\partial \mathcal{M}_{T}} \psi(\nabla \vartheta \cdot \nu)\left|\partial_{\nu} w\right|^{2} \mathrm{~d} \omega_{g} \mathrm{~d} t\right),
\end{aligned}
$$

upon taking $s$ and $\gamma$ sufficiently large, so the desired result follows immediately from this, (2.12) and (2.18).
