Straight rod with different order of thickness

Abstract

In this paper, we consider rods whose thickness vary linearly between ϵ and ϵ^2 . Our aim is to study the asymptotic behavior of these rods in the framework of the linear elasticity. We use a decomposition method of the displacement fields of the form $u = U_e + \bar{u}$, where U_e stands for the translation-rotations of the cross-sections and \bar{u} is related to their deformations. We establish a priori estimates. Passing to the limit in a fixed domain gives the problems satisfied by the bending, the stretching and the torsion limit fields which are ordinary differential equations depending on weights.

1. Introduction

In this paper we are interested in analyzing the asymptotic behavior of a thin rod with different order of thickness in the framework of the linear elasticity. We consider a straight rod of fixed length where the cross-sections are bounded Lipschitz domains with small diameter of order varying between ϵ and ϵ^2 . To be more precise, the order of the thickness of the rod is given by $\epsilon \rho_{\epsilon}(\cdot)$ where $\rho_{\epsilon}(\cdot)$ is a linear function depending on the cross-section of the rod such that it is 1 at the bottom and ϵ at the top of the rod. We investigate how the variable thickness of the rod affects to the a priori estimates and the limit problems.

Since the diameter of the rod tends to zero, this work belongs to the field of elliptic problems posed on thin domains. Many fields of science involve the study of thin domains, for example in solid mechanics (thin rods, plates, shells), fluid dynamics (lubrication, meteorology problems, ocean dynamics), physiology (blood circulation), etc. There are many papers dedicated to the study of the thin structures from the point of view of the elasticity, see e.g. [22, 21] for models of rods and [3, 4] for plates and shells.

Our work is based on the decomposition of a displacement of the rod according to [19]. Every displacement of the rod is the sum of an elementary displacement, it characterizes the translation and the rotation of the cross-sections, and a warping which is the residual displacement related to the deformation of the cross-section. This decomposition of the rod was introduced in [15] and [16] and it allows to obtain the Korn inequality as well as the asymptotic behavior of the strain tensor of a sequence of displacements in a simple and effective way.

The notion of the elementary displacement together with the unfolding method (see [8, 9]) has led to a new method in elasticity which has been successfully applied to many problems, see e.g [5, 6, 7] and

[13, 14, 15, 16, 17, 18, 19]. References and other applications of the unfolding operator technique can be found in [10, 11, 12, 1].

Our paper is organized as follows. In Section 2 we describe the geometry of the rod, introduce the decomposition of a displacement field of the rod and we give some estimates of the decomposition fields in terms of the strain energy (Theorem 2.3). The proof of the Theorem 2.3 is based on the approximation of the displacement of the rod by a rigid body displacement. Of course, the estimates may depend on the function $\rho_{\epsilon}(\cdot)$.

Section 3 is dedicated to get a priori estimates for the different fields assuming that the rod is clamped at the bottom. These estimates have an essential importance in our study to pass to the limit. Moreover, we introduce the rescaling operator Π_{ϵ} which allows to work in a fixed domain. One particular feature of this transformation is that the ratio of the dilation of the fixed rod depends on the third variable, it is given by the function $\epsilon \rho_{\epsilon}(\cdot)$. Then a special care is dedicated to the estimate of the derivatives with respect to the third variable.

In Section 4 we give the limit of the displacements and we show a few relations between some of them. Since some of the a priori estimates established depend on the variable thickness $\rho_{\epsilon}(\cdot)$ we introduce some weighted Sobolev spaces which allow to obtain the limit fields in a natural way. In Section 5 we pose the problem of elasticity and we specify the assumptions on the applied forces. We show that the choice of the applied forces is reasonable to get the suitable estimate of the total elastic energy, so that the convergence results of the previous sections can be used. In Section 6 we derive the equations satisfied by the limit fields and we prove the strong convergence of the energy. Moreover, we deduce some strong convergences of the fields of the displacement's decomposition. Finally, in Section 7 we summarize the main results.

2. Decomposition of the displacement of a straight rod with different order of thickness

Let ω be a bounded domain in \mathbb{R}^2 with Lipschitzian boundary, diameter equal to R and star-shaped with respect to a disc of radius R_1 . We choose the origin O of coordinates at the center of gravity of ω and we choose as coordinates axes $(O; \mathbf{e}_1)$ and $(O; \mathbf{e}_2)$ the principal axes of inertia of ω . Notice that, with this reference frame we have

$$\int_{\omega} x_1 dx_1 dx_2 = \int_{\omega} x_2 dx_1 dx_2 = \int_{\omega} x_1 x_2 dx_1 dx_2 = 0.$$
 (2.1)

The cross-section ω_{ϵ,x_3} of the rod is obtained by transforming ω with a dilatation of center O and ratio $\epsilon \rho_{\epsilon}(x_3)$, where

$$\rho_{\epsilon}(x_3) = 1 - \frac{x_3}{L} (1 - \frac{\epsilon}{L}), \quad x_3 \in [0, L].$$

We assume $0 < \epsilon < L/2$ and $0 < R_1 < 1/2$ without loss of generality.

Definition 2.1. The straight rod is defined as follows:

$$\Omega_{\epsilon} = \{ x = (x_1, x_2, x_3) \in \mathbb{R}^3 \mid x_3 \in (0, L), (x_1, x_2) \in \omega_{\epsilon, x_3} \},$$

where
$$\omega_{\epsilon,x_3} = \left\{ (x_1, x_2) \in \mathbb{R}^2 \mid \left(\frac{x_1}{\epsilon \rho_{\epsilon}(x_3)}, \frac{x_2}{\epsilon \rho_{\epsilon}(x_3)} \right) \in \omega \right\} = \epsilon \rho_{\epsilon}(x_3) \omega.$$




Figure 1: Straight rod Ω_{ϵ} .

Notice that the center line of the straight rod is the coordinate axis $(O; \mathbf{e}_3)$. Moreover, the thickness of the thin rod depends on x_3 , it is given by the function $\epsilon \rho_{\epsilon}(x_3) = \epsilon - \frac{x_3}{L} \epsilon \left(1 - \frac{\epsilon}{L}\right)$. Observe that the diameter of the lower boundary is order ϵ while the diameter of the upper boundary is order ϵ^2/L . (See Figure 1.)

Now, we define an elementary displacement associated to a displacement of the rod.

Definition 2.2. The elementary displacement U_e , associated to $u \in L^1(\Omega_e; \mathbb{R}^3)$, is given by:

$$U_{\epsilon}(x) = \mathcal{U}(x_3) + \mathcal{R}(x_3) \wedge (x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2), \quad x \in \Omega_{\epsilon},$$

where for a.e. $x_3 \in (0, L)$

$$\begin{cases}
\mathcal{U}(x_{3}) = \frac{1}{|\omega|\rho_{\epsilon}(x_{3})^{2}\epsilon^{2}} \int_{\omega_{\epsilon,x_{3}}} u(x_{1}, x_{2}, x_{3}) dx_{1} dx_{2}, \\
\mathcal{R}_{3}(x_{3}) = \frac{1}{(I_{1} + I_{2})\rho_{\epsilon}(x_{3})^{4}\epsilon^{4}} \int_{\omega_{\epsilon,x_{3}}} \left[(x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2}) \wedge u(x_{1}, x_{2}, x_{3}) \right] \cdot \mathbf{e}_{3} dx_{1} dx_{2}, \\
\mathcal{R}_{\alpha}(x_{3}) = \frac{1}{(I_{3-\alpha})\rho_{\epsilon}(x_{3})^{4}\epsilon^{4}} \int_{\omega_{\epsilon,x_{3}}} \left[(x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2}) \wedge u(x_{1}, x_{2}, x_{3}) \right] \cdot \mathbf{e}_{\alpha} dx_{1} dx_{2}, \\
I_{\alpha} = \int_{\omega} x_{\alpha}^{2} dx_{1} dx_{2}, \text{ for } \alpha \in \{1, 2\}.
\end{cases} \tag{2.2}$$

The first component \mathcal{U} of U_e is the displacement of the center line. The second component \mathcal{R} represents the rotation of the cross-section. Under the action of an elementary displacement the cross-section ω_{ϵ,x_3} is translated by $\mathcal{U}(x_3)$ and it is rotated around the vector $\mathcal{R}(x_3)$ with an angle $\|\mathcal{R}(x_3)\|_2$, where $\|\cdot\|_2$ is the Euclidean norm in \mathbb{R}^3 . Observe that, the torsion of the rod is given by the displacement $\mathcal{R}_3(x_3)\mathbf{e}_3 \wedge (x_1\mathbf{e}_1 + x_2\mathbf{e}_2)$.

Any displacement u of the rod can be decomposed as

$$u = U_e + \bar{u}. \tag{2.3}$$

The displacement \bar{u} is the warping.

Next theorem gives estimates of the components of the elementary displacement U_e and of the warping \bar{u} in terms of ϵ , ρ_{ϵ} and of the strain energy of the displacement u. Notice that if u belongs to $H^1(\Omega_{\epsilon})$ the functions \mathcal{U} and \mathcal{R} belong to $H^1((0,L);\mathbb{R}^3)$.

Theorem 2.3. Let $u \in H^1(\Omega_{\epsilon}; \mathbb{R}^3)$ and $u = U_e + \overline{u}$ the decomposition given by (2.2)-(2.3). Then the following estimates hold:

The constants are independent of ϵ and L.

Proof. To prove the above estimates we are going to introduce a partition of the rod Ω_{ϵ} in several small portions where every of these small rods are star-shaped with respect to suitable balls which verify that the ratio between their radius and the diameters of the portions remains uniformly bounded. Then we use the approximation of the displacement u by a rigid body displacement in each portion, (see Theorem 2.3 in [19]).

Step 1. Construction of the partition.

We start by considering the first portion of the rod

$$\Omega_{\epsilon}^{0} = \{x = (x_1, x_2, x_3) \in \mathbb{R}^3 \mid x_3 \in (0, \epsilon), (x_1, x_2) \in \omega_{\epsilon, x_3} \}.$$

First, notice that Ω_{ϵ}^{0} has a diameter less than $(R+1)\epsilon$ and all the cross-sections of Ω_{ϵ}^{0} are star-shaped with respect to a disc of radius $R_{1}\epsilon\rho_{\epsilon}(\epsilon)$. Therefore, by a simple geometrical argument, it is easy to check that this portion is star-shaped with respect to a ball of radius $R_{1}\epsilon\rho_{\epsilon}(\epsilon)$.

We consider now a partition of the interval [0,L] defined as

$$s_{\epsilon}^0 = 0 < s_{\epsilon}^1 = \epsilon < s_{\epsilon}^2 = s_{\epsilon}^1 + \epsilon \rho_{\epsilon}(s_{\epsilon}^1) < \dots < s_{\epsilon}^{N_{\epsilon}} = s_{\epsilon}^{N_{\epsilon}-1} + \epsilon \rho_{\epsilon}(s_{\epsilon}^{N_{\epsilon}-1}) \le L \le s_{\epsilon}^{N_{\epsilon}+1} = s_{\epsilon}^{N_{\epsilon}} + \epsilon \rho_{\epsilon}(s_{\epsilon}^{N_{\epsilon}}).$$

Hence, the points of the partition $\{s_{\epsilon}^k\}$ are the elements of an arithmetico-geometric sequence

$$s_{\epsilon}^{k} = \epsilon \frac{1 - \rho_{\epsilon}(\epsilon)^{k}}{1 - \rho_{\epsilon}(\epsilon)} \implies \lim_{k \to \infty} s_{\epsilon}^{k} = \frac{\epsilon}{1 - \rho_{\epsilon}(\epsilon)} = \frac{L}{1 - \frac{\epsilon}{L}} > L.$$

It makes sense to define N_{ϵ} as the largest integer such that $s_{\epsilon}^{N_{\epsilon}} \leq L$.

The (k+1)-portion of the rod is defined as

$$\Omega^k_\epsilon = \{x \in \mathbb{R}^3 \mid x_3 \in \left(s^k_\epsilon, s^k_\epsilon + \epsilon \rho_\epsilon(s^k_\epsilon)\right), (x_1, x_2) \in \omega_{\epsilon, x_3}\}, \quad 0 \leq k \leq N_\epsilon - 2,$$

and

$$\Omega_{\epsilon}^{N_{\epsilon}-1} = \{ x \in \mathbb{R}^3 \mid x_3 \in (s^{N_{\epsilon}-1}, L), (x_1, x_2) \in \omega_{\epsilon, x_3} \}.$$

Therefore, we obtain

$$\Omega_{\epsilon} = \operatorname{Int} \left\{ \bigcup_{k=0}^{N_{\epsilon}-1} \overline{\Omega_{\epsilon}^{k}} \right\}.$$




Figure 2: Partition of straight rod Ω_{ϵ} .

Step 2. Rigid body approximation of u in the portions.

Since Ω_{ϵ}^k $(0 \le k \le N_{\epsilon} - 2)$ is obtained by transforming Ω_{ϵ}^0 by a dilation of ratio $\rho_{\epsilon}(s_{\epsilon}^k)$ we can conclude that Ω_{ϵ}^k $(0 \le k \le N_{\epsilon} - 2)$ is star-shaped with respect to a ball of radius $R_1 \epsilon \rho_{\epsilon}(s_{\epsilon}^{k+1})$ and its diameter is less than $(R+1)\epsilon \rho_{\epsilon}(s_{\epsilon}^k)$. Moreover, the last portion $\Omega_{\epsilon}^{N_{\epsilon}-1}$ is star-shaped with respect to a ball of radius $R_1 \epsilon \rho_{\epsilon}(s_{\epsilon}^{N_{\epsilon}+1})$ and its diameter is less than $2(R+1)\epsilon \rho_{\epsilon}(s_{\epsilon}^{N_{\epsilon}-1})$.

From Theorem 2.3 in [19] there exists a rigid body displacement r_k $(0 \le k \le N_{\epsilon} - 1)$ such that

$$||u - r_k||_{L^2(\Omega_{\epsilon}^k; \mathbb{R}^3)}^2 \le C(R+1)^2 \epsilon^2 \rho_{\epsilon}(s_{\epsilon}^k)^2 ||(\nabla u)_{\mathcal{S}}||_{[L^2(\Omega_{\epsilon}^k)]^9}^2,$$

$$||\nabla (u - r_k)||_{[L^2(\Omega^k; \mathbb{R}^3)]^9}^2 \le C(R+1)^2 ||(\nabla u)_{\mathcal{S}}||_{[L^2(\Omega_{\epsilon}^k)]^9}^2.$$
(2.5)

The constants depend only on the reference cross-section ω and on the ratio between the diameter of the portion and the radius of the ball inside (see Theorem 2.3 in [19])

$$\frac{(R+1)\epsilon\rho_{\epsilon}(s_{\epsilon}^{k})}{R_{1}\epsilon\rho_{\epsilon}(s_{\epsilon}^{k+1})} = \frac{R+1}{R_{1}} \frac{\rho_{\epsilon}(s_{\epsilon}^{k})}{\rho_{\epsilon}(s_{\epsilon}^{k}) - \frac{\epsilon\rho_{\epsilon}(s_{\epsilon}^{k})}{L} \left(1 - \frac{\epsilon}{L}\right)} = \frac{R+1}{R_{1}} \frac{1}{\rho_{\epsilon}(\epsilon)} \le \frac{4}{3} \frac{R+1}{R_{1}}, \ 0 \le k \le N_{\epsilon} - 2. \tag{2.6}$$

Observe that for the last portion the ratio is less than $4\frac{R+1}{R_1}$.

Step 3. First estimate in (2.4).

Recall that the rigid body displacements r_k are of the form

$$r_k(x) = A_k + B_k \wedge (x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2 + (x_3 - s_{\epsilon}^k) \mathbf{e}_3), \quad x = (x_1, x_2, x_3) \in \Omega_{\epsilon}^k \text{ and } A_k, B_k \in \mathbb{R}^3.$$

Now, we are going to prove $(0 \le k \le N_{\epsilon} - 2)^1$

$$\|\mathcal{U} - A_k - B_k \wedge (x_3 - s_{\epsilon,k}) \mathbf{e}_3\|_{L^2((s^k, s^{k+1}_{\epsilon}) : \mathbb{R}^3)}^2 \le C \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon}^k)]^9}^2, \tag{2.7}$$

¹If $k = N_{\epsilon} - 1$ we have to replace s_{ϵ}^{k+1} by L.

$$\|\mathcal{R} - B_k\|_{L^2((s_{\epsilon}^k, s_{\epsilon}^{k+1}); \mathbb{R}^3)}^2 \le \frac{C}{\epsilon^2 \rho_{\epsilon}(s_{\epsilon}^{k+1})^2} \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon}^k)]^9}^2.$$
(2.8)

The constants do not depend on k and ϵ .

The proof is similar for both inequalities, we will show only the first one. Taking the mean value of $u-r_k$ over the cross-sections of the portion Ω^k_{ϵ} and by the definition of the elementary displacement and (2.1) we have

$$\|\mathcal{U} - A_k - B_k \wedge (x_3 - s_{\epsilon,k}) \mathbf{e}_3\|_{L^2((s_{\epsilon}^k, s_{\epsilon}^{k+1}); \mathbb{R}^3)}^2 = \int_{s_{\epsilon}^k}^{s_{\epsilon}^{k+1}} |\mathcal{U}(x_3) - A_k - B_k \wedge (x_3 - s_{\epsilon,k}) \mathbf{e}_3|^2 dx_3$$

$$= \int_{s_{\epsilon}^k}^{s_{\epsilon}^{k+1}} \left| \frac{1}{|\omega| \rho_{\epsilon}(x_3)^2 \epsilon^2} \int_{\omega_{\epsilon, x_3}} [u(x_1, x_2, x_3) - r_k(x_1, x_2, x_3)] dx_1 dx_2 \right|^2 dx_3$$

$$\leq \int_{s_{\epsilon}^k}^{s_{\epsilon}^{k+1}} \frac{1}{|\omega| \rho_{\epsilon}(x_3)^2 \epsilon^2} \int_{\omega_{\epsilon, x_3}} |u(x) - r_k(x)|^2 dx$$

$$\leq \frac{1}{|\omega| \rho_{\epsilon}(s_{\epsilon}^{k+1})^2 \epsilon^2} \int_{\Omega_{\epsilon}^k} |u(x) - r_k(x)|^2 dx.$$

Then using $(2.5)_1$ and taking into account (2.6) we obtain the expected estimate

$$\|\mathcal{U} - A_k - B_k \wedge (x_3 - s_{\epsilon,k}) \mathbf{e}_3\|_{L^2((s_{\epsilon}^k, s_{\epsilon}^{k+1}); \mathbb{R}^3)}^2 \leq \frac{C(R+1)^2 \epsilon^2 \rho_{\epsilon}(s_{\epsilon}^k)^2}{|\omega| \epsilon^2 \rho_{\epsilon}(s_{\epsilon}^{k+1})^2} \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon}^k)]^9}^2 \leq C \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon}^k)]^9}^2,$$

where the constant does not depend on ϵ and k.

Consequently, from (2.7) and (2.8), taking into account the definition of the elementary displacement and $\int_{\omega_{\epsilon}, x_{\epsilon}} x_{\alpha}^{2} dx_{1} dx_{2} = \epsilon^{4} \rho_{\epsilon}(x_{3})^{4} I_{\alpha}$ we have

$$||U_{e} - r_{k}||_{L^{2}(\Omega_{\epsilon}^{k})} \leq ||\mathcal{U} - A_{k} - B_{k} \wedge (x_{3} - s_{\epsilon,k})\mathbf{e}_{3}||_{L^{2}(\Omega_{\epsilon}^{k})} + ||(\mathcal{R} - B_{k}) \wedge (x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2})||_{L^{2}(\Omega_{\epsilon}^{k})}$$

$$\leq \int_{s_{\epsilon}^{k}}^{s_{\epsilon}^{k+1}} |\omega|\rho_{\epsilon}(x_{3})^{2}\epsilon^{2}|\mathcal{U}(x_{3}) - A_{k} - B_{k} \wedge (x_{3} - s_{\epsilon,k})\mathbf{e}_{3}|^{2} dx_{3} + C\epsilon^{4}\rho_{\epsilon}(s_{\epsilon}^{k})^{4}||\mathcal{R} - B_{k}||_{L^{2}(s_{\epsilon}^{k}, s_{\epsilon}^{k+1})}^{2}$$

$$\leq C\epsilon^{2}\rho_{\epsilon}(s_{\epsilon}^{k})^{2}||(\nabla u)s||_{L^{2}(\Omega_{\epsilon}^{k})]^{9}}^{2}.$$

Thus, we can replace r_k by U_e in $(2.5)_1$

$$||u - U_e||_{L^2(\Omega^k;\mathbb{R}^3)}^2 \le C\epsilon^2 \rho_{\epsilon}(s_{\epsilon}^k)^2 ||(\nabla u)_{\mathcal{S}}||_{[L^2(\Omega^k)]^9}^2.$$

Moreover, since $1 \leq \frac{\rho_{\epsilon}(s_{\epsilon}^k)}{\rho_{\epsilon}(x_3)} \leq 2$ for $x_3 \in (s_{\epsilon}^k, s_{\epsilon}^{k+1})$, we get

$$\left\| \frac{u - U_e}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon}^k; \mathbb{R}^3)}^2 \le C \epsilon^2 \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon}^k)]^9}^2.$$

Adding all these inequalities lead to the first estimate involving the warping

$$\left\| \frac{u - U_e}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon}; \mathbb{R}^3)}^2 \le C\epsilon^2 \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}^2. \tag{2.9}$$

Step 4. Second estimate in (2.4).

First of all, we compute the derivative of \mathcal{U} with respect to x_3 . Since the diameter of the cross-section depends on x_3 we rewrite \mathcal{U} performing a change of variables

$$\mathcal{U}(x_3) = \frac{1}{|\omega|\epsilon^2} \int_{\omega_{\epsilon}} u(\rho_{\epsilon}(x_3)s_1, \rho_{\epsilon}(x_3)s_2, x_3) \, ds_1 ds_2,$$

where $\omega_{\epsilon} = \epsilon \omega$. The derivative is given by

$$\frac{d\mathcal{U}}{dx_3}(x_3) = \frac{1}{|\omega|\epsilon^2} \int_{\omega_{\epsilon}} \left[\frac{\partial u}{\partial x_1} \rho'_{\epsilon}(x_3) s_1 + \frac{\partial u}{\partial x_2} \rho'_{\epsilon}(x_3) s_2 + \frac{\partial u}{\partial x_3} \right] ds_1 ds_2, \quad \text{for a.e } x_3 \in (0, L).$$

Undoing the change of variables we get

$$\frac{d\mathcal{U}}{dx_3}(x_3) = \frac{1}{|\omega|\epsilon^2\rho_\epsilon(x_3)^2} \int_{\omega_{\epsilon,x_3}} \left[\frac{\partial u}{\partial x_1} x_1 \frac{\rho'_\epsilon(x_3)}{\rho_\epsilon(x_3)} + \frac{\partial u}{\partial x_2} x_2 \frac{\rho'_\epsilon(x_3)}{\rho_\epsilon(x_3)} + \frac{\partial u}{\partial x_3} \right] dx_1 dx_2, \quad \text{ for a.e } x_3 \in (0,L).$$

From (2.5) we have

$$\left\| \frac{\partial u}{\partial x_i} - B_k \wedge \mathbf{e}_i \right\|_{L^2(\Omega_{\epsilon}^k; \mathbb{R}^3)}^2 \le C \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon}^k)]^9}^2, \quad i \in \{1, 2, 3\}.$$

Moreover, from (2.8) we may replace B_k by \mathcal{R}

$$\left\| \frac{\partial u}{\partial x_i} - \mathcal{R} \wedge \mathbf{e}_i \right\|_{L^2(\Omega_{\epsilon}^k; \mathbb{R}^3)}^2 \le C \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon}^k)]^9}^2, \quad i \in \{1, 2, 3\}.$$

Adding all these inequalities we obtain

$$\left\| \frac{\partial u}{\partial x_i} - \mathcal{R} \wedge \mathbf{e}_i \right\|_{L^2(\Omega_{\epsilon}; \mathbb{R}^3)}^2 \le C \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}^2, \quad i \in \{1, 2, 3\}.$$
 (2.10)

Taking into account (2.1) we have for a.e. $x_3 \in (0, L)$

$$\frac{d\mathcal{U}}{dx_3}(x_3) - \mathcal{R}(x_3) \wedge \mathbf{e}_3 = \frac{1}{|\omega|\epsilon^2 \rho_{\epsilon}(x_3)^2} \int_{\omega_{\epsilon,x_3}} \left[\left(\frac{\partial u}{\partial x_1}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_1 \right) x_1 \frac{\rho'_{\epsilon}(x_3)}{\rho_{\epsilon}(x_3)} + \left(\frac{\partial u}{\partial x_2}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_2 \right) x_2 \frac{\rho'_{\epsilon}(x_3)}{\rho_{\epsilon}(x_3)} + \left(\frac{\partial u}{\partial x_3}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_3 \right) \right] dx_1 dx_2.$$

Using (2.10) leads to $(0 \le k \le N_{\epsilon} - 2)^2$

$$\begin{split} \left\| \frac{d\mathcal{U}}{dx_{3}} - \mathcal{R} \wedge \mathbf{e}_{3} \right\|_{L^{2}(s_{\epsilon}^{k}, s_{\epsilon}^{k+1})}^{2} &\leq \frac{C}{\rho_{\epsilon}(s_{\epsilon}^{k+1})^{2}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon}^{k})]^{9}}^{2} + \frac{C}{\epsilon^{2} \rho_{\epsilon}(s_{\epsilon}^{k+1})^{2}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon}^{k})]^{9}}^{2} \\ &\leq \frac{C}{\epsilon^{2} \rho_{\epsilon}(s_{\epsilon}^{k+1})^{2}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon}^{k})]^{9}}^{2}. \end{split}$$

Hence, since $1 \leq \frac{\rho_{\epsilon}(x_3)}{\rho_{\epsilon}(s_{\epsilon}^{k+1})} \leq 2$ for $x_3 \in (s_{\epsilon}^k, s_{\epsilon}^{k+1})$ we obtain

$$\left\| \rho_{\epsilon} \left(\frac{d\mathcal{U}}{dx_3} - \mathcal{R} \wedge \mathbf{e}_3 \right) \right\|_{L^2(s_{\epsilon}^k, s_{\epsilon}^{k+1})}^2 \le \frac{C}{\epsilon^2} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}^2. \tag{2.11}$$

²If $k = N_{\epsilon} - 1$ we have to replace s_{ϵ}^{k+1} by L.

Adding all these inequalities we get the desired estimate

$$\left\| \rho_{\epsilon} \left(\frac{d\mathcal{U}}{dx_3} - \mathcal{R} \wedge \mathbf{e}_3 \right) \right\|_{L^2((0,L);\mathbb{R}^3)}^2 \le \frac{C}{\epsilon^2} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}^2. \tag{2.12}$$

Step 5. Third estimate in (2.4).

First of all, we introduce the function:

$$V(x_3) = \frac{1}{\epsilon^4 \rho_{\epsilon}(x_3)^4} \int_{\omega_{\epsilon, x_3}} [(x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2) \wedge u(x_1, x_2, x_3)] dx_1 dx_2.$$

To calculate the derivative with respect to x_3 we perform a change of variables which allows us to write the function V as follows:

$$V(x_3) = \frac{1}{\epsilon^4 \rho_{\epsilon}(x_3)^2} \int_{\omega_{\epsilon}} (\rho_{\epsilon}(x_3) s_1 \mathbf{e}_1 + \rho_{\epsilon}(x_3) s_2 \mathbf{e}_2) \wedge u(\rho_{\epsilon}(x_3) s_1, \rho_{\epsilon}(x_3) s_2, x_3)] ds_1 ds_2$$

$$= \frac{1}{\epsilon^4 \rho_{\epsilon}(x_3)} \int_{\omega_{\epsilon}} (s_1 \mathbf{e}_1 + s_2 \mathbf{e}_2) \wedge u(\rho_{\epsilon}(x_3) s_1, \rho_{\epsilon}(x_3) s_2, x_3)] ds_1 ds_2.$$

Then deriving with respect to x_3 gives (for a.e. $x_3 \in (0, L)$)

$$\frac{dV}{dx_3}(x_3) = \frac{-2\rho'_{\epsilon}(x_3)}{\epsilon^4 \rho_{\epsilon}(x_3)^2} \int_{\omega_{\epsilon}} \left[(s_1 \mathbf{e}_1 + s_2 \mathbf{e}_2) \wedge u(\rho_{\epsilon}(x_3)s_1, \rho_{\epsilon}(x_3)s_2, x_3) \right] ds_1 ds_2
+ \frac{1}{\epsilon^4 \rho_{\epsilon}(x_3)} \int_{\omega_{\epsilon}} \left[(s_1 \mathbf{e}_1 + s_2 \mathbf{e}_2) \wedge \left(\frac{\partial u}{\partial x_1} \rho'_{\epsilon}(x_3)s_1 + \frac{\partial u}{\partial x_2} \rho'_{\epsilon}(x_3)s_2 + \frac{\partial u}{\partial x_3} \right) \right] ds_1 ds_2$$

Undoing the change of variables we have (for a.e. $x_3 \in (0, L)$)

$$\begin{split} \frac{dV}{dx_3}(x_3) = & \frac{-2\rho_\epsilon'(x_3)}{\epsilon^4 \rho_\epsilon(x_3)^5} \int_{\omega_\epsilon, x_3} \left[(x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2) \wedge u(x_1, x_2, x_3) \right] dx_1 dx_2 \\ & + \frac{1}{\epsilon^4 \rho_\epsilon(x_3)^4} \int_{\omega_\epsilon, x_3} \left[(x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2) \wedge \left(\frac{\partial u}{\partial x_1} \frac{\rho_\epsilon'(x_3)}{\rho_\epsilon(x_3)} x_1 + \frac{\partial u}{\partial x_2} \frac{\rho_\epsilon'(x_3)}{\rho_\epsilon(x_3)} x_2 + \frac{\partial u}{\partial x_3} \right) \right] dx_1 dx_2. \end{split}$$

In view of (2.1) we can write (for a.e. $x_3 \in (0, L)$)

$$\begin{split} &\frac{dV}{dx_3}(x_3) = \frac{-2\rho'_{\epsilon}(x_3)}{\epsilon^4 \rho_{\epsilon}(x_3)^5} \int_{\omega_{\epsilon},x_3} \left[(x_1\mathbf{e}_1 + x_2\mathbf{e}_2) \wedge \left(u(x) - \mathcal{U}(x_3) - \mathcal{R}(x_3) \wedge (x_1\mathbf{e}_1 + x_2\mathbf{e}_2) \right) \right] dx_1 dx_2 \\ &+ \frac{\rho'_{\epsilon}(x_3)}{\epsilon^4 \rho_{\epsilon}(x_3)^5} \int_{\omega_{\epsilon},x_3} \left\{ (x_1\mathbf{e}_1 + x_2\mathbf{e}_2) \wedge \left[x_1 \left(\frac{\partial u}{\partial x_1}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_1 \right) + x_2 \left(\frac{\partial u}{\partial x_2}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_2 \right) \right) \right\} dx_1 dx_2 \\ &+ \frac{1}{\epsilon^4 \rho_{\epsilon}(x_3)^4} \int_{\omega_{\epsilon},x_3} (x_1\mathbf{e}_1 + x_2\mathbf{e}_2) \wedge \left(\frac{\partial u}{\partial x_3}(x) - \mathcal{R}(x_3) \wedge \mathbf{e}_3 \right) dx_1 dx_2. \end{split}$$

Using (2.9) and (2.11) leads to $(0 \le k \le N_{\epsilon} - 2)^3$

$$\begin{split} \left\| \frac{dV}{dx_{3}} \right\|_{L^{2}((s_{\epsilon}^{k}, s_{\epsilon}^{k+1}); \mathbb{R}^{3})}^{2} &\leq \frac{C}{\epsilon^{2} \rho_{\epsilon}(s_{\epsilon}^{k+1})^{2}} \left\| \frac{u - U_{e}}{\rho_{\epsilon}} \right\|_{L^{2}(\Omega_{\epsilon}^{k}; \mathbb{R}^{3})}^{2} + \frac{C}{\epsilon^{2} \rho_{\epsilon}(s_{\epsilon}^{k+1})^{2}} \sum_{i=1}^{3} \left\| \frac{\partial u}{dx_{3}} - \mathcal{R} \wedge \mathbf{e}_{i} \right\|_{L^{2}(\Omega_{\epsilon}^{k}; \mathbb{R}^{3})}^{2} \\ &\leq \frac{C}{\rho_{\epsilon}(s_{\epsilon}^{k+1})^{4}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon}^{k})^{9}}^{2} + \frac{C}{\epsilon^{4} \rho_{\epsilon}(s_{\epsilon}^{k+1})^{4}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon}^{k})^{9}}^{2} \end{split}$$

³If $k = N_{\epsilon} - 1$ we have to replace s_{ϵ}^{k+1} by L.

$$\leq \frac{C}{\epsilon^4 \rho_{\epsilon}(s_{\epsilon}^{k+1})^4} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon}^k)]^9}^2.$$

Thus, since $1 \leq \frac{\rho_{\epsilon}(x_3)}{\rho_{\epsilon}(s_{\epsilon}^{k+1})} \leq 2$ for $x_3 \in (s_{\epsilon}^k, s_{\epsilon}^{k+1})$ and adding all these inequalities we have

$$\left\| \rho_{\epsilon}^{2} \frac{dV}{dx_{3}} \right\|_{L^{2}((0,L);\mathbb{R}^{3})}^{2} \leq \frac{C}{\epsilon^{4}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}^{2}.$$

Since $(I_1 + I_2)\mathcal{R} = V + \frac{I_1}{I_2}(V \cdot \mathbf{e}_1)\mathbf{e}_1 + \frac{I_2}{I_1}(V \cdot \mathbf{e}_2)\mathbf{e}_2$ we get the required estimate

$$\left\| \rho_{\epsilon}^{2} \frac{d\mathcal{R}}{dx_{3}} \right\|_{L^{2}((0,L);\mathbb{R}^{3})}^{2} \leq \frac{C}{\epsilon^{4}} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}^{2}.$$
(2.13)

Step 6. Fourth estimate.

Observe that

$$\frac{\partial}{\partial x_{\alpha}}(u - U_{e}) = \frac{\partial u}{\partial x_{\alpha}} - \mathcal{R} \wedge \mathbf{e}_{\alpha}, \quad \text{for } \alpha \in \{1, 2\},
\frac{\partial}{\partial x_{3}}(u - U_{e}) = \frac{\partial u}{\partial x_{3}} - \frac{\partial \mathcal{U}}{\partial x_{3}} - \frac{\partial \mathcal{R}}{\partial x_{3}} \wedge (x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2})
= \frac{\partial u}{\partial x_{3}} - \mathcal{R} \wedge \mathbf{e}_{3} + \mathcal{R} \wedge \mathbf{e}_{3} - \frac{\partial \mathcal{U}}{\partial x_{3}} - \frac{\partial \mathcal{R}}{\partial x_{3}} \wedge (x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2}).$$

From these expressions and taking into account (2.10), (2.12) and (2.13) we can conclude

$$\|\nabla \bar{u}\|_{[L^2(\Omega_{\epsilon};\mathbb{R}^3)]^9}^2 \le C \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon})]^9}^2,$$

which ends the proof.

3. Estimates for the clamped rod at the bottom.

From now on, we will assume that the rod Ω_{ϵ} is clamped at the bottom, $\Gamma_{\epsilon,0} = \omega_{\epsilon,0} \times \{0\}$. Then the space of admissible displacements of the rod is

$$H^1_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon};\mathbb{R}^3) = \{ u \in H^1(\Omega_{\epsilon};\mathbb{R}^3) \mid u = 0 \text{ on } \Gamma_{\epsilon,0} \}.$$

Observe that the elementary displacement U_e associated to any $u \in H^1_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon}; \mathbb{R}^3)$ is equal to zero in the fixed part of the rod, $\mathcal{U}(0) = \mathcal{R}(0) = 0$.

Using estimates (2.4) and the boundary condition we deduce estimates on \mathcal{R} , $\frac{d\mathcal{U}}{dx_3}$ and \mathcal{U} .

Lemma 3.1. Assuming the rod clamped at the bottom, then we have

$$\begin{cases}
\|\rho_{\epsilon}\mathcal{R}\|_{L^{2}((0,L);\mathbb{R}^{3})} \leq \frac{CL}{\epsilon^{2}} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \\
\|\rho_{\epsilon}\frac{d\mathcal{U}_{\alpha}}{dx_{3}}\|_{L^{2}(0,L)} \leq \frac{CL}{\epsilon^{2}} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \quad \text{for } \alpha \in \{1,2\}, \\
\|\rho_{\epsilon}\frac{d\mathcal{U}_{3}}{dx_{3}}\|_{L^{2}(0,L)} \leq \frac{C}{\epsilon} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \\
\|\mathcal{U}_{\alpha}\|_{L^{2}(0,L)} \leq \frac{CL^{2}}{\epsilon^{2}} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \quad \text{for } \alpha \in \{1,2\}, \\
\|\mathcal{U}_{3}\|_{L^{2}(0,L)} \leq \frac{CL}{\epsilon} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}},
\end{cases}$$

$$(3.1)$$

The constants are independent of ϵ and L.

Proof. We begin with the proof of the first estimate in (3.1). Since $\mathcal{R}(0) = 0$ by integration by parts we have

$$\int_0^L 2\rho_{\epsilon}^3(x_3) \mathcal{R}(x_3) \frac{d\mathcal{R}}{dx_3}(x_3) dx_3 = -\int_0^L 3\rho_{\epsilon}^2(x_3) \rho_{\epsilon}'(x_3) \mathcal{R}^2(x_3) dx_3 + \rho_{\epsilon}^3(L) \mathcal{R}^2(L).$$

Then taking into account the facts that $\frac{1}{2L} \le -\rho'_{\epsilon}(x_3) = \frac{1}{L} \left(1 - \frac{\epsilon}{L}\right) \le \frac{1}{L} \left(0 < \epsilon < \frac{L}{2}\right)$ and $0 \le \rho^3_{\epsilon}(L)\mathcal{R}^2(L)$ we get

$$\int_0^L \rho_{\epsilon}^2(x_3) \mathcal{R}^2(x_3) \, dx_3 \le \frac{2L}{3} \int_0^L \rho_{\epsilon}^3(x_3) \mathcal{R}(x_3) \frac{d\mathcal{R}}{dx_3}(x_3) \, dx_3.$$

Hence, by the Cauchy's inequality it follows that:

$$\int_{0}^{L} \rho_{\epsilon}^{3}(x_{3}) \mathcal{R}(x_{3}) \frac{d\mathcal{R}}{dx_{3}}(x_{3}) dx_{3} \leq \|\rho_{\epsilon} \mathcal{R}\|_{L^{2}((0,L);\mathbb{R}^{3})} \|\rho_{\epsilon}^{2} \frac{d\mathcal{R}}{dx_{3}}\|_{L^{2}((0,L);\mathbb{R}^{3})}$$

Finally, the above inequalities together with the third estimate in (2.4) allow us to obtain the required estimate

$$\|\rho_{\epsilon} \mathcal{R}\|_{L^{2}((0,L);\mathbb{R}^{3})} \leq \frac{2L}{3} \|\rho_{\epsilon}^{2} \frac{d\mathcal{R}}{dx_{3}}\|_{L^{2}((0,L);\mathbb{R}^{3})} \leq \frac{CL}{\epsilon^{2}} \|(\nabla u)_{\mathcal{S}}\|_{[L^{2}(\Omega_{\epsilon})]^{9}}.$$
(3.2)

The constant is independent of ϵ and L.

The second estimate follows from $(2.4)_2$ and (3.2):

$$\left\| \rho_{\epsilon} \frac{d\mathcal{U}}{dx_{3}} \right\|_{L^{2}((0,L);\mathbb{R}^{3})} \leq \left\| \rho_{\epsilon} \left(\frac{d\mathcal{U}}{dx_{3}} - \mathcal{R} \wedge e_{3} \right) \right\|_{L^{2}((0,L))} + \| \rho_{\epsilon} (\mathcal{R} \wedge e_{3}) \|_{L^{2}((0,L);\mathbb{R}^{3})} \leq \frac{CL}{\epsilon^{2}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}.$$
 (3.3)

From the second estimate in (2.4) we obtain a better estimate for $\left\| \rho_{\epsilon} \frac{d\mathcal{U}_3}{dx_3} \right\|_{L^2(0,L)}$

$$\left\| \rho_{\epsilon} \frac{d\mathcal{U}_3}{dx_3} \right\|_{L^2(0,L)} = \left\| \rho_{\epsilon} \left(\frac{d\mathcal{U}}{dx_3} - \mathcal{R} \wedge \mathbf{e}_3 \right) \cdot \mathbf{e}_3 \right\|_{L^2((0,L);\mathbb{R}^3)} \le \frac{C}{\epsilon} \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon})]^9}. \tag{3.4}$$

Finally, the estimates for \mathcal{U} follows by a similar computation to \mathcal{R} . We first prove

$$\|\mathcal{U}_{i}^{\epsilon}\|_{L^{2}(0,L)} \leq 2L \left\| \rho_{\epsilon} \frac{d\mathcal{U}_{i}^{\epsilon}}{dx_{2}} \right\|_{L^{2}(0,L)} \quad \text{for } i = 1, 2, 3$$

then due to $(3.1)_2$ - $(3.1)_3$ we get $(3.1)_4$ - $(3.1)_5$.

In view of the definition of the elementary displacement (2.2) we can write explicitly the components of the displacement, the gradient and the symmetric gradient of the displacement

$$\begin{cases} u_1(x) = \mathcal{U}_1(x_3) - x_2 \mathcal{R}_3(x_3) + \bar{u}_1(x), \\ u_2(x) = \mathcal{U}_2(x_3) + x_1 \mathcal{R}_3(x_3) + \bar{u}_2(x), \\ u_3(x) = \mathcal{U}_3(x_3) - x_1 \mathcal{R}_2(x_3) + x_2 \mathcal{R}_1(x_3) + \bar{u}_3(x). \end{cases}$$
(3.5)

Remark 3.2. Notice that, due to the definition of U, R and (2.1) we know that the warping satisfies

$$\int_{\omega_{\epsilon,x_3}} \bar{u}_i dx_1 dx_2 = \int_{\omega_{\epsilon,x_3}} (x_1 \bar{u}_2 - x_2 \bar{u}_1) dx_1 dx_2 = \int_{\omega_{\epsilon,x_3}} x_\alpha \bar{u}_3 dx_1 dx_2 = 0, \quad i \in \{1,2,3\}, \quad \alpha \in \{1,2\}. \quad (3.6)$$

The previous Lemma 3.1 allows us to established the Korn's inequality for any displacement $u \in H^1_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon};\mathbb{R}^3)$.

The constant does not depend on ϵ and L.

Proof. Recall that any displacement $u \in H^1_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon}; \mathbb{R}^3)$ can be written as $u = U_e + \bar{u}$. Then we get

$$\left\| \frac{u_3}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon}; \mathbb{R}^3)} \leq \|\epsilon \mathcal{U}_3\|_{L^2(0, L)} + \left\| \frac{x_1 \mathcal{R}_2}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon})} + \left\| \frac{x_2 \mathcal{R}_1}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon})} + \left\| \frac{\bar{u}_3}{\rho_{\epsilon}} \right\|_{L^2(\Omega_{\epsilon})}$$
$$\leq CL \|(\nabla u)_{\mathcal{S}}\|_{[L^2(\Omega_{\epsilon}]^9},$$

which ends the proof.

3.1. Rescaling of the rod

In this paragraph we define an operator which changes the scale. It allows us to transform the rod Ω_{ϵ} into a domain independent of ϵ .

Set $\Omega = \omega \times (0, L)$, the reference beam. We rescale Ω_{ϵ} using the following operator:

defined for any function ϕ measurable on Ω_{ϵ} .

Observe that, if $\phi \in L^2(\Omega_{\epsilon})$ then $(\Pi_{\epsilon}\phi) \in L^2(\Omega)$ and we have

We recall that $||\rho'_{\epsilon}||_{L^{\infty}(0,L)} \leq \frac{1}{L}$, then from (2.4) and (3.10) we get

$$\left\| \rho_{\epsilon} \frac{\partial (\Pi_{\epsilon} \overline{u})}{\partial x_{3}} \right\|_{L^{2}(\Omega; \mathbb{R}^{3})} \leq \frac{C}{L} \left(\left\| \frac{\partial \overline{u}}{\partial x_{1}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} + \left\| \frac{\partial \overline{u}}{\partial x_{2}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \right) + \frac{1}{\epsilon} \left\| \frac{\partial \overline{u}}{\partial x_{3}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})}$$

$$\leq \frac{C}{\epsilon} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}. \tag{3.14}$$

In the same way, all the estimates in the previous sections over Ω_{ϵ} can be easily transposed over Ω .

4. Asymptotic behavior of a sequence of displacements

Now we consider a sequence of admissible displacements $\{u^{\epsilon}\}_{\epsilon}$, where $u^{\epsilon} \in H^1_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon}; \mathbb{R}^3)$, satisfying

$$\|(\nabla u^{\epsilon})_S\|_{[L^2(\Omega_{\epsilon})]^9} \le C\epsilon^2,$$

the constant does not depend on ϵ .

We are interested to describe the behaviour of the sequence $\{u^{\epsilon}\}_{\epsilon}$ as $\epsilon \to 0$. In the following proposition we introduce the weak limits of the fields of the displacement's decomposition in the rod. We denote by $\rho(x_3) = 1 - \frac{x_3}{L}$, $x_3 \in [0, L]$, the strong limit in $L^{\infty}(0, L)$ of ρ_{ϵ} . Observe that

$$0 \le \rho(t) \le \rho_{\epsilon}(t) \quad \text{for } t \in [0, L]. \tag{4.1}$$

First of all, we introduce certain weighted Lebesgue and Sobolev spaces defined in the interval (0, L).

• $L^2_{\rho^k}(0,L), k \in \mathbb{N}$, consists of locally summable functions $\varphi:(0,L) \to \mathbb{R}$ equipped with the following norm:

$$\|\varphi\|_{L^2_{\rho^k}(0,L)} = \Big(\int_0^L [\rho^k(t)\varphi(t)]^2 \, dt\Big)^{1/2}.$$

Obseve that, there exists a linear homeomorphism of $L^2(0,L)$ onto $L^2_{o^k}(0,L)$

$$T(\psi) = \frac{\psi}{\rho^k}, \quad \text{for } \psi \in L^2(0, L).$$

Then $L^2_{\rho^k}(0,L) = \left\{ \varphi \in L^2_{loc}(0,L) \mid \rho^k \varphi \in L^2(0,L) \right\}$ endowed with the norm above is a Banach space.

Remark 4.1. Observe that if $\{\Phi_{\epsilon}\}_{\epsilon}$ is a sequence of functions belonging to $L^{2}(\Omega)$ and satisfying $\rho_{\epsilon}^{k}\Phi_{\epsilon} \rightharpoonup \Psi$ weakly in $L^{2}(\Omega)$ then $\Phi_{\epsilon} \rightharpoonup \Phi = \frac{\Psi}{\rho^{k}}$ weakly in $L^{2}(\Omega)$. Conversely, if $\{\Phi_{\epsilon}\}_{\epsilon}$ is a sequence of functions such that $\rho_{\epsilon}^{k}\Phi_{\epsilon}$ is uniformly bounded in $L^{2}(\Omega)$ and satisfies $\Phi_{\epsilon} \rightharpoonup \Phi$ weakly in $L^{2}_{\rho^{k}}(\Omega)$ then $\rho_{\epsilon}^{k}\Phi_{\epsilon} \rightharpoonup \rho^{k}\Phi$ weakly in $L^{2}(\Omega)$. Here k belongs to \mathbb{N} .

• We define the space $H^1_{\rho}(0,L)$ as follows:

$$H^1_{\rho}(0,L) = \Big\{ \varphi \in H^1_{loc}(0,L) \mid \rho \varphi' \in L^2(0,L), \varphi \in L^2(0,L) \text{ and } \varphi(0) = 0 \Big\},$$

endowed with the following norm:

$$\|\varphi\|_{H^1_{\rho}(0,L)} = \left(\int_0^L [\rho(t)\varphi'(t)]^2 dt\right)^{1/2}.$$

We use this norm since as in the proof of Lemma 3.1 we can easily obtain

$$\|\varphi\|_{L^2(0,L)} \le 2L\|\rho\varphi'\|_{L^2(0,L)}, \text{ for } \varphi \in H^1_\rho(0,L).$$

Since ρ^{-k} , $k \in \mathbb{N}$, is locally integrable we can conclude that $H^1_{\rho}(0,L)$ is a Banach space, see [20].

• Analogously, $H^1_{\rho^2}(0,L)$ and $H^2_{\rho^2}(0,L)$ are the Banach spaces which contain the functions $\varphi:(0,L)\to\mathbb{R}$ such that

$$H^{1}_{\rho^{2}}(0,L) = \Big\{ \varphi \in H^{1}_{loc}(0,L) \mid \rho^{2}\varphi' \in L^{2}(0,L), \rho\varphi \in L^{2}(0,L) \text{ and } \varphi(0) = 0 \Big\},$$

$$H^2_{\rho^2}(0,L) = \Big\{ \varphi \in H^2_{loc}(0,L) \ \mid \ \rho^2 \varphi'' \in L^2(0,L), \\ \rho \varphi' \in L^2(0,L), \\ \varphi \in L^2(0,L) \text{ and } \varphi(0) = 0 \Big\}.$$

We define their norms to be

$$\|\varphi\|_{H^1_{\rho^2}(0,L)} = \left(\int_0^L [\rho^2(t)\varphi'(t)]^2 dt\right)^{1/2}.$$

$$\|\varphi\|_{H^2_{\rho^2}(0,L)} = \left(\int_0^L [\rho^2(t)\varphi''(t)]^2 dt\right)^{1/2}.$$

We can easily prove that

$$\|\rho\varphi\|_{L^{2}(0,L)} \leq \frac{2L}{3} \|\varphi\|_{H^{1}_{\rho^{2}}(0,L)} \qquad \text{for any } \varphi \in H^{1}_{\rho^{2}}(0,L),$$

$$\|\rho\varphi'\|_{L^{2}(0,L)} \leq \frac{2L}{3} \|\varphi\|_{H^{2}_{\rho^{2}}(0,L)} \qquad \text{for any } \varphi \in H^{2}_{\rho^{2}}(0,L),$$

$$(4.3)$$

then (4.2) yields $\|\varphi\|_{L^2(0,L)} \leq \frac{4L^2}{3} \|\varphi\|_{H^2_{\rho^2}(0,L)}$ for any $\varphi \in H^2_{\rho^2}(0,L)$.

Similarly we define some weighted spaces in the fixed domain Ω

$$\|\phi\|_{H^1_{\rho}(\Omega)} = \left(\int_{\Omega} \left\{ \left(\rho \frac{\partial \phi}{\partial x_3}\right)^2 + \left(\frac{\partial \phi}{\partial X_2}\right)^2 + \left(\frac{\partial \phi}{\partial X_1}\right)^2 + \phi^2 \right\} dX_1 dX_2 dx_3\right)^{1/2}.$$

Proposition 4.2. Let $\{u^{\epsilon}\}_{\epsilon}$ be a sequence of displacements such that $u^{\epsilon} \in H^{1}_{\Gamma_{\epsilon,0}}(\Omega_{\epsilon};\mathbb{R}^{3})$ and

$$\mathcal{R}^{\epsilon} \rightharpoonup \mathcal{R} \text{ weakly in } [H^1_{\rho^2}(0,L)]^3,$$
 (4.7)

$$\frac{1}{\epsilon} \left(\frac{d\mathcal{U}^{\epsilon}}{dx_3} - \mathcal{R}^{\epsilon} \wedge \mathbf{e}_3 \right) \rightharpoonup \mathcal{Z} \text{ weakly in } L^2_{\rho}((0, L); \mathbb{R}^3), \tag{4.8}$$

$$\mathcal{R}(0) = 0, \ \mathcal{U}_{\alpha}(0) = 0, \ \mathcal{U}_{3}(0) = 0.$$

Proof. First we get the weak limits, up to a subsequence still denoted by ϵ , of the different fields. Then we derive a few relations between some of them.

Step 1. The convergences.

Taking into account (4.1)-(4.2) and $(3.1)_2$ - $(3.1)_3$ we have

$$\|\mathcal{U}_{\alpha}^{\epsilon}\|_{H_{\alpha}^{1}(0,L)} \leq C, \qquad \|\mathcal{U}_{3}^{\epsilon}\|_{H_{\alpha}^{1}(0,L)} \leq C\epsilon, \qquad \text{for } \alpha = 1, 2.$$

Then we obtain the following convergences:

$$\mathcal{U}^{\epsilon}_{\alpha} \rightharpoonup \mathcal{U}_{\alpha}$$
 weakly in $H^{1}_{\rho}(0,L)$, for $\alpha = 1, 2$.

$$\frac{1}{\epsilon}\mathcal{U}_3^{\epsilon} \rightharpoonup \mathcal{U}_3$$
 weakly in $H_{\rho}^1(0,L)$.

According to (4.1) we get

$$\|\mathcal{R}_{i}^{\epsilon}\|_{H_{\rho^{2}(0,L)}^{1}} \leq \left\|\rho_{\epsilon}^{2} \frac{d\mathcal{R}_{i}}{dx_{3}}\right\|_{L^{2}(0,L)} \text{ for } i = 1, 2, 3.$$

Due to estimates $(2.4)_3$ and (4.3) we obtain

$$\mathcal{R}^{\epsilon} \rightharpoonup \mathcal{R}$$
 weakly in $[H^1_{\rho^2}(0,L)]^3$.

Again due to (4.1) we have

$$\left\| \frac{d\mathcal{U}^{\epsilon}}{dx_3} - \mathcal{R}^{\epsilon} \wedge \mathbf{e}_3 \right\|_{L^2_{\rho}((0,L);\mathbb{R}^3)} \le \left\| \rho_{\epsilon} \left(\frac{d\mathcal{U}}{dx_3} - \mathcal{R} \wedge e_3 \right) \right\|_{L^2((0,L);\mathbb{R}^3)}.$$

In view of estimate $(2.4)_2$ we get

$$\frac{1}{\epsilon} \left(\frac{d\mathcal{U}^{\epsilon}}{dx_3} - \mathcal{R}^{\epsilon} \wedge \mathbf{e}_3 \right) \rightharpoonup \mathcal{Z} \text{ weakly in } L^2_{\rho}((0,L); \mathbb{R}^3).$$

Thanks to the estimates (3.11) and (3.13) the sequence $\frac{1}{\epsilon^2}\Pi_{\epsilon}(\bar{u}^{\epsilon})$ is bounded in $L^2((0,L); H^1(\omega; \mathbb{R}^3))$. Then we obtain

$$\frac{1}{\epsilon^2} \Pi_{\epsilon}(\bar{u}^{\epsilon}) \rightharpoonup \bar{u} \text{ weakly in } L^2((0,L); H^1(\omega; \mathbb{R}^3)).$$

From property (3.10) of the rescaling operator and the estimate $(3.9)_2$ we have

$$\left\| \Pi_{\epsilon} u_{\alpha}^{\epsilon} \right\|_{L^{2}(\Omega)} = \frac{1}{\epsilon} \left\| \frac{u_{\alpha}^{\epsilon}}{\rho_{\epsilon}} \right\|_{L^{2}(\Omega_{\epsilon})} \le C \frac{L}{\epsilon^{2}} \| (\nabla u)_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \quad \text{for } \alpha = 1, 2.$$

$$(4.16)$$

Moreover, taking into account the derivation rule (3.12) and the estimates $(3.9)_1$ we have

$$\left\| \frac{\partial (\Pi_{\epsilon} u_{\alpha}^{\epsilon})}{\partial X_{\beta}} \right\|_{L^{2}(\Omega)} = \left\| \frac{\partial u_{\alpha}^{\epsilon}}{\partial x_{\beta}} \right\|_{L^{2}(\Omega_{\epsilon})} \le \frac{C}{\epsilon} \| (\nabla u^{\epsilon})_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \text{ for } \alpha, \beta = 1, 2, \tag{4.17}$$

$$\left\| \rho \frac{\partial (\Pi_{\epsilon} u_{\alpha}^{\epsilon})}{\partial x_{3}} \right\|_{L^{2}(\Omega)} \leq \left\| \rho_{\epsilon} \frac{\partial (\Pi_{\epsilon} u_{\alpha}^{\epsilon})}{\partial x_{3}} \right\|_{L^{2}(\Omega)} \leq \frac{C}{L} \left(\left\| \frac{\partial u_{\alpha}^{\epsilon}}{\partial x_{1}} \right\|_{L^{2}(\Omega_{\epsilon})} + \left\| \frac{\partial u_{\alpha}^{\epsilon}}{\partial x_{2}} \right\|_{L^{2}(\Omega_{\epsilon})} \right) + \frac{1}{\epsilon} \left\| \frac{\partial u_{\alpha}^{\epsilon}}{\partial x_{3}} \right\|_{L^{2}(\Omega_{\epsilon})} \\ \leq \frac{C}{\epsilon^{2}} \| (\nabla u^{\epsilon})_{\mathcal{S}} \|_{[L^{2}(\Omega_{\epsilon})]^{9}}, \quad \text{for } \alpha = 1, 2.$$

$$(4.18)$$

Therefore, from (4.16), (4.17) and (4.18) we get

$$\Pi_{\epsilon}(u_{\alpha}^{\epsilon}) \rightharpoonup u_{\alpha}$$
 weakly in $H_{\rho}^{1}(\Omega)$, for $\alpha = 1, 2$.

In the same way, from $(3.9)_1$, $(3.9)_3$ and (3.12) we obtain

$$\left\| \Pi_{\epsilon} u_3^{\epsilon} \right\|_{L^2(\Omega)} \le C \frac{L}{\epsilon} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}, \tag{4.19}$$

$$\left\| \frac{\partial (\Pi_{\epsilon} u_3^{\epsilon})}{\partial X_{\beta}} \right\|_{L^2(\Omega)} \le \frac{C}{\epsilon} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}, \text{ for } \beta = 1, 2,$$

$$(4.20)$$

$$\left\| \rho \frac{\partial (\Pi_{\epsilon} u_3^{\epsilon})}{\partial x_3} \right\|_{L^2(\Omega)} \le \frac{C}{\epsilon} \| (\nabla u)_{\mathcal{S}} \|_{[L^2(\Omega_{\epsilon})]^9}. \tag{4.21}$$

Hence, we get

$$\frac{1}{\epsilon}\Pi_{\epsilon}(u_3^{\epsilon}) \rightharpoonup u_3$$
 weakly in $H^1_{\rho}(\Omega)$.

From the definition of the elementary displacement we have

$$u^{\epsilon}(x) - \mathcal{U}^{\epsilon}(x_3) = \mathcal{R}^{\epsilon}(x_3) \wedge (x_1 \mathbf{e}_1 + x_2 \mathbf{e}_2) + \bar{u}^{\epsilon}(x).$$

Now using the rule of the derivation (3.12) and (3.10) we have for $\alpha = 1, 2$

$$\frac{1}{\epsilon} \left\| \frac{\partial \Pi_{\epsilon}(u^{\epsilon} - \mathcal{U}^{\epsilon})}{\partial X_{\alpha}} \right\|_{L^{2}(\Omega; \mathbb{R}^{3})} = \frac{1}{\epsilon} \left\| \frac{\partial (u^{\epsilon} - \mathcal{U}^{\epsilon})}{\partial x_{\alpha}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \leq \frac{1}{\epsilon} \left\| \mathcal{R}^{\epsilon}(x_{3}) \wedge \mathbf{e}_{\alpha} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} + \frac{1}{\epsilon} \left\| \frac{\partial \bar{u}}{\partial x_{\alpha}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \leq C,$$

$$\frac{1}{\epsilon} \left\| \rho \frac{\partial \Pi_{\epsilon}(u^{\epsilon} - \mathcal{U}^{\epsilon})}{\partial x_{3}} \right\|_{L^{2}(\Omega; \mathbb{R}^{3})} \leq \frac{C}{\epsilon} \left(\sum_{\alpha=1}^{2} \left\| \frac{\partial (u^{\epsilon} - \mathcal{U}^{\epsilon})}{\partial x_{\alpha}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \right) + \frac{1}{\epsilon^{2}} \left\| \frac{\partial (u^{\epsilon} - \mathcal{U}^{\epsilon})}{\partial x_{3}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \\
\leq C + \frac{1}{\epsilon^{2}} \left\| \frac{d\mathcal{R}^{\epsilon}}{dx_{3}} \wedge (x_{1}\mathbf{e}_{1} + x_{2}\mathbf{e}_{2}) \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} + \frac{1}{\epsilon^{2}} \left\| \frac{\partial \bar{u}^{\epsilon}}{\partial x_{3}} \right\|_{L^{2}(\Omega_{\epsilon}; \mathbb{R}^{3})} \leq C.$$

Consequently, from the two above estimates and (4.22) we get the last weak convergence

Now we are going to establish the relations between the weak limits. First consider $(2.4)_2$ which implies

$$(\Pi_{\epsilon}u_{1}^{\epsilon})(X_{1}, X_{2}, x_{3}) = \mathcal{U}_{1}^{\epsilon}(x_{3}) - \epsilon\rho_{\epsilon}X_{2}\mathcal{R}_{3}^{\epsilon}(x_{3}) + (\Pi_{\epsilon}\bar{u}_{1}^{\epsilon})(X_{1}, X_{2}, x_{3}), \text{ for a.e. } (X_{1}, X_{2}, x_{3}) \in \Omega.$$
 (4.24)

In view of (4.5), (4.7), (4.10) and (4.11) by passing to the limit in (4.24) we obtain

$$u_1(X_1, X_2, x_3) = \mathcal{U}_1(x_3)$$
, for a.e. $(X_1, X_2, x_3) \in \Omega$.

Repeating the above arguments for $(\Pi_{\epsilon}u_2^{\epsilon})$ we conclude that

$$u_2(X_1, X_2, x_3) = \mathcal{U}_2(x_3)$$
, for a.e. $(X_1, X_2, x_3) \in \Omega$.

Notice that u_{α} does not depend on the variables (X_1, X_2) , for $\alpha = 1, 2$.

From (3.5) we have for a.e. $(X_1, X_2, x_3) \in \Omega$

$$\frac{1}{\epsilon}(\Pi_{\epsilon}u_3^{\epsilon})(X_1,X_2,x_3) = \frac{1}{\epsilon}\mathcal{U}_3^{\epsilon}(x_3) - \rho_{\epsilon}X_1\mathcal{R}_2^{\epsilon}(x_3) + \rho_{\epsilon}X_2\mathcal{R}_1^{\epsilon}(x_3) + \frac{1}{\epsilon}(\Pi_{\epsilon}\bar{u}_3^{\epsilon})(X_1,X_2,x_3).$$

Now, using (4.6), (4.7), (4.10) and (4.12) we pass to the limit in the equality above and we get

$$u_3(X_1, X_2, x_3) = \mathcal{U}_3(x_3) - \rho X_1 \mathcal{R}_2(x_3) + \rho X_2 \mathcal{R}_1(x_3) \text{ for a.e. } (X_1, X_2, x_3) \in \Omega.$$

Observe that, due to (4.23), (4.25) can be written as

Now we turn to the identification of K_i . In view of (3.5) we have

$$\frac{1}{\epsilon} \Pi_{\epsilon}(u_1^{\epsilon} - \mathcal{U}_1^{\epsilon}) = -\rho_{\epsilon} X_2 \mathcal{R}_3^{\epsilon}(x_3) + \frac{1}{\epsilon} (\Pi_{\epsilon} \bar{u}_1^{\epsilon})(X_1, X_2, x_3), \text{ for a.e. } (X_1, X_2, x_3) \in \Omega.$$
 (4.27)

From (4.7), (4.10), (4.13) by passing to the limit in (4.27) we obtain

$$\mathcal{K}_1(X_1, X_2, x_3) = -\rho(x_3)X_2\mathcal{R}_3(x_3)$$
 for a.e. $(X_1, X_2, x_3) \in \Omega$.

Proceeding as above for $\frac{1}{\epsilon}\Pi_{\epsilon}(u_2^{\epsilon}-\mathcal{U}_2^{\epsilon})$ we get

$$\mathcal{K}_2(X_1, X_2, x_3) = \rho(x_3) X_1 \mathcal{R}_3(x_3)$$
 for a.e. $(X_1, X_2, x_3) \in \Omega$.

Finally we obtain the expression for K_3 . From (3.5) we have

$$\frac{1}{\epsilon} \Pi_{\epsilon}(u_3^{\epsilon} - \mathcal{U}_3^{\epsilon}) = -\rho_{\epsilon} X_1 \mathcal{R}_2^{\epsilon}(x_3) + \rho_{\epsilon} X_2 \mathcal{R}_1^{\epsilon}(x_3) + \frac{1}{\epsilon} (\Pi_{\epsilon} \bar{u}_3^{\epsilon})(X_1, X_2, x_3).$$

Convergences (4.7), (4.10), (4.13) allow to pass to the limit and we get

$$\mathcal{K}_3(X_1, X_2, x_3) = -\rho X_1 \mathcal{R}_2(x_3) + \rho X_2 \mathcal{R}_1(x_3)$$
 for a. e. $(X_1, X_2, x_3) \in \Omega$.

Equivalently, from (4.23) we have

$$\mathcal{K}_3(X_1, X_2, x_3) = -\rho X_1 \frac{d\mathcal{U}_1}{dx_3}(x_3) - \rho X_2 \frac{d\mathcal{U}_2}{dx_3}(x_3) \text{ for a.e. } (X_1, X_2, x_3) \in \Omega.$$

Remark 4.3. It is worth to note that the limit displacement fields is a kind of Bernoulli-Navier displacement.

Also observe that the limit warping \bar{u} verifies the following conditions:

$$\Pi_{\epsilon}(\nabla u^{\epsilon}) \rightharpoonup Z \text{ weakly in } [L^{2}_{\rho}(\Omega)]^{9}, \qquad \frac{1}{\epsilon} \Pi_{\epsilon}((\nabla u^{\epsilon})_{\mathcal{S}}) \rightharpoonup T \text{ weakly in } [L^{2}_{\rho}(\Omega)]^{9},$$
 (4.29)

where

$$Z = \begin{pmatrix} 0 & -\mathcal{R}_3 & \mathcal{R}_2 \\ \mathcal{R}_3 & 0 & -\mathcal{R}_1 \\ -\mathcal{R}_2 & \mathcal{R}_1 & 0 \end{pmatrix}, \quad T = \begin{pmatrix} \frac{\partial \bar{u}_1}{\partial X_1} & \frac{1}{2} \left(\frac{\partial \bar{u}_1}{\partial X_2} + \frac{\partial \bar{u}_2}{\partial X_1} \right) & \frac{1}{2} \left(-\rho^2 X_2 \frac{d\mathcal{R}_3}{dx_3} + \frac{\partial \tilde{u}_3}{\partial X_1} \right) \\ * & \frac{\partial \bar{u}_2}{dX_2} & \frac{1}{2} \left(\rho^2 X_1 \frac{d\mathcal{R}_3}{dx_3} + \frac{\partial \tilde{u}_3}{\partial X_2} \right) \\ * & * & \rho \frac{d\mathcal{U}_3}{dx_3} - \rho^2 X_1 \frac{d\mathcal{R}_2}{dx_3} + \rho^2 X_2 \frac{d\mathcal{R}_1}{dx_3} \end{pmatrix}.$$

$$\frac{1}{\epsilon} \Pi_{\epsilon} \left(\frac{\partial \bar{u}_{j}^{\epsilon}}{\partial x_{3}} \right) \rightharpoonup 0 \text{ weakly in } L_{\rho}^{2}(\Omega), \text{ for } j = 1, 2, 3.$$
 (4.31)

• Since \mathcal{U}^{ϵ} and \mathcal{R}^{ϵ} are independent of x_1 and x_2 we have

$$\Pi_{\epsilon}(\mathcal{R}^{\epsilon}) = \mathcal{R}^{\epsilon}, \quad \Pi_{\epsilon}(x_{\alpha}\mathcal{R}^{\epsilon}) = \epsilon \rho_{\epsilon} X_{\alpha} \mathcal{R}^{\epsilon}, \text{ for } \alpha = 1, 2, \quad \Pi_{\epsilon}\left(\frac{d\mathcal{U}^{\epsilon}}{dx_{3}}\right) = \frac{d\mathcal{U}^{\epsilon}}{dx_{3}}.$$

Then in view of (4.5), (4.6), (4.7) and (4.14) we obtain

$$\begin{split} &\Pi_{\epsilon}(\mathcal{R}^{\epsilon}) \rightharpoonup \mathcal{R} \text{ weakly in } [L_{\rho}^{2}(\Omega)]^{3}, \\ &\Pi_{\epsilon}(x_{\alpha}\mathcal{R}^{\epsilon}) \rightarrow 0 \text{ strongly in } [L_{\rho}^{2}(\Omega)]^{3}, \text{ for } \alpha = 1, 2, \\ &\Pi_{\epsilon}\Big(\frac{d\mathcal{U}_{\alpha}^{\epsilon}}{dx_{3}}\Big) \rightharpoonup \frac{d\mathcal{U}_{\alpha}}{dx_{3}} = (-1)^{3-\alpha}\mathcal{R}_{3-\alpha} \text{ weakly in } L_{\rho}^{2}(\Omega), \text{ for } \alpha = 1, 2, \\ &\Pi_{\epsilon}\Big(\frac{d\mathcal{U}_{\alpha}^{\epsilon}}{dx_{3}}\Big) \rightarrow 0 \text{ strongly in } L_{\rho}^{2}(\Omega). \end{split}$$

Step 2. Determination of the matrix T.

From (3.12) we have

$$\frac{1}{\epsilon} \Pi_{\epsilon} \left(\frac{\partial \bar{u}^{\epsilon}}{\partial x_{\alpha}} \right) = \frac{1}{\epsilon^{2} \rho_{\epsilon}} \frac{\partial (\Pi_{\epsilon} \bar{u}^{\epsilon})}{\partial X_{\alpha}} \text{ for } \alpha = 1, 2.$$

Then in view of (3.8) and using convergence (4.10) we obtain

$$T_{\alpha\beta} = \frac{1}{2} \left(\frac{\partial \bar{u}_{\alpha}}{\partial X_{\beta}} + \frac{\partial \bar{u}_{\beta}}{\partial X_{\alpha}} \right) \text{ for } \alpha, \beta = 1, 2.$$

Applying the rescaling operator to (3.8) we get

$$\frac{\rho}{\epsilon} \Pi_{\epsilon} \left((\nabla u^{\epsilon})_{\mathcal{S}} \right)_{13} = \frac{1}{2} \left[\frac{\rho}{\epsilon} \left(\frac{d\mathcal{U}_{1}^{\epsilon}}{dx_{3}} - \mathcal{R}_{2}^{\epsilon} \right) - \rho \rho_{\epsilon} X_{2} \frac{d\mathcal{R}_{3}^{\epsilon}}{dx_{3}} + \frac{\rho}{\rho_{\epsilon}} \frac{1}{\epsilon^{2}} \frac{\partial (\Pi_{\epsilon} \bar{u}_{3}^{\epsilon})}{\partial X_{1}} + \frac{\rho}{\epsilon} \Pi_{\epsilon} \left(\frac{\partial \bar{u}_{1}^{\epsilon}}{\partial x_{3}} \right) \right].$$

Convergences (4.7), (4.8), (4.10) and (4.31) allow us to pass to the limit and we obtain

$$T_{13} = \frac{1}{2} \left(\rho \mathcal{Z}_1 - \rho^2 X_2 \frac{d\mathcal{R}_3}{dx_3} + \frac{\partial \bar{u}_3}{\partial X_1} \right) = \frac{1}{2} \left(-\rho^2 X_2 \frac{d\mathcal{R}_3}{dx_3} + \frac{\partial \tilde{u}_3}{\partial X_1} \right).$$

Similar calculations which are not repeated here allows us to get

5. Position of the elastic problem

6. The limit problems

In this section we obtain the equations satisfied by the limit fields \mathcal{U} , \mathcal{R} and \bar{u} . To do this, we assume that the forces are given by (5.5) and satisfy (5.6)-(5.7). First, we apply the rescaling operator Π_{ϵ} to the original variational formulation of the problem (5.2)

+ \int_{\omega} \left\{ \mu \frac{\partial \phi_{3}}{\partial X_{1}} \left(-\rho^{2} X_{2} \frac{d\mathcal{R}_{3}}{dx_{3}} + \frac{\partial \tilde{u}_{3}}{\partial X_{1}} \right) + \mu \frac{\partial \phi_{3}}{\partial X_{2}} \left(\rho^{2} X_{1} \frac{d\mathcal{R}_{3}}{dx_{3}} + \frac{\partial \tilde{u}_{3}}{\partial X_{2}} \right) \right\} dX_{1} dX_{2} = 0$$
(6.7)

6.1.1. Determination of \tilde{u}_3

First, we choose $\phi_1 = \phi_2 = 0$. In view of (6.7) we have

where $E = \frac{\mu(3\lambda + 2\mu)}{\lambda + \mu}$ is the Young's modulus of the elastic material.

In this step we derive the equation satisfied by \mathcal{U}_3 . 6.4. Convergence of the total elastic energy

In the above subsections all the limit problems admit a unique solution. As a consequence the whole sequences $\left\{\frac{1}{\epsilon^2}\overline{u}^\epsilon\right\}_\epsilon$, $\left\{\mathcal{U}^\epsilon_\alpha\right\}_\epsilon$, $\left\{\frac{1}{\epsilon}\mathcal{U}^\epsilon_3\right\}_\epsilon$ and $\left\{\mathcal{R}^\epsilon_3\right\}_\epsilon$ converge weakly to their limit.

In this subsection we prove that the rescaled energy $\frac{\mathcal{E}(u^{\epsilon})}{\epsilon^4}$ converges to the elastic limit energy as ϵ tends to zero and that some weak convergences are in fact strong convergences.

Lemma 6.1. Under the assumptions (5.5), (5.6) and (5.7) on the applied forces, we obtain the following convergence for the total elastic energy

$$= |\omega| \int_{(0,L)} \rho^{2} f \cdot \mathcal{U} dx_{3} + (I_{1} + I_{2}) \int_{(0,L)} \rho^{4} g_{3} \mathcal{R}_{3} dx_{3}$$

$$-I_{1} \int_{(0,L)} \rho^{4} g_{1} \frac{d\mathcal{U}_{1}}{dx_{3}} dx_{3} - I_{2} \int_{(0,L)} \rho^{4} g_{2} \frac{d\mathcal{U}_{2}}{dx_{3}} dx_{3}. \tag{6.27}$$

Besides, since T is a symmetric matrix we know that it verifies the following algebraic identity

$$\lambda Tr(T)Tr(T) + \sum_{i,j=1}^{3} 2\mu T_{ij}T_{ij} = ET_{33}^{2} + \frac{E}{(1+\nu)(1-2\nu)}(T_{11} + T_{22} + 2\nu T_{33})^{2} + \frac{E}{2(1+\nu)}[(T_{11} - T_{22})^{2} + 4(T_{12}^{2} + T_{13}^{2} + T_{23}^{2})].$$

Then, in view of (2.1), (4.32), (6.11), (6.16) and (6.9) we have

$$\int_{\Omega} \lambda Tr(T) Tr(T) + \sum_{i,j=1}^{3} 2\mu T_{ij} T_{ij} dX_{1} dX_{2} dx_{3} = E \int_{\Omega} \rho^{2} \left(\frac{d\mathcal{U}_{3}}{dx_{3}}\right)^{2} dX_{1} dX_{2} dx_{3}
+ E \int_{0}^{L} \rho^{4} \left(I_{1} \left(\frac{d\mathcal{R}_{2}}{dx_{3}}\right)^{2} + I_{2} \left(\frac{d\mathcal{R}_{1}}{dx_{3}}\right)^{2}\right) dX_{1} dX_{2} dx_{3} + \frac{K\mu}{2} \int_{0}^{L} \rho^{4} \left(\frac{d\mathcal{R}_{3}}{dx_{3}}\right)^{2} dx_{3}
= E|\omega| \int_{\Omega} \rho^{2} \left(\frac{d\mathcal{U}_{3}}{dx_{3}}\right)^{2} dx_{3} + \sum_{\alpha=1}^{2} EI_{\alpha} \int_{(0,L)} \rho^{4} \left(\frac{d^{2}\mathcal{U}_{\alpha}}{dx_{3}^{2}}\right)^{2} dx_{3} + \frac{K\mu}{2} \int_{(0,L)} \rho^{4} \left(\frac{d\mathcal{R}_{3}}{dx_{3}}\right)^{2} dx_{3}.$$
(6.28)

We recall that

$$E|\omega| \int_{\Omega} \rho^{2} \left(\frac{d\mathcal{U}_{3}}{dx_{3}}\right)^{2} dx_{3} + \sum_{\alpha=1}^{2} EI_{\alpha} \int_{(0,L)} \rho^{4} \left(\frac{d^{2}\mathcal{U}_{\alpha}}{dx_{3}^{2}}\right)^{2} dx_{3} + \frac{K\mu}{2} \int_{(0,L)} \rho^{4} \left(\frac{d\mathcal{R}_{3}}{dx_{3}}\right)^{2} dx_{3}$$

$$= |\omega| \int_{(0,L)} \rho^{2} f \cdot \mathcal{U} dx_{3} - \sum_{\alpha=1}^{2} I_{\alpha} \int_{(0,L)} \rho^{4} g_{\alpha} \frac{d\mathcal{U}_{\alpha}}{dx_{3}} dx_{3} + (I_{1} + I_{2}) \int_{(0,L)} \rho^{4} g_{3} \mathcal{R}_{3} dx_{3}.$$

Finally we obtain

$$\lim_{\epsilon \to 0} \frac{\mathcal{E}(u^{\epsilon})}{\epsilon^4} = \int_{\Omega} \left\{ \lambda Tr(T) Tr(T) + \sum_{i,j=1}^{3} 2\mu T_{ij} T_{ij} \right\} dX_1 dX_2 dx_3,$$

which gives us the convergence of the rescaled energy to the total energy of the problems (6.23), (6.24) and (6.22) as ϵ goes to zero.

Now we can deduce the strong convergences of the fields of the displacement decomposition using the strong convergence of the energy. In view of the weak convergence of the symmetric gradient (4.29), the strict convexity of the elastic energy implies that the convergence of the symmetric gradient is strong

$$\frac{1}{\epsilon} \Pi_{\epsilon} ((\nabla u^{\epsilon})_{\mathcal{S}}) \to T \text{ strongly in } [L^{2}_{\rho}(\Omega)]^{9}.$$
(6.29)

As a consequence we get

$$\frac{\rho}{\epsilon} \Pi_{\epsilon} ((\nabla u^{\epsilon})_{\mathcal{S}})_{33} = \frac{\rho}{\epsilon} \frac{d\mathcal{U}_{3}^{\epsilon}}{dx_{3}} - \rho \rho_{\epsilon} X_{1} \frac{d\mathcal{R}_{2}^{\epsilon}}{dx_{3}} + \rho \rho_{\epsilon} X_{2} \frac{d\mathcal{R}_{1}^{\epsilon}}{dx_{3}} + \frac{\rho}{\epsilon} \Pi_{\epsilon} (\frac{\partial \bar{u}_{3}^{\epsilon}}{\partial x_{3}})$$

$$\rightarrow T_{33} = \rho \frac{d\mathcal{U}_3}{dx_3} - \rho^2 X_1 \frac{d\mathcal{R}_2}{dx_3} + \rho^2 X_2 \frac{d\mathcal{R}_1}{dx_3} \text{ strongly in } L^2(\Omega).$$
 (6.30)

Moreover, using $\int_{\omega} \Pi_{\epsilon}(\bar{u}_{3}^{\epsilon}) dX_{1}dX_{2} = \int_{\omega} X_{\alpha}\Pi_{\epsilon}(\bar{u}_{3}^{\epsilon}) dX_{1}dX_{2} = 0$, for $\alpha \in \{1,2\}$, and taking into account convergence (4.30) we may deduce from (6.30) that

$$\frac{\rho}{\epsilon} \frac{d\mathcal{U}_{3}^{\epsilon}}{dx_{3}} \to \rho \frac{d\mathcal{U}_{3}}{dx_{3}}, \quad \rho^{2} \frac{d\mathcal{R}_{\alpha}^{\epsilon}}{dx_{3}} \to \rho^{2} \frac{d\mathcal{R}_{\alpha}}{dx_{3}}, \text{ strongly in } L^{2}(0, L), \ (\alpha = 1, 2), \tag{6.31}$$

as ϵ tends to zero. Then, in view of the weak convergences (4.6) and (4.7), (6.31) implies that

$$\frac{1}{\epsilon} \mathcal{U}_3^{\epsilon} \to \mathcal{U}_3 \text{ strongly in } H^1_{\rho}(0, L), \tag{6.32}$$

$$\mathcal{R}^{\epsilon}_{\alpha} \to \mathcal{R}_{\alpha} \text{ strongly in } H^{1}_{\rho^{2}}(0, L), \quad \text{for } \alpha = 1, 2.$$
 (6.33)

Moreover, from (4.8) and (6.33) we have

$$\mathcal{U}^{\epsilon}_{\alpha} \to \mathcal{U}_{\alpha}$$
 strongly in $H^{1}_{\rho}(0,L)$, for $\alpha = 1, 2$.

Hence, due to the decomposition (3.5) and the previous strong convergences we deduce

$$\Pi_{\epsilon}(u_{\alpha}^{\epsilon}) \to \mathcal{U}_{\alpha}$$
 strongly in $H_{\rho}^{1}(\Omega)$, for $\alpha = 1, 2$.

$$\frac{1}{\epsilon} \Pi_{\epsilon}(u_{3}^{\epsilon}) \to \mathcal{U}_{3} - \rho X_{1} \frac{d\mathcal{U}_{1}}{dx_{3}} - \rho X_{2} \frac{d\mathcal{U}_{2}}{dx_{3}}$$
 strongly in $H_{\rho}^{1}(\Omega)$.

We also have

$$\frac{1}{\epsilon^2}\gamma_{\alpha\beta}\left(\Pi_{\epsilon}\bar{u}^{\epsilon}\right) \to \gamma_{\alpha\beta}(\bar{u}) \text{ strongly in } L^2(\Omega), \text{ for } \alpha, \beta = 1, 2.$$

We recall that the warping functions satisfy (4.28). Then from the 2d Korn inequality we derive

$$\sum_{\alpha=1}^{2} \left\| \frac{1}{\epsilon^{2}} \Pi_{\epsilon} \left(\bar{u}_{\alpha}^{\epsilon} \right) - \bar{u}_{\alpha} \right\|_{L^{2}(\Omega)} + \sum_{\alpha\beta=1}^{2} \left\| \frac{1}{\epsilon^{2}} \frac{\partial \Pi_{\epsilon} \left(\bar{u}_{\alpha}^{\epsilon} \right)}{\partial X_{\beta}} - \frac{\partial \bar{u}_{\alpha}}{\partial X_{\beta}} \right\|_{L^{2}(\Omega)} \leq C \sum_{\alpha\beta=1}^{2} \left\| \frac{1}{\epsilon^{2}} \gamma_{\alpha\beta} \left(\Pi_{\epsilon} \bar{u}^{\epsilon} \right) - \gamma_{\alpha\beta} (\bar{u}) \right\|_{L^{2}(\Omega)}.$$

That leads to

$$\frac{1}{\epsilon^2} \Pi_{\epsilon} (\bar{u}_{\alpha}^{\epsilon}) \to \bar{u}_{\alpha} \text{ strongly in } L^2((0,L); H^1(\omega)), \text{ for } \alpha = 1, 2.$$

7. Conclusion

In this last section we summarize the results obtained in the previous sections.

Theorem 7.1. Let u^{ϵ} be the solution of the elasticity problem (5.2). Under the assumptions (5.5)-(5.7) on the applied forces, the sequence $\{u^{\epsilon}\}$ satisfies the following convergences

$$\Pi_{\epsilon}(u_{\alpha}^{\epsilon}) \to \mathcal{U}_{\alpha} \text{ strongly in } H_{\rho}^{1}(\Omega), \text{ for } \alpha = 1, 2,$$

$$\frac{1}{\epsilon} \Pi_{\epsilon}(u_{3}^{\epsilon}) \to \mathcal{U}_{3} - \rho X_{1} \frac{d\mathcal{U}_{1}}{dx_{3}} - \rho X_{2} \frac{d\mathcal{U}_{2}}{dx_{3}} \text{ strongly in } H_{\rho}^{1}(\Omega),$$

where \mathcal{U}_{α} is the solution of the bending problem (6.23) and \mathcal{U}_3 is the weak solution of the stretching problem (6.24). Moreover, we have

$$\frac{1}{\epsilon} \Pi_{\epsilon} (\gamma_{ij}(u^{\epsilon})) \to T_{ij} \text{ strongly in } L^{2}_{\rho}(\Omega), \text{ for } i, j = 1, 2, 3.$$

where

$$T_{11} = T_{22} = -\nu T_{33}, \qquad T_{33} = \rho \frac{d\mathcal{U}_3}{dx_3} - \rho^2 X_1 \frac{d^2 \mathcal{U}_1}{dx_3^2} - \rho^2 X_2 \frac{d^2 \mathcal{U}_2}{dx_3^2},$$

$$T_{12} = 0, \qquad T_{13} = \left(-X_2 + \frac{\partial \chi}{\partial X_1}\right) \frac{\rho^2}{2} \frac{d\mathcal{R}_3}{dx_3}, \qquad T_{23} = \left(X_1 + \frac{\partial \chi}{\partial X_2}\right) \frac{\rho^2}{2} \frac{d\mathcal{R}_3}{dx_3},$$

with $\chi \in H^1(\omega)$ is the solution of the torsion problem (6.9) and \mathcal{R}_3 the weak solution of (6.22).
