Geometric optics expansions for hyperbolic corner problems II : huge amplification phenomenon.

Abstract

In this article we are interested in the rigorous construction of geometric optics expansions for weakly well-posed hyperbolic corner problems. More precisely we focus on the case where selfinteracting phases occur and are exactly the phases where the uniform Kreiss-Lopatinskii condition fails. We then show that the associated WKB expansion suffers arbitrarily many amplifications in a fixed finite time. As a consequence, we show that this corner problem can not be well-posed even at the price of a huge loss of derivatives. The new result, in that framework, is that the violent instability does not come from the failure of the weak Kreiss-Lopatinskii condition, but of the accumulation of arbitrarily many weak instabilities.

1 Introduction

The may study in this article is the rigorous construction of geometric optics expansions for hyperbolic corner problem that is to say, problems that read:

$$\begin{cases}
L(\partial)u := \partial_t u + A_1 \partial_1 u + A_2 \partial_2 u = f, & \text{for } x_1, x_2 > 0 \\
B_1 u_{|x_1=0} = g_1, & \text{on } x_1 > 0, \\
B_2 u_{|x_2=0} = g_2, & \text{on } x_2 > 0, \\
u_{|t \le 0} = 0,
\end{cases}$$
(1)

where the matrices $A_i \in \mathbf{M}_N(\mathbb{R})$ and where $B_i \in \mathbf{M}_{p_i \times N}(\mathbb{R})$ (the values of p_1 and p_2 will be made precise in Assumption 2.2).

Such expansions, under the uniform Kreiss-Lopatinskii condition (that is to say the necessary and sufficient condition for the well-posedness of the hyperbolic boundary value problem in the half

space (see [Kre70] for more details) have already been studied in [SS75] and more recently by the author in [Ben15] and [Ben]. More precisely in [SS75] the authors give precious intuitions and some elements of proof about this construction which are used in [Ben15]-[Ben] to construct rigorously the expansions.

In particular, a new phenomenon, proper to the corner problem, has been investigated. That is to say the selfinteraction phenomenon. In more details, this phenomenon induces that some phases in the WKB expansion can generate themselves after a suitable number of rebounds on the sides of the corner (see [Ben15]-[Ben] about this phenomenon). On one hand, in terms of the geometry of the characteristic variety, such systems contain a rectangle whose corners are elements of the characteristic variety (whith suitable group velocities) and whose side are parallel to the axis. On the other hand, in terms of the resolution of the WKB cascade, a new amplitude equation, whose provenance is intrinsically linked with the uniform Kreiss-Lopatinskii condition has to be solved to initialize the resolution.

We are here interested in corner problems whose, one of the boundary condition, to fix the ideas, let us say B_1 , does not satisfy the uniform Kreiss-Lopatinskii condition (the other boundary condition is assumed to be as "nice" as possible, that is it satisfies the uniform Kreiss-Lopatinskii condition or even it is strictly dissipative see [BGS07]). The litterature tells us that there are four possible kinds of degeneracy of the uniform Kreiss-Lopatinskii condition relying on the structure of the resolvent matrix where the uniform Kreiss-Lopatinskii condition breaks down (see Definition 2.1). Namely, the degeneracies of the uniform Kreiss-Lopatinskii condition can occur in the so-called hyperbolic, elliptic, mixed or glancing regions.

Concerning boundary value problems in the half space for which the uniform Kreiss-Lopatinskii condition is violated, the construction of the associated geometric has already been made for three of the four possible cases. We refer to [CG10] for the construction when the degeneracy takes place in the hyperbolic region and to [Ben14] and [Mar10] for the construction associated to a degeneracy in the elliptic or in the mixed region.

We will here focus our attention on a degeneracy of the uniform Kreiss-Lopatinskii condition in the hyperbolic region, that is to say to problems in the WR class in the sense of [BGRSZ02]. Some conjectures about the behaviours of the geometric optics expansions when the degeneracy of the uniform Kreiss-Lopatinskii condition occurs in the elliptic or in the mixed region can be found in paragraph 7.

In [CG10], the authors construct the geometric optics expansions for such WR problems in the half space and show that if the source terms are in order one compared to the small parameter ε which encodes the high oscillating behaviour, then the leading term in the geometric optics expansion is of order zero compared to ε . Then, they used this construction to show that the energy estimate with losses of derivatives established by [Cou05]:

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u_{|x_{1}=0}||_{L^{2}(\Omega_{T})}^{2} \leq C_{T} \left(||f||_{L^{2}_{x_{1}}(H^{1}(\partial\Omega_{1,T}))}^{2} + ||g_{1_{|x_{1}=0}}||_{(H^{1}(\partial\Omega_{1,T}))}^{2} \right),$$

is sharp in term of losses.

Concerning corner problems, the litterature is much more poor. Indeed, the full characterization of strongly well-posed problems is, to our knowledge, not achieved yet. So, the full characterization of weakly well-posed corner problems seems, in the author opinion, to be a long range problem. As

a consequence, the fact that we construct the geometric optics expansions for these (expected to be) weakly well-posed problems can be seen as a "Majda's project" (see [Maj83b] and [Maj83a]). That is to say, that the author belivies that the use of geometric optics expansions can give some intuition about what can be the good number of losses of derivatives in the associated corner problems.

In this article, we will focus our attention on the particular case of corner problems in the WR class whose section of the characteristic variety contains a loop. For those problems, it has been shown (see [Ben]) that some phases, namely the selfinteracting ones are generated by themselves after a suitable number of reflection on the boundary of the quarter space. In term of wave packet reflection, we thus have to consider a sequence of wave packets which is trapped by the corner.

We will also assume that one of the frequencies for which the uniform Kreiss-Lopatinskii condition breaks down is associated to such a selfinteracting phases. Our purpose is thus to construct the geometric optics expansion for the associated problem. As we will see in section 5, for any arbitrarily big $M \in \mathbb{N}$, the fact that the phase for which the uniform Kreiss-Lopatinskii condition breaks down is generated an arbitrarily number of times will imply a leading term in the geometric optics expansion of order zero, compared with the small parameter ε , when one consider a source term on the boundary $\{x_1 = 0\}$ of order M + 1 in terms of ε .

Using this geometric optics expansion, we will show that such a corner problem can not be (even weakly) well-posed on a finite interval of time because it losses an arbitrarily big number of derivatives. In term of losses of derivatives, it is the worst case that we can imagine.

The paper is organized as follows: in Section 2, we give some classical definitions and introduce some notations. In Section 3 we give a formal study of our problem and we describe what are the expected phases and there amplitudes in the WKB expansion. Then in Section 4, we give a general framework in which the previous formal discussion becomes rigorous. This section uses the same tools as these introduced in [Ben] to describe, with precision, the set of expected phases in the WKB expansion. However, we believed that it was important to recall these tools for a sake of completness.

Section 5 is devoted to the construction of the geometric optics expansion. The most difficult part of the construction is to find a way to initialize the resolution of the WKB cascade of equations. Indeed in [Ben] the new amplitude equation whose resolution permits to initialize the WKB expansion was, as already mentionned, intrinsically linked with the uniform Kreiss-Lopatinskii condition. As a consequence to initialize the resolution of the WKB cascade, we need a new amplitude equation. This equation comes from an adaptation of the method described in [CG10]. The hard point to handle with is that in [CG10], due to the "nice" geometry of the half space, it was possible to determine all the outgoing phases (which act as source terms in the equation determining the amplitude for which the uniform Kreiss-Lopatinskii breaks down) before all the others. However, this is not true anymore in the quarter space geometry. But we found a new equation for the initialization of the WKB, it is given in paragraph 5.1. The resolution of this equation is made in subparagraphs 5.1.4 and 5.1.6. The resolution is made after a "necessary" reformulation of this equation, in view to show that this equation can in fact be rewritten under the particular form $(I - \tilde{\mathbb{T}})u = G$, for some operator $\tilde{\mathbb{T}}$. This rewrite is made in paragraph 5.1.2.

Section 6 contains the proof of our main result, that is that a corner problem in the WR class for one side which admits a loop in the section of its characteristic variety and for which one of the element of the loop violates the uniform Kreiss-Lopatinskii condition can not be (even) weakly well-posed. It is not really a merry result because it tell us that, in such a framework, there is no hope to solve the corner problem. However, we believe that this result is interesting in itself because

it gives the first examples, in our knowledge, of ill-posed hyperbolic boundary value problems for which the ill-posedness is due to the accumulation of weak instabilities and not to the failure of the weak Kreiss-Lopatinskii condition. Moreover the instability phenomenon in this framework is much more sneaky.

At last, Section 7 gives examples of such ill-posed corner problems and some (more optimistic) conjectures about what should be the leading orders sizes of the geometric optics expansions (and so the number of losses of derivatives) in the more favorable cases where the uniform Kreiss-Lopatinskii condition breaks down outside the loop.

2 Notations and assumptions

2.1 About the operator $L(\partial)$.

Let

$$\Omega := \left\{ (x_1, x_2) \in \mathbb{R}^2 \setminus x_1 \ge 0, x_2 \ge 0 \right\}, \ \partial \Omega_1 := \Omega \cap \left\{ x_1 = 0 \right\}, \ \text{and} \ \partial \Omega_2 := \Omega \cap \left\{ x_2 = 0 \right\},$$

be the quarter space and both of its edges. For T > 0, we will denote:

$$\Omega_T :=]-\infty, T] \times \Omega, \ \partial \Omega_{1,T} :=]-\infty, T] \times \partial \Omega_1, \ \text{and} \ \partial \Omega_{2,T} :=]-\infty, T] \times \partial \Omega_2.$$

Hereof \mathscr{L} will denote the symbol of the differential operator $L(\partial)$. It is defined for $\tau \in \mathbb{R}$ and $\xi \in \mathbb{R}^2$ by :

$$\mathscr{L}(\tau,\xi) := \tau I + \sum_{j=1}^{2} \xi_j A_j.$$

The characteristic variety V of $L(\partial)$ is thus given by :

$$V:=\left\{(\tau,\xi)\in\mathbb{R}\times\mathbb{R}^2\setminus\det\mathscr{L}(\tau,\xi)=0\right\}.$$

In this article we choose to restrict our subject, in view to save some notations, to strictly hyperbolic operators. The following constructions of the geometric optics expansions should also operate in the framework of constantly hyperbolic operators. However this simplifying assumption will make the analysis of Section 5 slightly easier. We will give in the core of the proof some comments about the expected modifications about the proof for constantly hyperbolic operators. We thus assume the following property on $L(\partial)$:

Assumption 2.1 There exist N real valued functions, denoted by λ_j , analytic on $\mathbb{R}^2 \setminus \{0\}$ such that:

$$\forall \xi \in \mathbb{S}^1, \det \mathcal{L}(\tau, \xi) = \prod_{j=1}^N (\tau + \lambda_j(\xi)),$$

where the eigenvalues $\lambda_j(\xi)$ satisfy $\lambda_1(\xi) < ... < \lambda_N(\xi)$.

We also assume that the boundary of Ω is non-characteristic, and that the matrices B_1 and B_2 induce the good number of boundary conditions, that is to say:

Assumption 2.2 The matrices A_1 , A_2 are invertible. Moreover p_1 (resp. p_2), the number of lines of B_1 (resp. B_2), equals the number of strictly positive eigenvalues of A_1 (resp. A_2). At last B_1 and B_2 are assumed to be of maximal rank.

Under Assumption 2.2, we can define the resolvent matrices:

$$\mathscr{A}_1(\zeta) := -A_1^{-1} (\sigma I + i\eta A_2) \text{ and } \mathscr{A}_2(\zeta) := -A_2^{-1} (\sigma I + i\eta A_1),$$

where ζ denotes an element of the frequency space :

$$\Xi := \{ \zeta := (\sigma = \gamma + i\tau, \eta) \in \mathbb{C} \times \mathbb{R}, \gamma \ge 0 \} \setminus \{ (0, 0) \}.$$

For convenience, we also introduce Ξ_0 the boundary of Ξ :

$$\Xi_0 := \Xi \cap \{\gamma = 0\}.$$

and the notation:

for
$$j = 1, 2, \zeta_j := (\sigma, \xi_{3-j}),$$

For $j=1,2,\,\zeta_j\in(\Xi\setminus\Xi_0)$, we denote by $E^s_j(\zeta_j)$ the stable subspace of $\mathscr{A}_j(\zeta_j)$ and $E^u_j(\zeta_j)$ its unstable subspace. These spaces are well-defined according to [Her63]. For all $\zeta_j\in(\Xi\setminus\Xi_0)$, the stable subspace $E^s_j(\zeta_j)$ has dimension p_j , while $E^u_j(\zeta)$ has dimension $N-p_j$. Let us recall the following theorem due to Kreiss [Kre70]¹:

Theorem 2.1 Under Assumptions 2.1 and 2.2, for all $\underline{\zeta} \in \Xi$, there exists a neighborhood $\mathscr V$ of $\underline{\zeta}$ in Ξ , integers $L_1, L_2 \geq 1$, two partitions $N = \nu_{1,1} + ... + \nu_{1,L_1} = \nu_{2,1} + ... + \nu_{2,L_2}$ with $\nu_{1,l}, \nu_{2,l} \geq 1$, and two invertible matrices T_1, T_2 , regular on $\mathscr V$ such that :

$$\forall \zeta \in \mathscr{V}, \quad T_1(\zeta)^{-1} \mathscr{A}_1(\zeta) T_1(\zeta) = diag\left(\mathscr{A}_{1,1}(\zeta), ..., \mathscr{A}_{1,L_1}(\zeta)\right),$$
$$T_2(\zeta)^{-1} \mathscr{A}_2(\zeta) T_2(\zeta) = diag\left(\mathscr{A}_{2,1}(\zeta), ..., \mathscr{A}_{2,L_2}(\zeta)\right),$$

where the blocks $\mathcal{A}_{j,l}(\zeta)$ have size $\nu_{j,l}$ and satisfy one of the following alternatives:

- i) All the elements in the spectrum of $\mathcal{A}_{i,l}(\zeta)$ have positive real part.
- ii) All the elements in the spectrum of $\mathscr{A}_{i,l}(\zeta)$ have negative real part.
- iii) $\nu_{j,l} = 1$, $\mathscr{A}_{j,l}(\zeta) \in i\mathbb{R}$, $\partial_{\gamma}\mathscr{A}_{j,l}(\zeta) \in \mathbb{R} \setminus \{0\}$, and $\mathscr{A}_{j,l}(\zeta) \in i\mathbb{R}$ for all $\zeta \in \mathscr{V} \cap \Xi_0$.
- iv) $\nu_{i,l} > 1$, $\exists k_{i,l} \in i\mathbb{R}$ such that

$$\mathscr{A}_{j,l}(\underline{\zeta}) = egin{bmatrix} k_{j,l} & i & 0 \ & \ddots & i \ 0 & & k_{j,l} \end{bmatrix},$$

the coefficient in the lower left corner of $\partial_{\gamma}\mathscr{A}_{j,l}(\underline{\zeta})$ is real and non-zero, and moreover $\mathscr{A}_{j,l}(\zeta) \in i\mathbf{M}_{\nu_{j,l}}(\mathbb{R})$ for all $\zeta \in \mathscr{V} \cap \Xi_0$.

Thanks to this Theorem it is possible to describe the four kinds of frequencies, for each part of the boundary $\partial\Omega$:

Definition 2.1 For j = 1, 2, we denote by :

- 1) \mathcal{E}_j the set of elliptic frequencies, that is to say the set of $\underline{\zeta} \in \Xi_0$ such that Theorem 2.1 for the matrix $\mathscr{A}_j(\zeta)$ is satisfied with one block of type i) and one block of type ii) only.
- 2) \mathscr{H}_j the set of hyperbolic frequencies, that is to say the set of $\underline{\zeta} \in \Xi_0$ such that Theorem 2.1 for the matrix $\mathscr{A}_j(\zeta)$ is satisfied with blocks of type iii) only.
- 3) \mathscr{EH}_j the set of mixed frequencies, that is to say the set of $\underline{\zeta} \in \Xi_0$ such that Theorem 2.1 for the matrix $\mathscr{A}_j(\underline{\zeta})$ is satisfied with one block of type i), one of type ii) and at least one of type iii), but without block of type iv).

¹For constantly (resp. geometrically regular) hyperbolic operators, this theorem remains true see [Mét00](resp. [MZ05]) for the corresponding generalization.

4) \mathscr{G}_j the set of glancing frequencies, that is to say the set of $\underline{\zeta} \in \Xi_0$ such that Theorem 2.1 for the matrix $\mathscr{A}_j(\underline{\zeta})$ is satisfied with at least one block of type iv). Thus, by Definition, Ξ_0 admits the following decomposition:

$$\Xi_0 = \mathscr{E}_j \cup \mathscr{E}\mathscr{H}_j \cup \mathscr{H}_j \cup \mathscr{G}_j.$$

The study made in [Kre70] shows that the subspaces $E_1^s(\zeta_j)$ and $E_2^s(\zeta_j)$ admit a continous extension up to Ξ_0 . Moreover, for j = 1, 2, for $\zeta_j \in \Xi_0 \setminus (\mathscr{G}_1 \cup \mathscr{G}_2)$ one can decompose :

$$\mathbb{C}^{N} = E_{j}^{s}(i\underline{\tau}, \xi_{3-j}) \oplus E_{j}^{u}(i\underline{\tau}, \xi_{3-j}), \tag{2}$$

where the spaces E_j^s and E_j^u can be decomposed as :

$$E_{j}^{s}(i\underline{\tau},\xi_{3-j}) = E_{j}^{s,e}(i\underline{\tau},\xi_{3-j}) \oplus E_{j}^{s,h}(i\underline{\tau},\xi_{3-j}), \ E_{j}^{u}(i\underline{\tau},\xi_{3-j}) = E_{j}^{u,e}(i\underline{\tau},\xi_{3-j}) \oplus E_{j}^{u,h}(i\underline{\tau},\xi_{3-j}).$$

Here $E_j^{s,e}(i\underline{\tau},\xi_{3-j})$ (resp. $E_j^{u,e}(i\underline{\tau},\xi_{3-j})$) is the generalized eigenspace associated with eigenvalues of $\mathscr{A}_j(i\underline{\tau},\xi_{3-j})$ with negative (resp. positive) real part, and where spaces $E_j^{s,h}(i\underline{\tau},\xi_{3-j})$ and $E_j^{u,h}(i\underline{\tau},\xi_{3-j})$ are sums of eigenspaces of $\mathscr{A}_j(i\underline{\tau},\xi_{3-j})$ associated with some purely imaginary eigenvalues of $\mathscr{A}_j(i\underline{\tau},\xi_{3-j})$.

Moreover since the matrices A_1 and A_2 are invertible we can also write (2) in the following way: for j = 1, 2

$$\mathbb{C}^{N} = A_{j} E_{j}^{s} (i\underline{\tau}, \xi_{3-j}) \oplus A_{j} E_{j}^{u} (i\underline{\tau}, \xi_{3-j}), \tag{3}$$

In fact, it is possible to give a more precise decomposition of the spaces $E_j^{s,h}(\underline{\zeta}_j)$ and $E_j^{u,h}(\underline{\zeta}_j)$. Indeed, let $\underline{\omega}_{m,j}$ be a purely imaginary eigenvalue of $\mathscr{A}_j(\underline{\zeta}_j)$, that is:

$$\det(\underline{\tau} + \underline{\eta}A_1 + \underline{\omega}_{m,2}A_2) = \det(\underline{\tau} + \underline{\omega}_{m,1}A_1 + \underline{\eta}A_2) = 0.$$

Then, using Assumption 2.1, there exists an index $k_{m,j}$ such that:

$$\underline{\tau} + \lambda_{k_{m,2}}(\eta, \underline{\omega}_{m,2}) = \underline{\tau} + \lambda_{k_{m,1}}(\underline{\omega}_{m,1}, \eta) = 0,$$

where $\lambda_{k_{m,i}}$ is smooth in both variables. Let us then introduce the following classification:

Definition 2.2 The set of incoming (resp. outgoing) phases for the side $\partial\Omega_1$, denoted by \mathfrak{I}_1 (resp. \mathfrak{O}_1), is the set of indeces m such that the group velocity $v_m := \nabla \lambda_{k_{m,1}}(\underline{\omega}_{m,1},\underline{\eta})$ satisfies $\partial_1 \lambda_{k_{m,1}}(\underline{\omega}_{m,1},\underline{\eta}) > 0$ (resp. $\partial_1 \lambda_{k_{m,1}}(\underline{\omega}_{m,1},\underline{\eta}) < 0$). Similarly, the set of incoming (resp. outgoing) phases for the side $\partial\Omega_2$, denoted by \mathfrak{I}_2 (resp. \mathfrak{O}_2 , is the set of indeces m such that the group velocity $v_m := \nabla \lambda_{k_{m,2}}(\underline{\eta},\underline{\omega}_{m,2})$ satisfies $\partial_2 \lambda_{k_{m,2}}(\underline{\eta},\underline{\omega}_{m,2}) < 0$).

Thanks to this Definition, we can write the following decomposition of the stable and unstable components $E_j^{s,h}(\underline{\zeta})$ and $E_j^{u,h}(\underline{\zeta})$:

Lemma 2.1 For all $\zeta \in \mathcal{H}_j \cup \mathcal{EH}_j$, j = 1, 2 there holds

$$E_1^{s,h}(\zeta) = \bigoplus_{m \in \mathfrak{I}_1} \ker \mathcal{L}(\underline{\tau}, \underline{\omega}_{m,1}, \eta), \quad E_1^{u,h}(\zeta) = \bigoplus_{m \in \mathfrak{D}_1} \ker \mathcal{L}(\underline{\tau}, \underline{\omega}_{m,1}, \eta), \tag{4}$$

$$E_2^{s,h}(\underline{\zeta}) = \bigoplus_{m \in \mathfrak{I}_2} \ker \mathscr{L}(\underline{\tau}, \underline{\eta}, \underline{\omega}_{m,2}), \quad E_2^{u,h}(\underline{\zeta}) = \bigoplus_{m \in \mathfrak{I}_2} \ker \mathscr{L}(\underline{\tau}, \underline{\eta}, \underline{\omega}_{m,2}), \tag{5}$$

We refer, for example, to [CG10] or [Wil96] for a proof of this lemma.

2.2 About the boundary conditions.

Let us introduce the initial boundary value problem in the half space $\{x_1 \geq 0, x_2 \in \mathbb{R}\}$:

$$\begin{cases}
L(\partial)u = f, \text{ on } \{x_1 \ge 0, x_2 \in \mathbb{R}\} \\
B_1 u_{|x_1=0} = g_1, \\
u_{|t\le 0} = 0.
\end{cases}$$
(6)

Let us recall the following result, due to Kreiss [Kre70] which states that the boundary value problem (6) is strongly well-posed if and only if it satisfies the following condition:

Definition 2.3 We say that the system (6) satisfies the uniform Kreiss-Lopatinskii condition if it satisfies:

$$\forall \zeta \in \Xi, \ker B_1 \cap E_1^s(\zeta) = \{0\},\$$

where $E_1^s(\zeta)$ still denotes the continuiation of the resolvent matrix $\mathcal{A}_1(\zeta)$ up to $\gamma = 0$.

Definition 2.4 The hyperbolic region \mathscr{H} of the boundary value problem (6) is the set of $(\tau, \xi_2) \in \mathbb{R}^2$ such that $\mathscr{A}_1(i\tau, \xi_2)$ is diagonalizable with purely imaginary eigenvalues.

We denote by Υ the set of frequencies for which the ibvp (6) does not satisfy the uniform Kreiss-Lopatinskii condition i.e.

$$\Upsilon := \{ \zeta_1 \in \Xi : \ker B_1 \cap E_1^s(\zeta_1) \neq \{0\} \}.$$

Let us recall the following definition due to [BGRSZ02]:

Definition 2.5 The ibvp (6) is said to be in the WR class if it satisfies the following conditions:

- i) The ibvp (6) satisfies the weak Kreiss-Lopatinskii condition i.e. $\Upsilon \cap (\Xi \setminus \Xi_0) = \emptyset$.
- ii) $\Upsilon \neq \emptyset$ and $\Upsilon \subset \mathscr{H}$.
- iii) For all $\underline{\zeta} \in \Upsilon$, there is a neighborhood \mathscr{V} of $\underline{\zeta}$ in Ξ , a regular basis $(E_{1,1}^s,...,E_{1,p_1}^s)(\zeta)$ of $E_1^s(\zeta)$ on \mathscr{V} , an invertible $p_1 \times p_1$ matrix $P(\zeta)$, regular on \mathscr{V} and a smooth real valued function Θ such that

$$\forall \; \zeta \in \mathscr{V}, \; B_1\left[E^s_{1,1},...,E^s_{1,p_1}\right](\zeta) = P(\zeta)\operatorname{diag}(\gamma + i\Theta(\zeta),1,...,1).$$

In particular, one can find a Lopatinskii's determinant under the form:

$$\forall \zeta \in \mathcal{V}, \ \Delta(\zeta) = (\gamma + i\Theta(\zeta)) \det P(\zeta).$$

This discussion about hyperbolic boundary value problems in the half space motivates the following definition:

Definition 2.6 We say that the corner problem (1) is in the WR class for the side $\partial\Omega_1$ if the boundary value problem (6) is in the WR class.

So, in all this paper, the boundary condition for the side $\partial\Omega_1$ will not satisfy the uniform Kreiss-Lopatinskii condition and thus will lead to weak well-posedness. While, as mentionned in the introduction, the boundary condition for the side $\partial\Omega_2$ will be choosen as "nice" as possible in terms of well-posedness. However, we will see in Theorem 3.1 that even if the boundary condition on $\partial\Omega_2$ is in the most favorable class of strictly dissipative boundary conditions (see [BGS07]), it can not compensated the "bad" boundary condition on $\partial\Omega_2$.

To make things more precise, let us thus assume the following:

Assumption 2.3 The corner problem (1) is in the WR class for the side $\partial\Omega_1$.

The boundary condition on the side $\partial\Omega_2$ is strictly dissipative or satisfies (at least) the uniform Kreiss-Lopatinskii condition. In the first case, that is to say that the following inequality holds:

$$\forall v \in \ker B_2, \langle A_2 v, v \rangle < 0.$$

While in the second case, it means that $\forall \zeta \in \Xi$, we have :

$$\ker B_2 \cap E_2^s(\zeta) = \{0\}.$$

In both cases (we refer to [BGS07] for a proof that strictly dissipative boundary condition imply uniform Kreiss-Lopatinskii condition) the restriction of B_2 to $E_2^s(\zeta)$ is invertible. We denote this inverse by $\phi_2(\zeta)$.

When one studies geometric optics expansion for weakly well-posed boundary value problems, it is useful to define the following vectors (this definition comes from [CG10] and was also used later in [Ben14]):

Definition 2.7 Let (1) be in the WR class for the side $\partial\Omega_1$, then there exists $\diamond a \ vector \ e \in \mathbb{C}^N \setminus \{0\} \ such \ that \ \ker B_1 \cap E_1^s(\underline{\zeta}) = vect(e). \ \diamond A \ vector \ b \in \mathbb{C}^{p_1} \setminus \{0\} \ such \ that \ b \cdot Bw = 0, \ for \ all \ w \in E_1^s(\zeta).$

3 Formal phase generation process and main result.

3.1 Phase generation process.

In this paragraph we give some elements about what are the expected phases in the WKB expansion and the associated amplitudes for corner problem in the WR class for the side $\partial\Omega_1$. We will not here give a precise description of the phase generation process in itself (we refer to [Ben] and [SS75] for a complete discussion) but we will focus on the expected sizes of the amplitudes, according to the small parameter ε . More especially we will also discuss after how many time of travel the amplifications are expected.

Let us thus consider the hyperbolic corner problem:

$$\begin{cases}
L(\partial)u^{\varepsilon} = 0, & \text{on } \Omega_{T} \\
B_{1}u^{\varepsilon}_{|x_{1}=0} = g^{\varepsilon}, & \text{on } \partial\Omega_{1,T}, \\
B_{2}u^{\varepsilon}_{|x_{2}=0} = 0, & \text{on } \partial\Omega_{2,T}, \\
u^{\varepsilon}_{|t<0} = 0,
\end{cases} \tag{7}$$

and we assume that it satisfies Assumptions (2.1)-(2.2) and (2.3). We also suppose that this corner problem admits four selfinteracting planar phases (see Assumption (4.1) or [Ben] for more details) namely

$$\varphi_{n_j}(t,x) := \underline{\tau}t + \xi_1^{n_j}x_1 + \xi_2^{n_j}x_2, \ j = 1, \dots 4,$$

and that the source term g^{ε} in (7) is choosen in such a way that it "turns on" the phase φ_{n_1} . Finally we assume that the phase φ_{n_1} is associated to the only frequency for which the uniform Kreiss-Lopatinskii condition is violated.

Let us choose g^{ε} , zero for negative times, with compact support away from the corner for all positive times (or at least a function which is zero on a neighborhood of the corner for all positive times). Then by finite speed of propagation arguments, the information carried by g^{ε} can not hit

the side $\partial\Omega_2$ immediately. So, at least during a short time, we can forgot the boundary condition on $\{x_2=0\}$ and see the corner problem (7) as a problem in the WR class for the half space $\{x_1>0\}$. It is thus natural to start by taking the ansatz for this problem lying in the half space, that is to say to consider the phases $\varphi_{j,1}$ defined by

$$\varphi_{j,1}(t,x) := \underline{\tau}t + \xi_1^{j,1}x_1 + \xi_2^{n_1}x_2, \ j = 1,...N,$$

where the $(\xi_1^{j,1})$ are the roots in the ξ_1 variable of the dispersion relation:

$$\det \mathcal{L}(d\varphi_i) = 0,$$

associated to incoming-outgoing or incoming-incoming group velocities (see [Ben] for more details). Let us stress that, by assumption, the phase φ_{n_1} is contained in the $\varphi_{j,1}$.

However the analysis of [CG10] tells us that when the uniform Kreiss-Lopatinskii condition breaks down, due to a transport phenomenon along the side $\partial\Omega_1$, the leading order is one order less than the order of the source term. More precisely, if the source term is of order one, then the leading order in the WKB expansion is of order zero. It can also be shown that this transport phenomenon along the side $\partial\Omega_1$, in the presence of a source term on the boundary, is immediately turned on. We thus expect that this property for the problem in the half space remains true for the corner problem (7), at least during a short time.

In all this paper, we will assume that the transport along the side $\partial\Omega_1$ spreads the information away from the corner. If it is not the case then the information will hit the corner in finite time. Until now, we are not able to construct geometric optics expansions if such a situation occurs and we thus have a maximal time of existence for the geometric optics expansions. However let us remark that in the particular framework d=2, then the velocity of the transport along the side $\partial\Omega_1$ is explicitly computable. More precisely it is given by $-\frac{\tau}{\xi_2^{n_1}}$ (see [CG10]). So in this particular seeting asking that the transport phenomenon along the side $\partial\Omega_1$ spreads the information away from the corner is equivalent to ask that $\underline{\tau}$ and $\xi_2^{n_1}$ have opposite signs, which is easily verifiable in practice.

Then we study the reflections of the phase φ_{n_1} against the side $\partial\Omega_2$. A precise description of the reflections for the other amplitudes can be found in [Ben]. But it is not as important as the generation of the phase φ_{n_2} by the phase φ_{n_1} for our current purpose.

The ray associated to the phase φ_{n_1} is incoming-outgoing so it hits the side $\partial\Omega_2$ after a finite time of travel. However, when it happens, the striking ray still have its support away from the corner. Thus, once again, by finite speed of propagation arguments, at least during a small time, we can see the corner problem (7) as a problem in the half space $\{x_2 > 0\}$ from which the information on the side $\partial\Omega_2$ has been "turned on" by the incoming-outgoing phase φ_{n_1} . We thus add in the ansatz the amplitudes associated with the phases

$$\varphi_{j,2}(t,x) := \underline{\tau}t + \xi_1^{n_1}x_1 + \xi_2^{j,2}x_2, \ j = 1,...N_2,$$

where the $(\xi_2^{j,2})$ are the roots in the ξ_2 variable of the dispersion relation :

$$\det \mathscr{L}(d\varphi_j) = 0.$$

Let us here insist on the fact that there can be less than N roots for this dispersion relation and that these roots can be complex valued. Indeed, the boundary value problem in the half space

 $\{x_2 > 0\}$ is not assumed to be in the WR class. According to [Ben] we only consider the real roots associated with outgoing-incoming or incoming-incoming group velocities and a representant of the complex valued roots with positive imaginary part.

As the boundary condition on the side $\partial\Omega_2$ is assumed to satisfy the uniform Kreiss-Lopatinskii condition, there is no transport phenomenon along the boundary and the leading order of the WKB expansion remains of order zero (for a source term on the boundary of order one).

We can then repeat exactly the same arguments to show that the phases φ_{n_3} and φ_{n_4} are generated when we consider the reflections of the ray associated to φ_{n_2} on $\partial\Omega_1$ and the reflection of the ray associated to φ_{n_3} on $\partial\Omega_2$. It is then interesting to study the reflection of φ_{n_4} against the side $\partial\Omega_1$. This reflection starts after a strictly positive time t_0 at a strictly positive distance of the corner y_0 (the precise values of this parameters are given in Section 5 and will be fundamental in our proof). By selfinteraction phenomenon, we know that during this reflection the phase φ_{n_1} is generated again. However due to the degeneracy of uniform Kreiss-Lopatinskii condition for the phase φ_{n_1} , a new transport along the boundary is expected and shall induce a new amplification phenomenon. All the amplitudes in the ansatz then should lose one power of ε , that is to say that the amplitude of order zero becomes of order -1, the amplitude of order one becomes of order zero and so on.

As a consequence, if one starts with a source term of order two in ε then before the time t_0 , the leading order of the geometric optics expansion is expected to be of order one, but after the time t_0 , the leading order in this expansion is expected to be of order zero. Moreover the traces of the amplitudes associated to the phase φ_{n_1} are now expected to be zero for x_2 less than y_0 . We can thus repeat exactly the same arguments. That is to say that after another complete circuit around the loop, the amplitudes associated to φ_{n_4} hit again the side $\partial\Omega_1$ and regenerate the phase φ_{n_1} . A new amplification thus happens and all the amplitudes lose one order in terms of ε . The leading order in the geometric optics expansion is now expected to be of order zero for a source term on the boundary of order three.

So if one wants to construct a geometric optics expansion with M+1 amplifications before a fixed time T, it will be sufficient to choose the support of the source term g close enough of the corner to ensure that the rays have made M complete circuits around the loop before the time T.

Moreover, the fact that we choose to work with a fixed maximal time of resolution T and with a source term g having its support away from the corner permits us to assume that the number of generated phases in the phase generation process is finite and avoid the technical difficulties pointed in [Ben]. Indeed, in [Ben] its was shown that the phase generation process consists of considering sequences of phases with incoming-outgoing and then outgoing-incoming group velocities and to stop the sequence when we meet a phase with incoming-incoming group velocity. However, here each transport phenomenon from one side to the other takes some strictly positive time (which is explicitly computable) because the transported information has it support away from the corner. So when we apply the phase generation process we can stop the sequence as soon as the sum of the times needed to generate the considered phase is strictly more than the fixed maximal time T.

3.2 Main result.

In this paragraph we describe the main result of this paper. Roughly speaking, this result states that when one deals with a corner problem which do not satisfy the uniform Kreiss-Lopatinskii condition on each boundary then he should be careful. Indeed, Theorem 3.1 demonstrates that

such a problem can, in some situations depending on the geometry of the characteristic variety, be ill-posed. The violent instability is, in this framework, caused by an accumulation of weak instabilities and differs from the failure of the weak Kreiss-Lopatinskii condition which is, to our knowledge, the only known example of violent instability for hyperbolic boundary value problem. Before to state the main theorem, let us define more precisely the terms of the previous discussion:

Definition 3.1 The corner problem (1) is said to be weakly well-posed (or to generate a weak instability) if there exists nonzero integers K, K_1 , K_2 such that for all source terms $f \in H^K(\Omega_T)$, $g_1 \in H^{K_1}(\partial\Omega_{1,T})$, $g_2 \in H^{K_2}(\partial\Omega_{2,T})$, the corner problem (1) admits a unique solution $u \in L^2(\Omega_T)$ with traces $u_{|x_1=0} \in L^2(\partial\Omega_{1,T})$, $u_{|x_2=0} \in L^2(\partial\Omega_{2,T})$ satisfying the energy estimate:

$$\begin{split} \|u\|_{L^{2}(\Omega_{T})}^{2} + \|u_{|x_{1}=0}\|_{L^{2}(\partial\Omega_{1,T})}^{2} & + \|u_{|x_{2}=0}\|_{L^{2}(\partial\Omega_{2,T})}^{2} \leq \\ & C_{T} & \left(\|f\|_{H^{K}(\Omega_{T})}^{2} + \|g_{1}\|_{H^{K_{1}}(\partial\Omega_{1,T})}^{2} + \|g_{2}\|_{H^{K_{2}}(\partial\Omega_{2,T})}^{2}\right), \end{split}$$

for some positive constant C_T .

The corner problem (1) is said to be ill-posed (or to generate a violent instability) if such integers do not exist.

The main theorem of this paper is the following:

Theorem 3.1 Let (1) be a corner problem satisfying Assumptions 2.1-2.2-2.3-4.1 and 4.2 then (1) can not be weakly well-posed. In other words, for all $K \in \mathbb{N}^*$, one can find $g_1 \in H^K(\partial\Omega_{1,T})$, such that the energy estimate

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u|_{x_{1}=0}||_{L^{2}(\partial\Omega_{1,T})}^{2} + ||u|_{x_{2}=0}||_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(||f||_{L^{2}(\Omega_{T})}^{2} + ||g_{1}||_{H^{K}(\partial\Omega_{1,T})}^{2} + ||g_{2}||_{L^{2}(\partial\Omega_{2,T})}^{2}\right),$$
 is violated.

The proof of Theorem 3.1 is given in Section 6. This proof is based on the rigorous construction of a geometric optics expansion for the corner problem (1) with an arbitrary number of amplifications compared to the source term on the side $\partial\Omega_1$. This construction, which is the technical part of the proof, is made in Section 5.

4 General framework.

In this section we recall some notations and definitions used in [Ben] to describe rigorously the set of phases obtained by reflection against the side of the quarter space.

4.1 Definition of the frequency set and first properties.

Let us start with the definition of what we mean by a frequency set:

Definition 4.1 Let \mathscr{I} be a subset of \mathbb{N} and $\underline{\tau} \in \mathbb{R}$, $\underline{\tau} \neq 0$. A set indexed by \mathscr{I} ,

$$\mathscr{F} := \left\{ f_i := (\underline{\tau}, \xi_1^i, \xi_2^i), i \in \mathscr{I} \right\},\,$$

will be a set of frequencies for the corner problem (1) if for all $i \in \mathcal{I}$, f_i satisfies

$$\det \mathcal{L}(f_i) = 0,$$

and one of the following alternatives:

- $i) \xi_1^i, \xi_2^i \in \mathbb{R}.$
- ii) $\xi_1^i \in (\mathbb{C} \setminus \mathbb{R}), \ \xi_2^i \in \mathbb{R} \ and \ Im \ \xi_1^i > 0.$
- $iii) \ \xi_2^i \in (\mathbb{C} \setminus \mathbb{R}), \ \xi_1^i \in \mathbb{R} \ and \ Im \ \xi_2^i > 0.$

In all what follows, if \mathscr{F} is a frequency set for the corner problem (1), we will define:

$$\mathscr{F}_{os} := \{f_i \in \mathscr{F} \text{ satisfying } i)\},$$

 $\mathscr{F}_{ev1} := \{f_i \in \mathscr{F} \text{ satisfying } ii)\},$
 $\mathscr{F}_{ev2} := \{f_i \in \mathscr{F} \text{ satisfying } iii)\}.$

It is clear that the sets \mathscr{F}_{os} , \mathscr{F}_{ev1} and \mathscr{F}_{ev2} give a partition of \mathscr{F} . Moreover to each $f_i \in \mathscr{F}_{os}$, we can associate a group velocity $v_i := (v_{i,1}, v_{i,2})$. Let us recall that the group velocity v_i is defined in Definition 2.2. The set \mathscr{F}_{os} can thus be decomposed as follows:

The partition of \mathscr{F} induces the following partition of \mathscr{I} :

$$\mathscr{I} = \mathscr{I}_{a} \cup \mathscr{I}_{oo} \cup \mathscr{I}_{io} \cup \mathscr{I}_{oi} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev1} \cup \mathscr{I}_{ev2},$$

where we have denoted by \mathscr{I}_{io} (resp. $_{g, oo, oi, ii, ev1, ev2}$) the set of indeces $i \in \mathscr{I}$ such that the corresponding frequency $f_i \in \mathscr{F}_{io}$ (resp. $_{g, oo, oi, ii, ev1, ev2}$).

From now on, the source term g^{ε} on the boundary in (1) reads:

$$g^{\varepsilon}(t, x_2) := e^{\frac{i}{\varepsilon}(\underline{\tau}t + \underline{\xi}_2 x_2)} \varepsilon^{M+1} g(t, x_2), \tag{8}$$

for some fixed integer M and where the amplitude g has its support in space away from the corner and is zero for negative times.

The following definition gives a precise framework for the phase generation process described in paragraph 3.1. More precisely, this definition qualifies the frequency set that contains all (and only) the frequencies linked with the expected non-zero amplitudes in the WKB expansion of the solution to the corner problem (1).

Definition 4.2 The corner problem (1) is said to be complete for reflections if there exists a set of frequencies \mathscr{F} satisfying the following properties:

i) \mathscr{F} contains the real roots (in the variable ξ_1) associated with incoming-outgoing or incoming-incoming group velocities and the complex roots with positive imaginary part, to the dispersion equation

$$\det \mathscr{L}(\underline{\tau}, \xi_1, \underline{\xi}_2) = 0.$$

$$ii) \mathscr{F}_a = \emptyset.$$

- iii) If $(\underline{\tau}, \xi_1^i, \xi_2^i) \in \mathscr{F}_{io}$, then \mathscr{F} contains all the roots (in the variable ξ_2), denoted by ξ_2^p , to the dispersion relation $\det \mathscr{L}(\underline{\tau}, \xi_1^i, \xi_2) = 0$, that satisfy one of the following two alternatives:
- iii') $\xi_2^p \in \mathbb{R}$ and the frequency $(\underline{\tau}, \xi_1^i, \xi_2^p)$ is associated with an outgoing-incoming group velocity or an incoming-incoming group velocity.

$$iii''$$
) Im $\xi_2^p > 0$.

- iv) If $(\underline{\tau}, \xi_1^i, \xi_2^i) \in \mathscr{F}_{oi}$, then \mathscr{F} contains all the roots (in the variable ξ_1), denoted by ξ_1^p , to the dispersion relation $\det \mathscr{L}(\underline{\tau}, \xi_1, \xi_2^i) = 0$, that satisfy one of the following two alternatives:
- iv') $\xi_1^p \in \mathbb{R}$ and the frequency $(\underline{\tau}, \xi_1^p, \xi_2^i)$ is associated with an incoming-outgoing or an incoming-incoming group velocity.

$$iv''$$
) Im $\xi_1^p > 0$.

v) \mathscr{F} is minimal (for the inclusion) for the four preceding properties.

Remark Point i) imposes that the frequency set \mathscr{F} contains all the incoming phases for $\partial\Omega_1$ that are induced by the source term g^{ε} .

Point iii) (resp. iv)) explains the generation by reflection on the side $\partial\Omega_2$ (resp. $\partial\Omega_1$) of a wave packet that emanates from the side $\partial\Omega_1$ (resp. $\partial\Omega_2$).

An immediate consequence of the minimality of \mathscr{F} is that \mathscr{F}_{oo} is empty. Moreover let us stress that according to the discussion made in paragraph 3.1, because we are dealing with finite time and a source term which has its support away from the corner, without loss of generality we can assume that $\#\mathscr{F} < +\infty$.

Let us recall that if the corner problem is complete for reflections, one can define two applications, defined on the index set $\mathscr I$ and which give, in the output, the indexes "in the direct vicinity" of the input index :

$$\Phi, \Psi: \mathscr{I} \longrightarrow \mathscr{P}_N(\mathscr{I}),$$

where $\mathscr{P}_N(\mathscr{I})$ denotes the power set of \mathscr{I} with at most N elements. More precisely, the definitions of Φ and Ψ are : for $i \in \mathscr{I}$, $f_i = (\underline{\tau}, \xi_1^i, \xi_2^i)$,

$$\Phi(i) := \left\{ j \in \mathscr{I} \setminus \xi_2^j = \xi_2^i \right\} \text{ and } \Psi(i) := \left\{ j \in \mathscr{I} \setminus \xi_1^j = \xi_1^i \right\}.$$

For convinience let us introduce the short notations:

$$\Phi^*(i) := \Phi(i) \setminus \{i\} \text{ and } \Psi^*(i) := \Psi(i) \setminus \{i\}$$

We refer to [Ben] for more details about the sets $\Phi(i)$ (resp. $\Psi(i)$) in terms of wave packet reflection and about the graph structure that they induce on the index set \mathscr{I} . The applications Φ and Ψ have the following properties:

Proposition 4.1 If the corner problem (1) is complete for reflections, then Φ and Ψ satisfy:

- $i) \ \forall i \in \mathscr{I}, \ i \in \Psi(i), \ i \in \Phi(i).$
- $(ii) \ \forall i \in \mathscr{I}, \ \forall j \in \Psi(i), \ \forall k \in \Phi(i) \ we \ have \ \Psi(i) = \Psi(j) \ and \ \Phi(i) = \Phi(k).$
- iii) $\forall i \in \mathscr{I}$, $\Phi(i) \cap \mathscr{I}_{ev2} = \emptyset$ and $\Psi(i) \cap \mathscr{I}_{ev1} = \emptyset$. And, $\forall i \in \mathscr{I}_{ev1}, \forall j \in \mathscr{I}_{ev2}$, we have $\Psi(i) \subset \mathscr{I}_{ev1}$, $\Phi(i) \subset \mathscr{I}_{ev2}$.
 - $iv) \ \forall i \in \mathscr{I}_{os}, \ \#(\Phi(i) \cap \mathscr{I}_{ev1} \cap \mathscr{I}_{io} \cap \mathscr{I}_{ii}) \leq p_1 \ , \ and \ \#(\Psi(i) \cap \mathscr{I}_{ev2} \cap \mathscr{I}_{oi} \cap \mathscr{I}_{ii}) \leq p_2.$
 - v) $\forall i \in \mathscr{I}$, we have on one hand $\forall i_1, i_2 \in \Phi(i), i_1 \neq i_2$:

$$\Phi(i) \cap \Psi(i_1) = \{i_1\} \text{ and } \Psi(i_1) \cap \Psi(i_2) = \emptyset,$$

and on the other hand, $\forall j_1, j_2 \in \Psi(i), j_1 \neq j_2$:

$$\Psi(i) \cap \Phi(j_1) = \{j_1\} \text{ and } \Phi(j_1) \cap \Phi(j_2) = \emptyset.$$

We refer to [Ben] for a proof.

Thanks to applications Φ and Ψ it is easy to define the notion of two linked indeces in the graph structure of \mathscr{I} :

Definition 4.3 If $\underline{i} \in \mathscr{I}_{io}$, we say that the index $j \in \mathscr{I}_{io} \cup \mathscr{I}_{ev1}$ (resp. $j \in \mathscr{I}_{oi} \cup \mathscr{I}_{ev2}$) is linked with the index \underline{i} , if there exists $p \in 2\mathbb{N}+1$ (resp. $p \in 2\mathbb{N}$) and a sequence of indeces $\ell = (\ell_1, \ell_2, ..., \ell_p) \in \mathscr{I}^p$ such that:

$$\alpha'$$
) $\ell_1 \in \Psi(\underline{i}) \cap \mathscr{I}_{oi}, \ \ell_2 \in \Phi(\ell_1) \in \mathscr{I}_{io}, \ \dots, \ j \in \Phi(\ell_p) \ (resp. \ j \in \Psi(\ell_p)).$

We say that the index $j \in \mathcal{I}_{ii}$ is linked with the index \underline{i} , if there is a sequence of indeces $\ell = (\ell_1, \ell_2, ..., \ell_p) \in \mathcal{I}^p$ such that:

$$\beta') \ \ell_1 \in \Psi(\underline{i}) \cap \mathscr{I}_{oi}, \ \ell_2 \in \Phi(\ell_1) \cap \mathscr{I}_{io}, ..., \left\{ \begin{array}{l} j \in \Phi(\ell_p), \ p \ is \ odd, \\ j \in \Psi(\ell_p), \ p \ is \ even. \end{array} \right.$$

If $\underline{i} \in \mathscr{I}_{oi}$, we say that the index $j \in \mathscr{I}_{io} \cup \mathscr{I}_{ev1}$ (resp. $j \in \mathscr{I}_{oi} \cup \mathscr{I}_{ev2}$) is linked with the index \underline{i} , if there exists $p \in 2\mathbb{N}$ (resp. $p \in 2\mathbb{N} + 1$) and a sequence of indeces $\ell = (\ell_1, \ell_2, ..., \ell_p) \in \mathscr{I}^p$ such that:

$$\alpha''$$
) $\ell_1 \in \Phi(\underline{i}) \cap \mathscr{I}_{io}$, $\ell_2 \in \Psi(\ell_1) \in \mathscr{I}_{oi}$, ..., $j \in \Phi(\ell_p)$ (resp. $j \in \Psi(\ell_p)$).

We say that the index $j \in \mathscr{I}_{ii}$ is linked with the index \underline{i} , if there exists a sequence of indeces $\ell = (\ell_1, \ell_2, ..., \ell_p) \in \mathscr{I}^p$ such that:

$$\beta'') \ \ell_1 \in \Phi(\underline{i}) \cap \mathscr{I}_{io}, \ \ell_2 \in \Psi(\ell_1) \cap \mathscr{I}_{oi}, ..., \left\{ \begin{array}{l} j \in \Psi(\ell_p), \ p \ is \ odd, \\ j \in \Phi(\ell_p), \ p \ is \ even. \end{array} \right.$$

Finally, if $\underline{i} \in \mathscr{I}_{ii} \cup \mathscr{I}_{ev1} \cup \mathscr{I}_{ev2}$, there is no element of \mathscr{I} linked with \underline{i} .

Moreover, we will say that an index $j \in \mathscr{I}$ is linked with the index \underline{i} by a sequence of type H (for "horizontal") (resp. V (for "vertical")) and we will note $i \underset{H}{\hookrightarrow} j$ (resp. $i \underset{V}{\hookrightarrow} j$) if the sequence $(\underline{i}, \ell_1, \ell_2, ..., \ell_p, j)$ satisfies α'') or β'') (resp. α') or β').

The following proposition is an immediate consequence of definitions 4.2 and 4.3.

Proposition 4.2 Let \mathscr{F} be a complete for reflection frequency set indexed by \mathscr{I} . Let \mathscr{I}_0 be the set of indexes in \mathscr{I} generated by the source term g^{ε} , that is to say:

$$\mathscr{I}_0 := \left\{ i \in \mathscr{I}_{io} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev1} \setminus \det \mathscr{L}(\underline{\tau}, \xi_1^i, \underline{\xi_2}) = 0 \right\}.$$

Let $\mathscr{I}_{\mathscr{R}}$ be the set of indeces in \mathscr{I} linked with one of the elements of \mathscr{I}_0 . Then

$$\mathscr{I}_{\mathscr{R}}=\mathscr{I}.$$

Proposition 4.2 concludes the description of our formal framework for frequency sets.

4.2 Frequency sets with loop.

As in [Ben] we will assume that the considered corner problem admits a unique selfinteraction loop². Let us recall the definition of such a loop:

Definition 4.4 Let $i \in \mathcal{I}$, $p \in 2\mathbb{N} + 1$ and $\ell = (\ell_1, ..., \ell_p) \in \mathcal{I}^p$.

• We say that the index $i \in \mathcal{I}$ admits a loop if there exists a sequence ℓ satisfying :

$$\ell_1 \in \Phi(i), \ell_2 \in \Psi(\ell_1), ..., i \in \Psi(\ell_p).$$

- A loop for an index i is said to be simple if the sequence ℓ does not contain a periodically repeated subsequence.
- An index $i \in \mathcal{I}_{io}$ (resp. $i \in \mathcal{I}_{oi}$) admits a selfinteraction loop if i admits a simple loop and if the sequence (i, ℓ, i) is of type V (resp. H) according to Definition 4.3.

²However compared to [Ben], for convenience, we have exchanged the indeces n_2 and n_4 . It is due to the fact that here we are more intersted in the wave packets reflection than in [Ben].




Figure 1: The coefficients of the loop's elements.

Let us assume that:

Assumption 4.1 Let (1) be complete for the reflections. We assume that the frequency set \mathscr{F} contains a unique loop, of size 3 and that this loop is a selfinteraction loop. More precisely, we ask that the following properties are satisfied:

 $vi) \exists (n_1, n_3) \in \mathscr{I}_{io}^2, (n_2, n_4) \in \mathscr{I}_{oi}^2 \text{ such that}$

$$n_2 \in \Psi(n_1), n_3 \in \Phi(n_2), n_4 \in \Psi(n_3), n_1 \in \Phi(n_4).$$

vii) Let $i \in \mathcal{I}$ an index with a loop $\ell = (\ell_1, ..., \ell_p)$. Then p = 3 and $\{i, \ell_1, \ell_2, \ell_3\} = \{n_1, n_2, n_3, n_4\}$.

Let us define f^{n_j} the frequencies associated to the loop's elements and we write:

$$f^{n_1} := (\underline{\tau}, \underline{\xi}_1, \overline{\xi}_2), \ f^{n_2} := (\underline{\tau}, \underline{\xi}_1, \underline{\xi}_2), \ f^{n_3} := (\underline{\tau}, \overline{\xi}_1, \underline{\xi}_2) \text{ and, } f^{n_4} := (\underline{\tau}, \overline{\xi}_1, \overline{\xi}_2). \tag{9}$$

We also assume that the only index of \mathscr{I} for which uniform Kreiss-Lopatinskii condition is violated is n_1 . We summarize the previous requests on the set of indeces for the corner problem (1) in the following assumption:

Assumption 4.2 The corner problem (1) is in the class WR for the side $\partial\Omega_1$ and satisfies the uniform Kreiss-Lopatinskii condition on the side $\partial\Omega_2$. The set where the uniform Kreiss-Lopatinskii condition for the side $\partial\Omega_1$ breaks down Υ (see Definition 2.4) is given by $\Upsilon = \left\{\widetilde{f}^{n_1} := (i\underline{\tau}, \underline{\xi}_1, \overline{\xi}_2)\right\}$.

Moreover to make sure that the transport along the boundary spreads the information away from the corner we will ask that $\underline{\tau}$ and $\overline{\xi}_2$ has opposite signs.

To conclude let us recall that when the frequency set \mathscr{F} , indexed by \mathscr{I} , is complete for the reflections and that when it admits a unique loop, then it follows from the definition of linked indeces that we have the following Propositions :

Proposition 4.3 Let $i \in \mathcal{I}$ then there exists a unique type V sequence linking n_1 to i.

Moreover, one can write $\mathscr{I} \setminus \{n_1, n_2, n_3, n_4\}$ as a partition :

$$(\mathscr{I} \setminus \{n_1, n_2, n_3, n_4\}) = (\bigcup_{l < \mathfrak{l}_1} A_{a_l}) \left(\bigcup_{m < \mathfrak{l}_2} B_{b_m} \right) \left(\bigcup_{q < \mathfrak{l}_3} C_{c_q} \right) \left(\bigcup_{r < \mathfrak{l}_4} D_{d_r} \right), \tag{10}$$

where A_{a_l} denotes the set of indeces $i \in \mathscr{I}$ from which the type V sequence linking n_1 to i start by a_l , B_{b_m} denotes the set of indeces $i \in \mathscr{I}$ from which the type V sequence linking n_1 to i start by (n_2, b_l) , C_{c_q} denotes the set of indeces $i \in \mathscr{I}$ from which the type V sequence linking n_1 to i start by (n_2, n_3, c_q) and D_{d_r} is the set of indeces $i \in \mathscr{I}$ such that the type V sequence linking n_1 to i start by (n_2, n_3, n_4, d_r) .




Figure 2: "Tree structure" of the frequency set \mathscr{F} .

Proposition 4.4 Let \mathscr{F} be complete for the reflections, under Assumption 4.1. Let \mathscr{I} be the index set; then Φ and Ψ satisfy, in addition to the properties of Proposition 4.1, the four extra properties.

viii)

$$\Phi(n_1) \setminus \{n_2\} \subset \mathscr{I}_{io} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev1} \quad , \qquad \Psi(n_1) \setminus \{n_1\} \subset \mathscr{I}_{oi} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev2},
\Phi(n_4) \setminus \{n_4\} \subset \mathscr{I}_{io} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev1} \quad , \qquad \Psi(n_3) \setminus \{n_3\} \subset \mathscr{I}_{oi} \cup \mathscr{I}_{ii} \cup \mathscr{I}_{ev2}.$$

ix) Let $i \in \mathcal{I}_{ii} \cup \mathcal{I}_{ev1}$ and $j \in \mathcal{I}_{ii} \cup \mathcal{I}_{ev2}$ then

$$i \in \Phi(n_1) \implies \Psi(i) = \{i\} \quad , \quad j \in \Psi(n_1) \implies \Phi(j) = \{j\} \, ,$$

 $i \in \Phi(n_4) \implies \Psi(i) = \{i\} \quad , \quad j \in \Psi(n_3) \implies \Phi(j) = \{j\} \, .$

Let $\underline{j} \in A_{\underline{a}} \setminus \{\underline{a}\}$, we denote by $\ell = (\ell_1, ... \ell_p)$ the sequence of type H linking \underline{j} to \underline{a} . Then, according to the parity of p, we have :

x') If $p \in 2\mathbb{N}$, then $\underline{j} \notin \mathscr{I}_{oi}$. Moreover, if $\underline{j} \in \mathscr{I}_{ev1} \cup \mathscr{I}_{ii}$ then $\Psi(\underline{j}) = \{\underline{j}\}$. x'') If $p \in 2\mathbb{N} + 1$, then $\underline{j} \notin \mathscr{I}_{io}$. Moreover, if $\underline{j} \in \mathscr{I}_{ev2} \cup \mathscr{I}_{ii}$ then $\Phi(\underline{j}) = \{\underline{j}\}$.

Propositions 4.3 and 4.4 then permit to show that the set of indexes \mathscr{I} has the "tree" structure depicted in the figure 2. To conclude this section we define the following matrices which will be useful during the construction of the geometric optics expansions.

Definition 4.5 For j=1,2 and $k \in \mathfrak{R}_j$. Let $f^k = (\underline{\tau}, \xi_1^k, \xi_2^k)$ be the associated frequency with k. We define $P_{ev,j}^k$ (resp. $Q_{ev,j}^k$) the projector on $E_j^{s,e}(i\underline{\tau}, \xi_{3-j}^k)$ (resp. $A_j E_j^{s,e}(i\underline{\tau}, \xi_{3-j}^k)$) with respect to the decomposition (2) (resp. (3)).

For j=1,2 and $k \in \mathscr{I}_{os}$. Let $f^k=(\underline{\tau},\xi_1^k,\xi_2^k)$ be the associated frequency with k. We define P_j^k (resp. Q_j^k) the projector on $\ker \mathscr{L}(f^k)$ (resp. $A_j \ker \mathscr{L}(f^k)$) with respect to the decomposition (2) (resp. (3)). We also define R_j^k the partial-inverse of $\mathscr{L}(f^k)$ defined by:

$$R_i^k \mathcal{L}(f^k) = I - P_i^k, \ P_i^k R_i^k = R_i^k Q_i^k = 0.$$
 (11)

5 Geometric optics expansions for selfinteracting problems in the WR class.

The corner problem that we are now interested in reads:

$$\begin{cases}
L(\partial)u^{\varepsilon} = 0, & \text{on } \Omega_{T} \\
B_{1}u^{\varepsilon}_{|x_{1}=0} = g^{\varepsilon}_{M}, & \text{on } \partial\Omega_{1,T}, \\
B_{2}u^{\varepsilon}_{|x_{2}=0} = 0, & \text{on } \partial\Omega_{2,T}, \\
u^{\varepsilon}_{|t<0} = 0,
\end{cases} (12)$$

where the source term g_M^{ε} is given by :

$$g_M^{\varepsilon}(t, x_2) := \varepsilon^{M+1} e^{\frac{i}{\varepsilon} (\underline{\tau} t + \overline{\xi}_2 x_2)} g(t, x_2), \tag{13}$$

with $\underline{\tau}>0$ fixed, $\overline{\xi}_2<0$ defined in (9) and where $M\in\mathbb{N}$ is fixed. The function g is zero for negative time and has its support in space away from the corner for all positive times. More precisely, there exists $\underline{y}_0>0$ such that :

$$\forall t \in \mathbb{R}_+, \ \forall x < \underline{y}_0, \ g(t, x) = 0.$$

The aim of this section is to construct the geometric optics expansion associated to the corner problem (12) up to a fixed time T > 0. More precisely, we want to show that, up to choose the support of the function g close enough to the corner, the geometric optics expansion suffers a number of amplifications that can be made arbitrarilly large. Indeed, due to the presence of the loop, the amplification arising for the amplitude associated to n_1 will be repeated at each cycle around the loop. More precisely, if one wants fix M in (13) and wants to show that the leading order in the WKB expansion is of order zero then it will be sufficient to choose g such that its support to the corner to ensure that we can make M complete circuits before the time T.

Let us give more details about these times of travel. We fix a point $(0, \underline{y}^0) \in \partial \Omega_1$ satisfying $g(0, \underline{y}^0) \neq 0$ and we draw the characteristic with group velocity v_{n_1} passing through $(0, \underline{y}^0)$. This characteristic intersects $\partial \Omega_2$ in a point $(\underline{x}^0, 0)$ after a certain time of travel $t_1(\underline{y}^0)$. Then we draw the characteristic with group velocity v_{n_2} passing through $(\underline{x}^0, 0)$. It intersects $\partial \Omega_1$ in a point $(0, \underline{y}^1)$ after a certain time $t_2(\underline{y}^0)$. We repeat the same process for the characteristics with group velocity v_{n_3} and v_{n_4} . Let $(\underline{x}^1, 0)$, $(0, \underline{y}^2)$ be the corresponding points of intersection and $t_3(\underline{y}^0)$, $t_4(\underline{y}^0)$ be the corresponding times of travel. An easy computation shows that:

$$\underline{y}^2 := \beta \underline{y}^0$$
, and, $T_1(\underline{y}^0) := \sum_{j=1}^4 t_j(\underline{y}^0) = \alpha \underline{y}^0$,

where α and β are given by :

$$\alpha := -\frac{1}{v_{n_1,2}} \left(1 - \frac{v_{n_1,1}}{v_{n_2,1}} + \frac{v_{n_1,1}v_{n_2,2}}{v_{n_2,1}v_{n_3,2}} - \frac{v_{n_1,1}v_{n_2,2}v_{n_3,1}}{v_{n_2,1}v_{n_3,2}v_{n_4,1}} \right),\tag{14}$$

$$\beta := \prod_{j=1}^{4} \beta_{j}, \text{ with, } \beta_{j} := \begin{cases} \frac{v_{n_{j},1}}{v_{n_{j},2}}, & \text{if } j \text{ is odd,} \\ \frac{v_{n_{j},2}}{v_{n_{j},1}}, & \text{if } j \text{ is even,} \end{cases}$$
 (15)

where the $v_{n_i} := \begin{bmatrix} v_{n_i,1} & v_{n_i,2} \end{bmatrix}$ are the group velocities for the indeces of the loop.

After $m \in \mathbb{N}^*$ turns around the loop the initial point $(0, y^0)$ comes back on $\partial \Omega_1$ in $(0, y^{2m})$ after a total time of travel \underline{T}_m . It is easy to show that :

$$\underline{y}^{2m} := \beta^m \underline{y}^0$$
, and, $\underline{T}_m = \underline{T}_m(\underline{y}^0) = \alpha \underline{y}^0 \sum_{k=0}^{m-1} \beta^k$.

We point the fact that if $\beta < 1$, that is to say when the rays get closer and closer of the corner, the sum defining \underline{T}_m is finite. In other words, the rays reach the corner in a finite time $T_{max} := \alpha y^0 \sum_{k=0}^{\infty} \beta^k$. In this particular situation we will thus assume that $T < T_{max}$.

It is clear that one can always choose y^0 in such a way that :

$$\underline{T}_M \le T < \underline{T}_{M+1}.$$

As already mentionned in paragraph 3.1, if $t \in [\underline{T}_k, \min(\underline{T}_{k+1}, T)]$ one expects that all the amplitudes of order less than M-k+1 are zero. Moreover one also expects that the traces of the amplitudes associated to the index n_1 and which are not identically zero vanish for $x < y^{2k}$. Indeed, for time $t \in [\underline{T}_k, \min(\underline{T}_{k+1}, T)]$, the information has only made k complete circuits around the loop, so it can not have been amplified more than k times and can not have been transported under the threshold y^{2k} . This observation motivates the following definition:

Definition 5.1 Let us write, for $n \in \mathbb{N}$,

$$u_{n,n_1}(t,x) := \nu_{n,n_1}(t,x)e + \check{v}_n(t,x),$$

where the vector e in defined in Definition 2.7 (this decomposition will be explain in paragraph 5.1). And let $M \in \mathbb{N}$.

If $\beta \leq 1$, we say that the sequence of amplitudes $(u_{n,n_1})_{n \in \mathbb{Z}}$ is in \mathscr{P}_{\leq} if for all $n \in \mathbb{Z}$, $\nu_{n,n_1}|_{x_1=0}$

- is in $\mathscr{P}_{b,\leq}^{M-n}$. Where the space $\mathscr{P}_{b,\leq}^{M-n}$ is the set of functions $\mu \in \mathscr{C}^{\infty}(]-\infty,T[\,,\mathscr{D}(\mathbb{R}_{+}))$ satisfying: i) If M-n>0, then for $-\infty < t < \underline{T}_{M-n},\ \mu(t,x)=0\ \forall x\in\mathbb{R}_{+},\ and\ for\ all\ k\ such\ that$ $M - n \le k \le M$, if $\underline{T}_k \le t < \min(T, \underline{T}_{k+1})$, $\mu(t, x) = 0 \ \forall x < y^{2k}$.
- ii) If $M-n \leq 0$, then μ is zero for negative times, and for all k such that $0 \leq k \leq M$, if $\underline{T}_k \le t < \min(T, \underline{T}_{k+1}), \ \mu(t, x) = 0 \ \forall x < \underline{y}^{2k}.$
 - iii) If $n \le -1$ then $\mathscr{P}_b^{M-n} = \{0\}$.

If $\beta > 1$, we say that the sequence of amplitudes $(u_{n,n_1})_{n \in \mathbb{N}}$ is in $\mathscr{P}_{>}$ if for all $n \in \mathbb{N}$, $\nu_{n,n_{1|x_1=0}}$ is in $\mathscr{P}_{b,>}^{M-n}$. Where the space $\mathscr{P}_{b,>}^{M-n}$ is the set of functions $\mu \in \mathscr{C}^{\infty}(]-\infty,T[\,,\mathscr{D}(\mathbb{R}_{+}))$ satisfying: i) If M-n>0, then for $-\infty < t < \underline{T}_{M-n},\ \mu(t,x)=0\ \forall x\in\mathbb{R}_{+},\ and\ for\ all\ k\ such\ that$

- $M n \le k \le M$, if $\underline{T}_k \le t < \min(T, \underline{T}_{k+1})$, $\mu(t, x) = 0 \ \forall x < \underline{y}_0$.
 - ii) If $n \leq -1$ then $\mathscr{P}_{h}^{M-n} = \{0\}.$

The fact that we distinguish the profile space for $\beta \leq 1$ and for $\beta > 1$ is due to technical reasons which will be explained in paragraph 5.1.4. Notice that by definition we have $\mathscr{P}_{b,\leq}^{M-n}=\mathscr{P}_{b,\leq}^0$ for all n > M.

We are now able to describe the expected space of profiles:

Definition 5.2 When $\beta \leq 1$, a sequence $(u_{n,k})_{n \in \mathbb{N}, k \in \mathscr{I}_{os}}$ is said to be in the space of profiles $\mathbb{P}_{os,\leq}$ if $(u_{n,n_1}) \in \mathscr{P}_{\leq}$ and if for all $k \in \mathscr{I}_{os} \setminus \{n_1\}$, for all $n \in \mathbb{N}$, $(u_{n,k})_{n \in \mathbb{N}, k \in \mathscr{I}_{os}}$ lies in $H^{\infty}(\Omega_T)$.

When $\beta > 1$, a sequence $(u_{n,k})_{n \in \mathbb{N}, k \in \mathscr{I}_{os}}$ is said to be in the space of profiles $\mathbb{P}_{os,<}$ if $(u_{n,n_1}) \in \mathscr{P}_{<}$ and if for all $k \in \mathscr{I}_{os} \setminus \{n_1\}$, for all $n \in \mathbb{N}$, $(u_{n,k})_{n \in \mathbb{N}, k \in \mathscr{I}_{os}}$ lies in $H^{\infty}(\Omega_T)$.

For i=1,2, the set $\mathbb{P}_{ev,i}$ of evanescent profiles for the side $\partial\Omega_i$ is the set of $U(t,x,X_i) \in H^{\infty}(\Omega_T \times \mathbb{R}_+)$ for which there exists a positive δ such that $e^{\delta X_i}U(t,x,X_i) \in H^{\infty}(\Omega_T \times \mathbb{R}_+)$.

We postulate the ansatz:

$$u^{\varepsilon}(t,x) \sim \sum_{n\geq 0} \sum_{k\in\mathscr{I}_{os}} \varepsilon^{n} e^{\frac{i}{\varepsilon}\varphi_{k}(t,x)} u_{n,k}(t,x)$$

$$+ \sum_{n\geq 0} \sum_{k\in\mathfrak{R}_{1}} \varepsilon^{n} e^{\frac{i}{\varepsilon}\psi_{k,1}(t,x_{2})} U_{n,k,1}\left(t,x,\frac{x_{1}}{\varepsilon}\right) + \sum_{n\geq 0} \sum_{k\in\mathfrak{R}_{2}} \varepsilon^{n} e^{\frac{i}{\varepsilon}\psi_{k,2}(t,x_{1})} U_{n,k,2}\left(t,x,\frac{x_{2}}{\varepsilon}\right),$$

where $(u_{n,k})_{n\in\mathbb{N},k\in\mathscr{I}_{os}}\in\mathbb{P}_{os,\leq}$ (resp. $\mathbb{P}_{os,<}$) for $\beta\leq 1$ (resp. $\beta>1$), and for all $n\in\mathbb{N},\forall k\in\mathfrak{R}_1(resp.\mathfrak{R}_2),\,U_{n,k,1}$ (resp. $U_{n,k,2}$) is in $\mathbb{P}_{ev,1}$ (resp. $\mathbb{P}_{ev,2}$).

Plugging the ansatz (16) into the evolution equation of (12) lead us to the cascade of equations

:

of derivation in the fact variables $L_{k}(\partial_{X_{2}}) = 0$, and $L_{k}(\partial_{X_{2}}) = 0$, are defined by the

where the operators of derivation in the fast variables $L_k(\partial_{X_1})$ and $L_k(\partial_{X_2})$ are defined by :

$$L_k(\partial_{X_1}) := A_1(\partial_{X_1} - \mathscr{A}_1(\underline{\tau}, \xi_2^k)) \text{ for } k \in \mathfrak{R}_1,$$
 (18)

$$L_k(\partial_{X_2}) := A_2(\partial_{X_2} - \mathscr{A}_2(\underline{\tau}, \xi_1^k)) \text{ for } k \in \mathfrak{R}_2.$$

Then, plugging the ansatz (16) in the boundary conditions on $\partial\Omega_1$ and on $\partial\Omega_2$, give :

where $\delta_{n,p}$ denotes the Kronecker symbol.

Finally, plugging the ansatz (16) into the initial condition of (12), give:

Thanks to the cascade of equations (17)-(20) and (21) we are now able to state our made result about the construction of the geometric optics expansions:

Theorem 5.1 Let T > 0 and assume that the corner problem (12) satisfies Assumptions 2.1-2.2-2.3-4.1 and 4.2. Then:

- If $\beta > 1$, then for all $M \in \mathbb{N}$ the corner problem (12) admits a WKB expansion under the form (16). More precisely there exists sequence of functions $(u_{n,k})_{n\in\mathbb{N},k\in\mathscr{I}_{os}} \in \mathbb{P}_{os,>}$, $(U_{n,k,1}) \in \mathbb{P}_{ev1}$, and $(U_{n,k,2}) \in \mathbb{P}_{ev2}$ satisfying the cascade of equations (17)-(20) and (21). Moreover one can always choose g in such a way that the leading order in (16) is not identically zero.
- If $\beta \leq 1$, assume that $T < T_{max}$ if $\beta < 1$, then for all $M \in \mathbb{N}$ the corner problem (12) admits a WKB expansion under the form (16). More precisely there exists sequence of functions $(u_{n,k})_{n\in\mathbb{N},k\in\mathscr{I}_{os}} \in \mathbb{P}_{os,\leq}$, $(U_{n,k,1}) \in \mathbb{P}_{ev1}$, and $(U_{n,k,2}) \in \mathbb{P}_{ev2}$ satisfying the cascade of equations (17)-(20) and (21). Moreover one can always choose g in such a way that the leading order in (16) is not identically zero.

The question is now to solve the cascade of equations (17)-(20) and (21). More precisely, to solve the cascade, we are looking for an order of resolution of the different equations and an equation which can be solved before all the other in view to initialize the resolution.

In [Ben] it is shown that to construct any amplitude in one of the "trees" (that is the sets composing the partition (10) of \mathscr{I} despicted in Figure 2) it is in fact sufficient, thanks to the uniqueness of the type V sequence linking any index of the "tree" to its root (see Proposition 4.3) and uniform Kreiss-Lopatinskii condition to be known the amplitude associated to the root. Then is was show that to know the amplitudes associated to the roots it was sufficient to know the amplitudes associated to the loop indeces. Thus the determination of the loop's amplitudes was in [Ben] the construction needed to initialize the resolution of the cascade of equations.

The first equation of the cascade (17) implies that we have the well-known polarization condition for the oscillating amplitudes $u_{0,k}$, in particular for $k = n_1$, we have $u_{0,n_1} \in \ker \mathcal{L}(d\varphi_{n_1})$, in other words we can write:

$$P_1^{n_1} u_{0,n_1} = u_{0,n_1}. (22)$$

But, thanks to Assumption 2.1, $\ker \mathcal{L}(d\varphi_{n_1})$ is one dimensional. Assumption 4.2 then permits to write:

$$u_{0,n_1}(t,x) = \nu_{0,n_1}(t,x)e, \tag{23}$$

for some unknown scalar function ν_{0,n_1} and where e is the vector defined in 2.7.³ For other indeces $k \in \mathscr{I}_{os}$ we can always write :

where $\nu_{0,k}$ is a scalar function and where e_k is a generator of ker $\mathcal{L}(d\varphi_k)$.

More generally for any n let us intoduce the following decomposition:

$$u_{0,n_1}(t,x) = \nu_{0,n_1}(t,x)e + \check{v}(t,x),$$

where \check{v} lies in some subspace of $E_1^s(i\underline{\tau}, \overline{\xi}_2)$ where we can apply Kreiss-Lopatinskii condition. However, it seems that in that case, one can always determine \check{v} by reiterating the arguments of [Ben] which lead to ask for the invertibility of an operator reading under the form $(I - \mathbb{T})$.

³Let us remark that (23) is not true anymore if the operator $L(\partial)$ is hyperbolic with constant multiplicity. In that framework, (23) has to be remplaced by a decomposition reading:

where e is defined in Definition 2.7.

Next let us study the second equation of the cascade (17) written for n = 0 and $k = n_1$. If we compose this equation by $Q_1^{n_1}$ and use the fact that $\ker Q_1^{n_1} = \operatorname{Ran} \mathscr{L}(d\varphi_{n_1})$ thanks to the polarization condition (22) we obtain that u_{0,n_1} satisfies the equation:

$$Q_1^{n_1}L(\partial)P_1^{n_1}u_{0,n_1}=0.$$

From Lax's lemma [Lax57], we have:

$$Q_1^{n_1} L(\partial) P_1^{n_1} u_{0,n_1} = (\partial_t + v_{n_1} \cdot \nabla_x) \nu_{0,n_1} = 0, \tag{26}$$

where we used the fact that $Q_1^{n_1}$ induces an isomorphism from $\operatorname{Ran} P_1^{n_1}$ to $\operatorname{Ran} Q_1^{n_1}$. Using the fact that the group velocity v_{n_1} is incoming-outgoing, to solve equation (26) we only need to determine the trace of λ_{0,n_1} on $\{x_1=0\}$.

However, the degeneracy of the uniform Kreiss-Lopatinskii condition prevents to determine this trace by the easy classical way. Indeed, the only equation where the trace of ν_{0,n_1} on $\{x_1=0\}$ seems to appear is the boundary condition (20) written for n=0 that is:

$$B_1 \left[\sum_{j \in \Phi(n_1)} u_{0,j} \right]_{|x_1 = 0} = 0.$$

From (23) and the fact that, by definition $e \in \ker B_1$, the boundary condition reads:

where we recall that $\Phi^*(n_1)$ stands for $\Phi^*(n_1) \setminus \{n_1\}$. As a consequence this equation does not give any information about $\nu_{0,n_1|x_1=0}$. So it seems that we shall find another way to determine $\nu_{0,n_1|x_1=0}$. To do that, we will start by using the method of [CG10] which has been introduced to construct the geometric optics expansion for the initial boundary value problem in the half space and we will see how to adapt this method.

Before to recall the main ideas of the method of determination of $\nu_{0,n_1|_{x_1=0}}$ by [CG10], let us remark the following fact. If one assumes that $\nu_{0,n_1|_{x_1=0}}$ is known and write, once again in view to save some notations:

$$\nu_{0,n_1|x_1=0}(t,x_2) := \mu_0(t,x_2), \tag{27}$$

then is it easy to determine the other amplitudes $u_{0,k}$, for $k = n_2, ..., n_4$. Indeed, the transport equation determining ν_{0,n_1} reads:

$$\begin{cases} (\partial_t + v_{n_1} \cdot \nabla_x) \nu_{0,n_1} = 0, \text{ on } \Omega_T, \\ \nu_{0,n_1|_{x_1=0}} = \mu_0, \text{ on } \partial\Omega_{1,T}, \\ \nu_{0,n_1|_{t\leq 0}} = 0. \end{cases}$$

Integrating along the characteristics we obtain that:

$$\nu_{0,n_1}(t,x_1,x_2) = \mu_0 \left(t - \frac{1}{v_{n_1,1}} x_1, x_2 - \beta_1^{-1} x_1 \right). \tag{28}$$

In particular, the trace of u_{0,n_1} on $\{x_2=0\}$ is given by

$$u_{0,n_{1|x_{2}=0}} := \nu_{0,n_{1}}(t,x_{1},0)e,$$

so, using the uniform Kreiss-Lopatinskii condition in the boundary condition (20) written for n = 0 and $k = n_2$ permit us to determine the trace on $\{x_2 = 0\}$ of ν_{0,n_2} . Integrating along the characteristics we obtain:

$$\nu_{0,n_2}(t,x_1,x_2) = -\mu_0\left(\mathbf{t}_2(t,x_1,x_2),\mathbf{x}_2(x_1,x_2)\right)\mathcal{S}_{n_2}e,\tag{29}$$

where

$$\mathbf{t}_{2}(t, x_{1}, x_{2}) := t - \frac{1}{v_{n_{1}, 1}} x_{1} - \left[\frac{1}{v_{n_{2}, 2}} - \frac{\beta_{2}^{-1}}{v_{n_{1}, 1}} \right] x_{2}, \ \mathbf{x}_{2}(x_{1}, x_{2}) := -\beta_{1}^{-1}(x_{1} - \beta_{2}^{-1}x_{2}), \tag{30}$$

and

$$\mathscr{S}_{n_2} := P_2^{n_2} \phi^{n_2} B_2. \tag{31}$$

We can thus repeat exactly the same reasoning, applied to the amplitude u_{0,n_3} and then for the amplitude u_{0,n_4} , to obtain their values in terms of the unknown trace μ_0 . More precisely, we obtain :

$$\nu_{0,n_3}(t,x_1,x_2) = \mu_0\left(\mathbf{t}_3(t,x_1,x_2),\mathbf{x}_3(x_1,x_2)\right) \mathcal{S}_{n_3}e,\tag{32}$$

$$\nu_{0,n_4}(t,x_1,x_2) = -\mu_0\left(\mathbf{t}_4(t,x_1,x_2),\mathbf{x}_4(x_1,x_2)\right) \mathscr{S}_{n_4}e,\tag{33}$$

Where we set for ν_{0,n_3} :

with A a non meaningfull parameter introduced to simplify the notations. It is precisely given by :

$$A := \frac{1}{v_{n_2,1}} - \beta_3^{-1} \left(\frac{1}{v_{n_2,2}} - \frac{\beta_2^{-1}}{v_{n_1,1}} \right). \tag{36}$$

And for ν_{0,n_4} :

An important observation for what follows is to remark that the trace $\nu_{0,n_{4|x_1=0}}$ depends of the particular values, $\mathbf{t}_4(t,0,x_2)$ and $\mathbf{x}_4(0,x_2)$. An easy computation shows that the constant in front of x_2 in $\mathbf{t}_4(t,0,x_2)$ can in fact be expressed in terms of the parameters α and β , introduced in (14) and (15) and which encode the time needed to make one complete circuit around the loop. More precisely, we have:

$$\underline{\mathbf{t}}(t, x_2) := \mathbf{t}_4(t, 0, x_2) = t - \alpha \beta^{-1} x_2, \text{ and, } \underline{\mathbf{x}}(x_2) := \mathbf{x}_4(0, x_2) = \beta^{-1} x_2.$$
 (39)

Let us also notice, because it will be important in paragraph 5.1.5, that the knowledge of u_{0,n_4} allow us to express all the amplitudes in $\Phi(n_1)$ in terms of μ_0 . Indeed, Proposition 4.1 implies that

these amplitudes (except n_4) are in $\mathscr{I}_{ii} \cup \mathscr{I}_{io}$. So, let $\underline{i} \in \Phi(n_1) \setminus \{n_4\}$ to determine $u_{0,\underline{i}}$ for $\underline{i} \in \mathscr{I}_{io}$ (resp. $\underline{i} \in \mathscr{I}_{ii}$) we have to solve the transport equation :

 (\partial_t + v_{\underline{i}} \cdot \nabla_x) u_{0,\underline{i}} = 0, \\
 B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} u_{0,j} \right]_{|x_1 = 0} = -B_1 u_{0,n_4|x_1 = 0}, \\
 B_2 \left[\sum_{j \in \Psi(n_2)} u_{0,j} \right]_{|x_2 = 0} = 0, \\
 u_{0,\underline{i}_{|t \le 0}} = 0,
\end{cases} \right) \tag{41}$$

However, by assumption, the index \underline{i} is associated with a frequency for which the uniform Kreiss-Lopatinskii condition holds, so the boundary condition(s) of (40) (resp.(40)-(41)) can be written under the form :

$$u_{0,\underline{i}_{|x_1=0}} = -P_1^{\underline{i}}\phi_1^{\underline{i}}B_1u_{0,n_{4|x_1=0}}, \left(\text{ resp. } \left\{ \begin{array}{l} u_{0,\underline{i}_{|x_1=0}} = -P_1^{\underline{i}}\phi_1^{\underline{i}}B_1u_{0,n_{4|x_1=0}}, \\ u_{0,\underline{i}_{|x_2=0}} = 0. \end{array} \right) \right.$$

Using the expression of $u_{0,n_{4|x_1=0}}$ and integrating along the characteristics we obtain that :

$$u_{0,\underline{i}}(t,x) = \mathscr{S}^{n_4} e \mu_0 \left(\underline{\mathbf{t}} - \frac{1}{v_{i,1}} x_1, \underline{\mathbf{x}} - \frac{v_{\underline{i},2}}{v_{i,1}} x_1 \right) P_1^{\underline{i}} \phi_1^{\underline{i}} B_1 e_4. \tag{42}$$

5.1 Initialization of the resolution, determination of the loop's indeces.

As already mentionned in the previous paragraph to determine μ_0 we will adapt the method of [CG10].

Let us study the boundary condition for the amplitude u_{1,n_1} that is (20) written for n=1:

Thanks to Proposition 4.1, we know that $\Phi(n_1) \setminus \{n_4\}$ is included in $\mathscr{I}_{io} \cup \mathscr{I}_{ii}$, so the left hand side term is in $B_1 E_1^s(i\underline{\tau}, \overline{\xi}_2)$. By definition of b composing by b in the left makes this term vanish. We thus have :

$$b \cdot B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} (I - P_1^j) u_{1,j} \right]_{|x_1 = 0} = \delta_{1,M} \widetilde{g} - b \cdot B_1 u_{1,n_4}, \tag{44}$$

where $\widetilde{g} := b \cdot g$.

To make this equation more explicit in term of μ_0 , we use the cascade of equation (17) written for n = 0. Composing by the partial inverse R_1^k defined in Definition 4.5, lead us to the relation:

$$\forall j \in \Phi(n_1) \setminus \{n_4\}, (I - P_1^j)u_{1,j} = iR_1^j L(\partial)u_{0,j} = iR_1^j L(\partial)P_1^j u_{0,j},$$

where we used the polarization condition for $u_{0,j}$. We thus can write (44) under the form:

Let us recall the following Proposition due to [CG10]:

Proposition 5.1 ([CG10], Proposition 2) Let P_1^j , Q_1^j and R_1^j be defined in Definition 4.5 then we have $R_1^j A_1 P_1^j = 0$.

Let the vector b be defined in Definition 2.7. Then there exists a nonzero real number κ such that the following equation holds:

$$b \cdot B_1 \sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j L(\partial) P_1^j = \kappa \left(\Theta(i\underline{\tau}, \overline{\xi}_2) \partial_t + \partial_{\xi_2} \Theta(i\underline{\tau}, \overline{\xi}_2) \partial_2 \right),$$

where Θ is defined in Definition 2.5. Moreover, $\partial_t \Theta(i\underline{\tau}, \overline{\xi}_2) = 1$ and $\partial_{\xi_2} \Theta(i\underline{\tau}\partial_2, \overline{\xi}_2) = -\frac{\underline{\tau}}{\overline{\xi}_2} := \underline{c}$ and $\kappa := b \cdot B_1 e$.

Proof: We refer to [CG10] for a complete proof. We will here just show that we have the equality $\partial_{\xi_2}\Theta(i\underline{\tau},\overline{\xi}_2)=-\frac{\tau}{\overline{\xi}_2}$. This equality was already showed in [[CG10], Lemma 7], but since it is important for our purpose, let us give a proof for a sake of completeness.

Necessarily $\overline{\xi}_2 \neq 0$ otherwise the Kreiss-Lopatinskii condition will break down for $\gamma > 0$ because it would say that the boundary condition on $\partial \Omega_1$ does not satisfy the weak Kreiss-Lopatinskii condition. We then use the fact that d=2 and the relation $R_1^j A_1 P_1^j = 0$. First we have :

$$\forall j \in \Phi(n_1) \setminus \{n_4\}, \ \mathcal{L}(d\varphi_i)P_1^j = \underline{\tau}P_1^j + \xi_1^j A_1 P_1^j + \overline{\xi}_2 A_2 P_1^j = 0,$$

we compose by R_1^j , the term $R_1^jA_1P_1^j$ desappears. Then sum over $j \in \Phi(n_1) \setminus \{n_4\}$ and multiply by $b \cdot B_1$ to obtain :

$$b \cdot B_1 \sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j A_2 P_1^j = -\frac{\underline{\tau}}{\overline{\xi}_2} b \cdot B_1 \sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j P_1^j.$$

As a consequence of this Proposition, (45) can be expressed under the form:

$$\left(\partial_t \mu_0 - \frac{\underline{\tau}}{\overline{\xi}_2} \mu_0\right) = \frac{i}{\kappa} \left(-\widetilde{g} \delta_{1,M} + b \cdot B_1 P_2^{n_4} u_{1,n_4|x_1=0} + b \cdot B_1 (I - P_2^{n_4}) u_{1,n_4|x_1=0}\right).$$
(46)

Thus to determine the unknown trace μ_0 , we want to solve the same transport equation as in [CG10]. But, in the analysis of Coulombel and Guès the amplitude u_{1,n_4} which acts like a source term in (44) could be determinated independently of μ_0 . Indeed, for the geometry of the half space u_{1,n_4} is an outgoing amplitude so it satisfies a transport equation which does not require boundary condition for its resolution (see [CG10] for more details).

For the quarter space geometry it is not true anymore because u_{1,n_4} depends on u_{1,n_3} , which depends on u_{1,n_2} and so on. However, equation (44) meet with the intuiton about our problem that we gave in paragraph 3 because this equation says that the amplification of order zero is "turned on" by the outgoing (for the side $\partial\Omega_1$) mode u_{1,n_4} . Moreover, we mentionned at the end of the previous paragraph that amplitudes $u_{1,j}$ for $j=n_1,...n_4$ can be expressed in term of the unknown trace μ_0 .

So our purpose is now to express the "source term" u_{1,n_4} in terms of the unknow trace μ_0 . In view to do this, we will show in a first time that its unpolarized part $(I - P_2^{n_4})u_{1,n_4}$ can be expressed in term of μ_0 . In a second time we will show that its polarized part $P_2^{n_4}u_{1,n_4}$ can be expressed in terms of μ_0 and a new unknown trace μ_1 (see (81) for a precise definition). The determination of the dependency of $(I - P_2^{n_4})u_{1,n_4}$ in term of μ_0 is made in the following paragraph.

5.1.1 Unpolarized part of the terms of order one.

In a classical way, after composition of the second equation of 17 (written for n = 0 and $k = n_j$, j = 1, ...4) by the pseudo-inverse $R^{n_j}_{\bullet}$ introduced in Definition 4.5, we obtain that :

$$(I - P_{\bullet}^{n_j})u_{1,n_j} = iR_{\bullet}^{n_j}L(\partial)u_{0,n_j}, \tag{47}$$

where we used the fact that by definition $R^{n_j}_{\bullet} \mathscr{L}(d\varphi_{n_j}) = I - P^{n_j}_{\bullet}$.

Let us recall the following lemma, already used in [CG10]:

Lemma 5.1 We have the following equalities:

$$R_1^{n_1}A_1P_1^{n_1}=R_1^{n_3}A_1P_1^{n_3}=0, \ \ and, \ \ R_2^{n_2}A_2P_2^{n_2}=R_2^{n_4}A_2P_2^{n_4}=0.$$

Thanks to this lemma we can compute precisely the values of the unpolarized part of the amplitudes of order one. Indeed for $(I - P_1^{n_1})u_{1,n_1}$ we thus have :

$$(I - P_1^{n_1})u_{1,n_1} = -R_1^{n_1} \left[\partial_t + A_1\partial_1 + A_2\partial_2\right] \mu_0 \left(t - \frac{1}{v_{n_1,1}}x_1, x_2 - \beta_1^{-1}x_1\right) e,$$

$$= -\left[(\partial_t \mu_0)R_1^{n_1}e + (\partial_2 \mu_0)R_1^{n_1}A_2e\right] \left(t - \frac{1}{v_{n_1,1}}x_1, x_2 - \beta_1^{-1}x_1\right), \tag{48}$$

where we used the fact that $P_1^{n_1}e = e$ and lemma 5.1.

But as $e \in \ker \mathcal{L}(d\varphi_{n_1})$, we have $(\underline{\tau} + \underline{\xi}_1 A_1 + \overline{\xi}_2 A_2)e = 0$. We compose by $R_1^{n_1}$, and we use lemma 5.1 to show that :

This relation permits to reformulate (48) under the form:

For simplicity let us introduce the notation:

Remark The fact that one restricts to a corner problem (1) with only two dimensional variables is used in a non trivial way to establish relation (49) which allows us to reformulate (48) under the form (50). We will see in a moment why this reformulation is so important in the proof.

We do not know if the restriction d=2 is really necessary, however it has the advantage to make all the following computations much more simpler.

The same computation can be repeated to determine the unpolarized part of the amplitudes u_{1,n_j} , for j=2,...,4. Unfortunatly, since our aim is to determine the exact value of the trace

 $u_{1,n_4|x_1=0}$, we also need the exact values of the unpolarized part of the amplitudes u_{1,n_j} , for j=2,...,4. After some computations, they are given by :

$$(I - P_{n_2})u_{1,n_2} = \left[\left(1 + \frac{\underline{\tau}}{v_{n_1,1}\underline{\xi}_1}\right)\partial_t\mu_0 + \frac{\underline{\tau}}{\underline{\xi}_1}\partial_2\mu_0\right](\mathbf{t}_2, \mathbf{x}_2)R_{n_2}\mathscr{S}_{n_2}e,$$
 (52)

$$(I - P_{n_3})u_{1,n_3} = -\left[\left(1 - \frac{\underline{\tau}}{v_{n_2,2}\underline{\xi}_2}\left(1 - \frac{v_{n_2,1}}{v_{n_1,1}}\right)\right)\partial_t\mu_0 + \frac{\underline{\tau}}{\underline{\xi}_2}\beta_2^{-1}\beta_1^{-1}\partial_2\mu_0\right](\mathbf{t}_3,\mathbf{x}_3)R_{n_3}\mathscr{S}_{n_3}e(53)$$

$$(I - P_{n_4})u_{1,n_4} = \left[\left(1 + \frac{\underline{\tau}}{\overline{\xi}_1} A \right) \partial_t \mu_0 + \frac{\underline{\tau}}{\overline{\xi}_1} \prod_{j=1}^3 \beta_j^{-1} \partial_2 \mu_0 \right] (\mathbf{t}_4, \mathbf{x}_4) R_{n_4} \mathscr{S}_{n_4} e, \tag{54}$$

At this stage of the proof, the term depending on $(I-P_2^{n_4})u_{1,n_4}$ which appears in the right hand side of (46) has been express in terms of the function μ_0 . So we just have to express the term $P_2^{n_4}u_{1,n_4}$. In paragraph 5.1.3 we will see how the knowledge of the unpolarized part of the amplitudes of order one enable us to determine the polarized part of the amplitudes of order one. However, before to do this determination, it is useful (and it will a lot simplify the computations) to express the unpolarized part of the amplitude of order one in terms of the transport operator along the boundary. Moreover, as we will see in paragraph 5.1.4, this reformulation will also be essential for the resolution of the equation (46).

5.1.2 Reformulation of equations (52)-(53) and (54).

The following lemma which is just an algebraic property based on a simple computation is however fundamental for our analysis. Indeed it will permit to reformulate equation (46) in a much more pleasant form. The fact that we are able to reformulate (46) in a particular form (more precisely under the form $(I - \tilde{T})(\mathcal{F}\mu_0)$ see (88) for more details) is not at all anodyne when one wants to solve (46) in view to determine μ_0 , because it will permit to express $\mathcal{F}\mu_0$ as a sum of iterations of \tilde{T} corresponding to the number of complete circuits that we have made.

Lemma 5.2 If d = 2, we have the following equalities :

$$1 + \frac{\underline{\tau}}{\overline{\xi}_1} A = -\frac{\overline{\xi}_2}{\overline{\xi}_1} \beta_1^{-1} \beta_2^{-1} \beta_3^{-1}, \tag{57}$$

where we recall that A appearing in (57) is defined in (36).

Proof: We will only demonstrate (57), the proof of the two other equalities are simpler and follow exactly the same kind of computations.

First let us develop:

$$= \frac{1}{v_{n_{2},1} v_{n_{2},2} v_{n_{1},1} \overline{\xi}_{1}} \left[v_{n_{3},1} v_{n_{2},2} v_{n_{1},1} \overline{\xi}_{1} + v_{n_{2},2} v_{n_{1},1} \underline{\tau} - v_{n_{3},2} v_{n_{1},1} \underline{\tau} + \underline{\tau} v_{n_{3},2} v_{n_{2},1} \right].$$
(58)

Let us recall that for all $(\tau, \xi_1, \xi_2) \in V$, we have

$$\tau + \lambda(\xi_1, \xi_2) = 0,$$

using the fact that λ is homogenous of degree one, Euler formula implies that :

Once again thanks to (60) the second term in the right hand side of (64) becomes:

Combining equations (63), (64) and (65) we obtain:

$$v_{n_3,1}v_{n_2,2}v_{n_1,1}\overline{\xi}_1 = -v_{n_2,2}v_{n_1,1}\underline{\tau} + v_{n_3,2}v_{n_1,1}\underline{\tau} - v_{n_3,2}v_{n_2,1}\underline{\tau} - v_{n_1,2}v_{n_2,1}v_{n_3,2}\overline{\xi}_2.$$

Equality (57) follows from (58).

Thanks to Lemma 5.2, formulas (52)-(53) and (54) which give the unpolarized part of the amplitudes u_{1,n_i} , for i = 2, ..., 4 can be written under the more pleasant form:

 $(I - P_{n_2})u_{1,n_2} = -\frac{\overline{\xi}_2}{\underline{\xi}_1}\beta_1^{-1}(\mathscr{T}\mu_0)(\mathbf{t}_2, \mathbf{x}_2)R_{n_2}\mathscr{S}_{n_2}e,$ (66)

$$(I - P_{n_3})u_{1,n_3} = -\frac{\overline{\xi}_2}{\underline{\xi}_2} \prod_{j=1}^2 \beta_j^{-1}(\mathscr{T}\mu_0) (\mathbf{t}_3, \mathbf{x}_3) R_{n_3} \mathscr{S}_{n_3} e,$$
 (67)

$$(I - P_{n_4})u_{1,n_4} = -\frac{\overline{\xi}_2}{\overline{\xi}_1} \prod_{j=1}^3 \beta_j^{-1}(\mathscr{T}\mu_0) (\mathbf{t}_4, \mathbf{x}_4) R_{n_4} \mathscr{S}_{n_4} e,$$
 (68)

where the transport operator \mathcal{T} is defined in (51).

We thus remark that the unpolarized part of the amplitudes u_{1,n_j} , j = 1,...,4 depend of the same transport operator which is precisely the transport operator applied to μ_0 in equation (46).

Let us conclude this paragraph by the determination of the unpolarized part of the amplitudes $u_{1,j}$ for $\underline{i} \in \Phi(n_1) \setminus \{n_4\}$. The knowledge of these amplitudes will be useful in paragraph 5.1.5. From (42) and the relation (47), one easily obtains, that after the reformulation of $(I - P_{n_4})u_{1,n_4}$, we have :

5.1.3 Polarized part of the terms of order one.

The knowledge of the unpolarized part of the amplitudes of order one enable us to determine the polarized part of the amplitudes of order one, and will conclude the determination of the right hand side in equation (46).

Indeed, let us consider the equation (17) written for n = 1 and $k = n_j, j = 1, ...4$.. This equation reads:

$$i\mathscr{L}(d\varphi_{n_{j}})u_{2,n_{j}} + L(\partial)P_{1}^{n_{j}}u_{1,n_{j}} = -L(\partial)(I - P_{1})^{n_{j}}u_{1,n_{j}}, \text{ for } j \text{ odd,}$$

 $i\mathscr{L}(d\varphi_{n_{j}})u_{2,n_{j}} + L(\partial)P_{2}^{n_{j}}u_{1,n_{j}} = -L(\partial)(I - P_{2})^{n_{j}}u_{1,n_{j}}, \text{ for } j \text{ even.}$

Then a composition by $Q_1^{n_1}$, $Q_1^{n_3}$ in the first equation, and by $Q_2^{n_2}$, $Q_2^{n_4}$ in the second one, make the term depending of u_{2,n_j} disappear and from Lax lemma we obtain that the polarized parts of order one satisfy the transport equations:

with initial and boundary conditions given by (21)-(20). A preliminary to obtain the exact values of the solutions of (70)-(71) is thus to compute the source terms. This can be done thanks to the reformulation made in paragraph 5.1.2. Let us start by the term $Q_1^{n_1}L(\partial)(I-P_1)^{n_1}u_{1,n_1}$, from equation (50), an explicit computation gives:

Where we used the fact that $Q_1^{n_1}A_1R_1^{n_1}e=0$ (see paragraph 5.1.1 for more details).

To make this equation more explicit, as it as been done for the determination of the unpolarized parts of order one, we are looking for a relation linking $Q_1^{n_1}R_1^{n_1}e$ and $Q_1^{n_1}A_2R_1^{n_1}e$. Let us recall that $\ker Q_1^{n_1} = \operatorname{Ran} \mathscr{L}(d\varphi_{n_1})$ so for all $X \in \mathbb{C}^N$ we have $Q_1^{n_1}\mathscr{L}(d\varphi_{n_1})X = 0$. In particular, for $X = R_1^{n_1}e$ and we obtain:

Using this relation in (72) thus gives:

$$\left(t - \frac{1}{v_{n_{1},1}}x_{1}, x_{2} - \beta_{1}^{-1}x_{1}\right),$$

$$= -\left[Q_{1}^{n_{1}}R_{1}^{n_{1}}e\mathscr{T}^{2}\mu_{0}\right]\left(t - \frac{1}{v_{n_{1},1}}x_{1}, x_{2} - \beta_{1}^{-1}x_{1}\right),$$

$$(74)$$

where we recall that the transport operator \mathcal{T} is defined in (51).

Let us remark that, exactly as for the unpolarized part of amplitude of order one, the source term in (70) expresses in terms of the transport operator \mathcal{T} .

We then repeat the same kind of computations for the terms $Q_2^{n_2}L(\partial)(I-P_2)^{n_2}u_{1,n_2}$, $Q_1^{n_3}L(\partial)(I-P_1)^{n_3}u_{1,n_3}$ and $Q_2^{n_4}L(\partial)(I-P_2)^{n_4}u_{2,n_4}$. Using analogous relations as (73), more precisely:

and Lemma 5.2 in equations (66)-(67) and (??), some tedious (but explicit) computations give :

$$Q_1^{n_3}L(\partial)(I - P_1^{n_3})u_{1,n_3} = -\beta_1^{-2}\beta_2^{-2} \left(\frac{\overline{\xi}_2}{\underline{\xi}_2}\right)^2 \left[Q_1^{n_3}R_1^{n_3}\mathscr{S}^{n_3}e\mathscr{T}^2\mu_0\right](\underline{\mathbf{t}}_3,\underline{\mathbf{x}}_3),\tag{79}$$

$$Q_2^{n_4} L(\partial) (I - P_2^{n_4}) u_{1,n_4} = \prod_{j=1}^3 \beta_j^{-2} \left(\frac{\overline{\xi}_2}{\overline{\xi}_1} \right)^2 \left[Q_2^{n_4} R_2^{n_4} \mathscr{S}^{n_4} e \mathscr{T}^2 \mu_0 \right] (\underline{\mathbf{t}}_4, \underline{\mathbf{x}}_4). \tag{80}$$

More details about those computations can be find in Appendix 7.2.

Now that the source term in equation (70) is express in term of $\mathcal{T}^2\mu_0$, we can solve this equation in terms of $\mathcal{T}^2\mu_0$. Using the fact that $\ker B_1 = E_1^s(i\underline{\tau}, \overline{\xi}_2) = \operatorname{vect}\{e\}$, we write as in the beggining of paragraph 5.1:

where $\widetilde{Q_1^{n_1}}$ denotes the invert of the restriction of $Q_1^{n_1}$ to $\operatorname{Ran}P_1^{n_1}$ and where the trace function μ_{1,n_1} is a unknown. Then integrating along the characteristics give the eaxet value of ν_{1,n_1} (and thus $P_1^{n_1}u_{1,n_1}$) in terms of the unknown traces μ_0 , μ_1 . More precisely, we have to study two separates cases:

- $t \frac{1}{v_{n_1,1}x_1} < 0$. Then the transported information is above the characteristic, the transported condition is the initial condition. Moreover, as the function μ_0 is assumed to satisfy $\mu_{0|t\leq 0}$, one can checks on (74) that the transport associated to the source term in the interior is zero. Thus the associated solution is zero.
- $t \frac{1}{v_{n_1,1}x_1} > 0$. Then the transported information is bellow the characteristic, the transported condition is the boundary condition and this time the transport associated to the source term in the interior does not necessary vanish. Integrating along the characteristics give the explicit value:

$$= \mu_{1} \left(t - \frac{1}{v_{n_{1},1}} x_{1}; x_{2} - \beta_{1}^{-1} x_{1} \right) + c x_{1} \mathscr{T}^{2} \mu_{0} \left(t - \frac{s}{v_{n_{1},1}} x_{1}; x_{2} - \beta_{1}^{-1} x_{1} \right), \tag{83}$$

indeed, from the explicit value of the source term given in (74), one can easily checks that the source term lies along the characteristics, so the integral term is just a multiplication by a constant.

From this formula, and the formula giving the unpolarized part of u_{1,n_1} , we can thus give the following value for u_{1,n_1} :

from which, we deduce the value of $u_{1,n_{1}|_{x_{2}=0}}$ in terms of $\mathscr{T}\mu_{0}$ and μ_{1} :

$$u_{1,n_{1}|x_{2}=0} = \left[\mu_{1} + cx_{1}\mathcal{T}^{2}\mu_{0}e - \mathcal{T}\mu_{0}R_{n_{1}}e\right]\left(t - \frac{1}{v_{n_{1},1}}x_{1}, -\beta_{1}^{-1}x_{1}\right). \tag{84}$$

where c stands for an explicitely computable constant.

This trace then enable us to determine the amplitude u_{1,n_2} , then the amplitude u_{1,n_3} and finally the amplitude u_{1,n_4} and more precisely its trace on $\{x_1 = 0\}$ which appears in equation (46). Indeed, to fully determine u_{1,n_j} , j = 2, ..., 4 we just have to determine their polarized parts, thanks to paragraph 5.1.1. Let

$$P_2^{n_j}u_{1,n_j}(t,x) = \nu_{1,n_j}(t,x)e_j$$
, for $j = 2, 4, P_1^{n_j}u_{1,n_j}(t,x) = \nu_{1,n_j}(t,x)e_j$ for $j = 3,$

then, thanks to the uniform Kreiss-Lopatinskii condition and the fact that $n_2 \in \mathscr{I}_{oi}$, ν_{1,n_2} satisfy the transport equation :

$$\begin{cases}
(\partial_t + v_{n_2} \cdot \nabla_x) \nu_{1,n_1} = -\widetilde{Q_2^{n_2}} Q_2^{n_2} L(\partial) (I - P_2)^{n_2} u_{1,n_2}, \\
\nu_{1,n_{2|x_2=0}} = -\mathscr{S}^{n_2} u_{1,n_{1|x_2=0}} - \mathscr{S}^{n_2} (I - P_2^{n_2}) u_{1,n_{2|x_2=0}}, \\
\nu_{1,n_{2|t\leq 0}} = 0,
\end{cases} (85)$$

where the sources terms are given by (78), (84) and (66). We integrate along the characteristics, once again there are two cases to separate:

- $t \frac{1}{v_{n_2,2}x_2} \le 0$ The condition transported is the initial condition, and noticing that the source term in the interior is evaluated in $\underline{\mathbf{t}}_2(t,x) \le t \frac{1}{v_{n_2,2}x_2}$ (we recall that $\underline{\mathbf{t}}_2$ is defined in (30)) we deduce that the transport of the source term in the interior is also zero.
- $t \frac{1}{v_{n_2,2}x_2} > 0$ The condition transported is boundary condition. Integrate along the characteristics gives :

$$\nu_{1,n_2} = -\mathscr{S}^{n_2} \left[\mu_1 + cx_1 \mathscr{T}^2 \mu_0 e - \mathscr{T} \mu_0 R_{n_1} e \right] (\mathbf{t}_2, \mathbf{x}_2) + c_2 x_2 \mathscr{T}^2 \mu_0 (\underline{\mathbf{t}}_2, \underline{\mathbf{x}}_2),$$

where $c_2 := \beta_1^{-2} \left(\frac{\overline{\xi}_2}{\xi_1}\right)^2 \widetilde{Q}_2 Q_2^{n_2} R_2^{n_2} \mathscr{S}^{n_2} e$.

So at this stage, we obtain the polarized part of the amplitude $u_{n_2,1}$, from which we deduce the value of its trace on $\{x_1 = 0\}$. More precisely we have :

$$u_{n_{2},1} = -\left[\mathscr{S}^{n_{2}}\left[\mu_{1} + cx_{1}\mathscr{T}^{2}\mu_{0}e - \mathscr{T}\mu_{0}R_{n_{1}}e\right](\mathbf{t}_{2},\mathbf{x}_{2}) + c_{2}x_{2}\mathscr{T}^{2}\mu_{0}(\mathbf{t}_{2},\mathbf{x}_{2})\right]$$

$$-\frac{\overline{\xi}_{2}}{\underline{\xi}_{1}}\beta_{1}^{-1}(\mathscr{T}\mu_{0})(\mathbf{t}_{2},\mathbf{x}_{2})R_{n_{2}}\mathscr{S}_{n_{2}}e$$

$$-\frac{\overline{\xi}_{2}}{\underline{\xi}_{1}}\beta_{1}^{-1}(\mathscr{T}\mu_{0})(\mathbf{t}_{2},\mathbf{x}_{2})R_{n_{2}}\mathscr{S}_{n_{2}}e.$$
(86)

We then use this trace in the transport equation determining ν_{1,n_3} . Integrating along the characteristics we obtain the trace of $P_1^{n_3}u_{n_3,1}$. The important fact is that (as in the resolution of the resolution of (82) and (85)), the source term in the interior already lies along the characteristics so its contribution to the transport is just a multiplication by x_1 of itself. Moreover equations (86), (67) and (79) tell us that the source terms in the transport equation determining ν_{1,n_3} depends on μ_1 , $\mathcal{F}\mu_0$ and $\mathcal{F}^2\mu_0$, all evaluated in $(\mathbf{t}_2, \mathbf{x}_2)$. As a consequence $P_1^{n_3}u_{1,n_3}$ depends on μ_1 , $\mathcal{F}\mu_0$ and $\mathcal{F}^2\mu_0$, all evaluated in $(\mathbf{t}_3, \mathbf{x}_3)$, then from equation (67) so do u_{1,n_3} .

To conclude, we compute the trace of u_{1,n_3} on the set $\{x_2=0\}$ and we use it as a source term in the transport equation determining ν_{1,n_4} . Repeating exactly the same arguments we show that the $P_2^{n_4}u_{1,n_4}$ depends on μ_1 , $\mathcal{T}\mu_0$ and $\mathcal{T}^2\mu_0$, all evaluated in $(\mathbf{t}_4,\mathbf{x}_4)$. This fact implies that $P_2^{n_4}u_{1,n_4|_{x_1=0}}$ and from (68) $P_2^{n_4}u_{1,n_4|_{x_1=0}}$ depend on μ_1 , $\mathcal{T}\mu_0$ and $\mathcal{T}^2\mu_0$, all evaluated in (\mathbf{t},\mathbf{x}) .

As a consequence the right hand side of (46) has been expressed in terms of μ_1 , $\mathcal{T}\mu_0$ and $\mathcal{T}^2\mu_0$, all evaluated in $(\underline{\mathbf{t}},\underline{\mathbf{x}})$, more precisely (46) reads:

$$(\mathscr{T}\mu_0)(t,x_2) - (\widetilde{\mathbb{T}}\mu_0)(t,x_2) = \frac{i}{\kappa} \Big(-\widetilde{g}\delta_{1,M} + \mathscr{S}^{n_4}e\mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}}) \Big),$$

where $\widetilde{\mathbb{T}}$ is up to multiplications by some (possibly complicated functions) the sum of $\mathscr{T}\mu_0$ and $\mathscr{T}^2\mu_0$ followed by the evalutation in $(\underline{\mathbf{t}},\underline{\mathbf{x}})$. This reformulation is the keystone of our construction because its permits to factorize the transport phenomenon along the boundary in the left hand side to rewrite (46) under the form:

$$\left[(I - \widetilde{\mathbb{T}}) \mathscr{T} \mu_0 \right] (t, x_2) = \delta_{1, M} \widetilde{g} + \mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}),$$

where we set $\widetilde{\mu}_1 := \frac{i}{\kappa} \mathscr{S}^{n_4} e \mu_1$ and then drop the tilda and where we did the same operation (up to the sign) for \widetilde{g} .

In the following paragraph, we explain how this particular structure for equation (46) permit us to determine the unknown μ_0 .

5.1.4 Resolution of equation (46), preliminary study.

The resolution of equation (46) is based upon the study of the influence of the change of variables (\mathbf{t}, \mathbf{x}) on the profile spaces. But those spaces are not defined in the same way depending on the value of the dillatation parameter β . That is why the resolution of equation (46) needs to be discussed in two distincts frameworks.

The case $\beta < 1$, the information get closer of the corner. Before to solve equation (46) we give a useful property of the spaces of profiles $\mathscr{P}_{b,\leq}^{M-n}$:

Proposition 5.2 If $\mu \in \mathscr{P}_{b,\leq}^{M-n}$ then $\mu(\underline{\mathbf{t}},\underline{\mathbf{x}}) \in \mathscr{P}_{b,\leq}^{M-n+1}$.

Proof: We assume that M - n + 1 > 0 and M - n > 0, the other cases are similar and will not be demonstrate here.

In a first time we show that $\mu(\underline{\mathbf{t}},\underline{\mathbf{x}})$ is zero for $t\in]-\infty,\underline{T}_{M-n+1}[$. If $t<\underline{T}_{M-n}$ then so do $\underline{\mathbf{t}}<\underline{T}_{M-n}$ and it is automatic. So let us assume that $T_{M-n}< t<\underline{T}_{M-n+1}$ and $\underline{\mathbf{t}}<\underline{T}_{M-n+1}$. By definition of \mathscr{P}_b^{M-n} , $\mu(\underline{\mathbf{t}},x)$ is zero if $x<\beta^{M-n}\underline{y}_0$. Thus we restrict our attention to the case $x\geq \beta^{M-n}y_0$. We thus obtain that:

$$\underline{\mathbf{t}} < \underline{T}_{M-n+1} - \alpha \beta^{M-n} \underline{y}_0 = \underline{T}_{M-n},$$

from which it follows that $\mu(\underline{\mathbf{t}}, \cdot)$ is zero.

Now, let k be such that $M-n+1 \le k \le M$ and fix t in $[\underline{T}_k, \min(\underline{T}_{k+1}, T)]$, we will distinguish three cases depending of the value of $\underline{\mathbf{t}}$:

i) If $\underline{\mathbf{t}} < \underline{T}_{k-1}$ then it follows that :

$$\underline{T}_k < t < \alpha \beta^{-1} x + \underline{T}_{k-1}, \tag{87}$$

from which we deduce that $x > \beta^k y_0$. Consequently it is, in fact, not useful to study this case to show that $\mu(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ is zero for $x < \beta^k \underline{y}_0$.

- ii) If $\underline{T}_{k-1} < \underline{\mathbf{t}} < \underline{T}_k$ then by definition of $\mathscr{P}_{b,\leq}^{M-n}$, $\mu(\underline{\mathbf{t}},x)$ is zero for $x < \beta^{k-1}\underline{y}_0$ and as a consequence $\mu(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ is zero for $x < \beta^k \underline{y}_0$.
- iii) If $\underline{T}_k < \underline{\mathbf{t}}$ then we can repeat the argument applied in equation (87) to show that, this time, necessarily we have $\underline{y}_0 \beta^{k+1} > x$ for which we deduce that $\mu(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ is zero.

We also give a useful proposition concerning the influence of the change of variables $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ on the source term g. This proposition shows that even if g is not in some \mathscr{P}_h^k the change of variable $(\underline{\mathbf{t}},\underline{\mathbf{x}})$ has good properties on the support of g. More precisely:

Proposition 5.3 Let q be a smooth function which is zero for negative times and satisfying

$$\forall t > 0, \ g(t, x) = 0 \ \text{if } x < \underline{y}_0.$$

Then for all $l \in \mathbb{N}^*$, $g(\underline{\mathbf{t}}^l, \underline{\mathbf{x}}^l) \in \mathscr{P}_{h}^l$.

Proof: The proof pick up some ideas about the proof of Proposition 5.2. However, we give it for a sake of completness.

First let us show that $g(\underline{\mathbf{t}}^l,\underline{\mathbf{x}}^l)\in \mathscr{P}_{b,\leq}^l$ is zero for $t<\underline{T}_l$. If $\underline{t}^l<0$ is it trivial so let us assume that $\underline{\mathbf{t}}^l \geq 0$ and that $\underline{\mathbf{x}}^l \geq \underline{y}_0$, then for $t < \underline{T}_l$ we have the following bound :

$$\underline{\mathbf{t}}^{l} < \alpha \underline{y}_{0} \left(\sum_{j=0}^{l-1} \beta^{j} - \beta^{l} \sum_{j=1}^{l} \beta^{-j} \right) < 0,$$

which is a contradiction.

Now let fix k such that $l \leq k \leq M$ and a time $t \in [\underline{T}_k, \min(T, \underline{T}_{k+1})]$. Once again let us assume that $\underline{\mathbf{t}}^l > 0$, so $g(\underline{\mathbf{t}}^l, \underline{\mathbf{x}}^l)$ is zero if $\underline{\mathbf{x}}^l < y_0$, from the support property of g. In other word $g(\underline{\mathbf{t}}^l, \underline{\mathbf{x}}^l)$ is zero for $x < \beta^l y_0$. But using the fact that $\beta \le 1$ and that $l \le k$ it follows that in particular $g(\underline{\mathbf{t}}^l, \underline{\mathbf{x}}^l)$ is zero for $x < \beta^k y_0$

Now it is time to study equation (46). At the end of the previous paragraph we explained why (46) could be rewritten under the form:

$$\left[(I - \widetilde{\mathbb{T}})(\mathscr{T}\mu_0) \right] (t, x_2) = \widetilde{g}\delta_{M,1} + \mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}), \tag{88}$$

where the operator $\widetilde{\mathbb{T}}$ reads⁴:

$$(\widetilde{\mathbb{T}}u)(t,x_2) := c_1 u(\underline{\mathbf{t}}(t,x_2),\underline{\mathbf{x}}(x_2)) + c_2(t,x_2)(\mathscr{T}u)(\underline{\mathbf{t}}(t,x_2),\underline{\mathbf{x}}(x_2)).$$

⁴Notice that the precise values of the constant c_1 and of the function c_2 can be exactly express from equations (68) and explicit computations in the resolution of the transport equations mentionned in paragraph 5.1.3. However, it is useless for our purpose.

The idea of the resolution is to remark that the operator $\widetilde{\mathbb{T}}$ is expressed in the variables $(\underline{\mathbf{t}},\underline{\mathbf{x}})$ and thus "cost" in terms of time of travel the time needed to make one complete circuit around the loop. Thus as we arrange the things in such a way that we can only make M turns around the loop, one can always invert $I-\widetilde{\mathbb{T}}$ by taking the Neuman serie expansion. Indeed, the terms associated with $\widetilde{\mathbb{T}}^j$ with j big "cost too much time" to appear and consequently they are zero. Then one shows that we can repeat exactly the same reasoning to show that we can express μ_0 in terms of μ_2 (the scalar component of the unknown trace u_{2,n_1}) and so on to express μ_0 in terms of some μ_k (the scalar component of the unknown trace u_{k,n_1}) for k as big as we want and in terms of the source term g. However, the trace μ_0 in fact does not depend on μ_k for k big, because this should say that we have made k complete circuits around the loop. We thus determine μ_0 in terms of g only.

Formally, we can always invert the operator $(I - \widetilde{\mathbb{T}})$ appearing in equation (88) by taking the Neumann serie expansion. This gives the formal value of $\mathscr{T}\mu_0$:

$$(\mathscr{T}\mu_0)(t,x) = \sum_{j\geq 0} \widetilde{\mathbb{T}}^j \widetilde{g}(t,x) + \sum_{j\geq 0} \widetilde{\mathbb{T}}^j \mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}}). \tag{89}$$

Let us remark that the second sum in the right hand side of (89) reads:

$$\sum_{j\geq 1} (F_j(\mu_1))(\underline{\mathbf{t}}^j, \underline{\mathbf{x}}^j), \tag{90}$$

where the operators $F_j(\mu_1)$ are some explicitly computable operators and where $\underline{\mathbf{t}}^j$ and $\underline{\mathbf{x}}^j$ denote that we made the change of variables $(t, x) \to (\underline{\mathbf{t}}(t, x), \underline{\mathbf{t}}(x))$ j times that is:

$$\underline{\mathbf{t}}^j = \underline{\mathbf{t}}^j(t, x) := t - \alpha \sum_{l=0}^j \beta^{-j} x \text{ and } \underline{\mathbf{x}}^j = \underline{\mathbf{x}}^j(x) := \beta^{-j} x.$$

Now remember that by definition of the profiles spaces see Definition 5.2 we are looking for μ_1 to be in $\mathscr{P}_{b,\leq}^{M-1}$, so using the fact that the operators F_j are sums of derivatives (up to some multiplication by known functions), it follows that the $F_j(\mu_1)$ are in $\mathscr{P}_{b,\leq}^{M-1}$. Proposition 5.2 shows that $F_j(\mu_1)(\underline{\mathbf{t}}^j,\underline{\mathbf{x}}^j)$ is in $\mu_1 \in \mathscr{P}_{b,\leq}^{M-1+j}$. In the same way Proposition 5.3 applied to the first sum in the right hand side of (89) shows that this sum contains at most M terms.

As a consequence, equation (89) in fact reads:

$$(\mathscr{T}\mu_0)(t,x) = \sum_{j=0}^{M} \widetilde{\mathbb{T}}^j \widetilde{g}(t,x) + \mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}}), \tag{91}$$

which gives a (rigorous, because the Neumann expansion for $(I - \widetilde{\mathbb{T}})$ is finite) value of $(\mathcal{T}\mu_0)$ in terms of the (still) unknown function $\mu_1 \in \mathcal{P}_b^{M-1}$. In terms of wave packets propagation (91) tell us that μ_0 , compared to the others terms in the WKB expansion, only depends on μ_1 which has made a complete circuit around the loop. This fact agrees whith the intuition given in paragraph 3.1 that the amplitude u_{0,n_1} does not depend of the amplitudes u_{n,n_1} because theses amplitudes do not have achieve enough complete circuits around the loop. Let us also stress that the term depending of \widetilde{g} in the right hand side of (91) starts to be evaluated in (t,x) while the term depending of μ_1 is evaluated in (t,x). This will be a crucial point in the following.

Assume that μ_1 is a known function in $\mathscr{P}_{b,\leq}^{M-1}$, then is it easy to compute μ_0 : Indeed, by definition of the transport operator \mathscr{T} , μ_0 thus satisfies the transport equation:

operator
$$\mathcal{S}$$
, μ_0 thus satisfies the transport equation:
$$\begin{cases}
\partial_t \mu_0 - \frac{\tau}{\underline{\xi}_2} \partial_2 \mu_0 = \sum_{j=0}^M \widetilde{\mathbb{T}}^j \widetilde{g} + \mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}), \\
\mu_{0|x_2=0} = 0, \\
\mu_{0|t \le 0} = 0,
\end{cases}$$
(92)

which can be integrated along the characteristics to obtain the value of μ_0 . Let us denote by K the application that to a given source term in the interior for the transport equation (92) associate the solution of the transport equation (92). We can thus write:

$$\mu_0 = K \left(\sum_{j=0}^M \widetilde{\mathbb{T}}^j \widetilde{g} + \mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}) \right). \tag{93}$$

Let us remark that as we assumed that $-\frac{\mathbb{Z}}{\xi_2} > 0$, the transport operator \mathscr{T} "pushes" the information away from the corner. As a consequence, integrating (92) along the characteristics show that applying the operator K does not destroy the property to be zero on the strip $\{t \in \mathbb{R}, 0 < x < Y\}$, for Y > 0. This remark shows the following proposition:

Proposition 5.4 Let K be defined previously. If $\mu \in \mathscr{P}_b^k$, for some $k \in \mathbb{N}$, then $K\mu \in \mathscr{P}_b^k$

We thus have

$$\mu_0 = K \left(\sum_{j=0}^M \widetilde{\mathbb{T}}^j \widetilde{g} + \mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}) \right), \tag{94}$$

so to know μ_0 we have to determine the value of the right hand side of (89) in term of the amplitude of the source term of the corner problem (12) g and not in term of the unknown amplitude μ_1 evaluated in $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$.

Let us also remark that equation (94) meets with the intuition, described in paragraph 3.1, that u_{0,n_1} is "turned on" by the amplitude u_{1,n_1} which has made one complete circuit around the loop. Moreover, formally, if μ_1 is in $\mathscr{P}_{b,\leq}^{M-1}$ then Proposition 5.2 implies that $\mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}})$ is in $\mathscr{P}_{b,\leq}^M$ and using the fact that spaces $\mathscr{P}_{b,\leq}^k$ are invariants sets for the operator K (see Proposition 5.4 for more details) then equation (94) should give, as expected, a trace μ_0 in $\mathscr{P}_{b,\leq}^M$.

In the following paragraph, we show that the unknown trace μ_1 can be expressed in terms of the unknown scalar part of the trace μ_2 and μ_0 . But before that let us give some elements about the resolution of equation (46) in the case $\beta > 1$.

The case $\beta > 1$, the information does not approach the corner. As for the case $\beta \leq 1$ we start by a study of the influence of the change of variables $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ on the set of profiles $\mathscr{P}_{b,>}^{M-n}$.

Proposition 5.5 If $\mu \in \mathscr{P}_{b,>}^{M-n}$, then $\mu(\underline{\mathbf{t}},\underline{\mathbf{x}}) \in \mathscr{P}_{b,>}^{M-n+1}$. In particular, $\mu(\underline{\mathbf{t}}^j,\underline{\mathbf{x}}^j)$ is zero for l larger than n+1.

The proof of this proposition is based on the same ideas than the proof of Proposition 5.2. However as this proof is simpler than the proof of Proposition 5.2, will not write this proof here.

Let us also note that thanks to the conditions imposed on the source term g, Proposition 5.3 is trivial in the framework $\beta > 1$.

With Proposition 5.5 in hand it is then easy to show that the Neumann serie expansion associated with equation (88) contains a finite number of nonzero terms. One can thus reiterate the arguments described in the framework $\beta \leq 1$, to show that (94) holds even for $\beta > 1$.

5.1.5 The equation on μ_n , n > 0.

In this paragraph we give an equation determining the unknown scalar part of the trace $u_{n,n_{1|x_{1}=0}}$ for all $n \in \mathbb{N}^*$. As the reader may notice, this equation will look like the equation (46) determining μ_0 , up to some extra terms due to the fact that the amplitudes u_{n,n_1} are not polarized for $n \in \mathbb{N}^*$.

As for the unknown μ_0 , to obtain this new equation we study the boundary condition (20) written for $j = n_1$:

$$B_1 \left[\sum_{j \in \Phi(n_1)} u_{n,j} \right]_{|x_1=0} = \delta_{n,M+1}g.$$

And we write this equation under the form:

$$B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} P_1^j u_{n,j} \right]_{|x_1 = 0} + B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} (I - P_1^j) u_{n,j} \right]_{|x_1 = 0} = \delta_{n,M+1} g - B_1 u_{n,n_4|x_1 = 0}.$$
(95)

According to Proposition 4.1, the first term in the left hand side of (95) is in $B_1E_1^s(i\underline{\tau}, \overline{\xi}_2)$. So taking the inner product of (95) by the vector b defined in Definition 2.7 gives:

$$b \cdot B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} (I - P_1^j) u_{n,j} \right]_{|x_1 = 0} = b \cdot \delta_{n,M+1} g - b \cdot B_1 u_{n,n_4|x_1 = 0}, \tag{96}$$

where we used the cascade of equations (17). But now, let us recall that from the cascade of equations (17) we know that:

$$(I - P_1^j)u_{n,j} = iR_1^j L(\partial)u_{n-1,j} = iR_1^j L(\partial) \left(P_1^j u_{n-1,j} + (I - P_1^j)u_{n-1,j} \right),$$

and using this relation in equation (96) lead us to the following relation:

$$ib \cdot B_{1} \left[\sum_{j \in \Phi(n_{1}) \setminus \{n_{4}\}} R_{1}^{j} L(\partial) P_{1}^{j} u_{n-1,j} \right]_{|x_{1}=0} = b \cdot \delta_{n,M+1} g - b \cdot B_{1} u_{n,n_{4}|x_{1}=0}$$

$$- ib \cdot B_{1} \left[\sum_{j \in \Phi(n_{1}) \setminus \{n_{4}\}} R_{1}^{j} L(\partial) (I - P_{1}^{j}) u_{n-1,j} \right]_{|x_{1}=0}$$
(97)

We thus apply Proposition 5.1 to obtain that:

$$\mathscr{T}\mu_{n-1} = b \cdot \delta_{n,M+1}g - b \cdot B_1 u_{n,n_{4|x_1=0}} - ib \cdot B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j L(\partial)(I - P_1^j) u_{n-1,j} \right]_{|x_1=0}, \quad (98)$$

which tells us that the scalar unknown part of the amplitude u_{n-1,n_1} , namely μ_{n-1} , satisfies the same transport equation as μ_0 up to the extra "source term" g, in the particular setting n=M+1, and $-ib \cdot B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j L(\partial) (I-P_1^j) u_{n-1,j} \right]_{|x_1=0}$. We can reiterate the computations made in paragraphs 5.1.1 and 5.1.3 to make the terms $b \cdot B_1 u_{n,n_4|x_1=0}$ explicit in terms of μ_{n-1} and μ_n . We thus obtain :

$$\begin{bmatrix}
(I - \widetilde{\mathbb{T}})\mathscr{T}\mu_{n-1} \end{bmatrix}(t, x_2) = b \cdot \delta_{n,M+1}g(t, x_2) + \mu_n(\underline{\mathbf{t}}, \underline{\mathbf{x}}) \\
- ib \cdot B_1 \left[\sum_{j \in \Phi(n_1) \setminus \{n_4\}} R_1^j L(\partial)(I - P_1^j) u_{n-1,j} \right]_{|x_1 = 0} (t, x_2).$$
(99)

Then we reiterate the computations of paragraph 5.1.1 to treat the last term in the right hand side of (99). First of all let us remark that the terms $(I - P_1^j)u_{n-1,j}$ for $j \neq n_1, n_4$ are given by equation (69) for n = 2 but which is totally similar for n > 2. So after having applied the operator $R_1^j L(\partial)$ and taking the trace on $\{x_1 = 0\}$ one can show that the sum on $j \in \Phi^*(n_1) \setminus n_4$ appearing in the right hand side of (99) depends on $\mu_{n-2}(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ (and possibly of the source term g). That is why we write

$$\left[\sum_{j\in\Phi^*(n_1)\setminus\{n_4\}} R_1^j L(\partial)(I-P_1^j) u_{n-1,j}\right]_{|x_1=0} = (\Lambda_1 \mu_{n-2})(\underline{\mathbf{t}},\underline{\mathbf{x}}),$$

where Λ_1 is some explicitely computable operator which is a sum of derivatives up to some multiplications. However its exact expression is not interesting for our purpouse.

The same argument for $(I - P_1^{n_1})u_{n-1,n_1}$ (which is given by (50) in the case n = 2, but which is totally similar when n > 2) then show that we can write:

$$[R_1^{n_1}L(\partial)(I-P_1^{n_1})u_{n-1,n_1}]_{|x_1=0} = (\Lambda_0\mu_{n-2})(t,x),$$

where Λ_0 is an operator like Λ_1 .

We can thus write (99) under its final form that is:

$$\left[(I - \widetilde{\mathbb{T}}) \mathscr{T} \mu_{n-1} \right] (t, x_2) = \delta_{n, M+1} \widetilde{g}(t, x_2) + \mu_n(\underline{\mathbf{t}}, \underline{\mathbf{x}}) + (\Lambda \mu_{n-2})(t, x_2), \tag{100}$$

where we set $\Lambda u := (\Lambda_0 u)(t, x) + (\Lambda_1 u)(\underline{\mathbf{t}}, \underline{\mathbf{x}})$. The only point to keep in mind about Λ is that it is a sum (up to some multiplications) of derivatives. As a consequence, the spaces \mathscr{P}_b^k are invariant sets for the operator Λ .

5.1.6 End of the resolution of equation (46).

Will we in this paragraph give the end of the resolution of equation (46) in the case $\beta \leq 1$. Indeed as we will see this resolution does not take into account the value of β but only need Proposition 5.2. But Proposition 5.2 has its analogous in the case $\beta > 1$ (that is to say Proposition 5.5). That is why we feel free to denote the profil space \mathscr{P}_b^{M-n} in place of $\mathscr{P}_{b,\leq}^{M-n}$, in view to shorten the notations.

Let us recall that at the end of paragraph 5.1.4 we write equation (46) under the form:

$$\mu_0 = \kappa \left(\mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}) \right),$$

from which we deduced that under the assumption that $\mu_1 \in \mathscr{P}_b^{M-1}$ then $\mu_0 \in \mathscr{P}_b^M$. Until now, we will assume that the forall $1 \leq n \leq M+1$, $\mu_n \in \mathscr{P}_b^{M-n}$. Our aim is then to show that under this assumption (94) define a unique $\mu_0 \in \mathscr{P}_b^M$ and to express this μ_0 as a function of the source term.

Using the analysis described in the previous paragraph we are now able to express the unknown μ_1 . Indeed, (100) written for n=2 reads:

$$\left[(I - \widetilde{\mathbb{T}}) \mathscr{T} \mu_1 \right] (t, x_2) = \delta_{M,2} \widetilde{g}(t, x_2) + \mu_2(\underline{\mathbf{t}}, \underline{\mathbf{x}}) + (\Lambda \mu_0)(t, x).$$
 (101)

Using the fact that μ_0 is in \mathscr{P}_b^M and the fact that Λ keep \mathscr{P}_b^M we obtain that the term $(\Lambda \mu_0)(t,x)$ appearing in (101) is in \mathscr{P}_b^M . As in paragraph 5.1.4, we write the Neumann serie expansion associated to (101). Proposition 5.2 shows that this expansion contains only two terms, and reads:

$$(\mathscr{T}\mu_1)(t,x) := \delta_{M,1}\left(\widetilde{g}(t,x) + \widetilde{\mathbb{T}}\widetilde{g}(\underline{\mathbf{t}},\underline{\mathbf{x}})\right) + \left(\mu_2(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \widetilde{\mathbb{T}}\mu_2(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2)\right) + \Lambda\mu_0(t,x). \tag{102}$$

Up to the source term in the interior, μ_0 and μ_1 solve the same transport equation and we can write :

$$\mu_1(t,x) = \kappa \left(\delta_{M,1} \left(\widetilde{g}(t,x_2) + \widetilde{\mathbb{T}} \widetilde{g}(\underline{\mathbf{t}},\underline{\mathbf{x}}) \right) + \left(\mu_2(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \widetilde{\mathbb{T}} \mu_2(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2) \right) + \Lambda \mu_0(t,x_2) \right). \tag{103}$$

where we recall that κ is the operator that to a source term f associates the solution of the transport equation $\mathcal{T}u = f$. Then when one evaluate (103) in $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$, he obtains, using Propositions 5.2 and 5.3, that:

$$\mu_1(\underline{\mathbf{t}}, \underline{\mathbf{x}}) = \kappa \left(\delta_{M,1} \widetilde{g}(\underline{\mathbf{t}}, \underline{\mathbf{x}}) + \mu_2(\underline{\mathbf{t}}^2, \underline{\mathbf{x}}^2) \right). \tag{104}$$

Let us stress that (104) written in this form is not true. Indeed in this formulation, we used the fact that κ and the evaluation $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ commute which is is clearly false. However we are in this purpose only interested in the profile spaces in which the terms in the right hand side of (104) lies. As from Proposition 5.4, κ keeps the spaces \mathscr{P}_b^{M-n} invariant, our abuse of notations is not so important and we will do it until the end of the proof in view to simplify as much as possible the formulas. But the reader has to keep in mind that if he really want to compute the WKB expansion it is necessary to apply κ and then make the evaluation $(\underline{\mathbf{t}}, \underline{\mathbf{x}})$.

From (94) and (104) we deduce that

$$\mu_0(t,x) = \kappa \mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}}) = \kappa^2 \left(\delta_{M,1} \widetilde{g}(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \mu_2(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2) \right), \tag{105}$$

equation which tell us that μ_0 can be express in terms of μ_2 evaluated in a time corresponding to two complete circuits around the loop.

More generally, we can apply the same arguments as those used for n = 1 in (100) to obtain the formula : for all n > 0:

$$\mu_n(t, x_2) = \kappa \left(\delta_{n, M} \sum_{k=0}^{M} \widetilde{\mathbb{T}}^k \widetilde{g}(\underline{\mathbf{t}}^k, \underline{\mathbf{x}}^k) + \sum_{k=1}^{\min(n+1, M)} \widetilde{\mathbb{T}}^{k-1} \mu_{n+1}(\underline{\mathbf{t}}^k, \underline{\mathbf{x}}^k) + \sum_{k=0}^{\min(n-1, M)} \widetilde{\mathbb{T}}^k \Lambda \mu_{n-1}(\underline{\mathbf{t}}^k, \underline{\mathbf{x}}^k) \right).$$
(106)

And, under the assumption that for all $0 < n \le M+1$, $\mu_n \in \mathscr{P}_b^{M-n}$, those formulas make sense for $0 < n \le M$ (because under these assumption we can really ensure that the Neumann serie expansion contains a finite number of terms). We deduce from (106) that for all $l \le M$:

$$\mu_{n}(\underline{\mathbf{t}}^{l},\underline{\mathbf{x}}^{l}) = \kappa \left(\delta_{n,M} \sum_{k=l}^{M} \widetilde{\mathbb{T}}^{k} \widetilde{g}(\underline{\mathbf{t}}^{k},\underline{\mathbf{x}}^{k}) + \sum_{k=l+1}^{\min(n+1,M)} \widetilde{\mathbb{T}}^{k-1} \mu_{n+1}(\underline{\mathbf{t}}^{k},\underline{\mathbf{x}}^{k}) + \sum_{k=l}^{\min(n-1,M)} \widetilde{\mathbb{T}}^{k} \Lambda \mu_{n-1}(\underline{\mathbf{t}}^{k},\underline{\mathbf{x}}^{k}) \right),$$
(107)

from which we deduce that for all n < M, each $\mu_n(\underline{\mathbf{t}}^n, \underline{\mathbf{x}}^n)$ is equal to $\mu_{n+1}(\underline{\mathbf{t}}^{n+1}, \underline{\mathbf{x}}^{n+1})$, and that for n = M, $\mu_n(\underline{\mathbf{t}}^n, \underline{\mathbf{x}}^n)$ is equal to $g(\underline{\mathbf{t}}^M, \underline{\mathbf{x}}^M)$. A simple recurrence in (105) then shows that:

$$\mu_0(t, x_2) = \kappa^{M+1} g(\underline{\mathbf{t}}^M, \underline{\mathbf{x}}^M), \tag{108}$$

equation determining in a unique way $\mu_0 \in \mathscr{P}_b^M$ in terms of the known source term g. This conclude the resolution of equation (46).

Let us notice that (108) meet with the intuition described in 3.1 that μ_0 depends of the information that was present at time zero that has made M complete circuits around the loop.

5.2 Determination of the others amplitudes in the WKB expansion.

Once the amplitudes of the loop indeces are constructed it is easy to construct the amplitudes for the other indeces in the WKB expansion. The construction and, in particular, the order of resolution is exactly the same as the order used in [Ben] so we will not give all the details here. We refer to [Ben] for a complete proof.

5.2.1 Determination of the oscillating amplitudes.

Let us recall that thanks to Proposition 4.3 we know that the set of indexes $\mathscr{I}_{os} \setminus \{n_j\}$ can expressed as a partition (see (10) for more details). We will here describe the determination of an arbitrary oscillating amplitude associated to an index \underline{i} in one of the trees A_{ℓ_1} . The determination for the other sets composing (10) is similar and will not be discuss here.

Let us denote by $\ell_{\underline{i}} := (\ell_1, \ell_2, \ell_p)$ the type V sequence linking n_1 to \underline{i} . Then to determine the amplitude associated to \underline{i} we will determine all the amplitudes in the sequence ℓ . First thanks to Proposition 4.4, $\ell_1 \in \mathscr{I}_{oi}$ and we know that the amplitude u_{0,ℓ_1} satisfies the transport equation:

$$\begin{cases} (\partial_t + v_{\ell_1} \cdot \nabla_x) P_2^{\ell_1} u_{0,\ell_1} = 0, \\ P_2^{\ell_1} u_{0,\ell_1}|_{x_2=0} = P_2^{\ell_1} B_2 u_{0,n_1}|_{x_2=0}, \\ u_{0,\ell_1}|_{t<0} = 0, \end{cases}$$

with a known source term on the boundary since u_{0,n_1} and consequently $u_{0,n_1|_{x_2=0}}$ as already been determinated. So we can integrate this transport equation along the characteristics to determine u_{0,ℓ_1} . Notice that the amplification of order M+1 then spreads after a time strictly more than \underline{T}_M to u_{0,ℓ_1} .

Then we construct u_{0,ℓ_2} . Thanks to Proposition 4.4, $\ell_2 \in \mathscr{I}_{io}$ and to determine u_{0,ℓ_2} we have to solve the transport equation :

$$\begin{cases} (\partial_t + v_{\ell_2} \cdot \nabla_x) P_1^{\ell_2} u_{0,\ell_2} = 0, \\ P_1^{\ell_2} u_{0,\ell_{2|x_1=0}} = P_1^{\ell_2} B_1 u_{0,\ell_{1|x_1=0}}, \\ u_{0,\ell_{2|t \le 0}} = 0, \end{cases}$$

which is easy because the source term have already been constructed.

Then we can repeat this process until we reach \underline{i} . Notice that in the particular case $\underline{i} \in \mathscr{I}_{ii}$ we need to solve the transport equation :

$$\begin{cases} (\partial_t + v_{\underline{i}} \cdot \nabla_x) P_1^{\underline{i}} u_{0,\underline{i}} = 0, \\ P_1^{\underline{i}} u_{0,\underline{i}|x_1=0} = -S_1^{\underline{i}} B_1 u_{0,\ell_{p|x_1=0}}, \\ P_1^{\underline{i}} u_{0,\underline{i}|x_2=0} = 0, \\ u_{0,\underline{i}|t \le 0} = 0, \end{cases}, \begin{pmatrix} \operatorname{resp} \left\{ \begin{array}{l} (\partial_t + v_{\underline{i}} \cdot \nabla_x) P_2^{\underline{i}} u_{0,\underline{i}} = 0, \\ P_2^{\underline{i}} u_{0,\underline{i}|x_1=0} = 0, \\ P_2^{\underline{i}} u_{0,\underline{i}|x_2=0} = -S_2^{\underline{i}} B_2 u_{0,\ell_{p|x_2=0}}, \\ u_{0,\underline{i}|t \le 0} = 0, \end{array} \right. \end{cases}$$

if p is odd (resp. even) and we use the fact that the trace of u_{0,ℓ_p} on $\{x_1=0\}$ (resp. $\{x_2=0\}$) is zero near the corner (see [Ben] for more details) to ensure that $u_{0,i}$ is regular enough.

5.2.2 Determination of the evanescent amplitudes.

In this paragraph we conclude the construction of the leading order of the geometric optics expansion by giving elements of proof to construct the determination of an arbitrary evanescent amplitude lying in one of the trees A_{ℓ_1} . Without loss of generality let us assume that this amplitude is associated to an index $\underline{i} \in \mathfrak{R}_1$. Proposition 4.4 then implies that the type V sequence $\ell_{\underline{i}} := (\ell_1, \ell_2, \ell_p)$ linking n_1 to \underline{i} has an odd number of terms. Moreover, we can assume that the amplitude associated to the index ℓ_j have already been constructed. We then recall the following lemma due to Lescarret which states that the evanescent equations in the cascade (17) can be solved in the profile space $\mathbb{P}_{ev,1}$:

Lemma 5.3 For j = 1, 2, and $\underline{k} \in \mathfrak{R}_i$, let

$$\mathbb{P}^{\underline{k}}_{ev,j}U(X_j) := e^{X_j \mathscr{A}_j(\underline{\tau}, \xi_{3-j}^{\underline{k}})} P^{\underline{k}}_{s,j}U(0), \tag{109}$$

$$\mathbb{Q}^{\underline{k}}_{ev,j}F(X_j) := \int_0^{X_j} e^{(X_j-s)\mathscr{A}_j(\underline{\tau},\xi_{3-j}^{\underline{k}})} P^{\underline{k}}_{s,j} A_j^{-1} F(s) ds - \int_{X_j}^{+\infty} e^{(X_j-s)\mathscr{A}_j(\underline{\tau},\xi_{3-j}^{\underline{k}})} P^{\underline{k}}_{u,j} A_i^{-1} F(s) d\underline{s} 10)$$

Then, for all $F \in P_{ev,j}$ the equation :

$$L_{\underline{k}}(\partial_{X_i})U = F,$$

admits a solution in $P_{ev,i}$. Moreover, this solution reads:

$$U = \mathbb{P}^{\underline{k}}_{ev,i}U + \mathbb{Q}^{\underline{k}}_{ev,i}F.$$

This lemma tell us that to construct any evanescent for the side $\partial\Omega_1$ amplitude it is in fact sufficient to know the value of the trace the solution on $\{X_1 = 0\}$. As already mentionned in [Les07], to determine this trace we study the boundary condition (20) written for $k = \underline{i}$ and n = 0 from which we deduce the value of the "double" trace on $\{X_1 = x_1 = 0\}$. Indeed, from uniform Kreiss-Lopatinskii condition we obtain:

$$U_{0,i,k_{|X_1=x_1=0}} = -S_{ev,1}^{\underline{i}} B_1 u_{0,\ell_{p|x_1=0}},$$

where we recall that the right hand side is supposed to be known.

Then we are free to straighten the "double" trace into a single one by setting (for example):

$$U_{0,\underline{i},k_{|X_1=0}} = -\chi(x_1)S_{ev,1}^{\underline{i}}B_1u_{0,\ell_{p|_{x_1=0}}},$$

where χ is some function in $\mathcal{D}(]-1,+\infty[)$ satisfying $\chi(0)=1$.

It is interesting to remark that the evanescents amplitudes suffer the same amplification as the oscillating ones and this even if the degeneray of the uniform Kreiss-Lopatinskii condition is in the hyperbolic region. As for the oscillating amplitudes, one can show that evanescents amplitudes of order zero are zero for t less than T_M .

5.3 Construction of the higher order terms and summary.

5.3.1 The term of order one.

Once the amplitudes of order zero, and more precisely the keystone μ_0 , are determinated we can repeat our method of construction to determine the amplitudes of order one. As for the leading order, we start by the determination of the indeces of the loop. Let us remark that thanks to equations (50)-(66)-(67) and (68), we know the unpolarized parts of the u_{1,n_j} , j = 1...4 in terms of μ_0 . Similarly we also know the values of the polarized parts in terms of μ_1 .

So we just have to determine the unknown trace μ_1 to construct the amplitudes of order one for the loop elements. Then noticing that we know the unpolarized part of the indexes outside of the loop (because they only depend of the associated amplitude of order zero) and reiterating the

same computations as in paragraph 5.2 permit to determine their polarized part in term of μ_1 . As a consequence we just have to determine μ_1 to construct all the amplitudes of order one.

To do this, let us recall that, from paragraph 5.1.4, μ_1 satisfies equation (103), that is

$$(\mathscr{T}\mu_1)(t,x) := \delta_{M,2} \left(\widetilde{g}(t,x) + \widetilde{\mathbb{T}} \widetilde{g}(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \widetilde{\mathbb{T}}^2 \widetilde{g}(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2) \right) + \left(\mu_2(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \widetilde{\mathbb{T}} \mu_2(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2) \right) + \Lambda \mu_0(t,x).$$
(111)

where μ_2 , appearing in the right hand side, is assumed to be \mathscr{P}_b^{M-2} and where we used the same notations of paragraph 5.1.4. Let us remark that in terms of wave packets propagation, equation (111) tells us that μ_1 depends on two terms. More precisely a term which is nonzero after the time \underline{T}_{M-1} and which corresponds to μ_2 which had the time to make one complete circuit around the loop and a second term which is nonzero after the time \underline{T}_M corresponding to μ_2 which had the time to make two complete circuits around the loop.

Let us use equation (100) written for n=3 to express the right hand side of (111) in terms of μ_3 :

$$(\mu_2)(t,x) = K\left(\mu_3(\underline{\mathbf{t}},\underline{\mathbf{x}}) + \widetilde{\mathbb{T}}\mu_3(\underline{\mathbf{t}}^2,\underline{\mathbf{x}}^2) + \widetilde{\mathbb{T}}^2\mu_3(\underline{\mathbf{t}}^3,\underline{\mathbf{x}}^3)\right) + \delta_{2,M}\kappa\left(g + \widetilde{\mathbb{T}}g + \widetilde{\mathbb{T}}^2g\right) + \kappa\mu_1(\underline{\mathbf{t}},\underline{\mathbf{x}}).$$
(112)

The new difficulty in (111) compared to (94) is that the term $(\Lambda \mu_1)(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ lies in $\mathscr{P}_{b,\leq}^M$ and is a priori not zero. However in (111) we are not interested in μ_2 but we are interested in $\mu_2(\underline{\mathbf{t}}, \underline{\mathbf{x}})$ and $\mu_2(\underline{\mathbf{t}}^2, \underline{\mathbf{x}}^2)$. A simple change of variables in (112) shows that these quantities are given by:

$$\mu_{2}(\underline{\mathbf{t}}, \underline{\mathbf{x}}) = K\left(\mu_{3}(\underline{\mathbf{t}}^{2}, \underline{\mathbf{x}}^{2}) + \widetilde{\mathbb{T}}\mu_{3}(\underline{\mathbf{t}}^{3}, \underline{\mathbf{x}}^{3})\right) + \delta_{2,M}\kappa(g),$$

$$\mu_{2}(\underline{\mathbf{t}}^{2}, \underline{\mathbf{x}}^{2}) = K\left(\mu_{3}(\underline{\mathbf{t}}^{3}, \underline{\mathbf{x}}^{3})\right) + \delta_{2,M}\kappa(g),$$

and the term $(\Lambda \mu_1)(\underline{\mathbf{t}}, \underline{\mathbf{x}})$, which could have been a problem when one reinjectes (112) in (111), in fact disappears, and we thus obtain :

$$(\mu_{1})(t,x) = K\left(K\left(\mu_{3}(\underline{\mathbf{t}}^{2},\underline{\mathbf{x}}^{2}) + \widetilde{\mathbb{T}}\mu_{3}(\underline{\mathbf{t}}^{3},\underline{\mathbf{x}}^{3})\right) + \delta_{2,M}\kappa\left(g + \mathbb{T}g\right) + \widetilde{\mathbb{T}}K\left(\mu_{3}(\underline{\mathbf{t}}^{3},\underline{\mathbf{x}}^{3})\right) + \delta_{2,M}\kappa\left(g\right) + \delta_{1,M}\kappa\left(g + \widetilde{\mathbb{T}}g\right).$$

A simple reiteratif process, analogous to those used in paragraph 5.1.6, then shows that μ_1 satisfies an equation which reads under the form : ()

Once the amplitudes for indeces associated to the loop are known, the construction of the amplitudes which do not lie on the loop follows the same kind of arguments as those given in paragraph 5.2. A precise construction will not be given here and we refer to [Ben] for more details.

5.3.2 Summary: the construction of higher order terms.

6 Proof of the main result.

With Theorem 5.1 in hand, it is now easy to show Theorem 3.1. We argue by contradiction. We thus assume that the corner problem (1) is weakly (or strongly) well-posed in the sense that there exists a positive integer K, such that the corner problem (1) admits a solution satisfying the energy estimate:

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u|_{x_{1}=0}||_{L^{2}(\partial\Omega_{1,T})}^{2} + ||u|_{x_{2}=0}||_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(||f||_{L^{2}(\Omega_{T})}^{2} + ||g_{1}||_{H^{K}(\partial\Omega_{1,T})}^{2} + ||g_{2}||_{L^{2}(\partial\Omega_{2,T})}^{2}\right), \tag{113}$$

for T > 0 if $\beta \ge 1$ and $0 < T < T_{max}$ if $\beta < 1$. According to Theorem 5.1, for any $M \in \mathbb{N}$ one can always construct a truncated geometric optics expansions for the corner problem (12). It is given by:

$$u_{app}^{\varepsilon} := \sum_{n=0}^{1} \sum_{k \in \mathscr{I}_{os}} \varepsilon^{n} e^{\frac{i}{\varepsilon} \varphi_{k}(t,x)} u_{n,k}(t,x)$$

$$+ \sum_{n=0}^{1} \sum_{k \in \mathfrak{R}_{1}} \varepsilon^{n} e^{\frac{i}{\varepsilon} \psi_{k,1}(t,x_{2})} U_{n,k,1}\left(t,x,\frac{x_{1}}{\varepsilon}\right) + \sum_{n=0}^{1} \sum_{k \in \mathfrak{R}_{2}} \varepsilon^{n} e^{\frac{i}{\varepsilon} \psi_{k,2}(t,x_{1})} U_{n,k,2}\left(t,x,\frac{x_{2}}{\varepsilon}\right).$$

$$(114)$$

Moreover one can always choose g in such a way that the leading order of u_{app}^{ε} is not identically zero.

Let u^{ε} be a solution of (12). The error $u^{\varepsilon} - u_{app}^{\varepsilon}$ satisfies the corner problem :

$$\begin{cases} L(\partial)(u^{\varepsilon} - u_{app}^{\varepsilon}) = f^{\varepsilon}, \\ B_{1}(u^{\varepsilon} - u_{app}^{\varepsilon})|_{x_{1}=0} = 0, \\ B_{2}(u^{\varepsilon} - u_{app}^{\varepsilon})|_{x_{2}=0} = 0, \\ (u^{\varepsilon} - u_{app}^{\varepsilon})|_{t \leq 0} = 0, \end{cases}$$

where:

$$f^{\varepsilon} := \varepsilon \left[\sum_{k \in \mathscr{I}_{os}} e^{i\frac{\varphi_k}{\varepsilon}} L(\partial) u_{1,k} + \sum_{k \in \mathfrak{R}_1} e^{i\frac{\psi_{k,1}}{\varepsilon}} (L(\partial) U_{1,k,1})_{|X_1 = \frac{x_1}{\varepsilon}} + \sum_{k \in \mathfrak{R}_2} e^{i\frac{\psi_{k,2}}{\varepsilon}} (L(\partial) U_{1,k,2})_{|X_2 = \frac{x_2}{\varepsilon}} \right].$$

It follows from the energy estimate (113) that:

$$\|u^{\varepsilon} - u_{ann}^{\varepsilon}\|_{L^{2}(\Omega_{T})} \le \|f^{\varepsilon}\|_{L^{2}(\Omega_{T})}.$$
(115)

It is then easy to see from its expression that f^{ε} is $O(\varepsilon)$ in $L^{2}(\Omega_{T})$. Using the fact that u^{ε} is a solution of (12) we obtain that

$$||u^{\varepsilon}||_{L^{2}(\Omega_{T})} \leq ||g^{\varepsilon}||_{H^{K}(\Omega_{T})}, \tag{116}$$

from which we deduce that u^{ε} is $O(\varepsilon^{M-K})$ in $L^{2}(\Omega_{T})$. Let us choose M > K, by the triangle inequality and inequalities (115) and (116), it follows that u_{app}^{ε} is at least $O(\varepsilon)$ which is a contradiction with the fact that $u_{0,n_{1}}$ is nonzero.

7 Examples, conclusion and conjectures.

7.1 Examples.

We consider the following corner problem:

$$\begin{cases}
\partial_t u + A_1 \partial_1 u + A_2 \partial_2 u = 0, & \text{for } x_1, x_2 > 0 \\
B_1 u_{|x_1=0} = g^{\varepsilon}, & \text{for } x_2 > 0, \\
B_2 u_{|x_2=0} = 0, & \text{for } x_1 > 0, \\
u_{|t \le 0} = 0,
\end{cases}$$
(117)

with

$$A_1 := \begin{bmatrix} 0 & \sqrt{5} & 0 \\ \sqrt{5} & -4 & 0 \\ 0 & 0 & -\frac{5}{7} \end{bmatrix}$$
, and $A_2 := \begin{bmatrix} -1 & 0 & 0 \\ 0 & 1 & 0 \\ 0 & 0 & 1 \end{bmatrix}$.

One can see that this example is just a modification of the example in [Ben15] to make sure that the transport velocity along the boundary has the good sign.

The section of the characteristic variety V with $\{\underline{\tau} = 1\}$ is given by :




Figure 3: The characteristic variety for the corner problem (117).

$$V_{\{\mathcal{I}=1\}} = \left\{ (\xi_1, \xi_2) \in \mathbb{R}^2 \setminus \left(1 - \frac{5}{7}\xi_1 + \xi_2 \right) (1 - 4\xi_1 + 4\xi_1\xi_2 - 5\xi_1^2 - \xi_2^2) = 0 \right\},$$

and is depicted in Figure 3 as well as a part of the phase generation process associated to the source term :

$$g^{\varepsilon}(t, x_2) := e^{\frac{i}{\varepsilon}(t - 8x_2)} g(t, x_2),$$

In particular, let us remark that we have a loop with the phases $\varphi_1, ... \varphi_4$ defined by:

$$\varphi_1(t,x) := t - \frac{21}{5}x_1 - 8x_2, v_1 := \begin{bmatrix} 3\\ \frac{2}{5} \end{bmatrix},
\varphi_2(t,x) := t - \frac{21}{5}x_1 - 4x_2, v_2 := \begin{bmatrix} -\frac{5}{7}\\ 1 \end{bmatrix},
\varphi_3(t,x) := t - 3x_1 - 4x_2, v_3 := \begin{bmatrix} 5\\ -2 \end{bmatrix},
\varphi_4(t,x) := t - 3x_1 - 8x_2, v_4 := \begin{bmatrix} 5\\ -2 \end{bmatrix},$$

where the v_j denote the group velocities. Thus one can see that the group velocities v_1 , v_3 are incoming-outgoing while the group velocities v_2 , v_4 are outgoing-incoming. One can also shows that the stable subspace $E_1^s(i, -8) := \text{vect}(e_1)$ where the generator vector e is given by :

$$e_1 := \begin{bmatrix} \frac{7}{3} \\ \sqrt{5} \\ 0 \end{bmatrix}.$$

Then if one chooses for boundary condition on the side $\partial \Omega_1$: for fixed $\delta \in \mathbb{R}$

$$B_1 := \begin{bmatrix} -\sqrt{5} & \frac{7}{3} & \delta \end{bmatrix},$$

he can also easily see that $B_1e_1=0$, and thus the uniform Kreiss-Lopatinskii condition is not satisfied for the side $\partial\Omega_1$. Some extra computations enable to show that such a B_1 gives a problem in the WR class for the side $\partial\Omega_1$. Then one choose B_2 such that the associated boundary condition is for example strictly dissipative. The velocity of the transport along the side $\partial\Omega_1$ is then given by $\frac{1}{8}$ and we can apply Theorem 3.1 to show that the corner problem (117) is ill-posed.

Let us remark that applied Theorem 3.1 to the corner problem (117) may seem to be a bit abusive. Indeed, Theorem 3.1 needs strict hyperbolicity while the corner problem (117) is clearly not strictly hyperbolic. However, in the proof of Theorem 3.1, the only points were we used the hyperbolicity assumption were to establish the block structure and to use Lax Lemma. It can be show that these points are still true for geometrically regular hyperbolic systems (see [?] for a precise definition) as soon as we are away from the crossing points, which is the case for (117) under this choice of the source term.

As a consequence if one wants to give an example for which Theorem 3.1 apply, that is to say that a strictly hyperbolic operator is needed, the simplest way to do that is probably to use the example of [SS75, paragraph 7]. In this example, the authors construct a system whose characteristic variety is composed of two intersecting ellipses choosen in such a configuration that a loop exists. Without

loss of generality, we can assume that the loop is include in the half space $\{\xi_2 < 0\}$, to make sure that the velocity along the boundary has the good sign. Then one chooses a boundary condition to make sure that the associated corner problem is in the WR class. This point can be easily done because at this stage of the construction the system is composed of two decoupled parts.

To obtain a strictly hyperbolic system, it is sufficient to make the perturbation described in [SS75, paragraph 9]. One can conclude that the associated perturbed operator is strictly hyperbolic and that it is still in WR class, because this class is stable by small perturbations (see [BGRSZ02]).

7.2 Conclusion and conjectures.

In this article, we built the rigorous geometric optics expansion for a corner problem for which the uniform Kreiss-Lopatinskii condition breaks down on a selfinteraction frequency. We have shown that it was always possible to choose the source term of the corner problem in such a way that the associated geometric optics expansion suffers M+1 amplifications, before a fixed time T, compared to the source term, where M can be arbitrarily big. This leads us to the fact that such a corner problem can not be weakly well-posed because it suffers an arbitrarily big number of loss of derivative on the side $\partial\Omega_1$ and thus present an Hadamard instability.

As a consequence we show that for hyperbolic corner problem a weak instability can be repeated an arbitrary number of times to cause a violent instability which differs from the degeneracy of the weak Kreiss-Lopatinskii condition. In terms of well-posedness it is the worst case possible.

However there are other kinds of degeneracy of the uniform Kreiss-Lopatinskii condition. And in these cases, one should be more optimistic. Let us formulate the following reasonnable conjectures.

If the uniform Kreiss-Lopatinskii condition breaks down in the elliptic area, using the fact that

evanescent modes for the side $\partial\Omega_1$ are not reflected on the side $\partial\Omega_2$, the amplification observed in the high frequency expansion for the boundary value problem in the half space should not be improved. So we believe that the leading order in the WKB expansion should be of order ε^0 with a source term in the interior of order ε and a source term on the side $\partial\Omega_1$ of order ε^0 . The associated corner problem should be weakly well-posed with an energy estimate reading:

$$\|u\|_{L^{2}(\Omega_{T})}^{2} + \|u_{|x_{1}=0}\|_{L^{2}(\partial\Omega_{1,T})}^{2} + \|u_{|x_{2}=0}\|_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(\|f\|_{L^{2}(\Omega_{T})}^{2} + \|g_{1}\|_{H^{1}(\partial\Omega_{1,T})}^{2} + \|g_{2}\|_{L^{2}(\partial\Omega_{2,T})}^{2}\right).$$

When the uniform Kreiss-Lopatinskii condition is violated in the mixed area in such a way that $\ker B_1 \cap E_1^s(\underline{\zeta}) = \ker B_1 \cap E_1^{s,e}(\underline{\zeta}) = \operatorname{span}\{e\}$, where $E_1^{s,e}(\underline{\zeta})$ denotes the "elliptic" component of $E_1^s(\underline{\zeta})$ (see [Ben14] and [Les07]), then the same argument should apply. The conjecture is then that we have the same amplifications as for the boundary value problem in the half space. The expected energy estimate is:

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u|_{x_{1}=0}||_{L^{2}(\partial\Omega_{1,T})}^{2} + ||u|_{x_{2}=0}||_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(||f||_{H^{\frac{1}{2}}(\Omega_{T})}^{2} + ||g_{1}||_{H^{1}(\partial\Omega_{1,T})}^{2} + ||g_{2}||_{L^{2}(\partial\Omega_{2,T})}^{2} \right),$$

or

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u_{|x_{1}=0}||_{L^{2}(\partial\Omega_{1,T})}^{2} + ||u_{|x_{2}=0}||_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(||f||_{L^{2}(\Omega_{T})}^{2} + ||g_{1}||_{H^{1}(\partial\Omega_{1,T})}^{2} + ||g_{2}||_{L^{2}(\partial\Omega_{2,T})}^{2} \right),$$

depending of a technical assumption already discussed in [Ben14].

Finally when the uniform Kreiss-Lopatinskii condition fails in the hyperbolic region but for non-selfinteracting frequencies (or equivalently in the mixed region with $\ker B_1 \cap E_1^s(\underline{\zeta}) = \ker B_1 \cap E_1^{s,h}(\underline{\zeta}) = \operatorname{span}\{e\}$, where $E_1^{s,h}(\underline{\zeta})$ denotes the "hyperbolic" component of $E_1^s(\underline{\zeta})$ the conjecture is that the leading order in the geometric optics expansion is of order ε^0 for source terms of order ε^M , where M denotes the number of time that a ray has been amplified. More precisely M is defined by:

$$M := \max_{i \in \mathscr{I}_{os}} \#(\Upsilon \cap L_i),$$

where L_i is the set containing the values of the type V sequence linking i to the first generated index in the phase generation process. Indeed, an amplified ray should be amplified again if it contains in its reflections a phase associated to a frequency of degeneracy of the uniform Kreiss-Lopatinskii condition. The conjectured energy estimate is thus given by:

$$||u||_{L^{2}(\Omega_{T})}^{2} + ||u|_{x_{1}=0}||_{L^{2}(\partial\Omega_{1,T})}^{2} + ||u|_{x_{2}=0}||_{L^{2}(\partial\Omega_{2,T})}^{2} \leq C_{T} \left(||f||_{L^{2}_{x_{1}}(H^{M}(\partial\Omega_{1,T}))}^{2} + ||g_{1}||_{L^{2}(\partial\Omega_{2,T})}^{2}\right).$$

$$+ ||g_{1}||_{H^{M}(\partial\Omega_{1,T})}^{2} + ||g_{2}||_{L^{2}(\partial\Omega_{2,T})}^{2}\right).$$

$$(118)$$

All the previous conjectures are made under the assumption that the transport along the boundary spreads the information away from the corner. The energy estimates and the amplifications in the geometric optics expansions when the transport along the boundary send the information to the corner is left for future studies.

Details of the computations to establish equations (78)-(79) and (80).

Let us develop:

$$\begin{split} Q_1^{n_3}L(\partial)(I-P_1^{n_3})u_{1,n_3} &= -\frac{\overline{\xi}_2}{\underline{\xi}_2}\beta_1^{-1}\beta_2^{-1}\left[Q_1^{n_3}R_1^{n_3}\mathscr{S}^{n_3}e\left(\partial_{tt}^2\mu_0 - \frac{\underline{\tau}}{\overline{\xi}_2}\partial_{t2}^2\mu_0\right)\right. \\ &+ Q_1^{n_3}A_2R_1^{n_3}\mathscr{S}^{n_3}e\left(\left(-\frac{1}{v_{n_2,2}} + \frac{\beta_2^{-1}}{v_{n_1,1}}\right)\partial_{tt}^2\mu_0 + \beta_1^{-1}\beta_2^{-1}\partial_{t2}^2\mu_0\right. \\ &- \left. - \frac{\underline{\tau}}{\overline{\xi}_2}\left(\left(-\frac{1}{v_{n_2,2}} + \frac{\beta_2^{-1}}{v_{n_1,1}}\right)\partial_{t2}^2\mu_0 + \beta_1^{-1}\beta_2^{-1}\partial_{22}^2\mu_0\right)\right)\right](\mathbf{t}_3, \mathbf{x}_3), \end{split}$$

where we used the fact that $Q_1^{n_3}A_1R_1^{n_3}=0$. We then use the relation between $Q_1^{n_3}R_1^{n_3}\mathscr{S}^{n_3}e$ and $Q_1^{n_3}A_2R_1^{n_3}\mathscr{S}^{n_3}e$ given in (76) to express $Q_1^{n_3}L(\partial)(I-P_1^{n_3})u_{1,n_3}$ in terms of $Q_1^{n_3}R_1^{n_3}\mathscr{S}^{n_3}e$ only:

$$Q_1^{n_3}L(\partial)(I - P_1^{n_3})u_{1,n_3} = -\frac{\overline{\xi}_2}{\underline{\xi}_2}\beta_1^{-1}\beta_2^{-1}Q_1^{n_3}R_1^{n_3}\mathscr{S}^{n_3}e\left[\partial_{tt}^2\mu_0\left(1 + \frac{\underline{\tau}}{\underline{\xi}_2}\left(\frac{1}{v_{n_2,2}} - \frac{\beta_2^{-1}}{v_{n_1,1}}\right)\right) - C_3\partial_{t2}^2\mu_0 + \partial_{22}^2\mu_0\beta_1^{-1}\beta_2^{-1}\frac{\underline{\tau}^2}{\overline{\xi}_2\underline{\xi}_2}\right](\mathbf{t}_3, \mathbf{x}_3),$$

$$(119)$$

where

$$C_3 := \frac{\underline{\tau}}{\overline{\xi}_2} \left[1 + \frac{\underline{\tau}}{\underline{\xi}_2} \left(\frac{1}{v_{n_2,2}} - \frac{\beta_2^{-1}}{v_{n_1,1}} \right) \right] + \frac{\underline{\tau}}{\underline{\xi}_2} \beta_1^{-1} \beta_2^{-1}.$$

From Lemma 5.2, we know that the first term in C_3 is $\frac{\overline{\xi}_2}{\underline{\xi}_2}\beta_1^{-1}\beta_2^{-1}$. We thus obtain that $C_3 = 2\frac{\tau}{\underline{\xi}_2}\beta_1^{-1}\beta_2^{-1}$, and we can factorize (119) to obtain (79).

Using the fact that $Q_2^{n_4}A_2R_2^{n_4}=0$ we develop $Q_2^{n_4}L(\partial)(I-P_2^{n_4})u_{1,n_4}$ to obtain :

$$Q_{2}^{n_{4}}L(\partial)(I - P_{2}^{n_{4}})u_{1,n_{4}} = -\frac{\overline{\xi}_{2}}{\overline{\xi}_{1}} \prod_{j=1}^{3} \beta_{j}^{-1} \left[Q_{2}^{n_{4}} R_{2}^{n_{4}} \mathscr{S}^{n_{4}} e \left(\partial_{tt}^{2} \mu_{0} - \frac{\underline{\tau}}{\overline{\xi}_{2}} \partial_{t2}^{2} \mu_{0} \right) + Q_{2}^{n_{4}} A_{1} R_{2}^{n_{4}} \mathscr{S}^{n_{4}} e \left(-A \partial_{tt}^{2} \mu_{0} - \prod_{j=1}^{3} \beta_{j}^{-1} \partial_{t2}^{2} \mu_{0} \right) - \frac{\underline{\tau}}{\overline{\xi}_{2}} \left(-A \partial_{t2}^{2} \mu_{0} - \prod_{j=1}^{3} \beta_{j}^{-1} \partial_{22}^{2} \mu_{0} \right) \right] (\mathbf{t}_{4}, \mathbf{x}_{4}),$$

where we recall that A is defined in (36). We then use (77) to express this equation in terms of $Q_2^{n_4}R_2^{n_4}\mathcal{S}^{n_4}e$ only:

$$Q_2^{n_4}L(\partial)(I-P_2^{n_4})u_{1,n_4} \quad = \quad -\frac{\overline{\xi}_2}{\overline{\xi}_1}\prod_{i=1}^3\beta_j^{-1}Q_2^{n_4}R_2^{n_4}\mathscr{S}^{n_4}e\left[\partial_{tt}^2\mu_0\left(1+A\frac{\underline{\tau}}{\overline{\xi}_1}\right)+C_4\partial_{t2}^2\mu_0+\frac{\underline{\tau}^2}{\overline{\xi}_1\overline{\xi}_2}\prod_{i=1}^3\beta_j^{-1}\partial_{22}^2\mu_0\right](\mathbf{t}_4,\mathbf{x}_4),$$

where C_4 is defined by :

$$C_4 := -\frac{\underline{\tau}}{\overline{\xi}_2} \left(1 + A \frac{\underline{\tau}}{\overline{\xi}_1} \right) + \frac{\underline{\tau}}{\overline{\xi}_1} \prod_{i=1}^3 \beta_j^{-1}.$$

Once again thanks to Lemma 5.2, we obtain that C_4 in fact reads $C_4 = 2\frac{\tau}{\overline{\xi_1}} \prod_{j=1}^3 \beta_j^{-1}$. As a consequence we obtain (80).
