# LOCAL AND GLOBAL WELL-POSEDNESS RESULTS FOR THE BENJAMIN-ONO-ZAKHAROV-KUZNETSOV EQUATION

#### Abstract

We show that the initial value problem associated to the dispersive generalized Benjamin-Ono-Zakharov-Kuznetsov equation $$
u_{t}-D_{x}^{\alpha} u_{x}+u_{x y y}=u u_{x}, \quad(t, x, y) \in \mathbb{R}^{3}, \quad 1 \leq \alpha \leq 2,
$$ is locally well-posed in the spaces $E^{s}, s>\frac{2}{\alpha}-\frac{3}{4}$, endowed with the norm $\|f\|_{E^{s}}=\left\|\left.\langle | \xi\right|^{\alpha}+\mu^{2}\right\rangle^{s} \hat{f} \|_{L^{2}\left(\mathbb{R}^{2}\right)}$. As a consequence, we get the global wellposedness in the energy space $E^{1 / 2}$ as soon as $\alpha>\frac{8}{5}$. The proof is based on the approach of the short time Bourgain spaces developed by Ionescu, Kenig and Tataru [9] combined with new Strichartz estimates and a modified energy.


## 1. Introduction

In this paper we study a class of two-dimensional nonlinear dispersive equations which extend the well-known Korteweg-de Vries (KdV) and Benjamin-Ono (BO) equations. There are several ways to generalize such 1D models in order to include the effect of long wave lateral dispersion. For instance one can consider the Kadomstev-Petviashvili (KP) and Zakharov-Kuznetsov (ZK) equations. Here we are interested with the effect of the dispersion in the propagation direction applied to the initial value problem for the ZK equation. More precisely we consider the generalized g-BOZK equation

u_{t}-D_{x}^{\alpha} u_{x}+u_{x y y}=u u_{x}, \quad(t, x, y) \in \mathbb{R}^{3} \tag{1.1}
\end{equation*}
$$

where $D_{x}^{\alpha}$ is the Fourier multiplier by $|\xi|^{\alpha}, 1 \leq \alpha \leq 2$. When $\alpha=2$, (1.1) is the well-known ZK equation introduced by Zakharov and Kuznetsov in [21] to describe the propagation of ionic-acoustic waves in magnetized plasma. We refer to [14] for a rigorous derivation of ZK . For $\alpha=1$, equation (1.1) is the so-called Benjamin-Ono-Zakharov-Kuznetsov (BOZK) equation introduced in [11] and [15] and has applications to thin nanoconductors on a dielectric substrate.

We notice that (1.1) enjoys the two following conservation laws:

where

\mathcal{M}(u)=\int_{\mathbb{R}^{2}} u^{2} d x d y
$$

and

$$
\mathcal{H}(u)=\int_{\mathbb{R}^{2}}\left(\left|D_{x}^{\frac{\alpha}{2}} u\right|^{2}+\left|u_{y}\right|^{2}-\frac{1}{3} u^{3}\right) d x d y
$$

Therefore, it is natural to study the well-posedness of g-BOZK in the functional spaces $E^{0}$ and $E^{1 / 2}$, and more generally in $E^{s}$ defined for any $s \in \mathbb{R}$ by the norm

$$
\|f\|_{E^{s}}=\left\|\left.\langle | \xi\right|^{\alpha}+\mu^{2}\right\rangle^{s} \hat{f}(\xi, \mu) \|_{L^{2}\left(\mathbb{R}^{2}\right)}
$$

Observe that $E^{s}$ is nothing but the anisotropic Sobolev space $H^{\alpha s, 2 s}\left(\mathbb{R}^{2}\right)$. In particular when $\alpha=2$, then $E^{s}=H^{2 s}\left(\mathbb{R}^{2}\right)$.

Let us recall some well-known facts concerning the associated 1D model

u_{t}-D_{x}^{\alpha} u_{x}=u u_{x}, \quad(t, x) \in \mathbb{R}^{2} \tag{1.3}
\end{equation*}

The Cauchy problem for (1.3), and especially the cases $\alpha=1,2$ (respectively the BO and KdV equation), has been extensively studied these last decades, and is now well-understood. The standard fixed point argument in suitable functional spaces allows to solve the KdV equation at very low regularity level (see [13] for instance). This is in sharp contrast with what occurs in the case $\alpha<2$, since it was shown by Molinet-Saut-Tzvetkov [17] that the solution flow map for (1.3) cannot be $C^{2}$ in any Sobolev spaces (due to bad low-high interactions). Therefore the problem cannot be solved using such arguments. In view of this result, three approaches were developed to lower the regularity requirement. The first one consists in introducing a nonlinear gauge transform of the solution that solves an equation with better interactions (see [20]-[8]). This method was proved to be very efficient but as pointed out in [3], it is not clear how to find such a transform adapted to our 2D problem (1.1). The second one was introduced very recently by Molinet and the second author [18] and consists in an improvement of the classical energy method by taking into account the dispersive effect of the equation. This method is more flexible with respect to perturbations of the equation but requires that the dispersive part of the equation does not exhibit too strong resonances. Unfortunately, the cancelation zone of the resonance function $\Omega$ associated to g-BOZK (see (2.2) for the definition) seems too large to apply this technique to equation (1.1). Finally the third method introduced to solve (1.3) consists in improving dispersive estimates by localizing it in space frequency depending time intervals. In the context of the Bourgain spaces, this approach was successfully applied by Guo in [6] to solve (1.3) (see also [9] for an application to the KP-I equation) and seems to be the best way to deal with the g-BOZK equation.

Now we come back to the 2D problem (1.1). The initial value problem for the ZK equation $(\alpha=2)$ has given rise to many papers these last years. In particular, Faminskii proved in [4] that it is globally well-posed in the energy space $H^{1}\left(\mathbb{R}^{2}\right)$. The best result concerning the local well-posedness was recently independently obtained by Grünrock and Herr in [5] and by Molinet and Pilod in [16] where they show the LWP of (1.1) in $H^{s}\left(\mathbb{R}^{2}\right), s>1 / 2$. Similarly to the KdV equation, all these results were proved using the fixed point procedure. Concerning the case $\alpha=1$, using classical energy methods and parabolic regularization that does not take into account the dispersive effect of the equation, Cunha and Pastor [3] have proved the well-posedness of (1.1) in $H^{s}\left(\mathbb{R}^{2}\right)$ for $s>2$ as well as in the anisotropic Sobolev spaces $H^{s_{1}, s_{2}}\left(\mathbb{R}^{2}\right), s_{2}>2, s_{1} \geq s_{2}$. Also, it was proved in [7] that the solution mapping fails to be $C^{2}$ smooth in any $H^{s_{1}, s_{2}}\left(\mathbb{R}^{2}\right), s_{1}, s_{2} \in \mathbb{R}$. Moreover this result even extends to the case $1 \leq \alpha<\frac{4}{3}$.

In the intermediate cases $1<\alpha<2$, there is no positive results concerning the well-posedness for (1.1). Our main theorem is the following.

Theorem 1.1. Assume that $1 \leq \alpha \leq 2$ and $s>s_{\alpha}:=\frac{2}{\alpha}-\frac{3}{4}$. Then for every $u_{0} \in E^{s}$, there exists a positive time $T=T\left(\left\|u_{0}\right\|_{E^{s}}\right)$ and a unique solution $u$ to (1.1) in the class

$$
C\left([-T, T] ; E^{s}\right) \cap F^{s}(T) \cap B^{s}(T)
$$

Moreover, for any $0<T^{\prime}<T$, there exists a neighbourhood $\mathcal{U}$ of $u_{0}$ in $E^{s}$ such that the flow map data-solution

$$
S_{T^{\prime}}^{S}: \mathcal{U} \rightarrow C\left(\left[-T^{\prime}, T^{\prime}\right] ; E^{s}\right), u_{0} \mapsto u
$$

is continuous.
Remark 1.1. We refer to Section 2.2 for the definition of the functional spaces $F^{s}(T)$ and $B^{s}(T)$.

Remark 1.2. When $\alpha=2$, we recover the local well-posedness result in $E^{1 / 4+}=$ $H^{1 / 2+}\left(\mathbb{R}^{2}\right)$ for $Z K$ proved in [5] and [16]. In the case $\alpha=1$, Theorem 1.1 improves the previous results obtained in [3].

We discuss now some of the ingredients in the proof of Theorem 1.1. We will adapt the approach introduced by Ionescu, Kenig and Tataru [9] to our model (see also [6]-[12] for applications to other equations). It consists in an energy method combined with linear and nonlinear estimates in the short-time Bourgain's spaces $F^{s}(T)$ and their dual $\mathcal{N}^{s}(T)$. The $F^{s}(T)$ spaces enjoys a $X^{s, 1 / 2}$-type structure but with a localization in small time intervals whose length is of order $H^{1-\frac{2}{\alpha}}$ when the space frequency $(\xi, \mu)$ satisfies $|\xi|^{\alpha}+\mu^{2} \sim H$. When deriving bilinear estimates in these spaces, one of the main obstruction is the strong resonance induced by the dispersive part of the equation. To overcome this difficulty, we will derive some improved Strichartz estimates for free solutions localized outside the critical region $\left\{2 \mu^{2}=\alpha(\alpha+1)|\xi|^{\alpha}\right\}$. Finally, we need energy estimates in order to apply the classical Bona-Smith argument (see [1]) and conclude the proof of Theorem 1.1. To derive such energy estimates, we are led to deal with terms of the form

\int_{\mathbb{R}^{2}} P_{H} u P_{H}\left(u u_{x}\right)

where $P_{H}$ localizes in the frequencies $\left\{|\xi|^{\alpha}+\mu^{2} \sim H\right\}$. Unfortunately, in the twodimensional setting, we cannot put the $x$-derivative on the lower frequency term via commutators and integrations by parts without loosing a $y$-derivative. Therefore, we need to add a cubic lower-order term to the energy in order to cancel those bad interactions.

Assuming that $s_{\alpha}<\frac{1}{2}$, we may use the conservation laws (1.2) combined with the embedding $E^{1 / 2} \hookrightarrow L^{3}\left(\mathbb{R}^{2}\right)$ to get an a priori bound of the $E^{1 / 2}$ norm of the solution and then iterate Theorem 1.1 to obtain the following global well-posedness result.

Corollary 1.1. Assume that $\frac{8}{5}<\alpha \leq 2$ and $s=\frac{1}{2}$. Then the results of Theorem 1.1 are true for $T>0$ arbitrary large.

Finally, as in the one dimensional case, we show that as soon as $\alpha<2$, the solution map $S_{T}^{s}$ given by Theorem 1.1 is not of class $C^{2}$ for all $s \in \mathbb{R}$. This implies in particular that the Cauchy problem for (1.1) cannot be solved by direct contraction principle.

Theorem 1.2. Fix $s \in \mathbb{R}$ and $1 \leq \alpha<2$. Then there does not exist a $T>0$ such that (1.1) admits a unique local solution defined on the interval $[-T, T]$ and such that the flow-map data-solution $u_{0} \mapsto u(t), t \in[-T, T]$ is $C^{2}$-differentiable at the origin from $E^{s}$ to $E^{s}$.

The rest of the paper is organized as follows: in Section 2, we introduce the notations, define the function spaces and state some associated properties. In Section 3, we derive Strichartz estimates for free solutions of (1.1). In Section 4 we show some $L^{2}$-bilinear estimates which are used to prove the main short time bilinear estimates in Section 5 as well as the energy estimates in Section 6. Theorem 1.1 is proved in Section 7. We conclude the paper with an appendix where we show the ill-posedness result of Theorem 1.2.

## 2. Notations and functions spaces

2.1. Notations. For any positive numbers $a$ and $b$, the notation $a \lesssim b$ means that there exists a positive constant $c$ such that $a \leq c b$. By $a \sim b$ we mean that $a \lesssim b$ and $b \lesssim a$. Moreover, if $\gamma \in \mathbb{R}, \gamma+$, respectively $\gamma-$, will denote a number slightly greater, respectively lesser, than $\gamma$.

The Fourier variables of $(t, x, y)$ are denoted $(\tau, \xi, \mu)$. Let $U(t)=e^{t \partial_{x}\left(D_{x}^{\alpha}-\partial_{y y}\right)}$ be the linear group associated with the free part of (1.1) and set

\begin{align*}
\omega(\zeta) & =\omega(\xi, \mu)=\xi\left(|\xi|^{\alpha}+\mu^{2}\right)  \tag{2.1}\\
\Omega\left(\zeta_{1}, \zeta_{2}\right) & =\omega\left(\zeta_{1}+\zeta_{2}\right)-\omega\left(\zeta_{1}\right)-\omega\left(\zeta_{2}\right) \tag{2.2}
\end{align*}
$$

Let $h$ the partial derivatives of $\omega$ with respect to $\xi$ :

h(\xi, \mu)=\partial_{\xi} \omega(\xi, \mu)=(\alpha+1)|\xi|^{\alpha}+\mu^{2}
$$

We define the set of dyadic numbers $\mathbb{D}=\left\{2^{\ell}, \ell \in \mathbb{N}\right\}$. If $\beta \geq 0$ and $H=2^{\ell} \in \mathbb{D}$, we will denote by $\left\lfloor H^{\beta}\right\rfloor$ the dyadic number such that $\left\lfloor H^{\beta}\right\rfloor \leq H^{\beta}<2\left\lfloor H^{\beta}\right\rfloor$. In other words we set $\left\lfloor H^{\beta}\right\rfloor=2^{[\beta k]}$ where [.] is the integer part.

Let $\chi \in C_{0}^{\infty}$ satisfies $0 \leq \chi \leq 1, \chi=1$ on $[-4 / 3,4 / 3]$ and $\chi(\xi)=0$ for $|\xi|>5 / 3$. Let $\varphi(\xi)=\chi(\xi)-\chi(2 \xi)$ and for any $N \in \mathbb{D} \backslash\{1\}$, define $\varphi_{N}(\xi)=\varphi(\xi / N)$ and $\varphi_{1}=\chi$. For $H, N \in \mathbb{D}$, we consider the Fourier multipliers $P_{N}^{x}$ and $P_{H}$ defined as

\mathcal{F}\left(P_{N}^{x} u\right)(\tau, \xi, \mu)=\varphi_{N}(\xi) \mathcal{F} u(\tau, \xi, \mu) \\
\mathcal{F}\left(P_{H} u\right)(\tau, \xi, \mu)=\psi_{H}(\xi, \mu) \mathcal{F} u(\tau, \xi, \mu)
\end{gathered}
$$

with $\psi_{H}(\xi, \mu)=\varphi_{H}\left(|\xi|^{\alpha}+\mu^{2}\right)$.
If $A \subset \mathbb{R}^{2}$, we denote by $P_{A}=\mathcal{F}^{-1} 1_{A} \mathcal{F}$ the Fourier projection on $A$.
For $N, H \in \mathbb{D} \backslash\{1\}$, let us define

I_{N}=\left\{\xi: \frac{N}{2} \leq|\xi| \leq 2 N\right\}, \quad I_{1}=[-2,2],
$$

and

$$
\Delta_{H}=\left\{(\xi, \mu): h(\xi, \mu) \in I_{H}\right\}
$$

We also define $P_{\lesssim H}=\sum_{H_{1} \lesssim H} P_{H_{1}}, P_{\gg H}=I d-P_{\lesssim H}$ and $P_{\sim H}=I d-P_{\lesssim H}-P_{\gg H}$. We will use similarly the notation $\varphi \leq, \varphi \geq \ldots$

Let $\eta: \mathbb{R}^{4} \rightarrow \mathbb{C}$ be a bounded measurable function. We define the pseudoproduct operator $\Pi_{\eta}$ on $\mathcal{S}\left(\mathbb{R}^{2}\right)^{2}$ by

\mathcal{F}\left(\Pi_{\eta}(f, g)\right)(\zeta)=\int_{\zeta=\zeta_{1}+\zeta_{2}} \eta\left(\zeta_{1}, \zeta_{2}\right) \widehat{f}\left(\zeta_{1}\right) \widehat{g}\left(\zeta_{2}\right)

This bilinear operator enjoys the symmetry property

\int_{\mathbb{R}^{2}} \Pi_{\eta}(f, g) h=\int_{\mathbb{R}^{2}} f \Pi_{\eta_{1}}(g, h)=\int_{\mathbb{R}^{2}} \Pi_{\eta_{2}}(f, h) g \tag{2.3}

with $\eta_{1}\left(\zeta_{1}, \zeta_{2}\right)=\bar{\eta}\left(\zeta_{1}+\zeta_{2},-\zeta_{2}\right)$ and $\eta_{2}\left(\zeta_{1}, \zeta_{2}\right)=\bar{\eta}\left(\zeta_{1}+\zeta_{2},-\zeta_{1}\right)$ for any real-valued functions $f, g, h \in \mathcal{S}\left(\mathbb{R}^{2}\right)$. This operator behaves like a product in the sense that it satisfies

\partial \Pi_{\eta}(f, g)=\Pi_{\eta}(\partial f, g)+\Pi_{\eta}(f, \partial g), \tag{2.4}

for any $f, g \in \mathcal{S}\left(\mathbb{R}^{2}\right)$ where $\partial$ holds for $\partial_{x}$ or $\partial_{y}$. Moreover, if $f_{i} \in L^{2}\left(\mathbb{R}^{2}\right), i=1,2,3$ are localized in $\Delta_{H_{i}}$ for some $H_{i} \in \mathbb{D}$, then

\left|\int_{\mathbb{R}^{2}} \Pi_{\eta}\left(f_{1}, f_{2}\right) f_{3}\right| \lesssim H_{\min }^{\frac{1}{2 \alpha}+\frac{1}{4}} \prod_{i=1}^{3}\left\|f_{i}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)} \tag{2.5}
\end{equation*}

Estimate (2.5) follows from (2.3), Plancherel's theorem and the fact that $\left\|\psi_{H}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2} \sim$ $H^{\frac{1}{\alpha}+\frac{1}{2}}$ for any $H \in \mathbb{D}$.
2.2. Function spaces. If $\phi \in L^{2}\left(\mathbb{R}^{3}\right)$ is supported in $\mathbb{R} \times \Delta_{H}$ for $H \in \mathbb{D}$, the space $X_{H}$ is defined by the norm

\|\phi\|_{X_{H}}=\sum_{L \in \mathbb{D}} L^{1 / 2}\left\|\varphi_{L}(\tau-\omega(\zeta)) \phi(\tau, \zeta)\right\|_{L_{\tau \zeta}^{2}} .

For a function $f \in L^{2}\left(\mathbb{R}^{3}\right)$ such that $\mathcal{F}(f)$ is supported in $\mathbb{R} \times \Delta_{H}$ for $H \in \mathbb{D}$, we introduce the Bourgain's space $F_{H}$ localized in short time intervals of length $H^{-\beta}$ where $\beta$ is fixed to

defined by the norm

$$
\begin{equation*}
\|f\|_{F_{H}}=\sup _{t_{H} \in \mathbb{R}}\left\|\mathcal{F}\left(\varphi_{1}\left(H^{\beta}\left(\cdot-t_{H}\right)\right) f\right)\right\|_{X_{H}} . \tag{2.6}
\end{equation*}

Its dual version $\mathcal{N}_{H}$ is defined by the norm

\|f\|_{\mathcal{N}_{H}}=\sup _{t_{H} \in \mathbb{R}}\left\|\left(\tau-\omega(\zeta)+i H^{\beta}\right)^{-1} \cdot \mathcal{F}\left(\varphi_{1}\left(H^{\beta}\left(\cdot-t_{H}\right)\right) f\right)\right\|_{X_{H}} \tag{2.7}

Now if $s \geq 0$, we define the global $F^{s}$ and $\mathcal{N}^{s}$ spaces from their frequency localized version $F_{H}$ and $\mathcal{N}_{H}$ by using a nonhomogeneous Littlewood-Paley decomposition as follows

We define next a time localized version of those spaces. For $T>0$ and $Y=F^{s}$ or $Y=\mathcal{N}^{s}$, the space $Y(T)$ is defined by its norm

\|f\|_{Y(T)}=\inf \left\{\|\widetilde{f}\|_{Y}: \widetilde{f}: \mathbb{R}^{3} \rightarrow \mathbb{R} \text { and }\left.\widetilde{f}\right|_{[-T, T] \times \mathbb{R}^{2}}=f\right\}

For $s \geq 0$ and $T>0$ we define the Banach spaces for the initial data $E^{s}$ by

\|\phi\|_{E^{s}}=\left\|\langle h(\xi, \mu)\rangle^{s} \cdot \hat{\phi}\right\|_{L_{\xi, \mu}^{2}},
$$

and their intersections are denoted by $E^{\infty}=\bigcap_{s \geq 0} E^{s}$. Finally, the associated energy spaces $B^{s}(T)$ are endowed with norm

\|f\|_{B^{s}(T)}^{2}=\left\|P_{1} f(0, \cdot)\right\|_{L_{x y}^{2}}^{2}+\sum_{H \in \mathbb{D} \backslash\{1\}} H^{2 s} \sup _{t_{H} \in[-T, T]}\left\|P_{H} f\left(t_{H}, \cdot\right)\right\|_{L_{x y}^{2}}^{2}
$$

2.3. Properties of the function spaces. In this section, we state without proof some important results related to the short time function spaces introduced in the previous section. They all have been proved in different contexts in [9]-[12]-[6].

The $F^{s}(T)$ and $\mathcal{N}^{s}(T)$ spaces enjoy the following linear properties.
Lemma 2.1. Let $T>0$ and $s \geq 0$. Then it holds that

\|f\|_{L_{T}^{\infty} E^{s}} \lesssim\|f\|_{F^{s}(T)} \tag{2.8}
\end{equation*}
$$

for all $f \in F^{s}(T)$.
Proposition 2.1. Assume $T \in(0,1]$ and $s \geq 0$. Then we have that

\|u\|_{F^{s}(T)} \lesssim\|u\|_{B^{s}(T)}+\|f\|_{\mathcal{N}^{s}(T)} \tag{2.9}
\end{equation*}

for all $u \in B^{s}(T)$ and $f \in \mathcal{N}^{s}(T)$ satisfying

\partial_{t} u+D_{x}^{\alpha} \partial_{x} u+\partial_{x y y} u=f \text { on }[-T, T] \times \mathbb{R}^{2}
$$

We will also need the following technical results.
Lemma 2.2. Let $H, H_{1} \in \mathbb{D}$ be given. Then it holds that

H^{\beta / 2} \| \varphi_{\leq\left\lfloor H^{\beta}\right\rfloor}\left(\tau-\omega(\zeta) \int_{\mathbb{R}} \mid \phi\left(\tau^{\prime}, \zeta\right) H^{-\beta}\left(1+H^{-\beta}\left|\tau-\tau^{\prime}\right|\right)^{-4} d \tau^{\prime}\left\|_{L_{\tau \zeta}^{2}} \lesssim\right\| \phi \|_{X_{H_{1}}}\right.
$$

and

$$
\sum_{L>\left\lfloor H^{\beta}\right\rfloor} L^{1 / 2} \| \varphi_{L}\left(\tau-\omega(\zeta) \int_{\mathbb{R}} \mid \phi\left(\tau^{\prime}, \zeta\right) H^{-\beta}\left(1+H^{-\beta}\left|\tau-\tau^{\prime}\right|\right)^{-4} d \tau^{\prime}\left\|_{L_{\tau \zeta}^{2}} \lesssim\right\| \phi \|_{X_{H_{1}}}\right.
$$

for all $\phi \in F_{H_{1}}$.
Corollary 2.1. Let $\tilde{t} \in \mathbb{R}$ and $H, H_{1} \in \mathbb{D}$ be such that $H \gg H_{1}$. Then it holds that

H^{\beta / 2}\left\|\varphi_{\leq\left\lfloor H^{\beta}\right\rfloor} \mathcal{F}\left(\varphi_{1}\left(H^{\beta}(\cdot-\widetilde{t})\right) f\right)\right\|_{L_{\tau \zeta}^{2}} \lesssim\|f\|_{F_{H_{1}}}
$$

and

$$
\sum_{L>\left\lfloor H^{\beta}\right\rfloor} L^{1 / 2}\left\|\varphi_{L} \mathcal{F}\left(\varphi_{1}\left(H^{\beta}(\cdot-\widetilde{t})\right) f\right)\right\|_{L_{\tau \zeta}^{2}} \lesssim\|f\|_{F_{H_{1}}}
$$

for all $f \in F_{H_{1}}$.
Lemma 2.3. Let $H \in \mathbb{D}$ and $I \subset \mathbb{R}$ an interval. Then
$\sup _{L \in \mathbb{D}} L^{1 / 2}\left\|\varphi_{L}(\tau-\omega(\zeta)) \mathcal{F}\left(1_{I}(t) f\right)\right\|_{L^{2}\left(\mathbb{R}^{3}\right)} \lesssim\|\mathcal{F}(f)\|_{X_{H}}$,
for all $f$ such that $\mathcal{F}(f) \in X_{H}$.

## 3. Strichartz estimates

For $1 \leq \alpha \leq 2$ we set $B=\alpha(\alpha+1) / 2$, and for $\delta>0$ small enough, let us define

$$
A_{\delta}=\left\{(\xi, \mu) \in \mathbb{R}^{2}:(B-\delta)|\xi|^{\alpha} \leq \mu^{2} \leq(B+\delta)|\xi|^{\alpha}\right\}
$$

We also consider a function $\rho \in C^{\infty}(\mathbb{R},[0,1])$ satisfying $\rho=0$ on $\left[-\frac{1}{2}, \frac{1}{2}\right]$ and $\rho(\xi)=1$ for $|\xi| \geq 1$. We set $\rho_{\delta}(\xi)=\rho(\xi / \delta)$ so that $\rho_{\delta}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right)$ is a smooth version of $1_{A_{\delta}^{c}}$ in the sense that

$$
\begin{equation*}
\forall(\xi, \mu) \in \mathbb{R}^{*} \times \mathbb{R}, \quad \rho_{\delta}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right) 1_{A_{\delta}^{c}}(\xi, \mu)=1_{A_{\delta}^{c}}(\xi, \mu) \tag{3.1}
\end{equation*}
$$

and $\rho_{\delta}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right)=0$ on $A_{\delta / 2}$. The main result of this section is the following.
Proposition 3.1. Let $N \in \mathbb{D}$ and $\delta \in(0,1)$. Assume that $(p, q)$ satisfies $\frac{1}{q}=\theta \frac{1-\varepsilon}{2}$ and $\frac{1}{p}=\frac{1-\theta}{2}$ for some $\theta \in[0,1)$ and $\varepsilon>0$ small enough. Then it holds that

$$
\begin{equation*}
\left\|P_{N}^{x} P_{A_{\delta}^{c}} U(t) \phi\right\|_{L_{t}^{q} L_{x y}^{p}} \lesssim N^{\theta\left(\varepsilon(\alpha+1)-\frac{\alpha}{4}\right)}\|\phi\|_{L^{2}} \tag{3.2}
\end{equation*}
$$

for any $\phi \in L^{2}\left(\mathbb{R}^{2}\right)$.
Remark 3.1. We notice that in the case $\alpha=2$ and $\theta=1 / 2+$, estimate (3.2) was already used in [16] and is a direct consequence of a more general theorem related to homogeneous polynomial hypersurfaces proved by Carbery, Kenig and Ziesler [2]. However, this result does not apply as soon as $\alpha<2$ since the symbol $\omega$ defined in (2.1) is no more homogeneous.

To prove Proposition 3.1, we will need the following result.
Lemma 3.1. Let $N \in \mathbb{D} \backslash\{1\}$. Then

satisfies

\left\|I_{t}\right\|_{L_{x y}^{\infty}} \lesssim N^{-\alpha / 2}|t|^{-1} \tag{3.3}
\end{equation*}
$$

for all $t \in \mathbb{R}^{*}$ and $\delta \in(0,1)$.
Proof. First, recall that the semi-convergent integral $I_{t}$ may be understood as

I_{t}(x, t) & =\lim _{M \rightarrow \infty} \int_{\mathbb{R}^{2}} e^{i(t \omega(\xi, \mu)+x \xi+y \mu)} \varphi_{N}(\xi) \varphi_{\leq M}(\mu) \rho_{\delta}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right) d \xi d \mu \\
& =\lim _{M \rightarrow \infty}\left(I_{t}^{+}+I_{t}^{-}\right) \tag{3.4}
\end{align*}
$$

with

$$
\begin{equation*}
I_{t}^{ \pm}(x, y)=\int_{\mathbb{R}^{2}} e^{i(t \omega(\xi, \mu)+x \xi+y \mu)} \varphi_{N}(\xi) \varphi_{\leq M}(\mu) \rho_{\delta}^{ \pm}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right) d \xi d \mu \tag{3.5}
\end{equation*}
$$

and $\rho_{\delta}^{ \pm}=\rho_{\delta} 1_{\mathbb{R}_{ \pm}}$. We are going to bound $\left|I_{t}^{ \pm}\right|$, uniformly in $x, y$ and $M$. Let $\varepsilon \in(0,1)$ be a small number to be chosen later and define

$$
\begin{aligned}
B_{\varepsilon}^{+} & =\left\{\xi \in \mathbb{R}:\left(\alpha+1+B-\frac{\delta}{2}\right)|t||\xi|^{\alpha}<(1-\varepsilon)|x|\right\} \\
B_{\varepsilon}^{-} & =\left\{\xi \in \mathbb{R}:\left(\alpha+1+B+\frac{\delta}{2}\right)|t||\xi|^{\alpha}>(1+\varepsilon)|x|\right\}
\end{aligned}
$$

Then $I_{t}^{ \pm}$may be decomposed as
$I_{t}^{ \pm}(x, y)=\left(\int_{B_{\varepsilon}^{ \pm} \times \mathbb{R}}+\int_{\left(B_{\varepsilon}^{ \pm}\right)^{c} \times \mathbb{R}}\right) e^{i(t \omega(\xi, \mu)+x \xi+y \mu)} \varphi_{N}(\xi) \varphi_{\leq M}(\mu) \rho_{\delta}^{ \pm}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right) d \xi d \mu$

$$
\begin{equation*}
:=I_{t, 1}^{ \pm}(x, y)+I_{t, 2}^{ \pm}(x, y) \tag{3.6}
\end{equation*}
$$

We estimate $I_{t, 1}^{ \pm}$and rewrite it as

$$
\begin{equation*}
I_{t, 1}^{ \pm}(x, y)=\int_{\mathbb{R}} e^{i y \mu} \varphi_{\leq M}(\mu)\left(\int_{B_{\varepsilon}^{ \pm}} e^{i \psi_{1}(\xi)} \lambda_{1}^{ \pm}(\xi) d \xi\right) d \mu \tag{3.7}
\end{equation*}
$$

where the phase function $\psi_{1}$ is defined by $\psi_{1}(\xi)=x \xi+t \xi\left(|\xi|^{\alpha}+\mu^{2}\right)$, and where $\lambda_{1}^{ \pm}(\xi)=\varphi_{N}(\xi) \rho_{\delta}^{ \pm}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right)$. Then we easily check that

$$
\begin{equation*}
\left|\psi_{1}^{\prime}(\xi)\right| \gtrsim|t|\left(N^{\alpha}+\mu^{2}\right) \text { on } B_{\varepsilon}^{ \pm} \cap \operatorname{supp}\left(\lambda_{1}^{ \pm}\right) \tag{3.8}
\end{equation*}
$$

Indeed if we assume that $\xi \in B_{\varepsilon}^{+} \cap \operatorname{supp}\left(\lambda_{1}^{+}\right)$, then it holds $\mu^{2}<\left(B-\frac{\delta}{2}\right)|\xi|^{\alpha}$ and $|x|>\frac{\alpha+1+B-\delta / 2}{1-\varepsilon}|t|\left|\xi^{\alpha}\right|$, from which it follows $|x|>(1-\varepsilon)^{-1}|t|\left((\alpha+1)|\xi|^{\alpha}+\mu^{2}\right)$. Since $\psi_{1}^{\prime}(\xi)=x+t\left((\alpha+1)|\xi|^{\alpha}+\mu^{2}\right)$, we deduce $\left|\psi_{1}^{\prime}(\xi)\right| \gtrsim \max \left(|x|,|t|\left((\alpha+1)|\xi|^{\alpha}+\right.\right.$ $\left.\mu^{2}\right)$ ). A similar argument leads also to (3.8) for $\xi \in B_{\varepsilon}^{-} \cap \operatorname{supp}\left(\lambda_{1}^{-}\right)$. Moreover, observe that

\left\|\psi_{1}^{\prime \prime}\right\|_{L^{\infty}} \lesssim|t| N^{\alpha-1}, \quad\left\|\lambda_{1}^{ \pm}\right\|_{L^{\infty}} \lesssim 1, \quad\left\|\lambda_{1}^{ \pm}\right\|_{L^{1}} \lesssim N \tag{3.9}
\end{equation*}
$$

and
$\left\|\left(\lambda_{1}^{ \pm}\right)^{\prime}\right\|_{L^{1}} \lesssim N^{-1}\left(\int_{\mathbb{R}}\left|\varphi^{\prime}(\xi / N)\right| d \xi+\int_{\mathbb{R}}\left|\varphi_{N}(\xi)\right| \frac{\mu^{2}}{|\xi|^{\alpha+1}}\left|\left(\rho_{\delta}^{ \pm}\right)^{\prime}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right)\right| d \xi\right) \lesssim 1$.
Using (3.8)-(3.9)-(3.10), an integration by parts yields

\begin{aligned}
\left|\int_{B_{\varepsilon}^{ \pm}} e^{i \psi_{1}} \lambda_{1}^{ \pm}\right| & =\left|\int_{B_{\varepsilon}^{ \pm}}\left(e^{i \psi_{1}}\right)^{\prime} \frac{\lambda_{1}^{ \pm}}{\psi_{1}^{\prime}}\right| d \xi \\
& \lesssim \frac{\left\|\lambda_{1}^{ \pm}\right\|_{L^{\infty}}}{|t|\left(N^{\alpha}+\mu^{2}\right)}+\int_{\mathbb{R}}\left(\frac{\left|\left(\lambda_{1}^{ \pm}\right)^{\prime}\right|}{|t|\left(N^{\alpha}+\mu^{2}\right)}+\frac{\left|\lambda_{1}^{ \pm} \psi_{1}^{\prime \prime}\right|}{\left(t\left(N^{\alpha}+\mu^{2}\right)\right)^{2}}\right) d \xi \\
& \lesssim \frac{\left\|\lambda_{1}^{ \pm}\right\|_{L^{\infty}}}{|t|\left(N^{\alpha}+\mu^{2}\right)}+\frac{\left\|\left(\lambda_{1}^{ \pm}\right)^{\prime}\right\|_{L^{1}}}{|t|\left(N^{\alpha}+\mu^{2}\right)}+\frac{\left\|\lambda_{1}^{ \pm}\right\|_{L^{1}}\left\|\psi_{1}^{\prime \prime}\right\|_{L^{\infty}}}{\left(t\left(N^{\alpha}+\mu^{2}\right)\right)^{2}} \\
& \lesssim|t|^{-1}\left(N^{\alpha}+\mu^{2}\right)^{-1}+|t| N N^{\alpha-1}\left(t\left(N^{\alpha}+\mu^{2}\right)\right)^{-2} \\
& \lesssim|t|^{-1}\left(N^{\alpha}+\mu^{2}\right)^{-1}
\end{aligned}
$$

Coming back to (3.7) we infer

$$
\begin{equation*}
\left|I_{t, 1}^{ \pm}(x, y)\right| \lesssim|t|^{-1} \int_{\mathbb{R}} \frac{d \mu}{N^{\alpha}+\mu^{2}} \lesssim N^{-\alpha / 2}|t|^{-1} \tag{3.11}
\end{equation*}
$$

It remains to estimate $I_{t, 2}^{ \pm}$. Using that

$$
\begin{equation*}
\int_{\mathbb{R}} e^{i\left(t \xi \mu^{2}+y \mu\right)} d \mu=\frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} e^{-i \frac{y^{2}}{4 t \xi}+i \frac{\pi}{4} \operatorname{sgn}(\xi)} \tag{3.12}
\end{equation*}
$$

we get

$$
\begin{aligned}
I_{t, 2}^{+}(x, y)=\int_{\left(B_{\varepsilon}^{+}\right)^{c}} \times \mathbb{R}^{2} & \frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} e^{i\left(x \xi+t \xi|\xi|^{\alpha}-\frac{v^{2}}{4 t \xi}+\frac{\pi}{4} \operatorname{sgn}(\xi)\right)} \\
& \times \mathcal{F}_{\mu}^{-1}\left(\rho_{\delta}^{+}\left(B-\frac{\mu^{2}}{|\xi|^{\alpha}}\right)\right)(u) \mathcal{F}^{-1}\left(\varphi_{\leq M}\right)(y-v-u) \varphi_{N}(\xi) d \xi d u d v
\end{aligned}
$$

Performing the change of variables $u \rightarrow|\xi|^{-\alpha / 2} u$, a dilatation argument leads to

$$
\begin{align*}
I_{t, 2}^{+}(x, y) & =\int_{\mathbb{R}^{2}} \mathcal{F}^{-1}\left(\rho_{\delta}^{+}\left(B-\mu^{2}\right)\right)(v) \mathcal{F}^{-1}\left(\varphi_{\leq M}\right)(y-u)  \tag{3.13}\\
\times & \left(\int_{\left(B_{\varepsilon}^{+}\right)^{c}} e^{i\left(x \xi+t \xi|\xi|^{\alpha}-\frac{\left(u-|\xi|-\frac{\alpha}{2} v\right)^{2}}{4 t \xi}+\frac{\pi}{4} \operatorname{sgn}(\xi)\right)} \frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} \varphi_{N}(\xi) d \xi\right) d u d v
\end{align*}
$$

Since $\rho_{\delta}^{+}\left(B-\mu^{2}\right) \in \mathcal{D}(\mathbb{R})$, we infer

$$
\begin{equation*}
\left|I_{t, 2}^{+}(x, y)\right| \lesssim \sup _{u, v \in \mathbb{R}}\langle v\rangle^{-2}\left|\int_{\left(B_{\varepsilon}^{+}\right)^{c}} e^{i \psi_{2}} \lambda_{2}\right|:=\sup _{u, v \in \mathbb{R}}\langle v\rangle^{-2}\left|J^{+}(u, v)\right| \tag{3.14}
\end{equation*}
$$

where the new phase function $\psi_{2}$ is defined by $\psi_{2}(\xi)=x \xi+t \xi|\xi|^{\alpha}-\frac{u^{2}}{4 t \xi}+\frac{\pi}{4} \operatorname{sgn}(\xi)$, and

$$
\lambda_{2}(\xi)=\frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} e^{i\left(\frac{u v}{\left.2 t \xi|\xi|^{\alpha / 2}-\frac{v^{2}}{4 t \xi|\xi|^{\alpha}}\right)} \varphi_{N}(\xi) . . . . . . . .\right.}
$$

We argue similarly to estimate $I_{t, 2}^{-}$, except that we rewrite $\rho_{\delta}^{-}\left(B-\mu^{2}\right)$ as $\rho_{\delta}^{-}(B-$ $\left.\mu^{2}\right)=\left(\rho_{\delta}^{-}\left(B-\mu^{2}\right)-1\right)+1$. Hence we have,

\begin{align*}
& I_{t, 2}^{-}(x, y)=\int_{\mathbb{R}^{2}} \mathcal{F}_{\mu}^{-1}\left(\rho_{\delta}^{-}\left(B-\mu^{2}\right)-1\right)(v) \mathcal{F}^{-1}\left(\varphi_{\leq M}\right)(y-u)\left(\int_{\left(B_{\varepsilon}^{-}\right)^{c}} e^{i \psi_{2}} \lambda_{2}\right) d u d v  \tag{3.15}\\
&+\int_{\mathbb{R}} \mathcal{F}^{-1}\left(\varphi_{\leq M}\right)(y-u)\left(\int_{\left(B_{\varepsilon}^{-}\right)^{c}} e^{i \psi_{2}} \lambda_{3}\right)
\end{align*}
$$

with $\lambda_{3}(\xi)=\frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} \varphi_{N}(\xi)$. Since $\rho_{\delta}^{-}\left(B-\mu^{2}\right)-1 \in \mathcal{D}(\mathbb{R})$, estimate (3.14) together with (3.15) lead to
(3.16) $\left|I_{t, 2}^{+}(x, y)\right|+\left|I_{t, 2}^{-}(x, y)\right| \lesssim \sup _{u, v \in \mathbb{R}}\left(\langle v\rangle^{-2}\left(\left|J^{+}(u, v)\right|+\left|J^{-}(u, v)\right|\right)+|K(u)|\right)$,
where $J^{-}(u, v)=\int_{\left(B_{\varepsilon}^{-}\right)^{c}} e^{i \psi_{2}} \lambda_{2}$ and $K(u)=\int_{\left(B_{\varepsilon}^{-}\right)^{c}} e^{i \psi_{2}} \lambda_{3}$. Noticing that

$$
\begin{equation*}
\left\|\lambda_{2}\right\|_{L^{1}}+\left\|\lambda_{3}\right\|_{L^{1}} \lesssim N^{1 / 2}|t|^{-1 / 2} \tag{3.17}
\end{equation*}
$$

we get

\left|I_{t, 2}^{ \pm}(x, y)\right| \lesssim N^{1 / 2}|t|^{-1 / 2} \tag{3.18}
\end{equation*}
$$

which is acceptable as soon as $|t|<N^{-(\alpha+1)}$. Therefore we assume now that $|t| \geq N^{-(\alpha+1)}$. Observe that since (3.13) and (3.15) also holds for $I_{t, 1}^{ \pm}$with $\left(B_{\varepsilon}^{ \pm}\right)^{c}$ replaced with $B_{\varepsilon}^{ \pm}$, we deduce from (3.17) that

for any $(t, x, y) \in \mathbb{R}^{*} \times \mathbb{R}^{2}$. Differentiating the phase function we get

& \psi_{2}^{\prime}(\xi)=x+(\alpha+1) t|\xi|^{\alpha}+\frac{u^{2}}{4 t \xi^{2}}  \tag{3.20}\\
& \psi_{2}^{\prime \prime}(\xi)=\alpha(\alpha+1) t \operatorname{sgn}(\xi)|\xi|^{\alpha-1}-\frac{u^{2}}{2 t \xi^{3}} \tag{3.21}
\end{align*}
$$

Let $\gamma \in(0,1)$ be a small parameter that we will choose later, and define

$$
C_{\gamma}=\left\{\xi \in \mathbb{R}:(1-\gamma) \alpha(\alpha+1)|t||\xi|^{\alpha-1}<\frac{u^{2}}{2\left|t \xi^{3}\right|}<(1+\gamma) \alpha(\alpha+1)|t||\xi|^{\alpha-1}\right.
$$

We decompose $J^{ \pm}$as

J^{ \pm}(u, v)=\left(\int_{\left(B_{\varepsilon}^{ \pm}\right)^{c} \cap C_{\gamma}}+\int_{\left(B_{\varepsilon}^{ \pm}\right)^{c} \cap C_{\gamma}^{c}}\right) e^{i \psi_{2}} \lambda_{2}:=J_{1}^{ \pm}(u, v)+J_{2}^{ \pm}(u, v) \tag{3.22}
\end{equation*}
$$

From the definition of $C_{\gamma}$, we have $\left|\psi_{2}^{\prime \prime}(\xi)\right| \gtrsim|t| N^{\alpha-1} \vee \frac{u^{2}}{|t| N^{3}}$ for $\xi \in C_{\gamma}^{c}$. Moreover, we have $\left\|\lambda_{2}\right\|_{L^{\infty}} \lesssim|t|^{-1 / 2} N^{-1 / 2}$ and straightforward calculations lead to

\left\|\lambda_{2}^{\prime}\right\|_{L^{1}} \lesssim|t|^{-1 / 2} N^{-1 / 2}+|t|^{-3 / 2} N^{-\alpha+3 / 2}\langle v\rangle^{2}+|t|^{-3 / 2} N^{-\alpha / 2+5 / 2}|u v| \tag{3.23}
\end{equation*}
$$

The Van der Corput lemma applies and provides

\begin{equation*}
\left|J_{2}^{ \pm}(u, v)\right| \lesssim\left(|t| N^{(\alpha-1)} \vee \frac{u^{2}}{|t| N^{3}}\right)^{-1 / 2}\left(\left\|\lambda_{2}\right\|_{L^{\infty}}+\left\|\lambda_{2}^{\prime}\right\|_{L^{1}}\right) \lesssim N^{-\alpha / 2}|t|^{-1}\langle v\rangle^{2} \tag{3.24}
\end{equation*}
$$

To estimate $J_{1}^{ \pm}$, we will take advantage of the first derivative of $\psi_{2}$ given by (3.20). Let $\xi \in C_{\gamma}$. Then we easily see that

((\alpha+1)+B-\gamma B)|t||\xi|^{\alpha}<|(\alpha+1)| t|\xi|^{\alpha}+\left.\frac{u^{2}}{4 t \xi^{2}}|<((\alpha+1)+B+\gamma B)| t| | \xi\right|^{\alpha}
$$

If $\xi \in\left(B_{\varepsilon}^{+}\right)^{c}$, then

$$
\left.|x|<\frac{\alpha+1+B-\delta / 2}{1-\varepsilon}|t||\xi|^{\alpha}<(1-\varepsilon)^{-1} \frac{\alpha+1+B-\delta / 2}{\alpha+1+B-\gamma B}|(\alpha+1)| t|\xi|^{\alpha}+\frac{u^{2}}{4 t \xi^{2}} \right\rvert\,
$$

and if $\xi \in\left(B_{\varepsilon}^{-}\right)^{c}$, we have

$$
\left.|x|>\frac{\alpha+1+B+\delta / 2}{1+\varepsilon}|t|\left|\xi^{\alpha}\right|>(1+\varepsilon)^{-1} \frac{\alpha+1+B+\delta / 2}{\alpha+1+B+\gamma B}|(\alpha+1)| t|\xi|^{\alpha}+\frac{u^{2}}{4 t \xi^{2}} \right\rvert\,
$$

Since we can always choose $\varepsilon, \gamma>0$ small enough so that $(1-\varepsilon)^{-1} \frac{\alpha+1+B-\delta / 2}{\alpha+1+B-\gamma B}<1$ and $(1+\varepsilon)^{-1} \frac{\alpha+1+B+\delta / 2}{\alpha+1+B+\gamma B}>1$, we infer

\begin{equation*}
\left|\psi_{2}^{\prime}(\xi)\right| \gtrsim|x| \vee|t| N^{\alpha} \vee \frac{u^{2}}{|t| N^{2}} \text { on }\left(B_{\varepsilon}^{ \pm}\right)^{c} \cap C_{\gamma} \tag{3.25}
\end{equation*}
$$

Therefore $J_{1}^{ \pm}$is estimated thanks to (3.23)-(3.25) and integration by parts as follows
$\left|J_{1}^{ \pm}(u, v)\right|=\left|\int_{\left(B_{\varepsilon}^{ \pm}\right)^{c} \cap C_{\gamma}}\left(e^{i \psi_{2}}\right)^{\prime} \frac{\lambda_{2}}{\psi_{2}^{\prime}}\right|$

$$
\lesssim\left(|t| N^{\alpha} \vee \frac{u^{2}}{|t| N^{2}}\right)^{-1}\left(\left\|\lambda_{2}\right\|_{L^{\infty}}+\left\|\lambda_{2}^{\prime}\right\|_{L^{1}}\right)+\left(|t| N^{\alpha} \vee \frac{u^{2}}{|t| N^{2}}\right)^{-2}\left\|\psi_{2}^{\prime \prime}\right\|_{L^{\infty}\left(C_{\gamma}\right)}\left\|\lambda_{2}\right\|_{L^{1}}
$$

$$
\begin{equation*}
\lesssim|t|^{-3 / 2} N^{-\alpha / 2}\langle v\rangle^{2} \lesssim N^{-\alpha / 2}|t|^{-1}\langle v\rangle^{2} . \tag{3.26}
\end{equation*}
$$

Combining (3.22)-(3.24)(3.26) we deduce

$$
\begin{equation*}
\sup _{u, v \in \mathbb{R}}\left(\langle u\rangle^{-2}\left(\left|J^{+}(u, v)\right|+\left|J^{-}(u, v)\right|\right) \lesssim N^{-1 / 2}|t|^{-1}\right. \tag{3.27}
\end{equation*}
$$

as desired. Estimates for $K$ are similar, since (3.23) is replaced with

\left\|\lambda_{3}^{\prime}\right\|_{L^{1}} \lesssim|t|^{-1 / 2} N^{-1 / 2}
$$

We obtain the bound

$$
\begin{equation*}
\sup _{u, v \in \mathbb{R}}|K(u)| \lesssim N^{-1 / 2}|t|^{-1} \tag{3.28}
\end{equation*}
$$

Combining (3.4)-(3.5)-(3.6)-(3.11)-(3.16)-(3.27)-(3.28) we complete the proof of Lemma 3.1.

Proof of Proposition 3.1. The case $N=1$ is straightforward, therefore we assume $N \geq 2$. Interpolating estimates (3.3) and (3.19) we get for any $\varepsilon \in(0,1)$

\left\|I_{t}\right\|_{L_{x y}^{\infty}} \lesssim N^{-\frac{\alpha}{2}+\frac{\varepsilon(\alpha+1)}{2}}|t|^{-1+\frac{\varepsilon}{2}} . \tag{3.29}
\end{equation*}

On the other hand, we get from (3.1) that

P_{N}^{x} P_{A_{\delta}^{c}} U(t) \phi=I_{t} *_{x y}\left(P_{A_{\delta}^{c}} \phi\right)
$$

Thus, thanks to Young inequality and estimate (3.29), we infer

$$
\left\|P_{N}^{x} P_{A_{\delta}^{c}} U(t) \phi\right\|_{L_{x y}^{\infty}} \lesssim N^{-\frac{\alpha}{2}+\frac{\varepsilon(\alpha+1)}{2}}|t|^{-1+\frac{\varepsilon}{2}}\left\|P_{A_{\delta}^{c}} \phi\right\|_{L^{1}}
$$

for any $t \in \mathbb{R}^{*}$. Therefore, by interpolation with the straightforward equality $\|U(t) \phi\|_{L_{x y}^{2}}=\|\phi\|_{L^{2}}$ we deduce that for any $\theta \in[0,1)$,

\left\|P_{N}^{x} P_{A_{\delta}^{c}} U(t) \phi\right\|_{L_{x y}^{p}} \lesssim N^{\theta\left(\frac{\varepsilon(\alpha+1)}{2}-\frac{\alpha}{2}\right)}|t|^{\theta\left(\frac{\varepsilon}{2}-1\right)}\|\phi\|_{L^{p^{\prime}}}
$$

where $\frac{1}{p}+\frac{1}{p^{\prime}}=1$ and $\frac{1}{p}=\frac{1-\theta}{2}$. Remark that we exclude the case $\theta=1$ because the operator $P_{A_{\delta}^{c}}$ is not continuous on $L^{1}\left(\mathbb{R}^{2}\right)$. The previous estimate combined with the triangle inequality and Hardy-Littlewood-Sobolev theorem lead to

\left\|P_{N}^{x} P_{A_{\delta}^{c}} \int_{\mathbb{R}} U\left(t-t^{\prime}\right) f\left(t^{\prime}\right) d t^{\prime}\right\|_{L_{t}^{q} L_{x y}^{p}} \lesssim N^{\theta\left(\varepsilon(\alpha+1)-\frac{\alpha}{2}\right)}\|f\|_{L_{t}^{q^{\prime}} L_{x y}^{p^{\prime}}}, \tag{3.30}
\end{equation*}
$$

for all $f \in \mathcal{S}\left(\mathbb{R}^{3}\right)$, where $\frac{1}{q}+\frac{1}{q^{\prime}}=1$ and $\frac{2}{q}=1-\frac{\varepsilon}{2}$. Estimate (3.1) is then obtained from (3.30) by the classical Stein-Thomas argument.

Corollary 3.1. Assume $\delta \in(0,1), H, N \in \mathbb{D}$ and $f \in X_{H}$. Then for all $s>-\alpha / 8$, it holds that

\left\|P_{A_{\delta}^{c}} P_{N}^{x} \mathcal{F}^{-1}(f)\right\|_{L_{t x y}^{4}} \lesssim N^{s}\|f\|_{X_{H}} . \tag{3.31}
\end{equation*}
$$

Proof. We apply Proposition 3.1 with $\theta=\frac{1}{2-\varepsilon}$ and obtain

$$
\left\|P_{N}^{x} P_{A_{\delta}^{c}} U(t) \phi\right\|_{L_{t x y}^{4+}} \lesssim N^{(-\alpha / 8)+}\|\phi\|_{L^{2}}
$$

for any $\phi \in L^{2}\left(\mathbb{R}^{2}\right)$. Setting $f^{\sharp}(\theta, \xi, \mu)=f(\theta+\omega(\xi, \mu), \xi, \mu)$ it follows then from Minkowski and Cauchy-Schwarz in $\theta$ that

\begin{aligned}
\left\|P_{A_{\delta}^{c}} P_{N}^{x} \mathcal{F}^{-1}(f)\right\|_{L^{4+}} & \lesssim\left\|U(t) P_{A_{\delta}^{c}} P_{N}^{x} \mathcal{F}^{-1}\left(f^{\sharp}\right)\right\|_{L^{4+}} \\
& \lesssim N^{(-\alpha / 8)+} \int_{\mathbb{R}}\left\|f^{\sharp}(\theta, \zeta)\right\|_{L_{\zeta}^{2}} d \theta \\
& \lesssim N^{(-\alpha / 8)+} \sum_{L \in \mathbb{D}} L^{1 / 2}\left\|\varphi_{L}(\theta) f^{\sharp}(\theta, \zeta)\right\|_{L_{\theta \zeta}^{2}} \\
& \lesssim N^{(-\alpha / 8)+}\|f\|_{X_{H}} .
\end{aligned}
$$

Interpolating this with the trivial bound $\left\|\mathcal{F}^{-1}(f)\right\|_{L_{t x y}^{2}} \lesssim\|f\|_{X_{H}}$ we conclude the proof of Corollary 3.1.

We conclude this section by stating a global Strichartz estimate that will not be used in the proof of Theorem 1.1, but that may be of independent interest for future considerations.

Proposition 3.2. Let $N \in \mathbb{D}$. Assume that $(p, q)$ satisfies $\frac{1}{q}=\frac{5 \theta}{12}$ and $\frac{1}{p}=\frac{1-\theta}{2}$ for some $\theta \in[0,1]$. Then it holds that

$$
\begin{equation*}
\left\|P_{N}^{x} U(t) \phi\right\|_{L_{t}^{q} L_{x y}^{p}} \lesssim N^{-\frac{\theta}{6}\left(\alpha-\frac{1}{2}\right)}\|\phi\|_{L^{2}} \tag{3.32}
\end{equation*}
$$

for any $\phi \in L^{2}\left(\mathbb{R}^{2}\right)$.
Proof. As in the proof of Proposition 3.1, it suffices to show that

$$
\widetilde{I}_{t}(x, y):=\int_{\mathbb{R}^{2}} e^{i(t \omega(\xi, \mu)+x \xi+y \mu)} \varphi_{N}(\xi) \varphi_{\leq M}(\mu) d \xi d \mu
$$

satisfies

$$
\left|\widetilde{I}_{t}(x, y)\right| \lesssim N^{\frac{1}{6}-\frac{\alpha}{3}}|t|^{-5 / 6}
$$

with an implicit constant that does not depend on $M \in \mathbb{D}$. Thanks to (3.12) we may rewrite $\widetilde{I}_{t}$ as

$$
\widetilde{I}_{t}(x, y)=\int_{\mathbb{R}} \mathcal{F}^{-1}\left(\varphi_{\leq M}\right)(y-u)\left(\int_{\mathbb{R}} \frac{\sqrt{\pi}}{|t \xi|^{1 / 2}} e^{i \psi_{2}(\xi)} \varphi_{N}(\xi) d \xi\right) d u
$$

where $\psi_{2}(\xi)=x \xi+t \xi|\xi|^{\alpha}-\frac{u^{2}}{4 t \xi}+\frac{\pi}{4} \operatorname{sgn}(\xi)$ was defined in (3.14). Since the third derivative of $\psi_{2}$ is given by $\psi_{2}^{\prime \prime \prime}(\xi)=\alpha(\alpha-1)(\alpha+1) t|\xi|^{\alpha-2}+\frac{3 u^{2}}{2 t \xi^{4}}$, the Van der Corput lemma implies in the case $\alpha>1$ that

\left|\widetilde{I}_{t}(x, y)\right| \lesssim\left(|t| N^{\alpha-2}\right)^{1 / 3}(|t| N)^{-1 / 2} \sim N^{\frac{1}{6}-\frac{\alpha}{3}}|t|^{-5 / 6}

as desired. Now consider the case $\alpha=1$. In the region where $|t| \sim \frac{u^{2}}{|t| N^{3}}$, we get directly that $\left|\psi_{2}^{\prime \prime \prime}\right| \sim|t| N^{-1}$ as previously. Therefore we may assume $|t| \nsim \frac{u^{2}}{|t| N^{3}}$. From (3.21) we deduce $\left|\psi_{2}^{\prime \prime}\right| \gtrsim|t|$ which combined with the Van der Corput lemma provides

\left|\widetilde{I}_{t}(x, y)\right| \lesssim|t|^{-1 / 2}(|t| N)^{-1 / 2} \sim N^{-1 / 2}|t|^{-1} \tag{3.33}
\end{equation*}

On the other hand, we have the trivial bound

$$
\begin{equation*}
\left|\widetilde{I}_{t}(x, y)\right| \lesssim \int_{\mathbb{R}} \frac{\varphi_{N}(\xi)}{|t \xi|^{1 / 2}} d \xi \lesssim N^{1 / 2}|t|^{-1 / 2} \tag{3.34}
\end{equation*}
$$

Gathering (3.33)-(3.34) we infer

$$
\left|\widetilde{I}_{t}(x, y)\right| \lesssim\left(N^{-1 / 2}|t|^{-1}\right)^{2 / 3}\left(N^{1 / 2}|t|^{-1 / 2}\right)^{1 / 3} \sim N^{-1 / 6}|t|^{-5 / 6}
$$

which concludes the proof of (3.32).
Remark 3.2. It follows by applying estimate (3.32) with $\theta=1 / 2$ that

\left\|P_{N}^{x} U(t) \phi\right\|_{L_{t}^{24 / 5} L_{x y}^{4}} \lesssim N^{-\frac{1}{12}\left(\alpha-\frac{1}{2}\right)}\|\phi\|_{L^{2}}
$$

Therefore, arguing as in the proof of Corollary 3.1 we infer that for all $f \in X_{H}$ such that $\operatorname{supp} \mathcal{F}^{-1}(f) \subset[0, T] \times \mathbb{R}^{2}$ for some $T \in(0,1]$, we have

\begin{equation*}
\left\|P_{N}^{x} \mathcal{F}^{-1}(f)\right\|_{L_{t x y}^{4}} \lesssim N^{-\frac{1}{12}\left(\alpha-\frac{1}{2}\right)}\|f\|_{X_{H}} \tag{3.35}
\end{equation*}
$$

Consequently, (3.31) can be viewed as an improvement of estimate (3.35) since outside the curves $\mu^{2}=B|\xi|^{\alpha}$, it allows to recover $\frac{\alpha}{8}$ derivatives instead of $\frac{1}{12}\left(\alpha-\frac{1}{2}\right)$ derivatives in $L^{4}$.

## 4. $L^{2}$ BILINEAR ESTIMATES

For $H, N, L \in \mathbb{D}$, let us define $D_{H, N, L}$ and $D_{H, \infty, L}$ by

D_{H, N, L}=\left\{(\tau, \xi, \mu) \in \mathbb{R}^{3}: \xi \in I_{N},(\xi, \mu) \in \Delta_{H} \text { and }|\tau+\omega(\xi, \mu)| \leq L\right\} \tag{4.1}
\end{equation*}
$$

and

$$
\begin{equation*}
D_{H, \infty, L}=\left\{(\tau, \xi, \mu) \in \mathbb{R}^{3}:(\xi, \mu) \in \Delta_{H} \text { and }|\tau+\omega(\xi, \mu)| \leq L\right\}=\bigcup_{N \in \mathbb{D}} D_{H, N, L} \tag{4.2}
\end{equation*}
$$

Proposition 4.1. Assume that $H_{i}, N_{i}, L_{i} \in \mathbb{D}$ are dyadic numbers and $f_{i}: \mathbb{R}^{3} \rightarrow$ $\mathbb{R}_{+}$are $L^{2}$ functions for $i=1,2,3$.
(1) If $f_{i}$ are supported in $D_{H_{i}, \infty, L_{i}}$ for $i=1,2,3$, then

$$
\begin{equation*}
\int_{\mathbb{R}^{3}}\left(f_{1} * f_{2}\right) \cdot f_{3} \lesssim H_{\min }^{\frac{1}{2 \alpha}+\frac{1}{4}} L_{\min }^{1 / 2}\left\|f_{1}\right\|_{L^{2}}\left\|f_{2}\right\|_{L^{2}}\left\|f_{3}\right\|_{L^{2}} \tag{4.3}
\end{equation*}
$$

(2) Let us suppose that $H_{\min } \ll H_{\max }$ and $f_{i}$ are supported in $D_{H_{i}, \infty, L_{i}}$ for $i=1,2,3$. If $\left(H_{i}, L_{i}\right)=\left(H_{\min }, L_{\max }\right)$ for some $i \in\{1,2,3\}$ then

$$
\int_{\mathbb{R}^{3}}\left(f_{1} * f_{2}\right) \cdot f_{3} \lesssim H_{\max }^{-1 / 2} H_{\min }^{1 / 4} L_{\min }^{1 / 2} L_{\max }^{1 / 2}\left\|f_{1}\right\|_{L^{2}}\left\|f_{2}\right\|_{L^{2}}\left\|f_{3}\right\|_{L^{2}}
$$

Otherwise we have

$$
\int_{\mathbb{R}^{3}}\left(f_{1} * f_{2}\right) \cdot f_{3} \lesssim H_{\max }^{-1 / 2} H_{\min }^{1 / 4} L_{\min }^{1 / 2} L_{\text {med }}^{1 / 2}\left\|f_{1}\right\|_{L^{2}}\left\|f_{2}\right\|_{L^{2}}\left\|f_{3}\right\|_{L^{2}}
$$

(3) If $H_{\min } \sim H_{\max }$ and $f_{i}$ are supported in $D_{H_{i}, N_{i}, L_{i}}$ for $i=1,2,3$, then

$$
\begin{equation*}
\int_{\mathbb{R}^{3}}\left(f_{1} * f_{2}\right) \cdot f_{3} \lesssim N_{\max }^{-\alpha / 2} H_{\min }^{(1 / 4)+} L_{\operatorname{med}}^{1 / 2} L_{\max }^{1 / 2}\left\|f_{1}\right\|_{L^{2}}\left\|f_{2}\right\|_{L^{2}}\left\|f_{3}\right\|_{L^{2}} \tag{4.6}
\end{equation*}
$$

Before proving Proposition 4.1 we give a technical lemma.

Lemma 4.1. Assume $0<\delta<1$. Then we have that

\begin{equation*}
h\left(\zeta_{1}+\zeta_{2}\right) \leq\left|h\left(\zeta_{1}\right)-h\left(\zeta_{2}\right)\right|+f(\delta) \max \left(h\left(\zeta_{1}\right), h\left(\zeta_{2}\right)\right) \tag{4.7}
\end{equation*}
$$

for all $\zeta_{i}=\left(\xi_{1}, \mu_{i}\right) \in \mathbb{R}^{2}, i=1,2$ satisfying

$$
\begin{equation*}
\left(\xi_{1}, \mu_{1}\right),\left(\xi_{2}, \mu_{2}\right) \in A_{\delta} \tag{4.8}
\end{equation*}
$$

and

$$
\xi_{1} \xi_{2}<0 \text { and } \mu_{1} \mu_{2}<0
$$

and where $f$ is a continuous function on $[0,1]$ satisfying $\lim _{\delta \rightarrow 0} f(\delta)=0$.
Proof. Without loss of generality, we may assume

$$
\begin{equation*}
\xi_{1}>0, \mu_{1}>0, \xi_{2}<0, \mu_{2}<0 \text { and } h\left(\zeta_{1}\right) \geq h\left(\zeta_{2}\right) \tag{4.9}
\end{equation*}
$$

Thus, it suffices to prove that

(\alpha+1)\left(\left|\xi_{1}+\xi_{2}\right|^{\alpha}+\left|\xi_{2}\right|^{\alpha}-\left|\xi_{1}\right|^{\alpha}\right)+2 \mu_{2}\left(\mu_{1}+\mu_{2}\right) \leq f(\delta) h\left(\zeta_{1}\right) \tag{4.10}
\end{equation*}
$$

Thanks to (4.8) and (4.9), we have that

\left|\xi_{2}\right|^{\alpha} \leq g(\delta)\left|\xi_{1}\right|^{\alpha} \text { with } g(\delta)=\frac{\alpha+1+B+\delta}{\alpha+1+B-\delta} \xrightarrow[\delta \rightarrow 0]{ } 1 \tag{4.11}
\end{equation*}
$$

This implies that

$$
\begin{aligned}
\mu_{2}\left(\mu_{1}+\mu_{2}\right) & \leq(B+\delta)\left|\xi_{2}\right|^{\alpha}-(B-\delta)^{1 / 2}\left|\xi_{2}\right|^{\alpha / 2} \mu_{1} \\
& \leq(B+\delta)\left|\xi_{2}\right|^{\alpha}-(B-\delta)\left|\xi_{1} \xi_{2}\right|^{\alpha / 2} \\
& \leq f_{1}(\delta)\left|\xi_{2}\right|^{\alpha}
\end{aligned}
$$

with

$$
f_{1}(\delta)=B+\delta-\frac{B-\delta}{g(\delta)^{1 / 2}} \xrightarrow[\delta \rightarrow 0]{ } 0
$$

On the other hand, using (4.11) again we infer

$$
\left|\xi_{1}+\xi_{2}\right|^{\alpha}=\left.\left|\left|\xi_{1}\right|-\left|\xi_{2}\right|^{\alpha} \leq f_{2}(\delta)\right| \xi_{1}\right|^{\alpha} \text { with } f_{2}(\delta)=\left(g(\delta)^{1 / \alpha}-1\right)^{\alpha} \underset{\delta \rightarrow 0}{\longrightarrow} 0
$$

and

$$
\left|\xi_{2}\right|^{\alpha}-\left|\xi_{1}\right|^{\alpha} \leq\left|\xi_{1}\right|^{\alpha} \leq f_{3}(\delta)\left|\xi_{1}\right|^{\alpha} \text { with } f_{3}(\delta)=g(\delta)-1 \underset{\delta \rightarrow 0}{ } 0
$$

Estimate (4.10) follows then by choosing $f=f_{1}+f_{2}+f_{3}$.
Proof of Proposition 4.1. First we show part (1). We observe that

$$
\begin{equation*}
I:=\int_{\mathbb{R}^{3}}\left(f_{1} * f_{2}\right) \cdot f_{3}=\int_{\mathbb{R}^{3}}\left(\tilde{f}_{1} * f_{3}\right) \cdot f_{2}=\int_{\mathbb{R}^{3}}\left(\widetilde{f}_{2} * f_{3}\right) \cdot f_{1} \tag{4.12}
\end{equation*}
$$

where $\widetilde{f}_{i}(\tau, \zeta)=f_{i}(-\tau,-\zeta)$. Therefore we can always assume that $L_{1}=L_{\text {min }}$. Moreover, let us define $f_{i}^{\sharp}(\theta, \zeta)=f_{i}(\theta+\omega(\zeta), \zeta)$ for $i=1,2,3$. In view of the assumptions on $f_{i}$, the functions $f_{i}^{\sharp}$ are supported in the sets

$$
D_{H_{i}, \infty, L_{i}}^{\sharp}=\left\{(\theta, \xi, \mu) \in \mathbb{R}^{3}:(\xi, \mu) \in \Delta_{H_{i}} \text { and }|\theta| \leq L_{i}\right\} .
$$

We also note that $\left\|f_{i}\right\|_{L^{2}}=\left\|f_{i}^{\sharp}\right\|_{L^{2}}$. Then it follows that

$$
\begin{equation*}
I=\int_{\mathbb{R}^{6}} f_{1}^{\sharp}\left(\theta_{1}, \zeta_{1}\right) f_{2}^{\sharp}\left(\theta_{2}, \zeta_{2}\right) f_{3}^{\sharp}\left(\theta_{1}+\theta_{2}+\Omega\left(\zeta_{1}, \zeta_{2}\right), \zeta_{1}+\zeta_{2}\right) d \theta_{1} d \theta_{2} d \zeta_{1} d \zeta_{2} . \tag{4.13}
\end{equation*}
$$

For $i=1,2,3$, we define $F_{i}(\zeta)=\left(\int_{\mathbb{R}} f_{i}^{\sharp}(\theta, \zeta)^{2} d \theta\right)^{1 / 2}$. Thus applying the CauchySchwarz and Young inequalities in the $\theta$ variable we get

\begin{align*}

The aim of this section is to derive energy estimates for the solutions of (1.1) and the solutions of the equation satisfied by the difference of two solutions of (1.1). In order to simplify the notations, we will instead derive energy estimates on the solutions $v$ of the more general equation

Note that due to the lack of derivative on the lowest frequencies term $P_{\ll H} u$, Lemma 6.2 does not permit to control the term $\mathcal{I}_{H}^{14}(v)$ without loosing a $H^{\frac{2}{\alpha}-\frac{3}{2}}$ factor. This is why we modify the energy by adding the cubic term in (6.3). Let us rewrite $\mathcal{L}_{H}(v)$ as $\sum_{i=1}^{3} \mathcal{L}_{H}^{i}(v)$ with

\end{gathered}

and

After a few integrations by parts, we obtain thanks to (2.4) that

&+H^{-1} \int_{\mathbb{R}^{2}} \Pi_{\eta}\left(P_{\ll H} u_{x}, v_{y y}\right) P_{H} v .
\end{aligned}

Choosing $\eta=-\frac{1}{c_{1}} \eta_{3}$, a cancellation occurs and we get

In the case $u=v$, it suffices to set $\eta=-\frac{1}{2 c_{1}} \eta$ to obtain $2 \mathcal{I}_{H}^{14}(v)+\mathcal{L}_{H}^{3}(v)=$ $\mathcal{L}_{H}^{31}(v)+\mathcal{L}_{H}^{32}(v)$. Now we use estimate (6.11) to bound the terms $\mathcal{L}_{H}^{31}(v), \mathcal{L}_{H}^{32}$ as well as $\mathcal{L}_{H}^{1}(v)$. We get that

$\sum_{H \in \mathbb{D} \backslash\{1\}} \sup _{t_{H} \in[0, T]} H^{2 \sigma}\left|\int_{0}^{t_{H}}\left(\mathcal{L}_{H}^{31}(v)+\mathcal{L}_{H}^{32}(v)+\mathcal{L}_{H}^{1}(v)\right) d t\right| \lesssim\|u\|_{F^{s_{\alpha}+}(T)}\|v\|_{F^{\sigma}(T)}\|v\|_{F^{\sigma}(T)}$.
Finally to deal with $\mathcal{L}_{H}^{2}(v)$, we integrate by parts and use that

& -H^{-1} \int_{\mathbb{R}^{2}} \Pi_{\eta}\left(P_{\ll H} u_{x}, v\right) P_{H} D_{x}^{\alpha} v \\
= & -H^{-1 / \alpha} \int_{\mathbb{R}^{2}} \Pi_{\eta \widetilde{\eta}}\left(P_{\ll H} u_{x}, v_{x}\right) P_{H} v-H^{-1} \int_{\mathbb{R}^{2}} \Pi_{\eta}\left(P_{\ll H} u_{x}, v\right) P_{H} D_{x}^{\alpha} v,
\end{aligned}

Estimates for the fourth order terms. We get using (2.5) and Hölder inequality that

& \lesssim \sum_{H_{1} \ll H} H_{1}^{\frac{3}{2 \alpha}-\frac{3}{4}}\left(\left\|P_{\ll H_{1}} u_{1}\right\|_{L^{4}}\left\|P_{\sim H_{1}} u_{2}\right\|_{L^{4}}+\left\|P_{\gtrsim H_{1}} u_{1}\right\|_{L^{4}}\left\|u_{2}\right\|_{L^{4}}\right)\left\|P_{\sim H} v\right\|_{L^{2}}\left\|P_{H} v\right\|_{L^{2}}
\end{aligned}

(6.29) $\sum_{H \in \mathbb{D} \backslash\{1\}} \sup _{t_{H} \in[0, T]} H^{2 \sigma}\left|\int_{0}^{t_{H}} \mathcal{N}_{H}^{1}(v) d t\right| \lesssim\left\|u_{1}\right\|_{B^{s_{\alpha}+(T)}}\left\|u_{2}\right\|_{B^{s_{\alpha}+(T)}}\|v\|_{B^{\sigma}(T)}^{2}$.

Finally we evaluate the contribution of $\mathcal{N}_{H}^{3}(v)$ since by (2.3), the term $\mathcal{N}_{H}^{2}(v)$ could be treated similarly. We perform a dyadic decomposition on $u$ and $v$ to obtain

& +c_{1} H^{-1} \sum_{H_{1} \gtrsim H} \int_{\mathbb{R}^{2}} \Pi_{\eta}\left(P_{\ll H} u, v\right) P_{H} \partial_{x}\left(P_{H_{1}} u P_{\sim H_{1}} v\right) \\
:= & \mathcal{N}_{H}^{31}(v)+\mathcal{N}_{H}^{32}(v)+\mathcal{N}_{H}^{33}(v) .
\end{aligned}
$$

By using estimate (2.5) we infer that

& \lesssim \sum_{H_{1}, H_{2} \ll H} H_{1}^{\frac{1}{\alpha}-\frac{1}{4}}\left\|P_{H_{1}} u\right\|_{L^{2}} H_{2}^{\frac{1}{\alpha}-\frac{1}{4}}\left\|P_{H_{2}} u\right\|_{L^{2}}\left\|P_{\sim H} v\right\|_{L^{2}}^{2}
\end{aligned}

from which we deduce

$\sum_{H \in \mathbb{D} \backslash\{1\}^{t_{H} \in[0, T]}} \sup H^{2 s}\left|\int_{0}^{t_{H}} \mathcal{N}_{H}(v) d t\right| \lesssim\left(\left\|u_{1}\right\|_{B^{s \alpha+}(T)}\left\|u_{2}\right\|_{B^{s \alpha+}(T)}+\|u\|_{B^{s}(T)}^{2}\right)\|v\|_{B^{s}(T)}^{2}$,
which combined with (6.18)-(6.19) and (6.28) concludes the proof of Proposition 6.1.

## 7. Proof of Theorem 1.1.

The proof of Theorem 1.1 closely follows the proof of existence and uniqueness given in [12]. We start with a well-posedness result for smooth initial data $u_{0}$ in $E^{\infty}=H^{\infty}\left(\mathbb{R}^{2}\right)$. This result can be easily obtained with a parabolic regularization of (1.1) by adding an extra term $-\varepsilon \Delta u$ and going to the limit as $\varepsilon \rightarrow 0$. We refer the reader to [10] for more details.

Theorem 7.1. Assume that $u_{0} \in E^{\infty}$. Then there exist a positive time $T$ and a unique solution $u \in C\left([-T, T] ; E^{\infty}\right)$ of (1.1) with initial data $u(0,)=.u_{0}($.$) .$ Moreover $T=T\left(\left\|u_{0}\right\|_{E^{3}}\right)$ is a nonincreasing function of $\left\|u_{0}\right\|_{E^{3}}$ and the flow-map is continuous.

### 7.1. A priori estimates for $E^{\infty}$ solutions.

Theorem 7.2. Assume that $s>s_{\alpha}$. For any $M>0$ there exists $T=T(M)>0$ such that, for all initial data $u_{0} \in E^{\infty}$ satisfying $\left\|u_{0}\right\|_{E^{s}} \leq M$, the smooth solution $u$ given by Theorem 7.1 is defined on $[-T, T]$ and moreover

$$
\begin{equation*}
u \in C\left([-T, T] ; E^{\infty}\right) \quad \text { and } \quad\|u\|_{L_{T}^{\infty} E^{s}} \lesssim\left\|u_{0}\right\|_{E^{s}} \tag{7.1}
\end{equation*}
$$

To obtain Theorem 7.2 we will need the following result proved in [12].
Lemma 7.1. Assume that $s \geq 0, T>0$ and $u \in C\left([-T, T] ; E^{\infty}\right)$. Consider for $0 \leq T^{\prime} \leq T$

The map $T^{\prime} \mapsto \Lambda_{T^{\prime}}^{s}$ is nondecreasing, continuous on $[0, T)$ and moreover

\lim _{T^{\prime} \rightarrow 0} \Lambda_{T^{\prime}}^{s}(u)=0 \tag{7.3}
\end{equation*}
$$

Proof of Theorem 7.2 First note that we can always assume that the initial data $u_{0}$ have a small $E^{s}$-norm. Indeed, if $u(t, x, y)$ is a solution of (1.1) then $u_{\lambda}(t, x, y)=\lambda u\left(\lambda^{1+1 / \alpha} t, \lambda^{1 / \alpha} x, \lambda^{1 / 2} y\right)$ is a solution of (1.1) on the time interval $\left[0, \lambda^{-(1+1 / \alpha)} T\right]$, with initial data $u_{\lambda}(0, x, y)=\lambda u\left(\lambda^{1 / \alpha} x, \lambda^{1 / 2} y\right)$. On the other hand, one can easily check that

\left\|u_{\lambda}(0, x, y)\right\|_{E^{s}} \lesssim \lambda^{\frac{3}{4}-\frac{1}{2 \alpha}}\left(1+\lambda^{s}\right)\|u(0, x, y)\|_{E^{s}} \tag{7.4}
\end{equation*}

and then, choosing $\lambda \sim \varepsilon^{\left(\frac{3}{4}-\frac{1}{2 \alpha}\right)^{-1}}\left\|u_{0}\right\|_{E^{s}}^{\left(\frac{3}{4}-\frac{1}{2 \alpha}\right)^{-1}}$ we see that $u_{\lambda}(0,$.$) belongs to$ $B^{s}(\varepsilon)$ the ball of $E^{s}$ centered at the origin with radius $\varepsilon$. Hence it is enough to prove that if $u_{\lambda}(0,.) \in B^{s}(\varepsilon)$, Theorem 7.2 holds with $T=1$. This will prove the result with $T\left(\left\|u_{0}\right\|_{E^{s}}\right) \sim\left\|u_{0}\right\|_{E^{s}}^{-(1+1 / \alpha)(3 / 4-1 /(2 \alpha))}$.

In view of those considerations, we take now $u_{0} \in E^{\infty} \cap B^{s}(\varepsilon)$ and let $u \in$ $C\left([-T, T] ; E^{\infty}\right)$ be the solution of (1.1) given by Theorem 7.1 (with $0 \leq T \leq 1$ ). Then gathering the linear estimate (2.9), Proposition 5.1, (6.5) and (6.10) we get

\Lambda_{T}^{\beta}(u)^{2} \lesssim\left(1+\left\|u_{0}\right\|_{E^{0}}\right)\left\|u_{0}\right\|_{E^{\beta}}^{2}+\left(\Lambda_{T}^{s}(u)+\Lambda_{T}^{s}(u)^{2}\right) \Lambda_{T}^{\beta}(u)^{2} \tag{7.5}
\end{equation*}
$$

for all $\beta \geq s>s_{\alpha}$. Using (7.5) with $\beta=s$, a continuity argument and that $\lim _{t \rightarrow 0} \Lambda_{t}^{s}(u)=0$, we have $\Lambda_{T}^{s}(u) \lesssim \varepsilon$ as soon as $\left\|u_{0}\right\|_{E^{s}} \leq \varepsilon$. By estimate (2.9)
together with the short time estimate (5.1) it follows then that for $\left\|u_{0}\right\|_{E^{s}} \leq \varepsilon$,

Then Lemma 2.1, estimates (2.9), (5.1) and (7.5) lead to

for all $\beta \geq s$ as soon as $\left\|u_{0}\right\|_{E^{s}} \leq \varepsilon$. Using this above estimate with $\beta=3$ we can apply Theorem 7.1 a finite number of time and thus extend the solution $u$ of (1.1) on the time interval $[-1,1]$.
7.2. $L^{2}$-Lipschitz bounds and uniqueness. Let us consider two solutions $u_{1}$ and $u_{2}$ defined on $[-T, T]$, with initial data $\varphi_{1}$ and $\varphi_{2}$ and assume moreover that

If we define the function $v$ by $v=u_{1}-u_{2}$, we see that $v$ is a solution of (6.1) with $u=u_{1}+u_{2}$ and moreover $u$ solves (6.2) with a nonlinear term which is $u_{1}^{2}+u_{2}^{2}$. It follows then from (6.5), (6.9), (2.9), the short time estimate (5.2) together with the smallness assumptions (7.8) that

With this $L^{2}$-bound in hand we can now state our uniqueness result.
Proposition 7.1. Let $s>s_{\alpha}$. Consider $u_{1}$ and $u_{2}$ two solutions of (1.1) in $C\left([-T, T] ; E^{s}\right) \cap B^{s}(T) \cap F^{s}(T)$ for some $T>0$. If $u_{1}(0,)=.u_{2}(0,$.$) , then u_{1}=u_{2}$ on the time interval $[-T, T]$.

Proof. Let be $C=\max \left(\Gamma_{T}^{s}\left(u_{1}\right), \Gamma_{T}^{s}\left(u_{2}\right)\right)$. We consider the same dilatations $u_{i, \lambda}$ of $u_{i}$ as in the proof of Theorem 7.2. As previously, they are solutions of (1.1) on $\left[-T^{\prime}, T^{\prime}\right]$ with $T^{\prime}=\lambda^{-(1+1 / \alpha)} T$ and with initial data $u_{i, \lambda}(0, x, y)=$ $\lambda u\left(0, \lambda^{1 \alpha} x, \lambda^{1 / 2} y\right)$. Then since we have

$$
\begin{equation*}
\left\|u_{i, \lambda}(0, .)\right\|_{E^{s}} \lesssim \lambda^{3 / 4-1 /(2 \alpha)}\left(1+\lambda^{s}\right)\left\|u_{i, \lambda}(0, .)\right\|_{E^{s}} \tag{7.10}
\end{equation*}
$$

and

$$
\begin{align*}
\left\|u_{i, \lambda}\right\|_{L_{T^{\prime}}^{\infty} E^{s}}+\left\|u_{i, \lambda}\right\|_{B^{s}\left(T^{\prime}\right)} & \lesssim \lambda^{3 / 4-1 /(2 \alpha)}\left(1+\lambda^{s}\right)\left(\left\|u_{i, \lambda}\right\|_{L_{T}^{\infty} E^{s}}+\left\|u_{i, \lambda}\right\|_{B^{s}(T)}\right)  \tag{7.11}\\
12) & \lesssim C \lambda^{3 / 4-1 /(2 \alpha)}\left(1+\lambda^{s}\right) . \tag{7.12}
\end{align*}
$$

Choosing $\lambda$ small enough we get

$$
\begin{equation*}
\left\|u_{i, \lambda}\right\|_{L_{T^{\prime}}^{\infty} E^{s}} \lesssim \varepsilon, \text { and }\left\|u_{i, \lambda}\right\|_{B^{s}\left(T^{\prime}\right)} \lesssim \varepsilon \tag{7.13}
\end{equation*}
$$

We prove now that for $\tilde{T}<T^{\prime}$ small enough, we also have

$$
\begin{equation*}
\left\|u_{i, \lambda}\right\|_{F^{s}(\tilde{T})} \lesssim \varepsilon \tag{7.14}
\end{equation*}
$$

Since $\left\|u_{i, \lambda}\right\|_{F^{s}(T)} \leq C$, we can always find $H \in \mathbb{D}$ such that

$$
\begin{equation*}
\left\|P_{>H} u_{i, \lambda}\right\|_{F^{s}(\tilde{T})} \leq\left\|P_{>H} u_{i, \lambda}\right\|_{F^{s}(T)} \leq \varepsilon, i=1,2 . \tag{7.15}
\end{equation*}
$$

Moreover since $\|u\|_{\mathcal{N}^{s}(\tilde{T})} \leq C\|u\|_{L_{\tilde{T}}^{2} E^{s}}$, we infer from (2.9), Hölder inequality and the Sobolev embedding $E^{s} \hookrightarrow H^{1 / 2}\left(\mathbb{R}^{2}\right) \hookrightarrow L^{4}\left(\mathbb{R}^{2}\right)$ (since $s \geq 1 / 2$ ) that

$$
\begin{align*}
\left\|P_{\leq H} u_{i, \lambda}\right\|_{F_{\widetilde{T}}^{s}} & \leq\left\|u_{i, \lambda}\right\|_{B_{\widetilde{T}}^{s}}+\left\|P_{\leq H} \partial_{x}\left(u_{i, \lambda}^{2}\right)\right\|_{L_{\widetilde{T}}^{2} E^{s}}  \tag{7.16}\\
& \leq\left\|u_{i, \lambda}\right\|_{B_{\widetilde{T}}^{s}}+\tilde{T}^{1 / 2} H^{s+1 / \alpha}\left\|P_{\leq H}\left(u_{i, \lambda}^{2}\right)\right\|_{L_{\widetilde{T}}^{\infty} L_{x, y}^{2}}  \tag{7.17}\\
& \leq \varepsilon+\tilde{T}^{1 / 2} H^{s+1 / \alpha}\left\|u_{i, \lambda}\right\|_{L_{\widetilde{T}}^{\infty} L_{x, y}^{4}}^{2}  \tag{7.18}\\
& \leq \varepsilon+\tilde{T}^{1 / 2} H^{s+1 / \alpha}\left\|u_{i, \lambda}\right\|_{L_{\widetilde{T}}^{\infty} H^{1 / 2}} . \tag{7.19}
\end{align*}
$$

This leads to

$$
\begin{align*}
\left\|P_{\leq H} u_{i, \lambda}\right\|_{F_{\overparen{T}}^{s}} & \leq \varepsilon+\tilde{T}^{1 / 2} H^{s+1 / \alpha}\left\|u_{i, \lambda}\right\|_{L_{\tilde{T}}^{\infty} H^{1 / 2}}^{2}  \tag{7.20}\\
& \leq \varepsilon+\tilde{T}^{1 / 2} H^{s+1 / \alpha}\left\|u_{i, \lambda}\right\|_{L_{\tilde{T}}^{\infty} E^{s}}^{2}  \tag{7.21}\\
& \leq 2 \varepsilon \tag{7.22}
\end{align*}
$$

by choosing $\tilde{T}$ small enough. Gathering estimates (7.13), (7.15) and (7.20), we thus obtain that the smallness condition (7.8) holds, which shows that $u_{1}=u_{2}$ on $[-\tilde{T}, \tilde{T}]$ (since (7.9) holds). Using the same argument a finite number of time we obtain that $u_{1}=u_{2}$ on $\left[-T^{\prime}, T^{\prime}\right]$ and so on $[-T, T]$ by dilatation.
7.3. Existence. Let $s_{\alpha}<s<3$ and $u_{0} \in E^{s}$. By scaling considerations we can always assume that $u_{0} \in B^{s}(\varepsilon)$. Following [12] we are going to use the Bona-Smith argument to obtain the existence of a solution $u$ with $u_{0}$ as initial data.

Consider $\rho \in S\left(\mathbb{R}^{2}\right)$ with $\int \rho(x, y) d x d y=1$ and $\int x^{i} y^{j} \rho(x, y) d x d y=0$ for $0 \leq i \leq[s]+1,0 \leq j \leq[s]+1,1 \leq i+j$ and let us define $\rho_{\lambda}=\lambda^{1+1 / \alpha} \rho\left(\lambda^{1 / \alpha} x, \lambda^{1 / 2} y\right)$. Then following [1] we have

Lemma 7.2. Let $s \geq 0, \varphi \in E^{s}$ and $\varphi_{\lambda}=\rho_{\lambda} * \varphi$. Then,

$$
\begin{equation*}
\left\|\varphi_{\lambda}\right\|_{E^{s+\delta}} \lesssim \lambda^{-\delta}\|\varphi\|_{E^{s}}, \forall \delta \leq 0 \tag{7.23}
\end{equation*}
$$

and

$$
\begin{equation*}
\left\|\varphi_{\lambda}-\varphi\right\|_{E^{s-\delta}}=o\left(\lambda^{\delta}\right), \forall \delta \in[0, s] \tag{7.24}
\end{equation*}
$$

Consider now the smooth initial data $u_{0, \lambda}=\rho_{\lambda} * u_{0}$. Since $u_{0, \lambda} \in H^{\infty}\left(\mathbb{R}^{2}\right)$ for any $\lambda>0$, by Theorem 7.1, there exist $T_{\lambda}>0$ and an unique solution $u$ of (1.1) such that $u_{\lambda} \in C\left(\left[-T_{\lambda}, T_{\lambda}\right] ; H^{\infty}\left(\mathbb{R}^{2}\right)\right)$ with initial data $u_{\lambda}(0,)=.u_{0, \lambda}$. Note first that from (7.23) we have $\left\|u_{\lambda, 0}\right\|_{E^{s}} \leq\left\|u_{0}\right\|_{E^{s}} \leq \varepsilon$. Hence following the proof of Theorem 7.2, the sequence $\left(u_{\lambda}\right)$ can be extended on the interval $[-1,1]$ and moreover
(7.25) $\quad \Gamma_{1}^{s}\left(u_{\lambda}\right) \leq C\left\|u_{\lambda, 0}\right\|_{E^{s}} \lesssim \varepsilon$ and $\Gamma_{1}^{s+s_{\alpha}^{+}}\left(u_{\lambda}\right) \lesssim\left\|u_{0, \lambda}\right\|_{E^{s+s_{\alpha}^{+}}} \lesssim \lambda^{-s_{\alpha}^{+}}\left\|u_{0}\right\|_{E^{s}}$.

Then we get from (7.9) and (7.24) that for $0<\lambda^{\prime} \leq \lambda$,

$$
\begin{equation*}
\Gamma_{1}^{0}\left(u_{\lambda}-u_{\lambda^{\prime}}\right) \lesssim\left\|u_{0, \lambda}-u_{0, \lambda^{\prime}}\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}=o\left(\lambda^{s}\right) \tag{7.26}
\end{equation*}
$$

Moreover, from estimates (2.9), (5.1), (6.8) we see that, for $s>s_{\alpha}$,

$$
\begin{align*}
\Gamma_{1}^{s}\left(u_{\lambda}-u_{\lambda^{\prime}}\right)^{2} & \lesssim\left(1+\left\|u_{0, \lambda}-u_{0, \lambda^{\prime}}\right\|_{E^{0}}\right)\left\|u_{0, \lambda}-u_{0, \lambda^{\prime}}\right\|_{E^{s}}^{2}  \tag{7.27}\\
& +\left(\Gamma_{1}^{s+s_{\alpha}^{+}}\left(u_{\lambda}\right)+\Gamma_{1}^{s+s_{\alpha}^{+}}\left(u_{\lambda^{\prime}}\right)\right) \Gamma_{1}^{0}\left(u_{\lambda}-u_{\lambda^{\prime}}\right) \Gamma_{1}^{s}\left(u_{\lambda}-u_{\lambda^{\prime}}\right)  \tag{7.28}\\
& +\left(\Gamma_{1}^{s}\left(u_{\lambda}\right)^{2}+\Gamma_{1}^{s}\left(u_{\lambda^{\prime}}\right)^{2}\right) \Gamma_{1}^{s}\left(u_{\lambda}-u_{\lambda^{\prime}}\right)^{2} \tag{7.29}
\end{align*}
$$

which leads to
(7.30) $\Gamma_{1}^{s}\left(u_{\lambda}-u_{\lambda^{\prime}}\right)^{2} \lesssim\left\|u_{0, \lambda}-u_{0, \lambda^{\prime}}\right\|_{E^{s}}^{2}+\left(\Gamma_{1}^{s+s_{\alpha}^{+}}\left(u_{\lambda}\right)+\Gamma_{1}^{s+s_{\alpha}^{+}}\left(u_{\lambda^{\prime}}\right)\right) \Gamma_{1}^{0}\left(u_{\lambda}-u_{\lambda^{\prime}}\right)$.

Thus we have

$$
\begin{equation*}
\left\|u_{\lambda}-u_{\lambda^{\prime}}\right\|_{L_{1}^{\infty} E^{s}} \lesssim \Gamma_{1}^{s}\left(u_{\lambda}-u_{\lambda^{\prime}}\right) \rightarrow 0 \text { if } \lambda \rightarrow 0 . \tag{7.31}
\end{equation*}
$$

This proves that the sequence $\left(u_{\lambda}\right)$ converges in the norm $\Gamma_{1}^{s}$ to a solution $u$ of (1.1), which ends the proof.
7.4. Continuity of the flow map. We refer to [12] for the continuity of the flowmap, which follows easily now from the results given in the previous subsections together with Theorem 7.1

## 8. Appendix.

In this section we prove our $C^{2}$ ill-posedness result for initial data in $E^{s}$ (for all $s \in \mathbb{R}$ ) when $1 \leq \alpha<2$. This extends previous results in [7] where the ill-posedness of (1.1) is proved in $E^{s}$, for all $s \in \mathbb{R}$, assuming that $\alpha \leq 4 / 3$. This result has to be viewed as an extension of the well-known result in [17] where the $C^{2}$ ill-posedness in $H^{s}(\mathbb{R})$ (for all $s \in \mathbb{R}$ ) of the one dimensional generalized Benjamin-Ono equation $\partial_{t} u+D_{x}^{\alpha} u_{x}=u u_{x}$ is proved for all $\alpha \in[1,2[$.

Following [17], we see that it is enough to build a sequence of functions $f_{N}$ such that, for all $s \in \mathbb{R}$,

$$
\begin{equation*}
\left\|f_{N}\right\|_{E^{s}} \leq C \tag{8.1}
\end{equation*}
$$

and

$$
\begin{equation*}
\lim _{N \rightarrow+\infty}\left\|\int_{0}^{t} U\left(t-t^{\prime}\right)\left[U\left(t^{\prime}\right) f_{N} U\left(t^{\prime}\right)\left(f_{N}\right)_{x}\right] d t^{\prime}\right\|_{E_{s}}=+\infty . \tag{8.2}
\end{equation*}
$$

Let $N$ large enough, $\gamma \ll 1$ and $0<\varepsilon \ll 1$ such that $\gamma^{\varepsilon} \lesssim 1$. Let us now define the subsets of $\mathbb{R}^{2}$,

$$
\begin{equation*}
Q_{1}^{+}=[\gamma / 2, \gamma] \times\left[\gamma^{\varepsilon}, 2 \gamma^{\varepsilon}\right] \quad \text { and } \quad Q_{2}^{+}=[N, N+\gamma] \times\left[-\gamma^{\varepsilon} / 2,-\gamma^{\varepsilon}\right] \tag{8.3}
\end{equation*}
$$

Then define $Q_{1}^{-}=-Q_{1}^{+}$and $Q_{2}^{-}=-Q_{2}^{+}$. We consider $f_{N}$ defined through its Fourier transform by
(8.4) $\mathcal{F}\left(f_{N}\right)(\zeta)=\gamma^{-\frac{1+\varepsilon}{2}}\left(1_{Q_{1}^{+}}(\zeta)+1_{Q_{1}^{-}}(\zeta)\right)+\gamma^{-\frac{1+\varepsilon}{2}} N^{-\alpha s}\left(1_{Q_{2}^{+}}(\zeta)+1_{Q_{2}^{-}}(\zeta)\right)$.

Clearly the sequence $f_{N}$ is real valued and moreover (8.1) holds by obvious calculations. Consider now

$$
I_{N}(t, x, y)=\int_{0}^{t} U\left(t-t^{\prime}\right)\left[U\left(t^{\prime}\right) f_{N} U\left(t^{\prime}\right)\left(f_{N}\right)_{x}\right] d t^{\prime}
$$

Standard calculations leads then to

$$
I_{N}=\int_{\mathbb{R}^{4}} e^{i(x \xi+y \mu+t \omega(\zeta))} \xi \mathcal{F}\left(f_{N}\right)\left(\zeta_{1}\right) \mathcal{F}\left(f_{N} J\right)\left(\zeta-\zeta_{1}\right) \frac{e^{i t \Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)}-1}{\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)} d \zeta d \zeta_{1}
$$

with $\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)=\omega(\zeta)-\omega\left(\zeta_{1}\right)-\omega\left(\zeta-\zeta_{1}\right)$. By localization considerations, observe now that $I_{N}$ can be rewritten as the sum of eight terms with disjoint supports corresponding to each different interactions in the nonlinear term. Hence,
considering only the low-high interaction $1_{Q_{1}^{+}}(\zeta) 1_{Q_{2}^{+}}(\zeta)$, it will be enough to prove that (8.2) holds where $\mathcal{F}\left(I_{N}\right)$ is now replaced by

$$
\mathcal{F}\left(I_{N}\right)(t, \zeta)=\gamma^{-(1+\varepsilon)} N^{-\alpha s} e^{i t \omega(\zeta)} \xi \int_{\zeta_{1} \in Q_{1}^{+}, \zeta-\zeta_{1} \in Q_{2}^{+}} \frac{e^{i t \Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)}-1}{\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)} d \zeta_{1}
$$

We claim now that for $\zeta_{1} \in Q_{1}^{+}, \zeta-\zeta_{1} \in Q_{2}^{+}$and $\gamma=o(N)$, then it holds,

$$
\begin{equation*}
\left|\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)\right| \sim \gamma N^{\alpha} \tag{8.5}
\end{equation*}
$$

Recall first that
$\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)=\left[\xi|\xi|^{\alpha}-\xi_{1}\left|\xi_{1}\right|^{\alpha}-\left(\xi-\xi_{1}\right)\left|\xi-\xi_{1}\right|^{\alpha}\right]+\left[\xi \mu^{2}-\xi_{1} \mu_{1}^{2}-\left(\xi-\xi_{1}\right)\left(\mu-\mu_{1}\right)^{2}\right]=I+I I$.

## . Contribution I

By virtue of the mean value theorem we infer that there exists $\theta \in\left[\xi-\xi_{1}, \xi\right]$ such that

$$
\left.|\xi| \xi\right|^{\alpha}-\left.\left(\xi-\xi_{1}\right)\left|\xi-\xi_{1}\right|^{\alpha}|=(\alpha+1)| \xi_{1}| | \theta\right|^{\alpha}
$$

which leads to

$$
\begin{equation*}
\left.|\xi| \xi\right|^{\alpha}-\left(\xi-\xi_{1}\right)\left|\xi-\xi_{1}\right|^{\alpha} \mid \sim \gamma N^{\alpha} \tag{8.6}
\end{equation*}
$$

Moreover, recalling that $\left|\xi_{1}\right| \sim \gamma=o(N)$ we have

$$
\begin{equation*}
\left.\left|\xi_{1}\right| \xi_{1}\right|^{\alpha} \mid \sim \gamma^{\alpha+1}=o(N) . \tag{8.7}
\end{equation*}
$$

Then gathering (8.6) and (8.7) we obtain

$$
\begin{equation*}
I \simeq \gamma N^{\alpha} \tag{8.8}
\end{equation*}
$$

## . Contribution II

Since $\zeta_{1} \in Q_{1}^{+}$and $\zeta-\zeta_{1} \in Q_{2}^{+}$, then $N+\frac{\gamma}{2} \leq \xi \leq N+2 \gamma$ and $\frac{1}{2} \gamma^{\varepsilon} \leq \mu \leq \gamma^{\varepsilon}$ which leads to

$$
\begin{equation*}
\frac{1}{4} \gamma^{2 \varepsilon}\left(N+\frac{\gamma}{2}\right) \leq \xi \mu^{2} \leq \gamma^{2 \varepsilon}(N+2 \gamma) \tag{8.9}
\end{equation*}
$$

On the other hand, since $\zeta-\zeta_{1} \in Q_{2}^{+}$we have

$$
\begin{equation*}
-\frac{1}{4} \gamma^{2 \varepsilon}(N+\gamma) \leq-\left(\xi-\xi_{1}\right)\left(\mu-\mu_{1}\right)^{2} \leq-\gamma^{2 \varepsilon} N \tag{8.10}
\end{equation*}
$$

In the same way, since $\zeta_{1} \in Q_{1}^{+}$we have

$$
\begin{equation*}
\left|\xi_{1} \mu_{1}^{2}\right| \sim \gamma^{1+2 \varepsilon} \tag{8.11}
\end{equation*}
$$

Then gathering (8.9),(8.10) and (8.11) we infer that

$$
\begin{equation*}
I I=O\left(\gamma^{1+2 \varepsilon}\right) . \tag{8.12}
\end{equation*}
$$

Then (8.5) follows from (8.8) together with (8.12).
Choosing now $\gamma=N^{-(\alpha+\delta)}$ for some $\delta>0$, it follows from (8.5) that

$$
\left|\frac{e^{i t \Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)}-1}{\Omega\left(\zeta_{1}, \zeta-\zeta_{1}\right)}\right| \sim|t|
$$

which lead then to

$$
\begin{equation*}
\left\|I_{N}\right\|_{E^{s}}^{2} \gtrsim \gamma^{-2(1+\varepsilon)} N^{-2 \alpha s+2}|t| \gamma^{1+\varepsilon}\left(N^{\alpha}+\gamma^{2 \varepsilon}\right)^{2 s} \gamma^{2(1+\varepsilon)} \tag{8.13}
\end{equation*}
$$

Thus, choosing $\varepsilon(\alpha)$ and $\delta(\alpha)$ small enough, we have

$$
\lim _{N \rightarrow+\infty}\left\|I_{N}\right\|_{E^{2}}^{2} \gtrsim \lim _{N \rightarrow+\infty}|t| N^{2} \gamma^{1+\varepsilon} \gtrsim \lim _{N \rightarrow+\infty}|t| N^{2-\alpha-\varepsilon(\alpha+\delta)-\delta}=+\infty
$$

for all $\alpha \in[1,2[$ and for all $s \in \mathbb{R}$. This ends the proof of (8.2).
