HOMOCLINIC ORBITS WITH MANY LOOPS NEAR A $0^{2i\omega}$ RESONANT FIXED POINT OF HAMILTONIAN SYSTEMS

ABSTRACT. In this paper we study the dynamics near the equilibrium point of a family of Hamiltonian systems in the neighborhood of a $0^{2i\omega}$ resonance. The existence of a family of periodic orbits surrounding the equilibrium is well-known and we show here the existence of homoclinic connections with several loops for every periodic orbit close to the origin, except the origin itself. The same problem was studied before for reversible non Hamiltonian vector fields, and the splitting of the homoclinic orbits lead to exponentially small terms which prevent the existence of homoclinic connections with one loop to exponentially small periodic orbits. The same phenomenon occurs here but we get round this difficulty thanks to geometric arguments specific to Hamiltonian systems and by studying homoclinic orbits with many loops.

1. Introduction. We consider a family of real analytic Hamiltonian systems with two degrees of freedom. We suppose that these systems admit an equilibrium, that we take at the origin, and study the dynamics near this equilibrium.

An equilibrium is called *non degenerate* if the linear part of the vector field is invertible. Real Hamiltonian vector fields with two degrees of freedom admit three types of non degenerate equilibria: the *Elliptic equilibria* when there are two pairs of purely imaginary eigenvalues, the *Saddle-Center equilibria* when there is one pair of purely imaginary eigenvalues and one pair of real eigenvalues, and the *Hyperbolic equilibria* when all eigenvalues have non-zero real part.

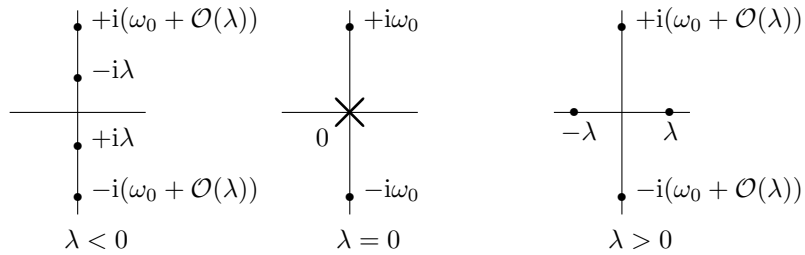


FIGURE 1. Eigenvalues of $DV_{H_\lambda}(0)$ in terms of λ for a $0^{2+i\omega}$ resonant equilibrium.

We study a family H_λ of Hamiltonians with a fixed point at the origin, whose linear part undergoes a transversal bifurcation at $\lambda = 0$ through the stratum of degenerate fixed points, from an elliptic fixed point to a saddle center fixed point. We assume that the degenerate fixed point of H_0 admits a pair of null eigenvalues with a non-trivial Jordan block. This case, which is generic, is called an $0^{2+i\omega}$ resonance (see Figure 1).

Although we are interested in the description of the dynamics associated to the saddle-center fixed point, we must distinguish two cases which are best described by considering the elliptic side of the bifurcation. Either the quadratic part of the Hamiltonian at the elliptic fixed point is definite, or it has index two. We will consider only the definite case. The homoclinic phenomenon described in the present paper does not occur in the other case.

We only study the dynamic for the “half-bifurcation” $\lambda > 0$, *i.e.* we study the dynamic in the neighborhood (in space) of a Saddle-Center fixed point in the neighborhood (in term of λ) of a $0^{2+i\omega}$ resonance.

1.1. Reversible $0^{2+i\omega}$ resonance. The $0^{2+i\omega}$ resonance also appears in the reversible context, where it was extensively studied (Iooss and Kirchgassner [11],

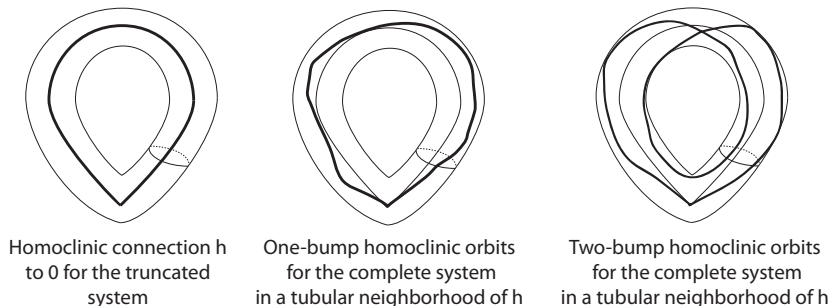
Lombardi [18], Iooss and Lombardi [13]) with motivations coming from waterwaves problems. In this context, for $\lambda > 0$ sufficiently small, the Lyapunov-Devaney theorem ensures that the equilibrium is surrounded by a family of periodic solutions of arbitrary small size. Lombardi [18] proved that there exists two exponentially small functions $\kappa_1(\lambda) < \kappa_2(\lambda)$ (i.e. $\kappa_i(\lambda) = \mathcal{O}(e^{-\frac{c_i}{\lambda}})$) such that on one hand the periodic orbits smaller than $\kappa_1(\lambda)$ do not admit any homoclinic reversible connection *with one bump*, while on the other hand there exist homoclinic connections to each periodic orbit of size greater than $\kappa_2(\lambda)$. In particular, there is no homoclinic connection to the origin.

These results are based on a reduction to normal forms for which all the periodic orbits admit a homoclinic connection. The persistence of these orbits in the whole system is studied through a careful analysis of the holomorphic continuation of solutions in the complex field.

There does not seem to exist an analog in the reversible context of our definiteness hypothesis.

1.2. Homoclinic orbits to a Hamiltonian Saddle-Center equilibrium. In the Hamiltonian case, there are many works about the dynamic associated to Saddle-Center equilibria, not necessarily in the context of the $0^2i\omega$ bifurcation. Near a Hamiltonian Saddle-Center, the Lyapunov-Moser Theorem ensures that there exists a family of periodic orbits surrounding the origin. The existence of homoclinic connections to these periodic orbits have been investigated in many papers, see [1, 2, 8, 9, 3, 19] for example.

In [3], a perturbation of an integrable Hamiltonian system with a saddle-center fixed point admitting a homoclinic connection is studied. It is proved that, in the perturbed system, all sufficiently small periodic orbits around the saddle-center equilibrium admit a heteroclinic connection (but not the fixed point itself). These Homoclinic orbits remain close to the homoclinic orbits of the unperturbed system, but may have several bumps, see Figure 1.2.



The system is reduced to a singular poincaré return map, following Conley [6]. This Poincaré map is singular because it is taken with respect to a homoclinic loop, and not with respect to a genuine periodic orbi. However, the singularity is tamed thanks to local normal forms around the fixed point, due to Moser in [21]. A KAM argument (using the integrability of the unperturbed system) then allows to reduce the study to a bounded invariant domain, and the conclusion is obtained through a soft area preservation argument.

In the present paper, we prove that the same behavior holds in the Hamiltonian $0^2i\omega$ resonance. We use a normal form Theorem to put the system in a form similar

to the one studied in [3] and then proceed as in this paper. Each step is however much more difficult than in [3] because we are dealing with a singular perturbation, where the hyperbolic exponents of the fixed point converge to zero with λ .

1.3. Homoclinic orbits with several loops for the Hamiltonian $0^{2i\omega}$ resonance. In this paper, we consider the Hamiltonian $0^{2i\omega}$ resonance. More precisely, let \mathbb{R}^4 be endowed with a constant symplectic form $\Omega(x, y) = \langle Jx, y \rangle$, where J is a 4×4 matrix such that $J^t = J^{-1} = -J$. Consider a \mathcal{C}^1 one parameter family of analytic Hamiltonians \mathbf{H}_λ , where λ belongs to an interval I of \mathbb{R} . We introduce the following Banach space of analytic functions.

Definition 1.1. Let us denote $\mathcal{A}(\mathcal{B}_{\mathbb{R}^m}(0, \rho), \mathbb{R}^n)$ the set of analytic functions $f : \mathcal{B}_{\mathbb{R}^m}(0, \rho) \rightarrow \mathbb{R}^n$ such that f admits a *bounded* analytic continuation $\tilde{f} : \mathcal{B}_{\mathbb{C}^m}(0, \rho) \rightarrow \mathbb{C}^n$. We define the norm $\|\cdot\|_{\mathcal{A}}$ on $\mathcal{A}(\mathcal{B}_{\mathbb{R}^m}(0, \rho), \mathbb{R}^n)$ by

$$\|f\|_{\mathcal{A}} := \sup_{z \in \mathcal{B}_{\mathbb{C}^m}(0, \rho)} \|\tilde{f}(z)\|_{\mathbb{C}^n}.$$

In the following we suppose that there exists ρ_0 such that

$$\begin{aligned} \mathbf{H} : I &\rightarrow \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho_0), \mathbb{R}) \\ \lambda &\mapsto \mathbf{H}_\lambda \end{aligned}$$

is a \mathcal{C}^1 map for the norm $\|\cdot\|_{\mathcal{A}}$, *i.e.* we assume

$$\mathbf{H} \in \mathcal{C}^1(I, \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho_0), \mathbb{R})). \quad (\text{H0})$$

We study the associated family of Hamiltonian vector fields $\mathbf{V}_{\mathbf{H}_\lambda} := J\nabla \mathbf{H}_\lambda$, which we suppose to admit a fixed point at the origin, *i.e.*

$$\mathbf{V}_{\mathbf{H}_\lambda}(0) = 0 \quad \text{for all } \lambda \in I. \quad (\text{H1})$$

We assume that for $\lambda = 0$, the fixed point admits a

$0^{2i\omega}$ resonance. . This means that there exists a basis (u_0, u_1, u_+, u_-) of \mathbb{C}^4 in which

$$D_x \mathbf{V}_{\mathbf{H}_0}(0) = \begin{pmatrix} 0 & 1 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & i\omega_0 & 0 \\ 0 & 0 & 0 & -i\omega_0 \end{pmatrix}. \quad (\text{H2})$$

We make an additional

assumption on $D_\lambda(D_x \mathbf{V}_{\mathbf{H}_\lambda}(0))$. which characterizes the behavior of the spectrum of $D_x \mathbf{V}_{\mathbf{H}_0}(0)$ for $\lambda = 0$. Denote by $(u_0^*, u_1^*, u_+^*, u_-^*)$ the dual basis of (u_0, u_1, u_+, u_-) . We assume that

$$c_{10} := \langle u_1^*, D_{x,\lambda}^2 \mathbf{V}_{\mathbf{H}_\lambda}(0) \cdot u_0 \rangle \neq 0 \quad (\text{H3})$$

holds. This hypothesis will ensure that the spectrum of $D_x \mathbf{V}_{\mathbf{H}_0}(0)$ is as represented in Figure 1: we do not consider the hyper-degenerate case when the double eigenvalue 0 stays at 0 for $\lambda \neq 0$. Hence, the origin is an elliptic fixed point when $c_{10}\lambda \leq 0$ and a saddle-center when $c_{10}\lambda \geq 0$ (we get Figure 1 when $c_{10} > 0$; if $c_{10} < 0$ it holds for $\lambda' = -\lambda$).

Furthermore, we make the following

assumption on the quadratic part $D_{x,x}^2 \mathbf{V}_{\mathbf{H}_0}(0).[x, x]$ of the vector field at $\lambda = 0$. ,

$$c_{20} := -\frac{1}{3} \langle u_1^*, D_{x,x}^2 \mathbf{V}_{\mathbf{H}_0}(0).[u_0, u_0] \rangle \neq 0. \quad (\text{H4})$$

This hypothesis ensures that, in some sense, the quadratic part of the vector field is not degenerate: c_{20} will appear in the normal form as the coefficient of the only quadratic term. Thank to this nonzero term, we will be able to show the existence of homoclinic orbits for the normal form while the linearized vector field does not admit any such orbit.

In the following we focus our interest on the existence of homoclinic connections, so we only study the half bifurcation

$$c_{10}\lambda \geq 0, \quad (\text{H5})$$

because in that case we work in the neighborhood of a

saddle-center fixed point. .

Finally, we assume that

$$\omega_0 > 0 \quad (\text{H6})$$

holds, which means that for the small $c_{10}\lambda < 0$, the quadratic part of the Hamiltonian is a definite quadratic form.

Under these hypotheses we prove in this paper the following theorem which ensures that there exist homoclinic connections to all the periodic orbits surrounding the origin provided that the homoclinic connections are allowed to admit any number of bumps. This result is stronger than the one obtained in the reversible case since it ensures that when any number of bumps is allowed, there is no lower bound of the size of periodic orbits admitting a homoclinic connection to them.

Theorem 1.2. *Under the hypotheses (H1), ..., (H6), there exist $\lambda_0 \geq 0$, $C_0 \geq 0$ and $\ell_0 \in \mathbb{N}$ such that for all $\lambda \leq \lambda_0$,*

1. *the origin is surrounded by a family of periodic orbits P_λ^a , labelled by their symplectic area $a \in [0, a_0]$ (Lyapunov-Moser);*
2. *for $a \in]0, C_0\lambda^{\ell_0}[$, every periodic orbit P_λ^a admits a homoclinic connection.*

Note that the Theorem 1.2 only deals with homoclinic connections to periodic orbits of arbitrary small size. It says *nothing on homoclinic connections to 0*. Their existence when several bumps are allowed remains fully open. The proof suggests (see Section 2) that the number of bumps of the homoclinic connection increases when the area of the periodic orbits decreases, if this really happens it might prevents the existence of a homoclinic connection to 0. However the theorem does not give any link between the number of bumps and the area.

Two obstacles prevent the result of Theorem 1.2 to apply to the water waves problem. The first obstacle is the Hypothesis (H0): the $0^2i\omega$ resonance appears in the water waves problem after a centermanifold reduction, and this reduction does not preserve the analyticity of the initial equation. The second is Hypothesis (H6): in the water waves problem ω_0 is negative, *i.e.* the quadratic part of the Hamiltonian is not definite. Although analyticity may be considered a technical hypothesis which could possibly be relaxed (although we strongly use it in the present work), the signature hypothesis is essential. There are strong indications that the dynamical behavior that we describe in the case $\omega_0 > 0$ does not occur in the case $\omega_0 < 0$. In particular, we believe that the multibump homoclinics proved to exist in the case $\omega_0 > 0$ do not exist in the waterwave case.

1.4. Normal forms for Hamiltonian systems. The first step in the proof of Theorem 1.2 is a normal form reduction. We give here an abstract normal form theorem of independent interest, extending Elphick & al. [7] (see also [10]), which was suggested to the authors by Gérard Iooss. Let \mathbb{R}^{2m} be endowed with the constant symplectic form $\Omega(x, y) = \langle Jx, y \rangle$ where J is a $2m \times 2m$ real matrix such that $J^t = J^{-1} = -J$. The Hamiltonian vectorfield of the C^1 function H is $J\nabla H$. The flow of this vectorfield is called the Hamiltonian flow of H . The time-one flow is called the Lie transform of H . This flow might not be defined on the whole space, but, if H is C^2 and has a critical point at 0, its Lie transform is defined in a neighborhood of 0, and it is locally a symplectic diffeomorphism.

Given two functions H and G , their Poisson Bracket is defined by

$$\{H, G\} := dH(J\nabla G) = \Omega(\nabla G, \nabla H).$$

Let Λ be a Banach space. We fix $k \geq 2$, and consider a C^1 family of C^k Hamiltonian functions $\mathcal{H}_\lambda(x)$. This means that the maps

$$(\lambda, x) \mapsto \mathcal{H}_\lambda(x), \quad (\lambda, x) \mapsto \partial_x \mathcal{H}_\lambda(x), \dots, \quad (\lambda, x) \mapsto \partial_x^{k-1} \mathcal{H}_\lambda(x)$$

are C^1 in a neighborhood of 0 in $\Lambda \times \mathbb{R}^{2m}$.

Theorem 1.3 (Normal form theorem). *Let \mathcal{H}_λ be a C^1 one parameter family of C^k Hamiltonians such that $D_x \mathcal{H}_\lambda(0) = 0$. We denote by $\mathcal{H}_{2,\lambda}(x) = \frac{1}{2} D_{x,x}^2 \mathcal{H}_\lambda(0) \cdot [x, x]$ the quadratic part of \mathcal{H}_λ and by L_0 the linear part at $\lambda = 0$ of the associated Hamiltonian vector field, i.e. $L_0 x = J \nabla_x \mathcal{H}_{2,0}(x)$.*

Then, for each ℓ such that $k \geq \ell \geq 2$, there exists a C^1 family $\phi_{\ell,\lambda}$ of analytic local diffeomorphisms satisfying

$$D_x \phi_{\ell,0}(0) = Id$$

and such that, in the neighborhood of 0 in \mathbb{R}^{2m} ,

$$\mathcal{H}_\lambda \circ \phi_{\ell,\lambda} = \mathcal{H}_{2,0} + \mathcal{N}_{\ell,\lambda} + \mathcal{R}_{\ell,\lambda}$$

where $\mathcal{N}_{\ell,\lambda}$ is a real polynomial of degree at most ℓ whose coefficients are C^1 functions of λ , and

$$\begin{aligned} \mathcal{N}_{\ell,\lambda}(x) &= \mathcal{O}(\lambda|x|^2 + |x|^3), & \mathcal{R}_{\ell,\lambda}(x) &= o(|x|^\ell), \\ \mathcal{N}_{\ell,\lambda}(e^{tL_0^*} x) &= \mathcal{N}_{\ell,\lambda}(x) \quad \forall t \in \mathbb{R}, & \text{or equivalently } \{\mathcal{H}_{2,0} \circ J, \mathcal{N}_{\ell,\lambda}\} &= 0. \end{aligned} \quad (1)$$

If \mathcal{H}_λ is a C^1 family of analytic Hamiltonians, then $\mathcal{H}_\lambda \circ \phi_{\ell,\lambda}$ and thus $\mathcal{R}_{\ell+1,\lambda}$ are C^1 families of analytic Hamiltonians. The proof is given in Appendix A.

Remark 1.4. In the case of the Birkhoff normal form, the normal form \mathcal{N} belongs to the kernel of $\{\mathcal{H}_{2,0}, \cdot\}$ while here it lies in the kernel of $\{\mathcal{H}_{2,0} \circ J, \cdot\}$. For elliptic fixed points, this is not different since $\mathcal{H}_{2,0} \circ J = \mathcal{H}_{2,0}$. As explained in the poof, it is always possible to find a normal form which commutes with $\mathcal{H}_{2,0} \circ J$, while it is only possible to find a normal form which commutes with $\mathcal{H}_{2,0}$ under additional assumptions, such as semi-simplicity, which are not satisfied in the situation of the present paper.

In the context of Theorem 1.2, the normal forms to all orders are integrable, and admit a saddle-center fixed point with a homoclinic loop. Theorem 1.3 allows to view the whole system as a perturbation of this integrable dynamics, which is a context similar to the one of [3]. The proof of Theorem 1.2 then consists of checking that the constructions of [3] still hold here. The main new difficulty is that we deal

here with a singular perturbation, where the hyperbolic exponents of the saddle-center fixed point converge to zero with λ . After rescaling, this causes the rotation speed in the elliptic directions to blow up as λ goes to zero. This difficulty is the reason for the apparition of exponentially small quantities in *e. g.* [18]. The present work is not as quantitative as [18] and we do not explicitly handle exponentially small quantities, but the singularity of the perturbation makes the implementation of each step of the proof much harder than in [3]. However, although we do not explicitly handle exponentially small quantities, the result obtained in the present paper is “stronger” than the one obtained in [18] since theorem 1.2 ensures that in the hamiltonian context and allowing several bumps for the homoclinic connections, there is no exponentially small minimal size for the periodic orbits admitting an homoclinic orbit to themselves.

In particular, the analysis of the return map involves a second normal form in the neighborhood of the saddle center, due to Moser in [21]. We have to prove (see Appendix C) that this normalization does not blow up when λ goes to 0, which requires a whole rewriting of the proof.

2. Structure of the proof of Theorem 1.2. This section is devoted to the proof of Theorem 1.2. The main technical steps of this proof are stated in propositions whose proofs are postponed in the next sections of the paper.

2.1. Normalization and scaling, dynamics of the normal forms of degree 3 and n .

Normalization and scaling. Proposition 2.1 below gathers the results of normalization and scaling of the Hamiltonian. Point (i) is the change of coordinates given by the normal form Theorem 1.3. Then (iii) is a scaling in space and time : after this scaling, the homoclinic orbits of the truncated normalized system have a size of order 1 (see the next subsections), which allows a perturbative proof in the neighborhood of these homoclinic orbits. We must perform the change of parameter (ii) to have a C^1 smoothness of scaling (iii).

Proposition 2.1. *Under hypotheses (H0), \dots , (H6), for all $n \geq 3$, there exist $\varepsilon_1 > 0$, $\rho_1 > 0$ and*

1. *a C^1 one parameter family of canonical analytic transformations of $\mathcal{B}(0, \rho_1)$,*

$$\mathbf{x} = \phi_{n,\lambda}(\tilde{x}) = \tilde{x} + \mathcal{O}(|\tilde{x}|^2), \quad \phi_{n,\lambda} \in \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho_1), \mathbb{R}^4);$$

2. a change of parameter \mathcal{C}^1 , $\lambda = \theta(\varepsilon^4)$ with its inverse $\varepsilon^4 = c_{10}\lambda + o(\lambda)$ defined for $\varepsilon \in]-\varepsilon_1, \varepsilon_1[$,
3. a scaling in space and time $\tilde{x} = \sigma_\varepsilon(\underline{x})$, $t = \varepsilon^2 \tilde{t}$;

such that in a neighborhood of the origin, for all $\varepsilon \in]-\varepsilon_0, 0[\cup]0, \varepsilon_0[$, the normalized Hamiltonian $\underline{H}_\varepsilon(\underline{x}) := \frac{8c_2(\varepsilon)^2}{\varepsilon^{12}} \mathbf{H}_{\theta(\varepsilon^4)}(\phi_{n, \theta(\varepsilon^4)}(\sigma_\varepsilon(\underline{x})))$ is of the form

$$\underline{H}_\varepsilon(\underline{x}) = \frac{1}{2} \left(\underline{p}_1^2 - \underline{q}_1^2 \right) + 2\sqrt{2}(\underline{q}_1)^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2} \underline{I}_2 + \varepsilon^2 \underline{N}_{n, \varepsilon}(\underline{q}_1, \underline{I}_2) + \varepsilon^{4n-8} \underline{R}_{n, \varepsilon}(\underline{x});$$

where

$$\underline{x} = (\underline{q}_1, \underline{p}_1, \underline{q}_2, \underline{p}_2), \quad \underline{I}_2 = \underline{q}_2^2 + \underline{p}_2^2,$$

and ω and c_2 are \mathcal{C}^1 functions of $\varepsilon \in]-\varepsilon_0, \varepsilon_0[$ such that $\omega(\varepsilon) = \omega_0 + \mathcal{O}(\varepsilon^4)$ et $c_2(\varepsilon) = c_{20} + \mathcal{O}(\varepsilon^4)$ with $c_{20} \neq 0$.

The normal form $\underline{N}_{n, \varepsilon}$ is a real polynomial of degree less than n in $(\underline{q}_1, \underline{q}_2, \underline{p}_2)$ such that

$$\underline{N}_{n, \varepsilon}(\underline{q}_1, \underline{I}_2) = \mathcal{O}\left(|\underline{q}_1| |\underline{I}_2| + \varepsilon^2 (|\underline{q}_1|^2 + |\underline{I}_2|)^2\right),$$

and the coefficients of this polynomial are \mathcal{C}^1 functions in $\varepsilon \in]-\varepsilon_0, \varepsilon_0[$. The remainder $\underline{R}_n :]-\varepsilon_0, \varepsilon_0[\rightarrow \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho_1); \mathbb{R}) : \varepsilon \mapsto \underline{R}_{n, \varepsilon}$ is \mathcal{C}^1 one parameter family of analytic Hamiltonians satisfying $\underline{R}_{n, \varepsilon}(\underline{x}) = \mathcal{O}(|\underline{x}|^{n+1})$.

This proposition is proved in Section 3. From now on, we work with the Hamiltonian $\underline{H}_\varepsilon$.

Phase portrait for the normal form of degree 3. We first study the dynamics of the Hamiltonian $\underline{H}_\varepsilon$ truncated at degree 3

$$\underline{H}_{3, \varepsilon}(\underline{x}) = \frac{1}{2} \left(\underline{p}_1^2 - \underline{q}_1^2 \right) + 2\sqrt{2} \underline{q}_1^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2} \underline{I}_2,$$

where $\underline{I}_2 = \underline{q}_2^2 + \underline{p}_2^2$. The associated differential system reads

$$\begin{cases} \underline{q}_1'(t) &= \underline{p}_1 \\ \underline{p}_1'(t) &= \underline{q}_1 - 6\sqrt{2} \underline{q}_1^2 \\ \underline{q}_2'(t) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} \underline{p}_2 \\ \underline{p}_2'(t) &= -\frac{\omega(\varepsilon)}{2\varepsilon^2} \underline{q}_2. \end{cases}$$

We observe that in this system, the two couples of variables $(\underline{q}_1, \underline{p}_1)$ and $(\underline{q}_2, \underline{p}_2)$ are uncoupled. The solutions of the half system in $(\underline{q}_2, \underline{p}_2)$ are

$$\begin{pmatrix} \underline{q}_2 \\ \underline{p}_2 \end{pmatrix} = \mathbf{R}_{\frac{\omega(\varepsilon)}{2\varepsilon^2} t} \begin{pmatrix} \underline{q}_2(0) \\ \underline{p}_2(0) \end{pmatrix}, \quad \text{where} \quad \mathbf{R}_\theta := \begin{pmatrix} \cos \theta & -\sin \theta \\ \sin \theta & \cos \theta \end{pmatrix}.$$

In particular \underline{I}_2 is constant. Let us denote by P_0^a **the periodic orbits satisfying $\underline{I}_2 = a$ and $(\underline{q}_1, \underline{p}_1) = (0, 0)$** . We get the phase portrait for the half system in $(\underline{q}_1, \underline{p}_1)$ by drawing the energy level sets which read

$$\left\{ (\underline{q}_1, \underline{p}_1), \frac{1}{2} \left(\underline{p}_1^2 - \underline{q}_1^2 \right) + 2\sqrt{2} \underline{q}_1^3 = \alpha \right\} = \left\{ (\underline{q}_1, \underline{p}_1), \underline{p}_1 = \pm \sqrt{\underline{q}_1^2 - 4\sqrt{2} \underline{q}_1^3 + \alpha} \right\}. \quad (2)$$

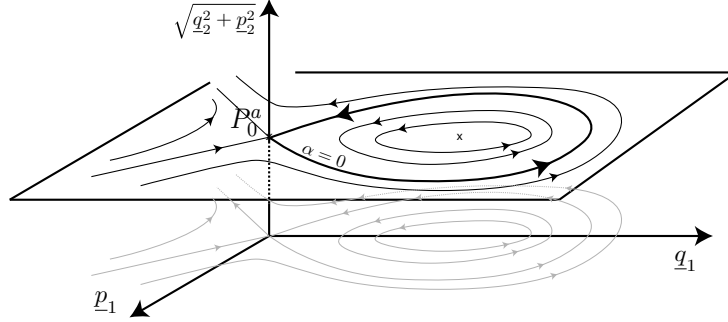


FIGURE 2. Phase portrait for the normal form of degree 3.

We then get the phase portrait of Figure 2, in which there is an **homoclinic orbit to P_0^a** when $\alpha = 0$, whose explicit form is

$$\begin{pmatrix} q_1(t) \\ p_1(t) \end{pmatrix} = \frac{1}{\sqrt{2}\sqrt{2}} \begin{pmatrix} \frac{1}{1 + \cosh(t)} \\ -\frac{\sinh(t)}{(1 + \cosh(t))^2} \end{pmatrix}.$$

For the normal form of degree n , given that $\frac{dI_2}{dt} = 0$, we also get the entire phase portrait, which is a deformation of the phase portrait (see Figure 2) of the normal form of degree 3.

Linear change of coordinates and truncation at infinity. From now on, it will be easier to work in the **new coordinates** (q_1, p_1, q_2, p_2) , obtained by the following canonical linear change of coordinates in which the linearized hamiltonian system at the origin is in Jordan form :

$$\begin{pmatrix} q_1 \\ p_1 \end{pmatrix} = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & 1 \\ -1 & 1 \end{pmatrix} \begin{pmatrix} q_1 \\ p_1 \end{pmatrix} := L \begin{pmatrix} q_1 \\ p_1 \end{pmatrix}, \quad \begin{pmatrix} q_2 \\ p_2 \end{pmatrix} = \begin{pmatrix} q_2 \\ p_2 \end{pmatrix}.$$

In these coordinates the Hamiltonian reads

$$-q_1 p_1 + (q_1 + p_1)^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2} I_2 + \varepsilon^2 N_n(q_1 + p_1, I_2, \varepsilon) + \varepsilon^{4n-8} \mathcal{R}_n(x, \varepsilon), \quad (3)$$

where $I_2 = q_2^2 + p_2^2$, ω is a \mathcal{C}^1 function of $\varepsilon \in]-\varepsilon_0, \varepsilon_0[$ which reads $\omega(\varepsilon) = \omega_0 + \mathcal{O}(\varepsilon^4)$; the normal form N_n is a real polynomial of degree less than n in (q_1, p_1, q_2, p_2) satisfying

$$N_n(q_1 + p_1, I_2, \varepsilon) = \mathcal{O}(|q_1 + p_1| |I_2| + \varepsilon^2(|q_1 + p_1|^2 + |I_2|)^2),$$

and the coefficients of which are \mathcal{C}^1 functions of $\varepsilon \in]-\varepsilon_0, \varepsilon_0[$; the remainder $\mathcal{R}_n :]-\varepsilon_0, \varepsilon_0[\rightarrow \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho_1); \mathbb{R}) : \varepsilon \mapsto \mathcal{R}_n(\cdot, \varepsilon)$ is a \mathcal{C}^1 one parameter family of analytic Hamiltonians such that $\mathcal{R}_n(x, \varepsilon) = \mathcal{O}(|x|^{n+1})$.

We cut this Hamiltonian to get a bounded flow. Let \mathcal{T}_{ρ_0} be a \mathcal{C}^∞ map of \mathbb{R} such that

$$\mathcal{T}_{\rho_0}(r) = \begin{cases} 1 & \text{for } r \in [-\frac{1}{4}\rho_0^2, \frac{1}{4}\rho_0^2] \\ 0 & \text{for } |r| \geq \rho_0^2. \end{cases}$$

We chose ρ_0 such that the homoclinic orbit obtained above for the truncated system is strictly included in $\mathcal{B}(0, \frac{1}{2}\rho_0)$. We finally consider the following Hamiltonian,

$$H(x, \varepsilon) = \mathcal{T}_{\rho_0}(q_1^2)\mathcal{T}_{\rho_0}(p_1^2)\mathcal{T}_{\rho_0}(I_2)\left(-q_1p_1 + (q_1 + p_1)^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2}I_2 + \varepsilon^2 N_n(q_1 + p_1, I_2, \varepsilon) + \varepsilon^{4n-8}\mathcal{R}_n(x, \varepsilon)\right),$$

which, in $\mathcal{B}(0, \frac{1}{2}\rho_0)$ is equal to the Hamiltonian (3) obtained above. This truncation is useful to work with a bounded flow, which cannot get out of $\mathcal{B}(0, \rho_0)$: this will be useful to obtain uniform upper bounds. And then with the aid of these upper bounds we will get that, for ε sufficiently small, the solutions of interest stay in $\mathcal{B}(0, \frac{1}{2}\rho_0)$: these solutions will also be solutions of the initial Hamiltonian (3).

In the following, we always work with the Hamiltonian without making mention of the cutoff function $\mathcal{T}_{\rho_0}(r)$, given that we will always work in $\mathcal{B}(0, \frac{1}{2}\rho_0)$.

New parameters ε, ν, μ . We introduce new parameters for the Hamiltonian, $\underline{\varepsilon} := (\varepsilon, \nu, \mu)$ so that

$$H(x, \underline{\varepsilon}) = -q_1p_1 + (q_1 + p_1)^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2}I_2 + \nu N_n(q_1 + p_1, I_2, \varepsilon) + \mu\nu\varepsilon^{N_0}\mathcal{R}_n(x, \varepsilon). \quad (4)$$

With these new parameters, we have

- for $(\varepsilon, \nu, \mu) = (\varepsilon, 0, 0)$ the Hamiltonian is the normal form of degree 3 studied above in subsection 2.1;
- for $(\varepsilon, \nu, \mu) = (\varepsilon, \varepsilon^2, 0)$ we have the normal form of degree n ;
- for $(\varepsilon, \nu, \mu) = (\varepsilon, \varepsilon^2, \varepsilon^{4n-8-(N_0+2)})$ the complete system.

The distance from the complete system to the normal form of degree 3 and the normal form of degree n corresponds then to the smoothness in the parameters ν (for degree 3) and μ (for degree n), uniformly in ε . We chose N_0 and n later in the proof.

Introducing heuristically our strategy of proof. At every order n , the normal form has homoclinic connections to the origin and to each periodic orbit of the family surrounding the origin. Moreover, if one deflects from the homoclinic trajectory “inward”, one arrives in a region of space filled with trajectories periodic in $(\underline{q}_1, \underline{p}_1)$. In the following, we consider the complete system as a perturbation of the normal form. The heuristic idea is then to show that if the homoclinic connection to a periodic orbit P^a is perturbed, necessarily it deflects “inward”, and then “follows” a trajectory periodic in $(\underline{q}_1, \underline{p}_1)$, maybe making several loops and then finally joins the periodic orbit P^a back. Such a trajectory for the complete system would then be an homoclinic orbit with several loops.

To give a mathematical sense to the idea of “doing several loops”, a natural idea is then to introduce an appropriate Poincaré section intersecting transversally the homoclinic orbits of the normal form and to consider iterations of the first return map to this section. *This is our strategy in the following.*

2.2. Construction of the first return map. *Let us introduce the Poincaré section*

$$\Sigma_1 := \{(q_1, p_1, q_2, p_2) \in \mathbb{R}^4 / q_1 = \delta\},$$

where δ is fixed “small” : we will have several conditions of smallness on δ in the following, but none linked to the size of $\underline{\varepsilon}$.

To construct the first return map to Σ_1 , denoted by $\Psi_{\underline{\varepsilon}}$, we proceed in two main steps, that we summarize here and detail below :

Global map.: We use the existence of an orbit homoclinic to the origin for the normal form of degree 3 and show by perturbation that there exists a return to the section for a and ν small. The perturbative method works only on a part of the homoclinic orbit which is covered in a finite period of time : we perform this strategy for **a trajectory from a second section Σ_2 to the section Σ_1** (see Figure 4).

Local map.: We chose Σ_2 and Σ_1 close to the origin. In order to construct a **local map from Σ_1 to Σ_2** we find a local conjugacy to an integrable system near the fixed point, following Moser.

Construction of a local change of coordinates, \mathcal{F}_ε .

Proposition 2.2. *There exist ε_0 , $\rho'_0 < \frac{1}{2}\rho_0$ and a family of canonical analytic changes of coordinates*

$$\begin{aligned}\mathcal{F}_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2) &:= (\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}, \psi_{2,\varepsilon})(\xi_1, \eta_1, \xi_2, \eta_2) \\ &= (\xi_1, \eta_1, \xi_2, \eta_2) + \mathcal{O}(|(\xi, \eta)|^2),\end{aligned}$$

defined for $|\varepsilon = (\varepsilon, \nu, \mu)| \leq \varepsilon_0$ such that the Hamiltonian H defined by (4) reads in the new coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$

$$\begin{aligned}H(\mathcal{F}_\varepsilon((\xi_1, \eta_1, \xi_2, \eta_2)), \varepsilon) &= K_\varepsilon(\xi_1\eta_1, \xi_2^2 + \eta_2^2) \\ &= -\xi_1\eta_1 + \frac{\omega(\varepsilon)}{2\varepsilon^2}(\xi_2^2 + \eta_2^2) + \mathcal{O}(|(\xi_1\eta_1, \xi_2^2 + \eta_2^2)|^2),\end{aligned}\quad (5)$$

and for all ε , $\mathcal{F}_\varepsilon, \mathcal{F}_\varepsilon^{-1} \in \mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho'_0), \mathbb{R}^4)$.

Moreover, $\mathcal{F}_{(\varepsilon, 0, 0)} := \mathcal{F}_0$ does not depend on ε , and there exists $\mathcal{M}_0 \in \mathbb{R}$ such that

$$|\mathcal{F}_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2) - \mathcal{F}_0(\xi_1, \eta_1, \xi_2, \eta_2)| \leq \nu \mathcal{M}_0 \quad (6)$$

for $|\varepsilon| \leq \varepsilon_0$. All the \mathcal{O} correspond to upper bounds independent of ε .

The proof of this proposition and a more detailed statement are given in Appendix C (Proposition C.1), using some preliminaries from Appendix B.

Remark 2.3. This proposition is a fundamental step of the proof. Unfortunately, it requires very long and technical computations to obtain the estimate (6). The main interest (and main difficulty in the proof) of this proposition is to deal with the singularity in ε of the initial Hamiltonian H (see the explicit form (4)) and to verify that despite of this singularity the estimate (6) is uniform in term of ε small. See also the more detailed version (Proposition C.1) of this proposition in Appendix C and the comments therein.

The form of the Hamiltonian obtained in the new coordinates allows to get the entire phase portrait. Indeed, the flow of the associated hamiltonian system satisfies

$$\frac{d(\xi_1\eta_1)}{dt} = 0, \quad \frac{d(\xi_2^2 + \eta_2^2)}{dt} = 0.$$

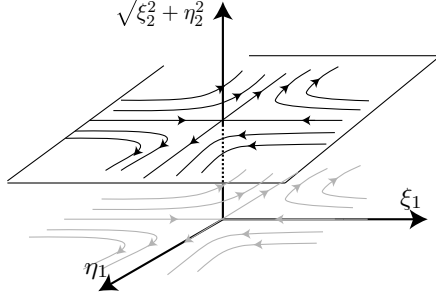
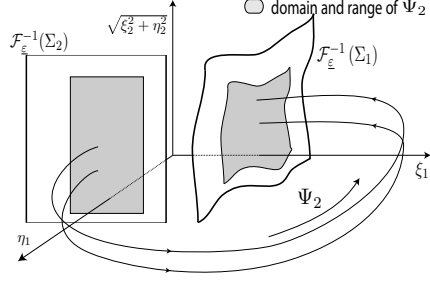
Moreover,

$$\frac{d\xi_1}{dt} = (\partial_1 K_\varepsilon)(\xi_1\eta_1, \xi_2^2 + \eta_2^2) \cdot \xi_1$$

holds and, given that the \mathcal{O} of equation (5) is independent of ε , we get

$$\left| K_\varepsilon(\xi_1\eta_1, \xi_2^2 + \eta_2^2) - \left(-\xi_1\eta_1 + \frac{\omega(\varepsilon)}{2\varepsilon^2}(\xi_2^2 + \eta_2^2) \right) \right| \leq \mathcal{M}_0 |(\xi_1\eta_1, \xi_2^2 + \eta_2^2)|^2. \quad (7)$$

Then, up to a reduction of the radius ρ'_0 if necessary (independent of ε), $\frac{d\xi_1}{dt} < 0$ if $\xi_1 > 0$ and $\frac{d\xi_1}{dt} > 0$ if $\xi_1 < 0$. So, the dynamics in the local coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$ is as draw in the phase portrait of Figure 3.

Global map, from a second section Σ_2 to Σ_1 . We define Σ_2 by defining its range in coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$,

$$\Sigma_2 := \mathcal{F}_{\underline{\varepsilon}}(\{(\xi_1, \eta_1, \xi_2, \eta_2) \in \mathcal{B}_{\mathbb{R}^4}(0, \rho'_0)/\eta_1 = \delta\}).$$

By a perturbative method in the neighborhood of the homoclinic orbit to the origin of the normal form of degree 3, we show the existence of a Poincaré map Ψ_2 following the flow from Σ_2 to Σ_1 . Precisely, denoting by $\phi(t, x, \underline{\varepsilon})$ the flow of the hamiltonian system associated to $H(\cdot, \underline{\varepsilon})$, we show the following proposition, which gives moreover the upper bound (8) useful later :

Proposition 2.4. *For δ sufficiently small, there exist $T^-(\delta) < T^+(\delta)$ such that for all (q_1, p_1, q_2, p_2) in*

$$\Sigma_2 \cap \mathcal{F}_{\underline{\varepsilon}}\left(\left\{(\xi_1, \eta_1, \xi_2, \eta_2)/0 \leq \xi_1 \leq \frac{1}{16}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \frac{1}{2}\delta\right\}\right),$$

there exists an unique $T_L((q_1, p_1, q_2, p_2), \underline{\varepsilon}) \in [T^-(\delta), T^+(\delta)]$ satisfying

$$\phi(T_L((q_1, p_1, q_2, p_2), \underline{\varepsilon}), (q_1, p_1, q_2, p_2), \underline{\varepsilon}) \in \Sigma_1 \cap \mathcal{B}(0, \delta).$$

Moreover, denoting by

$$\Psi_2((q_1, p_1, q_2, p_2), \underline{\varepsilon}) := \phi(T_L((q_1, p_1, q_2, p_2), \underline{\varepsilon}), (q_1, p_1, q_2, p_2), \underline{\varepsilon})$$

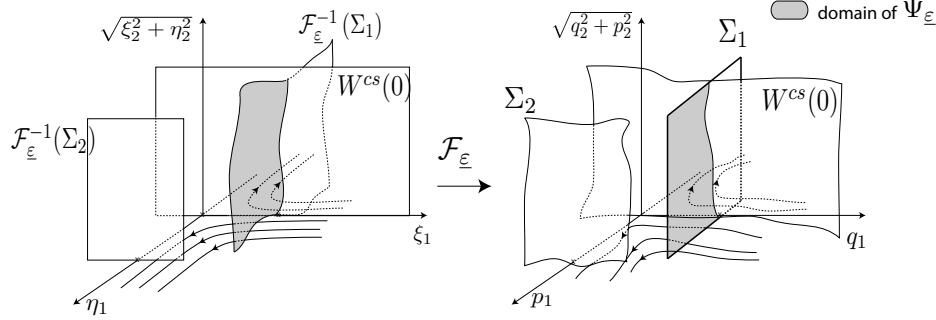
there exists M_2 such that

$$\left| \Psi_{2,q_2}((q_1, p_1, q_2, p_2), \underline{\varepsilon})^2 + \Psi_{2,p_2}((q_1, p_1, q_2, p_2), \underline{\varepsilon})^2 - (q_2^2 + p_2^2) \right| \leq \mu\nu\varepsilon^{N_0} M_2 T^+(\delta). \quad (8)$$

The proof of this proposition is given in section 4.3.

Existence of the first return map to Σ_1 . Observing the phase portrait in the neighborhood of the origin in the local coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$ (Figure 3), we see that the Poincaré map from Σ_1 to Σ_2 exists if and only if η_1 is positive. Given that in these coordinates, the center-stable manifold to the origin is the hyperplane $\{\eta_1 = 0\}$, we get that in coordinates (q_1, p_1, q_2, p_2) , the domain of existence corresponds to being “on the right side” of the center-stable manifold of the origin (see Figure 5).

Precisely, we show the following

FIGURE 5. Position of the domain of the Poincaré map and $W^{cs}(0)$.

Proposition 2.5. *It is possible to define a first return map*

$$\Psi : \Sigma_1 \cap \mathcal{F}_{\underline{\varepsilon}} \left(\left\{ (\xi_1, \eta_1, \xi_2, \eta_2) / 0 < \eta_1 \leq \frac{1}{24}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \delta \right\} \times]-\varepsilon_0, \varepsilon_0[\right] \rightarrow \Sigma_1.$$

A more detailed version of this proposition and its proof are given in part 4.3 (Proposition 4.2).

2.3. Construction of an invariant curve for the first return map using a KAM theorem. *From now on, we will not need to distinguish ν from ε , we work now with*

$$\underline{\varepsilon} = (\varepsilon, \nu, \mu) = (\varepsilon, \varepsilon^2, \mu).$$

In this section, we fix one periodic orbit P and prove that the restriction of Ψ to the energy level set of P can be expressed as a diffeomorphism of an annulus of \mathbb{R}^2 . Then we construct an invariant curve for this diffeomorphism with the aid of a KAM theorem. This curve will be useful later in part 2.4 to bound the iterations of the map Ψ , and then to conclude that $W^u(P)$ and $W^s(P)$ intersect each other.

The maps Ψ^a and their expression as diffeomorphisms of an annulus of \mathbb{R}^2 . Thank to the canonical change of coordinates $\mathcal{F}_{\underline{\varepsilon}}$ of Proposition 2.2, we have a precise labelling of the periodic orbits in the neighborhood of 0. Indeed, in coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$ we have the family of periodic orbits

$$\{(0, 0, \xi_2, \eta_2) / \xi_2^2 + \eta_2^2 = a\},$$

labelled by their symplectic area a . Then, we denote

$$P_{\underline{\varepsilon}}^a := \mathcal{F}_{\underline{\varepsilon}} \left(\{(0, 0, \xi_2, \eta_2) / \xi_2^2 + \eta_2^2 = a\} \right). \quad (9)$$

In particular, given that $\mathcal{F}_{\underline{\varepsilon}}$ is canonical, the symplectic area of $P_{\underline{\varepsilon}}^a$ is also a .

Let us denote by Ψ^a the restriction of Ψ to the energy level set of P^a , i.e. to

$$\Sigma_1 \cap \{H = H(P^a)\} = \{(q_1, p_1, q_2, p_2) / q_1 = \delta, H((q_1, p_1, q_2, p_2), \underline{\varepsilon}) = H(P_{\underline{\varepsilon}}^a, \underline{\varepsilon})\}$$

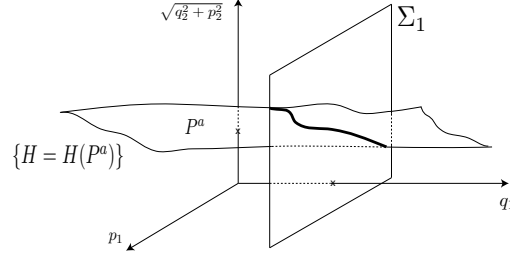


FIGURE 6. Intersection of the energy level set $\{H = H(P^a)\}$ with the section Σ_1 .

(see Figure 6). Proposition 2.6 below states that Ψ^a can be considered as a diffeomorphism of a disc of \mathbb{R}^2 .

Proposition 2.6. *Let us define the curve*

$$\mathcal{C}_s^a := \Sigma_1 \cap W^{cs}(0) \cap \{H = H(P^a)\}.$$

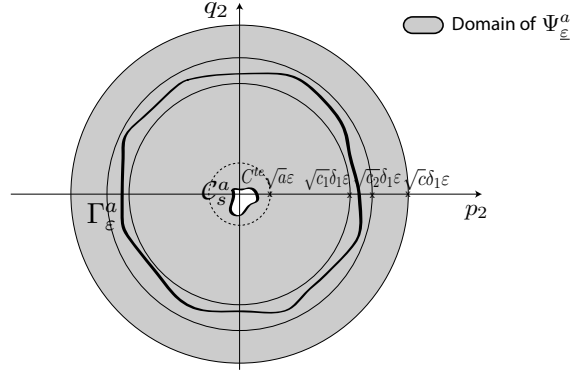


FIGURE 7. Invariant curve Γ_ε^a and size of the annulus used in the proof.

There exists c, c_0 such that, for $a \leq c_0 \delta^2 \varepsilon^2$, the restriction Ψ^a of Ψ to the energy level set $\{H = H(P^a)\}$ reads as a diffeomorphism

$$\Psi_\varepsilon^a : \{(q_2, p_2) / q_2^2 + p_2^2 \leq c \delta^2 \varepsilon^2, (q_2, p_2) \text{ outside of } \mathcal{C}_s^a\} \rightarrow \{(q_2, p_2), q_2^2 + p_2^2 \leq \omega_0 \delta^2 \varepsilon^2\}.$$

The proof of this Proposition is in Part 5.5.

Existence of an invariant curve. We prove now the existence of invariant curves for each diffeomorphism Ψ_ε^a . This will be possible by an appropriate choice of some parameters : in this part, we chose and fix the order n of the normal form and the power N_0 of ε in the Hamiltonian expressed with the three parameters $\underline{\varepsilon} = (\varepsilon, \nu, \mu)$ (see (4) above), and also a value μ as a power of ε . Here is the part of the proof where the normal form is the most fully used. Precisely, we show in this subsection the following

Proposition 2.7. *There exist ℓ_0 and ε_0 , c_1, c_2 such that for $\varepsilon \leq \varepsilon_0$, $a \leq \varepsilon^{3\ell_0+1}$, $\mu \leq \varepsilon^{4\ell_0+1}$ and $n \geq 2(\ell_0+2)$, $N_0 \geq 4\ell_0+5$, the map $\Psi_\varepsilon^a := \Psi_{(\varepsilon, \varepsilon^2, \varepsilon^{4\ell_0+1})}^a$ has an invariant curve Γ_ε^a in the annulus of \mathbb{R}^2 $\{(q_2, p_2) / I_2 \in [c_1 \delta^2 \varepsilon^2, c_2 \delta^2 \varepsilon^2]\}$.*

Proof. The rest of this subsection is devoted to the proof of this proposition. For that purpose, we use the following KAM theorem stated by Moser [20] :

Theorem 2.8 (KAM theorem). *Let*

$$\begin{aligned} \Phi : \mathbb{R}/2\pi\mathbb{Z} \times [a, b] &\rightarrow \mathbb{R}/2\pi\mathbb{Z} \times \mathbb{R} \\ (q, \rho) &\mapsto (q + \alpha(\rho) + F(q, \rho), \rho + G(q, \rho)). \end{aligned}$$

We assume that the map Φ is exact and that there exists $m_0 > 0$ such that for all ρ ,

$$\frac{1}{m_0} \leq \frac{d\alpha}{d\rho}(\rho) \leq m_0. \quad (10)$$

Then there exist $\ell_0 \in \mathbb{N}$ and $\delta_0(m_0) > 0$ such that if

$$|F|_{C^0} + |G|_{C^0} \leq \delta_0(m_0) \quad \text{and} \quad |\alpha|_{C^{\ell_0}} + |F|_{C^{\ell_0}} + |G|_{C^{\ell_0}} \leq m_0$$

are verified, then Φ admits an invariant curve of the form

$$\{(q, \rho) = (q' + f(q'), \rho_0 + g(q')), q' \in \mathbb{R}/2\pi\mathbb{Z}\}, \quad (11)$$

where f, g are \mathcal{C}^1 functions.

The following Proposition 2.9 will involve (proof below) that, with an appropriate choice of the parameters, the maps $\hat{\Psi}_{\underline{\varepsilon}}^a$ (which are the maps $\Psi_{\underline{\varepsilon}}^a$ after a change of coordinates, given in subsection 6.3) satisfy the hypothesis of the KAM theorem [20] applying it with

$$\begin{aligned} \hat{\Psi}_{(\varepsilon, \varepsilon^2, 0)}^a &: (q, \rho) \mapsto (q + \alpha_{\varepsilon}^a(\rho), \rho), \\ \hat{\Psi}_{(\varepsilon, \varepsilon^2, \mu)}^a &: (q, \rho) \mapsto (q + \alpha_{\varepsilon}^a(\rho) + F_{\underline{\varepsilon}}^a(q, \rho), \rho + G_{\underline{\varepsilon}}^a(q, \rho)). \end{aligned}$$

Proposition 2.9. *(see Figure 7) There exist c_0, c_1, c_2 and $m_0 > 0$ such that for ε sufficiently small, for all $a \in [0, c_0\delta^2\varepsilon^2]$ and all $k \leq E(\frac{N_0-1}{4}) - 1$, in the annulus*

$$\{(q_2, p_2)/I_2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]\},$$

the $\hat{\Psi}_{\underline{\varepsilon}}^a$ satisfy

1. *the map $\hat{\Psi}_{(\varepsilon, \varepsilon^2, \mu)}^a$ is exact;*
2. $-m_0 \leq \frac{\partial \alpha_{\varepsilon}^a}{\partial \rho} \leq -\frac{1}{m_0};$
3. $|\alpha_{\varepsilon}^a|_{C^k} \leq m_k;$
4. $\left|F_{\underline{\varepsilon}}^a\right|_{C^k} + \left|G_{\underline{\varepsilon}}^a\right|_{C^k} \leq m_0 \cdot \left(\frac{a^2}{\varepsilon^{6k}} + \frac{\mu}{\varepsilon^{4k}}\right).$

The proof of this proposition is given in section 6.

Recall that after the normalization until degree n , in Proposition 2.1, we had ε^{4n-8} in the expression of H , that we rewrote $\varepsilon^{4n-8} = \mu\nu\varepsilon^{N_0}$ when we introduced the parameters μ and ν . We recall also that we have already chosen the value of ν , $\nu = \varepsilon^2$, at the beginning of subsection 2.3. We now chose the values of n and N_0 : we apply the normalization Proposition 2.1 with $n := 2\ell_0 + 3$ and chose $N_0 := 4\ell_0 + 1$. Then necessarily $\mu = \varepsilon^{4\ell_0+1}$, and for $a \leq \varepsilon^{3\ell_0}$ Proposition 2.9 implies that the hypotheses of the KAM theorem are satisfied in the annulus $I_2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$ for all the maps $\hat{\Psi}_{\underline{\varepsilon}}^a$. Then there exists a curve $\Gamma_{\underline{\varepsilon}}^a$ of the form (11) in the annulus $I_2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$, invariant by the map $\Psi_{\underline{\varepsilon}}^a = \Psi_{(\varepsilon, \varepsilon^2, \varepsilon^{4\ell_0+1})}^a$. \square

2.4. Proof of Theorem 1.2. This subsection is devoted to the proof of Theorem 1.2, using the notations and results contained in the previous parts. Let us fix a and ε , and consider the unstable manifold $W^u(P^a)$ of the periodic orbit P^a .

Our first aim is to verify that $W^u(P^a)$ does intersect Σ_1 , and moreover that this intersection is in the neighborhood of $(\delta, 0, 0, 0)$ in which $\Sigma_1 \cap \{H = H(P^a)\}$ is a graph and also inside the invariant curve Γ_ε^a . More precisely we prove below that for a and ε sufficiently small, $W^u(P^a)$ hits the set

$$\Sigma_1 \cap \mathcal{B}(0, \delta) \cap \{(\xi_1, \eta_1, \xi_2, \eta_2)/\xi_2^2 + \eta_2^2 \leq \frac{1}{4}c_1\delta^2\varepsilon^2\}; \quad (12)$$

To prove this, we use that in the coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$, the unstable manifold of P^a is the tube

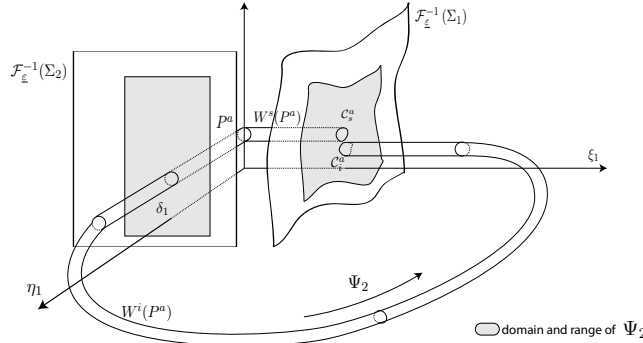


FIGURE 8. $W^u(P^a)$ and Σ_1 intersect.

$$\{(\xi_1, \eta_1, \xi_2, \eta_2) \in \mathbb{R}^4 / \xi_1 = 0, \xi_2^2 + \eta_2^2 = a\},$$

whose intersection with the hyperplane $\{(\xi_1, \eta_1, \xi_2, \eta_2)/\eta_1 = \delta\} = \mathcal{F}_\varepsilon^{-1}(\Sigma_2)$ is the circle $\{(0, \delta, \xi_2, \eta_2)/\xi_2^2 + \eta_2^2 = a\}$. Then for $a \leq \delta^2$ we can use the map Ψ_2 of Proposition 2.4, which maps Σ_2 onto Σ_1 : this way, we get that $W^u(P^a)$ intersects $\Sigma_1 \cap \mathcal{B}(0, \delta)$ (see Figure 8). Using moreover the estimate (8) of Proposition 2.4, we get that for $a < c_1\delta^2\varepsilon^2$ and for ε sufficiently small, $W^u(P^a)$ intersects Σ_1 in the set (12).

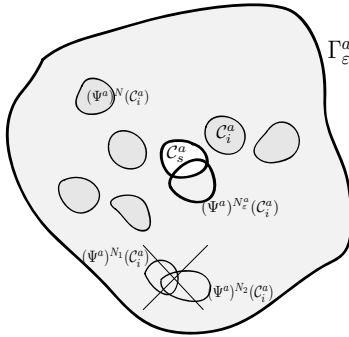


FIGURE 9. Iterations of the map Ψ^a on the curve C_u^a .

Denoting by \mathcal{C}_u^a the curve representing in (q_2, p_2) -coordinates the intersection $W^u(P^a) \cap \Sigma_1$, we then have two possible alternatives :

- first option : \mathcal{C}_u^a and the curve \mathcal{C}_s^a of the stable manifold intersect **in this case, the proof of the existence of an homoclinic connection to P^a is completed**,
- second option : \mathcal{C}_u^a and \mathcal{C}_s^a do not intersect.

Let us consider the second option. We know that both curves have the same symplectic area a , so \mathcal{C}_u^a cannot be entirely contained inside \mathcal{C}_s^a . Necessarily, \mathcal{C}_u^a is then outside of \mathcal{C}_s^a .

And we proved that Ψ_ε^a is defined on the set (12) outside of the curve \mathcal{C}_s^a , so we can consider $\Psi_\varepsilon^a(\mathcal{C}_i^a)$. Moreover, we know that for a and ε sufficiently small, the interior of the curve Γ_ε^a of Proposition 2.7 above maps onto the interior of Γ_ε^a with the map Ψ_ε^a . Then $\Psi_\varepsilon^a(\mathcal{C}_i^a)$ is also a curve whose symplectic area is a and contained inside Γ_ε^a . We again have two possible options:

- first option : $\Psi_\varepsilon^a(\mathcal{C}_i^a)$ and \mathcal{C}_s^a intersect, **in this case, the proof of the existence of an homoclinic connection with two loops to P^a is completed**,
- second option : $\Psi_\varepsilon^a(\mathcal{C}_i^a)$ is outside \mathcal{C}_s^a , and then belongs to the domain of Ψ_ε^a .

Then we iterate this process. Since \mathcal{C}_u^a is defined as the first intersection of $W^u(P^a)$ and Σ_1 , for all N $(\Psi_\varepsilon^a)^N(\mathcal{C}_i^a)$ and \mathcal{C}_u^a can not intersect. As Ψ_ε^a is a diffeomorphism (and then is invertible), then for all N_1, N_2 , $(\Psi_\varepsilon^a)^{N_1}(\mathcal{C}_i^a)$ and $(\Psi_\varepsilon^a)^{N_2}(\mathcal{C}_i^a)$ do not intersect. Iterating this process N_0 times, the set of the $(\Psi_\varepsilon^a)^N(\mathcal{C}_i^a)$ for $N \leq N_0$ cover a surface whose area is $N_0 \cdot a$. And this surface is inside the curve Γ_ε^a , whose area is finite. Then, the process must stop for one N_ε^a , *i.e.* necessarily there exists one $N = N_\varepsilon^a \in \mathbb{N}$ for which $(\Psi_\varepsilon^a)^N(\mathcal{C}_i^a)$ and \mathcal{C}_s^a intersect (see Figure 9). And this means that **there exists an homoclinic connection with N_ε^a loops to the periodic orbit P_ε^a** . \square

Remark 2.10 ((about the importance of Hypothesis (H6))). The Hypothesis (H6) is explicitly used below in the proof of Lemma 5.3, and we use this Lemma to prove the existence of Ψ_ε^a

outside. of the curve \mathcal{C}_s^a in Proposition 2.6 above (if hypothesis (H6) was not verified, the domain would be inside the curve). And the latter is crucial to allow the iterations of the first return map when the curves do not intersect (see Section 2.4).

In the heuristic picture of the strategy outlined above in Section 2.1, the Hypothesis (H6) is what allows to state that if the homoclinic trajectory deflects, it deviates

inwards. (“interior” in the (q_1, p_1) coordinates).

3. Normal form and scaling: Proof of Proposition 2.1. This section is devoted to the proof of Proposition 2.1. We proceed in three main steps, constructing the three maps of (i), (ii) and (iii) in the proposition.

Step 1. Consequences of the Normal Form Theorem 1.3. Under Hypotheses (H1), \dots , (H6), it is possible to find appropriate coordinates in \mathbb{R}^4 such that \mathbf{x} , \mathbf{H}_λ and Ω read

$$\mathbf{x} = (\mathbf{q}_1, \mathbf{p}_1, \mathbf{q}_2, \mathbf{p}_2), \quad \mathbf{H}_\lambda(\mathbf{x}) := \frac{1}{2}\mathbf{p}_1^2 + \frac{1}{2}\omega_0(\mathbf{q}_2^2 + \mathbf{p}_2^2) + \mathcal{O}(\lambda|\mathbf{x}|^2 + |\mathbf{x}|^3),$$

and $\Omega(\mathbf{x}, \mathbf{y}) = \langle J\mathbf{x}, \mathbf{y} \rangle$, where

$$J = \begin{pmatrix} 0 & 1 & 0 & 0 \\ -1 & 0 & 0 & 0 \\ 0 & 0 & 0 & 1 \\ 0 & 0 & -1 & 0 \end{pmatrix}.$$

We apply Theorem 1.3 to the family of Hamiltonians $\mathbf{H}_\lambda(\mathbf{x})$ and get the existence of a canonical transformation $\mathbf{x} = \phi_{n,\lambda}(\tilde{x})$ such that

$$\tilde{H}_\lambda(\tilde{x}) = \mathbf{H}_\lambda(\phi_{n,\lambda}(\tilde{x})) = \frac{1}{2}\tilde{p}_1^2 + \frac{1}{2}\omega_0(\tilde{q}_2^2 + \tilde{p}_2^2) + \tilde{N}_{n,\lambda}(\tilde{x}) + \tilde{R}_{n,\lambda}(\tilde{x}),$$

where the rest $\tilde{R}_{n,\lambda}(\tilde{x})$ is a \mathcal{C}^1 -one parameter family of analytic Hamiltonians satisfying $\tilde{R}_{n,\lambda}(\tilde{x}) = \mathcal{O}(|\tilde{x}|^{n+1})$ and where $\tilde{N}_{n,\lambda}$ is a real polynomial of degree $\leq n$ satisfying $\tilde{N}_{n,\lambda}(\tilde{x}) = \mathcal{O}(\lambda|\tilde{x}|^2 + |\tilde{x}|^3)$ and

$$\tilde{N}_{n,\lambda}(\tilde{q}_1, \tilde{p}_1 + t\tilde{q}_1, \mathbf{R}_{\omega_0 t}(\tilde{q}_2, \tilde{p}_2)) = \tilde{N}_{n,\lambda}(\tilde{q}_1, \tilde{p}_1, \tilde{q}_2, \tilde{p}_2) \quad \text{for all } t \in \mathbb{R}, \quad (13)$$

with

$$\mathbf{R}_{\omega_0 t} = \begin{pmatrix} \cos \omega_0 t & -\sin \omega_0 t \\ \sin \omega_0 t & \cos \omega_0 t \end{pmatrix}.$$

Setting $t = \frac{2\pi}{\omega_0}\ell$, $\ell \in \mathbb{Z}$ in (13) and pushing ℓ to ∞ , we get that necessarily $\tilde{N}_{n,\lambda}$ does not depend on \tilde{p}_1 , i.e.

$$\tilde{N}_{n,\lambda}(\tilde{q}_1, \tilde{p}_1, \tilde{q}_2, \tilde{p}_2) = \tilde{N}_{n,\lambda}^o(\tilde{q}_1, \tilde{q}_2, \tilde{p}_2).$$

Then identifying \mathbb{R}^2 and \mathbb{C} via $(\tilde{q}_2, \tilde{p}_2) \mapsto (z_2 = \tilde{q}_2 + i\tilde{p}_2, \bar{z}_2 = \tilde{q}_2 - i\tilde{p}_2)$ and defining $\tilde{M}_{n,\lambda}^o(\tilde{q}_1, z_2, \bar{z}_2) = \tilde{N}_{n,\lambda}^o(\tilde{q}_1, \tilde{q}_2, \tilde{p}_2)$, identity (13) reads

$$\tilde{M}_{n,\lambda}^o(\tilde{q}_1, e^{i\omega_0 t} z_2, e^{-i\omega_0 t} \bar{z}_2) = \tilde{M}_{n,\lambda}^o(\tilde{q}_1, z_2, \bar{z}_2) \quad \text{pour tout } t \in \mathbb{R}.$$

Then, setting $t = -\frac{\arg z_2}{\omega_0}$ and $t = -\frac{\arg z_2}{\omega_0} + \pi$, we obtain

$$\tilde{M}_{n,\lambda}^o(\tilde{q}_1, z_2, \bar{z}_2) = \tilde{M}_{n,\lambda}^o(\tilde{q}_1, |z_2|, |z_2|) = \tilde{M}_{n,\lambda}^o(\tilde{q}_1, -|z_2|, -|z_2|),$$

which ensures that $\tilde{M}_{n,\lambda}^o(\tilde{q}_1, z_2, \bar{z}_2) = \tilde{H}_{n,\lambda}(\tilde{q}_1, |z_2|^2)$ where $(\tilde{q}_1, I_2) \mapsto \tilde{H}_{n,\lambda}(\tilde{q}_1, I_2)$ is a real polynomial. Hence

$$\tilde{N}_{n,\lambda}(\tilde{q}_1, \tilde{p}_1, \tilde{q}_2, \tilde{p}_2) = \tilde{N}_{n,\lambda}^o(\tilde{q}_1, \tilde{q}_2, \tilde{p}_2) = \tilde{H}_{n,\lambda}(\tilde{q}_1, \tilde{q}_2^2 + \tilde{p}_2^2).$$

Hence we have proved the existence of a \mathcal{C}^1 one parameter family of canonical analytic transformations $\mathbf{x} = \phi_{n,\lambda}(\tilde{x})$ such that close to the origin $\tilde{H}_\lambda(\tilde{x}) = \mathbf{H}_\lambda(\phi_{n,\lambda}(\tilde{x}))$ reads

$$\tilde{H}_\lambda(\tilde{x}) = \frac{1}{2}\tilde{p}_1^2 + \frac{1}{2}\omega_0(\tilde{p}_2^2 + \tilde{q}_2^2) + \tilde{H}_{n,\lambda}(\tilde{q}_1, \tilde{p}_2^2 + \tilde{q}_2^2) + \tilde{R}_{n,\lambda}(\tilde{x}),$$

where the rest $\tilde{R}_{n,\lambda}(\tilde{x})$ is a \mathcal{C}^1 one parameter family of analytic Hamiltonians satisfying $\tilde{R}_{n,\lambda}(\tilde{x}) = \mathcal{O}(|\tilde{x}|^{n+1})$ and where $\tilde{H}_{n,\lambda}$ is a real polynomial with respect to $(\tilde{q}_1, \tilde{p}_2^2 + \tilde{q}_2^2)$ of degree less than n with respect to $(\tilde{q}_1, \tilde{p}_2, \tilde{q}_2)$, whose coefficients are \mathcal{C}^1 functions of λ . Moreover, $\tilde{H}_{n,\lambda}$ satisfies

$$\tilde{H}_{n,\lambda}(\tilde{q}_1, \tilde{p}_2^2 + \tilde{q}_2^2) = \mathcal{O}(\lambda(\tilde{q}_1^2 + \tilde{p}_2^2 + \tilde{q}_2^2) + (|\tilde{q}_1| + |\tilde{q}_2| + |\tilde{p}_2|)^3).$$

Step 2. Change of parameter λ . Expanding $\tilde{H}_{n,\lambda}$ we get that $\tilde{H}_\lambda(\tilde{x})$ reads

$$\begin{aligned}\tilde{H}_\lambda(\tilde{x}) = & \frac{1}{2}\tilde{p}_1^2 + \frac{1}{2}\tilde{\omega}(\lambda)(\tilde{q}_2^2 + \tilde{p}_2^2) - \frac{1}{2}\tilde{c}_1(\lambda)\tilde{q}_1^2 + \tilde{c}_2(\lambda)\tilde{q}_1^3 + \tilde{c}_3(\lambda)\tilde{q}_1(\tilde{q}_2^2 + \tilde{p}_2^2) \\ & + \tilde{Q}_{n,\lambda}(\tilde{q}_1, \tilde{p}_2^2 + \tilde{q}_2^2) + \tilde{R}_{n,\lambda}(\tilde{x}),\end{aligned}$$

where

$$\tilde{Q}_{n,\lambda}(\tilde{q}_1, \tilde{p}_2^2 + \tilde{q}_2^2) = \mathcal{O}\left((|\tilde{q}_1| + |\tilde{q}_2| + |\tilde{p}_2|)^4\right),$$

and where $\tilde{c}_1, \tilde{c}_2, \tilde{c}_3$ and $\tilde{\omega}$ are \mathcal{C}^1 functions of λ satisfying $\tilde{\omega}(0) = \omega_0$, $\tilde{c}_1(\lambda) = c_{10}\lambda + o(\lambda)$, $\tilde{c}_2(0) = c_{20}$. Moreover,

because of hypotheses (H2), (H3) et (H4). and ω_0 , c_{10} and c_{20} are different from 0.

Finally, since we only consider in this paper the “half bifurcation” corresponding to $c_{10}\lambda > 0$ (hypotheses (H3) and (H5)), the Implicit Function Theorem ensures that the identity

$$\tilde{\varepsilon}^2 = \tilde{c}_1(\lambda) = c_{10}\lambda + o(\lambda)$$

can be inverted in a neighborhood of the origin, *i.e.* $\lambda = \tilde{\theta}(\tilde{\varepsilon}^2)$ where $\tilde{\theta}$ is a function of class \mathcal{C}^1 .

Step 3. Scaling. We perform a scaling in space and time suggested by the normal form of order 3. Indeed, for any n , the normal form part of the Hamiltonian admits an homoclinic connection to 0 which depends on $\tilde{\varepsilon}$. Moreover, for $n = 3$ this homoclinic connection $\tilde{h}_{\tilde{\varepsilon}}$ can be computed explicitly and has the form

$$\tilde{h}_{\tilde{\varepsilon}}(\tilde{t}) = (\tilde{\varepsilon}^2 q_1^h(\tilde{\varepsilon} \tilde{t}), \tilde{\varepsilon}^3 p_1^h(\tilde{\varepsilon} \tilde{t}), 0, 0).$$

To study the dynamics close to this homoclinic connection, it is more convenient to rescale the system so that the rescaled normal form of order 3 of the rescaled Hamiltonian admits an homoclinic connection which does not depend on $\tilde{\varepsilon}$. So we perform the following scaling in space and time

$$\begin{aligned}\tilde{q}_1 &= \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^2 \underline{q}_1, & \tilde{q}_2 &= \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^{\frac{5}{2}} \underline{q}_2, & t &= \tilde{\varepsilon} \tilde{t}, \\ \tilde{p}_1 &= \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^3 \underline{p}_1, & \tilde{p}_2 &= \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^{\frac{5}{2}} \underline{p}_2.\end{aligned}\tag{14}$$

This scaling is a conformal mapping which is well defined for $\tilde{\varepsilon}$ small since $\tilde{c}_2(\tilde{\varepsilon}) = c_{20} + \mathcal{O}(\tilde{\varepsilon}^2)$ and since by hypothesis (H4), $c_{20} \neq 0$ holds. Note that the change of coordinates on $(\tilde{q}_1, \tilde{p}_1, \tilde{q}_2, \tilde{p}_2)$ is not canonical. Nevertheless, together with the scaling in time, for $\tilde{\varepsilon} \neq 0$ the rescaled differential system is an Hamiltonian system whose Hamiltonian reads

$$\frac{8\tilde{c}_2(\tilde{\varepsilon})}{\tilde{\varepsilon}^6} \tilde{H}_{\tilde{\varepsilon}}\left(\frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^2 \underline{q}_1, \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^3 \underline{p}_1, \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^{\frac{5}{2}} \underline{q}_2, \frac{1}{2\sqrt{2\tilde{c}_2(\tilde{\varepsilon})}} \tilde{\varepsilon}^{\frac{5}{2}} \underline{p}_2\right).$$

Moreover, to work with regular functions of the parameter, and because of the square root in the scaling we also perform a last change of parameter

$$\varepsilon^2 = \tilde{\varepsilon}.$$

For $\varepsilon \in]-\varepsilon_0, 0[\cup]0, \varepsilon_0[$ with $\varepsilon_0 = \sqrt{\tilde{\varepsilon}_0}$, we get for $\underline{x} = (q_1, p_1, q_2, p_2)$ the rescaled Hamiltonian

$$\begin{aligned} \underline{H}_\varepsilon(\underline{x}) &= \frac{8\tilde{c}_2(\tilde{\varepsilon})}{\tilde{\varepsilon}^{12}} \tilde{H}_{\varepsilon^2}(\sigma_\varepsilon(\underline{x})) \\ &= \frac{1}{2}p_1^2 - \frac{1}{2}q_1^2 + 2\sqrt{2}q_1^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2}(q_2^2 + p_2^2) \\ &\quad + \varepsilon^2 \underline{N}_{n,\varepsilon}(q_1, q_2^2 + p_2^2) + \varepsilon^{4n-8} \underline{R}_{n,\varepsilon}(\underline{x}), \end{aligned} \quad (15)$$

where $\underline{N}_{n,\varepsilon}$ is a polynomial of degree less than n with respect to (q_1, q_2, p_2) whose coefficients are \mathcal{C}^1 functions of ε and which satisfies

$$\begin{aligned} \underline{N}_{n,\varepsilon}(q_1, q_2^2 + p_2^2) &:= \frac{1}{\varepsilon^2 \varepsilon^{12}} \left[\tilde{c}_3(\varepsilon^2) \varepsilon^{14} q_1 (q_2^2 + p_2^2) + \tilde{Q}_{n,\varepsilon^2}(\varepsilon^4 q_1, \varepsilon^{10} (q_2^2 + p_2^2)) \right], \\ &= \mathcal{O}(|q_1| |q_2^2 + p_2^2| + \varepsilon^2 (|q_1|^2 + |q_2^2 + p_2^2|)^2). \end{aligned}$$

Recall finally that $\tilde{R}_{n,\tilde{\varepsilon}}$ is a \mathcal{C}^1 one parameter family of analytic Hamiltonians satisfying $\tilde{R}_{n,\tilde{\varepsilon}}(\tilde{x}) = \mathcal{O}(|\tilde{x}|^{n+1})$ for all $\tilde{\varepsilon}$ in $] -\tilde{\varepsilon}_0, \tilde{\varepsilon}_0[$. Thus the explicit formula

$$\underline{R}_{n,\varepsilon}(x) := \frac{1}{\varepsilon^{12} \varepsilon^{4n-8}} \tilde{R}_{n,\varepsilon^2} \left(\frac{1}{2\sqrt{2}\tilde{c}_2(\varepsilon^2)} \varepsilon^4 q_1, \frac{1}{2\sqrt{2}\tilde{c}_2(\varepsilon^2)} \varepsilon^6 p_1, \frac{1}{2\sqrt{2}\tilde{c}_2(\varepsilon^2)} \varepsilon^5 q_2, \frac{1}{2\sqrt{2}\tilde{c}_2(\varepsilon^2)} \varepsilon^5 p_2 \right)$$

ensures that $\underline{R}_{n,\varepsilon}(x)$ is a \mathcal{C}^1 family of the parameter ε . \square

4. Existence of the first return map on Σ_1 : Proof of Propositions 2.4 and 2.5. This section is devoted to the proof of Propositions 2.4 (given in subsections 4.2) and 2.5 (given in Part 4.3). The previous subsections 4.1 is devoted to the proof of a lemma used to prove these propositions.

4.1. Smoothness of the flow apart from the rotation. The following lemma will be the *key to prove the smoothness of the first return map*, and is a *consequence of the Normal Form Theorem applied up to degree n* . This lemma is first used in a weak way (the \mathcal{C}^1 smoothness is sufficient) in the proof of Proposition 2.4 below.

Lemma 4.1. *Denote*

$$R_\theta := \begin{pmatrix} I & O \\ O & R_\theta \end{pmatrix} := \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & 1 & 0 & 0 \\ 0 & 0 & \cos \theta & -\sin \theta \\ 0 & 0 & \sin \theta & \cos \theta \end{pmatrix},$$

and let $\phi(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu)$ be the flow of the Hamiltonian

$$\begin{aligned} H((q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu) &= -q_1 p_1 + \frac{\omega(\varepsilon)}{2\varepsilon^2} (q_2^2 + p_2^2) + \frac{1}{2} (q_1 + p_1)^3 \\ &\quad + \nu N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon) \\ &\quad + \nu \mu \varepsilon^{N_0} \mathcal{R}_n((q_1, p_1, q_2, p_2), \varepsilon). \end{aligned} \quad (16)$$

Then

$$\phi(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu) = R_{\frac{\omega(\varepsilon)}{2\varepsilon^2} t} \tilde{\phi}(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu),$$

where $\tilde{\phi}$ belongs to

$$\mathcal{C}^1([-\varepsilon_0, \varepsilon_0]^3, \mathcal{C}^{k_0}(\mathbb{R}^5)), \quad \text{where } k_0 := E\left(\frac{N_0 - 1}{4}\right),$$

meaning in particular that $\tilde{\phi}$ is \mathcal{C}^1 with respect to $(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu)$ and \mathcal{C}^{k_0} with respect to $(t, (q_1, p_1, q_2, p_2), \nu, \mu)$.

Proof. Denoting

$$\tilde{\phi}(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu) := R_{-\frac{\omega(\varepsilon)}{2\varepsilon^2}t} \phi(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu),$$

given that (q_1, p_1) and $(q_2^2 + p_2^2)$ are preserved by the rotation $R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}$, $\tilde{\phi}$ is then the flow of the nonautonomous Hamiltonian

$$\begin{aligned} \tilde{H}(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu) &= -q_1 p_1 + \frac{1}{2}(q_1 + p_1)^3 + \nu N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon) \\ &\quad + \nu \mu \varepsilon^{N_0} \mathcal{R}_n((q_1, p_1, R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2), \varepsilon). \end{aligned}$$

Thus $\tilde{\phi}$ has the smoothness of $\nabla_X \tilde{H}$, and in the definition of \tilde{H} all is \mathcal{C}^∞ in terms of $(t, (q_1, p_1, q_2, p_2), \nu, \mu)$ and \mathcal{C}^1 with respect to $(t, (q_1, p_1, q_2, p_2), \varepsilon, \nu, \mu)$, except $R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2)$ (when $\varepsilon = 0$). But the derivatives of $R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}$ read

$$\begin{aligned} D_{(q_2, p_2)}(R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2)) &= R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2), \\ \frac{\partial}{\partial t}(R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2)) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} \Omega R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2), \\ \frac{\partial}{\partial \varepsilon}(R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2)) &= \frac{2\varepsilon^2 \omega'(\varepsilon) + 4\varepsilon \omega(\varepsilon)}{4\varepsilon^4} \Omega R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2). \end{aligned} \tag{17}$$

We then get the estimate

$$\left| \nabla_X \mathcal{R}_n(q_1, p_1, R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2), \varepsilon) \right|_{\mathcal{C}^k} = \mathcal{O}_{\varepsilon \rightarrow 0} \left(\frac{1}{\varepsilon^{4k}} \right).$$

So $\nabla_X(\nu \mu \varepsilon^{N_0} \mathcal{R}_n((q_1, p_1, R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}t}(q_2, p_2), \varepsilon))$ is a \mathcal{C}^k -function in the neighborhood of $\varepsilon = 0$ as soon as $4k + 1 \leq N_0$. \square

4.2. Existence of the global map from Σ_2 to Σ_1 : Proof of Proposition

2.4. Let us introduce

$$\begin{aligned} \Sigma_1^- &:= \{(q_1, p_1, q_2, p_2) \in \mathbb{R}^4 / q_1 = \delta - \tfrac{1}{2}\delta\}, \\ \Sigma_1^+ &:= \{(q_1, p_1, q_2, p_2) \in \mathbb{R}^4 / q_1 = \delta + \tfrac{1}{2}\delta\}. \end{aligned}$$

We proceed in several steps.

Step 1. Case $\underline{\varepsilon} = (\varepsilon, 0, 0)$. Let us prove the existence of some $T^\pm(\xi_1, \delta)$ such that for all $(\xi_1, \eta_1, \xi_2, \eta_2)$ in

$$\mathcal{F}_0^{-1}(\Sigma_2) \cap \left\{ (\xi_1, \eta_1, \xi_2, \eta_2) / 0 \leq \xi_1 \leq \frac{1}{16}\delta, \sqrt{I_2} \leq \frac{1}{2}\delta \right\},$$

$\phi(T^\pm(\xi_1, \delta), \mathcal{F}_0(\xi_1, \delta, \xi_2, \eta_2), (\varepsilon, 0, 0))$ belongs to Σ_1^\pm .

To prove this, we first recall that when $\underline{\varepsilon} = (\varepsilon, 0, 0)$ the flow and \mathcal{F}_0 are uncoupled and that $\phi_{q_1, p_1}(\cdot, \cdot, \varepsilon, 0, 0)$ and \mathcal{F}_0 do not depend of ε (see Part 2.1 for the flow and Proposition 2.2 for \mathcal{F}_0). From these facts, we get first that if the T^\pm exist, they are independent of (ξ_2, η_2) and ε . Let us prove their existence working with the

restriction of the flow to the (q_1, p_1) -plane.

We then use the phase portrait drawn in Part 2.1: let us study

which of the orbits hit Σ_1^- and Σ_1^+ . . For that purpose, we work first in the $(\underline{q}_1, \underline{p}_1)$ coordinates of Part 2.1 and use the parameter α of (2). For δ sufficiently small, if an orbit hits Σ_1^- , then it necessarily hits also Σ_1^+ . Let us denote by α_δ the parameter of the orbit passing through the point $(\underline{q}_1, \underline{p}_1) = (\frac{\sqrt{2}}{2}\delta, 0)$, which reads also $(q_1, p_1) = (\frac{1}{2}\delta, \frac{1}{2}\delta)$. Then the orbits labelled by any $\alpha \in [\alpha_\delta, 0]$ hits Σ_1^- . A short computation gives

$$\alpha_\delta = -\frac{1}{2}\delta^2(1 - 4\delta).$$

It remains now to

get back to (q_1, p_1) -coordinates. and then to the local coordinates (ξ_1, η_1) . Firstly, from the study of the phase portraits, we get that the condition $\alpha \leq 0$ means in local coordinates that $\xi_1 \geq 0$. Let us then study the condition $\alpha \geq \alpha_\delta$, by studying the orbit labelled by α_δ , in the neighborhood of Σ_2 .

On Σ_2 , $\eta_1 = \delta$ is satisfied ; let us work in a domain a little larger in (q_1, p_1) coordinates

$$\{(q_1, p_1), q_1 \geq 0, p_1 \in [\frac{1}{2}\delta, \frac{3}{2}\delta]\}, \quad (18)$$

and look for a condition on q_1 which ensures that (q_1, p_1) belongs to an orbit satisfying $\alpha \geq \alpha_\delta$. We consider the orbit $\alpha = \alpha_\delta$ more precisely on the half part satisfying $\underline{p}_1 \geq 0$, thus we obtain

$$\underline{q}_1 \in [\sqrt{2}\frac{1}{2}\delta, \sqrt{2}\frac{3}{2}\delta].$$

From the equation $\underline{p}_1 = \sqrt{\underline{q}_1^2 - 4\sqrt{2}\underline{q}_1^3 + \alpha_\delta}$ of the orbit labelled by α_δ , we compute a lower bound of q_1 on this orbit. Let us denote by $q_1^{\alpha_\delta}(\underline{q}_1)$ a graph description of the orbit ; for \underline{q}_1 in $[\sqrt{2}\frac{1}{2}\delta, \sqrt{2}\frac{3}{2}\delta]$, we get

$$q_1^{\alpha_\delta}(\underline{q}_1) = \frac{1}{\sqrt{2}}(\underline{q}_1 - \sqrt{\underline{q}_1^2 - 4\sqrt{2}\underline{q}_1^3 + \alpha_\delta}) = \frac{1}{\sqrt{2}} \frac{4\sqrt{2}\underline{q}_1^3 - \alpha_\delta}{\underline{q}_1 + \sqrt{\underline{q}_1^2 - 4\sqrt{2}\underline{q}_1^3 + \alpha_\delta}} \geq \frac{1}{12}\delta.$$

Thus we obtain that if $q_1 \in [0, \frac{1}{12}\delta]$ and $p_1 \in [\frac{1}{2}\delta, \frac{3}{2}\delta]$, then (q_1, p_1) belongs to an orbit labelled by $\alpha \geq \alpha_\delta$.

Finally. , with the aid of (vi) of Proposition C.1, and given that I_2 is preserved by the flow, we get that for δ sufficiently small, all the points

$$(q_1, p_1, q_2, p_2) \in \Sigma_2 \cap \mathcal{F}_0 \left(\{(\xi_1, \eta_1, \xi_2, \eta_2) \in \mathbb{R}^4, 0 \leq \xi_1 \leq \frac{1}{16}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \frac{1}{2}\delta\} \right)$$

belong to orbits hitting Σ_1^- and Σ_1^+ , which achieves the proof of existence of $T^\pm(\xi_1, \delta)$ as claimed above.

Step 2. Upper and lower bounds for $T^\pm(\xi_1, \delta)$. (these bounds are useful to get back to the general case $\nu, \mu \neq 0$, see Step 3). Step 1 ensures the existence of the $T^\pm(\xi_1, \delta)$. T^- and T^+ are also locally defined by the Implicit Equations

$$\phi_{q_1}(T^\pm, \mathcal{F}_0(\xi_1, \delta, 0, 0), (\varepsilon, 0, 0)) = \delta \pm \frac{1}{2}\delta.$$

As in Step 2, we get the equivalent Implicit Equation

$$\tilde{\phi}_{q_1}(T^\pm, \mathcal{F}_0(\xi_1, \delta, 0, 0), (\varepsilon, 0, 0)) = \delta \pm \frac{1}{2}\delta. \quad (19)$$

Let us prove that (19) satisfies the hypotheses of the \mathcal{C}^{k_0} implicit function theorem in the neighborhood of each $(T^\pm(\xi_{10}, \delta), \xi_{10})$. On one hand, the result of Lemma 4.1 ensures that this equation is \mathcal{C}^{k_0} . On the other hand,

$$\partial_T \tilde{\phi}_{q_1}(T, (q_1, p_1, q_2, p_2), (\varepsilon, 0, 0)) = \partial_{p_1} H(\tilde{\phi}(T, (q_1, p_1, q_2, p_2), (\varepsilon, 0, 0)), (\varepsilon, 0, 0)),$$

where

$$\partial_{p_1} H((q_1, p_1, q_2, p_2), (\varepsilon, 0, 0)) = -q_1 + \frac{3}{2}(q_1 + p_1)^2$$

and

$$\begin{aligned} \tilde{\phi}_{q_1}(T^\pm(\xi_{10}, \mathcal{F}_0(\xi_{10}, \delta, 0, 0), (\varepsilon, 0, 0))) \\ = \delta \pm \frac{1}{2}\delta \left| \tilde{\phi}_{p_1}(T^\pm(\xi_{10}, \mathcal{F}_0(\xi_{10}, \delta, 0, 0), (\varepsilon, 0, 0))) \right| \leq \delta \end{aligned}$$

hold because of the definition T^\pm . Then the Implicit Functions Theorem applies for δ sufficiently small. This ensures that T^\pm are continuous with respect to ξ_1 , and thus bounded.

Step 3. Existence of $T_L(X, \underline{\varepsilon})$. From Step 1, we know that

$$\phi_{q_1}(T^-(\xi_1, \delta), \mathcal{F}_0(\xi_1, \delta, \xi_2, \eta_2), (\varepsilon, 0, 0)) = \frac{1}{2}\delta, \quad (20)$$

$$\phi_{q_1}(T^+(\xi_1, \delta), \mathcal{F}_0(\xi_1, \delta, \xi_2, \eta_2), (\varepsilon, 0, 0)) = \frac{3}{2}\delta. \quad (21)$$

Recall that (q_1, p_1) are preserved by the R_θ , so that $\phi_{q_1} = \tilde{\phi}_{q_1}$. And Step 2 ensures that there exists $T^-(\delta)$ and $T^+(\delta)$ such that for all ξ_1

$$T^-(\delta) \leq T^-(\xi_1, \delta), T^+(\xi_1, \delta) \leq T^+(\delta).$$

Then, from the \mathcal{C}^1 -smoothness of $\tilde{\phi}_{q_1}$ (Lemma 4.1 for $N_0 \geq 3$), together with (iv) of Proposition C.1, we obtain that for ν and μ sufficiently small,

$$\phi_{q_1}(T^-(\xi_1, \delta), \mathcal{F}_0(\xi_1, \delta, \xi_2, \eta_2), \underline{\varepsilon}) \in \left[\frac{1}{4}\delta, \frac{3}{4}\delta\right], \quad (22)$$

$$\phi_{q_1}(T^+(\xi_1, \delta), \mathcal{F}_0(\xi_1, \delta, \xi_2, \eta_2), \underline{\varepsilon}) \in \left[\frac{5}{4}\delta, \frac{7}{4}\delta\right]. \quad (23)$$

Thus we get the existence of $T_L(X, \underline{\varepsilon})$ thank to the Intermediate Value Theorem.

Step 4. Uniqueness of T_L . For that purpose, it is sufficient to show that in the set

$$\left\{ (q_1, p_1, q_2, p_2) / \frac{1}{4}\delta \leq q_1 \leq \frac{7}{4}\delta, |p_1| \leq \delta, \sqrt{I_2} \leq \delta \right\},$$

the flow satisfies $\frac{dq_1}{dt} < 0$. And indeed

$$\begin{aligned} \frac{dq_1}{dt} &= -q_1 + \frac{3}{2}(q_1 + p_1)^2 + \nu \partial_{p_1}(N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon)) \\ &\quad + \mu \varepsilon^{N_0} \mathcal{R}_n((q_1, p_1, q_2, p_2), \varepsilon)) \\ &\leq -\frac{1}{32}\delta + \frac{3}{2}9\delta^2 + M\nu. \end{aligned} \quad (24)$$

Then, for ν and δ sufficiently small, $\frac{dq_1}{dt} < 0$, which ensures the uniqueness of T_L .

Step 5. Upper bound (8). We use that the trajectories of the flow satisfy

$$\begin{aligned} \left| \frac{d(q_2^2 + p_2^2)}{dt} \right| &= \left| \mu\nu\varepsilon^{N_0}(p_2\partial_{p_2} - q_2\partial_{q_2})\mathcal{R}_n((q_1, p_1, q_2, p_2), \varepsilon) \right| \\ &\leq M\mu\nu\varepsilon^{N_0} \quad \text{for } (q_1, p_1, q_2, p_2) \in \mathcal{B}(0, \rho_0). \end{aligned}$$

Given that $T_L(\mathcal{F}_\varepsilon^{-1}(q_1, p_1, q_2, p_2), \varepsilon) \leq T^+(\delta)$, we get the upper bound (8) claimed above. \square

4.3. Existence and smoothness of the entire first return map: Proof of Proposition 2.5. The following Proposition is a more detailed version of Proposition 2.5.

Proposition 4.2. *There exists a first return map*

$$\begin{aligned} \Psi : \Sigma_1 \cap \mathcal{F}_\varepsilon \left(\{(\xi_1, \eta_1, \xi_2, \eta_2)/0 < \eta_1 \leq \tfrac{1}{24}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \delta\} \times]-\varepsilon_0, \varepsilon_0[\rightarrow \Sigma_1 \right. \\ \left. (p_1, q_2, p_2, \varepsilon) \mapsto R_{\frac{\omega(\varepsilon)}{2\varepsilon^2}T(p_1, q_2, p_2, \varepsilon)} \tilde{\phi}(T(p_1, q_2, p_2, \varepsilon), (\delta, p_1, q_2, p_2), \varepsilon), \right. \end{aligned}$$

where T belongs to $\mathcal{C}^1([-\varepsilon_0, \varepsilon_0]^3, \mathcal{C}^{k_0}(\mathbb{R}^3))$ with k_0 defined in Lemma 4.1.

Moreover, denoting $\Psi = (\Psi_{q_1}, \dots, \Psi_{p_2})$, there exists M such that for ε and δ sufficiently small,

$$|\Psi_{q_2}((p_1, q_2, p_2), \varepsilon)^2 + \Psi_{p_2}((p_1, q_2, p_2), \varepsilon)^2 - (q_2^2 + p_2^2)| \leq \nu M \delta^3 \quad (25)$$

holds on the domain of Ψ .

Proof of the existence. As mentioned in part 2.2, observing the local phase portrait in coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$ in $\mathcal{B}(0, \rho'_0)$, the local map from Σ_1 to Σ_2 is very simple, following the level sets

$$\{(\xi_1, \eta_1, \xi_2, \eta_2)/\xi_1\eta_1 = C^{te}, \xi_2^2 + \eta_2^2 = C^{te}\}.$$

This local map exists on the set $\{(\xi_1, \eta_1, \xi_2, \eta_2)/0 < \eta_1 \leq \delta\}$. We want to compose this local map with the global map Ψ_2 of Proposition 2.4 whose domain is

$$\Sigma_2 \cap \mathcal{F}_\varepsilon \left(\{(\xi_1, \eta_1, \xi_2, \eta_2)/0 \leq \xi_1 \leq \tfrac{1}{16}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \delta\} \right).$$

Then we need to trim the domain of the local map so that its range is included in the domain of Ψ_2 . Since $\xi_2^2 + \eta_2^2$ and $\xi_1\eta_1$ are conserved by the flow, it is sufficient to restrict the local map to trajectories for which $\xi_2^2 + \eta_2^2 \leq \delta^2$ and $|\xi_1\eta_1| \leq \delta \frac{1}{16}\delta$. We proved in Lemma 5.2 that if $|\eta_1| \leq 2\delta$ and $\sqrt{q_2^2 + p_2^2} \leq 2\delta$ then

$$\xi_1 = \xi_1^\Sigma(\eta_1, \xi_2, \eta_2) \leq \frac{3}{2}\delta.$$

So it is sufficient to trim the domain of the local map to the set

$$0 < \eta_1 \leq \delta \text{ and } |\eta_1| \leq \delta, \sqrt{q_2^2 + p_2^2} \leq \delta \text{ and } \eta_1 \leq \frac{2}{3} \frac{1}{16}\delta = \frac{1}{24}\delta,$$

and get then the domain of Ψ stated in the Proposition.

Proof of the smoothness. We showed above the existence of $T(p_1, q_2, p_2, \varepsilon)$. Recall that T is locally defined by the implicit equation given by the intersection with Σ_1 :

$$\phi_{q_1}(T, (\delta, p_1, q_2, p_2), \varepsilon) = \delta.$$

Recall that $\phi_{q_1} = \tilde{\phi}_{q_1}$, so that we get the equivalent implicit equation

$$\tilde{\phi}_{q_1}(T, (\delta, p_1, q_2, p_2), \underline{\varepsilon}) = \delta. \quad (26)$$

Let us prove that (26) satisfies the hypotheses of the \mathcal{C}^{k_0} implicit function theorem in the neighborhood of each $(T(p_{10}, q_{20}, p_{20}, \underline{\varepsilon}_0), p_{10}, q_{20}, p_{20}, \underline{\varepsilon}_0)$. If they are fulfilled, we can construct a \mathcal{C}^{k_0} map $T^*(p_1, q_2, p_2, \underline{\varepsilon})$, and the uniqueness of the first return ensures that $T = T^*$ and finally that T is \mathcal{C}^{k_0} . The result of Lemma 4.1 ensures that this equation is \mathcal{C}^{k_0} . Let us prove that all $((q_1, p_1, q_2, p_2), \underline{\varepsilon})$ in

$$\Sigma_1 \cap \mathcal{F}_{\underline{\varepsilon}} \left(\{(\xi_1, \eta_1, \xi_2, \eta_2)/0 < \eta_1 \leq \frac{1}{24}\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq \delta\} \times] - \varepsilon_0, \varepsilon_0[\right],$$

satisfies $\partial_T \tilde{\phi}_{q_1}(T, (q_1, p_1, q_2, p_2), \underline{\varepsilon}) \neq 0$. We have

$$\partial_T \tilde{\phi}_{q_1}(T, (q_1, p_1, q_2, p_2), \underline{\varepsilon}) = \partial_{p_1} H(\tilde{\phi}(T, (q_1, p_1, q_2, p_2), \underline{\varepsilon}), \underline{\varepsilon}),$$

where

$$\begin{aligned} \partial_{p_1} H((q_1, p_1, q_2, p_2), \underline{\varepsilon}) &= -q_1 + \frac{3}{2}(q_1 + p_1)^2 + \nu \partial_{p_1} N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon) \\ &\quad + \mu \nu \varepsilon^{N_0} \partial_{p_1} \mathcal{R}_n((q_1, p_1, q_2, p_2), \varepsilon). \end{aligned}$$

Given that we work in $\mathcal{B}(0, \rho_0)$ (see the truncature in Part 2.1), $\partial_{p_1} N_n$ and $\partial_{p_1} \mathcal{R}_n$ are uniformly bounded. Moreover,

$$\begin{aligned} \tilde{\phi}_{q_1}(T(p_1, q_2, p_2, \underline{\varepsilon}), (\delta, p_1, q_2, p_2), \underline{\varepsilon}) &= \delta, \\ \left| \tilde{\phi}_{p_1}(T(p_1, q_2, p_2, \underline{\varepsilon}), (\delta, p_1, q_2, p_2), \underline{\varepsilon}) \right| &\leq \delta \end{aligned}$$

hold because of the definition T and the range of Ψ_2 (Proposition 2.4). Then

$$\partial_T \tilde{\phi}_{q_1}(T(p_{10}, q_{20}, p_{20}, \underline{\varepsilon}_0), p_{10}, q_{20}, p_{20}, \underline{\varepsilon}_0) \leq -\delta + \frac{3}{2}(2\delta)^2 + M\nu < 0$$

holds for $\delta < \frac{1}{6}$ and ν sufficiently small.

Proof of the estimate (25). Recall how Ψ was constructed (proof of the existence above). We use two previous results: on one hand, in local coordinates the flow preserves $\xi_2^2 + \eta_2^2$, and on the other hand the estimate (8) gives an upper bound of the variation of $q_2^2 + p_2^2$ by the map Ψ_2 .

To complete the proof, we moreover compute estimates of the difference between $\xi_2^2 + \eta_2^2$ and $q_2^2 + p_2^2$ on Σ_1 and Σ_2 by the changes of coordinates $\mathcal{F}_{\underline{\varepsilon}}$ and $\mathcal{F}_{\underline{\varepsilon}}^{-1}$. We detail the proof for $\mathcal{F}_{\underline{\varepsilon}}$ on Σ_2 ; we more precisely need estimates for $(\xi_1, \eta_1, \xi_2, \eta_2)$ in the domain of Ψ_2 . Recall that we denote $\mathcal{F}_{\underline{\varepsilon}} := (\varphi_{1,\underline{\varepsilon}}, \psi_{1,\underline{\varepsilon}}, \varphi_{2,\underline{\varepsilon}}, \psi_{2,\underline{\varepsilon}})$; (viii) and (ix) of Proposition C.1 allows to get that, for all $(\xi_1, \eta_1, \xi_2, \eta_2) \in \mathcal{B}(0, \rho_0)$,

$$\begin{aligned} &|\varphi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2)^2 + \psi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2)^2 - (\xi_2^2 + \eta_2^2)| \\ &\leq \mathcal{M}_0 \nu |(\xi_1, \eta_1, \xi_2, \eta_2)|^2 (2\mathcal{M}_0 \nu |(\xi_1, \eta_1, \xi_2, \eta_2)|^2 + |\xi_2| + |\eta_2|). \end{aligned}$$

For $(\xi_1, \eta_1, \xi_2, \eta_2)$ in the domain of Ψ_2 , we then obtain

$$|\varphi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2)^2 + \psi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2)^2 - (\xi_2^2 + \eta_2^2)| \leq \nu \mathcal{M}'_0 \delta^3. \quad (27)$$

The same strategy for the change of coordinates $\mathcal{F}_{\underline{\varepsilon}}^{-1}$ in the domain of Ψ allows to achieve the proof of (25). \square

5. Restrictions of the first return map seen as diffeomorphisms of an annulus of \mathbb{R}^2 : Proof of Proposition 2.6. This part is devoted to the proof of Proposition 2.6. The proof itself is in Part 5.5. The previous parts are devoted to the proof of lemmas useful for the proof: in Parts 5.1 and 5.2 we prove respectively that the center-stable manifold $W^{cs}(0)$ and Σ_1 locally read as a graphs. In Part 5.3 we prove two lemmas concerning the geometry of the different energy level sets on $W^{cs}(0)$. And in Part 5.4 we prove that the level sets $\{H = H(P_{\underline{\varepsilon}}^a)\}$ locally read as graphs and give a description of its position with respect to the graph of $W^{cs}(0)$, thank to the lemmas of the previous part. Finally, with the aid of all these graphs we can prove Proposition 2.6.

From now on, we only need two of the three parameters $\underline{\varepsilon} = (\varepsilon, \nu, \mu)$: we only study the influence of the remainder on the dynamic (we explained it in Part 2.1 when we introduced the parameters $\underline{\varepsilon}, \nu, \mu$). Thus we introduce the notation

$$\underline{\varepsilon}' := (\varepsilon, \varepsilon^2, \mu).$$

5.1. In Σ_1 , the center-stable manifold $W^{cs}(0)$ reads as a graph.

Lemma 5.1. *For δ sufficiently small, there exists an analytic function $p_{1,\underline{\varepsilon}}^{cs}$ such that*

$$W_{\underline{\varepsilon}}^{cs}(0) \cap \Sigma_1 \cap \mathcal{B}(0, \delta) = \left\{ (q_1, p_1, q_2, p_2) / q_1 = \delta, p_1 = p_{1,\underline{\varepsilon}}^{cs}(q_2, p_2) \right\}.$$

Moreover, in $\mathcal{B}(0, \delta)$, $p_{1,\underline{\varepsilon}}^{cs}$ satisfies

$$\mathcal{F}_{\underline{\varepsilon}}^{-1}(\delta, p_1, q_2, p_2) \in \{\eta_1 > 0\} \Leftrightarrow p_1 > p_{1,\underline{\varepsilon}}^{cs}(q_2, p_2). \quad (28)$$

Proof. We proceed in three steps.

Step 1. existence. Recall that we denote $\mathcal{F}_{\underline{\varepsilon}}^{-1} := (\varphi_{1,\underline{\varepsilon}}^-, \psi_{1,\underline{\varepsilon}}^-, \varphi_{2,\underline{\varepsilon}}^-, \psi_{2,\underline{\varepsilon}}^-)$. For $\delta \leq \rho'_0$, for any (δ, p_1, q_2, p_2) in $\mathcal{B}(0, \delta)$ the equivalence

$$(\delta, p_1, q_2, p_2) \in W_{\underline{\varepsilon}}^{cs}(0) \iff \psi_{1,\underline{\varepsilon}}^-(\delta, p_1, q_2, p_2) = 0, \quad (29)$$

holds. Then, statement (vii) of Proposition C.1 ensures the existence of \mathcal{M}_0 independent of $\underline{\varepsilon}$ such that

$$|\psi_{1,\underline{\varepsilon}}^-(q_1, p_1, q_2, p_2) - p_1| \leq \mathcal{M}_0 |(q_1, p_1, q_2, p_2)|^2 \quad \text{for all } (q_1, p_1, q_2, p_2) \in \mathcal{B}(0, \rho'_0).$$

So for δ sufficiently small (independently of $\underline{\varepsilon}$), for all $(q_2, p_2) \in \mathcal{B}(0, \delta)$, we get

$$\psi_{1,\underline{\varepsilon}}^-(\delta, -\delta, q_2, p_2) < 0 < \psi_{1,\underline{\varepsilon}}^-(\delta, \delta, q_2, p_2).$$

Then the Intermediate value Theorem ensures the existence of a $p_{1,\underline{\varepsilon}}^{cs}(q_2, p_2) \in [-\delta, \delta]$ such that

$$\psi_{1,\underline{\varepsilon}}^-(\delta, p_{1,\underline{\varepsilon}}^{cs}(q_2, p_2), q_2, p_2) = 0.$$

Step 2. uniqueness and smoothness. We use the implicit equation (29). Differentiating (iii) of Proposition C.1 with respect to p_1 we get the existence of a convergent power series \mathcal{M}_1 (convergent on a ball $\mathcal{B}(0, \rho'_0)$) independent of $\underline{\varepsilon}$ such that

$$\partial_{p_1}(\psi_{1,\underline{\varepsilon}}^-(q_1, p_1, q_2, p_2) - p_1) \prec (q_1 + p_1 + q_2 + p_2) \mathcal{M}_1(q_1 + p_1 + q_2 + p_2).$$

See Appendix B for definitions and properties of the relation \prec .

Then, if $\delta \leq \rho'_0$, for all $(q_1, p_1, q_2, p_2) \in \mathcal{B}(0, \delta)$,

$$|\partial_{p_1}(\psi_{1,\varepsilon}^-(q_1, p_1, q_2, p_2) - p_1)| \leq 4\delta\mathcal{M}_1(4\delta).$$

So for δ sufficiently small $\partial_{p_1}\psi_{1,\varepsilon}^- > 0$ in $\mathcal{B}(0, \delta)$. Thus, for any fixed (q_2, p_2) , the function $p_1 \mapsto \psi_{1,\varepsilon}^-(\delta, p_1, q_2, p_2)$ is strictly increasing, and then we get the uniqueness of the $p_{1,\varepsilon}^{cs}(q_2, p_2)$ of Step 1. Moreover, the fact that $\partial_{p_1}\psi_{1,\varepsilon}^-$ is nonzero allows to apply the analytic Implicit Function Theorem to Equation (29) in the neighborhood of any fixed $(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2)$: we then obtain the analyticity of $p_{1,\varepsilon}^{cs}$.

Step 3. (28). holds given that the function $p_1 \mapsto \psi_{1,\varepsilon}^-(\delta, p_1, q_1, p_1)$ is increasing. \square

5.2. Σ_1 as a graph in local coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$.

Lemma 5.2. *For $\varepsilon, \nu, \mu < \varepsilon_0$ and δ sufficiently small, there exists an analytic map $\xi_{1,\varepsilon}^\Sigma$ defined on the domain $\mathcal{B}_{\mathbb{R}^3}(0, 2\delta) := \{(\eta_1, \xi_2, \eta_2) / |\eta_1| \leq 2\delta, \sqrt{\xi_2^2 + \eta_2^2} \leq 2\delta\}$ satisfying*

$$\mathcal{F}_{\varepsilon}^{-1}(\Sigma_1) \cap \mathcal{B}(0, 2\delta) = \left\{ (\xi_1, \eta_1, \xi_2, \eta_2) / \xi_1 = \xi_{1,\varepsilon}^\Sigma(\eta_1, \xi_2, \eta_2), (\eta_1, \xi_2, \eta_2) \in \mathcal{B}_{\mathbb{R}^3}(0, 2\delta) \right\}.$$

Proof. The proof is very similar to the proof of Lemma 5.1, so we only detail what is different.

Step 1. Existence. Recall that we denote $\mathcal{F}_{\varepsilon} = (\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}, \psi_{2,\varepsilon})$. As in the Step 1 of Lemma 5.1's proof, thank to the result (vi) of Proposition C.1, we prove that for δ, ε sufficiently small,

$$\varphi_{1,\varepsilon}\left(\frac{1}{2}\delta, \eta_1, \xi_2, \eta_2\right) - \delta < 0 < \varphi_{1,\varepsilon}\left(\frac{3}{2}\delta, \eta_1, \xi_2, \eta_2\right) - \delta$$

holds for any fixed (η_1, ξ_2, η_2) in $\mathcal{B}_{\mathbb{R}^3}(0, 2\delta)$. We obtain the existence of $p_{1,\varepsilon}^{cs}(\eta_1, \xi_2, \eta_2)$ in $[\frac{1}{2}\delta, \frac{3}{2}\delta]$ thank to the Intermediate Value Theorem.

Step 2. Uniqueness and smoothness. We proceed as in Step 2 of Lemma 5.1's proof, showing with the aid of (ii) of Proposition C.1 that for δ sufficiently small

$$\partial_{\xi_1}\varphi_{1,\varepsilon}(\xi_1, \eta_1, \xi_2, \eta_2) > 0$$

holds for all ξ_1 in $[\frac{1}{2}\delta, \frac{3}{2}\delta]$ and all (η_1, ξ_2, η_2) in $\mathcal{B}_{\mathbb{R}^3}(0, 2\delta)$. \square

5.3. Positions of the $W^s(P^a)$ on the graph of $W^{cs}(0)$. The following lemma ensures that the energy of P^a is strictly increasing in term of a .

Lemma 5.3. *There exist $a_0, \varepsilon_1 > 0$ and a convergent power series \mathcal{M}_1 such that for all $\varepsilon, \nu, \mu < \varepsilon_1$ and all $a, a' < a_0$*

1. $|H(P_{\varepsilon}^a, \varepsilon) - \frac{\omega(\varepsilon)}{\varepsilon^2}a| \leq \frac{\nu}{\varepsilon^2}a^2\mathcal{M}_1(a)$ holds
2. if $a < a'$ then $H(P_{\varepsilon}^a, \varepsilon) = K_{\varepsilon}(0, a) < H(P_{\varepsilon}^{a'}, \varepsilon) = K_{\varepsilon}(0, a')$.

Proof. Recall that K_{ε} was introduced in (5), and P_{ε}^a was defined by (9), so that for any fixed $(\xi_{2,a}, \eta_{2,a})$ such that $\xi_{2,a}^2 + \eta_{2,a}^2 = a$

$$H(P_{\varepsilon}^a, \varepsilon) = H(\mathcal{F}_{\varepsilon}(0, 0, \xi_{2,a}, \eta_{2,a}), \varepsilon) = K_{\varepsilon}(0, a).$$

Denoting

$$\mathcal{F}_{\underline{\varepsilon}} - \mathcal{F}_0 := \nu(\varphi'_{1,\underline{\varepsilon}}, \psi'_{1,\underline{\varepsilon}}, \varphi'_{2,\underline{\varepsilon}}, \psi'_{2,\underline{\varepsilon}})$$

and using the particular form of \mathcal{F}_0 stated in Proposition C.1, we get

$$\mathcal{F}_{\underline{\varepsilon}}(0, 0, \xi_{2,a}, \eta_{2,a}) = (0, 0, \xi_{2,a}, \eta_{2,a}) + \nu(\varphi'_{1,\underline{\varepsilon}}, \psi'_{1,\underline{\varepsilon}}, \varphi'_{2,\underline{\varepsilon}}, \psi'_{2,\underline{\varepsilon}})(0, 0, \xi_{2,a}, \eta_{2,a}). \quad (30)$$

Let us denote

$$H(q_1, p_1, q_2, p_2, \underline{\varepsilon}) = -q_1 p_1 + \frac{\omega(\underline{\varepsilon})}{2\varepsilon^2}(q_2^2 + p_2^2) + H_3(q_1, p_1, q_2, p_2, \underline{\varepsilon}).$$

H_3 is of order 3 in term of q_1 and is \mathcal{C}^1 in term of $\underline{\varepsilon} = (\varepsilon, \nu, \mu)$. Thus H_3 admits a convergent upper bound for \prec uniformly in $\underline{\varepsilon}$. So do $\varphi'_{1,\underline{\varepsilon}}, \psi'_{1,\underline{\varepsilon}}, \varphi'_{2,\underline{\varepsilon}}, \psi'_{2,\underline{\varepsilon}}$ as stated in (i) of Proposition C.1. We finally obtain the existence of a convergent power series \mathcal{M}_1 independent of $\underline{\varepsilon}$ such that

$$H(\mathcal{F}_{\underline{\varepsilon}}(0, 0, \xi_2, \eta_2), \underline{\varepsilon}) - \frac{\omega(\underline{\varepsilon})}{2\varepsilon^2}(\xi_2^2 + \eta_2^2) \prec \frac{\nu}{\varepsilon^2} \mathcal{M}_3(\xi_2, \eta_2). \quad (31)$$

Moreover, thank to the particular form of $K_{\underline{\varepsilon}} = H(\mathcal{F}_{\underline{\varepsilon}}(\cdot), \underline{\varepsilon})$ stated in (60), we get that \mathcal{M}_3 can be chosen of order 4 and as a power series of $\xi_2^2 + \eta_2^2$. Thus there exists a convergent power series \mathcal{M}_1 such that

$$K_{\underline{\varepsilon}}(0, a) - \frac{\omega(\underline{\varepsilon})}{2\varepsilon^2}a \prec \frac{\nu}{\varepsilon^2}a^2 \mathcal{M}_1(a), \quad (32)$$

which achieves the proof of (i) of the lemma. As a consequence of (32), there exist a_0 and a real M_1 such that

$$\partial_a K_{\underline{\varepsilon}}(0, a)|_{a=0} = \frac{\omega(\underline{\varepsilon})}{2\varepsilon^2}, \quad \text{for all } a \leq a_0, \quad \partial_a^2 K_{\underline{\varepsilon}}(0, a)|_a \leq \frac{\nu}{\varepsilon^2} M_1. \quad (33)$$

So, given that $\omega(0) > 0$ (Hypothesis (H6)) for ν sufficiently small (this small size is independent of ε) and $a < a' \leq a_0$,

$$H(P_{\underline{\varepsilon}}^{a'}, \underline{\varepsilon}) - H(P_{\underline{\varepsilon}}^a, \underline{\varepsilon}) = K_{\underline{\varepsilon}}(0, a') - K_{\underline{\varepsilon}}(0, a) > 0. \quad (34)$$

□

Remark 5.4. Hypothesis (H6) only appears in this lemma ! But in an essential way (to derive (34) from (33)).

We introduce in the following lemma the diffeomorphism $g_{\underline{\varepsilon}}$ which is the restriction of $\mathcal{F}_{\underline{\varepsilon}}$ to $\Sigma_1 \cap W^{cs}(0)$, seen as a map from \mathbb{R}^2 onto \mathbb{R}^2 thank to the graph form of $W^{cs}(0)$ stated in Lemma 5.1. The following result gives a hint on how the stable manifolds $W^s(P^a)$ of the P^a intersects with Σ_1 (recall that they are in $W^{cs}(0)$). Observe that in the (q_2, p_2) coordinates, these intersections are the images through $g_{\underline{\varepsilon}}$ of the circles of area a . The following Lemma describes some properties of the ranges of the circles through the map $g_{\underline{\varepsilon}}$.

Lemma 5.5. Let $\mathcal{C}_a := \{(\xi_2, \eta_2)/\xi_2^2 + \eta_2^2 = a\}$ circle of area a in \mathbb{R}^2 , and let us introduce

$$\begin{aligned} g_{\underline{\varepsilon}} : \mathcal{B}_{\mathbb{R}^2}(0, \tfrac{1}{2}\delta) &\rightarrow \mathbb{R}^2 \\ (\xi_2, \eta_2) &\mapsto (\varphi_{2,\underline{\varepsilon}}, \psi_{2,\underline{\varepsilon}})(\xi_{1,\underline{\varepsilon}}^{\Sigma}(0, \xi_2, \eta_2), 0, \xi_2, \eta_2), \end{aligned}$$

where we recall the notation $(\varphi_{1,\underline{\varepsilon}}, \psi_{1,\underline{\varepsilon}}, \varphi_{2,\underline{\varepsilon}}, \psi_{1,\underline{\varepsilon}}) = \mathcal{F}_{\underline{\varepsilon}}$. Then for δ and ν sufficiently small,

- (a): $g_{\underline{\varepsilon}}(\mathcal{C}_a)$ is a Jordan curve,
- (b): if $a < a'$ then $g_{\underline{\varepsilon}}(\mathcal{C}_a)$ is inside $g_{\underline{\varepsilon}}(\mathcal{C}_{a'})$.

Proof of (a). Given that \mathcal{C}_a is a Jordan curve it is sufficient to show that g_ε is an homeomorphism from $\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta)$ to $g_\varepsilon(\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta))$. For this purpose, let us prove that the map

$$g_\varepsilon^- : (q_2, p_2) \mapsto (\varphi_{2,\varepsilon}^-, \psi_{2,\varepsilon}^-)(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2)$$

is the inverse function of g_ε , where $(\varphi_{1,\varepsilon}^-, \psi_{1,\varepsilon}^-, \varphi_{2,\varepsilon}^-, \psi_{2,\varepsilon}^-) = \mathcal{F}_\varepsilon^{-1}$.

We first verify that g_ε^- is well defined on $g_\varepsilon(\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta))$. On one hand, Lemma 5.1 and Proposition C.1 ensures that g_ε^- is well defined if $\sqrt{q_2^2 + p_2^2} \leq \delta$ and $(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2)$ is in $\mathcal{B}(0, \rho'_0)$, and that $|p_{1,\varepsilon}^{cs}(q_2, p_2)| \leq \delta$. On the other hand, thank to Lemma 5.2 and (vi) of Proposition C.1, we get that for ν sufficiently small $g_\varepsilon(\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta)) \subset \mathcal{B}(0, \delta)$. Then $g_\varepsilon^- \circ g_\varepsilon$ is well-defined for small values of ν and $2\delta \leq \rho'_0$.

Let us prove now that $g_\varepsilon^- \circ g_\varepsilon$ is equal to identity. From the definitions of $\xi_{1,\varepsilon}^\Sigma$ and g_ε and given that

$$\mathcal{F}_\varepsilon(\xi_{1,\varepsilon}^\Sigma(0, \xi_2, \eta_2), 0, \xi_2, \eta_2) \in W^{cs}(0)$$

(because $\eta_1 = 0$), we get that

$$(\delta, p_{1,\varepsilon}^{cs}(g_\varepsilon(\xi_2, \eta_2)), g_\varepsilon(\xi_2, \eta_2)) = (\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}, \psi_{2,\varepsilon})(\xi_{1,\varepsilon}^\Sigma(0, \xi_2, \eta_2), 0, \xi_2, \eta_2).$$

Thus

$$g_\varepsilon^- \circ g_\varepsilon(\xi_2, \eta_2) = (\varphi_{2,\varepsilon}^-, \psi_{2,\varepsilon}^-)(\mathcal{F}_\varepsilon(\xi_{1,\varepsilon}^\Sigma(0, \xi_2, \eta_2), 0, \xi_2, \eta_2)) = (\xi_2, \eta_2).$$

This achieves the proof of (a).

Proof of (b). Let us first show that g_ε preserves the areas. Indeed, let \mathcal{C} be a curve of $\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta)$. We denote by $\mathcal{A}(\mathcal{C})$ the symplectic area of \mathcal{C} in \mathbb{R}^2 endowed with the restriction of Ω to \mathbb{R}^2 . Given that the curves of \mathbb{R}^4

$$\{(\xi_1, \eta_1, \xi_2, \eta_2)/\xi_1 = \xi_{1,\varepsilon}^\Sigma(0, q_2, p_2), \eta_1 = 0, (\xi_2, \eta_2) \in g_\varepsilon(\mathcal{C})\}$$

$$\{(q_1, p_1, q_2, p_2)/q_1 = \delta, p_1 = p_{1,\varepsilon}^{cs}(q_2, p_2), (q_2, p_2) \in \mathcal{C}\},$$

are respectively subsets of $\{(\xi_1, \eta_1, \xi_2, \eta_2)/\eta_1 = 0\}$ and of $\{(q_1, p_1, q_2, p_2)/q_1 = \delta\}$, their areas are respectively $\mathcal{A}(g_\varepsilon(\mathcal{C}))$ and $\mathcal{A}(\mathcal{C})$. So, given that \mathcal{F}_ε is symplectic and thus area-preserving, we get

$$\begin{aligned} \mathcal{A}(g_\varepsilon(\mathcal{C})) &= \mathcal{A}(\{(\xi_1, \eta_1, \xi_2, \eta_2)/\xi_1 = \xi_{1,\varepsilon}^\Sigma(0, q_2, p_2), \eta_1 = 0, (\xi_2, \eta_2) \in g_\varepsilon(\mathcal{C})\}) \\ &= \mathcal{A}(\mathcal{F}_\varepsilon(\{(\xi_1, \eta_1, \xi_2, \eta_2)/\xi_1 = \xi_{1,\varepsilon}^\Sigma(0, q_2, p_2), \eta_1 = 0, (\xi_2, \eta_2) \in g_\varepsilon(\mathcal{C})\})) \\ &= \mathcal{A}(\{(q_1, p_1, q_2, p_2)/q_1 = \delta, p_1 = p_{1,\varepsilon}^{cs}(q_2, p_2), (q_2, p_2) \in \mathcal{C}\}) = \mathcal{A}(\mathcal{C}). \end{aligned}$$

So g_ε is area-preserving.

The result (a) ensures that $g_\varepsilon(\mathcal{C}_{a'})$ divides $g_\varepsilon(\mathcal{B}_{\mathbb{R}^2}(0, \frac{1}{2}\delta))$ into two connected subsets. Given that g_ε is an homeomorphism (see the proof of (a)), $g_\varepsilon(\mathcal{C}_{\frac{1}{2}\delta})$ belongs to one of these subsets and $g_\varepsilon(\mathcal{C}_a)$ to the other. Area preservation ensures that $g_\varepsilon(\mathcal{C}_{\frac{1}{2}\delta})$'s area is greater than $g_\varepsilon(\mathcal{C}_{a'})$'s area, so $g_\varepsilon(\mathcal{C}_a)$ is inside $g_\varepsilon(\mathcal{C}_{a'})$ and $g_\varepsilon(\mathcal{C}_{\frac{1}{2}\delta})$ is outside. \square

5.4. In Σ_1 , the energy level set of P^a reads as a graph ; position of this graph with respect to the graph of $W^{cs}(0)$.

Lemma 5.6. *Let us define*

$$\tilde{h}_\varepsilon(q_2^2 + p_2^2, a) := \frac{\omega(\varepsilon)}{2\varepsilon^2}(q_2^2 + p_2^2) - H(P_\varepsilon^a, \varepsilon).$$

For δ sufficiently small and $a \leq \frac{1}{2}\delta^2$, for ε sufficiently small, there exists $p_{1,\varepsilon}^H$ such that

$$\begin{aligned} & \left\{ (q_1, p_1, q_2, p_2) / H((q_1, p_1, q_2, p_2), \varepsilon) = H(P_\varepsilon^a, \varepsilon) \right\} \cap \Sigma_1 \cap \mathcal{B}(0, \delta) \\ & \cap \left\{ (q_1, p_1, q_2, p_2) / |\tilde{h}_\varepsilon(q_2^2 + p_2^2, a)| \leq \delta^2 \right\} \\ & = \left\{ (q_1, p_1, q_2, p_2) / q_1 = \delta, p_1 = p_{1,\varepsilon}^H(q_2, p_2, a), (q_2, p_2) \in \mathcal{B}_{\mathbb{R}^2}(0, \delta), |\tilde{h}_\varepsilon| \leq \delta^2 \right\} \end{aligned}$$

Moreover, $p_{1,\varepsilon}^H$ reads

$$p_{1,\varepsilon}^H(q_2, p_2, a) := \tilde{p}_1^H(q_2, p_2, \tilde{h}_\varepsilon(q_2^2 + p_2^2, a), \varepsilon), \quad (35)$$

with \tilde{p}_1^H analytic with respect to (q_2, p_2, h) and \mathcal{C}^1 with respect to ε ; more precisely \tilde{p}_1^H belongs to $\mathcal{C}^1[-\varepsilon_0, \varepsilon_0]^3, \mathcal{A}$ (see Definition 1.1 of Part 1).

Proof. We proceed in two main steps.

Step 1. Existence. Let us denote $H_3 := H - H_2$ where H_2 is the quadratic part of H . We get

$$H(\delta, p_1, q_2, p_2, \varepsilon) = H(P_\varepsilon^a, \varepsilon) \iff \tilde{h}_\varepsilon(q_2^2 + p_2^2, a) = \delta p_1 - H_3(\delta, p_1, q_2, p_2, \varepsilon). \quad (36)$$

We first consider h as an independent variable, i.e. we consider the equation

$$h = \delta p_1 - H_3(\delta, p_1, q_2, p_2, \varepsilon), \quad (37)$$

From the explicit expression of H_3 for $\nu = 0$ and given that H_3 is \mathcal{C}^1 with respect to ν and all its variables, for δ and ν sufficiently small, we get that

$$\delta \cdot 2\delta - H_3(\delta, 2\delta, q_2, p_2, \varepsilon, \nu, \mu) \geq \delta^2, \quad \delta \cdot (-2\delta) - H_3(\delta, -2\delta, q_2, p_2, \varepsilon, 0, \mu) \leq -\delta^2.$$

Thus the Intermediate Value Theorem ensures that the equation (37) admits a solution $\tilde{p}_1^H(q_2, p_2, h, \varepsilon) \in [-\delta, \delta]$ when $|h| \leq \delta^2$.

Step 2. Uniqueness and smoothness. From the explicit form of H_3 when $\nu = 0$ and given that H_3 is \mathcal{C}^1 with respect to ν and all its variables, we get that for δ and ν sufficiently small, for $|p_1| \leq \delta$,

$$\partial_{p_1}(\delta p_1 - H_3(\delta, p_1, q_2, p_2, \varepsilon)) \geq \frac{1}{2}\delta > 0.$$

Considering the implicit equation (37) and proceeding like in the Step 2 of Lemma 5.1's proof, we then get the uniqueness and the analyticity of \tilde{p}_1^H . \square

The following lemma is a refinement of Lemma 5.6: it gives an expression of the domain of p_1^H in terms of (q_2, p_2, a) and a description of the position of the graph p_1^H with respect to $p_{1,\varepsilon}^{cs}$.

Lemma 5.7. *There exists c_0 such that for δ sufficiently small and for $a \leq c_0 \delta^2 \varepsilon^2$, the function p_1^H satisfies*

$$\begin{aligned} \{H = H(P^a)\} \cap \Sigma_1 \cap \mathcal{B}(0, \delta) \cap \{(q_1, p_1, q_2, p_2)/I_2 \leq \frac{1}{2} \omega_0 \delta^2 \varepsilon^2\} \\ = \left\{ (q_1, p_1, q_2, p_2)/q_1 = \delta, p_1 = p_1^H(q_2, p_2, a), I_2 \leq \frac{1}{2} \omega_0 \delta^2 \varepsilon^2 \right\} \end{aligned}$$

Moreover, for all $(q_2, p_2) \in g_{\varepsilon}(\mathcal{B}_{\mathbb{R}^2}(0, \delta))$, $p_{1,\varepsilon}^H(q_2, p_2, a) > p_{1,\varepsilon}^{cs}(q_2, p_2)$ holds if and only if

$$(q_2, p_2) \text{ is outside of } \mathcal{C}_s^a := \{(q_2, p_2)/p_1^H(q_2, p_2, a) = p_{1,\varepsilon}^{cs}(q_2, p_2)\}. \quad (38)$$

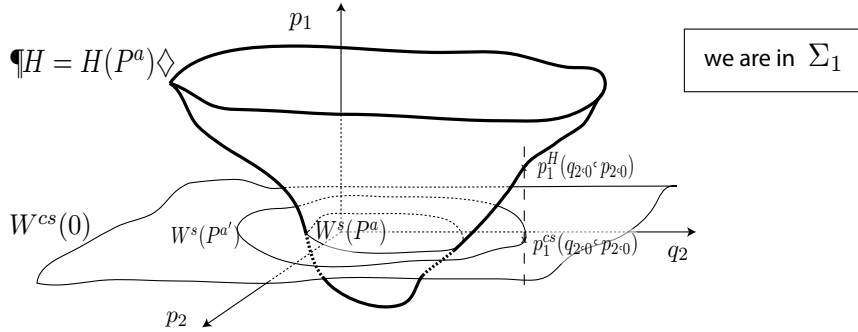


FIGURE 10. In Σ_1 , positions of the energy level set $\{H = H(P^a)\}$ and of the center-stable manifold $W^{cs}(0)$.

Proof of the domain of p_1^H . Recall that

$$|\tilde{h}_{\varepsilon}(q_2^2 + p_2^2, a)| = \left| \frac{\omega(\varepsilon)}{2\varepsilon^2} (q_2^2 + p_2^2) - H(P_{\varepsilon}^a, \varepsilon) \right|.$$

On one hand, given that ω is continuous, for ε sufficiently small we get

$$I_2 \leq \frac{1}{2} \omega_0 \delta^2 \varepsilon^2 \implies \left| \frac{\omega(\varepsilon)}{2\varepsilon^2} (q_2^2 + p_2^2) \right| \leq \frac{1}{2} \delta^2.$$

On the other hand, from (i) of Lemma 5.3, we get

$$|H(P_{\varepsilon}^a, \varepsilon)| \leq \left| H(P_{\varepsilon}^a, \varepsilon) - \frac{\omega(\varepsilon)}{2\varepsilon^2} a \right| + \left| \frac{\omega(\varepsilon)}{2\varepsilon^2} a \right| \leq a^2 \mathcal{M}_1(a) + \left| \frac{\omega(\varepsilon)}{2\varepsilon^2} a \right|.$$

So, there exists c_0 such that if $a \leq c_0 \varepsilon^2 \delta^2$ then $|H(P_{\varepsilon}^a, \varepsilon)| \leq \frac{1}{2} \delta^2$. This proves the expression of the domain of p_1^H claimed in the lemma, given that if $I_2 \leq \frac{1}{2} \omega_0 \delta^2 \varepsilon^2$ and $a \leq c_0 \varepsilon^2 \delta^2$ then $|\tilde{h}_{\varepsilon}(q_2^2 + p_2^2, a)| \leq \delta^2$. \square

Proof of the equivalence (38). Recall that g_{ε} was defined in Lemma 5.5. First, let us prove that $\mathcal{C}_s^a = g_{\varepsilon}(\mathcal{C}_a)$. For that purpose, we work on the intersection of the domains of $p_{1,\varepsilon}^H$ and $p_{1,\varepsilon}^{cs}$. We consider then q_2, p_2, a such that $I_2 \leq \omega_0 \delta^2 \varepsilon^2$ and $a \leq c_0 \delta^2 \varepsilon^2$. Using Lemma 5.3, for ε sufficiently small we get that

$$\begin{aligned} (\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2) &\in \{(q_1, p_1, q_2, p_2)/H((q_1, p_1, q_2, p_2), \varepsilon) = H(P_{\varepsilon}^a, \varepsilon)\} \\ \iff K_{\varepsilon}(0, (g_{\varepsilon}^{-1}(q_2, p_2))_{q_2}^2 + (g_{\varepsilon}^{-1}(q_2, p_2))_{p_2}^2) &= K_{\varepsilon}(0, a). \\ \iff g_{\varepsilon}^{-1}(q_2, p_2) &\in \mathcal{C}_a, \end{aligned}$$

which proves that $\mathcal{C}_s^a = g_\varepsilon(\mathcal{C}_a)$.

Let us consider a fixed value (q_{20}, p_{20}) outside of $g_\varepsilon(\mathcal{C}_a)$ and suppose that moreover (q_{20}, p_{20}) belongs to $g_\varepsilon(\mathcal{B}_{\mathbb{R}^2}(0, \delta))$. Then Lemma 5.5 ensures that there exists $a' > a$ such that $(q_{20}, p_{20}) \in g_\varepsilon(\mathcal{C}_a')$. Thus given that $\mathcal{C}_s^a = g_\varepsilon(\mathcal{C}_a)$, the proof will be achieved if we show

$$p_{1,\varepsilon}^H(q_2, p_2, a') < p_{1,\varepsilon}^H(q_2, p_2, a). \quad (39)$$

Recall that $p_{1,\varepsilon}^H$ is defined by (36), i.e.

$$\frac{\omega(\varepsilon)}{2\varepsilon^2}(q_2^2 + p_2^2) - H(P_\varepsilon^a, \varepsilon) = \delta p_{1,\varepsilon}^H(q_2, p_2, a) - H_3(\delta, p_{1,\varepsilon}^H(q_2, p_2, a), q_2, p_2, \varepsilon). \quad (40)$$

Recall also that we proved in the Step 2 of Lemma 5.6's proof that

$$p_1 \mapsto \delta p_1 - H_3(\delta, p_1, q_2, p_2, \varepsilon)$$

is strictly increasing for $|p_1| \leq \delta$. Finally, Lemma 5.3 ensures that $H(P_\varepsilon^a, \varepsilon) < H(P_\varepsilon^{a'}, \varepsilon)$, so that (39) is a consequence of (40). This achieves the proof of (38). \square

5.5. Proof of Proposition 2.6. *Let us define*

$$\begin{aligned} \Psi_\varepsilon^a : \{(q_2, p_2)/q_2^2 + p_2^2 \leq c\delta^2\varepsilon^2, (q_2, p_2) \text{ outside of } \mathcal{C}_s^a\} &\rightarrow \{(q_2, p_2)/q_2^2 + p_2^2 \leq \omega_0\delta^2\varepsilon^2\} \\ (q_2, p_2) &\mapsto \left(\Psi_\varepsilon\right)_{(q_2, p_2)}(p_1^H(q_2, p_2, a), q_2, p_2). \end{aligned}$$

We proceed in several steps.

Step 1. Let us prove first that for any c , for ε sufficiently small, the set

$$\left\{ (q_1, p_1, q_2, p_2)/q_1 = \delta, 0 < p_1 - p_{1,\varepsilon}^{cs}(q_2, p_2) \leq \frac{1}{24\mathcal{M}_0}\delta, q_2^2 + p_2^2 \leq c\delta^2\varepsilon^2 \right\} \quad (41)$$

is a subset of Ψ 's domain.

Firstly, the equivalence (28) of Lemma 5.1 ensures that

$$p_{1,\varepsilon}^{cs}(q_2, p_2) < p_1 \Rightarrow \eta_1 > 0.$$

Secondly, let us prove that

$$|p_1 - p_{1,\varepsilon}^{cs}(q_2, p_2)| \leq \frac{1}{24\mathcal{M}_0}\delta \Rightarrow |\psi_{1,\varepsilon}^-(\delta, p_1, q_2, p_2)| \leq \frac{1}{24}\delta; \quad (42)$$

where we recall that $\mathcal{F}_\varepsilon^{-1} = (\varphi_{1,\varepsilon}^-, \psi_{1,\varepsilon}^-, \varphi_{2,\varepsilon}^-, \psi_{2,\varepsilon}^-)$. On one hand, the definition of $p_{1,\varepsilon}^{cs}$ ensures that $\psi_{1,\varepsilon}^-(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2) = 0$, and on the other hand from Lemma B.3 we get that

$$\begin{aligned} \psi_{1,\varepsilon}^-(\delta, p_1, q_2, p_2) - \psi_{1,\varepsilon}^-(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2) \\ \prec |\partial_{p_1}\psi_{1,\varepsilon}^-|(\delta, |p_{1,\varepsilon}^{cs}|(q_2, p_2) + p_1, q_2, p_2)|p_1 - p_{1,\varepsilon}^{cs}(q_2, p_2)|. \end{aligned}$$

Then, from Lemma B.2 and (iii) of Proposition C.1, we obtain

$$|\psi_{1,\varepsilon}^-(\delta, p_1, q_2, p_2) - \psi_{1,\varepsilon}^-(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2)| \leq \mathcal{M}_0|p_1 - p_{1,\varepsilon}^{cs}(q_2, p_2)|.$$

This achieves the proof of (42).

Finally, for c and δ sufficiently small,

$$q_2^2 + p_2^2 \leq c\delta^2\nu \Rightarrow \sqrt{\xi_2^2 + \eta_2^2} \leq \delta.$$

Indeed, this result is a consequence of (vii) of Proposition C.1.

Step 2. domain of Ψ_ε^a . Let us prove now that for c sufficiently small, the set

$$\Sigma_1 \cap \{H = H(P_\varepsilon^a)\} \cap \{(q_1, p_1, q_2, p_2)/(q_2, p_2) \text{ is outside of } \mathcal{C}_s^a, q_2^2 + p_2^2 \leq c\delta^2\varepsilon^2\}$$

is a subset of the set (41), and then also of Ψ 's domain.

Firstly, observe that (38) ensures that

$$(q_2, p_2) \text{ outside of } \mathcal{C}_s^a \Rightarrow p_1^H(q_2, p_2, a) > p_{1,\varepsilon}^{cs}(q_2, p_2).$$

Secondly, let us show that for c and ε sufficiently small,

$$q_2^2 + p_2^2 \leq c\delta^2\varepsilon^2 \Rightarrow p_1^H(q_2, p_2, a) - p_{1,\varepsilon}^{cs}(q_2, p_2) \leq \frac{1}{24\mathcal{M}_0}\delta.$$

On one hand, we know that on the curve \mathcal{C}_s^a , $p_1^H(q_2, p_2, a) - p_{1,\varepsilon}^{cs}(q_2, p_2) = 0$. On the other hand, from the definition of $p_{1,\varepsilon}^{cs}$, we get that

$$Dp_{1,\varepsilon}^{cs}(q_2, p_2) = -\frac{D_{(q_2,p_2)}\psi_{1,\varepsilon}^-}{\partial_{p_1}\psi_{1,\varepsilon}^-}(\delta, p_{1,\varepsilon}^{cs}(q_2, p_2), q_2, p_2).$$

and so (iii) of Proposition C.1 allows to obtain that

$$|Dp_{1,\varepsilon}^{cs}(q_2, p_2)| \leq 2$$

for δ sufficiently small. From the definition (36) of p_1^H we get in a similar way that

$$|D_{q_2,p_2}p_1^H(q_2, p_2, a)| \leq \frac{C}{\varepsilon}.$$

Thus we obtain that

$$q_2^2 + p_2^2 \leq c\delta^2\varepsilon^2 \Rightarrow |p_1^H(q_2, p_2, a) - p_{1,\varepsilon}^{cs}(q_2, p_2)| \leq \left(2 + \frac{C}{\varepsilon}\right)\sqrt{c}\delta\varepsilon.$$

So, for c sufficiently small, the result claimed in the summary above holds.

Step 3. range of Ψ_ε^a . Let us prove that the image of (41) through Ψ is a subset of the set where the energy level set $\{H = H(P_\varepsilon^a)\}$ reads as the graph of p_1^H .

From Proposition 2.4, we already know that the range of Ψ is a subset of $\mathcal{B}(0, \delta)$. Let us show that the image of (41) is a subset of

$$\{(q_1, p_1, q_2, p_2), I_2 \leq \frac{1}{2}\omega_0\delta^2\varepsilon^2\}.$$

From (25) with $\nu = \varepsilon^2$, we get that if $I_2 \leq c\delta^2\varepsilon^2$ then

$$\left|\frac{\omega(\varepsilon)}{2\varepsilon^2}(\Psi_{q_2}((q_1, p_1, q_2, p_2), \varepsilon)^2 + \Psi_{p_2}((q_1, p_1, q_2, p_2), \varepsilon)^2)\right| \leq M(c + \delta)\delta^2.$$

So the result claimed in the summary of the main steps above holds for c and δ sufficiently small. \square

6. Construction of an invariant curve for the restrictions of the first return map with the aid of a KAM theorem: Proof of Proposition 2.9. This section is entirely devoted to the proof of Proposition 2.9.

In this part we consider $a \leq c_0\delta^2\varepsilon^2$, and work in annulus of the form

$$\{(q_2, p_2)/I_2 = q_2^2 + p_2^2 \in [c_1(\delta)\delta\varepsilon^2, c_2(\delta)\delta\varepsilon^2]\},$$

where c_1, c_2 are lower than the c of Ψ_ε^a 's domain (see Proposition 2.6): the choice of c_1, c_2 is made in Lemma 6.5. Here is an **outline of the proof of Proposition 2.9**:

- **Parts 6.1 and 6.2** are devoted to the proof of estimates concerning the Ψ_{ε}^a . The results (ii) and (iii) will be the consequences of the estimates on the $\Psi_{(\varepsilon, \varepsilon^2, 0)}^a$ showed in Part 6.1, and (iv) a consequence of the upper bounds of $\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a$ computed in Part 6.2.
- In

Part 6.3, we introduce the changes of coordinates which transforms Ψ_{ε}^a into $\hat{\Psi}_{\varepsilon}^a$. The proof of (ii), (iii) and (iv) follows directly from the results of Parts 6.1 and 6.2.

Part 6.4. is devoted to the proof of (i).

6.1. Estimates for the first return map $\Psi_{(\varepsilon, \varepsilon^2, 0)}^a$ of the normal form. In this part, we give first in Lemma 6.1 an explicit form of the $\Psi_{(\varepsilon, \varepsilon^2, 0)}^a$ in polar coordinates. We then use this form to compute upper and lower bounds. Up to the change of coordinates that we will perform in Part 6.3, Lemma 6.2 states the upper bound (iii) of Proposition 2.9 and Lemma 6.5 is the result (ii). The latter lemma requires the proof of the two preliminary results of Lemmas 6.3 and 6.4.

Lemma 6.1. *In polar coordinates, $\Psi_{(\varepsilon, \varepsilon^2, 0)}^a$ reads*

$$(\Psi_{\theta, (\varepsilon, \varepsilon^2, 0)}^a, \Psi_{r, (\varepsilon, \varepsilon^2, 0)}^a)(\theta, r) = (\theta + \Theta(r, a, \varepsilon), r),$$

with

$$\begin{aligned} \Theta(r, a, \varepsilon) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \\ &\quad + \varepsilon \int_0^{T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0))} \partial_2 N_n((\phi_{q_1} + \phi_{p_1})(s, (\delta, p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0), \varepsilon), r, \varepsilon) ds, \end{aligned}$$

where $p_{1(\varepsilon, \varepsilon^2, 0)}^H(r \cos \theta, r \sin \theta, a)$ and $T(p_1, r \cos \theta, r \sin \theta, (\varepsilon, \varepsilon^2, 0))$ (recall that T was defined in Proposition 4.2) are independent of θ .

Proof. Recall that for $\mu = 0$, the Hamiltonian system reads

$$\begin{cases} q_1'(t) &= -p_1 + \frac{3}{2}(q_1 + p_1)^2 + \varepsilon^2 \partial_1 N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon), \\ p_1'(t) &= q_1 - \frac{3}{2}(q_1 + p_1)^2 - \varepsilon^2 \partial_1 N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon), \\ q_2'(t) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} p_2 + \varepsilon^2 \partial_2 N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon) p_2, \\ p_2'(t) &= -\frac{\omega(\varepsilon)}{2\varepsilon^2} q_2 - \varepsilon^2 \partial_2 N_n(q_1 + p_1, q_2^2 + p_2^2, \varepsilon) q_2. \end{cases} \quad (43)$$

This system satisfies

$$\frac{d}{dt}(q_2^2 + p_2^2) = \frac{d}{dt} I_2 = 0.$$

Then, the (q_1, p_1) component of the flow reads $\phi_{(q_1, p_1)}(t, (q_1, p_1, I_{20}), \varepsilon)$ for a fixed value $I_2 = I_{20}$. So for q_{20}, p_{20} such that $q_{20}^2 + p_{20}^2 = I_{20}$,

$$\begin{pmatrix} q_2 \\ p_2 \end{pmatrix} (t) = \mathbf{R}_{\theta(t, I_{20}, \varepsilon)} \begin{pmatrix} q_{20} \\ p_{20} \end{pmatrix},$$

where

$$\theta(t, I_{20}, \varepsilon) := \frac{\omega(\varepsilon)}{2\varepsilon^2} t + \int_0^t \varepsilon^2 \partial_2 N_n((\phi_{q_1} + \phi_{p_1})(s, (q_1, p_1, I_{20}), \varepsilon), I_2, \varepsilon) ds.$$

The result claimed by Lemma 6.1 follows, up to the proof that the functions $p_{1(\varepsilon, \varepsilon^2, 0)}^H(r \cos \theta, r \sin \theta, a)$ and $T(p_1, r \cos \theta, r \sin \theta, (\varepsilon, \varepsilon^2, 0))$ are independent of θ .

Indeed, $p_1^H(\varepsilon, \varepsilon^2, 0)$ is defined as the unique p_1^H such that

$$\begin{aligned} H((\delta, p_1^H, q_2, p_2), (\varepsilon, \varepsilon^2, 0)) &= H(P_{(\varepsilon, \varepsilon^2, 0)}^a, (\varepsilon, \varepsilon^2, 0)) \\ \Leftrightarrow \delta p_1^H - \frac{1}{2}(\delta + p_1^H)^2 - \varepsilon^2 N_n(\delta + p_1^H, r^2, \varepsilon) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} r^2 - H(P_{(\varepsilon, \varepsilon^2, 0)}^a, (\varepsilon, \varepsilon^2, 0)). \end{aligned}$$

where the latter equation is independent of θ . Similarly, T is defined by

$$\tilde{\phi}_{q_1}(T, (\delta, p_1, q_2, p_2), (\varepsilon, \varepsilon^2, 0)) = \delta,$$

where from the form (43) of the hamiltonian system we know that the (q_1, p_1) component of the flow reads $\phi_{(q_1, p_1)}(t, (q_1, p_1, I_{20}), \varepsilon)$. Then, the definitions of p_1^H and T are independent of θ and we get the result. \square

Lemma 6.2. *There exists M such that for $0 \leq a \leq c_0$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$, for all $k \leq k_0 = E(\frac{N_0-1}{4})$, Θ satisfies*

$$|\partial_r^k \Theta(r, a, \varepsilon)| \leq \frac{M}{\varepsilon^{k+2}}.$$

Proof. On one hand, from the result of Lemma 4.1 the explicit formula of Θ in Lemma 6.1 reads

$$\begin{aligned} \Theta(r, a, \varepsilon) &= \frac{\omega(\varepsilon)}{2\varepsilon^2} T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \\ &\quad + \varepsilon^2 \mathcal{F}\left(T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)), p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, \varepsilon\right), \end{aligned} \quad (44)$$

with \mathcal{F} and T in $\mathcal{C}^1([- \varepsilon_0, \varepsilon_0], \mathcal{C}^{k_0})$. On the other hand, recall that

$$p_{1, \varepsilon'}^H(q_2, p_2, a) = \tilde{p}_1^H(q_2, p_2, \tilde{h}_{\varepsilon'}(q_2^2 + p_2^2, a), \varepsilon'), \quad (45)$$

where \tilde{p}_1^H belongs to $\mathcal{C}^1([- \varepsilon_0, \varepsilon_0], \mathcal{A})$. Thus the only irregularity is in

$$\tilde{h}_{\varepsilon'}(r^2, a) = \frac{\omega(\varepsilon)}{2\varepsilon^2} r^2 - H(P_{\varepsilon'}^a, \varepsilon')$$

for $\varepsilon = 0$. And we check that there exists M_1 such that for $k \leq k_0$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,

$$|\partial_r^k \tilde{h}_{\varepsilon'}(r^2, a)| \leq \frac{M_1}{\varepsilon^k}$$

holds. Finally, we obtain the existence of M such that for $k \leq k_0$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,

$$|\partial_r^k \Theta(r, a, \varepsilon)| \leq \frac{M}{\varepsilon^{k+2}}.$$

\square

To prove (ii) of Proposition 2.9, we need a lower bound of $\partial_r \Theta$. In view of the explicit form of Θ obtained in Lemma 6.1, we first compute estimates of T in Lemma 6.3 below and then of p_1^H in the following Lemma 6.4.

Lemma 6.3. *For the truncated Hamiltonian*

$$H((q_1, p_1, q_2, p_2), (\varepsilon, 0, 0)) = -q_1 p_1 + \frac{1}{2}(q_1 + p_1)^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2}(q_2^2 + p_2^2),$$

the time T of first return to the section satisfies

$$\partial_{p_1} T((q_1, p_1, q_2, p_2), (\varepsilon, 0, 0)) = \partial_{p_1} T^0(p_1) < 0.$$

Proof. In the coordinates $(\underline{q}_1, \underline{p}_1)$ (see Part 2.1), the truncated Hamiltonian reads

$$\frac{1}{2}(\underline{p}_1^2 - \underline{q}_1^2) + \frac{1}{2}\underline{q}_1^3 + \frac{\omega(\varepsilon)}{2\varepsilon^2}(\underline{q}_1^2 + \underline{p}_1^2).$$

Recall that $\underline{q}_1^2 + \underline{p}_1^2$ is constant, so that the flow follows the level sets

$$\frac{1}{2}(\underline{p}_1^2 - \underline{q}_1^2) + \frac{1}{2}\underline{q}_1^3 = -\alpha \Leftrightarrow \underline{p}_1 = \pm \sqrt{\underline{q}_1^2 - \underline{q}_1^3 - \alpha}.$$

We get periodic orbits when $0 < \alpha < \frac{4}{27}$ and the homoclinic orbit for $\alpha = 0$. Let us denote by $(\underline{q}_1(t), \underline{p}_1(t), \underline{q}_2(t), \underline{p}_2(t))$ the periodic solution associated with α and by $\tau(\alpha)$ its period. Then $\underline{p}_1(\frac{1}{2}\tau(\alpha)) = 0$, and $\underline{q}_1(0)$ and $\underline{q}_1(\frac{1}{2}\tau(\alpha))$ are the two positive roots of $z^2 - z^3 - \alpha$. And $\frac{1}{2}\tau(\alpha)$ satisfies

$$\frac{1}{2}\tau(\alpha) = \int_0^{\frac{1}{2}\tau(\alpha)} \frac{\underline{p}_1(t)}{\sqrt{\underline{q}_1(t)^2 - \underline{q}_1(t)^3 - \alpha}} dt = \int_{\underline{q}_1(0)=:z_1(\alpha)}^{\underline{q}_1(\frac{1}{2}\tau(\alpha))=:z_2(\alpha)} \frac{1}{\sqrt{z^2 - z^3 - \alpha}} dz$$

given that $\underline{q}'_1(t) = \underline{p}_1(t)$. By studying the map $z \mapsto z^2 - z^3$, we obtain that $\partial_\alpha z_1(\alpha) > 0$ and $\partial_\alpha z_2(\alpha) < 0$ for all $\alpha \in]0, \frac{4}{27}[$. This proves that $\partial_\alpha \tau(\alpha) < 0$, and thus that $\partial_{p_1} T^0(p_1) < 0$. \square

Lemma 6.4. *Let $\underline{c}_1, \underline{c}_2$ be two fixed positive reals satisfying $\underline{c}_2 - \underline{c}_1 > 4\delta$.*

Let us introduce $\underline{c}_1'', \underline{c}_2''$ such that $\underline{c}_1 < \underline{c}_1'' < \underline{c}_2'' < \underline{c}_2 - 4\delta$ and define

$$c_1 := \frac{4\underline{c}_1''}{\omega_0}, \quad c_2 := \frac{4\underline{c}_2''}{\omega_0}.$$

Then there exist c_0 such that for all ε sufficiently small, for all $a \in [0, c_0\delta^2\varepsilon^2]$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,

$$p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a) \in [\underline{c}_1\delta, \underline{c}_2\delta], \quad \partial_h \tilde{p}_1^H \geq \frac{1}{2}\delta > 0.$$

Moreover, on this domain, $\tilde{h}_{\varepsilon'}$ satisfies $\tilde{h}_{\varepsilon'}(r^2, a) \in [\underline{c}_1\delta^2, (\underline{c}_2 - 4\delta)\delta^2]$.

Proof. Recall that Lemma 5.6 defines \tilde{p}_1^H and asserts that it is \mathcal{C}^1 .

Step 1. Case $\underline{\varepsilon} = (\varepsilon, \nu = 0, \mu = 0)$. Let us introduce $\underline{c}_1', \underline{c}_2'$ such that

$$\underline{c}_1 < \underline{c}_1' < \underline{c}_1'' < \underline{c}_2'' < \underline{c}_2' - 4\delta < \underline{c}_2 - 4\delta.$$

In the case considered in this step, \tilde{p}_1^H is defined by

$$\delta \tilde{p}_1^H - \frac{1}{2}(\delta + \tilde{p}_1^H)^3 = h.$$

Recall also that on its domain, $|\tilde{p}_1^H| \leq \delta$ holds. From these two results we get that, on one hand

$$\partial_h \tilde{p}_1^H(r, 0, h, (\varepsilon, 0, 0)) \geq \frac{1}{\delta} > 0 \tag{46}$$

holds on the domain of \tilde{p}_1^H . And on the other hand, for all h in $[\underline{c}_1'\delta^2, (\underline{c}_2' - 4\delta)\delta^2]$,

$$\tilde{p}_1^H(r, 0, h, a, \nu = 0) \in [\underline{c}_1'\delta, \underline{c}_2'\delta]. \tag{47}$$

Step 2. Case $\underline{\varepsilon} = (\varepsilon, \varepsilon^2, 0)$. Given that \tilde{p}_1^H is \mathcal{C}^1 in term of ν and ε , from (47) we get that for ε sufficiently small, for all h in $[\underline{c}_1'\delta^2, (\underline{c}_2' - 4\delta)\delta^2]$,

$$\tilde{p}_1^H(r, 0, h, a, (\varepsilon, \varepsilon^2, 0)) \in [\underline{c}_1\delta, \underline{c}_2\delta].$$

and from (46) we obtain

$$\partial_h \tilde{p}_1^H(r, 0, h, (\varepsilon, \varepsilon^2, 0)) \geq \frac{1}{2\delta} > 0.$$

Recall that

$$\tilde{h}_{\underline{\varepsilon}'}(r^2, a) = \frac{\omega(\varepsilon)}{2\varepsilon^2} r^2 - H(P_{\underline{\varepsilon}'}^a, \underline{\varepsilon}').$$

The choice of c_1, c_2 ensures that for ε sufficiently small if r^2 belongs to $[c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$ then $\frac{\omega(\varepsilon)}{2\varepsilon^2} r^2$ is in $[\underline{c}_1''\delta^2, \underline{c}_2''\delta^2]$. And Lemma 5.3 with $\nu = \varepsilon^2$ ensures that

$$\left| H(P_{\underline{\varepsilon}'}^a, \underline{\varepsilon}') \right| \leq \frac{\omega(\varepsilon)}{2\varepsilon^2} a + \frac{\varepsilon^2}{\varepsilon^2} \mathcal{M}_0 a^2.$$

So, for c_0 sufficiently small, if $a \leq c_0\delta^2\varepsilon^2$, then

$$\left| H(P_{\underline{\varepsilon}'}^a, \underline{\varepsilon}') \right| \leq \min(\underline{c}_1'' - \underline{c}_1', (\underline{c}_2' - 4\delta) - \underline{c}_2'')\delta^2.$$

□

Lemma 6.5. *If $N_0 \geq 5$, there exist c_0, c_1, c_2 and $m, M > 0$ such that for ε sufficiently small, for all $a \in [0, c_0\delta^2\varepsilon^2]$ and all $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,*

$$-\frac{M}{\varepsilon^3} \leq \partial_r \Theta(r, a, \varepsilon) \leq -\frac{m}{\varepsilon^3}.$$

Moreover, we can chose c_1, c_2 satisfying

$$M\delta < c_1 < c_2 \leq c,$$

with the constant c introduced in Proposition 2.6 and M is the constant of the upper bound (25).

And there exist $\underline{c}_1, \underline{c}_2$ such that on this domain, $\tilde{h}_{\underline{\varepsilon}'}$ and p_1^H satisfies

$$\tilde{h}_{\underline{\varepsilon}'}(r^2, a) \in [\underline{c}_1\delta^2, (\underline{c}_2 - 4\delta)\delta^2], \quad p_1^H(r, \theta, a) \in [\underline{c}_1\delta, \underline{c}_2\delta]. \quad (48)$$

Proof. The existence of M (without conditions on a and r) is a direct consequence of Lemma 6.2 for $k = 1$, given that we suppose $N_0 \geq 5$.

In order to prove the existence of m , we use the form (44) of Θ together with the form (45) of p_1^H : Θ reads

$$\Theta(r, a, \varepsilon) = \frac{\omega(\varepsilon)}{2\varepsilon^2} T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) + \varepsilon^2 \tilde{\mathcal{F}}\left(\tilde{h}_{\underline{\varepsilon}'}(r^2, a), r, \varepsilon\right),$$

where T and $\tilde{\mathcal{F}}$ belong to $\mathcal{C}^1([-\varepsilon_0, \varepsilon_0], \mathcal{C}^{k_0})$. Differentiating with respect to r we get

$$\begin{aligned}
& \partial_r \Theta(r, a, \varepsilon) \\
&= \frac{\omega(\varepsilon)}{2\varepsilon^2} \partial_{p_1} T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \times \\
&\quad \left(\partial_h \tilde{p}_1^H(r, 0, a, (\varepsilon, \varepsilon^2, 0)) \partial_r \tilde{h}_{\varepsilon'}(r^2, a) + \partial_r \tilde{p}_1^H(r, 0, a, (\varepsilon, \varepsilon^2, 0)) \right) \\
&\quad + \frac{\omega(\varepsilon)}{2\varepsilon^2} \partial_r T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \\
&\quad + \varepsilon^2 \left(\partial_h \tilde{\mathcal{F}}(\tilde{h}_{\varepsilon'}(r^2, a), r, \varepsilon) \left(\frac{\omega(\varepsilon)}{2\varepsilon^2} r \right) + \partial_r \tilde{\mathcal{F}}(\tilde{h}_{\varepsilon'}(r^2, a), r, \varepsilon) \right), \tag{49} \\
&= \frac{\omega(\varepsilon)}{2\varepsilon^2} \partial_{p_1} T(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \partial_h \tilde{p}_1^H(r, 0, a, (\varepsilon, \varepsilon^2, 0)) \partial_r \tilde{h}_{\varepsilon'}(r^2, a) + \mathcal{O}\left(\frac{1}{\varepsilon^2}\right),
\end{aligned}$$

where (49) holds because $\partial_{p_1} T, \partial_r \tilde{p}_1^H, \partial_r T, \partial_h \tilde{\mathcal{F}}, \partial_r \tilde{\mathcal{F}}$ are continuous and for any fixed choice of c_0, c_1, c_2 , $\tilde{h}_{\varepsilon'}$ is bounded and Lemma 6.4 ensures that p_1^H is also.

Let us show that the principal part in (49) admits an upper bound of the form $-\frac{m}{\varepsilon^3}$ for an appropriate choice of c_0, c_1 and c_2 . For that purpose, we use Lemmas 6.3 and 6.4.

On one hand, Lemma 6.3 ensures that $\partial_{p_1} T^0(p_1) < 0$ when $p_1 > p_1(\delta)$. Then, given that T is \mathcal{C}^1 , for any set $\{p_1 \in [c_1\delta, c_2\delta]\}$, there exists m such that $\partial_{p_1} T^0 \leq -2m$ on this set. For ε, μ sufficiently small, we get

$$\partial_{p_1} T(p_1, q_2, p_2, \varepsilon) \leq -m < 0 \text{ for all } p_1 \in [c_1\delta, c_2\delta].$$

Let us chose c_1, c_2 satisfying moreover

$$4 \frac{c_2 - 4\delta}{\omega_0} < c, \quad c_1 < c_2 + 4\delta, \quad M\delta < \frac{4c_1}{\omega_0},$$

where M is the constant of the upper bound (25). On the other hand, with this choice of c_1, c_2 , Lemma 6.4 ensures that there exists c_0, c_1 and c_2 satisfying $c_1, c_2 \leq c$ and $c_1 > M\delta$ such that for all $a \in [0, c_0\delta^2\varepsilon^2]$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,

$$p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a) \in [c_1\delta, c_2\delta] \quad \partial_h \tilde{p}_1^H(r, 0, a, (\varepsilon, \varepsilon^2, 0)) \geq \frac{1}{2\delta} > 0.$$

Moreover, for $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$

$$\partial_r \tilde{h}_{\varepsilon'}(r^2, a) = 2 \frac{\omega(\varepsilon)}{2\varepsilon^2} r \geq \sqrt{c_1} \frac{\omega(\varepsilon)}{\varepsilon} \delta > 0.$$

We finally obtain that for $a \in [0, c_0\delta^2\varepsilon^2]$ and $r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]$,

$$\begin{aligned}
& \frac{\omega(\varepsilon)}{2\varepsilon^2} \frac{\partial T}{\partial p_1}(p_{1(\varepsilon, \varepsilon^2, 0)}^H(r, 0, a), r, 0, (\varepsilon, \varepsilon^2, 0)) \frac{\partial \tilde{p}_1^H}{\partial h}(r, 0, a, (\varepsilon, \varepsilon^2, 0)) \frac{\partial \tilde{h}_{\varepsilon'}}{\partial r}(r^2, a) \\
& \leq -\frac{m\omega(\varepsilon)^2 \sqrt{c_1}}{\varepsilon^3},
\end{aligned}$$

which, together with (49) achieves the proof of the Lemma. \square

6.2. Upper bound \mathcal{C}^k of $\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a$. Given that the KAM theorem of [20] (see Theorem 2.8 in part 2.3) is stated in polar coordinates, we need the following lemma, which gives upper bounds of the polar form $(\Psi_\theta^a(\theta, r), \Psi_r^a(\theta, r))$ of Ψ^a in

terms of $(\Psi_{q_2}^a(q_2, p_2), \Psi_{p_2}^a(q_2, p_2))$. This computation relies on the fact that we work on the domain

$$\{(q_2, p_2)/q_2^2 + p_2^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]\},$$

which is away from 0.

Lemma 6.6. *If $(p_1, q_2, p_2, \varepsilon')$ belongs to the domain of Ψ and $c_1\delta^2\varepsilon^2 \leq q_2^2 + p_2^2 \leq c_2\delta^2\varepsilon^2$, then*

$$\Psi_{(q_2, p_2)}(p_1, q_2, p_2, \varepsilon') = \Psi_r(p_1, q_2, p_2, \varepsilon') R_{\Psi_\theta(p_1, q_2, p_2, \varepsilon')},$$

where Ψ_r is \mathcal{C}^{k_0} and in $\mathbb{R}/2\pi\mathbb{Z}$,

$$\Psi_\theta(p_1, q_2, p_2, \varepsilon') \equiv \frac{\omega(\varepsilon')}{\varepsilon'^2} T(p_1, q_2, p_2, \varepsilon') + \tilde{\phi}_\theta(T(p_1, q_2, p_2, \varepsilon'), (\delta, p_1, q_2, p_2), \varepsilon'),$$

holds with T and $\tilde{\phi}_\theta$ \mathcal{C}^{k_0} in $\mathcal{C}^1(\cdot - \varepsilon_0, \varepsilon_0]^3, \mathcal{C}^{k_0})$ and there exists M such that for every variable x of $\tilde{\phi}$,

$$|\partial_x^j \tilde{\phi}_\theta| \leq \frac{M}{\varepsilon^j} \left(\sum_{k=0}^j |\partial_x^k \tilde{\phi}_{q_2}| + |\partial_x^k \tilde{\phi}_{p_2}| \right).$$

Proof. Thank to the upper bound (25) of Proposition 4.2 (with $\varepsilon = \varepsilon^2$), there exists M such that if $(p_1, q_2, p_2, \varepsilon')$ is in the domain of Ψ and (q_2, p_2) satisfies $\{(q_2, p_2)/q_2^2 + p_2^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]\}$ then

$$\Psi(p_1, q_2, p_2, \varepsilon') \in \{(q_1, p_1, q_2, p_2)/q_2^2 + p_2^2 \in [(c_1\delta^2 - M\delta^3)\varepsilon^2, (c_2\delta^2 + M\delta^3)\varepsilon^2]\}. \quad (50)$$

On one hand, Lemma 6.5 ensures that $c_1 > M\delta$, thus, denoting

$$\Psi_r(p_1, q_2, p_2, \varepsilon') := \sqrt{\Psi_{q_2}(p_1, q_2, p_2, \varepsilon')^2 + \Psi_{p_2}(p_1, q_2, p_2, \varepsilon')^2},$$

Ψ_r is \mathcal{C}^{k_0} as Ψ . On the other hand, recall that

$$\Psi(p_1, q_2, p_2, \varepsilon') = R_{\frac{\omega(\varepsilon')}{\varepsilon'^2} T(p_1, q_2, p_2, \varepsilon')} \tilde{\phi}(T(p_1, q_2, p_2, \varepsilon'), (\delta, p_1, q_2, p_2), \varepsilon'),$$

so

$$\Psi_\theta \equiv \frac{\omega(\varepsilon')}{\varepsilon'^2} T(p_1, q_2, p_2, \varepsilon') + \tilde{\phi}_\theta(T(p_1, q_2, p_2, \varepsilon'), (\delta, p_1, q_2, p_2), \varepsilon'),$$

where $\tilde{\phi}_\theta$ is defined by

$$\frac{\tilde{\phi}_{q_2} + i\tilde{\phi}_{p_2}}{\tilde{\phi}_r} = e^{i\tilde{\phi}_\theta}. \quad (51)$$

And (50) ensures that $|\tilde{\phi}_r|^2 \geq (c_1 - M\delta)\delta^2\varepsilon^2$, then if x is any variable of $\tilde{\phi}$, we get

$$|\partial_x \tilde{\phi}_\theta| \leq \frac{1}{\sqrt{(c_1 - M\delta)\delta\varepsilon}} (|\partial_x \tilde{\phi}_{q_2}| + |\partial_x \tilde{\phi}_{p_2}|).$$

Differentiating (51) many times, we obtain the upper bounds claimed above for the higher order derivatives of $\tilde{\phi}_\theta$. \square

Lemma 6.7. *For a, ε, μ sufficiently small and $0 \leq k \leq k_0$,*

$$\begin{aligned} |\Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, \mu)) - \Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, 0))|_{\mathcal{C}^k} &\leq \left(a^2 + \frac{\mu}{\varepsilon^k}\right) M, \\ |\Psi_\theta^a(r, \theta, (\varepsilon, \varepsilon^2, \mu)) - \Psi_\theta^a(r, \theta, (\varepsilon, \varepsilon^2, 0))|_{\mathcal{C}^k} &\leq \left(\frac{a^2}{\varepsilon^{k+2}} + \frac{\mu}{\varepsilon^{k+1}}\right) M. \end{aligned}$$

Proof. To compute an upper bound of $\left| \Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a \right|_{\mathcal{C}^k}$, we firstly wanted to use an upper bound of $\partial_\mu \Psi_{(\varepsilon, \varepsilon^2, \mu)}^a$ together with the Mean Value Theorem. Unfortunately, $\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a$ is not smooth with respect to μ because of

$$\tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a) = \frac{\omega(\varepsilon)}{\varepsilon^2} r^2 - H(P_{(\varepsilon, \varepsilon^2, \mu)}^a, (\varepsilon, \varepsilon^2, \mu)),$$

Indeed, $P_{\underline{\varepsilon}}^a$ is defined as $P_{\underline{\varepsilon}}^a := \mathcal{F}_{\underline{\varepsilon}}(\mathcal{C}^a)$ and $\mathcal{F}_{\underline{\varepsilon}} = \mathcal{F}_{(\varepsilon, \varepsilon, \mu)}$ is not smooth with respect to μ . So in the following we are going to use ∂_μ together with the Mean Value Theorem as soon as it is possible, and we will complete by a use of ∂_h together with an upper bound of $|\tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a) - \tilde{h}_{(\varepsilon, \varepsilon^2, 0)}(r^2, a)|$.

From Lemma 5.3, for $a < a_0$ and ε, μ sufficiently small we get the upper bound

$$\begin{aligned} |\tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a) - \tilde{h}_{(\varepsilon, \varepsilon^2, 0)}(r^2, a)| &= \left| H(P_{(\varepsilon, \varepsilon^2, 0)}^a, (\varepsilon, \varepsilon^2, 0)) - H(P_{(\varepsilon, \varepsilon^2, \mu)}^a, (\varepsilon, \varepsilon^2, \mu)) \right| \\ &\leq \mathcal{M}_0 a^2. \end{aligned}$$

On one hand, recall that from the definitions of Ψ^a (p.32) and from the form (35) of $p_{1, \underline{\varepsilon}}^H$, Ψ_r^a reads

$$\begin{aligned} \Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, \mu)) &= \Psi_r \left(\tilde{p}_1^H(r \cos \theta, r \sin \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)), r \cos \theta, r \sin \theta, (\varepsilon, \varepsilon^2, \mu) \right) \\ &:= \tilde{\Psi}_r^a(r, \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)) \end{aligned}$$

where Ψ_r and \tilde{p}_1^H belong to $\mathcal{C}^1(\cdot) - \varepsilon_0, \varepsilon_0[{}^3, \mathcal{C}^{k_0})$ and thus so is the new function $\tilde{\Psi}_r^a$ for $r^2 \in [c_1 \delta^2 \varepsilon^2, c_2 \delta^2 \varepsilon^2]$ and $a \leq c_0 \delta^2 \varepsilon^2$. Recall also that Lemma 6.4 ensures that $\tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}$ is bounded on this domain. Then we get that for any $j + \ell \leq k_0$,

$$\begin{aligned} &\left| \partial_r^j \partial_\theta^\ell \tilde{\Psi}_r^a(r, \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)) - \partial_r^j \partial_\theta^\ell \tilde{\Psi}_r^a(r, \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, 0)) \right| \\ &\leq \sup_{\substack{r^2 \in [c_1 \delta^2 \varepsilon^2, c_2 \delta^2 \varepsilon^2] \\ h \in [c_1 \delta^2, c_2 \delta^2]}} \left| \partial_h \left(\partial_r^j \partial_\theta^\ell \tilde{\Psi}_r^a(r, \theta, h, (\varepsilon, \varepsilon^2, \mu)) \right) \right| |\tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a) - \tilde{h}_{(\varepsilon, \varepsilon^2, 0)}(r^2, a)| \\ &\quad + \sup_{\substack{r^2 \in [c_1 \delta^2 \varepsilon^2, c_2 \delta^2 \varepsilon^2] \\ h \in [c_1 \delta^2, c_2 \delta^2]}} \left| \partial_\mu \left(\partial_r^j \partial_\theta^\ell \tilde{\Psi}_r^a(r, \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, 0)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)) \right) \right| \cdot \mu. \end{aligned}$$

And given that $|\partial_r^i \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a)| \leq \frac{M}{\varepsilon^i}$ (see the proof of Lemma 6.2), we obtain

$$\left| \Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, \mu)) - \Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, 0)) \right|_{\mathcal{C}^k} \leq \left(a^2 + \frac{\mu}{\varepsilon^k} \right) M.$$

On the other hand, recall that $\Psi_\theta^a(r, \theta, (\varepsilon, \varepsilon^2, \mu))$ reads

$$\begin{aligned} &\frac{\omega(\varepsilon)}{2\varepsilon^2} T(\tilde{p}_1^H(r \cos \theta, r \sin \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)), q_2, p_2, (\varepsilon, \varepsilon^2, \mu)) \\ &\quad + \tilde{\phi}_\theta(T(\tilde{p}_1^H(r \cos \theta, r \sin \theta, \tilde{h}_{(\varepsilon, \varepsilon^2, \mu)}(r^2, a), (\varepsilon, \varepsilon^2, \mu)), \\ &\quad \quad \quad q_2, p_2, (\varepsilon, \varepsilon^2, \mu)), (\delta, p_1, q_2, p_2), (\varepsilon, \varepsilon^2, \mu)) \end{aligned}$$

where T and \tilde{p}_1^H belong to $\mathcal{C}^1(\cdot) - \varepsilon_0, \varepsilon_0[{}^3, \mathcal{C}^{k_0})$. From Lemma 6.6 and given that $\tilde{\phi}_{q_2, p_2}$ belongs \mathcal{C}^{k_0} , with the same computations as that of the upper bounds of

$\Psi_r^a(r, \theta, (\varepsilon, \varepsilon^2, \mu))$, we get

$$\begin{aligned} |\Psi_\theta^a(r, \theta, (\varepsilon, \varepsilon^2, \mu)) - \Psi_\theta^a(r, \theta, (\varepsilon, \varepsilon^2, 0))|_{C^k} &\leq \frac{M}{\varepsilon} \left(a^2 + \frac{\mu}{\varepsilon^k} \right) + \frac{M}{\sqrt{\nu}^k} \left(a^2 + \frac{\mu}{\varepsilon^k} \right), \\ &\leq M' \left(\frac{a^2}{\varepsilon^{k+2}} + \frac{\mu}{\varepsilon^{2k+2}} \right). \end{aligned}$$

□

6.3. Change of coordinates, proof of (ii), (iii) and (iv) of Proposition 2.9.

Change of coordinates. Denoting by $[\frac{1}{\varepsilon^2}]$ the integer part of $\frac{1}{\varepsilon^2}$, let us define

$$\bar{\varepsilon} := \frac{1}{[\frac{1}{\varepsilon^2}]}, \quad (52)$$

and perform the following change of coordinates.

$$(\theta, r) := \left(\frac{1}{\bar{\varepsilon}} q, \sqrt{\bar{\varepsilon}} \rho \right), \quad q \in \mathbb{R}/2\pi\mathbb{Z}, \rho^2 \in \frac{\varepsilon^2}{\bar{\varepsilon}} [c_1 \delta^2, c_1 \delta^2].$$

Observe that $1 - \varepsilon^2 \leq \frac{\varepsilon^2}{\bar{\varepsilon}} \leq 1$. Let us denote by $\hat{\Psi}_{\bar{\varepsilon}}^a$ the map $\Psi_{\bar{\varepsilon}}^a$ expressed in those new coordinates. Thus $\hat{\Psi}_{\bar{\varepsilon}}^a$ is defined for $\rho^2 \in [c_1 \delta^2, (1 - \varepsilon^2) c_2 \delta^2]$, i.e. for ε sufficiently small $\hat{\Psi}_{\bar{\varepsilon}}^a$ is defined on a set $\rho^2 \in [c_1 \delta^2, d_1 \delta^2]$ independent of ε . $\hat{\Psi}_{\bar{\varepsilon}}^a$ reads

$$\begin{aligned} \hat{\Psi}_{(\varepsilon, \varepsilon^2, \mu)}^a(q, \rho) &= \left(q + \bar{\varepsilon} \Theta(\sqrt{\bar{\varepsilon}} \rho, a, \varepsilon) + \bar{\varepsilon} (\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a)_{\theta} \left(\frac{1}{\bar{\varepsilon}} q, \sqrt{\bar{\varepsilon}} \rho \right), \right. \\ &\quad \left. \rho + \frac{1}{\sqrt{\bar{\varepsilon}}} (\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a)_{\rho} \left(\frac{1}{\bar{\varepsilon}} q, \sqrt{\bar{\varepsilon}} \rho \right) \right), \\ &:= \left(q + \alpha_{\bar{\varepsilon}}^a(q, \rho) + F_{(\varepsilon, \varepsilon^2, \mu)}^a(q, \rho), r + G_{(\varepsilon, \varepsilon^2, \mu)}^a(q, \rho) \right). \end{aligned} \quad (53)$$

Proof of (ii) of Proposition 2.9.

$$\partial_{\rho} \alpha_{\bar{\varepsilon}}^a = \bar{\varepsilon} \sqrt{\bar{\varepsilon}} \partial_r \Theta(\sqrt{\bar{\varepsilon}} \rho, a, \varepsilon).$$

From Lemma 6.5 and the definition of d_1 , we get that for $\rho^2 \in [c_1 \delta^2, d_1 \delta^2]$,

$$-\frac{M}{\varepsilon^3} \bar{\varepsilon} \sqrt{\bar{\varepsilon}} \leq \frac{\partial \alpha_{\bar{\varepsilon}}^a}{\partial \rho} \leq -\frac{m}{\varepsilon^3} \bar{\varepsilon} \sqrt{\bar{\varepsilon}}.$$

Observe that from the definition (52) of $\bar{\varepsilon}$, we get that $1 \leq \frac{\bar{\varepsilon}}{\varepsilon^2} \leq 2$ if $\varepsilon^2 \leq \frac{1}{2}$. We then obtain

$$-2\sqrt{2}M \leq \frac{\partial \alpha_{\bar{\varepsilon}}^a}{\partial \rho} \leq -m;$$

so (ii) holds with $m_0 = \max(2\sqrt{2}M, \frac{1}{m})$.

Proof of (iii) of Proposition 2.9. Given that if $\rho^2 \in [c_1 \delta^2, d_1 \delta^2]$ then $r^2 \in [c_1 \delta^2 \varepsilon^2, c_2 \delta^2 \varepsilon^2]$, Lemma 6.2 ensures that for $k \leq k_0$,

$$\left| \frac{\partial^k \alpha_{\bar{\varepsilon}}^a}{\partial \rho^k}(q, \rho) \right| = \left| \bar{\varepsilon} \sqrt{\bar{\varepsilon}}^k \frac{\partial \Theta}{\partial r}(\sqrt{\bar{\varepsilon}} \rho, a, \varepsilon) \right| \leq \bar{\varepsilon} \sqrt{\bar{\varepsilon}}^k \frac{M}{\varepsilon^{k+2}} \leq \sqrt{2}^k M \quad \text{for } \varepsilon \leq \frac{1}{2}.$$

Proof of (iv) of Proposition 2.9. Lemma 6.7 ensures that for $i + j \leq k \leq k_0$,

$$\begin{aligned} \left| \partial_q^i \partial_\rho^j F_{(\varepsilon, \varepsilon^2, \mu)}^a(q, \rho) \right| &= \varepsilon \frac{\sqrt{\varepsilon}^j}{\varepsilon^i} \left| \partial_\theta^i \partial_r^j (\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a)_{\theta} \left(\frac{1}{\varepsilon} q, \sqrt{\varepsilon} \rho \right) \right|, \\ &\leq \varepsilon \frac{\sqrt{\varepsilon}^j}{\varepsilon^i} M \cdot \left(\frac{a^2}{\varepsilon^{i+j+2}} + \frac{\mu}{\varepsilon^{2(i+j+1)}} \right) \leq M \cdot \left(\frac{a^2}{\varepsilon^{3k}} + \frac{\mu}{\varepsilon^{6k}} \right); \end{aligned}$$

and

$$\begin{aligned} \left| \partial_q^i \partial_\rho^j G_{(\varepsilon, \varepsilon^2, \mu)}^a(q, \rho) \right| &= \varepsilon \frac{\sqrt{\varepsilon}^j}{\varepsilon^i} \left| \partial_\theta^i \partial_r^j (\Psi_{(\varepsilon, \varepsilon^2, \mu)}^a - \Psi_{(\varepsilon, \varepsilon^2, 0)}^a)_r \left(\frac{1}{\varepsilon} q, \sqrt{\varepsilon} \rho \right) \right|, \\ &\leq \varepsilon \frac{\sqrt{\varepsilon}^j}{\varepsilon^i} M \cdot \left(a^2 + \frac{\mu}{\varepsilon^{i+j}} \right) \leq M \cdot \left(\frac{a^2}{\varepsilon^{2k-2}} + \frac{\mu}{\varepsilon^{6k-4}} \right). \end{aligned}$$

So finally, for $0 \leq k \leq k_0 - 1$,

$$\left| F_{(\varepsilon, \varepsilon^2, \mu)}^a \right|_{\mathcal{C}^k} + \left| G_{(\varepsilon, \varepsilon^2, \mu)}^a \right|_{\mathcal{C}^k} \leq M \cdot \left(\frac{a^2}{\varepsilon^{3k}} + \frac{\mu}{\varepsilon^{6k}} \right).$$

□

6.4. Proof of (i) of Proposition 2.9: The $\hat{\Psi}^a$ are exact maps. We first prove that the $\hat{\Psi}^a$ are area-preserving maps (Lemma 6.8), and then that for every $\hat{\Psi}^a$ there exist some Jordan curves intersecting their range through $\hat{\Psi}^a$ (Lemma 6.9). These two results together ensures that (i) of Proposition 2.9 holds.

Lemma 6.8. $\hat{\Psi}_{\underline{\varepsilon}}^a$ is an area-preserving map.

Proof. $\Psi_{\underline{\varepsilon}}^a$ is symplectic given that it is a first return map associated to a Hamiltonian flow. Moreover, we verify that the change of coordinates

$$\varphi : (\rho, q) \mapsto (\sqrt{\varepsilon} \rho, \frac{1}{\varepsilon} q)$$

is symplectic. Then $\hat{\Psi}_{\underline{\varepsilon}}^a$ is symplectic and thus area-preserving. □

Lemma 6.9. We fix $\Delta > 0$.

For $\underline{\varepsilon}$ sufficiently small with respect to Δ , every Jordan curve \mathcal{C} in the set

$$\{(q, \rho) / \rho^2 \in [c_1' \delta^2, d_1 \delta^2]\}$$

and of the form

$$\mathcal{C} = \{(q, \rho), \rho = f(q)\} \quad \text{with for all } q \in \mathbb{R}/2\pi\mathbb{Z}, |f'(q)| \leq \Delta,$$

intersects its range $\hat{\Psi}_{\underline{\varepsilon}}^a(\mathcal{C})$.

Proof of an upper bound for the map $\Psi_{\underline{\varepsilon}}^a$. Firstly, we prove that there exists a constant M'' such that the upper bound

$$\left| (\hat{\Psi}_{\underline{\varepsilon}}^a)_\rho(q, \rho) - \rho \right| \leq M'' \mu \varepsilon^{N_0} \quad (54)$$

holds in the domain $\{(q, \rho) / \rho^2 \in [c_1 \delta^2, d_1 \delta^2]\}$. For that purpose, we use two results:

- 1 in the coordinates (q_2, p_2) , there exists M such that on the domain $\mathcal{B}(0, \rho_0)$ the flow of $H(\cdot, (\varepsilon, \varepsilon^2, \mu))$ satisfies

$$\left| \frac{d(q_2^2 + p_2^2)}{dt} \right| \leq M \mu \varepsilon^{N_0+2};$$

2. on the domain $\{(\theta, r)/r^2 \in [c_1\delta^2\varepsilon^2, c_2\delta^2\varepsilon^2]\}$ the time T of first return to Σ_1 is bounded: this is the consequence of the C^k -smoothness of $T(p_1, q_1, p_2, \varepsilon)$ together with the fact that p_1^H is bounded on this domain thank to (48) of Lemma 6.5.

From (i) and (ii) we derive that

$$\begin{aligned} \left| (\Psi_{\varepsilon}^a)_{q_2}(q_2, p_2, a)^2 + (\Psi_{\varepsilon}^a)_{p_2}(q_2, p_2, a)^2 - (q_2^2 + p_2^2) \right| &\leq M\mu\varepsilon^{N_0+2}(\text{Sup}|T|) \\ &\leq M'\mu\varepsilon^{N_0+1}. \end{aligned}$$

Thus in polar coordinates we get

$$\begin{aligned} \left| (\Psi_{\varepsilon}^a)_r(r, \theta, a)^2 - r^2 \right| &\leq M'\mu\varepsilon^{N_0+2}. \\ \Leftrightarrow \left| (\Psi_{\varepsilon}^a)_r(r, \theta, a) - r \right| \left| (\Psi_{\varepsilon}^a)_r(r, \theta, a) + r \right| &\leq M'\mu\varepsilon^{N_0+2}. \\ \Rightarrow \left| (\Psi_{\varepsilon}^a)_r(r, \theta, a) - r \right| &\leq M''\mu\varepsilon^{N_0+1} \quad \text{given that } r \geq \sqrt{c_1}\delta\varepsilon. \end{aligned}$$

Which, in coordinates (q, ρ) reads

$$\left| (\Psi_{\varepsilon}^a)_r(r, \theta, a) - r \right| = \left| (\Psi_{\varepsilon}^a)_{\rho}\left(\frac{1}{\varepsilon}q, \sqrt{\varepsilon}\rho\right) - \sqrt{\varepsilon}\rho \right| = \left| \sqrt{\varepsilon}(\hat{\Psi}_{\varepsilon}^a)_r(q, \rho) - \sqrt{\varepsilon}\rho \right|.$$

This completes the proof of (54).

Proof of Lemma 6.9. Consider a curve \mathcal{C} as described in the statement of the Lemma. From (54) we get that $\hat{\Psi}_{\varepsilon}^a(\mathcal{C})$ is in the tube

$$\{(q, \rho), \rho \in [f(q) - M''\mu\varepsilon^{N_0}, f(q) + M''\mu\varepsilon^{N_0}]\}$$

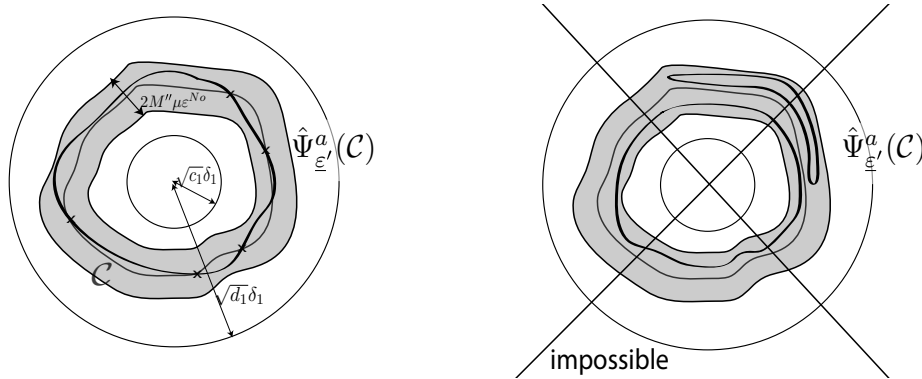


FIGURE 11. Range of \mathcal{C} through $\hat{\Psi}_{\varepsilon}^a$.

(see Figure 11) whose area admits the upper bound $2M''\mu\varepsilon^{N_0} \cdot (\text{length of the curve } \mathcal{C})$. Where the length of \mathcal{C} reads

$$\int_0^{2\pi} \sqrt{f'(q)^2 + f(q)^2} dq \leq 2\pi(\Delta + \sqrt{d_1}).$$

Suppose that $\hat{\Psi}_{\varepsilon}^a(\mathcal{C}) \cap \mathcal{C} = \emptyset$ holds. Given that \mathcal{C} is a Jordan curve, so is $\hat{\Psi}_{\varepsilon}^a(\mathcal{C})$, and then their inside and outside sets are well-defined. From Lemma 6.8 we get that their inside sets have the same area, and thus necessarily $\hat{\Psi}_{\varepsilon}^a(\mathcal{C})$ is in the outside

set of \mathcal{C} . Then $\hat{\Psi}_{\varepsilon}^a(\mathcal{C})$ is in the tube $\{(q, \rho), \rho \in [f(q), f(q) + M''\mu\varepsilon^{N_0}]\}$, and so is its inside set whose area is greater than πc_1 .

So for μ, ε sufficiently small with respect to c_1, d_1 and Δ the area of the tube is lower than the area of the curve $\hat{\Psi}_{\varepsilon}^a(\mathcal{C})$, so that necessarily $\hat{\Psi}_{\varepsilon}^a(\mathcal{C}) \cap \mathcal{C} \neq \emptyset$ is impossible. \square

A. Appendix. Proof of Theorem 1.3. This appendix is devoted to the proof of Theorem 1.3 used in Part 3. We thank Gérard Iooss who suggested us this version of the Normal Form Theorem and the main ideas of its proof. We denote by E_ℓ the finite dimensional vector space of homogeneous polynomials of degree ℓ on \mathbb{R}^{2m} . We denote by $F_\ell \subset E_\ell$ the subspace of homogeneous polynomial satisfying (1). So F_ℓ is the space of polynomials appearing in the normal form.

The property of the space F_ℓ that is used in the proof is that F_ℓ is a supplement of the image of the linear operator

$$S \mapsto \{\mathcal{H}_{2,0}, S\}$$

from E_ℓ to itself, which is called the Homological operator. This will be established below in step 3. Any other supplement could be used as well, and the choice made in Theorem 1.3 is not canonical.

Proof. We begin with a summary of the strategy of proof.

Strategy of proof. We perform the proof by induction on $\ell \geq 2$. We set $\phi_{1,\lambda} = Id$ and construct a \mathcal{C}^1 family of local analytic symplectic diffeomorphisms $\phi_{\ell,\lambda} = \phi_{\ell-1,\lambda} \circ \varphi_{\ell,\lambda}$ for each $\ell \geq 2$, where $\varphi_{\ell,\lambda}$ as the Lie transform (the time one Hamiltonian flow) of a homogeneous polynomial $S_{\ell,\lambda}$ of degree ℓ whose coefficients are \mathcal{C}^1 functions of λ . In view of step 2.1 below, such a homogeneous Hamiltonian generates a Lie transform $\varphi_{\ell,\lambda}$ which is a \mathcal{C}^1 family of local analytic symplectic diffeomorphisms. Assume that, for some $\ell \leq k$,

$$\mathcal{H}_\lambda \circ \phi_{\ell-1,\lambda} = \mathcal{H}_{2,0} + \mathcal{N}_{\ell-1,\lambda} + \mathcal{R}_{\ell-1,\lambda}$$

where $\mathcal{N}_{\ell-1,\lambda}$ is a polynomial of degree at most $\ell-1$ of the form (1) and whose coefficients are \mathcal{C}^1 functions of λ , and where $\mathcal{R}_{\ell-1,\lambda} = o(|x|^{\ell-1})$. Then $\mathcal{R}_{\ell-1,\lambda}$ is a \mathcal{C}^1 family of \mathcal{C}^k Hamiltonians hence there exists a \mathcal{C}^1 curve $P_{\ell,\lambda}$ in E_ℓ such that $\mathcal{R}_{\ell-1,\lambda} = P_{\ell,\lambda} + \mathcal{R}_{\ell,\lambda}$, with $\mathcal{R}_{\ell,\lambda} = o(|x|^\ell)$. The iterative step consists in finding a Hamiltonian $S_{\ell,\lambda}$ which is a homogeneous polynomial of degree ℓ whose coefficients are \mathcal{C}^1 functions of λ in such a way that the corresponding Lie transform $\varphi_{\ell,\lambda}$ satisfies the equation

$$\mathcal{H}_\lambda \circ \phi_{\ell-1,\lambda} \circ \varphi_{\ell,\lambda} = \mathcal{H}_{2,0} + \mathcal{N}_{\ell-1,\lambda} + N_{\ell,\lambda} + \mathcal{R}_{\ell,\lambda}, \quad (55)$$

with $N_{\ell,\lambda} \in F_\ell$ and $\mathcal{R}_{\ell,\lambda} = o(|x|^\ell)$. We then define $\mathcal{N}_{\ell,\lambda} := \mathcal{N}_{\ell-1,\lambda} + N_{\ell,\lambda}$.

The case $\ell = 2$, which is just a problem of deformations of linear systems, is a bit specific, we detail it in **Step 1** below. We then study in **Step 2.1** how a \mathcal{C}^1 family of homogeneous Hamiltonians of degree $\ell \geq 3$ generates a \mathcal{C}^1 family of analytic Lie transforms. This allows to solve the iterative equation in degree $\ell \geq 3$ in **Step 2.2**: We prove the existence of \mathcal{C}^1 curves $N_{\ell,\lambda}$ and $S_{\ell,\lambda}$ in F_ℓ and E_ℓ satisfying (55). The equations for $\ell = 2$ and $\ell \geq 3$ involve the same linear operator $S \mapsto \{\mathcal{H}_{2,0}, S\}$ on E_ℓ , called the homologic operator. We study this operator in **Step 3**, where we prove that F_ℓ as defined by (1) is a complementary space of its image. This property is used in **Step 1** and **Step 2.2**.

Step 1. Normalization at order 2. The initial Hamiltonian \mathcal{H}_λ reads

$$\mathcal{H}_\lambda = \mathcal{H}_{2,\lambda} + R_{2,\lambda} = \mathcal{H}_{2,0} + P_{2,\lambda} + R_{2,\lambda},$$

where $P_{2,\lambda}$ is a homogenous polynomial of degree 2 whose coefficients are C^1 functions of λ verifying $P_{2,0} \equiv 0$, and $R_{2,\lambda} = o(|x|^2)$.

We consider a family of linear symplectic diffeomorphisms $\varphi_{2,\lambda}$ obtained (for each λ) as the time one Hamiltonian flow of a family quadratic Hamiltonians $S_{2,\lambda}$. The gradient $\nabla S_{2,\ell}$ is a linear map, that we identify with its matrix (whose coefficients are C^1 functions of λ) so that

$$S_{2,\lambda}(x) = \frac{1}{2} \langle \nabla S_{2,\lambda} x, x \rangle$$

and

$$\varphi_{2,\lambda} = \exp(J\nabla S_{2,\lambda}),$$

which is a matrix whose coefficients are C^1 functions of λ . By keeping only the quadratic term in (55), we obtain the equation

$$(\mathcal{H}_{2,0} + P_{2,\lambda}) \circ \exp(J\nabla S_{2,\lambda}) = \mathcal{H}_{2,0} + N_{2,\lambda}. \quad (56)$$

Note in this expression that the composition \circ is not a product of linear maps, but the composition of a quadratic form with a linear map. We rewrite this equation as

$$N_{2,\lambda} - \mathcal{F}_2(P_{2,\lambda}, S_{2,\lambda}) = 0, \quad (56)$$

where $\mathcal{F}_2 : E_2 \times E_2 \rightarrow E_2$ is the analytic map given by

$$\mathcal{F}_2(P, S) = (\mathcal{H}_{2,0} + P) \circ \exp(J\nabla S) - \mathcal{H}_{2,0}.$$

The map $S \mapsto \nabla S$ is just the isomorphism which to a quadratic form associates its matrix times two. The map \mathcal{F}_2 satisfies

$$\mathcal{F}_2(0, 0) = 0, \quad \partial_P \mathcal{F}_2(0, 0) \cdot P = P, \quad \partial_S \mathcal{F}_2(0, 0) \cdot S = \{\mathcal{H}_{2,0}, S\}.$$

To compute the last derivative, just observe that

$$\partial_S \mathcal{F}_2(0, 0) \cdot S(x) = \partial_t (\mathcal{H}_{2,0} \circ e^{J\nabla t S})(x) = \partial_t (\mathcal{H}_{2,0} \circ e^{tJ\nabla S}(x)) = \{\mathcal{H}_{2,0}, S\}(x),$$

where the time derivatives are taken at $t = 0$.

Let F_2 be a complementary space of the image of the linear map $S \mapsto \{\mathcal{H}_{2,0}, S\}$ on E_2 , and let G_2 be a complementary space of its kernel. We will see in step 3 that we can take for F_2 the space of quadratic Hamiltonians satisfying (1). The map

$$(N, S) \mapsto N - \partial_S \mathcal{F}_2(0, 0) \cdot S$$

is an isomorphism from $G_2 \times F_2$ to E_2 . By the implicit function theorem, the equation

$$N - \mathcal{F}_2(P, S) = 0$$

can thus be solved by $(N(P), S(P)) \in F_2 \times G_2$ for each small $P \in E_2$. Moreover the map $P \mapsto (N(P), S(P))$ is analytic near the origin. We now set

$$N_{2,\lambda} = N(P_{2,\lambda}), \quad S_{2,\lambda} = S(P_{2,\lambda}).$$

These matrices are C^1 functions of λ , and they solve (56).

Step 2.1. Lie transform. Each element $S \in E_\ell, \ell \geq 3$ generates a Lie transform φ_S which is an analytic local symplectic diffeomorphism of \mathbb{R}^{2m} satisfying

$$\varphi_S(x) = x + J\nabla S(x) + \mathcal{O}(|x|^\ell). \quad (57)$$

For each bounded open set $B_\ell \subset E_\ell$, there exists $\rho > 0$ such that the map $S \mapsto \varphi_S$ is C^1 on B_ℓ with values in $\mathcal{A}(\mathcal{B}_{\mathbb{R}^{2m}}(0, \rho), \mathbb{R}^{2m})$.

As a consequence of (57), given a Hamiltonian $H \in E_i$, we have

$$H \circ \varphi_S = H + \{H, S\} + \mathcal{O}(|x|^{i+\ell-1}). \quad (58)$$

To prove that the map $S \mapsto \varphi_S$ is \mathcal{C}^1 we first consider the differential equation

$$\partial_t \psi_{tS} = J \nabla S \circ \psi_{tS}$$

with initial data $\psi_{0S} = Id$ on the Banach space $\mathcal{A}(\mathcal{B}_{\mathbb{R}^{2m}}(0, 1), \mathbb{R}^{2m})$. The map $(S, \psi) \mapsto J \nabla S \circ \psi$ is \mathcal{C}^1 . Considering S as a parameter, we apply the Cauchy-Lipschitz Theorem and obtain the existence of a solution $(t, S) \mapsto \psi_{tS} = \psi(t, S)$ which is \mathcal{C}^1 on $] -T, T[\times U_\ell$ for some $T > 0$ and some neighborhood U_ℓ of the origin in E_ℓ .

Let us now consider, for $\rho > 0$, the homothety $\theta : x \mapsto x/\rho$ of \mathbb{R}^{2m} . The map $\psi \mapsto \psi \circ \theta$ is a linear isometry between $\mathcal{A}(\mathcal{B}_{\mathbb{R}^{2m}}(0, 1), \mathbb{R}^{2m})$ and $\mathcal{A}(\mathcal{B}_{\mathbb{R}^{2m}}(0, \rho), \mathbb{R}^{2m})$. The map

$$(t, S) \mapsto \varphi_{tS} := \rho \psi(\rho^{(\ell-2)/2} t, \rho^{(\ell-2)/2} S) \circ \theta = \rho \psi_{\rho^{\ell-2} t S} \circ \theta$$

is defined on $] -\rho^{1-\ell/2} T, \rho^{1-\ell/2} T[\times \rho^{1-\ell/2} U$. We observe that $\varphi_{0S} = Id$, and that

$$\partial_t \varphi_{tS} = \rho^{(\ell-2)/2} \partial_t \psi(\rho^{(\ell-2)/2} t, \rho^{(\ell-2)/2} S) \circ \theta = \rho^{\ell-1} J \nabla S \circ \psi_{\rho^{\ell-2} t S} \circ \theta = J \nabla S \circ \varphi_{tS}$$

since ∇S is homogeneous of degree $\ell - 1$. As a consequence φ_{tS} is the time t Hamiltonian flow of S . If ρ is chosen small enough, then the map $(t, S) \mapsto \varphi_{tS}$ is defined and \mathcal{C}^1 on $] -2, 2[\times B_\ell$, hence the map $S \mapsto \varphi_S$ is a \mathcal{C}^1 on B_ℓ , with values in $\mathcal{A}(\mathcal{B}_{\mathbb{R}^{2m}}(0, \rho), \mathbb{R}^{2m})$.

Step 1.2. Equation at order $\ell \geq 3$. We are assuming that

$$\mathcal{H}_\lambda \circ \phi_{\ell-1, \lambda} = \mathcal{H}_{2,0} + \mathcal{N}_{\ell-1, \lambda} + P_{\ell-1, \lambda} + R_{\ell, \lambda}$$

In view of (58), we get that

$$\mathcal{H}_\lambda \circ \phi_{\ell-1, \lambda} \circ \varphi_{\ell, \lambda} = \mathcal{H}_{2,0} + \mathcal{N}_{\ell-1, \lambda} + P_{\ell, \lambda} + \{\mathcal{H}_{2,0} + N_{2, \lambda}, S_{\ell, \lambda}\} + o(|x|^\ell).$$

By keeping only the terms of order ℓ in (55), we get the equation

$$N_{\ell, \lambda} - \{\mathcal{H}_{2,0} + N_{2, \lambda}, S_{\ell, \lambda}\} = P_{\ell, \lambda}. \quad (59)$$

We write this equation under the form

$$N_{\ell, \lambda} - \mathcal{F}_\ell(\lambda, S_{\ell, \lambda}) = 0,$$

with $\mathcal{F}_\ell(\lambda, S) = \{\mathcal{H}_{2,0} + N_{2, \lambda}, S\} + P_{\ell, \lambda}$. Obviously, $\partial_S \mathcal{F}_\ell(0, 0) \cdot S = \{\mathcal{H}_{2,0}, S\}$.

Let F_ℓ be a complementary space of the image of the linear map $S \mapsto \{\mathcal{H}_{2,0}, S\}$ on E_ℓ , and let G_ℓ be a complementary space of its kernel. We will see in step 3 that we can take for F_ℓ the space of quadratic Hamiltonians satisfying (1). By the implicit function theorem, the equation

$$N - \mathcal{F}_\ell(\lambda, S) = 0$$

has a unique small solution $(N_{\ell, \lambda}, S_{\ell, \lambda})$ in $F_\ell \times G_\ell$, which is a \mathcal{C}^1 function of λ near $\lambda = 0$. Then, the Lie transform $\varphi_{\ell, \lambda}$ of $S_{\ell, \lambda}$ is a \mathcal{C}^1 family of local analytic diffeomorphisms which solves (55).

Step 3. Study of the homological operator. We have used above that F_ℓ , as defined by (1), complements the image of the homological operator

$$\mathcal{A} : S \mapsto \{\mathcal{H}_{2,0}, S\}$$

in E_ℓ . Any other complementary space could be used as well, but the relatively simple definition of F_ℓ makes it a good choice. In many situation, the kernel

$$K_\ell := \{N \in E_\ell \mid N \circ e^{tL_0} = N \ \forall t\}$$

of the homological operator turns out to also complement its image. The normal form can then be obtained in this space. In the case of Birkhoff normal forms, we have $F_\ell = K_\ell$. In the case of interest in the present paper, however, it is not possible to reduce the system to a normal form in K_ℓ .

Let us now prove that F_ℓ is always a complementary space of the image of the homological operator. For that purpose we define, for any pairs of polynomials $S, S' : \mathbb{R}^{2m} \rightarrow \mathbb{R}$ lying in E_ℓ the inner product given by

$$\langle S, S' \rangle_\ell = S(\partial_x) \cdot S'|_{x=0}.$$

For multi-indices $\alpha_1, \dots, \alpha_{2m}$ and $\beta_1, \dots, \beta_{2m}$, we have

$$\left\langle x_1^{\alpha_1} \dots x_{2m}^{\alpha_{2m}}, x_1^{\beta_1} \dots x_{2m}^{\beta_{2m}} \right\rangle_\ell = \alpha_1! \dots \alpha_{2m}! \delta_{\alpha_1, \beta_1} \dots \delta_{\alpha_{2m}, \beta_{2m}}$$

where $\delta_{\alpha_j, \beta_j} = 1$ if $\alpha_j = \beta_j$ and 0 otherwise. The product $\langle \cdot, \cdot \rangle_\ell$ thus defines an Euclidean structure on E_ℓ , and the standard base of E_ℓ is orthogonal for this structure. Let us set

$$\mathcal{H}_{2,0}^* := -\mathcal{H}_{2,0} \circ J,$$

in such a way that $L_0^* = (J\nabla\mathcal{H}_{2,0})^* = J\nabla\mathcal{H}_{2,0}^*$.

We claim that the adjoint of the homological operator \mathcal{A} is $\mathcal{A}^*(S) = \{\mathcal{H}_{2,0}^*, S\}$. This implies that $F_\ell = \text{Ker } \mathcal{A}^*$, and then that F_ℓ complements the image of \mathcal{A} , which is what we wanted to prove.

Let us finally prove the claim. For each linear map T of \mathbb{R}^{2m} , each index i , and each smooth function f on \mathbb{R}^{2m} , we have

$$S(\partial_x) \cdot (f \circ T) = (S \circ T^*(\partial_x) \cdot f) \circ T$$

as can be proved by induction on the degree ℓ of S . Here T^* is the adjoint of T for the standard Euclidean structure on \mathbb{R}^{2m} . We deduce that

$$\langle S \circ T, S' \rangle_\ell = \langle S, S' \circ T^* \rangle_\ell$$

for each S and S' in E_ℓ . We now compute

$$\begin{aligned} \langle \mathcal{A}^* S, S' \rangle &= \langle \mathcal{A} S', S \rangle = \langle \partial_t(S' \circ e^{tL_0})|_{t=0}, S \rangle = \partial_t \left\langle S' \circ e^{tL_0^*}, S \right\rangle_{|t=0} \\ &= \partial_t \left\langle S \circ e^{tL_0^*}, S' \right\rangle_{|t=0} = \left\langle \partial_t(S \circ e^{tL_0^*}), S' \right\rangle_{|t=0} = \langle \{\mathcal{H}_{2,0}^*, S\}, S' \rangle, \end{aligned}$$

which proves the claim. \square

B. Appendix. Definition of \prec and technical lemmas. In this appendix we define the relation \prec on the set of formal power series, and state a few properties of this relation. The proofs are left to the reader (the complete proofs are in the Appendix B of [15]).

Definition B.1. Let f and g be two formal power series on \mathbb{C} , with d variables. We denote them

$$f(x_1, \dots, x_d) = \sum_{n \in \mathbb{N}^d} a_n x_1^{n_1} \dots x_d^{n_d} := \sum_{n \in \mathbb{N}^d} a_n x^n, \quad g(x_1, \dots, x_d) = \sum_{n \in \mathbb{N}^d} b_n x^n.$$

We define \prec by $f(x_1, \dots, x_d) \prec g(x_1, \dots, x_d)$ if and only if

$$\forall n \in \mathbb{N}^d, \quad b_n \in \mathbb{R}^+ \quad \text{and} \quad |a_n| \leq b_n.$$

We define also

$$\begin{aligned} |f|(x) &:= \sum_{n \in \mathbb{N}^d} |a_n| x^n, \\ \max_{\prec} \{f, g\}(x) &:= \sum_{n \in \mathbb{N}^d} \max\{|a_n|, |b_n|\} x^n. \end{aligned}$$

Lemma B.2. *Let f and g be two formal power series from \mathbb{C}^d to \mathbb{C} .*

1. $f \prec g$ if and only if $|f| \prec g$.
2. If $f \prec g$ then

$$\forall i \leq d, \quad \partial_{x_i} f \prec \partial_{x_i} g.$$

3. Let $d' < d$ and $y = (y_1, \dots, y_{d'})$. Consider f and g for

$$x = (x_1, \dots, x_d) = (y_1, y_1, \dots, y_1, \dots, y_{d'}, \dots, y_{d'}),$$

that we denote $\tilde{f}(y)$ and $\tilde{g}(y)$. Then

$$f(x) \prec g(x) \Rightarrow \tilde{f}(y) \prec \tilde{g}(y).$$

4. When $d = 1$. If f is a convergent power series of order n_0 , then there exist two positive constants c and γ such that

$$f(x) \prec c \frac{x^{n_0}}{1 - \gamma x};$$

and more precisely, if $f \in \mathcal{A}(\mathcal{B}_{\mathbb{C}}(0, \rho), \mathbb{C})$ (see Definition 1.1), then

$$f(x) \prec \frac{\|f\|_{\mathcal{A}}}{\rho^{n_0}} \frac{x^{n_0}}{1 - \frac{1}{\rho} x}.$$

5. If $0 \prec f(x) \prec g(x)$, then

$$\frac{1}{1 - f(x)} \prec \frac{1}{1 - g(x)}.$$

6. If $f \prec g$ and $g \in \mathcal{A}(\mathcal{B}_{\mathbb{C}^d}(0, \rho), \mathbb{C})$, then $f \in \mathcal{A}(\mathcal{B}_{\mathbb{C}^d}(0, \rho), \mathbb{C})$ and

$$\|f\|_{\mathcal{A}} \leq \|g\|_{\mathcal{A}}.$$

Lemma B.3. *Let F be a scalar formal power series of the variables (x_1, \dots, x_d) , with positive coefficients, and Φ, Ψ be two vectorial formal power series*

$$\Phi(x_1, \dots, x_d) = (\phi_1, \dots, \phi_d)(x_1, \dots, x_d),$$

$$\Psi(x_1, \dots, x_d) = (\psi_1, \dots, \psi_d)(x_1, \dots, x_d).$$

Then we have the upper bound

$$F(\Phi + \Psi) - F(\Phi) \prec |DF|(|\Phi| + |\Psi|) \cdot |\Psi|,$$

where we use the notation

$$|DF|(|\Phi| + |\Psi|) \cdot |\Psi| := \sum_{i=1}^d |\partial_{x_i} F|(|\Phi_1| + |\Psi_1|, \dots, |\Phi_d| + |\Psi_d|) \cdot |\Psi_i|.$$

Lemma B.4. *We consider a family of formal power series of the form*

$$F_\nu(Y) := (F_{\nu,1}(y_1, \dots, y_d), \dots, F_{\nu,d}(y_1, \dots, y_d)) = (y_1, \dots, y_d) + \mathcal{O}(|Y|^2)$$

such that F_0 is convergent and there exist $N \in \mathbb{N}$ and a convergent power series \mathcal{M} such that for all $j = 1, \dots, d$,

$$F_{\nu,j} - F_{0,j} \prec \nu(y_1 + \dots + y_d)^N \mathcal{M}(y_1 + \dots + y_d)$$

holds ; we moreover suppose that F_ν is invertible and denote

$$F_\nu^{-1}(Y) := (F_{\nu,1}^-, \dots, F_{\nu,d}^-)(Y).$$

Then there exists a convergent power series \mathcal{M}_1 such that for all $j = 1, \dots, d$

$$F_{\nu,j}^- - F_{0,j}^- \prec \nu(y_1 + \dots + y_d)^N \mathcal{M}_1(y_1 + \dots + y_d)$$

holds.

C. Appendix. Construction of a local canonical change of coordinates:

Proof of Prop. 2.2. This appendix is devoted to the proof of the Proposition C.1 below, which is a more general and detailed version of Proposition 2.2.

This proposition gives some estimates on the dependence of a change of coordinates \mathcal{F}_ε in term of some parameters $\underline{\varepsilon} := (\varepsilon, \nu, \mu)$. For fixed values of the parameter $\underline{\varepsilon}$ the existence of the change of coordinates \mathcal{F}_ε is already well-known, it is a theorem of Moser [21] together with a result of Russmann [22]. The main result here is that under some assumptions, *the singularity in ε in the quadratic part of the initial Hamiltonian does not affect the bounds (i) – (ix)* (they are all independent of ε).

This proposition plays a *crucial part in the proof of Theorem 1.2*, points (i) and (ii) being the pivotal results. These results allow in particular to get fine properties of many objects such as the center-stable and center-unstable manifolds or the energy level sets, given that these objects are very simple in the $(\xi_1, \eta_1, \xi_2, \eta_2)$ -coordinates.

Indeed, these results play a big role in the proof of Proposition 2.6: at each step of the proof, we use local properties, local being in the spatial sense or for small values of the parameter ν , and we have to verify that the local neighborhoods do not tends to an empty set or do not move too much when ε goes to 0. For instance, consider Lemma 5.1 in which we claim that the center-stable manifold $W^{cs}(0)$ can be expressed locally as the graph of a map $p_{1,\underline{\varepsilon}}^{cs}$. The results of Proposition C.1 ensures that this graph expression holds for ε, ν, μ small, in a neighborhood (namely $\mathcal{B}(0, \delta)$) independent of ε, ν and μ .

Knowing precisely these neighborhoods is important then to perform a perturbative method (namely KAM theorem with the perturbative parameter μ , see Part 6) in a fixed annulus.

Proposition C.1. *Let us consider a family of real analytic Hamiltonians H in $\mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho), \mathbb{R})$ of the form*

$$H((q_1, p_1, q_2, p_2), \underline{\varepsilon}) = -\alpha_1 q_1 p_1 + \frac{\alpha_2(\underline{\varepsilon})}{\varepsilon^2} (q_2^2 + p_2^2) + h(q_1, p_1) + \nu \mathcal{R}'((q_1, p_1, q_2, p_2), \underline{\varepsilon}),$$

where $\underline{\varepsilon} = (\varepsilon, \nu, \mu)$. We suppose that α_2 is a continuous function verifying $\alpha_2(0) \neq 0$ and that $\mathcal{R}(\cdot, \underline{\varepsilon})$ is a C^1 -family of analytic functions, and

$$h(q_1, p_1) = \mathcal{O}(|(q_1, p_1)|^3), \quad \mathcal{R}((q_1, p_1, q_2, p_2), \underline{\varepsilon}) = \mathcal{O}(|(q_1, p_1, q_2, p_2)|^3).$$

Then, there exist ε_0 , ρ'_0 and a family of canonical changes of coordinates

$$\mathcal{F}_{\underline{\varepsilon}} = (\varphi_{1,\underline{\varepsilon}}, \psi_{1,\underline{\varepsilon}}, \varphi_{2,\underline{\varepsilon}}, \psi_{2,\underline{\varepsilon}})$$

defined for $|\underline{\varepsilon}| \leq \varepsilon_0$ such that the Hamiltonian in the new coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$ reads

$$\begin{aligned} H(\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon}) &= K_{\underline{\varepsilon}}(\xi_1 \eta_1, \xi_2^2 + \eta_2^2) \\ &= -\xi_1 \eta_1 + \frac{\omega(\underline{\varepsilon})}{2\varepsilon^2}(\xi_2^2 + \eta_2^2) + \mathcal{O}(|(\xi_1 \eta_1, \xi_2^2 + \eta_2^2)|^2), \end{aligned} \quad (60)$$

and such that for all $\underline{\varepsilon}$, $\mathcal{F}_{\underline{\varepsilon}}$ and $\mathcal{F}_{\underline{\varepsilon}}^{-1}$ belong to $\mathcal{A}(\mathcal{B}_{\mathbb{R}^4}(0, \rho'_0), \mathbb{R}^4)$, and for $\underline{\varepsilon} := (\varepsilon, 0, 0)$, $\mathcal{F}_{(\varepsilon, 0, 0)}$ is independent of ε and is of the form

$$\mathcal{F}_{(\varepsilon, 0, 0)}(\xi_1, \eta_1, \xi_2, \eta_2) := \mathcal{F}_0(\xi_1, \eta_1, \xi_2, \eta_2) = (\varphi_{1,0}(\xi_1, \eta_1), \psi_{1,0}(\xi_1, \eta_1), \xi_2, \eta_2). \quad (61)$$

Moreover we have the following estimates (recall that \prec is defined in Appendix B): there exists a power series of one variable \mathcal{M} , convergent on $\mathcal{B}(0, 4\rho'_0)$ such that

1. $(\mathcal{F}_{\underline{\varepsilon}} - \mathcal{F}_0)(\xi_1, \eta_1, \xi_2, \eta_2) \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 \mathcal{M}(\xi_1 + \eta_1 + \xi_2 + \eta_2)$,
2. $\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) - (\xi_1, \eta_1, \xi_2, \eta_2) \prec (\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 \mathcal{M}(\xi_1 + \eta_1 + \xi_2 + \eta_2)$,
3. $\mathcal{F}_{\underline{\varepsilon}}^{-1}(q_1, p_1, q_2, p_2) - (q_1, p_1, q_2, p_2) \prec (q_1 + p_1 + q_2 + p_2)^2 \mathcal{M}(q_1 + p_1 + q_2 + p_2)$.

And there exists a real \mathcal{M}_0 satisfying

4. $|\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) - \mathcal{F}_0(\xi_1, \eta_1, \xi_2, \eta_2)| \leq \nu \mathcal{M}_0$,
5. $|\mathcal{F}_{\underline{\varepsilon}}^{-1}(q_1, p_1, q_2, p_2) - \mathcal{F}_0^{-1}(q_1, p_1, q_2, p_2)| \leq \nu \mathcal{M}_0$,
6. $|\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) - (\xi_1, \eta_1, \xi_2, \eta_2)| \leq \mathcal{M}_0 |(\xi_1, \eta_1, \xi_2, \eta_2)|^2$,
7. $|\mathcal{F}_{\underline{\varepsilon}}^{-1}(q_1, p_1, q_2, p_2) - (q_1, p_1, q_2, p_2)| \leq \mathcal{M}_0 |(q_1, p_1, q_2, p_2)|^2$,
8. $|\varphi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) - \xi_2| \leq \nu \mathcal{M}_0 |(\xi_1, \eta_1, \xi_2, \eta_2)|^2$,
9. $|\psi_{2,\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) - \eta_2| \leq \nu \mathcal{M}_0 |(\xi_1, \eta_1, \xi_2, \eta_2)|^2$.

for all $(\xi_1, \eta_1, \xi_2, \eta_2)$ in $\mathcal{B}(0, \rho'_0)$ and all (q_1, p_1, q_2, p_2) in $\mathcal{B}(0, \rho'_0)$.

Plan of the proof. Proving this fair dependence in term of the parameters requires to perform again each step of the existence proofs of Moser and Russmann, to verify the effect of the singularity in term of ε at each step of the construction of $\mathcal{F}_{\underline{\varepsilon}}$. This is a very long and technical work given that $\mathcal{F}_{\underline{\varepsilon}}$ is firstly constructed as a formal power series, by induction on the coefficients, so that at each step we compute the estimates by the method of majorant series.

Section C.1: complex variables: We compute a change of coordinates which diagonalize the linear part of the vector field, but also leads to complex variables. We detail this classical change of coordinates in order to prove at the end of the proof (in Part C.5) that the final change of coordinate is real.

Section C.2: non canonical changes of coordinates: We first consider the family of changes of coordinates $F_{\underline{\varepsilon}}$, which are not canonical. For fixed values of $\underline{\varepsilon}$, they are the changes of coordinates constructed by Moser [21]. The construction of the final *canonical* changes of coordinates relies on the $F_{\underline{\varepsilon}}$, and so do the estimates of Proposition C.1. So, in Part C.2, we compute estimates on the dependence of $F_{\underline{\varepsilon}}$ with respect to $\underline{\varepsilon}$.

Section C.3: introduction of the canonical changes of coordinates:

We then introduce the family of *canonical* changes of coordinates $F_{\underline{\varepsilon}}^*$. For fixed values of $\underline{\varepsilon}$, they nearly are the changes of coordinates constructed by Russmann [22]. We moreover prove in this part the particular form of $F_{(\varepsilon, 0, 0)}^*$ (in order to get (61)).

Section C.4: estimate (i) on the canonical changes of coordinates:

We prove that the $\mathcal{F}_{\underline{\varepsilon}}$ satisfy an estimate of the form of (i) of Proposition C.1.

Section C.5: back to \mathbb{R} and proof of the final form of the Proposition

Gathering the previous results and getting back in \mathbb{R} , we can finally prove the Proposition C.1.

C.1. Diagonalization / complex variables. We first perform the following complex canonical change of coordinates

$$\begin{pmatrix} q'_1 \\ p'_1 \\ q'_2 \\ p'_2 \end{pmatrix} = \begin{pmatrix} I & O \\ O & P \end{pmatrix} \begin{pmatrix} q_1 \\ p_1 \\ q_2 \\ p_2 \end{pmatrix} := \mathcal{P} \begin{pmatrix} q_1 \\ p_1 \\ q_2 \\ p_2 \end{pmatrix}, \quad \text{where } P = \frac{1}{\sqrt{2}} \begin{pmatrix} 1 & i \\ i & 1 \end{pmatrix}.$$

Let us construct first the changes of coordinates $F_{\underline{\varepsilon}}^*$ in \mathbb{C}^4 , and at the end (see subsection C.5) define $\mathcal{F}_{\underline{\varepsilon}} := \mathcal{P}^{-1} F_{\underline{\varepsilon}}^* \mathcal{P}$. The Hamiltonian in the new coordinates reads

$$\begin{aligned} \mathbf{H}((x_1, y_1, x_2, y_2), \underline{\varepsilon}) \\ = -\alpha_1 x_1 y_1 - i \frac{\alpha_2(\underline{\varepsilon})}{\underline{\varepsilon}^2} x_2 y_2 + h(x_1, y_1) + \nu \mathcal{R}((x_1, y_1, x_2, y_2), \underline{\varepsilon}). \end{aligned} \quad (62)$$

with $\alpha_1, \alpha_2 \in \mathbb{R}$. The associated Hamiltonian system reads

$$\begin{cases} \dot{x}_1 &= \alpha_1 x_1 + \partial_{y_1} h(x_1, y_1) + \nu \partial_{y_1} \mathcal{R}((x_1, y_1, x_2, y_2), \underline{\varepsilon}) \\ \dot{y}_1 &= -\alpha_1 y_1 - \partial_{x_1} h(x_1, y_1) - \nu \partial_{x_1} \mathcal{R}((x_1, y_1, x_2, y_2), \underline{\varepsilon}) \\ \dot{x}_2 &= i \frac{\alpha_2(\underline{\varepsilon})}{\underline{\varepsilon}^2} x_2 + \nu \partial_{y_2} \mathcal{R}((x_1, y_1, x_2, y_2), \underline{\varepsilon}) \\ \dot{y}_2 &= -i \frac{\alpha_2(\underline{\varepsilon})}{\underline{\varepsilon}^2} y_2 - \nu \partial_{x_2} \mathcal{R}((x_1, y_1, x_2, y_2), \underline{\varepsilon}). \end{cases} \quad (63)$$

Let us denote it by

$$\begin{cases} \dot{x}_1 &= \alpha_1 x_1 + f_{1,0}(x_1, y_1) + \nu f_{1,\underline{\varepsilon}}((x_1, y_1, x_2, y_2)) \\ \dot{y}_1 &= -\alpha_1 y_1 + g_{1,0}(x_1, y_1) + \nu g_{1,\underline{\varepsilon}}((x_1, y_1, x_2, y_2)) \\ \dot{x}_2 &= i \frac{\alpha_2(\underline{\varepsilon})}{\underline{\varepsilon}^2} x_2 + \nu f_{2,\underline{\varepsilon}}((x_1, y_1, x_2, y_2)) \\ \dot{y}_2 &= -i \frac{\alpha_2(\underline{\varepsilon})}{\underline{\varepsilon}^2} y_2 + \nu g_{2,\underline{\varepsilon}}((x_1, y_1, x_2, y_2)). \end{cases} \quad (64)$$

Note that for $i = 1, 2$, the families $(f_{i,\underline{\varepsilon}})_{\underline{\varepsilon}}$ and $(g_{i,\underline{\varepsilon}})_{\underline{\varepsilon}}$ are \mathcal{C}^1 -families of the space $(\mathcal{A}(\mathcal{B}_{\mathbb{C}^4}(0, \rho_1), \mathbb{C}), \|\cdot\|_{\infty})$, given that $\underline{\varepsilon} \mapsto \mathcal{R}(\cdot, \underline{\varepsilon})$ is \mathcal{C}^1 on $\mathcal{A}(\mathcal{B}_{\mathbb{C}^4}(0, \rho_1), \mathbb{C})$.

C.2. First family $F_{\underline{\varepsilon}}$, not canonical. Let us firstly introduce the following notation:

Definition C.2. Let $\phi(x_1, y_1, x_2, y_2)$ be a formal power series from \mathbb{C}^4 to \mathbb{C} , of the form

$$\phi(x_1, y_1, x_2, y_2) = \sum_{m, n \in \mathbb{N}^2} c_{m, n} x_1^{m_1} y_1^{n_1} x_2^{m_2} y_2^{n_2}.$$

Let us define the “sub”-power series, from \mathbb{C}^2 to \mathbb{C} , made of the sum of all the monomials of ϕ satisfying $m_1 = n_1$ and $m_2 = n_2$,

$$[\phi](\omega_1, \omega_2) := \sum_{n \in \mathbb{N}^2} c_{n, n} \omega_1^{n_1} \omega_2^{n_2}.$$

We first fix $\underline{\varepsilon}$ and state the following lemma

Lemma C.3. Consider a Hamiltonian of the form (62) with α_1, α_2 real satisfying the assumptions of Proposition C.1. Then

(i): for all ε there exist a formal power series

$$(x_1, y_1, x_2, y_2) = \tilde{F}_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2) = (\tilde{\varphi}_{1,\varepsilon}, \tilde{\psi}_{1,\varepsilon}, \tilde{\varphi}_{2,\varepsilon}, \tilde{\psi}_{2,\varepsilon})((\xi_1, \eta_1, \xi_2, \eta_2)),$$

and formal power series of 2 variables $\tilde{a}_{i,\varepsilon}$ and $\tilde{b}_{i,\varepsilon}$ for $i = 1, 2$ satisfying

$$\tilde{F}_\varepsilon(x, \varepsilon) = x + \mathcal{O}(|x|^2),$$

$$\begin{aligned} \tilde{a}_{1,\varepsilon}(\omega_1, \omega_2) &= \alpha_1 + \mathcal{O}((\omega_1, \omega_2)), & \tilde{a}_{2,\varepsilon}(\omega_1, \omega_2) &= i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} + \mathcal{O}((\omega_1, \omega_2)), \\ \tilde{b}_{1,\varepsilon}(\omega_1, \omega_2) &= -\alpha_1 + \mathcal{O}((\omega_1, \omega_2)), & \tilde{b}_{2,\varepsilon}(\omega_1, \omega_2) &= -i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} + \mathcal{O}((\omega_1, \omega_2)), \end{aligned}$$

such that in the new coordinates $(\xi_1, \eta_1, \xi_2, \eta_2)$, the hamiltonian system reads

$$\begin{cases} \dot{\xi}_1 &= \tilde{a}_{1,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1 \\ \dot{\eta}_1 &= \tilde{b}_{1,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1 \\ \dot{\xi}_2 &= \tilde{a}_{2,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2 \\ \dot{\eta}_2 &= \tilde{b}_{2,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2. \end{cases} \quad (65)$$

(ii): for all ε , we have existence and uniqueness of the formal power series \tilde{F}_ε , $\tilde{a}_{i,\varepsilon}$ et $\tilde{b}_{i,\varepsilon}$ of (i) if

$$\left[\frac{\tilde{\varphi}_{1,\varepsilon}}{\xi_1} \right], \left[\frac{\tilde{\psi}_{1,\varepsilon}}{\eta_1} \right], \left[\frac{\tilde{\varphi}_{2,\varepsilon}}{\xi_2} \right], \left[\frac{\tilde{\psi}_{2,\varepsilon}}{\eta_2} \right] \quad (66)$$

are any 4 given power series of the form $1 + \mathcal{O}(\omega_1, \omega_2)$.

(iii): If \tilde{F}_ε is a formal power series satisfying (i), then \tilde{F}_ε' also satisfies (i) if and only there exist some formal power series Φ_i, Ψ_i such that

$$\begin{aligned} \Phi_i(\omega_1, \omega_2) &= 1 + \mathcal{O}((\omega_1, \omega_2)), \\ \Psi_i(\omega_1, \omega_2) &= 1 + \mathcal{O}((\omega_1, \omega_2)), \\ \tilde{F}_\varepsilon'(\xi, \eta) &= \tilde{F}_\varepsilon \left(\Phi_1(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1, \Psi_1(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1, \right. \\ &\quad \left. \Phi_2(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2, \Psi_2(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2 \right). \end{aligned}$$

(iv): Necessarily, $a_{1,\varepsilon} = -b_{1,\varepsilon}$ et $a_{2,\varepsilon} = -b_{2,\varepsilon}$.

(v): Moreover, if the 4 power series (66) are convergent power series, then \tilde{F}_ε , $\tilde{a}_{i,\varepsilon}$ and $\tilde{b}_{i,\varepsilon}$ are convergent, i.e. there exists a disk on which they are analytic.

Proof. in the statement of this lemma, (v) is in fact the direct consequence, in our case, of the result stated by Moser [21]. And (i) – (iv) are the steps of his proof (still applied to our particular case): (i) and (ii) correspond to his Part 2, (iv) is the lemma stated in his Part 3 and (iii) is the Step I of the proof of the latter lemma. Point (v) is proved in his Part 4. We state here explicitly these steps of his proof because we use it below.

Morser's proof relies on the fact that system in the new coordinates is of the form (65) if and only if \tilde{F}_ε satisfies

$$\begin{cases} \alpha_1 \tilde{\varphi}_{1,\varepsilon} + f_{1,0}(\tilde{\varphi}_{1,\varepsilon}, \tilde{\psi}_{1,\varepsilon}) + \nu f_{1,\varepsilon}(\tilde{F}_\varepsilon) = \Delta_{12} \tilde{\varphi}_{1,\varepsilon} \\ -\alpha_1 \tilde{\psi}_{1,\varepsilon} + g_{1,0}(\tilde{\varphi}_{1,\varepsilon}, \tilde{\psi}_{1,\varepsilon}) + \nu g_{1,\varepsilon}(\tilde{F}_\varepsilon) = \Delta_{12} \tilde{\psi}_{1,\varepsilon} \\ i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \tilde{\varphi}_{2,\varepsilon} + \nu f_{1,\varepsilon}(\tilde{F}_\varepsilon) = \Delta_{12} \tilde{\varphi}_{2,\varepsilon} \\ -i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \tilde{\psi}_{2,\varepsilon} + \nu g_{1,\varepsilon}(\tilde{F}_\varepsilon) = \Delta_{12} \tilde{\psi}_{2,\varepsilon}, \end{cases} \quad (67)$$

where we denote

$$\begin{aligned}\Delta_{12} &:= (\tilde{a}_{1,\varepsilon}(\xi_1\eta_1, \xi_2\eta_2)D_1 + \tilde{a}_{2,\varepsilon}(\xi_1\eta_1, \xi_2\eta_2)D_2) \\ D_1 &:= \xi_1\partial_{\xi_1} - \eta_1\partial_{\eta_1}, \\ D_2 &:= \xi_2\partial_{\xi_2} - \eta_2\partial_{\eta_2}.\end{aligned}\tag{68}$$

□

Lemma C.4. *Let us denote by $F_{\varepsilon} = (\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}, \psi_{2,\varepsilon})$, $a_{i,\varepsilon}$ the formal power series satisfying*

$$\left[\frac{\varphi_{1,\varepsilon}}{\xi_1} \right] = 1 = \left[\frac{\psi_{1,\varepsilon}}{\eta_1} \right] = \left[\frac{\varphi_{2,\varepsilon}}{\xi_2} \right] = \left[\frac{\psi_{2,\varepsilon}}{\eta_2} \right],\tag{69}$$

whose existence and uniqueness are asserted in Lemma C.3 (ii). They have the following properties

(i): $F_{(\varepsilon,0,0)}$ and $a_{1,(\varepsilon,0,0)}$ are independent of ε . Let us denote them by $a_{1,0}$ and

$$F_{(\varepsilon,0,0)} := F_0 = (\varphi_{1,0}, \psi_{1,0}, \varphi_{2,0}, \psi_{2,0}),$$

Moreover, they read

$$\begin{aligned}F_0(\xi_1, \eta_1, \xi_2, \eta_2) &= (\varphi_{1,0}(\xi_1, \eta_1), \psi_{1,0}(\xi_1, \eta_1), \xi_2, \eta_2) \\ a_{1,(\varepsilon,0,0)}(\omega_1, \omega_2) &= a_{1,0}(\omega_1), \quad a_{2,(\varepsilon,0,0)}(\omega_1, \omega_2) = i \frac{\alpha_2(\varepsilon)}{\varepsilon^2}.\end{aligned}$$

(ii): There exist a convergent power series \mathcal{M} such that for every $\varepsilon \leq \varepsilon_0$,

$$(F_{\varepsilon} - F_0)(\xi_1, \eta_1, \xi_2, \eta_2) \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 \mathcal{M}(\xi_1 + \eta_1 + \xi_2 + \eta_2).$$

Proof of (i). Let us consider System (67) with $\nu = \mu = 0$ and prove that there exists a solution $F_{(\varepsilon,0,0)}$ independent of ε and of the form required in (i). Given that the uniqueness of such $F_{(\varepsilon,0,0)}$ and $a_{1,(\varepsilon,0,0)}$ was established in Lemma C.3 (ii), this will prove (i).

With the system (67) together with the ansatz

$$\begin{aligned}F_{\varepsilon}(\xi_1, \eta_1, \xi_2, \eta_2) &= (\varphi_{1,\varepsilon}(\xi_1, \eta_1), \psi_{1,\varepsilon}(\xi_1, \eta_1), \xi_2, \eta_2) \\ a_{1,\varepsilon}(\omega_1, \omega_2) &= a_{1,\varepsilon}(\omega_1), \quad a_{2,\varepsilon}(\omega_1, \omega_2) = i \frac{\alpha_2(\varepsilon)}{\varepsilon^2},\end{aligned}$$

and using the particular form of the operators D_1 and D_2 (defined in (68)), we get

$$\begin{cases} \alpha_1 \varphi_{1,\varepsilon}(\xi_1, \eta_1) + f_{1,0}(\varphi_{1,\varepsilon}(\xi_1, \eta_1), \psi_{1,\varepsilon}(\xi_1, \eta_1)) = a_{1,\varepsilon}(\xi_1\eta_1) D_1 \varphi_{1,\varepsilon}(\xi_1, \eta_1) \\ -\alpha_1 \psi_{1,\varepsilon}(\xi_1, \eta_1) + g_{1,0}(\varphi_{1,\varepsilon}(\xi_1, \eta_1), \psi_{1,\varepsilon}(\xi_1, \eta_1)) = a_{1,\varepsilon}(\xi_1\eta_1) D_1 \psi_{1,\varepsilon}(\xi_1, \eta_1) \\ i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \xi_2 = i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \xi_2 \\ -i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \eta_2 = i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} (-\eta_2). \end{cases}\tag{70}$$

Only the two first equations remain. To prove that there exist such $\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, a_{1,\varepsilon}$ we moreover use (iv) of Lemma C.3: we are going to prove that there exist $a_{1,\varepsilon}(\xi_1\eta_1)$ and $b_{1,\varepsilon}(\xi_1\eta_1)$ solving the following system 71, and we will conclude thank to (iv) which asserts that $-b_{1,\varepsilon} = a_{1,\varepsilon}$.

$$\begin{cases} \alpha_1 \varphi_{1,\varepsilon}(\xi_1, \eta_1) + f_{1,0}(\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}) = (a_{1,\varepsilon}(\xi_1\eta_1) \xi_1 \partial_{\xi_1} + b_{1,\varepsilon}(\xi_1\eta_1) \eta_1 \partial_{\eta_1}) \varphi_{1,\varepsilon}(\xi_1, \eta_1) \\ -\alpha_1 \psi_{1,\varepsilon}(\xi_1, \eta_1) + g_{1,0}(\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}) = (a_{1,\varepsilon}(\xi_1\eta_1) \xi_1 \partial_{\xi_1} + b_{1,\varepsilon}(\xi_1\eta_1) \eta_1 \partial_{\eta_1}) \psi_{1,\varepsilon}(\xi_1, \eta_1). \end{cases}\tag{71}$$

Our aim is to prove the existence of such formal power series $\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, a_{1,\varepsilon}$ and $b_{1,\varepsilon}$. Denote them by

$$\begin{aligned}\varphi_{1,\varepsilon}(\xi_1, \eta_1) &:= \xi_1 + \sum_{N=2}^{+\infty} \varphi_1^N(\xi_1, \eta_1), & \psi_{1,\varepsilon}(\xi_1, \eta_1) &:= \xi_1 + \sum_{N=2}^{+\infty} \psi_1^N(\xi_1, \eta_1), \\ a_{1,\varepsilon}(\omega_1) &:= \alpha_1 + \sum_{N=1}^{+\infty} a_1^N(\omega_1), & b_{1,\varepsilon}(\omega_1) &:= -\alpha_1 + \sum_{N=1}^{+\infty} b_1^N(\omega_1).\end{aligned}$$

where the $\varphi_1^N, \psi_1^N, a_1^N$ and b_1^N are homogeneous polynomials of degree N . System (71) at degree $N \geq 2$ read then

$$\alpha_1 \varphi_1^N - \alpha_1 D_1 \varphi_1^N - \xi_1 a_1^{N-1} = \mathcal{F}_N(\varphi_1^M, \psi_1^M, a_1^{M-1}, M < N), \quad (72)$$

$$-\alpha_1 \psi_1^N - \alpha_1 D_1 \psi_1^N - \eta_1 b_1^{N-1} = \mathcal{G}_N(\varphi_1^M, \psi_1^M, a_1^{M-1}, M < N). \quad (73)$$

Observe that the kernel of the operator $(Id - D_1)$ is the vector space generated by the monomials of the form $\xi_1(\xi_1 \eta_1)^{n_1}$, and is a bijection of the vector space generated by all the other monomials. We then prove the existence of the $\varphi_1^N, \psi_1^N, a_1^{N-1}$ et b_1^{N-1} by induction: on one hand, for $\xi_1 a_1^N(\xi_1 \eta_1)$ we take the sum of all the monomials of the form $\xi_1(\xi_1 \eta_1)^{n_1}$ in the polynomial $-\mathcal{F}_N(\varphi_1^M, \psi_1^M, a_1^{M-1}, M < N)$, and do the same for b_1^N . And on the other hand, for $\varphi_1^N(\xi_1, \eta_1)$ we chose the antecedent of

$$\mathcal{F}_N(\varphi_1^M, \psi_1^M, a_1^{M-1}, M < N) - \xi_1 a_1^{N-1}(\xi_1 \eta_1)$$

by the operator $(Id - D_1)$ in the vector space generated by the monomials which are note of the form $\xi_1(\xi_1 \eta_1)^{n_1}$. We do the same with ψ_1^N , without monomials of the form $\eta_1(\xi_1 \eta_1)^{n_1}$.

Then the solution F_{ε} satisfies the properties stated (i) ; indeed: on one hand $\left[\frac{\varphi_{1,\varepsilon}}{\xi_1} \right] = 1 = \left[\frac{\psi_{1,\varepsilon}}{\eta_1} \right]$ given that $\varphi_{1,\varepsilon}$ has only one monomial of the form $\xi_1(\xi_1 \eta_1)^{n_1}$, which is ξ_1 . And on the other hand $(\varphi_{1,(\varepsilon,0,0)}, \psi_{1,(\varepsilon,0,0)}, a_{1,(\varepsilon,0,0)}, b_{1,(\varepsilon,0,0)})$ solves the system (71) which is independent of ε . And by the uniqueness stated in Lemma C.3 (ii), we get that $(\varphi_{1,(\varepsilon,0,0)}, \psi_{1,(\varepsilon,0,0)}, a_{1,(\varepsilon,0,0)}, b_{1,(\varepsilon,0,0)})$ are independent of ε . \square

Proof of (ii). Let us denote

$$F'_{\varepsilon} = (\varphi'_{1,\varepsilon}, \psi'_{1,\varepsilon}, \varphi'_{2,\varepsilon}, \psi'_{2,\varepsilon}) := \frac{1}{\nu}(F_{\varepsilon} - F_0), \quad a'_{i,\varepsilon} := \frac{1}{\nu}(a_{i,\varepsilon} - a_{i,0}).$$

In the following proof, we use the *absolute value* and the *maximum* associated with the order relation \prec , which are introduced in Definition B.1. We proceed in several steps.

Step 1. System (75) satisfied by the F'_{ε} . F_{ε} and F_0 satisfy (67) (with ε for the former, and $(\varepsilon, 0, 0)$ for the latter). We subtract those 2 systems and divide by ν , and then use the explicit expression of $a_{2,0}, \varphi_{1,0}, \psi_{1,0}, \varphi_{2,0}, \psi_{2,0}$, which implies in particular that

$$D_2 \varphi_{1,0} = 0 = D_2 \psi_{1,0} = D_1 \varphi_{2,0} = D_1 \psi_{2,0}.$$

We then get the following system satisfied by F'_ε

$$\begin{cases} \left(\alpha_1 - \alpha_1 D_1 - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2 \right) \varphi'_{1,\varepsilon} - \xi_1 a'_{1,\varepsilon} \\ \quad = (a_{1,0} - \alpha_1) D_1 \varphi'_{1,\varepsilon} + (a'_{1,\varepsilon} D_1 + a'_{2,\varepsilon} D_2) (\varphi_{1,0} - \xi_1 + \nu \varphi'_{1,\varepsilon}) \\ \quad - f_{1,\varepsilon}(F_0 + \nu F_\varepsilon) + \frac{1}{\nu} \left(f_{1,0}(\varphi_{1,0}, \psi_{1,0}) - f_{1,0}(\varphi_{1,0} + \nu \varphi'_{1,\varepsilon}, \psi_{1,0} + \nu \psi'_{1,\varepsilon}) \right) \\ (the same with \psi) \\ \left(i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} - \alpha_1 D_1 - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2 \right) \varphi'_{2,\varepsilon} - \xi_2 a'_{2,\varepsilon} \\ \quad = (a_{1,0} - \alpha_1) D_1 \varphi'_{2,\varepsilon} + (a'_{1,\varepsilon} D_1 + a'_{2,\varepsilon} D_2) \nu \varphi'_{2,\varepsilon} - f_{2,\varepsilon}(F_0 + \nu F'_\varepsilon) \\ (the same with \psi). \end{cases} \quad (74)$$

This system can be understood as an infinity of equalities of coefficients of power series, and then as equalities of the absolute values of coefficients. Moreover, observe that in the term of the left hand side, $\xi_1 a'_{1,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2)$ is made of monomials of the form $\xi_1(\xi_1 \eta_1)^{n_1}(\xi_2 \eta_2)^{n_2}$ and $\left(\alpha_1(I - D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2 \right) \varphi'_{1,\varepsilon}$ does not have any monomial of the form $\xi_1(\xi_1 \eta_1)^{n_1}(\xi_2 \eta_2)^{n_2}$.

Then, from each equality of (74), we get two inequalities, and obtain the following system

$$\begin{cases} \left| \left(\alpha_1(I - D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2 \right) \varphi'_{1,\varepsilon} \right| < \left| (a_{1,0} - \alpha_1) D_1 \varphi'_{1,\varepsilon} + (a'_{1,\varepsilon} D_1 + a'_{2,\varepsilon} D_2) (\varphi_{1,0} - \xi_1 + \nu \varphi'_{1,\varepsilon}) \right. \\ \quad \left. - f_{1,\varepsilon}(F_0 + \nu F_\varepsilon) + \frac{1}{\nu} (f_{1,0}(\varphi_{1,0}, \psi_{1,0}) - f_{1,0}(\varphi_{1,0} + \nu \varphi'_{1,\varepsilon}, \psi_{1,0} + \nu \psi'_{1,\varepsilon})) \right|, \\ \left| \xi_1 a'_{1,\varepsilon} \right| < \left| (a_{1,0} - \alpha_1) D_1 \varphi'_{1,\varepsilon} + (a'_{1,\varepsilon} D_1 + a'_{2,\varepsilon} D_2) (\varphi_{1,0} - \xi_1 + \nu \varphi'_{1,\varepsilon}) \right. \\ \quad \left. - f_{1,\varepsilon}(F_0 + \nu F_\varepsilon) + \frac{1}{\nu} (f_{1,0}(\varphi_{1,0}, \psi_{1,0}) - f_{1,0}(\varphi_{1,0} + \nu \varphi'_{1,\varepsilon}, \psi_{1,0} + \nu \psi'_{1,\varepsilon})) \right|, \\ \text{the same with the 3 other equations of (74)} \end{cases} \quad (75)$$

Step 2. An upper bound M_ε of F'_ε . We introduce two families of formal power series

$$\begin{aligned} M_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2) &:= \max_{\prec} \left\{ \max_{\prec} (D_1 \varphi'_{1,\varepsilon}, D_2 \psi'_{1,\varepsilon}) + \left| \left[\varphi'_{1,\varepsilon} \right] \right|, \right. \\ &\quad \max_{\prec} (D_1 \psi'_{1,\varepsilon}, D_2 \psi'_{1,\varepsilon}) + \left| \left[\psi'_{1,\varepsilon} \right] \right|, \\ &\quad \max_{\prec} (D_1 \varphi'_{2,\varepsilon}, D_2 \psi'_{2,\varepsilon}) + \left| \left[\varphi'_{2,\varepsilon} \right] \right|, \\ &\quad \max_{\prec} (D_1 \psi'_{2,\varepsilon}, D_2 \psi'_{2,\varepsilon}) + \left| \left[\psi'_{2,\varepsilon} \right] \right| \Big\} \\ A_\varepsilon(\omega_1, \omega_2) &:= \max_{\prec} \left\{ a'_{1,\varepsilon}, a'_{2,\varepsilon} \right\}. \end{aligned}$$

Let us prove that $\left| \varphi'_{1,\varepsilon} \right| < M_\varepsilon$. We denote

$$\varphi'_{1,\varepsilon}(\xi_1, \eta_1, \xi_2, \eta_2) := \sum_{m,n \in \mathbb{N}^2} c_{(m,n)} \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2}. \quad (76)$$

Then

$$\begin{aligned}
\max_{\prec} (D_1 \varphi'_{1,\varepsilon}, D_2 \psi'_{1,\varepsilon}) + \left| \left[\varphi'_{1,\varepsilon} \right] \right| \\
= \sum_{m,n \in \mathbb{N}^2} |c_{(m,n)}| \max \{ |m_1 - n_1|, |m_2 - n_2|, 1 \} \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2}. \\
\prec \sum_{m,n \in \mathbb{N}^2} |c_{(m,n)}| \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2} = \left| \varphi'_{1,\varepsilon} \right| (\xi_1, \eta_1, \xi_2, \eta_2). \tag{77}
\end{aligned}$$

So $\left| \varphi'_{1,\varepsilon} \right| \prec M_{\underline{\varepsilon}}$. With the same method one can check that $M_{\underline{\varepsilon}}$ is also an upper bound of $\left| \psi_{1,\varepsilon} \right|, \left| \varphi_{2,\varepsilon} \right|$ and $\left| \psi_{2,\varepsilon} \right|$.

Step 3. Lower bounds of the left hand side terms of (75) in term of $M_{\underline{\varepsilon}}$. Let us show that there is the following lower bound for the left hand part of equation (75)

$$\begin{aligned}
\min \left\{ \frac{|\alpha_1|}{4}, \frac{\alpha_2(\varepsilon)}{2\varepsilon^2} \right\} \cdot \left(\max_{\prec} (D_1 \varphi'_{1,\varepsilon}, D_2 \varphi'_{2,\varepsilon}) + \left| \left[\varphi'_{1,\varepsilon} \right] \right| \right) \\
\prec \left| \left(\alpha_1(I - D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right) \varphi'_{1,\varepsilon} \right|. \tag{78}
\end{aligned}$$

Indeed, using notation (76), the term of the right hand side of (78) satisfies

$$\begin{aligned}
& \left| \left(\alpha_1(I - D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right) \varphi'_{1,\varepsilon} \right| (\xi_1, \eta_1, \xi_2, \eta_2) \\
& \succ \sum_{m,n \in \mathbb{N}^2} \frac{|c_{(m,n)}|}{2} \left(|\alpha_1(1 - (m_1 - n_1))| + \left| \frac{\alpha_2(\varepsilon)}{\varepsilon^2} (m_2 - n_2) \right| \right) \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2}
\end{aligned}$$

given that α_1, α_2 are real. And we already computed the term of the left hand side of (78) (see (77)). So, (78) will be proved if we show that, for all $m, n \in \mathbb{N}^2$,

$$\begin{aligned}
& \min \left\{ \frac{|\alpha_1|}{4}, \frac{\alpha_2(\varepsilon)}{2\varepsilon^2} \right\} |c_{(m,n)}| \max \{ |m_1 - n_1|, |m_2 - n_2|, 1 \} \\
& \leq \frac{|c_{(m,n)}|}{2} \left(|\alpha_1(1 - (m_1 - n_1))| + \left| \frac{\alpha_2(\varepsilon)}{\varepsilon^2} (m_2 - n_2) \right| \right).
\end{aligned}$$

holds. We consider two different cases: firstly, if $m_1 = n_1 + 1$ and $m_2 = n_2$, then $c_{(m,n)} = 0$. Indeed, from the definition of $F_{\underline{\varepsilon}}$ we get

$$\left[\frac{\varphi'_{1,\varepsilon}}{\xi_1} \right] = \frac{1}{\nu} \left(\left[\frac{\varphi_{1,\varepsilon}}{\xi_1} \right] - \left[\frac{\varphi_{1,0}}{\xi_1} \right] \right) = \frac{1}{\nu} (1 - 1) = 0.$$

Secondly, if $m_1 \neq n_1 + 1$ or $m_2 \neq n_2$, we then get the result using that $|1 - (m_1 - n_1)| \geq 1$ or $|m_2 - n_2| \geq 1$. Hence

$$|\alpha_1| |1 - (m_1 - n_1)| + \left| \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right| |m_2 - n_2| \geq \min \{ |\alpha_1|, \left| \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right| \} \cdot 1.$$

The proof of (78) is then completed. And with the same method, we obtain the same type of inequalities for $\psi'_{1,\varepsilon}, \varphi'_{2,\varepsilon}, \psi'_{2,\varepsilon}$, and finally get

$$\min \left\{ \frac{|\alpha_1|}{4}, \frac{\alpha_2(\varepsilon)}{2\varepsilon^2} \right\} M_{\varepsilon} \\ \prec \max_{\prec} \left(\left| \left(\alpha_1(I-D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right) \varphi'_{i,\varepsilon} \right|, \left| \left(\alpha_1(I-D_1) - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} \right) \psi'_{i,\varepsilon} \right| \right)$$

Step 4. Upper bounds of the right hand side terms of (75) in term of M_{ε} . From now on, taking $(\xi_1, \eta_1, \xi_2, \eta_2) = (\omega, \omega, \omega, \omega)$, we consider all the power series as power series of one variable ω . The inequalities \prec are preserved by this change of variables. Given that $\varphi_{1,0}, \psi_{1,0}, \varphi_{2,0}, \psi_{2,0}$ and $a_{1,0} - \alpha_1$ are convergent power series (by Lemma C.3) without term of degree 0, and that $f_{1,0}, g_{1,0}$ are convergent without terms of degree 0 and 1, Lemma B.2 ensures the existence of c, γ such that

$$\varphi_{i,0}(\omega, \omega, \omega, \omega), \psi_{i,0}(\omega, \omega, \omega, \omega) \prec c \frac{\omega}{1 - \gamma\omega}, \quad a_{1,0}(\omega^2) - \alpha_1 \prec c \frac{\omega^2}{1 - \gamma\omega} \quad (79)$$

$$f_{1,0}, g_{1,0}(\omega, \omega) \prec c \frac{\omega^2}{1 - \gamma\omega}. \quad (80)$$

$f_{1,\varepsilon}, g_{1,\varepsilon}, f_{2,\varepsilon}$ et $g_{2,\varepsilon}$ are \mathcal{C}^0 in term of ε in the space $(\mathcal{A}(\mathcal{B}_{\mathbb{C}^4}(0, \rho_1), \mathbb{C}), \|\cdot\|_{\mathcal{A}})$, so that there exists an uniform upper bound in term of \mathcal{A} -uniform en ε . Moreover, the $f_{1,\varepsilon}, g_{1,\varepsilon}, f_{2,\varepsilon}$ and $g_{2,\varepsilon}$ do not have any monomial of degree 0 or 1. Then we get (with larger c and γ if necessary)

$$f_{1,\varepsilon}, g_{1,\varepsilon}, f_{2,\varepsilon}, g_{2,\varepsilon}(\omega, \omega, \omega, \omega) \prec c \frac{\omega^2}{1 - \gamma\omega}. \quad (81)$$

Let us compute upper bounds, in term of $M_{\varepsilon}(\omega, \omega, \omega, \omega)$ and $A_{\varepsilon}(\omega^2, \omega^2)$, of the terms of the right hand side of (75). We use Lemma B.3 to obtain the last of the following inequalities.

$$\begin{aligned} & |(a_{1,0} - \alpha_1)D_1\varphi'_{1,\varepsilon}|(\omega, \omega, \omega, \omega) \prec c \frac{\omega^2}{1 - \gamma\omega} M_{\varepsilon}(\omega, \omega, \omega, \omega); \\ & \left| \left(a'_{1,\varepsilon}D_1 + a'_{2,\varepsilon}D_2 \right) (\varphi_{1,0} - \xi_1 + \nu\varphi'_{1,\varepsilon}) \right| \prec A_{\varepsilon}(\omega^2, \omega^2) \left(2\nu M_{\varepsilon}(\omega, \omega, \omega, \omega) + c \frac{\omega^2}{1 - \gamma\omega} \right); \\ & |f_{1,\varepsilon}(F_{\varepsilon}(\omega, \omega, \omega, \omega))| \prec |f_{1,\varepsilon}| \left(|\varphi_{1,0}| + \dots + |\psi_{2,0}| + \nu(|\varphi'_{1,\varepsilon}| + \dots + |\psi'_{2,\varepsilon}|), \dots \right) \\ & \prec c \frac{\left(4c \frac{\omega}{1 - \gamma\omega} + 4\nu M_{\varepsilon}(\omega, \omega, \omega, \omega) \right)^2}{1 - \gamma \left(4c \frac{\omega}{1 - \gamma\omega} + 4\nu M_{\varepsilon}(\omega, \omega, \omega, \omega) \right)}; \\ & \frac{1}{\nu} (f_{1,0}(\varphi_{1,0}, \psi_{1,0}) - f_{1,0}(\varphi_{1,\varepsilon}, \psi_{1,\varepsilon})) \\ & \prec \frac{1}{\nu} |Df_{1,0}| \left(|\varphi_{1,0}| + |\psi_{1,0}| + \nu(|\varphi'_{1,\varepsilon}| + |\psi'_{1,\varepsilon}|) \right) \cdot \nu(|\varphi'_{1,\varepsilon}| + |\psi'_{1,\varepsilon}|) \\ & \prec \frac{2c \frac{\omega}{1 - \gamma\omega} 2\nu M_{\varepsilon}(\omega, \omega, \omega, \omega)}{1 - \gamma \left(2c \frac{\omega}{1 - \gamma\omega} + 2\nu M_{\varepsilon}(\omega, \omega, \omega, \omega) \right)} 2M_{\varepsilon}(\omega, \omega, \omega, \omega). \end{aligned}$$

Step 5. An inequation independent of ε satisfied by M_ε . We come back to system (75) and use the lower bounds of the terms of the left hand side (Step 3) and the upper bounds of the right hand side (Step 4). Taking the maximum of the terms of the left hand side, we obtain

$$\left\{ \begin{array}{l} M_\varepsilon \prec c \frac{\omega^2}{1-\gamma\omega} M_\varepsilon + A_\varepsilon \left(2\nu M_\varepsilon + c \frac{\omega^2}{1-\gamma\omega} \right) \\ \quad + c \frac{\left(4c \frac{\omega}{1-\gamma\omega} + 4\nu M_\varepsilon \right)^2}{1-\gamma \left(4c \frac{\omega}{1-\gamma\omega} + 4\nu M_\varepsilon \right)} + c \frac{2c \frac{\omega}{1-\gamma\omega} + 2\nu M_\varepsilon}{1-\gamma \left(2c \frac{\omega}{1-\gamma\omega} + 2\nu M_\varepsilon \right)} 2M_\varepsilon \\ \omega A_\varepsilon \prec c \frac{\omega^2}{1-\gamma\omega} M_\varepsilon + A_\varepsilon \left(2\nu M_\varepsilon + c \frac{\omega^2}{1-\gamma\omega} \right) \\ \quad + c \frac{\left(4c \frac{\omega}{1-\gamma\omega} + 4\nu M_\varepsilon \right)^2}{1-\gamma \left(4c \frac{\omega}{1-\gamma\omega} + 4\nu M_\varepsilon \right)} + c \frac{2c \frac{\omega}{1-\gamma\omega} + 2\nu M_\varepsilon}{1-\gamma \left(2c \frac{\omega}{1-\gamma\omega} + 2\nu M_\varepsilon \right)} 2M_\varepsilon. \end{array} \right. \quad (82)$$

We introduce

$$N_\varepsilon(\omega) := M_\varepsilon(\omega, \omega, \omega, \omega) + \omega A_\varepsilon(\omega^2, \omega^2).$$

Moreover, given that $\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}$ and $\psi_{2,\varepsilon}$ do not have any monomial of degree 0 or 1 and the $a_{i,\varepsilon}$ of degree 0, necessarily, N_ε read $N_\varepsilon = \omega^2 N'_\varepsilon(\omega)$, where N'_ε is a formal power series. We aim now at showing an upper bound of N'_ε independent of ε . And from system (82) we get that there exist c' and γ' such that for $\nu \leq 1$ N'_ε satisfies

$$N'_\varepsilon \prec c' \frac{c'\omega}{1-\gamma\omega} N'_\varepsilon + 2\omega N'^2_\varepsilon + c' \frac{\left(\frac{c}{1-\gamma\omega} + \omega N'_\varepsilon \right) \left(\frac{c}{1-\gamma\omega} + 2\omega N'_\varepsilon \right)}{1-\gamma' \left(\frac{c\omega}{1-\gamma\omega} + \omega^2 N'_\varepsilon \right)}. \quad (83)$$

N'_ε satisfies then a functional inequality independent of ε .

Step 6. Construction of a convergent majorant series Z . We aim now at constructing a convergent power series Z satisfying

$$Z(\omega) = c' \frac{c'\omega}{1-\gamma\omega} Z(\omega) + 2\omega Z^2 + c' \frac{\left(\frac{c}{1-\gamma\omega} + \omega Z \right) \left(\frac{c}{1-\gamma\omega} + 2\omega Z \right)}{1-\gamma' \left(\frac{c\omega}{1-\gamma\omega} + \omega^2 Z \right)}, \quad (84)$$

and such that $Z(0) \geq N'_\varepsilon(0)$. Indeed, from (83), by induction on the coefficients of N'_ε and Z we will then obtain

$$N'_\varepsilon(\omega) \prec Z(\omega),$$

so that Z will be the convergent upper bound independent of ε that we are looking for.

And by the analytic implicit functions theorem applied to equation (84) in the neighborhood of $\omega = 0$, we get the existence of a such Z : indeed, for $\omega = 0$, equation (84) read

$$Z - cc' = 0,$$

where $\partial_Z(Z - cc') = 1 \neq 0$ for all Z . And, up to a choice of larger c and c' in (83) if necessary, $cc' \geq N'_\varepsilon(0)$ is satisfied because $N'_\varepsilon(0)$ is uniformly bounded in term of ε for $\varepsilon \leq \varepsilon_0$ given that all the analytic functions defining N'_ε are \mathcal{C}^0 in term of ε . So we get the existence of a convergent power series Z such that $N'_\varepsilon(\omega) \prec Z(\omega)$. Then,

$$M_\varepsilon(\omega, \omega, \omega, \omega) \prec \omega^2 Z(\omega), \quad A_\varepsilon(\omega^2, \omega^2) \prec \omega Z(\omega)$$

hold, and thus

$$M_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) \prec M_{\underline{\varepsilon}}(\xi_1 + \eta_1 + \xi_2 + \eta_2, \dots, \xi_1 + \eta_1 + \xi_2 + \eta_2) \prec (\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 Z(\xi_1 + \eta_1 + \xi_2 + \eta_2)$$

and the same for $A_{\underline{\varepsilon}}$. Finally thank to Step 2, we get

$$\begin{aligned} |\varphi'_{1,\underline{\varepsilon}}|, |\psi'_{1,\underline{\varepsilon}}|, |\varphi'_{2,\underline{\varepsilon}}| \text{ and } |\psi'_{2,\underline{\varepsilon}}|(\xi_1, \eta_1, \xi_2, \eta_2) &\prec (\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 Z(\xi_1 + \eta_1 + \xi_2 + \eta_2), \\ |a'_{i,\underline{\varepsilon}}|(\xi_1, \eta_1, \xi_2, \eta_2) &\prec (\xi_1 + \eta_1 + \xi_2 + \eta_2) Z(\xi_1 + \eta_1 + \xi_2 + \eta_2). \end{aligned}$$

□

C.3. The canonical family $F_{\underline{\varepsilon}}^*$: Construction, properties of F_0^* . In this part, the first Lemma C.5 states the existence of a family of canonical changes of coordinates $F_{\underline{\varepsilon}}^*$ verifying a criteria, and then Lemma C.7 gives the main properties of F_0^* . Thank to the criteria, in next section we will prove that the $F_{\underline{\varepsilon}}^*$ are convergent and we will show that $F_{\underline{\varepsilon}}^* - F_0^*$ admits upper bounds of the type claimed in Proposition C.1. The appropriate choice of the criteria will also allows to prove in Part C.5 that the $\mathcal{F}_{\underline{\varepsilon}}$ are real. Our criteria (87) is very close to the one used by Rssmann [22] but slightly different in order to obtain a real change of coordinates.

Lemma C.5. *For all $\underline{\varepsilon}$,*

(i): *There exists some canonical formal power series*

$$\tilde{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) = (\xi_1, \eta_1, \xi_2, \eta_2) + \mathcal{O}(|(\xi_1, \eta_1, \xi_2, \eta_2)|^2), \quad (85)$$

and a Hamiltonian formal power series of 2 variables $K_{\underline{\varepsilon}}$ such that

$$\mathbf{H}(\tilde{F}_{\underline{\varepsilon}}((\xi_1, \eta_1, \xi_2, \eta_2)), \underline{\varepsilon}) = K_{\underline{\varepsilon}}(\xi_1 \eta_1, \xi_2 \eta_2) = -\alpha_1 \xi_1 \eta_1 - i \frac{\alpha_2(\underline{\varepsilon})}{\varepsilon^2} \xi_2 \eta_2 + \dots \quad (86)$$

(ii): *If $\tilde{F}_{\underline{\varepsilon}}$ satisfies (i), then $\tilde{F}_{\underline{\varepsilon}}'$ also satisfies (i) if and only if there exists a formal power series $S(\omega_1, \omega_2)$ such that*

$$\tilde{F}_{\underline{\varepsilon}}'(\xi, \eta) = \tilde{F}_{\underline{\varepsilon}}(\Phi_1(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1, \Psi_1(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1, \Phi_2(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2, \Psi_2(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2)$$

holds, where we denote

$$\Phi_i(\omega_1, \omega_2) := e^{\partial_{\omega_i} S(\omega_1, \omega_2)}, \quad \Psi_i(\omega_1, \omega_2) := e^{-\partial_{\omega_i} S(\omega_1, \omega_2)}.$$

(iii): *There exists a unique canonical formal power series denoted $F_{\underline{\varepsilon}}^* = (\varphi_{1,\underline{\varepsilon}}^*, \psi_{1,\underline{\varepsilon}}^*, \varphi_{2,\underline{\varepsilon}}^*, \psi_{2,\underline{\varepsilon}}^*)$ satisfying (i) and verifying the criteria*

$$\omega_1 \left(\left[\frac{\varphi_{1,\underline{\varepsilon}}^*}{\xi_1} \right] (\omega_1, \omega_2) - \left[\frac{\psi_{1,\underline{\varepsilon}}^*}{\eta_1} \right] (\omega_1, \omega_2) \right) + i \omega_2 \left(\left[\frac{\varphi_{2,\underline{\varepsilon}}^*}{\xi_2} \right] (\omega_1, \omega_2) - \left[\frac{\psi_{2,\underline{\varepsilon}}^*}{\eta_2} \right] (\omega_1, \omega_2) \right) = 0. \quad (87)$$

Remark C.6. Taking the values $a_{1,\underline{\varepsilon}}(\omega_1, \omega_2) = \partial_{\omega_1} K_{\underline{\varepsilon}}(\omega_1, \omega_2)$ and $a_{2,\underline{\varepsilon}}(\omega_1, \omega_2) = \partial_{\omega_2} K_{\underline{\varepsilon}}(\omega_1, \omega_2)$, we see that (i) of this lemma is a particular case of Lemma C.3.

Proof of (i). We construct $\tilde{F}_{\underline{\varepsilon}}$ with the aid of a generatrix function, i.e. we construct a formal power series $W_{\underline{\varepsilon}}$ and define $\tilde{F}_{\underline{\varepsilon}}$ by the implicit equation

$$\tilde{F}_{\underline{\varepsilon}}(\partial_{\eta_1} W_{\underline{\varepsilon}}(x, \eta), \eta_1, \partial_{\eta_2} W_{\underline{\varepsilon}}(x, \eta), \eta_2) = (x_1, \partial_{x_1} W_{\underline{\varepsilon}}(x, \eta), x_2, \partial_{x_2} W_{\underline{\varepsilon}}(x, \eta)).$$

In order to obtain $\tilde{F}_{\underline{\varepsilon}}$ of the form (85) we look for $W_{\underline{\varepsilon}}$ of the form

$$W_{\underline{\varepsilon}}(x, \eta) = W_{\underline{\varepsilon}}(x_1, \eta_1, x_2, \eta_2) = x_1 \eta_1 + x_2 \eta_2 + \mathcal{O}(|(x, \eta)|^3).$$

Then, the formal power series W_{ε} and K_{ε} verify (86) if and only if

$$\begin{aligned} \mathbf{H}((x_1, \partial_{x_1} W_{\varepsilon}(x, \eta), x_2, \partial_{x_2} W_{\varepsilon}(x, \eta)), \varepsilon) \\ = K_{\varepsilon}(\partial_{\eta_1} W_{\varepsilon}(x, \eta), \eta_1, \partial_{\eta_2} W_{\varepsilon}(x, \eta), \eta_2), \end{aligned} \quad (88)$$

with K_{ε} of the form

$$K_{\varepsilon}(\xi_1, \eta_1, \xi_2, \eta_2) = K_{\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) = -\alpha_1 \xi_1 \eta_1 - i \frac{\omega(\varepsilon)}{\varepsilon^2} + \mathcal{O}(|(\xi_1, \eta_1, \xi_2, \eta_2)|^3).$$

Let us denote

$$W_{\varepsilon}^N(x, \eta) := \sum_{N \geq 2} W_{\varepsilon}^N(x, \eta), \quad \mathbf{H}(x, y, \varepsilon) := \sum_{N \geq 2} \mathbf{H}_{\varepsilon}^N(x, y), \quad K_{\varepsilon}(\xi, \eta) := \sum_{N \geq 2} K_{\varepsilon}^N(\xi, \eta);$$

where $W_{\varepsilon}^N, \mathbf{H}_{\varepsilon}^N, K_{\varepsilon}^N$ are homogeneous polynomials of degree N . Then (88) is satisfied if and only if for all $N \geq 2$,

$$\alpha_1 D_1 W_{\varepsilon}^N(x, \eta) + i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2 W_{\varepsilon}^N(x, \eta) - K_{\varepsilon}^N(x, \eta) = \mathcal{F}_N(W_{\varepsilon}^M, K_{\varepsilon}^M, M < N),$$

where \mathcal{F}_N only depends of the $W_{\varepsilon}^M, K_{\varepsilon}^M$ for $M < N$ and where we denote $D_1 = x_1 \partial_{x_1} - \eta_1 \partial_{\eta_1}$, and $D_2 = x_2 \partial_{x_2} - \eta_2 \partial_{\eta_2}$.

Given that α_1 and α_2 are real, observing the images of the monomials, we get that $(\alpha_1 D_1 + i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2)$ is a bijection of the set of formal power series without monomials of the form $(x_1 \eta_1)^m (x_2 \eta_2)^n$. Thus, we construct the W_{ε}^N and K_{ε}^N by induction, choosing at the step N :

$$\begin{aligned} K_{\varepsilon}^N(x_1 \eta_1, x_2 \eta_2) &= \left[\mathcal{F}_N(W_{\varepsilon}^M, K_{\varepsilon}^M, M < N) \right] (\xi_1 \eta_1, \xi_2 \eta_2) \\ W_{\varepsilon}^N(x_1, \eta_1, x_2, \eta_2) &= (\alpha_1 D_1 + i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} D_2)^{-1} \\ &\quad \left(\mathcal{F}_N(W_{\varepsilon}^M, K_{\varepsilon}^M, M < N) - K_{\varepsilon}^N(x_1 \eta_1, x_2 \eta_2) \right). \end{aligned} \quad (89)$$

Proof of (ii). This is nearly the result proved by Rssmann [22] in its part 3: he shows that the change of coordinates

$$(\xi_1, \eta_1, \xi_2, \eta_2) \mapsto (\Phi_1(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1, \Psi_1(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1, \Phi_2(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2, \Psi_2(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2)$$

is canonical if and only if Φ_i and Ψ_i are of the form stated in (ii). Using the result of [21] here above in (iii) of Lemma C.3 we then achieve the proof of (ii).

Proof of (iii). Let us fix one \tilde{F}_{ε} satisfying (i). From (ii), we get that F_{ε}^* solves (iii) if and only if on one hand there exists a formal power series $S(\omega_1, \omega_2)$ such that

$$F_{\varepsilon}^* = \tilde{F}_{\varepsilon} \left(e^{\partial_{\omega_1} S(\xi_1 \eta_1, \xi_2 \eta_2)} \xi_1, e^{-\partial_{\omega_1} S(\xi_1 \eta_1, \xi_2 \eta_2)} \eta_1, e^{\partial_{\omega_2} S(\xi_1 \eta_1, \xi_2 \eta_2)} \xi_2, e^{-\partial_{\omega_2} S(\xi_1 \eta_1, \xi_2 \eta_2)} \eta_2 \right), \quad (90)$$

and on the other hand, denoting $F_{\varepsilon}^* = (\varphi_{1,\varepsilon}^*, \psi_{1,\varepsilon}^*, \varphi_{2,\varepsilon}^*, \psi_{2,\varepsilon}^*)$, the criteria (87) is verified, i.e.

$$\omega_1 \left(\left[\frac{\varphi_{1,\varepsilon}^*}{\xi_1} \right] (\omega_1, \omega_2) - \left[\frac{\psi_{1,\varepsilon}^*}{\eta_1} \right] (\omega_1, \omega_2) \right) + i \omega_2 \left(\left[\frac{\varphi_{2,\varepsilon}^*}{\xi_2} \right] (\omega_1, \omega_2) - \left[\frac{\psi_{2,\varepsilon}^*}{\eta_2} \right] (\omega_1, \omega_2) \right) = 0.$$

Let us show that for this \tilde{F}_{ε} there exists a unique S such that F_{ε}^* satisfies those two conditions (except $S(0,0)$ that does not need to be unique). Denoting $\tilde{F}_{\varepsilon} :=$

$(\tilde{\varphi}_{1,\varepsilon}, \tilde{\psi}_{1,\varepsilon}, \tilde{\varphi}_{2,\varepsilon}, \tilde{\psi}_{2,\varepsilon})$, from (90) we get for $i = 1, 2$

$$\begin{aligned} \left[\frac{\varphi_{i,\varepsilon}^*}{\xi_i} \right](\omega_1, \omega_2) &= e^{\partial_{\omega_i} S(\omega_1, \omega_2)} \left[\frac{\tilde{\varphi}_{i,\varepsilon}}{\xi_i} \right](\omega_1, \omega_2), \\ \left[\frac{\psi_{i,\varepsilon}^*}{\eta_i} \right](\omega_1, \omega_2) &= e^{-\partial_{\omega_i} S(\omega_1, \omega_2)} \left[\frac{\tilde{\psi}_{i,\varepsilon}}{\eta_i} \right](\omega_1, \omega_2), \end{aligned}$$

Recall that $\tilde{F}_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2) = (\xi_1, \eta_1, \xi_2, \eta_2) + \mathcal{O}(|(\xi_1, \eta_1, \xi_2, \eta_2)|^2)$, thus $\left[\frac{\tilde{\varphi}_{i,\varepsilon}}{\xi_i} \right] = 1 + \dots$ and $\left[\frac{\tilde{\psi}_{i,\varepsilon}}{\eta_i} \right] = 1 + \dots$. Then (87) holds if and only if

$$\begin{aligned} -2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})S &= \omega_1 \left[(e^{\partial_{\omega_1} S} - (1 + \partial_{\omega_1} S)) + \left(\left[\frac{\tilde{\varphi}_{1,\varepsilon}}{\xi_1} \right] - 1 \right) e^{\partial_{\omega_1} S} \right. \\ &\quad \left. - (e^{-\partial_{\omega_1} S} - (1 - \partial_{\omega_1} S)) - \left(\left[\frac{\tilde{\psi}_{1,\varepsilon}}{\eta_1} \right] - 1 \right) e^{-\partial_{\omega_1} S} \right] \\ &\quad + i\omega_2 \left[(e^{\partial_{\omega_2} S} - (1 + \partial_{\omega_2} S)) + \left(\left[\frac{\tilde{\varphi}_{2,\varepsilon}}{\xi_2} \right] - 1 \right) e^{\partial_{\omega_2} S} \right. \\ &\quad \left. - (e^{-\partial_{\omega_2} S} - (1 - \partial_{\omega_2} S)) - \left(\left[\frac{\tilde{\psi}_{2,\varepsilon}}{\eta_2} \right] - 1 \right) e^{-\partial_{\omega_2} S} \right]. \end{aligned} \quad (91)$$

Recall that $S(0, 0)$ does not need to be unique to complete the proof. Let us choose $S(0, 0) = 0$ and denote

$$S(\omega_1, \omega_2) := \sum_{N \geq 1} S^N(\omega_1, \omega_2),$$

where the S^N are homogeneous polynomials of degree N . Then (91) reads

$$\begin{cases} -2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})S^1 &= 0, \\ -2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})S^N &= \mathcal{F}_N(S^M, 1 \leq M < N) \quad \text{for } N \geq 2. \end{cases} \quad (92)$$

Computing the images of the monomials through the operator $(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})$, we observe that it is invertible on the set of formal power series without monomial of degree 0. Then 92 allows to construct S without monomial of degree 0 in a unique way. \square

The following Lemma gives a more precise description of $F_{(\varepsilon, 0, 0)}^*$.

Lemma C.7. $F_{(\varepsilon, 0, 0)}^*$ is independent of ε ; then we denote it $F_{(\varepsilon, 0, 0)}^* = F_0^*$. Moreover F_0^* is of the form

$$F_0^*(\xi_1, \eta_1, \xi_2, \eta_2) = (\varphi_{1,0}^*(\xi_1, \eta_1), \psi_{1,0}^*(\xi_1, \eta_1), \xi_2, \eta_2). \quad (93)$$

Proof. We proceed in 2 main steps.

Step 1. Construction of a $\tilde{F}_{(\varepsilon, 0, 0)}$ independent of ε , of the form (93).

Following the strategy of proof of (i) of Lemma C.5, it is sufficient to prove that we can construct $W_{(\varepsilon, 0, 0)}$ and $K_{(\varepsilon, 0, 0)}$ of the form

$$W_{(\varepsilon, 0, 0)}(x, \eta) = x_1 \eta_1 + x_2 \eta_2 + W'(x_1, \eta_1), \quad K_{(\varepsilon, 0, 0)}(\omega_1, \omega_2) = -\alpha_1 \omega_1 - i \frac{\alpha_2(\varepsilon)}{\varepsilon^2} + K'(\omega_1).$$

We use the particular form of \mathbf{H} when $\nu = 0$ (see (62)). Denoting $D_1 = x_1 \partial_{x_1} - \eta_1 \partial_{\eta_1}$, we obtain that $W_{(\varepsilon, 0, 0)}$ and $K_{(\varepsilon, 0, 0)}$ satisfy (i) of Lemma C.5 if and only if

$$-\alpha_1 D_1 W'(x_1, \eta_1) = K'((x_1 + \partial_{\eta_1} W'(x_1, \eta_1))\eta_1) - h(x_1, \eta_1 + \partial_{x_1} W'(x_1, \eta_1)). \quad (94)$$

Note that this equation is independent of ε . Let us show that we can construct such W' and K' . Denote

$$W'(x_1, \eta_1) = \sum_{N \geq 3} W'^N(x_1, \eta_1), \quad K'(\omega_1) = \sum_{N \geq 2} K'^N(\omega_1),$$

where the W'^N, K'^N are homogeneous polynomials of degree N . At degree N , (94) reads

$$-\alpha_1 D_1 W'^N(x_1, \eta_1) - K'^N(x_1 \eta_1) = \mathcal{F}_N(W'^M, K'^M, M < N).$$

Recall that $\alpha_1 \neq 0$. As in the proof of (i) of Lemma C.5, $\alpha_1 D_1$ is invertible on the set of formal power series without monomials of the form $(x_1 \eta_1)^m$, and we get the existence proceeding by induction with the same strategy.

Step 2. Construction of $F_{(\varepsilon, 0, 0)}^*$ independent of ε and of the form (93).

Following the strategy of construction of the proof of (iii) of Lemma C.5, it is sufficient to prove that we can construct

$$F_{(\varepsilon, 0, 0)}^* = \tilde{F}_{(\varepsilon, 0, 0)} \left(e^{\partial_{\omega_i} S_{(\varepsilon, 0, 0)}(\xi_1 \eta_1, \xi_2 \eta_2)} \xi_i, e^{-\partial_{\omega_i} S_{(\varepsilon, 0, 0)}(\xi_1 \eta_1, \xi_2 \eta_2)} \eta_i; i = 1, 2 \right),$$

with the $\tilde{F}_{(\varepsilon, 0, 0)} = \tilde{F}_0$ of Step 1 above, and

$$S_{(\varepsilon, 0, 0)}(\omega_1, \omega_2) = S_0(\omega_1).$$

Given that \tilde{F}_0 is of the form (93), the criteria (87) reads

$$\begin{aligned} \omega_1 \left(e^{\partial_{\omega_1} S_0(\omega_1)} \left[\frac{\tilde{\varphi}_{1,0}}{\xi_1} \right] (\omega_1) - e^{-\partial_{\omega_1} S_0(\omega_1)} \left[\frac{\tilde{\psi}_{1,0}}{\eta_1} \right] (\omega_1) \right) &= 0 \\ \Leftrightarrow -2\omega_1 \partial_{\omega_1} S_0(\omega_1) &= \omega_1 \left[(e^{\partial_{\omega_1} S_0(\omega_1)} - (1 + \partial_{\omega_1} S_0(\omega_1))) + \left(\left[\frac{\tilde{\varphi}_{1,0}}{\xi_1} \right] - 1 \right) e^{\partial_{\omega_1} S_0(\omega_1)} \right. \\ &\quad \left. - (e^{-\partial_{\omega_1} S_0(\omega_1)} - (1 - \partial_{\omega_1} S_0(\omega_1))) - \left(\left[\frac{\tilde{\psi}_{1,0}}{\eta_1} \right] - 1 \right) e^{-\partial_{\omega_1} S_0(\omega_1)} \right]. \end{aligned}$$

This equation is independent of ε and admits a unique solution $S_0(\omega_1)$: the proof is similar to that of (iii) of Lemma C.5. \square

C.4. Upper bound of $F_{\varepsilon}^* - F_0^*$. In this part, we state in the Lemma C.9 that $F_{\varepsilon}^* - F_0^*$ admits an upper bound of the form of those of Proposition C.1. But firstly, we prove the technical Lemma C.8 which will be useful to prove Lemma C.9.

Lemma C.8. *Let Φ be a vectorial formal power series of the form*

$$\Phi: (\xi_1, \eta_1, \xi_2, \eta_2) \mapsto (\Phi_1(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1, \Psi_1(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1, \Phi_2(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2, \Psi_2(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2),$$

where $\Phi_1, \Psi_1, \Phi_2, \Psi_2$ are formal power series satisfying

$$\Phi_1(0, 0) = 1 = \Psi_1(0, 0) = \Phi_2(0, 0) = \Psi_2(0, 0).$$

Then there exist some formal power series $\Phi_1^-, \Psi_1^-, \Phi_2^-, \Psi_2^-$ such that

$$\Phi^-: (\xi_1, \eta_1, \xi_2, \eta_2) \mapsto (\Phi_1^-(\xi_1 \eta_1, \xi_2 \eta_2) \xi_1, \Psi_1^-(\xi_1 \eta_1, \xi_2 \eta_2) \eta_1, \Phi_2^-(\xi_1 \eta_1, \xi_2 \eta_2) \xi_2, \Psi_2^-(\xi_1 \eta_1, \xi_2 \eta_2) \eta_2).$$

Proof. Let us denote the inverse of Φ

$$\Phi^{-1} : (\xi_1, \eta_1, \xi_2, \eta_2) \mapsto \left(\tilde{\Phi}_1(\xi_1, \eta_1, \xi_2, \eta_2), \tilde{\Psi}_1(\xi_1, \eta_1, \xi_2, \eta_2), \tilde{\Phi}_2(\xi_1, \eta_1, \xi_2, \eta_2), \tilde{\Psi}_2(\xi_1, \eta_1, \xi_2, \eta_2) \right).$$

We want to prove that $\tilde{\Phi}_1$ reads $\xi_1 \Phi^{-1}(\xi_1 \eta_1, \xi_2 \eta_2)$, *i.e.* that all the monomials of the formal power series $\tilde{\Phi}_1$ are of the form $(\xi_1 \eta_1)^{n_1} (\xi_2 \eta_2)^{n_2} \xi_1$. This is equivalent to show that

$$(\xi_1 \partial_{\xi_1} - \eta_1 \partial_{\eta_1}) \tilde{\Phi}_1 = \tilde{\Phi}_1, \quad \text{and} \quad (\xi_2 \partial_{\xi_2} - \eta_2 \partial_{\eta_2}) \tilde{\Phi}_1 = 0.$$

Writing similar conditions on $\tilde{\Psi}_1, \tilde{\Phi}_2, \tilde{\Psi}_2$, we get that Lemma C.8 holds if and only if Φ satisfies

$$D\Phi^{-1}(\xi_1, \eta_1, \xi_2, \eta_2) \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & -1 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{pmatrix} \begin{pmatrix} \xi_1 \\ \eta_1 \\ \xi_2 \\ \eta_2 \end{pmatrix} = \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & -1 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{pmatrix} \Phi^{-1}(\xi_1, \eta_1, \xi_2, \eta_2), \quad (95)$$

and

$$D\Phi^{-1}(\xi_1, \eta_1, \xi_2, \eta_2) \begin{pmatrix} 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & -1 \end{pmatrix} \begin{pmatrix} \xi_1 \\ \eta_1 \\ \xi_2 \\ \eta_2 \end{pmatrix} = \begin{pmatrix} 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 1 & 0 \\ 0 & 0 & 0 & -1 \end{pmatrix} \Phi^{-1}. \quad (96)$$

We know that Φ verifies those two criteria (95) and (96). Let us prove then that Φ^{-1} satisfies (95) (same proof for (96)). From (95) verified by Φ at $(\xi_1, \eta_1, \xi_2, \eta_2) = \Phi^{-1}(\xi'_1, \eta'_1, \xi'_2, \eta'_2)$ and using

$$D\Phi^{-1}(\xi_1, \eta_1, \xi_2, \eta_2) = (D\Phi(\Phi^{-1}(\xi_1, \eta_1, \xi_2, \eta_2)))^{-1},$$

we get

$$\begin{aligned} D\Phi \circ \Phi^{-1}(\xi'_1, \eta'_1, \xi'_2, \eta'_2) \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & -1 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{pmatrix} \Phi^{-1}(\xi'_1, \eta'_1, \xi'_2, \eta'_2) \\ = \begin{pmatrix} 1 & 0 & 0 & 0 \\ 0 & -1 & 0 & 0 \\ 0 & 0 & 0 & 0 \\ 0 & 0 & 0 & 0 \end{pmatrix} \Phi \circ \Phi^{-1}(\xi'_1, \eta'_1, \xi'_2, \eta'_2). \end{aligned}$$

And this implies the result (95). \square

Lemma C.9. *For all $\underline{\varepsilon} \in]-\varepsilon_0, \varepsilon_0[$, the formal power series $F_{\underline{\varepsilon}}^*$ is a convergent series. Moreover there exists a convergent power series \mathcal{M} such that*

$$F_{\underline{\varepsilon}}^* - F_0^* \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 \mathcal{M}(\xi_1 + \eta_1 + \xi_2 + \eta_2). \quad (97)$$

Proof. To show that the $F_{\underline{\varepsilon}}^*$ are convergent, the strategy is the same as that of Rssmann [22], even if here we use a criterium (87) different from his. Here we only prove the upper bound (97).

The first key ideas of this proof are the similar upper bound proved for $F_{\underline{\varepsilon}}$ in Lemma C.4 (ii) and the result (iii) of Lemma C.3 which allows to express $F_{\underline{\varepsilon}}^*$ in term of $F_{\underline{\varepsilon}}$: there exist a vectorial formal power series

$$\begin{aligned} \Phi_{\underline{\varepsilon}} : (\xi_1, \eta_1, \xi_2, \eta_2) &\mapsto \\ &(\Phi_{1,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)\xi_1, \Psi_{1,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)\eta_1, \Phi_{2,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)\xi_2, \Psi_{2,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)\eta_2) \end{aligned}$$

where $\Phi_{i,\underline{\varepsilon}}(\omega_1, \omega_2) = 1 + \dots$ and $\Psi_{i,\underline{\varepsilon}}(\omega_1, \omega_2) = 1 + \dots$, such that

$$F_{\underline{\varepsilon}} = F_{\underline{\varepsilon}}^* \circ \Phi_{\underline{\varepsilon}}.$$

Then, in this proof we will split $\Phi_{\underline{\varepsilon}}$ into a product of maps of the form

$$\begin{aligned} F_{\underline{\varepsilon}} &= F_{\underline{\varepsilon}}^* \circ \overbrace{\left((\xi_i, \eta_i) \mapsto (\tilde{\Phi}_{i,\underline{\varepsilon}}\xi_i, \tilde{\Psi}_{i,\underline{\varepsilon}}\eta_i) \right)}^{:=\tilde{\Phi}_{\underline{\varepsilon}}} \circ \overbrace{\left((\xi_i, \eta_i) \mapsto (\Phi_{i,\underline{\varepsilon}}\Psi_{i,\underline{\varepsilon}}\xi_i, \eta_i) \right)}^{:=h_{\underline{\varepsilon}}} \\ &= \underbrace{F_{\underline{\varepsilon}}^* \circ \left((\xi_i, \eta_i) \mapsto (e^{\partial_{\omega_i} S_{\xi_i}} e^{-\partial_{\omega_i} S_{\eta_i}}) \right)}_{:= (\tilde{\varphi}_{1,\underline{\varepsilon}}, \tilde{\psi}_{1,\underline{\varepsilon}}, \tilde{\varphi}_{2,\underline{\varepsilon}}, \tilde{\psi}_{2,\underline{\varepsilon}})} \circ \underbrace{\left((\xi_i, \eta_i) \mapsto (e^{\hat{S}_{i,\underline{\varepsilon}}}\xi_i, e^{\hat{S}_{i,\underline{\varepsilon}}}\eta_i) \right) \circ g_{\varepsilon}}_{:=f_{\underline{\varepsilon}}}, \end{aligned}$$

where $g_{\varepsilon} : ((\xi_i, \eta_i) \mapsto (\Phi_{i,\underline{\varepsilon}}\Psi_{i,\underline{\varepsilon}}\xi_i, \eta_i))$ and $S_{\underline{\varepsilon}}, \hat{S}_{i,\underline{\varepsilon}}, \tilde{\Phi}_{i,\underline{\varepsilon}}, \tilde{\Psi}_{i,\underline{\varepsilon}}, \Phi_{i,\underline{\varepsilon}}, \Psi_{i,\underline{\varepsilon}}$ are power series of two variables $(\omega_1, \omega_2) = (\xi_1\eta_1, \xi_2\eta_2)$.

Remark C.10. This factorization of $F_{\underline{\varepsilon}}^*$ is the same as that used by Rssman [22] in his proof: he proves that $F_{\underline{\varepsilon}}^*$ converges by showing that every map of the factorization converges. In our proof below, we recall how these maps are constructed, but

we consider that their convergence for all fixed $\underline{\varepsilon}$ is a known fact.

Here is an outline of the proof:

Step 1.: We define $h_{\underline{\varepsilon}}$ and compute an estimate of $h_{\underline{\varepsilon}} - h_0$;

Step 2.: We introduce $\tilde{\Phi}_{\underline{\varepsilon}}$ and prove that it reads

$$\tilde{\Phi}_{\underline{\varepsilon}} : (\xi_i, \eta_i) \mapsto (e^{S_{i,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)}\xi_i, e^{-S_{i,\underline{\varepsilon}}(\xi_1\eta_1, \xi_2\eta_2)}\eta_i);$$

Step 3.: We show that the $S_{i,\underline{\varepsilon}}$ read

$$S_{i,\underline{\varepsilon}} = \hat{S}_{i,\underline{\varepsilon}} + \partial_{\omega_i} S_{\underline{\varepsilon}},$$

and prove an upper bound of $f_{\underline{\varepsilon}} - f_0$;

Step 4.: We introduce $(\tilde{\varphi}_{1,\underline{\varepsilon}}, \tilde{\psi}_{1,\underline{\varepsilon}}, \tilde{\varphi}_{2,\underline{\varepsilon}}, \tilde{\psi}_{2,\underline{\varepsilon}})$ and show an estimate of $S_{\underline{\varepsilon}} - S_0$.

The key argument of Steps 1, 2 and 3 is that $F_{\underline{\varepsilon}}^*$ is symplectic. Step 4 relies on the criterium satisfied by $F_{\underline{\varepsilon}}^*$. Let us now detail these steps.

Step 1. Let us define

$$h_{\underline{\varepsilon}} : (\xi_1, \eta_1, \xi_2, \eta_2) \mapsto ((\Phi_{1,\underline{\varepsilon}}\Psi_{1,\underline{\varepsilon}})(\xi_1\eta_1, \xi_2\eta_2)\xi_1, \eta_1, (\Phi_{2,\underline{\varepsilon}}\Psi_{2,\underline{\varepsilon}})(\xi_1\eta_1, \xi_2\eta_2)\xi_2, \eta_2).$$

Given that $F_{\underline{\varepsilon}}^*$ is symplectic, ${}^tDF_{\underline{\varepsilon}}^*\Omega DF_{\underline{\varepsilon}}^* = \Omega$ holds and thus

$${}^tDF_{\underline{\varepsilon}}\Omega DF_{\underline{\varepsilon}} = {}^tD\Phi_{\underline{\varepsilon}}{}^tDF_{\underline{\varepsilon}}^*\Omega DF_{\underline{\varepsilon}}^*D\Phi_{\underline{\varepsilon}} = {}^tD\Phi_{\underline{\varepsilon}}\Omega D\Phi_{\underline{\varepsilon}}.$$

Considering two of the coefficients of these matrix, we get

$$\begin{aligned} \partial_{\eta_1} \varphi_{1,\varepsilon} \partial_{\xi_1} \psi_{1,\varepsilon} - \partial_{\eta_1} \psi_{1,\varepsilon} \partial_{\xi_1} \varphi_{1,\varepsilon} + \partial_{\eta_1} \varphi_{2,\varepsilon} \partial_{\xi_1} \psi_{2,\varepsilon} - \partial_{\eta_1} \psi_{2,\varepsilon} \partial_{\xi_1} \varphi_{2,\varepsilon} \\ = -\partial_{\omega_1} (\Phi_{1,\varepsilon} \Psi_{1,\varepsilon} \omega_1) \\ \partial_{\eta_2} \varphi_{1,\varepsilon} \partial_{\xi_2} \psi_{1,\varepsilon} - \partial_{\eta_2} \psi_{1,\varepsilon} \partial_{\xi_2} \varphi_{1,\varepsilon} + \partial_{\eta_2} \varphi_{2,\varepsilon} \partial_{\xi_2} \psi_{2,\varepsilon} - \partial_{\eta_2} \psi_{2,\varepsilon} \partial_{\xi_2} \varphi_{2,\varepsilon} \\ = -\partial_{\omega_2} (\Phi_{2,\varepsilon} \Psi_{2,\varepsilon} \omega_2), \end{aligned} \quad (98)$$

with $F_\varepsilon := (\varphi_{1,\varepsilon}, \psi_{1,\varepsilon}, \varphi_{2,\varepsilon}, \psi_{2,\varepsilon})$ and where $\Phi_{i,\varepsilon}, \Psi_{i,\varepsilon}$ are formal power series of two variables $(\omega_1, \omega_2) = (\xi_1 \eta_1, \xi_2 \eta_2)$.

On one hand, from the result (ii) of Lemma C.4 we get the existence of a convergent power series \mathcal{M}_1 such that

$$\partial_{\xi_1} (F_\varepsilon - F_0)(\xi_1, \eta_1, \xi_2, \eta_2) \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2) \mathcal{M}_1(\xi_1 + \eta_1 + \xi_2 + \eta_2),$$

and obtain similar upper bounds for $\partial_{\xi_2} (F_\varepsilon - F_0)$ and for the $\partial_{\eta_i} (F_\varepsilon - F_0)$. On the other hand, Lemma C.3(v) ensures that F_0 converges.

Thus, subtracting (98) for ε from (98) for $\varepsilon = (\varepsilon, 0, 0)$, we get the existence of a convergent power series \mathcal{M}_2 such that

$$\partial_{\omega_i} (\Phi_{i,\varepsilon} \Psi_{i,\varepsilon} \omega_i) - \partial_{\omega_i} (\Phi_{i,0} \Psi_{i,0} \omega_i) \prec \nu \mathcal{M}_2(\omega_1 + \omega_2).$$

From which we finally obtain the existence of a convergent power series \mathcal{M}_h such that

$$h_\varepsilon - h_0 \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2) \mathcal{M}_h(\xi_1 + \eta_1 + \xi_2 + \eta_2).$$

Step 2. Let us define

$$\tilde{\Phi}_\varepsilon := \Phi_\varepsilon \circ h_\varepsilon^{-1}.$$

Given that Φ_ε and h_ε are both of the form

$$(\xi_i, \eta_i) \mapsto (f_i(\xi_1 \eta_1, \xi_2 \eta_2) \xi_i, g_i(\xi_1 \eta_1, \xi_2 \eta_2) \eta_i)$$

with $f_i(\omega_1, \omega_2) = 1 + \dots, g_i(\omega_1, \omega_2) = 1 + \dots$, Lemma C.8 ensures that $\tilde{\Phi}_\varepsilon$ is also of this form, i.e. there exist $\tilde{\Phi}_{i,\varepsilon} = 1 + \dots, \tilde{\Psi}_{i,\varepsilon} = 1 + \dots$ such that

$$\tilde{\Phi}_\varepsilon : (\xi_i, \eta_i) \mapsto (\tilde{\Phi}_{i,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \xi_i, \tilde{\Psi}_{i,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2) \eta_i).$$

Let us show that for $i = 1, 2$, $\tilde{\Phi}_{i,\varepsilon}$ and $\tilde{\Psi}_{i,\varepsilon}$ satisfy

$$\tilde{\Phi}_{i,\varepsilon}(\omega_1, \omega_2) \tilde{\Psi}_{i,\varepsilon}(\omega_1, \omega_2) = 1. \quad (99)$$

From the definition $\tilde{\Phi}_\varepsilon \circ h_\varepsilon = \Phi_\varepsilon$ of $\tilde{\Phi}_\varepsilon$, we get that for $i = 1, 2$

$$\begin{cases} \tilde{\Phi}_{i,\varepsilon}(\Phi_{1,\varepsilon} \Psi_{1,\varepsilon}(\omega_1, \omega_2) \omega_1, \Phi_{2,\varepsilon} \Psi_{2,\varepsilon}(\omega_1, \omega_2) \omega_2) \Phi_{i,\varepsilon} \Psi_{i,\varepsilon}(\omega_1, \omega_2) = \Phi_{i,\varepsilon}(\omega_1, \omega_2) \\ \tilde{\Psi}_{i,\varepsilon}(\Phi_{1,\varepsilon} \Psi_{1,\varepsilon}(\omega_1, \omega_2) \omega_1, \Phi_{2,\varepsilon} \Psi_{2,\varepsilon}(\omega_1, \omega_2) \omega_2) = \Psi_{i,\varepsilon}(\omega_1, \omega_2). \end{cases}$$

and then, for $i = 1, 2$

$$\tilde{\Phi}_{i,\varepsilon}(\Phi_{1,\varepsilon} \Psi_{1,\varepsilon} \omega_1, \Phi_{2,\varepsilon} \Psi_{2,\varepsilon} \omega_2) \tilde{\Psi}_{i,\varepsilon}(\Phi_{1,\varepsilon} \Psi_{1,\varepsilon} \omega_1, \Phi_{2,\varepsilon} \Psi_{2,\varepsilon} \omega_2) \Phi_{i,\varepsilon} \Psi_{i,\varepsilon} \omega_i = \Phi_{i,\varepsilon} \Psi_{i,\varepsilon} \omega_i.$$

Given that $\Phi_{1,\varepsilon} \Psi_{1,\varepsilon}(\omega_1, \omega_2) = 1 + \dots$ and $\Phi_{2,\varepsilon} \Psi_{2,\varepsilon}(\omega_1, \omega_2) = 1 + \dots$, the map

$$(\omega_1, \omega_2) \mapsto (\Phi_{1,\varepsilon} \Psi_{1,\varepsilon} \omega_1, \Phi_{2,\varepsilon} \Psi_{2,\varepsilon} \omega_2)$$

is invertible, and we then obtain

$$\tilde{\Phi}_{i,\varepsilon}(\omega_1, \omega_2) \tilde{\Psi}_{i,\varepsilon}(\omega_1, \omega_2) \omega_i = \omega_i,$$

which achieves the proof of (99). Introducing $S_{i,\varepsilon} := \ln(\tilde{\Phi}_{i,\varepsilon})$, $\tilde{\Phi}_{i,\varepsilon}$ reads

$$\tilde{\Phi}_{i,\varepsilon}(\omega_1, \omega_2) = e^{S_{i,\varepsilon}(\omega_1, \omega_2)}, \quad \tilde{\Psi}_{i,\varepsilon}(\omega_1, \omega_2) = e^{-S_{i,\varepsilon}(\omega_1, \omega_2)}.$$

Step 3. Given that F_{ε}^* is symplectic and $F_{\varepsilon} \circ h_{\varepsilon}^{-1} = F_{\varepsilon}^* \circ \tilde{\Phi}_{\varepsilon}$, we get

$${}^t D(F_{\varepsilon} \circ h_{\varepsilon}^{-1}) \Omega D(F_{\varepsilon} \circ h_{\varepsilon}^{-1}) = {}^t D\tilde{\Phi}_{\varepsilon} \Omega D\tilde{\Phi}_{\varepsilon}. \quad (100)$$

Considering the coefficients of this matrix and denoting

$$\tilde{F}_{\varepsilon} = (\tilde{\varphi}_{1,\varepsilon}, \tilde{\psi}_{1,\varepsilon}, \tilde{\varphi}_{2,\varepsilon}, \tilde{\psi}_{2,\varepsilon}) = F_{\varepsilon} \circ h_{\varepsilon}^{-1}$$

we obtain

$$\begin{aligned} \partial_{\xi_2} \tilde{\varphi}_{1,\varepsilon} \partial_{\xi_1} \tilde{\psi}_{1,\varepsilon} - \partial_{\xi_2} \tilde{\psi}_{1,\varepsilon} \partial_{\xi_1} \tilde{\varphi}_{1,\varepsilon} + \partial_{\xi_2} \tilde{\varphi}_{2,\varepsilon} \partial_{\xi_1} \tilde{\psi}_{2,\varepsilon} - \partial_{\xi_2} \tilde{\psi}_{2,\varepsilon} \partial_{\xi_1} \tilde{\varphi}_{2,\varepsilon} \\ = \eta_1 \eta_2 (\partial_{\omega_2} S_{1,\varepsilon} - \partial_{\omega_1} S_{2,\varepsilon}). \end{aligned} \quad (101)$$

From Step 1 above and (ii) of Lemma C.4, together with Lemma B.4, we get that \tilde{F}_{ε} reads

$$\tilde{F}_{\varepsilon} = \tilde{F}_0 + \nu \tilde{F}'_{\varepsilon},$$

where \tilde{F}'_{ε} has an convergent upper bound for \prec , uniform in term of ε . Then Equation (101) is of the form

$$R_0(\omega_1, \omega_2) + \nu R_{\varepsilon}(\omega_1, \omega_2) = \partial_{\omega_2} S_{1,\varepsilon}(\omega_1, \omega_2) - \partial_{\omega_1} S_{2,\varepsilon}(\omega_1, \omega_2),$$

where R_0 is convergent and R_{ε} is uniformly bounded for \prec . Let us define then

$$\hat{S}_{1,\varepsilon}(\omega_1, \omega_2) := \int_0^{\omega_2} (R_0 + \nu R_{\varepsilon})(\omega_1, t) dt, \quad \hat{S}_{2,\varepsilon}(\omega_1, \omega_2) \equiv 0,$$

and

$$\begin{aligned} f_{\varepsilon} : (\xi_1, \eta_1, \xi_2, \eta_2) \mapsto \\ (e^{\hat{S}_{1,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2)} \xi_1, e^{-\hat{S}_{1,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2)} \eta_1, e^{\hat{S}_{2,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2)} \xi_2, e^{-\hat{S}_{2,\varepsilon}(\xi_1 \eta_1, \xi_2 \eta_2)} \eta_2). \end{aligned}$$

From these definition, the $\hat{S}_{i,\varepsilon}$ and f_{ε} are also of the form

$$\hat{S}_{i,\varepsilon} := \hat{S}_{i,0} + \nu \hat{S}'_{i,\varepsilon}, \quad f_{\varepsilon} = f_0 + \nu f'_{\varepsilon}$$

with the $\hat{S}'_{i,\varepsilon}$ and f'_{ε} bounded for \prec by a convergent power series independent of ε .

Moreover, the $S_{i,\varepsilon} - \hat{S}_{i,\varepsilon}$ verify then

$$\partial_{\omega_2} (S_{1,\varepsilon} - \hat{S}_{1,\varepsilon}) - \partial_{\omega_1} (S_{2,\varepsilon} - \hat{S}_{2,\varepsilon}) = 0. \quad (102)$$

Let us define

$$S_{\varepsilon}(\omega_1, \omega_2) := \int_0^{\omega_1} (S_{1,\varepsilon} - \hat{S}_{1,\varepsilon})(t, \omega_2) dt + \int_0^{\omega_2} (S_{2,\varepsilon} - \hat{S}_{2,\varepsilon})(0, t) dt;$$

thank to (102), S_{ε} satisfies

$$\partial_{\omega_1} S_{\varepsilon} = S_{1,\varepsilon} - \hat{S}_{1,\varepsilon}, \quad \partial_{\omega_2} S_{\varepsilon} = S_{2,\varepsilon} - \hat{S}_{2,\varepsilon}.$$

Step 4. Gathering the results of Steps 1 to 3 and using Lemma B.4, we get that $F_{\underline{\varepsilon}}^*$ reads

$$\begin{aligned} F_{\underline{\varepsilon}}^* &= F_{\underline{\varepsilon}} \circ h_{ep}^{-1} \circ f_{\underline{\varepsilon}}^{-1} (e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \xi_1, e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} \eta_1, e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} \xi_2, e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} \eta_2) \\ &:= (\check{\varphi}_{1,\underline{\varepsilon}}, \check{\psi}_{1,\underline{\varepsilon}}, \check{\varphi}_{2,\underline{\varepsilon}}, \check{\psi}_{2,\underline{\varepsilon}}) (e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \xi_1, e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} \eta_1, e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} \xi_2, e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} \eta_2) \end{aligned} \quad (103)$$

where

$$(\check{\varphi}_{1,\underline{\varepsilon}}, \check{\psi}_{1,\underline{\varepsilon}}, \check{\varphi}_{2,\underline{\varepsilon}}, \check{\psi}_{2,\underline{\varepsilon}}) = (\check{\varphi}_{1,0}, \check{\psi}_{1,0}, \check{\varphi}_{2,0}, \check{\psi}_{2,0}) + \nu(\check{\varphi}'_{1,\underline{\varepsilon}}, \check{\psi}'_{1,\underline{\varepsilon}}, \check{\varphi}'_{2,\underline{\varepsilon}}, \check{\psi}'_{2,\underline{\varepsilon}}), \quad (104)$$

with $(\check{\varphi}'_{1,\underline{\varepsilon}}, \check{\psi}'_{1,\underline{\varepsilon}}, \check{\varphi}'_{2,\underline{\varepsilon}}, \check{\psi}'_{2,\underline{\varepsilon}})$ have a convergent upper bound for \prec independent of $\underline{\varepsilon}$.

Let us now study $S_{\underline{\varepsilon}}$. We proceed in several steps.

Step 4.1. Consequence of Criterion (87): equation satisfied by $S'_{\underline{\varepsilon}} := \frac{1}{\nu}(S_{\underline{\varepsilon}} - S_0)$. With the notation (103), observe that $F_{\underline{\varepsilon}}^*$ satisfies the criterium (87) if and only if

$$\begin{aligned} &\omega_1 \left(e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \left[\frac{\check{\varphi}_{1,\underline{\varepsilon}}}{\xi_1} \right] (\omega_1, \omega_2) - e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} \left[\frac{\check{\psi}_{1,\underline{\varepsilon}}}{\eta_1} \right] (\omega_1, \omega_2) \right) \\ &+ i\omega_2 \left(e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} \left[\frac{\check{\varphi}_{2,\underline{\varepsilon}}}{\xi_2} \right] (\omega_1, \omega_2) - e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} \left[\frac{\check{\psi}_{2,\underline{\varepsilon}}}{\eta_2} \right] (\omega_1, \omega_2) \right) = 0. \end{aligned}$$

The same calculations as those of the proof of Lemma C.5(iii) (to obtain equation (91)) lead to the equivalent equation

$$\begin{aligned} -2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2}) S_{\underline{\varepsilon}} &= \omega_1 \left[(e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} - (1 - \partial_{\omega_1} S_{\underline{\varepsilon}})) + \left(\left[\frac{\check{\varphi}_{1,\underline{\varepsilon}}}{\xi_1} \right] - 1 \right) e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \right. \\ &\quad \left. - (e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} - (1 + \partial_{\omega_1} S_{\underline{\varepsilon}})) - \left(\left[\frac{\check{\psi}_{1,\underline{\varepsilon}}}{\eta_1} \right] - 1 \right) e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} \right] \\ &+ i\omega_2 \left[(e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} - (1 - \partial_{\omega_2} S_{\underline{\varepsilon}})) + \left(\left[\frac{\check{\varphi}_{2,\underline{\varepsilon}}}{\xi_2} \right] - 1 \right) e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} \right. \\ &\quad \left. - (e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} - (1 + \partial_{\omega_2} S_{\underline{\varepsilon}})) - \left(\left[\frac{\check{\psi}_{2,\underline{\varepsilon}}}{\eta_2} \right] - 1 \right) e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} \right]. \end{aligned}$$

Writing this latter equation for $\underline{\varepsilon}$ and for $\underline{\varepsilon} = (\varepsilon, 0, 0)$, we get that $S'_{\underline{\varepsilon}} := \frac{1}{\nu}(S_{\underline{\varepsilon}} - S_0)$ satisfies

$$-2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2}) S'_{\underline{\varepsilon}} = \omega_1 \left[\frac{1}{\nu} (e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_1} S_0}) + \partial_{\omega_1} S'_{\underline{\varepsilon}} + \left[\frac{\check{\varphi}'_{1,\underline{\varepsilon}}}{\xi_1} \right] e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \right]$$

$$\begin{aligned}
& + \left(\left[\frac{\check{\varphi}_{1,0}}{\xi_1} \right] - 1 \right) \frac{1}{\nu} (e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_1} S_0}) \\
& \frac{1}{\nu} (e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} - e^{\partial_{\omega_1} S_0}) + \partial_{\omega_1} S'_{\underline{\varepsilon}} \\
& - \left[\frac{\check{\psi}'_{1,\underline{\varepsilon}}}{\eta_1} \right] e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} - \left(\left[\frac{\check{\psi}_{1,0}}{\eta_1} \right] - 1 \right) \frac{1}{\nu} (e^{\partial_{\omega_1} S_{\underline{\varepsilon}}} - e^{\partial_{\omega_1} S_0}) \\
& + i\omega_2 \left[\frac{1}{\nu} (e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_2} S_0}) + \partial_{\omega_2} S'_{\underline{\varepsilon}} + \left[\frac{\check{\varphi}'_{2,\underline{\varepsilon}}}{\xi_2} \right] e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} \right. \\
& + \left(\left[\frac{\check{\varphi}_{2,0}}{\xi_2} \right] - 1 \right) \frac{1}{\nu} (e^{-\partial_{\omega_2} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_2} S_0}) \\
& \left. - \frac{1}{\nu} (e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} - e^{\partial_{\omega_2} S_0}) + \partial_{\omega_2} S'_{\underline{\varepsilon}} - \left[\frac{\check{\psi}'_{2,\underline{\varepsilon}}}{\eta_2} \right] e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} \right. \\
& \left. - \left(\left[\frac{\check{\psi}_{2,0}}{\eta_2} \right] - 1 \right) \frac{1}{\nu} (e^{\partial_{\omega_2} S_{\underline{\varepsilon}}} - e^{\partial_{\omega_2} S_0}) \right].
\end{aligned} \tag{105}$$

In order to obtain a majorant series of the $S'_{\underline{\varepsilon}}$, we define

$$V_{i,\underline{\varepsilon}}(\omega_1, \omega_2) := |\partial_{\omega_i} S_{\underline{\varepsilon}}|(\omega_1, \omega_2), \quad V_{\underline{\varepsilon}}(\omega) := V_{1,\underline{\varepsilon}}(\omega, \omega) + V_{2,\underline{\varepsilon}}(\omega, \omega),$$

and compute a majorant series of the $V_{\underline{\varepsilon}}$ with the aid of (105).

Step 4.2. Lower bound of the left hand term of (105). Let us denote

$$S_{\underline{\varepsilon}} := \sum_{n_1, n_2 \in \mathbb{N}} a_{n_1, n_2} \omega_1^{n_1} \omega_2^{n_2}.$$

Then

$$\begin{aligned}
\omega_i V_{i,\underline{\varepsilon}}(\omega_1, \omega_2) &= \sum_{n_1, n_2 \in \mathbb{N}} n_i |a_{n_1, n_2}| \omega_1^{n_1} \omega_2^{n_2}, \\
|\omega_1 \partial_{\omega_1} S_{\underline{\varepsilon}} + i\omega_2 \partial_{\omega_2} S_{\underline{\varepsilon}}| &= \sum_{n_1, n_2 \in \mathbb{N}} |n_1 + in_2| |a_{n_1, n_2}| \omega_1^{n_1} \omega_2^{n_2}.
\end{aligned}$$

Given that $n_i \leq |n_1 + in_2|$, we get

$$\omega_i V_{i,\underline{\varepsilon}} \prec |\omega_1 \partial_{\omega_1} S_{\underline{\varepsilon}} + i\omega_2 \partial_{\omega_2} S_{\underline{\varepsilon}}|(\omega_1, \omega_2). \tag{106}$$

Step 4.3. Existence of an upper bound of the right hand term of (105). of the form

$$\sum_{i=1}^2 \omega_i (G_i^1(\omega_1, \omega_2) + G_i^2(\omega_1, \omega_2, V_{1,\underline{\varepsilon}}, V_{2,\underline{\varepsilon}})), \tag{107}$$

where G_i^1, G_i^2 are convergent power series independent of $\underline{\varepsilon}$ and G_i^1 is an homogeneous polynomial of degree 1 and G_i^2 is of order more than 2. To show that, let us

compute successively upper bounds of each right hand side term of (105):

$$\begin{aligned}
& \frac{1}{\nu}(e^{-\partial_{\omega_i} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_i} S_0}) - \frac{1}{\nu}(e^{-\partial_{\omega_i} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_i} S_0}) + 2\partial_{\omega_i} S'_{\underline{\varepsilon}} \\
&= -\frac{2}{\nu}(\sinh(\partial_{\omega_i} S_{\underline{\varepsilon}}) - \sinh(\partial_{\omega_i} S_0)) + 2\partial_{\omega_i} S'_{\underline{\varepsilon}} \\
&= -2\partial_{\omega_i} S'_{\underline{\varepsilon}} \sum_{p=1}^{\infty} \frac{\sum_{k=0}^{2p} (\partial_{\omega_i} S_{\underline{\varepsilon}})^k (\partial_{\omega_i} S_0)^{2p-k}}{(2p+1)!} \\
&\prec 2V_{i,\underline{\varepsilon}} \sum_{p=1}^{\infty} \frac{(2p+1)(|\partial_{\omega_i} S_0| + \nu V_{i,\underline{\varepsilon}})^{2p}}{(2p+1)!} \\
&\prec 2V_{i,\underline{\varepsilon}}(|\partial_{\omega_i} S_0| + V_{i,\underline{\varepsilon}}) \sum_{p=0}^{\infty} \frac{(|\partial_{\omega_i} S_0| + V_{i,\underline{\varepsilon}})^{2p}}{(2p+2)!};
\end{aligned}$$

(the last inequality holds for $\nu \leq 1$), where the last upper bound is of the form G_i^2 given that S_0 is convergent and independent of $\underline{\varepsilon}$.

Given that $\check{\varphi}_{1,\underline{\varepsilon}}$ is of the form (104), there exists a convergent series \mathcal{M} independent of $\underline{\varepsilon}$ such that

$$\begin{aligned}
\left| \left[\frac{\check{\varphi}'_{1,\underline{\varepsilon}}}{\xi_1} \right] e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} \right|(\omega_1, \omega_2) &= \left| \left[\frac{\check{\varphi}'_{1,\underline{\varepsilon}}}{\xi_1} \right] + \left[\frac{\check{\varphi}'_{1,\underline{\varepsilon}}}{\xi_1} \right] (e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} - 1) \right|(\omega_1, \omega_2) \\
&\prec (\omega_1 + \omega_2) \mathcal{M}(\omega_1, \omega_2) (1 + (e^{|\partial_{\omega_1} S_{\underline{\varepsilon}}|(\omega_1, \omega_2)} - 1)) \\
&\prec (\omega_1 + \omega_2) \mathcal{M}(0, 0) + (\omega_1 + \omega_2) (\mathcal{M}(\omega_1, \omega_2) - \mathcal{M}(0, 0) \\
&\quad + \mathcal{M}(\omega_1, \omega_2)(\exp - 1) \circ (|\partial_{\omega_1} S_0| + V_{1,\underline{\varepsilon}}))
\end{aligned}$$

which is of the form (107) given that for all $\underline{\varepsilon}$, $|\partial_{\omega_i} S_{\underline{\varepsilon}}|(0, 0) = 0$ holds because

$$\partial_{\omega_i} S_{\underline{\varepsilon}}(0, 0) = S_{i,\underline{\varepsilon}}(0, 0) - \hat{S}_{i,\underline{\varepsilon}}(0, 0) = S_{i,\underline{\varepsilon}}(0, 0),$$

where

$$e^{S_{i,\underline{\varepsilon}}(\omega_1, \omega_2)} = \Phi_{\underline{\varepsilon}}(\omega_1, \omega_2) = 1 + \dots$$

We get similarly an upper bound of $\left[\frac{\check{\psi}'_{1,\underline{\varepsilon}}}{\eta_1} \right] e^{\partial_{\omega_1} S_{\underline{\varepsilon}}}$.

Finally,

$$\begin{aligned}
& \left| \left[\frac{\check{\varphi}_{1,0}}{\xi_1} \right] - 1 \right| \frac{1}{\nu} |e^{-\partial_{\omega_1} S_{\underline{\varepsilon}}} - e^{-\partial_{\omega_1} S_0}| \\
&\prec \left| \left[\frac{\check{\varphi}_{1,0}}{\xi_1} \right] - 1 \right| \frac{1}{\nu} |-\partial_{\omega_1} S_{\underline{\varepsilon}} - (-\partial_{\omega_1} S_0)| e^{|\partial_{\omega_1} S_{\underline{\varepsilon}}| + |\partial_{\omega_1} S_0|} \quad \text{by Lemma B.3} \\
&\prec \left| \left[\frac{\check{\varphi}_{1,0}}{\xi_1} \right] - 1 \right| V_{1,\underline{\varepsilon}} e^{2|\partial_{\omega_1} S_0| + V_{1,\underline{\varepsilon}}} \quad \text{for } \nu \leq 1,
\end{aligned}$$

which is of the form G_i^2 .

Step. Equation of construction of the majorant series Z . Gathering the results of Steps 4.1, 4.2 and 4.3, we obtain that $V_{\underline{\varepsilon}}$ satisfies

$$\begin{aligned}
\omega V_{\underline{\varepsilon}}(\omega) &\prec \omega \left(G_1^1(\omega, \omega) + G_2^1(\omega, \omega) \right. \\
&\quad \left. + G_1^2(\omega, \omega, V_{\underline{\varepsilon}}(\omega), V_{\underline{\varepsilon}}(\omega)) + G_2^2(\omega, \omega, V_{\underline{\varepsilon}}(\omega), V_{\underline{\varepsilon}}(\omega)) \right)
\end{aligned}$$

Hence

$$V_{\underline{\varepsilon}}(\omega) \prec c\omega + c \frac{(\omega + V_{\underline{\varepsilon}}(\omega))^2}{1 - \gamma(\omega + V_{\underline{\varepsilon}}(\omega))} \quad (108)$$

by (iv) of Lemma B.2.

Let us construct a convergent power series $Z(\omega)$ such that

$$Z(\omega) = c\omega + c \frac{(\omega + Z(\omega))^2}{1 - \gamma(\omega + Z(\omega))},$$

and prove by induction on the coefficients of the series that $V_{\underline{\varepsilon}} \prec Z(\omega)$.

Step 4.5. Initialization of the induction (if existence of Z). Thank to (108) the proof by induction works if we prove the initialization. At degree 1 in (ω_1, ω_2) , (105) reads

$$2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})(S'_{\underline{\varepsilon}})_1 = 0$$

given that the right hand side (105) is of the form (107). Thus the degree 1 term of $S'_{\underline{\varepsilon}}$, $(S'_{\underline{\varepsilon}})_1$ vanishes. At degree 2 in (ω_1, ω_2) , (105) gives

$$2(\omega_1 \partial_{\omega_1} + i\omega_2 \partial_{\omega_2})(S'_{\underline{\varepsilon}})_2 = \sum_{i=1}^2 \omega_i \left(\left[\frac{\check{\varphi}'_{1,\underline{\varepsilon}}}{\xi_1} \right]_1 - \left[\frac{\check{\psi}'_{1,\underline{\varepsilon}}}{\eta_1} \right]_1 \right);$$

where the right hand side term is uniformly bounded. Thus, there exists α independent of $\underline{\varepsilon}$ such that

$$\omega(V_{\underline{\varepsilon}})_1(\omega) \prec \alpha\omega^2.$$

Step 4.6. Existence of Z . To satisfy the initialization assumption, we look for Z satisfying

$$Z(\omega) = c\omega + c \frac{(\omega + Z(\omega))^2}{1 - \gamma(\omega + Z(\omega))} \quad \text{and} \quad Z(\omega) = \omega Z_1(\omega), \quad \text{with } Z_1(0) \geq \alpha;$$

i.e. we look for Z_1 such that

$$Z_1 \cdot (1 - \gamma\omega(1 + Z_1)) - c(1 - \gamma\omega(1 + Z_1)) - c\omega(1 + Z_1)^2 = 0 \iff \mathcal{F}(Z_1, \omega) = 0.$$

This equation, independent of $\underline{\varepsilon}$, satisfies the assumptions of the analytic Implicit Functions Theorem in the neighborhood of $(\omega, Z_1) = (0, \alpha)$. Thus we get the existence of the analytic function Z_1 , i.e. a convergent power series in the neighborhood of 0.

Choosing $S'_{\underline{\varepsilon}}(0, 0) = 0$ (possible because only the derivatives of $S'_{\underline{\varepsilon}}$ are in the definition of $F_{\underline{\varepsilon}}^*$), we obtain the upper bound

$$\begin{aligned} S'_{\underline{\varepsilon}}(\omega_1, \omega_2) &\prec S'_{\underline{\varepsilon}}(0, 0) + \omega_1 V_{1,\underline{\varepsilon}}(\omega_1, \omega_2) + \omega_2 V_{2,\underline{\varepsilon}}(\omega_1, \omega_2) \\ &\prec (\omega_1 + \omega_2) V_{\underline{\varepsilon}}(\omega_1 + \omega_2) \\ &\prec (\omega_1 + \omega_2) Z_1(\omega_1 + \omega_2), \end{aligned}$$

where Z_1 is a convergent power series independent of $\underline{\varepsilon}$.

Step 5. Conclusion of the Lemma's proof. $F_{\underline{\varepsilon}}^*$ reads

$$F_{\underline{\varepsilon}}^* = F_{\underline{\varepsilon}} \circ h_{\underline{\varepsilon}}^{-1} \circ f_{\underline{\varepsilon}}^{-1} \circ ((\xi_i, \eta_i) \mapsto (e^{-\partial_{\omega_i} S_{\underline{\varepsilon}}} \xi_i, e^{\partial_{\omega_i} S_{\underline{\varepsilon}}} \eta_i)).$$

And thank to Lemma B.4 and to the results of the previous steps, this is a product of formal power series of the form $R_{\underline{\varepsilon}} = R_0 + \nu R'_{\underline{\varepsilon}}$ where R_0 , $R_{\underline{\varepsilon}}$ are convergent and admit a convergent upper bound \mathcal{M} independent of $\underline{\varepsilon}$. Thus $F_{\underline{\varepsilon}}^*$ is also of this form $R_0 + \nu R'_{\underline{\varepsilon}}$. Moreover, $F_{\underline{\varepsilon}}^*$ is defined as

$$F_{\underline{\varepsilon}}^*(\xi_1, \eta_1, \xi_2, \eta_2) = (\xi_1, \eta_1, \xi_2, \eta_2) + \cdots, \quad F_0^*(\xi_1, \eta_1, \xi_2, \eta_2) = (\xi_1, \eta_1, \xi_2, \eta_2) + \cdots,$$

so that we can chose the upper bound of $F_{\underline{\varepsilon}}^* - F_0^*$ without monomials of degree 0 and 1 ; *i.e.* there exists a convergent power series \mathcal{M} such that

$$(F_{\underline{\varepsilon}}^* - F_0^*)(\xi_1, \eta_1, \xi_2, \eta_2) \prec \nu(\xi_1 + \eta_1 + \xi_2 + \eta_2)^2 \mathcal{M}(\xi_1 + \eta_1 + \xi_2 + \eta_2).$$

□

C.5. Back in \mathbb{R}^4 , proof of Proposition C.1.

Lemma C.11. 1. Define $\mathcal{F}_{\underline{\varepsilon}} := \mathcal{P}^{-1} F_{\underline{\varepsilon}}^* \mathcal{P}$, where $F_{\underline{\varepsilon}}^*$ was introduced in Lemma C.5. Then

$$\overline{\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2)} = \mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2); \quad (109)$$

i.e. $\mathcal{F}_{\underline{\varepsilon}}$ is a real power series with real.

2. There exists $K_{\underline{\varepsilon}}$ such that

$$H(\mathcal{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon}) = K_{\underline{\varepsilon}}(\xi_1 \eta_1, \xi_2^2 + \eta_2^2).$$

Proof of (i). In this proof we use the following notation if the power series f reads $f(x) = \sum_{n \in \mathbb{N}^d} a_n x^n$, then we denote

$$\bar{f}(x) := \sum_{n \in \mathbb{N}^d} \overline{a_n} x^n.$$

Let us define

$$J_1 : \begin{array}{ccc} \mathbb{C}^4 & \rightarrow & \mathbb{C}^4 \\ (\xi_1, \eta_1, \xi_2, \eta_2) & \mapsto & (\overline{\xi_1}, \overline{\eta_1}, \overline{\xi_2}, \overline{\eta_2}), \end{array}$$

and denote $J_2 := \mathcal{P} J_1 \mathcal{P}^{-1}$. Then $J_2(\xi'_1, \eta'_1, \xi'_2, \eta'_2) = (\overline{\xi'_1}, \overline{\eta'_1}, i \overline{\eta'_2}, i \overline{\xi'_2})$. And we get that the equality (109) is satisfied if and only if

$$J_2 F_{\underline{\varepsilon}}^* J_2 = F_{\underline{\varepsilon}}^*. \quad (110)$$

To prove that (110) holds we use the uniqueness of the $F_{\underline{\varepsilon}}^*$ of (iii) in Lemma C.5: let us prove that $\check{F}_{\underline{\varepsilon}} := J_2 F_{\underline{\varepsilon}}^* J_2$ verifies the conditions of (iii) of Lemma C.5.

Condition 1: $\check{F}_{\underline{\varepsilon}}$ is symplectic. From part C.1 we know that \mathcal{P} is symplectic, so it is equivalent to prove that $\mathcal{P}^{-1} \check{F}_{\underline{\varepsilon}} \mathcal{P}$ is symplectic, what holds if and only if

$${}^t D \mathcal{F}_{\underline{\varepsilon}} \Omega D \mathcal{F}_{\underline{\varepsilon}} = \Omega$$

holds. And this holds given that $\mathcal{F}_{\underline{\varepsilon}}$ is symplectic and Ω is real.

Condition 2: $\underline{H}(\check{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon})$ is a function of $\xi_1 \eta_1$, $\xi_2 \eta_2$ and $\underline{\varepsilon}$. Recall that lemmas C.3, C.4, C.5, C.7 and C.9 were proved for a general Hamiltonian \mathbf{H} introduced in (62), and observe that the Hamiltonian

$$\underline{H}((q'_1, p'_1, q'_2, p'_2), \underline{\varepsilon}) := H(\mathcal{P}^{-1}(q'_1, p'_1, q'_2, p'_2), \underline{\varepsilon})$$

is of the form (62). Moreover, the Hamiltonian H is a real power series and from Lemma C.5, we know that

$$\underline{H}(F_{\underline{\varepsilon}}^*(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon}) = K_{\underline{\varepsilon}}(\xi_1 \eta_1, \xi_2 \eta_2).$$

Then a short computation leads to

$$\underline{H}(\check{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon}) = \overline{K_{\underline{\varepsilon}}}(\xi_1 \eta_1, -\xi_2 \eta_2).$$

Condition 3: $\check{F}_{\underline{\varepsilon}}$ satisfies the criteria (87). Fix $\underline{\varepsilon}$, and denote

$$\begin{aligned}\check{F}_{\underline{\varepsilon}}(\xi_1, \eta_1, \xi_2, \eta_2) &:= (\check{\varphi}_1, \check{\psi}_1, \check{\varphi}_2, \check{\psi}_2)(\xi_1, \eta_1, \xi_2, \eta_2); \\ F_{\underline{\varepsilon}}^*(\xi_1, \eta_1, \xi_2, \eta_2) &:= (\varphi_1^*, \psi_1^*, \varphi_2^*, \psi_2^*)(\xi_1, \eta_1, \xi_2, \eta_2).\end{aligned}$$

Then we get

$$\begin{aligned}\check{\varphi}_1(\xi_1, \eta_1, \xi_2, \eta_2) &= \overline{\varphi_1^*}(\xi_1, \eta_1, -i\eta_2, -i\xi_2), \quad \check{\varphi}_2(\xi_1, \eta_1, \xi_2, \eta_2) = i \overline{\psi_2^*}(\xi_1, \eta_1, -i\eta_2, -i\xi_2), \\ \check{\psi}_1(\xi_1, \eta_1, \xi_2, \eta_2) &= \overline{\psi_1^*}(\xi_1, \eta_1, -i\eta_2, -i\xi_2), \quad \check{\psi}_2(\xi_1, \eta_1, \xi_2, \eta_2) = i \overline{\varphi_2^*}(\xi_1, \eta_1, -i\eta_2, -i\xi_2).\end{aligned}$$

Let us express $\left[\frac{\check{\varphi}_1}{\xi_1}\right]$ in terms of $\left[\frac{\varphi_1^*}{\xi_1}\right]$. Let us denote

$$\varphi_1^* := \sum_{m, n \in \mathbb{N}^2} \alpha_{m, n} \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2},$$

then we obtain successively

$$\begin{aligned}\left[\frac{\varphi_1^*}{\xi_1}\right] &= \sum_{\substack{m_2=n_2 \\ m_1=n_1+1}} \alpha_{m, n} (\xi_1 \eta_1)^{n_1} (\xi_2 \eta_2)^{n_2}, \\ \overline{\varphi_1^*}(\xi_1, \eta_1, -i\eta_2, -i\xi_2) &= \sum_{m, n \in \mathbb{N}^2} \overline{\alpha_{m, n}} (-i)^{m_2+n_2} \xi_1^{m_1} \eta_1^{n_1} \xi_2^{m_2} \eta_2^{n_2} \\ \left[\frac{\check{\varphi}_1}{\xi_1}\right](\xi_1, \eta_1, \xi_2, \eta_2) &= \sum_{\substack{m_2=n_2 \\ m_1=n_1+1}} \overline{\alpha_{m, n}} (-i)^{2n_2} (\xi_1 \eta_1)^{n_1} (\xi_2 \eta_2)^{n_2} \\ &= \overline{\left[\frac{\varphi_1^*}{\xi_1}\right]}(\xi_1 \eta_1, -\xi_2 \eta_2).\end{aligned}$$

Similarly, we get

$$\begin{aligned}\left[\frac{\check{\psi}_1}{\eta_1}\right](\xi_1 \eta_1, \xi_2 \eta_2) &= \overline{\left[\frac{\psi_1^*}{\eta_1}\right]}(\xi_1 \eta_1, -\xi_2 \eta_2), \\ \left[\frac{\check{\varphi}_2}{\xi_2}\right](\xi_1 \eta_1, \xi_2 \eta_2) &= -\overline{\left[\frac{\psi_2^*}{\eta_2}\right]}(\xi_1 \eta_1, -\xi_2 \eta_2), \\ \left[\frac{\check{\psi}_2}{\eta_2}\right](\xi_1 \eta_1, \xi_2 \eta_2) &= -\overline{\left[\frac{\varphi_2^*}{\xi_2}\right]}(\xi_1 \eta_1, -\xi_2 \eta_2).\end{aligned} \tag{111}$$

Then, using the fact that $F_{\underline{\varepsilon}}^*$ satisfies (87), we obtain that for all (ω_1, ω_2) ,

$$\begin{aligned}&\omega_1 \left(\left[\frac{\check{\varphi}_1}{\xi_1}\right] - \left[\frac{\check{\psi}_1}{\eta_1}\right] \right) (\omega_1, \omega_2) + i\omega_2 \left(\left[\frac{\check{\varphi}_2}{\xi_2}\right] - \left[\frac{\check{\psi}_2}{\eta_2}\right] \right) (\omega_1, \omega_2) \\ &= \overline{\omega_1 \left(\left[\frac{\varphi_1^*}{\xi_1}\right] - \left[\frac{\psi_1^*}{\eta_1}\right] \right) + i\omega_2 \left(\left[\frac{\varphi_2^*}{\xi_2}\right] - \left[\frac{\psi_2^*}{\eta_2}\right] \right)} (\omega_1, -\omega_2) = 0,\end{aligned}$$

i.e. $\check{F}_{\underline{\varepsilon}}$ satisfies the criteria (87). \square

Proof of (ii). From Lemma C.5, there exists $K_{\underline{\varepsilon}}^*$ such that $F_{\underline{\varepsilon}}^*$ verifies

$$\underline{H}(F_{\underline{\varepsilon}}^*(\xi_1, \eta_1, \xi_2, \eta_2), \underline{\varepsilon}) = K_{\underline{\varepsilon}}^*(\xi_1 \eta_1, \xi_2 \eta_2).$$

Then we obtain

$$\begin{aligned} H(\mathcal{F}_\varepsilon(\xi_1, \eta_1, \xi_2, \eta_2), \varepsilon) &= H(\mathcal{P}^{-1}F_\varepsilon^*\mathcal{P}(\xi_1, \eta_1, \xi_2, \eta_2), \varepsilon) \\ &= \underline{H}(F_\varepsilon^*(\xi_1, \eta_1, \frac{1}{\sqrt{2}}(\xi_2 + i\eta_2), \frac{1}{\sqrt{2}}(\eta_2 + i\xi_2)), \varepsilon) = K_\varepsilon^*(\xi_1\eta_1, \frac{i}{2}(\xi_2^2 + \eta_2^2)). \end{aligned}$$

Thus (ii) holds with $K_\varepsilon(\xi_1\eta_1, \xi_2^2 + \eta_2^2) := K_\varepsilon^*(\xi_1\eta_1, \frac{i}{2}(\xi_2^2 + \eta_2^2))$. \square

Proof of Proposition C.1. Let us prove that the family \mathcal{F}_ε defined in Lemma C.11 satisfies the results claimed in Proposition C.1. Let ρ'_0 be such that $\rho'_0 < \rho_0$ and $4\rho'_0$ is a radius of convergence of the power series \mathcal{M} of Lemma C.9 and such that ρ'_0 is a radius of convergence of F_0^* (recall that Lemma C.9 ensures that F_0^* is convergent). And define $\mathcal{M}_0 := \|\mathcal{M}\|_{\mathcal{A}(\mathcal{B}(0, 4\rho'_0))}$.

Then (60) holds thank to (ii) of Lemma C.11 and (61) is a consequence of Lemma C.7.

(i) is a consequence of Lemma C.9 ; (ii) and (iii) hold thank to Lemma C.9 and because the monomial of degree 1 of $F_0^*(\xi_1, \eta_1, \xi_2, \eta_2)$ is $(\xi_1, \eta_1, \xi_2, \eta_2)$ and the monomial of degree 1 of $(F_0^*)^{-1}(q_1, p_1, q_2, p_2)$ is (q_1, p_1, q_2, p_2) .

We get (iv) from (i) above and (vi) of Lemma B.2 ; we obtain (v) from (i) above together with Lemma B.4 and (vi) of Lemma B.2 ; (vi) and (vii) are a consequence of (i) and (ii) above and of Lemma B.2-(vi) ; we get (viii) and (ix) from (vi) and Lemma C.7. \square
