# LOCATION OF EIGENVALUES FOR THE WAVE EQUATION WITH DISSIPATIVE BOUNDARY CONDITIONS

#### Abstract

We examine the location of the eigenvalues of the generator $G$ of a semi-group $V(t)=e^{t G}, t \geq 0$, related to the wave equation in an unbounded domain $\Omega \subset \mathbb{R}^{d}$ with dissipative boundary condition $\partial_{\nu} u-\gamma(x) \partial_{t} u=0$ on $\Gamma=\partial \Omega$. We study two cases: $(A): 0<\gamma(x)<1, \forall x \in \Gamma$ and $(B): 1<$ $\gamma(x), \forall x \in \Gamma$. We prove that for every $0<\epsilon \ll 1$, the eigenvalues of $G$ in the case $(A)$ lie in the region $\Lambda_{\epsilon}=\left\{z \in \mathbb{C}:|\operatorname{Re} z| \leq C_{\epsilon}\left(|\operatorname{Im} z|^{\frac{1}{2}+\epsilon}+1\right), \operatorname{Re} z<0\right\}$, while in the case $(B)$ for every $0<\epsilon \ll 1$ and every $N \in \mathbb{N}$ the eigenvalues lie in $\Lambda_{\epsilon} \cup \mathcal{R}_{N}$, where $\mathcal{R}_{N}=\left\{z \in \mathbb{C}:|\operatorname{Im} z| \leq C_{N}(|\operatorname{Re} z|+1)^{-N}\right.$, Re $\left.z<0\right\}$.


1. Introduction. Let $K \subset \mathbb{R}^{d}$, $d \geq 2$, be an open bounded domain and let $\Omega=\mathbb{R}^{d} \backslash \bar{K}$ be connected. We suppose that the boundary $\Gamma$ of $\Omega$ is $C^{\infty}$. Consider the boundary problem

\partial_{\nu} u-\gamma(x) \partial_{t} u=0 \text { on } \mathbb{R}_{t}^{+} \times \Gamma, \\
u(0, x)=f_{1}, u_{t}(0, x)=f_{2}
\end{array}\right.
$$

with initial data $\left(f_{1}, f_{2}\right) \in H^{1}(\Omega) \times L^{2}(\Omega)=\mathcal{H}$. Here $\nu(x)$ is the unit outward normal at $x \in \Gamma$ pointing into $\Omega$ and $\gamma(x) \geq 0$ is a $C^{\infty}$ function on $\Gamma$. The solution of the problem (1.1) is given by $\left(u(t, x), u_{t}(t, x)\right)=V(t) f=e^{t G} f, t \geq 0$, where $V(t)$ is a contraction semi-group in $\mathcal{H}$ whose generator

$$
G=\left(\begin{array}{ll}
0 & 1 \\
\Delta & 0
\end{array}\right)
$$

has a domain $D(G)$ which is the closure in the graph norm of functions $\left(f_{1}, f_{2}\right) \in C_{(0)}^{\infty}(\bar{\Omega}) \times C_{(0)}^{\infty}(\bar{\Omega})$ satisfying the boundary condition $\partial_{\nu} f_{1}-\gamma f_{2}=0$ on $\Gamma$. For $d$ odd Lax and Phillips [6] proved that the spectrum of $G$ in $\operatorname{Re} z<0$ is formed by isolated eigenvalues with finite multiplicity, while the continuous spectrum of $G$ coincides with $\mathbf{i} R$. We obtain the same result for all dimensions $d \geq 2$ under the restriction $\gamma(x) \neq 1, \forall x \in \Gamma$ in the case $d$ even by using the Dirichlet-to-Neumann map $\mathcal{N}(\lambda)$ (see Section 6). Notice that if $G f=\lambda f$ with $f=\left(f_{1}, f_{2}\right) \neq 0, \operatorname{Re} \lambda<0$ and $\partial_{\nu} f_{1}-\gamma f_{2}=0$ on $\Gamma$, we get

\partial_{\nu} f_{1}-\lambda \gamma f_{1}=0 \text { on } \Gamma
\end{array}\right.
$$

and $V(t) f=e^{\lambda t} f$ has an exponentially decreasing global energy. Such solutions are called asymptotically disappearing and they perturb the inverse scattering problems. Recently it was proved [2] that if we have at least one eigenvalue $\lambda$ of $G$ with $\operatorname{Re} \lambda<0$, then the wave operators $W_{ \pm}$ related to the Cauchy problem for the wave equation and the boundary problem (1.1) are not

[^0]complete, that is $\mathrm{Ran} W_{-} \neq \mathrm{R} a n W_{+}$. Hence we cannot define the scattering operator $S$ by the product $W_{+}^{-1} \circ W_{-}$. Notice that if the global energy is conserved in time and the unperturbed and perturbed problems are associated to unitary groups, the corresponding scattering operator $S(z): L^{2}\left(\mathbb{S}^{d-1}\right) \rightarrow L^{2}\left(\mathbb{S}^{d-1}\right)$ satisfies the identity
$$
S^{-1}(z)=S^{*}(\bar{z}), z \in \mathbb{C}
$$
if $S(z)$ is invertible at $z$. Since $S(z)$ and $S^{*}(z)$ are analytic operator-valued operators in the "physical" half plane $\{z \in \mathbb{C}: \operatorname{Im} z<0\}$ (see [5]) the above relation implies that $S(z)$ is invertible for $\operatorname{Im} z>0$. For dissipative boundary problems this relation in general is not true and $S\left(z_{0}\right)$ may have a non trivial kernel for some $z_{0}, \operatorname{Im} z_{0}>0$. For odd dimensions $d$ Lax and Phillips [6] proved that this implies that $\mathbf{i} z_{0}$ is an eigenvalue of $G$. Thus the analysis of the location of the eigenvalues of $G$ is important for the location of the points where the kernel of $S(z)$ is not trivial.

In the scattering theory of Lax-Phillips [6] for odd dimensions $d$ the energy space can be presented as a direct sum $\mathcal{H}=D_{a}^{-} \oplus K_{a} \oplus D_{a}^{+}, a>0$, and we have the relations

V(t) D_{a}^{+} \subset D_{a}^{+}, V(t)\left(K_{a}\right) \subset K_{a} \oplus D_{+}^{a}, V(t) D_{a}^{-} \subset \mathcal{H}, t \geq 0
$$

R. Phillips defined a system as non controllable if there exists a state $f \in K_{a}$ such that $V(t) f \perp$ $D_{a}^{+}, t \geq 0$. This means that there exist states in the "black box" $K_{a}$ which remain undetected by the scattering process. Majda [7] proved that if we have such state $f$, then $\left(u(t, x), u_{t}(t, x)\right)=$ $V(t) f$ is a disappearing solution, that is there exists $T>0$ depending on $f$ such that $u(t, x)$ vanishes for all $t \geq T>0$. On the other hand, if $\gamma(x) \neq 1, \forall x \in \Gamma$, and the boundary is analytic there are no disappearing solutions (see [7]). Thus in this case it is natural to search asymptotically disappearing solutions. The existence of examples in the case $\gamma \equiv 1$ when the point spectrum of $G$ is empty has been mentioned in [8]. Since we did not found a proof of this result in the literature, for reader convenience we propose a simple analysis of this question for the ball $B_{3}=\left\{x \in \mathbb{R}^{3}:|x| \leq 1\right\}$. In the Appendix we prove that if $\gamma \equiv 1$ and $\bar{K}=B_{3}$, the generator $G$ has no eigenvalues in $\{z \in \mathbb{C}: \operatorname{Re} z<0\}$.

We study in the Appendix also the case when $\gamma \equiv$ const $\neq 1$ and $K=B_{3}$. If $0<\gamma<1$, we show that there are no real eigenvalues of $G$. On the other hand, for $\gamma>1$ all eigenvalues of $G$ are real and lie in the interval $\left(-\infty,-\frac{1}{\gamma-1}\right]$. Moreover, in this case there are infinite number real eigenvalues of $G$ and when $\gamma \searrow 1$ the eigenvalues of $G$ go to $-\infty$. For arbitrary strictly convex obstacle $K$ and $\gamma(x)>1, \forall x \in \Gamma$, we obtain a similar result in Theorem 1.3 proving that with exception of a finite number eigenvalues all other are confined in a very small neighbourhood of the negative real axis.

If $\max _{x \in \Gamma}|\gamma(x)-1|$ is sufficiently small, the leading term of the back-scattering amplitude $a(\lambda,-\omega, \omega), \omega \in \mathbb{S}^{n-1}$, becomes very small for all directions $\omega \in \mathbb{S}^{n-1}$ and for $\gamma \equiv 1$ this leading term vanishes for all directions (see [9]). For strictly convex obstacles and $\gamma \equiv 1$ the second term of the back-scattering amplitude does not vanish (see [4]), but it is negligible for the applications (see Section 5 in [13] for the case of first order systems). The existence of a space with infinite dimension of eigenfunctions of $G$ implies that one has a large set of initial data for which the solutions of (1.1) are asymptotically disappearing. Notice that these solutions cannot be outgoing in the sense of Lax-Phillips (see [7]), that is they have a non-vanishing projection on the space $D_{a}^{-}$ mentioned above. Moreover, the eigenvalues of $G$ are stable under perturbations of the boundary and the boundary condition (see [2]).

Now we pass to the description of our results. In [8] Majda examined the location of the eigenvalues of $G$ and he proved that if $\sup \gamma(x)<1$, the eigenvalues of $G$ lie in the region

E_{1}=\left\{z \in \mathbb{C}:|\operatorname{Re} z| \leq C_{1}\left(|\operatorname{Im} z|^{3 / 4}+1\right), \operatorname{Re} z<0\right\}
$$

while if $\sup \gamma(x) \geq 1$, the eigenvalues of $G$ lie in $E_{1} \cup E_{2}$, where

$$
E_{2}=\left\{z \in \mathbb{C}:|\operatorname{Im} z| \leq C_{2}\left(|\operatorname{Re} z|^{1 / 2}+1\right), \operatorname{Re} z<0\right\}
$$

The purpose of this paper is to improve the above results for the location of eigenvalues. We consider two cases: $(A): 0<\gamma(x)<1, \forall x \in \Gamma,(B): \gamma(x)>1, \forall x \in \Gamma$. Our main result is the following

Theorem 1.1. In the case $(A)$ for every $\epsilon, 0<\epsilon \ll 1$, the eigenvalues of $G$ lie in the region

$$
\Lambda_{\epsilon}=\left\{z \in \mathbb{C}:|\operatorname{Re} z| \leq C_{\epsilon}\left(|\operatorname{Im} z|^{\frac{1}{2}+\epsilon}+1\right), \operatorname{Re} z<0\right\} .
$$

In the case (B) for every $\epsilon, 0<\epsilon \ll 1$, and every $N \in \mathbb{N}$ the eigenvalues of $G$ lie in the region $\Lambda_{\epsilon} \cup \mathcal{R}_{N}$, where

$$
\mathcal{R}_{N}=\left\{z \in \mathbb{C}:|\operatorname{Im} z| \leq C_{N}(|\operatorname{Re} z|+1)^{-N}, \operatorname{Re} z<0\right\} .
$$

For strictly convex obstacles $K$ we prove a better result in the case (B).
Theorem 1.2. Assume that $K$ is strictly convex. In the case $(B)$ there exists $R_{0}>0$ such that for every $N \in \mathbb{N}$ the eigenvalues of $G$ lie in the region $\left\{z \in \mathbb{C}:|z| \leq R_{0}, \operatorname{Re} z<0\right\} \cup \mathcal{R}_{N}$.

The eigenvalues of $G$ are symmetric with respect to the real axis, so it is sufficient to examine the location of the eigenvalues whose imaginary part is non negative. Introduce in $\{z \in \mathbb{C}: \operatorname{Im} z \geq 0\}$ the sets

$$
\begin{gathered}
Z_{1}=\left\{z \in \mathbb{C}: \operatorname{Re} z=1, h^{\delta} \leq \operatorname{Im} z \leq 1\right\}, 0<h \ll 1,0<\delta<1 / 2 \\
Z_{2}= \\
\{z \in \mathbb{C}: \operatorname{Re} z=-1,0 \leq \operatorname{Im} z \leq 1\}, Z_{3}=\{z \in \mathbb{C}:|\operatorname{Re} z| \leq 1, \operatorname{Im} z=1\}
\end{gathered}
$$

We put $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$ and we use the branch $0 \leq \arg z<2 \pi$ with $\operatorname{Im} \sqrt{z}>0$ if $\operatorname{Im} z>0$. From (1.2) we deduce that if $(u, v)$ is an eigenfunction of $G$, then $u$ satisfies the problem

$$
\left\{\begin{array}{l}
\left(-h^{2} \Delta-z\right) u=0 \text { in } \Omega  \tag{1.3}\\
-\mathbf{i} h \partial_{\nu} u-\gamma \sqrt{z} u=0 \text { on } \Gamma
\end{array}\right.
$$

The proofs of Theorems 1.1 and 1.2 are based on a semi-classical analysis of the equation

$$
\begin{equation*}
N_{e x t}(z, h) f-\gamma \sqrt{z} f=0 \tag{1.4}
\end{equation*}
$$

where $f=\left.u\right|_{x \in \Gamma}$ is the trace of the first component of an eigenfunction of $G$. Here

$$
\mathcal{N}_{e x t}(z, h) f:\left.H_{h}^{s}(\Gamma) \ni f \longrightarrow h D_{\nu} u\right|_{\Gamma} \in H_{h}^{s-1}(\Gamma)
$$

is the exterior Dirichlet-to-Neumann map, $D_{\nu}=-\mathbf{i} \partial_{\nu}$ and $u$ is the solution of the problem

$$
\left\{\begin{array}{l}
\left(-h^{2} \Delta-z\right) u=0 \text { in } \Omega, u \in H_{h}^{2}(\Omega)  \tag{1.5}\\
\left.u\right|_{x \in \Gamma}=f
\end{array}\right.
$$

In the paper we use the semi-classical Sobolev space $H_{h}^{s}(\Gamma), s \in \mathbb{R}$, with norm $\left\|\langle h D\rangle^{s} u\right\|_{L^{2}(\Gamma)}$, where $\langle h D\rangle=\left(1+\left(h D_{x}\right)^{2}\right)^{1 / 2}$. The purpose is to prove that if $z \in Z_{1} \cup Z_{2} \cup Z_{3}$ lies in some

regions and $h$ is small enough from (1.4) we get $f=0$ which is not possible for an eigenfunction $u$. In this direction our strategy is close to that for the analysis of eigenvalues-free regions for the interior transmission eigenvalues in [19] and [20]. We apply some results for the interior Dirichlet-to-Neumann map $\mathcal{N}_{\text {int }}(z, h)$ established in [19] and [20] for bounded domains which after modifications and some constructions remain true for the exterior Dirichlet-to-Neumann map $\mathcal{N}_{\text {ext }}(z, h)$ defined above.

The paper is organized as follows. In Section 2 we collect some results concerning the semiclassical exterior Dirichlet-to-Neumann map $\mathcal{N}_{\text {ext }}(z, h)$. The eigenvalues-free regions for the case (A) are discussed in Section 3. In Section 4 we study the case (B), where the arguments for the case (A) are not applicable for the investigation of eigenvalues close to the negative real axis. The strictly convex obstacles are examined in Section 5. In Section 6 we discuss the question of the discreteness of the spectrum of $G$ in $\{z \in \mathbb{C}: \operatorname{Re} z<0\}$ for dimensions $d \geq 2$. For odd dimensions $d$, as it was mentioned above, this result was obtained in the classical paper [6]. For $d$ even we present a proof based on the properties of the Dirichlet-to-Neumann map $\mathcal{N}_{\text {ext }}(\lambda)$. Moreover, we obtain a trace formula for the counting function of the eigenvalues of $G$ in an open domain $\omega \subset\{z \in \mathbb{C}: \operatorname{Re} z<0\}$. Finally, in the Appendix we examine the special case when $K$ is unit ball in $\mathbb{R}^{3}$ and $\gamma$ is a constant.
2. Dirichlet-to-Neumann map. In our exposition we apply some $h$-pseudo-differential operators and we are going to recall some basic facts. Let $X$ be a $C^{\infty}$ smooth compact manifold without boundary with dimension $d-1 \geq 1$. Let $(x, \xi)$ be the canonical local coordinates in $T^{*}(X)$ and let $a(x, \xi, h) \in C^{\infty}\left(T^{*}(X)\right)$. Given $m \in \mathbb{R}, l \in \mathbb{R}, \delta>0$ and a function $c(h)>0$, one denotes by $S_{\delta}^{l, m}(c(h))$ the set of symbols $a(x, \xi, h)$ such that

\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} a(x, \xi, h)\right| \leq C_{\alpha, \beta}(c(h))^{-l-\delta(|\alpha|+|\beta|)}(1+|\xi|)^{m-|\beta|},(x, \xi) \in T^{*}(X), \forall \alpha, \forall \beta
$$

If $c(h)=h$, we denote $S_{\delta}^{l, m}(c(h))$ simply by $S_{\delta}^{l, m}$ and the symbols restricted to a domain where $|\xi| \leq C$ will be denoted by $a \in S_{\delta}^{l}(c(h))$. We use also symbols $a(x, \xi, h) \in S_{0,1}^{m}$ satisfying the estimates

\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} a(x, \xi, h)\right| \leq C_{\alpha, \beta}(1+|\xi|)^{m-|\beta|},(x, \xi) \in T^{*}(X), \forall \alpha, \forall \beta
$$

One defines the $h$-pseudo-differential operator $O p_{h}(a)$ with symbol $a(x, \xi, h)$ by

$$
\left(O p_{h}(a) f\right)(x)=(2 \pi h)^{-d+1} \int_{T^{*} X} e^{-\mathbf{i}\langle x-y, \xi\rangle / h} a(x, \xi, h) f(y) d y d \xi
$$

For the reader convenience we recall two properties of the semi-classical pseudo- differential operators $O p_{h}(a)$ (see Section 7 of [3] and Proposition 2.1 of [19]). Assume that $a \in C^{\infty}\left(T^{*}(X)\right)$ satisfies the bounds

$$

\left|\partial_{x}^{\alpha} a(x, \xi, h)\right| \leq C_{\alpha} c_{0}(h) h^{-|\alpha| / 2}, \forall(x, \xi) \in T^{*}(X) \tag{2.1}
\end{equation*}
$$

for $|\alpha| \leq d$, where $c_{0}(h)>0$ is a parameter. Then there exists a constant $C>0$ independent of $h$ such that

$$
\begin{equation*}
\left\|O p_{h}(a)\right\|_{L^{2}(X) \rightarrow L^{2}(X)} \leq C c_{0}(h) . \tag{2.2}
\end{equation*}
$$

Next for $0 \leq \delta<1 / 2$ we have a calculus and if $a \in S_{\delta}^{l_{1}, m_{1}}, b \in S_{\delta}^{l_{2}, m_{2}}$, then for $s \in \mathbb{R}$ we get

$$
\left\|O p_{h}(a) O p_{h}(b)-O p_{h}(a b)\right\|_{H^{s}(X) \rightarrow H^{s-m_{1}-m_{2}+1}(X)} \leq C_{s} h^{-l_{1}-l_{2}-2 \delta+1} .
$$

We refer to [3] for more details concerning the calculus. The left hand side of last inequality can be estimated also in some cases when one of the symbols $a$ or $b$ is in a class $S_{\delta}^{l, m}$ with $0 \leq \delta<1$. For the precise statements the reader should consult Proposition 2.2 in [19] and Proposition 4.2 in [20].

Let $\left(x^{\prime}, \xi^{\prime}\right)$ be the coordinates on $T^{*}(\Gamma)$. Denote by $r_{0}\left(x^{\prime}, \xi^{\prime}\right)$ the principal symbol of the Laplace-Beltrami operator $-\Delta_{\Gamma}$ on $\Gamma$ equipped with the Riemannian metric induced by the Euclidean metric in $\mathbb{R}^{d}$. For $z \in Z_{1} \cup Z_{2} \cup Z_{3}$ let

$$
\rho\left(x^{\prime}, \xi^{\prime}, z\right)=\sqrt{z-r_{0}\left(x^{\prime}, \xi^{\prime}\right)} \in C^{\infty}\left(T^{*} \Gamma\right)
$$

be the root of the equation

$$
\rho^{2}+r_{0}\left(x^{\prime}, \xi^{\prime}\right)-z=0
$$

with $\operatorname{Im} \rho\left(x^{\prime}, \xi^{\prime}, z\right)>0$. For large $\left|\xi^{\prime}\right|$ we have $\left|\rho\left(x^{\prime}, \xi^{\prime}, z\right)\right| \sim\left|\xi^{\prime}\right|, \operatorname{Im} \rho\left(x^{\prime}, \xi^{\prime}, z\right) \sim\left|\xi^{\prime}\right|$. Moreover, for $z \in Z_{1} \cup Z_{3}$ we have

$$
\operatorname{Im} \rho\left(x^{\prime}, \xi^{\prime}, z\right) \geq \frac{|\operatorname{Im} z|}{2|\rho|},|\rho| \geq \sqrt{|\operatorname{Im} z|},
$$

while for $r_{0} \geq 2$, we have

$$
C_{1} \sqrt{r_{0}+1} \geq 2 \operatorname{Im} \rho \geq|\rho| \geq C_{2} \sqrt{r_{0}+1}
$$

For $z \in Z_{2}$ the last equality is true for all ( $x^{\prime}, \xi^{\prime}$ ) (see Lemma 3.1 in [19]).
G. Vodev established for bounded domains $K \subset \mathbb{R}^{d}, d \geq 2$, the following approximation of the interior Dirichlet-to-Neumann map $N_{\text {int }}(z, h)$ related to the boundary problem (1.5), where the equation $\left(-h^{2} \Delta-z\right) u=0$ is satisfied in $K$.

Theorem 2.1 ([19], Theorem 3.3). For every $0<\epsilon \ll 1$ there exists $0<h_{0}(\epsilon) \ll 1$ such that for $z \in Z_{1, \epsilon}=\left\{z \in \mathbb{C}: \operatorname{Re} z=1,1 \geq \operatorname{Im} z \geq h^{1 / 2-\epsilon}\right\}$ and $0<h \leq h_{0}$ we have

$$
\begin{equation*}
\left\|\mathcal{N}_{i n t}(z, h)(f)-O p_{h}(\rho+h b) f\right\|_{H_{h}^{1}(\Gamma)} \leq \frac{C h}{\sqrt{|\operatorname{Im} z|}}\|f\|_{L^{2}(\Gamma)} \tag{2.3}
\end{equation*}
$$

where $b \in S_{0,1}^{0}(\Gamma)$ does not depend on $h$ and $z$. Moreover, (2.3) holds for $z \in Z_{2} \cup Z_{3}$ with $|\operatorname{Im} z|$ replaced by 1 .

The same result remains true for unbounded domains $\Omega$ with $\mathcal{N}_{\text {int }}(z, h)$ replaced by $\mathcal{N}_{\text {ext }}(z, h)$ by modifications to the proof in [19] based on the construction of a semi-classical parametrix close to the boundary. For reader convenience we recall below some facts from [19] and we discuss some modifications which will be necessary for our exposition. Consider normal geodesic coordinates $\left(x_{1}, x^{\prime}\right)$ in a neighbourhood of a fixed point $x_{0} \in \Gamma$, where $x_{1}=\operatorname{dist}(x, \Gamma)$. Then $-h^{2} \Delta-z$ in these coordinates has the form

with $D_{x_{1}}=-\mathbf{i} \partial_{x_{1}}, D_{x^{\prime}}=-\mathbf{i} \partial_{x^{\prime}}, r\left(x, \xi^{\prime}\right)=\left\langle R(x) \xi^{\prime}, \xi^{\prime}\right\rangle, q(x, \xi)=\langle q(x), \xi\rangle$. Here $R(x)$ is a symmetric $(d-1) \times(d-1)$ matrix with smooth real-valued entries and $r\left(0, x^{\prime}, \xi^{\prime}\right)=r_{0}\left(x^{\prime}, \xi^{\prime}\right)$. Let $\phi(\sigma) \in C^{\infty}(\mathbb{R})$ be a cut-off function such that $\phi(\sigma)=1$ for $|\sigma| \leq 1, \phi(\sigma)=0$ for $|\sigma| \geq 2$. Let $\psi\left(x^{\prime}\right)$ be a $C^{\infty}$ cut-off function on $\Gamma$ supported in a small neighbourhood of $x_{0}$ and $\psi\left(x_{0}\right)=1$. In [19], Proposition 3.4 for $\delta_{1}>0$ small enough one constructs a semi-classical parametrix

\end{array}\right.
$$

where $\rho_{1}=1$ if $z \in Z_{2} \cup Z_{3}, \rho_{1}=|\rho|^{3}$ if $z \in Z_{1}$.

The phase $\varphi\left(x, y^{\prime}, \xi^{\prime}, z\right)$ is complex-valued and

a=\sum_{k=0}^{N-1} \sum_{j=0}^{N-1} x_{1}^{k} h^{j} a_{k, j}\left(x^{\prime}, \xi^{\prime}, z\right)
\end{gathered}
$$

$N \gg 1$ being a large integer.
Moreover, $\varphi_{1}=\rho, \operatorname{Im} \varphi \geq x_{1} \operatorname{Im} \rho / 2,0 \leq x_{1} \leq 2 \delta_{1} \min \left\{1, \rho_{1}\right\}$ and the amplitude $a$ satisfies $\left.a\right|_{x_{1}=0}=\psi\left(x^{\prime}\right)$. The phase $\varphi$ and the amplitude $a$ are determined so that

To describe the behavior of $A_{N}, B_{N}$, introduce the function $\chi\left(x^{\prime}, \xi^{\prime}\right)=\phi\left(\delta_{0} r_{0}\left(x^{\prime}, \xi^{\prime}\right)\right)$, where $0<\delta_{0} \ll 1$. Following [19], we say that a symbol $b \in C^{\infty}\left(T^{*} \Gamma\right)$ belongs to $S_{\delta_{1}, \delta_{2}}^{l_{1}}\left(\mu_{1}\right)+S_{\delta_{3}, \delta_{4}}^{l_{2}}\left(\mu_{2}\right)$ if

\end{gathered}
$$

Therefore,

$$

uniformly with respect to $z, h$ and $0 \leq x_{1} \leq 2 \delta_{1} \min \left\{1, \rho_{1}\right\}$.
For $z \in Z_{1,0}$ and any integer $s \geq 0$, there exist $l_{s}, N_{s}>0$ so that for $N \geq N_{s}$ we have the estimate (see Proposition 3.7 in [19])

Let $G_{D}$ be the self-adjoin realization of the operator $-\Delta$ on $L^{2}(\Omega)$ with Dirichlet boundary condition on $\Gamma$. Since the spectrum of $G_{D}$ is the positive real axis, for $z \in Z_{1,0}$ we have the estimate

Now let $u_{\psi} \in H_{h}^{2}(\Omega)$ be the solution of the problem

will be a solution of $\left(h^{2} G_{D}-z\right) w_{\psi}=0$ in $\Omega,\left.w_{\psi}\right|_{\Gamma}=0$. Since for $z \in Z_{1,0} \cup Z_{2} \cup Z_{3}$ the point $z / h^{2}$ is not in the spectrum of $G_{D}$, one deduces $w_{\psi}=0$. This implies as in [19] the following
Proposition 2.1. For $z \in Z_{1,0}$ we have the estimate

with constants $C_{N}, s_{d}>0$, independent of $f, h$ and $z$, and $s_{d}$ independent of $N$. If $z \in Z_{2} \cup Z_{3}$, then (2.6) holds with $|\operatorname{Im} z|$ replaced by 1.

Choose a partition of unity $\sum_{j=1}^{J} \psi_{j}\left(x^{\prime}\right)=1$ on $\Gamma$ and set $T(z, h)=\sum_{j=1}^{J} T_{\psi_{j}}(z, h)$. Notice that the principal symbol of $T(z, h)$ is $\rho$. By using Proposition 2.1 and repeating without any change the argument in Section 3 in [19], one concludes that the statement of Theorem 2.1 remains true replacing in $(2.3) \mathcal{N}_{\text {int }}(z, h)$ by $\mathcal{N}_{\text {ext }}(z, h)$.
3. Eigenvalues-free regions in the case (A). In this section we suppose that $0<\epsilon_{0} \leq \gamma(x) \leq$ $1-\epsilon_{0}, \epsilon_{0}>0, \forall x \in \Gamma$. If $(u, v) \neq 0$ is an eigenfunction of $G$ with eigenvalue $\lambda \in\{z \in \mathbb{C}: \operatorname{Re} z<0\}$, then $f=\left.u\right|_{x \in \Gamma} \neq 0$. Indeed, if $f=0$ on $\Gamma$, then $u \in H^{2}(\Omega)$ will be eigenfunction of the Dirichlet problem in $\Omega$ and this is impossible. From (1.3) one obtains the equation (1.4).

According to Theorem 2.1 with $\mathcal{N}_{\text {ext }}(z, h)$, for $z \in Z_{1}, \delta=1 / 2-\epsilon$, we have

where for $z \in Z_{2} \cup Z_{3}$ the above estimate holds with $|\operatorname{Im} z|$ replaced by 1. Here we use the fact that

which follows from [19], Proposition 2.1. Introduce the symbol

We will show that $c\left(x^{\prime}, \xi^{\prime}, z\right)$ is elliptic in a suitable class. Write

Case I. $z \in Z_{1, \epsilon}$. Set $\delta=1 / 2-\epsilon$. The symbol $c$ is elliptic for $\left|\xi^{\prime}\right|$ large enough and it remains to examine its behavior for $\left|\xi^{\prime}\right| \leq C_{0}$. For these values of $\xi^{\prime}$ we have $|\rho+\gamma \sqrt{z}| \leq C_{1}$. First consider the set

Hence, for bounded $\left|\xi^{\prime}\right|$ we have $|c| \geq C_{3} h^{\delta}, C_{3}>0$, while for large $\left|\xi^{\prime}\right|$ we have $|c| \sim\left|\xi^{\prime}\right|$. As in Section 2 we use the function $\chi$ and define $\mathcal{M}_{1}:=Z_{1} \times \operatorname{supp} \chi, \mathcal{M}_{2}:=\left(Z_{1} \times \operatorname{supp}(1-\chi)\right) \cup\left(\left(Z_{2} \cup\right.\right.$ $\left.\left.Z_{3}\right) \times T^{*} \Gamma\right)$. Set $\left\langle\xi^{\prime}\right\rangle=\left(1+\left|\xi^{\prime}\right|\right)^{1 / 2}$. It is easy to see that for $\left(z, x^{\prime}, \xi^{\prime}\right) \in \mathcal{M}_{1}$, we have

Now consider the symbol $c^{-1}=\frac{\rho+\gamma \sqrt{z}}{\left(1-\gamma^{2}\right) z-r_{0}}$. Since $\rho+\gamma \sqrt{z} \in S_{\delta}^{0,1}$, it remains to study the properties of $g:=\left(\left(1-\gamma^{2}\right) z-r_{0}\right)^{-1}$. For $\left(x^{\prime}, \xi^{\prime}\right) \in \mathcal{F}$, we get $\left|\left(1-\gamma^{2}\right) z-r_{0}\right| \geq \frac{\epsilon_{0}^{2}}{2}>0$ and

On the other hand, $\left(x^{\prime}, \xi^{\prime}\right) \notin \mathcal{F}$ yields $\left|1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)\right|>\frac{\epsilon_{0}^{2}}{2}$ and for $\left(x^{\prime}, \xi^{\prime}\right) \notin \mathcal{F}$ we obtain

Case III. $z \in Z_{3}$. In this case $\operatorname{Im} z=1$ and one has

This implies that $c \in S_{0}^{0,1}$ is elliptic and $c^{-1} \in S_{0}^{0,-1}$.
Consequently, we get

On the other hand, for $\left|\alpha_{1}\right|+\left|\beta_{1}\right| \geq 1,\left|\alpha_{2}\right|+\left|\beta_{2}\right| \geq 1$ and $\left|\xi^{\prime}\right| \leq C_{0}$ according to (3.2), (3.4), (3.7), (3.8), for $\left(x^{\prime}, \xi^{\prime}\right) \in \mathcal{F}$ we get

\end{equation*}
$$

while for $\left(x^{\prime}, \xi^{\prime}\right) \notin \mathcal{F}$ we have

\end{equation*}

Consider the operator $O p_{h}\left(c^{-1}\right) O p_{h}(c)-I$. Following Section 7 in [3], the symbol of this operator is given by

On the other hand, the estimates (3.9), (3.10) yield

\left|\partial_{x^{\prime}}^{\alpha} b_{N}\left(x^{\prime}, \xi^{\prime}\right)\right| \leq C_{\alpha} \frac{h}{|\operatorname{Im} z|^{2}} h^{-\delta|\alpha|}
$$

Thus, applying once more (2.2), one gets

\left\|O p_{h}\left(c^{-1}\right) O p_{h}(c) f-f\right\|_{L^{2}(\Gamma)} \leq C_{6} \frac{h}{|\operatorname{Im} z|^{2}}\|f\|_{L^{2}(\Gamma)}
$$

A combination of the above estimates implies

\begin{equation*}
\|f\|_{L^{2}(\Gamma)} \leq C_{7}\left(h^{1-2 \delta}+h^{1-\frac{3}{2} \delta}\right)\|f\|_{L^{2}(\Gamma)} \tag{3.11}
\end{equation*}
$$

Since $\delta=1 / 2-\epsilon, 0<\epsilon \ll 1$, for $0<h \leq h_{0}(\epsilon)$ small enough (3.8) yields $f=0$.
Going back to $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$, we have

\operatorname{Re} \lambda=-\frac{\operatorname{Im} \sqrt{z}}{h}, \operatorname{Im} \lambda=\frac{\operatorname{Re} \sqrt{z}}{h}
$$

Suppose that $z \in Z_{1}$. Then

|\operatorname{Re} \lambda| \geq C\left(h^{-1}\right)^{1-\delta},|\operatorname{Im} \lambda| \leq C_{1} h^{-1} \leq C_{2}|\operatorname{Re} \lambda|^{\frac{1}{1-\delta}}
$$

So if $|\operatorname{Re} \lambda| \geq C_{3}|\operatorname{Im} \lambda|^{1-\delta}, \operatorname{Re} \lambda \leq-C_{4}<0$ there are no eigenvalues $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$ of $G$. For $z \in Z_{2} \cup Z_{3}$ there are no eigenvalues $\lambda$ too if $|\lambda| \geq R_{0}$.

This shows that in the case (A) for every $0<\epsilon \ll 1$ the eigenvalues of $G$ must lie in the region $\Lambda_{\epsilon}$ defined in Theorem 1.1.
4. Eigenvalues-free region in the case (B). In this section we deal with the case (B). The analysis of Section 3 works only for $z \in Z_{1} \cup Z_{3}$. Indeed for $z \in Z_{1}$ we have

$$
\operatorname{Re}\left(\left(1-\gamma^{2}\right)-r_{0}\right) \leq\left(1-\gamma^{2}\right)<-\eta_{0}<0
$$

The symbol $g$ introduced in the previous section satisfies the estimates (3.5) and $c \in S_{\delta}^{0,1}, c^{-1} \in$ $S_{\delta}^{0,-1}$. For $z \in Z_{3}$ we apply the same argument. Thus for $z \in Z_{1} \cup Z_{3}$ we obtain that the eigenvalues $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$ of $G$ must lie in $\Lambda_{\epsilon}$. For $z \in Z_{2}$ the argument exploited in the case (A) breaks down since for $\operatorname{Re} z=-1, \operatorname{Im} z=0$ the symbol

$$
\mathbf{i}\left[1+r_{0}\left(x^{\prime}, \xi^{\prime}\right)-\gamma\left(x^{\prime}\right)\right]
$$

is not elliptic and it may vanish for some $\left(x_{0}^{\prime}, \xi_{0}^{\prime}\right)$.
In the following we suppose that $z \in Z_{2}$. Therefore Proposition 2.1 yields a better approximation

$$
\begin{equation*}
\left\|\mathcal{N}_{e x t}(z, h)(f)-T(z, h) f\right\|_{H^{1}(\Gamma)} \leq C_{N} h^{-s_{d}+N}\|f\|_{L^{2}(\Gamma)}, \forall N \in \mathbb{N} \tag{4.1}
\end{equation*}
$$

If $f \neq 0$ is the trace of an eigenfunction of $G$, from the equality (1.4) we obtain

$$
\left|\operatorname{Re}\langle T(z, h) f-\gamma \sqrt{z} f, f\rangle_{L^{2}(\Gamma)}\right| \leq C_{N} h^{-s_{d}+N}\|f\|_{L^{2}(\Gamma)}
$$

There exists $t$ with $0<t<1$ such that

$$
\begin{array}{r}
\operatorname{Re}\langle(T(z, h)-\gamma \sqrt{z}) f, f\rangle_{L^{2}(\Gamma)}=\operatorname{Re}\langle T(-1, h) f, f\rangle_{L^{2}(\Gamma)} \\
-\operatorname{Im} z \operatorname{Im}\left[\left\langle\left(\frac{\partial T}{\partial z}\left(z_{t}, h\right)-\gamma \frac{1}{2 \sqrt{z_{t}}}\right) f, f\right\rangle_{L^{2}(\Gamma)}\right] \tag{4.2}
\end{array}
$$

with $z_{t}=-1+\mathbf{i} t \operatorname{Im} z \in Z_{2}$. The next Lemma is an analogue of Lemma 3.9 in [19].
Lemma 4.1. Let $z \in Z_{2}$ and let $f=\left.u\right|_{\Gamma}$ be the trace of an eigenfunction $u$ of $G$ with eigenvalue $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$. Then

\begin{equation*}
\left\|\frac{d T}{d z}(z, h) f-O p_{h}\left(\frac{d \rho}{d z}(z)\right) f\right\|_{L^{2}(\Gamma)} \leq C h\|f\|_{H_{h}^{-1}(\Gamma)} \tag{4.3}
\end{equation*}
$$

with a constant $C>0$ independent of $z, h$ and $f$. Moreover,

$$
\begin{equation*}
\left|\operatorname{Re}\langle T(-1, h) f, f\rangle_{L^{2}(\Gamma)}\right| \leq C_{N} h^{-s_{d}+N}\|f\|_{L^{2}(\Gamma)}, \forall N \in \mathbb{N} \tag{4.4}
\end{equation*}
$$

Proof. The proof of (4.3) is the same as in [19] since for $z \in Z_{2}$ we get

\sum_{j=0}^{N-1} h^{j} \frac{d a_{1, j}}{d z} \in S_{0}^{0,-1}
$$

To establish (4.4), we apply Green's formula in the unbounded domain $\Omega$. By using the notation of Section 2, set $\tilde{u}=\sum_{j=1}^{J} \tilde{u}_{\psi}$. Then $-\left.\mathbf{i} h \partial_{\nu} \tilde{u}\right|_{\Gamma}=T(z, h) f$ and for $R \gg 1$ the function $\tilde{u}$ vanishes for $|x| \geq R$. Thus one obtains

\mathbf{i}\langle\Delta \tilde{u}, \tilde{u}\rangle_{L^{2}(\Omega)}=-\mathbf{i} \int_{\Omega}|\nabla \tilde{u}|^{2} d x-\mathbf{i}\left\langle\partial_{\nu} \tilde{u}, \tilde{u}\right\rangle_{L^{2}(\Gamma)}

Multiplying the above equality by $h$ and taking the real part, we deduce

-\operatorname{Im} h\langle\Delta \tilde{u}, \tilde{u}\rangle_{L^{2}(\Omega)}=\operatorname{Re}\langle T(z, h) f, f\rangle_{L^{2}(\Gamma)}
$$

Therefore,

\operatorname{Re}\langle T(-1, h) f, f\rangle_{L^{2}(\Gamma)} .=-\operatorname{Im} h\left\langle\left(\Delta-h^{-2}\right) \tilde{u}, \tilde{u}\right\rangle_{L^{2}(\Omega)}=-\operatorname{Im} h^{-1}\langle\mathcal{P}(-1, h) \tilde{u}, \tilde{u}\rangle_{L^{2}(\Omega)}
$$

and

$$
\left|\operatorname{Re}\langle T(-1, h) f, f\rangle_{L^{2}(\Gamma)}\right| \leq h^{-1}\|\mathcal{P}(-1, h) \tilde{u}\|_{L^{2}(\Omega)}\|\tilde{u}\|_{L^{2}(\Omega)}
$$

It is easy to see that $\|\tilde{u}\|_{L^{2}(\Omega)} \leq C h^{-s_{d}}\|f\|_{L^{2}(\Omega)}$ and combining this with (2.5) for $z \in Z_{2}$, we obtain (4.4).

Proof of Theorem 1.1, case (B). From (4.2), (4.4) and $\operatorname{Im} z \neq 0$ we have

\begin{equation*}
\left|\operatorname{Im}\left\langle\left(\frac{\partial T}{\partial z}\left(z_{t}, h\right)-\frac{\gamma}{2 \sqrt{z_{t}}}\right) f, f\right\rangle_{L^{2}(\Gamma)}\right| \leq C_{N} \frac{h^{-s_{d}+N}}{|\operatorname{Im} z|}\|f\|_{L^{2}(\Gamma)} \tag{4.5}
\end{equation*}
$$

Consider the operator $L:=O p_{h}\left(\frac{d \rho}{d z}\left(z_{t}\right)\right)-\frac{\gamma}{2 \sqrt{z_{t}}}$ and notice that

\left|\operatorname{Im}\left\langle\left(\frac{\partial T}{\partial z}\left(z_{t}, h\right)-\frac{\gamma}{2 \sqrt{z_{t}}}\right) f, f\right\rangle_{L^{2}(\Gamma)}-\operatorname{Im}\langle L f, f\rangle_{L^{2}(\Gamma)}\right| \leq C h\|f\|_{L^{2}(\Gamma)} \tag{4.6}
\end{equation*}
$$

On the other hand,

$$
\operatorname{Im}\langle L f, f\rangle_{L^{2}(\Gamma)}=\frac{1}{2 \mathbf{i}}\left\langle\left(L-L^{*}\right) f, f\right\rangle_{L^{2}(\Gamma)}
$$

and the principal symbol of $\frac{1}{2 \mathbf{i}}\left(L-L^{*}\right)$ has the form

$$
s\left(x^{\prime}, \xi^{\prime} ; z\right):=\frac{1}{2} \operatorname{Im}\left[\frac{1}{\sqrt{-1+\mathbf{i} t \operatorname{Im} z-r_{0}}}-\frac{\gamma}{\sqrt{-1+\mathbf{i} t \operatorname{Im} z}}\right]
$$

Let

$$
z_{t}=y e^{\mathbf{i}(\pi-\varphi)}, y=\sqrt{1+t^{2}|\operatorname{Im} z|^{2}},|\varphi| \leq \pi / 4
$$

Here and below we omit the dependence of $y$ on $t$. Then $1 \leq y \leq \sqrt{2}$ and

$$
\sqrt{z_{t}}=\sqrt{y} \sin \varphi / 2+\mathbf{i} \sqrt{y} \cos \varphi / 2, \operatorname{Im} \frac{1}{\sqrt{z_{t}}}=-\frac{\cos \varphi / 2}{\sqrt{y}}
$$

In the same setting

$$
-1+\mathbf{i} t \operatorname{Im} z-r_{0}=q e^{\mathbf{i}(\pi-\psi)}, q=\sqrt{\left(1+r_{0}\right)^{2}+t^{2}(\operatorname{Im} z)^{2}},|\psi| \leq \pi / 4
$$

we see that

$$
\operatorname{Im} \frac{1}{\sqrt{-1+\mathbf{i} t \operatorname{Im} z-r_{0}}}=-\frac{\cos \psi / 2}{\sqrt{q}}
$$

Therefore

$$
s=\frac{1}{2 \sqrt{y q}}(\gamma \sqrt{q} \cos \varphi / 2-\sqrt{y} \cos \psi / 2)=\frac{\gamma^{2} q \cos ^{2} \varphi / 2-y \cos ^{2} \psi / 2}{2 \sqrt{y q}(\gamma \sqrt{q} \cos \varphi / 2+\sqrt{y} \cos \psi / 2)}
$$

To prove that $s$ is elliptic, it is sufficient to show that

$$
\begin{gathered}
\gamma^{2} q(1+\cos \varphi)-y(1+\cos \psi)=\gamma^{2} q\left(1+\frac{1}{y}\right)-y\left(1+\frac{1+r_{0}}{q}\right) \\
=\frac{1}{y q}\left[\gamma^{2} q^{2}(1+y)-y^{2}\left(1+q+r_{0}\right)\right]
\end{gathered}
$$

is elliptic. Consider the function

$$
F\left(r_{0}\right)=\gamma^{2}\left(\left(1+r_{0}\right)^{2}+t^{2} \operatorname{Im}^{2} z\right)(1+y)-y^{2}\left(1+\sqrt{\left(1+r_{0}\right)^{2}+t^{2} \operatorname{Im}^{2} z}+r_{0}\right)
$$

Clearly,

$$
F(0)=\left(\gamma^{2}-1\right)(1+y) y^{2} \geq \eta_{1}>0
$$

since in the case (B) we have $\gamma^{2}-1 \geq \eta_{0}>0$. Next, for $\gamma \geq 1, r_{0} \geq 0$ we have

$$
\begin{aligned}
\frac{\partial F}{\partial r_{0}}= & 2 \gamma^{2}(1+y)\left(1+r_{0}\right)-y^{2}\left(1+\frac{1+r_{0}}{\sqrt{\left(1+r_{0}\right)^{2}+t^{2} \operatorname{Im}^{2} z}}\right) \\
& \geq 2\left(\gamma^{2}(1+y)\left(1+r_{0}\right)-y^{2}\right) \geq 2\left(1+y-y^{2}\right)
\end{aligned}
$$

On the other hand, it is clear that $1+y-y^{2}>0$ for $0 \leq y<\frac{1+\sqrt{5}}{2}$. In our case $1 \leq y \leq \sqrt{2}<\frac{1+\sqrt{5}}{2}$ and we deduce $\frac{\partial F}{\partial r_{0}}\left(r_{0}\right)>0$ for $r_{0} \geq 0,1 \leq y \leq \sqrt{2}$. This implies $F\left(r_{0}\right)>0$ for $r_{0} \geq 0$ and $s$ is elliptic. Consequently,

$$
\operatorname{Im}\langle L f, f\rangle_{L^{2}(\Gamma)} \geq\left(\eta_{2}-C h\right)\|f\|_{L^{2}(\Gamma)}, \eta_{2}>0
$$

and for small $h$ and $\|f\|_{L^{2}(\Gamma)} \neq 0, \operatorname{Im} z \neq 0$, we deduce from (4.5) and (4.6)

$$
|\operatorname{Im} z| \leq C_{N}^{\prime} h^{-s_{d}+N} \leq B_{N} h^{N}, \forall N \in \mathbb{N}
$$

Going back to $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$, we have

\operatorname{Re} \sqrt{z}=\mu^{1 / 2} \sin \varphi / 2, \operatorname{Im} \sqrt{z}=\mu^{1 / 2} \cos \varphi / 2, \mu=\sqrt{1+(\operatorname{Im} z)^{2}} \leq \sqrt{2}
$$

and $0 \leq \sin \varphi \leq B_{N} h^{N}$. This implies for $h$ small enough the estimate

|\operatorname{Im} \lambda|=\left|\frac{\operatorname{Re} \sqrt{z}}{h}\right| \leq 2^{1 / 4} B_{N}\left(h^{-1}\right)^{-N+1} \leq C_{N}|\operatorname{Re} \lambda|^{-N}
$$

Thus for $z \in Z_{2}$ and every $N \in \mathbb{N}$ the eigenvalues $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$ of $G$ lie in $\mathcal{R}_{N}$ and this completes the proof of Theorem 1.1.

The eigenvalues of $G$ could have accumulation points on $\mathbf{i} \mathbb{R}$. For odd dimension $d$ Lax and Phillips [6] proved that the scattering matrix $S(z)$ is invertible for $z=0$. This leads easily to the following

Proposition 4.1. Assume $d$ odd. The operator $G$ has no a sequence of eigenvalues $\lambda_{j}, \operatorname{Re} \lambda_{j}<0$ such that $\lim _{j \rightarrow \infty} \lambda_{j}=\mathbf{i} z_{0}, z_{0} \in \mathbb{R}$.

The proof is the same as that of Proposition 4.11 in [2]. The above proposition does not exclude the possibility to have eigenvalues $\lambda_{j}$ with $\left|\operatorname{Im} \lambda_{j}\right| \rightarrow+\infty$. On the other hand, Theorem 1.2, established in the next section, implies that for strictly convex obstacles and $\gamma(x)>1$ the imaginary part of all eigenvalues of $G$ is bounded by a constant $R_{0}>0$ and for $d$ odd we can apply Proposition 4.1.
5. Eigenvalue-free region for strictly convex obstacles in the case (B). In this section we study the eigenvalues-free regions when $K$ is a strictly convex obstacle. Let $0<\epsilon \ll 1 / 2$ be a small number. Set

$$
\chi_{1}\left(x^{\prime}, \xi^{\prime}\right)=\phi\left(\frac{1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)}{h^{\epsilon / 2}}\right)
$$

where $\phi$ is the function introduced in Section 2. Notice that on the support of $1-\chi_{1}$ we have $\left|1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)\right| \geq h^{\epsilon / 2}$. By a modification of the construction in [19] (see also [14]) we can construct a semi-classical parametrix $\tilde{u}_{\psi}$ having the form (2.4), where $\psi f$ is replaced by $O p_{h}\left(1-\chi_{1}\right) \psi f$.

Then for $\left|1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)\right| \geq h^{\epsilon / 2}$ we have $|\rho|^{2} \geq h^{\epsilon / 2}$ and we can improve the estimate (2.5) obtaining

$$
\begin{equation*}
\left\|\mathcal{P}(z, h) \tilde{u}_{\psi}\right\|_{H^{s}(\Omega)} \leq C_{N} h^{-l_{s}}\left(\frac{h}{h^{\epsilon / 2}|\operatorname{Im} z|}\right)^{N}\|f\|_{L^{2}(\Gamma)},|\operatorname{Im} z| \geq h^{1-\epsilon} \tag{5.1}
\end{equation*}
$$

To do this, one repeats without changes the argument in Section 3 of [19] replacing the lower bound $|\rho|^{2} \geq|\operatorname{Im} z|$ by $|\rho|^{2} \geq h^{\epsilon / 2}$. Consequently, the right hand side of (5.1) is estimated by $\mathcal{O}_{N}\left(h^{-l_{s}+N \epsilon / 2}\right)$ and this yields a semi-classical parametrix

$$
\mathcal{P}(z, h) w_{1}=\mathcal{O}_{N}\left(h^{N}\right),\left.w_{1}\right|_{x \in \Gamma}=O p_{h}\left(1-\chi_{1}\right) \psi f
$$

Consider a partition of unity $\chi_{\delta}^{-}+\chi_{\delta}^{0}+\chi_{\delta}^{+}=1$ on $T^{*}(\Gamma)$, where the functions $\chi_{\delta}^{-}, \chi_{\delta}^{0}, \chi_{\delta}^{+} \in S_{\delta, 0}^{0}$ are with values in $\mathbb{R}^{+}$and such that supp $\chi_{\delta}^{-} \subset\left\{r_{0}-1 \leq-h^{\delta}\right\}$, supp $\chi_{\delta}^{+} \subset\left\{r_{0}-1 \geq h^{\delta}\right\}$, supp $\chi_{\delta}^{0} \subset\left\{\left|r_{0}-1\right| \leq 2 h^{\delta}\right\}, \chi_{\delta}^{0}=1$ on $\left\{\left|r_{0}-1\right| \leq h^{\delta}\right\}$. Then, as in [19], [20], we obtain the following
Theorem 5.1 (Theorem 2.1, [20]). For every $0<\epsilon \ll 1$ there exists $h_{0}(\epsilon)>0$ such that for $0<h \leq h_{0}(\epsilon),|\operatorname{Im} z| \geq h^{1-\epsilon}$, we have

$$
\begin{equation*}
\left\|\mathcal{N}_{e x t}(z, h) O p_{h}\left(\chi_{\epsilon / 2}^{-}\right)-O p_{h}\left(\rho \chi_{\epsilon / 2}^{-}\right)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C h^{1 / 2} \tag{5.2}
\end{equation*}
$$

and for $|\operatorname{Im} z| \leq h^{\epsilon}$ we have the estimate

$$
\begin{equation*}
\left\|\mathcal{N}_{e x t}(z, h) O p_{h}\left(\chi_{\epsilon / 2}^{+}\right)-O p_{h}\left(\rho \chi_{\epsilon / 2}^{+}\right)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C h^{1 / 2} \tag{5.3}
\end{equation*}
$$

Thus the problem is to get an estimate for $\left\|\mathcal{N}_{\text {ext }}(z, h) O p_{h}\left(\chi_{\epsilon / 2}^{0}\right)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)}$. We will prove the following

Theorem 5.2. For $h^{2 / 3} \leq \operatorname{Im} z \leq h^{\epsilon}$ we have the estimate

$$
\begin{equation*}
\left\|\mathcal{N}_{e x t}(z, h) O p_{h}\left(\chi_{\epsilon / 2}^{0}\right)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C h^{\epsilon / 2} \tag{5.4}
\end{equation*}
$$

Remark 1. By the analysis in [20] we may cover the region $h^{1-\epsilon} \leq \operatorname{Im} z \leq h^{\epsilon}$ but the above result is sufficient for our analysis since the region $0<\operatorname{Im} z \leq h^{2 / 3}$ is examined in Chapter 9 and 10 in [17], where a parametrix for the exterior Dirichlet problem is constructed with a precise estimate of the symbol of $\mathcal{N}_{\text {ext }}$ in small neighbourhood of the glancing set (see (10.31) in [17]).

Set for simplicity of notation $\mu=\operatorname{Im} z$. We will follow closely the construction of a semi-classical parametrix in Sections 5, 6 in [20]. The only difference is that we deal with an unbounded domain and the local form of $\mathcal{P}$ slightly changes. For the convenience of the reader we are going to recall the result in [15]. Let $\Omega_{\delta}=\{x \in \Omega: \operatorname{dist}(x, \Gamma)<\delta\}$. Since $K$ is strictly convex, in local normal geodesic coordinates $(x, \xi) \in T^{*}\left(\Omega_{\delta}\right)$, considered in Section 2, the principal symbol of $\mathcal{P}$ becomes

$$
p(x, \xi)=\xi_{1}^{2}+r_{0}\left(x^{\prime}, \xi^{\prime}\right)+x_{1} q_{1}\left(x^{\prime}, \xi^{\prime}\right)-1-\mathbf{i} \mu+\mathcal{O}\left(x_{1}^{2} r_{0}\right)
$$

with $0<C_{1} \leq q_{1}\left(x^{\prime}, \xi^{\prime}\right) \leq C_{2}$. Here locally in the interior of $K$ we have $x_{1}>0$, while in the exterior of $K$ we have $x_{1}<0$. Following [20], denote by $\mathcal{R}$ the set of functions $a \in C^{\infty}\left(T^{*}\left(\Omega_{\delta}\right)\right)$ satisfying with all derivatives the estimates

$$
a=\mathcal{O}\left(x_{1}^{\infty}\right)+\mathcal{O}\left(\xi_{1}^{\infty}\right)+\mathcal{O}\left(\left(1-r_{0}\right)^{\infty}\right)
$$

in a neighbourhood of $\mathcal{K}:=\left\{(x, \xi): x_{1}=\xi_{1}=1-r_{0}=0\right\}$. It was shown in Theorem 3.1 in [15] that there exists an exact symplectic map $\chi: T^{*}\left(\Omega_{\delta}\right) \rightarrow T^{*}\left(\Omega_{\delta}\right)$ so that $\chi(x, \xi)=(y(x, \xi), \eta(x, \xi))$ satisfies

$$
\begin{gathered}

\left(y^{\prime}, \eta^{\prime}\right)=\left(x^{\prime}, \xi^{\prime}\right)+\mathcal{O}\left(x_{1}\right), \\
(p \circ \chi(x, \xi))=\left(q_{1}\left(x^{\prime}, \xi^{\prime}\right)^{2 / 3}+\mathcal{O}\left(x_{1}\right)\right)\left(\xi_{1}^{2}+x_{1}-\zeta\left(x^{\prime}, \xi^{\prime}\right)\right),(\bmod \mathcal{R})
\end{gathered}

in a neighbourhood of $\mathcal{K}$ with

Let $\mathcal{U} \subset T^{*}\left(\Omega_{\delta}\right)$ be a small neighbourhood of $\mathcal{K}$. By using a $h$-Fourier integral operator on $\Omega_{\delta}$ associated to the canonical relation

By a simple change of variable $t=-x_{1}$, we pass to the situation when the exterior of $K$ is presented by $t>0$. Next one applies a new symplectic transformation of the tangential variables $\left(x^{\#}, \xi^{\#}\right)=\chi^{\#}\left(x^{\prime}, \xi^{\prime}\right) \in T^{*}(\Gamma)$ so that $\xi_{d}^{\#}=-L_{1}^{(0)}\left(x^{\prime}, \xi^{\prime}\right)$ (see Section 2 in [20]). Therefore the operator $P_{0}^{\prime}$ is transformed into

The only difference with [20] is the sign (-) in front of $t$ in the form of $\tilde{P}_{0}$.
For simplicity of the notations we denote the coordinates $\left(x^{\#}, \xi^{\#}\right)$ by $(y, \eta)$ and consider the operator

First we will treat the situation examined in Section 6 in [20] when $\mu>0$ and $\eta_{d}$ satisfy the conditions

\left(D_{t}^{2}-t+\eta_{d}-\mathbf{i} \mu q(y, \eta)\right) \Psi_{k}\left(-t h^{-2 / 3},\left(\eta_{d}-\mathbf{i} \mu q(y, \eta)\right) h^{-2 / 3}\right) \\
=-k h^{-2 / 3} \Psi_{k-1}\left(-t h^{-2 / 3},\left(\eta_{d}-\mathbf{i} \mu q(y, \eta)\right) h^{-2 / 3}\right)
\end{gathered}
$$

and

$$
\left(D_{t}^{2}-t+\eta_{d}-\mathbf{i} \mu q(y, \eta)\right) \mathcal{A}(t)=-h \sum_{k=0}^{M-1}(k+1) a_{k+1} \psi_{k}
$$

Next the construction of the parametrix goes without any changes as in Section 5 in [20] applying Lemmas 5.3, 5.4 and 5.5 instead of Lemmas 3.1, 3.2 and 3.3 in [20]. Thus as an analogue of Theorem 5.7 in [20] we get the following

Proposition 5.2. For all $s \geq 0$, we have the bounds

Combining Proposition 5.1 and Proposition 5.2, we obtain, as in [20], Theorem 5.2.
After this preparation we pass to the analysis of an eigenvalues-free region when

$$

Clearly,

$$

since $1-r_{0} \leq 1$, supp $\chi_{\epsilon / 2}^{+} \cap \operatorname{supp} \chi_{\epsilon / 2}^{-}=\emptyset$ and $1-\gamma^{2} \leq-\eta_{0}$. Thus for bounded $\left|\xi^{\prime}\right|$ we have $\left|g_{1}\right| \geq \eta_{2}>0$, while for $\left|\xi^{\prime}\right| \gg 1$ we get $\left|g_{1}\right| \sim\left|\xi^{\prime}\right|$. To estimate $g_{1}^{-1}$, it is necessary to estimate only $\rho\left(\chi_{\epsilon / 2}^{+}+\chi_{\epsilon / 2}^{-}\right)+\sqrt{z} \gamma$ and one deduces

The Dirichlet problem for $-h^{2} \Delta-z$ with $z=1+\mathrm{iIm} h^{2 / 3} w,|w| \leq C_{0}$, has been investigated by Sjöstrand in Chapters 9 and 10 in [17] (see also [1]). For $0 \leq w \leq 1$ this covers the region $\mathcal{D}$. In [17] the exterior Dirichlet-to-Neumann map $\mathcal{N}_{\text {ext }}(z, h)$ is defined with respect to the outgoing solution ${ }^{1}$ of the problem (1.5). Notice that for $\operatorname{Im} z>0$ the outgoing solutions are in $H_{h}^{2}(\Omega)$, so the exterior Dirichlet-to-Neumann map in [17] coincides with that defined in Section 2. We need to recall some results in Chapter 10 of [17]. The operator $\mathcal{N}_{\text {ext }}(z, h)$ is a $h$-pseudo-differential operator with symbol $n_{\text {ext }}\left(x^{\prime}, \xi^{\prime}, h\right)$. Introduce the glancing set

We have $\gamma(x) \geq 1+\eta_{3}>1, \forall x \in \Gamma$. Choose a small number $\delta_{0}, 0<\delta_{0}<\eta_{3} / 2$. Then for $\left|r_{0}\left(x^{\prime}, \xi^{\prime}\right)-1\right| \geq \delta_{0}$ the symbol $n_{\text {ext }}$ satisfies the estimates

while for $\left|r_{0}\left(x^{\prime}, \xi^{\prime}\right)-1\right| \leq 2 \delta_{0}$ we have the estimates

\end{equation*}

if $r_{0}\left(x^{\prime}, \xi^{\prime}\right)-1$ is transformed into $\xi_{d}$ by a tangential Fourier integral operator as it was mentioned in the beginning of this section. From the estimates near $\mathcal{G}$ it follows that for small $0<h \leq h_{0}\left(\delta_{0}\right)$ we have a bound

with a constant $C>0$ independent on $h$ and $\delta_{0}$. Let $f \neq 0$ be the trace of $\left.u\right|_{\Gamma}$, where $(u, v)$ is an eigenfunction of $G$. Consider the equality

&=\operatorname{Re}\left\langle\mathcal{N}_{e x t}(z, h) \phi\left(\frac{1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)}{\delta_{0}}\right) f, f\right\rangle_{L^{2}(\Gamma)} \tag{5.26}
\end{align*}
$$

The above estimate shows that the right hand side in (5.26) is bounded by $C_{1}\left(h^{1 / 3}+\delta_{0}^{1 / 2}\right)\|f\|_{L^{2}(\Gamma)}^{2}$.
Introduce two functions $\psi_{ \pm}(\sigma) \in C^{\infty}(\mathbb{R}:[0,1])$ such that $\psi_{+}(\sigma)=0$ for $\sigma \leq 1 / 2, \psi_{+}(\sigma)=1$ for $\sigma \geq 1, \psi_{-}(\sigma)=\psi_{+}(-\sigma)$. We write

\mathcal{N}_{e x t}(z, h)\left[1-\phi\left(\frac{1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)}{\delta_{0}}\right)\right]=\mathcal{N}_{e x t}(z, h) \chi_{+}+\mathcal{N}_{e x t}(z, h) \chi_{-}
$$

where

\chi_{ \pm}\left(x^{\prime}, \xi^{\prime}\right)=\left[1-\phi\left(\frac{1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)}{\delta_{0}}\right)\right] \psi_{ \pm}\left(\frac{1-r_{0}\left(x^{\prime}, \xi^{\prime}\right)}{\delta_{0}}\right)
$$

have support in $\left\{\left(x^{\prime}, \xi^{\prime}\right): 1-r_{0}\left(x^{\prime}, \xi^{\prime}\right) \geq \delta_{0} / 2\right\}$ and $\left\{\left(x^{\prime}, \xi^{\prime}\right): 1-r_{0}\left(x^{\prime}, \xi^{\prime}\right) \leq-\delta_{0} / 2\right\}$, respectively. The principal symbols $n_{ \pm}$of $\mathcal{N}_{\text {ext }}(z, h) \chi_{ \pm}$have the form

On the other hand,

In the same way for the principal symbol $n_{-}$of $\mathcal{N}_{\text {ext }}(z, h) \chi_{-}$we get

On the support of $\chi_{-}$we have $0<r_{0}-1<y \leq\left(r_{0}-1\right)+h^{2 / 3}$, and this implies $y^{1 / 2} \sin \frac{\psi}{2} \leq$ $\frac{1}{\sqrt{2}} h^{1 / 3}$. Combining the above estimates, we conclude that

Let $\sqrt{z}=v+\mathbf{i} w, v, w \in \mathbb{R}$. Then $v^{2}=1+w^{2} \geq 1$ yields $\operatorname{Re} \sqrt{z}=v \geq 1$. Consequently,

From this estimate and (5.27) one deduces that the left hand side of (5.26) is greater than $\left(\eta_{3}-C_{1} h^{1 / 3}\right)\|f\|_{L^{2}(\Gamma)}^{2}$. For small $h$ and small $\delta_{0}$ (depending on $\eta_{3}$ ) we obtain a contradiction with the estimate of the right hand side of (5.26). Finally, if $\operatorname{Re} z=1,0<\operatorname{Im} z \leq h^{2 / 3}$ with $0<h \leq h_{0}\left(\eta_{3}\right)$ there are no eigenvalues $\lambda=\frac{\mathbf{i} \sqrt{z}}{h}$ of $G$. Combining this with the result of Section 4 , completes the proof of Theorem 1.2.
6. Discreteness of the spectrum and trace formula. In this section we will prove the discreteness of the spectrum of $G$ in the left half plane using the Dirichlet-to-Neumann map and we establish a trace formula which can be useful for the study of the eigenvalues asymptotics. Before going to the proof of a trace formula for the counting function of the eigenvalues of $G$, we need to examine the properties of the Dirichlet-to-Neumann map $\mathcal{N}(\lambda)$ defined below. This map can be used to prove the discreteness of the spectrum of $G$ in $\{z \in \mathbb{C}: \operatorname{Re} z<0\}$. This result for $d$ odd was established in [6] and the proof there exploits the fact that the scattering operator $S(z)$ is invertible for $z=0$. For even dimensions $d$ this property of $S(z)$ is not true. We present a proof of the discreteness of the spectrum of $G$ based on the invertibility of an operator involving $\mathcal{N}(\lambda)^{-1}$ and it seems that for $d$ even this result is new.

Proposition 6.1. Let $\gamma(x) \neq 1$ for all $x \in \Gamma$. Then for $d \geq 2$ the spectrum of the generator $G$ in $\{z \in \mathbb{C}: \operatorname{Re} z<0\}$ is formed by isolated eigenvalues with finite multiplicities.

Proof. Consider for $\operatorname{Re} \lambda<0$ the map

$$
\mathcal{N}(\lambda):\left.H^{s}(\Gamma) \ni f \longrightarrow \partial_{\nu} u\right|_{\Gamma} \in H^{s-1}(\Gamma)
$$

where $u$ is the solution of the problem

\left(\Delta-\lambda^{2}\right) u=0 \text { in } \Omega, u \in H^{2}(\Omega)  \tag{6.1}\\
u=f \text { on } \Gamma
\end{array}\right.
$$

The condition $u \in H^{2}(\Omega)$ implies that $u$ is $\mathbf{i} \lambda$ - outgoing which means that there exists $R>\rho_{0}$ and a function $g \in L_{\text {comp }}^{2}\left(\mathbb{R}^{d}\right)$ such that

u(x)=\left(-\Delta_{0}+\lambda^{2}\right)^{-1} g,|x| \geq R
$$

where $R_{0}(\lambda)=\left(-\Delta_{0}+\lambda^{2}\right)^{-1}$ is the outgoing resolvent of the free Laplacian in $\mathbb{R}^{d}$ which is analytic for $\operatorname{Re} \lambda>0$. Recall that $R_{0}(\lambda)$ has kernel

where $H_{\nu}^{(1)}(x)$ is the Hankel function of first kind and we have the asymptotic (see for example, Chapter 7 in [12])

Below we present some well known facts for the sake of completeness. The solution of the Dirichlet problem (6.1) with $f \in H^{3 / 2}(\Gamma)$ has the representation

where $e(f): H^{3 / 2}(\Gamma) \ni f \rightarrow e(f) \in H_{\text {comp }}^{2}(\Omega)$ is an extension operator and $R_{D}(\lambda)=\left(-\Delta_{D}+\right.$ $\left.\lambda^{2}\right)^{-1}$ is the outgoing resolvent of the Dirichlet Laplacian $\Delta_{D}$ in $\Omega$ which is analytic for $\operatorname{Re} \lambda<0$. ${ }^{2}$ Therefore

\mathcal{N}(\lambda) f=\partial_{\nu}(e(f))+\partial_{\nu}\left[\left(-\Delta_{D}+\lambda^{2}\right)^{-1}\left(\Delta-\lambda^{2}\right)(e(f))\right]
$$

implies that $\mathcal{N}(\lambda)$ is analytic for $\operatorname{Re} \lambda<0$. The solution of (6.1) for $\operatorname{Re} \lambda<0$ can be written also as follows (see (2.4) in [10])

u(x ; \lambda)=\int_{\partial \Omega}\left[R_{0}(\lambda, x-y)(\mathcal{N}(\lambda) f)(y)-\frac{\partial R_{0}(\lambda, x-y)}{\partial \nu_{y}} f(y) d y\right] .

Taking the trace on $\Gamma$, this implies

\left(C_{00}(\lambda) f\right)(x)=\frac{f(x)}{2}+\int_{\Gamma} \frac{\partial R_{0}}{\partial \nu_{y}}(\lambda, x-y) f(y) d y=\frac{f(x)}{2}+(\mathcal{K}(\lambda) f)(x), \\
\left(C_{01}(\lambda) f\right)(x)=-\int_{\Gamma} R_{0}(\lambda, x-y) f(y) d y
\end{gathered}
$$

are the Calderon operators (see for example, [10]) which are analytic operator-valued functions for $\lambda \in \mathbb{C}$ for $d$ odd and on the logarithmic covering of $\mathbb{C}$ for $d$ even. The operators $\mathcal{K}(\lambda), C_{01}(\lambda)$ are pseudo-differential operators of order -1

Melrose proved ([10], Section 3) that there exists an entire family $P_{D}(\lambda)$ of pseudo-differential operators of order -1 on $\Gamma$ so that

\left(-\Delta_{\Gamma}+1\right)^{1 / 2} C_{01}(\lambda)=\operatorname{Id}+P_{D}(\lambda)
$$

$\Delta_{\Gamma}$ being the Laplace Beltrami operator on $\Gamma$. For $\operatorname{Re} \lambda<0$ this implies

On the other hand, it is well known that the Neumann problem

has no non trivial (i $\mathbf{i}$ )-outgoing solutions for $\operatorname{Re} \lambda<0$. This implies that for $\operatorname{Re} \lambda<0$ the operator $\mathcal{K}(\lambda)$ has not $1 / 2$ as an eigenvalues and since $\mathcal{K}(\lambda)$ is compact, we deduce that $\mathcal{N}(\lambda)^{-1}$ is analytic for $\operatorname{Re} \lambda<0$.

Going back to the problem (1.2), we write the boundary condition as follows

The operator $\mathcal{N}(\lambda)^{-1}: L^{2}(\Gamma) \longrightarrow H^{1}(\Gamma)$ is compact and by Theorems 1.2 and Theorem 1.3 there are points $\lambda_{0}, \operatorname{Re} \lambda_{0}<0$, for which ( $\operatorname{Id}-\lambda_{0} \mathcal{N}\left(\lambda_{0}\right)^{-1} \gamma$ ) is invertible. Applying the analytic Fredholm theorem, one concludes that the spectrum of $G$ in the open half-plane $\operatorname{Re} \lambda<0$ is formed by isolated eigenvalues with finite multiplicities.

Remark 2. The assumption $\gamma(x) \neq 1, \forall x \in \Gamma$, was used only to apply Theorems 1.2 and 1.3. For odd dimensions $d$ we can relax this assumption. Indeed, for $d$ odd we have no resonances in a small neighbourhood of 0 for the Dirichlet and Neumann problems, so we may apply the above argument in a open domain including a small neighbourhood of 0 . For $d$ even this property does not hold. ${ }^{3}$

[^2]Now we pass to a trace formula involving the operator

$$
C(\lambda):=\mathcal{N}(\lambda)-\lambda \gamma=\mathcal{N}(\lambda)\left(\operatorname{Id}-\lambda \mathcal{N}(\lambda)^{-1} \gamma\right),
$$

which by the analysis above is an analytic operator-valued function in $\{z \in \mathbb{C}: \operatorname{Re} z<0\}$, while $C(\lambda)^{-1}$ is meromorphic in the same domain. Our purpose is to find a formula for the trace

$$
\begin{equation*}
\operatorname{tr} \frac{1}{2 \pi i} \int_{\delta}(\lambda-G)^{-1} d \lambda \tag{6.5}
\end{equation*}
$$

where $\omega \subset\{\operatorname{Re} z<0\}$ is a domain with boundary a positively oriented curve $\delta$ and $(G-\lambda)^{-1}$ is analytic on $\delta$. Since $(G-\lambda)^{-1}$ is meromorphic in $\omega$, if $\lambda_{0}$ is a pole of $(G-\lambda)^{-1}$, the (algebraic) multiplicity of an eigenvalue $\lambda_{0}$ of $G$ is given by

$$
\operatorname{mult}\left(\lambda_{0}\right)=\operatorname{rank} \frac{1}{2 \pi i} \int_{\left|\lambda-\lambda_{0}\right|=\epsilon_{0}}(\lambda-G)^{-1} d \lambda
$$

with $\epsilon_{0}>0$ small enough and $\left\{\lambda \in \mathbb{C}:\left|\lambda-\lambda_{0}\right|=\epsilon_{0}\right\}$ positively oriented. Therefore, (6.5) is just equal to the number of the eigenvalues of $G$ in $\omega$ counted with their multiplicities. Let $(u, w)=(G-\lambda)^{-1}(f, g)$. Then we have $w=\lambda u+f$ and setting $q=\left.u\right|_{\Gamma}$, we get

$$
u=-R_{D}(\lambda)(g+\lambda f)+K(\lambda) q
$$

Here $R_{D}(\lambda)=\left(-\Delta_{D}+\lambda^{2}\right)^{-1}$ is the outgoing resolvent introduced in the proof of Proposition 6.1 and $K(\lambda)$ satisfies

$$
\left\{\begin{array}{l}
\left(\Delta-\lambda^{2}\right) K(\lambda)=0 \text { in } \Omega, \\
K(\lambda)=\operatorname{Id} \text { on } \Gamma .
\end{array}\right.
$$

The boundary condition on $\Gamma$ implies

$$
\partial_{\nu}\left[-R_{D}(\lambda)(g+\lambda f)+K(\lambda) q\right]-\gamma \lambda\left[-R_{D}(\lambda)(g+\lambda f)+q\right]-\gamma f=0, x \in \Gamma
$$

and the term $\gamma \lambda\left[R_{D}(\lambda)(g+\lambda f)\right.$ vanishes. Next $\mathcal{N}(\lambda)=\left.\partial_{\nu} K(\lambda)\right|_{\Gamma}$ is the Dirichlet-to-Neumann map, and assuming $C^{-1}(\lambda)$ invertible, one gets

$$
q=C^{-1}(\lambda)\left(\left[\partial_{\nu} R_{D}(\lambda)(g+\lambda f)\right]+\gamma f\right)
$$

Therefore

$$
\begin{gathered}
u=\left[-\lambda R_{D}(\lambda)+\lambda K(\lambda) C^{-1}(\lambda) \partial_{\nu} R_{D}(\lambda)+C^{-1}(\lambda) \gamma\right] f+X g \\
w=Y f+\left[\lambda R_{D}(\lambda)+\lambda K(\lambda) C^{-1}(\lambda) \partial_{\nu} R_{D}(\lambda)\right] g
\end{gathered}
$$

where the form of the operators $X$ and $Y$ is not important for the calculus of the trace. Thus we have the equality

$$
\operatorname{tr} \int_{\delta}(\lambda-G)^{-1} d \lambda=-\operatorname{tr} \int_{\delta}\left(2 \lambda K(\lambda) C^{-1}(\lambda) \partial_{\nu} R_{D}(\lambda)+C^{-1}(\lambda) \gamma\right) d \lambda
$$

The operator $C^{-1}(\lambda)$ is meromorphic with finite rank singularities near every pole. For the first term in the integral on the right hand side we apply Lemma 2.2 in [16] to permute the operators in the integrand combined with the equality

$$
\frac{\partial \mathcal{N}}{\partial \lambda}(\lambda)=\left.\partial_{\nu} \frac{\partial K}{\partial \lambda}(\lambda)\right|_{\Gamma}=-2 \lambda \partial_{\nu} R_{D}(\lambda) K(\lambda) .
$$

Finally, we obtain the following
Proposition 6.2. Assume $\gamma(x) \neq 1, \forall x \in \Gamma$. Let $\delta \subset\{z \in \mathbb{C}: \operatorname{Re} \lambda<0\}$ be a closed positively oriented curve and let $\omega$ be the domain bounded by $\delta$. Assume that $C^{-1}(\lambda)$ is meromorphic in $\omega$ without poles on $\delta$. Then

$$
\begin{equation*}
\operatorname{tr} \frac{1}{2 \pi i} \int_{\delta}(\lambda-G)^{-1} d \lambda=\operatorname{tr} \frac{1}{2 \pi i} \int_{\delta} C^{-1}(\lambda) \frac{\partial C}{\partial \lambda}(\lambda) d \lambda \tag{6.6}
\end{equation*}
$$

In the Appendix we show that for the ball in $\mathbb{R}^{3}$ and $\gamma \equiv$ const $>1$ we have infinite number real eigenvalues. We expect that in the case $(B)$ there are infinite number eigenvalues of $G$ lying in the domain $\mathcal{R}_{N}$ and it would be interesting to apply Proposition 6.2 to obtain a Weyl formula for these eigenvalues following the approach in [16] and [14].
7. Appendix. In this Appendix we assume that $\gamma \geq 0$ is a constant and $d$ odd. We examine the existence of the eigenvalues of $G$ for the ball $B_{3}=\left\{x \in \mathbb{R}^{3}:|x| \leq 1\right\}$. Consider the Dirichlet problem for the Helmholtz equation in the exterior of $B$.

$$
\left\{\begin{array}{l}
\left(\Delta-\lambda^{2}\right) u=0 \text { in }|x|>1, u \in H^{2}(|x| \geq 1)  \tag{7.1}\\
\left.u\right|_{|x|=1}=f \in L^{2}\left(\mathbb{S}^{2}\right)
\end{array}\right.
$$

Setting $\lambda=i \mu, \operatorname{Im} \mu>0$, it is well known that the outgoing solution of (7.1) in polar coordinates $(r, \omega), r \in \mathbb{R}^{+}, \omega \in \mathbb{S}^{2}$ is given by a series

$$
u(x, \mu)=\sum_{n=0}^{\infty} \sum_{m=-n}^{n} a_{n, m} \frac{h_{n}^{(1)}(\mu r)}{h_{n}^{(1)}(\mu)} Y_{n, m}(\omega),|x|=r
$$

Here $Y_{n, m}(\omega)$ are the spherical functions which are eigenfunctions of the Laplace-Beltrami operator $-\Delta_{\mathbb{S}^{2}}$ with eigenvalues $n(n+1)$ and

$$
h_{n}^{(1)}(r)=\frac{H_{n+1 / 2}^{(1)}(r)}{r^{1 / 2}}
$$

are the spherical (modified) Hankel functions of first kind. A classical result of Macdonald says that the zeros of the function $H_{n+1 / 2}^{(1)}(z)$ lie in the half plane $\operatorname{Im} z<0$ (see Theorem 8.2 in [12]).

The boundary condition in (7.1) is satisfied choosing $a_{n, m}$ so that

$$
\begin{equation*}
f(\omega)=\sum_{n=0}^{\infty} \sum_{m=-n}^{n} a_{n, m} Y_{n, m}(\omega) \tag{7.2}
\end{equation*}
$$

Now consider the boundary problem

$$
\left\{\begin{array}{l}
\left(\Delta-\lambda^{2}\right) u=0 \text { in }|x|>1, u \in H^{2}(|x| \geq 1)  \tag{7.3}\\
\partial_{r} u-\lambda \gamma u=0 \text { on } \mathbb{S}^{2}
\end{array}\right.
$$

We will prove the following
Proposition 7.1. For $\gamma=1$ and $\operatorname{Re} \lambda<0$ there are no non trivial solutions of (7.3). For $0<\gamma<1$ the eigenvalues of $G$ lie in the region

$$
\begin{equation*}
\left\{z \in \mathbb{C}: \pi / 4<|\pi-\operatorname{Arg} z|<\pi / 2,|z|>\frac{|\cos (\operatorname{Arg} z)|}{(1-\gamma)|\cos (2 \operatorname{Arg} z)|}\right\} \tag{7.4}
\end{equation*}
$$

Proof. Introduce the Dirichlet-to-Neumann map $\mathcal{N}(\lambda) f=\left.\partial_{r} u\right|_{|x|=1}$, where $u$ is the solution of (7.1). Assume that $(u, v)$ is an eigenfunction of $G$. Then $u$ satisfies (7.3). Setting $\left.u\right|_{|x|=1}=f$, $\lambda=\mathbf{i} \mu, \operatorname{Im} \mu>0$, the boundary condition implies

$$
\begin{equation*}
\mathcal{N}(\mathbf{i} \mu) f-\mathbf{i} \mu \gamma f=0 \text { on }|x|=1 \tag{7.5}
\end{equation*}
$$

and we deduce

$$
\sum_{n=0}^{\infty} \sum_{m=-n}^{n} C(n ; \mu, \gamma) a_{n, m} Y_{n . m}(\omega)=0
$$

with

$$
\begin{equation*}
C(n ; \mu, \gamma):=\left.\partial_{r}\left[\frac{h_{n}^{(1)}(\mu r)}{h_{n}^{(1)}(\mu)}\right]\right|_{r=1}-i \mu \gamma, n \in \mathbb{N} \tag{7.6}
\end{equation*}
$$

It is well known (see [12]) that the functions $h_{n}^{(1)}(x)$ have the form

$$
h_{n}^{(1)}(x)=(-\mathbf{i})^{n+1} \frac{e^{\mathbf{i} x}}{x} \sum_{m=0}^{n} \frac{\mathbf{i}^{m}}{m!(2 x)^{m}} \frac{(n+m)!}{(n-m)!}=(-\mathbf{i})^{n+1} \frac{e^{\mathbf{i} x}}{x} R_{n}\left(\frac{\mathbf{i}}{2 x}\right)
$$

with

$$
R_{n}(z):=\sum_{m=0}^{n} \frac{z^{m}}{m!} \frac{(n+m)!}{(n-m)!}
$$

The problem is reduced to show that $C(n ; \mu, \gamma) \neq 0$ for all $n \in \mathbb{N}$, if $\gamma=1$ or $\lambda$ lies in the region (7.4) in the case $0<\gamma<1$.

In fact this implies that all coefficients $a_{n, m}$ vanish, so $f=0$. Taking the derivative with respect to $r$, one obtains

$$
\begin{equation*}
C(n ; \mu, \gamma)=\mathbf{i} \mu(1-\gamma)-\sum_{m=0}^{n}(m+1) \frac{\mathbf{i}^{m}}{m!(2 \mu)^{m}} \frac{(n+m)!}{(n-m)!}\left(R_{n}\left(\frac{\mathbf{i}}{2 \mu}\right)\right)^{-1} . \tag{7.7}
\end{equation*}
$$

Setting $w=\frac{\mathbf{i}}{2 \mu}=\frac{\mathbf{i} \bar{\mu}}{2|\mu|^{2}}$, one deduces

$$
\begin{equation*}
-C(n ; \mu, \gamma)=\frac{1}{2 w}(1-\gamma)+\left(R_{n}(w)\right)^{-1} \frac{d}{d w}\left(w R_{n}(w)\right) \tag{7.8}
\end{equation*}
$$

Notice that $\operatorname{Re} \frac{\mathbf{i} \bar{\mu}}{|\mu|^{2}}>0$ implies $\operatorname{Re} w>0$, so we wish to prove that $C(n ; \mu, \gamma) \neq 0$ for $\operatorname{Re} w>0$. The case $n=0$ is trivial because $\mathbf{i} \mu(1-\gamma)-1 \neq 0$. We know that $R_{n}(w)$ has no roots in the half plane $\operatorname{Re} w \geq 0$. This implies that the roots of $w R_{n}(w)=0$ lie in the half plane $\operatorname{Re} w \leq 0$. By the classical Gauss-Lucas theorem the roots of $\frac{d}{d w}\left(w R_{n}(w)\right)=0$ lie in the convex set of the roots of $w R_{n}(w)=0$ and one deduces that $\frac{d}{d w}\left(w R_{n}(w)\right) \neq 0$ for Re $w>0$. Thus for $\gamma=1$ we have no eigenvalues of $G$.

For $0<\gamma<1$ we must examine the zeros of the function

$$
g_{n}(w)=\frac{1}{2 w^{2}}(1-\gamma)+\frac{1}{w}+\sum_{j=1}^{n} \frac{1}{w-z_{j}}, n \geq 1
$$

where $z_{j}$, Re $z_{j}<0, j=1, \ldots, n$, are the roots of $R_{n}(w)=0$. If fact, if $R_{n}\left(w_{0}\right)=0$, we have $H_{n+1 / 2}^{(1)}\left(\frac{\mathbf{i}}{2 w_{0}}\right)=0$ and this implies Re $w_{0}<0$. We obtain

$$
\begin{equation*}
\operatorname{Re} g_{n}(w)=\frac{(1-\gamma)\left((\operatorname{Re} w)^{2}-(\operatorname{Im} w)^{2}\right)+2 \operatorname{Re} w|w|^{2}}{2|w|^{4}}+\sum_{j=1}^{n} \frac{\operatorname{Re} w-\operatorname{Re} z_{j}}{\left|w-z_{j}\right|^{2}} \tag{7.9}
\end{equation*}
$$

If $\operatorname{Re} g_{n}(w)=0$, we must have

$$
2 \operatorname{Re} w|w|^{2}+(1-\gamma)\left((\operatorname{Re} w)^{2}-(\operatorname{Im} w)^{2}\right)<0
$$

Setting $w=-\frac{1}{2 \lambda}$, the last inequality implies

$$
|\operatorname{Re} \lambda|<|\operatorname{Im} \lambda|, \operatorname{Re} \lambda>(1-\gamma)\left((\operatorname{Re} \lambda)^{2}-(\operatorname{Im} \lambda)^{2}\right)
$$

and we obtain that the eigenvalues of $G$ belong to the domain (7.4).
Passing to the case $\gamma>1$, we have the following
Proposition 7.2. For $\gamma>1$ all eigenvalues $\lambda$ for which (7.3) has a non trivial solution are real and they lie in the interval $\left(-\infty,-\frac{1}{\gamma-1}\right]$. Moreover, there is an infinite number of real eigenvalues of $G$.

Proof. To prove the existence of real eigenvalues, consider the polynomial

$$
F_{n}(w)=\left[\frac{1}{2}(1-\gamma)+w\right] R_{n}(w)+w^{2} R_{n}^{\prime}(w)
$$

Clearly, $F_{n}(0)<0$ and $F_{n}(w) \rightarrow+\infty$ as $w \rightarrow+\infty$, so $F_{n}(w)=0$ has at least one root $w_{0}$ in $\mathbb{R}^{+}$ and $C\left(n ; \mu_{0}, \gamma\right)=0$ for $\mu_{0}=\frac{\mathbf{i}}{2 w_{0}}$.

Now suppose that $w_{0} g_{n}\left(w_{0}\right)=0, n \geq 1$ with $\operatorname{Re} w_{0}>0, \operatorname{Im} w_{0} \neq 0$. Then $\operatorname{Im}\left(w_{0} g_{n}\left(w_{0}\right)\right)=0$ implies

$$
\begin{gather*}
-\frac{(1-\gamma) \operatorname{Im} w_{0}}{2\left|w_{0}\right|^{2}}+\operatorname{Re} w_{0}\left[-\sum_{j=1}^{n} \frac{\operatorname{Im} w_{0}}{\left|w_{0}-z_{j}\right|^{2}}+\sum_{j=1}^{n} \frac{\operatorname{Im} z_{j}}{\left|w_{0}-z_{j}\right|^{2}}\right]  \tag{7.10}\\
+\operatorname{Im} w_{0} \sum_{j=1}^{n} \frac{\operatorname{Re} w_{0}-\operatorname{Re} z_{j}}{\left|w_{0}-z_{j}\right|^{2}}=0
\end{gather*}
$$

On the other hand, if $z_{j}$ with $\operatorname{Im} z_{j} \neq 0$ is a root of $R_{n}(w)=0$, then $\overline{z_{j}}$ is also a root and

$$
\begin{aligned}
\frac{\operatorname{Im} z_{j}}{\left|w_{0}-z_{j}\right|^{2}}-\frac{\operatorname{Im} z_{j}}{\left|w_{0}-\bar{z}_{j}\right|^{2}} & =\frac{\operatorname{Im} z_{j}}{\left|w_{0}-z_{j}\right|^{2}\left|w_{0}-\bar{z}_{j}\right|^{2}}\left(\left|w_{0}-\bar{z}_{j}\right|^{2}-\left|w_{0}-z_{j}\right|^{2}\right) \\
& =\frac{4 \operatorname{Im} w_{0}\left(\operatorname{Im} z_{j}\right)^{2}}{\left|w_{0}-z_{j}\right|^{2}\left|w_{0}-\bar{z}_{j}\right|^{2}}
\end{aligned}
$$

Hence we can write (7.10) as follows

$$
\begin{equation*}
\operatorname{Im} w_{0}\left[\frac{\gamma-1}{2\left|w_{0}\right|^{2}}-\sum_{j=1}^{n} \frac{\operatorname{Re} z_{j}}{\left|w_{0}-z_{j}\right|^{2}}+\sum_{\operatorname{Im} z_{j}>0} \frac{4 \operatorname{Re} w_{0}\left(\operatorname{Im} z_{j}\right)^{2}}{\left|w_{0}-z_{j}\right|^{2}\left|w_{0}-\bar{z}_{j}\right|^{2}}\right]=0 \tag{7.11}
\end{equation*}
$$

The term in the brackets [...] is positive, and one concludes that $\operatorname{Im} w_{0}=0$. The same argument works for $\gamma=1$ since $z_{j} \neq 0$. Thus for $\gamma=1$ we may have only real roots and since $w R_{n}^{\prime}(w) \neq 0$ for $w>0$ we conclude that there are no roots of $g_{n}(w)=0$. This implies again the absence of eigenvalues for $\gamma \equiv 1$.

From $\operatorname{Re} g_{n}\left(w_{0}\right)=0$, one deduces for the real roots $w_{0}$ the inequality

$$
2 w_{0}+(1-\gamma)<0
$$

and this yields for the eigenvalues $\lambda$ of $G$ the estimate

$$
\lambda \leq-\frac{1}{\gamma-1}
$$

It remains to show that we have an infinite number of real eigenvalues. It is not excluded that for $n \neq m$ the polynomials $F_{n}(w)$ and $F_{m}(w)$ have the same real positive root. If we assume that for Re $w>0$ the sequence of polynomials $\left\{F_{n}(w)\right\}_{n=0}^{\infty}$ has only a finite number of real roots $w_{1}, \ldots, w_{N}, w_{j} \in \mathbb{R}^{+}$, then there exists an infinite number of polynomials $F_{n_{j}}(w)$ having the same root which implies that we have an eigenvalue of $G$ with infinite multiplicity. This is a contradiction, and the number of real eigenvalues of $G$ is infinite.

Remark 3. With small modifications Propositions 7.1 and 7.2 can be established for the ball $\left\{x \in \mathbb{R}^{d}:|x| \leq 1\right\}$ and $d \geq 5$ odd, by using the modified Hankel functions

$$
\frac{H_{n+d / 2-1}^{(1)}(r)}{r^{d / 2-1}}
$$

and the eigenfunctions $Y_{n, m}(\omega)$ of the Laplace-Beltrami operator $-\Delta_{S^{d-1}}$ with eigenvalues $n(n+$ $d-2)$.
