# Penalization of Robin boundary conditions

#### Abstract

This paper is devoted to the mathematical analysis of a method based on fictitious domain approach. Boundary conditions of Robin type (also known as Fourier boundary conditions) are enforced using a penalization method. A complete description of the method and a full analysis are provided for univariate elliptic and parabolic problems using finite difference approximation. Numerical evidence of the predicted estimations is provided as well as numerical results for a nonlinear problem and a first extension of the method in the bivariate situation is proposed.

## 1. Introduction

This paper is devoted to the definition and analysis of a finite difference fictitious domain method where the boundary conditions of Robin type are enforced using a penalization method. As for all fictitious domain methods, the initial problem with solution $u$ and raised hyperbolic [22, 13, 14, 10] equations. The main advantage of penalization methods stands in allowing the numerical resolution of the problem in an obstacle-free simple domain. There, the use of a Cartesian mesh is possible and different numerical methods including pseudospectral methods [18], finite differences/volumes [4, 20, 22] and wavelets [26, 27, 19] can be implemented efficiently to approximate the solution.

This paper can be considered as a continuation of [16] where Dirichlet boundary conditions were considered. The scope of that paper was the modeling of the plasma-wall interaction

[^0]in the region of a tokamak called Scrape-Off Layer (SOL), where magnetic field lines are open and intercept solid obstacles. A volume penalization method has been proposed to $0<x_{l}<x_{r}<1$.

The paper is organized as follows: Section 2 is devoted to elliptic equations. The penalized problem is introduced and existence, uniqueness and convergence of the solution in regard to penalization parameter are established. Numerical approximation of the problem using finite differences is defined and analyzed in Section 2.6. Convergence and stability analysis are provided and illustrated by various numerical tests. Parabolic equations are considered in Section 3 where a time discretization followed by space discretization are used. The analysis is performed and illustrated by various simulations. Section 4 is devoted to numerical tests for a nonlinear problem describing the temperature in the plasma of a tokamak close to an obstacle. A first application of the method to the bivariate situation is also presented.

## 2. Elliptic equation

### 2.1. Definition of the problem

An archetype of elliptic partial differential equations with Robin boundary conditions is the so called reaction-diffusion equation

\begin{cases}-\Delta u+u=f & \text { in } \omega \\ \frac{\partial u}{\partial n}+\alpha u=g & \text { on } \partial \omega\end{cases}
$$

where $\omega$ is a given smooth bounded open set in $\mathbb{R}^{D}, n$ is the outward-pointing unit normal vector on the boundary $\partial \omega, f \in L^{2}(\omega), g \in L^{2}(\partial \omega)$ and $\alpha \geq 0$ are given. The case $\alpha=0$ corresponds to Neumann boundary conditions. The Lax-Milgram theorem [1, 11] provides
the existence and uniqueness of the solution $u \in H^{1}(\omega)$ of its weak formulation. In the particular case $D=1$ and $\omega=] 0,1[$, the problem reads

-u^{\prime}(0)+\alpha u(0)=g(0), u^{\prime}(1)+\alpha u(1)=g(1)

The unique solution $u \in H^{1}(] 0,1[)$ of the weak formulation of (2.1) is in fact in $H^{2}(] 0,1[)$ $H^{2}(] 0,1[) \hookrightarrow C^{1}([0,1])$ that $u \in C^{1}([0,1])$ and, if $f \in C^{0}([0,1])$ that $u \in C^{2}([0,1])$.

As presented on Figure 1 left, $\Omega=] 0,2[$ is used to define a penalized problem associated with (2.1). Denoting $\chi$ the characteristic function of $\Omega \backslash \bar{\omega}=] 1,2[$ and introducing a real parameter $\eta>0$, a new problem raised on $\Omega$ with Robin boundary conditions at the boundary points reads

-u_{\eta}^{\prime}(0)+\alpha u_{\eta}(0)=g(0), u_{\eta}^{\prime}(2)+\alpha u_{\eta}(2)=g(1)
\end{array}\right.
$$

When $x \in] 0,1[, \chi(x)=0$ and we recover the equation of (2.1) with the Robin condition at $x=0$ unchanged. When $x \in] 1,2[, \chi(x)=1$, and using a small value of $\eta$ implies that the leading term in the first equation of (2.2) is $\frac{1}{\eta}\left(u_{\eta}^{\prime}+\alpha u_{\eta}-g(1)\right)$ which imposes ${ }_{50} u_{\eta}^{\prime}+\alpha u_{\eta}-g(1) \approx 0$. We therefore recover, at least formally, the boundary conditions of (2.1).

Remark 2.1. Boundary conditions at $x=2$ have been set to Robin type but different conditions could be enforced at this point.

In the following sections, we prove that this penalized problem $(2.2)$ is well-posed in its weak form:

and that its unique solution $u_{\eta}$ tends, when $\eta$ goes to 0 , to a function $\bar{u}$ whose restriction to

### 2.2. Existence and uniqueness

The coercivity of the bilinear form associated with the weak formulation (2.3) is not satisfied for all $\eta>0$, and the Lax-Milgram theorem can not be applied. We have the following:
${ }^{60}$ Lemma 2.2. For all $\eta>0$, there exists a unique solution $u_{\eta} \in H^{1}(] 0,2[)$ of the weak formulation (2.3) of the penalized problem (2.2). In addition, $u_{\eta} \in C^{1}([0,2])$.

Proof. We first establish the regularity result. If $u_{\eta} \in H^{1}(] 0,2[)$ is solution of the penalized problem (2.2) in its weak form (2.3) then $u_{\eta} \in H^{2}(] 0,2[) \hookrightarrow C^{1}([0,2])$. We therefore seek a solution of class $C^{1}$ and looking at the equations satisfied in $] 0,1[$ and $] 1,2\left[\right.$ respectively, $u_{\eta}$ is of the form

u_{\eta}(x)= \begin{cases}\lambda_{1} e^{x}+\mu_{1} e^{-x}+u(x) & \text { if } x \in] 0,1[  \tag{2.4}\\ \lambda_{2} e^{r_{1} x}+\mu_{2} e^{r_{2} x}+\frac{g(1)}{\eta+\alpha} & \text { if } x \in] 1,2[,\end{cases}
$$

where

r_{1}=\frac{1}{2}\left(\frac{1}{\eta}+\sqrt{\frac{1}{\eta^{2}}+4\left(1+\frac{\alpha}{\eta}\right)}\right) \quad \text { and } \quad r_{1} r_{2}=-\left(1+\frac{\alpha}{\eta}\right) .

Taking into account the Robin boundary conditions at $x=0$ and $x=2$ as well as the continuity of $u_{\eta}$ and its derivative at $x=1$, leads to the following linear system:

Its matrix $M$ satisfies $\operatorname{det}(M)=e^{\left(-1+r_{1}+r_{2}\right)}\left(A+\alpha B+\alpha^{2} C\right)$ with $\alpha \geq 0$ and

& A=\left(e^{2}-1\right)\left(r_{1} e^{r_{1}}-r_{2} e^{r_{2}}\right)+\left(1+e^{2}\right) r_{1} r_{2}\left(e^{r_{2}}-e^{r_{1}}\right) \\
& B=\left(1+e^{2}\right)\left(e^{r_{1}}+e^{r_{2}}\right)\left(r_{1}-r_{2}\right)+\left(e^{2}-1\right)\left(r_{1} r_{2}-1\right)\left(e^{r_{2}}-e^{r_{1}}\right) \\
& C=\left(e^{2}-1\right)\left(r_{1} e^{r_{2}}-r_{2} e^{r_{1}}\right)+\left(1+e^{2}\right)\left(e^{r_{1}}-e^{r_{2}}\right)

Since $r_{1}>0$ and $r_{2}=-\left(1+\frac{\alpha}{\eta}\right) / r_{1}<0$, we have $r_{1} r_{2}<0, r_{1}>r_{2}$ and $e^{r_{1}}>e^{r_{2}}$. Therefore, $A>0, B>0$ and $C>0$, and we conclude that $\operatorname{det}(M)>0$.

The system 2.5) has then a single solution $\left(\lambda_{1}, \mu_{1}, \lambda_{2}, \mu_{2}\right)^{T}$, leading to the existence and uniqueness of $u_{\eta}$ solution of (2.2).

### 2.3. Convergence

We now investigate the limit of $u_{\eta}$ when $\eta$ goes to zero. We have the following result:
Lemma 2.3. The solution $u_{\eta}$ of the penalized problem (2.2) simply converges, when $\eta \rightarrow 0^{+}$, to $\bar{u}$ with

- $\bar{u}_{\mid 0,1[ }=u$ solution of the original problem 2.1),
- $\bar{u}{ }_{\mid 11,2[ }=v$ solution of $\left\{\begin{array}{l}\left.v^{\prime}+\alpha v=g(1) \quad \text { in }\right] 1,2[ \\ v(1)=u(1) .\end{array}\right.$

In other words,

$$

Proof. One has

\lim _{\eta \rightarrow 0^{+}} r_{1}=+\infty\left(r_{1} \sim \frac{1}{\eta}\right) \quad \text { and } \quad \lim _{\eta \rightarrow 0^{+}} r_{2}=-\alpha
$$

Introducing $\lambda_{2}^{*}=\lambda_{2} r_{1} e^{2 r_{1}}$ and $\mu_{2}^{*}=\mu_{2}+\frac{g(1)}{\eta+\alpha}$, one has for $x \in[1,2]$,

u_{\eta}(x)=\lambda_{2}^{*} \frac{1}{r_{1} e^{2 r_{1}}} e^{r_{1} x}+\mu_{2}^{*} e^{r_{2} x}-\frac{g(1)}{\eta+\alpha} e^{r_{2} x}+\frac{g(1)}{\eta+\alpha},
$$

and

Looking at the system satisfied by $\left(\lambda_{1}, \mu_{1}, \lambda_{2}^{*}, \mu_{2}^{*}\right)^{T}$, the system (2.5) reads now $A_{\eta} X_{\eta}=b_{\eta}$ as follows:

The matrix $A_{\eta}$ is invertible since $\operatorname{det}\left(A_{\eta}\right)=\frac{1}{r_{1} e^{2 r_{1}}} \operatorname{det}(M) \neq 0$. Moreover, $A_{\eta} \xrightarrow[\eta \rightarrow 0^{+}]{ } A$ and $b_{\eta} \xrightarrow[\eta \rightarrow 0^{+}]{ } b$ with

\alpha-1 & \alpha+1 & 0 & 0 \\

Since $A$ is invertible, it follows that $X_{\eta}=A_{\eta}^{-1} b_{\eta} \xrightarrow[\eta \rightarrow 0^{+}]{\longrightarrow} A^{-1} b=X$. We obtain

Finally, taking the limit $\eta \rightarrow 0^{+}$in 2.4 yields the desired result.
Remark 2.4. The positive sign in front of the penalization term in problem (2.2) is important: the penalized problem with the opposite sign has also a unique solution $u_{\eta}$ for every $\eta>0$
${ }_{75}$ but this solution generally does not converge to the solution $u$ of (2.1) in $[0,1]$. The sign determines the direction of advection $\left(\frac{\chi}{\eta} u_{\eta}^{\prime}\right)$, the positive sign thus means a convection to the right: what happens in the domain [1, 2] does not influence the solution in $[0,1]$ when $\eta$ approaches 0 .

### 2.4. Error estimate

Lemma 2.5. In the domain $[0,1],\left\|u_{\eta}-u\right\|=\underset{\eta \rightarrow 0^{+}}{O}(\eta)$ for $L^{\infty}, L^{1}, L^{2}$ and $H^{1}$ norms.
Proof. Following (2.4), for $x \in[0,1]$, one has $u_{\eta}(x)-u(x)=\lambda_{1} e^{x}+\mu_{1} e^{-x}$ and $u_{\eta}^{\prime}(x)-u^{\prime}(x)=$ $\lambda_{1} e^{x}-\mu_{1} e^{-x}$. In addition, $(\alpha-1) \lambda_{1}+(\alpha+1) \mu_{1}=0$ from (2.7) and $\lambda_{1}$ is given using Cramer's rule by:

\alpha u(1)-g(1)\left(1+\frac{r_{2} e^{r_{2}}}{\eta+\alpha}\right) & -e^{-1} & -\frac{1}{e^{r_{1}}} & -r_{2} e^{r_{2}}

Using Taylor or asymptotic expansions as $\eta \rightarrow 0^{+}$, we obtain $\operatorname{det}\left(A_{\eta}\right)=\operatorname{det}(A)+o(1)$ and $\operatorname{det}\left(A_{\eta \lambda 1}\right)=-(\alpha+1) e^{-\alpha}\left(g(1) \alpha+u(1)\left(1-\alpha^{2}\right)\right) \eta+o(\eta)$ in both cases $\alpha>0$ and $\alpha=0$.

Finally,

$$
\lambda_{1}=-\frac{(\alpha+1)\left(g(1) \alpha+u(1)\left(1-\alpha^{2}\right)\right)}{\left(1+\alpha^{2}\right)\left(e-e^{-1}\right)+2 \alpha\left(e+e^{-1}\right)} \eta+o(\eta) \quad \text { and } \quad \mu_{1}=\frac{1-\alpha}{1+\alpha} \lambda_{1} .
$$

Using the estimates $\lambda_{1}=O(\eta)$ and $\mu_{1}=O(\eta)$ as $\eta \rightarrow 0^{+}$, the result of Lemma 2.5 is now straightforward.

### 2.5. Stability

The following result provides information about the continuous dependence of the solution $u_{\eta}$ on the data $f$ and $g$ :

Lemma 2.6. The application $(f, g) \in L^{2}(] 0,1[) \times L^{2}(\{0,1\}) \mapsto u_{\eta \mid] 0,1[ } \in H^{1}(] 0,1[)$ is linear continuous for all $\eta>0$. In addition

$$
\exists C>0, \quad\left\|u_{\eta}\right\|_{H^{1}(0,1[)} \underset{\eta \rightarrow 0^{+}}{\leq} C\left(\|f\|_{L^{2}}+\|g\|_{L^{2}(\{0,1\})}\right),
$$

where $C$ is independent of $\eta$.
Proof. The linearity of the application is a consequence of the linearity of the penalized problem (2.2). Expanding the determinant at the numerator of (2.8) along the first column and using that the determinant at the denominator depends only on $\eta$ ( $\alpha$ being fixed), we can write $\lambda_{1}=g(1) D_{\eta}^{1}+u(1) D_{\eta}^{2}$. Thus, using also $\mu_{1}=\frac{1-\alpha}{1+\alpha} \lambda_{1}$,

& \leq C_{1} D_{\eta}(|g(1)|+|u(1)|)+\|u\|_{H^{1}(] 0,1[)} \tag{2.9}

where $D_{\eta}=\max \left(\left|D_{\eta}^{1}\right|,\left|D_{\eta}^{2}\right|\right)$.

On the other hand, the application $(f, g) \in L^{2}(] 0,1[) \times L^{2}(\{0,1\}) \mapsto u \in H^{1}(] 0,1[)$ is linear continuous. Indeed, taking as test function $u$ itself in the weak formulation yields

& \leq\|f\|_{L^{2}}\|u\|_{H^{1}}+C_{2}\|g\|_{L^{2}(\{0,1\})}\|u\|_{H^{1}}

using the continuity of the trace application. Hence $\|u\|_{H^{1}} \leq C_{3}\left(\|f\|_{L^{2}}+\|g\|_{L^{2}(\{0,1\})}\right)$, where $C_{3}=\max \left(1, C_{2}\right)$.

Using also $|g(1)| \leq \sqrt{g^{2}(0)+g^{2}(1)} \leq\|g\|_{L^{2}(\{0,1\})}$ and $|u(1)| \leq \sqrt{u^{2}(0)+u^{2}(1)} \leq\|u\|_{L^{2}(\{0,1\})} \leq$ $\left.C_{2}\|u\|_{H^{1}}, 2.9\right)$ gives $\left\|u_{\eta}\right\|_{H^{1}(j 0,1[)} \leq C_{\eta}\left(\|f\|_{L^{2}}+\|g\|_{L^{2}(\{0,1\})}\right)$, where $C_{\eta}=C_{1} D_{\eta}\left(1+C_{2} C_{3}\right)+C_{3}$, which proves the continuity of the considered linear application for all $\eta>0$.

By reconsidering the expansion of the determinant $\operatorname{det}\left(A_{\eta \lambda_{1}}\right)$ along the first column, we find using the Taylor expansion obtained for $\lambda_{1}$ as $\eta \rightarrow 0^{+}$in the proof of Lemma 2.5 that $D_{\eta}^{1}=-\frac{(\alpha+1) \alpha}{\left(1+\alpha^{2}\right)\left(e-e^{-1}\right)+2 \alpha\left(e+e^{-1}\right)} \eta+o(\eta)$ and $D_{\eta}^{2}=-\frac{(\alpha+1)\left(1-\alpha^{2}\right)}{\left(1+\alpha^{2}\right)\left(e-e^{-1}\right)+2 \alpha\left(e+e^{-1}\right)} \eta+o(\eta)$. Therefore $D_{\eta} \xrightarrow[\eta \rightarrow 0^{+}]{ } 0$ and $C_{\eta} \xrightarrow[\eta \rightarrow 0^{+}]{ } C_{3}$, the continuity constant of the original problem. We thus obtain finally the inequality

for a constant $C=C_{3}+\varepsilon$ independent of $\eta$.

### 2.6. Numerical approximation

For the numerical approximation, we consider the geometry that arises in plasma application: the fluid domain where the initial equation is raised is $\omega=] 0, x_{l}[\cup] x_{r}, 1[$ and the solid obstacle is located in $] x_{l}, x_{r}$ [ centered at $x=0.5$, with $x_{l}=0.5(1-d)$ and $x_{r}=0.5(1+d)$ where $d$ is the size of the obstacle, as represented in Figure 1 right. The reaction-diffusion equation is satisfied in $\omega$ with Robin boundary conditions at the obstacle boundary $\left\{x_{l}, x_{r}\right\}$ and periodic boundary conditions at $x=0$ and $x=1$, corresponding to the physical situation. Therefore, the initial problem reads

The penalization technique proposed in the previous sections applies here as follows:

where $\chi$ is the characteristic function of the entire obstacle domain $] x_{l}, x_{r}\left[, \chi_{l}\right.$ is the characteristic function of the left part $] x_{l}, x_{l}+\Delta_{l}$ [ of the obstacle domain and $\chi_{r}$ is the characteristic that both intervals are disjoint, see Figure 1 right.

Adapting the theoretical results obtained for the problem (2.1) and its penalization (2.2), it can be shown that the penalized problem (2.11) is well-posed in its weak form for all $\eta>0$, and that its unique solution $u_{\eta}$ tends, when $\eta$ goes to 0 , to a function $\bar{u}$ whose restriction to $] 0, x_{l}[\cup] x_{r}, 1[$ is the solution $u$ of the original problem (2.10).
Remark 2.7. As in Remark 2.4, the signs considered in (2.11) for the penalization terms were chosen in order to have an advection which goes from the fluid domain to the solid domain. In addition, a free part was introduced in the middle of the obstacle to avoid communication between left and right parts when $\eta$ goes to 0 .

### 2.6.1. Numerical analysis

The penalized problem (2.11) is discretized using finite differences. We consider a uniform subdivision $\left(x_{i}\right)_{1 \leq i \leq N+1}$ of $[0,1]$ of step size $h\left(x_{i}=(i-1) h=\frac{i-1}{N}\right)$ and the following scheme:

To simplify the notations, we use $g_{l}$ instead of $g\left(x_{l}\right)$ and $g_{r}$ instead of $g\left(x_{r}\right)$. The vector $\left(U_{i}\right)_{1 \leq i \leq N+1}$ is expected to be an approximation of $\left(u_{\eta}\left(x_{i}\right)\right)_{1 \leq i \leq N+1}$. The linear system $A_{h} U_{h}=$ $r_{h}$ associated with (2.12) reads

where $a_{i}=-\frac{1}{h^{2}}-\frac{\chi_{l}\left(x_{i}\right)}{\eta} \frac{1}{h}, b_{i}=1+\frac{2}{h^{2}}+\frac{\chi_{l}\left(x_{i}\right)+\chi_{r}\left(x_{i}\right)}{\eta}\left(\frac{1}{h}+\alpha\right), c_{i}=-\frac{1}{h^{2}}-\frac{\chi_{r}\left(x_{i}\right)}{\eta} \frac{1}{h}$ and $r_{i}=$ $\left(1-\chi\left(x_{i}\right)\right) f\left(x_{i}\right)+\frac{\chi_{l}\left(x_{i}\right)}{\eta} g_{l}+\frac{\chi_{r}\left(x_{i}\right)}{\eta} g_{r}$. We prove in the following the consistency and the stability of the finite difference scheme.

Lemma 2.8 (Existence and uniqueness). For all $\eta, h>0$, the system (2.13) has a unique solution.

Proof. For $1 \leq i \leq N$, one has $b_{i}>0, a_{i}<0$ and $c_{i}<0$, thus

$A_{h}$ is consequently a strictly diagonally dominant matrix, hence invertible by the Hadamard lemma.

Lemma 2.9 (Stability). For all $\eta, h>0$, the finite difference scheme (2.13) is stable in the norm $\|\cdot\|_{\infty}$ with $\left\|A_{h}^{-1}\right\|_{\infty} \leq 1$.

Proof. The main argument is that the matrix $A_{h}$ is strictly diagonally dominant with $\left|\left(A_{h}\right)_{i i}\right|-$ $\sum_{j \neq i}\left|\left(A_{h}\right)_{i j}\right| \geq \delta>0$ where $\delta$ is independent of $h$.

Considering $M \in\{1, \ldots, N\}$ such that $\left|U_{M}\right|=\max _{1 \leq i \leq N}\left|U_{i}\right|=\left\|U_{h}\right\|_{\infty}$, it follows

which shows that in all cases $\left|U_{M}\right| \leq\left|r_{M}\right|$ since $\left|b_{M}\right|-\left|a_{M}\right|-\left|c_{M}\right| \geq 1$ and $-\left|U_{i}\right| \geq-\left|U_{M}\right|$. Finally, using $\left|r_{M}\right| \leq\left\|r_{h}\right\|_{\infty}$ we obtain $\left\|U_{h}\right\|_{\infty} \leq\left\|r_{h}\right\|_{\infty}$ that is $\left\|A_{h}^{-1}\right\|_{\infty} \leq 1$.

Lemma 2.10 (Consistency). For all $\eta>0$, if the solution $u_{\eta}$ of (2.11) satisfies $u_{\eta} \in C^{3}(\mathbb{R})$ then the scheme (2.13) is first-order consistent with

Proof. For $u_{\eta} \in C^{3}$, straightforward Taylor-Lagrange formula gives the desired result.
Theorem 2.11 (Convergence). For all $\eta>0$, if the solution $u_{\eta}$ of (2.11) satisfies $u_{\eta} \in C^{3}(\mathbb{R})$ then the scheme (2.13) is first-order convergent in the norm $\|\cdot\|_{\infty}$ with

where $\mathcal{U}_{h}=\left(u_{\eta}\left(x_{1}\right), \ldots, u_{\eta}\left(x_{N}\right)\right)^{T}$ and $C_{\eta}$ is a constant independent of $h$.
Proof. Convergence is a consequence of the Lax theorem: the finite difference scheme (2.13) is stable (Lemma 2.9) and consistent (Lemma 2.10).

### 2.6.2. Numerical tests

In this section, numerical experiments are performed to validate the approximation of the solution of the original problem (2.10) by the numerical solution of the penalized problem (2.11) discretized with the first-order finite difference scheme (2.12). We also present the results obtained using the following second-order finite difference scheme:

involving a cyclic pentadiagonal matrix.


Figure 2: Condition number $\kappa\left(A_{h}\right)$ in the 2 -norm of the matrix of the finite difference scheme versus the penalization parameter $\eta$ for $\alpha=1, d=0.1, \Delta_{l}=\Delta_{r}=0.3 d$ and $h=10^{-2}$.

For both considered schemes, (2.12) and $(2.14)$, the penalization introduces terms of order $\eta^{-1}$ in the matrix $A_{h}$, which leads to an ill-conditioned matrix problem for small values of the penalization parameter $\eta$. As shown in Figure 2, for a fixed space step $h$, the condition number $\kappa\left(A_{h}\right)=\left\|A_{h}\right\| \cdot\left\|A_{h}^{-1}\right\|$ (in the 2-norm defined in $\ell^{2}$ ) varies linearly with respect to $\eta^{-1}$ for $\eta \ll 1$. However, applying a diagonal preconditioner, $C=\operatorname{diag}\left(A_{h}\right)$, allows to obtain a condition number almost independent of $\eta$ as shown in Figure 2. This preconditioning does not resolve the poor conditioning associated with the second-order derivative that induces a resulting conditioning $\kappa\left(C^{-1} A_{h}\right)=O\left(h^{-2}\right)$. However, one could make the condition number independent of $h$ using a conventional preconditioner suitable for elliptic operators.

The numerical solutions of the penalized problem (2.11) using the finite difference schemes (2.12) and (2.14) are compared to the exact solution of the problem 2.10) for different types of conditions:

1. Nonhomogeneous Neumann boundary conditions $\left(u^{\prime}\left(x_{l}\right)=1, u^{\prime}\left(x_{r}\right)=2\right)$ in Figure 3:
2. Robin boundary conditions $\left(u^{\prime}\left(x_{l}\right)+u\left(x_{l}\right)=0,-u^{\prime}\left(x_{r}\right)+u\left(x_{r}\right)=0\right)$ in Figure 4 .

We chose $d=0.1$ (i.e. $x_{l}=0.45$ and $x_{r}=0.55$ for the obstacle boundary) and $\Delta_{l}=\Delta_{r}=$ 0.3d. The different masks are $\chi=\chi_{\left[x_{l}, x_{r}\right]}, \chi_{l}=\chi_{\left[x_{l}, x_{l}+\Delta_{l}\right]}$ and $\chi_{r}=\chi_{\left[x_{r}-\Delta_{r}, x_{r}\right]}$ (all intervals were taken closed to ensure in particular $\chi\left(x_{l}\right)=\chi_{l}\left(x_{l}\right)$ and $\left.\chi\left(x_{r}\right)=\chi_{r}\left(x_{r}\right)\right)$.

The errors represented on Figures 3(c), 3(d), 4(c) and 4(d) correspond to $\left\|\mathcal{V}_{h}-U_{h}\right\|$ inside the fluid domain $\omega$, where $\mathcal{V}_{h}=\left(u\left(x_{1}\right), \ldots, u\left(x_{N}\right)\right)^{T}$. For a fixed norm, we write $\left\|\mathcal{V}_{h}-U_{h}\right\| \leq\left\|\mathcal{V}_{h}-\mathcal{U}_{h}\right\|+\left\|\mathcal{U}_{h}-U_{h}\right\|$, where $\left\|\mathcal{V}_{h}-\mathcal{U}_{h}\right\|$ is an error related to the penalization method and provides information on the effect of the parameter $\eta$, and $\left\|\mathcal{U}_{h}-U_{h}\right\|$ is an error introduced by the spatial discretization.

Based on the theoretical estimates obtained previously, the following bound $\left\|\mathcal{V}_{h}-U_{h}\right\|_{\infty} \leq$ $C \eta+C_{\eta} h^{p}$, where $p=1$ for the first-order scheme (2.12) and $p=2$ for the second-order scheme $(2.14)$ is expected.

Provided that $\eta$ is small enough leading to a negligible penalization error, the error measured as a function of $h$ (Figures 3(c) and 4(c)) gives an order of convergence consistent with the chosen discretizations.

Similarly, provided that $h$ is small enough to neglect the discretization error, the error measured with respect to $\eta$ allows to evaluate the order of convergence of $u_{\eta}$ to $u$ in the fluid

domain. The errors obtained for $h=10^{-5}$ in Figures $3(\mathrm{~d})$ and 4(d) show a linear decrease when $\eta \rightarrow 0$, as obtained theoretically in Lemma 2.5, thus revealing the effective control of the penalization parameter over the boundary conditions.

## 3. Parabolic equation

In this section, we consider the following parabolic equation with Robin boundary conditions:

$$

where $\omega$ is a given smooth bounded open set in $\mathbb{R}^{D}, n$ is the outward-pointing unit normal vector on the boundary $\partial \omega, u_{0}$ is the initial condition, $f$ and $g$ are source terms, and $\alpha \geq 0$.

We first recall some results concerning the solution of this problem and its time discretization. Then the penalization method is introduced and analyzed and numerical examples are given.

### 3.1. Preliminaries

### 3.1.1. Existence and uniqueness

Existence and uniqueness can be proved using the classical Fourier or diagonalization method [12, 1]. We have the following lemma (see Appendix A for the details of the proof):

Lemma 3.1. The heat equation with Robin boundary conditions (3.1) where $u_{0} \in L^{2}(\omega), f \in$ $L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $g \in C^{1}\left([0, T] ; H^{1 / 2}(\partial \omega)\right)$ admits a unique solution $u \in L^{2}(] 0, T\left[; H^{1}(\omega)\right) \cap$ $C\left([0, T] ; L^{2}(\omega)\right)$.

### 3.1.2. Time discretization

Assuming that the data are smooth $\left(f \in C(\bar{\omega} \times[0, T])\right.$ and $\left.g \in C^{1}(\partial \omega \times[0, T])\right)$, we discretize in time the problem (3.1) using the implicit Euler scheme (for sake of simplicity):

where $\Delta t=\frac{T}{M}\left(M \in \mathbb{N}^{*}\right)$ is the time step and $t^{n}=n \Delta t$ for $0 \leq n \leq M$. We consider the following weak formulation of (3.2):

Using the Lax-Milgram theorem, the sequence $\left(u^{n}\right)_{0 \leq n \leq M}$ is uniquely defined and $u^{n} \in H^{1}(\omega)$ for $n \geq 1$.

A direct adaption of the proof in [7, Part I] for Dirichlet boundary conditions allows to handle Robin boundary conditions and to obtain the following result:

Lemma 3.2. If the solution $u$ of (3.1) satisfies $u \in C^{2}(\bar{\omega} \times[0, T])$ then the time discretization (3.2) is first-order convergent in the norm $\|\cdot\|_{L^{2}}$ with

### 3.2. Penalization

We present here the penalization method proposed for the heat equation with Robin boundary conditions (3.1) in the spatial univariate case $(D=1)$ with the geometry of Figure 1 left. In this case, the problem is written

\begin{cases}\frac{\partial u}{\partial t}-\frac{\partial^{2} u}{\partial x^{2}}=f & x \in] 0,1[, t \in] 0, T[  \tag{3.5}\\ -\frac{\partial u}{\partial x}(0, t)+\alpha u(0, t)=g(0, t) & t \in] 0, T[ \\ \frac{\partial u}{\partial x}(1, t)+\alpha u(1, t)=g(1, t) & t \in] 0, T[ \\ u(x, 0)=u_{0}(x) & x \in] 0,1[ \end{cases}
$$

Time discretization (3.2) and penalization of the resulting sequence of elliptic problems lead to

where again $\eta>0$ is the penalization parameter and $\chi$ is the characteristic function of the domain $] 1,2[$. Using Lemma 2.2 (which remains valid with nonunit coefficients), the sequence $\left(u_{\eta}^{n}\right)_{0 \leq n \leq M}$ is uniquely defined and $u_{\eta}^{n} \in C^{1}([0,2])$ for $n \geq 1$. The influence of parameter $\eta$ is presented in the following lemma:

### 3.3. Numerical approximation

As for the numerical approximation of the elliptic case, the numerical tests are performed in the geometry of Figure 1 right. The problem then reads

We first perform the time discretization using the implicit Euler scheme, and the penalization method is then applied to the sequence of elliptic problems. We obtain:

The last step consists of the spatial discretization.

### 3.3.1. Spatial discretization

As in Section 2.6.1, we consider a uniform subdivision $\left(x_{i}\right)_{1 \leq i \leq N+1}$ of $[0,1]$ of space step $h$ and introduce the following finite difference scheme:

At each time step, this scheme leads to the resolution of the following linear system

Theorem 3.4. For all $\Delta t, \eta>0$, if the solution $u_{\eta}^{n}$ of (3.9) satisfies $u_{\eta}^{n} \in C^{3}(\mathbb{R})$ for all $0 \leq n \leq M$ then the space discretization (3.10) is first-order convergent in the norm $\|\cdot\|_{\infty}$ with

As for the elliptic case, we obtain the invertibility and the stability of $A_{h}$ in the $\|\cdot\|_{\infty}$ norm: $\left\|A_{h}^{-1}\right\|_{\infty} \leq 1$ (see Lemmas 2.8 and 2.9). One also has $\left\|B_{h}\right\|_{\infty} \leq 1$. Therefore,

### 3.3.2. Numerical tests

We present here the results obtained using either the first-order finite difference scheme (3.10) or the Crank-Nicolson method (see Appendix B for details).

For both schemes, we compare the numerical solutions to the exact solution of problem (3.8) with $\alpha=1, g\left(x_{l}, t\right)=2\left(1-e^{-10 t}\right)$ and $g\left(x_{r}, t\right)=3\left(1-e^{-10 t}\right)$, see Figure 5. We choose $d=0.1$ and $\Delta_{l}=\Delta_{r}=0.3 d$.

Setting the final time $T=1$, we measure the error $\left\|\mathcal{V}_{h}(T)-U_{h}^{M}\right\|$ inside the fluid domain $\left[0, x_{l}\right] \cup\left[x_{r}, 1\right]$, where $\mathcal{V}_{h}(T)=\left(u\left(x_{1}, T\right), \ldots, u\left(x_{N}, T\right)\right)^{T}$, as a function of $\Delta t, \eta$ and $h$. Since

where $\mathcal{V}_{h}^{M}=\left(u^{M}\left(x_{1}\right), \ldots, u^{M}\left(x_{N}\right)\right)^{T}$ and $\mathcal{U}_{h}^{M}=\left(u_{\eta}^{M}\left(x_{1}\right), \ldots, u_{\eta}^{M}\left(x_{N}\right)\right)^{T}$, three sources of error can be distinguished: $\left\|\mathcal{V}_{h}(T)-\mathcal{V}_{h}^{M}\right\|$ is an error related to the time discretization, $\left\|\mathcal{V}_{h}^{M}-\mathcal{U}_{h}^{M}\right\|$ is an error introduced by the penalization, and $\left\|\mathcal{U}_{h}^{M}-U_{h}^{M}\right\|$ is an error associated with the space discretization.

Formally one has

for a scheme of order $p$ in space and order $q$ in time, if the space discretization is adapted to the obstacle.

The above estimates are confirmed numerically by plotting the error inside the fluid domain. The orders of convergence are recovered (Figure 5(c) and Figure 5(d)). These tests suggest that the constants $C_{\Delta t}$ and $C_{\Delta t, \eta}$ remain bounded when $\Delta t, \eta \rightarrow 0$. Moreover, the implicit Euler scheme or the Crank-Nicolson scheme which are unconditionally stable (in the norms $\|\cdot\|_{\infty}$ and $\|\cdot\|_{2}$ for the former, in the norm $\|\cdot\|_{2}$ for the latter, when used to solve the heat equation) eliminate the need of a stability condition that could be very restrictive in practice in the context of penalization. Indeed, the penalization parameter $\eta$ is intended to go to 0 introducing convective terms that dominate the diffusive one. It is therefore expected that the use of a fully explicit discretization for the penalization terms leads to a CFL (Courant-Friedrichs-Lewy) stability condition of the form $\frac{1}{\eta} \Delta t \leq \Delta x$.

## 4. Application

### 4.1. Nonlinear problem

The developed penalization method is here applied to a nonlinear advection-diffusion problem coming from a simplification of the model of electronic and ionic temperatures evolution along a magnetic field line, for a plasma in contact with an obstacle [9, 23]. It

The advection term is treated explicitly using an upwind scheme with:

$v_{\chi}(x)$ referring to $(1-\chi(x)) v(x)$. The nonlinear penalization terms are treated semi-implicitly using an upwind scheme, while the nonlinear diffusion term is discretized semi-implicitly with:

The temperature $u$ is initialized to $u_{0}=1$ throughout the computational domain $[0,1]$ and we compare the numerical solution obtained by the scheme (4.2) with an exact stationary solution $u_{s}$ of (4.1).

Figure 6(a) shows the numerical solution at $T=10$ when the stationary state has been reached. The errors plotted in Figures 6(b) and 6(c) correspond to $\left\|\mathcal{V}_{s, h}-U_{h}^{M}\right\|$ in the fluid domain, where $\mathcal{V}_{s, h}=\left(u_{s}\left(x_{1}\right), \ldots, u_{s}\left(x_{N}\right)\right)^{T}$ and $U_{h}^{M}=\left(U_{1}^{M}, \ldots, U_{N}^{M}\right)^{T}$. A first order of convergence is obtained with respect to the space step $h$ (Figure 6(b)), which is consistent with the discretization (4.2). Depending on the penalization parameter $\eta$, a first order is observed (Figure 6(c)), as in the linear case.

According to these results, the penalization method proposed in this paper to enforce Neumann or Robin boundary conditions has been coupled with the penalization technique previously proposed in [16] for Dirichlet conditions. Numerical tests for a one-dimensional system of equations describing the density, the velocity and the temperature in the plasma of a tokamak close to an obstacle can be found in [23]. The present method is also implemented in a realistic two-dimensional code SolEdge2D dedicated to the simulation of the plasmawall interaction in the edge region of a tokamak with complex geometries [9]. Extension of this method for the boundary conditions associated with electric potential has been sketched in [6].

### 4.2. Bivariate case

The difficulties faced when generalizing the approach to the multivariate case are real. The extension of various terms from the boundary to the complementary domain is one of the key difficulties.

To test the feasibility of the generalization, we consider the following problem:

$$
\left\{\begin{array}{l}
-\Delta u+u=f \quad \text { in } \omega  \tag{4.3}\\
\frac{\partial u}{\partial n}+\alpha u=g \quad \text { on } \partial D \\
u(0, y)=u(1, y), u(x, 0)=u(x, 1)
\end{array}\right.
$$

where $D=D\left(\left(x_{0}, y_{0}\right), r\right)$ is an open disk of center $\left(x_{0}, y_{0}\right)$ and radius $r$ included in $] 0,1[\times] 0,1[$ and $\omega=] 0,1[\times] 0,1[\backslash \bar{D}$. We propose the penalized problem:

$$
\left\{\begin{array}{l}
-\Delta u_{\eta}+u_{\eta}+\frac{\chi_{0}}{\eta}\left(\nabla u_{\eta} \cdot \tilde{n}+\alpha u_{\eta}-\tilde{g}\right)=(1-\chi) f \quad \text { in } \Omega  \tag{4.4}\\
u_{\eta}(0, y)=u_{\eta}(1, y), u_{\eta}(x, 0)=u_{\eta}(x, 1)
\end{array}\right.
$$

where $\Omega=] 0,1[\times] 0,1[, \eta>0$ is the penalization parameter, $\chi$ is the characteristic function of $D$ and $\chi_{0}$ is the characteristic function of the ring $R=D \backslash \bar{D}_{\text {int }}, D_{\text {int }}=D\left(\left(x_{0}, y_{0}\right), r_{\text {int }}\right)$
being the open disk of center $\left(x_{0}, y_{0}\right)$ and radius $0<r_{\text {int }}<r$ (see Figure 7(a)). Finally, $\tilde{n}$ (resp. $\tilde{g}$ ) is an extension of $n$ (resp. $g$ ) defined as follows:

$$
\begin{aligned}
& \tilde{n}(x, y)=-\frac{\nabla \phi}{\|\nabla \phi\|} \quad \text { with } \quad \phi(x, y)=\left(x-x_{0}\right)^{2}+\left(y-y_{0}\right)^{2} \\
& \tilde{g}(x, y)=g\left(\left(x_{0}, y_{0}\right)+r e^{i \theta}\right) \quad \text { with } \quad \theta=\arg \left(\left(x-x_{0}\right)+i\left(y-y_{0}\right)\right) .
\end{aligned}
$$

Assuming the existence and uniqueness of the solution $u_{\eta}$ of the penalized problem (4.4), we guess to have, in the limit $\eta \rightarrow 0$, the convergence $u_{\eta} \rightarrow \bar{u}$ such that:

- in $\omega, \bar{u}=u$ solution of the original problem (4.3),
- in $R, \bar{u}=u_{R}$ solution of

$$
\begin{cases}\nabla v \cdot \tilde{n}+\alpha v=\tilde{g} & \text { in } R \\ v=u & \text { on } \partial D\end{cases}
$$

- in $D_{\text {int }}, \bar{u}=u_{\text {int }}$ solution of

$$
\begin{cases}-\Delta v+v=0 & \text { in } D_{\mathrm{int}} \\ v=u_{R} & \text { on } \partial D_{\mathrm{int}} .\end{cases}
$$

We present here the first numerical experiments performed to test the convergence of $u_{\eta}$ to $u$ in the original domain $\omega$. The numerical test is made with a manufactured solution by choosing $u$ 1-periodic in $x$ and $y$ and adjusting $f$ and $g$ accordingly. The numerical solution of the penalized problem obtained for $u(x, y)=\sin (2 \pi x) \sin (2 \pi y), \alpha=1,\left(x_{0}, y_{0}\right)=(0.6,0.7)$, $r=0.25$ and $r_{\text {int }}=0.125$ is reported in Figure 7(c). The penalized problem is solved numerically using the finite element method provided by the FreeFem ++ software [15]. On Figure $7(\mathrm{~d})$, we report the $L^{2}$ norm error $\left\|u-u_{\eta, h}\right\|_{L^{2}(\omega)}$ for a fixed penalization parameter $\eta=10^{-4}$ and different mesh sizes $h$. We observe a decrease of this error when $h \rightarrow 0$ showing numerically the convergence of the proposed method. The remaining error for the smallest $h$ indicates that $u_{\eta} \approx u$ for the fixed value of $\eta \ll 1$.

## 5. Conclusion

A new penalization fictitious domain method to take account of Neumann or Robin boundary conditions has been proposed in this paper. This method has been first defined and analyzed for univariate linear partial differential equations of elliptic or parabolic types. Theoretical results including the convergence with respect to the penalization parameter $\eta$ have been obtained. We then analyzed the convergence of finite difference discretization schemes of the penalized problem. We validated the method by various numerical tests that confirmed the theoretical results. This penalization method has been successfully applied to a nonlinear advection-diffusion equation mimicking the equations governing ionic and electronic temperatures of a plasma in the edge region of a tokamak. The first extension of this method to the multivariate case is finally reported.

## Appendix A. Proof of Lemma 3.1

Proof. First, we reduce the inhomogeneous boundary conditions in (3.1) to homogeneous boundary conditions using the inverse trace theorem. According to [21, Theorem 8.3] (see also [8]), there exists a continuous operator $\mathcal{R}: H^{3 / 2}(\partial \omega) \times H^{1 / 2}(\partial \omega) \rightarrow H^{2}(\omega)$ such that $\left.\mathcal{R}\left(h_{1}, h_{2}\right)\right|_{\partial \omega}=h_{1}$ and $\left.\frac{\partial}{\partial n} \mathcal{R}\left(h_{1}, h_{2}\right)\right|_{\partial \omega}=h_{2}$. Thus, for all $t \in[0, T]$, there exists $v(t)=$ $\mathcal{R}(0, g(t)) \in H^{2}(\omega)$ satisfying $\left.v(t)\right|_{\partial \omega}=0$ and $\left.\frac{\partial v(t)}{\partial n}\right|_{\partial \omega}=g(t)$, so that $\frac{\partial v}{\partial n}+\alpha v=g$ on
$\partial \omega \times] 0, T[$. Putting $u=v+w$, the equation (3.1) can be formally rewritten as

$$
\begin{cases}\frac{\partial w}{\partial t}-\Delta w=f-\frac{\partial v}{\partial t}+\Delta v & \text { in } \omega \times] 0, T[  \tag{A.1}\\ \frac{\partial w}{\partial n}+\alpha w=0 & \text { on } \partial \omega \times] 0, T[ \\ w(x, 0)=u_{0}(x)-v(x, 0) & \text { in } \omega .\end{cases}
$$

Let us put $f^{*}=f-\frac{\partial v}{\partial t}+\Delta v$ and $u_{0}^{*}=u_{0}-v(0)$. We want to show that $f^{*} \in$ $L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $u_{0}^{*} \in L^{2}(\omega)$. In order to do this, let us show that $v \in C^{1}\left([0, T] ; H^{2}(\omega)\right)$. Noting $v_{d}(t)=\mathcal{R}\left(0, \frac{d g}{d t}(t)\right)$, there exists, by continuity of the operator $\mathcal{R}$, a constant $C \geq 0$ such that for all $t, t_{0} \in[0, T]$ with $t \neq t_{0}$,

$$
\begin{equation*}
\left\|\frac{v(t)-v\left(t_{0}\right)}{t-t_{0}}-v_{d}(t)\right\|_{H^{2}(\omega)} \leq C\left\|\frac{g(t)-g\left(t_{0}\right)}{t-t_{0}}-\frac{d g}{d t}(t)\right\|_{H^{1 / 2}(\omega)} . \tag{A.2}
\end{equation*}
$$

Letting $t$ go to $t_{0}$ in A.2), we deduce the differentiability of $v$ and $\frac{d v}{d t}(t)=v_{d}(t)=\mathcal{R}\left(0, \frac{d g}{d t}(t)\right)$. The continuity of $\frac{d v}{d t}$ then follows similarly from the inequality

$$
\begin{equation*}
\left\|\frac{d v}{d t}(t)-\frac{d v}{d t}\left(t_{0}\right)\right\|_{H^{2}(\omega)} \leq C\left\|\frac{d g}{d t}(t)-\frac{d g}{d t}\left(t_{0}\right)\right\|_{H^{1 / 2}(\omega)} \tag{A.3}
\end{equation*}
$$

Hence $v \in C^{1}\left([0, T] ; H^{2}(\omega)\right)$, in particular $v(0) \in L^{2}(\omega), \frac{\partial v}{\partial t} \in L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $\Delta v \in$ $L^{2}(] 0, T\left[; L^{2}(\omega)\right)$. Thus $f^{*} \in L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $u_{0}^{*} \in L^{2}(\omega)$.

Second, we show that the equation

$$
\begin{cases}\frac{\partial w}{\partial t}-\Delta w=f^{*} & \text { in } \omega \times] 0, T[  \tag{A.4}\\ \frac{\partial w}{\partial n}+\alpha w=0 & \text { on } \partial \omega \times] 0, T[ \\ w(x, 0)=u_{0}^{*}(x) & \text { in } \omega\end{cases}
$$

where $f^{*} \in L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $u_{0}^{*} \in L^{2}(\omega)$, has a unique solution $w$ in the space $L^{2}(] 0, T\left[; H^{1}(\omega)\right) \cap$ $C^{0}\left([0, T] ; L^{2}(\omega)\right)$. Introducing a new unknown function $w^{*}(t)=e^{-t} w(t)$, A.4) is equivalent to

$$
\begin{cases}\frac{\partial w^{*}}{\partial t}-\Delta w^{*}+w^{*}=f^{* *} & \text { in } \omega \times] 0, T[  \tag{A.5}\\ \frac{\partial w^{*}}{\partial n}+\alpha w^{*}=0 & \text { on } \partial \omega \times] 0, T[ \\ w^{*}(x, 0)=u_{0}^{* *}(x) & \text { in } \omega,\end{cases}
$$

where $f^{* *}=f^{*} e^{-t} \in L^{2}(] 0, T\left[; L^{2}(\omega)\right)$ and $u_{0}^{* *}=u_{0}^{*} \in L^{2}(\omega)$. We consider the following weak formulation of A.5):

Find $w^{*} \in L^{2}(] 0, T\left[; H^{1}(\omega)\right) \cap C^{0}\left([0, T] ; L^{2}(\omega)\right)$ such that

$$
\left\{\begin{array}{l}
\left\{\begin{array}{l}
\frac{d}{d t}\left\langle w^{*}(t), v\right\rangle_{L^{2}(\omega)}+a\left(w^{*}(t), v\right)=\left\langle f^{* *}(t), v\right\rangle_{L^{2}(\omega)} \quad \forall v \in H^{1}(\omega) \\
\quad \text { (in distributional sense in }] 0, T[) \\
w^{*}(t=0)=u_{0}^{* *}
\end{array}\right. \tag{A.6}
\end{array}\right.
$$

where

$$
\begin{aligned}
& \forall u, v \in H^{1}(\omega), \quad a(u, v)=\int_{\omega} \nabla u \cdot \nabla v d x+\int_{\omega} u v d x+\alpha \int_{\partial \omega} u v d \sigma \\
& \forall u, v \in L^{2}(\omega), \quad\langle u, v\rangle_{L^{2}(\omega)}=\int_{\omega} u v d x
\end{aligned}
$$

Applying [1, Theorem 8.2.3] (whose proof is based on a spectral approach) yields the existence and uniqueness of the solution $w^{*} \in L^{2}(] 0, T\left[; H^{1}(\omega)\right) \cap C^{0}\left([0, T] ; L^{2}(\omega)\right)$ of the weak formulation A.6).

## Appendix B. The Crank-Nicolson method used in Section 3.3.2

The Crank-Nicolson method is applied directly to the continuous penalization of the original problem (3.8) providing the following scheme:

$$
\left\{\begin{align*}
& \frac{U_{i}^{n+1}-U_{i}^{n}}{\Delta t}+ \frac{1}{2}\left[-\frac{U_{i+1}^{n+1}-2 U_{i}^{n+1}+U_{i-1}^{n+1}}{h^{2}}\right. \\

&+\frac{\chi_{r}\left(x_{i}\right)}{\eta}\left(-\frac{-U_{i+2}^{n+1}+4 U_{i+1}^{n+1}-3 U_{i}^{n+1}}{2 h}+\alpha U_{i}^{n+1}-g_{r}^{n+1}\right) \\
&-\frac{U_{i+1}^{n}-2 U_{i}^{n}+U_{i-1}^{n}}{h^{2}}  \tag{B.1}\\
&+\frac{\chi_{l}\left(x_{i}\right)}{\eta}\left(\frac{3 U_{i}^{n}-4 U_{i-1}^{n}+U_{i-2}^{n}}{2 h}+\alpha U_{i}^{n}-g_{l}^{n}\right) \\
&\left.+\frac{\chi_{r}\left(x_{i}\right)}{\eta}\left(-\frac{-U_{i+2}^{n}+4 U_{i+1}^{n}-3 U_{i}^{n}}{2 h}+\alpha U_{i}^{n}-g_{r}^{n}\right)\right] \\
&=\frac{1}{2}\left(1-\chi\left(x_{i}\right)\right)\left(f\left(x_{i}, t^{n+1}\right)+f\left(x_{i}, t^{n}\right)\right) \\
& U_{i}^{n+1}=U_{N+i}^{n+1} \\
& U_{i}^{0}=\left(1-\chi\left(x_{i}\right)\right) u_{0}\left(x_{i}\right),
\end{align*}\right.
$$

for $i=1, \ldots, N$ and $n=0, \ldots, M-1$.
