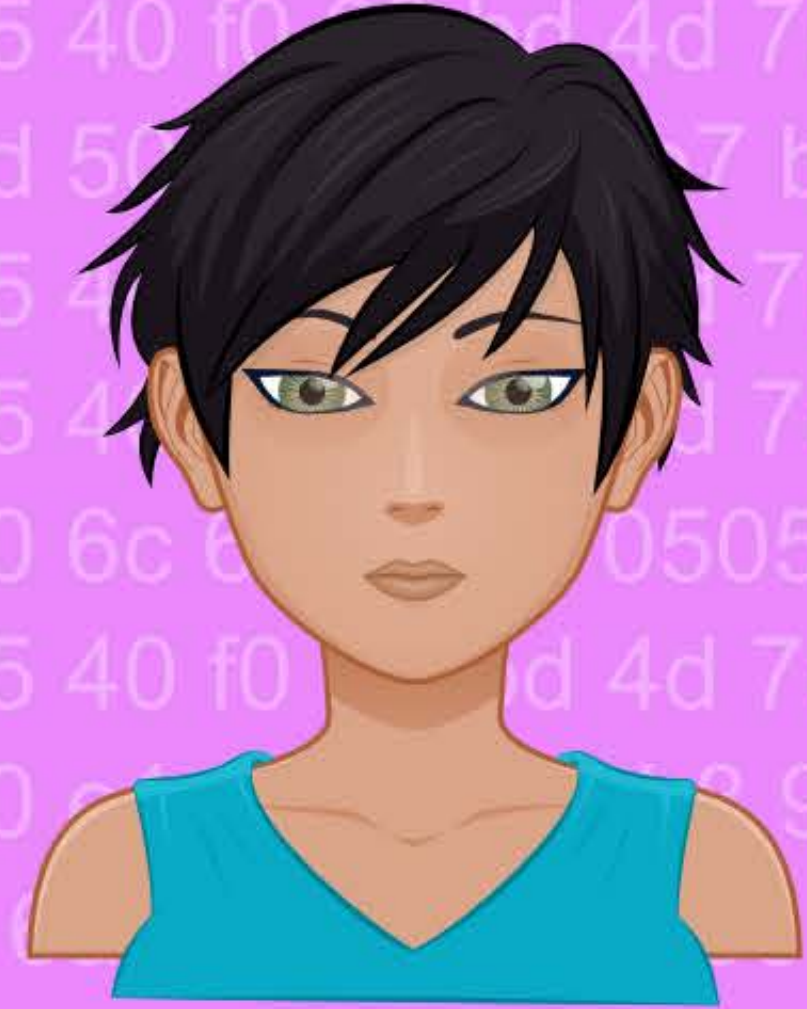

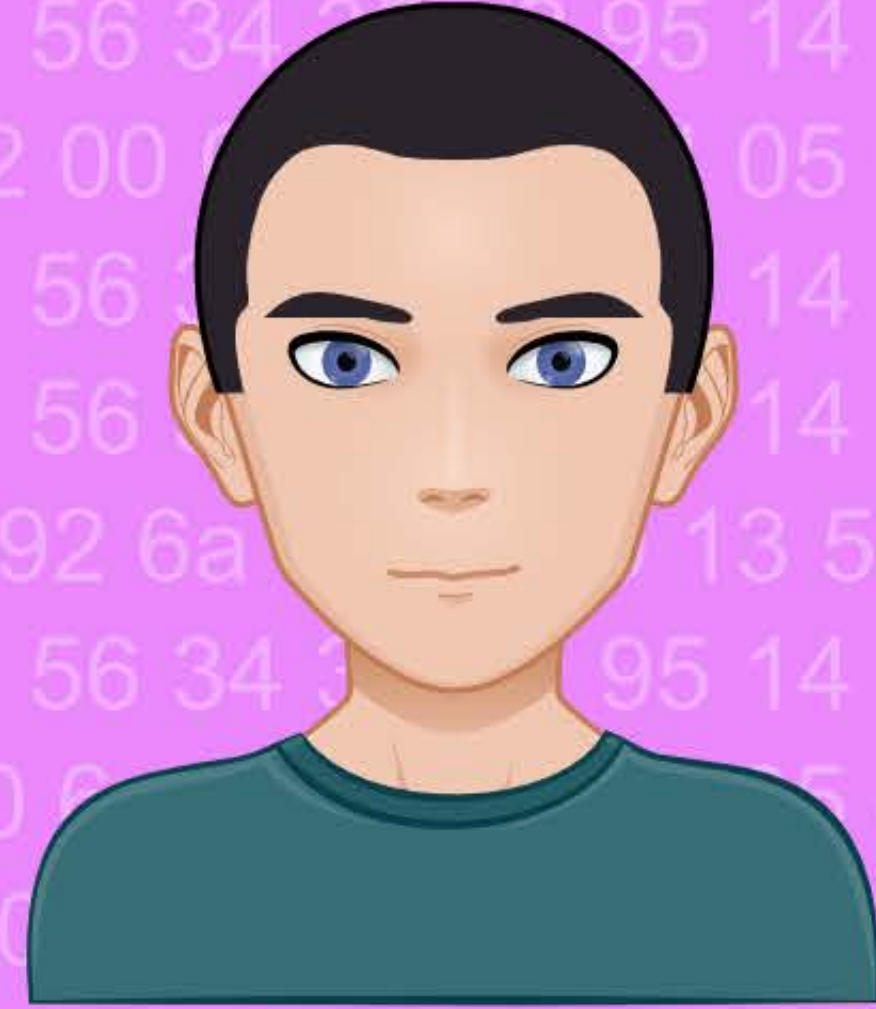
WHO SOULD COME?



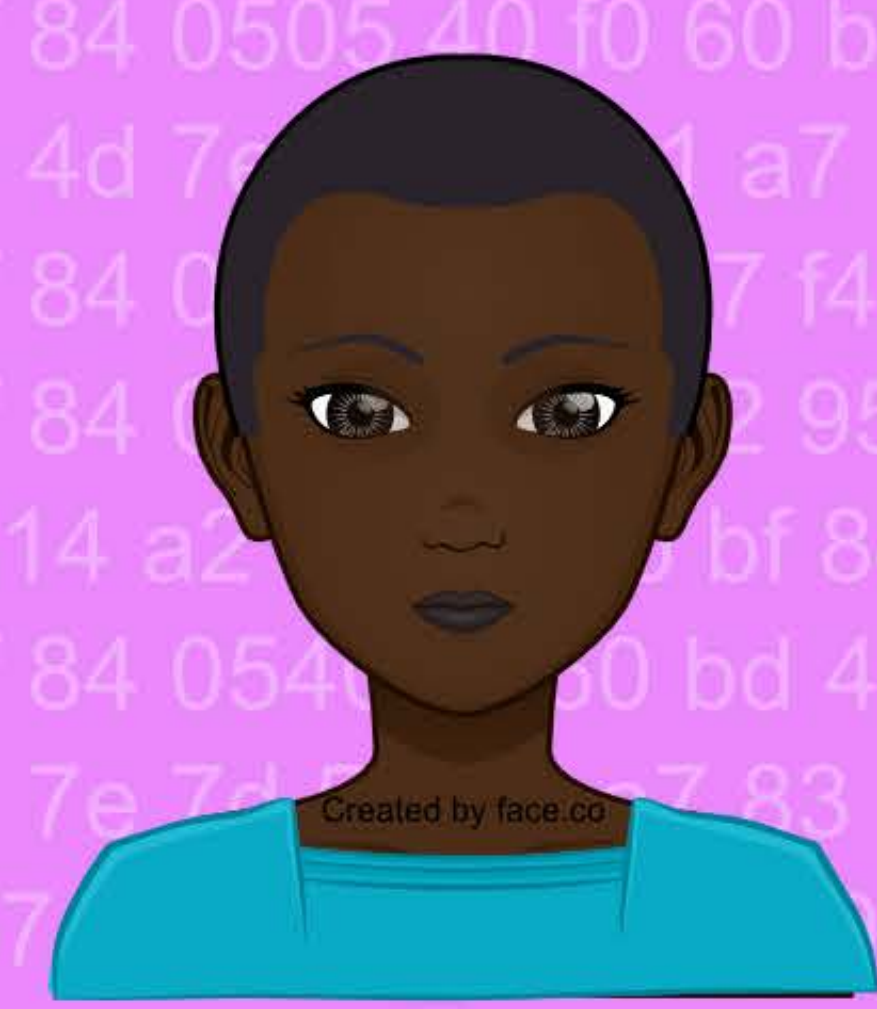
**Students**  
 > INSA students involved in privacy challenges (app building, embedded software designing)  
 > other students (e.g : journalism, politics)



**Librarians**  
 > provide secured (?) wifi connexions to users  
 > Sign contracts with 3rd part vendors including user data  
 > should know a bit more about how DRM managers leak out personal data



**Concerned citizens**  
 "And we are all involved" (Pascal)  
 > want to have control over their own data  
 > Are usually aware of mass surveillance and tracking by GAFAM



**Professionnals**  
 Could be for instance :  
 > Journalists trying to protect themselves and their sources  
 > Webmasters,  
 > Researchers esp. on sensitive matters  
 > policemen. And why not ?

 > teach cryptography

 > manage workshops



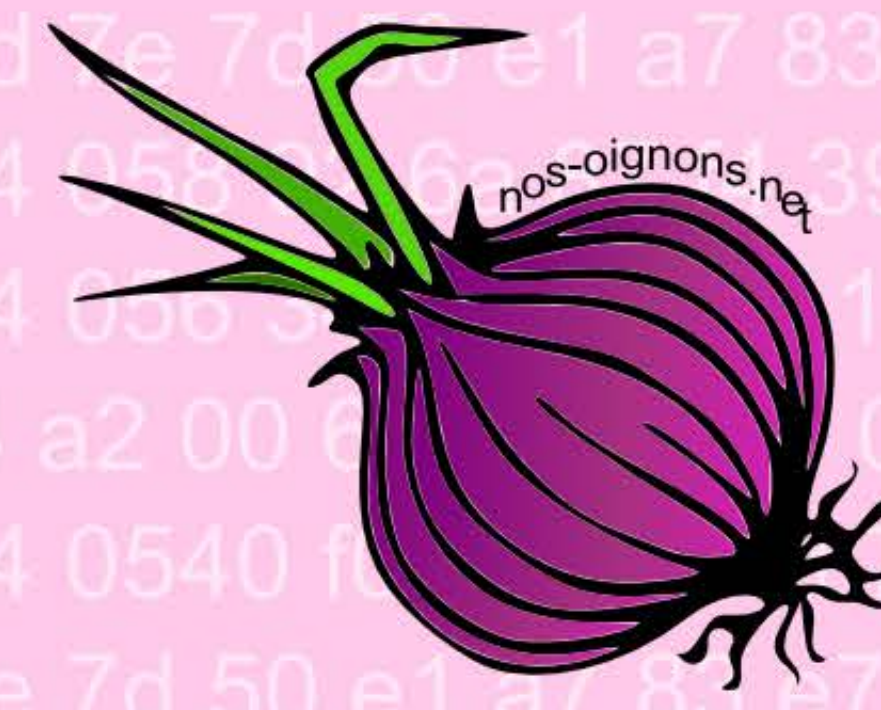
**Students**

 > love onions

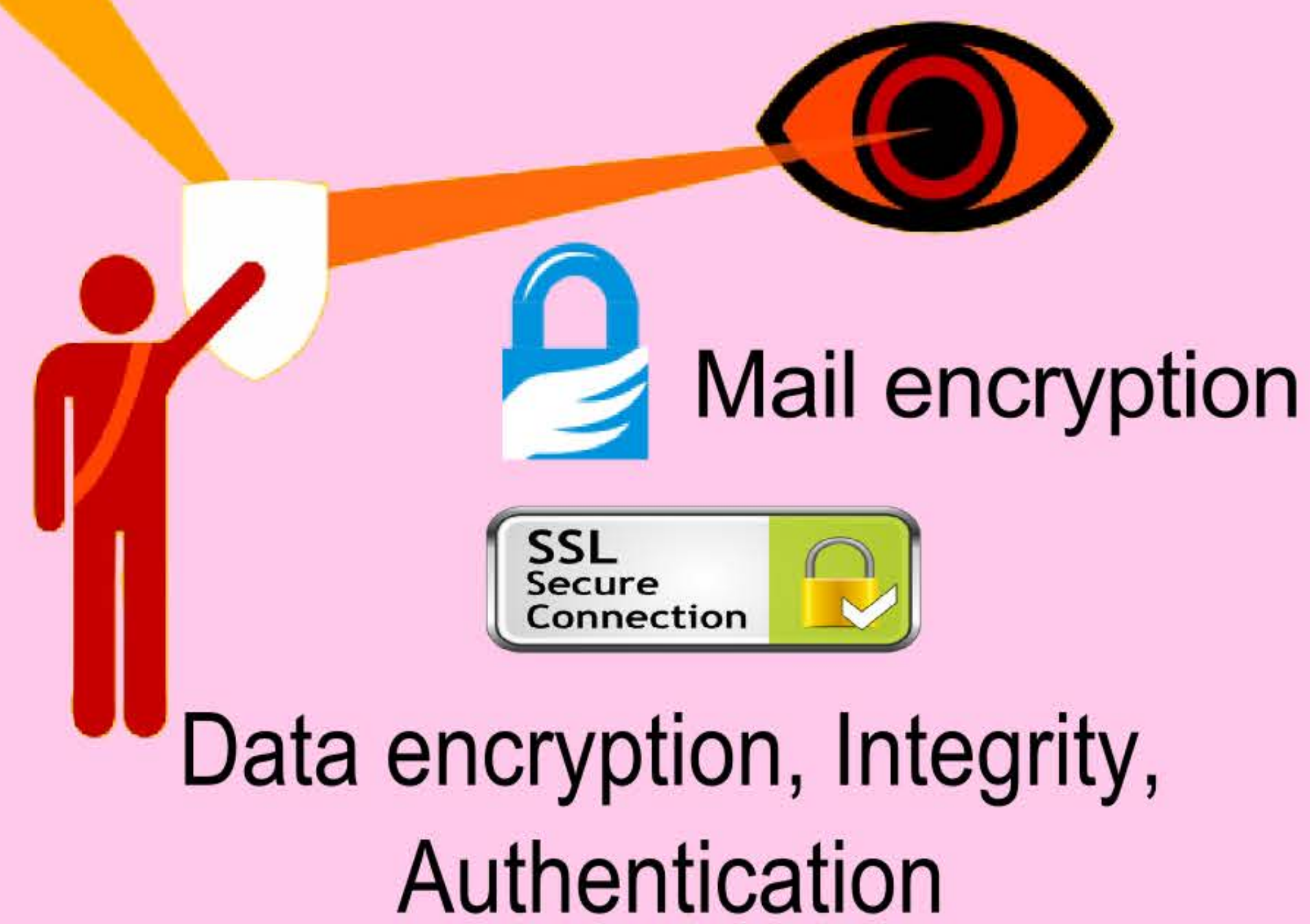

**IFLA Stated** (14<sup>th</sup> August 2015)

Data protection and privacy protection should be included as a part of the media and information literacy training for library and information service users. This should include training on tools to use to protect their privacy

Library and information services should reject electronic surveillance
