Research on CBIR started in the early 1990's and is likely to continue during the first two decades of the 21st century. In leading universities and companies many research groups are actively working in this area and a fairly large number of prototypes and commercial products are already available. However, the current solutions are still far from reaching the ultimate goal.

There are two approaches to image retrieval: Text-Based approach and Content- Based approach. Today, the most common way of doing this is by textual descriptions and categorizing of images. Different people might categorize or describe the same image differently; it leads to the problem of retrieving it again. This process is a time consuming process when dealing with very large databases. Content based image retrieval (CBIR) is a way to get around these problems. CBIR systems search collection of images based on features that can be extracted from the image files themselves without manual description. In past decades many CBIR systems have been developed, the common ground for them is to extract a desired image. Many different approaches to CBIR have been tried and one of the common thing is color histogram is been used.

CBIR systems use visual content such as color, texture, and simple shape properties to search images from large scale image databases. Although they improve textbased image retrieval systems, these systems have not yet received commercial success. One of the major reasons for this limited success is that CBIR depend upon a global view of the image, sometimes leading to a lot of irrelevant image content that is used in the searching technique. A solution for the global view problem can be found in localized CBIR. These systems mainly focus on the part of the image in which the user is interested.

II. BASICS OF IMAGE PROCESSING

3.4 How is a pixel stored?

- Pixels are stored as Integers.
- Most popular are 24 bit color images where 8 bits each for Red, Green and Blue color values are used to represent a 24-bit pixel value.
- 8 bit images are grayscale images where as 32 bit images have an additional transparency channel.

III. SYSTEM ARCHITECTURE

The proposed system consists of hand gesture recognition to retrieve images from huge database as depicted in Figure 1.When user will show the hand posture in front of the web camera a video frame will be captured and recognized with the signature stored in database. When user interacts with camera various image processing techniques will be used for detection and recognition internally in the system. 3.5 RGB Color Model

- The RGB color model is an additive color model in which red, green, and blue color is added together in various ways to reproduce a broad array of colors.
- In computing, the component values are often stored as integer numbers in the range 0 to255. These may be represented as either decimal or hexadecimal numbers.

3.6 RGB Color Images

- Color images are composed of three different channels viz. Red, Green and Blue.
- One can also imagine three overlapped 8-bit images to compose a final 24-bit color image.



3.7RGB Color Example

- Sample PIXEL value in HEX = 0EDEB5
- In programming the hex numbers are represented as 0x0EDEB5. 0x prefix is for hex notation.
- Then individual color channels:
- 0E (red) DE (green)- B5 (blue)
- 00001110 11011110 10110101

V. ALGORITHMS

4.1 RGB to Grayscale Conversion

Algorithm:-

- Step1. Traverse through entire input image array.
- Step2. Read individual pixel color value (24-bit).
- Step3. Split the color value into individual R, G and B 8-bit values.
- Step 4.Calculate the grayscale component (8-bit) for given R, G and B pixels using a conversion formula.
- Step 5.Compose a 24-bit pixel value from 8-bit grayscale value.
- Step 6.Store the new value at same location in output mage.

4.2 Blurring

Definition:-In image terms blurring means that each pixel in the source image gets spread over and mixed into surrounding pixels.

 Another way to look at this is that each pixel in the destination image is made up out of a mixture of surrounding pixels from the source image.



4.2.1 Why should we create a Blurred Image?

Blurring an image reduces the sharpening effect; this makes the detection more accurate.

- · There two type of blurring an image
- Gray scaled blur.
- Color blur.

Algorithm:-

- Step1. Traverse through entire input image array.
- Step 2. Read individual pixel color value (24-bit).
- Step3. Split the color value into individual R, G and B 8- bit values.
- Step 4. Calculate the RGB average of surrounding pixels and assign this average value to it.
- Step 5.Repeat the above step for each pixel.
- Step 6.Store the new value at same location in output image.

4.3 Thresholding

- Thresholding is the simplest method of image segmentation.
- From a grayscale image, thresholding can be used to create binary images i.e. image with only black or white colors.
- It is usually used for feature extraction where required features of image are converted to white and everything else to black. (Or vice-versa)

Algorithm:-

- Step1. Traverse through entire input image array.
- Step2. Read individual pixel color value (24-bit) and convert it into grayscale.
- Step3. Calculate the binary output pixel value (black or white) based on current threshold.
- Step4. Store the new value at same location in output image.
