# ADMISSIBLE $Q$-CURVATURES UNDER ISOMETRIES FOR THE CONFORMAL GJMS OPERATORS

## 1. Introduction and statement of the main result

Let $M$ be a compact manifold of dimension $n \geq 3$ and let $k \geq 1$ be an integer such that $k \leq \frac{n}{2}$ if $n$ is even. In their celebrated work, Graham-Jenne-Mason-Sparling [15] provided a systematic construction of conformally invariant operators (GJMS operators for short) based on the ambient metric of Fefferman-Graham [12, 13]. More precisely, letting $\mathcal{M}$ be the set of Riemannian metrics on $M$, then for all $g \in \mathcal{M}$, there exists an operator $P_{g}: C^{\infty}(M) \rightarrow C^{\infty}(M)$ such that
(i) $P_{g}$ is a differential operator and $P_{g}=\Delta_{g}^{k}+l o t$
(ii) $P_{g}$ is natural, that is $\varphi^{\star} P_{g}=P_{\varphi^{\star} g}$ for all smooth diffeomorphism $\varphi: M \rightarrow M$.
(iii) $P_{g}$ is self-adjoint with respect to the $L^{2}-$ scalar product
(iv) Given $\omega \in C^{\infty}(M)$ and defining $\hat{g}=e^{2 \omega} g$, we have that

$$
\begin{equation*}
P_{\hat{g}}(f)=e^{-\frac{n+2 k}{2} \omega} P_{g}\left(e^{\frac{n-2 k}{2} \omega} f\right) \text { for all } f \in C^{\infty}(M) . \tag{1}
\end{equation*}
$$

Here $\Delta_{g}:=-\operatorname{div}_{g}(\nabla)$ is the Laplace-Beltrami operator and lot denotes differential terms of lower order. Point (iii) above is due to Graham-Zworski [16]. For instance, on $\mathbb{R}^{n}$ endowed with its Euclidean metric $\xi$, one has that $P_{\xi}=\Delta_{\xi}^{k}$. There is a natural scalar invariant, namely the $Q$-curvature, attached to the operator $P_{g}$ : this scalar invariant, denoted as $Q_{g}$, was initially introduced by Branson and $\emptyset$ rsted [7] for $n=2 k=4$ and generalized by Branson [4, 5]. When $k=1$, the GJMS operator is the conformal Laplacian and the $Q$-curvature is the scalar curvature (up to a dimensional constant). When $k=2$, the GJMS operator is the Paneitz operator introduced in [26]. When $n \neq 2 k$, the $Q$-curvature is $Q_{g}:=\frac{2}{n-2 k} P_{g}(1)$ : when $n=2 k$, the definition is much more subtle and involves a continuation in dimension argument (we refer to the survey Branson-Gover [6] and to Juhl [20] for an exposition in book form). In the spirit of classical problems in conformal geometry, our objective here is to prescribe the $Q$-curvature in a conformal class; that is, given a conformal Riemannian class $\mathcal{C}$ on $M$ and a function $f \in C^{\infty}(M)$, we investigate the existence of a metric $g \in \mathcal{C}$ such that $Q_{g}=f$. As one checks (see Proposition 3 below), up to multiplication by a constant, this amounts to finding

[^0]critical points of the perturbation of the Hilbert functional
\[

\mathcal{C} & \rightarrow \mathbb{R} \\
g & \mapsto \frac{\int_{M} Q_{g} d v_{g}}{V_{f}(M, g)^{\frac{n-2 k}{n}}}
\end{aligned}

where $V_{f}(M, g):=\int_{M} f d v_{g}$ is the weighted $f$-volume of $(M, g)$. This structure suggests to apply variational methods to prescribe the $Q$-curvature and we define

$$
\mu_{f}(\mathcal{C}):=\inf _{g \in \mathcal{C}} \frac{\int_{M} Q_{g} d v_{g}}{V_{f}(M, g)^{\frac{n-2 k}{n}}}
$$

Given a metric $g \in \mathcal{C}$, the conformal class can be described as

$$
\mathcal{C}=\left\{e^{2 \omega} g / \omega \in C^{\infty}(M)\right\}
$$

We assume that $n>2 k$ : in this context, it is more convenient to write a metric $\hat{g} \in \mathcal{C}$ as $\hat{g}=u^{\frac{4}{n-2 k}} g$ with $u \in C_{+}^{\infty}(M)$, the set of positive smooth functions. With this parametrization, we have that

$$
\mathcal{C}=\left\{u^{\frac{4}{n-2 k}} g / u \in C_{+}^{\infty}(M)\right\},
$$

and the relation (1) between $P_{g}$ and $P_{\hat{g}}$ rewrites

$$
\begin{equation*}
P_{\hat{g}} \varphi=u^{1-2^{\star}} P_{g}(u \varphi) \tag{2}
\end{equation*}
$$

for all $\varphi \in C^{\infty}(M)$, where $2^{\star}:=\frac{2 n}{n-2 k}$. Therefore, taking $\varphi \equiv 1$, we have that

$$
P_{g} u=\frac{n-2 k}{2} Q_{\hat{g}} u^{2^{\star}-1} \text { in } M
$$

where $\hat{g}=u^{\frac{4}{n-2 k}} g$, and then finding a metric in $\mathcal{C}$ with $f$ as $Q$-curvature amounts to solving the variational elliptic equation $P_{g} u=\frac{n-2 k}{2} f u^{2^{\star}-1}$. Despite this elegant variational structure, this question gives rise to a crucial intrinsic difficulty due to the essence of the problem, that is the conformal invariance of the operator. More precisely, in the spirit of Bourguignon-Ezin [3], Delanoë and the author proved in [9] that

$$
\int_{M} X\left(Q_{g}\right) d v_{g}=0
$$

for all conformal Killing field $X$ on $(M, \mathcal{C})$. When $k=1$, this is the celebrated Kazdan-Warner obstruction [21] to the scalar curvature problem. In particular, if $\varphi \in C^{\infty}\left(\mathbb{S}^{n}\right) \backslash\{0\}$ is a first eigenfunction of the Laplace-Beltrami operator on the standard sphere $\left(\mathbb{S}^{n}, h\right)$, then for any $\epsilon \neq 0, Q_{h}+\epsilon \varphi$ is not achived as the $Q$-curvature of a metric in the conformal class of the standard sphere. Therefore, a function can be arbitrarily close to a $Q$-curvature but not be a $Q$-curvature itself: the prescription of the $Q$-curvature is then a highly unstable problem, and its underlying analysis is intricate. We refer again to [9] for considerations on the structure of the set of $Q$-curvatures. In the case $k=1$ and $n \geq 3$, the problem of prescribing a constant $Q$-curvature is known as the Yamabe problem: it is not the purpose of the present article to make an extensive historical review of the famous resolution of this problem, and we refer to Lee-Parker [22] and the references therein. Concerning fourth order problems, that is for $k=2$, there has been an intensive litterature on the question: here, we refer to the recent surveys of Branson-Gover [6], Chang [8], Malchiodi [24] and the references therein.

In the sequel, we will say that a function is admissible if it can be achieved as the $Q$-curvature of a metric in a given conformal class. As seen above, some functions on the sphere are not admissible for the standard conformal class. Moser [25] remarked that functions enjoying some symmetries automatically satisfy the Kazdan-Warner identities: indeed, on the standard sphere, given an isometry $\sigma$ such that $\varphi \circ \sigma=-\varphi$ for all first eigenfunction of the Laplace-Beltrami operator (take $\sigma=-I d$ for instance), then the Kazdan-Warner identity yields 0 for all function invariant by $\sigma$. Then, Moser had the idea to impose invariance under a group of isometries to find admissible functions on the sphere for the scalar curvature problem in 2D. This strategy was also used by Escobar-Schoen [11] and Hebey [18] in higher dimensions. In the same spirit, Delanoë and the author [9] proved that a function on the sphere which is close to $Q_{h}$ and invariant under a group of isometries acting without fixed point is admissible. In the present article, we relax the condition of being close to $Q_{h}$ by imposing cancelation of some derivatives (see Theorem 3 below). In the specific case $n=2 k+1$, very few is required; this is the object our main result:

Theorem 1. Let $k \geq 1$ and let $G$ be a subgroup of isometries of $\left(\mathbb{S}^{2 k+1}, h\right)$. Let $f \in C^{\infty}(M)$ be a positive $G$-invariant function and assume that $G$ acts without fixed point (that is $\left|O_{G}(x)\right| \geq 2$ for all $x \in \mathbb{S}^{2 k+1}$ ). Then there exists $g \in[h]$ such that $Q_{g}=f$ and $G \subset \operatorname{Isom}_{g}\left(\mathbb{S}^{n}\right)$.

When $k=1,2$, this result is due respectively to Hebey [18] and to the author [27]. This theorem is a particular case of more general results proved on arbitrary conformal manifolds (see Proposition 8 and Theorem 3 below). In this article, we make a general analysis of the operator $P_{g}$ and of the blow-up phenomenon attached to it on arbitrary conformal manifolds. In the last section, we apply this analysis to the conformal sphere.

## 2. Miscellaneous on the operator $P_{g}$

The operator $P_{g}$ can be written (partially) as a divergence form (we refer to Branson-Gover [6]): as a preliminary step, we precise this divergence form that will be useful in the sequel:

Proposition 1. Let $P_{g}$ be the conformal GJMS operator. Then for any $l \in$ $\{0, \ldots, k-1\}$, there exists $A_{(l)}(g)$ a smooth $T_{2 l}^{0}$-tensor field on $M$ such that

$$
\begin{equation*}
P_{g}=\Delta_{g}^{k}+\sum_{l=0}^{k-1}(-1)^{l} \nabla^{j_{l} \ldots j_{1}}\left(A_{(l)}(g)_{i_{1} \ldots i_{l} j_{1} \ldots j_{l}} \nabla^{i_{1} \ldots i_{l}}\right), \tag{3}
\end{equation*}
$$

where the indices are raised via the musical isomorphism. In addition for any $l \in\{0, \ldots, k-1\}, A_{(l)}(g)$ is symmetric in the following sense: $A_{(l)}(g)(X, Y)=$
$A_{(l)}(g)(Y, X)$ for all $X, Y T_{0}^{l}$-tensors on $M$. In particular, we have that

$$
\begin{equation*}
\int_{M} u P_{g}(v) d v_{g}=\int_{M}\left(\Delta_{g}^{\frac{k}{2}} u \Delta_{g}^{\frac{k}{2}} v+\sum_{l=0}^{k-1} A_{(l)}(g)\left(\nabla^{l} u, \nabla^{l} v\right)\right) d v_{g} \tag{4}
\end{equation*}
$$

for all $u, v \in C^{\infty}(M)$. Here, we have adopted the convention

$$
\Delta_{g}^{\frac{k}{2}} u \Delta_{g}^{\frac{k}{2}} v:=\left(\nabla \Delta_{g}^{\frac{k-1}{2}} u, \nabla \Delta_{g}^{\frac{k-1}{2}} v\right)_{g}
$$

when $k$ is odd.
Proof. The proof uses only the self-adjointness of the operator $P_{g}$. In the sequel, we note $A^{\star}$ the adjoint of any operator $A$ with respect to the $L^{2}$-product. As a preliminary, we compute the adjoint of some elementary operators. We adopt here Hamilton's convention [17]: the notation $A \star B$ denotes a linear combination of contraction of the tensors $A, B, g$ and $g^{-1}$. Given $B$ a smooth $T_{q}^{0}$-tensor field on $M$, we consider the operator $B u:=B \cdot \nabla^{q} u=B_{i_{1} \ldots i_{q}} \nabla^{i_{1} \ldots i_{q}} u$ for all $u \in C^{\infty}(M)$.
We claim that

$$
B^{\star}=(-1)^{q} B+\sum_{l=1}^{q-1} \nabla^{l} u \star \nabla^{q-l} B
$$

We prove the claim. We let $u, v \in C^{\infty}(M)$ be two smooth functions on $M$. Integrating by parts, we have that

$$
\begin{aligned}
\int_{M} u B v d v_{g} & =\int_{M} u B_{i_{1} \ldots i_{q}} \nabla^{i_{1} \ldots i_{q}} v d v_{g}=(-1)^{q} \int_{M} \nabla^{i_{q} \ldots i_{1}}\left(u B_{i_{1} \ldots i_{q}}\right) v d v_{g} \\
& =(-1)^{q} \int_{M}\left(B_{i_{1} \ldots i_{q}} \nabla^{i_{q} \ldots i_{1}} u+\sum_{l=0}^{q-1} \nabla^{l} u \star \nabla^{q-l} B\right) v d v_{g}
\end{aligned}
$$

Therefore, $B^{\star}$ is defined and

$$
B^{\star} u=(-1)^{q} B_{i_{1} \ldots i_{q}} \nabla^{i_{q} \ldots i_{1}} u+\sum_{l=0}^{q-1} \nabla^{l} u \star \nabla^{q-l} B
$$

For any smooth tensor field $T$, we define $\operatorname{Asym}(T)(X, Y, \ldots):=T(X, Y, \ldots)-$ $T(Y, X, \ldots)$. It follows from the definition of the curvature tensor that

$$
\operatorname{Asym}\left(\nabla^{2} T\right)=T \star R,
$$

where $R$ is the curvature tensor. Therefore, for any permutation $\sigma$ of $\{1, \ldots, q\}$, we have that

$$
\begin{equation*}
\nabla^{q} u-\sigma \cdot \nabla^{q} u=\nabla^{q-2} u \star R \tag{5}
\end{equation*}
$$

where $\sigma \cdot T$ permutes the variables of the covariant tensor $T$ along $\sigma$. Therefore, we have that $\nabla^{i_{q} \ldots i_{1}} u-\nabla^{i_{1} \ldots i_{q}} u$ is a contraction of $\nabla^{q-2} u$, and therefore we get that $B^{\star}=(-1)^{q} B+$ lot. This proves the claim.
We are now in position to prove Proposition 1. It follows from the definition of $P_{g}$ that there exists $B$, a smooth $T_{2 k-1}^{0}$-tensor field on $M$, such that $P_{g} u=$ $\Delta_{g}^{k} u+B u+l o t$ for all $u \in C^{\infty}(M)$. Since $P_{g}$ and $\Delta_{g}$ are self-adjoint, we then get that

$$
P_{g}=P_{g}^{\star}=\Delta_{g}^{k}+B^{\star}+l o t=\Delta_{g}^{k}-B+l o t
$$

since $2 k-1$ is odd. In particular, $B u=l o t$ and therefore, $B u=0$ for all $u \in$ $C^{\infty}(M)$.

We now take $C$ a smooth $(2 k-2,0)$ - tensor field such that $P_{g}=\Delta_{g}^{k}+C \cdot \nabla^{2 k-2}+l o t$. We define $A$ as the symmetrized tensor of $C$, that is via coordinates $A(X, Y)=$ $(-1)^{k-1} \frac{1}{2}(C(X, Y)+C(Y, X))$ for all $X, Y$ any $T_{0}^{k-1}$-tensors on $M$. As easily checked, since changing the order of differentiation involves only lower order terms via with (5), we have that

$$
\begin{aligned}
C \cdot \nabla^{2 k-2} u= & C_{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} \nabla^{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k_{1}}} u \\
= & (-1)^{k-1} A_{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} \nabla^{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} u+\nabla^{2 k-4} u \star R \\
= & (-1)^{k-1} A_{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} \nabla^{j_{k-1} \ldots j_{1} i_{1} \ldots i_{k-1}} u+\nabla^{2 k-4} u \star R \\
= & (-1)^{k-1} \nabla^{j_{k-1} \ldots j_{1}}\left(A_{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} \nabla^{i_{1} \ldots i_{k-1}} u\right) \\
& +\nabla^{2 k-4} u \star R+\sum_{l=1}^{k-1} \nabla^{2 k-2-l} u \star \nabla^{l} A
\end{aligned}
$$

and then

$$
P_{g}=\Delta_{g}^{k}+(-1)^{k-1} \nabla^{j_{k-1} \ldots j_{1}}\left(A_{i_{1} \ldots i_{k-1} j_{1} \ldots j_{k-1}} \nabla^{i_{1} \ldots i_{k-1}}\right)+\text { lot }
$$

Iterating these steps yields (3). Integrating by parts then yields (4).
Define the norm $\|u\|_{H_{k}^{2}}:=\sum_{l=0}^{k}\left\|\nabla^{l} u\right\|_{2}$ and the space $H_{k}^{2}(M)$ as the completion of $C^{\infty}(M)$ for the norm $\|\cdot\|_{H_{k}^{2}}$. As a consequence of (4), we get that the bilinear form $(u, v) \mapsto \int_{M} u P_{g} v d v_{g}$ extends to a continuous symmetrical bilinear form on $H_{k}^{2}(M) \times H_{k}^{2}(M)$. We say that $P_{g}$ is coercive if there exists $c>0$ such that

$$
\int_{M} u P_{g} u d v_{g} \geq c\|u\|_{2}^{2} \text { for all } u \in H_{k}^{2}(M)
$$

We then define the norm $\|u\|_{P_{g}}:=\sqrt{\int_{M} u P_{g} u d v_{g}}$ for all $u \in H_{k}^{2}(M)$.
Proposition 2. Assume that $P_{g}$ is coercive. Then $\|\cdot\|_{P_{g}}$ is a norm on $H_{k}^{2}$ equivalent to $\|\cdot\|_{H_{k}^{2}}$.

Proof. Clearly $\|\cdot\|_{P_{g}}$ is a norm and there exists $C>0$ such that $\|\cdot\|_{P_{g}} \leq C\|\cdot\|_{H_{k}^{2}}$. We now argue by contradiction and we assume that the two norms are not equivalent: then there exists $\left(u_{i}\right)_{i \in \mathbb{N}} \in H_{k}^{2}(M)$ such that

$$
\begin{equation*}
\left\|u_{i}\right\|_{H_{k}^{2}}=1 \text { and }\left\|u_{i}\right\|_{P_{g}}=o(1) \tag{6}
\end{equation*}
$$

when $i \rightarrow+\infty$. Up to a subsequence, still denoted as $\left(u_{i}\right)$, there exists $u \in H_{k}^{2}(M)$ such that $u_{i} \rightharpoonup u$ weakly in $H_{k}^{2}(M)$ and $u_{i} \rightarrow u$ strongly in $H_{k-1}^{2}(M)$ when $i \rightarrow+\infty$. The coercivity of $P_{g}$ yields $\left\|u_{i}\right\|_{2}=o(1)$ when $i \rightarrow+\infty$, and then $u \equiv 0$. Therefore, we have that

$$
\begin{equation*}
u_{i} \rightharpoonup 0 \text { weakly in } H_{k}^{2}(M) \text { and } u_{i} \rightarrow 0 \text { strongly in } H_{k-1}^{2}(M) \tag{7}
\end{equation*}
$$

when $i \rightarrow+\infty$. Consequently, (6) rewrites

$$
\begin{equation*}
\lim _{i \rightarrow+\infty} \int_{M}\left|\nabla^{k} u_{i}\right|_{g}^{2} d v_{g}=1 \text { and } \lim _{i \rightarrow+\infty} \int_{M}\left(\Delta_{g}^{\frac{k}{2}} u_{i}\right)^{2} d v_{g}=0 \tag{8}
\end{equation*}
$$

The contradiction comes from a Bochner-Lichnerowicz-Weitzenbock type formula. Here again, we use (5). We fix $u, v \in C^{\infty}(M)$ : we have that (the notation $a \equiv b$
means that the terms are equal up to a divergence)

$$
\begin{aligned}
\left(\nabla^{k} u, \nabla^{k} v\right)_{g} & \equiv g^{\alpha_{1} \beta_{1}} \ldots g^{\alpha_{k} \beta_{k}} \nabla_{\alpha_{1} \ldots \alpha_{k}} u \nabla_{\beta_{1} \ldots \beta_{k}} v \\
& \equiv-g^{\alpha_{1} \beta_{1}} \ldots g^{\alpha_{k} \beta_{k}} \nabla_{\beta_{1} \alpha_{1} \ldots \alpha_{k}} u \nabla_{\beta_{2} \ldots \beta_{k}} v \\
& \equiv-g^{\alpha_{1} \beta_{1}} \ldots g^{\alpha_{k} \beta_{k}} \nabla_{\alpha_{2} \ldots \alpha_{k} \beta_{1} \alpha_{1}} u \nabla_{\beta_{2} \ldots \beta_{k}} v+\nabla^{k-1} u \star \nabla^{k-1} v \star R \\
& \equiv-g^{\alpha_{2} \beta_{2}} \ldots g^{\alpha_{k} \beta_{k}} \nabla_{\alpha_{2} \ldots \alpha_{k}} g^{\alpha_{1} \beta_{1}} \nabla_{\beta_{1} \alpha_{1}} u \nabla_{\beta_{2} \ldots \beta_{k}} v+\nabla^{k-1} u \star \nabla^{k-1} v \\
& \equiv g^{\alpha_{2} \beta_{2}} \ldots g^{\alpha_{k} \beta_{k}} \nabla_{\alpha_{2} \ldots \alpha_{k}} \Delta_{g} u \nabla_{\beta_{2} \ldots \beta_{k}} v+\nabla^{k-1} u \star \nabla^{k-1} v \star R \\
& \equiv\left(\nabla^{k-1} \Delta_{g} u, \nabla^{k-1} v\right)_{g}+\nabla^{k-1} u \star \nabla^{k-1} v \star R .
\end{aligned}
$$

the same procedure applied to $\left(\nabla^{k-1} v, \nabla^{k-1} \Delta_{g} u\right)_{g}$ yields

$$
\begin{aligned}
\left(\nabla^{k} u, \nabla^{k} v\right)_{g} \equiv & \left(\nabla^{k-2} \Delta_{g} u, \nabla^{k-2} \Delta_{g} v\right)_{g} \\
& +\nabla^{k-1} u \star \nabla^{k-1} v \star R+\nabla^{k-2} \Delta_{g} u \star \nabla^{k-2} v \star R
\end{aligned}
$$

Taking $u=v=u_{i}$, integrating over $M$ and using (7) yields

$$
\int_{M}\left|\nabla^{k} u_{i}\right|_{g}^{2} d v_{g}=\int_{M}\left|\nabla^{k-2} \Delta_{g} u_{i}\right|_{g}^{2} d v_{g}+o(1)
$$

when $i \rightarrow+\infty$. Iterating this process and considering separately the cases $k$ odd and $k$ even, we get that

$$
\int_{M}\left|\nabla^{k} u_{i}\right|_{g}^{2} d v_{g}=\int_{M}\left(\Delta_{g}^{\frac{k}{2}} u_{i}\right)^{2} d v_{g}+o(1)
$$

when $i \rightarrow+\infty$. This is a contradiction with (8) and Proposition 2 is proved.

## 3. General considerations on the equivariant Yamabe invariant

We let $(M, \mathcal{C})$ be a conformal Riemannian manifold. We let $G \subset \operatorname{Diff}(M)$ be a subgroup of diffeomorphisms of $M$. We define

$$
\mathcal{C}_{G}:=\left\{g \in \mathcal{C} / G \subset \operatorname{Isom}_{g}(M)\right\}
$$

and we assume that $\mathcal{C}_{G} \neq \emptyset$. In particular, $G$ is contained in a compact group. Therefore, without loss of generality, we assume that $G$ is a compact group. As easily checked, for any $g \in \mathcal{C}_{G}$, we have that

$$
\mathcal{C}_{G}=\left\{e^{2 \omega} g / \omega \in C_{G}^{\infty}(M)\right\}
$$

where $C_{G}^{\infty}(\Omega)=\left\{\omega \in C^{\infty}(M) / \omega \circ \sigma=\omega\right.$ for all $\left.\sigma \in G\right\}$ is the set of $G$-invariant smooth functions on $M$. We assume that $n>2 k$ : in this context, it is more convenient to write a metric $\hat{g} \in \mathcal{C}$ as $\hat{g}=u^{\frac{4}{n-2 k}} g$ with $u \in C_{+}^{\infty}(M)$. The relation between $P_{g}$ and $P_{\hat{g}}$ is given by (2). With the new parametrization, we have that

$$
\mathcal{C}_{G}=\left\{u^{\frac{4}{n-2 k}} g / u \in C_{G,+}^{\infty}(M)\right\}
$$

where $C_{G,+}^{\infty}(M):=\left\{u \in C_{G}^{\infty}(M) / u>0\right\}$. Let $f \in C_{G,+}^{\infty}(M)$ be a smooth positive $G$-invariant function. By analogy with the Yamabe invariant, we define

$$
\mu_{f}\left(\mathcal{C}_{G}\right):=\inf _{g \in \mathcal{C}_{G}} \frac{\int_{M} Q_{g} d v_{g}}{V_{f}(M, g)^{\frac{2}{2^{\star}}}}
$$

where $V_{f}(M, g)$ is the $f$-volume defined in the introduction and $2^{\star}:=\frac{2 n}{n-2 k}$. We fix $g \in \mathcal{C}_{G}$ : as easily checked, we have that

$$
\mu_{f}\left(\mathcal{C}_{G}\right)=\frac{2}{n-2 k} \inf _{u \in C_{G,+}^{\infty}(M)} I_{g}(u)
$$

where

$$
I_{g}(u):=\frac{\int_{M} u P_{g} u d v_{g}}{\left(\int_{M} f|u|^{2^{\star}} d v_{g}\right)^{\frac{2}{2^{\star}}}}
$$

for all $u \in H_{k}^{2}(M) \backslash\{0\}$.
Proposition 3. A metric $g \in \mathcal{C}_{G}$ is a critical point of the functional $g \mapsto \frac{\int_{M} Q_{g} d v_{g}}{V_{f}(M, g)^{\frac{2}{2^{x}}}}$ if and only if there exists $\lambda \in \mathbb{R}$ such that $Q_{g}=\lambda f$.
Proof. We fix $g \in \mathcal{C}_{G}$ and $t \mapsto g(t) \in \mathcal{C}_{G}$ a differentiable family of metrics conformal to $g$ such that $g(0)=g$. In particular, there exists a differentiable family $t \mapsto u(t) \in$ $C_{G,+}^{\infty}(M)$ such that $g(t)=u(t)^{\frac{4}{n-2 k}} g$ and $u(0)=1$. We define $\dot{u}:=u^{\prime}(0)$. Using the self-adjointness of $P_{g}$, straightforward computations yield

$$
\frac{d}{d t}\left(\frac{\int_{M} Q_{g(t)} d v_{g(t)}}{V_{f}(M, g(t))^{\frac{2}{2^{\star}}}}\right)_{t=0}=2 \frac{\int_{M} \dot{u}\left(Q_{g}-f \bar{Q}_{g}^{f}\right) d v_{g}}{V_{f}(M, g(t))^{\frac{2}{2^{\star}}}}
$$

where

$$
\bar{Q}_{g}^{f}=\frac{\int_{M} Q_{g} d v_{g}}{V_{f}(M, g)}
$$

Since $u$ is $G$-invariant, the function $\dot{u}$ ranges $C_{G}^{\infty}(M)$. Fix $v \in C^{\infty}(M)$ and let $v_{G}$ be its symmetrization via the Haar measure (which is well-defined since $G$ is compact). We then define $u(t):=1+t v_{G}$ for all $t \in \mathbb{R}$ : since $f$ and $Q_{g}$ are $G$-invariant (this is a consequence of point (ii) of the characterization of $P_{g}$ and of the definition of $Q_{g}$ ), we get that

$$
\int_{M} \dot{u}\left(Q_{g}-f \bar{Q}_{g}^{f}\right) d v_{g}=\int_{M} v_{G}\left(Q_{g}-f \bar{Q}_{g}^{f}\right) d v_{g}=\int_{M} v\left(Q_{g}-f \bar{Q}_{g}^{f}\right) d v_{g}
$$

Therefore, $g$ is a critical point if and only if $Q_{g}=f \bar{Q}_{g}^{f}$. This proves Proposition 3.

To carry out the analysis, coercivity and positivity preserving property are required. More precisely, we assume that there exists $g \in \mathcal{C}$ such that
$\left\{\begin{array}{cl}(C) & \text { the operator } P_{g} \text { is coercive } \\ (P P P) & \text { for any } u \in C^{\infty}(M) \text { such that } P_{g} \geq 0 \text { then either } u>0 \text { or } u \equiv 0\end{array}\right\}$.
Note that $(C)$ and $(P P P)$ are conformally invariant: they hold for some $g \in \mathcal{C}$ iff they hold for all $g \in \mathcal{C}$.
Proposition 4. Assume that the metric $g$ is Einstein with positive scalar curvature and $n>2 k$, then $P_{g}$ satisfies $(C)$ and $(P P P)$.

Proof. This relies essentially on the the explicit expression of the GJMS operator in the Einstein case: see Proposition 7.9 of Fefferman-Graham [13] and also Gover [14] for a proof via tractors. Indeed, for an Einstein metric $g, P_{g}$ expresses as an explicit product of second-order operators with constant coefficients depending only on the scalar curvature. For positive curvature, a direct consequence is that $P_{g}$ satisfies $(P P P)$ by $k$ applications of the second-order comparison principle. Moreover, still in this case, since $P_{g}=S\left(\Delta_{g}\right)$ with $S$ a polynomial with positive constant coefficients, it follows from Hebey-Robert [19] that the first eigenvalue of $P_{g}$ is $S(0)>0\left(0\right.$ is the first eigenvalue of $\left.\Delta_{g}\right)$, and then $P_{g}$ satisfies $(C)$.

Due to the lack of compactness of the embedding $H_{k}^{2}(M) \hookrightarrow L^{2^{\star}}(M)$, it is standard to use the subcritical method. Given $q \in\left(2,2^{\star}\right]$, we define

$$
I_{g, q}(u):=\frac{\int_{M} u P_{g} u d v_{g}}{\left(\int_{M} f|u|^{q} d v_{g}\right)^{\frac{2}{q}}}
$$

for all $u \in H_{k}^{2}(M) \backslash\{0\}$, and

$$
\mu_{q}:=\inf _{u \in H_{k, G}^{2}(M) \backslash\{0\}} I_{g, q}(u),
$$

where $H_{k, G}^{2}(M):=\left\{u \in H_{k}^{2}(M) / u \circ \sigma=u\right.$ a.e. for all $\left.\sigma \in G\right\}$. The first result is that $\mu_{q}$ is achieved at a smooth positive minimizer when $q<2^{\star}$ :
Proposition 5. We fix $q \in\left(2,2^{\star}\right)$, we assume that $(C)$ and $(P P P)$ hold and that $\mathcal{C}_{G} \neq \emptyset$. Then $\mu_{q}>0$ is achieved. Moreover, there exists $u_{q} \in C_{G,+}^{\infty}(M)$ a smooth positive function such that $\mu_{q}=I_{g, q}\left(u_{q}\right)$ and

$$
\begin{equation*}
P_{g} u_{q}=\mu_{q} f u_{q}^{q-1} \text { in } M \text { with } \int_{M} f u_{q}^{q} d v_{g}=1 \tag{9}
\end{equation*}
$$

Proof. Since $P_{g}$ is coercive, the norms $\|\cdot\|_{H_{k}^{2}}$ and $\|\cdot\|_{P_{g}}$ are equivalent, and then, it follows from Hölder's and Sobolev's inequality that

$$
\begin{align*}
& \left(\int_{M} f|u|^{q} d v_{g}\right)^{\frac{2}{q}} \leq\left(\int_{M} f d v_{g}\right)^{\frac{2}{q}-\frac{2}{2^{\star}}}\left(\int_{M} f|u|^{2^{\star}} d v_{g}\right)^{\frac{2}{2^{\star}}}  \tag{10}\\
& \leq C\left(\int_{M} f d v_{g}\right)^{\frac{2}{q}-\frac{2}{2^{\star}}}\|u\|_{H_{k}^{2}}^{2} \leq C^{\prime}\left(\int_{M} f d v_{g}\right)^{\frac{2}{q}-\frac{2}{2^{\star}}}\|u\|_{P_{g}}^{2}
\end{align*}
$$

and then $I_{g, q}(u) \geq\left(C^{\prime}\right)^{-1}\left(\int_{M} f d v_{g}\right)^{-\frac{2}{q}+\frac{2}{2^{\star}}}$ for all $u \in H_{k}^{2}(M) \backslash\{0\}$, and therefore $\mu_{q}>0$. The existence of a minimizer is standard and we omit it. Let us take then $u \in H_{k, G}^{2}(M) \backslash\{0\}$ be a mimimizer. Without loss of generality, we can assume that $\int_{M} f|u|^{q} d v_{g}=1$.
The Euler-Lagrange equation for $I_{g, q}$ yields $I_{g, q}^{\prime}(u) \varphi=0$ for all $\varphi \in H_{k, G}^{2}(M)$. Using the Haar measure and arguing as in the proof of Proposition 3 (see also [18]), we get that this equality holds for all $\varphi \in H_{k}^{2}(M)$. Since the exponent $q$ is subcritical, we get with standard bootstrap arguments that $u \in C_{G}^{2 k}(M)$ and $P_{g} u=$ $\mu_{q} f|u|^{q-2} u$. We are left with proving that $u>0$ or $u<0$. We let $v \in C_{G}^{2 k}(M)$ be such that $P_{g} v=\left|P_{g} u\right|$ in $M$. Since $u \not \equiv 0$, it follows from $(P P P)$ that $v \geq|u|$ and $v>0$. Using again the definition of $\mu_{q}$, we have that

$$
\begin{aligned}
\mu_{q} & \leq \frac{\int_{M} v P_{g} v d v_{g}}{\left(\int_{M} f v^{q} d v_{g}\right)^{\frac{2}{q}}}=\mu_{q} \frac{\int_{M} f v|u|^{q-1} d v_{g}}{\left(\int_{M} f v^{q} d v_{g}\right)^{\frac{2}{q}}} \\
& \leq \mu_{q} \frac{\left(\int_{M} f v^{q} d v_{g}\right)^{\frac{1}{q}}\left(\int_{M} f|u|^{q} d v_{g}\right)^{\frac{q-1}{q}}}{\left(\int_{M} f v^{q} d v_{g}\right)^{\frac{2}{q}}} \\
& \leq \mu_{q}\left(\int_{M} f|u|^{q} d v_{g}\right)^{\frac{q-2}{q}}=\mu_{q} \text { since } v \geq|u|
\end{aligned}
$$

Therefore equality holds everywhere and $|u|=v>0$. In particular $u$ does not change sign, and we can assume that it is positive. Bootstrap and regularity theory (see [1]) then yield $u \in C_{G,+}^{\infty}(M)$, and Proposition 5 is proved with $u_{q}:=u$.

Proposition 6. We claim that $\lim _{q \rightarrow 2^{\star}} \mu_{q}=\mu_{2^{\star}}=\frac{n-2 k}{2} \mu_{f}\left(\mathcal{C}_{G}\right)$.
Proof. Using the Hölder's inequality (10), we get that

$$
I_{g, 2^{\star}}(u) \leq I_{g, q}(u) V_{f}(M, g)^{\frac{2}{q}-\frac{2}{2^{\star}}}
$$

for all $u \in H_{k}^{2}(M) \backslash\{0\}$, and then $\mu_{2^{\star}} \leq \mu_{q} V_{f}(M, g)^{\frac{2}{q}-\frac{2}{2^{\star}}}$, which yields $\mu_{2^{\star}} \leq$ $\liminf _{q \rightarrow 2^{\star}} \mu_{q}$. Conversely, fix $\epsilon>0$ and let $u \in H_{k, G}^{2}(M) \backslash\{0\}$ be such that $I_{g, 2^{\star}}(u)<\mu_{2^{\star}}+\epsilon$. Since $\lim _{q \rightarrow 2^{\star}} I_{g, q}(u)=I_{g, 2^{\star}}(u)$, we then get that there exists $q_{0}<2^{\star}$ such that $\mu_{q}<\mu_{2^{\star}}+\epsilon$ for $q \in\left(q_{0}, 2^{\star}\right)$, and then $\lim \sup _{q \rightarrow 2^{\star}} \mu_{q} \leq \mu_{2^{\star}}$. Therefore, $\lim _{q \rightarrow 2^{\star}} \mu_{q}=\mu_{2^{\star}}$.

For $q \in\left(2,2^{\star}\right]$, we define $\mu_{q,+}:=\inf \left\{I_{g, q}(u) / u \in H_{k, G}^{2}(M) \backslash\{0\}\right.$ and $u \geq 0$ a.e. $\}$. Arguing as above, we get that $\lim _{q \rightarrow 2^{\star}} \mu_{q,+}=\mu_{2^{\star},+}$. Since $\mu_{q,+}=\mu_{q}$ for all $q<2^{\star}$ with Proposition 5, we then get that $\mu_{2^{\star}}=\mu_{2^{\star},+}$.

We claim that $\mu_{2^{\star},+}=\frac{n-2 k}{2} \mu_{f}\left(\mathcal{C}_{G}\right)$. Indeed, via local convolutions with a positive kernel, we get that $C_{+}^{\infty}(M)$ is dense in $H_{k,+}^{2}(M)$ for the $H_{k}^{2}$-norm. A symmetrization via the Haar measure then yields that $C_{G,+}^{\infty}(M)$ is dense in $H_{k, G,+}^{2}(M)$ : clearly this yields $\mu_{2^{\star},+}=\frac{n-2 k}{2} \mu_{f}\left(\mathcal{C}_{G}\right)$, and the claim is proved.

We define $D_{k}^{2}\left(\mathbb{R}^{n}\right)$ as the completion of $C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ for the norm $u \mapsto\left\|\Delta_{\xi}^{\frac{k}{2}} u\right\|_{2}$ and we define

$$
\begin{equation*}
\frac{1}{K(n, k)}:=\inf _{u \in D_{k}^{2}\left(\mathbb{R}^{n}\right) \backslash\{0\}} \frac{\int_{\mathbb{R}^{n}}\left(\Delta_{\xi}^{\frac{k}{2}} u\right)^{2} d v_{\xi}}{\left(\int_{\mathbb{R}^{n}}|u|^{2^{\star}} d v_{\xi}\right)^{\frac{2}{2^{\star}}}} \tag{11}
\end{equation*}
$$

It follows from Sobolev's embedding theorem that $K(n, k)>0$. Moreover, it follows from Lions [23] that the infimum is achieved by $U: x \mapsto\left(1+|x|^{2}\right)^{k-\frac{n}{2}}$, and that all minimizers are compositions of $U$ by translations and homotheties.

Proposition 7. We have that

$$
\begin{equation*}
\mu_{f}\left(\mathcal{C}_{G}\right) \leq \frac{2}{n-2 k} \cdot \frac{\left|O_{G}(x)\right|^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2^{\star}}} K(n, k)} \tag{12}
\end{equation*}
$$

for all $x \in M$, where $\left|O_{G}(x)\right|$ denotes the cardinal (possibly $\infty$ ) of the orbit $O_{G}(x)$.
Proof. We fix $x \in M$. Without loss of generality, we assume that $m:=\left|O_{G}(x)\right|<$ $+\infty$ (otherwise (12) is clear). We let $\sigma_{1}=I d_{M}, \ldots, \sigma_{m} \in G$ be such that $O_{G}(x)=$ $\left\{x_{1}, \ldots, x_{m}\right\}$ where $x_{i}=\sigma_{i}(x)$ for all $i \in\{1, \ldots, m\}$ are distinct. We let $u \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ be a radially symmetrical smooth function and we define for $\epsilon>0$ small the function

$$
u_{\epsilon, i}(z):=u\left(\frac{1}{\epsilon} \exp _{x_{i}}^{-1}(z)\right) \text { if } d_{g}\left(z, x_{i}\right)<i_{g}(M) \text { and } 0 \text { otherwise. }
$$

Clearly, $u_{\epsilon, i} \in C^{\infty}(M)$ for $\epsilon>0$ small enough. We now define

$$
u_{\epsilon}:=\sum_{i=1}^{m} u_{\epsilon, i}
$$

As one checks, since $u$ is radially symmetrical, we have that $u_{\epsilon} \in C_{G}^{\infty}(M)$ is $G$-invariant for $\epsilon>0$ small enough.

Let us compute $I_{g, 2^{\star}}\left(u_{\epsilon}\right)$. We fix $\delta \in\left(0, i_{g}(M)\right)$ and we define the metric $g_{\epsilon}:=$ $\left(\exp _{g}^{\star}\right)(\epsilon \cdot)$ : since the elements of $G$ are isometries (and then $P_{g}=P_{\sigma^{\star} g}=\sigma^{\star} P_{g}$ for all $\sigma \in G$ ) and the $u_{\epsilon, i}$ 's have disjoint supports, we get that

$$
\begin{aligned}
\int_{M} u_{\epsilon} P_{g} u_{\epsilon} d v_{g} & =\sum_{i, j=1}^{m} \int_{M} u_{\epsilon, i} P_{g} u_{\epsilon, j} d v_{g}=\sum_{i=1}^{m} \int_{M} u_{\epsilon, i} P_{g} u_{\epsilon, i} d v_{g} \\
& =\sum_{i=1}^{m} \int_{B_{\delta}\left(x_{i}\right)} u_{\epsilon, 1} \circ \sigma_{i}^{-1} P_{g}\left(u_{\epsilon, 1} \circ \sigma_{i}^{-1}\right) d v_{g} \\
& =m \int_{B_{\delta}(x)} u_{\epsilon, 1} P_{g} u_{\epsilon, 1} d v_{g}=m \epsilon^{n-2 k} \int_{B_{\epsilon-1}(0)} u P_{g_{\epsilon}} u d v_{g_{\epsilon}}
\end{aligned}
$$

since $\lim _{\epsilon \rightarrow 0} g_{\epsilon}=\xi$, the Euclidean metric, we get that

$$
\int_{M} u_{\epsilon} P_{g} u_{\epsilon} d v_{g}=\epsilon^{n-2 k}\left(m \int_{\mathbb{R}^{n}}\left(\Delta_{\xi}^{\frac{k}{2}} u\right)^{2} d v_{\xi}+o(1)\right)
$$

when $\epsilon \rightarrow 0$. Similarly, using the $G$-invariance of $f$, we get that

$$
\int_{M} f\left|u_{\epsilon}\right|^{2^{\star}} d v_{g}=\epsilon^{n}\left(m f(x) \int_{\mathbb{R}^{n}}|u|^{2^{\star}} d v_{\xi}+o(1)\right)
$$

when $\epsilon \rightarrow 0$, and then

$$
I_{g, 2^{\star}}\left(u_{\epsilon}\right)=\frac{m^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2^{\star}}}} \cdot \frac{\int_{\mathbb{R}^{n}}\left(\Delta_{\xi}^{\frac{k}{2}} u\right)^{2} d v_{\xi}}{\left(\int_{\mathbb{R}^{n}}|u|^{2^{\star}} d v_{\xi}\right)^{\frac{2}{2^{\star}}}}+o(1)
$$

when $\epsilon \rightarrow 0$. Therefore, since $\mu_{f}\left(\mathcal{C}_{G}\right)=\mu_{2^{\star}}$, taking the limit $\epsilon \rightarrow 0$ and taking the infimum on the $u$ 's, we get that

$$
\mu_{2^{\star}} \leq \frac{\left|O_{G}(x)\right|^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2^{\star}}}} \cdot \inf _{u \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right) \backslash\{0\} \text { radial }} \frac{\int_{\mathbb{R}^{n}}\left(\Delta_{\xi}^{\frac{k}{2}} u\right)^{2} d v_{\xi}}{\left(\int_{\mathbb{R}^{n}}|u|^{2^{\star}} d v_{\xi}\right)^{\frac{2}{2^{\star}}}}
$$

It follows from Lions [23] that the infimum $K(n, k)^{-1}$ is achieved at smooth radially symmetrical functions, therefore we obtain (12).

## 4. The quantization of the formation of singularities

The objective of this section is to prove the following result:
Theorem 2. Let $(M, \mathcal{C})$ be a conformal Riemannian manifold of dimension $n \geq 3$ and let $k \in \mathbb{N}^{\star}$ be such that $2 k<n$. Let $G$ be a group of diffeomorphisms such that $\mathcal{C}_{G} \neq \emptyset$ and let $f \in C_{G,+}^{\infty}(M)$ be a positive $G$-invariant function. Assume that there exists $g \in \mathcal{C}$ such that $P_{g}$ satisfies $(C)$ and $(P P P)$. For any $q \in\left(2,2^{\star}\right)$, we let $u_{q} \in C_{G,+}^{\infty}(M)$ as in Proposition 5. Then:
(i) either $\lim \sup _{q \rightarrow+\infty}\left\|u_{q}\right\|_{\infty}=+\infty$, and there exists $x \in M$ such that $\nabla f(x)=$ 0 and

$$
\mu_{f}\left(\mathcal{C}_{G}\right)=\frac{2}{n-2 k} \cdot \frac{\left|O_{G}(x)\right|^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2 \star}} K(n, k)}
$$

(ii) or $\left\|u_{q}\right\|_{\infty} \leq C$ for all $q<2^{\star}$, and there exists $u \in C_{G,+}^{\infty}(M)$ such that $\lim _{q \rightarrow 2^{\star}} u_{q}=u$ in $C^{2 k}(M)$ and $P_{g} u=\frac{n-2 k}{2} \mu_{f}\left(\mathcal{C}_{G}\right) f u^{2^{\star}-1}$ in $M$. In particular, there exists $\hat{g} \in \mathcal{C}_{G}$ such that $Q_{\hat{g}}=f$ and the infimum $\mu_{f}\left(\mathcal{C}_{G}\right)$ is achieved.

This type of result is classical. The proof of Theorem 2 goes through nine steps. For $q \in\left(2,2^{\star}\right)$, we let $u_{q} \in C_{G,+}^{\infty}(M)$ be as in Proposition 5 (this is relevant since $(C)$ and ( $P P P$ ) hold).
Step 1: We assume that there exists $C>0$ such that $\left\|u_{q}\right\|_{\infty} \leq C$ for all $q<2^{\star}$. We claim that (ii) of Theorem 2 holds.
We prove the claim. Indeed, it follows from (9), Proposition 6, the uniform bound of $\left(u_{q}\right)_{q}$ in $L^{\infty}$ and standard elliptic (see for instance [1]), that, up to a subsequence, there exists $u \in C^{2 k}(M)$ nonnegative such that $\lim _{q \rightarrow 2^{\star}} u_{q}=u$ in $C^{2 k}(M)$ : therefore, $P_{g} u=\mu_{2^{\star}} f u^{2^{\star}-1}$ in $M$ and $\int_{M} f u^{2^{\star}} d v_{g}=1$. In particular, $P_{g} u \geq 0$ and $u \not \equiv 0$, and then it follows from $(P P P)$ that $u>0$. Since $u_{q}$ is $G$-invariant for all $q \in\left(2,2^{\star}\right)$, we get that $u \in C_{G,+}^{\infty}(M)$. Moreover, $I_{g}(u)=\mu_{2^{\star}}$, and then the metric $u^{\frac{4}{n-2 k}} g$ is extremal for $\mu_{f}\left(\mathcal{C}_{G}\right)$ : it then follows from Proposition 3 that $\hat{g}:=\left(\mu_{f}\left(\mathcal{C}_{G}\right)\right)^{1 / k} u^{\frac{4}{n-2 k}} g$ is also an extremal for $\mu_{f}\left(\mathcal{C}_{G}\right)$ and $Q_{\hat{g}}=f$. This ends Step 1.

From now on, we assume that $\lim \sup _{q \rightarrow 2^{\star}}\left\|u_{q}\right\|_{\infty}=+\infty$. For the sake of clearness, we will write $\left(u_{q}\right)$ even for a subsequence of $\left(u_{q}\right)$. For any $q \in\left(2,2^{\star}\right)$, we let $x_{q} \in M$ be such that

for all $x \in B_{\beta_{q}^{-1} \delta}(0)$, where $\delta \in\left(0, i_{g}(M)\right)$.
Step 2: We claim that there exists $\tilde{u} \in C^{2 k}\left(\mathbb{R}^{n}\right)$ such that $\lim _{q \rightarrow 2^{\star}} \tilde{u}_{q}=\tilde{u}$ in $C_{l o c}^{2 k}\left(\mathbb{R}^{n}\right)$ where

0 \leq \tilde{u} \leq \tilde{u}(0)=1 \text { and } \Delta_{\xi}^{k} \tilde{u}=\mu_{2^{\star}} f\left(x_{\infty}\right) \tilde{u}^{2^{\star}-1} \text { in } \mathbb{R}^{n} \tag{16}
\end{equation*}
$$

and $x_{\infty}:=\lim _{q \rightarrow 2^{\star}} x_{q}$.
We prove the claim. It follows of the naturality of the geometric operator $P_{g}$ and of (9) that

for all $q \in\left(2,2^{\star}\right)$, where $g_{q}:=\left(\exp _{x_{q}}^{\star} g\right)\left(\beta_{q} \cdot\right)$. In particular, since the exponential is a normal chart at $x_{q}$, we have that $\lim _{q \rightarrow 2^{\star}} g_{q}=\xi$ in $C_{l o c}^{2 k}\left(\mathbb{R}^{n}\right)$. Since $0 \leq \tilde{u}_{q} \leq$ $\tilde{u}_{q}(0)=1$, it follows from standard elliptic theory (see for instance [1]) that there exists $\tilde{u} \in C^{2 k}\left(\mathbb{R}^{n}\right)$ such that $\lim _{q \rightarrow 2^{\star}} \tilde{u}_{q}=\tilde{u}$ in $C_{l o c}^{2 k}\left(\mathbb{R}^{n}\right)$. In addition, using that $P_{\xi}=\Delta_{\xi}^{k}$, passing to the limit in (17) yields (16). This proves the claim.
Step 3: We claim that there exists $C>0$ such that

We prove the claim. We fix $R>0$ and we let $q$ be in $\left(2,2^{\star}\right)$ : a change of variable and Sobolev's embedding yields

for all $q \in\left(2,2^{\star}\right)$. Using (9) and Proposition 6 , letting $q \rightarrow 2^{\star}$, we get that

when $q \rightarrow 2^{\star}$. Since $\tilde{u}(0)>0$, we the get that $\beta_{q}=O\left(\alpha_{q}\right)$ when $q \rightarrow 2^{\star}$. This inequality combined with (14) yields (18). This proves the claim.

Step 4: We claim that $\tilde{u} \in D_{k}^{2}\left(\mathbb{R}^{n}\right)$.
We prove the claim. Indeed, for all $i \in\{0, \ldots, k\}$, it follows from (18) and a change of variable that $\left\|\nabla^{i} \tilde{u}_{q}\right\|_{L^{p_{i}}\left(B_{R}(0)\right)} \leq C\left\|\nabla^{i} u_{q}\right\|_{L^{p_{i}\left(B_{R \beta_{q}}\left(x_{q}\right)\right)}} \leq\left\|\nabla^{i} \tilde{u}_{q}\right\|_{L^{p_{i}}(M)}$ for all $q \in\left(2,2^{\star}\right)$, all $R>0$ and where $p_{i}:=\frac{2 n}{n-2 k+2 i}$. It follows from Sobolev's inequalities that the right-hand-side is dominated by $\left\|u_{q}\right\|_{H_{k}^{2}}$, and therefore, letting $q \rightarrow 2^{\star}$ and $R \rightarrow+\infty$ yields $\nabla^{i} \tilde{u} \in L^{p_{i}}\left(\mathbb{R}^{n}\right)$ for all $i \in\{0, \ldots, k\}$. We let $\eta \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ be such that $\eta_{\mid B_{1}(0)} \equiv 1$ : as easily checked, $\left(\eta\left(m^{-1} .\right) \tilde{u}\right)_{m} \in C_{c}^{\infty}\left(\mathbb{R}^{n}\right)$ is a Cauchy sequence for the $D_{k}^{2}$-norm, and therefore $\tilde{u} \in D_{k}^{2}\left(\mathbb{R}^{n}\right)$. This proves the claim.

Step 5: We claim that

We prove the claim. Since $\tilde{u} \in D_{k}^{2}\left(\mathbb{R}^{n}\right)$, we multiply (16) by $\tilde{u}$ and integrate to get $\int_{\mathbb{R}^{n}}\left(\Delta_{\xi}^{\frac{k}{2}} \tilde{u}\right)^{2} d v_{\xi}=\mu_{2^{\star}} f\left(x_{\infty}\right) \int_{\mathbb{R}^{n}} \tilde{u}^{2^{\star}} d v_{\xi}$. Since $\tilde{u} \not \equiv 0$, plugging this identity in the Sobolev inequality (11) yields

We let $m:=\left|O_{G}\left(x_{\infty}\right)\right|$ if $\left|O_{G}\left(x_{\infty}\right)\right|<\infty$, and any $m \in \mathbb{N} \backslash\{0\}$ otherwise. We let $\sigma_{1}, \ldots, \sigma_{m} \in G$ be such that $\sigma_{i}\left(x_{\infty}\right) \neq \sigma_{j}\left(x_{\infty}\right)$ for all $i, j \in\{1, \ldots, m\}, i \neq j$. We fix $\delta<\min _{i \neq j}\left\{d_{g}\left(z, z^{\prime}\right) / z \neq z^{\prime} \in O_{G}\left(x_{\infty}\right)\right\}$. The $G$-invariance yields

(21) & =\int_{M} f u_{q}^{q} d v_{g} \geq \sum_{i=1}^{m} \int_{B_{\delta}\left(\sigma_{i}\left(x_{\infty}\right)\right)} f u_{q}^{q} d v_{g}=m \int_{B_{\delta}\left(x_{\infty}\right)} f u_{q}^{q} d v_{g} \\
& \geq m \int_{B_{R \beta_{q}\left(x_{q}\right)}} f u_{q}^{q} d v_{g}=m\left(\frac{\beta_{q}}{\alpha_{q}}\right)^{n-2 k} \int_{B_{R}(0)} f\left(\exp _{x_{q}}\left(\beta_{q} \cdot\right)\right) \tilde{u}_{q}^{q} d v_{g_{q}}
\end{aligned}
$$

for all $q \in\left(2,2^{\star}\right)$ and all $R>0$. Letting $q \rightarrow+\infty$, and then $R \rightarrow+\infty$ and using (20), we get that

In particular, since $\beta_{q} \geq \alpha_{q}$ with (18), we get an upper-bound for $m$, and therefore $\left|O_{G}(x)\right|<\infty$, and we take $m=\left|O_{G}(x)\right|$. The inequality rewrites

It then follows from (12) and (18) that (19) holds. Moreover, we also get that equality holds in (20) and that $\tilde{u}$ is an extremal for the Sobolev inequality (11). This proves the claim.
Step 6: We claim that

We prove the claim. Since equality holds in (20), that $\lim _{q \rightarrow 2^{\star}} \frac{\alpha_{q}}{\beta_{q}}=1$ and that (19) holds, we get with a change of variables that

\end{equation*}

For $\delta>0$, we let $B_{\delta}\left(O_{G}\left(x_{\infty}\right)\right)$ be the union of balls of radius $\delta$ centered at the orbit. Therefore, since $\int_{M} f u_{q}^{q} d v_{g}=1,(21),(23)$ and the $G$-invariance yield

We prove the claim. This pointwise inequality has its origins in Druet [10]. We define $w_{q}(x):=d\left(x, O_{G}\left(x_{q}\right)\right)^{\frac{n-2 k}{2}} u_{q}(x)$ for all $q \in\left(2,2^{\star}\right)$ and all $x \in M$. We argue by contradiction and assume that $\lim _{q \rightarrow 2^{\star}}\left\|w_{q}\right\|_{\infty}=+\infty$. We define $\left(y_{q}\right)_{q \in\left(2,2^{\star}\right)} \in$ $M$ such that

As easily checked, coming back to the definitions of $\alpha_{q}$ and $\beta_{q}$, it follows from (19) that $\lim _{q \rightarrow 2^{\star}} u_{q}\left(x_{q}\right)^{2^{\star}-q}=1$. Therefore, since $u_{q}\left(y_{q}\right) \leq u_{q}\left(x_{q}\right)$ for all $q$ and (27) holds, we get that $\lim _{q \rightarrow 2^{\star}} \gamma_{q}^{2^{\star}-q}=1$. We define

for all $q \in\left(2,2^{\star}\right)$, where $\lim _{q \rightarrow 2^{\star}} o(1)=0$ uniformly. We fix $R>0$. It follows from the definition (26) of $w_{q}$ and $y_{q}$ that

\end{equation*}

for all $x \in B_{R}(0)$ and $q \in\left(2,2^{\star}\right)$. The limit $w_{q}\left(y_{q}\right) \rightarrow+\infty$ when $q \rightarrow 2^{\star}$ rewrites $\lim _{q \rightarrow 2^{\star}} \gamma_{q}^{-1} d_{g}\left(y_{q}, O_{G}\left(x_{q}\right)\right)=+\infty$ : therefore, there exists $q_{0} \in\left(2,2^{\star}\right)$ such that $d\left(\exp _{y_{q}}\left(\gamma_{q} x\right), O_{G}\left(x_{q}\right)\right) \geq d\left(y_{q}, O_{G}\left(x_{q}\right)\right) / 2$ for all $x \in B_{R}(0)$ and all $q \in\left(q_{0}, 2^{\star}\right)$, and it follows from (29) that $0 \leq \bar{u}_{q}(x) \leq 2^{\frac{n-2 k}{2}}$ for all $x \in B_{R}(0)$ and all $q \in\left(q_{0}, 2^{\star}\right)$. It then follows from (28) and standard elliptic theory (see for instance [1]) that there exists $\bar{u} \in C^{2 k}\left(\mathbb{R}^{n}\right)$ such that $\lim _{q \rightarrow 2 \star} \bar{u}_{q}=\bar{u}$ in $C_{l o c}^{2 k}\left(\mathbb{R}^{n}\right)$. Moreover, $\bar{u} \geq 0$ and $\bar{u}(0)=\lim _{q \rightarrow 2^{\star}} \bar{u}_{q}(0)=1$, and then $\bar{u} \not \equiv 0$. In particular,

\lim _{R \rightarrow+\infty} \lim _{q \rightarrow 2^{\star}} \int_{B_{R \gamma_{q}}\left(y_{q}\right)} f u_{q}^{q} d v_{g}=f\left(y_{\infty}\right) \int_{\mathbb{R}^{n}} \bar{u}^{2^{\star}} d v_{\xi} \tag{30}
\end{equation*}
$$

where $y_{\infty}:=\lim _{q \rightarrow 2^{\star}} y_{q}$. Since $\lim _{q \rightarrow 2^{\star}} \gamma_{q}^{-1} d_{g}\left(y_{q}, O_{G}\left(x_{q}\right)\right)=+\infty$ and $\gamma_{q} \geq \alpha_{q}=$ $(1+o(1)) \beta_{q}$ when $q \rightarrow 2^{\star}$, we get that for any $R, R^{\prime}>0$

where $q \rightarrow 2^{\star}$. We let $\sigma_{1}, \ldots, \sigma_{m} \in G$ be such that $O_{G}\left(x_{\infty}\right)=\left\{\sigma_{1}\left(x_{\infty}\right), \ldots, \sigma_{m}\left(x_{\infty}\right)\right\}$ and these points are distinct: as easily checked, we have that $\cup_{i=1}^{m} B_{R^{\prime} \beta_{q}}\left(\sigma_{i}\left(x_{q}\right)\right) \subset$ $B_{R^{\prime} \beta_{q}}\left(O_{G}\left(x_{q}\right)\right)$ and the balls are distinct. Therefore

for all $q \in\left(2,2^{\star}\right)$ and $R, R^{\prime}>0$. Letting $q \rightarrow 2^{\star}$, then $R, R^{\prime} \rightarrow+\infty$ and using (23) and (30), we get that

We prove the claim. We fix $\Omega \subset \subset M \backslash O_{G}\left(x_{\infty}\right)$ a relatively compact subset. It follows from Step 7 that there exists $C(\Omega)>0$ such that $u_{q}(x) \leq C(\Omega)$ for all $x \in \Omega$ and all $q \in\left(2,2^{\star}\right)$. It then follows from (9) and standard elliptic theory (see for instance [1]) that there exists $u_{\infty} \in C^{\infty}\left(M \backslash O_{G}\left(x_{\infty}\right)\right)$ such that $\lim _{q \rightarrow 2^{\star}} u_{q}=u_{\infty}$ in $C_{l o c}^{2 k}(\Omega)$. It then follows from (24) that $u_{\infty} \equiv 0$, and then (31) holds. This proves the claim.
The following remark will be useful in the sequel: since $\left\|u_{q}\right\|_{P_{g}}^{2}=\mu_{q} \rightarrow \mu_{2^{\star}}$ when $q \rightarrow 2^{\star}$ and $u_{q} \rightarrow 0$ in $C^{2 k}$ outside the orbit, we get from the compact embedding $H_{k}^{2} \hookrightarrow H_{k-1}^{2}$ that

We prove the claim. Indeed, this is equivalent to proving that $X(f)\left(x_{\infty}\right)=0$ for all vector field $X$ on $M$. With no loss of generality, we assume that $\nabla X\left(x_{\infty}\right)=0$ (this is always possible by modifying $X$ in a normal chart at $x_{\infty}$ ) and that $X$ has its support in $B_{\delta}\left(x_{\infty}\right)$, where $\delta<\min \left\{d_{g}\left(z, z^{\prime}\right) / z \neq z^{\prime} \in O_{G}\left(x_{\infty}\right)\right\}$. We are going to estimate $\int_{M} X\left(u_{q}\right) \Delta_{g}^{k} u_{q} d v_{g}$ with two different methods. We detail here the case $k=2 l$ even and we leave the odd case to the reader.

Integrating by parts, we have that

& +\sum_{i=1}^{l} \int_{M} \Delta_{g}^{l} u_{q} \Delta_{g}^{l-i}\left(\Delta_{g}\left(X\left(\Delta_{g}^{i-1} u_{q}\right)\right)-X\left(\Delta_{g}^{i} u_{q}\right)\right) d v_{g}
\end{aligned}
$$

Using the explicit contraction in (5), we get that

\Delta_{g}(X(v))-X\left(\Delta_{g} v\right)=\left(\Delta_{g} X\right)(\nabla v)-2\left(\nabla X, \nabla^{2} v\right)-\operatorname{Ric}_{g}(X, \nabla v)
$$

where $v \in C^{\infty}(M)$ and $\Delta_{g} X$ is the rough Laplacian, that is $\left(\Delta_{g} X\right)^{\alpha}=-g^{i j} \nabla_{i j} X^{\alpha}$. Therefore, we have that (for convenience, we omit the curvature tensor $R$ )

$$
\Delta_{g}\left(X\left(\Delta_{g}^{i-1} u_{q}\right)\right)-X\left(\Delta_{g}^{i} u_{q}\right)=\nabla^{2} X \star \nabla^{2 i-1} u_{q}+\nabla X \star \nabla^{2 i} u_{q}+X \star \nabla^{2 i-1} u_{q}
$$

for all $i \in\{1, \ldots, l\}$, and then, denoting as $\nabla^{\{m\}} T$ any linear combination of covariant derivatives of $T$ up to order $m$, we get that

$$
\begin{aligned}
& \Delta_{g}^{l-i}\left(\Delta_{g}\left(X\left(\Delta_{g}^{i-1} u_{q}\right)\right)-X\left(\Delta_{g}^{i} u_{q}\right)\right) \\
& =\Delta_{g}^{l-i}\left(\nabla^{2} X \star \nabla^{2 i-1} u_{q}+\nabla X \star \nabla^{2 i} u_{q}+X \star \nabla^{2 i-1} u_{q}\right) \\
& =\nabla^{\{2 l-2 i+2\}} X \star \nabla^{\{2 l-1\}} u_{q}+\nabla X \star \nabla^{2 l} u_{q}
\end{aligned}
$$

and then

$$
\begin{aligned}
& \quad \int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=\int_{M} X\left(\Delta_{g}^{l} u_{q}\right) \Delta_{g}^{l} u_{q} d v_{g} \\
& \quad+\int_{M} \Delta_{g}^{l} u_{q}\left(\nabla^{\{2+2 l\}} X \star \nabla^{\{2 l-1\}} u_{q}+\nabla X \star \nabla^{2 l} u_{q}\right) d v_{g} \\
& =\int_{M} X\left(\Delta_{g}^{l} u_{q}\right) \Delta_{g}^{l} u_{q} d v_{g}+\int_{M} \Delta_{g}^{l} u_{q} \star \nabla^{\{2 l+2\}} X \star \nabla^{\{2 l-1\}} u_{q} d v_{g} \\
& \quad+\int_{M} \Delta_{g}^{l} u_{q} \nabla X \star \nabla^{2 l} u_{q} d v_{g}
\end{aligned}
$$

Since $k=2 l$, it follows from (32) and the Cauchy-Schwarz inequality that

$$
\int_{M} \Delta_{g}^{l} u_{q} \star \nabla^{\{2 l+2\}} X \star \nabla^{\{2 l-1\}} u_{q} d v_{g}=O\left(\left\|u_{q}\right\|_{H_{k}^{2}}\left\|u_{q}\right\|_{H_{k-1}^{2}}\right)=o(1)
$$

when $q \rightarrow 2^{\star}$. Moreover, since $\nabla X\left(x_{\infty}\right)=0$ and (31) holds, we get that

$$
\int_{M} \Delta_{g}^{l} u_{q} \nabla X \star \nabla^{2 l} u_{q} d v_{g}=o\left(\left\|u_{q}\right\|_{H_{k}^{2}}\right)=o(1)
$$

when $q \rightarrow 2^{\star}$. Therefore, integrating by parts, we get that

$$
\begin{aligned}
& \int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=\int_{M} X\left(\Delta_{g}^{l} u_{q}\right) \Delta_{g}^{l} u_{q} d v_{g}+o(1) \\
& =\int_{M} X\left(\frac{\left(\Delta_{g}^{l} u_{q}\right)^{2}}{2}\right) d v_{g}+o(1)=-\int_{M} \frac{\operatorname{div}_{g}(X)}{2}\left(\Delta^{l} u_{q}\right)^{2}+o(1)
\end{aligned}
$$

when $q \rightarrow 2^{\star}$ and where $\operatorname{div}_{g}(X)=\nabla_{i} X^{i}$. Since $\nabla X\left(x_{\infty}\right)=0,(31)$ holds and $\left\|u_{q}\right\|_{H_{k}^{2}} \leq C$ for all $q \rightarrow 2^{\star}$, we get that the right-hand-side above goes to zero, and then

$$
\begin{equation*}
\lim _{q \rightarrow 2^{\star}} \int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=0 \tag{33}
\end{equation*}
$$

We now estimate $\int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}$ using equation (9). It follows from (4) that

$$
\int_{M} X\left(u_{q}\right) P_{g} u_{q} d v_{g}=\int_{M} \Delta_{g}^{l} X\left(u_{q}\right) \Delta_{g}^{l} u_{q} d v_{g}+\sum_{l=0}^{k-1} \int_{M} A_{(l)}\left(\nabla^{l} X\left(u_{q}\right), \nabla^{l} u_{q}\right) d v_{g}
$$

It then follows from (32) and an integration by parts that

$$
\int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=\int_{M} X\left(u_{q}\right) P_{g} u_{q} d v_{g}+o(1)
$$

when $q \rightarrow 2^{\star}$. We now use equation (9) to get that

$$
\begin{aligned}
& \int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=\mu_{q} \int_{M} f X\left(u_{q}\right) u_{q}^{q-1} d v_{g}+o(1) \\
& =\mu_{q} \int_{M} f X\left(\frac{u_{q}^{q}}{q}\right) d v_{g}=-\frac{\mu_{q}}{q} \int_{M}\left(X(f)+f \operatorname{div}_{g}(X)\right) u_{q}^{q} d v_{g}+o(1)
\end{aligned}
$$

when $q \rightarrow 2^{\star}$. It now follows from Proposition $6,(22)$ and $\nabla X\left(x_{\infty}\right)=0$ that

$$
\lim _{q \rightarrow 2^{\star}} \int_{M} X\left(u_{q}\right) \Delta_{g}^{2 l} u_{q} d v_{g}=-\frac{\mu_{2^{\star}} X(f)\left(x_{\infty}\right)}{2^{\star}\left|O_{G}\left(x_{\infty}\right)\right| f\left(x_{\infty}\right)}
$$

This limit combined with (33) yields $X(f)\left(x_{\infty}\right)=0$, which, as already mentioned, proves that $\nabla f\left(x_{\infty}\right)=0$. This ends Step 9 .
Theorem 2 is a direct consequence of Steps 1 to 9 .
As a direct byproduct of Theorem 2, we have the following proposition:
Proposition 8. Let $(M, \mathcal{C})$ be a conformal Riemannian manifold of dimension $n \geq 3$ and let $k \in \mathbb{N}^{\star}$ be such that $2 k<n$. Let $G$ be a group of diffeomorphisms such that $\mathcal{C}_{G} \neq \emptyset$ and let $f \in C_{G,+}^{\infty}(M)$ be a positive $G$-invariant function. Assume that there exists $g \in \mathcal{C}_{G}$ such that $P_{g}$ satisfies $(C)$ and $(P P P)$. We assume that

$$
\mu_{f}\left(\mathcal{C}_{G}\right)<\frac{2}{n-2 k} \cdot \frac{\left|O_{G}(x)\right|^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2^{\star}}} K(n, k)},
$$

for all $x \in M$. Then there exists $\hat{g} \in \mathcal{C}_{G}$ such that $Q_{\hat{g}}=f$ and the infimum $\mu_{f}\left(\mathcal{C}_{G}\right)$ is achieved.

A similar result was proved in [18] for $k=1$ and in [2] when $n=2 k$.

## 5. The case of the sphere

We consider here the standard unit $n$-sphere $\mathbb{S}^{n}$ endowed with its standard round metric $h$ and the associated conformal class $\mathcal{C}:=[h]$.

Proposition 9. Let $G$ be a subgroup of $\operatorname{Isom}_{h}\left(\mathbb{S}^{n}\right)$ and let $f \in C_{G,+}^{\infty}\left(\mathbb{S}^{n}\right)$ be a smooth positive function. Let $p \in \mathbb{S}^{n}$ be such that $\nabla^{i} f(p)=0$ for all $i \in\{1, \ldots, n-$ $2 k\}$ and $\left|O_{G}(p)\right| \geq 2$. Then

$$
\mu_{f}\left(\mathcal{C}_{G}\right)<\frac{2}{n-2 k} \cdot \frac{\left|O_{G}(p)\right|^{\frac{2 k}{n}}}{K(n, k) f(p)^{\frac{2}{2^{\star}}}}
$$

Proof. Given $\lambda>1$ and $x_{0} \in \mathbb{S}^{n}$, we let $\phi_{\lambda}: \mathbb{S}^{n} \rightarrow \mathbb{S}^{n}$ be such that $\phi_{\lambda}(x)=$ $\pi_{x_{0}}^{-1}\left(\lambda^{-1} \pi_{x_{0}}(x)\right)$ if $x \neq x_{0}$ and $\phi_{\lambda}\left(x_{0}\right)=x_{0}$, where $\pi_{x_{0}}$ is the stereographic projection of pole $x_{0}$. Up to a rotation, we can assume that $x_{0}:=(0, \ldots, 0,1)$ is the north pole: then we have that $\left(\pi_{N}^{-1}\right)^{\star} h=U_{1}^{\frac{4}{n-2 k}} \xi$, where $U_{1}(x):=\left(\left(1+|x|^{2}\right) / 2\right)^{k-n / 2}$. As easily checked, $\phi_{\lambda}$ is a conformal diffeomorphism and standard computations yield $\phi_{\lambda}^{\star} h=u_{x_{0}, \beta}^{\frac{4}{n-2 k}} h$ where $\beta:=\left(\lambda^{2}+1\right)\left(\lambda^{2}-1\right)^{-1}$ and

$$
u_{x_{0}, \beta}(x):=\left(\frac{\sqrt{\beta^{2}-1}}{\beta-\cos d_{h}\left(x, x_{0}\right)}\right)^{\frac{n-2 k}{2}}
$$

for all $x \in \mathbb{S}^{n}$ and $\beta>1$. In particular, we have that

$$
\begin{equation*}
\int_{\mathbb{S}^{n}} u_{p, \beta}^{2^{\star}} d v_{h}=\omega_{n} \tag{34}
\end{equation*}
$$

where $\omega_{n}>0$ is the volume of $\left(\mathbb{S}^{n}, h\right)$. It follows from the conformal law (2) that

$$
\begin{equation*}
P_{h} u_{x_{0}, \beta}=c_{n, k} Q_{h} u_{x_{0}, \beta}^{2^{\star}-1} \text { in } \mathbb{S}^{n} \text { with } c_{n, k}:=\frac{n-2 k}{2} \tag{35}
\end{equation*}
$$

We now fix $p \in \mathbb{S}^{n}$ as in the statement of Proposition 9 and we let $\sigma_{1}, \ldots \sigma_{m} \in G$ be such that $O_{G}(p)=\left\{\sigma_{1}(p), \ldots, \sigma_{m}(p)\right\}$ and $\left|O_{G}(p)\right|=m \geq 2$. We define

$$
u_{\beta}:=\sum_{i=1}^{m} u_{\sigma_{i}(p), \beta}
$$

for all $\beta>1$. One checks that $u_{\beta}$ is positive and $G$-invariant. Let us estimate

$$
I_{h}\left(u_{\beta}\right):=\frac{\int_{\mathbb{S}^{n}} u_{\beta} P_{h} u_{\beta} d v_{h}}{\left(\int_{\mathbb{S}^{n}} f u_{\beta}^{2^{\star}} d v_{h}\right)^{\frac{2}{2^{\star}}}} .
$$

The $G$-invariance and (35) yield

$$
\int_{\mathbb{S}^{n}} u_{\beta} P_{h} u_{\beta} d v_{h}=c_{n, k} Q_{h} \sum_{i, j=1}^{m} \int_{\mathbb{S}^{n}} u_{\sigma_{i}(p), \beta} u_{\sigma_{j}(p), \beta}^{2^{\star}-1} d v_{h}=m c_{n, k} Q_{h}\left(\omega_{n}+d_{\beta}\right)
$$

where we have used (34) and where

$$
d_{\beta}:=\sum_{i=2}^{m} \int_{\mathbb{S}^{n}} u_{\beta, p} u_{\beta, \sigma_{i}(p)}^{2^{\star}-1} d v_{h}
$$

for all $\beta>1$. Standard computations yield

$$
d_{\beta}=(1+o(1)) \Lambda_{p, G}\left(\beta^{2}-1\right)^{\frac{n-2 k}{2}}
$$

when $\beta \rightarrow 1$, where

$$
\Lambda_{p, G}:=\left(\int_{\mathbb{S}^{n}}\left(1-\cos d_{h}(x, p)\right)^{k-n / 2} d v_{h}\right) \cdot \sum_{i=2}^{m}\left(1-\cos d_{h}\left(p, \sigma_{i}(p)\right)\right)^{k-n / 2} d v_{h}>0
$$

Concerning the denominator, it follows from the cancelation hypothesis on the derivatives of $f$ that $|f(x)-f(p)| \leq C d_{h}\left(x, O_{G}(p)\right)^{n-2 k+1}$ for all $x \in \mathbb{S}^{n}$. Therefore, rough estimates yield

$$
\left|\int_{\mathbb{S}^{n}}(f-f(p)) u_{\beta}^{2^{\star}} d v_{h}\right| \leq C\left(\beta^{2}-1\right)^{\frac{n-2 k+1}{2}}
$$

for all $\beta>1$. A convexity inequality yields

$$
\begin{aligned}
\int_{\mathbb{S}^{n}} u_{\beta}^{2^{\star}} d v_{h} & \geq \sum_{i=1}^{m} \int_{\mathbb{S}^{n}} u_{\beta, \sigma_{i}(p)}^{2^{\star}} d v_{h}+2^{\star} \sum_{i \neq j} \int_{\mathbb{S}^{n}} u_{\sigma_{i}(p), \beta} u_{\sigma_{j}(p), \beta}^{2^{\star}-1} d v_{h} \\
& \geq m\left(\omega_{n}+2^{\star} d_{\beta}\right)
\end{aligned}
$$

Noting $\Lambda_{p, G}>0$ and that $c_{n, k} Q_{h} \omega_{n}^{{\frac{2^{\star}-2}{}}_{2^{\star}}}=K(n, k)^{-1}$ (since pulling back $u_{\beta, p}$ by the stereographic projections gives $U_{1}$, an extremal for (11)), these estimates yield

$$
\begin{aligned}
I_{h}\left(u_{\beta}\right) & \leq \frac{\left|O_{G}(p)\right|^{\frac{2 k}{n}}}{f(p)^{\frac{2}{2^{\star}}} K(n, k)} \cdot\left(1-\frac{\Lambda_{p, G}}{\omega_{n}}\left(\beta^{2}-1\right)^{\frac{n-2 k}{2}}+o\left(\left(\beta^{2}-1\right)^{\frac{n-2 k}{2}}\right)\right) \\
& <\frac{\left|O_{G}(p)\right|^{\frac{2 k}{n}}}{f(p)^{\frac{2}{2^{\star}}} K(n, k)} .
\end{aligned}
$$

Coming back to the definition of $\mu_{f}\left(\mathcal{C}_{G}\right)$, this proves Proposition 9.
Proof of Theorem 1: In the case $n=2 k+1$, it follows from Proposition 4 and 9 that Case (i) of Theorem 2 cannot hold. Therefore Case (ii) holds, and Theorem 1 is proved.
More generally, Propositions 4 and 7, Theorem 2 and Proposition 9, yield:
Theorem 3. Let $k \geq 1$ and let $G$ be a subgroup of isometries of $\left(\mathbb{S}^{n}, h\right), n>2 k$. Let $f \in C^{\infty}(M)$ be a positive $G$-invariant function and assume that $G$ acts without fixed point (that is $\left|O_{G}(x)\right| \geq 2$ for all $x \in \mathbb{S}^{n}$ ). Assume that there exists $p \in \mathbb{S}^{n}$ such that

$$
\frac{\left|O_{G}(p)\right|^{\frac{2 k}{n}}}{f(p)^{\frac{2}{2^{\star}}}} \leq \frac{\left|O_{G}(x)\right|^{\frac{2 k}{n}}}{f(x)^{\frac{2}{2^{\star}}}}
$$

for all $x \in \mathbb{S}^{n}$ and that $\nabla^{i} f(p)=0$ for all $i \in\{1, \ldots, n-2 k\}$. Then there exists $g \in[h]$ such that $Q_{g}=f$ and $G \subset \operatorname{Isom}_{g}\left(\mathbb{S}^{n}\right)$.
