# ON THE LINK BETWEEN BINOMIAL THEOREM AND DISCRETE CONVOLUTION OF POWER FUNCTION

#### Abstract

In this manuscript we introduce and discuss the $2 m+1$-degree integer valued polynomials $\mathbf{P}_{b}^{m}(n)$. These polynomials are in strong relation with discrete convolution of power function. It is also shown that odd binomial expansion is partial case of $\mathbf{P}_{b}^{m}(n)$. Basis on above, we show the relation between Binomial theorem and discrete convolution of power function.

## 1. Introduction

The polynomials $\mathbf{P}_{b}^{m}(n)$ are $2 m+1$-degree integer valued polynomials, which connect discrete convolution [BDM11] of power with Binomial theorem [AS72]. Basically, Binomial expansion is a partial case of $\mathbf{P}_{b}^{m}(n)$, while polynomials $\mathbf{P}_{b}^{m}(n)$ is in relation with discrete convolution of power function.
1.1. Definitions, Notations and Conventions. We now set the following notation, which remains fixed for the remainder of this paper:

[^0]- $\mathbf{A}_{m, r}, m \in \mathbb{N}$ is a real coefficient defined recursively

$$
\mathbf{A}_{m, r}:= \begin{cases}(2 r+1)\binom{2 r}{r}, & \text { if } r=m  \tag{1.1}\\ (2 r+1)\binom{2 r}{r} \sum_{d=2 r+1}^{m} \mathbf{A}_{m, d}\binom{d}{2 r+1} \frac{(-1)^{d-1}}{d-r} B_{2 d-2 r}, & \text { if } 0 \leq r<m \\ 0, & \text { if } r<0 \text { or } r>m\end{cases}
$$

where $B_{t}$ are Bernoulli numbers [Wei]. It is assumed that $B_{1}=\frac{1}{2}$.

- $\mathbf{L}_{m}(n, k), m \in \mathbb{N}, n, k \in \mathbb{R}$ is polynomial of degree $2 m$ in $n, k$

$$
\mathbf{L}_{m}(n, k):=\sum_{r=0}^{m} \mathbf{A}_{m, r} k^{r}(n-k)^{r}
$$

- $\mathbf{P}_{b}^{m}(n), m, b \in \mathbb{N}, n \in \mathbb{R}$ is polynomial of degree $2 m+1$ in $b, n$

$$
\mathbf{P}_{b}^{m}(n):=\sum_{k=0}^{b-1} \mathbf{L}_{m}(n, k)
$$

- $\mathbf{H}_{m, t}(b), m, t, b \in \mathbb{N}$ is a natural coefficient defined as

$$
\mathbf{H}_{m, t}(b):=\sum_{j=t}^{m}\binom{j}{t} \mathbf{A}_{m, j} \frac{(-1)^{j}}{2 j-t+1}\binom{2 j-t+1}{b} B_{2 j-t+1-b}
$$

- $\mathbf{X}_{m, t}(j), m, t \in \mathbb{N}, j \in \mathbb{R}$ is polynomial of degree $2 m+1-t$ in $j$

$$
\mathbf{X}_{m, t}(j):=(-1)^{m} \sum_{k=1}^{2 m+1-t} \mathbf{H}_{m, t}(k) \cdot j^{k}
$$

- $[P(k)]$ is the Iverson's convention [Ive62], where $P(k)$ is logical sentence on $k$

$$
[P(k)]= \begin{cases}1, & P(k) \text { is true }  \tag{1.2}\\ 0, & \text { otherwise }\end{cases}
$$

- $\langle x-a\rangle^{n}$ is powered Macaulay bracket, [Mac19]

$$
\langle x-a\rangle^{n}:=\left\{\begin{array}{ll}
(x-a)^{n}, & x \geq a  \tag{1.3}\\
0, & \text { otherwise }
\end{array} \quad a \in \mathbb{Z}\right.
$$

- $\{x-a\}^{n}$ is powered Macaulay bracket

$$
\{x-a\}^{n}:=\left\{\begin{array}{ll}
(x-a)^{n}, & x>a  \tag{1.4}\\
0, & \text { otherwise }
\end{array} \quad a \in \mathbb{Z}\right.
$$

During the manuscript, the variable $a$ is reserved to be only the condition of Macaulay functions. If the power function $\langle x-a\rangle^{n}$ or $\{x-a\}^{n}$ is written without parameter $a$ e.g $\langle x\rangle^{n}$ or $\{x\}^{n}$ means that it is assumed $a=0$.

## 2. Polynomials $\mathbf{P}_{b}^{m}(n)$ and their properties

We'd like to begin our discussion from short overview of polynomial $\mathbf{L}_{m}(n, k)$. Polynomial $\mathbf{L}_{m}(n, k), m \in \mathbb{N}, n, k \in \mathbb{R}$ is polynomial of degree $2 m$ in $n, k$. In extended form, the polynomial $\mathbf{L}_{m}(n, k)$ is as follows

$$
\mathbf{L}_{m}(n, k)=\mathbf{A}_{m, m} k^{m}(n-k)^{m}+\mathbf{A}_{m, m-1} k^{m-1}(n-k)^{m-1}+\cdots+\mathbf{A}_{m, 0}
$$

where $\mathbf{A}_{m, r}$ are real coefficients by definition 1.1. Note that $\mathbf{L}_{m}(n, k)$ implicitly involves discrete convolution of power function. We'll back to it soon. The coefficient $\mathbf{A}_{m, r}$ is a real number. Coefficients $\mathbf{A}_{m, r}$ are nonzero only for $r$ within the interval $r \in\{m\} \cup\left[0, \frac{m-1}{2}\right]$. For example, let's show an array of $\mathbf{A}_{m, r}$ for $m=0,1,2, . .7$. In order to proceed, let's type Column[Table[CoeffA[m, r], \{m, 0, 7\}, \{r, 0, m\}], Left] into Mathematica console using [Kol19], we get

Table 1. Coefficients $\mathbf{A}_{m, r}$. For $m \geq 11$ the real values of $\mathbf{A}_{m, r}$ are taking place.

Thus, the polynomial $\mathbf{L}_{m}(n, k)$ could be written as well as

$$
\mathbf{L}_{m}(n, k)=\mathbf{A}_{m, m} k^{m}(n-k)^{m}+\sum_{r=0}^{\frac{m-1}{2}} \mathbf{A}_{m, r} k^{r}(n-k)^{r}
$$

For example, a few of polynomials $\mathbf{L}_{m}(n, k)$ are

$$
\begin{aligned}
\mathbf{L}_{0}(n, k) & =1 \\
\mathbf{L}_{1}(n, k) & =6 k(n-k)+1=-6 k^{2}+6 k n+1 \\
\mathbf{L}_{2}(n, k) & =30 k^{2}(n-k)^{2}+1=30 k^{4}-60 k^{3} n+30 k^{2} n^{2}+1, \\
\mathbf{L}_{3}(n, k) & =140 k^{3}(n-k)^{3}-14 k(n-k)+1 \\
& =-140 k^{6}+420 k^{5} n-420 k^{4} n^{2}+140 k^{3} n^{3}+14 k^{2}-14 k n+1
\end{aligned}
$$

We'd like to notice that the polynomials $\mathbf{L}_{m}(n, k)$ are symmetrical as follows
Property 2.1. For every $n, k \in \mathbb{Z}$

$$
\mathbf{L}_{m}(n, k)=\mathbf{L}_{m}(n-k, k)
$$

Following table displays the symmetry of $\mathbf{L}_{m}(n, k)$

Table 2. Triangle generated by $\mathbf{L}_{1}(n, k), 0 \leq k \leq n$.

Therefore, we have briefly discussed the polynomials $\mathbf{L}_{m}(n, k)$, which is required step to be familiarized with the polynomial $\mathbf{P}_{b}^{m}(n)$ in detailed way. For now, let's discuss the polynomial $\mathbf{P}_{b}^{m}(n)$. Polynomial $\mathbf{P}_{b}^{m}(n)$ is defined as summation of $\mathbf{L}_{m}(n, k)$ over $k$ such that $0 \leq k \leq b-1$. In extended form, the polynomial $\mathbf{P}_{b}^{m}(n)$ is

$$
\begin{aligned}
\mathbf{P}_{b}^{m}(n) & =\sum_{k=0}^{b-1} \mathbf{L}_{m}(n, k)=\sum_{k=0}^{b-1} \sum_{r=0}^{m} \mathbf{A}_{m, r} k^{r}(n-k)^{r}=\sum_{r=0}^{m} \mathbf{A}_{m, r} \sum_{k=0}^{b-1} k^{r}(n-k)^{r} \\
& =\sum_{r=0}^{m} \mathbf{A}_{m, r} \sum_{k=0}^{b-1} k^{r} \sum_{j=0}^{r}(-1)^{j}\binom{r}{j} n^{r-j} k^{j} \\
& =\sum_{r=0}^{m} \sum_{j=0}^{r}(-1)^{j} n^{r-j}\binom{r}{j} \mathbf{A}_{m, r} \sum_{k=0}^{b-1} k^{r+j} \\
& =\sum_{r=0}^{m} \sum_{j=0}^{r} n^{r-j}\binom{r}{j} \mathbf{A}_{m, r} \frac{(-1)^{j}}{r+j+1} \sum_{s=0}^{r+j}\binom{r+j+1}{s} B_{s}(b-1)^{r+j-s+1}
\end{aligned}
$$

However, by Property (2.1), the $\mathbf{P}_{b}^{m}(n)$ may be written in the form

$$
\begin{aligned}
\mathbf{P}_{b}^{m}(n) & =\sum_{k=1}^{b} \mathbf{L}_{m}(n, k)=\sum_{k=1}^{b} \sum_{r=0}^{m} \mathbf{A}_{m, r} k^{r}(n-k)^{r} \\
& =\sum_{k=1}^{b} \sum_{r=0}^{m} \mathbf{A}_{m, r} k^{r} \sum_{t=0}^{r}(-1)^{r-t} n^{t}\binom{r}{t} k^{r-t} \\
& =\sum_{t=0}^{m} n^{t} \underbrace{\sum_{k=1}^{b} \sum_{r=t}^{m}(-1)^{r-t}\binom{r}{t} \mathbf{A}_{m, r} k^{2 r-t}}_{(-1)^{m-t} \mathbf{X}_{m, t}(b)}
\end{aligned}
$$

In above formula brace underlines $2 m+1-t$ degree polynomial $\mathbf{X}_{m, t}(j), m, t \in \mathbb{N}, j \in \mathbb{R}$ in $j$, see definition (1.1). From this formula it may be not immediately clear why $\mathbf{X}_{m, t}(j)$ represent polynomials in $j$. However, this can be seen if we change the summation order and
use Faulhaber's formula $\sum_{k=1}^{n} k^{p}=\frac{1}{p+1} \sum_{j=0}^{p}\binom{p+1}{j} B_{j} n^{p+1-j}$ to obtain

$$
\mathbf{X}_{m, t}(j)=(-1)^{m} \sum_{r=t}^{m}\binom{r}{t} \mathbf{A}_{m, r} \frac{(-1)^{r}}{2 r-t+1} \sum_{\ell=0}^{2 r-t}\binom{2 r-t+1}{\ell} B_{\ell} j^{2 r-t+1-\ell}
$$

Introducing $k=2 r-t+1-\ell$, we further get the formula

$$
\mathbf{X}_{m, t}(j)=(-1)^{m} \sum_{k=1}^{2 m-t+1} j^{k} \underbrace{\sum_{r=t}^{m}\binom{r}{t} \mathbf{A}_{m, r} \frac{(-1)^{r}}{2 r-t+1}\binom{2 r-t+1}{k} B_{2 r-t+1-k}}_{\mathbf{H}_{m, t}(k)}
$$

To produce examples of $\mathbf{X}_{m, t}(j)$ for $m=3$ let's type Column[Table[X[3, n, j], \{n, 0, 3\}], Left] into Mathematica console using [Kol19], we get further

$$
\begin{aligned}
& \mathbf{X}_{3,0}(j)=7 j^{2}-28 j^{3}+70 j^{5}-70 j^{6}+20 j^{7}, \\
& \mathbf{X}_{3,1}(j)=7 j-42 j^{2}+175 j^{4}-210 j^{5}+70 j^{6}, \\
& \mathbf{X}_{3,2}(j)=-14 j+140 j^{3}-210 j^{4}+84 j^{5}, \\
& \mathbf{X}_{3,3}(j)=35 j^{2}-70 j^{3}+35 j^{4}
\end{aligned}
$$

It gives us opportunity to review the $\mathbf{P}_{b}^{m}(n)$ from different prospective, for instance

$$
\begin{equation*}
\mathbf{P}_{b}^{m}(n)=\sum_{r=0}^{m}(-1)^{m-r} \mathbf{X}_{m, r}(b) \cdot n^{r}=\sum_{r=0}^{m} \sum_{\ell=1}^{2 m-r+1}(-1)^{2 m-r} \mathbf{H}_{m, r}(\ell) \cdot b^{\ell} \cdot n^{r} \tag{2.1}
\end{equation*}
$$

The last line of (2.1) clearly states why $\mathbf{P}_{b}^{m}(n)$ are polynomials in $b, n$. Let's show a few examples of polynomials $\mathbf{P}_{b}^{m}(n)$

$$
\begin{aligned}
\mathbf{P}_{b}^{0}(n) & =b \\
\mathbf{P}_{b}^{1}(n) & =3 b^{2}-2 b^{3}-3 b n+3 b^{2} n \\
\mathbf{P}_{b}^{2}(n) & =10 b^{3}-15 b^{4}+6 b^{5} \\
& -15 b^{2} n+30 b^{3} n-15 b^{4} n \\
& +5 b n^{2}-15 b^{2} n^{2}+10 b^{3} n^{2}, \\
\mathbf{P}_{b}^{3}(n) & =-7 b^{2}+28 b^{3}-70 b^{5}+70 b^{6}-20 b^{7} \\
& +7 b n-42 b^{2} n+175 b^{4} n-210 b^{5} n+70 b^{6} n \\
& +14 b n^{2}-140 b^{3} n^{2}+210 b^{4} n^{2}-84 b^{5} n^{2} \\
& +35 b^{2} n^{3}-70 b^{3} n^{3}+35 b^{4} n^{3}
\end{aligned}
$$

The following property also holds in terms of $\mathbf{P}_{b}^{m}(n)$
Property 2.2. For every $m, b, n \in \mathbb{N}$

$$
\mathbf{P}_{b+1}^{m}(n)=\mathbf{P}_{b}^{m}(n)+\mathbf{L}_{m}(n, b)
$$

We consider the polynomials $\mathbf{P}_{b}^{m}(n)$ since that basis on them we reveal the main aim of the work and establish a connection between the Binomial theorem and the discrete convolution of a power functions $\langle x\rangle^{n},\{x\}^{n}$. In the next section we show that odd binomial expansion $(x+y)^{2 m+1}, 2 m+1, m \geq 0$ is a partial case of $\mathbf{P}_{b}^{m}(n)$.

## 3. Odd Binomial expansion as partial case of polynomial $\mathbf{P}_{b}^{m}(n)$

An odd power function $n^{2 m+1}, n, m \in \mathbb{N}$ could be expressed in terms of partial case of polynomial $\mathbf{P}_{b}^{m}(n)$ as follows
Lemma 3.1. For each $n, m \in \mathbb{N}$

$$
\mathbf{P}_{n}^{m}(n) \equiv n^{2 m+1}
$$

By Lemma 3.1 and (2.1) the following identities straightforward

$$
n^{2 m+1}=\sum_{r=0}^{m} \sum_{\ell=1}^{2 m-r+1}(-1)^{2 m-r} \mathbf{H}_{m, r}(\ell) \cdot n^{\ell+r}=\sum_{r=0}^{m}(-1)^{m-r} \mathbf{X}_{m, r}(n) \cdot n^{r}
$$

By Property 2.1 an odd power $n^{2 m+1}+1, m, n \in \mathbb{N}$ can also be expressed as

$$
n^{2 m+1}+1=[n \text { is even }] \mathbf{L}_{m}(n, n / 2)+2 \sum_{k=0}^{\frac{n-1}{2}} \mathbf{L}_{m}(n, k),
$$

where [ $n$ is even] is Iverson's bracket (1.2). Moreover, the partial case of Lemma 3.1 for $n=x+y$ gives binomial expansion
Corollary 3.2. (Partial case of Lemma 3.1 for binomials.) For every $x+y, m \in \mathbb{N}$

$$
\mathbf{P}_{x+y}^{m}(x+y) \equiv \sum_{r=0}^{m}\binom{2 m+1}{r} x^{2 m-r} y^{r}
$$

For instance, for $m=2$ we have

$$
\mathbf{P}_{x+y}^{2}(x+y)=(x+y)\left(x^{4}+4 x^{3} y+6 x^{2} y^{2}+4 x y^{3}+y^{4}\right)
$$

which is binomial expansion of fifth power. In addition, the following power identities in terms of $\mathbf{H}_{m, r}(x), \mathbf{X}_{m, r}(x)$ are taking place

$$
\begin{aligned}
(x+y)^{2 m+1} & =\sum_{r=0}^{m} \sum_{\ell=1}^{2 m-r+1}(-1)^{2 m-r} \mathbf{H}_{m, r}(\ell) \cdot(x+y)^{\ell+r} \\
& =\sum_{r=0}^{m}(-1)^{m-r} \mathbf{X}_{m, r}(x+y) \cdot(x+y)^{r}
\end{aligned}
$$

It clearly follows that Multinomial expansion of odd-powered $t$-fold sum $\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{2 m+1}$ can be reached by $\mathbf{P}_{b}^{m}\left(x_{1}+x_{2}+\cdots+x_{t}\right)$ as well

Corollary 3.3. For all $x_{1}+x_{2}+\cdots+x_{t}, m \in \mathbb{N}$

$$
\mathbf{P}_{x_{1}+x_{2}+\cdots+x_{t}}^{m}\left(x_{1}+x_{2}+\cdots+x_{t}\right) \equiv \sum_{k_{1}+k_{2}+\cdots+k_{t}=2 m+1}\binom{2 m+1}{k_{1}, k_{2}, \ldots, k_{t}} \prod_{s=1}^{t} x_{t}^{k_{s}}
$$

Moreover, the following multinomial identities hold

$$
\begin{aligned}
\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{2 m+1} & =\sum_{r=0}^{m} \sum_{\ell=1}^{2 m-r+1}(-1)^{2 m-r} \mathbf{H}_{m, r}(\ell) \cdot\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{\ell+r} \\
& =\sum_{r=0}^{m}(-1)^{m-r} \mathbf{X}_{m, r}\left(x_{1}+x_{2}+\cdots+x_{t}\right) \cdot\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{r}
\end{aligned}
$$

## 4. Binomial expansion in terms of $\mathbf{P}_{b}^{m}(n)$ and Iverson's convention

In the previous section we have established a connection between the polynomial $\mathbf{P}_{b}^{m}(n)$ and an odd power function. To go over to the general case of a power function, we consider the relationship between an even and an odd powers, namely

$$
x^{\mathrm{even}}=x \cdot x^{\mathrm{odd}}
$$

Thus, a generalized power function $x^{s}, s \in \mathbb{N}$ can be expressed in terms of an odd power function and the Iverson's bracket as follows

Property 4.1. For every $x \in \mathbb{R}, s \in \mathbb{Z}$

$$
x^{s}=x^{[s \text { is even }]} \cdot x^{2\left\lfloor\frac{s-1}{2}\right\rfloor+1}
$$

Hereof, it is easy to obtain a power $x^{s}$ by means of partial case of $\mathbf{P}_{b}^{m}(n)$ for all $s \geq 1 \in \mathbb{N}$
Corollary 4.2. By Lemma 3.1 and Property 4.1, for every $x, s \geq 1 \in \mathbb{N}$

$$
x^{s}=x^{[s \text { is even }]} \mathbf{P}_{x}^{\frac{s-1}{2}}(x)
$$

Therefore, for every $x, s \geq 1 \in \mathbb{N}$ as well true

$$
\begin{aligned}
x^{s} & =\sum_{k=0}^{h} \sum_{\ell=1}^{2 h-k+1}(-1)^{2 h-k} \mathbf{H}_{h, k}(\ell) \cdot x^{[s \text { is even }]+\ell+k} \\
& =\sum_{k=0}^{h}(-1)^{h-k} \mathbf{X}_{h, k}(x) \cdot x^{[s \text { is even }]+k}
\end{aligned}
$$

where $h=\frac{s-1}{2}$ and [ $s$ is even] is Iverson's bracket. The binomial expansion of $(x+y)^{s}$ for every $s \geq 1 \in \mathbb{N}$ is
Corollary 4.3. By Corollary 3.2 and Property 4.1, for each $s \geq 1, x, y \in \mathbb{N}$

$$
(x+y)^{[s \text { is even }]} \mathbf{P}_{x+y}^{h}(x+y) \equiv \sum_{k \geq 0}\binom{s}{k} x^{s-k} y^{k},
$$

where $h=\frac{s-1}{2}$.
By Corollary 4.3

$$
\begin{aligned}
(x+y)^{s} & =\sum_{k=0}^{h} \sum_{\ell=1}^{2 h-k+1}(-1)^{2 h-k} \mathbf{H}_{h, k}(\ell) \cdot(x+y)^{[s \text { is even }]+\ell+k} \\
& =\sum_{k=0}^{h}(-1)^{h-k} \mathbf{X}_{h, k}(x+y) \cdot(x+y)^{[s \text { is even }]+k}
\end{aligned}
$$

where $h=\frac{s-1}{2}$. Now we are able to express the corollary 4.3 in terms of multinomials. For the $t$-fold $s$-powered sum $\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{s}$ we have following relation between Multinomial expansion and $\mathbf{P}_{x}^{h}(x)$

Corollary 4.4. For all $s \geq 1, x_{1}+x_{2}+\cdots+x_{t}, s \in \mathbb{N}$
$\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{[s \text { is even }]} \mathbf{P}_{x_{1}+x_{2}+\cdots+x_{t}}^{h}\left(x_{1}+x_{2}+\cdots+x_{t}\right) \equiv \sum_{k_{1}+k_{2}+\cdots+k_{t}=s}\binom{s}{k_{1}, k_{2}, \ldots, k_{t}} \prod_{\ell=1}^{t} x_{\ell}^{k_{\ell}}$,
where $h=\frac{s-1}{2}$.
Therefore, the following expression holds as well

$$
\begin{aligned}
\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{s} & =\sum_{k=0}^{h} \sum_{\ell=1}^{2 h-k+1}(-1)^{2 h-k} \mathbf{H}_{h, k}(\ell) \cdot\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{[s \text { is even }]+\ell+t} \\
& =\sum_{k=0}^{h}(-1)^{h-k} \mathbf{X}_{h, k}\left(x_{1}+x_{2}+\cdots+x_{t}\right) \cdot\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{[s \text { is even }]+k},
\end{aligned}
$$

where $h=\frac{s-1}{2}$.

## 5. Relation between $\mathbf{P}_{b}^{m}(n)$ and discrete convolution of power functions

$$
\langle x\rangle^{n},\{x\}^{n}
$$

Previously we have established the relations between polynomial $\mathbf{P}_{b}^{m}(n)$, Binomial and Multinomial theorems. In this section we establish and discuss a relation between $\mathbf{P}_{b}^{m}(n)$ and convolution of the power functions $\langle x\rangle^{n},\{x\}^{n}$. To show that $\mathbf{P}_{b}^{m}(n)$ implicitly involves the discrete convolution of the power function $\langle x\rangle^{n}$ let's remind that

$$
\mathbf{P}_{b}^{m}(n)=\sum_{r=0}^{m} \mathbf{A}_{m, r} \sum_{k=0}^{b-1} k^{r}(n-k)^{r}
$$

A discrete convolution of defined over set of integers $\mathbb{Z}$ function $f$ is following

$$
(f * f)[n]=\sum_{k} f(k) f(n-k)
$$

Now a general formula of discrete convolution $\langle x\rangle^{n} *\langle x\rangle^{n}$ could be derived immediately

$$
\begin{aligned}
\langle x-a\rangle^{n} *\langle x-a\rangle^{n} & =\sum_{k}\langle k-a\rangle^{n}\langle x-k-a\rangle^{n} \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[k \geq a][x-k \geq a] \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[k \geq a][k \leq x-a] \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[a \leq k \leq x-a] \\
& =\sum_{k=a}^{x-a}(k-a)^{n}(x-k-a)^{n},
\end{aligned}
$$

where $[a \leq k \leq x-a]$ is Iverson's bracket of $k$. Note that $a$ is parameter of $\langle x-a\rangle^{r}$ by definition (1.3). In above equation we have applied a Knuth's recommendation [Knu92] concerning the sigma notation of sums. Thus, we have a general expression of discrete convolution $\langle x\rangle^{n} *\langle x\rangle^{n}$. For now, let's notice that

Lemma 5.1. For every $x \geq 1, x \in \mathbb{N}$

$$
\langle x\rangle^{n} *\langle x\rangle^{n} \equiv \sum_{k=0}^{x} k^{r}(n-k)^{r}
$$

Thus,
Corollary 5.2. By Lemma 5.1, the polynomials $\mathbf{P}_{b}^{m}(n)$ is in relation with discrete convolution of power function $\langle x\rangle^{n} *\langle x\rangle^{n}$ as follows

$$
\mathbf{P}_{x+1}^{m}(x)=\sum_{r=0}^{m} \mathbf{A}_{m, r}\langle x\rangle^{r} *\langle x\rangle^{r}
$$

Therefore, another conclusion follows
Theorem 5.3. By Lemma 3.1, Corollary 5.2 and property 2.2, for every $x \geq 1, x, m \in \mathbb{N}$

$$
x^{2 m+1}=-1+\sum_{r=0}^{m} \mathbf{A}_{m, r}\langle x\rangle^{r} *\langle x\rangle^{r}
$$

As next step, let's show a relation between discrete convolution of $\{x\}^{n}$ and power function of odd exponent. Discrete convolution $\{x-a\}^{n} *\{x-a\}^{n}$ is following

$$
\begin{aligned}
\{x-a\}^{n} *\{x-a\}^{n} & =\sum_{k}\{k-a\}^{n}\{x-k-a\}^{n} \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[k>a][x-k>a] \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[a<k<x-a] \\
& =\sum_{k}(k-a)^{n}(x-k-a)^{n}[a+1 \leq k \leq x-a-1] \\
& =\sum_{k=a+1}^{x-a-1}(k-a)^{n}(x-k-a)^{n}
\end{aligned}
$$

Now we notice the following identity in terms of polynomial $\mathbf{P}_{b}^{m}(n)$ and discrete convolution $\{x\}^{n} *\{x\}^{n}$
Proposition 5.4. For every $m, b, n \in \mathbb{N}$

$$
\begin{aligned}
\mathbf{P}_{x}^{m}(x) & =\sum_{r=0}^{m} \mathbf{A}_{m, r}\left(0^{r} x^{r}+\sum_{k=1}^{x-1} k^{r}(x-k)^{r}\right) \\
& =\sum_{r=0}^{m} \mathbf{A}_{m, r} 0^{r} x^{r}+\sum_{r=0}^{m} \mathbf{A}_{m, r}\{x\}^{r} *\{x\}^{r}
\end{aligned}
$$

Since that for all $r$ in $\mathbf{A}_{m, r} 0^{r} x^{r}$ we have

$$
\mathbf{A}_{m, r} 0^{r} x^{r}= \begin{cases}1, & \text { if } r=0 \\ 0, & \text { if } r>0\end{cases}
$$

Above is true because $\mathbf{A}_{m, 0}=1$ for every $m \in \mathbb{N}$, it is convinced [GKP94] that $x^{0}=1$ for every $x$. Hence, the following identity between $\mathbf{P}_{b}^{m}(n)$ and discrete convolution $\{x\}^{n} *\{x\}^{n}$ holds

Theorem 5.5. By Lemma 3.1 and Proposition 5.4, for every $x \geq 1, x, m \in \mathbb{N}$

$$
x^{2 m+1}=1+\sum_{r=0}^{m} \mathbf{A}_{m, r}\{x\}^{r} *\{x\}^{r}
$$

Corollary 5.6. By Theorem 5.5, for all $m \in \mathbb{N}$

$$
\sum_{r=0}^{m} \mathbf{A}_{m, r}=2^{2 m+1}-1
$$

Corollary 5.6 holds since that convolution $\{x\}^{r} *\{x\}^{r}=1$ for each $r$ when $x=2$. Furthermore, we are able to find a relation between the Binomial theorem and discrete convolution of power function $\langle x\rangle^{n}$.
6. Binomial expansion in terms of discrete convolutions of power function $\langle x\rangle^{n},\{x\}^{n}$
The equivalence (4.3) states the relation between Binomial theorem and partial case of $\mathbf{P}_{b}^{m}(n)$. As it is stated previously in Corollary 5.2 and Proposition 5.4, the polynomials $\mathbf{P}_{b}^{m}(n)$ are able to be expressed in terms of discrete convolutions $\langle x\rangle^{n} *\langle x\rangle^{n},\{x\}^{n} *\{x\}^{n}$. In this section we generalize these results in order to show relation between Binomial, Multinomial theorems and discrete convolutions $\langle x\rangle^{n} *\langle x\rangle^{n},\{x\}^{n} *\{x\}^{n}$

Corollary 6.1. (Partial case of Theorem 5.3 for Binomials.) For each $x+y \geq 1, x, y, m \in \mathbb{N}$

$$
\sum_{r=0}^{m} \mathbf{A}_{m, r}\langle x+y\rangle^{r} *\langle x+y\rangle^{r} \equiv 1+\sum_{r=0}^{2 m+1}\binom{2 m+1}{r} x^{2 m+1-r} y^{r}
$$

For example, for $m=0,1,2$ the Corollary 6.1 gives

$$
\begin{aligned}
\sum_{r=0}^{0} \mathbf{A}_{0, r}\langle x+y\rangle^{r} *\langle x+y\rangle^{r} & =1+x+y \\
\sum_{r=0}^{1} \mathbf{A}_{1, r}\langle x+y\rangle^{r} *\langle x+y\rangle^{r} & =1+x+y+(-1+x+3 y-2 y)(x+y)(1+x+y) \\
& =x^{3}+3 x^{2} y+3 x y^{2}+y^{3}+1 \\
\sum_{r=0}^{2} \mathbf{A}_{2, r}\langle x+y\rangle^{r} *\langle x+y\rangle^{r} & =1+x+y+(x+y)(1+x+y)\left(-1+x+5 x^{2}+y+10 x y+5 y^{2}\right. \\
& -15 x(x+y)+10 x^{2}(x+y)-15 y(x+y)+20 x y(x+y) \\
& +10 y^{2}(x+y)+9(x+y)^{2}-15 x(x+y)^{2} \\
& \left.-15 y(x+y)^{2}+6(x+y)^{3}\right) \\
& =x^{5}+5 x^{4} y+10 x^{3} y^{2}+10 x^{2} y^{3}+5 x y^{4}+y^{5}+1
\end{aligned}
$$

To get above examples we were using command Simplify[Sum/CoeffA[1, r] * MacaulayDiscConv[x $+y, r, 0],\{r, 0,1\}]$, Element[x, Integers], Assumptions $->x+y>0]$ in Mathematica console by [Kol19].

Corollary 6.2. (Partial case of Theorem 5.5 for Binomials.) For each $x+y \geq 1, x, y, m \in \mathbb{N}$

$$
\sum_{r=0}^{m} \mathbf{A}_{m, r}\{x+y\}^{r} *\{x+y\}^{r} \equiv-1+\sum_{r=0}^{2 m+1}\binom{2 m+1}{r} x^{2 m+1-r} y^{r}
$$

For example, for $m=0,1$ the Corollary 6.2 gives

$$
\begin{aligned}
\sum_{r=0}^{0} \mathbf{A}_{0, r}\{x+y\}^{r} *\{x+y\}^{r} & =x+y-1 \\
\sum_{r=0}^{1} \mathbf{A}_{1, r}\{x+y\}^{r} *\{x+y\}^{r} & =x+y-1-(x+y-1)(x+y)(2(x+y)-1-3 x-3 y) \\
& =x^{3}+3 x^{2} y+3 x y^{2}+y^{3}-1
\end{aligned}
$$

In case of variations of $a$ in $\langle x-a\rangle^{n}$ and $\{x-a\}^{n}$ for each $x \geq 2 a, a=$ const, $a \in \mathbb{Z}, m \in \mathbb{N}$ the following identities hold

$$
\begin{aligned}
& (x-2 a)^{2 m+1}+1=\sum_{r=0}^{m} \mathbf{A}_{m, r}\langle x-a\rangle^{r} *\langle x-a\rangle^{r} \\
& (x-2 a)^{2 m+1}-1=\sum_{r=0}^{m} \mathbf{A}_{m, r}\{x-a\}^{r} *\{x-a\}^{r}
\end{aligned}
$$

Note that $a$ is parameter of $\langle x-a\rangle^{r},\{x-a\}^{r}$ by definitions (1.3), (1.4). By Corollary 6.1 and Property 4.1, for each $s, x, y \in \mathbb{N}$

$$
(x+y)^{[s \text { is even }]}\left(-1+\sum_{r=0}^{h} \mathbf{A}_{h, r}\langle x+y\rangle^{r} *\langle x+y\rangle^{r}\right) \equiv \sum_{k=0}^{s}\binom{s}{k} x^{s-k} y^{k}
$$

where $h=\frac{s-1}{2}$. In terms of convolution $\{x\}^{n} *\{x\}^{n}$ for $s \geq 1, x+y \geq 2$ we also have the following relation. By Corollary 6.2 and Property 4.1, for each $s, x, y \in \mathbb{N}$

$$
(x+y)^{[s \text { is even }]}\left(1+\sum_{r=0}^{h} \mathbf{A}_{h, r}\{x+y\}^{r} *\{x+y\}^{r}\right) \equiv \sum_{k=0}^{s}\binom{s}{k} x^{s-k} y^{k}
$$

where $h=\frac{s-1}{2}$.
6.1. Generalisation for Multinomial case. In this section we'd like to discus the multinomial cases of Theorems 5.3, 5.5. We have the following relation involving Multinomial expansion and discrete convolution of power function $\langle x\rangle^{n}$

Corollary 6.3. (Partial case of Theorem 5.3 for Multinomials.) For each $x_{1}+x_{2}+\cdots+x_{t} \geq$ $1, x_{1}, x_{2}, \ldots, x_{t}, m \in \mathbb{N}$

$$
\begin{array}{r}
\sum_{r=0}^{m} \mathbf{A}_{m, r}\left\langle x_{1}+x_{2}+\cdots+x_{t}\right\rangle^{r} *\left\langle x_{1}+x_{2}+\cdots+x_{t}\right\rangle^{r} \\
\equiv 1+\sum_{k_{1}+k_{2}+\cdots+k_{t}=2 m+1}\binom{2 m+1}{k_{1}, k_{2}, \ldots, k_{t}} \prod_{\ell=1}^{t} x_{\ell}^{k_{\ell}}
\end{array}
$$

For instance, for $m=1$ and trinomials the corollary 6.3 gives

$$
\begin{aligned}
& \sum_{r=0}^{1} \mathbf{A}_{1, r}\langle x+y+z\rangle^{r} *\langle x+y+z\rangle^{r} \\
& =1+x+y+z-(x+y+z)(1+x+y+z)(1-3 x-3 y-3 z+2(x+y+z)) \\
& =1+x^{3}+3 x^{2} y+3 x y^{2}+y^{3}+3 x^{2} z+6 x y z+3 y^{2} z+3 x z^{2}+3 y z^{2}+z^{3}
\end{aligned}
$$

Corollary 6.4. (Partial case of Theorem 5.5 for Multinomials.) For each $x_{1}+x_{2}+\cdots+x_{t} \geq$ $1, x_{1}, x_{2}, \ldots, x_{t}, m \in \mathbb{N}$

$$
\begin{gathered}
\sum_{r=0}^{m} \mathbf{A}_{m, r}\left\{x_{1}+x_{2}+\cdots+x_{t}\right\}^{r} *\left\{x_{1}+x_{2}+\cdots+x_{t}\right\}^{r} \\
\equiv-1+\sum_{k_{1}+k_{2}+\cdots+k_{t}=2 m+1}\binom{2 m+1}{k_{1}, k_{2}, \ldots, k_{t}} \prod_{\ell=1}^{t} x_{\ell}^{k_{\ell}}
\end{gathered}
$$

For example, for $m=1$ and trinomials the Corollary 6.4 gives

$$
\begin{aligned}
& \sum_{r=0}^{1} \mathbf{A}_{1, r}\langle x+y+z\rangle^{r} *\langle x+y+z\rangle^{r} \\
& =x+y+z-1-(x+y+z-1)(x+y+z)(2(x+y+z)-1-3 x-3 y-3 z) \\
& =x^{3}+3 x^{2} y+3 x y^{2}+y^{3}+3 x^{2} z+6 x y z+3 y^{2} z+3 x z^{2}+3 y z^{2}+z^{3}-1
\end{aligned}
$$

By Corollary 6.3, Corollary 6.4 and Property 4.1, for every $x_{1}+x_{2}+\cdots+x_{t} \geq 1, m \in \mathbb{N}$ the following relation between discrete convolutions and Multinomial expansion holds

$$
\begin{aligned}
& \left(x_{1}+x_{2}+\cdots+x_{t}\right)^{s} \\
& =\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{[s \text { is even }]}\left(-1+\sum_{k=0}^{h} \mathbf{A}_{h, k}\left\langle x_{1}+x_{2}+\cdots+x_{t}\right\rangle^{k} *\left\langle x_{1}+x_{2}+\cdots+x_{t}\right\rangle^{k}\right) \\
& =\left(x_{1}+x_{2}+\cdots+x_{t}\right)^{[s \text { is even }]}\left(1+\sum_{k=0}^{h} \mathbf{A}_{h, k}\left\{x_{1}+x_{2}+\cdots+x_{t}\right\}^{k} *\left\{x_{1}+x_{2}+\cdots+x_{t}\right\}^{k}\right) \\
& \equiv \sum_{k_{1}+k_{2}+\cdots+k_{t}=s}\binom{s}{k_{1}, k_{2}, \ldots, k_{t}} \prod_{\ell=1}^{t} x_{\ell}^{k_{\ell}},
\end{aligned}
$$

where $h=\frac{s-1}{2}$.

Let be a matrices

\alpha_{1,0} & \alpha_{1,0} & \cdots & \alpha_{1, j} \\
\alpha_{2,0} & \alpha_{2,0} & \cdots & \alpha_{2, j} \\
\vdots & & & \\
\alpha_{i, 0} & \alpha_{i, 0} & \cdots & \alpha_{i, j}
\end{array}\right] \in \mathbb{N}^{i \times j}
\end{gathered}
$$

where $\alpha_{i, j}=i^{j}(n-i)^{j}$.

$$
\mathcal{C}_{m}=\left[\begin{array}{c}
\mathbf{A}_{m, 0} \\
\mathbf{A}_{m, 1} \\
\vdots \\
\mathbf{A}_{m, m}
\end{array}\right] \in \mathbb{R}^{m \times 1}
$$

Therefore, by Lemma 3.1, the following identity is true

$$
x^{2 m+1}=\mathcal{A}_{m} \times \mathcal{B}_{m, x}(x) \times \mathcal{C}_{m}
$$

For example,

$$
4^{2 \cdot 3+1}=[1,1,1,1] \cdot\left[\begin{array}{cccc}
3^{0} & 3^{1} & 3^{2} & 3^{3} \\
4^{0} & 4^{1} & 4^{2} & 4^{3} \\
3^{0} & 3^{1} & 3^{2} & 3^{3} \\
0^{0} & 0^{1} & 0^{2} & 0^{3}
\end{array}\right] \cdot\left[\begin{array}{c}
1 \\
-14 \\
0 \\
140
\end{array}\right]
$$

## 8. Derivation of coefficients $\mathbf{A}_{m, r}$

By Lemma 3.1 for every $m \geq 0 \in \mathbb{N}$

$$
n^{2 m+1}=\mathbf{P}_{n}^{m}(n)=\sum_{r=0}^{m} \mathbf{A}_{m, r} \sum_{k=0}^{n-1} k^{r}(n-k)^{r}
$$

The coefficients $\mathbf{A}_{m, r}$ could be evaluated using the binomial expansion of $\sum_{k=0}^{n-1} k^{r}(n-k)^{r}$

$$
\sum_{k=0}^{n-1} k^{r}(n-k)^{r}=\sum_{k=0}^{n-1} k^{r} \sum_{j=0}^{r}(-1)^{j}\binom{r}{j} n^{r-j} k^{j}=\sum_{j=0}^{r}(-1)^{j}\binom{r}{j} n^{r-j} \sum_{k=0}^{n-1} k^{r+j}
$$

Using Faulhaber's formula $\sum_{k=1}^{n} k^{p}=\frac{1}{p+1} \sum_{j=0}^{p}\binom{p+1}{j} B_{j} n^{p+1-j}$ we get

$$
\begin{align*}
\sum_{k=0}^{n-1} k^{r}(n-k)^{r} & =\sum_{j=0}^{r}\binom{r}{j} n^{r-j} \frac{(-1)^{j}}{r+j+1}\left[\sum_{s}\binom{r+j+1}{s} B_{s} n^{r+j+1-s}-B_{r+j+1}\right] \\
& =\sum_{j, s}\binom{r}{j} \frac{(-1)^{j}}{r+j+1}\binom{r+j+1}{s} B_{s} n^{2 r+1-s}-\sum_{j}\binom{r}{j} \frac{(-1)^{j}}{r+j+1} B_{r+j+1} n^{r-j} \\
& =\sum_{s} \underbrace{\sum_{j}\binom{r}{j} \frac{(-1)^{j}}{r+j+1}\binom{r+j+1}{s}}_{S(r)} B_{s} n^{2 r+1-s} \\
& -\sum_{j}\binom{r}{j} \frac{(-1)^{j}}{r+j+1} B_{r+j+1} n^{r-j} \tag{8.1}
\end{align*}
$$

where $B_{s}$ are Bernoulli numbers and $B_{1}=\frac{1}{2}$. Now, we notice that

$$
S(r)=\sum_{j}\binom{r}{j} \frac{(-1)^{j}}{r+j+1}\binom{r+j+1}{s}=\left\{\begin{array}{cl}
\frac{1}{(2 r+1)\left({ }_{2}^{2 r}\right)}, & \text { if } s=0 \\
\frac{(-1)^{r}}{s}\binom{r}{2 r-s+1}, & \text { if } s>0
\end{array}\right.
$$

In particular, the last sum is zero for $0<s \leq r$. Therefore, expression (8.1) takes the form

$$
\begin{aligned}
\sum_{k=0}^{n-1} k^{r}(n-k)^{r} & =\frac{1}{(2 r+1)\left(2_{r}^{2 r}\right)} n^{2 r+1}+\underbrace{\sum_{s \geq 1} \frac{(-1)^{r}}{s}\binom{r}{2 r-s+1} B_{s} n^{2 r+1-s}}_{(\star)} \\
& -\underbrace{\sum_{j}\binom{r}{j} \frac{(-1)^{j}}{r+j+1} B_{r+j+1} n^{r-j}}_{(\diamond)}
\end{aligned}
$$

Hence, introducing $\ell=2 r+1-s$ to $(\star)$ and $\ell=r-j$ to $(\diamond)$, we get

\sum_{k=0}^{n-1} k^{r}(n-k)^{r} & =\frac{1}{(2 r+1)\binom{2 r}{r}} n^{2 r+1}+\sum_{\ell=2 r+1-s} \frac{(-1)^{r}}{2 r+1-\ell}\binom{r}{\ell} B_{2 r+1-\ell} n^{\ell} \\
& -\sum_{\ell=r-j}\binom{r}{\ell} \frac{(-1)^{j-\ell}}{2 r+1-\ell} B_{2 r+1-\ell} n^{\ell}
\end{aligned}
$$

Since that $j-\ell=j-(r-j)=2 j-r$

$$
\begin{aligned}
\sum_{k=0}^{n-1} k^{r}(n-k)^{r} & =\frac{1}{(2 r+1)\binom{2 r}{r}} n^{2 r+1}+(-1)^{r} \sum_{\ell=2 r+1-s} \frac{1}{2 r+1-\ell}\binom{r}{\ell} B_{2 r+1-\ell} n^{\ell} \\
& -\frac{1}{(-1)^{r}} \sum_{\ell=r-j}\binom{r}{\ell} \frac{(-1)^{2 j}}{2 r+1-\ell} B_{2 r+1-\ell} n^{\ell} \\
& =\frac{1}{(2 r+1)\binom{2 r}{r}} n^{2 r+1}+2 \sum_{\text {odd } \ell=1,3, \ldots}^{r} \frac{(-1)^{r}}{2 r+1-\ell}\binom{r}{\ell} B_{2 r+1-\ell} n^{\ell}
\end{aligned}
$$

Using the definition of $\mathbf{A}_{m, r}$ coefficients, we obtain the following identity for polynomials in $n$

$$
\begin{equation*}
\sum_{r=0}^{m} \mathbf{A}_{m, r} \frac{1}{(2 r+1)\binom{2 r}{r}} n^{2 r+1}+2 \sum_{r=0}^{m} \sum_{\text {odd } \ell=1,3, \ldots}^{r} \mathbf{A}_{m, r} \frac{(-1)^{r}}{2 r+1-\ell}\binom{r}{\ell} B_{2 r+1-\ell} n^{\ell} \equiv n^{2 m+1} \tag{8.2}
\end{equation*}
$$

Taking the coefficient of $n^{2 r+1}$ for $r=m$ in (8.2) we get $\mathbf{A}_{m, m}=(2 m+1)\binom{2 m}{m}$. Since that odd $\ell \leq r$ in explicit form is $2 j+1 \leq r$, it follows that $j \leq \frac{m-1}{2}$, where $j$ is iterator. Therefore, taking the coefficient of $n^{2 j+1}$ for an integer $j$ in the range $\frac{m}{2} \leq j \leq m$, we get $\mathbf{A}_{m, j}=0$. Taking the coefficient of $n^{2 d+1}$ for $d$ in the range $m / 4 \leq d<m / 2$ we get

$$
\mathbf{A}_{m, d} \frac{1}{(2 d+1)\binom{2 d}{d}}+2(2 m+1)\binom{2 m}{m}\binom{m}{2 d+1} \frac{(-1)^{m}}{2 m-2 d} B_{2 m-2 d}=0
$$

i.e

$$
\mathbf{A}_{m, d}=(-1)^{m-1} \frac{(2 m+1)!}{d!d!m!(m-2 d-1)!} \frac{1}{m-d} B_{2 m-2 d}
$$

Continue similarly we can express $\mathbf{A}_{m, r}$ for each integer $r$ in range $m / 2^{s+1} \leq r<m / 2^{s}$ (iterating consecutively $s=1,2 \ldots$ ) via previously determined values of $\mathbf{A}_{m, d}$ as follows

$$
\mathbf{A}_{m, r}=(2 r+1)\binom{2 r}{r} \sum_{d=2 r+1}^{m} \mathbf{A}_{m, d}\binom{d}{2 r+1} \frac{(-1)^{d-1}}{d-r} B_{2 d-2 r}
$$

## 9. Verification of the results and examples

To fulfill our study we provide an opportunity to verify its results by means of Wolfram Mathematica language. It is possible to verify the most important results of the manuscript using the Mathematica programs available at github repository arXiv1603.02468 Mathematica Implementatio Also, we'd like to show why an odd-power identity, namely Lemma 3.1 holds by a few examples. We arrange in tables the values of $\mathbf{L}_{m}(n, k)$ to show that $\mathbf{P}_{n}^{m}(n)=$ $\mathbf{L}_{m}(n, 0)+\mathbf{L}_{m}(n, 1)+\cdots+\mathbf{L}_{m}(n, n-1)=n^{2 m+1}$. For example, for $m=1$ we have the following values of $\mathbf{L}_{1}(n, k)$

From Table 3 it is seen that

$$
\begin{aligned}
& \mathbf{P}_{0}^{1}(0)=0=0^{3} \\
& \mathbf{P}_{1}^{1}(1)=1=1^{3} \\
& \mathbf{P}_{2}^{1}(2)=1+7=2^{3} \\
& \mathbf{P}_{3}^{1}(3)=1+13+13=3^{3} \\
& \mathbf{P}_{4}^{1}(4)=1+19+25+19=4^{3} \\
& \mathbf{P}_{5}^{1}(5)=1+25+37+37+25=5^{3}
\end{aligned}
$$

Another case, for $m=2$ we have the following values of $\mathbf{L}_{2}(n, k)$

| 6 | 1 | 751 | 1921 | 2431 | 1921 | 751 | 1 |  |

Again, an odd-power identity 3.1 holds

$$
\begin{aligned}
& \mathbf{P}_{0}^{2}(0)=0=0^{5} \\
& \mathbf{P}_{1}^{2}(1)=1=1^{5} \\
& \mathbf{P}_{2}^{2}(2)=1+31=2^{5} \\
& \mathbf{P}_{3}^{2}(3)=1+121+121=3^{5} \\
& \mathbf{P}_{4}^{2}(4)=1+271+481+271=4^{5} \\
& \mathbf{P}_{5}^{2}(5)=1+481+1081+1081+481=5^{5}
\end{aligned}
$$

## 11. Conclusion

In this manuscript we have discussed and the $2 m+1$-degree integer valued polynomials $\mathbf{P}_{b}^{m}(n)$. Basing on $\mathbf{P}_{b}^{m}(n)$ we established a relation between Binomial theorem and discrete convolution of power function. Also, it is shown that odd binomial expansion is partial case of $\mathbf{P}_{b}^{m}(n)$.
