# The class of the affine line is a zero divisor in the Grothendieck ring: an improvement

#### Abstract

Lev A. Borisov has shown that the class of the affine line is a zero divisor in the Grothendieck ring of algebraic varieties over complex numbers. We improve the final formula by removing a factor.


## Résumé

Lev A. Borisov a prouvé que la classe de la droite affine est un diviseur de zéro dans l'anneau de Grothendieck des variétés algébriques complexes. Nous améliorons la formule finale en supprimant un facteur.

## 1. Introduction

The Grothendieck ring $K_{0}\left(\operatorname{Var}_{\mathbb{C}}\right)$ of complex algebraic varieties is defined as the quotient of the free abelian group generated by the isomorphism classes $[X]$ of complex algebraic varieties modulo the relations

$$
[X]=[Y]+[X \backslash Y]
$$

for all closed subvarieties $Y \subset X$. The cartesian product of varieties gives the product structure.

[^0]The class $\mathbb{L}=\left[\mathbb{A}^{1}(\mathbb{C})\right]$ of the affine line has a major role in the study of the Grothendieck ring. It has been proved in [LL03] that $X$ and $Y$ are stably birational if and only if their classes $[X]$ and $[Y]$ are equal modulo $\mathbb{L}$. After Bjorn Poonen had shown in $[\mathrm{Poo} 02]$ that $K_{0}\left(\operatorname{Var}_{\mathbb{C}}\right)$ is not a domain, Lev Borisov has made precise this result in [Bor14] by showing that $\mathbb{L}$ is a zero divisor. He has compared the two sides [ $X_{W}$ ] and $\left[Y_{W}\right]$ of the Pfaffian-Grassmannian double mirror correspondence, and obtained the following formula:

$$
\left(\left[X_{W}\right]-\left[Y_{W}\right]\right) \cdot\left(\mathbb{L}^{2}-1\right) \cdot(\mathbb{L}-1) \cdot \mathbb{L}^{7}=0
$$

This result is not only an improvement of that of Poonen: it is crucial in motivic integration to understand the kernel of the localization morphism $K_{0}\left(\operatorname{Var}_{\mathbb{C}}\right) \rightarrow K_{0}\left(\operatorname{Var}_{\mathbb{C}}\right)\left[\mathbb{L}^{-1}\right]$, since we consider classes in the localized ring. In this paper, we improve this formula as follows.

Theorem $1.1\left(\left[X_{W}\right]-\left[Y_{W}\right]\right) \cdot \mathbb{L}^{6}=0$

## 2. The class of Grasmannians

Proposition 2.1 For $2 \leq k<n$, we have the relation

$$
[G(k, n)]=[G(k, n-1)]+\mathbb{L}^{n-k} \cdot[G(k-1, n-1)] .
$$

Proof. Let $e_{1}, \ldots, e_{n}$ be the canonical basis of $\mathbb{C}^{n}, F$ the hyperplane orthogonal to $e_{n}, U \subset G(k, n)$ the open subset defined by $\{T \in G(k, n) \mid \operatorname{dim}(T \cap F)=k-1\}$ and $\pi: U \rightarrow G(k-1, F)$ the regular mapping which sends $T$ on $T \cap F$. For $S \in G(k-1, F)$, the fiber $\pi^{-1}(S)$ can be identified to

$$
\mathbb{P}\left(\mathbb{C}^{n} / S\right) \backslash \mathbb{P}(F / S) \simeq \mathbb{A}^{n-k}
$$

Let $H$ be a complementary subspace of $S$ in $F$ and the open subset $V=\left\{S^{\prime} \in G(k-1, F) \mid S^{\prime} \oplus H=F\right\}$. For all $S^{\prime} \in V$, we have the identification $\mathbb{C}^{n} / S^{\prime} \simeq H \oplus \mathbb{C} e_{n}$, hence $\pi$ is a trivial fibration over $V$. Consequently, $\pi$ is a locally trivial fibration, therefore $[U]=\mathbb{L}^{n-k} \cdot[G(k-1, n-1)]$. We have $[G(k, n)]=$ $[Z]+[U]$ with $Z=G(k, n) \backslash U=\{T \in G(k, n) \mid T \subset F\}=G(k, F)$, which shows the announced formula.

A simple induction gives the following formulas for $n \geq 4$ :

$$
[G(2, n)]=\left\{\begin{array}{l}
{\left[\mathbb{P}^{n-2}\right] \cdot \sum_{k=0}^{(n-2) / 2} \mathbb{L}^{2 k} \text { if } n \text { is even }} \\
{\left[\mathbb{P}^{n-1}\right] \cdot \sum_{k=0}^{(n-3) / 2} \mathbb{L}^{2 k} \text { if } n \text { is odd }}
\end{array}\right.
$$

For example, $[G(2,5)]=\left[\mathbb{P}^{4}\right] \cdot\left(\mathbb{L}^{2}+1\right)$ and $[G(2,7)]=\left[\mathbb{P}^{6}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)$.

## 3. Improvement of Borisov's formula

### 3.1. Pfaffian and Grassmannian double mirror varieties

Let $V$ be a 7 -dimensional complex vector space and $W$ a generic 7-dimensional space of skew forms on $V$. We define $X_{W}$ as a subvariety of the Grassmannian $G(2, V)$ which is the locus of all $T \in G(2, V)$ with $\omega_{\mid T}=0$ for all $\omega \in W$, and $Y_{W}$ as a subvariety of $\mathbb{P} W$ of skew forms whose rank is less than 6 . Smoothness of these two varieties has been shown by E. Rødland in [Rød00]. Furthermore, we know that all forms in $Y_{W}$ have rank 4 and all forms in $\mathbb{P} W \backslash Y_{W}$ have rank 6 .

### 3.2. The formula

Let us define $H$ as a subvariety of $G(2, V) \times \mathbb{P} W$ which consists of pairs $(T, \mathbb{C} \omega)$ with $\omega_{\mid T}=0$. In order to obtain the explicit equations which define $H$, let us set $T_{0} \in G(2, V)$ with basis $e_{1}, e_{2}$ and $H$ a complementary subspace with basis $e_{3}, \ldots, e_{7}$. The neighborhood $U=\{T \in G(2, V) \mid T \oplus H=V\}$ of $T_{0}$ can be identified to $\mathscr{L}\left(T_{0}, H\right)$ by considering the map $f \in \mathscr{L}\left(T_{0}, H\right) \mapsto\left\{x+f(x) \mid x \in T_{0}\right\} \in U$. If we set $\left(f_{i, j}\right)_{(i, j) \in\{1,2\} \times\{3, \ldots, 7\}}$ the basis of $\mathscr{L}\left(T_{0}, H\right)$ adapted to the two bases previously considered, we can identify $T \in U$ to $\left\{x+\sum \alpha_{i, j} f_{i, j}(x) \mid x \in T_{0}\right\}$. Now, for $\omega=\sum_{i=1}^{7} \beta_{i} \omega_{i} \in W$, the condition $\omega_{\mid T}=0$ can be expressed as

$$
\sum_{i=1}^{7} \beta_{i} \omega_{i}\left(e_{1}+\sum_{j=3}^{7} \alpha_{1, j} e_{j}, e_{2}+\sum_{j=3}^{7} \alpha_{2, j} e_{j}\right)=0
$$

Looking at the projections onto the two factors $G(2, V)$ and $\mathbb{P} W$ will give us two ways to express $[H]$. Theorem 1.1 will be a direct consequence of the two next propositions.

Proposition $3.1[H]=\left[\mathbb{P}^{6}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right) \cdot\left[\mathbb{P}^{5}\right]+\left[X_{W}\right] \cdot \mathbb{L}^{6}$
Proof. Considering the projection $p: H \rightarrow G(2, V)$ onto the first factor, which is a trivial fibration in restriction to $p^{-1}\left(X_{W}\right)$ and a locally trivial fibration in restriction to $G(2, V) \backslash p^{-1}\left(X_{W}\right)$, Proposition 2.4 of [Bor14] proves that

$$
[H]=[G(2,7)] \cdot\left[\mathbb{P}^{5}\right]+\left[X_{W}\right] \cdot \mathbb{L}^{6}
$$

The expression $[G(2,7)]=\left[\mathbb{P}^{6}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)$ gives the result.
Proposition $3.2[H]=\left[Y_{W}\right] \cdot \mathbb{L}^{6}+\left[\mathbb{P}^{6}\right] \cdot\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)$
Lemma 3.3 Let $\pi: H \rightarrow \mathbb{P} W$ be the projection onto the second factor. Its restrictions to $\pi^{-1}\left(Y_{W}\right)$ and $\pi^{-1}\left(\mathbb{P} W \backslash Y_{W}\right)$ are piecewise trivial fibrations (see 4.2.1 in [Seb04]).

Proof of the lemma. The reasoning is the same for rank $4\left(Y_{4}=Y_{W}\right)$ and rank $6\left(Y_{6}=\mathbb{P} W \backslash Y_{W}\right)$. For $i \in\{4,6\}$, let us set

$$
Z_{i}=\pi^{-1}\left(Y_{i}\right)=H \cap\left(G(2, V) \times Y_{i}\right)
$$

In order to have piecewise triviality of $\pi$ on $Z_{i}$, it suffices, according to Theorem 4.2.3 in [Seb04], to prove that there exists a uniform fiber $F_{i}$ such that for all $x \in Y_{i}$,

$$
Z_{i} \times_{Y_{i}}\{x\} \simeq F_{i} \times_{\mathbb{C}} \operatorname{Spec}(\kappa(x)) .
$$

To achieve this, it suffices to note that a skew form of rank 4 or 6 with coefficients in a field $K \supset \mathbb{C}$ is congruent to the skew form

$$
\left(\begin{array}{rrr}
0 & I_{2} & 0 \\
-I_{2} & 0 & 0 \\
0 & 0 & 0
\end{array}\right) \quad \text { or } \quad\left(\begin{array}{rrr}
0 & I_{3} & 0 \\
-I_{3} & 0 & 0 \\
0 & 0 & 0
\end{array}\right)
$$

with a base change having coefficients in $K$, an action that spreads on fibers.
Lemma 3.4 Let $\mathbb{C} \omega \in Y_{W}$ be a closed point. Then the class of its fiber is

$$
\left[\pi^{-1}(\mathbb{C} \omega)\right]=\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)+\mathbb{L}^{6} .
$$

Proof. As $\operatorname{rk}(\omega)=4$, there exists a basis $e_{1}, \ldots, e_{7}$ of $V$ in which the matrix of $\omega$ is

$$
\left(\begin{array}{rrr}
0 & I_{2} & 0 \\
-I_{2} & 0 & 0 \\
0 & 0 & 0
\end{array}\right)
$$

Denote $F=\operatorname{Vect}\left\{e_{3}, \ldots, e_{7}\right\}$ and $H=F \oplus \mathbb{C} e_{2}$. We have

$$
\left[\pi^{-1}(\mathbb{C} \omega)\right]=\left[\left\{T \in G(2, V) \mid \omega_{\mid T}=0\right\}\right]=\left[\left\{T \in G(2, H) \mid \omega_{\mid T}=0\right\}\right]+[U]
$$

where $U$ is the open subset $\left\{T \in G(2, V) \mid \operatorname{dim}(T \cap H)=1, \omega_{\mid T}=0\right\}$, with the locally trivial fibration $\pi: U \rightarrow \mathbb{P} H=\mathbb{P}^{5}$. Note that $\operatorname{ker}(\omega)=\operatorname{Vect}\left\{e_{5}, e_{6}, e_{7}\right\} \subset H$ and $\operatorname{ker}\left(\omega_{\mid H}\right)=\operatorname{ker}(\omega) \oplus \mathbb{C} e_{3} \subset H$.

Let $D=\mathbb{C} e \in \mathbb{P} H$. There are three cases.

- First case: $D \subset \operatorname{ker}(\omega)$. We have

$$
\begin{aligned}
{\left[\pi^{-1}(D)\right] } & =[\{\mathbb{C} f \in \mathbb{P}(V / D) \mid \omega(f, e)=0\}]-\left[\left\{\mathbb{C} f \in \mathbb{P}(H / D) \mid \omega_{\mid H}(f, e)=0\right\}\right] \\
& =\left[\mathbb{P}^{5}\right]-\left[\mathbb{P}^{4}\right]=\mathbb{L}^{5}
\end{aligned}
$$

- Second case: $D \not \subset \operatorname{ker}(\omega)$ and $D \subset \operatorname{ker}\left(\omega_{\mid H}\right)$. In this case $\pi^{-1}(D)=\varnothing$, because

$$
\{\mathbb{C} f \in \mathbb{P}(V / D) \mid \omega(f, e)=0\}=\left\{\mathbb{C} f \in \mathbb{P}(H / D) \mid \omega_{\mid H}(f, e)=0\right\}
$$

- Third case: $D \not \subset \operatorname{ker}\left(\omega_{\mid H}\right)$. We have

$$
\begin{aligned}
{\left[\pi^{-1}(D)\right] } & =[\{\mathbb{C} f \in \mathbb{P}(V / D) \mid \omega(f, e)=0\}]-\left[\left\{\mathbb{C} f \in \mathbb{P}(H / D) \mid \omega_{\mid H}(f, e)=0\right\}\right] \\
& =\left[\mathbb{P}^{4}\right]-\left[\mathbb{P}^{3}\right]=\mathbb{L}^{4}
\end{aligned}
$$

Consequently

$$
\begin{aligned}
{[U] } & =[\mathbb{P} \operatorname{ker}(\omega)] \cdot \mathbb{L}^{5}+\left([\mathbb{P} H]-\left[\mathbb{P} \operatorname{ker}\left(\omega_{\mid H}\right)\right]\right) \cdot \mathbb{L}^{4} \\
& =\left[\mathbb{P}^{2}\right] \cdot \mathbb{L}^{5}+\left(\left[\mathbb{P}^{5}\right]-\left[\mathbb{P}^{3}\right]\right) \cdot \mathbb{L}^{4} \\
& =\left(\left[\mathbb{P}^{5}\right]-1\right) \cdot \mathbb{L}^{4}
\end{aligned}
$$

We can repeat the argument with $H$. As $\omega_{\mid F}=0$, we have

$$
\begin{aligned}
{\left[\left\{T \in G(2, H) \mid \omega_{\mid T}=0\right\}\right] } & =\left[\left\{T \in G(2, F) \mid \omega_{\mid T}=0\right\}\right]+\left[\mathbb{P} \operatorname{ker}\left(\omega_{\mid H}\right)\right] \cdot \mathbb{L}^{4} \\
& =[G(2,5)]+\left[\mathbb{P}^{3}\right] \cdot \mathbb{L}^{4} \\
& =\left[\mathbb{P}^{4}\right] \cdot\left(\mathbb{L}^{2}+1\right)+\left[\mathbb{P}^{3}\right] \cdot \mathbb{L}^{4}
\end{aligned}
$$

Finally, we get

$$
\begin{aligned}
{\left[\pi^{-1}(\mathbb{C} \omega)\right] } & =\left(\left[\mathbb{P}^{5}\right]-1\right) \cdot \mathbb{L}^{4}+\left[\mathbb{P}^{4}\right] \cdot\left(\mathbb{L}^{2}+1\right)+\left[\mathbb{P}^{3}\right] \cdot \mathbb{L}^{4} \\
& =\left(\left[\mathbb{P}^{5}\right]-1\right) \cdot \mathbb{L}^{4}+\left(\left[\mathbb{P}^{5}\right]-\mathbb{L}^{5}\right) \cdot\left(\mathbb{L}^{2}+1\right)+\left(\mathbb{L}^{3}+\mathbb{L}^{2}+\mathbb{L}+1\right) \cdot \mathbb{L}^{4} \\
& =\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)+\mathbb{L}^{6} .
\end{aligned}
$$

A similar calculation gives the following result.

Lemma 3.5 Let $\mathbb{C} \omega \in \mathbb{P} W \backslash Y_{W}$ be a closed point. Then the class of its fiber is

$$
\left[\pi^{-1}(\mathbb{C} \omega)\right]=\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)
$$

Proof of Proposition 3.2. Let $\mathbb{C} \omega_{1} \in Y_{W}$ and $\mathbb{C} \omega_{2} \in \mathbb{P} W \backslash Y_{W}$ be two closed points. Lemma 3.3 implies that

$$
\left\{\begin{array}{l}
{\left[\pi^{-1}\left(Y_{W}\right)\right]=\left[Y_{W}\right] \cdot\left[\pi^{-1}\left(\mathbb{C} \omega_{1}\right)\right]} \\
{\left[\pi^{-1}\left(\mathbb{P} W \backslash Y_{W}\right)\right]=\left([\mathbb{P} W]-\left[Y_{W}\right]\right) \cdot\left[\pi^{-1}\left(\mathbb{C} \omega_{2}\right)\right]}
\end{array}\right.
$$

and consequently

$$
[H]=\left[Y_{W}\right] \cdot\left[\pi^{-1}\left(\mathbb{C} \omega_{1}\right)\right]+\left([\mathbb{P} W]-\left[Y_{W}\right]\right) \cdot\left[\pi^{-1}\left(\mathbb{C} \omega_{2}\right)\right]
$$

Using Lemmas 3.4 and 3.5, we have

$$
\begin{aligned}
{[H] } & =\left[Y_{W}\right] \cdot\left(\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)+\mathbb{L}^{6}\right)+\left(\left[\mathbb{P}^{6}\right]-\left[Y_{W}\right]\right) \cdot\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right) \\
& =\left[Y_{W}\right] \cdot \mathbb{L}^{6}+\left[\mathbb{P}^{6}\right] \cdot\left[\mathbb{P}^{5}\right] \cdot\left(\mathbb{L}^{4}+\mathbb{L}^{2}+1\right)
\end{aligned}
$$

which concludes the proof.
