On Saturated Uniformly A-convex Algebras

Abstract. Following ideas of A. C. Cochran, we give a suitable definition of a saturated uniformly A-convex algebra. In the m-convex case, such algebra is a uniform topological one.

Keywords. Uniformly A-convex Algebra; Saturated Algebra; Uniform Topological Algebra.

1. PRELIMINARIES

A locally convex algebra is a complex algebra with a locally convex topology for which the multiplication is separately continuous. A locally m-convex algebra is a locally convex algebra whose topology is defined by a family of submultiplicative seminorms. A uniform seminorm on an algebra E is a seminorm p such that $p(x^2) = p(x)^2$ for all $x \in E$. Such a seminorm is submultiplicative. A uniform topological algebra is a locally convex algebra whose topology is defined by a family of uniform seminorms. A uniform normed algebra is a normed algebra $(E, \|.\|)$ such that $\|x^2\| = \|x\|^2$ for all $x \in E$. A locally convex algebra E is uniformly A-convex if its topology is defined by a family $\{p_{\alpha}, \alpha \in \Lambda\}$ of seminorms with the property that for $x \in E$, there is a positive constant r_x such that $p_{\alpha}(xy) \leq r_x p_{\alpha}(y)$ and $p_{\alpha}(yx) \leq r_x p_{\alpha}(y)$ for all $\alpha \in \Lambda$ and $y \in E$. Let E be a locally convex algebra. Denote by $M^*(E)$ the set of all nonzero multiplicative linear functionals on E. Denote by M(E) the space of all nonzero continuous multiplicative linear functionals on E, topologized via the weak topology, it is called the carrier space of E.

2. RESULTS

Let $(E, (p_{\alpha})_{\alpha \in \Lambda})$ be a Hausdorff commutative uniformly A-convex algebra with unit e. The family $\{p_{\alpha}, \alpha \in \Lambda\}$ of seminorms can be chosen such that $p_{\alpha}(e) = 1$ for all $\alpha \in \Lambda$. For $x \in E$, let $||x|| = \sup [\sup\{p_{\alpha}(xy), p_{\alpha}(y) \leq 1\} : \alpha \in \Lambda] =$ $\inf\{r_x > 0, p_{\alpha}(xy) \leq r_x p_{\alpha}(y)$ for all $\alpha \in \Lambda, y \in E\}$. By [1, Lemma 3.2], ||.|| is a submultiplicative norm on E for which $p_{\alpha}(x) \leq ||x||$ for all $\alpha \in \Lambda$ and $x \in E$. Let M be the carrier space of $(E, (p_{\alpha})_{\alpha \in \Lambda})$ and let M_n be the carrier space of $(E, ||.||), M \subset M_n$. Since (E, ||.||) is a commutative normed algebra with unit, M_n is nonempty. M may be empty [2]. For the sequel, we assume that M is nonempty. For $\alpha \in \Lambda$ and $m \in M$, Cochran [1] has defined the extended real number $t_{\alpha}(m) = \sup\{|m(x)|, p_{\alpha}(x) \leq 1\}$ and the map $\phi_{\alpha} : M \to R$ by $\phi_{\alpha}(m) = t_{\alpha}(m)^{-1}$ if $t_{\alpha}(m) < \infty$ and $\phi_{\alpha}(m) = 0$ otherwise.

Proposition 2.1.

- (1) $t_{\alpha}(m) \ge 1$ and $0 \le \phi_{\alpha}(m) \le 1$ for all $\alpha \in \Lambda$ and $m \in M$;
- (2) $t_{\alpha}(m) < \infty$ if, and only if, *m* is continuous for p_{α} ;
- (3) If $t_{\alpha}(m) < \infty$, then $|m(x)| \le t_{\alpha}(m) p_{\alpha}(x)$ for all $x \in E$.

Proof. (1) Since m(e) = 1 and $p_{\alpha}(e) = 1$, it follows that $t_{\alpha}(m) \ge 1$, hence $\phi_{\alpha}(m) = t_{\alpha}(m)^{-1} \le 1$.

(2) m is continuous for p_{α} if, and only if, m is bounded on $\{x \in E, p_{\alpha}(x) \leq 1\}$, i.e. $t_{\alpha}(m) < \infty$.

(3) Let $x \in E$ and $\varepsilon > 0$, $|m\left((p_{\alpha}(x) + \varepsilon)^{-1}x\right)| \le t_{\alpha}(m)$ since $p_{\alpha}\left((p_{\alpha}(x) + \varepsilon)^{-1}x\right) \le 1$, thus $|m(x)| \le t_{\alpha}(m)(p_{\alpha}(x) + \varepsilon)$. Since $\varepsilon > 0$ is arbitrary, we conclude that $|m(x)| \le t_{\alpha}(m)p_{\alpha}(x)$.

Let $C_b(M)$ be the algebra of all complex continuous bounded functions on M, with the topology defined by the family $\{\hat{p}_{\alpha}, \alpha \in \Lambda\}$ of seminorms, where $\hat{p}_{\alpha}(f) = \sup\{\phi_{\alpha}(m)|f(m)|, m \in M\}$ for all $f \in C_b(M)$. For $\alpha \in \Lambda$, define $M_{\alpha} = \{m \in M, t_{\alpha}(m) < \infty\}$. If M_{α} is empty, $\phi_{\alpha}(m) = 0$ for all $m \in M$, so $\hat{p}_{\alpha}(f) = 0$ for all $f \in C_b(M)$. If M_{α} is nonempty, $\hat{p}_{\alpha}(f) = \sup\{t_{\alpha}(m)^{-1}|f(m)|, m \in M_{\alpha}\}$. If $\{p_{\alpha}, \alpha \in \Lambda\}$ is a directed family of seminorms, then $M = \bigcup_{\alpha \in \Lambda} M_{\alpha}$, so there exists $\alpha \in \Lambda$ such that M_{α} is nonempty. The following result is due to Cochran [1], the proof is given for completeness.

Proposition 2.2 [1]. Let $G: E \to C(M)$ be the Gelfand map. Then

(1) $|\hat{x}(m)| \leq ||x||$ for all $x \in E$ and $m \in M$, so $G(E) = \hat{E} \subset C_b(M)$;

(2) $\hat{p}_{\alpha}(\hat{x}) \leq p_{\alpha}(x)$ for all $\alpha \in \Lambda$ and $x \in E$.

Proof. (1) Let $m \in M \subset M_n$. Since $(E, \|.\|)$ is a normed algebra and $m \in M_n$, it follows that $|\hat{x}(m)| = |m(x)| \leq \|x\|$ for all $x \in E$. Consequently, $\hat{E} \subset C_b(M)$.

(2) Let $\alpha \in \Lambda$. If M_{α} is empty, $\hat{p}_{\alpha}(\hat{x}) = 0 \leq p_{\alpha}(x)$ for all $x \in E$. If M_{α} is nonempty, we have $|m(x)| \leq t_{\alpha}(m)p_{\alpha}(x)$ for all $m \in M_{\alpha}$ and $x \in E$, i.e. $t_{\alpha}(m)^{-1}|m(x)| \leq p_{\alpha}(x)$ for all $m \in M_{\alpha}$ and $x \in E$. Thus $\hat{p}_{\alpha}(\hat{x}) = \sup\{t_{\alpha}(m)^{-1}|m(x)|, m \in M_{\alpha}\} \leq p_{\alpha}(x)$ for all $x \in E$.

Let $\alpha \in \Lambda$ and let F_{α} be the topological dual of (E, p_{α}) . For $f \in F_{\alpha}$, put $t_{\alpha}(f) = \sup\{|f(x)|, p_{\alpha}(x) \leq 1\}, t_{\alpha}$ is a norm on F_{α} . If M_{α} is nonempty, M_{α} is usually topologized via the weak topology. But for the following proposition, we consider on M_{α} the topology τ_{α} induced by the topology of t_{α} . The map $M_{\alpha} \to R, m \to t_{\alpha}(m)$, is continuous for τ_{α} . Since $(M_{\alpha}, \tau_{\alpha})$ is a metric space, it

is a completely regular space, we denote by M_{α}^{β} the Stone-Čech compactification of M_{α} .

Proposition 2.3. The following assertions are equivalent:

- (1) If $p_{\alpha}(x) = 1$ for some $\alpha \in \Lambda$ and $x \in E$, then $\hat{p}_{\alpha}(\hat{x}) = 1$;
- (2) $\hat{p}_{\alpha}(\hat{x}) = p_{\alpha}(x)$ for all $\alpha \in \Lambda$ and $x \in E$;

(3) For $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1, M_{\alpha}$ is nonempty and the continuous extension of the map $M_{\alpha} \to R, m \to t_{\alpha}(m)^{-1} |m(x)|$, to M_{α}^{β} is equal to 1 at some $m_0 \in M_{\alpha}^{\beta}$.

Proof. (1) \Rightarrow (2) : Let $\alpha \in \Lambda$ and $x \in E$. If $p_{\alpha}(x) = 0$, then $0 \leq p_{\alpha}(\hat{x}) \leq p_{\alpha}(x) = 0$ by Proposition 2.2, so $\hat{p}_{\alpha}(\hat{x}) = 0$. If $p_{\alpha}(x) \neq 0$, $\hat{p}_{\alpha}\left(p_{\alpha}(x)^{-1}\hat{x}\right) = 1$ since $p_{\alpha}\left(p_{\alpha}(x)^{-1}x\right) = 1$, hence $\hat{p}_{\alpha}(\hat{x}) = p_{\alpha}(x)$.

(2) \Rightarrow (3) : Let $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$. M_{α} is nonempty since $1 = p_{\alpha}(x) = \hat{p}_{\alpha}(\hat{x}) \neq 0$. Let m_1, m_2 in M_{α} , $|m_1(x) - m_2(x)| = |(m_1 - m_2)(x)| \leq t_{\alpha}(m_1 - m_2)p_{\alpha}(x) = t_{\alpha}(m_1 - m_2)$, then the map $M_{\alpha} \rightarrow R, m \rightarrow m(x)$, is continuous. Consequently, the map $\varphi_{\alpha} : M_{\alpha} \rightarrow R, \varphi_{\alpha}(m) = t_{\alpha}(m)^{-1}|m(x)|$, is continuous. φ_{α} is also bounded on M_{α} since $\hat{p}_{\alpha}(\hat{x}) = \sup\{t_{\alpha}(m)^{-1}|m(x)|, m \in M_{\alpha}\} = p_{\alpha}(x) = 1$. Therefore φ_{α} has a continuous extension φ_{α}^{β} to M_{α}^{β} . Since $t_{\alpha}(m)^{-1}|m(x)| \leq 1$ for all $m \in M_{\alpha}$ and M_{α} is dense in M_{α}^{β} , it follows that $\varphi_{\alpha}^{\beta}(m) \leq 1$ for all $m \in M_{\alpha}^{\beta}$. We have $1 = \sup\{t_{\alpha}(m)^{-1}|m(x)|, m \in M_{\alpha}\} \leq \sup\{\varphi_{\alpha}^{\beta}(m), m \in M_{\alpha}^{\beta}\} = 1$. Since M_{α}^{β} is compact, there exists $m_0 \in M_{\alpha}^{\beta}$ such that $\varphi_{\alpha}^{\beta}(m_0) = 1$.

 $\begin{array}{ll} (3) \Rightarrow \ (1) &: \text{ Let } \alpha \in \Lambda \text{ and } x \in E \text{ such that } p_{\alpha}\left(x\right) = 1. \text{ If } \hat{p}_{\alpha}\left(\hat{x}\right) = \sup\{t_{\alpha}\left(m\right)^{-1}|m(x)|, m \in M_{\alpha}\} = s < 1, t_{\alpha}(m)^{-1}|m(x)| \leq s < 1 \text{ for all } m \in M_{\alpha} \\ \text{, then } \varphi_{\alpha}^{\beta}\left(m\right) \leq s < 1 \text{ for all } m \in M_{\alpha}^{\beta}, \text{ this contradicts } (3) &. \text{ Therefore } \hat{p}_{\alpha}\left(\hat{x}\right) \geq 1, \text{ so } 1 \leq \hat{p}_{\alpha}\left(\hat{x}\right) \leq p_{\alpha}\left(x\right) = 1 \text{ i.e. } \hat{p}_{\alpha}\left(\hat{x}\right) = 1. \end{array}$

We say that E is a Cochran algebra if $\hat{p}_{\alpha}(\hat{x}) = p_{\alpha}(x)$ for all $\alpha \in \Lambda$ and $x \in E$.

Proposition 2.4. If E is a Cochran algebra, then the Gelfand map G from $(E, (p_{\alpha})_{\alpha \in \Lambda})$ onto $(\hat{E}, (\hat{p}_{\alpha})_{\alpha \in \Lambda})$ is an algebraic and topological isomorphism.

Proof. Let $x \in E$. If $\hat{x} = 0$, then $\hat{p}_{\alpha}(\hat{x}) = p_{\alpha}(x) = 0$ for all $\alpha \in \Lambda$, so x = 0 since E is Hausdorff. Consequently, G is an algebraic isomorphism. Since $\hat{p}_{\alpha}(\hat{x}) = p_{\alpha}(x)$ for all $\alpha \in \Lambda$ and $x \in E$, G is a topological isomorphism.

Proposition 2.5. Let E be a Cochran algebra whose carrier space M is equicontinuous. Then E is a uniform normed algebra.

Proof. For $x \in E$, let $q(x) = \sup\{|m(x)|, m \in M\}$. Since M is equicontinuous, the map q is a continuous seminorm on E. Let $\alpha \in \Lambda$ and $x \in E, p_{\alpha}(x) =$

 $\hat{p}_{\alpha}(\hat{x}) = \sup\{\phi_{\alpha}(m)|m(x)|, m \in M\} \leq q(x) \text{ since } 0 \leq \phi_{\alpha}(m) \leq 1 \text{ for all } m \in M.$ Let $x \in E$ such that q(x) = 0, since E is Hausdorff and $p_{\alpha}(x) \leq q(x) = 0$ for all $\alpha \in \Lambda$, it follows that x = 0. q is a continuous uniform norm on E such that $p_{\alpha}(x) \leq q(x)$ for all $\alpha \in \Lambda$ and $x \in E$, then the topology of E can be defined by the uniform norm q.

Corollary 2.1. Let E be a Cochran algebra. If E is barrelled or a Q-algebra, then E is a uniform normed algebra.

Proof. (1) Assume that *E* is barrelled. By Proposition 2.2, $|m(x)| \leq ||x||$ for all $x \in E$ and $m \in M$. Therefore *M* is bounded for the weak topology, so *M* is equicontinuous.

(2) Assume that E is a Q-algebra. By [3, Proposition II.7.1], every topological Q-algebra has an equicontinuous carrier space.

The saturated uniformly A-convex algebras were introduced by Cochran [1] as a subclass of the class of Cochran algebras.

Definition 2.1 [1]. *E* is saturated if for each $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$, there exists $m_0 \in M$ such that $m_0(x) = \sup\{|m(y)|, p_{\alpha}(y) \leq 1\}$ for some $m \in M$. (Then $\hat{p}_{\alpha}(\hat{x}) = 1 = p_{\alpha}(x)$).

Oudadess [2] has proved that the class of complete saturated algebras (in the sense of Definition 2.1) is empty. His proof uses the completeness of the algebra. Here we give a simple proof in the general case.

Proposition 2.6. The class of saturated algebras (in the sense of Definition 2.1) is empty.

Proof. Let $\alpha \in \Lambda$, we have $p_{\alpha}(-e) = p_{\alpha}(e) = 1$. Since the algebra is saturated, there exist m_0, m in M such that $-1 = m_0(-e) = \sup\{|m(y)|, p_{\alpha}(y) \leq 1\} \geq 0$, which is absurd.

We think that the definition of a saturated algebra should be as follows:

Definition 2.2. *E* is saturated if for each $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$, there exists $m_0 \in M$ such that $|m_0(x)| = \sup\{|m_0(y)|, p_{\alpha}(y) \leq 1\}$, i.e. $m_0 \in M_{\alpha}$ and $t_{\alpha}(m_0)^{-1}|m_0(x)| = 1$.

Proposition 2.7. If E is saturated, then E is a Cochran algebra.

Proof. Let $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$. By hypothesis, M_{α} is nonempty and the map $M_{\alpha} \to R, m \to t_{\alpha}(m)^{-1} |m(x)|$, is equal to 1 at some $m_0 \in M$. Therefore E is a Cochran algebra by Proposition 2.3.

If p_{α} is submultiplicative, $N_{\alpha} = \{x \in E, p_{\alpha}(x) = 0\}$ is an ideal in E and the quotient algebra E/N_{α} is a normed algebra with the norm $||x_{\alpha}||_{\alpha} = p_{\alpha}(x), x_{\alpha} = x + N_{\alpha}$. Let E_{α} be the completion of $E/N_{\alpha}, E_{\alpha}$ is a commutative Banach algebra with unit.

Proposition 2.8. If p_{α} is submultiplicative, then

- (1) M_{α} is a nonempty compact space;
- (2) $t_{\alpha}(m) = 1$ for all $m \in M_{\alpha}$.

Proof. (1) M_{α} is homeomorphic to $M(E_{\alpha})$ by [4, Proposition 7.5], then M_{α} is a nonempty compact space.

(2) Let $m \in M_{\alpha}, |m(x)| \leq t_{\alpha}(m) p_{\alpha}(x)$ for all $x \in E$, then N_{α} is included in Ker(m). We may define a multiplicative linear functional m_{α} on E/N_{α} by $m_{\alpha}(x_{\alpha}) = m(x)$. Since E/N_{α} is a normed algebra and $m_{\alpha} \in M(E/N_{\alpha}), |m_{\alpha}(x_{\alpha})| \leq$ $||x_{\alpha}||_{\alpha}$ for all $x \in E$. Further, as E/N_{α} is unital, $1 = \sup\{|m_{\alpha}(x_{\alpha})|, ||x_{\alpha}||_{\alpha} \leq$ $1\} = \sup\{|m(x)|, p_{\alpha}(x) \leq 1\} = t_{\alpha}(m).$

Proposition 2.9. If p_{α} is submultiplicative for every $\alpha \in \Lambda$, then the following assertions are equivalent:

- (1) E is saturated;
- (2) E is a Cochran algebra;
- (3) $(E, (p_{\alpha})_{\alpha \in \Lambda})$ is a uniform topological algebra.

Proof. (1) \Rightarrow (2) : By Proposition 2.7.

 $(2) \Rightarrow (3)$: Let $\alpha \in \Lambda$ and $x \in E$, $p_{\alpha}(x) = \hat{p}_{\alpha}(\hat{x}) = \sup\{t_{\alpha}(m)^{-1}|m(x)|, m \in M_{\alpha}\}$ by Proposition 2.8. Thus p_{α} is a uniform seminorm.

(3) \Rightarrow (1) : Let $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$. Since E_{α} is a uniform Banach algebra, $1 = p_{\alpha}(x) = ||x_{\alpha}||_{\alpha} = \sup\{|g(x_{\alpha})|, g \in M(E_{\alpha})\} = \sup\{|m(x)|, m \in M_{\alpha}\}$ by [4, proposition 7.5]. Since M_{α} is compact, there exists $m_0 \in M_{\alpha}$ such that $|m_0(x)| = 1 = t_{\alpha}(m_0)$ by Proposition 2.8, hence E is saturated.

We give an example of a saturated algebra which is not m-convex.

Example. Let $C_b(R)$ be the algebra of all complex continuous bounded functions on R. Let Λ be the subset of $C_b(R)$ defined by $\phi \in \Lambda$ if $\phi(x) > 0$ for all $x \in R$, $\sup\{|\phi(x)|, x \in R\} = 1$ and ϕ vanishes at infinity. We endow $C_b(R)$ with the topology determined by the family $\{p_{\phi}, \phi \in \Lambda\}$ of seminorms, where $p_{\phi}(f) = \sup\{|f(x)\phi(x)|, x \in R\}$. $C_b(R)$ is a commutative complete uniformly A-convex algebra with unit u(u(x) = 1 for all $x \in R$) such that $p_{\phi}(u) = 1$ for all $\phi \in \Lambda$. $(C_b(R), (p_{\phi})_{\phi \in \Lambda})$ is not m-convex. Let $f \in C_b(R)$ and $\phi \in \Lambda$ such that $|f(x_0)\phi(x_0)| = 1$. Show that $|f(x_0)| = \sup\{|g(x_0)|, p_{\phi}(g) \leq 1\}$. The proof is due to Beddaa [5], it is given here for completeness. We have $|f(x_0)| \leq \sup\{|g(x_0)|, p_{\phi}(g) \leq 1\}$ since $p_{\phi}(f) = 1$. If $p_{\phi}(g) \leq 1 = |f(x_0)\phi(x_0)|$, then

 $|g(x_0)\phi(x_0)| \leq |f(x_0)\phi(x_0)|$, so $|g(x_0)| \leq |f(x_0)|$ since $\phi(x_0) > 0$. We have shown that $|\delta_{x_0}(f)| = \sup\{|\delta_{x_0}(g)|, p_{\phi}(g) \leq 1\}$, where $\delta_{x_0} : C_b(R) \to C, \delta_{x_0}(h) = h(x_0)$, is a nonzero continuous multiplicative linear functional on $C_b(R)$. Thus $(C_b(R), (p_{\phi})_{\phi \in \Lambda})$ is saturated.

Oudadess [2] has introduced the following definition:

Definition 2.3 [2]. *E* is v-saturated if for all $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$, there exist m_0, m in $M^* = M^*(E)$ such that $|m_0(x)| = \sup\{|m(y)|, p_{\alpha}(y) \leq 1\}$.

We have three remarks about this definition.

1. If E is v-saturated, for $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$, there exist m_0, m in M^* such that $\sup\{|m(x)|, p_{\alpha}(y) \leq 1\} = |m_0(x)| < \infty$, then M is nonempty since $m \in M$, so the fact of replacing M by M^* is not justified.

2. Outdadess [2] did not use anywhere the sup-property of his definition. He only used the following deduced property: for all $\alpha \in \Lambda$ and $x \in E$ such that $p_{\alpha}(x) = 1$, there exists $m_0 \in M^*$ such that $|m_0(x)| \ge 1$.

3. In [2, Theorem 5.4], Oudadess claimed that if E is complete and vsaturated, then the Gelfand map G from $(E, (p_{\alpha})_{\alpha \in \Lambda})$ onto $(\hat{E}, (\hat{p}_{\alpha})_{\alpha \in \Lambda})$ is an algebraic and topological isomorphism. For the proof, he used Theorem 3.5 of [1], but this theorem allows us only to conclude that G is a continuous algebraic isomorphism.
