## ON A NONLINEAR CRITICAL ELLIPTIC EQUATION WITH A PERTURBED HARDY POTENTIAL

ABSTRACT. In this work, we use a minimisation argument to show the existence of a nontrivial solution to

$$
\begin{cases}-\Delta u-\frac{a(x)}{|x|^{2}} u=u^{2^{\star}-1} & \text { in } \Omega \\ u \geq 0 & \text { a.e. in } \Omega \\ u=0 & \text { in } \partial \Omega\end{cases}
$$

where $\Omega \subset \mathbb{R}^{n}, n \geq 3$, is a smooth domain.

## 1. Introduction

Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}, n \geq 3$, such that $0 \in \partial \Omega$. We let $a \in C^{0, \theta}(\bar{\Omega})$ for some $\left.\theta \in\right] 0,1[$ be a Hölder continuous function. In this note, we investigate the existence of weak solutions $u \in H_{0}^{1}(\Omega), u \not \equiv 0$, to the problem

$$
(H) \begin{cases}-\Delta u-\frac{a(x)}{|x|^{2}} u=u^{2^{\star}-1} & \text { in } \Omega \\ u \geq 0 & \text { a.e. in } \Omega \\ u=0 & \text { in } \partial \Omega\end{cases}
$$

where $2^{\star}:=\frac{2 n}{n-2}$ and $H_{0}^{1}(\Omega)$ is the completion of $C_{c}^{\infty}(\Omega)$ for the norm $u \mapsto\|\nabla u\|_{2}$. The exponent $2^{\star}$ is critical from the viewpoint of Sobolev embeddings: $H_{0}^{1}(\Omega)$ is continuously embedded in $L^{q}(\Omega)$ for all $1 \leq q \leq 2^{\star}$, and the embedding is compact if $1 \leq q<2^{\star}$. Such type of equations has been investigated by many authors since the pioneer work of Brezis-Nirenberg [1] (which is the case $a(x):=\lambda|x|^{2}$ for some $\lambda \in \mathbb{R}$ ). For the case of nontrivial Hardy potential, without claiming any exhaustivity, we refer to Jannelli [4], Ruiz-Willem [5] (both for the case $0 \in \Omega$ ), the recent survey by Ghoussoub-Robert [3] and the references therein.
Concerning terminology, we say that $u \in H_{0}^{1}(\Omega)$ is a weak solution to $(H)$ if

$$
\int_{\Omega} \nabla u \nabla v d x-\int_{\Omega} \frac{a(x)}{|x|^{2}} u v d x=\int_{\Omega} u^{2^{*}-1} v d x \text { for all } v \in H_{0}^{1}(\Omega) .
$$

This definition makes sense because of the Sobolev embedding $H_{0}^{1}(\Omega) \hookrightarrow L^{2^{\star}}(\Omega)$ and the Hardy inequality

$$
\frac{(n-2)^{2}}{4} \int_{\Omega} \frac{v^{2}}{|x|^{2}} d x \leq \int_{\Omega}|\nabla v|^{2} d x
$$

for all $v \in H_{0}^{1}(\Omega)$. Since $0 \in \partial \Omega$, this classical inequality is improved and one has

$$
\begin{equation*}
\gamma_{H}(\Omega) \int_{\Omega} \frac{v^{2}}{|x|^{2}} d x \leq \int_{\Omega}|\nabla v|^{2} d x \tag{1}
\end{equation*}
$$

for all $v \in H_{0}^{1}(\Omega)$, where

$$
\frac{(n-2)^{2}}{4}<\gamma_{H}(\Omega) \leq \frac{n^{2}}{4}
$$

is the best possible constant such that (1) holds. Note that when $\Omega$ is convex, or more generally when $\Omega \subset \mathbb{R}_{+}^{n}:=\left\{x \in \mathbb{R}^{n} / x_{1}>0\right\}$, then $\gamma_{H}(\Omega)$ achieves the maximal value $\frac{n^{2}}{4}$. We refer to Ghoussoub-Robert [2] for discussions and references about the value of $\gamma_{H}(\Omega)$.

In the sequel, we assume that the operator $-\Delta-\frac{a(x)}{|x|^{2}}$ is coercive, that is there exists $c>0$ such that

$$
\int_{\Omega}\left(|\nabla v|^{2}-\frac{a(x) v^{2}}{|x|^{2}}\right) d x \geq c \int_{\Omega}|\nabla v|^{2} d x \text { for all } v \in H_{0}^{1}(\Omega)
$$

We investigate weak solutions to $(H)$ as minima of the functional defined for $u \in$ $H_{0}^{1}(\Omega) \backslash\{0\}$ by

We define

$$
J_{a}^{\Omega}(u):=\frac{\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x}{\left(\int_{\Omega}|u|^{2^{\star}} d x\right)^{\frac{2}{2^{\star}}}}
$$

$$
\mu_{a}(\Omega):=\inf \left\{J_{a}^{\Omega}(u) \mid u \in H_{0}^{1}(\Omega) \backslash\{0\}\right\}
$$

In the following $D^{1,2}\left(\mathbb{R}_{+}^{n}\right)$ is the completion of $C_{0}^{\infty}\left(\mathbb{R}_{+}^{n}\right)$ for the norm $u \mapsto\|\nabla u\|_{2}$. We prove the following result.
Theorem 1.1. Let $\Omega$ be a smooth bounded domain of $\mathbb{R}^{n}, n \geq 3$. Let $a \in C^{0, \theta}(\bar{\Omega})$ for some $\theta \in(0,1)$. We assume that $-\Delta-\frac{a(x)}{|x|^{2}}$ is coercive and that $\gamma:=a(0)<\frac{n^{2}}{4}$. We assume that

$$
\mu_{a}(\Omega)<\frac{1}{K(n, \gamma)}
$$

where

$$
\frac{1}{K(n, \gamma)}:=\inf _{u \in D^{1,2}\left(\mathbb{R}_{+}^{n}\right) \backslash\{0\}} \frac{\int_{\mathbb{R}_{+}^{n}}\left(|\nabla v|^{2}-\frac{\gamma v^{2}}{|x|^{2}}\right) d x}{\left(\int_{\mathbb{R}_{+}^{n}}|v|^{2^{\star}} d x\right)^{\frac{2}{2^{\star}}}}
$$

Then there exists $u \in H_{0}^{1}(\Omega) \backslash\{0\}$ that is a weak solution of $(H)$. Moreover, $u$ can be achieved as a minimizer for $\mu_{a}(\Omega)$.

Remark 1. For example, if $a(x)=\gamma$ and $\gamma<\frac{(n-2)^{2}}{4}$ we have that $-\Delta-\frac{a(x)}{|x|^{2}}$ is coercive in $\mathbb{R}^{n}$. More generally, it is necessary and sufficient that $\gamma<\gamma_{H}(\Omega)$ or $\gamma_{H}(\Omega)$ is the Hardy-Sobolev constant.

This note is devoted to the proof of Theorem 1.1.

## 2. Proof of Theorem 1.1

Let $\left(u_{k}\right)_{k \in \mathbb{N}} \in H_{0}^{1}(\Omega) \backslash\{0\}$ be a minimizing sequence for $\mu_{a}(\Omega)$, that is $J_{a}^{\Omega}\left(u_{k}\right)=$ $\mu_{a}(\Omega)+o(1)$ as $k \rightarrow+\infty$. Without loss of generality, we can assume that

$$
\left\|u_{k}\right\|_{2^{*}}^{2}=1 \text { for all } k \in \mathbb{N}
$$

and then

$$
\begin{equation*}
\int_{\Omega}\left|\nabla u_{k}\right|^{2}-\frac{a(x) u_{k}^{2}}{|x|^{2}} d x=\mu_{a}(\Omega)+o(1) \text { as } k \rightarrow+\infty \tag{2}
\end{equation*}
$$

Step 1: We claim that $\left(u_{k}\right)_{k \in \mathbb{N}}$ is bounded in $H_{0}^{1}(\Omega)$.

Proof. Since the operator is coercive, there exists $C>0$ such that

$$
\begin{equation*}
\int_{\Omega}\left(\left|\nabla u_{k}\right|^{2}-\frac{a(x) u_{k}^{2}}{|x|^{2}}\right) d x \geq C \int_{\Omega}\left|\nabla u_{k}\right|^{2} d x \tag{3}
\end{equation*}
$$

for all $k \in \mathbb{N}$. We combine (2) and (3) to get

$$
C \int_{\Omega}\left|\nabla u_{k}\right|^{2} d x \leq \mu_{a}(\Omega)+o(1)
$$

as $k \rightarrow+\infty$. Therefore $\left(u_{k}\right)_{k \in \mathbb{N}}$ is bounded in $H_{0}^{1}(\Omega)$. This proves the claim.
As a consequence, up to the extraction of a subsequence, there exists $u \in H_{0}^{1}(\Omega)$ such that

$$
\begin{array}{lcl}
u_{k} \rightharpoonup u & \text { converges weakly in } & H_{0}^{1}(\Omega) \\
u_{k} \rightarrow u & \text { converges strongly in } & L^{2}(\Omega) \\
u_{k} \rightarrow u & \text { converges a.e in } & \Omega .
\end{array}
$$

We define $v_{k}=u_{k}-u$, we use equation (2) and we get

$$
\int_{\Omega}\left|\nabla\left(v_{k}+u\right)\right|^{2} d x-\int_{\Omega} \frac{a(x)\left(v_{k}+u\right)^{2}}{|x|^{2}} d x=\mu_{a}(\Omega)+o(1) .
$$

Therefore

$$
\begin{aligned}
& \int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega}|\nabla u|^{2} d x+2 \int_{\Omega}\left(\nabla v_{k}, \nabla u\right) d x \\
& -\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x-2 \int_{\Omega} \frac{a(x) v_{k} u}{\left|x^{2}\right|} d x=\mu_{a}(\Omega)+o(1) .
\end{aligned}
$$

Since $v_{k} \rightharpoonup 0$ converges weakly in $H_{0}^{1}(\Omega)$ as $k \rightarrow+\infty$, we get that

$$
\begin{equation*}
\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x=\mu_{a}(\Omega)+o(1) \tag{4}
\end{equation*}
$$

as $k \rightarrow+\infty$.
Step 2: We claim that

$$
\begin{equation*}
\lim _{k \rightarrow+\infty}\left[\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x\right]=0 \tag{5}
\end{equation*}
$$

where $a(0)=\gamma$.
Proof. Since $a \in C^{0, \theta}(\bar{\Omega})$ then there exists $c>0$ such that

$$
|a(x)-a(0)| \leq c|x|^{\theta} \text { for all } x \in \Omega
$$

This gives

$$
\begin{aligned}
\left|\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x\right| & =\left|\int_{\Omega} \frac{(a(x)-a(0)) v_{k}^{2}}{|x|^{2}}\right| \\
& \leq \int_{\Omega} \frac{|a(x)-a(0)| v_{k}^{2}}{|x|^{2}} d x \\
& \leq c \int_{\Omega} \frac{|x|^{\theta} v_{k}^{2}}{|x|^{2}} d x .
\end{aligned}
$$

We let $\delta>0$ to be fixed later. We have that

$$
\begin{aligned}
\left|\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x\right| & \leq c \int_{B(0, \delta)} \frac{|x|^{\theta} v_{k}^{2}}{|x|^{2}} d x+c \int_{\Omega \backslash B(0, \delta)} \frac{|x|^{\theta} v_{k}^{2}}{|x|^{2}} d x \\
& =I_{1}(k)+I_{2}(k)
\end{aligned}
$$

as $k \rightarrow+\infty$. Concerning $I_{1}(k)$, we use the Hardy inequality (1) to get

$$
I_{1}(k)=c \int_{B(0, \delta)} \frac{|x|^{\theta} v_{k}^{2}}{|x|^{2}} d x \leq \delta^{\theta} \int_{B(0, \delta)} \frac{v_{k}^{2}}{|x|^{2}} d x \leq \frac{c}{\gamma_{H}(\Omega)} \delta^{\theta} \int_{\Omega}\left|\nabla v_{k}\right|^{2} d x
$$

for all $k \in \mathbb{N}$. Therefore, since $\left(v_{k}\right)_{k}$ is bounded in $H_{0}^{1}(\Omega)$, we get that

$$
\begin{equation*}
I_{1}(k) \leq c_{1} \delta^{\theta} \tag{6}
\end{equation*}
$$

for all $k \in \mathbb{N}$. Concerning $I_{2}(k)$, we have that

$$
I_{2}(k)=c \int_{\Omega \backslash B(0, \delta)} \frac{|x|^{\theta} v_{k}^{2}}{|x|^{2}} d x \leq c_{2} \delta^{\theta-2} \int_{\Omega \backslash B(0, \delta)} v_{k}^{2} d x
$$

for all $k \in \mathbb{N}$. Since $v_{k} \rightarrow 0$ strongly in $L^{2}$, we get that

$$
\begin{equation*}
\lim _{k \rightarrow \infty} I_{2}(k)=0 \tag{7}
\end{equation*}
$$

Let $\epsilon>0$ be a positive number. Since $\lim _{\delta \rightarrow 0} c_{1} \delta^{\theta}=0$, there exists $\delta>0$ such that $c_{1} \delta^{\theta}<\frac{\epsilon}{2}$, and then (6) yields $I_{1}(k)<\frac{\epsilon}{2}$ for all $k \in \mathbb{N}$. Moreover, it follows from (7) that there exists $k_{0}$ such that $I_{2}(k)<\frac{\epsilon}{2}$ for all $k>k_{0}$. Then,

$$
\left|\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x\right| \leq \frac{\epsilon}{2}+\frac{\epsilon}{2}=\epsilon
$$

for all $k>k_{0}$. Therefore,

$$
\lim _{k \rightarrow \infty}\left[\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x\right]=0
$$

This proves the claim.
Step 3: We claim that $\|u\|_{2^{*}}^{2}=1$.
Proof. We have

$$
\begin{equation*}
\|u\|_{2^{*}}^{2} \mu_{a}(\Omega) \leq \int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x \tag{8}
\end{equation*}
$$

It follows from Ghoussoub-Robert [[2], Proposition 4.3] that for any $\epsilon>0$, there exists $C_{\epsilon}>0$ such that

$$
\|v\|_{2^{*}}^{2} \leq(K(n, \gamma)+\epsilon) \int_{\Omega}\left(|\nabla v|^{2}-\frac{\gamma v^{2}}{|x|^{2}}\right) d x+C_{\epsilon} \int_{\Omega} v^{2} d x
$$

for all $v \in H_{0}^{1}(\Omega)$. When $k \rightarrow+\infty, v_{k} \rightarrow 0$ in $L^{2}(\Omega)$, we then get that

$$
\begin{equation*}
\left\|v_{k}\right\|_{2^{*}}^{2} \leq(K(n, \gamma)+\epsilon) \int_{\Omega}\left(\left|\nabla v_{k}\right|^{2}-\frac{\gamma v_{k}^{2}}{|x|^{2}}\right) d x+o(1) \tag{9}
\end{equation*}
$$

We combine (4), (5), (8) and (9) and to get

$$
\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x=\mu_{a}(\Omega)+o(1)
$$

$$
\begin{align*}
\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x & =\mu_{a}(\Omega)-\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x+o(1) \\
\|u\|_{2^{*}}^{2} \mu_{a}(\Omega) & \leq \mu_{a}(\Omega)-\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x+o(1) \\
\left(\|u\|_{2^{*}}^{2}-1\right) \mu_{a}(\Omega) & \leq-\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x+o(1) \\
\left(1-\|u\|_{2^{*}}^{2}\right) \mu_{a}(\Omega) & \geq \int_{\Omega}\left|\nabla v_{k}\right|^{2} d x-\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x+o(1) \\
& \geq \int_{\Omega}\left|\nabla v_{k}\right|^{2} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x+o(1) \\
\left(1-\|u\|_{2^{*}}^{2}\right) \mu_{a}(\Omega) & \geq \frac{1}{(K(n, \gamma)+\epsilon)}\left\|v_{k}\right\|_{2^{*}}^{2}+o(1) \tag{10}
\end{align*}
$$

$$
\left\|u_{k}\right\|_{2^{*}}^{2}=\left\|v_{k}\right\|_{2^{*}}^{2}+\|u\|_{2^{*}}^{2}+o(1)
$$

as $k \rightarrow+\infty$. Since $\left\|u_{k}\right\|_{2^{*}}^{2}=1$, we get

$$
\begin{equation*}
1=\left\|v_{k}\right\|_{2^{*}}^{2}+\|u\|_{2^{*}}^{2}+o(1) . \tag{11}
\end{equation*}
$$

Inequality (10) and (11) yield

$$
\begin{aligned}
\left(1-\|u\|_{2^{*}}^{2}\right) \mu_{a}(\Omega) & \geq \frac{1}{(K(n, \gamma)+\epsilon)}\left(1-\|u\|_{2^{*}}^{2}\right) \\
\left(1-\|u\|_{2^{*}}^{2}\right)\left(\mu_{a}(\Omega)-\frac{1}{(K(n, \gamma)+\epsilon)}\right) & \geq 0 .
\end{aligned}
$$

Since $\mu_{a}(\Omega)<\frac{1}{K(n, \gamma)}$, then there exists $\epsilon>0$ such that $\mu_{a}(\Omega)-\frac{1}{K(n, \gamma)+\epsilon}<0$, and therefore

$$
\|u\|_{2^{*}}^{2} \geq 1 .
$$

Since $u_{k} \rightharpoonup u$ converges weakly in $H_{0}^{1}(\Omega)$ as $k \rightarrow+\infty$, we have that $\|u\|_{2^{*}}^{2} \leq$ $\liminf \left\|u_{k}\right\|_{2^{*}}^{2}=1$. Therefore, we get that

$$
\|u\|_{2^{*}}^{2}=1 .
$$

This proves the claim.
Step 4: We claim that $u$ is a minimizer for $\mu_{a}(\Omega)$.
Proof. Equation (4) rewrites

$$
\begin{equation*}
\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x=\mu_{a}(\Omega)-\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x+\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x+o(1) . \tag{12}
\end{equation*}
$$

Equation (5) gives

$$
\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x-\int_{\Omega} \frac{a(x) v_{k}^{2}}{|x|^{2}} d x=\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x-\int_{\Omega} \frac{a(0) v_{k}^{2}}{|x|^{2}} d x+o(1)
$$

as $k \rightarrow+\infty$. Then, combining (9) with (12), we get that

$$
\begin{aligned}
\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x & \leq \mu_{a}(\Omega)-\frac{1}{K(n, \gamma)+\epsilon}\left\|v_{k}\right\|_{2^{*}}^{2}+o(1) \\
& \leq \mu_{a}(\Omega)+o(1)
\end{aligned}
$$

as $k \rightarrow+\infty$. Therefore, since $\|u\|_{2^{*}}^{2}=1$, we get

$$
\begin{equation*}
\frac{\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x}{\|u\|_{2^{*}}^{2}} \leq \mu_{a}(\Omega) . \tag{13}
\end{equation*}
$$

Combining (13) with the definition of $\mu_{a}(\Omega)$, we get that

$$
\mu_{a}(\Omega)=\frac{\int_{\Omega}|\nabla u|^{2} d x-\int_{\Omega} \frac{a(x) u^{2}}{|x|^{2}} d x}{\|u\|_{2^{\star}}^{2}}
$$

Therefore, $u$ is a minimizer of $\mu_{a}(\Omega)$ and the claim is proved.
Step 5: We claim that, up to multiplying by a positive constant, $u$ is a weak solution to (H).

Proof. Indeed, since $u$ is a minimum for $\mu_{a}(\Omega)$, it is a critical point of $J_{a}^{\Omega}$ and then, using that $\|u\|_{2^{\star}}=1$, we may as well assume that $u \geq 0$ on $\Omega$ (otherwise we replace $u$ by $|u|$ in the minimization process) and we get that

$$
\int_{\Omega} \nabla u \nabla v d x-\int_{\Omega} \frac{a(x)}{|x|^{2}} u v d x=\mu_{a}(\Omega) \int_{\Omega}|u|^{2^{*}-2} u v d x \text { for all } v \in H_{0}^{1}(\Omega)
$$

and $u$ is a weak solution to equation

$$
-\Delta u-\frac{a(x)}{|x|^{2}} u=\mu_{a}(\Omega) u^{2^{\star}-1} \text { in } H_{0}^{1}(\Omega)
$$

We define $u=k \tilde{u}$ where $k:=\mu_{a}(\Omega)^{\frac{-1}{\left(2^{*}-2\right)}}$. As one checks, $\tilde{u}$ is still a minimizer of $J_{a}^{\Omega}$ and $\tilde{u}$ is a weak solution to $(H)$. This proves the claim and Step 5.

Remark 2. It follows from the above analysis that $u_{k} \rightarrow u$ strongly in $H_{0}^{1}(\Omega)$. Indeed, we use equation (4), the coercivity of the operator and that $u$ is minimun to conclude that

$$
\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x-\int_{\Omega} \frac{a(x) v_{k}^{2} d x}{|x|^{2}} d x=o(1)
$$

and then

$$
\int_{\Omega}\left|\nabla v_{k}\right|^{2} d x \leq o(1)
$$

as $k \rightarrow+\infty$. Since $v_{k} \rightarrow 0$ strongly in $L^{2}(\Omega)$, we get that $v_{k} \rightarrow 0$ strongly in $H_{0}^{1}(\Omega)$. Therefore $u_{k} \rightarrow u$ strongly in $H_{0}^{1}(\Omega)$.
