Cognitive Behavioral Therapy with Daily Mindfulness Training: a Case Report of Comorbid Binge Eating and Bipolar Disorders

Brown and Ryan (2003) conceptualized dispositional mind-10fulness as a self-regulatory function, which is characterized by 11 12"being attentive to and aware of what is taking place in the 13present moment" (p.882). Mindfulness training added to cog-14nitive behavioral therapy (CBT) has been shown to reduce binge eating behavior, drive for thinness, and body dissatis-15faction while increasing psychological well-being and quality 1617of life for obese individuals diagnosed with binge eating disorder (BED; Carrard et al. 2011). In order to integrate mind-1819 fulness into general psychological practice, clinicians often 20utilize practical strategies with their clients such as the use of 21daily reminders, the integration into daily activities, and psychoeducational techniques like educational skill building 22and stress management (Dimidjian and Kleiber 2013; Shonin **01**23 et al. 2014). Mindfulness meditation can be trained with 24between-session practice (Bowen and Kurz 2012). 25Moreover, mindfulness has been shown to reduce negative 26mood and impulsivity, as well as increase psychological 2728well-being with clinical and nonclinical populations (Bowen and Kurz 2012; Brown and Ryan 2003). 29

Highlighting the effects of mindfulness on cognitive and emotional regulation, several studies have shown its benefits for healthier eating patterns and less binge eating (e.g., Baer et al. 2005a, b; Compare et al. 2012; Jordan et al. 2014; Levin et al. 2014). Furthermore, in the treatment of BED, Baer et al. (2005a, b) argued that instead of changing thoughts or nega-35tive emotional states, the focus should be on making more 36 adapted choices in response to psychological distress via 37 mindfulness rather than binging. In addition to its usefulness 38 with BED populations, mindfulness also targets mental pro-39 cesses that cut across a variety of other psychological disor-40 ders (i.e., "transdiagnostic") such as anxiety, depression, sub-41 stance use, and chronic pain conditions (see Greeson et al. 422014). However, there have been no reports, to our knowl-43edge, that describe a CBT with mindfulness intervention used 44 to treat BED and bipolar disorder in an outpatient clinic 45setting. 46

Given that BED and bipolar disorders are highly comorbid 47(Javaras et al. 2008), we report on the application of a 12-week 48 individual CBT intervention with mindfulness training to the 49clinical case of an adult patient with bipolar disorder I (BD-I) 50and BED: a 49-year-old Caucasian woman who contacted AR 51(first author, health psychologist) as an outpatient to partici-52pate in a mindfulness-based therapy because of symptoms 53related to diagnoses of BD-I, BED, and obesity (BMI= 54 36 kg/m^2). Diagnoses were established by two clinical evalu-55ations: (a) BD-I 20 years ago (after an initial suicide attempt) 56and (b) BED during the first session of the reported psycho-57therapy. The patient concurrently had psychiatric support in 58the community. The patient experienced multiple suicide at-59tempts via intentional ingestion: the first time 20 years ago 60 (when she was initially diagnosed with BD-I) and the last time 613 months prior to beginning the current therapy. Previous psy-62 chological supports helped her understand the origins of her 63 psychological distress but did not give her the necessary ther-64 apeutic tools to manage it in her everyday life. She was treated 65with mood stabilizers since her most recent suicide attempt 66 and reported medical adherence. She reported having no prior 67 knowledge of mindfulness and provided written consent to 68 AR to participate in the treatment. 69

70During therapy sessions, the therapist and patient first discussed the diagnostic criteria for bipolar disorder and 7172BED, and then the therapist provided psychoeducation about 73mindfulness and how to use it in daily life. Moreover, to in-74crease her mindfulness skills, the patient listened to a mindfulness recording for 10 min each day as practice. A notebook 75including (a) a diary for planning mindfulness sessions and 76 writing comments about it, (b) columns to restructure cogni-77 tions, and (c) columns to describe the emotional determinants 78and outcomes of binge episodes was offered to the patient. 79 This tool was provided so that she could engage in self-80 81 management care of her disorders. Once per week for 12 weeks, the patient reviewed the notebook with the thera-82 pist. During these 1-h face-to-face sessions, the therapist and 83 the patient worked together in an effort to understand the 84 barriers that prevented her from using the notebook through-85 out the week and to foster the patient's autonomous motiva-86 tion toward therapy. 87

88 At baseline and after every four sessions, the patient completed several self-report questionnaires that measured eating 89 behavior (Three-Factor Eating Questionnaire TFEQ-R18), de-90 pression (Beck Depression Inventory, BDI-II; Hospital 91 92Anxiety and Depression Scale, HADS-D), anxiety (Hospital Anxiety and Depression Scale, HADS-A), impulsivity 93(Barratt Impulsiveness Scale, BIS-11), motivation toward 9495therapy (Client Motivation for Therapy Scale, CMOTS), and mindfulness skills (Mindful Attention Awareness Scale, 96 MAAS; Acceptance and Action Question, AAQ-II). The re-97 98 sults are displayed in Table 1.

99 The patient reported less cognitive restriction with food, as well as better controlled and less emotional eating after 12 100101sessions of weekly psychotherapy. Moreover, she reported a decrease in cognitive impulsivity but maintained high scores 102in motor impulsivity and nonplanning. Surprisingly, the pa-103 104tient's anxiety scores increased and dispositional mindfulness 105scores remained stable across the 12-week psychotherapy period. Depression scores were consistent with a major depres-106107sive episode experienced within bipolar disorder: the patient showed moderate or severe depression scores every 4 weeks. 108 Motivation scores showed that the patient was more intrinsi-109cally motivated toward therapy but more extrinsically moti-110 vated when she endorsed severe depression (i.e., after 4 weeks 111and at post-therapy). Surprisingly, the patient seemed to be as 112113mindful at the end of the therapy as she was at baseline, although her psychological flexibility increased across time in 114therapy. Furthermore, the patient reported less binge episodes 115and a more structured meal organization during the second 116half of psychotherapy. 117

118 One of the determinants of BED is the difficulty to cope 119 with psychological distress (Baer et al. 2005a, b), and bipolar 120 disorder can be viewed as a dysfunction in mood regulation 121 (Swann et al. 2007). As BD-I includes manic and depressive 122 episodes, the associations with behavioral impulsivity (including substance abuse) are well known regardless of the123type of episode (Swann et al. 2007). This clinical case report124aimed to highlight the wide range of applications of daily125mindfulness training in obese individuals with BED and other126psychiatric comorbidities.127

The results reported by the patient are important for clini-128cians to note for several reasons. First, depression scores 129assessed with the BDI-II was sensitive to change across ther-130apy while the HADS-D was not. Second, while dispositional 131mindfulness remained stable, psychological flexibility (i.e., 132acceptance) increased during the 12-week program. These 133results suggest that daily mindfulness training and discussions 134 during sessions foster acceptance of thoughts, emotions, 135and bodily sensations in daily life. Moreover, the patient 136became more intrinsically and extrinsically motivated 137toward therapy as the number of sessions progressed. 138These changes in motivational regulation could be ex-139plained by the positive alliance between patient and 140therapist and by the early stage of change of the patient 141 regarding binge episodes. In fact, the patient never 142attempted to seek support for her BED prior to the 143current treatment. Furthermore, the results showed that 144when depression increased, the patient's motives for at-145tending therapy were more extrinsic (i.e., while feeling 146depressed, she stated she was attending therapy for the happi-147ness of her therapist instead of her own). This association is 148similar to literature arguing that motivation is modulated 149by the satisfaction of psychological needs (Deci and 150Ryan 1985). Previous research has shown that negative 151states of mind (e.g., depression) are associated with mo-152tivation for change, which may be one explanation for the 153current observed patterns. 154

On the other hand, during therapy, the patient reported that 155she was not always compliant with the daily mindfulness 156training. She first argued that she did not understand how 157mindfulness could help her; hence, the therapist educated 158her on the effects and mechanisms of action of mindfulness. 159After the psychoeducation sessions, the patient began to put 160an alarm on her phone to enhance adherence to daily 161mindfulness training. It seems that understanding the 162potential benefits of mindfulness training facilitated her 163 involvement and autonomy in her own care. Bowen and 164Kurz (2012) argued that maintaining long-term mindfulness 165training and its implementation in everyday life could be ob-166 tained by daily practice. In this case, the patient reported that 167she succeeded at being mindful when difficult situations came 168in her life, which is in accordance with previous predictions 169(Bowen and Kurz 2012). A recent study investigating the role 170played by therapeutic alliance, adherence, and competence in 171treatment failure showed that both therapeutic alliance and 172competence are mediators between adherence and treatment 173success (Weck et al. 2015), suggesting that feeling competent 174and having a strong alliance with the therapist increases 175

adherence to therapy and probability for a successful outcome.
In our case, the negative states of mood experienced by the
patient could have decreased her feeling of competence,
disrupted the relationship between therapeutic alliance, and
decreased treatment adherence.

After the 12 planned weeks of therapy, the patient de-181cided to stop seeing AR, stating that the therapy was stress-182183ful due to the changes in her "diet" (i.e., from binge episodes to structured eating). The anxiety scores increasing 184from baseline to post-therapy seem to show the patient's 185186uncertainty during the therapy process. In fact, during weekly sessions, she reported that she did not feel compe-187 tent. As a clinical health psychologist, it was challenging to 188address the patient's concurrent mood alterations and con-189190cerns about the subjective effectiveness of the therapy. Positive feedback was given when the patient reported im-191provements in the management of her daily life, but it 192

seems that other techniques should be implemented to minimize anxiety in the behavior change process (i.e., 194 readapting alimentation to replace BED). 195

These findings should be considered in the context of 196several limitations. First, the therapeutic relationship 197may have led the patient to give responses she wanted 198the therapist to see (i.e., response bias), although infor-199mation given to her about the outcome measures was 200limited. Second, this is a case of one 49-year-old female 201patient that should not be taken as representative of the 202population of patients with BED and BD-I. To our 203knowledge, this is the first report of a mindfulness-204based intervention for bipolar disorder with multiple suicide 205attempts and BED. Mindfulness training should be considered 206as a complementary tool in CBT for improving cognitive reg-207ulation of negative emotions across illnesses including obesi-208ty, BED, and BD-I. 209
