Kraskiewicz-Pragacz modules and some ´ positivity properties of Schubert polynomials

Abstract. We use the modules introduced by Kraśkiewicz and Pragacz (1987, 2004) to show some positivity properties of Schubert polynomials. We give a new proof to the classical fact that the product of two Schubert polynomials is Schubert-positive, and also show a new result that the plethystic composition of a Schur function with a Schubert polynomial is Schubert-positive. The present submission is an extended abstract on these results and the full version of this work will be published elsewhere.

Résumé. Nous employons les modules introduits par Kraskiewicz et Pragacz (1987, 2004) et démontrons certaines propriétés de positivité des polynômes de Schubert: nous donnons une nouvelle preuve pour le fait classique que le produit de deux polynômes de Schubert est Schubert-positif; nous d'emontrons aussi un nouveau résultat que la composition plethystique d'une fonction de Schur avec un polynôme de Schubert est Schubert-positif. Cet article est un sommaire de ces résultats, et une version pleine de ce travail sera publée ailleurs.

1 Introduction

The study of Schubert polynomials is an important and interesting subject in algebraic combinatorics. One of the possible methods for studying Schubert polynomials is through the modules introduced by Kraśkiewicz and Pragacz ([KP87], [KP04]). Let $\mathfrak b$ be the Lie algebra of all upper triangular matrices. For each permutation w, Kraskiewicz and Pragacz defined a representation \mathcal{S}_w of b such that its character with respect to the subalgebra h of all diagonal matrices is equal to the Schubert polynomial \mathfrak{S}_w .

In [Wat14a], the author investigated characterizations of b-modules having a filtration whose subquotients are Kraskiewicz-Pragacz modules (or *KP filtration* for short). The main motivation for this study is the investigation of positivity properties of Schubert polynomials. For example, it is a classical fact, usually proved using the cohomology ring of flag variety, that the product $\mathfrak{S}_w \mathfrak{S}_v$ of two Schubert polynomials is a positive sum of Schubert polynomials. If we show that the tensor product $S_w \otimes S_v$ of KP modules has a KP filtration, then it gives another proof to this fact. Another example is the question of positivity for the plethystic composition of a Schur function with a Schubert polynomial: if $\mathfrak{S}_w = x^{\alpha} + x^{\beta} + \cdots$ and s_λ is a Schur function, is $s_\lambda(x^\alpha, x^\beta, \ldots)$ a positive sum of Schubert polynomials? 2 Preliminaries 2 Preliminaries

Let N be the set of all positive integers and let $\mathbb{Z}_{\geq 0}$ be the set of all nonnegative integers. A *permutation* w is a bijection from N to itself which fixes all but finitely many points. Let S_{∞} denote the group of all permutations. Let *n* be a positive integer. Let $S_n = \{w \in S_\infty : w(i) = i \ (i > n)\}\)$ and $S_{\infty}^{(n)} = \{w \in S_{\infty} : w(n+1) < w(n+2) < \cdots \}$. Sometimes a permutation will be written in one-line form: i.e. if $w \in S_n$, we may write $[w(1) w(2) \cdots w(n)]$ to mean w. For $i < j$, let t_{ij} denote the permutation which exchanges i and j and fixes all other points. Let $s_i = t_{i,i+1}$. For a permutation w, let $\ell(w) = #\{i < j : w(i) > w(j)\}$. Let $w_0 \in S_n$ be the longest element of S_n , i.e. $w_0(i) = n + 1 - i (1 \le i \le n)$. For $w \in S_{\infty}^{(n)}$ we define $\text{code}(w) = (\text{code}(w)_1, \ldots, \text{code}(w)_n) \in \mathbb{Z}_{\geq}^n$ $w_0(i) = n + 1 - i (1 \le i \le n)$. For $w \in S_{\infty}$ we define the *Rothe diagram* $D(w)$ of a permutation w as

Figure 1: Rothe diagram of $w = [25143]$ (corresponding to the positions of the black dots above) is $D(w) = \{(1, 1), (2, 1), (2, 3), (2, 4), (4, 3)\}$ (shown by the boxes above).

For a polynomial $f = f(x_1, \ldots, x_n)$ and $1 \leq i \leq n-1$, we define $\partial_i f = \frac{f - s_i f}{x_i - x_{i+1}}$. It is known that the set $\{\mathfrak{S}_w : w \in S_{\infty}^{(n)}\}$ constitutes a Z-base for $\mathbb{Z}[x_1, \ldots, x_n]$ ([Mac91, (4.13)]).

Let K be a field of characteristic zero. Let $\mathfrak{b} = \mathfrak{b}_n$ be the Lie algebra of all upper triangular Kmatrices. and let $\mathfrak{h} \subset \mathfrak{b}$ and $\mathfrak{n}^+ \subset \mathfrak{b}$ be the subalgebra of all diagonal matrices and the subalgebra of all strictly upper triangular matrices respectively. Let $U(\mathfrak{b})$ and $U(\mathfrak{n}^+)$ be the universal enveloping algebras

of b and \mathfrak{n}^+ respectively. For a $\mathcal{U}(\mathfrak{b})$ -module M and $\lambda = (\lambda_1, \dots, \lambda_n) \in \mathbb{Z}^n$, let $M_{\lambda} = \{m \in M :$ $hm = \langle \lambda, h \rangle m \quad (\forall h \in \mathfrak{h})\}$ where $\langle \lambda, h \rangle = \sum \lambda_i h_i$. If $M_\lambda \neq 0$ then λ is said to be a *weight* of M. If $M = \bigoplus_{\lambda \in \mathbb{Z}^n} M_{\lambda}$ and each M_{λ} has a finite dimension, then M is said to be a *weight* b-module and we define $ch(M) = \sum_{\lambda} dim M_{\lambda} x^{\lambda}$ where $x^{\lambda} = x_1^{\lambda_1} \cdots x_n^{\lambda_n}$. From here we only consider weight b-modules, and write Ext^i to mean Ext functors in the category of all weight b-modules. For $1 \le i < j \le n$, let $e_{ij} \in \mathfrak{b}$ be the matrix with 1 at the (i, j) -position and all other coordinates 0. For $\lambda \in \mathbb{Z}^n$, let K_λ denote the one-dimensional $U(\mathfrak{b})$ -module where $h \in \mathfrak{h}$ acts by $\langle \lambda, h \rangle$ and e_{ij} acts by 0. We define $\rho = (n-1, n-2, \ldots, 0) \in \mathbb{Z}^n$, $\mathbf{1} = (1, \ldots, 1) \in \mathbb{Z}^n$ and $\epsilon_j = (0, \ldots, 1, \ldots, 0) \in \mathbb{Z}^n$ (1 at j-th position).

3 Kraśkiewicz-Pragacz modules

In [KP87], Kraskiewicz and Pragacz defined certain $U(\mathfrak{b})$ -modules which we call here *Kraskiewicz*-*Pragacz modules* or *KP modules*. Here we use the following definition. Let $K^n = \bigoplus_{1 \le i \le n} K u_i$ be the vector representation of b. For each $p \in \mathbb{N}$, let $\{i : (i, p) \in D(w)\} = \{i_1, \ldots, i_{l_p}\}$ $(i_1 < \cdots < i_{l_p})$, and let $u_w^{(p)} = u_{i_1} \wedge \cdots \wedge u_{i_{l_p}}$. Let $u_w = u_w^{(1)} \otimes u_w^{(2)} \otimes \cdots \in \bigwedge^{l_1} K^n \otimes \bigwedge^{l_2} K^n \otimes \cdots$. Then the KP module S_w associated to w is defined as $S_w = \mathcal{U}(\mathfrak{b})u_w$. This module satisfies the following:

Theorem 3.1 ([KP04, Remark 1.6 and Theorem 4.1]) S_w *is a weight module and* $\text{ch}(S_w) = \mathfrak{S}_w$ *.*

Example 3.2 *If* $w = s_i$ *, then* $D(s_i) = \{(i, i)\}\$ *,* $u_{s_i} = u_i$ *and* $S_{s_i} = \bigoplus_{1 \leq j \leq i} Ku_j =: K^i$ *.* So $\text{ch}(\mathcal{S}_{s_i}) =$ $x_1 + \cdots + x_i = \mathfrak{S}_{s_i}.$

Example 3.3 More generally, if $w \in S_{\infty}^{(n)}$ is a Grassmannian permutation with descent at *i*-th posi*tion, i.e.* $w(1) < \cdots < w(i)$ and $w(i + 1) < w(i + 2) < \cdots$, then the corresponding Rothe *diagram is, after a rearrangement of the columns, a Young diagram in French notation (see Figure* 2). In this case u_w is a lowest-weight vector in a irreducible representation of \mathfrak{gl}_i with lowest weight $code(w)$, and thus \mathcal{S}_w is isomorphic to this module (seen as a module over \mathfrak{b}_n through the morphism $\mathfrak{b}_n \ni e_{pq} \mapsto$ $\int e_{pq} \quad (q \leq i)$ $\begin{cases} \n\frac{p_{pq}}{(q > i)} \in \mathfrak{b}_i \hookrightarrow \mathfrak{gl}_i$. This corresponds to the fact that Schubert polynomials

indexed by permutations are just the Schur polynomials.

Example 3.4 *If* w *is 2143-avoiding, then it is known ([Mac91, (1.27)]) that the rows of* D(w) *are totally (pre)ordered by inclusion. Thus in this case* u_w *is an extremal weight vector in a certain irreducible representation of* \mathfrak{gl}_n *, and thus* \mathcal{S}_w *is isomorphic to a Demazure module: i.e. the* $U(\mathfrak{b})$ *-module generated by an extremal weight vector in a irreducible representation of* \mathfrak{gl}_n . Note that this corresponds to the result *of Lascoux and Schutzenberger ([LS89, Theorem 5], [Las03, Corollary 10.5.2]) that Schubert polynomials with 2143-avoiding indices are equal to certain key polynomials.*

A *KP* filtration of a weight b-module M is a filtration $0 = M_0 \subset M_1 \subset \cdots \subset M_r = M$ of b-modules such that each M_i/M_{i-1} is isomorphic to some S_{λ^i} ($\lambda^i \in \mathbb{Z}^n$). It is clear from the definition that if M has a KP filtration then $ch(M)$ is a positive sum of Schubert polynomials.

4 A criterion for the existence of KP filtration 4 A criterion for the existence of KP filtration

In order to develop an analogue of the theory on excellent filtration for KP modules using the highest-In order to develop an analogue of the theory on excellent filtration for KP modules using the highestweight category theory, an important step is to characterize KP modules as projective objects in certain weight category theory, an important step is to characterize KP modules as projective objects in certain categories of b-modules, as Polo did for Demazure modules in [Pol89]. We proved in [Wat14a] the categories of b-modules, as Polo did for Demazure modules in [Pol89]. We proved in [Wat14a] the following such characterization. following such characterization.

Introduce an order \leq on \mathbb{Z}^n as follows. For $\lambda, \mu \in \mathbb{Z}^n$, take k so that $\lambda + k \mathbf{1}, \mu + k \mathbf{1} \in \mathbb{Z}_{\geq 0}^n$, and define $\lambda \leq \mu \iff \ell(w) = \ell(v)$ and $w^{-1} \geq v^{-1}$ where $w, v \in S_{\infty}^{(n)}$ are defined by $\text{code}(w) = \lambda + k\mathbf{1}$ and $\text{code}(v) = \mu + k\mathbf{1}$. Here \geq denotes the lexicographic ordering on permutations. For $\lambda \in \mathbb{Z}_{\geq 0}^n$, let $\mathcal{C}_{\leq \lambda}$ be the category of all weight b-modules whose weights are all $\leq \lambda$. $\lambda \le \mu \iff \ell(w) = \ell(v)$ and $w^{-1} \ge v^{-1}$ where $w, v \in S_\infty^{(n)}$ are defined by $code(w) = \lambda + k1$ and $\text{code}(v) = \mu + k1$. Here $\geq \text{ denotes the lexicographic ordering on permutations. For } \lambda \in \mathbb{Z}_{\geq 0}^n$, let $\mathcal{C}_{\leq \lambda}$

Theorem 4.1 ([Wat14a, Proposition 6.4]) The modules S_{λ} and $S_{\rho-\lambda}^* \otimes K_{\rho}$ are in $C_{\leq \lambda}$ and give the *projective cover and the injective hull of* K_{λ} *in* $\mathcal{C}_{\leq \lambda}$ *respectively.*

Example 4.2 Let $n = 3$. Then the weights $\lambda \in \mathbb{Z}^n$ which are less than or equal to $(0, 2, 1)$, with respect to the ordering \leq , are $(1,1,1), (2,1,0), (1,2,0), (2,0,1), (3,0,0), (1,0,2)$ and $(0,2,1)$. Then it is easy to

In the proof of this characterization, we used the following structural result on KP modules. The current proof of the following result in [Wat14a] uses a long case-by-case check, and we hope that there is a more elegant proof.

For $w \in S_{\infty}^{(n)}$ and $1 \leq i < j \leq n$, let $C_{ij}(w) = \{p : (i,p) \notin D(w), (j,p) \in D(w)\}$ (= $\{w(k) :$ $k > j$, $w(i) < w(k) < w(j)$ and let $m_{ij}(w) = |C_{ij}(w)|$. Then, since $e_{ij}^2 u_w^{(p)} = 0$ for $p \in C_{ij}(w)$ and $e_{ij}u_w^{(p)} = 0$ for $p \notin C_{ij}(w)$, we see that $e_{ij}^{m_{ij}(w)+1}$ annihilates $u_w = u_w^{(1)} \otimes u_w^{(2)} \otimes \cdots$. The following theorem states that the annihilator of u_w is in fact generated by these elements:

Theorem 4.3 ([Wat14a, Theorem 4.1]) Let I_w is the left ideal of $\mathcal{U}(\mathfrak{n}^+)$ generated by the elements $e_{ij}^{m_{ij}(w)+1}$ ($1\leq i < j \leq n$). Then there exists an $\mathcal{U}(\mathfrak{n}^+)$ -module isomorphism $\mathcal{U}(\mathfrak{n}^+)/I_w\cong \mathcal{S}_w$ sending $1 \mod I_w$ *to* u_w .

Example 4.4 Let $n = 4$ and $w = [25143] \in S_{\infty}^{(4)}$. Then the Rothe diagram $D(w)$ is as in Figure 1, and I_w is generated by $e_{12}^3, e_{13}, e_{14}^2, e_{23}, e_{24}$ and e_{34}^2 .

Note that Theorem 4.3 can be seen as an analog of the Joseph's result ([Jos85, Theorem 3.4]) on Demazure modules which states (in \mathfrak{gl}_n case) that the annihilator ideal of the lowest weight vector of weight $\lambda \in \mathbb{Z}^n$ in a Demazure module is generated by $e_{ij}^{\max\{\lambda_j-\lambda_i,0\}+1}$ $(1 \le i < j \le n)$.

Using Theorem 4.1, the following characterization of modules having KP filtrations can be shown with a standard argument from the theory of highest-weight categories (in fact, one more trick is needed [Wat14a, Lemma 7.1]):

Theorem 4.5 ([Wat14a, Corollary 7.6, Theorem 8.1]) *Let* M *be a finite-dimensional weight* b*-module. Then the followings are equivalent:*

1. M *has a KP filtration.*

5 Applications

In this section we present two applications of Theorem 4.5. One application is the proof of the fact that the tensor product $S_w \otimes S_v$ of KP modules admits a KP filtration. This can be seen as a module-theoretic counterpart of the classical fact that the product $\mathfrak{S}_w \mathfrak{S}_v$ of Schubert polynomials is a positive sum of Schubert polynomials, and it also gives a new proof to this fact. Another application is the Schubertpositivity of the "plethystic composition" $s_{\lambda}[\mathfrak{S}_w]$ of a Schur function with a Schubert polynomial.

First we prepare some useful corollaries from Theorem 4.5:

Proposition 5.1 *1. If* $M = M_1 \oplus \cdots \oplus M_r$, then M has a KP filtration if and only if each M_i has.

2. If $0 \to L \to M \to N \to 0$ is exact and M and N have KP filtrations, then L also has a KP *filtration.*

Proof: 1. is easy since $\text{Ext}^1(M, N) = \bigoplus \text{Ext}^1(M_i, N)$ for any N. 2. also follows from Theorem 4.5, since if $0 \to L \to M \to N \to 0$ is an exact sequence then we have an exact sequence $\text{Ext}^1(M, A) \to$ $\text{Ext}^1(L, A) \to \text{Ext}^2(N, A)$ for any A. \Box

Using this, we can show that the tensor product of KP modules admits a KP filtration:

Theorem 5.2 ([Wat14b, Theorem 4.1]) *For any* $w, v \in S_{\infty}^{(n)}$, the module $S_w \otimes S_v$ have a KP filtration. **Outline of Proof:** First check the case $w = s_i$ (this corresponds to Monk's formula for Schubert polynomials) by explicitly constructing a filtration. Then we see that $S_{s_i} \otimes S_{s_j} \otimes \cdots \otimes S_{s_k} \otimes S_v$ have a KP filtration for any i, j, \ldots, k and $v \in S_{\infty}^{(n)}$, and by Proposition 5.1.1, $\bigwedge^{j_1} S_{s_{i_1}} \otimes \cdots \otimes \bigwedge^{j_r} S_{s_{i_r}} \otimes S_v$ have a KP filtration for any $i_1, j_1, \ldots, i_r, j_r$ and $v \in S_\infty^{(n)}$.

If $w \in S_n$, it can be shown, also using the cases of Monk's formula, that for suitable $i_1 \ldots, i_{n-1}$ there exists an exact sequence $0 \to S_w \to \Lambda^{i_1} S_{s_1} \otimes \cdots \otimes \Lambda^{i_{n-1}} S_{s_{n-1}} \to N \to 0$ such that N have a KP filtration whose subquotients are of the form S_u ($u^{-1} > w^{-1}$). Then the claim follows by the induction on w using the exact sequence $0 \to \mathcal{S}_w \otimes \mathcal{S}_v \to \bigwedge^{i_1} \mathcal{S}_{s_1} \otimes \cdots \otimes \bigwedge^{i_{n-1}} \mathcal{S}_{s_{n-1}} \otimes \mathcal{S}_v \to N \otimes \mathcal{S}_v \to 0$ and Proposition 5.1.2.

For a general w the claim follows by letting n large, since for $n' > n$, \mathfrak{b}_n -modules can be naturally identified with b_n -modules on which e_{ij} (j > n) acts by zero and under this identification the b_n -module \mathcal{S}_w $(w \in S_\infty^{(n)} \subset S_\infty^{(n')})$ corresponds to the $\mathfrak{b}_{n'}$ -module \mathcal{S}_w .

Remark 5.3 *As we pointed in [Wat14a] and [Wat14b], Theorem 5.2 gives a new description of generalized Littlewood-Richardson coefficients, in a manner somewhat similar to triple-intersection formula in the geometric theory of Schubert calculus: for* $u, v, w \in S_n$, *if the polynomial* $\mathfrak{S}_u \mathfrak{S}_v$ *is expanded into a* s um of Schubert polynomials, the coefficient of \mathfrak{S}_w is equal to the dimension of $\text{Hom}_{\mathfrak{b}}(\mathcal{S}_u\otimes\mathcal{S}_v,\mathcal{S}_{w_0w}^*\otimes\mathcal{S}_v)$ $(K_{\rho}) \cong \text{Hom}_{\mathfrak{b}}(\mathcal{S}_u \otimes \mathcal{S}_v \otimes \mathcal{S}_{w_0w}, K_{\rho}).$

As a corollary of Theorem 5.2, we can show that the plethystic composition of a Schur function with a Schubert polynomial is Schubert-positive:

Corollary 5.4 ([Wat14b, Corollary 4.3]) Let λ be a partition and s_{λ} be the corresponding Schur func*tion.* Let $w \in S_{\infty}^{(n)}$ and write \mathfrak{S}_w as a sum of monomials as $\mathfrak{S}_w = x^{\alpha} + x^{\beta} + \cdots$. Then $s_{\lambda}[\mathfrak{S}_w] :=$ $s_{\lambda}(x^{\alpha}, x^{\beta}, \ldots)$ *is a positive sum of Schubert polynomials.*

Proof: Let s_λ denote the Schur functor corresponding to λ (here we are using the same symbol as Schur functions, but we hope that it would cause no confusion). Then $s_{\lambda}(\mathcal{S}_{w})$ is a direct sum component of $\mathcal{S}_{w}^{\otimes |\lambda|}$, and thus, by Proposition 5.1.1 and Theorem 5.2, have a KP filtration. Thus the claim follows since s_{λ} [\mathfrak{S}_w] is the character of $s_{\lambda}(\mathcal{S}_w)$.

Remark 5.5 *The method we used here, i.e. the use of KP modules and highest-weight category theory for the study of Schubert positivity, is of course not only applicable for the proof of the positivity of product and plethystic composition but also for the investigation of other positivity properties of Schubert polynomials. For example, by considering the restriction of KP modules to certain subalgebra of* b *and using the similar method here (i.e. using highest-weight category theory to reduce the problem to the* s *implest case* \mathfrak{S}_{s_i} *), it can be shown that for any* $w \in S_\infty^{(n)}$ and $I = \{i_1 < \cdots < i_r\}$, $J = \{j_1 < \cdots < j_s\}$

with $I \sqcup J = \{1, \ldots, n\}$ *, the polynomial* $\mathfrak{S}_w(z_1, \ldots, z_n)$ ($z_k =$ $\int x_p (k = i_p)$ y_q $(k = j_q)$ *is a positive sum of*

polynomials of the form $\mathfrak{S}_u(x_1,\ldots,x_r)\mathfrak{S}_v(y_1,\ldots,y_s)$. As one of the referees pointed out, this result *appears in a work [BS98, Theorem 4.5.4] of Bergeron and Sottile, where the coefficient appearing in the restriction is related to the multiplication coefficients. It would be an interesting problem to investigate module-theoretic counterpart to this relation.*
