# ON THE LINK BETWEEN FINITE DIFFERENCES AND DERIVATIVES OF POLYNOMIALS

#### Abstract

The main aim of this paper to establish the relations between forward, backward and central finite and divided differences (that is discrete analog of the derivative) and partial and ordinary high-order derivatives of the polynomials.

## 1. Introduction

Let introduce the basic definition of finite difference. Finite difference is difference between function values with constant increment. There are three types of finite differences: forward, backward and central. Generally, the first order forward difference could be noted as: $\Delta_{h} f(x)=f(x+h)-f(x)$ backward, respectively, is $\nabla_{h} f(x)=f(x)-f(x-h)$ and central $\delta_{h} f(x)=f\left(x+\frac{1}{2} h\right)-f\left(x-\frac{1}{2} h\right)$, where $h=$ const, (see [1], [2], 3]). If increment is enough small, but constant, we can say that finite difference tends to derivative, but not equals. The error of this approximation could be counted next: $\frac{\Delta_{h} f(x)}{h}-f^{\prime}(x)=\mathcal{O}(h) \rightarrow 0$, where $h-$ increment, such that, $h \rightarrow 0$. By means of induction as well right for backward difference. More exact approximation we have using central difference, that is: $\frac{\delta_{h} f(x)}{h}-f^{\prime}(x)=\mathcal{O}\left(h^{2}\right)$, note that function should be twice differentiable. The finite difference is the discrete analog of the derivative (see [4]), the main distinction is constant increment of the function's argument, while difference to be taken. Backward and forward differences are opposite each other. More generally, high order finite differences (forward, backward and central respectively) could be denoted as (see [7]):

Let describe the main properties of finite difference operator, they are next (see [5])
(1) Linearity rules $\Delta(f(x)+g(x))=\Delta f(x)+\Delta g(x)$
$\delta(f(x)+g(x))=\delta f(x)+\delta g(x)$
$\nabla(f(x)+g(x))=\nabla f(x)+\nabla g(x)$
(2) $\Delta(C \cdot f(x))=C \cdot \Delta f(x), \nabla(C \cdot f(x))=C \cdot \nabla f(x)$, $\delta(C \cdot f(x))=C \cdot \delta f(x)$
(3) Constant rule $\Delta C=\nabla C=\delta C=0$.

Strictly speaking, divided difference (see [6]) with constant increment is discrete analog of derivative, when finite difference is discrete analogue of function's differential. They are close related to each other. Let define the divided difference

Definition 1.4. Divided difference of fixed increment definition (forward, centaral, backward respectively)

Hereby, divided diffrence could be represented from the finite difference, let be $j=i \pm$ const

Each properties, which holds for finite differences holds for divided differences as well.

## 2. Definitions for $x_{g}$ Distribution

Let be variable $x_{g}: x_{g}=g \cdot C, C=x_{g+1}-x_{g}=$ const, $C \in \mathbb{R} \rightarrow x_{g} \in \mathbb{R}, g \in \mathbb{Z}$. Define the finite difference of function of such argument, we take $C=h$ and rewrite forward, backward and central differences of some analytically defined function
$f\left(x_{i}\right)$ next way: $\Delta f\left(x_{i+1}\right)=f\left(x_{i+1}\right)-f\left(x_{i}\right), \nabla f\left(x_{i-1}\right)=f\left(x_{i}\right)-f\left(x_{i-1}\right), \delta f\left(x_{i}\right)=$ $f\left(x_{i+\frac{1}{2}}\right)-f\left(x_{i-\frac{1}{2}}\right)$. The $n$-th differences of such a function could be written as

Let be differences $\Delta f\left(x_{i+1}\right), \delta f\left(x_{i}\right), \nabla f\left(x_{i-1}\right)$, such that $i \in \mathbb{Z}$ and differences is taken starting from point $i$, which divides the space $\mathbb{Z}=\mathbb{Z}^{-} \cup \mathbb{Z}^{+}$symmetrically, this way we have $(i+1) \in \mathbb{Z}^{+},(i-1) \in \mathbb{Z}^{-}, i \in\left(\mathbb{Z}^{+}, \mathbb{Z}^{-}\right)$. Let derive some properties of that distribution:
(1) $\max \left(\mathbb{Z}^{-}\right)=\min \left(\mathbb{Z}^{+}\right)=i$
(2) Forward difference is taken starting from $\min \left(\mathbb{Z}^{+}\right)$, while backward from $\max \left(\mathbb{Z}^{-}\right)$
(3) $\operatorname{card}\left(\mathbb{Z}^{+}\right)=\operatorname{card}\left(\mathbb{Z}^{-}\right)$
(4) Maximal order of forward difference in which it is not equal to zero is $\max \left(\mathbb{Z}^{+}\right)$
(5) Maximal order of backward difference in which it is not equal to zero is $\min \left(\mathbb{Z}^{-}\right)$
(6) Maximal order of central difference in which it is not equal to zero is $\max \left(\mathbb{Z}^{+}\right)$
(7) Forward and backward difference equal each other by absolute value, while to be taken from $i=0$

## 3. Difference and derivative of power function

Since the $n$-order polynomial defined as sum of argument to power with higher power $n$, let describe a few properties of finite(divided) difference of power function.

Lemma 3.1. For any power function with natural number as exponent holds the equality between forward, backward and central divided differences, and derivative with order respectively to exponent and equals to exponent under factorial sign.

Proof. Let be function $f(x)=x^{n}, n \in \mathbb{N}$. The derivative of power function, $f^{\prime}(x)=$ $n x^{n-1}$, so $k$-th derivative $f^{(k)}(x)=n \cdot(n-1) \cdots(n-k+1) \cdot x^{n-k}, n>k$. Using limit notation, we have: $\lim _{m \rightarrow n^{-}} f^{(m)}(x)=f^{(n)}(x)=n$ !. Let rewrite expressions (2.1) 2.2, 2.3) according to definition $x_{i}=i \cdot \Delta x$, note that $\Delta x \equiv \nabla x \equiv \delta x$. By means of power function multiplication property $(i \cdot \Delta x)^{n}=i^{n} \cdot \Delta x^{n}$, we can rewrite the $n$-th finite difference equations (2.1, 2.2, 2.3) as follows

Using limit notation on (3.2), we obtain

=\sum_{k=0}^{n}\binom{n}{k}(-1)^{k} \cdot(i+n-k)^{n}=n!
\end{gathered}
$$

Similarly, going from (2.3), backward $n$-th difference equals:

\lim _{m \rightarrow n^{-}} \frac{\nabla^{m}\left(x_{i-1}^{n}\right)}{\nabla x^{m}}=\lim _{m \rightarrow n^{-}} \sum_{k=0}^{m}\binom{m}{k}(-1)^{k} \cdot(i-m+k)^{m} \\
=\sum_{k=0}^{n}\binom{n}{k}(-1)^{k} \cdot(i-n+k)^{n}=n!
\end{gathered}
$$

And $n$-th central (2.2)

\lim _{m \rightarrow n^{-}} \frac{\delta^{m} f\left(x_{i}\right)}{\delta x^{m}}=\lim _{m \rightarrow n^{-}} \sum_{k=0}^{m}\binom{m}{k}(-1)^{k} \cdot\left(i+\frac{m}{2}-k\right)^{m} \\
=\sum_{k=0}^{n}\binom{n}{k}(-1)^{k} \cdot\left(i+\frac{n}{2}-k\right)^{n}=n!
\end{gathered}
$$

As we can see, the $n$-th forward, backward and central divided(finite) differences of $n$-th power equal to same value, so they equal each other and we can to conclude

Definition 3.4. We introduce the difference equality operator $E(f)$, such that

Property 3.6. Let be central difference written as $\delta_{m} f\left(x_{i}\right)=f\left(x_{i+m}\right)-f\left(x_{i-m}\right)$ the $n$-th central difference of $n$-th power is $\delta^{n}{ }_{m}\left(x_{i}^{n}\right)=n!\cdot 2 m \cdot \delta x^{n}$, where $\delta x=$ $x_{i+m}-x_{i-m}=$ const

Going from lemma (3.1), we have next properties
(1) $\Delta^{k}\left(x_{i+1}^{k}\right)=$ const, $(i+1) \in \mathbb{Z}+: \max (\mathbb{Z}+)>k \longrightarrow \Delta^{k}\left(x_{i+1}^{k}\right) \equiv \Delta^{k}\left(x_{i}^{k}\right)$
(2) $\nabla^{k}\left(x_{i-1}^{k}\right)=$ const, $(i-1) \in \mathbb{Z}-: \min (\mathbb{Z}-) \ll k \longrightarrow \nabla^{k}\left(x_{i-1}^{k}\right) \equiv \nabla^{k}\left(x_{i}^{k}\right)$
(3) $\delta^{k}\left(x_{i}^{k}\right)=$ const, $i \in \mathbb{Z}+: \max (\mathbb{Z}+)>k \longrightarrow \delta^{k}\left(x_{i}^{k}\right) \equiv \delta^{k}\left(x_{i+j}^{k}\right)$
(4) $\forall([i+1] \in \mathbb{Z}+,[i-1] \in \mathbb{Z}-): \Delta^{k+j}\left(x_{i+1}^{k}\right)=\nabla^{k+j}\left(x_{i-1}^{k}\right)=0$,

Hereby, according to above properties, we can write the lemma (3.1) as

## 4. Difference of polynomials

Let be polynomial $P_{n}\left(x_{g}\right)$ defined as

Finite differences of such kind polynomial, are $\Delta P_{n}\left(x_{i}\right)=P_{n}\left(x_{i+1}\right)-P_{n}\left(x_{i}\right)$, $\nabla P_{n}\left(x_{i-1}\right)=P_{n}\left(x_{i}\right)-P_{n}\left(x_{i-1}\right), \delta P_{n}\left(x_{i}\right)=P_{n}\left(x_{i+\frac{1}{2}}\right)-P_{n}\left(x_{i-\frac{1}{2}}\right)$. Such way, according to properties (11. 2, (3) from section 1, so high order finite differences of polynomials could be written as:
$\Delta^{k} P_{n}\left(x_{i+1}\right)=\Delta^{k}\left(a_{0} \cdot x_{i+1}^{0}+\cdots+a_{n} \cdot x_{i+1}^{n}\right)=\Delta^{k}\left(a_{0} \cdot x_{i+1}^{0}\right)+\cdots+\Delta^{k}\left(a_{n} \cdot x_{i+1}^{n}\right)$
Backward difference, respectively, is
$\nabla^{k} P_{n}\left(x_{i-1}\right)=\nabla^{k}\left(a_{0} \cdot x_{i-1}^{0}+\cdots+a_{n} \cdot x_{i-1}^{n}\right)=\nabla^{k}\left(a_{0} \cdot x_{i-1}^{0}\right)+\cdots+\nabla^{k}\left(a_{n} \cdot x_{i-1}^{n}\right)$
And central

\delta^{k} P_{n}\left(x_{i}\right)=\delta^{k}\left(a_{0} \cdot x_{i}^{0}+\cdots+a_{n} \cdot x_{i}^{n}\right)=\delta^{k}\left(a_{0} \cdot x_{i}^{0}\right)+\cdots+\delta^{k}\left(a_{n} \cdot x_{i}^{n}\right)
$$

Above expressions hold for any build $n$-order polynomial.
Lemma 4.2. $\forall([i+1] \in \mathbb{Z}+,[i-1] \in \mathbb{Z}-): \Delta^{k+j}\left(x_{i+1}^{k}\right)=\nabla^{k+j}\left(x_{i-1}^{k}\right)=0, j>1$
Proof. According to lemma (3.1), the $n$-th difference of $n$-th power is constant, consequently, the constant rule (3) holds $\Delta C=\delta C=\nabla C=0$.

According to lemma (4.2) and properties (2, (3), we have limits:

& =\Delta^{n}\left(a_{n} \cdot x_{i+1}^{n}\right)=a_{n} \cdot \Delta^{n}\left(x_{i+1}^{n}\right) \\
& \delta^{k \rightarrow n} P_{n}\left(x_{i}\right)=\lim _{k \rightarrow n}\left\{\delta^{k}\left(a_{0} \cdot x_{i}^{0}\right)+\cdots+\delta^{k}\left(a_{n} \cdot x_{i}^{n}\right)\right\}  \tag{4.4}\\
& =\delta^{n}\left(a_{n} \cdot x_{i}^{n}\right)=a_{n} \cdot \delta^{n}\left(x_{i}^{n}\right) \\
& \nabla^{k \rightarrow n} P_{n}\left(x_{i-1}\right)=\lim _{k \rightarrow n}\left\{\nabla^{k}\left(a_{0} \cdot x_{i-1}^{0}\right)+\cdots+\nabla^{k}\left(a_{n} \cdot x_{i-1}^{n}\right)\right\}  \tag{4.5}\\
& =\nabla^{n}\left(a_{n} \cdot x_{i-1}^{n}\right)=a_{n} \cdot \nabla^{n}\left(x_{i-1}^{n}\right)
\end{align*}

Since the $n$-th difference of $n$-th power equals to $n!$, we have theorem.
Theorem 4.6. Each n-order polynomial has the constant $n$-th divided difference and derivative, which equals each other and equal constant times $n$ !.

Proof. According to limits (4.3, 4.4, 4.5), we have $\Delta^{n} P_{n}\left(x_{i+1}\right)=a_{n} \cdot \Delta^{n}\left(x_{i+1}^{n}\right)$, $\nabla^{n} P_{n}\left(x_{i-1}\right)=a_{n} \cdot \nabla^{n}\left(x_{i-1}^{n}\right), \delta^{n} P_{n}\left(x_{i}\right)=a_{n} \cdot \delta^{n}\left(x_{i}^{n}\right)$, going from lemma (3.1), the $n$-th difference of $n$-order polynomial equals to $k_{n} \cdot n$ !, the properties (1), 2, (3, (4) proofs that for enough large sets $\mathbb{Z}^{+}, \mathbb{Z}^{-}$we have $\Delta^{n}\left(x_{i+1}\right) \equiv \Delta^{n}\left(x_{i}\right), \delta^{n}\left(x_{i}\right) \equiv$ $\delta^{n}\left(x_{i+j}\right), \quad \nabla^{n}\left(x_{i-1}\right) \equiv \nabla^{n}\left(x_{i}\right), \min (\mathbb{Z}-)<n<\max (\mathbb{Z}+)$. Therefore, we have equality

Or, by means of definition (3.4)

## 5. Relation with Partial derivatives

Let be partial finite differences defined as

\Delta f\left(u_{1}, u_{2}, \ldots, u_{n}\right)_{u_{1}}:=f\left(u_{1}+h, u_{2}, \ldots, u_{n}\right)-f\left(u_{1}, u_{2}, \ldots, u_{n}\right)  \tag{5.1}\\
\delta f\left(u_{1}, u_{2}, \ldots, u_{n}\right)_{u_{1}}:=f\left(u_{1}+h, u_{2}, \ldots, u_{n}\right)-f\left(u_{1}-h, u_{2}, \ldots, u_{n}\right)  \tag{5.2}\\
\nabla f\left(u_{1}, u_{2}, \ldots, u_{n}\right)_{u_{1}}:=f\left(u_{1}, u_{2}, \ldots, u_{n}\right)-f\left(u_{1}-h, u_{2}, \ldots, u_{n}\right) \tag{5.3}
\end{gather*}

By means of mathematical induction, going from Lemma (3.1), we have equality between $n$-th partial derivative and $n$-th partial difference, while be taken of polynomial defined function or power function.

Theorem 5.4. For each $n$-th natural power of many variables the $n$-th partial divided differences and $n$-th partial derivatives equal each other.

Proof. Let be function $Z=f\left(u_{1}, u_{2}, \ldots, u_{n}\right)=\left(u_{1}, u_{2}, \ldots, u_{n}\right)^{n}$. We denote the equality operator of partial difference as $E\left(F\left(u_{1}, u_{2}, \ldots, u_{n}\right)\right)_{u_{k}}$, where $u_{k}$ is variable of taken difference. On this basis

Or, using equality operator

where $A$ is free constant, depending of relations between variables and $0 \leq k \leq$ $n$.

Property 5.7. Let be partial differences $\Delta f\left(u_{1}^{n}+u_{2}^{n}+u_{3}^{n}+\cdots+u_{k}^{n}\right)_{M}, \delta f\left(u_{1}^{n}+\right.$ $\left.u_{2}^{n}+u_{3}^{n}+\cdots,+u_{k}^{n}\right)_{M}, \nabla f\left(u_{1}^{n}+u_{2}^{n}+u_{3}^{n}+\cdots+u_{k}^{n}\right)_{M}$, where $M$ - set of variables, the $n$-th partial differences of each variables are

$$
\begin{align*}
& \Delta^{n} f\left(u_{1}^{n}, u_{2}^{n}, u_{3}^{n}, \cdots, u_{k}^{n}\right)_{u_{1}, u_{2}, u_{3}, \cdots, u_{k}}=k \cdot n!\left(\Delta u_{1}\right)^{n} \cdots\left(\Delta u_{k}\right)^{n}  \tag{5.8}\\
& \Delta^{n} f\left(u_{1}^{n}, u_{2}^{n}, u_{3}^{n}, \cdots, u_{k}^{n}\right)_{u_{1}, u_{2}, u_{3}, \cdots, u_{k}}=k \cdot n!\left(\delta u_{1}\right)^{n} \cdots\left(\delta u_{k}\right)^{n}  \tag{5.9}\\
& \nabla^{n} f\left(u_{1}^{n}, u_{2}^{n}, u_{3}^{n}, \cdots, u_{k}^{n}\right)_{u_{1}, u_{2}, u_{3}, \cdots, u_{k}}=k \cdot n!\left(\nabla u_{1}\right)^{n} \cdots\left(\nabla u_{k}\right)^{n}  \tag{5.10}\\
& \forall\left(u_{1}, u_{2}, u_{3}, \cdots, u_{k}\right) \in \mathbb{Z}: \max (\mathbb{Z})>n,\left(\delta u_{1}\right) \equiv\left(\delta u_{2}\right) \equiv \ldots \equiv\left(\delta u_{k}\right), \\
& \left(\nabla u_{1}\right) \equiv\left(\nabla u_{2}\right) \equiv \ldots \equiv\left(\nabla u_{k}\right),\left(\Delta u_{1}\right) \equiv\left(\Delta u_{2}\right) \equiv \ldots \equiv\left(\Delta u_{k}\right)
\end{align*}
$$

Theorem 5.11. For each non-single variable polynomial with order $n$ holds the equality between $k \leq n$-order partial differences and derivative.

Proof. Let be non-single variable polynomial

$$
\begin{equation*}
\mathcal{P}_{n}\left(u_{n}\right)=\sum_{i=1}^{n} M_{i} \cdot u_{i}^{i} \tag{5.12}
\end{equation*}
$$

Going from above property (5.7), the $k$-th partial differences of one variable are

$$
\begin{align*}
\Delta^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}}=M_{k} \cdot k!\cdot\left(\Delta u_{k}\right)^{k}, \delta^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}} & =M_{k} \cdot k!\cdot\left(\delta u_{k}\right)^{k}, \\
\nabla^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}} & =M_{k} \cdot k!\cdot\left(\nabla u_{k}\right)^{k} \tag{5.13}
\end{align*}
$$

$0 \leq k \leq n$. The $k$-th partial derivative:

$$
\begin{equation*}
\frac{\partial^{k} \mathcal{P}_{n}\left(u_{n}\right)}{\partial u_{k}^{k}}=M_{k} \cdot k! \tag{5.14}
\end{equation*}
$$

Hereby

$$
\begin{equation*}
\frac{\partial^{k} \mathcal{P}_{n}\left(u_{n}\right)}{\partial u_{k}^{k}}=\frac{\Delta^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}}}{\Delta u_{k}^{k}}=\frac{\delta^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}}}{\delta u_{k}^{k}}=\frac{\nabla^{k} \mathcal{P}_{n}\left(u_{n}\right)_{u_{k}}}{\nabla u_{k}^{k}} \tag{5.15}
\end{equation*}
$$

Also could be noted as

$$
\begin{equation*}
\frac{\partial^{k} \mathcal{P}_{n}\left(u_{n}\right)}{\partial u_{k}^{k}}=E\left(\mathcal{P}_{n}\left(u_{n}\right)\right)_{u_{k}}=M_{k} \cdot k!, \quad k \leq n \tag{5.16}
\end{equation*}
$$

## 6. The Error of approximation

From section 1 we know the link between ordinary finite differences and derivatives, that is

$$
\begin{aligned}
& \frac{\Delta_{h} f(x)}{h}-f^{\prime}(x)=\mathcal{O}_{1}(h) \\
& \frac{\delta_{h} f(x)}{h}-f^{\prime}(x)=\mathcal{O}_{1}\left(h^{2}\right)
\end{aligned}
$$

Note that for each particular error $\mathcal{O}_{k}(h)$ we use the index, respected to the order of derivative and difference.

Property 6.1. While difference to be taken of power function with positive natural exponent, holds the rule $\lim _{k \rightarrow j}\left(\frac{\Delta^{k} x^{n}}{\Delta x^{k}}-\frac{d^{k} x^{n}}{d x^{k}}\right)=\mathcal{O}_{j}(h): \mathcal{O}_{j}(h)<\mathcal{O}_{j+1}(h), j<n$ and finally $\forall(h \in \mathbb{R}): \mathcal{O}_{n}(h)=0$, i.e with increasing the order of difference the limiting behavior of derivative decreasing accordingly.

Proof. Generally, the big $\mathcal{O}$ notation is a mathematical notation, invented by Paul Bachmann and Edmund Landau (see [8], [9]), that describes the limiting behavior of a function when the argument tends towards a particular value or infinity. The $\mathcal{O}(x)$ could be defined as

$$
\mathcal{O}(x)=c \int g(x) d x-\int f(x) d x, \text { while } f(x) \leq c g(x)
$$

Taking that, if $f(x)=x^{n}$, we integrate (1.1) and obtain the recurrent relation

$$
\mathcal{O}_{k}(h)=\int_{0}^{\infty} \Delta_{h}^{k}\left(x^{n}\right) d x-\int_{0}^{\infty} f^{(k)}(x) d x
$$

Using limit notation, we obtain

$$
\lim _{k \rightarrow n}\left[\int_{0}^{\infty} \Delta_{h}^{k}\left(x^{n}\right) d x-\int_{0}^{\infty} f^{(k)}(x) d x\right]=\mathcal{O}_{k \rightarrow n}(h) \longrightarrow 0
$$

## 7. Summary

In this section we summarize the obtained results in the previous chapters and establish the relationship between them. According to lemma (3.1), theorems (4.6), (5.4), (5.11) we have concluded

$$
\begin{gather*}
\frac{d^{n} x^{n}}{d x^{n}}=E\left(x^{n}\right)=n!  \tag{7.1}\\
\frac{d^{n} P_{n}(x)}{d x^{n}}=E\left(P_{n}(x)\right)=a_{n} \cdot E\left(x^{n}\right)  \tag{7.2}\\
\frac{\partial^{n} Z}{\partial u_{k}^{n}}=E(Z)_{u_{k}}=A \cdot n!  \tag{7.3}\\
\frac{\partial^{k} \mathcal{P}_{n}\left(u_{n}\right)}{\partial u_{k}^{k}}=E\left(\mathcal{P}_{n}\left(u_{n}\right)\right)_{u_{k}}=M_{k} \cdot k! \tag{7.4}
\end{gather*}
$$

Generalizing these expressions, we can derive the general relations between ordinary, partial derivatives and finite (divided) differences

$$
\begin{gather*}
\underbrace{E\left(u^{n}\right)=E\left(P_{n}\left(u_{g}\right)\right)=E(Z)_{u_{k}}=E\left(\mathcal{P}_{n+j}\left(u_{n+j}\right)\right)_{u_{n}}}_{Y}  \tag{7.5}\\
\underbrace{\frac{d^{n} u^{n}}{d u^{n}}=\frac{d^{n} P_{n}(u)}{d u^{n}}=\frac{\partial^{n} Z}{\partial u_{k}^{n}}=\frac{\partial^{n} \mathcal{P}_{n+j}\left(u_{n+j}\right)}{\partial u_{n}^{n}}}_{U}, j \geq 0  \tag{7.6}\\
\forall\left(A, M_{n}, a_{n}\right)=1
\end{gather*}
$$

I.e the equalities holds with precision to constant. Function $Z$ defined as $Z=$ $f\left(u_{1}, u_{2}, \ldots, u_{n}\right)=\left(u_{1}, u_{2}, \ldots, u_{n}\right)^{n}$. And finally

$$
Y=U
$$

with same limitations.

## 8. Conclusion

In this paper were established the equality between ordinary and partial finite (divided) differences and derivatives of power function and polynomials, with order equal between each other.
