# Feedback boundary stabilization of 2d fluid-structure interaction systems

#### Abstract

We study the feedback stabilization of a system composed by an incompressible viscous fluid and a deformable structure located at the boundary of the fluid domain. We stabilize the position and the velocity of the structure and the velocity of the fluid around a stationary state by means of a Dirichlet control, localized on the exterior boundary of the fluid domain and with values in a finite dimensional space. Our result concerns weak solutions for initial data close to the stationary state. Our method is based on general arguments for stabilization of nonlinear parabolic systems combined with a change of variables to handle the fact that the fluid domain of the stationary state and of the stabilized solution are different. We prove that for initial data close to the stationary state, we can stabilize the position and the velocity of the deformable structure and the velocity of the fluid.

## 1 Introduction

We consider the problem of stabilization for a fluid-structure system composed by a viscous incompressible fluid and a deformable structure located at the boundary of the fluid domain. The fluid motion is modeled by the Navier-Stokes system and the structure deformation follows the equation of a "viscous" beam. Such a model is already considered by several authors (33], [10, etc.). Our aim consists in showing the boundary stabilization of such a system in the 2 d case and for weak solutions. The method used here could be adapted for other fluid-structure systems in the case of a fluid modeled by the Navier-Stokes system. In the 3d case or for strong solutions, the stabilization of such fluid-structure systems could be obtained by using the methodology developed in [6] or in 8].

Let us first describe more precisely the system considered in this paper. The domain of reference for the fluid is denoted by $\mathcal{F}_{\text {ref }}$. We assume that it is a smooth domain of $\mathbb{R}^{2}$ such that its boundary $\partial \mathcal{F}_{\text {ref }}$ contains a flat part $\Gamma_{\text {ref }}$. We can assume that $\Gamma_{\text {ref }}=(0,1) \times\{0\}$ and we set $\Gamma_{0} \stackrel{\text { def }}{=} \partial \mathcal{F}_{\text {ref }} \backslash \overline{\Gamma_{\text {ref }}}$.

On the part $\Gamma_{\text {ref }}$, we assume that there is a beam that can deform through the action of exterior forces and in particular the force due to the fluid. The fluid boundary is thus moving, $\Gamma_{\text {ref }}$ being transformed into

whereas $\Gamma_{0}$ remains unchanged. The new domain of fluid $\mathcal{F}(\eta(t, \cdot))$ is the interior of $\Gamma_{0} \cup \overline{\Gamma_{\text {str }}(\eta(t))}$. We assume that

and that $\Gamma_{0} \cap \Gamma_{\text {str }}(\eta(t))=\emptyset$ so that $\Gamma_{0} \cup \overline{\Gamma_{\text {str }}(\eta(t))}$ is a close, simple $C^{1}$ curve and this definition makes sense (see Figure 11).

The fluid-structure system that we consider reads as follows

Moreover, $f^{S}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}, b^{S}: \Gamma_{0} \rightarrow \mathbb{R}^{2}$ and $g^{S}:(0,1) \rightarrow \mathbb{R}$ are time-independent functions corresponding to a stationary state $\left(v^{S}, p^{S}, \eta^{S}\right)$ of the above system:

where the boundary value $b^{S}$ is supposed to satisfy $\int_{\Gamma_{0}} b^{S} \cdot n d \gamma=0$.
Finally, $u$ is a control function that we will search in a feedback form so that the corresponding solution $\left(v, \eta, \partial_{t} \eta\right)$ tends to the stationary solution $\left(v^{S}, \eta^{S}, 0\right)$ as $t \rightarrow \infty$. The precise statement of this convergence
is given below. Here $\Xi \in \mathcal{L}\left(\mathbf{L}^{2}\left(\Gamma_{0}\right)\right)$ is an operator used to localize the action of the control $u$ in a relatively compact subset of $\Gamma_{0}$ and such that $\int_{\Gamma_{0}} \Xi(u) \cdot n d \gamma=0$. Precisely, it can be defined by

where $\rho \in C^{2}\left(\Gamma_{0}\right)$ is a non zero function compactly supported in $\Gamma_{0}$ such that $\int_{\Gamma_{0}} \rho d \gamma=1$.
Before stating in details the main result, let us first rewrite systems $\sqrt[1.3]{ }$ and $\sqrt{1.8}$ in a more general way that allows to take into account the incompressibility of the fluid. A formal calculation yields

Consequently, it is natural to work with displacements $\eta$ with constant mean value along the time. For simplicity, we assume that the mean value of $\eta$ is zero:

With this assumption, we also have $\partial_{t t} \eta(t, \cdot) \in L_{0}^{2}(0,1)$ and from the boundary conditions 1.2 , we obtain $\partial_{s s} \eta(t, \cdot), \partial_{t s s} \eta(t, \cdot) \in L_{0}^{2}(0,1)$. Therefore, the equation for $\eta$ in 1.3 yields the following condition for all $t \geqslant 0$,

Note that an analogous condition can be imposed on $p^{S}$ to have $\eta^{S} \in L_{0}^{2}(0,1)$. These conditions imply that, in contrast to the Navier-Stokes system, the pressure is not determined up to a constant in this fluid-structure interaction system. To avoid to deal with this constraint we will use the orthogonal projection

The properties of these operators are described in Section 3 In particular their square roots $A_{1}^{1 / 2}$ and $A_{2}^{1 / 2}$ are well defined. We also denote by $(\cdot, \cdot)_{\mathcal{H}_{\mathcal{S}}}$ the usual scalar product of $L^{2}(0,1)$.

With the above notation, systems 1.3 and 1.8 rewrite:

In above settings $\mathbf{1}_{\Gamma_{0}}$ denotes the characteristic function of $\Gamma_{0}$.
Our aim is to use the control $u$ in $\sqrt{1.3}$ in order to "reach" the above stationary state. More precisely, we impose a feedback law depending on the difference between $\left(v(t, \cdot), \eta(t, \cdot), \partial_{t} \eta(t, \cdot)\right)$ and $\left(v^{S}, \eta^{S}, 0\right)$ in order to obtain that the difference between these states goes to 0 exponentially.

Such results of stabilization are classical for the classical Navier-Stokes system (without any structure), see for instance, [23], 38, [9], 37, [2], [5], etc. Note that for this problem there is a difference between the dimension 2 and the dimension 3: due to the nonlinearity in the Navier-Stokes system, and to the method developed (stabilization of the linearized system, fixed point), in dimension 2 one can take initial data in $L^{2}$ ( or $H^{s}, s<1 / 2$ ), whereas in dimension 3, one needs to take the initial data in $H^{1}$ (or at least $H^{s}, s \geqslant 1 / 2$ ). As a consequence, in dimension 3 , we have to impose compatibility condition at $t=0$ between the initial condition and the feedback control $u$ (see [4, 3, 2] for details). Several techniques have been considered to overcome this difficulty: 34, 2], 5], etc. For instance in [5], the solution consists in assuming that the control $u$ satisfies an evolution equation with another feedback control. We are thus reduced to stabilize a system coupling the fluid velocity and the control $u$. In dimension 2 , the method allows to consider classical feedback operators for weak solutions. This is done for the Navier-Stokes system in 38 . Note that in dimension 2, the stabilization of strong solutions leads to the same problem of compatibility conditions.

For the fluid-structure interaction systems, there are few results of stabilization. A first result was obtained in 36 for the system considered in this article. The target velocity $v^{S}$ is zero, the control is acting in the whole structure and the author works with strong solutions (initial data in $H^{1}$ for the fluid velocity). The case of a deformable structure immersed in a fluid is considered in 19, 18. For the case of a rigid body, a 1 d simplified model is treated in [7] whereas the 2 d and 3 d case are considered in 6]. In this last paper, we work with a notion of weak solutions in order to deal with the 2 d case without the problem of the compatibility conditions. However, in [6] we need that the initial and the final position of the structure are equal.

The main novelty of this work is to prove stabilizability result for weak solutions of a fluid-structure system. Moreover, we consider a nontrivial target velocity $v^{S}$ to be stabilized. We work in the 2d case only and the method for the stabilization follows the same idea as the papers quoted above. One important difficulty that we need to deal with is that there is no proof in the literature for the existence of weak solutions of a fluid-structure system with a Banach fixed point. In order to do this here, a first step consists in performing a change of variables to work on a cylindrical domain (see Section 2). Such an approach is already considered for strong solutions and there exists changes of variables that allow to keep the divergence free conditions and the form of the boundary conditions. We don't employ such a change of variables on the unknowns but on the test functions. This leads to transform our system in a cylindrical domain with non homogeneous divergence conditions and non homogeneous boundary conditions. We can overcome the corresponding difficulty by using a framework developed in 39 for the Navier-Stokes system. All this work could be adapted to other fluid-structure systems such as the case of rigid bodies moving into a viscous incompressible fluid as in [6]. Indeed, the presence here of the deformable structure that follows a beam equation leads to lots of technical difficulties (see the three sections in the appendix).

Let us also mention that several works have been devoted to the study of the fluid-plate system. The model was proposed in [33]. The existence of weak solutions was proved in [16] and the existence of strong solutions was obtained in 10 and in 29 . For these two results, as in our case, the damping term, that is $-\delta \partial_{t s s} \eta$, is essential. In [24], the author manages to prove the existence of weak solutions (in 2 d or in 3 d ) for this problem in the case without damping $(\delta=0)$.

Let us write the weak formulations for both systems 1.18 and 1.19 . Assume

One of the difficulties, that is classical in fluid-structure interaction problems, is coming from the fact that the solutions and the test functions of 1.18 and of 1.19 are not written in the same spatial domains. To overcome this issue, we transform the system 1.18 by using a change of variables $X$ such that $X\left(t, \mathcal{F}\left(\eta^{S}\right)\right)=$ $\mathcal{F}(\eta(t, \cdot))$ and $X\left(t, \Gamma_{\text {str }}\left(\eta^{S}\right)\right)=\Gamma_{\text {str }}(\eta(t, \cdot))$, and also such that $X(t, \cdot)=\mathrm{Id}$ on $\Gamma_{0}$ for all $t$. More precisely, here we use a change of variables depending on time through a dependance on $\eta(t)$ only: we choose the particular form $X(t, \cdot)=X_{\eta(t)}$ for all $t \geqslant 0$ where, for any deformation $\eta \in H_{0}^{2}(0,1), X_{\eta}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ satisfies $X_{\eta}\left(\mathcal{F}\left(\eta^{S}\right)\right)=\mathcal{F}(\eta)$ and

Note that we will obtain that $X_{\eta(t)}$ is a $C^{1}$-diffeomorphism of $\mathbb{R}^{2}$ into itself for all $t \geqslant 0$ by assuming that $\eta$ is a continuous bounded function in time with values in $C^{1}([0,1])$ and is close to $\eta^{S}$.

The change of variables also allows us to describe the feedback law satisfied by $u$ in 1.3 . We take $u$ under the form

3. we have $v=b^{S}+\Xi(u)$ on $(0,+\infty) \times \Gamma_{0}$, with $u$ obtained through $1.29-1.31$;
4. relation 1.23 holds for all $(\varphi, \zeta) \in C_{0}^{1}\left([0, \infty) ; C^{1}(\overline{\mathcal{F}(\eta(t))}) \times\left(C^{2}([0,1]) \cap L_{0}^{2}(0,1)\right)\right)$ satisfying 1.20$)$ 1.22 .

We refer to Section 2.1 for the precise definition of the functional spaces used above.
Theorem 1.2. Assume

Remark 1.3. Note that assumption $\mathcal{F}\left(\eta^{S}\right)$ of class $C^{1,1}$ allows us to freely use $H^{2}$-regularity results for the Laplace equation and for the Stokes equations. It is also a natural assumption because, even if the reference domain $\mathcal{F}_{\text {ref }}$ and $\eta^{S}$ are regular, the boundary conditions $\eta^{S}=\partial_{s} \eta^{S}=0$ on $\{0,1\}$ do not guarantee a class of regularity for $\mathcal{F}\left(\eta^{S}\right)$ better than $C^{1,1}$.
Remark 1.4. The family $\left[\varphi_{j}, \zeta_{j}^{1}, \zeta_{j}^{2}\right], j=1, \ldots, N_{\sigma}$ can be obtained for instance from $\left[\varphi_{j}, \zeta_{j}^{1}, \zeta_{j}^{2}\right]=L v_{j}$ where $L$ is finite rank linear operator on $\mathbf{L}^{2}\left(\mathcal{F}\left(\eta^{S}\right)\right) \times\left(H_{0}^{2}(0,1) \cap \mathcal{H}_{S}\right) \times \mathcal{H}_{S}$ independent of $j$ which can be computed from the solution of a finite dimensional Riccati equation, see [5, 8] or [37] for details.

Remark 1.5. The uniqueness of the controlled weak solution (in the sense of Definition 1.1) is not proved in Theorem 1.2. Since the proof relies on a Banach fixed point argument it is indeed true that the solution is unique within a class of stable solutions sufficiently close to the stationary state. But uniqueness is not obtained in the classical energy space defined by 1.32 . The uniqueness of weak solution is not an easy issue, even under the hypothesis of small initial data. It must be the subject of further investigations.

Remark 1.6. Using the method developed here, we can obtain the same result for other fluid-structure systems. For instance, we could obtain the stabilization of weak solutions for the case where the structure is a rigid body (see [6]). One could also consider the case of a deformable structure in the case where the equation of deformation is approximated by a finite dimensional method: see [20], [28], [14]. For these cases, the fixed point and the estimates are simpler than here. The case of a deformable structure modeled by the Lame equation or by the wave equation with an adequate damping can also obtained directly from our work. For other damping laws or without damping, even the well-posedness is not always done and the corresponding stabilization problems have to be studied differently. Let us quote some references on the well-posedness of such systems: [15], [12], [13], [30], [40], etc.

The outline of the paper is as follows. In Section 2, we construct the change of variables and we rewrite the system in a fixed domain. We then obtain the system satisfied by the difference between the controlled solution and the stationary state. By linearizing this system, we obtain in Section 3 the coupled system (3.1)(3.4) that couples an Oseen's type system with a beam type system with dissipation. With this dissipation, we prove that the semigroup associated with system $(3.1-(3.4)$ is analytic. That allows us to use the general
theory developed in [5, 8 , to deduce in Section 4 the feedback stabilization of our linear system, first in the homogeneous case and then in the non homogeneous case (and in particular with terms corresponding to the non null divergence condition and non null boundary condition). In Section 5 , we use a fixed point procedure to obtain the stabilization of the nonlinear system and thus to prove the main result. In the appendix, we postpone technical proofs to the three sections: Section $A$ is devoted to the change of variables, Section B to the linearization, and Section $\mathbb{C}$ to some estimates for the fixed point.

## 2 Notation and change of variables

### 2.1 Notation

The classical Lebesgue and Sobolev spaces are written $L^{\alpha}, H^{k}$ and we denote by $C_{b}$ the continuous and bounded maps. We use the bold notation for the spaces of vector fields: $\mathbf{L}^{\alpha}=\left(L^{\alpha}\right)^{2}, \mathbf{H}^{k}=\left(H^{k}\right)^{2}$ etc. For a Hilbert space $\mathcal{X}$ and $0<T \leqslant+\infty, L^{p}(0, T ; \mathcal{X})$ and $H^{s}(0, T ; \mathcal{X}), p \in[1, \infty], s \geqslant 0$, are usual vector-valued Lebesgue and Sobolev spaces and in the case $T=+\infty$, we use the shorter expressions $L^{p}(\mathcal{X}) \stackrel{\text { def }}{=} L^{p}(0,+\infty ; \mathcal{X})$ and $H^{s}(\mathcal{X}) \stackrel{\text { def }}{=} H^{s}(0,+\infty ; \mathcal{X})$. We denote by $L_{\mathrm{loc}}^{2}(0, T ; \mathcal{X})$ (resp. $\left.H_{\mathrm{loc}}^{s}(0, T ; \mathcal{X})\right)$ the set of functions belonging to $L^{2}(0, T ; \mathcal{X})$ (resp. $\left.H^{s}(0, T ; \mathcal{X})\right)$ for all $T>0$. For two Hilbert spaces $\mathcal{X}, \mathcal{Y}$ we write $W(\mathcal{X}, \mathcal{Y}) \stackrel{\text { def }}{=} L^{2}(\mathcal{X}) \cap H^{1}(\mathcal{Y})$.

If $\mathcal{Z}$ is a vector-valued function space of the time variable $t \geqslant 0$, for $\sigma>0$ we use the subscript $\sigma$ in $\mathcal{Z}_{\sigma}$ to denote the space

We use the notation $(\mathcal{X})^{\prime}$, or simply $\mathcal{X}^{\prime}$, for the dual space of $\mathcal{X}$, we use the notation $\mathcal{L}(\mathcal{X}, \mathcal{Y})$ for the bounded linear maps from $\mathcal{X}$ into $\mathcal{Y}$ and the notation $\mathcal{X} \hookrightarrow \mathcal{Y}$ for the continuous embedding of $\mathcal{X}$ into $\mathcal{Y}$. Moreover, $[\mathcal{X}, \mathcal{Y}]_{\theta}$ denotes the complex interpolation space of index $\theta \in(0,1)$. If $\mathcal{X} \hookrightarrow \mathcal{Y}$ the following continuous embeddings hold for all $\theta \in(0,1)$ and $s \in(1 / 2,1]$ :

The first above embedding is an easy consequence of the fact that $[\mathcal{X}, \mathcal{Y}]_{1 /(2 s)}$ is the trace space of $L^{2}(\mathcal{X}) \cap$ $H^{s}(\mathcal{Y})$, see e.g. [25]. The second one comes from the equality $\left[L^{2}(\mathcal{X}), H^{s}(\mathcal{Y})\right]_{\theta}=H^{\theta s}\left([\mathcal{X}, \mathcal{Y}]_{\theta}\right)$ (see Theorem 5.1 and (6.8) in [27]) combined with the embedding $L^{2}(\mathcal{X}) \cap H^{s}(\mathcal{Y}) \hookrightarrow\left[L^{2}(\mathcal{X}), H^{s}(\mathcal{Y})\right]_{\theta}$.

In order to simplify the notation, we write in what follows

We also use functional spaces of type $L^{2}\left(0, \infty ; \mathbf{H}^{1}(\mathcal{F}(\eta(t)))\right)$. Such a space is defined through a family $\{X(t, \cdot)\}_{t \geqslant 0}$ of $C^{1}$-diffeomorphisms that transforms $\mathcal{F}$ onto $\mathcal{F}(\eta(t, \cdot))$ and such that both $X$ and $X^{-1}$ belong to $C_{b}\left(\mathbf{C}^{1}(\overline{\mathcal{F}})\right)$. We say that $v \in L^{2}\left(0, \infty ; \mathbf{H}^{1}(\mathcal{F}(\eta(t)))\right)$ if $v \circ X \in L^{2}\left(\mathbf{H}^{1}(\mathcal{F})\right)$. It can be seen that the above definition of $L^{2}\left(0, \infty ; \mathbf{H}^{1}(\mathcal{F}(\eta(t)))\right)$ is independent of the choice of $X$. For instance, if $\eta \in C_{b}\left(C^{1}([0,1])\right)$ one can choose the family of change of variables $\left\{X_{\eta(t)}\right\}_{t \geqslant 0}$ introduced in Section 2.2 below. Other spaces of functions defined on a non cylindrical domain of $\mathbb{R}^{3}$ are defined similarly: $C_{b}\left([0, \infty) ; \mathbf{L}^{2}(\mathcal{F}(\eta(t)))\right)$, $C^{1}\left([0, \infty) ; \mathbf{C}^{1}(\overline{\mathcal{F}(\eta(t))})\right.$, etc.

In what follows, $C>0$ denotes a generic constant that may change from line to line and which is independent on the other terms of the relation where it is used.

### 2.2 Construction of the change of variables

We transform the system written in the non cylindrical domain

We consider the set

We consider $\widehat{\theta} \in C_{c}^{\infty}(\mathbb{R})$ such that $\widehat{\theta} \equiv 1$ in $(-\alpha / 2, \alpha / 2)$ and $\widehat{\theta} \equiv 0$ in $\mathbb{R} \backslash(-\alpha, \alpha)$, and for ( $\left.y_{1}, y_{2}\right) \in \mathbb{R}^{2}$ we define $\theta\left(y_{1}, y_{2}\right) \stackrel{\text { def }}{=} \widehat{\theta}\left(y_{2}-\eta^{S}\left(y_{1}\right)\right)$. Then $\theta \in C^{3}\left(\mathbb{R}^{2}\right)$ and for a given function $\eta \in H_{0}^{2}(0,1)$ we define the change of variables:

As a consequence, $X_{\eta} \in \mathbf{H}^{2}\left(\mathbb{R}^{2}\right)$. From the continuous embedding $H_{0}^{2}(0,1) \hookrightarrow C^{1}([0,1])$ we also deduce that $X_{\eta} \in \mathbf{C}^{1}\left(\mathbb{R}^{2}\right)$. Moreover, we can check that for $\left(y_{1}, y_{2}\right) \in \mathbb{R}^{2}$,

In what follows, we will construct a solution $t \mapsto \eta(t)$ in $C_{b}\left(H_{0}^{2}(0,1)\right)$ such that

In what follows, we will use the simplified notation

\forall t \geqslant 0, \quad X(t, \cdot)=\operatorname{Id} \quad \text { in } \overline{\mathcal{F}} \backslash \mathcal{V}_{\alpha}
$$

and

\forall t \geqslant 0, \quad \nabla X(t, \cdot)=I_{2} \quad \text { in } \overline{\mathcal{F}} \backslash \mathcal{V}_{\alpha} .
$$

In the sequel, we use the above relation on $\Gamma_{0}$.
Finally, for a $2 \times 2$ matrix $M$ we denote by $\operatorname{Cof}(M)$ the cofactor matrix and we recall the classical relations

We remark that 2.7), 2.6 imply $\operatorname{det}(\nabla X)>0$ and using 2.9) we deduce that for $v, \varphi$ in $L^{2}\left(\mathbf{L}^{2}(\mathcal{F}(\eta(t)))\right)$,

where $\widetilde{v}(t, y)=\nabla X(t, y)^{*} v(t, X(t, y))$ and $\widetilde{\varphi}(t, y)=\operatorname{Cof}(\nabla X(t, y))^{*} \varphi(t, X(t, y))$. It is such an observation that motivates the change of variables that are introduced in the next section (see 2.11) and 2.15) below).

### 2.3 Rewriting the system (1.3) in a fixed domain

In this section we assume 2.8 . Our change of variables is defined by

Remark 2.1. We could have used the change of variables $\widetilde{v}(t, y) \stackrel{\text { def }}{=} v(t, X(t, y))$ or, as in 41] or [14], $\widetilde{v}(t, y) \stackrel{\text { def }}{=} \operatorname{Cof}(\nabla X(t, y))^{*} v(t, X(t, y))$. The advantage of the latter choice is that it preserves the divergence free condition. Here we use this formula to transform the test function $\varphi$, see 2.15 below.

We have the following results (the technical proof is postponed in Section A.1.

&-\left(A_{2}^{1 / 2} \eta_{1}^{0}, A_{2}^{1 / 2} \zeta(0)\right)_{\mathcal{H}_{\mathcal{S}}}-\int_{\mathbb{R}_{+}}\left(A_{2}^{1 / 2} \eta, A_{2}^{1 / 2} \partial_{t} \zeta\right)_{\mathcal{H}_{\mathcal{S}}} d t=\int_{\mathbb{R}_{+}} \int_{\mathcal{F}}(\nabla X)^{*}\left(f^{S} \circ X\right) \cdot \widetilde{\varphi} d y d t+\int_{\mathbb{R}_{+}}\left(g^{S}, \zeta\right)_{\mathcal{H}_{\mathcal{S}}} d t \tag{2.18}
\end{align*}
$$

where

$$
\xi \stackrel{\text { def }}{=} \eta-\eta^{S}
$$

where $\widetilde{v}^{0} \stackrel{\text { def }}{=} \nabla X(0, y)^{*} v^{0}(X(0, y))$, where $\mathcal{M}_{\xi}^{\sqrt[1]{1}}=\mathcal{M} \sqrt[{\sqrt{3}}]{\xi}+\mathcal{M} \xi_{\xi}^{\sqrt[5]{2}}, \mathcal{M} \frac{\sqrt[2]{2}}{\xi}=\mathcal{M}_{\xi}^{\sqrt[4]{4}}+\mathcal{M}_{\xi}^{\sqrt[6]{6}}$ are linear mappings depending on $\xi$ given in Lemma A.1 and Lemma $\sqrt{\text { A.2 }}$ and where $\mathcal{B}_{\xi}^{\sqrt[11]{1}}, \mathcal{B}_{\xi}^{\sqrt{2}}$ are bilinear mappings depending on $\xi$ given in Lemma A.3. Note that 2.10 is used to transform 1.23 into 2.18 .

Since $\left(v^{S}, \eta^{S}\right)$ is independent in time, we have

Now, we can decompose the above operators in a linear part and surlinear part. First, we define the sets of type $\mathcal{Q}_{i}\left(\alpha_{1}, \ldots, \alpha_{k}\right)$ where $i, k \in \mathbb{N}$. They are the sets of polynomials in the variables $\alpha_{1}, \ldots, \alpha_{k}$ and with coefficients that are Lipschitz continuous functions of $y \in \mathbb{R}^{2}$ and of $\xi$ and that vanish in $\overline{\mathcal{F}} \backslash \overline{\mathcal{V}_{\alpha}}$ (see (2.4), and such that the degree of its nonzero monomial of lowest degree is greater or equal to $i$. For instance, we can write

More precisely, we only need to assume that $A_{1}: \mathcal{D}\left(A_{1}\right) \subset \mathcal{H}_{\mathcal{S}} \rightarrow \mathcal{H}_{\mathcal{S}}$ and $A_{2}: \mathcal{D}\left(A_{2}\right) \subset \mathcal{H}_{\mathcal{S}} \rightarrow \mathcal{H}_{\mathcal{S}}$ are positive, densely defined, self-adjoint and with compact resolvents and that $\mathcal{D}\left(A_{1}^{1 / 2}\right) \hookrightarrow \mathcal{D}\left(A_{2}\right)$,

Assumption (3.5) is crucial in our analysis since it allows to invoke 17 and to obtain the analyticity of the semigroup generated by the underlying linear operator of system $\sqrt{3.1}-(\sqrt{3.4}$ (see Proposition 3.11 below). We suppose that $T \in \mathcal{L}\left(\mathcal{H}_{\mathcal{S}}, \mathbf{V}^{0}(\partial \mathcal{F})\right)$ satisfies 2.55), 2.57), 2.56), (2.58), that $(T \xi)_{\Gamma_{0}} \equiv 0$ for any $\xi \in \mathcal{H}_{\mathcal{S}}$. Finally, the operators $\Lambda^{(1)}, \Lambda^{(2)}$ are assumed to satisfy $(2.59),(2.60),(2.61),(2.62)$ and $\sqrt{2.631}$. Note that the operators $A_{1}, A_{2}, T, \Lambda^{(1)}$ and $\Lambda^{(2)}$ defined by (1.16), 1.17), (2.28) and (2.44) satisfy the above conditions.

We still assume that $\Xi \in \mathcal{L}\left(\mathbf{L}^{2}(\partial \mathcal{F})\right)$ is the self-adjoint operator defined by 2.29). We need its precise definition to obtain the adjoint of the control operator (see (3.67) below). We recall that $\Xi$ satisfies 2.53 .

We first consider system (3.1-3.4 in the case $F=0, G=0, F_{\text {div }}=0$ and $F_{b}=0$ :

The above system is completed with the initial conditions

where $A$ is the infinitesimal generator of an analytic semigroup. This abstract form is quite standard in the study of the stabilizability for the Navier-Stokes system, see 35].

We consider the space $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$ equipped with the scalar product:

Let us define $\mathbb{P}$ the orthogonal projection of $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$ onto $\mathcal{H}$.
We have the following characterization of the orthogonal of $\mathcal{H}$ in $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$.
Proposition 3.1. The orthogonal of $\mathcal{H}$ in $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$ is given by

Then we have in particular that $\int_{\mathcal{F}} w^{(1)} \cdot w^{(2)} d y=0$ for all $w^{(2)} \in \mathbf{V}_{0}^{1}(\mathcal{F})$ and the De Rham Lemma guarantees that $w^{(1)}=\nabla p$ for some $p \in H^{1}(\mathcal{F})$ such that $\int_{\mathcal{F}} p d y=0$, see 42, Chap. I, Prop. 1.1 and Rem 1.4]. Thus, by plugging $w^{(1)}=\nabla p$ in (3.15) and integrating by parts, we obtain that

Proposition 3.2. The orthogonal projection operator $\mathbb{P}: \mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}} \rightarrow \mathcal{H}$ satisfies for $s \in[0,1]$ :

From (3.17), we deduce that

For $s=1$, we take $\left[w, \xi_{1}, \xi_{2}\right] \in \mathbf{H}^{1}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{3 / 4}\right) \times \mathcal{D}\left(A_{1}^{1 / 4}\right)$. Then, we deduce from 2.56] and from the $C^{1,1}$ regularity of $\partial \mathcal{F}$ that $\left(T \xi_{2}\right) \cdot n \in H^{1 / 2}(\partial \mathcal{F})$. Similarly, from 2.56 and 2.57) we get

Proposition 3.4. The operator $A_{0}$ defined by $3.19-3.21$ is densely defined with compact resolvent and it is the infinitesimal generator of a strongly continuous semigroup of contractions on $\mathcal{H}$.

Proof. Standard calculation gives, for all $\mathbf{Z} \in \mathcal{D}\left(A_{0}\right),\left\langle A_{0} \mathbf{Z}, \mathbf{Z}\right\rangle \leqslant 0$ which implies that $A_{0}$ is dissipative. Then, we show that $\left(\lambda-A_{0}\right)$ is onto for some $\lambda>0$ : assume $\mathbf{F}=[f, g, h] \in \mathcal{H}$, we have to prove the existence and the uniqueness of $\mathbf{Z}=\left[w, \xi_{1}, \xi_{2}\right] \in \mathcal{D}\left(A_{0}\right)$ such that

& +\frac{1}{\lambda}\left(A_{1}^{1 / 2} \xi_{2}, A_{1}^{1 / 2} \zeta_{2}\right)_{\mathcal{H}_{\mathcal{S}}}=\int_{\mathcal{F}} f \cdot \varphi d y+\left(h, \zeta_{2}\right)_{\mathcal{H}_{\mathcal{S}}}-\frac{1}{\lambda}\left(A_{1}^{1 / 2} g, A_{1}^{1 / 2} \zeta_{2}\right)_{\mathcal{H}_{\mathcal{S}}} . \tag{3.24}
\end{align*}

The Riesz theorem gives the existence and uniqueness of $\left[w, \xi_{2}\right] \in \mathbb{V}$ satisfying (3.24). Taking $\zeta_{2}=0$ in (3.24) and using the De Rham theorem, we obtain the existence of $q$ such that $(w, q)$ is the weak solution of the Stokes system (the three first equations of $(3.22)$. From 2.56 , we deduce $T \xi_{2} \in \mathbf{V}^{3 / 2}(\partial \mathcal{F})$ and thus, since $f \in \mathbf{L}^{2}(\mathcal{F})$, standard elliptic results on the Stokes system give $w \in \mathbf{H}^{2}(\mathcal{F})$ and $q \in H^{1}(\mathcal{F})$. In particular, $\mathbb{T}(w, q) n \in \mathbf{H}^{1 / 2}(\partial \mathcal{F})$ and thus $T^{*}(\mathbb{T}(w, q) n) \in \mathcal{H}_{\mathcal{S}}$.

We write $\xi_{1}=\lambda^{-1}\left(\xi_{2}+g\right)$ and we use that $(w, q)$ satisfies the Stokes system to transform 3.24) into

for all $\zeta_{2} \in \mathcal{D}\left(A_{1}^{1 / 2}\right)$. Note that we have used the continuous embedding $D\left(A_{1}^{1 / 2}\right) \hookrightarrow D\left(A_{2}\right)$. The above system implies that $A_{1} \xi_{1} \in \mathcal{H}_{\mathcal{S}}$ and thus that $\xi_{1} \in \mathcal{D}\left(A_{1}\right)$. Finally, the fact that $A_{0}$ is densely defined with compact resolvent is straightforward.

Proposition 3.5. The semigroup generated by $A_{0}$ is exponentially stable on $\mathcal{H}$.
Proof. To show the exponential stability of the semigroup, we use the classical result of Gearhart (see, for instance, [31, Theorem 1.3.2, p.4]): since $\left(e^{t A}\right)_{t>0}$ is a $C_{0}$-semigroup of contractions on the Hilbert space $\mathcal{H}$ (see Proposition 3.4, then it is exponentially stable if and only if

Moreover, since $\Gamma_{0}$ is a nonempty open subset such that $w=0$ on $\Gamma_{0}$, we have the Poincaré inequality $\|w\|_{\mathbf{H}^{1}(\mathcal{F})} \leqslant C\|\nabla w\|_{\mathbf{L}^{2}(\mathcal{F})}$. Combining this relation with the trace inequality, the Korn inequality and 2.55 , we deduce that:

More precisely, $\left[w, \xi_{1}, \xi_{2}\right] \mapsto\left[w-D_{0} \xi_{2}, \xi_{1}, \xi_{2}\right]$ is an isomorphism from $\mathcal{D}\left(A_{0}\right)$ onto $\mathbf{V}_{0}^{2}(\Omega) \times \mathcal{D}\left(A_{1}\right) \times \mathcal{D}\left(A_{1}^{1 / 2}\right)$ as well as from $\mathcal{H}$ onto $\mathbf{V}_{n}^{0}(\Omega) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$. |\tau|\left(\left\|A_{1}^{1 / 2} \xi_{1}\right\|_{\mathcal{H}_{\mathcal{S}}}+\left\|\xi_{2}\right\|_{\mathcal{H}_{\mathcal{S}}}\right) \leqslant C\left(\left\|T^{*}(\mathbb{T}(w, q) n)\right\|_{\mathcal{H}_{\mathcal{S}}}+\left\|A_{1}^{1 / 2} g\right\|_{\mathcal{H}_{\mathcal{S}}}+\|h\|_{\mathcal{H}_{\mathcal{S}}}\right) . \tag{3.47}
\end{equation*}
$$

Then by combining (3.46, (3.47) and the boundedness of $T^{*}: \mathbf{L}^{2}(\partial \mathcal{F}) \rightarrow \mathcal{H}_{\mathcal{S}}$ we deduce that:

Using Proposition 3.2 and Proposition 3.8. we have $\mathbb{P}\left[\varphi, \zeta_{1}, 0\right] \in \mathcal{D}\left(\left(-A_{0}\right)^{\epsilon}\right)$. Then we can write

& =\left|\left\langle\left[w, \xi_{1}, \xi_{2}\right], \mathbb{P}\left[\varphi, \zeta_{1}, 0\right]\right\rangle_{\mathcal{H}}\right| \\
& \leqslant\left\|\left[w, \xi_{1}, \xi_{2}\right]\right\|_{\left(\mathcal{D}\left(\left(-A_{0}\right)^{\epsilon}\right)\right)^{\prime}}\left\|\mathbb{P}\left[\varphi, \zeta_{1}, 0\right]\right\|_{\left.\mathcal{D}\left(\left(-A_{0}\right)^{\epsilon}\right)\right)} \\
& \leqslant C\left\|\left[w, \xi_{1}, \xi_{2}\right]\right\|_{\left(\mathcal{D}\left(\left(-A_{0}\right)^{\epsilon \epsilon}\right)^{\prime}\right.}\left(\|\varphi\|_{\mathbf{H}^{2 \epsilon}(\mathcal{F})}+\left\|\zeta_{1}\right\|_{\mathcal{D}\left(A_{1}^{1 / 2+\epsilon / 2}\right)}\right) .
\end{aligned}

Consequently, we deduce 3.51) and combining it with 3.50 yields

Proposition 3.12. The operator $A$ defined by (3.53, (3.54, and 3.55 is densely defined with compact resolvent, and it is the infinitesimal generator of an analytic semigroup on $\mathcal{H}$. Moreover, the adjoint of the operator $A$ is given by $\mathcal{D}\left(A^{*}\right)=\mathcal{D}(A)$ and

Using a perturbation argument (see, for instance, 32, Corollary 2.4, p. 81]), we deduce the first part of the Proposition.

&+\int_{\mathcal{F}}\left(\left(v^{S} \cdot \nabla\right) \varphi-\left(\nabla v^{S}\right)^{*} \varphi\right) \cdot w d y \tag{3.58}

Here we have used that $v^{S}=0$ on $\Gamma_{\text {str }}$ and $\varphi=0$ on $\Gamma_{0}$. Using 2.61 we deduce the result.
Let us fix $\lambda_{0}>0$ large enough so that $\lambda_{0}-A$ is positive and $\left(\lambda_{0}-A\right)^{\alpha}$ is well defined for $\alpha \in(0,1)$. We deduce from Proposition 3.12 and similarly as for Proposition 3.8 the following result.

Proof. Equalities (3.59) are consequences of $\mathcal{D}(A)=\mathcal{D}\left(A^{*}\right)$ and of the maximal accretivity of $\lambda-A$ for $\lambda>0$ large enough, see [11, Prop. 6.1, p170]. Note that to obtain $\langle(\lambda-A) \mathbf{Z}, \mathbf{Z}\rangle \geqslant 0$ we have to control the terms coming from $\Lambda^{(1)}, \Lambda^{(2)}$ and this can be done by using 2.59 , 2.60 and 2.63. In particular we use the fact that $\Lambda^{(2,2)} \in \mathcal{L}\left(\mathcal{H}_{S},\left(\mathbf{H}^{1}(\mathcal{F})\right)^{\prime}\right)$ which follows from 2.59) and 2.63) with an interpolation argument.

### 3.4 The operator $B$

To prove the case $s=-1 / 2$, we recall that in that case $D_{\mathcal{F}} u$ is defined by duality as follows: for any $\left[f, a_{f}, b_{f}\right] \in \mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$,

Moreover, we have from standard trace inequalities and Stokes regularity,

B: \mathbf{V}^{0}(\partial \mathcal{F}) \rightarrow\left[\mathcal{D}\left(A^{*}\right)\right]^{\prime}, \quad B u=\left(\lambda_{0}-A\right) \mathbb{P} D_{\mathcal{F}} u \tag{3.65}
\end{equation*}
$$

Proposition 3.15. The operator $B$ defined by 3.65 satisfies:

Proof. The regularity property $(3.66$ is a direct consequence of Proposition 3.2, Proposition 3.13 and of (3.61) The characterization 3.67) follows directly from 3.63).

We are now in position to deduce formulation $(3.12)-(3.13)$ from $(3.6)-(3.10$ and $\sqrt{3.11}$. First, since we have $\mathbf{Z}-D_{\mathcal{F}} u \in \mathcal{H}$ we have $(I-\mathbb{P})\left(\mathbf{Z}-D_{\mathcal{F}} u\right)=0$ which implies that $\mathbf{Z}$ satisfies (3.13). Moreover, assume that $\mathbf{Z}=\left[w, \xi_{1}, \xi_{2}\right]$ is a regular solution of (3.6)-(3.10) and assume that $\boldsymbol{\Phi}=\left[\varphi, \zeta_{1}, \zeta_{2}\right] \in \mathcal{D}\left(A^{*}\right)$. We multiply (3.6) with $\varphi, 3.9$ by $\zeta_{1}$ and (3.10) by $\zeta_{2}$. Then, after some integrating by parts and using (3.13), we obtain

Since the above equality is satisfied for any $\boldsymbol{\Phi} \in \mathcal{D}\left(A^{*}\right)$ we obtain the first equality of 3.12 .

## 4 Feedback Stabilizability of the linear system

### 4.1 Stabilizability of the homogeneous linear system

The goal of this subsection is to prove, for a fixed rate of decrease $\sigma>0$, the existence of a feedback control

such that solutions of (3.6-3.10 tends to zero as $t \rightarrow+\infty$ with an exponential rate of decrease $\sigma>0$. For that, we are going to show the existence of families $\left(\varphi_{j}, \zeta_{1, j}, \zeta_{2, j}\right)$ and $v_{j}, j=1, \ldots, N_{\sigma}$ such that the underlying closed-loop linear operator of (3.6)-(3.10) with 4.1) generates and analytic and exponentially stable semigroup of type lower than $-\sigma$ (see [11, II-1, (2.8) and Cor. 2.1]). It then permits to deduce results for nonhomogeneous system (3.1)-(3.4) that are used in the next subsection to construct solutions of the nonlinear system 2.48-2.51 with a fixed-point argument.
Proposition 4.1. For $\sigma>0$, there exist $N_{\sigma} \in \mathbb{N}^{*}$ and families $\left[\varphi_{j}, \zeta_{1, j}, \zeta_{2, j}\right] \in \mathcal{D}\left(A^{*}\right)$ and $v_{j} \in \mathbf{V}^{2}(\partial \mathcal{F})$, $j=1, \ldots, N_{\sigma}$, and a corresponding feedback operator $F_{\sigma}: \mathcal{H} \rightarrow \mathbf{V}^{2}(\partial \mathcal{F})$ defined by

F_{\sigma}\left[w, \xi_{1}, \xi_{2}\right]=\sum_{j=1}^{N_{\sigma}}\left(\int_{\mathcal{F}} w \cdot \varphi_{j} d y+\left(A_{1}^{1 / 2} \xi_{1}, A_{1}^{1 / 2} \zeta_{1, j}\right)_{\mathcal{H}_{\mathcal{S}}}+\left(\xi_{2}, \zeta_{2, j}\right)_{\mathcal{H}_{\mathcal{S}}}\right) v_{j} \tag{4.2}
\end{equation*}
$$

such that the linear operator $A_{\sigma} \stackrel{\text { def }}{=} A+B F_{\sigma}$ with domain $\mathcal{D}\left(A_{\sigma}\right) \stackrel{\text { def }}{=}\left\{\mathbf{Z} \in \mathcal{H} \mid A \mathbf{Z}+B F_{\sigma} \mathbf{Z} \in \mathcal{H}\right\}$ is the infinitesimal generator of an analytic and exponentially stable semigroup on $\mathcal{H}$ of type lower than $-\sigma$. Moreover, for $\alpha \in[0,1]$ we have $\mathcal{D}\left(\left(-A_{\sigma}\right)^{\alpha}\right) \hookrightarrow\left[\mathbf{H}^{2 \alpha}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2+\alpha / 2}\right) \times \mathcal{D}\left(A_{1}^{\alpha / 2}\right)\right] \cap \mathcal{H}$ and $\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\alpha}\right)=$ $\mathcal{D}\left(\left(\lambda_{0}-A^{*}\right)^{\alpha}\right)$, and for $\alpha \in[0,1 / 4)$ we have $\left.\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\alpha}\right)^{\prime}\right) \hookrightarrow \mathbf{H}^{2 \alpha}(\mathcal{F})^{\prime} \times \mathcal{D}\left(A_{1}^{1 / 2-\alpha / 2}\right) \times \mathcal{D}\left(A_{1}^{\alpha / 2}\right)^{\prime}$.

Proof. The proof of the above proposition relies on the Hautus-Fattorini stabilizability criterion, see [5, Theorem 1] or [8]. Since $A$ has compact resolvent and generates an analytic semigroup on $\mathcal{H}$, and since $B$ is relatively bounded with respect to $A$, then the homogeneous linear system is stabilizable by finite dimensional feedback control for any rate of decrease if and only if the following criterion is satisfied for all $\lambda \in \mathbb{C}$ :

Assume $\boldsymbol{\Phi}=\left[\varphi, \zeta_{1}, \zeta_{2}\right] \in \mathcal{D}\left(A^{*}\right)$ satisfies the two first relations 4.3). From (3.56) and (3.67), it implies that

\lambda \zeta_{2}-A_{1} \zeta_{1}+A_{2} \zeta_{2}+T^{*}(\mathbb{T}(\varphi, \pi) n)+\left(\Lambda^{(1,2)}\right)^{*}(\nabla \varphi)+\left(\Lambda^{(2,2)}\right)^{*}(\varphi) & =0,
\end{align*}\right.
$$

and

In what follows we denote $c(\varphi, \pi) \stackrel{\text { def }}{=} \int_{\partial \mathcal{F}} \rho \mathbb{T}(\varphi, \pi) n \cdot n d \gamma$. Combining (4.5) and the classical uniqueness result of 21 for Stokes type systems (see also [8, Appendix A]) we deduce that $\varphi=0$ and $\pi-c(\varphi, \pi)=0$ in $\mathcal{F}$. It implies in particular that $\mathbb{T}(\varphi, \pi-c(\varphi, \pi)) n=0$ on $\partial \mathcal{F}$ and $T \zeta_{2}=0$ on $\partial \mathcal{F}$. Using 2.55), we deduce that $\zeta_{2}=0$. Moreover, since we have $T^{*}(n)=0$, from $\mathbb{T}(\varphi, \pi-c(\varphi, \pi)) n=0$ we deduce $T^{*}(\mathbb{T}(\varphi, \pi) n)=0$ on $\partial \mathcal{F}$. Then using the last equation of (4.4) we obtain $A_{1} \zeta_{1}=0$ and then $\zeta_{1}=0$. We have obtained $\boldsymbol{\Phi}=0$.

Then the general framework of [5, 8, can be applied and for a given $\sigma>0$, there exist families

and $v_{j} \in \mathbf{V}^{0}(\partial \mathcal{F}), j=1, \ldots, N_{\sigma}$, and a feedback law of the form 4.2 such that the conclusions of the proposition hold. Moreover, each $v_{j}$ can be chosen in $\mathbf{V}^{2}(\partial \mathcal{F})$. This comes from the fact that the set of admissible families $\left(v_{j}\right)$ is a nonempty open set of $\left(\mathbf{V}^{0}(\partial \mathcal{F})\right)^{N_{\sigma}}$ (see [5] Theorem 5] or [8 Theorem 6]). Indeed, if a family $\left(\tilde{v}_{j}\right)$ is admissible then all families in a neighborhood of $\left(\tilde{v}_{j}\right)$ in $\left(\mathbf{V}^{0}(\partial \mathcal{F})\right)^{N_{\sigma}}$ are admissible. Then the conclusion follows from the density of $\mathbf{V}^{2}(\partial \mathcal{F})$ in $\mathbf{V}^{0}(\partial \mathcal{F})$.

Finally, the statements concerning $\mathcal{D}\left(\left(-A_{\sigma}\right)^{\alpha}\right)$ and $\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\alpha}\right)$ are obtained as in [6 and the statement concerning $\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\alpha}\right)^{\prime}$ then follows from 3.40.

Remark 4.2. From the definition 4.2 we can extend $F_{\sigma}$ to an operator from $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$ to $\mathbf{V}^{2}(\partial \mathcal{F})$ by using the same formula 4.2]. Moreover, since $\left[\varphi_{j}, \zeta_{1, j}, \zeta_{2, j}\right] \in \mathcal{H}$, it yields that $F_{\sigma}=F_{\sigma} \mathbb{P}$ and that $F_{\sigma}=0$ on $\mathcal{H}^{\perp}$. We can also extend $F_{\sigma}$ as an operator from $\mathcal{D}\left(A_{\sigma}^{*}\right)^{\prime}$ to $\mathbf{V}^{2}(\partial \mathcal{F})$ by setting

### 4.2 Stabilizability of the non homogeneous linear system

The goal of this section is to obtain regularity results for the following nonhomogeneous linear system:

\partial_{t} \xi_{1}=\xi_{2}, \quad t \in(0,+\infty),  \tag{4.9}\\
\partial_{t} \xi_{2}+A_{2} \xi_{2}+A_{1} \xi_{1}=-T^{*}\left(\mathbb{T}(w, p) n+\Lambda^{(1)}\left(\xi_{1}, \xi_{2}\right) n\right)+T^{*} G n, \quad t \in(0,+\infty), \tag{4.10}

with the initial conditions

In above settings we have extended the feedback operator $F_{\sigma}$ to $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{\mathcal{S}}$ (see Remark 4.2) and $F, G, F_{\text {div }}, F_{b}$ are nonhomogenous right-hand terms which play the role of the nonlinearities $F(\mathbf{Z})$, $G(\mathbf{Z}), F_{\text {div }}(\mathbf{Z}), F_{b}(\mathbf{Z})$ in 2.48 - 2.51 .

Suppose for the moment that $\left(F_{\text {div }}, F_{b}\right)=(0,0)$. By taking into account 4.1) in formulation (3.12)(3.13) complemented with the nonhomogeneous right-hand terms $F, G$, we deduce that the above system with $F_{\text {div }}=0$ and $F_{b}=0$ can be rewritten as

In what follows, we recall that we use the notation 2.1). We have the following result.

Proposition 4.3. Assume $\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right] \in \mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}, F \in L_{\sigma}^{2}\left(\mathbf{H}^{1}(\mathcal{F})^{\prime}\right), G \in L_{\sigma}^{2}\left(\mathbf{L}^{2}(\mathcal{F})\right)$ and $\left(F_{\mathrm{div}}, F_{b}\right)=(0,0)$. Then system 4.6)-4.11) admits a unique solution

& \leqslant C\left(\|[F, G]\|_{L_{\sigma}^{2}\left(\mathbf{H}^{1}(\mathcal{F})^{\prime} \times \mathbf{L}^{2}(\mathcal{F})\right)}+\left\|\mathbb{P}\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathcal{H}}\right) .

Proof. We write system (4.6)-(4.11) as 4.12-(4.13). By using 4.14) we have

Finally, from the definition (4.2) of the operator $F_{\sigma}$, from Proposition 3.14 and from Proposition 3.2 equality 4.13 yields $(I-\mathbb{P}) \mathbf{Z} \in$ $H_{\sigma}^{1}\left(\mathbf{H}^{1}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{3 / 4}\right) \times \mathcal{D}\left(A_{1}^{1 / 4}\right)\right)$.

Let us now consider the case of non zero nonhomegeneous terms $F_{\text {div }}$ and $F_{b}$. For that we need to introduce a lifting operator for the divergence condition which is compatible with the feedback condition, namely we set $L_{\text {div }}[g, h]=\left[w, \xi_{1}, 0\right]$ with $\left(w, \xi_{1}\right)$ satisfying

A_{1} \xi_{1}=-T^{*}\left(\mathbb{T}(w, p) n+\Lambda^{(1)}\left(\xi_{1}, 0\right) n\right) . \tag{4.19}

To state regularity properties for $L_{\text {div }}$ we need the functional framework introduced in 39. For $s \in$ $[-1 / 2,2]$ we define

Finally, using again Stokes regularity results with the fact that $\left(w, \xi_{1}\right) \in \mathbf{H}^{1}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{3 / 4}\right)$ yields 4.21) for $s=2$.

The case $s \in(-2 \varepsilon, 2)$ then follows by interpolation.
Using the lifting operator $L_{\text {div }}$, system (4.6-(4.10), 4.11) can be written as

$$
\begin{align*}
\mathbf{Z} & =\widehat{\mathbf{Z}}+L_{\text {div }}\left(F_{b}, F_{\text {div }}\right),  \tag{4.39}\\
\mathbb{P} \widehat{\mathbf{Z}}^{\prime} & =A_{\sigma} \mathbb{P} \widehat{\mathbf{Z}}+\mathbb{P}(F-\operatorname{div} G)-\mathbb{P} L_{\text {div }}\left(F_{b}, F_{\text {div }}\right)^{\prime} \text { in } \mathcal{D}\left(A^{*}\right)^{\prime},  \tag{4.40}\\
\mathbb{P} \widehat{\mathbf{Z}}(0) & =\mathbb{P}\left(\mathbf{Z}^{0}-L_{\text {div }}\left(F_{b}(0), F_{\text {div }}(0)\right),\right.  \tag{4.41}\\
(I-\mathbb{P}) \widehat{\mathbf{Z}} & =(I-\mathbb{P}) D_{\mathcal{F}} F_{\sigma} \mathbb{P} \widehat{\mathbf{Z}} . \tag{4.42}
\end{align*}
$$

In order to analyze 4.40), we need the following proposition.
Proposition 4.5. Assume $\mathbf{F} \in H_{\sigma}^{1 / 2+\delta}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)$ for some $\delta \in(0,1 / 2)$. Then, the solution of

\begin{equation*}
\mathbf{W}^{\prime}=A_{\sigma} \mathbf{W}+\mathbf{F}^{\prime}, \quad \mathbf{W}(0)=0 \tag{4.43}
\end{equation*}
$$

belongs to $H_{\sigma}^{1 / 2+\delta}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{\delta}\right)^{\prime}\right) \cap L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1 / 2}\right)\right)$ and satisfies

$$
\begin{equation*}
\|\mathbf{W}\|_{H_{\sigma}^{1 / 2+\delta}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)}+\|\mathbf{W}\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1 / 2}\right)\right)} \leqslant C\|\mathbf{F}\|_{H_{\sigma}^{1 / 2+\delta}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)} \tag{4.44}
\end{equation*}
$$

Proof. First, since $A_{\sigma}-\sigma I$ is of negative type and is the infinitesimal generator of an analytic semigroup, for any $\mathbf{F} \in H_{\sigma}^{1}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)$ the solution of 4.43) satisfies

$$
\begin{equation*}
\|\mathbf{W}\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1-\delta}\right)\right)}+\|\mathbf{W}\|_{H_{\sigma}^{1}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)} \leqslant C\|\mathbf{F}\|_{H_{\sigma}^{1}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)} \tag{4.45}
\end{equation*}
$$

Second, assume $\mathbf{F} \in L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)$. There exists a sequence $\left(\mathbf{F}_{n}\right)$ in $C_{c}^{1}(\mathcal{H})$ that converges to $\mathbf{F}$ in $L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\delta}\right)^{\prime}\right)$. We remark that the solution $\mathbf{W}_{n}$ of 4.43) corresponding to $\mathbf{F}_{n}$ satisfies

$$
\left(\mathbf{W}_{n}-\mathbf{F}_{n}\right)^{\prime}=A_{\sigma}\left(\mathbf{W}_{n}-\mathbf{F}_{n}\right)+A_{\sigma} \mathbf{F}_{n}, \quad\left(\mathbf{W}_{n}-\mathbf{F}_{n}\right)(0)=0,
$$

and using again the maximal regularity results, we find

$$
\left\|\mathbf{W}_{n}-\mathbf{F}_{n}\right\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{\delta}\right)^{\prime}\right)} \leqslant C\left\|A_{\sigma} \mathbf{F}_{n}\right\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{1+\delta}\right)^{\prime}\right)} \leqslant C\left\|\mathbf{F}_{n}\right\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{\delta}\right)^{\prime}\right)} .
$$

Thus, passing to the limit as $n \rightarrow+\infty$ we obtain $\|\mathbf{W}\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{\delta}\right)^{\prime}\right)} \leqslant C\|\mathbf{F}\|_{L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{\delta}\right)^{\prime}\right)}$. Then we conclude with (4.45) and with an interpolation argument.

Next, for $\varepsilon \in(0,1 / 8)$ given in 4.20 let us define the following functional spaces:

$$
\begin{gather*}
\mathcal{E} \stackrel{\text { def }}{=} L_{\sigma}^{2}\left(\mathbf{H}^{1}(\mathcal{F})^{\prime}\right) \times L_{\sigma}^{2}\left(\mathbf{L}^{2}(\mathcal{F})\right) \times\left[H_{\sigma}^{1 / 2+\varepsilon}\left(\mathbf{H}_{\partial \mathcal{F}, \mathcal{F}}^{-1 / 2-2 \varepsilon,-1-2 \varepsilon}\right) \cap L_{\sigma}^{2}\left(\mathbf{H}_{\partial \mathcal{F}, \mathcal{F}}^{1 / 2,0}\right)\right],  \tag{4.46}\\
\mathcal{G} \stackrel{\text { def }}{=}\left[H_{\sigma}^{1 / 2+\varepsilon}\left(\mathbf{H}^{2 \varepsilon}(\mathcal{F})^{\prime} \times \mathcal{D}\left(A_{1}^{1 / 2-\varepsilon / 2}\right) \times \mathcal{D}\left(A_{1}^{\varepsilon / 2}\right)^{\prime}\right)\right] \cap\left[L_{\sigma}^{2}\left(\mathbf{H}^{1}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{3 / 4}\right) \times \mathcal{D}\left(A_{1}^{1 / 4}\right)\right)\right] . \tag{4.47}
\end{gather*}
$$

Notice that 2.2 yields the following continuous embedding:

\begin{equation*}
\mathcal{G} \hookrightarrow\left[H_{\sigma}^{1 / 2}\left(\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}\right)\right] \cap\left[C_{b, \sigma}\left(\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}\right)\right] \tag{4.48}
\end{equation*}
$$

We are now in position to state the main result of this section.
Corollary 4.6. Assume $\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right] \in \mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}$ and $\left[F, G, F_{b}, F_{\text {div }}\right] \in \mathcal{E}$. Then system 4.6 (4.11) admits a unique solution $\left[w, \xi_{1}, \xi_{2}\right] \in \mathcal{G}$ and we have

$$
\begin{equation*}
\left\|\left[w, \xi_{1}, \xi_{2}\right]\right\|_{\mathcal{G}} \leqslant C\left(\left\|\left[F, G, F_{b}, F_{\mathrm{div}}\right]\right\|_{\mathcal{E}}+\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{0}^{1 / 2}\right) \times \mathcal{H}_{S}}\right) . \tag{4.49}
\end{equation*}
$$

Proof. We write system (4.6)-4.11] as 4.39-4.42] with $\mathbf{Z}=\left[w, \xi_{1}, \xi_{2}\right]$. Since

\left[F_{b}, F_{\mathrm{div}}\right] \in H_{\sigma}^{1 / 2+\varepsilon}\left(\mathbf{H}_{\partial \mathcal{F}, \mathcal{F}}^{-1 / 2-2 \varepsilon,-1-2 \varepsilon}\right) \cap L_{\sigma}^{2}\left(\mathbf{H}_{\partial \mathcal{F}, \mathcal{F}}^{1 / 2,0}\right)
$$

we deduce from Proposition 4.4 that

$$
L_{\mathrm{div}}\left(F_{b}, F_{\mathrm{div}}\right) \in \mathcal{G}
$$

Using Corollary 3.3 and 4.48 we deduce from the above relation

$$
\mathbb{P} L_{\text {div }}\left(F_{b}, F_{\text {div }}\right) \in H_{\sigma}^{1 / 2+\varepsilon}\left(\mathbf{H}^{2 \varepsilon}(\mathcal{F})^{\prime} \times \mathcal{D}\left(A_{1}^{1 / 2-\varepsilon / 2}\right) \times \mathcal{D}\left(A_{1}^{\varepsilon / 2}\right)^{\prime}\right) \cap C_{b, \sigma}(\mathcal{H})
$$

Using Proposition 4.1 Proposition 3.13 and (3.38) we deduce from the above relation,

$$
\begin{equation*}
\mathbb{P} L_{\text {div }}\left(F_{b}, F_{\text {div }}\right) \in H_{\sigma}^{1 / 2+\varepsilon}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\varepsilon}\right)^{\prime}\right) \cap C_{b, \sigma}(\mathcal{H}) . \tag{4.50}
\end{equation*}
$$

From the hypotheses on the initial conditions, and from the above relation, we obtain

$$
\begin{equation*}
\mathbb{P}\left(\mathbf{Z}^{0}-L_{\mathrm{div}}\left(F_{b}(0), F_{\mathrm{div}}(0)\right) \in \mathcal{H}\right. \tag{4.51}
\end{equation*}
$$

where $\mathbf{Z}^{0} \stackrel{\text { def }}{=}\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]$.
Gathering 4.50, 4.51) and applying Proposition 4.5 and Proposition 4.3 with the fact that

$$
W_{\sigma}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1 / 2}\right), \mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{1 / 2}\right)^{\prime}\right) \hookrightarrow H_{\sigma}^{1 / 2+\varepsilon}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\varepsilon}\right)^{\prime}\right) \cap L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1 / 2}\right)\right)
$$

we deduce that

$$
\mathbb{P} \widehat{\mathbf{Z}} \in H_{\sigma}^{1 / 2+\varepsilon}\left(\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\varepsilon}\right)^{\prime}\right) \cap L_{\sigma}^{2}\left(\mathcal{D}\left(\left(-A_{\sigma}\right)^{1 / 2}\right)\right) \hookrightarrow \mathcal{G} .
$$

We underline that the last above embedding is well justified by Proposition 4.1. In particular the embedding $\mathcal{D}\left(\left(-A_{\sigma}^{*}\right)^{\varepsilon}\right)^{\prime} \hookrightarrow \mathbf{H}^{2 \varepsilon}(\mathcal{F})^{\prime} \times \mathcal{D}\left(A_{1}^{1 / 2-\varepsilon / 2}\right) \times \mathcal{D}\left(A_{1}^{\varepsilon / 2}\right)^{\prime}$ is true since $\varepsilon<1 / 4$.

We deduce from the above relation, from the definition 4.2 of the operator $F_{\sigma}$, from Proposition 3.14 and from Proposition 3.2 that

$$
(I-\mathbb{P}) D_{\mathcal{F}} F_{\sigma} \mathbb{P} \widehat{\mathbf{Z}} \in H_{\sigma}^{1 / 2+\varepsilon}\left(\mathbf{H}^{1}(\mathcal{F}) \times D\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}\right)
$$

Combining the above relations, we deduce that

$$
\left[w, \xi_{1}, \xi_{2}\right]=\mathbf{Z}=\mathbb{P} \widehat{\mathbf{Z}}+(I-\mathbb{P}) \widehat{\mathbf{Z}}+L_{\mathrm{div}}\left(F_{b}, F_{\text {div }}\right) \in \mathcal{G}
$$

with the estimate 4.49.

## 5 Fixed point

### 5.1 Proof of Theorem 1.2

In order to prove Theorem 1.2, we consider the Banach spaces $\mathcal{E}$ and $\mathcal{G}$ defined by 4.46) and 4.47) and the following mapping defined on a closed ball of $\mathcal{E}$ of radius $R>0$,

$$
\Psi: B_{\mathcal{E}}(0, R) \rightarrow \mathcal{E}, \quad\left[F, G, F_{b}, F_{\mathrm{div}}\right] \mapsto\left[F(\mathbf{Z}), G(\mathbf{Z}), F_{b}(\mathbf{Z}), F_{\mathrm{div}}(\mathbf{Z})\right]
$$

where $\mathbf{Z}=\left[w, \xi_{1}, \xi_{2}\right] \in \mathcal{G}$ is the solution of (4.6)-4.11) given by Corollary 4.6 and where $F(\mathbf{Z}), G(\mathbf{Z}), F_{b}(\mathbf{Z})$, $F_{\text {div }}(\mathbf{Z})$ are defined by (2.43), 2.25) and 2.27).

We remark that if $\left.F, G, F_{b}, F_{\text {div }}\right]$ is a fixed point of the mapping $\Psi$, then the corresponding solution $\left[w, \xi_{1}, \xi_{2}\right]$ of (4.6)-4.11] is a solution of 2.48-(2.52). Consequently, we are reduced to show that $\Psi$ admits a fixed point. We prove that for $R$ small enough, $\Psi$ is well-defined from $B_{\mathcal{E}}(0, R)$ onto itself and that the restriction of $\Psi$ on this closed ball is a contraction mapping.

First, we notice that (4.49) implies 2.8 provided that $\left[F, G, F_{b}, F_{\text {div }}\right] \in B_{\mathcal{E}}(0, R)$ with $R$ small enough and that $\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]$ has a norm small enough in $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}$. In particular, the changes of variables $X$ and $Y$ are well-defined as well as $F(\mathbf{Z}), G(\mathbf{Z}), F_{b}(\mathbf{Z}), F_{\text {div }}(\mathbf{Z})$.

Second, we use several technical results whose proofs are given in the next subsections. To simplify the notation, in what follows, we assume

$$
\begin{equation*}
R+\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}} \leqslant 1 . \tag{5.1}
\end{equation*}
$$

Proposition 5.1. There exists $C_{\#}>0$ such that for all $R>0$ and $\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]$ satisfying 5.1), and all $\left[F, G, F_{\mathrm{div}}, F_{b}\right] \in B_{\mathcal{E}}(0, R)$,

$$
\left\|\Psi\left(\left[F, G, F_{b}, F_{\mathrm{div}}\right]\right)\right\|_{\mathcal{E}} \leqslant C_{\#}\left(R+\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}}\right)^{2} .
$$

From the above proposition, we remark that if

$$
\begin{equation*}
\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{1}^{1 / 2}\right) \times \mathcal{H}_{S}} \leqslant R, \tag{5.2}
\end{equation*}
$$

and $R$ is small enough so that

$$
\begin{equation*}
4 C_{\#} R \leqslant 1, \tag{5.3}
\end{equation*}
$$

then $\Psi$ is well-defined from $B_{\mathcal{E}}(0, R)$ into itself.
The second important technical result we need is the following:
Proposition 5.2. There exists $C_{\#}>0$ such that for all $R>0$ and $\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]$ satisfying (5.1), and all $\left[F^{(1)}, G^{(1)}, F_{b}^{(1)}, F_{\text {div }}^{(1)}\right]$ and $\left[F^{(2)}, G^{(2)}, F_{b}^{(2)}, F_{\mathrm{div}}^{(2)}\right]$ in $B_{\mathcal{E}}(0, R)$,

$$
\begin{aligned}
& \left\|\Psi\left(\left[F^{(1)}, G^{(1)}, F_{b}^{(1)}, F_{\mathrm{div}}^{(1)}\right]\right)-\Psi\left(\left[F^{(2)}, G^{(2)}, F_{b}^{(2)}, F_{\mathrm{div}}^{(2)}\right]\right)\right\|_{\mathcal{E}} \\
& \quad \leqslant C_{\#}\left(R+\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}\left(A_{0}^{1 / 2}\right) \times \mathcal{H}_{S}}\right)\left\|\left[F^{(1)}, G^{(1)}, F_{b}^{(1)}, F_{\mathrm{div}}^{(1)}\right]-\left[F^{(2)}, G^{(2)}, F_{b}^{(2)}, F_{\mathrm{div}}^{(2)}\right]\right\|_{\mathcal{E}} .
\end{aligned}
$$

With the same conditions 5.2 and 5.3), we deduce that the restriction of $\Psi$ on $B_{\mathcal{E}}(0, R)$ is a contraction mapping. The classical Banach fixed point theorem allows us to deduce the existence of a solution.

### 5.2 Proof of Proposition 5.1

Since $\left[F, G, F_{b}, F_{\text {div }}\right]$ satisfies,

$$
\begin{equation*}
\left\|\left[F, G, F_{b}, F_{\mathrm{div}}\right]\right\|_{\mathcal{E}} \leqslant R, \tag{5.4}
\end{equation*}
$$

then from 4.49) we deduce that the corresponding solution of 4.6-4.11) obeys

\left\|\left[w, \xi_{1}, \xi_{2}\right]\right\|_{\mathcal{G}} \leqslant C\left(R+\left\|\left[w^{0}, \xi_{1}^{0}, \xi_{2}^{0}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F}) \times H^{2}(0,1) \times L^{2}(0,1)}\right) . \tag{5.5}
\end{equation*}
$$

By definition of $\mathcal{G}$ (see 4.47) and from 4.48), we deduce for $\varepsilon \in(0,1 / 8)$,

\begin{equation*}
\xi_{1} \in H_{\sigma}^{1 / 2+\varepsilon}\left(H_{0}^{2-2 \varepsilon}(0,1)\right), \tag{5.6}
\end{equation*}
$$

$$
\begin{gather*}
\xi_{2} \in H_{\sigma}^{1 / 2+\varepsilon}\left(H^{-2 \varepsilon}(0,1)\right),  \tag{5.7}\\
w \in H_{\sigma}^{1 / 2}\left(\mathbf{L}^{2}(\mathcal{F})\right) \cap C_{b, \sigma}\left(\mathbf{L}^{2}(\mathcal{F})\right) \cap L_{\sigma}^{2}\left(\mathbf{H}^{1}(\mathcal{F})\right),  \tag{5.8}\\
\xi_{1} \in H_{\sigma}^{1 / 2}\left(H_{0}^{2}(0,1)\right) \cap C_{b, \sigma}\left(H_{0}^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H^{3}(0,1)\right),  \tag{5.9}\\
\xi_{2} \in H_{\sigma}^{1 / 2}\left(L^{2}(0,1)\right) \cap C_{b, \sigma}\left(L^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H_{0}^{1}(0,1)\right), \tag{5.10}
\end{gather*}
$$

and since $\xi_{2}=\partial_{t} \xi_{1}$

$$
\begin{equation*}
\xi_{1} \in H_{\sigma}^{3 / 2}\left(L^{2}(0,1)\right) \cap C_{b, \sigma}^{1}\left(L^{2}(0,1)\right) \cap H_{\sigma}^{1}\left(H_{0}^{1}(0,1)\right) . \tag{5.11}
\end{equation*}
$$

Using interpolation arguments and Sobolev embeddings we deduce the following embeddings,

$$
\begin{gathered}
H_{\sigma}^{1 / 2+\varepsilon}\left(H^{1-2 \varepsilon}(0,1)\right) \hookrightarrow C_{b, \sigma}\left(L^{\infty}(0,1)\right), \\
H_{\sigma}^{1 / 2}\left(L^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H^{1}(0,1)\right) \hookrightarrow H_{\sigma}^{1 / 4}\left(H^{1 / 2}(0,1)\right) \hookrightarrow L_{\sigma}^{4}\left(L^{4}(0,1)\right), \\
H_{\sigma}^{1 / 2}\left(L^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H^{1}(0,1)\right) \hookrightarrow H_{\sigma}^{3 / 8}\left(H^{1 / 4}(0,1)\right) \hookrightarrow L_{\sigma}^{8}\left(L^{4}(0,1)\right), \\

\xi_{2} \in H_{\sigma}^{1 / 2}\left(L^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H_{0}^{1}(0,1)\right) \hookrightarrow H_{\sigma}^{1 / 8}\left(H_{0}^{3 / 4}(0,1)\right) \hookrightarrow L_{\sigma}^{8 / 3}\left(H_{0}^{3 / 4}(0,1)\right), \\
\xi_{2} \in H_{\sigma}^{1 / 2}\left(L^{2}(0,1)\right) \cap L_{\sigma}^{2}\left(H_{0}^{1}(0,1)\right) \hookrightarrow H_{\sigma}^{3 / 8}\left(H^{1 / 4}(0,1)\right) \hookrightarrow L_{\sigma}^{8}\left(H^{1 / 4}(0,1)\right), \\

There exists an extension operator $E$ which is continuous from $L^{2}(\mathcal{F})$ into $L^{2}(\mathcal{T})$ as well as from $H^{1}(\mathcal{F})$ into $H_{0}^{1}(\mathcal{T})$. Note that an interpolation argument guarantees that we also have $E \in \mathcal{L}\left(H^{s}(\mathcal{F}), H_{0}^{s}(\mathcal{T})\right)$ for $s \in(0,1)$. Then using this extension operator, any function in $H^{s}(\mathcal{F}), s \in[0,1]$ can be considered as a function in $H_{0}^{s}(\mathcal{T})$ : in what follows we will extend $w_{i}$,
$i=1,2$ or some test functions $\varphi$, but for simplicity we will keep the same name $w_{i}$ and $\varphi$ instead of $E\left(w_{i}\right)$ and $E(\varphi)$. We will also freely use the boundedness properties of $E$ without recalling it.

Moreover, any function defined on $(0,1)$ is considered as a function defined on $\mathcal{T}$ but only depending on $y_{1}$ and equal to zero outside $(0,1)$ : by this way we can consider $\xi_{1}$ and $\xi_{2}$ as functions defined on $\mathcal{T}$.

For $p \in[1,+\infty), s \geqslant-1$ and a function $f: \mathcal{T} \rightarrow \mathbb{R}$ we write

$$

Proof. Assume $\varphi \in H^{1}(\mathcal{F})$. First, we have for a.e. $t \in(0, \infty)$,

\begin{gather*}
\left|\int_{\mathcal{F}} \tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\left(\partial_{s s} \xi_{1}\right) w_{i} w_{j} \varphi d y\right|=\left|\int_{\mathcal{T}} \tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\left(\partial_{s s} \xi_{1}\right)\left(\mathbf{1}_{\mathcal{F}} w_{i}\right) w_{j} \varphi d y\right| \\
\leqslant C\left\|\tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\left(\mathbf{1}_{\mathcal{F}} w_{i}\right) w_{j} \varphi\right\|_{L_{y_{2}}\left(L_{y_{1}}^{2}\right)}\left\|\partial_{s s} \xi_{1}\right\|_{L_{y_{2}}^{\infty}\left(L_{y_{1}}^{2}\right)} \\
\leqslant C\left\|\tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\left(\mathbf{1}_{\mathcal{F}} w_{i}\right) w_{j}\right\|_{L_{y_{2}}^{2}\left(L_{y_{1}}^{2}\right)}\|\varphi\|_{L_{y_{2}}^{2}\left(H_{y_{1}}^{1}\right)}\left\|\xi_{1}\right\|_{H_{0}^{2}(0,1)} \\
\leqslant C\left\|\tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\right\|_{L_{y_{2}}^{\infty}\left(H_{y_{1}}^{1}\right)}\left\|\left(\mathbf{1}_{\mathcal{F}} w_{i}\right) w_{j}\right\|_{L^{2}(\mathcal{T})}\left\|\xi_{1}\right\|_{H_{0}^{2}(0,1)}\|\varphi\|_{H^{1}(\mathcal{F})} . \tag{C.11}
\end{gather*}
$$

On the other hand,

$$
\left\|\left(\mathbf{1}_{\mathcal{F}} w_{i}\right) w_{j}\right\|_{L^{2}(\mathcal{T})} \leqslant C\left\|\left(\mathbf{1}_{\mathcal{F}} w_{i}\right)\right\|_{H^{1 / 4}(\mathcal{F})}\left\|w_{j}\right\|_{H^{3 / 4}(\mathcal{F})}
$$

Combining the above equation and C.11, with C.5 and C.9) we deduce

$$
\left\|\tau\left(y, \xi_{1}, \partial_{s} \xi_{1}\right)\left(\partial_{s s} \xi_{1}\right) w_{i} w_{j}\right\|_{L_{\sigma}^{2}\left(H^{1}(\mathcal{F})^{\prime}\right)} \leqslant C\left\|\xi_{1}\right\|_{L_{\sigma}^{\infty}\left(H_{0}^{2}(0,1)\right)}\left\|w_{i}\right\|_{L_{\sigma}^{8}\left(H^{1 / 4}(\mathcal{F})\right)}\left\|w_{j}\right\|_{L_{\sigma}^{8 / 3}\left(H^{3 / 4}(\mathcal{F})\right)}
$$

and we conclude by using C.2.
In Lemma C. 5 below, $\tau$ is a bounded Lipschitz continuous function of $\mathbb{R}^{2} \times\left[-c_{0}, c_{0}\right]$ with values in $\mathbb{R}$ for $c_{0}>0$ given in (2.8). From (C.2) and C.3) we deduce that $t \mapsto \tau\left(y, \xi_{1}\left(t, y_{1}\right)\right)$ satisfies

\begin{equation*}
\left\|\tau\left(y, \xi_{1}\right)\right\|_{L^{\infty}\left(W^{1, \infty}(\mathcal{T})\right)} \leqslant C . \tag{C.12}
\end{equation*}
$$

Moreover, we also assume that $\tau(y, \cdot)$ is zero for $y \in \overline{\mathcal{F}} \backslash \overline{\mathcal{V}_{\alpha}}$ (see 2.4). By this way,

\forall(y, \zeta) \in\left(\partial \mathcal{F} \backslash \bar{\Gamma}_{\text {str }}\right) \times\left[-c_{0}, c_{0}\right] \quad \tau(y, \zeta)=0 \tag{C.13}
\end{equation*}

Lemma C.5. Let $n_{1}, n_{2} \in \mathbb{N}$ such that $n_{1}+n_{2} \geqslant 1$ and assume C.12-C.13. Then

\begin{equation*}
\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} w_{i}\right\|_{H_{\sigma}^{1 / 2+\varepsilon}\left(H^{2 \varepsilon}(\mathcal{F})^{\prime}\right)}+\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} w_{i}\right\|_{H_{\sigma}^{1 / 2+\varepsilon}\left(H^{-1 / 2-2 \varepsilon}(\partial \mathcal{F})\right)} \leqslant C R_{0}^{2} \tag{C.14}
\end{equation*}
$$

Proof. We start by estimating the first term in the left-hand side of C.14. First we have the following relations

\begin{aligned}
& H^{2 \varepsilon}(\mathcal{T})=\left[H^{1}(\mathcal{T}), L^{2}(\mathcal{T})\right]_{1-2 \varepsilon}=\left[H_{y_{1}}^{1}\left(L_{y_{2}}^{2}(-L, L)\right) \cap L_{y_{1}}^{2}\left(H_{y_{2}}^{1}(-L, L)\right), L_{y_{1}}^{2}\left(L_{y_{2}}^{2}(-L, L)\right)\right]_{1-2 \varepsilon} \\
&=H_{y_{1}}^{2 \varepsilon}\left(L_{y_{2}}^{2}(-L, L)\right) \cap L_{y_{1}}^{2}\left(H_{y_{2}}^{2 \varepsilon}(-L, L)\right)
\end{aligned}
$$

Each of the above equalities follows from classical arguments (see for instance 25). The last relation can be written

H^{2 \varepsilon}(\mathcal{T})=L_{y_{1}}^{2}\left(H_{y_{2}}^{2 \varepsilon}(-L, L)\right) \cap L_{y_{2}}^{2}\left(H_{y_{1}}^{2 \varepsilon}(-L, L)\right) .
$$

Assume now that $\varphi \in H^{2 \varepsilon}(\mathcal{F})$. Using C.12 and the above relation, we have for a.e. $t \in(0, \infty)$,

&\left|\int_{\mathcal{F}} \tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} w_{i} \varphi d y\right|=\left|\left\langle w_{i}, \tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \varphi\right\rangle_{H^{2 \varepsilon}(\mathcal{F})^{\prime}, H^{2 \varepsilon}(\mathcal{F})}\right| \\
& \leqslant C\left\|w_{i}\right\|_{H^{2 \varepsilon}(\mathcal{F})^{\prime}}\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \varphi\right\|_{H^{2 \varepsilon}(\mathcal{F})} \\
& \leqslant C\left\|w_{i}\right\|_{H^{2 \varepsilon}(\mathcal{F})^{\prime}}\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \mathbf{1}_{\mathcal{F}} \varphi\right\|_{H^{2 \varepsilon}(\mathcal{T})} \\
& \leqslant C\left\|w_{i}\right\|_{H^{2 \varepsilon}(\mathcal{F})^{\prime}}\left(\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{2}}^{2}\left(H_{\left.y_{1}\right)}^{2 \varepsilon}\right)}+\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{1}}^{2}\left(H_{y_{2}}^{2 \varepsilon}\right)}\right) . \tag{C.15}
\end{align*}
$$

Moreover, using C.4, C.6, C.5 we deduce,

$$
\begin{aligned}
& \left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{2}}^{2}\left(H_{y_{1}}^{2 \varepsilon}\right)} \leqslant C\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}}\right\|_{L_{y_{2}}^{\infty}\left(H_{y_{1}}^{1 / 2+2 \varepsilon}\right)}\left\|\mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{2}}^{2}\left(H_{y_{1}}^{2 \varepsilon}\right)} \\
& \leqslant C\left\|\xi_{1}\right\|_{L_{y_{2}}^{\infty}\left(H_{y_{1}}^{1 / 2+2 \varepsilon}\right)}^{n_{1}}\left\|\partial_{s} \xi_{1}\right\|_{L_{y_{2}}^{\infty}\left(H_{y_{1}}^{1 / 2+2 \varepsilon}\right.}^{n_{2}}\left\|\mathbf{1}_{\mathcal{F}} \varphi\right\|_{H^{2 \varepsilon}(\mathcal{T})} \\
& \qquad \quad \leqslant C\left\|\xi_{1}\right\|_{H_{0}^{1 / 2+2 \varepsilon}(0,1)}^{n_{1}}\left\|\partial_{s} \xi_{1}\right\|_{H_{0}^{1 / 2+2 \varepsilon}(0,1)}^{n_{2}}\|\varphi\|_{H^{2 \varepsilon}(\mathcal{T})}
\end{aligned}
$$

and using (C.4) and C.5 with the fact that $\xi_{1}$ is independent on $y_{2}$ we deduce,

$$
\begin{aligned}
&\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{1}}^{2}\left(H_{y_{2}}^{2 \varepsilon}\right)} \leqslant C\left\|\xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}}\right\|_{L_{y_{1}}^{\infty}\left(H_{y_{2}}^{1 / 2+2 \varepsilon}\right)}\left\|\mathbf{1}_{\mathcal{F}} \varphi\right\|_{L_{y_{1}}^{2}\left(H_{y_{2}}^{2 \varepsilon}\right)} \\
& \leqslant C\left\|\xi_{1}\right\|_{L^{\infty}(0,1)}^{n_{1}}\left\|\partial_{s} \xi_{1}\right\|_{L^{\infty}(0,1)}^{n_{2}}\|\varphi\|_{H^{2 \varepsilon}(\mathcal{T})}
\end{aligned}
$$

Finally, since $\varepsilon \in(0,1 / 8)$ we have $\left.H_{0}^{1-2 \varepsilon}(0,1) \hookrightarrow H_{0}^{1 / 2+2 \varepsilon}(0,1)\right) \hookrightarrow L^{\infty}(0,1)$ and combining the above inequalities with (C.15) the result follows from C.1 , C.2).

For the second relation, assume $\varphi \in H^{1 / 2+2 \varepsilon}(\partial \mathcal{F})$. For a.e. $t \in(0, \infty)$ we have,

\begin{align*}
\left|\int_{\partial \mathcal{F}} \tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} w_{i} \varphi d \gamma\right|=\left|\left\langle w_{i}, \tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} \varphi\right\rangle_{H^{-1 / 2-2 \varepsilon}(\partial \mathcal{F}), H^{1 / 2+2 \varepsilon}(\partial \mathcal{F})}\right| \\
\leqslant C\left\|w_{i}\right\|_{H^{-1 / 2-2 \varepsilon}(\partial \mathcal{F})}\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}}\right\|_{H^{1 / 2+2 \varepsilon}(\partial \mathcal{F})}\|\varphi\|_{H^{1 / 2+2 \varepsilon}(\partial \mathcal{F})} . \tag{C.16}
\end{align*}
$$

Thus, taking C.13) into account we deduce that

$$
\begin{align*}
\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}}\right\|_{H^{1 / 2+2 \varepsilon}(\partial \mathcal{F})}= & \left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}}\right\|_{H^{1 / 2+2 \varepsilon}\left(\Gamma_{\mathrm{str}}\right)} \\
& \leqslant C\left\|\tau\left(y, \xi_{1}\right)\right\|_{W^{1, \infty}\left(\Gamma_{\mathrm{str}}\right)}\left\|\xi_{1}\right\|_{H^{1 / 2+2 \varepsilon}\left(\Gamma_{\mathrm{str}}\right)}^{n_{1}}\left\|\partial_{s} \xi_{1}\right\|_{H^{1 / 2+2 \varepsilon}\left(\Gamma_{\mathrm{str}}\right)}^{n_{2}} . \tag{C.17}
\end{align*}
$$

Moreover, we remark that for a function $g$ defined on $\mathcal{T}$ and only depending on $y_{1}$ we have

$$
\begin{aligned}
\|g\|_{H^{1 / 2+2 \varepsilon}\left(\Gamma_{\mathrm{str}}\right)}^{2}= & \int_{\Gamma_{\mathrm{str}}}|g(y)| d \gamma(y)+\int_{\Gamma_{\mathrm{str}}} \int_{\Gamma_{\mathrm{str}}} \frac{|g(y)-g(\tilde{y})|^{2}}{|y-\tilde{y}|^{2+4 \varepsilon}} d \gamma(y) d \gamma(\tilde{y}) \\
& \leqslant \int_{\Gamma_{\mathrm{str}}}\left|g\left(y_{1}\right)\right| d \gamma(y)+\int_{\Gamma_{\mathrm{str}}} \int_{\Gamma_{\mathrm{str}}} \frac{\left|g\left(y_{1}\right)-g\left(\tilde{y}_{1}\right)\right|^{2}}{\left|y_{1}-\tilde{y}_{1}\right|^{2+4 \varepsilon}} d \gamma(y) d \gamma(\tilde{y}) \\
& \leqslant \int_{0}^{1}|g(s)| \ell(s) d s+\int_{0}^{1} \int_{0}^{1} \frac{|g(s)-g(\tau)|^{2}}{|s-\tau|^{2+4 \varepsilon}} \ell(s) \ell(\tau) d s d \tau \leqslant\|\ell\|_{L^{\infty}(0,1)}^{2}\|g\|_{H^{1 / 2+2 \varepsilon(0,1)}}^{2},
\end{aligned}
$$

where we have used the notation $\ell(s)=\sqrt{1+\left(\partial_{s} \eta^{S}(s)\right)^{2}}$. Then combining C.16) and C.17) with the above estimate for $g=\xi_{1}$ and $g=\partial_{s} \xi_{1}$, with (C.12) we obtain for a.e. $t \in(0,+\infty)$,

$$
\left\|\tau\left(y, \xi_{1}\right) \xi_{1}^{n_{1}}\left(\partial_{s} \xi_{1}\right)^{n_{2}} w_{i}\right\|_{H^{-1 / 2-2 \varepsilon}(\partial \mathcal{F})} \leqslant C\left\|\xi_{1}\right\|_{H^{1 / 2+2 \varepsilon}(0,1)}^{n_{1}}\left\|\partial_{s} \xi_{1}\right\|_{H^{1 / 2+2 \varepsilon}(0,1)}^{n_{2}}\left\|w_{i}\right\|_{H^{-1 / 2-2 \varepsilon}(\partial \mathcal{F})} .
$$

Finally, since $\varepsilon \in(0,1 / 8)$ we have $H^{1-2 \varepsilon}(0,1) \hookrightarrow H^{1 / 2+2 \varepsilon}(0,1)$ and the conclusion follows from C.1).
