Feedback boundary stabilization of 2d fluid-structure interaction systems

Abstract

We study the feedback stabilization of a system composed by an incompressible viscous fluid and a deformable structure located at the boundary of the fluid domain. We stabilize the position and the velocity of the structure and the velocity of the fluid around a stationary state by means of a Dirichlet control, localized on the exterior boundary of the fluid domain and with values in a finite dimensional space. Our result concerns weak solutions for initial data close to the stationary state. Our method is based on general arguments for stabilization of nonlinear parabolic systems combined with a change of variables to handle the fact that the fluid domain of the stationary state and of the stabilized solution are different. We prove that for initial data close to the stationary state, we can stabilize the position and the velocity of the deformable structure and the velocity of the fluid.

1 Introduction

We consider the problem of stabilization for a fluid-structure system composed by a viscous incompressible fluid and a deformable structure located at the boundary of the fluid domain. The fluid motion is modeled by the Navier-Stokes system and the structure deformation follows the equation of a "viscous" beam. Such a model is already considered by several authors ([33], [10], etc.). Our aim consists in showing the boundary stabilization of such a system in the 2d case and for weak solutions. The method used here could be adapted for other fluid-structure systems in the case of a fluid modeled by the Navier-Stokes system. In the 3d case or for strong solutions, the stabilization of such fluid-structure systems could be obtained by using the methodology developed in [6] or in [8].

Let us first describe more precisely the system considered in this paper. The domain of reference for the fluid is denoted by \mathcal{F}_{ref} . We assume that it is a smooth domain of \mathbb{R}^2 such that its boundary $\partial \mathcal{F}_{ref}$ contains a flat part Γ_{ref} . We can assume that $\Gamma_{ref} = (0, 1) \times \{0\}$ and we set $\Gamma_0 \stackrel{\text{def}}{=} \partial \mathcal{F}_{ref} \setminus \overline{\Gamma_{ref}}$.

On the part Γ_{ref} , we assume that there is a beam that can deform through the action of exterior forces and in particular the force due to the fluid. The fluid boundary is thus moving, Γ_{ref} being transformed into

whereas Γ_0 remains unchanged. The new domain of fluid $\mathcal{F}(\eta(t, \cdot))$ is the interior of $\Gamma_0 \cup \overline{\Gamma_{\text{str}}(\eta(t))}$. We assume that




Figure 1: The fluid-plate system

and that $\Gamma_0 \cap \Gamma_{\text{str}}(\eta(t)) = \emptyset$ so that $\Gamma_0 \cup \overline{\Gamma_{\text{str}}(\eta(t))}$ is a close, simple C^1 curve and this definition makes sense (see Figure 1).

The fluid-structure system that we consider reads as follows

with the initial conditions

Here and in all that follows, (e_1, e_2) is the canonical basis of \mathbb{R}^2 , in particular $e_2 = \begin{bmatrix} 0 \\ 1 \end{bmatrix}$,

the vector fields n is the unit exterior normal to $\mathcal{F}(\eta(t))$ and in particular, on $\Gamma_{\text{str}}(\eta(t))$,

The constants α , β and δ are assumed to satisfy

Moreover, $f^S : \mathbb{R}^2 \to \mathbb{R}^2$, $b^S : \Gamma_0 \to \mathbb{R}^2$ and $g^S : (0, 1) \to \mathbb{R}$ are time-independent functions corresponding to a stationary state (v^S, p^S, η^S) of the above system:

where the boundary value b^S is supposed to satisfy $\int_{\Gamma_0} b^S \cdot n d\gamma = 0$. Finally, u is a control function that we will search in a feedback form so that the corresponding solution $(v, \eta, \partial_t \eta)$ tends to the stationary solution $(v^S, \eta^S, 0)$ as $t \to \infty$. The precise statement of this convergence

is given below. Here $\Xi \in \mathcal{L}(\mathbf{L}^2(\Gamma_0))$ is an operator used to localize the action of the control u in a relatively compact subset of Γ_0 and such that $\int_{\Gamma_0} \Xi(u) \cdot nd\gamma = 0$. Precisely, it can be defined by

where $\rho \in C^2(\Gamma_0)$ is a non zero function compactly supported in Γ_0 such that $\int_{\Gamma_0} \rho d\gamma = 1$.

Before stating in details the main result, let us first rewrite systems (1.3) and (1.8) in a more general way that allows to take into account the incompressibility of the fluid. A formal calculation yields

Consequently, it is natural to work with displacements η with constant mean value along the time. For simplicity, we assume that the mean value of η is zero:

With this assumption, we also have $\partial_{tt}\eta(t,\cdot) \in L^2_0(0,1)$ and from the boundary conditions (1.2), we obtain $\partial_{ss}\eta(t,\cdot), \partial_{tss}\eta(t,\cdot) \in L^2_0(0,1)$. Therefore, the equation for η in (1.3) yields the following condition for all $t \ge 0$,

From the definition (1.5)-(1.6) of $\mathbb{H}_{\eta}(v, p)$ and from (1.7), the above condition can be written as

Note that an analogous condition can be imposed on p^S to have $\eta^S \in L^2_0(0, 1)$. These conditions imply that, in contrast to the Navier–Stokes system, the pressure is not determined up to a constant in this fluid-structure interaction system. To avoid to deal with this constraint we will use the orthogonal projection

The properties of these operators are described in Section 3. In particular their square roots $A_1^{1/2}$ and $A_2^{1/2}$ are well defined. We also denote by $(\cdot, \cdot)_{\mathcal{H}_S}$ the usual scalar product of $L^2(0, 1)$.

With the above notation, systems (1.3) and (1.8) rewrite:

In above settings $\mathbf{1}_{\Gamma_0}$ denotes the characteristic function of Γ_0 .

Our aim is to use the control u in (1.3) in order to "reach" the above stationary state. More precisely, we impose a feedback law depending on the difference between $(v(t, \cdot), \eta(t, \cdot), \partial_t \eta(t, \cdot))$ and $(v^S, \eta^S, 0)$ in order to obtain that the difference between these states goes to 0 exponentially.

Such results of stabilization are classical for the classical Navier-Stokes system (without any structure), see for instance, [23], [38], [9], [37], [2], [5], etc. Note that for this problem there is a difference between the dimension 2 and the dimension 3: due to the nonlinearity in the Navier-Stokes system, and to the method developed (stabilization of the linearized system, fixed point), in dimension 2 one can take initial data in L^2 (or H^s , s < 1/2), whereas in dimension 3, one needs to take the initial data in H^1 (or at least H^s , $s \ge 1/2$). As a consequence, in dimension 3, we have to impose compatibility condition at t = 0 between the initial condition and the feedback control u (see [4, 3, 2] for details). Several techniques have been considered to overcome this difficulty: [34], [2], [5], etc. For instance in [5], the solution consists in assuming that the control u satisfies an evolution equation with another feedback control. We are thus reduced to stabilize a system coupling the fluid velocity and the control u. In dimension 2, the method allows to consider classical feedback operators for weak solutions. This is done for the Navier-Stokes system in [38]. Note that in dimension 2, the stabilization of strong solutions leads to the same problem of compatibility conditions.

For the fluid-structure interaction systems, there are few results of stabilization. A first result was obtained in [36] for the system considered in this article. The target velocity v^S is zero, the control is acting in the whole structure and the author works with strong solutions (initial data in H^1 for the fluid velocity). The case of a deformable structure immersed in a fluid is considered in [19], [18]. For the case of a rigid body, a 1d simplified model is treated in [7] whereas the 2d and 3d case are considered in [6]. In this last paper, we work with a notion of weak solutions in order to deal with the 2d case without the problem of the compatibility conditions. However, in [6] we need that the initial and the final position of the structure are equal.

The main novelty of this work is to prove stabilizability result for *weak* solutions of a fluid-structure system. Moreover, we consider a nontrivial target velocity v^S to be stabilized. We work in the 2d case only and the method for the stabilization follows the same idea as the papers quoted above. One important difficulty that we need to deal with is that there is no proof in the literature for the existence of *weak* solutions of a fluid-structure system with a Banach fixed point. In order to do this here, a first step consists in performing a change of variables to work on a cylindrical domain (see Section 2). Such an approach is already considered for *strong* solutions and there exists changes of variables that allow to keep the divergence free conditions and the form of the boundary conditions. We don't employ such a change of variables on the unknowns but on the test functions. This leads to transform our system in a cylindrical domain with non homogeneous divergence conditions and non homogeneous boundary conditions. We can overcome the corresponding difficulty by using a framework developed in [39] for the Navier-Stokes system. All this work could be adapted to other fluid-structure systems such as the case of rigid bodies moving into a viscous incompressible fluid as in [6]. Indeed, the presence here of the deformable structure that follows a beam equation leads to lots of technical difficulties (see the three sections in the appendix).

Let us also mention that several works have been devoted to the study of the fluid-plate system. The model was proposed in [33]. The existence of weak solutions was proved in [16] and the existence of strong solutions was obtained in [10] and in [29]. For these two results, as in our case, the damping term, that is $-\delta \partial_{tss} \eta$, is essential. In [24], the author manages to prove the existence of weak solutions (in 2d or in 3d) for this problem in the case without damping ($\delta = 0$).

Let us write the weak formulations for both systems (1.18) and (1.19). Assume

One of the difficulties, that is classical in fluid-structure interaction problems, is coming from the fact that the solutions and the test functions of (1.18) and of (1.19) are not written in the same spatial domains. To overcome this issue, we transform the system (1.18) by using a change of variables X such that $X(t, \mathcal{F}(\eta^S)) =$ $\mathcal{F}(\eta(t, \cdot))$ and $X(t, \Gamma_{str}(\eta^S)) = \Gamma_{str}(\eta(t, \cdot))$, and also such that $X(t, \cdot) = \text{Id on } \Gamma_0$ for all t. More precisely, here we use a change of variables depending on time through a dependance on $\eta(t)$ only: we choose the particular form $X(t, \cdot) = X_{\eta(t)}$ for all $t \ge 0$ where, for any deformation $\eta \in H_0^2(0, 1), X_\eta : \mathbb{R}^2 \to \mathbb{R}^2$ satisfies $X_\eta(\mathcal{F}(\eta^S)) = \mathcal{F}(\eta)$ and

The construction of X_{η} is given in Section 2.2. Note that we will obtain that $X_{\eta(t)}$ is a C^1 -diffeomorphism of \mathbb{R}^2 into itself for all $t \ge 0$ by assuming that η is a continuous bounded function in time with values in $C^1([0, 1])$ and is close to η^S .

The change of variables also allows us to describe the feedback law satisfied by u in (1.3). We take u under the form

$$N_{\sigma} \in \mathbb{N}, \quad v_j \in \mathbf{H}^2(\Gamma_0), \quad \left[\varphi_j, \zeta_j^1, \zeta_j^2\right] \in \mathbf{L}^2(\mathcal{F}(\eta^S)) \times (H_0^2(0, 1) \cap \mathcal{H}_S) \times \mathcal{H}_S, \quad j \in \{1, \dots, N_{\sigma}\}.$$
(1.31)

Now, let us give the definition of a weak solution for our problem.

Definition 1.1. The pair (v, η) is a weak solution of (1.18) if it satisfies the following properties

1. it satisfies the regularity

$$\eta \in C([0, +\infty); H_0^2(0, 1) \cap L_0^2(0, 1)) \cap L_{\text{loc}}^2(0, +\infty; H^3(0, 1)),$$

$$\partial_t \eta \in C([0, +\infty); L_0^2(0, 1)) \cap L_{\text{loc}}^2(0, +\infty; H_0^1(0, 1)),$$

$$v \in C([0, +\infty); \mathbf{L}^2(\mathcal{F}(\eta(t)))) \cap L_{\text{loc}}^2(0, +\infty; \mathbf{H}^1(\mathcal{F}(\eta(t))));$$

(1.32)

- 2. there exists a family $\{X(t,\cdot)\}_{t\geq 0}$ of C^1 -diffeomorphisms that transforms \mathcal{F} onto $\mathcal{F}(\eta(t,\cdot))$ and such that both X and X^{-1} belong to $C_b(\mathbf{C}^1(\overline{\mathcal{F}}))$.
- 3. we have $v = b^S + \Xi(u)$ on $(0, +\infty) \times \Gamma_0$, with u obtained through (1.29)-(1.31);
- 4. relation (1.23) holds for all $(\varphi, \zeta) \in C_0^1([0, \infty); C^1(\overline{\mathcal{F}(\eta(t))}) \times (C^2([0, 1]) \cap L_0^2(0, 1)))$ satisfying (1.20)-(1.22).

We refer to Section 2.1 for the precise definition of the functional spaces used above.

Theorem 1.2. Assume

and

Then for all $\sigma > 0$, there exist $N_{\sigma} \in \mathbb{N}$, $\mu > 0$, C > 0, $v_j \in \mathbf{H}^2(\Gamma_0)$, $j = 1, \ldots, N_{\sigma}$ such that if

$$\|v^{0} \circ X_{\eta^{0}} - v^{S}\|_{\mathbf{L}^{2}(\mathcal{F}(\eta^{S}))} + \|\eta^{0}_{1} - \eta^{S}\|_{H^{2}(0,1)} + \|\eta^{0}_{2}\|_{L^{2}(0,1)} \leq \mu$$

then there exists a weak solution (v, η) of (1.18), (1.29)-(1.31) (in the sense of Definition 1.1) and:

$$\begin{aligned} \|v \circ X_{\eta(t)} - v^{S}\|_{\mathbf{L}^{2}(\mathcal{F}(\eta^{S}))} + \|\eta(t) - \eta^{S}\|_{H^{2}(0,1)} + \|\partial_{t}\eta(t)\|_{L^{2}(0,1)} \\ &\leqslant Ce^{-\sigma t} \left(\|v^{0} \circ X_{\eta^{0}_{1}} - v^{S}\|_{\mathbf{L}^{2}(\mathcal{F}(\eta^{S}))} + \|\eta^{0}_{1} - \eta^{S}\|_{H^{2}(0,1)} + \|\eta^{0}_{2}\|_{L^{2}(0,1)} \right). \end{aligned}$$

Remark 1.3. Note that assumption $\mathcal{F}(\eta^S)$ of class $C^{1,1}$ allows us to freely use H^2 -regularity results for the Laplace equation and for the Stokes equations. It is also a natural assumption because, even if the reference domain \mathcal{F}_{ref} and η^S are regular, the boundary conditions $\eta^S = \partial_s \eta^S = 0$ on $\{0, 1\}$ do not guarantee a class of regularity for $\mathcal{F}(\eta^S)$ better than $C^{1,1}$.

Remark 1.4. The family $[\varphi_j, \zeta_j^1, \zeta_j^2]$, $j = 1, \ldots, N_\sigma$ can be obtained for instance from $[\varphi_j, \zeta_j^1, \zeta_j^2] = Lv_j$ where L is finite rank linear operator on $\mathbf{L}^2(\mathcal{F}(\eta^S)) \times (H_0^2(0,1) \cap \mathcal{H}_S) \times \mathcal{H}_S$ independent of j which can be computed from the solution of a finite dimensional Riccati equation, see [5, 8] or [37] for details.

Remark 1.5. The uniqueness of the controlled weak solution (in the sense of Definition 1.1) is not proved in Theorem 1.2. Since the proof relies on a Banach fixed point argument it is indeed true that the solution is unique within a class of stable solutions sufficiently close to the stationary state. But uniqueness is not obtained in the classical energy space defined by (1.32). The uniqueness of weak solution is not an easy issue, even under the hypothesis of small initial data. It must be the subject of further investigations.

Remark 1.6. Using the method developed here, we can obtain the same result for other fluid-structure systems. For instance, we could obtain the stabilization of weak solutions for the case where the structure is a rigid body (see [6]). One could also consider the case of a deformable structure in the case where the equation of deformation is approximated by a finite dimensional method: see [20], [28], [14]. For these cases, the fixed point and the estimates are simpler than here. The case of a deformable structure modeled by the Lame equation or by the wave equation with an adequate damping can also obtained directly from our work. For other damping laws or without damping, even the well-posedness is not always done and the corresponding stabilization problems have to be studied differently. Let us quote some references on the well-posedness of such systems: [15], [12], [13], [30], [40], etc.

The outline of the paper is as follows. In Section 2, we construct the change of variables and we rewrite the system in a fixed domain. We then obtain the system satisfied by the difference between the controlled solution and the stationary state. By linearizing this system, we obtain in Section 3 the coupled system (3.1)– (3.4) that couples an Oseen's type system with a beam type system with dissipation. With this dissipation, we prove that the semigroup associated with system (3.1)–(3.4) is analytic. That allows us to use the general theory developed in [5, 8] to deduce in Section 4 the feedback stabilization of our linear system, first in the homogeneous case and then in the non homogeneous case (and in particular with terms corresponding to the non null divergence condition and non null boundary condition). In Section 5, we use a fixed point procedure to obtain the stabilization of the nonlinear system and thus to prove the main result. In the appendix, we postpone technical proofs to the three sections: Section A is devoted to the change of variables, Section B to the linearization, and Section C to some estimates for the fixed point.

2 Notation and change of variables

2.1 Notation

The classical Lebesgue and Sobolev spaces are written L^{α} , H^{k} and we denote by C_{b} the continuous and bounded maps. We use the bold notation for the spaces of vector fields: $\mathbf{L}^{\alpha} = (L^{\alpha})^{2}$, $\mathbf{H}^{k} = (H^{k})^{2}$ etc. For a Hilbert space \mathcal{X} and $0 < T \leq +\infty$, $L^{p}(0,T;\mathcal{X})$ and $H^{s}(0,T;\mathcal{X})$, $p \in [1,\infty]$, $s \geq 0$, are usual vector-valued Lebesgue and Sobolev spaces and in the case $T = +\infty$, we use the shorter expressions $L^{p}(\mathcal{X}) \stackrel{\text{def}}{=} L^{p}(0, +\infty; \mathcal{X})$ and $H^{s}(\mathcal{X}) \stackrel{\text{def}}{=} H^{s}(0, +\infty; \mathcal{X})$. We denote by $L^{2}_{\text{loc}}(0,T;\mathcal{X})$ (resp. $H^{s}_{\text{loc}}(0,T;\mathcal{X})$) the set of functions belonging to $L^{2}(0,T;\mathcal{X})$ (resp. $H^{s}(0,T;\mathcal{X})$) for all T > 0. For two Hilbert spaces \mathcal{X} , \mathcal{Y} we write $W(\mathcal{X}, \mathcal{Y}) \stackrel{\text{def}}{=} L^{2}(\mathcal{X}) \cap H^{1}(\mathcal{Y})$.

If \mathcal{Z} is a vector-valued function space of the time variable $t \ge 0$, for $\sigma > 0$ we use the subscript σ in \mathcal{Z}_{σ} to denote the space

$$\mathcal{Z}_{\sigma} \stackrel{\text{def}}{=} \left\{ \mathbf{Z} \in \mathcal{Z} \; ; \; t \mapsto e^{\sigma t} \mathbf{Z}(t) \in \mathcal{Z} \right\}.$$
(2.1)

For instance,

$$W_{\sigma}(\mathcal{X}, \mathcal{Y}) \stackrel{\text{\tiny def}}{=} \left\{ \mathbf{Z} \in L^{2}(\mathcal{X}) \cap H^{1}(\mathcal{Y}) \; ; \; t \mapsto e^{\sigma t} \mathbf{Z}(t) \in W(\mathcal{X}, \mathcal{Y}) \right\}$$

We use the notation $(\mathcal{X})'$, or simply \mathcal{X}' , for the dual space of \mathcal{X} , we use the notation $\mathcal{L}(\mathcal{X}, \mathcal{Y})$ for the bounded linear maps from \mathcal{X} into \mathcal{Y} and the notation $\mathcal{X} \hookrightarrow \mathcal{Y}$ for the continuous embedding of \mathcal{X} into \mathcal{Y} . Moreover, $[\mathcal{X}, \mathcal{Y}]_{\theta}$ denotes the complex interpolation space of index $\theta \in (0, 1)$. If $\mathcal{X} \hookrightarrow \mathcal{Y}$ the following continuous embeddings hold for all $\theta \in (0, 1)$ and $s \in (1/2, 1]$:

The first above embedding is an easy consequence of the fact that $[\mathcal{X}, \mathcal{Y}]_{1/(2s)}$ is the trace space of $L^2(\mathcal{X}) \cap H^s(\mathcal{Y})$, see e.g. [25]. The second one comes from the equality $[L^2(\mathcal{X}), H^s(\mathcal{Y})]_{\theta} = H^{\theta s}([\mathcal{X}, \mathcal{Y}]_{\theta})$ (see Theorem 5.1 and (6.8) in [27]) combined with the embedding $L^2(\mathcal{X}) \cap H^s(\mathcal{Y}) \hookrightarrow [L^2(\mathcal{X}), H^s(\mathcal{Y})]_{\theta}$.

In order to simplify the notation, we write in what follows

$$\mathbf{V}_{0}^{s}(\mathcal{F}) \stackrel{\text{def}}{=} \left\{ f \in \mathbf{H}^{s}(\mathcal{F}) \; ; \; \operatorname{div} f = 0 \quad \text{in} \quad \mathcal{F} \quad \text{and} \quad f = 0 \quad \text{on} \quad \partial \mathcal{F} \right\}, \quad (s > 1/2),$$
$$\mathbf{V}^{s}(\partial \mathcal{F}) \stackrel{\text{def}}{=} \left\{ w \in \mathbf{H}^{s}(\partial \mathcal{F}) \; ; \; \langle w \cdot n, 1 \rangle_{H^{-\frac{1}{2}}(\partial \mathcal{F}), H^{\frac{1}{2}}(\partial \mathcal{F})} = 0 \right\} \quad (s \ge -1/2).$$

We also use functional spaces of type $L^2(0, \infty; \mathbf{H}^1(\mathcal{F}(\eta(t))))$. Such a space is defined through a family $\{X(t, \cdot)\}_{t\geq 0}$ of C^1 -diffeomorphisms that transforms \mathcal{F} onto $\mathcal{F}(\eta(t, \cdot))$ and such that both X and X^{-1} belong to $C_b(\mathbf{C}^1(\overline{\mathcal{F}}))$. We say that $v \in L^2(0, \infty; \mathbf{H}^1(\mathcal{F}(\eta(t))))$ if $v \circ X \in L^2(\mathbf{H}^1(\mathcal{F}))$. It can be seen that the above definition of $L^2(0, \infty; \mathbf{H}^1(\mathcal{F}(\eta(t))))$ is independent of the choice of X. For instance, if $\eta \in C_b(C^1([0, 1]))$ one can choose the family of change of variables $\{X_{\eta(t)}\}_{t\geq 0}$ introduced in Section 2.2 below. Other spaces of functions defined on a non cylindrical domain of \mathbb{R}^3 are defined similarly: $C_b([0,\infty); \mathbf{L}^2(\mathcal{F}(\eta(t))))$, $C^1([0,\infty); \mathbf{C}^1(\overline{\mathcal{F}}(\eta(t))))$, etc.

In what follows, C > 0 denotes a generic constant that may change from line to line and which is independent on the other terms of the relation where it is used.

2.2 Construction of the change of variables

We transform the system (1.18) written in the non cylindrical domain

Since $\eta^S \in C^3([0,1])$, see (1.33), we can extend η^S to a function in $C^3(\mathbb{R})$.

We consider the set

(2.4)

We suppose that $\alpha > 0$ is small enough in order that $\mathcal{V}_{\alpha} \subset \mathcal{F}$. Note that $\partial \mathcal{V}_{\alpha} \cap \partial \mathcal{F} = \Gamma_{\text{str}}$. We consider $\widehat{\theta} \in C_c^{\infty}(\mathbb{R})$ such that $\widehat{\theta} \equiv 1$ in $(-\alpha/2, \alpha/2)$ and $\widehat{\theta} \equiv 0$ in $\mathbb{R} \setminus (-\alpha, \alpha)$, and for $(y_1, y_2) \in \mathbb{R}^2$ we define $\theta(y_1, y_2) \stackrel{\text{def}}{=} \widehat{\theta}(y_2 - \eta^S(y_1))$. Then $\theta \in C^3(\mathbb{R}^2)$ and for a given function $\eta \in H_0^2(0, 1)$ we define the change of variables:

$$X_{\eta}: \mathbb{R}^2 \to \mathbb{R}^2, \quad y \mapsto \begin{cases} y + \theta(y)(\eta(y_1) - \eta^S(y_1))e_2 & \text{if } y_1 \in (0,1), \\ y & \text{if } y_1 \notin (0,1). \end{cases}$$

We can check that $X_{\eta} = \text{Id in } \mathcal{F} \setminus \mathcal{V}_{\alpha}$ and that (1.28) holds true, and in particular

Note that $\eta \in H_0^2(0,1)$ and $\eta^S \in H_0^2(0,1)$ imply that the extension of $\eta - \eta^S$ by zero outside (0,1) belongs to $H^2(\mathbb{R})$ and is supported in [0,1]. As a consequence, $X_\eta \in \mathbf{H}^2(\mathbb{R}^2)$. From the continuous embedding $H_0^2(0,1) \hookrightarrow C^1([0,1])$ we also deduce that $X_\eta \in \mathbf{C}^1(\mathbb{R}^2)$. Moreover, we can check that for $(y_1, y_2) \in \mathbb{R}^2$,

and that the mapping X_{η} is a C^1 -diffeomorphism of \mathbb{R}^2 onto itself if we assume that

$$\|\widehat{\theta}'\|_{L^{\infty}(\mathbb{R})}\|\eta - \eta^{S}\|_{L^{\infty}(0,1)} < 1.$$
(2.7)

In that case, from (2.5), we deduce that X_{η} is a C^1 -diffeomorphism of \mathcal{F} onto $\mathcal{F}(\eta)$. We denote by Y_{η} the inverse of X_{η} .

In what follows, we will construct a solution $t \mapsto \eta(t)$ in $C_b(H_0^2(0,1))$ such that

$$\|\eta - \eta^{S}\|_{L^{\infty}(L^{\infty}(0,1))} \leqslant c_{0} \tag{2.8}$$

for $c_0 \in (0, 1/\|\widehat{\theta}'\|_{L^{\infty}(\mathbb{R})})$. This will guarantee that for all $t \ge 0$, $X_{\eta(t)}$ is a C^1 -diffeomorphism of \mathcal{F} onto $\mathcal{F}(\eta(t))$ and that $X_{\eta(\cdot)} \in C_b(\mathbf{C}^1(\mathcal{F}))$ and $Y_{\eta(\cdot)} \in C_b(\mathbf{C}^1(\mathcal{F}))$. In what follows, we will use the simplified notation

$$\forall (t,y) \in \mathbb{R}^+ \times \mathcal{F}, \quad X(t,y) \stackrel{\text{def}}{=} X_{\eta(t)}(y) \quad \text{and} \quad Y(t,y) \stackrel{\text{def}}{=} Y_{\eta(t)}(y).$$

From their definitions we observe that

In the sequel, we use the above relation on Γ_0 .

Finally, for a 2×2 matrix M we denote by Cof(M) the cofactor matrix and we recall the classical relations

We remark that (2.7), (2.6) imply det(∇X) > 0 and using (2.9) we deduce that for v, φ in $L^2(\mathbf{L}^2(\mathcal{F}(\eta(t))))$,

2.3Rewriting the system (1.3) in a fixed domain

In this section we assume (2.8). Our change of variables is defined by

Remark 2.1. We could have used the change of variables $\tilde{v}(t,y) \stackrel{\text{def}}{=} v(t,X(t,y))$ or, as in [41] or [14], $\widetilde{v}(t,y) \stackrel{\text{def}}{=} \operatorname{Cof}(\nabla X(t,y))^* v(t,X(t,y))$. The advantage of the latter choice is that it preserves the divergence free condition. Here we use this formula to transform the test function φ , see (2.15) below.

We have the following results (the technical proof is postponed in Section A.1).

Lemma 2.2. With the notation (2.11), we have

For the test function in (1.23), we use the following change of variables.

Lemma 2.3. With the notation (2.15), if φ satisfies (1.20)–(1.22) then

We can then transform the weak formulation (1.23): combining Lemma A.1, Lemma A.2, and Lemma A.3 in the appendix (Section A), we obtain that \tilde{v} satisfies the weak formulation

2.4 Properties of the linear operators Ξ , T, $\Lambda^{(1)}$, $\Lambda^{(1)}$

In order to study system (2.48)-(2.52) we need to give some regularity properties of Ξ , T, $\Lambda^{(1)}$, $\Lambda^{(2)}$.

First, observe that $\Xi \in \mathcal{L}(\mathbf{L}^2(\partial \mathcal{F}))$ defined by (2.29) is self-adjoint and since $\partial \mathcal{F}$ is of class $C^{1,1}$,

where here F, G, F_{div} and F_b are given.

Let us remark that the results given in this section can be obtained for general operators A_1 , A_2 , T, $\Lambda^{(1)}$ and $\Lambda^{(2)}$. More precisely, we only need to assume that $A_1 : \mathcal{D}(A_1) \subset \mathcal{H}_S \to \mathcal{H}_S$ and $A_2 : \mathcal{D}(A_2) \subset \mathcal{H}_S \to \mathcal{H}_S$ are positive, densely defined, self-adjoint and with compact resolvents and that $\mathcal{D}(A_1^{1/2}) \hookrightarrow \mathcal{D}(A_2)$,

Assumption (3.5) is crucial in our analysis since it allows to invoke [17] and to obtain the analyticity of the semigroup generated by the underlying linear operator of system (3.1)-(3.4) (see Proposition 3.11 below). We suppose that $T \in \mathcal{L}(\mathcal{H}_{\mathcal{S}}, \mathbf{V}^{0}(\partial \mathcal{F}))$ satisfies (2.55), (2.57), (2.56), (2.58), that $(T\xi)_{\Gamma_{0}} \equiv 0$ for any $\xi \in \mathcal{H}_{\mathcal{S}}$. Finally, the operators $\Lambda^{(1)}$, $\Lambda^{(2)}$ are assumed to satisfy (2.59), (2.60), (2.61), (2.62) and (2.63). Note that the operators A_1 , A_2 , T, $\Lambda^{(1)}$ and $\Lambda^{(2)}$ defined by (1.16), (1.17), (2.28) and (2.44) satisfy the above conditions. We still assume that $\Xi \in \mathcal{L}(\mathbf{L}^{2}(\partial \mathcal{F}))$ is the self-adjoint operator defined by (2.29). We need its precise

definition to obtain the adjoint of the control operator (see (3.67) below). We recall that Ξ satisfies (2.53). We first consider system (3.1)–(3.4) in the case F = 0, G = 0, $F_{\text{div}} = 0$ and $F_b = 0$:

The above system is completed with the initial conditions

We show that the system (3.6)–(3.11) can be rewritten in the form

where A is the infinitesimal generator of an analytic semigroup. This abstract form is quite standard in the study of the stabilizability for the Navier–Stokes system, see [35].

We consider the space $\mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S$ equipped with the scalar product:

Let us define \mathbb{P} the orthogonal projection of $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2}) \times \mathcal{H}_{\mathcal{S}}$ onto \mathcal{H} .

We have the following characterization of the orthogonal of \mathcal{H} in $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2}) \times \mathcal{H}_{\mathcal{S}}$.

Proposition 3.1. The orthogonal of \mathcal{H} in $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2}) \times \mathcal{H}_{\mathcal{S}}$ is given by

Proof. Assume $[w^{(1)}, \xi_1^{(1)}, \xi_2^{(1)}] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}}$ satisfies for all $[w^{(2)}, \xi_1^{(2)}, \xi_2^{(2)}] \in \mathcal{H}$:

I, Prop. 1.1 and Rem 1.4]. Thus, by plugging $w^{(1)} = \nabla p$ in (3.15) and integrating by parts, we obtain that

Proof. First, by using (3.14) we verify that for any $[w, \xi_1, \xi_2] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S$,

From (3.17), we deduce that

Then, we deduce from (2.56) and from the $C^{1,1}$ regularity of $\partial \mathcal{F}$ that $(T\xi_2) \cdot n \in H^{1/2}(\partial \mathcal{F})$. Similarly, from (2.56) and (2.57) we get

Then the conclusion follows by an interpolation argument.

As a consequence, since \mathbb{P} is self-adjoint on \mathcal{H} , a duality argument yields the following result.

Corollary 3.3. The orthogonal projection operator $\mathbb{P}: \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}} \to \mathcal{H}$ can be extended as an operator satisfying for $s \in (0, 1]$:

$$\mathbb{P} \in \mathcal{L}(\mathbf{H}^{s}(\mathcal{F})' \times \mathcal{D}(A_{1}^{1/2-s/4}) \times \mathcal{D}(A_{1}^{s/4})', \mathbf{H}^{s}(\mathcal{F})' \times \mathcal{D}(A_{1}^{1/2-s/4}) \times \mathcal{D}(A_{1}^{s/4})').$$
(3.18)

3.2The operator A_0

First, we define the linear operator $A_0: \mathcal{D}(A_0) \subset \mathcal{H} \to \mathcal{H}$ as follows: we set

$$\mathcal{D}(A_0) \stackrel{\text{def}}{=} \mathcal{V} \cap \Big[\mathbf{H}^2(\mathcal{F}) \times \mathcal{D}(A_1) \times \mathcal{D}(A_1^{1/2}) \Big], \tag{3.19}$$

and for $[w, \xi_1, \xi_2] \in \mathcal{D}(A_0)$, we set

$$\widetilde{A}_{0} \begin{bmatrix} w\\ \xi_{1}\\ \xi_{2} \end{bmatrix} \stackrel{\text{def}}{=} \begin{bmatrix} \nu \Delta w\\ \xi_{2}\\ -A_{1}\xi_{1} - A_{2}\xi_{2} - T^{*}(2\nu D(w)n) \end{bmatrix}$$
(3.20)

and

$$A_0 \stackrel{\text{def}}{=} \mathbb{P} \widetilde{A}_0. \tag{3.21}$$

Proposition 3.4. The operator A_0 defined by (3.19)–(3.21) is densely defined with compact resolvent and it is the infinitesimal generator of a strongly continuous semigroup of contractions on \mathcal{H} .

Proof. Standard calculation gives, for all $\mathbf{Z} \in \mathcal{D}(A_0)$, $\langle A_0 \mathbf{Z}, \mathbf{Z} \rangle \leq 0$ which implies that A_0 is dissipative. Then, we show that $(\lambda - A_0)$ is onto for some $\lambda > 0$: assume $\mathbf{F} = [f, g, h] \in \mathcal{H}$, we have to prove the existence and the uniqueness of $\mathbf{Z} = [w, \xi_1, \xi_2] \in \mathcal{D}(A_0)$ such that

$$\lambda w - \nu \Delta w + \nabla q = f \quad \text{in } \mathcal{F},$$

$$\operatorname{div} w = 0 \quad \text{in } \mathcal{F},$$

$$w = T\xi_2 \quad \text{on } \partial \mathcal{F},$$

$$\lambda \xi_1 - \xi_2 = g,$$

$$\lambda \xi_2 + A_2 \xi_2 + A_1 \xi_1 = -T^* \left(\mathbb{T}(w, q)n\right) + h.$$
(3.22)

Let us consider a variational formulation associated to (3.22): find

$$[w,\xi_2] \in \mathbb{V} \stackrel{\text{def}}{=} \left\{ [w,\xi_2] \in \mathbf{H}^1(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) ; \text{ div } w = 0, \ w = T\xi_2 \text{ on } \partial \mathcal{F} \right\},$$
(3.23)

such that for any $[\varphi, \zeta_2] \in \mathbb{V}$,

$$\lambda \left(\int_{\mathcal{F}} w \cdot \varphi dy + \left(\xi_{2}, \zeta_{2}\right)_{\mathcal{H}_{\mathcal{S}}} \right) + 2\nu \int_{\mathcal{F}} Dw : D\varphi \, dy + \left(A_{2}^{1/2}\xi_{2}, A_{2}^{1/2}\zeta_{2} \right)_{\mathcal{H}_{\mathcal{S}}} \\ + \frac{1}{\lambda} \left(A_{1}^{1/2}\xi_{2}, A_{1}^{1/2}\zeta_{2} \right)_{\mathcal{H}_{\mathcal{S}}} = \int_{\mathcal{F}} f \cdot \varphi \, dy + \left(h, \zeta_{2} \right)_{\mathcal{H}_{\mathcal{S}}} - \frac{1}{\lambda} \left(A_{1}^{1/2}g, A_{1}^{1/2}\zeta_{2} \right)_{\mathcal{H}_{\mathcal{S}}}.$$
(3.24)

The Riesz theorem gives the existence and uniqueness of $[w, \xi_2] \in \mathbb{V}$ satisfying (3.24). Taking $\zeta_2 = 0$ in (3.24) and using the De Rham theorem, we obtain the existence of q such that (w, q) is the weak solution of the Stokes system (the three first equations of (3.22)). From (2.56), we deduce $T\xi_2 \in \mathbf{V}^{3/2}(\partial \mathcal{F})$ and thus, since $f \in \mathbf{L}^2(\mathcal{F})$, standard elliptic results on the Stokes system give $w \in \mathbf{H}^2(\mathcal{F})$ and $q \in H^1(\mathcal{F})$. In particular, $\mathbb{T}(w, q)n \in \mathbf{H}^{1/2}(\partial \mathcal{F})$ and thus $T^*(\mathbb{T}(w, q)n) \in \mathcal{H}_S$.

We write $\xi_1 = \lambda^{-1}(\xi_2 + g)$ and we use that (w, q) satisfies the Stokes system to transform (3.24) into

$$\left(A_1^{1/2}\xi_1, A_1^{1/2}\zeta_2\right)_{\mathcal{H}_{\mathcal{S}}} = -\lambda\left(\xi_2, \zeta_2\right)_{\mathcal{H}_{\mathcal{S}}} - \left(A_2\xi_2, \zeta_2\right)_{\mathcal{H}_{\mathcal{S}}} - \left(T^*\left(\mathbb{T}(w, q)n\right), \zeta_2\right)_{\mathcal{H}_{\mathcal{S}}} + \left(h, \zeta_2\right)_{\mathcal{H}_{\mathcal{S}}},$$

for all $\zeta_2 \in \mathcal{D}(A_1^{1/2})$. Note that we have used the continuous embedding $D(A_1^{1/2}) \hookrightarrow D(A_2)$. The above system implies that $A_1\xi_1 \in \mathcal{H}_S$ and thus that $\xi_1 \in \mathcal{D}(A_1)$. Finally, the fact that A_0 is densely defined with compact resolvent is straightforward.

Proposition 3.5. The semigroup generated by A_0 is exponentially stable on \mathcal{H} .

Proof. To show the exponential stability of the semigroup, we use the classical result of Gearhart (see, for instance, [31, Theorem 1.3.2, p.4]): since $(e^{tA})_{t>0}$ is a C_0 -semigroup of contractions on the Hilbert space \mathcal{H} (see Proposition 3.4), then it is exponentially stable if and only if

$$i\mathbb{R} \subset \rho(A_0), \tag{3.25}$$

and

$$\sup_{\tau \in \mathbb{R}} \| (i\tau - A_0)^{-1} \|_{\mathcal{L}(\mathcal{H})} < \infty.$$
(3.26)

Using that A generates a semigroup of contractions, we have (see, for instance, [32, Corollary 3.6, p.11])

$$\forall \lambda \in \mathbb{C}, \ \Re \lambda > 0 \quad \Re \lambda \| (\lambda - A_0)^{-1} \|_{\mathcal{L}(\mathcal{H})} \leq 1.$$
(3.27)

In order to prove the exponential stability of $(e^{tA})_{t>0}$, we show the existence of C > 0 such that:

$$\forall \lambda \in \mathbb{C}, \ \Re \lambda \in (0,1) \quad \| (\lambda - A_0)^{-1} \|_{\mathcal{L}(\mathcal{H})} \leqslant C.$$
(3.28)

The above estimate yields the result: indeed, for $\tau \in \mathbb{R}$ and $\delta \in (0, 1)$, one can write the formula

$$(i\tau - A_0) = (i\tau + \delta - A_0)(I - \delta(i\tau + \delta - A_0)^{-1}).$$

Taking $\delta < 1/C$ where C is the constant in (3.28), it yields (3.25) and (3.26).

Now let us prove (3.28): assume $\lambda \in \mathbb{C}$ with $\Re \lambda \in (0, 1)$ and assume $(\lambda - A_0)[w, \xi_1, \xi_2] = [f, g, h] \in \mathcal{H}$. This relation can be written as (3.22). Multiplying by $[w, \xi_1, \xi_2]$, we first obtain

$$\Re\lambda\left(\|w\|_{\mathbf{L}^{2}(\mathcal{F})}^{2}+\|\xi_{2}\|_{\mathcal{H}_{\mathcal{S}}}^{2}+\|A_{1}^{1/2}\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}}^{2}\right)+2\nu\int_{\mathcal{F}}|Dw|^{2}\,dy+\|A_{2}^{1/2}\xi_{2}\|_{\mathcal{H}_{\mathcal{S}}}^{2}\\ \leqslant C\|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_{1},\xi_{2}]\|_{\mathcal{H}}.$$
(3.29)

Moreover, since Γ_0 is a nonempty open subset such that w = 0 on Γ_0 , we have the Poincaré inequality $||w||_{\mathbf{H}^1(\mathcal{F})} \leq C ||\nabla w||_{\mathbf{L}^2(\mathcal{F})}$. Combining this relation with the trace inequality, the Korn inequality and (2.55), we deduce that:

$$\|\xi_2\|_{\mathcal{H}_{\mathcal{S}}}^2 \leqslant C \|T\xi_2\|_{\mathbf{V}^{1/2}(\partial\mathcal{F})}^2 \leqslant C \|w\|_{\mathbf{H}^1(\mathcal{F})}^2 \leqslant C \int_{\mathcal{F}} |Dw|^2 \, dy.$$

Then using the above inequality with (3.29) we obtain

$$\|w\|_{\mathbf{H}^{1}(\mathcal{F})}^{2} + \|T\xi_{2}\|_{\mathbf{V}^{1/2}(\partial\mathcal{F})}^{2} + \|\xi_{2}\|_{\mathcal{H}_{\mathcal{S}}}^{2} \leqslant C\|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_{1},\xi_{2}]\|_{\mathcal{H}}.$$
(3.30)

Combining the above inequality with $\lambda \xi_1 = \xi_2 + g$ and (2.56) yields

$$|\lambda|^2 \|\xi_1\|_{\mathcal{H}_{\mathcal{S}}}^2 + |\lambda|^2 \|T\xi_1\|_{\mathbf{V}^{1/2}(\partial\mathcal{F})}^2 \leqslant C \|[f,g,h]\|_{\mathcal{H}}^2 + C \|[f,g,h]\|_{\mathcal{H}} \|[w,\xi_1,\xi_2]\|_{\mathcal{H}}.$$
(3.31)

Next, from the two last equalities in (3.22) we obtain

$$A_1\xi_1 = -T^*\mathbb{T}(w,p)n + h + A_2g - \lambda A_2\xi_1 + \lambda g - \lambda^2\xi_1.$$

Then by multiplying the above equation by ξ_1 and using $D(A_1^{1/2}) \hookrightarrow D(A_2)$ we deduce

$$\|A_{1}^{1/2}\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}}^{2} \leqslant C\left(\|\mathbb{T}(w,p)n\|_{\mathbf{V}^{-1/2}(\partial\mathcal{F})}\|T\xi_{1}\|_{\mathbf{V}^{1/2}(\partial\mathcal{F})} + \|h\|_{\mathcal{H}_{\mathcal{S}}}\|\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}} + \|A_{1}^{1/2}g\|_{\mathcal{H}_{\mathcal{S}}}\|A_{1}^{1/2}\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}} + \|A_{1}^{1/2}\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}}\|\lambda\|\|\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}} + \|g\|_{\mathcal{H}_{\mathcal{S}}}|\lambda|\|\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}} + |\lambda|^{2}\|\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}}^{2}\right).$$
(3.32)

The above inequality, (2.56) and (3.31) yield

$$\|A_1^{1/2}\xi_1\|_{\mathcal{H}_{\mathcal{S}}}^2 \leqslant C\left(\|\mathbb{T}(w,p)n\|_{\mathbf{V}^{-1/2}(\partial\mathcal{F})}^2 \frac{1}{1+|\lambda|^2} + \|[f,g,h]\|_{\mathcal{H}}^2 + \|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_1,\xi_2]\|_{\mathcal{H}}\right).$$
(3.33)

Moreover, from the following Green formula

$$\forall \varphi \in \mathbf{V}^{1}(\mathcal{F}) \quad \int_{\partial \mathcal{F}} \mathbb{T}(w, p) n \cdot \varphi d\Gamma = \int_{\mathcal{F}} \operatorname{div} \mathbb{T}(w, p) \cdot \varphi dy + \int_{\mathcal{F}} 2\nu Dw : D\varphi dy$$
(3.34)

we deduce

$$\|\mathbb{T}(w,p)n\|_{\mathbf{V}^{-1/2}(\partial\mathcal{F})}^{2} \leqslant C\left(\|w\|_{\mathbf{H}^{1}(\mathcal{F})}^{2} + \|\operatorname{div}\mathbb{T}(w,p)\|_{\mathbf{L}^{2}(\mathcal{F})}^{2}\right)$$

and with (3.30) and the first equation in (3.22) we obtain

$$\|\mathbb{T}(w,p)n\|_{\mathbf{V}^{-1/2}(\partial\mathcal{F})}^{2} \leqslant C\left(\|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_{1},\xi_{2}]\|_{\mathcal{H}}+\|[f,g,h]\|_{\mathcal{H}}^{2}+|\lambda|^{2}\|w\|_{\mathbf{L}^{2}(\mathcal{F})}^{2}\right).$$

Then combining this last estimate with (3.33) yields

$$\|A_1^{1/2}\xi_1\|_{\mathcal{H}_{\mathcal{S}}}^2 \leq C\left(\|w\|_{\mathbf{L}^2(\mathcal{F})}^2 + \|[f,g,h]\|_{\mathcal{H}}^2 + \|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_1,\xi_2]\|_{\mathcal{H}}\right)$$

Moreover, this last estimates with (3.30) yields

$$\|w\|_{\mathbf{L}^{2}(\mathcal{F})}^{2} + \|\xi_{2}\|_{\mathcal{H}_{\mathcal{S}}}^{2} + \|A_{1}^{1/2}\xi_{1}\|_{\mathcal{H}_{\mathcal{S}}}^{2} \leq C\left(\|[f,g,h]\|_{\mathcal{H}}^{2} + \|[f,g,h]\|_{\mathcal{H}}\|[w,\xi_{1},\xi_{2}]\|_{\mathcal{H}}\right),$$

and it proves (3.28).

Remark 3.6. Assumption (3.5) is not used in the proof of Proposition 3.5. It remains true even if $A_2 = 0$. We have the following characterization of the adjoint of A_0 .

Proposition 3.7. The adjoint of the operator A_0 is given by

$$\mathcal{D}(A_0^*) = \mathcal{D}(A_0) \tag{3.35}$$

and

$$A_0^* \begin{bmatrix} \varphi \\ \zeta_1 \\ \zeta_2 \end{bmatrix} = \mathbb{P} \begin{bmatrix} \nu \Delta \varphi \\ -\zeta_2 \\ A_1 \zeta_1 - A_2 \zeta_2 - T^* \left(2\nu D(\varphi) n \right) \end{bmatrix}.$$
(3.36)

Proof. Equality (3.36) follows from an integration by parts and (3.35) is obtained from regularity results for the Stokes system as in Proposition 3.4.

Proposition 3.8. For $\alpha \in [0, 1]$, the following equalities hold

$$\mathcal{D}((-A_0)^{\alpha}) = [\mathcal{D}(A_0), \mathcal{H}]_{1-\alpha} = [\mathcal{D}(A_0^*), \mathcal{H}]_{1-\alpha} = \mathcal{D}((-A_0^*)^{\alpha}),$$
(3.37)

where $[\cdot, \cdot]$. denotes the complex interpolation method. Moreover, we have

$$\mathcal{D}((-A_0)^{\alpha}) = \left[\mathbf{H}^{2\alpha}(\mathcal{F}) \times \mathcal{D}(A_1^{1/2 + \alpha/2}) \times \mathcal{D}(A_1^{\alpha/2})\right] \cap \mathcal{H} \quad if \ \alpha \in (0, 1/4),$$
(3.38)

$$\mathcal{D}((-A_0)^{\alpha}) = \left\{ [w, \xi_1, \xi_2] \in \left[\mathbf{H}^{2\alpha}(\mathcal{F}) \times \mathcal{D}(A_1^{1/2 + \alpha/2}) \times \mathcal{D}(A_1^{\alpha/2}) \right] \cap \mathcal{H} ; \ w = T\xi_2 \ on \ \partial \mathcal{F} \right\} \ if \ \alpha \in (1/4, 1) .$$
(3.39)

Proof. Relations (3.37) are consequences of $\mathcal{D}(A_0^*) = \mathcal{D}(A_0)$ and of the maximal accretivity of $-A_0$, see [11, Prop. 6.1, p170].

To prove the last two relations, we introduce the Dirichlet map defined by $D_0(\xi_2) = z$ where z is the solution of

$$\begin{cases} -\Delta z + \nabla \pi &= 0 \text{ in } \mathcal{F}, \\ \operatorname{div} z &= 0 \text{ in } \mathcal{F}, \\ z &= T\xi_2 \text{ on } \partial \mathcal{F}. \end{cases}$$

Using (2.56) and standard result on the Stokes system, we deduce that for any $\alpha \in [0, 1]$,

$$D_0 \in \mathcal{L}\left(\mathcal{D}(A_1^{\alpha/2}), \mathbf{H}^{2\alpha}(\mathcal{F})\right).$$

It is clear that

$$\mathcal{D}(A_0) = \left\{ [w, \xi_1, \xi_2] \in \mathbf{H}^2(\mathcal{F}) \times \mathcal{D}(A_1) \times \mathcal{D}(A_1^{1/2}) ; \ w - D_0 \xi_2 \in \mathbf{V}_0^2(\Omega) \right\}$$

and that

$$\mathcal{H} = \left\{ [w, \xi_1, \xi_2] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}} ; w - D_0 \xi_2 \in \mathbf{V}_n^0(\mathcal{F}) \right\}$$

More precisely, $[w, \xi_1, \xi_2] \mapsto [w - D_0 \xi_2, \xi_1, \xi_2]$ is an isomorphism from $\mathcal{D}(A_0)$ onto $\mathbf{V}_0^2(\Omega) \times \mathcal{D}(A_1) \times \mathcal{D}(A_1^{1/2})$ as well as from \mathcal{H} onto $\mathbf{V}_n^0(\Omega) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S$. We deduce by interpolation that for all $\alpha \in [0, 1]$:

$$[\mathcal{D}(A_0),\mathcal{H}]_{1-\alpha} = \left\{ [w,\xi_1,\xi_2] \in \mathcal{H} ; \ (\xi_1,\xi_2) \in \mathcal{D}(A_1^{1/2+\alpha/2}) \times \mathcal{D}(A_1^{\alpha/2}), \ w - D_0\xi_2 \in [\mathbf{V}_0^2(\mathcal{F}),\mathbf{V}_n^0(\mathcal{F})]_{1-\alpha} \right\}.$$

Then the conclusion follows from (3.37), from

$$[\mathbf{V}_0^2(\mathcal{F}),\mathbf{V}_n^0(\mathcal{F})]_{1-\alpha}=[\mathbf{H}^2(\mathcal{F})\cap\mathbf{H}_0^1(\mathcal{F}),\mathbf{L}^2(\mathcal{F})]_{1-\alpha}\cap\mathbf{V}_n^0(\mathcal{F})$$

(see [22]) and from the characterization of this last interpolation space (see [25]).

Corollary 3.9. The following continuous embedding holds:

$$\mathcal{D}((-A_0)^{\alpha})' \hookrightarrow \mathbf{H}^{2\alpha}(\mathcal{F})' \times \mathcal{D}(A_1^{1/2 - \alpha/2}) \times \mathcal{D}(A_1^{\alpha/2})' \quad if \ \alpha \in [0, 1/4).$$
(3.40)

Proof. First, from (3.38) we deduce that for $\alpha \in [0, 1/4)$,

$$\mathbb{P} \in \mathcal{L}(\mathbf{H}^{2\alpha}(\mathcal{F}) \times \mathcal{D}(A_1^{1/2+\alpha/2}) \times \mathcal{D}(A_1^{\alpha/2}), \mathcal{D}((-A_0)^{\alpha})).$$

Then for $\mathbf{X} \in \mathcal{H}$ and $\mathbf{Y} \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S$ we have

$$\langle \mathbf{X}, \mathbf{Y} \rangle = \langle \mathbf{X}, \mathbb{P}\mathbf{Y} \rangle \leqslant \|\mathbf{X}\|_{\mathcal{D}((-A_0)^{\alpha})'} \|\mathbb{P}\mathbf{Y}\|_{\mathcal{D}((-A_0)^{\alpha})} \leqslant C \|\mathbf{X}\|_{\mathcal{D}((-A_0)^{\alpha})'} \|\mathbf{Y}\|_{\mathbf{H}^{2\alpha}(\mathcal{F}) \times \mathcal{D}(A_1^{1/2 + \alpha/2}) \times \mathcal{D}(A_1^{\alpha/2})}.$$

Then it follows,

$$\|\mathbf{X}\|_{\mathbf{H}^{2\alpha}(\mathcal{F})'\times\mathcal{D}(A_1^{1/2-\alpha/2})\times\mathcal{D}(A_1^{\alpha/2})'} \leqslant C \|\mathbf{X}\|_{\mathcal{D}((-A_0)^{\alpha})'},$$

and we conclude with a density argument.

We recall a classical result for analytic semigroups (see [32, Thm 5.2, p.61])

Lemma 3.10. Assume A is the infinitesimal generator of a strongly continuous semigroup on \mathcal{H} with an exponential growth lower or equal to zero i.e. $\sup_{t\geq 0} \|e^{tA}\| < +\infty$. If $i\mathbb{R} \subset \rho(A)$ and if there exists $C_0 > 0$ such that,

$$\left\| (i\tau - A)^{-1} \right\|_{\mathcal{L}(\mathcal{H})} \leqslant \frac{C_0}{|\tau|} \quad (\tau \in \mathbb{R}^*), \tag{3.41}$$

then (e^{tA}) is an analytic semigroup on \mathcal{H} .

We recall the proof of this lemma for sake of completeness.

Proof. First we have $0 \in \rho(A)$. Assume $\lambda \in \mathbb{C}$. We write

$$(\lambda - A) = (i\Im\lambda - A) \left(\mathrm{Id} + \Re\lambda(i\Im\lambda - A)^{-1} \right).$$

Assume $\Im \lambda \neq 0$. Then from (3.41)

$$\|(i\Im\lambda - A)^{-1}\|_{\mathcal{L}(\mathcal{H})} \leqslant \frac{C_0}{|\Im\lambda|}$$

Therefore, if

$$|\Re\lambda| \leqslant \alpha \frac{|\Im\lambda|}{C_0} \tag{3.42}$$

for some $\alpha \in (0, 1)$, then $(\mathrm{Id} + \Re \lambda (i\Im \lambda - A)^{-1})$ is invertible and

$$\left\| \left(\mathrm{Id} + \Re \lambda (i\Im \lambda - A)^{-1} \right)^{-1} \right\|_{\mathcal{L}(\mathcal{H})} \leqslant \frac{1}{1 - \alpha}.$$

Thus any λ satisfying (3.42) belongs to $\rho(A)$ and satisfies

$$\|(\lambda - A)^{-1}\|_{\mathcal{L}(\mathcal{H})} \leq \frac{C}{|\lambda|}.$$

Since (e^{tA}) is a strongly continuous semigroup on \mathcal{H} with an exponential growth lower or equal to zero, for λ such that $\Re \lambda > 0$, we have $\lambda \in \rho(A)$ and

$$\|(\lambda - A)^{-1}\|_{\mathcal{L}(\mathcal{H})} \leq \frac{C}{\Re\lambda},$$

see [11, Thm 2.5 p 101]. If moreover,

$$\Re \lambda \geqslant \alpha \frac{|\Im \lambda|}{C_0},$$

then we deduce

$$\|(\lambda - A)^{-1}\|_{\mathcal{L}(\mathcal{H})} \leq \frac{C}{|\lambda|}.$$

Thus there exists $\delta \in (0, \pi/2)$ such that

$$\rho(A) \supset \Sigma \stackrel{\text{\tiny def}}{=} \left\{ \lambda \in \mathbb{C} \ ; \ |\arg \lambda| < \frac{\pi}{2} + \delta \right\} \cup \{0\}$$

and

$$\|(\lambda - A)^{-1}\|_{\mathcal{L}(\mathcal{H})} \leq \frac{C}{|\lambda|} \quad (\lambda \in \Sigma \setminus \{0\}).$$

Applying [32, Thm 5.2, p.61], we deduce that (e^{tA}) is an analytic semigroup.

Proposition 3.11. The operator A_0 defined by (3.19), (3.20), (3.21) is the infinitesimal generator of an analytic semigroup on \mathcal{H} .

Proof. We apply Lemma 3.10. We already know from Proposition 3.5 that $i\mathbb{R} \subset \rho(A_0)$. For $\tau \in \mathbb{R}^*$, we consider the equation $(i\tau - A_0)\mathbf{Z} = \mathbf{F} \in \mathcal{H}$. Setting $\mathbf{Z} = [w, \xi_1, \xi_2]$ and $\mathbf{F} = [f, g, h]$ we can write

Multiplying the first equation by \overline{w} and performing an integration by parts we obtain:

$$i\tau \left(\int_{\mathcal{F}} |w|^2 dy + \|\xi_2\|_{\mathcal{H}_{\mathcal{S}}}^2 \right) + 2\nu \int_{\mathcal{F}} |Dw|^2 dy + \|A_2^{1/2}\xi_2\|_{\mathcal{H}_{\mathcal{S}}}^2 + \left(A_1\xi_1, \xi_2\right)_{\mathcal{H}_{\mathcal{S}}} = \int_{\mathcal{F}} f \cdot \overline{w} \, dy + \left(h, \xi_2\right)_{\mathcal{H}_{\mathcal{S}}}.$$
 (3.44)

Next, using $\xi_2 = i\tau\xi_1 - g$ we deduce

$$i\tau \left(\int_{\mathcal{F}} |w|^2 dy + \|\xi_2\|_{\mathcal{H}_{\mathcal{S}}}^2 - \|A_1^{1/2}\xi_1\|_{\mathcal{H}_{\mathcal{S}}}^2 \right) + 2\nu \int_{\mathcal{F}} |Dw|^2 \, dy + \|A_2^{1/2}\xi_2\|_{\mathcal{H}_{\mathcal{S}}}^2$$
$$= \int_{\mathcal{F}} f \cdot \overline{w} \, dy + \left(h,\xi_2\right)_{\mathcal{H}_{\mathcal{S}}} + \left(A_1^{1/2}\xi_1, A_1^{1/2}g\right)_{\mathcal{H}_{\mathcal{S}}}.$$
 (3.45)

Then multiplying by τ and taking the imaginary part of the above equation first gives:

$$|\tau|^2 \|[w,\xi_1,\xi_2]\|_{\mathcal{H}}^2 = 2|\tau|^2 \|A_1^{1/2}\xi_1\|_{\mathcal{H}_{\mathcal{S}}}^2 + \Im\langle [f,g,h],\tau[w,\xi_1,\xi_2]\rangle_{\mathcal{H}},$$

and with the Cauchy-Schwarz inequality, we obtain:

$$|\tau|^{2} ||[w,\xi_{1},\xi_{2}]||_{\mathcal{H}}^{2} \leqslant 4|\tau|^{2} ||A_{1}^{1/2}\xi_{1}||_{\mathcal{H}_{\mathcal{S}}}^{2} + ||[f,g,h]||_{\mathcal{H}}^{2}.$$
(3.46)

We now consider the equation of the structure (the last two equations of (3.43)): since the dissipation (the term $A_2\xi_2$) is sufficient, the corresponding system is parabolic. More precisely, since A_2 is a positive, densely defined, self-adjoint operator on \mathcal{H}_S with (3.5), Theorem 1.1 in [17] guarantees that

Then by combining (3.46), (3.47) and the boundedness of $T^*: \mathbf{L}^2(\partial \mathcal{F}) \to \mathcal{H}_S$ we deduce that:

In order to remove the term $\|\mathbb{T}(w,p)n\|_{\mathbf{L}^2(\partial\mathcal{F})}$ in the above estimate, we first use the trace theorem and regularity results for the Stokes system, for $\epsilon \in (0, 1/4)$:

and then with the first equality in (3.43) and the boundedness of $T: \mathcal{D}(A_1^{1/2-\epsilon/2}) \to \mathbf{V}^{2-2\epsilon}(\partial \mathcal{F})$ we get

$$\|\mathbb{T}(w,p)n\|_{\mathbf{L}^{2}(\partial\mathcal{F})} \leqslant C\left(\|f\|_{\mathbf{L}^{2}(\mathcal{F})} + |\tau|\|w\|_{(\mathbf{H}^{2\epsilon}(\mathcal{F}))'} + \|\xi_{2}\|_{\mathcal{D}(A_{1}^{1/2-\epsilon/2})}\right).$$
(3.49)

Combining the above relation with $\xi_2 = i\tau\xi_1 - g$ we deduce

$$\|\mathbb{T}(w,p)n\|_{\mathbf{L}^{2}(\partial\mathcal{F})} \leqslant C\left(\|f\|_{\mathbf{L}^{2}(\mathcal{F})} + \|g\|_{\mathcal{D}(A_{1}^{1/2})} + |\tau|\|w\|_{(\mathbf{H}^{2\epsilon}(\mathcal{F}))'} + |\tau|\|\xi_{1}\|_{\mathcal{D}(A_{1}^{1/2-\epsilon/2})}\right).$$
(3.50)

Now let us prove that for $\epsilon \in (0, 1/4)$,

$$\|w\|_{(\mathbf{H}^{2\epsilon}(\mathcal{F}))'} + \|\xi_1\|_{\mathcal{D}\left(A_1^{1/2-\epsilon/2}\right)} \leqslant C\|[w,\xi_1,\xi_2]\|_{(\mathcal{D}((-A_0)^{\epsilon}))'}.$$

Assume $(\varphi, \zeta_1) \in \mathbf{H}^{2\epsilon}(\mathcal{F}) \times \mathcal{D}(A_1^{1/2+\epsilon/2})$ with $\epsilon \in (0, 1/4)$. Using Proposition 3.2 and Proposition 3.8, we have $\mathbb{P}[\varphi, \zeta_1, 0] \in \mathcal{D}((-A_0)^{\epsilon})$. Then we can write

Consequently, we deduce (3.51) and combining it with (3.50) yields

The above relation and (3.48) imply

$$|\tau|||[w,\xi_1,\xi_2]||_{\mathcal{H}} \leq C(|\tau|||(-A_0)^{-\epsilon}[w,\xi_1,\xi_2]||_{\mathcal{H}} + ||[f,g,h]||_{\mathcal{H}}).$$

Recalling $(i\tau - A_0)\mathbf{Z} = \mathbf{F}$, this can be written

$$\|i\tau(i\tau - A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} \leqslant C(\|i\tau(-A_0)^{-\epsilon}(i\tau - A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} + \|\mathbf{F}\|_{\mathcal{H}}).$$

Thus, remarking that $(-A_0)^{-\epsilon}(i\tau - A_0)^{-1}\mathbf{F} = (i\tau - A_0)^{-1}(-A_0)^{-\epsilon}\mathbf{F}$, by using (3.52) with $(-A_0)^{-\epsilon}\mathbf{F}$ instead of \mathbf{F} , we deduce that

$$\|i\tau(i\tau - A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} \leqslant C(\|i\tau(-A_0)^{-2\epsilon}(i\tau - A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} + \|\mathbf{F}\|_{\mathcal{H}})$$

Then by iterating the argument we finally prove that for all $n \in \mathbb{N}^*$ there exists $C_n > 0$ such that

$$\|i\tau(i\tau-A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} \leqslant C_n(\|i\tau(-A_0)^{-n\epsilon}(i\tau-A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} + \|\mathbf{F}\|_{\mathcal{H}}),$$

and for $n \ge 1/\epsilon$, the above relation with $i\tau(i\tau - A_0)^{-1}\mathbf{F} = A_0(i\tau - A_0)^{-1}\mathbf{F} + \mathbf{F}$ and (3.26) finally yields $\|i\tau(i\tau - A_0)^{-1}\mathbf{F}\|_{\mathcal{H}} \le C \|\mathbf{F}\|_{\mathcal{H}}$ which gives the result.

(3.54)

and

$$\stackrel{\text{\tiny def}}{=} \mathbb{P}\widetilde{A},\tag{3.55}$$

where $\mathbb{P}: \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}} \to \mathcal{H}$ is the orthogonal projection operator.

Proposition 3.12. The operator A defined by (3.53), (3.54), and (3.55) is densely defined with compact resolvent, and it is the infinitesimal generator of an analytic semigroup on \mathcal{H} . Moreover, the adjoint of the operator A is given by $\mathcal{D}(A^*) = \mathcal{D}(A)$ and

$$A^* \begin{bmatrix} \varphi \\ \zeta_1 \\ \zeta_2 \end{bmatrix} = \mathbb{P} \begin{bmatrix} \nu \Delta \varphi + (v^S \cdot \nabla) \varphi - (\nabla v^S)^* \varphi \\ -\zeta_2 - A_1^{-1} \left(\Lambda^{(1,1)} \right)^* (\nabla \varphi) - A_1^{-1} \left(\Lambda^{(2,1)} \right)^* (\varphi) \\ A_1 \zeta_1 - A_2 \zeta_2 - T^* \left(2\nu D(\varphi)n \right) - \left(\Lambda^{(1,2)} \right)^* (\nabla \varphi) - \left(\Lambda^{(2,2)} \right)^* (\varphi) \end{bmatrix}.$$

Proof. We write

 $A = A_0 + A_{\flat}$

where A_0 is defined by (3.19), (3.20), (3.21) and is the infinitesimal generator of an analytic semigroup on \mathcal{H} (Proposition 3.11). Relations (2.59), (2.60) and (1.34) combined with Proposition 3.8 yield that $\mathcal{D}(A_b) \subset \mathcal{D}((-A_0)^{1/2})$. Using a perturbation argument (see, for instance, [32, Corollary 2.4, p. 81]), we deduce the first part of the Proposition.

To characterize the adjoint of A, assume $[w, \xi_1, \xi_2], [\varphi, \zeta_1, \zeta_2] \in \mathcal{D}(A)$ and we observe that:

Thus

$$\langle A[w,\xi_1,\xi_2], [\varphi,\zeta_1,\zeta_2] \rangle = \langle [w,\xi_1,\xi_2], A_0^*[\varphi,\zeta_1,\zeta_2] \rangle - \int_{\mathcal{F}} \Lambda^{(1)}(\xi_1,\xi_2) : \nabla\varphi \ dy - \int_{\mathcal{F}} \Lambda^{(2)}(\xi_1,\xi_2) \cdot \varphi \ dy + \int_{\mathcal{F}} \left((v^S \cdot \nabla)\varphi - (\nabla v^S)^*\varphi \right) \cdot w \ dy.$$
(3.58)

Here we have used that $v^S = 0$ on Γ_{str} and $\varphi = 0$ on Γ_0 . Using (2.61) we deduce the result.

Let us fix $\lambda_0 > 0$ large enough so that $\lambda_0 - A$ is positive and $(\lambda_0 - A)^{\alpha}$ is well defined for $\alpha \in (0, 1)$. We deduce from Proposition 3.12 and similarly as for Proposition 3.8 the following result.

In particular, $\mathcal{D}((\lambda_0 - A)^{\alpha}) = \mathcal{D}((\lambda_0 - A^*)^{\alpha}) = \mathcal{D}((-A_0)^{\alpha})$ is characterized by (3.38) and (3.39).

Proof. Equalities (3.59) are consequences of $\mathcal{D}(A) = \mathcal{D}(A^*)$ and of the maximal accretivity of $\lambda - A$ for $\lambda > 0$ large enough, see [11, Prop. 6.1, p170]. (3.60)

Proposition 3.14. The mapping $D_{\mathcal{F}}$ defined above satisfies the following boundedness property:

$$D_{\mathcal{F}} \in \mathcal{L}(\mathbf{V}^{s}(\partial \mathcal{F}), \mathbf{H}^{s+\frac{1}{2}}(\mathcal{F}) \times \mathcal{D}(A_{1}^{s/4+5/8}) \times \mathcal{D}(A_{1}^{s/4+1/8})) \quad s \in \left[-\frac{1}{2}, \frac{1}{2}\right].$$
(3.61)

Proof. To obtain (3.61) it suffices to prove it for s = 1/2 and s = -1/2 and then use an interpolation argument. We first consider the case s = 1/2 and use a lifting argument: according to [1, Cor. 3.8] there exists $z \in \mathbf{H}^1(\mathcal{F})$ such that div z = 0 in \mathcal{F} , $z = \Xi u$ on $\partial \mathcal{F}$ and satisfying $\|z\|_{\mathbf{H}^1(\mathcal{F})} \leq C \|u\|_{\mathbf{V}^{\frac{1}{2}}(\partial \mathcal{F})}$. By definition of λ_0 , there exists a unique $[\tilde{w}, \xi_1, \xi_2] \in \mathcal{V} \subset \mathbf{H}^1(\mathcal{F}) \times D(A_1^{3/4}) \times D(A_1^{1/4})$ solution of (3.62). To prove the case s = -1/2, we recall that in that case $D_{\mathcal{F}}u$ is defined by duality as follows: for any $[f, a_f, b_f] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}}$,

(3.63)

where $[\varphi, \xi, \zeta] \in \mathcal{D}(A^*)$ and $\pi \in H^1(\mathcal{F})$ such that $\int_{\mathcal{F}} \pi dy = 0$ satisfy

$$\begin{cases} \lambda_{0}\varphi - \nu\Delta\varphi + (\nabla v^{S})^{*}\varphi - (v^{S} \cdot \nabla)\varphi + \nabla\pi = f \text{ in } \mathcal{F}, \\ \operatorname{div} \varphi = 0 \text{ in } \mathcal{F} \\ \varphi = T\zeta_{2} \text{ on } \partial\mathcal{F}, \qquad (3.64) \\ \lambda_{0}\zeta_{1} + \zeta_{2} + A_{1}^{-1} \left(\Lambda^{(1,1)}\right)^{*} (\nabla\varphi) + A_{1}^{-1} \left(\Lambda^{(2,1)}\right)^{*} (\varphi) = a_{f}, \\ \lambda_{0}\zeta_{2} - A_{1}\zeta_{1} + A_{2}\zeta_{2} + T^{*} (\mathbb{T}(\varphi, \pi)n) + \left(\Lambda^{(1,2)}\right)^{*} (\nabla\varphi) + \left(\Lambda^{(2,2)}\right)^{*} (\varphi) = b_{f}. \end{cases}$$

Using (3.56), we see that system (3.64) can be written as

Then for any $[f, a_f, b_f] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_{\mathcal{S}}$, there exists a unique $[\varphi, \zeta_1, \zeta_2] \in \mathcal{D}(A^*)$, as well as a corresponding pressure $\pi \in H^1(\mathcal{F})$ such that $\int_{\mathcal{F}} \pi dy = 0$, solution of the above equation. Moreover, we have from standard trace inequalities and Stokes regularity,

$$\left\|\mathbb{T}(\varphi,\pi)n\right\|_{\mathbf{V}^{\frac{1}{2}}(\partial\mathcal{F})} \leqslant C\left\|\left[f,a_{f},b_{f}\right]\right\|_{\mathbf{L}^{2}(\mathcal{F})\times\mathcal{D}(A_{1}^{1/2})\times\mathcal{H}_{\mathcal{S}}}$$

which yields the result for $s = -\frac{1}{2}$.

Next, we define the input operator

Proposition 3.15. The operator B defined by (3.65) satisfies:

Moreover, the adjoint of B is defined by

where $\pi \in H^1(\mathcal{F})$ satisfies $\int_{\mathcal{F}} \pi \, dy = 0$ and

Proof. The regularity property (3.66) is a direct consequence of Proposition 3.2, Proposition 3.13 and of (3.61). The characterization (3.67) follows directly from (3.63).

We are now in position to deduce formulation (3.12)-(3.13) from (3.6)-(3.10) and (3.11). First, since we have $\mathbf{Z} - D_{\mathcal{F}} u \in \mathcal{H}$ we have $(I - \mathbb{P})(\mathbf{Z} - D_{\mathcal{F}} u) = 0$ which implies that \mathbf{Z} satisfies (3.13). Moreover, assume that $\mathbf{Z} = [w, \xi_1, \xi_2]$ is a regular solution of (3.6)-(3.10) and assume that $\mathbf{\Phi} = [\varphi, \zeta_1, \zeta_2] \in \mathcal{D}(A^*)$. We multiply (3.6) with φ , (3.9) by ζ_1 and (3.10) by ζ_2 . Then, after some integrating by parts and using (3.13), we obtain

Since the above equality is satisfied for any $\Phi \in \mathcal{D}(A^*)$ we obtain the first equality of (3.12).

4 Feedback Stabilizability of the linear system

4.1 Stabilizability of the homogeneous linear system

The goal of this subsection is to prove, for a fixed rate of decrease $\sigma > 0$, the existence of a feedback control

$$u(t) = \sum_{j=1}^{N_{\sigma}} \left(\int_{\mathcal{F}} w(t) \cdot \varphi_j dy + \left(A_1^{1/2} \xi_1(t), A_1^{1/2} \zeta_{1,j} \right)_{\mathcal{H}_{\mathcal{S}}} + \left(\xi_2(t), \zeta_{2,j} \right)_{\mathcal{H}_{\mathcal{S}}} \right) v_j \tag{4.1}$$

such that solutions of (3.6)-(3.10) tends to zero as $t \to +\infty$ with an exponential rate of decrease $\sigma > 0$. For that, we are going to show the existence of families $(\varphi_j, \zeta_{1,j}, \zeta_{2,j})$ and $v_j, j = 1, \ldots, N_{\sigma}$ such that the underlying closed-loop linear operator of (3.6)-(3.10) with (4.1) generates and analytic and exponentially stable semigroup of type lower than $-\sigma$ (see [11, II-1, (2.8) and Cor. 2.1]). It then permits to deduce results for nonhomogeneous system (3.1)-(3.4) that are used in the next subsection to construct solutions of the nonlinear system (2.48)-(2.51) with a fixed-point argument.

Proposition 4.1. For $\sigma > 0$, there exist $N_{\sigma} \in \mathbb{N}^*$ and families $[\varphi_j, \zeta_{1,j}, \zeta_{2,j}] \in \mathcal{D}(A^*)$ and $v_j \in \mathbf{V}^2(\partial \mathcal{F})$, $j = 1, \ldots, N_{\sigma}$, and a corresponding feedback operator $F_{\sigma} : \mathcal{H} \to \mathbf{V}^2(\partial \mathcal{F})$ defined by

$$F_{\sigma}[w,\xi_{1},\xi_{2}] = \sum_{j=1}^{N_{\sigma}} \left(\int_{\mathcal{F}} w \cdot \varphi_{j} dy + \left(A_{1}^{1/2}\xi_{1}, A_{1}^{1/2}\zeta_{1,j} \right)_{\mathcal{H}_{\mathcal{S}}} + \left(\xi_{2}, \zeta_{2,j} \right)_{\mathcal{H}_{\mathcal{S}}} \right) v_{j}$$
(4.2)

such that the linear operator $A_{\sigma} \stackrel{\text{def}}{=} A + BF_{\sigma}$ with domain $\mathcal{D}(A_{\sigma}) \stackrel{\text{def}}{=} \{\mathbf{Z} \in \mathcal{H} \mid A\mathbf{Z} + BF_{\sigma}\mathbf{Z} \in \mathcal{H}\}$ is the infinitesimal generator of an analytic and exponentially stable semigroup on \mathcal{H} of type lower than $-\sigma$. Moreover, for $\alpha \in [0,1]$ we have $\mathcal{D}((-A_{\sigma})^{\alpha}) \hookrightarrow [\mathbf{H}^{2\alpha}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2+\alpha/2}) \times \mathcal{D}(A_{1}^{\alpha/2})] \cap \mathcal{H}$ and $\mathcal{D}((-A_{\sigma}^{*})^{\alpha}) = \mathcal{D}((\lambda_{0} - A^{*})^{\alpha})$, and for $\alpha \in [0, 1/4)$ we have $\mathcal{D}((-A_{\sigma}^{*})^{\alpha})') \hookrightarrow \mathbf{H}^{2\alpha}(\mathcal{F})' \times \mathcal{D}(A_{1}^{1/2-\alpha/2}) \times \mathcal{D}(A_{1}^{\alpha/2})'.$

Proof. The proof of the above proposition relies on the Hautus-Fattorini stabilizability criterion, see [5, Theorem 1] or [8]. Since A has compact resolvent and generates an analytic semigroup on \mathcal{H} , and since B is relatively bounded with respect to A, then the homogeneous linear system is stabilizable by finite dimensional feedback control for any rate of decrease if and only if the following criterion is satisfied for all $\lambda \in \mathbb{C}$:

Assume $\Phi = [\varphi, \zeta_1, \zeta_2] \in \mathcal{D}(A^*)$ satisfies the two first relations (4.3). From (3.56) and (3.67), it implies that

$$\lambda \zeta_{1} + \zeta_{2} + A_{1}^{-1} \left(\Lambda^{(1,1)}\right)^{*} (\nabla \varphi) + A_{1}^{-1} \left(\Lambda^{(2,1)}\right)^{*} (\varphi) = 0, \\ \lambda \zeta_{2} - A_{1} \zeta_{1} + A_{2} \zeta_{2} + T^{*} (\mathbb{T}(\varphi, \pi)n) + \left(\Lambda^{(1,2)}\right)^{*} (\nabla \varphi) + \left(\Lambda^{(2,2)}\right)^{*} (\varphi) = 0, \end{cases}$$

and

$$\rho \mathbb{T}(\varphi, \pi) n = \left(\int_{\partial \mathcal{F}} \rho \mathbb{T}(\varphi, \pi) n \cdot n d\gamma \right) \rho n \quad \text{on } \partial \mathcal{F}.$$
(4.5)

In what follows we denote $c(\varphi, \pi) \stackrel{\text{def}}{=} \int_{\partial \mathcal{F}} \rho \mathbb{T}(\varphi, \pi) n \cdot n d\gamma$. Combining (4.5) and the classical uniqueness result of [21] for Stokes type systems (see also [8, Appendix A]) we deduce that $\varphi = 0$ and $\pi - c(\varphi, \pi) = 0$ in \mathcal{F} . It implies in particular that $\mathbb{T}(\varphi, \pi - c(\varphi, \pi))n = 0$ on $\partial \mathcal{F}$ and $T\zeta_2 = 0$ on $\partial \mathcal{F}$. Using (2.55), we deduce that $\zeta_2 = 0$. Moreover, since we have $T^*(n) = 0$, from $\mathbb{T}(\varphi, \pi - c(\varphi, \pi))n = 0$ we deduce $T^*(\mathbb{T}(\varphi, \pi)n) = 0$ on $\partial \mathcal{F}$. Then using the last equation of (4.4) we obtain $A_1\zeta_1 = 0$ and then $\zeta_1 = 0$. We have obtained $\Phi = 0$.

Then the general framework of [5, 8] can be applied and for a given $\sigma > 0$, there exist families

$$[\varphi_j, \zeta_{1,j}, \zeta_{2,j}] \in \mathcal{D}(A^*)$$

and $v_j \in \mathbf{V}^0(\partial \mathcal{F})$, $j = 1, ..., N_{\sigma}$, and a feedback law of the form (4.2) such that the conclusions of the proposition hold. Moreover, each v_j can be chosen in $\mathbf{V}^2(\partial \mathcal{F})$. This comes from the fact that the set of admissible families (v_j) is a nonempty open set of $(\mathbf{V}^0(\partial \mathcal{F}))^{N_{\sigma}}$ (see [5, Theorem 5] or [8, Theorem 6]). Indeed, if a family (\tilde{v}_j) is admissible then all families in a neighborhood of (\tilde{v}_j) in $(\mathbf{V}^0(\partial \mathcal{F}))^{N_{\sigma}}$ are admissible. Then the conclusion follows from the density of $\mathbf{V}^2(\partial \mathcal{F})$ in $\mathbf{V}^0(\partial \mathcal{F})$.

Finally, the statements concerning $\mathcal{D}((-A_{\sigma})^{\alpha})$ and $\mathcal{D}((-A_{\sigma}^{*})^{\alpha})$ are obtained as in [6] and the statement concerning $\mathcal{D}((-A_{\sigma}^{*})^{\alpha})'$ then follows from (3.40).

Remark 4.2. From the definition (4.2) we can extend F_{σ} to an operator from $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2}) \times \mathcal{H}_{S}$ to $\mathbf{V}^{2}(\partial \mathcal{F})$ by using the same formula (4.2). Moreover, since $[\varphi_{j}, \zeta_{1,j}, \zeta_{2,j}] \in \mathcal{H}$, it yields that $F_{\sigma} = F_{\sigma}\mathbb{P}$ and that $F_{\sigma} = 0$ on \mathcal{H}^{\perp} . We can also extend F_{σ} as an operator from $\mathcal{D}(A_{\sigma}^{*})'$ to $\mathbf{V}^{2}(\partial \mathcal{F})$ by setting

(4.10)

with the initial conditions

u

$$\xi_1(0) = \xi_1^0$$
 and $\xi_2(0) = \xi_2^0$, $w(0) = w^0$ in \mathcal{F} . (4.11)

In above settings we have extended the feedback operator F_{σ} to $\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A_{1}^{1/2}) \times \mathcal{H}_{\mathcal{S}}$ (see Remark 4.2) and $F, G, F_{\text{div}}, F_{b}$ are nonhomogenous right-hand terms which play the role of the nonlinearities $F(\mathbf{Z})$, $G(\mathbf{Z}), F_{\text{div}}(\mathbf{Z}), F_{b}(\mathbf{Z})$ in (2.48)-(2.51).

Suppose for the moment that $(F_{\text{div}}, F_b) = (0, 0)$. By taking into account (4.1) in formulation (3.12)-(3.13) complemented with the nonhomogeneous right-hand terms F, G, we deduce that the above system with $F_{\text{div}} = 0$ and $F_b = 0$ can be rewritten as

Assume $[w^0, \xi_1^0, \xi_2^0] \in \mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S, F \in L^2_{\sigma}(\mathbf{H}^1(\mathcal{F})'), G \in L^2_{\sigma}(\mathbf{L}^2(\mathcal{F}))$ and $(F_{\text{div}}, F_b) = (0, 0)$. Then system (4.6)-(4.11) admits a unique solution

$$\begin{split} \|\mathbb{P}[w,\xi_{1},\xi_{2}]\|_{W_{\sigma}(\mathcal{D}((-A_{\sigma})^{1/2}),\mathcal{D}((-A_{\sigma}^{*})^{1/2})')} + \|(I-\mathbb{P})[w,\xi_{1},\xi_{2}]\|_{H^{1}_{\sigma}(\mathbf{H}^{1}(\mathcal{F})\times\mathcal{D}(A_{1}^{3/4})\times\mathcal{D}(A_{1}^{1/4}))} \\ & \leq C\left(\|[F,G]\|_{L^{2}_{\sigma}(\mathbf{H}^{1}(\mathcal{F})'\times\mathbf{L}^{2}(\mathcal{F}))} + \|\mathbb{P}[w^{0},\xi_{1}^{0},\xi_{2}^{0}]\|_{\mathcal{H}}\right). \end{split}$$

Proof. We write system (4.6)-(4.11) as (4.12)-(4.13). By using (4.14) we have

To state regularity properties for L_{div} we need the functional framework introduced in [39]. For $s \in [-1/2, 2]$ we define

In what follows, we need another assumption than the ones introduced in Section 3.1: for some $\varepsilon \in (0, 1/8)$:

From Proposition 4.1, there exists a unique solution $[\varphi, \zeta_1, \zeta_2] \in \mathcal{D}(A^*)$ of

In order to prove the existence and uniqueness of $[w, \xi_1, \xi_2] \in (\mathbf{H}^{2\varepsilon}(\mathcal{F}))' \times \mathcal{D}(A_1^{1/2-\varepsilon/2}) \times \mathcal{D}(A_1^{\varepsilon/2})'$ satisfying (4.35), we proceed as follows: first there exists a unique $[\widehat{w}, \widehat{\xi}_1, \widehat{\xi}_2] \in \mathcal{D}(A_0^{\varepsilon/2})'$ such that for any $[f, \zeta_1^f, \zeta_2^f] \in \mathcal{D}(A_0^{\varepsilon/2})$,

$$(4.36)$$

where $(\varphi, \chi, \zeta_1, \zeta_2)$ is the solution of (4.23) associated with $[f, \zeta_1^f, \zeta_2^f]$. The existence and uniqueness for this problem is a consequence of (4.28).

Second, there exists a unique $[w, \xi_1, \xi_2] \in (\mathbf{H}^{2\varepsilon}(\mathcal{F}))' \times \mathcal{D}(A_1^{1/2-\varepsilon/2}) \times \mathcal{D}(A_1^{\varepsilon/2})'$ such that for any

In order to analyze (4.40), we need the following proposition.

Proof. First, since $A_{\sigma} - \sigma I$ is of negative type and is the infinitesimal generator of an analytic semigroup, for any $\mathbf{F} \in H^1_{\sigma}(\mathcal{D}((-A^*_{\sigma})^{\delta})')$ the solution of (4.43) satisfies

Second, assume $\mathbf{F} \in L^2_{\sigma}(\mathcal{D}((-A^*_{\sigma})^{\delta})')$. There exists a sequence (\mathbf{F}_n) in $C^1_c(\mathcal{H})$ that converges to \mathbf{F} in $L^2_{\sigma}(\mathcal{D}((-A^*_{\sigma})^{\delta})'))$. We remark that the solution \mathbf{W}_n of (4.43) corresponding to \mathbf{F}_n satisfies

Proof. We write system (4.6)-(4.11) as (4.39)-(4.42) with $\mathbf{Z} = [w, \xi_1, \xi_2]$. Since

Gathering (4.50), (4.51) and applying Proposition 4.5 and Proposition 4.3 with the fact that

we deduce that

$$\mathbb{P}\widehat{\mathbf{Z}} \in H^{1/2+\varepsilon}_{\sigma}(\mathcal{D}((-A^*_{\sigma})^{\varepsilon})') \cap L^2_{\sigma}(\mathcal{D}((-A_{\sigma})^{1/2})) \hookrightarrow \mathcal{G}.$$

We underline that the last above embedding is well justified by Proposition 4.1. In particular the embedding $\mathcal{D}((-A_{\sigma}^{*})^{\varepsilon})' \hookrightarrow \mathbf{H}^{2\varepsilon}(\mathcal{F})' \times \mathcal{D}(A_{1}^{1/2-\varepsilon/2}) \times \mathcal{D}(A_{1}^{\varepsilon/2})'$ is true since $\varepsilon < 1/4$.

We deduce from the above relation, from the definition (4.2) of the operator F_{σ} , from Proposition 3.14 and from Proposition 3.2 that

5 Fixed point

5.1 Proof of Theorem 1.2

In order to prove Theorem 1.2, we consider the Banach spaces \mathcal{E} and \mathcal{G} defined by (4.46) and (4.47) and the following mapping defined on a closed ball of \mathcal{E} of radius R > 0,

$$\Psi: B_{\mathcal{E}}(0,R) \to \mathcal{E}, \quad \left[F,G,F_b,F_{\rm div}\right] \mapsto \left[F(\mathbf{Z}),G(\mathbf{Z}),F_b(\mathbf{Z}),F_{\rm div}(\mathbf{Z})\right]$$

where $\mathbf{Z} = [w, \xi_1, \xi_2] \in \mathcal{G}$ is the solution of (4.6)-(4.11) given by Corollary 4.6 and where $F(\mathbf{Z}), G(\mathbf{Z}), F_b(\mathbf{Z}), F_{div}(\mathbf{Z})$ are defined by (2.43), (2.25) and (2.27). We remark that if $[F, G, F_b, F_{div}]$ is a fixed point of the mapping Ψ , then the corresponding solution

We remark that if $[F, G, F_b, F_{div}]$ is a fixed point of the mapping Ψ , then the corresponding solution $[w, \xi_1, \xi_2]$ of (4.6)-(4.11) is a solution of (2.48)-(2.52). Consequently, we are reduced to show that Ψ admits a fixed point. We prove that for R small enough, Ψ is well-defined from $B_{\mathcal{E}}(0, R)$ onto itself and that the restriction of Ψ on this closed ball is a contraction mapping.

First, we notice that (4.49) implies (2.8) provided that $[F, G, F_b, F_{\text{div}}] \in B_{\mathcal{E}}(0, R)$ with R small enough and that $[w^0, \xi_1^0, \xi_2^0]$ has a norm small enough in $\mathbf{L}^2(\mathcal{F}) \times \mathcal{D}(A_1^{1/2}) \times \mathcal{H}_S$. In particular, the changes of variables X and Y are well-defined as well as $F(\mathbf{Z}), G(\mathbf{Z}), F_{\text{div}}(\mathbf{Z})$.

Second, we use several technical results whose proofs are given in the next subsections. To simplify the notation, in what follows, we assume

Proposition 5.1. There exists $C_{\#} > 0$ such that for all R > 0 and $[w^0, \xi_1^0, \xi_2^0]$ satisfying (5.1), and all $[F, G, F_{\text{div}}, F_b] \in B_{\mathcal{E}}(0, R)$,

From the above proposition, we remark that if

(5.2)

and R is small enough so that

$$4C_{\#}R \leqslant 1,\tag{5.3}$$

then Ψ is well-defined from $B_{\mathcal{E}}(0, R)$ into itself.

The second important technical result we need is the following:

Proposition 5.2. There exists $C_{\#} > 0$ such that for all R > 0 and $[w^0, \xi_1^0, \xi_2^0]$ satisfying (5.1), and all $[F^{(1)}, G^{(1)}, F_b^{(1)}, F_{div}^{(1)}]$ and $[F^{(2)}, G^{(2)}, F_b^{(2)}, F_{div}^{(2)}]$ in $B_{\mathcal{E}}(0, R)$,

$$\begin{split} \left\| \Psi\left(\left[F^{(1)}, G^{(1)}, F^{(1)}_{b}, F^{(1)}_{\mathrm{div}} \right] \right) - \Psi\left(\left[F^{(2)}, G^{(2)}, F^{(2)}_{b}, F^{(2)}_{\mathrm{div}} \right] \right) \right\|_{\mathcal{E}} \\ & \leq C_{\#} \left(R + \| [w^{0}, \xi^{0}_{1}, \xi^{0}_{2}] \|_{\mathbf{L}^{2}(\mathcal{F}) \times \mathcal{D}(A^{1/2}_{0}) \times \mathcal{H}_{S}} \right) \left\| \left[F^{(1)}, G^{(1)}, F^{(1)}_{b}, F^{(1)}_{\mathrm{div}} \right] - \left[F^{(2)}, G^{(2)}, F^{(2)}_{b}, F^{(2)}_{\mathrm{div}} \right] \right\|_{\mathcal{E}}. \end{split}$$

With the same conditions (5.2) and (5.3), we deduce that the restriction of Ψ on $B_{\mathcal{E}}(0, R)$ is a contraction mapping. The classical Banach fixed point theorem allows us to deduce the existence of a solution.

5.2 Proof of Proposition 5.1

(5.9)

$$\xi_{1} \in H_{\sigma}^{1/2}(L^{2}(0,1)) \cap C_{b,\sigma}(L^{2}(0,1)) \cap L_{\sigma}^{2}(H_{0}^{1}(0,1)),$$

$$(5.10)$$

and since $\xi_2 = \partial_t \xi_1$

$$\xi_1 \in H^{3/2}_{\sigma}(L^2(0,1)) \cap C^1_{b,\sigma}(L^2(0,1)) \cap H^1_{\sigma}(H^1_0(0,1)).$$
(5.11)

Using interpolation arguments and Sobolev embeddings we deduce the following embeddings,

 $H^{1/2+\varepsilon}_{\sigma}(H^{1-2\varepsilon}(0,1)) \hookrightarrow C_{b,\sigma}(L^{\infty}(0,1)),$

$$\begin{aligned} \|\xi_1\|_{H^{1/2+\varepsilon}_{\sigma}(H^{2-2\varepsilon}_{0}(0,1))} + \|\xi_2\|_{H^{1/2+\varepsilon}_{\sigma}(H^{-2\varepsilon}(0,1))} + \|\xi_1\|_{C_{b,\sigma}(L^{\infty}(0,1))} + \|\partial_s\xi_1\|_{C_{b,\sigma}(L^{\infty}(0,1))} \\ &+ \|\partial_{ss}\xi_1\|_{L^4_{\sigma}(L^4(0,1))} + \|\xi_2\|_{L^4_{\sigma}(L^4(0,1))} + \|\partial_{ss}\xi_1\|_{L^8_{\sigma}(L^4(0,1))} + \|\xi_2\|_{L^8_{\sigma}(L^4(0,1))} \\ &+ \|w\|_{L^4_{\sigma}(\mathbf{L}^4(\mathcal{F}))} \leqslant C \left(R + \|[w^0,\xi_1^0,\xi_2^0]\|_{\mathbf{L}^2(\mathcal{F})\times H^2(0,1)\times L^2(0,1)}\right). \end{aligned}$$

Note that ξ_1 and ξ_2 can be considered as functions defined on \mathcal{F} but only depending on y_1 and equal to zero outside (0, 1), and, in particular by using the fact that $\partial_s \xi_1 = \xi_1 = 0$ on $\{0, 1\}$, the above spacial norms in (0, 1) can be replaced by spacial norms in \mathcal{F} . Moreover, by combining (4.8), (5.7), (4.2) and $T \in \mathcal{L}(H^{-2\varepsilon}(0, 1), \mathbf{H}^{-1/2-2\varepsilon}(\partial \mathcal{F}))$, (obtained from (2.57) with duality argument) we deduce

Combining, (2.33), (2.43) with (5.18) and (5.19) we deduce the result for $G(\mathbf{Z})$. Then, we estimate $F(\mathbf{Z})$. First, using (5.14) and (5.15), we deduce that

Next, using Lemma C.2, we have for any function $\tau \in W^{1,\infty}(\mathbb{R}^3)$,

Next, assume $(g,h) \in \mathbf{H}_{\partial\mathcal{F},\mathcal{F}}^{1/2+2\varepsilon,1+2\varepsilon}$. For a.e. in $(0,\infty)$, we have

$$= \int_{\partial \mathcal{F}} r^{(2)} \cdot (g + hn) \, d\gamma - \int_{\mathcal{F}} r^{(2)} \cdot \nabla h \, dy.$$
(5.23)

On the other hand, since we have (5.17), we can apply Lemma C.5 to obtain,

A Calculation for the change of variables

$$\|[w,\xi_1,\xi_2]\|_{\mathcal{G}} + \|w\|_{H^{1/2+\varepsilon}_{\sigma}(\mathbf{H}^{-1/2-2\varepsilon}(\partial\mathcal{F}))} \leqslant R_0, \tag{C.1}$$

for $R_0 \in (0, 1]$. This implies (5.6)-(5.15) with the corresponding bound in term of R_0 . From (5.12) and from

$$\begin{split} \xi_1 &\in H^{3/2}_{\sigma}(L^2(0,1)) \cap H^{1/2}_{\sigma}(H^2_0(0,1)) \hookrightarrow H^{5/8}_{\sigma}(H^{7/4}_0(0,1)), \\ \xi_1 &\in H^1_{\sigma}(H^1_0(0,1)) \cap L^2_{\sigma}(H^3(0,1) \cap H^2_0(0,1)) \hookrightarrow H^{3/8}_{\sigma}(H^{9/4}_0(0,1)) \hookrightarrow L^8_{\sigma}(H^{9/4}_0(0,1)), \\ \xi_2 &\in H^{1/2}_{\sigma}(L^2(0,1)) \cap L^2_{\sigma}(H^1_0(0,1)) \hookrightarrow H^{1/8}_{\sigma}(H^{3/4}_0(0,1)) \hookrightarrow L^{8/3}_{\sigma}(H^{3/4}_0(0,1)), \\ \xi_2 &\in H^{1/2}_{\sigma}(L^2(0,1)) \cap L^2_{\sigma}(H^1_0(0,1)) \hookrightarrow H^{3/8}_{\sigma}(H^{1/4}(0,1)) \hookrightarrow L^8_{\sigma}(H^{1/4}(0,1)), \\ w &\in H^{1/2}_{\sigma}(\mathbf{L}^2(\mathcal{F})) \cap L^2_{\sigma}(\mathbf{H}^1(\mathcal{F})) \hookrightarrow H^{1/8}_{\sigma}(\mathbf{H}^{3/4}(\mathcal{F})) \hookrightarrow L^8_{\sigma}(\mathbf{H}^{3/4}(\mathcal{F})), \\ w &\in H^{1/2}_{\sigma}(\mathbf{L}^2(\mathcal{F})) \cap L^2_{\sigma}(\mathbf{H}^1(\mathcal{F})) \hookrightarrow H^{3/8}_{\sigma}(\mathbf{H}^{1/4}(\mathcal{F})) \hookrightarrow L^8_{\sigma}(\mathbf{H}^{1/4}(\mathcal{F})), \end{split}$$

we obtain the following estimate:

$$\begin{aligned} \|\xi_1\|_{H^{5/8}_{\sigma}(H^{7/4}(0,1))} + \|\xi_1\|_{L^8_{\sigma}(H^{9/4}(0,1))} + \|\xi_2\|_{L^{8/3}_{\sigma}(H^{3/4}(0,1))} + \|\xi_2\|_{L^8_{\sigma}(H^{1/4}(0,1))} \\ + \|w\|_{L^{8/3}_{\sigma}(\mathbf{H}^{3/4}(\mathcal{F}))} + \|w\|_{L^8_{\sigma}(\mathbf{H}^{1/4}(\mathcal{F}))} + \|\xi_1\|_{L^\infty_{\sigma}(L^\infty(0,1))} + \|\partial_s\xi_1\|_{L^\infty_{\sigma}(L^\infty(0,1))} \leqslant CR_0. \end{aligned}$$

In what follows, we suppose $R_0 > 0$ small enough so that

Let $\mathcal{T} = [-L, L] \times [-L, L]$ be a rectangle such that $\overline{\mathcal{F}} \subset \mathcal{T}$. There exists an extension operator E which is continuous from $L^2(\mathcal{F})$ into $L^2(\mathcal{T})$ as well as from $H^1(\mathcal{F})$ into $H^1_0(\mathcal{T})$. Note that an interpolation argument guarantees that we also have $E \in \mathcal{L}(H^s(\mathcal{F}), H^s_0(\mathcal{T}))$ for $s \in (0, 1)$. Then using this extension operator, any function in $H^s(\mathcal{F})$, $s \in [0, 1]$ can be considered as a function in $H^s_0(\mathcal{T})$: in what follows we will extend w_i , i = 1, 2 or some test functions φ , but for simplicity we will keep the same name w_i and φ instead of $E(w_i)$ and $E(\varphi)$. We will also freely use the boundedness properties of E without recalling it.

Moreover, any function defined on (0,1) is considered as a function defined on \mathcal{T} but only depending on y_1 and equal to zero outside (0,1): by this way we can consider ξ_1 and ξ_2 as functions defined on \mathcal{T} .

For $p \in [1, +\infty)$, $s \ge -1$ and a function $f : \mathcal{T} \to \mathbb{R}$ we write

$$\|f\|_{L^p_{y_2}(H^s_{y_1})} \stackrel{\text{def}}{=} \left(\int_{-L}^{L} \|f(\cdot, y_2)\|_{H^s(-L,L)}^p dy_2 \right)^{1/p}$$

and

We also define the $\|\cdot\|_{L^p_{y_1}(H^s_{y_2})}$ analogously, just by reversing the role of y_1, y_2 .

Let us stress some basic properties that we use below. First for $s \ge 0$ and $f \in H^s(\mathcal{T})$ we have

Above and in what follows, $\mathbf{1}_{\mathcal{F}}$ denotes the characteristic functions of \mathcal{F} . Moreover, for $p \in [1, +\infty]$, $s \in [0, 2] \setminus \{\frac{1}{2}, \frac{3}{2}\}$ and $g \in H_0^s(0, 1)$,

$$\|g\|_{L^{p}_{y_{2}}(H^{s}_{y_{1}})} \leq C \|g\|_{H^{s}_{0}(0,1)}.$$
(C.6)

We also have the following result.

Lemma C.1. Assume $p \in [1, +\infty]$, $s \in [0, 1/2)$ and $g \in H^s(0, 1)$. Then we have,

Thus, by observing that $\rho_{s,A}(y_1) = A^{-2s}\rho_{s,1}(y_1/A)$ and by using Hardy's inequality we obtain

for a constant $C_* > 0$ which is independent on A. Thus, with an interpolation argument (see [43, Thm. 1.18.5, p. 130]) we deduce that

$$\int_0^A |f(y_1)|^2 (\rho_{1,A}(y_1))^s dy_1 \leqslant C_*^s ||f||^2_{H^s_0(I)},$$

Here, $\mathbf{1}_{I_j}$ denote the characteristic functions of I_j . Above we have use the fact that g is zero outside (0, 1).

In Lemmas C.2 to C.4 below τ is a bounded Lipschitz continuous function of $\mathbb{R}^2 \times [-c_0, c_0] \times \mathbb{R}$ with values in \mathbb{R} for $c_0 > 0$ given in (2.8). From (C.3) we deduce

we deduce

$$\left| \int_{\mathcal{F}} \tau(y,\xi_1,\partial_s\xi_1)(\partial_{ss}\xi_1)\partial_{y_1}w_i\varphi dy \right| \leq C \|\mathbf{1}_{\mathcal{F}}\tau(y,\xi_1,\partial_s\xi_1)(\partial_{ss}\xi_1)\|_{L^{\infty}_{y_2}(H^{1/4}_{y_1})} \|\varphi\|_{L^{2}_{y_2}(H^{1}_{y_1})} \|w_i\|_{L^{2}_{y_2}(H^{3/4}_{y_1})}$$

Now using (C.4) and Lemma C.1, we obtain

$$\begin{aligned} \left| \int_{\mathcal{F}} \tau(y,\xi_{1},\partial_{s}\xi_{1})(\partial_{ss}\xi_{1})\partial_{y_{1}}w_{i}\varphi dy \right| &\leq C \|\tau(y,\xi_{1},\partial_{s}\xi_{1})\|_{L^{\infty}_{y_{2}}(H^{1}_{y_{1}})} \|(\mathbf{1}_{\mathcal{F}}\partial_{ss}\xi_{1})\|_{L^{\infty}_{y_{2}}(H^{1/4}_{y_{1}})} \|\varphi\|_{H^{1}(\mathcal{T})} \|w_{i}\|_{H^{3/4}(\mathcal{T})} \\ &\leq C \|\tau(y,\xi_{1},\partial_{s}\xi_{1})\|_{L^{\infty}_{y_{2}}(H^{1}_{y_{1}})} \|\partial_{ss}\xi_{1}\|_{H^{1/4}(0,1)} \|\varphi\|_{H^{1}(\mathcal{T})} \|w_{i}\|_{H^{3/4}(\mathcal{T})} \end{aligned}$$

and thus with (C.9),

Lemma C.5. Let $n_1, n_2 \in \mathbb{N}$ such that $n_1 + n_2 \ge 1$ and assume (C.12)-(C.13). Then

$$\|\tau(y,\xi_1)\xi_1^{n_1}(\partial_s\xi_1)^{n_2}w_i\|_{H^{1/2+\varepsilon}_{\sigma}(H^{2\varepsilon}(\mathcal{F})')} + \|\tau(y,\xi_1)\xi_1^{n_1}(\partial_s\xi_1)^{n_2}w_i\|_{H^{1/2+\varepsilon}_{\sigma}(H^{-1/2-2\varepsilon}(\partial\mathcal{F}))} \leqslant CR_0^2.$$
(C.14)

Proof. We start by estimating the first term in the left-hand side of (C.14). First we have the following relations

$$\begin{aligned} H^{2\varepsilon}(\mathcal{T}) &= [H^1(\mathcal{T}), L^2(\mathcal{T})]_{1-2\varepsilon} = [H^1_{y_1}(L^2_{y_2}(-L,L)) \cap L^2_{y_1}(H^1_{y_2}(-L,L)), L^2_{y_1}(L^2_{y_2}(-L,L))]_{1-2\varepsilon} \\ &= H^{2\varepsilon}_{y_1}(L^2_{y_2}(-L,L)) \cap L^2_{y_1}(H^{2\varepsilon}_{y_2}(-L,L)). \end{aligned}$$

Each of the above equalities follows from classical arguments (see for instance[25]). The last relation can be written

$$H^{2\varepsilon}(\mathcal{T}) = L^{2}_{y_{1}}(H^{2\varepsilon}_{y_{2}}(-L,L)) \cap L^{2}_{y_{2}}(H^{2\varepsilon}_{y_{1}}(-L,L)).$$

Assume now that $\varphi \in H^{2\varepsilon}(\mathcal{F})$. Using (C.12) and the above relation, we have for a.e. $t \in (0, \infty)$,

$$\begin{aligned} \left| \int_{\mathcal{F}} \tau(y,\xi_{1})\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}w_{i}\varphi dy \right| &= \left| \langle w_{i},\tau(y,\xi_{1})\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\varphi \rangle_{H^{2\varepsilon}(\mathcal{F})',H^{2\varepsilon}(\mathcal{F})} \right| \\ &\leq C \left\| w_{i} \right\|_{H^{2\varepsilon}(\mathcal{F})'} \left\| \tau(y,\xi_{1})\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\varphi \right\|_{H^{2\varepsilon}(\mathcal{F})} \\ &\leq C \left\| w_{i} \right\|_{H^{2\varepsilon}(\mathcal{F})'} \left\| \xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\mathbf{1}_{\mathcal{F}}\varphi \right\|_{H^{2\varepsilon}(\mathcal{T})} \\ &\leq C \left\| w_{i} \right\|_{H^{2\varepsilon}(\mathcal{F})'} \left(\left\| \xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\mathbf{1}_{\mathcal{F}}\varphi \right\|_{L^{2}_{y_{2}}(H^{2\varepsilon}_{y_{1}})} + \left\| \xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\mathbf{1}_{\mathcal{F}}\varphi \right\|_{L^{2}_{y_{1}}(H^{2\varepsilon}_{y_{2}})} \right). \end{aligned}$$
(C.15)

Moreover, using (C.4), (C.6), (C.5) we deduce,

$$\begin{aligned} \|\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\mathbf{1}_{\mathcal{F}}\varphi\|_{L^{2}_{y_{2}}(H^{2\varepsilon}_{y_{1}})} &\leq C \|\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\|_{L^{\infty}_{y_{2}}(H^{1/2+2\varepsilon}_{y_{1}})} \|\mathbf{1}_{\mathcal{F}}\varphi\|_{L^{2}_{y_{2}}(H^{2\varepsilon}_{y_{1}})} \\ &\leq C \|\xi_{1}\|_{L^{\infty}_{y_{2}}(H^{1/2+2\varepsilon}_{y_{1}})}^{n_{1}} \|\partial_{s}\xi_{1}\|_{L^{\infty}_{y_{2}}(H^{1/2+2\varepsilon}_{y_{1}})}^{n_{2}} \|\mathbf{1}_{\mathcal{F}}\varphi\|_{H^{2\varepsilon}(\mathcal{T})} \\ &\leq C \|\xi_{1}\|_{H^{1/2+2\varepsilon}_{0}(0,1)}^{n_{1}} \|\partial_{s}\xi_{1}\|_{H^{1/2+2\varepsilon}_{0}(0,1)}^{n_{2}} \|\varphi\|_{H^{2\varepsilon}(\mathcal{T})} \end{aligned}$$

and using (C.4) and (C.5) with the fact that ξ_1 is independent on y_2 we deduce,

$$\begin{aligned} \|\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\mathbf{1}_{\mathcal{F}}\varphi\|_{L^{2}_{y_{1}}(H^{2\varepsilon}_{y_{2}})} &\leq C \|\xi_{1}^{n_{1}}(\partial_{s}\xi_{1})^{n_{2}}\|_{L^{\infty}_{y_{1}}(H^{1/2+2\varepsilon}_{y_{2}})} \|\mathbf{1}_{\mathcal{F}}\varphi\|_{L^{2}_{y_{1}}(H^{2\varepsilon}_{y_{2}})} \\ &\leq C \|\xi_{1}\|_{L^{\infty}(0,1)}^{n_{1}} \|\partial_{s}\xi_{1}\|_{L^{\infty}(0,1)}^{n_{2}} \|\varphi\|_{H^{2\varepsilon}(\mathcal{T})}. \end{aligned}$$

Finally, since $\varepsilon \in (0, 1/8)$ we have $H_0^{1-2\varepsilon}(0, 1) \hookrightarrow H_0^{1/2+2\varepsilon}(0, 1)) \hookrightarrow L^{\infty}(0, 1)$ and combining the above inequalities with (C.15) the result follows from (C.1), (C.2). For the second relation, assume $\varphi \in H^{1/2+2\varepsilon}(\partial \mathcal{F})$. For a.e. $t \in (0, \infty)$ we have,

$$\left| \int_{\partial \mathcal{F}} \tau(y,\xi_1) \xi_1^{n_1} (\partial_s \xi_1)^{n_2} w_i \varphi d\gamma \right| = \left| \langle w_i, \tau(y,\xi_1) \xi_1^{n_1} (\partial_s \xi_1)^{n_2} \varphi \rangle_{H^{-1/2-2\varepsilon}(\partial \mathcal{F}), H^{1/2+2\varepsilon}(\partial \mathcal{F})} \right| \\ \leqslant C \|w_i\|_{H^{-1/2-2\varepsilon}(\partial \mathcal{F})} \|\tau(y,\xi_1) \xi_1^{n_1} (\partial_s \xi_1)^{n_2} \|_{H^{1/2+2\varepsilon}(\partial \mathcal{F})} \|\varphi\|_{H^{1/2+2\varepsilon}(\partial \mathcal{F})}.$$
(C.16)

Thus, taking (C.13) into account we deduce that

$$\begin{aligned} \|\tau(y,\xi_1)\xi_1^{n_1}(\partial_s\xi_1)^{n_2}\|_{H^{1/2+2\varepsilon}(\partial\mathcal{F})} &= \|\tau(y,\xi_1)\xi_1^{n_1}(\partial_s\xi_1)^{n_2}\|_{H^{1/2+2\varepsilon}(\Gamma_{\mathrm{str}})} \\ &\leqslant C \|\tau(y,\xi_1)\|_{W^{1,\infty}(\Gamma_{\mathrm{str}})} \|\xi_1\|_{H^{1/2+2\varepsilon}(\Gamma_{\mathrm{str}})}^{n_1} \|\partial_s\xi_1\|_{H^{1/2+2\varepsilon}(\Gamma_{\mathrm{str}})}^{n_2}. \end{aligned}$$
(C.17)

Moreover, we remark that for a function g defined on \mathcal{T} and only depending on y_1 we have

$$\begin{split} \|g\|_{H^{1/2+2\varepsilon}(\Gamma_{\rm str})}^{2} &= \int_{\Gamma_{\rm str}} |g(y)| d\gamma(y) + \int_{\Gamma_{\rm str}} \int_{\Gamma_{\rm str}} \frac{|g(y) - g(\tilde{y})|^{2}}{|y - \tilde{y}|^{2+4\varepsilon}} d\gamma(y) d\gamma(\tilde{y}) \\ &\leq \int_{\Gamma_{\rm str}} |g(y_{1})| d\gamma(y) + \int_{\Gamma_{\rm str}} \int_{\Gamma_{\rm str}} \frac{|g(y_{1}) - g(\tilde{y}_{1})|^{2}}{|y_{1} - \tilde{y}_{1}|^{2+4\varepsilon}} d\gamma(y) d\gamma(\tilde{y}) \\ &\leq \int_{0}^{1} |g(s)| \ell(s) ds + \int_{0}^{1} \int_{0}^{1} \frac{|g(s) - g(\tau)|^{2}}{|s - \tau|^{2+4\varepsilon}} \ell(s) \ell(\tau) ds d\tau \leq \|\ell\|_{L^{\infty}(0,1)}^{2} \|g\|_{H^{1/2+2\varepsilon}(0,1)}^{2}, \end{split}$$

where we have used the notation $\ell(s) = \sqrt{1 + (\partial_s \eta^S(s))^2}$. Then combining (C.16) and (C.17) with the above estimate for $g = \xi_1$ and $g = \partial_s \xi_1$, with (C.12) we obtain for a.e. $t \in (0, +\infty)$,

 $\|\tau(y,\xi_1)\xi_1^{n_1}(\partial_s\xi_1)^{n_2}w_i\|_{H^{-1/2-2\varepsilon}(\partial\mathcal{F})} \leqslant C \|\xi_1\|_{H^{1/2+2\varepsilon}(0,1)}^{n_1} \|\partial_s\xi_1\|_{H^{1/2+2\varepsilon}(0,1)}^{n_2} \|w_i\|_{H^{-1/2-2\varepsilon}(\partial\mathcal{F})}.$

Finally, since $\varepsilon \in (0, 1/8)$ we have $H^{1-2\varepsilon}(0, 1) \hookrightarrow H^{1/2+2\varepsilon}(0, 1)$ and the conclusion follows from (C.1).
