# Critical behaviour of reduced $\mathrm{QED}_{4,3}$ and dynamical fermion gap generation in graphene

#### Abstract

The dynamical generation of a fermion gap in graphene is studied at the infra-red Lorentz-invariant fixed point where the system is described by an effective relativistic-like field theory: reduced $\mathrm{QED}_{4,3}$ with $N$ four component fermions ( $N=2$ for graphene), where photons are ( $3+1$ )-dimensional and mediate a fully retarded interaction among $(2+1)$-dimensional fermions. A correspondence between reduced $\mathrm{QED}_{4,3}$ and $\mathrm{QED}_{3}$ allows us to derive an exact gap equation for $\mathrm{QED}_{4,3}$ up to next-to-leading order. Our results show that a dynamical gap is generated for $\alpha>\alpha_{c}$ where $1.03<\alpha_{c}<1.08$ in the case $N=2$ or for $N<N_{c}$ where $N_{c}$ is such that $\alpha_{c} \rightarrow \infty$ and takes the values $3.24<N_{c}<3.36$. The striking feature of these results is that they are in good agreement with values found in models with instantaneous Coulomb interaction. At the fixed point: $\alpha=1 / 137 \ll \alpha_{c}$, and the system is therefore in the semi-metallic regime in accordance with experiments.


## I. INTRODUCTION

Effects of electron-electron interactions in graphene, a one-atom thick layer of graphite, have been the subject of extensive experimental and theoretical works for the last decade, see [1] for a review. In contrast to Galilean invariant band metals and semi-conductors, intrinsic (undoped) graphene is characterized by a massless Dirac-like quasiparticle spectrum at low-energies [2]. Because of the vanishing density of states at the two stable Fermi (or Dirac) points, the Coulomb interaction is poorly screened and remains long-ranged. Moreover, the (bare) Fermi velocity is much smaller than the velocity of light: $v=c / 300$, and, consequently, the (bare) fine structure constant of graphene is of order 1 in general: $\alpha=$ $\alpha_{\mathrm{QED}} c /(\kappa v) \approx 2.2 / \kappa$ where $\alpha_{\mathrm{QED}}=e^{2} /(4 \pi \hbar c)=1 / 137$. Suspended graphene, for which the dielectric constant $\kappa \approx 1$, is therefore often thought of as the condensed matter realization of strongly coupled quantum electrodynamics (QED) albeit non-relativistic. Nevertheless, an early renormalization group approach revealed the existence of an infrared Lorentz invariant fixed point for graphene [3]. Approaching this fixed point, the Fermi velocity flows to the velocity of light, $v \rightarrow c$, while the fine structure constant of graphene flows to the usual QED one: $\alpha \rightarrow \alpha_{\text {QED }}$. Experimentally, the flow of the velocity seems to be cut at values of the order of $3 v$ in clean suspended graphene [4] which might be interpreted as a slight effective reduction of the coupling constant to 0.73 which is still close to unity.

A commonly raised theoretical issue is then to know whether or not the strong and long-ranged Coulomb interaction may drive the semi-metallic system into an insulating phase thereby dynamically generating a gap in the single particle fermionic spectrum, see, e.g., [5-18]. This excitonic instability should take place for values of the coupling constant larger than a critical one, $\alpha_{c}$, i.e., a gap is dynamically generated for $\alpha>\alpha_{c}$ for the physical number of fermion flavours (spin): $N=2$. Alter-
natively, the instability would also manifest at $N<N_{c}$ where $N_{c}$ is a critical fermion flavour number for which $\alpha_{c} \rightarrow \infty$. A quantitative analysis of such an instability is important given the fact that the possibility to generate in a controlled way a fermion gap in graphene and graphene-like materials is crucial for, e.g., the development of graphene-based transistors 19]. Moreover, such an instability is the condensed matter physics analogue of the much studied dynamical mass generation and associated dynamical chiral symmetry breaking ( $\mathrm{D} \chi \mathrm{SB}$ ) in usual relativistic QEDs and in particular in $(2+1)$ dimensional QED or $\mathrm{QED}_{3}$ see, e.g., 20 28]. Of theoretical importance, is to clarify the precise relation between $\mathrm{QED}_{3}$ and effective field theories describing graphene.

A puzzling fact is that, despite the strength of the interaction, there is no experimental evidence for the existence of a gap of more than 0.1 meV in clean suspended graphene [4]. This may be the indication that $\alpha$ is not large enough in actual samples and/or that the latter may be subject to additional sources of screening, e.g., from electrons in $\sigma$ bands [29]. Neglecting the latter and focusing on clean graphene at zero temperature, there have been many attempts to compute $\alpha_{c}$ on the basis of an elementary model of massless Dirac fermions interacting via the instantaneous Coulomb interaction, i.e., the limit $v / c \rightarrow 0$ which is indeed quite realistic. Various methods were used such as, e.g., analytical or numerical solutions of leading order (LO) Schwinger-Dyson (SD) equations 5-7, 9-11, 14, 16, 17], renormalization group studies [8, 13], lattice simulations [12, 15] and a combination of Bethe-Salpeter and functional renormalization group approaches 18]. All computations agree on the fact that $\alpha_{c} \sim \mathrm{O}(1)$ but there is still no general agreement on the precise value of $\alpha_{c}$ even though recent results [14, 16-18] seem to indicate that it is indeed larger than the bare value of $\alpha$ in agreement with the experimentally observed semi-metallic behaviour.

In the present paper, we revisit the problem of dynamical gap generation in graphene from a completely differ-
ent angle. We shall focus on the deep infra-red Lorentz invariant fixed point of [3] where graphene may be effectively described by a massless relativistic quantum field theory model whereby $d_{e}=2+1$-dimensional electrons interact via a $d_{\gamma}=3+1$-dimensional long-range fully retarded potential, i.e., the limit $v \rightarrow c$. As described in Sec. III such a model belongs to the class of reduced QED 30], see also [31], or $\mathrm{RQED}_{d_{\gamma}, d_{e}}$, and corresponds to $\mathrm{RQED}_{4,3}$ in the case of graphene 32, 33]. Our results will provide an exact analytical solution for the SD equations of $\mathrm{RQED}_{4,3}$ up to next-to-leading order (NLO) including a full resummation of the wave function renormalization constant and a proof of the weak gauge-variance of $\alpha_{c}$ and $N_{c}$. They are based on an important correspondence between $\mathrm{RQED}_{4,3}$ and large- $N$ $\mathrm{QED}_{3}$ which is described in Sec . III The latter will allow us, in Secs. IV and V, to transcribe the recent exact NLO gap equation found for $\mathrm{QED}_{3}$ [28] to the case of $\mathrm{RQED}_{4,3}$. Solving the gap equation will yield high precision estimates of $\alpha_{c}$ and $N_{c}$. Comparison with other results that can be found in the literature will be given in Sec.VI and the conclusion in Sec.VII In the following, we work in units in which $\hbar=c=1$.

## II. THE MODEL

The effective low-energy action describing graphene at the Lorentz invariant fixed point is that of massless RQED $_{4,3}$ which is given by:
$S=\sum_{\sigma=1}^{N} \int \mathrm{~d}^{3} x \bar{\Psi}_{\sigma} i \gamma^{\mu} D_{\mu} \Psi_{\sigma}-\int \mathrm{d}^{4} x\left(\frac{F_{\mu \nu}^{2}}{4}+\frac{\left(\partial_{\mu} A^{\mu}\right)^{2}}{2 \bar{\xi}}\right)$,
where $\Psi$ is a four-component spinor with $N$ flavours ( $N=2$ for graphene), $\gamma^{\mu}$ is the Dirac matrix satisfying the usual algebra: $\left\{\gamma^{\mu}, \gamma^{\nu}\right\}=2 g^{\mu \nu}$ where $g^{\mu \nu}=$ $\operatorname{diag}(1,-1,-1)$ is the metric tensor, $D_{\mu}=\partial_{\mu}+i e A_{\mu}$ is the covariant derivative and $\bar{\xi}=1-\bar{\eta}$ is the gauge fixing parameter associated with the $(3+1)$-dimensional gauge field. Similarly to $\mathrm{QED}_{3}$, this actions has a $U(2 N)$ flavour symmetry. Dynamical mass generation leads to a spontaneous breakdown of this symmetry to $U(N) \times U(N)$. Notice, however, that while $\mathrm{QED}_{3}$ is super-renormalizable and has an intrinsic mass scale fixed by the dimensionful coupling constant $a=N e^{2} / 8$ [20], $\mathrm{RQED}_{4,3}$ is renormalizable and has a dimensionless coupling $\alpha=e^{2} /(4 \pi)$ 30, 32, 33]. As noticed in 30], $\mathrm{D} \chi \mathrm{SB}$ in $\mathrm{RQED}_{4,3}$ corresponds to the so-called conformal phase transition (CPT) whereas it is only a pseudo-CPT in $\mathrm{QED}_{3}$ [34]. Nevertheless, in both cases, the dynamical mass satisfies the Miransky scaling albeit with different coefficients in front of the exponential, see [30]. In the following, we shall not be interested by the full scaling but rather focus on the critical behaviour of $\mathrm{RQED}_{4,3}$, i.e., consider the transition point $\alpha=\alpha_{c}$ or $N=N_{c}$ where the dynamical mass first appears.

In order to study the dynamical generation of such a mass we need to solve the SD equations for the fermion propagator. As we have mentionned above, the NLO solution of such equations has recently been done in the case of $\mathrm{QED}_{3}$ in the $1 / N$-expansion [28]. Technically, the calculations were performed with the help of the standard rules of perturbation theory for massless Feynman diagrams as in [35] and with the help of the Gegenbauer polynomial technique as used in [36], see also the recent short review 37]. Similar calculations can be carried out for $\mathrm{RQED}_{4}, 3$ on the basis of the multi-loop results obtained in 32, 33]. An alternative way to derive the same results is based on a simple correspondence between $\mathrm{RQED}_{4,3}$ and large- $N \mathrm{QED}_{3}$. As we shall demonstrate in the following, the latter will allow us to straightfowardly study the critical properties of $\mathrm{RQED}_{4,3}$ without any further complicated calculation.

## III. CORRESPONDENCE BETWEEN REDUCED QED $_{4,3}$ AND QED $_{3}$

We first consider the photon propagator of $\mathrm{RQED}_{4,3}$ [32, 33] (in Euclidean space):

From Eq. (11) we see that we may define an effective gauge fixing parameter, $\eta=1-\xi$, for the reduced gauge field which is related to the gauge fixing parameter, $\bar{\eta}=1-\bar{\xi}$, of the corresponding 4-dimensional gauge field as follows:

Next, we consider the photon propagator of $\mathrm{QED}_{3}$ in a nonlocal $\xi$-gauge [22]:

where $\Pi(p)$ is the polarization operator. At the LO of the $1 / N$-expansion, the polarization operator reads:

In the large- $N$ limit, the infrared behaviour of $D_{\text {QED3 }}^{\mu \nu}(p)$ changes 23, 24], see also 38, 39], because:

D_{\mathrm{QED} 3}^{\mu \nu}(p)=\frac{8}{e^{2} N|p|} d^{\mu \nu}(\eta) \tag{5}
\end{equation*}
$$

As already noticed in [32, 33] the photon propagators of $\mathrm{QED}_{3}$ in the large- $N$ limit, Eq. (5), and the one of RQED $_{4,3}$, Eq. (1) have the same form. One may easily pass from one form to the other with the help of the following transformation:

\end{equation*}
$$

where $L=\pi^{2} N$ [24, 28]. The transformation (6) will allow us to transcribe the recent solution of dynamic mass generation in $\mathrm{QED}_{3}$ using the $1 / N$-expansion [24, 27, 28] to the case of $\mathrm{RQED}_{4,3}$ using the loop expansion. In the following, LO will either refer to LO in the $1 / N$-expansion for $\mathrm{QED}_{3}$ or to the one-loop order for RQED $_{4,3}$. Similarly, NLO will either refer to NLO in the $1 / N$-expansion for $\mathrm{QED}_{3}$ or to the two-loop order for RQED $_{4,3}$. Of course, the solution of SD equations, combined with the various resummations we shall perform in the following, is non-perturbative in nature and beyond the reach of a simple $1 / N$ or loop expansion.

## IV. LEADING ORDER

In order to illustrate how the correspondence works, we first compute the critical coupling at LO. Combining the $\mathrm{LO} \mathrm{QED}_{3}$ result [28] with the transformation (6), the LO gap equation for the critical coupling of $\mathrm{RQED}_{4,3}$ reads:

1=\frac{16(2+\xi)}{L_{c}} \quad \rightarrow \quad 1=16(2+\xi) g_{c}=8(5+\bar{\xi}) g_{c} \tag{7}
\end{equation*}
$$

where $g_{c}=\alpha_{c} /(4 \pi)$. This yields:

\alpha_{c}(\bar{\xi})=\frac{\pi}{2(5+\bar{\xi})} \tag{8}
\end{equation*}
$$

The LO critical coupling is seen to be strongly gauge dependent but does not depend on the fermion flavour number, $N$. Its value in various gauges, including Landau $(\bar{\xi}=0, \xi=-1)$ and Feynman $(\bar{\xi}=\xi=1)$ gauges, reads:

\alpha_{c}(\bar{\xi}=0)=0.3142, & \alpha_{c}(\bar{\xi}=1)=0.2618 \\
\alpha_{c}(\bar{\xi}=-1)=0.3927, & \alpha_{c}(\bar{\xi}=1 / 3)=0.2945 \tag{9b}
\end{array}
$$

The gauge $(\bar{\xi}=-1, \xi=0)$ corresponds to the Landau gauge for the reduced gauge field while the gauge $(\bar{\xi}=$ $1 / 3, \xi=2 / 3$ ) will be discussed later.

Following, e.g., [6, 9, 10] (see also the review [1]) the dynamical screening of the interaction may be included, in the so-called random-phase approximation (RPA), by resumming the one-loop polarization operator, Eq. (4); notice that the LO polarization operator in $\mathrm{QED}_{3}$ and the one-loop polarization operator in $\mathrm{RQED}_{4,3}$ are equal. Contrarily to the case of $\mathrm{QED}_{3}$, however, in $\mathrm{RQED}_{4,3}$ such a resummation does not change the infrared property of the corresponding photon propagator [32] which then reads:

This RPA resummation may be taken into account with the help of a simple redefinition of the coupling constant which becomes:

Accordingly, the transformation (6) has to be replaced by:

\frac{1}{L} \rightarrow \frac{\tilde{e}^{2}}{16 \pi^{2}}=\frac{\tilde{\alpha}}{4 \pi} \equiv \tilde{g}, \quad \eta \rightarrow \frac{\bar{\eta}}{2} \quad\left(\xi \rightarrow \frac{1+\bar{\xi}}{2}\right) \tag{12}
\end{equation*}

The gap equation (7) then immediately yields the LO RPA critical coupling constant:

\alpha_{c}(\bar{\xi})=\frac{\pi}{2(5+\bar{\xi})-N \pi^{2} / 4} \tag{13}
\end{equation*}
$$

which now is not only gauge dependent but also depends on the number of fermion flavours, $N$. For $N=2$, Eq. (13) yields the following values in various gauges:

\alpha_{c}(\bar{\xi}=0)=0.6202, & \alpha_{c}(\bar{\xi}=1)=0.4447 \\
\alpha_{c}(\bar{\xi}=-1)=1.0249, & \alpha_{c}(\bar{\xi}=1 / 3)=0.5481 \tag{14b}
\end{array}
$$

Dynamical screening therefore increases the value of the critical coupling, compare (14) with (9). It is also convenient to find the critical fermion flavour number $N_{c}$ for which $\alpha_{c} \rightarrow \infty$. Eq. (13) yields:

This number coincides with the critical flavour number $N_{c}$ for $\mathrm{D} \chi \mathrm{SB}$ in $\mathrm{QED}_{3}$ which is defined as $N_{c}=L_{c} / \pi^{2}$. In various gauges, its value reads:

N_{c}(\bar{\xi}=0)=4.0529, & N_{c}(\bar{\xi}=1)=4.8634 \\
N_{c}(\bar{\xi}=-1)=3.2423, & N_{c}(\bar{\xi}=1 / 3)=4.3230 \tag{16b}
\end{array}
$$

Notice that the value $N_{c}(1 / 3)=128 /\left(3 \pi^{2}\right)$ has already been obtained in [30] where the importance of the $\bar{\xi}=1 / 3$ gauge has been emphasized following the seminal work of Nash 22], see also discussions in [28]. As shown by Nash [22], the wave function renormalization constant may be resummed at the level of the gap equation. The peculiar $\bar{\xi}=1 / 3$ gauge is the one where the wave function renormalization constant vanishes at LO and for which Nash's resummation does not affect much the results. We shall confirm this below.

## V. NEXT-TO-LEADING ORDER

From our NLO results for $\mathrm{QED}_{3}$ [28], combined with the transformations (6) or (12), we may compute the NLO coupling constant of $\mathrm{RQED}_{4,3}$. However, in order to properly do so, some additional replacements are necessary.

The first additional replacement is related to the fact that, in $\mathrm{QED}_{3}$, the NLO polarization operator $\hat{\Pi}_{2}$ 28] contributed to the NLO result within the framework of the $1 / N$ expansion:

\Pi_{2}^{\left(\mathrm{QED}_{3}\right)}(p)=\frac{2 a}{N \pi^{2}} \frac{\hat{\Pi}_{2}}{|p|}, \quad \hat{\Pi}_{2}=\frac{92}{9}-\pi^{2} \tag{17}
\end{equation*}
$$

On the other hand, within the framework of standard perturbation theory which applies to $\mathrm{RQED}_{4,3}$, it is only the LO (one-loop) polarization operator, Eq. (4), which contributes at NLO (two-loop). From the ratio of Eqs. (17) and (4) we define $\hat{\Pi}_{1}$ which is such that:

\frac{\Pi_{2}^{\left(\mathrm{QED}_{3}\right)}(p)}{\Pi_{1}(p)}=\frac{\hat{\Pi}_{2}}{\hat{\Pi}_{1}}, \quad \hat{\Pi}_{1}=\frac{N \pi^{2}}{2} \tag{18}
\end{equation*}
$$

So, in going from large- $N \mathrm{QED}_{3}$ to $\mathrm{RQED}_{4,3}$, the first additional replacement reads:

\hat{\Pi}_{2} \quad \rightarrow \quad \hat{\Pi}_{1} \tag{19}
\end{equation*}
$$

As we shall see below, of importance will be the fact that the values of $\hat{\Pi}_{1}$ are large in comparison with those of $\hat{\Pi}_{2}$.

The second additional replacement is related to the use of the nonlocal $\xi$-gauge in the case of $\mathrm{QED}_{3}$. Transforming back to the usual $\xi$-gauge in $\mathrm{RQED}_{4,3}$ amounts to apply the following simple condition:

With these additional transformations we are now in a position to transcribe the NLO results of large- $N \mathrm{QED}_{3}$ to the case of $\mathrm{RQED}_{4,3}$. In the following, we shall first solve the NLO gap equation without Nash's resummation and then with Nash's resummation.

## A. NLO without Nash's resummation

Combining the $\mathrm{QED}_{3}$ NLO results of [28] with the transformations (6), (19) and (20), the NLO gap equation for the critical coupling of $\mathrm{RQED}_{4,3}$ without RPA resummation reads:

& 1=16(2+\xi) g_{c} \\
& -8\left(S(\xi)-16\left(4-\frac{50}{3} \xi+5 \xi^{2}\right)-8 \hat{\Pi}_{1}\right) g_{c}^{2} \tag{21}
\end{align*}
$$

where we have kept $\xi=(1+\bar{\xi}) / 2$ to facilitate comparison with the results of [28]. In Eq. (21), $S(\xi)$ contains the contribution of the complicated diagrams $I_{1}, I_{2}$ and $I_{3}$ having representations [24] in the form of two-fold series (for $I_{1}$ ) and three-fold ones (for $I_{2}$ and $I_{3}$ ), respectively. Solving Eq. (21), we have two standard solutions:

where

d_{1}(\xi)=8\left(S(\xi)-8\left(4-\frac{112}{3} \xi+9 \xi^{2}\right)-8 \hat{\Pi}_{1}\right) \tag{23}
\end{equation*}
$$

It turns out that the "-" solution is unphysical and has to be rejected because $\alpha_{c,-}<0$. So, the physical solution
is unique and corresponds to $\alpha_{c}=\alpha_{c,+}$. For numerical applications, we use the numerical estimates of [24, 28]:

which enter the expression of $S(\xi)$ :

In various $\bar{\xi}$-gauges: $\bar{\xi}=0,1,-1,1 / 3$ that respectively correspond to $\xi=1 / 2,1,0,2 / 3$, Eq. (24) allows us to obtain the numerical value of:

$$
\begin{align*}
& S(\bar{\xi}=0)=\frac{R_{1}}{2}-\frac{3 R_{2}}{32}-\frac{57 P_{2}}{512}  \tag{26a}\\
& S(\bar{\xi}=1)=-\frac{5 P_{2}}{32}  \tag{26b}\\
& S(\bar{\xi}=-1)=R_{1}-\frac{R_{2}}{8}-\frac{7 P_{2}}{128}  \tag{26c}\\
& S(\bar{\xi}=1 / 3)=\frac{R_{1}}{3}-\frac{5 R_{2}}{72}-\frac{49 P_{2}}{384} \tag{26~d}
\end{align*}
$$

Notice that the solutions of Eq. (22) are physical provided that the following inequality is satisfied:

$$
\begin{equation*}
d_{1}(\xi) \geq 0 \tag{27}
\end{equation*}
$$

In the absence of RPA resummation, Eq. (27) is satisfied only in the unphysical case $N=0$ for which $\hat{\Pi}_{1}=0$. For $N>0$, the large value of $\hat{\Pi}_{1}$ makes $d_{1}(\xi)$ negative which in turn implies that Eq. (21) has no physical solutions.

Fortunately, the situation strongly improves upon performing the RPA resummation. Indeed, in this case, the inequality Eq. (27) is satisfied for all the values of $\xi$ we consider, excepting the case $\bar{\xi}=\xi=1$ which corresponds to the Feynman gauge. To see this, consider Eq. (11) which can be re-written as:

$$
\begin{equation*}
\alpha=\frac{\tilde{\alpha}}{1-\hat{\Pi}_{1} \tilde{\alpha} /(2 \pi)}, \quad g=\frac{\tilde{g}}{1-2 \hat{\Pi}_{1} \tilde{g}} \tag{28}
\end{equation*}
$$

where $\hat{\Pi}_{1}$ defined in Eq. (18) was made explicit. Substituting Eq. (28) in (21), we see that the contribution of $\hat{\Pi}_{1}$ cancels out from the new gap equation which reads:

$$
\begin{equation*}
1=16(2+\xi) \tilde{g}_{c}-8\left(S(\xi)-16\left(4-\frac{50}{3} \xi+5 \xi^{2}\right)\right) \tilde{g}_{c}^{2} \tag{29}
\end{equation*}
$$

Hence, Eq. (29) has a broader range of solutions than Eq. (21) including all $\bar{\xi}$-values such as: $-5.695<\bar{\xi}<$ 0.915 or, equivalently: $-2.348<\xi<0.957$; the Feynman gauge is still excluded because $S(\bar{\xi}=1)$ is large and negative. Numerical applications for $\tilde{\alpha}_{c}=\tilde{\alpha}_{c,+}$ then yield:

$$
\begin{equation*}
\tilde{\alpha}_{c}(0)=0.3804, \quad \tilde{\alpha}_{c}(-1)=0.3794, \quad \tilde{\alpha}_{c}(1 / 3)=0.3924 \tag{30}
\end{equation*}
$$

Substituting the values (30) in Eq. (28) yields, for $N=2$ :

$$
\begin{equation*}
\alpha_{c}(0)=0.9451, \alpha_{c}(-1)=0.9389, \alpha_{c}(1 / 3)=1.0227 \tag{31}
\end{equation*}
$$

The critical number, $N_{c}$, for which $\alpha_{c} \rightarrow \infty$ and is such that a finite critical coupling exists for $N<N_{c}$ takes the following values:

$$
\begin{equation*}
N_{c}(0)=3.3472, N_{c}(-1)=3.3561, N_{c}(1 / 3)=3.2450 \tag{32}
\end{equation*}
$$

The numerical values in (32) are a little larger than in $\mathrm{QED}_{3}$ where $N_{c}$ is defined as $N_{c}=L_{c} / \pi^{2}$ because of the additional (small) factor $\hat{\Pi}_{2}$ coming with a negative sign, see [28].

## B. NLO with Nash's resummation

Following [22] we now resum the "basic" part of the NLO corrections corresponding to the fermion wave function renormalization. Combining the $\mathrm{QED}_{3}$ resummed gap equation of [28] with the transformations (6), (19) and $(20)$, the NLO resummed gap equation for the critical coupling of $\mathrm{RQED}_{4,3}$ without RPA resummation reads:

$$
\begin{equation*}
1=\frac{128}{3} g_{c}+8\left(\tilde{S}(\xi)-\frac{1280}{27}-\frac{32}{3} \hat{\Pi}_{1}\right) g_{c}^{2} \tag{33}
\end{equation*}
$$

where $\tilde{S}(\xi)$ contains the rest of $S(\xi)$, see [28], after the extraction of the "most important" contributions. Similarly to the case of $\mathrm{QED}_{3}$ [28], the striking feature of Eq. (33) is the absence of $\xi$-dependence at LO and it's strong suppression at $\underset{\sim}{N L O}$ : the $\xi$-dependence does exist at NLO but only via $\tilde{S}(\xi)$ which, as we shall see shortly, is small numerically. Solving Eq. (33), we have the two standard solutions:

$$
\begin{equation*}
\alpha_{c, \pm}=\frac{4 \pi}{64 / 3 \pm \sqrt{d_{2}(\xi)}} \tag{34}
\end{equation*}
$$

where

$$
\begin{equation*}
d_{2}(\xi)=8\left(\tilde{S}(\xi)+\frac{256}{27}-\frac{32}{3} \hat{\Pi}_{1}\right) \tag{35}
\end{equation*}
$$

As before, the "-" solution is unphysical and has to be rejected because $\alpha_{c,-}<0$. So, the physical solution is unique and corresponds to $\alpha_{c}=\alpha_{c,+}$. In order to provide numerical estimates, we use the values $\tilde{R}_{1}, \tilde{R}_{2}$ and $\tilde{P}_{2}$, see [28]:

$$
\begin{equation*}
\tilde{R}_{1}=3.7428, \quad \tilde{R}_{2}=1.175, \quad \tilde{P}_{2}=-19.280 \tag{36}
\end{equation*}
$$

which enter the expression of $\tilde{S}(\xi)$ :

$$
\begin{equation*}
\tilde{S}(\xi)=(1-\xi) \tilde{R}_{1}-\left(1-\xi^{2}\right) \frac{\tilde{R}_{2}}{8}-\left(7+16 \xi-3 \xi^{2}\right) \frac{\tilde{P}_{1}}{128} \tag{37}
\end{equation*}
$$

For the gauge choices: $\bar{\xi}=0,1,-1,1 / 3$ that respectively correspond to $\xi=1 / 2,1,0,2 / 3$, we may then obtain numerical values of:

$$
\begin{align*}
& S(\bar{\xi}=0)=\frac{\tilde{R}_{1}}{2}-\frac{3 \tilde{R}_{2}}{32}-\frac{57 \tilde{P}_{2}}{512}  \tag{38a}\\
& S(\bar{\xi}=1)=-\frac{5 \tilde{P}_{2}}{32}  \tag{38b}\\
& S(\bar{\xi}=-1)=\tilde{R}_{1}-\frac{\tilde{R}_{2}}{8}-\frac{7 \tilde{P}_{2}}{128}  \tag{38c}\\
& S(\bar{\xi}=1 / 3)=\frac{\tilde{R}_{1}}{3}-\frac{5 \tilde{R}_{2}}{72}-\frac{49 \tilde{P}_{2}}{384} \tag{38d}
\end{align*}
$$

Notice that the solutions of Eq. (34) are physical provided that:

$$
\begin{equation*}
d_{2}(\xi) \geq 0 \tag{39}
\end{equation*}
$$

As in the previous case, this inequality is satisfied only for the nonphysical case $N=0$.

Fortunately, the situation once again strongly improves upon the additional implementation of the RPA resummation. Substituting Eq. (28) in (33), we see that the contribution of $\hat{\Pi}_{1}$ cancels out from the new gap equation which reads:

$$
\begin{equation*}
1=\frac{128}{3} \tilde{g}_{c}+8\left(\tilde{S}(\xi)-\frac{1280}{27}\right) \tilde{g}_{c}^{2} \tag{40}
\end{equation*}
$$

Hence, Eq. (40) has a broader range of solutions than Eq. (33) including all $\bar{\xi}$-values such as: $-19.668<\bar{\xi}<$ 8.928 or, equivalently: $-9.334<\xi<4.964$. This shows that the improvement is even better that in the absence of Nash's resummation because, in the present case, a physical solution also exists in the Feynman gauge $\bar{\xi}=$ $\xi=1$. Numerical applications for $\tilde{\alpha}_{c}=\tilde{\alpha}_{c,+}$ yield:

$$
\begin{array}{ll}
\tilde{\alpha}_{c}(\bar{\xi}=0)=0.3966, & \tilde{\alpha}_{c}(\bar{\xi}=1)=0.4011 \\
\tilde{\alpha}_{c}(\bar{\xi}=-1)=0.3931, & \tilde{\alpha}_{c}(\bar{\xi}=1 / 3)=0.3980 \tag{41b}
\end{array}
$$

Substituting the values (41) in Eq. (28) yields, for $N=2$ :

$$
\begin{array}{ll}
\alpha_{c}(\bar{\xi}=0)=1.0521, & \tilde{\alpha}_{c}(\bar{\xi}=1)=1.0841 \\
\alpha_{c}(\bar{\xi}=-1)=1.0278, & \alpha_{c}(\bar{\xi}=1 / 3)=1.0619 \tag{42b}
\end{array}
$$

These values are very close to each other proving the very weak gauge variance of our results. For the sake of completeness, we give the value of the critical coupling constant in the case $N=1$ :

$$
\begin{array}{ll}
\alpha_{c}(\bar{\xi}=0)=0.5761, & \tilde{\alpha}_{c}(\bar{\xi}=1)=0.5855 \\
\alpha_{c}(\bar{\xi}=-1)=0.5687, & \alpha_{c}(\bar{\xi}=1 / 3)=0.5790 \tag{43b}
\end{array}
$$

and in the case $N=3$ :

$$
\begin{array}{ll}
\alpha_{c}(\bar{\xi}=0)=6.0588, & \tilde{\alpha}_{c}(\bar{\xi}=1)=7.2971 \\
\alpha_{c}(\bar{\xi}=-1)=5.3310, & \alpha_{c}(\bar{\xi}=1 / 3)=6.3960 \tag{44b}
\end{array}
$$

For higher (integer) values of $N$, there is no instability. This can be seen by computing the value of $N, N_{c}$, for which $\alpha_{c} \rightarrow \infty$. As in the previous case, see Eq. (32), this value coincides with the critical value $N_{c}$ for $\mathrm{D} \chi \mathrm{SB}$ in $\mathrm{QED}_{3}$ :

$$
\begin{array}{ll}
N_{c}(\bar{\xi}=0)=3.2102, & N_{c}(\bar{\xi}=1)=3.1745 \\
N_{c}(\bar{\xi}=-1)=3.2388, & N_{c}(\bar{\xi}=1 / 3)=3.1991 \tag{45b}
\end{array}
$$

As anticipated above, we see that the "right(est)" gauge choice [30] is the one close to ( $\bar{\xi}=1 / 3, \xi=2 / 3$ ) where the results are more or less the same before and after Nash's resummation.

We finally consider the case where $\tilde{S}(\xi)=0$ in (40). In this case, there no gauge dependence at all and we have: $\tilde{\alpha}_{c}=0.41828$. Hence:

$$
\begin{align*}
& \alpha_{c}(N=2)=1.2196  \tag{46a}\\
& \alpha_{c}(N=1)=0.6229, \quad \alpha_{c}(N=3)=28.9670 \tag{46b}
\end{align*}
$$

The number $N_{c}$ coincides with $N_{c}=L_{c} / \pi^{2}$ in $\mathrm{QED}_{3}$ and has the following value:

$$
\begin{equation*}
\bar{N}_{c}=3.0440 \tag{47}
\end{equation*}
$$

which is a little less than the ones in (45).

## VI. COMPARISON WITH OTHER RESULTS

Our results for $\alpha_{c}\left(0.94<\alpha_{c}<1.02\right.$ without Nash's resummation and $1.03<\alpha_{c}<1.08$ with Nash's resummation) are in good agreement with $\alpha_{c}=0.92$ 11] and $\alpha_{c}=1.13$ 9]. These last results were obtained as improvements of previous studies: [11] took into account of the dynamical screening of the interactions with respect to [6] where the value $\alpha_{c}=1.62$ was found in the static approximation, i.e., RPA with polarization operator at zero frequency; 9] took into account Fermi velocity renormalization with respect to the earlier work in [5]; see also discussions in Refs. 11] and [18] as well as a detailed summary of these results in the review [1] and in [14]. Our results are also in good agreement with lattice Monte-Carlo simulations where $\alpha_{c}=1.11 \pm 0.06$ was obtained in (12] and $\alpha_{c}=0.9 \pm 0.2$ in [15]. Moreover, in the strong coupling regime, $\alpha_{c} \rightarrow \infty$, our critical values for $N_{c}\left(3.24<N_{c}<3.36\right.$ without Nash's resummation and $3.17<N_{c}<3.24$ with Nash's resummation) are close to $N_{c}=7.2 / 2=3.6$ obtained in [9] and $N_{c}=3.52$ [10]. These results for $\alpha_{c}$ would not be compatible with the semimetallic behaviour of graphene observed experimentally [4] if we were to compare them with the bare
coupling constant $\alpha \approx 2.2$ in clean suspended graphene. We may however argue that the renormalization of the Fermi velocity observed in [4] would rather be compatible with a coupling constant of about 0.73 which is indeed smaller than all of the above values theoretically obtained for $\alpha_{c}$.

Nevertheless, the results [5, 6, 9, 11] were then criticized for not properly taking into account dynamical screening of interactions and/or wave function and/or velocity renormalizations. Recent attempts to better take into account (some or all of) these effects at the level of SD equations led to larger values: $3.2<\alpha_{c}<3.3$ [14], $\alpha_{c}=7.65$ [16] and $\alpha_{c}=3.1$ 17]. Such large values are well above the bare value of $\alpha$ and therefore compatible with the semi-metallic ground state observed experimentally.

## VII. CONCLUSION

The critical behaviour of $\mathrm{RQED}_{4,3}$ was studied up to NLO on the basis of a correspondence with $\mathrm{QED}_{3}$ providing high precision estimates of the critical coupling constant, $\alpha_{c}$, and critical fermion flavour number, $N_{c}$, for graphene at the fixed point. Dynamical screening and wave function renormalization were fully taken into account (there is no velocity renormalization at the fixed point). We found that $\alpha_{c} \sim \mathrm{O}(1)$, so that $\alpha_{c} \gg \alpha_{\mathrm{QED}}$ and, at the fixed point, graphene is deep in the semimetallic phase in qualitative agreement with experiments in actual samples. The striking feature of our results is that our values of $\alpha_{c}$ and $N_{c}$ are in good quantitative agreement with results obtained in the nonrelativistic limit [7, 9 12, 15]. Such an agreement between the two extreme limits, $v / c \rightarrow 0$ and $v / c \rightarrow 1$, seems to suggest that the study of the fixed point is not only of academic interest and that our model may be an efficient effective field theory model in describing some of the features of actual planar condensed matter physics systems 41]. An interesting and difficult challenge would then be to extend all of these computations to arbitrary values of $v / c$. We leave this task for future work.
