Age-related differences in affective responses to and memory for emotions conveyed by music: a cross-sectional study

There is mounting evidence that aging is associated with the maintenance of positive affect and the decrease of negative affect to ensure emotion regulation goals. Previous empirical studies have primarily focused on a visual or autobiographical form of emotion communication. To date, little investigation has been done on musical emotions. The few studies that have addressed aging and emotions in music were mainly interested in emotion recognition, thus leaving unexplored the question of how aging may influence emotional responses to and memory for emotions conveyed by music. In the present study, eighteen older (60-84 years) and eighteen younger (19-24 years) listeners were asked to evaluate the strength of their experienced emotion on happy, peaceful, sad, and scary musical excerpts (Vieillard et al., 2008) while facial muscle activity was recorded. Participants then performed an incidental recognition task followed by a task in which they judged to what extent they experienced happiness, peacefulness, sadness, and fear when listening to music. Compared to younger adults, older adults (a) reported a stronger emotional reactivity for happiness than other emotion categories, (b) showed an increased zygomatic activity for scary stimuli, (c) were more likely to falsely recognize happy music, and (d) showed a decrease in their responsiveness to sad and scary music. These results are in line with previous findings and extend them to emotion experience and memory recognition, corroborating the view of age-related changes in emotional responses to music in a positive direction away from negativity.

INTRODUCTION 035

Research on age differences in emotion processing has been 036 mostly restricted to visual stimuli (e.g., facial expression, video, 037 words, and pictures) but a growing body of research converges 038 in indicating that music also serves as a powerful emotional trig-039 ger. For example, Blood et al. (1999) have shown that classical 040 musical stimuli which are selected to elicit intensely pleasant 041 emotional responses engage neural networks that are implicated 042 in reward. Neuropsychological studies have also demonstrated 043 that the amygdala is recruited when processing scary music (e.g., 044 Gosselin et al., 2005, 2007). Physiological data have also put in 045 evidence that music is a strong emotion inducer (e.g., Khalfa et al., 046 2002). Furthermore, music has the clear advantage of maintain-047 ing attention toward the emotions conveyed because it does not 048 allow perceptual attention to be redirected (except if the listener 049 takes off his/her headphones). For these reasons, music appears as 050 a viable method to test age-related changes in emotion processing. 051

Among the past studies that have addressed the question 052 of age-related changes in musical emotion processing, most of 053 them have focused on the people's ability to recognize musi-054 cal emotions (Allen and Brosgole, 1993; Laukka and Juslin, 055 2007; Drapeau et al., 2009; van Tricht et al., 2010; Lima and 056 Castro, 2011; Vieillard et al., 2012). For instance, Drapeau et al. 057

091 (2009) compared healthy elderly adults and elderly adults with 092 Alzheimer's disease in their ability to rate the extent to which 093 the selected musical stimuli communicating happiness, peace-094 fulness, sadness and fear (Vieillard et al., 2008) expressed each 095 of these four emotions. Their findings showed that recognition 096 performances of healthy older adults were relatively preserved 097 with the highest recognition accuracy for happy stimuli. Laukka 098 and Juslin (2007) compared young and older adults' ability to 099 recognize anger, fear, happiness, sadness, and neutrality in short 100 melodies performed on an electric guitar with different degrees of 101 expressivity. In their study, the participants judged the emotional 102 expression of each stimulus in a forced choice task comprised 103 of anger, fear, happiness, sadness, neutral, and "other emotion" 104 alternatives. Compared to young adults, older adults were less 105 accurate in recognizing negative emotions such as sadness and 106 fear, but their ability to recognize other emotion categories was 107 spared. More recently, Lima and Castro (2011) went one step fur-108 ther by examining age-related changes in emotion recognition 109 among three age groups of participants (i.e., young, middle-aged, 110 and old). Selecting the same musical excerpts as those used in 111 Drapeau et al. (2009)'s study, the authors asked the participants 112 to judge the emotional intensity perceived for each stimulus on 113 four rating scales (i.e., happiness, sadness, peacefulness, and fear) 114

presented simultaneously. Consistent with previous findings, the authors found an emotion-specific age-related change characterized by a stable recognition of happiness and peacefulness categories but a gradual decline in responsiveness to sad and scary music from young adulthood to older age.

As an alternative to the hypotheses of age-related differences 120 in cognitive functioning¹ or hearing loss², the above findings 121 have been interpreted as being the result of a combination of age-122 related changes in brain structure and functioning and in moti-123 vational goals. On the one hand, empirical evidence suggest that 124 the observed decline found in older adults in negative emotion 125 recognition may be the result of a linear reduction in the volume 126 of the amygdala (e.g., Zimmerman et al., 2006) and/or of a 127 decrease of the reactivity to negative information in the amygdala 128 (e.g., Mather et al., 2004). On the other hand, Socioemotional 129 Selectivity Theory (Carstensen et al., 1999; Carstensen, 2006) sug-130 gests that the decline in the recognition of negative emotions 131 would reflect a motivational shift toward emotionally meaningful 132 goals due to an increased awareness of the limited perspective of 133 time. This so-called "positivity effect" which refers to all combina-134 tions of enhanced processing of positive information and reduced 135 processing of negative information, has been thought of as an 136 emotion regulation strategy to preserve high levels of well-being 137 in later life. In a recent literature review, Reed and Carstensen 138 (2012) showed that this positivity effect (1) requires cognitive 139 resources (e.g., Mather and Knight, 2005), (2) is sensitive to the 140 experimental context (Kensinger et al., 2002; Grühn et al., 2005), 141 and (3) is adaptive, i.e., it emerges when emotional well-being is 142 prioritized. Consequently, the authors claimed that the positivity 143 effect would represent a controlled shift in attentional resources 144 rather than an automatic process associated with the neuronal 145 degeneration in brain regions. Such view is compatible with the 146 idea that the positivity effect may have a cognitive counterpart. 147

Recently, Vieillard et al. (2012) conducted a study in order 148 to test for age-related differences in the psychological structure 149 of musical emotions, and to assess whether these changes may 150 be associated with a decrease in emotional complexity. In this 151 research, younger and older participants were presented with 152 musical excerpts conveying different emotions such as happiness, 153 peacefulness, sadness, and fear (Vieillard et al., 2008). Participants 154 were asked to perform an emotional judgment task using different 155 rating scales (i.e., valence, hedonic value, arousal, and liking) as 156 well as a free categorization task in which they freely created emo-157 tional categories based on the perceived acoustical cues. Findings 158 showed age-related differences characterized by a reduced pro-159 cessing of arousal for scary music, an increased focus on happy 160 music, and an emotional dedifferentiation corresponding to 161 a decrease in differentiation between the arousal and valence 162 dimensions. Such results have been explained within the frame-163 work of the Dynamic Integration Theory (Labouvie-Vief, 2009; 164 Labouvie-Vief et al., 2010) postulating that the degradation of 165 emotional complexity would be the cognitive counterpart of the 166

older adults' attempt to maximize positive affects and minimize 172 negative affect in order to preserve well-being. 173

In short, the studies reviewed above show converging evidence 174 for a positivity effect in how emotions in music are perceived, 175 categorized, and recognized with advancing age. However, sev-176 eral questions remain open. First, little is known about age-related 177 changes regarding the emotions experienced while listening to 178 music. Previous findings have suggested that participants were 179 more accurate in their judgment of intended emotions in musi-180 cal excerpts when focusing on their own emotional experience 181 (Vieillard et al., 2008). One of the goals of the present study 182 was thus to investigate the influence of aging on emotion pro-183 cessing while being personally engaged in musical listening. This 184 is an important question because it has been suggested that 185 emphasizing on emotion rather than on knowledge may be more 186 meaningful to older adults (e.g., Mikels et al., 2010). Second, as 187 far as we know, the possibility of age-related changes in memory 188 recognition for positive musical stimuli has yet to be examined. 189 Past research showed that age-related changes in emotional goals 190 influence memory. A positivity effect in memory recognition 191 tasks has already been shown in older adults for affective pic-192 tures (e.g., Charles et al., 2003; Mather and Carstensen, 2005) 193 and for words (e.g., Kensinger, 2008). The main explanation was 194 that memory can work as an elaborative process to regulate emo-195 tions such that the older adults' goal to maintain well-being would 196 influence mental constructions of the past and thus lead to a 197 positivity effect in the way they remember events. In line with 198 this hypothesis, it has been showed that memory for negative pic-199 tures decreased in older adults both in recall and recognition tasks 200 (e.g., Charles et al., 2003). Kensinger (2008) found a positivity 201 effect in older adults for non-arousing words, explaining this as 202 an age-related difference in the way positive information was pri-203 marily processed as a function of differences in motivational goals 204 at each age level. To date, the question remains open whether 205 age-related differences in the elaborative processing of memory 206 may be observed in a non-verbal channel of emotion communi-207 cation such as music. Third, to our knowledge, no previous study 208 has investigated age differences in facial muscle activity when lis-209 tening to music. Past studies examining age-related differences 210 in facial expressiveness have found that young and older adults 211 express similar patterns of facial responding to visual stimuli such 212 as emotional scenes, objects or faces (Reminger et al., 2000; Smith 213 et al., 2005; Bailey et al., 2009). However, older adults compared to 214 younger adults may exhibit diminished reactivity in facial expres-215 siveness (Smith et al., 2005; Burriss et al., 2007). The reduction of 216 facial expressiveness in the elderly has been thought to be a pos-217 sible consequence of general physiological losses in the nervous 218 system. However, another explanation suggests that the reduction 219 of facial expressiveness may reflect an attempt to regulate emo-220 tion since facial expression may be motivationally driven (Smith 221 et al., 2005). Given such emotion regulation hypothesis and in 222 line with the embodiment theory of emotion (Niedenthal et al., 223 2005), one can imagine that facial expressions may not only help 224 to down-regulate emotion (by displaying less facial expressions), 225 but also allow to modify the emotional reaction (by displaying a 226 facial expression contrary to what one feels). In this perspective, 227 facial electromyogram (EMG) appears as an interesting indicator 228

of whether there is congruence between facial expressivity and 229 230 musical emotion in both young and older adults, or do older adults express positive facial expression as a means to counteract 231 negative emotions. 232

There is an agreement to consider that emotional responding 233 is a multi-component process, giving rise to affective experiences, 234 235 physiological adjustments and expressive behaviors (e.g., Scherer, 2005). These various aspects of emotion may be differentially 236 influenced by age. Therefore, a unifying view of these changes 237 is necessary to give more insight into the lifespan developmental 238 course of emotion, particularly in the musical domain in which 239 this topic has remained unexplored. To this end, we focused on 240 different indexes of emotional response to music, namely subjec-241 tive experience, emotion expression and memory recognition for 242 musical excerpts that conveyed different emotions. 243

Finally, although the positivity effect has been observed across 244 a number of experimental paradigms such as dot-probe tasks 245 (Charles et al., 2003), eye-tracking paradigms (Isaacowitz et al., 246 2006a,b), working memory (Mikels et al., 2005), memory recog-247 nition and free recall tasks (Charles et al., 2003), and across a 248 variety of stimuli (e.g., pictures, word lists, facial expressions), 249 the robustness of this phenomenon has been mainly demon-250 strated through the visual channel of emotion communication. 251 Consequently, research regarding the effect of age on emotion 252 processing in music is needed to test for the generalizability of 253 the positivity effect. 254

256 CURRENT RESEARCH

257 The present study was designed to further extend previous stud-258 ies and expand experimental designs to the domain of music. Our 259 aim was twofold: first, to investigate the effects of aging on the 260 emotion felt when listening to music and second, to address age-261 related differences on memory recognition for musical excerpts as 262 a function of their intended emotion. To this end, we used a set of 263 musical stimuli expressing happiness, peacefulness, sadness, and fear which were all controlled for valence and arousal (Vieillard 264 265 et al., 2008). We used a rating task focused on the emotion expe-266 rienced by the participants rather than on the emotion recognized 267 by the participants. In order to address more extensively the effect 268 of aging on the experienced emotion, we designed the experiment so that the subjective report of the intensity of the emotion 269 felt was coupled with a recording of participants' facial expres-270 271 sions. These particular indexes were chosen since past research 272 has shown that facial expressions, measured by the corrugator 273 (i.e., frowning) and zygomatic (i.e., smiling) muscle activity, were 274 mostly related to the valence in music: positive emotions generally 275 lead to increased zygomatic activity, while negative ones were associated more with increased corrugator activity (e.g., Witvliet 276 and Vrana, 2007; Khalfa et al., 2008). Because it has been sug-277 gested that facial EMG may also be voluntarily modulated to serve 278 279 emotion regulation goal (Smith et al., 2005), we used this index to examine to what extent and how older adults show positive or 280 negative facial expression as a function of musical emotions. 281

Based on the hypothesis postulating a motivated attention 282 toward positivity with advancing age, and given the view that 283 situations relevant to a person's motivational goals may elicit 284 285 more intense emotional experience (e.g., Charles and Piazza,

2007), we expected that older adults, compared to younger adults, 286 would judge their feeling as more intense when listening to 287 positive musical excerpts (especially happy music that is more 288 arousing than peaceful one) than when listening to negative musi-289 cal excerpts. Since no age-related changes in facial expressivity 290 were found in previous research (e.g., Levenson et al., 1991; Tsai 291 et al., 2000; Magai et al., 2006), we also expected older adults to 292 be spared in their facial expressions (i.e., corrugators and zygo-293 matic muscle activity). More specifically, if older adults have 294 spontaneous facial activity, it is expected that they would dis-295 play a greater zygomatic activity for positive music in comparison 296 with their younger counterparts. At the same time, it is also 297 expected that older adults would display voluntary facial expres-298 sion as a tool to manage emotion. In this hypothesis, older adults 299 would show reduced expressivity or incongruent expression, in 300 particular in response to negativity. Moreover, in view of the 301 scarce data available on the influence of aging on memory recog-302 nition for musical excerpts that convey different emotions, and 303 because the memory elaborative processes for music are based 304 on more abstract information than those involved in the memory 305 for visual and autobiographical material, it is difficult to predict 306 the nature of the effects likely to be observed. Consequently, we 307 conducted an exploratory approach to test whether the positivity 308 effect may be generalized to memory recognition for musical 309 excerpts conveying different emotions. We expected that com-310 pared to younger adults, older adults should better recognize 311 positive musical excerpts than negative ones. 312

METHOD

PARTICIPANTS

A total of 40 native French speaking volunteers (22% amateur musicians³) participated in the present study. Exclusion criteria included the presence of uncorrected hearing, medical or psychiatric antecedents, psychotic symptoms, and history of substance abuse. As a result, the data of 18 young adults (19–24 years, M =21 years; 61 % females) and 18 older adults (60–84 years, M =66 years; 83% females) was analyzed. Younger and older adults were recruited, respectively at the psychology department of the University of Franche-Comté and through senior social programs in Besançon. Participants did not receive financial compensation 326 for their participation. 327

APPARATUS

Participants were tested individually in a quiet room at stable ambient temperature at the University. Facial muscle activity was monitored continuously during the listening and rating phases using an MP150 Biopac system (Biopac Systems, Inc., Goleta, CA) at a sampling rate of 500 Hz and processed using AcqKnowledge software. Eprime software (Schneider et al., 2002) was used for excerpts presentation and ratings recording. Musical excerpts were presented binaurally through Professional 240 Sennheiser headphones.

MATERIALS 343

344 Forty short musical excerpts, computer-generated in a piano timbre and taken from Vieillard et al. (2008) set of unfamiliar musical 345 346 stimuli were selected for their power to convey four distinct emotions (i.e., happiness, peacefulness, sadness, and fear). Musical 347 excerpts were controlled for their valence (unpleasant vs. pleas-348 ant) and arousal (low vs. high). Each emotion category included 349 ten musical excerpts that lasted an average of 10 s. The happy 350 excerpts were written in a major mode at an average tempo of 351 137 Metronome Markings (MM range: 92-196), with the melodic 352 line lying in the medium high pitch range (the pedal was not 353 used). The peaceful excerpts were composed in a major mode, had 354 an intermediate tempo (mean: 74 MM, range: 54-100), and were 355 played with pedal and arpeggio accompaniment. The sad excerpts 356 were written in a minor mode at an average slow tempo of 46 MM 357 (range: 40-60), with the pedal. The scary excerpts were composed 358 with minor chords on the third and sixth degree, hence implying 359 the use of many out-of-key notes. Although most scary excerpts 360 were regular and consonant, a few had irregular rhythms and were 361 dissonant. Their tempo varied from 44 to 172 MM. Examples 362 363 can be heard at www.brams.umontreal.ca/peretz. A previous study that was conducted to examine the effect of age on 364 emotion perception in music demonstrated that older listen-365 ers successfully distinguished happiness, peacefulness, sadness, 366 and fear conveyed by these musical excerpts (Vieillard et al., 367 2012). In a study phase described below, participants were pre-368 sented with 20 musical excerpts (i.e., 5 happy, 5 peaceful, 5 369 sad, and 5 scary) and were instructed to indicate what they 370 experienced in terms of Emotional Intensity. The 20 remain-371 ing musical excerpts were then used as lures in the incidental 372 recognition task. 373

PROCEDURE 375

374

376 The experiment was divided into two sessions separated by an 377 interval of ~1 week. During the first session, participants completed a consent form and were asked about their age, musical 378 listening, education level, self-reported health, visual and audi-379 380 tory acuity, and medical history. Auditory perception was con-381 trolled using free AudioTest software (www.cotral.com). More 382 specifically, it was assessed by presenting pure tones at intervals between 500 and 8000 Hz to both ears through Professional 383 384 240 Sennheiser headphones. For each participant, the lowest 385 sound pressure level at which each frequency was detected was 386 recorded. In addition, several tests assessing general cognitive function (MMSE, Petit et al., 1998), fluid intelligence (Raven's 387 progressive matrices, set I, Raven et al., 1998, updated 2003), 388 389 and working memory (letter-number sequencing from WAIS-III, Wechsler, 2000) were administered. The first session lasted 390 391 about an hour.

During the second session, physiological sensors were attached 392 393 while the participants sat comfortably in a quiet room in the presence of the experimenter. To prevent participants from focus-394 ing on their facial muscles, they were informed that the electrodes 395 placed on their face were used to record their electrodermal 396 activity during the experiment. At the beginning of the session, 397 two musical excerpts different from those used in the experi-398 ment were used in order to adjust the volume of the headphones 399

for each participant. In the study phase, two practice excerpts 400 (1 happy and 1 peaceful) following by 20 excerpts (5 of each 401 emotion) were then presented binaurally. After each trial, partic-402 ipants were asked to rate the intensity of the emotion felt using a 403 10-point scale ranging from 0 "weak" to 9 "strong." Facial mus-404 cle activity was also recorded. The excerpts were presented in 405 two pseudo-randomized orders that were created to ensure that 406 no more than two excerpts of the same emotion category were 407 presented consecutively. Each musical excerpt was preceded and 408 followed by two baseline periods of at least 10 s of silence. 409

Before the incidental recognition task, participants completed 410 two questionnaires to assess depression (Beck et al., 1998) and 411 anxiety (Spielberger, 1993; Beck et al., 1998). In the recognition 412 task participants were asked to indicate whether an excerpt had 413 been heard before ("old") or not ("new") by pressing the appro-414 priate key. In this phase, 40 musical excerpts (i.e., 20 old excerpts 415 and 20 new excerpts) were randomly presented. 416

Finally, participants were instructed to listen to the same set of 417 40 musical excerpts presented binaurally in a randomized order. 418 After each musical excerpt, participants were asked to judge to 419 what extent they experienced "happiness," "peacefulness," "sad-420 ness," or "fear" using a 10-point scale ranging from 0 "not at all" to 9 "a lot." Accordingly, each excerpt was presented four times; each presentation was associated with one of the four emotion scales. The presentation order of each musical excerpt and each rating scale was fully randomized across participants. The second session lasted about 2 h. At the end of the session, participants were fully debriefed. 427

DATA ACQUISITION AND TRANSFORMATION

Facial EMG activity (µVolts) was recorded over the left corrugator 430 and zygomatic sites, using two pairs of 8 mm Ag/AgCl shielded 431 electrodes filled with isotonic gel. The EMG data were band-pass 432 filtered from 100 to 500 Hz and processed with a root mean square 433 algorithm over 20 samples (with a 100-ms window). Recording 434 artifacts were visually identified and discarded from the sample. 435 These corresponded to less than 0.5% of all measurements. 436

RESULTS

SAMPLE CHARACTERISTICS

Younger adults reported more years of education than the older 440 adults, $t_{(34)} = -2.33$, p < 0.05. A chi-square goodness-of-fit test 441 (χ^2) indicated no significant differences between age groups in 442 the proportion of formal musical training of at least 3 years 443 $\chi^2(1, N = 36) = 4.5, p > 0.05$. Age groups did not differ regar-444 ding their depression, state anxiety, or trait anxiety scores⁴. 445 446

⁴⁴⁷ ⁴BDI-II scores indicated that 75% (n = 27) of the participants scored below 448 the cut-off (score of 11) for a minimum depression symptomatology and that 449 19.44% (n = 7) of the participants scored below the cut-off (score of 19) for at least mild depression. The remaining two participants (one young and one 450 older adult) scored between 22 and 24, which indicates moderate depression 451 symptomatology. STAI state anxiety scores indicated that 83.33% (n = 30) 452 of the participants scored below the cut-off (score of 35) for very low state 453 anxiety, 13.89% (n = 5) of them scored below the cut-off (score of 45) for low 454 state anxiety, and that 2.78% (n = 1) of them scored below the cut-off (score 455 of 55) for mild state anxiety. STAI trait anxiety scores indicated that 30.56% (n = 11) of the participants scored below the cut-off (score of 35) for very low 456

Non-parametric Mann-Whitney U-test⁵ performed on the audi-457 458 tory thresholds (dB) did not show statistically significant differences between younger and older adults (U = 10.50, z = 0.77, 459 p = 0.44 for 500 Hz; U = 0, z = 0, p = 1 for 1000 Hz; U =460 10, z = 0.84, p = 0.40 for 2000 Hz; U = 8, z = 1.12, p = 0.26461 for 4000 Hz; U = 33, z = 0.23, p = 0.81, for 8000 Hz). As was 462 expected, younger adults scored better than older adults on fluid 463 intelligence (Raven's progressive matrices, set I, Raven et al., 1998, 464 updated 2003), $t_{(34)} = -2.84$, p < 0.05. Younger adults tended 465 to perform better than older adults on a working memory test 466 (Digit Span from WAIS-III, Wechsler, 2000), $t_{(34)} = -1.94$, p =467 0.06. There were no significant age differences on self-reported 468 health, $t_{(34)} = -0.81$, p = 0.42. Finally, the Mini Mental State 469 Examination (MMSE; Petit et al., 1998) scores for the older adults 470 suggested no apparent signs of dementia (M = 29.7, 28-30). 471 Sample characteristics are detailed in Table 1. 472

473 **EMOTION INTENSITY FELT** 474

479

A mixed model analysis of variance was conducted on the mean 475 score of the Emotional Intensity Felt with Age Group (younger 476 adults, older adults) as the between-subjects factor and Intended 477 478

503 state anxiety, 41.67% (n = 15) scored below the cut-off (score of 45) for low 504 trait anxiety, and 19.44% (n = 7) scored below the cut-off (score of 55) for moderate trait anxiety. The remaining two participants (one young and one 505 older adult) scored between 57 and 58, which correspond for a high anxiety 506 state.

507 ⁵Because the audio test software did not provide absolute thresholds, we used 508 the lowest sound pressure level (dB) at which each frequency was detected 509 as an ordinal data. For this reason, the non-parametric Mann-Whitney test 510 (independent samples) was used. Although hearing thresholds varied as a 511 function of age, the Mann-Whitney test did not reveal significant differences between age groups probably because of the variability observed within the 512 groups, in particular in the older adults. 513

Emotions (happiness, peacefulness, sadness, fear) as the within-514 subjects factor. 515

As illustrated in Figure 1, we found a significant Age Group by 516 Intended Emotion interaction, $F_{(3, 102)} = 3.75$, p < 0.05, $\eta_C^2 =$ 517 0.06⁶. In order to test our hypothesis, we computed a planned 518 comparison between the emotion intensity felt by young adults 519 and that felt by older adults when listening to happy music. As 520 expected, older adults compared to young adults reported experi-521 encing higher emotional intensity when listening to happy music, 522 $F_{(1, 34)} = 5.57, p < 0.05, \eta_G^2 = 0.14$. This older adults' reactivity 523 for positivity was also confirmed by another set of planned com-524 parisons indicating that older adults reported experiencing higher 525 emotional activation when listening to happy music than when 526 listening to sad music, $F_{(1, 34)} = 7.34$, p < 0.05, $\eta_G^2 = 0.18$, or scary music, $F_{(1, 34)} = 8.76$, p < 0.05, $\eta_G^2 = 0.20$, while younger 527 528 adults did not. No other significant effect was found. A sepa-529 rate analysis with years of education, fluid intelligence scores, and 530 working memory performances (i.e., factors that were found to 531 be different between the two age groups) as covariates indicated 532 that the Age Group by Intended Emotion interaction remained 533 significant, $F_{(3, 93)} = 3.14$, p < 0.05, $\eta_G^2 = 0.05$. 534

FACIAL MUSCLE ACTIVITY

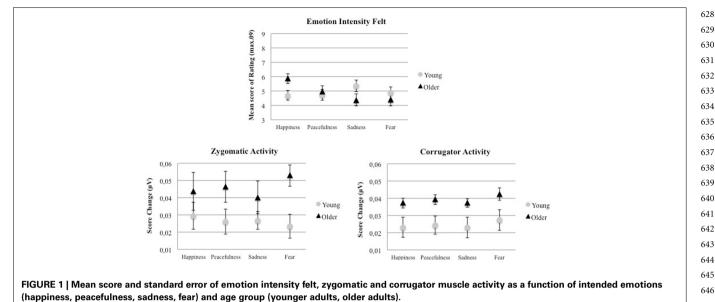
536 Facial EMG responses were calculated as the difference between 537 the signal (Area under the curve, μV^* sec) over the time course 538 of the musical excerpt and a baseline EMG level measured from 539 1s prior to the onset of the excerpt (time -1 to 0 s) to the begin-540 ning of the excerpt. The area under the curve was extracted 541 within these two time windows and was averaged for each con-542 dition and for each participant. Two participants were excluded 543 (1 younger and 1 older adults) from the initial sample due to 544 technical problems. Analyses were then conducted on seventeen 545 younger and seventeen older adults. The Shapiro-Wilk normality 546 test reached significance for the sample set of EMG data mean-547 ing that the assumption of normality has to be rejected. As a 548 result, statistical analyses were performed using non-parametric 549 tests. First, the differences between age groups were tested sep-550 arately for zygomatic and corrugator using the Mann-Whitney 551 U-test. Results showed a significant effect of Age Group both 552 for zygomatic (U = 42, z = 3.51, p < 0.001) and for corrugator 553 muscle (U = 83, z = 2.10, p < 0.05) indicating that facial activ-554 ity was more important in older adults than in their younger 555 counterparts. Friedman repeated measures analyses of variance 556 (RM-ANOVA) were conducted separately on zygomatic and on 557 corrugator activity to test the effect of Intended Emotion factor 558 for each Age Group. For zygomatic muscle, data revealed a signifi-559 cant effect of Intended Emotion in older adults, $\chi^2 = 12.46$, df =560 3, p < 0.05, but not in young adults, $\chi^2 = 2.01$, df = 3, p = 0.57. 561 As shown in Figure 1, older adults showed an increased zygo-562 matic activity, in particular for scary music. Regarding corrugator 563 564

⁵⁶⁵ ⁶We computed generalized eta squared statistics (η_G^2) with the aim to yield 566 measures of effect size comparable across a wide variety of research designs 567 (Bakeman, 2005), regardless of whether the factor is between or within subjects. activity, no significant effect of Intended Emotion was found either in older adults, $\chi^2 = 3.00$, df = 3, p = 0.39, or in younger adults, $\chi^2 = 5.68$, df = 3, p = 0.13.

596 INCIDENTAL RECOGNITION TASK

597 Proportions of hits, false alarms, and corrected recognition scores 598 (hits minus false alarms) are reported in Table 2. An analysis 599 of variance was conducted on corrected recognition scores with 600 Age Group (younger adults, older adults) as the between-subjects 601 factor and Intended Emotion (happiness, peacefulness, sadness, 602 fear) as the within-subjects factor. Analysis showed a significant 603 main effect of Age Group indicating that younger adults recog-604 nized more musical stimuli than older adults, $F_{(1, 34)} = 30.87$, 605 p < 0.001, $\eta_G^2 = 0.50$. There was also a significant main effect of Intended Emotion, $F_{(3, 102)} = 4.86$, p < 0.05, $\eta_C^2 = 0.12$, indi-606 cating that scary music stimuli were better recognized than 607 608 peaceful and sad music stimuli. This was confirmed by post-hoc 609 Bonferroni comparisons (ps < 0.05). No significant Age Group 610 by Intended Emotion interaction was observed, $F_{(3, 102)} = 0.27$, p = 0.84, $\eta_C^2 = 0.01$. Younger adults' recognition performances 611 were at chance level or above only for the highly arousing musi-612 613 cal stimuli such as happy (52%) and scary (61%) ones, while 614 older adults' recognition performances varied between 10 and 615 39% through the four intended emotions.

Additional separate analyses conducted on hits and false 616 617 alarms revealed that older adults generated more false alarms than younger adults, $F_{(1, 34)} = 18.47$, p < 0.001, $\eta_G^2 = 0.35$. 618 There was also a significant main effect of Intended Emotion, 619 $F_{(3, 102)} = 22.02, p < 0.001, \eta_G^2 = 0.36$, as well as a significant 620 Intended Emotion by Age Group interaction for false alarm rates, 621 $F_{(3, 102)} = 4.85, p < 0.05, \eta_G^2 = 0.08$. Post-hoc Bonferroni com-622 parisons showed that the older listeners, compared with their 623 vounger counterparts, had more difficulty to correctly reject new 624 happy musical stimuli (p < 0.05). Moreover, older adults were 625 better to correctly reject new scary musical stimuli in comparison 626 to all other intended emotions (ps < 0.001) while younger adults 627

were better to correctly reject new scary musical stimuli in com-649 parison to only low arousing stimuli like peaceful (p < 0.05) 650 and sad (p < 0.05) ones. No significant effect or interaction was 651 found for hits rates. Again, the analysis of covariance with years 652 653 of education, fluid intelligence scores, and working memory performances as covariates showed that the Intended Emotion by Age 654 Group interaction remained significant, $F_{(3, 93)} = 3.70, p < 0.05$, 655 $\eta_G^2 = 0.07.$ 656

D-prime was calculated using tables for d-prime and beta 657 available in Hochhaus (1972) and analyzed using another mixed 658 ANOVA. This indicates the ability to discriminate between true 659 targets and false targets (Green and Swets, 1966), with Age Group 660 (younger adults, older adults) as the between-subjects factor and 661 Intended Emotion (happiness, peacefulness, sadness, fear) as the 662 within-subjects factors. We obtained a significant main effect of 663 Age, $F_{(1, 34)} = 26.41$, p < 0.001, $\eta_G^2 = 0.44$ indicating that, over-664 all, older adults showed lower d-prime score (M = 0.43, SE =665 0.15) than younger adults (M = 1.50, SE = 0.15). This suggests 666 a lower sensitivity in the discrimination of true musical excerpts 667 from false musical excerpts in older adults. No other significant 668 interaction was found with d-prime as the dependent variable. 669 The beta value that indicates the minimum level of activation 670 necessary for a participant to respond to a true target (Green and 671 Swets, 1966) was also calculated (Hochhaus, 1972). No signifi-672 cant main effect or interaction was found with beta value as the 673 dependent variable. 674

DIFFERENTIATION IN EMOTION FELT

As in previous studies (Vieillard et al., 2008), we derived the 677 best label attributed to each musical excerpt by each participant. 678 This was done selecting the label (i.e., happy, peaceful, sad, scary) 679 that had received the maximal rating. When the maximal rating 680 corresponded to the label that matched the intended emotion, a 681 score of 1 was given. When the maximal rating did not correspond 682 to the emotion, a score of 0 was given. When the highest rating 683 was given for more than one label, the response was considered 684

721 ambivalent and received a score of 0. For example, when an 722 excerpt was perceived eliciting both peacefulness and sadness to 723 the same degree (e.g., with a rating of 7), it was considered as 724 ambivalent. Best labels scores are presented in Table 3.

725 A mixed model analysis of variance was conducted on the 726 mean Best Label with Age Group (younger adults, older adults) 727 as a between-subjects factor and Intended Emotions (happiness, 728 peacefulness, sadness, fear) and Emotion Felt (happiness, peace-729 fulness, sadness, fear) as within-subjects factors. Significant main 730 effects of Age Group, $F_{(1, 34)} = 7.43$, p < 0.05, $\eta_G^2 = 0.18$, and 731 Emotion Felt, $F_{(3, 102)} = 5.87$, p < 0.001, $\eta_G^2 = 0.14$ were found. 732 As expected, results also indicated a significant Intended Emotion 733 by Emotion Felt interaction, $F_{(9, 306)} = 71.45$, p < 0.001, $\eta_G^2 =$ 734 0.58, as well as a significant Intended Emotion by Emotion Felt 735 by Age Group, $F_{(9, 306)} = 5.10$, p < 0.001; $\eta_G^2 = 0.09$. No other 736 significant main effect or interaction was observed. We first com-737 pared the experience emotion between younger and older adults 738 for each intended emotion. The results indicated that older adults, compared to younger adults, reported experiencing lower levels 739 of sadness when listening to sad music, $F_{(1, 34)} = 5.44, p < 0.05$, 740 $\eta_G^2 = 0.14$, but reported higher levels of sadness when listening 741 to scary music, $F_{(1, 34)} = 6.35$, p < 0.05, $\eta_G^2 = 0.16$. Moreover,

755 when listening to scary music, older adults reported experienc-756 ing lower levels of fear, $F_{(1, 34)} = 18.78$, p < 0.001, $\eta_G^2 = 0.36$, 757 than their younger counterparts. The second set of comparisons 758 was conducted to compare the emotion experienced for each 759 intended emotion within each age group. The results showed 760 that older adults reported similar levels of sadness and peaceful-761 ness when listening to peaceful music, $F_{(1, 34)} = 1.92$, p = 0.18, 762 $\eta_G^2 = 0.05$, and sad music, $F_{(1, 34)} = 0.85$, p = 0.36, $\eta_G^2 = 0.03$, 763 as well as similar levels of sadness and fear when listening to 764 scary music, $F_{(1, 34)} = 0.44$, p = 0.51, $\eta_G^2 = 0.01$. Younger adults 765 reported similar levels of sadness and peacefulness only when lis-766 tening to peaceful music, $F_{(1, 34)} = 0.73$, p = 0.40, $\eta_G^2 = 0.02$. 767 Happy music was the only music that primarily elicited hap-768 piness (when compared with the level of peacefulness felt) in 769 both young and older adults, $F_{(1, 34)} = 117.63$, p < 0.001, $\eta_G^2 =$ 770 0.78, and $F_{(1, 34)} = 105.92$, p < 0.001, $\eta_G^2 = 0.76$, respectively]. 771 The Intended Emotion by Emotion Felt by Age Group interac-772 tion remained significant when years of education, fluid intelli-773 gence scores, and working memory performances were entered as 774 covariates, $F_{(9, 279)} = 2.90, p < 0.05, \eta_G^2 = 0.06.$

THE RELATIONSHIP BETWEEN AGE AND DEPENDENT MEASURES

777 In order to check for any relationships between age and the different dependent measures (i.e., emotion intensity felt, phys-778 779 iological responses to music, recognition accuracy, and the type of emotion felt) for each of the four intended emotions, we 780 computed a series of correlations. Because age was significantly 781 correlated with years of education, $r_{(34)} = -0.41$, p < 0.05, fluid 782 intelligence, $r_{(34)} = -0.48$, p < 0.05, working memory, $r_{(34)} =$ 783 -0.35, p < 0.05, and each of the five measures of auditory thresh-784 olds, $r_{(34)} = 0.56$, p < 0.001 for 500 Hz; $r_{(34)} = 0.54$, p < 0.001785 for 1000 Hz; $r_{(34)} = 0.61$, p < 0.001 for 2000 Hz; $r_{(34)} = 0.42$, 786 p < 0.05 for 4000 Hz; $r_{(34)} = 0.75$, p < 0.001 for 8000 Hz, these 787 variables were controlled for in partial correlations. Results indi-788 cated that the mean scores of hits, corrected recognition, and 789 d-prime for peaceful music were negatively and significantly 790 correlated with age, $r_{(34)} = -0.34$, p < 0.05 for hits, $r_{(34)} =$ 791 -0.51, p < 0.05 for corrected recognition, and $r_{(34)} = -0.53$, 792 p < 0.05 for d-prime. Similarly, age was negatively and signif-793 icantly correlated with the mean score of corrected recognition 794 and d-prime for happy music, $r_{(34)} = -0.69$, p < 0.001 for cor-795 rected recognition, and $r_{(34)} = -0.65$, p < 0.001 for d-prime, 796 while it was positively and significantly correlated with the mean 797 score of false alarms, $r_{(34)} = 0.63$, p < 0.001. Altogether, the data 798 indicated that the older the people are, the lower their ability to

discriminate studied positive musical excerpts conveying peace-799 800 fulness and happiness from unstudied ones. The mean score of Beta index for sad music was also positively and significantly cor-801 related with age, $r_{(34)} = 0.50$, p < 0.05, suggesting that the older 802 the people are, the more conservative they are to discriminate 803 studied stimuli from unstudied musical excerpts conveying sad-804 805 ness. Moreover, data indicated that the older the people are, the stronger their experience of sadness while listening to peaceful 806 music, $r_{(34)} = 0.46$, p < 0.05, and the weaker their experience of 807 fear while listening to scary music, $r_{(34)} = -0.49$, p < 0.05. No 808 other significant correlations were found. 809

811THE RELATIONSHIP BETWEEN EMOTION INTENSITY FELT, FACIAL812MUSCLE ACTIVITY, AND RECOGNITION PERFORMANCES

For each age group, we investigated to what extent the emotion 813 intensity felt during the first presentation of musical stimuli was 814 linked to the physiological responses as well as to the subsequent 815 cognitive performances on the incidental recognition task. The 816 relationship between physiological reactions and recognition per-817 formances was also examined. In younger adults, results indicated 818 that the stronger the emotion intensity felt in response to sad 819 music, the higher the hits, $r_{(14)} = 0.54$, p < 0.05. In older adults, 820 results showed that the stronger the emotion intensity felt for 821 happy music, the higher the false alarms, $r_{(14)} = 0.54$, p < 0.05. 822 No other significant correlations were found. 823

DISCUSSION

In this study, we investigated how the emotional experience as 826 well as memory recognition for musical excerpts eliciting four 827 different emotions (happiness, sadness, peacefulness, and fear) 828 may change with age. To this end, younger and older listeners 829 were asked to evaluate the intensity of the emotion felt while their 830 facial expressions (i.e., zygomatic and corrugator muscle activity) 831 were recorded. They were then instructed to perform an inciden-832 tal recognition task followed by another task in which they had 833 to assess for each musical excerpt to what extent they experienced 834 each of the four emotions. 835

As predicted, the results showed that, when presented with 836 happy music, older adults assessed the emotion felt as more 837 intense than their younger counterparts. The fact that older adults 838 rated their emotional experience as significantly more intense 839 for happy music stimuli in comparison to sad and scary music 840 stimuli is consistent with the literature showing that aging is asso-841 ciated with a relative preference for positivity over negativity. This 842 also supports the view that emotions and motivations cannot 843 be disentangled from each other. However, the assumption that 844 the stronger emotional experience reported by older adults while 845 listening to happy music would be reflected in a greater zygo-846 matic activity was not supported. Compared to younger adults, 847 older adults showed stronger facial expressions for both corruga-848 tor and zygomatic muscles as well as for all intended emotions. 849 This suggests that facial expressions are not exclusively aligned 850 with the emotional state, thus raising the question of whether 851 the general increase of facial expressiveness in older adults would 852 simply reflect a deeper engagement in the task. However and 853 interestingly, the current results also showed that older adults' 854 zygomatic activity, but not for young adults', varied as a func-855 tion of the intended emotions in such a way that older adults

showed an increased zygomatic activity for scary excerpts but not 856 for happy or peaceful ones. This is in line with the idea that the 857 reaction of smiling may serve as a defensive goal in inhibiting 858 negative feelings for older adults. It can also be argued that zygo-859 matic activity may reflect partial facial expression of fear, but then 860 there we should have observed a greater concomitant activity for 861 the corrugator muscle. However, this was not observed. Taken 862 together, these findings are consistent with the idea that older 863 adults' facial expressions possibly reflect an attempt to regulate 864 emotion. Further research is needed to substantiate the role 865 of voluntary facial expressions in the older adults' response to 866 emotions. 867

Consistent with our expectations, our findings indicated that 868 older adults correctly recognized less musical excerpts than their 869 younger counterparts. Moreover, older adults' range of perfor-870 mances was quite similar to that found by Kensinger (2008) with 871 emotional words. This suggests that modality has little impact on 872 the strength of the memory decline with aging. The results of the 873 present study also indicated that younger adults as well as older 874 adults better recognized negative and arousing musical excerpts 875 (i.e., scary music) than all other excepts while producing low 876 false alarms rates for these scary music stimuli. This corroborates 877 the hypothesis of an increased distinctiveness of negative stimuli 878 (e.g., Pesta et al., 2001) and extends previous studies that showed 879 that older adults can visually detect arousing and negative stimuli 880 as well as their younger counterparts (e.g., Magai et al., 2006; 881 Knight et al., 2007). Our findings also gave evidence for increased 882 false recognition for happy music stimuli in older adults but 883 not for young adults. We found a negative relationship between 884 age and the ability to discriminate between true and false happy 885 musical excerpts as well as a positive relationship between the 886 emotion intensity felt in older adults and their rate of false 887 alarms for happy stimuli. Taken together, these findings suggest 888 that positive emotion elicited by happy excerpts may produce 889 an attentional bias in older adults that can lead to confusion 890 between studied and non-studied excerpts and thus enhance 891 the probability of false alarms. Such increase in discrimination 892 threshold is consistent with previous studies showing that aging 893 was associated to a higher false response rate to positive words 894 (Fernandes et al., 2008; Piguet et al., 2008) and corroborates the 895 idea that the reduction of distinctiveness for positive information 896 in older adults would be the result of their liberal bias toward 897 positivity. However, in the present study, the positivity bias is 898 detrimental to memory accuracy. 899

Another main finding of the current research is that, when 900 presented with sad and scary musical excerpts, older adults 901 reported experiencing lower levels of sadness and fear than 902 their younger counterparts. Correlation analyses indicated that 903 the older the people are, the weaker their experience of fear 904 felt while listening to scary music. This fits nicely with pre-905 vious research demonstrating age-related changes in emotion 906 recognition (Laukka and Juslin, 2007; Lima and Castro, 2011) 907 and emotion perception (Vieillard et al., 2012) in music, and 908 extends these studies by showing these changes also occur when 909 participants are focused on their own emotional experience. 910 Interestingly, compared to Lima and Lima and Castro's (2011) 911 recognition paradigm, the personal engagement involved in the 912 current task seems to facilitate the older adults' ability to process

negative emotions. This is consistent with previous findings 913 914 demonstrating that older adults benefit more from instructions 915 encouraging to focus on emotion than on information acquisition (Mikels et al., 2010) and corroborates the view of an age-related 916 emphasis on emotion processing. Of course, further research is 917 needed to compare the older adults' responsiveness to musi-918 919 cal emotions in both contexts of recognition and of emotional experience. 920

Given the relatively short duration of the musical stimuli used 921 in the present study, one may argue that this could challenge their 922 ability to induce emotions, leading participants to rate their per-923 ceived emotions rather than their felt emotions. Although studies 924 aiming to induce felt emotions in listeners tend to use longer 925 excerpts than those investigating perceived emotions (Eerola and 926 Vuoskoski, 2013), we believe that the short excerpts used in our 927 experiment also successfully induced emotions. First of all, our 928 results indicated that participants reported moderate intensity of 929 the emotion felt along with significant differences in facial expres-930 931 sivity. Furthermore, previous findings demonstrated that musical excerpts as short as 13s may recruit neural mechanisms involved 932 in pleasant/unpleasant emotional responses (Blood et al., 1999). 933 In the study of Vieillard et al. (2008) which used similar 10s 934 musical excerpts recorded in a piano timbre, listeners better 935 recognized some intended emotions when focusing on their emo-936 tional experience rather than when focusing on the recognition of 937 the emotion. This suggests that asking participants to focus on felt 938 emotions increases the degree of personal engagement in musi-939 cal emotion even for short musical excerpts. Taken together, these 940 data corroborate the hypothesis that the musical emotions were 941 not only recognized, but indeed felt. 942

One limitation of this study is that we used a cross-sectional 970 design. Historical differences in the cultural system and in musical 971 exposure may have affected young and older adults' performances 972 differently. The observed age differences in emotional responses 973 to music might thus reflect a cohort effect rather than an age 974 effect. Future research would benefit from investigating this issue 975 more thoroughly. Nevertheless, our study suggests that emo-976 tional response to music and memory recognition for musical 977 excerpts conveying emotions show differences with advancing 978 age. These age-related differences are characterized by a stronger 979 emotional reactivity for happiness, an increased zygomatic activ-980 ity in response to scary stimuli, an increase in false recognition 981 for happy musical excerpts, and a decrease in responsiveness to 982 sad and scary music. This study extends previous findings and 983 expands them to music, a powerful channel of emotion commu-984 nication. Importantly, the findings suggest that aging may cause a 985 decrease in negative affects and an increase in positive affects even 986 when these affects are elicited by a more abstract source of emo-987 tion that does not refer to specific events. Finally, the current data 988 are in line with the hypothesis that older adults could use emo-989 tional coping skills acquired over the life span in order to avoid 990 potentially negative events and maintain positive ones (Charles 991 et al., 2001; Labouvie-Vief et al., 2010). 992 993
