# CONVEX PROJECTIVE GENERALIZED DEHN FILLING 

SUHYOUNG CHOI, GYE-SEON LEE, AND LUDOVIC MARQUIS


#### Abstract

In dimension $d=4,5,6,7$, we find the first examples of complete finite volume hyperbolic $d$-dimensional manifolds $M$ with cusps such that an infinite number of orbifolds $M_{m}$ obtained by generalized Dehn fillings on $M$ admit a properly convex real projective structure. The manifolds $M$ are covering of hyperbolic Coxeter orbifolds and the orbifold fundamental groups $\Gamma_{m}$ of $M_{m}$ are Gromov hyperbolic relative to a collection of subgroups virtually isomorphic to $\mathbb{Z}^{d-2}$.

## 1. Introduction

1.1. Motivation. Hyperbolic Dehn filling theorem proven by Thurston [Thu02] is a fundamental theorem of hyperbolic 3 -manifold theory. It states that if the interior of a compact 3 -manifold $M$ with toral boundaries admits a complete hyperbolic structure of finite volume, then except for finitely many Dehn fillings on each boundary component, all Dehn fillings of $M$ admit a hyperbolic structure.

Within the realm of hyperbolic geometry, this phenomenon happens only for 3-manifolds even though there are topological Dehn fillings for every compact $d$-manifold $M$ with a boundary which is homeomorphic to a ( $d-1$ )-dimensional torus $\mathbb{T}^{d-1}$. Let $\mathbb{D}^{n}$ be the closed $n$-ball. Since the compact $d$-manifold $\mathbb{D}^{2} \times \mathbb{T}^{d-2}$ has also a toral boundary, if we glue $M$ and $\mathbb{D}^{2} \times \mathbb{T}^{d-2}$ together along their boundaries, then we obtain a closed $d$-manifold, called a

[^0]Dehn filling of $M$. In a similar way we can deal with compact $d$-manifolds with several toral boundaries. Now even if we assume that the interior of $M$ admits a finite volume hyperbolic structure, no Dehn fillings of $M$ admit a hyperbolic structure when $d \geqslant 4$.

Although Dehn fillings in dimension bigger than 3 admit no hyperbolic structure, they can admit a geometric structure which is "larger" than a hyperbolic structure. A main aim of this article is to show that a real projective structure can be a good candidate for this purpose. In a similar spirit, Anderson [And06] and Bamler [Bam12] proved that many aspects of Dehn filling theory for hyperbolic 3 -manifolds can be generalized to Einstein metrics in every dimension. More precisely, if the interior of a compact $d$-manifold $M$ with toral boundaries admits a finite volume hyperbolic structure, then except for finitely many Dehn fillings on each boundary component, all Dehn fillings of $M$ admit Einstein metrics.

Let $\mathbb{S}^{d}$ be the $d$-dimensional projective sphere ${ }^{1}$ and note that the group $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ of linear automorphism of determinant $\pm 1$ is the group of projective automorphisms of $\mathbb{S}^{d}$. We say that a $d$-dimensional manifold $N$ admits a properly convex real projective structure if $N$ is homeomorphic to $\Omega / \Gamma$ with $\Omega$ a properly convex subset of $\mathbb{S}^{d}$ and $\Gamma$ a discrete subgroup of $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ acting properly discontinuously on $\Omega$. Now we can ask the following question:

Question 1.1. Is there a compact manifold $M$ of dimension $d \geqslant 4$ with toral boundaries such that the interior of $M$ admits a finite volume hyperbolic structure, and except for finitely many Dehn fillings on each boundary component, all Dehn fillings of $M$ admit a properly convex real projective structure?

We can generalize Question 1.1 only requiring the interior of $M$ to admit a properly convex real projective structure of finite volume.
1.2. Evidence. In this paper, we give an evidence towards a positive answer to Question 1.1. It is difficult for us to find such a manifold directly, and hence we begin with Coxeter orbifold, also called reflection orbifold or reflectofold (see Chapter 13 of Thurston [Thu02] for more precise definition of orbifold). The definition of Coxeter orbifold is somewhat more complicated than the definition of manifold, however it turns out that convex projective Coxeter orbifolds are easier to build than convex projective manifolds. The first examples towards Question 1.1 are hyperbolic Coxeter $d$-orbifolds for $d=4,5,6$.

Consider a convex polytope $P$ in the hyperbolic space $\mathbb{H}^{d}$ with dihedral angles submultiples of $\pi$, i.e. each dihedral angle is $\frac{\pi}{m}$ with an integer $m \geqslant 2$ or $m=\infty$. We call such a polytope a hyperbolic Coxeter polytope. The group $\Gamma$ generated by the reflections about the codimension one faces of $P$ is a discrete subgroup of the group Isom $\left(\mathbb{W}^{d}\right)$ of isometries of $\mathbb{M}^{d}$, which is isomorphic to $\mathrm{PO}_{d, 1}(\mathbb{R})$, and the quotient $\mathbb{H}^{d} / \Gamma$ is a hyperbolic Coxeter $d$-orbifold. Hyperbolic Coxeter orbifolds are useful objects that we can concretely construct. For example, the first example of a closed orientable hyperbolic 3-manifold is an eight-fold cover of a right-angled hyperbolic Coxeter 3-orbifold with 14 faces, which was constructed by Löbell in 1931 [Lob31].

By Andreev's theorems [And70a, And70b], there is a version of the Dehn filling theorem for hyperbolic Coxeter 3-orbifolds (see Chapter 7 of Vinberg-Shvartsman [VS93] and Proposition 2 of Kolpakov [Kol12]): Let $\mathcal{O}_{\infty}$ be a compact Coxeter 3 -orbifold with a boundary $\partial \mathcal{O}_{\infty}$ that is a closed Coxeter 2-orbifold admitting a Euclidean structure. A m-generalized Dehn filling $\mathcal{O}_{m}$ of $\mathcal{O}_{\infty}$, or simply a $m$-Dehn filling, is a closed Coxeter 3 -orbifold $\mathcal{O}_{m}$ such that $\mathcal{O}_{\infty}$ is orbifold diffeomorphic (see Davis [Dav14] or Wiemeler [Wie13]) to the complement of an open neighborhood of an edge $r$ of order $m^{2}$ of $\mathcal{O}_{m}$ (see Figure 1). Note that the existence of a $m$-Dehn filling implies that the boundary $\partial \mathcal{O}_{\infty}$ of $\mathcal{O}_{\infty}$ must be a rectangle with 4 corner reflectors of order 2.

A corollary of Andreev's theorems says that if the interior of $\mathcal{O}_{\infty}$ admits a hyperbolic structure of finite volume, then there exists a natural number $N$ such that, for each $m>N$, the 3 -orbifolds $\mathcal{O}_{m}$ admit a hyperbolic structure.

Now we can state the main theorem of the paper: let $\mathcal{O}_{\infty}$ be a compact Coxeter $d$-orbifold with a boundary $\partial \mathcal{O}_{\infty}$ that is a closed Coxeter $(d-1)$-orbifold admitting a Euclidean structure. A m-Dehn filling $\mathcal{O}_{m}$ of $\mathcal{O}_{\infty}$ is a Coxeter $d$-orbifold such that $\mathcal{O}_{\infty}$ is orbifold diffeomorphic to the complement of an open neighborhood of a face $r$ of codimension 2 of $\mathcal{O}_{m}$, and each interior point of $r$ has a neighborhood modeled on $\left(\mathbb{R}^{2} / D_{m}\right) \times \mathbb{R}^{d-2}$. We abbreviate a connected open set to a domain.

Theorem A. In dimension $d=4,5,6$ (resp. $d=7$ ), there exists a complete finite volume hyperbolic Coxeter d-orbifold $\mathcal{O}_{\infty}$ with orbifold fundamental group $W_{\infty}$ and holonomy representation $\rho_{\infty}: W_{\infty} \rightarrow \mathrm{O}_{d, 1}(\mathbb{R}) \subset \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ such that there is a natural number $N$ and a sequence of

representations

$$
\left(\rho_{m}: W_{\infty} \rightarrow \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})\right)_{m>N}

satisfying the following:

- The image $\rho_{m}\left(W_{\infty}\right)$ is a discrete subgroup of $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ acting properly discontinuously and cocompactly (resp. with finite covolume) on the unique $\rho_{m}\left(W_{\infty}\right)$-invariant properly convex domain $\Omega_{m} \subset \mathbb{S}^{d}$.
- The induced representation $W_{\infty} / \operatorname{ker}\left(\rho_{m}\right) \rightarrow \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ is the holonomy representation of a properly convex real projective structure on a Dehn filling $\mathcal{O}_{m}$ of $\mathcal{O}_{\infty}$.
- The representations $\left(\rho_{m}\right)_{m>N}$ converge algebraically to $\rho_{\infty}$.
- The convex domains $\left(\Omega_{m}\right)_{m>N}$ converge to $\Omega_{\infty}=\mathbb{H}^{d} \subset \mathbb{S}^{d}$ in the Hausdorff topology.

Remark 1.2. The authors conjecture that the sequence $\left(\mathcal{O}_{m}\right)_{m}$ of convex projective orbifolds with Hilbert metrics converge to the convex projective orbifold $\mathcal{O}_{\infty}$ in the Gromov-Hausdorff topology.

Remark 1.3. The Coxeter orbifolds $\mathcal{O}_{\infty}$ whose orbifold fundamental groups are the Coxeter groups in Table 1 (assuming $j \neq 5, p, q=3$ and by setting $m=\infty$ ) are "prime" examples satisfying Theorem A. We describe in Section 9 how to build infinitely many Coxeter orbifolds $\mathcal{O}_{\infty}$ satisfying Theorem A using a gluing procedure and the Coxeter groups of Table 1 given by setting $j=5$ or $p=5$. However, this gluing trick can be applied only in dimension 4 and 5 .

Remark 1.4. The reader might wonder what "prime" means in this paper. As an ad-hoc definition, a Coxeter $d$-orbifold is prime if it arises from a $d$-polytope with $d+2$ faces of codimension 1 , or as a bit more interesting definition, if it cannot be obtained by the gluing procedure described in Section 9.

In Theorem A , changing the target Lie group of representations from $\mathrm{O}_{d, 1}(\mathbb{R})$ to $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ is essential because of the following theorem:

Theorem 1.5 (Garland and Raghunathan [GR70]). Let $d$ be an integer strictly bigger than 3. Assume that $\Gamma$ is a lattice in $\mathrm{O}_{d, 1}(\mathbb{R})$ and $\rho_{\infty}: \Gamma \rightarrow \mathrm{O}_{d, 1}(\mathbb{R})$ is the canonical inclusion. Then there is a neighborhood $U$ of $\rho_{\infty}$ in $\operatorname{Hom}\left(\Gamma, \mathrm{O}_{d, 1}(\mathbb{R})\right)$ such that every $\rho \in U$ is conjugate to $\rho_{\infty}$.

In other words, every sufficiently small deformation of $\rho_{\infty}$ in $\operatorname{Hom}\left(\Gamma, \mathrm{O}_{d, 1}(\mathbb{R})\right)$ is trivial (see also Bergeron and Gelander [BG04] for an alternative proof).

By Selberg's lemma, Theorem A also allows us to find properly convex projective structures on Dehn fillings of a manifold:

Theorem B. In dimension $d=4,5,6$, there exists a finite volume hyperbolic d-manifold $M_{\infty}$ such that an infinite number of closed d-orbifolds $M_{m}$ obtained by Dehn fillings of $M_{\infty}$ admit properly convex real projective structures. Moreover, the singular locus of $M_{m}$ is the union of disjoint (d-2)-dimensional tori, and hence the orbifold fundamental group of $M_{m}$ is not Gromov hyperbolic.
1.3. Another novelty of the examples in Theorem A. A properly convex domain $\Omega$ in $\mathbb{S}^{d}$ is divisible if there exists a discrete subgroup $\Gamma$ of $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ such that $\Gamma$ preserves $\Omega$ and the quotient $\Omega / \Gamma$ is compact. In that case, we say that $\Gamma$ divides $\Omega$. We call $\Omega$ decomposable if there exist non-empty closed convex subsets $A, B \subset \mathbb{S}^{d}$ such that the spans of $A$ and $B$ are disjoint and the convex hull of $A \cup B$ is the closure $\bar{\Omega}$ of $\Omega$. Otherwise, $\Omega$ is called indecomposable.

Divisible strictly convex domains exist in every dimension (see [Ben04a], even better for a construction of divisible strictly convex domains of dimension $d \geqslant 4$ not quasi-isometric to the real hyperbolic space, see [Kap07] or [Ben06b] for $d=4$ ). On the other hand, the existence of indecomposable divisible properly convex domains of every dimension $d$ which are not strictly convex is still an open question.

At the time of writing this paper, the only known examples of indecomposable divisible properly convex domains which are not strictly convex are the examples introduced by Benoist [Ben06a] in dimension $d=3, \ldots, 7$. The construction of Benoist has been explored by the third author in [Mar10] and by the second author with Ballas and Danciger in [BDL15], both in dimension $d=3$. Afterwards, the authors [CLM] study further this kind of examples in dimension $d=4, \ldots, 7$. Moreover, the construction in this paper is inspired by the work of Benoist [Ben06b].

The difference between the previously known examples and the examples in Theorem A can be visually seen from the notion of properly embedded simplex of dimension $e$ (shorten to $e$-simplex). A simplex $\Delta$ is properly embedded in a properly convex domain $\Omega$ if $\Delta \subset \Omega$ and $\partial \Delta \subset \partial \Omega$. A properly embedded $e$-simplex $\Delta$ of a convex domain $\Omega$ is tight if $\Delta$ is not included in a $e^{\prime}$-properly embedded simplex $\Delta^{\prime}$ of $\Omega$ with $e^{\prime}>e$.

All the pairs ( $\Gamma, \Omega$ ) built in [Ben06a, Mar10, BDL15, CLM], assuming that $\Gamma$ divides $\Omega$, satisfy the following properties:

- The $d$-dimensional convex domain $\Omega$ contains a properly embedded ( $d-1$ )-simplex.
- The group $\Gamma$ is Gromov hyperbolic relative to a finite collection of subgroups of $\Gamma$ virtually isomorphic to $\mathbb{Z}^{d-1}$.
- The quotient orbifold $\Omega / \Gamma$ is homeomorphic to the union along the boundaries of finitely many $d$-orbifolds each of which admits a finite volume hyperbolic structure on its interior.

Theorem C. Assume that $d=4,5,6, \Gamma=\rho_{m}\left(W_{\infty}\right)$ and $\Omega=\Omega_{m}$ in Theorem A. Then $(\Gamma, \Omega)$ satisfies the following:

- The d-dimensional convex domain $\Omega$ contains a properly embedded tight (d-2)simplex.
- The group $\Gamma$ is Gromov hyperbolic relative to a finite collection of subgroups virtually isomorphic to $\mathbb{Z}^{d-2}$.
- The quotient orbifold $\Omega / \Gamma$ is not homeomorphic to the union along the boundaries of finitely many d-orbifolds each of which admits a finite volume hyperbolic structure on its interior.

The computations involved in the proof of Theorem A in fact easily extend to give a two (small) new families of pairs $(\Gamma, \Omega)$ (see the Coxeter graphs in Table 2 for Theorem D and Table 3 for Theorem E).

Theorem D. For each $(d, e) \in\{(5,2),(6,2),(7,3),(8,4)\}$, there exists a discrete group $\Gamma \subset$ $\mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ which divides $\Omega \subset \mathbb{S}^{d}$ such that:

- The d-dimensional convex domain $\Omega$ contains a properly embedded tight e-simplex.
- The group Г is Gromov hyperbolic relative to a finite collection of subgroups virtually isomorphic to $\mathbb{Z}^{e}$.
- The quotient orbifold $\Omega / \Gamma$ is not homeomorphic to the union along the boundaries of finitely many d-orbifolds each of which admits a finite volume hyperbolic structure on its interior.

Theorem E. For each $d=5,6$, there exists a discrete group $\Gamma \subset \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ which divides $\Omega \subset \mathbb{S}^{d}$ such that:

- The d-dimensional convex domain $\Omega$ contains a properly embedded tight (d-2)simplex and a properly embedded tight triangle.
- The group Г is Gromov hyperbolic relative to a finite collection of subgroups virtually isomorphic to $\mathbb{Z}^{2}$ and $\mathbb{Z}^{d-2}$.
- The quotient orbifold $\Omega / \Gamma$ is not homeomorphic to the union along the boundaries of finitely many d-orbifolds each of which admits a finite volume hyperbolic structure on its interior.

Finally, we would like to propose the following question:
Question 1.6. For which integers $\left(d, m, e_{1}, \ldots, e_{m}\right)$ with $m \geqslant 1$ and $2 \leqslant e_{1}<e_{2}<\cdots<e_{m} \leqslant d-1$, is there ad-dimensional divisible convex domain $\Omega \subset \mathbb{S}^{d}$ which contains a properly embedded tight $e_{i}$-simplex for all $i=1, \ldots, m$ ?

## 2. Preliminary

2.1. Coxeter groups. A Coxeter system is a pair $(S, M)$ of a finite set $S$ and a symmetric matrix $M=\left(M_{s t}\right)_{s, t \in S}$ whose diagonal entries $M_{s s}=1$ and whose off-diagonal entries $M_{s t} \in\{2,3, \ldots, m, \ldots, \infty\}$. To a Coxeter system $(S, M)$ we can associate a Coxeter group, denoted by $W_{S}$ (or simply $W$ ): the group generated by $S$ with the relations $(s t)^{M_{s t}}=1$ for every $(s, t) \in S \times S$ such that $M_{s t} \neq \infty$. The rank of $W$ is the cardinality $|S|$ of $S$.

The Coxeter diagram (or Coxeter graph) of $W$ is a labeled graph, also denoted by $W$, such that the set of vertices of $W$ is $S$, an edge $\overline{s t}$ connects two vertices $s, t \in S$ if and only if $M_{s t} \neq 2$,
and the label of the edge $\overline{s t}$ is $M_{s t} \in\{3, \ldots, m, \ldots, \infty\}$. A Coxeter group $W$ is irreducible if the Coxeter graph $W$ is connected. The Gram matrix of $W$, denoted by $\operatorname{Cos}(W)$, is an $|S| \times|S|$ symmetric matrix whose entries are given by

$$
(\operatorname{Cos}(W))_{s t}=-2 \cos \left(\frac{\pi}{M_{s t}}\right) \quad \text { for every } s, t \in S
$$

An irreducible Coxeter group $W$ (or a connected Coxeter graph $W$ ) is spherical (resp. affine or Lannér) if for every $s \in S$, the $(s, s)$-minor of $\operatorname{Cos}(W)$ is positive definite and the determinant of $\operatorname{Cos}(W)$ is positive (resp. zero or negative). If an irreducible Coxeter group $W$ is not spherical nor affine, then $W$ is large, i.e. there is a homomorphism of a finite index subgroup of $W$ onto a non-abelian free group (see Margulis-Vinberg [MV00]). Remark that an irreducible affine Coxeter group is virtually $\mathbb{Z}^{|S|-1}$. A Coxeter graph $W$ (or a Coxeter group $W$ ) is called spherical (resp. affine) if each connected component of $W$ is spherical (resp. affine). Note that a Coxeter group $W$ is spherical if and only if $W$ is a finite group.

We refer to Appendix A for the list of all the irreducible spherical, irreducible affine and Lannér Coxeter groups, which we will use frequently.
2.2. Coxeter polytopes. Let $V$ be a $(d+1)$-dimensional vector space over $\mathbb{R}$, and let $\mathbb{S}(V)$ be the projective sphere, i.e. the space of half-lines in $V$. In order to indicate the dimension of $\mathbb{S}(V)$, we use the notation $\mathbb{S}^{d}$ instead of $\mathbb{S}(V)$. Denote by $\mathrm{SL}^{ \pm}(V)$ (resp. $\mathrm{SL}(V)$ ) the group of matrices with determinant $\pm 1$ (resp. 1). The projective sphere $\mathbb{S}(V)$ and $\mathrm{SL}^{ \pm}(V)$ are two-fold covers of the real projective space $\mathbb{P}(V)$ and the group $\operatorname{PGL}(V)$ of projective transformations of $V$, respectively.

The natural projection of $V \backslash\{0\}$ onto $\mathbb{S}(V)$ is denoted by $\mathbb{S}$, and for every subspace $W$ of $V, \mathbb{S}(W)$ denotes $\mathbb{S}(W \backslash\{0\})$ for the simplicity of the notation. A subset $P$ of $\mathbb{S}(V)$ is convex if for every 2 -dimensional subspace $\Pi$ of $V, P \cap \mathbb{S}(\Pi)$ is connected, and moreover a convex subset $P$ is properly convex if the closure $\bar{P}$ of $P$ does not contain a pair of antipodal points. In other words, $P$ is properly convex if and only if there is an affine chart $\mathbb{A}$ of $\mathbb{S}(V)$ such that $\bar{P} \subset \mathbb{A}$ and $P$ is convex in $\mathbb{A}$ in the usual sense. A properly convex set $P$ is strictly convex if there is no nontrivial segment in the boundary $\partial P$ of $P$.

A projective polytope is a properly convex subset $P$ of $\mathbb{S}(V)$ such that $P$ has a non-empty interior and

$$
P=\bigcap_{i=1}^{r} \mathbb{S}\left(\left\{v \in V \mid \alpha_{i}(v) \leqslant 0\right\}\right)
$$

where $\alpha_{i}, i=1, \ldots, r$, are linear forms on $V$. We always assume that the set of linear forms is minimal, i.e. none of the half spaces $\mathbb{S}\left(\left\{v \in V \mid \alpha_{i}(v) \leqslant 0\right\}\right)$ contains the intersection of all the others. A facet (resp. ridge) of a polytope is a face of codimension 1 (resp. 2). Two facets $s, t$ of a polytope $P$ are adjacent if $s \cap t$ is a ridge of $P$.

A projective reflection is an element of $\mathrm{SL}^{ \pm}(V)$ of order 2 which is the identity on a hyperplane. Each projective reflection $\sigma$ can be written as:

$$
\sigma=\operatorname{Id}-\alpha \otimes b
$$

where $\alpha$ is a linear form on $V$ and $b$ is a vector in $V$ such that $\alpha(b)=2$. The projective hyperplane $\mathbb{S}(\operatorname{ker}(\alpha))$ is the support of $\sigma$ and the half-line $\mathbb{S}(b)$ the polar of $\sigma$. A projective rotation is an element of $\operatorname{SL}(V)$ which is the identity on a subspace $H$ of codimension 2 and which is conjugate to a matrix $\left(\begin{array}{c}\cos \theta-\sin \theta \\ \sin \theta \\ \cos \theta\end{array}\right)$ on $V / H$ with $0<\theta<2 \pi$. The real number $\theta$ is called the angle of rotation.

A mirror polytope is a pair of a projective polytope $P$ of $\mathbb{S}(V)$ and a finite number of projective reflections $\left(\sigma_{s}=\operatorname{Id}-\alpha_{s} \otimes b_{s}\right)_{s \in S}$ with $\alpha_{s}\left(b_{s}\right)=2$ such that:

- The index set $S$ consists of all the facets of $P$.
- For each facet $s \in S$, the support of $\sigma_{s}$ is the supporting hyperplane of $s$.
- For every two distinct facets $s, t$ of $P, \alpha_{s}\left(b_{t}\right)$ and $\alpha_{t}\left(b_{s}\right)$ are either both negative or both zero, and $\alpha_{s}\left(b_{t}\right) \alpha_{t}\left(b_{s}\right) \geqslant 4$ or $=4 \cos ^{2} \theta$ with $0<\theta \leqslant \frac{\pi}{2}$.
In fact, $\alpha_{s}\left(b_{t}\right) \alpha_{t}\left(b_{s}\right)=4 \cos ^{2} \theta$ if and only if the product $\sigma_{s} \sigma_{t}$ is a rotation of angle $2 \theta$. Remark that the definition of mirror polytope does not come out of the blue: It is motivated by Tits-Vinberg's Theorem 2.1 (see Proposition 6 of Vinberg [Vin71] or Lemma 1.2 of Benoist [Ben04b] for more details).

The dihedral angle of a ridge $s \cap t$ of a mirror polytope $P$ is $\theta$ if $\sigma_{s} \sigma_{t}$ is a rotation of angle $2 \theta$, and 0 otherwise. A Coxeter polytope is a mirror polytope whose dihedral angles are 0 or submultiples of $\pi$. If $P$ is a Coxeter polytope, then the Coxeter system of $P$ is the Coxeter system ( $S, M$ ) such that $S$ is the set of facets of $P$ and for every two distinct facets $s, t$ of $S, M_{s t}=m_{s t}$ if $\sigma_{s} \sigma_{t}$ is a rotation of angle $\frac{2 \pi}{m_{s t}}$, and $M_{s t}=\infty$ otherwise. We denote by $W_{P}$ (or simply $W$ ) the Coxeter group of $P$, and we call $P$ irreducible if $W_{P}$ is irreducible.
2.3. Tits's simplex. To a Coxeter group $W$, we can associate a Coxeter polytope $\Delta_{W}$. The polytope $\Delta_{W}$ is a simplex of dimension the rank of $W$ minus 1 and the Coxeter group of $\Delta_{W}$ is $W$.

Consider the vector space $V=\left(\mathbb{R}^{S}\right)^{*}$ and denote by $\left(e_{s}\right)_{s \in S}$ the canonical basis of $\mathbb{R}^{S}$. The simplex we want to obtain is the projectivization $P=\mathbb{S}(\mathcal{C})$ of the simplicial cone $\mathcal{C}=\{\varphi \in$ $\left.\left(\mathbb{R}^{S}\right)^{*} \mid \varphi\left(e_{s}\right) \leqslant 0, \forall s \in S\right\}$. For each element $s \in S$, the reflection about the facet $P \cap \mathbb{S}(\{\varphi \in$ $\left.\left.\left(\mathbb{R}^{S}\right)^{*} \mid \varphi\left(e_{s}\right)=0\right\}\right)$ is defined by the formula $\sigma_{s}(\varphi)=\varphi-2 \varphi\left(e_{s}\right) B_{W}\left(e_{s}, \cdot\right)$, where $B_{W}$ is the symmetric bilinear form given by $B_{W}\left(e_{s}, e_{t}\right)=-2 \cos \left(\frac{\pi}{M_{s t}}\right)$. The matrix $\left(B_{W}\left(e_{s}, e_{t}\right)\right)_{s, t \in S}$ is the matrix of Tits bilinear form of $W$, and the resulting Coxeter polytope is the Tits simplex $\Delta_{W}$ of $W$. Remark that the group generated by the reflections $\sigma_{s}$ preserves the symmetric bilinear form $B_{W}$.
2.4. Tits-Vinberg's Theorem. Let $(S, M)$ be a Coxeter system. For each subset $S^{\prime}$ of $S$, we consider the Coxeter group $W_{S^{\prime}}$ of the Coxeter subsystem ( $S^{\prime}, M^{\prime}$ ), where $M^{\prime}$ is the restriction of $M$ to $S^{\prime}$. Theorem 2.1 shows that the natural homomorphism $W_{S^{\prime}} \rightarrow W_{S}$ is injective, and therefore $W_{S^{\prime}}$ can be identified with the subgroup of $W_{S}$ generated by $S^{\prime}$. These subgroups $W_{S^{\prime}}$ are called standard subgroups of $W_{S}$. If $P$ is a Coxeter polytope and $f$ is a proper face of $P$ (i.e. $f \neq \varnothing, P$ ), then we write $S_{f}=\{s \in S \mid f \subset s\}$ and $W_{f}:=W_{S_{f}}$.

Theorem 2.1 (Chapter V of Tits [Bou68] for Tits simplex, and Vinberg [Vin71]). Let $P$ be a Coxeter polytope of $\mathbb{S}(V)$ with Coxeter group $W_{P}$ and let $\Gamma_{P}$ be the subgroup of $\mathrm{SL}^{ \pm}(V)$ generated by the projective reflections $\left(\sigma_{s}\right)_{s \in S}$. Then:

- The homomorphism $\sigma: W_{P} \rightarrow \Gamma_{P}$ defined by $\sigma(s)=\sigma_{s}$ is an isomorphism.
$\therefore$ The family of polytopes $(\gamma(P))_{\gamma \in \Gamma_{P}}$ is a tilling of a convex subset $\mathcal{C}_{P}$ of $\mathbb{S}(V)$.
$\therefore$ The group $\Gamma_{P}$ is a discrete subgroup of $\mathrm{SL}^{ \pm}(V)$ acting properly discontinuously on the interior $\Omega_{P}$ of $\mathcal{C}_{P}$.
$\because$ An open proper face $f$ of $P$ lies in $\Omega_{P}$ if and only if the Coxeter group $W_{f}$ is finite.
We call $\Gamma_{P}$ the projective Coxeter group of $P$. Theorem 2.1 tells us that $\Omega_{P}$ is a convex domain of $\mathbb{S}(V)$ and $\Omega_{P} / \Gamma_{P}$ is a convex real projective Coxeter orbifold.
2.5. The link of a Coxeter polytope at a vertex. Given a mirror polytope $P$ of dimension $d$ in $\mathbb{S}^{d}$, we can associate to a vertex $v$ of $P$ a new mirror polytope $P_{v}$ of dimension $d-1$ which is " $P$ seen from $v$ ". We call $P_{v}$ the link of $P$ at $v$. In order to build $P_{v}$, first, look at the projective sphere $\mathbb{S}_{v}=\mathbb{S}\left(\mathbb{R}^{d+1} /\langle v\rangle\right)$, where $\langle v\rangle$ is the subspace spanned by $v$, and second, observe that the reflections $\left(\sigma_{s}\right)_{s \in S_{v}}$ induce reflections on $\mathbb{S}_{v}$. Finally, we can construct a projective polytope in $\mathbb{S}_{v}$ :

$$
\bigcap_{s \in S_{v}} \mathbb{S}\left(\left\{x \in \mathbb{R}^{d+1} \mid \alpha_{s}(x) \leqslant 0\right\} /\langle v\rangle\right) .
$$

This projective polytope together with the reflections induced by $\left(\sigma_{s}\right)_{s \in S_{v}}$ on $\mathbb{S}_{v}$ give us the link $P_{v}$ of $P$ at $v$, which is a mirror polytope of dimension $d-1$. It is obvious that if $P$ is a Coxeter polytope, then $P_{v}$ is also a Coxeter polytope. Note that if $W_{v}$ denotes $W_{P_{v}}$, then the Coxeter graph $W_{v}$ is obtained from the Coxeter graph $W_{P}$ by keeping only the vertices in $S_{v}$ and the edges connecting two vertices of $S_{v}$.
2.6. The Cartan matrix of a Coxeter polytope. An $m \times m$ matrix $A=\left(a_{i j}\right)_{i, j=1, \ldots, m}$ is a Cartan matrix if every diagonal entry of $A$ is 2 , every off-diagonal entry is negative or zero, and for all $i, j=1, \ldots, m, a_{i j}=0$ if and only if $a_{j i}=0$.

A Cartan matrix $A$ is irreducible if there are no simultaneous permutations of the rows and the columns of $A$ such that $A$ is a non-trivial block diagonal matrix, i.e. it is not a direct sum of two matrices. Every Cartan matrix $A$ decomposes into a direct sum of irreducible matrices, which are called the components of $A$. By Perron-Frobenius theorem, an irreducible Cartan matrix $A$ has a real eigenvalue. An irreducible Cartan matrix $A$ is of positive type, zero type or negative type when the smallest real eigenvalue of $A$ is positive, zero or negative, respectively. If $A^{+}$(resp. $A^{0}, A^{-}$) denotes the direct sum of the components of positive (resp. zero, negative) type of a Cartan matrix $A$, then $A=A^{+} \oplus A^{0} \oplus A^{-}$, i.e. the direct sum of $A^{+}$, $A^{0}$ and $A^{-}$.

For each Coxeter polytope $P$, we can define the Cartan matrix $A_{P}$ of $P$ by $\left(A_{P}\right)_{s t}=\alpha_{s}\left(b_{t}\right)$. Note that $A_{P}$ is irreducible if and only if $P$ is irreducible. The pairs $\left(\alpha_{s}, b_{s}\right)_{s \in S}$ that determine the Coxeter polytope $P$ are unique up to the action of $|S|$ positive numbers $\left(\lambda_{s}\right)_{s \in S}$ given by:

$$
\begin{equation*}
\left(\alpha_{s}, b_{s}\right)_{s \in S} \mapsto\left(\lambda_{s} \alpha_{s}, \lambda_{s}^{-1} b_{s}\right)_{s \in S} \tag{1}
\end{equation*}
$$

This leads to define an equivalence relation on Cartan matrices: Two Cartan matrices $A$ and $A^{\prime}$ are equivalent if there exists a positive diagonal matrix $D$ such that $A^{\prime}=D A D^{-1}$. We denote by $[A]$ the equivalence class of the Cartan matrix $A$.

For every sequence $\left(s_{1}, \ldots, s_{k}\right)$ of elements of $S$, the number $A_{s_{1} s_{2}} A_{s_{2} s_{3}} \cdots A_{s_{k} s_{1}}$ is independent of the choice of a Cartan matrix in the class [A]. These invariants are called the cyclic products of $A$, which determine [A] (see Proposition 16 of [Vin71]). The importance of Cartan matrix can be seen from:

Theorem 2.2. [Corollary 1 of Vinberg [Vin71]] Let A be an irreducible Cartan matrix of negative type and of rank $d+1$. Then there exists a mirror polytope $P$ of dimension $d$ such that $A_{P}=A$. Moreover, $P$ is unique up to conjugations by $\mathrm{SL}^{ \pm}(V)$.
2.7. Elliptic and Parabolic Coxeter polytopes. A Coxeter polytope $P$ is elliptic (resp. parabolic) if the projective Coxeter group $\Gamma_{P}$ of $P$ is derived from a discrete cocompact group generated by reflections in the sphere (resp. the Euclidean space). These polytopes were classified by Coxeter:

Theorem 2.3 (Coxeter [Cox49] and Propositions 21 and 22 of Vinberg [Vin71]). Let $P$ be a Coxeter polytope with Coxeter group $W$. Then $P$ is elliptic if and only if $A_{P}=A_{P}^{+}$. If this is the case, then $P$ is isomorphic to the Tits simplex $\Delta_{W}$.

In order to describe parabolic Coxeter polytopes, we need to introduce a notation: If $W$ is an irreducible affine Coxeter group, then $\Omega_{\Delta_{W}}$ is an affine chart of dimension $\operatorname{rank}(W)-1$ on which $W$ acts properly and cocompactly, and $W$ preserves an Euclidean norm on $\Omega_{\Delta_{W}}$ induced by the Tits bilinear form $B_{W}$. Now let $W$ be an affine Coxeter group. If we write $W=W_{1} \times \cdots \times W_{r}$ the decomposition of $W$ into irreducible components, then

$$
\hat{\Delta}_{W}:=\Delta_{W_{1}} \times \cdots \times \Delta_{W_{r}} \subset \Omega_{\Delta_{W_{1}}} \times \cdots \times \Omega_{\Delta_{W_{r}}}
$$

is a Coxeter polytope in the Euclidean space $\mathbb{E}^{e}$ of dimension $e=\operatorname{rank}(W)-r$, where the symbol $\times$ stands for the usual Cartesian product. The Euclidean norm on the affine space $\Omega_{\Delta_{W_{1}}} \times \cdots \times \Omega_{\Delta_{W_{r}}}$ is the product of the Euclidean norms of the factors, and the action of $W$ on $\mathbb{E}^{e}$ is again proper and cocompact.

Theorem 2.4 (Coxeter [Cox49] and Propositions 21 and 23 of Vinberg [Vin71]). Let $P$ be a Coxeter polytope of dimension $d$ with Coxeter group $W$. Then $P$ is parabolic if and only if $A_{P}=A_{P}^{0}$ and $A_{P}$ is of rank d. If this is the case, then $P$ is isomorphic to $\hat{\Delta}_{W}$.
2.8. Hilbert geometry. A Coxeter polytope $P$ of $\mathbb{S}^{d}$ is said to be loxodromic if $A_{P}=A_{P}^{-}$and of rank $d+1$. Before going any further, we remark that if $P$ is an irreducible loxodromic Coxeter polytope of dimension $d$, then the representation $\sigma: W_{P} \rightarrow \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ in Theorem 2.1 is irreducible and the convex domain $\Omega_{P}$ is properly convex (see Lemma 15 of Vinberg [Vin71]). This situation leads us to study Hilbert geometry.

Given a properly convex domain $\Omega$, we can use the cross-ratio to define a metric $d_{\Omega}$ on $\Omega$ : For any two distinct points $x, y$ in $\Omega$, the line $l$ passing through $x$ and $y$ meets the boundary $\partial \Omega$ of $\Omega$ in two other points $p$ and $q$. Assume that $p$ and $y$ separate $x$ and $q$ on the line $l$ (see

Figure 2). The Hilbert metric $d_{\Omega}: \Omega \times \Omega \rightarrow[0,+\infty)$ is defined by:

$$
d_{\Omega}(x, y)=\frac{1}{2} \log ([p: x: y: q]) \quad \text { for every } x, y \in \Omega
$$

where $[p: x: y: q]$ is the cross-ratio of the points $p, x, y, q$. The metric topology of $\Omega$ is the same as the one inherited from $\mathbb{S}(V)$. The metric space $\left(\Omega, d_{\Omega}\right)$ is complete, the closed balls are compact, the group $\operatorname{Aut}(\Omega)$ of projective transformations that preserve $\Omega$ acts by isometries on $\Omega$, and therefore acts properly.


Figure 2. The Hilbert metric

The Hilbert metric comes from a Finsler norm on $\Omega$, and this Finsler metric gives rise to an absolutely continuous measure $\mu_{\Omega}$ with respect to Lebesgue measure, called the Busemann measure. We refer to de la Harpe [dlH93] or Vernicos [Ver05] for more details on Hilbert geometry.
2.9. Perfect, quasi-perfect and 2-perfect Coxeter polytope. Vinberg [Vin71] also shows that if $P$ is a Coxeter polytope, then the following are equivalent:

- For every vertex $v$ of $P$, the standard subgroup $W_{v}$ of $W$ is finite.
- The convex subset $\mathcal{C}_{P}$ of $\mathbb{S}(V)$ is open, i.e. $\mathcal{C}_{P}=\Omega_{P}$.
- The action of $\Gamma_{P}$ on $\Omega_{P}$ is cocompact.

Following him, we call such a Coxeter polytope $P$ perfect (see Definition 8 of [Vin71]). It is known that a perfect Coxeter polytope is either elliptic, parabolic, or irreducible loxodromic (see Proposition 26 of [Vin71]).

A Coxeter polytope $P$ is 2-perfect if every vertex link of $P$ is perfect, and it is quasi-perfect if every vertex link of $P$ is either elliptic or parabolic. It is obvious that a quasi-perfect Coxeter polytope is 2 -perfect. In order to describe the geometric property of 2 -perfect projective Coxeter groups, we introduce the following terminology: Let $C\left(\Lambda_{P}\right)$ be the convex hull of the limit set ${ }^{3} \Lambda_{P}$ of $\Gamma_{P}$. The action of $\Gamma_{P}$ on $\Omega_{P}$ is geometrically finite if $\mu_{\Omega_{P}}\left(C\left(\Lambda_{P}\right) \cap P\right)<\infty$, finite covolume if $\mu_{\Omega_{P}}(P)<\infty$, and convex-cocompact if $C\left(\Lambda_{P}\right) \cap P \subset \Omega_{P}$.

Theorem 2.5 (Theorem A, Marquis [Mar14]). Let P be an irreducible, loxodromic, 2-perfect Coxeter polytope, let $\Gamma_{P}$ be the projective Coxeter group of $P$, and let $\Omega_{P}$ be the interior of the $\Gamma$-orbit of $P$. Then the action of $\Gamma_{P}$ on $\Omega_{P}$ is

[^3]- geometrically finite,
$\therefore$ finite covolume if and only if $P$ is quasi-perfect,
$\therefore$ convex-cocompact if and only if every vertex link of $P$ is elliptic or loxodromic.
2.10. Deformation spaces of marked Coxeter polytopes. Two projective polytopes $\mathcal{G}$ and $\mathcal{G}^{\prime}$ are combinatorially equivalent if there exists a bijection $\delta$ between the set $\mathcal{F}$ of all faces of $\mathcal{G}$ and the set $\mathcal{F}^{\prime}$ of all faces of $\mathcal{G}^{\prime}$ such that $\delta$ preserves the inclusion relation, i.e. for every $F_{1}, F_{2} \in \mathcal{F}, F_{1} \subset F_{2}$ if and only if $\delta\left(F_{1}\right) \subset \delta\left(F_{2}\right)$. We call $\delta$ a lattice isomorphism between $\mathcal{G}$ and $\mathcal{G}^{\prime}$. A combinatorial polytope is a combinatorial equivalence class of polytopes. A labeled polytope is a pair of a combinatorial polytope $\mathcal{G}$ and a ridge labeling on $\mathcal{G}$, which is a function of the set of the ridges of $\mathcal{G}$ to $\left\{\left.\frac{\pi}{m} \right\rvert\, m=2,3, \ldots, \infty\right\}$.

Let $\mathcal{G}$ be a labeled $d$-polytope. A marked Coxeter polytope realizing $\mathcal{G}$ is a pair of a Coxeter $d$-polytope $P$ of $\mathbb{S}^{d}$ and a lattice isomorphism $\phi$ between $\mathcal{G}$ and $P$ such that the label of each ridge $r$ of $\mathcal{G}$ is the dihedral angle of the ridge $\phi(r)$ of $P$. Two marked Coxeter polytopes $(P, \phi$ : $\mathcal{G} \rightarrow P)$ and ( $P^{\prime}, \phi^{\prime}: \mathcal{G} \rightarrow P^{\prime}$ ) realizing $\mathcal{G}$ are isomorphic if there is a projective automorphism $\psi$ of $\mathbb{S}^{d}$ such that $\psi(P)=P^{\prime}$ and $\hat{\psi} \circ \phi=\phi^{\prime}$, where $\hat{\psi}$ is the lattice isomorphism between $P$ and $P^{\prime}$ induced by $\psi$.

Definition 2.6. The deformation space $\mathcal{G}(\mathcal{G})$ of a labeled d-polytope $\mathcal{G}$ is the space of isomorphism classes of marked Coxeter $d$-polytopes realizing $\mathcal{G}$.

A labeled polytope $\mathcal{G}$ is rigid if the deformation space $\mathcal{C}(\mathcal{G})$ is the singleton. Otherwise, $\mathcal{G}$ is flexible.

Remark 2.7. A labeled polytope $\mathcal{G}$ and the deformation space $\mathcal{C}(\mathcal{G})$ can be thought of as a Coxeter orbifold $\mathcal{O}$ and the deformation space of marked convex real projective structures on $\mathcal{O}$, respectively (see Thurston [Thu02]).

In a way similar to Coxeter polytopes, we can associate to a labeled polytope $\mathcal{G}$ a Coxeter system and therefore the Coxeter group $W_{\mathcal{G}}$ : the generators and the relations of $W_{\mathcal{G}}$ corresponds to the facets and the ridge labeling of $\mathcal{G}$, respectively. A labeled polytope $\mathcal{G}$ is irreducible (resp. spherical, affine, large, Lannér) if $W_{\mathcal{G}}$ is irreducible (resp. spherical, affine, large, Lannér). We can also define the $\operatorname{link} \mathcal{G}_{v}$ of a labeled polytope $\mathcal{G}$ at a vertex $v$ using the usual notion of the link of a combinatorial polytope and labeling $\mathcal{G}_{v}$ accordingly. A labeled polytope $\mathcal{G}$ is perfect (resp. 2-perfect) if every vertex link of $\mathcal{G}$ is spherical (resp. perfect). An easy observation is:

Remark 2.8. Let $\mathcal{G}$ be a labeled polytope of dimension $d$. Then:

- If $W_{\mathcal{G}}$ is spherical or Lannér, then $\mathcal{G}$ is perfect.
- If $W_{\mathcal{G}}$ is affine and virtually isomorphic to $\mathbb{Z}^{d}$, then $\mathcal{G}$ is perfect.
- If $\mathcal{G}$ is a perfect $d$-simplex, then $W_{\mathcal{G}}$ is spherical, irreducible affine or Lannér.

Note that we cannot define the notion of quasi-perfect labeled polytope because, for example, the labeled triangle $\left(\frac{\pi}{\infty}, \frac{\pi}{\infty}, \frac{\pi}{\infty}\right)$ admits a realization for which the link of every vertex is parabolic (e.g. an ideal triangle of $\mathbb{\Vdash}^{2}$ ) or loxodromic (e.g. a hyperideal triangle of $\mathbb{H}^{2}$ ).

To be short, we say that a vertex $v$ of a Coxeter (or labeled) polytope is "something" if the corresponding link is "something". Here, the word "something" can be: irreducible, spherical, affine, large, Lannér, rigid, flexible, perfect, 2-perfect and so on.
2.11. The space of Cartan matrices. Let $(S, M)$ be a Coxeter system with Coxeter group $W$. A Cartan matrix $A=\left(a_{s t}\right)_{s, t \in S}$ realizes $(S, M)$ (or simply $W$ ) if $a_{s t} a_{t s}=4 \cos ^{2}\left(\frac{\pi}{M_{s t}}\right)$ when $M_{s t} \neq \infty$ and $a_{s t} a_{t s} \geqslant 4$ when $M_{s t}=\infty$. The space of Cartan matrices of $W$ of rank $d+1$, denoted by $\mathfrak{C}(W, d)$, is the space of equivalence classes of Cartan matrices of rank $d+1$ which realize $W$ (see (1) in Section 2.6 for the equivalence relation).

If $\mathcal{G}$ is a labeled $d$-polytope with Coxeter group $W_{\mathcal{G}}$, then there is a map

$$
\Lambda: \mathcal{C}(\mathcal{G}) \rightarrow \bigcup_{e \leqslant d} \mathfrak{C}\left(W_{\mathcal{G}}, e\right)
$$

given by $\Lambda(P)=\left[A_{P}\right]$. We will see that in the cases we are interested in, the image of $\mathcal{C}(\mathcal{G})$ under $\Lambda$ is exactly $\mathfrak{C}\left(W_{\mathcal{G}}, d\right)$ and moreover $\mathscr{C}(\mathcal{G})$ is homeomorphic to $\mathfrak{C}\left(W_{\mathcal{G}}, d\right)$.
2.12. Dehn filling of Coxeter polytope. Let $P_{\infty}$ be a Coxeter $d$-polytope and let $\mathcal{V}=$ $\left\{v_{1}, \ldots, v_{k}\right\}$ be a non-empty subset of the set $\mathcal{V}_{\mathcal{P}}$ of all parabolic vertices of $P_{\infty}$.

Definition 2.9. A projective generalized Dehn filling (or simply Dehn filling) of $P_{\infty}$ at $\mathcal{V}$ is a Coxeter $d$-polytope $P_{m_{1}, \ldots, m_{k}}$ with $m_{i} \in \mathbb{N}, i=1, \ldots, k$, such that the underlying labeled polytope of $P_{\infty}$ is obtained from the underlying labeled polytope of $P_{m_{1}, \ldots, m_{k}}$ by collapsing a ridge $r_{i}$ of label $\frac{\pi}{m_{i}}$ to the vertex $v_{i}$ for each $i=1, \ldots, k$ (see Figure 1 for Dehn filling in dimension 3).

Remark 2.10. Since every vertex $v \in \mathcal{V}$ is parabolic, we know from Marquis [Mar14] that $v$ is cusped, i.e. there exists a neighbourhood $\mathcal{U}$ of $v$ such that

$$
\mu_{\Omega_{P_{\infty}}}\left(P_{\infty} \cap \mathcal{U}\right)<\infty .
$$

In Section 8, we show that the existence of a Dehn filling implies some condition on the cusp: Let $P_{\infty}$ be an irreducible Coxeter $d$-polytope with Coxeter group $W_{\infty}$. If there is a Dehn filling of $P_{\infty}$ at $\mathcal{V} \subset \mathcal{V}_{\mathcal{P}}$, then for each $v \in \mathcal{V}$, the Coxeter group $W_{\infty, v}$ of the link of $P_{\infty}$ at $v$ is equal to $\tilde{A}_{1} \times \tilde{A}_{d-2}$ (see Appendix A for the notation of the spherical and affine Coxeter groups).
2.13. Combinatorial 4-polytopes with 6 facets. By taking a cone with basis a polytope $Q$ of dimension $d-1$, we obtain a polytope $\operatorname{Pyr}(Q)$ of dimension $d$. Every non-trivial choice of apex of the cone gives the same combinatorial structure for $\operatorname{Pyr}(Q)$. Such a polytope $\operatorname{Pyr}(Q)$ is called the pyramid over $Q$. We use the notation $\Delta_{d}$ to denote the simplex of dimension $d$. A polytope $P$ is simple if every vertex link of $P$ is the simplex.

There are 4 different combinatorial polytopes of dimension 4 with 6 facets (see Paragraph 6.5 of Ziegler [Zie95]). Two of them are simple: $\Delta_{1} \times \Delta_{3}$ and $\Delta_{2} \times \Delta_{2}$, and two others are pyramids: $\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{2}\right)$ and $\operatorname{Pyr}\left(\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{1}\right)\right)$.

We emphasize the following distinction between these four polytopes.

- In $\Delta_{1} \times \Delta_{3}$ : there exists a pair of facets that do not intersect.
- In $\Delta_{2} \times \Delta_{2}$ : any two facets are adjacent.
- In $\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{2}\right)$ and $\operatorname{Pyr}\left(\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{1}\right)\right)$ : any two facets intersect.
- In $\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{2}\right)$ : there is exactly one pair of non-adjacent facets.
- In $\operatorname{Pyr}\left(\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{1}\right)\right)$ : there are exactly two pairs of non-adjacent facets.

A triangular prism (or simply prism) is the combinatorial polytope $\Delta_{1} \times \Delta_{2}$, and hence $\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{2}\right)$ is the 4-pyramid over the prism. More generally, $\Delta_{1} \times \Delta_{d-1}$ is the $d$-prism (or a simplicial prism).

## 3. Labeled polytopes $\mathcal{G}_{m}^{i}$

In Sections 3, 4,5 and 6, for the sake of demonstrating the construction of the examples in Theorem A without too many technical details, we concentrate our attention on three families of labeled 4-polytopes $\mathcal{G}_{m}^{i}$ with $i=1,2,3$ such that $7 \leqslant m \leqslant \infty$ if $i=1,2$, and $3 \leqslant m \leqslant \infty$ if $i=3$. The arguments can easily extended to cover the other families in Table 1.

If $m$ is finite, then the underlying polytope of $\mathcal{G}_{m}^{i}$ is the product of two triangles, and if $m=\infty$, then the underlying polytope of $\mathcal{G}_{\infty}^{i}$ is the pyramid over the prism (see Figure 3 for the Schlegel diagrams of these polytopes, and refer to Chapter 5 of Ziegler [Zie95] for more details about Schlegel diagram). We explain below how to give labels on the ridges of $\mathcal{G}_{m}^{i}$ using the Coxeter groups $W_{m}^{i}$ in Table 4.

Table 4. The Coxeter graph of $W_{m}^{1}, W_{m}^{2}, W_{m}^{3}$
3.1. The labeled polytopes $\mathcal{G}_{m}^{i}$ for $m$ finite. The underlying polytope of $\mathcal{G}_{m}^{i}$ is the Cartesian product $\mathcal{G}$ of two triangles. It is a 4-dimensional polytope with 6 facets, 15 ridges and 9 vertices.

We describe more precisely the combinatorial structure of $\mathcal{G}$ : Let $T_{1}, T_{2}$ be two triangles and let $\mathcal{G}=T_{1} \times T_{2}$. Denote the edges of $T_{1}$ by $e_{1}, e_{2}, e_{3}$ and the edges of $T_{2}$ by $e_{4}, e_{5}, e_{6}$. The 6 facets of $\mathcal{G}$ are $F_{k}=e_{k} \times T_{2}, k=1,2,3$, and $F_{l}=T_{1} \times e_{l}, l=4,5,6$, and the 15 ridges of $\mathcal{G}$ can be divided into 2 families:

- 9 ridges (quadrilaterals): $e_{k} \times e_{l}$ for every $k=1,2,3$ and $l=4,5,6$.
- 6 ridges (triangles): $T_{1} \times w$ and $v \times T_{2}$ for every vertex $w$ (resp. $v$ ) of $T_{2}\left(\right.$ resp. $\left.T_{1}\right)$.

The ridge $F_{k} \cap F_{l}$ is $\left(e_{k} \cap e_{l}\right) \times T_{2}$ if $(k, l) \in\{(1,2),(2,3),(3,1)\}, T_{1} \times\left(e_{k} \cap e_{l}\right)$ if $(k, l) \in\{(4,5),(5,6),(6,4)\}$, and $e_{k} \times e_{l}$ if $k=1,2,3$ and $l=4,5,6$. Finally, the 9 vertices of $\mathcal{G}$ are $v_{k l s t}=F_{k} \cap F_{l} \cap F_{s} \cap F_{t}$ for $(k, l) \in\{(1,2),(2,3),(3,1)\}$ and $(s, t) \in\{(4,5),(5,6),(6,4)\}$.

Note that every two distinct facets of $\mathcal{G}$ are adjacent, and hence we can label the ridges of $\mathcal{G}$ according to the Coxeter graph $W_{m}^{i}$ in Table 4 to obtain the labeled polytope $\mathcal{G}_{m}^{i}$.

Proposition 3.1. Let $\mathcal{G}_{m}^{i}$ be the labeled polytope with $m$ finite. Then:

- The labeled polytopes $\mathcal{G}_{m}^{1}$ and $\mathcal{G}_{m}^{3}$ are perfect.
- The labeled polytope $\mathcal{G}_{m}^{2}$ is 2-perfect with exactly two Lannér vertices $v_{1345}$ and $v_{2345}$.

Proof. First, remark that $\mathcal{G}_{m}^{i}$ is simple, and so every vertex link is a 3 -simplex. Hence, by Remark 2.8, the proof immediately follows from comparing the Coxeter diagrams of the links of $\mathcal{G}_{m}^{i}$ and the Coxeter diagrams in Appendix A. For example, on the one hand, the Coxeter group of the link of $\mathcal{G}_{m}^{1}$ (or $\mathcal{G}_{m}^{3}$ ) at the vertex $v_{1345}$ is:

which is the spherical Coxeter diagram $A_{4}$ in Table 6, and on the other hand, the Coxeter group of the link of $\mathcal{G}_{m}^{2}$ at the vertex $v_{1345}$ is:

which is a Lannér Coxeter diagram in Table 9.
3.2. The labeled polytopes $\mathcal{G}_{m}^{i}$ for $m$ infinite. The underlying polytope of the labeled polytope $\mathcal{G}_{\infty}^{i}, i=1,2,3$, is the pyramid $\mathcal{G}_{\infty}$ over the prism. It is a 4 -dimensional polytope with 6 facets, 14 ridges and 7 vertices.

More precise description of the combinatorial structure of $\mathcal{G}_{\infty}$ is as follows: Let $I$ be a segment with two endpoints $a_{5}$ and $a_{6}$, and $\Delta$ be a triangle with three edges $b_{1}, b_{2}$ and $b_{3}$. The prism $I \times \Delta$ has 5 faces labeled in the obvious way (see Figure 4). Let $\mathcal{G}_{\infty}=\operatorname{Pyr}(I \times \Delta)$. Among the 6 facets of $\mathcal{G}_{\infty}$, the five of them, $F_{i}, i=1,2,3,5,6$, correspond to the facets of $I \times \Delta$, and $F_{4}$ denotes the remaining one. The 14 ridges of $\mathcal{G}_{\infty}$ can be divided into 2 families:

- 5 ridges correspond to the faces of $I \times \Delta$ and these ridges are in the facet $F_{4}$.


Figure 4. The basis of $\mathcal{G}_{\infty}$

- 9 ridges correspond to the edges of $I \times \Delta$ and these ridges are $F_{1} \cap F_{2}, F_{2} \cap F_{3}, F_{3} \cap F_{1}$ and $F_{k} \cap F_{l}$ with $k=1,2,3$ and $l=5,6$.
We remark that every two facets $F_{k}$ and $F_{l}$ are adjacent except when $\{k, l\}=\{5,6\}$ and $F_{5} \cap F_{6}$ is the apex $s$ of the pyramid $\mathcal{G}_{\infty}$, and therefore we can label the ridges of $\mathcal{G}_{\infty}$ according to the Coxeter graph $W_{\infty}^{i}$ in Table 4 to obtain $\mathcal{G}_{\infty}^{i}$.

Proposition 3.2. Let $\mathcal{G}_{\infty}^{i}$ be the labeled polytope $\mathcal{G}_{m}^{i}$ with $m$ infinite. Then:

- For every $i=1,2,3$, the labeled polytope $\mathcal{G}_{\infty}^{i}$ is 2-perfect.
- For each $i=1,3$, the only non-spherical vertex of $\mathcal{G}_{\infty}^{i}$ is the apex $s$, which is affine of type $\tilde{A}_{1} \times \tilde{A}_{2}$.
- The labeled polytope $\mathcal{G}_{\infty}^{2}$ has 3 non-spherical vertices $v_{1345}, v_{2345}$ and the apex s. Two of them, $v_{1345}$ and $v_{2345}$, are Lannér, and $s$ is affine of type $\tilde{A}_{1} \times \tilde{A}_{2}$.
Proof. Remark that except the apex $s$ of $\mathcal{G}_{\infty}^{i}$, every vertex link is a 3 -simplex, and the link of $s$ is a prism. Once again, by Remark 2.8, the proof follows from comparing the Coxeter diagrams of the links of $\mathcal{G}_{\infty}^{i}$ and the Coxeter diagrams in Appendix A. For the apex $s$, the Coxeter group of the link of $\mathcal{G}_{\infty}^{i}$ at $s=F_{1} \cap F_{2} \cap F_{3} \cap F_{5} \cap F_{6}$ is:


which is the affine Coxeter group $\tilde{A}_{2} \times \tilde{A}_{1}$ (see Table 7) virtually isomorphic to $\mathbb{Z}^{2} \times \mathbb{Z}^{1}=\mathbb{Z}^{3}$, and hence $s$ is perfect.


## 4. Deformation spaces $\mathcal{C}\left(\mathcal{G}_{m}^{i}\right)$

This section is devoted to the proof of the following propostion:
Proposition 4.1. Let $\mathcal{G}\left(\mathcal{G}_{m}^{i}\right)$ be the deformation space of the labeled polytope $\mathcal{G}_{m}^{i}$ with $m$ finite. Then:

- The deformation space $\mathcal{\mathcal { V }}\left(\mathcal{G}_{m}^{i}\right), i=1,2$, consists of two points for every $6<m<\infty$.
- The deformation space $\mathcal{G}\left(\mathcal{G}_{m}^{3}\right)$ consists of two disjoints lines for every $3<m<\infty$.

In order to prove Proposition 4.1 and others, we need Theorem 4.2, which tells us how the combinatorial structure of a Coxeter polytope $P$ is influenced by the Cartan matrix of $P$. Recall that $S$ is the set of facets of $P, A=A_{P}$ the Cartan matrix of $P$ and for every face $f$ of
$P, S_{f}=\{s \in S \mid f \subset s\}$. Let $\sigma(P)=\left\{S_{f} \mid f\right.$ is a face of $\left.P\right\} \subset 2^{S}$. If the dihedral angle between the facets $s$ and $t$ is $\frac{\pi}{2}$, then we express this fact by writing $s \perp t$. For each $T \subset S$,

$$
Z(T)=\{s \in S \mid s \perp t \text { for all } t \in T\} \quad \text { and } \quad A_{T}=\left(A_{s t}\right)_{s, t \in T}
$$

Theorem 4.2 (Theorem 4 and 7 of Vinberg [Vin71]). Let $P$ be a Coxeter d-polytope with Coxeter group $W$ and let $T$ be a proper subset of $S$.

- If $W_{T}$ is spherical, then $T \in \sigma(P)$.
$\therefore$ If $A_{T}=A_{T}^{0}$ and $A_{Z(T)}^{0}=\varnothing$, then $T \in \sigma(P)$.
$\therefore$ If $W_{T}$ is virtually isomorphic to $\mathbb{Z}^{d-1}, A_{T}=A_{T}^{0}$ and $P$ is not parabolic, then $T \in \sigma(P)$ and $\bigcap_{t \in T} t$ is a vertex of $P$.
4.1. Preparation of the computation. If $\iota$ is a double index (resp. an integer), then let $c_{l}:=\cos \left(\frac{\pi}{m_{l}}\right)$ (resp. $\left.:=\cos \left(\frac{\pi}{l}\right)\right)$ and $s_{l}:=\sin \left(\frac{\pi}{m_{l}}\right)$ (resp. $:=\sin \left(\frac{\pi}{l}\right)$ ). We introduce the following matrix:

$$
A_{\lambda, \mu}=\left(\begin{array}{cccccc}
2 & -1 & -\lambda^{-1} & & & \\
-1 & 2 & -1 & & & \\
-\lambda & -1 & 2 & -2 c_{34} & & \\
& & -2 c_{34} & 2 & -2 c_{45} & -2 \mu^{-1} c_{64} \\
& & & -2 c_{45} & 2 & -2 c_{56} \\
& & & -2 \mu c_{64} & -2 c_{56} & 2
\end{array}\right)
$$

with $\lambda, \mu>0$. If $\left(S=\{1,2,3,4,5,6\}, M_{m}^{i}\right)$ is the Coxeter system associated to $W_{m}^{i}$, then:

- If $\left(m_{34}, m_{45}, m_{56}, m_{64}\right)=(3,3, m, 2)$, then $A_{\lambda}:=A_{\lambda, 1}$ realizes $W_{m}^{1}$.
- If $\left(m_{34}, m_{45}, m_{56}, m_{64}\right)=(5,3, m, 2)$, then $A_{\lambda}$ realizes $W_{m}^{2}$.
- If $\left(m_{34}, m_{45}, m_{56}, m_{64}\right)=(3,3, m, 3)$, then $A_{\lambda, \mu}$ realizes $W_{m}^{3}$.

If $i=1,2$ (resp. 3), then the equivalence class of Cartan matrices realizing $W_{m}^{i}$ is determined by exactly one (resp. two) cyclic product(s): (123) (resp. (123) and (456)). In other words, every Cartan matrix $A$ realizing $W_{m}^{i}$ is equivalent to a unique $A_{\lambda, \mu}$, and so we call $A_{\lambda, \mu}$ the standard form of $A$.

Proposition 4.3. Suppose $3 \leqslant m<\infty$. Then $\mathcal{G}\left(\mathcal{G}_{m}^{i}\right)$ is homeomorphic to:

- $\left\{\lambda \in \mathbb{R} \mid \lambda>0\right.$ and $\left.\operatorname{det}\left(A_{\lambda}\right)=0\right\}$ for $i=1,2$.
- $\left\{(\lambda, \mu) \in \mathbb{R}^{2} \mid \lambda, \mu>0\right.$ and $\left.\operatorname{det}\left(A_{\lambda, \mu}\right)=0\right\}$ for $i=3$.

Proof. We begin with the fact that the rank of $A_{\lambda, \mu}$ is always greater than or equal to 5 by computing the (3,3)-minor of $A_{\lambda, \mu}$, and therefore the image of the map

$$
\Lambda: \mathcal{C}\left(\mathcal{G}_{m}\right) \rightarrow \bigcup_{e \leqslant 4} \mathfrak{C}\left(W_{m}^{i}, e\right)
$$

given by $P \mapsto\left[A_{P}\right]$ lies in $\mathfrak{C}\left(W_{m}^{i}, 4\right)$. Moreover, we know from Theorem 2.2 that $\Lambda$ is injective. Now let us prove that the image of $\mathcal{E}\left(\mathcal{G}_{m}\right)$ under $\Lambda$ is exactly $\mathfrak{C}\left(W_{m}^{i}, 4\right)$ : Once again, by Theorem 2.2, every Cartan matrix $A$ in $\mathfrak{C}\left(W_{m}^{i}, 4\right)$ is realized by some Coxeter 4-polytope $P$. We need to check that the combinatorial structure of $P$ is the product of two triangles.

For every two distinct facets $s, t$ of $P$, the standard subgroup generated by $s, t$ is a finite dihedral group, which is a spherical Coxeter group, and hence by the first item of Theorem 4.2, the facets $s, t$ are adjacent. Finally, we know from Section 2.13 that the product of two
triangles is the only 4-polytope with 6 facets such that every two distint facets are adjacent, which completes the proof.

### 4.2. The computation. For $\alpha, \beta, \gamma \in \mathbb{R}$, let:

$$
\Psi_{\alpha, \beta, \gamma}=1-\cos (\alpha)^{2}-\cos (\beta)^{2}-\cos (\gamma)^{2}-2 \cos (\alpha) \cos (\beta) \cos (\gamma)
$$

The following equality is remarkable:

$$
\Psi_{\alpha, \beta, \gamma}=-4 \cos \left(\frac{\alpha+\beta+\gamma}{2}\right) \cos \left(\frac{-\alpha+\beta+\gamma}{2}\right) \cos \left(\frac{\alpha-\beta+\gamma}{2}\right) \cos \left(\frac{\alpha+\beta-\gamma}{2}\right)
$$

If $\alpha, \beta, \gamma \in\left(0, \frac{\pi}{2}\right]$, then $\Psi_{\alpha, \beta, \gamma}<0($ resp. $=0,>0)$ if and only if $\alpha+\beta+\gamma<\pi$ (resp. $\left.=\pi,>\pi\right)$. We introduce the following two matrices:

$$
A_{\lambda}^{1}=\left(\begin{array}{ccc}
1 & -c_{12} & -\lambda^{-1} c_{31} \\
-c_{12} & 1 & -c_{23} \\
-\lambda c_{31} & -c_{23} & 1
\end{array}\right) \quad A_{\mu}^{2}=\left(\begin{array}{ccc}
1 & -c_{45} & -\mu^{-1} c_{64} \\
-c_{45} & 1 & -c_{56} \\
-\mu c_{64} & -c_{56} & 1
\end{array}\right)
$$

Implicitly, we assume that $m_{12}=m_{23}=m_{13}=m_{45}=3$, but we keep the notation of double index in order to the use the remarkable equality. By a direct computation, we have:

$$
\frac{1}{64} \operatorname{det}\left(A_{\lambda, \mu}\right)=\operatorname{det}\left(A_{\lambda}^{1}\right) \operatorname{det}\left(A_{\mu}^{2}\right)-s_{12}^{2} c_{34}^{2} s_{56}^{2}
$$

Another direct computation gives us:

$$
\begin{aligned}
& \operatorname{det}\left(A_{\lambda}^{1}\right)=1-\left(c_{12}^{2}+c_{23}^{2}+c_{31}^{2}\right)-c_{12} c_{23} c_{31}\left(\lambda+\lambda^{-1}\right)=\Psi_{123}-c_{12} c_{23} c_{31}\left(\lambda+\lambda^{-1}-2\right) \\
& \operatorname{det}\left(A_{\mu}^{2}\right)=1-\left(c_{45}^{2}+c_{56}^{2}+c_{64}^{2}\right)-c_{45} c_{56} c_{64}\left(\mu+\mu^{-1}\right)=\Psi_{456}-c_{45} c_{56} c_{64}\left(\mu+\mu^{-1}-2\right)
\end{aligned}
$$

where $\Psi_{123}\left(\right.$ resp. $\left.\Psi_{456}\right)$ is $\Psi_{\alpha, \beta, \gamma}$ with $(\alpha, \beta, \gamma)=\left(\frac{\pi}{m_{12}}, \frac{\pi}{m_{23}}, \frac{\pi}{m_{31}}\right)$ (resp. $\left(\frac{\pi}{m_{45}}, \frac{\pi}{m_{56}}, \frac{\pi}{m_{64}}\right)$ ).
Remark 4.4. The quantity $\Psi_{123}$ is negative (resp. zero, positive) if and only if the triangle $\{1,2,3\}$ is hyperbolic (resp. affine, spherical). Of course, the analogous statement is true for the quantity $\Psi_{456}$ and the triangle $\{4,5,6\}$.

### 4.3. Proof of Proposition 4.1.

Proof of Proposition 4.1. Assume that $i=1,2$. By Proposition 4.3, we know that $\mathscr{C}\left(\mathcal{G}_{m}^{i}\right)$ is homeomorphic to:

$$
\left\{\lambda \in \mathbb{R} \mid \lambda>0 \text { and } \operatorname{det}\left(A_{\lambda}\right)=0\right\}
$$

Moreover, since $c_{64}=0$ and the triangle $\left(\frac{\pi}{3}, \frac{\pi}{3}, \frac{\pi}{3}\right)$ is affine, i.e. $\Psi_{123}=0$, we have:

$$
\frac{1}{64} \operatorname{det}\left(A_{\lambda}\right)=\frac{1}{8}\left(2-\left(\lambda+\lambda^{-1}\right)\right) \Psi_{456}-s_{12}^{2} c_{34}^{2} s_{56}^{2}
$$

Observe that $m>6$ if and only if the triangle $\left(\frac{\pi}{2}, \frac{\pi}{3}, \frac{\pi}{m}\right)$ is hyperbolic, i.e. $\Psi_{456}<0$. Let $x=$ $\lambda+\lambda^{-1}$. The function $[2,+\infty) \ni x \mapsto \operatorname{det}\left(A_{\lambda}\right) \in \mathbb{R}$ is an unbounded strictly increasing function. If $x=2$, i.e. $\lambda=1$, then $\operatorname{det}\left(A_{\lambda}\right)=-64 s_{12}^{2} c_{34}^{2} s_{56}^{2}<0$. Hence, there is a unique $x>2$ and exactly two $\lambda \in \mathbb{R}_{+}^{*} \backslash\{1\}$ such that $\operatorname{det}\left(A_{\lambda}\right)=0$.

Now assume that $i=3$. Once again, by Proposition 4.3, we need to solve the equation:

$$
\frac{1}{64} \operatorname{det}\left(A_{\lambda, \mu}\right)=\frac{1}{8}\left(\lambda+\lambda^{-1}-2\right)\left(c_{45} c_{56} c_{64}\left(\mu+\mu^{-1}-2\right)-\Psi_{456}\right)-s_{12}^{2} c_{34}^{2} s_{56}^{2}=0
$$

on the set $\left\{(\lambda, \mu) \in \mathbb{R}^{2} \mid \lambda, \mu>0\right\}$. Let $x=\lambda+\lambda^{-1}$ and $y=\mu+\mu^{-1}$. The equation is of the form:

$$
(x-2)(y-A)=B
$$

with $B>0$ and $A<2$, and thus the solution space of the equation on $\left\{(x, y) \in \mathbb{R}^{2} \mid x, y \geqslant 2\right\}$ is homeomorphic to a closed half-line whose extremity $E$ is a point $\left(x_{0}, 2\right)$ with $x_{0}>2$ (see the blue curve in Figure 5 (A)). It follows that the set of solutions in $(\lambda, \mu)$ is homeomorphic to two disjoints lines (see the two blue curves in Figure 5 (B)), which completes the proof.


Figure 5. The deformation space $\mathcal{C}\left(\mathcal{G}_{m}^{3}\right)$ with $m=7$

Remark 4.5. If $i=1,2$ and $3 \leqslant m \leqslant 6$, then $\mathcal{\mathcal { C }}\left(\mathcal{G}_{m}^{i}\right)=\varnothing$.
Remark 4.6. If $i=3$ and $m=3$, then the equation to solve is of the form:

$$
(x-2)(y-2)=B
$$

with $B>0$, and thus the set of solutions in $(\lambda, \mu)$ is homeomorphic to four disjoints lines.
Definition 4.7. For each Coxeter polytope $P \in \mathcal{G}\left(\mathcal{G}_{m}^{3}\right)$, the Cartan matrix $A_{P}$ is equivalent to the unique standard form $A_{\lambda, \mu}$, and thus the real number $\mu$ is an invariant of $P$. It is called the $\mu$-invariant of $P$ and denoted by $\mu(P)$.

By the parametrization of $\mathcal{C}\left(\mathcal{G}_{m}^{3}\right)$, the map $\mathcal{C}\left(\mathcal{G}_{m}^{3}\right) \rightarrow \mathbb{R}_{+}^{*}$ given by $P \mapsto \mu(P)$ is a two-to-one covering map. More precisely, for any $\mu>0$, there exist exactly two Coxeter polytopes $P_{m}$ and $P_{m}^{\prime}$ in $\mathcal{C}\left(\mathcal{G}_{m}^{3}\right)$ such that $A_{P_{m}}=A_{\lambda, \mu}$ and $A_{P_{m}^{\prime}}=A_{\lambda^{-1}, \mu}$ with some $\lambda>0$.
Remark 4.8 (Duality). If $i=1,2$, then $\mathcal{C}\left(\mathcal{G}_{m}^{i}\right)=\left\{P, P^{\sharp}\right\}$ and $A_{P^{\sharp}}$ is the transpose of $A_{P}$, and so $P$ and $P^{\sharp}$ are dual in a sense that there is an outer automorphism of $\mathrm{SL}_{5}^{ \pm}(\mathbb{R})$ which exchange them. If $i=3$, then the analogous statement is true for each pair $\left\{P, P^{\sharp}\right\}$ of Coxeter polytopes in $\mathcal{C}\left(\mathcal{G}_{m}^{i}\right)$ such that $A_{P}=A_{\lambda, \mu}$ and $A_{P^{\sharp}}=A_{\lambda^{-1}, \mu^{-1}}$ (up to equivalence).

## 5. Limits of $P_{m}$

In this section, we study the limit of the sequence $\left(P_{m}\right)_{m}$.

## Proposition 5.1.

- Let $i=1,2$. Assume $P_{m}$ is one of the two points of $\mathcal{C}\left(\mathcal{G}_{m}^{i}\right)$. If $A_{P_{m}}$ has the standard form, then as $m$ goes to infinity, $A_{P_{m}}$ converges to the symmetric matrix:

$$
A_{\infty}^{i}=\left(\begin{array}{cccccc}
2 & -1 & -1 & & & \\
-1 & 2 & -1 & & & \\
-1 & -1 & 2 & -2 c_{34} & & \\
& & -2 c_{34} & 2 & -1 & \\
& & & -1 & 2 & -2 \\
& & & & -2 & 2
\end{array}\right)
$$

- Let $i=3$ and $\mu>0$. Assume $P_{m}$ is one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}^{3}\right)$ such that $\mu\left(P_{m}\right)=\mu$. If $A_{P_{m}}$ has the standard form, then as $m$ goes to infinity, $A_{P_{m}}$ converges to the matrix:

$$
A_{\infty, \mu}^{3}=\left(\begin{array}{cccccc}
2 & -1 & -1 & & & \\
-1 & 2 & -1 & & & \\
-1 & -1 & 2 & -1 & & \\
& & -1 & 2 & -1 & -\mu^{-1} \\
& & & -1 & 2 & -2 \\
& & & -\mu & -2 & 2
\end{array}\right)
$$

Proof. This is a straightforward computation.
For each $m \in \mathbb{N} \cup\{\infty\}$, let $P_{m}$ be a Coxeter polytope with Coxeter group $W_{m}$ and Coxeter system $\left(S_{m}, M_{m}\right)$, and let $\rho_{m}: W_{m} \rightarrow \mathrm{SL}_{d+1}^{ \pm}(\mathbb{R})$ be the corresponding representation. A sequence of Coxeter polytopes $\left(P_{m}\right)_{m}$ converges to $P_{\infty}$ as $m \rightarrow \infty$ if:

- There is a bijection $\hat{\phi}: S_{\infty} \rightarrow S_{m}$ which induces the homomorphism $\phi: W_{\infty} \rightarrow W_{m}$.
$\therefore$ The sequence of representations $\left(\rho_{m} \circ \phi\right)_{m}$ converges algebraically to $\rho_{\infty} \in \operatorname{Hom}\left(W_{\infty}, \mathrm{SL}^{ \pm}(V)\right)$.
Note that $\operatorname{Hom}\left(W_{\infty}, \mathrm{SL}^{ \pm}(V)\right)$ is the space of all homomorphisms of $W_{\infty}$ into $\mathrm{SL}^{ \pm}(V)$ with the topology of pointwise convergence.

Corollary 5.2. Let $i=1,2$ or 3 and $\mu>0$. Let $P_{m}$ be one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}^{i}\right)$ (such that $\mu\left(P_{m}\right)=\mu$ if $i=3$ ). As $m$ goes to infinity, the sequence $\left(P_{m}\right)_{m}$ converges to a Coxeter polytope $P_{\infty}$ whose Cartan matrix is $A_{\infty}^{i}$ if $i=1,2$ and $A_{\infty, \mu}^{3}$ if $i=3$. Moreover, the underlying polytope of $P_{\infty}$ is the pyramid over the prism.

Proof. We ignore the subscript $i$ and the index $\mu$ because the proof does not depend on $i$ and $\mu$.

The Cartan matrix $A_{\infty}$ is irreducible, of negative type and of rank $d+1$. By Theorem 2.2, there exists a unique Coxeter polytope $P_{\infty}$ realizing $A_{\infty}$. The obvious bijection between $S_{\infty}$ and $S_{m}$ and Proposition 5.1 immediately tell us that the sequence $\left(P_{m}\right)_{m}$ converges to a Coxeter polytope $P_{\infty}$. The only remaining part is to prove that the underlying polytope of $P_{\infty}$ is the pyramid over the prism. Let $T=\{1,2,3,5,6\}$. The Cartan matrix $A_{T}=A_{T}^{0}$ and $W_{T}=\tilde{A}_{1} \times \tilde{A}_{2}$ virtually isomorphic to $\mathbb{Z}^{3}$, and thus the third part of Theorem 4.2 shows that $T \in \sigma(P)$ and the intersection of the five facets corresponding to $T$ is a vertex $v$ of $P_{\infty}$. By Theorem 2.4, the link of $P_{\infty}$ at $v_{\infty}$ is a parabolic Coxeter 3-polytope whose underlying polytope is a prism, and so $P_{\infty}$ is indeed the pyramid over the prism.

## 6. GEOMETRIC DESCRIPTION

In this section, we explain the geometric properties of the Coxeter polytopes $P_{m}$ and of the action of the projective reflection groups $\Gamma_{P_{m}}$ of $P_{m}$ on $\Omega_{P_{m}}$. To do so, we need the following theorem:

Theorem 6.1 (Theorem E of Marquis [Mar14] using Benoist [Ben04a] and Cooper-Long-Tillmann [CLT15]). Let P be a quasi-perfect loxodromic Coxeter polytope. Then the following are equivalent:

- The group $W_{P}$ is Gromov hyperbolic relative to the standard subgroups of $W_{P}$ corresponding to the parabolic vertices of $P$.
- The convex domain $\Omega_{P}$ is strictly convex.
- The boundary $\partial \Omega_{P}$ of $\Omega_{P}$ is of class $\mathcal{C}^{1}$.
6.1. Description of the geometry of the first example. Assume $i=1$, and drop the index $i$. The Coxeter polytope $P_{\infty}$ is a quasi-perfect hyperbolic polytope of dimension 4, listed in Tumarkin [Tum04]. In particular, $P_{\infty}$ is a hyperbolic Coxeter polytope of finite volume, i.e. the projective Coxeter group of $P_{\infty}$ is a non-uniform lattice of $\mathrm{PO}_{d, 1}(\mathbb{R})$.

The Coxeter 4-polytope $P_{m}$ is perfect. The group $\Gamma_{m}$ is not Gromov hyperbolic since the group generated by the reflections corresponding to $\{1,2,3\}$ is an affine Coxeter group virtually isomorphic to $\mathbb{Z}^{2}$, and so by Theorem 6.1 , the convex domain $\Omega_{m}$ is not strictly convex nor with $\mathcal{C}^{1}$ boundary.
6.2. Description of the geometry of the second example. Assume $i=2$, and drop the index $i$. The Coxeter polytope $P_{\infty}$ is a 2-perfect hyperbolic polytope of dimension 4 with four spherical vertices, one parabolic vertex and two loxodromic vertices, and the Coxeter polytope $P_{m}$ is a 2-perfect Coxeter polytope of dimension 4 with seven spherical vertices and two loxodromic vertices (see the right subfigure 6). We will come back on these examples in Section 9.
6.3. Description of the geometry of the third example. Assume $i=3$, and drop the index $i$. The Coxeter polytope $P_{\infty}$ is a quasi-perfect polytope of dimension 4 with six spherical vertices, one parabolic vertex (see the left subfigure 6). Moreover, $\Gamma_{\infty}$ is a non-uniform lattice of $\mathrm{PO}_{d, 1}(\mathbb{R})$ if and only if $\mu\left(P_{\infty}\right)=1$. In other words, if $\mu\left(P_{\infty}\right) \neq 1$, then $P_{\infty}$ is not a hyperbolic Coxeter polytope and the convex domain $\Omega_{P_{\infty}}$ is not an ellipsoid, however by Theorem 6.1, it is strictly convex with $\mathcal{C}^{1}$ boundary.

The Coxeter polytope $P_{m}$ is a perfect Coxeter polytope of dimension 4. Once again, by Theorem 6.1, the convex domain $\Omega_{m}$ is not strictly convex nor with $\mathcal{C}^{1}$ boundary. Note that compare to Section 6.1, in the case when $i=3$, there is a one-parameter family of deformations of the convex domains.

## 7. More prime examples in dimension 4

In Table 1A, we give a list of Coxeter groups $W_{m}$, which is not redundant but contains the previous three examples. For each of them, if $m$ is an integer greater than or equal to 7, then we can label the product of two triangles in order to obtain a labeled polytope $\mathcal{G}_{m}$. The technique we previously describe easily extends to show:


Figure 6. The spherical vertices are in black, the parabolic vertices are in white, the loxodromic vertices are in grey.

Theorem 7.1. Choose one of the 13 families $\left(W_{m}\right)_{m \geqslant 7}$ in Table 1A. If the Coxeter graphs of the family have one loop, then $\mathcal{G}\left(\mathcal{G}_{m}\right)$ consists of two points. If the Coxeter graphs of the family have two loops, then $\mathcal{V}\left(\mathcal{G}_{m}\right)$ consists of two disjoints lines.

If $m=\infty$, then we can label a pyramid over a prism in order to obtain a labeled polytope $\mathcal{G}_{\infty}$. Eventually, we can show:

Theorem 7.2. Choose one of the 13 families $\left(W_{m}\right)_{m \geqslant 7}$ in Table 1A.

- Assume that the Coxeter graphs of the family have one loop. If $P_{m}$ is one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}\right)$, then the sequence $\left(P_{m}\right)_{m}$ converges to the unique hyperbolic polytope $P_{\infty}$ whose Coxeter graph is $W_{\infty}$.
- Assume that the Coxeter graphs of the family have two loops. If $\mu>0$ and $P_{m}$ is one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}\right)$ with $\mu\left(P_{m}\right)=\mu$, then $\left(P_{m}\right)_{m}$ converges to $P_{\infty}$ which is the unique Coxeter 4-polytope such that $\mu\left(P_{\infty}\right)=\mu$ and $W_{P_{\infty}}=W_{\infty}$.


## 8. Necessary conditions for Dehn fillings

Let $P_{\infty}$ be a Coxeter polytope with Coxeter group $W_{\infty}$ and for some $m_{i} \in \mathbb{N}$, let $P_{m_{1}, \ldots, m_{k}}$ be a Dehn filling of $P_{\infty}$ at a non-empty set $\mathcal{V}=\left\{v_{1}, \ldots, v_{k}\right\}$ of some parabolic vertices of $P_{\infty}$, i.e. the underlying labeled polytope of $P_{\infty}$ is obtained from $P_{m_{1}, \ldots, m_{k}}$ by collapsing a ridge $r_{i}$ of label $\frac{\pi}{m_{i}}$ to the vertex $v_{i}$ for every $v_{i} \in \mathcal{V}$.
Proposition 8.1. Let $d \geqslant 3$, and let $P_{\infty}$ be an irreducible Coxeter polytope of dimension $d$. If there exists a Dehn filling of $P_{\infty}$ at $\mathcal{V}$, then for every $v \in \mathcal{V}, W_{\infty, v}=\tilde{A}_{1} \times \tilde{A}_{d-2}$. Moreover, the link $P_{\infty, v}$ of $P_{\infty}$ at $v$ is a $(d-1)$-prism.

Before beginning the proof, we recall the following notations and a lemma of Vinberg: Let $P$ be a Coxeter polytope with Coxeter group $W$, and $S$ the set of facets of $P$. For each face $f$ of $P$, let $S_{f}=\{s \in S \mid f \subset s\}$, and $\sigma(P)=\left\{S_{f} \mid f\right.$ is a face of $\left.P\right\} \subset 2^{S}$. If $T \subset S$, then $Z(T)=\{s \in S \mid s \perp t \forall t \in T\}$. Finally, $W_{T}$ and $A_{T}$ denote the Coxeter group and the Cartan matrix restricted to $T$, respectively, and $S^{0}$ denote the subset $T$ of $S$ such that $A_{T}=A_{S}^{0}$.

Lemma 8.2 (Lemma 13 and Proposition 21 of Vinberg [Vin71]). Let $W$ be an irreducible affine Coxeter group. If $A_{0}$ is the Tits matrix of $W$ and $A$ is a Cartan matrix realizing $W$, then the following is true:

- $\operatorname{rank}(A) \leqslant \operatorname{rank}\left(A_{0}\right)+1$.
- $\operatorname{rank}(A) \geqslant \operatorname{rank}\left(A_{0}\right)$, and the equlity holds if and only if $A$ and $A_{0}$ are equivalent.
- If $A$ is not of zero type, then $W=\tilde{A}_{k}$ for some $k \geqslant 1$.

Proof of Proposition 8.1. For the simplicity of the notation, we assume that $|\mathcal{V}|=1$ and denote by $P_{m}$ a Dehn filling of $P_{\infty}$ at $\mathcal{V}$. The proof of the general case is the same.

Let $S_{v}$ be the set of facets of $P_{\infty}$ containing $v \in \mathcal{V}$. First, look at the $v$-link Coxeter group $W_{\infty, v}$ of $W_{\infty}$, i.e. the Coxeter group of the link $P_{\infty, v}$ of $P_{\infty}$ at $v$. Since $v$ is a parabolic vertex, each component of the decomposition of the Coxeter group $W_{\infty, v}$ :

$$
W_{\infty, v}=W_{\infty, v}^{1} \times \cdots \times W_{\infty, v}^{l} \quad \text { for some } l \in \mathbb{N}
$$

is an irreducible affine Coxeter group (see Table 7) and $W_{\infty, v}$ is virtually isomorphic to $\mathbb{Z}^{d-1}$.
The facets of $P_{\infty}$ are in correspondence with the facets of $P_{m}$, and so we can consider the Coxeter subgroup $W_{m, v}$ of $W_{m}$ corresponding to the set $S_{v}$. Moreover, two adjacent facets of $S_{v}$ in $P_{\infty}$ are also adjacent in $P_{m}$ with the same dihedral angle. Remark that the converse statement is false. Also, the decomposition of $W_{\infty, v}$ gives a partition of the set $S_{v}=S_{v}^{1} \sqcup \cdots \sqcup S_{v}^{l}$, where $W_{\infty, v}^{i}$ corresponds to $S_{v}^{i}$ for each $i=1, \ldots, l$, with the geometric interpretation that if $s \in S_{v}^{i}$ and $t \in S_{v}^{j}$ with $i \neq j$, then $s$ and $t$ are adjacent in $P_{\infty}$ and the dihedral angle is $\frac{\pi}{2}$. As a consequence, the decomposition of $W_{\infty, v}$ induces a decomposition of the Coxeter group $W_{m, v}$ :

$$
W_{m, v}=W_{m, v}^{1} \times \cdots \times W_{m, v}^{l}
$$

At this moment, it is not obvious that each factor of this decomposition is irreducible, however we will see in the next paragraph that this is the case.

Let $r$ be the ridge of $P_{m}$ that collapses to the vertex $v$ to obtain $P_{\infty}$, and $r=s \cap t$ with two facets $s, t \in S_{v}$. Then $W_{\{s, t\}}=I_{2}(m)$ in $W_{m}$ and $W_{\{s, t\}}=\tilde{A}_{1}$ in $W_{\infty}$, and so we can assume that $W_{m, v}^{1}=I_{2}(m)$ and $W_{\infty, v}^{1}=\tilde{A}_{1}$. Finally, collapsing the ridge $r$ is the only change of the adjacency rule, and hence for all $i=2, \ldots, l$, we have $W_{m, v}^{i}=W_{\infty, v}^{i}$.

Let $A_{\infty, v}\left(\right.$ resp. $\left.A_{m, v}\right)$ be the Cartan submatrix of $A_{\infty}:=A_{P_{\infty}}$ (resp. $A_{m}:=A_{P_{m}}$ ) corresponding to $S_{v}$. According to the decomposition of $W_{\infty, v}$, we can decompose $A_{\infty, v}$ and $A_{m, v}$ as the direct sum:

$$
A_{\infty, v}=A_{\infty, v}^{1} \oplus \cdots \oplus A_{\infty, v}^{l} \quad \text { and } \quad A_{m, v}=A_{m, v}^{1} \oplus \cdots \oplus A_{m, v}^{l}
$$

where each $A_{\infty, v}^{i}$ and $A_{m, v}^{i}, i=1, \ldots, l$, corresponds to $S_{v}^{i}$, respectively, i.e. each $A_{\infty, v}^{i}$ (resp. $A_{m, v}^{i}$ ) is a component of $A_{\infty, v}$ (resp. $A_{m, v}$ ). Observe that $l \geqslant 2$ : Otherwise,

$$
d-1=\operatorname{rank}\left(A_{\infty, v}\right)=\operatorname{rank}\left(A_{\infty, v}^{1}\right)=1,
$$

which contradicts to the fact that $d \geqslant 3$.

Now, we have the following equalities or inequalities for rank:

- $\operatorname{rank}\left(A_{m, v}\right) \leqslant \operatorname{rank}\left(A_{m}\right)=d+1$,
- $\operatorname{rank}\left(A_{\infty, v}\right)=d-1$,
- $\operatorname{rank}\left(A_{m, v}^{1}\right)=\operatorname{rank}\left(A_{\infty, v}^{1}\right)+1$,
- $\operatorname{rank}\left(A_{m, v}^{i}\right) \geqslant \operatorname{rank}\left(A_{\infty, v}^{i}\right)$ for every $i \in\{2, \ldots, l\}$,
- $\operatorname{rank}\left(A_{m, v}^{i}\right)=\operatorname{rank}\left(A_{\infty, v}^{i}\right)+1$ for at least one $i \in\{2, \ldots, l\}$.

The first item is trivial. The second item follows from the fact that $v$ is a parabolic vertex of $P_{\infty}$. The third item is also trivial. The fourth item is a consequence of the second item of Lemma 8.2 and $W_{m, v}^{i}=W_{\infty, v}^{i}$.

In order to prove the fifth item, we assume on the contrary that for every $i \in\{2, \ldots, l\}$, $\operatorname{rank}\left(A_{m, v}^{i}\right)=\operatorname{rank}\left(A_{\infty, v}^{i}\right)$. Let $T=S_{v}^{2} \sqcup \cdots \sqcup S_{v}^{l}$. First, by the second item of Lemma 8.2, for each $i \in\{2, \ldots, l\}$, the Cartan matrix $A_{m, v}^{i}$ is of zero type, and hence $A_{m, T}=A_{m, T}^{0}$. If $U=T \cup Z(T)^{0}$, then $A_{m, U}=A_{m, U}^{0}$ and $Z(U)^{0}=\varnothing$, so by the second item of Theorem 4.2, the intersection of the facets of $P_{m}$ corresponding to $U$ is non-empty. It follows that the intersection of the facets of $P_{m}$ corresponding to $T$ is also non-empty, contradicting the combinatorial structure of the Dehn filling $P_{m}$.

From the fifth item, we can assume without loss of generality that:

$$
\operatorname{rank}\left(A_{m, v}^{2}\right)=\operatorname{rank}\left(A_{\infty, v}^{2}\right)+1
$$

Now we have to show that $l=2$. Suppose for contradiction that $l \geqslant 3$. Since

$$
\operatorname{rank}\left(A_{\infty, v}\right)=\sum_{i=1}^{l} \operatorname{rank}\left(A_{\infty, v}^{i}\right) \quad \text { and } \quad \operatorname{rank}\left(A_{m, v}\right)=\sum_{i=1}^{l} \operatorname{rank}\left(A_{m, v}^{i}\right),
$$

the previous five equalities and inequalities implies that:

$$
\operatorname{rank}\left(A_{m}\right)=\operatorname{rank}\left(A_{m, v}\right)=d+1 \quad \text { and } \quad \operatorname{rank}\left(A_{m, v}^{i}\right)=\operatorname{rank}\left(A_{\infty, v}^{i}\right) \text { for every } i \in\{3, \ldots, l\}
$$

and hence by the second item of Lemma 8.2, we conclude that for every $i=3, \ldots, l, A_{m, v}^{i}$ is equivalent to $A_{\infty, v}^{i}$, which is of zero type.

Now look at the Cartan matrix $A_{m}$ :

$$
A_{m}=\left[\begin{array}{cccccc}
A_{m}^{1} & 0 & 0 & \ldots & 0 & C_{1} \\
0 & A_{m}^{2} & 0 & \ldots & 0 & C_{2} \\
0 & 0 & A_{m}^{3} & \ldots & 0 & C_{3} \\
\ldots & \ldots & \ldots & \ldots & 0 & \ldots \\
0 & 0 & 0 & 0 & A_{m}^{l} & C_{l} \\
D_{1} & D_{2} & D_{3} & \ldots & D_{l} & F
\end{array}\right]
$$

where $C_{i}, D_{i}, i=1, \ldots, l$, and $F$ are some matrices. First, all entries of $C_{i}$ and $D_{i}$ are negative or null. Second, since $A_{m}^{i}$ is of zero type, for every $i=3, \ldots, l$, there is a vector $X_{i}>0$ such that $A_{m}^{i} X_{i}=0$. Recall that $X>0$ if every entry of $X$ is strictly positive. Moreover, since $\operatorname{rank}\left(A_{m}\right)=\operatorname{rank}\left(A_{m, v}\right)$, we also have that

$$
\operatorname{rank}\left[\begin{array}{c}
A_{m}^{l} \\
D_{l}
\end{array}\right]=\operatorname{rank}\left(A_{m}^{l}\right)
$$

and so the vector $D_{l} X$ should be zero. As a consequence, $D_{l}$ is a zero matrix, and so is $C_{l}$, which contradicts the fact that $A_{m}$ and $A_{\infty}$ are irreducible. Finally, we prove that $l=2$.

In the previous paragraph, we show that $A_{m, v}^{2}$ cannot be of zero type, and therefore the Coxeter group $W_{\infty, v}^{2}=W_{m, v}^{2}$ must be an irreducible affine Coxeter group which can be realized by a Cartan matrix not of zero type. By the third item of Lemma 8.2, only one family of irreducible affine Coxeter group satisfies this property: $\tilde{A}_{k}$ (see Table 7). After all, $W_{\infty, v}=\tilde{A}_{1} \times \tilde{A}_{k}$ virtually isomorphic to $\mathbb{Z}^{k+1}$, and therefore $k=d-2$.

Finally, the Coxeter polytope $P_{\infty, v}$ satisfies the hypothesis of Theorem 2.4, and so $P_{\infty, v}$ is isomorphic to $\hat{\Delta}_{\tilde{A}_{1} \times \tilde{A}_{d-2}}$, which is a prism.

## 9. How to make more examples

### 9.1. Some definitions.

Truncation. Let $\mathcal{G}$ be a combinatorial polytope, and let $v$ be a vertex of $\mathcal{G}$. A (combinatorial) truncation of $\mathcal{G}$ at $v$ is an operation that cuts the vertex $v$ (without touching the facets not containing $v$ ), creating a new facet in place of $v$ (see Figure 7). The truncated polytope of $\mathcal{G}$ at $v$ is denoted by $\mathcal{G}^{\dagger v}$. If $\mathcal{G}$ is a labeled polytope, then we attach the labels $\frac{\pi}{2}$ to all new ridges of $\mathcal{G}^{\dagger v}$, and we denote this new labeled polytope again by $\mathcal{G}^{\dagger v}$. Given a set $\mathcal{V}$ of vertices of $\mathcal{G}$, in a similar way, we define the truncated polytope $\mathcal{G}^{\dagger \mathcal{V}}$ of $\mathcal{G}$ at $\mathcal{V}$.


Figure 7. An example of truncation: $\mathcal{G} \leadsto \mathcal{G}^{\dagger v}$

If $P$ is a Coxeter polytope of $\mathbb{S}^{d}$ and $v$ is a vertex of $P$, then we can also define a (geometric) truncation applied to $P$ in the case when:

Definition 9.1. The vertex $v$ of $P$ is truncable if the projective subspace $\Pi_{v}$ spanned by the polars [ $b_{s}$ ] for all facets $s$ of $P$ containing $v$ is a hyperplane such that for every (closed) edge $e \ni v$, the set $\Pi_{\nu} \cap e$ consists of exactly one point in the interior of $e$.

Assume that a vertex $v$ of $P$ is truncable. Then a new Coxeter polytope $P^{\dagger v}$ can be obtained from $P$ by the following operation of truncation: Let $\Pi_{v}^{-}\left(\right.$resp. $\left.\Pi_{v}^{+}\right)$be the connected component of $\mathbb{S}^{d} \backslash \Pi_{v}$ which does not contain $v$ (resp. which contains $v$ ), and let $\overline{\Pi_{v}^{-}}$be the closure of $\Pi_{v}^{-}$. The underlying polytope of $P^{\dagger v}$ is $\overline{\Pi_{v}^{-}} \cap P$, which has one new facet given by the hyperplane $\Pi_{v}$ and the old facets given by $P$. The reflections about the old facets of $P^{\dagger v}$ are unchanged, and the reflection about the new facet is determined by the support $\Pi_{v}$ and the polar $v$. It is easy to see that the dihedral angles of the ridges in the new facet of $P^{\dagger v}$ are $\frac{\pi}{2}$.

Remark 9.2. The hyperplane $\Pi_{v}$ is invariant by the reflections about the facets of $P$ containing $v$, and thus the intersection $\Pi_{v} \cap P$ is a Coxeter polytope of $\Pi_{v}$ isomorphic to $P_{v}$. Also, note that the polytope $\overline{\Pi_{v}^{+}} \cap P$ is the pyramid over $\Pi_{v} \cap P$.

In a similar way, if $\mathcal{V}$ is a subset of the set of truncable vertices of $P$, then we define the truncated Coxeter polytope $P^{\dagger \mathcal{V}}$ of $P$ at $\mathcal{V}$. The following lemma is an easy corollary of Proposition 4.14 and Lemma 4.17 in Marquis [Mar14].

Lemma 9.3. Let $\mathcal{G}$ be a labeled polytope with Coxeter group $W$, and let $\mathcal{V}$ be a subset of the set of simple vertices of $\mathcal{G}$. Assume that $W$ is irreducible and for every $v \in \mathcal{V}$, the $v$-link Coxter group $W_{v}$ is Lannér. Then the map $\chi: \mathcal{G}(\mathcal{G}) \rightarrow \mathcal{G}\left(\mathcal{G}^{\dagger \mathcal{V}}\right)$ given by $\chi(P)=P^{\dagger \mathcal{V}}$ is well-defined and $\chi$ is a homeomorphism.

Remark 9.4. If $\mathcal{G}$ is a labeled polytope with only spherical and Lannér vertices and $\mathcal{V}$ is the set of Lannér vertices, then $\mathcal{G}^{\dagger \mathcal{V}}$ is perfect.

Gluing. Let $\mathcal{G}_{1}$ and $\mathcal{G}_{2}$ be two labeled $d$-polytopes, and let $v_{i}, i=1,2$, be a vertex of $\mathcal{G}_{i}$. If there is an isomorphism $f:\left(\mathcal{G}_{1}\right)_{v_{1}} \rightarrow\left(\mathcal{G}_{2}\right)_{v_{2}}$ as labeled polytope, then we can construct a new labeled $d$-polytope, denoted by $\mathcal{G}_{1 v_{1} \sharp v_{2}} \mathcal{G}_{2}$ (or simply $\mathcal{G}_{1} \sharp \mathcal{G}_{2}$ ), by gluing together two truncated polytopes $\mathcal{G}_{1}^{\dagger \nu_{1}}$ and $\mathcal{G}_{2}^{\dagger \nu_{2}}$ via $f$ (see Figure 8).


Figure 8. Gluing two 3-polytopes $\mathcal{G}_{1}$ and $\mathcal{G}_{2}$ along $v_{1}$ and $v_{2}$
Similarly, we can also define a (geometric) gluing applied to Coxeter polytopes: let $P_{1}$ and $P_{2}$ be Coxeter polytopes of $\mathbb{S}^{d}$ and let $v_{i}, i=1,2$, be a truncable vertex of $P_{i}$. If there is an isomorphism $g:\left(P_{1}\right)_{v_{1}} \rightarrow\left(P_{2}\right)_{v_{2}}$ as Coxeter polytopes, then the Coxeter polytope $P_{1} \sharp P_{2}$ is obtained by gluing two truncated polytopes $P_{1}^{\dagger \nu_{1}}$ and $P_{2}^{\dagger v_{2}}$ via $g$. For more details about truncation, we refer to [CLM].
9.2. Examples of truncable polytopes. In order to check whether the Coxeter group is relatively Gromov hyperbolic or not, we need the following theorem. Recall that if $(S, M)$ is a Coxeter system, then a subset $T$ of $S$ gives us a Coxeter subsystem $\left(T, M_{T}\right)$, where $M_{T}$ is the restrictioin of $M$ to $T$. Here, we abbreviate $\left(T, M_{T}\right)$ to $T$. If $s, t \in S$ are commuting elements of $W_{S}$, then we express this fact by writing $s \perp t$. In a natural way, we can understand the following notations: $S_{1} \perp S_{2}$ for $S_{1}, S_{2} \subset S$, and $U^{\perp}$ for $U \subset S$.

Theorem 9.5 (Moussong [Mou88] for Gromov hyperbolic case and Caprace [Cap09, Cap15]). Let $(S, M)$ be a Coxeter system, and let $\mathcal{T}$ be a collection of subsets of $S$. Then the group $W_{S}$ is Gromov hyperbolic relative to $\left\{W_{T} \mid T \in \mathcal{T}\right\}$ if and only if the following hold:

- If $U$ is an affine subsystem of $S$ of rank $\geqslant 3$, then $U \subset T$ for some $T \in \mathcal{T}$.
$\therefore$ If $S_{1}, S_{2}$ are irreducible non-spherical subsystems such that $S_{1} \perp S_{2}$, then $S_{1} \cup S_{2} \subset T$ for some $T \in \mathcal{T}$.
$\therefore$ If $T, T^{\prime}$ are two distinct elements of $\mathcal{T}$, then $T \cap T^{\prime}$ is a spherical subsystem of $S$.
$\because$ If $T \in \mathcal{T}$ and $U$ is an irreducible non-spherical subsystem of $T$, then $U^{\perp} \subset T$
First example. Let $P \in \mathcal{G}\left(\mathcal{G}_{m}^{2}\right)$ and let $\mathcal{V}$ be the set of the two Lannér vertices of $P$. By Lemma 9.3 , every vertex $v \in \mathcal{V}$ is truncable, and hence we obtain the perfect polytope $P^{\dagger \mathcal{V}}$.

Second example. Take the Coxeter group $U$ in the left diagram of Table 5. As in Section 3, we can label the product of two triangles according to the Coxeter diagram $U$ to obtain a labeled 4-polytope $\mathcal{G}_{U}$, which has 5 spherical vertices and 4 Lannér vertices. By Moussong's criterion (see Theorem 9.5), the Coxeter group $U$ is Gromov hyperbolic, however we will see that $U$ is not hyperbolizable, i.e. $U$ cannot be the Coxeter group of a hyperbolic Coxeter 4-polytope, by computing the deformation space of $\mathcal{G}_{U}$.


Table 5. Coxeter diagram of $U$ and $V$

We will compute the deformation space $\mathcal{C}\left(\mathcal{G}_{U}\right)$ of $\mathcal{G}_{U}$ and see that $\mathcal{C}\left(\mathcal{G}_{U}\right)$ satisfies the surprising property of being homeomorphic to a circle. In a way similar to Section 4, the deformation space $\mathcal{C}\left(\mathcal{G}_{U}\right)$ is homeomorphic to $\left\{(\lambda, \mu) \in \mathbb{R}^{2} \mid \lambda, \mu>0\right.$ and $\left.\operatorname{det}\left(A_{\lambda, \mu}\right)=0\right\}$, where:

$$
A_{\lambda, \mu}=\left(\begin{array}{cccccc}
2 & -\sqrt{2} & -\lambda^{-1} & & & \\
-\sqrt{2} & 2 & -1 & & & \\
-\lambda & -1 & 2 & -2 c_{5} & & \\
& & -2 c_{5} & 2 & -1 & -\mu^{-1} \\
& & & -1 & 2 & -\sqrt{2} \\
& & & -\mu & -\sqrt{2} & 2
\end{array}\right)
$$

A straightforward computation gives us:

$$
\begin{aligned}
\frac{1}{64} \operatorname{det}\left(A_{\lambda, \mu}\right) & =\left(1-\frac{1}{4}-\frac{1}{4}-\frac{1}{2}-\frac{1}{2} \frac{1}{2} \frac{\sqrt{2}}{2}\left(\lambda+\lambda^{-1}\right)\right)\left(-\frac{\sqrt{2}}{8}\left(\mu+\mu^{-1}\right)\right)-c_{5}^{2} s_{4}^{2} s_{4}^{2} \\
\frac{1}{2} \operatorname{det}\left(A_{\lambda, \mu}\right) & =\left(\lambda+\lambda^{-1}\right)\left(\mu+\mu^{-1}\right)-8 c_{5}^{2}
\end{aligned}
$$

In other words, the deformation space $\mathcal{E}\left(\mathcal{G}_{U}\right)$ is homeomorphic to:

$$
\left\{(\lambda, \mu) \in \mathbb{R}^{2} \mid \lambda, \mu>0 \text { and }\left(\lambda+\lambda^{-1}\right)\left(\mu+\mu^{-1}\right)-8 c_{5}^{2}=0\right\}
$$

which is homeomorphic to a circle (see Figure 9).


Figure 9. The deformation space $\mathcal{G}_{U}$
As a consequence, first $\mathcal{G}_{U}$ is not hyperbolizable since $\lambda=\mu=1$ is not in $\mathcal{C}\left(\mathcal{G}_{U}\right)$, and second we can answer the following question asked by Benoist if we weaken slightly the assumption:

Question 9.6. Is there a perfect labeled polytope $\mathcal{G}$ such that $\mathcal{G}$ can be realized as a hyperbolic Coxeter polytope and the deformation space $\mathcal{G}(\mathcal{G})$ is compact and is of dimension $\geqslant 1$ ?

Theorem 9.7. There exists a perfect labeled 4-polytope $\mathcal{G}$ such that $W_{\mathcal{G}}$ is Gromov hyperbolic and $\mathcal{G}(\mathcal{G})$ is homeomorphic to the circle.
Proof. Let $\mathcal{V}$ be the set of all Lannér vertices of $\mathcal{G}_{U}$. Then the truncated polytope $\mathcal{G}_{U}^{\dagger \mathcal{V}}$ is perfect, and by Lemma 9.3, $\mathcal{C}\left(\mathcal{G}_{U}^{\dagger \mathcal{V}}\right)=\mathscr{C}\left(\mathcal{G}_{U}\right)$, which is homeomorphic to the circle.

Remark that if we take the Coxeter group $V$ in the right diagram of Table 5 , then $\mathcal{C}\left(\mathcal{G}_{V}\right)$ is also homeomorphic to a circle and every Coxeter polytope $P \in \mathscr{C}\left(\mathcal{G}_{V}\right)$ is quasi-perfect and of finite volume. Note that the link of $\mathcal{G}_{V}$ at the vertex $v_{2345}$ has the Coxeter group:

which is the affine Coxeter group $\tilde{C}_{4}$ virtually isomorphic to $\mathbb{Z}^{3}$ (see Table 7).

### 9.3. Playing Lego.

First game. Let $N$ be an integer $\geqslant 2$, and let $T$ be a line tree with $N$ vertices, i.e. each vertex of $T$ is of valence 1 or 2 , and enumerate the vertices $t_{1}, \ldots, t_{N}$ of $T$. Choose $N$ integers

$m_{1}, \ldots, m_{N}>6$, and for each $i=1, \ldots, N$, select a Coxeter polytope $P_{i}$ from two polytopes in
$\mathcal{G}\left(\mathcal{G}_{m_{i}}^{2}\right)$ (see Section 4). Each $P_{i}$ has two truncable vertices whose links are isomorphic as Coxeter polytope because every Lannér vertex of $\mathcal{G}_{m_{i}}^{2}$ is rigid. Let $\mathcal{V}_{i}$ be the set of truncable vertices of $P_{i}$. If each vertex $t_{i}$ of $T$ corresponds to $P_{i}$, then the tree $T$ naturally gives us a pattern to glue the Coxeter polytopes $P_{i}^{\dagger \nu_{i}}, i=1, \ldots, N$, along the new facets of $P_{i}^{\dagger \nu_{i}}$ in order to obtain a perfect Coxeter 4-polytope $P_{m_{1}, \ldots, m_{N}}$. Remark that for each $t_{i}$, there are two possible positions of $P_{i}$.

If we make every $m_{i}$ go to infinity, then the limit $P_{\infty, \ldots, \infty}$ is a finite volume hyperbolic Coxeter 4-polytope with $N$ cusps. In other words, the Coxeter polytopes $P_{m_{1}, \ldots, m_{N}}$ are Dehn fillings of $P_{\infty}, \ldots, \infty$. An important remark is that since the choice of the integers $m_{1}, \ldots, m_{N}>6$ are independent each other, we can apply the Dehn filling operation to each cusp of $P_{\infty, \ldots, \infty}$ independently.

Second game. Choose two integers $N, N^{\prime} \geqslant 1$ and a tree $T$ with $N+N^{\prime}$ vertices such that $N$ vertices, denoted by $\left\{\tau_{1}, \ldots, \tau_{N}\right\}=: \tau$, are of valence 1 or 2 and $N^{\prime}$ vertices, denoted by $\left\{\tau_{1}^{\prime}, \ldots, \tau_{N^{\prime}}^{\prime}\right\}=: \tau^{\prime}$, are of valence $1,2,3$ or 4 . Select $N$ integers $m_{1}, \ldots, m_{N}>6$. For each vertex

$t \in \tau$ (resp. $\tau^{\prime}$ ), we put a Coxeter polytope $P_{i}$ (resp. $Q_{j}$ ) among the polytopes in $\mathcal{E}\left(\mathcal{G}_{m_{i}}^{2}\right)$ (resp. $\mathcal{G}\left(\mathcal{G}_{U}\right)$ ). Each Coxeter polytope $P_{i}$ (resp. $Q_{j}$ ) has two (resp. four) truncable rigid vertices, and all the links of $P_{i}$ and $Q_{j}$ at the truncable vertices are isomorphic to each other. Let $\mathcal{V}_{i}$ (resp. $\mathcal{V}_{j}^{\prime}$ ) be the set of truncable vertices of $P_{i}$ (resp. $Q_{j}$ ). Then the tree $T$ gives us a pattern to glue the Coxeter polytopes $P_{i}^{\dagger \nu_{i}}, i=1, \ldots, N$, and $Q_{j}^{\dagger \nu_{j}^{\prime}}, j=1, \ldots, N^{\prime}$, along their new facets in order to obtain a perfect Coxeter 4-polytope $P_{m_{1}, \ldots, m_{N}}^{\prime}$.

Once again, if every $m_{i}$ goes to infinity, then by Theorem 2.5, the limit polytope $P_{\infty, \ldots, \infty}^{\prime}$ is of finite volume in $\Omega_{P_{\infty}^{\prime}, \ldots, \infty}$. Remark that by Theorem 9.5 of Caprace, the Coxeter group of $P_{\infty, \ldots, \infty}^{\prime}$ is Gromov hyperbolic relative to the standard subgroups corresponding to the parabolic vertices of $P_{\infty, \ldots, \infty}^{\prime}$, however $P_{\infty, \ldots, \infty}^{\prime}$ is not hyperbolizable since $\mathcal{G}_{U}$ is not.

## 10. Higher dimensional examples

10.1. Tumarkin's classification. The simplest polytope is the simplex, however we know from Proposition 8.1 that a hyperbolic Coxeter $d$-polytope which allows us to get a Dehn filling must have a vertex whose link is a ( $d-1$ )-prism, but the simplex has only simple vertices.

The next simplest polytopes have $d+2$ facets, and Tumarkin [Tum04] classified all finite volume hyperbolic Coxeter $d$-polytopes with $d+2$ facets: They exist only in dimension $d \leqslant 17$, and among them, hyperbolic Coxeter $d$-polytopes $P_{\infty}$ with a $\tilde{A}_{1} \times \tilde{A}_{d-2}$ cusp exist only in dimension $d \leqslant 7$. In this paper, for prime examples, we restrict ourself to $d$-polytopes with $d+2$ facets, and thus Proposition 8.1 (or the work of Tumarkin) implies that the underlying
polytope of $P_{\infty}$ is $\operatorname{Pyr}\left(\Delta_{1} \times \Delta_{d-2}\right)$. We will see that the underlying polytopes of the Dehn fillings $P_{m}$ of $P_{\infty}$ are $\Delta_{2} \times \Delta_{d-2}$.
10.2. The labelling of the $\mathcal{G}_{m}$. In a way similar to Section 3, we can label the product of a ( $d-2$ )-simplex and a triangle according to each of the 12 families of Coxeter groups $\left(W_{m}\right)_{m \geqslant 7}$ in Tables $1 \mathrm{~B}, \mathrm{C}, \mathrm{D}$ in order to get a labeled polytope $\mathcal{G}_{m}$ :

First, let $a_{1}, \ldots, a_{d-1}$ be the vertices in the loop $\tilde{A}_{d-2}$ of $W_{m}$, and $b_{1}, b_{2}, b_{3}$ the remaining vertices of $W_{m}$. Next, denote the facets of the ( $d-2$ )-simplex by the same symbols $a_{1}, \ldots, a_{d-1}$ and the edges of the triangle by the symbols $b_{1}, b_{2}, b_{3}$. Then the symbols $a_{1}, \ldots, a_{d-1}, b_{1}, b_{2}, b_{3}$ are naturally assigned to the facets of $\Delta_{d-2} \times \Delta_{2}$. Finally, we obtain the labeled polytopes $\mathcal{G}_{m}$ with a ridge labelling on $\Delta_{d-2} \times \Delta_{2}$ according to $W_{m}$. The techniques we describe before can be easily extended to show:

Theorem 10.1. Choose one of the 12 families $\left(W_{m}\right)_{m \geqslant 7}$ in Tables 1 B,C,D. If the Coxeter graphs of the family have one loop, then $\mathcal{G}\left(\mathcal{G}_{m}\right)$ consists of two points. If the Coxeter graphs of the family have two loops, then $\mathcal{G}\left(\mathcal{G}_{m}\right)$ consists of two disjoints lines.

If $m=\infty$, then we can label a pyramid over a prism according to $W_{\infty}$ in order to obtain a labeled polytope $\mathcal{G}_{\infty}$. Eventually, we can show:

Theorem 10.2. Choose one of the 12 families $\left(W_{m}\right)_{m \geqslant 7}$ in Tables 1 B,C,D.

- Assume that the Coxeter graphs of the family have one loop. If $P_{m}$ is one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}\right)$, then the sequence $\left(P_{m}\right)_{m}$ converges to the unique hyperbolic polytope $P_{\infty}$ whose Coxeter graph is $W_{\infty}$.
- Assume that the Coxeter graphs of the family have two loops. If $\mu>0$ and $P_{m}$ is one of the two points of $\mathcal{G}\left(\mathcal{G}_{m}\right)$ such that $\mu\left(P_{m}\right)=\mu$, then $\left(P_{m}\right)_{m}$ converges to $P_{\infty}$ which is the unique Coxeter polytope such that $\mu\left(P_{\infty}\right)=\mu$ and whose Coxeter graph is $W_{\infty}$.

Proof of Theorems 10.1 and 10.2. We first need to compute $\mathcal{G}\left(\mathcal{G}_{m}\right)$, the proof is identical to the proof of Proposition 4.1, so we leave it to the reader. To help the reader do the actual computation, we remark that if $c_{1}, \ldots, c_{n}$ are real numbers and $D_{\lambda}$ is the determinant of the following matrix $M_{\lambda}$

$$
M_{\lambda}=\left(\begin{array}{cccccc}
2 & -c_{1} & & & & -c_{n} \lambda^{-1} \\
-c_{1} & 2 & -c_{2} & & & \\
& -c_{2} & 2 & -c_{3} & & \\
& & -c_{3} & 2 & \ddots & \\
& & & \ddots & 2 & -c_{n-1} \\
-c_{n} \lambda & & & & -c_{n-1} & 2
\end{array}\right)
$$

then we have the following equality:

$$
\left.D_{\lambda}=D_{1}-c_{1} c_{2} \cdots c_{n}\left(\left(\lambda+\lambda^{-1}\right)-2\right)\right)
$$

Now we need to check that $\mathcal{G}_{m}$ is the underlying labeled polytope of any Coxeter polytopes realizing $W_{m}$. In the case when $m=\infty$, there is a standard subgroup of $W_{\infty}$ that is an affine Coxeter group $\tilde{A}_{1} \times \tilde{A}_{d-2}$, and hence as in the proof of Corollary $5.2, P_{\infty}$ is a pyramid over a prism (see also Proposition 8.1).

In the case when $m<\infty$, we need to be more careful. The shortest path is probably to do a bit of book-keeping and to separate dimension 5 from dimensions 6,7 . If we denote by $\operatorname{Pyr}^{g}(Q)$ the pyramid over ... the pyramid over $Q$ ( $g$ times), then every $d$-polytope with $d+2$ facets is of the form $\operatorname{Pyr}^{g}\left(\Delta_{e} \times \Delta_{f}\right)$ with $e+f+g=d$ (see Section 6.5 of Ziegler [Zie95]). It is easy to show that $\mathrm{Pyr}^{g}\left(\Delta_{e} \times \Delta_{f}\right)$ is a polytope with $(e+1)(f+1)+g$ vertices and among them exactly $(e+1)(f+1)$ vertices are simple. Moreover, the number of edges of $\mathrm{Pyr}^{g}\left(\Delta_{e} \times \Delta_{f}\right)$ is $(e+1)(f+1)\left(g+\frac{e+f}{2}\right)+\frac{g(g-1)}{2}$.

First in dimension 6 or 7 , remark that the $3(d-1)$ standard subgroups of $W_{m}$ given by erasing one node of the $\tilde{A}_{d-2}$ loop and one node of the remaining part are spherical Coxeter groups of rank $d$. It follows that the Coxeter group $W_{m}$ contains at least $3(d-1)$ standard spherical subgroups of rank $d$, and by Theorem $4.2, P_{m}$ has at least $3(d-1)$ simple vertices.

However, a careful inspection shows that: if $d=6$ or 7 , then the only $d$-polytope with at least $3(d-1)$ vertices are: $\Delta_{2} \times \Delta_{4}, \Delta_{3} \times \Delta_{3}, \Delta_{2} \times \Delta_{5}$ and $\Delta_{3} \times \Delta_{4}$. In particular, $P$ must be simple, and we just have to eliminate the possibility of $\Delta_{3} \times \Delta_{3}$ and $\Delta_{3} \times \Delta_{4}$.

In order to so, we need to introduce the following: Let $S$ be the set of facets of a polytope $P$. A subset $A$ of $(k+1)$ elements of $S$ is $k$-adjacent if for every subset $B$ of $k$ elements of $A$, the intersection of the facets in $B$ is a $(d-k)$-dimensional face of $P$. Notice that for the polytope $\Delta_{e} \times \Delta_{f}$ with $e \leqslant f$, there is a $f$-adjacent subset of $(f+1)$ facets but no $(f+1)$-adjacent subset of $(f+2)$ facets. However, the Coxeter group $W_{m}$ contains $\tilde{A}_{d-2}$ and so by Theorem 4.2, there exists a ( $d-2$ )-adjacent subset of $(d-1)$ facets of $P_{m}$. As a consequence, $P$ must be $\Delta_{2} \times \Delta_{d-2}$.

Second, in dimension 5, we should remark that the 30 standard subgroups of $W_{m}$ given by erasing one node (resp. two nodes) of the $\tilde{A}_{3}$ loop and two nodes (resp. one node) of the remaining part are spherical of rank $d-1$. So the Coxeter group $W_{m}$ contains at least 30 standard spherical subgroups of rank $d-1$. By Theorem 4.2, this implies that $P_{m}$ has at least 30 edges. But, a careful inspection show that the only 5 -polytope with 7 -facets with at least 30 edges is $\Delta_{2} \times \Delta_{3}$.

Remark 10.3. The following is the reason why we separate the arguments for dimension 5 and dimensions 6,7: The right Coxeter group in Table 1B with $k=l=5$ has only 6 spherical subsystem of rank 5; and the polytope $\operatorname{Pyr}\left(\Delta_{3} \times \Delta_{3}\right)$ has 64 edges, however $\Delta_{2} \times \Delta_{5}$ has only 63 edges.
10.3. Nine examples in dimension 5. See the left diagram in Table 1B. If $p=3$, then the Coxeter polytopes $P_{m}$ with $m$ finite are perfect and $\Omega_{P_{m}}$ is not strictly convex nor with $\mathcal{C}^{1}$ boundary. The polytope $P_{\infty}$ is a quasi-perfect hyperbolic Coxeter polytope with one parabolic vertex.

If $p=4$, then the polytopes $P_{m}$ with $m$ finite are quasi-perfect with one parabolic vertex and $\Omega_{P_{m}}$ is not strictly convex nor with $\mathcal{C}^{1}$-boundary. The polytope $P_{\infty}$ is a quasi-perfect hyperbolic Coxeter polytope with two parabolic vertices.

If $p=5$, then the polytopes $P_{m}$ with $m$ finite are 2 -perfect with three rigid loxodromic vertices and $\Omega_{P_{m}}$ is not strictly convex. The polytope $P_{\infty}$ is a 2-perfect hyperbolic Coxeter polytope with one parabolic vertex and three rigid loxodromic vertices.

Now look at the right diagram in Table 1B. Here we will only mention the properties of the Coxeter polytope $P_{m}$ when $m$ is finite. When $(p, q)=(3,3)$, the Coxeter polytopes
$P_{m}$ are perfect. When $(p, q)=(4,3)$, the Coxeter polytopes $P_{m}$ are quasi-perfect with one parabolic vertex. When $(p, q)=(4,4)$, the Coxeter polytopes $P_{m}$ are quasi-perfect with two parabolic vertices. When $(p, q)=(5,3)$, the Coxeter polytopes $P_{m}$ are 2-perfect with three rigid loxodromic vertices. When $(p, q)=(5,4)$, the Coxeter polytopes $P_{m}$ are 2-perfect with one parabolic vertex and three rigid loxodromic vertices. Finally, when $(p, q)=(5,5)$, the Coxeter polytopes $P_{m}$ are 2-perfect with six rigid loxodromic vertices.

An important remark is that when $p=5$, we can apply the operation of truncation to $P_{m}$ in order to build infinitely many non-prime examples.
10.4. Two examples in dimension 6. The two Coxeter polytopes we find in dimension 6 are perfect when $m$ is finite (see Table1C). The following remark explains why we cannot contruct infinitely many non-prime examples in dimension $\geqslant 6$. In other words, it is hard to find truncable vertices of polytope of dimension $\geqslant 6$.

Remark 10.4. By the work of Lannér, we know that large perfect Coxeter simplex, which corresponds to Lannér Coxeter group, exists only up to dimension 4. However, Lemma 9.3 which is the starting point for truncation requires a truncable vertex to be simple, and hence the operation of truncation/gluing works only up to dimension 5. Remark that there exists a Coxeter polytope with a non-truncable non-simple loxodromic perfect vertex.
10.5. Two examples in dimension 7. The two Coxeter polytopes we find in dimension 7 are quasi-perfect when $m$ is finite (see Table 1D). Note $P_{m}$ is not perfect.

## 11. Proof of the main theorems

### 11.1. Proof of Theorem A.

Proof of Theorem A. In Sections 5 and 10, we provide finite volume hyperbolic Coxeter polytopes $P_{\infty}$ of dimension $d=4,5,6,7$ that admit Dehn fillings $\left(P_{m}\right)_{m \geqslant 7}$.

Here, we remark that since the Coxeter polytopes $\left(P_{m}\right)_{m \geqslant 7}$ and $P_{\infty}$ are quasi-perfect, by Theorem 8.2 of [Mar14], the convex domains $\left(\Omega_{m}\right)_{m \geqslant 7}$ (resp. $\Omega_{\infty}$ ) that are different from $\mathbb{S}^{d}$ and that are invariant by $\rho_{m}\left(W_{\infty}\right)$ (resp. $\rho_{\infty}\left(W_{\infty}\right)$ ) are unique.

Let $\left(S_{\infty}, M_{\infty}\right)$ be the Coxeter system of $P_{\infty}$. We know that the representations $\left(\rho_{m}\right)_{m \geqslant 7}$ converge algebraically to $\rho_{m}$, and therefore for each $s \in S_{\infty}$, the supports and the polars of reflections $\rho_{m}\left(\sigma_{s}\right)$ converges to the support and the polar of reflections $\rho_{\infty}\left(\sigma_{s}\right)$. It follows that the underlying projective polytopes of $\left(P_{m}\right)_{m \geqslant 7}$ converge to the underlying projective polytope of $P_{\infty}$ in the Hausdorff topology for the closed subsets of $\mathbb{S}^{d}$. Moreover, the properly convex closed subsets $\left(\bar{\Omega}_{m}\right)_{m \geqslant 7}$ of $\mathbb{S}^{d}$ converges to a convex closed set $K$ in some affine chart of $\mathbb{S}^{d}$ (up to subsequence), and so the uniqueness of $\rho_{\infty}\left(W_{\infty}\right)$-invariant convex domain $\Omega_{\infty}$ implies that $K=\bar{\Omega}_{\infty}$ and $\left(\Omega_{m}\right)_{m \geqslant 7}$ converges to $\Omega_{\infty}$.

### 11.2. Proof of Theorem B.

Proof of Theorem B. Let $W_{\infty}$ (resp. $W_{m}$ ) be the orbifold fundamental group of $\mathcal{O}_{\infty}\left(\right.$ resp. $\left.\mathcal{O}_{m}\right)$. By Selberg's Lemma, there is a torsion-free finite-index subgroup $\Gamma_{\infty}$ of $W_{\infty}$ such that the quotient $M_{\infty}=\Omega_{\infty} / \Gamma_{\infty}$ is a manifold. Let $\Gamma_{m}$ be the projection of $\Gamma_{\infty}$ via the surjective homomorphism $W_{\infty} \rightarrow W_{m}$. The subgroup $\Gamma_{m}$ of $W_{m}$ is of finite index bounded above by the index of $\Gamma_{\infty}$ in $W_{\infty}$, and the closed $d$-orbifolds $M_{m}=\Omega_{m} / \Gamma_{m}$ are Dehn fillings of $M_{\infty}$.

Remark 11.1. In the proof of Theorem B, the orbifold $M_{m}$ is not a manifold.
Proof of Remark 11.1. We can assume that $\Gamma_{\infty}$ is normal in $W_{\infty}$, i.e. $\Gamma_{m}$ is a finite-index normal subgroup of $W_{m}$. Assume for contradiction that $\Gamma_{m}$ is torsion-free. Since $\Gamma_{m}$ is torsionfree, the restriction of the homomorphism $W_{m} \rightarrow W_{m} / \Gamma_{m}$ to $D_{m}$ is injective. This implies that the index of $\Gamma_{m}$ inside $W_{m}$ is unbounded, which is a contradiction.
11.3. Proof of Theorems C, D and E. The main tools to prove Theorem C are Theorem 9.5 of Moussong-Caprace and a Theorem of Druţu-Sapir. We state a simplifed version of the main theorem in Druțu-Sapir [DS05]. Recall the definition of quasi-isometry: Let ( $X, d_{X}$ ) and $\left(Y, d_{Y}\right)$ be metric spaces. A map $f: X \rightarrow Y$ is called a ( $c, D$ )-quasi-isometric embedding if there exist constants $c \geqslant 1$ and $D \geqslant 0$ such that for all $x, x^{\prime} \in X$

$$
\frac{1}{c} d_{X}\left(x, x^{\prime}\right)-D \leqslant d_{Y}\left(f(x), f\left(x^{\prime}\right)\right) \leqslant c d_{X}\left(x, x^{\prime}\right)+D .
$$

Moreover, a quasi-isometric embedding $f: X \rightarrow Y$ is a quasi-isometry if there is $E>0$ such that the $E$-neighborhood of $f(X)$ is $Y$.

Theorem 11.2 (Druțu-Sapir [DS05]). Let $\Gamma$ be a Gromov hyperbolic group relative to a family $A_{1}, \ldots, A_{r}$ of infinite abelian subgroup of finite type. Let $\Lambda$ be a group of finite type and $B$ an abelian group of finite type.

- For every quasi-isometric embedding of $B$ into $\Gamma$, the image of $B$ is at bounded distance from a conjugate of $A_{i}$ for some $i$.
- If $\Lambda$ is quasi-isometric to $\Gamma$, then $\Lambda$ is Gromov hyperbolic relative to a family $B_{1}, \ldots, B_{s}$ of subgroups, each of which is quasi-isometric to $A_{i}$ for some $i$.

Proof of Theorem C. The fact that the group $\Gamma$ is Gromov hyperbolic relative to a family of subgroups virtually isomorphic to $\mathbb{Z}^{d-2}$ is an easy consequence of Theorem 9.5 of Caprace.

By Lemma 8.19 of Marquis [Mar14], the convex domain $\Omega$ contain a properly embedded ( $d-2$ )-simplex. Now, we show that the convex domain $\Omega$ does not contain a properly embedded $(d-1)$-simplex.

First, note that a $(d-1)$-simplex equipped with Hilbert metric is bilipshitz equivalent to the Euclidean space $\mathbb{R}^{d-1}$ (see de la Harpe [dlH93]). Second, since $\Gamma$ divides $\Omega$, by S̆varcMilnor lemma, the group $\Gamma$ is quasi-isometric to the metric space $\left(\Omega, d_{\Omega}\right)$. Hence, any properly embedded ( $d-1$ )-simplex induces a quasi-isometric embedding $f$ of $\mathbb{R}^{d-1}$ into $\Gamma$, which is Gromov hyperbolic to a family of subgroups virtually isomorphic to $\mathbb{Z}^{d-2}$. By the first item of Theorem 11.2, the embedding $f$ induces a quasi-isometric embedding of $\mathbb{R}^{d-1}$ into a peripheral $\mathbb{Z}^{d-2}$ of $\Gamma$, but there is no quasi-isometric embedding of $\mathbb{R}^{d-1}$ into $\mathbb{Z}^{d-2}$.

The quotient orbifold is not homeomorphic to a union along the boundaries of finitely many $d$-orbifolds each of which admits a finite volume hyperbolic structure on its interior because otherwise $\Gamma$ would be Gromov hyperbolic relative to a finite collection of subgroups virtually isomorphic to $\mathbb{Z}^{d-1}$, and $\Gamma$ is Gromov hyperbolic relative to a finite collection of subgroups virtually isomorphic to $\mathbb{Z}^{d-2}$, which contradicts the item 2 of Theorem 11.2.

Proof of Theorem D. See the Coxeter graphs of Table 2. Each of those Coxeter graph $W$ is obtained by linking a Coxeter subgraph $W_{l e f t}$ which is an $\tilde{A}_{2}, \tilde{A}_{3}$ or $\tilde{A}_{4}$ Coxeter graph to a disjoint Coxeter subgraph $W_{\text {right }}$ which is Lannér, by an edge with no label.

One can label the product $\mathcal{G}$ of two simplex $\Delta_{e} \times \Delta_{f}$ with $e$ (resp. $f$ ) being the rank of $W_{\text {left }}$ (resp. $W_{\text {right }}$ ) minus one using $W$ as in section 3 , after that the same computation as the one in section 4 shows that $\mathcal{C}(\mathcal{G})$ is two points if $W$ has one loop and two disjoints lines if $W$ has two loops.

The fact that $\mathcal{G}$ is perfect is a consequence of the fact that for every node $s$ of $W_{l e f t}$, and every node $t$ of $W_{\text {right }}$, the Coxeter group obtained by erasing the node $s$ and $t$ of $W$ is spherical.

Finally, the same arguments than for Theorem C show that the group $W$ is relatively hyperbolic and that $\Omega$ contains only tight properly embedded simplex of the expected dimension.

Proof of Theorem E. See the Coxeter graphs of Table 3. The only difference with Theorem D is that the computation that gives the existence of such Coxeter polytope is this time an extension of the computation of Remark 4.6.

## Appendix A. Useful Coxeter diagrams

A.1. Spherical and affine Coxeter diagram. The irreducible spherical and affine Coxeter group were classified by Coxeter [Cox34]. We reproduce the list of those Coxeter diagrams in Figures 6 and 7. We use the usual convention that an edge that should be labeled by 3 has in fact no label.
A.2. Lannér Coxeter groups. A Coxeter group associated to a large irreducible perfect simplex is called a Lannér Coxeter group, after Lannér [Lan50] first enumerated them in 1950. These groups are very limited, for example they exist only in dimension $2,3,4$, and there exist infinitely many in dimension 2,9 in dimension 3 and 5 in dimension 4 .
