### Labor Conflict as a Global Phenomenon: Issues and Implications

#### By Maxime Quijoux

Some social phenomena require more attention than others, especially while they are in full swing. The phenomenon of labor conflict<sup>1</sup> is one such. After having occupied since the 1960s a hegemonic place in the social sciences,<sup>2</sup> the theme of labor conflict has subsequently somewhat faded in France<sup>3</sup> and the rest of the world.<sup>4</sup> This loss of interest is generally explained by the demographic or political decline of the working class, eclipsed by a service society more inclined to negotiate.<sup>5</sup> In "a context marked by the reconfiguration of the economic crisis and labor force recomposition", it is of course difficult to "draw upon the categories of conflict and negotiation" that were in use fifty years ago.<sup>6</sup> However, research perspectives have also changed. Sociologists and political scientists have gradually abandoned labor mobilization for other objects and population categories, even in the framework of research on labor and social movements. Over the past decade, some French scholars have thus shown that, though conflict did not disappear from the companies in metropolitan France, the manner in which it is expressed has been transformed: strikes, for example, are shorter and less intense than in the past, partly replaced by other forms of expression and labor mobilization. 8 After having accepted, for some time, the idea of a decline in "materialist" mobilizations, particularly regarding wage issues, and their replacement by more "qualitative" ones, French political scientists now seem to have adopted a more cautious stance: instead of

thinking in terms of the replacement of one type of mobilization by another, they admit that the old model has persisted since the 1990s and note the porous boundaries between associative and employee organizations.<sup>9</sup>

Claims of pacification of labor relations, which are increasingly contested in the French academic field, seem simply inconceivable at an international level: since the mid-1990s, the number of disputes in Chinese companies has steadily risen<sup>10</sup> while in many countries and regions of the world labor-related conflicts and mobilizations are ever more intense and frequent.<sup>11</sup> Recent news testifies to this major unrest, which moreover only represents the most "visible" – because most widely reported – aspect of the global social conflict. Nor have "post-industrial" countries been spared occupational mobilizations, which may have taken different and even new forms in terms of their genesis and expression. Marked by the decline of industrial bastions, the gradual liberalization of labor codes and the emergence of the third sector, the present historic conjuncture

For twenty years, Bangladesh has experienced regular tragedies in its textile factories, the most serious being that of Rana Plaza, a building located near Dacca, which collapsed on 24 April 2013, causing the death of more than 1100 people and injuring more than 2000 more. The country has since experienced a series of mobilizations, particularly in the course of elections, accompanied by a wave of general strikes. This accident also provoked international mobilization, resulting in a series of specific actions, including the 15 May 2013 signature of an agreement regarding labor conditions and the standardization of the country's factories between the IndustriAll federation of European industries, Uni Global Union and a hundred clothing brands. forces workers and their organizations to engage in what is, in terms of both time and energy, an often long and costly process of adaptation. Often involving labor "communities" characterized by a strong tradition of labor union activism<sup>13</sup>, present-day sustained protests against restructuring and the massive general strikes set off by the 2008 financial crisis and its attendant policies have been accompanied by increased legal professionalization<sup>14</sup> of "traditional" labor union practices. At the same time, new forms of mobilization have gradually emerged and been seized upon by what were until recently "invisible" <sup>15</sup> and/or inexperienced populations. <sup>16</sup>

Faced with the persistence of this issue and the manner in which it has developed, this issue seeks to stimulate a new research dynamic. Given the limits of the present format and the still very incomplete nature of scholarship on this theme, this is less a matter of advancing theories than of exploring new avenues for existing debates. In this sense, the contributions brought together in this number put forward three particularly rich issues.

Causes and Repertories of Action: The Heuristic and Epistemological Virtues of a Decentered Approach

The past thirty years have witnessed a twofold dynamic characterized by the decline of the working class and the spread of precarious work among new categories of worker. This has led French social scientists to reconsider the causes and conditions of mobilization in the working world. After having taken note of the effects of the decline of the labor world on the plummeting number of workplace struggles, <sup>17</sup> the sociology of occupational mobilization has since the early 2000s turned its attention to what are most often described as "unlikely" mobilizations. <sup>18</sup> Because these

struggles are pursued under unstable employment and working conditions by actors who possess limited political skills and an ephemeral occupational identity, they disrupt objects of study, disciplinary frontiers and some analytic routines regarding the forms of labor mobilization. Given the nature of some political regimes and the absence of a labor code and/or labor union organizations in certain countries, international examinations of labor conflicts contribute – sometimes radically – to deconstructing our scholarly archetypes, which are often reduced to measuring strikes and the degree of wage integration.<sup>19</sup> In fact, the plurality and wealth of repertories of action – which include rioting (Raphaël Botiveau), multiple strategies for circumventing labor union repression (Quentin Delpech and Mathieu Hocquelet), appropriation of social movement strategies (Sophie Béroud)<sup>20</sup> and transnational campaigns<sup>21</sup> – allow one, not only to better account for the "evolving dynamics of conflicts, negotiations and actors behind them",<sup>22</sup> but also to shed light on their specific properties. Moreover, bringing an international perspective to bear on labor conflict also provides a different in-depth vision of the manner in which these repertories circulate<sup>23</sup> and the links among the various actors in these struggles. Here, too, we are invited to move beyond our customary analytic frameworks.

### Rethinking the Field of Industrial Relations

Three main actors are traditionally represented in the analysis of labor conflicts: workers and/or their representatives, employers and public authorities.<sup>24</sup> The importance given to the production of rules and institutions – from their genesis to their effects on the working world – has led researchers to make law and negotiation central notions, alongside conflict and strike, for understanding the strategies developed by these various actors.<sup>25</sup> Since the mid-1980s, the effects

of the globalization of exchange and the emergence of new commercial and institutional spaces – first and foremost, the European Union – have significantly modified this approach. In line with analyses of the decline of industrial bastions, many observers have thus underscored the inability of labor union organizations to adjust their analytical frameworks and methods of struggle in keeping with ever more volatile capital movements. Others, by contrast, have endeavored to account for the manner in which the various actors have attempted to produce new norms and actions in keeping with gradually emergent economic and political configurations. New rules and novel measures have emerged, reinforcing the shift from an activist-centered labor unionism to an expert – indeed, technocratic – one. Once again, the internationalization of "labor conflict" has permitted decentering, which in turn has allowed new research perspectives to be identified.

A simple preliminary observation justifies this: many labor conflicts appear in political and social contexts in which the system of professional relations is ineffective due to the lack of a formal labor market, a regulatory state and/or independent social partners.<sup>29</sup> There have certainly been efforts – mainly in Europe<sup>30</sup> – to form transnational representative institutions but these have stumbled against the absence of employers' organizations and the difficulties for professional organizations to move beyond the national framework.<sup>31</sup> As a consequence, "traditional" institutions cede the international scene to a collection of actors whose particularity is often the fact that they are external to both the national framework and the particular economic sector. More sharply than in the context of metropolitan France,<sup>32</sup> the international perspective on labor conflicts sheds light on the porous boundaries between the associative and professional worlds as well as that of international institutions.<sup>33</sup> Does the international scale for all that disqualify the professional relations approach? Despite its difficulties, labor union action continues and the

gradual emergence of new "mega" structures<sup>34</sup> (whose involvement in recent negotiations<sup>35</sup> and international actions<sup>36</sup> has had national and global repercussions) argues for redefining the field of these professional relations – its actors as well as their roles and interactions – rather than abandoning it.

#### An International Relations Issue

Finally, the international approach to labor conflict leads us to reconsider its political dimension. Since the fall of the Berlin Wall and the collapse of the Soviet Union, scholarly and lay perceptions of labor as a space of social tension and an arena of democratic struggle have significantly declined. On the national and international scene, the growing place occupied by patriotic<sup>37</sup> and religious rhetoric since the early 2000s has pushed the social question to the political margins. At the start of the present decade, it resurfaced in the countries of North Africa and the Mideast – regions nevertheless "known" as strongholds of nationalism and religion. In a context less marked by economic slowdown than by the "crisis of the social authoritarian state",<sup>38</sup> the revolts that shook these regions were driven by job scarcity and disturbances in the "traditional" forms of employment access.<sup>39</sup> Taken alone, the issue of labor does not, it is true, explain the genesis of these revolts<sup>40</sup> or the array of countries<sup>41</sup> affected by them. Yet it can be argued that it has been a major cause of the political transformations that have taken place in them. This makes our object

of investigation a genuine question of international relations. However, the democratic and global dimensions of labor conflict are not limited to the emblematic case of the "Arab Spring" uprisings. They manifest themselves elsewhere as well, particularly in countries that supply cheap labor. Indeed, the competitiveness of these countries is very often predicated on a concentration of economic and political power that is reflected, among other things, in the absence of protection and rights both within and outside of companies. It is therefore not unusual for general strikes to accompany elections or for wage demands to be mixed with political slogans as in Cambodia and Bangladesh. While these conflicts have not spread throughout their respective regions, for historical and cultural reasons, their particular struggles have assumed other forms and have been internationalized, with global repercussions. For, in the aftermath of some industrial disasters, the attempts of Western mobilization entrepreneurs to hold companies responsible for the labor conditions of their contract manufacturers in producer countries have had a series of national and international consequences. Although they are in an embryonic state and can thus still be perfected (Q. Delpech), 42 these campaigns have – in terms both of their forms 43 and their results – produced novel modes for regulating the international division of labor, ones that remain to be measured and examined. In a global market that remains profoundly anomic, such conflicts are just the "visible" portion of these mobilizations. It is thus imperative that a central role once again be accorded to labor – alongside the economy, nationalism and religion – in efforts to understand the current dynamics of contemporary societies.<sup>44</sup>
