# Existence of guided waves due to a lineic perturbation of a 3D periodic medium

#### Abstract

In this note, we exhibit a three dimensional structure that permits to guide waves. This structure is obtained by a geometrical perturbation of a 3D periodic domain that consists of a three dimensional grating of equi-spaced thin pipes oriented along three orthogonal directions. Homogeneous Neumann boundary conditions are imposed on the boundary of the domain. The diameter of the section of the pipes, of order $\varepsilon>0$, is supposed to be small. We prove that, for $\varepsilon$ small enough, shrinking the section of one line of the grating by a factor of $\sqrt{\mu}(0<\mu<1)$ creates guided modes that propagate along the perturbed line. Our result relies on the asymptotic analysis (with respect to $\varepsilon$ ) of the spectrum of the Laplace-Neumann operator in this structure. Indeed, as $\varepsilon$ tends to 0 , the domain tends to a periodic graph, and the spectrum of the associated limit operator can be computed explicitly.

## 1 Statement of the problem

Let $\omega_{1}, \omega_{2}$ and $\omega_{3}$ be three Lipschitz bounded domains of $\mathbb{R}^{2}$ of same area $\left(\left|\omega_{1}\right|=\left|\omega_{2}\right|=\left|\omega_{3}\right|\right)$ containing the origin $(0,0)$, let $\varepsilon>0$ be a parameter (that is going to be small), and let $a_{1}, a_{2}$ and $a_{3}$ be three positive real numbers. We denote by $\left(\mathbf{e}_{i}\right)_{i \in\{1,2,3\}}$, the standard basis of $\mathbb{R}^{3}$. For any $(k, \ell) \in \mathbb{Z}^{2}$, we consider the three dimensional domain $D_{k, \ell, 3}^{\varepsilon}$ defined by

D_{k, \ell, 3}^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3} \text { such that }\left(\left(x_{1}-a_{1} k\right) / \varepsilon,\left(x_{2}-a_{2} \ell\right) / \varepsilon\right) \in \omega_{3}\right\}
$$

which is an unbounded cylinder of constant cross section $\varepsilon \omega_{3}$. It is infinite along the $\mathbf{e}_{3}$ direction (invariant with respect to $\left.x_{3}\right)$ and contains the point $\left(a_{1} k, a_{2} \ell, 0\right)$. Similarly, for any $(k, \ell) \in \mathbb{Z}^{2}$, we define the domains

& D_{k, \ell, 2}^{\varepsilon}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \mathbb{R}^{3} \text { such that }\left(\left(x_{1}-a_{1} k\right) / \varepsilon,\left(x_{3}-a_{3} \ell\right) / \varepsilon\right) \in \omega_{2}\right\}
\end{aligned}
$$

and we consider the periodic domain $\Omega_{\varepsilon}$ given by

\Omega_{\varepsilon}=\bigcup_{i \in\{1,2,3\}} \bigcup_{(k, \ell) \in \mathbb{Z}^{2}} D_{k, \ell, i}^{\varepsilon} \tag{1}
\end{equation*}
$$

The domain $\Omega_{\varepsilon}$ is a three dimensional grating of equi-spaced parallel pipes (of constant cross section) oriented along the three orthogonal directions $\mathbf{e}_{1}, \mathbf{e}_{2}$ and $\mathbf{e}_{3}$. It is $a_{j}$-periodic with respect to $x_{j}, j=1,2,3$. Moreover, the points $\left(k a_{1}, \ell a_{2}, m a_{3}\right),(k, \ell, m) \in \mathbb{Z}^{3}$, belong to $\Omega_{\varepsilon}$.

In order to create guided modes, we introduce a linear defect (see [1]-[5]-[2]) in the periodic structure by modifying the section size of one pipe of the grating (it is conjectured that guided modes cannot appear in the purely periodic structure, see [4] for the proof in the case of a symmetric medium). More precisely, we assume that the domain $D_{0,0,3}^{\varepsilon}$ is replaced with the domain

$$

where $\mu$ is a positive parameter. In other words, we enlarge $(\mu>1)$ or shrink $(0<\mu<1)$ the section of one pipe of the domain by a factor $\mu$ (see Fig 1a). The corresponding perturbed domain is denoted by $\Omega_{\varepsilon}^{\mu}$. Its precise definition is given by

\Omega_{\varepsilon}^{\mu}=\left(\bigcup_{i \in\{1,2\}} \bigcup_{(k, \ell) \in \mathbb{Z}^{2}} D_{k, \ell, i}^{\varepsilon}\right) \bigcup\left(\bigcup_{(k, \ell) \in \mathbb{Z}^{2} \backslash\{(0,0)\}} D_{k, \ell, 3}^{\varepsilon}\right) \bigcup D_{0,0,3}^{\varepsilon, \mu} . \tag{2}
\end{equation*}

$\Omega_{\varepsilon}^{\mu}$ is still $a_{3}$-periodic with respect to $x_{3}$. However, the presence of the perturbed pipe $D_{0,0,0}^{\varepsilon, \mu}$ breaks the periodicity with respect to $x_{1}$ and $x_{2}$. We emphasize that the domain $\Omega_{\varepsilon}^{\mu}$ (as well as $\Omega_{\varepsilon}$ ) tends to a 3 D periodic graph as $\varepsilon$ tends to 0 .

We look for guided modes, i.e. solutions to the wave equation $\partial_{t}^{2} u-\Delta u=0$ in $\Omega_{\varepsilon}^{\mu}$, satisfying homogeneous Neumann boundary conditions on $\partial \Omega_{\varepsilon}^{\mu}$ (see [7] for the investigation of the Dirichlet case), that propagate along the defect pipe $D_{0,0,0}^{\varepsilon, \mu}$ (i.e. in the $\mathbf{e}_{3}$ direction) but stay confined in the transversal directions. More precisely, denoting by $B_{\varepsilon}^{\mu}$ the restriction of the domain $\Omega_{\varepsilon}^{\mu}$ to the band $\left|x_{3}\right|<a_{3} / 2$,

we search solutions of the form $u\left(x_{1}, x_{2}, x_{3}, t\right)=v\left(x_{1}, x_{2}, x_{3}\right) e^{i \omega t-\beta x_{3}}$, where $\beta$ is a real parameter and $v\left(x_{1}, x_{2}, x_{3}\right) \in$ $L_{2}\left(B_{\varepsilon}^{\mu}\right)$ is an $a_{3}$-periodic function in $x_{3}$. In fact, it is easily seen that the $\beta$-quasiperiodic fonction $v\left(x_{1}, x_{2}, x_{3}\right) e^{-i \beta x_{3}}$ is an eigenfunction of the operator

with $D\left(A_{\varepsilon}^{\mu}(\beta)\right)=\left\{u \in H_{\Delta}^{1}\left(B_{\varepsilon}^{\mu}\right),\left.u\right|_{\Sigma^{+}}=\left.e^{-i \beta} u\right|_{\Sigma^{-}},\left.\partial_{x_{3}} u\right|_{\Sigma^{+}}=\left.e^{-i \beta} \partial_{x_{3}} u\right|_{\Sigma^{-}},\left.\partial_{n} u\right|_{\partial B_{\varepsilon}^{\mu} \backslash \Sigma^{ \pm}}=0\right\}$, where

H_{\Delta}^{1}\left(B_{\varepsilon}^{\mu}\right)=\left\{u \in H^{1}\left(B_{\varepsilon}^{\mu}\right), \text { s.t. } \Delta u \in L_{2}\left(B_{\varepsilon}^{\mu}\right)\right\} \text { and } \Sigma^{ \pm}=\left\{\left(x_{1}, x_{2}, x_{3}\right) \in \partial B_{\varepsilon}^{\mu}, x_{3}= \pm a_{3} / 2\right\}

To study the spectral properties of $A_{\varepsilon}^{\mu}(\beta)$, we investigate its (formal) limit $\mathcal{A}^{\mu}(\beta)$ as $\varepsilon$ tends to 0 . The operator $\mathcal{A}^{\mu}(\beta)$ is defined on the limit graph $\mathcal{G}$ (see Fig. 1b) and its spectrum can be explicitly computed. In particular, its spectrum has infinitely many gaps (Lemma 2.1), i.e. open intervals $(a, b) \subset \mathbb{R}$ such that the intersection of $[a, b]$ with the spectrum is reduced to $\{a, b\}$. Moreover, for $\mu<1$, there is at least one eigenvalue in each gap (Lemma 2.5). Since, in addition, for $\varepsilon>0$ sufficiently small, the spectrum of $A_{\varepsilon}^{\mu}(\beta)$ is close to the spectrum of $\mathcal{A}^{\mu}(\beta)$, the existence of guided modes is guaranteed (Theorem 3.1).

## 2 The spectrum of the limit operator $\mathcal{A}^{\mu}(\beta)$

### 2.1 Definition of the limit operator $\mathcal{A}^{\mu}(\beta)$

The limit operator $\mathcal{A}^{\mu}(\beta)$ is defined on the infinite periodic graph $\mathcal{G}=\bigcap_{\varepsilon>0} B_{\varepsilon}^{\mu}$ obtained as the limit of $B_{\varepsilon}^{\mu}$ as $\varepsilon$ tends to $0: \mathcal{G}$ is made of the vertices $\left\{v_{k, \ell}=\left(k a_{1}, \ell a_{2}, 0\right), v_{k, \ell}^{ \pm}=\left(k a_{1}, \ell a_{2}, \pm a_{3} / 2\right),(k, \ell) \in \mathbb{Z}^{2}\right\}$ connected by the edges

\left\{e_{k+1 / 2, \ell}=\left(v_{k, \ell}, v_{k+1, \ell}\right), \quad e_{k, \ell+1 / 2}=\left(v_{k, \ell}, v_{k, \ell+1}\right), \quad e_{k, \ell}^{ \pm}=\left(v_{k, \ell}, v_{k, \ell}^{ \pm}\right), \quad(k, \ell) \in \mathbb{Z}^{2}\right\}
$$

It is $a_{1}$-periodic with respect to $x_{1}$ and $a_{2}$-periodic with respect to $x_{2}$ (see Fig. 1b).
For any function $u$ defined on $\mathcal{G}$, we denote by $\mathbf{u}_{k, \ell}$ (resp. $\mathbf{u}_{k, \ell}^{ \pm}$) its value at the vertex $v_{k, \ell}$ (resp. $v_{k, \ell}^{ \pm}$). The restriction of $u$ to the edge $e_{k+1 / 2, \ell}$ (resp. $e_{k, \ell+1 / 2}$ and $e_{k, \ell}^{ \pm}$) is denoted by $u_{k+1 / 2, \ell}\left(x_{1}\right)$ (resp. $u_{k, \ell+1 / 2}\left(x_{2}\right)$ and $\left.u_{k, \ell}^{ \pm}\left(x_{3}\right)\right)$.

The definition of $\mathcal{A}^{\mu}(\beta)$ also requires the introduction of the function spaces $L_{2}^{\mu}(\mathcal{G})$ and $H^{2}(\mathcal{G})$ defined as

and, for any $(k, \ell) \in \mathbb{Z}^{2}, w_{k, \ell}^{\mu}$ is the weight coefficient equal to $\mu$ for $k=\ell=0$ and 1 otherwise.
The unbounded limit operator in $L_{2}^{\mu}(\mathcal{G})$ has domain

& \left.u_{k+\frac{1}{2}, \ell}^{\prime}\left(k a_{1}\right)-u_{k-\frac{1}{2}, \ell}^{\prime}\left(k a_{1}\right)+u_{k, \ell+\frac{1}{2}}^{\prime}\left(\ell a_{2}\right)-u_{k, \ell-\frac{1}{2}}^{\prime}\left(\ell a_{2}\right)+w_{k, \ell}^{\mu}\left(\left(u_{k, \ell}^{+}\right)^{\prime}(0)-\left(u_{k, \ell}^{-}\right)^{\prime}(0)\right)=0\right\} \tag{8}

and is defined by

\forall u \in D\left(\mathcal{A}^{\mu}(\beta)\right), \quad \mathcal{A}^{\mu}(\beta) u=-u^{\prime \prime} \quad \text { on any edge of the graph } \mathcal{G} . \tag{9}
\end{equation*}

The functions of $D\left(\mathcal{A}^{\mu}(\beta)\right)$ are continuous on $\mathcal{G}$ and $\beta$ quasi-periodic. Moreover, they satisfy the Kirchhoff conditions (8) that enforce the weighted sum of the outward derivatives of $u$ to vanish at each vertex $v_{k, \ell}\left((k, \ell) \in \mathbb{Z}^{2}\right)$. We point out that the perturbation, which results from a geometrical modification of the domain for the problem (4), is taken into account at the limit by means of the Kirchhoff condition (8) at the vertex $v_{0,0}\left(w_{0,0}^{\mu}=\mu\right)$. The formal derivation of the limit model can be found in [6]. It is easily verified that the operator $\mathcal{A}^{\mu}(\beta)$ is self-adjoint (for the weighted scalar product associated with (6)), see also [3]. The objective of the following two sections is to study the spectrum of $\mathcal{A}^{\mu}(\beta)$.

### 2.2 Characterization and properties of the essential spectrum of $\mathcal{A}^{\mu}(\beta)$

By a compact perturbation argument, one can prove that $\sigma_{\text {ess }}\left(\mathcal{A}^{\mu}(\beta)\right)=\sigma(\mathcal{A}(\beta))$, where $\mathcal{A}(\beta)=\mathcal{A}^{1}(\beta)$ is the purely periodic operator corresponding to $\mathcal{A}^{\mu}(\beta)$ for $\mu=1$. The computation of its spectrum relies on the Floquet-Bloch theory (see [9]). More precisely, we can prove that $\lambda=\omega^{2} \in \sigma(\mathcal{A}(\beta))$ if and only if either $\omega=0$ and $\beta=0$ or $\omega \neq 0$ and there exists $\left(k_{1}, k_{2}\right) \in[0, \pi]^{2}$ such that

Based on the previous characterization, we prove that the operator $\mathcal{A}(\beta)$ has a countable infinity of gaps that can be separated into three categories (see [10] for the proof):

Lemma 2.1 The following properties hold:
1- $\sigma_{1} \cup \sigma_{2} \cup \sigma_{3} \subset \sigma(\mathcal{A}(\beta))$, where

\sigma_{i}=\left\{\left(\pi n / a_{i}\right)^{2}, n \in \mathbb{Z}\right\} \text { for } i \in\{1,2\}, \text { and } \sigma_{3}=\left\{\left(( \pm \beta+2 \pi n) / a_{3}\right)^{2}, n \in \mathbb{Z}\right\}
$$

2- For any $\beta \in[0, \pi]$, the operator $\mathcal{A}(\beta)$ has infinitely many gaps whose ends tend to infinity.
3- Let $\mathcal{W}(\beta)=\left\{\pi n / a_{3}, n \in \mathbb{N}^{*}\right\}$ if $\beta \notin\{0, \pi\}$ and $\mathcal{W}(\beta)=\left\{\beta / a_{3}+(2 n+1) \pi / a_{3}, n \in \mathbb{N}^{*}\right\}$ if $\beta \in\{0, \pi\}$,.
If an interval $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ is a spectral gap of $\mathcal{A}(\beta)$, then, one of the following possibilities holds:
(i) $\omega_{b}^{2} \notin \sigma_{1} \cup \sigma_{2}, \omega_{t}^{2} \notin \sigma_{1} \cup \sigma_{2}$, and there is a unique $\omega_{0} \in\left(\omega_{b}, \omega_{t}\right) \cap \mathcal{W}(\beta)$.
(ii) $\omega_{b}^{2} \in \sigma_{1} \cup \sigma_{2}, \omega_{t}^{2} \notin \sigma_{1} \cup \sigma_{2}$ and $\mathcal{W}(\beta) \cap\left(\omega_{b}, \omega_{t}\right)=\varnothing$.
(iii) $\omega_{b}^{2} \notin \sigma_{1} \cup \sigma_{2}, \omega_{t}^{2} \in \sigma_{1} \cup \sigma_{2}$ and $\mathcal{W}(\beta) \cap\left(\omega_{b}, \omega_{t}\right)=\varnothing$.

### 2.3 Computation of the discrete spectrum

Let us now determine the discrete spectrum of $\mathcal{A}^{\mu}(\beta)$. If $\lambda=\omega^{2}$ is an eigenvalue of $\mathcal{A}^{\mu}(\beta)$, then the corresponding eigenfunction $u \in D\left(\mathcal{A}^{\mu}(\beta)\right)$ satisfies the linear differential equation $u^{\prime \prime}+\omega^{2} u=0$ on each edge of the graph $\mathcal{G}$. Solving explicitly this equation (on each edge), taking into account the quasi-periodicity of $u$ and the Kirchhoff conditions (8), we can replace the eigenvalue problem $\mathcal{A}^{\mu}(\beta) u=\lambda u$ with a set of finite differences equations for $\left(\mathbf{u}_{\ell, k}\right)_{(\ell, k) \in \mathbb{Z}^{2}}$ :

Lemma 2.2 Assume that $\omega \notin\left\{\pi \mathbb{Z} / a_{1}\right\} \cup\left\{\pi \mathbb{Z} / a_{2}\right\} \cup\left\{\pi \mathbb{Z} / a_{3}\right\} . u \in D\left(\mathcal{A}^{\mu}(\beta)\right)$ is an eigenfunction of $\mathcal{A}^{\mu}(\beta)$ if and only if $\left(\mathbf{u}_{k, \ell}\right)_{(k, \ell) \in \mathbb{Z}^{2}}$ belongs to $\ell_{2}\left(\mathbb{Z}^{2}\right)$ and satisfies

\frac{\mathbf{u}_{k+1, \ell}}{\sin \left(\omega a_{1}\right)}+\frac{\mathbf{u}_{k-1, \ell}}{\sin \left(\omega a_{1}\right)}+\frac{\mathbf{u}_{k, \ell+1}}{\sin \left(\omega a_{2}\right)}+\frac{\mathbf{u}_{k, \ell-1}}{\sin \left(\omega a_{2}\right)}-2 g_{\beta}(\omega) \mathbf{u}_{k, l}=0, \quad \forall(k, \ell) \in \mathbb{Z}^{2} \backslash\{(0,0)\}  \tag{11}\\
\frac{\mathbf{u}_{1,0}}{\sin \left(\omega a_{1}\right)}+\frac{\mathbf{u}_{-1,0}}{\sin \left(\omega a_{1}\right)}+\frac{\mathbf{u}_{0,1}}{\sin \left(\omega a_{2}\right)}+\frac{\mathbf{u}_{0,-1}}{\sin \left(\omega a_{2}\right)}-2 g_{\beta}(\omega) \mathbf{u}_{0,0}=2(\mu-1) \frac{\cos \left(\omega a_{3}\right)-\cos \beta}{\sin \left(\omega a_{3}\right)} \mathbf{u}_{0,0}
\end{array}\right.
$$

where we have defined $g_{\beta}(\omega)=\frac{1}{\tan \left(\omega a_{1}\right)}+\frac{1}{\tan \left(\omega a_{2}\right)}+\frac{\cos \left(\omega a_{3}\right)-\cos \beta}{\sin \left(\omega a_{3}\right)}$.
As well-known, finite difference schemes may be investigated using the discrete Fourier transform

$$
\begin{equation*}
\mathcal{F}: \mathbf{v}=\left(\mathbf{v}_{k, \ell}\right)_{(k, \ell) \in \mathbb{Z}^{2}} \mapsto \mathcal{F}(\mathbf{v})=\widehat{\mathbf{v}}, \quad \widehat{\mathbf{v}}(\xi, \eta)=\sum_{k, \ell \in \mathbb{Z}} e^{i(k \xi+\ell \eta)} \mathbf{v}_{k, \ell}, \quad(\xi, \eta) \in[0,2 \pi]^{2} \tag{12}
\end{equation*}
$$

where $\mathcal{F}$ is an isometry between $\ell_{2}\left(\mathbb{Z}^{2}\right)$ and $L_{2}\left((0,2 \pi)^{2}\right)$. This, together with Lemma 2.2, provides the following characterization for the discrete spectrum of $\mathcal{A}^{\mu}(\beta)$ :

Lemma 2.3 Assume that $\omega \notin\left\{\pi \mathbb{Z} / a_{1}\right\} \cup\left\{\pi \mathbb{Z} / a_{2}\right\} \cup\left\{\pi \mathbb{Z} / a_{3}\right\} . u \in D\left(\mathcal{A}^{\mu}(\beta)\right)$ is an eigenfunction of $\mathcal{A}^{\mu}(\beta)$ if and only if the discrete Fourier transform $\widehat{\mathbf{u}}$ of $\left(\mathbf{u}_{\ell, k}\right)_{(\ell, k) \in \mathbb{Z}^{2}}$ belongs to $L_{2}\left((0,2 \pi)^{2}\right)$ and satisfies

$$
\begin{equation*}
\left(f(\xi, \eta, \omega)-\phi_{\beta}(\omega)\right) \widehat{\mathbf{u}}(\xi, \eta)=(\mu-1) \phi_{\beta}(\omega) \mathbf{u}_{0,0} \tag{13}
\end{equation*}
$$

where $\phi_{\beta}(\omega)=\frac{\cos \left(\omega a_{3}\right)-\cos \beta}{\sin \left(\omega a_{3}\right)}$ and $f(\xi, \eta, \omega)=\frac{\cos \xi-\cos \left(\omega a_{1}\right)}{\sin \left(\omega a_{1}\right)}+\frac{\cos \eta-\cos \left(\omega a_{2}\right)}{\sin \left(\omega a_{2}\right)}$.
Under the assumption of Lemma 2.3, (10) can be written as $f(\xi, \eta, \omega)-\phi_{\beta}(\omega)=0$. It follows that $\lambda=\omega^{2}$ does not belong to $\sigma_{\text {ess }}\left(\mathcal{A}^{\mu}(\beta)\right)$ if and only if, for any $(\xi, \eta) \in[0,2 \pi]^{2}, \phi_{\beta}(\omega)-f(\xi, \eta, \omega)$ does not vanish. As a consequence, as soon as $\lambda=\omega^{2} \notin \sigma_{\text {ess }}\left(\mathcal{A}^{\mu}(\beta)\right)$, the function $(\xi, \eta) \mapsto \phi_{\beta}(\omega) /\left(\phi_{\beta}(\omega)-f(\xi, \eta, \omega)\right)$ is continuous and bounded. Then, the inverse discrete Fourier transform can be applied to (13) to obtain

$$
\mathbf{u}_{k, \ell}=\frac{(1-\mu) \mathbf{u}_{0,0}}{4 \pi^{2}} \int_{(0,2 \pi)^{2}} \frac{\phi_{\beta}(\omega)}{\phi_{\beta}(\omega)-f(\xi, \eta, \omega)} e^{-i(k \xi+\ell \eta)} d \xi d \eta, \quad \forall(k, \ell) \in \mathbb{Z}^{2}
$$

Writing the previous relation for $k=\ell=0$ yields the following criterion of existence of an eigenvalue:

Lemma 2.4 Assume that $\omega \notin\left\{\pi \mathbb{Z} / a_{1}\right\} \cup\left\{\pi \mathbb{Z} / a_{2}\right\} \cup\left\{\pi \mathbb{Z} / a_{3}\right\}$ and that $\lambda=\omega^{2} \notin \sigma_{\text {ess }}\left(\mathcal{A}^{\mu}(\beta)\right)$. Then, $\lambda$ is an eigenvalue of $\mathcal{A}^{\mu}(\beta)$ if and only if

$$
\begin{equation*}
\mu=1-F_{\beta}(\omega) \quad \text { where } \quad F_{\beta}(\omega)=\left(\frac{1}{4 \pi^{2}} \int_{(0,2 \pi)^{2}} \frac{\phi_{\beta}(\omega)}{\phi_{\beta}(\omega)-f(\xi, \eta, \omega)} d \xi d \eta\right)^{-1} \tag{14}
\end{equation*}
$$

The study of the behavior of the function $F_{\beta}$ leads to the existence of at least one eigenvalue in each gap of $\mathcal{A}^{\mu}(\beta)$ as soon as $\mu<1$, the minimal number of eigenvalues in each gap depending on the type of gaps (cf. Lemma. 2.1-3 for the classification):

Lemma 2.5 For $\mu>1$, the operator $\mathcal{A}^{\mu}(\beta)$ has no eigenvalue. For $0<\mu<1$, let $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ be a spectral gap of the operator $\mathcal{A}^{\mu}(\beta)$ :
(a) If $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ is a gap of type (i), then $\mathcal{A}^{\mu}(\beta)$ has at least two eigenvalues $\lambda_{1}=\omega_{1}^{2}$ and $\lambda_{2}=\omega_{2}^{2}$ that satisfy $\omega_{b}<\omega_{1}<\omega_{0}<\omega_{2}<\omega_{t}$ (see Lemma. 2.1-3 for the definition of $\omega_{0}$ ).
(b) If $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ is a gap of type (ii) or (iii), then $\mathcal{A}^{\mu}(\beta)$ has at least one eigenvalue $\lambda_{1}=\omega_{1}^{2}$ such that $\omega_{b}<\omega_{1}<\omega_{t}$.

The sketch of the proof of the previous lemma is the following, a complete proof being available in [10] (Theorem 5.2.1): First, one can verify that $F_{\beta}(\omega) \geq 0$ in any gap, which, together with (14) proves that $\mathcal{A}^{\mu}(\beta)$ has no eigenvalue for $\mu>1$. Then, if $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ is a gap of type (i), one can show that

$$
\lim _{\omega \rightarrow \omega_{b}^{+}}\left(1-F_{\beta}(\omega)\right)=\lim _{\omega \rightarrow \omega_{t}^{-}}\left(1-F_{\beta}(\omega)\right)=1 \text { and that } \lim _{\omega \rightarrow \omega_{0}}\left(1-F_{\beta}(\omega)\right)=0
$$

By continuity of $F_{\beta}$ inside the gap, (a) directly results from the intermediate value theorem and (14). If $\left(\omega_{b}^{2}, \omega_{t}^{2}\right)$ is a gap of type (ii), the intermediate value theorem also permits us to conclude since

$$
\lim _{\omega \rightarrow \omega_{b}}\left(1-F_{\beta}(\omega)\right) \leq 0 \text { and } \lim _{\omega \rightarrow \omega_{t}^{-}}\left(1-F_{\beta}(\omega)\right)=1
$$

A similar argument works for a gap of type (iii).

## 3 Guided modes for the operator $A_{\varepsilon}^{\mu}(\beta)$ : an asymptotic result

Finally, thanks to the general result [8] (Theorem 2.13 convergence of the spectrum of $A_{\varepsilon}^{\mu}(\beta)$ toward the spectrum of $\mathcal{A}^{\mu}(\beta)$ ), we can prove the following result of existence of eigenvalue for the operator $A_{\varepsilon}^{\mu}(\beta)$ :

Theorem 3.1 Let $\mu \in(0,1)$, $\left(\lambda_{b}, \lambda_{t}\right)$ be a spectral gap of the operator $\mathcal{A}^{\mu}(\beta)$ and $\lambda_{0} \in\left(\lambda_{b}, \lambda_{t}\right)$ be a (simple) eigenvalue of this operator. Then, there exists $\varepsilon_{0}>0$ such that if $\varepsilon<\varepsilon_{0}$ the operator $A_{\varepsilon}^{\mu}(\beta)$ has an eigenvalue $\lambda_{\varepsilon}$ inside a spectral gap $\left(\lambda_{b}^{\varepsilon}, \lambda_{t}^{\varepsilon}\right)$. Moreover, $\lambda_{\varepsilon}=\lambda_{0}+O(\sqrt{\varepsilon})$.
