ANALYSIS AND APPROXIMATION OF ONE-DIMENSIONAL SCALAR CONSERVATION LAWS WITH GENERAL POINT CONSTRAINTS ON THE FLUX

ABSTRACT. We introduce and analyze a class of models with nonlocal point constraints for traffic flow through bottlenecks, such as exits in the context of pedestrians traffic and reduction of lanes on a road under construction in vehicular traffic. Constraints are defined based on data collected from non-local in space and/or in time observations of the flow. We propose a theoretical analysis and discretization framework that permits to include different data acquisition strategies; a numerical comparison is provided. Nonlocal constraint allows to model, e.g., the irrational behavior (“panic”) near the exit observed in dense crowds and the capacity drop at tollbooth in vehicular traffic.

Existence and uniqueness of solutions are shown under suitable and “easy to check” assumptions on the constraint operator. A numerical scheme for the problem, based on finite volume methods, is designed, its convergence is proved and its validation is done with an explicit solution. Numerical examples show that nonlocally constrained models are able to reproduce important features in traffic flow such as self-organization.

Keywords: scalar conservation law, nonlocal point constraint, well-posedness, fixed point argument, finite volume scheme, convergence of approximations, vehicular traffics, crowd dynamics

1. INTRODUCTION

1.1. Well posedness and approximation of conservation laws with point constraints on the flow. In this paper we study Cauchy problems for one-dimensional scalar conservation laws subject to point constraints of the form

$$\begin{aligned}
 (1.1a) \quad & \rho_t + f(\rho)_x = 0, & x \in \mathbb{R}, t \in (0, T], \\
 (1.1b) \quad & f(\rho)(t, 0^\pm) \leq q(t), & t \in (0, T], \\
 (1.1c) \quad & \rho(0, x) = \rho_0(x), & x \in \mathbb{R}.
 \end{aligned}$$

Above ρ is the unknown variable, f is the flux, q gives the maximal flow allowed through $x = 0$ and ρ_0 is the initial datum. Such problems naturally arise in modeling the flows of conserved quantities through bottlenecks, namely at points where an obstacle hinders the flow. At last, the final time $T > 0$ will be called *time horizon* in the sequel.

Despite the concept of point constraints is stated in a general mathematical framework, see for instance [45], according to the authors' knowledge, problem (1.1) is so far applied only in two frameworks: crowd dynamics [3, 2, 4, 16, 17, 18, 20, 22, 23] and vehicular traffics [7, 5, 6, 14, 19, 21, 25, 26, 27, 29]. However, it is easy to envisage the application of (1.1) in other fields of research, such as biology (e.g., to model flows of biological substances across cell membranes), biomedicine (e.g., to model blood flows in vessels through thromboses), internet traffic engineering (e.g., to model flows of data through routers or proxies), etc. Moreover, recent empirical data for both pedestrian and vehicular flows highlight phenomena such as capacity drop, self-organization, Braess' paradox, etc., that can not be reproduced by the macroscopic models already available. However, modifications can be introduced in the basic models in order to capture such specific features of real traffic flows.

In the literature the existence results for models based on (1.1) are achieved by means of mathematical tools developed *ad hoc* for each model. As a consequence, an existence result obtained for a model can be hardly adapted to other models, even if they are slight modifications of the original one. Indeed, for instance, the existence results in [5, 4, 17, 19, 25, 27] are obtained by applying the wave-front tracking method proposed by Dafermos in [24] and improved later on by Di Perna [28] and Bressan [11], see [12, 34] and the references therein for more details. However, this method can be hardly adapted from one model to another one because it relies on a case-by-case study of all the possible interactions, that strictly depend on the model under consideration.

The lack of general hypotheses that guarantee the existence of entropy solutions for models based on (1.1) is a serious obstacle toward a wider application of (1.1). For instance, the examples proposed in Section 1.3 and the corresponding numerical simulations given in Section 7 consist of models which are extremely close to the one proposed in [4], are of some interest by them own and, at the same time, seem excessively expensive to treat with the wave-front tracking machinery.

We deal in this paper with modifications to (1.1a) that are quite practical because they do not modify the structure of the fundamental model nor of its discrete counterparts, but they add complexity due to the introduction of a coupling with operators prescribing point constraints (1.1b) non-locally depending on the flow. Simulations based on elementary splitting numerical procedures for resolving the coupling between the flow and the non-local constraint permit testing and adaptation of models at low cost. Our aim is to provide a mathematically rigorous set of general and "easy to check" hypotheses that guarantee existence (and sometimes uniqueness) of entropy solutions to (1.1a) coupled to wide classes of constraint operators described in Section 2. We highlight the results presented in Theorem 3.1, Corollary 3.1 and Theorem 3.2 in Section 3. In Section 4 we give examples of problems of the form (1.1) that can be used as building blocks to construct more complex problems. As our well-posedness results in this paper rely on fixed point techniques, they are not constructive or they do not lead to practical algorithms for construction of solutions. To palliate this drawback we also introduce a general numerical scheme and "easy to check" hypotheses that guarantee the convergence of the scheme to entropy solutions to (1.1), see Section 5. Moreover we apply in Sections 6 and 7, the numerical scheme to the building blocks introduced in Section 4.

1.2. State of the art and the general framework of the present paper.

1.2.1. *Applications to crowd dynamics.* In [22] the authors apply (1.1) to model pedestrians evacuating a corridor through an exit door located in $x = 0$. In this framework, $\rho \in [0, \rho_{\max}]$ is the density of pedestrians and $f : [0, \rho_{\max}] \rightarrow [0, f_{\max}]$ the flux of pedestrians. In order to reproduce the capacity drop of the door in presence of high densities, they consider the following basic expression for the constraint

$$q(t) = \begin{cases} q_L & \text{if } \rho(t, 0^-) < R, \\ q_H & \text{if } \rho(t, 0^-) > R, \end{cases}$$

where q_L and q_H are, respectively, the efficiency of the door at low and high densities, $0 < q_H < q_L$, and $R > 0$ is the threshold between low and high densities. Let us recall that the main assumptions of the model are empirically confirmed in [33]. The existence of entropy solutions is proved in [23, 44] by applying the wave-front tracking method. Numerical approximations of the model are developed in [16, 17]. We underline that the model is able to reproduce the Braess' paradox for pedestrian flows [35], as the examples given in [18, 20, 23] show.

According to the above expression of the constraint q , the capacity drop of the door has a non-realistic behaviour since it is instantaneous when a high density reaches the door and it only depends on the density at the door. More realistic models should reproduce a gradual decay in the efficiency of the door as the pedestrians accumulate close to it, see [15, Figure 1]. Moreover, according to the above model, during the evacuation of pedestrians that are initially uniformly distributed, once the efficiency of the door falls, it remains constant until the very last pedestrian is evacuated, see [22, Figure 9]. On the contrary, in real life the efficiency of the door gradually increases as the number of the remaining pedestrians to be evacuated becomes smaller and smaller, see again [15, Figure 1]. All these considerations

lead the authors of the recent paper [4] to the following expression for the constraint

$$(1.2) \quad q(t) = p(\xi(t)) \quad \text{with} \quad \xi(t) = \int_{-\infty}^0 w(x) \rho(t, x) dx,$$

where w is a weight supported in some upstream bounded neighbourhood of $x = 0$ and p is a given non-increasing map that encodes the influence on the efficiency of the door of some *subjective crowd density* near the door. In fact, the quantity ξ has the meaning of the crowd density as perceived by a pedestrian located just before the door. The Riemann problems corresponding to (1.1), (1.2) are studied in detail in [2], where it is also investigated how the regularity of p impacts the well-posedness of the problem, in particular in the case of a piecewise constant function p , which is the relevant one for the numerical applications. The numerical approximation of its solutions together with its qualitative validation are proposed in [3], where the convergence of the numerical scheme is proved by reduction to the case where q is a given function of time. It is shown in [3] that the model is able to reproduce the main effects related to the capacity drop, that are the faster is slower effect [32] and the Braess' paradox for pedestrian flows [35].

Well-posedness of (1.1), (1.2) is proved in [4], under the Lipschitz continuity assumption on the function p . This work is based on a wave-front tracking method with discretized (piecewise constant) function p . This construction has some drawbacks (actually we have a sequence of ill-posed problems converging to a well-posed one), we refer to [2] for the details. Therefore, even if the wave-front tracking strategy proved useful in the theoretical analysis, in [3] we prefer to use a simple finite volume scheme for illustrating some key features of pedestrian flows in the context of model (1.1), (1.2).

1.2.2. *Applications to vehicular traffics.* Colombo and Goatin apply in [19] the concept of point constraints to the first order model for road traffic by Lighthill, Whitham [39] and Richards [43], with the goal to reproduce the effects of obstacles along the road, like toll gates, traffic lights or localized construction sites. The resulting model reads (1.1), where q is a function of time given beforehand, $\rho \in [0, \rho_{\max}]$ is the density of vehicles and $f: [0, \rho_{\max}] \rightarrow [0, f_{\max}]$ is the flux function that satisfies the following assumption

$$(F) \quad f \text{ belongs to } \mathbf{Lip}([0, \rho_{\max}]; [0, f_{\max}]) \text{ and is bell-shaped, that is } f(0) = 0 = f(\rho_{\max}) \\ \text{and there exists } \rho_c \in (0, \rho_{\max}) \text{ such that } f'(\rho) (\rho_c - \rho) > 0 \text{ for a.e. } \rho \in [0, \rho_{\max}].$$

The existence of a unique solution is proved in [19] by using the wave-front tracking method. One of the main difficulties in this approach is the proof of a uniform bound for the total variation of the solution. The authors show that $t \rightarrow \text{TV}(\rho(t))$ may increase; hence, to overcome this difficulty they rather prove that $t \rightarrow \text{TV}(\psi(\rho(t)))$ does not increase, where $\psi(\rho) = \int_{\rho_c}^{\rho} |f'(r)| dr$. Only recently in [14] an estimate for the local total variation of the solution is provided. The convergence of a numerical approximation by means of a monotone finite volume scheme is proposed in [6]. Recall that the model can also be applied in traffic management, e.g. to synchronize traffic lights, see [21].

Finally, for the sake of completeness, let us also briefly recall two recent generalizations of (1.1), even if the results of the present paper do not directly apply to them. The first one is the application of the theory of point constraint to the second order model for road traffic by Aw, Rascle [8] and Zhang [49], see [7, 5, 29, 30]. Clearly, the resulting model does not fit in the framework of the present paper, which deals with scalar conservation laws. However we will give comments and remarks related also to this model. The second generalization that we want to recall is that one proposed in [25, 26, 27], where the authors introduce the concept of *moving* point constraint to model the influence of a slow and large vehicle on road traffic, problem that is considered also in [10, 37] but with different approaches.

1.2.3. *Our general framework.* In [19] and in [22], q is given beforehand as a function of time and as a function of the density at $x = 0^-$, respectively. Here, we consider a problem (1.1) subject to the more general class of point constraints

$$(1.3) \quad q(t) = \mathcal{Q}[\rho](t) \text{ for a.e. } t \in [0, T],$$

where

$$\mathcal{Q}: \mathbf{C}^0([0, T]; \mathbf{L}^1(\mathbb{R}; \mathbb{R})) \longrightarrow \mathbf{L}^1([0, T]; [0, f_{\max}]).$$

As a result, the operator \mathcal{Q} may be non-local both in time and space, and it may account for psychological features that strongly influence the dynamics of a living system. Additional structure restrictions on \mathcal{Q} will be imposed later, see Section 2.1. Moreover, to shorten notation and calculations, in the sequel we will assume that \mathcal{Q} does not depend explicitly on time; the general case does not present additional analytic difficulties.

In the present work, we rely on the approach of [3], both at the theoretical and at the numerical level. We describe a class of non-locally constrained models for which the existence, the approximation results and (under stronger assumptions) the uniqueness of solutions can be derived. Namely, starting from the well-posedness results and established approximation techniques for (1.1) (see [6, 19]), using fixed point arguments we are able to address solvability of non-locally constrained problems of the kind (1.1), (1.3). Further, as in [3] we combine the simple finite volume strategy of the work [6] for numerical computation of the solution ρ to (1.1) with the fractional step technique, taking into account the evolution of the constraint $q = \mathcal{Q}[\rho]$. For compact operators \mathcal{Q} , we justify convergence of the resulting algorithm. Finally we use the scheme to simulate crowd or vehicle motions for some model cases, where non-local constraints (with space and/or time non-locality) may be of interest.

1.3. Examples of new advanced models. In this section we introduce some models related to the one proposed in [4] together with their physical motivation. They are divided into three examples, addressing

- the comparison of different ways to collect data on the state of traffic;
- self-organization;
- a more precise description of capacity drop;
- capacity drop related to perceived density.

Numerical simulations on these examples are postponed to Section 7.

Let us underline that in Section 4 we present further elementary examples of constraint operators to which our results apply. Their discrete counterparts are proposed in Section 6. We do not fix a physical interpretation for these operators, which can be used as a set of building blocks to construct more complex models.

For later use let us introduce the maps $p: [0, \rho_{\max}] \rightarrow (0, f_{\max}]$, $w: \mathbb{R}_- \rightarrow \mathbb{R}_+$ and $\kappa: \mathbb{R}_+ \rightarrow \mathbb{R}_+$ and, for simplicity, let us assume that

- $p \in \mathbf{Lip}([0, \rho_{\max}]; (0, f_{\max}])$ is a non increasing map;
- (PWK) • $w \in \mathbf{L}^\infty(\mathbb{R}_-; \mathbb{R}_+)$ is an increasing map with compact support and $\|w\|_{\mathbf{L}^1(\mathbb{R}_-)} = 1$;
- $\kappa \in \mathbf{Lip}(\mathbb{R}_+; \mathbb{R}_+)$ is a non increasing map with $\|\kappa\|_{\mathbf{L}^1(\mathbb{R}_+)} = 1$ and $\text{supp}(\kappa) = [0, \tau]$, $\tau > 0$.

Whenever w' appears in the expression of a constraint operator, (**wLip**) below is assumed as well.

The above assumptions can be relaxed to varying degrees in each specific modeling context, with minor consequences on the subsequent results.

Example 1.1. Let p , w and κ be as in (PWK) with $w \in \mathbf{C}_c^1(\mathbb{R}; \mathbb{R}_+)$. In this section we consider the following equivalent (in a sense that will be specified in Definition 2.2) non-local (both in time and space) constraint operators

$$(1.4) \quad \begin{aligned} \mathcal{Q}[\rho](t) &= p \left(\int_{\mathbb{R}_-} \int_0^t w(x) \kappa(t-s) \rho(s, x) \, ds \, dx \right), \\ \widehat{\mathcal{Q}}[\rho](t) &= p \left(\int_{\mathbb{R}_-} \left[w(x) \bar{\kappa}(t) \rho_0(x) + w'(x) \int_0^t \bar{\kappa}(t-s) f(\rho)(s, x) \, ds \right] dx - w(0^-) \int_0^t \bar{\kappa}(t-s) f(\rho)(s, 0^-) \, ds \right), \end{aligned}$$

where $\bar{\kappa} \in \mathbf{C}^2(\mathbb{R}_+; \mathbb{R}_+)$ is the primitive of κ such that $\bar{\kappa}(0) = 0$.

The constraint operators \mathcal{Q} and $\widehat{\mathcal{Q}}$ reproduce the situation in which the maximal flow at time t in $x = 0$ depends on the values of the density in $\text{supp}(\kappa(t - \cdot)) \times \text{supp}(w)$. Moreover, due to the monotonicity assumptions on w , respectively on κ , the efficiency is more affected by the “closest” values of the density, respectively by the “more recent” values of the density. Introduce also the constraint operators

$$\begin{aligned} \widetilde{\mathcal{Q}}[\rho](t) &= p \left(\sum_{0 < t_i \leq t} [t_i - t_{i-1}] \kappa(t - t_{i-1}) \int_{\mathbb{R}_-} w(x) \rho(t_i, x) \, dx \right), \\ \overline{\mathcal{Q}}[\rho](t) &= p \left(\sum_{y_i < 0} [y_{i+1} - y_i] w(y_i) \left[\int_0^t \kappa(t-s) \rho(s, y_{i+1}) \, ds \right] \right), \end{aligned}$$

which can be interpreted as discretized versions of \mathcal{Q} , with $0 \leq t_i < t_{i+1}$ and $y_0 \leq y_i < y_{i+1} \leq y_{M+1} = 0$.

Let us underline that constraint operators of the form introduced above naturally arise in modelling vehicular traffics through a toll booth if the number of open gates is decided according to on line data. In fact, we have the following:

- In the case the data are collected by a *video camera*, then the corresponding constraint operator takes the form \mathcal{Q} or $\widehat{\mathcal{Q}}$, being $\text{supp}(w)$ the area registered by the video camera and $\text{supp}(\kappa)$ the period of time the data are taken into account.
- In the case the data come from a *photo camera* that shoots photos at times t_i of the area given by $\text{supp}(w)$, then the corresponding constraint operator is $\widetilde{\mathcal{Q}}$, being again $\text{supp}(\kappa)$ the period of time the data are taken into account.
- In the case the data come from *local sensors* located in y_i , then the corresponding constraint operator takes the form $\overline{\mathcal{Q}}$, being again $\text{supp}(\kappa)$ the period of time the data are taken into account.

Observe that the introduction of a time delay $\sigma > 0$ in adapting the number of open gates to the available data can be modelled, for instance, by taking

$$\mathcal{Q}[\rho](t) = p \left(\int_{\mathbb{R}_-} \int_0^{\max\{0, t-\sigma\}} w(x) \kappa(t-\sigma-s) \rho(s, x) \, ds \, dx \right).$$

The numerical simulations based on the models introduced in this example are deferred to Example 7.1, where we compare the resulting numerical simulations corresponding to the different models. In particular we show that the simulations corresponding to \mathcal{Q} and $\widehat{\mathcal{Q}}$ are essentially the same. Also the simulations with $\widetilde{\mathcal{Q}}$ and $\overline{\mathcal{Q}}$ are essentially the same as those with \mathcal{Q} and $\widehat{\mathcal{Q}}$ if the number of times t_i and of sensors y_i is very high. \square

Example 1.2. In [4] the authors consider the constraint operator

$$(1.5) \quad \mathcal{Q}[\rho](t) = p(\xi(t)), \quad \xi(t) = \int_{\mathbb{R}_-} w(x) \rho(t, x) dx,$$

where p and w are given by **(PWK)**, to reproduce the capacity drop of a bottleneck when a very high density of pedestrians accumulate upstream (see also the examples 2.1 and 4.1). However this model is not realistic if the density contains big oscillations. In fact, as soon as a high density approaches the bottleneck, its efficiency can become very small. As a consequence, even a small density of pedestrians may form a queue provided a sufficiently high density is approaching from behind. In order to temper this drawback, we propose a constraint operator of the form

$$(1.6) \quad \mathcal{Q}[\rho](t) = p(\xi(t)), \quad \xi(t) = \min \left\{ \int_{\mathbb{R}_-} w(x) \rho(t, x) dx, \alpha f_-^{-1} \left(\int_0^t \kappa(t-s) f(\rho)(s, 0^-) ds \right) \right\},$$

where $0 < \alpha \leq \frac{R}{\rho_c}$ is a constant, p , w and κ are as in **(PWK)** and f_- is the restriction of f to $[0, \rho_c]$. In (1.6), the maximal flow at time t in $x = 0$ depends at the same time on the weighted number of pedestrians located in a neighbourhood before the bottleneck and on the weighted number of pedestrians that have passed through the bottleneck during the period $[0, t]$. In fact, when a density of pedestrian approaches the bottleneck, the constraint operator defined in (1.6) first takes into account the flow of pedestrians through the bottleneck. Next, because the number of pedestrians before the bottleneck decreases in time, this latter is taken into account by the constraint operator in a second step. The two numerical simulations given in Example 7.2 (see Figure 6) with the same initial datum and map w , but one with the constraint operator (1.5) and one with the constraint operator (1.6), show that at least in this test case the constraint operator (1.6) does not present the drawback. At the same time and on the contrary to (1.5), the constraint operator (1.6) is able to take into account the self-organization of pedestrians and the capacity of the bottleneck, see [48, Figure 3] for empirical data detected in a London underground station that put in evidence both these aspects. Clearly, the choice of the functions w and κ should take into account the empirical data. However, this goes behind the aims of the present paper. The resulting numerical simulations are presented in Example 7.2 (see Figure 7). Let us finally underline that the same approach can be used to model analogous dynamics occurring in vehicular traffic through bottlenecks, see [48, Figure 4]. \square

Example 1.3. In the model (1.1), (1.3), (1.5) introduced in [4], the function ξ serves as the indicator of the subjective density at the bottleneck and is the solution of a Cauchy problem for an Ordinary Differential Equation (ODE), see [4, page 2688] and (2.5). In this example we model the fact that the panic can not disappear too fast by considering the constraint operator

$$(1.7) \quad \widehat{\mathcal{Q}}[\rho](t) = p(\xi(t)),$$

where ξ is defined as the solution in $\mathcal{D}'((0, T))$ of the following Cauchy problem for an ODE

$$(1.8) \quad \dot{\xi}(t) = \max \left\{ \int_{\mathbb{R}_-} w'(x) [f(\rho)(t, x) - f(\rho)(t, 0^-)] dx, -\delta \xi \right\}, \quad \xi(0) = \xi_0[\rho_0],$$

or

$$(1.9) \quad \dot{\xi}(t) = \max \left\{ \int_{\mathbb{R}_-} w'(x) [f(\rho)(t, x) - f(\rho)(t, 0^-)] dx, -\delta \right\}, \quad \xi(0) = \xi_0[\rho_0],$$

where $\xi_0: \mathbf{L}^1(\mathbb{R}) \rightarrow \mathbb{R}$, $\delta > 0$ is a constant and $w: \mathbb{R}_- \rightarrow \mathbb{R}_+$ is such that

$$(w\text{Lip}) \quad w \in \mathbf{Lip}((-\infty, 0); \mathbb{R}_+) \text{ but it can be/is discontinuous at } x = 0.$$

This has to be compared to the original model (1.5), cf. Example 2.1 below. We defer to Remark 4.3 for an existence and uniqueness result for (1.1), (1.3), (1.7), (1.8). By the numerical simulation in Example 7.3 we see that the constraints operator (1.7) with (1.8) or (1.9) is able to avoid the level of subjective density to decrease too quickly. \square

We recall that the wave-front tracking approach used in [4] provides well posedness results and allows for a rather precise study of the profiles of the solutions. Unfortunately, it requires an extremely careful case by case study of all possible interactions and the intermediate results obtained for the specific model cannot be adapted in a straightforward way to different models, even very close to the original one, such as those proposed in this section. Nevertheless, in general, once the study of a specific model is advanced, one would like to consider other similar models to compare them and to check which one fits the best with real life observations. This paper provides some abstract general tools to address existence and uniqueness for a wide class of models with point constraints. These methods are not constructive, and this is why we couple them with a numerical scheme, whose convergence is proved under general hypotheses. In Section 7 we defer numerical simulations based on the models introduced in the above examples.

1.4. Structure of the paper. The paper is organized as follows. In Section 2, we introduce the general assumptions on the constraint operators that allow to prove well-posedness of (1.1) and we recall the definition of entropy solutions for (1.1). In Section 3, we prove well-posedness results for (1.1) under the assumptions introduced in Section 2. In Section 4, we give examples of constraint operators that satisfy the general assumptions introduced in the previous sections and that can be used as building blocks to construct more complex ones. In Section 5, we introduce the numerical scheme, based on finite volume methods and we prove its convergence. Section 6 is devoted to the construction and the study of approximate constraint operators related to the constraint operators introduced in Section 4. Finally in Section 7, we first validate the numerical scheme with an explicit solution and then we perform numerical simulations using constraint operators given in examples 1.1–1.3.

2. ASSUMPTIONS AND DEFINITIONS

Our first goal is to point out properties of the constraint operators \mathcal{Q} for which a sound mathematical theory can be established.

2.1. Assumptions. We take the classical assumption (F) on the flux function f that appears in the equation (1.1a). Existence results will be stronger under the additional genuine nonlinearity assumption:

(GNL) for any $\rho_1, \rho_2 \in [0, \rho_{\max}]$ such that $\rho_1 < \rho_2$, the restriction of f to $[\rho_1, \rho_2]$ is not affine.

For the sake of simplicity and because this is enough for our modeling purposes, we will impose that the initial datum ρ_0 that appears in (1.1c) belongs to $\mathbf{L}^1(\mathbb{R}; [0, \rho_{\max}])$. Let us underline that, thanks to the property of finite speed of propagation for equation (1.1a), extension of the existence and uniqueness results to $\mathbf{L}^\infty(\mathbb{R}; [0, \rho_{\max}])$ is rather straightforward (see, in particular, the proof of [4, Theorem 2.1]).

Now, let us specify properties of the operator \mathcal{Q} . Firstly, we need an operator acting as follows

$$\mathcal{Q}: \mathbf{C}^0(0, T; \mathbf{L}^1) \longrightarrow \mathbf{L}^1(0, T),$$

where

$$\mathbf{C}^0(0, T; \mathbf{L}^1) = \mathbf{C}^0([0, T]; \mathbf{L}^1(\mathbb{R}; [0, \rho_{\max}])) \quad \text{and} \quad \mathbf{L}^1(0, T) = \mathbf{L}^1((0, T); [0, f_{\max}])$$

are endowed, respectively, with the distances induced by the norms

$$\|\rho\|_{\mathbf{C}^0(0, T; \mathbf{L}^1)} = \max_{t \in [0, T]} \int_{\mathbb{R}} |\rho(t, x)| dx \quad \text{and} \quad \|q\|_{\mathbf{L}^1(0, T)} = \int_0^T |q(t)| dt.$$

On concrete examples, the technical assumptions imposed below may be easier to verify as consequences of some reinforced assumptions involving $\mathbf{L}^1(0, T; \mathbf{L}^1)$ or $\mathbf{L}^\infty(0, T)$ in the place of $\mathbf{C}^0(0, T; \mathbf{L}^1)$ and $\mathbf{L}^1(0, T)$, where

$$\mathbf{L}^1(0, T; \mathbf{L}^1) = \mathbf{L}^1((0, T) \times \mathbb{R}; [0, \rho_{\max}]) \quad \text{and} \quad \mathbf{L}^\infty(0, T) = \mathbf{L}^\infty((0, T); [0, f_{\max}])$$

are endowed, respectively, with the distances induced by the norms

$$\|\rho\|_{\mathbf{L}^1(0, T; \mathbf{L}^1)} = \int_0^T \int_{\mathbb{R}} |\rho(t, x)| dx dt \quad \text{and} \quad \|q\|_{\mathbf{L}^\infty(0, T)} = \text{ess sup}_{t \in (0, T)} |q(t)|.$$

For this reason, whenever necessary, we assume that the constraint operator \mathcal{Q} can be extended to $\mathbf{L}^1(0, T; \mathbf{L}^1)$. Observe that the embeddings $\mathbf{L}^1(0, T; \mathbf{L}^1) \supset \mathbf{C}^0(0, T; \mathbf{L}^1)$ and $\mathbf{L}^\infty(0, T) \subset \mathbf{L}^1(0, T)$ are continuous.

The first natural assumption is that \mathcal{Q} is “history dependent” (cf. [46] for a related work on history-dependent operators in the setting of viscoplastic contact problems) in the sense that

(Q^{hd}) ρ_1, ρ_2 are in the domain of \mathcal{Q} and coincide on $[0, t] \times \mathbb{R} \implies \mathcal{Q}[\rho_1] = \mathcal{Q}[\rho_2]$ in $[0, t]$.

This simply means that the constraint level does not depend on the future traffic but only on the past and actual traffic, therefore it is a fully natural assumption in applications (even if the existence result may not require assumption (Q^{hd})). In particular, assuming (Q^{hd}) one can introduce for any $t \in [0, T]$ the restriction of \mathcal{Q} to $\mathbf{C}^0(0, t; \mathbf{L}^1)$ as the operator $\mathcal{Q}_t: \mathbf{C}^0(0, t; \mathbf{L}^1) \rightarrow \mathbf{L}^1(0, t)$ defined as follows. First, for any given function $\rho \in \mathbf{C}^0(0, t; \mathbf{L}^1)$ one introduces an arbitrary extension $\mathcal{E}[\rho] \in \mathbf{C}^0(0, T; \mathbf{L}^1)$, say, by letting $\mathcal{E}[\rho](s) = \rho(s, \cdot) \mathbf{1}_{[0, t]}(s) + \rho(t, \cdot) \mathbf{1}_{[t, T]}(s)$. Then, one defines $\mathcal{Q}_t[\rho]$ as the restriction to $[0, t]$ of $\mathcal{Q}[\mathcal{E}[\rho]]$.

In the sequel, whenever necessary we will tacitly use the possibility of such restriction of \mathcal{Q} and denote the resulting operator by \mathcal{Q}_t . Yet, property (Q^{hd}) will not explicitly appear in our assumptions, because it is either too weak or too strong for our purposes. Indeed, in view of the uniqueness study, assumption (Q^{hd}) has to be strengthened to a kind of

Lipschitz continuity assumption on \mathcal{Q}_t , with Lipschitz constant that is small for small times. The precise assumption is technical and reads as follows:

for any $t \in [0, T]$ the operator $\mathcal{Q}_t: \mathbf{C}^0(0, t; \mathbf{L}^1) \rightarrow \mathbf{L}^1(0, t)$ is Lipschitz continuous, moreover, there exists $\omega: \mathbb{R}_+ \rightarrow \mathbb{R}_+$ continuous, non-decreasing, $\omega(0) = 0$ and for any $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$

$$(Q^{\text{Lip}}) \quad \|\mathcal{Q}_t[\rho_1] - \mathcal{Q}_t[\rho_2]\|_{\mathbf{L}^1(0, t)} \leq \omega(t - \tau) \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)} \quad \text{for a.e. } t \in [0, T],$$

where $\tau = \max\{s \in [0, t]: \rho_1 = \rho_2 \text{ in } \mathbf{C}^0(0, s; \mathbf{L}^1)\}$.

Under assumption (Q^{Lip}) , the Banach-Picard fixed point argument can be used recursively on small time intervals to yield both existence and uniqueness of solutions. There are simpler sufficient conditions under which (Q^{Lip}) holds, namely, that there exists a constant $C > 0$ such that

$$(2.1) \quad \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^1(0, t)} \leq C \|\rho_1 - \rho_2\|_{\mathbf{L}^1(0, t; \mathbf{L}^1)} \quad \text{for all } t \in [0, T],$$

or

$$(2.2) \quad \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^\infty(0, t)} \leq C \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)} \quad \text{for all } t \in [0, T].$$

Assumptions (2.1) and (2.2) are uniform in t Lipschitz continuity assumptions between the appropriate spaces; these assumptions are easily checked for the examples in Section 4. We refer to Corollary 3.1 below for a proof that any of the above two conditions entails (Q^{Lip}) .

Let us underline that for the existence result, assumption (Q^{Lip}) is sufficient but in general it is too restrictive. Moreover, (Q^{Lip}) should be used in combination with the Lipschitz estimate (3.3) stated in Lemma 3.2 below. The result of this lemma holds true for the scalar constrained Cauchy problem (1.1). Note that the theory of point constraints has recently been applied to systems of conservation laws as well, see for instance [5]; in the context of systems, results analogous to those of Lemma 3.2 can hardly be proved. In further perspective, we are interested in studying such more complex models, at least from the perspective of existence and approximation of their solutions. For this reason we observe that under assumption (GNL) it is enough to require the mere continuity property of an extension of \mathcal{Q} , namely

$$(Q^{\text{cont}}) \quad \mathcal{Q} \text{ can be extended to a continuous map from } \mathbf{L}^1(0, T; \mathbf{L}^1) \text{ to } \mathbf{L}^1(0, T).$$

In the situation where the genuine nonlinearity assumption (GNL) should be dropped, we can replace (Q^{cont}) by

$$(Q^{\text{comp}}) \quad \mathcal{Q} \text{ is continuous and compact from } \mathbf{C}^0(0, T; \mathbf{L}^1) \text{ to } \mathbf{L}^1(0, T).$$

Because the topology of $\mathbf{L}^1(0, T; \mathbf{L}^1)$ is weaker than the one of $\mathbf{C}^0(0, T; \mathbf{L}^1)$, the two assumptions (Q^{cont}) and (Q^{comp}) are not directly comparable. Let us explain the roles of the assumption (Q^{comp}) or of the pair of assumptions (GNL) , (Q^{cont}) . In the latter case, compactness of families of functions (ρ_Δ) solving (1.1a) away from $x = 0$ can be justified by using the compactification properties of genuinely nonlinear scalar conservation law, see [41]. The appropriate topology is the \mathbf{L}^1 topology, which requires to use the space $\mathbf{L}^1(0, T; \mathbf{L}^1)$ in the place of the more natural space $\mathbf{C}^0(0, T; \mathbf{L}^1)$. Under the assumption (Q^{comp}) , compactness of the corresponding constraints (q_Δ) (and consequently that of (ρ_Δ)) is a straightforward property. In both cases, the Schauder fixed point argument can be used in order to resolve the coupling between ρ and q in (1.1), (1.3). Assumption (Q^{comp}) will be also taken for the study of numerical approximations of the problem, for the sake of simplicity of the proof. We refer to Remark 5.2 for details.

2.2. Entropy solutions for models with point constraints. We are ready to define a notion of solution for the equation (1.1a) subject to a nonlocal point constraint. We define the solution on $[0, T]$ for $T > 0$; extension of the definition to $t \in \mathbb{R}_+$ is straightforward. Throughout the paper, assumptions on f and ρ_0 are those of the introduction, except for (GNL) which will be mentioned explicitly each time it is used.

For our purposes, it is convenient to consider the problem as a 2×2 system of equations for the two unknowns ρ and q . We split the definition into two points, the first one being applicable to the case where q is a given function on $[0, T]$.

Definition 2.1. *A couple (ρ, q) such that $\rho \in \mathbf{C}^0([0, T]; \mathbf{L}_{\text{loc}}^1(\mathbb{R}; [0, \rho_{\max}]))$ and $q \in \mathbf{L}^\infty(0, T)$ is an entropy solution to (1.1), (1.3) if the following conditions hold.*

- (i) *The function ρ is an entropy solution of the constrained Cauchy problem (1.1) with the constraint q , i.e., for every test function $\phi \in \mathbf{C}_c^\infty([0, T] \times \mathbb{R}; \mathbb{R}_+)$ and for every $k \in [0, \rho_{\max}]$*

$$(2.3a) \quad \int_{\mathbb{R}_+} \int_{\mathbb{R}} [|\rho - k| \partial_t \phi + \text{sign}(\rho - k) (f(\rho) - f(k)) \partial_x \phi] \, dx \, dt$$

$$(2.3b) \quad + 2 \int_{\mathbb{R}_+} \left[1 - \frac{q(t)}{f(\rho_c)} \right] f(k) \phi(t, 0) \, dt$$

$$(2.3c) \quad + \int_{\mathbb{R}} |\rho_0(x) - k| \phi(0, x) \, dx \geq 0,$$

and the left and right traces $t \mapsto \gamma^\pm f(\rho)(t)$ of $f(\rho)$ at $\{x = 0\}$ fulfill

$$(2.3d) \quad \gamma^\pm f(\rho)(t) \leq q(t) \text{ for a.e. } t \in [0, T].$$

(ii) The function q is linked to ρ by the relation (1.3).

Recall that the item (i) is precisely [6, Definition 2.1], which is a minor generalization of the original one [19, Definition 3.2] introduced by Colombo and Goatin. Let us stress that the lines (2.3a), (2.3c) constitute the classical Kruzhkov definition of an entropy solution, see [36], suitable in the case of a conservation law set up in $\mathbb{R}_+ \times \mathbb{R}$ without any constraint condition, namely for (1.1a), (1.1c). Lines (2.3b) and (2.3d) account for the constraint (1.1b).

Remark 2.1.

(i) In order to give a precise meaning to (2.3d), let us stress that strong (in the $\mathbf{L}_{\text{loc}}^1$ sense) left and right traces at $x = 0$ of the flux of a function verifying (2.3a)-(2.3c) do exist. We refer, for instance, to [6, Theorem 2.2] which gives a convenient reformulation of the results of Vasseur [47] and Panov [42].

We also stress that in practical applications where f is non-constant on any interval (assumption **(GNL)** is a sufficient condition) $f(\rho)(t, 0^\pm)$ coincides with $f(\rho(t, 0^\pm))$. Indeed, in this case the strong traces $t \mapsto \gamma^\pm \rho(t)$ exist as well, see [42]. In the sequel, we will write $f(\rho)(t, 0^\pm)$ for $\gamma^\pm f(\rho)(t)$ and $\rho(\cdot, 0^\pm)$ for $\gamma^\pm \rho(t)$.

(ii) Let us recall that the assumption of time-continuity (with values in $\mathbf{L}_{\text{loc}}^1(\mathbb{R})$) of entropy solutions in the sense of Definition 2.1 (i) is a regularity property of general $\mathbf{L}_{\text{loc}}^1((0, T) \times \mathbb{R})$ solutions, analogous to the above property of existence of traces. This regularity is justified, e.g., in [13].

(iii) We refer to [6, Proposition 2.6] for a series of equivalent formulations of conditions (2.3) that we will not exploit directly in this paper, although the results we exploit in the sequel (continuous dependence of ρ on q , convergence of numerical schemes for a given q) do rely upon the reformulations from [6]. \square

It turns out that the constrained problems of the form (1.1), (1.3) corresponding to two different constraint operators \mathcal{Q} and $\widehat{\mathcal{Q}}$ may lead to the same solutions for all data. In this context, the mathematical properties of one of the constraint operators can be better than those of the other one, which is sometimes instrumental for the analysis. For this reason, we introduce and exploit the following definition.

Definition 2.2. Two constraint maps \mathcal{Q} and $\widehat{\mathcal{Q}}$ are equivalent if $\mathcal{Q}[\rho] = \widehat{\mathcal{Q}}[\rho]$ for any entropy solution ρ of (1.1), (1.3) corresponding to \mathcal{Q} or to $\widehat{\mathcal{Q}}$.

Example 2.1. Consider the constraint operator \mathcal{Q} introduced in [4] and defined in (1.5) with p and w that satisfy **(PWK)**. Assume in addition that w satisfies **(wLip)** and introduce also the constraint operator

$$(2.4) \quad \widehat{\mathcal{Q}}[\rho](t) = p(\xi(t)),$$

where ξ is the solution in $\mathcal{D}'([0, T])$ of the following Cauchy problem for an ODE

$$(2.5) \quad \dot{\xi}(t) = \int_{\mathbb{R}_-} w'(x) [f(\rho)(t, x) - f(\rho)(t, 0^-)] dx, \quad \xi(0) = \int_{\mathbb{R}_-} w(x) \rho_0(x) dx.$$

Then the constraint operators \mathcal{Q} and $\widehat{\mathcal{Q}}$ are equivalent in the sense of Definition 2.2. Indeed, for any entropy solution (ρ, q) to (1.1), (1.3), (1.5) or to (1.1), (1.3), (2.4), (2.5), ρ satisfies the Cauchy problem for a conservation law (1.1a), (1.1c) in $\mathcal{D}'([0, T] \times \mathbb{R})$ (this is a consequence of (2.3a)-(2.3c) with $k = 0$ and $k = \rho_{\max}$). It is evident that, given (ρ, q) entropy solution to the constrained Cauchy problem (1.1), (1.3), (1.5), there exists a unique solution ξ to problem (2.5). Then, by applying the integration by parts formula to the right-hand side of the ODE in (2.5) we find

$$\dot{\xi}(t) = - \int_{\mathbb{R}_-} w(x) f(\rho)_{x,t}(t, x) dx \quad \text{in } \mathcal{D}'([0, T]),$$

hence by (1.1a), (1.1c) and by taking into account the initial condition in (2.5), we see that ξ coincides in $[0, T]$ with ξ given in (1.5) and

$$\widehat{\mathcal{Q}}[\rho] = p(\xi(t)) = p \left(\int_{\mathbb{R}_-} w(x) \rho(t, x) dx \right) = \mathcal{Q}[\rho].$$

Reciprocally, taking the time derivative of (1.5) in the sense of distributions, with the same arguments we infer (2.4), (2.5). We defer to Example 4.1 for a deeper study of the constraint operator \mathcal{Q} and to Example 6.1 for the study of a corresponding discrete constraint operator. Finally, we defer to Remark 4.2 for an existence and uniqueness result for (1.1), (1.3), (2.4), (2.5). \square

Example 2.2. Take p and κ as in **(PWK)** and $\phi \in \mathbf{Lip}([0, T]; \mathbf{C}_c^1(\mathbb{R}; \mathbb{R}))$ such that $\phi(\cdot, 0^-) = \kappa(\cdot)$. Take in addition $r \in \mathbf{Lip}([0, f_{\max}]; [0, \rho_{\max}])$. The constraint operators

$$\mathcal{Q}[\rho](t) = p \circ r \left(\int_0^t f(\rho)(s, 0^-) \kappa(t-s) ds \right) \quad \text{and} \quad \widehat{\mathcal{Q}}[\rho](t) = p \circ r(\xi(t)),$$

where

$$\begin{aligned} \xi(t) &= \int_0^t \int_{\mathbb{R}_-} [-\rho(s, x) \phi_t(t-s, x) + f(\rho)(s, x) \phi_x(t-s, x)] dx ds \\ &\quad + \int_{\mathbb{R}_-} [\rho_0(x) \phi(t, x) - \rho(t, x) \phi(0, x)] dx, \end{aligned}$$

are equivalent. As in the example above, the equivalence is established by using integration by parts formula and the fact that ρ satisfies the Cauchy problem for a conservation law (1.1a), (1.1c) in $\mathcal{D}'([0, T] \times \mathbb{R})$. We refer to Example 4.3 for the study of an analogous example.

Observe that the definition of ξ in terms of the averaged trace of the flux $f(\rho(0^-, \cdot))$ permits to recover stability properties of the constraint operator due to the Green-Gauss formula. In contrast, time averaging of the trace $\rho(0^-, \cdot)$ does not lead to a consistent mathematical theory. For this reason, in the present example we need to introduce a function r that plays the role of a partial inverse of f . To be specific, let us denote by f_- (respectively, by f_+) the restriction of f to $[0, \rho_c]$ (respectively, to $[\rho_c, \rho_{max}]$). Observe that the model of this example can be seen as qualitatively close to (1.5) for sufficiently large crowd densities (respectively, for moderate crowd densities), if we choose r that behaves like f_+^{-1} (respectively, as f_-^{-1}) on some interval $[0, F]$ with $F < f_{max}$. Compared to (1.5) where the subjective density results from the perception of the instantaneous spatial distribution of the crowd, in this example the subjective density results from the memory of the crowd behavior at the precise location of the bottleneck. \square

3. EXISTENCE AND UNIQUENESS OF ENTROPY SOLUTIONS TO CONSTRAINED PROBLEMS

In this section, using fixed point arguments we show existence results (under the assumptions **(GNL)** and **(Q^{cont})** or under the assumption **(Q^{comp})**) and uniqueness results (under the assumption **(Q^{Lip})**).

3.1. Evolution operators. To start with, let us define the following operators. Here and throughout the section, the initial datum ρ_0 is fixed. The maps

$$\mathcal{R}_t: \mathbf{L}^1(0, t) \rightarrow \mathbf{C}^0(0, t; \mathbf{L}^1)$$

associate to a given constraint function q the entropy solution ρ to (1.1) with time horizon t in the sense of Definition 2.1 (i). Composing this map with \mathcal{Q}_t , we define the map

$$\mathcal{T}_t = \mathcal{R}_t \circ \mathcal{Q}_t: \mathbf{C}^0(0, t; \mathbf{L}^1) \rightarrow \mathbf{C}^0(0, t; \mathbf{L}^1).$$

Let us stress that t is not necessarily fixed to be equal to T , namely, under the history dependence assumption **(Q^{hd})**, we can consider first sufficiently small time horizon and then proceed by bootstrapping the construction of entropy solutions in order to achieve the prescribed final time T . To be precise, we have

Lemma 3.1. *Assume that the constraint operator \mathcal{Q} verifies property **(Q^{hd})**. Let $0 = t_0 < t_i < t_{i+1} < t_N = T$ and let $(\rho^{(1)}, q^{(1)}), \dots, (\rho^{(N)}, q^{(N)})$ be defined recursively as follows. First,*

$(\rho^{(1)}, q^{(1)})$ is an entropy solution in the sense of Definition 2.1 to the constrained Cauchy problem (1.1), (1.3) with initial datum ρ_0 , constraint operator \mathcal{Q} and time horizon t_1 .

Then for $i = 2, \dots, N$, we set $\rho_0^{(i)} = \rho^{(i-1)}(t_{i-1} - t_{i-2})$ and for $s \in [0, t_i - t_{i-1}]$, $q^{(i)}(s) := \mathcal{Q}^{(i)}[\rho](s) = \mathcal{Q}[\mathcal{E}^{(i)}[\rho]](s + t_{i-1})$, where¹

$$\mathcal{E}^{(i)}[\rho](t) := \rho_0 \mathbf{1}_{\{0\}}(t) + \sum_{j=1}^{i-1} \rho^{(j)}(t - t_{j-1}) \mathbf{1}_{(t_{j-1}, t_j]}(t) + \rho(t - t_{i-1}) \mathbf{1}_{(t_{i-1}, t_i]}(t).$$

With these notations in hand, we assume that

$(\rho^{(i)}, q^{(i)})$ is an entropy solution in the sense of Definition 2.1 of the constrained Cauchy problem (1.1), (1.3) with initial datum $\rho_0^{(i)}$, constraint operator $\mathcal{Q}^{(i)}$ and time horizon $t_i - t_{i-1}$.

Then the couple (ρ, q) , with ρ defined on $[0, T] \times \mathbb{R}$ by

$$(3.1) \quad \rho(t, \cdot) = \rho_0 \mathbf{1}_{\{0\}}(t) + \sum_{i=1}^N \rho^{(i)}(t - t_{i-1}, \cdot) \mathbf{1}_{(t_{i-1}, t_i]}(t)$$

and q defined a.e. on $[0, T]$ by

$$(3.2) \quad q = \sum_{i=1}^N q^{(i)}(t - t_{i-1}) \mathbf{1}_{(t_{i-1}, t_i]}(t)$$

is an entropy solution to the constrained Cauchy problem (1.1), (1.3) in the sense of Definition 2.1 with initial datum ρ_0 , constraint operator \mathcal{Q} and time horizon T .

Moreover, if at every stage of the construction $(\rho^{(i)}, q^{(i)})$, $i = 1, \dots, N$, are unique, then the uniqueness of the entropy solution to (1.1), (1.3) also holds.

¹The constraints $\mathcal{Q}^{(i)}$ depend explicitly on the time variable, through the already constructed functions $\rho^{(j)}$, $j = 1, \dots, i-1$. This explicit time dependence is handled without any additional difficulty within the construction of Theorem 3.1.

Proof. The fact that (ρ, q) given by (3.1), (3.2) is an entropy solution until time T follows by a direct verification of Definition 2.1 globally on $[0, T]$. First, Definition 2.1(ii) comes from the fact that by construction and due to the property (\mathbf{Q}^{hd}) , we have for all $i = 1, \dots, N$, for a.e. $s \in [t_{i-1}, t_i]$,

$$\mathcal{Q}[\rho](s) = \mathcal{Q}^{(i)}[\rho^{(i)}](s + t_{i-1}) = q^{(i)}(s + t_{i-1}) = q(s).$$

Second, observe that due to the time continuity of entropy solutions we can extend (2.3a)-(2.3c) to test functions supported in $[0, T] \times \mathbb{R}$ with the additional term $\int_{\mathbb{R}} |\rho(T, x) - k| \phi(T, x) dx$ in the right-hand side. Therefore it is immediate to check the entropy inequalities for ρ with test functions restricted to $[t_{i-1}, t_i]$; this is a mere time translation of the corresponding inequalities (2.3a)-(2.3c) (with the extra term at $t = t_i - t_{i-1}$) for $\rho^{(i)}$. Then it is enough to sum up the entropy inequalities corresponding to different values of i and to use cancel the terms accounting for $t = t_i$, $i = 1, \dots, N-1$, due to the fact that, by construction, $\rho^{(i+1)}(0, \cdot) = \rho^{(i)}(t_i - t_{i-1}, \cdot)$ whence

$$\int_{\mathbb{R}} |\rho^{(i)}(t_i - t_{i-1}, x) - k| \phi(t_i, x) dx - \int_{\mathbb{R}} |\rho^{(i+1)}(0, x) - k| \phi(t_i, x) dx = 0.$$

Finally, assume that at every stage of the construction, uniqueness of $(\rho^{(i)}, q^{(i)})$ holds. Assume that $(\tilde{\rho}, \tilde{q})$ is a solution on $[0, T]$. The function $\tilde{\rho}^{(1)} = \tilde{\rho}|_{[0, t_1]}$ solves the same problem as $\rho^{(1)}$, therefore $\tilde{\rho}^{(1)} \equiv \rho^{(1)}$. Then the initial data and the constraint operators defining $\rho^{(2)}$ and $\tilde{\rho}^{(2)} : (t, \cdot) \mapsto \rho(t + t_1, \cdot)$ on $[0, t_2 - t_1]$ coincide, therefore $\tilde{\rho}^{(2)} \equiv \rho^{(2)}$. Continuing by induction, we find that $\tilde{\rho} = \rho$ and conclude to uniqueness of the entropy solution to (1.1), (1.3) with initial datum ρ_0 , constraint operator \mathcal{Q} and time horizon T . \square

Before stating our main results, let us recall the uniform Lipschitz continuity estimate for the maps \mathcal{R}_t obtained in [6, Proposition 2.10].

Lemma 3.2. *For any $q, \tilde{q} \in \mathbf{L}^\infty(0, T)$ and $t \in [0, T]$ we have*

$$(3.3) \quad \|\mathcal{R}_t[q] - \mathcal{R}_t[\tilde{q}]\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)} \leq 2\|q - \tilde{q}\|_{\mathbf{L}^1(0, t)}.$$

Further, let us give constraint-independent bounds in $\mathbf{C}^0(0, T; \mathbf{L}^1)$ on the component ρ of entropy solutions of (1.1). They will be used to ensure boundedness and \mathbf{L}^1 -tightness of families of entropy solutions (or approximate entropy solutions) to constrained problems.

Lemma 3.3. *Let \mathbb{T} be the triangle $\{(t, x) : 0 \leq t \leq T, |x| \leq \text{Lip}(f)t\}$. Fix an initial datum $\rho_0 \in \mathbf{L}^1(\mathbb{R}; [0, \rho_{\max}])$ and let $\rho_{\text{free}} \in \mathbf{C}^0(0, T; \mathbf{L}^1)$ be the entropy solution of the unconstrained Cauchy problem (1.1a), (1.1c). Then for any constraint q , the entropy solution ρ of the constrained Cauchy problem (1.1) verifies*

- $\|\rho\|_{\mathbf{C}^0(0, T; \mathbf{L}^1)} = \|\rho_0\|_{\mathbf{L}^1(\mathbb{R})}$;
- $0 \leq \rho \leq \rho_{\max}$ a.e. on \mathbb{T} ;
- $\rho \equiv \rho_{\text{free}}$ and $\inf(\rho_0) \leq \rho \leq \sup(\rho_0)$ a.e. on $\mathbb{T}^c = ([0, T] \times \mathbb{R}) \setminus \mathbb{T}$.

In particular, given ρ_0 and T , the image of \mathcal{R}_T is bounded in $\mathbf{C}^0(0, T; \mathbf{L}^1)$.

Proof. The first claim is obvious because $\|\rho(t)\|_{\mathbf{L}^1(\mathbb{R})} = \|\rho_0\|_{\mathbf{L}^1(\mathbb{R})}$ for all $t \geq 0$. Since the speed of propagation of the waves is bounded from above by $\text{Lip}(f)$, the restriction of ρ to \mathbb{T}^c can be seen as the entropy solution to a Dirichlet boundary problem defined in a non-cylindrical domain, and then one can observe that the Dirichlet data are ignored according to the Bardos-LeRoux-Nédélec interpretation [9]; cf. [1] for details of the argument. As a consequence, the restriction of ρ to \mathbb{T}^c is fully determined by the initial datum alone and thus it coincides with the restriction of ρ_{free} to \mathbb{T}^c . The bounds therefore follows readily from the fact that ρ_{free} satisfies the maximum principle and from the fact that in \mathbb{T} , ρ takes values in $[0, \rho_{\max}]$. Then the last claim is an immediate consequence of these bounds. \square

3.2. A well-posedness result. We start with the following well-posedness result.

Theorem 3.1.

- (1) *If \mathcal{Q} verifies $(\mathbf{Q}^{\text{Lip}})$, then the constrained Cauchy problem (1.1), (1.3) admits one and only one entropy solution in the sense of Definition 2.1.*
- (2) *The conclusion of (1) still holds true if \mathcal{Q} is equivalent in the sense of Definition 2.2 to a constraint $\hat{\mathcal{Q}}$ that verifies the assumption $(\mathbf{Q}^{\text{Lip}})$.*

Proof. The second claim obviously follows from the first one. Therefore only the first claim has to be proved. Observe that a couple $(\rho, q) \in \mathbf{C}^0(0, T; \mathbf{L}^1) \times \mathbf{L}^1(0, T)$ is an entropy solution of (1.1), (1.3) if and only if ρ is a fixed point of the map $\mathcal{F}_T = \mathcal{R}_T \circ \mathcal{Q}_T$. We will prove the theorem by applying the Banach-Picard fixed point theorem for sufficiently small T . The general claim of existence and uniqueness follows then by bootstrapping the construction, according to Lemma 3.1.

Let $t_1 > 0$ be sufficiently small such that $N = T/t_1 \in \mathbb{N}$ and $2\omega(t_1) < 1$, where ω is the function defined in $(\mathbf{Q}^{\text{Lip}})$. Combining (3.3) with $(\mathbf{Q}^{\text{Lip}})$, we find for all $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$

$$\begin{aligned} \|\mathcal{F}_{t_1}[\rho_1] - \mathcal{F}_{t_1}[\rho_2]\|_{\mathbf{C}^0(0, t_1; \mathbf{L}^1)} &\leq 2\|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^1(0, t_1)} \\ &\leq 2\omega(t_1 - \tau)\|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t_1; \mathbf{L}^1)} < \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t_1; \mathbf{L}^1)}, \end{aligned}$$

where $\tau \in [0, t_1]$ is the largest time for which $\rho_1(s, \cdot) = \rho_2(s, \cdot)$ in $\mathbf{L}^1(\mathbb{R})$ for all $s \in [0, \tau]$. Moreover, according to Lemma 3.3, the image of \mathcal{R}_{t_1} is included in a ball B of $\mathbf{C}^0(0, t_1; \mathbf{L}^1)$ centred in 0 and with radius $\|\rho_0\|_{\mathbf{L}^1(\mathbb{R})}$, therefore, all fixed points of \mathcal{T}_{t_1} are included in this ball. Hence we can apply the contractive fixed point theorem to the restriction $\mathcal{T}|_B$ of \mathcal{T} to B and conclude that there exists a unique solution $\rho^{(1)}$ of our problem with time horizon t_1 . We bootstrap the argument applying Lemma 3.1 with $t_i = i t_1$. Indeed, using property $(\mathbf{Q}^{\text{Lip}})$ with $\tau = t_1$ we find the possibility to extend the solution defined on $[0, t_1]$ to the larger interval $[0, 2t_1]$. Continuing in this way, we obtain a uniform partition of $[0, T]$ on which we can apply both existence and uniqueness claims of Lemma 3.1. This concludes the proof. \square

In practice, verification of assumption $(\mathbf{Q}^{\text{Lip}})$ may be tedious. Therefore we provide the following corollary based on sufficient conditions.

Corollary 3.1. *A constraint operator \mathcal{Q} satisfies $(\mathbf{Q}^{\text{Lip}})$ and the corresponding constrained Cauchy problem (1.1), (1.3) admits one and only one entropy solution in the sense of Definition 2.1 if one of the following conditions is satisfied:*

- (1) \mathcal{Q}_t verifies (2.1) for all $t \in [0, T]$.
- (2) \mathcal{Q}_t verifies (2.2) for all $t \in [0, T]$.

Proof. Assume that ρ_1 and ρ_2 coincide in $\mathbf{L}^1(\mathbb{R})$ up to a time $\tau \leq t$.

- (1) If \mathcal{Q}_t verifies (2.1) for all $t \in [0, T]$, then

$$\begin{aligned} \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^1(0,t)} &\leq C \|\rho_1 - \rho_2\|_{\mathbf{L}^1(0,t;\mathbf{L}^1)} = C \int_{\tau}^t \|\rho_1(s, \cdot) - \rho_2(s, \cdot)\|_{\mathbf{L}^1(\mathbb{R})} ds \\ &\leq C(t - \tau) \max_{s \in [\tau, t]} \|\rho_1(s, \cdot) - \rho_2(s, \cdot)\|_{\mathbf{L}^1(\mathbb{R})} = C(t - \tau) \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0,t;\mathbf{L}^1)}. \end{aligned}$$

- (2) First, observe that (2.2) implies property (\mathbf{Q}^{hd}) . Therefore, $\mathcal{Q}[\rho_1]$ and $\mathcal{Q}[\rho_2]$ also coincide up to the time τ . Hence, if \mathcal{Q}_t verifies (2.2) for all $t \in [0, T]$, then

$$\begin{aligned} \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^1(0,t)} &= \int_{\tau}^t |\mathcal{Q}[\rho_1](s) - \mathcal{Q}[\rho_2](s)| ds \leq (t - \tau) \text{ess sup}_{s \in [\tau, t]} |\mathcal{Q}[\rho_1](s) - \mathcal{Q}[\rho_2](s)| \\ &= (t - \tau) \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^\infty(0,t)} \leq (t - \tau) C \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0,t;\mathbf{L}^1)}. \end{aligned}$$

Thus in both cases we proved that $(\mathbf{Q}^{\text{Lip}})$ holds with $\omega = C \text{Id}$ and Theorem 3.1 applies. \square

Remark 3.1. One can also get a result of continuous dependence on ρ using the above technique. To this end, it is enough to include a term in the right-hand side of (3.3) to account for the \mathbf{L}^1 difference of initial conditions, and to use the version of Banach fixed point theorem with parameter.

However, to state continuous dependence result in a more natural way (in this case, also a dependence on \mathcal{Q} can be studied), one can use the technique of Gronwall inequalities under the appropriate assumptions. We will not pursue this line here, referring to [4] for an example. Observe that continuous dependence estimates obtained with these techniques may be very pessimistic, cf. [2]. \square

3.3. Existence results. While uniqueness and continuous dependence arguments developed or evoked in the previous paragraph seem to require some kind of Lipschitz continuity of \mathcal{Q} , existence results can be obtained in much more generality. We have

Theorem 3.2. *The constrained Cauchy problem (1.1), (1.3) admits at least one entropy solution in the sense of Definition 2.1 if one of the following conditions is satisfied:*

- (a) \mathcal{Q} satisfies $(\mathbf{Q}^{\text{comp}})$.
- (b) f satisfies (\mathbf{GNL}) and \mathcal{Q} satisfies $(\mathbf{Q}^{\text{cont}})$.

The same conclusion holds if \mathcal{Q} is equivalent to a constraint operator that satisfies (a) or (b).

Proof. As in the proof of Theorem 3.1, we reduce the question of existence of an entropy solution to the problem (1.1), (1.3) to the question of existence of a fixed point for the map \mathcal{T}_T . Moreover, the last claim is an obvious consequence of the claims of the theorem in the cases (a) and (b), which we now prove.

(a) We have seen in the proof of Theorem 3.1 that the definition of \mathcal{T}_T can be restricted to a ball B of $\mathbf{C}^0(0, T; \mathbf{L}^1)$ such that \mathcal{T}_T acts from the convex set B into itself. Due to estimate (3.3) and assumption $(\mathbf{Q}^{\text{comp}})$, the map \mathcal{T}_T is continuous from $\mathbf{C}^0(0, T; \mathbf{L}^1)$ to itself. Moreover, due to $(\mathbf{Q}^{\text{comp}})$ the image $\mathcal{T}_T(B)$ is relatively compact in $\mathbf{C}^0(0, T; \mathbf{L}^1)$ and one can apply the Schauder fixed point theorem in $\mathbf{C}^0(0, T; \mathbf{L}^1)$ to get existence of a solution.

(b) Now, under assumptions (\mathbf{GNL}) , $(\mathbf{Q}^{\text{cont}})$, we will replace the space $\mathbf{C}^0(0, T; \mathbf{L}^1)$ by $\mathbf{L}^1(0, T; \mathbf{L}^1)$. Then we define \mathcal{T}_T from $\mathbf{L}^1(0, T; \mathbf{L}^1)$ into $\mathbf{C}^0(0, T; \mathbf{L}^1) \subset \mathbf{L}^1(0, T; \mathbf{L}^1)$. As before, due to Lemma 3.3 we can restrict this map to the ball B' of $\mathbf{L}^1(0, T; \mathbf{L}^1)$ centred in 0 and with radius $T \|\rho_0\|_{\mathbf{L}^1(\mathbb{R})}$. We use the continuity assumption $(\mathbf{Q}^{\text{cont}})$ along with the estimate (3.3) and the continuous embedding of $\mathbf{C}^0(0, T; \mathbf{L}^1)$ into $\mathbf{L}^1(0, T; \mathbf{L}^1)$ in order to justify the continuity of this restriction of \mathcal{T}_T . It remains to prove the relative compactness of the image $\mathcal{T}_T(B')$; then existence of a fixed point of \mathcal{T}_T in $\mathcal{T}_T(B') \subset \mathbf{C}^0(0, T; \mathbf{L}^1)$ follows, therefore we get an entropy solution to our problem (1.1), (1.3). To prove the relative compactness of $\mathcal{T}_T(B')$, observe that one has the $\mathbf{L}_{\text{loc}}^1((0, T) \times \mathbb{R})$ relative compactness of uniformly bounded families of (local) entropy solutions of equation (1.1a) due to the genuine nonlinearity assumption (\mathbf{GNL}) (see [42,

40]). It remains to upgrade the $\mathbf{L}_{\text{loc}}^1$ to \mathbf{L}^1 compactness, which is possible in our case due to the uniform tightness property for functions in $\mathcal{F}_T(B')$, which is a consequence of the last claim of Lemma 3.3 all functions in $\mathcal{F}_T(B')$ are dominated by a fixed $\mathbf{C}^0(0, T; \mathbf{L}^1)$ function ρ_{free} . This concludes the proof of the theorem. \square

In the spirit of Corollary 3.1, let us point out that the compactness assumption on \mathcal{Q} can follow from the stronger assumption of compactness of \mathcal{Q} as operator from $\mathbf{C}^0(0, T; \mathbf{L}^1)$ to $\mathbf{L}^\infty(0, T)$; we refer to Section 4 for examples where the latter assumption is easy to check.

4. BASIC EXAMPLES OF CONSTRAINT OPERATORS

In this section we introduce some examples of constraint operators satisfying the hypotheses of Theorem 3.1, whence existence and uniqueness results for the corresponding constrained Cauchy problems (1.1), (1.3) follow. This list is of course not exhaustive, but we indicate several ways to average density or flux values so that to ensure the continuity of averages with respect to the a.e. convergence of solutions. As a consequence it is possible to use these examples as “building blocks” to construct more complex constraint operators to which the theory in the previous section applies.

Example 4.1. Let us consider first the constraint operator \mathcal{Q} defined by (1.5), introduced in the framework of evacuation of a crowd through an exit door in [4] and numerically studied in [3]. Existence and uniqueness of the entropy solution to the constrained Cauchy problem (1.1), (1.3), (1.5) is proved in [4, Theorem 3.1]. Thanks to Theorem 3.1, we can give a shorter alternative proof which requires weaker hypotheses on p and w . However this proof does not lead to a practically implementable construction procedure, and it does not give any hint on the behaviour of the entropy solution nor *a priori* bounds of its total variation, unlike to the (much longer) arguments of [4]. Observe that in the present setting we do not need to assume **(GNL)** for f .

First, the property **(Q^{hd})** is clearly satisfied by (1.5). If p and w are as in **(PWK)**, then for any $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$ and $t \in [0, T]$ we have

$$\begin{aligned} \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^\infty(0, t)} &\leq \text{Lip}(p) \text{ess sup}_{s \in (0, t)} \left| \int_{\mathbb{R}_-} [\rho_1(s, x) - \rho_2(s, x)] w(x) dx \right| \\ &\leq \text{Lip}(p) \|w\|_{\mathbf{L}^\infty(\mathbb{R})} \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}. \end{aligned}$$

Therefore, condition (2.2) is satisfied with $C = \text{Lip}(p) \|w\|_{\mathbf{L}^\infty(\mathbb{R})}$. Hence by virtue of Corollary 3.1 the constraint operator given by (1.5) enjoys **(Q^{Lip})** and the constrained Cauchy problem (1.1), (1.3), (1.5) admits one and only one entropy solution in the sense of Definition 2.1. \square

Example 4.2. Consider the case of a constraint operator $\mathcal{Q}[\rho]$ that depends on the values of ρ at times belonging to an a priori fixed discrete set. More specifically, let $t_1, \dots, t_M \in [0, T]$ with $t_i < t_{i+1}$ and take

$$(4.1) \quad \mathcal{Q}[\rho](t) = p(\xi(t)), \quad \xi(t) = \sum_{t_i \leq t} \int_{\mathbb{R}} w_i(t, x) \rho(t_i, x) dx,$$

where $w_1, \dots, w_M: [0, T] \times \mathbb{R} \rightarrow \mathbb{R}$ are in \mathbf{L}^∞ . By definition the property **(Q^{hd})** is clearly satisfied. If $p \in \mathbf{Lip}(\mathbb{R}; [0, f_{\text{max}}])$, then for any $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$ and $t \in [0, T]$ we have

$$\begin{aligned} \|\mathcal{Q}[\rho_1] - \mathcal{Q}[\rho_2]\|_{\mathbf{L}^\infty(0, t)} &\leq \text{Lip}(p) \text{ess sup}_{s \in (0, t)} \left| \sum_{t_i \leq s} \int_{\mathbb{R}} w_i(s, x) [\rho_1(t_i, x) - \rho_2(t_i, x)] dx \right| \\ &\leq \left[\text{Lip}(p) \sum_{i=1}^M \|w_i\|_{\mathbf{L}^\infty(0, T; \mathbf{L}^\infty)} \right] \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}. \end{aligned}$$

Therefore, condition (2.2) is satisfied with $C = \text{Lip}(p) \sum_{i=1}^M \|w_i\|_{\mathbf{L}^\infty(0, T; \mathbf{L}^\infty)}$. Hence, by virtue of Corollary 3.1, the constraint operator given by (4.1) enjoys **(Q^{Lip})** and the constrained Cauchy problem (1.1), (1.3), (4.1) admits one and only one entropy solution in the sense of Definition 2.1. \square

Example 4.3. Consider a constraint operator \mathcal{Q} such that $\mathcal{Q}[\rho](t)$ depends on the weighted average of $f(\rho)$ in $y \in \mathbb{R}$ on the time interval $[\max\{0, t - \tau\}, t]$, with $\tau > 0$. This can be expressed by introducing $r \in \mathbf{Lip}(\mathbb{R}_+; [0, f_{\text{max}}])$, κ as in **(PWK)** and by requiring that

$$(4.2) \quad \mathcal{Q}[\rho](t) = r(\eta(t)), \quad \eta(t) = \int_0^t \kappa(t-s) f(\rho)(s, y^-) ds.$$

Proving any continuity property for \mathcal{Q} is not possible because its definition involves the traces of a function in $\mathbf{L}^1(\mathbb{R}; \mathbb{R})$; to be precise, the operator \mathcal{Q} is not well defined on the functional spaces we consider. However it is well defined for functions ρ satisfying (1.1a) in the weak sense, because the field $(\rho, f(\rho))$ in the (t, x) -plane is divergence-free. For this reason we construct a constraint operator $\widehat{\mathcal{Q}}$ equivalent to \mathcal{Q} in the sense of Definition 2.2, which is well defined and for which continuity (and even Lipschitz continuity) can be easily proved. We fix $\phi \in \mathbf{Lip}([0, T] \times (-\infty, y])$ such that $\phi(t, y) = \kappa(t)$ and $x \mapsto \phi(t, x)$ is increasing. Introduce the constraint operator

$$(4.3a) \quad \widehat{\mathcal{Q}}[\rho](t) = r(\xi(t))$$

with

$$(4.3b) \quad \xi = \xi^a + \xi^b + \xi^c,$$

$$(4.3c) \quad \xi^a(t) = \int_0^t \int_{-\infty}^y [-\rho(s, x) \phi_t(t-s, x) + f(\rho)(s, x) \phi_x(t-s, x)] dx ds,$$

$$(4.3d) \quad \xi^b(t) = - \int_{-\infty}^y \rho(t, x) \phi(0, x) dx,$$

$$(4.3e) \quad \xi^c(t) = \int_{-\infty}^y \rho_0(x) \phi(t, x) dx.$$

Observe that ξ^b and ξ^c have the same form as the argument of p in examples 4.1 and 4.2, respectively. The property (\mathbf{Q}^{hd}) is clearly satisfied by the constraint operators under consideration. Moreover, by a direct application of the integration by parts formula we obtain the equivalence of the two operators \mathcal{Q} and $\widehat{\mathcal{Q}}$, see Example 2.2.

We prove now that $\widehat{\mathcal{Q}}$ satisfies $(\mathbf{Q}^{\text{Lip}})$. For any $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$ and $t \in [0, T]$ we have

$$\begin{aligned} |\widehat{\mathcal{Q}}[\rho_1](t) - \widehat{\mathcal{Q}}[\rho_2](t)| &\leq \text{Lip}(r) \left[|\xi_1^a(t) - \xi_2^a(t)| + |\xi_1^b(t) - \xi_2^b(t)| \right] \\ &\leq \text{Lip}(r) \left[\text{Lip}(\phi) (1 + \text{Lip}(f)) T + \|\phi\|_{\mathbf{C}^0(0, t; \mathbf{L}^\infty)} \right] \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}, \end{aligned}$$

where ξ_i^a, ξ_i^b correspond to ρ_i , $i = 1, 2$. Therefore $\widehat{\mathcal{Q}}$ satisfies (2.2) and, by Corollary 3.1, it satisfies also $(\mathbf{Q}^{\text{Lip}})$ and the constrained Cauchy problem (1.1), (1.3), (4.3) admits one and only one entropy solution in the sense of Definition 2.1. \square

Let us underline the following observations:

- In Example 4.2, ξ accounts for a space average of the density at some specific moments of time, the value of ξ being transformed into a constraint value by the nonlinear map p .
- In Example 4.3, η accounts for a time average of the flux at a specific location in space, the value of η being transformed into a constraint value by the nonlinear map r .

If the flux f is bell shaped, see (\mathbf{F}) , then the link between the two examples for subjective densities lower than ρ_c can be provided by the choice $r = p \circ f^{-1}$, where f_- is the restriction of f to $[0, \rho_c]$.

Example 4.4. Inspired by the examples 1.3 and 2.1, we propose a class of operators

$$(4.4) \quad \widehat{\mathcal{Q}}[\rho](t) = p(\xi(t)),$$

where p is given by (\mathbf{PWK}) and ξ is the solution to the Cauchy problem for an ODE

$$(4.5) \quad \dot{\xi}(t) = H\left(\xi(t), \int_{\mathbb{R}_-} F(t, x, \rho(t, x)) dx\right), \quad \xi(0) = \xi_0[\rho_0].$$

Above $\xi_0: \mathbf{L}^1(\mathbb{R}) \rightarrow \mathbb{R}$,

$$(4.6) \quad H \in \mathbf{Lip}(\mathbb{R} \times \mathbb{R}; \mathbb{R})$$

and

$$(4.7) \quad F \in \mathbf{C}_c^0([0, T] \times \mathbb{R}_- \times [0, \rho_{\max}]; \mathbb{R}) \text{ and there exists a constant } L_F > 0 \text{ such that for any } (t, x) \in [0, T] \times \mathbb{R}_- \text{ and } \rho_1, \rho_2 \in [0, \rho_{\max}]$$

$$|F(t, x, \rho_1) - F(t, x, \rho_2)| \leq L_F |\rho_1 - \rho_2|.$$

The property (\mathbf{Q}^{hd}) is clearly satisfied by $\widehat{\mathcal{Q}}$. Moreover for any $\rho_1, \rho_2 \in \mathbf{C}^0(0, T; \mathbf{L}^1)$ and $t \in [0, T]$, if ξ_1 and ξ_2 are the corresponding solutions of (4.5), then

$$\begin{aligned} |\xi_1(t) - \xi_2(t)| &\leq \text{Lip}(H) \left[|\xi_1(t) - \xi_2(t)| + \int_{\mathbb{R}_-} |F(t, x, \rho_1(t, x)) - F(t, x, \rho_2(t, x))| dx \right] \\ &\leq \text{Lip}(H) \left[|\xi_1(t) - \xi_2(t)| + L_F \int_{\mathbb{R}_-} |\rho_1(t, x) - \rho_2(t, x)| dx \right] \\ &\leq \text{Lip}(H) \left[|\xi_1(t) - \xi_2(t)| + L_F \|\rho_1(t, \cdot) - \rho_2(t, \cdot)\|_{\mathbf{L}^1(\mathbb{R})} \right] \end{aligned}$$

and by the Gronwall lemma we have

$$\begin{aligned} |\xi_1(t) - \xi_2(t)| &\leq \text{Lip}(H) L_F \int_{\min\{\tau, t\}}^t \|\rho_1(s, \cdot) - \rho_2(s, \cdot)\|_{\mathbf{L}^1(\mathbb{R})} e^{\text{Lip}(H)(t-s)} ds \\ &\leq \text{Lip}(H) L_F e^{\text{Lip}(H)T} T \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}, \end{aligned}$$

where $\tau = \max\{s \in [0, T] : \rho_1 = \rho_2 \text{ in } \mathbf{C}^0(0, s; \mathbf{L}^1)\}$. Therefore, we have that

$$\|\widehat{\mathcal{Q}}_t[\rho_1] - \widehat{\mathcal{Q}}_t[\rho_2]\|_{\mathbf{L}^1(0, t)} \leq [\text{Lip}(p) \text{Lip}(H) L_F e^{\text{Lip}(H)T} T^2] \|\rho_1 - \rho_2\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}$$

and $\widehat{\mathcal{Q}}_t: \mathbf{C}^0(0, t; \mathbf{L}^1) \rightarrow \mathbf{L}^1(0, t)$ is Lipschitz continuous. Moreover, we have that

$$\begin{aligned} & \left\| \widehat{\mathcal{Q}}_t[\rho_1] - \widehat{\mathcal{Q}}_t[\rho_2] \right\|_{\mathbf{L}^1(0, t)} \leq \\ & \leq \text{Lip}(p) \text{Lip}(H) L_F \int_0^t \int_{\min\{\tau, s\}}^s \left\| \rho_1(r, \cdot) - \rho_2(r, \cdot) \right\|_{\mathbf{L}^1(\mathbb{R})} e^{\text{Lip}(H)(s-r)} dr ds \\ & \leq \left[\text{Lip}(p) \text{Lip}(H) L_F \int_0^t \int_{\min\{\tau, s\}}^s e^{\text{Lip}(H)(s-r)} dr ds \right] \left\| \rho_1 - \rho_2 \right\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}. \end{aligned}$$

It is readily seen that the factor in front of $\left\| \rho_1 - \rho_2 \right\|_{\mathbf{C}^0(0, t; \mathbf{L}^1)}$ vanishes as $(t - \tau) \rightarrow 0$. In conclusion we proved that $\widehat{\mathcal{Q}}$ satisfies $(\mathbf{Q}^{\text{Lip}})$ and the constrained Cauchy problem (1.1), (1.3), (4.4) admits one and only one entropy solution in the sense of Definition 2.1. \square

Remark 4.1. It is easy to relax the hypothesis of Lipschitz continuity on H in Example 4.4 to prove the existence of an entropy solution to (1.1), (1.3), (4.4), (4.5). Indeed equation (4.5) admits a local solution provided the function H is continuous. If in addition H is bounded, then the solution ξ is global and is uniformly in \mathbf{BV} . This is enough to ensure that property $(\mathbf{Q}^{\text{comp}})$ holds. \square

Remark 4.2. Observe that the ODE in (2.5) in Example 2.1 can be written in the form (4.5). Indeed, let $\phi: [0, t] \times \mathbb{R}_- \rightarrow \mathbb{R}_+$ be an arbitrary Lipschitz function such that $\phi(\cdot, 0) = 1$ and $\text{supp}(\phi) \subset (0, t) \times \mathbb{R}_-$, then by the integration by parts formula and by using the fact that ρ satisfies (1.1a) in $\mathcal{D}'([0, T] \times \mathbb{R})$, we can express ξ as follows

$$\begin{aligned} \xi(t) - \xi(0) &= \int_0^t \left\{ \int_{\mathbb{R}_-} w'(x) f(\rho)(s, x) dx - w(0) f(\rho)(s, 0^-) \right\} ds \\ &= \int_0^t \int_{\mathbb{R}_-} \left\{ w'(x) f(\rho)(s, x) - [w(x) \phi(s, x) f(\rho)(s, x)]_x \right\} dx ds \\ &= \int_0^t \int_{\mathbb{R}_-} \left\{ [w(x) [1 - \phi(s, x)]]_x f(\rho)(s, x) + w(x) \phi(s, x) \rho_s(s, x) \right\} dx ds \\ &= \int_0^t \int_{\mathbb{R}_-} \left\{ [w(x) [1 - \phi(s, x)]]_x f(\rho)(s, x) - w(x) \phi_s(s, x) \rho(s, x) \right\} dx ds \end{aligned}$$

and we can write the ODE in (2.5) as follows

$$\dot{\xi}(t) = \int_{\mathbb{R}_-} \left\{ [w(x) [1 - \phi(t, x)]]_x f(\rho)(t, x) - w(x) \phi_t(t, x) \rho(t, x) \right\} dx.$$

Hence (2.5) takes the form (4.5) with $H(\xi, I) = I$, $\xi_0[\rho_0] = \int_{\mathbb{R}_-} \rho_0(x) dx$ and

$$F(t, x, \rho) = [w(x) (1 - \phi(t, x))]_x f(\rho) - w(x) \phi_t(t, x) \rho.$$

The conditions (4.6), (4.7) are satisfied with $L_F = \text{Lip}(w(1 - \phi)) \text{Lip}(f) + w(0) \text{Lip}(\phi)$.

In particular the constrained Cauchy problem (1.1), (1.3), (2.4), (2.5) admits one and only one entropy solution in the sense of Definition 2.1. \square

Remark 4.3. With reference to Example 1.3, observe that the ODE in (1.8) can be written in the form (4.5). Indeed, analogously to Remark 4.2, for any Lipschitz function $\phi: [0, t] \times \mathbb{R}_- \rightarrow \mathbb{R}_+$ such that $\phi(\cdot, 0) = 1$ and $\text{supp}(\phi) \subset (0, t) \times \mathbb{R}_-$, we can take $H(\xi, I) = \max\{I, -\delta \xi\}$ and

$$F(t, x, \rho) = [w(x) (1 - \phi(t, x))]_x f(\rho) - w(x) \phi_t(t, x) \rho.$$

We stress that F is a function; indeed, even if w has a jump at zero, the factor of $w'(\cdot)$ is $(1 - \phi)$, which makes the product equal to zero at $x = 0$. The conditions (4.6), (4.7) are satisfied with $L_F = \text{Lip}(w(1 - \phi)) \text{Lip}(f) + w(0) \text{Lip}(\phi)$.

In particular the constrained Cauchy problem (1.1), (1.3), (1.7), (1.8) admits one and only one entropy solution in the sense of Definition 2.1. \square

Observe also that, taking the derivative of the function ξ defined by (4.3b) and integrating by part $\dot{\xi}_b$ defined by (4.3d), we obtain that the constraint operator $\widehat{\mathcal{Q}}$ defined by (4.3) belongs to the class introduced in Example 4.4.

5. FINITE VOLUME APPROXIMATION OF NONLOCALLY CONSTRAINED PROBLEMS

The results in the previous section can be obtained by using a fractional step procedure in the place of fixed point arguments in order to relax the coupling between ρ and q . As in the above proofs, Lipschitz continuity estimates or compactness arguments are the cornerstones of the convergence proofs for such approximation procedures. A combination of the classical wave-front tracking algorithm with fractional stepping was used in [4] for the case of the constraint (1.5). The advantage of the wave-front tracking technique is that it is constructive and can be used for numerical simulations (see in particular [4, Section 6]); but, because of the presence of “nonlocal interactions” and of fractional stepping, this algorithm turns out to be very heavy. In this section, we follow the fractional step strategy and the finite volume method to construct convenient numerical approximations. In particular, we design a discretization algorithm for problem (1.1), (1.3) and prove its convergence. The details of the discretization for (1.1)

and the scheme are essentially the same as in our work [3] devoted to the particular case of the constraint (1.5). Here, we focus first on properties required for the discretization of general constraints of the form (1.3), and then we apply the results to several examples of constraints relevant for modeling purposes. The convergence of the scheme will be proved under general assumptions, see $(\mathcal{Q}_\Delta^{\text{cons}})$ and $(\mathcal{Q}_\Delta^{\text{comp}})$.

5.1. Non-local constrained finite volume method. In this section we describe the numerical scheme based on finite volume method that we use to solve (1.1), (1.3) and we prove its convergence.

Let Δx and Δt be the constant space and time steps respectively. Introduce the points $x_{j+1/2} = j\Delta x$, the cells $K_j = [x_{j-1/2}, x_{j+1/2})$ and the cell centers $x_j = (j-1/2)\Delta x$ for $j \in \mathbb{Z}$. Let j_c be the index such that $x_{j_c+1/2}$ is the location of the constraint. Define $N = \lfloor T/\Delta t \rfloor$ and for $n \in \mathbb{N} \cap [0, N]$ introduce the time discretization $t^n = n\Delta t$. For $n \in \mathbb{N} \cap [0, N]$ and $j \in \mathbb{Z}$, we denote by ρ_j^n the approximation of the average of $\rho(t^n, \cdot)$ on the cell K_j , namely

$$\rho_j^0 = \frac{1}{\Delta x} \int_{K_j} \rho_0(x) dx \quad \text{and} \quad \rho_j^n \simeq \frac{1}{\Delta x} \int_{K_j} \rho(t^n, x) dx \quad \text{if } n > 0.$$

Let us introduce the discretized initial datum ρ_Δ^0 defined by

$$(5.1) \quad \rho_\Delta^0(x) = \rho_j^0 \quad \text{for } x \in K_j.$$

If ρ_0 is a piecewise continuous function, we can re-define ρ_j^0 as point values of ρ_0 at x_j or as the mean of the one-sided limits of ρ_0 at x_j if x_j is a point of jump. In all cases, we have convergence of ρ_Δ^0 to ρ_0 in $\mathbf{L}^1(\mathbb{R})$, moreover, ρ_Δ^0 obeys the same \mathbf{L}^∞ bounds as ρ_0 .

We seek for an approximate solution (ρ_Δ, q_Δ) defined on $[0, T] \times \mathbb{R}$, taking values in $[0, \rho_{\max}] \times [0, f_{\max}]$ and of the form

$$\rho_\Delta(t, x) = \sum_{n=1}^N \rho_\Delta^n(x) \mathbf{1}_{(t^{n-1}, t^n]}(t), \quad q_\Delta(t) = \sum_{n=1}^N q_\Delta^n \mathbf{1}_{(t^{n-1}, t^n]}(t).$$

where $(\rho_\Delta^n, q_\Delta^n)_{n=1, \dots, N}$ are discrete functions computed by executing the following algorithm, based on a suitable discretization \mathcal{Q}_Δ of \mathcal{Q} that satisfies (\mathbf{Q}^{hd}) .

0. Initialization. We start with the discretized initial datum ρ_Δ^0 given in (5.1) and an initial value of the constraint $q_\Delta^0 = \mathcal{Q}_\Delta[\rho_\Delta^0](0)$.
1. For each $n = 0, \dots, N-1$,
 - A. We recall that for the unconstrained Cauchy problem (1.1a), (1.1c), a standard finite volume method can be written into the form

$$(5.2) \quad \rho_j^{n+1} = \rho_j^n - \frac{\Delta t}{\Delta x} \left(\mathcal{F}_{j+1/2}^n - \mathcal{F}_{j-1/2}^n \right),$$

where $\mathcal{F}_{j+1/2}^n = F(\rho_j^n, \rho_{j+1}^n)$ is a monotone, consistent numerical flux, that is, F satisfies the following assumptions:

- * F is Lipschitz continuous from $[0, \rho_{\max}]^2$ to \mathbb{R} with Lipschitz constant $\text{Lip}(F)$,
- * $F(a, a) = f(a)$ for any $a \in [0, \rho_{\max}]$,
- * $[0, \rho_{\max}]^2 \ni (a, b) \mapsto F(a, b) \in [0, f_{\max}]$ is non-decreasing with respect to a and non-increasing with respect to b .

We also recall that in [6] the numerical flux for the Cauchy problem (1.1) with time dependent constraint q is modified as follows in order to take into account the constraint condition

$$(5.3) \quad \mathcal{F}_{j+1/2}^n = \begin{cases} F(\rho_j^n, \rho_{j+1}^n) & \text{if } j \neq j_c, \\ \min\{F(\rho_j^n, \rho_{j+1}^n), q_\Delta^n\} & \text{if } j = j_c, \end{cases}$$

where q_Δ^n is an approximation of $q(t^n)$.

- B. Given $(\rho_\Delta^k)_{k=1, \dots, n}$ with

$$\rho_\Delta^k(x) = \rho_j^n \quad \text{for } x \in K_j,$$

we compute $q_\Delta^n \in [0, f_{\max}]$ by discretizing relation (1.3):

$$(5.4) \quad q_\Delta^n = \mathcal{Q}_\Delta[\mathcal{E}^n[\rho_\Delta^n]](t^n)$$

where

$$\mathcal{E}^n[\rho_\Delta^n](t, x) = \sum_{k=1}^n \rho_\Delta^k(t - t^{k-1}, x) \mathbf{1}_{(t^{k-1}, t^k]}(t).$$

In the sequel, we will operate with the norm $\|\cdot\|_{\mathbf{L}^1(0,T)}$ for q_Δ and with the norm $\|\cdot\|_{\mathbf{L}^\infty(0,T;\mathbf{L}^1)}$ for ρ_Δ , both norms being computed from the above expressions of q_Δ and ρ_Δ as functions of t and (t, x) , respectively.

To prove convergence for this algorithm, we will need two specific properties of the discrete constraint operator \mathcal{Q}_Δ . First, we assume the following consistency for the approximation of \mathcal{Q} by \mathcal{Q}_Δ :

$$(\mathcal{Q}_\Delta^{\text{cons}}) \quad \left[q_\Delta = \mathcal{Q}_\Delta[\rho_\Delta], \ \|q_\Delta - q\|_{\mathbf{L}^1(0,T)} \rightarrow 0 \text{ and } \|\rho_\Delta - \rho\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \rightarrow 0 \right] \implies q = \mathcal{Q}[\rho].$$

Next, we require an asymptotic compactness property which we expect to be compatible with constraints satisfying the compactness assumption $(\mathbf{Q}^{\text{comp}})$, but also with some other constraints like (1.2) thanks to the idea of equivalence between constraints introduced in Definition 2.2:

$$(\mathcal{Q}_\Delta^{\text{comp}}) \quad \left[\begin{array}{l} \text{the sequence of approximate solutions } (\rho_\Delta) \text{ obtained} \\ \text{with the above algorithm is bounded in } \mathbf{L}^\infty(0, T; \mathbf{L}^1) \\ \text{and } q_\Delta = \mathcal{Q}_\Delta[\rho_\Delta] \end{array} \right] \implies (q_\Delta) \text{ is compact in } \mathbf{L}^1(0, T).$$

Here and in the sequel, by compactness of (q_Δ) we mean the possibility to extract a convergent subsequence in $\mathbf{L}^1(0, T)$, i.e., the relative compactness.

Remark 5.1. If a given constraint operator \mathcal{Q} verifies $(\mathbf{Q}^{\text{comp}})$, it is natural to construct discrete constraint operators (\mathcal{Q}_Δ) which verify $(\mathcal{Q}_\Delta^{\text{comp}})$ irrespective of the nature of the sequence (ρ_Δ) .

Nonetheless, observe that requiring the $(\mathcal{Q}_\Delta^{\text{comp}})$ only for approximate solutions (ρ_Δ) obtained with the algorithm described in this section makes the property much weaker: the sequence (ρ_Δ) need not to be arbitrary, but it solves a discretized PDE. Therefore, $(\mathcal{Q}_\Delta^{\text{comp}})$ is a joint property of discretizations of \mathcal{Q} and of the solution operator \mathcal{R} to a constrained Cauchy problem for a conservation law.

In this section, we do not formalize the idea of equivalence of two discrete constraint operators \mathcal{Q}_Δ and $\widehat{\mathcal{Q}}_\Delta$ like this was done in Definition 2.2 for the continuous case; but in the examples, we exploit the same idea by proving property $(\mathcal{Q}_\Delta^{\text{comp}})$ due to a transformation of \mathcal{Q}_Δ into a more convenient form, using the “weak formulation” of the scheme (5.2). \square

The alternative line of analysis, with space $\mathbf{C}^0(0, T; \mathbf{L}^1)$ for ρ replaced by $\mathbf{L}^1(0, T; \mathbf{L}^1)$ and asymptotic compactness for \mathcal{Q}_Δ replaced by the genuine nonlinearity assumption (\mathbf{GNL}) and a kind of asymptotic continuity assumption on (\mathcal{Q}_Δ) is briefly discussed in Remark 5.2.

5.2. Convergence of the scheme. Let us notice that as in [6, Proposition 4.2], under the CFL condition

$$(5.5) \quad \text{Lip}(F) \frac{\Delta t}{\Delta x} \leq \frac{1}{2},$$

we have the \mathbf{L}^∞ stability of the scheme (5.2), (5.3), (5.4), that is

$$(5.6) \quad 0 \leq \rho_\Delta(t, x) \leq \rho_{\max} \quad \text{for a.e. } (t, x) \in (0, T) \times \mathbb{R}.$$

We are now in a position to prove a convergence result for the scheme (5.2), (5.3), (5.4). We have the following results

Theorem 5.1. *Let \mathcal{Q} verify $(\mathbf{Q}^{\text{Lip}})$ and $(\tilde{\rho}, \tilde{q})$ be the unique entropy solution of (1.1), (1.3) in the sense of Definition 2.1.*

- (1) *Assume that the approximation \mathcal{Q}_Δ of \mathcal{Q} is consistent in the sense $(\mathcal{Q}_\Delta^{\text{cons}})$ and asymptotically compact in the sense $(\mathcal{Q}_\Delta^{\text{comp}})$. Then (ρ_Δ, q_Δ) constructed by the scheme (5.2), (5.3), (5.4) converges to $(\tilde{\rho}, \tilde{q})$ as $\Delta t, \Delta x \rightarrow 0$.*
- (2) *If \mathcal{Q} and $\widehat{\mathcal{Q}}$ are equivalent in the sense of Definition 2.2 and $\widehat{\mathcal{Q}}$ admits an approximation $\widehat{\mathcal{Q}}_\Delta$ that satisfies $(\mathcal{Q}_\Delta^{\text{cons}})$ and $(\mathcal{Q}_\Delta^{\text{comp}})$, then $(\widehat{\rho}_\Delta, \widehat{q}_\Delta)$ constructed by the scheme (5.2), (5.3), (5.4) corresponding to $\widehat{\mathcal{Q}}_\Delta$ converges to $(\tilde{\rho}, \tilde{q})$ as $\Delta t, \Delta x \rightarrow 0$.*

Proof. (1) By construction we have that (ρ_Δ) is uniformly bounded in $\mathbf{L}^\infty(0, T; \mathbf{L}^1)$. Therefore $(\mathcal{Q}_\Delta^{\text{comp}})$ gives the existence of a subsequence of (q_Δ) , still denoted (q_Δ) and a constraint function $q \in \mathbf{L}^1(0, T)$ such that (q_Δ) converges to q strongly in $\mathbf{L}^1(0, T)$ as $\Delta t \rightarrow 0$. Let $\rho \in \mathbf{C}^0([0, T]; \mathbf{L}_{\text{loc}}^1(\mathbb{R}; [0, \rho_{\max}]))$ be the unique entropy solution to (1.1) in the sense of Definition 2.1 (i) associated to q . We first prove that the subsequence (ρ_Δ) converges to ρ strongly in $\mathbf{L}^1(0, T; \mathbf{L}^1)$ as $\Delta t, \Delta x \rightarrow 0$. Let \widehat{q}_Δ be a piecewise constant (with step Δt) approximation of q such that \widehat{q}_Δ converges to q strongly in $\mathbf{L}^1(0, T)$. Let us introduce the auxiliary sequence $\widehat{\rho}_\Delta$ constructed by the scheme (5.2), (5.3) and associated to the sequence of discrete constraints \widehat{q}_Δ . We have

$$\|\rho - \rho_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \leq \|\rho - \widehat{\rho}_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} + \|\rho_\Delta - \widehat{\rho}_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)}.$$

But, thanks to [6, Theorem 4.9], under the CFL condition (5.5), $\|\rho - \widehat{\rho}_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)}$ tends to 0 as $\Delta t, \Delta x \rightarrow 0$. Furthermore, thanks to [3, Proposition 3.1], we have

$$\|\rho_\Delta - \widehat{\rho}_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \leq 2T \|q_\Delta - \widehat{q}_\Delta\|_{\mathbf{L}^1(0,T)},$$

which also shows that $\|\rho_\Delta - \widehat{\rho}_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)}$ tends to 0 as $\Delta t, \Delta x \rightarrow 0$. Now, by the definition of ρ , the couple (ρ, q) fulfills Definition 2.1 (i). Moreover, due to the above convergences of (ρ_Δ) and (q_Δ) and the consistency property $(\mathcal{Q}_\Delta^{\text{cons}})$, it

follows that (1.3) holds. Thus (ρ, q) coincides with the unique entropy solution $(\bar{\rho}, \bar{q})$. Finally, it is classical that the extraction of a subsequence can be bypassed due to the uniqueness of $(\bar{\rho}, \bar{q})$.

(2) This item follows from the definition of equivalent operators Definition 2.2 and (1). \square

Remark 5.2. We think that, like for the existence proof, in the above convergence result the discrete compactness assumption $(\mathbf{Q}^{\text{comp}})$ can be replaced by a discrete analogous of the mere continuity property $(\mathbf{Q}^{\text{cont}})$, whenever the genuine nonlinearity assumption (\mathbf{GNL}) on f is imposed. In this case, contrarily to the above proof one has to ensure in the first step the relative compactness of (ρ_Δ) . In the second step, discrete analogous of $(\mathbf{Q}^{\text{cont}})$ will ensure convergence of the sequence (q_Δ) associated to the convergent subsequence of (ρ_Δ) . Finally, $(\mathcal{Q}_\Delta^{\text{cons}})$ will permit us to link the respective limits ρ and q by the constraint relation (1.3).

However, quite technical arguments of the compensated compactness kind, based on (\mathbf{GNL}) , are required in order to handle (ρ_Δ) at the first step. Therefore we limit our convergence study to the setting of Theorem 5.1. Notice that such alternative kind of compactness argument is however needed in studying approximations of the constrained Aw, Rascle [8] and Zhang [49] model studied in [5], since the arguments in [6, Theorem 4.9] and in [3, Proposition 3.1] are specific to the scalar case. Studies of models as in [5] and of their approximation are postponed to future work. \square

6. EXAMPLES OF DISCRETE CONSTRAINT OPERATORS

In this section we apply the theory developed in Section 5 to construct and study discrete constraint operators corresponding to the constraint operators introduced in Section 4. In particular we prove that the hypotheses of Theorem 5.1 are satisfied and we infer the convergence of the scheme (5.2), (5.3), (5.4) as $\Delta t, \Delta x \rightarrow 0$ to the unique entropy solution of the corresponding constrained Cauchy problem (1.1), (1.3) in the sense of Definition 2.1.

Example 6.1. With reference to Example 1.2, we recall that as a discrete version of the constraint operator \mathcal{Q} defined in (1.5), in [3] the authors introduce

$$(6.1) \quad \mathcal{Q}_\Delta[\rho_\Delta](t) = p \left(\Delta x \sum_{j=j_w}^{j_c} \rho_j^n w_j \right) \quad \text{for } t \in (t^{n-1}, t^n],$$

where $w_j = \frac{1}{\Delta x} \int_{K_j} w(x) dx$ and j_w is an integer such that $\text{supp}(w) \subset \bigcup_{j_w \leq j \leq j_c} K_j$. Let's prove first that \mathcal{Q}_Δ enjoys property $(\mathcal{Q}_\Delta^{\text{cons}})$. If $\|\mathcal{Q}_\Delta[\rho_\Delta] - q\|_{\mathbf{L}^1(0,T)} \rightarrow 0$ and $\|\rho_\Delta - \rho\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \rightarrow 0$, then

$$\begin{aligned} \|\mathcal{Q}[\rho] - \mathcal{Q}_\Delta[\rho_\Delta]\|_{\mathbf{L}^1(0,T)} &\leq \text{Lip}(p) \sum_{j=j_w}^{j_c} \left\| \int_{K_j} [\rho(\cdot, x) w(x) - \rho_\Delta(\cdot, x) w_j] dx \right\|_{\mathbf{L}^1(0,T)} \\ &\leq \text{Lip}(p) \sum_{j=j_w}^{j_c} \left[\left\| \int_{K_j} \rho(\cdot, x) [w(x) - w_j] dx \right\|_{\mathbf{L}^1(0,T)} + \left\| \int_{K_j} [\rho(\cdot, x) - \rho_\Delta(\cdot, x)] w_j dx \right\|_{\mathbf{L}^1(0,T)} \right] \\ &\leq \text{Lip}(p) \sum_{j=j_w}^{j_c} \left[\rho_{\max} T \int_{K_j} |w(x) - w_j| dx + \|w\|_{\mathbf{L}^\infty(\mathbb{R})} \left\| \int_{K_j} |\rho(\cdot, x) - \rho_\Delta(\cdot, x)| dx \right\|_{\mathbf{L}^1(0,T)} \right] \\ &\leq \text{Lip}(p) \left[\rho_{\max} T \sum_{j=j_w}^{j_c} \int_{K_j} |w(x) - w_j| dx + \|w\|_{\mathbf{L}^\infty(\mathbb{R})} \|\rho - \rho_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \right] \xrightarrow{\Delta x \rightarrow 0} 0. \end{aligned}$$

Finally, let us prove also that $(\mathcal{Q}_\Delta^{\text{comp}})$ holds. By definition (ρ_Δ) are constructed by applying a conservative finite volume method, hence

$$\|\rho_\Delta\|_{\mathbf{L}^\infty(0,T;\mathbf{L}^1)} = \|\rho_\Delta^0\|_{\mathbf{L}^1(\mathbb{R})} = \|\rho_0\|_{\mathbf{L}^1(\mathbb{R})}.$$

We need to justify that $(\mathcal{Q}_\Delta[\rho_\Delta])$ is compact in $\mathbf{L}^1(0, T)$. This can be done by changing \mathcal{Q}_Δ under an equivalent form, see the proof of [3, Proposition 3.2], under the additional assumption of Lipschitz continuity of w . Namely, by [3, Proposition 3.2] we have that $(\mathcal{Q}_\Delta[\rho_\Delta])$ is uniformly bounded in \mathbf{BV} , and therefore it is compact in $\mathbf{L}^1(0, T)$. In conclusion, Theorem 5.1 applies if w satisfies (\mathbf{wLip}) . \square

Example 6.2. With reference to Example 4.2, let us introduce as a discrete version of operator defined in (4.1) the discrete constraint operator

$$(6.2) \quad \mathcal{Q}_\Delta[\rho_\Delta](t) = p(\xi_\Delta), \quad \xi_\Delta = \sum_{t_i < t} \int_{\mathbb{R}} w_i^\Delta(t, x) \rho_\Delta(t_i, x) dx$$

where

$$w_i^\Delta(t, x) = \frac{1}{\Delta x} \int_{K_j} w_i(t^{n-1}, y) dy, \quad \text{for } t \in (t^{n-1}, t^n] \text{ and } x \in K_j.$$

For simplicity assume that

(wLipPC) for any $t \in [0, T]$ we have $x \mapsto w_i(t, x)$ is in $\mathbf{Lip}(\mathbb{R}; \mathbb{R})$ and for any $x \in \mathbb{R}$ we have $t \mapsto w_i(t, x)$ is piecewise constant.

Let us prove first that $(\mathcal{Q}_\Delta^{\text{cons}})$ is satisfied by (6.2). If $\|\mathcal{Q}_\Delta[\rho_\Delta] - q\|_{\mathbf{L}^1(0,T)} \rightarrow 0$ and $\|\rho_\Delta - \rho\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \rightarrow 0$, then

$$\begin{aligned} & \|\mathcal{Q}[\rho] - \mathcal{Q}_\Delta[\rho_\Delta]\|_{\mathbf{L}^1(0,T)} \leq \text{Lip}(p) \int_0^T \left| \sum_{t_i \leq t} \int_{\mathbb{R}} [w_i(t,x) \rho(t_i,x) - w_i^\Delta(t,x) \rho_\Delta(t_i,x)] dx \right| dt \\ & \leq \text{Lip}(p) \int_0^T \sum_{t_i \leq t} \int_{\mathbb{R}} [|w_i(t,x) - w_i^\Delta(t,x)| \rho(t_i,x) + w_i^\Delta(t,x) |\rho(t_i,x) - \rho_\Delta(t_i,x)|] dx dt \\ & \leq \text{Lip}(p) \sum_{i=1}^M \left[\|w_i - w_i^\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \rho_{\max} + \|w_i\|_{\mathbf{L}^1(0,T;\mathbf{L}^\infty)} \|\rho - \rho_\Delta\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \right] \xrightarrow{\Delta x \rightarrow 0} 0. \end{aligned}$$

Finally, it is immediate to check the compactness property $(\mathcal{Q}_\Delta^{\text{comp}})$ because p is continuous and the sequence (ξ_Δ) takes values in a finite dimensional subset of $\mathbf{L}^1(0,T)$ due to assumption **(wLipPC)**. \square

Example 6.3. With reference to Example 4.3, let j_s be the index such that $x_{j_s+1/2}$ is the location of y . We introduce as a discrete version of the constraint operator defined in (4.2) the discrete constraint operator

$$\mathcal{Q}_\Delta[\rho_\Delta] = r(\eta_\Delta),$$

where

$$\begin{aligned} \eta_\Delta(t) &= \Delta t \sum_{m=0}^n \kappa^{n-m} \mathcal{F}_{j_s+1/2}^m && \text{for } t \in (t^n, t^{n+1}), \\ \kappa^0 &= \kappa(0), \\ \kappa^{m+1} &= \frac{1}{\Delta t} \int_{t^m}^{t^{m+1}} \kappa(s) ds. \end{aligned}$$

In order to check whether the above discrete constraint operator satisfies $(\mathcal{Q}_\Delta^{\text{cons}})$ and $(\mathcal{Q}_\Delta^{\text{comp}})$ we write η_Δ in an equivalent form. Let (ϕ_j^m) be a discretization of ϕ such that $\phi_{j_s}^m = \kappa^m$. Since ϕ is Lipschitz continuous we have that there exists a constant $C > 0$ such that

$$|\phi_j^{m+1} - \phi_j^m| \leq C \Delta t, \quad |\phi_{j+1}^m - \phi_j^m| \leq C \Delta x.$$

Observe that

$$\begin{aligned} \sum_{m=0}^n (\rho_j^{m+1} - \rho_j^m) \phi_j^{n-m} &= \rho_j^{n+1} \phi_j^0 - \rho_j^0 \phi_j^{n+1} + \sum_{m=0}^n \rho_j^m (\phi_j^{n+1-m} - \phi_j^{n-m}), \\ \sum_{j \leq j_s} (\mathcal{F}_{j+1/2}^m - \mathcal{F}_{j-1/2}^m) \phi_j^{n-m} &= \mathcal{F}_{j_s+1/2}^m \phi_{j_s}^{n-m} - \sum_{j \leq j_s} \mathcal{F}_{j-1/2}^m (\phi_j^{n-m} - \phi_{j-1}^{n-m}). \end{aligned}$$

Therefore, multiplying by ϕ_j^{n-m} the equality

$$\frac{\rho_j^{m+1} - \rho_j^m}{\Delta t} = - \frac{\mathcal{F}_{j+1/2}^m - \mathcal{F}_{j-1/2}^m}{\Delta x}$$

derived from (5.2) and adding over $j \leq j_s$ and $m \leq n$ give

$$\begin{aligned} & \frac{1}{\Delta t} \sum_{j \leq j_s} \left[\rho_j^{n+1} \phi_j^0 - \rho_j^0 \phi_j^{n+1} + \sum_{m=0}^n \rho_j^m (\phi_j^{n+1-m} - \phi_j^{n-m}) \right] \\ &= - \frac{1}{\Delta x} \sum_{m=0}^n \left[\mathcal{F}_{j_s+1/2}^m \phi_{j_s}^{n-m} - \sum_{j \leq j_s} \mathcal{F}_{j-1/2}^m (\phi_j^{n-m} - \phi_{j-1}^{n-m}) \right]. \end{aligned}$$

Thus for any $t \in (t^n, t^{n+1})$ we have that

$$\begin{aligned} \eta_\Delta(t) &= \Delta t \sum_{m=0}^n \kappa^{n-m} \mathcal{F}_{j_s+1/2}^m = \Delta t \sum_{m=0}^n \phi_{j_s}^{n-m} \mathcal{F}_{j_s+1/2}^m = \Delta x \sum_{j \leq j_s} \left[\rho_j^0 \phi_j^{n+1} - \rho_j^{n+1} \phi_j^0 \right] \\ & \quad + \Delta t \Delta x \sum_{m=0}^n \sum_{j \leq j_s} \left[-\rho_j^m \frac{\phi_j^{n+1-m} - \phi_j^{n-m}}{\Delta t} + \mathcal{F}_{j-1/2}^m \frac{\phi_j^{n-m} - \phi_{j-1}^{n-m}}{\Delta x} \right]. \end{aligned}$$

Observe that in this way we obtained a discretization $\widehat{\mathcal{Q}}_\Delta$ of the operator $\widehat{\mathcal{Q}}$ appearing in (4.3). Recall also that the definition (4.2) of \mathcal{Q} is a formal definition, while $\widehat{\mathcal{Q}}$ in (4.3) is rigorous. Therefore it is natural to prove $(\mathcal{Q}_\Delta^{\text{cons}})$ for the discretized constraint operator by comparing it to $\widehat{\mathcal{Q}}$. For simplicity, assume $j_c \neq j_s$. Let $f(\rho)(t, \cdot) = 0$ for all $t < 0$ and

$\mathcal{F}^h = 0$ for all $h < 0$. Assume that $\|\widehat{\mathcal{Q}}_\Delta[\rho_\Delta] - q\|_{\mathbf{L}^1(0,T)} \rightarrow 0$ and $\|\rho_\Delta - \rho\|_{\mathbf{L}^1(0,T;\mathbf{L}^1)} \rightarrow 0$, then

$$\begin{aligned} & \|\widehat{\mathcal{Q}}[\rho] - \mathcal{Q}_\Delta[\rho_\Delta]\|_{\mathbf{L}^1(0,T)} \leq \\ & \leq \text{Lip}(r) \sum_{n=0}^{N-1} \int_{t^n}^{t^{n+1}} \left| \xi^a(t) - \Delta t \Delta x \sum_{m=0}^n \sum_{j \leq j_s} \left[-\rho_j^m \frac{\phi_j^{n+1-m} - \phi_j^{n-m}}{\Delta t} + \mathcal{F}_{j-1/2}^m \frac{\phi_j^{n-m} - \phi_{j-1}^{n-m}}{\Delta x} \right] \right| dt \\ & + \text{Lip}(r) \sum_{n=0}^{N-1} \int_{t^n}^{t^{n+1}} \left| \xi^b(t) + \Delta x \sum_{j \leq j_s} \rho_j^{n+1} \phi_j^0 \right| + \text{Lip}(r) \sum_{n=0}^{N-1} \int_{t^n}^{t^{n+1}} \left| \xi^c(t) - \Delta x \sum_{j \leq j_s} \rho_j^0 \phi_j^{n+1} \right| dt \xrightarrow{\Delta x \rightarrow 0} 0. \end{aligned}$$

Indeed we have that

$$\begin{aligned} \text{(A)} \quad & \left| \xi^a(t) - \Delta t \Delta x \sum_{m=0}^n \sum_{j \leq j_s} \left[-\rho_j^m \frac{\phi_j^{n+1-m} - \phi_j^{n-m}}{\Delta t} + \mathcal{F}_{j-1/2}^m \frac{\phi_j^{n-m} - \phi_{j-1}^{n-m}}{\Delta x} \right] \right| \\ & \leq \sum_{m=0}^n \sum_{j \leq j_s} \int_{t^m}^{t^{m+1}} \int_{K_j} \left| -\rho(s,x) \phi_t(t-s,x) + \rho_j^m \frac{\phi_j^{n+1-m} - \phi_j^{n-m}}{\Delta t} \right| dx ds \\ & + \sum_{m=0}^n \sum_{j \leq j_s} \int_{t^m}^{t^{m+1}} \int_{K_j} \left| f(\rho)(s,x) \phi_x(t-s,x) - \mathcal{F}_{j-1/2}^m \frac{\phi_j^{n-m} - \phi_{j-1}^{n-m}}{\Delta x} \right| dx ds \\ & \leq \sum_{m=0}^n \sum_{j \leq j_s} \int_{t^m}^{t^{m+1}} \int_{K_j} \left[\left| \rho_j^m - \rho(s,x) \right| \text{Lip}(\phi) + \rho_{\max} \left| \frac{\phi_j^{n+1-m} - \phi_j^{n-m}}{\Delta t} - \phi_t(t-s,x) \right| \right] dx ds \\ & + \sum_{m=0}^n \sum_{j \leq j_s} \int_{t^m}^{t^{m+1}} \int_{K_j} \text{Lip}(F) \left(\left| \rho(s,x) - \rho_{j-1}^m \right| + \left| \rho(s,x) - \rho_j^m \right| \right) \text{Lip}(\phi) dx ds \\ & + \sum_{m=0}^n \sum_{j \leq j_s} \int_{t^m}^{t^{m+1}} \int_{K_j} f_{\max} \left| \phi_x(t-s,x) - \frac{\phi_j^{n-m} - \phi_{j-1}^{n-m}}{\Delta x} \right| dx ds \xrightarrow{\Delta x \rightarrow 0} 0, \end{aligned}$$

$$\begin{aligned} \text{(B)} \quad & \left| \xi^b(t) + \Delta x \sum_{j \leq j_s} \rho_j^{n+1} \phi_j^0 \right| \leq \sum_{j \leq j_s} \int_{K_j} \left| -\rho(t,x) \phi(0,x) + \rho_j^{n+1} \phi_j^0 \right| dx \\ & \leq \sum_{j \leq j_s} \int_{K_j} \left[\left| \rho(t,x) - \rho_j^{n+1} \right| \|\phi\|_{\mathbf{L}^\infty(\mathbb{R}_+ \times \mathbb{R})} + \rho_{\max} \left| \phi(0,x) - \phi_j^0 \right| \right] dx \xrightarrow{\Delta x \rightarrow 0} 0, \end{aligned}$$

and

$$\begin{aligned} \text{(C)} \quad & \left| \xi^c(t) - \Delta x \sum_{j \leq j_s} \rho_j^0 \phi_j^{n+1} \right| \leq \sum_{j \leq j_s} \int_{K_j} \left| \rho_0(x) \phi(t,x) - \rho_j^0 \phi_j^{n+1} \right| dx \\ & \leq \sum_{j \leq j_s} \int_{K_j} \left[\left| \rho_0(x) - \rho_j^0 \right| \|\phi\|_{\mathbf{L}^\infty(\mathbb{R}_+ \times \mathbb{R})} + \rho_{\max} \left| \phi(t,x) - \phi_j^{n+1} \right| \right] dx \xrightarrow{\Delta x \rightarrow 0} 0. \end{aligned}$$

Finally, let us prove also $(\mathcal{Q}_\Delta^{\text{comp}})$, i.e., that $(\mathcal{Q}_\Delta[\rho_\Delta])$ is compact in $\mathbf{L}^1(0,T)$.

We have that $(\mathcal{Q}_\Delta[\rho_\Delta])$ is uniformly bounded in \mathbf{BV} because

$$\begin{aligned} & \sum_{n=1}^{N-1} |\mathcal{Q}_\Delta[\rho_\Delta](t^{n+1}) - \mathcal{Q}_\Delta[\rho_\Delta](t^n)| \leq \text{Lip}(r) \sum_{n=1}^{N-1} |\eta_\Delta(t^{n+1}) - \eta_\Delta(t^n)| \\ & = \text{Lip}(r) \Delta t \sum_{n=1}^{N-1} \left| \sum_{m=0}^n \kappa^{n-m} \mathcal{F}_{j_s+1/2}^m - \sum_{m=0}^{n-1} \kappa^{n-1-m} \mathcal{F}_{j_s+1/2}^m \right| \\ & = \text{Lip}(r) \Delta t \sum_{n=1}^{N-1} \left| \kappa^0 \mathcal{F}_{j_s+1/2}^n + \sum_{m=0}^{n-1} [\kappa^{n-m} - \kappa^{n-1-m}] \mathcal{F}_{j_s+1/2}^m \right| \\ & \leq \text{Lip}(r) \Delta t \sum_{n=1}^{N-1} \left[\kappa^0 \mathcal{F}_{j_s+1/2}^n + \text{Lip}(\kappa) \Delta t \sum_{m=0}^{n-1} \mathcal{F}_{j_s+1/2}^m \right] \\ & \leq 2 [\kappa(0) + \text{Lip}(\kappa)T] \text{Lip}(r) \text{Lip}(F) T \rho_{\max}. \end{aligned}$$

Therefore $(\mathcal{Q}_\Delta[\rho_\Delta])$ is compact in $\mathbf{L}^1(0,T)$. \square

Example 6.4. In this example we propose a discrete version of the constraint operator given in Example 4.4. Let us first rewrite the Cauchy problem (4.5) in its integral form

$$\xi(t) = \xi_0[\rho_0] + \int_0^t H \left(\xi(s), \int_{\mathbb{R}} F(s,x,\rho(s,x)) dx \right) ds.$$

Its natural discretization is then the forward Euler discretization

$$\begin{aligned}\xi^0 &= \xi_0[\rho_0], \\ \xi^{n+1} &= \xi^n + \Delta t H \left(\xi^n, \Delta x \sum_{j \in \mathbb{Z}} F \left(t^n, x_j, \rho_j^n \right) \right), \quad n \in \mathbb{N}.\end{aligned}$$

Assume that the sequence of approximate solutions (ρ_Δ) obtained with the above algorithm is bounded in $\mathbf{L}^\infty(0, T; \mathbf{L}^1)$, then $(\xi^{n+1} - \xi^n)/\Delta t$ is uniformly bounded by the assumptions we made on H . Therefore (ξ_Δ) is bounded uniformly in \mathbf{BV} and we have $(\mathcal{Q}_\Delta^{\text{comp}})$. \square

7. NUMERICAL APPLICATIONS

In this section, we first validate the numerical scheme introduced in Section 5 with an explicit solution. Then we present numerical simulations related to the constraint operators introduced in examples 1.1–1.3. In particular, the simulations show that some drawbacks of (1.5) have been removed.

7.1. Validation of the numerical scheme. We propose here to validate the numerical scheme (5.2), (5.3), (5.4) by showing its numerical convergence toward the exact solution to (1.1), (1.3), (1.4) presented in Figure 1 and obtained by an explicit analysis of the wave-front interactions, with computer-assisted computation of interaction times and front slopes. The set up for the simulation is as follows. Consider the domain of computation $[-6, 0]$, take a normalized flux $f(\rho) = \rho(1 - \rho)$ (namely the maximal velocity and the maximal density are assumed to be equal to one) and the weight functions $w(x) = 2(1 + x) \mathbf{1}_{[-1, 0]}(x)$ and $\kappa(t) = 2(1 - t) \mathbf{1}_{[0, 1]}(t)$. Assume a uniform distribution of maximal density in $[x_1, x_2]$ at time $t = 0$, namely $\rho_0(x) = \mathbf{1}_{[x_1, x_2]}(x)$. The efficiency of the exit, p is of the form

$$(7.1) \quad p(\xi) = \begin{cases} p_0 & \text{if } 0 \leq \xi < \xi_1, \\ p_1 & \text{if } \xi_1 \leq \xi < \xi_2, \\ p_2 & \text{if } \xi_2 \leq \xi \leq 1. \end{cases}$$

The explicit solution ρ corresponding to the values

$$\begin{aligned}x_1 &= -6, & x_2 &= -1.2, & p_0 &= 0.16, & p_1 &= 66/625 = 0.1056, & p_2 &= 24/625 = 0.0384, \\ \xi_1 &= \frac{1087}{300} - \frac{1152}{625} \sqrt{2} (3\sqrt{3} - 4) + \frac{2}{125} \log \left[\frac{2}{\sqrt{3}} \right] \sim 0.508, & \xi_2 &\sim 0.6911,\end{aligned}$$

is represented in Figure 1.

Moreover, the time values in Figure 1 are

$$\begin{aligned}t_A &= 4.8, & t_B &= 1.2, & t_C &= 2, & t_D &= 4, & t_E &\sim 4.417, & t_F &= 5, & t_G &\sim 5.878, & t_H &\sim 12.554, & t_I &\sim 105.063, \\ t_L &\sim 105.553, & t_M &\sim 105.647, & t_N &\sim 106.759, & t_O &\sim 107.111, & t_P &\sim 107.185, & t_Q &\sim 108.464.\end{aligned}$$

The approximate solution is numerically computed using the Godounov numerical flux (see e.g. [31, 38]), which will be used in the remaining of this paper:

$$F(a, b) = \begin{cases} \min_{[a, b]} f & \text{if } a \leq b, \\ \max_{[b, a]} f & \text{if } a > b. \end{cases}$$






FIGURE 2. With reference to Subsection 7.1: The numerically computed solution $x \mapsto \rho_{\Delta}(t, x)$ at different fixed times t .

In Figure 2 we present the numerically computed solution $x \mapsto \rho_\Delta(t, x)$ at different fixed times t on the domain $[-6, 1]$. The parameters of discretization are $\Delta x = 10^{-3}$ and $\Delta t = 4 \times 10^{-4}$. Let us now introduce the relative \mathbf{L}^1 -error for the density ρ , at a given time t^n , defined by

$$E_{\mathbf{L}^1}^n = \left[\sum_j \left| \rho(t^n, x_j) - \rho_j^n \right| \right] / \left[\sum_j \left| \rho(t^n, x_j) \right| \right].$$

In Table 1, we computed the relative \mathbf{L}^1 -errors for different numbers of space cells at the fixed time $t = 10$ and for a fixed time step $\Delta t = 10^{-4}$. As in [6, 3], we observe that the application of the constrained numerical flux (5.3) does not affect the accuracy of the scheme.




FIGURE 3. The function $t \mapsto \xi_{\Delta}(t)$

In Figure 3 is presented the evolution in time of the function ξ_Δ , the approximation of

$$(7.2) \quad \xi(t) = \int_{\mathbb{R}_-} \int_0^t w(x) \kappa(t-s) \rho(s, x) ds dx,$$

that reports the level of “panic” in the constraint operator \mathcal{Q} defined in (1.4). The main feature that can be emphasized is that the level of panic increases and disappears quickly. We shall see in Example 7.3, results when ξ_Δ is an approximation of ξ defined by (1.8) or (1.9) that are extensions of (7.2) and that prevent the level of panic from disappearing too fast.

Finally, we report in Table 2, the L^1 -errors at $t = 10$ between the exact solution and the approximate solution computed with the constraint operator $\hat{\mathcal{Q}}$ defined in (1.4) for different numbers of space cells and for a fixed time step $\Delta t = 10^{-4}$. Observe that \mathcal{Q} and $\hat{\mathcal{Q}}$ defined in (1.4) are equivalent in the sense of Definition 2.2. As expected, comparing Table 1 and Table 2, one can easily check that the errors are essentially similar and thus the solutions computed with \mathcal{Q} and $\hat{\mathcal{Q}}$ are essentially the same.

7.2. Numerical simulations. In what follows, the exit is always located at $x = 0$, we always consider the normalized flux $f(\rho) = \rho(1 - \rho)$, the space weight $w(x) = 2(1 + x) \mathbf{1}_{[-1, 0]}(x)$ and the time weight $\kappa(t) = 2(1 - t) \mathbf{1}_{[0, 1]}(t)$. If not precised, the simulations are performed with the discretization parameters $\Delta x = 10^{-3}$ and $\Delta t = 4 \times 10^{-4}$.

Example 7.1. (With reference to Example 1.1) In this part, the set up for the simulations is the same as for the validation done in Subsection 7.1. We focus on the constraint operators $\tilde{\mathcal{Q}}$ and $\overline{\mathcal{Q}}$ that can be interpreted as discretized versions of \mathcal{Q} . We take as final time $T = 10$. For each of these constraint operators, we perform two types of simulations. A first type of simulations is carried out by taking a small number of discretized times and positions. We thus take the times $t_i = i$, for $i = 0, \dots, 10$ and positions $y_0 = -0.8$, $y_1 = -0.5$, $y_2 = -0.2$ and $y_3 = 0$. We present in Figure 4 (a) and Figure 5 (a) the obtained results. For the second type of simulations, we take all the times and positions of the discretization, namely, $t_i = i\Delta t$, for $i = 0, \dots, 25000$ and $y_i = -6 + i\Delta x$, $i = 1, \dots, 6000$. The results are depicted in Figure 4 (b) and Figure 5 (b), where we notice a good agreement with the solution presented in Figure 2(f). One can notice that, as expected, the constraint operator that corresponds to the case where data are collected by video camera is the more efficient since the two other may underestimate the importance of the congestion before the exit. \square



Example 7.2. (With reference to Example 1.2) Here the domain of computation is $[-6, 1]$ and the efficiency of the exit is the continuous function defined by

$$(7.3) \quad p(\xi) = \begin{cases} p_0 & \text{if } 0 \leq \xi < \xi_1, \\ \frac{(p_0 - p_1)\xi + p_1\xi_1 - p_0\xi_2}{\xi_1 - \xi_2} & \text{if } \xi_1 \leq \xi < \xi_2, \\ p_1 & \text{if } \xi_2 \leq \xi \leq 1, \end{cases}$$


with the values

$$p_0 = 0.21, \quad p_1 = 0.07, \quad \xi_1 = 0.35, \quad \xi_2 = 0.731.$$

We consider the initial density $\rho_0(x) = \mathbf{1}_{[-1, -0.1]}(x)$. Figure 6 shows the evolution of the fluxes at the exit computed with the constraint operators (1.5) and (1.6), where $\alpha = 2$ is the maximum possible value. We can see that the value of

the flux computed with (1.5) is immediately at the lowest level of the efficiency of the exit, whereas the one computed with (1.6) grows quickly to the highest level of the efficiency of the exit.

Now, in order to clearly see the self-organization, we consider the domain of computation $[-4, 1]$, the initial density $\rho_0(x) = \mathbf{1}_{[-4, -2]}(x)$ and the efficiency of the exit is still defined by (7.3), where

$$p_0 = 0.2, \quad p_1 = 0.1, \quad \xi_1 = 0.32, \quad \xi_2 = 0.35.$$




FIGURE 7. The flux at the exit corresponding to the constraint operator (1.6) showing the self-organization.

Figure 7 shows the evolution in time of the flux at the exit. We can notice that this flux first increases until it reaches the maximum level of the efficiency of the exit. Then it falls down until the lowest value of this efficiency. After a very short period it increases without reaching the maximum level of the efficiency. This is the effect of self-organization. Finally, after some time, the flux keeps a certain value until the low density observed upstream the exit allows the efficiency to recover its max value. This is in a qualitative agreement with the empirical results by Cepolina [15].

Example 7.3. (With reference to Example 1.3) In this part, we recall the set up introduced in [4]. The domain of computation is $[-6,1]$, the efficiency of the exit is defined by (7.1) with the values

$$p_0 = 0.21, \quad p_1 = 0.168, \quad p_2 = 0.021, \quad \xi_1 = 0.566, \quad \xi_2 = 0.731.$$




FIGURE 8. The functions ξ_Δ^1 , ξ_Δ^2 , ξ_Δ^3 for (1.5), (1.8) and (1.9), respectively.

The initial density is $\rho_0(x) = \mathbf{1}_{[-5.75, -2]}(x)$. Figure 8 shows the evolution in time of ξ_Δ^1 , ξ_Δ^2 and ξ_Δ^3 computed using (1.5), (1.8) and (1.9) respectively for $\delta = 8 \times 10^{-3}$. The graphs show that the level of panic taking into account in ξ_Δ^2 or ξ_Δ^3 disappears very slowly comparing to the one of ξ_Δ^1 .

8. CONCLUSIONS

In this paper, one-dimensional scalar conservation laws with nonlocal point constraints on the flux are considered. General and “easy to check” assumptions on the constraint operator are given in order to establish well-posedness of the problem using fixed point arguments. Examples of constraint operators that satisfy these assumptions are given ; they are extensions and improvements of the one considered in [4], in the sense that they remove some drawbacks that may appear in the models based upon the latter one. A numerical scheme based on finite volume methods is developed and validated with an explicit solution. Examples of discrete constraint operators, related to the examples given in the continuous case, are given. The numerical results show that these constraints are able to reproduce features in vehicular traffic and crowd dynamics such as the self-organization. The results presented in this paper allow to consider management problems as in [18, 21].
