# Markov-modulated Ornstein-Uhlenbeck processes

#### Abstract

In this paper we consider an Ornstein-Uhlenbeck (ou) process $(M(t))_{t \geqslant 0}$ whose parameters are determined by an external Markov process $(X(t))_{t \geqslant 0}$ on a finite state space $\{1, \ldots, d\}$; this process is usually referred to as Markov-modulated Ornstein-Uhlenbeck (or: mмоu). We use stochastic integration theory to determine explicit expressions for the mean and variance of $M(t)$. Then we establish a system of partial differential equations (PDE s) for the Laplace transform of $M(t)$ and the state $X(t)$ of the background process, jointly for time epochs $t=t_{1}, \ldots, t_{K}$. Then we use this PDE to set up a recursion that yields all moments of $M(t)$ and its stationary counterpart; we also find an expression for the covariance between $M(t)$ and $M(t+u)$. We then establish a central limit theorem for $M(t)$ for the situation that certain parameters of the underlying ou processes are scaled, in combination with the modulating Markov process being accelerated; interestingly, specific scalings lead to drastically different limiting processes. We conclude the paper by considering the situation of a single Markov process modulating multiple ou processes.

## 1 Introduction

The Ornstein-Uhlenbeck (ou) process is a stationary Markov-Gauss process, with the additional feature that is eventually reverts to its long-term mean; see the seminal paper [33], as well as [22] for a historic account. Having originated from physics, by now the process has found widespread use in a broad range of other application domains: finance, population dynamics, climate modeling, etc. In addition, it plays an important role in queueing theory, as it can be seen as the limiting process of specific classes of infinite-server queues under a certain scaling [30]. The ou process is characterized by three parameters (which we call $\alpha, \gamma$, and $\sigma^{2}$ throughout this paper), which relate to the process' mean, convergence speed towards the mean, and variance, respectively.
The probabilistic properties of the ou process have been thoroughly studied. One of the key results is that its value at a given time $t$ has a Normal distribution, with a mean and variance that can be expressed explicitly in terms of the parameters $\alpha, \gamma$, and $\sigma^{2}$ of the underlying ou process; see for instance [22, Eqn. (2)]. In addition, various other quantities have been analyzed, such as the distribution of first passage times or the maximum value attained in an interval of given length; see e.g. [1] and references therein. The concept of regime switching (or: Markov modulation, as it is usually referred to in the operations research literature) has become increasingly important over the past decades. In regime switching, the parameters of the underlying stochastic process are determined by an external background process (or: modulating process), that is typically assumed to evolve independently of the stochastic process under consideration. Often the background process is assumed to be a Markov chain defined on a finite state space, say $\{1, \ldots, d\}$; in the context of Markov-modulated ou (mмои) this means that when this Markov chain is in state $i$, the process locally behaves as a ou process with parameters $\alpha_{i}, \gamma_{i}$, and $\sigma_{i}^{2}$.

Owing to its various attractive features, regime switching has become an increasingly popular concept. In a broad spectrum of application domains it offers a natural framework for modeling situations in which the stochastic process under study reacts to an autonomously evolving environment. In finance, for instance, one could identify the background process with the 'state of the economy', for instance as a two-state process (that is, alternating between a 'good' and a 'bad' state), to which e.g. asset prices react. Likewise, in wireless networks the concept can be used to model the channel conditions that vary in time, and to which users react.
In the operations research literature there is a sizable body of work on Markov-modulated queues, see e.g. the textbooks [4, Ch. XI] and [27], while Markov modulation has been intensively used in insurance and risk theory as well [5]. In the financial economics literature, the use of regime switching dates back to at least the late 1980s [20]; various specific models have been considered since then, see for instance [3, 15, 16].

In this paper we present a set of new results in the context of the analysis of mmou. Here and in the sequel we let $M(t)$ denote the position of the mmou process at time $t$, whereas $M$ denotes its stationary counterpart. In the first place we derive explicit formulas for the mean and variance of $M(t)$ and $M$, jointly with the state of the background process, relying on standard machinery from stochastic integration theory. In specific special cases the resulting formulas simplify drastically (for instance when it is assumed that the background process starts off in equilibrium at time 0 , or when the parameters $\gamma_{i}$ are assumed uniform across the states $i \in\{1, \ldots, d\}$ ).

The second contribution concerns the derivation of a system of partial differential equations for the Laplace transform of $M(t)$; when equating the partial derivative with respect to time to 0 , we obtain a system of ordinary differential equations for the Laplace transform of $M$. This result is directly related to [35, Thm. 3.2], with the differences being that there the focus is on just stationary behavior, and that the system considered there has the additional feature of reflection at a lower boundary (to avoid the process attaining negative values). We set up a recursive procedure that generates all moments of $M(t)$; in each iteration a non-homogeneous system of differential equations needs to be solved. This procedure complements the recursion for the moments of the steady-state quantity $M$, as presented in [35, Corollary 3.1] (in which each recursion step amounts to solving a system of linear equations). In addition, we also set up a system of partial differential equations for the Laplace transform associated with the joint distribution of $M\left(t_{1}\right), \ldots, M\left(t_{K}\right)$, and determine the covariance $\mathbb{C o v}(M(t, t+u))$. A third contribution concerns the behavior of the MMOU process under certain parameter scalings.
$\triangleright$ A first scaling that we consider concerns speeding up the jumps of the background process by a factor $N$. Using the system of partial differential equations that we derived earlier, it is shown that the limiting process, obtained by sending $N \rightarrow \infty$, is an ordinary (that is, non-modulated) ou process, with parameters that are time averages of the individual $\alpha_{i}, \gamma_{i}$, and $\sigma_{i}^{2}$.
$\triangleright$ A second regime that we consider scales the transition rates of the Markovian background process by $N$, while the $\alpha_{i}$ and $\sigma_{i}^{2}$ are inflated by a factor $N^{h}$ for some $h>0$; the resulting process we call $M^{[N, h]}(t)$. We then center (subtract the mean, which is roughly proportional to $N^{h}$ ) and normalize $M^{[N, h]}(t)$, with the goal to establish a central limit theorem (CLT). Interestingly, it depends on the value of $h$ what the appropriate normalization is. If $h<1$ the variance of $M^{[N, h]}(t)$ is roughly proportional to the 'scale' at which the modulated ou process operates, viz. $N^{h}$, and as a consequence the normalization looks like $N^{h / 2}$; at an intuitive level, the timescale of the background process is so fast, that the process essentially looks like an ou process with time-averaged parameters. If, on the contrary, $h>1$, then the variance of $M^{[N, h]}(t)$ grows like $N^{2 h-1}$, which is faster than $N^{h}$; as a consequence, the proper normalization looks like $N^{h-1 / 2}$; in this case the variance that appears in the clt is directly related to the deviation matrix [13] associated with the background process. Importantly, we do not just prove Normality for a given value of $t>0$, but rather weak convergence (at the process level, that is) to the solution of a specific limiting stochastic differential equation.

The last contribution focuses on the situation that a single Markovian background process modulates multiple ou processes. This, for instance, models the situation in which different asset prices react to the same 'external circumstances' (i.e., state of the economy), or the situation in which different users of a wireless network react to the same channel conditions. The probabilistic behavior of the system is captured through a system of partial differential equations. It is also pointed out how the corresponding moments can be found.

Importantly, there is a strong similarity between the results presented in the framework of the present paper, and corresponding results for Markov-modulated infinite-server queues. In these systems the background process modulates an $M / M / \infty$ queue, meaning that we consider an $M / M / \infty$ queue of which the arrival rate and service rate are determined by the state of the background process [14, 17]. For these
systems, the counterparts of our ммоu results have been established: the mean and variance have been computed in e.g. [9, 28], (partial) differential equations for the Laplace transform of $M(t)$, as well as recursions for higher moments can be found in [7, 9, 28], whereas parameter scaling results are given in $[7,9]$ and, for a slightly different model [12]. Roughly speaking, any property that can be handled explicitly for the Markov-modulated infinite-server queue can be explicitly addressed for mмои as well, and vice versa.

This paper is organized as follows. Section 2 defines the model, and presents preliminary results. Then Section 3 deals with the system's transient behavior, in terms of a recursive scheme that yields all moments of $M(t)$, with explicit expressions for the mean and variance. Section 4 presents a system of partial differential equations for the Laplace transform of $M(t)$ (which becomes a system of ordinary differential equations in steady state). In Section 5 , the parameter scalings mentioned above are applied (resulting in a process $M^{(N)}(t)$ ), leading to a cLT for an appropriately centered and normalized version of $M^{(N)}(t)$. The last section considers the setting of a single background process modulating multiple ou processes.

## 2 Model and preliminaries

We start by giving a detailed model description of the Markov-modulated Ornstein-Uhlenbeck (ммоч) process. We are given a probability space $(\Omega, \mathcal{F}, \mathbb{P})$ on which a random variable $M_{0}$, a standard Brownian motion $(B(t))_{t \geqslant 0}$ and a continuous-time Markov process $(X(t))_{t \geqslant 0}$ with finite state space are defined. It is assumed that $M_{0}, X$ and $B$ are independent. The process $X$ is the so-called background process; its state space is denoted by $\{1, \ldots, d\}$.
The idea behind ммои is that the background process $X(\cdot)$ modulates an Ornstein-Uhlenbeck process. Intuitively, this means that while $X(\cdot)$ is in state $i \in\{1, \ldots, d\}$, the mмои process $(M(t))_{t \geqslant 0}$ behaves as an Ornstein-Uhlenbeck process $U_{i}(\cdot)$ with parameters $\alpha_{i}, \gamma_{i}$ and $\sigma_{i}$, which evolves independently of the background process $X(\cdot)$. In mathematical terms, this means that $M(\cdot)$ should obey the stochastic differential equation

\begin{equation*}
\mathrm{d} M(t)=\left(\alpha_{X(t)}-\gamma_{X(t)} M(t)\right) \mathrm{d} t+\sigma_{X(t)} \mathrm{d} B(t) \tag{1}
\end{equation*}
$$

To be more precise, we will call a stochastic process $(M(t))_{t \geqslant 0}$ an mмоu process with initial condition $M(0)=M_{0}$ if

$$
\begin{equation*}
M(t)=M_{0}+\int_{0}^{t}\left(\alpha_{X(s)}-\gamma_{X(s)} M(s)\right) \mathrm{d} s+\int_{0}^{t} \sigma_{X(s)} \mathrm{d} B(s) . \tag{2}
\end{equation*}
$$

The following theorem provides basic facts about the existence, uniqueness and distribution of an ммои process. For proofs and additional details, see Section A. As mentioned in the introduction, specific aspects of ммои have been studied earlier in the literature; see for instance [35].
Theorem 2.1. Define $\Gamma(t):=\int_{0}^{t} \gamma_{X(s)} \mathrm{d} s$. Then the stochastic process $(M(t))_{t \geqslant 0}$ given by

M(t)=M_{0} e^{-\Gamma(t)}+\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \alpha_{X(s)} \mathrm{d} s+\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \sigma_{X(s)} \mathrm{d} B(s)
$$

is the unique mmou process with initial condition $M_{0}$.
Conditional on the process $X$, the random variable $M(t)$ has a Normal distribution with random mean

$$
\begin{equation*}
\mu(t)=M_{0} \exp (-\Gamma(t))+\int_{0}^{t} \exp (-(\Gamma(t)-\Gamma(s))) \alpha_{X(s)} \mathrm{d} s \tag{3}
\end{equation*}
$$

and random variance

$$
\begin{equation*}
v(t)=\int_{0}^{t} \exp (-2(\Gamma(t)-\Gamma(s))) \sigma_{X(s)}^{2} \mathrm{~d} s \tag{4}
\end{equation*}
$$

This result is analogous with the corresponding result for the Markov-modulated infinite-server queue in $[9,14]$ : there it is shown that the number of jobs in the system has a Poisson distribution with random parameter.

For later use, we now recall some concepts pertaining to the theory of deviation matrices of Markov processes. For an introduction to this topic we refer to standard texts such as [24, 25, 32]. For a compact survey, see [13].
Let the transition rates corresponding to the continuous-time Markov chain $(X(t))_{t \geqslant 0}$ be given by $q_{i j} \geqslant 0$ for $i \neq j$ and $q_{i}:=-q_{i i}:=\sum_{j \neq i} q_{i j}$. These transition rates define the intensity matrix or generator $Q$. The (unique) invariant distribution corresponding to $Q$ is denoted by (the column vector) $\boldsymbol{\pi}$, i.e., it obeys $\boldsymbol{\pi} Q=\mathbf{0}$ and $\mathbf{1}^{\mathrm{T}} \boldsymbol{\pi}=1$, where $\mathbf{1}$ is a $d$-dimensional all-ones vector.
Let $\Pi:=1 \boldsymbol{\pi}^{\mathrm{T}}$ denote the ergodic matrix. Then the fundamental matrix is given by $F:=(\Pi-Q)^{-1}$, whereas the deviation matrix is defined by $D:=F-\Pi$. Standard identities are $Q F=F Q=\Pi-I$, as well as $\Pi D=D \Pi=0$ (here 0 is to be read as an all-zeros $d \times d$ matrix) and $F \mathbf{1}=\mathbf{1}$. The $(i, j)$-th entry of the deviation matrix, with $i, j \in\{1, \ldots, d\}$, can be alternatively computed as

D_{i j}:=\int_{0}^{\infty}\left(\mathbb{P}(X(t)=j \mid X(0)=i)-\pi_{j}\right) \mathrm{d} t
$$

which in matrix form reads

$$
\begin{equation*}
D=\int_{0}^{\infty}\left(\exp (Q t)-\mathbf{1} \boldsymbol{\pi}^{\mathrm{T}}\right) \mathrm{d} t \tag{5}
\end{equation*}
$$

## 3 Transient behavior: moments

In this section we analyze the moments of $M(t)$. First considering the mean and variance in the general situation, we then concentrate on more specific cases in which the expressions simplify greatly. In particular, we address the situation that all the $\gamma_{i}$ s are equal, the situation that the background process starts off in equilibrium at time 0 , and the steady-state regime. The computations are immediate applications of stochastic integration theory. The section is completed by deriving an expression for the covariance between $M(t)$ and $M(t+u)$ (for $t, u \geqslant 0$ ), and a procedure that uses Itô's formula to recursively determine all moments.

### 3.1 Mean and variance: general case

Let $\boldsymbol{Z}(t) \in\{0,1\}^{d}$ be the vector of indicator functions associated with the Markov chain $(X(t))_{t \geqslant 0}$, that is, we let $Z_{i}(t)=1$ if $X(t)=i$ and 0 else. Let $\boldsymbol{p}_{t}$ denote the vector of transient probabilities
of the background process, i.e., $(\mathbb{P}(X(t)=1), \ldots, \mathbb{P}(X(t)=d))^{\mathrm{T}}$ (where we have not specified the distribution of the initial state $X(0)$ yet).
We subsequently find expressions for the mean $\mu_{t}:=\mathbb{E} M(t)$ and variance $v_{t}:=\operatorname{Var} M(t)$.
$\triangleright$ The mean can be computed as follows. To this end, we consider the mean of $M(t)$ jointly with the state of the background process at time $t$. To this end, we define $\boldsymbol{Y}(t):=\boldsymbol{Z}(t) M(t)$, and $\boldsymbol{\nu}_{t}:=\mathbb{E} \boldsymbol{Y}(t)$. It is clear that

$$
\begin{equation*}
\mathrm{d} \boldsymbol{Z}(t)=Q^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} t+\mathrm{d} \boldsymbol{K}(t), \tag{6}
\end{equation*}
$$

for a $d$-dimensional martingale $\boldsymbol{K}(t)$. With Itô's rule we get, with $\bar{Q}_{\gamma}:=Q^{\mathrm{T}}-\operatorname{diag}\{\gamma\}$,

$$
\begin{align*}
\mathrm{d} \boldsymbol{Y}(t) & =M(t)\left(Q^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} t+\mathrm{d} \boldsymbol{K}(t)\right)+\boldsymbol{Z}(t)\left(\left(\boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{Z}(t)-\boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{Y}(t)\right) \mathrm{d} t+\boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t)\right) \\
& =\left(\bar{Q}_{\gamma} \boldsymbol{Y}(t)+\operatorname{diag}(\alpha) \boldsymbol{Z}(t)\right) \mathrm{d} t+\operatorname{diag}\{\boldsymbol{\sigma}\} \boldsymbol{Z}(t) \mathrm{d} B(t)+M(t) \mathrm{d} \boldsymbol{K}(t) . \tag{7}
\end{align*}
$$

Taking expectations of both sides, we obtain the system

$$
\boldsymbol{\nu}_{t}^{\prime}=\bar{Q}_{\gamma} \boldsymbol{\nu}_{t}+\operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{p}_{t} .
$$

This is a non-homogeneous linear system of differential equations, that is solved by

$$
\boldsymbol{\nu}_{t}=e^{\bar{Q}_{\gamma} t} \boldsymbol{\nu}_{0}+\int_{0}^{t} e^{\bar{Q}_{\gamma}(t-s)} \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{p}_{s} \mathrm{~d} s
$$

then $\mu_{t}=\mathbf{1}^{\mathrm{T}} \boldsymbol{\nu}_{t}$. Realize that $\boldsymbol{\nu}_{0}=m_{0} \boldsymbol{p}_{0}$, as we assumed that $M(0)$ equals $m_{0}$.
The equations simplify drastically if the background process starts off in equilibrium at time 0 ; then evidently $\boldsymbol{p}_{t}=\boldsymbol{\pi}$ for all $t \geq 0$. As a result, we find $\boldsymbol{\nu}_{t}=e^{\bar{Q}_{\gamma} t} \boldsymbol{\nu}_{0}-\bar{Q}_{\gamma}^{-1}\left(I-e^{\bar{Q}_{\gamma} t}\right) \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\pi}$. We now consider the steady-state regime (i.e., $t \rightarrow \infty$ ). From the above expressions, it immediately follows that $\boldsymbol{\nu}_{\infty}=-\bar{Q}_{\gamma}^{-1} \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\pi}$, and $\mu_{\infty}=\mathbf{1}^{\mathrm{T}} \boldsymbol{\nu}_{\infty}=-\mathbf{1}^{\mathrm{T}} \bar{Q}_{\gamma}^{-1} \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\pi}$. We further note that $\gamma=-(Q-\operatorname{diag}\{\boldsymbol{\gamma}\}) \mathbf{1}$, and hence $\boldsymbol{\gamma}^{\mathrm{T}} \bar{Q}_{\gamma}^{-1}=-\mathbf{1}^{\mathrm{T}}$, so that $\boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{\nu}_{\infty}=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}$.
$\triangleright$ The variance can be found in a similar way. Define $\overline{\boldsymbol{Y}}(t):=\boldsymbol{Z}(t) M^{2}(t)$, and $\boldsymbol{w}_{t}:=\mathbb{E} \overline{\boldsymbol{Y}}(t)$. Now our starting point is the relation

$$
\mathrm{d}\left(M(t)-\mu_{t}\right)=\left(\boldsymbol{\alpha}^{\mathrm{T}}\left(\boldsymbol{Z}(t)-\boldsymbol{p}_{t}\right)-\boldsymbol{\gamma}^{\mathrm{T}}\left(\boldsymbol{Y}(t)-\boldsymbol{\nu}_{t}\right)\right) \mathrm{d} t+\boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t)
$$

so that

$$
\begin{aligned}
\mathrm{d}\left(M(t)-\mu_{t}\right)^{2}= & 2\left(M(t)-\mu_{t}\right)\left(\boldsymbol{\alpha}^{\mathrm{T}}\left(\boldsymbol{Z}(t)-\boldsymbol{p}_{t}\right)-\boldsymbol{\gamma}^{\mathrm{T}}\left(\boldsymbol{Y}(t)-\boldsymbol{\nu}_{t}\right)\right) \mathrm{d} t \\
& +2\left(M(t)-\mu_{t}\right) \boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t)+\boldsymbol{\sigma}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{Z}(t)\} \boldsymbol{\sigma} \mathrm{d} t .
\end{aligned}
$$

Taking expectations of both sides,

$$
v_{t}^{\prime}=2 \boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{\nu}_{t}-2 \mu_{t} \boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{p}_{t}-2 \boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{w}_{t}+2 \mu_{t} \boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{\nu}_{t}+\boldsymbol{\sigma}^{\mathrm{T}} \operatorname{diag}\left\{\boldsymbol{p}_{t}\right\} \boldsymbol{\sigma} .
$$

Clearly, to evaluate this expression, we first need to identify $\boldsymbol{w}_{t}$. To this end, we set up and equation for $\mathrm{d} \overline{\boldsymbol{Y}}(t)$ as before, take expectations, so as to obtain

\boldsymbol{w}_{t}^{\prime}=\bar{Q}_{2 \boldsymbol{\gamma}} \boldsymbol{w}_{t}+2 \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\nu}_{t}+\operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{p}_{t}
$$

here $\boldsymbol{\sigma}^{2}$ is the vector $\left(\sigma_{1}^{2}, \ldots, \sigma_{d}^{2}\right)^{\mathrm{T}}$. This leads to

$$
\begin{equation*}
\boldsymbol{w}_{t}=e^{\bar{Q}_{2 \gamma} t} \boldsymbol{w}_{0}+\int_{0}^{t} e^{\bar{Q}_{2 \gamma}(t-s)}\left(2 \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\nu}_{s}+\operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{p}_{s}\right) \mathrm{d} s \tag{8}
\end{equation*}
$$

so that $v_{t}=\mathbf{1}^{\mathrm{T}} \boldsymbol{w}_{t}-\mu_{t}^{2}$. Observe that $\boldsymbol{w}_{0}=m_{0}^{2} \boldsymbol{p}_{0}$.
Again simplifications can be made if $\boldsymbol{p}_{0}=\boldsymbol{\pi}$ (and hence $\boldsymbol{p}_{t}=\boldsymbol{\pi}$ for all $t \geqslant 0$ ). In that case, we had already found an expression for $\boldsymbol{\nu}_{s}$ above, and as a result (8) can be explicitly evaluated.
For the stationary situation ( $t \rightarrow \infty$, that is) we obtain

$$
\boldsymbol{w}_{\infty}=-\bar{Q}_{2 \gamma}^{-1}\left(2 \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\nu}_{\infty}+\operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{\pi}\right),
$$

and $v_{\infty}=\mathbf{1}^{\mathrm{T}} \boldsymbol{w}_{\infty}-\mu_{\infty}^{2}$.
We consider now an even more special case: $\gamma_{i} \equiv \gamma$ for all $i$ (in addition to $\boldsymbol{p}_{t}=\boldsymbol{\pi}$; we let $t \geqslant 0$ ). It is directly seen that $\mu_{\infty}=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha} / \gamma$. Note that $\gamma^{\mathrm{T}} \bar{Q}_{\gamma}^{-1}=-\mathbf{1}^{\mathrm{T}}$ implies $\mathbf{1}^{\mathrm{T}} \bar{Q}_{\delta \boldsymbol{1}}^{-1}=-\delta^{-1} \mathbf{1}^{\mathrm{T}}$ for any $\delta>0$, so that

$$
\begin{aligned}
v_{\infty} & =\mathbf{1}^{\mathrm{T}} \boldsymbol{w}_{\infty}-\mu_{\infty}^{2}=\frac{\mathbf{1}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\nu}_{\infty}}{\gamma}+\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}-\left(\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}}{\gamma}\right)^{2} \\
& =-\frac{\mathbf{1}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\alpha}\} \bar{Q}_{\gamma \boldsymbol{1}}^{-1} \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{\pi}}{\gamma}+\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}-\left(\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}}{\gamma}\right)^{2} .
\end{aligned}
$$

Now observe that, with $\check{D}_{i j}(\gamma):=\int_{0}^{\infty} p_{i j}(v) e^{-\gamma v} \mathrm{~d} v$ for $\gamma>0$, integration by parts yields

$$
Q \check{D}(\gamma)=\int_{0}^{\infty} Q P(v) e^{-\gamma v} \mathrm{~d} v=\int_{0}^{\infty} P^{\prime}(v) e^{-\gamma v} \mathrm{~d} v=-I+\int_{0}^{\infty} \gamma P(v) e^{-\gamma v} \mathrm{~d} v=-I+\gamma \check{D}(\gamma) .
$$

As a consequence, $-(Q-\gamma I) \check{D}(\gamma)=I$, so that

$$
v_{\infty}=\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}+\frac{1}{\gamma} \boldsymbol{\alpha}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} \check{D}(\gamma) \boldsymbol{\alpha}-\left(\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}}{\gamma}\right)^{2},
$$

which, with $D_{i j}(\gamma):=\int_{0}^{\infty}\left(p_{i j}(v)-\pi_{j}\right) e^{-\gamma v} \mathrm{~d} v=\check{D}_{i j}(\gamma)-\pi_{j} / \gamma$, eventually leads to

$$
v_{\infty}=\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}+\frac{1}{\gamma} \boldsymbol{\alpha}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D(\gamma) \boldsymbol{\alpha}
$$

The next subsection further studies the case in which the $\gamma_{i}$ s are equal, i.e., $\gamma_{i} \equiv \gamma$, and the background process is in steady state at time 0 , i.e., and $\boldsymbol{p}_{\boldsymbol{t}}=\boldsymbol{\pi}$. As it turns out, under these conditions the mean and variance can also be found by an alternative elementary, insightful argumentation.

### 3.2 Mean and variance: special case of equal $\gamma$, starting in equilibrium

In this subsection we consider the special case $\gamma_{i} \equiv \gamma$ for all $i$, while the Markov chain $X(t)$ starts off in equilibrium at time 0 (so that $\mathbb{P}(X(t)=i)=\mathbb{P}(X(0)=i)=\pi_{i}$ for all $t \geqslant 0$ ). In this special case we can evaluate $\mu_{t}$ and $v_{t}$ rather explicitly, particularly when in addition particular scalings are imposed.

We first concentrate on computing the transient mean $\mu_{t}$. We denote by $X$ the path $(X(s), s \in[0, t])$. Now using the representation of Thm. 2.1, and recalling the standard fact that $\mu_{t}$ can be written as $\mathbb{E}(\mathbb{E}(M(t) \mid X))$, it is immediately seen that $\mu_{t}$ can be written as a convex mixture of $m_{0}$ and $\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha} / \gamma$ :

$$
\mu_{t}=m_{0} e^{-\gamma t}+e^{-\gamma t} \int_{0}^{t} e^{\gamma s} \mathrm{~d} s\left(\sum_{i=1}^{d} \pi_{i} \alpha_{i}\right)=m_{0} e^{-\gamma t}+\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}}{\gamma}\left(1-e^{-\gamma t}\right)
$$

use that $(X(t))_{t \geqslant 0}$ started off in equilibrium at time 0 . This expression converges, as $t \rightarrow \infty$, to the stationary mean $\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha} / \gamma$, as expected.
The variance $v_{t}$ can be computed similarly, relying on the so called law of total variance, which says that $\operatorname{Var} M(t)=\mathbb{E}(\mathbb{V} \operatorname{ar}(M(t) \mid X))+\operatorname{Var}(\mathbb{E}(M(t) \mid X))$. Regarding the first term, it is seen that Thm. 2.1 directly yields

$$
\begin{aligned}
\mathbb{E}(\operatorname{Var}(M(t) \mid X)) & =\mathbb{E}\left(\int_{0}^{t} e^{-2 \gamma(t-s)} \sigma_{X(s)}^{2} \mathrm{~d} s\right) \\
& =\int_{0}^{t} e^{-2 \gamma(t-s)} \mathbb{E}\left(\sigma_{X(s)}^{2}\right) \mathrm{d} s=\sum_{i=1}^{d} \pi_{i} \sigma_{i}^{2}\left(\frac{1-e^{-2 \gamma t}}{2 \gamma}\right) .
\end{aligned}
$$

Along similar lines,

$$
\begin{aligned}
\operatorname{Var}(\mathbb{E}(M(t) \mid X)) & =\mathbb{V} \operatorname{ar}\left(\int_{0}^{t} e^{-\gamma(t-s)} \alpha_{X(s)} \mathrm{d} s\right) \\
& =\int_{0}^{t} \int_{0}^{t} \operatorname{Cov}\left(e^{-\gamma(t-s)} \alpha_{X(s)}, e^{-\gamma(t-u)} \alpha_{X(u)}\right) \mathrm{d} u \mathrm{~d} s \\
& =e^{-2 \gamma t} \int_{0}^{t} \int_{0}^{t} e^{\gamma(s+u)} \operatorname{Cov}\left(\alpha_{X(s)}, \alpha_{X(u)}\right) \mathrm{d} u \mathrm{~d} s
\end{aligned}
$$

The latter integral expression can be made more explicit. Recalling that $(X(t))_{t \geqslant 0}$ started off in equilibrium at time 0 , it can be evaluated as

$$
\begin{aligned}
& 2 e^{-2 \gamma t} \int_{0}^{t} \int_{0}^{s} e^{\gamma(s+u)} \operatorname{Cov}\left(\alpha_{X(s)}, \alpha_{X(u)}\right) \mathrm{d} u \mathrm{~d} s \\
& \quad=2 e^{-2 \gamma t} \int_{0}^{t} \int_{0}^{s} e^{\gamma(s+u)} \sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \pi_{i}\left(p_{i j}(s-u)-\pi_{j}\right) \mathrm{d} u \mathrm{~d} s \\
& \quad=\frac{1}{\gamma} \sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \int_{0}^{t}\left(e^{-\gamma v}-e^{-\gamma(2 t-v)}\right) \pi_{i}\left(p_{i j}(v)-\pi_{j}\right) \mathrm{d} v
\end{aligned}
$$

(where the last equation follows after changing the order of integration and some elementary calculus). We arrive at the following result.

Proposition 3.1. For $t \geq 0$,

$$
\mu_{t}=m_{0} e^{-\gamma t}+\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}}{\gamma}\left(1-e^{-\gamma t}\right)
$$

and

$$
v_{t}=\sum_{i=1}^{d} \pi_{i} \sigma_{i}^{2}\left(\frac{1-e^{-2 \gamma t}}{2 \gamma}\right)+\sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \int_{0}^{t}\left(\frac{e^{-\gamma v}-e^{-\gamma(2 t-v)}}{\gamma}\right) \pi_{i}\left(p_{i j}(v)-\pi_{j}\right) \mathrm{d} v
$$

We conclude this section by considering two specific limiting regimes, to which we return in Section 5 where we will derive limit distributions under parameter scalings.
$\triangleright$ Specializing to the situation that $t \rightarrow \infty$, we obtain

$$
\mathbb{V a r} M=\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}+\frac{1}{\gamma} \sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \pi_{i} D_{i j}(\gamma)=\frac{\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}}{2 \gamma}+\frac{1}{\gamma} \boldsymbol{\alpha}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D(\gamma) \boldsymbol{\alpha},
$$

in accordance with the expression we found before.
$\triangleright$ Scale $\boldsymbol{\alpha} \mapsto N^{h} \boldsymbol{\alpha}, \boldsymbol{\sigma}^{2} \mapsto N^{h} \boldsymbol{\sigma}^{2}$, and $Q \mapsto N Q$ for some $h \geq 0$. We obtain that $\mathbb{V a r} M(t)$ equals

$$
N^{h} \sum_{i=1}^{d} \pi_{i} \sigma_{i}^{2}\left(\frac{1-e^{-2 \gamma t}}{2 \gamma}\right)+N^{2 h} \sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \int_{0}^{t}\left(\frac{e^{-\gamma v}-e^{-\gamma(2 t-v)}}{\gamma}\right) \pi_{i}\left(p_{i j}(v N)-\pi_{j}\right) \mathrm{d} v,
$$

which for $N$ large behaves as

$$
\begin{align*}
\left(\frac{1-e^{-2 \gamma t}}{2 \gamma}\right) & \left(N^{h} \sum_{i=1}^{d} \pi_{i} \sigma_{i}^{2}+2 N^{2 h-1} \sum_{i=1}^{d} \sum_{j=1}^{d} \alpha_{i} \alpha_{j} \pi_{i} D_{i j}\right) \\
= & \left(\frac{1-e^{-2 \gamma t}}{2 \gamma}\right)\left(N^{h} \boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}+2 N^{2 h-1} \boldsymbol{\alpha}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D \boldsymbol{\alpha}\right), \tag{9}
\end{align*}
$$

where $D:=D(0)$ is the deviation matrix introduced in Section 2.
We observe an interesting dichotomy: for $h<1$ the variance is essentially linear in the 'scale' of the ou processes $N^{h}$, while for $h>1$ it behaves superlinearly in $N^{h}$ (more specifically, proportionally to $N^{2 h-1}$ ). It is this dichotomy that also featured in earlier work on Markov-modulated infinite-server queues [7].
The intuition behind the dichotomy is the following. If $h<1$, then the timescale of the background process systematically exceeds that of the $d$ underlying ou processes (that is, the background process is 'faster'). As a result, the system essentially behaves as an ordinary (that is, non-modulated) ou process with 'time average' parameters $\alpha_{\infty}:=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}, \gamma$, and $\sigma_{\infty}^{2}:=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}$. If $h>1$, on the contrary, the background process jumps at a slow rate, relative to the typical timescale of the ou processes; as a result, the process $(M(t))_{t \geqslant 0}$ moves between multiple local limits (where the individual 'variance coefficients' $\sigma_{i}^{2}$ do not play a role).

Note that it follows from (9) that $\operatorname{diag}\{\boldsymbol{\pi}\} D$ is a nonnegative definite matrix, although singular and non-symmetric in general; more precisely, it is a consequence of the fact that (9) is a variance and hence nonnegative, in conjunction with the fact the we can pick $\boldsymbol{\sigma}^{2}=0$. Below we state and prove the nonnegativity by independent arguments; cf. [2, Prop 3.2].
Proposition 3.2. The matrix $D^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\}+\operatorname{diag}\{\boldsymbol{\pi}\} D$ is symmetric and nonnegative definite.
Proof. First we prove the claim that the matrix $Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\}+\operatorname{diag}\{\boldsymbol{\pi}\} Q$ is (symmetric and) nonpositive definite. To that end we start from the semimartingale decomposition (6) for $\boldsymbol{Z}$. By the product rule we obtain, collecting all the martingale terms in $\mathrm{d} M_{t}$,

$$
\mathrm{d}\left(\boldsymbol{Z}_{t} \boldsymbol{Z}_{t}^{\mathrm{T}}\right)=Q^{\mathrm{T}} \boldsymbol{Z}_{t} \boldsymbol{Z}_{t}^{\mathrm{T}} \mathrm{~d} t+\boldsymbol{Z}_{t} \boldsymbol{Z}_{t}^{\mathrm{T}} Q \mathrm{~d} t+\mathrm{d}\langle\boldsymbol{Z}\rangle_{t}+\mathrm{d} M_{t} .
$$

As the predictable quadratic variation of $\boldsymbol{Z}$ is absolutely continuous and increasing, we can write $\mathrm{d}\langle\boldsymbol{Z}\rangle_{t}=P_{t} \mathrm{~d} t$, where $P_{t}$ is a nonnegative definite matrix. Next we make the observation that $\boldsymbol{Z}_{t} \boldsymbol{Z}_{t}^{\mathrm{T}}=$ $\operatorname{diag}\left\{\boldsymbol{Z}_{t}\right\}$. Hence we have by combining (6) and the above display

$$
\operatorname{diag}\left\{Q^{\mathrm{T}} \boldsymbol{Z}_{t}\right\}=Q^{\mathrm{T}} \operatorname{diag}\left\{\boldsymbol{Z}_{t}\right\}+\operatorname{diag}\left\{\boldsymbol{Z}_{t}\right\} Q+P_{t}
$$

Taking expectations w.r.t. the stationary distribution of $\boldsymbol{Z}_{t}$ and using $Q^{\mathrm{T}} \pi=0$, we obtain

$$
0=Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\}+\operatorname{diag}\{\boldsymbol{\pi}\} Q+\mathbb{E} P_{t}
$$

from which it follows that $Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\}+\operatorname{diag}\{\boldsymbol{\pi}\} Q$ is (symmetric and) nonpositive definite.
This in turn implies that $-D^{\mathrm{T}}\left(Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\}+\operatorname{diag}\{\boldsymbol{\pi}\} Q\right) D$ is symmetric and nonnegative definite. Recall now that $F Q=\Pi-I$ and hence $D Q=\Pi-I$. Then $D^{\mathrm{T}} Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D=-\left(\operatorname{diag}\{\boldsymbol{\pi}\}-\boldsymbol{\pi} \boldsymbol{\pi}^{\mathrm{T}}\right) D$. But $\boldsymbol{\pi}^{\mathrm{T}} D=0$, so $D^{\mathrm{T}} Q^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D=-\operatorname{diag}\{\boldsymbol{\pi}\} D$. The result now follows.

### 3.3 Covariances

In this subsection we point out how to compute the covariance

$$
c(t, u):=\mathbb{C o v}(M(t), M(t+u))
$$

for $t, u \geqslant 0$. To this end, we observe that by applying a time shift, we first assume in the computations to follow that $t=0$, and we consider $c(t):=\operatorname{Cov}(M(t), M(0))$. Below we make frequently use of the additional quantities $\boldsymbol{C}(t)=\mathbb{C o v}(\boldsymbol{Y}(t), M(0))$ and $\boldsymbol{B}(t)=\operatorname{Cov}(\boldsymbol{Z}(t), M(0))$. Note that $c(t)=$ $\mathbf{1}^{\mathrm{T}} \boldsymbol{C}(t)$. Multiplying Equations (6) and (7) by $M(0)$, we obtain upon taking expectation the following system of ODE s:

$$
\binom{\boldsymbol{B}^{\prime}(t)}{\boldsymbol{C}^{\prime}(t)}=R\binom{B(t)}{C(t)}, \quad \text { where } \quad R:=\left(\begin{array}{cc}
Q^{\mathrm{T}} & 0 \\
\operatorname{diag}\{\boldsymbol{\alpha}\} & \bar{Q}_{\gamma}
\end{array}\right)\binom{\boldsymbol{B}(t)}{\boldsymbol{C}(t)}
$$

with initial conditions $\boldsymbol{B}(0)=\mathbb{C o v}(\boldsymbol{Z}(0), M(0))$ and $\boldsymbol{C}(0)=\mathbb{C o v}(\boldsymbol{Y}(0), M(0))$. In a more compact and obvious notation, we have $\boldsymbol{A}^{\prime}(t)=R A(t)$, and hence $\boldsymbol{A}(t)=\exp (R t) \boldsymbol{A}(0)$.
Likewise we can compute

$$
A(t, u):=\binom{\operatorname{Cov}(\boldsymbol{Z}(t+u), M(t))}{\operatorname{Cov}(\boldsymbol{Y}(t+u), M(t))}=\exp (R u)\binom{\mathbb{C o v}(\boldsymbol{Z}(t), M(t))}{\operatorname{Cov}(\boldsymbol{Y}(t), M(t))}
$$

It remains to derive an expression for the last covariances. For $\operatorname{Cov}(\boldsymbol{Z}(t), M(t))$ we need $\mathbb{E} M(t) \boldsymbol{Z}(t)=$ $\mathbb{E} \boldsymbol{Y}(t)$ and $\mathbb{E} M(t), \mathbb{E} \boldsymbol{Z}(t)$. For $\mathbb{C o v}(\boldsymbol{Y}(t), M(t))$ we need $\mathbb{E} M(t) \boldsymbol{Y}(t)=\mathbb{E} M(t)^{2} \boldsymbol{Z}(t), \mathbb{E} \boldsymbol{Y}(t)$ and $\mathbb{E} M(t)$. All these quantities have been obtained in Section 3.1.

### 3.4 Recursive scheme for higher order moments

The objective of this section is to set up a recursive scheme to generate all transient moments, that is, the expected value of $M(t)^{k}$, for any $k \in\{1,2, \ldots\}$, jointly with the indicator function $1\{X(t)=i\}$. To that end we consider the expectation of $(M(t))^{k} \boldsymbol{Z}(t)$. First we rewrite Equation (1) as

$$
\begin{equation*}
\mathrm{d} M(t)=\left(\boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{Z}(t)-\boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{Z}(t) X(t)\right) \mathrm{d} t+\boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t) \tag{10}
\end{equation*}
$$

Itô's lemma and (10) directly yield

$$
\begin{aligned}
& \mathrm{d}(M(t))^{k}=k(M(t))^{k-1}\left(\boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{Z}(t)-\boldsymbol{\gamma}^{\mathrm{T}} \boldsymbol{Z}(t) X(t)\right) \mathrm{d} t+k(M(t))^{k-1} \boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t) \\
&+\frac{1}{2} k(k-1)(M(t))^{k-2} \boldsymbol{\sigma}^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{Z}(t)\} \boldsymbol{\sigma} \mathrm{d} t .
\end{aligned}
$$

Then we apply the product rule to $M(t)^{k} \boldsymbol{Z}(t)$, together with the just obtained equation and Equation (6), so as to obtain

$$
\begin{aligned}
\mathrm{d}\left((M(t))^{k} \boldsymbol{Z}(t)\right)= & k(M(t))^{k-1}(\operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{Z}(t)-\operatorname{diag}\{\boldsymbol{\gamma}\} \boldsymbol{Z}(t) M(t)) \mathrm{d} t \\
& +k(M(t))^{k-1} \operatorname{diag}\{\boldsymbol{\sigma}\} \boldsymbol{Z}(t) \mathrm{d} B(t)+\frac{1}{2} k(k-1)(M(t))^{k-2} \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{Z}(t) \mathrm{d} t \\
& +(M(t))^{k}\left(Q^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} t+\mathrm{d} K(t)\right)
\end{aligned}
$$

All martingale terms on the right are genuine martingales and thus have expectation zero. Putting $\boldsymbol{H}_{k}(t):=\mathbb{E} M(t)^{k} \boldsymbol{Z}(t)$, we get the following recursion in ODE form:

$$
\begin{aligned}
\frac{\mathrm{d}}{\mathrm{~d} t} \boldsymbol{H}_{k}(t) & =k \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{H}_{k-1}(t)-k \operatorname{diag}\{\gamma\} \boldsymbol{H}_{k}(t)+\frac{1}{2} k(k-1) \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{H}_{k-2}(t)+Q^{\mathrm{T}} \boldsymbol{H}_{k}(t) \\
& =\bar{Q}_{k \gamma} \boldsymbol{H}_{k}(t)+k \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{H}_{k-1}(t)+\frac{1}{2} k(k-1) \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{H}_{k-2}(t)
\end{aligned}
$$

Stacking $\boldsymbol{H}_{0}(t), \ldots, \boldsymbol{H}_{n}(t)$ into a single vector $\overline{\boldsymbol{H}}_{n}(t)$, we obtain the differential equation

$$
\frac{\mathrm{d}}{\mathrm{~d} t} \overline{\boldsymbol{H}}_{n}(t)=A_{n} \overline{\boldsymbol{H}}_{n}(t)
$$

with $A_{n} \in \mathbb{R}^{(n+1) d \times(n+1) d}$ denoting a lower block triangular matrix, whose solution is $\boldsymbol{H}_{n}(t)=$ $\exp \left(A_{n} t\right) \boldsymbol{H}_{n}(0)$. Eventually, $h_{k}(t):=\mathbb{E} M(t)^{k}$ is given by $h_{k}(t)=\mathbf{1}^{\mathrm{T}} \boldsymbol{H}_{k}(t)$. Note that for $k=1,2$ the results of Section 3 can be recovered.

## 4 Transient behavior: partial differential equations

The goal of this section is to characterize, for a given vector $t \in \mathbb{R}^{K}$ (with $K \in \mathbb{N}$ ) such that $0 \leqslant$ $t_{1} \leqslant \cdots \leqslant t_{K}$, the Laplace transform of $\left(M\left(t+t_{1}\right), \ldots, M\left(t+t_{K}\right)\right)$ (together with the state of the background process at these time instances). More specifically, we set up a system of PDE s for

$$
g_{\boldsymbol{i}}(\boldsymbol{\vartheta}, t):=\mathbb{E} e^{-\left(\vartheta_{1} M\left(t_{1}+t\right)+\cdots+\vartheta_{K} M\left(t_{K}+t\right)\right)} 1\left\{X\left(t_{1}+t\right)=i_{1}, \ldots, X\left(t_{K}+t\right)=i_{K}\right\}
$$

here $t \geqslant 0, \boldsymbol{i} \in\{1, \ldots, d\}^{K}$ and $\boldsymbol{\vartheta} \in \mathbb{R}^{K}$. The system of pdes is with respect to $t$ and $\vartheta_{1}$ up to $\vartheta_{K}$. We first point out the line of reasoning for the case $K=1$, and then present the pde for $K=2$. The cases $K \in\{3,4, \ldots\}$ can be dealt with fully analogously, but lead to notational inconveniences and are therefore left out.
It is noted that the stationary version of the result below (i.e., $t \rightarrow \infty$ ) for the special case $K=1$ has appeared in [35] (where we remark that in [35] the additional issue of reflection at 0 has been incorporated).

### 4.1 Fourier-Laplace transform

For $K=1$, the object of interest is

$$
g_{i}(\vartheta, t):=\mathbb{E} e^{-\vartheta M(t)} 1\{X(t)=i\}
$$

for $i=1, \ldots, d$; realize that, without loss of generality, we have taken $t_{1}=0$. For a more compact notation we stack the $g_{i}$ in a single vector $\boldsymbol{g}$, so $\boldsymbol{g}(\vartheta, t)=\mathbb{E} e^{-\vartheta M(t)} \boldsymbol{Z}(t)$. Replacing in this expression $\vartheta$ by $-\mathrm{i} u$ for $u \in \mathbb{R}$ gives the characteristic function of $M(t)$ jointly with $\boldsymbol{Z}(t)$.

Theorem 4.1. Consider the case $K=1$ and $t_{1}=0$. The Laplace transforms $\boldsymbol{g}(\vartheta, t)$ satisfy the following system of PDE s:

$$
\begin{equation*}
\frac{\partial}{\partial t} \boldsymbol{g}(\vartheta, t)=Q^{\mathrm{T}} \boldsymbol{g}(\vartheta, t)-\left(\vartheta \operatorname{diag}\{\boldsymbol{\alpha}\}-\frac{1}{2} \vartheta^{2} \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\}\right) \boldsymbol{g}(\vartheta, t)-\vartheta \operatorname{diag}\{\gamma\} \frac{\partial}{\partial \vartheta} \boldsymbol{g}(\vartheta, t) \tag{11}
\end{equation*}
$$

The corresponding initial conditions are $\boldsymbol{g}(0, t)=\boldsymbol{p}_{t}$ and $\boldsymbol{g}(\vartheta, 0)=e^{-\vartheta m_{0}} \boldsymbol{p}_{0}$.
Proof. The proof mimics the procedure used in Section 3.4 to determine the moments of $M(t)$. Letting $f(\vartheta, t)=e^{-\vartheta M(t)}$, applying Itô's formula to (10) yields
$\mathrm{d} f(\vartheta, t)=-\vartheta f(\vartheta, t)\left(\left(\boldsymbol{\alpha}^{\mathrm{T}} \boldsymbol{Z}(t)-\gamma^{\mathrm{T}} \boldsymbol{Z}(t) M(t)\right) \mathrm{d} t+\boldsymbol{\sigma}^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} B(t)\right)+\frac{1}{2} \vartheta^{2} f(\vartheta, t) \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{Z}(t) \mathrm{d} t$.
We then apply the product rule to $f(\vartheta, t) \boldsymbol{Z}(t)$, using the just obtained equation in combination with Equation (6). This leads to

$$
\begin{aligned}
\mathrm{d}(f(\vartheta, t) \boldsymbol{Z}(t))=- & \vartheta f(\vartheta, t)((\operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{Z}(t)-\operatorname{diag}\{\boldsymbol{\gamma}\} \boldsymbol{Z}(t) M(t)) \mathrm{d} t+\operatorname{diag}\{\boldsymbol{\sigma}\} \boldsymbol{Z}(t) \mathrm{d} B(t)) \\
& +\frac{1}{2} \vartheta^{2} f(\vartheta, t) \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \boldsymbol{Z}(t) \mathrm{d} t+f(\vartheta, t)\left(Q^{\mathrm{T}} \boldsymbol{Z}(t) \mathrm{d} t+\mathrm{d} K(t)\right)
\end{aligned}
$$

Taking expectations, and recalling that $\boldsymbol{g}(\vartheta, t)=\mathbb{E} f(\vartheta, t) \boldsymbol{Z}(t)$ and that the martingale terms have expectation zero, we obtain

$$
\begin{aligned}
\frac{\partial}{\partial t} \boldsymbol{g}(\vartheta, t)= & -\vartheta \operatorname{diag}\{\boldsymbol{\alpha}\} \boldsymbol{g}(\vartheta, t)+\vartheta \operatorname{diag}\{\boldsymbol{\gamma}\} \mathbb{E}(f(\vartheta, t) M(t) \boldsymbol{Z}(t)) \\
& +\frac{1}{2} \vartheta^{2} \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} f(\vartheta, t)+Q^{\mathrm{T}} f(\vartheta, t)
\end{aligned}
$$

Realizing that $\partial \boldsymbol{g} / \partial \vartheta=-\mathbb{E}(f(\vartheta, t) M(t) \boldsymbol{Z}(t))$, we can rewrite this as (11).
It is remarked that the above system (11) of pde s coincides, for $t \rightarrow \infty$, with the stationary result of [35] (where it is mentioned that in [35] the feature of reflection at 0 has been incorporated). In addition, it is noted that this system can be converted into a system of ordinary differential equations, as follows. Let $T$ be exponentially distributed with mean $\tau^{-1}$, independent of all other random features involved in the model. Define

$$
g_{i}(\vartheta):=\mathbb{E} e^{-\vartheta M(T)} 1\{X(T)=i\}
$$

Now multiply the pde featuring in Thm. 4.1 by $\tau e^{-\tau t}$, and integrate over $t \in[0, \infty$ ), to obtain (use integration by parts for the left-hand side)

$$
\lambda\left(\boldsymbol{g}(\vartheta)-e^{-\vartheta m_{0}} \boldsymbol{p}_{0}\right)=Q^{\mathrm{T}} \boldsymbol{g}(\vartheta)-\left(\vartheta \operatorname{diag}\{\boldsymbol{\alpha}\}-\frac{1}{2} \vartheta^{2} \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\}\right) \boldsymbol{g}(\vartheta)-\vartheta \operatorname{diag}\{\gamma\} \frac{\partial}{\partial \vartheta} \boldsymbol{g}(\vartheta)
$$

All above results related to the case $K=1$. For higher values of $K$ the same procedure can be followed; as announced we now present the result for $K=2$. Let $i, k$ be elements of $\{1, \ldots, d\}$, and $\boldsymbol{\vartheta} \equiv$ $\left(\vartheta_{1}, \vartheta_{2}\right) \in \mathbb{R}^{2}$. We obtain the following system of PDE s:

$$
\begin{aligned}
& \frac{\partial}{\partial t} g_{i, k}(\boldsymbol{\vartheta}, t)=\sum_{j=1}^{d} q_{j i} g_{j, k}(\boldsymbol{\vartheta}, t)+\sum_{\ell=1}^{d} q_{\ell k} g_{i, \ell}(\boldsymbol{\vartheta}, t) \\
& \quad-\left(\vartheta_{1} \alpha_{i}+\vartheta_{2} \alpha_{k}-\frac{1}{2} \vartheta_{1}^{2} \sigma_{i}^{2}-\frac{1}{2} \vartheta_{2}^{2} \sigma_{k}^{2}\right) g_{i, k}(\boldsymbol{\vartheta}, t)-\vartheta_{1} \gamma_{i} \frac{\partial}{\partial \vartheta_{1}} g_{i, k}(\boldsymbol{\vartheta}, t)-\vartheta_{2} \gamma_{k} \frac{\partial}{\partial \vartheta_{2}} g_{i, k}(\boldsymbol{\vartheta}, t),
\end{aligned}
$$

or in self-evident matrix notation, suppressing the arguments $\boldsymbol{\vartheta}$ and $t$,

$$
\begin{aligned}
\frac{\partial G}{\partial t} & =Q^{\mathrm{T}} G+G Q-\vartheta_{1} \operatorname{diag}\{\boldsymbol{\alpha}\} G-\vartheta_{2} G \operatorname{diag}\{\boldsymbol{\alpha}\} \\
& +\frac{1}{2} \vartheta_{1}^{2} \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} G+\frac{1}{2} \vartheta_{2}^{2} G \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\}-\vartheta_{1} \operatorname{diag}\{\boldsymbol{\gamma}\} \frac{\partial G}{\partial \vartheta_{1}}-\vartheta_{2} \frac{\partial G}{\partial \vartheta_{2}} \operatorname{diag}\{\boldsymbol{\gamma}\}
\end{aligned}
$$

This matrix-valued system of PDE s can be converted into its vector-valued counterpart. Define the $d^{2}-$ dimensional vector $\check{\boldsymbol{g}}(\boldsymbol{\vartheta}, t):=\operatorname{vec}(G(\boldsymbol{\vartheta}, t))$. Recall the definitions of the Kronecker sum (denoted by ' $\oplus$ ') and the Kronecker product (denoted by ' $\otimes$ '). Using the relations vec $(A B C)=\left(C^{\mathrm{T}} \otimes A\right) \operatorname{vec}(B)$ and $A \oplus B=A \otimes I+I \otimes B$, for matrices $A, B$, and $C$ of appropriate dimensions, we obtain the vector-valued PDE

$$
\begin{aligned}
& \frac{\partial \check{\boldsymbol{g}}}{\partial t}=\left(Q^{\mathrm{T}} \oplus Q^{\mathrm{T}}\right) \check{\boldsymbol{g}}-\vartheta_{1}(I \otimes \operatorname{diag}\{\boldsymbol{\alpha}\}) \check{\boldsymbol{g}}-\vartheta_{2}(\operatorname{diag}\{\boldsymbol{\alpha}\} \otimes I) \check{\boldsymbol{g}} \\
& \quad+\frac{\vartheta_{1}^{2}}{2}\left(I \otimes \operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\}\right) \check{\boldsymbol{g}}+\frac{\vartheta_{2}^{2}}{2}\left(\operatorname{diag}\left\{\boldsymbol{\sigma}^{2}\right\} \otimes I\right) \check{\boldsymbol{g}}-\vartheta_{1}(I \otimes \operatorname{diag}\{\gamma\}) \frac{\partial \check{\boldsymbol{g}}}{\partial \vartheta_{1}}-\vartheta_{2}(\operatorname{diag}\{\gamma\} \otimes I) \frac{\partial \check{\boldsymbol{g}}}{\partial \vartheta_{2}}
\end{aligned}
$$

again suppressing the arguments $\boldsymbol{\vartheta}$ and $t$.
It is clear how this procedure should be extended to $K \in\{3,4, \ldots\}$, but, as mentioned above, we do not include this because of the cumbersome notation needed.

### 4.2 Explicit computations for two-dimensional case

We now present more explicit expressions relating to the case that $d=2$. Define $q:=q_{1}+q_{2}$. Suppose the system starts off at $(M(0), X(0))=\left(m_{0}, 2\right)$. Throughout this example we use the notation

$$
g_{i}(\vartheta, t, j):=\mathbb{E}\left(e^{-\vartheta M(t)} 1\{X(t)=j\} \mid X(0)=i\right)
$$

The theory of this section yields the following system of partial differential equations:

$$
\begin{aligned}
\frac{\partial}{\partial t} g_{2}(t, \vartheta, 1)+\vartheta \gamma_{1} \frac{\partial}{\partial \vartheta} g_{2}(t, \vartheta, 1) & =\left(-q_{1}-\vartheta \alpha_{1}+\frac{1}{2} \vartheta^{2} \sigma_{1}^{2}\right) g_{2}(t, \vartheta, 1)+q_{2} g_{2}(t, \vartheta, 2) \\
\frac{\partial}{\partial t} g_{2}(t, \vartheta, 2)+\vartheta \gamma_{2} \frac{\partial}{\partial \vartheta} g_{2}(t, \vartheta, 2) & =\left(-q_{2}-\vartheta \alpha_{2}+\frac{1}{2} \vartheta^{2} \sigma_{2}^{2}\right) g_{2}(t, \vartheta, 2)+q_{1} g_{2}(t, \vartheta, 1)
\end{aligned}
$$

with conditions (realizing that $\pi_{i}=q_{i} / q$ )

$$
\binom{g_{2}(0, \vartheta, 1)}{g_{2}(0, \vartheta, 2)}=\binom{0}{e^{-\vartheta x}}, \quad\binom{g_{2}(t, 0,1)}{g_{2}(t, 0,2)}=\binom{\pi_{1}-\pi_{1} e^{-q t}}{\pi_{2}+\pi_{1} e^{-q t}}
$$

and $\vartheta \in \mathbb{R}$ and $t \in[0, \infty)$.
In the special case that $q_{1}=0$ (so that state 2 is transient, and state 1 is absorbing), the system of differential equations decouples; the second of the above two partial differential equations can be solved using the method of characteristics. Routine calculations lead to

$$
g_{2}(t, \vartheta, 2)=\exp \left(-\vartheta m_{0} e^{-\gamma_{2} t}-q_{2} t-\frac{\alpha_{2}}{\gamma_{2}}\left(\vartheta-\vartheta e^{-\gamma_{2} t}\right)+\frac{\sigma_{2}^{2}}{4 \gamma_{2}}\left(\vartheta^{2}-\vartheta^{2} e^{-2 \gamma_{2} t}\right)\right)
$$

Now the first equation of the two partial differential equations can be solved as well, with the distinguishing feature that now we have a non-homogeneous (rather than a homogeneous) single-dimensional partial differential equation. It can be verified that it is solved by

$$
\begin{aligned}
g_{2}(t, \vartheta, 1)= & q_{2} \exp \left(-\frac{\alpha_{1}}{\gamma_{1}} \vartheta+\frac{\sigma_{1}^{2}}{4 \gamma_{1}} \vartheta^{2}\right) \times \\
& \quad \int_{0}^{t} g_{2}\left(s, \vartheta e^{-\gamma_{1}(t-s)}, 2\right) \exp \left(\frac{\alpha_{1}}{\gamma_{1}} \vartheta e^{-\gamma_{1}(t-s)}-\frac{\sigma_{1}^{2}}{4 \gamma_{1}} \vartheta^{2} e^{-2 \gamma_{1}(t-s)}\right) \mathrm{d} s
\end{aligned}
$$

## 5 Parameter scaling

So far we have characterized the distribution of $M(t)$ in terms of an algorithm to determine moments, and a PDE for the Fourier-Laplace transform. In other words, so far we have not presented any explicit results on the distribution of $M(t)$ itself. In this section we consider asymptotic regimes in which this is possible; these regimes can be interpreted as parameter scalings.
More specifically, in this section we consider the following two scaled versions of the mмоu model.
$\triangleright$ In the first we (linearly) speed up the background process (that is, we replace $Q \mapsto N Q$ or, equivalently, $X(t) \mapsto X(N t)$ ). Our main result is that, as $N \rightarrow \infty$, the mмои essentially experiences the time-averaged parameters, i.e., $\alpha_{\infty}:=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\alpha}, \gamma_{\infty}:=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\gamma}$ and $\sigma_{\infty}^{2}:=\boldsymbol{\pi}^{\mathrm{T}} \boldsymbol{\sigma}^{2}$. As a consequence, it behaves as an ou process with these parameters.
$\triangleright$ The second regime considered concerns a simultaneous scaling of the background process and the ou processes. This is done as in Section 3.2: $Q$ on the one hand, and $\boldsymbol{\alpha}$ and $\boldsymbol{\sigma}^{2}$ on the other hand are scaled at different rates: we replace $\boldsymbol{\alpha} \mapsto N^{h} \boldsymbol{\alpha}$ and $\boldsymbol{\sigma}^{2} \mapsto N^{h} \boldsymbol{\sigma}^{2}$, but $Q \mapsto N Q$ for some $h \geqslant 0$ ). We obtain essentially two regimes, in line with the observations in Section 3.2.

As mentioned above, we are particularly interested in the limiting behavior in the regime that $N$ grows large. It is shown that the process $M(t)$, which we now denote as $M^{[N]}(t)$ to stress the dependence on $N$, converges to the solution of a specific sde. Importantly, we establish weak convergence, i.e., in the sense of convergence at the process level; our result can be seen as the counterpart of the result for Markov-modulated infinite-server queues in [2].

We consider sequences of ммоч processes, indexed by $N$, subject to the following scaling: $q_{i j} \mapsto N q_{i j}$; $\alpha_{j} \mapsto N^{h} \alpha_{j} ; \sigma_{j} \mapsto N^{h / 2} \sigma_{j}$, where $h \geqslant 0$; note that by appropriately choosing $h$ we enter the two regimes described above as we let $N$ grow large (see Corollaries 5.2 and 5.3). The definitions of $M(t)$,
$\boldsymbol{Z}(t)$ and $\boldsymbol{K}(t)$ (the latter two having been defined in Section 3) then take the following form (where superscripts are being used to make the dependence on $N$ explicit):

$$
\begin{equation*}
\mathrm{d} M^{[N, h]}(t)=\sum_{k=1}^{d} \tilde{M}_{k}^{[N, h]}(t) Z_{k}^{[N]}(t) \mathrm{d} t+N^{h / 2} \sum_{k=1}^{d} \sigma_{k} Z_{k}^{[N, h]}(t) \mathrm{d} B(t) \tag{12}
\end{equation*}
$$

where $\tilde{M}_{k}^{[N, h]}(t):=N^{h} \alpha_{k}-\gamma_{k} M^{[N, h]}(t)$, and

$$
\begin{equation*}
\mathrm{d} K_{j}^{[N]}(t)=\mathrm{d} Z_{j}^{[N]}(t)-N \sum_{i=1}^{d} Z_{i}^{[N]}(t) q_{i j} \mathrm{~d} t \tag{13}
\end{equation*}
$$

It is useful to define the local martingales $L_{k}^{[N]}(t)$, recalling the definition of the deviation matrix $D$ from Section 2:

$$
\begin{aligned}
\mathrm{d} L_{k}^{[N]}(t) & :=N^{-1} \sum_{j=1}^{d} D_{j k} \mathrm{~d} K_{j}^{[N]}(t) \\
& =N^{-1} \sum_{j=1}^{d} D_{j k} \mathrm{~d} Z_{j}^{[N]}(t)-\sum_{i=1}^{d} \sum_{j=1}^{d} Z_{i}^{[N]}(t) q_{i j} D_{j k} \mathrm{~d} t \\
& =N^{-1} \sum_{j=1}^{d} D_{j k} \mathrm{~d} Z_{j}^{[N]}(t)+\left(Z_{k}^{[N]}(t)-\pi_{k}\right) \mathrm{d} t
\end{aligned}
$$

where we used in the last equality the fact that $Q D=\Pi-I$ (as an immediate consequence of $Q F=\Pi$; see Section 2), which we can alternatively write as $-\sum_{j=1}^{d} q_{i j} D_{j k}=1_{\{i=k\}}-\pi_{k}$, for any $i, k \in$ $\{1, \ldots, d\}$.
Let, with the definitions of $\alpha_{\infty}, \gamma_{\infty}$, and $\sigma_{\infty}^{2}$ given above, the 'average path' $\varrho(t)$ be defined by the ODE

$$
\mathrm{d} \varrho(t)=\left(\alpha_{\infty}-\gamma_{\infty} \varrho(t)\right) \mathrm{d} t
$$

such that we have

$$
\varrho(t)=\varrho_{0} e^{-\gamma_{\infty} t}+\frac{\alpha_{\infty}}{\gamma_{\infty}}\left(1-e^{-\gamma_{\infty} t}\right)
$$

Note that $N^{-h} M^{[N, h]}(t)$ converges to $\varrho(t)$ almost surely as $N \rightarrow \infty$, which can be established by writing the definition of $M^{[N, h]}(t)$ in the form of (16) and invoking the ergodic theorem, from which we also find that $N^{-h} \tilde{M}_{k}^{[N, h]}(t) \rightarrow \alpha_{k}-\gamma_{k} \varrho(t)$ as $N \rightarrow \infty$.
We can now state the main theorem of this section.
Theorem 5.1. Under the scaling $q_{i j} \mapsto N q_{i j} ; \alpha_{j} \mapsto N^{h} \alpha_{j} ; \sigma_{j} \mapsto N^{h / 2} \sigma_{j}$, and assuming that $N^{-h} M^{[N, h]}(0)$ converges in probability to the deterministic value $\varrho_{0}$, we have that the scaled and centered process $\hat{M}^{[N]}(t)$, as defined through

$$
\hat{M}^{[N, h]}(t):=N^{-\beta}\left(M^{[N, h]}(t)-N^{h} \varrho(t)\right),
$$

converges weakly to the solution of the following SDE:

$$
\mathrm{d} \hat{M}(t)=-\gamma_{\infty} \hat{M}(t) \mathrm{d} t+\sqrt{\sigma_{\infty}^{2} 1_{\{h \leqslant 1\}}+V(t) 1_{\{h \geqslant 1\}}} \mathrm{d} B(t) .
$$

where $\beta:=\max \{h / 2, h-1 / 2\}$ and

$$
V(t):=2 \int_{0}^{t} \sum_{i=1}^{d} \sum_{j=1}^{d} \pi_{i}\left(\alpha_{i}-\gamma_{i} \varrho(s)\right) D_{i j}\left(\alpha_{j}-\gamma_{j} \varrho(s)\right) \mathrm{d} s
$$

Before proving this result, we observe that the above theorem provides us with the limiting behavior in the two regimes described at the beginning of this section. In the first corollary we simply take $h=0$.

Corollary 5.2. Under the scaling $q_{i j} \mapsto N q_{i j} ; \alpha_{j} \mapsto \alpha_{j} ; \sigma_{j} \mapsto \sigma_{j}$, we have that $M^{[N, 0]}(t)$ converges weakly to a process $\mathscr{M}_{1}(t)$, which is an (ordinary, i.e., non-modulated) ou process with parameters $\left(\alpha_{\infty}, \gamma_{\infty}, \sigma_{\infty}\right)$, defined through the SDE

$$
\mathrm{d} \mathscr{M}_{1}(t)=\left(\alpha_{\infty}-\gamma_{\infty} \mathscr{M}_{1}(t)\right) \mathrm{d} t+\sigma_{\infty} \mathrm{d} B(t)
$$

The following corollary describes the situation in which both the background process and the ou process is scaled, but at different rates.

Corollary 5.3. Under the scaling $q_{i j} \mapsto N q_{i j} ; \alpha_{j} \mapsto N^{h} \alpha_{j} ; \sigma_{j} \mapsto N^{h / 2} \sigma_{j}$, we have that $\hat{M}^{[N, h]}(t)$ converges weakly to a process $\mathscr{M}_{2}(t)$, defined through one of the following SDE $s$ : if $0<h<1$, then

$$
\mathrm{d} \mathscr{M}_{2}(t)=-\gamma_{\infty} \mathscr{M}_{2}(t) \mathrm{d} t+\sigma_{\infty} \mathrm{d} B(t)
$$

if $h=1$, then

$$
\mathrm{d} \mathscr{M}_{2}(t)=-\gamma_{\infty} \mathscr{M}_{2}(t) \mathrm{d} t+\sqrt{\sigma_{\infty}^{2}+V(t)} \mathrm{d} B(t)
$$

and if $h>1$, then

$$
\mathrm{d} \mathscr{M}_{2}(t)=-\gamma_{\infty} \mathscr{M}_{2}(t) \mathrm{d} t+\sqrt{V(t)} \mathrm{d} B(t)
$$

These corollaries are trivial consequences of Thm. 5.1, and therefore we direct our attention to the proof of this main theorem itself. We remark that Corollary 5.3 confirms an observation we made in Section 3: for $h<1$ the system essentially behaves as an non-modulated ou process, while for $h>1$ the background process plays a role through its deviation matrix $D$.

Proof. Consider the following process:

$$
\begin{equation*}
\mathrm{d} \Phi^{[N, h]}(t):=N^{h / 2-\beta} \sum_{k=1}^{d} \sigma_{k} Z_{k}^{[N]}(t) \mathrm{d} B(t)+N^{-\beta} \sum_{k=1}^{d} \tilde{M}_{k}^{[N, h]}(t) \mathrm{d} L_{k}^{[N]}(t) \tag{14}
\end{equation*}
$$

Clearly, this is a local martingale, as linear combinations preserve the local martingale property and locally bounded, predictable processes integrated with respect to local martingales are themselves local martingales.
By plugging in the definitions of the $M^{[N, h]}$ and $L_{k}^{[N]}$, and applying the relation between $M^{[N, h]}(t)$ and $\hat{M}^{[N, h]}(t)$, we obtain

$$
\begin{aligned}
\mathrm{d} \Phi^{[N, h]}(t) & =\mathrm{d} M^{[N, h]}(t)-\left(N^{h} \alpha_{\infty}-\gamma_{\infty} M^{[N, h]}(t)\right) \mathrm{d} t+N^{-1-\beta} \sum_{j=1}^{d} \sum_{k=1}^{d} D_{j k} \tilde{M}_{k}^{[N]}(t) \mathrm{d} Z_{j}^{[N]}(t) \\
& =\mathrm{d} \hat{M}^{[N, h]}(t)+\gamma_{\infty} \hat{M}^{[N, h]}(t) \mathrm{d} t+N^{-1-\beta} \sum_{j=1}^{d} \sum_{k=1}^{d} D_{j k} \tilde{M}_{k}^{[N, h]}(t) \mathrm{d} Z_{j}^{[N]}(t)
\end{aligned}
$$

We denote the last term by $\mathrm{d} H^{[N, h]}(t)$, and observe that it converges to 0 as $N \rightarrow \infty$ (to this end, recall that $N^{-h} \tilde{M}_{k}^{[N, h]}(t) \rightarrow \alpha_{k}-\gamma_{k} \varrho(t)$ as $N \rightarrow \infty$, and observe that directly from the definition of $\beta$ it follows that $h-1-\beta<0$ ).
We apply the martingale central limit theorem [26, Ch. 7, Thm. 1.4] to the sequence of local martingales $\Phi^{[N, h]}(t)$. As we have that

$$
\mathbb{E} \sup _{0 \leq t \leq T}\left(\Phi^{[N, h]}(t)-\Phi^{[N, h]}(t-)\right) \rightarrow 0
$$

for every $T>0$ as $N \rightarrow \infty$, we must find the predictable quadratic variation $\left\langle\Phi^{[N, h]}\right\rangle_{t}$. From (14),

$$
\mathrm{d}\left\langle\Phi^{[N, h]}\right\rangle_{t}=N^{h-2 \beta} \sum_{k=1}^{d} \sigma_{k}^{2} Z_{k}^{[N]}(t) \mathrm{d} t+N^{-2 \beta} \sum_{j=1}^{d} \sum_{k=1}^{d} \tilde{M}_{j}^{[N, h]}(t) \tilde{M}_{k}^{[N, h]}(t) \mathrm{d}\left\langle L_{j}^{[N]}, L_{k}^{[N]}\right\rangle_{t} .
$$

As a result, $\left\langle\Phi^{[N, h]}\right\rangle_{t}$ consists of two terms, corresponding to the two terms in the previous display. The first of these terms is, as $N \rightarrow \infty$, proportional to $N^{h-2 \beta} \sigma_{\infty}^{2}$ due to the ergodic theorem. The second term requires a bit of additional work. In Lemma B. 1 in Appendix B, we cover the convergence of $N\left\langle L_{j}^{[N]}, L_{k}^{[N]}\right\rangle_{t}$, and we already established the convergence of $N^{-h} \tilde{M}^{[N, h]}(t)$. We now invoke the continuous mapping theorem on the mapping $F$ :

$$
F\left[m_{1}, m_{2}, \ell\right](t):=\int_{0}^{t} m_{1}(s) m_{2}(s) \mathrm{d} \ell(s)
$$

which is indeed continuous for continuous functions $m_{1}, m_{2}, \ell$. It follows that the second term is of the order $N^{2 h-2 \beta-1}$, with the corresponding proportionality constant being equal to

$$
\int_{0}^{t} \sum_{j=1}^{d} \sum_{k=1}^{d}\left(\alpha_{j}-\gamma_{j} \varrho(s)\right)\left(\alpha_{k}-\gamma_{k} \varrho(s)\right)\left(\pi_{j} D_{j k}+\pi_{k} D_{k j}\right) \mathrm{d} s
$$

which we recognize as $V(t)$. The sum of both terms therefore behaves essentially polynomially, with degree

$$
\max \{h-2 \beta, 2 h-2 \beta-1\}=\max \{h, 2 h-1\}-2 \beta=0
$$

the first term contributes if $h \leqslant 1$, and the second term if $h \geqslant 1$. It thus follows that

$$
\left\langle\Phi^{[N, h]}\right\rangle_{t} \rightarrow \sigma_{\infty}^{2} 1_{\{h \leqslant 1\}}+V(t) 1_{\{h \geqslant 1\}}
$$

and as such by the M-CLT that $\Phi^{[N, h]}$ converges weakly to $\Phi$, defined as

$$
\Phi(t):=B\left(\sigma_{\infty}^{2} 1_{\{h \leqslant 1\}}+V(t) 1_{\{h \geqslant 1\}}\right)=\sqrt{\sigma_{\infty}^{2} 1_{\{h \leqslant 1\}}+V(t) 1_{\{h \geqslant 1\}}} B(t)
$$

where $B(t)$ is a standard Brownian motion.
The last part of the proof consists of converting this limiting process of $\Phi^{[N, h]}$ into one for $\hat{M}^{[N, h]}$. To this end, consider

$$
\begin{aligned}
\mathrm{d}\left(e^{\gamma_{\infty} t} \hat{M}^{[N, h]}(t)\right) & =e^{\gamma_{\infty} t} \mathrm{~d} \hat{M}^{[N, h]}(t)+\gamma_{\infty} e^{\gamma_{\infty} t} \hat{M}^{[N, h]}(t) \mathrm{d} t \\
& =e^{\gamma_{\infty} t} \mathrm{~d} \Phi^{[N, h]}(t)+e^{\gamma_{\infty}} \mathrm{d} H^{[N, h]}(t)
\end{aligned}
$$

where we recall that $\mathrm{d} H^{[N, h]}(t)$ vanishes as $N \rightarrow \infty$. From this we see that if $\Phi^{[N, h]}(t)$ converges in distribution, then so does $\hat{M}^{[N, h]}(t)$; moreover, it is clear that its limit is the unique solution of the SDE in the claim of the proof.

## 6 Multiple MMOU processes driven by the same background process

In this section, we consider a single background process $X$, taking as before values in $\{1, \ldots, d\}$, modulating multiple ou processes. Suppose there are $J \in \mathbb{N}$ such processes, with parameters $\left(\boldsymbol{\alpha}^{(1)}, \boldsymbol{\gamma}^{(1)}, \boldsymbol{\sigma}^{(1)}\right)$ up to $\left(\boldsymbol{\alpha}^{(J)}, \boldsymbol{\gamma}^{(J)}, \boldsymbol{\sigma}^{(J)}\right)$. It is further assumed that the ou processes are driven by independent Brownian motions $B_{1}(\cdot) \ldots, B_{J}(\cdot)$. Combining the above, this leads to the $J$ coupled sde s

$$
\mathrm{d} M_{j}(t)=\left(\alpha_{X(t)}^{(j)}-\gamma_{X(t)}^{(j)} M_{j}(t)\right) \mathrm{d} t+\sigma_{X(t)}^{(j)} \mathrm{d} B_{j}(t)
$$

for $j=1, \ldots, J$. We call the process a $J$-mмоu process.
Interestingly, this construction yields $J$ components that have common features, as they react to the same background process, as well as component-specific features, as a consequence of the fact that the driving Brownian motions are independent. This model is particularly useful in settings with multidimensional stochastic processes whose components are affected by the same external factors.
An example of a situation where this idea can be exploited is that of multiple asset prices reacting to the (same) state of the economy, which could be represented by a background process (for instance with two states, that is, alternating between a 'good' and a 'bad' state). In this way the dependence between the individual components can be naturally modeled. In mathematical finance, one of the key challenges is to develop models that incorporate the correlation between the individual components in a sound way. Some proposals were to simplistic, ignoring too many relevant details, while others correspond with models with overly many parameters, with its repercussions in terms of the calibration that needs to be performed.
Another setting in which such a coupling may offer a natural modeling framework is that of a wireless network. Channel conditions may be modeled as alternating between various levels, and users' transmission rates may react in a similar way to these fluctuations.

Many of the results derived in the previous sections, covering the case $J=1$, can be generalized to the situation of $J$-Mmou processes described above. To avoid unnecessary repetition, we restrict ourselves to a few of these extensions. In particular, we present (i) the counterpart of Thm. 2.1, stating that $\boldsymbol{M}(t)$ is, conditionally on the path of the background process, multivariate Normally distributed; (ii) some explicit calculations for the means and (co-)variances for certain special cases; (iii) the generalization of the PDE of Thm. 4.1, (iv) explicit expressions for the steady-state (mixed) moments. Procedures for transient moments, and scaling results (such as a $J$-dimensional cLt) are not included in this paper, but can be developed as in the single-dimensional case.

### 6.1 Conditional Normality

First we condition on the path $(X(s), s \in[0, t])$. It is evident that, under this conditioning, the individual components of $\boldsymbol{M}(t)$ are independent. The following result describes this setting in greater detail.
Proposition 6.1. Define $\Gamma^{(j)}(t):=\int_{0}^{t} \gamma_{X(s)}^{(j)} \mathrm{d} s$, for $j=1, \ldots, J$. Then the $J$-dimensional stochastic process $(\boldsymbol{M}(t))_{t \geqslant 0}$ given by

$$
M^{(j)}(t)=M_{0}^{(j)} e^{-\Gamma^{(j)}(t)}+\int_{0}^{t} e^{-\left(\Gamma^{(j)}(t)-\Gamma^{(j)}(s)\right)} \alpha_{X(s)}^{(j)} \mathrm{d} s+\int_{0}^{t} e^{-\left(\Gamma^{(j)}(t)-\Gamma^{(j)}(s)\right)} \sigma_{X(s)}^{(j)} \mathrm{d} B(s)
$$

is the unique $J$-mmou process with initial condition $\boldsymbol{M}_{0}$.
Conditional on the process $X$, the random vector $\boldsymbol{M}(t)$ has a multivariate Normal distribution with, for $j=1, \ldots, J$, random mean

$$
\mu^{(j)}(t)=M_{0}^{(j)} \exp \left(-\Gamma^{(j)}(t)\right)+\int_{0}^{t} \exp \left(-\left(\Gamma^{(j)}(t)-\Gamma^{(j)}(s)\right)\right) \alpha_{X(s)}^{(j)} \mathrm{d} s
$$

and random covariance $v^{(j, k)}(t)=0$ if $j \neq k$ and

$$
v^{(j, j)}(t)=\int_{0}^{t} \exp \left(-2\left(\Gamma^{(j)}(t)-\Gamma^{(j)}(s)\right)\right)\left(\sigma_{X(s)}^{(j)}\right)^{2} \mathrm{~d} s
$$

### 6.2 Mean and (co-)variance

The mean and (co-)variance of $\boldsymbol{M}(t)$ for $J$-mмои can be computed relying on stochastic integration theory, with a procedure similar to the one relied on in Section 3; we do not include the resulting expressions.
We consider in greater detail the special case that $\gamma_{i}^{(j)} \equiv \gamma^{(j)}$ for all $i \in\{1, \ldots, d\}$ (as in Section 3), because in this situation expressions simplify greatly. The means and variances can be found as in Prop. 2.1; we now point out how to compute the covariance $v_{t}^{(j, k)}:=\operatorname{Cov}\left(M^{(j)}(t), M^{(k)}(t)\right.$ ) (with $j \neq k$ ), relying on the law of total covariance. We write, in self-evident notation,

$$
v_{t}^{(j, k)}=\mathbb{E}\left(\mathbb{C o v}\left(M^{(j)}(t), M^{(k)}(t) \mid X\right)\right)+\mathbb{C o v}\left(\mathbb{E}\left(M^{(j)}(t) \mid X\right), \mathbb{E}\left(M^{(k)}(t) \mid X\right)\right)
$$

The first term obviously cancels (cf. Prop. 6.1), while the second reads

$$
\begin{aligned}
& \frac{1}{\gamma^{(j)}+\gamma^{(k)}}\left(\sum_{i_{1}=1}^{d} \sum_{i_{2}=1}^{d} \alpha_{i_{1}}^{(j)} \alpha_{i_{2}}^{(k)} \int_{0}^{t}\left(e^{-\gamma^{(k)} v}-e^{-\left(\gamma^{(j)}+\gamma^{(k)}\right) t+\gamma^{(j)} v}\right) \pi_{i_{1}}\left(p_{i_{1} i_{2}}(v)-\pi_{i_{2}}\right) \mathrm{d} v\right. \\
&\left.\sum_{i_{1}=1}^{d} \sum_{i_{2}=1}^{d} \alpha_{i_{1}}^{(k)} \alpha_{i_{2}}^{(j)} \int_{0}^{t}\left(e^{-\gamma^{(j)} v}-e^{-\left(\gamma^{(k)}+\gamma^{(j)}\right) t+\gamma^{(k)} v}\right) \pi_{i_{1}}\left(p_{i_{1} i_{2}}(v)-\pi_{i_{2}}\right) \mathrm{d} v\right)
\end{aligned}
$$

We consider two limiting regimes.
$\triangleright$ For $t \rightarrow \infty$, it is readily checked that there is convergence to

$$
\frac{1}{\gamma^{(j)}+\gamma^{(k)}}\left(\left(\boldsymbol{\alpha}^{(j)}\right)^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D\left(\gamma^{(k)}\right) \boldsymbol{\alpha}^{(k)}+\left(\boldsymbol{\alpha}^{(k)}\right)^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D\left(\gamma^{(j)}\right) \boldsymbol{\alpha}^{(j)}\right) .
$$

$\triangleright$ Apply, as before, the scaling $\boldsymbol{\alpha} \mapsto N^{h} \boldsymbol{\alpha}, \boldsymbol{\sigma}^{2} \mapsto N^{h} \boldsymbol{\sigma}^{2}$, and $Q \mapsto N Q$ for some $h>0$. We obtain that the covariance, for $N$ large, behaves as

$$
\left(\frac{1-e^{-\left(\gamma^{(j)}+\gamma^{(k)}\right) t}}{\gamma^{(j)}+\gamma^{(k)}}\right)\left(2 N^{2 h-1}\left(\boldsymbol{\alpha}^{(j)}\right)^{\mathrm{T}} \operatorname{diag}\{\boldsymbol{\pi}\} D \boldsymbol{\alpha}^{(k)}\right)
$$

Example 6.2. We now provide explicit results for $t \rightarrow \infty$ for the case $d=2, J=2$. It can be verified that, with $q_{1}:=q_{12}, q_{2}:=q_{21}$ and $q:=q_{1}+q_{2}$,

$$
D\left(\gamma^{(j)}\right)=\frac{1}{q\left(q+\gamma^{(j)}\right)}\left(\begin{array}{rr}
q_{2} & -q_{2} \\
-q_{1} & q_{1}
\end{array}\right)
$$

It is a matter of elementary calculus to show that the steady-state covariance is

$$
\operatorname{Cov}\left(M_{1}, M_{2}\right)=\frac{1}{\gamma^{(1)}+\gamma^{(2)}} \frac{q_{1} q_{2}}{q^{2}} \frac{2 q+\gamma^{(1)}+\gamma^{(2)}}{\left(q+\gamma^{(1)}\right)\left(q+\gamma^{(2)}\right)}\left(\left(\alpha_{1}^{(2)}-\alpha_{2}^{(2)}\right)\left(\alpha_{1}^{(1)}-\alpha_{2}^{(1)}\right)\right)
$$

whereas, for $j=1,2$,

$$
\mathbb{V a r} M_{j}=\frac{q_{1}\left(\sigma_{2}^{(j)}\right)^{2}+q_{2}\left(\sigma_{1}^{(j)}\right)^{2}}{2 \gamma^{(j)} q}+\frac{1}{\gamma^{(j)}} \frac{q_{1} q_{2}}{q^{2}\left(q+\gamma^{(j)}\right)}\left(\alpha_{1}^{(j)}-\alpha_{2}^{(j)}\right)^{2}
$$

These expressions enable us to compute the correlation coefficient between $M_{1}$ and $M_{2}$. For the special case that $\boldsymbol{\sigma}^{(1)}=\boldsymbol{\sigma}^{(2)}=\mathbf{0}$, we obtain, modulo its sign,

$$
\sqrt{\frac{\gamma^{(1)} \gamma^{(2)}}{\left(q+\gamma^{(1)}\right)\left(q+\gamma^{(2)}\right)}} \frac{2 q+\gamma^{(1)}+\gamma^{(2)}}{\gamma^{(1)}+\gamma^{(2)}}
$$

which can be verified to be smaller than 1 .

### 6.3 Transient behavior: partial differential equations

In order to uniquely characterize the joint distribution of $\boldsymbol{M}(t)$, we now set up a system of partial differential equations for the objects

$$
g_{i}(\boldsymbol{\vartheta}, t):=\mathbb{E}\left(e^{\sum_{j=1}^{J} \vartheta_{j} M^{(j)}(t)} 1\{X(t)=i\}\right)
$$

with $i \in\{1, \ldots, d\}$. Relying on the machinery used when establishing the system of PDE $s$ featuring in Thm. 4.1, we obtain that $\partial \boldsymbol{g}(\boldsymbol{\vartheta}, t) / \partial t$ equals

$$
Q^{\mathrm{T}} \boldsymbol{g}(\boldsymbol{\vartheta}, t)-\sum_{j=1}^{J}\left(\vartheta_{j} \operatorname{diag}\left\{\boldsymbol{\alpha}^{(j)}\right\}-\frac{1}{2} \vartheta_{j}^{2} \operatorname{diag}\left\{\left(\boldsymbol{\sigma}^{(j)}\right)^{2}\right\}\right) \boldsymbol{g}(\boldsymbol{\vartheta}, t)-\sum_{j=1}^{J} \vartheta_{j} \operatorname{diag}\left\{\gamma^{(j)}\right\} \frac{\partial}{\partial \vartheta_{j}} \boldsymbol{g}(\boldsymbol{\vartheta}, t)
$$

### 6.4 Recursive scheme for higher order moments

The above system of PDE s can be used to determine all (transient and stationary) moments related to $J$-mmou. We restrict ourselves to the stationary moments here. Define $\boldsymbol{h}_{\boldsymbol{k}}=\left(h_{1, \boldsymbol{k}}, \ldots, h_{d, \boldsymbol{k}}\right)^{\mathrm{T}}$, where

$$
h_{i, \boldsymbol{k}}:=\mathbb{E}\left((-1)^{\sum_{j=1}^{J} k_{j}}\left(M^{(1)}\right)^{k_{1}} \cdots\left(M^{(J)}\right)^{k_{J}} 1\{X=i\}\right)
$$

Observe that $\boldsymbol{h}_{\mathbf{0}}=\boldsymbol{\pi}$. With techniques similar to those applied earlier, $\boldsymbol{e}_{j} \in \mathbb{R}^{J}$ denoting the $j$-th unit vector, we obtain the recursion

$$
\begin{aligned}
\boldsymbol{h}_{\boldsymbol{k}}= & \left(Q^{\mathrm{T}}-\sum_{j=1}^{J} k_{j} \operatorname{diag}\left\{\boldsymbol{\gamma}^{(j)}\right\}\right)^{-1} \\
& \times\left(\sum_{j=1}^{J} k_{j} \operatorname{diag}\left\{\boldsymbol{\alpha}^{(j)}\right\} \boldsymbol{h}_{\boldsymbol{k}-\boldsymbol{e}_{j}}-\frac{1}{2} \sum_{j=1}^{J} k_{j}\left(k_{j}-1\right) \operatorname{diag}\left\{\left(\boldsymbol{\sigma}^{(j)}\right)^{2}\right\} \boldsymbol{h}_{\boldsymbol{k}-2 \boldsymbol{e}_{j}}\right) .
\end{aligned}
$$

This procedure allows us to compute all mixed moments, thus facilitating the calculation of covariances as well. In the situation of $J=2$, for instance, we find that

$$
\mathbb{E} M^{(1)} M^{(2)}=\mathbf{1}\left(Q^{\mathrm{T}}-\operatorname{diag}\left\{\gamma^{(1)}\right\}-\operatorname{diag}\left\{\gamma^{(2)}\right\}\right)^{-1}\left(\operatorname{diag}\left\{\boldsymbol{\alpha}^{(1)}\right\} \boldsymbol{h}_{0,1}+\operatorname{diag}\left\{\boldsymbol{\alpha}^{(2)}\right\} \boldsymbol{h}_{1,0}\right)
$$

where $\boldsymbol{h}_{0,1}$ and $\boldsymbol{h}_{1,0}$ follow from the analysis presented in Section 5.
Remark 6.3. The model proposed in this section describes a $J$-dimensional stochastic process with dependent components. In many situations, the dimension $d$ can be chosen relatively small (see for instance [6, 18]), whereas $J$ tends to be large (e.g., in the context of asset prices). Importantly, the $\frac{1}{2} J(J+1)=O\left(J^{2}\right)$ entries of the covariance matrix of $\boldsymbol{M}(t)$ (or its stationary counterpart $\boldsymbol{M}$ ) are endogenously determined by the model, and need not be estimated from data. Instead, this approach requires the calibration of just the $d(d-1)$ entries of the $Q$-matrix, as well as the $3 d J$ parameters of the underlying ou processes, totaling $O(J)$ parameters. We conclude that, as a consequence, this framework offers substantial potential advantages.

## 7 Discussion and concluding remarks

This paper has presented a set of results on MMOU, ranging from procedures to compute moments and a PDE for the Fourier-Laplace transform, to weak convergence results under specific scalings and a multivariate extension in which multiple mmou s are modulated by the same background process. Although a relatively large number of aspects is covered, there are many issues that still need to be studied. One such area concerns the large-deviations behavior under specific scalings, so as to obtain the counterparts of the results obtained in e.g. [8, 10, 11] for the Markov-modulated infinite-server queue.
It is further remarked that in this paper we looked at an regime-switching version of the ou process, but of course we could have considered various other processes. One option is the Markov-modulated version of the so-called Cox-Ingersoll-Ross (CIR) process:

$$
\mathrm{d} M(t)=\left(\alpha_{X(t)}-\gamma_{X(t)} M(t)\right) \mathrm{d} t+\sigma_{X(t)} \sqrt{M(t)} \mathrm{d} B(t)
$$

Some results we have established for mмOU have their immediate mmcir counterpart, while for others there are crucial differences. It is relatively straightforward to adapt the procedure used in Section 4.1, to set up a system of PDE s for the Fourier-Laplace transforms (essentially based on Itô's rule). Interestingly, the recursions to generate all moments are now one-step (rather than two-step) recursions. A further objective would be to see to what extent the results of our paper generalize to more general classes of diffusions; see e.g. [21].

## A Existence and basic properties of MMOU

In this appendix we provide background and formal underpinnings of results presented in Section 2. Throughout we work with a given probability space $(\Omega, \mathcal{F}, \mathbb{P})$ on which a random variable $M_{0}$, a standard Brownian motion $B$, and a continuous-time Markov process $X$ with finite state space are defined. It is assumed that $M_{0}, X$ and $B$ are independent. Denote the natural filtrations of $X$ and $B$ by $\left(\mathcal{F}_{t}^{X}\right)_{t \geqslant 0}$ and $\left(\mathcal{F}_{t}^{B}\right)_{t \geqslant 0}$, respectively. As before, the state space of $X$ is $\{1, \ldots, d\}$ for some $d \in \mathbb{N}$, and we let $\alpha_{i} \in \mathbb{R}, \gamma_{i}>0$ and $\sigma_{i} \in \mathbb{R}$ for $i \in\{1, \ldots, d\}$. We start by the definition of mmou, cf. Equation (2).

Definition A.1. A stochastic process $M$ is called an mmou process with initial condition $M_{0}$ if

$$
\begin{equation*}
M(t)=M_{0}+\int_{0}^{t}\left(\alpha_{X(s)}-\gamma_{X(s)} M(s)\right) \mathrm{d} s+\int_{0}^{t} \sigma_{X(s)} \mathrm{d} B(s) \tag{15}
\end{equation*}
$$

for all $t \geq 0$.

To show existence of an mMOU process, we first need a filtration $\left(\mathcal{H}_{t}\right)_{t \geqslant 0}$ that satisfies the usual conditions and with respect to which $X$ is adapted and $B$ is a Brownian motion. Define the multivariate process $Y$ by $Y_{t}=\left(M_{0}, X_{t}, B_{t}\right)$. Its natural filtration is given by $\mathcal{F}_{t}^{Y}=\sigma\left(M_{0}, \mathcal{F}_{t}^{X}, \mathcal{F}_{t}^{B}\right)$. Using the independence assumptions, it is easily verified that $Y$ is a Markov process with respect to $\mathcal{F}_{t}^{Y}$ and that $B$ is a Brownian motion with respect to this filtration. In addition, $Y$ is a Feller process. This is an immediate result of the independence assumptions and the fact that $M_{0}$ (viewed as a stochastic process), $X$ and $B$ are Feller processes.
Now define the augmented filtration $\left(\mathcal{H}_{t}\right)_{t \geqslant 0}$ via $\mathcal{H}_{t}=\sigma\left(\mathcal{F}_{t}^{Y}, \mathcal{N}\right)$, where $\mathcal{N}$ consists of all $F \subset \Omega$ such that there exists $G \in \mathcal{F}_{\infty}^{Y}$ with $F \subset G$ and $\mathbb{P}(G)=0$. Since $Y$ has càdlàg paths, it follows from [29, Prop. III.2.10] that $\left(\mathcal{H}_{t}\right)_{t \geqslant 0}$ satisfies the usual conditions. Relative to this filtration, the process $B$ is a Brownian motion [23, Th. 2.7.9] and $Y$ is a Feller process [23, p. 92].

We now verify in detail the validity of Thm. 2.1. To construct an mmou process, define the stochastic process

$$
\Gamma(t):=\int_{0}^{t} \gamma_{X(s)} \mathrm{d} s
$$

which is clearly adapted to $\left(\mathcal{H}_{t}\right)_{t \geqslant 0}$. The continuous stochastic process

$$
\begin{equation*}
M(t)=M_{0} e^{-\Gamma(t)}+\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \alpha_{X(s)} \mathrm{d} s+\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \sigma_{X(s)} \mathrm{d} B(s) \tag{16}
\end{equation*}
$$

is well defined and adapted to $\left(\mathcal{H}_{t}\right)_{t \geqslant 0}$, too. Using similar techniques as in the construction of ordinary ou (cf. [31, Ch. V.5]), one verifies that $M(t)$ satisfies Equation (15), so the stochastic process $M$, as given by (16), is an mmou process.

Now we would like to know whether a process that satisfies the stochastic differential equation (15) is unique. Of course, uniqueness up to indistinguishability is the strongest form of uniqueness we can get.

We will show that this holds for ммоч. To this end, suppose we have two ммои processes $M^{(1)}$ and $M^{(2)}$, i.e.,

$$
M^{(i)}(t)=M_{0}+\int_{0}^{t}\left(\alpha_{X(s)}-\gamma_{X(s)} M^{(i)}(s)\right) \mathrm{d} s+\int_{0}^{t} \sigma_{X(s)} \mathrm{d} B(s), \quad i \in\{1,2\} .
$$

Then $V(t):=M^{(1)}(t)-M^{(2)}(t)$ satisfies

$$
V(t)=-\int_{0}^{t} \gamma_{X(s)} V(s) \mathrm{d} s
$$

with initial condition $V(0)=0$, on a measurable set $\Omega^{\star}$ that has probability 1 . If $V(t)=0$ for all $t \geq 0$ for every $\omega \in \Omega^{\star}$, then $M^{(1)}$ and $M^{(2)}$ are indistinguishable. This is indeed the case, as a direct consequence of [19, Th. I.5.1] and [19, Th. I.5.3]. Consequently, every mмоu process admits a representation as in Equation (16).

For fixed $t \geq 0$ we would like to know the distribution of $M(t)$. Let, for a given $\Gamma(t), \mu(t)$ and $v(t)$ be given by (3) and (4), respectively. Observe that we may write

$$
M(t)=\mu(t)+\int_{0}^{t} \exp (-(\Gamma(t)-\Gamma(s))) \sigma_{X(s)} \mathrm{d} B(s)
$$

Using the independence assumptions and standard properties of integrals with respect to Brownian motion, it is easily verified that

$$
\begin{aligned}
\mathbb{E}\left[e^{\mathrm{i} \theta M(t)} \mid \mathcal{F}_{\infty}^{X}\right] & =\mathbb{E}\left[\exp \left(\mathrm{i} \theta\left(\mu(t)+\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \sigma_{X(s)} \mathrm{d} B(s)\right)\right) \mid \mathcal{F}_{\infty}^{X}\right] \\
& =e^{\mathrm{i} \theta \mu(t)} \mathbb{E}\left[\exp \left(\mathrm{i} \theta\left(\int_{0}^{t} e^{-(\Gamma(t)-\Gamma(s))} \sigma_{X(s)} \mathrm{d} B(s)\right)\right) \mid \mathcal{F}_{\infty}^{X}\right] \\
& =e^{\mathrm{i} \theta \mu(t)} \exp \left(-\frac{1}{2} \theta^{2} \int_{0}^{t} e^{-2(\Gamma(t)-\Gamma(s))} \sigma_{X(s)}^{2} \mathrm{~d} s\right) \\
& =e^{\mathrm{i} \theta \mu(t)-\frac{1}{2} \theta^{2} v(t)},
\end{aligned}
$$

which implies the Normality claim in Thm. 2.1.

## B Some convergence results for finite Markov chains

In this appendix, we establish a technical result needed in Section 5.
Lemma B.1. As $N \rightarrow \infty$, we have $N\left\langle L_{k}^{[N]}, L_{\ell}^{[N]}\right\rangle_{t} \rightarrow\left(\pi_{l} D_{k \ell}+\pi_{\ell} D_{\ell k}\right) t$.
Proof. By the product rule, we have

$$
N^{-1} \mathrm{~d}\left(Z_{i}^{[N]}(t) Z_{j}^{[N]}(t)\right)=N^{-1} Z_{i}^{[N]}(t) \mathrm{d} Z_{j}^{[N]}(t)+N^{-1} Z_{j}^{[N]}(t) \mathrm{d} Z_{i}^{[N]}(t)+N^{-1} \mathrm{~d}\left[Z_{i}^{[N]}, Z_{j}^{[N]}\right]_{t}
$$

Making use of the fact that $Z_{i}^{[N]}(t) Z_{j}^{[N]}(t)=Z_{i}^{[N]}(t) 1_{\{i=j\}}$ and of formula (13), we obtain after rearranging that

$$
\begin{aligned}
N^{-1} Z_{i}^{[N]}(t) & \mathrm{d} K_{j}^{[N]}(t)+N^{-1} Z_{j}^{[N]}(t) \mathrm{d} K_{i}^{[N]}(t) \\
& =-N^{-1} \mathrm{~d}\left[Z_{i}^{[N]}, Z_{j}^{[N]}\right]_{t}-Z_{i}^{[N]}(t) q_{i j} \mathrm{~d} t-Z_{j}^{[N]}(t) q_{j i} \mathrm{~d} t+N^{-1} \mathrm{~d} Z_{i}^{[N]}(t) 1_{\{i=j\}}
\end{aligned}
$$

Note that the two terms on the left-hand side are local martingales, and as the difference between the optional and the predictable quadratic variation is a local martingale, we can apply the martingale central limit theorem to the local martingale

$$
-N^{-1} \mathrm{~d}\left\langle Z_{i}^{[N]}, Z_{j}^{[N]}\right\rangle_{t}-Z_{i}^{[N]}(t) q_{i j} \mathrm{~d} t-Z_{j}^{[N]}(t) q_{j i} \mathrm{~d} t+N^{-1} \mathrm{~d} Z_{i}^{[N]}(t) 1_{\{i=j\}}
$$

and thus we establish that, as $N \rightarrow \infty$, for $i \neq j$

$$
N^{-1}\left\langle Z_{i}^{[N]}, Z_{j}^{[N]}\right\rangle_{t} \rightarrow-\left(\pi_{i} q_{i j}+\pi_{j} q_{j i}\right) t
$$

it is readily verified that this claim also applies when $i=j$. Then observe that

$$
\mathrm{d}\left\langle L_{k}^{[N]}, L_{\ell}^{[N]}\right\rangle_{t}=N^{-2} \sum_{i=1}^{d} \sum_{j=1}^{d} D_{i k} D_{j \ell} \mathrm{~d}\left\langle Z_{i}^{[N]}, Z_{j}^{[N]}\right\rangle_{t} .
$$

From $Q D=\Pi-I$ it follows that $-\sum_{j=1}^{d} q_{i j} D_{j \ell}=1_{\{i=\ell\}}-\pi_{\ell}$ and $-\sum_{i=1}^{d} q_{j i} D_{i k}=1_{\{j=k\}}-\pi_{k}$, and consequently we have that

$$
-\sum_{i=1}^{d} \sum_{j=1}^{d} D_{i k} D_{j \ell}\left(\pi_{i} q_{i j}+\pi_{j} q_{j i}\right)=\pi_{\ell} D_{\ell k}+\pi_{k} D_{k \ell}
$$

which implies the stated.
