# Unfolding Method for Diffusion Process in a Rarefied Binary Structure.

#### Abstract

The aim of this paper is to study the homogenization of a diffusion process which takes place in a binary structure made by an ambient connected phase surrounding the suspensions (very small particles of diameter of order $\varepsilon \delta$ ) distributed in an $\varepsilon$-periodic network. Using the periodic unfolding method introduced in [4], in the critical case, when $\varepsilon$ and $\delta$ go to 0 we determine the asymptotic behavior of the solution of an evolution problem.

## 1 Introduction

This article is devoted to describing the asymptotic behavior of an evolution problem which governs the diffusion process of a rarefied binary structure. The problem is given by (4.1) with assumptions (4.2)-(4.3) and (5.7). In this problem, the first constant $a_{\varepsilon, \delta}$ represents the mass density of the suspensions while the second one $b_{\varepsilon, \delta}$ is their diffusivity. The parameter $\delta$ is the size order of the suspensions in the reference cell $Y$ and $\varepsilon$ is the periodicity length. The critical case $\lim _{(\varepsilon, \delta) \rightarrow(0,0)} \delta^{N-2} / \varepsilon^{2} \in(0,+\infty)$ is considered.
This problem was first treated in a paper of Bentalha and al. (see [6]) in 2006 . In this article, the authors investigate the case of a diffusivity $b_{\varepsilon, \delta}$ going to infinity, the suspensions being spheres. They use the control zone method. One year later, Gruais (see [7]) study the stationary problem making the assumption $\lim _{(\varepsilon, \delta) \rightarrow(0,0)} b_{\varepsilon, \delta}=\lim _{(\varepsilon, \delta) \rightarrow(0,0)} \delta^{N} a_{\varepsilon, \delta}=1$. She use a multiple scale method. The same year, using again the control zone method Gruais and Poliševski find the limit problem in the case $\lim _{(\varepsilon, \delta) \rightarrow(0,0)} b_{\varepsilon, \delta}<+\infty$ (see [8]).

In the present paper, we revisit the evolution problem (4.1) with the periodic unfolding method introduced in [4], but we focus our attention in the most interesting case: namely the critical case with $\lim _{(\varepsilon, \delta) \rightarrow(0,0)} b_{\varepsilon, \delta} \in(0,+\infty)$ and $\lim _{(\varepsilon, \delta) \rightarrow(0,0)} \delta^{N} a_{\varepsilon, \delta} \in(0,+\infty)$ (see assumptions (5.7)).

The periodic unfolding method is a general tool to study periodic homogenization. Nowadays, this method is used in a lot of new papers since it is a simple way to replace the two-scale convergence by a convergence in a fixed domain: via $\mathcal{T}_{\varepsilon}$ in $\Omega \times Y$ (where $Y$ is the reference periodic cell) or via $\mathcal{T}_{\varepsilon, \delta}$ in $\Omega \times \mathbb{R}^{N}$.

The paper is organized as follows. Section 2 contains the main notations regarding the structure. In Section 3, we recall the definitions of some unfolding operators ( $\mathcal{T}_{\varepsilon}, \mathcal{T}_{\varepsilon, \delta}$ and $\mathcal{M}_{\varepsilon}$ ) and we also recall the main results concerning $\mathcal{T}_{\varepsilon, \delta}$ (Lemmas 3.1 and 3.2.
In Section 4, we present the evolution problem in its variational formulation (4.4). Then, the total energy estimate (4.5) allows to introduce the assumptions on the data (4.6)-(4.7)-(5.8). In Section 5, transforming the solution of the evolution problem with the operator $\mathcal{T}_{\varepsilon, \delta}$ leads to the assumptions on the two small parameters $\varepsilon$ and $\delta$ and on $a_{\varepsilon, \delta}, b_{\varepsilon, \delta}$ (see (5.7)).
Theorem (6.1) in Section 6 gives the unfolded limit problem. Here, it is worth to note that for the first time the limit evolution problem in its variational form is first posed in $\Omega \times \mathbb{R}^{N}$.

In the last section, using the Laplace transform we give the homogenized limit problem (Theorem 7.2). The limit equation differs from the initial one (4.1) regarding the convolution term, this new term accounting for the memory effects is here in fact a "strange term" (see [2]).

## 2 Notations

Let $\Omega$ and $B$ be two bounded domains in $\mathbb{R}^{N}$ with Lipschitz boundary. Denote

- $Y=(-1 / 2,1 / 2)^{N}$ the reference cell,
- $\Omega^{T}=(0, T) \times \Omega$,
- $Y_{\delta}=Y \backslash \delta \bar{B}$,
- $\Xi_{\varepsilon}=\left\{\xi \in \mathbb{Z}^{\mathrm{N}} \mid \varepsilon(\xi+\mathrm{Y}) \subset \Omega\right\}$,
- $\widehat{\Omega}_{\varepsilon}=\operatorname{interior}\left\{\bigcup_{\xi \in \Xi_{\varepsilon}} \varepsilon(\xi+\bar{Y})\right\}, \Lambda_{\varepsilon}=\Omega \backslash \bar{\Omega}_{\varepsilon}$,
- $B_{\varepsilon, \delta}=\Omega \cap \bigcup_{\xi \in \Xi_{\varepsilon}} \varepsilon(\xi+\delta B)$,
- $\Omega_{\varepsilon, \delta}^{*}=\Omega \backslash \overline{B_{\varepsilon, \delta}}$,
- $\mathbf{1}_{\Omega_{\varepsilon, \delta}^{*}}$ is the characteristic function of the set $\Omega_{\varepsilon, \delta}^{*}$.

For a.e $z \in \mathbb{R}^{N}$, one has

where $[z] \in \mathbb{Z}^{\mathrm{N}}$ is the integer part of $z$ while $\{z\} \in Y$ denotes the fractional part of $z$.

## 3 Some recalls on the unfolding operators $\mathcal{T}_{\varepsilon}, \mathcal{M}_{\varepsilon}$ and $\mathcal{T}_{\varepsilon, \delta}$

- For $\phi$ measurable function on $\Omega$, the unfolding operator $\mathcal{T}_{\varepsilon}$ is defined by

The properties of $\mathcal{T}_{\varepsilon}$ are given in [4].

- The local average operator $\mathcal{M}_{\varepsilon}: L^{1}(\Omega) \longrightarrow L^{1}(\Omega)$ is defined as follows:

Below, we recall the main properties of the operator $\mathcal{T}_{\varepsilon, \delta}$ (see Theorem 2.11 of [5]).

## 4 The evolution problem

We consider the evolution problem which governs the diffusion process in our binary mixture

Here $a_{\varepsilon, \delta}$ and $b_{\varepsilon, \delta}$ are strictly positive constants bounded from below independently of $\varepsilon$ and $\delta$. Hence, there exists $c_{0}>0$ such that for any $(\varepsilon, \delta)$

The first constant $a_{\varepsilon, \delta}$ represents the density of mass of the suspensions while the second one is the diffusivity of suspensions.

Lemma 4.1. Problem (4.1) has the following variational formulation:

Proof. The existence and uniqueness of the solution of Problem (4.4) is given by the FaedoGalerkin's method (see e.g. [3] or [9]) which also gives the equality (4.5).

Assumption $A_{2}$. We assume that there exists a constant $C_{0}$, which does not depend on $\varepsilon$ and $\delta$, such that ${ }^{11}$

\leq & e^{T}\left(\left\|\sqrt{\rho_{\varepsilon, \delta}} u_{\varepsilon, \delta}^{0}\right\|_{L^{2}(\Omega)}^{2}+\left\|\frac{1}{\sqrt{\rho_{\varepsilon, \delta}}} f_{\varepsilon, \delta}\right\|_{L^{2}\left(\Omega^{T}\right)}^{2}\right) \leq C_{0} e^{T}
\end{align*}
$$

which in turn leads to $(4.8)_{1}$. Again with (4.6) and (4.10)-(4.11) we get 4.8$)_{2}$. Then, the assumptions (4.3) yield

Proof. From (3.4) and (4.8) we immediately deduce (5.1). From (3.4) ${ }_{2}$ we have

\end{equation*}

Hence

So, the above estimates (5.2) highlight several cases. We will focus our attention on the most interesting one.

Now, as a consequence of Assumptions $A_{1}, A_{2}$ and the estimate 3.4 $_{2}$, the sequences $\left\{\mathcal{T}_{\varepsilon, \delta}\left(u_{\varepsilon, \delta}^{0}\right)\right\}$, $\left\{\delta^{N} \mathcal{T}_{\varepsilon, \delta}\left(f_{\varepsilon, \delta}\right)\right\}$ are bounded respectively in $L^{2}(\Omega \times B), L^{2}\left(\Omega^{T} \times B\right)$.

Assumption $A_{5}$. We assume that there exist $U^{0} \in L^{2}(\Omega \times B)$ and $F \in L^{2}\left(\Omega^{T} \times B\right)$ such that

Lemma 5.2. There exist a subsequence of $(\varepsilon, \delta)$, still denoted $(\varepsilon, \delta)$, and $U \in L^{2}\left(\Omega^{T} ; H_{l o c}^{1}\left(\mathbb{R}^{N}\right)\right)$ with $\nabla_{z} U \in L^{2}\left(\Omega^{T} \times \mathbb{R}^{N}\right)$ such that

\nabla_{z} \mathcal{T}_{\varepsilon, \delta}\left(u_{\varepsilon, \delta}\right) 1_{1 / \delta Y} \rightharpoonup \nabla_{z} V & \text { weakly in } L^{2}\left(\Omega^{T} \times \mathbb{R}^{N}\right)
\end{array}

and we have $U=V+u$.
Proof. From the estimates (5.1)-(5.2), there exist subsequences of $(\varepsilon, \delta)$ such that the convergences (5.9) and (5.10) hold. Convergences $(4.12)_{2}$ and (3.2) yield

\mathbf{L} & =\left\{\Phi \in L^{2}(\Omega ; \mathbf{H}) \mid \Phi(\cdot, \infty) \in H_{0}^{1}(\Omega)\right\} .
\end{align*}

For any $\Phi \in \mathbf{H}$, we know that there exists a constant denoted $\Phi(\infty)$ such that

Denote

Theorem 6.1. Let $u_{\varepsilon, \delta}$ be the solution of the evolution Problem (4.5). For the whole sequence $(\varepsilon, \delta)$ we have the convergences (4.12), (5.9) and (5.10).
The limit function $U$ is the solution of the unfolded evolution problem

& <\frac{d U}{d t}(t, \cdot, \infty), \Phi(\cdot, \infty)>_{H^{-1}(\Omega), H_{0}^{1}(\Omega)}+a_{0}<\frac{d U}{d t}(t), \Phi>_{L^{2}\left(\Omega ;\left(H^{1}(B)\right)^{\prime}\right), L^{2}\left(\Omega ; H^{1}(B)\right)} \\
& +\int_{\Omega} \nabla_{x} U(t, \cdot, \infty) \nabla_{x} \Phi(\cdot, \infty) d x+\gamma_{0} \int_{\Omega \times \mathbb{R}^{N}} k_{0} \nabla_{z} U(t) \nabla_{z} \Phi d x d z  \tag{6.2}\\
& =\int_{\Omega} f(t) \Phi(\cdot, \infty) d x+\int_{\Omega \times B} F(t) \Phi d x d z, \quad \text { for a.e. } t \in(0, T), \quad \forall \Phi \in \mathbf{L}, \\
& U(0, x, \infty)=u^{0}(x), \quad U(0, x, z)=U^{0}(x, z) \quad \text { for a.e. }(x, z) \in \Omega \times B .
\end{align*}
$$

Furthermore U satisfies

+ & \int_{0}^{t} \int_{\Omega}\left|\nabla_{x} U(s, \cdot, \infty)\right|^{2} d s d x+\gamma_{0} \int_{0}^{t} \int_{\Omega \times \mathbb{R}^{N}} k_{0}\left|\nabla_{z} U\right|^{2} d s d x d z \\
= & \int_{0}^{t} \int_{\Omega} f(s) U(s, \cdot, \infty) d s d x+\int_{0}^{t} \int_{\Omega \times B} F(t) U(t) d x d z  \tag{6.3}\\
+ & \frac{1}{2} \int_{\Omega}\left|u^{0}\right|^{2} d x+\frac{a_{0}}{2} \int_{\Omega \times B}\left|U^{0}\right|^{2} d x d z
\end{align*}

Before proving the unfolded limit problem, we introduce and prove three lemmas. The first one concerns a density result, the second one gives a convergence result for functions vanishing in $B_{\varepsilon, \delta}$ and the last one introduces a test function.

Since the open set $B$ is bounded, there exists $\eta_{0}>0$ such that

Step 1. We fix a function $\chi$ in $\mathcal{C}^{\infty}\left(\mathbb{R}^{N}\right)$ satisfying

Since $\chi_{\eta}=1$ on $\partial Y$, the function $\phi_{\eta}$ belongs to $H_{p e r}^{1}(Y)$. We have $\phi_{\eta}=\phi$ on $Y \backslash 2 \bar{B}$ and $\nabla \phi_{\eta}=\nabla \phi \chi_{\eta}+\nabla \chi_{\eta} \phi$. Hence

Since $\phi$ belongs to $\mathcal{C}_{\text {per }}^{\infty}(\bar{Y})$ and the measure of $\eta B$ goes to zero, one obtains the strong convergence of $\phi_{\eta}$ to $\phi$ in $H_{p e r}^{1}(Y)$.
Step 2. Let $\psi$ be in $H_{p e r}^{1}(Y)$. The space $\mathcal{C}_{\text {per }}^{\infty}(\bar{Y})$ is dense in $H_{p e r}^{1}(Y)$. Hence for any $\varepsilon>0$ there exists $\varphi \in \mathcal{C}_{p e r}^{\infty}(\bar{Y})$ such that

Step 2. We prove (6.7) for $w \in L^{p}(\Omega)$.
Let $w$ be in $L^{p}(\Omega)$. Since $\mathcal{C}(\bar{\Omega})$ is dense in $L^{p}(\Omega), p \in[1, \infty)$, for any $\varepsilon_{1}>0$ there exists $W \in \mathcal{C}(\bar{\Omega})$ suth that

The function $\psi_{\varepsilon, \delta}$ belongs to $\mathcal{C}^{\infty}(\bar{\Omega})$ and

\psi_{\varepsilon, \delta} \longrightarrow \psi(\infty) \quad \text { strongly in } L^{2}(\Omega) \tag{6.10}
\end{equation*}
$$

Proof. There exists $R>0$ such that the support of $\nabla_{z} \psi$ is included in the ball $B(O ; R)$. For $\delta$ small enough $B(O ; \delta R) \subset Y$. We perform a change of variables and we use the fact that $\psi-\psi(\infty)$ belongs to $H_{0}^{1}(B(O ; R))$. That gives

& \leq C(\varepsilon \delta)^{N} R^{2} \int_{B(O ; R)}\left|\nabla_{z} \psi(z)\right|^{2} d z
\end{aligned}

The constant does not depend on $\varepsilon$ and $\delta$. Summing over $\Xi_{\varepsilon}$ yields

\int_{\Omega}\left|\psi_{\varepsilon, \delta}(x)-\psi(\infty)\right|^{2} d x=\sum_{\xi \in \Xi_{\varepsilon}} \int_{\varepsilon \xi+\varepsilon Y}\left|\psi_{\varepsilon, \delta}(x)-\psi(\infty)\right|^{2} d x \leq C \delta^{N}\left\|\nabla_{z} \psi\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2}
$$

Hence, we get the strong convergence (6.10).
Proof of Theorem 6.1. First observe that Problem (6.2) has a unique solution $U$ belonging to $L^{2}(0, T ; \mathbf{L})$. It is a consequence of the Faedo-Galerkin's method which also gives the equality (6.3). This will imply the convergence of the full sequences in (4.12), (5.9) and (5.10). It is therefore enough to obtain the limit Problem (6.2) for a subsequence, which we do below.

The aim of the three first steps is to obtain the variational formulation (6.20) of the limit problem. Then, in the last step we prove that $U(\cdot, \cdot, \infty) \in H^{1}\left(0, T ; H^{-1}(\Omega)\right)$ and $U \in H^{1}\left(0, T ; L^{2}\left(\Omega ;\left(H^{1}(B)\right)^{\prime}\right)\right)$.
Step 1. Let $(\phi, w)$ be in $\mathcal{C}^{1}([0, T]) \times \mathcal{D}(\Omega)$ such that $\phi(T)=0$. Taking $\phi(t) w(x)$ as test function in (4.4) and then integrating by parts lead to

Now, let $(\phi, w)$ be in $C^{1}([0, T]) \times \mathcal{D}(\Omega)$ such that $\phi(T)=0$ and let $\psi \in \mathbf{H} \cap C^{\infty}\left(\mathbb{R}^{N}\right)$ such that the support of $\nabla_{z} \psi$ is bounded. In (4.4) we take as test function $\phi(t) w(x) \psi_{\varepsilon, \delta}(x)$, where $\psi_{\varepsilon, \delta}$ is given by (6.9).

If $\delta$ is small enough the function $\psi_{\varepsilon, \delta}$ is constant (and equal to $\psi(\infty)$ ) on the boundary of the cells $\varepsilon \xi+\varepsilon Y\left(\xi \in \Xi_{\varepsilon}\right)$. Now, let $\Phi$ be in $H_{0}^{1}\left(0, T ; L^{2}\left(\Omega ; H^{1}(B)\right)\right)$ we extend $\Phi$ as a function $\bar{\Phi}$ belonging to $H_{0}^{1}\left(0, T ; L^{2}\left(\Omega ; H^{1}\left(\mathbb{R}^{N}\right)\right)\right)$ satisfying

## 7 The homogenized limit problem

From now on, we extend $f$ and $F$ by zero on $[T,+\infty[$.
For any $\phi \in L^{2}(0,+\infty)$ and for any $p \in \mathbb{R}_{+}^{*}$, the Laplace transform (see e.g. [10], [11] or [12]) is defined by

+ & \int_{\Omega} u^{0}(x) \Phi(x, \infty) d x+a_{0} \int_{\Omega \times B} U^{0}(x, z) \Phi(x, z) d x d z, \quad \forall p>0, \quad \forall \Phi \in \mathbf{L} .

For any $p>0$, the Lax-Milgram theorem gives the existence and uniqueness of $\widehat{U}(p) \in \mathbf{L}$. The following estimates hold:

& \leq \frac{C}{p}\left(\|\widehat{f}(p)\|_{L^{2}(\Omega)}^{2}+\|\widehat{F}(p)\|_{L^{2}(\Omega \times B)}^{2}+\left\|u^{0}\right\|_{L^{2}(\Omega)}^{2}+\left\|U^{0}\right\|_{L^{2}(\Omega \times B)}^{2}\right), \quad \forall p>0
\end{aligned}
$$

The constant does not depend on $p$. We recall that

$$
\forall p>0, \quad\|\widehat{f}(p)\|_{L^{2}(\Omega)}^{2} \leq \frac{1}{p}\|f\|_{L^{2}\left(\Omega^{T}\right)}^{2}, \quad\|\widehat{F}(p)\|_{L^{2}(\Omega \times B)}^{2} \leq \frac{1}{p}\|F\|_{L^{2}\left(\Omega^{T} \times B\right)}^{2}
$$

Now, let us introduce the solutions $\widehat{\theta}_{0}$ and $\widehat{\theta}_{1}$ of the following cell problems:

$$
\begin{align*}
& \widehat{\theta}_{0}(p) \in L^{2}\left(\Omega ; \dot{H}^{1}\left(\mathbb{R}^{N}\right)\right), \\
& a_{0} p \int_{B} \widehat{\theta}_{0}(p, x) \Phi d z+\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \widehat{\theta}_{0}(p, x) \nabla_{z} \Phi d z  \tag{7.2}\\
= & \int_{B} \widehat{F}(p, x) \Phi d z+a_{0} \int_{B} U^{0}(x, z) \Phi d x d z, \\
& \text { for a.e. } x \in \Omega, \quad \forall \Phi \in \dot{H}^{1}\left(\mathbb{R}^{N}\right), \quad \forall p>0,
\end{align*}
$$

and

$$
\begin{align*}
& \widehat{\theta}_{1}(p) \in \mathbf{H}, \quad \widehat{\theta}_{1}(p, \infty)=1 \\
& a_{0} p \int_{B} \widehat{\theta}_{1}(p) \Phi d z+\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \widehat{\theta}_{1}(p) \nabla_{z} \Phi d z=0,  \tag{7.3}\\
& \forall \Phi \in \dot{H}^{1}\left(\mathbb{R}^{N}\right), \quad \forall p>0
\end{align*}
$$

Again, the Lax-Milgram theorem gives the existence of $\widehat{\theta}_{0}, \widehat{\theta}_{1}$ and

$$
p\left\|\widehat{\theta}_{0}(p)\right\|_{L^{2}(\Omega \times B)}^{2}+\left\|\nabla_{z} \widehat{\theta}_{0}(p)\right\|_{L^{2}\left(\Omega \times \mathbb{R}^{N}\right)}^{2} \leq \frac{C}{p}\left(\|\widehat{F}(p)\|_{L^{2}(\Omega \times B)}^{2}+\left\|U^{0}\right\|_{L^{2}(\Omega \times B)}^{2}\right) \quad \forall p>0
$$

Now, in order to estimate $\widehat{\theta}_{1}$ we consider a function $\vartheta \in \mathbf{H} \cap \mathcal{C}^{\infty}\left(\mathbb{R}^{N}\right)$ satisfying

$$
\begin{equation*}
\vartheta(\infty)=1, \quad \vartheta=0 \quad \text { in } B, \quad \nabla_{z} \vartheta \text { has a compact support. } \tag{7.4}
\end{equation*}
$$

The function $\widehat{\theta}_{2}=\widehat{\theta}_{1}-\vartheta$ is the solution of

$$
\begin{align*}
& \widehat{\theta}_{2}(p) \in \dot{H}^{1}\left(\mathbb{R}^{N}\right), \\
& a_{0} p \int_{B} \widehat{\theta}_{2}(p) \Phi d z+\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \widehat{\theta}_{2}(p) \nabla_{z} \Phi d z  \tag{7.5}\\
= & -\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \vartheta \nabla_{z} \Phi d z=\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \Delta_{z} \vartheta \Phi d z, \\
& \forall \Phi \in \dot{H}^{1}\left(\mathbb{R}^{N}\right), \quad \forall p>0 .
\end{align*}
$$

Then, taking $\widehat{\theta}_{2}(p)$ has test function in (7.5) leads to

$$
p\left\|\widehat{\theta}_{2}(p)\right\|_{L^{2}(B)}^{2}+\left\|\nabla_{z} \widehat{\theta}_{2}(p)\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2} \leq \frac{C}{p}\left\|\Delta_{z} \vartheta\right\|_{L^{2}\left(\mathbb{R}^{N}\right)}^{2}, \quad \forall p>0
$$

We express $\widehat{U}(p)$ in terms of $\widehat{\theta}_{0}(p), \widehat{\theta}_{2}(p), \vartheta$ and $\widehat{u}(p)$. To do that, observe that the Laplace transform $\widehat{u}(p)$ of $u$ is in fact $\widehat{U}(p, \cdot, \infty)$. Hence, we have

$$
\widehat{U}(p, x, z)=\widehat{u}(p, x) \widehat{\theta}_{1}(p, z)+\widehat{\theta}_{0}(p, x, z)=\widehat{u}(p, x) \widehat{\theta}_{2}(p, z)+\widehat{\theta}_{0}(p, x, z)+\widehat{u}(p, x) \vartheta(z)
$$

$$
\text { for a.e. }(x, z) \in \Omega \times \mathbb{R}^{N}, \quad \forall p>0
$$

Let $\psi$ be in $H_{0}^{1}(\Omega)$, we choose $\psi$ as test-function in (7.1). That gives

$$
\begin{align*}
& p \int_{\Omega} \widehat{u}(p) \psi d x+a_{0} p \int_{\Omega}\left(\int_{B} \widehat{\theta}_{2}(p, z) d z\right) \widehat{u}(p) \psi d x \\
+ & a_{0} p \int_{\Omega}\left(\int_{B} \widehat{\theta}_{0}(p, \cdot, z) d z\right) \psi d x+\int_{\Omega} \nabla \widehat{u}(p) \nabla \psi d x \\
= & \int_{\Omega}\left(\widehat{f}(p)+u^{0}\right) \psi d x+\int_{\Omega}\left(\int_{B} \widehat{F}(p, \cdot, z) d z\right) \psi d x  \tag{7.6}\\
+ & a_{0} \int_{\Omega}\left(\int_{B} U^{0}(\cdot, z) d z\right) \psi d x .
\end{align*}
$$

Now, applying the inverse Laplace transform (see [1], [10] and [11]) in Problems (7.2), (7.3) and (7.6) give

$$
\begin{align*}
& \theta_{0} \in H^{1}\left(0, T ; L^{2}\left(\Omega ;\left(H^{1}(B)\right)^{\prime}\right)\right), \quad \theta_{0} \in L^{2}\left(\Omega^{T} ; \dot{H}^{1}\left(\mathbb{R}^{N}\right)\right), \\
& a_{0}<\frac{d \theta_{0}}{d t}(t, x), \Phi>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)}+\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \theta_{0}(t, x) \nabla_{z} \Phi d z  \tag{7.7}\\
= & \int_{B} F(t, x) \Phi d z, \text { for a.e. }(t, x) \in(0,+\infty) \times \Omega, \\
& \theta_{0}(0)=U^{0}, \quad \forall \Phi \in \dot{H}^{1}\left(\mathbb{R}^{N}\right),
\end{align*}
$$

$\theta_{2}$ is the solution of the following evolution problem:

$$
\begin{align*}
& \theta_{2} \in H^{1}\left(0, T ;\left(H^{1}(B)\right)^{\prime}\right), \quad \theta_{2} \in L^{2}\left(0, T ; \dot{H}^{1}\left(\mathbb{R}^{N}\right)\right), \\
& a_{0}<\frac{d \theta_{2}}{d t}(t), \Phi>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)}+\gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \theta_{2}(t) \nabla_{z} \Phi d z=0,  \tag{7.8}\\
& \theta_{2}(0)=\frac{\gamma_{0} k_{0}}{a_{0}} \Delta_{z} \vartheta, \text { for a.e. } t \in(0,+\infty), \quad \forall \Phi \in \dot{H}^{1}\left(\mathbb{R}^{N}\right) .
\end{align*}
$$

Here again, the Faedo-Galerkin's method gives the existence and uniqueness of the solutions of the two above evolution equations. Proceeding as in Theorem 6.1 we show that $\theta_{0} \in$ $H^{1}\left(0, T ; L^{2}\left(\Omega ;\left(H^{1}(B)\right)^{\prime}\right)\right)$ and $\theta_{2} \in H^{1}\left(0, T ;\left(H^{1}(B)\right)^{\prime}\right)$.

Lemma 7.1. $\mathrm{Se} t$

$$
\Theta_{0}=\int_{B} \theta_{0} d z, \quad \Theta_{2}=\int_{B} \theta_{2} d z
$$

We have

$$
\Theta_{0} \in H^{1}\left(0, T ; L^{2}(\Omega)\right), \quad \Theta_{2} \in H^{1}(0, T)
$$

Moreover, the function $\Theta_{2}$ does not depend on the choice of the function $\vartheta$.
Proof. Since $\theta_{0} \in L^{2}\left(\Omega^{T} \times B\right)$ we obtain $\Theta_{0} \in L^{2}\left(\Omega^{T}\right)$ (as a consequence of the CauchySchwarz inequality and the Fubini's theorem). Choosing $1-\vartheta$ as test function in 7.7) (observe
that $1-\vartheta \in \dot{H}^{1}\left(\mathbb{R}^{N}\right)$ ) gives

$$
\begin{align*}
& a_{0} \frac{d}{d t}\left(<\theta_{0}(t, x), 1>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)}\right)=a_{0}<\frac{d \theta_{0}}{d t}(t, x), 1>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)} \\
= & a_{0}<\frac{d \theta_{0}}{d t}(t, x), 1-\vartheta>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)}  \tag{7.9}\\
= & \gamma_{0} \int_{\mathbb{R}^{N}} k_{0} \nabla_{z} \theta_{0}(t, x) \nabla_{z} \vartheta d z+\int_{B} F(t, x) d z .
\end{align*}
$$

Now, the fact that

- $<\theta_{0}(t, x), 1>_{\left(H^{1}(B)\right)^{\prime}, H^{1}(B)}=\int_{B} \theta_{0}(t, x) d z$ for a.e. $x \in \Omega$,
- $\nabla_{z} \theta_{0} \in\left[L^{2}\left(\Omega^{T} \times \mathbb{R}^{N}\right)\right]^{N}$,
- $\nabla_{z} \vartheta \in\left[\mathcal{C}^{\infty}\left(\mathbb{R}^{N}\right)\right]^{N}$ (with compact support)
- $F \in L^{2}\left(\Omega^{T} \times B\right)$
and the above equalities (7.9) yield $\frac{d \Theta_{0}}{d t} \in L^{2}\left(\Omega^{T}\right)$. As a consequence $\Theta_{0}$ belongs to $H^{1}\left(0, T ; L^{2}(\Omega)\right)$. Proceeding in the same way gives $\Theta_{2} \in H^{1}(0, T)$.

Denote $\widehat{\Theta}_{2}$ the Laplace transform of $\Theta_{2}$. One has

$$
\widehat{\Theta}_{2}=\int_{B} \widehat{\theta}_{2} d z=\int_{B}\left(\widehat{\theta}_{1}-\vartheta\right) d z=\int_{B} \widehat{\theta}_{1} d z
$$

It follows that $\Theta_{2}$ does not depend of the choice of $\vartheta$.
We transform Problem (7.6) by the inverse Laplace transform, that gives

$$
\begin{align*}
& <\frac{d}{d t}\left(u+a_{0} \Theta_{2} * u\right), \psi>_{H^{-1}(\Omega), H_{0}^{1}(\Omega)}+\int_{\Omega} \nabla u(t) \nabla \psi d x \\
& =-a_{0}<\frac{d \Theta_{0}}{d t}(t), \psi>_{H^{-1}(\Omega), H_{0}^{1}(\Omega)}+\int_{\Omega} f(t) \psi d x,+a_{0} \int_{\Omega}\left(\int_{B} F(t) d z\right) \psi d x  \tag{7.10}\\
& u(0)=u^{0}, \Theta_{0}(0)=\int_{B} U^{0} d z, \quad \text { for a.e. } t \in(0,+\infty), \quad \forall \psi \in H_{0}^{1}(\Omega) .
\end{align*}
$$

Finally, we obtain
Theorem 7.2. The limit field $u$ is the solution of the following evolution problem:

$$
\begin{array}{ll}
u \in L^{2}\left(0, T ; H_{0}^{1}(\Omega)\right) \cap L^{\infty}\left(0, T ; L^{2}(\Omega)\right) \cap H^{1}\left(0, T ; H^{-1}(\Omega)\right), \\
\frac{d}{d t}\left(u+a_{0} \Theta_{2} * u\right)-\Delta u=-a_{0} \frac{d \Theta_{0}}{d t}+G & \text { in } \Omega^{T},  \tag{7.11}\\
u=0 & \text { on } \partial \Omega \times(0, T), \\
u(0)=u^{0} & \text { in } \Omega,
\end{array}
$$

where

- $\Theta_{2}=\int_{B} \theta_{2} d z$ belongs to $H^{1}(0, T)$, the function $\theta_{2}$ being the solution of (7.8),
- $G(t)=f(t)+\int_{B} F(t, \cdot, z) d z$ belongs to $L^{2}\left(\Omega^{T}\right)$,
- $\Theta_{0}=\int_{B} \theta_{0} d z$ belongs to $H^{1}\left(0, T ; L^{2}(\Omega)\right)$, the function $\theta_{0}$ being the solution of (7.7).

[^1]:    ${ }^{2}$ Recall that the space $\dot{H}^{1}\left(\mathbb{R}^{N}\right)$ is the completion of $\mathcal{D}\left(\mathbb{R}^{N}\right)$ for the norm $\|\nabla \phi\|_{L^{2}\left(\mathbb{R}^{N}\right)}$. The Sobolev imbedding theorem implies that for $N \geq 3$, it is a subspace of $L^{2^{*}}\left(\mathbb{R}^{N}\right)$, where $2^{*}$ is the Sobolev exponent associated to 2 . Therefore, all its elements admit 0 as limit at $\infty$ of $\mathbb{R}^{N}$ (in the weak sense of $L^{2^{*}}\left(\mathbb{R}^{N}\right)$ ).
