LOCAL INCOMPRESSIBILITY ESTIMATES FOR THE LAUGHLIN PHASE

ELLIOTT H. LIEB, NICOLAS ROUGERIE, AND JAKOB YNGVASON

ABSTRACT. We prove sharp density upper bounds on optimal length-scales for the ground states of classical 2D Coulomb systems and generalizations thereof. Our method is new, based on an auxiliary Thomas-Fermi-like variational model. Moreover, we deduce density upper bounds for the related low-temperature Gibbs states. Our motivation comes from fractional quantum Hall physics, more precisely, the perturbation of the Laughlin state by external potentials or impurities. These give rise to a class of many-body wave-functions that have the form of a product of the Laughlin state and an analytic function of many variables. This class is related via Laughlin's plasma analogy to Gibbs states of the generalized classical Coulomb systems we consider. Our main result shows that the perturbation of the Laughlin state cannot increase the particle density anywhere, with implications for the response of FQHE systems to external perturbations.

1. INTRODUCTION

The fractional quantum Hall effect (FQHE) [24, 28, 32, 64] is a remarkable feature of the transport properties of 2D electron gases under strong perpendicular magnetic fields and at low temperatures. Soon after its experimental discovery [66], it was recognized in the seminal works of Laughlin [30, 31] that the origin of the effect lies in the emergence of a new, strongly correlated, phase of matter. The latter has been argued to host elementary excitations with fractional charge, a fact that was later experimentally confirmed [60, 20, 45]. Even more fascinating, but still lacking an experimental confirmation, is the possibility that these excitations (quasi-particles) are anyons [6, 68, 43], i.e. have quantum statistics different from those of bosons and fermions, the only known types of fundamental particles. Due to these exciting prospects, it is an ongoing quest in condensed matter physics to generalize FQHE physics to other, more flexible, contexts than the 2D electron gas [47, 9, 19, 11, 67].

One of the distinctive features of strongly correlated FQH states is that they are incompressible liquids, rendering them very robust against perturbations and external fields. Incompressibility, in the form relevant to the FQHE, has in fact two aspects:

1. The proposed strongly correlated FQHE wave functions are approximate ground states for the many-body Hamiltonian of the system at hand. Their energy is separated from the rest of the spectrum by a gap independent of volume and particle number.

2. Modifications of model FQHE ground states that stay within the (highly degenerate) ground eigenspace of the many-body Hamiltonian cannot increase the local one-particle density beyond a fixed value.

These two aspects are very non-trivial to check, particularly since we are talking about strongly correlated states of matter for which mean-field descriptions in terms of independent particles are not adequate. The main evidence so far in favor of Properties 1 and 2 has been experimental and numerical and it remains an important theoretical challenge to improve on this.

The main paradigms of the FQHE are encoded in Laughlin's wave-function, the simplest FQH state:

$$\Psi_{\text{Lau}}(z_1, \dots, z_N) = c_{\text{Lau}} \prod_{i < j} (z_i - z_j)^{\ell} e^{-B \sum_{i=1}^N |z_i|^2/4}.$$
 (1.1)

Here $z_1, \ldots, z_N \in \mathbb{C}$ are the positions of N particles moving in \mathbb{R}^2 , identified with the complex plane, and the constant c_{Lau} is a normalization factor (setting the L^2 -norm equal to 1). For fermions, ℓ is odd and ≥ 3 (the case $\ell = 1$ corresponds to noninteracting fermions), while for bosons $\ell \geq 2$ is even. The function (1.1) has originally been proposed as a variational ansatz for the ground state of the many-body magnetic Schrödinger Hamiltonian¹

$$H_N^{\rm QM} = \sum_{j=1}^N \left[\left(-i\nabla_j - \frac{B}{2} x_j^{\perp} \right)^2 + V(x_j) \right] + \sum_{1 \le i < j \le N} w(x_i - x_j)$$
(1.2)

acting on $L^2(\mathbb{R}^{2N})$, the Hilbert space for N 2D particles. To arrive at an ansatz of the form (1.1) one assumes that the energy scales are set, in order of importance, by

- the strength B (set equal to 2 in the sequel) of a constant applied magnetic field perpendicular to the plane,
- the *repulsive* pair-interaction potential w,
- the external scalar potential V, representing trapping and/or disorder.

Since the magnetic field is the main player, the first reduction is to replace the state space $L^2(\mathbb{R}^{2N}) \simeq \bigotimes^N L^2(\mathbb{R}^2)$ by $\bigotimes^N \mathfrak{H}$ where (z is the complex coordinate in the plane)

$$\mathfrak{H} = \left\{ \psi(z) = f(z)e^{-|z|^2/2} \in L^2(\mathbb{R}^2) \mid f \text{ analytic } \right\}$$
(1.3)

is the lowest Landau level (LLL), ground eigenspace of the magnetic Laplacian $\left(-i\nabla - \frac{B}{2}x^{\perp}\right)^2$. In other words, one reduces available one-body orbitals to those minimizing the magnetic kinetic energy. Spins are all aligned with the external magnetic field so that one only needs consider symmetric/antisymmetric wave-functions of $\bigotimes^N \mathfrak{H}$ to describe bosons/fermions.

Next, the first desire of the repulsive interactions is to make the many-body wavefunction of the system vanish when two particles meet. Combined with the regularity of the LLL orbitals, this forces the inclusion of Jastrow factors $(z_i - z_j)^{\ell}, \ell \in \mathbb{N}$ in the wave-function, leading to (1.1). The integer ℓ is chosen to accomodate symmetry (the wave-function must be symmetric/antisymmetric under coordinates exchanges $z_i \leftrightarrow z_j$ to describe bosons/fermions) and to fix the filling factor (number of particles per magnetic flux quantum) equal to $1/\ell$, thus leaving, in fact, no free variational parameter in the ansatz.

Finally, it is argued that the proposed form is sufficiently robust that it is relevant as an approximate ground state for a large class of repulsive interaction potentials w and (sufficiently weak) external potentials V. It is this alleged robustness that the incompressibility notion refers to.

A possible mathematical formulation of Property 1 is to consider a model pair-potential w whose projection to the N-body LLL has (1.1) as an exact zero-energy ground-state [25, 65, 46]. The claim would then be that the next energy level is bounded below, independently of N. This problem has remained open so far, see [38, 56] for further discussion.

Property 2 is the main subject of the present contribution. To formulate it properly, we note that the arguments leading to choosing (1.1) as a variational ansatz in fact leave the possibility to choose any L^2 -normalized function of the form

$$\Psi_F(z_1,\ldots,z_N) = F(z_1,\ldots,z_N)\Psi_{\text{Lau}}(z_1,\ldots,z_N)$$
(1.4)

with F analytic and symmetric under exchange of the z_i . This form exhausts the class of functions that minimize the magnetic kinetic energy and at the same time avoid repulsive interactions by vanishing at least as $(z_i - z_j)^{\ell}$ as z_i and z_j come together. In the bosonic case and with $\ell = 2$ these are exactly the ground states of the contact interaction [56, Section 2.1]. A natural guess is to assume that the interaction energy is rendered negligible by restricting admissible wave-functions to (1.4). For this reason we shall refer to the class of states of the form (1.4) as *fully correlated states*, with the understanding that adding more correlations to those contained in Ψ_{Lau} to the wave-function cannot further reduce the interaction energy. The first reason to restrict attention to the Laughlin state (1.1) is that, amongst fullycorrelated states, it is the only one that has a filling factor exactly equal to $1/\ell$. But, more generally, a distinctive and crucial feature of the FQHE is that it is very robust against small variations of the filling factor, and the addition of an essentially arbitrary weak external potential V. The origin of this rigidity is what we refer to as Property 2. Denote

$$\rho_F(z) = N \int_{\mathbb{R}^{2(N-1)}} |\Psi_F(z, z_2, \dots, z_N)|^2 dz_2 \dots dz_N$$
(1.5)

the one-particle density of a state of the form (1.4). One can argue [30] and in fact prove rigorously [55, 56] that the Laughlin state has an essentially constant one-particle density of value $1/(\pi \ell)$ in the disk $D(0, \sqrt{\pi \ell N})$, quickly dropping to 0 outside of the disk. Property **2** can then roughly be formulated as

$$\rho_F \lessapprox \frac{1}{\pi \ell} \text{ for any state of the form (1.4).}$$
(1.6)

Some care has to be taken in formulating this rigorously for, in view of existing numerical simulations [17, 18], the symbol \leq above cannot actually stand for a microscopic pointwise bound. In this paper we improve and generalize results of [57, 58] (see also [53, Chapter 3] for further discussion) by proving that (1.6) holds in the sense of local averages over length scales $\gg N^{1/4}$, which is much smaller than the extension of the Laughlin state itself, of order $N^{1/2}$. In view of recent results [7, 33] applying to the pure Laughlin state F = 1, it is natural to conjecture that (1.6) in fact holds on any length scale $\gg 1$.

The significance of our result for the robustness of the Laughlin state against perturbations by external fields is that it forbids a fully-correlated state to accommodate variations of an external potential by accumulating mass in energetically favorables places. Combining with constructions and estimates from [55, 56], it follows that, if the one-body potential V is radial-increasing or Mexican-hat-like, the minimum potential energy amongst fullycorrelated states (1.4) can be asymptotically attained using simpler states of the form

$$\Psi_f(z_1, \dots, z_N) = \Psi_{\text{Lau}}(z_1, \dots, z_N) \prod_{j=1}^N f(z_j)$$
(1.7)

with f an analytic function of a single variable. We conjecture that the same holds for essentially any external potential V. Physically, this means that it is never favorable to add more correlations to the Laughlin state in order to accommodate an external potential, provided the latter is weak enough so that it does not make the ground state jump across the energy gap assumed in Property 1. If f in (1.7) is a polynomial one can write

$$f(z) = \prod_{j=1}^{J} (z - a_j)$$
(1.8)

and the parameters $a_j \in \mathbb{C}$ are interpreted as the locations of quasi-holes, each carrying a charge $1/\ell$. If the locations a_1, \ldots, a_J of the quasi-holes are treated quantum-mechanically instead of classically as above, one should expect that they behave as anyons [6, 43, 68] with statistics parameter $-1/\ell$. From Laughlin's original picture [30, 31] and experimental confirmations thereof [45], one expects that in the presence of a disorder potential, the

response of the Laughlin state is simply to generate such quasi-holes. Our results can be interpreted as a step towards a rigorous proof of this fact, which remains an open problem.

In the next section we state our main results precisely and discuss them further (they were announced in the note [41]). The rest of the paper is devoted to their proofs.

2. Main results

2.1. Universal density bounds. As discussed in the introduction (see also [57, 58]), we assume that the magnetic field and repulsive interactions are strong enough, so that the ground state of the system has the form (1.4). We aim at proving that there is a universal upper bound to the local density of all such states, on scales much smaller than the total size of the system. Thus, let

$$\Psi_{\text{Lau}}(z_1, \dots, z_N) = c_{\text{Lau}} \prod_{i < j} (z_i - z_j)^{\ell} e^{-\sum_{i=1}^N |z_i|^2/2}$$
(2.1)

be the L^2 -normalized Laughlin function with exponent $\ell \in \mathbb{N}$, in units where the magnetic length is $1/\sqrt{2}$. As previously explained we consider analytic perturbations thereof:

$$\mathcal{L}_{\ell}^{N} = \left\{ \Psi_{F} = F(z_{1}, \dots, z_{N}) \Psi_{\text{Lau}} \mid F \text{ analytic and symmetric, } \|\Psi_{F}\|_{L^{2}(\mathbb{R}^{2N})} = 1 \right\}.$$
(2.2)

For a function $\Psi_F \in \mathcal{L}_{\ell}^N$ we denote by

$$\rho_F(z) = N \int_{\mathbb{R}^{2(N-1)}} |\Psi_F(z, z_2, \dots, z_N)|^2 dz_2 \dots dz_N$$
(2.3)

the associated one-particle density. Our main result is a universal upper bound on ρ_F , holding on mesoscopic length scales:

Theorem 2.1 (Rigidity bound for fully-correlated states).

For any $\alpha > 1/4$, any disk D of radius N^{α} and any (sequence of) states $\Psi_F \in \mathcal{L}_{\ell}$ we have

$$\int_{D} \rho_F \le \frac{1}{\pi \ell} |D| (1 + o(1)) \tag{2.4}$$

where |D| is the area of the disk and o(1) tends to zero as $N \to \infty$.

More generally, for any open set with Lipschitz boundary Ω , denote by Ω_r the set obtained by dilating Ω around some origin by a factor $r = N^{\alpha}$. Then, for any $\alpha > 1/4$

$$\int_{\Omega_r} \rho_F \le \frac{1}{\pi \ell} |\Omega_r| (1 + o(1)) \tag{2.5}$$

as $N \to \infty$.

2.2. Potential energy estimates. With Theorem 2.1 in hand, we can return to the original physical problem (1.2) in the presence of an external potential V. If the magnetic kinetic energy is frozen by restricting one-body orbitals to the LLL, and if we further assume that the interaction energy is also frozen by restricting to (2.2), the only non-trivial energy term left in the Hamiltonian is set by V. An interesting problem consists in studying the minimization of this energy amongst fully-correlated states:

$$E_V(N,\ell) := \inf\left\{\int_{\mathbb{R}^2} V(z)\rho_F(z)dz, \ \rho_F \text{ as in } (2.3), \ \Psi_F \in \mathcal{L}_\ell^N\right\}.$$
 (2.6)

This infimum will not necessarily be attained, but it is easy to see that, for fixed N, the density ρ_F is bounded in L^{∞} uniformly in F (this follows from the fact that all one-body orbitals are in the LLL [13], see the discussion in [57, Remark 2.2]). Therefore the infimum exists for any V such that its negative part, V_- , is in $L^1(\mathbb{R}^2)$.

In view of Theorem 2.1, it is fairly natural to expect a lower bound to (2.6) in terms of the "bathtub energy", defined as [40, Theorem 1.14]

$$E_V^{\text{bt}}(\ell) := \min\left\{ \int_{\mathbb{R}^2} V\rho \mid 0 \le \rho \le \frac{1}{\pi\ell}, \ \int_{\mathbb{R}^2} \rho = N \right\}.$$
 (2.7)

We can prove this for a large class of external potentials V, that we now describe. Since the typical extension of the Laughlin state is of order \sqrt{N} , it is more convenient to state our asumptions in terms of a scaled version of the potential.

Asumption 2.2 (The external potential).

Let $V \in C^2(\mathbb{R}^2)$ be a (sequence of) potential(s) that we write in the manner

$$V(x) = U\left(\frac{x}{\sqrt{N}}\right) \tag{2.8}$$

for a (possibly N-dependent) $U \in C^2(\mathbb{R}^2)$. Assume that there exists a fixed radius R > 0and an $\alpha > 0$ such that

(1) Local behavior:

 $\|$

$$\nabla U\|_{L^{\infty}(D(0,R))} \le CN^{1/2-\alpha}, \quad \|\Delta U\|_{L^{\infty}(D(0,R))} \le CN^{1-2\alpha}.$$
(2.9)

(2) Growth at infinity: $U \ge \underline{U}$ outside of D(0,R) for a potential $\underline{U} \in C^2(\mathbb{R}^2)$ satisfying

$$\|\nabla U\|_{L^{\infty}(\mathbb{R}^2)} \le C, \quad \|\Delta U\|_{L^{\infty}(\mathbb{R}^2)} \le C$$
(2.10)

and

$$\int_{\mathbb{R}^2} \exp(-\underline{U}) \le C \tag{2.11}$$

independently of N.

A typical example we have in mind is a potential V of the sort

$$V(x) = V_{\text{trap}}(x) + V_{\text{disorder}}(x) = U_{\text{trap}}\left(\frac{x}{\sqrt{N}}\right) + U_{\text{disorder}}\left(\frac{x}{\sqrt{N}}\right)$$
(2.12)

where the part U_{trap} represents trapping in a given sample, and satisfies Item 2 of the asumptions, whereas U_{disorder} represents some disorder due to impurities in the sample, is compactly supported in a fixed disk and satisfies Item 1 of the asumption.

Item 1 means that we consider a potential V whose variations happen on length scales $O(N^{\alpha}), \alpha > 0$, the best scale we may hope for (but cannot quite reach) in our density bounds, Theorem 2.1. Note that this should *not* be interpreted as saying that the potential energy bounds we are about to state work on the optimal length scale, see Remark 2.4 below. Item 2 is essentially a mild trapping asumption. It is clearly satisfied by any regular enough function U growing at least like $c \log |x|, c > 2$ at infinity.

We shall prove the following corrolary, which improves [58, Theorem 1.1]:

Corollary 2.3 (Lower bound to the potential energy).

Let V be as in Asumption 2.2. Then

$$E_V(N,\ell) \ge E_V^{\rm bt}(\ell)(1+o(1)) + o(N) \tag{2.13}$$

as $N \to \infty$.

Remark 2.4 (Affordable length scales).

In accordance with the limitations of Theorem 2.1, the above result is meaningful when $\alpha > 1/4$ in Asumption 2.2, i.e., the potential varies on length scales much larger than $N^{1/4}$. To appreciate this, recall [40, Theorem 1.14] that the minimizer of the bathtub energy takes only the values 0 and $(\pi \ell)^{-1}$ almost everywhere. Under Assumption 2.2, the typical length scale of the potential V is $L = N^{\alpha}$. It can have a variation of order rL in a disk of radius r. For comparison (and without loss of generality) let us set the reference energy to be the minimum of V in the disk. The difference in bathtub energy according to whether the minimizer is, say, equal to 0 or $(\pi \ell)^{-1}$ everywhere in said disk cannot be larger than $O(r^3L)$ (area times maximal value of the potential). Pick now r = L. For the energy difference to dominate the error term o(N) in (2.13), we need $L^4 \gg N$, that is $N^{4\alpha} \gg N$, and this is guaranteed only if $\alpha > 1/4$. The bound (2.13) thus captures the behavior of the bathtub minimizer on its smallest length scale (i.e., that of V) only if the latter is $\gg N^{1/4}$.

We conjecture that, apart the caveat with length scales we just discussed, the lower bound (2.13) is optimal and can be reached by using trial states of the form (1.7). At present, utilizing constructions and estimates in [55] we are only able to prove this for special radial potentials:

Corollary 2.5 (Optimization of the potential energy in radial traps).

Let U be some smooth potential growing at infinity at most polynomially and satisfying one of the two following assumptions

- (1) U is radially increasing,
- (2) U has a "Mexican-hat" shape: U(|x|) has a single local maximum at the origin and a single global minimum at some radius R.

Define

$$V(x) = U\left(\frac{x}{\sqrt{N}}\right). \tag{2.14}$$

Then

$$E_V(N,\ell) = E_V^{\rm bt}(\ell)(1+o(1)) \tag{2.15}$$

in the limit $N \to \infty$.

More precisely, in case (1)

 $\mathcal{E}_N[\Psi_{\text{Lau}}] = E_V^{\text{bt}}(\ell)(1+o(1)) \text{ when } N \to \infty$ (2.16)

and in case (2) one can find a fixed number $\underline{m} \in \mathbb{R}$ and a sequence $m(N) \in \mathbb{N}$ with $m \sim \underline{m}N$ as $N \to \infty$ such that, defining

$$\Psi_m(z_1, \dots, z_N) := c_m \Psi_{\text{Lau}}(z_1, \dots, z_N) \prod_{j=1}^N z_j^m$$
(2.17)

...

we have

$$\mathcal{E}_N[\Psi_m] = E_V^{\rm bt}(\ell)(1+o(1)) \quad when \ N \to \infty.$$
(2.18)

A remarkable fact about (2.16) is that the Laughlin state stays an approximate ground state in any radial increasing potential, however steep. We refer to [57, 58] again and to the companion paper [41] for further discussion of the significance of this fact.

2.3. Proof outline: screening properties in the plasma analogy. The backbone of the proof is Laughlin's plasma analogy, a very fruitful mapping of the many-body density of Ψ_{Lau} to a problem in classical statistical mechanics, originating in [30, 31]. As in our previous papers [55, 56, 57, 58] we generalize this to any fully-correlated state (1.4). We rewrite the *N*-particle probability density of any fully correlated state Ψ_N in the form of a Boltzmann-Gibbs factor

$$|\Psi_F(z_1,\ldots,z_N)|^2 = \frac{1}{Z_N} \exp\left(-H_N(z_1,\ldots,z_N)\right)$$
 (2.19)

with a classical Hamiltonian

$$H_N(z_1, \dots, z_N) = \sum_{j=1}^N |z_j|^2 - 2\ell \sum_{1 \le i < j \le N} \log |z_i - z_j| - 2\log |F(z_1, \dots, z_N)|.$$
(2.20)

To interpret (2.20) as an energy functional for N classical positively charged particles with coordinates $z_1, \ldots, z_N \in \mathbb{C} \simeq \mathbb{R}^2$ we recall that Poisson's equation relates the electrostatic potential φ generated by a charge distribution ρ in the manner

$$-\Delta\varphi = 2\pi\rho. \tag{2.21}$$

where Δ is the two-dimensional Laplacian. Thus one can see (2.20) as the energy of N positively charged particles subject to

• the external potential generated by a constant background of opposite charge. Since

$$-\Delta_{z_j}|z_j|^2 = -4 \tag{2.22}$$

the potential $|z_j|^2$ can be interpreted as being generated by a uniform charge background of negative density $-2/\pi$.

• pairwise Coulomb repulsion:

$$-\Delta_{z_j}\left(-2\ell\sum_{1\leq i< j\leq N}\log|z_i-z_j|\right) = \sum_{i\neq j}4\pi\ell\delta_{z_i=z_j},\qquad(2.23)$$

thus the second term in (2.20) is the 2D Coulomb interaction between particles of identical charge $\sqrt{2\ell}$.

• the potential generated by an essentially arbitrary, but *positive*, (many particle) charge distribution encoded in the (modulus of the) analytic function F. Indeed, for any $j = 1 \dots N$,

$$-\Delta_{z_{j}}(-\log|F(z_{1},\ldots,z_{N})|) \ge 0.$$
(2.24)

This is, in fact, the only property of F we use in our method. Equation (2.24) means that $-\log |F|$ is superharmonic in every variable, because F is analytic ².

A plausibility argument for our main results goes as follows:

- (1) The effective temperature in (2.19) is small compared to the total energy, so that the Boltzmann-Gibbs factor is essentially concentrated around minimizing configurations of the Hamiltonian (2.20).
- (2) For F = 1, i.e. in the case of the pure Laughlin state, one should expect that the local density of points in a minimizing configuration is close to $1/(\ell \pi)$. Indeed, this is the condition for the negatively charged fixed constant background (c.f. (2.22)) to efficiently screen the positively charged mobile particles $z_j, j = 1...N$ (c.f. (2.23)).
- (3) If $F \neq 1$ we add an additional positive charge distribution to the game because of (2.24). Since the mobile particles $z_j, j = 1 \dots N$ are positively charged in this representation, one can expect that such an addition will exert a repelling force on the density distribution of the mobile particles and reduce it locally.

This intuitive picture is, however, not as clear as it may look at first sight. If we imagine the potential term associated to F as being generated by point-like positively charged particles, it is not obvious a priori why several such charges cannot work together and conspire to increase the density locally. Arranged tightly on a circle they could, perhaps, concentrate the density at a high value around the centre of the circle. Note also that $-2\log |F(z_1,\ldots,z_N)|$ is generated by a mobile charge distribution because $\Delta_{z_j} \log |F(z_1,\ldots,z_N)|$ is in general a function of z_1,\ldots,z_N and only constant in special cases (essentially when $F = f^{\otimes N}$ is a tensor power, as in (1.7)). Thus, the positions of the additional charges are in general correlated with those of the actual charges. Moreover, as the example $F(z_1,\ldots,z_N) = \prod_i \exp(cz_i)$ shows, the area occupied by the bulk of the density can be stretched in one direction but compressed in another.

The heuristic argument (1)-(3) above is, in any case, certainly far from a rigorous proof. To obtain such a proof, the reduction to considering only ground states of (2.20) presents, perhaps, the least difficulty. To appreciate this, it is helpful to rescale lengths: we can write

$$\mu_F(z_1,\ldots,z_N) := N^N \left| \Psi_F(\sqrt{N}z_1,\ldots,\sqrt{N}z_N) \right|^2 = \frac{1}{\tilde{\mathcal{Z}}_N} \exp\left(-N\tilde{H}_N(z_1,\ldots,z_N)\right)$$
(2.25)

as a probability measure with

$$\tilde{H}_N(z_1, \dots, z_N) = \sum_{j=1}^N |z_j|^2 - 2\frac{\ell}{N} \sum_{1 \le i < j \le N} \log|z_i - z_j| - \frac{2}{N} \log|F(\sqrt{N}z_1, \dots, \sqrt{N}z_N)|.$$
(2.26)

²One can write it in Weierstrass factorized form to see that (2.24) holds, or use the Cauchy integral formula for the value of an analytic function at the center of any disk and rely on the characterization of superharmonic functions in terms of averages in disks [40, Chapter 9].

Thus, modulo a simple change of length-scales, we can reduce to a statistical mechanics problem

- in mean-field scaling, the first and second sum in the above being of the same order for large N.
- with small effective temperature $T = N^{-1}$.

This makes it clear why mostly ground-state configurations are relevant for the proof, although some care is needed to estimate the effect of entropy terms in the classical free energy. In fact, the reduction to classical ground state configurations is responsible for the fact that our main result holds only on length scales $\gg N^{1/4}$. For ground-states instead of Gibbs states, the result holds on scales $\gg 1$. There is thus certainly room for improvement in this particular part of the proof, see Remark 2.6 below.

With the reduction to ground states of (2.20) out of our way, the main question is now to understand points (2) and (3) of the list above. In our approach, the solution is essentially based on *screening* properties of ground states of classical Coulomb systems, namely their tendency to achieve local neutrality in order for the total potential generated by the positively and negatively charged particles to compensate one another.

Consider a minimizing configuration $Z_N^0 = \{z_1^0, \ldots, z_N^0\}$ for the classical Hamiltonian (2.20) (the labeling of the points is irrelevant by symmetry of (2.20) under permutations). To any subset $\{z_1^0, \ldots, z_K^0\}$ of the configuration (in fact, any K-tuple of points in \mathbb{R}^2) we associate a screening region Σ_K such that

$$\Phi(x) = \int_{\Sigma_K} \frac{1}{\pi \ell} \log |x - y| dy - \sum_{j=1}^K \log |x - z_k| \begin{cases} = 0 \text{ outside } \Sigma_K \\ \ge 0 \text{ inside } \Sigma_K. \end{cases}$$
(2.27)

The above means that the total potential generated by the K positive charges under consideration and a constant background of opposite charge density $(\pi \ell)^{-1}$ contained in Σ_K vanishes identically outside Σ_K . The background density coming from the first term in (2.20) thus completely screens the K point charges outside of the set Σ_K . Note that for (2.27) to hold we must have neutrality,

$$|\Sigma_K| = \pi \ell K. \tag{2.28}$$

The sets Σ_K are constructed in our approach via the minimization of an auxiliary functional bearing some formal resemblance to a 2D version of the usual Thomas-Fermi theory for molecules [39]. Accepting their existence, the rest of the proof has two main steps, going roughly as follows

- Given the screening region Σ_K associated to a subset $\{z_1^0, \ldots, z_K^0\}$ of the minimizing configuration, no other point of a minimizing configuration of particles can lie within Σ_K . We refer to this as the *exclusion property*. It holds for ground states of (2.20), as we shall prove, because the third term herein is superharmonic.
- Any configuration of points satisfying the exclusion property must have its local density bounded above by $(\pi \ell)^{-1}$. If some region contains a larger density, consider a disk included in it. The screening region associated to the points contained in the disk would have, because of (2.28), to leak outside of the disk. It would then overlap with other points of the configuration, which is impossible because of the exclusion property.

10

The construction of the screening set, via a variant of Thomas-Fermi theory, is done in Section 3. Some care is needed in handling the auxiliary variational problem, because it is of a non-standard type. We next prove the local density bound for ground states of (2.20) in Section 4, following the above strategy. The application to low-temperature Gibbs states (2.19) occupies Section 5, where we prove Theorem 2.1. Finally we deduce Corollaries 2.3 and 2.5 in Section 6.

Remark 2.6 (Recent related results).

The classical Hamiltonian (2.20) and the associated Gibbs state (2.19) in the pure Laughlin case F = 1 have attracted much attention in their own right. Apart from the connection with the FQHE we are primarily concerned about here, one can see them as basic models for trapped plasmas. In this context, a generalization often considered (2D log-gas or 2D β -ensemble) is to replace $|z_j|^2 \to V(z_j)$ in (2.26), with $V : \mathbb{R}^2 \to \mathbb{R}$ a general trapping potential. Minimizing configurations are then weighted Fekete sets [59], and Gibbs states for special values of the temperature are connected to certain random matrices ensembles [5, 21].

For general V the density is not flat: the limiting density of points is proportional to ΔV on its support. One expects the true minimizers and low-temperature Gibbs states to follow this profile on any microscopic length scale $\gg N^{-1/2}$ (in the scaled variables used in (2.26)). This has recently been proved in [4, 51] for ground states (see also [48] for higher dimensional Coulomb and Riesz gases) and in [7, 8, 33, 35] for Gibbs states. See also earlier partial results (not on the optimal scale) in [62, 54, 49] and [2, 3, 10, 15, 16, 36, 34, 61] for related recent literature.

One can see our main result as a generalization of the fine-scale rigidity estimates of [4, 51, 7, 33] to the case of a non-trivial F. Motivated by FQHE physics, this generalization is our chief concern. For general analytic F one should expect only local density upper bounds, but no corresponding lower bound in general. None of the available methods seem to apply here, but the new approach we sketched above might be of interest in the usual context with F = 1 and a general V in (2.26). Note that we obtain the expected density upper bound on essentially optimal length scales for minimizing configurations (see Proposition 4.6 below), but that it remains an open problem to do the same for Gibbs states, i.e. allow any $\alpha > 0$ instead of only $\alpha > 1/4$ in Theorem 2.1.

3. Incompressible 2D Thomas-Fermi molecules

In this section we discuss a Thomas-Fermi-like variational theory of 2D molecules. We consider the functional

$$\mathcal{E}^{\mathrm{TF}}[\sigma] = -\int_{\mathbb{R}^2} V_{\mathrm{nuc}}(x)\sigma(x)\,dx + D(\sigma,\sigma) \tag{3.1}$$

where σ is the density distribution of negatively charged "electrons",

$$V_{\rm nuc}(x) = -\sum_{i=1}^{K} \log |x - x_i|$$
(3.2)

is the 2D electrostatic potential generated by K point "nuclei" of charge +1 located at positions x_1, \ldots, x_K in the plane and

$$D(\sigma, \sigma) = -\frac{1}{2} \iint_{\mathbb{R}^2 \times \mathbb{R}^2} \sigma(x) \log |x - y| \sigma(y) \, dx \, dy \tag{3.3}$$

is the electrostatic self-energy of the "electrons".

We emphasize that in the application we have in mind, the designations "nuclei" and "electrons" do not refer to real physical entities. The terminology is just chosen for convenience and analogy with standard TF theory for molecules [14, 39].

We consider the minimization of $\mathcal{E}^{\mathrm{TF}}$ over the variational set

$$\mathcal{M}^{\mathrm{TF}} := \left\{ \sigma \in L^{\infty}(\mathbb{R}^2) \cap L^1\left(\mathbb{R}^2, \log(2+|x|)dx\right), 0 \le \sigma \le 1, \ \int_{\mathbb{R}^2} \sigma = K \right\}$$
(3.4)

which means that we are interested in an "incompressible neutral molecule". The term "incompressible" refers to the constraint $\sigma \leq 1$ on the density of electrons and "neutral" to the requirement that the total charge of the electrons equals that of the nuclei.

Remark 3.1 (Related models).

From a physics point of view, a more natural functional to consider would be

$$\mathcal{E}_{\tau}[\sigma] = \int_{\mathbb{R}^2} \tau(\sigma) - \int_{\mathbb{R}^2} V_{\text{nuc}}(x)\sigma(x)\,dx + D(\sigma,\sigma) \tag{3.5}$$

with a function τ representing the kinetic energy density of the electrons. For $\tau(\sigma) = (\text{const.}) \cdot \sigma^2$ this term is the standard local density/semi-classical approximation of the quantum kinetic energy of a 2D electron gas. The minimization problem (3.1)–(3.4), which is the relevant one for our purpose, corresponds formally to taking $\tau(\sigma) = \sigma^p$ with $p \to \infty$ to enforce the uniform upper bound $\sigma \leq 1$, but we shall not follow this $p \to \infty$ route.

Many results we prove below have a natural extension to the case where V_{nuc} is a more general potential, as long as it is generated by a compactly supported charge distribution. One could also consider the corresponding 3D model, which is in fact slightly simpler to deal with, because of the fall-off at infinity of the 3D Coulomb kernel.

We also mention that there is a kinship with recently studied flocking/swarming models [12, 22] where constrained minimization problems similar to the above have been considered and proved to support phase transitions.

 \diamond

The facts we shall need about the variational problem for \mathcal{E}^{TF} are collected in the following theorem.

Theorem 3.2 (Incompressible neutral Thomas-Fermi molecules).

Let K be a positive integer. We have

- (1) **Well-posedness.** There exists a unique σ^{TF} that minimizes \mathcal{E}^{TF} over the variational set \mathcal{M}^{TF} .
- (2) Potential and variational inequalities. Let

$$\Phi^{\mathrm{TF}} := V_{\mathrm{nuc}} + \sigma^{\mathrm{TF}} * \log|.|$$
(3.6)

be the total electrostatic potential of the molecule. It is continuous and once continuously differentiable away from the nuclei and tends to zero at infinity. Moreover, for almost all x,

$$\Phi^{\rm TF}(x) \ge 0 \quad if \; \sigma^{\rm TF}(x) > 0$$

$$\Phi^{\rm TF}(x) = 0 \quad if \; \sigma^{\rm TF}(x) = 0. \tag{3.7}$$

- (3) Values of the electron density. The set $\{x : 0 < \sigma^{\text{TF}}(x) < 1\}$ has zero Lebesgue measure. Hence σ^{TF} takes only the values 1 or 0 a.e.
- (4) Support of the electron density.

(i) The set $\{x : \sigma^{TF}(x) > 0\}$ is essentially bounded: If D(0, r) denotes a disk with radius r and center at 0, then for any $R > \max |x_i|$ we have, up to a set of measure zero,

$$\{x: \sigma^{\mathrm{TF}}(x) > 0\} \subset D\left(0, R + \sqrt{M_R}\right)$$
(3.8)

with

$$M_R := \frac{1}{\pi} \sup_{|x|=R} \Phi^{\rm TF}(x).$$
(3.9)

(ii) Up to a set of measure zero, $\{x : \sigma^{TF}(x) > 0\}$ is equal to the open set

$$\Sigma^{\rm TF}(x_1, \dots, x_K) = \{x : \Phi^{\rm TF}(x) > 0\}$$
(3.10)

and the area of $\Sigma^{\mathrm{TF}}(x_1, \ldots, x_K)$ is equal to K.

(iii) The locations x_1, \ldots, x_K of the nuclei lie within $\Sigma^{\text{TF}}(x_1, \ldots, x_K)$ and all connected components of the latter set contain at least one x_j . (iv)

$$\Sigma^{\mathrm{TF}}(x_1, \dots, x_{K-1}) \subset \Sigma^{\mathrm{TF}}(x_1, \dots, x_K).$$
(3.11)

(v) For a single nucleus,

$$\Sigma^{\rm TF}(x_1) = \{x : |x - x_1| < 1/\sqrt{\pi}\}.$$
(3.12)

The inclusion in (3.11) says that when a nucleus is added, the density σ^{TF} and the potential Φ^{TF} increase everywhere. The rest of this section is devoted to the proof of these results.

3.1. Existence and uniqueness of a minimizer. The uniqueness is simpler than the existence and we consider it first:

Lemma 3.3 (Strict convexity and uniqueness).

The functional \mathcal{E}^{TF} is strictly convex on \mathcal{M}^{TF} . Consequently, the minimizer σ^{TF} , if it exists, is unique.

Proof. We only have to show that $D(\sigma, \sigma)$ is strictly convex on \mathcal{M}^{TF} . This is a consequence of the positivity of $D(\mu, \mu)$ for neutral charge distributions μ as in [56, Lemma 3.2]. The general fact is that

$$D(\mu,\mu) = \frac{1}{2\pi} \int_{\mathbb{R}^2} \left(\int_{\mathbb{R}^2} \frac{1}{|t-z|} d\mu(z) \right)^2 dt$$
(3.13)

whenever $\int_{\mathbb{R}^2} \mu = 0$, see [59, Chapter I, Lemma 1.8]. This implies the claimed strict convexity property: pick two measures μ_1 and μ_2 with $\int \mu_1 = \int \mu_2$. Then

$$\frac{1}{2}D(\mu_1,\mu_1) + \frac{1}{2}D(\mu_2,\mu_2) - D\left(\frac{1}{2}\mu_1 + \frac{1}{2}\mu_2,\frac{1}{2}\mu_1 + \frac{1}{2}\mu_2\right) = \frac{1}{4}D\left(\mu_1 - \mu_2,\mu_1 - \mu_2\right) \ge 0$$
(3.14)

since $\int_{\mathbb{R}^2} \mu_1 = \int_{\mathbb{R}^2} \mu_2 = 1$. Equality holds if and only if $\mu_1 = \mu_2$ a.e. Uniqueness of the minimizer follows because we minimize a strictly convex functional on a convex set. \Box

Next we consider the boundedness from below and lower semicontinuity of the functional $\mathcal{E}^{\mathrm{TF}}$.

Lemma 3.4 (Boundedness from below).

The functional \mathcal{E}^{TF} is uniformly bounded from below on \mathcal{M}^{TF} . It is moreover lower semicontinuous under strong convergence in $L^1 \cap L^p$ for any p > 1.

Proof. For any $\sigma \in \mathcal{M}^{\mathrm{TF}}$ we can use the normalization to write

$$\mathcal{E}^{\rm TF}[\sigma] = \frac{1}{2} \iint_{\mathbb{R}^2 \times \mathbb{R}^2} \left(K^{-1} \sum_{i=1}^K \log|x - x_i| + K^{-1} \sum_{i=1}^K \log|y - x_i| - \log|x - y| \right) \sigma(x) \sigma(y) dx dy$$
(3.15)

Then, since $|x - y| \le (1 + |x|)(1 + |y|)$, we have

$$\mathcal{E}^{\mathrm{TF}}[\sigma] \ge K \int_{\mathbb{R}^2} \left(K^{-1} \sum_{i=1}^K \log |x - x_i| - \log(1 + |x|) \right) \sigma(x) dx.$$
(3.16)

The function in parenthesis is clearly uniformly bounded from below outside of a disk D(0, R) that contains all the nuclei. On the disk D(0, R) it is locally integrable. Since $\sigma \in \mathcal{M}^{\mathrm{TF}}$ is uniformly bounded in $\in L^1(\mathbb{R}^2) \cap L^{\infty}(\mathbb{R}^2)$ and non-negative, we can split the integration domain according to whether $|x| \leq R$ or the other way around, and conclude that both pieces are bounded from below uniformly.

The lower semi-continuity follows from the same kind of considerations, using in addition Fatou's lemma and the fact that $\log |.| \in L^q_{loc}(\mathbb{R}^2)$ for any $1 \leq q < \infty$.

We now prove the existence of a minimizer. Note that if we had been minimizing under the constraint that the mass be equal to N < K, existence of a minimizer would follow from standard arguments discussed e.g. in [59]. At neutrality, when the number of electrons equals that of nuclei, this is slightly more subtle and we use some tricks we learned from [10, 26, 27].

Proof of Theorem 3.2, Item 1. Uniqueness of the minimizer is already contained in Lemma 3.3. For the existence, consider a minimizing sequence $(\sigma_n)_{n \in \mathbb{N}}$. In view of the definition of \mathcal{M}^{TF} we can extract a (not relabeled) subsequence which converges weakly- \star as a Radon measure, weakly in any $L^p(\mathbb{R}^2)$ for any $1 , and weakly-<math>\star$ in $L^{\infty}(\mathbb{R}^2)$ to a candidate minimizer σ^{TF} , i.e.

$$\int_{\mathbb{R}^2} f\sigma_n \to \int_{\mathbb{R}^2} f\sigma \tag{3.17}$$

for any function $f \in L^q(\mathbb{R}^2)$, $1 \leq q < \infty$ (the convergence as a Radon measure corresponds to f continuous with compact support). Using Mazur's lemma [40, Theorem 2.13] and the convexity of the functional we could assume without loss that the convergence is strong in any $L^q(\mathbb{R}^2), 1 < q < \infty$, but we shall not use this.

By the lower semicontinuity proved in Lemma 3.4 we obtain

$$\mathcal{E}^{\mathrm{TF}}[\sigma^{\mathrm{TF}}] \le \inf\{\mathcal{E}^{\mathrm{TF}}[\sigma] : \sigma \in \mathcal{M}^{\mathrm{TF}}\}.$$
(3.18)

Hence we only have to prove that $\sigma^{\text{TF}} \in \mathcal{M}^{\text{TF}}$. The upper and lower constraints on σ_n pass to the limit easily, but it remains to show that

$$\int_{\mathbb{R}^2} \sigma^{\mathrm{TF}} = K. \tag{3.19}$$

This follows from the fact that the sequence $(\sigma_n)_{n \in \mathbb{N}}$ is tight, i.e., no mass escapes to infinity in the limit. To prove this we pick some R > 0 and rewrite the energy as in (3.15), then split the part of the double integral where $|x| \ge R$, $|y| \ge R$ from the rest:

$$\mathcal{E}^{\mathrm{TF}}[\sigma_n] = \frac{1}{2} \iint_{|x| \ge R, |y| \ge R} \left(K^{-1} \sum_{i=1}^K \log |x - x_i| + K^{-1} \sum_{i=1}^K \log |y - x_i| - \log |x - y| \right) \sigma_n(x) \sigma_n(y) dx dy + \frac{1}{2} \iint_{|x| \le R \text{ or } |y| \le R} \left(K^{-1} \sum_{i=1}^K \log |x - x_i| + K^{-1} \sum_{i=1}^K \log |y - x_i| - \log |x - y| \right) \sigma_n(x) \sigma_n(y) dx dy.$$
(3.20)

The second term is bounded below independently of n and R by the same arguments as in the proof of Lemma 3.4. For the rest we rewrite

$$K^{-1} \sum_{i=1}^{K} \log |x - x_i| + K^{-1} \sum_{i=1}^{K} \log |y - x_i| - \log |x - y|$$

= $\left(K^{-1} \sum_{i=1}^{K} \log |x - x_i| - \frac{1}{2} \log(1 + |x|^2) + K^{-1} \sum_{i=1}^{K} \log |y - x_i| - \frac{1}{2} \log(1 + |y|^2) \right)$
 $- \log \frac{|x - y|}{\sqrt{1 + |x|^2} \sqrt{1 + |y|^2}}.$ (3.21)

The function in parenthesis on the second line is bounded below uniformly for $|x|, |y| \ge R$ large enough, so that, once integrated against $\mathbb{1}_{|x|\ge R}\mathbb{1}_{|y|\ge R}\sigma_n(x)\sigma_n(y)dxdy$ it gives a contribution uniformly bounded from below. For the contribution of the last term we note that

$$\frac{|x-y|}{\sqrt{1+|x|^2}\sqrt{1+|y|^2}} \le \frac{|x|+|y|}{\sqrt{1+|x|^2}\sqrt{1+|y|^2}} \le \frac{1}{\sqrt{1+|y|^2}} + \frac{1}{\sqrt{1+|x|^2}}$$
(3.22)

and thus

$$\begin{aligned} \iint_{|x|\geq R, |y|\geq R} \log \frac{|x-y|}{\sqrt{1+|x|^2}\sqrt{1+|y|^2}} \sigma_n(x)\sigma_n(y)dxdy \\ &\leq -\frac{1}{2}\log(1+R^2)\left(\int_{|x|\geq R} \sigma_n(x)dx\right)^2 + C. \end{aligned} (3.23)$$

All in all we deduce that, the energy of σ_n being uniformly bounded above,

$$\frac{1}{4}\log(1+R^2)\left(\int_{|x|\ge R}\sigma_n(x)dx\right)^2 \le C,\tag{3.24}$$

where C depends neither on n nor on R > 0 provided the latter is large enough. Since $\log(1+R^2) \to +\infty$ for $R \to \infty$, this implies tightness of the minimizing sequence, namely that for any $\varepsilon > 0$ there exists $R_{\varepsilon} > 0$ such that

$$\limsup_{n \to \infty} \int_{|x| \ge R_{\varepsilon}} \sigma_n(x) dx < \varepsilon.$$
(3.25)

To study the properties of the minimizer, whose existence and uniqueness we have now established, we next consider the corresponding electrostatic potential.

3.2. The Thomas-Fermi potential. To any electron density σ we associate a potential

$$\Phi_{\sigma} = V_{\rm nuc} + \sigma * \log |.| = (\rho_{\rm nuc} - \sigma) * (-\log |.|).$$
(3.26)

If $\int_{\mathbb{R}^2} \sigma = K$ then this is the Coulomb potential generated by a neutral charge distribution. We prove first that it is regular away from the nuclei and decays at infinity.

Lemma 3.5 (Regularity and asymptotic behavior of the potential).

If $\sigma \in \mathcal{M}^{\mathrm{TF}}$, the potential Φ_{σ} is continuous and once continuously differentiable away from the nuclei and tends to zero at infinity. More generally, if σ satisfies the conditions (3.4) except neutrality, but $\int \sigma \langle K$, then

$$\left| \Phi_{\sigma}(x) - \left(K - \int_{\mathbb{R}^2} \sigma \right) \log |x| \right| \to 0$$
(3.27)

when $|x| \to \infty$

Proof. If $\sigma \in \mathcal{M}^{\text{TF}}$ has compact support the regularity follows from [40, Theorem 10.2]. The general case follow by cutting σ at some finite radius R and using the dominated convergence theorem as $R \to \infty$.

For the asymptotic behaviour we consider also first the case that σ has support in some disk D(0, R) with $R < \infty$. For $|y| \leq \frac{1}{2}|x|$ we have

$$\log|x-y| = \log|x| + \log\left|1 - \frac{y}{x}\right| \le \log|x| + \frac{|y/x|}{1 - |y/x|} \le \log|x| + 2\frac{|y|}{|x|}$$
(3.28)

where the ratio of two vectors in \mathbb{R}^2 is interpreted as that of the corresponding complex numbers.

Thus, for $|x| \ge 2 \max_i \{R, |x_i|\}$

$$\left|\Phi_{\sigma}(x) - \left(K - \int_{\mathbb{R}^2} \sigma\right) \log |x|\right| \le 2 \left(\sum_{i=1}^K |x_i| + \int_{D(0,R)} |y|\sigma(y)dy\right) \frac{1}{|x|}.$$
(3.29)

and the result is proved in this case.

Let us now only assume that

$$\int_{\mathbb{R}^2} \sigma(y) \log(1+|y|) dy < \infty \tag{3.30}$$

as in the definition of \mathcal{M}^{TF} . This implies that for any $\varepsilon > 0$ there is a R_{ε} such that

$$\int_{|y|\ge R_{\varepsilon}} \sigma(y) \log(1+|y|) dy < \varepsilon.$$
(3.31)

For every $\varepsilon > 0$ there is a $\delta > 0$ such that $\log(1-t) < \varepsilon$ if $|t| < \delta$. Pick some large R and write for $|x| \ge R \ge R_{\varepsilon}$

$$\int_{\mathbb{R}^2} \log\left|1 - \frac{y}{x}\right| \sigma(y) dy = \int_{|y| \le \delta \cdot R} \log\left|1 - \frac{y}{x}\right| \sigma(y) dy + \int_{|y| \ge \delta \cdot R} \log\left|1 - \frac{y}{x}\right| \sigma(y) dy.$$
(3.32)

The first term is bounded by (const.) ε by the choice of δ and because $\int_{\mathbb{R}^2} \sigma$ is finite.

The second term we write as

$$\int_{|y| \ge \delta \cdot R} \log |x - y| \sigma(y) dy - \log |x| \int_{|y| \ge \delta \cdot R} \sigma(y) dy.$$
(3.33)

If $\delta \cdot R$ is large enough, we can ensure

$$\int_{|y| \ge \delta \cdot R} \sigma(y) dy \le C \varepsilon (\log |x|)^{-1}.$$
(3.34)

because of (3.31). In the remaining term (remember that $\delta \cdot R$ is large and $|x| \ge \delta \cdot R$) we split the integral into a disk D(x, 1) of radius 1 around x and the rest. Since the logarithm is square integrable over the unit disk we can use the Cauchy-Schwarz inequality to conclude that

$$\left| \int_{D(x,1)} \log |x - y| \sigma(y) dy \right| \le C \varepsilon^{1/2}$$
(3.35)

because $0 \le \sigma \le 1$ and $\int_{D(x,1)} \sigma \le \varepsilon$. The integral over the complement of D(x,1) is also small because there $\log |x - y| \le 2 \log |y|$ and the integral against σ tends to zero as the size of the integration domain increases.

Summarizing, we have proved that for any $\varepsilon > 0$ there exists $R_{\varepsilon} > 0$ such that

$$\int_{\mathbb{R}^2} \log\left|1 - \frac{y}{x}\right| \sigma(y) dy \le \varepsilon \tag{3.36}$$

for $|x| \ge R_{\varepsilon}$. Returning to the first equality in (3.28) proves the lemma.

Lemma 3.6 (Variational inequalities).

Recall the definition (3.6) of the Thomas-Fermi potential. There exists $\lambda \in \mathbb{R}$ such that for almost every x

$$\Phi^{\rm TF}(x) \ge \lambda \ if \ \sigma^{\rm TF}(x) = 1 \tag{3.37}$$

$$\Phi^{\rm TF}(x) = \lambda \ if \ 0 < \sigma^{\rm TF}(x) < 1 \tag{3.38}$$

$$\Phi^{\rm TF}(x) \le \lambda \ if \ \sigma^{\rm TF}(x) = 0 \tag{3.39}$$

Proof. Eqs. (3.37)–(3.39) follow from local minimality of the functional (3.1) at σ^{TF} by performing small variations in the standard way, c.f. [23, Lemma 4.1.2] or [12, 22]. Here λ is the Lagrange multiplier associated with the mass constraint. That we get only inequalities on the sets { $\sigma^{\text{TF}} = 1$ } and { $\sigma^{\text{TF}} = 0$ } comes from the fact that the variational constraint $0 \le \sigma \le 1$ allows only one-sided variations on these sets.

Lemma 3.7 (Value of the chemical potential). The Lagrange multiplier λ defined in Lemma 3.6 is equal to 0 and $\Phi^{\text{TF}} = 0$ a.e. where $\sigma^{\text{TF}} = 0$.

Proof. Assume $\lambda < 0$. By Lemma 3.5 Φ^{TF} vanishes at infinity so there is a radius R such that $\Phi^{\text{TF}}(x) > \lambda$ for $|x| \ge R$. By (3.37)–(3.39) this implies $\sigma^{\text{TF}}(x) = 1$ a.e. for $|x| \ge R$, contradicting the finiteness of $\int \sigma$. Hence $\lambda < 0$ is excluded.

Assume $\lambda > 0$. As above, there is a radius R such that $\Phi^{\text{TF}}(x) < \lambda$ for $|x| \ge R$. By (3.37)–(3.39) this implies $\sigma^{\text{TF}}(x) = 0$ a.e. for $|x| \ge R$. Hence the set $\{\sigma^{\text{TF}} > 0\}$ is bounded, up to a set of measure zero. Consider the circular average

$$\bar{\Phi}(R) := \frac{1}{2\pi} \int_0^{2\pi} \Phi^{\mathrm{TF}} \left(R \, e^{i\theta} \right) d\theta. \tag{3.40}$$

Because Φ^{TF} is harmonic on $\{x : \Phi^{\text{TF}}(x) < \lambda\}$, it cannot have a local minimum on this set so we know that $\Phi^{\text{TF}}(x) \ge 0$ everywhere and hence $\bar{\Phi}(R) \ge 0$. By continuity of Φ^{TF} and the assumption $\lambda > 0$ there is a radius R_0 such that $\bar{\Phi}(R_0) > 0$, but $\bar{\Phi}(R) < \lambda$ for $R > R_0$. The circle with radius R_0 thus encloses the whole set $\{\sigma^{\text{TF}} > 0\}$, up to a set of measure zero. On the other hand, by Newon's Theorem [40, Theorem 9.7], $\bar{\Phi}(R_0)$ is proportional to the total charge inside the circle of radius R_0 which is zero and we have a contradiction.

Having excluded both $\lambda < 0$ and $\lambda > 0$ we conclude that $\lambda = 0$. Finally, $\{x : \Phi^{\text{TF}}(x) < 0\}$ is empty because Φ^{TF} would be harmonic on this set and zero on its boundary. \Box

With Lemmas 3.6 and 3.7 we have established Item (2) of Theorem 3.2 We next show that σ^{TF} takes only the values 0 or 1 almost everywhere.

Proof of Theorem 3.2, Item (3). We want to show that the set

$$A := \left\{ x : 0 < \sigma^{\mathrm{TF}}(x) < 1 \right\}$$
(3.41)

has zero Lebesgue measure. By the definition (3.6) of Φ^{TF} we have in the sense of distributions

$$-\Delta\Phi^{\rm TF} = 2\pi \left(\rho_{\rm nuc} - \sigma^{\rm TF}\right). \tag{3.42}$$

with $\rho_{\text{nuc}} = \sum_{i=1}^{K} \delta_{x_i}$. Because Φ^{TF} is constant (in fact zero) on A, we can immediately exclude that A contains an open set, because on such a set we would have

$$\Delta \Phi^{\rm TF} = 0 \tag{3.43}$$

contradicting (3.42). Since there exist sets of positive measure but with empty interior this does not prove the lemma, however. The problem of overcoming the lack of knowledge of A, and showing that (3.43) holds a.e. on A was solved in a similar problem in [22] and we sketch that argument here.

If a function f is in $W_{\text{loc}}^{1,1}$ then on the set on which f has any fixed value, its gradient, ∇f , vanishes except for a set of measure zero, see [63, 44, 1] or [40, Theorem 6.9]. Away from the nuclei, Φ^{TF} is explicitly seen to be continuous and in L_{loc}^1 , and the same holds for its gradient $\nabla \Phi^{\text{TF}}$. On A we thus have $\nabla \Phi^{\text{TF}} = 0$. In order to repeat this argument for the Laplacian, we need to show that Φ^{TF} is in $W_{\text{loc}}^{2,1}$.

What we do know is that the sum of the squares of the second derivatives, $\Delta \Phi^{\text{TF}}$, is an L^1_{loc} function (see (3.42)). What we need is that all mixed second derivatives are in L^1_{loc} .

This follows by an exercise involving Fourier transforms, c.f. [22, Lemma 11]. Thus (3.43) does hold a.e. on A, and this contradicts (3.42) unless A has zero Lebesgue measure. \Box

We now turn to the last item of Theorem 3.2, concerning the support of the electron density.

Proof of Theorem 3.2, Item (4).

Step 1. We first prove the estimate (3.8) on the support of σ^{TF} . By Lemma 3.7 we know that $\lambda = 0$. There is an R such that $|x_i| < R$ for all i. For $|x| \ge R$ and $\hat{R} > R$ we introduce the function

$$g(x) = \begin{cases} \pi \cdot (\hat{R} - |x|)^2 & \text{if } |x| \le \hat{R} \\ 0 & \text{if } |x| > \hat{R} \end{cases}.$$
 (3.44)

Then, for $R < |x| \le \hat{R}$,

$$\Delta g \le 2\pi. \tag{3.45}$$

Consider the set

$$S = \{x : 0 \le g(x) < \Phi^{\text{TF}}(x), \ |x| \ge R\}.$$
(3.46)

Since $\Phi^{\text{TF}} > 0$ on this set, which contains no nucleus by assumption, we have $\sigma^{\text{TF}} = 1$ and $\Delta \Phi^{\text{TF}} = 2\pi$ on S. Hence

$$\Delta(g - \Phi^{\rm TF}) \le 0 \tag{3.47}$$

on S, so the function $g - \Phi^{\text{TF}}$ is superharmonic on S and reaches its minimum at the boundary or at infinity. At infinity the function vanishes. For |x| = R we can make $g - \Phi^{\text{TF}} \ge 0$ by choosing

$$\hat{R} = R + \sqrt{M_R} \tag{3.48}$$

where M_R is given by (3.9). We conclude that on S we have $g - \Phi^{\text{TF}} \ge 0$ and thus this set must be empty. Then $\Phi^{\text{TF}} \le g$ for $|x| \ge R$, so $\Phi^{\text{TF}} = 0$ and hence $\sigma^{\text{TF}} = (2\pi)^{-1} \Delta \Phi^{\text{TF}} = 0$ for $|x| > \hat{R}$. This yields the desired result, Equation (3.8).

Step 2. Next we consider the open set $\Sigma^{\text{TF}}(x_1, \ldots, x_K) \equiv \Sigma^{\text{TF}}$ where the potential Φ^{TF} is strictly positive. From Equation (3.7) we have $\Sigma^{\text{TF}} \subset {\sigma^{\text{TF}} > 0}$ while ${\sigma^{\text{TF}} > 0}$ is contained in the closure $\bar{\Sigma}^{\text{TF}}$. Since Φ^{TF} is continuous outside the "nuclei", Σ^{TF} is Jordan measurable which means that its boundary has Lebesgue measure zero. Hence Σ^{TF} and ${\sigma^{\text{TF}} > 0}$ are equal up to a null set. Since σ^{TF} takes only the values 1 or 0, it follows that the area of Σ^{TF} is equal to K.

Step 3. Since $\Phi^{\text{TF}}(x) \to +\infty$ when x approaches a location of a nucleus, we have $x_i \in \Sigma^{\text{TF}}$ for all *i*. Consider a connected component of Σ^{TF} which does not include any x_i . On this component we have

$$\Delta \Phi^{\rm TF} = 2\pi \tag{3.49}$$

and thus Φ^{TF} is subharmonic, hence reaches its maximum at the boundary, where $\Phi^{\text{TF}} = 0$. This contradicts the strict positivity of Φ^{TF} on $\Sigma^{\text{TF}}(x_1, \ldots, x_K)$. Hence all connected components of Σ^{TF} contain at least one nucleus.

Step 4. Denote by Φ_{K-1}^{TF} and Φ_{K}^{TF} the TF potentials corresponding to $\{x_1, \ldots, x_{K-1}\}$ and $\{x_1, \ldots, x_K\}$ respectively and by σ_K and σ_{K-1} the minimizing densities. Likewise

we denote by Σ_{K-1}^{TF} and Σ_{K}^{TF} the sets where the potentials Φ_{K-1}^{TF} and Φ_{K}^{TF} are strictly positive. Consider the open set

$$\mathcal{U} = \left\{ x : \Phi_K^{\rm TF}(x) < \Phi_{K-1}^{\rm TF} \right\}.$$
 (3.50)

Clearly, $x_i \notin \mathcal{U}$ for all $i = 1, \ldots, K$. Since $\Phi_K^{\text{TF}} \geq 0$ we have $\Phi_{K-1} > 0$ on \mathcal{U} and hence $\sigma_{K-1} = 1$ on \mathcal{U} . Thus

$$(2\pi)^{-1}\Delta(\Phi_{K-1} - \Phi_K) = \sigma_{K-1} - \sigma_K \ge 0$$
(3.51)

on \mathcal{U} because $\sigma_K \leq 1$. Thus $\Phi_{K-1} - \Phi_K$ is subharmonic on \mathcal{U} and \mathcal{U} must be empty. We conclude that

$$\Phi_{K-1}(z) \le \Phi_K(z) \tag{3.52}$$

everywhere. In Σ_{K-1}^{TF} we have $\Phi_{K-1}(z) > 0$, hence $\Phi_K(z) > 0$, so $\Sigma_{K-1} \subset \Sigma_K^{\text{TF}}$.

Step 5. For a single nucleus, uniqueness implies that the minimizer must be rotationally symmetric around x_1 . By Step 3 the support of the density is connected and hence a full disk with $\sigma^{\text{TF}} = 1$. The Poisson equation then lead to the unique solution

$$\Phi^{\rm TF}(x) = \begin{cases} -\log|x - x_1| + \pi |x - x_1|^2 - \frac{1}{2}\log\pi - 1 & \text{if } |x - x_1| < 1/\sqrt{\pi} \\ 0 & \text{if } |x - x_1| \ge 1/\sqrt{\pi} \end{cases}$$
(3.53)

4. LOCAL DENSITY UPPER BOUNDS FOR CLASSICAL GROUND STATES

In this section we discuss the ground state of a generalized classical jellium Hamiltonian as presented in the introduction, and prove the announced local density upper bound on any microscopic scale $\gg 1$. The argument is split in two steps, corresponding to Subsections 4.1 and 4.2:

- First we prove an exclusion rule for ground states configurations: no point can lie inside a screening region defined by any subset of the other points. The latter is given by the open set Σ^{TF} where the TF potential Φ^{TF} corresponding to the chosen subset of the ground state configuration is strictly positive.
- Second, we prove that *any* configuration of points satisfying the above exclusion rule must have a local density bounded above by 1, which is the desired optimal upper bound.

In Subsection 4.3 we apply these results to ground states of the Hamiltonian (2.20) entering the plasma analogy, and small perturbations thereof.

4.1. Exclusion by screening. The exclusion rule we shall chiefly rely on in the sequel is as follows:

Definition 4.1 (Exclusion by screening).

Let $X_N = \{x_1, \ldots, x_N\} \subset \mathbb{R}^2$. Take any subset $\{y_1, \ldots, y_K, y_{K+1}\} \subset X_N$ of distinct points y_i . Define as in (3.10) $\Sigma^{\mathrm{TF}}(y_1, \ldots, y_K)$ to be the open set where the TF potential (3.6), generated by nuclei at locations y_1, \ldots, y_K and the corresponding background charge distribution σ^{TF} , is strictly positive. We say that X_N satisfies the *exclusion rule* if

$$y_{K+1} \notin \Sigma^{\mathrm{TF}}(y_1, \dots, y_K) \tag{4.1}$$

holds for any choice of $y_1, \ldots, y_K, y_{K+1} \in X_N$.

We call this "exclusion by screening" because Σ^{TF} defines a region surrounding y_1, \ldots, y_K outside of which the background charge density σ^{TF} totally screens the potential generated by y_1, \ldots, y_K . Indeed, as we proved in the preceding section, Equation (3.7), the total potential generated by the background and the point charges together vanishes identically outside Σ^{TF} . Note also that the closure of Σ^{TF} is the essential support of σ^{TF} .

The relevance of this notion to our problem is as follows: Consider a Hamiltonian function on \mathbb{R}^{2N} of the form

$$\mathcal{H}(x_1, \dots, x_N) = \frac{\pi}{2} \sum_{i=1}^N |x_i|^2 - \sum_{1 \le i < j \le N} \log |x_i - x_j| + \mathcal{W}(x_1, \dots, x_N)$$
(4.2)

with \mathcal{W} symmetric and superharmonic in each variable x_i . Equation (4.2) is obtained from (2.20) by a simple change of length units that we perform in order that the maximum local density be 1 instead of $\pi \ell$ (see Subsection 4.3 below).

Proposition 4.2 (Classical ground states satisfy the exclusion rule).

Any minimizing configuration $\{x_1^0, \ldots, x_N^0\}$ for \mathcal{H} satisfies the exclusion rule (4.1).

Proof. By symmetry of the Hamiltonian we may, without loss, choose

$$y_i = x_i^0, 1 \le i \le K + 1. \tag{4.3}$$

Consider fixing all points but x_{K+1}^0 . The energy to consider is then

$$G(x) = \mathcal{H}(x_1^0, \dots, x_K^0, x, x_{K+2}^0, \dots, x_N^0).$$
(4.4)

We claim that if $x \in \Sigma^{\text{TF}}(x_1^0, \ldots, x_K^0) \equiv \Sigma^{\text{TF}}$ then there is an $\tilde{x} \in \partial \Sigma^{\text{TF}}$ such that $G(\tilde{x}) < G(x)$. Thus the minimizing point x_{K+1}^0 cannot lie in Σ^{TF} .

To prove the claim, we add and substract a term $-\int_{\Sigma^{TF}} \log |x - x'| dx'$ to write

$$G(x) = \Phi(x) + R(x) \tag{4.5}$$

$$\Phi(x) = -\sum_{i=1}^{K} \log|x - x_i^0| + \int_{\Sigma^{\rm TF}} \log|x - x'| dx'$$
(4.6)

$$R(x) = \frac{\pi}{2}|x|^2 - \int_{\Sigma^{\rm TF}} \log|x - x'| dx' - \sum_{i=K+2}^N \log|x - x_i^0| + \mathcal{W}(x) + \text{const.}$$
(4.7)

with a superharmonic function

$$\mathcal{W}(x) := \mathcal{W}(x_1^0, \dots, x_K^0, x, x_{K+2}^0, \dots, x_N^0).$$
(4.8)

Now, Φ is precisely the TF potential corresponding to "nuclear charges" at $x_i^0, \ldots x_K^0$. Hence, using (3.7), $\Phi > 0$ on Σ^{TF} and zero on the boundary $\partial \Sigma^{\text{TF}}$. The first two terms in R are harmonic on Σ^{TF} when taken together. (The Laplacian applied to the first term gives 2π and to the second term -2π on Σ^{TF} .) The other terms are superharmonic on Σ^{TF} . Thus, R takes its minimum on the boundary, so there is a $\tilde{x} \in \partial \Sigma^{\text{TF}}$ with $R(x) \geq R(\tilde{x})$ for all $x \in \Sigma^{\text{TF}}$. On the other hand, $\Phi(x) > 0 = \Phi(\tilde{x})$ so $G(x) > G(\tilde{x})$. 4.2. Exclusion rule and density bounds. We now show that any configuration of points satisfying the exclusion rule (4.1) has its local density everywhere bounded above by 1. To this end let R > 0 and define n(R) to be the maximum number of nuclei that a disk D(a, R) of radius R can accomodate while respecting the exclusion rule:

 $n(R) = \sup \left\{ N \in \mathbb{N} \mid \text{ there exists } X_N = \{x_1, \dots, x_N\} \subset D(a, R) \text{ satisfying } (4.1) \right\}.$ (4.9)

It is clear that n(R) is independent of a because a translation of the x_i just translates the corresponding exclusion region.

Our density bound is as follows:

Theorem 4.3 (Exclusion rule implies a density bound). We have

$$\varrho_{\max} := \limsup_{R \to \infty} \frac{n(R)}{\pi R^2} \le 1.$$
(4.10)

We first recall from [58] a simpler density bound based on an unpublished theorem of Lieb which is essentially (4.1) for the special case K = 1.

Lemma 4.4 (Minimal distance between points).

Let $\{x_1, \ldots, x_N\}$ be a configuration of points satisfying (4.1). Then

$$\min_{1 \le i \ne j \le N} |x_i - x_j| \ge \frac{1}{\sqrt{\pi}}.$$
(4.11)

Consequently

$$\varrho_{\max} = \limsup_{R \to \infty} \frac{n(R)}{\pi R^2} \le 4.$$
(4.12)

Proof. By Theorem 3.2, Item 4(v), the exclusion region $\Sigma^{\text{TF}}(x)$ for a single point x is the open disk of radius $1/\sqrt{\pi}$ centered at x. Hence (4.11) follows from (4.1).

To deduce (4.12), pick a configuration of points $\{x_1, \ldots, x_N\}$ contained in a disk of radius R and smear each point over an open disk of radius $1/(2\sqrt{\pi})$. Because of (4.11) these disks do not overlap and must all be contained in a slightly larger disk of radius R + O(1) for large R. Thus

$$\frac{N}{4} \le \pi R^2 + O(R) \tag{4.13}$$

where the left side is the area covered by the small disks and the right-hand side the area of the large disk. This gives the desired result. $\hfill \Box$

The rough bound Equation (4.12) turns out to be quite useful for the proof of the full Theorem 4.3. The first step is a lemma saying that the lim sup in (4.10) is attained by sequences of configurations with no large vacancies:

Lemma 4.5 (Maximal configurations have no vacancies).

Let R_k be a sequence of radii with $R_k \to \infty$ for $k \to \infty$ and $X_{N_k} = \{x_1, \ldots, x_{N_k}\} \subset D(0, R_k)$ a sequence of configurations such that

$$\frac{N_k}{\pi R_k^2} \underset{k \to \infty}{\to} \varrho_{\max}.$$
(4.14)

Then, for any fixed $\varepsilon > 0$ and any sub-disk $D(a, \varepsilon R_k) \subset D(0, R_k)$,

$$\sharp \{ x \in X_{N_k} \cap D(a, \varepsilon R_k) \} \ge \varrho_{\max} \pi \varepsilon^2 R_k^2 (1 + o(1))$$

$$(4.15)$$

with $o(1) \to 0$ for $R_k \to \infty$.

This means that, for a configuration achieving the tightest packing in a given sequence of balls, the density is asymptotically uniform on any length scale comparable to the size of the balls.

Proof. The main idea is that a density lower than ρ_{max} in some sub-disk would have to be compensated for by a density higher than ρ_{max} in another sub-disk. This would contradict the definition of ρ_{max} as the lim sup of the maximal density achievable in any sequence of disks with radii tending to ∞ .

Note first that by Lemma 4.4 we have for any R, as in (4.13),

$$n(R) \le \max\left(1, 4\pi R^2 + CR\right).$$
 (4.16)

Hence ρ_{max} is finite and, in fact,

$$\varrho_{\max} \le 4. \tag{4.17}$$

We now tile the disk of radius R_k with disjoint smaller disks of radius $s := \varepsilon R_k$, labeled by an index $i = 1 \dots I$. We can achieve this leaving only an area $O(\varepsilon^2 R_k^2)$ untiled. The latter we tile with disjoint still smaller disks of radius $t := \varepsilon^{1/2} R_k^{1/2}$, labeled by $j = 1 \dots J$. In this way we leave only a domain A_h with area $|A_h| = O(\varepsilon R_k)$ uncovered. Let n(i, s), respectively n(j, t), be the number of points of the configuration X_{N_k} in each of the the smaller and the still smaller disks and let n_h be the number of points in A_h . By definition of ϱ_{\max} we have

$$n(R_k) = \sum_{i=1}^{I} n(i,s) + \sum_{j=1}^{J} n(j,t) + n_h$$

$$\leq n(1,s) + \sum_{i=2}^{I} \rho_{\max} \pi \varepsilon^2 R_k^2 (1+o(1)) + \sum_{j=1}^{J} \rho_{\max} \pi \varepsilon R_k (1+o(1)) + C \max(1,|A_h|)$$

$$= n(1,s) + \rho_{\max} (1+o(1)) \left(\pi R_k^2 - \pi \varepsilon^2 R_k^2 - |A_h|\right) + C \max(1,|A_h|).$$
(4.18)

In the second line we used the definition of ρ_{\max} as a lim sup and that for each fixed $\varepsilon > 0$, $\varepsilon R_k \to \infty$. Moreover, we used Lemma 4.4 to bound the density in A_h . In the third line we simply used that we tile with disjoint sets. Since by assumption

$$n(R_k) = \rho_{\max} \pi R_k^2 (1 + o(1))$$
(4.19)

we deduce

$$n(1,s) \ge \rho_{\max} \pi \varepsilon^2 R_k^2 (1+o(1)) \left(1 - C \varepsilon^{-1} R_k^{-1}\right) + o(1) R_k^2.$$
(4.20)

For large R_k and fixed $\varepsilon > 0$, the small disk labeled i = 1 must thus satisfy (4.15). For any disk as in the statement, we can construct a tiling such that it is the first small disk and the result follows.

We now describe briefly the main arguments leading to the proof of Theorem 4.3. The area of the "neutralizing region" Σ^{TF} associated with the nuclear charges contained in a disk of radius R is equal to the number of charges in the disk, so the task is to show that this area is asymptotically equal to the area of the disk as $R \to \infty$. On the boundary of the region Σ^{TF} the potential generated by the point charges in the disk and the TF neutralizing density σ^{TF} must vanish because of the exclusion rule. In particular, the

potential must vanish at any point of the nuclear charge configuration outside the disk. By the previous lemma, we can assume that the density of such vanishing points is bounded below uniformly, and combining this with a bound on the gradient of the potential we obtain an upper bound on the potential outside the disk. We can now proceed in two different ways (the second one was sketched in [41]):

- The bound on the potential outside the disk together with (3.8) implies that we can enclose Σ^{TF} completely in a slightly larger dis. whose radius behaves as R(1+o(1)). Thus the area of Σ^{TF} , which is equal to the number of nuclei in the disk increases at most like the area of the disk plus a small correction.
- Using Newton's theorem we obtain a bound on the circular average of the potential which involves the deviation from neutrality for the charge distribution within the disk. A comparison with the previous upper bound again leads to the desired result: Asymptotically the positive charge cannot be larger than the negative charge in the disk.

The details are as follows, the first steps being common to both arguments.

Proof of Theorem 4.3. Consider any maximal density sequence of radii and configurations defined in the previous Lemma 4.5. We use the lemma in two ways. First, taking $\varepsilon = 1/2$, we conclude that the sequence of radii $r_k := R_k/2$ and the corresponding number n_k of points $\{x_1, \ldots, x_{n_k}\}$ in $X_{N_k} \cap D(0, r_k)$ satisfy

$$\lim_{k \to \infty} \frac{n_k}{\pi r_k^2} = \rho_{\max}.$$
(4.21)

Second, for every $\varepsilon > 0$, the lemma implies that every point in the annulus

$$\mathcal{A} := D(0, R_k) \setminus D(0, r_k) \tag{4.22}$$

is at most a distance $O(\varepsilon r_k)$ from some point in $X_{N_k} \cap \mathcal{A}$ as $r_k \to \infty$. Let σ_k^{TF} be the TF density defined by the point charges $\{x_1, \ldots, x_{n_k}\} \subset D(0, r_k)$ and

$$\Phi_k^{\rm TF} = \left(\sum_{j=1}^{n_k} \delta_{x_j} - \sigma_k^{\rm TF}\right) * \left(-\log|.|\right)$$
(4.23)

the corresponding TF potential. From Prop. 4.2 we know that Φ_k^{TF} vanishes at all points in $X_{N_k} \cap \mathcal{A}$. Moreover, we know that

$$\int_{\Sigma_k^{TF}} \sigma_k^{\text{TF}} = n_k. \tag{4.24}$$

Pick some $\frac{1}{2} > \delta > 0$. For $|x| \ge (1+\delta)r_k$ a simple estimate gives a bound on the gradient of the potential:

$$|\nabla \Phi_k^{\rm TF}| \le C \frac{n_k}{\delta \cdot r_k}.\tag{4.25}$$

Indeed, if $|x| \ge (1+\delta)r_k$ then $|x-x_j| \ge \delta \cdot r_k$ for $j = 1, \ldots, n_k$ and thus

$$\sum_{j=1}^{n_k} \frac{1}{|x - x_j|} \le \frac{n_k}{\delta \cdot r_k}.$$
(4.26)

24

Also, splitting the integral into two regions where $|x - y| \ge \alpha = \sqrt{n_k}$ or vice-versa,

$$\int_{y \in \mathbb{R}^2} \frac{1}{|x-y|} \sigma_k^{\mathrm{TF}}(y) dy \leq \int_{|x-y| \leq \alpha} \frac{1}{|x-y|} dy + \alpha^{-1} \int_{\mathbb{R}^2} \sigma_k^{\mathrm{TF}} \leq C\alpha + n_k \alpha^{-1} \leq C\sqrt{n_k} \leq C \frac{n_k}{\delta \cdot r_k}$$
(4.27)

because $\int \sigma_k^{\text{TF}} = n_k$ and we know from Lemma 4.4 that $n_k \ge C r_k^2$.

Since every point in the annulus \mathcal{A} is at most a distance $O(\varepsilon r_k)$ from a point where Φ_k^{TF} vanishes, the gradient estimate (4.25) implies a bound on the potential in the annulus:

$$\sup_{x \in \mathcal{A}} |\Phi_k^{\mathrm{TF}}(x)| \le C\varepsilon r_k \frac{n_k}{\delta \cdot r_k} \le C\frac{\varepsilon}{\delta} r_k^2 (1+o(1))$$
(4.28)

where in the second inequality we used that n_k is in any case smaller than $4r_k^2(1+o(1))$ for large k by Lemma 4.4. With (4.28) at our disposal, we can conclude in two different ways:

First proof. By Equation (3.8) the bound (4.28) implies a bound on the largest radius \bar{r}_k of a disk $D(0, \bar{r}_k)$ containing the support of σ_k^{TF} :

$$\bar{r}_k \le \left((1+\delta)r_k + Cr_k\sqrt{\frac{\varepsilon}{\delta}} \right) (1+o(1)).$$
(4.29)

Choosing $\delta = \varepsilon^{1/3}$ to optimize the above we obtain

$$\bar{r}_k \le r_k (1 + C\varepsilon^{1/3})(1 + o(1)).$$
 (4.30)

Since $0 \le \sigma_k^{\text{TF}} \le 1$ this implies

$$n_k = \int_{\mathbb{R}^2} \sigma_k^{\rm TF} \le \pi \bar{r}_k^2 \le \pi r_k^2 (1 + C\varepsilon^{1/3})^2 (1 + o(1))$$
(4.31)

and thus, since $\varepsilon > 0$ is arbitrary,

$$\varrho_{\max} = \lim_{k \to \infty} \frac{n_k}{\pi r_k^2} \le 1.$$
(4.32)

Second proof. Let $\overline{\Phi}$ be the circular average (3.40) of Φ . By Newton's theorem [40, Theorem 9.7] we have in the complement of $D(0, r_k)$

$$\partial_r \bar{\Phi} = \frac{M(r) - n_k}{r}$$
 with $M(r) = \int_{D(0,r)} \sigma^{\mathrm{TF}}$

Thus, picking some fixed $\delta' > \delta > 0$,

$$\bar{\Phi}((1+\delta')r_k) - \bar{\Phi}((1+\delta)r_k) \le \left(\pi r_k^2 (1+\delta')^2 - n_k\right) \log \frac{1+\delta'}{1+\delta}$$

because $M(r) \leq \pi r^2$ is an increasing function. By construction we have, for large k, $n_k \geq \pi r_k^2 \rho_{\max}(1+o(1))$ and so

$$\bar{\Phi}((1+\delta')r_k) - \bar{\Phi}((1+\delta)r_k) \le \pi r_k^2 \left((1+\delta')^2 - \varrho_{\max} - o(1) \right) \log \frac{1+\delta'}{1+\delta}.$$

Combining with (4.28) we deduce

$$\pi r_k^2 \left((1+\delta')^2 - \varrho_{\max} - o(1) \right) \log \frac{1+\delta'}{1+\delta} \ge -C\frac{\varepsilon}{\delta} r_k^2$$

and thus

$$\varrho_{\max} \le (1+\delta')^2 (1+o(1)) + C \left(\log \frac{1+\delta'}{1+\delta}\right)^{-1} \frac{\varepsilon}{\delta}$$

for any $\varepsilon > 0$ and $\delta' > \delta > 0$ where the o(1) goes to when $k \to \infty$. We may thus take the limits $k \to \infty$, $\varepsilon \to 0$, $\delta \to 0$, $\delta' \to 0$, in this order to deduce that $\rho_{\max} \leq 1$ as desired.

4.3. Applications. After scaling, $x \to z = \sqrt{\pi \ell} x$, Theorem 4.3 applies to the Hamiltonian

$$H_N(Z_N) = \sum_{j=1}^N |z_j|^2 - 2\ell \sum_{1 \le i < j \le N} \log |z_i - z_j| + W(Z_N)$$
(4.33)

for any superharmonic function W of the N variables. To obtain a corresponding result for low-temperature Gibbs states, we shall later use a Feynman-Hellmann argument and thus need to obtain bounds for a perturbed version of (4.33):

$$H_N^{\varepsilon}(Z_N) = H_N(Z_N) + \varepsilon \sum_{i=1}^N U(z_i)$$
(4.34)

where $\varepsilon > 0$ is a small enough number.

Proposition 4.6 (Density bound for perturbed plasma ground states).

Assume $U \in C^2(\mathbb{R}^2)$ with ΔU uniformly bounded on \mathbb{R}^2 . Let $Z_N^0 = (z_1^0, \ldots, z_N^0)$ be a minimizing configuration for (4.34) and

$$\mu_{\varepsilon}^{0}(z) = \frac{1}{N} \sum_{i=1}^{N} \delta(z - z_{i}^{0})$$
(4.35)

the corresponding empirical measure. For any open set with Lipschitz boundary Ω , denote by Ω_r the set obtained by dilating Ω around some origin by a factor $r \xrightarrow[N \to \infty]{} \infty$. Then, as $N \to \infty$

$$\int_{\Omega_r} \mu_{\varepsilon}^0 \le \frac{1}{N\ell\pi} |\Omega_r| \left(1 + \frac{\varepsilon}{4} \|\Delta U\|_{\infty} \right) (1 + o(1))$$
(4.36)

with $\|\Delta U\|_{\infty} = \sup_{\mathbb{R}^2} |\Delta U|.$

Proof. For $\varepsilon = 0$ and Ω a disk this is just a combination of Proposition 4.2 and Theorem 4.3, together with the scaling $x \to \sqrt{\pi \ell} z$. For the perturbed Hamiltonian, we add and subtract

$$\frac{\varepsilon}{4} \sum_{i=1}^{N} \|\Delta U\|_{\infty} |z_i|^2 \tag{4.37}$$

and use the fact that $U(z) - \frac{1}{4} ||\Delta U||_{\infty} |z|^2$ is superharmonic. Hence

$$\varepsilon \sum_{i=1}^{N} \left(U(z_i) - \frac{1}{4} \|\Delta U\|_{\infty} |z_i|^2 \right)$$
 (4.38)

can be absorbed in W and we only need to reproduce the proof by writing (4.34) in the manner

$$H_N^{\varepsilon}(Z_N) = \left(1 + \frac{\varepsilon}{4} \|\Delta U\|_{\infty}\right) \left[\sum_{j=1}^N |z_j|^2 - 2\tilde{\ell} \sum_{1 \le i < j \le N} \log|z_i - z_j| + \widetilde{W}(Z_N)\right].$$
(4.39)

where $\tilde{\ell} = \left(1 + \frac{\varepsilon}{4} \|\Delta U\|_{\infty}\right)^{-1} \ell$ and \widetilde{W} is again superharmonic in each variable.

To obtain the result for a general domain Ω_r , we argue by covering it with disks, as in the "Cheese Theorem" [42, Section 14.4] which quantifies how effectively a region can be approximately covered with non-overlapping disks. We tile Ω_r with disks of radius \sqrt{r} , leaving an open set of area at most O(r) untiled. In the disks, we argue as previously. In the remaining untiled area we can use the rougher bound on the minimal separation of points, Lemma 4.4 to show that it contains at most O(r) points. This is of smaller order than the main contribution to (4.36), which comes from the disks, whose union contains $O(r^2)$ points, and the result follows.

5. Local density bounds for classical Gibbs states

Here we prove our main result Theorem 2.1. We proceed in two steps which are roughly as follows:

- we first obtain the result for fully-correlated states having angular momentum bounded by CN^2 for some C > 0. These have the bulk of their density contained in a region that is not vastly larger than the extension of the Laughlin state.
- next we eliminate the a priori angular momentum bound by a localization procedure.

5.1. Conditional local density bound. In order to combine neatly with the localization procedure used in Subsection 5.2 below, we must work in a slightly more general setting than discussed in Section 2.3. Let μ be a N-body probability density that we can write in the form

$$\boldsymbol{\mu}(z_1, \dots, z_N) = |\Psi_{\text{Lau}}(z_1, \dots, z_N)|^2 \prod_{j=1}^N \exp\left(-\frac{|z_j - a|^2}{L^2}\right) G(z_1, \dots, z_N)$$
(5.1)

where L > 0 is a number and log G is subharmonic (see e.g. [40, Chapter 9] for equivalent characterizations):

$$G \ge 0$$
 and $\Delta_j \log G \ge 0$ for any $j = 1 \dots N$. (5.2)

Note that G need not be the modulus of an analytic function here. It could, in fact, be of the form $G = |F_1| + |F_2|$ with F_1 and F_2 analytic, and we shall use this later, see Lemma 5.2 below.

Marginal probabilities of μ will be denoted as

$$\boldsymbol{\mu}^{(k)}(z_1,\ldots,z_k) = \int_{\mathbb{R}^{2(N-k)}} \boldsymbol{\mu}(z_1,\ldots,z_N) dz_{k+1} \ldots dz_N.$$
(5.3)

In this subsection we prove the following on the first marginal density:

Theorem 5.1 (Conditional density bound).

Take $L \geq 1$ in (5.1). For any disk D of radius $r = N^{\alpha}$, $\alpha > 1/4$, any choice of origin $a \in \mathbb{R}^2$

$$\int_{D} \boldsymbol{\mu}^{(1)} \leq \frac{1}{N\ell\pi} |D| \left(1 + o_D(1) + O(L^{-2}) \right) + CN^{-1-2\alpha'} \int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\mu}^{(1)}(z) dz \qquad (5.4)$$

for any $\alpha' < \alpha$ where |D| is the area of the disk and $o_D(1)$ tends to zero as $|D| \to \infty$.

To see how this relates to our main result, think of the case where $\mu = |\Psi_F|^2$ is the density of a fully-correlated state, that is where $L = +\infty$ and G = |F| with F analytic. Assuming a total angular momentum of order N^2

$$\left\langle \Psi_F \Big| \sum_{j=1}^N z_j \partial_{z_j} - \bar{z}_j \partial_{\bar{z}_j} \Big| \Psi_F \right\rangle \le CN^2 \tag{5.5}$$

we have (see e.g. [56, Equation (2.18)])

$$\int_{\mathbb{R}^2} |z|^2 \mu^{(1)}(z) dz \le CN.$$
(5.6)

Theorem 2.1 follows in this case by taking a = 0: the main (first) term behaves as $N^{-1+2\alpha} \gg N^{-1+2\alpha'}$ and the error (second term) as $N^{-2\alpha'}$, thus the statement is meaningful for $\alpha > 1/4$.

Proof. The method is basically the same as in [58, Section 3.1]. We first write μ as a Boltzmann-Gibbs factor:

$$\mu(z_1, \dots, z_N) = \frac{1}{\mathcal{Z}_N} \exp\left(-\mathbb{H}_N(z_1, \dots, z_N)\right)$$
$$\mathbb{H}_N(Z_N) = \sum_{j=1}^N \left(|z_j|^2 + \frac{|z_j - a|^2}{L^2}\right) - 2\ell \sum_{1 \le i < j \le N} \log|z_i - z_j| - \log G(z_1, \dots, z_N)$$
(5.7)

with \mathcal{Z}_N a normalization constant. Thus μ minimizes the free-energy functional

$$\mathcal{E}_{N}^{0}[\boldsymbol{\nu}] := \int_{\mathbb{R}^{2N}} \mathbb{H}_{N}(Z_{N}) d\boldsymbol{\nu}(Z_{N}) + \int_{\mathbb{R}^{2N}} \boldsymbol{\nu} \log \boldsymbol{\nu}$$
(5.8)

over all N-particles probability densities $\boldsymbol{\nu}$. We denote by $E_N^0 = -\log \mathcal{Z}_N$ the minimum value.

For $r, \delta > 0$ let U_r denote the negative characteristic function of a disk with radius r. Let $U_{r,\delta}$ be a regularization over a distance δ so that

$$\|\Delta U_{r,\delta}\|_{\infty} \le C\delta^{-2}.\tag{5.9}$$

We may choose the regularization in such a way that

$$U_{r+\delta} \le U_{r,\delta} \le U_r. \tag{5.10}$$

Consider now a perturbed version of the above classical Hamiltonian \mathbb{H}_N :

$$\mathbb{H}_{N}^{\varepsilon}(Z_{N}) = \mathbb{H}_{N}(Z_{N}) + \varepsilon \sum_{j=1}^{N} U_{r,\delta}(z_{j})$$
(5.11)

along with the associated free-energy functional

$$\mathcal{E}_{N}^{\varepsilon}[\boldsymbol{\nu}] := \int_{\mathbb{R}^{2N}} \mathbb{H}_{N}^{\varepsilon}(Z_{N}) d\boldsymbol{\nu}(Z_{N}) + \int_{\mathbb{R}^{2N}} \boldsymbol{\nu} \log \boldsymbol{\nu}$$
(5.12)

whose minimum we denote by E_N^{ε} . By definition we have

$$\mathcal{E}_{N}^{\varepsilon}[\boldsymbol{\mu}] = E_{N}^{0} + \varepsilon N \int_{\mathbb{R}^{2}} U_{r,\delta} \boldsymbol{\mu}^{(1)}$$
(5.13)

and we will obtain our density estimate from upper and lower bounds to this free energy. **Free-energy upper bound.** We need an upper bound on E_N^0 . We use the trial state

$$\boldsymbol{\mu}^{t}(z_{1},\ldots,z_{N}) := \left(\frac{1}{\pi\eta^{2}}\right)^{N} \mathbb{1}_{z_{1}\in D(z_{1}^{0},\eta)} \otimes \ldots \otimes \mathbb{1}_{z_{N}\in D(z_{N}^{0},\eta)}.$$
(5.14)

where $Z_N^0 = (z_1^0, \ldots, z_N^0)$ is a minimizing configuration for H_N . We have

$$\int_{\mathbb{R}^{2N}} \boldsymbol{\mu}^t \log \boldsymbol{\mu}^t = -N \log(\pi \eta^2)$$
(5.15)

and

$$\int_{\mathbb{R}^{2N}} \mathbb{H}_N(Z_N) \boldsymbol{\mu}^t(Z_N) dZ_N \leq \sum_{j=1}^N \left(\frac{1}{\pi \eta^2} \int_{D(z_j^0, \eta)} |z|^2 dz + \frac{1}{L^2 \pi \eta^2} \int_{D(z_j^0, \eta)} |z_j - a|^2 dz \right) \\ - 2\ell \sum_{1 \leq i < j \leq N} \log |z_i^0 - z_j^0| - \log G(Z_N^0), \quad (5.16)$$

because superharmonicity in each variable of the function

$$(z_1, \dots, z_N) \mapsto -2\ell \sum_{1 \le i < j \le N} \log |z_i - z_j| - \log G(Z_N)$$
(5.17)

implies that it cannot increase upon taking an average over disks centered at the z_i^0 's (see e.g. [40, Chapter 9]). For the one-body term we have, integrating in polar coordinates

$$\frac{1}{\pi\eta^2} \int_{D(z_j^0,\eta)} |z|^2 dz = \frac{1}{\pi\eta^2} \int_{D(0,\eta)} |z + z_j^0|^2 dz = |z_j^0|^2 + \frac{1}{\pi\eta^2} \int_{D(0,\eta)} |z|^2 dz = |z_j^0|^2 + \frac{\eta^2}{2}$$
(5.18)

and by the same token, since $L \ge 1$

$$\frac{1}{L^2 \pi \eta^2} \int_{D(z_j^0,\eta)} |z_j - a|^2 dz \le \frac{1}{L^2} |z_j^0 - a|^2 + \frac{\eta^2}{2}.$$
(5.19)

Fixing η we thus deduce

$$\mathcal{E}_{N}^{\varepsilon}[\boldsymbol{\mu}] \leq \min_{\mathbb{R}^{2N}} \mathbb{H}_{N}^{0} + \varepsilon N \int_{\mathbb{R}^{2}} U_{r,\delta} \boldsymbol{\mu}^{(1)} + CN.$$
(5.20)

Free-energy lower bound. By positivity of the relative entropy (Jensen's inequality) we have, for any pair of probability measures $\boldsymbol{\nu}, \boldsymbol{\nu}^t$,

$$\int_{\mathbb{R}^{2N}} \boldsymbol{\nu} \log \boldsymbol{\nu} \ge \int_{\mathbb{R}^{2N}} \boldsymbol{\nu} \log \boldsymbol{\nu}^t.$$
(5.21)

Taking

$$\boldsymbol{\nu}^{t}(z_{1},\ldots,z_{N}) := (\pi N)^{-N} \prod_{j=1}^{N} \exp\left(-\frac{|z_{j}-a|^{2}}{N}\right)$$
(5.22)

we deduce that for any probability measure

$$\int_{\mathbb{R}^{2N}} \boldsymbol{\nu} \log \boldsymbol{\nu} \ge -\int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\nu}^{(1)}(z) dz - O(N \log N).$$
(5.23)

Thus

$$\mathcal{E}_{N}^{\varepsilon}[\boldsymbol{\mu}] \geq \int_{\mathbb{R}^{2N}} \mathbb{H}_{N}^{\varepsilon}(Z_{N})\boldsymbol{\mu}(Z_{N})dZ_{N} - \int_{\mathbb{R}^{2}} |z-a|^{2}\boldsymbol{\mu}^{(1)}(z)dz - O(N\log N)$$
(5.24)

$$\geq \min_{\mathbb{R}^{2N}} \mathbb{H}_N^{\varepsilon} - \int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\mu}^{(1)}(z) dz - O(N \log N)$$
(5.25)

$$\geq \min_{\mathbb{R}^{2N}} \mathbb{H}_N^0 + \varepsilon N \int_{\mathbb{R}^2} U_{r,\delta} \mu_{\varepsilon}^0 - \int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\mu}^{(1)}(z) dz - O(N \log N)$$
(5.26)

where μ_{ε}^{0} is the empirical measure of a minimizing configuration for $\mathbb{H}_{N}^{\varepsilon}$.

Conclusion. Combining with (5.20) we deduce

$$\int_{\mathbb{R}^2} U_{r,\delta} \boldsymbol{\mu}^{(1)} \ge \int_{\mathbb{R}^2} U_{r,\delta} \boldsymbol{\mu}_{\varepsilon}^0 - (\varepsilon N)^{-1} \int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\mu}^{(1)}(z) dz - C\varepsilon^{-1} \log N.$$
(5.27)

But, by (5.10) we have

$$\int_{D_r} \boldsymbol{\mu}^{(1)} = -\int_{\mathbb{R}^2} U_r \boldsymbol{\mu}^{(1)} \le -\int_{\mathbb{R}^2} U_{r,\delta} \boldsymbol{\mu}^{(1)}$$
(5.28)

and

$$-\int_{\mathbb{R}^2} U_{r,\delta} \mu_{\varepsilon}^0 \le \int_{D_{r+\delta}} \mu_{\varepsilon}^0.$$
(5.29)

Proposition 4.6 applies to μ_0^{ε} because it is the empirical measure of a minimizing configuration for (5.7) (compare with (4.34)). All in all we thus have

$$\int_{D_r} \boldsymbol{\mu}^{(1)} \le \pi N^{-1} (r+\delta)^2 \left(1 + o(1) + \frac{C}{L^2} + \varepsilon \delta^{-2} \right) + \varepsilon^{-1} \log N + (\varepsilon N)^{-1} \int_{\mathbb{R}^2} |z-a|^2 \boldsymbol{\mu}^{(1)}(z) dz$$
(5.30)

where we have used (5.9) and assumed that $r + \delta \gg 1$. Consider now the case that $r = N^{\alpha}$ with $\alpha > 1/4$. We can then clearly choose ε, δ in dependence of r so as to have

$$r \gg \delta \gg \varepsilon^{1/2} \gg (N \log N)^{1/2} r^{-1}, \tag{5.31}$$

which implies

$$N^{-1}r^2 \gg \varepsilon^{-1}\log N \text{ and } 1 \gg \varepsilon \delta^{-2}$$
 (5.32)

and thus (5.4) follows.

30

5.2. Localization procedure. We now want to extend Theorem 5.1 by dropping the angular momentum constraint. We use a rather standard localization procedure, see e.g. [37, 52] for its discussion in more general contexts. In order for the localization method to combine efficiently with what we have proved so far, we need the following elementary lemma:

Lemma 5.2 (The PL class).

The class of functions G satisfying (5.2) is closed under addition. Thus any function G that can be written in the manner $G = \sum_j \alpha_j |F_j|$ with α_j positive numbers and F_j analytic functions satisfies (5.2).

Proof. This is a well-known fact, see e.g. [50, Paragraphs 2.12 to 2.14] where (5.2) is called the PL class. One can verify it by a simple computation: if G, H satisfy (5.2) we have

$$\Delta \log G = \frac{G\Delta G - |\nabla G|^2}{G^2} \ge 0 \tag{5.33}$$

and the same for H, thus

$$(G+H)^{2}\Delta\log(G+H) = (G+H)(\Delta G+\Delta H) - |\nabla G+\nabla H|^{2}$$

$$= G\Delta G - |\nabla G^{2}| + H\Delta H - |\nabla H|^{2} + G\Delta H + H\Delta G - 2\nabla G \cdot \nabla H$$

$$\geq \frac{G}{H}|\nabla H|^{2} + \frac{H}{G}|\nabla G|^{2} - 2\nabla G \cdot \nabla H$$

$$\geq \left|\sqrt{\frac{G}{H}}\nabla H - \sqrt{\frac{H}{G}}\nabla G\right|^{2} \geq 0.$$
 (5.34)

The rest of the statement follows because any |F| with F analytic satisfies (5.2) as remarked after Equation (2.24). See also [29, Page 84].

We now proceed to extending Theorem 5.1 to states not necessarily satisfying (5.5). This will conclude the

Proof of Theorem 2.1. For $\Psi_F \in \mathcal{L}_N^{\ell}$ define

$$\boldsymbol{\mu}_F(z_1, \dots, z_N) = |\Psi_F(z_1, \dots, z_N)|^2.$$
(5.35)

Localization procedure. We define a smooth partition of unity on \mathbb{R}^2

$$\chi^2 + \eta^2 \equiv 1, \quad \chi^2(z) = e^{-\frac{|z-a|^2}{L^2}}$$
 (5.36)

with $L \to \infty$ a length scale to be optimized over. Consider the classical *M*-particle state μ_M built from μ by localizing exactly *M* particles and integrating out the other:

$$\boldsymbol{\mu}_{M}(z_{1},\ldots,z_{M}) := \prod_{j=1}^{M} \chi^{2}(z_{j}) \int_{\mathbb{R}^{2(N-M)}} \prod_{j=M+1}^{N} \eta^{2}(z_{j}) \boldsymbol{\mu}_{F}(Z_{N}) dz_{M+1} \ldots dz_{N}.$$
(5.37)

Observe that, by symmetry under particle exchange,

$$\boldsymbol{\mu}_{F}(Z_{N}) = \sum_{M=0}^{N} \binom{N}{M} \prod_{j=1}^{M} \chi^{2}(z_{j}) \prod_{j=M+1}^{N} \eta^{2}(z_{j}) \boldsymbol{\mu}_{F}(Z_{N})$$
(5.38)

and thus the L^2 -normalization of Ψ_F implies

$$\sum_{M=0}^{N} \binom{N}{M} \int_{\mathbb{R}^{2M}} \mu_M = 1.$$
(5.39)

Next, recalling (2.3) and (5.3) we denote by $\mu_F^{(1)} = N^{-1}\rho_F$ the one-particle probability density of Ψ_F . By symmetry under particle exchange again, we have

$$\chi^{2}(z_{1})\boldsymbol{\mu}_{F}^{(1)}(z_{1}) = \int_{\mathbb{R}^{2(N-1)}} \chi^{2}(z_{1})\boldsymbol{\mu}_{F}(Z_{N})dz_{2}\dots dz_{N}$$

$$= \int_{\mathbb{R}^{2(N-1)}} \chi^{2}(z_{1}) \prod_{M=2}^{N} \left(\chi^{2}(z_{M}) + \eta^{2}(z_{M})\right) \boldsymbol{\mu}_{F}(Z_{N})dz_{2}\dots dz_{N}$$

$$= \sum_{M=1}^{N} \binom{N-1}{M-1} \int_{\mathbb{R}^{2(N-1)}} \chi^{2}(z_{1})\dots\chi^{2}(z_{M})\eta^{2}(z_{M+1})\dots\eta^{2}(z_{N})\boldsymbol{\mu}_{F}(Z_{N})dz_{2}\dots dz_{N}$$

$$= \sum_{M=1}^{N} \binom{N-1}{M-1} \boldsymbol{\mu}_{M}^{(1)}.$$
(5.40)

Finally, since clearly $|z - a|^2 \chi^2(z) \le L^{2+\delta}$ for arbitrary $\delta > 0$ we have

$$\sum_{M=1}^{N} \binom{N-1}{M-1} \int_{\mathbb{R}^{2}} |z_{1}-a|^{2} \boldsymbol{\mu}_{M}^{(1)}(z_{1}) dz_{1} \\
= \sum_{M=1}^{N} \binom{N-1}{M-1} \int_{\mathbb{R}^{2M}} |z_{1}-a|^{2} \prod_{j=1}^{M} \chi^{2}(z_{j}) \prod_{j=M+1}^{N} \eta^{2}(z_{j}) \boldsymbol{\mu}_{F}(Z_{N}) dz_{1} \dots dz_{N} \\
\leq L^{2+\delta} \int_{\mathbb{R}^{2M}} \sum_{M=1}^{N} \binom{N-1}{M-1} \prod_{j=2}^{M} \chi^{2}(z_{j}) \prod_{j=M+1}^{N} \eta^{2}(z_{j}) \boldsymbol{\mu}_{F}(Z_{N}) dz_{1} \dots dz_{N} \\
\leq L^{2+\delta} \int_{\mathbb{R}^{2M}} \prod_{j=2}^{N} \left(\chi^{2}(z_{j}) + \eta^{2}(z_{j}) \right) \boldsymbol{\mu}_{F}(Z_{N}) dz_{1} \dots dz_{N} \leq L^{2+\delta}. \quad (5.41)$$

Application. Pick a disk D of center $a \in \mathbb{R}^2$ and radius $r = N^{\alpha}$ with $\alpha > 1/4$ and choose

$$\chi^2(z) = \exp\left(-\frac{|z-a|^2}{L^2}\right)$$
 (5.42)

with $L = N^{\beta}, \beta > \alpha$. Then clearly

$$\int_{D} \mu_{F}^{(1)} \le (1 + o(1)) \int_{D} \chi^{2} \mu_{F}^{(1)}$$
(5.43)

and we expect the right-hand side to be at most of order $N^{-1+2\alpha}$. To estimate it, we start from (5.40) and first brutally get rid of terms with small M for they have too few particles

to contribute to the density at this scale:

$$\int_{D} \chi^{2} \boldsymbol{\mu}_{F}^{(1)} = \sum_{M=1}^{N} {\binom{N}{M}} \frac{M}{N} \int_{D} \boldsymbol{\mu}_{M}^{(1)}$$

$$\leq N^{\gamma-1} \sum_{M=1}^{N^{\gamma}} {\binom{N}{M}} \int_{D} \boldsymbol{\mu}_{M}^{(1)} + \sum_{M=N^{\alpha}}^{N} {\binom{N}{M}} \frac{M}{N} \int_{D} \boldsymbol{\mu}_{M}^{(1)}$$

$$\leq N^{\gamma-1} \sum_{M=1}^{N^{\gamma}} {\binom{N}{M}} \int_{\mathbb{R}^{2M}} \boldsymbol{\mu}_{M} + \sum_{M=N^{\alpha}}^{N} {\binom{N}{M}} \frac{M}{N} \int_{D} \boldsymbol{\mu}_{M}^{(1)}$$

$$\leq N^{\gamma-1} + \sum_{M=N^{\gamma}}^{N} {\binom{N}{M}} \frac{M}{N} \int_{D} \boldsymbol{\mu}_{M}^{(1)}$$
(5.44)

where we used that

$$\binom{N}{M} = \frac{N}{M} \binom{N-1}{M-1}$$
(5.45)

and inserted (5.39). We pick $\gamma < 2\alpha$ to render the first term $N^{\gamma-1}$ in the above much smaller than the expected $N^{-1+2\alpha}$, so that we may focus on the second one.

We thus need to bound the 1-particle probability density $\mu_M^{(1)}$, first marginal of the *M*-particles state μ_M . Recalling (5.37) we can write

$$\boldsymbol{\mu}_{M}(z_{1},\ldots,z_{k}) = |\Psi_{\text{Lau}}(z_{1},\ldots,z_{M})|^{2} \exp\left(-\sum_{j=1}^{M} \frac{|z_{j}-a|^{2}}{L^{2}}\right) G_{M}(z_{1},\ldots,z_{M}) \quad (5.46)$$

where $(c_M \text{ is a positive constant ensuring normalization of (5.46)})$

$$G_M(z_1, \dots, z_M) = c_M \int_{\mathbb{R}^{2(N-M)}} \prod_{j=M+1}^N \eta^2(z_j) e^{-|z_j|^2} \prod_{\substack{M+1 \le i < j \le N}} |z_i - z_j|^{2\ell} |z_{M+1} - |z_i|^{2\ell} dz_{M+1} \dots dz_N. \quad (5.47)$$

At fixed z_{M+1}, \ldots, z_M , the integrand in the above is the squared modulus of an analytic function of the variables z_1, \ldots, z_M (they appear only in the second line) and is thus subharmonic. Since the PL class is closed under addition, c.f. Lemma 5.2, we deduce that G_M satisfies Assumption (5.2). We can thus apply (5.4) to the normalized version of μ_M and deduce

$$\frac{\int_{D} \boldsymbol{\mu}_{M}^{(1)}}{\int_{\mathbb{R}^{2M}} \boldsymbol{\mu}_{M}} \leq \frac{1}{M\ell\pi} |D| \left(1 + o_{D}(1) + O\left(L^{-2}\right) \right) + CM^{-1-2\alpha'} \int_{\mathbb{R}^{2}} |z-a|^{2} \boldsymbol{\mu}_{M}^{(1)}(z) dz \quad (5.48)$$

for any $\alpha' < \alpha$. Next, we sum the above inequalities from $M = N^{\gamma}$ to N and insert the result in (5.44) to obtain

$$\int_{D} \chi^{2} \boldsymbol{\mu}_{F}^{(1)} \leq \sum_{M=N^{\gamma}}^{N} {N \choose M} \frac{M}{N} \left(\int_{\mathbb{R}^{2M}} \boldsymbol{\mu}_{M} \right) \frac{|D|}{\pi \ell M} (1 + o_{N}(1)) + CN^{-\gamma - 2\gamma \alpha'} \sum_{M=N^{\gamma}}^{N} {N \choose M} \frac{M}{N} \int_{\mathbb{R}^{2}} |z - a|^{2} \boldsymbol{\mu}_{M}^{(1)}(z) dz + N^{\gamma - 1}$$
(5.49)

where we have used that we sum only terms where $M \gg 1$ to ensure that the $o_D(1)$ terms are indeed small. We next insert (5.39) in the first sum and use (5.45) in combination with (5.41) to deal with the second one, obtaining

$$\int_{D} \chi^{2} \boldsymbol{\mu}_{F}^{(1)} \leq \frac{|D|}{\pi \ell N} \left(1 + o_{N}(1)\right) + C N^{-\gamma - 2\gamma \alpha' + (2+\delta)\beta} + N^{\gamma - 1}.$$
(5.50)

To optimize over γ we take

$$\gamma = \frac{1}{2 + 2\alpha'} + \frac{(1+\delta)\beta}{2 + 2\alpha'}$$
(5.51)

and since we are at liberty to choose α', β arbitrarily close to α and δ arbitrarily small, we can render γ arbitrarily close to 1/2, so that the error terms in (5.50) become $O(N^{-1/2+\varepsilon})$ for arbitrarily small $\varepsilon > 0$. For $\alpha > 1/4$ we deduce

$$\int_{D} \boldsymbol{\mu}_{F}^{(1)} \le (1+o(1)) \int_{D} \chi^{2} \boldsymbol{\mu}_{F}^{(1)} \le \frac{|D|}{\pi \ell N} (1+o_{N}(1))$$
(5.52)

as desired because the main term is of order $N^{-1+2\alpha}$. To deduce the general result (2.5) we can simply replace indicative functions of disks by indicative functions of more general open sets everywhere in Section 5, relying on (4.36) for a general open set.

6. Energy in confining potentials

Corollary 2.5 follows from Corollary 2.3 in exactly the same way as in [57, Section 4.2], utilizing results from [56]. Details are thus omitted, and we focus on the

Proof of Corollary 2.3. This is a variation on the arguments of Section 5.1, but it is more convenient to work with scaled variables as in [58, Section 3]. We thus write, with the notation of Asumption 2.2

$$\int_{\mathbb{R}^2} V\rho_F = N \int_{\mathbb{R}^2} U\mu_F^{(1)} \tag{6.1}$$

with the scaled one-particle probability density

$$\mu_F^{(1)}(x) = \rho_F\left(\sqrt{N}x\right). \tag{6.2}$$

We will deduce the result from the lower bound

$$\int_{\mathbb{R}^2} U\mu_F^{(1)} \ge (1+o(1)) \inf\left\{\int_{\mathbb{R}^2} U\mu \mid 0 \le \mu \le \frac{1}{\pi\ell}, \ \int_{\mathbb{R}^2} \mu = 1\right\} + o(1) \tag{6.3}$$

by a simple change of variables.

Let L > R be a large but fixed number, with R as in Asumption 2.2. Define a $U_L \leq U$ such that

$$U_L = \begin{cases} U \text{ in } D(0,L) \\ \underline{U} \text{ in } D(0,2L)^c \end{cases}$$

$$(6.4)$$

and U_L satisfies the same bounds (2.10)- (2.11) as \underline{U} outside of D(0, L). We then consider (compare with (2.26))

$$\tilde{H}_N^{\varepsilon}(z_1, \dots, z_N) = \sum_{j=1}^N \left(|z_j|^2 + \varepsilon U_L(z_j) \right) - 2\frac{\ell}{N} \sum_{1 \le i < j \le N} \log |z_i - z_j| - \frac{2}{N} \log |F(\sqrt{N}z_1, \dots, \sqrt{N}z_N)| \quad (6.5)$$

and estimate (recall the notation (2.25))

$$\tilde{\mathcal{E}}_{N}^{\varepsilon}[\mu_{F}] := \int_{\mathbb{R}^{2N}} \tilde{H}_{N}^{\varepsilon} \mu_{F} + \frac{1}{N} \int_{\mathbb{R}^{2N}} \mu_{F} \log \mu_{F}.$$
(6.6)

Since μ_F is the Gibbs state at temperature 1/N associated with $\tilde{H}_N^{\varepsilon}$ and $\mu_F^{(1)}$ its first marginal we have

$$\tilde{\mathcal{E}}_{N}^{\varepsilon}[\mu_{F}] = \varepsilon N \int_{\mathbb{R}^{2}} U_{L} \mu_{F}^{(1)} + \int_{\mathbb{R}^{2N}} \tilde{H}_{N}^{0} \mu_{F} + \frac{1}{N} \int_{\mathbb{R}^{2N}} \mu_{F} \log \mu_{F}$$

$$\leq \varepsilon N \int_{\mathbb{R}^{2}} U_{L} \mu_{F}^{(1)} + \min_{\mathbb{R}^{2N}} \tilde{H}_{N}^{0} + C(\log N + 1)$$
(6.7)

using a trial state similar to (5.14) to bound the minimal free energy at temperature 1/N associated with \tilde{H}_N^0 , exactly as in [58, Section 3.1].

On the other hand, by Jensen's inequality

$$\int_{\mathbb{R}^{2N}} \mu_F \log \mu_F \ge \int_{\mathbb{R}^{2N}} \mu_F \log \left(\frac{e^{-U_L}}{\int_{\mathbb{R}^2} e^{-U_L}} \right)^{\otimes N}$$
$$\ge -N \int_{\mathbb{R}^2} U_L \mu_F^{(1)} - CN \tag{6.8}$$

where we used (2.11) to bound $\int_{\mathbb{R}^2} e^{-U_L}$. Thus

$$\tilde{\mathcal{E}}_{N}^{\varepsilon}[\mu_{F}] \geq \min_{\mathbb{R}^{2N}} \left\{ \tilde{H}_{N}^{\varepsilon}(z_{1},\ldots,z_{N}) - \frac{1}{N} \sum_{j=1}^{N} U_{L}(z_{j}) \right\} - C$$
$$\geq \min_{\mathbb{R}^{2N}} \tilde{H}_{N}^{0} + (N\varepsilon - 1) \int_{\mathbb{R}^{2}} U_{L} \tilde{\mu}_{\varepsilon}^{0} - C$$
(6.9)

where

$$\tilde{\mu}_{\varepsilon}^{0}(z) = \frac{1}{N} \sum_{i=1}^{N} \delta(z - z_{i}^{0})$$
(6.10)

is the empirical measure of a configuration (z_1^0, \ldots, z_N^0) minimizing the classical Hamiltonian $\tilde{H}_N^{\varepsilon}(z_1, \ldots, z_N) - \frac{1}{N} \sum_{j=1}^N U_L(z_j)$. We can apply a (re-scaled version of) Proposition 4.6 to $\tilde{\mu}^0_{\varepsilon}$. Thus, for any domain Ω_r obtain from a fixed Lipschitz Ω by scaling lengths by a factor $r = N^{\alpha'}$, $\alpha' > -1/2$

$$\int_{\Omega_r} \tilde{\mu}_{\varepsilon}^0 \leq \frac{1}{\ell \pi} |\Omega_r| \left(1 + \frac{\varepsilon}{4} \|\Delta U_L\|_{\infty} \right) (1 + o(1))$$
$$\leq \frac{1}{\ell \pi} |\Omega_r| \left(1 + C\varepsilon N^{1-2\alpha} \right) (1 + o(1))$$
(6.11)

where we used (2.9) to estimate $\|\Delta U_L\|_{\infty}$. By a Riemann sum approximation on a grid of side length $N^{\alpha'}$ we then have

$$\int_{\mathbb{R}^2} U_L \tilde{\mu}_{\varepsilon}^0 \ge \int_{\mathbb{R}^2} U_L \hat{\mu}_{\varepsilon}^0 - C \|\nabla U_L\|_{L^{\infty}} N^{\alpha'}$$
(6.12)

where $\hat{\mu}_{\varepsilon}^{0}$ is a piecewise constant function satisfying

$$0 \le \hat{\mu}_{\varepsilon}^0 \le \frac{1}{\ell \pi} \left(1 + C \varepsilon N^{2\beta} \right) \left(1 + o(1) \right)$$
(6.13)

and

$$\int_{\mathbb{R}^2} \hat{\mu}_{\varepsilon}^0 = 1. \tag{6.14}$$

Since, using (2.9), $\|\nabla U_L\|_{L^{\infty}} \leq CN^{1/2-\alpha}$ we deduce

$$\tilde{\mathcal{E}}_{N}^{\varepsilon}[\mu_{F}] \geq \min_{\mathbb{R}^{2N}} \tilde{H}_{N}^{0} + (N\varepsilon - 1) \int_{\mathbb{R}^{2}} U_{L} \hat{\mu}_{\varepsilon}^{0} - CN^{1/2 + \alpha' - \alpha}$$
(6.15)

for any fixed $\alpha > -1/2$. Comparing with (6.7) we obtain

$$\int_{\mathbb{R}^{2}} U\mu_{F}^{(1)} \geq \left(1 - \frac{1}{\varepsilon N}\right) \int_{\mathbb{R}^{2}} U_{L}\hat{\mu}_{\varepsilon}^{0} - \frac{C\log N}{\varepsilon N} - \frac{CN^{1/2 + \alpha' - \alpha}}{\varepsilon N} \\
\geq \left(1 - \frac{1}{\varepsilon N}\right) \inf \left\{ \int_{\mathbb{R}^{2}} U_{L}\mu \mid 0 \leq \mu \leq \frac{1}{\pi \ell} \left(1 + C\varepsilon N^{1 - 2\alpha}\right) (1 + o(1)), \int_{\mathbb{R}^{2}} \mu = 1 \right\} \\
- \frac{C\log N}{\varepsilon N} - \frac{CN^{1/2 + \alpha' - \alpha}}{\varepsilon N}$$
(6.16)

where we used that $U \ge U_L$. Since $\alpha > 0$ and α' can be chosen arbitrarily close to -1/2in the above, we can choose $\varepsilon = N^{-\delta}$ with some δ less than, but sufficiently close to, 1 to get

$$\int_{\mathbb{R}^2} U\mu_F^{(1)} \ge (1 - o(1)) \inf\left\{\int_{\mathbb{R}^2} U_L \mu \mid 0 \le \mu \le \frac{1}{\pi\ell}, \int_{\mathbb{R}^2} \mu = 1\right\} + o(1)$$
(6.17)

The continuity of the bathtub energy as a function of the upper density constraint we have just used is a consequence of the explicit solution of the minimization problem [40, Theorem 1.14]. To conclude the proof of (6.3) we note that, under our asumptions on U, it suffices to take L large enough but fixed to have

$$\inf\left\{\int_{\mathbb{R}^2} U_L \mu \mid 0 \le \mu \le \frac{1}{\pi\ell}, \ \int_{\mathbb{R}^2} \mu = 1\right\} = \inf\left\{\int_{\mathbb{R}^2} U\mu \mid 0 \le \mu \le \frac{1}{\pi\ell}, \ \int_{\mathbb{R}^2} \mu = 1\right\}.$$
(6.18)

This follows from the fact that minimizers of the bathtub energy are equal to either 0 or $(\pi \ell)^{-1}$ almost everywhere, and that for potentials increasing at infinity, their support is compact.

7. Conclusions

By employing a new theorem about multi-particle screening we have derived sharp local upper bounds on the particle density in ground states of a classical 2D Coulomb gas perturbed by arbitrary many-body potentials that are superharmonic in every variable. We have also derived corresponding bounds for Gibbs states which, via Laughlin's plasma analogy, have direct applications to quantum many-particle states in strong magnetic fields exhibiting the Fractional Quantum Hall Effect (FQHE) and which are fully correlated in order to minimize a repulsive interaction between the particles. Our results hold asymptotically for large particle numbers, on length scales that are small compared to the full system's extension. We expect that there is room for improvement as regards the smallest length scale we can afford. This remains an *open problem*.

The bounds for the classical Coulomb ground states rest on two pillars: First, an "exclusion rule" for ground state configurations which prevents points in such a configuration from entering a screening region defined by the other points in the configuration. Second, a universal density bound that we prove for any configuration of points satisfying the exclusion rule.

For the Gibbs state the modification of the ground state density caused by the entropy term in the free energy has to be estimated. This is done by perturbing the classical Coulomb Hamiltonian locally and bounding the perturbed free energy, obtaining a density bound via the Feynman-Hellmann principle. This procedure is first carried out under the assumption of an a-priori bound on the angular momentum and then extended to the general case by a localization argument.

Besides the density bounds we also derive lower bounds for the energy of fully correlated FQHE states confined in external potentials. In combination with previously obtained upper bounds this establishes the Laughlin state as an approximate quantum mechanical ground state in the class of strongly correlated FQHE states for radially increasing external potentials. For a potential of a "Mexican-hat" shape the ground state is well approximated by a modification of the Laughlin state by quasi-holes placed at the origin. An *open problem* is to show that perturbations by general external potentials can be handled similarly, i.e., that good approximate ground states for them can be obtained by generating uncorrelated quasi-holes.
