# PARABOLIC TRANSMISSION EIGENVALUE-FREE REGIONS IN THE DEGENERATE ISOTROPIC CASE 

GEORGI VODEV


#### Abstract

We study the location of the transmission eigenvalues in the isotropic case when the restrictions of the refraction indices on the boundary coincide. Under some natural conditions we show that there exist parabolic transmission eigenvalue-free regions.


## 1. Introduction and statement of results

Let $\Omega \subset \mathbf{R}^{d}, d \geq 2$, be a bounded, connected domain with a $C^{\infty}$ smooth boundary $\Gamma=\partial \Omega$. A complex number $\lambda \in \mathbf{C}, \lambda \neq 0, \operatorname{Re} \lambda \geq 0$, will be said to be a transmission eigenvalue if the following problem has a non-trivial solution:

\begin{cases}\left(\Delta+\lambda^{2} n_{1}(x)\right) u_{1}=0 & \text { in } \quad \Omega,  \tag{1.1}\\ \left(\Delta+\lambda^{2} n_{2}(x)\right) u_{2}=0 & \text { in } \quad \Omega, \\ u_{1}=u_{2}, \partial_{\nu} u_{1}=\partial_{\nu} u_{2} & \text { on } \\ \Gamma,\end{cases}
$$

where $\nu$ denotes the Euclidean unit inner normal to $\Gamma, n_{j} \in C^{\infty}(\bar{\Omega}), j=1,2$ are strictly positive real-valued functions called refraction indices. In the non-degenerate isotropic case when

$$
\begin{equation*}
n_{1}(x) \neq n_{2}(x) \quad \text { on } \quad \Gamma \tag{1.2}
\end{equation*}
$$

it has been recently proved in [16] that there are no transmission eigenvalues in the region

$$
\begin{equation*}
\{\lambda \in \mathbf{C}: \operatorname{Re} \lambda \geq 0,|\operatorname{Im} \lambda| \geq C\} \tag{1.3}
\end{equation*}
$$

for some constant $C>0$. Moreover, it follows from the analysis in [6] (see Section 4) that the eigenvalue-free region (1.3) is optimal and cannot be improved in general. In the present paper we will consider the degenerate isotropic case when

$$
\begin{equation*}
n_{1}(x) \equiv n_{2}(x) \quad \text { on } \quad \Gamma . \tag{1.4}
\end{equation*}
$$

We suppose that there is an integer $j \geq 1$ such that

$$
\begin{gather*}
\partial_{\nu}^{s} n_{1}(x) \equiv \partial_{\nu}^{s} n_{2}(x) \quad \text { on } \quad \Gamma, \quad 0 \leq s \leq j-1,  \tag{1.5}\\
\partial_{\nu}^{j} n_{1}(x) \neq \partial_{\nu}^{j} n_{2}(x) \quad \text { on } \quad \Gamma . \tag{1.6}
\end{gather*}
$$

It was proved in [1] (see Theorem 4.2) that in this case the eigenvalue-free region (1.3) is no longer valid. On the other hand, it follows from [5] that under the conditions (1.5) and (1.6) there are no transmission eigenvalues in $|\arg \lambda| \geq \varepsilon,|\lambda| \geq C_{\varepsilon} \gg 1, \forall 0<\varepsilon \ll 1$. Our goal in the present paper is to improve this result showing that in this case we have a much larger parabolic eigenvalue-free region. Our main result is the following

Theorem 1.1. Under the conditions (1.5) and (1.6) there exists a constant $C>0$ such that there are no transmission eigenvalues in the region

$$
\begin{equation*}
\left\{\lambda \in \mathbf{C}: \operatorname{Re} \lambda \geq 0,|\operatorname{Im} \lambda| \geq C(\operatorname{Re} \lambda+1)^{1-\kappa_{j}}\right\}, \tag{1.7}
\end{equation*}
$$

where $\kappa_{j}=2(4 j+3)^{-1}$.

To prove this theorem we make use of the semi-classical parametrix for the interior Dirichlet-to-Neumann (DN) map built in [14]. It is proved in [14] that for $|\operatorname{Im} \lambda| \geq(\operatorname{Re} \lambda+1)^{1 / 2+\epsilon}$, $0<\epsilon \ll 1$, the DN map is an $h-\Psi \mathrm{DO}$ of class $\operatorname{OPS}_{1 / 2-\epsilon}^{1}(\Gamma)$, where $0<h \ll 1$ is a semiclassical parameter such that $h \sim|\lambda|^{-1}$. A direct consequence of this fact is the existence of a transmission eigenvalue-free region of the form

$$
\begin{equation*}
|\operatorname{Im} \lambda| \geq C_{\epsilon}(\operatorname{Re} \lambda+1)^{1 / 2+\epsilon}, \quad \forall 0<\epsilon \ll 1, \tag{1.8}
\end{equation*}
$$

under the condition (1.2). The most difficult part of the parametrix construction in [14] is near the glancing region (see Section 3 for the definition). Indeed, outside an arbitrary neighbourhood of the glancing region the parametrix construction in [14] works for $|\operatorname{Im} \lambda| \geq(\operatorname{Re} \lambda+1)^{\epsilon}$ and the corresponding parametrix belongs to the class $\operatorname{OP} \mathcal{S}_{0}^{1}(\Gamma)$. In other words, to improve the eigenvalue-free region (1.8) one has to improve the parametrix in the glancing region. Such an improved parametrix has been built in [15] for strictly concave domains and as a consequence (1.8) was improved to

$$
\begin{equation*}
|\operatorname{Im} \lambda| \geq C_{\epsilon}(\operatorname{Re} \lambda+1)^{\epsilon}, \quad \forall 0<\epsilon \ll 1 \tag{1.9}
\end{equation*}
$$

in this case. In fact, it turns out that to get larger eigenvalue-free regions under the condition (1.2) no parametrix construction in the glancing region is needed. It suffices to show that the norm of the DN map microlocalized in a small neighbourhood of the glancing region gets small if $|\operatorname{Im} \lambda|$ and $\operatorname{Re} \lambda$ are large. Indeed, this strategy has been implemented in [16] to get the optimal transmission eigenvalue-free region (1.3) for an arbitrary domain. In fact, the main point in the approach in [16] is the construction of a parametrix in the hyperbolic region valid for $1 \ll C_{\epsilon} \leq|\operatorname{Im} \lambda| \leq(\operatorname{Re} \lambda)^{1-\epsilon}, \operatorname{Re} \lambda \geq C_{\epsilon}^{\prime} \gg 1,0<\epsilon \ll 1$. The strategy of [16], however, does not work any more when we have the condition (1.4). In this case the parametrix in the glancing region turns out to be essential to get eigenvalue-free regions like (1.7). In Section 3 we revisit the parametrix construction of [14] and we study carefully the way in which it depends on the restriction on the boundary of the normal derivatives of the refraction index (see Theorem 3.1). In Section 4 we show how Theorem 3.1 implies Theorem 1.1. We also show that to improve (1.7) it suffices to improve the parametrix in the glancing region, only (see Proposition 4.2).

As in [9] one can study in this case the counting function $N(r, C)=\#\{\lambda-$ trans. eig. : $C \leq$ $|\lambda| \leq r\}$, where $r \gg C>0$. We have the following
Corollary 1.2. Under the conditions of Theorem 1.1, there exists a constant $C>0$ such that the counting function of the transmission eigenvalues satisfies the asymptotics

\begin{equation*}
N(r, C)=\left(\tau_{1}+\tau_{2}\right) r^{d}+\mathcal{O}_{\varepsilon}\left(r^{d-\kappa_{j}+\varepsilon}\right), \quad \forall 0<\varepsilon \ll 1, \tag{1.10}
\end{equation*}
$$

where

$$
\tau_{j}=\frac{\omega_{d}}{(2 \pi)^{d}} \int_{\Omega} n_{j}(x)^{d / 2} d x
$$

$\omega_{d}$ being the volume of the unit ball in $\mathbf{R}^{d}$.
Note that the eigenvalue-free region (1.3) implies (1.10) with $\kappa_{j}$ replaced by 1 . Note also that asymptotics for the counting function $N(r, C)$ with remainder $o\left(r^{d}\right)$ have been previously obtained in [3], [7], [12] still under the condition (1.2).

## 2. Basic properties of the $h-\Psi$ DOs

In this section we will recall some basic properties of the $h-\Psi$ DOs on a compact manifold without boundary. Let $\Gamma, \operatorname{dim} \Gamma=d-1$, be as in the previous section and recall that given a
symbol $a \in C^{\infty}\left(T^{*} \Gamma\right)$, the $h-\Psi \mathrm{DO}, \mathrm{Op}_{h}(a)$, is defined as follows

\left(\mathrm{Op}_{h}(a) f\right)\left(x^{\prime}\right)=(2 \pi h)^{-d+1} \int_{T^{*} \Gamma} e^{-\frac{i}{h}\left\langle x^{\prime}-y^{\prime}, \xi^{\prime}\right\rangle} a\left(x^{\prime}, \xi^{\prime}\right) f\left(y^{\prime}\right) d y^{\prime} d \xi^{\prime}
$$

We have the following criteria of $L^{2}$ - boundedness.
Proposition 2.1. Let the function a satisfy the bounds

$$
\begin{equation*}
\left|\partial_{x^{\prime}}^{\alpha} a\left(x^{\prime}, \xi^{\prime}\right)\right| \leq C_{\alpha}, \quad \forall\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma, \tag{2.1}
\end{equation*}
$$

for all multi-indices $\alpha$. Then the operator $\operatorname{Op}_{h}(a)$ is bounded on $L^{2}(\Gamma)$ and satisfies

$$
\begin{equation*}
\left\|\mathrm{Op}_{h}(a)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C \sum_{|\alpha| \leq d} C_{\alpha} \tag{2.2}
\end{equation*}
$$

with a constant $C>0$ independent of $h$ and $C_{\alpha}$.
Let the function a satisfy the bounds

$$
\begin{equation*}
\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}\right)\right| \leq C_{\alpha, \beta} h^{-(|\alpha|+|\beta|) / 2}, \quad \forall\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma \tag{2.3}
\end{equation*}
$$

for all multi-indices $\alpha$ and $\beta$. Then the operator $\mathrm{Op}_{h}(a)$ is bounded on $L^{2}(\Gamma)$ and satisfies

$$
\begin{equation*}
\left\|\mathrm{Op}_{h}(a)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C \sum_{|\alpha|+|\beta| \leq s_{d}} C_{\alpha, \beta} \tag{2.4}
\end{equation*}
$$

with a constant $C>0$ independent of $h$ and $C_{\alpha, \beta}$, where $s_{d}>0$ is an integer depending only on the dimension.

Given $\ell \in \mathbf{R}, \delta_{1}, \delta_{2} \geq 0$ and a function $m>0$ on $T^{*} \Gamma$, we denote by $S_{\delta_{1}, \delta_{2}}^{\ell}(m)$ the set of all functions $a \in C^{\infty}\left(T^{*} \Gamma\right)$ satisfying

$$
\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}\right)\right| \leq C_{\alpha, \beta} m^{\ell-\delta_{1}|\alpha|-\delta_{2}|\beta|}
$$

for all multi-indices $\alpha$ and $\beta$ with constants $C_{\alpha, \beta}>0$ independent of $m$. Given $k \in \mathbf{R}, 0 \leq \delta<$ $1 / 2$, we also denote by $\mathcal{S}_{\delta}^{k}$ the space of all symbols $a \in C^{\infty}\left(T^{*} \Gamma\right)$ satisfying

$$
\left|\partial_{x^{\prime}}^{\alpha} \partial_{\xi^{\prime}}^{\beta} a\left(x^{\prime}, \xi^{\prime}\right)\right| \leq C_{\alpha, \beta} h^{-\delta(|\alpha|+|\beta|)}\left\langle\xi^{\prime}\right\rangle^{k-|\beta|}
$$

for all multi-indices $\alpha$ and $\beta$ with constants $C_{\alpha, \beta}>0$ independent of $h$. It is well-known that the $h-\Psi D O$ s of class $\mathrm{OPS}_{\delta}^{k}$ have nice calculus (e.g. see Section 7 of [2]). The next proposition is very usefull for inverting such operators depending on additional parameters (see also Proposition 2.2 of [14]).

Proposition 2.2. Let $h^{\ell} a^{ \pm} \in \mathcal{S}_{\delta}^{ \pm k}, 0 \leq \delta<1 / 2$, where $\ell_{ \pm} \geq 0$ are some numbers. Assume in addition that the functions $a^{ \pm}$satisfy

$$
\begin{equation*}
\left|\partial_{x^{\prime}}^{\alpha_{1}} \partial_{\xi^{\prime}}^{\beta_{1}} a^{+}\left(x^{\prime}, \xi^{\prime}\right) \partial_{x^{\prime}}^{\alpha_{2}} \partial_{\xi^{\prime}}^{\beta_{2}} a^{-}\left(x^{\prime}, \xi^{\prime}\right)\right| \leq \mu C_{\alpha_{1}, \beta_{1}, \alpha_{2}, \beta_{2}} h^{-\left(\left|\alpha_{1}\right|+\left|\beta_{1}\right|+\left|\alpha_{2}\right|+\left|\beta_{2}\right|\right) / 2} \tag{2.5}
\end{equation*}
$$

$\forall\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma$, for all multi-indices $\alpha_{1}, \beta_{1}, \alpha_{2}$, $\beta_{2}$ such that $\left|\alpha_{j}\right|+\left|\beta_{j}\right| \geq 1, j=1,2$, with constants $C_{\alpha_{1}, \beta_{1}, \alpha_{2}, \beta_{2}}>0$ independent of $h$ and $\mu$. Then we have

$$
\begin{equation*}
\left\|\mathrm{Op}_{h}\left(a^{+}\right) \mathrm{Op}_{h}\left(a^{-}\right)-\mathrm{Op}_{h}\left(a^{+} a^{-}\right)\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C(\mu+h) \tag{2.6}
\end{equation*}
$$

with a constant $C>0$ independent of $h$ and $\mu$.

Given any real $s$, we define the semi-classical Sobolev norm by

$$
\|f\|_{H_{h}^{s}(\Gamma)}:=\left\|\mathrm{Op}_{h}\left(\left\langle\xi^{\prime}\right\rangle^{s}\right) f\right\|_{L^{2}(\Gamma)}
$$

Using the calculus of the $h-\Psi$ DOs one can derive from (2.4) the following
Proposition 2.3. Let $a \in \mathcal{S}_{\delta}^{-k}, 0 \leq \delta<1 / 2$. Then, for every $s$, we have

$$
\mathrm{Op}_{h}(a)=\mathcal{O}_{s}(1): H_{h}^{s}(\Gamma) \rightarrow H_{h}^{s+k}(\Gamma)
$$

Proposition 2.2 implies the following
Proposition 2.4. Let $a^{ \pm} \in \mathcal{S}_{0}^{ \pm k}$. Then, for every $s$, we have

$$
\mathrm{Op}_{h}\left(a^{+}\right) \mathrm{Op}_{h}\left(a^{-}\right)-\mathrm{Op}_{h}\left(a^{+} a^{-}\right)=\mathcal{O}_{s}(h): H_{h}^{s}(\Gamma) \rightarrow H_{h}^{s}(\Gamma)
$$

## 3. The parametrix construction Revisited

In this section we will build a parametrix for the semi-classical Dirichlet-to-Neumann map following [14]. Note that in [14] there is a gap due to a missing term in the transport equations (4.11), which however does not affect the proof of the main results. Here we will correct this gap making some slight modifications.

Given $f \in H^{m+1}(\Gamma)$, let $u$ solve the equation

$$
\begin{cases}\left(h^{2} \Delta+z n(x)\right) u=0 & \text { in } \quad \Omega  \tag{3.1}\\ u=f & \text { on } \Gamma\end{cases}
$$

where $n \in C^{\infty}(\bar{\Omega})$ is a strictly positive function, $0<h \ll 1$ is a semi-classical parameter and $z \in Z_{1} \cup Z_{2} \cup Z_{3}$, where $Z_{1}=\{z \in \mathbf{C}: \operatorname{Re} z=1,0<|\operatorname{Im} z| \leq 1\}, Z_{2}=\{z \in \mathbf{C}$ : $\operatorname{Re} z=-1,|\operatorname{Im} z| \leq 1\}, Z_{3}=\{z \in \mathbf{C}:|\operatorname{Re} z| \leq 1,|\operatorname{Im} z|=1\}$. Given $\varepsilon>0$ we also set $Z_{1}(\varepsilon)=\left\{z \in Z_{1}: h^{\varepsilon} \leq|\operatorname{Im} z| \leq 1\right\}$. We define the semi-classical Dirichlet-to-Neumann map

$$
\mathcal{N}(h, z): H^{m+1}(\Gamma) \rightarrow H^{m}(\Gamma)
$$

by

$$
\mathcal{N}(h, z) f:=-\left.i h \partial_{\nu} u\right|_{\Gamma}
$$

where $\nu$ denotes the Euclidean unit inner normal to $\Gamma$. Given an integer $m \geq 0$, denote by $H_{h}^{m}(\Omega)$ the Sobolev space equipped with the semi-classical norm

$$
\|v\|_{H_{h}^{m}(\Omega)}=\sum_{|\alpha| \leq m} h^{|\alpha|}\left\|\partial_{x}^{\alpha} v\right\|_{L^{2}(\Omega)}
$$

We define similarly the Sobolev space $H_{h}^{m}(\Gamma)$. Note that this norm is equivalent to that one defined in Section 2. Throughout this section we will use the normal coordinates $\left(x_{1}, x^{\prime}\right)$ with respect to the Euclidean metric near the boundary $\Gamma$, where $0<x_{1} \ll 1$ denotes the Euclidean distance to the boundary and $x^{\prime}$ are coordinates on $\Gamma$. We denote by $\Delta_{\Gamma}$ the negative LaplaceBeltrami operator on $\Gamma$ equipped with the Riemannian metric induced by the Euclidean one in $\Omega$. Let $r_{0}\left(x^{\prime}, \xi^{\prime}\right) \geq 0$ be the principal symbol of $-\Delta_{\Gamma}$ written in the coordinates $\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma$. Since the function $n$ is smooth up to the boundary we can expand it as

$$
n(x)=\sum_{k=0}^{N-1} x_{1}^{k} n_{k}\left(x^{\prime}\right)+x_{1}^{N} \mathcal{M}_{N}(x)
$$

for every integer $N \geq 1$, where $n_{k}=\left.(k!)^{-1} \partial_{\nu}^{k} n\right|_{\Gamma}, n_{0}>0$, and $\mathcal{M}_{N}(x)$ is a real-valued smooth function. Set

$$
\rho\left(x^{\prime}, \xi^{\prime}, z\right)=\sqrt{-r_{0}\left(x^{\prime}, \xi^{\prime}\right)+z n_{0}\left(x^{\prime}\right)}, \quad \operatorname{Im} \rho>0
$$

The glancing region for the problem (3.1) is defined by

$$
\Sigma:=\left\{\left(x^{\prime}, \xi^{\prime}\right) \in T^{*} \Gamma: r_{\sharp}\left(x^{\prime}, \xi^{\prime}\right)=1\right\}, \quad r_{\sharp}=n_{0}^{-1} r_{0} .
$$

Let $\phi \in C_{0}^{\infty}(\mathbf{R}), 0 \leq \phi \leq 1, \phi(\sigma)=1$ for $|\sigma| \leq 1, \phi(\sigma)=0$ for $|\sigma| \geq 2$, and set $\eta\left(x^{\prime}, \xi^{\prime}\right)=$ $\phi\left(r_{0}\left(x^{\prime}, \xi^{\prime}\right) / \delta_{0}\right)$. Clearly, taking $\delta_{0}>0$ small enough we can arrange that $|\rho| \geq C\left\langle r_{0}\right\rangle^{1 / 2} \geq C\left\langle\xi^{\prime}\right\rangle$ on $\operatorname{supp}(1-\eta)$. We also define the function $\chi\left(x^{\prime}, \xi^{\prime}\right)=\phi\left(\left(1-r_{\sharp}\left(x^{\prime}, \xi^{\prime}\right)\right) / \delta_{1}\right)$, where $0<\delta_{1} \ll 1$ is independent of $h$ and $z$. Clearly, $\chi=1$ in a neighbourhood of $\Sigma, \chi=0$ outside another neighbourhood of $\Sigma$.

We will say that a function $a \in C^{\infty}\left(T^{*} \Gamma\right)$ belongs to $S_{\delta_{1}, \delta_{2}}^{\ell_{1}}\left(m_{1}\right)+S_{\delta_{3}, \delta_{4}}^{\ell_{2}}\left(m_{2}\right)$ if $\eta a \in S_{\delta_{1}, \delta_{2}}^{\ell_{1}}\left(m_{1}\right)$ and $(1-\eta) a \in S_{\delta_{3}, \delta_{4}}^{\ell_{2}}\left(m_{2}\right)$. Given any integer $k$, it follows from Lemma 3.2 of [14] that

$$
\begin{equation*}
\rho^{k},|\rho|^{k} \in S_{2,2}^{k}(|\rho|)+S_{0,1}^{k}(|\rho|) . \tag{3.2}
\end{equation*}
$$

In particular, (3.2) implies that

$$
\begin{equation*}
(1-\eta) \rho^{k},(1-\eta)|\rho|^{k} \in \mathcal{S}_{0}^{k} \tag{3.3}
\end{equation*}
$$

Since $\rho=i \sqrt{r_{0}}\left(1+\mathcal{O}\left(r_{0}^{-1}\right)\right)$ as $r_{0} \rightarrow \infty$, it is easy to check that

$$
\begin{equation*}
(1-\eta) \rho^{k}-(1-\eta)\left(i \sqrt{r_{0}}\right)^{k} \in \mathcal{S}_{0}^{k-2} \tag{3.4}
\end{equation*}
$$

for every integer $k$. Since $|\rho| \geq C \sqrt{|\operatorname{Im} z|}$ for $z \in Z_{1},\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp} \chi$ and $|\rho| \geq C>0$ for $z \in Z_{2} \cup Z_{3}$ or $z \in Z_{1},\left(x^{\prime}, \xi^{\prime}\right) \in \operatorname{supp}(1-\chi)$ (see Lemma 3.1 of [14]), it also follows from (3.2) that

$$
\begin{gather*}
(1-\chi) \rho^{k},(1-\chi)|\rho|^{k} \in \mathcal{S}_{0}^{k}  \tag{3.5}\\
\chi \rho^{k}, \chi|\rho|^{k} \in \mathcal{S}_{1 / 2-\epsilon}^{-N}, \quad z \in Z_{1}(1 / 2-\epsilon),  \tag{3.6}\\
\chi \rho^{k}, \chi|\rho|^{k} \in \mathcal{S}_{0}^{-N}, \quad z \in Z_{2} \cup Z_{3} \tag{3.7}
\end{gather*}
$$

for every integer $N \geq 0$ and $0<\epsilon \ll 1$. Our goal in this section is to prove the following

Remark. We do not need (3.9) to prove Theorem 1.1. However, the estimate (3.9) is important because it shows that to improve the eigenvalue-free region (1.7), it suffices to improve the parametrix in the glancing region, only (see Proposition 4.2 below).

Proof of Theorem 3.1. We will first recall the parametrix construction in [14]. We will proceed locally and then we will use partition of the unity to get the global parametrix. Fix a point $x^{0} \in \Gamma$ and let $\mathcal{U}_{0} \subset \Gamma$ be a small open neighbourhood of $x^{0}$. Let $\left(x_{1}, x^{\prime}\right), x_{1}>0, x^{\prime} \in \mathcal{U}_{0}$, be the normal coordinates. In these coordinates the Laplacian can be written as follows

We can expand them as follows

Take a function $\psi^{0} \in C_{0}^{\infty}\left(\mathcal{U}_{0}\right)$. In what follows $\psi$ will denote either the function $\psi^{0}$ or the function $\psi^{0}(1-\chi)$. Following [14], we will construct a parametrix $\widetilde{u}_{\psi}$ of the solution of (3.1) with $\left.\widetilde{u}_{\psi}\right|_{x_{1}=0}=\mathrm{Op}_{h}(\psi) f$ in the form

Here $0<\delta \ll 1$ is a parameter independent of $h$ and $z$ to be fixed later on. The phase $\varphi$ is complex-valued such that $\left.\varphi\right|_{x_{1}=0}=-\left\langle x^{\prime}, \xi^{\prime}\right\rangle$ and satisfies the eikonal equation $\bmod \mathcal{O}\left(x_{1}^{N}\right)$ :

Indeed, the LHS is equal to $2 i(K+1) \rho a_{K+1, J}$ modulo $S_{2,2}^{-3 K-4 J-2}(|\rho|)+S_{0,1}^{-J+1}(|\rho|)$, while the RHS belongs to $S_{2,2}^{-3 K-4 J-2}(|\rho|)+S_{0,1}^{-J+1}(|\rho|)$. In other words, $\rho a_{K+1, J}$ belongs to $S_{2,2}^{-3 K-4 J-2}(|\rho|)+S_{0,1}^{-J+1}(|\rho|)$. This implies that $a_{K+1, J}$ belongs to $S_{2,2}^{-3 K-4 J-3}(|\rho|)+S_{0,1}^{-J}(|\rho|)$, as desired. Furthermore, (3.24) follows from (3.13) and (3.23) since the functions $A_{N}^{(j)}$ are expressed in terms of $\varphi_{k}$ and $a_{k, j}$. One needs the simple observation that

We have that, modulo functions independent of all $n_{\ell}$ with $\ell \geq k+J+1$, the LHS is equal to $2 i k \rho a_{k, J+1}$, while the RHS is equal to $-k(k+1) a_{k+1, J}$. Hence the function

Using Lemma 3.4 we will prove the following

are satisfied modulo $\mathcal{S}_{0}^{-j-1}$. We will proceed by induction. Suppose now that the assertion is true for all $j \leq J-1$ and all $k \geq 1$, and for $j=J$ and $k \leq K$. This implies that the LHS of (3.26) with $k=K$ and $j=J$ is equal to $2 i(K+1)(1-\eta) \widetilde{\varphi}_{1}\left(a_{K+1, J}-\widetilde{a}_{K+1, J}\right)$ modulo $\mathcal{S}_{0}^{-J}$, while the RHS belongs to $\mathcal{S}_{0}^{-J}$. Hence, $(1-\eta)\left(a_{K+1, J}-\widetilde{a}_{K+1, J}\right)$ belongs to $\mathcal{S}_{0}^{-J-1}$, as desired.

\tau_{\psi}=\rho \psi+b_{s}^{\psi}+c_{s} h^{s} \rho^{-s-1} z n_{s} \psi+\widetilde{b}_{s}^{\psi}
$$

where

$$
\widetilde{b}_{s}^{\psi}=-i h^{s+1} \eta a_{1, s}-i h^{s+1}(1-\eta)\left(a_{1, s}-\widetilde{a}_{1, s}\right)-i \sum_{j=s+1}^{N-1} h^{j+1} a_{1, j} .
$$

By (3.39), (3.41) and (3.42) we have

$$
\left\|\mathrm{Op}_{h}\left(\widetilde{b}_{s}^{\psi}\right)\right\|_{L^{2}(\Gamma) \rightarrow H_{h}^{s+1}(\Gamma)} \leq \begin{cases}C_{S} h^{s+1}|\operatorname{Im} z|^{-3 / 2-2 s}, & z \in Z_{1}(1 / 2-\epsilon),  \tag{3.43}\\ C_{s} h^{s+1}, & z \in Z_{2} \cup Z_{3}\end{cases}
$$

Moreover, if $\psi=\psi^{0}(1-\chi)$, the estimate (3.43) holds with $|\operatorname{Im} z|$ replaced by 1 and $Z_{1}(1 / 2-\epsilon)$ replaced by $Z_{1}$. We would like to apply Lemma 2.8 with $m=s+1$. To this end we take $N$ big enough to arrange that

$$
\epsilon N-\ell_{s+1}>s+1
$$

By (3.27) and (3.43) we get

$$
\begin{gather*}
\left\|\mathcal{N}(h, z) \mathrm{Op}_{h}(\psi)-\mathrm{Op}_{h}\left(\rho \psi+b_{s}^{\psi}+c_{s} h^{s} \rho^{-s-1} z n_{s} \psi\right)\right\|_{L^{2}(\Gamma) \rightarrow H_{h}^{s+1}(\Gamma)} \\
\leq \begin{cases}C_{s} h^{s+1}|\operatorname{Im} z|^{-3 / 2-2 s}, & z \in Z_{1}(1 / 2-\epsilon), \\
C_{s} h^{s+1}, & z \in Z_{2} \cup Z_{3},\end{cases} \tag{3.44}
\end{gather*}
$$

if $\psi=\psi^{0}$. Moreover, if $\psi=\psi^{0}(1-\chi)$, the estimate (3.44) holds with $|\operatorname{Im} z|$ replaced by 1 and $Z_{1}(1 / 2-\epsilon)$ replaced by $Z_{1}(1-\epsilon)$.

We will now use a partition of the unity on $\Gamma$. We can find functions $\left\{\psi_{j}^{0}\right\}_{j=1}^{J}$ such that $\sum_{j=1}^{J} \psi_{j}^{0}=1$ and (3.44) is valid with $\psi^{0}$ replaced by each $\psi_{j}^{0}$, that is, with $\psi=\psi_{j}^{0}$ or $\psi=$ $\psi_{j}^{0}(1-\chi)$. Summing up all the estimates we get (3.8) and (3.9), respectively.

## 4. Proof of Theorem 1.1

Define the DN maps $\mathcal{N}_{j}(\lambda), j=1,2$, by

$$
\mathcal{N}_{j}(\lambda) f=\left.\partial_{\nu} u_{j}\right|_{\Gamma}
$$

where $\nu$ is the Euclidean unit inner normal to $\Gamma$ and $u_{j}$ is the solution to the equation

$$
\begin{cases}\left(\Delta+\lambda^{2} n_{j}(x)\right) u_{j}=0 & \text { in } \quad \Omega,  \tag{4.1}\\ u_{j}=f & \text { on } \Gamma,\end{cases}
$$

and consider the operator

$$
T(\lambda)=\mathcal{N}_{1}(\lambda)-\mathcal{N}_{2}(\lambda)
$$

Clearly, $\lambda$ is a transmission eigenvalue if there exists a non-trivial function $f$ such that $T(\lambda) f=0$. Thus Theorem 1.1 is a consequence of the following
Theorem 4.1. Under the conditions of Theorem 1.1, the operator $T(\lambda)$ sends $L^{2}(\Gamma)$ into $H^{j+1}(\Gamma)$. Moreover, there exists a constant $C>0$ such that $T(\lambda)$ is invertible for $|\operatorname{Im} \lambda| \geq$ $C(\operatorname{Re} \lambda+1)^{1-\kappa_{j}}$ with an inverse satisfying in this region the bound

$$
\begin{equation*}
\left\|T(\lambda)^{-1}\right\|_{H^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma)} \lesssim|\lambda|^{j-1} \tag{4.2}
\end{equation*}
$$

where the Sobolev space is equipped with the classical norm.
Proof. We make our problem semi-classical by putting $h=\left|\operatorname{Re} \lambda^{2}\right|^{-1 / 2}, z=h^{2} \lambda^{2}= \pm 1+i \operatorname{Im} z$, if $\left|\operatorname{Re} \lambda^{2}\right| \geq\left|\operatorname{Im} \lambda^{2}\right|, \pm \operatorname{Re} \lambda^{2}>0$, and $h=\left|\operatorname{Im} \lambda^{2}\right|^{-1 / 2}, z=h^{2} \lambda^{2}=\operatorname{Re} z+i$, if $\left|\operatorname{Re} \lambda^{2}\right| \leq\left|\operatorname{Im} \lambda^{2}\right|$. Clearly, $h \sim|\lambda|^{-1}$. We set $\mathcal{N}_{j}(h, z)=-i h \mathcal{N}_{j}(\lambda)$ and

$$
T(h, z)=\mathcal{N}_{1}(h, z)-\mathcal{N}_{2}(h, z) .
$$

We now apply Theorem 3.1 with $s=j \geq 1$. In view of the conditions (1.5) and (1.6), we get

$$
\begin{equation*}
\left\|T(h, z)-\mathrm{Op}_{h}\left(c_{j} h^{j} \rho^{-j-1} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right)\right)\right\|_{L^{2}(\Gamma) \rightarrow H_{h}^{j+1}(\Gamma)} \leq C_{j} h^{j+1}|\operatorname{Im} z|^{-2 j-3 / 2} \tag{4.3}
\end{equation*}
$$

for $z \in Z_{1}(1 / 2-\epsilon)$, where

$$
n_{j}^{(\ell)}=\left.(j!)^{-1} \partial_{\nu}^{j} n_{\ell}\right|_{\Gamma}, \quad \ell=1,2,
$$

and the function $\rho$ is defined in Section 3 with $n_{0}=\left.n_{1}\right|_{\Gamma}=\left.n_{2}\right|_{\Gamma}$. When $z \in Z_{2} \cup Z_{3}$, the estimate (4.3) holds with $|\operatorname{Im} z|$ replaced by 1. Note that by (3.5), (3.6), (3.7), we have that for every integer $k, \rho^{k} \in \mathcal{S}_{1 / 2-\epsilon}^{k}$ if $z \in Z_{1}(1 / 2-\epsilon)$, and $\rho^{k} \in \mathcal{S}_{0}^{k}$ if $z \in Z_{2} \cup Z_{3}$. We would like to apply Proposition 2.2 with

$$
a^{+}=\left(c_{j} h^{j} \rho^{-j-1} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right)\right)^{-1}, \quad a^{-}=c_{j} h^{j} \rho^{-j-1} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right) .
$$

Using (3.2) one can easily check that (2.5) is satisfied with $\mu=h|\operatorname{Im} z|^{-2}=\mathcal{O}\left(h^{2 \epsilon}\right)$. By (2.6) we get

$$
\begin{equation*}
\left\|\mathrm{Op}_{h}\left(a^{+}\right) \mathrm{Op}_{h}\left(a^{-}\right)-I\right\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C h^{2 \epsilon} \leq 1 / 2 \tag{4.4}
\end{equation*}
$$

if $h$ is taken small enough. It follows from (4.4) that the operator $\mathrm{Op}_{h}\left(a^{-}\right)$is invertible with an inverse

$$
\mathcal{A}:=\left(\mathrm{Op}_{h}\left(a^{-}\right)\right)^{-1}=\left(\mathrm{Op}_{h}\left(a^{+}\right) \mathrm{Op}_{h}\left(a^{-}\right)\right)^{-1} \mathrm{Op}_{h}\left(a^{+}\right) .
$$

Since $h^{j} a^{+} \in \mathcal{S}_{1 / 2-\epsilon}^{j+1}$ uniformly in $z$, by Proposition 2.3 we have

$$
h^{j} \mathrm{Op}_{h}\left(a^{+}\right)=\mathcal{O}(1): H_{h}^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma)
$$

This implies

$$
\begin{equation*}
\mathcal{A}=\mathcal{O}\left(h^{-j}\right): H_{h}^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma) . \tag{4.5}
\end{equation*}
$$

By (4.3) and (4.5),

$$
\begin{equation*}
\|\mathcal{A} T(h, z)-I\|_{L^{2}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq C_{j} h|\operatorname{Im} z|^{-2 j-3 / 2} \tag{4.6}
\end{equation*}
$$

for $z \in Z_{1}(1 / 2-\epsilon)$. When $z \in Z_{2} \cup Z_{3}$, the estimate (4.6) holds with $|\operatorname{Im} z|$ replaced by 1 . It follows from (4.6) that the operator $\mathcal{A} T(h, z)$ is invertible for $z \in Z_{1}(1 / 2-\epsilon),|\operatorname{Im} z| \geq$ $\left(2 C_{j} h\right)^{1 /(2 j+3 / 2)}$, and for $z \in Z_{2} \cup Z_{3}, h$ small enough. Hence so is $T(h, z)$ and we have the bound

$$
\begin{equation*}
\left\|T(h, z)^{-1}\right\|_{H_{h}^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq 2\|\mathcal{A}\|_{H_{h}^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma)} \leq \mathcal{O}\left(h^{-j}\right) . \tag{4.7}
\end{equation*}
$$

Now (4.2) follows from (4.7) after passing from $(h, z)$ to $\lambda$ and using the fact that the semiclassical norm in $H_{h}^{j+1}(\Gamma)$ is bounded from above by the classical norm in $H^{j+1}(\Gamma)$.

It is worth noticing that it follows from the estimate (3.9) that the operator $T(h, z)$ can be inverted outside the glancing region for much smaller $|\operatorname{Im} z|$. In other words, to improve the eigenvalue-free region (1.7) one has to improve the parametrix in the glancing region, only. More precisely, we have the following

Proposition 4.2. Let $z \in Z_{1}(1-\epsilon)$. Then, under the conditions of Theorem 1.1, there exists an operator

$$
\mathcal{A}_{1}=\mathcal{O}\left(h^{-j}\right): H_{h}^{j+1}(\Gamma) \rightarrow L^{2}(\Gamma)
$$

such that

$$
\begin{equation*}
\left\|T(h, z) \mathcal{A}_{1}-\operatorname{Op}_{h}(1-\chi)\right\|_{H_{h}^{j+1}(\Gamma) \rightarrow H_{h}^{j+1}(\Gamma)} \leq C h . \tag{4.8}
\end{equation*}
$$

When $z \in Z_{2} \cup Z_{3}$, the estimate (4.8) holds with $\chi$ replaced by 0 .

Proof. By (3.9) with $s=j$ we have

$$
\begin{equation*}
\left\|T(h, z) \mathrm{Op}_{h}(1-\chi)-\mathrm{Op}_{h}\left((1-\chi) c_{j} h^{j} \rho^{-j-1} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right)\right)\right\|_{L^{2}(\Gamma) \rightarrow H_{h}^{j+1}(\Gamma)} \leq C_{j} h^{j+1} \tag{4.9}
\end{equation*}
$$

for $z \in Z_{1}(1-\epsilon)$. Let $\chi_{1} \in C_{0}^{\infty}\left(T^{*} \Gamma\right)$ be such that $\chi=1$ on $\operatorname{supp} \chi_{1}, \chi_{1}=1$ in a neighbourhood of $\Sigma$, and set

$$
a_{1}^{+}=(1-\chi) \rho^{-j-1} c_{j} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right), \quad a_{1}^{-}=\left(1-\chi_{1}\right) \rho^{j+1}\left(c_{j} z\left(n_{j}^{(1)}-n_{j}^{(2)}\right)\right)^{-1}
$$

We have $a_{1}^{+} \in \mathcal{S}_{0}^{-j-1}, a_{1}^{-} \in \mathcal{S}_{0}^{j+1}$ and $a_{1}^{+} a_{1}^{-}=1-\chi$. We now apply Proposition 2.4 with $a_{1}^{+}$ and $a_{1}^{-}$in place of $a^{+}$and $a^{-}$. We have

$$
\begin{equation*}
\left\|\mathrm{Op}_{h}\left(a_{1}^{+}\right) \mathrm{Op}_{h}\left(a_{1}^{-}\right)-\mathrm{Op}_{h}(1-\chi)\right\|_{H_{h}^{j+1}(\Gamma) \rightarrow H_{h}^{j+1}(\Gamma)} \leq C h \tag{4.10}
\end{equation*}
$$

Clearly, (4.8) follows from (4.9) and (4.10) with $\mathcal{A}_{1}=h^{-j} \mathrm{Op}_{h}(1-\chi) \mathrm{Op}_{h}\left(a_{1}^{-}\right)$.
