On the fourth derivative test for exponential sums

Abstract

We give an upper bound for the exponential sum $\sum_{m=1}^{M} \exp(2i\pi f(m))$ where f is a real valued function whose fourth derivative has the order of magnitude $\lambda > 0$ small. Van der Corput's classical bound, in terms of M and λ only, involves the exponent 1/14. We show how this exponent may be replaced by any $\theta < 1/12$ without further hypotheses. The proof uses a recent result by Wooley on the cubic Vinogradov system.

Let $C \geq 1$ be a real constant fixed once and for all. Let $a \in \mathbb{R}$, $M \in \mathbb{N}$ with $M \geq 10$. Let $0 < \lambda_4 < 1/10$ be a real number and let $f : [a, a + M] \to \mathbb{R}$ be a C^4 function such that

$$\lambda_4 \le |f^{(4)}(x)| \le C\lambda_4 \text{ for } x \in [a, a+M].$$

We are interested in bounding the exponential sum

$$S_{a,M}(f) := \sum_{a < m \le a+M} e(f(m)), \tag{2}$$

with the usual notation $e(t) := e^{2i\pi t}$ for $t \in \mathbb{R}$. Under the previous assumptions, van der Corput's result asserts that setting $\theta_4 = 1/14$ and $\beta_4 = 4/7$, one has

$$S_{a,M}(f) \ll_C M \lambda_4^{\theta_4} \tag{3}$$

uniformly for $a \in \mathbb{R}$, $M \ge \lambda_4^{-\beta_4}$ and f satisfying (1). The purpose of this paper is to improve on the exponent θ_4 in (3). Our result is the following.

Theorem 1 Let $a \in \mathbb{R}$, $M \in \mathbb{N}$ with $M \geq 10$. Let $0 < \lambda_4 < 1/10$ be a real number and let $f : [a, a + M] \to \mathbb{R}$ be a C^4 function satisfying (1). Then for each $\varepsilon > 0$, and with the notation (2), one has

$$S_{a,M}(f) \ll_{C,\varepsilon} M^{1+\varepsilon} \lambda_4^{1/12} + M^{\frac{11}{12}+\varepsilon}$$

uniformly for $a \in \mathbb{R}$, $M \ge \lambda_4^{-3/5}$ and f satisfying (1).

Remark. Theorem 1 is not the first improvement of Van der Corput's result. Here is a brief history of these results under the hypothesis (1) alone :

- Sargos [4] proved that for $\theta_4 = 1/14$, β_4 may be replaced by 3/7. Moreover, in the same paper, he also proved that θ_4 could be replaced by any $\theta < \frac{3}{40}$ provided that β_4 is replaced by 3/5.
- Robert & Sargos [1] proved θ_4 may be replaced by any $\theta < \frac{1}{13}$ provided that β_4 is replaced by 8/13.

Note that our Theorem 1 implies that θ_4 may be replaced by any $\theta < 1/12$ provided that β_4 is replaced by 1.

It should also be mentioned that more generally when $k \ge 2$ is fixed, van der Corput proved that if $f : [a, a + M] \to \mathbb{R}$ is C^k such that $\lambda_k \le |f^{(k)}(x)| \le C\lambda_k$, then $S_{a,M}(f) \ll_C M\lambda_k^{\theta_k}$ for $M \ge \lambda_k^{-\beta_k}$ with $\theta_k := 1/(2^k - 2)$, $\beta_k := 2^{k-1}/(2^k - 2)$. For k = 2, the example of the Gauss sums shows at once that $\theta_2 = 1/2$ is optimal. For k = 3, the exponent $\theta_3 = 1/6$ is conjectured to be optimal even for $M \ge \lambda_3^{-1}$ (see [4]). For $k \ge 5$, explicit better exponents can be produced (see for example [3] for an exposition of the recent results for $4 \le k \le 10$).

Proof of Theorem 1. By a classical series of transforms, the proof reduces to estimating the number $J_s(N)$ of solutions of

$$\sum_{j=1}^{s} \left(x_j^r - y_j^r \right) = 0 \qquad (r = 1, 2, 3) \qquad 1 \le x_j, y_j \le N.$$
(4)

The only novelty in the proof of Theorem 1 is the use of Wooley's recent breakthrough [5] where he proved Vinogradov's cubic conjecture, namely that for each integer $s \ge 1$ and each $\varepsilon > 0$ one has

$$J_s(N) \ll_{\varepsilon} N^{s+\varepsilon} + N^{2s-6+\varepsilon} \qquad (N \ge 1).$$
(5)

The preliminary transform of $S_{a,M}(f)$ is taken care of by the following result, which is a particular case of Lemme 1 of [3] with k = 4.

Lemma 1 Let $a \in \mathbb{R}$, $M \in \mathbb{N}$ with $M \ge 10$. Let $0 < \lambda_4 < 1/10$ be a real number and let $f : [a, a + M] \to \mathbb{R}$ be a C^4 function satisfying (1). Then setting $N := \lfloor \lambda_4^{-1/5} \rfloor$, and with the notation (2), one has for each $s \ge 1$

$$|S_{a,M}(f)|^{2s} \ll_{s,C} M^{2s}\lambda_4 \left(1 + \frac{1}{M\lambda_4}\right) \left(\frac{J_s(N)}{N^{2s-6}}\right) \log M$$

uniformly for $a \in \mathbb{R}$, $M \geq \lambda_4^{-3/5}$ and f satisfying (1), where $J_s(N)$ has been defined in (4).

The proof of Theorem 1 is now straightforward : we use Lemma 1 with s = 6, and we bound $J_6(N)$ using (5). This completes the proof of Theorem 1.
