# ON WELL-POSEDNESS FOR SOME DISPERSIVE PERTURBATIONS OF BURGERS' EQUATION 

LUC MOLINET, DIDIER PILOD AND STÉPHANE VENTO


#### Abstract

We show that the Cauchy problem for a class of dispersive perturbations of Burgers' equations containing the low dispersion Benjamin-Ono equation $$
\partial_{t} u-D_{x}^{\alpha} \partial_{x} u=\partial_{x}\left(u^{2}\right), \quad 0<\alpha \leq 1
$$ is locally well-posed in $H^{s}(\mathbb{R})$ when $s>s_{\alpha}:=\frac{3}{2}-\frac{5 \alpha}{4}$. As a consequence, we obtain global well-posedness in the energy space $H^{\frac{\alpha}{2}}(\mathbb{R})$ as soon as $\frac{\alpha}{2}>s_{\alpha}$, i.e. $\alpha>\frac{6}{7}$.


## 1. Introduction

This paper is concerned with the initial value problem for a class of dispersive perturbations of Burgers' equation containing in particular the low dispersion Benjamin-Ono equation

$$
\begin{equation*}
\partial_{t} u-D_{x}^{\alpha} \partial_{x} u=\partial_{x}\left(u^{2}\right), \tag{1.1}
\end{equation*}
$$

where $u=u(x, t)$ is a real valued function, $x \in \mathbb{R}, t \in \mathbb{R}, \alpha>0$ and $D_{x}^{\alpha}$ is the Riesz potential of order $-\alpha$, which is given via Fourier transform by

$$
\widehat{D_{x}^{\alpha} \phi}(\xi)=|\xi|^{\alpha} \widehat{\phi}(\xi)
$$

The cases $\alpha=2$ and $\alpha=1$ correspond to the well-known Korteweg-de Vries (KdV) and Benjamin-Ono (BO) equations. In the case $\alpha=0, \partial_{x} u$ is a transport term, so that there is no dispersion anymore and equation (1.1) corresponds merely to the inviscid Burgers equation.

While the Cauchy problem associated with (1.1) is now very well-understood in the case $\alpha \geq 1$, our objective here is to investigate the case of low dispersion when $0<\alpha<1$, which seems of great physical interest (see for example the introductions in $[19,21]$ and the references therein). In particular, in the case $\alpha=\frac{1}{2}$, the dispersion is somehow reminiscent of the linear dispersion of finite depth water waves with surface tension. The corresponding Whitham equation with surface tension writes

\partial_{t} u-w\left(D_{x}\right) \partial_{x} u+\partial_{x}\left(u^{2}\right)=0 \tag{1.2}
\end{equation*}
$$

where $u=u(x, t)$ is a real valued function, $x \in \mathbb{R}, t \in \mathbb{R}, \omega\left(D_{x}\right)$ is the Fourier multiplier of symbol $w(\xi)=\left(\frac{\tanh (\xi)}{\xi}\right)^{\frac{1}{2}}\left(1+\tau \xi^{2}\right)^{\frac{1}{2}}$ and $\tau$ is a positive parameter related to the surface tension. Note that for high frequencies $w(\xi) \sim|\xi|^{\frac{1}{2}}$, which corresponds exactly to equation (1.1) in the $L^{2}$ critical case.

[^0]Equation (1.1) is hamiltonian. In particular, the quantities

$$
\begin{equation*}
M(u)=\int_{\mathbb{R}} u^{2}(x, t) d x \tag{1.3}
\end{equation*}
$$

and

$$
\begin{equation*}
H(u)=\int_{\mathbb{R}}\left(\frac{1}{2}\left|D^{\frac{\alpha}{2}} u(x, t)\right|^{2}+\frac{1}{3} u^{3}(x, t)\right) d x \tag{1.4}
\end{equation*}
$$

are (at least formally) conserved by the flow associated to (1.1). Moreover, equation (1.1) is invariant under the scaling transformation

$$
u_{\lambda}(x, t)=\lambda^{\alpha} u\left(\lambda x, \lambda^{\alpha+1} t\right)
$$

for any positive number $\lambda$. A straightforward computation shows that $\left\|u_{\lambda}\right\|_{\dot{H}^{s}}=$ $\lambda^{s+\alpha-\frac{1}{2}}\left\|u_{\lambda}\right\|_{\dot{H}^{s}}$, and thus the critical index corresponding to (1.1) is $s_{\alpha}=\frac{1}{2}-\alpha$. In particular, equation (1.1) is $L^{2}$-critical for $\alpha=\frac{1}{2}$ and energy critical for $\alpha=\frac{1}{3}$.

Next we recall some important facts about the initial value problem (IVP) associated with (1.1) in $L^{2}$-based Sobolev spaces $H^{s}(\mathbb{R})^{1}$. For results in weighted Sobolev spaces, we refer to Fonseca, Linares and Ponce [9] and the references therein. It was proved by Molinet, Saut and Tzvetkov [24], that, due to bad high-low frequency interactions in the nonlinearity, the IVP associated with (1.1) cannot be solved by a contraction argument on the corresponding integral equation in any Sobolev space $H^{s}(\mathbb{R}), s \in \mathbb{R}$, as soon as $\alpha<2$. Thus, one needs to use compactness arguments based on a priori estimates on the solution and on the difference of two solutions at the required level of regularity.

Standard energy estimates, the Kato-Ponce commutator estimate and Gronwall's inequality provide the following bound for solutions of (1.1)

\|u\|_{L_{T}^{\infty} H_{x}^{s}} \leq c\left\|u_{0}\right\|_{H_{x}^{s}} e^{c \int_{0}^{T}\left\|\partial_{x} u\right\|_{L_{x} \infty} d t}
$$

Therefore, one way to obtain a priori estimates in $H^{s}$ is to control $\left\|\partial_{x} u\right\|_{L_{T}^{1} L_{x}^{\infty}}$ at the $H^{s}$-level. This can be done easily in $H^{\frac{3}{2}+}(\mathbb{R})$ by using the Sobolev embedding $H^{\frac{1}{2}+}(\mathbb{R}) \hookrightarrow L^{\infty}(\mathbb{R})$. In the Bejamin-Ono case $\alpha=1$, Ponce [30] used the smoothing effects (Strichartz estimates, Kato type smoothing estimate and maximal function estimate) associated with the dispersive part of (1.1) to obtain well-posedness in $H^{\frac{3}{2}}(\mathbb{R})$. Later on, Koch and Tzvetkov [20] introduced a refined Strichartz estimate, derived by chopping the time interval in small pieces whose length depends on the spatial frequency of the solution, which allowed them to prove local well-posedness for BO in $H^{\frac{5}{4}+}(\mathbb{R})$. This refined Strichartz estimate was then improved by Kenig and Koenig [16] and the local well-posedness for BO pushed down to $H^{\frac{9}{8}+}(\mathbb{R})$. Recently, Linares, Pilod and Ponce [21] extended Kenig and Koenig's result to (1.1) in the range $0<\alpha<1$ by proving that the corresponding initial value problem is well-posed in $H^{s}(\mathbb{R})$ for $s>\frac{3}{2}-\frac{3 \alpha}{8}$. Note that even very few dispersion (when $0<\alpha \ll 1$ ) allows to enlarge the resolution space, which is not the case anymore when there is no dispersion. Indeed, it is known that the IVP associated with Burgers' equation is ill-posed in $H^{\frac{3}{2}}(\mathbb{R})$ (c.f. Remark 1.6. in [21]).

Another technique to obtain suitable estimates on the solutions at low regularity is the use of a nonlinear gauge transformation which allows to weaken the bad

[^1]frequency interactions in the nonlinear term. Such transformation was introduced by Tao [32] for the Benjamin-Ono equation and enabled him to prove global wellposedness for BO in $H^{1}(\mathbb{R})$. By using this gauge transformation in the context of Bourgain's spaces $X^{s, b}$, Burq and Planchon [6], respectively Ionescu and Kenig [14], proved that the IVP associated with BO is well-posed in $H^{\frac{1}{4}+}(\mathbb{R})$, respectively $L^{2}(\mathbb{R})$. We also refer to Molinet and Pilod [25] for another proof of Ionescu and Kenig's result with stronger uniqueness result (for example unconditional uniqueness in $H^{\frac{1}{4}+}(\mathbb{R})$ ). In [13], Herr, Ionescu, Kenig and Koch were able to extend Ionescu and Kenig's result to the whole range $1<\alpha<2$. By using a paradifferential gauge transformation, they proved that the IVP associated to (1.1) is globally well-posed in $L^{2}(\mathbb{R})$ for $1<\alpha<2$.

Recently Molinet and Vento [28] introduced a new method to obtain energy estimates at low regularity for strongly nonresonant dispersive equations. It starts with the classical estimate for the dyadic piece $P_{N} u$ localized in turn of the spatial frequency $N$,

\left\|P_{N} u\right\|_{L_{T}^{\infty} L_{x}^{2}}^{2} \lesssim\left\|P_{N} u_{0}\right\|_{L_{x}^{2}}^{2}+\sup _{t \in] 0, T[ }\left|\int_{0}^{t} \int_{\mathbb{R}} P_{N} \partial_{x}\left(u^{2}\right) P_{N} u d x d t\right| . \tag{1.5}
\end{equation*}
$$

To control the last term on the right-hand side of the energy estimate (1.5), one performs a paraproduct decomposition

$$
\begin{equation*}
\int_{\mathbb{R} \times[0, t]} P_{N} \partial_{x}\left(u^{2}\right) P_{N} u=\int_{\mathbb{R} \times[0, t]} \partial_{x} P_{N}\left(u_{\gtrsim N} u_{\gtrsim N}\right) P_{N} u+\int_{\mathbb{R} \times[0, t]} \partial_{x} P_{N}\left(u_{\ll N} u\right) P_{N} u \tag{1.6}
\end{equation*}
$$

and put the derivative on the lowest spatial frequencies by "integrating by parts" ${ }^{2}$. The idea is then to perform a dyadic decomposition of each function in term of its modulation variable and to put one of them (the one with the greatest modulation) in the space $X^{s-1,1}$. This allows to recover at least $|\Omega| N^{-1}$ where $\Omega$ is the resonance function. The price to pay is to handle the characteristic function $1_{] 0, t[ }$ which appears after extending the functions to $\mathbb{R}^{2}$ and is not continuous in $X^{s-1,1}$. On the positive side, the $X^{s-1,1}$ norm of $u$ is relatively simple to control by using the classical linear estimates in Bourgain's spaces as follows

$$
\begin{equation*}
\|u\|_{X^{s-1,1}} \lesssim\left\|u_{0}\right\|_{H^{s-1}}+\left\|\partial_{x} J_{x}^{s-1}\left(u^{2}\right)\right\|_{L_{x, T}^{2}} \lesssim\left\|u_{0}\right\|_{H^{s}}+\left\|J_{x}^{s}\left(u^{2}\right)\right\|_{L_{T}^{\infty} H_{x}^{s}} \tag{1.7}
\end{equation*}
$$

Thus, for $s>\frac{1}{2}$, one can easily concludes the bilinear estimate since $H^{s}(\mathbb{R})$ is a Banach algebra. By using this method, Molinet and Vento proved that the IVP associated with (1.1) is locally well-posed in $H^{s}(\mathbb{R})$ for $s \geq 1-\frac{\alpha}{2}$ when $1 \leq \alpha \leq 2$. Note that Guo [11] also proved local well-posedness in $H^{s}(\mathbb{R})$ for $s>2-\alpha$ when $1 \leq \alpha \leq 2$ without using a gauge transformation. He used instead the short time Bourgain's spaces in the way of Ionescu, Kenig and Tataru in [15].

Throughout this paper we consider the class of dispersive equations

$$
\begin{equation*}
\partial_{t} u+L_{\alpha+1} u=\partial_{x}\left(u^{2}\right), \tag{1.8}
\end{equation*}
$$

where $u=u(x, t)$ is a real-valued function, $x \in \mathbb{R}, t \in \mathbb{R}, \alpha>0$ and the linear operator $L_{\alpha+1}$ satisfies the following hypothesis.

[^2]Hypothesis 1. We assume that $L_{\alpha+1}$ is the Fourier multiplier operator by $i \omega_{\alpha+1}$ where $\omega_{\alpha+1}$ is a real-valued odd function belonging to $C^{1}(\mathbb{R}) \cap C^{\infty}\left(\mathbb{R}^{*}\right)$ and satisfying: There exists $\xi_{0}>0$ such that for any $\xi \geq \xi_{0}$, it holds

$$
\begin{equation*}
\left|\partial^{\beta} \omega_{\alpha+1}(\xi)\right| \sim|\xi|^{\alpha+1-\beta}, \beta \in\{0,1,2\} \tag{1.9}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\partial^{\beta} \omega_{\alpha+1}(\xi)\right| \lesssim|\xi|^{\alpha+1-\beta}, \beta \geq 3 \tag{1.10}
\end{equation*}
$$

Remark 1.1. We easily check that the following operators satisfy Hypothesis 1:
(1) The purely dispersive operator $L=-D_{x}^{\alpha} \partial_{x}, \alpha>0$.
(2) The Whitham operator with symbol $\omega(\xi)=\xi\left(\frac{\tanh (\xi)}{\xi}\right)^{\frac{1}{2}}\left(1+\tau \xi^{2}\right)^{\frac{1}{2}}, \tau>0$ for $\alpha=1 / 2$.
(3) The linear Intermediate Long Wave operator $L=\partial_{x} D_{x} \operatorname{coth}\left(D_{x}\right)$ for $\alpha=1$.

In this article, we show that the initial value problem (IVP) associated with (1.8) is locally well-posed in $H^{s}(\mathbb{R})$ for $s>\frac{3}{2}-\frac{5 \alpha}{4}$ when $0<\alpha \leq 1$, which improves Linares, Pilod and Saut's result in [21].
Theorem 1.2. Assume that $L_{\alpha+1}$ satisfies Hypothesis 1 with $0<\alpha \leq 1$ and let $s>s_{\alpha}=\frac{3}{2}-\frac{5 \alpha}{4}$. Then, for any $u_{0} \in H^{s}(\mathbb{R})$, there exist $T=T\left(\left\|u_{0}\right\|_{H^{s}}\right)>0$ and a unique solution $u$ of the IVP associated with (1.8) in the class

$$
\begin{equation*}
C\left([0, T]: H^{s}(\mathbb{R})\right) \cap X_{T}^{s-1,1} \cap L^{2}\left(0, T: W^{s-s_{\alpha}+(1-\alpha)_{-}, \infty}(\mathbb{R})\right) \tag{1.11}
\end{equation*}
$$

Moreover, for any $0<T^{\prime}<T$, there exists a neighborhood $\mathcal{U}$ of $u_{0}$ in $H^{s}(\mathbb{R})$ such that the flow-map data solution $v_{0} \mapsto v$ is continuous from $\mathcal{U}$ into $C\left(\left[0, T^{\prime}\right]: H^{s}(\mathbb{R})\right)$.

Remark 1.3. In the case $\alpha=1$ and $L_{\alpha+1}=-D_{x}^{\alpha} \partial_{x}$, our result provides a proof of the local well-posedness for BO in $H^{\frac{1}{4}+}(\mathbb{R})$. In other words, we recover Burq and Planchon's result in [6] without using a gauge transformation.

If we assume moreover that the symbol $\omega_{\alpha+1}$ satisfies

$$
\begin{equation*}
\left|\omega_{\alpha+1}(\xi)\right| \lesssim|\xi| \text { for }|\xi| \lesssim 1 \tag{1.12}
\end{equation*}
$$

we easily see that the Hamiltonian

$$
H_{\alpha+1}(u)=\int_{\mathbb{R}}\left(\frac{1}{2}\left|\Lambda^{\alpha / 2} u(x, t)\right|^{2}+\frac{1}{3} u^{3}(x, t)\right) d x
$$

where $\Lambda^{\alpha / 2}$ is the space Fourier multiplier defined by

$$
\widehat{\Lambda^{\alpha / 2} v}(\xi)=\left|\frac{\omega_{\alpha+1}(\xi)}{\xi}\right|^{1 / 2} \hat{v}(\xi)
$$

as well as (1.3) are conserved by the flow associated to (1.8). Iterating Theorem 1.2 , we obtain global well-posedness as soon as $\alpha>\frac{6}{7}$.

Corollary 1.1. Assume that $L_{\alpha+1}$ satisfies Hypothesis 1 and (1.12) with $\frac{6}{7}<$ $\alpha \leq 1$. Then the Cauchy problem associated with (1.8) is globally well-posed in the energy space $H^{\frac{\alpha}{2}}(\mathbb{R})$.

Remark 1.4. The operators defined in Remark 1.1 also satisfy assumption (1.12).

Remark 1.5. Based on numerical computations by Klein and Saut [19], the global well-posedness of (1.1) was conjectured [19, 21] in the $L^{2}$-subcritical case $\alpha>\frac{1}{2}$. Here, we answer to part of this conjecture when $\alpha>\frac{6}{7}$. Up to our knowledge, this is the first global existence result for $\alpha<1$.

Remark 1.6. It would be interesting to obtain results on the dispersion decay of the solutions associated to small data for (1.1) with low dispersion. Some progress in this direction were recently done by Ifrim and Tataru [12] for the Benjamin-Ono equation. ${ }^{3}$
Remark 1.7. In [22], Linares, Pilod and Saut showed that the solitary waves associated to (1.1) are orbitally stable in the energy space $H^{\frac{\alpha}{2}}(\mathbb{R})$ as soon as $\alpha>\frac{1}{2}$, conditionally to the global well-posedness in $H^{\frac{\alpha}{2}}$ (see Remark 2.1 in [22]). We also refer to Arnesen [2] and Angulo [1] for other proofs of this result. Theorem 2.14 in [22] combined with Theorem 1.2 provides then a complete orbital stability result in the energy space as soon as $\alpha>\frac{6}{7}$.

Now, we discuss the main ingredients in the proof of Theorem 1.2. Since it is not clear wether one can take advantage of a gauge transformation in the case $\alpha<1$ or not, we elect to follow the energy method introduced in [28]. However, we need to add several key ingredients.

Firstly, in order to close the bilinear estimate (1.7) in $H^{s}(\mathbb{R})$ for $s \leq \frac{1}{2}$, we use the norm $\|\cdot\|_{L_{T}^{2} L_{x}^{\infty}}$, which is in turn estimated by using the refined Strichartz estimate as in $[20,16,21]$. Then, we can control the last term on the right-hand side of (1.7) by using the fractional Leibniz rule as $\left\|J_{x}^{s}\left(u^{2}\right)\right\|_{L_{T}^{\infty} H_{x}^{s}} \lesssim\|u\|_{L_{T}^{2} L_{x}^{\infty}}\left\|J_{x}^{s} u\right\|_{L_{T}^{\infty} L_{x}^{2}}$.

The norm $\|\cdot\|_{L_{T}^{2} L_{x}^{\infty}}$ is also an important ingredient to close the energy estimate (1.5). This creates a serious technical difficulty. Indeed to handle some commutators with those norms, we need then to use a generalized Coifman-Meyer theorem for multilinear Fourier multipliers $m\left(\xi_{1}, \cdots, \xi_{n}\right)$ satisfying the Marcinkiewicz type condition

$$
\left|\partial^{\beta} m\left(\xi_{1}, \cdots, \xi_{n}\right)\right| \lesssim \prod_{i=1}^{n}\left|\xi_{i}\right|^{-\beta_{i}}, \quad \forall \beta \in \mathbb{N}^{n}
$$

Such a theorem was proved by Muscalu, Pipher, Tao and Thiele [29] in the bilinear case and can be deduced from a result of Bernicot [3] in the multilinear case (see Section 2.3 for more details).

With this theorem in hand, we can estimate the first term of (1.6) corresponding to the high-high frequency interactions by using the norms $\|u\|_{X_{T}^{s-1,1}}$ and $\left\|J_{x}^{1-\alpha} u\right\|_{L_{T}^{2} L_{x}^{\infty}}$ as explained above. For the second term, we would like to integrate by parts and use the $\|\cdot\|_{X^{s-1,1}-\text { norm as in [28] but the resonance relation }}$ $|\Omega| \sim N_{\min } N_{\max }^{\alpha}$ would not be sufficient to recover the "big" derivative we lost by using this norm. This is one of the main difficulty to work at low dispersion $\alpha<1$. For this reason, we modify the energy by adding a cubic term, constructed so that the contribution of its time derivative coming from the linear part of the equation cancels out the high-low frequency term. It is worth noticing that this modified energy is defined in Fourier variables in the same spirit of the modified

[^3]energy in the I-method [8]. We also refer to our recent works [26, 27] on the modified Korteweg-de Vries equation both on the line and on the torus for a similar strategy using a modified energy. Note that we gain a factor $N_{\min } N_{\max }^{\alpha}$ on the additional cubic term. On the other hand, the contribution of its time derivative coming from the nonlinear part of the equation is of order four and contains one more spatial derivative. For $\alpha<1$, it is clear that when this spatial derivative falls on the term with the highest spatial frequencies we should lose $N_{\min }^{-1} N_{\max }^{1-\alpha}$ which is not acceptable for some high-low frequency interaction terms. The crucial observation here is that there is a fundamental cancellation between two of those terms exhibiting the badest high-low frequency interactions.

Those ingredients are enough to derive a suitable a priori estimate for a solution of (1.8). However, things are more complicated to get an estimate for the difference of two solutions $u_{1}$ and $u_{2}$, since the corresponding equation lacks of symmetry. For this reason, we are only able to derive an energy estimate for the difference $w=u_{1}-u_{2}$ at low regularity $H^{\sigma}, \sigma<0$, and with an additional weight on low frequency. This is sufficient for our purposes, since we only need this estimate for the difference of solutions having the same low frequency part in order to prove the uniqueness and the continuity of the flow map (c.f. [14]). However, the bilinear estimate is not straightforward as before when working with negative regularity $H^{\sigma}, \sigma<0$. To overcome this last difficulty, we follow the strategy in [28] and work with the sum space $F^{s, \frac{1}{2}}=X^{s-1,1}+X^{s,\left(\frac{1}{2}\right)+}$ instead of working with $X^{s-1,1}$ only.

Finally, it is worth noticing that even in the particular case of purely power dispersion where scaling invariance occurs, equation (1.8) is $L^{2}$-super critical for $\alpha<1 / 2$ and thus we will not be able to use a classical scaling argument to prove the local existence result. Roughly speaking, our method consists in cutting the spatial frequencies of the solution into two parts $P_{\leq N_{0}}$ and $P_{>N_{0}}$. We gain some positive factor of the time $T$ (but lose some positive factor of $N_{0}$ ) when estimating the low frequency part whereas we gain a negative factor of $N_{0}$ when estimating the high frequency part. This will allow us to close our estimates on $] 0, T$ [ for smooth solution to (1.1) by taking $N_{0}$ big enough and $T>0$ small enough. Finally, the continuity of the solution as well as the continuity with respect to initial data will be proved by using a kind of uniform decay estimate on the high spatial frequencies of the solution.

The paper is organized as follows: in Section 2, we introduce the notation, define the function spaces and state some important preliminary estimates related the generalized Coifman-Meyer theorem. In Section 3, we derive multilinear estimates at the $L^{2}$-level. Those estimates will be used in Sections 4 and 5 to prove estimates for the solution and the difference of two solutions of the equation. Finally, we give the proof of Theorem 1.2 in Section 6.

## 2. Notation, function spaces and preliminary estimates

2.1. Notation. For any positive numbers $a$ and $b$, the notation $a \lesssim b$ means that there exists a positive constant $C$ such that $a \leq C b$, and we denote $a \sim b$ when $a \lesssim b$ and $b \lesssim a$. We also write $a \ll b$ if the estimate $b \lesssim a$ does not hold. If $x \in \mathbb{R}$,
$x_{+}$, respectively $x_{-}$will denote a number slightly greater, respectively lesser, than $x$. We also set $\langle x\rangle=\left(1+x^{2}\right)^{\frac{1}{2}}$.

For $u=u(x, t) \in \mathcal{S}^{\prime}\left(\mathbb{R}^{2}\right), \mathcal{F} u=\hat{u}$ will denote its space-time Fourier transform, whereas $\mathcal{F}_{x} u$, respectively $\mathcal{F}_{t} u$ will denote its Fourier transform in space, respectively in time. For $s \in \mathbb{R}$, we define the Bessel and Riesz potentials of order $-s, J_{x}^{s}$ and $D_{x}^{x}$, by

Let $\widetilde{\phi} \in C_{0}^{\infty}(\mathbb{R})$ be such that $\widetilde{\phi}_{\left.\right|_{ \pm\left[\frac{1}{2}, 2\right]}} \equiv 1$ and $\operatorname{supp}(\widetilde{\phi}) \subset \pm\left[\frac{1}{4}, 4\right]$. For $l \in \mathbb{Z}$, we define

Any summations over capitalized variables such as $N$ or $L$ are presumed to be dyadic. Unless stated otherwise, we work with homogeneous dyadic decomposition for the space frequency variables and non-homogeneous decompositions for modulation variables, i.e. these variables range over numbers of the form $\left\{2^{k}: k \in \mathbb{Z}\right\}$ and $\left\{2^{k}: k \in \mathbb{N}\right\}$ respectively. Then, we have that

For the sake of brevity we often write $u_{N}=P_{N} u, u_{\leq N}=P_{\leq N} u, \cdots$

Finally, if $N_{1}, N_{2}$ are two dyadic numbers, we denote $N_{1} \vee N_{2}=\max \left\{N_{1}, N_{2}\right\}$ and $N_{1} \wedge N_{2}=\min \left\{N_{1}, N_{2}\right\}$.
2.2. Function spaces. For $1 \leq p \leq \infty, L^{p}$ denotes the usual Lebesgue space and for $s \in \mathbb{R}, H^{s}$ is the $L^{2}$-based Sobolev space with norm $\|f\|_{H^{s}}=\left\|J_{x}^{s} f\right\|_{L^{2}}$. If $B$ is a space of functions on $\mathbb{R}, T>0$ and $1 \leq p \leq \infty$, we define the spaces $L_{T}^{p} B_{x}$ and $L_{t}^{p} B_{x}$ by the norms

Definition 2.1. For $n \geq 1$ and $\chi$ a bounded measurable function on $\mathbb{R}^{n}$, we define the multilinear Fourier multiplier operator $\Pi_{\chi}^{n}$ on $\mathcal{S}(\mathbb{R})^{n}$ by

\end{equation*}

If $\sigma$ is a permutation of $\{1, \ldots, n\}$, then it is clear that

where $\chi_{\sigma}\left(\xi_{1}, \ldots, \xi_{n}\right)=\chi\left(\xi_{\sigma(1)}, \ldots, \xi_{\sigma(n)}\right)$. For any $t>0$, we define $\left.\mathbb{R}_{t}^{n}=\mathbb{R}^{n} \times\right] 0, t[$ and for $u_{1}, \ldots u_{n+1} \in \mathcal{S}\left(\mathbb{R}^{2}\right)$, we set

When there is no risk of confusion, we will write $G_{t}^{n}=G_{t, \chi}^{n}$ with $\chi \in L^{\infty}\left(\mathbb{R}^{n}\right)$.
From Plancherel theorem, it is not too hard to check that

where $\tilde{\chi}\left(\xi_{1}, \ldots, \xi_{n}\right)=\chi\left(-\sum_{i=1}^{n} \xi_{i}, \xi_{2}, \ldots, \xi_{n}\right)$. We deduce from (2.5)-(2.7) that

The classical Coifman-Meyer theorem [7] states that if $\chi$ is smooth away from the origin and satisfies the Hörmander-Milhin condition

for sufficiently many multi-indices $\beta \in \mathbb{N}^{n}$, then the operator $\Pi_{\chi}^{n}$ is bounded from $L^{p_{1}}(\mathbb{R}) \times \cdots \times L^{p_{n}}(\mathbb{R})$ to $L^{p}(\mathbb{R})$ and satisfies

as long as $1<p_{j} \leq+\infty, 1 \leq p<+\infty$ and $\frac{1}{p}=\frac{1}{p_{1}}+\cdots \frac{1}{p_{n}}$.
In the sequel, we will need the following generalized version of Coifman-Meyer's theorem.

Theorem 2.2. Let $1<p_{1}, \cdots, p_{n}<+\infty$ and $1 \leq p<+\infty$ satisfy $\frac{1}{p}=\frac{1}{p_{1}}+\cdots \frac{1}{p_{n}}$. Assume that $f_{1}, \ldots, f_{n} \in \mathcal{S}(\mathbb{R})$ are functions with Fourier variables supported in $\left\{|\xi| \sim N_{i}\right\}$ for some dyadic numbers $N_{1}, \ldots, N_{n}$.

Assume also that $\chi \in C^{\infty}\left(\mathbb{R}^{n}\right)$ satisfies the Marcinkiewicz type condition

\forall \beta=\left(\beta_{1}, \ldots, \beta_{n}\right) \in \mathbb{N}^{n}, \quad\left|\partial^{\beta} \chi(\xi)\right| \lesssim \prod_{i=1}^{n}\left|\xi_{i}\right|^{-\beta_{i}} \tag{2.11}

on the support of $\prod_{i=1}^{n} \hat{f}_{i}\left(\xi_{i}\right)$. Then,

with an implicit constant that doesn't depend on $N_{1}, \ldots, N_{n}$.
Remark 2.3. Condition (2.9) is too restrictive for our purpose. For instance if $N_{1} \ll N_{2}$ are dyadic numbers and

then $\chi$ clearly satisfies condition (2.11), but $\left|\partial_{\xi_{1}} \chi\left(\xi_{1}, \xi_{2}\right)\right| \sim N_{1}^{-1} \gg N_{2}^{-1} \sim$ $\left|\left(\xi_{1}, \xi_{2}\right)\right|^{-1}$, so that $\chi$ does not satisfy (2.9).

Theorem 2.2 was proved by Muscalu, Pipher, Tao and Thiele [29] in the case of bilinear Fourier multipliers ${ }^{4}$ (in dimension 2).

One could certainly prove Theorem 2.2 by extending the arguments in [29] to the multilinear case ${ }^{5}$. Instead, we will deduce Theorem 2.2 as a Corollary of Bernicot's theorem in [3].
Theorem 2.4 ([3], Theorem 1.3). Suppose $1<p_{1}, \ldots, p_{n}<\infty, 1 \leq p<\infty$ and $1 / p=1 / p_{1}+\ldots+1 / p_{n}$. Assume that $\chi \in C^{\infty}\left(\mathbb{R}^{n}\right)$ satisfies

\forall \beta=\left(\beta_{1}, \ldots, \beta_{n}\right) \in \mathbb{N}^{n}, \quad\left|\partial^{\beta} \chi(\xi)\right| \lesssim \frac{\prod_{i=1}^{n}\left|\lambda_{i}\right|^{\beta_{i}}}{d_{\lambda}(\xi, 0)^{|\beta|}} \tag{2.13}
\end{equation*}
$$

for some $\lambda_{1}, \ldots, \lambda_{n}>0$ and where $d_{\lambda}$ is the metric defined by $d_{\lambda}(\xi, 0)=\sum_{i=1}^{n} \lambda_{i}\left|\xi_{i}\right|$. Then we have for any smooth functions $f_{1}, \ldots, f_{n} \in \mathcal{S}(\mathbb{R})$

\left\|\Pi_{\chi}^{n}\left(f_{1}, \ldots, f_{n}\right)\right\|_{L^{p}} \lesssim \prod_{i=1}^{n}\left\|f_{i}\right\|_{L^{p_{i}}} \tag{2.14}

with an implicit constant that doesn't depend on $\lambda$.

[^4]Proof of Theorem 2.2. Noticing that

with $\tilde{\chi}\left(\xi_{1}, \cdots, \xi_{n}\right)=\chi\left(\xi_{1}, \cdots, \xi_{n}\right) \prod_{i=1}^{n} \phi_{\sim N_{i}}\left(\xi_{i}\right)$, it suffices to show that $\tilde{\chi}$ satisfies (2.13) for suitable $\lambda_{1}, \cdots, \lambda_{n}>0$. But setting $\lambda=\left(\frac{N_{n}}{N_{1}}, \ldots, \frac{N_{n}}{N_{n-1}}, 1\right)$, this is easily checked since on the one hand

\frac{\prod_{i=1}^{n}\left|\lambda_{i}\right|^{\beta_{i}}}{d_{\lambda}(\xi, 0)^{|\beta|}} \sim \frac{\prod_{i=1}^{n}\left(\frac{N_{n}}{N_{i}}\right)^{\beta_{i}}}{\left(N_{n} \sum_{i=1}^{n} \frac{\left|\xi_{i}\right|}{N_{i}}\right)^{|\beta|}} \sim \prod_{i=1}^{n} N_{i}^{-\beta_{i}}

for $\left|\xi_{i}\right| \sim N_{i}$.
Remark 2.5. It is worth noticing that if two symbols $\chi_{1}, \chi_{2}$ satisfy (2.11), then this condition also holds for the product function $\chi_{1} \chi_{2}$. This is easily obtained thanks to the Leibniz rule.

Lemma 2.6. Let $0<\alpha \leq 1$. Let $N_{1} \ll N_{2}$ be two dyadic numbers. Then the symbol $\chi$ defined on $\mathbb{R}^{2}$ by

where $\Omega_{2}$ is defined in (3.1), satisfies the Marcinkiewicz condition (2.11) on the set $\left\{\left(\xi_{1}, \xi_{2}\right) \in \mathbb{R}^{2}:\left|\xi_{1}\right| \sim N_{1},\left|\xi_{2}\right| \sim N_{2}\right\}$.

Proof. Let $\left(\xi_{1}, \xi_{2}\right) \in \mathbb{R}^{2}$ be such that $\left|\xi_{1}\right| \sim N_{1}$ and $\left|\xi_{2}\right| \sim N_{2}$. First we estimate $\partial^{\beta} \Omega_{2}\left(\xi_{1}, \xi_{2}\right)$ for $\beta=\left(\beta_{1}, \beta_{2}\right) \in \mathbb{N}^{2}$. From Lemma 3.1 and the mean value theorem we easily get that

& \left|\partial^{\beta} \Omega_{2}\left(\xi_{1}, \xi_{2}\right)\right| \lesssim N_{1}^{\alpha+1-|\beta|} \quad \text { if } \beta_{1} \geq 2, \beta_{2}=0 \tag{2.17}
\end{align*}

Now classical derivative rules lead to

C_{\beta}=\left\{\gamma=\left(\gamma_{i, j}\right)_{\substack{0 \leq i \leq \beta_{1} \\ 0 \leq j \leq \beta_{2}}}: \sum_{\substack{0 \leq i \leq \beta_{1} \\ 0 \leq j \leq \beta_{2}}} \gamma_{i, j}=|\beta|, \sum_{\substack{0 \leq i \leq \beta_{1} \\ 0 \leq j \leq \beta_{2}}} i \gamma_{i, j}=\beta_{1}, \sum_{\substack{0 \leq i \leq \beta_{1} \\ 0 \leq j \leq \beta_{2}}} j \gamma_{i, j}=\beta_{2}\right\} .

Therefore, we deduce from (3.2) as well as (2.15)-(2.16)-(2.17) that

& \quad \lesssim \max _{\gamma \in C_{\beta}} \frac{N_{1}^{1+\beta_{1}} N_{2}^{\alpha+\beta_{2}}}{\left(N_{1} N_{2}^{\alpha}\right)^{|\beta|+1}} N_{2}^{\alpha \gamma_{1,0}} \prod_{j=0}^{\beta_{2}}\left(N_{1} N_{2}^{\alpha-j}\right)^{\gamma_{0, j}} \cdot \prod_{i=2}^{\beta_{1}} N_{1}^{(\alpha+1-i) \gamma_{i, 0}} \cdot \prod_{\substack{1 \leq i \leq \beta_{1} \\
1 \leq j \leq \beta_{2}}} N_{2}^{(\alpha+1-i-j) \gamma_{i, j}} \\
& \\
& \quad \lesssim \max _{\gamma \in C_{\beta}} N_{1}^{A_{\gamma}} N_{2}^{B_{\gamma}}
\end{aligned}
$$

with

Noticing that for $\gamma \in C_{\beta}$ we have

& =\alpha \sum_{i=2}^{\beta_{1}} \gamma_{i, 0}+\sum_{\substack{1 \leq i \leq \beta_{1} \\
1 \leq j \leq \beta_{2}}}(i-1) \gamma_{i, j} .
\end{aligned}

Similarly, we get

We conclude that $A_{\gamma} \geq 0$ and $A_{\gamma}=-B_{\gamma}$, which provides

2.4. Basic estimates on the sum space $F^{0, \frac{1}{2}}=X^{-1,1}+X^{0,\left(\frac{1}{2}\right)_{+}}$. By definition of sum space in (2.2), we always have by taking the trivial decompositions $\left(u_{1}, u_{2}\right)=$ $(u, 0)$ or $\left(u_{1}, u_{2}\right)=(0, u)$ that

## 3. $L^{2}$-MULTILINEAR ESTIMATES

3.1. $L^{2}$-bilinear estimates. We follow the strategy in [28] to show $L^{2}$-bilinear estimates related to the dispersive symbol.

Let us define the resonance function of order 2 associated with (1.1) by

where $\omega_{\alpha+1}$ is the dispersive symbol defined in Hypothesis 1. For $\xi_{1}, \xi_{2}, \xi_{3} \in \mathbb{R}$, it will be convenient to define the quantities $\left|\xi_{\text {max }}\right| \geq\left|\xi_{\text {med }}\right| \geq\left|\xi_{\text {min }}\right|$ to be the maximum, median and minimum of $\left|\xi_{1}\right|,\left|\xi_{2}\right|$ and $\left|\xi_{3}\right|$ respectively.

For the sake of completeness, we recall a few results proved in [28].
Lemma 3.1 ([28], Lemma 2.1). Let $\alpha>0$. Let $\xi_{1}, \xi_{2} \in \mathbb{R}$, and $\xi_{3}=-\left(\xi_{1}+\xi_{2}\right)$. Then

If $N_{\min } \lesssim 1$, then

where $G_{t, \chi}^{2}$ is defined in (2.6).
Proof. From (2.8) we may always assume $N_{1} \leq N_{2} \leq N_{3}$. Estimate (3.6) is easily obtained thanks to Plancherel identity and Bernstein inequality. Thus it remains to deal with the case $N_{1} \gg 1$. By localization considerations, $G_{t, \chi}^{2}$ vanishes unless $N_{2} \sim N_{3}$. Setting $R=N_{1}^{1+\frac{\alpha}{4}} N_{3}^{\alpha-1}$, we split $G_{t, \chi}^{2}$ as

where $G_{\infty}^{2}(u, v, w)=\int_{\mathbb{R}^{2}} \Pi_{\chi}^{2}(u, v) w$ and $1_{t, R}^{h i g h}, 1_{t, R}^{\text {low }}$ are defined in (3.3).
The contribution of $G_{t}^{2, h i g h}$ is estimated thanks to Lemma 3.3 as well as Hölder inequality by

To evaluate the contribution of $G_{t}^{2, \text { low }}$, we use Lemma 3.1 and we get

& +G_{\infty}^{2}\left(Q_{\ll N_{1} N_{3}^{\alpha}}\left(1_{t, R}^{\text {low }} u_{1}\right), Q_{\ll N_{1} N_{3}^{\alpha}} u_{2}, Q_{\sim N_{1} N_{3}^{\alpha}} u_{3}\right) \\
= & : G_{t, 1}^{2, \text { low }}+G_{t, 2}^{2, \text { low }}+G_{t, 3}^{2, \text { low }} . \tag{3.10}

& \lesssim \sum_{L_{1} \gtrsim N_{1} N_{3}^{\alpha}}\left(L_{1}^{-\left(\frac{1}{2}\right)+} \vee L_{1}^{-1} N_{1}\right) N_{3}^{\frac{1}{2}-\frac{\alpha}{4}}\left\|u_{1}\right\|_{F^{0, \frac{1}{2}}}\left\|u_{2}\right\|_{Z^{0}}\left\|u_{3}\right\|_{Z^{0}} \\
& \lesssim N_{1}^{-\frac{1}{2}-\frac{\alpha}{4}} N_{3}^{1-\alpha} \prod_{i=1}^{3}\left\|u_{i}\right\|_{Z^{0}}, \tag{3.11}
\end{align*}
$$

where in the last step we used that $0 \leq \alpha \leq 1$. Using again Theorem 2.2, Hölder inequality and Lemma 2.7 we estimate the contribution of $G_{t, 2}^{2, \text { low }}$ by

3.12) & \lesssim N_{1}^{-\frac{1}{2}-\frac{\alpha}{4}} N_{3}^{(1-\alpha)_{+}}\left(N_{1}^{-\frac{1}{2}+\frac{\alpha}{4}}\left\|Q_{\ll N_{1} N_{3}^{\alpha}}\left(1_{t, R}^{l o w} u_{1}\right)\right\|_{L_{t}^{2} L_{x}^{\infty-}}\right)\left\|u_{2}\right\|_{Z^{0}}\left\|u_{3}\right\|_{Z^{0}} . \tag{3.12}

& \lesssim\left\|u_{1}\right\|_{Z^{0}}+\sum_{L \gtrsim N_{1} N_{3}^{\alpha}}\left(L^{-\frac{1}{2}} \vee L^{-1} N_{1}\right) N_{1}^{\frac{\alpha}{4}}\left\|u_{1}\right\|_{F^{0, \frac{1}{2}}} \\
& \lesssim\left\|u_{1}\right\|_{Z^{0}} . \tag{3.14}
\end{align*}
$$

Combining (3.12)-(3.14) we infer

3.2. $L^{2}$-trilinear estimates. We first state an elementary estimate.

Proposition 3.6. Let $0<\alpha \leq 1$. Assume $0<t \leq 1$ and $u_{i} \in Z^{0} i=1,2,3,4$ are functions with spatial Fourier support in $\left\{|\xi| \sim N_{i}\right\}$ with $N_{i}$ dyadic. Let $\chi \in$ $C^{\infty}\left(\mathbb{R}^{3}\right)$ satisfy the Marcinkiewicz condition (2.11).

Then it holds that

\left|G_{t, \chi}^{3}\left(u_{1}, u_{2}, u_{3}, u_{4}\right)\right| \lesssim N_{1}^{\left(\frac{1}{2}\right)-}\left\langle N_{1}\right\rangle^{-\frac{\alpha}{4}} N_{2}^{\left(\frac{1}{2}\right)-}\left\langle N_{2}\right\rangle^{-\frac{\alpha}{4}} N_{\max }^{0_{+}} \prod_{i=1}^{4}\left\|u_{i}\right\|_{Z^{0}} \tag{3.15}

For $\xi_{1}, \xi_{2}, \xi_{3}, \xi_{4} \in \mathbb{R}$, it will be convenient to define the quantities $\left|\xi_{\text {max }}\right| \geq\left|\xi_{\text {sub }}\right| \geq$ $\left|\xi_{t h d}\right| \geq\left|\xi_{\text {min }}\right|$ to be the maximum, sub-maximum, third-maximum and minimum of $\left|\xi_{1}\right|,\left|\xi_{2}\right|,\left|\xi_{3}\right|$ and $\left|\xi_{4}\right|$ respectively.

Lemma 3.7. Let $\alpha>0$. Let $\xi_{1}, \xi_{2}, \xi_{3} \in \mathbb{R}$ and $\xi_{4}=-\left(\xi_{1}+\xi_{2}+\xi_{3}\right)$. If we assume that $\left|\xi_{\text {min }}\right| \ll\left|\xi_{\text {thd }}\right|$ then it holds

Let $\chi \in C^{\infty}\left(\mathbb{R}^{3}\right)$ satisfy the Marcinkiewicz condition (2.11). Then,

Proof. From (2.8) it is sufficient to consider the case $N_{1} \ll N_{2} \leq N_{3} \sim N_{4}$. Moreover, we may assume that $N_{2} N_{4}^{\alpha} \gg 1$ and $N_{2} \gg 1$ since otherwise the claim follows from estimate (3.15). We proceed now as in the proof of Proposition 3.5. First we decompose $G_{t}^{3}$ as $G_{t}^{3, \text { high }}+G_{t}^{3, \text { low }}$ with

According to (3.17) the above sum is nontrivial only for $L_{\max } \gtrsim N_{2} N_{4}^{\alpha}$. In the case where $L_{\max }=L_{1}$, we deduce from (2.12)-(2.21)-(3.13) and Lemma 3.4 that

& \lesssim \sum_{L_{1} \gtrsim N_{2} N_{4}^{\alpha}}\left(L_{1}^{-\left(\frac{1}{2}\right)_{+}} \vee L_{1}^{-1} N_{1}\right) N_{1}^{\left(\frac{1}{2}\right)_{-}} N_{2}^{\frac{1}{2}-\frac{\alpha}{4}} N_{4}^{0+}\left\|u_{1}\right\|_{F^{0, \frac{1}{2}}}\left\|u_{2}\right\|_{Z^{0}}\left\|u_{3}\right\|_{Z^{0}}\left\|u_{4}\right\|_{Z^{0}} \\
& \lesssim N_{1}^{\left(\frac{1}{2}\right)-} N_{2}^{-\frac{1}{2}-\frac{\alpha}{4}} N_{4}^{(1-\alpha)+} \prod_{i=1}^{4}\left\|u_{i}\right\|_{Z^{0}} .
\end{aligned}
$$

In the same way, we get that the sum over $L_{\max }=L_{2}$ is controlled by

& \lesssim \sum_{L_{2} \gtrsim N_{2} N_{4}^{\alpha}}\left(L_{2}^{-\left(\frac{1}{2}\right)_{+}} \vee L_{2}^{-1} N_{2}\right) N_{1}^{\left(\frac{1}{2}\right)-} N_{4}^{\left(\frac{1}{2}-\frac{\alpha}{4}\right)+}\left\|u_{1}\right\|_{L_{t}^{\infty} L_{x}^{2}}\left\|u_{2}\right\|_{F^{0, \frac{1}{2}}}\left\|u_{3}\right\|_{Z^{0}}\left\|u_{4}\right\|_{Z^{0}} \\
& \lesssim N_{1}^{\left(\frac{1}{2}\right)-} N_{2}^{-\frac{1}{2}-\frac{\alpha}{4}} N_{4}^{(1-\alpha)+} \prod_{i=1}^{4}\left\|u_{i}\right\|_{Z^{0}} .
\end{aligned}
$$

Arguing similarly and using (3.14), the sum over $L_{\max }=L_{3}$ can be estimated by

& \lesssim \sum_{L_{3} \gtrsim N_{2} N_{4}^{\alpha}}\left(L_{3}^{-\left(\frac{1}{2}\right)_{+}} \vee L_{3}^{-1} N_{4}\right) N_{1}^{\left(\frac{1}{2}\right)-} N_{2}^{\frac{1}{2}-\frac{\alpha}{4}} N_{4}^{0+}\left\|u_{1}\right\|_{L_{t}^{\infty} L_{x}^{2}}\left\|u_{2}\right\|_{Z^{0}}\left\|u_{3}\right\|_{F^{0, \frac{1}{2}}}\left\|u_{4}\right\|_{Z^{0}} \\

Finally we easily check that the bound in the case $L_{\max }=L_{4}$ is obtained similarly. Gathering all these estimates we get the desired result.

## 4. Estimates for a Smooth solution

The aim of this section is to get suitable a priori estimates of a solution of (1.8) in the space $Y^{s} \hookrightarrow Z^{s}$ for $s>s_{\alpha}$.

### 4.1. Bilinear estimate.

Proposition 4.1. Assume that $0<T \leq 1$ and $s \geq 0$. Let $u$ be a smooth solution to (1.8) defined in the time interval $[0, T]$. Then

4.2. Refined Strichartz estimate. Let us first recall the following Strichartz estimate:

where $U_{\alpha}(t)=e^{t L_{\alpha+1}}$ is the free evolution operator associated to (1.8). This estimate is a direct consequence of Theorem 2.1 in [17] applied with $\phi=(1-\eta) \omega_{\alpha+1}$. From this we get following the proof of Proposition 2.3 in [21] (see also [16]) the refined Strichartz estimate:

Proposition 4.3. Let $0<\alpha \leq 1$. Assume that $0<T \leq 1$ and $s>s_{\alpha}$. Let $u$ be a smooth solution to (1.8) defined on the time interval $[0, T]$. There exists $0<\kappa<\frac{1}{2}$ such that if $0<T \ll\|u\|_{L_{T}^{-}}^{-\frac{1}{\kappa}} H_{x}^{s}$, then

\left\|J_{x}^{\left(s-s_{\alpha}\right)+(1-\alpha)_{-}} u\right\|_{L_{T}^{2} L_{x}^{\infty}} \leq 2 T^{\kappa}\|u\|_{L_{T}^{\infty} H_{x}^{s}} \leq 1 \tag{4.6}
\end{equation*}
$$

Proof. From Bernstein's inequality, we easily estimate the low frequencies part:

& \lesssim T^{\kappa_{1}}\|u\|_{L_{T}^{\infty} H_{x}^{s}}+T^{\kappa_{2}}\|u\|_{L_{T}^{2} L_{x}^{\infty}}\|u\|_{L_{T}^{\infty} H_{x}^{s}}
\end{aligned}
$$

Noticing that for $s>s_{\alpha}$ and $0<\alpha \leq 1$, it holds $\left(s-s_{\alpha}\right)+(1-\alpha)_{-} \geq 0$, we obtain (4.6) by combining the two above estimates and taking $\kappa=\kappa_{1} \vee \kappa_{2}$.

Corollary 4.1. Let $0<\alpha \leq 1$. Assume that $0<T \leq 1$ and $s>s_{\alpha}$. Let $u$ be a smooth solution to (1.8) defined on the time interval $[0, T]$. There exist $0<\kappa<\frac{1}{2}$ and $C_{0}>1$ such that if $0<T \ll\|u\|_{L_{T}^{-\alpha}}^{-\frac{1}{\kappa}} H_{x}^{s}$, then

Proof. We have to extend the function $u$ from $] 0, T[$ to $\mathbb{R}$. For this we introduce the extension operator $\rho_{T}$ defined by

According to classical results on extension operators (see for instance [23]), for any $1 / 2<b \leq 1, f \mapsto \eta f\left(\mu_{T}(\cdot)\right)$ is linear continuous from $H^{b}([0, T])$ into $H^{b}(\mathbb{R})$ with a bound that does not depend on $T>0$.
First, the unitarity of the free group $U_{\alpha}(\cdot)$ in $H^{s}(\mathbb{R})$ easily leads to
(4.9) $\left\|\rho_{T}(u)\right\|_{L_{t}^{\infty} H_{x}^{s}} \lesssim\left\|u\left(\mu_{T}(\cdot)\right)\right\|_{L_{t}^{\infty} H_{x}^{s}} \lesssim\|u\|_{L_{T}^{\infty} H_{x}^{s}}+\|u(0)\|_{H^{s}}+\|u(T)\|_{H^{s}}$.

Second, the definition of the $X^{\theta, b}$-norm leads, for $1 / 2<b \leq 1$ and $\theta \in \mathbb{R}$, to (4.10)

& +\left\|\eta U_{\alpha}(-\cdot) J_{x}^{\theta} U_{\alpha}(T) u(T)\right\|_{L^{2}(] T,+\infty\left[; L_{x}^{\infty}\right)}
\end{aligned}
$$

whereas (4.3) leads to

& \lesssim\|u(0)\|_{L_{x}^{2}}+\left\|J_{x}^{\theta+\frac{1-\alpha}{4}} u(0)\right\|_{L_{x}^{2}} \lesssim\|u(0)\|_{H^{\theta+\frac{1-\alpha}{4}}}
\end{aligned}
$$

and in the same way

Noticing that, for $0<\alpha \leq 1, s-s_{\alpha}+1-\alpha=s-\frac{1}{2}+\frac{\alpha}{4} \leq s-\frac{1}{4}$, this ensures that

& +\|u(0)\|_{H^{s-\varepsilon}}+\|u(T)\|_{H^{s-\varepsilon}} \tag{4.11}
\end{align*}
$$

for any $\varepsilon>0$.
Gathering (4.9)-(4.11), we thus infer that for any $(T, s) \in \mathbb{R}_{+}^{*} \times \mathbb{R}, \rho_{T}$ is a bounded
linear operator from $C\left([0, T] ; H^{s}(\mathbb{R})\right) \cap X_{T}^{s-1,1} \cap L_{T}^{2} W_{x}^{\left(s-s_{\alpha}\right)+(1-\alpha)_{-}, \infty}$ into $Y^{s}$ with a bound that does not depend on $(T, s)$. Therefore (4.1) and (4.6) lead to (4.7).
4.3. Energy estimate. Applying the operator $P_{N}$ with $N>0$ dyadic to equation (1.8), taking the $L^{2}$ scalar product with $P_{N} u$ and integrating on $] 0, t[$ we obtain

Let $N_{0} \geq 2^{9}$ and $N>N_{0}$. Define $\mathcal{J}_{N}$ by

By localization considerations, we get

\mathcal{J}_{N}^{2}=-\langle N\rangle^{2 s} \sum_{N_{1} \gtrsim N} \int_{\mathbb{R}_{t}} P_{N_{1}} u P_{\sim N_{1}} u P_{N}^{2} \partial_{x} u \tag{4.14}
\end{equation*}

Since $P_{N} P_{\sim N}=P_{N}$, we may rewrite $J_{N}^{1}$ more symmetrically as

& =N^{2 s} \int_{\mathbb{R}_{t}} \Pi_{\chi_{1}}^{2}\left(\partial_{x} u_{\ll N}, P_{\sim N} u\right) P_{\sim N} u \tag{4.15}
\end{align*}
$$

with

\begin{equation*}
\chi_{1}\left(\xi_{1}, \xi_{2}\right)=\left(\frac{\langle N\rangle}{N}\right)^{2 s}\left(\phi_{N}\left(\xi_{2}\right)+2 i \frac{\xi_{1}+\xi_{2}}{N} \chi\left(\xi_{1}, \xi_{2}\right) \phi_{\sim N}\left(\xi_{2}\right)\right) \phi_{N}\left(\xi_{1}+\xi_{2}\right) \tag{4.16}

Note that the function $\chi_{1}$ satisfies the condition (2.11). This decomposition of $\mathcal{J}_{N}$ motivates the definition of our modified energy. For $N_{0}>1, u \in H^{s}(\mathbb{R})$, with $s \in \mathbb{R}$, and $N>0$ dyadic we define

\mathcal{E}_{N}^{1}(u)=\int_{\mathbb{R}^{2}} \frac{\chi_{1}\left(\xi_{1}, \xi_{2}\right)}{\Omega_{2}\left(\xi_{1}, \xi_{2}\right)} \xi_{1} \widehat{u_{\ll N}}\left(\xi_{1}\right) \widehat{P_{\sim N} u}\left(\xi_{2}\right) \widehat{P_{\sim N} u}\left(-\xi_{1}-\xi_{2}\right) d \xi_{1} d \xi_{2},

$\Omega_{2}\left(\xi_{1}, \xi_{2}\right)$ is the quadratic resonance relation defined in (3.1), and $c$ is a real constant to be fixed later.

We define the modified energy at the $H^{s}$-regularity by using a nonhomogeneous dyadic decomposition in spatial frequency ${ }^{6}$

Rewriting $\mathcal{K}_{N}^{31}$ as

## 5. Estimates for the difference of two solutions

In this section, we provide the needed estimates for the difference $w$ of two solutions $u, v$ of (1.8). If $w=u-v$ and $z=u+v$, then

The lack of symmetry in the nonlinear term of (5.1) prevents us to estimate $w$ in $Y_{T}^{s}, s>s_{\alpha}$. To overcome this difficulty, we will rather work at a lower regularity level $\sigma<0$ and more precisely with

Remark 5.1. For $\alpha \in] 0,1]$ and $s>s_{\alpha}=\frac{3}{2}-\frac{5}{4} \alpha$, it holds $-\frac{1}{2}+\frac{\alpha}{4}<0$ and $s-2+\frac{3}{2} \alpha>-\frac{1}{2}+\frac{\alpha}{4}$. Therefore, the definition interval in (5.2) is never empty. Moreover, it is worth noticing that $-\sigma<\frac{1}{2}-\frac{\alpha}{4} \leq s_{\alpha}<s$.

Since we are not able to control the $X_{T}^{\sigma-1,1} \cap L_{T}^{2} W_{x}^{1-\alpha+\left(\sigma-s_{\alpha}\right)_{-}, \infty}$ part of $w$ for $\sigma<0$ we need to bound the difference in the sum space $F^{\sigma, \frac{1}{2}}$. Finally, to treat some low-high interactions in the energy estimates, we also need to add a weight on the low space frequencies so that $w$ will take place in $\bar{Z}^{\sigma}$.

### 5.1. Bilinear estimate.

Proposition 5.2. Let $0<\alpha \leq 1$. Assume that $0<T \leq 1, s>s_{\alpha}$ and $-\frac{1}{2}+\frac{\alpha}{4}<$ $\sigma<\min \left(0, s-2+\frac{3}{2} \alpha\right)$. Let $z \in Y_{T}^{s}$ and let $w \in \bar{Z}_{T}^{\sigma}$ be a solution of (5.1) on $] 0, T[$ with $w_{0} \in \overline{H^{\sigma}}$. Then it holds

Now, using that $0<-\sigma<s$, we easily bound the contribution of the low frequency part $J_{\leq N_{0}}$ by

### 5.2. Refined Strichartz estimate.

We fix $-\frac{1}{2}+\frac{\alpha}{4}<\sigma<\min \left(0, s-2+\frac{3}{2} \alpha\right)$ and set $w=u-v$. It is clear that $w(0)=w_{0} \in \bar{H}^{\sigma}$ and the continuous embedding from $Y_{T}^{s}$ into $Z_{T}^{\sigma}$ ensures that $w \in Z_{T}^{\sigma}$. Now, from Duhamel formula we have

Therefore, taking $u_{0}-v_{0}=0$, we obtain that $u \equiv v$ on $] 0, T^{\prime}[$. Noticing, that equation (1.1) ensures that $u_{t}, v_{t} \in L^{\infty}\left(0, T ; H^{s-2}(\mathbb{R})\right)$ and thus $u, v \in C\left([0, T] ; L^{2}(\mathbb{R})\right)$, it follows that $v\left(T^{\prime}\right)=u\left(T^{\prime}\right)$. Repeating this argument a finite number of times we extend the uniqueness result on $] 0, T[$.
6.2. A priori estimates on smooth solutions. According to [31] (see also [4] to get the continuity of the flow-map) for any $u_{0} \in H^{\theta}(\mathbb{R})$, with $\theta \geq 3$, there exists a positive time $T=T\left(\left\|u_{0}\right\|_{H^{3}}\right)$ and a unique solution $u \in C\left([0, T] ; H^{\theta}(\mathbb{R})\right)$ to (1.8) emanating from $u_{0}$. Moreover, for any fixed $R>0$, the map $u_{0} \mapsto u$ is continuous from the ball of $H^{\theta}(\mathbb{R})$ of radius $R$ centered at the origin into $C\left([0, T] ; H^{\theta}(\mathbb{R})\right)$.

Let $u_{0} \in H^{\infty}(\mathbb{R})$. From the above result $u_{0}$ gives rise to a solution $u \in$ $C\left(\left[0, T^{*}\left[; H^{\infty}(\mathbb{R})\right)\right.\right.$ to (1.8) with $T^{*} \geq T\left(\left\|u_{0}\right\|_{H^{3}}\right)$ and

Now, applying (6.5) with $s=3, N_{0}=$ $\left[8 C_{2}\left(1+\left\|u_{0}\right\|_{H^{s^{\prime}}}\right)^{2}\right]^{\frac{1}{\delta}+}$, where $\delta=\min \left\{\alpha, s^{\prime}-s_{\alpha}\right\}$, and $T=\min \left\{T_{0},\left(8 C_{2} N_{0}^{\frac{3}{2}}\right)^{-1}\right\}$, we get

\|u\|_{Y_{T_{0}}^{s^{\prime}}}^{2} \leq 8 C_{0}^{2}\left\|u_{0}\right\|_{H^{s^{\prime}}}^{2}
$$

But since $T^{*}>T_{0}$, by continuity this ensures that $\|u\|_{Y_{T}^{s^{\prime}}}^{2} \leq 2^{4} C_{0}^{2}\left\|u_{0}\right\|_{H^{s^{\prime}}}^{2}$ for some $T_{0}<T<T^{*}$ which contradicts the definition of $T_{0}$. This concludes the proof of (6.4).

Note that Lemma 4.4 and Corollary 4.2 then ensure that for any $N_{0} \geq C_{1}(1+$ $\left.\left\|u_{0}\right\|_{H^{s_{\alpha}}}\right)^{\frac{1}{\alpha}}$, it holds

$$
\begin{equation*}
\left\|P_{\geq N_{0}} u\right\|_{L_{T}^{\infty} H_{x}^{s^{\prime}}}^{2} \lesssim\left\|P_{\geq N_{0}} u_{0}\right\|_{H^{s^{\prime}}}^{2}+\left(N_{0}^{-\alpha_{+}}+N_{0}^{\left(s_{\alpha}-s\right)_{+}}\right)\left(1+\left\|u_{0}\right\|_{H^{s^{\prime}}}\right)^{4} \tag{6.7}
\end{equation*}
$$

where $T>0$ is defined as in (6.4).
6.3. Local existence in $H^{s}(\mathbb{R}), s>s_{\alpha}$. Now let us fix $s>s_{\alpha}$ and $u_{0} \in H^{s}(\mathbb{R})$. We set $u_{0, n}=P_{\leq n} u_{0}$ and we denote by $u_{n} \in C\left(\left[0, T_{n}^{\star}\right) ; H^{\infty}(\mathbb{R})\right)$ the solutions to (1.8) emanating from $u_{0, n}$. Setting

$$
\begin{equation*}
T=A_{0}\left(1+\left\|u_{0}\right\|_{H^{s}}\right)^{-\frac{1}{\beta_{0}}} \tag{6.8}
\end{equation*}
$$

it follows from (6.4) that for any $n \in \mathbb{N}^{*}, T_{n}^{\star} \geq T$ and

$$
\begin{equation*}
\left\|u_{n}\right\|_{Y_{T}^{s}} \lesssim\left\|u_{0}\right\|_{H^{s}} \tag{6.9}
\end{equation*}
$$

Let $-\frac{1}{2}+\frac{\alpha}{4}<\sigma<\min \left(0, s-2+\frac{3}{2} \alpha\right)$. For $n \geq m \geq 1$, clearly $u_{0, n}-u_{0, m} \in \bar{L}^{2}(\mathbb{R})$ and thus (6.1) ensures that

$$
\left\|u_{n}-u_{m}\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{\sigma}} \lesssim\left\|u_{0, n}-u_{0, m}\right\|_{\bar{H}^{\sigma}} \lesssim\left\|P_{\geq m} u_{0}\right\|_{H^{s}}
$$

where $0<T^{\prime \prime}=T^{\prime \prime}\left(\left\|u_{0}\right\|_{H^{s^{\prime}}}\right) \leq T$. This last inequality combined with (6.7) ensure that

$$
\begin{align*}
\left\|u_{n}-u_{m}\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{s}}^{2} \lesssim & N_{0}^{2(s-\sigma)}\left\|P_{<N_{0}}\left(u_{n}-u_{m}\right)\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{\sigma}}^{2}  \tag{6.10}\\
& +\left\|P_{\geq N_{0}} u_{n}\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{s}}^{2}+\left\|P_{\geq N_{0}} u_{m}\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{s}}^{2} \\
\lesssim & N_{0}^{2(s-\sigma)}\left\|P_{\geq m} u_{0}\right\|_{H^{s}}^{2( }+\left\|P_{\geq N_{0}} u_{0}\right\|_{H^{s}}^{2} \\
& +\left(N_{0}^{-\alpha+}+N_{0}^{\left(s_{\alpha}-s\right)+}\right)\left(1+\left\|u_{0}\right\|_{\left.H^{s}\right)^{4}}\right. \tag{6.11}
\end{align*}
$$

for any $N_{0} \geq C_{1}\left(1+\left\|u_{0}\right\|_{H^{s_{\alpha}}}\right)^{\frac{1}{\alpha}}$. This proves that $\left\{u_{n}\right\}$ is a Cauchy sequence in $C\left(\left[0, T^{\prime \prime}\right] ; H^{s}(\mathbb{R})\right)$ and thus converges to some $u$ in this space. It is then not hard to check that $u \in Y_{T^{\prime \prime}}^{s}$ and is a solution to (1.8) emanating from $u_{0}$. By the uniqueness result, this is the only one. Repeating this argument a finite number of times we obtain that actually $\left\{u_{n}\right\}$ converges to $u$ in $C\left([0, T] ; H^{s}(\mathbb{R})\right)$ with $T$ defined in (6.8).
6.4. Continuity of the solution-map. Finally, to prove the continuity with respect to initial data, we take a sequence $\left\{u_{0}^{j}\right\} \subset B_{H^{s}}\left(0,2\left\|u_{0}\right\|_{H^{s}}\right)$ that converges to $u_{0}$ in $H^{s}(\mathbb{R})$. We denote by respectively $u^{j}$ and $u_{n}^{j}$ the associated solutions to (1.8) emanating from respectively $u_{0}^{j}$ and $P_{\leq n} u_{0}^{j}$. Noticing that

$$
\lim _{m \rightarrow+\infty} \sup _{j \in \mathbb{N}}\left\|P_{\geq m}\left(u_{0}^{j}\right)\right\|_{H^{s}}=0
$$

we infer from (6.11) that

$$
\lim _{n \rightarrow+\infty} \sup _{j \in \mathbb{N}}\left\|u^{j}-u_{n}^{j}\right\|_{L_{T^{\prime \prime}}^{\infty} H_{x}^{\sigma}}=0
$$

with $T^{\prime \prime}=T^{\prime \prime}\left(\left\|u_{0}\right\|_{H^{s}}\right)>0$. From

$$
\left\|u^{j}-u\right\|_{L_{T}^{\infty} H_{x}^{s}} \leq\left\|u^{j}-u_{n}^{j}\right\|_{L_{T}^{\infty} H_{x}^{s}}+\left\|u_{n}^{j}-u_{n}\right\|_{L_{T}^{\infty} H_{x}^{s}}+\left\|u_{n}-u\right\|_{L_{T}^{\infty} H_{x}^{s}}
$$

and the continuity with respect to initial data in $H^{3}(\mathbb{R})$ (note that $P_{\leq n} u_{0}$ and $P_{\leq n} u_{0}$ belong to $\left.H^{\infty}(\mathbb{R})\right)$, it follows that $u^{j} \rightarrow u$ in $C\left(\left[0, T^{\prime \prime}\right] ; H^{s}(\mathbb{R})\right)$. Iterating this process a finite number of times we obtain that $u^{j} \rightarrow u$ in $C\left([0, T] ; H^{s}(\mathbb{R})\right)$ with $T$ defined in (6.8) which completes the proof of Theorem 1.2.
