# Fixed points of $n$-valued maps, the fixed point property and the case of surfaces - a braid approach

#### Abstract

We study the fixed point theory of $n$-valued maps of a space $X$ using the fixed point theory of maps between $X$ and its configuration spaces. We give some general results to decide whether an $n$-valued map can be deformed to a fixed point free $n$-valued map. In the case of surfaces, we provide an algebraic criterion in terms of the braid groups of $X$ to study this problem. If $X$ is either the $k$-dimensional ball or an even-dimensional real or complex projective space, we show that the fixed point property holds for $n$-valued maps for all $n \geq 1$, and we prove the same result for even-dimensional spheres for all $n \geq 2$. If $X$ is the 2 -torus, we classify the homotopy classes of 2 -valued maps in terms of the braid groups of $X$. We do not currently have a complete characterisation of the homotopy classes of split 2 -valued maps of the 2 -torus that contain a fixed point free representative, but we give an infinite family of such homotopy classes.


## 1 Introduction

Multifunctions and their fixed point theory have been studied for a number of years, see for example the books [Ber, Gor], where fairly general classes of multifunctions and spaces are considered. Continuous $n$-valued functions are of particular interest, and more information about their fixed point theory on finite complexes may be found in [ $\mathrm{Br} 1, \mathrm{Br} 2$, Br3, Br4, BK, BL, Bet1, Bet2, Sch1, Sch2, Sch3]. In this paper, we will concentrate our attention on the case of metric spaces, and notably that of surfaces. In all of what follows, $X$ and $Y$ will be topological spaces, and $\phi: X \multimap Y$ will be a multivalued function
i.e. a function that to each $x \in X$ associates a non-empty subset $\phi(x)$ of $Y$. Following the notation and the terminology of the above-mentioned papers, a multifunction $\phi: X \multimap Y$ is upper semi-continuous if for all $x \in X, \phi(x)$ is closed, and given an open set $V$ in $Y$, the set $\{x \in X \mid \phi(x) \subset V\}$ is open in $X$, is lower semi-continuous if the set $\{x \in X \mid \phi(x) \cap V \neq \varnothing\}$ is open in $X$, and is continuous if it is upper semi-continuous and lower semi-continuous. Let $I$ denote the unit interval $[0,1]$. We recall the definitions of (split) $n$-valued maps.

Definitions. Let $X$ and $Y$ be topological spaces, and let $n \in \mathbb{N}$.
(a) An n-valued map (or multimap) $\phi: X \multimap Y$, is a continuous multifunction that to each $x \in X$ assigns an unordered subset of $Y$ of cardinal exactly $n$.
(b) A homotopy between two $n$-valued maps $\phi_{1}, \phi_{2}: X \multimap Y$ is an $n$-valued map $H: X \times$ $I \multimap Y$ such that $\phi_{1}=H(\cdot, 0)$ and $\phi_{2}=H(\cdot, 1)$.

Definition ([Sch1]). An $n$-valued function $\phi: X \multimap Y$ is said to be a split n-valued map if there exist single-valued maps $f_{1}, f_{2}, \ldots, f_{n}: X \longrightarrow Y$ such that $\phi(x)=\left\{f_{1}(x), \ldots, f_{n}(x)\right\}$ for all $x \in X$. This being the case, we shall write $\phi=\left\{f_{1}, \ldots, f_{n}\right\}$. Let $\operatorname{Sp}(X, Y, n)$ denote the set of split $n$-valued maps between $X$ and $Y$.

A priori, $\phi: X \multimap Y$ is just an $n$-valued function, but if it is split then it is continuous by Proposition 42 in the Appendix, which justifies the use of the word 'map' in the above definition. Partly for this reason, split $n$-valued maps play an important rôle in the theory.

We now recall the notion of coincidence of a pair $(\phi, f)$ where $\phi$ is an $n$-valued map and $f: X \longrightarrow Y$ is a single-valued map (meaning continuous) $c f$. [BK]. Let $\mathrm{Id}_{X}: X \longrightarrow X$ denote the identity map of $X$.

Definitions. Let $\phi: X \multimap Y$ be an $n$-valued map, and let $f: X \longrightarrow Y$ be a singlevalued map. The set of coincidences of the pair $(\phi, f)$ is denoted by $\operatorname{Coin}(\phi, f)=$ $\{x \in X \mid f(x) \in \phi(x)\}$. If $X=Y$ and $f=\operatorname{Id}_{X}$ then $\operatorname{Coin}\left(\phi, \operatorname{Id}_{X}\right)=\{x \in X \mid x \in \phi(x)\}$ is called the fixed point set of $\phi$, and will be denoted by $\operatorname{Fix}(\phi)$. If $f$ is the constant map $c_{y_{0}}$ at a point $y_{0} \in Y$ then $\operatorname{Coin}\left(\phi, c_{y_{0}}\right)=\left\{x \in X \mid y_{0} \in \phi(x)\right\}$ is called the set of roots of $\phi$ at $y_{0}$.

Recall that a space $X$ is said to have the fixed point property if any self-map of $X$ has a fixed point. This notion may be generalised to $n$-valued maps as follows.

Definition. If $n \in \mathbb{N}$, a space $X$ is said to have the fixed point property for $n$-valued maps if any $n$-valued map $\phi: X \multimap X$ has a fixed point.

If $n=1$ then we obtain the classical notion of the fixed point property. It is well known that the fixed point theory of surfaces is more complicated than that of manifolds of higher dimension. This is also the case for $n$-valued maps. A number of results for singled-valued maps of manifolds of dimension at least three may be generalised to the setting of $n$ valued maps, see for example the results of Schirmer from the 1980's [Sch1, Sch2, Sch3]. In dimension one or two, the situation is more complex, and has only been analysed within the last ten years or so, see [Br1] for the study of $n$-valued maps of the circle. The papers [Br4, BL] illustrate some of the difficulties that occur when the manifold is the 2-torus $\mathbb{T}^{2}$. Our expectation is that the case of surfaces of negative Euler characteristic will be much more involved.

In this paper, we explore the fixed point property for $n$-valued maps, and we extend the famous result of L. E. J. Brouwer that every self-map of the disc has a fixed point to this setting [Bro]. We will also develop some tools to decide whether an $n$-valued map can be deformed to a fixed point free $n$-valued map, and we give a partial classification of those split 2 -valued maps of $\mathbb{T}^{2}$ that can be deformed to fixed point free 2 -valued maps. Our approach to the study of fixed point theory of $n$-valued maps makes use of the homotopy theory of configuration spaces. It is probable that these ideas can also be adapted to coincidence theory. This viewpoint is fairly general. It helps us to understand the theory, and provides some means to perform (not necessarily easy) computations in general. Nevertheless, for some specific situations, such as for surfaces of non-negative Euler characteristic, these calculations are often tractable. To explain our approach, let $F_{n}(Y)$ denote the $n^{\text {th }}$ (ordered) configuration space of a space $Y$, defined by:

F_{n}(Y)=\left\{\left(y_{1}, \ldots, y_{n}\right) \mid y_{i} \in Y, \text { and } y_{i} \neq y_{j} \text { if } i \neq j\right\} .
$$

Configuration spaces play an important rôle in several branches of mathematics and have been extensively studied, see [CG, FH] for example. The symmetric group $S_{n}$ on $n$ elements acts freely on $F_{n}(Y)$ by permuting coordinates. The corresponding quotient space, known as the $n^{\text {th }}$ (unordered) configuration space of $Y$, will be denoted by $D_{n}(Y)$, and the quotient map will be denoted by $\pi: F_{n}(Y) \longrightarrow D_{n}(Y)$. The $n^{\text {th }}$ pure braid group $P_{n}(Y)$ (respectively the $n^{\text {th }}$ braid group $B_{n}(Y)$ ) of $Y$ is defined to be the fundamental group of $F_{n}(Y)$ (resp. of $D_{n}(Y)$ ), and there is a short exact sequence:

1 \longrightarrow P_{n}(Y) \longrightarrow B_{n}(Y) \xrightarrow{\tau} S_{n} \longrightarrow 1, \tag{1}
\end{equation*}

where $\tau$ is the homomorphism that to a braid associates its induced permutation. For $i=1, \ldots, n$, let $p_{i}: F_{n}(Y) \longrightarrow Y$ denote projection onto the $i^{\text {th }}$ factor. The notion of intermediate configuration spaces was defined in [GG1, GG3]. More precisely, if $n, m \in \mathbb{N}$, the subgroup $S_{n} \times S_{m} \subset S_{n+m}$ acts freely on $F_{n+m}(Y)$ by restriction, and the corresponding orbit space $F_{n+m}(Y) /\left(S_{n} \times S_{m}\right)$ is denoted by $D_{n, m}(Y)$. Let $B_{n, m}=\pi_{1}\left(D_{n, m}(Y)\right)$ denote the associated 'mixed' braid group. The space $F_{n+m}(Y)$ is equipped with the topology induced by the inclusion $F_{n+m}(Y) \subset Y^{n+m}$, and $D_{n, m}(Y)$ is equipped with the quotient topology. If $Y$ is a manifold without boundary then the natural projections $\bar{p}_{m, n}: D_{m, n}(Y) \longrightarrow D_{m}(Y)$ onto the first $m$ coordinates are fibrations. For maps whose target is a configuration space, we have the following notions.

Definitions. Let $X$ and $Y$ be topological spaces, and let $n \in \mathbb{N}$. A map $\Phi: X \longrightarrow D_{n}(Y)$ will be called an $n$-unordered map, and a map $\Psi: X \longrightarrow F_{n}(Y)$ will be called an $n$-ordered map. For such an $n$-ordered map, for $i=1, \ldots, n$, there exist maps $f_{i}: X \longrightarrow Y$ such that $\Psi(x)=\left(f_{1}(x), \ldots, f_{n}(x)\right)$ for all $x \in X$, and for which $f_{i}(x) \neq f_{j}(x)$ for all $1 \leq i, j \leq n$, $i \neq j$, and all $x \in X$. In this case, we will often write $\Psi=\left(f_{1}, \ldots, f_{n}\right)$.

The fixed point-theoretic concepts that were defined earlier for $n$-valued maps carry over naturally to $n$-unordered and $n$-ordered maps as follows.

Definitions. Let $X$ and $Y$ be topological spaces, let $f: X \longrightarrow Y$ be a single-valued map, let $y_{0} \in Y$, and let $n \in \mathbb{N}$.
(a) Given an $n$-unordered map $\Phi: X \longrightarrow D_{n}(Y), x \in X$ is said to be a coincidence of the pair $(\Phi, f)$ if there exist $\left(x_{1}, \ldots, x_{n}\right) \in F_{n}(Y)$ and $j \in\{1, \ldots, n\}$ such that $\Phi(x)=$
$\pi\left(x_{1}, \ldots, x_{n}\right)$ and $f(x)=x_{j}$. The set of coincidences of the pair $(\Phi, f)$ will be denoted by $\operatorname{Coin}(\Phi, f)$. If $X=Y$ and $f=\operatorname{Id}_{X}$ then $\operatorname{Coin}\left(\Phi, \operatorname{Id}_{X}\right)$ is called the fixed point set of $\Phi$, and is denoted by $\operatorname{Fix}(\Phi)$. If $f$ is the constant map $c_{y_{0}}$ at $y_{0}$ then $\operatorname{Coin}\left(\Phi, c_{y_{0}}\right)$ is called the set of roots of $\Phi$ at $y_{0}$.
(b) Given an $n$-ordered map $\Psi: X \longrightarrow F_{n}(Y)$, the set of coincidences of the pair $(\Psi, f)$ is defined by $\operatorname{Coin}(\Psi, f)=\left\{x \in X \mid f(x)=p_{j} \circ \Psi(x)\right.$ for some $\left.1 \leq j \leq n\right\}$. If $X=Y$ and $f=\operatorname{Id}_{X}$ then $\operatorname{Coin}\left(\Psi, \operatorname{Id}_{X}\right)=\left\{x \in X \mid x=p_{j} \circ \Psi(x)\right.$ for some $\left.1 \leq j \leq n\right\}$ is called the fixed point set of $\Psi$, and is denoted by $\operatorname{Fix}(\Psi)$. If $f$ is the constant map $c_{y_{0}}$ then $\operatorname{Coin}\left(\Psi, c_{y_{0}}\right)=\left\{x \in X \mid y_{0}=p_{j} \circ \Psi(x)\right.$ for some $\left.1 \leq j \leq n\right\}$ is called the set of roots of $\Psi$ at $y_{0}$.

In order to study $n$-valued maps via single-valued maps, we use the following natural relation between multifunctions and functions. First observe that there is an obvious bijection between the set of $n$-point subsets of a space $Y$ and the unordered configuration space $D_{n}(Y)$. This bijection induces a one-to-one correspondence between the set of $n$ valued functions from $X$ to $Y$ and the set of functions from $X$ to $D_{n}(Y)$. In what follows, given an $n$-valued function $\phi: X \multimap Y$, we will denote the corresponding function whose target is the configuration space $D_{n}(Y)$ by $\Phi: X \longrightarrow D_{n}(Y)$, and vice-versa. Since we are concerned with the study of continuous multivalued functions, we wish to ensure that this correspondence restricts to a bijection between the set of (continuous) $n$-valued maps and the set of continuous single-valued maps whose target is $D_{n}(Y)$. It follows from Theorem 8 that this is indeed the case if $X$ and $Y$ are metric spaces. This hypothesis will clearly be satisfied throughout this paper. If the map $\Phi: X \longrightarrow D_{n}(Y)$ associated to $\phi$ admits a lift $\widehat{\Phi}: X \longrightarrow F_{n}(Y)$ via the covering map $\pi$ then we shall say that $\widehat{\Phi}$ is a lift of $\phi$ (see Section 2 for a formal statement of this definition). We will make use of this notion to develop a correspondence between split $n$-valued maps and maps from $X$ into $F_{n}(Y)$. As we shall see, the problems that we are interested in for $n$-valued maps, such as coincidence, fixed point and root problems, may be expressed within the context of $n$-unordered maps, to which we may apply the classical theory of single-valued maps.

Our main aims in this paper are to explore the fixed point property of spaces for $n$ valued maps, and to study the problem of whether an $n$-valued map map can be deformed to a fixed point free $n$-valued map. We now give the statements of the main results of this paper. The first theorem shows that for simply-connected metric spaces, the usual fixed point property implies the fixed point property for $n$-valued maps.

Theorem 1. Let $X$ be a simply-connected metric space that has the fixed point property, and let $n \in \mathbb{N}$. Then every n-valued map of $X$ has at least $n$ fixed points, so $X$ has the fixed point property for $n$-valued maps. In particular, for all $n, k \geq 1$, the $k$-dimensional disc $\mathbb{D}^{k}$ and the $2 k$-dimensional complex projective space $\mathbb{C} P^{2 k}$ have the fixed point property for $n$-valued maps.

It may happen that a space does not have the (usual) fixed point property but that it has the fixed point property for $n$-valued maps for $n>1$. This is indeed the case for the $2 k$-dimensional sphere $\mathbb{S}^{2 k}$.
Proposition 2. If $n \geq 2$ and $k \geq 1$, $\mathbb{S}^{2 k}$ has the fixed point property for $n$-valued maps.
Theorem 1 and Proposition 2 will be proved in Section 2. Although the $2 k$-dimensional real projective space $\mathbb{R} P^{2 k}$ is not simply connected, in Section 3 we will show that it has the fixed point property for $n$-valued maps for all $n \in \mathbb{N}$.

THEOREM 3. Let $k, n \geq 1$. The real projective space $\mathbb{R} P^{2 k}$ has the fixed point property for $n$-valued maps. Further, any n-valued map of $\mathbb{R} P^{2 k}$ has at least $n$ fixed points.

We do not know of an example of a space that has the fixed point property, but that does not have the fixed point property for $n$-valued maps for some $n \geq 2$.

In Section 4, we turn our attention to the question of deciding whether an $n$-valued map of a surface $X$ of non-negative Euler characteristic $\chi(X)$ can be deformed to a fixed point free $n$-valued map. In the following result, we give algebraic criteria involving the braid groups of $X$.

THEOREM 4. Let $X$ be a compact surface without boundary such that $\chi(X) \leq 0$, let $n \geq 1$, and let $\phi: X \multimap X$ be an $n$-valued map.
(a) The n-valued map $\phi$ can be deformed to a fixed point free n-valued map if and only if there is a homomorphism $\varphi: \pi_{1}(X) \longrightarrow B_{1, n}(X)$ that makes the following diagram commute:

where $\iota_{1, n}: D_{1, n}(X) \longrightarrow X \times D_{n}(X)$ is the inclusion map.
(b) If the n-valued map $\phi$ is split, it can be deformed to a fixed point free n-valued map if and only if there is a homomorphism $\widehat{\varphi}: \pi_{1}(X) \longrightarrow P_{n+1}(X)$ that makes the following diagram commute:

where $\widehat{\iota}_{n+1}: F_{n+1}(X) \longrightarrow X \times F_{n}(X)$ is the inclusion map.
If $\phi: X \multimap X$ is a split $n$-valued map given by $\phi=\left\{f_{1}, \cdots, f_{n}\right\}$ that can be deformed to a fixed point free $n$-valued map, then certainly each of the single-valued maps $f_{i}$ can be deformed to a fixed point free map. The question of whether the converse of this statement holds for surfaces is open. We do not know the answer for any compact surface without boundary different from $\mathbb{S}^{2}$ or $\mathbb{R} P^{2}$, but it is likely that the converse does not hold. More generally, one would like to know if the homotopy class of $\phi$ contains a representative for which the number of fixed points is exactly the Nielsen number. Very little is known about this question, even for the 2-torus. Recall that the Nielsen number of an $n$-valued map $\phi: X \multimap X$, denoted $N(\phi)$, was defined by Schirmer [Sch2], and generalises the usual Nielsen number in the single-valued case. She showed that $N(\phi)$ is a lower bound for the number of fixed points among all $n$-valued maps homotopic to $\phi$.

Within the framework of Theorem 4, it is natural to study first the case of 2-valued maps of the 2 -torus $\mathbb{T}^{2}$, which is the focus of Section 5 . In what follows, $\mu$ and $\lambda$ will denote the meridian and the longitude respectively of $\mathbb{T}^{2}$. Let $\left(e_{1}, e_{2}\right)$ be a basis of $\pi_{1}\left(\mathbb{T}^{2}\right)$ such that $e_{1}=[\mu]$ and $e_{2}=[\lambda]$. For self-maps of $\mathbb{T}^{2}$, we will not be overly concerned with the choice of basepoints since the fundamental groups of $\mathbb{T}^{2}$ with respect to two different basepoints may be canonically identified. In Section 5.1 , we will study the groups $P_{2}\left(\mathbb{T}^{2}\right), B_{2}\left(\mathbb{T}^{2}\right)$
and $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$, and in Corollary 27, we will see that $P_{2}\left(\mathbb{T}^{2}\right)$ is isomorphic to the direct product of a free group $\mathbb{F}_{2}(u, v)$ of rank 2 and $\mathbb{Z}^{2}$. In what follows, the elements of $P_{2}\left(\mathbb{T}^{2}\right)$ will be written with respect to the decomposition $\mathbb{F}_{2}(u, v) \times \mathbb{Z}^{2}$, and $\mathrm{Ab}: \mathbb{F}_{2}(u, v) \longrightarrow \mathbb{Z}^{2}$ will denote Abelianisation. Theorem 35, which is a result of [Sch2] for the Nielsen number of split $n$-valued maps, will be used in part of the proof of the following proposition.

Proposition 5. Let $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ be a split 2-valued map of the torus $\mathbb{T}^{2}$, and let $\widehat{\Phi}=\left(f_{1}, f_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a lift of $\phi$ such that $\widehat{\Phi}_{\#}\left(e_{1}\right)=\left(w^{r},(a, b)\right)$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=$ $\left.\left(w^{s},(c, d)\right)\right)$, where $(r, s) \in \mathbb{Z}^{2} \backslash\{(0,0)\}, a, b, c, d \in \mathbb{Z}$ and $w \in \mathbb{F}_{2}(u, v)$. Then the Nielsen number of $\phi$ is given by:

N(\phi)=\left|\operatorname{det}\left(\begin{array}{cc}
a-1 & c \\
b & d-1
\end{array}\right)\right|+\left|\operatorname{det}\left(\begin{array}{cc}
r m+a-1 & s m+c \\
r n+b & s n+d-1
\end{array}\right)\right|
$$

where $A b(w)=(m, n) \in \mathbb{Z}^{2}$. If the map $\phi$ can be deformed to a fixed point free 2valued map, then both of the maps $f_{1}$ and $f_{2}$ can be deformed to fixed point free maps. Furthermore, $f_{1}$ and $f_{2}$ can be deformed to fixed point free maps if and only if either:
(a) the pairs of integers $(a-1, b),(c, d-1)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$, or
(b) $s(a-1, b)=r(c, d-1)$.

Within the framework of Proposition 5, given a split 2-valued map $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ for which $N(\phi)=0$, we would like to know whether $\phi$ can be deformed to a fixed point free 2 -valued map. If $N(\phi)=0$, then by this proposition, one of the conditions (a) or (b) must be satisfied. The following result shows that condition (b) is also sufficient.

THEOREM 6. Let $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a lift of a split 2-valued map $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ that satisfies $\widehat{\Phi}_{\#}\left(e_{1}\right)=\left(w^{r},(a, b)\right)$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=\left(w^{s},(c, d)\right)$, where $w \in \mathbb{F}_{2}(u, v), a, b, c, d \in \mathbb{Z}$ and $(r, s) \in \mathbb{Z}^{2} \backslash\{(0,0)\}$ satisfy $s(a-1, b)=r(c, d-1)$. Then $\phi$ may be deformed to $a$ fixed point free 2-valued map.

With respect to condition (a), we obtain a partial converse for certain values of $a, b, c, d, m$ and $n$.

Theorem 7. Suppose that $(a-1, b),(c, d-1)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$ generated by an element of the form $(0, q),(1, q),(p, 0)$ or $(p, 1)$, where $p, q \in \mathbb{Z}$, and let $r, s \in \mathbb{Z}$. Then there exist $w \in \mathbb{F}_{2}(u, v)$, a split fixed point free 2-valued map $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ and a lift $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ of $\phi$ such that such that $A b(w)=(m, n), \widehat{\Phi}_{\#}\left(e_{1}\right)=\left(\left(w^{r},(a, b)\right)\right.$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=\left(w^{s},(c, d)\right)$.

Proposition 5 and Theorems 6 and 7 will be proved in Section 5. Besides the introduction and an appendix, this paper is divided into 4 sections. In Section 2, we give some basic definitions, we establish the connection between multimaps and maps whose target is a configuration space, and we show that simply-connected spaces have the fixed point property for $n$-valued maps if they have the usual fixed point property. In Section 3, we show that even-dimensional real projective spaces have the fixed point property for $n$-valued maps. In Section 4, we provide general criteria of a homotopic and algebraic nature, to decide whether an $n$-valued map can be deformed or not to a fixed point free $n$ valued map, and we give the corresponding statements for the case of roots. In Section 5,
we study the fixed point theory of 2 -valued maps of the 2 -torus. In Section 5.1, we give presentations of certain braid groups of $\mathbb{T}^{2}$, in Section 5.2, we describe the set of homotopy classes of split 2 -valued maps of $\mathbb{T}^{2}$, and in Section 5.3 , we study the fixed point theory of split 2-valued maps. In the Appendix, written with R. F. Brown, in Theorem 8, we show that for the class of metric spaces that includes those considered in this paper, $n$-valued maps can be regarded as single-valued maps whose target is the associated unordered configuration space.

## 2 Generalities and the $n$-valued fixed point property

In Section 2.1, we begin by describing the relations between $n$-valued maps and $n$-unordered maps. We will assume throughout that $X$ and $Y$ are metric spaces, so that we can apply Theorem 8. Making use of unordered configuration space, in Lemma 9 and Corollary 11, we prove some properties about the fixed points of $n$-valued maps. In Section 2.2, we give an algebraic condition that enables us to decide whether an $n$-valued map is split. We also study the case where $X$ is simply connected (the $k$-dimensional disc for example, which has the usual fixed point property) and we prove Theorem 1, and in Section 2.3, we analyse the case of the $2 k$-dimensional sphere (which does not have the usual fixed point property), and we prove Proposition 2.

### 2.1 Relations between $n$-valued maps, $n$-(un)ordered maps and their fixed point sets

A proof of the following result may be found in the Appendix.
Theorem 8. Let $X$ and $Y$ be metric spaces, and let $n \in \mathbb{N}$. An n-valued function $\phi: X \multimap$ $Y$ is continuous if and only if the corresponding function $\Phi: X \longrightarrow D_{n}(Y)$ is continuous.

It would be beneficial for the statement of Theorem 8 to hold under weaker hypotheses on $X$ and $Y$. See [BG] for some recent results in this direction.

Definition. If $\phi: X \multimap Y$ is an $n$-valued map and $\Phi: X \longrightarrow D_{n}(Y)$ is the associated $n$-unordered map, an $n$-ordered map $\widehat{\Phi}: X \longrightarrow F_{n}(Y)$ is said to be a lift of $\phi$ if the composition $\pi \circ \widehat{\Phi}: X \longrightarrow D_{n}(Y)$ of $\widehat{\Phi}$ with the covering map $\pi: F_{n}(Y) \longrightarrow D_{n}(Y)$ is equal to $\Phi$.

If $\phi=\left\{f_{1}, \ldots, f_{n}\right\}: X \multimap Y$ is a split $n$-valued map, then it admits a lift $\widehat{\Phi}=$ $\left(f_{1}, \ldots, f_{n}\right): X \longrightarrow F_{n}(Y)$. For any such lift, $\operatorname{Fix}(\widehat{\Phi})=\operatorname{Fix}(\phi)$, and the map $\widehat{\Phi}$ determines an ordered set of $n$ maps $\left(f_{1}=p_{1} \circ \widehat{\Phi}, \ldots, f_{n}=p_{n} \circ \widehat{\Phi}\right)$ from $X$ to $Y$ for which $f_{i}(x) \neq f_{j}(x)$ for all $x \in X$ and all $1 \leq i<j \leq n$. Conversely, any ordered set of $n$ maps $\left(f_{1}, \ldots, f_{n}\right)$ from $X$ to $Y$ for which $f_{i}(x) \neq f_{j}(x)$ for all $x \in X$ and all $1 \leq i<j \leq n$ determines an $n$-ordered map $\Psi: X \longrightarrow F_{n}(Y)$ defined by $\Psi(x)=\left(f_{1}(x), \ldots, f_{n}(x)\right)$ and a split $n$ valued map $\phi=\left\{f_{1}, \ldots, f_{n}\right\}: X \multimap Y$ of which $\Psi$ is a lift. So the existence of such a split $n$-valued map $\phi$ is equivalent to that of an $n$-ordered map $\Psi: X \longrightarrow F_{n}(Y)$, where $\Psi=\left(f_{1}, \ldots, f_{n}\right)$. This being the case, the composition $\pi \circ \Psi: X \longrightarrow D_{n}(Y)$ is the map $\Phi: X \longrightarrow D_{n}(Y)$ that corresponds (in the sense described in Section 1) to the $n$-valued map $\phi$. Consequently, an $n$-valued map $\phi: X \multimap Y$ admits a lift if and only if it is split. As we shall now see, Theorem 8 will be of help in the description of the relations between (split) $n$-valued maps and $n$-(un)ordered maps of metric spaces. As we have seen, to each $n$-valued map (resp. split $n$-valued map), we may associate an $n$-unordered map (resp. a lift), and vice-versa. Note that the symmetric group $S_{n}$ not only acts (freely) on $F_{n}(Y)$ by permuting coordinates, but it also acts on the set of ordered $n$-tuples of maps between $X$ and $Y$. Further, the restriction of the latter action to the subset $F_{n}(Y)^{X}$ of $n$-ordered maps, $i . e$. maps of the form $\Psi: X \longrightarrow F_{n}(Y)$, where $\Psi(x)=\left(f_{1}(x), \ldots, f_{n}(x)\right)$ for all $x \in X$ for which $f_{i}(x) \neq f_{j}(x)$ for all $x \in X$ and $1 \leq i<j \leq n$, is also free. In what follows, $[X, Y]$ (resp. $[X, Y]_{0}$ ) will denote the set of homotopy classes (resp. based homotopy classes) of maps between $X$ and $Y$.

Lemma 9. Let $X$ and $Y$ be metric spaces, and let $n \in \mathbb{N}$.
(a) The set $S p(X, Y, n)$ of split n-valued maps from $X$ to $Y$ is in one-to-one correspondence with the orbits of the set of maps $F_{n}(Y)^{X}$ from $X$ to $F_{n}(Y)$ modulo the free action defined above of $S_{n}$ on $F_{n}(Y)^{X}$.
(b) If two n-valued maps from $X$ to $Y$ are homotopic and one is split, then the other is also split. Further, the set $\operatorname{Sp}(X, Y, n) / \sim$ of homotopy classes of split n-valued maps from $X$ to $Y$ is in one-to-one correspondence with the orbits of the set $\left[X, F_{n}(Y)\right]$ of homotopy classes of maps from $X$ to $F_{n}(Y)$ under the action of $S_{n}$ induced by that of $S_{n}$ on $F_{n}(Y)^{X}$. (c) Suppose that $X=Y$. If an n-valued map $\phi: X \multimap X$ is split and deformable to a fixed point free map, then a lift $\widehat{\Phi}: X \longrightarrow F_{n}(X)$ of $\phi$ may be written as $\Psi=\left(f_{1}, \ldots, f_{n}\right)$, where for all $i=1, \ldots, n$, the map $f_{i}: X \longrightarrow X$ is a map that is deformable to a fixed point free map.

Proof.
(a) Let $\phi: X \multimap Y$ be a split $n$-valued map. From the definition, there exists an $n$ ordered map $\widehat{\Phi}: X \longrightarrow F_{n}(Y)$ such that $\Phi=\pi \circ \widehat{\Phi}$, up to the identification given by Theorem 8. If $\widehat{\Phi}=\left(f_{1}, \ldots, f_{n}\right)$, the other lifts of $\phi$ are obtained via the action of the group of deck transformations of the covering space, this group being $S_{n}$ in our case, and so are of the form $\left(f_{\sigma(1)}, \ldots, f_{\sigma(n)}\right)$, where $\sigma \in S_{n}$. This gives rise to the stated one-to-one correspondence between $\operatorname{Sp}(X, Y, n)$ and the orbit space $F_{n}(Y)^{X} / S_{n}$.
(b) By naturality, the map $\pi: F_{n}(Y) \longrightarrow D_{n}(Y)$ induces a map $\widehat{\pi}:\left[X, F_{n}(Y)\right] \longrightarrow$ $\left[X, D_{n}(Y)\right]$ defined by $\widehat{\pi}([\Psi])=[\pi \circ \Psi]$ for any $n$-ordered map $\Psi: X \longrightarrow F_{n}(Y)$. Given two homotopic $n$-valued maps between $X$ and $Y$, which we regard as maps from $X$ to $D_{n}(Y)$ using Theorem 8, if the first has a lift to $F_{n}(Y)$, then the lifting property of a covering implies that the second also admits a lift to $F_{n}(Y)$, so if the first map is split
then so is the second map. To prove the second part of the statement, first note that there is a surjective map $f: F_{n}(Y)^{X} \longrightarrow \operatorname{Sp}(X, Y, n)$ given by $f(g)=\pi \circ g$, where we identify $\operatorname{Sp}(X, Y, n)$ with the set of maps $D_{n}(Y)^{X}$ from $X$ to $D_{n}(Y)$, that induces a surjective map $\bar{f}:\left[X, F_{n}(Y)\right] \longrightarrow \mathrm{Sp}(X, Y, n) / \sim$ on the corresponding sets of homotopy classes. Further, if $\Psi_{1}, \Psi_{2} \in F_{n}(Y)^{X}$ are two $n$-ordered maps that are homotopic via a homotopy $H$, and if $\alpha \in S_{n}$, then the maps $\alpha \circ \Psi_{1}, \alpha \circ \Psi_{2} \in F_{n}(Y)^{X}$ are also homotopic via the homotopy $\alpha \circ H$, and so we obtain a quotient map $q:\left[X, F_{n}(Y)\right] \longrightarrow\left[X, F_{n}(Y)\right] / S_{n}$. We claim that $\bar{f}$ factors through $q$ via the map $\overline{\bar{f}}:\left[X, F_{n}(Y)\right] / S_{n} \longrightarrow \operatorname{Sp}(X, Y, n) / \sim$ defined by $\overline{\bar{f}}([g])=[f(g)]$. To see this, let $g, h \in F_{n}(Y)^{X}$ be such that $q([g])=q([h])$. Then there exists $\alpha \in S_{n}$ such that $\alpha([g])=[h]$. Then $\bar{f}(\alpha[g])=[\alpha f(h)]=\bar{f}([h])=[f(h)]$. But from the definition of $\operatorname{Sp}(X, Y, n),[\alpha f(g)]=[f(g)]$, and so $[f(g)]=[f(h)]$, which proves the claim. By construction, the map $\overline{\bar{f}}$ is surjective. It remains to show that it is injective. Let $g, h \in F_{n}(Y)^{X}$ be such that $\overline{\bar{f}}([g])=\overline{\bar{f}}([h])$. Then $[f(g)]=[f(h)]$, and thus $f(g)$ and $f(h)$ are homotopic via a homotopy $H$ in $\operatorname{Sp}(X, Y, n)$, where $H(0, f(g))=f(g)$ and $H(1, f(g))=f(h)$. Then $H$ lifts to a homotopy $\widetilde{H}$ such that $\widetilde{H}(0, g)=g$, and $\widetilde{H}(1, g)$ is a lift of $f(h)$. But $h$ is also a lift of $f(h)$, so there exists $\alpha \in S_{n}$ such that $f(h)=\alpha h$. Further, $g$ is homotopic to $f(h)$, so is homotopic to $\alpha(h)$, and hence $q([g])=q([\alpha(h)])=q([h])$ from the definition of $q$, which proves the injectivity of $\overline{\bar{f}}$.
(c) Since $\phi$ is split, we may choose a lift $\widehat{\Phi}=\left(f_{1}, \ldots, f_{n}\right): X \longrightarrow F_{n}(X)$ of $\phi$. By hypothesis, there is a homotopy $H: X \times I \longrightarrow D_{n}(X)$ such that $H(\cdot, 0)=\Phi$, and $H(\cdot, 1)$ is fixed point free. Since the initial part of the homotopy $H$ admits a lift, there exists a lift $\widehat{H}: X \times I \longrightarrow F_{n}(X)$ of $H$ such that $\widehat{H}(\cdot, 0)=\widehat{\Phi}$, and $\widehat{H}(\cdot, 1)$ is fixed point free. So $\widehat{H}(\cdot, 1)$ is of the form $\left(f_{1}, \ldots, f_{n}\right)$, where $f_{i}$ is fixed point free for $1 \leq i \leq n$, and the conclusion follows.

## Remarks 10.

(a) The action of $S_{n}$ on the set of homotopy classes $\left[X, F_{n}(Y)\right]$ is not necessarily free (see Proposition 34(b)).
(b) The question of whether the converse of Lemma 9(c) is valid for surfaces is open, see the introduction.

The following consequence of Lemma 9(c) will be useful in what follows, and implies that if a split $n$-valued map can be deformed to a fixed point free $n$-valued map (through $n$-valued maps), then the deformation is through split $n$-valued maps.

Corollary 11. Let $X$ be a metric space, and let $n \in \mathbb{N}$. A split n-valued map $\phi: X \multimap X$ may be deformed within $S p(X, X, n)$ to a fixed point free n-valued map if and only if any lift $\widehat{\Phi}=\left(f_{1}, \ldots, f_{n}\right): X \longrightarrow F_{n}(X)$ of $\phi$ may be deformed within $F_{n}(X)$ to a fixed point free map $\widehat{\Phi}^{\prime}=\left(f_{1}^{\prime}, \ldots, f_{n}^{\prime}\right): X \longrightarrow F_{n}(X)$. In particular, for all $1 \leq i \leq n$, there exists a homotopy $H_{i}: X \times I \longrightarrow X$ between $f_{i}$ and $f_{i}^{\prime}$, where $f_{i}^{\prime}$ is a fixed point free map, and $H_{j}(x, t) \neq H_{k}(x, t)$ for all $1 \leq j<k \leq n, x \in X$ and $t \in[0,1]$.

Proof. The 'if' part of the statement may be obtained by considering the composition of the deformation between $\Psi$ and $\Psi^{\prime}$ by the projection $\pi$ and by applying Theorem 8 . The 'only if' part follows in a manner similar to that of the proof of the first part of Lemma 9(b).

### 2.2 The fixed point property of simply connected spaces and the $k$-disc $\mathbb{D}^{k}$ for $n$-valued maps

In this section, we analyse the case where $X$ is a simply-connected metric space that possesses the fixed point property, such as the closed $k$-dimensional disc $\mathbb{D}^{k}$. In Lemma 12, we begin by proving a variant of the so-called 'Splitting Lemma' that is more general than the versions that appear in the literature, such as that of Schirmer given in [Sch1, Section 2, Lemma 1] for example. The hypotheses are expressed in terms of the homomorphism on the level of the fundamental group of the target $Y$, rather than that of the domain $X$, and the criterion is an algebraic condition, in terms of the fundamental group, for an $n$-valued map from $X$ to $Y$ to be split. This allows us to prove Theorem 1, which says that a simply-connected metric space that has the fixed point property also possesses the fixed point property for $n$-valued maps for all $n \geq 1$. In particular, $\mathbb{D}^{k}$ satisfies this property for all $k \geq 1$. The 2 -disc will be the only surface with boundary that will be considered in this paper. The cases of other surfaces with boundary, such as the annulus and the Möbius band, will be studied elsewhere.

Lemma 12. Let $n \geq 1$, let $\phi: X \multimap Y$ be an $n$-valued map between metric spaces, where $X$ is connected and locally arcwise-connected, and let $\Phi: X \longrightarrow D_{n}(Y)$ be the associated $n$-unordered map. Then $\phi$ is split if and only if the image of the induced homomorphism $\Phi_{\#}: \pi_{1}(X) \longrightarrow B_{n}(Y)$ is contained in the image of the homomorphism $\pi_{\#}: P_{n}(Y) \longrightarrow$ $B_{n}(Y)$ induced by the covering map $\pi: F_{n}(Y) \longrightarrow D_{n}(Y)$. In particular, if $X$ is simply connected then all n-valued maps from $X$ to $Y$ are split.

Proof. Since $X$ and $Y$ are metric spaces, using Theorem 8, we may consider the $n$ unordered map $\Phi: X \longrightarrow D_{n}(Y)$ that corresponds to $\phi$. The first part of the statement follows from standard results about the lifting property of a map to a covering space in terms of the fundamental group [Mas, Chapter 5, Section 5, Theorem 5.1]. The second part is a consequence of the first part.

As a consequence of Lemma 12, we are able to prove Theorem 1.
Proof of Theorem 1. Let $X$ be a simply-connected metric space that has the fixed point property. By Lemma 12 , any $n$-valued map $\phi: X \multimap X$ is split. Writing $\phi=\left\{f_{1}, \ldots, f_{n}\right\}$, each of the maps $f_{i}: X \longrightarrow X$ is a self-map of $X$ that has at least one fixed point. So $\phi$ has at least $n$ fixed points, and in particular, $X$ has the fixed point property for $n$-valued maps. The last part of the statement then follows.

## $2.3 n$-valued maps of the sphere $\mathbb{S}^{2 k}$

Let $k \geq 1$. Although $\mathbb{S}^{2 k}$ does not have the fixed point property for self-maps, we shall show in this section that it has the fixed point property for $n$-valued maps for all $n>1$, which is the statement of Proposition 2. We first prove a lemma.

Lemma 13. Let $n \geq 1$ and $k \geq 2$. Then any $n$-valued map of $\mathbb{S}^{k}$ is split.
Proof. The result follows from Lemma 12 using the fact that $\mathbb{S}^{k}$ is simply connected.

Proof of Proposition 2. Let $n \geq 2$, and let $\phi: \mathbb{S}^{2 k} \multimap \mathbb{S}^{2 k}$ be an $n$-valued map. By Lemma $13, \phi$ is split, so it admits a lift $\widehat{\Phi}: \mathbb{S}^{2 k} \longrightarrow F_{n}\left(\mathbb{S}^{2 k}\right)$, where $\widehat{\Phi}=\left(f_{1}, f_{2}, \ldots, f_{n}\right)$. Since $f_{1}(x) \neq f_{2}(x)$ for all $x \in \mathbb{S}^{2 k}$, we have $f_{2}(x) \neq-\left(-f_{1}(x)\right)$, it follows that $f_{2}$ is homotopic to $-f_{1}$ via a homotopy that for all $x \in \mathbb{S}^{2 k}$, takes $-f_{1}(x)$ to $f_{2}(x)$ along the unique geodesic that joins them. Thus the degree of one of the maps $f_{1}$ and $f_{2}$ is different from -1 , and so has a fixed point, which implies that $\phi$ has a fixed point.

Remark. If $n>2$ and $k=1$ then the result of Proposition 2 is clearly true since by [GG4, pp. 43-44], the set $\left[\mathbb{S}^{2}, F_{n}\left(\mathbb{S}^{2}\right)\right]$ of homotopy classes of maps between $\mathbb{S}^{2}$ and $F_{n}\left(\mathbb{S}^{2}\right)$ contains only one class, which is that of the constant map. So any representative of this class is of the form $\phi=\left(f_{1}, \ldots, f_{n}\right)$, where all of the maps $f_{i}: \mathbb{S}^{2} \longrightarrow \mathbb{S}^{2}$ are homotopic to the constant map. Such a map always has a fixed point, and hence $\phi$ has at least $n$ fixed points.

## $3 n$-valued maps of the projective space $\mathbb{R} P^{2 k}$

In this section, we will show that the projective space $\mathbb{R} P^{2 k}$ also has the fixed point property for $n$-valued maps, which is the statement of Theorem 3 . Since $\mathbb{R} P^{2 k}$ is not simply connected, we will require more elaborate arguments than those used in Sections 2.2 and 2.3. We separate the discussion into two cases, $k=1$, and $k>1$.

## $3.1 n$-valued maps of $\mathbb{R} P^{2}$

The following result is the analogue of Lemma 13 for $\mathbb{R} P^{2}$.
Lemma 14. Let $n \geq 1$. Then any $n$-valued map of the projective plane is split.
Proof. Let $\phi: \mathbb{R} P^{2} \multimap \mathbb{R} P^{2}$ be an $n$-valued map, let $\Phi: \mathbb{R} P^{2} \longrightarrow D_{n}\left(\mathbb{R} P^{2}\right)$ be the associated $n$-unordered map, and let $\Phi_{\#}: \pi_{1}\left(\mathbb{R} P^{2}\right) \longrightarrow B_{n}\left(\mathbb{R} P^{2}\right)$ be the homomorphism induced on the level of fundamental groups. Since $\pi_{1}\left(\mathbb{R} P^{2}\right)$ is isomorphic to the cyclic group of order 2 , it follows that $\operatorname{Im}\left(\Phi_{\#}\right)$ is contained in the subgroup $\left\langle\Delta_{n}^{2}\right\rangle$ of $B_{n}\left(\mathbb{R} P^{2}\right)$ generated by the full twist braid $\Delta_{n}^{2}$ of $B_{n}\left(\mathbb{R} P^{2}\right)$ because $\Delta_{n}^{2}$ is the unique element of $B_{n}\left(\mathbb{R} P^{2}\right)$ of order 2 [GG2, Proposition 23]. But $\Delta_{n}^{2}$ is a pure braid, so $\operatorname{Im}\left(\Phi_{\#}\right) \subset P_{n}\left(\mathbb{R} P^{2}\right)$. Thus $\Phi$ factors through $\pi$, and hence $\phi$ is split by Lemma 12 as required.

Proposition 15. Let $n \geq 1$. Then any n-valued map of $\mathbb{R} P^{2}$ has at least $n$ fixed points, in particular $\mathbb{R} P^{2}$ has the fixed point property for $n$-valued maps.

Proof. Let $\phi: \mathbb{R} P^{2} \multimap \mathbb{R} P^{2}$ be an $n$-valued map of $\mathbb{R} P^{2}$. Then $\phi$ is split by Lemma 14 , and so $\phi=\left\{f_{1}, \ldots, f_{n}\right\}$, where $f_{1}, \ldots, f_{n}: \mathbb{R} P^{2} \longrightarrow \mathbb{R} P^{2}$ are pairwise coincidence-free self-maps of $\mathbb{R} P^{2}$. But $\mathbb{R} P^{2}$ has the fixed point property, and so for $i=1, \ldots, n, f_{i}$ has a fixed point. Hence $\phi$ has at least $n$ fixed points.

## $3.2 n$-valued maps of $\mathbb{R} P^{2 k}, k>1$

The aim of this section is to prove that $\mathbb{R} P^{2 k}$ has the fixed point property for $n$-valued maps for all $n \geq 1$ and $k>1$. Indeed, we will show that every such $n$-valued map has at least $n$ fixed points.

Given an $n$-valued map $\phi: X \multimap X$ of a topological space $X$, we consider the corresponding map $\Phi: X \longrightarrow D_{n}(X)$, and the induced homomorphism $\Phi_{\#}: \pi_{1}(X) \longrightarrow$ $\pi_{1}\left(D_{n}(X)\right)$ on the level of fundamental groups, where $\pi_{1}\left(D_{n}(X)\right)=B_{n}(X)$. By the short exact sequence (1), $P_{n}(X)$ is a normal subgroup of $B_{n}(X)$ of finite index $n$ !, so the subgroup $H=\Phi_{\#}^{-1}\left(P_{n}(X)\right)$ is a normal subgroup of $\pi_{1}(X)$ of finite index. Further, if $L=\pi_{1}(X) / H$, the composition $\pi_{1}(X) \xrightarrow{\Phi_{\#}} B_{n}(X) \xrightarrow{\tau} S_{n}$ is a homomorphism that induces a homomorphism between $L$ and $S_{n}$.

Proposition 16. Let $n \in \mathbb{N}$. Suppose that $X$ is a connected, locally arcwise-connected metric space. With the above notation, there exists a covering $q: \widehat{X} \longrightarrow X$ of $X$ that corresponds to the subgroup $H$, and the $n$-valued map $\phi_{1}=\phi \circ q: \widehat{X} \multimap X$ admits exactly $n$ ! lifts, which are $n$-ordered maps from $\widehat{X}$ to $F_{n}(X)$. If one such lift $\widehat{\Phi}_{1}: \widehat{X} \longrightarrow F_{n}(X)$ is given by $\widehat{\Phi}_{1}=\left(f_{1}, \ldots, f_{n}\right)$, where for $i=1, \ldots, n$, $f_{i}$ is a map from $\widehat{X}$ to $X$, then the other lifts are of the form $\left(f_{\tau(1)}, \ldots, f_{\tau(n)}\right)$, where $\tau \in S_{n}$.

Proof. The first part is a consequence of [Mas, Theorem 5.1, Chapter V, Section 5], using the observation that $S_{n}$ is the deck transformation group corresponding to the covering $\pi: F_{n}(X) \longrightarrow D_{n}(X)$. The second part follows from the fact that $S_{n}$ acts freely on the covering space $F_{n}(X)$ by permuting coordinates.

The fixed points of the $n$-valued map $\phi: X \multimap X$ may be described in terms of the coincidences of the covering map $q: \widehat{X} \longrightarrow X$ with the maps $f_{1}, \ldots, f_{n}$ given in the statement of Proposition 16.

Proposition 17. Let $n \in \mathbb{N}$, let $X$ be a connected, locally arcwise-connected, metric space, let $\phi: X \multimap X$ be an n-valued map, and let $\widehat{\Phi}_{1}=\left(f_{1}, \ldots, f_{n}\right): \widehat{X} \longrightarrow F_{n}(X)$ be an $n$-ordered map that is a lift of $\phi_{1}=\phi \circ q: \widehat{X} \multimap X$ as in Proposition 16. Then the map $q$ restricts to a surjection $q: \bigcup_{i=1}^{n} \operatorname{Coin}\left(q, f_{i}\right) \longrightarrow F i x(\phi)$. Furthermore, the pre-image of a point $x \in \operatorname{Fix}(\phi)$ by this map is precisely $q^{-1}(x)$, namely the fibre over $x \in X$ of the covering map $q: \widehat{X} \longrightarrow X$.

Proof. Let $\widehat{x} \in \operatorname{Coin}\left(q, f_{i}\right)$ for some $1 \leq i \leq n$, and let $x=q(\widehat{x})$. Then $f_{i}(\widehat{x})=q(\widehat{x})$, and since $\Phi(x)=\pi \circ \widehat{\Phi}_{1}(\widehat{x})=\left\{f_{1}(\widehat{x}), \ldots, f_{n}(\widehat{x})\right\}$, it follows that $x \in \phi(x)$, i.e. $x \in \operatorname{Fix}(\phi)$, so the map is well defined. To prove surjectivity and the second part of the statement, it suffices to show that if $x \in \operatorname{Fix}(\phi)$, then any element $\widehat{x}$ of $q^{-1}(x)$ belongs to $\bigcup_{i=1}^{n} \operatorname{Coin}\left(q, f_{i}\right)$. So let $x \in \phi(x)$, and let $\widehat{x} \in \widehat{X}$ be such that $q(\widehat{x})=x$. By commutativity of the following diagram:

and the fact that $x \in \operatorname{Fix}(\phi)$, it follows that $x$ is one of the coordinates, the $j^{\text {th }}$ coordinate say, of $\widehat{\Phi}_{1}(\widehat{x})$. This implies that $\widehat{x} \in \operatorname{Coin}\left(q, f_{j}\right)$, which completes the proof of the proposition.

Proposition 18. Let $n, k>1$. If $\phi: \mathbb{S}^{2 k} \multimap \mathbb{R} P^{2 k}$ is an n-valued map, then $\phi$ is split, and for $i=1, \ldots, n$, there exist maps $f_{i}: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$ for which $\phi=\left\{f_{1}, \ldots, f_{n}\right\}$. Further, $f_{i}$ is null homotopic for all $i \in\{1, \ldots, n\}$.

Proof. The first part follows from Lemma 12. It remains to prove the second part, i.e. that each $f_{i}$ is null homotopic. Since $\mathbb{S}^{2 k}$ is simply connected, the set $\left[\mathbb{S}^{2 k}, \mathbb{S}^{2 k}\right]=$ $\left[\mathbb{S}^{2 k}, \mathbb{S}^{2 k}\right]_{0}=\pi_{2 k}\left(\mathbb{S}^{2 k}\right)$, where $[\cdot, \cdot]_{0}$ denotes basepoint-preserving homotopy classes of maps. Let $x_{0} \in \mathbb{S}^{2 k}$ be a basepoint, let $p: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$ be the two-fold covering, and let $\bar{x}_{0}=$ $p\left(x_{0}\right) \in \mathbb{R} P^{2 k}$ be the basepoint of $\mathbb{R} P^{2 k}$. Consider the natural map $\left[\left(\mathbb{S}^{2 k}, x_{0}\right),\left(\mathbb{S}^{2 k}, x_{0}\right)\right] \longrightarrow$ $\left[\left(\mathbb{S}^{2 k}, x_{0}\right),\left(\mathbb{R} P^{2 k}, \bar{x}_{0}\right)\right]$ from the set of based homotopy classes of self-maps of $\mathbb{S}^{2 k}$ to the based homotopy classes of maps from $\mathbb{S}^{2 k}$ to $\mathbb{R} P^{2 k}$, that to a homotopy class of a basepointpreserving self-map of $\mathbb{S}^{2 k}$ associates the homotopy class of the composition of this self-map with $p$. This correspondence is an isomorphism. The covering map $p$ has topological degree $2[\mathrm{Ep}]$, so the degree of a map $f: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$ is an even integer (we use the system of local coefficients given by the orientation of $\left.\mathbb{R} P^{2 k}[\mathrm{Ol}]\right)$. Since $H^{l}\left(\mathbb{R} P^{2 k}, \widetilde{\mathbb{Q}}\right)=0$ for $\widetilde{\mathbb{Q}}$ twisted by the orientation and $l \neq 2 k$, if $i \neq j$, it follows that the Lefschetz coincidence number $L\left(f_{i}, f_{j}\right)$ is equal to $\operatorname{deg}\left(f_{i}\right)$. But $f_{i}$ and $f_{j}$ are coincidence free, so their Lefschetz coincidence number must be zero, which implies that $\operatorname{deg}\left(f_{i}\right)=0$ [GJ]. Since $n>1$, we conclude that $\operatorname{deg}\left(f_{i}\right)=0$ for all $1 \leq i \leq n$, and the result follows.

We are now able to prove the main result of this section, that $\mathbb{R} P^{2 k}$ has the fixed point property for $n$-valued maps for all $k, n \geq 1$.

Proof of Theorem 3. The case $n=1$ is classical, so assume that $n \geq 2$. We use the notation introduced at the beginning of this section, taking $X=\mathbb{R} P^{2 k}$. Since $\pi_{1}\left(\mathbb{R} P^{2 k}\right) \cong$ $\mathbb{Z}_{2}, H$ is either $\pi_{1}\left(\mathbb{R} P^{2 k}\right)$ or the trivial group. In the former case, the $n$-valued map $\phi: \mathbb{R} P^{2 k} \multimap \mathbb{R} P^{2 k}$ is split, $\operatorname{Fix}(\phi)=\bigcup_{i=1}^{n} \operatorname{Fix}\left(f_{i}\right)$, where $\phi=\left\{f_{1}, \ldots, f_{n}\right\}$, and for all $i=$ $1, \ldots, n, f_{i}$ is a self-map of $\mathbb{R} P^{2 k}$. It follows that $\phi$ has at least $n$ fixed points. So suppose that $H$ is the trivial subgroup of $\pi_{1}\left(\mathbb{R} P^{2 k}\right)$. Then $\widehat{\mathbb{R} P^{2 k}}=\mathbb{S}^{2 k}$, and $q$ is the covering map $p: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$. We first consider the case $n=2$. Let $\phi: \mathbb{R} P^{2 k} \multimap \mathbb{R} P^{2 k}$ be a 2 -valued map, and let $\widehat{\Phi}_{1}: \mathbb{S}^{2 k} \longrightarrow F_{2}\left(\mathbb{R} P^{2 k}\right)$ be a lift of the map $\Phi_{1}=\Phi \circ p: \mathbb{S}^{2 k} \longrightarrow D_{2}\left(\mathbb{R} P^{2 k}\right)$ that factors through the projection $\pi: F_{2}\left(\mathbb{R} P^{2 k}\right) \longrightarrow D_{2}\left(\mathbb{R} P^{2 k}\right)$. By Proposition 16, $\widehat{\Phi}_{1}=\left(f_{1}, f_{2}\right)$, where for $i=1,2, f_{i}: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$ is a single-valued map, and it follows from Proposition 18 that $f_{1}$ and $f_{2}$ are null homotopic. If $\operatorname{Coin}\left(f_{i}, p\right)=\varnothing$ for some $i \in\{1,2\}$, then arguing as in the second part of the proof of Proposition 18, it follows that $L\left(p, f_{i}\right)=\operatorname{deg}(p)=2$, which yields a contradiction. So $\operatorname{Coin}\left(f_{i}, p\right) \neq \varnothing$ for all $i \in\{1,2\}$. Using the fact that $f_{1}$ and $f_{2}$ are coincidence free, we conclude that $\phi$ has at least two fixed points, and the result follows in this case.

Finally suppose that $n>2$. Arguing as in the case $n=2$, we obtain a lift of $\phi \circ p$ of the form $\left(f_{1}, \ldots, f_{n}\right)$, where for $i=1, \ldots, n, f_{i}: \mathbb{S}^{2 k} \longrightarrow \mathbb{R} P^{2 k}$ is a map. If $i=1, \ldots, n$ then for all $j \in\{1, \ldots, n\}, j \neq i$, we may apply the above argument to $f_{i}$ and $f_{j}$ to obtain $\operatorname{Coin}\left(f_{i}, p\right) \neq \varnothing$. Hence $\phi$ has at least $n$ fixed points, and the result follows.

REmark. If $n>1$, we do not know whether there exists a non-split $n$-valued map $\phi: \mathbb{R} P^{2 k} \multimap \mathbb{R} P^{2 k}$.

## 4 Deforming (split) $n$-valued maps to fixed point and root-free maps

In this section, we generalise a standard procedure for deciding whether a single-valued map may be deformed to a fixed point free map to the $n$-valued case. We start by giving
a necessary and sufficient condition for an $n$-valued map (resp. a split $n$-valued map) $\phi: X \longrightarrow X$ to be deformable to a fixed point free $n$-valued map (resp. split fixed point free $n$-valued map), at least in the case where $X$ is a manifold without boundary. This enables us to prove Theorem 4. We then go on to give the analogous statements for roots. Recall from Section 1 that $D_{1, n}(X)$ is the quotient of $F_{n+1}(X)$ by the action of the subgroup $\{1\} \times S_{n}$ of the symmetric group $S_{n+1}$, and that $B_{1, n}(X)=\pi_{1}\left(D_{1, n}(X)\right)$.

Proposition 19. Let $n \in \mathbb{N}$, let $X$ be a metric space, and let $\phi: X \multimap X$ be an n-valued map. If $\phi$ can be deformed to a fixed point free n-valued map, then there exists a map $\Theta: X \longrightarrow D_{1, n}(X)$ such that the following diagram is commutative up to homotopy:

where $\iota_{1, n}: D_{1, n}(X) \longrightarrow X \times D_{n}(X)$ is the inclusion map. Conversely, if $X$ is a manifold without boundary and there exists a map $\Theta: X \longrightarrow D_{1, n}(X)$ such that diagram (3) is commutative up to homotopy, then the n-valued map $\phi: X \multimap X$ may be deformed to a fixed point free $n$-valued map.

Proof. For the first part, if $\phi^{\prime}$ is a fixed point free deformation of $\phi$, then we may take the factorisation map $\Theta: X \longrightarrow D_{1, n}(X)$ to be that defined by $\Theta(x)=\left(x, \Phi^{\prime}(x)\right)$. For the converse, the argument is similar to the proof of the case of single-valued maps, and is as follows. Let $\Theta: X \longrightarrow D_{1, n}(X)$ be a homotopy factorisation that satisfies the hypotheses. Composing $\Theta$ with the projection $\bar{p}_{1, n}: D_{1, n}(X) \longrightarrow X$ onto the first coordinate, we obtain a self-map of $X$ that is homotopic to the identity. Let $H: X \times I \longrightarrow X$ be a homotopy between $\bar{p}_{1, n} \circ \Theta$ and $\operatorname{Id}_{X}$. Since $\bar{p}_{1, n}: D_{1, n}(X) \longrightarrow X$ is a fibration and there is a lift of the restriction of $H$ to $X \times\{0\}, H$ lifts to a homotopy $\widetilde{H}: X \times I \longrightarrow D_{1, n}(X)$. The restriction of $\widetilde{H}$ to $X \times\{1\}$ yields the required deformation.

For split $n$-valued maps, the correspondence given by Lemma 9(a) gives rise to a statement analogous to that of Proposition 19 in terms of $F_{n}(X)$.

Proposition 20. Let $n \in \mathbb{N}$, let $X$ be a metric space, and let $\phi: X \multimap X$ be a split $n$-valued map. If $\phi$ can be deformed to a fixed point free $n$-valued map, and if $\widehat{\Phi}: X \longrightarrow$ $F_{n}(X)$ is a lift of $\phi$, then there exists a map $\widehat{\Theta}: X \longrightarrow F_{n+1}(X)$ such that the following diagram is commutative up to homotopy:

where $\widehat{\iota}_{n+1}: F_{n+1}(X) \longrightarrow X \times F_{n}(X)$ is the inclusion map. Conversely, if $X$ is a manifold without boundary and there exists a map $\widehat{\Theta}: X \longrightarrow F_{n+1}(X)$ such that diagram (4) is commutative up to homotopy, then the split n-valued map $\phi: X \multimap X$ may be deformed through split maps to a fixed point free split n-valued map.

Proof. Similar to that of Proposition 19.
We now apply Propositions 19 and 20 to prove Theorem 4, which treats the case where $X$ is a compact surface without boundary (orientable or not) of non-positive Euler characteristic.

Proof of Theorem 4. The space $D_{1, n}(X)$ is a finite covering of $D_{1+n}(X)$, so it is a $K(\pi, 1)$ since $D_{1+n}(X)$ is a $K(\pi, 1)$ by [FN, Corollary 2.2]. To prove the 'only if' implication of part (a), diagram (2) implies the existence of diagram (3) using the fact that the space $D_{1, n}(X)$ is a $K(\pi, 1)$, where $\varphi=\Theta_{\#}$ is the homomorphism induced by $\Theta$ on the level of the fundamental groups. Conversely, diagram (3) implies that the two maps $\iota_{1, n} \circ \Theta$ and $\operatorname{Id}_{X} \times \Phi$ are homotopic, but not necessarily by a basepoint-preserving homotopy, so diagram (2) is commutative up to conjugacy. Let $\delta \in \pi_{1}(X) \times B_{n}(X)$ be such that $\left(\iota_{1, n}\right)_{\#} \circ \varphi(\alpha)=\delta\left(\operatorname{Id}_{X} \times \phi\right)_{\#}(\alpha) \delta^{-1}$ for all $\alpha \in \pi_{1}(X)$, and let $\widehat{\delta} \in B_{1, n}(X)$ be an element such that $\left(\iota_{1, n}\right)_{\#}(\widehat{\delta})=\delta$. Considering the homomorphism $\varphi^{\prime}: \pi_{1}(X) \longrightarrow B_{1, n}(X)$ defined by $\varphi^{\prime}(\alpha)=\widehat{\delta}^{-1} \varphi(\alpha) \widehat{\delta}$ for all $\alpha \in \pi_{1}(X)$, we obtain the commutative diagram (2), where we replace $\varphi$ by $\varphi^{\prime}$. The proof of part (b) is similar, and is left to the reader.

For the case of roots, we now give statements analogous to those of Propositions 19 and 20 and of Theorem 4. The proofs are similar to those of the corresponding statements for fixed points, and the details are left to the reader.

Proposition 21. Let $n \in \mathbb{N}$, let $X$ and $Y$ be metric spaces, let $y_{0} \in Y$ be a basepoint, and let $\phi: X \multimap Y$ be an n-valued map. If $\phi$ can be deformed to a root-free $n$-valued map, then there exists a map $\Theta: X \longrightarrow D_{n}\left(Y \backslash\left\{y_{0}\right\}\right)$ such that the following diagram is commutative up to homotopy:

where the map $\iota_{n}: D_{n}\left(Y \backslash\left\{y_{0}\right\}\right) \longrightarrow D_{n}(Y)$ is induced by the inclusion map $Y \backslash\left\{y_{0}\right\} \longleftrightarrow Y$. Conversely, if $Y$ is a manifold without boundary and there exists a map $\Theta: X \longrightarrow D_{n}(Y)$ such that diagram (5) is commutative up to homotopy, then the n-valued map $\phi: X \multimap Y$ may be deformed to a root-free $n$-valued map.

For split $n$-valued maps, the correspondence of Lemma 9(a) gives rise to a statement analogous to that of Proposition 21 in terms of $F_{n}(Y)$.

Proposition 22. Let $n \in \mathbb{N}$, let $X$ and $Y$ be metric spaces, let $y_{0} \in Y$ a basepoint, and let $\phi: X \multimap Y$ be a split n-valued map. If $\phi$ can be deformed to a root-free n-valued map then there exists a map $\widehat{\Theta}: X \longrightarrow F_{n}\left(Y \backslash\left\{y_{0}\right\}\right)$ and a lift $\widehat{\Phi}$ of $\phi$ such that the following diagram is commutative up to homotopy:

where the map $\widehat{\iota}_{n}: F_{n}\left(Y \backslash\left\{y_{0}\right\}\right) \longrightarrow F_{n}(Y)$ is induced by the inclusion map $Y \backslash\left\{y_{0}\right\} \longleftrightarrow$ $Y$. Conversely, if $Y$ is a manifold without boundary, and there exists a map $\widehat{\Theta}: X \longrightarrow$ $F_{n}\left(Y \backslash\left\{y_{0}\right\}\right)$ such that diagram (6) is commutative up to homotopy, then the split n-valued map $\phi: X \multimap Y$ may be deformed through split maps to a root-free split n-valued map.

Propositions 21 and 22 may be applied to the case where $X$ and $Y$ are compact surfaces without boundary of non-positive Euler characteristic to obtain the analogue of Theorem 4 for roots.

Theorem 23. Let $n \in \mathbb{N}$, and let $X$ and $Y$ be compact surfaces without boundary of non-positive Euler characteristic.
(a) An n-valued map $\phi: X \multimap Y$ can be deformed to a root-free n-valued map if and only if there is a homomorphism $\varphi: \pi_{1}(X) \longrightarrow B_{n}\left(Y \backslash\left\{y_{0}\right\}\right)$ that makes the following diagram commute:

where $\iota_{n}: D_{n}\left(Y \backslash\left\{y_{0}\right\}\right) \longrightarrow D_{n}(Y)$ is induced by the inclusion map $Y \backslash\left\{y_{0}\right\} \longleftrightarrow Y$, and $\Phi: X \longrightarrow D_{n}(Y)$ is the n-unordered map associated to $\phi$.
(b) A split n-valued map $\phi: X \multimap Y$ can be deformed to a root-free n-valued map if and only if there exist a lift $\widehat{\Phi}: X \longrightarrow F_{n}(Y)$ of $\phi$ and a homomorphism $\widehat{\varphi}: \pi_{1}(X) \longrightarrow$ $P_{n}\left(Y \backslash\left\{y_{0}\right\}\right)$ that make the following diagram commute:

where $\widehat{\iota}_{n}: F_{n}\left(Y \backslash\left\{y_{0}\right\}\right) \longrightarrow F_{n}(Y)$ is induced by the inclusion map $Y \backslash\left\{y_{0}\right\} \longleftrightarrow Y$.

## 5 An application to split 2-valued maps of the 2-torus

In this section, we will use some of the ideas and results of Section 4 to study the fixed point theory of 2 -valued maps of the 2 -torus $\mathbb{T}^{2}$. We restrict our attention to the case where the maps are split, i.e. we consider 2 -valued maps of the form $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ that admit a lift $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$, where $\widehat{\Phi}=\left(f_{1}, f_{2}\right), f_{1}$ and $f_{2}$ being coincidence-free self-maps of $\mathbb{T}^{2}$. We classify the set of homotopy classes of split 2 -valued maps of $\mathbb{T}^{2}$, and we study the question of the characterisation of those split 2-valued maps that can be deformed to fixed point free 2 -valued maps. The case of arbitrary 2 -valued maps of $\mathbb{T}^{2}$ will be treated in a forthcoming paper. In Section 5.1, we give presentations of the groups $P_{2}\left(\mathbb{T}^{2}\right), B_{2}\left(\mathbb{T}^{2}\right)$ and $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ that will be used in the following sections, where 1 denotes a basepoint of $\mathbb{T}^{2}$. In Section 5.2, we describe the set of based and free homotopy classes of split 2-valued maps of $\mathbb{T}^{2}$. In Section 5.3 , we give a formula for the Nielsen number, and we derive a necessary condition for such a split 2-valued map to be deformable to a fixed point free

2 -valued map. We then give an infinite family of homotopy classes of split 2 -valued maps of $\mathbb{T}^{2}$ that satisfy this condition and that may be deformed to fixed point free 2-valued maps. To facilitate the calculations, in Section 5.3.2, we shall show that the fixed point problem is equivalent to a root problem.

### 5.1 The groups $P_{2}\left(\mathbb{T}^{2}\right), B_{2}\left(\mathbb{T}^{2}\right)$ and $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$

In this section, we give presentations of $P_{2}\left(\mathbb{T}^{2}\right), B_{2}\left(\mathbb{T}^{2}\right)$ and $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ that will be used in the following sections. Other presentations of these groups may be found in the literature, see $[\mathrm{Bel}, \mathrm{Bi}, \mathrm{GM}, \mathrm{Sco}]$ for example. We start by considering the group $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$. If $u$ and $v$ are elements of a group $G$, we denote their commutator $u v u^{-1} v^{-1}$ by $[u, v]$, and the commutator subgroup of $G$ by $\Gamma_{2}(G)$. If $A$ is a subset of $G$ then $\langle\langle A\rangle\rangle_{G}$ will denote the normal closure of $A$ in $G$.

Proposition 24. The group $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ admits the following presentation:
generators: $\rho_{1,1}, \rho_{1,2}, \rho_{2,1}, \rho_{2,2}, B_{1,2}, B$ and $B^{\prime}$.
relations:
(a) $\rho_{2,1} \rho_{1,1} \rho_{2,1}^{-1}=B_{1,2} \rho_{1,1} B_{1,2}^{-1}$.
(b) $\rho_{2,1} \rho_{1,2} \rho_{2,1}^{-1}=B_{1,2} \rho_{1,2} \rho_{1,1}^{-1} B_{1,2} \rho_{1,1} B_{1,2}^{-1}$.
(c) $\rho_{2,2} \rho_{1,1} \rho_{2,2}^{-1}=\rho_{1,1} B_{1,2}^{-1}$.
(d) $\rho_{2,2} \rho_{1,2} \rho_{2,2}^{-1}=B_{1,2} \rho_{1,2} B_{1,2}^{-1}$.
(e) $\rho_{2,1} B \rho_{2,1}^{-1}=B$ and $\rho_{2,2} B \rho_{2,2}^{-1}=B$.
(f) $\rho_{2,1} B_{1,2} \rho_{2,1}^{-1}=B_{1,2} \rho_{1,1}^{-1} B_{1,2} \rho_{1,1} B_{1,2}^{-1}$ and $\rho_{2,2} B_{1,2} \rho_{2,2}^{-1}=B_{1,2} \rho_{1,2}^{-1} B_{1,2} \rho_{1,2} B_{1,2}^{-1}$.
(g) $B^{\prime} \rho_{1,1} B^{\prime-1}=\rho_{1,1}$ and $B^{\prime} \rho_{1,2} B^{\prime-1}=\rho_{1,2}$.
(h) $B^{\prime} B_{1,2} B^{\prime-1}=B_{1,2}^{-1} B^{-1} B_{1,2} B B_{1,2}$ and $B^{\prime} B B^{\prime-1}=B_{1,2}^{-1} B B_{1,2}$.
(i) $\left[\rho_{1,1}, \rho_{1,2}^{-1}\right]=B B_{1,2}$ and $\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]=B_{1,2} B^{\prime}$.

In particular, $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ is a semi-direct product of the free group of rank three generated by $\left\{\rho_{1,1}, \rho_{1,2}, B_{1,2}\right\}$ by the free group of rank two generated by $\left\{\rho_{2,1}, \rho_{2,2}\right\}$.

Geometric representatives of the generators of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ are illustrated in Figure 1. The torus is obtained from this figure by identifying the boundary to a point.

REmARk. The inclusion of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ in $P_{2}\left(\mathbb{T}^{2}\right)$ induces a surjective homomorphism $\alpha: P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$ that sends $B$ and $B^{\prime}$ to the trivial element, and sends each of the remaining generators (considered as an element of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ ) to itself (considered as an element of $P_{2}\left(\mathbb{T}^{2}\right)$ ). Applying this to the presentation of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ given by Proposition 24, we obtain the presentation of $P_{2}\left(\mathbb{T}^{2}\right)$ given in $[\mathrm{FH}]$.

Proof of Proposition 24. Consider the following Fadell-Neuwirth short exact sequence:

\begin{equation*}
1 \longrightarrow P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right) \xrightarrow{\left(p_{2}\right) \#} P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right) \longrightarrow 1 \tag{7}
\end{equation*}
$$

where $\left(p_{2}\right)_{\#}$ is the homomorphism given geometrically by forgetting the first string and induced by the projection $p_{2}: F_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow \mathbb{T}^{2} \backslash\{1\}$ onto the second coordinate. The kernel $K=P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right)$ of $\left(p_{2}\right)_{\#}$ (resp. the quotient $Q=P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{1}\right)$ ) is a free group of rank three (resp. two). It will be convenient to choose presentations for these two groups that have an extra generator. From Figure 1, we take $K$ (resp. $Q$ ) to be generated by $X=\left\{\rho_{1,1}, \rho_{1,2}, B_{1,2}, B\right\}$ (resp. $Y=\left\{\rho_{2,1}, \rho_{2,2}, B^{\prime}\right\}$ ) subject to the single

relation $\left[\rho_{1,1}, \rho_{1,2}^{-1}\right]=B B_{1,2}$ (resp. $\left.\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]=B^{\prime}\right)$. We apply standard methods to obtain a presentation of the group extension $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ [Jo, Proposition 1, p. 139]. This group is generated by the union of $X$ with coset representatives of $Y$, which we take to be the same elements geometrically, but considered as elements of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$. This yields the given generating set. There are three types of relation. The first is that of $K$. The second type of relation is obtained by lifting the relation of $Q$ to $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$, which gives rise to the relation $\left[\rho_{2,1}, \rho_{2,2}^{-1}\right] B^{\prime-1}=B_{1,2}$. The third type of relation is obtained by rewriting the conjugates of the elements of $X$ by the chosen coset representatives of the elements of $Y$ in terms of the elements of $X$ using the geometric representatives of $X$ and $Y$ illustrated in Figure 1. We leave the details to the reader. The last part of the statement is a consequence of the fact that $K$ (resp. $Q$ ) is a free group of rank three (resp. two), so the short exact sequence (7) splits.

REmark. For future purposes, it will be convenient to have the following relations at our disposal:

$$
\begin{array}{rlrl}
\rho_{2,1}^{-1} \rho_{1,1} \rho_{2,1} & =\rho_{1,1} B_{1,2}^{-1} \rho_{1,1} B_{1,2} \rho_{1,1}^{-1} & \rho_{2,1}^{-1} \rho_{1,2} \rho_{2,1} & =\rho_{1,1} B_{1,2}^{-1} \rho_{1,1}^{-1} \rho_{1,2} B_{1,2}^{-1} \rho_{1,1} B_{1,2} \rho_{1,1}^{-1} \\
\rho_{2,2}^{-1} \rho_{1,1} \rho_{2,2} & =\rho_{1,1} \rho_{1,2} B_{1,2} \rho_{1,2}^{-1} & \rho_{2,2}^{-1} \rho_{1,2} \rho_{2,2}=\rho_{1,2} B_{1,2}^{-1} \rho_{1,2} B_{1,2} \rho_{1,2}^{-1} \\
\rho_{2,1}^{-1} B_{1,2} \rho_{2,1} & =\rho_{1,1} B_{1,2} \rho_{1,1}^{-1} & \rho_{2,2}^{-1} B_{1,2} \rho_{2,2}=\rho_{1,2} B_{1,2} \rho_{1,2}^{-1} .
\end{array}
$$

As in the proof of Proposition 24, these equalities may be derived geometrically.

The presentation of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ given by Proposition 24 may be modified to obtain another presentation that highlights its algebraic structure as a semi-direct product of free groups of finite rank.

Proposition 25. The group $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ admits the following presentation:
generators: $B, u, v, x$ and $y$.
relations:
(a) $x u x^{-1}=u$.
(b) $x v x^{-1}=v\left[v^{-1}, u\right] B^{-1}\left[u, v^{-1}\right]$.
(c) $x B x^{-1}=u\left[v^{-1}, u\right] B\left[u, v^{-1}\right] u^{-1}$.
(d) $y u y^{-1}=v\left[v^{-1}, u\right] B u v^{-1}$.
(e) $y v y^{-1}=v$.
(f) $y B y^{-1}=v\left[v^{-1}, u\right] B\left[u, v^{-1}\right] v^{-1}=u v u^{-1} B u v^{-1} u^{-1}$.

In particular, $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ is a semi-direct product of the free group of rank three generated by $\{u, v, B\}$ by the free group of rank two generated by $\{x, y\}$.

Proof. Using relation (i) of Proposition 24, we define $B^{\prime}$ as $B_{1,2}^{-1}\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]$ and $B_{1,2}$ as $B^{-1}\left[\rho_{1,1}, \rho_{1,2}^{-1}\right]$. We then apply the following change of variables:

$$
\begin{equation*}
u=\rho_{1,1}, v=\rho_{1,2}, x=\rho_{1,1} B_{1,2}^{-1} \rho_{2,1} \text { and } y=\rho_{1,2} B_{1,2}^{-1} \rho_{2,2} . \tag{8}
\end{equation*}
$$

Relations (a)-(e) of Proposition 24 may be seen to give rise to relations (a)-(f) of Proposition 25. Rewritten in terms of the generators of Proposition 25, relations (f)-(h) of Proposition 24 are consequences of relations (a)-(f) of Proposition 25. To see this, using the relations of Proposition 25, first note that:

$$
\begin{aligned}
x B_{1,2} x^{-1} & =x B^{-1}\left[u, v^{-1}\right] x^{-1}=u\left[v^{-1}, u\right] B^{-1}\left[u, v^{-1}\right] u^{-1} \cdot\left[u,\left[v^{-1}, u\right] B\left[u, v^{-1}\right] v^{-1}\right] \\
& =B^{-1}\left[u, v^{-1}\right]=B_{1,2} \text { and } \\
y B_{1,2} y^{-1} & =y B^{-1}\left[u, v^{-1}\right] y^{-1}=v\left[v^{-1}, u\right] B^{-1}\left[u, v^{-1}\right] v^{-1} \cdot\left[v\left[v^{-1}, u\right] B u v^{-1}, v^{-1}\right] \\
& =B^{-1}\left[u, v^{-1}\right]=B_{1,2} .
\end{aligned}
$$

In light of these relations, it is convenient to carry out the calculations using $B_{1,2}$ instead of $B$. In conjunction with the relations of the preceding remark, we obtain the following relations:

$$
\left\{\begin{array}{l}
y u y^{-1}=v B_{1,2}^{-1} u v^{-1}, x v x^{-1}=u v u^{-1} B_{1,2}  \tag{9}\\
y^{-1} u y=B_{1,2} v^{-1} u v, x^{-1} v x=u^{-1} v B_{1,2}^{-1} u
\end{array}\right.
$$

from which it follows that:

$$
\begin{aligned}
& \rho_{2,1} B_{1,2} \rho_{2,1}^{-1}=B_{1,2} u^{-1} x B_{1,2} x^{-1} u B_{1,2}^{-1}=B_{1,2} u^{-1} B_{1,2} u B_{1,2}^{-1}=B_{1,2} \rho_{1,1}^{-1} B_{1,2} \rho_{1,1} B_{1,2}^{-1} \text { and } \\
& \rho_{2,2} B_{1,2} \rho_{2,2}^{-1}=B_{1,2} v^{-1} y B_{1,2} y^{-1} v B_{1,2}^{-1}=B_{1,2} v^{-1} B_{1,2} v B_{1,2}^{-1}=B_{1,2} \rho_{1,2}^{-1} B_{1,2} \rho_{1,2} B_{1,2}^{-1} .
\end{aligned}
$$

Thus relations (a)-(f) of Proposition 25 imply relations (f) of Proposition 24. Now $B^{\prime}=$ $B_{1,2}^{-1}\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]$, and a straightforward computation shows that:

$$
\begin{aligned}
B^{\prime}=u^{-1} x y^{-1} v B_{1,2}^{-1} x^{-1} u v^{-1} y & =u^{-1} x y^{-1} v B_{1,2}^{-1} x^{-1} u v^{-1} \cdot x y x^{-1} \cdot x y^{-1} x^{-1} y \\
& =\left[v^{-1}, u\right] B_{1,2} \cdot x y^{-1} x^{-1} y .
\end{aligned}
$$

One may then check that:

$$
\begin{aligned}
& x y^{-1} x^{-1} y u y^{-1} x y x^{-1}=B_{1,2}^{-1}\left[u, v^{-1}\right] u\left[v^{-1}, u\right] B_{1,2} \text { and } \\
& x y^{-1} x^{-1} y v y^{-1} x y x^{-1}=B_{1,2}^{-1}\left[u, v^{-1}\right] v\left[v^{-1}, u\right] B_{1,2},
\end{aligned}
$$

and that:

$$
\begin{aligned}
& B^{\prime} \rho_{1,1} B^{\prime-1}=B^{\prime} u B^{\prime-1}=\left[v^{-1}, u\right] B_{1,2} \cdot x y^{-1} x^{-1} y u y^{-1} x y x^{-1} B_{1,2}^{-1}\left[u, v^{-1}\right]=u=\rho_{1,1} \text { and } \\
& B^{\prime} \rho_{1,2} B^{\prime-1}=B^{\prime} v B^{\prime-1}=\left[v^{-1}, u\right] B_{1,2} \cdot x y^{-1} x^{-1} y v y^{-1} x y x^{-1} B_{1,2}^{-1}\left[u, v^{-1}\right]=v=\rho_{1,2} .
\end{aligned}
$$

Hence relations (a)-(f) of Proposition 25 imply relations (g) of Proposition 24. Furthermore,

$$
\begin{aligned}
B^{\prime} B_{1,2} B^{\prime-1} & =v^{-1} u v u^{-1} B_{1,2} x y^{-1} x^{-1} y B_{1,2} y^{-1} x y x^{-1} B_{1,2}^{-1} u v^{-1} u^{-1} v \\
& =v^{-1} u v u^{-1} B_{1,2} u v^{-1} u^{-1} v=B_{1,2}^{-1} . B_{1,2}\left[v^{-1}, u\right] B_{1,2}\left[u, v^{-1}\right] B_{1,2}^{-1} \cdot B_{1,2} \\
& =B_{1,2}^{-1} B^{-1} B_{1,2} B B_{1,2},
\end{aligned}
$$

and since

$$
\begin{aligned}
x y^{-1} x^{-1} y\left[u, v^{-1}\right] y^{-1} x y x^{-1} & =\left[B_{1,2}^{-1}\left[u, v^{-1}\right] u\left[v^{-1}, u\right] B_{1,2}, B_{1,2}^{-1}\left[u, v^{-1}\right] v^{-1}\left[v^{-1}, u\right] B_{1,2}\right] \\
& =B_{1,2}^{-1}\left[u, v^{-1}\right] B_{1,2},
\end{aligned}
$$

we obtain:

$$
\begin{aligned}
B^{\prime} B B^{\prime-1} & =\left[v^{-1}, u\right] B_{1,2} B_{1,2}^{-1}\left[u, v^{-1}\right] B_{1,2}^{-1} B_{1,2} B_{1,2}^{-1}\left[u, v^{-1}\right]=B_{1,2}^{-1}\left[u, v^{-1}\right] B_{1,2}^{-1} \cdot B_{1,2} \\
& =B_{1,2}^{-1} B B_{1,2} .
\end{aligned}
$$

Hence relations (a)-(f) of Proposition 25 imply relations (h) of Proposition 24. This proves the first part of the statement. The last part of the statement is a consequence of the nature of the presentation.

The homomorphism $\alpha: P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$ mentioned in the remark that follows the statement of Proposition 24 may be used to obtain a presentation of $P_{2}(T)$ in terms of the generators of Proposition 25. To do so, we first show that $\operatorname{Ker}(\alpha)$ is the normal closure in $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ of $B$ and $B^{\prime}$.

Proposition 26. $\operatorname{Ker}(\alpha)=\left\langle\left\langle B, B^{\prime}\right\rangle\right\rangle_{P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)}$.
Proof. Consider the presentation of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ given in Proposition 24, as well as the short exact sequence (7) and the surjective homomorphism $\alpha: P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$. In terms of the generators of Proposition 24, for $i=1,2, \alpha$ sends $\rho_{i, j}$ (resp. $B_{1,2}$ ) (considered as an element of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ ) to $\rho_{i, j}$ (resp. to $\left.B_{1,2}\right)$ (considered as an element of $\left.P_{2}\left(\mathbb{T}^{2}\right)\right)$, and it sends $B$ and $B^{\prime}$ to the trivial element. Since $B, B^{\prime} \in \operatorname{Ker}(\alpha)$, it is clear that $\left\langle\left\langle B, B^{\prime}\right\rangle\right\rangle_{P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)} \subset \operatorname{Ker}(\alpha)$. We now proceed to prove the converse inclusion. Using the projection $\left(p_{2}\right)_{\#}$ and $\alpha$, we obtain the following commutative diagram of short exact
sequences:


Diagram (10) is constructed in the following manner: the surjective homomorphism $\alpha^{\prime}: P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)-$ $P_{1}\left(\mathbb{T}^{2}, x_{2}\right)$ is induced by the inclusion $\iota^{\prime}: \mathbb{T}^{2} \backslash\{1\} \longrightarrow \mathbb{T}^{2}$, and the right-hand column is a Fadell-Neuwirth short exact sequence, where the fibration $p_{2}^{\prime}: F_{2}\left(\mathbb{T}^{2}\right) \longrightarrow \mathbb{T}^{2}$ is given by projecting onto the second coordinate. The homomorphism $\tau: P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right) \longrightarrow$ $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ is interpreted as inclusion. Taking $\left\{\rho_{2,1}, \rho_{2,2}, B^{\prime}\right\}$ to be a generating set of $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$ subject to the relation $\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]=B^{\prime}$, as for $\alpha$, we see that $\alpha^{\prime}\left(\rho_{2, j}\right)=\rho_{2, j}$ and $\alpha^{\prime}\left(B^{\prime}\right)=1$. Alternatively, we may consider $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$ to be the free group on $\left\{\rho_{2,1}, \rho_{2,2}\right\}$, and $P_{1}\left(\mathbb{T}^{2}, x_{2}\right)$ to be the free Abelian group on $\left\{\rho_{2,1}, \rho_{2,2}\right\}$, so $\alpha^{\prime}$ is Abelianisation, and $\operatorname{Ker}\left(\alpha^{\prime}\right)=\Gamma_{2}\left(P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)\right)$. Interpreting $\alpha^{\prime}$ as the canonical projection of $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$ onto its quotient by the normal closure of the element $\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]$ in $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$, we see that $\operatorname{Ker}\left(\alpha^{\prime}\right)=\left\langle\left\langle\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]\right\rangle\right\rangle_{P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)}$. But $\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]=B^{\prime}$ in $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$, hence:

$$
\begin{equation*}
\operatorname{Ker}\left(\alpha^{\prime}\right)=\left\langle\left\langle B^{\prime}\right\rangle\right\rangle_{P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)} . \tag{11}
\end{equation*}
$$

The fact that $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$ is a free group implies that $\operatorname{Ker}\left(\alpha^{\prime}\right)$ is too (albeit of infinite rank). The commutativity of the lower right-hand square of (10) is a consequence of the following commutative square:

where $\iota: F_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ is induced by the inclusion $\iota^{\prime}$. Together with $\alpha$ and $\alpha^{\prime}$, the second two columns of (10) give rise to a homomorphism $\bar{\alpha}: P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right) \longrightarrow$ $P_{1}\left(\mathbb{T}^{2} \backslash\left\{x_{2}\right\}, x_{1}\right)$. Taking $\left\{\rho_{1,1}, \rho_{1,2}, B_{1,2}, B\right\}$ to be a generating set of $P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right)$, by commutativity of the diagram, we see that $\bar{\alpha}$ sends each of $\rho_{1,1}, \rho_{1,2}$ and $B_{1,2}$ (considered as an element of $P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\},\left(x_{1}, x_{2}\right)\right)$ ) to itself (considered as an element of $P_{1}\left(\mathbb{T}^{2} \backslash\right.$ $\left.\left\{x_{2}\right\}, x_{1}\right)$ ), and sends $B^{\prime}$ to the trivial element. In particular, $\bar{\alpha}$ is surjective. As for $\alpha^{\prime}$, we may consider $P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right)$ to be the free group of rank three generated by $\left\{\rho_{1,1}, \rho_{1,2}, B_{1,2}\right\}$, and $P_{1}\left(\mathbb{T}^{2} \backslash\left\{x_{2}\right\}, x_{1}\right)$ to be the group generated by $\left\{\rho_{1,1}, \rho_{1,2}, B_{1,2}\right\}$ subject
to the relation $\left[\rho_{1,1}, \rho_{1,2}^{-1}\right]=B_{1,2}$. The homomorphism $\alpha^{\prime}$ may thus be interpreted as the canonical projection of $P_{1}\left(\mathbb{T}^{2} \backslash\left\{x_{2}\right\}, x_{1}\right)$ onto its quotient by $\left\langle\left\langle\left[\rho_{1,1}, \rho_{1,2}^{-1}\right] B_{1,2}^{-1}\right\rangle\right\rangle_{P_{1}\left(\mathbb{T}^{2} \backslash\left\{x_{2}\right\}, x_{1}\right)}$. But by relation (i) of Proposition 24, $B^{\prime}=\left[\rho_{1,1}, \rho_{1,2}^{-1}\right] B_{1,2}^{-1}$, hence:

$$
\operatorname{Ker}(\bar{\alpha})=\left\langle\left\langle B^{\prime}\right\rangle\right\rangle_{P_{1}\left(\mathbb{T}^{2} \backslash\left\{x_{2}\right\}, x_{1}\right)}
$$

By exactness, the first (resp. second) two rows of (10) give rise to an induced homomorphism $\left.\tau\right|_{\operatorname{Ker}(\bar{\alpha})}: \operatorname{Ker}(\bar{\alpha}) \longrightarrow \operatorname{Ker}(\alpha)$ (resp. $\left.\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}: \operatorname{Ker}(\alpha) \longrightarrow \operatorname{Ker}\left(\alpha^{\prime}\right)\right)$, and $\left.\tau\right|_{\operatorname{Ker}(\bar{\alpha})}$ is injective because $\tau$ is. The homomorphism $\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}$ is surjective, because by (11), any element $x$ of $\operatorname{Ker}\left(\alpha^{\prime}\right)$ may be written as a product of conjugates of $B^{\prime}$ and its inverse by products of $\rho_{2,1}, \rho_{2,2}$ and $B^{\prime}$. This expression, considered as an element of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$, belongs to $\operatorname{Ker}(\alpha)$, and its image under $\left(p_{2}\right)_{\#}$ is equal to $x$.

The fact that $\operatorname{Im}\left(\left.\tau\right|_{\operatorname{Ker}(\bar{\alpha})}\right) \subset \operatorname{Ker}\left(\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}\right)$ follows from exactness of the second column of (10). Conversely, if $z \in \operatorname{Ker}\left(\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}\right)$ then $z \in \operatorname{Ker}(\tau)$ by exactness of the second column. So there exists $y \in P_{1}\left(\mathbb{T}^{2} \backslash\left\{1, x_{2}\right\}, x_{1}\right)$ such that $\tau(y)=z$. But $\bar{\alpha}(y)=\alpha(\tau(y))=\alpha(z)=1$, and hence $y \in \operatorname{Ker}(\bar{\alpha})$. This proves that $\operatorname{Ker}\left(\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}\right) \subset$ $\operatorname{Im}\left(\left.\tau\right|_{\operatorname{Ker}(\bar{\alpha})}\right)$, and we deduce that the first column is exact.

Finally, since $\operatorname{Ker}\left(\alpha^{\prime}\right)$ is free, we may pick an infinite basis consisting of conjugates of $B^{\prime}$ by certain elements of $P_{1}\left(\mathbb{T}^{2} \backslash\{1\}, x_{2}\right)$. Further, there exists a section $s: \operatorname{Ker}\left(\alpha^{\prime}\right) \longrightarrow$ [ $\operatorname{Ker}(\alpha)]$ for $\left.\left(p_{2}\right)_{\#}\right|_{\operatorname{Ker}(\alpha)}$ that consists in sending each of these conjugates (considered as an element of $\left.\operatorname{Ker}\left(\alpha^{\prime}\right)\right)$ to itself (considered as an element of $\left.\operatorname{Ker}(\alpha)\right)$. In particular, $\operatorname{Ker}(\alpha)$ is an internal semi-direct product of $\tau(\operatorname{Ker}(\bar{\alpha}))$, which is contained in $\langle\langle B\rangle\rangle_{P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)}$, by $s(\operatorname{Ker}(\bar{\alpha}))$, which is contained in $\left\langle\left\langle B^{\prime}\right\rangle\right\rangle_{P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)}$. Hence $\operatorname{Ker}(\alpha)$ is contained in the subgroup $\left\langle\left\langle B, B^{\prime}\right\rangle\right\rangle_{P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)}$. This completes the proof of the proposition.

We may thus deduce the following useful presentation of $P_{2}\left(\mathbb{T}^{2}\right)$.
Corollary 27. The group $P_{2}\left(\mathbb{T}^{2},\left(x_{1}, x_{2}\right)\right)$ admits the following presentation:
generators: $u, v, x$ and $y$.
relations:
(a) $x u x^{-1}=u$ and $y u y^{-1}=u$.
(b) $x v x^{-1}=v$ and $y v y^{-1}=v$.
(c) $x y x^{-1}=y$.

In particular, $P_{2}\left(\mathbb{T}^{2},\left(x_{1}, x_{2}\right)\right)$ is isomorphic to the direct product of the free group of rank two generated by $\{u, v\}$ and the free Abelian group of rank two generated by $\{x, y\}$.

Remark. The decomposition of Corollary 27 is a special case of [BGG, Lemma 17].
Proof of Corollary 27. By Proposition 26, a presentation of $P_{2}\left(\mathbb{T}^{2}\right)$ may be obtained from the presentation of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ given in Proposition 25 by setting $B$ and $B^{\prime}$ equal to 1 . Under this operation, relations (a) and (d) (resp. (b) and (e)) of Proposition 25 are sent to relations (a) (resp. (b)) of Corollary 27, and relations (c) and (f) of Proposition 25 become trivial. We must also take into account the fact that $B^{\prime}=1$ in $P_{2}\left(\mathbb{T}^{2}\right)$. In $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$, we have:

$$
B^{\prime}=B_{1,2}^{-1}\left[\rho_{2,1}, \rho_{2,2}^{-1}\right]=\left[v^{-1}, u\right] B\left[B^{-1}\left[u, v^{-1}\right] \cdot u^{-1} x, y^{-1} v\left[v^{-1}, u\right] B\right]
$$

and taking the image of this equation by $\alpha$, we obtain:

$$
\begin{aligned}
1 & =\left[v^{-1}, u\right]\left[\left[u, v^{-1}\right] u^{-1} x, y^{-1} v\left[v^{-1}, u\right]\right] \\
& =\left[v^{-1}, u\right] \cdot\left[u, v^{-1}\right] u^{-1} x \cdot y^{-1} v\left[v^{-1}, u\right] \cdot x^{-1} u\left[v^{-1}, u\right] \cdot\left[u, v^{-1}\right] v^{-1} y=u^{-1} x y^{-1} u v u^{-1} x^{-1} u v^{-1} y
\end{aligned}
$$

in $P_{2}\left(\mathbb{T}^{2}\right)$. Using relations (a) (resp. (b)) of Corollary 27, it follows that $\left[x, y^{-1}\right]=1$, which yields relation (c) of Corollary 27. The last part of the statement is a consequence of the nature of the presentation.

Remark. As we saw in Proposition $25, P_{2}\left(\mathbb{T}^{2} \backslash\{1\},\left(x_{1}, x_{2}\right)\right)$ is a semi-direct product of the form $\mathbb{F}_{3}(u, v, B) \rtimes \mathbb{F}_{2}(x, y)$, the action being given by the relations of that proposition. Transposing the second two columns of the commutative diagram (10), we obtain, up to isomorphism, the following commutative diagram:

where $\alpha(u)=u, \alpha(v)=v, \alpha(B)=1, \alpha(x)=(1 ;(1,0))$ and $\alpha(y)=(1 ;(0,1))$. This is a convenient setting to study the question of whether a 2 -valued map may be deformed to a root-free 2-valued map (which implies that the corresponding map may be deformed to a fixed point free map), since using (12) and Theorem 23(b), the question is equivalent to a lifting problem, to which we will refer in Section 5.3, notably in Propositions 38 and 40.

Using the short exact sequence (1), we obtain the following presentation of the full braid group $B_{2}\left(\mathbb{T}^{2},\left(x_{1}, x_{2}\right)\right)$ from that of $P_{2}\left(\mathbb{T}^{2},\left(x_{1}, x_{2}\right)\right)$ given by Corollary 27.

Proposition 28. The group $B_{2}\left(\mathbb{T}^{2},\left(x_{1}, x_{2}\right)\right)$ admits the following presentation: generators: $u, v, x, y$ and $\sigma$.
relations:
(a) $x u x^{-1}=u$ and $y u y^{-1}=u$.
(b) $x v x^{-1}=v$ and $y v y^{-1}=v$.
(c) $x y x^{-1}=y$.
(d) $\sigma^{2}=\left[u, v^{-1}\right]$.
(e) $\sigma x \sigma^{-1}=x$ and $\sigma y \sigma^{-1}=y$.
(f) $\sigma u \sigma^{-1}=\left[u, v^{-1}\right] u^{-1} x$ and $\sigma v \sigma^{-1}=\left[u, v^{-1}\right] v^{-1} y$.

Proof. Once more, we apply the methods of [Jo, Proposition 1, p. 139], this time to the short exact sequence (1) for $X=\mathbb{T}^{2}$ and $n=2$, where we take $P_{2}\left(\mathbb{T}^{2}\right)$ to have the presentation given by Corollary 27. A coset representative of the generator of $\mathbb{Z}_{2}$ is given by the braid $\sigma=\sigma_{1}$ that swaps the two basepoints. Hence $\{u, v, x, y, \sigma\}$ generates $B_{2}\left(\mathbb{T}^{2}\right)$. Relations (a)-(c) emanate from the relations of $P_{2}\left(\mathbb{T}^{2}\right)$. Relation (d) is obtained by lifting the relation of $\mathbb{Z}_{2}$ to $B_{2}\left(\mathbb{T}^{2}\right)$ and using the fact that $\sigma^{2}=B_{1,2}=\left[u, v^{-1}\right]$. To obtain relations (e) and (f), by geometric arguments, one may see that for $j \in\{1,2\}$, $\sigma \rho_{1, j} \sigma^{-1}=\rho_{2, j}$ and $\sigma \rho_{2, j} \sigma^{-1}=B_{1,2} \rho_{2, j} B_{1,2}^{-1}$, and one then uses equation (8) to express these relations in terms of $u, v, x$ and $y$.

### 5.2 A description of the homotopy classes of 2-ordered and split 2 -valued maps of $\mathbb{T}^{2}$, and the computation of the Nielsen number

In this section, we describe the homotopy classes of 2-ordered (resp. split 2-valued) maps of $\mathbb{T}^{2}$ using the group structure of $P_{2}\left(\mathbb{T}^{2}\right)$ (resp. of $B_{2}\left(\mathbb{T}^{2}\right)$ ) given in Section 5.1.

Proposition 29.
(a) The set $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]_{0}$ of based homotopy classes of 2 -ordered maps of $\mathbb{T}^{2}$ is in one-toone correspondence with the set of commuting, ordered pairs of elements of $P_{2}\left(\mathbb{T}^{2}\right)$.
(b) The set $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$ of homotopy classes of 2 -ordered maps of $\mathbb{T}^{2}$ is in one-to-one correspondence with the set of commuting, conjugate, ordered pairs of $P_{2}\left(\mathbb{T}^{2}\right)$, i.e. two commuting pairs $\left(\alpha_{1}, \beta_{1}\right)$ and $\left(\alpha_{2}, \beta_{2}\right)$ of $P_{2}\left(\mathbb{T}^{2}\right)$ give rise to the same homotopy class of 2 -ordered maps of $\mathbb{T}^{2}$ if there exists $\delta \in P_{2}\left(\mathbb{T}^{2}\right)$ such that $\delta \alpha_{1} \delta^{-1}=\alpha_{2}$ and $\delta \beta_{1} \delta^{-1}=\beta_{2}$.
(c) Under the projection $\widehat{\pi}:\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] \longrightarrow\left[\mathbb{T}^{2}, D_{2}\left(\mathbb{T}^{2}\right)\right]$ induced by the covering map $\pi: F_{2}\left(\mathbb{T}^{2}\right) \longrightarrow D_{2}\left(\mathbb{T}^{2}\right)$, two homotopy classes of 2 -ordered maps of $\mathbb{T}^{2}$ are sent to the same homotopy class of 2 -unordered maps if and only if any two pairs of braids that represent the maps are conjugate in $B_{2}\left(\mathbb{T}^{2}\right)$.

Proof. Let $x_{0} \in \mathbb{T}^{2}$ and $\left(y_{0}, z_{0}\right) \in F_{2}\left(\mathbb{T}^{2}\right)$ be basepoints, and let $\Psi: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a basepoint-preserving 2 -ordered map. The restriction of $\Psi$ to the meridian $\mu$ and the longitude $\lambda$ of $\mathbb{T}^{2}$, which are geometric representatives of the elements of the basis $\left(e_{1}, e_{2}\right)$ of $\pi_{1}\left(\mathbb{T}^{2}\right)$, gives rise to a pair of geometric braids. The resulting pair $\left(\Psi_{\#}\left(e_{1}\right), \Psi_{\#}\left(e_{2}\right)\right)$ of elements of $P_{2}\left(\mathbb{T}^{2}\right)$ obtained via the induced homomorphism $\Psi_{\#}: \pi_{1}\left(\mathbb{T}^{2}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$ is an invariant of the based homotopy class of the map $\Psi$, and the two braids $\Psi_{\#}\left(e_{1}\right)$ and $\Psi_{\#}\left(e_{2}\right)$ commute. Conversely, given a pair of braids $(\alpha, \beta)$ of $P_{2}\left(\mathbb{T}^{2}\right)$, let $f_{1}: \mathbb{S}^{1} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ and $f_{2}: \mathbb{S}^{1} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be geometric representatives of $\alpha$ and $\beta$ respectively, i.e. $\alpha=\left[f_{1}\right]$ and $\beta=\left[f_{2}\right]$. Then we define a geometric map from the wedge of two circles into $F_{2}\left(\mathbb{T}^{2}\right)$ by sending $x \in \mathbb{S}^{1} \vee \mathbb{S}^{1}$ to $f_{1}(x)$ (resp. to $f_{2}(x)$ ) if $x$ belongs to the first (resp. second) copy of $\mathbb{S}^{1}$. By classical obstruction theory in low dimension, this map extends to $\mathbb{T}^{2}$ if and only if $\alpha$ and $\beta$ commute as elements of $P_{2}\left(\mathbb{T}^{2}\right)$, and part (a) follows. Parts (b) and (c) are consequences of part (a) and classical general facts about maps between spaces of type $K(\pi, 1)$, see [Wh, Chapter V, Theorem 4.3] for example.

Applying Proposition 20 to $\mathbb{T}^{2}$, we obtain the following consequence.
Proposition 30. If $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ is a split 2-valued map and $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ is a lift of $\phi$, the map $\phi$ can be deformed to a fixed point free 2-valued map if and only if there exist commuting elements $\alpha_{1}, \alpha_{2} \in P_{3}\left(\mathbb{T}^{2}\right)$ such that $\alpha_{1}$ (resp. $\alpha_{2}$ ) projects to $\left(e_{1}, \widehat{\Phi}_{\#}\left(e_{1}\right)\right)$ (resp. $\left(e_{2}, \widehat{\Phi}_{\#}\left(e_{2}\right)\right)$ ) under the homomorphism induced by the inclusion map $\widehat{\iota}_{3}: F_{3}\left(\mathbb{T}^{2}\right) \longrightarrow$ $\mathbb{T}^{2} \times F_{2}\left(\mathbb{T}^{2}\right)$.

Proof. Since $\mathbb{T}^{2}$ is a space of type $K(\pi, 1)$, the existence of diagram (4) is equivalent to that of the corresponding induced diagram on the level of fundamental groups. It then suffices to take $\alpha_{1}=\Theta_{\#}\left(e_{1}\right)$ and $\alpha_{2}=\Theta_{\#}\left(e_{2}\right)$ in the statement of Proposition 20.

Proposition 30 gives a criterion to decide whether a split 2 -valued map of $\mathbb{T}^{2}$ can be deformed to a fixed point free 2-valued map. However, from a computational point of view, it seems better to use an alternative condition in terms of roots (see Section 5.3.3).

In the following proposition, we make use of the identification of $P_{2}\left(\mathbb{T}^{2}\right)$ with $\mathbb{F}_{2} \times \mathbb{Z}^{2}$ given in Corollary 27.

## Proposition 31.

(a) The set $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]_{0}$ of based homotopy classes of 2 -ordered maps of $\mathbb{T}^{2}$ is in one-to-one correspondence with the set of pairs $(\alpha, \beta)$ of elements of $\mathbb{F}_{2} \times \mathbb{Z}^{2}$ of the form $\alpha=\left(w^{r},(a, b)\right), \beta=\left(w^{s},(c, d)\right)$, where $(a, b),(c, d),(r, s) \in \mathbb{Z}^{2}$ and $w \in \mathbb{F}_{2}$. Further, up to taking a root of $w$ if necessary, we may assume that $w$ is either trivial or is a primitive element of $\mathbb{F}_{2}$ (i.e. $w$ is not a proper power of another element of $\mathbb{F}_{2}$ ).
(b) The set $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$ of homotopy classes of 2 -ordered maps of $\mathbb{T}^{2}$ is in one-to-one correspondence with the set of the equivalence classes of pairs $(\alpha, \beta)$ of elements of $\mathbb{F}_{2} \times \mathbb{Z}^{2}$ of the form given in part (a), where the equivalence relation is defined as follows: the pairs of elements $\left(\left(w_{1}^{r_{1}},\left(a_{1}, b_{1}\right)\right),\left(w_{1}^{s_{1}},\left(c_{1}, d_{1}\right)\right)\right)$ and $\left(\left(w_{2}^{r_{2}},\left(a_{2}, b_{2}\right)\right),\left(w_{2}^{s_{2}},\left(c_{2}, d_{2}\right)\right)\right)$ of $\mathbb{F}_{2} \times \mathbb{Z}^{2}$ are equivalent if and only if $\left(a_{1}, b_{1}, c_{1}, d_{1}\right)=\left(a_{2}, b_{2}, c_{2}, d_{2}\right)$, and either:
(i) $w_{1}=w_{2}=1$, or
(ii) $w_{1}$ and $w_{2}$ are primitive, and there exists $\varepsilon \in\{1,-1\}$ such that $w_{1}$ and $w_{2}^{\varepsilon}$ are conjugate in $\mathbb{F}_{2}$, and $\left(r_{1}, s_{1}\right)=\varepsilon\left(r_{2}, s_{2}\right) \neq(0,0)$.
Proof. Part (a) follows using Proposition 29(a), the identification of $P_{2}\left(\mathbb{T}^{2}\right)$ with $\mathbb{F}_{2} \times \mathbb{Z}^{2}$ given by Corollary 27, and the fact that two elements of $\mathbb{F}_{2}$ commute if and only if they are powers of some common element of $\mathbb{F}_{2}$. Part (b) is a consequence of Proposition 29(b), Corollary 27, and the straightforward description of the conjugacy classes of the group $\mathbb{F}_{2} \times \mathbb{Z}^{2}$.

To describe the homotopy classes of split 2 -valued maps of $\mathbb{T}^{2}$, let us consider the set $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$ of homotopy classes of 2-ordered maps and the action of $\mathbb{Z}_{2}$ on this set that is induced by the action of $\mathbb{Z}_{2}$ on $F_{2}\left(\mathbb{T}^{2}\right)$. By Lemma $9(\mathrm{~b})$, the corresponding set of orbits $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] / \mathbb{Z}_{2}$ is in one-to-one correspondence with the set $\operatorname{Sp}\left(\mathbb{T}^{2}, \mathbb{T}^{2}, 2\right) / \sim$ of homotopy classes of split 2 -valued maps of $\mathbb{T}^{2}$. Given a homotopy class of a 2 -ordered map of $\mathbb{T}^{2}$, choose a based representative $f: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$. The based homotopy class of $f$ is determined by the element $f_{\#}$ of $\operatorname{Hom}\left(\mathbb{Z}^{2}, P_{2}\left(\mathbb{T}^{2}\right)\right)$. In turn, by Proposition 31 (a), $f_{\#}$ is determined by a pair of elements of $P_{2}\left(\mathbb{T}^{2}\right)$ of the form $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$, where $(a, b),(c, d)$ and $(r, s)$ belong to $\mathbb{Z}^{2}$, and $w \in \mathbb{F}_{2}$. To characterise the equivalence class of $f$ in $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] / \mathbb{Z}_{2}$, we first consider the set of conjugates of this pair by the elements of $P_{2}\left(\mathbb{T}^{2}\right)$, which by Proposition 29(b) describes the homotopy class of $f$ in $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$, and secondly, we take into account the $\mathbb{Z}_{2}$-action by conjugating by the elements of $B_{2}\left(\mathbb{T}^{2}\right)$. So the equivalence class of $f$ in $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] / \mathbb{Z}_{2}$ is characterised by the set of conjugates of the pair $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$ by elements of $B_{2}\left(\mathbb{T}^{2}\right)$. The presentation of $B_{2}\left(\mathbb{T}^{2}\right)$ given by Proposition 28 contains the action by conjugation of $\sigma$ on $P_{2}\left(\mathbb{T}^{2}\right)$. Consider the homomorphism involution of $\mathbb{F}_{2}(u, v)$ that is defined on the generators of $\mathbb{F}_{2}(u, v)$ by $u \longmapsto u^{-1}$ and $v \longmapsto v^{-1}$. The image of an element $w \in \mathbb{F}_{2}(u, v)$ by this automorphism will be denoted by $\widehat{w}$. With respect to the decomposition of $P_{2}\left(\mathbb{T}^{2}\right)$ given by Corollary 27 , let $\gamma: P_{2}\left(\mathbb{T}^{2}\right) \longrightarrow \mathbb{F}_{2}(u, v)$ denote the projection onto $\mathbb{F}_{2}(u, v)$. Let $\mathrm{Ab}: \mathbb{F}_{2}(u, v) \longrightarrow \mathbb{Z}^{2}$ denote the Abelianisation homomorphism that sends $u$ to $(1,0)$ and $v$ to $(0,1)$. We write $\operatorname{Ab}(w)=\left(|w|_{u},|w|_{v}\right)$, where $|w|_{u}$ (resp. $|w|_{v}$ ) denotes the exponent sum of $u$ (resp. $v$ ) in the word $w$, and $\ell(w)$ will denote the word length of $w$ with respect to $u$ and $v$. One may check easily that $(\widehat{w})^{-1}=\widehat{w^{-1}}$ and $\ell(w)=\ell(\widehat{w})$ for all $w \in \mathbb{F}_{2}(u, v)$. Note also that if
$\lambda \in \mathbb{F}_{2}(u, v)$ and $r \in \mathbb{Z}$ then:

$$
\begin{equation*}
\widehat{\lambda}(\lambda \widehat{\lambda})^{r} \lambda=\widehat{\lambda}(\lambda \widehat{\lambda})^{r} \widehat{\lambda}^{-1} \cdot \widehat{\lambda} \lambda=\left(\widehat{\lambda} \lambda \widehat{\lambda}^{-1}\right)^{r} \widehat{\lambda} \lambda=(\widehat{\lambda} \lambda)^{r+1} \tag{13}
\end{equation*}
$$

Lemma 32. For all $w \in \mathbb{F}_{2}(u, v), \widehat{w}=v u^{-1} \gamma\left(\sigma w \sigma^{-1}\right) u v^{-1}$ and

$$
\begin{equation*}
\sigma w \sigma^{-1}=\left(u v^{-1} \widehat{w} v u^{-1},\left(|w|_{u},|w|_{v}\right)\right) . \tag{14}
\end{equation*}
$$

In particular, $\widehat{w}$ is conjugate to $\gamma\left(\sigma w \sigma^{-1}\right)$ in $\mathbb{F}_{2}(u, v)$.
Proof. By Proposition 28, we have:

$$
\sigma u \sigma^{-1}=\left[u, v^{-1}\right] u^{-1} x=u v^{-1} \widehat{u} v u^{-1} x^{|u|_{u}} \text { and } \sigma v \sigma^{-1}=\left[u, v^{-1}\right] v^{-1} y=u v^{-1} \widehat{v} v u^{-1} y^{|v|_{v}} .
$$

If $w \in \mathbb{F}_{2}(u, v)$ then (14) follows because $x$ and $y$ belong to the centre of $P_{2}\left(\mathbb{T}^{2}\right)$. Thus $\gamma\left(\sigma w \sigma^{-1}\right)=u v^{-1} \widehat{w} v u^{-1}$ as required.

Lemma 33.
(a) Let $a, b \in \mathbb{F}_{2}(u, v)$ be such that $a b$ is written in reduced form. Then $a b=\widehat{b} \widehat{a}$ if and only if there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $r, s \in \mathbb{Z}$ such that:

$$
\begin{equation*}
a=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda} \text { and } b=(\lambda \widehat{\lambda})^{r} \lambda . \tag{15}
\end{equation*}
$$

(b) For all $w \in \mathbb{F}_{2}(u, v), w$ and $\widehat{w}$ are conjugate in $\mathbb{F}_{2}(u, v)$ if and only if there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $l \in \mathbb{Z}$ such that:

$$
\begin{equation*}
w=(\lambda \widehat{\lambda})^{l} \tag{16}
\end{equation*}
$$

Remark. By modifying the definition of the • homomorphism appropriately, Lemma 33 and its proof may be generalised to any free group of finite rank on a given set.

Proof of Lemma 33. We first prove the 'if' implications of (a) and (b). For part (a), let $a, b \in \mathbb{F}_{2}(u, v)$ be such that $a b$ is written in reduced form, and that (15) holds. Using (13), we have:

$$
a b=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}(\lambda \widehat{\lambda})^{r} \lambda=(\widehat{\lambda} \lambda)^{r+s+1}=(\widehat{\lambda} \lambda)^{r} \widehat{\lambda}(\lambda \widehat{\lambda})^{s} \lambda=\widehat{b} \widehat{a} .
$$

For part (b), if (16) holds then $\widehat{w}=(\widehat{\lambda} \lambda)^{l}=\widehat{\lambda}(\lambda \widehat{\lambda})^{l}(\widehat{\lambda})^{-1}=\widehat{\lambda} w \widehat{\lambda}^{-1}$ by (13), so $w$ and $\widehat{w}$ are conjugate in $\mathbb{F}_{2}(u, v)$.

Finally, we prove the 'only if' implications of (a) and (b) simultaneously by induction on the length $k$ of the words $a b$ and $w$, which we assume to be non trivial and written in reduced form. Let (E1) denote the equation $a b=\widehat{b} \widehat{a}$, and let (E2) denote the equation $\widehat{w}=\theta w \theta^{-1}$, where $\theta \in \mathbb{F}_{2}(u, v)$. Note that if $a$ and $b$ satisfy (E1) then both $a$ and $b$ are non trivial, and that $\widehat{b} \widehat{a}$ is also in reduced form. Further, if $z \in \mathbb{F}_{2}(u, v)$, then since $|z|_{y}=-|\widehat{z}|_{y}$ for $y \in\{u, v\}$, it follows from the form of (E1) and (E2) that $k$ must be even in both cases. We carry out the proof of the two implications by induction as follows.
(i) If $k \leq 4$ then (E1) implies (15). One may check easily that $k$ cannot be equal to 2. Suppose that $k=4$ and that (E1) holds. Now $\ell(a) \neq 1$, for otherwise $b$ would start with $a^{-1}$, but then $a b$ would not be reduced. Similarly, $\ell(b) \neq 1$, so we must have $\ell(a)=\ell(b)=2$, in which case $b=\widehat{a}$, and it suffices to take $r=s=0$ and $\lambda=b$ in (15).
(ii) If $k \leq 4$ then (E2) implies (16). Once more, it is straightforward to see that $k$ cannot be equal to 2 . Suppose that $k=4$. Since $w$ and $\widehat{w}$ are conjugate, we have $|w|_{y}=|\widehat{w}|_{y}$ for $y \in\{u, v\}$, and so $|w|_{y}=0$. Since $w$ is in reduced form, one may then check that (16) holds, where $\ell(\lambda)=2$.
(iii) Suppose by induction that for some $k \geq 4$, (E1) implies (15) if $\ell(a b)<k$ and (E2) implies (16) if $\ell(w)<k$. Suppose that $a$ and $b$ satisfy (E1) and that $\ell(a b)=k$. If $\ell(a)=\ell(b)$ then $b=\widehat{a}$, and as above, it suffices to take $r=s=0$ and $\lambda=b$ in (15). So assume that $\ell(a) \neq \ell(b)$. By applying the automorphism $\widehat{\cdot}$ and exchanging the rôles of $a$ and $b$ if necessary, we may suppose that $\ell(a)<\ell(b)$. We consider two subcases.
(A) $\ell(a) \leq \ell(b) / 2$ : since both sides of (E1) are in reduced form, $b$ starts and ends with $\widehat{a}$, and there exists $b_{1} \in \mathbb{F}_{2}(u, v)$ such that $b=\widehat{a} b_{1} \widehat{a}$, written in reduced form. Substituting this into (E1), we see that $a \widehat{a} b_{1} \widehat{a}=a \widehat{b_{1}} a \widehat{a}$, and thus $\widehat{a} b_{1}=\widehat{b}_{1} a$, written in reduced form. This equation is of the form (E1), and since $\ell\left(\widehat{a} b_{1}\right)<\ell(b)<\ell(a b)$, we may apply the induction hypothesis. Thus there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $r, s \in \mathbb{Z}$ such that $\widehat{a}=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}$, and $b_{1}=(\lambda \widehat{\lambda})^{r} \lambda$. Therefore $a=(\lambda \widehat{\lambda})^{s} \lambda$ and

$$
b=\widehat{a} b_{1} \widehat{a}=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}(\lambda \widehat{\lambda})^{r} \lambda(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}=(\widehat{\lambda} \lambda)^{2 s+r+1} \widehat{\lambda}
$$

using (13), which proves the result in this case.
(B) $\ell(b) / 2<\ell(a)<\ell(b)$ : since both sides of (E1) are in reduced form, $b$ starts with $\widehat{a}$, and there exists $b_{1} \in \mathbb{F}_{2}(u, v), b_{1} \neq 1$, such that $b=\widehat{a} b_{1}$. Substituting this into (E1), we obtain $a \widehat{a} b_{1}=a \widehat{b}_{1} \widehat{a}$, which is equivalent to $\widehat{a} b_{1} \widehat{a}^{-1}=\widehat{b}_{1}$. This equation is of the form (E2), and since $\ell\left(\widehat{b}_{1}\right)<\ell(b)<\ell(a b)=k$, we may apply the induction hypothesis. Thus there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $l \in \mathbb{Z}$ such that $b_{1}=(\lambda \widehat{\lambda})^{l}$. The fact that $b_{1} \neq 1$ implies that $\lambda \widehat{\lambda} \neq 1$ and $l \neq 0$. We claim that $\lambda \widehat{\lambda}$ may be chosen to be primitive. To prove the claim, suppose that $\lambda \hat{\lambda}$ is not primitive. Since $\mathbb{F}_{2}(u, v)$ is a free group of rank 2 , the centraliser of $\lambda \widehat{\lambda}$ in $\mathbb{F}_{2}(u, v)$ is infinite cyclic, generated by a primitive element $v$, and replacing $v$ by $v^{-1}$ if necessary, there exists $s \geq 2$ such that $v^{s}=\lambda \widehat{\lambda}$. Therefore $b_{1}=v^{s l}$, and substituting this into the relation $\widehat{b}_{1}=\widehat{a} b_{1} \widehat{a}^{-1}$, we obtain $\widehat{v}^{s l}=\widehat{a} v^{s l} \widehat{a}^{-1}=\left(\widehat{a} v \widehat{a}^{-1}\right)^{s l}$ in the free group $\mathbb{F}_{2}(u, v)$, from which we conclude that $\widehat{v}=\widehat{a} v \widehat{a}^{-1}$. We may thus apply the induction hypothesis to this relation because $\ell(v)<\ell\left(b_{1}\right)<k$, and since $v$ is primitive, there exists $\gamma \in \mathbb{F}_{2}(u, v)$ for which $v=\gamma \widehat{\gamma}$. Hence $b_{1}=(\gamma \widehat{\gamma})^{s l}$, where $\gamma \widehat{\gamma}$ is primitive, which proves the claim. Substituting $b_{1}=(\lambda \widehat{\lambda})^{l}$ into the relation $\widehat{a} b_{1} \widehat{a}^{-1}=\widehat{b}_{1}$, we obtain:

$$
\left(\widehat{a} \lambda \widehat{\lambda} \widehat{a}^{-1}\right)^{l}=\widehat{a}(\lambda \widehat{\lambda})^{l} \widehat{a}^{-1}=\widehat{(\lambda \hat{\lambda})^{l}}=(\widehat{\lambda} \lambda)^{l}
$$

where we take $\lambda \hat{\lambda}$ to be primitive. Once more, since $\mathbb{F}_{2}(u, v)$ is a free group of rank 2 and $l \neq 0$, it follows that $\widehat{a} \lambda \widehat{\lambda} \widehat{a}^{-1}=\widehat{\lambda} \lambda=\widehat{\lambda} \lambda \widehat{\lambda} \widehat{\lambda}^{-1}$, from which we conclude that $\widehat{\lambda}^{-1} \widehat{a}$ belongs to the centraliser of $\lambda \widehat{\lambda}$. But $\lambda \widehat{\lambda}$ is primitive, so there exists $t \in \mathbb{Z}$ such that $\widehat{\lambda}^{-1} \widehat{a}=(\lambda \widehat{\lambda})^{t}$, and hence $\widehat{a}=\widehat{\lambda}(\lambda \widehat{\lambda})^{t}$. Hence $a=\lambda(\widehat{\lambda} \lambda)^{t}=(\lambda \widehat{\lambda})^{t} \lambda$ and $b=\widehat{a} b_{1}=\widehat{\lambda}(\lambda \widehat{\lambda})^{t+l}=(\widehat{\lambda} \lambda)^{t+l} \widehat{\lambda}$ in a manner similar to that of (13), so (15) holds.
(iv) By the induction hypothesis and (iii), we may suppose that for some $k \geq 4$, (E1) implies (15) if $\ell(a b) \leq k$ and (E2) implies (16) if $\ell(w)<k$. Suppose that $\ell(w)=k$ and that $w$ and $\widehat{w}$ are conjugate. Let $\widehat{w}=\theta w \theta^{-1}$, where $\theta \in \mathbb{F}_{2}(u, v)$. If $\theta=1$ then $w=\widehat{w}$, which is impossible. So $\theta \neq 1$, and since $\ell(w)=\ell(\widehat{w})$, there must be cancellation in the expression $\theta w \theta^{-1}$. Taking the inverse of the relation $\widehat{w}=\theta w \theta^{-1}$ if necessary, we may
suppose that cancellation occurs between $\theta$ and $w$. So there exist $\theta_{1}, \theta_{2} \in \mathbb{F}_{2}(u, v)$ such that $\theta=\theta_{1} \theta_{2}$ written in reduced form, and such that the cancellation between $\theta$ and $w$ is maximal i.e. if $w_{1}=\theta_{2} w$ is written in reduced form then $\theta_{1} w_{1}$ is also reduced. Let $\ell(\theta)=n$ and $\ell\left(\theta_{2}\right)=r$. We again consider two subcases.
(A) Suppose first that $r=n$. Then $\theta_{1}=1, \theta_{2}=\theta$ and $w=\theta^{-1} w_{1}$, so:

$$
\begin{equation*}
\ell(w)=\ell\left(\theta^{-1} w_{1}\right) \leq \ell\left(\theta^{-1}\right)+\ell\left(w_{1}\right)=n+\ell(w)-n=\ell(w) \tag{17}
\end{equation*}
$$

Hence $\ell\left(\theta^{-1} w_{1}\right)=\ell\left(\theta^{-1}\right)+\ell\left(w_{1}\right)$, from which it follows that $w=\theta^{-1} w_{1}$ is written in reduced form. Therefore $\widehat{w}=\widehat{\theta}^{-1} \widehat{w}_{1}$ is also written in reduced form. Now $\widehat{w}=\theta w \theta^{-1}=$ $w_{1} \theta^{-1}$, and applying an inequality similar to that of (17), we see that $\widehat{w}=w_{1} \theta^{-1}$ is written in reduced form. Hence $\widehat{\theta}^{-1} \widehat{w}_{1}=w_{1} \theta^{-1}$, which is in the form of (E1), both sides being written in reduced form. Thus $\ell\left(w_{1} \theta^{-1}\right)=\ell\left(\theta^{-1} w_{1}\right)=\ell(w)=k$, and by the induction hypothesis, there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $r, s \in \mathbb{Z}$ such that $w_{1}=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}$ and $\theta^{-1}=(\lambda \widehat{\lambda})^{r} \lambda$. So by (13), $w=\theta^{-1} w_{1}=(\lambda \widehat{\lambda})^{r} \lambda(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}=(\lambda \widehat{\lambda})^{r+s+1}$, which proves the result in the case $r=n$.
(B) Now suppose that $r<n$. Then there must be cancellation on both sides of $w$. Taking the inverse of both sides of the equation $\widehat{w}=\theta w \theta^{-1}$ if necessary, we may suppose that the length of the cancellation on the left is less than or equal to that on the right. So there exist $\theta_{1}, \theta_{2}, \theta_{3}, w_{2} \in \mathbb{F}_{2}(u, v)$ such that $\theta=\theta_{1} \theta_{2} \theta_{3}, w=\theta_{3}^{-1} w_{2} \theta_{2} \theta_{3}$ and $\widehat{w}=\theta_{1} \theta_{2} w_{2} \theta_{1}^{-1}$, all these expressions being written in reduced form. Since $\ell(w)=\ell(\widehat{w})$, it follows from the second two expressions that $\ell\left(\theta_{1}\right)=\ell\left(\theta_{3}\right)$, and that $w=\theta_{3}^{-1} w_{2} \theta_{2} \theta_{3}=\widehat{\theta}_{1} \widehat{\theta}_{2} \widehat{w}_{2} \widehat{\theta}_{1}^{-1}$, written in reduced form, from which we conclude that $\widehat{\theta}_{1}=\theta_{3}^{-1}$, and that $w_{2} \theta_{2}=\widehat{\theta}_{2} \widehat{w}_{2}$, written in reduced form, which is in the form of (E1). Now $\ell\left(w_{2} \theta_{2}\right)<\ell(w)=k$, and applying the induction hypothesis, there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $r, s \in \mathbb{Z}$ such that $w_{2}=(\widehat{\lambda} \lambda)^{s} \widehat{\lambda}$ and $\theta_{2}=(\lambda \widehat{\lambda})^{r} \lambda$. Hence $w=\theta_{3}^{-1} w_{2} \theta_{2} \theta_{3}=\theta_{3}^{-1}(\widehat{\lambda} \lambda)^{r+s+1} \theta_{3}=\left(\theta_{3}^{-1} \widehat{\lambda} \widehat{\theta}_{3} \cdot \widehat{\theta}_{3}^{-1} \lambda \theta_{3}\right)^{r+s+1}=$ $(\gamma \widehat{\gamma})^{r+s+1}$, where $\gamma=\theta_{3}^{-1} \widehat{\lambda}_{3} \widehat{\theta}_{3}$. This completes the proof of the induction step, and hence that of the lemma.

## Proposition 34.

(a) Let $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ be a split 2-valued map, and let $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a lift of $\phi$ that is determined by the pair $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$ as described in Proposition 31. Let $\mathcal{O}_{\phi}$ denote the set of conjugates of this pair by elements of $B_{2}\left(\mathbb{T}^{2}\right)$. Then $\mathcal{O}_{\phi}$ is the union of the sets $\mathcal{O}_{\phi}^{(1)}$ and $\mathcal{O}_{\phi}^{(2)}$, where $\mathcal{O}_{\phi}^{(1)}$ is the subset of pairs of the form $\left(\left(w_{1}^{r},(a, b)\right),\left(w_{1}^{s},(c, d)\right)\right)$, where $w_{1}$ runs over the set of conjugates of $w$ in $\mathbb{F}_{2}(u, v)$, and $\mathcal{O}_{\phi}^{(2)}$ is the subset of pairs of the form $\left(\left(w_{2}^{r},\left(a+r|w|_{u}, b+r|w|_{v}\right)\right),\left(w_{2}^{s},\left(c+s|w|_{u}, d+s|w|_{v}\right)\right)\right)$, where $w_{2}$ runs over the set of conjugates of $\widehat{w}$ in $\mathbb{F}_{2}(u, v)$. Further, the correspondence that to $\phi$ associates $\mathcal{O}_{\phi}$ induces a bijection between the set of homotopy classes of split 2-valued maps and the set of conjugates of the pairs of the form given by Proposition 31(a) by elements of $B_{2}\left(\mathbb{T}^{2}\right)$.
(b) Let $f=\left(f_{1}, f_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a 2-ordered map of $\mathbb{T}^{2}$ determined by the pair $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$, let $g=\left(g_{1}, g_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$, and let $\widehat{\pi}:\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] \longrightarrow$ $\left[\mathbb{T}^{2}, D_{2}\left(\mathbb{T}^{2}\right)\right]$ be the projection defined in the proof of Lemma $9(b)$. Then $\widehat{\pi}^{-1}(\widehat{\pi}([f]))=$ $\{[f],[g]\}$. Further, $[f]=[g]$ if and only if there exist $\lambda \in \mathbb{F}_{2}(u, v)$ and $l \in \mathbb{Z}$ such that $w=(\lambda \widehat{\lambda})^{l}$.

Proof.
(a) To compute $\mathcal{O}_{\phi}$, we determine the conjugates of the pair $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$ by elements of $B_{2}\left(\mathbb{T}^{2}\right)$, namely by words of the form $\sigma^{\varepsilon} z$, where $\varepsilon \in\{0,1\}$, and $z \in$ $P_{2}\left(\mathbb{T}^{2}\right)$. With respect to the decomposition of Corollary 27, if $\varepsilon=0$, we obtain the elements of $\mathcal{O}_{\phi}^{(1)}$. If $\varepsilon=1$, using the computation for $\varepsilon=0$ and the fact that $\sigma z^{m} \sigma^{-1}=$ $\left(u v^{-1} \widehat{z}^{m} v u^{-1},\left(m|z|_{u}, m|z|_{v}\right)\right)$ for all $z \in \mathbb{F}_{2}(u, v)$ and $m \in \mathbb{Z}$ by Lemma 32, we obtain the elements of $\mathcal{O}_{\phi}^{(2)}$. This proves the first part of the statement. The second part is a consequence of classical general facts about maps between spaces of type $K(\pi, 1)$, see [Wh, Chapter V, Theorem 4.3] for example.
(b) Let $\alpha \in\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$ and let $f=\left(f_{1}, f_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be such that $f \in \alpha$. Taking $g=\left(f_{2}, f_{1}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$, under the projection $\widehat{\pi}:\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right] \longrightarrow\left[\mathbb{T}^{2}, D_{2}\left(\mathbb{T}^{2}\right)\right]$, $\widehat{\pi}(\beta)=\widehat{\pi}(\alpha)$, where $\beta=[g]$. From Section $2.1, \alpha$ and $\beta$ are the only elements of $\left[\mathbb{T}^{2}, F_{2}\left(\mathbb{T}^{2}\right)\right]$ that project under $\widehat{\pi}$ to $\widehat{\pi}(\alpha)$, which proves the first part. It remains to decide whether $\alpha=\beta$. Suppose that $f$ is determined by the pair $P_{1}=\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right)$. Since $\widehat{\pi}(\beta)=\widehat{\pi}(\alpha), g$ is determined by a pair belonging to $\mathcal{O}_{\phi}$. Using the fact that $g$ is obtained from $f$ via the $\mathbb{Z}_{2}$-action on $F_{2}\left(\mathbb{T}^{2}\right)^{\mathbb{T}^{2}}$ that arises from the covering map $\pi$ and applying covering space arguments, there exists $g^{\prime} \in \beta$ that is determined by the pair $P_{2}=\left(\left(\widehat{w}^{r},(a+\right.\right.$ $\left.\left.\left.r|w|_{u}, b+r|w|_{v}\right)\right),\left(\widehat{w}^{s},\left(c+s|w|_{u}, d+s|w|_{v}\right)\right)\right)$. Then $\alpha=\beta$ if and only if $P_{1}$ and $P_{2}$ are conjugate by an element of $P_{2}\left(\mathbb{T}^{2}\right)$, which is the case if and only if $w$ and $\widehat{w}$ are conjugate in the free group $\mathbb{F}_{2}(u, v)$ (recall from the proof of Lemma 33 that if $w$ and $\widehat{w}$ are conjugate then $|w|_{u}=|w|_{v}=0$ ). By part (a) of that lemma, this is equivalent to the existence of $\lambda \in \mathbb{F}_{2}(u, v)$ and $l \in \mathbb{Z}$ such that $w=(\lambda \widehat{\lambda})^{l}$.

### 5.3 Fixed point theory of split 2-valued maps

In this section, we give a sufficient condition for a split 2 -valued map of $\mathbb{T}^{2}$ to be deformable to a fixed point free 2-valued map. Proposition 30 already provides one such condition. We shall give an alternative condition in terms of roots, which seems to provide a more convenient framework from a computational point of view. To obtain fixed point free 2 -valued maps of $\mathbb{T}^{2}$, we have two possibilities at our disposal: we may either use Theorem $4(\mathrm{~b})$, in which case we should determine the group $P_{3}\left(\mathbb{T}^{2}\right)$, or Theorem $23(\mathrm{~b})$, in which case we may make use of the results of Section 5.1, and notably Proposition 25. We choose the second possibility. We divide the discussion into three parts. In Section 5.3.1, we prove Proposition 5. In Section 5.3.2, we give the analogue for roots of the second part of Proposition 5, and in Section 5.3.3, we will give some examples of split 2 -valued maps that may be deformed to root-free 2 -valued maps.

### 5.3.1 The proof of Proposition 5

Let $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ be a 2 -valued map of $\mathbb{T}^{2}$. As in Corollary 27 , we identify $P_{2}\left(\mathbb{T}^{2}\right)$ with $\mathbb{F}_{2} \times \mathbb{Z}^{2}$. The Abelianisation homomorphism is denoted by $\mathrm{Ab}: \mathbb{F}_{2}(u, v) \longrightarrow \mathbb{Z}^{2}$. Recall from the beginning of Section 2.1 that if $\phi$ is split and $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ is a lift of $\phi$, then $\operatorname{Fix}(\widehat{\Phi})=\operatorname{Fix}(\phi)$. In this section, we compute the Nielsen number $N(\phi)$ of $\phi$, and we give necessary conditions for $\phi$ to be homotopic to a fixed point free 2-valued map. Although the Nielsen number is not the main subject of this paper, it is an important invariant in fixed point theory. The Nielsen number of $n$-valued maps was defined in [Sch2]. The following result of that paper will enable us to compute $N(\phi)$ in our setting.

Theorem 35 ([Sch2, Corollary 7.2]). Let $n \in \mathbb{N}$, let $K$ be a compact polyhedron, and let $\phi=\left\{f_{1}, \ldots, f_{n}\right\}: K \multimap K$ be a split n-valued map. Then $N(\phi)=N\left(f_{1}\right)+\cdots+N\left(f_{n}\right)$.
Proof of Proposition 5. Let $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ be a split 2 -valued map of $\mathbb{T}^{2}$, and let $\widehat{\Phi}=$ $\left(f_{1}, f_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ be a lift of $\phi$ such that $\widehat{\Phi}_{\#}\left(e_{1}\right)=\left(w^{r},(a, b)\right)$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=$ $\left(w^{s},(c, d)\right)$ ), where $(r, s) \in \mathbb{Z}^{2} \backslash\{(0,0)\}, a, b, c, d \in \mathbb{Z}$ and $w \in \mathbb{F}_{2}(u, v)$. For $i=1,2$, we shall compute the matrix $M_{i}$ of the homomorphism $f_{i \#}: \mathbb{Z}^{2} \longrightarrow \mathbb{Z}^{2}$ induced by $f_{i}$ on the fundamental group of $\mathbb{T}^{2}$ with respect to the basis $\left(e_{1}, e_{2}\right)$ of $\pi_{1}\left(\mathbb{T}^{2}\right)$ (up to the canonical identification of $\pi_{1}\left(\mathbb{T}^{2}\right)$ for different basepoints if necessary). In practice, the bases in the target are the images of the elements $\left(\rho_{1,1}, \rho_{1,2}\right)$ and $\left(\rho_{2,1}, \rho_{2,2}\right)$ by the homomorphism $p_{i \#}: P_{2}\left(\mathbb{T}^{2}\right) \longrightarrow \pi_{1}\left(\mathbb{T}^{2}\right)$ induced by the projection $p_{i}: F_{2}\left(\mathbb{T}^{2}\right) \longrightarrow \mathbb{T}^{2}$ onto the $i^{\text {th }}$ coordinate, where $i=1,2$. Note that $f_{i \#}=p_{i \#} \circ \widehat{\Phi}_{\#}$. Setting $w=w(u, v)$, and using multiplicative notation and equation (8), we have:

\begin{aligned}
& \widehat{\Phi}_{\#}\left(e_{1}\right)=w^{r} x^{a} y^{b}=\left(w\left(\rho_{1,1}, \rho_{1,2}\right)\right)^{r}\left(\rho_{1,1} B_{1,2}^{-1} \rho_{2,1}\right)^{a}\left(\rho_{1,2} B_{1,2}^{-1} \rho_{2,2}\right)^{b} \\
& \widehat{\Phi}_{\#}\left(e_{2}\right)=w^{s} x^{c} y^{d}=\left(w\left(\rho_{1,1}, \rho_{1,2}\right)\right)^{s}\left(\rho_{1,1} B_{1,2}^{-1} \rho_{2,1}\right)^{c}\left(\rho_{1,2} B_{1,2}^{-1} \rho_{2,2}\right)^{d} .
\end{aligned}
$$

Projecting onto the first (resp. second) coordinate, it follows that $f_{1 \#}\left(e_{1}\right)=\rho_{1,1}^{r m+a} \rho_{1,2}^{r n+b}$ and $f_{1 \#}\left(e_{2}\right)=\rho_{1,1}^{s m+c} \rho_{1,2}^{s n+d}$ (resp. $f_{2 \#}\left(e_{1}\right)=\rho_{2,1}^{a} \rho_{2,2}^{b}$ and $\left.f_{2 \#}\left(e_{2}\right)=\rho_{2,1}^{c} \rho_{2,2}^{d}\right)$, so $M_{1}=$ $\left(\begin{array}{cc}r m+a & s m+c \\ r n+b & s n+d\end{array}\right)$ and $M_{2}=\left(\begin{array}{cc}a & c \\ b & d\end{array}\right)$. One then obtains the equation for $N(\phi)$ as a consequence of Theorem 35 and the usual formula for the Nielsen number of a self-map of $\mathbb{T}^{2}$ [BBPT]. The second part of the statement is clear, since if $\phi$ can be deformed to a fixed point free 2 -valued map then $f_{1}, f_{2}$ can both be deformed to fixed point free maps. To prove the last part, $f_{1}$ and $f_{2}$ can both be deformed to fixed point free maps if and only if $\operatorname{det}\left(M_{i}-I_{2}\right)=0$ for $i=1,2$, which using linear algebra is equivalent to:

\begin{gather*}
\operatorname{det}\left(M_{2}-I_{2}\right)=0, \text { and }  \tag{18}\\
\operatorname{det}\left(\begin{array}{cc}
a-1 & s m \\
b & s n
\end{array}\right)+\operatorname{det}\left(\begin{array}{cc}
r m & c \\
r n & d-1
\end{array}\right)=0 \tag{19}
\end{gather*}
$$

Equation (18) is equivalent to the proportionality of $(c, d-1)$ and $(a-1, b)$. Suppose that equation (19) holds. If one of the determinants in that equation is zero, then so is the other, and it follows that $(a-1, b),(c, d-1)$ and $(m, n)$ generate a subgroup of $\mathbb{Z}^{2}$ isomorphic to $\mathbb{Z}$, which yields condition (a) of the statement. If both of these determinants are non zero then $(m, n)$ is neither proportional to $(a-1, b)$ nor to $(c, d-1)$, and since $(c, d-1)$ and $(a-1, b)$ are proportional, $(m, n)$ is not proportional to any linear combination of the two. Further, (19) may be written as:

$$
0=s \operatorname{det}\left(\begin{array}{cc}
a-1 & m \\
b & n
\end{array}\right)+r \operatorname{det}\left(\begin{array}{cc}
m & c \\
n & d-1
\end{array}\right)=\operatorname{det}\left(\begin{array}{cc}
s(a-1)-r c & m \\
s b-r(d-1) & n
\end{array}\right),
$$

from which it follows that $s(a-1, b)=r(c, d-1)$, which is condition (b) of the statement. The converse is straightforward.

Remark. Within the framework of Proposition 5 , the fact that $f_{1}$ and $f_{2}$ can be deformed to fixed point free maps does not necessarily imply that there exists a deformation of the pair $\left(f_{1}, f_{2}\right)$, regarded as a map from $\mathbb{T}^{2}$ to $F_{2}\left(\mathbb{T}^{2}\right)$, to a pair $\left(f_{1}^{\prime}, f_{2}^{\prime}\right)$ where the maps $f_{1}^{\prime}$ and $f_{2}^{\prime}$ are fixed point free. To answer the question of whether the 2 -ordered map
$\left(f_{1}, f_{2}\right): \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ can be deformed or not to a fixed point free 2-ordered map under the hypothesis that each map can be deformed to a fixed point free map would be a major step in understanding the fixed point theory of $n$-valued maps, and would help in deciding whether the Wecken property holds or not for $\mathbb{T}^{2}$ for the class of split $n$-valued maps.

### 5.3.2 Deformations to root-free 2-valued maps

Recall from the introduction that a root of an $n$-valued map $\phi_{0}: X \multimap Y$, with respect to a basepoint $y_{0} \in Y$, is a point $x$ such that $y_{0} \in \phi_{0}(x)$. If $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ is an $n$-valued map then we may construct another $n$-valued map $\phi_{0}: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ as follows. If $x \in \mathbb{T}^{2}$ and $\phi(x)=\left\{x_{1}, \ldots, x_{n}\right\}$, then let $\phi_{0}(x)=\left\{x_{1} \cdot x^{-1}, \ldots, x_{n} . x^{-1}\right\}$. The correspondence that to $\phi$ associates $\phi_{0}$ is bijective. Moreover, if $\phi$ is split, so that $\phi=\left\{f_{1}, f_{2}, \ldots, f_{n}\right\}$, where the self-maps $f_{i}: \mathbb{T}^{2} \longrightarrow \mathbb{T}^{2}, i=1, \ldots, n$, are coincidence-free, then $\phi_{0}$ is also split, and is given by $\phi_{0}(x)=\left\{f_{1}(x) \cdot x^{-1}, \ldots, f_{n}(x) \cdot x^{-1}\right\}$ for all $x \in \mathbb{T}^{2}$. The restriction of the above-mentioned correspondence to the case where the $n$-valued maps are split is also a bijection. The following lemma implies that the question of deciding whether an $n$-valued map $\phi$ can be deformed to a fixed point free map is equivalent to deciding whether the associated map $\phi_{0}$ can be deformed to a root-free map. Let 1 denote the basepoint of $\mathbb{T}^{2}$.

Lemma 36. With the above notation, a point $x_{0} \in \mathbb{T}^{2}$ is a fixed point of an n-valued map $\phi$ of $\mathbb{T}^{2}$ if and only if it is a root of the $n$-valued map $\phi_{0}$ (i.e. $1 \in \phi\left(x_{0}\right)$ ). Further, $\phi$ may be deformed to an n-valued map $\phi^{\prime}$ such that $\phi^{\prime}$ has $k$ fixed points if and only if $\phi_{0}$ may be deformed to an n-valued map $\phi_{0}^{\prime}$ such that $\phi_{0}^{\prime}$ has $k$ roots.

Proof. Straightforward, and left to the reader.
The algebraic condition given by Theorem 23(b) is equivalent to the existence of a homomorphism $g_{\#}: \pi_{1}\left(\mathbb{T}^{2}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$ that factors through $P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$. The following result is the analogue for roots of the second part of Proposition 5.

Proposition 37. Let $g: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ be a split 2-valued map, and let $\widehat{g}=\left(g_{1}, g_{2}\right): \mathbb{T}^{2} \longrightarrow$ $F_{2}\left(\mathbb{T}^{2}\right)$ be a lift of $g$ such that $\widehat{g}_{\#}\left(e_{1}\right)=\left(w^{r},\left(a^{\prime}, b\right)\right)$ and $\widehat{g}_{\#}\left(e_{2}\right)=\left(w^{s},\left(c, d^{\prime}\right)\right) \in P_{2}\left(\mathbb{T}^{2}\right)$, where $(r, s) \in \mathbb{Z}^{2} \backslash\{(0,0)\}$, $a^{\prime}, b, c, d^{\prime} \in \mathbb{Z}, w \in \mathbb{F}_{2}(u, v)$ and $A b(w)=(m, n)$. If $g$ can be deformed to a root-free map, then each of the maps $g_{1}, g_{2}: \mathbb{T}^{2} \longrightarrow \mathbb{T}^{2}$ can be deformed to a root-free map. Further, $g_{1}$ and $g_{2}$ can both be deformed to root-free maps if and only if either:
(a) the pairs $\left(a^{\prime}, b\right),\left(c, d^{\prime}\right)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$, or
(b) $s\left(a^{\prime}, b\right)=r\left(c, d^{\prime}\right)$.

Proof. If $g$ can be deformed to a root-free map then clearly the maps $g_{1}, g_{2}: \mathbb{T}^{2} \longrightarrow \mathbb{T}^{2}$ can be deformed to root-free maps. For the second part of the statement, for $i=1,2$, consider the maps $f_{i}: \mathbb{T}^{2} \longrightarrow \mathbb{T}^{2}$, where $f_{i}(x)=g_{i}(x) . x$, and where $g_{1}$ and $g_{2}$ can both be deformed to root-free maps. Then $f_{1}$ and $f_{2}$ can be deformed to fixed point free maps, and the maps $f_{1}, f_{2}$ are determined by the elements $\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)$ of $P_{2}\left(\mathbb{T}^{2}\right)$, where $a=a^{\prime}+1$ and $d=d^{\prime}+1$. By Proposition 5, either the elements $(a-1, b),(c, d-1)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$, or $s(a-1, b)=r(c, d-1)$, which is the same as saying that either the elements $\left(a^{\prime}, b\right),\left(c, d^{\prime}\right)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$, or $s\left(a^{\prime}, b\right)=r\left(c, d^{\prime}\right)$, and the result follows.

### 5.3.3 Examples of split 2-valued maps that may be deformed to root-free 2-valued maps

We now give a family of examples of split 2 -valued maps of $\mathbb{T}^{2}$ that satisfy the necessary condition of Proposition 37 for such a map to be deformable to a root-free map. To do so, we exhibit a family of 2-ordered maps that we compose with the projection $\pi: F_{2}\left(\mathbb{T}^{2}\right) \longrightarrow$ $D_{2}\left(\mathbb{T}^{2}\right)$ to obtain a family of split 2 -valued maps. We begin by studying a 2-ordered map of $\mathbb{T}^{2}$ determined by a pair of braids of the form $\left(\left(w^{r},(a, b)\right),\left(w^{s},(c, d)\right)\right.$, where $s(a, b)=r(c, d)$ (we make use of the notation of Proposition 37).
Proposition 38. If $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ is a lift of a split 2-valued map $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ that satisfies $\widehat{\Phi}_{\#}\left(e_{1}\right)=\left(w^{r},(a, b)\right)$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=\left(w^{s},(c, d)\right)$, where $w \in \mathbb{F}_{2}(u, v), a, b, c, d \in \mathbb{Z}$ and $(r, s) \in \mathbb{Z}^{2} \backslash\{(0,0)\}$ satisfy $s(a, b)=r(c, d)$, then $\phi$ may be deformed to a root-free 2-valued map.
Proof. By hypothesis, the subgroup $\Gamma$ of $\mathbb{Z}^{2}$ generated by $(a, b)$ and $(c, d)$ is contained in a subgroup isomorphic to $\mathbb{Z}$. Let $\gamma$ be a generator of $\Gamma$. Suppose first that $r$ and $s$ are both non zero. Then we may take $\gamma=\left(a_{0}, b_{0}\right)=(\ell / r)(a, b)=(\ell / s)(c, d)$, where $\ell=\operatorname{gcd}(r, s)$, and the elements $\left(w^{r},(a, b)\right)$ and $\left(w^{s},(c, d)\right)$ belong to the subgroup of $P_{2}\left(\mathbb{T}^{2}\right)$ generated by $\left(w^{\ell},\left(a_{0}, b_{0}\right)\right)$. Let $z \in P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ be an element that projects to $\left(w^{\ell},\left(a_{0}, b_{0}\right)\right)$ under the homomorphism $\alpha: P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2}\right)$ induced by the inclusion $\mathbb{T}^{2} \backslash\{1\} \longrightarrow \mathbb{T}^{2}$. The map $\varphi: \pi_{1}\left(\mathbb{T}^{2}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ defined by $\varphi\left(e_{1}\right)=z^{r / \ell}$ and $\varphi\left(e_{2}\right)=z^{s / \ell}$ extends to a homomorphism, and is a lift of $\widehat{\Phi}_{\#}$. The result in this case follows by Theorem 23(b). Now suppose thar $r=0$ (resp. $s=0$ ). Then $(a, b)=(0,0)$ (resp. $(c, d)=(0,0))$ and $\left(w^{r},(a, b)\right)$ (resp. $\left(w^{s},(c, d)\right)$ ) is trivial in $P_{2}\left(\mathbb{T}^{2}\right)$. Let $z \in P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ be an element that projects to $\left(w^{s},(c, d)\right)$ (resp. to $\left.\left(w^{r},(a, b)\right)\right)$. Then we define $\varphi\left(e_{1}\right)=1$ and $\varphi\left(e_{2}\right)=z\left(\right.$ resp. $\varphi\left(e_{1}\right)=z$ and $\varphi\left(e_{2}\right)=1$ ), and once more the result follows.

Proof of Theorem 6. This follows directly from Proposition 38 and the relation between the fixed point and root problems described by Lemma 36.
Lemma 39. Let $k, l \in \mathbb{Z}$ and suppose that either $p \in\{0,1\}$ or $q \in\{0,1\}$. With the notation of Proposition 25, the elements $\left(x^{p} y^{q}\right)^{k}$ and $\left(u^{p} v^{q}\right)^{l}$ of $P_{2}\left(\mathbb{T}^{2} \backslash\{1\} ;\left(x_{1}, x_{2}\right)\right)$ commute.

Proof. We will make use of Proposition 25 and some of the relations obtained in its proof. If $p$ or $q$ is zero then the result follows easily. So it suffices to consider the two cases $p=1$ and $q=1$. By equation (9), for $\varepsilon \in\{1,-1\}$, we have $x^{\varepsilon} v x^{-\varepsilon}=u^{\varepsilon} v\left(u^{-1} B_{1,2}\right)^{\varepsilon}$ and $y^{\varepsilon} u y^{-\varepsilon}=\left(v B_{1,2}^{-1}\right)^{\varepsilon} u v^{-\varepsilon}$, and by induction on $r$, it follows that $x^{r} v x^{-r}=u^{r} v\left(u^{-1} B_{1,2}\right)^{r}$ and $y^{r} u y^{-r}=\left(v B_{1,2}^{-1}\right)^{r} u v^{-r}$ for all $r \in \mathbb{Z}$. So if $p=1$ or $q=1$ then we have respectively:

$$
\begin{aligned}
& x y^{q} u v^{q} y^{-q} x^{-1}=x\left(v B_{1,2}^{-1}\right)^{q} u v^{-q} \cdot v^{q} x^{-1}=u v^{q} u^{-1} u=u v^{q}, \text { and } \\
& x^{p} y u^{p} v y^{-1} x^{-p}=x^{p}\left(y v y^{-1}\right)^{p} v x^{-p}=x^{p} v\left(B_{1,2}^{-1} u\right)^{p} v^{-1} \cdot v x^{-p}=u^{p} v\left(u^{-1} B_{1,2}\right)^{p}\left(B_{1,2}^{-1} u\right)^{p}=u^{p} v,
\end{aligned}
$$

as required.
This enables us to prove the following proposition and Theorem 7.
Proposition 40. Suppose that $(a, b),(c, d)$ and $(m, n)$ belong to a cyclic subgroup of $\mathbb{Z}^{2}$ generated by an element of the form $(0, q),(1, q),(p, 0)$ or $(p, 1)$, where $p, q \in \mathbb{Z}$, and let $r, s \in \mathbb{Z}$. Then there exist $w \in \mathbb{F}_{2}(u, v)$, a split 2-valued map $\phi: \mathbb{T}^{2} \multimap \mathbb{T}^{2}$ and a lift $\widehat{\Phi}: \mathbb{T}^{2} \longrightarrow F_{2}\left(\mathbb{T}^{2}\right)$ of $\phi$ for which $A b(w)=(m, n), \widehat{\Phi}_{\#}\left(e_{1}\right)=\left(\left(w^{r},(a, b)\right)\right.$ and $\widehat{\Phi}_{\#}\left(e_{2}\right)=$ $\left(w^{s},(c, d)\right)$, and such that $\phi$ can be deformed to a root-free 2-valued map.

Proof. Once more we apply Theorem $23(\mathrm{~b})$. Let $(p, q)$ be a generator of the cyclic subgroup given in the statement. So there exist $\lambda_{1}, \lambda_{2}, \lambda_{3} \in \mathbb{Z}$ such that $(a, b)=\lambda_{1}(p, q)$, $(c, d)=\lambda_{2}(p, q)$ and $(m, n)=\lambda_{3}(p, q)$. We define $\varphi: \pi_{1}\left(\mathbb{T}^{2}\right) \longrightarrow P_{2}\left(\mathbb{T}^{2} \backslash\{1\}\right)$ by $\varphi\left(e_{1}\right)=\left(u^{p} v^{q}\right)^{\lambda_{3} r}\left(x^{p} y^{q}\right)^{\lambda_{1}}$ and $\varphi\left(e_{2}\right)=\left(u^{p} v^{q}\right)^{\lambda_{3} s}\left(x^{p} y^{q}\right)^{\lambda_{2}}$. Lemma 39 implies that $\varphi$ extends to a well-defined homomorphism, and we may take $w=\left(u^{p} v^{q}\right)^{\lambda_{3}}$.

Proof of Theorem 7. This follows directly from Proposition 40 and the relation between the fixed point and root problems described in Lemma 36.

REmark. Theorem 7 implies that there is an infinite family of homotopy classes of 2valued maps of $\mathbb{T}^{2}$ that satisfy the necessary condition of Proposition 37(a), and can be deformed to root-free maps. We do not know whether there exist examples of maps that satisfy this condition but that cannot be deformed to root-free, however it is likely that such examples exist.

## Appendix: Equivalence between $n$-valued maps and maps into configuration spaces

This appendix constitutes joint work with R. F. Brown. Let $n \in \mathbb{N}$. As observed in Section 1, the set of $n$-valued functions from $X$ to $Y$ is in one-to-one correspondence with the set of functions from $X$ to $D_{n}(Y)$. As we have seen in the main part of this paper, this correspondence facilitates the study of $n$-valued maps, and more specifically of their fixed point theory. In this appendix, we prove Theorem 8 that clarifies the topological relationship preserved by the correspondence under some mild hypotheses on $X$ and $Y$. For the sake of completeness, we will include the proof of a simple fact (Proposition 42) mentioned in [Sch1] that relates the splitting of maps and the continuity of multifunctions.

Given a metric space $Y$, let $\mathcal{K}^{\prime}$ be the family of non-empty compact sets of $Y$. We equip $\mathcal{K}^{\prime}$ with the topology induced by the Hausdorff metric on $\mathcal{K}^{\prime}$ defined in [Ber, Chapter VI, Section 6].

Theorem 41 ([Ber, Chapter VI, Section 6, Theorem 1]). Let $X$ and $Y$ be metric spaces, let $\mathcal{K}^{\prime}$ denote the family of non-empty compact sets of $Y$, let $\Gamma: X \multimap Y$ be a multifunction such that for all $x \in X, \Gamma(x) \in \mathcal{K}^{\prime}$ and $\Gamma(x) \neq \varnothing$. Then $\Gamma$ is continuous if and only if it is a single-valued continuous mapping from $X$ to $\mathcal{K}^{\prime}$.

As we mentioned in Section 1, $F_{n}(Y)$ may be equipped with the topology induced by the inclusion of $F_{n}(Y)$ in $Y^{n}$, and $D_{n}(Y)$ may be equipped with the quotient topology using the quotient $\operatorname{map} \pi: F_{n}(Y) \longrightarrow D_{n}(Y)$, a subset $W$ of $D_{n}(Y)$ being open if and only if $\pi^{-1}(W)$ is open in $F_{n}(Y)$. If $Y$ is a metric space with metric $d$, the set $D_{n}(Y)$ is a subset of $\mathcal{K}^{\prime}$, and the Hausdorff metric on $\mathcal{K}^{\prime}$ mentioned above restricts to a Hausdorff metric $d_{H}$ on $D_{n}(Y)$ defined as follows. If $z, w \in D_{n}(Y)$ then there exist $\left(z_{1}, \ldots, z_{n}\right),\left(w_{1}, \ldots, w_{n}\right) \in F_{n}(Y)$ such that $z=\pi\left(z_{1}, \ldots, z_{n}\right)$ and $w=\pi\left(w_{1}, \ldots, w_{n}\right)$, and we define $d_{H}$ by:

$$
d_{H}(z, w)=\max \left(\max _{1 \leq i \leq n} d\left(z_{i}, w\right), \max _{1 \leq i \leq n} d\left(w_{i}, z\right)\right)
$$

where $d\left(z_{i}, w\right)=\min _{1 \leq j \leq n} d\left(z_{i}, w_{j}\right)$ for all $1 \leq i \leq n$. Notice that $d_{H}(z, w)$ does not depend on the choice of representatives in $F_{n}(Y)$. We now prove Theorem 8.

Proof of Theorem 8. By Theorem 41, it suffices to show that the set $D_{n}(Y)$ equipped with the Hausdorff metric $d_{H}$ is homeomorphic to the unordered configuration space $D_{n}(Y)$ equipped with the quotient topology, or equivalently, to show that a subset of $D_{n}(Y)$ is open with respect to the Hausdorff metric topology if and only if it is open with respect to the quotient topology. Let $y \in D_{n}(Y)$, and let $\left(y_{1}, \ldots, y_{n}\right) \in F_{n}(Y)$ be such that $\pi\left(y_{1}, \ldots, y_{n}\right)=y$.

For the 'if' part, let $U_{1}, \ldots, U_{n}$ be open balls in $Y$ whose centres are $y_{1}, \ldots, y_{n}$ respectively. Without loss of generality, we may assume that they have the same radius $\varepsilon>0$, and are pairwise disjoint. Consider the Hausdorff ball $U_{H}$ of radius $\varepsilon$ in $D_{n}(Y)$ whose centre is $y$. Let $z$ be an element of $U_{H}$, and let $\left(z_{1}, \ldots, z_{n}\right) \in F_{n}(Y)$ be such that $\pi\left(z_{1}, \ldots, z_{n}\right)=z$. Suppose that $z \notin \pi\left(U_{1} \times \cdots \times U_{n}\right)$. We argue for a contradiction. Then there exists a ball $U_{i}$ such that $z_{j} \notin U_{i}$ for all $j \in\{1, \ldots, n\}$. So $d\left(y_{i}, z\right) \geq \varepsilon$, and from the definition of $d_{H}$, it follows that $d_{H}(y, z) \geq \varepsilon$, which contradicts the choice of $z$. Hence $z \in \pi\left(U_{1} \times \cdots \times U_{n}\right)$, and the 'if' part follows.

For the 'only if' part, let us consider an open ball $U_{H}$ of radius $\varepsilon>0$ in the Hausdorff metric $d_{H}$ whose centre is $y$. We will show that there are open balls $U_{1}, \ldots, U_{n}$ in $Y$ whose centres are $y_{1}, \ldots, y_{n}$ respectively, such that the subset of elements $z$ of $D_{n}(Y)$, where $z=\pi\left(z_{1}, \ldots, z_{n}\right)$ for some $\left(z_{1}, \ldots, z_{n}\right) \in F_{n}(Y)$, and where each $U_{i}$ contains exactly one point of $\left\{z_{1}, \ldots, z_{n}\right\}$, is a subset of $U_{H}$. Define $\delta>0$ to be the minimum of $\varepsilon$ and the distances $d\left(y_{i}, y_{j}\right) / 2$ for all $i \neq j$. For $j=1, \ldots, n$ let $U_{j}$ be the open ball in $Y$ of radius $\delta$ with respect to $d$ and whose centre is $y_{j}$. Clearly, $U_{i} \cap U_{j}=\varnothing$ for all $i \neq j$. So for all $z=\left\{z_{1}, \ldots, z_{n}\right\}$ belonging to the set $\pi\left(U_{1} \times \cdots \times U_{n}\right)$, each $U_{j}$ contains exactly one point of $\left\{z_{1}, \ldots, z_{n}\right\}$, which up to permuting indices, we may suppose to be $z_{j}$. Further, for all $j=1, \ldots, n, d\left(z_{j}, y\right)=d\left(z_{j}, y_{j}\right)<\delta$ and $d\left(y_{j}, z\right)=d\left(y_{j}, z_{j}\right)<\delta$. So from the definition of $d_{H}, d_{H}(y, z)<\delta<\varepsilon$, hence $z \in U_{H}$, and the 'only if' part follows.

Just above Lemma 1 of [Sch1, Section 2], Schirmer wrote 'Clearly a multifunction which splits into maps is continuous'. For the sake of completeness, we provide a short proof of this fact.

Proposition 42. Let $n \in \mathbb{N}$, let $X$ be a topological space, and let $Y$ be a Hausdorff topological space. For $i=1, \ldots, n$, let $f_{i}: X \longrightarrow Y$ be continuous. Then the split $n$ valued map $\phi=\left\{f_{1}, \ldots, f_{n}\right\}: X \multimap Y$ is continuous.

Proof. Let $x_{0} \in X$, and let $V$ be an open subset of $Y$ such that $\phi\left(x_{0}\right) \cap V \neq \varnothing$. Then there exists $j \in\{1, \ldots, n\}$ such that $f_{j}\left(x_{0}\right) \in V$. Since $f_{j}$ is continuous, there exists an open subset $U_{j}$ containing $x_{0}$ such that if $x \in U_{j}$ then $f_{j}(x) \in V$, so $\phi(x) \cap V \neq \varnothing$. Therefore $\phi$ is lower semi-continuous. To prove upper semi-continuity, first note that for all $x \in X$, $\phi(x)$ is closed in $Y$ because $\phi(x)$ is a finite set and $Y$ is Hausdorff. Now let $x_{0} \in X$ be such that $\phi\left(x_{0}\right) \subset V$. We then use the continuity of the $f_{j}$ to define the $U_{j}$ as before, and we set $U=\bigcap_{j=1}^{n} U_{j}$. Since $\phi(U) \subset V$, we have proved that $\phi$ is also upper semi-continuous, and so it is continuous.
