On large deviation probabilities for empirical distribution of branching random walks: Schröder case and Böttcher case

Abstract: Given a super-critical branching random walk on  $\mathbb{R}$  started from the origin, let  $Z_n(\cdot)$  be the counting measure which counts the number of individuals at the *n*-th generation located in a given set. Under some mild conditions, it is known in [5] that for any interval  $A \subset \mathbb{R}$ ,  $\frac{Z_n(\sqrt{n}A)}{Z_n(\mathbb{R})}$  converges a.s. to  $\nu(A)$ , where  $\nu$  is the standard Gaussian measure. In this work, we investigate the convergence rates of

$$\mathbb{P}\left(\frac{Z_n(\sqrt{n}A)}{Z_n(\mathbb{R})} - \nu(A) > \Delta\right),\,$$

for  $\Delta \in (0, 1 - \nu(A))$ , in both Schröder case and Böttcher case.

### 1 Introduction and Main results

### 1.1 Branching random walk and its empirical distribution

Branching random walk, as an interesting object in probability theory, has been widely considered and well studied these years. The recent developments can be referred to Hu-Shi [15], Shi [26]. On the other hand, this object is closely related to many other random models, for example, multiplicative cascades, random fractals and random walk in random environment (see e.g. Hu-Shi [14, 16], Liu [19, 20]).

Generally speaking, in a branching random walk, the point processes independently produced by the particles, formulated by the number of children and their displacements, all follow the so-called reproduction law. However, in this work, we consider a simpler model by assuming that the number of children and the motions are independent. Let us construct it in the following way.

We take a Galton-Watson tree  $\mathcal{T}$ , rooted at  $\rho$ , with offspring distribution  $\{p_k; k \geq 0\}$ . For any  $u, v \in \mathcal{T}$ , we write  $u \leq v$  if u is an ancestor of v or u = v. Moreover, to each node  $v \in \mathcal{T} \setminus \{\rho\}$ , we attach a real-valued random variable  $X_v$  and define its position by

$$S_v := \sum_{\rho \prec u \leq v} X_u.$$

Let  $S_{\rho} := 0$  for convenience. Suppose that given the tree  $\mathcal{T}$ ,  $\{X_v; v \in \mathcal{T} \setminus \{\rho\}\}$  are i.i.d. copies of some random variable X (which is called step size). Thus,  $\{S_u; u \in \mathcal{T}\}$  is a branching random

walk. For any  $n \in \mathbb{N}$ , we introduce the following counting measure

$$Z_n(\cdot) = \sum_{|v|=n, v \in \mathcal{T}} 1_{\{S_v \in \cdot\}},$$

where |v| denotes the generation of node v, i.e., the graph distance between v and  $\rho$ . Apparently,  $Z_0 = \delta_0$ .

In this article, we always suppose that  $p_0=0, p_1<1$ . Note immediately that  $\{Z_n(\mathbb{R}); n\geq 0\}$  is a supercritical Galton-Watson process with mean  $m:=\sum_{k\geq 1} kp_k>1$ . Assume that  $m<\infty$ . It is well known that the martingale

 $W_n := \frac{Z_n(\mathbb{R})}{m^n}$ 

converges almost surely to some non-degenerate limit W if and only if  $\sum k \log k p_k < \infty$  (see e.g. [4]). Naturally, a central limit theorem on  $Z_n(\cdot)$ , was conjectured by Harris [12] and was proved by Asmussen-Kaplan [2], then was extended by Klebaner [18] and Biggins [5]. It says that if the step size X has zero mean and finite variance  $\sigma^2$ , for  $A \in \mathcal{A}_0 := \{(-\infty, x]; x \in \mathbb{R}\}$ ,

$$\lim_{n \to \infty} \frac{Z_n(\sqrt{n\sigma^2}A)}{m^n} = \nu(A)W, \quad a.s.$$
 (1.1)

where  $\nu$  is the standard Gaussian measure on  $\mathbb{R}$ . Let  $\bar{Z}_n(\cdot) := \frac{Z_n(\cdot)}{Z_n(\mathbb{R})}$  be the corresponding empirical distribution. Then,

$$\lim_{n \to \infty} \bar{Z}_n(\sqrt{n\sigma^2}A) = \nu(A), \quad a.s.$$
 (1.2)

What interests us is the convergence rates of (1.1) and (1.2).

In the literature, Asmussen and Kaplan [2] proved that if  $x_n = (\sigma \sqrt{n})x + o(\sqrt{n})$  with  $x \in \mathbb{R}$ , then

$$\lim_{n \to \infty} \mathbb{E}\left(\left(m^{-n} Z_n((-\infty, x_n]) - \nu((-\infty, x])W\right)^2\right) = 0.$$

Recently, Chen [6], under some regular assumptions, proved that as  $n \to \infty$ ,

$$\frac{Z_n(\sqrt{n\sigma^2}A)}{m^n} - \nu(A)W = \frac{1}{\sqrt{n}}\xi(A) + o(\frac{1}{\sqrt{n}}), \text{ a.s.}$$
 (1.3)

where  $\xi(A)$  is some explicitly defined random variable. Later, Gao and Liu [10] generalized this convergence for a branching random walk in some random environment. They also, in [11], obtained the second and third orders in this asymptotic expansion. In particular, if  $A = \mathbb{R}$ , one can refer to [13] and [3] for convergence rate of  $W_n$  to W. Furthermore, by taking A a singleton, the local version of this convergence has been investigated by Révész [25], Chen [6] and Gao [9], even in higher dimensions.

In this paper, we aim at understanding the so-called large deviation behaviour of the convergence (1.2), by considering the decaying rate of the following probability

$$\mathbb{P}\left(\bar{Z}_n(\sqrt{n\sigma^2}A) - \nu(A) \ge \Delta\right),\tag{1.4}$$

with  $\Delta > 0$  a small constant.

In fact, this problem has been investigated by Louidor and Perkins [21] by assuming that  $p_0 = p_1 = 0$  (Böttcher case) and that X is simple random walk's step. Recently, Louidor and Tsairi [22] extend this result to the Böttcher case with bounded step size by allowing dependence between the motions of children and their numbers. However, if X is not bounded, its tail distribution will be involved in the arguments and many regimes will appear in the asymptotic behaviours of (1.4).

In what follows, we will consider (1.4) in the Böttcher case by assuming that the step size X has either Weibull tail distribution or Gumbel tail distribution. Also, we will study this problem in the Schöder case where  $p_1 > 0 = p_0$ .

### 1.2 Main results

In the following of this paper, we always assume that,

$$\mathbb{E}(e^{\theta Z_1(\mathbb{R})}) = \sum_{k>0} p_k e^{\theta k} < \infty, \quad \text{for some } \theta > 0, \tag{1.5}$$

and that

$$X$$
 is symmetric, with  $E[X^2] = \sigma^2 = 1.$  (1.6)

Remark 1.1. The assumption of symmetry of X is not necessary, but simplifies the proof. As long as  $\Lambda(\cdot)$ , defined in (1.9) below, is finite on an open interval including 0, our arguments work. The exact value of  $E[X^2]$  does not play crucial role in our arguments either, but simplifies notion. We only need that X satisfies the classic central limit theorem.

Before stating our main results, we first introduce some notations. Let  $\mathcal{A}$  be the algebra generated by  $\{(-\infty, x], x \in \mathbb{R}\}$ . For  $p \in (\nu(A), 1)$  with  $A \in \mathcal{A} \setminus \emptyset$  such that  $\nu(A) > 0$ , define

$$I_A(p) = \inf\{|x| : \nu(A - x) \ge p\};$$
 (1.7)

$$J_A(p) = \inf \left\{ y : \sup_{x \in \mathbb{R}} \nu((A - x) / \sqrt{1 - y}) \ge p, \ y \in [0, 1] \right\}.$$
 (1.8)

We say that X fulfills Cramér's condition if  $E[e^{\kappa X}] < \infty$ , for some  $\kappa > 0$ . In this case, we can define the so-called logarithmic moment generating function and its inverse: for any  $t \in \mathbb{R}$  and  $s \in \mathbb{R}_+$ ,

$$\Lambda(t) =: \log E[e^{tX}] \in [0, \infty] \quad \text{and} \quad \Lambda^{-1}(s) := \inf\{t > 0 : \Lambda(t) \ge s\}, \tag{1.9}$$

with the convention that  $\inf \emptyset = \sup\{t > 0 : \Lambda(t) < \infty\}.$ 

**Theorem 1.1** (Schröder case). Assume that  $p_1 > p_0 = 0$  and X fulfills Cramér's condition. For  $p \in (\nu(A), 1)$ , if  $I_A(p) < \infty$  and  $I_A(p)$  is continuous at p, then

$$\lim_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = -\Lambda^{-1}(\log \frac{1}{p_1})I_A(p).$$

**Remark 1.2.** If we replace Cramér's condition in above theorem by  $\mathbb{P}(X > z) = \Theta(1)e^{-\lambda z^{\alpha}}$  as  $z \to \infty$  with  $\lambda > 0$  and  $0 < \alpha < 1$ , then using same idea of proving (1.10) below, we may have

$$\lim_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = -\lambda I_A(p)^{\alpha}.$$

**Theorem 1.2** (Schröder case). Assume that  $p_1 > p_0 = 0$ . For  $p \in (\nu(A), 1)$ , if  $I_A(p) = \infty$  and  $J_A(p)$  is continuous at p, then

$$\lim_{n \to \infty} \frac{1}{n} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = (\log p_1) J_A(p).$$

The next theorems concern the Böttcher case where  $p_0 = p_1 = 0$ . If  $I_A(p+) = I_A(p) < \infty$ , the decaying rate of (1.4) depends on the tail distribution of X, and also on the tree structure. In the following two theorems, we study two typical tail distributions of step size X: Weibull tail and Gumbel tail. Besides, we introduce

$$b := \min\{k \ge 1 : p_k > 0\}$$
 and  $B := \sup\{k \ge 1 : p_k > 0\} \in [b, \infty].$ 

**Theorem 1.3** (Böttcher case, Weibull tail). Assume that  $p_0 = p_1 = 0$ . Suppose  $\mathbb{P}(X > z) = \Theta(1)e^{-\lambda z^{\alpha}}$  as  $z \to \infty$  for some constant  $\alpha > 0$  and  $\lambda > 0$ . Take  $p \in (\nu(A), 1)$  such that  $I_A(p) < \infty$  and  $I_A(p)$  is continuous at p.

1. If  $\alpha \leq 1$  and B > b, then

$$\lim_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = -\lambda I_A(p)^{\alpha}. \tag{1.10}$$

2. If  $\alpha > 1$  and B > b, then

$$\lim_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = -\left(\frac{2\log b \log B}{\alpha(\log B - \log b)}\right)^{\alpha - 1} \lambda I_A(p)^{\alpha}. \tag{1.11}$$

3. If B = b, then there exist  $C_{\alpha} > c_{\alpha} > 0$  such that

$$-C_{\alpha} \leq \liminf_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) \geq p\right) \leq \limsup_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) \geq p\right) \leq -c_{\alpha}.$$

$$(1.12)$$

**Theorem 1.4** (Böttcher case, Gumbel tail). Assume that  $p_0 = p_1 = 0$ . Suppose  $\mathbb{P}(X > z) = \Theta(1)e^{-e^{z^{\alpha}}}$  as  $z \to \infty$  for some constant  $\alpha > 0$ . For  $p \in (\nu(A), 1)$  such that  $I_A(p) < \infty$  and  $I_A(p)$  is continuous at p, we have

$$\lim_{n \to \infty} n^{-\frac{\alpha}{2(\alpha+1)}} \log \left[ -\log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \right] = (y_{\alpha}I_A(p)\log b)^{\frac{\alpha}{\alpha+1}}, \tag{1.13}$$

where  $y_{\alpha} := \frac{(1+\alpha)\log B}{(1+\alpha)\log B - \log b}$ .

**Remark 1.3.** To obtain the exact decaying rates, we take advantage of the randomness of the embedding tree in the arguments. However, if we consider a regular tree (B = b) and motions with Weibull tail, such idea does not work any more and the situation becomes more delicate. We believe that in this case, there is a close link between the decaying rate and the a.s. convergence (1.3).

To accomplish this work, we also state the result when X is bounded, which is obtained by Louidor and Tsairi in [22].

**Theorem 1.5** (Böttcher case, Theorem 1.2 of [22]). Assume that  $p_0 = p_1 = 0$ . If ess sup X = L for some  $0 < L < \infty$ , for  $p \in (\nu(A), 1)$  such that  $I_A(p) < \infty$  and  $I_A(p)$  is continuous at p, we have

$$\lim_{n \to \infty} \frac{1}{n^{1/2}} \log \left[ -\log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p \right) \right] = \frac{I_A(p) \log b}{L}. \tag{1.14}$$

The following result is universal, regardless of the tail distribution of X, when  $I_A(p) = \infty$ .

**Theorem 1.6** (Böttcher case, Theorem 1.2 of [22]). Assume that  $p_0 = p_1 = 0$ . For  $p \in (\nu(A), 1)$  such that  $I_A(p) = \infty$  and  $J_A(p)$  is continuous at p, we have

$$\lim_{n \to \infty} \frac{1}{n} \log \left[ -\log \mathbb{P}\left( \bar{Z}_n(\sqrt{n}A) \ge p \right) \right] = J_A(p) \log b.$$

At the end of this section, let us say a couple of words on strategy of proofs, which is partially inspired by that of Loudior and Perkins. To have  $\{\bar{Z}_n(\sqrt{n}A) \geq p\}$ , we take an intermediate generation  $t_n$  and suppose that most individuals at this generation are positioned around  $x\sqrt{n}$ , so that finally  $\bar{Z}_n(\sqrt{n}A) \approx \nu_{n-t_n}(\sqrt{n}(A-x)) \approx \nu(\frac{n}{n-t_n}(A-x)) \gtrsim p$ . This brings out the definitions of  $I_A(p)$  and  $J_A(p)$ . If  $I_A(p) < \infty$ , we take  $t_n = o(n)$ ; otherwise, we take  $t_n = \Theta(n)$ . Moreover, the effort made up to generation  $t_n$  depends not only on branching but also on motions, which brings out the different treatments in different regimes.

The rest of this paper is organised as follows. In Sect. 2, we present some basic facts on random walks and branching random walks which will be used frequently in our proofs of main results. We study the Schröder case in Sect. 3, where Theorems 1.1 and 1.2 are proved. In Sect. 4, Böttcher case is treated. Theorems 1.3 and 1.4 will be proved. Let  $C_1, C_2, \cdots$  and  $c_1, c_2, \cdots$  denote positive constants which might change from line to line. As usual,  $f_n = O(g_n)$  or  $f_n = O(1)g_n$  mean that  $f_n \leq Cg_n$  for some C > 0 and all  $n \geq 1$ .  $f_n = O(1)g_n$  means that  $f_n$  is bounded both above and below by  $g_n$  asymptotically.  $f_n = o(g_n)$  or  $f_n = o_n(1)g_n$  mean that  $\lim_{n \to \infty} \frac{f_n}{g_n} = 0$ .

# 2 Preliminary results

In this section, we present some well-known facts and useful lemmas, which will be applied frequently in the next sections. Denote by  $\nu_n := \underbrace{\mathbb{P}_X * \cdots * \mathbb{P}_X}$ , the distribution of a X-random walk

at the *n*-th step. Recall that  $\nu$  represents the standard normal distribution on the real line. The following lemma states some basic facts about  $\nu$  and  $\nu_n$ .

**Lemma 2.1.** Let  $A \in \mathcal{A} \setminus \emptyset$  and  $p \in (0,1)$ .

- 1. The mapping  $(a,b) \mapsto \nu(aA+b) \in C^{\infty}(\mathbb{R}^2)$ . Moreover, it is Lipschitz on b and is uniformly continuous on  $K \times \mathbb{R}$  for any compact set K.
- 2. If  $0 < I_A(p) < \infty$ , then there exists  $x \in \mathbb{R}$  with  $|x| = I_A(p)$  such that  $\nu(A x) \ge p$ .
- 3.  $0 \le J_A(p) < 1$  and there exists  $x \in \mathbb{R}$  and  $r \in (0,1)$  with  $r = J_A(p)$  such that  $\nu((A-x)/\sqrt{1-r}) \ge p$ .
- 4. If  $p > \nu(A)$ , then either  $0 < I_A(p) < \infty$  or  $I_A(p) = \infty$ ,  $J_A(p) \in (0,1)$ .
- 5. (i) Let  $A_{\varepsilon}^- := \{x \in A : B(x, \varepsilon) \subset A\}$  be the  $\varepsilon$ -interior of A, and  $A_{\varepsilon}^+ := \bigcup_{x \in A} B(x, \varepsilon)$  be the  $\varepsilon$ -neighbourhood of A. Then

$$A_{\varepsilon}^{-} \subset \cap_{y \in [-\varepsilon/2, \varepsilon/2]} (A - y) \text{ and } A \setminus A_{\varepsilon}^{-} \subset (\partial A)_{\varepsilon}^{+}$$

and

$$\cup_{y\in[-\varepsilon/2,\varepsilon/2]}(A-y)\subset A_{\varepsilon}^+ \ and \ A_{\varepsilon}^+\setminus A\subset (\partial A)_{\varepsilon}^+,$$

where  $(\partial A)^+_{\varepsilon}$  is the  $\varepsilon$ -neighbourhood of  $\partial A$  and  $\lim_{\varepsilon \downarrow 0} \nu((\partial A)^+_{\varepsilon}) = \nu(\partial A) = 0$ .

(ii) Moreover,

$$\sup_{x \in \mathbb{R}} |\nu(A_{\varepsilon}^+ - x) - \nu(A - x)| = \sup_{x \in \mathbb{R}} |\nu(A_{\varepsilon}^+ \setminus A - x)| \le \sup_{x} \nu((\partial A - x)_{\varepsilon}^+).$$

If  $Leb(\cdot)$  is the Lebesgue measure on  $\mathbb{R}$ , we have  $Leb(\partial A) = \nu(\partial A) = 0$ , and

$$\sup_{x} \nu((\partial A - x)_{\varepsilon}^{+}) \le Leb((\partial A)_{\varepsilon}^{+}) \to 0, \ as \ \varepsilon \downarrow 0.$$

6. As  $\nu(\partial A) = 0$ , for any l > 1, we have the following uniform convergence,

$$\lim_{n\to\infty} \sup_{a\in[l^{-1},l]} \sup_{b\in\mathbb{R}} \left| \nu_n(\sqrt{n}(aA+b)) - \nu(aA+b) \right| = 0.$$

In fact, (1)-(4) and (6) can be found in Lemmas 2.1, 2.2 and 2.4 of [21], (5) is a basic property. So we feel free to omit its proof.

Let  $\mathcal{M}$  be the collection of locally finite counting measures on  $\mathbb{R}$ . For any  $\zeta \in \mathcal{M}$  which is finite, we can write it as

$$\zeta = \sum_{i=1}^{|\zeta|} \delta_{x_i}$$

with  $x_i \in \mathbb{R}$  and  $|\zeta| < \infty$  the total mass. For convenience, we write  $x \in \zeta$  if  $\zeta\{x\} \ge 1$ . Let  $\{Z_n^{\zeta}\}$  be the branching random walk started from  $Z_0^{\zeta} = \zeta$ . Similarly, let  $\bar{Z}_n^{\zeta}(\cdot)$  be the corresponding empirical distribution. Because of (1.5), we have the following lemma, borrowed from [21].

**Lemma 2.2.** There exists  $C_1, C_2 > 0$  such that for all  $\Delta > 0$  sufficiently small and  $n \geq 1$ , for any finite  $\zeta \in \mathcal{M}$ ,

$$\mathbb{P}\left(\bar{Z}_n^{\zeta}(A) > \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_n(A - x) + \Delta\right) \le C_1 e^{-C_2 \Delta^2 |\zeta|},\tag{2.1}$$

The same holds if >,  $+\Delta$  are replaced by <,  $-\Delta$ , respectively.

The next two lemmas are slightly stronger versions of (1.2).

**Lemma 2.3.** Let  $A \in \mathcal{A} \setminus \emptyset$ . Let  $\{a_n : n \geq 1\}$  and  $\{b_n : n \geq 1\}$  be two deterministic sequences such that  $a_n \to 1$  and  $b_n \to 0$ . Then as  $n \to \infty$ ,

$$\bar{Z}_n(\sqrt{n}(a_nA + b_n)) \xrightarrow{a.s.} \nu(A).$$
 (2.2)

We feel free to omit its proof as it is a direct consequence of (1.2).

**Lemma 2.4.** Take the same assumptions as in Lemma 2.3. Then for any finite  $\zeta \in \mathcal{M}$ , as  $n \to \infty$ ,

$$\bar{Z}_n^{\sqrt{n}\zeta}(\sqrt{n}(a_nA + b_n)) \xrightarrow{a.s.} \frac{\sum_{x \in \zeta} \nu(A - x)W^x}{\sum_{x \in \zeta} W^x}, \tag{2.3}$$

where  $\sqrt{n}\zeta = \sum_{x \in \zeta} \delta_{x\sqrt{n}}$  and  $\{W^x : x \in \zeta\}$  are i.i.d. random variables distributed as W.

*Proof.* For any  $A \in \mathcal{A}$  and  $x \in \mathbb{R}$ , as  $n \to \infty$ ,

$$\frac{Z_n^{\delta_x\sqrt{n}}(\sqrt{n}A)}{m^n} - W\nu(A-x) \xrightarrow{a.s.} 0.$$

This convergence, together with the branching property of Galton-Watson process, gives

$$\bar{Z}_n^{\sqrt{n}\zeta}(\sqrt{n}A) \xrightarrow{a.s.} \frac{\sum_{x \in \zeta} \nu(A-x)W^x}{\sum_{x \in \zeta} W^x}.$$
 (2.4)

We thus conclude by Lemma 2.3.

When  $p_1 > 0$ , denote by  $\chi$  the so-called Schröder constant with

$$m^{-\chi} = p_1. \tag{2.5}$$

We also recall here a result from Lemma 13 in [8]. Note that  $Z_n(\mathbb{R}) = |Z_n|$  for the counting measure  $Z_n$ .

**Lemma 2.5.** If  $p_1 > 0$ , then there exists a constant  $C_3 > 0$  such that

$$P(|Z_n| = k) \le C_3 \left(\frac{1}{k} \wedge \left(k^{\chi - 1} p_1^n\right)\right), \quad \forall k, n \ge 1.$$

$$(2.6)$$

The next lemma is the well-known Cramér theorem; see Theorem 3.7.4 in [7]. Recall that  $\nu_n$  the distribution of a X-random walk at n-th step.

**Lemma 2.6.** If  $\mathbb{E}[e^{\kappa X}] < \infty$  for some  $\kappa > 0$ , for any a > 0 and  $\varepsilon > 0$ , as  $n \to \infty$ ,

$$\lim_{n \to \infty} \frac{1}{n} \log \nu_n((-(a+\epsilon)n, -an]) = -\gamma(a) := -\sup_{t>0} \{at - \Lambda(t)\}.$$
 (2.7)

For a < 0, we have a similar result with  $\gamma(a) = \gamma(-a)$ . This result follows immediately from Cramér's theorem, which says that for any a > 0,

$$\lim_{n \to \infty} \frac{1}{n} \log \nu_n((-\infty, -an]) = -\gamma(a),$$

where the rate function  $\gamma(a) \geq 0$  and convex.

# 3 Schröder case

# **3.1** Proof of Theorem 1.1: $I_A(p) < \infty$ and $I_A$ is continuous at p

In this section, we are going to demonstrate Theorem 1.1.

For the lower bound, we will make a single branch up to some generation  $O(\sqrt{n})$ , and the random walk along this branch moves to the level  $x\sqrt{n}$  so that the descendants at the *n*-th generation behave like  $\bar{Z}_n(\sqrt{n}A) \approx \nu(A-x) \geq p$  with high probability. For the upper bound, we will begin with a rough bound. Then an iteration method will be applied to improve the bound and to obtain the exact limit.

### 3.1.1 Lower bound

Recall  $\Lambda(t) = \log E[e^{tX}]$ , (1.9) and (2.7). Define

$$\bar{\Lambda}(p_1) := \inf_{a>0} \frac{\log \frac{1}{p_1} + \gamma(a)}{a}.$$

One could check that

$$\bar{\Lambda}(p_1) = \Lambda^{-1}(\log \frac{1}{p_1}) \in (0, \infty). \tag{3.1}$$

**Lemma 3.1.** (Lower bound) If all assumptions in Theorem 1.1 hold, then for any  $\varepsilon > 0$ ,

$$\liminf_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge -(I_A(p) + \varepsilon)\Lambda^{-1}(\log \frac{1}{p_1}). \tag{3.2}$$

*Proof.* Since  $I_A(p)$  is continuous at p, by (2) of Lemma 2.1, there exist  $x \in \mathbb{R}, \delta > 0$  such that

$$\nu(A-x) \ge p + \delta$$
 and  $|x| = I_A(p) + \varepsilon$ .

We only consider the case where x < 0. The case where x > 0 can be treated similarly. For any a > 0, let  $C_a := \frac{I_A(p) + \varepsilon}{a}$  and  $t_n := \lfloor C_a \sqrt{n} \rfloor$ . Note that  $-aC_a = x$ . Observe that for any  $\eta > 0$ ,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \ge \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p, Z_{t_n}(\mathbb{R}) = Z_{t_n}((-a(1+\eta)t_n, -at_n]) = 1\right)$$

which by Markov property at time  $t_n$  implies that,

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) \geq p) 
\geq \mathbb{P}(Z_{t_{n}}(\mathbb{R}) = Z_{t_{n}}((-a(1+\eta)t_{n}, -at_{n}]) = 1) \inf_{y \in (-a(1+\eta)t_{n}, -at_{n}]} \mathbb{P}\left(\bar{Z}_{n-t_{n}}^{\delta_{y}}(\sqrt{n}A) \geq p\right) 
= p_{1}^{t_{n}}\nu_{t_{n}}(-(a(1+\eta)t_{n}, -at_{n}]) \inf_{y \in ((1+\eta)x\sqrt{n}, x\sqrt{n}]} \mathbb{P}\left(\bar{Z}_{n-t_{n}}(\sqrt{n}A - y) \geq p\right).$$
(3.3)

It remains to treat the probability on the right hand side. Let  $A(x, \eta) := \bigcap_{y_0 \in ((1+\eta)x, x]} (A - y_0)$ . Observe that for any  $y \in (-a(1+\eta)C_a\sqrt{n}, -aC_a\sqrt{n}]$ ,

$$\bar{Z}_{n-t_n}(\sqrt{n}A - y) \ge \bar{Z}_{n-t_n}(\sqrt{n}A(x,\eta)) = \bar{Z}_{n-t_n}\left(\sqrt{n-t_n}\left(\frac{\sqrt{n}}{\sqrt{n-t_n}}A(x,\eta)\right)\right).$$

On the other hand, by (5) of Lemma 2.1, for  $\eta > 0$  small enough,

$$\nu(A(x,\eta)) \ge \nu(A-x) - \delta/2 \ge p + \delta/2.$$

It follows that

$$\begin{split} &\inf_{y \in ((1+\eta)x\sqrt{n}, x\sqrt{n}]} \mathbb{P}\left(\bar{Z}_{n-t_n}(\sqrt{n}A - y) \geq p\right) \\ &\geq \mathbb{P}\left(\bar{Z}_{n-t_n}\left(\sqrt{n-t_n}\left(\frac{\sqrt{n}}{\sqrt{n-t_n}}A(x,\eta)\right)\right) \geq p\right) \\ &\geq \mathbb{P}\left(\bar{Z}_{n-t_n}\left(\sqrt{n-t_n}\left(\frac{\sqrt{n}}{\sqrt{n-t_n}}A(x,\eta)\right)\right) \geq \nu(A(x,\eta)) - \delta/2\right), \end{split}$$

which, as  $n \to \infty$ , converges to 1 in view of Lemma 2.3. Going back to (3.3), this means that for  $\eta > 0$  small enough and n large enough,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \ge \frac{1}{2} p_1^{t_n} \nu_{t_n} \Big( (-a(1+\eta)t_n, -at_n] \Big).$$

This yields that

$$\liminf_{n\to\infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge C_a \log p_1 + \liminf_{n\to\infty} \frac{C_a}{t_n} \log \nu_{t_n} \left( (-a(1+\eta)t_n, -at_n] \right),$$

which, by (2.7), implies

$$\liminf_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge -C_a \left(\log \frac{1}{p_1} + \gamma(a)\right).$$

As the limit on the right hand side does not depend on a, we obtain that

$$\liminf_{n\to\infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge -(I_A(p) + \varepsilon) \inf_{a>0} \frac{\log \frac{1}{p_1} + \gamma(a)}{a} = -(I_A(p) + \varepsilon)\bar{\Lambda}(p_1),$$

which implies the lower bound.

**Remark 3.1.** If X is a simple random walk, then we have

$$\bar{\Lambda}(p_1) = \log\left(1 + \sqrt{1 - p_1^2}\right) - \log p_1 \in (0, \infty).$$

### 3.1.2 Upper bound

In this subsection, we are going to show that

$$\limsup_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \le -I_A(p)\bar{\Lambda}(p_1). \tag{3.4}$$

We believe that the strategy of lower bound is somehow optimal. For the upper bound, we consider also some intermediate generation of order  $O(\sqrt{n})$ , where, to get  $\{\bar{Z}_n(\sqrt{n}A) \geq p\}$ , the population size should be atypically small and the extreme positions should be close to  $\pm I_A(p)\sqrt{n}$ .

For  $\varepsilon \in (0, 1/2)$  small,  $a \in \mathbb{R}_+$ , define

$$N(a) = [a(1-\varepsilon)\sqrt{n}]$$
 and  $B_n := [-I_A(p)(1-\varepsilon)\sqrt{n}, I_A(p)(1-\varepsilon)\sqrt{n}].$ 

Moreover, there exists  $\delta \in (0, p - \nu(A))$  small enough such that

$$\sup_{z \in B_n/\sqrt{n}} \nu(A-z) \le p - \delta. \tag{3.5}$$

The following lemma states the idea presented at the beginning of this section. It gives also a rough upper bound. Let  $\mathcal{M}_B$  be the collection of all locally finite counting measures on  $\mathbb{R}$  which vanish outside B; i.e.,  $\mathcal{M}_B = \{\zeta \in \mathcal{M} : \zeta(B^c) = 0\}$ . Recall that  $|\zeta|$  is the total mass of  $\zeta \in \mathcal{M}$ .

**Lemma 3.2.** Suppose that all assumptions in Theorem 1.1 hold. Then there exists  $\alpha > 0$ , such that for  $a = I_A(p)\alpha$  and n large enough,

$$\mathbb{P}(Z_{N(a)}(B_n^c) \ge 1) = o_n(1)\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p)$$
(3.6)

Moreover, we have

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) = (1 + o_n(1))\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, |Z_{N(a)}| \le n, \bar{Z}_n(\sqrt{n}A) \ge p). \tag{3.7}$$

Consequently, there exists some constant  $C_4 > 0$  such that for all  $n \ge 1$ ,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \le C_4 p_1^{\alpha I_A(p)(1-\varepsilon)\sqrt{n}}$$
(3.8)

*Proof.* The proof will be divided into two subparts.

Subpart 1: We shall prove (3.6). Observe that by symmetry of  $\nu_N$  and Markov inequality,

$$\mathbb{P}(Z_{N(a)}(B_n^c) \ge 1) \le 2\mathbb{P}\left(Z_{N(a)}\left([I_A(p)(1-\varepsilon)\sqrt{n}, +\infty)\right) \ge 1\right)$$

$$\le 2\mathbb{E}\left[Z_{N(a)}\left([I_A(p)(1-\varepsilon)\sqrt{n}, +\infty)\right)\right]$$

$$= 2m^{N(a)}\nu_{N(a)}\left([I_A(p)(1-\varepsilon)\sqrt{n}, +\infty)\right).$$

By Chernoff bound of Cramér's theorem, one sees that

$$\nu_{N(a)}\Big([I_A(p)(1-\varepsilon)\sqrt{n},+\infty)\Big) = \nu_{N(a)}\Big(\left[\frac{I_A(p)}{a}N(a),+\infty\right)\Big) \leq \exp\left\{-N(a)\gamma\left(\frac{I_A(p)}{a}\right)\right\},$$

which implies that

$$\mathbb{P}(Z_{N(a)}(B_n^c) \ge 1) \le 2e^{-N(a)(\gamma(\frac{I_A(p)}{a}) - \log m)}$$

$$= 2e^{-\sqrt{n}(1-\varepsilon)(a\gamma(\frac{I_A(p)}{a}) - a\log m)}.$$
(3.9)

Meanwhile,

$$\lim_{a \downarrow 0} a(\gamma(I_A(p)/a) - \log m) = I_A(p) \lim_{a \to +\infty} \frac{\gamma(a) - \log m}{a}$$
$$= I_A(p) \lim_{a \to +\infty} \frac{\gamma(a) + \log \frac{1}{p_1}}{a} > I_A(p)\bar{\Lambda}(p_1).$$

where the inequality follows from the definition of  $\bar{\Lambda}(p_1)$ . Therefore, for any  $\alpha \in (0,1)$  small enough and any  $\varepsilon > 0$  small enough, with  $a = I_A(p)\alpha$ , we have

$$\limsup_{n} \frac{1}{\sqrt{n}} \log \mathbb{P}(Z_{N(a)}(B_n^c) \ge 1) \le -(1+\varepsilon)I_A(p)\bar{\Lambda}(p_1).$$

Therefore, in view of the lower bounded obtained in Lemma 3.1, one could choose  $\alpha > 0$  and  $\varepsilon_0 > 0$  sufficiently small such that for  $\varepsilon \in (0, \varepsilon_0)$ ,

$$\mathbb{P}(Z_{N(a)}(B_n^c) \ge 1) = o_n(1)\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p),$$

which is just (3.6).

Subpart 2: We turn to prove (3.7) and (3.8). According to (3.6), to bound  $\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \geq p)$ , we only need to consider  $\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, \bar{Z}_n(\sqrt{n}A) \geq p)$ . Note that by Markov property at time N(a),

$$\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, \bar{Z}_n(\sqrt{n}A) \ge p) = \sum_{\zeta \in \mathcal{M}_{B_n}} \mathbb{P}(Z_{N(a)} = \zeta, \bar{Z}_n(\sqrt{n}A) \ge p) 
= \sum_{\zeta \in \mathcal{M}_{B_n}} \mathbb{P}(Z_{N(a)} = \zeta) \mathbb{P}\left(\bar{Z}_{n-N(a)}^{\zeta}(\sqrt{n}A) \ge p\right).$$
(3.10)

By (1) and (6) of Lemma 2.1, we have

$$\sup_{z \in B_n} |\nu_{n-N(a)}(\sqrt{n}A - z) - \nu(A - \frac{z}{\sqrt{n}})| = o_n(1).$$

So, by (3.5), for n large enough and any  $\zeta \in \mathcal{M}_{B_n}$ , one has

$$p \ge \sup_{z \in B_n} \nu(A - \frac{z}{\sqrt{n}}) + \delta \ge \frac{1}{|\zeta|} \sum_{z \in \zeta} \nu_{n-N(a)}(\sqrt{n}A - z) + \delta/2.$$

Therefore, (3.10) becomes

$$\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, \bar{Z}_n(\sqrt{n}A) \ge p)$$

$$\leq \sum_{\zeta \in \mathcal{M}_{B_n}} \mathbb{P}(Z_{N(a)} = \zeta) \mathbb{P}\left(\bar{Z}_{n-N(a)}^{\zeta}(\sqrt{n}A) \ge \frac{1}{|\zeta|} \sum_{z \in \zeta} \nu_{n-N(a)}(\sqrt{n}A - z) + \delta/2\right),$$

which, by Lemma 2.2, is bounded by  $C_1 \sum_{\zeta \in \mathcal{M}_{B_n}} \mathbb{P}(Z_{N(a)} = \zeta) e^{-C_2|\zeta|\delta^2/4}$ . This gives that

$$\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, \bar{Z}_n(\sqrt{n}A) \ge p) \le C_1 \sum_{k=1}^{\infty} \mathbb{P}(|Z_{N(a)}| = k)e^{-c_1 k}.$$
(3.11)

As a consequence of (2.6),

$$\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, \bar{Z}_n(\sqrt{n}A) \ge p) \le c_2 p_1^{N(a)}. \tag{3.12}$$

Furthermore, following the same arguments to get (3.11), we have

$$\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, |Z_{N(a)}| \ge n, \bar{Z}_n(\sqrt{n}A) \ge p) \le C_1 \sum_{k=n}^{\infty} \mathbb{P}(|Z_{N(a)}| = k)e^{-c_1k} \\
\le C_1 e^{-c_1n} \\
= o_n(1)\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p), \tag{3.13}$$

where the last equality follows from Lemma 3.1. Then (3.6) and (3.13) yield that

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) \geq p) 
\leq \mathbb{P}\left(Z_{N(a)} \notin \mathcal{M}_{B_{n}}\right) + \mathbb{P}\left(Z_{N(a)} \in \mathcal{M}_{B_{n}}, \bar{Z}_{n}(\sqrt{n}A) \geq p\right) 
= o_{n}(1)\mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) \geq p\right) + \mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_{n}}, |Z_{N(a)}| < n, \bar{Z}_{n}(\sqrt{n}A) \geq p),$$
(3.14)

which, together with (3.12), gives (3.7) and (3.8).

More generally, for  $\rho_n = 1 + o_n(1)$ , we also have

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}(\rho_n A)) \ge p) \le C_5 e^{-\log \frac{1}{p_1} I_A(p)\alpha(1-\varepsilon)\sqrt{n}}.$$

The arguments above still work by remarking (1) of Lemma 2.1 which says that

$$\sup_{A \in \mathcal{A}} |\nu(\rho_n A) - \nu(A)| = O(|\rho_n - 1|) = o_n(1)$$

and that

$$\sup_{A \in \mathcal{A}} |\nu(A-z) - \nu(A-y)| = O(|y-z|).$$

In what follows, we fix  $\alpha > 0$ , the real number taken in the previous lemma and take  $\varepsilon \in (0, \varepsilon_0)$ . Here is the key lemma for the iteration of the upper bound.

**Lemma 3.3.** Suppose that all assumptions in Theorem 1.1 hold. Take  $\rho_n = 1 + o_n(1)$ . If we have

$$\limsup_{n} \frac{\log \mathbb{P}(\bar{Z}_{n}(\sqrt{n}\rho_{n}A) \ge p)}{\sqrt{n}} \le -LI_{A}(p), \tag{3.15}$$

for some L > 0, then

$$\limsup_{n} \frac{\log \mathbb{P}(\bar{Z}_n(\sqrt{n}\rho_n A) \ge p)}{\sqrt{n}} \le -F(L)I_A(p), \tag{3.16}$$

where

$$F(L) := \alpha \inf_{u \in \mathbb{R}} \left( \log \frac{1}{p_1} + \gamma(u) - uL \right) + L$$

with  $\alpha > 0$  chosen in Lemma 3.2.

**Remark 3.2.** By Lemma 3.2, we could take  $L = \alpha \log \frac{1}{p_1}$ . One can see that  $F(L) \leq \bar{\Lambda}(p_1)$  for  $L \leq \bar{\Lambda}(p_1)$  in Lemma A.1.

Proof. Recall that  $a = \alpha I_A(p)$  is fixed here. By (3.7), it suffices to consider  $\mathbb{P}(Z_{N(a)} \in \mathcal{M}_{B_n}, |Z_{N(a)}| < n, \bar{Z}_n(\sqrt{n}\rho_n A) \ge p)$  with  $N(a) = [a(1-\varepsilon)\sqrt{n}]$ . In the rest of this proof, we write N and N(a) and N(a) and N(a) and N(a) are proof. We observe that given  $\{Z_N = \zeta\}$ ,

$$\bar{Z}_n(\sqrt{n}\rho_n A) = \bar{Z}_{n-N}^{\zeta}(\sqrt{n}\rho_n A) \le \max_{z \in \zeta} \bar{Z}_{n-N}^z(\sqrt{n-N}(\rho_n' A)), \tag{3.17}$$

where the last inequality follows from the elementary inequality

$$\frac{\sum_{i=1}^{k} a_i}{\sum_{i=1}^{k} b_i} \le \max_{i \le k} \frac{a_i}{b_i}, \quad \forall a_i \ge 0, b_i > 0.$$

Then (3.17) gives

$$\mathbb{P}(Z_N \in \mathcal{M}_B, |Z_N| < n, \bar{Z}_n(\sqrt{n}\rho_n A) \ge p) 
\leq \mathbb{P}\left(Z_N \in \mathcal{M}_B, |Z_N| < n, \max_{z \in Z_N} \bar{Z}_{n-N}^z(\sqrt{n-N}(\rho'_n A)) \ge p\right).$$
(3.18)

For any M > 0, let us consider a partition on B:

$$(1-\varepsilon)\sqrt{n}u_0 < (1-\varepsilon)\sqrt{n}u_1 < \cdots < (1-\varepsilon)\sqrt{n}u_M,$$

where  $u_{i+1} - u_i = \eta := \frac{2I_A(p)}{M}$  with  $u_0 = -I_A(p)$  and  $u_M = I_A(p)$ . Then the r.h.s of (3.18) is less than

$$\mathbb{P}\left(\bigcup_{i=0}^{M-1} \left\{ Z_N \in \mathcal{M}_B, |Z_N| < n, \max_{z \in Z_N \cap J_i} \bar{Z}_{n-N}^z(\sqrt{n-N}(\rho_n'A)) \ge p \right\} \right),$$

where  $J_0 = [(1 - \varepsilon)\sqrt{n}u_0, (1 - \varepsilon)\sqrt{n}u_1]$  and

$$J_i = ((1 - \varepsilon)\sqrt{n}u_i, (1 - \varepsilon)\sqrt{n}u_{i+1}], \quad 1 \le i \le M - 1.$$

It follows from Markov property that

$$\mathbb{P}(Z_{N} \in \mathcal{M}_{B}, |Z_{N}| < n, \bar{Z}_{n}(\sqrt{n}\rho_{n}A) \ge p)$$

$$\leq \sum_{i=0}^{M-1} \sum_{\zeta \in \mathcal{M}_{B}, |\zeta| \le n} \mathbb{P}(Z_{N} = \zeta) \, \mathbb{P}\left(\max_{z \in \zeta \cap J_{i}} \bar{Z}_{n-N}^{z}(\sqrt{n-N}(\rho'_{n}A)) \ge p\right)$$

$$\leq \sum_{i=0}^{M-1} \sum_{\zeta \in \mathcal{M}_{B}, |\zeta| \le n} \mathbb{P}(Z_{N} = \zeta) \sum_{z \in \zeta \cap J_{i}} \mathbb{P}\left(\bar{Z}_{n-N}(\sqrt{n-N}(\rho'_{n}A) - z) \ge p\right)$$

$$\leq \sum_{i=0}^{M-1} \left[\sum_{\zeta \in \mathcal{M}_{B}, |\zeta| \le n} \mathbb{P}(Z_{N} = \zeta) \, \zeta(J_{i})\right] \, \mathbb{P}\left(\bar{Z}_{n-N}(\sqrt{n-N}\rho'_{n}A^{+}_{2\eta} - (1-\varepsilon)u_{i})\right) \ge p\right). (3.19)$$

The last inequality holds for  $\eta > 0$  and n large enough, because that for n sufficiently large, for any  $z \in J_i$ , we have

$$\sqrt{n-N}(\rho'_nA)-z\subset\sqrt{n-N}\rho'_n(A^+_{2\eta}-(1-\varepsilon)u_i),$$

where  $A_{2\eta}^+ = \bigcup_{x \in A} B(x, 2\eta)$  is the  $2\eta$ -neighbourhood of A. Observe that for any  $0 \le i \le M - 1$ ,

$$\sum_{\zeta \in \mathcal{M}_{B}, |\zeta| \leq n} \mathbb{P}\left(Z_{N} = \zeta\right) \zeta(J_{i}) \leq n \mathbb{P}\left(|Z_{N}| \leq n, Z_{N}(J_{i}) \geq 1\right)$$

$$\leq n \mathbb{E}\left[|Z_{N}|; |Z_{N}| \leq n\right] \nu_{N}\left(J_{i}\right). \tag{3.20}$$

Again, by (2.6),

$$\mathbb{E}[|Z_N|; |Z_N| \le n] \le n \mathbb{P}(|Z_N| \le n) \le c_3 n^{\chi + 1} p_1^N. \tag{3.21}$$

On the other hand, by (2.7) and Chernoff bound,

$$\nu_N(J_i) \le e^{-N\inf_{u_i \le u \le u_{i+1}} \gamma(u/a)}. \tag{3.22}$$

With (3.19) in hand, plugging (3.21) and (3.22) into (3.20) yields that

$$\mathbb{P}(Z_N \in \mathcal{M}_B, |Z_N| < n, \bar{Z}_n(\sqrt{n}\rho_n A) \ge p)$$

$$\leq c_3 n^{\chi+2} p_1^N \sum_{i=0}^{M-1} e^{-N\inf_{u_i \le u \le u_{i+1}} \gamma(u/a)} \mathbb{P}\left(\bar{Z}_{n-N}\left(\sqrt{n-N}\rho'_n(A_{2\eta}^+ - (1-\varepsilon)u_i)\right) \ge p\right). \quad (3.23)$$

It remains to bound  $\mathbb{P}\left(\bar{Z}_{n-N}(\sqrt{n-N}\rho'_n(A^+_{2\eta}-(1-\varepsilon)u_i))\geq p\right)$ . Here we are going to use the assumption (3.15). We first consider  $A^+_{2\eta}-(1-\varepsilon)u_i$  and the corresponding  $I_{A^+_{2\eta}-(1-\varepsilon)u_i}(p)$ . According to (5) of Lemma 2.1, we have for any  $x\in\mathbb{R}$ ,

$$\lambda((\partial A)_{2\eta}^+) + \nu(A - x) \ge \nu(A_{2\eta}^+ - x) \ge \nu(A - x).$$

We take  $\eta > 0$  sufficiently small (i.e., M large enough) so that  $\lambda((\partial A)^{2\eta}) \leq \delta/2$ , which ensures that for any  $u \in \mathbb{R}$ ,

$$I_{A-u}(p-\delta/2) \le I_{A_{2n}^+-u}(p) \le I_{A-u}(p).$$
 (3.24)

Moreover, by (3.5),  $\sup_{u_0 \le u \le u_M} \nu(A_{2\eta}^+ - (1 - \varepsilon)u) \le p - \delta/2$ . So, we can apply (3.15) and obtain that

$$\limsup_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_{n-N}(\sqrt{n-N}\rho'_n(A^+_{2\eta} - (1-\varepsilon)u_i)) \ge p\right) \le -LI_{A^+_{2\eta} - (1-\varepsilon)u_i}(p)$$

$$\le -LI_{A-(1-\varepsilon)u_i}(p-\delta/2).$$

Let us now introduce  $x_{+}(p) := \inf\{x \geq 0 : \nu(A - x) \geq p\}$  and  $x_{-}(p) := \inf\{x \geq 0 : \nu(A + x) \geq p\}$ . Clearly  $I_{A}(p) = x_{+}(p) \wedge x_{-}(p)$ . For  $u \in (u_{0}, u_{M})$ ,

$$I_{A-u}(p) = (x_{+}(p) - u) \wedge (x_{-}(p) + u).$$

By (1) of Lemma 2.1, we can choose  $\delta > 0$  sufficiently small such that  $x_{\pm}(p - \delta/2) \in [x_{\pm}(p)(1 - \varepsilon), x_{\pm}(p))$ . This brings that

$$I_{A-(1-\varepsilon)u_i}(p-\delta/2) \ge (1-\varepsilon)((x_+(p)-u_i) \wedge (x_-(p)+u_i)).$$

It implies that

$$\limsup_{n\to\infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_{n-N}(\sqrt{n-N}\rho'_n(A^+_{2\eta}-u_i)) \ge p\right) \le -L(1-\varepsilon)((x_+(p)-u_i)\wedge (x_-(p)+u_i)).$$

As a result, (3.23) entails that

$$\lim_{n \to \infty} \sup \frac{1}{\sqrt{n}} \log \mathbb{P}(Z_N \in \mathcal{M}_B, |Z_N| < n, \bar{Z}_n(\sqrt{n}\rho_n A) \ge p)$$

$$\leq -(1 - \varepsilon) \min_{0 \leq i \leq M - 1} \left\{ a \log \frac{1}{p_1} + a \inf_{u_i \leq u \leq u_{i+1}} \gamma(u/a) + L((x_+(p) - u_i) \wedge (x_-(p) + u_i)) \right\}$$

$$\leq -(1 - \varepsilon) \inf_{u_0 \leq u \leq u_M} \left\{ a \log \frac{1}{p_1} + a\gamma(u/a) + L((x_+(p) - u) \wedge (x_-(p) + u)) \right\} + \eta L, \qquad (3.25)$$

as  $u_{i+1} - u_i = \eta$ . Observe that for any  $u_0 \le u \le u_M$ ,

$$a \log \frac{1}{p_1} + a\gamma(u/a) + L(x_+(p) - u) \ge \inf_{u \in \mathbb{R}} \left\{ a \log \frac{1}{p_1} + a\gamma(u/a) + L(x_+(p) - u) \right\},$$

and

$$a \log \frac{1}{p_1} + a\gamma(u/a) + L(x_-(p) + u) \ge \inf_{u \in \mathbb{R}} \left\{ a \log \frac{1}{p_1} + a\gamma(u/a) + L(x_-(p) + u) \right\}.$$

Recall that  $a = \alpha I_A(p)$  and that the symmetry of the distribution of step size implies that  $\gamma(u) = \gamma(-u)$ . Therefore,

$$\begin{split} &\inf_{u_0 \leq u \leq u_M} \left\{ a \log \frac{1}{p_1} + a \gamma(u/a) + L((x_+(p) - u) \wedge (x_-(p) + u)) \right\} \\ &\geq \inf_{u \in \mathbb{R}} \left\{ a \log \frac{1}{p_1} + a \gamma(u/a) + L(x_+(p) - u) \right\} \wedge \inf_{u \in \mathbb{R}} \left\{ a \log \frac{1}{p_1} + a \gamma(u/a) + L(x_-(p) + u) \right\} \\ &= \inf_{u \in \mathbb{R}} \left\{ a \log \frac{1}{p_1} + a \gamma(u/a) + Lu \right\} + L(x_+(p) \wedge x_-(p)) \\ &= F(L) I_A(p), \end{split}$$

which, together with (3.7) and (3.25), implies (3.16), by letting  $\eta \downarrow 0$  and  $\varepsilon \downarrow 0$  in (3.25). We complete the proof.

Now we are prepared to prove (3.4).

**Proof of** (3.4). We begin with the rough bound in (3.8). Let  $L_0 = -\alpha \log p_1$  and

$$L_k := F(L_{k-1}), \quad \forall k \ge 1.$$

In view of Lemma (3.3), by iteration, we get that for any  $k \geq 0$ ,

$$\limsup_{n \to \infty} \frac{1}{\sqrt{n}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \le -I_A(p)L_k.$$

By Lemma A.1,  $\lim_{k\to\infty} L_k = \bar{\Lambda}(p_1)$ . We thus conclude (3.4).

## 3.2 Proof of Theorem 1.2: $I_A(p) = \infty$

The idea of the proof is mainly borrowed from Louidor and Perkins [21, Section 2.3.2]. Recall that  $J_A(p) = \inf \{ y : \sup_{x \in \mathbb{R}} \nu((A-x)/\sqrt{1-y}) \ge p, \ y \in [0,1] \}.$ 

**Lemma 3.4.** Suppose that all assumptions in Theorem 1.2 hold. Then

$$\liminf_{n \to \infty} \frac{1}{n} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge J_A(p) \log p_1. \tag{3.26}$$

*Proof.* Since  $J_A(p)$  is continuous at p, then by (3) in Lemma 2.1, for any  $\varepsilon > 0$  small enough, we may find  $r \in (0,1)$ ,  $x \in \mathbb{R}$  and  $\delta > 0$ ,  $\eta > 0$ , such that

$$J_A(p) - \varepsilon < r < J_A(p) + \varepsilon$$
 and  $\nu(\bigcap_{y \in [x-\eta, x+\eta]} (A-y) / \sqrt{1-r}) \ge p + \delta$ .

Set

$$t_n = rn + x\sqrt{n}; \quad m = n - t_n; \quad B_n := [(x - \eta)\sqrt{n}, (x + \eta)\sqrt{n}].$$

Observe that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \ge \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p, Z_{t_n} \in \mathcal{M}_{B_n}, |Z_{t_n}| = 1).$$

Applying Markov property at time  $t_n$  implies that

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) \geq p) \geq \mathbb{P}(Z_{t_{n}} \in \mathcal{M}_{B_{n}}, |Z_{t_{n}}| = 1) \inf_{y \in B_{n}} \mathbb{P}(\bar{Z}_{n-t_{n}}^{\delta_{y}}(\sqrt{n}A) \geq p)$$

$$= p_{1}^{t_{n}} \nu_{t_{n}}(B_{n}) \inf_{y \in [(x-\eta)\sqrt{n}, (x+\eta)\sqrt{n}]} \mathbb{P}(\bar{Z}_{m}(\sqrt{n}A - y) \geq p)$$

$$\geq p_{1}^{t_{n}} \nu_{t_{n}}(B_{n}) \mathbb{P}(\bar{Z}_{m}(\sqrt{m}\rho_{n} \cap_{y \in [x-\eta, x+\eta]} \frac{(A-y)}{\sqrt{1-r}}) \geq p)$$

where  $\rho_n = \frac{\sqrt{n(1-r)}}{\sqrt{m}} \to 1$ . By Lemma 2.1,

$$\left| \nu_m \left( \sqrt{m} \rho_n \cap_{y \in [x-\eta, x+\eta]} \frac{(A-y)}{\sqrt{1-r}} \right) - \nu \left( \cap_{y \in [x-\eta, x+\eta]} \frac{(A-y)}{\sqrt{1-r}} \right) \right| = o_n(1).$$

So for n large enough,

$$\nu_m\left(\sqrt{m}\rho_n\cap_{y\in[x-\eta,x+\eta]}\frac{(A-y)}{\sqrt{1-r}}\right)\geq\nu\left(\bigcap_{y\in[x-\eta,x+\eta]}\frac{(A-y)}{\sqrt{1-r}}\right)-\delta/2\geq p+\delta/2.$$

This, together with Lemma 2.1 entails that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \geq p)$$

$$\geq p_1^{t_n} \nu_{t_n}(B_n) \mathbb{P}\left(\bar{Z}_m\left(\sqrt{m}\rho_n \cap_{y \in [x-\eta, x+\eta]} \frac{(A-y)}{\sqrt{1-r}}\right) \geq \nu_m\left(\sqrt{m}\rho_n \cap_{y \in [x-\eta, x+\eta]} \frac{(A-y)}{\sqrt{1-r}}\right) - \delta/2\right)$$

$$\geq p_1^{t_n} \nu_{t_n}(\sqrt{n}[x-\eta, x+\eta])(1+o_n(1)).$$

Note that  $\nu_{t_n}(\sqrt{n}[x-\eta,x+\eta]) = \Theta(1)$  by classical central limit theorem. As a consequence,

$$\liminf_{n\to\infty} \frac{1}{n} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge r \log p_1 \ge (J_A(p) + \varepsilon) \log p_1.$$

We obtain (3.26) by letting  $\varepsilon \downarrow 0$ .

**Lemma 3.5.** Suppose that all assumptions in Theorem 1.2 hold. Then for any  $\varepsilon > 0$  small enough,

$$\limsup_{n \to \infty} \frac{1}{n} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \le (J_A(p) - \varepsilon) \log p_1. \tag{3.27}$$

*Proof.* For  $\varepsilon \in (0, J_A(p))$  small enough, set  $t_n = \lfloor (J_A(p) - \varepsilon)n \rfloor$ . Then

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) = \sum_{\zeta \in \mathcal{M}} \mathbb{P}(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p) \mathbb{P}(Z_{t_n} = \zeta). \tag{3.28}$$

By the definition of  $J_A(p)$ , there exists  $\delta > 0$  such that for  $\varepsilon' \in [\varepsilon, 2\varepsilon]$ ,

$$\sup_{y \in \mathbb{R}} \nu \left( \frac{A - y}{\sqrt{1 - J_A(p) + \varepsilon'}} \right) \le p - \delta. \tag{3.29}$$

(1) and (5) of Lemma 2.1 show that for n large enough,

$$\frac{1}{|\zeta|} \sum_{y \in \zeta} \nu_{n-t_n}(\sqrt{n}A - y) \le \frac{1}{|\zeta|} \sum_{y \in \zeta} \nu\left(\frac{\sqrt{n}}{\sqrt{n-t_n}}A - \frac{y}{\sqrt{n-t_n}}\right) + \delta/2 \le p - \delta/2.$$

This implies that

$$\mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p\right) \le \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge \frac{1}{|\zeta|} \sum_{y \in \zeta} \nu_{n-t_n}(\sqrt{n}A - y) + \delta/2\right),$$

which by Lemma 2.2 is less than  $C_1e^{-C_2\delta^2|\zeta|/4}$ . Going back to (3.28) and using (2.6), we have

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) \geq p) \leq \sum_{\zeta \in \mathcal{M}} C_{1}e^{-C_{2}\delta^{2}|\zeta|/4}\mathbb{P}(Z_{t_{n}} = \zeta)$$

$$= \sum_{k=1}^{\infty} C_{1}\mathbb{P}(|Z_{t_{n}}| = k)e^{-c_{4}k}$$

$$\leq c_{5} \sum_{k=1}^{\infty} p_{1}^{t_{n}}k^{\chi-1}e^{-c_{4}k} \leq c_{6}p_{1}^{t_{n}}.$$
(3.30)

This yields (3.27) immediately.

Theorem 1.2 follows directly from the lemmas 3.4 and 3.5.

### 4 Böttcher case

In this section, we suppose that  $p_0 = p_1 = 0$ . As we claimed in the introduction, different tail distributions of step size bring out different regimes. To obtain Theorems 1.3 and 1.4, we need to treat the sub-exponential and the super-exponential decaying tails differently.

### 4.1 Proof of Theorem 1.3: step size has Weibull tail distribution

### 4.1.1 Proof when step size has (sub)-exponential decay

In this section, we assume that  $2 \le b < B \le \infty$ ,  $\mathbb{P}(X > z) = \Theta(1)e^{-\lambda z^{\alpha}}$  as  $z \to \infty$  with  $\alpha \in (0, 1]$ ,  $\lambda > 0$  and also that  $I_A(p) < \infty$  and  $I_A(\cdot)$  is continuous at  $p = \nu(A) + \Delta$ . We are devoted to proving

$$\lim_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) = -\lambda I_A(p)^{\alpha}. \tag{4.1}$$

**Lower bound of** (4.1): Suppose that at the first generation, the root gives birth to exactly b children, denoted by  $\rho_1, \dots, \rho_b$ . Moreover, suppose that their positions are  $S_{\rho_1} \in [(x-\eta)\sqrt{n}, (x+\eta)\sqrt{n}]$ ,  $S_{\rho_i} \in [-M, M]$  for  $2 \le i \le b$ . Here we take M > 0 such that

$$\mathbb{P}(|X| \le M) \ge 1/2.$$

As  $I_A(\cdot)$  is continuous and finite at p, for any  $\varepsilon > 0$  small enough, there exist  $x \in \mathbb{R}$  and  $\eta > 0, \delta > 0$  such that

$$\inf_{y \in [x-\eta, x+\eta]} \nu(A-y) \ge p + \delta, \quad |x| = I_A(p) + \varepsilon.$$

By Lemma (2.4), given  $\mathbf{E} := \{ |Z_1| = b, S_{\rho_1} \in [(x - \eta)\sqrt{n}, (x + \eta)\sqrt{n}], S_{\rho_i} \in [-M, M], \forall i = 2, \dots, b \},$ 

$$\liminf_{n \to \infty} \bar{Z}_n(\sqrt{n}A) \ge \frac{(p+\delta)W_1 + \sum_{i=2}^b \nu(A)W_i}{\sum_{i=1}^b W_i},$$

where  $W_i$ ,  $i = 1, 2, \dots, b$  are i.i.d. copies of W. This shows that

$$\liminf_{n \to \infty} \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p | \mathbf{E}) \ge \mathbb{P}\left(\liminf_{n \to \infty} \bar{Z}_n(\sqrt{n}A) \ge p + \delta/2 | \mathbf{E}\right)$$

$$\ge \mathbb{P}\left(\frac{(p+\delta)W_1 + \sum_{i=2}^b \nu(A)W_i}{\sum_{i=1}^b W_i} \ge p + \delta/2\right)$$

$$=: C_{A, n, \delta, b}.$$

Since B > b, W has a continuous positive density on  $(0, \infty)$ ; see Athreya and Ney [4, Chapter II, Lemma 2]. So  $C_{A,p,\delta,b}$  is a positive real number. Consequently,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \ge \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p|\mathbf{E}\right) \mathbb{P}(\mathbf{E})$$
$$\ge \Theta(1)p_b e^{-\lambda(|x| - \eta)^{\alpha} n^{\alpha/2}} (1 + o_n(1)) \left(\frac{1}{2}\right)^{b-1}.$$

Taking limits yields that

$$\liminf_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \ge -\lambda (I_A(p) + \varepsilon - \eta)^{\alpha}.$$

Letting  $\varepsilon \downarrow 0$  and  $\eta \downarrow 0$  gives that

$$\liminf_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \ge -\lambda I_A(p)^{\alpha}.$$

**Upper bound of** (4.1): Take an intermediate generation  $t_n = \lfloor t \log n \rfloor$  with some t > 0. Let  $B_n = [(-I_A(p) + \varepsilon)\sqrt{n}, (I_A(p) - \varepsilon)\sqrt{n}]$  with  $\varepsilon > 0$  small enough. Note that there exists  $\delta > 0$  such that

$$\sup_{x \in [-I_A(p) + \varepsilon, I_A(p) - \varepsilon]} \nu(A - x) \le p - \delta. \tag{4.2}$$

Observe that

$$\mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) \geq p\right) 
\leq \mathbb{P}(Z_{t_{n}}(B_{n}^{c}) \geq 1) + \mathbb{P}(Z_{t_{n}} \in \mathcal{M}_{B_{n}}, \bar{Z}_{n}(\sqrt{n}A) \geq p) 
\leq 2\mathbb{P}(Z_{t_{n}}((I_{A}(p) - \varepsilon)\sqrt{n}, \infty) \geq 1) + \sum_{\zeta \in \mathcal{M}_{B_{n}}} \mathbb{P}(Z_{t_{n}} = \zeta)\mathbb{P}(\bar{Z}_{n-t_{n}}^{\zeta}(\sqrt{n}A) \geq p).$$
(4.3)

On the one hand, by Markov inequality,

$$\mathbb{P}(Z_{t_n}((I_A(p) - \varepsilon)\sqrt{n}, \infty) \ge 1) \le \mathbb{E}[Z_{t_n}((I_A(p) - \varepsilon)\sqrt{n}, \infty)] = m^{t_n}\nu_{t_n}((I_A(p) - \varepsilon)\sqrt{n}, \infty). \quad (4.4)$$

It is known (see [23]) that

$$\nu_{t_n}((I_A(p) - \varepsilon)\sqrt{n}, \infty) \begin{cases} = e^{-\lambda(I_A(p) - \varepsilon)^{\alpha} n^{\alpha/2} + o(n^{\alpha/2})}, & \alpha < 1; \\ \leq e^{-(\lambda - \varepsilon)(I_A(p) - \varepsilon)\sqrt{n}} \mathbb{E}[e^{(\lambda - \varepsilon)X}]^{t_n}, & \alpha = 1, \end{cases}$$

$$(4.5)$$

where for  $\alpha = 1$ , we use Markov inequality again by noting that  $\mathbb{E}[e^{-(\lambda - \varepsilon)X}] < \infty$  for  $\varepsilon \in (0, \lambda)$ . On the other hand, for any  $\zeta \in \mathcal{M}_{B_n}$ , because of (4.2), one has

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu(A - \frac{x}{\sqrt{n}}) \le p - \delta.$$

Again by (6) of Lemma 2.1, for n large enough,

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) \le p - \delta/2.$$

This, combined with Lemma 2.2, implies that

$$\mathbb{P}(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p) \le \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) + \delta/2\right)$$

$$\le C_1 e^{-C_2|\zeta|\delta^2/4}.$$
(4.6)

In view of (4.4), (4.5) and (4.6), (4.3) becomes

$$\mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) \geq p\right) \\
\leq 2m^{t_{n}}e^{-(\lambda-\varepsilon)(I_{A}(p)-\varepsilon)^{\alpha}n^{\alpha/2}+o(n^{\alpha/2})} + C_{1}\sum_{\zeta \in \mathcal{M}_{B_{n}}} \mathbb{P}(Z_{t_{n}} = \zeta)e^{-C_{2}|\zeta|\delta^{2}/4} \\
\leq 2m^{t_{n}}e^{-(\lambda-\varepsilon)(I_{A}(p)-\varepsilon)^{\alpha}n^{\alpha/2}+o(n^{\alpha/2})} + C_{1}e^{-c_{7}b^{t_{n}}},$$

as  $|Z_{t_n}| \geq b^{t_n}$ . We take  $t > \frac{\alpha}{2 \log b}$  so that  $b^{t_n} \gg n^{\alpha/2}$  and hence

$$\mathbb{P}(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p) \le e^{-(\lambda-\varepsilon)(I_A(p)-\varepsilon)^{\alpha}n^{\alpha/2} + o(n^{\alpha/2})}$$

We thus obtain that

$$\limsup_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p) \le -(\lambda - \varepsilon)(I_A(p) - \varepsilon)^{\alpha},$$

which, together with the lower bound above, concludes (4.1).

### 4.1.2 Proof when step size has super-exponential decay

In this section, we assume that the tail distribution of step size is  $\mathbb{P}(X > x) = \Theta(1)e^{-\lambda x^{\alpha}}$  with  $\alpha > 1$ . The embedding tree is assumed to be random with  $2 \le b < B \le +\infty$ . We are going to prove the following convergence: for  $p \in (\nu(A), 1)$  such that  $I_A(p)$  is continuous and finite, we have

$$\lim_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) = -\left(\frac{2\log b \log B}{\alpha(\log B - \log b)}\right)^{\alpha - 1} \lambda I_A(p)^{\alpha},\tag{4.7}$$

with the convention that  $\frac{2 \log b \log B}{\alpha(\log B - \log b)} = \frac{2 \log b}{\alpha}$  if  $B = \infty$ .

**Lower bound of** (4.7): According to the definition of  $I_A(p)$ , for any  $\delta > 0$  small enough, there exist  $x_0 \in \mathbb{R}$ ,  $\varepsilon > 0$  and  $\eta > 0$  such that

$$I_A(p) < |x_0| \le I_A(p) + \varepsilon$$
,  $\inf_{y \in [x_0 - \eta, x_0 + \eta]} \nu(A - y) \ge p + \delta$ .

Take an integer d > b such that  $p_d > 0$ . (If  $B < \infty$ , then we choose d = B. If  $B = \infty$ , we will let  $d \to \infty$  later.) Let  $t_n = \lfloor t_1 \log n - t_2 \log \log n \rfloor$  with some  $t_1, t_2 > 0$ . Then for sufficiently large n, let

$$s_n = \left| \frac{\log \log n + t_n \log b}{\log d} \right|, \quad \Upsilon = \frac{2 \log b \log d}{\alpha (\log d - \log b)}.$$

Let us construct a tree  $\mathbf{t}$  of height  $t_n$  in the following way. First,  $\mathbf{t}_{t_n-s_n} := \{v \in \mathbf{t} : |v| \leq t_s - s_n\}$  is a b-regular tree. Using Neveu's notation [24], let  $\mathbb{U} := \bigcup_{n\geq 1} \mathbb{N}_+^n \cup \{\rho\}$  be the infinite Ulam-Harris tree, to code the vertices. Here denote  $u^* = (1, \dots, 1)$  to be the first individual of the  $(t_n - s_n)$ -th generation in the lexicographic order. Next,  $\mathbf{t}(u^*)$  is a d-regular tree and  $\{\mathbf{t}(u) : u \neq u^*, |u| = t_n - s_n\}$  are all b-regular trees, where for any  $u \in \mathbf{t}$ ,  $\mathbf{t}(u) := \{v \in \mathbf{t} : u \leq v\}$  is the subtree of  $\mathbf{t}$  rooted at u. Recall from the very beginning of this paper that  $\mathcal{T}$  is the embedded Galton-Watson tree. Let  $\mathcal{T}_{t_n} = \{u \in \mathcal{T} : |u| \leq t_n\}$ . Define the following event

$$\mathcal{E}_{t_n,b,d} = \{ \mathcal{T}_{t_n} = \mathbf{t}, S_u \in [(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}], \text{ for all } |u| = t_n \text{ s.t. } u \in \mathbf{t}(u^*) \},$$
(4.8)

which means that all the descendants of  $u^*$  at the  $t_n$ -th generation are positioned in the interval  $[(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}]$ . It follows immediately that

$$\mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p\right) \ge \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \ge p | \mathcal{E}_{t_n,b,d}\right) \mathbb{P}(\mathcal{E}_{t_n,b,d}) \tag{4.9}$$

and that

$$\mathbb{P}(\mathcal{E}_{t_n,b,d}) \ge p_b^{b^{t_n}} p_d^{d^{s_n}} \mathbb{P}^{\mathbf{t}}(S_u \in [(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}], \forall u \in \mathbf{t}(u^*), |u| = t_n), \tag{4.10}$$

where  $\mathbb{P}^{\mathbf{t}} = \mathbb{P}(\cdot | \mathcal{T}_{t_n} = \mathbf{t})$ . To bound the probability on the R. H. S. of (4.10), let us take the following labels (step sizes):

$$X_v \in \left[ (x_0 - \frac{\eta}{2}) \frac{\sqrt{n}}{t_n - s_n}, (x_0 + \frac{\eta}{2}) \frac{\sqrt{n}}{t_n - s_n} \right], \quad \forall \rho \prec v \preceq u^*;$$

and

$$X_v \in [-M, M], \quad \forall v \in \mathbf{t}(u^*) \text{ and } |v| \le t_n,$$

where M is a fixed real number such that  $\mathbb{P}(X \in [-M, M]) \geq 1/2$ . Observe that for n large enough, for any  $u \in \mathbf{t}(u^*)$  s.t.  $|u| = t_n$ ,

$$S_u \in \left[ (x_0 - \frac{\eta}{2})\sqrt{n} - Ms_n, (x_0 + \frac{\eta}{2})\sqrt{n} + Ms_n \right] \subset [(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}].$$

As a consequence,

$$\mathbb{P}^{\mathbf{t}}(S_{u} \in (x_{0} - \eta)\sqrt{n}, (x_{0} + \eta)\sqrt{n}], \forall u \in \mathbf{t}(u^{*}), |u| = t_{n})$$

$$\geq \mathbb{P}\left(X \in \left[(x_{0} - \frac{\eta}{2})\frac{\sqrt{n}}{t_{n} - s_{n}}, (x_{0} + \frac{\eta}{2})\frac{\sqrt{n}}{t_{n} - s_{n}}\right]\right)^{t_{n} - s_{n}} \times \prod_{1 < k \leq s_{n}} \mathbb{P}(X \in [-M, M])^{d^{k}}$$

$$\geq \left(\frac{1}{2}\right)^{2d^{s_{n}}} c_{8}^{t_{n} - s_{n}} \exp\left\{-\lambda(t_{n} - s_{n})^{1 - \alpha}\left(|x_{0}| - \frac{\eta}{2}\right)^{\alpha} n^{\alpha/2}\right\}.$$

Here we take  $t_1 = \frac{\alpha}{2 \log b}$  and  $t_2 = \frac{2\alpha}{\log b}$  so that

$$\frac{n^{\alpha/2}}{(t_n - s_n)^{\alpha - 1}} = (1 + o_n(1))\Upsilon^{\alpha - 1} \frac{n^{\alpha/2}}{(\log n)^{\alpha - 1}} \gg d^{s_n} \gg b^{t_n}.$$

Therefore, by (4.10),

$$\mathbb{P}(\mathcal{E}_{t_n,b,d}) \ge \exp\left\{-\lambda \left(|x_0| - \frac{\eta}{2}\right)^{\alpha} \Upsilon^{\alpha - 1} \frac{n^{\alpha/2}}{\left(\log n\right)^{\alpha - 1}} + o\left(\frac{n^{\alpha/2}}{(\log n)^{\alpha - 1}}\right)\right\}. \tag{4.11}$$

It remains to bound  $\mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) \geq p | \mathcal{E}_{t_n,b,d}\right)$ . Define

$$\mathcal{M}_0 = \left\{ \zeta \in \mathcal{M} : |\zeta| = d^{s_n} + b^{t_n} - b^{s_n}, \zeta([(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}]) \ge d^{s_n} \right\}.$$

For any  $\zeta \in \mathcal{M}_0$ , by considering only the particles in  $[(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}]$ 

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu(\sqrt{n}A - x) \ge \frac{d^{s_n}}{d^{s_n} + b^{t_n} - b^{s_n}} \inf_{y \in [x_0 - \eta, x_0 + \eta]} \nu(A - y) 
\ge \frac{\log n}{\log n + 1} (p + \delta),$$

which, combining with (5) of Lemma 2.1, implies that for n large enough,

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) \ge p + \delta/2.$$

This means that for any  $\zeta \in \mathcal{M}_0$ ,

$$\left\{ \bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \geq \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) - \delta/2 \right\} \subset \{\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \geq p\},$$

as  $p = \nu(A) + \Delta$ . Note that  $Z_{t_n} \in \mathcal{M}_0$  given  $\mathcal{E}_{t_n,b,d}$ . Then by Lemma 2.2, we have

$$\begin{split} & \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \geq p | \mathcal{E}_{t_n,b,d}) \\ & \geq \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \geq \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) - \delta/2\right) \bigg|_{\zeta = Z_{t_n} \in \mathcal{M}_0} \\ & \geq 1 - C_1 e^{-C_2 d^{s_n} \delta^2/4} \geq \frac{1}{2}, \end{split}$$

for all n large enough. This implies that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \ge \frac{1}{2}\mathbb{P}(\mathcal{E}_{t_n,b,d}),$$

which, together with (4.11), gives

$$\liminf_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha / 2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \ge -\lambda \left( |x_0| - \frac{\eta}{2} \right)^{\alpha} \Upsilon^{\alpha - 1}.$$
(4.12)

Then we get the lower bound by letting  $\delta \downarrow 0$  and  $d \uparrow B$ .

**Upper bound of** (4.7): Again, by the definition of  $I_A(p)$ , for any  $\delta > 0$  small enough, there exist  $\eta > 0$  such that

$$\sup_{|y| \le I_A(p) - \eta} \nu(A - y) \le p - \delta.$$

Let  $B_n := [(-I_A(p) + \eta)\sqrt{n}, (I_A(p) - \eta)\sqrt{n}], t_n = \lfloor \frac{\alpha \log b}{2} \log n \rfloor$ . Observe that for any  $\zeta \in \mathcal{M}$ ,

$$\begin{split} \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu(A - \frac{x}{\sqrt{n}}) = & \frac{1}{|\zeta|} \sum_{x \in \zeta \cap B_n} \nu(A - \frac{x}{\sqrt{n}}) + \frac{1}{|\zeta|} \sum_{x \in \zeta \cap B_n^c} \nu(A - \frac{x}{\sqrt{n}}) \\ \leq & p - \delta + \frac{\zeta(B_n^c)}{|\zeta|}, \end{split}$$

which is less than  $p - \delta/2$  as soon as  $\frac{\zeta(B_n^c)}{|\zeta|} \leq \delta/2$ . Further, by (5) of Lemma 2.1, for all n large enough,

$$\mathcal{M}_1 := \left\{ \zeta \in \mathcal{M} : \frac{\zeta(B_n^c)}{|\zeta|} \le \delta/2 \right\} \subset \left\{ \zeta \in \mathcal{M} : \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) \le p - \delta/4 \right\}. \tag{4.13}$$

By conditioning on  $\{Z_{t_n} = \zeta\}$  for any  $\zeta \in \mathcal{M}_1$ , we observe that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \le \mathbb{P}(\bar{Z}_{t_n}(B_n^c) > \delta/2) + \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p, \bar{Z}_{t_n}(B_n^c) \le \delta/2)$$

$$= \mathbb{P}(\bar{Z}_{t_n}(B_n^c) > \delta/2) + \sum_{\zeta \in \mathcal{M}_1} \mathbb{P}(Z_{t_n} = \zeta) \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge p\right),$$

which, by (4.13), is bounded by

$$\mathbb{P}(\bar{Z}_{t_n}(B_n^c) > \delta/2) + \sum_{\zeta \in \mathcal{M}} \mathbb{P}(Z_{t_n} = \zeta) \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) + \delta/4\right).$$

Note that  $|Z_{t_n}| \geq b^{t_n}$ . In view of Lemma 2.2,

$$\sum_{\zeta \in \mathcal{M}} \mathbb{P}(Z_{t_n} = \zeta) \mathbb{P}\left(\bar{Z}_{n-t_n}^{\zeta}(\sqrt{n}A) \ge \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) + \delta/4\right) \le C_1 e^{-c_9 b^{t_n}}.$$

Since  $\mathbb{P}(\bar{Z}_{t_n}(B_n^c) > \delta/2) \leq \mathbb{P}(Z_{t_n}(B_n^c) \geq \delta b^{t_n}/2)$ , then

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \le \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) + C_1 e^{-c_9 b^{t_n}}.$$
(4.14)

It remains to bound  $\mathbb{P}(Z_{t_n}(B_n^c) \geq \delta b^{t_n}/2)$ , which will be investigated separately in two cases:  $B = \infty$  and  $B < \infty$ .

First case:  $B = \infty$ . Note that by Markov inequality and symmetry of X,

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le \mathbb{P}(Z_{t_n}(B_n^c) \ge 1)$$

$$\le m^{t_n} \nu_{t_n}(B_n^c) \le 2m^{t_n} \nu_{t_n} \left( \left[ (I_A(p) - \eta)\sqrt{n}, \infty \right) \right).$$

Then (1) of Lemma A.2 implies that

$$\limsup_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha/2}} \log \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le -\lambda \left(\frac{2 \log b}{\alpha}\right)^{\alpha - 1} (I_A(p) - \eta)^{\alpha}.$$

As  $b^{t_n} \ge \frac{n^{\alpha/2}}{b} \gg \frac{n^{\alpha/2}}{t_n^{\alpha-1}}$ , in view of (4.14), we get

$$\limsup_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha / 2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \le -\lambda \left(\frac{2 \log b}{\alpha}\right)^{\alpha - 1} (I_A(p) - \eta)^{\alpha},$$

which, with the help of (4.12), proves (4.7) in the case of  $B = \infty$  by letting  $\eta \downarrow 0$ .

**Second case:**  $b < B < \infty$ . The proof will be divided into three subparts. Subpart 1: Recall that  $t_n = \left\lfloor \frac{\alpha}{2\log b} \log n \right\rfloor$ . Let  $s_n = \left\lfloor \frac{t_n \log b - 2\alpha \log \log n}{\log B} \right\rfloor$ . For n large enough, we have  $\delta b^{t_n}/4 \geq B^{s_n}$ . Observe that

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le 2\mathbb{P}\left(Z_{t_n}((I_A(p) - \eta)\sqrt{n}, \infty) \ge B^{s_n}\right).$$

Recall that up to the  $t_n$ -th generation, the genealogical tree  $\mathcal{T}_{t_n}$  is Galton-Watson. Set  $I(n) = (I_A(p) - \eta)\sqrt{n}$ . Then

$$\mathbb{P}(Z_{t_n}((I_A(p) - \eta)\sqrt{n}, \infty) \ge B^{s_n}) = \sum_{\mathbf{t}} \mathbb{P}(\mathcal{T}_{t_n} = \mathbf{t}) \mathbb{P}^{\mathbf{t}} \left( \sum_{|u| = t_n, u \in \mathbf{t}} 1_{\{S_u > I(n)\}} \ge B^{s_n} \right).$$

Observe that

$$\left\{ \sum_{|u|=t_n, u \in \mathbf{t}} 1_{\{S_u > I(n)\}} \ge B^{s_n} \right\} \subset \left\{ \bigcup_{\mathcal{J} \subset \mathbf{t}_{t_n}, |\mathcal{J}| = B^{s_n}} \bigcap_{u \in \mathcal{J}} \{S_u > I(n)\} \right\}, \tag{4.15}$$

where  $\mathbf{t}_{t_n} = \{u \in \mathbf{t} : |u| = t_n\}$ . This yields that

$$\mathbb{P}(Z_{t_n}((I_A(p) - \eta)\sqrt{n}, \infty) \ge B^{s_n}) \le \sum_{\mathbf{t}} \mathbb{P}(\mathcal{T} = \mathbf{t}) \sum_{\mathcal{J} \subset \mathbf{t}_{t_n}, |\mathcal{J}| = B^{s_n}} \mathbb{P}^{\mathbf{t}} \left( \bigcap_{u \in \mathcal{J}} \{S_u > I(n)\} \right)$$
(4.16)

We claim that for any  $\mathbf{t}$  and  $\mathcal{J} \subset \mathbf{t}_{t_n}$  with  $|\mathcal{J}| = B^{s_n}$ 

$$\mathbb{P}^{\mathbf{t}}\left(\bigcap_{u\in\mathcal{J}}\{S_{u}>I(n)\}\right) \leq c_{10}t_{n}B^{s_{n}}e^{-\lambda n^{\alpha}} + (c_{10}n)^{t_{n}B^{s_{n}}}\exp\left\{-\frac{\lambda\left((I_{A}(p)-\eta)\sqrt{n}-t_{n}\right)^{\alpha}}{\left(t_{n}-s_{n}+\frac{1}{B^{1/(\alpha-1)}-1}\right)^{\alpha-1}}\right\}.$$
(4.17)

(4.17) will be proved in Subpart 2. Notice that

$$\# \{ \mathcal{J} \subset \mathbf{t}_{t_n}, \, |\mathcal{J}| = B^{s_n} \} = \begin{pmatrix} |\mathbf{t}_{t_n}| \\ B^{s_n} \end{pmatrix} \leq \begin{pmatrix} B^{t_n} \\ B^{s_n} \end{pmatrix},$$

which, together with (4.17) and (4.16), gives

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le \binom{B^{t_n}}{B^{s_n}} \times \left( c_{10} t_n B^{s_n} e^{-\lambda n^{\alpha}} + (c_{10} n)^{t_n B^{s_n}} \exp \left\{ -\frac{\lambda \left( (I_A(p) - \eta) \sqrt{n} - t_n \right)^{\alpha}}{\left( t_n - s_n + \frac{1}{B^{1/(\alpha - 1)} - 1} \right)^{\alpha - 1}} \right\} \right).$$

Note that  $B^{s_n} \leq \frac{n^{\alpha/2}}{(\log n)^{2\alpha}}$  and

$$\binom{B^{t_n}}{B^{s_n}} = \frac{(B^{t_n})!}{(B^{s_n})!(B^{t_n} - B^{s_n})!} \le \frac{B^{t_n B^{s_n}}}{(B^{s_n})!} \le B^{t_n B^{s_n}}.$$

Then

$$t_n B^{s_n} \log n = O(1) \frac{n^{\alpha/2}}{(\log n)^{2\alpha - 2}} \ll \frac{n^{\alpha/2}}{(\log n)^{\alpha - 1}},$$
$$\frac{((I_A(p) - \eta)\sqrt{n} - t_n)^{\alpha}}{\left(t_n - s_n + \frac{1}{B^{1/(\alpha - 1)} - 1}\right)^{\alpha - 1}} = \frac{n^{\alpha/2}}{(\log n)^{\alpha - 1}} \left(\Upsilon^{\alpha - 1} (I_A(p) - \eta)^{\alpha} + o_n(1)\right),$$

where  $\Upsilon = \frac{2 \log b \log B}{\alpha (\log B - \log b)}$ . So,

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le \exp\left\{-\frac{\lambda n^{\alpha/2}}{(\log n)^{\alpha-1}} \left(\Upsilon^{\alpha-1}(I_A(p) - \eta)^{\alpha} + o_n(1)\right)\right\}.$$

In view of (4.14), we conclude that

$$\limsup_{n \to \infty} \frac{(\log n)^{\alpha - 1}}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p) \le -\lambda \Upsilon^{\alpha - 1} (I_A(p) - \eta)^a,$$

which, by letting  $\eta \to 0$ , gives what we need. .

Subpart 2: This subpart is devoted to demonstrating (4.17). For any  $\mathcal{J}$ , define  $\mathbf{t}_{\mathcal{J}} = \{v \in \mathbf{t} : \rho \prec v \leq u, u \in \mathcal{J}\}$ . One sees that

L.H.S. of (4.17) 
$$\leq \mathbb{P}^{\mathbf{t}} \left( \sum_{\rho \prec v \preceq u} |X_v| \geq I(n), \forall u \in \mathcal{J} \right)$$
  
 $\leq \mathbb{P}^{\mathbf{t}} \left( \sup_{v \in \mathbf{t}_{\mathcal{J}}} |X_v| \geq n \right) + \mathbb{P}^{\mathbf{t}} \left( \sup_{v \in \mathbf{t}_{\mathcal{J}}} |X_v| \leq n; \sum_{\rho \prec v \preceq u} |X_v| \geq I(n), \forall u \in \mathcal{J} \right).$  (4.18)

It follows from the tail distribution of X that there exists  $c_{11} \geq 1$  such that

$$\mathbb{P}(|X| \ge x) \le c_{11}e^{-\lambda x^{\alpha}}, \forall x \ge 0.$$

As a consequence, we have

$$\mathbb{P}^{\mathbf{t}}\left(\sup_{v\in\mathbf{t}_{\mathcal{J}}}|X_{v}|\geq n\right)\leq|\mathbf{t}_{\mathcal{J}}|\mathbb{P}(|X|\geq n)\leq c_{11}t_{n}B^{s_{n}}e^{-\lambda n^{\alpha}}.$$
(4.19)

Meanwhile,

$$\mathbb{P}^{\mathbf{t}} \left( \sup_{v \in \mathbf{t}_{\mathcal{J}}} |X_{v}| \leq n; \sum_{\rho \prec v \leq u} |X_{v}| \geq I(n), \forall u \in \mathcal{J} \right) \\
\leq \sum_{x_{v} \in \mathbb{N} \cap [0,n), v \in \mathbf{t}_{\mathcal{J}}} \mathbb{P}^{\mathbf{t}} \left( \bigcap_{v \in \mathbf{t}_{\mathcal{J}}} \{ |X_{v}| \in [x_{v}, x_{v} + 1] \} \right) 1_{\left\{ \min_{u \in \mathcal{J}} \sum_{\rho \prec v \leq u} (x_{v} + 1) \geq I(n) \right\}} \\
\leq \sum_{x_{v} \in \mathbb{N} \cap [0,n), v \in \mathbf{t}_{\mathcal{J}}} c_{11}^{t_{n}B^{s_{n}}} e^{-\lambda \sum_{v \in \mathbf{t}_{\mathcal{J}}} x_{v}^{\alpha}} 1_{\left\{ \min_{u \in \mathcal{J}} \sum_{\rho \prec v \leq u} x_{v} \geq I_{1}(n) \right\}}, \tag{4.20}$$

where  $I_1(n) = I(n) - t_n$ . We need to bound R.H.S. of (4.20). To end this, we **CLAIM** that from  $\{x_v, v \in \mathbf{t}_{\mathcal{J}}\}$ , one can construct a rooted deterministic tree  $\mathbf{t}_{\mathcal{J}}^*$  with labels  $x_{\rho} = 0$  and  $\{x_v^*, v \in \mathbf{t}_{\mathcal{J}}^* \setminus \{\rho\}\} \subset \{x_v, v \in \mathbf{t}_{\mathcal{J}}\}$  such that

$$\sum_{v \in \mathbf{t}_{\mathcal{J}}} x_v^{\alpha} \ge \sum_{v \in \mathbf{t}_{\mathcal{J}}^*} (x_v^*)^{\alpha}, \quad \min_{|u| = t_n, u \in \mathbf{t}_{\mathcal{J}}^*} \sum_{\rho \prec v \le u} x_v^* \ge \min_{u \in \mathcal{J}} \sum_{\rho \prec v \le u} x_v \ge I_1(n), \tag{4.21}$$

and that  $\mathbf{t}_{\mathcal{J}}^*$  contains a single branch up to the generation  $t_n - s_n$ , then it has the *B*-regular structure up to the generation  $t_n$ . The detailed construction will be postponed to *Subpart 3*.

With the help of (4.21), we get that

R.H.S. of (4.20)
$$\leq c_{11}^{t_n B^{s_n}} n^{|\mathbf{t}_{\mathcal{J}}|} \sup_{x_v^* \in \mathbb{N}, x_v^* < n, v \in \mathbf{t}_{\mathcal{J}}^*} e^{-\lambda \sum_{v \in \mathbf{t}_{\mathcal{J}}^*} (x_v^*)^{\alpha}} 1_{\left\{ \min_{|u| = t_n} \sum_{\rho \prec v \preceq u} x_v^* \ge I_1(n) \right\}}.$$

$$(4.22)$$

Note that  $\min_{|u|=t_n} \sum_{\rho \prec v \preceq u} x_v^* \ge I_1(n)$  leads to  $\sum_{|u|=t_n} \sum_{\rho \prec v \preceq u} x_v^* \ge I_1(n) B^{s_n}$ , which means

$$\sum_{i=1}^{k_0} \sum_{|u|=i} x_u^* + \sum_{i=1+k_0}^{t_n} \frac{\sum_{|u|=i} x_u^*}{B^{i-k_0}} \ge I_1(n),$$

with  $k_0 = t_n - s_n$ . Note that

$$\#\{u \in \mathbf{t}_{\mathcal{J}}^* : |u| = i\} = \begin{cases} 1, & i \le k_0; \\ B^{i-k_0}, & k_0 < i \le t_n. \end{cases}$$

Write  $\bar{x}_i^* = \sum_{|u|=i} x_u^*$  for  $i \leq k_0$  and  $\bar{x}_i^* = \frac{\sum_{|u|=i} x_u^*}{B^{i-k_0}}$  for  $k_0 < i \leq t_n$ . So we have

$$1_{\{\min_{|u|=t_n} \sum_{\rho \prec v \prec u} x_v^* \ge I_1(n)\}} \le 1_{\{\sum_{i=1}^{t_n} \bar{x}_i^* \ge I_1(n)\}}$$

Consequently,

$$\sup_{x_{v}^{*} \in \mathbb{N} \cap [0,n), v \in \mathbf{t}_{\mathcal{J}}^{*}} e^{-\lambda \sum_{v \in \mathbf{t}_{\mathcal{J}}^{*}} (x_{v}^{*})^{\alpha}} 1_{\left\{\min_{|u|=t_{n}} \sum_{\rho \prec v \preceq u} x_{v}^{*} \geq I_{1}(n)\right\}} \leq \sup_{x_{v}^{*} \in \mathbb{N} \cap [0,n), v \in \mathbf{t}_{\mathcal{J}}^{*}} e^{-\lambda \sum_{v \in \mathbf{t}_{\mathcal{J}}^{*}} (x_{v}^{*})^{\alpha}} 1_{\left\{\sum_{i=1}^{t_{n}} \bar{x}_{i}^{*} \geq I_{1}(n)\right\}}.$$

$$(4.23)$$

Moreover, as  $\alpha > 1$ , by convexity of  $x \mapsto x^{\alpha}$  on  $\mathbb{R}_+$ , we obtain that for  $k_0 < i \le t_n$ ,

$$\sum_{|u|=i} \left( x_u^* \right)^{\alpha} \ge B^{i-k_0} \left( \frac{\sum_{|u|=i} x_u^*}{B^{i-k_0}} \right)^{\alpha} = B^{i-k_0} (\bar{x}_i^*)^{\alpha},$$

and  $\sum_{|u|=i} (x_u^*)^{\alpha} = (\bar{x}_i^*)^{\alpha}$  for  $1 \leq i \leq k_0$ . Again using convexity implies that, for any  $\mu_i > 0$ ,

$$\sum_{v \in \mathbf{t}^*} (x_v^*)^{\alpha} \ge \sum_{i=1}^{k_0} (\bar{x}_i^*)^{\alpha} + \sum_{i=k_0+1}^{t_n} B^{i-k_0} (\bar{x}_i^*)^{\alpha} 
= \sum_{i=1}^{k_0} (\bar{x}_i^*)^{\alpha} + \sum_{i=1+k_0}^{t_n} B^{i-k_0} \mu_i^{-\alpha} (\mu_i \bar{x}_i^*)^{\alpha} 
\ge \left( k_0 + \sum_{i=1+k_0}^{t_n} B^{i-k_0} \mu_i^{-\alpha} \right) \left( \frac{\sum_{i=1}^{k_0} \bar{x}_i^* + \sum_{i=1+k_0}^{t_n} B^{i-k_0} \mu_i^{1-\alpha} \bar{x}_i^*}{k_0 + \sum_{i=1+k_0}^{t_n} B^{i-k_0} \mu_i^{-\alpha}} \right)^{\alpha}.$$

By taking  $\mu_i > 0$  such that  $B^{i-k_0}\mu_i^{1-\alpha} = 1$ , one sees that given  $\sum_{i=1}^{t_n} \bar{x}_i^* \geq I_1(n)$ , we have

$$\sum_{v \in \mathbf{t}^*} (x_v^*)^{\alpha} \ge \left( k_0 + \sum_{i=1+k_0}^{t_n} B^{-\frac{i-k_0}{\alpha-1}} \right)^{1-\alpha} \left( \sum_{i=1}^{t_n} \bar{x}_i^* \right)^{\alpha} \\
\ge \frac{\left( (I_A(p) - \eta)\sqrt{n} - t_n \right)^{\alpha}}{\left( t_n - s_n + \frac{1}{B^{1/(\alpha-1)} - 1} \right)^{\alpha-1}}.$$
(4.24)

With (4.18), (4.20) and (4.19) in hand, plugging (4.24) and (4.23) into (4.22) yields that

L.H.S. of (4.17)

$$\leq c_{11}t_n B^{s_n} e^{-\lambda n^{\alpha}} + (c_{11}n)^{t_n B^{s_n}} \exp \left\{ -\frac{\lambda \left( (I_A(p) - \eta)\sqrt{n} - t_n \right)^{\alpha}}{\left( t_n - s_n + \frac{1}{B^{1/(\alpha - 1)} - 1} \right)^{\alpha - 1}} \right\}.$$
(4.25)

We have completed the proof of (4.17).

Subpart 3: We now explain how to construct  $\{x_v^*, v \in \mathbf{t}^*\}$ . Recall that  $k_0 = t_n - s_n$  and  $|Z_k^{\mathbf{t}}|$  is the number of particles at the k-th generation in  $\mathbf{t}$ . Then

$$|Z_{i+k_0}^{\mathbf{t}}| \ge B^i, \forall 1 \le i \le t_n - k_0 = s_n.$$


This shows that there are sufficiently many particles in  $\mathbf{t}$ . As always, we say that  $s_u := \sum_{\rho < v \le u} x_v$  is the position of  $u \in \mathbf{t}$  and  $x_u$  its displacement. For each  $u \in \mathbf{t}$  and that  $\kappa(u)$  is the number of its children, if it is selected to be in  $\mathbf{t}^*$ ,  $x_u^* = x_u$  (but its ancestor line might be changed, so might be its position).

At the  $(t_n-1)$ -th generation, there are at least  $B^{s_n-1}$  particles in  $\mathbf{t}$ . Let us rearrange them according to their positions:  $s_{u_{(1)}} \geq s_{u_{(2)}} \geq \cdots s_{u_{(B^{s_n-1})}} \geq \cdots$ . We only take  $u_{(j)}, j=1, \cdots, B^{s_n-1}$  (together with their descedants) to be in  $\mathbf{t}^*$ . Those particles are said to be selected. For  $u_{(j)}$ , if  $\kappa(u_{(j)}) = B$ , we jump to consider  $u_{(j+1)}$ . Otherwise, we prune  $B - \kappa(u_{(j)})$  unselected particles at the  $t_n$ -th generation and graft them to  $u_{(j)}$ . The fact that  $|Z^{\mathbf{t}}_{t_n}| = B^{s_n}$  ensures that  $u_{(j)}$  finally has B children for any  $\forall 1 \leq j \leq B^{s_n-1}$ .

Suppose that we have already got the  $B^{i+1}$  particles with their descendants for the generation  $k_0 + i + 1$  of  $\mathbf{t}^*$ . We are interested in their parents at the  $(k_0 + i)$ -th generation in  $\mathbf{t}$ , the number of which is at least  $B^i$ . We rearrange them according to their positions:  $s_{w_{(1)}} \geq s_{w_{(2)}} \geq \cdots s_{w_{(B^i)}} \geq \cdots$ . We select  $w_{(j)}$ ,  $j = 1, \dots, B^i$  with their descendants in  $\mathbf{t}^*$ , For  $w_{(j)}$ , if  $\kappa(w_{(j)}) = B$ , we jump to consider  $u_{(j+1)}$ . Otherwise, we prune  $B - \kappa(w_{(j)})$  unselected particles at the  $(k_0 + i + 1)$ -th generation together with their descendants and graft these subtrees to  $w_{(j)}$ .

We continue this backward construction until the  $k_0$ -th generation where there is only one particle in  $\mathbf{t}^*$ . We then take directly all its ancestors in  $\mathbf{t}$  to establish the single branch of  $\mathbf{t}^*$ .

In the following figure, we give an example of this construction. The horizontal axis represents generations and the vertical axis represents positions of particles. In FigA, from the tree  $\mathbf{t}$ , we choose  $B^{s_n}$  particles in  $\mathcal{J}$  and colour them in red. In FigB, we subtract all the ancestors of the red particles and remove the others. In FigC, we do the pruning and grafting for the last two generations as explained above. In FigD, we get the final labelled tree  $\mathbf{t}^*$  in blue while the red particles are those chosen in  $\mathcal{J}$ . The blue dashed lines link the particles and their added descendants at each step.



Observe that only a part of the particles in  $\mathbf{t}$  has been selected and that the positions at the final generation of  $\mathbf{t}^*$  are all getting higher. (4.21) is satisfied.

### 4.1.3 LDP when the tree is regular

Unfortunately, the arguments above do not all work when the embedding tree  $\mathcal{T}$  is regular. We could only get the upper and lower bound for the large deviation behaviours:

$$-C_{\alpha} \leq \liminf_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) - \nu(A) \geq \Delta\right)$$

$$\leq \limsup_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_{n}(\sqrt{n}A) - \nu(A) \geq \Delta\right) \leq -c_{\alpha}. \quad (4.26)$$

**Lower bound** No matter whether  $\alpha < 1$  or  $\alpha \ge 1$ , we only consider the first generation and suppose that

$$S_u \in [(x-\eta)\sqrt{n}, (x+\eta)\sqrt{n}], \quad \forall |u| = 1,$$

where  $|x| = I_A(p) + \varepsilon$  with  $\inf_{y \in [x-\eta, x+\eta]} \nu(A-y) \ge p + \delta$  for some  $\delta, \eta, \varepsilon > 0$ . Given  $\mathbf{E} := \{S_u \in [(x-\eta)\sqrt{n}, (x+\eta)\sqrt{n}], \forall |u| = 1\},$ 

$$\liminf_{n \to \infty} \bar{Z}_n(\sqrt{n}A) \ge p + \delta.$$

Then

$$\mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta\right) \ge \mathbb{P}(S_u \in [(x - \eta)\sqrt{n}, (x + \eta)\sqrt{n}], \forall |u| = 1; \bar{Z}_n(\sqrt{n}A) \ge p)$$

$$\ge \mathbb{P}(\bar{Z}_n(\sqrt{n}A) \ge p|\mathbf{E})\mathbb{P}(\mathbf{E}),$$

where

$$\liminf_{n\to\infty} \mathbb{P}(\bar{Z}_n(\sqrt{n}A \ge p|\mathbf{E}) \ge \mathbb{P}(\liminf_{n\to\infty} \bar{Z}_n(\sqrt{n}A) \ge p|E) = 1.$$

On the other hand,

$$\mathbb{P}(\mathbf{E}) = \mathbb{P}(X \in [(x-\eta)\sqrt{n}, (x+\eta)\sqrt{n}])^b = (1+o_n(1))e^{-\lambda b(x-\eta)^{\alpha}n^{\alpha/2}}.$$

We thus deduce that

$$\liminf_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta\right) \ge -\lambda b(x - \eta)^{\alpha}.$$

We obtain the lower bound in (4.26) with  $C_{\alpha} = \lambda b(I_A(p))^{\alpha}$ .

**Upper bound** When  $\alpha \leq 1$ , the arguments in Section 4.1.1 still work for regular tree. So the upper bound is obtained with  $c_{\alpha} = \lambda (I_A(p))^{\alpha}$  in the case of  $\alpha \leq 1$ .

When  $\alpha > 1$ , (4.14) still holds. So, for  $B_n = [-(I_A(p) - \eta)\sqrt{n}, (I_A(p) - \eta)\sqrt{n}]$  and  $t_n = \left\lfloor \frac{\alpha \log b}{2} \log n \right\rfloor$ ,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \le \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) + C_1 e^{-c_9 b^{t_n}}.$$

Observe that

$$\frac{Z_{t_n}(B_n^c)}{b^{t_n}} = \sum_{|u|=t_n} \frac{1_{|S_u| \ge (I_A(p)-\eta)\sqrt{n}}}{b^{t_n}} \le \frac{1}{(I_A(p)-\eta)\sqrt{n}} \sum_{|u|=t_n} \frac{|S_u|}{b^{t_n}}.$$

Moreover,  $|S_u| \leq \sum_{\rho \prec v \prec u} |X_u|$  implies that

$$\frac{Z_{t_n}(B_n^c)}{b^{t_n}} \le \frac{1}{(I_A(p) - \eta)\sqrt{n}} \sum_{|u| = t_n} \frac{|S_u|}{b^{t_n}} \le \frac{1}{(I_A(p) - \eta)\sqrt{n}} \sum_{k=1}^{t_n} \sum_{|u| = k} \frac{|X_u|}{b^k}.$$

It follows that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \le \mathbb{P}\left(\sum_{k=1}^{t_n} \sum_{|u|=k} \frac{|X_u|}{b^k} \ge \delta(I_A(p) - \eta)\sqrt{n}\right) + C_1 e^{-c_9 n^{\alpha/2}}$$

$$= \mathbb{P}\left(\left(\sum_{k=1}^{t_n} \sum_{|u|=k} \frac{|X_u|}{b^k}\right)^{\alpha} \ge [\delta(I_A(p) - \eta)\sqrt{n}]^{\alpha}\right) + C_1 e^{-c_9 n^{\alpha/2}}.$$

By convexity of  $x \mapsto x^{\alpha}$ , for any  $\mu_k > 0$ , one sees that

$$\left(\sum_{k=1}^{t_n} \sum_{|u|=k} \frac{|X_u|}{b^k}\right)^{\alpha} = \left(\sum_{k=1}^{t_n} \sum_{|u|=k} \frac{\mu_k}{b^k} (\mu_k^{-1}|X_u|)\right)^{\alpha}$$

$$\leq \left(\sum_{k=1}^{t_n} \mu_k\right)^{\alpha} \frac{\sum_{k=1}^{t_n} \sum_{|u|=k} \mu_k b^{-k} (\mu_k^{-1}|X_u|)^{\alpha}}{\sum_{k=1}^{t_n} \mu_k}$$

$$\leq \mu^{\alpha-1} \sum_{k=1}^{t_n} \sum_{|u|=k} b^{-k} \mu_k^{1-\alpha} |X_u|^{\alpha},$$

where  $\mu = \sum_{k=1}^{\infty} \mu_k$ . We are going to take a decreasing sequence  $\mu_k = k^{-2}$  so that  $\mu < \infty$ . Therefore, for any  $\theta > 0$ ,

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) - \nu(A) \geq \Delta)$$

$$\leq \mathbb{P}\left(\mu^{\alpha-1} \sum_{k=1}^{t_{n}} \sum_{|u|=k} b^{-k} \mu_{k}^{1-\alpha} |X_{u}|^{\alpha} \geq \left[\delta(I_{A}(p) - \eta)\sqrt{n}\right]^{\alpha}\right) + C_{1}e^{-c_{9}n^{\alpha/2}}$$

$$\leq e^{-\frac{\theta}{\mu^{\alpha-1}}\delta^{\alpha}(I_{A}(p) - \eta)^{\alpha}n^{\alpha/2}} \mathbb{E}\left[\exp\{\theta \sum_{k=1}^{t_{n}} \sum_{|u|=k} b^{-k} \mu_{k}^{1-\alpha} |X_{u}|^{\alpha}\}\right] + C_{1}e^{-c_{9}n^{\alpha/2}}.$$
(4.27)

We then show that for  $\theta > 0$  sufficiently small such that  $\sup_{k \geq 1} \theta b^{-k} k^{2(\alpha-1)} \leq \lambda/2$ , there exists  $c_{\lambda} > 0$  such that

$$\mathbb{E}\left[\exp\{\theta\sum_{k=1}^{t_n}\sum_{|u|=k}b^{-k}\mu_k^{1-\alpha}|X_u|^\alpha\}\right] \le e^{c_\lambda\theta t_n^{2\alpha-1}}.$$

In fact, by independence,

$$\mathbb{E}\left[\exp\{\theta \sum_{k=1}^{t_n} \sum_{|u|=k} b^{-k} \mu_k^{1-\alpha} |X_u|^{\alpha}\}\right] = \prod_{k=1}^{t_n} \prod_{|u|=k} \mathbb{E}\left[\exp\{\theta b^{-k} k^{2(\alpha-1)} |X_u|^{\alpha}\}\right]$$

$$= \prod_{k=1}^{t_n} \prod_{|u|=k} \left(1 + \int_0^\infty \theta b^{-k} k^{2(\alpha-1)} e^{\theta b^{-k} k^{2(\alpha-1)} x} \mathbb{P}(|X_u|^{\alpha} \ge x) dx\right).$$

The tail distribution of X shows that  $\mathbb{P}(|X| \geq x) \leq c_{11}e^{-\lambda x^{\alpha}}$  for any  $x \geq 0$ . It follows that

$$\mathbb{E}\left[\exp\{\theta\sum_{k=1}^{t_n}\sum_{|u|=k}b^{-k}k^{2(\alpha-1)}|X_u|^{\alpha}\}\right] \leq \prod_{k=1}^{t_n}\prod_{|u|=k}\left(1+c_{11}\int_0^\infty \theta b^{-k}k^{2(\alpha-1)}e^{\theta b^{-k}k^{2(\alpha-1)}x-\lambda x}dx\right)$$

$$=\prod_{k=1}^{t_n}\prod_{|u|=k}\left(1+c_{11}\frac{\theta b^{-k}k^{2(\alpha-1)}}{\lambda-\theta b^{-k}k^{2(\alpha-1)}}\right)$$

$$\leq \exp\left\{\sum_{k=1}^{t_n}\sum_{|u|=k}c_{11}\frac{\theta b^{-k}k^{2(\alpha-1)}}{\lambda-\theta b^{-k}k^{2(\alpha-1)}}\right\} < e^{c_{\lambda}\theta t_n^{2\alpha-1}}.$$

Plugging it into (4.27) yields that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \le e^{-\frac{\theta}{\mu^{\alpha} - 1}\delta^{\alpha}(I_A(p) - \eta)^{\alpha}n^{\alpha/2} + c_{\lambda}\theta t_n^{2\alpha - 1}} + C_1e^{-c_9n^{\alpha/2}}.$$

Recall that  $t_n = O(\log n)$ . We have

$$\limsup_{n \to \infty} \frac{1}{n^{\alpha/2}} \log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \le -c_{\alpha}.$$

### 4.2 Proof of Theorem 1.4: step size has Gumbel tail distribution

In this section, we assume that the tail distribution of step size is of Gumbel's type, in other words,  $\mathbb{P}(X \geq x) = \Theta(1)e^{-e^{x^{\alpha}}}$  with  $\alpha > 0$ , for  $x \to \infty$ . In what follows, we are devoted to demonstrating that if  $I_A$  is finite and continuous at  $p = \nu(A) + \Delta$ , then

$$\lim_{n \to \infty} n^{-\frac{\alpha}{2(\alpha+1)}} \log \left[ -\log \mathbb{P}\left(\bar{Z}_n(\sqrt{n}A) - \nu(A) > \Delta\right) \right] = (y_{\alpha}I_A(p)\log b)^{\frac{\alpha}{\alpha+1}}, \tag{4.28}$$

where  $y_{\alpha} = \frac{(1+\alpha)\log B}{(1+\alpha)\log B - \log b}$ .

The ideas of proof are similar to that used in Section 4.1.2. However, we do not need to assume B > b.

### **4.2.1** Lower bound of (4.28)

As stated in Section 4.1.2, for any sufficiently small  $\delta > 0$ , there exist  $x_0 \in \mathbb{R}$ ,  $\varepsilon, \eta > 0$  such that

$$\inf_{|y-x_0| < \eta} \nu(A-x) \ge p + \delta, \ I_A(p) < x_0 - \eta < x_0 \le I_A(p) + \varepsilon.$$

Take  $d \ge b$  an integer such that  $p_d > 0$ . (Again, if  $B < \infty$ , then we choose d = B. If  $B = \infty$ , we will let  $d \to \infty$  later.) Let

$$t_n = \left\lfloor tn^{\frac{\alpha}{2(\alpha+1)}} - \frac{2\log n}{\log b} \right\rfloor, s_n = \left\lfloor \frac{\log n + t_n \log b}{\log d} \right\rfloor \wedge t_n, y_\alpha(d) = \frac{(1+\alpha)\log d}{(1+\alpha)\log d - \log b}$$

where t > 0 will be determined later on. With these d,  $t_n$ ,  $s_n$ , recall event  $\mathcal{E}_{t_n,d,b}$  from (4.8). It follows that

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \ge \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta; \mathcal{E}_{t_n,d,b}). \tag{4.29}$$

Define

$$\mathcal{M}_2 = \left\{ \zeta \in \mathcal{M} : |\zeta| = d^{s_n} + b^{t_n} - b^{s_n}, \zeta([(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}]) \ge d^{s_n} \right\}.$$

We have for any  $\zeta \in \mathcal{M}_2$ ,

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu(A - \frac{x}{\sqrt{n}}) \ge \frac{d^{s_n}}{b^{t_n} - b^{s_n} + d^{s_n}} \inf_{y \in [x_0 - \eta, x_0 + \eta]} \nu(A - y) \ge \frac{n}{n+1} (p+\delta),$$

which, together with (5) of Lemma 2.1, implies that for all n sufficiently large,

$$\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) \ge p + \delta/2.$$

Note that,  $Z_{t_n} \in \mathcal{M}_2$ , given  $\mathcal{E}_{t_n,d,b}$ . Consequently,

$$\mathbb{P}(\bar{Z}_{n}(\sqrt{n}A) \geq p; \mathcal{E}_{t_{n},d,b}) 
\geq \sum_{\zeta \in \mathcal{M}_{2}} \mathbb{P}(Z_{t_{n}} = \zeta; \mathcal{E}_{t_{n},d,b}) \mathbb{P}\left(\bar{Z}_{n-t_{n}}^{\zeta}(\sqrt{n}A) \geq p\right) 
\geq \sum_{\zeta \in \mathcal{M}_{2}} \mathbb{P}(Z_{t_{n}} = \zeta; \mathcal{E}_{t_{n},d,b}) \mathbb{P}\left(\bar{Z}_{n-t_{n}}^{\zeta}(\sqrt{n}A) \geq \frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_{n}}(\sqrt{n}A - x) - \delta/2\right) 
\geq \mathbb{P}(\mathcal{E}_{t_{n},d,b})(1 - C_{1}e^{-C_{2}|\zeta|\delta^{2}/4}),$$

where the last inequality follows from Lemma 2.2. As  $|\zeta| \geq b^{t_n}$ , for n large enough,

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \ge \frac{1}{2}\mathbb{P}(\mathcal{E}_{t_n,d,b}). \tag{4.30}$$

Recall that  $u^* = (1, \dots, 1)$  with  $|u^*| = t_n - s_n$ . It remains to consider  $\mathbb{P}(\mathcal{E}_{t_n,d,b})$ , which by (4.10) is

$$\mathbb{P}(\mathcal{E}_{t_n,d,b}) \ge p_b^{b^{t_n}} p_d^{d^{s_n}} \mathbb{P}^{\mathbf{t}}(S_u \in [(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}], \forall u > u^*, |u| = t_n). \tag{4.31}$$

Let  $\mathcal{X} = (x_0 y_\alpha(d) \log b)^{\frac{1}{\alpha+1}}$  and  $t = \frac{\mathcal{X}^\alpha}{\log b}$ . We suppose that for any ancestor of  $u^*$ :  $u \leq u^*$ ,

$$X_u \in \left[ \mathcal{X} n^{\frac{1}{2(\alpha+1)}}, \, \mathcal{X} n^{\frac{1}{2(\alpha+1)}} + \frac{\eta}{2t} n^{\frac{1}{2(\alpha+1)}} \right],$$

and that for any descendant of  $u^*$ :  $u^* \prec u$  s.t.  $|u| \leq t_n$ ,

$$X_u \in \left[ \left( \mathcal{X}^{\alpha} n^{\frac{\alpha}{2(\alpha+1)}} - (|u| + s_n - t_n) \log d \right)^{\frac{1}{\alpha}}, \left( \mathcal{X}^{\alpha} n^{\frac{\alpha}{2(\alpha+1)}} - (|u| + s_n - t_n) \log d \right)^{\frac{1}{\alpha}} + \frac{\eta}{2t} n^{\frac{1}{2(\alpha+1)}} \right].$$

This ensures that for any descendant u of  $u^*$  at the  $t_n$ -th generation, its position  $S_u$  satisfies

$$\left| S_u - \left[ (t_n - s_n) \mathcal{X} n^{\frac{1}{2(\alpha+1)}} + \sum_{k=1}^{s_n} \left( \mathcal{X}^{\alpha} - k n^{-\frac{\alpha}{2(\alpha+1)}} \log d \right)^{\frac{1}{\alpha}} n^{\frac{1}{2(\alpha+1)}} \right] \right| \le \eta \sqrt{n}/2,$$

where as  $n \to \infty$ ,  $t_n \approx t n^{\frac{\alpha}{2(\alpha+1)}}$ ,  $s_n \approx \frac{\log b}{\log d} t_n$  and

$$(t_n - s_n)\mathcal{X}n^{\frac{1}{2(\alpha+1)}} + \sum_{k=1}^{s_n} \left(\mathcal{X}^{\alpha} - kn^{-\frac{\alpha}{2(\alpha+1)}} \log d\right)^{\frac{1}{\alpha}} n^{\frac{1}{2(\alpha+1)}}$$

$$= \sqrt{n} \left[ \left(1 - \frac{\log b}{\log d}\right) t\mathcal{X} + \int_0^{\frac{\log b}{\log d}t} (\mathcal{X}^{\alpha} - x \log d)^{\frac{1}{\alpha}} dx + o_n(1) \right]$$

$$= \sqrt{n}(x_0 + o_n(1)).$$

So for all n large enough, we have

$$S_u \in [(x_0 - \eta)\sqrt{n}, (x_0 + \eta)\sqrt{n}], \quad \forall u^* \prec u, |u| = t_n.$$

As a result,

$$\mathbb{P}^{\mathbf{t}}(S_{u} \in [(x_{0} - \eta)\sqrt{n}, (x_{0} + \eta)\sqrt{n}], \forall u^{*} \prec u, |u| = t_{n})$$

$$\geq \mathbb{P}\left(X \in [\mathcal{X}n^{\frac{1}{2(\alpha+1)}}, \mathcal{X}n^{\frac{1}{2(\alpha+1)}} + \frac{\eta}{2t}n^{\frac{1}{2(\alpha+1)}}]\right)^{t_{n} - s_{n}}$$

$$\times \prod_{k=1}^{s_{n}} \mathbb{P}\left(X \in \left[\left(\mathcal{X}^{\alpha}n^{\frac{\alpha}{2(\alpha+1)}} - k\log d\right)^{\frac{1}{\alpha}}, \left(\mathcal{X}^{\alpha}n^{\frac{\alpha}{2(\alpha+1)}} - k\log d\right)^{\frac{1}{\alpha}} + \frac{\eta}{2t}n^{\frac{1}{2(\alpha+1)}}\right]\right)^{d^{k}}$$

$$\geq \left(\frac{1}{2}\right)^{d^{s_{n}+1}} c_{12}^{t_{n}-s_{n}} \exp\left\{-(t_{n}-s_{n})e^{\mathcal{X}^{\alpha}n^{\frac{\alpha}{2(\alpha+1)}}} - \sum_{k=1}^{s_{n}} d^{k}e^{\mathcal{X}^{\alpha}n^{\frac{\alpha}{2(\alpha+1)}} - k\log d}\right\}.$$

Plugging it into (4.31) implies that

$$\mathbb{P}(\mathcal{E}_{t_n,d,b}) \geq p_b^{b^{t_n}} p_d^{nb^{t_n}} \left(\frac{1}{2}\right)^{db^{t_n}} c_{12}^{t_n} \exp\left\{-t_n e^{\mathcal{X}^{\alpha} n^{\frac{\alpha}{2(\alpha+1)}}}\right\} = \exp\left\{-(1+o_n(1))t_n e^{\mathcal{X}^{\alpha} n^{\frac{\alpha}{2(\alpha+1)}}}\right\}.$$

Going back to (4.30), we hence conclude the lower bound by letting  $d \uparrow B$ .

### 4.2.2 Upper bound

Let  $B_n := [(-I_A(p) + \eta)\sqrt{n}, (I_A(p) - \eta)\sqrt{n}], t_n = \lfloor tn^{\frac{\alpha}{2(\alpha+1)}} \rfloor$  with some t > 0. Recall (4.13). One sees that for any  $\zeta \in \mathcal{M}$  and n large enough,

$$\left\{\frac{\zeta(B_n^c)}{|\zeta|} \leq \delta/2\right\} \subset \left\{\frac{1}{|\zeta|} \sum_{x \in \zeta} \nu_{n-t_n}(\sqrt{n}A - x) \leq p - \delta/4\right\}.$$

Again, similar to (4.14), we thus have

$$\mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \le \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) + C_1 e^{-c_9 b^{t_n}}.$$
(4.32)

Here we need to treat  $\mathbb{P}(Z_{t_n}(B_n^c) \geq \delta b^{t_n}/2)$  separately in the two following cases.

**Upper bound:**  $B = \infty$  In this case,  $y_{\alpha} = 1$ . By Markov inequality, we have

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le \frac{2}{\delta} b^{-t_n} \mathbb{E}[Z_{t_n}(B_n^c)]$$

$$= \frac{4}{\delta} b^{-t_n} m^{t_n} \nu_{t_n} ((I_A(p) - \eta) \sqrt{n}, \infty).$$

In view of (2) of Lemma A.2, one has immediately,

$$\liminf_{n \to \infty} \frac{1}{n^{\frac{\alpha}{2(\alpha+1)}}} \log \left[ -\log \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \right] \ge \left( \frac{I_A(p) - \eta}{t} \right)^{\alpha}.$$

In (4.32),  $b^{t_n} = \exp\{t \log bn^{\frac{\alpha}{2(\alpha+1)}}\}$ . We choose  $t = \frac{(I_A(p)-\eta)^{\frac{\alpha}{\alpha+1}}}{(\log b)^{\frac{1}{\alpha+1}}}$  so that  $t \log b = \left(\frac{I_A(p)-\eta}{t}\right)^{\alpha}$ . We thus conclude that

$$\liminf_{n\to\infty} \frac{1}{n^{\frac{\alpha}{2(\alpha+1)}}} \log \left[ -\log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta) \right] \ge ((I_A(p) - \eta)y_\alpha \log b)^{\frac{\alpha}{2(\alpha+1)}}.$$

**Upper bound:**  $b \leq B < \infty$  Following the same idea applied in (4.16), we take

$$s_n = \left\lfloor \frac{t_n \log b - \log n}{\log B} \right\rfloor, \ k_0 = t_n - s_n,$$

and reconstruct the special subtree  $\mathbf{t}_{\mathcal{J}}^*$ . It follows from the Gumbel tail distribution of X that there exists  $c_{13} \geq 1$  such that

$$\mathbb{P}(|X| \ge x) \le c_{13}e^{-e^{x^{\alpha}}}, \text{ and } \forall x \ge 0.$$

Similarly to (4.16), (4.18), (4.20) and (4.19), one sees that

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2)$$

$$\leq 2B^{t_n B^{s_n}} \left[ c_{13} t_n B^{s_n} e^{-e^{n^{\alpha}}} + c_{13}^{t_n B^{s_n}} n^{t_n B^{s_n}} \max_{\substack{x_u^* \geq 0, u \in \mathbf{t}_{\mathcal{J}}^* \\ \sum_{k=1}^{t_n} \bar{x}_k^* \geq l_1(n)}} \exp \left\{ -\sum_{u \in \mathbf{t}_{\mathcal{J}}^*} e^{(x_u^*)^{\alpha}} \right\} \right]. \quad (4.33)$$

Note that

$$\sum_{u \in \mathbf{t}_{\mathcal{T}}^*} e^{(x_u^*)^{\alpha}} \ge \sum_{k=1}^{t_n - s_n} \sum_{|u| = k} e^{(x_u^*)^{\alpha}} + \sum_{k=1}^{s_n} \sum_{|u| = k + t_n - s_n} e^{(x_u^* \vee M)^{\alpha}} - \sum_{k=1}^{s_n} B^k e^{M^{\alpha}}.$$

where  $M \geq 0$  is chosen so that  $x \mapsto e^{x^{\alpha}}$  is convex on  $[M, \infty)$ . Immediately,  $\sum_{|u|=k+t_n-s_n} e^{(x_u^* \vee M)^{\alpha}} \geq B^k e^{(\frac{\sum x_u^* \vee M}{B^k})^{\alpha}}$ . So,

$$\sum_{u \in \mathbf{t}_{\mathcal{I}}^*} e^{(x_u^*)^{\alpha}} \ge \sum_{k=1}^{t_n - s_n} e^{(\bar{x}_k^*)^{\alpha}} + \sum_{k=1}^{s_n} B^k e^{(\bar{x}_{k+t_n - s_n}^*)^{\alpha}} - \sum_{k=1}^{s_n} B^k e^{M^{\alpha}}.$$

where  $\bar{x}_k^* = \frac{\sum_{|u|=k} x_u^*}{B^{(k-t_n+s_n)_+}}$ . Let  $\Xi_n := \max\{(\bar{x}_k^*)^\alpha + (k-t_n+s_n)_+ \log B; 1 \le k \le t_n\}$ . Then,

$$\sum_{u \in \mathbf{t}_{\mathcal{J}}^*} e^{(x_u^*)^{\alpha}} \ge e^{\Xi_n} - B^{s_n+1} e^{M^{\alpha}}.$$

Plugging it into (4.33) implies that

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le e^{-(1+o_n(1))n^{\alpha}} + 2(c_{13}Bn)^{t_n} \max_{\substack{x_u^* \ge 0, u \in \mathbf{t}_{\mathcal{J}}^* \\ \sum_{t=1}^{t_n} \bar{x}_i^* \ge I(n)}} \exp\{-e^{\Xi_n} + B^{s_n+1}e^{M^{\alpha}}\}.$$
(4.34)

Note that  $\{\sum_{k=1}^{t_n} \bar{x}_k^* \ge I_1(n)\}$  implies

$$I_1(n) \le \sum_{k=1}^{t_n} \bar{x}_k^* \le (t_n - s_n) \Xi_n^{1/\alpha} + \sum_{k=1}^{s_n} (\Xi_n - k \log B)^{1/\alpha},$$

and  $\Xi_n \geq s_n \log B = (t \log b + o_n(1)) n^{\frac{\alpha}{2(\alpha+1)}}$ . Let  $K_n := \Xi_n n^{-\frac{\alpha}{2(\alpha+1)}}$ . Then,

$$(I_A(p) - \eta) + o_n(1) \le \left(1 - \frac{\log b}{\log B} + o_n(1)\right) t K_n^{1/\alpha} + \int_0^{t \log b/\log B} \left(K_n - x \log B\right)_+^{1/\alpha} dx$$

$$\le \left(1 - \frac{\log b}{\log B} + o_n(1)\right) t K_n^{1/\alpha} + \frac{\alpha K_n^{1+1/\alpha}}{(1+\alpha)\log B}.$$

In view of the right hand side of (4.34) where  $t_n B^{s_n} \leq \frac{t_n}{n} b^{t_n}$ , we take t such that  $t_n \log b \leq \Xi_n$ . In other words,  $t \leq K_n/\log b$ . This choice entails that

$$K_n^{1+1/\alpha} \left( \frac{\log B - \log b}{\log B \log b} + o_n(1) + \frac{\alpha}{(1+\alpha)\log B} \right) \ge I_A(p) - \eta + o_n(1).$$

Thus, setting  $\mathcal{X} = [(I_A(p) - \eta)y_\alpha \log b]^{\frac{\alpha}{\alpha+1}}$  and  $t = \frac{\mathcal{X}}{\log b}$ , we have

$$K_n \ge \mathcal{X}(1 + o_n(1)), \ b^{t_n} \le e^{\mathcal{X}n^{\frac{\alpha}{2(\alpha+1)}}} \text{ and } t_n B^{s_n} \log n \ll e^{\mathcal{X}n^{\frac{\alpha}{2(\alpha+1)}}}.$$

As  $\Xi_n = K_n n^{\frac{\alpha}{2(\alpha+1)}}$ , applying this to (4.34) yields that for sufficiently large n,

$$\mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2) \le e^{-(1+o_n(1))n^{\alpha}} + 2(c_{13}Bn)^{t_nB^{s_n}} \exp\left\{-e^{\mathcal{X}(1+o_n(1))n^{\frac{\alpha}{2(\alpha+1)}}} + c_{14}t_nB^{s_n}\right\}$$

$$\le e^{-(1+o_n(1))e^{n^{\alpha}}} + \exp\left\{-(1+o_n(1))e^{[(I_A(p)-\eta)y_{\alpha}\log b]^{\frac{\alpha}{\alpha+1}}n^{\frac{\alpha}{2(\alpha+1)}}}\right\}.$$

Therefore,

$$\liminf \frac{1}{n^{\frac{\alpha}{2(\alpha+1)}}} \log \left[-\log \mathbb{P}(Z_{t_n}(B_n^c) \ge \delta b^{t_n}/2)\right] \ge \left[(I_A(p) - \eta)y_\alpha \log b\right]^{\frac{\alpha}{\alpha+1}}.$$

Going back to (4.32), as  $b^{t_n} = e^{\mathcal{X}n^{\frac{\alpha}{2(\alpha+1)}}}$ , we conclude that

$$\liminf \frac{1}{n^{\frac{\alpha}{2(\alpha+1)}}} \log[-\log \mathbb{P}(\bar{Z}_n(\sqrt{n}A) - \nu(A) \ge \Delta)] \ge [(I_A(p) - \eta)y_\alpha \log b]^{\frac{\alpha}{\alpha+1}},$$

which ends the proof of the upper bound of Theorem 1.4 by letting  $\eta \downarrow 0$ .

# A Appendix

**Lemma A.1.** If  $L_0 < \bar{\Lambda}(p_1)$  and  $L_{k+1} = F(L_k) = \alpha \inf_{u \in \mathbb{R}} (-\log p_1 + \gamma(u) - uL_k) + L_k$  for any  $k \geq 0$ , then the sequence  $(L_k)_{k \geq 0}$  is non-decreasing and

$$\lim_{k \to \infty} L_k = \bar{\Lambda}(p_1) = \inf_{a > 0} \frac{\gamma(a) - \log p_1}{a}.$$

*Proof.* This sequence  $(L_k)_{k\geq 1}$  is non-decreasing, so its limit exists. In fact, if  $L\in (0,\Lambda^{-1}(\log\frac{1}{p_1}))$ , we have  $F(L)\geq L$ , in other words,

$$\inf_{u \in \mathbb{R}} \{ \gamma(u/a) - Lu/a \} + \log \frac{1}{p_1} = \inf_{u \in \mathbb{R}} \{ \gamma(u) - Lu \} + \log \frac{1}{p_1} \ge 0.$$

Note that the rate function  $\gamma$  is convex, so we only need that  $\gamma'(u) = L$  and the infimum is  $\log \frac{1}{p_1} - \Lambda(L) \ge 0$ .

Note that if  $L_k \leq \theta := \bar{\Lambda}(p_1)$ ,  $\log \frac{1}{p_1} = \Lambda(\theta)$ , and

$$L_{k+1} = \alpha(\Lambda(\theta) - \Lambda(L_k)) + L_k \le \alpha \Lambda'(\theta)(\theta - L_k) + L_k \le \theta.$$

Hence,  $\lim_{k\to\infty} L_k = L_\infty \le \theta$ . Here  $\alpha \Lambda'(\theta) \le 1$  because we need to take  $\alpha > 0$  small so that

$$\alpha \gamma(1/\alpha) - \alpha \log m \ge \inf_{a>0} \frac{\gamma(a) - \log p_1}{a} = \theta.$$

In fact, either  $1/\alpha \ge \sup_{t \in \mathbb{R}_+} \Lambda'(t) \ge \Lambda'(\theta)$ , or there exists  $t_{1/\alpha} > 0$  such that  $1/\alpha = \Lambda'(t_{1/\alpha})$  and then  $\gamma(1/\alpha) = \frac{t_{t/\alpha}}{\alpha} - \Lambda(t_{1/\alpha})$ . This follows that

$$\alpha \gamma(1/\alpha) - \alpha \log m = t_{1/\alpha} - \alpha(\Lambda(t_{1/\alpha}) + \log m) \ge \theta.$$

As  $\Lambda(t) \geq 0$ , we have  $t_{1/\alpha} > \theta$ . Consequently,  $\Lambda'(\theta) \leq \Lambda'(t_{1/\alpha}) = 1/\alpha$ .

On the other hand, as  $L_0 \leq L_k \leq \theta$ ,

$$L_{k+1} - L_k = \alpha(\Lambda(\theta) - \Lambda(L_k)) \ge \alpha \Lambda'(L_k)(\theta - L_k) \ge \alpha \Lambda'(L_0)(\theta - L_k) \ge 0.$$

This shows that  $\theta - L_k \to 0$ .

The following lemma concerns large deviation probabilities of sums of independent random variables. The results are possibly well-known to some experts or implicitly contained in some articles.

**Lemma A.2.** Suppose that  $\{X_i\}_{i\geq 1}$  is a sequence of i.i.d. random variables, having the same distribution as X. X is symmetric.

(1) If  $\mathbb{P}(X \geq x) = \Theta(1)e^{-\lambda x^{\alpha}}$  as  $x \to \infty$  with some  $\lambda > 0$  and  $\alpha > 1$ , then for a > 0, and for a sequence of integers  $(t_n)$  such that  $t_n = o(n^{\frac{1}{3}})$  and  $t_n \to \infty$ , we have

$$\limsup_{n \to \infty} \frac{t_n^{\alpha - 1}}{n^{\alpha / 2}} \log \mathbb{P}\left(\sum_{i = 1}^{t_n} X_i \ge a\sqrt{n}\right) \le -\lambda a^{\alpha}.$$

(2) If  $\mathbb{P}(X \geq x) = \Theta(1)e^{-e^{x^{\alpha}}}$  as  $x \to \infty$  with some  $\alpha > 0$ , then for any a > 0 and any sequence  $t_n \uparrow \infty$  such that  $t_n = o\left(\frac{\sqrt{n}}{(\log n)^{2/\alpha+1}}\right)$ ,

$$\liminf_{n \to \infty} \frac{t_n^{\alpha}}{n^{\alpha/2}} \log \left[ -\log \mathbb{P}\left(\sum_{i=1}^{t_n} X_i \ge a\sqrt{n}\right) \right] \ge a^{\alpha}.$$

*Proof.* It suffices to consider  $\mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \geq a\sqrt{n}\right)$ . Observe that

$$\mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \ge a\sqrt{n}\right) \le \mathbb{P}\left(\sup_{1 \le i \le t_n} |X_i| \ge n\right) + \mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \ge a\sqrt{n}, \sup_{1 \le i \le t_n} |X_i| < n\right). \tag{A.1}$$

*Proof of (1):* Note that there exists  $c_{15} > 0$  such that for any  $x \ge 0$ ,

$$\mathbb{P}(|X| \ge x) \le c_{15}e^{-\lambda x^{\alpha}}.$$

Apparently,

$$\mathbb{P}\left(\sup_{1\leq i\leq t_n}|X_i|\geq n\right)\leq t_n\mathbb{P}(|X|\geq n)\leq c_{14}t_ne^{-\lambda n^{\alpha}}.$$
(A.2)

Meanwhile,

$$\mathbb{P}\left(\sum_{i=1}^{t_{n}}|X_{i}| \geq a\sqrt{n}, \sup_{1\leq i\leq t_{n}}|X_{i}| < n\right) \\
= \sum_{x_{i}\in[0,n)\cap\mathbb{N}, i=1,\cdots,t_{n}} \mathbb{P}\left(\sum_{i=1}^{t_{n}}|X_{i}| \geq a\sqrt{n}, \sup_{1\leq i\leq t_{n}}|X_{i}| < n, |X_{i}| \in [x_{i},x_{i}+1)\right) \\
\leq \sum_{\substack{\sum_{i=1}^{t_{n}}x_{i}\geq a\sqrt{n}-t_{n};\\x_{i}\in[0,n)\cap\mathbb{N}, i=1,\cdots,t_{n}}} \mathbb{P}\left(|X_{i}| \in [x_{i},x_{i}+1], \forall 1\leq i\leq t_{n}\right) \\
\leq \sum_{\substack{\sum_{i=1}^{t_{n}}x_{i}\geq a\sqrt{n}-t_{n};\\x_{i}\in[0,n)\cap\mathbb{N}, i=1,\cdots,t_{n}}} c_{15}^{t_{n}} \exp\left\{-\lambda \sum_{i=1}^{t_{n}}x_{i}^{\alpha}\right\} \\
\leq \sum_{\substack{\sum_{i=1}^{t_{n}}x_{i}\geq a\sqrt{n}-t_{n};\\x_{i}\in[0,n)\cap\mathbb{N}, i=1,\cdots,t_{n}}} c_{15}^{t_{n}} \exp\left\{-\lambda \frac{(a\sqrt{n}-t_{n})^{\alpha}}{t_{n}^{\alpha-1}}\right\} \\
\leq (nc_{15})^{t_{n}} \exp\left\{-\lambda \frac{(a\sqrt{n}-t_{n})^{\alpha}}{t_{n}^{\alpha-1}}\right\}, \tag{A.3}$$

where in the last inequality we use the fact that the convexity of mapping  $x \mapsto x^{\alpha}$  for  $\alpha > 1$  implies

$$\sum_{i=1}^{t_n} x_i^{\alpha} \ge t_n \left( \frac{\sum_{i=1}^{t_n} x_i}{t_n} \right)^{\alpha} \ge \frac{(a\sqrt{n} - t_n)^{\alpha}}{t_n^{\alpha - 1}}.$$

Plugging (A.2) and (A.3) into (A.1), we obtain that

$$\limsup_{n \to \infty} \frac{t_n^{\alpha - 1}}{n^{\alpha / 2}} \log \mathbb{P} \left( \sum_{i = 1}^{t_n} |X_i| \ge a \sqrt{n} \right) \le -\lambda a^{\alpha},$$

which suffices to conclude (1) of Lemma A.2.

*Proof of (2):* Similarly, for any  $\varepsilon > 0$  there exists some constant  $c_{16} \geq 1$  such that

$$\mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \ge a\sqrt{n}\right) \le c_{15}t_n e^{-e^{n^{\alpha}}} + \mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \ge a\sqrt{n}, \sup_{1 \le i \le t_n} |X_i| < n\right) 
\le c_{15}t_n e^{-e^{n^{\alpha}}} + (c_{16}n)^{t_n} \exp\left\{-(1-\varepsilon)e^{\left(\frac{a\sqrt{n}}{t_n}\right)^{\alpha}}\right\},$$
(A.4)

where we use the fact

$$\sum_{i=1}^{t_n} e^{x_i^{\alpha}} \ge \exp\left\{\max_{1 \le i \le t_n} x_i^{\alpha}\right\} \ge \exp\left\{\left(\frac{\sum_{i=1}^{t_n} x_i}{t_n}\right)^{\alpha}\right\}.$$

Consequently,

$$\liminf_{n \to \infty} \frac{t_n^{\alpha}}{n^{\alpha/2}} \log \left[ -\log \mathbb{P}\left(\sum_{i=1}^{t_n} |X_i| \ge a\sqrt{n}\right) \right] \ge a^{\alpha}.$$

We have completed the proof.
