# Non-parametric estimation of time varying AR(1)-processes with local stationarity and periodicity

#### Abstract

Extending the ideas of [7], this paper aims at providing a kernel based non-parametric estimation of a new class of time varying $\operatorname{AR}(1)$ processes $\left(X_{t}\right)$, with local stationarity and periodic features (with a known period $T$ ), inducing the definition $X_{t}=a_{t}(t / n T) X_{t-1}+\xi_{t}$ for $t \in \mathbb{N}$ and with $a_{t+T} \equiv a_{t}$. Central limit theorems are established for kernel estimators $\widehat{a}_{s}(u)$ reaching classical minimax rates and only requiring low order moment conditions of the white noise $\left(\xi_{t}\right)_{t}$ up to the second order.

## 1. Introduction

Since the seminal paper [5], the local-stationarity property provides new models and approaches for introducing non-stationarity in times series. The recently published handbook [7] gives a complete survey about new results obtained since 20 years on this topics.
An interesting new kind of models is obtained from a natural extension of usual ARMA processes, so called tvARMA $(p, q)-$ processes defined in [8], as:

\sum_{j=0}^{p} \alpha_{j}\left(\frac{t}{n}\right) X_{t-j}^{(n)}=\sum_{k=0}^{q} \beta_{k}\left(\frac{t}{n}\right) \xi_{t-k}, \quad 1 \leq t \leq n \tag{1.1}
\end{equation*}
$$

where $\alpha_{j}$ and $\beta_{k}$ are bounded functions. This is a special case of locally stationary linear process defined by $X_{t}^{(n)}=\sum_{j=0}^{\infty} \gamma_{j}\left(\frac{t}{n}\right) \xi_{t-j}$. Such models has been studied in many papers, especially concerning the parametric, semi-parametric or non-parametric estimations of functions $\alpha_{j}, \beta_{k}$ or $\gamma_{j}$, or other functions depending on these functions; see, for instance references [6], [8], [7], or [3], [11], [15] or [2].

For simplicity, we restrict in this first ${ }_{1}$ work to time-varying $A R(1)$-processes

X_{t}^{(n)}=a_{t}\left(\frac{t}{n T}\right) X_{t-1}^{(n)}+\xi_{t}, \quad \text { with } a_{t+T} \equiv a_{t}, \text { for any } 1 \leq t \leq n T, n \in \mathbb{N} \tag{1.2}
\end{equation*}
$$

where $T \in \mathbb{N}^{*}$ is a fixed and known integer number, and $\left(\xi_{t}\right)$ a white noise.
The choice of such extension of the tvAR(1) processes is relative to modelling considerations: for instance, in the climatic framework, [4] considered models of air temperatures where the function of interest writes as the product of a periodic sequence by a locally varying function. This choice provide an interest-
where $\left(Z_{t}\right)$ is a sequence of i.i.d. random vectors modelling for instance exogenous inputs. This more tough case is deferred to forthcoming papers.
Time varying other models with an infinite memory may also be processed as GARCH-type models (see for instance [9]). Quote also that [10] introduced INGARCH-models, those models are GLM models; non-stationary versions of which also may be considered. They will be considered in further works.

The structure of the paper is as follows. In Section 2, we define and study asymptotic properties of non-parametric estimators for the process (1.2). Section 3 provides some Monte-Carlo results while the proofs are reported in Section 4.

## 2. Asymptotic normality of a non-parametric estimator for periodic tvAR(1) processes

### 2.1. Definition and first properties of the process

Here we denote by $T \in \mathbb{N}^{*}$ a fixed and known period.
The paper is dedicated to the simplest case $X=\left(X_{t}^{(n)}\right)_{1 \leq t \leq n T, n \in \mathbb{N}}$, of a $T$-periodic locally stationary $\mathrm{AR}(1)$-process,

$$
\begin{equation*}
X_{t}^{(n)}=a_{t}\left(\frac{t}{n T}\right) X_{t-1}^{(n)}+\xi_{t}, \quad \text { with } a_{t+T} \equiv a_{t} \quad \text { for any } \quad 1 \leq t \leq n T, n \in \mathbb{N}, \tag{2.1}
\end{equation*}
$$

where $X_{0}^{(n)}=X_{0}$ with $\mathbb{E}\left(X_{0}^{2}\right)<\infty$. Here $\left(\xi_{t}\right)_{t \in \mathbb{N}}$ is a sequence of i.i.d.r.v. satisfying $\mathbb{E}\left(\xi_{t}\right)=0$ and $\operatorname{Var}\left(\xi_{t}\right)=\sigma^{2}$ for any $t \in \mathbb{N}$.
The functions $\left(a_{s}(\cdot)\right)_{1 \leq s \leq T},[0,1] \rightarrow \mathbb{R}$ are supposed to satisfy some regularity. Hence, we provide the forthcoming definition 2.1 usually made in a nonparametric framework:
Definition 2.1. For $\rho>0$, we denote $\lceil\rho\rceil \in \mathbb{N}$ the smallest integer number such that $\lceil\rho\rceil>\rho$. A function $f: x \in \mathbb{R} \mapsto f(x) \in \mathbb{R}$ is said to belong to the class $\mathcal{C}^{\rho}\left(\mathcal{V}_{u}\right)$ where $\mathcal{V}_{u}$ is a neighbourhood of $u \in \mathbb{R}$, if $f \in \mathcal{C}^{\lceil\rho\rceil-1}\left(\mathcal{V}_{u}\right)$ and if $f^{(\lceil\rho\rceil-1)}$ is a $(1+\rho-\lceil\rho\rceil)$-Holderian function $(0<1+\rho-\lceil\rho\rceil \leq 1)$, i.e. there exists $C \geq 0$ such as

$$
\left|f^{(\lceil\rho\rceil)}\left(u_{1}\right)-f^{(\lceil\rho\rceil)}\left(u_{2}\right)\right| \leq C\left|u_{1}-u_{2}\right|^{\rho-\lceil\rho\rceil}, \quad \text { for any } u_{1}, u_{2} \in \mathcal{V}_{u}
$$

Remark that with this unusual definition, a Lipschitz function is in $\mathcal{C}^{1}$. As a consequence we specify the assumptions on functions $\left(a_{t}\right)$ using a fixed positive real number $\rho>0$ :

Assumption $(\mathbf{A}(\rho))$ : The functions $\left\{a_{t}(\cdot) ; t \in \mathbb{N}\right\}$ are such as:

1. (Periodicity) There exists $T \in \mathbb{N}^{*}$ such that $\alpha_{t}(v)=\alpha_{t+T}(v)$ for any $(t, v) \in \mathbb{N} \times[0,1]$.
2. (Contractivity) There exists $\alpha=\sup _{t \in \mathbb{N}, v \in[0,1]}\left|a_{t}(v)\right|<1$.
3. (Regularity) For any $t \in \mathbb{N}$, assume that $a_{t} \in \mathcal{C}^{\rho}$.

Remark 2.1. Quote that $T=1$ corresponds to a non-periodic case and $\left(X_{t}^{(n)}\right)$ is then a usual tvAR(1) process defined in (1.1).
First it is clear that the conditions on functions $\left(a_{s}\right)$ insure the existence of a causal linear process $\left(X_{t}^{(n)}\right)_{1 \leq t \leq n T}$ for any $n \in \mathbb{N}$ satisfying (1.2). More precisely, we obtain the following moment relationships:
Proposition 2.1. Let $X=\left(X_{t}^{(n)}\right)_{1 \leq t \leq n, n \in \mathbb{N}^{*}}$ satisfy (2.1) under Assumption $(A(\rho))$ with $\rho>0$. Then,

1. For any $n \in \mathbb{N}^{*}$ and $1 \leq t \leq n,\left|\mathbb{E}\left(X_{t}^{(n)}\right)\right| \leq \alpha^{t}\left|\mathbb{E}\left(X_{0}\right)\right|$.
2. Let $s \in\{1, \ldots, T\}$. There exists functions $\gamma_{s}^{(2)} \in \mathcal{C}^{\rho}([0,1])$ such as if $t \in\{1, \ldots, n T\}$ and $t \equiv s[T]:$

\begin{align*}
& \mathbb{E}\left(\left(X_{t}^{(n)}\right)^{2}\right)=\gamma_{s}^{(2)}\left(\frac{t}{n T}\right)+\mathcal{O}\left(\frac{1}{n}\right) \\
& \text { with }\left\{\begin{aligned}
\gamma_{s}^{(2)}(v) & =\sigma^{2} \frac{1+\sum_{i=0}^{T-1} \beta_{s, i}(v)}{1-\beta_{s, T}(v)} \\
\beta_{t, i}(v) & =\prod_{j=0}^{i-1} a_{t-j}^{2}(v) \leq \alpha^{2 i}<1
\end{aligned}\right. \tag{2.2}
\end{align*}
$$

3. Assume $\mathbb{E}\left(\xi_{0}^{4}\right)=\mu_{4}<\infty$ and $\mathbb{E}\left(\xi_{0}^{3}\right)=0$ (this holds e.g. if $\xi_{0}$ admits a symmetric distribution).
For $s \in\{1, \ldots, T\}$, there exists functions $\gamma_{s}^{(4)} \in \mathcal{C}^{\rho}([0,1])$ such as for $t \in\{1, \ldots, n T\}$ with $t \equiv s[T]$

$$
\begin{align*}
\mathbb{E}\left(\left(X_{t}^{(n)}\right)^{4}\right)=\gamma_{s}^{(4)}\left(\frac{t}{n T}\right)+\mathcal{O}\left(\frac{1}{n}\right) \\
\text { with } \quad\left\{\begin{aligned}
\gamma_{s}^{(4)}(v) & =\left(\mu_{4}+6 \sigma^{2} \gamma_{s}^{(2)}(v)\right) \frac{1+\sum_{i=0}^{T-1} \delta_{s, i}(v)}{1-\delta_{s, T}(v)} \\
\delta_{t, i}(v) & =\prod_{j=0}^{i-1} a_{t-j}^{4}(v) \leq \alpha^{4 i}<1
\end{aligned}\right. \tag{2.3}
\end{align*}
$$

Moreover, for any $\left(t, t^{\prime}\right) \in\{1, \ldots, n T\}^{2}$,

$$
\begin{equation*}
\operatorname{Cov}\left(\left(X_{t}^{(n)}\right)^{2},\left(X_{t^{\prime}}^{(n)}\right)^{2}\right)=\left(\gamma_{s^{\prime}}^{(4)}\left(\frac{t^{\prime}}{n T}\right)+\mathcal{O}\left(\frac{1}{n}\right)\right) \prod_{i=1}^{t-t^{\prime}} a_{t^{\prime}+i}^{2}\left(\frac{t^{\prime}+i}{n}\right) \tag{2.4}
\end{equation*}
$$

We will now assume $X_{0}=0$.
In addition of the previous proposition, another relation can be easily established. Indeed, for $t \in\{0,1, \ldots, n T\}$, with $s=t[T]$, by multiplying (2.1) by $X_{t}$ and taking the expectation:

$$
\begin{equation*}
a_{t}\left(\frac{t}{n T}\right)=a_{s}\left(\frac{t}{n T}\right)=\frac{\mathbb{E}\left(X_{t} X_{t-1}\right)}{\mathbb{E}\left(X_{t-1}^{2}\right)} \tag{2.5}
\end{equation*}
$$

The relation (2.5) is the foundation of the definition of the following nonparametric estimators of the functions $a_{s}(\cdot)$.

### 2.2. Asymptotic normality of the estimator

Assume that the sample $\left(X_{1}, \ldots, X_{n T}\right)$ is observed for some $n \geq 1$; this condition entails a reasonable loss of at most $T$ data and allows a more comprehensive study.
For each $s \in\{1, \ldots, T\}$, we define $I_{n, s}=\{s, s+T, \ldots, s+(n-1) T\}$, a set with $\# I_{n, s}=n$. Now for $t \in I_{n, s}$, (2.5) becomes:

$$
a_{s}\left(\frac{t}{n T}\right)=\frac{\mathbb{E}\left(X_{t} X_{t-1}\right)}{\mathbb{E}\left(X_{t-1}^{2}\right)}
$$

A convolution kernel $K: \mathbb{R} \rightarrow \mathbb{R}$ will be required in the sequel and it satisfies one of both the following assumptions:

Assumption $(K)$ : Let $K: \mathbb{R} \rightarrow \mathbb{R}^{+}$be a Borel bounded function such that:

- $\int_{\mathbb{R}} K(t) d t=1$ and $K(-x)=K(x)$ for any $x \in \mathbb{R}$;
- there exists $\beta>0$ such as $\lim _{|t| \rightarrow+\infty} e^{\beta|t|} K(t)=0$.

Assumption $(\widetilde{K})$ : Let $K: \mathbb{R} \rightarrow \mathbb{R}^{+}$be a Borel bounded function such that:

- $\int_{\mathbb{R}} K(t) d t=1$ and $K(-x)=K(x)$ for any $x \in \mathbb{R}$;
- there exists some $B>0$ such as $K(t)=0$, if $|t|>B$.

Typical examples of kernel functions are $K(t)=(2 \pi)^{-1 / 2} e^{-t^{2} / 2}$ and $K(t)=$ $\frac{1}{2} \mathbb{I}_{[-1,1]}(t)$ satisfying respectively Assumptions $(K)$ and $(\widetilde{K})$.

Assume that a sequence of positive bandwidths $\left(b_{n}\right)_{n \in \mathbb{N}}$ is chosen in such a way that

$$
\lim _{n \rightarrow \infty} b_{n}=0, \quad \lim _{n \rightarrow \infty} n b_{n}=\infty
$$

Now, keeping in mind the expression (2.5), for $s \in\{1, \ldots, T\}$ and $u \in(0,1)$, we set
$\widehat{a}_{s}^{(n)}(u)=\frac{\widehat{N}_{s}^{(n)}(u)}{\widehat{D}_{s}^{(n)}(u)}$, with $\left\{\begin{array}{l}\widehat{N}_{s}^{(n)}(u)=\frac{1}{n b_{n}} \sum_{j \in I_{n, s}} K\left(\frac{\frac{j}{n T}-u}{b_{n}}\right) X_{j} X_{j-1}, \\ \widehat{D}_{s}^{(n)}(u)=\frac{1}{n b_{n}} \sum_{j \in I_{n, s}} K\left(\frac{\frac{j}{n T}-u}{b_{n}}\right) X_{j-1}^{2} .\end{array}\right.$
since extremities are omitted we avoid the corresponding edge effects. The case $u=0$ does not make any contribution while the case $u=1$ corresponds with simple periodic behaviours and such results should be found in [12].

Using essentially a martingale central limit theorem (the steps of the proofs are precisely detailed in Section 4), we obtain:

Theorem 2.1. Let $0<\rho \leq 2$ and Assumption $(A(\rho))$, let $K$ satisfy Assumption $(K)$ or $(\widetilde{K})$. Then, for a sequence $\left(b_{n}\right)_{n \in \mathbb{N}}$ of positive real numbers such as $\lim _{n \rightarrow \infty} b_{n} n^{\frac{1}{1+2(\rho \wedge 1)}}=0$,

$$
\begin{align*}
& \quad \sqrt{n b_{n}}\left(\widehat{a}_{s}(u)-\mathbb{E}\left(\widehat{a}_{s}(u)\right)\right) \underset{n \rightarrow+\infty}{\stackrel{\mathcal{L}}{\rightarrow}} \mathcal{N}\left(0, \frac{\sigma^{2}}{\gamma_{s}^{(2)}(u)} \int_{\mathbb{R}} K^{2}(x) d x\right) \\
& \text { for any } u \in(0,1), s \in\{1, \ldots, T\}, \text { with } \gamma_{s}^{(2)}(u)=\sigma^{2} \frac{1+\sum_{i=0}^{T-1} \beta_{s, i}(u)}{1-\beta_{s, T}(u)} . \tag{2.7}
\end{align*}
$$

Note that for $\rho \leq 1$ the classical optimal semi-parametric minimax rate is reached.
This is not the case if $\rho \in(1,2]$. In that case, another moment condition is needed in order to improve the convergence rate of $\widehat{a}_{s}(u)$.
Theorem 2.2. Let $1 \leq \rho \leq 2$ and Assumption $(A(\rho))$, let $K$ satisfy Assumption $(K)$ or $(\widetilde{K})$. Moreover, suppose that $\mathbb{E}\left|\xi_{0}\right|^{\beta}<\infty$ with $\beta=4-\frac{2 \rho}{5 \rho-4} \in\left[2, \frac{10}{3}\right]$ and $\xi_{0}$ admits a symmetric distribution. Then (2.7) holds for a sequence $\left(b_{n}\right)_{n \in \mathbb{N}}$ of positive real numbers such as $b_{n} n^{\frac{1}{2 \rho+1}} \underset{n \rightarrow+\infty}{\longrightarrow} 0$.
Moreover in case $\rho=2$ and if $b_{n}=c n^{-\frac{1}{5}}$ then the central limit still holds but the limit is now non centred:
$\mathcal{N}\left(\frac{c^{\frac{5}{2}}}{\gamma_{s}^{(2)}(u)}\left(\frac{1}{2} a_{s}^{\prime \prime}(u) \gamma_{s}^{(2)}(u)+a_{s}^{\prime}(u)\left(\gamma_{s}^{(2)}\right)^{\prime}(u)\right) \int_{\mathbb{R}} z^{2} K(z) d z, \frac{\sigma^{2}}{\gamma_{s}^{(2)}(u)} \int_{\mathbb{R}} K^{2}(x) d x\right)$.
Remark 2.2. Optimal window widths write as $b_{n} \sim c n^{-\frac{1}{2 \rho+1}}$ thus the above result holds with a suboptimal window width. Moreover the symmetry assumption is discussed in Remark 4.2. Now for the case $\rho=2$ in case the derivatives of $a_{s}$ are regular around the point $u$, then the optimal window width actually may be used and the central limit theorem again holds with a non-centred Gaussian limit.
Remark 2.3. Of course, if $T=1$, Theorems 2.1 and 2.2 hold. These results provide another minimax estimation of the function $u \in[0,1] \rightarrow a(u)$ requiring sharper moment and regularity conditions than the ones proposed in Theorem 4.1 of [8].

## 3. Monte-Carlo experiments

In this section, numerous Monte-Carlo experiments have been made for studying the accuracy of the new non-parametric estimator $\widehat{a}_{s}(\cdot)$. Firstly, we considered 3 typical functions $[0,1] \rightarrow a_{s}^{(\rho)}(u) \in \mathcal{C}^{\rho}([0,1])$ and such as $\sup _{u \in[0,1], s \in \mathbb{N}}\left|a_{s}^{(\rho)}(u)\right| \leq$ $\alpha<1$ :

- For $\rho=2$, we chose $a_{s}^{(2)}(u)=0.9 \cos \left(2 \pi \frac{n u}{T}\right) \cos (3 u)$. Figure 1 exhibits the graph of the function $a_{1}^{(2)}$ and an example of its estimation (for $n=1000$ );

- For $\rho=1.5$, we chose $a_{s}^{(1.5)}(u)=0.9 \cos \left(2 \pi \frac{n u}{T}\right) \int_{0}^{u} \frac{W_{t}(\omega)}{\sup _{x \in[0,1]}\left|W_{x}(\omega)\right|} d t$ where $\left(W_{t}\right)_{t \in[0,1]}$ is an observed trajectory of a Wiener Brownian motion;
- For $\rho=0.5$, we chose $a_{s}^{(0.5)}(u)=0.9 \cos \left(2 \pi \frac{n u}{T}\right) \frac{W_{u}(\omega)}{\sup _{x \in[0,1]}\left|W_{x}(\omega)\right|}$ where $\left(W_{t}(\omega)\right)_{t \in[0,1]}$ is an observed trajectory of a Wiener Brownian motion. Figure 2 exhibits the graph of this chosen function $a_{1}^{(0.5)}$.
We also chose two "typical" kernels:
- A bounded supported kernel, the well-known Epanechnikov kernel, $K_{E}(x)=$ $\frac{3}{4}\left(1-x^{2}\right) \mathbb{1}_{\{|x| \leq 1\}}$, which is known to minimize the asymptotic MISE in the kernel density estimation frame;
- An unbounded supported kernel, the well-known Gaussian kernel defined

$$
\text { by } K_{G}(x)=\frac{1}{\sqrt{2 \pi}} \exp \left(-\frac{x^{2}}{2}\right) .
$$

We considered the cases $n=100,200,500$ and 1000 , and we fixed $T=2$. Finally 1000 independent replications of $\left(X^{(n)}\right)$ are generated with two different cases of innovations $\left(\xi_{t}\right)$ :

- Firstly, the case where the probability distribution of $\xi_{0}$ is a Gaussian $\mathcal{N}(0,4)$ distribution such as $\mathbb{E}\left|\xi_{0}\right|^{4}<\infty$ and therefore Theorem 2.1 holds for $\rho=0.5$ and Theorem 2.2 holds for $\rho=1.5$ and $\rho=2$.
- Secondly, the case where the probability distribution of $\xi_{0}$ is a Student $t(3)$ (with 3 degrees of freedom) distribution and such as $\mathbb{E}\left|\xi_{0}\right|^{\beta}<\infty$ for any $\beta<3$ but $\mathbb{E}\left|\xi_{0}\right|^{3}=\infty$. Then Theorem 2.1 holds for $\rho=0.5$ but Theorem 2.2 does not hold for $\rho=1.5$ and $\rho=2$.

Finally, for each $n$, functions $a_{s}^{(\rho)}$, kernel $K$ and probability distributions of $\xi_{0}$, we present the results computed from 1000 replications and the following methodology:

1. For each replication $j$, we defined $b_{n}=n^{-\lambda}$ with $\lambda=0.10,0.11, \ldots, 0.80$, $\left(u_{i}\right)_{1 \leq i \leq 99}=0.01,0.02, \ldots, 0.99, s=1,2, \cdots, T$, and the estimators $\widehat{a}_{s}\left(u_{i}\right)$ are computed.
2. For each replication $j$ and each $\lambda=0.10,0.11, \ldots, 0.80$, an estimator of the MISE is computed:

$$
\widehat{M I S E}_{s}(\lambda)=\frac{1}{99} \sum_{i=1}^{99}\left(\widehat{a}_{s}\left(u_{i}\right)-a_{s}\left(u_{i}\right)\right)^{2}
$$

3. For each replication $j$, we minimised an estimator of the global square root of MISE:

$$
\widehat{\lambda}_{j}=\underset{0.1 \leq \lambda \leq 0.8}{\operatorname{Arg} \min } \sum_{s=1}^{T} \sqrt{\widehat{M I S E}_{s}(\lambda)}
$$

4. Then we computed $\bar{\lambda}=\frac{1}{1000} \sum_{j=1}^{1000} \widehat{\lambda}_{j}$ over all the replications.
5. Finally, we computed the estimator of the minimal global square root of MISE,

$$
\overline{M I S E^{1 / 2}}=\frac{1}{1000} \sum_{j=1}^{1000} \sum_{s=1}^{T} \sqrt{\widehat{M I S E}_{s}\left(\widehat{\lambda}_{j}\right)}
$$

As a consequence, $\bar{\lambda}$ and $\overline{M I S E^{1 / 2}}$ are two interesting estimators relative to Theorems 2.1 and 2.2. The first one specifies the link between the choice of an optimal bandwidth $b_{n}$ qnd the regularity $\rho$ of the functions $a_{s}(\cdot)$. The second one measures the optimal convergence rate of the estimators $\widehat{a}_{s}(\cdot)$ to $a_{s}(\cdot)$. All the results are printed in Tables 1 and 2.

Conclusions of the simulations: Firstly, and as it should be deduced from Theorem 2.1 and 2.2, we observed the larger the regularity $\rho$, the smaller $\bar{\lambda}$

and therefore the larger the optimal bandwidth $\overline{b_{n}}=n^{-\bar{\lambda}}$, and the faster the convergence rate of $\widehat{a}_{s}$. Secondly, even if the choice of the optimal bandwidth is significantly different following the choice of the kernel (clearly smaller with the Epanechnikov kernel), the optimal convergence rate is almost the same for both the kernel. Finally, according also with Theorem 2.2, the convergence rate is clearly slower with a heavy tail distribution $(t(3))$ than with a Gaussian distribution, and this phenomenon increases when $\rho$ increases.

## 4. Proofs

We first provide the proof of Proposition 2.1.
Proof of Proposition 2.1.

- Finally, in the case $\rho \in \mathbb{N}^{*}$, we can use the previous case an a TaylorLagrange expansion of the function $c$, implying $R(u, v)=\frac{c^{(\rho)}(\theta)}{\rho!}|u-v|^{\rho}$ with $\theta=\lambda u+(1-\lambda) v$ and $\lambda \in[0,1]$.
Then, using (4.13) and with $\mu_{u}(z) \in[0,1]$, and $\zeta_{n}=\int_{\mathbb{R}} h_{n}(v) c(v) d v-$ $c(u) \int_{\mathbb{R}} h_{n}(v) d v$

\mathbb{E}\left|J_{n}-J_{n, M}\right| \leq C \sqrt{n b_{n}}\left(\frac{A_{n}}{n b_{n}}+b_{n}\right) h^{1 / 4}(M) \tag{4.43}
\end{equation*}
$$

since $x \rightarrow|a(x)-a(u)|$ is a $\mathcal{C}^{1}$ function (in the above defined sense). Finally, using Cauchy-Schwartz inequality in (4.38), we obtain for $M$ large enough,

$$
\begin{align*}
\mathbb{E}\left|J_{n}\right| & \leq \mathbb{E}\left|J_{n}-J_{n, M}\right|+\sqrt{\operatorname{Var}\left(J_{n, M}\right)} \\
& \leq C\left(\sqrt{n b_{n}}\left(\frac{A_{n}}{n b_{n}}+b_{n}\right) h^{1 / 4}(M)+\left(\frac{A_{n}}{n b_{n}}+b_{n}^{\rho}\right)^{1 / 2} M h^{1 / 2}(M)\right) \\
& \leq C\left(\sqrt{n b_{n}^{3}} h^{1 / 4}(M)+b_{n}^{\rho / 2} M h^{1 / 2}(M)\right) \tag{4.44}
\end{align*}
$$

assuming $A_{n} / n b_{n}=o\left(b_{n}^{\rho / 2}\right)$ i.e. $\left(n / A_{n}\right)^{-2 /(2+\rho)}=o\left(b_{n}\right)$ (and note that $-2 /(2+\rho) \leq 1 /(1+2 \rho))$.
Now, if $\mathbb{E}\left(\left|\xi_{0}\right|^{\beta}\right)<\infty$ with $\beta \in(2,4]$, then using Holder and Markov Inequalities, there exists $C_{\beta}>0$ such as

$$
h(M)=\mathbb{E}\left(\left|\xi_{0}\right|^{2} \mathbb{I}_{\left\{\left|\xi_{0}\right|>M\right\}}\right) \leq C_{\beta} M^{2-\beta}
$$

Since here $b_{n}=o\left(n^{-1 /(1+2 \rho)}\right)$, does not yields the minimax rates, we deduce that

$$
\left\{\begin{array}{lll}
\sqrt{n b_{n}^{3}} h^{1 / 4}(M) \underset{n \rightarrow+\infty}{\longrightarrow} 0 & \text { when } & M^{1+2 \rho} \geq n^{(4 \rho-4) /(\beta-2)} \\
b_{n}^{\rho / 2} M h^{1 / 2}(M) \underset{n \rightarrow+\infty}{\longrightarrow} 0 & \text { when } & M^{1+2 \rho} \leq n^{\rho /(4-\beta)}
\end{array}\right.
$$

Thus, from inequality (4.44), we deduce that the optimal choice is obtained when

$$
\frac{4 \rho-4}{\beta-2}=\frac{\rho}{4-\beta}, \quad \text { which entails } \beta=4-2 \cdot \frac{\rho}{5 \rho-4}
$$

d. Case $\rho=2$.

The expression of the non-central limit for the case of optimal window widths and the expansion of the bias (4.31) now the asymptotics expression for (4.33) yields the proposed noncentred Gaussian limit, see Remark 4.1. The same truncation step as above is also needed.
The proof is now complete.

Remark 4.1. Using the previous bound (4.30) of $\mathbb{E} J_{n}$ and Bienaymé-Tchebychev inequality, we deduce that if $b_{n}=o\left(n^{-1 /(1+2 \rho)}\right)$ then $J_{n} \underset{n \rightarrow+\infty}{\xrightarrow{\mathbb{P}}} 0$.
Moreover, if $\rho=2$ and $b_{n}=c n^{-1 / 5}$, using the expansion (4.31) of $\mathbb{E} J_{n}$ and again Bienaymé-Tchebychev inequality, then $J_{n} \underset{n \rightarrow+\infty}{\stackrel{\mathbb{P}}{\rightarrow}} B_{s}(u) c^{5 / 2}$.
Therefore with the consistency result (4.28), for any $u \in(0,1)$ and $s \in\{1, \ldots, T\}$,

$$
\frac{J_{n}}{\widehat{D}_{s}^{(n)}(u)} \underset{n \rightarrow+\infty}{\stackrel{\mathbb{P}}{\rightarrow}} B_{s}(u) \frac{c^{\frac{5}{2}}}{\sigma^{2}} \frac{1+\sum_{i=0}^{T-1} \beta_{s, i}(u)}{1-\beta_{s, T}(u)}
$$

Remark 4.2. For the general case with maybe $\xi_{0}$ non symmetric and $\mathbb{E} \xi_{0}=0$, the item 3. of Proposition 2.1 needs some improvements. Denote $w_{t}^{(k)}=\mathbb{E}\left(X_{t}^{k}\right)$ for $k=1,3$, then $w_{t}^{(4)}=w_{t}$ and $w_{t}^{(2)}=v_{t}$, then (4.7) turns to be written

$$
\begin{equation*}
w_{t}=q_{t} w_{t-1}+4 \mathbb{E} A_{t} \mathbb{E} X_{t-1} \mu_{3}+6 \sigma^{2} v_{t}+\mu_{4} \leq \alpha^{4} w_{t-1}+r(t), \tag{4.45}
\end{equation*}
$$

as previously $\sup _{t} w_{t}<\infty$.
We need to derive suitable equivalents of $w_{t}^{(k)}$ if $k=1$. Firstly

$$
w_{t}^{(1)}=\mathbb{E} A_{t} w_{t-1}^{(1)}=\cdots=E A_{t} \cdots \mathbb{E} A_{1} \cdot \mathbb{E} X_{0}
$$

and in fact this term is negligible and the proof of Proposition 2.1 and Lemma 3. remains unchanged.

In this case the proof of the above point $\mathbf{2 / c}$. needs a simple improvement and

$$
\xi_{j, M}=\xi_{j} \wedge M \vee(-M)-\mathbb{E}\left(\xi_{j} \wedge M \vee(-M)\right)
$$

In this truncated setting, inequality (4.40) writes:

$$
\begin{aligned}
\left|X_{j-1, M}^{(n)}-X_{j-1}^{(n)}\right| \leq \alpha \mid X_{j-2, M}^{(n)}- & X_{j-2}^{(n)} \mid \\
& +\left|\xi_{j-1}\right| \mathbb{I}_{\left\{\left|\xi_{j-1}\right|>M\right\}}+\mathbb{E}\left(\left|\xi_{j-1}\right| \mathbb{I}_{\left\{\left|\xi_{j-1}\right|>M\right\}}\right)
\end{aligned}
$$

so that the end of the proof is unchanged by only setting $C=2 c \mathbb{E} \xi_{0}^{2} /(1-\alpha)$.
Remark 4.3. Secondly, in case we even omit the condition $\mathbb{E} \xi_{0}=0$ one needs to also express an asymptotic expansion for $w_{t}^{(3)}=\mathbb{E} A_{t}^{3} w_{t-1}^{(3)}+3 \mathbb{E} A_{t} w_{t-1}^{(1)} \sigma^{2}+\mu_{3} \sim$ $\mathbb{E} A_{t}^{3} w_{t-1}^{(3)}+\mu_{3}$; an analogue expansion to Proposition 2.1 and Lemma 3. may thus be derived. Namely $w_{t}^{(3)}=\gamma_{s}^{(3)}\left(\frac{t}{n T}\right)+\mathcal{O}\left(\frac{1}{n}\right)$, with

$$
\begin{aligned}
\gamma_{s}^{(3)}(v) & =\mu_{3} \cdot \frac{1+\sum_{i=0}^{T-1} \zeta_{s, i}(v)}{1-\zeta_{s, T}(v)} \\
\zeta_{t, i}(v) & =\prod_{j=0}^{i-1} a_{t-j}^{3}(v) \leq \alpha^{3 i}<1, \quad \text { for } \quad 1 \leq i \leq T, \quad v \in(0,1)
\end{aligned}
$$

Then the expression of the equivalent of $w_{t}$ is also adequately transformed up to the above relations.
