Characterization and occurrence of squash chlorotic leaf spot virus, a tentative new
 torradovirus species infecting cucurbits in Sudan

14 Abstract

During a survey conducted in Sudan in 2012, a virus with spherical particles was isolated from a squash plant showing chlorotic leaf spots. The virus was transmitted mechanically and by two whitefly species, but not by aphids. RT-PCR with generic torradovirus primers yielded a band of expected size from total RNA of a symptomatic plant. Next-generation sequencing confirmed that this is tentatively a new torradovirus species, for which we propose the name 'squash chlorotic leaf spot virus'. Using specific RT-PCR primers, the virus was detected in cucurbit samples collected since 1992 at different locations in Sudan.

In Sudan, cucurbit crops are severely affected by a number of viruses transmitted by aphids, 29 whiteflies or beetles [1, 2, 4, 5]. During a survey conducted in 2012, severe chlorotic leaf 30 spots were observed on a squash (*Cucurbita moschata*) plant in a farm located at Fadasi, near 31 Wad Medani (Gezira State, Sudan) (Fig. 1a). A leaf sample (Su12-10) was tested by DAS-32 ELISA, and no positive reaction was observed using IgGs and alkaline phosphatase 33 conjugated IgGs prepared in our laboratory for some of the most common cucurbit viruses 34 occurring in Sudan (cucumber mosaic virus, cucumber vein yellowing virus (CVYV), 35 36 cucurbit aphid-borne yellows virus, melon rugose mosaic virus, Moroccan watermelon mosaic virus, papaya ringspot virus, snake melon asteroid mosaic virus, squash mosaic virus 37 38 (SqMV), watermelon chlorotic stunt virus (WmCSV) and zucchini yellow mosaic virus (ZYMV)) [1-3]. After mechanical inoculation of sap extracts in 0.03 M Na₂HPO₄ containing 39 40 0.2% diethyldithiocarbamate to zucchini squash (Cucurbita pepo) cv Diamant in a quarantine greenhouse, very severe mosaic symptoms, leaf curling and limited necrosis developed within 41 42 two weeks after inoculation. Leaf-dip observation using a Philips CM10 (Eindhoven, The Netherlands) electron microscope and ammonium molybdate as a contrasting agent showed 43 the presence of a few isometric virus particles circa 30 nm in diameter and a number of 44 slightly flexuous filamentous particles. Extracts from a symptomatic plant were again tested 45 with DAS-ELISA, and a positive reaction was observed only for CVYV. This virus was 46 probably present at a too low concentration in the original sample to be detected by DAS-47 ELISA in the first test. 48

After two serial mechanical transmissions to zucchini squash, neither CVYV nor flexuous 49 particles were detected, while the severe symptoms and the small spherical particles were still 50 observed (Fig. 1b and c). After mechanical inoculation of the spherical virus alone, squash (C. 51 moschata) cv. Pleine de Naples and cv. Menina developed chlorotic leaf spot symptoms 52 similar to those observed in the field. In order to further characterize the spherical virus, 53 vector transmission experiments were conducted using aphids and whiteflies. No transmission 54 was observed when 10 Myzus persicae or Aphis gossypii were deposited on each of 10 55 zucchini squash plants, using non-persistent transmission conditions (3 min acquisition access 56 period (AAP), 2 h inoculation access period (IAP)). Similarly, no transmission was observed 57 58 when 20 M. persicae or A. gossypii were deposited on each of 10 or 3 zucchini squash plants, respectively, using persistent transmission conditions (1 day AAP, 3 days IAP). Using circa 59 60 50 whiteflies per plant, Bemisia tabaci biotype Q transmitted the virus to 3 and 4 out of 6 zucchini squash plants after AAPs of 6 and 30 h, respectively. In similar conditions, *Trialeurodes vaporariorum* transmitted the virus to 2 and 1 out of 6 zucchini squash plants
after AAPs of 6 and 30 h, respectively. The shape of the particles and transmission properties
of the virus suggested the presence of a torradovirus.

65 Total RNA was extracted from 50 mg of a zucchini squash plant showing severe symptoms 66 using TRI-reagent (Molecular Research Center Inc., Cincinnati, OH), resuspended in 20 µl of RNase-free H₂O, and heated for 5 min at 65°C before RT-PCR reaction. Polyvalent primers 67 Torrado-1F/Torrado-1R designed to amplify torradoviruses [8] were used in an RT-PCR 68 reaction. A PCR signal of the expected size (371 nt) was obtained with sample Su12-10 and 69 was directly sequenced. A BLASTn search in GenBank revealed 76 %-nt identity with Carrot 70 torradovirus 1 RNA1 (KF533719). Total RNA (1µg) of Su12-10 was used for preparation of 71 72 small RNAs suitable for Illumina HiSeq sequencing (Fasteris SA, Switzerland). A total number of 14,252,180 reads of 21-24 nt was obtained. De novo assembly using the CLC 73 74 Genomics Workbench 7 (CLC Bio, Aarhus, Denmark) generated two large viral contigs of 5690 and 4020 nt, respectively. A BLASTn search performed with these two contigs against 75 76 GenBank yielded 67%-nt identity of a 843 nt segment with Carrot torradovirus 1 RNA1 (KF533719), and 65%-nt identity of a 246 nt segment with Cassava torrado-like virus RNA2 77 78 (KC505251), respectively.

The 3' extremities were sequenced using an oligo(dT) primer and a 5' primer specific for each 79 80 RNA based on the sequence obtained by NGS. The 5' extremities were sequenced by 5'RACE using an Invitrogen (Paisley, UK) kit according to the manufacturer's manual. The 81 82 genome is constituted of two RNAs of 7046 and 4730 bases, respectively, excluding the 3'terminal polyA tail. Mapping of the Illumina reads on the complete sequence with the CLC 83 workbench, indicated a depth of coverage of 3199x for RNA1 and 4216x for RNA2. RNA1 84 85 putatively encodes a large protein of 2207 amino-acids with an expected molecular weight of 246 kDa, containing conserved helicase, protease and RNA-dependent RNA-polymerase 86 motifs present in all torradoviruses so far [7]. As for other torradoviruses, RNA2 contained 87 two ORFs corresponding to proteins of 233 aa (26 kDa) and 1054 aa (115 kDa), with an 88 overlap of 116 nt; nt positions of ORF 1 and 2 are 84-783 and 667-3229 respectively (Fig. 2). 89 Low-stringency protein BLAST analysis on the two major ORFs revealed a limited similarity 90 (35-40% identity) with known torradoviruses. In addition, two putative small ORFs of 432 nt 91 92 and 306 nt respectively were detected in silico in the 3' parts of RNA1 and RNA2. These two small ORFs were not reported in other torradoviruses and had no identity in Blast analysis 93

with any sequence in the databases. More studies are required to determine if these putative
ORFs are biologically significant. If the small putative ORFs are not considered, the 5' and 3'
untranslated regions (UTRs) of RNA1 are 231 and 437 nt long, respectively. The putative 5'
and 3'UTRs of RNA2 are 83 nt and 904 nt long, respectively. This is within the range of
lengths observed for other torradoviruses, which display a great variability in UTR lengths,
with often very long 3'UTRs, up to 1.2kb [7].

Nucleotide and amino-acid sequences of the new virus were aligned using ClustalW included 100 101 in MEGA6 [6] with full-length sequences of the genome of acknowledged or putative torradoviruses: Tomato torrado virus (GenBank accessions DQ3888879 and DQ388880 for 102 RNA1 and RNA2 respectively), Tomato marchitez virus (EF681764-765), tomato chocolate 103 virus (FJ560489-490), tomato chocolate spot virus (GQ305131-132), Lettuce necrotic leaf 104 105 curl virus (KC855266-267), tomato necrotic dwarf virus (KC999058-059), carrot torradovirus 1 (KF533719-720) and motherwort yellow mottle virus (KM229700-701). Nucleotide 106 107 sequence identity between the cucurbit-infecting virus and the 8 acknowledged or tentative torradoviruses were 44-46% and 40-42% for RNA1 and RNA2 respectively, whereas aa 108 sequence identities were 31-34%, 20-27% and 31.7-33.3% for RNA1 ORF1, RNA2 ORF1 109 and RNA2 ORF2 respectively. Neighbour-joining or maximum likelihood tree reconstruction 110 on different alignments (full-length nucleotide sequences of RNA1 or RNA2, aa sequences of 111 the different ORFs, "Pro-Pol" as sequence of ORF1 [7]) yielded similar clusterings, with two 112 main branches containing the tomato-infecting torradoviruses vs. the other acknowledged 113 torradoviruses, and the cucurbit virus rather basal within the torradovirus tree (Fig. 2 and data 114 not shown). 115

116 Two primers were defined based on the first partial sequence of Su12-10. TorrCuc-5 CGCGGATTGTTGATGATGGC (position 4585-4604) and TorrCuc-3 117 AGTCGTTCATGGTGACTCCG (position 4770-4789) were designed for the amplification of 118 a 205 nt fragment in the RdRp-coding region of RNA1. For RT-PCR experiments, total RNA 119 was denatured by heating for 2 min at 80°C and quickly chilling on ice. The RT step was 120 done for 45 min at 42°C using AMV reverse transcriptase (Promega, Madison, WI) and 121 primer TorrCuc2-3. PCR was performed in a second step using Taq polymerase (Promega) 122 with 2µl of RT products with a 3 min denaturation time at 94°C, 40 cycles with a 30 s 123 denaturation time at 94 °C, a 30 s annealing time at 60 °C, a 45 s elongation time at 72 °C, 124 125 followed by a 10 min final elongation cycle at 72 °C.

A host range study was undertaken that included two plants of four cucurbit species (C. pepo 126 127 (zucchini squash), Cucumis melo (melon), Cucumis sativus (cucumber) and Citrullus lanatus (watermelon)) and of 20 non-cucurbit species (Brassica rapa, Capsella bursa-pastoris, 128 129 Capsicum annuum, Chenopodium amaranticolor, C. quinoa, Lactuca sativa, Lavatera trimestris, 130 Nicotiana benthamiana, N. clevelandii, , N. glutinosa, N. tabacum cv. Xanthi, Petunia hybrida, 131 Phaseolus vulgaris, Physalis floridana, Pisum sativum, Salvia splendens, Solanum lycopersicum, Valerianella officinalis, Vigna sinensis and Zinnia elegans). Plants were mechanically inoculated 132 133 with extracts from a zucchini squash showing severe symptoms. This experiment was repeated once. Three weeks after inoculation, local and systemic symptoms were rated, and 134 135 total RNA extracts were prepared from each plant and tested by RT-PCR using the specific RT-PCR primers. Symptoms were observed on the four cucurbit species, and all RT-PCR 136 137 tests were positive, producing bands of the expected size. Zucchini squash developed severe mosaic symptoms, leaf curling, stunting and few necrotic spots. In other cucurbits, symptoms 138 were slight yellow mottle in melon, small chlorotic spots mostly along the veins in cucumber, 139 140 and local and systemic necrotic lesions in watermelon. None of the non-cucurbit species developed symptoms, including tomato and lettuce, which are known hosts of torradoviruses 141 [7], while all RT-PCR tests in these hosts were negative except with extracts from 142 symptomless N. benthamiana and N. clevelandii, which all yielded a band of the expected 143 144 size. All RT-PCR tests done with extracts from non-inoculated control plants were negative.

Based on its biological, morphological and molecular properties, we propose that the virus with spherical particles isolated from squash sample Su12-10 is a tentative new member of genus *Torradovirus*, for which we suggest the name squash chlorotic leaf spot virus (SCLSV).

Since primers TorrCuc-5 and TorrCuc-3 displayed some cross-reactivity with SqMV in some 149 field samples (data not shown), a new primer pair was designed in the 5' part of RNA2 150 CCGTGGGCCTCCGATCCCCC TorrCuc2-3 (TorrCuc2-5 and 151 TGCCTCTAGAGGCCAGGCG, positions 696-714 and 1282-1300 respectively in SCLSV 152 RNA2) using sequences generated by NGS. This primer pair allowed the amplification of a 153 605 bp fragment located in the partially overlapping ORF1 and ORF2 of RNA2. RT-PCR 154 155 conditions were the same as described above for primers TorrCuc-5 and TorrCuc-3. RT-PCR tests were done with these primers on samples collected in 2012, as well as on samples 156 157 collected during previous surveys conducted in Sudan in 1992, 1993, 1995, 2002 and 2003. 158 These samples were kept either as crude extracts or as total RNA extracts at -20°C. Of the 380

samples tested, 36 (9.5%) were positive in RT-PCR for SCLSV. This was confirmed by 159 sequencing the RT-PCR products. Positive samples were from snake melon (C. melo var 160 flexuosus) (23 out of 193 tested; 11.9%), melon (5/44; 11.4%), squash (3/37; 8.1%) 161 watermelon (3/75; 4%) and wild Cucumis species (2/16; 12.5%). None of the 15 samples of 162 Luffa sp., Lagenaria sp. and Momordica charantia were positive in RT-PCR. Positive 163 samples were found only from locations along the Nile River (Wad Medani, Khartoum, 164 Shendi, Atbara) covering a 400 km transect from Gezira scheme (Gezira State) in the South to 165 Atbara (Nile State) in the North. Interestingly, positive reactions were obtained for samples 166 167 originating from the same farm as Su12-10 that were collected in 1992 and 2003, indicating that the virus is well established in the environment. 168

Sequence analyses revealed up to 6.4% nucleotide divergence between samples in the 170 171 sequenced region. Two clusters of sequences could be defined (Fig. 3), without obvious correlation to the host plant of the samples. However, a partial correlation with the geographic 172 173 origin of the samples was noticed. All but 3 samples from Wad Medani region grouped in one cluster, while all samples from the Northern part of the transect (Shendi, Atbara) grouped in 174 175 the second cluster. Mixed infections with isolates from the same cluster were observed in one sample from Wad Medani (cluster 1) and two samples from Shendi and Atbara (cluster 2). 176 One of the isolates from 1992 originating from Fadasi (Wad Medani area) was divergent from 177 both groups (Fig. 3). 178

SCLSV probably remained unnoticed until now because it was often found in mixed infections with other severe viruses, such as WmCSV or ZYMV. SCLCV occurrence in wild *Cucumis* sp., potential reservoirs growing all year round in Sudan, and the abundance of whitefly vectors in Sudan are favourable ecological factors for SCLSV maintenance in the environment. To the best of our knowledge, this is the first report of a torradovirus infecting cucurbits, and one of the earliest (1992) reports of a torradovirus infection.
