ON MORI CONE OF BOTT TOWERS

ABSTRACT. A Bott tower of height r is a sequence of projective bundles

$$X_r \xrightarrow{\pi_r} X_{r-1} \xrightarrow{\pi_{r-1}} \cdots \xrightarrow{\pi_2} X_1 = \mathbb{P}^1 \xrightarrow{\pi_1} X_0 = \{pt\},\$$

where $X_i = \mathbb{P}(\mathcal{O}_{X_{i-1}} \oplus \mathcal{L}_{i-1})$ for a line bundle \mathcal{L}_{i-1} over X_{i-1} for all $1 \leq i \leq r$ and $\mathbb{P}(-)$ denotes the projectivization. These are smooth projective toric varieties and we refer to the top object X_r also as a Bott tower. In this article, we study the Mori cone and numerically effective (nef) cone of Bott towers, and we classify Fano, weak Fano and log Fano Bott towers. We prove some vanishing theorems for the cohomology of tangent bundle of Bott towers. We give some applications to Bott-Samelson-Demazure-Hansen (BSDH) varieties, by using the degeneration of a BSDH variety to a Bott tower. We also recover the results in [PK16], by toric methods.

Keywords: Bott towers, Bott-Samelson-Demazure-Hansen varieties, Mori cone, primitive relations and toric varieties.

1. INTRODUCTION

In [BS58], R. Bott and H. Samelson introduced a family of (smooth differentiable) manifolds which may be viewed as the total spaces of iterated \mathbb{P}^1 -bundles over a point $\{pt\}$, where each \mathbb{P}^1 -bundle is the projectivization of a rank 2 decomposable vector bundle. In [GK94], M. Grossberg and Y. Karshon proved (in complex geometry setting) that these manifolds have a natural action of a compact torus and also obtained some applications to representation theory and symplectic geometry. In [Civ05], Y. Civan proved that these are smooth projective toric varieties. These are called Bott towers, we denote them by $\{(X_i, \pi_i) : 1 \leq i \leq r\}$, where

$$X_r \xrightarrow{\pi_r} X_{r-1} \xrightarrow{\pi_{r-1}} \cdots \xrightarrow{\pi_2} X_1 = \mathbb{P}^1 \xrightarrow{\pi_1} \{pt\},\$$

 $X_i = \mathbb{P}(\mathcal{O}_{X_{i-1}} \oplus \mathcal{L}_{i-1})$ for a line bundle \mathcal{L}_{i-1} over X_{i-1} for all $1 \leq i \leq r$ and r is the dimension of X_r . In [CS11], [CMS10] and [Ish12], the authors studied "cohomological rigidity" properties of Bott towers. These also play an important role in algebraic topology and K-theory (see [CR05], [DJ91] and references therein). In this article we refer to X_r also as a Bott tower (it is also called Bott manifold).

On the other hand, Bott-Samelson-Demazure-Hansen (for short, BSDH) varieties are also iterated projective line bundles, but where each projective bundle is the projectivization of certain rank 2 vector bundle (not necessarily decomposable). The BSDH varieties were algebraically constructed by M. Demazure and H.C. Hansen independently

by adapting a differential geometric approach from the paper of R. Bott and H. Samelson (see [BS58], [Dem74] and [Han73]). These are natural desingularizations of Schubert varieties by factoring the Schubert variety using Bruhat decomposition, and these are dependent on the given expression of the Weyl group element corresponding to the Schubert variety (see for instance [CKP15, Page 32]). We also see in this paper some properties of these varieties which depend on the given expression.

In [GK94], M. Grossberg and Y. Karshon constructed degenerations of BSDH varieties to Bott towers, by complex geometric methods. In [Pas10] B. Pasquier and in [PK16] A.J. Parameswaran and P. Karuppuchamy constructed these toric degenerations algebraically. B. Pasquier used these degenerations to study the cohomology of line bundles on BSDH varieties (see [Pas10]). In [PK16], the authors studied the limiting toric variety for a simple simply connected algebraic group by geometric methods.

In this paper we study the geometry of Bott towers in more detail by methods of toric geometry and we prove some applications to BSDH varieties. We also recover the results in [PK16] and extend them to the Kac-Moody setting.

We work over the field \mathbb{C} of complex numbers. We study the **Mori cone** of X_r and prove that the class of curves corresponding to 'primitive relations $r(P_i)$ ' forms a basis of the real vector space of numerical classes of one-cycles in X_r (see Theorem 5.7 and Corollary 5.8). An extremal ray R in the Mori cone is called **Mori ray** if $R \cdot K_{X_r} < 0$, where K_{X_r} is the canonical divisor in X_r . We describe extremal rays and Mori rays of the Mori cone of X_r (see Theorem 9.1). We characterize the ampleness and numerically effectiveness of line bundles on X_r (see Lemma 6.1) and describe the generators of the *nef* cone of X_r (see Theorem 6.7).

Recall that a smooth projective variety X is called **Fano** (respectively, **weak Fano**) if its anti-canonical divisor $-K_X$ is ample (respectively, *nef* and *big*). Following [AS14], we say that a pair (X, D) of a normal projective variety X and an effective Q-divisor D is **log Fano** if it is Kawamata log terminal and $-(K_X + D)$ is ample (see Section 8 for more details). We study the Fano, weak Fano and the log Fano (of the pair (X_r, D) for a suitably chosen divisor D in X_r) properties of the Bott tower X_r .

To describe these results we need some notation. It is known that a Bott tower $\{(X_i, \pi_i) : 1 \leq i \leq r\}$ is uniquely determined by an upper triangular matrix M_r with integer entries, defined via the first Chern class of the line bundles \mathcal{L}_{i-1} on X_{i-1} , where $X_i = \mathbb{P}(\mathcal{O}_{X_{i-1}} \oplus \mathcal{L}_{i-1})$ for $1 \leq i \leq r$ (see [GK94, Section 2.3], [Civ05] and [VT15, Section 7.8]). For more details see Section 2. Let

$$M_r := \begin{bmatrix} 1 & \beta_{12} & \beta_{13} & \dots & \beta_{1r} \\ 0 & 1 & \beta_{23} & \dots & \beta_{2r} \\ 0 & 0 & 1 & \dots & \beta_{3r} \\ \vdots & \vdots & & \ddots & \vdots \\ 0 & \dots & \dots & & 1 \end{bmatrix}_{r \times r}$$

where β_{ij} 's are integers. Define for $1 \leq i \leq r$,

$$\eta_i^+ := \{r \ge j > i : \beta_{ij} > 0\}$$

and

$$\eta_i^- := \{ r \ge j > i : \beta_{ij} < 0 \}.$$

If $|\eta_i^+| = 1$ (respectively, $|\eta_i^+| = 2$), then let $\eta_i^+ = \{m\}$ (respectively, $\eta_i^+ = \{m_1, m_2\}$). If $|\eta_i^-| = 1$ (respectively, $|\eta_i^-| = 2$), then set $\eta_i^- = \{l\}$ (respectively, $\eta_i^- = \{l_1, l_2\}$).

The following can be viewed as a condition on i^{th} row of the matrix M_r :

- N_i^1 is the condition that $|\eta_i^+| = 0$ and $|\eta_i^-| = 0$.
- N_i² is the condition that

 (i) |η_i⁺| = 0, |η_i⁻| ≤ 1, and if |η_i⁻| = 1 then β_{il} = -1; or
 (ii) |η_i⁻| = 0, |η_i⁺| ≤ 1, and if |η_i⁺| = 1 then β_{im} = 1 and β_{mk} = 0 for all k > m.

 N_i³ is the condition that

 Case 1: Assume that |η_i⁺| = 0. Then |η_i⁻| ≤ 2, and if |η_i⁻| = 1(respectively, 2) then β_{li} = -1 or -2 (respectively, β_{il1} = -1 = β_{il2}).

Case 2: If $|\eta_i^-| = 1 = |\eta_i^+|$ and l < m, then $\beta_{il} = -1$, $\beta_{im} = 1$ and $\beta_{mk} = 0$ for all k > m.

Case 3: Assume that $|\eta_i^+| = 1$. Then $\beta_{im} = 1$ and either it satisfies (i) Case 2; or

(ii) $|\eta_i^-| = 0$ and $\beta_{mk} = 0$ for all k > m; or

(iii) there exists unique $r \ge s > m$ such that

- $\beta_{ms} \beta_{is} = 1$ and $\beta_{mk} \beta_{ik} = 0$ for all k > s, or
- $\beta_{ms} \beta_{is} = -1$ and $\beta_{is} \beta_{ms} \beta_{sk} = 0$ for all k > s.

Definition 1.1. We say X_r satisfies <u>condition I</u>, <u>condition II</u> or <u>condition III</u> if N_i^1 , N_i^2 or N_i^3 holds for all $1 \le i \le r$ respectively.

Remark 1.2.

- Let $1 \leq i \leq r$. We have $N_i^1 \Longrightarrow N_i^2 \Longrightarrow N_i^3$.
- If X_r satisfies condition I, then it also satisfies conditions II and III.
- If X_r satisfies condition II, then it also satisfies condition III.

1.1. Results for Bott towers. We prove,

Theorem (See Theorem 7.2).

- (1) X_r is Fano if and only if it satisfies II.
- (2) X_r is weak Fano if and only if it satisfies III.

As a consequence we get some vanishing results for the cohomology of tangent bundle of Bott towers and hence local rigidity results. Let T_{X_r} denote the tangent bundle of X_r .

Corollary (see Corollary 7.3 and Corollary 7.4). If X_r satisfies II, then $H^i(X_r, T_{X_r}) = 0$ for all $i \ge 1$. In particular, X_r is locally rigid.

For $1 \leq i \leq r$, we define some constants k_i which again depend on the given matrix M_r corresponding to the Bott tower X_r (for more details see Section 8). We prove,

Theorem (see Theorem 8.1). The pair (X_r, D) is log Fano if and only if $k_i < 0$ for all $1 \le i \le r$.

1.2. Results for BSDH varieties. Let G be a Kac-Moody group (for the definition see [Kum12]). Let B be a Borel subgroup containing a fixed maximal torus T. Let W be the Weyl group corresponding to the pair (G, B, T) and let $w \in W$. Let $\tilde{w} := s_{\beta_1} \cdots s_{\beta_n}$ be an

expression (possibly non-reduced) of w in simple reflections and let $Z(\tilde{w})$ be the BSDH variety corresponding to \tilde{w} (see Section 2). Let $X_{\tilde{w}}$ be the toric limit of $Z(\tilde{w})$ constructed as in [Pas10] and [PK16] (see Section 3, do not confuse with the notation, $X_{\tilde{w}}$ does NOT denote a Schubert variety). Note that $X_{\tilde{w}}$ is a Bott tower (see Corollary 3.5). We prove that the ample cone $Amp(X_{\tilde{w}})$ of $X_{\tilde{w}}$ can be identified with a subcone of the ample cone $Amp(Z(\tilde{w}))$ of $Z(\tilde{w})$ (see Corollary 10.1).

When G is a simple algebraic group and the expression \tilde{w} is reduced, Fanoness and weak Fanoness of the BSDH variety $Z(\tilde{w})$ are considered in [Cha17]. Here we have the following results: Let $\tilde{w} = s_{\beta_1} \cdots s_{\beta_i} \cdots s_{\beta_j} \cdots s_{\beta_r}$ be an expression (remember that β_k 's are simple roots). Let $\beta_{ij} := \langle \beta_j, \check{\beta}_i \rangle$, where $\check{\beta}_i$ is the co-root of β_i . We use the same terminology for BSDH varieties as in Bott tower case above.

Corollary (See Corollary 10.2).

(1) If $Z(\tilde{w})$ satisfies II, then $Z(\tilde{w})$ is Fano.

(2) If $Z(\tilde{w})$ satisfies III, then $Z(\tilde{w})$ is weak Fano.

In [AS14], D. Anderson and A. Stapledon studied the log Fanoness of Schubert varieties, and in [And14], log Fanoness of BSDH varieties is studied for chosen divisors. Let D' be a divisor in $Z(\tilde{w})$ with support in the boundary. For $1 \leq i \leq r$, we define some constants f_i which depend on the given expression \tilde{w} (for more details see Section 10).

Theorem (see Theorem 10.5). The pair $(Z(\tilde{w}), D')$ is log Fano if $f_i > 0$ for all $1 \le i \le r$.

When G is a simple algebraic group in [CKP15] and [CK17], we obtained some vanishing results of the cohomology of tangent bundle of $Z(\tilde{w})$ when \tilde{w} is reduced, and in [CKP] the case \tilde{w} is non-reduced was considered. Here we get some vanishing results for $Z(\tilde{w})$ in our case and hence some rigidity results, by using its toric limit as a Bott tower. Let $T_{Z(\tilde{w})}$ denote the tangent bundle of $Z(\tilde{w})$.

Corollary (see Corollary 10.6). If $Z(\tilde{w})$ satisfies II, then $H^i(Z(\tilde{w}), T_{Z(\tilde{w})}) = 0$ for all $i \geq 1$. In particular, $Z(\tilde{w})$ is locally rigid.

The paper is organized as follows:

In Section 2, we discuss preliminaries on Bott towers, BSDH varieties and toric varieties. In Section 3, we recall the algebraic construction of toric degeneration of BSDH variety. We describe the limiting toric variety as an iterated \mathbb{P}^1 -bundle, a Bott tower. In Section 4, we discuss the Picard group of the Bott tower and compute the relative tangent bundle.

Section 5 contains detailed study of primitive collections and primitive relations of the Bott tower and we also describe the Mori cone. In Section 6 we describe ample and *nef* line bundles on the Bott tower, and we also find the generators of the *nef* cone.

In Section 7 and 8, we study Fano, weak Fano and log Fan properties for Bott towers. We observe that these properties depend on the given matrix corresponding to the Bott tower and we also see some vanishing results. In Section 9, we describe extremal rays and Mori rays for the Bott tower and we see some applications. Section 10 contains some applications to the BSDH-varieties and their toric limits. In Section 11, we give another proof of the results in [PK16] by toric methods.

2. Preliminaries

In this section we recall toric varieties (see [CLS11]), Bott towers (see [Civ05] and [VT15]) and Bott-Samelson-Demazure-Hansen varieties (see [Kum12]). We work throughout the article over the field \mathbb{C} of complex numbers. We expect that the proofs work for algebraically closed fields of arbitrary characteristic, but did not find appropriate references in that generality.

2.1. Toric varieties. We briefly recall the structure of toric varieties from [CLS11] (see also [Ful93] and [Oda88]).

Definition 2.1. A normal variety X is called a toric variety (of dimension n) if it contains an n-dimensional torus T (i.e. $T = (\mathbb{C}^*)^n$) as a Zariski open subset such that the action of the torus on itself by multiplication extends to an action of the torus on X.

Toric varieties are completely described by the combinatorics of the corresponding fans. We briefly recall here, let N be the lattice of one-parameter subgroups of T and let Mbe the lattice of characters of T. Let $M_{\mathbb{R}} := M \otimes \mathbb{R}$ and $N_{\mathbb{R}} := N \otimes \mathbb{R}$. Then we have a natural bilinear pairing

$$\langle -, - \rangle : M_{\mathbb{R}} \times N_{\mathbb{R}} \to \mathbb{R}.$$

A fan Σ in $N_{\mathbb{R}}$ is a collection of convex polyhedral cones that is closed under intersections and cone faces. Let $\check{\sigma}$ be the dual cone of $\sigma \in \Sigma$ in $M_{\mathbb{R}}$. For $\sigma \in \Sigma$, the semigroup algebra $\mathbb{C}[\check{\sigma} \cap M]$ is a normal domain and finitely generated \mathbb{C} -algebra. Then the scheme $Spec(\mathbb{C}[\check{\sigma} \cap M])$ is called the affine toric variety corresponding to σ . For a given fan Σ , we can define a toric variety X_{Σ} by gluing the affine toric varieties $Spec(\mathbb{C}[\check{\sigma} \cap M])$ as σ varies in Σ . For all $1 \leq s \leq n$,

$$\Sigma(s) := \{ \sigma \in \Sigma : \dim(\sigma) = s \}.$$

For each $\rho \in \Sigma(1)$, we denote u_{ρ} , the generator of $\rho \cap N$. For $\sigma \in \Sigma$,

$$\sigma(1) := \Sigma(1) \cap \sigma.$$

There is a bijective correspondence between the cones in Σ and the *T*-orbits in X_{Σ} . For each $\sigma \in \Sigma$, the dimension $\dim(O(\sigma))$ of the *T*-orbit $O(\sigma)$ corresponding to σ is $n - \dim(\sigma)$. Let $\tau, \sigma \in \Sigma$, then τ is a face of σ if and only if $O(\sigma) \subset \overline{O(\tau)}$, where $\overline{O(\sigma)}$ is the closure of *T*-orbit $O(\sigma)$. We denote $V(\sigma) = \overline{O(\sigma)}$ and it is a toric variety with the corresponding fan being $\operatorname{Star}(\sigma)$, the star of σ which is the set of cones in Σ which have σ as a face. Let $D_{\rho} = \overline{O(\rho)}$ be the torus-invariant prime divisor in X_{Σ} corresponding to $\rho \in \Sigma(1)$. The group $TDiv(X_{\Sigma})$ of *T*-invariant divisors in X_{Σ} is given by

$$TDiv(X_{\Sigma}) = \bigoplus_{\rho \in \Sigma(1)} \mathbb{Z}D_{\rho}.$$

For each $m \in M$, the character χ^m of T is a rational function on X_{Σ} and the corresponding divisor is given by

$$div(\chi^m) = \sum_{\rho \in \Sigma(1)} \langle m, u_\rho \rangle D_\rho.$$

2.2. Bott towers. In this section we recall some basic definitions and results on Bott towers. Let \mathcal{L}_0 be a trivial line bundle over a single point $X_0 := \{pt\}$, and let $X_1 := \mathbb{P}(\mathcal{O}_{X_0} \oplus \mathcal{L}_0)$, where $\mathbb{P}(-)$ denotes the projectivization. Let \mathcal{L}_1 be a line bundle on X_1 , then define $X_2 := \mathbb{P}(\mathcal{O}_{X_1} \oplus \mathcal{L}_1)$, which is a \mathbb{P}^1 -bundle over X_1 . Repeat this process *r*-times, so that each X_i is a \mathbb{P}^1 -bundle over X_{i-1} for $1 \leq i \leq r$. We get the following:

$$X_{r} = \mathbb{P}(\mathcal{O}_{X_{r-1}} \oplus \mathcal{L}_{r-1})$$

$$\downarrow^{\pi_{r}}$$

$$X_{r-1} = \mathbb{P}(\mathcal{O}_{X_{r-2}} \oplus \mathcal{L}_{r-2})$$

$$\downarrow^{\pi_{r-1}}$$

$$\vdots$$

$$\downarrow^{\pi_{2}}$$

$$X_{1} = \mathbb{P}(\mathcal{O}_{X_{0}} \oplus \mathcal{L}_{0})$$

$$\downarrow^{\pi_{1}}$$

$$X_{0} = \{pt\}$$

For each $1 \leq i \leq r$, X_i is a smooth projective toric variety (see [Civ05, Theorem 22]). Consider the points [1:0] and [0:1] in \mathbb{P}^1 , we call them the south pole and the north pole respectively. The zero section of \mathcal{L}_{i-1} gives a section $s_i^0 : X_{i-1} \longrightarrow X_i$, the south pole section; similarly, the north pole section $s_i^1 : X_{i-1} \longrightarrow X_i$ by letting the first coordinate in $\mathbb{P}(\mathcal{O}_{X_{i-1}} \oplus \mathcal{L}_{i-1})$ to vanish.

Let $1 \leq i \leq r$. Since $\pi_i : X_i \longrightarrow X_{i-1}$ is a projective bundle, by a standard result on the cohomology ring of projective bundles we have the following (see [Har77, Page 429] for instance):

Theorem 2.2. The cohomology ring $H^*(X_i, \mathbb{Z})$ of X_i is a free module over $H^*(X_{i-1}, \mathbb{Z})$ on generators 1 and u_i , which have degree 0 and 2 respectively, that is

$$H^*(X_i,\mathbb{Z}) = H^*(X_{i-1},\mathbb{Z}) \mathbb{1} \oplus H^*(X_{i-1},\mathbb{Z}) u_i.$$

The ring structure is determined by the single relation

$$u_i^2 = c_1(\mathcal{L}_{i-1})u_i,$$

where $c_1(-)$ denotes the first Chern class and the restriction of u_i to the fibre $\mathbb{P}^1 \subset X_i$ is the first Chern class of the canonical line bundle over \mathbb{P}^1 . Hence we have

$$H^*(X_i, \mathbb{Z}) = H^*(X_{i-1}, \mathbb{Z})[u_i]/J_i,$$

where J_i is the ideal generated by $u_i^2 - c_1(\mathcal{L}_{i-1})u_i$.

Consider the exponential sequence (see [Har77, Page 446]):

$$0 \longrightarrow \mathbb{Z} \longrightarrow \mathcal{O}_{X_{i-1}} \longrightarrow \mathcal{O}_{X_{i-1}}^* \longrightarrow 0$$

Then we get the following exact sequence:

$$0 \longrightarrow H^{1}(X_{i-1}, \mathbb{Z}) \longrightarrow H^{1}(X_{i-1}, \mathcal{O}_{X_{i-1}}) \longrightarrow H^{1}(X_{i-1}, \mathcal{O}^{*}_{X_{i-1}}) \xrightarrow{c_{1}(-)} H^{2}(X_{i-1}, \mathbb{Z}) \longrightarrow H^{2}(X_{i-1}, \mathcal{O}_{X_{i-1}}) \longrightarrow \cdots$$

Since X_{i-1} is toric, we have $H^j(X_{i-1}, \mathcal{O}_{X_{i-1}}) = 0$ for all j > 0 (see [Oda88, Corollary 2.8]). As $H^1(X_{i-1}, \mathcal{O}^*_{X_{i-1}}) = Pic(X_{i-1})$, we get $c_1(-) : Pic(X_{i-1}) \xrightarrow{\sim} H^2(X_{i-1}, \mathbb{Z})$. Then we have the following:

Theorem 2.3. Each line bundle \mathcal{L}_{i-1} on X_{i-1} is determined (up to algebraic isomorphism) by its first Chern class, which can be written as a linear combination

$$c_1(\mathcal{L}_{i-1}) = -\sum_{k=1}^{i-1} \beta_{ki} u_k \in H^2(X_{i-1}, \mathbb{Z}),$$

where β_{ik} 's are integers for $1 \leq k \leq i-1$.

Then by Theorem 2.2 and 2.3, by iteration, we get the following:

Corollary 2.4. We have

$$H^*(X_r,\mathbb{Z}) = \mathbb{Z}[u_1,\ldots,u_r]/J,$$

where J is the ideal generated by $\{u_j^2 + \sum_{i < j} \beta_{ij} u_i u_j : 1 \leq j \leq r\}$ and the integers β_{ij} 's are as in Theorem 2.3.

Write $\{\beta_{ij} : 1 \le i < j \le r\}$, the collection of r(r-1)/2 integers, as an upper triangular $r \times r$ matrix

$$M_r := \begin{bmatrix} 1 & \beta_{12} & \beta_{13} & \dots & \beta_{1r} \\ 0 & 1 & \beta_{23} & \dots & \beta_{2r} \\ 0 & 0 & 1 & \dots & \beta_{3r} \\ \vdots & \vdots & & \ddots & \vdots \\ 0 & \dots & \dots & & 1 \end{bmatrix}_{r \times r}$$
(2.1)

Then we get the following result (see for instance [GK94, Lemma 2.15] and also [Civ05, Section 3]).

Corollary 2.5. There is a bijective correspondence between {Bott towers of height r} and $\{r \times r \text{ upper triangular matrices with integer entries as in (2.1)}\}.$

Two Bott towers $\{(X_i, \pi_i) : 1 \leq i \leq r\}$ and $\{(X'_i, \pi'_i) : 1 \leq i \leq r\}$ are isomorphic if there exists a collection of isomorphisms $\{\phi_i : X_i \to X'_i : 1 \leq i \leq r\}$ such that the following diagram is commutative:

2.2.1. Toric structure on Bott tower. Let $\{e_1^+, \ldots, e_r^+\}$ be the standard basis of the lattice \mathbb{Z}^r . Define, for all $i \in \{1, \ldots, r\}$,

$$e_i^- := -e_i^+ - \sum_{j>i} \beta_{ij} e_j^+,$$
(2.2)

where β_{ij} 's are integers as above. Then we have the following theorem (see [Civ05, Section 3 and Theorem 22] and for algebraic topology setting see [VT15, Theorem 7.8.7]):

Theorem 2.6. The Bott tower $\{(X_i, \pi_i) : 1 \le i \le r\}$ corresponding to a matrix M_r as in (2.1) is isomorphic to $\{(X_{\Sigma_i}, \pi_{\Sigma_i}) : 1 \le i \le r\}$, the collection of smooth projective toric varieties corresponding to the fan Σ_i with the 2^i maximal cones generated by the set of vectors

$$\{e_j^{\epsilon}: 1 \leq j \leq i \text{ and } \epsilon \in \{+, -\}\},\$$

and where $\pi_{\Sigma_i} : X_{\Sigma_i} \to X_{\Sigma_{i-1}}$ is the toric morphism induced by the projection $\overline{\pi_{\Sigma_i}} : \mathbb{Z}^i \to \mathbb{Z}^{i-1}$ for all $1 \leq i \leq r$.

Note that by Theorem 2.6, Σ_i has 2*i* one-dimensional cones generated by the vectors

$$\{e_j^+, e_j^- : 1 \le j \le i\},$$

and by (2.2), we can see that the divisors $D_{\rho_j^+}$ corresponding to e_j^+ for $1 \le j \le i$ form a basis of the Picard group of X_i (see Section 4 for more details).

2.3. **BSDH varieties.** Let $A = (a_{ij})_{1 \le i,j \le n}$ be a generalized Cartan matrix. Let G be the Kac-Moody group associated to A (see [Kum12, Chapter IV]). Fix a maximal torus T and a Borel subgroup B containing T. Let $S := \{\alpha_1, \ldots, \alpha_n\}$ be the set of all simple roots of (G, B, T). We denote s_{α_i} the simple reflection corresponding to α_i . Note that the Weyl group W of G is generated by

$$\{s_{\alpha_i}: 1 \le i \le n\}.$$

Let $w \in W$, an expression \tilde{w} of w is a sequence $(s_{\beta_1}, \ldots, s_{\beta_r})$ of simple reflections $s_{\beta_1}, \ldots, s_{\beta_r}$ such that $w = s_{\beta_1} \cdots s_{\beta_r}$. An expression \tilde{w} of w is said to be reduced if the number r of simple reflections is minimal. In such case we call r the length of w. By abuse of notation, we also denote the expression \tilde{w} by $\tilde{w} = s_{\beta_1} \cdots s_{\beta_r}$. For $\alpha \in S$, we denote P_{α} , the minimal parabolic subgroup of G generated by B and a representative of s_{α} .

Definition 2.7. Let $w \in W$ and $\tilde{w} := s_{\beta_1} \cdots s_{\beta_r}$ be an expression (not necessarily reduced) of w. The Bott-Samelson-Demazure-Hansen (for short, BSDH) variety corresponding to \tilde{w} is

$$Z(\tilde{w}) := P_{\beta_1} \times \cdots \times P_{\beta_r} / B^r,$$

where the action of B^r on $P_{\beta_1} \times \cdots \times P_{\beta_r}$ is defined by

 $(p_1,\ldots,p_r)\cdot(b_1,\ldots,b_r)=(p_1b_1,b_1^{-1}p_2b_2,\ldots,b_{r-1}^{-1}p_rb_r)$ for all $p_i\in P_{\beta_i},b_i\in B$.

These are smooth projective varieties of dimension r. There is a natural morphism $\phi_{\tilde{w}}: Z(\tilde{w}) \longrightarrow G/B$ defined by

$$[(p_1,\ldots,p_r)]\mapsto p_1\cdots p_r B.$$

If \tilde{w} is reduced, the BSDH variety $Z(\tilde{w})$ is a natural desingularization of the Schubert variety, the *B*-orbit closure of wB/B in G/B (see [Dem74], [Han73] and [Kum12, Chapter VIII]).

We can also construct the BSDH variety by iterated \mathbb{P}^1 -bundles. Let $\tilde{w}' := s_{\beta_1} \cdots s_{\beta_{r-1}}$. Let $f: G/B \longrightarrow G/P_{\beta_r}$ be the map given by $gB \mapsto gP_{\beta_r}$ and let $p: Z(\tilde{w}') \longrightarrow G/P_{\beta_r}$ be the map given by $[(p_1, \ldots, p_{r-1})] \mapsto p_1 \cdots p_{r-1}P_{\beta_r}$. Then we have the following cartesian diagram (see [BK07, Page 66] and [Kum12, Chapter VII]):

Note that $f_{\tilde{w}}$ is a \mathbb{P}^1 -fibration and the relative tangent bundle $T_{f_{\tilde{w}}}$ of $f_{\tilde{w}}$ is $\phi_{\tilde{w}}^*(\mathcal{L}_{\beta_r})$, where \mathcal{L}_{β_r} is the homogeneous line bundle on G/B corresponding to β_r . Using the cohomology of the relative tangent bundle $T_{f_{\tilde{w}}}$ we studied the cohomology of the tangent bundle of $Z(\tilde{w})$, when G is finite dimensional and \tilde{w} is a reduced expression (see [CKP15] and [CK17]). In Section 3, we compute the relative tangent bundle of the corresponding toric limits, in the more general setting of Bott towers. The fibration $f_{\tilde{w}}$ comes with a natural section $\sigma_{\tilde{w}}: Z(\tilde{w}') \to Z(\tilde{w})$ induced by the projection

$$P_{\beta_1} \times \cdots \times P_{\beta_r} \to P_{\beta_1} \times \cdots \times P_{\beta_{r-1}}.$$

For the toric limits we get two natural sections, as will be explained in Section 3. For all $i \in \{1, \ldots, r\}$, we denote Z_i , the divisor in $Z(\tilde{w})$ defined by

$$\{[(p_1,\ldots,p_r)]\in Z(\tilde{w}): p_i\in B\}$$

In [LT04], N. Lauritzen and J.F. Thomsen proved that Z'_is forms a basis of the Picard group of $Z(\tilde{w})$ and they also proved that if \tilde{w} is a reduced expression these form a basis of the monoid of effective divisors (see [LT04, Proposition 3.5]). Recently, the effective divisors of $Z(\tilde{w})$ for \tilde{w} non-reduced case have been considered in [And14].

3. Toric degeneration of a BSDH variety

In [GK94], toric degenerations of BSDH varieties to Bott towers, were constructed by complex geometric methods. In [Pas10] and [PK16] they have given an algebraic construction for toric degeneration of a BSDH variety. We recall the algebraic construction here.

Note that the simple roots are linearly independent elements in the character group of G. We can choose a positive integer q and a injective morphism $\lambda : \mathbb{G}_m \longrightarrow T$ (i.e. $\lambda \in N$ and λ is injective) such that for all $1 \leq i \leq n$ and $u \in \mathbb{G}_m$, $\alpha_i(\lambda(u)) = u^q$ (see [Pas10, Page 2836]). When G is finite dimensional, for each one-parameter subgroup $\lambda \in N$, define

$$P(\lambda) := \{ g \in G : \lim_{u \to 0} \lambda(u) g \lambda(u)^{-1} \text{ exists in } G \}.$$

The set $P(\lambda)$ is a parabolic subgroup and the unipotent radical $R_u(P(\lambda))$ of $P(\lambda)$ is given by

$$R_u(P(\lambda)) = \{g \in G : \lim_{u \to 0} \lambda(u)g\lambda(u)^{-1} \text{ is identity in } G\}.$$

Any parabolic subgroup of G is of this form (see [Spr10, Proposition 8.4.5]). Choose a one-parameter subgroup $\lambda \in N$ such that the corresponding parabolic subgroup is B.

Let us define an endomorphism of G for all $u \in \mathbb{G}_m$ by

$$\Psi_u: G \to G, \quad g \mapsto \lambda(u)g\lambda(u)^{-1}$$

Let \mathcal{B} be the set of all endomorphisms of B. Now define a morphism

$$\Psi: \mathbb{G}_m \to \mathcal{B} \text{ by } u \mapsto \Psi_u|_B$$

This map can be extended to 0 and for all $x \in U$, $\Psi_u|_B(x)$ goes to identity when u goes to zero. Let $\mathbb{A}^1 := Spec\mathbb{C}[t]$ be the affine line over \mathbb{C} . We denote for all $u \in \mathbb{A}^1$, Ψ_u the image of u in \mathcal{B} . Note that Ψ_u is the identity on T and Ψ_0 is the projection from B to T.

Let $\tilde{w} = s_{\beta_1} \cdots s_{\beta_r}$ be an expression.

Definition 3.1.

(i) Let \mathcal{X} be the variety defined by

$$\mathcal{X} := \mathbb{A}^1 \times P_{\beta_1} \times \cdots \times P_{\beta_r} / B^r,$$

where the action of B^r on $\mathbb{A}^1 \times P_{\beta_1} \times \cdots \times P_{\beta_r}$ is given by

$$(u, p_1, \dots, p_r) \cdot (b_1, \dots, b_r) = (u, p_1 b_1, \Psi_u (b_1)^{-1} p_2 b_2, \dots, \Psi_u (b_{r-1})^{-1} p_r b_r).$$

(ii) For all $i \in \{1, \ldots, r\}$, we denote \mathcal{Z}_i the divisor in \mathcal{X} defined by

$$\{(u, p_1, \ldots, p_r) \in \mathcal{Z} : p_i \in B\}.$$

Note that \mathcal{X} and $\mathcal{Z}'_{i}s$ are integral. Let $\pi : \mathcal{X} \to \mathbb{A}^{1}$ be the projection onto the first factor. Then we have the following theorem (see [Pas10, Proposition 1.3 and 1.4] and [PK16, Theorem 9]).

Theorem 3.2.

- (1) $\pi: \mathcal{X} \to \mathbb{A}^1$ is a smooth projective morphism.
- (2) For all $u \in \mathbb{A}^1 \setminus \{0\}$, the fiber $\pi^{-1}(u)$ is isomorphic to the BSDH variety $Z(\tilde{w})$ such that $\pi^{-1}(u) \cap \mathcal{Z}_i$ corresponds to the divisor Z_i in $Z(\tilde{w})$.
- (3) $\pi^{-1}(0)$ is a smooth projective toric variety.

Now onwards, we denote $\mathcal{X}_u := \pi^{-1}(u)$ for $u \in \mathbb{A}^1$ and the limiting toric variety $\mathcal{X}_0 = \pi^{-1}(0)$ by $X_{\tilde{w}}$ (do not confuse with the Schubert variety).

Recall that $\{e_1^+, \ldots, e_r^+\}$ is the standard basis of the lattice \mathbb{Z}^r . Define, for all $i \in \{1, \ldots, r\}$,

$$e_i^- := -e_i^+ - \sum_{j>i} \beta_{ij} e_j^+, \tag{3.1}$$

here we take $\beta_{ij} := \langle \beta_j, \check{\beta}_i \rangle$. The following proposition will give the description of the fan of the toric variety $X_{\tilde{w}}$ (see [Pas10, Proposition 1.4]).

Proposition 3.3.

(1) The fan Σ of the smooth toric variety $X_{\tilde{w}}$ consists of the cones generated by subsets of

$$\{e_1^+, \dots, e_r^+, e_1^-, \dots, e_r^-\}$$

and containing no subset of the form $\{e_i^+, e_i^-\}$.

(2) For all $i \in \{1, ..., r\}, \mathcal{Z}_i^0$ is the irreducible $(\mathbb{C}^*)^r$ -stable divisor in $X_{\tilde{w}}$ corresponding to the one-dimensional cone of Σ generated by e_i^+ and these form a basis of the divisor class group of $X_{\tilde{w}}$.

Note that the maximal cones of Σ are generated by $\{e^\epsilon_i: 1\leq i\leq r, \epsilon\in\{+,-\}\}$.

In [Pas10], B. Pasquier used the combinatorics of the toric variety $X_{\tilde{w}}$ to obtain vanishing theorems for the cohomology of line bundles on BSDH variety $Z(\tilde{w})$.

Now we describe the toric limit $X_{\tilde{w}}$ as an iterated \mathbb{P}^1 -bundle. Let $\tilde{w}' := s_{\beta_1} \cdots s_{\beta_{r-1}}$. Then we get a toric morphism

$$f_r: X_{\tilde{w}} \to X_{\tilde{w}'}$$

induced by the lattice map

$$\overline{f}_r: \mathbb{Z}^r \to \mathbb{Z}^{r-1}$$

the projection onto the first r-1 coordinates.

We prove,

Lemma 3.4.

- (1) $f_r: X_{\tilde{w}} \to X_{\tilde{w}'}$ is a toric \mathbb{P}^1 -fibration with two disjoint toric sections.
- (2) $X_{\tilde{w}} \simeq \mathbb{P}(\mathcal{O}_{X_{\tilde{w}'}} \oplus \mathscr{L})$ for some unique line bundle \mathscr{L} on $X_{\tilde{w}'}$.

Proof. Let Σ' be the fan corresponding to the toric variety $X_{\tilde{w}'}$. From the above proposition, we can see that Σ has a splitting by Σ' and $\{e_r^+, 0, e_r^-\}$. Then by [CLS11, Theorem 3.3.19],

$$f_r: X_{\tilde{w}} \to X_{\tilde{w}'}$$

is a locally trivial fibration with the fan Σ_F of the fiber being $\{e_r^+, 0, e_r^-\}$. Since Σ_F is the fan of the projective line \mathbb{P}^1 , we conclude f_r is a toric \mathbb{P}^1 -fibration. As toric sections of the toric fibration correspond to the maximal cones in Σ_F , we get two disjoint toric sections for f_r . This proves (1).

Proof of (2): Since $f_r : X_{\tilde{w}} \to X_{\tilde{w}'}$ is \mathbb{P}^1 -fibration with a section, we see $X_{\tilde{w}}$ is a projective bundle $\mathbb{P}(\mathscr{E})$ over $X_{\tilde{w}'}$ corresponding to a rank 2 vector bundle \mathscr{E} on $X_{\tilde{w}'}$ (see for example [Har77, Chapter V, Proposition 2.2, page 370]).

Recall that the sections of projective bundle $X_{\tilde{w}} = \mathbb{P}(\mathscr{E})$ correspond to the quotient line bundles of \mathscr{E} (see [Har77, Proposition 7.12]). Since $X_{\tilde{w}} = \mathbb{P}(\mathscr{E})$ is projective line bundle on $X_{\tilde{w}'}$ with two disjoint sections, we see \mathscr{E} is decomposable as a direct sum of line bundles on $X_{\tilde{w}'}$.

As

$$\mathbb{P}(\mathscr{E}) \simeq \mathbb{P}(\mathscr{L}' \otimes \mathscr{E})$$

for any line bundle \mathscr{L}' on $X_{\tilde{w}'}$ (see [Har77, Lemma 7.9]), we can assume without loss of generality

$$\mathscr{E} = \mathcal{O}_{X_{\widetilde{w}'}} \oplus \mathscr{L}$$

for some unique line bundle \mathscr{L} on $X_{\tilde{w}'}$. Hence $X_{\tilde{w}} \simeq \mathbb{P}(\mathcal{O}_{X_{\tilde{w}'}} \oplus \mathscr{L})$ and this completes the proof of the lemma. \Box

Then by definition of Bott tower we get:

Corollary 3.5. The toric limit $X_{\tilde{w}}$ is a Bott tower.

We have the following situation:



4. On Picard group of a Bott tower

Now we describe a basis of the Picard group $Pic(X_r)$ of X_r .

Let $\epsilon \in \{+, -\}$ and for $1 \leq i \leq r$, let ρ_i^{ϵ} be the one-dimensional cone generated by e_i^{ϵ} . For all $1 \leq i \leq r$, we define $D_{\rho_i^{\epsilon}}$ to be the toric divisor corresponding to the one-dimensional cone ρ_i^{ϵ} .

We prove,

Lemma 4.1. The set $\{D_{\rho_i^{\epsilon}} : 1 \leq i \leq r \text{ and } \epsilon \in \{+, -\}\}$ forms a basis of $Pic(X_r)$.

Proof. By Theorem 2.6, using the description of the one-dimensional cones we have the following decomposition of $\Sigma(1)$:

$$\Sigma(1) = \{\rho_i^+ : 1 \le i \le r\} \cup \{\rho_i^- : 1 \le i \le r\}.$$
(4.1)

Again by Theorem 2.6, $\{D_{\rho_i^+}: 1 \leq i \leq r\}$ forms a basis of the Picard group $Pic(X_r)$ of X_r . Since

$$0 \sim div(\chi^{e_i^+}) = \sum_{\rho \in \Sigma(1)} \langle u_\rho, e_i^+ \rangle D_\rho,$$

by (2.2) we can see that $\{D_{\rho_i^-} : 1 \le i \le r\}$ also forms a basis of $Pic(X_r)$.

In general, let $\sigma \in \Sigma$ be the maximal cone generated by $\{e_i^{\epsilon} : 1 \leq i \leq r\}$. Take the torus-fixed point x^{ϵ} in X_r corresponding to the maximal cone σ . Let U be the torus-invariant open affine neighbourhood of x^{ϵ} in X_r . Then U is an affine space of dimension r; in particular, Pic(U) = 0. Therefore, we get

$$X_r \setminus U = \cup_{i=1}^r D_{\rho_i^{\epsilon}}$$

and $Pic(X_r)$ is generated by

$$\{D_{\rho_i^{\epsilon}} : 1 \le i \le r\}$$

(see [Har70, Chapter II, Proposition 3.1, page 66]). Since $\{D_{\rho_i^{\epsilon}} : 1 \leq i \leq r\}$ is linearly independent and the rank of $Pic(X_r)$ is r, this set $\{D_{\rho_i^{\epsilon}} : 1 \leq i \leq r\}$ forms a basis of $Pic(X_r)$.

Remark 4.2. In Section 12, for $1 \le i \le r$, we express $D_{\rho_i^-}$ in terms of $D_{\rho_i^+}$ $(1 \le j \le r)$.

Let $1 \leq i \leq r$. We prove the following.

Lemma 4.3. The relative tangent bundle T_{π_i} of $\pi_i : X_i \to X_{i-1}$ is given by

$$T_{\pi_i} \simeq \mathcal{O}_{X_i}(D_{\rho_i^+} + D_{\rho_i^-}) \simeq \mathcal{O}_{X_i}(\sum_{j=1}^{i-1} \beta_{ij} D_{\rho_j^-} + 2D_{\rho_i^-}).$$

Proof. By definition of Bott tower, π_i is a \mathbb{P}^1 -fibration. Then the relative canonical bundle K_{π_i} is given by

$$K_{\pi_i} = \mathcal{O}_{X_i}(K_{X_i}) \otimes \pi_i^*(\mathcal{O}_{X_{i-1}}(-K_{X_{i-1}}))$$

(see [Kle80, Corollary 24, page 56]). By [CLS11, Theorem 8.2.3] (see also [Ful93, Page 74]), we have

$$K_{X_{\Sigma}} = -\sum_{\rho \in \Sigma(1)} D_{\rho}.$$

Then

$$K_{\pi_i} = \mathcal{O}_{X_i} \left(-\sum_{\rho \in \Sigma(1)} D_{\rho}\right) \otimes \pi_i^* \left(\mathcal{O}_{X_{i-1}} \left(\sum_{\rho' \in \Sigma'(1)} D_{\rho'}\right)\right) \,,$$

where Σ' is the fan of X_{i-1} . Since X_{i-1} smooth, any divisor of the form $D = \sum_{\rho' \in \Sigma'(1)} a_{\rho'} D_{\rho'}$ with $a_{\rho'} \in \mathbb{Z}$, in X_{i-1} is Cartier. Hence the pullback $\pi_i^*(D)$ is defined and given by

$$\pi_i^*(D) = \pi_i^*(\sum_{\rho' \in \Sigma'(1)} a_{\rho'} D_{\rho'}) = \sum_{\rho \in \Sigma(1)} -\varphi_D(\overline{\pi}_i(u_\rho)) D_\rho,$$

where φ_D is the support function corresponding to the divisor D (see [CLS11, Theorem 4.2.12] for the correspondence between support functions and Cartier divisors).

Since the lattice map $\overline{\pi}_i : \mathbb{Z}^i \to \mathbb{Z}^{i-1}$ is the projection onto the first i-1 factors (see page 8), by definition of u_{ρ} and e_i^- (see (2.2)), for $\epsilon \in \{+, -\}$ we have

$$\overline{\pi}_i(u_{\rho_j^{\epsilon}}) = \begin{cases} u_{\rho_j^{\prime \epsilon}} & \text{if } 1 \le j \le i-1. \\ 0 & \text{if } j = i. \end{cases}$$

Hence

$$-\varphi_D(\overline{\pi}_i(u_{\rho_j^{\epsilon}})) = \begin{cases} a_{\rho_j^{\prime \epsilon}} & \text{if } 1 \le j \le i-1. \\ 0 & \text{if } j = i. \end{cases}$$

Thus we have,

$$\pi_i^* \left(\sum_{\rho' \in \Sigma'(1)} D_{\rho'} \right) = \sum_{\rho \in \Sigma(1) \setminus \{\rho_i^+, \rho_i^-\}} D_{\rho'}$$

Therefore, we see that

$$K_{\pi_i} = \mathcal{O}_{X_i}(-D_{\rho_i^+} - D_{\rho_i^-}).$$
(4.2)

By (2.2), we note that

$$0 \sim div(\chi^{e_i^+}) = D_{\rho_i^+} - D_{\rho_i^-} - \sum_{j=1}^{i-1} \beta_{ij} D_{\rho_j^-}.$$
(4.3)

Since $\check{K}_{\pi_i} = \det T_{\pi_i}$, we get $\check{K}_{\pi_i} = T_{\pi_i}$ as π_i is a \mathbb{P}^1 -fibration. Therefore, the result follows from (4.2) and (4.3).

The following is well known and proved here for completeness.

Lemma 4.4. Let X and Y be smooth varieties. Let $f : X \longrightarrow Y$ be a fibration with a section σ and denote by $\sigma(Y)$ its image in X. Then the restriction of the relative tangent bundle T_f to $\sigma(Y)$ is isomorphic to the normal bundle $\mathcal{N}_{\sigma(Y)/X}$ of $\sigma(Y)$ in X.

Proof. Consider the normal bundle short exact sequence

$$0 \longrightarrow T_{\sigma(Y)} \longrightarrow T_X|_{\sigma(Y)} \longrightarrow \mathcal{N}_{\sigma(Y)/X} \longrightarrow 0, \tag{4.4}$$

where $T_{\sigma(Y)}$ and T_X are the tangent bundles of $\sigma(Y)$ and X respectively.

Also consider the following short exact sequence

$$0 \longrightarrow T_f \longrightarrow T_X \longrightarrow f^*T_Y \longrightarrow 0 .$$
(4.5)

By restricting (4.5) to $\sigma(Y)$, since σ is a section of f, we get the following short exact sequence

$$0 \longrightarrow T_f|_{\sigma(Y)} \longrightarrow T_X|_{\sigma(Y)} \longrightarrow T_{\sigma(Y)} \longrightarrow 0 .$$
(4.6)

By using (4.4) and (4.6), we see $T_f|_{\sigma(Y)}$ is isomorphic to $\mathcal{N}_{\sigma(Y)/X}$. This completes the proof.

We prove,

Lemma 4.5. Let $1 \leq i \leq r$. The normal bundle $\mathcal{N}_{X_i/X_{i-1}}$ of X_{i-1} in X_i is \mathscr{L}_{i-1} , where \mathscr{L}_{i-1} is as in the definition of Bott tower and \mathscr{L}_{i-1} is denotes the dual of \mathscr{L}_{i-1} .

Proof. Fix $1 \leq i \leq r$ and let $\mathscr{L} := \mathscr{L}_{i-1}$. Recall that $\mathbb{P}(\mathscr{E})$ is by definition $Proj(S(\mathscr{E}))$, $S(\mathscr{E})$ is symmetric algebra of \mathscr{E} (see [Har77, Page 162]). Let $V(\mathscr{L}) = Spec(S(\mathscr{L}))$, the geometric vector bundle associated to the locally free sheaf (line bundle) \mathscr{L} (see [Har77, Exercise 5.18, Page 128]). Then, $V(\mathscr{L})$ is an open subvariety in $\mathbb{P}(\mathscr{E})$ and we have the following commutative diagram



Also note that the section $s_i^0(X_{i-1})$ of π_i corresponding to the projection $\mathscr{E} \to \mathcal{O}_{X_i}$ is same as the zero section $\sigma_{\pi}(X_{i-1})$ of π .

Now consider the following short exact sequence

$$0 \longrightarrow T_{\pi} \longrightarrow T_{V(\mathscr{L})} \longrightarrow \pi^* T_{X_{i-1}} \longrightarrow 0.$$
(4.7)

Since the restriction $T_{\pi|\sigma_{\pi}(X_{i-1})}$ of T_{π} to $\sigma_{\pi}(X_{r-1})$ is \mathscr{L} , by Lemma 4.4 and by above short exact sequence (4.7) we see that

$$\mathcal{N}_{\sigma_{\pi}(X_{i-1})/V(\mathscr{L})} \simeq \mathscr{\check{L}}.$$

Hence we conclude that

$$\mathcal{N}_{X_{i-1}/X_i} \simeq \check{\mathscr{L}}$$

(here we are identifying X_{i-1} with the section corresponding to the projection

$$\mathscr{E} = \mathcal{O}_{X_{i-1}} \oplus \mathscr{L} \to \mathcal{O}_{X_{i-1}}$$
).

This completes the proof of the lemma.

Let $1 \leq i \leq r$. We prove,

Lemma 4.6.

(1) The toric sections of π_i are given by $D_{\rho_i^{\epsilon}}, \epsilon \in \{+, -\}$.

Ċ

(2) The normal bundle $\mathcal{N}_{X_{i-1}/X_i}$ of X_{i-1} in X_i is given by

$$\mathcal{N}_{X_{i-1}/X_i} = \mathscr{L}_{i-1} = \mathcal{O}_{X_i}(D_{\rho^+}),$$

where the line bundle \mathscr{L}_{i-1} is as in the definition of the Bott tower X_i .

Proof. Proof of (1): Recall that π_i is a \mathbb{P}^1 -fibration induced by the projection $\overline{\pi}_i : \mathbb{Z}^i \to \mathbb{Z}_{i-1}$. For each cone $\sigma \in \Sigma_F$ of dimension 1 (which is a maximal cone in Σ_F), the subvariety $V(\sigma)$ is an invariant section of π_i , which is an invariant divisor in X_i . Hence we get two invariant divisors $V(\rho_i^+) = D_{\rho_i^+}$ and $V(\rho_i^-) = D_{\rho_i^-}$.

Proof of (2): By Lemma 4.5, we have $\mathcal{N}_{X_{i-1}/X_i} = \mathscr{L}_{i-1}$ and the section X_{i-1} is given by the projection $\mathscr{E} = \mathcal{O}_{X_{i-1}} \oplus \mathscr{L}_{i-1} \to \mathcal{O}_{X_{i-1}}$. Hence (2) follows from (1).

5. PRIMITIVE RELATIONS OF THE BOTT TOWER

5.1. Primitive collections and primitive relations. First recall the notion of primitive collections and primitive relations of a fan Σ , which are basic tools for the classification of Fano toric varieties due to Batyrev (see [Bat91]).

Definition 5.1. We say $P \subset \Sigma(1)$ is a **primitive collection** if P is not contained in $\sigma(1)$ for some $\sigma \in \Sigma$ but any proper subset is. Note that if Σ is simplicial, primitive collection means that P does not generate a cone in Σ but every proper subset does.

Definition 5.2. Let $P = \{\rho_1, \ldots, \rho_k\}$ be a primitive collection in a complete simplicial fan Σ . Recall u_ρ be the primitive vector of the ray $\rho \in \Sigma$. Then $\sum_{i=1}^k u_{\rho_i}$ is in the relative interior of a cone γ_P in Σ with a unique expression

$$\sum_{i=1}^{\kappa} u_{\rho_i} = \sum_{\rho \in \gamma_P(1)} c_{\rho} u_{\rho}, \ c_{\rho} \in \mathbb{Q}_{>0}.$$

Hence

$$\sum_{i=1}^{k} u_{\rho_i} - \left(\sum_{\rho \in \gamma_P(1)} c_\rho u_\rho\right) = 0.$$
(5.1)

Then we call (5.1) the **primitive relation** of X_{Σ} corresponding to P.

Recall that $TDiv(X_{\Sigma})$ denote the group of torus-invariant divisors in X_{Σ} (see Page 8). Since the fan Σ of X_r is full dimensional, we have the following short exact sequence

$$0 \longrightarrow M \xrightarrow{\varphi_1} TDiv(X_r) = \bigoplus_{\rho \in \Sigma(1)} \mathbb{Z}D_{\rho} \xrightarrow{\varphi_2} Pic(X_r) \to 0,$$
(5.2)

where the maps are given by $\varphi_1 : m \mapsto div(\chi^m)$ and $\varphi_2 : D \mapsto \mathcal{O}_{X_r}(D)$ (see [CLS11, Theorem 4.2.1]).

Now we recall some standard notations: Let X be a smooth projective variety, we define

$$N_1(X)_{\mathbb{Z}} := \{ \sum_{\text{finite}} a_i C_i : a_i \in \mathbb{Z}, C_i \text{ irreducible curve in } X \} / \equiv$$

where \equiv is the numerical equivalence, i.e. $Z \equiv Z'$ if and only if $D \cdot Z = D \cdot Z'$ for all divisors D in X. We denote by [C] the class of C in $N_1(X)_{\mathbb{Z}}$. Let $N_1(X) := N_1(X)_{\mathbb{Z}} \otimes \mathbb{R}$. It is a well known fact that $N_1(X)$ is a finite dimensional real vector space (see [Kle66, Proposition 4, §1, Chapter IV]). In the case where X is a (smooth projective) toric variety, $N_1(X)_{\mathbb{Z}}$ is dual to Pic(X) via the natural pairing (see [CLS11, Proposition 6.3.15]).

In our case $X = X_r$, there are dual exact sequences:

$$0 \longrightarrow M \xrightarrow{\varphi_1} \mathbb{Z}^{\Sigma(1)} \xrightarrow{\varphi_2} Pic(X_r) \longrightarrow 0$$

and

$$0 \longrightarrow N_1(X_r)_{\mathbb{Z}} \xrightarrow{\varphi_2^*} \mathbb{Z}^{\Sigma(1)} \xrightarrow{\varphi_1^*} N \longrightarrow 0, \qquad (5.3)$$

where

$$\varphi_2^*([C]) = (D_{\rho} \cdot C)_{\rho \in \Sigma(1)}, \qquad C \text{ is an irreducible complete curve in } X_{\rho}$$

and

 $\varphi_1^*(e_{\rho}) = u_{\rho}, \qquad e_{\rho} \text{ is a standard basis vector of } \mathbb{R}^{\Sigma(1)}$

(see [CLS11, Proposition 6.4.1]).

Let P be a primitive collection in Σ . Note that since X_r is smooth projective,

$$P \cap \gamma_P(1) = \emptyset$$

and

$$c_{\rho} \in \mathbb{Z}_{>0} \text{ for all } \rho \in \gamma_P(1)$$
 (5.4)

(see [CLS11, Proposition 7.3.6]).

As an element in $\mathbb{Z}^{\sum(1)}$, we write $r(P) = (r_{\rho})_{\rho \in \Sigma(1)}$, where

$$r_{\rho} = \begin{cases} 1 & \text{if } \rho \in P \\ -c_{\rho} & \text{if } \rho \in \gamma_{P}(1) \\ 0 & \text{otherwise} \end{cases}$$
(5.5)

Then by (5.1) we see that

$$\sum_{\rho\in\sum(1)}r_{\rho}u_{\rho}=0$$

Hence by the exact sequence (5.3) and by (5.4), we observe that r(P) gives an element in $N_1(X_r)_{\mathbb{Z}}$ (see [CLS11, Page 305]).

We prove,

Lemma 5.3. Let $P_i := \{\rho_i^+, \rho_i^-\}, 1 \le i \le r$. Then

$$\{P_i: 1 \le i \le r\}$$

is the set of all primitive collections of the fan Σ of X_r .

Proof. By Theorem 2.6, the cones in the fan Σ of X_r are generated by subsets of

$$\{e_1^+, \dots, e_r^+, e_1^-, \dots, e_r^-\}$$

and containing no subset of the form $\{e_i^+, e_i^-\}$. Then by Definition 5.1, it is clear that $P_i = \{\rho_i^+, \rho_i^-\}$ is a primitive collection for all *i*. Also note that again by description of the cones in Σ , any primitive collection must contain a P_i for some $1 \le i \le r$.

Fix $1 \leq i \leq r$. Let Q be a collection of one-dimensional cones such that it properly contains P_i , i.e. there exists $1 \leq j \leq r$ and $j \neq i$ such that $\rho_j^{\epsilon} \in Q \supset P_i$, $\epsilon \in \{+, -\}$. Assume that Q is a primitive collection. Then by Definition 5.1, $\{\rho_i^+, \rho_i^-\} \subset Q$ generates a cone in Σ . This is a contradiction to the description of the cones in Σ . Therefore, we conclude that

$$\{P_i : 1 \le i \le r\}$$

is the set of all primitive collections.

Now we define the **Contractible classes** from [Cas03]: Let X be a smooth projective toric variety. We define $NE(X)_{\mathbb{Z}}$ in $N_1(X)$ by

$$NE(X)_{\mathbb{Z}} := \{\sum_{finite} a_i C_i : a_i \in \mathbb{Z}_{\geq 0} \text{ and } C_i \text{ irreducible curve in } X \}.$$

Let $\gamma \in NE(X)_{\mathbb{Z}}$ be primitive (i.e. the generator of $\mathbb{Z}_{\geq 0}\gamma$) and such that there exists some irreducible curve in X having numerical class in $\mathbb{Q}_{>0}\gamma$. Then

Definition 5.4. (see [Cas03, Definition 2.3]) The above class γ is called **contractible** if there exists a toric variety X_{γ} and an equivariant morphism $\phi_{\gamma} : X \to X_{\gamma}$, surjective with connected fibers, such that for every irreducible curve C in X,

$$\phi_{\gamma}(C) = \{pt\} \text{ if and only if } [C] \in \mathbb{Q}_{\geq 0}\gamma.$$

Remark 5.5. Note that any contractible class is always a class of some invariant curve and also a primitive relation (see [Cas03, Theorem 2.2] and [Sca09, Page 74]).

Recall the following result from [Cas03, Proposition 3.4].

Proposition 5.6. Let $P = \{\rho_1, \ldots, \rho_k\}$ be a primitive collection in Σ , with the primitive relation r(P):

$$\sum_{i=1}^{n} u_{\rho_i} - \sum_{\rho \in \gamma_P(1)} c_{\rho} u_{\rho} = 0.$$

Then r(P) is contractible if and only if for every primitive collection Q of Σ such that $P \cap Q \neq \emptyset$ and $P \neq Q$, the set $(Q \setminus P) \cup \gamma_P(1)$ contains a primitive collection.

5.2. Mori cone. We use the notation as above. Let X be a smooth projective variety. We define NE(X) the real convex cone in $N_1(X)$ generated by classes of irreducible curves. The Mori cone $\overline{NE}(X)$ is the closure of NE(X) in $N_1(X)$ and it is a strongly convex cone of maximal dimension.

If X is a (smooth projective) toric variety, it is known that $NE(X)_{\mathbb{Z}}$ is generated by the finitely many torus-invariant irreducible curves in X and hence $NE(X)_{\mathbb{Z}}$ is a finitely generated monoid. Hence the cone $NE(X) = \overline{NE}(X)$ is a rational polyhedral cone and we have

$$\overline{NE}(X) = \sum_{\tau \in \Sigma(r-1)} \mathbb{R}_{\geq 0}[V(\tau)],$$

where $r = \dim(X)$ and $[V(\tau)] \in N_1(X)_{\mathbb{Z}}$ is the class of the toric curve $V(\tau)$. This is called the Toric Cone Theorem (see [CLS11, Theorem 6.3.20]). Let $\tau \in \Sigma(r-1)$ be a wall, that is $\tau = \sigma \cap \sigma'$ for some $\sigma, \sigma' \in \Sigma(r)$. Let σ (respectively, σ') is generated by $\{u_{\rho_1}, u_{\rho_2}, \ldots, u_{\rho_r}\}$ (respectively, by $\{u_{\rho_2}, \ldots, u_{\rho_{r+1}}\}$) and let τ be generated by $\{u_{\rho_2}, \ldots, u_{\rho_r}\}$. Then we get a linear relation,

$$u_{\rho_1} + \sum_{i=2}^{r} b_i u_{\rho_i} + u_{\rho_{r+1}} = 0$$
(5.6)

The relation (5.6) called **wall relation** and we have

$$D_{\rho} \cdot V(\tau) = \begin{cases} b_i & \text{if } \rho = \rho_i \text{ and } i \in \{2, 3, \dots, r\} \\ 1 & \text{if } \rho = \rho_i \text{ and } i \in \{1, r+1\} \\ 0 & \text{otherwise} \end{cases}$$

(see [CLS11, Proposition 6.4.4 and eq. (6.4.6) page 303]).

Now we describe the Mori cone $\overline{NE}(X_r)$ of X_r in terms of the primitive relations of X_r .

Theorem 5.7. $\overline{NE}(X_r)_{\mathbb{Z}} = \sum_{i=1}^r \mathbb{Z}_{\geq 0} r(P_i).$

Proof. We have

$$\overline{NE}(X_r) = \sum_{P \in \mathscr{P}} \mathbb{R}_{\geq 0} r(P) ,$$

where \mathscr{P} is the set of all primitive collections in X_r (see [CLS11, Theorem 6.4.11]). By Lemma 5.3, $\{P_i : 1 \le i \le r\}$ is the set of all primitive collections of X_r . Therefore, we get

$$\overline{NE}(X_r) = \sum_{i=1}^r \mathbb{R}_{\geq 0} r(P_i) \; .$$

By [Cas03, Theorem 4.1], we have

$$\overline{NE}(X_r)_{\mathbb{Z}} = \sum_{\gamma \in \mathscr{C}} \mathbb{Z}_{\geq 0} \gamma,$$

where \mathscr{C} is the set of all contractible classes in X_r .

By Proposition 5.6, we can see that the primitive relations $r(P_i)$ are contractible classes for $1 \le i \le r$. Since any contractible class is a primitive relation, we get

$$\mathscr{C} = \{ r(P_i) : 1 \le i \le r \}.$$

Hence we conclude that

$$\overline{NE}(X_r)_{\mathbb{Z}} = \sum_{i=1}^{r} \mathbb{Z}_{\geq 0} r(P_i)$$

This completes the proof of the theorem.

We have

Corollary 5.8. The set $\{r(P_i) : 1 \leq i \leq r\}$ forms a basis of $N_1(X_r)_{\mathbb{Z}}$.

Proof. By Theorem 5.7, $\{r(P_i) : 1 \le i \le r\}$ generates the monoid $\overline{NE}(X_r)_{\mathbb{Z}}$ and the cone $\overline{NE}(X_r)$ is of dimension r. So $r(P_i)$ for $1 \le i \le r$ are linearly independent. Also the group $N_1(X_r)_{\mathbb{Z}}$ is generated by $\overline{NE}(X_r)_{\mathbb{Z}}$, hence by $r(P_i)$ for $1 \le i \le r$. Hence these form a basis of $N_1(X_r)_{\mathbb{Z}}$.

Next we describe the primitive relation $r(P_i)$ explicitly by finding the cone γ_{P_i} in (5.1) for $1 \leq i \leq r$. We also observe that these cones depend on the given matrix corresponding to the Bott tower. We need some notation to state the result.

Recall the matrix M_r corresponding to the Bott tower X_r is

$$M_{r} = \begin{bmatrix} 1 & \beta_{12} & \beta_{13} & \dots & \beta_{1r} \\ 0 & 1 & \beta_{23} & \dots & \beta_{2r} \\ 0 & 0 & 1 & \dots & \beta_{3r} \\ \vdots & \vdots & & \ddots & \vdots \\ 0 & \dots & \dots & & 1 \end{bmatrix}_{r \times r}$$

(see Section 2).

Fix $1 \leq i \leq r$. Define:

- (1) Let $r \ge j > j_1 = i \ge 1$ and define $a_{1,j} := \beta_{j_1j}$.
- (2) Let $r \ge j_2 > j_1$ be the least integer such that $a_{1,j} > 0$, then define for $j > j_2$

$$a_{2,j} := \beta_{ij_2}\beta_{j_2j} - \beta_{ij}.$$

(3) Let k > 2 and let $r \ge j_k > j_{k-1}$ be the least integer such that $a_{k-1,j} < 0$, then inductively, define for $j > j_k$

$$a_{k,j} := -a_{k-1,j_k} \beta_{j_k j} + a_{k-1,j}$$

(4) For $j \leq i, b_j := 0$, and for j > i define

$$b_j := a_{l,j} \text{ if } j_{l+1} \ge j > j_l, l \ge 1.$$
 (5.7)

Note that we have

$$b_j = \begin{cases} 0 & \text{for } j \leq i \\ < 0 & \text{for } j \in \{j_3, \dots, j_m\} \\ \geq 0 & \text{otherwise }. \end{cases}$$

(5) Let $I_i := \{j_1, \dots, j_m\}.$

Example 5.9. Let

$$M_{7} = \begin{bmatrix} 1 & -1 & -1 & -1 & 2 & -1 & 2 \\ 0 & 1 & 0 & 2 & -1 & 2 & -1 \\ 0 & 0 & 1 & 0 & -1 & -1 & -1 \\ 0 & 0 & 0 & 1 & -1 & 2 & -1 \\ 0 & 0 & 0 & 0 & 1 & -1 & 2 \\ 0 & 0 & 0 & 0 & 0 & 1 & -1 \\ 0 & 0 & 0 & 0 & 0 & 0 & 1 \end{bmatrix}_{7 \times 7}$$

Let $G = SL(5, \mathbb{C})$ and let

$$\tilde{w} = s_{\beta_1} \cdots s_{\beta_7} = s_{\alpha_2} s_{\alpha_1} s_{\alpha_3} s_{\alpha_1} s_{\alpha_2} s_{\alpha_1} s_{\alpha_2}$$

Note that the matrix corresponding to the toric limit $X_{\tilde{w}}$ is M_7 .

Let i = 1 then $j_1 = 1$ and (1) $a_{1,2} = \beta_{12} = \langle \beta_2, \check{\beta}_1 \rangle = \langle \alpha_1, \check{\alpha}_2 \rangle = -1$; (2) $a_{1,3} = \beta_{13} = \langle \beta_3, \check{\beta}_1 \rangle = \langle \alpha_3, \check{\alpha}_2 \rangle = -1$; (3) $a_{1,4} = \beta_{14} = \langle \beta_4, \check{\beta}_1 \rangle = \langle \alpha_1, \check{\alpha}_2 \rangle = -1$; (4) $a_{1,5} = \beta_{15} = \langle \beta_5, \check{\beta}_1 \rangle = \langle \alpha_2, \check{\alpha}_2 \rangle = 2$; (5) $a_{1,6} = \beta_{16} = \langle \beta_6, \check{\beta}_1 \rangle = \langle \alpha_1, \check{\alpha}_2 \rangle = -1$; (6) $a_{1,7} = \beta_{17} = \langle \beta_7, \check{\beta}_1 \rangle = \langle \alpha_2, \check{\alpha}_2 \rangle = 2$. Then $j_2 = 5$ and (1) $a_{2,6} = \beta_{15}\beta_{56} - \beta_{16} = \langle \beta_5, \check{\beta}_1 \rangle \langle \beta_6, \check{\beta}_5 \rangle - \langle \beta_6, \check{\beta}_1 \rangle = \langle \alpha_1, \check{\alpha}_2 \rangle = -1$; (2) $a_{2,7} = \beta_{15}\beta_{57} - \beta_{17} = \langle \alpha_2, \check{\alpha}_2 \rangle = 2$. Then $j_3 = 6$ and $a_{3,7} = -a_{2,6}\beta_{67} + a_{2,7}$ (1) $= -(\langle \beta_6, \check{\beta}_5 \rangle)(\langle \beta_7, \check{\beta}_6 \rangle) + (\langle \beta_7, \check{\beta}_5 \rangle)$ = -(-1)(-1) + (2)= 1.

Therefore, $I_1 = \{1,5,6\}$.

Let $1 \leq i \leq r$. Let $\mathscr{A}_i := \{e_j^{\epsilon_j} : 1 \leq j \leq r, b_j \neq 0 \text{ and }$

$$\epsilon_j = \begin{cases} + & \text{for } j \notin I_i \\ - & \text{for } j \in I_i \end{cases} \}.$$

Remark 5.10. Note that as $b_j = 0$ for $j \leq i$, we can take $i < j \leq r$ in the definition of \mathscr{A}_i .

Now we prove,

Proposition 5.11. Let $1 \leq i \leq r$. The cone γ_{P_i} in the primitive relation of X_r corresponding to P_i is generated by \mathscr{A}_i .

Before going to the proof we see an example.

Example 5.12. We use same setting as in Example 5.9. By Lemma 5.3, we have $P_i = \{\rho_i^+, \rho_i^-\}$ for all $1 \le i \le 7$.

By definition of e_i^- (see (2.2)), we have

(i)
$$e_1^- + e_1^+ = e_2^+ + e_3^+ + e_4^+ - 2e_5^+ + e_6^+ - 2e_7^+$$
.

(ii)
$$e_2^- + e_2^+ = -2e_4^+ + e_5^+ - 2e_6^+ + e_7^+$$
.

(iii)
$$e_3^- + e_3^+ = e_5^+ + e_7^+$$
.

(iv)
$$e_4^- + e_4^+ = e_5^+ - 2e_6^+ + e_7^+$$

(v)
$$e_5^- + e_5^+ = e_6^+ - 2e_7^+$$

(vi) $e_6^- + e_6^+ = e_7^+$.

(vii)
$$e_7^- + e_7^+ = 0.$$

Now we describe the cone γ_{P_1} .

Observe that in (i) coefficient of e_5^+ is negative. By (v), we can see

$$e_1^- + e_1^+ = e_2^+ + e_3^+ + e_4^+ + 2(e_5^- - e_6^+ + 2e_7^+) + e_6^+ - 2e_7^+.$$

Then

$$e_1^- + e_1^+ = e_2^+ + e_3^+ + e_4^+ + 2e_5^- - e_6^+ + 2e_7^+.$$

By (vi),

$$e_1^- + e_1^+ = e_2^+ + e_3^+ + e_4^+ + 2e_5^- + e_6^- + e_7^+.$$
(5.8)

In this case, $I_1 = \{1, 5, 6\}$ (see Example 5.9) and the cone γ_{P_1} is generated by

$$\{e_2^+, e_3^+, e_4^+, e_5^-, e_6^-, e_7^+\}$$

Now we prove Proposition 5.11:

Proof. By (2.2), for all $1 \le i \le r$, we have

$$e_i^- + e_i^+ = -\sum_{j>i} \beta_{ij} e_j^+ .$$
(5.9)

If for all j > i, $\beta_{ij} \leq 0$, then the cone γ_{P_i} is generated by

$$\{e_j^+ : j > i, \beta_{ij} < 0\}$$

If not, choose the least integer $j_2 > i$ such that $\beta_{ij_2} > 0$. Now write

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} \beta_{ij} e_j^+\right) + \beta_{ij_2}(-e_{j_2}^+) - \left(\sum_{j > j_2} \beta_{ij} e_j^+\right).$$

Again by using (5.9), we have

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} \beta_{ij} e_j^+\right) + \beta_{ij_2} \left(e_{j_2}^- + \sum_{j > j_2} \beta_{j_2j} e_j^+\right) - \left(\sum_{j > j_2} \beta_{ij} e_j^+\right).$$

Then

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} \beta_{ij} e_j^+\right) + \beta_{ij_2} e_{j_2}^- + \sum_{j > j_2} (\beta_{ij_2} \beta_{j_2j} - \beta_{ij}) e_j^+\right).$$

By definition $a_{2,j} = \beta_{ij_2}\beta_{j_2j} - \beta_{ij}$, then we have

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} \beta_{ij} e_j^+\right) + \beta_{ij_2} e_{j_2}^- + \left(\sum_{j > j_2} a_{2,j} e_j^+\right).$$

If $a_{2,j} \ge 0$ for all $j > j_2$, then γ_{P_i} is generated by

 $\{e_j^{\epsilon_j}: j > i, \epsilon_j = + \forall j \neq j_2, \text{ and } \epsilon_j = - \text{ for } j = j_2\}.$

Otherwise, choose the least integer $j_3 > j_2$ such that $a_{2,j_3} < 0$. By substituting $-e_{j_3}^+$ from (5.9), we get

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} a_{1,j}e_j^+\right) + \beta_{ij_2}e_{j_2}^- + \left(\sum_{j_3 > j > j_2} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{2,j}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{j_3}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{j_3}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{j_3}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + \left(\sum_{j > j_3} a_{j_3}e_j^+\right) - a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3j}e_j^+\right) + a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_{j_3}e_j^+\right) + a_{2,j_3}\left(e_{j_3}^- + \sum_{j > j_3} \beta_$$

Then,

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} a_{1,j}e_j^+\right) + \beta_{ij_2}e_{j_2}^- + \left(\sum_{j_3 > j > j_2} a_{2,j}e_j^+\right) - a_{2,j_3}e_{j_3}^- + \sum_{j > j_3}(-a_{2,j_3}\beta_{j_3j} + a_{2,j})e_j^+\right).$$

By definition of $a_{3,j} = -a_{2,j_3}\beta_{jj_3} + a_{2,j}$, then we have

$$e_i^- + e_i^+ = -\left(\sum_{j_2 > j > i} a_{1,j}e_j^+\right) + 2e_{j_2}^- + \left(\sum_{j_3 > j > j_2} a_{2,j}e_j^+\right) - a_{2,j_3}e_{j_3}^- + \left(\sum_{j > j_3} a_{3,j}e_j^+\right).$$

By repeating this process, we get the cone γ_{P_i} as we required.

Let $1 \le i \le r$. Recall $I_i = \{i = j_1, \dots, j_m\}$ as in page 19. Define for $1 \le j \le r$,

$$c_j := \begin{cases} -b_j & \text{if } j \in I_i \setminus \{j_1, j_2\} \\ b_j & \text{otherwise} \end{cases}$$

Set $\gamma_{P_i}(1) := \{\gamma_1, \ldots, \gamma_l\}$. Then we have

Corollary 5.13. For $1 \le i \le r$, the primitive relation $r(P_i)(=(r_{\rho})_{\rho \in \Sigma(1)})$ of X_r given by

$$r_{\rho} = \begin{cases} 1 & \text{for } \rho = \rho_i^+ \text{ or } \rho_i^- \\ -c_j & \text{for } \rho = \gamma_j \in \gamma_{P_i}(1) \\ 0 & \text{otherwise} \end{cases}$$

Example 5.14. We use Example 5.12. The following can be seen easily from (5.8).

- (1) $\gamma_{P_1}(1) = \{\rho_2^+, \rho_3^+, \rho_4^+, \rho_5^-, \rho_6^-, \rho_7^+\}$.
- (2) The primitive relation $r(P_1) = (r_{\rho})_{\rho \in \Sigma(1)}$ is given by

$$r_{\rho} = \begin{cases} 1 & \text{for } \rho = \rho_{1}^{+} \text{ or } \rho_{1}^{-} \\ -1 & \text{for } \rho = \rho_{k}^{+}, k \in \{2, 3, 4, 7\} \text{ and } \rho = \rho_{6}^{-} \\ -2 & \text{for } \rho = \rho_{5}^{-} \\ 0 & \text{otherwise} \end{cases}$$

Now we describe the primitive relations $r(P_i)$ in terms of intersection of two maximal cones in the fan of X_r . Let $1 \leq i \leq r$. Let $\mathscr{C}'_i := \{e_j^{\epsilon_j} : 1 \leq j \leq r \text{ and }$

$$\epsilon_j = \begin{cases} + & \text{if } j \notin I_i \setminus \{j_1\} \\ - & \text{if } j \in I_i \end{cases} \}.$$

Let $\mathscr{C}''_i := \{ e_j^{\epsilon_j} : 1 \le j \le r \text{ and }$

$$\epsilon_j = \begin{cases} + & \text{if } j \notin I_i \\ - & \text{if } j \in I_i \end{cases}$$

Example 5.15. We use Example 5.12, for i = 1, we have $I_1 = \{1, 5, 6\}$. Then

$$\mathscr{C}'_1 = \{e^+_1, e^+_2, e^+_3, e^+_4, e^-_5, e^-_6, e^+_7\} \text{ and } \mathscr{C}''_1 = \{e^-_1, e^+_2, e^+_3, e^+_4, e^-_5, e^-_6, e^+_7\}$$

We prove the following by using *wall relation* (see page 16).

Proposition 5.16. Fix $1 \le i \le r$. The class of curve $r(P_i)$ is given by

$$r(P_i) = [V(\tau_i)] ,$$

where $\tau_i = \sigma \cap \sigma'$ and σ (respectively, σ') is the cone generated by \mathscr{C}'_i (respectively, by \mathscr{C}''_i).

Proof. From Corollary 5.13, we have the following.

$$e_i^+ + e_i^- - \sum_{j>i} c_j e_j^{\epsilon_j} = 0, \qquad (5.10)$$

where ϵ_i is as in the statement.

First we show that the set $Q := \{\rho \in \Sigma(1) : D_{\rho} \cdot V(\tau_i) > 0\}$ is not contained in $\sigma(1)$ for any $\sigma \in \Sigma$ (we adapt the arguments of [CLS11, Proof of Theorem 6.4.11, page 306], here

we are not assuming the curve $V(\tau_i)$ is extremal). Indeed, suppose $Q \subseteq \sigma(1)$ for some $\sigma \in \Sigma$. Let D be an ample divisor in X_r . Then, we can assume that D is of the form

$$D = \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho} , \ a_{\rho} = 0 \text{ for all } \rho \in \sigma(1) \text{ and } a_{\rho} \ge 0 \text{ for all } \rho \notin \sigma(1)$$

(see [CLS11, (6.4.10), page 306]). Then we can see

$$D \cdot V(\tau_i) = \sum_{\rho \notin \sigma(1)} a_{\rho} D_{\rho} \cdot V(\tau_i).$$

As $Q \subseteq \sigma(1)$, by definition of Q, $D_{\rho} \cdot V(\tau_i) \leq 0$ for $\rho \notin \sigma(1)$. Since $a_{\rho} \geq 0$ for $\rho \notin \sigma(1)$, we get $D \cdot V(\tau_i) \leq 0$, which is a contradiction as D is ample. Therefore, Q is not contained in $\sigma(1)$ for any $\sigma \in \Sigma$.

Hence to prove the proposition it is enough to prove

$$P_i = Q(:= \{ \rho \in \Sigma(1) : D_{\rho} \cdot V(\tau_i) > 0 \})$$

(see again [CLS11, Proof of Theorem 6.4.11, page 306]).

From (5.10) and by using *wall relation*, we can see that

$$D_{\rho} \cdot V(\tau_i) = \begin{cases} 1 & \text{if } \rho = \rho_i^+ \text{ or } \rho_i^-.\\ -c_j & \text{if } \rho = \rho_j^{\epsilon_j} \text{ and } j \in I_i \setminus \{j_1\}.\\ 0 & \text{otherwise.} \end{cases}$$

Since c_j 's are all positive integers (see (5.4)), by Lemma 5.3 we conclude that

$$P_i = \{ \rho \in \Sigma(1) : D_\rho \cdot V(\tau_i) > 0 \}$$

 \square

and hence $r(P_i) = [V(\tau_i)]$. This completes the proof of the proposition.

Example 5.17. In Example 5.12, the curve $r(P_1) = [V(\tau_1)]$ with $\tau_1 = \sigma \cap \sigma'$ where σ is the cone generated by

$$\mathscr{C}_1' = \{e_1^+, e_2^+, e_3^+, e_4^+, e_5^-, e_6^-, e_7^+\}$$

and σ' is the cone generated by

$$\mathscr{C}_1'' = \{e_1^-, e_2^+, e_3^+, e_4^+, e_5^-, e_6^-, e_7^+\}.$$

6. Ample and nef line bundles on the Bott tower

Let X be a smooth projective variety. Recall $N^1(X)$ is the real finite dimensional vector space of numerical classes of real divisors in X (see [Kle66, §1, Chapter IV]). In $N^1(X)$, we define the *nef* cone Nef(X) to be the cone generated by classes of numerically effective divisors and it is a strongly convex closed cone in $N^1(X)$. The ample cone Amp(X) of X is the cone in $N^1(X)$ generated by classes of ample divisors. Note that the ample cone Amp(X) is interior of the *nef* cone Nef(X) (see [Kle66, Theorem 1, §2, Chapter IV]). Recall that the *nef* cone Nef(X) and the Mori cone $\overline{NE}(X)$ are closed convex cones and are dual to each other (see [Kle66, §2, Chapter IV]).

In our case, we have $Pic(X_r)_{\mathbb{R}} = N^1(X_r)$, as the numerical equivalence and linear equivalence coincide (see [CLS11, Proposition 6.3.15]).

In this section, we characterize the ampleness and numerically effectiveness of line bundles on X_r and we study the generators of the *nef* cone of X_r . We use the notation as in Section 5. Let $D = \sum a_{\rho} D_{\rho}$ be a toric divisor in X_r and for $1 \le i \le r$, define

$$d_i := (a_{\rho_i^+} + a_{\rho_i^-} - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j a_{\gamma_j}).$$

Then we prove,

Lemma 6.1.

- (1) The divisor D is ample if and only if $d_i > 0$ for all $1 \le i \le r$.
- (2) The divisor D is numerically effective (nef) if and only if $d_i \ge 0$ for all $1 \le i \le r$.

Proof. Proof of (2): Recall that the primitive relation $r(P_i)$ is given by

$$r(P_i) = (r_\rho)_{\rho \in \Sigma(1)}$$

(see page 15). First observe that we have the following

$$D \cdot r(P_i) = \sum_{\rho \in \Sigma(1)} a_{\rho} (D_{\rho} \cdot r(P_i)) = \sum_{\rho \in \Sigma(1)} a_{\rho} r_{\rho}$$

(see [CLS11, Proposition 6.4.1, page 299]).

Then by (5.5), we get

$$D \cdot r(P_i) = \sum_{\rho \in P_i} a_{\rho} - \sum_{\rho \in \gamma_{P_i}(1)} r_{\rho} a_{\rho}.$$

By Lemma 5.3, we have $P_i = \{\rho_i^+, \rho_i^-\}$. Then by Corollary 5.13, we get

$$D \cdot r(P_i) = (a_{\rho_i^+} + a_{\rho_i^-} - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j a_{\gamma_j}) =: d_i.$$
(6.1)

Since the *nef* cone $Nef(X_r)$ and the Mori cone $\overline{NE}(X_r)$ are dual to each other, the divisor D is *nef* if and only if $D \cdot C \geq 0$ for all torus-invariant irreducible curves C in X_r . By Theorem 5.7, we have

$$\overline{NE}(X_r) = \sum_{i=1}^r \mathbb{R}_{\ge 0} r(P_i).$$

Hence D is nef if and only if $D \cdot r(P_i) \ge 0$ for all $1 \le i \le r$. Therefore, by (6.1), we conclude that the divisor D is nef if and only if $d_i \ge 0$ for all $1 \le i \le r$. This completes the proof of (2).

Proof of (1): Recall that the divisor D is ample if and only if its class in $Pic(X_r)_{\mathbb{R}}$ lies in the interior of the *nef* cone $Nef(X_r)$. Hence by using similar arguments as in the proof of (2) and the toric Kleiman criterion for ampleness [CLS11, Theorem 6.3.13], we can see that D is ample if and only if $d_i > 0$ for all $1 \le i \le r$. \Box

Next we describe the generators of the *nef* cone $Nef(X_r)$ of X_r .

Example 6.2. Let $G = SL(3, \mathbb{C})$ and $\tilde{w} = s_{\alpha_1}s_{\alpha_2}$. Note that the corresponding matrix for the Bott tower $X_{\tilde{w}}$ is

$$A_2 = \begin{bmatrix} 1 & -1 \\ 0 & 1 \end{bmatrix}_{2 \times 2}$$

Then $X_{\tilde{w}} = \mathbb{P}(\mathcal{O}_{\mathbb{P}^1} \oplus \mathcal{O}_{\mathbb{P}^1}(1))$, the Hirzebruch surface \mathscr{H}_1 and the rays $(\rho_1^+, \rho_1^-, \rho_2^+ \text{ and } \rho_2^-)$ of the fan (shown below) of $X_{\tilde{w}}$ are generated by

$$e_1^+, e_1^- = -e_1^+ + e_2^+, e_2^+ and - e_2^+$$



Figure. Fan of Hirzebruck surface \mathscr{H}_1 .

The primitive relations $r(P_1)$ and $r(P_2)$ are given by

$$r(P_1)$$
 : $e_1^+ + e_1^- = e_2$ and $r(P_2)$: $e_2^+ + e_2^- = 0$.

By wall relation, we observe that

- (1) $D_{\rho_1^+} \cdot r(P_1) = 1$ and $D_{\rho_1^+} \cdot r(P_2) = 0$.
- (2) $D_{\rho_2^-} \cdot r(P_1) = 0$ and $D_{\rho_2^-} \cdot r(P_2) = 1$.

Then the dual basis of $\{r(P_1), r(P_2)\}$ is $\{D_{\rho_1^+}, D_{\rho_2^-}\}$. Hence the generators of the nef cone $Nef(\mathscr{H}_1)$ are $D_{\rho_1^+}$ and $D_{\rho_2^-}$. Note that by Lemma 4.1, $Pic(\mathscr{H}_1)$ is generated by $\{D_{\rho_1^+}, D_{\rho_2^-}\}$. Let $D = aD_{\rho_1^+} + bD_{\rho_2^-} \in Pic(\mathscr{H}_1)$. Then

D is ample if and only if a > 0 and b > 0

(this gives back [CLS11, Example (6.1.16), page 273]).

Now we prove the similar results for X_r . For $1 \le m \le r$, define

$$J_m := \{1 \le i < m : \{\rho_m^+\} \cap \gamma_{P_i}(1) \ne \emptyset\}$$

Remark 6.3. Note that the set J_m is the collection of indices i < m for which $u_{\rho_m^+}$ appear in the γ_{P_i} part of the expression (5.1) for the primitive relation $r(P_i)$.

We set $D_1 := D_{\rho_1^+}$, and for m > 1 define inductively

$$D_m := \begin{cases} D_{\rho_m^+} & \text{if } J_m = \emptyset\\ (\sum_{k \in J_m} c_{\rho_m^+}^{\gamma_{P_k}} D_k) + D_{\rho_m^+} & \text{if } J_m \neq \emptyset, \end{cases}$$

where $-c_{\rho_m^+}^{\gamma_{P_k}}$ is the coefficient of e_m^+ in the primitive relation $r(P_k)$.

Example 6.4. In Example 6.2, $D_1 = D_{\rho_1^+}$, $J_2 = \{1\}$ and $D_2 = D_1 + D_{\rho_2^+}$. By using (2.2), we see that

$$0 \sim div(\chi^{e_1^+}) \sim D_{\rho_1^+} - D_{\rho_1^-}$$

and

$$D \sim div(\chi^{e_2^+}) \sim D_{\rho_2^+} - D_{\rho_2^-} + D_{\rho_1^-}$$

Hence $D_2 = D_1 + D_{\rho_2^+} = D_{\rho_2^-}$. Example 6.5. In Example 5.12,

(1) Recall by (5.8), we have

$$e_1^- + e_1^+ = e_2^+ + e_3^+ + e_4^+ + 2e_5^- + e_6^- + e_7^+.$$

Then, $\gamma_{P_1}(1) = \{\rho_2^+, \rho_3^+, \rho_4^+, \rho_5^-, \rho_6^-, \rho_7^+\}.$
(2) $\gamma_{P_2}(1) = \{\rho_4^-, \rho_5^-, \rho_6^+, \rho_7^+\}$ (since $e_2^+ + e_2^- = 2e_4^- + e_5^- + e_6^+ + e_7^+).$

(3)
$$\gamma_{P_3}(1) = \{\rho_5^+, \rho_7^+\}$$
 (since $e_3^+ + e_3^- = e_5^+ + e_7^+$).
(4) $\gamma_{P_4}(1) = \{\rho_5^+, \rho_6^-, \rho_7^-\}$ (since $e_4^+ + e_4^- = e_5^+ + 2e_6^- + e_7^-$).

(5)
$$\gamma_{P_5}(1) = \{\rho_6^+, \rho_7^-\}$$
 (since $e_5^+ + e_5^- = e_6^+ + 2e_7^-$).

(6)
$$\gamma_{P_6}(1) = \{\rho_7^+\}$$
 (since $e_6^+ + e_6^- = e_7^+$).

(7)
$$\gamma_{P_7}(1) = \emptyset$$
. (since $e_7^+ + e_7^- = 0$).

Then,

(1) If
$$m = 1$$
, then $D_1 = D_{\rho_1^+}$.
(2) If $m = 2$, then $J_2 = \{1\}$ and $c_{\rho_2^+}^{\gamma_{P_1}} = 1$. Hence $D_2 = D_1 + D_{\rho_2^+}$
(3) If $m = 3$, then $J_3 = \{1\}$ and $c_{\rho_3^+}^{\gamma_{P_1}} = 1$. Hence $D_3 = D_1 + D_{\rho_3^+}$
(4) If $m = 4$, then $J_4 = \{1\}$ and $c_{\rho_4^+}^{\gamma_{P_1}} = 1$. Hence $D_4 = D_1 + D_{\rho_4^+}$
(5) If $m = 5$, then $J_5 = \{3, 4\}$ and $c_{\rho_5^+}^{\gamma_{P_3}} = 1$; $c_{\rho_5^+}^{\gamma_{P_4}} = 1$. Hence $D_5 = D_3 + D_4 + D_{\rho_5^+}$.

(6) If
$$m = 6$$
, then $J_6 = \{2, 5\}$ and $c_{\rho_6^+}^{\gamma_{P_2}} = 1$; $c_{\rho_6^+}^{\gamma_{P_5}} = 1$. Hence
 $D_6 = D_2 + D_5 + D_{\rho_6^+}$.
(7) If $m = 7$, then $J_7 = \{1, 2, 3, 6\}$ and
 $c_{\rho_7^+}^{\gamma_{P_1}} = 1$; $c_{\rho_7^+}^{\gamma_{P_2}} = 1$; $c_{\rho_7^+}^{\gamma_{P_3}} = 1$; and $c_{\rho_7^+}^{\gamma_{P_6}} = 1$. Hence
 $D_7 = D_1 + D_2 + D_3 + D_6 + D_{\rho_7^+}$.

We prove,

Proposition 6.6. The set $\{D_i : 1 \le i \le r\}$ is dual basis of $\{r(P_i) : 1 \le i \le r\}$.

Proof. Fix $1 \leq i \leq r$. By Proposition 5.16, the class of curve corresponding to the primitive relation $r(P_i)$ is given by

$$r(P_i) = [V(\tau_i)]$$

(where τ_i is described as in Proposition 5.16). From Corollary 5.13, the primitive relation $r(P_i)(=[V(\tau_i)])$ is

$$e_i^+ + e_i^- - \sum_{j>i} c_j e_j^{\epsilon_j} = 0,$$
(6.2)

where ϵ_j is as in Proposition 5.16. Note that this is the *wall relation* for the torus-invariant curve $V(\tau_i)$. We prove

$$D_m \cdot r(P_i) = D_m \cdot V(\tau_i) = \begin{cases} 1 & \text{if } i = m. \\ 0 & \text{if } i \neq m. \end{cases}$$
(6.3)

By (6.2) and by *wall relation*, we have

$$D_{\rho_m^+} \cdot V(\tau_i) = \begin{cases} 1 & \text{for } m = i \\ 0 & \text{for } m < i \\ -c_{\rho_m^+}^{\gamma_{P_i}} & \text{for } m > i \text{ and } i \in J_m \\ 0 & \text{for } m > i \text{ and } i \notin J_m \end{cases}$$
(6.4)

Hence by definition of D_m , it is clear that

$$D_m \cdot V(\tau_i) = \begin{cases} 1 & \text{for } m = i \\ 0 & \text{for } m < i \end{cases}$$
(6.5)

Now we claim $D_m \cdot V(\tau_i) = 0$ for all m > i. Assume that m > i and write m = i + j, where $1 \le j \le r - i$. We prove the claim by induction on j. If j = 1, then $D_m = D_{i+1}$.

Case 1: If $J_{i+1} = \emptyset$, then $D_{i+1} = D_{\rho_{i+1}^+}$. By (6.4), we see that

$$D_{i+1} \cdot V(\tau_i) = 0.$$

Case 2: Assume that $J_{i+1} \neq \emptyset$.

Subcase 1: If $i \notin J_{i+1}$, then by (6.4) and (6.5), we can see that

$$D_{i+1} \cdot V(\tau_i) = 0.$$

Subcase 2: If $i \in J_{i+1}$, then by (6.5), we have

$$D_{i+1} \cdot V(\tau_i) = c_{\rho_{i+1}^+}^{\gamma_{P_i}} + (D_{\rho_{i+1}^+} \cdot V(\tau_i)).$$

By (6.4), $D_{\rho_{i+1}^+} \cdot V(\tau_i) = -c_{\rho_{i+1}^+}^{\gamma_{P_i}}$ and hence $D_{i+1} \cdot V(\tau_i) = 0$. This proves the claim for j = 1.

Now assume that j > 1.

Case 1: If $J_m = \emptyset$, then by (6.4) and (6.5), we see that

$$D_m \cdot V(\tau_i) = 0.$$

Case 2: Assume that $J_m \neq \emptyset$.

Subcase 1: If $i \notin J_m$, then by (6.4) and (6.5), we can see that

$$D_m \cdot V(\tau_i) = \left(\left(\sum_{k \in J_m, k > i} c_{\rho_m^+}^{\gamma_{P_k}} D_k \right) \cdot V(\tau_i) \right) + \left(D_{\rho_m^+} \cdot V(\tau_i) \right).$$

By induction on $j,\, D_k \cdot V(\tau_i) = 0$ for all i < k < m. By (6.4), as m > i and $m \notin J_m$, we have

$$D_{
ho_m^+} \cdot V(au_i) = 0$$
 .

Hence we conclude that

$$D_m \cdot V(\tau_i) = 0.$$

This completes the proof of the proposition.

We have,

Theorem 6.7.

- (1) The nef cone $Nef(X_r)$ of X_r is generated by $\{D_i : 1 \le i \le r\}$.
- (2) The divisor $D = \sum_{i} a_i D_i$ is ample if and only if $a_i > 0$ for all $1 \le i \le r$.

Proof. Since the *nef* cone $Nef(X_r)$ is dual of the Mori cone $\overline{NE}(X_r)$, (1) follows from Proposition 6.6.

Proof of (2): This follows from (1) as the ample cone $Amp(X_r)$ is interior of the *nef* cone $Nef(X_r)$.

7. FANONESS AND WEAK FANONESS OF BOTT TOWER

In this section we describe the matrices M_r such that the corresponding to Bott tower X_r is Fano or weak Fano. First recall the *litaka dimension* of a Cartier divisor D in a normal projective variety X. Let

$$N(D) := \{ m \ge 0 : H^0(X, \mathscr{L}(mD)) \neq 0 \},\$$

where $\mathscr{L}(mD)$ is the line bundle associated to mD. For $m \in N(D)$, we have a rational map

$$\phi_m: X \dashrightarrow \mathbb{P}(H^0(X, \mathscr{L}(mD))^*).$$

If N(D) is empty we define the *litaka dimension* $\kappa(D)$ of D as $-\infty$. Otherwise we define

$$\kappa(D) := \max_{m \in N(D)} \{ dim(\phi_m(X)) \}.$$

Observe that $\kappa(D) \in \{-\infty, 0, 1, \dots, dim(X)\}$. We say D is big if $\kappa(D) = dim(X)$ (see [Laz04, Section 2.2, page 139]). Note that an ample divisor is big.

Lemma 7.1. Let X be a smooth projective variety, let U be an open affine subset of X. Let D be an effective divisor with support $X \setminus U$. Then D is big.

Proof. It suffices to show that there exists an effective divisor E with support $X \setminus U$ such that E is *big.* Indeed, we then have mD = E + F for some $m \ge 0$ and for some effective divisor F. Then E + F is big and hence so is D.

There exists $f_1, \ldots, f_n \in \mathcal{O}_X(U)$ algebraically independent over \mathbb{C} , where $n = \dim(X)$. View f_1, \ldots, f_n as rational functions on X, then $f_1, \ldots, f_n \in H^0(X, \mathcal{O}_X(E))$ for some effective divisor E with support $X \setminus U$ (since $\operatorname{div}(f_i)$ is an effective divisor with support in $X \setminus U$ for $1 \leq i \leq r$). Thus, the monomials in f_1, \ldots, f_n of any degree m are linearly independent elements of $H^0(X, \mathcal{O}_X(mE))$. So $\operatorname{dim}(H^0(X, \mathcal{O}_X(mE)))$ grows like m^n as $m \to \infty$. Hence E is big (see [Laz04, Corollary 2.1.38 and Lemma 2.2.3]) and this completes the proof.

We get the following as a variant of Lemma 7.1.

Let X be a smooth projective variety and D be an effective divisor. Let supp(D) denotes the support of D. If $X \setminus supp(D)$ is affine, then D is big.

A smooth projective variety X is called Fano (respectively, weak Fano) if its anticanonical line bundle $-K_X$ is ample (respectively, *nef* and *big*). To describe our results we use the notation and terminology from Section 1 (see page 3).

We prove,

Theorem 7.2.

- (1) X_r is Fano if and only if it satisfies II.
- (2) X_r is weak Fano if and only if it satisfies III.

Proof. Proof of (2): We have

$$K_{X_r} = -\sum_{\rho \in \Sigma(1)} D_\rho \tag{7.1}$$

(see [CLS11, Theorem 8.2.3] or [Ful93, Page 74]). The anti-canonical line bundle of any projective toric variety is *big*, since we have

$$supp(-K_{X_r}) = X_r \setminus (\mathbb{C}^*)^r,$$

 $(\mathbb{C}^*)^r$ is an affine open subset of X_r , by Lemma 7.1, $-K_{X_r}$ is big.

By using Lemma 6.1, we prove that $-K_{X_r}$ is *nef* if and only if X_r satisfies III.

Let $D = -K_{X_r}$. By (7.1) and by definition of d_i for D (see Lemma 6.1), we have

$$d_i = 2 - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j.$$

Then by Lemma 6.1(2), $-K_{X_r}$ is *nef* if and only if $\sum_{\gamma_j \in \gamma_{P_i}(1)} c_j \leq 2$ for all $1 \leq i \leq r$.

First assume that $-K_{X_r}$ is *nef.* Fix $1 \le i \le r$. By above discussion, we have

$$\sum_{\gamma_j \in \gamma_{P_i}(1)} c_j \le 2. \tag{7.2}$$

Since c_j 's are positive integers (see (5.4)), we get the following situation:

 $|\gamma_{P_i}(1)| = 0 \text{ or } |\gamma_{P_i}(1)| = 1, \text{ or } |\gamma_{P_i}(1)| = 2.$

<u>Case 1</u>: If $|\gamma_{P_i}(1)| = 0$, then by definition of γ_{P_i} (see Proposition 5.11), we have

$$r(P_i)$$
 : $e_i^+ + e_i^- = 0.$

Hence we see X_r satisfies the condition N_i^1 .

<u>Case 2</u>: If $|\gamma_{P_i}(1)| = 1$, then there exists unique $r \ge j > i$, such that $\gamma_j \in \gamma_{P_i}(1)$ and the primitive relation is either

$$r(P_i) : e_i^+ + e_i^- = c_j e_j^+$$
 (7.3)

or

$$r(P_i) : e_i^+ + e_i^- = c_j e_j^-$$
(7.4)

By (7.2), we get $c_i = 1$ or 2.

Subcase (i): Assume that $c_j = 1$. If the primitive relation is (7.3), then we can see that $|\eta_i^+| = 0$ and $c_j = -\beta_{ij} = 1$. Then $\beta_{ij} = -1$ and hence X_r satisfies the condition N_i^2 .

If the primitive relation is (7.4), then by (2.2) $|\eta_i^-| = 0$ and $|\eta_i^+| = 1$. Hence $c_j = \beta_{ij} = 1$ and $\beta_{jk} = 0$ for all k > j.

Subcase (ii): Assume that $c_j = 2$. If the primitive relation $r(P_i)$ is (7.3), then $|\eta_i^+| = 0$ and $|\eta_i^-| = 1$. So by (2.2), we have $c_j = -\beta_{ij}$. If the primitive relation $r(P_i)$ is (7.4), then $|\eta_i^+| = 1, |\eta_i^-| = 0$ and $\beta_{jk} = 0$ for all k > j. Again by (2.2), we have $c_j = \beta_{ij}$ Thus,

either
$$\beta_{ij} = -2$$
 or $\beta_{ij} = 2$.

Hence X_r satisfies the condition N_i^3 .

<u>Case 3</u>: If $|\gamma_{P_i}(1)| = 2$, then there exists $r \ge s_1 > s_2 > i$ with $\gamma_{s_1}, \gamma_{s_2} \in \gamma_{P_i}(1)$ such that the primitive relation $r(P_i)$ is

$$r(P_i) : e_i^+ + e_i^- = c_{s_1} e_{s_1}^\pm + c_{s_2} e_{s_2}^\pm$$
 (7.5)

Subcase (i): If the primitive relation is $r(P_i)$:: $e_i^+ + e_i^- = c_{s_1}e_{s_1}^+ + c_{s_2}e_{s_2}^+$, by (2.2) we see $\overline{|\eta_i^+| = 0}$ and $|\eta_i^-| = 2$. By (7.2) and (5.4) (c_i 's are positive integers), we get

 $c_{s_1}=1$, $c_{s_2}=1$ and $\beta_{is_1}=\beta_{is_2}=-1.$

Hence X_r satisfies the condition N_i^3 .

Subcase (ii): If the primitive relation is $r(P_i)$: $e_i^+ + e_i^- = c_{s_1}e_{s_1}^+ + c_{s_2}e_{s_2}^-$, by (2.2) we see $|\eta_i^+| = 1 = |\eta_i^-|$. Then $\beta_{is_1} = -1$, $\beta_{is_2} = 1$ and $\beta_{s_2k} = 0$ for all $k > s_2$.

Subcase (iii): If the primitive relation is $r(P_i)$: $e_i^+ + e_i^- = c_{s_1}e_{s_1}^- + c_{s_2}e_{s_2}^+$, by (2.2) we see $|\eta_i^+| = 1$ and $\beta_{is_1} = 1$. Then $\beta_{s_1s_2} - \beta_{is_2} = 1$ and $\beta_{s_1k} - \beta_{ik} = 0$ for all $k > s_2$.

Subcase (iv): If the primitive relation is $r(P_i)$: $e_i^+ + e_i^- = c_{s_1}e_{s_1}^- + c_{s_2}e_{s_2}^-$, by (2.2) we see $|\eta_i^+| = 1$ and $\beta_{is_1} = 1$. Then $\beta_{s_1s_2} - \beta_{is_2} = -1$ and $\beta_{is_2} - \beta_{s_1s_2} - \beta_{s_2k} = 0$ for all $k > s_2$.

Hence X_r satisfies the condition N_i^3 . Therefore, we conclude that if X_r is weak Fano then X_r satisfies the condition *III*. Similarly, we can prove by using Lemma 6.1(2), if X_r satisfies *III* then X_r is weak Fano. This completes the proof of (2).

Proof of (1): This follows by using similar arguments as in the proof of (2) and Lemma 6.1(1).

7.1. Local rigidity of Bott towers. Now we prove some vanishing results for the cohomology of tangent bundle of the Bott tower X_r and we get some local rigidity results. Let T_{X_r} denotes the tangent bundle of X_r . Then we have

Corollary 7.3. If $X_{\tilde{w}}$ satisfies II, then $H^i(X_{\tilde{w}}, T_{X_{\tilde{w}}}) = 0$ for all $i \ge 1$.

Proof. If X_r satisfies II, then by Theorem 7.2, X_r is Fano variety. By [BB96, Proposition 4.2], since X_r is a smooth Fano toric variety, we get $H^i(X_r, T_{X_r}) = 0$ for all $i \ge 1$. \Box

It is well known that by Kodaira-Spencer theory, the vanishing of $H^1(X, T_X)$ implies that X is locally rigid, i.e. admits no local deformations (see [Huy06, Proposition 6.2.10, page 272]).

Then by above result we have

Corollary 7.4. The Bott tower X_r is locally rigid if it satisfies II.

8. Log Fanoness of Bott towers

Recall that a pair (X, D) of a normal projective variety X and an effective \mathbb{Q} -divisor D is **Kawamata log terminal (klt)** if $K_X + D$ is \mathbb{Q} -Cartier, and for all proper birational maps $f : Y \longrightarrow X$, the pull back $f^*(K_X + D) = K_Y + D'$ satisfies $f_*K_Y = K_X$ and $\lfloor D' \rfloor \leq 0$, where $\lfloor \sum_i a_i D_i \rfloor = \sum_i \lfloor a_i \rfloor D_i$, $\lfloor x \rfloor$ is the greatest integer $\leq x$.

The pair (X, D) is called **log Fano** if it is klt and $-(K_X + D)$ is ample.

We recall here, a condition for the anti-canonical line bundle to be *big* (see [CG13]). Let X be a \mathbb{Q} - Gorenstein projective normal variety over \mathbb{C} . If X admits a divisor D with the pair (X, D) being log Fano then $-K_X$ is big (In [CG13] there is a necessary and sufficient condition that X is log Fano (or "Fano type") variety, see [CG13, Theorem 1.1] for more details on this).

If X is smooth and D is a normal crossing divisor, the pair (X, D) is log Fano if and only if $\lfloor D \rfloor = 0$ and $-(K_X + D)$ is ample (see [KM08, Lemma 2.30, Corollary 2.31 and Definition 2.34]). In case of toric variety X see also [CLS11, Definition 11.4.23 and Proposition 11.4.24, page 558]. We use notation as in Lemma 6.1. Let $D = \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho}$ be a toric divisor in X_r , with $a'_{\rho}s$ in $\mathbb{Q}_{\geq 0}$ and $\lfloor D \rfloor = 0$. For $1 \leq i \leq r$, define

$$k_i := d_i - 2 + \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j.$$

Then we prove,

Theorem 8.1. The pair (X_r, D) is log Fano if and only if $k_i < 0$ for all $1 \le i \le r$.

Proof. From the above discussion by the condition on D, the pair (X_r, D) is log Fano if and only if $-(K_{X_r} + D)$ is ample. Note that as $-K_{X_r} = \sum_{\rho \in \Sigma(1)} D_{\rho}$, we get

$$-(K_{X_r} + D) = \sum_{\rho \in \Sigma(1)} (1 - a_{\rho}) D_{\rho}$$

By Lemma 6.1, $-(K_{X_r} + D)$ is ample if and only if

$$\left((1 - a_{\rho_i^+}) + (1 - a_{\rho_i^-}) - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j(1 - a_{\gamma_j})\right) > 0 \text{ for all } 1 \le i \le r.$$
(8.1)

Recall the definition of d_i for D,

$$d_i = a_{\rho_i^+} + a_{\rho_i^-} - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j a_{\gamma_j}.$$

Then we have

$$\left((1-a_{\rho_i^+})+(1-a_{\rho_i^-})-\sum_{\gamma_j\in\gamma_{P_i}(1)}c_j(1-a_{\gamma_j})\right)=-(d_i-2+\sum_{\gamma_j\in\gamma_{P_i}(1)}c_j).$$

Hence in (8.1)

$$((1 - a_{\rho_i^+}) + (1 - a_{\rho_i^-}) - \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j(1 - a_{\gamma_j})) = -k_i \text{ for all } 1 \le i \le r$$

and we conclude that $-(K_{X_r} + D)$ is ample if and only if $k_i < 0$ for all $1 \le i \le r$. This completes the proof of the theorem.

9. Extremal rays and Mori rays of the Bott tower

In this section we study the extremal rays and Mori rays of Mori cone of X_r . First we recall some definitions. Let V be a finite dimensional vector space over \mathbb{R} and let K be a (closed) cone in V. A subcone Q in K is called extremal if $u, v \in K, u + v \in Q$ then $u, v \in Q$. A face of K is an extremal subcone. A one-dimensional face is called an extremal ray. Note that an extremal ray is contained in the boundary of K.

Let X be a smooth projective variety. An extremal ray R in $\overline{NE}(X) \subset N_1(X)$ is called Mori if $R \cdot K_X < 0$, where K_X is the canonical divisor in X. Recall that $\overline{NE}(X_r)$ is a strongly convex rational polyhedral cone of maximal dimension in $N_1(X_r)$.

We prove,

Theorem 9.1.

- (1) The class of curves $r(P_i)$ for $1 \le i \le r$ are all extremal rays in the Mori cone $\overline{NE}(X_r)$ of X_r .
- (2) Fix $1 \le i \le r$, the class of curve $r(P_i)$ is Mori ray if and only if either $|\gamma_{P_i}(1)| = 0$, or $|\gamma_{P_i}(1)| = 1$ with $c_j = 1$ for $\gamma_j \in \gamma_{P_i}(1)$.

Proof. Proof of (1): This follows from Theorem 5.7 and Corollary 5.8.

Proof of (2): By (1), $r(P_i)$ $1 \leq i \leq r$ are all extremal rays in $\overline{NE}(X_r)$. Hence for $1 \leq i \leq r$, $r(P_i)$ is Mori if $K_{Xr} \cdot r(P_i) < 0$. Since $K_{Xr} = -\sum_{\rho \in \Sigma(1)} D_{\rho}$, we can see by Corollary 5.13 and by similar arguments as in the proof of Lemma 6.1

$$K_{X_r} \cdot r(P_i) = -2 + \sum_{\gamma_j \in \gamma_{P_i}(1)} c_j.$$
 (9.1)

Thus if $K_{Xr} \cdot r(P_i) < 0$, then

$$\sum_{\alpha_j \in \gamma_{P_i}(1)} c_j < 2$$

As c_j are all positive integers (see 5.4), we get either $|\gamma_{P_i}(1)| = 0$, or $|\gamma_{P_i}(1)| = 1$ and $c_j = 1$ for $\gamma_j \in \gamma_{P_i}(1)$.

Similarly, by using (9.1) we can prove the converse. This completes the proof of the theorem. $\hfill \Box$

Now we prove a general result for smooth projective toric varieties,

Lemma 9.2. Let X be a smooth projective toric variety of dimension r. Then X is Fano if and only if every extremal ray is Mori.

Proof. By [CLS11, Theorem 6.3.20](Toric Cone Theorem), we have

$$\overline{NE}(X) = \sum_{\tau \in \Sigma(r-1)} [V(\tau)].$$
(9.2)

If X is Fano, then by definition, $-K_X$ is ample. By toric Kleiman criterion for ampleness [CLS11, Theorem 6.3.13], we can see that $-K_X \cdot V(\tau) > 0$ for all $\tau \in \Sigma(r-1)$. Then $K_X \cdot V(\tau) < 0$ for all $\tau \in \Sigma(r-1)$. In particular, every extremal ray is Mori.

Conversely, let $\mathbb{R}_{\geq 0}[V(\tau)]$ be an extremal ray, by assumption it is a Mori ray. Then by definition of a Mori ray, we have $K_X \cdot V(\tau) < 0$. This implies $-K_X \cdot V(\tau) > 0$. By (9.2), $\overline{NE}(X)$ is a polyhedral cone and hence the extremal rays generate the cone $\overline{NE}(X)$. Hence we see that $-K_X \cdot C > 0$ for all classes of curves [C] in $\overline{NE}(X)$. Again by toric Kleiman criterion for ampleness, we conclude that $-K_X$ is ample and hence Xis Fano.

Then we have the following:

Corollary 9.3. The Bott tower X_r is Fano if and only if every extremal ray in $NE(X_r)$ is Mori.

10. Applications to BSDH varieties and its toric limits

In this section we see some applications to BSDH-varieties, by using their toric degeneration as a Bott tower. 10.1. Ample cone of the toric limit of BSDH variety. In [LT04], the ampleness of line bundles on BSDH variety $Z(\tilde{w})$ is studied. Now we compare the ample cone of the toric limit $X_{\tilde{w}}$ with that of the BSDH-variety $Z(\tilde{w})$ as a consequence of Theorem 3.2.

Corollary 10.1. The ample cone $Amp(X_{\tilde{w}})$ of $X_{\tilde{w}}$ can be identified with a subcone of the ample cone $Amp(Z(\tilde{w}))$ of $Z(\tilde{w})$.

Proof. By Theorem 3.2, $\pi : \mathcal{X} \to \mathbb{A}^1$ is a smooth projective morphism with $\mathcal{X}_0 = X_{\tilde{w}}$ and $\mathcal{X}_u = Z(\tilde{w})$ for $u \neq 0$.

Let $\mathcal{L} = {\mathcal{L}_u : u \in \mathbb{A}^1}$ be a line bundle on $\pi : \mathcal{X} \to \mathbb{A}^1$ with \mathcal{L}_0 is an ample line bundle on $X_{\tilde{w}}$. Note that the ampleness of line bundle is an open condition for the proper morphism π , i.e. there exists an open subset U in \mathbb{A}^1 containing 0 such that \mathcal{L}_u is ample line bundle on \mathcal{X}_u for all $u \in U$ (see [Laz04, Theorem 1.2.17]). Hence we can identity $Amp(X_{\tilde{w}})$ with a subcone of $Amp(Z(\tilde{w}))$.

10.2. Fano and weak Fano properties. In this section, we observe that Fano and weak Fano properties for BSDH variety $Z(\tilde{w})$ depend on the given expression \tilde{w} .

When G is finite dimensional and the expression \tilde{w} is reduced, the classification of the expressions \tilde{w} for which $Z(\tilde{w})$ is Fano or weak Fano is considered in [Cha17]. Here we get similar results when G is a Kac-Moody group.

First we discuss the conditions I, II and III with some examples. We use the ordering of simple roots as in [Hum72, Page 58].

<u>The condition I:</u>

This condition means that the expression \tilde{w} is fully commutative without repeating the simple reflections. For example if $G = SL(n, \mathbb{C})$ and $\tilde{w} = s_{\alpha_1}s_{\alpha_3}\cdots s_{\alpha_r}$, $1 < r \leq n-1$ and r is odd, then $|\eta_i^+| = 0$ and $|\eta_i^-| = 0$ for all i.

• $X_{\tilde{w}}$ (or $Z(\tilde{w})$) satisfies the condition I and also observe that in this case we have

$$X_{\tilde{w}} \simeq Z(\tilde{w}) \simeq \mathbb{P}^1 \times \cdots \times \mathbb{P}^1 \quad (dim(Z(\tilde{w})) \text{ times }).$$

The condition II:

Let $G = SL(n, \mathbb{C})$ and fix $1 \leq j < r \leq n-1$ such that j is even and r is odd.

Let $\tilde{w} = s_{\alpha_1} s_{\alpha_3} \cdots s_{\alpha_{j-3}} s_{\alpha_{j-1}} s_{\alpha_j} s_{\alpha_{j+1}} s_{\alpha_{j+3}} \cdots s_{\alpha_r}$.

Note that s_{α_j} appears only once in the expression \tilde{w} and $|\eta_i^+| = 0$ for all *i*. Let *p* be the 'position of s_{α_j} ' in the expression \tilde{w} , then $|\eta_i^-| = 0$ for all $i \neq p, p-1$ and $|\eta_{p-1}^-| = 1 = |\eta_p^-|$ with $\beta_{p-1p} = -1 = \beta_{pp+1}$.

• $X_{\tilde{w}}$ (or $Z(\tilde{w})$) satisfies condition II but not I.

The condition *III*:

Again, let $G = SL(n, \mathbb{C})$ and fix $1 \le j < r \le n-1$ such that j is even and r is odd.

Let $\tilde{w} = s_{\alpha_1}s_{\alpha_3}\cdots s_{\alpha_{j-3}}s_{\alpha_j}s_{\alpha_{j-1}}s_{\alpha_{j+1}}s_{\alpha_{j+3}}\cdots s_{\alpha_r}$ (observe that we interchanged s_{α_j} and $s_{\alpha_{j-1}}$ in the example of condition II). Then $|\eta_i^+| = 0$ and $|\eta_i^-| \leq 2$ for all *i*. Let *p* be

the 'position of s_{α_j} ' in the expression \tilde{w} , then $|\eta_i^-| = 0$ for all $i \neq p$ and $|\eta_p^-| = 2$ with $\beta_{pp+1} = -1 = \beta_{pp+1}$.

• $X_{\tilde{w}}$ (or $Z(\tilde{w})$) satisfies the condition III but not I and II.

Let $\tilde{w} = s_{\alpha_1} s_{\alpha_3} s_{\alpha_1}$. Then $|\eta_1^+| = 1$ with $\beta_{13} = 2$, and $|\eta_1^-| = |\eta_2^+| = \eta_2^-| = 0$.

• $X_{\tilde{w}_1}$ (or $Z(\tilde{w}_1)$) satisfies III but not I and II.

Observe that the condition $|\eta_i^-| = 1$ and $\beta_{il} = -2$, happens only in non-simply laced cases. Let G = SO(5, k) (i.e. G is of type B_2), let $\tilde{w}_1 = s_{\alpha_2}s_{\alpha_1}$ and $\tilde{w}_2 = s_{\alpha_1}s_{\alpha_2}$. Recall that we have $\langle \alpha_1, \alpha_2 \rangle = -2$ and $\langle \alpha_2, \alpha_1 \rangle = -1$. Then

- $X_{\tilde{w}_1}$ (or $Z(\tilde{w}_1)$) satisfies *III* but not *I* and *II*.
- $X_{\tilde{w}_2}$ (or $Z(\tilde{w}_2)$) satisfies II but not I.

Let G be of type G_2 (with $\langle \alpha_1, \alpha_2 \rangle = -1$ and $\langle \alpha_2, \alpha_1 \rangle = -3$). Let $\tilde{w}_1 = s_{\alpha_2} s_{\alpha_1}$ and $\tilde{w}_2 = s_{\alpha_1} s_{\alpha_2}$. Then

- $X_{\tilde{w}_1}$ (or $Z(\tilde{w}_1)$) satisfies II but not I.
- $X_{\tilde{w}_2}$ (or $Z(\tilde{w}_2)$) does not satisfy any of the conditions I, II or III.

Recall that the canonical line bundle $\mathcal{O}_{Z(\tilde{w})}(K_{Z(\tilde{w})})$ of $Z(\tilde{w})$ is given by

$$\mathcal{O}_{Z(\tilde{w})}(K_{Z(\tilde{w})}) = \mathcal{O}_{Z(\tilde{w})}(-\partial Z(\tilde{w})) \otimes \mathcal{L}(-\delta),$$

where $\partial Z(\tilde{w})$ is the boundary divisor of $Z(\tilde{w})$ and $\delta \in N$ such that $\langle \delta, \check{\alpha} \rangle = 1$ for all $\alpha \in S$, where $\check{\alpha}$ is the co-root of α (see [Kum12, Proposition 8.1.2] and also [Ram85, Proposition 2]). Note that if G is finite dimensional, δ is half sum of the positive roots.

Recall that by Lemma 3.5, the toric limit $X_{\tilde{w}}$ is a Bott tower. Now we have the following result:

Corollary 10.2.

- (1) If $Z(\tilde{w})$ satisfies II, then $Z(\tilde{w})$ is Fano.
- (2) If $Z(\tilde{w})$ satisfies III, then $Z(\tilde{w})$ is weak Fano.

Proof. By Theorem 3.2, $\phi : \mathcal{X} \to \mathbb{A}^1$ is a smooth projective morphism with $\mathcal{X}_0 = X_{\tilde{w}}$ and $\mathcal{X}_u = Z(\tilde{w})$ for $u \in \mathbb{A}^1$, $u \neq 0$.

Proof of (1): By [Laz04, Theorem 1.2.17], if $-K_{\chi_0}$ is ample then $-K_{\chi_u}$ is ample for $u \neq 0$. By Theorem 7.2, $-K_{X_{\tilde{w}}}$ is ample if and only if $X_{\tilde{w}}$ satisfies *II*. Hence we conclude that if $Z(\tilde{w})$ satisfies *II*, then $Z(\tilde{w})$ is Fano.

Proof of (2): First we prove $-K_{Z(\tilde{w})}$ is *big.* Let

$$Z_0 := Z(\tilde{w}) \setminus \partial Z(\tilde{w}).$$

Note that Z_0 is an open affine subset of $Z(\tilde{w})$. Then by Lemma 7.1, $\partial Z(\tilde{w})$ is *big*. Since

$$\mathcal{O}(-K_{Z(\tilde{w})}) = \mathcal{O}(\partial Z(\tilde{w})) \otimes \mathcal{L}(\delta)$$

and $\mathcal{L}(\delta)$ is *nef*, we conclude $-K_{Z(\tilde{w})}$ is *big*, as tensor product of a *big* and a *nef* line bundles is again a big line bundle.

By [Laz04, Theorem 1.4.14] and $\mathcal{X}_u = Z(\tilde{w})$ for $u \neq 0$, we can see that if $-K_{\mathcal{X}_0}$ is *nef* then $-K_{\mathcal{X}_u}$ is also *nef* for $u \neq 0$. Therefore, (2) follows from Theorem 7.2(2).

There exists expressions \tilde{w} such that the BSDH variety $Z(\tilde{w})$ Fano (respectively, weak Fano) but the toric limit $X_{\tilde{w}}$ is not Fano (respectively, not weak Fano).

Example 10.3. Let $G = SL(4, \mathbb{C})$.

- (1) Let $\tilde{w} = s_{\alpha_1}s_{\alpha_1}$. Then $Z(\tilde{w}) \simeq \mathbb{P}^1 \times \mathbb{P}^1$, which is Fano. The toric limit $X_{\tilde{w}} \simeq \mathbb{P}(\mathcal{O}_{\mathbb{P}^1} \oplus \mathcal{O}_{\mathbb{P}^1}(2))$. Since $X_{\tilde{w}}$ does not satisfy II, then by Theorem 7.2, $X_{\tilde{w}}$ is not Fano.
- (2) Let $\tilde{w} = s_{\alpha_1} s_{\alpha_2} s_{\alpha_1}$. Then it can be seen $Z(\tilde{w})$ is Fano (see [Cha17, Example 5.3]). By Theorem 7.2, the toric limit $X_{\tilde{w}}$ is weak Fano but not Fano.

Example 10.4. Let G = SO(5, k), i.e. G is of type B_2 . Let $\tilde{w} = s_{\alpha_1} s_{\alpha_2} s_{\alpha_1}$. By Theorem 7.2, the toric limit $X_{\tilde{w}}$ is not weak Fano. Also we can see $Z(\tilde{w})$ is weak Fano but not Fano (see [Cha17, Theorem 5.2]).

10.3. Log Fano BSDH varieties and its toric limits. In [And14] and [AS14] log Fanoness of Schubert varieties and BSDH varieties were studied respectively. Now we characterize the (suitably chosen) \mathbb{Q} -divisors D in $X_{\tilde{w}}$ (respectively, D' in $Z(\tilde{w})$) for which $(X_{\tilde{w}}, D)$ (respectively, $(Z(\tilde{w}), D')$ is log Fano.

Let $\gamma_i = s_{\beta_r} \cdots s_{\beta_{i+1}}(\beta_i)$ for $1 \le i \le r$. Then,

$$\mathcal{L}(\delta) = \sum_{i=1}^{r} b_i Z_i , \text{ with}$$
$$b_i = \langle \delta, \check{\gamma}_i \rangle = ht(\gamma_i), \tag{10.1}$$

where δ is as in Section 10.2 (see page 36), $\mathcal{L}(\delta)$ is the homogeneous line bundle on $Z(\tilde{w})$ corresponding to δ and $ht(\beta)$ for a root $\beta = \sum_{i=1}^{n} n_i \alpha_i$, is the height defined by $ht(\beta) = \sum_{i=1}^{n} n_i$ (see [MR85, Proof of Proposition 10]). When \tilde{w} is reduced, γ_i is a positive root and we can see the relation (10.1) from the Chevalley formula for intersection of Schubert variety by a divisor (see [AS14, Page 410] or [Che94]). It is known that

$$-K_{Z(\tilde{w})} = \sum_{i=1}^{\prime} (b_i + 1)Z_i$$
(10.2)

(see [MR85, Proposition 4]). Let $D' = \sum_{i=1}^{r} a_i Z_i$ be a effective \mathbb{Q} -divisor in $Z(\tilde{w})$, with $\lfloor D' \rfloor = 0$. Then by (10.2), we get

$$-(K_{Z(\tilde{w})} + D') = \sum_{i=1}^{r} (b_i + 1 + a_i) Z_i.$$

For $1 \leq i \leq r$, define

$$f_i := (b_i + 1 + a_i) - \sum_{\gamma_j \in \gamma_{P_i}(1)^+} c_j (b_j + 1 + a_j),$$

where $\gamma_{P_i}(1)^+ := \gamma_{P_i}(1) \cap \{\rho_l^+ : 1 \le l \le r\}.$

We prove,

Theorem 10.5. The pair $(Z(\tilde{w}), D')$ is log Fano if $f_i > 0$ for all $1 \le i \le r$.

Proof. By definition of D', the pair $(Z(\tilde{w}), D')$ is log Fano if and only if $-(K_{Z(\tilde{w})} + D')$ is ample. Now we prove $-(K_{Z(\tilde{w})} + D')$ is ample if $f_i > 0$ for all $1 \le i \le r$. Recall that $Z_i = \{[(p_1, \ldots, p_r)] \in Z(\tilde{w}) : p_i \in B\}$ is a divisor in $Z(\tilde{w}), D_{\rho_i^+}$ is the divisor corresponding to $\rho_i^+ \in \Sigma(1)$ and $Z_i^x = \pi^{-1}(x) \cap Z_i$ for $x \in k$ (see Section 2 and Section 3).

By Theorem 3.2, we have

$$\mathcal{Z}_i^x = Z_i \text{ for } x \neq 0 \text{ and } \mathcal{Z}_i^0 = D_{\rho_i^+}.$$
 (10.3)

Assume that $f_i > 0$ for all $1 \le i \le r$. By (10.3) and by [Laz04, Theorem 1.2.7] to prove $(Z(\tilde{w}), D')$ is log Fano it is enough to prove

$$\sum_{i=1}^{r} (b_i + 1 + a_i) D_{\rho_i^+} \text{ is ample }.$$

By Lemma 6.1, we see that $\sum_{i=1}^{r} (b_i + 1 + a_i) D_{\rho_i^+}$ is ample if and only if

$$f_i = ((b_i + 1 + a_i) - \sum_{\gamma_j \in \gamma_{P_i}(1)^+} c_j(b_j + 1 + a_j)) > 0 \text{ for all } 1 \le i \le r.$$

Hence we conclude that $(Z(\tilde{w}), D')$ is log Fano.

10.4. Local rigidity of BSDH varieties and its toric limits. In this section we obtain some vanishing results for the cohomology of tangent bundle of the toric limit $X_{\tilde{w}}$ and $Z(\tilde{w})$.

In [CKP15] and [CK17], we have obtained some vanishing results for the cohomology of tangent bundle of $Z(\tilde{w})$, when G is finite dimensional and \tilde{w} is reduced (see [CKP15, Section 3] and [CK17, Theorem 8.1]). The case \tilde{w} is non-reduced is considered in [CKP].

Now we prove some vanishing results for the cohomology of tangent bundle of BSDH variety $Z(\tilde{w})$ when G is Kac-Moody group and \tilde{w} not necessarily reduced. Let T_X denotes the tangent bundle of X, where $X = X_{\tilde{w}}$ or $Z(\tilde{w})$. Then we have

Corollary 10.6.

- (1) If $X_{\tilde{w}}$ satisfies II, then $H^i(X_{\tilde{w}}, T_{X_{\tilde{w}}}) = 0$ for all $i \ge 1$. In particular, $X_{\tilde{w}}$ is locally rigid.
- (2) If $Z(\tilde{w})$ satisfies II, then $H^i(Z(\tilde{w}), T_{Z(\tilde{w})}) = 0$ for all $i \ge 1$. In particular, $Z(\tilde{w})$ is locally rigid.

Proof. Proof of (1): This follows from Corollary 7.3 as $X_{\tilde{w}}$ is a Bott tower.

Proof of (2): From Theorem 3.2, $\pi : \mathcal{X} \to \mathbb{A}^1$ is a smooth projective morphism with $\mathcal{X}_0 = X_{\tilde{w}}$ and $\mathcal{X}_u = Z(\tilde{w})$ for $u \in \mathbb{A}^1$, $u \neq 0$. Hence (2) follows from (1) by semi-continuity theorem (see [Har77, Theorem 12.8]).

11. AJP AND PK RESULTS USING TORIC GEOMETRY

In this section we are going to recover the results of [PK16] by using methods of toric geometry. In [PK16], they have assumed that G is a simple algebraic group. In our situation G is a Kac-Moody group.

Recall the following:

- (1) $\tilde{w} = s_{\beta_1} \cdots s_{\beta_r}$ and $\tilde{w}' = s_{\beta_1} \cdots s_{\beta_{r-1}}$.
- (2) The toric morphism

$$f_r: X_{\tilde{w}} \to X_{\tilde{w}'}$$

induced by the lattice map

$$\overline{f}_r: \mathbb{Z}^r \to \mathbb{Z}^{r-1},$$

the projection onto the first r-1 coordinates.

As we discussed in Section 3, there are two disjoint toric sections for the \mathbb{P}^1 -fibration

$$f_r: X_{\tilde{w}} \to X_{\tilde{w}'}$$

(see Lemma 3.4).

Definition 11.1.

- (1) <u>Schubert and non-Schubert sections</u>: We call the section corresponding to the maximal cone ρ_r^+ (respectively, ρ_r^-) in Σ_F (the fan of the fiber of f_r) by 'Schubert section σ_{r-1}^0 ' (respectively, 'non-Schubert section σ_{r-1}^1)').
- (2) Schubert point: Let $\sigma \in \Sigma$ be the maximal cone generated by

$$\{e_1^+,\ldots,e_r^+\}.$$

We call the point in $X_{\tilde{w}}$ corresponding to the maximal cone σ by 'Schubert point'.

(3) <u>Schubert line</u>: We call the fiber of f_r over the Schubert point by 'Schubert line L_r '.

Note that these definitions agree with that of in [PK16].

Now onwards we denote $\tilde{w} = (1, \ldots, r)$ (respectively, $\tilde{w}' = (1, \ldots, r-1)$) for the expression $\tilde{w} = s_{\beta_1} \cdots s_{\beta_r}$ (respectively, $\tilde{w}' = s_{\beta_1} \cdots s_{\beta_{r-1}}$).

Let $I_{i_1} = (i_1, \ldots, i_m)$ be a subsequence of \tilde{w} . Inductively we define the curve $L_{I_{i_1}}$ corresponding to I_{i_1} . Let $L_{I'_{i_1}}$ be the curve in $X_{\tilde{w}'}$ corresponding to the subsequence $I'_{i_1} = (i_1, \ldots, i_{m-1})$ of I_{i_1} . Then define

$$L_{I_{i_1}} := \sigma_{r-1}^1(L_{I'_{i_1}}).$$

and

$$\sigma_{r-1}^0(L_{I'_{i_1}}) = L_{I'_{i_1}}.$$

We have the following result:

Lemma 11.2. The classes of Schubert lines L_j , $1 \le j \le r$ form a basis of $N_1(X_{\tilde{w}})$.

Proof. Proof is by induction on r. Assume that the result is true for r-1. Since $X_{\tilde{w}}$ is a projective bundle over $X_{\tilde{w}'}$ (see Lemma 3.4), then by [Bar71, Lemma 1.1],

$$L_r$$
 and $\sigma_{r-1}^0(L_j)$ for $1 \le j \le r$

(the image of L_j by the Schubert section in $X_{\tilde{w}}$) form a basis of $N_1(X_{\tilde{w}})$. By definition of L_I , we have

$$\sigma_{r-1}^0(L_j) = L_j \text{ for } 1 \le j \le r-1$$

and hence the result follows.

Let $1 \leq j \leq r$. Let $\mathscr{D} := \{e_l^{\epsilon_l} : 1 \leq l \leq r \text{ and } \epsilon_l = + \text{ for all } l\}$. Let $\mathscr{D}'_j := \{e_l^{\epsilon_l} : 1 \leq l \leq r \text{ and } \epsilon_l = + \text{ for all } l \neq l; \epsilon_j = -\}$.

Lemma 11.3. Fix $1 \leq j \leq r$. Then the Schubert line L_j is given by

$$L_j = V(\tau_j)$$
, with $\tau_j = \sigma \cap \sigma'_j$,

intersection of the maximal cones in Σ , where σ (respectively, σ'_j) is generated by \mathscr{D} (respectively, \mathscr{D}'_j).

Proof. Let us consider the expression $\tilde{w}_j = s_{\beta_1} \cdots s_{\beta_j}$ for $1 \leq j < r$. Let Σ_j be the fan of the toric variety $X_{\tilde{w}_j}$. By Lemma 3.4,

$$f_j: X_{\tilde{w}_j} \to X_{\tilde{w}_{j-1}}$$

is a \mathbb{P}^1 -fibration induced by $\overline{f}_j : \mathbb{Z}^j \to \mathbb{Z}^{j-1}$ the projection onto the first j-1 factors. Also note that the Schubert point in $X_{\tilde{w}_{j-1}}$ corresponds to the maximal cone generated by

$$\{e_l^+ : 1 \le l \le j - 1\}$$

and the fan of the fiber is given by $\{e_j^+, 0, e_j^-\}$. Let σ_j (respectively, σ'_j) be the cone generated by

$$\{e_l^+: 1 \le l \le j\}$$

(respectively,

$$\{e_l^+: 1 \le l \le j-1\} \cup \{e_j^-\} \quad)$$

Then by definition of Schubert line L_j , we can see that L_j is the curve in $X_{\tilde{w}_j}$ given by

$$L_j = V(\tau_j)$$
, where $\tau_j \in \Sigma_j$ and $\tau_j = \sigma_j \cap \sigma'_j$

Since the Schubert section of f_k for $(j \le k \le r)$ corresponds to e_k^+ , we see

$$\sigma_r^0 \circ \cdots \circ \sigma_{j+1}^0(L_j),$$

by abuse of notation we also denote it again by L_j in $X_{\tilde{w}}$, is given by

$$L_j = V(\tau_j)$$
 with $\tau = \sigma \cap \sigma'_j$,

where σ and σ'_j are as described in the statement. This completes the proof of the lemma.

40

Let $\mathscr{D}_{i_1}'' := \{e_l^{\epsilon_l} : 1 \le l \le r \text{ and }$

$$\epsilon_l = \begin{cases} + & \text{if } l \notin I_{i_1} \setminus \{i_1\} \\ - & \text{if } l \in I_{i_1} \end{cases} \}.$$

Let $\mathscr{D}_{i_1}^{\prime\prime\prime} := \{e_l^{\epsilon_l} : 1 \le l \le r \text{ and }$

$$\epsilon_l = \begin{cases} + & \text{if } l \notin I_{i_1} \\ - & \text{if } l \in I_{i_1} \end{cases}$$

Proposition 11.4. The curve $L_{I_{i_1}}$ is given by

$$L_{I_{i_1}} = V(\tau_{i_1}) \text{ with } \tau_{i_1} = \sigma_{i_1} \cap \sigma'_{i_1},$$

where σ_{i_1} (respectively, σ'_{i_1}) is the cone generated by \mathscr{D}''_{i_1} (respectively, \mathscr{D}''_{i_1}).

Proof. As in the proof of Lemma 11.3, we start with $j = i_1$ and L_{i_1} is the Schubert line in $X_{\tilde{w}_{i_1}}$. By Lemma 11.3, we have

$$L_{i_1} = V(\tau_{i_1})$$
 with $\tau_{i_1} = \sigma_{i_1} \cap \sigma'_{i_1}$.

By definition of L_I , we have

$$\sigma_{i_2-1}^0 \circ \dots \circ \sigma_{i_1+1}^0(L_{i_1}) = L_{i_1} \text{ in } X_{\tilde{w}_{i_2-1}}$$

and

$$\sigma_{i_2}^1 \circ \sigma_{i_2-1}^0 \circ \dots \circ \sigma_{i_1+1}^0(L_{i_1}) = L_{\{i_1, i_2\}} \text{ in } X_{\tilde{w}_{i_2}}.$$

By repeating the process we conclude that

$$L_{I_{i_1}} = V(\tau_{i_1})$$
 with $\tau_{i_1} = \sigma_{i_1} \cap \sigma'_{i_1}$,

where σ_{i_1} and σ'_{i_1} are as described in the statement. This completes the proof of the proposition.

Fix $1 \leq i \leq r$. Let

$$I_i := \{i = j_1, j_2, \dots, j_m\}$$

as in Proposition 5.11.

Theorem 11.5. The class of curve L_{I_i} is $r(P_i)$ in $N_1(X_{\tilde{w}})_{\mathbb{Z}}$.

Proof. This follows from Proposition 5.16 and Proposition 11.4.

Now we get [PK16, Theorem 22] as a corollary.

Corollary 11.6. The set $\{L_{I_i} : 1 \leq i \leq r\}$ of classes of curves forms a basis of $N_1(X_{\tilde{w}})$ and every torus invariant curve in $N_1(X_{\tilde{w}})$ lie in the cone generated by $\{L_{I_i} : 1 \leq i \leq r\}$.

Proof. First assertion follows from Corollary 5.8 and Theorem 11.5. Second assertion follows from Theorem 5.7. $\hfill \Box$

We have the following result (see [PK16, Theorem 30])

Corollary 11.7. The extremal rays of the toric limit $X_{\tilde{w}}$ are precisely the curves L_{I_i} for $1 \leq i \leq r$.

Proof. This follows from Theorem 9.1 and Theorem 11.5.

We prove the following:

Proposition 11.8. Let $1 \leq j \leq r$ and let L_j be the Schubert curve in $X_{\tilde{w}}$. Then,

$$K_{X_{\tilde{w}}} \cdot L_j = -2 - \sum_{k>j} \beta_{kj}.$$

Proof. By definition of e_i^- , we have

$$e_j^+ + e_j^- + \sum_{k>j} \beta_{kj} e_k^+ = 0.$$
(11.1)

By Lemma 11.3, we have $L_j = V(\tau)$, with $\tau = \sigma \cap \sigma'$ where σ (respectively, σ') is generated by

$$\{e_l^{\epsilon_l}: 1 \le l \le r, \epsilon_l = + \text{ for all } l\}$$

(respectively,

$$\{e_l^{\epsilon_l}: \epsilon_l = + \text{ for } 1 \le l \le r \text{ and } l \ne j, \epsilon_j = -\}$$
).

Hence (11.1) is the wall relation for the curve L_j . Then by wall relation, we see that

$$D_{\rho} \cdot L_{j} = \begin{cases} 1 & \text{if } \rho = \rho_{j}^{+} \text{ or } \rho_{j}^{-}.\\ \beta_{kj} & \text{if } \rho = \rho_{k}^{+} \text{ and } k > j.\\ 0 & \text{otherwise.} \end{cases}$$

Since $K_{X_{\tilde{w}}} = -\sum_{\rho \in \Sigma(1)} D_{\rho}$, we get

$$K_{X_{\bar{w}}} \cdot L_j = -2 - \sum_{k>j} \beta_{kj}.$$

This completes the proof of the proposition.

Similarly, the results [PK16, Theorem 35] and [PK16, Corollary 36] follow from Theorem 9.1 and Corollary 9.3.

Remark 11.9.

- (1) In Theorem 7.3, we have seen the vanishing results of the tangent bundle of Bott tower X_r for some special cases. It is an interesting problem to study the cohomology of tangent bundle of X_r, which gives local rigidity results for X_r, and hence for the BSDH variety Z(w).
- (2) It also interesting to find the automorphism group of the Bott tower X_r . We are working in this direction.

12. Appendix

By Lemma 4.1, the set $\{D_{\rho_i^+} : 1 \leq i \leq r\}$ forms a basis of $Pic(X_r)$. Now we describe $D_{\rho_i^-}$ in terms of $D_{\rho_j^+}$'s $(1 \leq j \leq r)$.

Let $1 \leq i \leq r$, define $h_i^{i-1} := -\beta_{i,i-1}$ and

$$h_{i}^{j} := \begin{cases} 0 & \text{for } j > i. \\ 1 & \text{for } j = i. \\ -\sum_{k=j}^{i-1} \beta_{i,k}(h_{k}^{j}) & \text{for } j < i. \end{cases}$$

Then we prove,

Lemma 12.1. Let $1 \leq i \leq r$. The coefficient of $D_{\rho_j^+}$ in $D_{\rho_i^-}$ is h_i^j .

Proof. Proof is by induction on i and by using

$$0 \sim div(\chi^{e_i^+}) = \sum_{\rho \in \Sigma(1)} \langle u_\rho, e_i^+ \rangle D_\rho.$$
(12.1)

Recall the equation (2.2),

$$e_i^- = -e_i^+ - \sum_{j>i} \beta_{ij} e_j^+ \text{ for all i }.$$

If i = 1, by (12.1), we see

$$0 \sim div(\chi^{e_1^+}) = D_{\rho_1^+} - D_{\rho_1^-}.$$

Then

$$D_{\rho_1^-} \sim D_{\rho_1^+}.$$
 (12.2)

If i = 2, by (12.1) and (2.2), we see

$$0 \sim div(\chi^{e_2^+}) = D_{\rho_2^+} - D_{\rho_2^-} - \beta_{21}D_{\rho_1^-}.$$

By (12.2), we get

$$D_{\rho_2^-} \sim D_{\rho_2^+} - \beta_{21} D_{\rho_1^+} = h_2^2 D_{\rho_2^+} + h_2^1 D_{\rho_1^+}.$$

By induction assume that

$$D_{\rho_k^-} \sim \sum_{j=1}^r h_k^j D_{\rho_j^+}$$
 for all $k < i$.

Again by (12.1) and (2.2), we see

$$0 \sim div(\chi^{e_i^+}) = D_{\rho_i^+} - D_{\rho_i^-} - \sum_{k < i} \beta_{ik} D_{\rho_k^-}.$$

Then

$$D_{\rho_i^-} \sim D_{\rho_i^+} - \sum_{k < i} \beta_{ik} D_{\rho_k^-}.$$

Hence

$$D_{\rho_i^-} \sim D_{\rho_i^+} - \sum_{k < i} \beta_{ik} (\sum_{j=1}^r h_k^j D_{\rho_j^+}).$$

Since $h_k^j = 0$ for k < j, we get

$$D_{\rho_i^-} \sim D_{\rho_i^+} - \sum_{k < i} \beta_{ik} (\sum_{j=1}^{i-1} h_k^j D_{\rho_j^+}).$$

Then

$$D_{\rho_i^-} \sim D_{\rho_i^+} + \sum_{j=1}^{i-1} (-\sum_{k=j}^{i-1} \beta_{ik} h_k^j) D_{\rho_j^+}.$$

Therefore, we conclude that $D_{\rho_i^-} \sim D_{\rho_i^+} + \sum_{j=1}^{i-1} h_i^j D_{\rho_j^+}$. This completes the proof of the lemma.

Let $\epsilon \in \{+, -\}$. Define

$$\Sigma(1)^{\epsilon} := \{ \rho_i^{\epsilon} : 1 \le i \le r \}.$$

Then

$$D = \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho} = \sum_{\rho \in \Sigma(1)^+} a_{\rho} D_{\rho} + \sum_{\rho \in \Sigma(1)^-} a_{\rho} D_{\rho}.$$

For $1 \leq i \leq r$, let

$$g_i := a_{\rho_i^+} + \sum_{j=i}^r a_{\rho_j^-} h_j^i.$$

Then we have

Corollary 12.2.

$$D = \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho} \sim \sum_{i=1}^{r} g_i D_{\rho_i^+}.$$

Proof. We have

$$D = \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho} = \sum_{i=1}^{r} a_{\rho_{i}^{+}} D_{\rho_{i}^{+}} + \sum_{i=1}^{r} a_{\rho_{i}^{-}} D_{\rho_{i}^{-}}.$$

By Lemma 12.1, we can see that

$$\sum_{i=1}^{r} a_{\rho_i^-} D_{\rho_i^-} \sim \sum_{i=1}^{r} a_{\rho_i^-} (\sum_{j=1}^{i} h_i^j D_{\rho_j^+}).$$

Then

$$\sum_{i=1}^r a_{\rho_i^-} D_{\rho_i^-} \sim \sum_{i=1}^r (\sum_{j=i}^r a_{\rho_j^-} h_j^i) D_{\rho_j^+}.$$

Hence we have

$$D \sim \sum_{i=1}^{r} (a_{\rho_i^+} + \sum_{j=i}^{r} a_{\rho_j^-} h_j^i) D_{\rho_i^+}.$$

Thus, $D \sim \sum_{i=1}^{r} g_i D_{\rho_i^+}$ and this completes the proof.

In [Pas10]), B. Pasquier obtained vanishing theorems for the cohomology of certain line bundles on BSDH varieties, by using cohomology of line bundles on the toric limit and by semi-continuity theorem (see [Pas10, Theorem 0.1]). By Corollary 12.2, we can also see some vanishing results for the cohomology of certain line bundles on BSDH varieties. For example the following result:

Let $D = \sum_{i=1}^{r} g_i Z_i$ be a divisor in BSDH variety $Z(\tilde{w})$, where g_i is as above for $1 \le i \le r$. We use the notation as in Section 6.

Corollary 12.3. If $d_i \ge 0$ for all $1 \le i \le r$, then $H^j(Z(\tilde{w}), D) = 0$ for all j > 0.

Proof. Since $d_i \ge 0$ for all $1 \le i \le r$, by Lemma 6.1, $\sum_{\rho \in \Sigma(1)} a_\rho D_\rho$ is a *nef* divisor in $X_{\tilde{w}}$. Then we have

$$H^{j}(X_{\tilde{w}}, \sum_{\rho \in \Sigma(1)} a_{\rho} D_{\rho}) = 0 \text{ for all } j > 0$$

(see [CLS11, Theorem 9.2.3, page 410] or [Oda88, Theorem 2.7, page 77]). Recall that by Theorem 3.2, we have

$$\mathcal{Z}_i^x = Z_i \text{ for } 0 \neq x \in k \text{ and } \mathcal{Z}_i^0 = D_{\rho_i^+}.$$

Hence by Theorem 3.2, Corollary 12.2 and by semi-continuity theorem (see [Har77, Theorem 12.8]), we get

$$H^{j}(Z(\tilde{w}), D) = 0$$
 for all $j > 0$.
