### ON THE NORMALITY OF THE NULL-FIBER OF THE MOMENT MAP FOR  $θ$ - AND TORI REPRESENTATIONS

ABSTRACT. Let  $(G, V)$  be a representation with either G a torus or  $(G, V)$  a locally free stable  $\theta$ -representation. We study the fiber at 0 of the associated moment map, which is a commuting variety in the latter case. We characterize the cases where this fiber is normal. The quotient  $(i.e.$  the symplectic reduction) turns out to be a specific orbifold when the representation is polar. In the torus case, this confirms a conjecture stated by C. Lehn, M. Lehn, R. Terpereau and the author in a former article. In the  $\theta$ -case, the conjecture was already known but this approach yield another proof.

#### <span id="page-1-0"></span>**INTRODUCTION**

Let k be an algebraically closed field of characteristic zero. Let  $(G, V)$  be a representation of a connected reductive algebraic group G on a finite dimensional k-vector space V. Let  $\frak g$  be the Lie algebra of G. We define the moment map

$$
\mu: \left\{ \begin{array}{ccc} V \oplus V^* & \to & \mathfrak{g}^* \\ (x, \varphi) & \mapsto & (g \mapsto \varphi(g \cdot x)) \end{array} \right.
$$

Among the fibers of the moment map, the most special one is  $\mu^{-1}(0)$ . When the representation  $(G, V)$  is the adjoint action of G on  $\mathfrak{g}, \mu^{-1}(0)$  can be identified wih the commuting scheme of g. According to a long-standing conjecture, this scheme should be normal. One of the aim of this work is to study the normality of the scheme  $\mu^{-1}(0)$  in some nice cases. For instance, if  $(G, V)$  is visible and locally free, we already know that  $\mu^{-1}(0)$  is a complete intersection and the normality question reduces to singular locus questions thanks to Serre's criterion (see *e.g.* Corollary [1.7](#page-5-0) and Remark [1.8\)](#page-6-1). Using this, Panyushev [\[Pan\]](#page-21-0) has shown that  $\mu^{-1}(0)$  is reduced

and normal in the case of the representation associated to a symmetric Lie algebra of maximal rank.

There are some natural generalizations of adjoint representations and symmetric Lie algebras: the so-called  $\theta$ -representations ( or  $\theta$ -groups) of Vinberg [\[Vin\]](#page-21-1) and, more generally, the polar representations of Dadok and Kac [\[DK\]](#page-21-2). Recall that a θ-representation is a representation  $(G, V)$  isomorphic to some  $(H_0, \mathfrak{h}_1)$  where H is a connected reductive group acting on its Lie algebra h, with h equipped with a  $\mathbb{Z}_m$ -grading  $\bigoplus_{i\in\mathbb{Z}_m}$   $\mathfrak{h}_i$  and where  $H_0$  is the connected subgroup of H whose Lie algebra is  $\mathfrak{h}_0$ . It turns out that the geometry of  $\mu^{-1}(0)$  can be a bit more involved in this setting of  $\theta$ -representations than for the classical adjoint representation. For instance, it is possible to find examples of such representations where  $\mu^{-1}(0)$ is non-irreducible [\[Pan,](#page-21-0) [Bu11\]](#page-21-3), non-reduced or irreducible non-normal [\[BLLT\]](#page-21-4). In this paper, we classify the locally free stable  $\theta$ -representations for which  $\mu^{-1}(0)$  is normal. It turns out (Theorem [4.6\)](#page-15-0) that this normality property holds in all the classical cases and we find only 5 non-normal examples of exceptional cases, each of rank 1. We take the opportunity to generalize some properties of decompositions classes to the  $\theta$ -cases in Section [4.](#page-13-0) The  $\theta$ -case is partly based on the study of some specific tori representations. This is one motivation for studying  $\mu^{-1}(0)$  for a general representation of a torus in Section [2.](#page-6-0) The fiber turns out to be normal as soon as it is irreducible and we give a combinatorial criterion for this in terms of the weights of the representation (Theorem [2.2\)](#page-7-0).

The variety  $\mu^{-1}(0)$  is also involved in the symplectic reduction  $(V \oplus V^*)/\!\!/ G :=$  $\mu^{-1}(0)/\!\!/ G$  where  $X/\!\!/ G$  denotes the categorical quotient of an affine G-variety X. If  $\mu^{-1}(0)$  is normal, then the symplectic reduction is also normal. Following a theorem of Joseph [\[Jos\]](#page-21-5) in the Lie algebra case, and a conjecture stated in [\[BLLT\]](#page-21-4) in the complex case (see conjecture [1.3](#page-3-1) here), the variety  $(V \oplus V^*)/\!\!/ \!\!/ G$  should be isomorphic to a specific orbifold whenever  $(G, V)$  is visible and polar. The results of the present paper yield a proof of this conjecture when  $G$  is a torus (Corollary [3.10\)](#page-12-0), and allows to recover it when  $(G, V)$  is a stable locally free  $\theta$ -representation (Remark [4.13\)](#page-20-1). In the torus case, we also get that that the visibility assumption is necessary (Proposition [3.9\)](#page-11-0) but that the scheme  $(V \oplus V^*)/\!\!/ \!\!/ G$  is nevertheless reduced (Theorem [2.2\)](#page-7-0) and normal (Proposition [3.4\)](#page-9-0) in general.

One should note that, as the torus case suggests, we put light on representations which are far from being irreducible. Part of the results concerning tori (*e.g.*, the normality of the symplectic reduction) were written independantly in the recent preprint [\[HSS\]](#page-21-6). The general philosophy of [\[HSS\]](#page-21-6) is to focus on "large" representations (ex: 2-large) whereas the polar representations are "small".

#### 1. Generalities

In this section, we introduce some classical material to study null fibers of moment maps. Even if some results are stated in a greater generalities, most of this section is heavily inspired by [\[Pan\]](#page-21-0). Popov's article [\[Po\]](#page-21-7) is also a source of inspiration.

We work over an algebraically closed field  $\&$  of characteristic zero. We use the language of scheme even if these schemes will always be separated of finite type over k and will often be reduced, i.e. varieties. We do not require that the varieties are irreducible. When speaking about the *irreducible components* of a scheme, we always mean the irreducible components of the corresponding reduced variety and we do not consider embedded components.

If A is a subset of a vector space,  $\langle A \rangle$  stands for the subspace generated by A.

**Definition 1.1.** An element  $x \in V$  is said to be

- semisimple if  $G.x$  is closed,
- nilpotent if  $0 \in \overline{G.x}$ .

Equivalently, x is nilpotent if and only if  $\pi(x) = \pi(0)$  where  $\pi: V \to V/\hspace{-3pt}/ G$  is the categorical quotient map.

**Definition 1.2.** The representation  $(G, V)$ , is said to be

- *locally free*, if dim  $G.x = \dim G$  for some  $x \in V$ .
- *visible*, if there are finitely many nilpotent G-orbits.
- $stable$ , if there is an open subset of  $V$ , consisting of semisimple elements
- *polar*, if there exists  $v \in V$  such that  $\dim \mathfrak{c}_v = \dim V//G$  where  $\mathfrak{c}_v :=$  ${x \in V \mid \mathfrak{g} \cdot x \subset \mathfrak{g} \cdot v}.$  We then say that  $\mathfrak{c}_v$  is a *Cartan subspace* of V.

Examples of visible and stable representations are given by the adjoint action of G on  $\mathfrak g$ , or a  $\theta$ -representation arising from a  $\mathbb Z_2$ -grading (so-called *symmetric Lie algebras*). In general, θ-representations are always visible but not necessarily stable [\[Vin\]](#page-21-1). Polar representations, as introduced in [\[DK\]](#page-21-2), can be neither stable nor visible. Examples of locally free representations are given by symmetric Lie algebras *of maximal rank*. It is worth noting that no adjoint representation  $(G, \mathfrak{g})$ is locally free.

When  $k = \mathbb{C}$  and  $(G, V)$  is polar, we write c and c<sup> $\vee$ </sup> for dual Cartan subspaces of V and  $V^*$ , following  $[BLLT, (3.4), (3.6)]$ , together with dual decompositions  $V = \mathfrak{c} \oplus (\mathfrak{g} \cdot \mathfrak{c}) \oplus U$  and  $V^* = \mathfrak{c}^\vee \oplus (\mathfrak{g} \cdot \mathfrak{c}^\vee) \oplus U^\vee$ . Write W for the Weyl group  $N_G(\mathfrak{c})/C_G(\mathfrak{c})$ . The following was Conjecture A in [\[BLLT\]](#page-21-4).

<span id="page-3-1"></span>**Conjecture 1.3.** Assume that  $(G, V)$  is visible and polar, then we have an iso*morphism of Poisson varieties*  $(V \oplus V^*)/\!\!/ \!\!/ G \cong (\mathfrak{c} \oplus \mathfrak{c}^{\vee})/W$ .

<span id="page-3-2"></span>*Remark* 1.4. Assume  $\Bbbk = \mathbb{C}$ . From [\[BLLT,](#page-21-4) Proposition 3.3&3.5], we have a injective natural morphism  $\mathfrak{c} \times \mathfrak{c}^{\vee}/W \to \mu^{-1}(0)/\!\!/ G$  of Poisson varieties. Since  $\mathfrak{c} \oplus \mathfrak{c}^{\vee}/W$  is normal, Conjecture [1.3](#page-3-1) is equivalent to:

- (1) The morphism  $\mathfrak{c} \times \mathfrak{c}^{\vee}/W \to \mu^{-1}(0)/\!\!/ G$  is dominant (i.e. it is bijective.)
- (2)  $\mu^{-1}(0)/\!\!/ G$  is normal

When studying the null fiber of the moment map, it is enlightening to study the modality of  $(G, V)$ . The modality of a G-subvariety  $X \subseteq V$  is defined as

$$
\operatorname{mod}(G, X) := \max_{Y \subseteq X} \left( \min_{x \in Y} (\operatorname{codim}_Y G.x) \right)
$$

where the maximum is taken over all irreducible subvarieties  $Y \subseteq X$ .

In the remaining of the section we will consider a finite cover of  $V, V = \bigcup_i J_i$ such that

- Each  $J_i$  is G-stable, irreducible and locally closed in V of constant orbit dimension (that is  $\exists m_i \in \mathbb{N}, \forall x \in J_i, \dim G \cdot x = m_i$ ), •  $\overline{J_i} = \overline{J_i} \Rightarrow i = j$ .
- 

Exemples of such cover includes sheets of  $(G, V)$  or decomposition classes in the case of the adjoint action. Note that if the cover is disjoint  $V = \bigsqcup_i J_i$ , then the second condition follows from the first one. Since the  $J_i$  are of constant orbit dimension, we have  $mod(G, J_i) = dim J_i - m_i$ . Moreover, from finiteness and locally closeness, each irreducible subvariety  $Y \subset V$  intersects at least one  $J_i$  as a dense open subset of Y and we have  $\min_{x \in Y} \operatorname{codim}_Y G.x = \operatorname{mod}(G, J_i)$ . Hence

$$
\operatorname{mod}(G, V) = \max_{i} \operatorname{mod}(G, J_i).
$$

Given a subvariety  $X \subseteq V$ , we write

$$
(2) \qquad (\mu^{-1}(0))_X := \{(x,\varphi) \in \mu^{-1}(0) | x \in X\} = \{(x,\varphi) \in X \times V^* | \varphi \in (\mathfrak{g}.x)^{\perp}\}\
$$

seen as a subvariety of  $\mu^{-1}(0)$ . This allows for instance to decompose  $\mu^{-1}(0)$ , as a finite union:

$$
\mu^{-1}(0) = \bigcup_i (\mu^{-1}(0))_{J_i}.
$$

**Lemma 1.5.** *(i)* Each  $(\mu^{-1}(0))_{J_i}$  is an irreducible and locally closed subvari*ety of*  $\mu^{-1}(0)$  *of dimension* dim  $V + \text{mod}(G, J_i)$ *.* 

- *(ii)* Each irreducible component of  $\mu^{-1}(0)$  is of the form  $(\mu^{-1}(0))_{J_i}$  for some i.
- (*iii*) There is a bijection between the set of irreducible components of  $\mu^{-1}(0)$ *of maximal dimension* dim  $V + \text{mod}(G, V)$  *and the set of*  $J_i$  *with maximal*  $modality \mod(G, J_i) = mod(G, V).$

*Proof.* (i) From [\(2\)](#page-4-0),  $(\mu^{-1}(0))_{J_i}$  is a subbundle in  $J_i \times V^*$  of codimension  $m_i$ . In particular, it is an irreducible subvariety of  $\mu^{-1}(0)$  of dimension

(4) 
$$
\dim V + \dim J_i - m_i = \dim V + \text{mod}(G, J_i).
$$

(ii) is clear from (i) and  $(3)$ .

(iii) By considering projection on the first variable,  $(\mu^{-1}(0))_{J_i} = (\mu^{-1}(0))_{J_j}$  can happen only if  $\overline{J_i} = \overline{J_j}$ , that is only if  $i = j$ . The bijection is then clear from (i) and (ii).  $\Box$ 

Another classical result is the following characterization of the smooth locus of  $\mu^{-1}(0)$ . If y belongs to a G-module Y (e.g.  $Y = V$  or  $Y = V \oplus V^*$ ), we let  $\mathfrak{g}^y := \{ g \in \mathfrak{g} | g \cdot y = 0 \}$  be the centralizer of y in g.

<span id="page-5-1"></span>**Proposition 1.6.** *The following assertions are equivalent for an element*  $(x, \varphi) \in$  $\mu^{-1}(0) \subset V \oplus V^*$ 

- (*i*)  $(x, \varphi)$  *is a smooth point of the scheme*  $\mu^{-1}(0)$
- *(ii)*  $(x, \varphi)$  *belongs to a unique irreducible component*  $(\mu^{-1}(0))_{J_i}$  *for some*  $J_i$ *, and* dim  $\mathfrak{g}^{x,\varphi} = \text{mod}(G, J_i) + \dim \mathfrak{g} - \dim V$

*Proof.* The tangent space of  $\mu^{-1}(0)$  at  $z = (x, \varphi)$  is Ker  $d_z \mu$ . The dual map of  $d_z \mu$ has the following expression

$$
(d_z \mu)^* : \begin{cases} \mathfrak{g} & \to \mathfrak{g} \quad (V \oplus V^*)^* \\ g & \mapsto \quad [(y, \psi) \mapsto \psi(g.x) + \varphi(g.y)] \end{cases}
$$

In particular,  $\text{Ker}(d_z(\mu))^* = \{g \in \mathfrak{g} | g \cdot x = 0 = g \cdot \varphi\} = \mathfrak{g}^{x,\varphi}.$  Hence dim  $\text{Ker}(d_z(\mu))^* = \{g \in \mathfrak{g} | g \cdot x = 0 = g \cdot \varphi\} = \mathfrak{g}^{x,\varphi}.$  $2 \dim V - \dim \mathfrak{g} + \dim \mathfrak{g}^{x,\varphi}.$ 

Recall that smooth points on a scheme belong to a unique irreducible component. Let  $(x, \varphi)$  belong to a unique irreducible component  $(\mu^{-1}(0))_{J_i}$  for some  $J_i$ . Since  $\dim(\mu^{-1}(0))_{J_i} = \dim V + \text{mod}(G, J_i)$  (Lemma 1.5), we get that  $(x, \varphi)$  is a smooth point of  $\mu^{-1}(0)$  if and only if dim  $V - \dim \mathfrak{g} + \dim \mathfrak{g}^{x,\varphi} = \text{mod}(G, J_i)$ , hence the equivalence.

<span id="page-5-0"></span>**Corollary 1.7.** *Assume that*  $mod(G, V) = dim V - dim G$ *. Then* 

- $(i)$   $(G, V)$  *is locally free.*
- (*ii*)  $\mu^{-1}(0)$  *is a complete intersection of dimension*  $2 \dim V \dim G$ .
- (*iii*) The smooth points of the scheme  $\mu^{-1}(0)$  are the points  $(x, \varphi)$  satisfying  $\mathfrak{g}^{x,\varphi} = \{0\}.$
- (*iv*)  $\mu^{-1}(0)$  *is irreducible if and only if*  $mod(G, J_i) < mod(G, V)$ *, for any i such that*  $\overline{J_i} \neq V$ *. If it is the case, the scheme*  $\mu^{-1}(0)$  *is also reduced*
- (v)  $\mu^{-1}(0)$  *is reduced and normal if and only if it is irreducible and the following holds*

$$
\forall i, \, [\text{mod}(G, J_i) = \text{mod}(G, V) - 1 \Rightarrow (\exists (x, \varphi) \in (\mu^{-1}(0))_{J_i} \text{ s.t. } \mathfrak{g}^{x, \varphi} = \{0\})]
$$

*Proof.* (i) Let  $i_0$  be the index such that  $J_{i_0} = V$ . Then  $m_{i_0}$  is the maximum orbit dimension in V and we get  $mod(G, V) \geqslant mod(G, J_{i_0}) = \dim V - m_{i_0} \geqslant \dim V - \dim G$ . From the hypothesis, we have equalities so  $m_{i_0} = \dim G$ .

(ii) The irreducible components of maximal dimension of  $\mu^{-1}(0)$  have codimension  $2 \dim V - (\dim V + \text{mod}(G, V)) = \dim G$  in  $V \oplus V^*$ . Since  $\mu^{-1}(0)$  is defined in  $V \oplus V^*$  by dim  $\mathfrak g$  equation, (ii) follows.

(iii) From (ii),  $\mu^{-1}(0)$  is equidimensional and its irreducible components have dimension  $2 \dim V - \dim G$ . From proof of Proposition [1.6,](#page-5-1) we see that the tangent space of  $\mu^{-1}(0)$  at  $(x,\varphi)$  has dimension  $2\dim V - \dim \mathfrak{g} + \dim \mathfrak{g}^{x,\varphi}$ . The result follows.

(iv) We have already seen in (i) that  $mod(G, J_{i_0}) = mod(G, V)$  for  $i_0$  such that  $\overline{J_{i_0}} = V$ . The characterization of the irreducibility of  $\mu^{-1}(0)$  then follows from

equidimensionality and Lemma 1.5 (iii). For  $x \in J_{i_0}$ , we have  $\mathfrak{g}^x = \{0\}$ . So  $(\mu^{-1}(0))_{J_{i_0}}$  is in the smooth locus of  $\mu^{-1}(0)$  by (iii). Hence  $\mu^{-1}(0)$  is reduced as soon as it is irreducible.

(v) Recall now that a variety is normal if and only if it satisfies Serre's condition  $(S<sub>2</sub>)$  and its singular locus has codimension at least 2. The former is provided by (ii). Under the irreducibility assumption, the latter is equivalent to [\(5\)](#page-5-2). Indeed, the singular locus of  $\mu^{-1}(0)$  is a closed subset of  $\bigcup_{i\neq i_0} (\mu^{-1}(0))_{J_i}$ . But, it follows from Lemma 1.5(i) that an irreducible component of a closed subset of  $\bigcup_{i\neq i_0} (\mu^{-1}(0))_{J_i}$  of codimension 1 in  $\mu^{-1}(0)$  contains at least one  $(\mu^{-1}(0))_{J_i}$  with  $mod(G, J_i) = mod(G, V) - 1.$ 

<span id="page-6-1"></span>*Remark* 1.8*.* In the notation of the proof of (i), we have, for a general representation  $(G, V)$ : mod $(G, V) \geq \dim V - m_{i_0}$ . The limit case mod $(G, V) = \dim V - m_{i_0}$ corresponds to condition  $(\mathcal{F}_0)$  of  $\text{u}$ , see (2.2) and Corollary 2.5 in *loc. cit.* Then Proposition 3.1 in *loc. cit.* asserts that this condition hold when  $(G, V)$  is visible. In particular, hypothesis of the above corollary are satisfied when  $(G, V)$  is locally free and visible.

Similarily, condition  $(\mathcal{F}_1)$  in *loc. cit.* is equivalent to the condition appearing in Corollary [1.7](#page-5-0) (iv). Related statements to corollary [1.7](#page-5-0) can be found in Theorems 2.4, 3.1 and 3.2 in *loc. cit.*

#### 2. Null-fiber of the moment map - torus case

<span id="page-6-0"></span>In this section  $V$  is an *n*-dimensional representation of an *r*-dimensional torus  $G = T \cong (\mathbb{k}^{\times})^r$ . The weight space  $X^*(T)$  is isomorphic to  $\mathbb{Z}^r$ . We let  $W_{\mathbb{Q}} :=$  $X^*(T) \otimes_{\mathbb{Z}} \mathbb{Q}$ . It is a  $\mathbb{Q}$ -vector space of dimension r. Recall that the irreducible representations of T are one-dimensional. So we can decompose  $V = \bigoplus_{i=1}^{n} V_i$ , with T acting on  $V_i \cong \mathbb{k}$  with weight  $s_i = \begin{pmatrix} s_i^j \end{pmatrix}$  $j \in [1,r] \in X^*(T)$ . That is, the action of an element  $t = (t_j)_{j \in [\![1,r]\!]} \in T$  on an element  $v = (v_i)_{i \in [\![1,n]\!]} \in V$  is given by

$$
t \cdot v = \left( \left( \prod_{j=1}^r t_j^{(s_i^j)} \right) v_i \right)_i.
$$

We introduce the  $n \times r$  matrix  $S := (s_i^j)_{i,j}$ . Given  $I \subset [1,n]$  or  $i \in [1,n]$ , we also define the  $\#I \times r$ -matrix  $S_I := (s_i^j)_{(i,j)\in I\times[\![1,r]\!]}$  and the  $(n-1) \times r$ -matrix  $S_{\hat{i}} := S_{\llbracket 1,n \rrbracket \setminus \{i\}}.$ 

In the sequel we need a partition of  $V$  by suitable strata. These are indexed by subsets  $I \subset [1, n]$  and are given by

$$
J_I := \{(v_i)_i \in V | v_i \neq 0 \Leftrightarrow i \in I\}.
$$

*Remark* 2.1. Each  $J_I$  is a locally closed irreducible T-stable subvariety whose closure is  $V_I := \{(v_i)_i \in V | \forall i \notin I, v_i = 0\}.$ 

Moreover, there is a T-equivariant action of  $(\mathbb{C}^{\times})^n$  on V given by  $(\lambda_i)_i \cdot (v_i)_i =$  $(\lambda_i v_i)_i$ . The orbits of this action are precisely the strata  $J_I$ . Hence many geometric properties of the action of T on a point  $v \in V$  (dimension of orbit, nilpotency, semisimplicity, ...) are preserved along the stratum  $J_I$  containing v. It will then

be convenient to make the computations only at  $v_I := (\delta_{i \in I})_i$  where  $\delta$  is the Kronecker symbol.

It is now clear that  $V = \bigsqcup_I J_I$  is a cover satisfying the assumptions of Section [1.](#page-3-0)

For 
$$
v \in V
$$
, writing  $X_v := \begin{pmatrix} v_1 \\ \vdots \\ v_n \end{pmatrix}$ , we have

$$
\mathfrak{t} \cdot v = \langle (s_i^j v_i)_{i \in [\![1,n]\!]} | j \in [\![1,r]\!] \rangle = \text{Im}(X_v S) = X_v \text{Im}(S).
$$

where  $\text{Im}(S)$  (resp.  $\text{Im}(X_v S)$ ) denote the image space of the linear maps  $\mathbb{k}^r \to \mathbb{k}^n$ associated to S (resp.  $X_vS$ ) in the canonical basis. It follows from [\(6\)](#page-7-1) that, for  $v \in J_I$ , we have

<span id="page-7-5"></span>(7) dim T.v = rk S<sup>I</sup> .

In particular, the modality of  $J_I$  is given by

<span id="page-7-3"></span>(8) 
$$
\text{mod}(T, J_I) = \#I - \text{rk}\,S_I = \dim \text{Ker}(^tS_I).
$$

where  $\text{Ker}(tS_I)$  is the kernel of the linear map  $\mathbb{k}^{\#I} \to \mathbb{k}^r$  associated to  ${}^tS_I$ . Via the natural identifications  $\Bbbk^{\#I} \cong V_I \subset V \cong \Bbbk^n$ ,  $\text{Ker}({}^tS_I)$  is identified with  $\text{Ker}({}^tS) \cap V_I$ . Assume that  $I_1 \subset I_2$  are two subsets of  $[\![1,n]\!]$ , then  $\text{Ker}({}^tS) \cap V_{I_1} \subset \text{Ker}({}^tS) \cap V_{I_2}$ . So

<span id="page-7-4"></span>(9) 
$$
I_1 \subset I_2 \Rightarrow \mod(T, J_{I_1}) \leqslant \mod(T, J_{I_2}),
$$

From  $(1)$ , we get

(10) 
$$
\operatorname{mod}(T, V) = \operatorname{mod}(T, J_{\llbracket 1, n \rrbracket}) = \dim V - \operatorname{rk} S.
$$

We can apply [\(2\)](#page-4-0) to  $X = J_I$  to define  $(\mu^{-1}(0))_{J_I}$ . This yields a partition of  $\mu^{-1}(0)$  into a disjoint union of irreducible locally closed (Lemma 1.5) subsets

<span id="page-7-2"></span>
$$
\mu^{-1}(0) = \bigsqcup_{I} (\mu^{-1}(0))_{J_I}
$$

<span id="page-7-0"></span>**Theorem 2.2.** Assume that  $(T, V)$  is a reprentation with  $T$  a torus. *Then, under above notation:*

- (*i*)  $\mu^{-1}(0)$  *is a reduced complete intersection of dimension*  $2 \dim V \text{rk } S$ .
- *(ii)* The irreducible components of  $\mu^{-1}(0)$  are the subsets of the form  $\overline{(\mu^{-1}(0))_{J}}$ *with*  $\text{rk } S - \text{rk } S_I = n - \#I$ .
- (*iii*)  $\mu^{-1}(0)$  *is irreducible if and only if, for any*  $i \in [1, n]$ *, we have*  $\text{rk}(S_i) = \text{rk } S$ *.*
- (*iv*)  $\mu^{-1}(0)$  *is normal if and only if it is irreducible.*

*Proof.* By Lemma 1.5, the irreducible components of  $\mu^{-1}(0)$  of maximal dimension  $\dim V + \text{mod}(T, V) = 2 \dim V - \text{rk } S$  [\(10\)](#page-7-2) are the  $\overline{(\mu^{-1}(0))_{J_I}}$  with  $\# I - \text{rk } S_I =$  $n - \text{rk } S$  [\(8\)](#page-7-3). This last condition is the one expressed in (ii).

Then, from  $(9)$ ,  $\mu^{-1}(0)$  has a single irreducible component of maximal dimension if and only if  $mod(T, J_I) < mod(T, J_{[1,n]})$  for any I of the form  $[1, n] \setminus \{i\}$ . If  $I = [1, n] \setminus \{i\}$ , it follows from [\(8\)](#page-7-3), that

$$
\text{mod}(T, J_I) = \begin{cases} \text{mod}(T, J_{\llbracket 1, n \rrbracket}) - 1 & \text{if } \text{rk } S_i = \text{rk } S \\ \text{mod}(T, J_{\llbracket 1, n \rrbracket}) & \text{if } \text{rk } S_i = \text{rk } S - 1 \end{cases}
$$

.

In the next paragraph, we show that  $\mu^{-1}(0)$  is a complete intersection, hence equidimensional. Together with the above arguments, this implies that (ii) and (iii) holds.

Consider the kernel of the representation  $(T, V)$ ,  $K := \{t \in T | \forall i, s_i(t) = 1\}.$ Its Lie algebra is  $\mathfrak{k} := \{ t \in \mathfrak{k} \subseteq \mathbb{k}^r | St = 0 \} = \text{Ker}(S)$ . Applying [\(7\)](#page-7-5) to a general element  $v \in V$ , we get  $\dim(T/K) \cdot v = \dim T \cdot v = \text{rk } S = \dim \mathfrak{t} - \dim \mathfrak{k}$ . So the representation  $(T/K, V)$  is not only faithul but locally free. Note that  $T/K$  is also a torus and that  $\mu^{-1}(0)$  is the same for  $(T, V)$  and  $(T/K, V)$ . Therefore, there is no loss of generality in assuming that  $(T, V)$  is locally free in order to prove (i) and (iv). Under this assumption, important features are  $rk S = \dim T$  [\(7\)](#page-7-5) and  $mod(T, V) = dim V - dim T$  [\(10\)](#page-7-2). In particular, we can apply Corollary [1.7](#page-5-0) and get that  $\mu^{-1}(0)$  is a complete intersection.

<span id="page-8-1"></span>Assuming that  $(T, V)$  is locally free, we claim that

(11) 
$$
\forall I \subset [1, n], \ \exists (x, \varphi) \in (\mu^{-1}(0))_{J_I}, \ \mathfrak{t}^{(x, \varphi)} = \{0\}.
$$

Under this claim, (ii) and Corollary [1.7](#page-5-0) (iii) imply that each irreducible component of  $\mu^{-1}(0)$  has smooth points. Hence  $\mu^{-1}(0)$  is reduced and this ends the proof of (i). The claim also implies that condition  $(5)$  is automatically satisfied so (iv) follows from Corollary [1.7](#page-5-0) (v).

*Proof of claim* [\(11\)](#page-8-1) Let  $I \subset [1, n]$ . The decomposition  $V = \bigoplus_i V_i$  induces to a decomposition  $V^* = \bigoplus V_i^* \cong \mathbb{k}^n$ . We set  $x = v_I = (\delta_{i \in I})_i \in J_i \subset V$  and  $\varphi := (\delta_{i \notin I})_i \in V^*$  with respect to these decompositions. Since  $\mathfrak{t} \cdot x \subset V_I$ , we have  $\varphi \in (\mathfrak{t} \cdot x)^{\perp}$  so  $(x, \varphi) \in (\mu^{-1}(0))_{J_I}$ . Also, let  $t \in T$  stabilizing  $(x, \varphi)$ . Then  $s_i(t) = 1$ for any  $i \in I$  and  $1/(s_i(t)) = 1$  for any  $i \notin I$ . Hence t is in the kernel of the representation. By local freeness, we get  $\mathfrak{t}^{x,\varphi} = \{0\}.$ 

#### 3. Symplectic reduction for tori representations

<span id="page-8-0"></span>We keep the notation and setting of the previous section. The aim of this section is to study the symplectic reduction  $(V \oplus V^*)/\!\!/ T := \mu^{-1}(0)/\!\!/ T$ . We prove Conjecture [1.3](#page-3-1) in the context of representations of tori (Corollary [3.10\)](#page-12-0). Moreover, we show that that the conjecture is essentially false for non-visible action (Proposition [3.9\)](#page-11-0), but that the symplectic reduction remains normal in this case (Proposition [3.4\)](#page-9-0).

In this section, many properties depend on considerations on the convex hull of some of the weights  $s_i \in X^*(T)$ . If  $\emptyset \neq A \subset X^*(T) \subset W_{\mathbb{Q}} = X^*(T) \otimes_{\mathbb{Z}} \mathbb{Q}$ , we denote by  $CH(A)$ , the convex hull of A in  $W_{\mathbb{Q}}$ . We also denote by  $CH(A)$  the interior (for the classical topology) of  $CH(A)$  in  $\langle A \rangle$ . Alternatively,  $\overset{\circ}{CH}(A)$  is the set of convex combination  $\sum_{a \in A} \alpha_a a$  with each  $\alpha_a$  positive. It is an elementary result on convex hull that  $0 \notin CH(A)$  (resp.  $0 \notin \overset{\circ}{CH}(A)$ ) if and only if  $\exists \phi \in W^*_{\mathbb{Q}}$ s. t.  $\forall a \in A, \phi(a) > 0$  (resp.  $\phi(a) \geq 0$  and  $\phi(A) \neq \{0\}$ ). Note that such  $\phi$  can be multiplied by a sufficiently large integer so that we can always assume  $\varphi \in X^*(T)$ . In our context of weights on a group, this translates as follows.

<span id="page-9-1"></span>**Lemma 3.1.** *Under above notation*,  $0 \notin CH(A)$  *(resp.*  $0 \notin \overset{\circ}{CH}(A)$ *) if and only if there exists a one-parameter subgroup*  $\mathbb{C}^{\times} \stackrel{\rho}{\hookrightarrow} T$  *such that*  $\forall a \in A$ *,*  $\exists b_a \in \mathbb{N}^*$  *(resp.*  $b_a \in \mathbb{N}$  *with at least one*  $a \in A$  *s.t.*  $b_a \neq 0$ ,  $\forall t \in \mathbb{C}^\times$ ,  $a(\rho(t)) = t^{b_a}$ .

<span id="page-9-2"></span>**Proposition 3.2.** *Let*  $\emptyset \neq I \subseteq [1, n]$  *and*  $v \in J_I$ *.* 

- *(1)*  $v \in V$  *is nilpotent if and only if*  $0 \notin CH(\lbrace s_i | i \in I \rbrace)$ *.*
- (2)  $v \in V$  *is semisimple if and only if*  $0 \in \widetilde{CH}(\lbrace s_i | i \in I \rbrace)$ *.*

*Proof.* First, recall that the elements of  $J_I$  all share the same orbit dimension. In particular, an element  $y \in \overline{T.v} \setminus T.v$  lies in  $J_{I'}$  for some  $I' \subsetneq I$ . Then, from Hilbert-Mumford criterion,  $v = (v_i)_i \in V \setminus \{0\}$  is nilpotent (resp. is not semi-simple) if and only if there exists a one-parameter subgroup  $\mathbb{C}^{\times} \stackrel{\rho}{\hookrightarrow} T$  such that  $\rho(t).v_i = t^{b_i}v_i$ with  $b_i$  positive for each  $i \in I$  (resp. non-negative for each  $i \in I$  and at least one  $b_i$ non-zero). Since  $t^{b_i} = s_i(\rho(t))$ , the result then follows from Lemma [3.1.](#page-9-1)

<span id="page-9-3"></span>Given  $(T, V)$  and associated weights  $(s_i)_{i \in \llbracket 1,n \rrbracket}$ , we split  $\llbracket 1,n \rrbracket$  into

(12)  $I_d := \{i \in [1, n] | \text{rk } S_i = \text{rk } S\}, \quad I_f := I \setminus I_d = \{i \in [1, n] | \text{rk } S_i = \text{rk } S - 1\}.$ 

<span id="page-9-4"></span>**Corollary 3.3.** The representation  $(T, V)$  is stable if and only if  $0 \in \widehat{CH}(\lbrace s_i | i \in$  $[1, n]\}.$ 

*In this case*  $I_f = \emptyset$  *and*  $\mu^{-1}(0)$  *is irreducible and normal* 

*Proof.* A generic element of V lies in  $J_{[1,n]}$  so the first assertion follows from Propo-sition [3.2.](#page-9-2) If we can write 0 as a convex combination of the  $(s_i)_{i\in[\![1,n]\!]}$  with non-zero coefficients,  $I_f$  is empty so the second statement follows from Theorem [2.2.](#page-7-0)  $\Box$ 

<span id="page-9-0"></span>**Proposition 3.4.** *There is an isomophism*  $(V \oplus V^*)/\mathbb{Z} \cong (V_{I_d} \oplus V_{I_d}^*)/\mathbb{Z}$ *. In particular,*  $(V \oplus V^*)/\!\!/ T$  *is normal.* 

*Proof.* We denote by  $\mu_{I_d}$  the moment map  $V_{I_d} \oplus V_{I_d}^* \to \mathfrak{t}^*$ . Recall that  $\mu^{-1}(0)$  and  $\mu_{I_d}^{-1}(0)$  are reduced by Theorem [2.2.](#page-7-0) Hence so are  $(V \oplus V^*)/\!\!/ T = \mu^{-1}(0)/\!\!/ T$  and  $(V_{I_d} \oplus V_{I_d}^*)/\!\!/ T = \mu_{I_d}^{-1}(0)/\!\!/ T$ . Note that  $V_{I_d}^*$  can be identified with the subrepresentation of  $V^*$  generated by the isotypical components associated to the weights  $\{-s_i | i \in I_d\}$ . This allows us to consider  $\mu_{I_d}^{-1}(0)$  as a T-stable closed subscheme of  $\mu^{-1}(0)$ . Therefore, we have a closed immersion  $\mu_{I_d}^{-1}(0)/T \to \mu^{-1}(0)/T$ . To show that this is an isomorphism, there remains to prove that this map is a surjective. For this, we are going to show that the only closed orbits in  $\mu^{-1}(0)$  lie in  $\mu_{I_d}^{-1}(0)$ .

Let  $(x, y) \in \mu^{-1}(0)$  and assume that  $x \notin V_{I_d}$ . From the assumption on x, we know that there exists i such that  $x_i \neq 0$  and  $\text{rk } S_i < \text{rk } S$ . Then there exists an element  $t \in \langle s_j | j \neq i \rangle^{\perp} \subset \mathfrak{t}$  such that  $s_i(t) = 1$ . So  $t \cdot x = x_i$  and  $V_{\{i\}} \subset \mathfrak{t} \cdot x$ . Since  $y \in (\mathfrak{t} \cdot x)^{\perp}$ , we get  $y_i = 0$ . Then a one-parameter subgroup  $\mathbb{C}^{\times} \stackrel{\rho}{\hookrightarrow} T$  given by  $s_j(\rho(t)) = t^{\delta_{i,j}}$  acts on  $(x, y)$  via  $t \cdot y = y$  and  $\lim_{t \to 0} t \cdot x = x'$  with  $x'_j = x_j$  if  $j \neq i$  and  $x'_i = 0$ . Hence  $(x', y) \in \overline{T.(x, y)} \setminus T.(x, y)$ . A similar argument shows that  $T.(x, y)$  is also non-closed as soon as  $y \notin V_{I_d}^*$ .

Let us now show that  $(V_{I_d} \oplus V_{I_d}^*)/\!\!/ \! / T$  is normal. For each  $i \in I_f$ ,  $s_i$  is not a linear combination of the other  $s_j$   $(j \neq i)$ . Hence  $\{s_i \mid i \in I_f\}$  induces a basis of  $\langle s_i \mid i \in I_f \rangle$ 

 $[1,n]\rangle/\langle s_i \, | \, i \in I_d \rangle$  and  $\text{rk } S_{I_d} = \text{rk } S - \#I_f$ . Assuming that  $\text{rk } S_{I_d \setminus \{i\}} = \text{rk } S_{I_d} - 1$ for some  $i \in I_d$ , we would then have rk  $S_i \leqslant \text{rk } S_{I_d} - 1 + \#(I_f) = \text{rk } S - 1$ , which contradicts the assumption  $i \in I_d$ . So  $\text{rk } S_{I_d \setminus \{i\}} = \text{rk } S_{I_d}$  for any  $i \in I_d$  and  $(T, V_{I_d})$ satisfies hypothesis of Theorem [2.2](#page-7-0) (iii-iv). Hence  $\mu_{I_d}^{-1}(0)$  is irreducible and normal, so the same holds for its quotient by  $T$ .

We have the following useful characterization of a visible action:

<span id="page-10-0"></span>**Proposition 3.5.** *The representation*  $(T, V)$  *with weight*  $(s_i)_{i \in \mathbb{I} \setminus [n]}$  *is visible if and only if there is a partition*  $[\![1,n]\!] = \bigsqcup_{j=0}^l I_j$  *satisfying* 

 $(i) \langle s_i | i \in [1, n] \rangle = \bigoplus_{j=0}^{l} \langle s_i | i \in I_j \rangle$  $(iii)$  dim $\langle s_i | i \in I_j \rangle =$  $\int \#I_j$  *if*  $j = 0$  $#I_j - 1$  *if*  $j ≥ 1$  $(iii) \ \forall j \geq 1, \ 0 \in \mathring{CH}({s_i | i \in I_j}).$ 

Note that the subset  $I_0$  in the proposition has to coincide with  $I_f$  defined in [\(12\)](#page-9-3) and that  $I_d = \bigsqcup_{j \geqslant 1} I_j$ .

*Proof.* "if" part: Assume that such a partition exists. Let  $x \in V$  be nilpotent and let  $\tilde{I}$  be such that  $x \in J_{\tilde{I}}$ . Define  $\tilde{I}_j := \tilde{I} \cap I_j$ . Assume that j is a positive index such that  $\tilde{I}_j \neq \emptyset$ . Since x is nilpotent and  $\tilde{I}_j \subset \tilde{I}$ , it follows from Proposition [3.2](#page-9-2) that  $0 \notin CH(\lbrace s_i | i \in \tilde{I}_j \rbrace)$ . By (iii),  $\tilde{I}_j$  is a proper subset of  $I_j$ .

On the other hand, (iii) also implies that there is a convex combination  $\sum_{i\in I_j} \alpha_i s_i =$ 0 with each  $\alpha_i > 0$ . By (ii), this combination is the unique linear relation (up to scalar multiplication) between the  $(s_i)_{i \in I_j}$ . In particular, the family  $(s_i)_{i \in \tilde{I}_j}$  is linearly independant. The same hold if  $j = 0$  by (ii). By (i), we get that  $(s_i)_{i \in \tilde{I}}$  is linearly independent.

Then, by [\(7\)](#page-7-5),  $\dim T.x = \text{rk } S_{\tilde{I}} = \# \tilde{I} = \dim J_{\tilde{I}}$ . Hence  $T.x$  is open in  $J_{\tilde{I}}$ . Since this holds for any  $x \in J_{\tilde{I}}$ , we get  $T.x = J_{\tilde{I}}$ . Since there are finitely many possible index set  $\tilde{I}$ , the representation  $(T, V)$  is visible.

"only if" part: We will argue by induction on dim V. Assume dim  $V = 1$ . If  $s_1 \neq 0$ , we set  $l = 0$  and  $I_0 := \{s_1\}$ . If  $s_1 = 0$ , we set  $l := 1$ ,  $I_0 := \emptyset$  and  $I_1 := \{s_1\}$ .

Assume now that the result holds true for any visible representation of T of dimension  $n-1$  and consider a visible representation  $(T, V)$  of dimension n. Since  $V' := V_{[1,n-1]}$  is a subrepresentation of V, it is also visible. By the inductive hypothesis, there exists a partition  $[[1, n-1]] = \bigsqcup_{j=0}^{l'} I'_j$  satisfying (i), (ii) and (iii). If  $s_n \notin \langle s_i | i \in [1, n-1] \rangle$ , we can set  $I_0 := I'_0 \cup \{n\}$  and  $I_j := I'_j$  for any  $j \geq 1$ .

From now on, we assume that  $s_n \in \langle s_i | i \in [1, n-1] \rangle$ . As a first step, we claim that there is a subset  $\tilde{I} \subset [1, n-1]$  and some non-zero rational coefficients  $(\beta_i)_{i \in \tilde{I}}$ such that

- $\bullet\ \ s_n := \sum_{i\in \tilde I} \beta_i s_i$
- $\tilde{I} \cap I'_j \neq I'_j$  for any  $j \geq 1$
- $\beta_i > 0$  for  $i \in \bigsqcup_{j \geqslant 1} I'_j \cap \tilde{I}$ .

Indeed, start with a combination with rational coefficients  $s_n := \sum_{i \in [1,n-1]} \beta'_i s_i$ . Fix  $j \geq 1$ . From (iii) and (ii), there is a combination with positive coefficients

 $0 = \sum_{i \in I'_j} \alpha_i s_i$ . Let  $\lambda_j := \max_{i \in I'_j} \{-\beta'_i/\alpha_i\}$ . Set  $\beta_i := \beta'_i + \lambda_j \alpha_i$  for  $i \in I'_j$ . So  $\beta_i \geqslant 0$  for any  $i \in I'_j$  and  $\beta_i = 0$  for at least one  $i \in I'_j$ . Then set  $\tilde{I} := \{i | \beta_i \neq 0\}$ and the claim is shown.

From the property  $\tilde{I} \cap I'_j \neq I'_j$  and (i), (ii), (iii), we get that  $(s_i)_{i \in \tilde{I}}$  is linearly independant as in the proof of the "if part". So, up to scalar multiplication, the only relation between  $\{s_i | i \in \tilde{I} \cup \{n\}\}\$ is given by the above coefficients  $\beta_i$   $(i \in \tilde{I})$ . Assuming that  $\beta_i > 0$  for some  $i \in \tilde{I}$  (*e.g.* if  $\tilde{I} \cap \bigsqcup_{j \geqslant 1} I'_j \neq \emptyset$ ), we get  $0 \notin CH(\{s_i | i \in I\})$  $\tilde{I} \cup \{n\}\}\)$  so orbits in  $J_{\tilde{I} \cup \{n\}}$  are nilpotent by Proposition [3.2.](#page-9-2) From [\(7\)](#page-7-5), these orbits are of dimension rk  $S_{\tilde{I}\cup\{n\}} = #I = \dim J_{\tilde{I}\cup\{n\}} - 1$ . This contradicts the visibility of  $(T, V)$ . As a result,  $\tilde{I} \subset I_0$  and  $\beta_i < 0$  for each  $i \in I_0$ . Setting  $l := l' + 1$ ,  $I_l := \tilde{I} \cup \{n\}, I_0 := I'_0 \setminus \tilde{I}$  and  $I_j := I'_j$  for  $j \in [1, l']$  then yield (i), (ii) and (iii) for the representation  $(T, V)$ .

*Remark* 3.6*.* We can re-interpret Proposition [3.5](#page-10-0) as follows. The visible tori actions are essentially made of two part: a part of rank 0 provided by  $I_0$  and several stable blocks of rank 1, each looking very much like [\[BLLT,](#page-21-4) Example 8.6]. There are other appearence of stable blocks of rank 1 in Lemma [4.9.](#page-17-0)

#### <span id="page-11-2"></span>Corollary 3.7. *Any visible representation of a torus is polar.*

*Proof.* Let  $(T, V)$  be a visible representation and adopt notation of Proposition [3.5.](#page-10-0) For  $\underline{w} := (w_1, \ldots, w_l) \in \mathbb{C}^l$ , we consider  $x(\underline{w})$  as the element  $(x_i)_{i \in [\![1,n]\!]}$  given by  $x_i := 0$  if  $i \in I_0$  and  $x_i := w_j$  if  $i \in I_j$   $(j \geq 1)$ . From [\(6\)](#page-7-1), we get  $\mathfrak{t} \cdot x(\underline{w}) =$  $X_{x(\underline{w})}Im(S)$ . From Proposition [3.5](#page-10-0) (i),  $Im(S) = \bigoplus_j Im(S_{I_j})$ . Since  $X_{x(\underline{w})}$  acts by  $w_j Id$  on  $Im(S_{I_j})$ , we get that  $\mathfrak{t} \cdot x(\underline{w})$  is included in  $\mathfrak{t} \cdot x(1,\ldots,1)$ . The subspace  $\mathfrak{c} := \{x(\underline{w}) | \underline{w} \in \mathbb{C}^l\}$  is our candidate for being a Cartan subspace of  $(T, V)$  and there remains to show that  $l = \dim V/T$ , [\[DK\]](#page-21-2).

Since  $(T, V)$  is visible, a general fiber of the quotient map  $V \to V/T$  is the closure of a general orbit in V. Hence, by [\(7\)](#page-7-5), dim  $V/T = \dim V - \text{rk } S$ . This is equal to l by Proposition [3.5.](#page-10-0)

Let us now take a closer look at  $(V \oplus V^*)/\!\!/ T$ , that is at closed orbits of  $\mu^{-1}(0)$ . A first observation is the following.

<span id="page-11-1"></span>**Lemma 3.8.** *If*  $(x, y) \in \mu^{-1}(0)$  *is such that*  $x \in V$  *and*  $y \in V^*$  *are semisimple, then*  $(x, y)$  *is semisimple in*  $V \oplus V^*$ *.* 

*Proof.* Consider the set of weigths for the action of T on  $V \oplus V^*$ . Denote by  $A_x$  (resp.  $A_y, A_{x,y}$  the set of weights corresponding to the support of x (resp. y,  $(x, y)$ ). By Proposition [3.2,](#page-9-2)  $0 \in \overset{\circ}{CH}(A_x)$  and  $0 \in \overset{\circ}{CH}(A_y)$ . So  $0 \in \overset{\circ}{CH}(A_x \cup A_y) = \overset{\circ}{CH}(A_{x,y})$ . The result follows.  $\hfill \square$ 

<span id="page-11-0"></span>**Proposition 3.9.** *The representation*  $(T, V)$  *is visible if and only if closed orbits of*  $\mu^{-1}(0)$  *are those of the form*  $T.(x, y)$  *with*  $T.x$  *and*  $T.y$  *closed.* 

*Proof.* • Assume that  $(T, V)$  is visible. With similar arguments to those of Propo-sition [3.4,](#page-9-0) we are going to show that, whenever  $x \in V$  is not semisimple,  $(x, y) \in$ 

 $\mu^{-1}(0)$  cannot be semisimple. A symmetric argument on  $y \in V^*$  and Lemma [3.8](#page-11-1) then allow to conclude for the "only if" part.

Let  $x \in J_{\tilde{I}}$  for some  $\tilde{I} \subset [1, n]$ . The representation  $(T, V_{\tilde{I}})$  is also visible, so we can apply Proposition [3.5](#page-10-0) (with  $\tilde{I}$  instead of  $[[1, n]]$ ) and get a partition  $\tilde{I} = \bigsqcup_{j=0}^{l} \tilde{I}_j$ . Apply also Proposition [3.5](#page-10-0) to V, so that we get a partition  $[\![1,n]\!] = \bigsqcup_j I_j$ .

Assuming that x is not semisimple amounts to assume that  $\tilde{I}_0 \neq \emptyset$  (Proposition [3.2\)](#page-9-2). If  $\tilde{I}_0 \cap I_0 \neq \emptyset$ , Proposition [3.4](#page-9-0) states that any element of  $\mu^{-1}(0)$  of the form  $(x, y)$  is not semisimple. From now on, we assume that there exists  $j \geq 1$  such that  $\tilde{I}_0 \cap I_j \neq \emptyset$ . From property (ii) of Proposition [3.5](#page-10-0) on  $\tilde{I}_0$  and  $I_j$ , we also know that  $I_j \setminus \tilde{I}_0 \neq \emptyset$ . Fix  $i_0 \in \tilde{I}_0 \cap I_j$  and  $i_1 \in I_j \setminus \tilde{I}_0$ . The relation between the  $(s_i)_{i \in I_j}$  can be written as  $\sum_{i \in I_j} \alpha_i s_i = 0$  with the  $\alpha_i$  positive integers. Then we can define a one parameter subgroup  $\rho: \mathbb{C}^{\times} \hookrightarrow T$ , via

$$
s_i(\rho(t)) = \begin{cases} t^{\alpha_{i_1}} & \text{if } i = i_0 \\ t^{-\alpha_{i_0}} & \text{if } i' = i_1 \\ 1 & \text{else} \end{cases}
$$

Then  $V_{\{i_0\}} = Lie(\rho(\mathbb{C}^{\times})) \cdot x \subset \mathfrak{t} \cdot x$  and, whenever  $(x, y) \in \mu^{-1}(0)$ , we have  $y_{i_0} = 0$ . Since  $\rho(t)$  acts on  $y_{i_1}$  by multiplication by  $t^{\alpha_{i_0}}$ , we get that  $\lim_{t\to 0}(\rho(t)\cdot(x,y))$ exists and that its first component lies in  $J_{\tilde{I}\setminus\{i_0\}}$ . In particular,  $T.(x, y)$  is not closed.

• Assume now that  $(T, V)$  is not visible. We want to find  $(x, y)$  semisimple such that x is not semisimple. Let  $I \subset [1, n]$  be such that  $J_I$  contains infinitely many nilpotent orbits. Then  $0 \notin CH(\lbrace s_i | i \rbrace I)$  (Proposition [3.2\)](#page-9-2) and rk  $S_I$  <  $\dim J_I = \#I$  [\(7\)](#page-7-5). Thus there exists non-trivial linear relations  $\sum_{i \in I} \alpha_i s_i = 0$  with integer coefficients and for any such relation the  $\alpha_i$  are not all of the same sign. We can therefore write a relation of the form  $\sum_{i\in I'} \beta_i s_i = \sum_{i\in I''} \beta_i s_i$  with each  $\beta_i$ positive,  $I', I'' \neq \emptyset$  and  $I' \sqcup I'' \subset I$ . Let  $x = (x_i)_i \in J_{I'}$  and, analogously in  $V^*$ , let  $y = (y_i)_i \in J_{I''} \subset V_{I''}^* \subset V^*$ . From this, we get that x is non-zero nilpotent, that  $y \in V_{I''}^* \subset (V_{I'})^{\perp} \subset (\mathfrak{t} \cdot x)^{\perp}$  and that

$$
T.(x,y) \subset \left\{ (x',y') \in V_{I'} \times V_{I''}^* \middle| \prod_{i \in I'} (x_i')^{\beta_i} \prod_{i \in I''} (y_i')^{\beta_i} = \prod_{i \in I'} (x_i)^{\beta_i} \prod_{i \in I''} (y_i)^{\beta_i} \right\}.
$$

This last subset is a T-invariant closed subset of V which does not intersect  $\{0\} \times V^*$ . Let  $(x', y')$  be in the closed orbit of  $\overline{T.(x, y)}$ . Since  $x' \subset J_{\tilde{I}}$  with  $\tilde{I} \subset I'$ ,  $x'$  is non-zero nilpotent hence not semisimple.

Proposition [3.9](#page-11-0) shows that the visibility assumption in Conjecture [1.3](#page-3-1) is necessary, since the statement fails set-theoretically in any non-visible case..

When  $k = \mathbb{C}$ , we can state the following:

#### <span id="page-12-0"></span>Corollary 3.10. *Conjecture [1.3](#page-3-1) holds true for representations of tori*

*Proof.* Note that the polar assumption is redundant by Corollary [3.7.](#page-11-2) According to Proposition [3.9,](#page-11-0) the generic elements of the irreducible (Proposition [3.4\)](#page-9-0) variety  $V \oplus V^*/\!\!/ T$  are closed orbits of the form  $T.(x, y)$  with x regular (i.e. with T.x closed of maximal dimension among closed orbits). We may assume that  $x \in \mathfrak{c}$ .

Then  $y \in (\mathfrak{t} \cdot x)^{\perp} = (\mathfrak{t} \cdot \mathfrak{c})^{\perp} = \mathfrak{c}^{\vee} \oplus U^{\vee}$  and, since  $T.y$  is closed, we get  $y \in \mathfrak{c}^{\vee}$ [\[DK,](#page-21-2) Corollary 2.5]. Hence (1) of Remark [1.4](#page-3-2) holds Statement (2) follows from Proposition [3.4.](#page-9-0)

#### 4. NULL-FIBER OF THE MOMENT MAP -  $\theta$  CASE

<span id="page-13-0"></span>A standard reference for the theory of  $\theta$ -representations is [\[Vin\]](#page-21-1). These representations are visible and polar but they are not always stable. A classification of the irreducible  $\theta$ -representations with their main features can be found in [\[Kac,](#page-21-8) §3].

Let us first introduce some notation. Let  $\mathfrak{h} = \bigoplus_{i \in \mathbb{Z}_m} \mathfrak{h}_i$  be a reductive Lie algebra equipped with a  $\mathbb{Z}_m$ -grading, that is  $[\mathfrak{h}_i, \mathfrak{h}_j] \subset \mathfrak{h}_{i+j}$ . Let H be any connected algebraic group having h as its Lie algebra. We consider the adjoint representation of  $G := H_0$  on  $V := \mathfrak{h}_1$  where  $H_0$  is the connected subgroup of H with Lie algebra h0. Fix ω an m-th root of 1. We denote by θ the automorphism of h given by  $\theta(x) = \omega^i x$  for  $x \in \mathfrak{h}_i$ . If  $\mathfrak a$  is a  $\theta$ -stable subspace of  $\mathfrak h$ , we can decompose  $\mathfrak a = \bigoplus \mathfrak a_i$ with  $\mathfrak{a}_i := \mathfrak{a} \cap \mathfrak{h}_i$ . We then denote the dual direct sum by  $\mathfrak{a}^* = \bigoplus \mathfrak{a}_i^{\vee}$ . We will identify  $\mathfrak{a}_i^{\vee}$  and  $(\mathfrak{a}_i)^*$ .

We need to understand  $\mu^{-1}(0)$ . From [\[Vin,](#page-21-1) §1.2 and §2.2], the  $\theta$ -representation  $(H_0, \mathfrak{h}_1)$  is isomorphic to  $(\prod_k (H^{(k)})_0, \prod_{k} (\mathfrak{h}^{(k)})_1)$  for some graded Lie algebras  $\mathfrak{h}^{(k)} =$  $\bigoplus (\mathfrak{h}^{(k)})_i$  which are either simple or abelian. The  $((H^{(k)})_0, (\mathfrak{h}^{(k)})_1)$  with  $\mathfrak{h}$  simple are called the *simple components* of  $(H_0, \mathfrak{h}_1)$ . Then  $\mu^{-1}(0)$  is the direct product of the  $\mu_k^{-1}(0)$  where  $\mu_k$  is the moment map associated to the representation  $((H^{(k)})_0, (\mathfrak{h}^{(k)})_1)$ . In the abelian case,  $\mu^{-1}(0) = \mathfrak{h}_1 \oplus \mathfrak{h}_1^*$ . From now on, we will assume that h is simple.

The Killing form  $L(\cdot, \cdot)$  is a non-degenerate symmetric bilinear form on  $\mathfrak{h} \times \mathfrak{h}$ which is invariant under H and  $\theta$ . Via  $L, V^* \cong \mathfrak{h}_1^{\vee}$  identifies to  $\mathfrak{h}_{-1}$ . If  $x \in \mathfrak{h}$  and  $\mathfrak{a} \subset \mathfrak{h}$ , we denote the centraliser of x in  $\mathfrak{a}$  by  $\mathfrak{a}^x = \{y \in \mathfrak{a} \mid [x, y] = 0\}$ . Assume that  $\varphi \in V^*$  corresponds to  $y \in \mathfrak{h}_{-1}$  via L. Then the condition  $\varphi \in (\mathfrak{g} \cdot x)^{\perp}$  is read  $0 = L([a, x], y) = L(\mathfrak{h}_0, [x, y])$ , that is  $[x, y] = 0$  since  $[x, y] \in \mathfrak{h}_0$  and L is non-degenerate on  $\mathfrak{h}_0 \oplus \mathfrak{h}_0$ . Thus  $\mu^{-1}(0)$  is isomorphic to the commuting scheme:

(13) 
$$
\mu^{-1}(0) \cong \{(x, y) \in \mathfrak{h}_1 \times \mathfrak{h}_{-1} | [x, y] = 0\}.
$$

We now want to define a suitable locally closed cover of  $\mathfrak{h}_1$  satisfying the conditions stated in Section [1](#page-3-0)

**Definition 4.1.** We say that a Levi subalgebra l of h *arises from*  $h_1$  if there exists a semisimple element  $s \in \mathfrak{h}_1$  such that  $\mathfrak{l} = \mathfrak{h}^s$ .

In other words,  $(j_l)_{reg} \cap j_l \neq \emptyset$  where  $j_l$  is the center of l and  $(j_l)_{reg}$  denotes the set of elements of  $\lambda_1$  whose H-orbit is of maximal dimension. Such a Levi l is clearly  $\theta$ -stable. Hence  $\mathfrak{l} = \bigoplus \mathfrak{l}_i$  gives rise to a  $\mathbb{Z}_m$ -graded reductive Lie algebra. We denote by  $L_0$  the connected subgroup of H with Lie algebra  $\mathfrak{l}_0$ .

Recall from [\[Vin\]](#page-21-1) that any  $x \in \mathfrak{h}_1$  has a Jordan decomposition  $x_s + x_n$  with  $x_s, x_n \in \mathfrak{h}_1$ , the semisimple and nilpotent part of x, respectively.

**Definition 4.2.** Given l a Levi subalgebra of  $\mathfrak{h}$  arising from  $\mathfrak{h}_1$ , and  $\mathcal{O}$  a nilpotent  $L_0$ -orbit in  $\mathfrak{l}_1$ , we define the *decomposition class* associated to  $(\mathfrak{l}, \mathcal{O})$  as

$$
J(\mathfrak{l},\mathcal{O}) := H_0 \cdot \{(\mathfrak{z}_\mathfrak{l})_{reg} \cap \mathfrak{h}_1 + \mathcal{O}\}
$$

Alternatively,  $x \in J(\mathfrak{l}, \mathcal{O})$  if and only if x is  $H_0$ -conjugate to an element  $x' \in \mathfrak{l}_1$ such that  $I = \mathfrak{h}^{x'_{s}}$  and  $\mathcal{O} = L_0 \cdot x'_n$ . Hence decomposition classes are equivalence classes, so they form a partition of  $\mathfrak{h}_1$ . Next, we adapt some results of  $|Br|$  (see also [\[TY,](#page-21-9) §39]).

<span id="page-14-0"></span>**Proposition 4.3.** Let  $J(I, \mathcal{O})$  be a decomposition class.

- (*i*) If  $x \in J(\mathfrak{l}, \mathcal{O})$ , then  $J(\mathfrak{l}, \mathcal{O}) = H_0 \cdot \{y \in \mathfrak{h}_1 | \mathfrak{h}^y = \mathfrak{h}^x\}$
- *(ii)*  $J(I, O)$  *is an irreducible locally closed subset of*  $\mathfrak{h}_1$ *.*
- *(iii) If*  $x \in J(\mathfrak{l}, \mathcal{O})$  *then* dim  $H_0 \cdot x = \dim \mathfrak{h}_1 \dim \mathfrak{l}_1 + \dim \mathcal{O}$ .
- $(iv) \mod (H_0, J(1, \mathcal{O})) = \dim(\mathfrak{z}_1)_1.$

*Proof.* There is no loss of generality in assuming that x satisfies  $\mathfrak{h}^{x_s} = \mathfrak{l}$  and  $\mathcal{O} =$  $L_0 \cdot x_n$ .

(i) From [\[TY,](#page-21-9) 35.3.3, 39.1.2, 39.1.1], we have  $\{y \in \mathfrak{h}_1 | \mathfrak{h}^y = \mathfrak{h}^x\} = \{y \in \mathfrak{l}_1 | \mathfrak{h}^{y_s} =$  $\mathfrak{l}, (\mathfrak{l}')^{y_n} = (\mathfrak{l}')^{x_n}$  where  $\mathfrak{l}' := [\mathfrak{l}, \mathfrak{l}]$ . Since  $L_0$  acts trivially on  $(\mathfrak{z}_\mathfrak{l})_{reg}$ , this yields  $J(\mathfrak{l},\mathcal{O})\subset H_0\cdot \{y\in \mathfrak{h}_1|\mathfrak{h}^y=\mathfrak{h}^x\}.$  Note that the condition  $\mathfrak{h}^{y_s}=\mathfrak{l}$  implies that  $y, y_s, y_n \in \mathfrak{l}_1$ . In order to prove the converse inclusion, it is therefore enough to show that  $\mathcal{U} := \{n \in \mathfrak{l}'_1 | (\mathfrak{l}')^n = (\mathfrak{l}')^{x_n}\} \subset \mathcal{O}$ . Let  $n \in \mathcal{U}$ . Then  $\mathfrak{l}_0^n = \mathfrak{l}_0^{x_n}$  so  $\dim L_0 \cdot n = \dim L_0 \cdot x_n = \dim \mathcal{O}$ . The subset U is a dense open subset of  $(\mathfrak{l}_1')^{x_n}$ by  $[TY, 35.3.3]$ , hence U is irreducible. From  $[TY, 35.3.4]$ , U is included in the nilpotent cone of  $\mathfrak{l}'_1$  which consists of fintely many  $L_0$ -orbits. Let  $\mathcal{O}'$  be the  $L_0$ nilpotent orbit whose intersection with  $\mathcal U$  is dense in  $\mathcal U$ . Then  $\mathcal U \subset \overline{\mathcal O'}$ . Since all the elements of U share the same L<sub>0</sub>-orbit dimension and  $x_n \in \mathcal{O} \cap \mathcal{U}$ , we can eventually conclude that  $\mathcal{O} = \mathcal{O}'$  and  $\mathcal{U} \subset \mathcal{O}$ .

(ii) It is clear from the definition that  $J(\mathfrak{l}, \mathcal{O})$  is irreducible. Set  $m = \dim \mathfrak{h}^x$  for some  $x \in J(\mathfrak{l}, \mathcal{O})$ . By (i), it does not depend on the choice of x. The map  $\varphi : y \mapsto \mathfrak{h}^y$ , from  $\{y \in \mathfrak{h} | \dim \mathfrak{h}^y = m\}$  to the Grassmannian of m-dimensional subspaces in  $\mathfrak{h}$ , is a morphism of varieties [\[TY,](#page-21-9) 19.7.6, 29.3.1]. By (i),  $J(\mathfrak{l}, \mathcal{O}) = \mathfrak{h}_1 \cap \varphi^{-1}(H_0 \cdot (\mathfrak{h}^x))$ with  $\mathfrak{h}^x$  seen as an element of the Grassmannian. As orbits are locally closed sets, so are their inverse images by morphisms of varieties. Hence  $J(\mathfrak{l}, \mathcal{O})$  is locally closed in  $\{y \in \mathfrak{h} | \dim \mathfrak{h}^y = m\}$  and the result follows.

(iii) Consider ad x as an endomorphism of  $\mathfrak h$ . Then l is its generalized eigenspace associated to 0. Let us denote by q the sum of the other generalized eigenspaces. We have  $\mathfrak{h} = \mathfrak{l} \oplus \mathfrak{q}$  and  $\mathfrak{h} \cdot x = [\mathfrak{l} \oplus \mathfrak{q}, x] = (\text{ad }x)(\mathfrak{l}) \oplus (\text{ad }x)(\mathfrak{q}) = (\text{ad }x_n)(\mathfrak{l}) \oplus \mathfrak{q}$ . Intersect with  $\mathfrak{h}_1$  yields  $\mathfrak{h}_0 \cdot x = \mathfrak{l}_0 \cdot x_n \oplus \mathfrak{q}_1$ . In particular,  $\text{codim}_{\mathfrak{h}_1} H_0 \cdot x = \text{codim}_{\mathfrak{l}_1} L_0 \cdot x_n$ .

(iv) From the computations in (iii), we also get that  $\mathfrak{h} \cdot x$  has trivial intersection with  $\mathfrak{z}_1$ . Since  $\mathfrak{h}_0 \cdot x + (\mathfrak{z}_1)_1$  is the tangeant space of  $J(\mathfrak{l}, \mathcal{O})$  at x, we get  $\dim J(\mathfrak{l}, \mathcal{O}) = \dim H_0 \cdot x + \dim(\mathfrak{z}_\mathfrak{l})_1$ . Since the elements of  $J(\mathfrak{l}, \mathcal{O})$  all share the same orbit dimension, we have  $mod(H_0, J(\mathfrak{l}, \mathcal{O})) = dim J(\mathfrak{l}, \mathcal{O}) - dim H_0 \cdot x$ . The result follows.  $\Box$ 

From Proposition [4.3,](#page-14-0) the decomposition classes satisfy the requirements of the covers used in Section [1.](#page-3-0) However, note that two different data  $(l_i, \mathcal{O}_i)$ ,  $i = 1, 2$  can give rise to the same decomposition class. In the sequel, we fix a Cartan subspace  $c \subset \mathfrak{h}_1$ , that is a maximal subspace of commuting semisimple elements. The number dim c is called the *rank* of  $(H_0, \mathfrak{h}_1)$ .

**Definition 4.4.** We say that a property  $P$  is *hereditary* if, whenever  $P$  holds on a θ-representation  $(H_0, \mathfrak{h}_1)$ , it holds on the restricted θ-representation  $((H_0^s)^\circ, \mathfrak{h}_1^t)$ for any semisimple element  $t \in \mathfrak{h}_1$ . Here,  $(H_0^s)^\circ$  is the connected subgroup of  $H_0$ whose Lie algebra is  $\mathfrak{g}_0^s$ .

Next, we recall a few classical facts.

<span id="page-15-1"></span>**Lemma 4.5.** *Let*  $(H_0, \mathfrak{h}_1)$  *be a*  $\theta$ *-representation with Cartan subspace*  $\mathfrak{c} \subset \mathfrak{h}_1$ *.* 

- *(i)* For an element in general position  $s \in \mathfrak{c}$ , we have  $\mathfrak{h}^s = \mathfrak{h}^{\mathfrak{c}}$  and  $(\mathfrak{z}(\mathfrak{h}^s))_1 = \mathfrak{c}$ .
- *(ii)*  $(H_0, \mathfrak{h}_1)$  *is locally free if and only if* dim  $\mathfrak{h}_1 = \dim \mathfrak{h}_0 + \dim \mathfrak{c}$ .
- (*iii*)  $(H_0, \mathfrak{h}_1)$  *is stable if and only if there exists*  $s \in \mathfrak{c}$  *such that*  $\mathfrak{h}_1^s = \mathfrak{z}(\mathfrak{h}^s)_1 = \mathfrak{c}$ .
- *(iv) Stability and local freeness are both hereditary properties.*

*Proof.* (i) follows from [\[Vin,](#page-21-1) §3.2].

Since  $\theta$ -representations are visible, it follows from Remark [1.8](#page-6-1) that  $mod(H_0, \mathfrak{h}_1)$  =  $\dim \mathfrak{h}_1 - m_0$  where  $m_0$  is the maximal orbit dimension in  $\mathfrak{h}_1$ . By (i), Proposition [4.3](#page-14-0) (iv) and [\(1\)](#page-4-2), the maximal modality of a decomposition class is  $mod(H_0, \mathfrak{h}_1) = dim \mathfrak{c}$ . Assertion (ii) follows.

From Proposition [4.3](#page-14-0) (iii), an element  $x = x_s + x_n$  can have maximal orbit dimension in  $\mathfrak{h}_1$  only if  $L_0 \cdot x_n$  is of maximal dimension in  $\mathfrak{l}_1$  with  $\mathfrak{l} = \mathfrak{h}^{x_s}$ . This is possible with  $x_n = 0$  only if  $l'_1 = \{0\}$  where  $l' = [l, l]$ . Since  $l_1$  contains a Cartan subspace, this implies that  $I_1$  is a Cartan subspace. On the other hand, assume that there exists  $s \in \mathfrak{c}$  such that  $\mathfrak{h}_1^s = \mathfrak{z}(\mathfrak{h}^s)_1 = \mathfrak{c}$ . Then  $J(\mathfrak{h}^s, \{0\})$  is a decomposition class of dimension  $\dim H_0 \cdot s + \text{mod}(H_0, J(\mathfrak{h}^s, \{0\})) = \dim \mathfrak{h}_1 - \dim \mathfrak{h}_1^s + 0 + \dim \mathfrak{z}(\mathfrak{h}^s)_1 =$ dim  $\mathfrak{h}_1$  by Proposition [4.3.](#page-14-0) Hence  $J(\mathfrak{h}^s, \{0\})$  is the open class in  $\mathfrak{h}_1$ . Since it is made of semisimple elements, the representation is stable.

(iv) follows from [\[BLLT,](#page-21-4) Lemma 6.3].  $\square$ 

Recall from [\[BLLT,](#page-21-4) Proposition 4.3] that  $\mu^{-1}(0)$  can be irreducible only if  $(H_0, \mathfrak{h}_1)$  is stable.

<span id="page-15-0"></span>Theorem 4.6. *Assume that* (H0, h1) *is a stable and locally free* θ*-representation with* h *simple, then*

- *i)*  $\mu^{-1}(0)$  *is an irreducible and reduced complete intersection*
- *ii*)  $\mu^{-1}(0)$  $\mu^{-1}(0)$  $\mu^{-1}(0)$  *is normal if and only if*  $(H_0, \mathfrak{h}_1)$  *does not belong to Table 1*

Corollary 4.7. *Under the hypothesis of the previous theorem and if* h *is of classical type, then*  $\mu^{-1}(0)$  *is normal* 

From [\[Pan,](#page-21-0) Theorem 3.2] (or, alternatively, Remark [1.8](#page-6-1) and Corollary [1.7\)](#page-5-0), (i) holds. The remaining of the section is devoted to the proof of Theorem [4.6](#page-15-0) (ii).

For this, we first rephrase condition [\(5\)](#page-5-2) in Lemma [4.8.](#page-16-1) Then we list all the  $\theta$ representations of rank one in Proposition [4.10.](#page-17-1) In Lemma [4.11,](#page-19-0) we check which of them satisfies condition  $(\mathcal{P})$  $(\mathcal{P})$  $(\mathcal{P})$ . Finally, we check that the non-normal cases of rank one do not yield any non-normal example of greater rank in Lemma [4.12.](#page-20-3)

Recall that all Cartan subspaces of  $\mathfrak{h}_1$  are conjugate. From Lemma [4.5](#page-15-1) (i) (iii) and Proposition [4.3](#page-14-0) (iv), the decomposition class  $J(\mathfrak{h}^{\mathfrak{c}},\{0\})$  is the only one with maximal modality  $mod(H_0, \mathfrak{h}_1) = dim \mathfrak{c}$ . Moreover, the decomposition classes with  $mod(H_0, J(\mathfrak{l}, \mathcal{O})) = \dim \mathfrak{c} - 1$  are the ones such that  $dim(\mathfrak{z}_\mathfrak{l})_1 = \dim \mathfrak{c} - 1$  and  $\mathcal O$ arbitrary. The condition on  $\mathfrak l$  means that  $(L_0, \mathfrak l_1')$  is a  $\theta$ -representation of rank one, where  $\mathfrak l'$  is the derived subalgebra of  $\mathfrak l$ .

Recall that, for  $x \in \mathfrak{h}_1$  with  $\mathfrak{l} = \mathfrak{h}^{x_s}$ , we have  $\mathfrak{h}_0^{x,y} \subset \mathfrak{h}^x \subset \mathfrak{l}$  and that  $\mathfrak{l}_0 = \mathfrak{l}'_0$  by Lemma  $4.5$  (iv). Hence, using Corollary  $1.7$  (v), we have:

 $for any Levi subalgebra  $\mathfrak{l} \subset \mathfrak{h}$  arising from  $\mathfrak{h}_1$  such that  $(L_0, \mathfrak{l}'_1)$  is of rank one:$ 

In other words,  $\mu^{-1}(0)$  is normal if and only if the same holds for the semisimple part of any Levi subalgebra arising from  $\mathfrak{h}_1$  whose associated  $\theta$ -representation is of rank one. The main difference with the symmetric Lie algebra case studied in [\[Pan\]](#page-21-0) is that we have many θ-representations of rank one. We now aim to classify them. For this, we recall a few features of the so-called *Kac diagrams*. The reader is referred to [\[Kac,](#page-21-8) §3] or [\[Vin,](#page-21-1) §8] for a detailed treatment.

- A Kac diagram is an affine (possibly twisted) Dynkin diagram  $X_n^{(\ell)}$  equipped with an integer label for each node. Up to isomorphisms of representations. it is enough to consider labels in  $\{0, 1, 2\}$ . If we focus on representations of positive rank, one can restricts to labels in  $\{0, 1\}.$
- If  $X_n(\ell)$  with a labelling  $(v_0, \ldots, v_n)$  form a Kac diagram, then it gives rise to a  $\mathbb{Z}_m$ -grading on a reductive Lie algebra h, where  $m = \ell \sum v_i$ .

• The Lie algebra  $\mathfrak{h}_0$  is a reductive algebra whose semisimple part is the Lie algebra corresponding to the subdiagram of 0-labelled nodes. The rank of  $\mathfrak{h}_0$  is that of the finite Dynkin diagram giving rise to  $X_n^{(\ell)}$ .

For instance, for each affine Dynkin diagram  $X_n^{(\ell)}$  appearing in the classification of Kac [\[Kac,](#page-21-8) §3, Table 1], we can label each node of  $X_n^{(\ell)}$  with 1. We denote such a Kac diagram by  $X_n^{(\ell)}(1)$ . They give rise to the only  $\theta$ -representations of positive rank  $(H_0, \mathfrak{h}_1)$  where  $H_0$  is a torus.

<span id="page-17-0"></span>**Lemma 4.9.** *Let*  $(H_0, \mathfrak{h}_1)$  *be a*  $\theta$ *-representation corresponding to a Kac diagram of the form*  $X_n^{(\ell)}(\mathbf{1})$ *. Then*  $(H_0, \mathfrak{h}_1)$  *is stable locally free of rank* 1*, and*  $\mu^{-1}(0)$  *is a normal variety.*

*Proof.* In this case,  $\mathfrak{h}_0$  is just the Cartan subalgebra of  $\mathfrak{h}$  (associated with the Dynkin diagram without the extended node  $\alpha_{n+1}$  and  $\mathfrak{h}_1$  is the sum of root spaces  $\mathfrak{h}_{\alpha_i}$ ,  $i \in [1, n+1]$ . Local freeness is clear since  $\alpha_1, \ldots, \alpha_n$  is a basis of  $\mathfrak{h}_0^*$ . By Lemma [4.5](#page-15-1) (ii), the rank of  $(H_0, \mathfrak{h}_1)$  is one. Since  $\alpha_{n+1}$  is the opposite of the highest root, there is a single relation linking the  $\alpha_i$ :  $\alpha_{n+1} = \sum_{i \in [1,n]} a_i \alpha_i$  with  $a_i < 0$ . By Corollary [3.3,](#page-9-4)  $(H_0, \mathfrak{h}_1)$  is stable and  $\mu^{-1}(0)$  is normal.

<span id="page-17-1"></span>**Proposition 4.10.** Let  $(H_0, \mathfrak{h}_1)$  be a stable and locally free  $\theta$ -representation of *rank* 1 *obtained from a simple Lie algebra*  $\mathfrak{h}$ *. Then*  $(H_0, \mathfrak{h}_1)$  *corresponds to a Kac*  $diagram of the form X_n^{(\ell)}(1)$  $diagram of the form X_n^{(\ell)}(1)$  $diagram of the form X_n^{(\ell)}(1)$  *or which appears in Table 1 or Table [2](#page-16-3)* 

*Proof.* When the Lie algebra  $\mathfrak h$  is exceptional we use the software  $\lbrack \text{GAP} \rbrack$  and its package  $[\text{SLA}]$ . We proceed as follows<sup>[1](#page-17-2)</sup>.

Given h of exceptional type (respectively of type  $D_4$ ), the first step consists in listing the Kac-diagrams relative to h (resp. with underlying Dynkin diagram  $D_4^{(3)}$ ) with labels in  $\{0,1\}$ . Then we select the corresponding gradings for which  $\dim \mathfrak{h}_1 = \dim \mathfrak{h}_0 + 1$ . There are few of them. For each selected grading, we choose a random element  $x \in \mathfrak{h}_1$  and compute its semisimple part s. Since the rank of  $(H_0, \mathfrak{h}_1)$  is at least 1, the element s should be non-zero (otherwise choose another x). Then,  $(H_0, \mathfrak{h}_1)$  is stable locally free of rank 1 if and only if dim  $\mathfrak{h}_1^s = 1$  (Lemma [4.5\)](#page-15-1). In addition to the  $X_n^{(\ell)}(1)$ , the only other Kac diagrams arising in this way are those of Tables [1](#page-16-0) and [2.](#page-16-3)

Assume now that  $\mathfrak{h} \subset \mathfrak{gl}(V)$  is classical. Our goal is to show that the only stable and locally free  $\theta$ -representatons of rank 1 are those arising from the  $X_n^{(\ell)}(1)$ . The strategy is similar to the exceptional case, except that we rather rely on the description of classical  $\theta$ -representations of Vinberg [\[Vin,](#page-21-1) §7]. We refer to this paper and we use the notation therein. In particular, there are four subcases to consider:

*First case*:  $\theta$  is an inner automorphism of  $\mathfrak{h} = \mathfrak{sl}(V)$  (type A);

*Second case*: h is of type B or D;

*Third case*: h is of type C;

*Fourth case*: θ outer and h of type A.

In the first three cases (respectively in the fourth case)  $\theta$  (respectively  $\theta^2$ ) is an automorphism of order  $m_0$  given by  $g \mapsto aga^{-1}$  for some  $a \in GL(V)$  satisfying  $a^{m_0} \in {\pm Id}$ . For  $\theta$  of order 1 or 2, the only locally free case of rank 1 is  $A_1^{(1)}(1)$  so we may assume that  $m_0 > 1$ . Then  $V = \bigoplus_{\lambda \in S} V(\lambda)$  where  $V(\lambda) = \{x \in V | a.x =$  $\lambda x$ } and  $S = {\lambda | \lambda^{m_0} = +1}$  or  $S = {\lambda | \lambda^{m_0} = -1}$ . That is  $S = {\lambda_0 \omega_0^j | j \in \mathbb{Z}_{m_0}}$ for  $\lambda_0 = 1$  or  $exp(\frac{2i\pi}{2m_0})$  and  $\omega_0 := exp(\frac{2i\pi}{m_0})$ . For  $j \in \mathbb{Z}_{m_0}$ , we set  $\lambda_j := \lambda_0 \omega_0^j$  and  $k_j := \dim V(\lambda_j)$ . The elements  $x \in \mathfrak{h}_k$  satisfy  $x \cdot V(\lambda_j) \subset V(\lambda_{j+k})$  for any  $j \in \mathbb{Z}_{m_0}$ .

We first look at the first case. From [\[Vin\]](#page-21-1), the rank of  $(H_0, \mathfrak{h}_1)$  is  $\min_{j \in \mathbb{Z}_{m_0}} k_j$ . Since  $\mathfrak{h}_0 \cong \mathfrak{sl}(V) \cap \prod_{j \in \mathbb{Z}_{m_0}} \mathfrak{gl}(V_j)$  and  $\mathfrak{h}_1 \cong \prod_{j \in \mathbb{Z}_{m_0}} Hom(V_j, V_{j+1}),$  we have

$$
\dim \mathfrak{h}_1 - \dim \mathfrak{h}_0 = \left(\sum_{j \in \mathbb{Z}_{m_0}} k_j k_{j+1}\right) - \left(\sum_{j \in \mathbb{Z}_{m_0}} k_j^2 - 1\right) = 1 - \frac{1}{2} \sum_{j \in \mathbb{Z}_{m_0}} (k_j - k_{j+1})^2.
$$

From Lemma [4.5](#page-15-1) (ii), we want that this number is 1. The only possibility is that  $k_j = k_{j'}$  for any  $j, j' \in \mathbb{Z}_{m_0}$  and the condition on the rank forces this common value to be 1. In this particular case,  $H_0$  is a torus so this must coincide with a grading given by a Kac diagram of the form  $A_n^{(1)}(\underline{1})$  (inner automorphism).

From now on we focus on the last three cases. In each of these cases, a nondegenerate bilinear form comes into play. This form induces a duality between  $V(\lambda)$  and  $V(\overline{\lambda})$  and we have  $k_j = k_{\overline{j}}$  where  $\overline{j}$  denotes the element of  $\mathbb{Z}_{m_0}$  satisfying  $\lambda_{\bar{i}} = \overline{\lambda_i}$ . Depending on whether each elements 1 and -1 belong to S or not, the corresponding  $\theta$ -representations may have different behavior. For  $\nu \in {\pm 1}$ , we set  $\eta_{\nu} := \begin{cases} 1 & \text{if } \nu \in S \\ 1 & \text{if } \nu \neq \emptyset \end{cases}$ 1 if  $\nu \in S$ <br>
−1 if  $\nu \notin S$ . Set also  $\epsilon_1 := \begin{cases} 1 & \text{in the 2nd and 4th case} \\ -1 & \text{in the 3rd case} \end{cases}$ −1 in the 3rd case and  $\epsilon_{-1} := \begin{cases} 1 & \text{in the 2nd case} \\ 1 & \text{in the 2nd case} \end{cases}$ −1 in the 3rd and 4th case . We then have a uniform formula

$$
\dim \mathfrak{h}_1 - \dim \mathfrak{h}_0 = \frac{1}{2} \left[ \sum_j k_j k_{j+1} - \sum_j k_j^2 + (\epsilon_1 \eta_1 k_0 + \epsilon_{-1} \eta_{-1} k_{m'}) \right]
$$

$$
= \frac{1}{4} \left[ -\sum_j (k_j - k_{j+1})^2 + 2\epsilon_1 \eta_1 k_0 + 2\epsilon_{-1} \eta_{-1} k_{m'} \right]
$$

In a nutshell,  $\mathfrak{h}_0$  is a product of the  $\mathfrak{gl}(V_j) \cong \mathfrak{gl}(V_j)$  for  $\lambda_j \notin {\pm 1}$  and possible copies of  $\mathfrak{so}(V_i)$  or  $\mathfrak{sp}(V_i)$  for  $\lambda_i \in \{\pm 1\}$ . A similar combinatoric holds for  $\mathfrak{h}_1$ . In the fourth case, the assumption  $m_0 > 1$  ensures that  $kId_V$  lies in a k-th part of the grading in  $\mathfrak{gl}(V)$  satisfying  $k \notin \{0, 1\}.$ 

We choose  $m' \in \mathbb{Z}_{m_0}$  such that  $Re(\lambda_{m'})$  is minimal. By convention, the argument of a complex number is taken in [0,  $2\pi$ [. Choosing  $j_{min} \in \mathbb{Z}_{m_0}$  such that  $k_j$  is minimal and  $Im(\lambda_i) \geq 0$ , we define

$$
I = \left\{ j \left| arg(\lambda_j) < arg(\lambda_{j_{min}}) \text{ or } arg(\lambda_{m'}) \leq arg(\lambda_j) < arg(\lambda_{\overline{j_{min}}}) \right\} \right\},
$$
\n
$$
I = \left\{ j \left| arg(\lambda_{j_{min}}) \leq arg(\lambda_j) < arg(\lambda_{m'}) \text{ or } arg(\lambda_{\overline{j_{min}}}) \leq arg(\lambda_j) \right\} \right\}.
$$

Using the equality  $n^2 = n(n-1) + n$ , we can write

$$
\dim \mathfrak{h}_1 - \dim \mathfrak{h}_0 = \frac{1}{4} \left[ -\sum_{j \in I} (k_j - k_{j+1})(k_j - k_{j+1} - 1) - \sum_{j \in J} (k_{j+1} - k_j)(k_{j+1} - k_j - 1) \right. \\ \left. + \sum_{j \in I} (k_{j+1} - k_j) + \sum_{j \in J} (k_j - k_{j+1}) + 2\epsilon_1 \eta_1 k_0 + 2\epsilon_{-1} \eta_{-1} k_{m'} \right]
$$

The first two terms are non-positive and the rest of the expression is equal to  $(k_{j_{min}} - k_0) + (k_{\overline{j_{min}}} - k_{m'}) + (k_{j_{min}} - k_{m'}) + (k_{\overline{j_{min}}} - k_0) + 2 \epsilon_1 \eta_1 k_0 + 2 \epsilon_{-1} \eta_{-1} k_{m'} =$  $2[(\epsilon_1\eta_1-1)k_0+k_{j_{min}}]+2[(\epsilon_{-1}\eta_{-1}-1)k_{m'}+k_{j_{min}}].$  Each of the terms in brackets is either equal to  $k_{j_{min}}$  if  $\epsilon_{\nu} \eta_{\nu} = 1$ , or is not greater than  $-k_{j_{min}}$  if  $\epsilon_{\nu} \eta_{\nu} = -1$ . In particular, dim  $\mathfrak{h}_1$  – dim  $\mathfrak{h}_0$  can be positive only if  $\epsilon_{\nu} \eta_{\nu} = 1$  for  $\nu \in {\pm 1}$ . Hence, it is of type I in the terminology of [\[Vin,](#page-21-1) §7.2], and its rank is  $k_{j_{min}}$ . Then, it follows from our formulas and Lemma [4.5](#page-15-1) that the only locally free cases of rank 1 are the following ones

$$
\begin{pmatrix}\nk_{j_{min}} = 1, \\
\forall j \in I, k_j - k_{j+1} \in \{0, 1\}, \\
\forall j \in J, k_{j+1} - k_j \in \{0, 1\}\n\end{pmatrix}
$$
 and 
$$
\begin{cases}\n\pm 1 \in S & \text{in the 2nd case} \\
\pm 1 \notin S & \text{in the 3rd case} \\
1 \in S, -1 \notin S & \text{in the 4th case}\n\end{cases}
$$

In the last three cases, the action is not stable in general. Given subspaces  $U(\lambda) \subset V(\lambda)$  of dimension 1, we can construct a non-zero semisimple element  $C \in \mathfrak{h}_1$  such that  $C(U(\lambda)) = U(\omega_0\lambda)$ . Then  $V' := Ker(C)$  decomposes as  $V' := \bigoplus_{\lambda} V'(\lambda)$ ; the decomposition in two summands  $V = (\bigoplus_{\lambda} U(\lambda)) \oplus V'$  is orthogonal and the derived subalgebra of  $\mathfrak{gl}(V)^C$  can be identified with  $\mathfrak{sl}(V')$ . If there exists  $j \in \mathbb{Z}_{m_0}$  such that  $k_j, k_{j+1} \geq 2$ , then we can construct in each case a non-zero element N in  $\mathfrak{h}_1^C \cap \mathfrak{sl}(V')$  with  $N(V'(\lambda_j)) \subset V'(\lambda_{j+1}), N(V'(\lambda_{\overline{j+1}})) \subset V'(\lambda_{\overline{j}})$  and  $N(U(\lambda)) = 0 = N(V'(\lambda_k))$  for any  $\lambda \in S$  and any  $k \notin \{j, j+1\}$ . This contradicts the stability hypothesis since  $N \in \mathfrak{h}^C \setminus \mathbb{k}C$ , see Lemma [4.5](#page-15-1) (iii). Thus, the only stable gradings to consider are those with  $\begin{cases} k_j = 1 \ 0 \end{cases}$  for j such that  $\lambda_j \notin {\pm 1}$  $k_j \in \{1, 2\}$  for j such that  $\lambda_j \in \{\pm 1\}$ . The different possibilities are listed in Table [3](#page-20-4) (up to multiplication of  $a$  by  $-1$  in type  $B$ , which gives rise to the same grading). Once again,  $H_0$  is a torus in each case so the corresponding grading must be obtained from a Kac diagram of the form  $X_n^{(\ell)}(1)$ . These Kac diagrams are identified in the last column of Table [3.](#page-20-4)  $\Box$ 

<span id="page-19-0"></span>**Lemma 4.11.** *If*  $(H_0, \mathfrak{h}_1)$  *is a*  $\theta$ *-representation associated to a Kac diagram of Table [1](#page-16-0) (resp. Table [2\)](#page-16-3) then it does not satisfy (resp. it satisfies) condition* ([P](#page-16-2)) *of Lemma [4.8.](#page-16-1)*

The proof of this lemma relies on computer-based computations. First, we list representatives of the nilpotent  $H_0$ -orbits on  $\mathfrak{h}_1$ . For any such representative  $n_i$ , we choose a random element  $n'_i \in \mathfrak{h}_{-1}^n$ . Then we compute  $\mathfrak{h}_0^{(n_i, n'_i)}$  $\int_0^{(n_i,n_i)}$ . It turns out to be  $\{0\}$  for each i in cases of Table [2](#page-16-3) so  $(\mathcal{P})$  $(\mathcal{P})$  $(\mathcal{P})$  holds. In cases of Table [1,](#page-16-0) we compute  $\mathfrak{w}_i := \{y \in \mathfrak{h}_0^{n_i} \, | \, [y, \mathfrak{h}_{-1}^{n_i}] = \{0\}\} = \bigcap_{z \in \mathfrak{h}_{-1}^{n_i}} \mathfrak{h}_0^{(n_i, z)}$ . In each case, it turns out that there exists i such that  $\mathfrak{w}_i \neq \{0\}$ . Hence  $(\mathcal{P})$  $(\mathcal{P})$  $(\mathcal{P})$  must fail in these cases. An example

of such  $n_i$ ,  $\mathfrak{w}_i$  is given in the table, using the numbering of the roots as in [\[Bo\]](#page-20-5) and where  $x_{\alpha}$  denotes a root vector for the root  $\alpha$ .

<span id="page-20-3"></span>Lemma 4.12. *Let*  $(H_0, \mathfrak{h}_1)$  *be a locally free stable*  $\theta$ *-representation with*  $\mathfrak{h}$  *simple. Then there is no proper Levi*  $\mathfrak l$  *arising from*  $\mathfrak h_1$  *such that*  $(L_0, \mathfrak l'_1)$  *corresponds to a Kac diagram of Table [1.](#page-16-0)*

*Proof.* Assume that such a proper Levi exists. Then  $\mathfrak h$  is of type  $E_7$  or  $E_8$  and the Cartan subspace of  $\mathfrak{h}_1$  is of dimension 2 or 3. Moreover the order of the automorphism  $\theta$  giving rise to the graduation is a multiple of 9 or 14. We can now consider all the possible Kac diagrams of type  $E_7$  or  $E_8$  such that dim  $\mathfrak{g}_1 - \dim \mathfrak{g}_0 \geq 2$ . After computation, it turns out that the resulting  $\mathbb{Z}_m$ -gradings have order which are not multiple of 9 or 14, which is a contradiction.  $\Box$ 

<span id="page-20-1"></span>*Remark* 4.13*.* Conjecture [1.3](#page-3-1) in the case of a locally free stable θ-representation follows from [\[BLLT,](#page-21-4) Theorem 1.2]. We briefly explain here how to recover it using the results of this paper. First, note that the 5 exceptional cases of Table [1](#page-16-0) are of rank one. Then it follows from  $BLLT$ , Proposition 3.4  $\&$  5.1 that the natural map  $\mathfrak{c} \oplus \mathfrak{c}^{\vee}/W \to V \oplus V^*/\!\!/ G$  is a dominant closed immersion, hence an isomorphism. In the other cases, Theorem [4.6](#page-15-0) ensures that  $\mu^{-1}(0)$  is normal. So the same holds for the symplectic reduction and the result follows from [\[BLLT,](#page-21-4) Proposition 5.1] and Remark [1.4.](#page-3-2)

Note that the ground results on polar representations of  $[DK]$  are known for  $\theta$ representations over any algebraically closed field of characteristic zero. Thus, we don't need the assumption  $\mathbb{k} = \mathbb{C}$  used in [\[BLLT\]](#page-21-4).
