# SENSITIVITY ANALYSIS FOR MIRROR-STRATIFIABLE CONVEX FUNCTIONS

#### Abstract

This paper provides a set of sensitivity analysis and activity identification results for a class of convex functions with a strong geometric structure, that we coined "mirror-stratifiable". These functions are such that there is a bijection between a primal and a dual stratification of the space into partitioning sets, called strata. This pairing is crucial to track the strata that are identifiable by solutions of parametrized optimization problems or by iterates of optimization algorithms. This class of functions encompasses all regularizers routinely used in signal and image processing, machine learning, and statistics. We show that this "mirror-stratifiable" structure enjoys a nice sensitivity theory, allowing us to study stability of solutions of optimization problems to small perturbations, as well as activity identification of first-order proximal splitting-type algorithms. Existing results in the literature typically assume that, under a non-degeneracy condition, the active set associated to a minimizer is stable to small perturbations and is identified in finite time by optimization schemes. In contrast, our results do not require any non-degeneracy assumption: in consequence, the optimal active set is not necessarily stable anymore, but we are able to track precisely the set of identifiable strata. We show that these results have crucial implications when solving challenging ill-posed inverse problems via regularization, a typical scenario where the non-degeneracy condition is not fulfilled. Our theoretical results, illustrated by numerical simulations, allow to characterize the instability behaviour of the regularized solutions, by locating the set of all low-dimensional strata that can be potentially identified by these solutions.

1. Introduction. Variational methods and non-smooth optimization algorithms are ubiquitous to solve large-scale inverse problems in various fields of science and engineering, and in particular in data science. The non-smooth structure of the optimization problems promotes solutions conforming to some notion of simplicity or low-complexity (e.g. sparsity, low-rank, etc.). The low-complexity structure is often manifested in the form of a low-dimensional "active set". It is thus of prominent interest to be able to quantitatively characterize the stability of these active sets to perturbations of the objective function. Of crucial importance is also the identification in finite time of these active sets by iterates of optimization algorithms that numerically minimize the objective function. This type of problems and results is referred to as "activity identification"; a review of the relevant literature will be provided in the sequel (at the beginning of each section). In a nutshell, the existing identification results guarantee a perfect stability of active sets to perturbations, or a finite identification of these sets via algorithmic schemes, under some non-degeneracy conditions (see in particular [37, 24, 55]). The crucial non-degeneracy assumption, that takes generally the form (3.1), can be viewed as a geometric generalization of strict complementary in non-linear programming. However, as we will illustrate shortly through some preliminary numerics, such a condition is too stringent and is often barely verified. The goal of this paper is to investigate the situation where this non-degeneracy assumption is violated.

[^0]1.1. Motivating Example. In order to better grasp the relevance of our analysis, let us first start with the setting of inverse problems that pervades various fields including signal processing and machine learning. We will com back to this setting in Section 4 with further discussions and references.

Regularized Inverse Problems. Assume one observes

$$
\begin{equation*}
y=y_{0}+w \in \mathbb{R}^{P} \quad \text { where } \quad y_{0} \stackrel{\text { def. }}{=} \Phi x_{0} \tag{1.1}
\end{equation*}
$$

where $w$ is some perturbation (called noise) and $\Phi \in \mathbb{R}^{P \times N}$ (called forward operator, or design matrix in statistics). Solving an inverse problem amounts to recovering $x_{0}$, to a good approximation, knowing $y$ and $\Phi$ according to (1.1). Unfortunately, in general, $P$ can be much smaller than the ambient dimension $N$, and when $P=N$, the mapping $\Phi$ is in general ill-conditioned or even singular.

A classical approach is then to assume that $x_{0}$ has some "low-complexity", and to use a prior regularization $R$ promoting solutions with such low-complexity. This leads to the following optimization problem

$$
\min _{x \in \mathbb{R}^{N}} E(x,(\lambda, y)) \stackrel{\text { def. }}{=} R(x)+\frac{1}{2 \lambda}\|y-\Phi x\|^{2}, \quad(\mathcal{P}(\lambda, y))
$$

Let's discuss two popular examples of regularizing functions promoting a low-complexity structure. These two functions will be used in our numerical experiments.

Example 1 ( $\ell_{1}$ norm). For $x \in \mathbb{R}^{N}$, its $\ell_{1}$ norm reads

$$
\begin{equation*}
R(x)=\|x\|_{1} \stackrel{\text { def. }}{=} \sum_{i=1}^{N}\left|x_{i}\right| . \tag{1.2}
\end{equation*}
$$

As advocated for instance by [15, 52], the $\ell_{1}$ enforces the solutions of $(\mathcal{P}(\lambda, y))$ to be sparse, i.e. to have a small number of non-zero components. Indeed, the $\ell_{1}$ norm can be shown to be the tightest convex relaxation (in the sense of bi-conjugation) of the $\ell_{0}$ pseudo-norm restricted to the unit Euclidian ball. Recall that $\ell_{0}$ pseudo-norm of $x \in \mathbb{R}^{N}$ measures its sparsity

$$
\|x\|_{0} \stackrel{\text { def. }}{=} \sharp\left\{i \in\{1, \ldots, N\}: x_{i} \neq 0\right\}
$$

Sparsity has witnessed a huge surge of interest in the last decades. For instance, in signal and imaging sciences, one can approximate most natural signals and images using sparse expansions in an appropriate dictionary (see e.g. [43]). In statistics, sparsity is a key toward model selection and interpretability [9].

EXAMPLE 2 (Nuclear norm). For a matrix $x \in \mathbb{R}^{n_{1} \times n_{2}} \sim \mathbb{R}^{N}$, where $N=n_{1} n_{2}$, the nuclear norm is defined as

$$
\|x\|_{*} \stackrel{\text { def. }}{=}\|\sigma(x)\|_{1}=\sum_{i=1}^{n} \sigma_{i}(x)
$$

where $n \stackrel{\text { def. }}{=} \min \left(n_{1}, n_{2}\right)$ and $\sigma(x)=\left(\sigma_{1}(x), \ldots, \sigma_{n}(x)\right) \in \mathbb{R}_{+}^{n}$ is the vector of singular values of $x$. The nuclear norm is the tightest convex relaxation of the rank (in the sense of bi-conjugation) restricted to the unit Frobenius ball [35]. This underlies its wide use to promote solutions of $(\mathcal{P}(\lambda, y))$ with low rank, where we recall $\operatorname{rank}(x) \stackrel{\text { def. }}{=}\|\sigma(x)\|_{0}$. Low-rank regularization has proved useful for a variety of applications, including control theory and machine learning; see e.g. [28, 1, 11]

Active set identification. The above discussed regularizers $R$ are non-smooth convex functions. This non-smoothness arises in a highly structured fashion and is usually associated, locally, with some low-dimensional active subset of $\mathbb{R}^{N}$ (in many cases, such a subset is an affine or a smooth manifold). Thus $R$ will favor solutions of $(\mathcal{P}(\lambda, y))$ that lie in a low-dimensional active set would allow to invert the system (1.1) in a stable way. More precisely, one would like that under small perturbations $w$, the solutions of $(\mathcal{P}(\lambda, y))$ move stably along the active set. A byproduct of this behaviour is that from an algorithmic perspective, if an optimization algorithm is used to solve $(\mathcal{P}(\lambda, y))$, one would hope that the iterates of the scheme identify the active set in finite time.

Identifying the low-dimensional active set in a stable way is highly desirable for several reasons. One first reason is that it is a fundamental property most practitioners are looking for. Typical examples include neurosciences [27] where the goal is to recover a spike train from neural activity, or astrophysics [50] where it is desired to separate stars from a background. In both examples, sparsity can be used as a modeling hypothesis and the recovery method should comply with it in a stable way. A second reason is algorithmic since one can also take advantage of the low-dimensionality of the identified active set to reduce computational burden and memory storage, hence opening the door to higher-order acceleration of optimization algorithms (see $[36,44]$ ).

Unfortunately, this desirable behaviour rarely occurs in practical applications. Yet one still observes some form of partial stability (to be given a rigorous meaning in Section 3 and 4), as confirmed by the numerical experiment of the next paragraph.

Illustrative numerical experiment. We consider a simple "compressed sensing" scenario, with the $\ell_{1}$ norm $R=\|\cdot\|_{1}$ [12] and the nuclear norm $R=\|\cdot\|_{*}$ [13] as regularizers. The operator $\Phi \in \mathbb{R}^{N \times P}$ is drawn uniformly at random from the standard Gaussian ensemble, i.e. the entries of $\Phi$ are independent and identically distributed Gaussian random variables with zero-mean and unit variance. In the case $R=\|\cdot\|_{1}$, we set $(N, P)=(100,50)$ and the vector to recover $x_{0}$ is drawn uniformly at random among sparse vectors with $R_{0}\left(x_{0}\right) \stackrel{\text { def. }}{=}\left\|x_{0}\right\|_{0}=10$ and unit non-zero entries. In the case $R=\|\cdot\|_{*}$, we set $(N, P)=(400,300)\left(n_{1}=n_{2}=n=20\right)$ and the matrix to recover $x_{0}$ is drawn uniformly at random among low-rank matrices with $R_{0}\left(x_{0}\right) \stackrel{\text { def. }}{=} \operatorname{rank}\left(x_{0}\right)=4$ and unit non-zero singular values. For each problem suite $(R, N, P), 1000$ realizations of $\left(x_{0}, \Phi, w\right)$ are drawn, and $y$ is then generated according to (1.1). The entries of the noise vector $w$ are drawn uniformly from a Gaussian with standard deviation 0.1 , we set $\lambda=0.28$ for $R=\|\cdot\|_{1}$ and $\lambda=10$ for $R=\|\cdot\|_{*}$.

For each realization of $\left(x_{0}, \Phi, w\right)$, we solve the associated problem $(\mathcal{P}(\lambda, y))$ using CVX to get a high precision; denote $x^{\star}(\lambda, y)$ the obtained solutions. We also solve $(\mathcal{P}(\lambda, y))$ by the Forward-Backward (FB) scheme which reads in this case ${ }^{1}$

$$
x_{k+1}=\operatorname{prox}_{\lambda \gamma R}\left(x_{k}+\gamma \Phi^{*}\left(y-\Phi x_{k}\right)\right)
$$

In our setting, with $\gamma_{k} \equiv 1.8 / \sigma_{\max }\left(\Phi^{*} \Phi\right)$ and non-emptiness of $\operatorname{Argmin}(E(\cdot, \lambda, y)$, it is well-known that the sequence $\left(x_{k}\right)_{k \in \mathbb{N}}$ converges to a point in $\operatorname{Argmin}(E(\cdot, \lambda, y))$.

The top row of Figure 1.1 displays the histogram of the complexity index excess $R_{0}\left(x^{\star}(\lambda, y)\right)-R_{0}\left(x_{0}\right)$ which clearly shows that we do not have exact stability under

the perturbations $w$. Indeed, although $R_{0}\left(x^{\star}(\lambda, y)\right)$ is still rather small, its value is in most cases larger than the complexity index $R_{0}\left(x_{0}\right)$. The bottom row of Figure 1.1 depicts the evolution with $k$ of the complexity index $R_{0}\left(x_{k}\right)$ for two random instances of $x_{0}$ (in blue and red) corresponding to two different values of $R_{0}\left(x^{\star}(\lambda, y)\right)-R_{0}\left(x_{0}\right)$. One can observe that the iterates identify in finite time some low-dimensional active set with a complexity index strictly larger than the one associated to $x_{0}$ (the red curves). We will provide a more detailed discussion of this phenomenon in Section 6.

As we will emphasize in the review of previous work, existing results on sensitivity analysis and low-complexity regularization only focus the case where $R_{0}\left(x^{\star}(\lambda, y)\right)=$ $R_{0}\left(x_{0}\right)$, whose underlying claim is that the low-complexity model is perfectly stable to perturbations, which typically requires some non-degeneracy assumption to hold. In many situations, however, including the compressed sensing scenario described above, but also in super-resolution imaging (see [26]) and other challenging inverse problems, non-degeneracy-type hypotheses are too restrictive. It is the goal of this paper to develop a more general sensitivity analysis, that goes beyond the non-degenerate case, to improve our understanding of stability to perturbations of low-complexity regularized inverse problems.
1.2. Contributions and Outline. Our first contribution consists in introducing, in Section 2, a class of proper lower-semicontinuous (lsc) convex functions that we coin "mirror-stratifiable". The subdifferential of such a function induces a primal-dual pairing of stratifications, which is pivotal to track identifiable strata. We discuss several examples of functions enjoying such a structure. With this structure at hand, we then turn to the main result of this paper, formalized in Theorem 1, and on which all
the others rely. This result shows finite identification for a mirror-stratifiable function without the need of any non-degeneracy condition whatsoever. Sections 3,4 and 5 instantiate this abstract result for a set of concrete problems, respectively: sensitivity of composite smooth+non-smooth optimization problems (Theorem 2), identification by proximal splitting schemes such as Forward-Backward and Douglas-Rachford algorithms (Theorems 4 and 5), and finally, activity identification for regularized inverse problems (Theorem 3). Before stating these results, we make a short review of the associated literature. Finally Section 6 illustrates these theoretical findings with numerical experiments, in particular in a compressed sensing scenario involving the $\ell_{1}$ and nuclear norms as regularizers. Following the philosophy of reproducible research, all the code to reproduce the figures of this article is available online ${ }^{2}$.
2. Mirror-Stratifiable Functions. In this section, we introduce the class of mirror-stratifiable convex functions, and present the nice sensitivity property they provide (Theorem 1). We also illustrate that many popular regularizers used in data science are mirror-stratifiable. Most the results of this section (in particular all the examples) are easy to obtain by basic calculus; we do not give these proofs in the text and we gather some of them in Appendix A.
2.1. Stratifications and definitions. We start with recalling the following standard definition of stratification.

Definition 1 (Stratification). A stratification of a set $D \subset \mathbb{R}^{N}$ is a finite partition $\mathcal{M}=\left\{M_{i}\right\}_{i \in I}$ such that for any partitioning sets (called strata) $M$ and $M^{\prime}$ we have

$$
M \cap \operatorname{cl}\left(M^{\prime}\right) \neq \emptyset \Longrightarrow M \subset \operatorname{cl}\left(M^{\prime}\right)
$$

If the strata are open polyhedra, then $\mathcal{M}$ is a polyhedral stratification, and if they are $C^{2}$-smooth manifolds then $\mathcal{M}$ entails a $C^{2}$-stratification.

A stratification is naturally endowed with the partial ordering $\leqslant$ in the sense

$$
\begin{equation*}
M \leqslant M^{\prime} \quad \Longleftrightarrow \quad M \subset \operatorname{cl}\left(M^{\prime}\right) \quad \Longleftrightarrow \quad M \cap \operatorname{cl}\left(M^{\prime}\right) \neq \emptyset \tag{2.1}
\end{equation*}
$$

The first equivalence stems from the definition and the second one follows from Definition 1 . The relation is clearly reflexive and transitive. Furthermore, we have

$$
\begin{equation*}
\operatorname{cl}(M)=\bigcup_{M^{\prime} \leqslant M} M^{\prime} . \tag{2.2}
\end{equation*}
$$

At this stage, it is worth emphasizing that the strata are not needed to be manifolds in the rest of the paper. It is however the case that in many practical cases that we will discuss, strata are indeed manifolds, and sometimes affine manifolds.

Example 3 (Polyhedral sets and functions). A partition of a polyhedral set into its open faces induces a natural finite polyhedral stratification of it. In turn, let $R$ : $\mathbb{R}^{N} \rightarrow \overline{\mathbb{R}} \stackrel{\text { def. }}{=} \mathbb{R} \cup\{+\infty\}$ be a polyhedral function, and consider a polyhedral stratification of its epigraph, which is a polyhedral set in $\mathbb{R}^{N+1}$. Projecting all polyhedral strata onto the first $N$-coordinates one obtains a finite polyhedral stratification of $\operatorname{dom}(R)$.

Remark 1. The previous example extends to semialgebraic sets and functions, which are known to induce stratifications into finite disjoint unions of manifolds. In fact, this holds for any tame class of sets/functions; see, e.g., [18].

[^2]For a point $x \in D$, there is a unique stratum containing $x$, denoted $M_{x}$. We also single out a specific set of strata, called active strata, that will play a central role for finite identification purposes.

Definition 2 (Active strata). Given a stratification $\mathcal{M}$ of $D \subset \mathbb{R}^{N}$ and a point $x \in D$, a stratum $M \in \mathcal{M}$ is said active at $x$ if $x \in \operatorname{cl}(M)$. The set of active strata at $x$ is denoted $\mathcal{A}_{x}(\mathcal{M})$.

Proposition 1. We have the following equivalent characterizations of $\mathcal{A}_{x}(\mathcal{M})$ :

$$
\begin{align*}
\mathcal{A}_{x}(\mathcal{M}) & =\left\{M \in \mathcal{M}: M \geqslant M_{x}\right\}  \tag{2.3}\\
& =\left\{M_{x^{\prime}} \in \mathcal{M}: \forall x^{\prime} \text { sufficiently close to } x\right\} \tag{2.4}
\end{align*}
$$

2.2. Mirror-Stratifiable functions. Following [19, Section 4], we define the key correspondence operator whose role will become apparent shortly.

Definition 3. Let $R: \mathbb{R}^{N} \rightarrow \overline{\mathbb{R}}$ be a proper lsc convex function. The associated correspondence operator $\mathcal{J}_{R}: 2^{\mathbb{R}^{N}} \rightarrow 2^{\mathbb{R}^{N}}$ is defined as

$$
\mathcal{J}_{R}(S) \stackrel{\text { def. }}{=} \bigcup_{x \in S} \operatorname{ri}(\partial R(x))
$$

where $\partial R$ is the subdifferential of $R$.
Observe that, by definition, $\mathcal{J}_{R}$ is increasing for set inclusion

$$
\begin{equation*}
S \subset S^{\prime} \quad \Longrightarrow \quad \mathcal{J}_{R}(S) \subset \mathcal{J}_{R}\left(S^{\prime}\right) \tag{2.5}
\end{equation*}
$$

For this operator to be useful in sensitivity analysis, we further impose that $\mathcal{J}_{R}$ is decreasing for the partial ordering $\leqslant$ in (2.1), as captured in our main definition. We will denote $R^{*}$ the Legendre-Fenchel conjugate of $R$.

Definition 4 (Mirror-stratifiable functions). Let $R: \mathbb{R}^{N} \rightarrow \overline{\mathbb{R}}$ be a proper lsc convex function; we say that $R$ is mirror-stratifiable with respect to a (primal) stratification $\mathcal{M}=\left\{M_{i}\right\}_{i \in I}$ of $\operatorname{dom}(\partial R)$ and a (dual) stratification $\mathcal{M}^{*}=\left\{M_{i}^{*}\right\}_{i \in I}$ of $\operatorname{dom}\left(\partial R^{*}\right)$ if the following holds:
(i) Conjugation induces a duality pairing between $\mathcal{M}$ and $\mathcal{M}^{*}$, and $\mathcal{J}_{R}: \mathcal{M} \rightarrow$ $\mathcal{M}^{*}$ is invertible with inverse $\mathcal{J}_{R^{*}}$, i.e. $\forall M \in \mathcal{M}, M^{*} \in \mathcal{M}^{*}$ we have

$$
M^{*}=\mathcal{J}_{R}(M) \Longleftrightarrow \mathcal{J}_{R^{*}}\left(M^{*}\right)=M
$$

(ii) $\mathcal{J}_{R}$ is decreasing for the relation $\leqslant$ : for any $M$ and $M^{\prime}$ in $\mathcal{M}$

$$
M \leqslant M^{\prime} \Longleftrightarrow \mathcal{J}_{R}(M) \geqslant \mathcal{J}_{R}\left(M^{\prime}\right)
$$

Notice that the primal-dual stratifications that make $R$ mirror-stratifiable are not unique, as will be exemplified in Remark 3. Though the definition is formal and the assumptions looks restrictive, this class include many useful examples, as illustrated in the next section. We finish this section with a remark, used in the sequel.

Remark 2 (Separability). For each $l=1, \ldots, L$, suppose that the proper lsc convex function $R_{l}: \mathbb{R}^{N_{l}} \rightarrow \overline{\mathbb{R}}$ is mirror-stratifiable with respect to stratifications $\mathcal{M}_{l}$ and $\mathcal{M}_{l}^{*}$. Then it is easy to show, using standard subdifferential and conjugacy calculus, that the function $R: \mathbb{R}^{N_{1}} \times \cdots \times \mathbb{R}^{N_{L}} \rightarrow \sum_{l=1}^{L} R_{l}\left(x_{l}\right)$ is mirror-stratifiable with stratifications $\mathcal{M}_{1} \times \cdots \times \mathcal{M}_{L}$ and $\mathcal{M}_{1}^{*} \times \cdots \times \mathcal{M}_{L}^{*}$.
2.3. Examples. The notion of mirror-stratifiable function looks quite rigid. However, many of the regularization functions routinely used in data science are mirror-stratifiable. Let us provide some relevant examples in this section. In particular, the $\ell_{1}$-norm and the nuclear norm will be used in the numerical experiments.
2.3.1. Quadratic function. Consider the quadratic function $R: x \in \mathbb{R}^{N} \mapsto$ $\frac{1}{2}\langle A x, x\rangle$, where $A$ is symmetric definite-positive. Its conjugate is $R^{*}: u \in \mathbb{R}^{N} \mapsto$ $\frac{1}{2}\left\langle A^{-1} u, u\right\rangle$. Thus $R$ is mirror-stratifiable with $\mathcal{M}=\mathcal{M}^{*}=\left\{\mathbb{R}^{N}\right\}$.
2.3.2. $\ell_{1}$-norm. Let $R: x \in \mathbb{R} \mapsto|x|$, whose conjugate $R^{*}=\iota_{[-1,1]}$. It follows that $R$ is mirror-stratifiable with $\mathcal{M}=\{ ]-\infty, 0[,\{0\}] 0,,+\infty[ \}$ and $\mathcal{M}^{*}=\{\{-1\}]-$, $1,1[,\{+1\}\}$. Using Remark 2, the next result is clear.

LEMMA 1. The $\ell_{1}$-norm and its conjugate $\iota_{[-1,+1]^{N}}$ are mirror-stratifiable with respect to the stratifications $\mathcal{M}=\{ ]-\infty, 0[,\{0\}] 0,,+\infty[ \}^{N}$ of $\mathbb{R}^{N}$ and $\mathcal{M}^{*}=\{\{-1\}]-$, $1,1[,\{+1\}\}^{N}$ of $[-1,+1]^{N}$.

REMARK 3 (Non-uniqueness of stratifications). In general, we do not have uniqueness of stratifications inducing mirror-stratifiable functions. To illustrate this, let us consider the $\ell_{1}$ norm. Take the partitions $\mathcal{M}=\{ ]-\infty, 0[\cup] 0,+\infty[,\{0\}\}^{N}$ of $\mathbb{R}^{N}$ and $\mathcal{M}^{*}=\{\{-1,+1\}]-1,,1[ \}^{N}$. These are valid stratifications though the strata are not connected. Other possible valid stratifications are given by strata $M_{j}=\left\{x \in \mathbb{R}^{N}:\|x\|_{0}=j\right\}$ and $M_{j}^{*}=\mathcal{J}_{\|\cdot\|_{1}}\left(M_{j}\right)$, for $j=0,1, \ldots, N$. It is immediate to check that the $\ell_{1}$-norm is also mirror-stratifiable with respect to these stratifications. However, as devised above, it is in general not wise to take such large strata as they lead to less sharp localization and sensitivity results.

REMARK 4 (Instability under the sum rule). The family of mirror-stratifiable functions is unfortunately not stable under the sum. As a simple counter-example, consider the pair of conjugate functions on $\mathbb{R}: R(x)=|x|+x^{2} / 2$ and $R^{*}(u)=$ $(\max \{|u|-1,0\})^{2} / 2$. We obviously have $\operatorname{dom}(\partial R)=\operatorname{dom}\left(\partial R^{*}\right)=\mathbb{R}$. However we observe that $\mathcal{J}_{R}(\mathbb{R})=\mathbb{R} \backslash\{-1,1\}$. This yields that $\mathcal{J}_{R}$ cannot be a pairing between any two stratifications of $\mathbb{R}$, and therefore $R$ cannot be mirror-stratifiable.
2.3.3. $\ell_{1,2}$ norm. The $\ell_{1,2}$ norm, also known as the group Lasso regularization, has been advocated to promote group/block sparsity [56], i.e. it drives all the coefficients in one group to zero together. Let $\mathcal{B}$ a non-overlapping uniform partition of $\{1, \ldots, N\}$ into $K$ blocks. The $\ell_{1,2}$ norm induced by the partition $\mathcal{B}$ reads

$$
\|x\|_{\mathcal{B}}=\sum_{B \in \mathcal{B}}\left\|x_{B}\right\|_{2}
$$

where $x_{B}$ is the restriction of $x$ to the entries indexed by the block $B$. This is again a separable function of the $x_{B}$ 's. One can easily show that the $\ell_{2}$ norm on $\mathbb{R}^{|B|}$ and its conjugate, the indicator of the unit $\ell_{2}$-ball $\mathbb{B}_{\ell_{2}^{|B|}}$ in $\mathbb{R}^{|B|}$, are mirror-stratifiable with respect to the stratifications $\left\{\{0\}, \mathbb{R}^{|B|} \backslash\{0\}\right\}$ of $\mathbb{R}^{N}$ and $\left\{\mathbb{S}^{|B|-1}, \operatorname{int}\left(\mathbb{B}_{\ell_{2}^{|B|}}\right)\right\}$ of $\mathbb{B}_{\ell_{2}^{|B|}}$ ). In turn, the $\ell_{1,2}$ norm is mirror-stratifiable with respect to the stratifications $\mathcal{M}=\left\{\{0\}, \mathbb{R}^{|B|} \backslash\{0\}\right\}^{K}$ and $\mathcal{M}^{*}=\left\{\mathbb{S}^{|B|-1}, \operatorname{int}\left(\mathbb{B}_{\ell_{2}^{|B|}}\right)\right\}^{K}$.
2.3.4. Nuclear norm. Let us come back to the nuclear norm defined in Example 2. For simplicity, we assume $n_{1}=n_{2}=n$. Let $M$ be a stratum of the $\ell_{1}$ norm stratification. In the following, we denote by $M^{\text {sym }}$ its symmetrization. We observe that $\sigma^{-1}\left(M^{\text {sym }}\right)=\left\{X \in \mathbb{R}^{n \times n}: \operatorname{rank}(X)=\|z\|_{0}, z \in M\right\}$. So many inverse images
$\sigma^{-1}\left(M^{\text {sym }}\right)$ of strata $M^{\text {sym }}$ coincide. This suggests the following $n+1$ stratifications: for a given $i \in\{0, \ldots, N\}$

$$
\begin{aligned}
M_{i} & =\left\{X \in \mathbb{R}^{n \times n}: \operatorname{rank}(X)=i\right\} \\
M_{i}^{*} & =\left\{U \in \mathbb{R}^{n}: \sigma_{1}(U)=\cdots=\sigma_{i}(U)=1, \forall j>i,\left|\sigma_{j}(U)\right|<1\right\}
\end{aligned}
$$

This yields that $\|\cdot\|_{*}$ is mirror-stratifiable with respect to these stratifications.
2.3.5. Polyhedral Functions. We here establish mirror-stratifiability of polyhedral functions, including the $\ell_{1}$ norm, the $\ell_{\infty}$ norm and anisotropic TV semi-norm. A polyhedral function $R: \mathbb{R}^{N} \rightarrow \overline{\mathbb{R}}$ can be expressed as

$$
\begin{equation*}
R(x)=\max _{i=1, \ldots, k}\left\{\left\langle a_{i}, x\right\rangle-\alpha_{i}\right\}+\iota^{\bigcap_{i=k+1, \ldots, m}\left\{x:\left\langle a_{i}, x\right\rangle-\alpha_{i} \leqslant 0\right\}}(x) . \tag{2.6}
\end{equation*}
$$

For any $x \in \operatorname{dom}(R)$, introduce the two sets of indices

$$
\begin{aligned}
I^{\max }(x) & =\left\{i=1, \ldots, m:\left\langle a_{i}, x\right\rangle-\alpha_{i}=R(x)\right\} \\
I^{\mathrm{feas}}(x) & =\left\{i=1, \ldots, m:\left\langle a_{i}, x\right\rangle=\alpha_{i}\right\}
\end{aligned}
$$

For a given index set $I \subset\{1, \ldots, m\}$, we consider the affine manifold

$$
\begin{equation*}
M_{I} \stackrel{\text { def. }}{=}\left\{x \in \operatorname{dom}(R): I^{\max }(x) \cap I^{\text {feas }}(x)=I\right\} \tag{2.7}
\end{equation*}
$$

We see that some $M_{I}$ may be empty and that $\mathcal{M}=\left\{M_{I}\right\}_{I}$ is a stratification of $\operatorname{dom}(R)$. The stratum $M_{I}$ is characterized by the optimality part $I^{\max }=I \cap\{1, \ldots, k\}$ and the feasibility part $I^{\text {feas }}=I \cap\{k+1, \ldots, m\}$ of $I$. Similarly we define

$$
M_{I}^{*}=\operatorname{ri}\left(\operatorname{conv}\left\{a_{i}: i \in I^{\max }\right\}\right)+\operatorname{ri}\left(\operatorname{cone}\left\{a_{i}: i \in I^{\mathrm{feas}}\right\}\right)
$$

Let us formalize in the next proposition a result alluded to in [19].
Proposition 2. A polyhedral function $R$ is mirror-stratifiable with respect to its naturally induced stratifications $\left\{M_{I}\right\}_{I}$ and $\left\{M_{I}^{*}\right\}_{I}$.

Remark 5 (Back to $\|\cdot\|_{1}$ ). As we anticipated, Proposition 2 subsumes Lemma 1 as a special case. To see this, observe that

$$
\|x\|_{1}=\max _{\|u\|_{\infty} \leqslant 1}\langle u, x\rangle=\max _{u \in\{-1,+1\}^{N}}\langle u, x\rangle
$$

which is of the form (2.6) with $k=m=2^{N}$. Thus there are $2^{2^{N}}$ affine manifolds as defined by (2.7). But many of them are empty: there is only $3^{N}$ (non-empty, distinct) manifolds in the stratification of $\mathbb{R}^{N}$, and they coincide with those in Lemma 1.
2.3.6. Spectral Lifting of Polyhedral Functions. As we discussed in Remark $4, \mathcal{J}_{R}$ may fail to induce a duality pairing between stratifications of $R$ and $R^{*}$, in which case $R$ cannot be mirror-stratifiable. Hence, for this type of duality to hold, one needs to impose stringent strict convexity conditions. To avoid this, and still afford a large class of mirror-stratifiable functions that are of utmost in applications, we consider spectral lifting of polyhedral functions, in the same vein as [19] did it for partial smoothness.

A matrix function $R: \mathbb{R}^{N=n \times n} \rightarrow \overline{\mathbb{R}}$ is said to be a spectral lift of a polyhedral function if there exists a polyhedral function $R^{\text {sym }}: \mathbb{R}^{n} \rightarrow \mathbb{R}$, invariant under signed permutation of its coordinates, such that $R=R^{\mathrm{sym}} \circ \sigma$ where $\sigma$ computes the singular
values of a matrix. Associated to $\mathcal{M}=\left\{M_{I}\right\}_{I}$ the (polyhedral) stratification induced by $R^{\text {sym }}$, we consider its symmetrized stratification. We define the symmetrization of $M \in \mathcal{M}$, as the set $M^{\text {sym }}$

$$
M^{\text {sym }}=\left\{x \in \mathbb{R}^{N}: \exists y \in M \text { such that for all } i \text { there exists } j \text { and }\left|x_{i}\right|=\left|y_{j}\right|\right\}
$$

The next result is a corollary of the main result of [19].
Proposition 3. A spectral function $R=R^{\text {sym }} \circ \sigma$ is mirror-stratifiable with respect to the smooth stratification $\left\{\sigma^{-1}\left(M^{\mathrm{sym}}\right)\right\}$ and its image by $\mathcal{J}_{R}$.

REMARK 6 (Back to $\|\cdot\|_{*}$ ). The nuclear norm is a spectral lift of the $\ell_{1}$ norm. Therefore, one can recover mirror-stratification of the nuclear norm, with the stratifications given in Section 2.3.4, by putting together Lemma 1 and Proposition 3.
2.4. Identification for Mirror-Stratifiable Functions. To our point of view, the notion of mirror-stratifibility deserves a special study in view of the following simple but powerful geometrical observation. We state it as a theorem because of its utmost importance in the subsequent developments of this paper.

ThEOREM 1 (General identification). Let $R$ be a proper lsc convex function which is mirror-stratifiable with respect to primal-dual stratifications $\mathcal{M}=\{M\}$ and $\mathcal{M}^{*}=\left\{M^{*}\right\}$. Consider a pair of points $(\bar{x}, \bar{u})$ and the associated strata $M_{\bar{x}}$ and $M_{\bar{u}}^{*}$. If two sequences $x_{k} \rightarrow \bar{x}$ and $u_{k} \rightarrow \bar{u}$ such that $u_{k} \in \partial R\left(x_{k}\right)$, then for $k$ large enough, $x_{k}$ is localized in a specific set of strata such that

$$
\begin{equation*}
M_{\bar{x}} \leqslant M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{\bar{u}}^{*}\right) \tag{2.8}
\end{equation*}
$$

Proof. By assumption on $R, \partial R$ is sequentially closed and thus $\bar{u} \in \partial R(\bar{x})$. Now, since $x_{k}$ is close to $\bar{x}$, upon invoking (2.4) and (2.3), we get

$$
M_{x_{k}} \geqslant M_{\bar{x}}
$$

which shows the left-hand side of (2.8). Similarly, we have

$$
\begin{equation*}
M_{u_{k}}^{*} \geqslant M_{\bar{u}}^{*} \tag{2.9}
\end{equation*}
$$

Using the fact that $\partial R\left(x_{k}\right)$ is a closed convex set together with (2.5) leads to

$$
u_{k} \in \partial R\left(x_{k}\right)=\operatorname{cl}\left(\operatorname{ri}\left(\partial R\left(x_{k}\right)\right)\right)=\operatorname{cl}\left(\mathcal{J}_{R}\left(\left\{x_{k}\right\}\right)\right) \subset \operatorname{cl}\left(\mathcal{J}_{R}\left(M_{x_{k}}\right)\right)
$$

which entails $M_{u_{k}} \leqslant \mathcal{J}_{R}\left(M_{x_{k}}\right)$. Using finally (2.9) and that by definition, $\mathcal{J}_{R}$ is decreasing for the relation $\leqslant$, we get

$$
M_{\bar{u}}^{*} \leqslant M_{u_{k}}^{*} \leqslant \mathcal{J}_{R}\left(M_{x_{k}}\right) \quad \Longrightarrow \quad M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{\bar{u}}^{*}\right)
$$

whence we deduce the right-hand side of (2.8).
Mirror-stratification thus allows us to prove the simple but powerful claim of Theorem 1. As we will see in the rest of the paper, this result will be the backbone to prove sensitivity and finite identification results in absence of non-degeneracy.
3. Sensitivity of Composite Optimization Problems. In this section, we consider a parametric convex optimization problem of the form

$$
\begin{equation*}
\min _{x \in \mathbb{R}^{N}} E(x, p) \stackrel{\text { def. }}{=} F(x, p)+R(x) \tag{p}
\end{equation*}
$$

depending on the parameter vector $p \in \Pi$, where $\Pi$ is the parameter set, an open subset of a finite dimensional linear space. Sensitivity analysis studies the properties of solutions $x^{\star}(p)$ of $(\mathcal{P}(p))$ (assuming they exist) to perturbations of the parameters vector $p \in \Pi$ around some reference point $p_{0}$. In Section 3.1, we briefly review the existing results on this topic and their limitations. We then introduce in Section 3.2 our new results obtained owing to the mirror-stratifiable structure.
3.1. Existing sensitivity results. Classical sensitivity results (see e.g. [7, 45, 21]) study the regularity of the set-valued map $p \mapsto x^{\star}(p)$. A typical result proves Lipschitz continuity of this map provided that $E$ is smooth enough and $E\left(\cdot, p_{0}\right)$ has a local second-order (quadratic) growth at $x^{\star}\left(p_{0}\right)$, i.e. that there exists some $c>0$ such that $E\left(x, p_{0}\right) \geqslant E\left(x^{\star}\left(p_{0}\right), p_{0}\right)+c\left\|x-x^{\star}\left(p_{0}\right)\right\|^{2}$ for $x$ nearby $x^{\star}\left(p_{0}\right)$. For $C^{2}$-smooth optimization, this growth condition is equivalent to positive definiteness of the hessian of $E$ with respect to $x$ evaluated at $\left(x^{\star}\left(p_{0}\right), p_{0}\right)$ [29]. For classical smooth constrained optimization problems, activity is captured by the subset of active inequality constraints. Under reasonable non-degeneracy conditions (see, for example, [29]), this active set is stable under small perturbations to the objective.

A nice nonsmooth sensitivity theory is based on the notion of partial smoothness [37]. Partial smoothness is an intrinsically geometrical assumption which, informally speaking, says that $E$ behaves smoothly along an active manifold and sharply in directions normal to the manifold. Furthermore, under a non-degeneracy assumption at a minimizer (see (3.1)), it allows appealing statements of second-order optimality conditions (including second-order generalized differentiation) and associated sensitivity analysis around that minimizer [37, 38].

Specializing the result of [24, Proposition 8.4] to a proper lsc convex function $E(\cdot, p)$, one can show that $C^{2}$-partial smoothness of $E(\cdot, p)$ at $x^{\star}\left(p_{0}\right)$ relative to some fixed manifold (independent of $p$ ) for 0 , together with the non-degeneracy assumption

$$
\begin{equation*}
0 \in \operatorname{ri}\left(\partial E\left(x^{\star}\left(p_{0}\right), p_{0}\right)\right) \tag{3.1}
\end{equation*}
$$

is equivalent to the existence of an identifiable $C^{2}$-smooth manifold, i.e. for $x^{\star}(p)$ and $u^{\star}(p) \in \partial E\left(x^{\star}(p), p\right)$ close enough to $x^{\star}\left(p_{0}\right)$ and $0, x^{\star}(p)$ lives on the active/partly smooth manifold of $x^{\star}\left(p_{0}\right)$. If these assumptions are supplemented with a quadratic growth condition of $E$ (see above) along the active manifold, then one also has $C^{1}$ smoothness of the single-valued mapping $p \mapsto x^{\star}(p)$ [37, Theorem 5.7]. It can be deduced from [23, Corollary 4.3] that for almost all linear perturbations of lsc convex semialgebraic functions, the non-degeneracy and quadratic growth conditions hold. This genericity fails however to hold for many cases of interest. As an example, consider $E$ of $(\mathcal{P}(\lambda, y))$ with $\lambda>0$ fixed and $p=y$. If $R$ is a proper lsc convex and semialgebraic function, one has from [23] that for Lebesgue almost all $\Phi^{*} y$, problem $(\mathcal{P}(\lambda, y))$ has at most one minimizer at which furthermore non-degeneracy and quadratic growth hold. Of course genericity in terms of $\Phi^{*} y$ does not imply that in terms of $y$, which is our parameter of interest. Not to mention that we supposed $\lambda$ fixed while it is not in many cases of interest.
3.2. Sensitivity analysis without non-degeneracy. For a fixed $p,(\mathcal{P}(p))$ is a standard composite optimization problem. Here, we assume that the objective is the sum of a $C^{1}\left(\mathbb{R}^{N}\right)$ convex function $F(\cdot, p)$ and a nonsmooth proper lsc convex function $R$. We denote $\nabla F(x, p)$ the gradient of $F(\cdot, p)$ at $x$.

We are going to show that if the minimizer $x^{\star}\left(p_{0}\right)$ is unique, slight perturbations
$p$ or $p_{0}$ generate solutions $x^{\star}(p)$ that are in a "controlled" stratum $M_{x^{\star}(p)}$ precisely sandwiched to extreme strata defined from primal-dual solution for $p_{0}$.

THEOREM 2 (Sensitivity analysis with mirror-stratifiable functions). Let $p_{0}$ be a given point in the parameter space $\Pi$. Make some general assumptions: (i) $E\left(\cdot, p_{0}\right)$ has a unique minimizer $x^{\star}\left(p_{0}\right)$, (ii) $E$ is lsc on $\mathbb{R}^{N} \times \Pi$, (iii) $E\left(x^{\star}\left(p_{0}\right), \cdot\right)$ is continuous at $p_{0}$, (iv) $\nabla F$ is continuous at $\left(x^{\star}\left(p_{0}\right), p_{0}\right)$, and (v) $E$ is level-bounded ${ }^{3}$ in $x$ uniformly in $p$ locally around $p_{0}$. If $R$ is mirror-stratifiable according to $\left(\mathcal{M}, \mathcal{M}^{*}\right)$, then for all $p$ close to $p_{0}$, any minimizer $x^{\star}(p)$ of $E(\cdot, p)$ is localized as follows

$$
\begin{equation*}
M_{x^{\star}\left(p_{0}\right)} \leqslant M_{x^{\star}(p)} \leqslant \mathcal{J}_{R^{*}}\left(M_{u^{\star}\left(p_{0}\right)}^{*}\right) \quad \text { where } \quad u^{\star}\left(p_{0}\right) \stackrel{\text { def. }}{=}-\nabla F\left(x^{\star}\left(p_{0}\right), p_{0}\right) \tag{3.2}
\end{equation*}
$$

Proof. Le $p_{k} \in \Pi$ be a sequence of parameters converging to $p_{0}$. By assumption on $F$ and $R, E(\cdot, p)$ is proper for any $p$. Since it is also lsc and is level-bounded in $x$ uniformly in $p$ locally around $p_{0}$ by conditions (ii) and (v). It follows from [48, Theorem $1.17(\mathrm{a})]$ that $\operatorname{Argmin} E\left(\cdot, p_{k}\right)$ is non-empty and compact, and, in turn, any sequence $\left(x_{k}^{\star}\right)_{k}$ of minimizers is bounded. We consider a (non-relabelled for simplicity) sub-sequence $x_{k}^{\star} \rightarrow \bar{x}$. We then have

$$
\begin{aligned}
E\left(\bar{x}, p_{0}\right) & \stackrel{\text { condition (ii) }}{\leqslant} \liminf _{k} E\left(x_{k}^{\star}, p_{k}\right) \\
& \stackrel{\text { Optimality }}{\leqslant} \liminf _{k} E\left(x^{\star}\left(p_{0}\right), p_{k}\right) \\
& \quad=\quad \operatorname{cim}_{k} E\left(x^{\star}\left(p_{0}\right), p_{k}\right)=E\left(x^{\star}\left(p_{0}\right), p_{0}\right)
\end{aligned}
$$

By the uniqueness condition (i), we conclude that $\bar{x}=x^{\star}\left(p_{0}\right)$. Let $u_{k}^{\star} \stackrel{\text { def. }}{=}-\nabla F\left(x_{k}^{\star}, p_{k}\right)$. Since $\nabla F$ is continuous at $\left(x_{0}, p_{0}\right)$ by assumption (iv), one has $u_{k}^{\star} \rightarrow u_{0}$. The firstorder optimality condition of problem $(\mathcal{P}(p))$ reads $u_{k}^{\star} \in \partial R\left(x_{k}^{\star}\right)$. Hence we are now in position to invoke Theorem 1 to conclude. $\square$

REmARK 7 (Single manifold identification). In the special case where we have the non-degeneracy condition

$$
\begin{equation*}
u^{\star}\left(p_{0}\right)=-\nabla F\left(x^{\star}\left(p_{0}\right), p_{0}\right) \in \operatorname{ri}\left(\partial R\left(x^{\star}\left(p_{0}\right)\right)\right) \tag{3.3}
\end{equation*}
$$

our result simplifies and we recover the known exact identification result. To see this, we note that (3.3) also reads $u^{\star}\left(p_{0}\right) \in \mathcal{J}_{R}\left(\left\{x^{\star}\left(p_{0}\right)\right\}\right)$, and thus $M_{u^{\star}\left(p_{0}\right)}^{*}=$ $\mathcal{J}_{R}\left(\left\{x^{\star}\left(p_{0}\right)\right\}\right)$. In this case (3.2)becomes $M_{x^{\star}(p)}=M_{x_{0}}$ for all $p$ close to $p_{0}$. Such a result was also established in [34, 38] under condition (3.3), when $F\left(\cdot, p_{0}\right)$ is also locally $C^{2}$ around $x^{\star}\left(p_{0}\right)$ and $R$ is partly smooth at $x^{\star}\left(p_{0}\right)$ relative to a $C^{2}$-smooth manifold $M_{x^{\star}\left(p_{0}\right)}$. Our result covers the more delicate degenerate situation where $u^{\star}\left(p_{0}\right)$ might be on the relative boundary of the subdifferential, but requires the stronger mirrorstratifiability structure on the non-smooth part. However, the active set at $x^{\star}(p)$ is in general not unique for all $p$ close to $p_{0}$.

Remark 8 (Quadratic growth). We can also establish the Lipschitz continuity of $x^{\star}(p)$ under the conditions of Theorem 2, under an additional second-order growth condition, just as in classical sensitivity analysis (see [7, Section 4.2.1]). Let us assume that there exists a neighbourhood $\mathcal{V}$ of $x^{\star}\left(p_{0}\right)$ and $\kappa>0$ such that

$$
\begin{equation*}
E\left(x, p_{0}\right) \geqslant E\left(x^{\star}\left(p_{0}\right), p_{0}\right)+\kappa\left\|x-x^{\star}\left(p_{0}\right)\right\|^{2} \quad \forall x \in \mathcal{V} \tag{3.4}
\end{equation*}
$$

[^3]Since $x_{k}^{\star} \rightarrow x^{\star}\left(p_{0}\right)$ for $p_{k} \rightarrow p_{0}$ (see the proof of Theorem 2), we have $x_{k}^{\star} \in \mathcal{V}$ for $k$ large enough. If, moreover, $\nabla F(x, \cdot)$ is Lipschitz-continuous in a neighbourhood of $p_{0}$ with Lipschitz constant $\nu$ independent of $x \in \mathcal{V}$, we get

$$
\begin{aligned}
\kappa\left\|x_{k}^{\star}-x^{\star}\left(p_{0}\right)\right\|^{2} \leqslant & E\left(x_{k}^{\star}, p_{0}\right)-E\left(x^{\star}\left(p_{0}\right), p_{0}\right) \\
= & \left(\left(E\left(x^{\star}\left(p_{0}\right), p_{k}\right)-E\left(x_{k}^{\star}, p_{k}\right)\right)-\left(E\left(x^{\star}\left(p_{0}\right), p_{0}\right)-E\left(x_{k}^{\star}, p_{0}\right)\right)\right) \\
& -\left(E\left(x^{\star}\left(p_{0}\right), p_{k}\right)-E\left(x_{k}^{\star}, p_{k}\right)\right) \\
\left(x_{k}^{\star} \text { minimizes } E\left(\cdot, p_{k}\right)\right) \leqslant & \left(E\left(x^{\star}\left(p_{0}\right), p_{k}\right)-E\left(x_{k}^{\star}, p_{k}\right)\right)-\left(E\left(x^{\star}\left(p_{0}\right), p_{0}\right)-E\left(x_{k}^{\star}, p_{0}\right)\right. \\
(\text { By }(\mathcal{P}(p)))= & \left(F\left(x^{\star}\left(p_{0}\right), p_{k}\right)-F\left(x_{k}^{\star}, p_{k}\right)\right)-\left(F\left(x^{\star}\left(p_{0}\right), p_{0}\right)-F\left(x_{k}^{\star}, p_{0}\right)\right) \\
\text { (Mean-Value Theorem) } \leqslant & \left(\sup _{x \in \mathcal{V}}\left\|\nabla F\left(x, p_{k}\right)-\nabla F\left(x, p_{0}\right)\right\|\right)\left\|x_{k}^{\star}-x^{\star}\left(p_{0}\right)\right\| \\
\leqslant & \nu\left\|p_{k}-p_{0}\right\|\left\|x_{k}^{\star}-x^{\star}\left(p_{0}\right)\right\| .
\end{aligned}
$$

whence we conclude that

$$
d\left(x^{\star}\left(p_{0}\right), \operatorname{Argmin} E\left(\cdot, p_{k}\right)\right) \leqslant \nu / \kappa\left\|p_{k}-p_{0}\right\| .
$$

4. Regularized Inverse Problems. A typical context where our framework of mirror-stratifiability is of usefulness is that of studying stability to noise of regularized linear inverse problems. We come back to the situation presented in introduction: studying stability issues to perturbed observations of the form $y=y_{0}+w$ amounts to analyzing sensitivity of the minimizers and the optimal value function in $(\mathcal{P}(\lambda, y))$ when the parameter $p=(\lambda, y)$ evolves around the reference point $p_{0}=\left(0, y_{0}\right)$. Unlike the usual sensitivity analysis theory setting recalled in the previous section (e.g. [7]), here the objective $E$ may not even be continuous at $p_{0}$.

We provide hereafter some pointers to the relevant literature, then we develop our sensitivity results for mirror-stratifiable functions. These results involve primal and dual solutions to the noiseless problem

\min _{x \in \mathbb{R}^{N}} E(x,(0, y)) \stackrel{\text { def. }}{=} R(x) \quad \text { s.t. } \quad \Phi x=y \tag{0,y}
\end{equation*}

### 4.1. Existing sensitivity results for regularized Inverse Problems.

Lipschitz stability. Assume there exists a dual multiplier $\eta \in \mathbb{R}^{P}$ (sometimes referred to as a "dual certificate") for the noiseless constrained problem $(\mathcal{P}(0, y))$ taken at $y=y_{0}$ such that $\Phi^{*} \eta \in \partial R\left(x_{0}\right)$. The latter condition is equivalent to $x_{0}$ being a minimizer of $(\mathcal{P}(0, y))$. This condition goes by the name of the "source" or "range" condition in the inverse problems literature. It has been widely used to derive stability results in terms of $\left\|\Phi x^{\star}(\lambda, y)-\Phi x_{0}\right\|$ or $R\left(x^{\star}(\lambda, y)\right)-R\left(x_{0}\right)-$ $\left\langle\Phi^{*} \eta, x^{\star}(\lambda, y)-x_{0}\right\rangle ;$ see [49] and references therein. To afford stability in terms of $\left\|x^{\star}(\lambda, y)-x_{0}\right\|$ directly, the range condition has to be strengthened to its nondegenerate version $\Phi^{*} \eta \in \operatorname{ri}\left(\partial R\left(x_{0}\right)\right)$. It has been shown that this condition implies that the set-valued map $(\lambda, y) \mapsto x^{\star}(\lambda, y)$ is Lipschitz-continuous at $\left(0, y_{0}\right)$; see [31] and [55].

Active set stability. In the case where $R$ is partly smooth, one can approach an even more complete sensitivity theory by studying stability of the partly smooth manifold of $R$ at $x_{0}$. In particular, it can be shown that if a strict non-degeneracy assumption holds, then problems $(\mathcal{P}(0, y))$ and $(\mathcal{P}(\lambda, y))$ have unique minimizers (respectively $x_{0}$ and $x^{\star}(\lambda, y)$ ), and $x^{\star}(\lambda, y)$ lies on the partly smooth manifold of $R$ at $x_{0}$.

Observe that compared to Lipschitz stability, active set stability is more demanding as the non-degeneracy condition has to hold for a specific dual multiplier, which is obviously more stringent. This type of results has appeared many times in the literature for special cases, e.g. for the $\ell_{1}$ norm [30, 57], the nuclear norm [1]. The work in $[53,54]$ has unified all these results, under non-degeneracy.

Non-degeneracy in practice for deconvolution and compressed sensing. The above results require that some abstract non-degeneracy condition holds, which imposes strict limitations on practical situations. In particular, when $\Phi$ is a convolution operator and $x_{0}$ is sparse, [10] studies Lipschitz stability and [25] support stability. In this setting, the non-degeneracy condition holds whenever the spikes are separated enough, which is not often verified. Another setting where this stability theory has been applied in when $\Phi$ is drawn from a random matrix ensemble, i.e. compressed sensing. For a variety of partly smooth regularizers (including the $\ell_{1}$, nuclear and $\ell_{1,2}$ norms), the non-degeneracy condition holds with high probability if, roughly speaking, the sample size $P$ is sufficiently larger than the "dimension" of the active set at $x_{0}$ (see e.g. [12, 22]). Again this is a clear limitation as illustrated in Section 1.1.
4.2. Primal and dual problems. Suppose we have observations of the form (1.1), and we want to recover $x_{0}$ (or a provably good approximation of it). As advocated in Section 1.1, a popular approach is to adopt a regularization framework which can be cast as the optimization problem $(\mathcal{P}(\lambda, y)$ ) (for $\lambda>0)$ and $(\mathcal{P}(0, y))$ (when $\lambda=0$ ). In the sequel, to avoid trivialities, we assume that $R^{\infty}(\delta)>0, \forall 0 \neq$ $\delta \in \operatorname{ker}(\Phi)$, where $R^{\infty}$ is the asymptotic or recession function of $R$. This is a necessary and sufficient condition for the set of minimizers of $(\mathcal{P}(\lambda, y))$ and $(\mathcal{P}(0, y))$ to be non-empty and compact.

REMARK 9 (Discontinuity of $F$ ). Letting $p \stackrel{\text { def. }}{=}(\lambda, y) \in \Pi \stackrel{\text { def. }}{=} \mathbb{R}_{+} \times \mathbb{R}^{P}$, we see that $(\mathcal{P}(\lambda, y))$ and $(\mathcal{P}(0, y))$ are instances of $(\mathcal{P}(p))$, by setting

$$
F(x, p) \stackrel{\text { def. }}{=}\left\{\begin{array}{ll}
\frac{1}{2 \lambda}\|y-\Phi x\|^{2} & \text { if } \lambda>0,  \tag{4.1}\\
\iota \mathcal{H}_{y}(x) & \text { if } \lambda=0,
\end{array} \quad \text { where } \quad \mathcal{H}_{y} \stackrel{\text { def. }}{=}\left\{x \in \mathbb{R}^{N}: \Phi x=y\right\}\right.
$$

The corresponding function $F$ considered does not obey the assumptions of Theorem 2. Indeed, the parameter set $\Pi$ is not open, with $p_{0}=\left(0, y_{0}\right)$ that lives on the boundary of $\Pi$, and $F$ is only lsc at such $p_{0}$ (because of the affine constraint $\Phi x=y$ ). The main consequence will be that one cannot anymore allow $p$ to vary freely nearby $p_{0}$.

In order to study the sensitivity of solutions, we look at the Fenchel-Rockafellar dual problem, which reads (for all $\lambda \geqslant 0$ )

$$
\max _{q \in \mathbb{R}^{P}}\langle q, y\rangle-\frac{\lambda}{2}\|q\|^{2}-R^{*}\left(\Phi^{*} q\right)
$$

Note that for $\lambda>0$, there is a unique dual solution, denoted $q^{\star}(\lambda, y)$ (thanks to strong concavity). We also have from the primal-dual extremality relationship that for any primal solution $x^{\star}(\lambda, y)$ of $(\mathcal{P}(\lambda, y))$,

$$
\begin{equation*}
q^{\star}(p)=\frac{y-\Phi x^{\star}(p)}{\lambda} \quad \text { and } \quad \Phi^{*} q^{\star}(p) \in \partial R\left(x^{\star}(p)\right) \tag{4.2}
\end{equation*}
$$

While $(\mathcal{D}(0, y))$ is the dual of $(\mathcal{P}(0, y))$, it is important to realize that it is not the limit of $(\mathcal{D}(\lambda, y))$ in the sense that its set of dual solutions is in general not a singleton.

Lemma 3 hereafter singles out a specific dual optimal solution (sometimes called "minimum norm certificate") and defined by

\begin{equation*}
q_{0}(0, y)=\underset{q \in \mathbb{R}^{P}}{\operatorname{argmin}}\left\{\|q\|_{2}: \Phi^{*} q \in \partial R\left(x^{\star}(0, y)\right)\right\} \tag{4.3}
\end{equation*}
$$

The following two important lemmas ensure the convergence of the solutions to the primal and dual problems as $\lambda \rightarrow 0$ and as $\left\|y-y_{0}\right\| \rightarrow 0$.

Lemma 2 (Primal solution convergence). Assume that $x_{0}$ is the unique solution to $\left(\mathcal{P}\left(0, y_{0}\right)\right)$. For any sequence of parameters $p_{k}=\left(\lambda_{k}, y_{k}\right)$ with $\lambda_{k}>0$ such that

$$
\left(\frac{\left\|y_{k}-y_{0}\right\|^{2}}{\lambda_{k}}, \lambda_{k}\right) \longrightarrow(0,0)
$$

and any solution $x^{\star}\left(p_{k}\right)$ of $\left(\mathcal{P}\left(p_{k}\right)\right)$, we have $x^{\star}\left(p_{k}\right) \rightarrow x_{0}$.
Proof. Denote $x_{k}^{\star} \stackrel{\text { def. }}{=} x^{\star}\left(p_{k}\right)$. Since $\left\{x_{k}^{\star}\right\}_{k}$ is bounded, one can extract a (nonrelabelled for simplicity) converging subsequence $x_{k}^{\star} \rightarrow \bar{x}$. Optimality of $x_{k}^{\star}$ implies that

$$
\begin{equation*}
R\left(x_{k}^{\star}\right) \leqslant \frac{1}{2 \lambda_{k}}\left\|y_{k}-\Phi x_{k}^{\star}\right\|^{2}+R\left(x_{k}^{\star}\right) \leqslant \frac{1}{2 \lambda_{k}}\left\|y_{k}-y_{0}\right\|^{2}+R\left(x_{0}\right) \tag{4.4}
\end{equation*}
$$

Passing to the limit and using the hypothesis that $\frac{1}{\lambda_{k}}\left\|y_{k}-y_{0}\right\|^{2} \rightarrow 0$, we get

$$
\limsup _{k} R\left(x_{k}^{\star}\right) \leqslant R\left(x_{0}\right)
$$

On the other hand, lower semi-continuity of $R$ entails $\liminf _{k} R\left(x_{k}^{\star}\right) \geqslant R(\bar{x})$. Combining these two inequalities, we deduce that $R(\bar{x}) \leqslant R\left(x_{0}\right)$. Multiplying (4.4) by $\lambda_{k}$, one obtains

$$
\begin{equation*}
\lambda_{k} R\left(x_{k}^{\star}\right) \leqslant \frac{1}{2}\left\|y_{k}-\Phi x_{k}^{\star}\right\|^{2}+\lambda_{k} R\left(x_{k}^{\star}\right) \leqslant \frac{1}{2}\left\|y_{k}-y_{0}\right\|^{2}+\lambda_{k} R\left(x_{0}\right) \tag{4.5}
\end{equation*}
$$

Since $\lambda_{k} \rightarrow 0, R$ is non-negative and lsc, and $R\left(x_{k}^{\star}\right)$ are bounded, we have

$$
\begin{aligned}
\limsup _{k}\left(\lambda_{k} R\left(x_{k}^{\star}\right)\right) & \leqslant \lim _{k} \lambda_{k} \limsup _{k} R\left(x_{k}^{\star}\right)=0 \quad \text { and } \\
\underset{k}{\liminf }\left(\lambda_{k} R\left(x_{k}^{\star}\right)\right) & \geqslant \lim _{k} \lambda_{k} \liminf _{k} R\left(x_{k}^{\star}\right) \\
& \geqslant R(\bar{x}) \lim _{k} \lambda_{k}=0
\end{aligned}
$$

and thus $\lim _{k \rightarrow \infty}\left(\lambda_{k} R\left(x_{k}^{\star}\right)\right)=0$. Consequently, passing to the limit in (4.5) shows that $\left.\| y_{0}-\Phi \bar{x}\right) \|^{2} \leqslant 0$, i.e. $\bar{x}$ is a feasible point of $\left(\mathcal{P}\left(0, y_{0}\right)\right)$. Altogether, this shows that $\bar{x}$ is a solution of $\left(\mathcal{P}\left(0, y_{0}\right)\right)$, and by uniqueness of the minimizer, $\bar{x}=x_{0}$.

Lemma 3 (Dual solution convergence). For any sequence of parameters $p_{k}=$ $\left(\lambda_{k}, y_{k}\right)$ such that

$$
\left(\frac{\left\|y_{k}-y_{0}\right\|}{\lambda_{k}}, \lambda_{k}\right) \longrightarrow(0,0)
$$

we have $q^{\star}\left(p_{k}\right) \rightarrow q_{0}\left(0, y_{0}\right)$.
Proof. We show the convergence in two steps: (i) $q^{\star}\left(\lambda, y_{k}\right) \rightarrow q^{\star}\left(\lambda, y_{0}\right)$ for any fixed $\lambda>0$; (ii) $q^{\star}\left(\lambda_{k}, y_{0}\right) \rightarrow q_{0}\left(0, y_{0}\right)$. As far as (i) is concerned, we notice that
$q^{\star}(\lambda, y)=\operatorname{prox}_{R^{*} \circ \Phi^{*} / \lambda}(y / \lambda)$. Thus, by virtue of [48, Theorem 2.26], we conclude that $q^{\star}\left(\lambda, y_{k}\right) \rightarrow q^{\star}\left(\lambda, y_{0}\right)$. Let us now turn to (ii). Using the respective optimality of $q_{k}^{\star}=q^{\star}\left(\lambda_{k}, y_{0}\right)$ and $q_{0} \stackrel{\text { def. }}{=} q_{0}\left(0, y_{0}\right) \in \mathfrak{D}\left(0, y_{0}\right)$, one obtains

$$
\begin{align*}
-\left\langle q_{k}^{\star}, y_{0}\right\rangle+\frac{\lambda_{k}}{2}\left\|q_{k}^{\star}\right\|^{2}+R^{*}\left(\Phi^{*} q_{k}^{\star}\right) & \leqslant-\left\langle q_{0}, y_{0}\right\rangle+\frac{\lambda_{k}}{2}\left\|q_{0}\right\|^{2}+R^{*}\left(\Phi^{*} q_{0}\right) \\
& \leqslant-\left\langle q_{k}^{\star}, y_{0}\right\rangle+\frac{\lambda_{k}}{2}\left\|q_{0}\right\|^{2}+R^{*}\left(\Phi^{*} q_{k}^{\star}\right) \tag{4.6}
\end{align*}
$$

whence we get $\left\|q_{k}^{\star}\right\| \leqslant\left\|q_{0}\right\|$, which shows in particular that $\left\{q_{k}^{\star}\right\}_{k}$ is bounded. We can thus extract any converging subsequence (not relabelled for simplicity) $q_{k}^{\star} \rightarrow \bar{q}$. Passing to the limit in (4.6), using the fact that $R^{*}$ is lsc, one obtains

$$
-\left\langle\bar{q}, y_{0}\right\rangle+R^{*}\left(\Phi^{*} \bar{q}\right) \leqslant-\left\langle\bar{q}, y_{0}\right\rangle+\liminf _{k} R^{*}\left(\Phi^{*} q_{k}^{\star}\right) \leqslant-\left\langle q_{0}, y_{0}\right\rangle+R^{*}\left(\Phi^{*} q_{0}\right)
$$

which shows that $\bar{q} \in \mathfrak{D}\left(0, y_{0}\right)$. This together with the fact that $\left\|q_{k}^{\star}\right\| \leqslant\left\|q_{0}\right\|$ as we already saw, shows that $q_{k}^{\star}=q_{0}$ by uniqueness of $q_{0}$.
4.3. Sensitivity. We are now in position to state the main result of this section, which tracks the strata of $x^{\star}(p)$ in the regime where the perturbation $\|w\|=\left\|y-y_{0}\right\|$ is sufficiently small.

Theorem 3. Suppose that $x_{0}$ is the unique solution to $\left(\mathcal{P}\left(0, y_{0}\right)\right)$. Assume furthermore that $R$ is mirror-stratifiable with respect to the primal-dual stratifications $\left(\mathcal{M}, \mathcal{M}^{*}\right)$. Then there exists constants $\left(C_{0}, C_{1}\right)$ depending only on $x_{0}$ such that for all $p$ such that

$$
\begin{equation*}
\left\{p=(\lambda, y): C_{0}\left\|y-y_{0}\right\| \leqslant \lambda \leqslant C_{1}\right\} \tag{4.7}
\end{equation*}
$$

there exists a minimizer $x^{\star}(p)$ of $E(\cdot, p)$ localized as follows

$$
\begin{equation*}
M_{x_{0}} \leqslant M_{x^{\star}(p)} \leqslant \mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right) \quad \text { where } \quad u_{0} \stackrel{\text { def. }}{=} \Phi^{*} q_{0}\left(0, y_{0}\right) \tag{4.8}
\end{equation*}
$$

Proof. Under (4.7) with for instance $C_{1}$ small enough, one check that there exists $k$ large enough such that the regime required for $\left(y_{k}, \lambda_{k}\right)$ to apply Lemma 2 and 3 is attained. In turn, we have a converging primal-dual pair $\left(x^{\star}\left(p_{k}\right), \Phi^{*} q^{\star}\left(p_{k}\right)\right) \rightarrow$ $\left(x_{0}, u_{0}\right)$. One can then apply Theorem 1 to conclude.
5. Identification with Proximal Splitting Algorithms. Proximal splitting methods are algorithms designed to solve large-scale structured optimization and monotone inclusion problems, by evaluating various first-order quantities such as gradients, proximity operators, linear operators, all separately at various points in the course of iteration. Though they can show slow convergence each iteration has a cheap cost. We refer to e.g. $[3,5,17,47]$ for a comprehensive treatment and review.

Capitalizing on our identifiability result for mirror-stratifiable functions, we now instantiate its consequences on finite identification of proximal splitting algorithms. While existing results on finite identification strongly rely on partial smoothness around a non-degenerate cluster point $[33,40,41,39]$, we examine here intricate situations where neither of these assumptions holds.
5.1. Forward-Backward algorithm. The Forward-Backward (FB) splitting method [42] is probably the most well-known proximal splitting algorithm. In our context, it can be used to solve optimization problems with the additive "smooth + non-smooth" structure of the form

$$
\begin{equation*}
\min _{x \in \mathbb{R}^{N}} f(x)+R(x) \tag{5.1}
\end{equation*}
$$

where $f \in C^{1}\left(\mathbb{R}^{N}\right)$ is convex with $L$-Lipschitz gradient, and $R$ is a proper lsc and convex function. We assume that $\operatorname{Argmin}(f+R) \neq \emptyset$. The FB iteration in relaxed form reads [16]

$$
\begin{equation*}
x_{k+1}=\left(1-\tau_{k}\right) x_{k}+\tau_{k} \operatorname{prox}_{\gamma_{k} R}\left(x_{k}-\gamma_{k} \nabla f\left(x_{k}\right)\right), \tag{5.2}
\end{equation*}
$$

with $\left.\gamma_{k} \in\right] 0,2 / L\left[\right.$ and $\left.\left.\tau_{k} \in\right] 0,1\right]$, where $\operatorname{prox}_{\gamma R}, \gamma>0$, is the proximal mapping of $R$,

$$
\begin{equation*}
\operatorname{prox}_{\gamma R}(x) \stackrel{\text { def. }}{=} \underset{z \in \mathbb{R}^{N}}{\operatorname{argmin}} \frac{1}{2}\|z-x\|^{2}+\gamma R(z) \tag{5.3}
\end{equation*}
$$

Different variants of FB method were studied, and a popular trend is the inertial schemes which aim at speeding up the convergence (see [46, 4], and the sequenceconvergence version as proved recently in [14]).

Under the non-degeneracy assumption $-\nabla f\left(x^{\star}\right) \in \operatorname{ri}\left(\partial R\left(x^{\star}\right)\right)$, it was shown in [40] that FB and its inertial variants correctly identify the active manifold in finitely many iterations, and then enter a local linear convergence regime. These results encompass many special cases such as those studied in [32, 8, 51]. Apart of this non-degenerate case, we establish now the general identification of enlarged strata.

THEOREM 4. Consider the FB iteration (5.2) to solve (5.1) with $0<\inf _{k} \gamma_{k} \leqslant$ $\sup _{k} \gamma_{k}<2 / L$ and $\inf _{k} \tau_{k}>0$. Then $x_{k}$ converges to $x^{\star} \in \operatorname{Argmin}(f+R)$. Assume that $R$ is also mirror-stratifiable with respect to $\left(\mathcal{M}, \mathcal{M}^{*}\right)$, then for $k$ large enough,

$$
M_{x^{\star}} \leqslant M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{u^{\star}}^{*}\right) \quad \text { where } \quad u^{\star} \stackrel{\text { def. }}{=}-\nabla f\left(x^{\star}\right)
$$

Proof. Convergence of the sequence $\left(x_{k}\right)_{k \in \mathbb{N}}$ to $x^{\star}$ is obtained from [16, Corollary 6.5]. Moreover, since the proximal mapping is the resolvent of the subdifferential, (5.2) is equivalent to the monotone inclusion

$$
u_{k+1} \stackrel{\text { def. }}{=} \frac{x_{k}-v_{k+1}}{\gamma_{k}}-\nabla f\left(x_{k}\right) \in \partial R\left(v_{k+1}\right)
$$

where $v_{k+1} \stackrel{\text { def. }}{=} \frac{x_{k+1}-x_{k}}{\tau_{k}}+x_{k}$. In turn, with the conditions $\inf _{k} \tau_{k}>0$ and $\inf _{k} \gamma_{k}>0$, and continuity of $\stackrel{\tau_{k}}{\nabla} f$, we have $v_{k} \rightarrow x^{\star}$ and thus $u_{k} \rightarrow-\nabla f\left(x^{\star}\right) \in \partial R\left(x^{\star}\right)$. It then remains to apply Theorem 1 to $\left(v_{k}, u_{k}\right)$ and $R$ to conclude.

It can be easily shown that Theorem 4 holds for several extensions of the iterateconvergent version of FISTA [14]. We omit the details here for the sake of brevity.

We rather take a closer look to the case when the FB scheme (5.2) to solve $(\mathcal{P}(\lambda, y))$ (see also (4.1)) for $\lambda>0$. Putting together Theorem 3 and 4 , we obtain the following localization result depending only on the data to estimate $x_{0}$ assuming that the noise level $\left\|y-y_{0}\right\|$ is small enough.

Proposition 4. Under the assumptions of Theorem 3, consider the FB iteration (5.2) to solve $(\mathcal{P}(\lambda, y))$ with $0<\inf _{k} \gamma_{k} \leqslant \sup _{k} \gamma_{k}<2 \lambda /\|\Phi\|^{2}$ and $\inf _{k} \tau_{k}>0$. Then, for $k$ large enough, the iterates $x_{k}$ satisfy

$$
M_{x_{0}} \leqslant M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right) \quad \text { where } \quad u_{0} \stackrel{\text { def. }}{=} \Phi^{*} q\left(0, y_{0}\right)
$$

with $q\left(0, y_{0}\right)$ from (4.3).
Proof. To lighten notation, denote $p=(\lambda, y)$. As in Theorem 4, we have $x_{k} \rightarrow$ $x^{\star}(p)$ a minimizer of $(\mathcal{P}(\lambda, y))$. Thus we get

$$
M_{x_{0}} \leqslant M_{x^{\star}(p)} \leqslant M_{x_{k}},
$$

where the first inequality comes from Theorem 3 and the second one from Theorem 4. This gives the first inequality in the localization result.

Moreover, in the special case at hand $\partial R\left(x^{\star}(p)\right) \ni-\nabla f\left(x^{\star}(p)\right)=\Phi^{*} q^{\star}(p) \rightarrow u_{0}$ as $p \rightarrow\left(0, y_{0}\right)$, where we invoked (4.2). It then follows from (2.9) and the fact that $\mathcal{J}_{R^{*}}$ is decreasing for the relation $\leqslant$, that

$$
M_{u_{0}}^{*} \leqslant M_{-\nabla f\left(x^{\star}(p)\right)}^{*} \Longleftrightarrow \mathcal{J}_{R^{*}}\left(M_{-\nabla f\left(x^{\star}(p)\right)}^{*}\right) \leqslant \mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right)
$$

Using once again Theorem 4, we get

$$
M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{-\nabla f\left(x^{\star}(p)\right)}^{*}\right) \leqslant \mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right)
$$

which yields the second desired inequality.
Though the iterates $x_{k}$ of FB do not converge to $x_{0}$, this proposition tells us that the iterates identify an enlarged stratum associated to $x_{0}$. This is an appealing feature from a practical perspective, since one can often make some prior assumption on the sought after vector $x_{0}$, such as for instance sparsity or low-rank properties, as we have illustrated in the numerical experiments of Section 6.
5.2. Douglas-Rachford Splitting Algorithm. The Douglas-Rachford (DR) method [42] is another popular splitting method designed to minimize convex objectives having the additive "non-smooth + non-smooth" structure of the form

$$
\begin{equation*}
\min _{x \in \mathbb{R}^{N}} f(x)+g(x) \tag{5.4}
\end{equation*}
$$

with $f$ and $g$ be proper lsc and convex functions such that $\operatorname{ri}(\operatorname{dom}(f)) \cap \operatorname{ri}(\operatorname{dom}(g)) \neq \emptyset$ and $\operatorname{Argmin}(f+g) \neq \emptyset$. The DR scheme reads

$$
\left\{\begin{align*}
v_{k+1} & =\operatorname{prox}_{\gamma f}\left(2 x_{k}-z_{k}\right)  \tag{5.5}\\
z_{k+1} & =z_{k}+\tau_{k}\left(v_{k+1}-x_{k}\right) \\
x_{k+1} & =\operatorname{prox}_{\gamma g}\left(z_{k+1}\right)
\end{align*}\right.
$$

where $\left.\gamma>0, \tau_{k} \in\right] 0,2$ [ is a relaxation parameter. By definition, the DR method is not symmetric with respect to the order of the functions $f$ and/or $g$. Nevertheless, all of our statements throughout hold true, with obvious adaptations, when the order of $f$ and $g$ is reversed in (5.5).

It has been shown in [41] that under appropriate non-degeneracy assumptions, the DR identifies the active manifolds in finite time, and then show a local linear regime.These results unify all those that were established in the literature for special problems, see e.g. [20] for linearly constrained $\ell_{1}$-minimization, [6] for quadratic or linear programs, [2] for feasibility with two subspaces. Under mirror-stratifiability of $f$ or $g$, we get the following enlarged identification result.

THEOREM 5. Consider the $D R$ iteration (5.5) to solve (5.4) with $\left.\tau_{k} \in\right] 0,2[$ such that $\sum_{k \in \mathbb{N}} \tau_{k}\left(2-\tau_{k}\right)=+\infty$. Then $z_{k}$ converges to a fixed point $z^{\star}$ with $x^{\star}=\operatorname{prox}_{\gamma g}\left(z^{\star}\right) \in \operatorname{Argmin}(f+g)$, and $x_{k}$ and $v_{k}$ both converge to $x^{\star}$. Introducing $u^{\star}=\frac{z^{\star}-x^{\star}}{\gamma}$, we have furthermore:
(i) If $g$ is also mirror-stratifiable with respect to the primal-dual stratifications $\left(M^{g}, M^{g^{*}}\right)$, then for $k$ large enough

$$
M_{x^{\star}}^{g} \leqslant M_{x_{k}}^{g} \leqslant \mathcal{J}_{g^{*}}\left(M_{u^{\star}}^{g^{*}}\right) .
$$

(ii) If $f$ is also mirror-stratifiable with respect to the primal-dual stratifications $\left(M^{f}, M^{f^{*}}\right)$, then for $k$ large enough

$$
M_{x^{\star}}^{f} \leqslant M_{v_{k}}^{f} \leqslant \mathcal{J}_{f^{*}}\left(M_{-u^{\star}}^{f^{*}}\right) .
$$

Proof. Under the prescribed choice of $\tau_{k}$, convergence of $z_{k}$ is ensured by virtue of [16, Corollary 5.2]. By non-expansiveness of the proximal mapping, and as we are in finite dimension, we also obtain convergence of $x_{k}$ and $v_{k}$ to $x^{\star}$. To prove (i), not that the update of $x_{k}$ in (5.5) is equivalent to the monotone inclusion

$$
\begin{equation*}
u_{k} \stackrel{\text { def. }}{=} \frac{z_{k}-x_{k}}{\gamma} \in \partial g\left(x_{k}\right) \tag{5.6}
\end{equation*}
$$

Since $\left(x_{k}, u_{k}\right) \rightarrow\left(x^{\star}, u^{\star}\right)$, we conclude about (i) by invoking Theorem 1. Similarly, we note that the update of $v_{k}$ in (5.5) is equivalent to

$$
\begin{equation*}
w_{k} \stackrel{\text { def. }}{=} \frac{2 x_{k}-z_{k}-v_{k+1}}{\gamma} \in \partial f\left(v_{k+1}\right) \tag{5.7}
\end{equation*}
$$

Using that $\left(v_{k}, w_{k}\right) \rightarrow\left(x^{\star},-u^{\star}\right)$ and applying Theorem 1 we get (ii).
In the same vein as for FB in the previous section, we now turn to applying the DR scheme (5.5) to solve $(\mathcal{P}(\lambda, y))$ by setting in (5.4) $f(x)=\frac{1}{2 \lambda}\|y-\Phi x\|^{2}$ and $g(x)=R(x)$. Putting Theorem 3 and 5-(i) together, we obtain the following analogue to Proposition 4.

Proposition 5. Under the assumptions of Theorem 3, consider the DR iteration (5.5) to solve $(\mathcal{P}(\lambda, y))$ with $\gamma>0$ and $\left.\tau_{k} \in\right] 0,2\left[\right.$ such that $\sum_{k \in \mathbb{N}} \tau_{k}\left(2-\tau_{k}\right)=+\infty$. Then, for $k$ large enough, the $D R$ iterates satisfy

$$
M_{x_{0}} \leqslant M_{x_{k}} \leqslant \mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right) \quad \text { where } \quad u_{0} \stackrel{\text { def. }}{=} \Phi^{*} q\left(0, y_{0}\right)
$$

Proof. The proof follows the same reasoning as that of Proposition 4 by additionally observing (recall the notation in the proof of Theorem 5) that from (5.6)-(5.7), we have $u^{\star}(p)=-\nabla f\left(x^{\star}(p)\right)=\Phi^{*} q^{\star}(p) \in \partial R\left(x^{\star}(p)\right)$.
6. Numerical Illustrations. In this section, we numerically illustrate our theoretical results on sensitivity and finite identification in the context of regularized inverse problems. We adopt the same two "compressed sensing" scenarios described in Section 1.1. The dimension $R_{0}\left(x_{0}\right)=\operatorname{dim}\left(M_{x_{0}}\right)$ of the strata associated to to $x_{0}$ is measured as $R_{0}=\|\cdot\|_{0}$ (resp. $R_{0}=$ rank) for the $\ell_{1}$ (resp. nuclear) norm regularization.

Strata sensitivity. We first illustrate the relevance of the strata sensitivity Theorem 3 by studying the dimension of the largest possible active stratum $\mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right)$ (in fact its closure). $u_{0}$ is computed from $x_{0}$ as the solution of the convex optimization problem (4.3), so that we know the maximum complexity index excess predicted by Theorem 3, i.e.

$$
\delta^{\star}\left(x_{0}\right) \stackrel{\text { def. }}{=} \operatorname{dim}\left(\mathcal{J}_{R^{*}}\left(M_{u_{0}}^{*}\right)\right)-\operatorname{dim}\left(M_{x_{0}}\right)
$$

For each given $\delta$, and among the 1000 randomly generated replications of $\left(x_{0}, \Phi\right)$, we compute the proportion of $x_{0}$ such that it is is the unique solution of $\left(\mathcal{P}\left(0, y_{0}\right)\right)$ and $\delta^{\star}\left(x_{0}\right) \leqslant \delta$. These proportions are displayed in Figure 6.1 as a function of the input complexity index $R_{0}\left(x_{0}\right)=\operatorname{dim}\left(M_{x_{0}}\right)$. Obviously, for each fixed $R_{0}\left(x_{0}\right)$, the proportion is an increasing function of $\delta$.

The blue curve corresponds to $\delta=0$, i.e. the proportion of vectors $x_{0}$ whose active stratum $M_{x_{0}}$ can be recovered stably under small noise perturbation by solving $(\mathcal{P}(\lambda, y))$ for $\lambda$ chosen according to (4.7); see for instance [22]. At the opposite extreme, the red curve corresponds to the largest achievable value $\delta$, for which $M_{x_{0}}$ can be highly unstable to perturbations. The intermediate curves, i.e. from blue to red, illustrate and quantify the typical tradeoff observed in practice: one can allow for more complex input vectors (i.e. larger values of $R_{0}\left(x_{0}\right)$ ) at the expense of a higher instability in the recovery of the active stratum $M_{x_{0}}$ in presence of even small noise.

Forward-Backward finite identification. We now numerically illustrate the finite identification property of the FB splitting scheme as predicted by Theorem 4 and Proposition 4. We remain under the same compressed sensing setting as before. The randomly generated replications of $x_{0}$ are such that $R_{0}\left(x_{0}\right)=10$ for $R=\|\cdot\|_{1}$ and to 4 for $R=\|\cdot\|_{*}$.

The evolution of the complexity index $R_{0}\left(x_{k}\right)$ of the FB iterate $x_{k}$ is shown
in Figure 6.2. The blue lines correspond to several trajectories (the bold one is the average trajectory), each for a randomly generated instance of $x_{0}$ such that $\delta^{\star}\left(x_{0}\right)=0$, i.e. those vectors whose active strata $M_{x_{0}}$ can be exactly recovered under small perturbations. Thus, the iterates identify $M_{x_{0}}$ in finite time. The red lines (the bold one is the average trajectory) are those for which $\delta^{\star}\left(x_{0}\right)=\delta>0$. As anticipated by our theoretical results, the iterates identify a stratum strictly larger that $M_{x_{0}}$.

## Appendix A. Proofs of the results in Section 2.

Proof of Proposition 1. Let us first prove (2.3) by double inclusion. Let $M \in$ $\mathcal{A}_{x}(\mathcal{M})$, that is, $x \in \operatorname{cl}(M)$. Since $x \in M_{x}$, the intersection $\operatorname{cl}(M) \cap M_{x}$ contains $x$ and thus is nonempty. We deduce from (2.1) that $M \geqslant M_{x}$. Conversely, if $M \geqslant M_{x}$, then $x \in M_{x} \subset \operatorname{cl}(M)$ and therefore $M \in \mathcal{A}_{x}(\mathcal{M})$.

Let us turn to (2.4). Observe that Definition 2 can be read as follows: $M \in$ $\mathcal{A}_{x}(\mathcal{M})$ if and only if $d(x, \operatorname{cl}(M))=0$. Since there is a finite number of strata in the stratification, let us consider $\delta$ the minimum of the nonzero distances $d\left(x, \operatorname{cl}\left(M^{\prime}\right)\right)$ for $M^{\prime}$ not active. For all $x^{\prime}$ in the open ball of radius $\delta$ and of center $x$, we have

$$
d\left(x, \operatorname{cl}\left(M_{x^{\prime}}\right)\right) \leqslant\left\|x-x^{\prime}\right\|<\delta \quad \Longleftrightarrow \quad d\left(x, \operatorname{cl}\left(M_{x^{\prime}}\right)\right)=0
$$

This shows that the set of these strata $M_{x^{\prime}}$ indeed coincides with $\mathcal{A}_{x}(\mathcal{M})$.
Proof of Proposition 2. From classical convex analysis calculus rules, we get for all $x \in \operatorname{dom} R$

$$
\partial R(x)=\operatorname{conv}\left\{a_{i}: i \in I^{\max }(x)\right\}+\operatorname{cone}\left\{a_{i}: i \in I^{\text {feas }}(x)\right\}
$$

By definition of $M_{I}$, the relative interior of $\partial R(x)$ is constant over a stratum: for all $x \in M_{I}\left(\right.$ with $\left.M_{I} \neq \emptyset\right)$

$$
\begin{aligned}
\operatorname{ri}(\partial R(x)) & =\operatorname{ri}\left(\operatorname{conv}\left\{a_{i}: i \in I^{\max }(x)\right\}+\operatorname{cone}\left\{a_{i}: i \in I^{\text {feas }}(x)\right\}\right) \\
& =\operatorname{ri}\left(\operatorname{conv}\left\{a_{i}: i \in I^{\max }(x)\right\}\right)+\operatorname{ri}\left(\operatorname{cone}\left\{a_{i}: i \in I^{\text {feas }}(x)\right\}\right) \\
& =\operatorname{ri}\left(\operatorname{conv}\left\{a_{i}: i \in I^{\max }\right\}\right)+\operatorname{ri}\left(\operatorname{cone}\left\{a_{i}: i \in I^{\text {feas }}\right\}\right)
\end{aligned}
$$

This yields $\mathcal{J}_{R}\left(M_{I}\right)=M_{I}^{*}$. Conversely we have $\partial R^{*}(u)=\{x: u \in \partial R(x)\}$, which entails for all $u \in M_{I}^{*}$

$$
\partial R^{*}(u)=\left\{x: I^{\mathrm{max}}(x) \cap I^{\mathrm{feas}}(x) \supset I\right\}
$$

and therefore $\operatorname{ri}\left(\partial R^{*}(u)\right)=M_{I}$. This gives $\mathcal{J}_{R^{*}}\left(M_{I}^{*}\right)=M_{I}$, which proves item (i) of Definition 4.

To show (ii) of Definition 4, we make the following observation:

$$
\begin{aligned}
M_{I} \leqslant M_{I^{\prime}} & \Longleftrightarrow \text { any } x \in M_{I} \text { lies in } \operatorname{cl}\left(M_{I^{\prime}}\right) \\
& \Longleftrightarrow I^{\max }=I^{\max }(x) \supset\left(I^{\prime}\right)^{\max } \quad \text { and } \quad I^{\text {feas }}=I^{\text {feas }}(x) \supset\left(I^{\prime}\right)^{\text {feas }} \\
& \Longleftrightarrow I \supset I^{\prime} .
\end{aligned}
$$

On the other hand we have

$$
\begin{aligned}
\operatorname{cl}\left(\mathcal{J}_{R}\left(M_{I}\right)\right) & \left.\supset \operatorname{cl}\left(\operatorname{ri}\left(\operatorname{conv}\left\{a_{i}: i \in I^{\max }\right\}\right)\right)+\operatorname{cl}\left(\text { ri cone }\left\{a_{i}: i \in I^{\text {feas }}\right\}\right)\right) \\
& =\operatorname{conv}\left\{a_{i}: i \in I^{\max }\right\}+\operatorname{cone}\left\{a_{i}: i \in I^{\text {feas }}\right\}
\end{aligned}
$$

Note that the first $\supset$ is in fact $=$ because $\operatorname{conv}\left\{a_{i}: i \in I^{\max }\right\}$ is compact. Using unique decomposition of a polyhedron, we can write,

$$
\mathcal{J}_{R}\left(M_{I}\right) \geqslant \mathcal{J}_{R}\left(M_{I^{\prime}}\right) \Longleftrightarrow \operatorname{cl}\left(\mathcal{J}_{R}\left(M_{I}\right)\right) \supset \mathcal{J}_{R}\left(M_{I^{\prime}}\right) \Longleftrightarrow I \supset I^{\prime}
$$

which ends the proof.
Proof of Proposition 3. The proof builds upon a key result stated in [19]. Theorem 4.6(i) in [19] asserts that the collection $\left\{\sigma^{-1}\left(M^{\text {sym }}\right): M \in \mathcal{M}\right\}$ forms a smooth stratification of $\operatorname{dom}(R)$ with the desired properties. The fact that spectral functions are mirror-stratifiable follows from the polyhedral case with the help of Theorem 4.6(iv) in [19], which states that

$$
\mathcal{J}_{R}\left(\sigma^{-1}\left(M^{\mathrm{sym}}\right)\right)=\sigma^{-1}\left(\mathcal{J}_{R^{\text {sym }}}\left(M^{\mathrm{sym}}\right)\right)
$$

together with continuity of the singular value mapping $\sigma$.
