## Motivations

- Propagation of the electromagnetic field resulting from a lightning strike in and near a composite material. In particular, we focus on composite material of an aircraft.
- The latest aircraft Airbus A350 and Boeing B757 are made of advanced materials such that composites, titanium and advanced aluminium.
- A revolutionary material. The advantages of composite material : the weight. It is lighter than the metal and it is a strong and durable material, insensitive to corrosion.

## Motivations

- Traditionally, the old aircraft's fuselage was made of aluminum. Aluminium conducts electricity one thousand more than composite. Composite consists in carbon fibers enclosed in epoxy resin, and therefore it is the resin that causes the composite to be less conductive than aluminium.
- A carbon fuselage is not a conductive as one made of metal. Modern aircrafts have seen also the increasing reliance on electronic avionics systems instead of mechanical controls and electromechanical instrumentation. For these reasons, aircraft manufacturers are very sensitive to lightning protection and pay special attention to aircraft certification through testing and analysis.

## Modeling

- It is composed by air above composite material. Composite consists of electrical conducting carbon fibers distributed in periodic inclusion in epoxy resin. We study the behavior of the EM field in this domain.

- $\widetilde{P}$ is the domain containing the material. And the periodic cell

- $e$ is the lateral size of the basic cell of the periodic microstructure of the material.


## Modeling

- The propagation of this field in the composite will be modeled by Time-Harmonic Maxwell's equations.

- $\mu_{0}$ the permeability of the vacuum,
- $\varepsilon=\varepsilon_{0} \epsilon^{\star}$ the permittivity and $\epsilon^{\star}$ the relative permittivity with $\epsilon^{\star}=\varepsilon_{a}$ in the air, $\varepsilon_{r}$ in the resin, $\varepsilon_{c}$ in the carbon.

## 3D model

- We consider that carbon fibers are conductive but not perfect conductor, $\sigma_{c}=40000$ S. $\mathrm{m}^{-1}$.
- Epoxy resin is not conductive. In our model, we doped the resin that is to say we added black carbon or graphene. Then the electrical conductivity of the resin increases from $10^{-12}$ to $10^{-3} \mathrm{~S} . \mathrm{m}^{-1}$.
- During the electrical solicitation of a lightning strike, the air becomes suddenly conductive. The ionized channel of a lightning strike is very conductive, we take $\sigma_{c}=4200 \mathrm{~S} . \mathrm{m}^{-1}$.

## Homogenized problem

- Homogenization has been developed for periodic structures. The aim of Homogenization theory is to describe the average properties of composite material at the macroscopic level, taking into account their microscopic arrangement. ([A.Bensoussan, J. L.Lions, G.Papanicolaou], [D.Cioranescu et P.Donato], E.Sanchez-Palencia,...)



## Periodic Homogenization

- The macroscopic scale, which corresponds to the scale of observation is represented by the variable $x$. The microscopic scale is the characteristic scale of the environment, it corresponds to the size of heterogeneities. The ratio between these two typical scales is denoted $\varepsilon$, where $\varepsilon$ is a small parameter. The variable describing penomena on a microscopic scale is $\frac{\chi}{\varepsilon}$.
- In our problem the carbon fibers are distributed periodically in the resin. The size of the period, composed by carbon fiber and resin, is small compared to the size of the plate, we denote $\varepsilon$ their ratio.



## Periodic Homogenization

- For models describing phenomena at very small length scales, the discretization to perform numerical simulation should be of smaller length in comparison to the length scale of the model. The computational cost of such simulation is very high. Sometimes, even impossible. Homogenization can help approximate the solutions to the Microscopic models.

## We non-dimensionalize the problem

- We propose a rescaling of the system, we consider a set of characteristic sizes related to our problem: $\bar{\omega}$ the characteristic pulsation, $\bar{\sigma}$ the characteristic electric conductivity, $\bar{E}$ the characteristic electric magnitude and the characteristic thickness of the plate $\bar{L}$. Physical factors are then rewritten using those values. We obtain a new set of dimensionless and unitless variables and fields in which the system is rewritten. With the dimensionless variables: $\mathbf{x}=(x, y, z)$ with $x=\frac{\widetilde{x}}{\bar{L}}, y=\frac{\widetilde{y}}{\bar{L}}$ and $z=\frac{\widetilde{z}}{\bar{L}}$

- where $\bar{\omega} \mu_{0} \frac{\bar{L}}{\bar{E}} \overline{H_{d}}$ being order 1 with the characteristic magnetic field $\overline{H_{d}}=\frac{I}{2 \pi r}, I=200 \mathrm{kA}$ is the current density and r the radius of the lightning, and the characteristic electric field $\bar{E}=20 \mathrm{kV} / \mathrm{m}$.
- The characteristic thickness of the plate $\bar{L}$ is about $10^{-3} \mathrm{~m}$ and the size of the basic cell $e$ is about $10^{-5} \mathrm{~m}$. We define the ratio $\frac{e}{\bar{L}}$ equals a small parameter $\varepsilon$ :

## System into dimensionless variables

- Concerning the characteristic electric conductivity it seems to be reasonable to take for $\bar{\sigma}$ the value of the effective electric conductivity of the composite material.
- The effective longitudinal electric conductivity, (the arithmetic average), is expressed by the equation:

where $f_{c}$ is the volume fraction of the carbon fiber.

- The effective transverse electric conductivity, (the harmonic average), is expressed by

- In our study we consider the case for $\bar{\omega}=10^{6}$ rad. $\mathrm{s}^{-1}$, which corresponds to the air ionized, a resin doped and the effective longitudinal electric conductivity of the carbon fibers.

## Existence and unity of the solution

- $a^{\varepsilon, \eta}$ is not coercive, it is necessary to regularize it by adding terms involving the divergence of $E^{\varepsilon}$ in $\Omega_{a}^{\varepsilon}, \Omega_{r}^{\varepsilon}$ and $\Omega_{c}^{\varepsilon}$, since the continuity of the divergence is broken through the interfaces $\partial \Omega_{a}^{\varepsilon}$, $\partial \Omega_{r}^{\varepsilon}$ and $\partial \Omega_{c}^{\varepsilon}$.
- we define the regularized formulation of problem :

## Mathematical analysis of the model

## Existence and unity of the solution

- For any $\varepsilon>0$ and any $\eta \geq 0$, sesquilinear form $a_{R}^{\varepsilon, \eta}(.,$.$) is$ continuous over $\mathbf{X}^{\varepsilon}(\Omega)$ thanks to the continuity conditions. It is also coercive thanks to this proposition :


## Proposition

For any $\varepsilon>0$, for any $\eta \geq 0$ and for any $s>0$, there exists a positive constant $\omega_{0}$ which does not depend on $\varepsilon$ and such that for all $\omega \in\left(0, \omega_{0}\right)$, there exists a positive constant $\mathcal{C}_{0}$ depending on $\varepsilon_{r}, \varepsilon_{c}, s, \omega$ but not on $\varepsilon$ such that:

## Mathematical analysis of the model

## Existence and unity of the solution

- The sesquilinear form $a_{R}^{\varepsilon, \eta}$ is continuous, bounded, coercive thanks to the above proposition and the right hand side is continuous on $X^{\varepsilon}(\Omega)$, then regularized problem has a unique solution in $X^{\varepsilon}(\Omega)$ thanks to the Lax-Milgram Lemma.
- The problems are equivalents for an appropriate choice of $s$, then the terms s.div disappear.

## Part II : Homogenization

## Homogenized problem

- We use two methods of homogenization : an asymptotic analysis and the two-scale convergence, as $\varepsilon$ goes to 0 , which gives a rigourous justification of the homogenization result.
- We study the following equation for $\Sigma_{a}^{\varepsilon}=\varepsilon, \Sigma_{r}^{\varepsilon}=\varepsilon^{4}$ and $\Sigma_{c}^{\varepsilon}=1$ and $\eta=5$

## Asymptotic expansion

- If $x$ and $y=\frac{x}{\varepsilon}$ denote, respectively, the macroscopic and microscopic variables, the asymptotic expansion method consists in approaching the unknown $E^{\varepsilon}$ by the series, and resolve the new problem in $\Omega \times \mathcal{Z}$.:

+\ldots)=0 .

- $\varepsilon$ is small, $\varepsilon^{i}$ can be neglected, then we extract a cascade of equations

## Asymptotic expansion

- with the divergence equation

\nabla_{\mathbf{y}} \cdot\left(i \omega \mathbf{1}_{C}(\mathbf{y}) E_{0}(\mathbf{x}, \mathbf{y})\right)=0, \tag{26}
\end{equation*}

- and the boundary conditions

- Multiplying the first equation by $E_{0}$ and integrating by parts over $\mathcal{Z}$ leads to

## Homogenization

## Two-scale convergence

- We show rigorously with two-scale convergence that the solution of problem converge to the solution of the homogenized problem when $\varepsilon$ goes to 0 .
- Two-scale convergence was developed by G Allaire, G.Nguetseng


## Homogenization

- The main theorem


## Théorème

(Nguetseng). Let $u^{\varepsilon}(\mathbf{x}) \in \mathbf{L}^{2}(\Omega)$. Suppose there exists a constant $c>0$ such that for all $\varepsilon$

\left\|u^{\varepsilon}\right\|_{L^{2}(\Omega)} \leq c . \tag{32}
\end{equation*}

- Then there exists a subsequence of $\varepsilon$ (still denoted $u^{\varepsilon}$ ) and $u_{0}(\mathbf{x}, \mathbf{y}) \in \mathbf{L}^{2}\left(\Omega, \mathbf{L}_{\#}^{2}(\mathcal{Z})\right)$ such that:

u^{\varepsilon}(\mathbf{x}) \text { two-scale converges to } u_{0}(\mathbf{x}, \mathbf{y}) \text {. } \tag{33}
\end{equation*}

- we have for all $v(\mathbf{x}) \in C_{0}(\bar{\Omega})$ and all $w(\mathbf{y}) \in \mathbf{L}_{\#}^{2}(\mathcal{Z})$

\lim _{\varepsilon \rightarrow 0} & \int_{\Omega} u^{\varepsilon}(\mathbf{x}) \cdot v(\mathbf{x}) w\left(\frac{\mathbf{x}}{\varepsilon}\right) d \mathbf{x}  \tag{34}\\
& =\int_{\Omega} \int_{\mathcal{Z}} u_{0}(\mathbf{x}, \mathbf{y}) \cdot v(\mathbf{x}) w(\mathbf{y}) d \mathbf{x} d \mathbf{y} .
\end{align*}

(Estimate) For any $\varepsilon>0$, for any $\eta \geq 0$, there exists a positive constant $\omega_{0}$ which does not depend on $\varepsilon$ and such that for all $\omega \in\left(0, \omega_{0}\right)$,

## Homogenization

## Théorème

Under assumptions of Theorem Estimate, sequence $E^{\varepsilon}$ solution of the initial problem, converges to $E(\mathbf{x}) \in \mathbf{L}^{2}(\Omega)$ which is the unique solution of the homogenized problem:

with $\theta_{1}=\int_{\mathcal{Z}} \operatorname{Id}+\nabla_{\boldsymbol{y}} \chi(\boldsymbol{y}) d \mathbf{y}$ and $\theta_{2}=\int_{\mathcal{Z}} \mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\boldsymbol{y}} \chi(\boldsymbol{y})\right) d \mathbf{y}$. And where the scalar function $\chi$ is the unique solution, up to an additive constant in the Hilbert space of $\mathcal{Z}$ periodic functions $H_{\#}^{1}(\mathcal{Z})$, of

where $[f]$ is the jump across the surface of $\partial \Omega_{C}, n_{j}, j=\{1,2,3\}$ is the proiection on the axis e: of the normal of $\partial \Omega$

- Step 1: Two-scale convergence. Due to the estimate, $E^{\varepsilon}$ is bounded in $\mathrm{L}^{2}(\Omega)$. Hence, up to a subsequence, $E^{\varepsilon}$ two-scale converges to $E_{0}(\mathbf{x}, \mathbf{y})$ belonging to $\mathbf{L}^{2}\left(\Omega, \mathbf{L}_{\#}^{2}(\mathcal{Z})\right)$. That means for any $V(\mathbf{x}, \mathbf{y}) \in \mathbf{C}_{0}^{1}\left(\Omega, \mathbf{C}_{\#}^{1}(\mathcal{Z})\right)$, we have:

& \left.+i \omega\left(\mathbf{1}_{C}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)+\varepsilon^{4} \mathbf{1}_{R}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)\right) \mathbf{1}_{\{y<0\}}+\varepsilon \mathbf{1}_{\{y>0\}}\right] E^{\varepsilon}(\mathbf{x}) \cdot V^{\varepsilon}\left(\mathbf{x}, \frac{\mathbf{x}}{\varepsilon}\right) d \mathbf{x} \\
& =-i \omega \int_{\Gamma_{d}} H_{d} \times e_{2} \cdot\left(e_{2} \times V\left(x, 1, z, \xi, \frac{1}{\varepsilon}, \zeta\right)\right) \times e_{2} d \sigma \tag{40}

- Now we multiply (40) by $\varepsilon^{2}$ and we pass to the two-scale limit, applying Theorem (Nguetseng) we obtain:

- The divergence equation is multiplied with $V\left(\mathbf{x}, \frac{\mathbf{x}}{\varepsilon}\right)=\varepsilon v(\mathbf{x}) \psi\left(\frac{x}{\varepsilon}\right)$, where $v \in \mathbf{C}_{0}^{1}(\Omega)$ and $\psi \in \mathbf{H}_{\#}^{1}(\mathcal{Z})$. Theorem Nguetseng and integration by parts yields for all $\psi \in \mathbf{H}_{\#}^{1}(\mathcal{Z})$ and $v \in \mathbf{C}_{0}^{1}(\Omega)$

& \lim _{\varepsilon \rightarrow 0} \int_{\Omega} \nabla \cdot\left\{-\omega^{2} \varepsilon^{5} k(\epsilon) E^{\varepsilon}(\mathbf{x})+i \omega\left[\left(\mathbf{1}_{C}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)+\varepsilon^{4} \mathbf{1}_{R}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)\right) \mathbf{1}_{\{y<0\}}+\varepsilon \mathbf{1}_{\{y>0\}}\right] E\right. \\
& =-\lim _{\varepsilon \rightarrow 0} \int_{\Omega}\left\{-\omega^{2} \varepsilon^{5} k(\epsilon) E^{\varepsilon}(\mathbf{x})+i \omega\left[\mathbf{1}_{C}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)+\varepsilon^{4} \mathbf{1}_{R}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)\right) \mathbf{1}_{\{y<0\}}\right. \\
& \left.\left.+\varepsilon \mathbf{1}_{\{y>0\}}\right] E^{\varepsilon}\right\} \cdot\left(\varepsilon \nabla v(\mathbf{x}) \psi\left(\frac{\mathbf{x}}{\varepsilon}\right)+v(\mathbf{x}) \nabla_{\mathbf{y}} \psi\left(\frac{\mathbf{x}}{\varepsilon}\right)\right) d \mathbf{x} \\
& =-\int_{\Omega} \int_{\mathcal{Z}} v(\mathbf{x}) \nabla_{\mathbf{y}} \psi(\mathbf{y}) \cdot\left[i \omega \mathbf{1}_{C}(\mathbf{y}) E_{0}(\mathbf{x}, \mathbf{y})\right] d \mathbf{y} d \mathbf{x}=0 .
\end{aligned}

- from which it follows that

- We build oscillating test functions satisfying the constraint and use them in weak formulation. We define test function $V(\mathbf{x}, \mathbf{y})=\alpha(\mathbf{x})+\nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y}), V(\mathbf{x}, \mathbf{y}) \in \mathbf{C}_{0}^{1}\left(\Omega, \mathbf{C}_{\#}^{1}(\mathcal{Z})\right)$ and we inject in (40) test function $V^{\varepsilon}=V\left(\mathbf{x}, \frac{x}{\varepsilon}\right)$, which gives:

& \left.+\frac{1}{\varepsilon^{2}} \nabla_{\mathbf{y}} \times \nabla_{\mathbf{y}} \times V\left(\mathbf{x}, \frac{\mathbf{x}}{\varepsilon}\right)\right)+\left[-\omega^{2} \varepsilon^{5} k(\epsilon)+i \omega\left(\left(\mathbf{1}_{C}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)\right.\right.\right.  \tag{50}\\
& \left.\left.\left.+\varepsilon^{4} \mathbf{1}_{R}^{\varepsilon}\left(\frac{\mathbf{x}}{\varepsilon}\right)\right) \mathbf{1}_{\{y<0\}}+\varepsilon \mathbf{1}_{\{y>0\}}\right)\right] E^{\varepsilon}(\mathbf{x}) \cdot V\left(\mathbf{x}, \frac{\mathbf{x}}{\varepsilon}\right) d \mathbf{x} \\
& =-i \omega \int_{\Gamma_{d}} H_{d} \times e_{2} \cdot\left(e_{2} \times V^{\ddagger}(x, 1, z, \xi, \zeta)\right) \times e_{2} d \sigma,

- with $V(x, 1, z, \xi, \nu, \zeta)=V^{\ddagger}(x, 1, z, \xi, \zeta)$ the restriction on $V$ which does not depend on $\nu$. The term containing the constraint, the third one, disappears. Passing to the limit $\varepsilon \rightarrow 0$ and replacing the expression of $V$ by the term $\alpha(\mathbf{x})+\nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y})$, we have

& \quad=-i \omega \int_{\Gamma_{d}} H_{d} \times e_{2} \cdot\left(e_{2} \times\left(\alpha(x, 1, z)+\nabla_{\mathbf{y}} \beta(x, 1, z, \xi, \zeta)\right)\right) \times e_{2} d \sigma \tag{52}
\end{align*}
$$

- Now in (52) we replace expression $E_{0}$ giving by (48). We obtain

$$
\begin{align*}
\int_{\Omega} & \int_{\mathcal{Z}}\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x}) \cdot\left(\nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times\left(\alpha(\mathbf{x})+\nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y})\right)\right. \\
& \left.+i \omega \mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x})\right) \cdot\left(\alpha(\mathbf{x})+\nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y})\right) d \mathbf{y} d \mathbf{x} \\
& =-i \omega \int_{\Gamma_{d}} H_{d} \times e_{2} \cdot\left(e_{2} \times\left(\alpha(x, 1, z)+\nabla_{\mathbf{y}} \beta(x, 1, z, \xi, \zeta)\right)\right) \times e_{2} d \sigma . \tag{53}
\end{align*}
$$

- Taking $\alpha(\mathbf{x})=0$ in weak formulation, we obtain

$$
\begin{align*}
\int_{\Omega} \int_{\mathcal{Z}}(\operatorname{Id}+ & \left.\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) \nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times E(\mathbf{x}) \nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y}) \\
& +i \omega \mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x}) \cdot \nabla_{\mathbf{y}} \beta(\mathbf{x}, \mathbf{y}) d \mathbf{y} d \mathbf{x}=0 \tag{54}
\end{align*}
$$

- Integrating by parts

$$
\begin{align*}
\int_{\Omega} \int_{\mathcal{Z}}-\nabla_{\mathbf{y}} \cdot\{(\operatorname{Id} & \left.\left.+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) \nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times E(\mathbf{x})\right\} \beta(\mathbf{x}, \mathbf{y}) \\
& -i \omega \nabla_{\mathbf{y}} \cdot\left\{\mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}-\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x})\right\} \beta(\mathbf{x}, \mathbf{y}) d \mathbf{y} d \mathbf{x}=0 . \tag{55}
\end{align*}
$$

- And since $\nabla_{\mathbf{y}} \cdot\left\{\mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x})\right\}=0$ we obtain

$$
\begin{equation*}
\int_{\Omega} \int_{\mathcal{Z}}-\nabla_{\mathbf{y}} \cdot\left\{\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) \nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times E(\mathbf{x})\right\} \beta(\mathbf{x}, \mathbf{y}) d \mathbf{y} d \mathbf{x}=0 \tag{56}
\end{equation*}
$$

$40 / 45$

- which gives the cell problem

$$
\begin{equation*}
\nabla_{\mathbf{y}} \cdot\left[\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right]=0 \tag{57}
\end{equation*}
$$

- From (49) and (57), the scalar function $\chi$ is the unique solution, thanks to Lax-Milgram Lemma, up to an additive constant in the Hilbert space of $\mathcal{Z}$ periodic function $H_{\#}^{1}(\mathcal{Z})$ of the following boundary value problem

$$
\left\{\begin{array}{l}
\triangle_{y}(\chi(\mathbf{y}))=0 \text { in } \mathcal{Z} \backslash \partial \Omega_{C}  \tag{58}\\
{\left[\frac{\partial \chi}{\partial n}\right]=-n_{j} \text { on } \partial \Omega_{C},} \\
{[\chi]=0 \text { on } \partial \Omega_{C} .}
\end{array}\right.
$$

- where $[f]$ is the jump across the surface of $\partial \Omega_{C}, n_{j}, j=\{1,2,3\}$ is the projection on the axis $e_{j}$ of the normal of $\partial \Omega_{C}$. (58) can be seen as an electrostatic problem. Solving (49) and (57) reduces to look for a potential induced by surface density of charges. Then $\chi$ is this potential induced by the charges on the interface of carbon fiber.

- Setting $\beta(\mathbf{x}, \mathbf{y})=0$ in (53) and integrating by parts, we get

$$
\begin{align*}
\int_{\Omega} \int_{\mathcal{Z}}\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) & \nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times E(\mathbf{x}) \cdot \alpha(\mathbf{x}) \\
& +i \omega \mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) E(\mathbf{x}) \alpha(\mathbf{x}) d \mathbf{y} d \mathbf{x} \\
& =-i \omega \int_{\Gamma_{d}} H_{d} \times e_{2} \cdot\left(e_{2} \times \alpha(x, 1, z)\right) \times e_{2} d \sigma \tag{59}
\end{align*}
$$

- which gives the following well posed problem for $E(\mathbf{x})$

$$
\left\{\begin{array}{l}
\theta_{1} \nabla_{\mathbf{x}} \times \nabla_{\mathbf{x}} \times E(\mathbf{x})+i \omega \theta_{2} E(\mathbf{x})=0 \text { in } \Omega,  \tag{60}\\
\theta_{1} \nabla_{\mathbf{x}} \times E(\mathbf{x}) \times e_{2}=-i \omega H_{d} \times e_{2} \text { on } \Gamma_{d}, \\
\nabla_{\mathbf{x}} \times E(\mathbf{x}) \times e_{2}=0 \text { on } \Gamma_{L} .
\end{array}\right.
$$

- with $\theta_{1}=\int_{\mathcal{Z}} \operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y}) d \mathbf{y}$ and $\theta_{2}=\int_{\mathcal{Z}} \mathbf{1}_{C}(\mathbf{y})\left(\operatorname{Id}+\nabla_{\mathbf{y}} \chi(\mathbf{y})\right) d \mathbf{y}$.


## Numerical simulations

- Numerical simulations were done using FreeFem++, it is a software to solve numerically partial differential equations (PDE) with finite elements methods.
- We resolve cell problem using Lagrange P2 finite elements.
