# ON THE COHOMOLOGY OF CALOGERO-MOSER SPACES

#### Abstract

We compute the equivariant cohomology of smooth Calogero-Moser spaces and some associated symplectic resolutions of symplectic quotient singularities.


## 1. Notation and main results

All along this note, we will abbreviate $\otimes_{\mathbb{C}}$ as $\otimes$. By an algebraic variety, we mean a reduced scheme of finite type over $\mathbb{C}$.
1.A. Reflection group. - Let $V$ be a $\mathbb{C}$-vector space of finite dimension $n$ and let $W$ be a finite subgroup of $\mathbf{G L}_{\mathbb{C}}(V)$. We set

$$
\operatorname{Ref}(W)=\left\{s \in W \mid \operatorname{dim}_{\mathbb{C}} V^{s}=n-1\right\}
$$

and we assume that

$$
W=\langle\operatorname{Ref}(W)\rangle .
$$

We set $\varepsilon: W \rightarrow \mathbb{C}^{\times}, w \mapsto \operatorname{det}(w)$.
If $s \in \operatorname{Ref}(W)$, we denote by $\alpha_{s}^{V}$ and $\alpha_{s}$ two elements of $V$ and $V^{*}$ respectively such that $V^{s}=\operatorname{Ker}\left(\alpha_{s}\right)$ and $V^{* s}=\operatorname{Ker}\left(\alpha_{s}^{\vee}\right)$, where $\alpha_{s}^{\vee}$ is viewed as a linear form on $V^{*}$.
If $w \in W$, we set

$$
\operatorname{cod}(w)=\operatorname{codim}_{\mathbb{C}}\left(V^{w}\right)
$$

and we define a filtration $\mathscr{F}$. $(\mathbb{C} W)$ of the group algebra of $W$ as follows: let

$$
\mathscr{F}_{i}(\mathbb{C} W)=\bigoplus_{\operatorname{cod}(w) \leqslant i} \mathbb{C} w .
$$

Then

$$
\mathbb{C}^{\operatorname{ld}}{ }_{V}=\mathscr{F}_{0}(\mathbb{C} W) \subset \mathscr{F}_{1}(\mathbb{C} W) \subset \cdots \subset \mathscr{F}_{n}(\mathbb{C} W)=\mathbb{C} W=\mathscr{F}_{n+1}(\mathbb{C} W)=\cdots
$$

is a filtration of $\mathbb{C} W$. For any subalgebra $A$ of $\mathbb{C} W$, we set $\mathscr{F}_{i}(A)=A \cap \mathscr{F}_{i}(\mathbb{C} W)$, so that

$$
\mathbb{C I d}_{V}=\mathbb{C} \mathscr{F}_{0}(A) \subset \mathscr{F}_{1}(A) \subset \cdots \subset \mathscr{F}_{n}(A)=A=\mathscr{F}_{n+1}(A)=\cdots
$$

is also a filtration of $A$. Let $\hbar$ be a formal variable, and write

$$
\begin{aligned}
& \operatorname{Rees}_{\mathscr{F}}^{\bullet}(A)=\bigoplus_{i \geqslant 0} \hbar^{i} \mathscr{F}_{i}(A) \subset \mathbb{C}[\hbar] \otimes A \quad \text { (the Rees algebra), } \\
& \operatorname{gr}_{\mathscr{F}}^{\bullet}(A)=\bigoplus_{i \geqslant 0} \mathscr{F}_{i}(A) / \mathscr{F}_{i-1}(A) .
\end{aligned}
$$

Recall that $\operatorname{gr}_{\mathscr{F}}^{*}(A) \simeq \operatorname{Rees}_{\mathscr{F}}^{\bullet}(A) / \hbar \operatorname{Rees}_{\mathscr{F}}^{\bullet}(A)$.
1.B. Rational Cherednik algebra at $t=0$. - All along this note, we fix a function $c$ : $\operatorname{Ref}(W) \rightarrow \mathbb{C}$ which is invariant under conjugacy. We define the rational Cherednik algebra $\mathbf{H}_{c}$ to be the quotient of the algebra $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ (the semi-direct product of the tensor algebra $\mathrm{T}\left(V \oplus V^{*}\right)$ with the group $\left.W\right)$ by the relations
$\left(\mathscr{H}_{c}\right)$

$$
\left\{\begin{array}{l}
{\left[x, x^{\prime}\right]=\left[y, y^{\prime}\right]=0,} \\
{[y, x]=\sum_{s \in \operatorname{Ret}(W)}(\varepsilon(s)-1) c_{s} \frac{\left\langle y, \alpha_{s}\right\rangle\left\langle\alpha_{s}^{\vee}, x\right\rangle}{\left\langle\alpha_{s}^{\vee}, \alpha_{s}\right\rangle} s,}
\end{array}\right.
$$

for all $x, x^{\prime} \in V^{*}, y, y^{\prime} \in V$. The first commutation relations imply that we have morphisms of algebras $\mathbb{C}[V] \rightarrow \mathbf{H}_{c}$ and $\mathbb{C}\left[V^{*}\right] \rightarrow \mathbf{H}_{c}$. Recall [4, Theorem 1.3] that we have an isomorphism of $\mathbb{C}$-vector spaces

$$
\begin{equation*}
\mathbb{C}[V] \otimes \mathbb{C} W \otimes \mathbb{C}\left[V^{*}\right] \xrightarrow{\sim} \mathbf{H}_{c} \tag{1.1}
\end{equation*}
$$

induced by multiplication (this is the so-called PBW-decomposition).
We denote by $\mathbf{Z}_{c}$ the center of $\mathbf{H}_{c}$ : it is well-known [4] that $\mathbf{Z}_{c}$ is an integral domain, which is integrally closed and contains $\mathbb{C}[V]^{W}$ and $\mathbb{C}\left[V^{*}\right]^{W}$ as subalgebras (so it contains $\left.\mathbf{P}=\mathbb{C}[V]^{W} \otimes \mathbb{C}\left[V^{*}\right]^{W}\right)$, and that it is a free $\mathbf{P}$-module of rank $|W|$. We denote by $\mathscr{Z}_{c}$ the algebraic variety whose ring of regular functions $\mathbb{C}\left[\mathscr{Z}_{c}\right]$ is $\mathbf{Z}_{c}$ : this is the Calogero-Moser space associated with the datum ( $V, W, c$ ).

Using the PBW-decomposition, we define a $\mathbb{C}$-linear map $\boldsymbol{\Omega}_{\mathbf{H}}^{c}: \mathbf{H}_{c} \longrightarrow \mathbb{C} W$ by

$$
\mathbf{\Omega}_{\mathbf{H}}^{c}(f w g)=f(0) g(0) w
$$

for all $f \in \mathbb{C}[V], g \in \mathbb{C}\left[V^{*}\right]$ and $w \in \mathbb{C} W$. This map is $W$-equivariant for the action on both sides by conjugacy, so it induces a well-defined $\mathbb{C}$-linear map

$$
\boldsymbol{\Omega}^{c}: \mathbf{Z}_{c} \longrightarrow \mathbf{Z}(\mathbb{C} W) .
$$

Recall from [3, Corollary 4.2.11] that $\boldsymbol{\Omega}^{c}$ is a morphism of algebras, and that
$\mathscr{Z}_{c}$ is smooth if and only if $\boldsymbol{\Omega}^{c}$ is surjective.
The "only if" part is essentially due to Gordon [6, Corollary 5.8] (see also [3, Proposition 9.6 .6 and (16.1.2)]) while the "if" part follows from the work of Bellamy, Schedler and Thiel [13, Corollary 1.4].
1.C. Grading. - The algebra $\mathrm{T}\left(V \oplus V^{*}\right) \rtimes W$ can be $\mathbb{Z}$-graded in such a way that the generators have the following degrees

$$
\begin{cases}\operatorname{deg}(y)=-1 & \text { if } y \in V \\ \operatorname{deg}(x)=1 & \text { if } x \in V^{*} \\ \operatorname{deg}(w)=0 & \text { if } w \in W\end{cases}
$$

This descends to a $\mathbb{Z}$-grading on $\mathbf{H}_{c}$ since the defining relations $\left(\mathscr{H}_{c}\right)$ are homogeneous. Since the center of a graded algebra is always graded, it follows that $\mathbf{Z}_{c}$ also inherits a
$\mathbb{Z}$-grading. By definition $\mathbf{P}=\mathbb{C}[V]^{W} \otimes \mathbb{C}\left[V^{*}\right]^{W}$ is clearly a graded subalgebra of $\mathbf{Z}_{c}$. So the Calogero-Moser space $\mathscr{Z}_{c}$ inherits a regular $\mathbb{C}^{\times}$-action.
1.D. Main results. - For a complex algebraic variety $\mathscr{X}$ (equipped with its classical topology), we denote by $\mathrm{H}^{i}(\mathscr{X})$ its $i$-th singular cohomology group with coefficients in $\mathbb{C}$. If $\mathscr{X}$ carries a regular action of a torus $\mathbf{T}$, we denote by $\mathrm{H}_{\mathbf{T}}^{i}(\mathscr{X})$ its $i$-th $\mathbf{T}$-equivariant cohomology group (still with coefficients in $\mathbb{C}$ ). Note that $\mathrm{H}^{2 \bullet}(\mathscr{X})=\bigoplus_{i \geqslant 0} \mathrm{H}^{2 i}(\mathscr{X})$ is a graded $\mathbb{C}$-algebra and $\mathrm{H}_{\mathbf{T}}^{2 \bullet}(\mathscr{X})=\bigoplus_{i \geqslant 0} \mathrm{H}_{\mathbf{T}}^{2 i}(\mathscr{X})$ is a graded $\mathrm{H}_{\mathbf{T}}^{2 \bullet}(\mathbf{p t})$-algebra. The following result [4, Theorem 1.8] describes the algebra structure on the cohomology of $\mathscr{Z}_{c}$ (with coefficients in $\mathbb{C}$ ):

Theorem 1.3 (Etingof-Ginzburg). - Assume that $\mathscr{Z}_{c}$ is smooth. Then:
(a) $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ for all $i$.
(b) There is an isomorphism of graded $\mathbb{C}$-algebras $\mathrm{H}^{2 \bullet}\left(\mathscr{Z}_{c}\right) \simeq \mathrm{gr}_{\mathscr{F}}^{\bullet}(\mathrm{Z}(\mathbb{C} W))$.

In this note, we prove an equivariant version of this statement (we identify $R=\mathrm{H}_{\mathbb{C}^{\times}}^{*}(\mathbf{p t})$ with $\mathbb{C}[\hbar]$ in the usual way):
Theorem A. - Assume that $\mathscr{Z}_{c}$ is smooth. Then:
(a) $\mathrm{H}_{\mathbb{C} \times}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ for all $i$.
(b) There is an isomorphism of graded $R$-algebras $\mathrm{H}_{\mathbb{C}^{\times}}^{2 \cdot}\left(\mathscr{Z}_{c}\right) \simeq \operatorname{Rees}_{\mathscr{F}}^{\bullet}(\mathrm{Z}(\mathbb{C} W))$.

Note that Theorem A(a) just follows from statement (a) of Etingof-Ginzburg Theorem by Proposition 2.4(a) below. As a partial consequence of Theorem A, we also obtain the following application to the equivariant cohomology of some symplectic resolutions.

Theorem B. - Assume that the symplectic quotient singularity $\left(V \times V^{*}\right) / W$ admits a symplectic resolution $\pi: \mathscr{X} \longrightarrow\left(V \times V^{*}\right) / W$. Recall that the $\mathbb{C}^{\times}$-action on $\left(V \times V^{*}\right) / W$ lifts (uniquely) to $\mathscr{X}$ (see [11, Theorem 1.3(ii)]). Then:
(a) $\mathrm{H}_{\mathbb{C}^{\times}}^{2 i+1}(\mathscr{X})=0$ for all i.
(b) There is an isomorphism of graded $R$-algebras $\mathrm{H}_{\mathbb{C}^{\times}}^{2 \cdot( }(\mathcal{X}) \simeq \operatorname{Rees}_{\mathscr{F}}^{\bullet}(\mathrm{Z}(\mathbb{C} W))$.

Note that for $W=\mathfrak{S}_{n}$ acting on $\mathbb{C}^{n}$, Theorem B describes the equivariant cohomology of the Hilbert scheme of $n$ points in $\mathbb{C}^{2}$ : this was already proved (by different methods) by Vasserot [14]. In [5, Conjecture 1.3], Ginzburg-Kaledin proposed a conjecture for the equivariant cohomology of a symplectic resolution of a symplectic quotient singularity $E / G$, where $E$ is a finite dimensional symplectic vector space and $G$ is a finite subgroup of $\mathbf{S p}(E)$. However, their conjecture cannot hold as stated, because they considered the $\mathbb{C}^{\times}$action by dilatation, which is contractible. Theorem B shows that the correct equivariant cohomological realization of the Rees algebra is provided by the symplectic $\mathbb{C}^{\times}$-action, which exists only when $G$ stabilizes a Lagrangian subspace of $E$.

Remark 1.4. - Recall from the works of Etingof-Ginzburg [4], Ginzburg-Kaledin [5], Gordon [6] and Bellamy [1] that the existence of a symplectic resolution of $\left(V \times V^{*}\right) / W$ is equivalent to the existence of a parameter $c$ such that $\mathscr{Z}_{c}$ is smooth, and that it can only occurs if all the irreducible components of $W$ are of type $G(d, 1, n)$ (for some $d, n \geqslant 1$ ) or $G_{4}$ in Shephard-Todd classification.
1.E. Conjectures. - In [3, Chapter 16, Conjectures COH and ECOH ], Rouquier and the first author proposed the following conjecture which aims to generalize the above Etingof-Ginzburg Theorem 1.3 into two directions: it includes singular Calogero-Moser spaces and it extends to equivariant cohomology.

Conjecture 1.5. - With the above notation, we have:
(1) $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ for all $i$.
(2) We have an isomorphism of graded $\mathbb{C}$-algebras $\mathrm{H}^{2 \bullet}\left(\mathscr{Z}_{c}\right) \simeq \operatorname{gr}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$.
(3) We have an isomorphism of graded $R$-algebras $\mathrm{H}_{\mathbb{C}}^{2 \cdot}\left(\mathscr{Z}_{c}\right) \simeq \operatorname{Rees} \mathscr{F}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$.

By (1.2), when $\mathscr{Z}_{c}$ is smooth, the image of $\boldsymbol{\Omega}^{c}$ coincide with the center of $\mathbb{C} W$. So Theorem A proves this conjecture for smooth $\mathscr{Z}_{c}$.

We will also prove in Example 3.6 the following result:

Proposition 1.6. - If $\operatorname{dim}_{\mathbb{C}}(V)=1$, then Conjecture 1.5 holds.
1.F. Structure of the paper. - The paper is organized as follows. The proof of Theorem A relies on classical theorems about restriction to fixed points. In the next Section 2, we first recall basic properties on equivariant cohomology and equivariant K-theory and restriction to fixed points. Section 3 explains how these general principles can be applied to Calogero-Moser spaces. Theorem A will be proved in Section 4. The cyclic group case (Proposition 1.6) will be handled in Example 3.6. The proof of Theorem B will be given in Section 5.

## 2. Equivariant cohomology, K-theory and fixed points

2.A. Equivariant cohomology. - Let $\mathscr{X}$ be a complex algebraic variety equipped with a regular action of a torus T. Recall that the equivariant cohomology of $\mathscr{X}$ is defined by

$$
\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathscr{X})=\mathrm{H}^{\bullet}\left(E_{\mathbf{T}} \times_{B_{\mathrm{T}}} X\right),
$$

where $E_{\mathrm{T}} \rightarrow B_{\mathrm{T}}$ is a universal T-bundle. The pullback of the structural morphism $x: \mathscr{X} \rightarrow$ pt yields a ring homomorphism $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p t}) \rightarrow \mathrm{H}_{\mathbf{T}}^{\bullet}(\mathscr{X})$, which makes $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathcal{X})$ a graded $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p} \mathbf{t})$ algebra.

Denote by $X(\mathbf{T})$ the character lattice of $\mathbf{T}$. The for each $\chi \in X(\mathbf{T})$, denote by $\mathbb{C}_{\chi}$ the one dimensional $\mathbf{T}$-module of character $\chi$, the first Chern class $c_{\chi}$ of the line bundle $E_{\mathbf{T}} \times_{\mathbf{T}} \mathbb{C}_{\chi}$ on $B_{\mathbf{T}}$ is an element in $\mathrm{H}^{2}\left(B_{\mathbf{T}}\right)$. Identify the vector space $\mathbb{C} \otimes_{\mathbb{Z}} X(\mathbf{T})$ with the dual $\mathfrak{t}^{*}$ of the Lie algebra $\mathfrak{t}$ of $\mathbf{T}$ via $\chi \mapsto d \chi$. Then the assignment $\chi \mapsto c_{\chi}$ yields an isomorphism of graded $\mathbb{C}$-algebras $S\left(\mathbf{t}^{*}\right)=\mathrm{H}_{\mathbf{T}}^{20}(\mathbf{p t})$.
2.B. Equivariant K-theory. - We denote by $\mathrm{K}_{\mathbf{T}}(\mathscr{X})$ the Grothendieck ring of the category of T-equivariant vector bundles on $\mathscr{X}$. Note that when $\mathscr{X}$ is a point, a T-equivariant vector bundles is the same as a finite dimensional T-module. We have a canonical isomorphism $K_{\mathbf{T}}(\mathbf{p t})=\mathbb{Z}[X(\mathbf{T})]$ which sends the class of a $\mathbf{T}$-module $M$ to

$$
\begin{equation*}
\operatorname{dim}^{\mathbf{T}}(M)=\sum_{\chi \in X(\mathbf{T})} \operatorname{dim}_{\mathbb{C}}\left(M_{\chi}\right) \chi \tag{2.1}
\end{equation*}
$$

where $M_{\chi}$ is the $\chi$-weight space in $M$.
Let $\hat{\mathrm{H}}_{\mathbf{T}}^{2 \bullet}(\mathscr{X})$ be the completion of $\mathrm{H}_{\mathbf{T}}^{2 \bullet}(\mathscr{X})$ with respect to the ideal $\bigoplus_{i>0} \mathrm{H}_{\mathbf{T}}^{2 i}(\mathscr{X})$. The equivariant Chern character provides a ring homomorphism

$$
\operatorname{ch}_{\mathscr{X}}: \mathrm{K}_{\mathbf{T}}(\mathscr{X}) \longrightarrow \hat{\mathrm{H}}_{\mathbf{T}}^{2 \bullet}(\mathscr{X})
$$

with the following properties. First, when $\mathscr{X}$ is a point pt, we have

$$
\begin{array}{ccc}
\mathbf{c h}_{\mathbf{p t}}: \mathrm{K}_{\mathbf{T}}(\mathbf{p t})=\mathbb{Z}[X(\mathbf{T})] & \longrightarrow & \hat{\mathrm{H}}_{\mathbf{T}}^{2 \bullet}(\mathbf{p t})=\hat{\mathrm{S}}\left(\mathbf{t}^{*}\right)  \tag{2.2}\\
\chi & \longmapsto & \exp (d \chi) .
\end{array}
$$

Next the Chern character commutes with pullback. More precisely, if $\mathscr{Y}$ is another variety with a regular action of the same torus $\mathbf{T}$ and if $\varphi: \mathscr{X} \rightarrow \mathscr{Y}$ is a $\mathbf{T}$-equivariant morphism, then the following diagram commutes


Here $\varphi^{*}$ denotes both the pullback map in K-theory or in equivariant cohomology, and $\hat{\varphi}^{*}$ is the map induced after completion by the pullback map in equivariant cohomology. In particular, by applying the above diagram to $\mathscr{Y}=\mathbf{p t}$ and the structural morphism $\mathscr{X} \rightarrow \mathbf{p t}$, we may view $\operatorname{ch}_{\mathscr{X}}$ as a morphism of algebras over $\mathrm{K}_{\mathbf{T}}(\mathbf{p t})$, with the $\mathrm{K}_{\mathbf{T}}(\mathbf{p t})$-algebra structure on $\hat{\mathrm{H}}_{\mathbf{T}}^{2 \bullet}(\mathscr{X})$ provided by the embedding (2.2).
2.C. Fixed points. - We denote by $\mathscr{X}^{\mathbf{T}}$ the (reduced) variety consisting of fixed points of $\mathbf{T}$ in $\mathscr{X}$. Let $i_{\mathscr{X}}: \mathscr{X}^{\mathbf{T}} \longleftrightarrow \mathscr{X}$ be the natural closed immersion. Since $\mathbf{T}$ acts trivially on $\mathscr{X}^{\mathbf{T}}$, we have $\mathrm{H}_{\mathbf{T}}^{\bullet}\left(\mathscr{X}^{\mathbf{T}}\right)=\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p t}) \otimes \mathrm{H}^{\bullet}\left(\mathscr{X}^{\mathbf{T}}\right)$ as $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p t})$-algebras. Recall that the $\mathbf{T}$-action on $\mathscr{X}$ is called equivariantly formal if the Leray-Serre spectral sequence

$$
\mathrm{E}_{2}^{p q}=\mathrm{H}^{p}\left(B_{\mathbf{T}} ; \mathrm{H}^{q}(X)\right) \Longrightarrow \mathrm{H}_{\mathbf{T}}^{p+q}(X)
$$

for the fibration $E_{\mathbf{T}} \times_{\mathbf{T}} X \rightarrow B_{\mathbf{T}}$ degenerates at $E_{2}$. We have the following standard result on equivariant cohomology (see for instance [9, Proposition 2.1]):

Proposition 2.4. - Assume that $\mathrm{H}^{2 i+1}(\mathscr{X})=0$ for all $i$. Then $\mathscr{X}$ is equivariantly formal, and:
(a) There is an isomorphism of graded $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p} \mathbf{t})$-modules $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathscr{X}) \simeq \mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p t}) \otimes \mathrm{H}^{\bullet}(\mathscr{X})$. In particular $\mathrm{H}_{\mathbf{T}}^{2 i+1}(\mathscr{X})=0$ for all $i$.
(b) The pullback map $i_{\mathscr{X}}^{*}: \mathrm{H}_{\mathbf{T}}^{\bullet}(\mathscr{X}) \rightarrow \mathrm{H}_{\mathbf{T}}^{\bullet}\left(\mathscr{X}^{\mathbf{T}}\right)$ is injective.
(c) Let $\mathfrak{m}$ be the unique graded maximal ideal of $\mathrm{H}_{\mathbf{T}}^{\bullet}(\mathbf{p t})$. Then we have an isomorphism of algebras $\mathrm{H}^{\bullet}(\mathscr{X}) \simeq \mathrm{H}_{\mathbf{T}}^{\bullet}(\mathscr{X}) / \mathfrak{m H}_{\mathbf{T}}^{\bullet}(\mathscr{X})$.

In particular, this shows that Conjectures 1.5(1) and (3) imply Conjecture 1.5(2).

Example 2.5 (Blowing-up). - Let $\mathscr{Y}$ be an affine variety with a $\mathbf{T}$-action and let $\mathscr{C}$ be a T-stable closed subvariety (not necessarily reduced) of $\mathscr{Y}$. Let $\mathscr{X}$ be the blowing-up of $\mathscr{Y}$ along $\mathscr{C}$. Write $\pi: \mathscr{X} \rightarrow \mathscr{Y}$ for the natural morphism, and we equip $\mathscr{X}$ with the unique T-action such that $\pi$ is equivariant. We assume that $\mathscr{X}^{\mathbf{T}}$ is finite. We write

$$
\mathrm{H}_{\mathbf{T}}^{2 \boldsymbol{\bullet}}\left(\mathscr{X}^{\mathbf{T}}\right)=\bigoplus_{x \in \mathscr{X}^{\mathbf{T}}} \mathrm{S}\left(\mathfrak{t}^{*}\right) \mathbf{e}_{x},
$$

where $\mathbf{e}_{x} \in \mathrm{H}_{\mathbf{T}}^{0}\left(\mathscr{X}^{\mathbf{T}}\right)$ is the primitive idempotent associated with $x$ (i.e., the fundamental class of $x$ ).

Then $\mathscr{D}=\pi^{*}(\mathscr{C})$ is a $\mathbf{T}$-stable effective Cartier divisor, and we denote by [ $\mathscr{D}$ ] the class in $\mathrm{K}_{\mathbf{T}}(\mathscr{X})$ of its associated line bundle (which is $\mathbf{T}$-equivariant). We denote by $\operatorname{ch}_{\mathscr{X}}^{1}([\mathscr{D}]) \in$ $\mathrm{H}_{\mathbf{T}}^{2}(\mathscr{X})$ its first $\mathbf{T}$-equivariant Chern class. We want to compute $i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathbf{T}}^{1}(\mathscr{D})\right)$.

First, let $I$ be the ideal of $\mathbb{C}[\mathscr{Y}]$ associated with $\mathscr{C}$. As it is $\mathbf{T}$-stable, we can find a family of $\mathbf{T}$-homogeneous generators $\left(a_{i}\right)_{1 \leqslant i \leqslant k}$ of $I$. We denote by $\lambda_{i} \in X(\mathbf{T})$ the $\mathbf{T}$-weight of $a_{i}$. The choice of this family of generators induces a T-equivariant closed immersion $\mathscr{X} \hookrightarrow \mathscr{Y} \times \mathbf{P}^{k-1}(\mathbb{C})$. We denote by $\mathscr{X}_{i}$ the affine chart corresponding to " $a_{i} \neq 0^{\prime \prime}$ ". If $x \in \mathscr{X}^{\mathbf{T}}$, we denote by $\mathbf{i}(x) \in\{1,2, \ldots, k\}$ an element such that $x \in \mathscr{X}_{\mathbf{i}(x)}$. Then

$$
\begin{equation*}
i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathbf{T}}^{1}(\mathscr{D})\right)=-\hbar \sum_{x \in \mathscr{P}^{\mathrm{T}}}\left(d \lambda_{\mathbf{i}(x)}\right) \mathbf{e}_{x} \tag{2.6}
\end{equation*}
$$

Indeed, we just need to compute the local equation of $\mathscr{D}$ around $x \in \mathscr{X}^{\mathbf{T}}$, and this can be done in $\mathscr{X}_{\mathbf{i}(x)}$. But $\mathscr{D} \cap \mathscr{X}_{i}$ is principal for all $i$, defined by

$$
\mathscr{D} \cap \mathscr{X}_{i}=\left\{(y, \xi) \in \mathscr{Y} \times \mathbf{P}^{k-1}(\mathbb{C}) \mid(y, \xi) \in \mathscr{X}_{i} \text { and } a_{i}(y)=0\right\} .
$$

So $\mathscr{D} \cap \mathscr{X}_{i}$ is defined by a $\mathbf{T}$-homogeneous equation of degree $\lambda_{i} \in X(\mathbf{T})$, and so (2.6) follows.

## 3. Localization and Calogero-Moser spaces

In this section, we apply the previous discussions to $\mathscr{X}=\mathscr{Z}_{c}$ and $\mathbf{T}=\mathbb{C}^{\times}$. Denote by $q: \mathbb{C}^{\times} \rightarrow \mathbb{C}^{\times}$the identity map. Then $X\left(\mathbb{C}^{\times}\right)=q^{\mathbb{Z}}$, and we have

$$
\mathrm{K}_{\mathbb{C}^{\times}}(\mathbf{p t})=\mathbb{Z}\left[q, q^{-1}\right], \quad \mathrm{H}_{\mathbb{C}^{\times}}^{2 \cdot}(\mathbf{p t})=\mathbb{C}[\hbar],
$$

with $\hbar=c_{q}$, following the notation of Section 2.A. So $\hat{H}_{\mathbb{C}}^{20}(\mathbf{p t})=\mathbb{C}[[\hbar]]$ and the Chern map in this case is given by

$$
\mathrm{ch}_{\mathbf{p t}}: \mathbb{Z}\left[q, q^{-1}\right] \hookrightarrow \mathbb{C}[[\hbar]], \quad q \mapsto \exp (\hbar) .
$$

Note also that a finite $\mathbb{C}^{\times}$-module is nothing but a finite dimensional $\mathbb{Z}$-graded vector space $M=\bigoplus_{i \in \mathbb{Z}} M_{i}$ such that $\mathbb{C}^{\times}$acts on $M_{i}$ by the character $q^{i}$. The identification $\mathrm{K}_{\mathbb{C} \times}(\mathbf{p t})=\mathbb{Z}\left[q, q^{-1}\right]$ sends the class of $M$ to its graded dimension (or Hilbert series):

$$
\operatorname{dim}^{\mathrm{gr}}(M)=\sum_{i \in \mathbb{Z}} \operatorname{dim}_{\mathbb{C}}\left(M_{i}\right) q^{i} \in \mathbb{N}\left[q, q^{-1}\right] .
$$

3.A. Fixed points. - For $\chi \in \operatorname{Irr}(W)$, we denote by $\omega_{\chi}: \mathrm{Z}(\mathbb{C} W) \rightarrow \mathbb{C}$ the associated morphism of algebras, i.e. $\omega_{\chi}(z)=\chi(z) / \chi(1)$ is the scalar through which $z$ acts on the irreducible $\mathbb{C} W$-module with the character $\chi$. We denote by $e_{\chi}^{W}$ the unique primitive idempotent of $\mathrm{Z}(\mathbb{C} W)$ such that $\omega_{\chi}\left(e_{\chi}^{W}\right)=1$. If $\mathscr{E}$ is a subset of $\operatorname{Irr}(W)$, then we set $e_{\mathscr{E}}^{W}=\sum_{\chi \in \mathscr{E}} e_{\chi}^{W}$.

Now, consider the algebra homomorphism

$$
\Omega_{\chi}^{c}=\omega_{\chi} \circ \mathbf{\Omega}^{c}: \mathbf{Z}_{c} \longrightarrow \mathbb{C}
$$

Its kernel is a maximal ideal of $\mathbf{Z}_{c}$, denote by $z_{\chi}$ the corresponding closed point in $\mathscr{Z}_{c}$. It follows from [3, Lemma 10.2.3 and (14.2.2)] that $z_{\chi} \in \mathscr{Z}_{c}^{\mathbb{C}^{\times}}$and that the map

$$
\begin{align*}
z: \operatorname{Irr}(W) & \longrightarrow \mathscr{Z}^{\times}  \tag{3.1}\\
\chi & \longmapsto z_{\chi}
\end{align*}
$$

is surjective. The fibers of this map are called the Calogero-Moser c-families. They were first consider by Gordon [6] and Gordon-Martino [8]: see also for instance [3, §9.2]. Let $\mathrm{CM}_{c}(W)$ be the set of Calogero-Moser $c$-families. For $\mathscr{E} \in \mathrm{CM}_{c}(W)$, we denote by $z_{\mathscr{E}} \in \mathscr{Z} \mathbb{Z}^{\times}$ its image under the map $z$. On the other hand, by [3, (16.1.2)] we have

$$
\begin{equation*}
\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)=\bigoplus_{\mathscr{E} \in \mathrm{CM}_{c}(W)} \mathbb{C} e_{\mathscr{E}}^{W} \tag{3.2}
\end{equation*}
$$

Hence we get an isomorphism of $\mathbb{C}$-algebras

$$
\mathrm{H}^{2 \bullet}\left(\mathscr{Z}_{c}^{\mathbb{C}^{\times}}\right) \simeq \operatorname{Im}\left(\Omega^{c}\right), \quad e_{z_{\mathscr{E}}} \mapsto e_{\mathscr{E}}^{W}
$$

which extends to an isomorphism of $\mathbb{C}[\hbar]$-algebras $\mathrm{H}^{2 \bullet}\left(\mathscr{Z}_{c}^{\mathbb{C}^{\times}}\right) \simeq \mathbb{C}[\hbar] \otimes \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)$. For simplification, we set $i_{c}=i_{\mathscr{Z}_{c}}: \mathscr{Z}_{c}^{\mathbb{C}^{\times}} \hookrightarrow \mathscr{Z}$ and, under the above identification, we view the pullback map $i_{c}^{*}$ as a morphism of algebras

$$
i_{c}^{*}: \mathrm{H}_{\mathbf{T}}^{2 \cdot}\left(\mathscr{Z}_{c}\right) \longrightarrow \mathbb{C}[\hbar] \otimes \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)
$$

So, by Proposition 2.4, Conjecture 1.5 is implied by the following one:

Conjecture 3.3. - With the above notation, we have:
(1) $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ for all $i$.
(2) $\operatorname{Im}\left(i_{c}^{*}\right)=\operatorname{Rees}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$.

Remark 3.4. - Set

$$
\mathscr{F}_{i}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)=\left\{z \in \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right) \mid \hbar^{i} z \in \operatorname{Im}\left(i_{c}^{*}\right)\right\} .
$$

Then, by construction and Proposition 2.4, $\mathscr{F}_{\bullet}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$ is the filtration of $\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)$ satisfying

$$
\mathrm{H}_{\mathbb{C}^{\times}}^{2 \bullet}\left(\mathscr{Z}_{c}\right) \simeq \operatorname{Im}\left(i_{c}^{*}\right)=\operatorname{Rees}_{\mathscr{F} \mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)
$$

and

$$
\mathrm{H}^{2 \bullet}\left(\mathscr{Z}_{c}\right) \simeq \operatorname{gr}_{\mathscr{F} \mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) .
$$

So showing Conjecture 3.3 is then equivalent to showing that the filtrations $\mathscr{F} \cdot\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$ and $\mathscr{F}_{\bullet}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)$ coincide.

Note also that, since $\mathscr{Z}_{c}$ is an affine variety of dimension $2 n$, we have $\mathrm{H}^{i}\left(\mathscr{Z}_{c}\right)=0$ for $i>2 n$, so this shows that

$$
\begin{equation*}
\mathscr{F}_{n}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)=\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)=\mathscr{F}_{n}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) . \tag{b}
\end{equation*}
$$

On the other hand, since $\mathscr{Z}_{c}$ is connected, we have

$$
\mathscr{F}_{0}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)=\mathscr{F}_{0}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)=\mathbb{C} .
$$

These two particular cases will be used below.
The following result, based on the previous remark, can be viewed as a reduction step for the proof of Conjecture 3.3:

Proposition 3.5. - Assume that $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ and

$$
\operatorname{dim}_{\mathbb{C}}\left(\mathrm{H}^{2 i}\left(\mathscr{Z}_{c}\right)\right)=\operatorname{dim}_{\mathbb{C}}\left(\mathscr{F}_{i}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) / \mathscr{F}_{i-1}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)
$$

for all $i$. Then Conjecture 3.3 holds if and only if $\operatorname{Rees}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) \subset \operatorname{Im}\left(i_{c}^{*}\right)$.

Proof. - Assume that $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ and

$$
\operatorname{dim}_{\mathbb{C}}\left(\mathrm{H}^{2 i}\left(\mathscr{Z}_{c}\right)\right)=\operatorname{dim}_{\mathbb{C}}\left(\mathscr{F}_{i}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) / \mathscr{F}_{i-1}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)
$$

for all $i$. We keep the notation of Remark 3.4. It then follows from this remark and the hypothesis that

$$
\operatorname{dim}_{\mathbb{C}}\left(\mathscr{F}_{i}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) / \mathscr{F}_{i-1}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)=\operatorname{dim}_{\mathbb{C}}\left(\mathrm{H}^{2 i}\left(\mathscr{Z}_{c}\right)\right)=\operatorname{dim}\left(\mathscr{F}_{i}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) / \mathscr{F}_{i-1}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)
$$

for all $i$. So, by induction, we get that $\operatorname{dim}_{\mathbb{C}}\left(\mathscr{F}_{i}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)=\operatorname{dim}\left(\mathscr{F}_{i}^{\mathrm{H}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right.$ for all $i$ (by the equality ( $\sharp$ ) of Remark 3.4). This shows that $\operatorname{Rees}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)=\operatorname{Im}\left(i_{c}^{*}\right)$ if and only if $\operatorname{Rees}_{\mathscr{F}}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) \subset \operatorname{Im}\left(i_{c}^{*}\right)$, as desired.

Example 3.6. - Assume in this example, and only in this example, that $\operatorname{dim}_{\mathbb{C}}(V)=1$. It is proved in [3, Theorem 18.5.8] that in this case $\mathrm{H}^{2 i+1}\left(\mathscr{Z}_{c}\right)=0$ and

$$
\operatorname{dim}_{\mathbb{C}}\left(\mathrm{H}^{2 i}\left(\mathscr{Z}_{c}\right)\right)=\operatorname{dim}_{\mathbb{C}}\left(\mathscr{F}_{i}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right) / \mathscr{F}_{i-1}\left(\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)\right)\right)
$$

for all $i$. Since $\mathscr{Z}_{c}$ is affine of dimension 2 , we have $\mathrm{H}^{i}\left(\mathscr{Z}_{c}\right)=0$ if $i \notin\{0,2\}$. So it follows from the equalities (b) and ( $\sharp$ ) that Conjecture 3.3 holds in this case (this proves Proposition 1.6).
3.B. Chern map. - If $\mathscr{E}$ is a Calogero-Moser family, we denote by $\mathfrak{m}_{\mathscr{E}} \subset \mathbf{Z}_{c}$ the ideal of functions vanishing at $z_{\mathscr{\delta}} \in \mathscr{Z}_{c}^{\mathbb{C}^{\times}}$. We also set

$$
\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)_{\mathbb{Z}}=\bigoplus_{\delta \in C M_{c}(W)} \mathbb{Z} e_{\delta}^{W}
$$

We make the natural identification $\mathrm{K}_{\mathbb{C}^{\times}}\left(\mathscr{E}_{c}^{\mathbb{C}^{\times}}\right)=\mathbb{Z}\left[q, q^{-1}\right] \otimes_{\mathbb{Z}} \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)_{\mathbb{Z}}$. Through these identifications, the Chern map $\mathrm{ch}_{\mathscr{E}_{c}^{c \times}}$ just becomes the natural inclusion $\mathbb{Z}\left[q, q^{-1}\right] \otimes_{\mathbb{Z}} \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)_{\mathbb{Z}} \hookrightarrow$ $\mathbb{C}[\hbar \hbar]] \otimes \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)$. Moreover, if $P$ is a $\mathbb{Z}$-graded finitely generated projective $\mathbf{Z}_{c}$-module, then the commutativity of the diagram (2.3) just says that

$$
\begin{equation*}
i_{c}^{*}\left(\operatorname{ch}_{\mathfrak{F}_{c}}([P])\right)=\sum_{\delta \in \mathrm{CM}_{c}(W)} \operatorname{dim}^{\mathrm{gr}}\left(P / \mathfrak{m}_{\delta} P\right) e_{\delta}^{W} \subset \mathbb{C}[[\hbar]] \otimes \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right) . \tag{3.7}
\end{equation*}
$$

## 4. Proof of Theorem $A$

Hypothesis and notation. We assume in this section, and only in this section, that $\mathscr{Z}_{c}$ is smooth.

If $M=\bigoplus_{i \in \mathbb{Z}} M_{i}$ and $N=\bigoplus_{i \in \mathbb{Z}} N_{i}$ are two finite-dimensional graded $\mathbb{C} W$-modules, we set

$$
\langle M, N\rangle_{W}^{\mathrm{gr}}=\sum_{i, j \in \mathbb{Z}}\left\langle M_{i}, N_{j}\right\rangle_{W} q^{i+j},
$$

where $\langle E, F\rangle_{W}=\operatorname{dim}^{\operatorname{Hom}} \mathbb{C}^{C}(E, F)$ for any finite dimensional $\mathbb{C} W$-modules $E$ and $F$. We extend this notation to the case where $M$ or $N$ is a graded virtual character (i.e. an element of $\left.\mathbb{Z}\left[q, q^{-1}\right] \otimes_{\mathbb{Z}} \mathbb{Z} \operatorname{Irr}(W)\right)$. Finally, we denote by $\mathbb{C}\left[V^{*}\right]^{\mathrm{co}(W)}$ the coinvariant algebra, i.e. the quotient of the algebra $\mathbb{C}\left[V^{*}\right]$ by the ideal generated by the elements $f \in \mathbb{C}\left[V^{*}\right]^{W}$ such that $f(0)=0$. Then $\mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)}$ is a graded $\mathbb{C} W$-module, which is isomorphic to the regular representation $\mathbb{C} W$ when one forgets the grading (we define similarly $\mathbb{C}[V]^{\mathrm{co}(W)}$ ).
4.A. Localization in K-theory. - Recall from (1.2) that the smoothness of $\mathscr{Z}_{c}$ implies that $\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)=\mathrm{Z}(\mathbb{C} W)$, so that $z: \operatorname{Irr}(W) \rightarrow \mathscr{Z}_{c}^{\mathbb{C}^{\times}}$is bijective. Let $e=e_{1}^{W}=(1 /|W|) \sum_{w \in W} w$. The smoothness of $\mathscr{Z}_{c}$ also implies that the functor

$$
\begin{aligned}
\mathbf{H}_{c}-\bmod & \longrightarrow \mathbf{Z}_{c}-\bmod \\
M & \longmapsto e M=e \mathbf{H}_{c} \otimes_{\mathbf{H}_{c}} M
\end{aligned}
$$

is an equivalence of categories [4, Theorem 1.7]. If $E$ is a finite dimensional $\mathbb{Z}$-graded $\mathbb{C} W$-module, the $\mathbf{H}_{c}$-module $\mathbf{H}_{c} \otimes_{\mathbb{C} W} E$ is finitely generated, $\mathbb{Z}$-graded and projective. Therefore, $e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E$ is a finitely generated graded projective $\mathbf{Z}_{c}$-module, which can be viewed as a $\mathbb{C}^{\times}$-equivariant vector bundle on $\mathscr{Z}_{c}$. For simplification, we set

$$
\operatorname{ch}_{c}(E)=i_{c}^{*}\left(\operatorname{ch}_{\mathscr{Z}_{c}}\left(e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E\right)\right) \in \mathbb{C}[[\hbar]] \otimes \operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)
$$

Proposition 4.1. - Assume that $\mathscr{Z}_{c}$ is smooth. Let $E$ be a finite dimensional graded $\mathbb{C} W$ module. Then

$$
\operatorname{ch}_{c}(E)=\sum_{\chi \in \operatorname{Irr}(W)} q^{b_{\chi}} \frac{\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)} \otimes E\right\rangle_{W}^{\mathrm{g}}}{\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\cos (W)}\right\rangle_{W}^{\mathrm{gr}}} e_{\chi}^{W},
$$

where $b_{\chi}$ is the valuation of $\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)}\right\rangle_{G}^{\mathrm{gr}}$.

Proof. - As the formula is additive, we may, and we will, assume that $E$ is an irreducible $\mathbb{C} W$-module, concentrated in degree 0 , and we denote by $\psi$ its character.
Now, let $\chi \in \operatorname{Irr}(W)$ : we denote by $\mathfrak{m}_{\chi}$ the maximal ideal of $\mathbf{Z}_{c}$ corresponding to the fixed point $z_{\chi}$. We set $\mathfrak{p}=\mathfrak{m}_{\chi} \cap \mathbf{P}$ : it does not depend on $\chi$ (it is the maximal ideal of $\mathbf{P}=\mathbb{C}\left[V / W \times V^{*} / W\right]$ of functions which vanishes at $(0,0)$; see for instance $\left.[3,(14.2 .2)]\right)$. By (3.7),

$$
\operatorname{ch}_{c}(E)=\sum_{\chi \in \operatorname{Irr}(W)} \operatorname{dim}^{\mathrm{gr}}\left(\left(e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E\right) / \mathfrak{m}_{\chi}\left(e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E\right)\right) e_{\chi}^{W}
$$

Now, let $\overline{\mathbf{Z}}_{c}=\mathbf{Z}_{c} / \mathfrak{p} \mathbf{Z}_{c}$ and $\overline{\mathbf{H}}_{c}=\mathbf{H}_{c} / \mathfrak{p} \mathbf{H}_{c}$. We set $\overline{\mathfrak{m}}_{\chi}=\mathfrak{m}_{\chi} / \mathfrak{p} \mathbf{Z}_{c}$. Then $\overline{\mathbf{H}}_{c}$ is a finite dimensional $\mathbb{C}$-algebra (called the restricted rational Cherednik algebra) and again the bimodule
$e \overline{\mathbf{H}}_{c}$ induces a Morita equivalence between $\overline{\mathbf{H}}_{c}$ and $\overline{\mathbf{Z}}_{c}$. This implies that $e \overline{\mathbf{H}}_{c} / \overline{\mathfrak{m}}_{\chi} \overline{\mathbf{H}}_{c}=$ $\left(\overline{\mathbf{Z}}_{c} / \overline{\mathfrak{m}}_{\chi}\right) \otimes_{\overline{\mathbf{Z}}_{c}} e \overline{\mathbf{H}}_{c}$ is a simple right $\overline{\mathbf{H}}_{c}$-module (that will be denoted by $\mathscr{L}_{c}(\chi)$ ).

Since $\mathbb{C} W$ is semisimple, the $\mathbb{C} W$-module $E$ is flat, and so

$$
\begin{aligned}
\left(e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E\right) / \mathfrak{m}_{\chi}\left(e \mathbf{H}_{c} \otimes_{\mathbb{C} W} E\right) & \simeq\left(e \mathbf{H}_{c} / \mathfrak{m}_{\chi}\left(e \mathbf{H}_{c}\right)\right) \otimes_{\mathbb{C} W} E \\
& \simeq\left(e \overline{\mathbf{H}}_{c} / \overline{\mathfrak{m}}_{\chi}\left(e \overline{\mathbf{H}}_{c}\right)\right) \otimes_{\mathbb{C} W} E . \\
& \simeq \mathscr{L}_{c}(\chi) \otimes_{\mathbb{C} W} E .
\end{aligned}
$$

But the graded dimension of $\mathscr{L}_{c}(\chi) \otimes_{\mathbb{C} W} E$ is known whenever $\mathscr{Z}_{c}$ is smooth and is given by the expected formula (see [1, Lemma 3.3 and its proof]).

Let $K_{\mathbb{C} \times}(\mathbb{C} W)$ denote the Grothendieck group of the category of finite dimensional graded $\mathbb{C} W$-modules. If $E$ is a finite dimensional graded $\mathbb{C} W$-module, we denote by $[E]$ its class in $\mathrm{K}_{\mathbb{C}^{\times}}(\mathbb{C} W)$. We still denote by $\mathrm{ch}_{c}: \mathrm{K}_{\mathbb{C}^{\times}}(\mathbb{C} W) \rightarrow \mathbb{C}[[\hbar]] \otimes \mathrm{Z}(\mathbb{C} W)$ the map defined by

$$
\operatorname{ch}_{c}([E])=\operatorname{ch}_{c}(E) .
$$

Now, let $W^{\prime}$ be a parabolic subgroup of $W$ and set $V^{\prime}=V^{W^{\prime}}$ and $r=\operatorname{codim}_{\mathbb{C}}\left(V^{\prime}\right)$. We identify the dual $V^{\prime *}$ of $V^{\prime}$ with $V^{* W^{\prime}}$ and note that

$$
\begin{equation*}
V=V^{\prime} \oplus\left(V^{\prime *}\right)^{\perp} \tag{4.2}
\end{equation*}
$$

We denote by $\wedge\left(V^{*}\right)^{\perp}$ the element of $\mathrm{K}_{\mathbb{C}^{\times}}\left(\mathbb{C} W^{\prime}\right)$ defined by

$$
\wedge\left(V^{*}\right)^{\perp}=\sum_{i \geqslant 0}(-1)^{i}\left[\wedge^{i}\left(V^{*}\right)^{\perp}\right] .
$$

Recall also that there exists $n$ algebraically independent homogeneous polynomials $f_{1}, \ldots$, $f_{n}$ in $\mathbb{C}[V]^{W}$ such that $\mathbb{C}[V]^{W}=\mathbb{C}\left[f_{1}, \ldots, f_{n}\right]$, and we denote by $d_{i}$ the degree of $f_{i}$.

Corollary 4.3. - Assume that $\mathscr{Z}_{c}$ is smooth. Let $E^{\prime}$ be a finite dimensional graded $\mathbb{C} W^{\prime}$ module. Then

$$
\operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{\prime *}\right)^{\perp} \otimes\left[E^{\prime}\right]\right)\right)=\frac{\left(1-q^{d_{1}}\right) \cdots\left(1-q^{d_{n}}\right)}{(1-q)^{n-r}} \sum_{\chi \in \operatorname{Irr}(W)} q^{b_{\chi}} \frac{\left\langle\chi, \operatorname{Ind}_{W^{\prime}}^{W} E^{\prime}\right\rangle_{W}^{\mathrm{gr}}}{\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\cos (W)\rangle_{W}^{\mathrm{gr}}}\right.} e_{\chi}^{W}
$$

Proof. - The group $W^{\prime}$ acts trivially on $V^{\prime}$ so it acts trivially on $\wedge^{i} V^{\prime}$ for all $i$. Therefore,

$$
(1-q)^{n-r} \operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{\prime *}\right)^{\perp} \otimes\left[E^{\prime}\right]\right)\right)=\operatorname{ch}_{c}\left(\operatorname{ind}_{W^{\prime}}^{W}\left(\wedge V^{\prime} \otimes \wedge\left(V^{\prime *}\right)^{\perp} \otimes\left[E^{\prime}\right]\right)\right)
$$

But $\wedge V^{\prime} \otimes \wedge\left(V^{*}\right)^{\perp}=\operatorname{Res}_{W^{\prime}}^{W}(\wedge V)$ by (4.2), so, by Frobenius formula,

$$
(1-q)^{n-r} \operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{\prime *}\right)^{\perp} \otimes\left[E^{\prime}\right]\right)\right)=\operatorname{ch}_{c}\left(\wedge V \otimes \operatorname{Ind}_{W^{\prime}}^{W} E^{\prime}\right)
$$

So it follows from Proposition 4.1 that

$$
\begin{aligned}
&(1-q)^{n-r} \operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{*}\right)^{\perp} \otimes\left[E^{\prime}\right]\right)\right) \\
&=\sum_{\chi \in \operatorname{Irr}(W)} \frac{q^{b_{\chi}}}{\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)}\right\rangle_{W}^{\mathrm{gr}}}\left\langle\chi, \mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)} \otimes(\wedge V) \otimes \operatorname{Ind}_{W^{\prime}}^{W}\left(E^{\prime}\right)\right\rangle_{W}^{\mathrm{gr}} e_{\chi}^{W}
\end{aligned}
$$

But, if $w \in W$, the Molien's formula implies that the graded trace of $w$ on $\mathbb{C}\left[V^{*}\right]^{\mathrm{co}(W)}$ is equal to

$$
\frac{\left(1-q^{d_{1}}\right) \cdots\left(1-q^{d_{n}}\right)}{\operatorname{det}(1-w q)}
$$

while its graded trace on $\wedge V$ is equal to $\operatorname{det}(1-w q)$. So the class of $\mathbb{C}\left[V^{*}\right]^{\operatorname{co}(W)} \otimes \wedge V$ is equal to $\left(1-q^{d_{1}}\right) \cdots\left(1-q^{d_{n}}\right)$ times the class of the trivial module, and the corollary follows.

Proof of Theorem A. - Assume that $\mathscr{Z}_{c}$ is smooth. This implies in particular that Conjecture 1.5(1) and (2) hold (Etingof-Ginzburg Theorem 1.3), and so the hypotheses of Proposition 3.5 are satisfied. Note also that $\operatorname{Im}\left(\boldsymbol{\Omega}^{c}\right)=\mathrm{Z}(\mathbb{C} W)$ by (1.2). It is then sufficient to prove that $\hbar^{i} \mathscr{F}_{i}(\mathrm{Z}(\mathbb{C} W)) \subset \operatorname{Im}\left(i_{c}^{*}\right)$ for all $i$.

Let us introduce some notation. If $G$ is a finite group and $H$ is a subgroup, we define a $\mathbb{C}$-linear map $\operatorname{Tr}_{H}^{G}: \mathrm{Z}(\mathbb{C} H) \longrightarrow \mathrm{Z}(\mathbb{C} G)$ by

$$
\operatorname{Tr}_{H}^{G}(z)=\sum_{g \in[G / H]}{ }^{g} z=\frac{1}{|H|} \sum_{g \in G}{ }^{g} z
$$

(here, $[G / H]$ denotes a set of representatives of elements of $G / H$ and $g z=g z g^{-1}$ ). It is easily checked that

$$
\begin{equation*}
\operatorname{Tr}_{H}^{G}\left(e_{\eta}^{H}\right)=\frac{\eta(1)}{|H|} \sum_{\gamma \in \operatorname{Irr}(G)} \frac{|G|}{\gamma(1)}\left\langle\gamma, \operatorname{Ind}_{H}^{G}(\eta)\right\rangle_{G} e_{\gamma}^{G} \tag{4.4}
\end{equation*}
$$

for all $\eta \in \operatorname{Irr}(H)$. Also, if $h \in H$ and $\Sigma_{H}(h) \in \mathrm{Z}(\mathbb{C} H)$ denotes the sum of the conjugates of $h$ in $H$, then

$$
\begin{equation*}
\operatorname{Tr}_{H}^{G}\left(\Sigma_{H}(h)\right)=\frac{\left|C_{G}(h)\right|}{\left|C_{H}(h)\right|} \Sigma_{G}(h) . \tag{4.5}
\end{equation*}
$$

Let $\mathscr{P}_{r}(W)$ denote the set of parabolic subgroups $W^{\prime}$ of $W$ such that $\operatorname{codim}_{\mathbb{C}}\left(V^{W^{\prime}}\right)=r$. It follows from (4.5) that

$$
\begin{equation*}
\mathscr{F}_{r}(\mathrm{Z}(\mathbb{C} W))=\sum_{W^{\prime} \in \mathscr{P}_{r}(W)} \operatorname{Tr}_{W^{\prime}}^{W}\left(\mathrm{Z}\left(\mathbb{C} W^{\prime}\right)\right) . \tag{4.6}
\end{equation*}
$$

Therefore, by Proposition 3.5, it is sufficient to prove that
( $\star$ ) $\quad \hbar^{r} \operatorname{Tr}_{W^{\prime}}^{W}\left(e_{\chi^{\prime}}^{W^{\prime}}\right) \in \operatorname{Im}\left(i_{c}^{*}\right)$ for all $W^{\prime} \in \mathscr{P}_{r}(W)$ and all $\chi^{\prime} \in \operatorname{Irr}\left(W^{\prime}\right)$.
But it turns out that the coefficient of $\hbar^{r}$ in

$$
\frac{\chi^{\prime}(1)}{\left|W^{\prime}\right|} \operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{\prime *}\right)^{\perp} \otimes \chi^{\prime}\right)\right)
$$

is equal, according to Corollary 4.3, to

$$
\frac{\chi^{\prime}(1)}{\left|W^{\prime}\right|} \sum_{\chi \in \operatorname{Irr}(W)} \frac{|W|\left\langle\chi, \operatorname{Ind}_{W^{\prime}}^{W} \chi^{\prime}\right\rangle_{W}}{\chi(1)} e_{\chi}^{W}
$$

(since $\left.d_{1} \cdots d_{n}=|W|\right)$. Note that by definition $\frac{\chi^{\prime}(1)}{\left|W^{\prime}\right|} \operatorname{ch}_{c}\left(\operatorname{Ind}_{W^{\prime}}^{W}\left(\wedge\left(V^{* *}\right)^{\perp} \otimes \chi^{\prime}\right)\right)$ belongs to $\mathbb{C}[[\hbar]] \otimes_{\mathbb{C}[\hbar]} \operatorname{Im}\left(i_{c}^{*}\right)$, so each of its homogeneous components belong to $\operatorname{Im}\left(i_{c}^{*}\right)$. By (4.4), this proves that $(\star)$ holds, and the proof of Theorem A is complete.

## 5. Proof of Theorem B

> Hypothesis and notation. We assume in this section, and only in this section, that the symplectic quotient singularity $\mathscr{Z}_{0}=\left(V \times V^{*}\right) / W$ admits a symplectic resolution $\mathscr{X} \rightarrow \mathscr{Z}_{0}$.

Recall [11, Theorem 1.3(ii)] that the $\mathbb{C}^{\times}$-action on $\mathscr{Z}_{0}$ lifts uniquely to $\mathscr{X}$. As it is explained in Remark 1.4, the existence of a symplectic resolution of $\mathscr{Z}_{0}$ implies that all the irreducible components of $W$ are of type $G(d, 1, n)$ or $G_{4}$. Since the proof of Theorem B can be easily reduced to the irreducible case, we will separate the proof in two cases.

Proof of Theorem B for $W=G(d, 1, n)$. - Assume here that $W=G(d, 1, n)$. Let $\mathbf{S}^{1}$ be the group of complex numbers of modulus 1 . In this case, it follows from [7] that $\mathscr{X}$ is diffeomorphic to some smooth $\mathscr{Z}_{c}$, and that the diffeomorphism might be chosen to be $\mathbf{S}^{1}$-equivariant. As the $\mathbf{S}^{1}$-equivariant cohomology is canonically isomorphic to the $\mathbb{C}^{\times}$equivariant cohomology, this proves Theorem B in this case.

Proof of Theorem B for $W=G_{4}$. - Assume here that $W=G_{4}$. It is possible (probable?) that again $\mathscr{X}$ is $\mathbf{S}^{1}$-diffeomorphic to some smooth $\mathscr{Z}_{c}$, but we are unable to prove it (it is only known that they are diffeomorphic). So we will prove Theorem B in this case by brute force computations.
We fix a primitive third root of unity $\zeta$ and we assume that $V=\mathbb{C}^{2}$ and that $W=\langle s, t\rangle$, where

$$
s=\left(\begin{array}{cc}
\zeta & 0 \\
\zeta^{2} & 1
\end{array}\right) \quad \text { and } \quad t=\left(\begin{array}{cc}
1 & -\zeta^{2} \\
0 & \zeta
\end{array}\right)
$$

By the work of Bellamy [2], there are only two symplectic resolutions of $\mathscr{Z}_{0}=\left(V \times V^{*}\right) / W$. They have both been constructed by Lehn and Sorger [12]: one can be obtained from the other by exchanging the role of $V$ and $V^{*}$, so we will only prove Theorem B for one of them. Let us describe it.

Let $H=V^{s}$ and let $\mathscr{H}$ denote the image of $H \times V^{*}$ in $\mathscr{Z}_{0}$, with its reduced structure of closed subvariety. We denote by $\beta: \mathscr{Y} \rightarrow \mathscr{Z}_{0}$ the blowing-up of $\mathscr{Z}_{0}$ along $\mathscr{H}$ and we denote by $\alpha: \mathscr{X} \rightarrow \mathscr{Y}$ the blowing-up of $\mathscr{Y}$ along its reduced singular locus $\mathscr{S}$. Then [12]

$$
\pi=\beta \circ \alpha: \mathscr{X} \longrightarrow \mathscr{Z}_{0}
$$

is a symplectic resolution.
We now give more details, which all can be found in $[12, \S 1]$. First, $\mathbb{C}\left[\mathscr{Z}_{0}\right]$ is generated by 8 homogeneous elements $\left(z_{i}\right)_{1 \leqslant i \leqslant 8}$ whose degrees are given by the following table:

| $z$ | $z_{1}$ | $z_{2}$ | $z_{3}$ | $z_{4}$ | $z_{5}$ | $z_{6}$ | $z_{7}$ | $z_{8}$ |
| :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: | :---: |
| $\operatorname{deg}(z)$ | 0 | 4 | -4 | 2 | -2 | -6 | 6 | 0 |

The defining ideal of $\mathscr{H}$ in $\mathbb{C}\left[\mathscr{Z}_{0}\right]$ is generated by 6 homogeneous elements $\left(b_{j}\right)_{1 \leqslant j \leqslant 6}$ whose degrees are given by the following table:

| $b$ | $b_{1}$ | $b_{2}$ | $b_{3}$ | $b_{4}$ | $b_{5}$ | $b_{6}$ |
| :---: | :---: | :---: | :---: | :---: | :---: | :---: |
| $\operatorname{deg}(b)$ | 2 | 6 | 0 | 12 | 8 | 4 |

This defines a $\mathbb{C}^{\times}$-equivariant closed immersion $\mathscr{Y} \hookrightarrow \mathscr{Z}_{0} \times \mathbf{P}^{5}(\mathbb{C})$. We denote by $\mathscr{Y}_{i}$ the affine chart defined by " $b_{i} \neq 0$ ". The equations of the zero fiber $\beta^{-1}(0)$ given in [12, §1] show that $\mathscr{Y}^{\mathbb{C}^{\times}}=\left\{p_{2}, p_{3}, p_{4}, p_{6}\right\}$, where $p_{i}$ is the unique element of $\mathscr{Y}_{i}^{\mathbb{C}^{\times}}$. We use the notation of Example 2.5. By (2.6) and (5.2), we have

## (\%)

$$
i_{\mathscr{Y}}^{*}\left(\operatorname{ch}_{\mathscr{Y}}^{1}\left(\left[\beta^{*} \mathscr{H}\right]\right)\right)=-\hbar\left(6 \mathbf{e}_{p_{2}}+12 \mathbf{e}_{p_{4}}+4 \mathbf{e}_{p_{6}}\right) .
$$

Now, $\mathscr{S}$ is contained in $\mathscr{Y}_{2} \cup \mathscr{Y}_{3}$, so $\alpha$ is an isomorphism in a neighborhood of $p_{4}$ and $p_{6}$. So let $q_{4}=\alpha^{-1}\left(p_{4}\right)$ and $q_{6}=\alpha^{-1}\left(p_{6}\right)$. These are elements of $\mathscr{X}^{\mathbb{C}^{\times}}$.

On the other hand, $\mathscr{Y}_{2}$ is a transversal $A_{1}$-singularity, so the defining ideal of $\mathscr{S} \cap \mathscr{Y}_{2}$ in $\mathbb{C}\left[\mathscr{Y}_{2}\right]$ is generated by three homogeneous elements $a_{+}, a_{\circ}$ and $a_{-}$(of degree 6,0 and -6 , by $[12, \S 1])$, and it is easily checked that $\alpha^{-1}\left(p_{2}\right)^{\mathbb{C}^{\times}}=\left\{q_{2}^{+}, q_{2}^{-}\right\}$where $q_{2}^{ \pm}$is the unique $\mathbb{C}^{\times}$-fixed element in the affine chart defined by " $a_{ \pm} \neq 0$ ".

Also, $\mathscr{Y}_{3}$ is isomorphic to $\left(\mathfrak{h} \times \mathfrak{h}^{*}\right) / \mathfrak{S}_{3}$, where $\mathfrak{h}$ is the diagonal Cartan subalgebra of $\mathfrak{s l}_{3}(\mathbb{C})$ and $\mathfrak{S}_{3}$ is the symmetric group on 3 letters, viewed as the Weyl group of $\mathfrak{s l}_{3}(\mathbb{C})$. Let $\operatorname{Hilb}_{3}\left(\mathbb{C}^{2}\right)$ denote the Hilbert scheme of 3 points in $\mathbb{C}^{2}$, and let Hilb ${ }_{3}^{0}\left(\mathbb{C}^{2}\right)$ denote the (reduced) closed subscheme defined as the Hilbert scheme of three points in $\mathbb{C}^{2}$ whose sum is equal to $(0,0)$. By [10, Proposition 2.6],

$$
\begin{equation*}
\mathscr{X}_{3} \simeq \operatorname{Hilb}_{3}^{0}\left(\mathbb{C}^{2}\right) \tag{5.3}
\end{equation*}
$$

It just might be noticed that the isomorphism $\mathscr{Y}_{3} \simeq\left(\mathfrak{h} \times \mathfrak{h}^{*}\right) / \mathfrak{S}_{3}$ becomes $\mathbb{C}^{\times}$-equivariant if one "doubles the degrees" in $\left(\mathfrak{h} \times \mathfrak{h}^{*}\right) / \mathfrak{S}_{3}$, that is, if $\mathbb{C}^{\times}$acts on $\mathfrak{h}$ (respectively $\mathfrak{h}^{*}$ ) with weight 2 (respectively -2 ). Recall that $\mathbb{C}^{\times}$-fixed points in $\mathbf{H i l b}_{3}^{0}\left(\mathbb{C}^{2}\right)$ are parametrized by partitions of 3: we denote by $q_{3}^{+}, q_{3}^{\circ}$ and $q_{3}^{-}$the fixed points in $\mathscr{X}_{3}$ corresponding respectively to the partitions $(3),(2,1)$ and $(1,1,1)$ of 3 , so that

$$
\begin{equation*}
\mathscr{X}_{3}^{\mathbb{C}^{\times}}=\left\{q_{3}^{+}, q_{3}^{\circ}, q_{3}^{-}\right\} \tag{5.4}
\end{equation*}
$$

Finally, we have

$$
\begin{equation*}
\mathscr{X}^{\mathbb{C}^{\times}}=\left\{q_{2}^{+}, q_{2}^{-}, q_{3}^{+}, q_{3}^{\circ}, q_{3}^{-}, q_{4}, q_{6}\right\} \tag{5.5}
\end{equation*}
$$

Also, $\pi^{*}(\mathscr{H})=\alpha^{*}\left(\beta^{*}(\mathscr{H})\right)$ is an effective Cartier divisor of $\mathscr{X}$, and it follows from (\&) and the commutativity of the diagram 2.3 that

$$
i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathscr{X}}^{1}\left(\left[\pi^{*} \mathscr{H}\right]\right)\right)=-\hbar\left(6 \mathbf{e}_{q_{2}^{+}}+6 \mathbf{e}_{q_{2}^{-}}+12 \mathbf{e}_{q_{4}}+4 \mathbf{e}_{q_{6}}\right)
$$

We now wish to compute $i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathscr{X}}^{1}\left(\left[\alpha^{*} \mathscr{S}\right]\right)\right)$. As the singular locus $\mathscr{S}$ is contained in $\mathscr{Y}_{2} \cup \mathscr{Y}_{3}$, and contains $p_{2}$ and $p_{3}$, there exists $n_{2}^{+}, n_{2}^{-}, n_{3}^{+}, n_{3}^{\circ}$ and $n_{3}^{-}$in $\mathbb{Z}$ such that

$$
i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathscr{X}}^{1}\left(\left[\alpha^{*} \mathscr{S}\right]\right)\right)=-\hbar\left(n_{2}^{+} \mathbf{e}_{q_{2}^{+}}+n_{2}^{-} \mathbf{e}_{q_{2}^{-}}+n_{3}^{+} \mathbf{e}_{q_{3}^{+}}+n_{3}^{\circ} \mathbf{e}_{q_{3}^{\circ}}+n_{3}^{-} \mathbf{e}_{q_{3}^{-}}\right)
$$

Since $a_{+}$and $a_{-}$have degree 6 and -6 , it follows from (2.6) that $n_{2}^{+}=6$ and $n_{2}^{-}=-6$.
As we can exchange the roles of $\mathfrak{h}$ and $\mathfrak{h}^{*}$ in the description of $\mathscr{Y}_{3}$ and its singular locus (because $\mathfrak{h} \simeq \mathfrak{h}^{*}$ as an $\mathfrak{S}_{3}$-module), this shows that $n_{3}^{-}=-n_{3}^{+}$and $n_{3}^{\circ}=-n_{3}^{\circ}$. So $n_{3}^{\circ}=0$ and it remains to compute $n_{3}^{+}$. So let $U_{+}$be the open subset of $\mathbf{H i l b}_{3}^{0}\left(\mathbb{C}^{2}\right)$ consisting of ideals $J$ of codimension 3 of $\mathbb{C}[x, y]$ such that the classes of $1, x$ and $x^{2}$ form a basis of $\mathbb{C}[x, y] / J$. Then we have an isomorphism $J_{+}: \mathbb{C}^{4} \xrightarrow{\sim} U_{+}$given by

$$
(a, b, c, d) \longmapsto J_{+}(a, b, c, d)=\left\langle x^{3}+a x+b, y-c x^{2}-d x-\frac{2}{3} a c\right\rangle
$$

The form of the generators of the ideal $J_{+}(a, b, c, d)$ is here to ensure that $J_{+}(a, b, c, d) \in$ $\operatorname{Hilb}_{3}^{0}\left(\mathbb{C}^{2}\right)$. The fixed point $q_{3}^{+}$is the unique one in $U_{+}$. Through this identification, the action of $\mathbb{C}^{\times}$on $\mathbb{C}^{4}$ is given by

$$
\xi \cdot(a, b, c, d)=\left(\xi^{4} a, \xi^{6} b, \xi^{-6} c, \xi^{-4} d\right)
$$

(remember that we must "double the degrees" of the usual action). The equation of $\alpha^{*}(\mathscr{S})$ on this affine chart $\simeq \mathbb{C}^{4}$ can then be computed explicitly and is given by $4 a^{3}+27 b^{2}=0$, so is of degree 12 . This shows that $n_{3}^{+}=12$. Finally,

$$
\begin{equation*}
i_{\mathscr{X}}^{*}\left(\operatorname{ch}_{\mathscr{X}}^{1}\left(\left[\alpha^{*} \mathscr{S}\right]\right)\right)=-\hbar\left(6 \mathbf{e}_{q_{2}^{+}}-6 \mathbf{e}_{q_{2}^{-}}+12 \mathbf{e}_{q_{3}^{+}}-12 \mathbf{e}_{q_{3}^{-}}\right) \tag{0}
\end{equation*}
$$

Let us now conclude. First, recall from [5, Theorem 1.2] that

$$
\begin{cases}\mathrm{H}^{2 i+1}(\mathscr{X})=0 & \text { for all } i  \tag{5.6}\\ \mathrm{H}^{2 \bullet}(\mathscr{X}) \simeq \operatorname{gr}_{\mathscr{F}}(\mathrm{Z}(\mathbb{C} W)) .\end{cases}
$$

By Proposition 2.4, we get
( $\mathbf{~})$

$$
\operatorname{dim}_{\mathbb{C}} \mathrm{H}_{\mathbb{C}^{\times}}^{2 i}(\mathscr{X})= \begin{cases}1 & \text { if } i=0 \\ 3 & \text { if } i=1 \\ 7 & \text { if } i \geqslant 2\end{cases}
$$

Now, $W$ has seven irreducible characters $1, \varepsilon, \varepsilon^{2}, \chi, \chi \varepsilon, \chi \varepsilon^{2}$ and $\theta$, where $\chi$ is the unique irreducible character of degree 2 with rational values and $\theta$ is the unique one of degree 3. We denote by

$$
\Psi: \mathrm{H}_{\mathbb{C}^{\times}}^{2 \bullet}\left(\mathscr{X}^{\mathbb{C}^{\times}}\right) \xrightarrow{\sim} \mathbb{C}[[\hbar]] \otimes \mathrm{Z}(\mathbb{C} W)
$$

the isomorphism of $\mathbb{C}[[\hbar]]$-algebras such that

$$
\begin{gathered}
\Psi\left(\mathbf{e}_{q_{4}}\right)=e_{1}^{W}, \quad \Psi\left(\mathbf{e}_{q_{6}}\right)=e_{\theta}^{W}, \quad \Psi\left(\mathbf{e}_{q_{2}^{+}}\right)=e_{\chi \varepsilon}^{W}, \quad \Psi\left(\mathbf{e}_{q_{2}^{-}}\right)=e_{\chi \varepsilon^{2}}^{W}, \\
\Psi\left(\mathbf{e}_{q_{3}^{+}}\right)=e_{\varepsilon^{2}}^{W}, \quad \Psi\left(\mathbf{e}_{q_{3}^{\circ}}\right)=e_{\chi}^{W} \quad \text { and } \quad \Psi\left(\mathbf{e}_{q_{3}^{-}}\right)=e_{\varepsilon}^{W} .
\end{gathered}
$$

By Proposition 2.4, $\mathrm{H}_{\mathbb{C}^{\times}}^{2 \bullet}(\mathscr{X})$ is isomorphic to its image by $\Psi \circ i_{\mathscr{X}}^{*}$ in $\mathbb{C}[[\hbar]] \otimes \mathrm{Z}(\mathbb{C} W)$. But, by $(\diamond)$ and $(\diamond)$, and after investigation of the character table of $W$, this image contains

$$
\hbar\left(6 \mathbf{e}_{\chi \varepsilon}^{W}-6 \mathbf{e}_{\chi \varepsilon^{2}}^{W}+12 e_{1}^{W}+4 e_{\theta}^{W}\right)=\hbar\left(4+\Sigma_{W}(s)+\Sigma_{W}\left(s^{2}\right)\right)
$$

and

$$
\hbar\left(12 e_{\varepsilon^{2}}^{W}-12 e_{\varepsilon}^{W}+6 e_{\chi \varepsilon}-6 e_{\chi \varepsilon^{2}}\right)=\hbar\left((1+2 \zeta) \Sigma_{W}(s)+\left(1+2 \zeta^{2}\right) \Sigma_{W}\left(s^{2}\right)\right)
$$

So it contains $\hbar \Sigma_{W}(s)$ and $\hbar \Sigma_{W}\left(s^{2}\right)$. Also, by $(\boldsymbol{\phi})$ and Proposition 2.4, it also contains $\hbar^{2} Z(\mathbb{C} W)$, so

$$
\operatorname{Rees}_{\mathscr{F}}^{\bullet}(\mathrm{Z}(\mathbb{C} W)) \subset \operatorname{Im}\left(\Psi \circ i_{\mathscr{X}}^{*}\right)
$$

Using again ( $\boldsymbol{4}$ ) and Proposition 2.4, a comparison of dimensions yields that

$$
\operatorname{Rees}_{\mathscr{F}}^{\bullet}(\mathrm{Z}(\mathbb{C} W))=\operatorname{Im}\left(\Psi \circ i_{\mathscr{X}}^{*}\right)
$$

and the proof is complete.
