# ON DAVENPORT CONSTANT

#### Abstract

We prove that for every fixed integer $r \geqslant 1$ the Davenport constant $\mathrm{D}\left(C_{n}^{r}\right)$ is asymptotic to $r n$ when $n$ tends to infinity. An extension of this theorem to a wider framework is also provided.


For every integer $n \geqslant 1$, let $C_{n}$ be the cyclic group of order $n$. It is well known that every non-trivial finite Abelian group $G$ can be uniquely decomposed as a direct product of cyclic groups $C_{n_{1}} \oplus \cdots \oplus C_{n_{r}}$ such that $1<n_{1}|\cdots| n_{r} \in \mathbb{N}$. The integers $r$ and $n_{r}$-sometimes also denoted by $\exp (G)$ - appearing in this decomposition are respectively called the rank and exponent of $G$. For every integer $1 \leqslant d \mid \exp (G)$, we denote by $G_{d}$ the subgroup of $G$ consisting of all elements of order dividing $d$.

Any finite sequence $S$ of $\ell$ elements of $G$ will be called a sequence over $G$ of length $|S|=\ell$. Also, we denote by $\sigma(S)$ the sum of all elements in $S$. The sequence $S$ will be referred to as a zero-sum sequence whenever $\sigma(S)=0$.

By $\mathrm{D}(G)$ we denote the smallest integer $t \geqslant 1$ such that every sequence $S$ over $G$ of length $|S| \geqslant t$ contains a non-empty zero-sum subsequence. This number, which is called the Davenport constant, drew over the last fifty years an ever growing interest, most notably in additive combinatorics and algebraic number theory. A detailed account on the many aspects of this invariant can be found in $[8,10,13,17]$.

To name but one striking feature, let us recall the Davenport constant has the following arithmetical interpretation. Given the ring of integers $\mathcal{O}_{\mathbf{K}}$ of some number field $\mathbf{K}$ with ideal class group $G$, the maximum number of prime ideals in the decomposition of an irreducible element of $\mathcal{O}_{\mathbf{K}}$ is $\mathrm{D}(G)$ [22]. The importance of this fact is best highlighted by the following generalization of the prime number theorem [17, Theorem 9.15], stating that the number $F(x)$ of pairwise non-associated irreducible elements in $\mathcal{O}_{\mathbf{K}}$ whose norms do not exceed $x$ in absolute value satisfies,

$$
F(x) \underset{x \rightarrow+\infty}{\sim} C \frac{x}{\log x}(\log \log x)^{\mathrm{D}(G)-1},
$$

with a suitable constant $C>0$ depending solely on $G$.
We are thus naturally led to the problem of determining the exact value of $\mathrm{D}(G)$. The best explicit bounds known so far are

$$
\begin{equation*}
\sum_{i=1}^{r}\left(n_{i}-1\right)+1 \leqslant \mathrm{D}(G) \leqslant n_{r}\left(1+\log \frac{|G|}{n_{r}}\right) \tag{1}
\end{equation*}
$$

The lower bound follows easily from the fact that if $\left(e_{1}, \ldots, e_{r}\right)$ is a basis of $G$ such that $\operatorname{ord}\left(e_{i}\right)=n_{i}$ for all $i \in \llbracket 1, r \rrbracket$, the sequence $S$ consisting of $n_{i}-1$ copies of $e_{i}$ for each $i \in \llbracket 1, r \rrbracket$ contains no non-empty zero-sum subsequence. The upper bound first appeared in [7, Theorem 7.1] and was rediscovered in [16, Theorem 1]. See also [1, Theorem 1.1] for a reformulation of the proof's original argument as well as an application of the Davenport constant to the study of Carmichael numbers.
$\mathrm{D}(G)$ has been proved to match the lower bound in (1) when $G$ is either a $p$ group [18] or has rank at most 2 [19, Corollary 1.1]. Eventhough there are infinitely many finite Abelian groups whose Davenport constant is known to exceed this lower bound $[7,11,12,15]$, none of the ones identified so far either have rank 3 or the form

[^0]$C_{n}^{r}$. These two types of groups are still conjectured to have a Davenport constant matching the lower bound in (1).
Conjecture 1. For all integers $n, r \geqslant 1$,
$$
\mathrm{D}\left(C_{n}^{r}\right)=r(n-1)+1
$$

Besides the already mentioned results settling Conjecture 1 for all $r$ when $n$ is a prime power and for all $n$ when $r \leqslant 2$, note that $\mathrm{D}\left(C_{n}^{3}\right)$ is known only when $n=2 p^{\alpha}$, with $p$ prime and $\alpha \geqslant 1$ [6, Corollary 4.3], or $n=2^{\alpha} 3$ with $\alpha \geqslant 2$ [7, Corollary 5.1], and satisfies Conjecture 1 in both cases. To the best of our knowledge, the exact value of $\mathrm{D}\left(C_{n}^{r}\right)$ is currently unknown for all pairs $(n, r)$ such that $n$ is not a prime power and $r \geqslant 4$. In all those remaining cases, the bounds in (1) translate into

$$
\begin{equation*}
r(n-1)+1 \leqslant \mathrm{D}\left(C_{n}^{r}\right) \leqslant n(1+(r-1) \log n), \tag{2}
\end{equation*}
$$

which leaves a substantial gap to be bridged. Conjecture 1 thus remains wide open.
The aim of the present note is to clarify the behavior of $\mathrm{D}\left(C_{n}^{r}\right)$ for any fixed $r \geqslant 1$ when $n$ goes to infinity. Our main theorem proves Conjecture 1 in the following asymptotic sense.

Theorem 1. For every integer $r \geqslant 1$,

$$
\mathrm{D}\left(C_{n}^{r}\right) \underset{n \rightarrow+\infty}{\sim} r n .
$$

The proof of Theorem 1 relies on a new upper bound for $\mathrm{D}\left(C_{n}^{r}\right)$, turning out to be a lot sharper than the one in (2) for large values of $n$. So as to state it properly, we now make the following definition.

For every integer $n \geqslant 1$, we denote by $P(n)$ the greatest prime power dividing $n$, with the convention $P(1)=1$. In what follows, the key point will be that $P(n)$ tends to infinity when $n$ does so. Indeed, denoting by $\left(a_{i}\right)_{i \geqslant 1}$ the integer sequence of prime powers, let $\left(b_{n}\right)_{n \geqslant 1}$ be the integer sequence defined by $b_{n}=\prod_{a_{i} \leqslant n} a_{i}$ for all $n \geqslant 1$. By definition, for every integer $N \geqslant 1$, one has $P(n)>N$ as soon as $n>b_{N}$. Therefore, $P(n)$ tends to infinity when $n$ does so.

Theorem 2. For every integer $r \geqslant 1$, there exists a constant $d_{r} \geqslant 0$ such that for every integer $n \geqslant 1$,

$$
\mathrm{D}\left(C_{n}^{r}\right) \leqslant r(n-1)+1+d_{r}\left(\frac{n}{P(n)}-1\right)
$$

Now, since $P(n)$ tends to infinity when $n$ does so, Theorem 2 allows us to deduce that, for every integer $r \geqslant 1$, the gap between the Davenport constant and its conjectural value

$$
\partial\left(C_{n}^{r}\right)=\mathrm{D}\left(C_{n}^{r}\right)-(r(n-1)+1)
$$

is actually $o(n)$. This theorem will be obtained via the inductive method, which involves another key combinatorial invariant we now proceed to define.

By $\eta(G)$ we denote the smallest integer $t \geqslant 1$ such that every sequence $S$ over $G$ of length $|S| \geqslant t$ contains a non-empty zero-sum subsequence $S^{\prime} \mid S$ with $\left|S^{\prime}\right| \leqslant$ $\exp (G)$. It is readily seen that $\mathrm{D}(G) \leqslant \eta(G)$ for every finite Abelian group $G$.

A natural construction shows that, for all integers $n, r \geqslant 1$, one has

$$
\begin{equation*}
\left(2^{r}-1\right)(n-1)+1 \leqslant \eta\left(C_{n}^{r}\right) \tag{3}
\end{equation*}
$$

Indeed, if $\left(e_{1}, \ldots, e_{r}\right)$ is a basis of $C_{n}^{r}$, it is easily checked that the sequence $S$ consisting of $n-1$ copies of $\sum_{i \in I} e_{i}$ for each non-empty subset $I \subseteq \llbracket 1, r \rrbracket$ contains no non-empty zero-sum subsequence of length at most $n$.

The exact value of $\eta\left(C_{n}^{r}\right)$ is known to match the lower bound in (3) for all $n$ when $r \leqslant 2$ [13, Theorem 5.8.3], and for all $r$ when $n=2^{\alpha}$, with $\alpha \geqslant 1$ [14, Satz 1]. Besides these two results, $\eta\left(C_{n}^{r}\right)$ is currently known only when $r=3$ and $n=3^{\alpha} 5^{\beta}$, with $\alpha, \beta \geqslant 0\left[9\right.$, Theorem 1.7], in which case $\eta\left(C_{n}^{3}\right)=8 n-7$, or $n=2^{\alpha} 3$, with $\alpha \geqslant 1$ [9, Theorem 1.8], in which case $\eta\left(C_{n}^{3}\right)=7 n-6$. When $n=3$, note that the problem of finding $\eta\left(C_{3}^{r}\right)$ is closely related to the well-known cap-set problem, and that for $r \geqslant 4$, the only known values so far are $\eta\left(C_{3}^{4}\right)=39[20], \eta\left(C_{3}^{5}\right)=89$ [4] and $\eta\left(C_{3}^{6}\right)=223$ [21]. For more details on this fascinating topic, see $[3,5]$ and the references contained therein.

In another direction, Alon and Dubiner showed [2] that when $r$ is fixed, $\eta\left(C_{n}^{r}\right)$ grows linearly in the exponent $n$. More precisely, they proved that for every integer $r \geqslant 1$, there exists a constant $c_{r}>0$ such that for every integer $n \geqslant 1$,

$$
\begin{equation*}
\eta\left(C_{n}^{r}\right) \leqslant c_{r}(n-1)+1 \tag{4}
\end{equation*}
$$

From now on, we will identify $c_{r}$ with its smallest possible value in this theorem.
On the one hand, it follows from (3) that $c_{r} \geqslant 2^{r}-1$, for all $r \geqslant 1$. Since, as already mentioned, $\eta\left(C_{n}\right)=n$ and $\eta\left(C_{n}^{2}\right)=3 n-2$ for all $n \geqslant 1$, it is possible to choose $c_{1}=1$ and $c_{2}=3$, with equality in (4).

On the other hand, the method used in [2] yields $c_{r} \leqslant(c r \log r)^{r}$, where $c>0$ is an absolute constant, and it is conjectured in [2] that there actually is an absolute constant $d>0$ such that $c_{r} \leqslant d^{r}$ for all $r \geqslant 1$.

We can now state and prove our main technical result, which is the following.
Theorem 3. For all integers $n, r \geqslant 1$,

$$
\mathrm{D}\left(C_{n}^{r}\right) \leqslant r(n-1)+1+\left(c_{r}-r\right)\left(\frac{n}{P(n)}-1\right)
$$

Proof of Theorem 3. We set $G=C_{n}^{r}$ and denote by $H=G_{P(n)}$ the largest Sylow subgroup of $G$. Since $H \simeq C_{P(n)}^{r}$ is a $p$-group, it follows from [18] that

$$
\mathrm{D}(H)=r(P(n)-1)+1
$$

In addition, since the quotient group $G / H \simeq C_{n / P(n)}^{r}$ has rank $r$ and exponent $n / P(n)$, it follows from (4) that

$$
\eta(G / H) \leqslant c_{r}\left(\frac{n}{P(n)}-1\right)+1
$$

Now, from any sequence $S$ over $G$ such that

$$
|S| \geqslant \exp (G / H)(\mathrm{D}(H)-1)+\eta(G / H)
$$

one can sequentially extract at least $d=\mathrm{D}(H)$ disjoint non-empty subsequences $S_{1}^{\prime}, \ldots, S_{d}^{\prime} \mid S$ such that $\sigma\left(S_{i}^{\prime}\right) \in H$ and $\left|S_{i}^{\prime}\right| \leqslant \exp (G / H)$ for every $i \in \llbracket 1, d \rrbracket$. Since $T=\prod_{i=1}^{d} \sigma\left(S_{i}^{\prime}\right)$ is a sequence over $H$ of length $|T|=\mathrm{D}(H)$, there exists a non-empty subset $I \subseteq \llbracket 1, d \rrbracket$ such that $T^{\prime}=\prod_{i \in I} \sigma\left(S_{i}^{\prime}\right)$ is a zero-sum subsequence of $T$. Then, $S^{\prime}=\prod_{i \in I} S_{i}^{\prime}$ is a non-empty zero-sum subsequence of $S$.

Therefore, we have

$$
\begin{aligned}
\mathrm{D}(G) & \leqslant \exp (G / H)(\mathrm{D}(H)-1)+\eta(G / H) \\
& \leqslant \frac{n}{P(n)}(r(P(n)-1))+c_{r}\left(\frac{n}{P(n)}-1\right)+1 \\
& =r(n-1)+1+\left(c_{r}-r\right)\left(\frac{n}{P(n)}-1\right),
\end{aligned}
$$

which completes the proof.

Note that Theorem 3 is sharp for all $n$ when $r=1$ and for all $r$ when $n$ is a prime power. Also, Theorems 1 and 2 are now direct corollaries of Theorem 3.

Proof of Theorem 2. The result follows from Theorem 3 by setting $d_{r}=c_{r}-r$.
Proof of Theorem 1. Since $P(n)$ tends to infinity when $n$ does so, the desired result follows easily from (2) and Theorem 2.

To conclude this paper, we would like to offer a possibly useful extension of Theorem 3 to the following wider framework. Given any finite Abelian group $L$ and any integer $r \geqslant 1$, we consider the groups defined by $L_{n}^{r}=L \oplus C_{n}^{r}$, where $n \geqslant 1$ is any integer such that $\exp (L) \mid n$. Note that the case $L=\{0\}$ brings one back to $L_{n}^{r}=C_{n}^{r}$ whose Davenport constant is already covered by Theorem 3.

Our aim in this more general context is to prove that, for every finite Abelian group $L$ and every integer $r \geqslant 1, \mathrm{D}\left(L_{n}^{r}\right)$ behaves asymptotically in the same way it already does, according to Theorem 3, when $L$ is trivial. To do so, we establish the following theorem.

Theorem 4. Let $L \simeq C_{n_{1}} \oplus \cdots \oplus C_{n_{\ell}}$, with $1 \leqslant n_{1}|\cdots| n_{\ell} \in \mathbb{N}$, be a finite Abelian group. For every integer $n \geqslant 1$ such that $\exp (L) \mid n$ and every integer $r \geqslant 1$,

$$
\mathrm{D}\left(L_{n}^{r}\right) \leqslant r(n-1)+1+\left(c_{\ell+r}-r\right)\left(\frac{n}{P(n)}-1\right)+\frac{n}{P(n)} \sum_{i=1}^{\ell}\left(\operatorname{gcd}\left(n_{i}, P(n)\right)-1\right)
$$

Proof of Theorem 4. We set $G=L_{n}^{r}$ and $H=G_{P(n)}$. On the one hand, since $H \simeq C_{n_{1}^{\prime}} \oplus \cdots \oplus C_{n_{\ell}^{\prime}} \oplus C_{P(n)}^{r}$, with $n_{i}^{\prime}=\operatorname{gcd}\left(n_{i}, P(n)\right) \mid n_{i}$ for all $i \in \llbracket 1, \ell \rrbracket$ and $1 \leqslant n_{1}^{\prime}|\cdots| n_{\ell}^{\prime} \mid P(n)$, is a $p$-group, it follows from [18] that

$$
\mathrm{D}(H)=\sum_{i=1}^{\ell}\left(n_{i}^{\prime}-1\right)+r(P(n)-1)+1
$$

On the other hand, since the quotient group $G / H$ has exponent $n / P(n)$ and rank at most $\ell+r$, it follows from (4) that

$$
\eta(G / H) \leqslant \eta\left(C_{\frac{n}{\ell+r}}^{P(n)}\right) \leqslant c_{\ell+r}\left(\frac{n}{P(n)}-1\right)+1 .
$$

Therefore, just like in our proof of Theorem 3, we obtain

$$
\begin{aligned}
\mathrm{D}(G) & \leqslant \exp (G / H)(\mathrm{D}(H)-1)+\eta(G / H) \\
& \leqslant \frac{n}{P(n)}\left(\sum_{i=1}^{\ell}\left(n_{i}^{\prime}-1\right)+r(P(n)-1)\right)+c_{\ell+r}\left(\frac{n}{P(n)}-1\right)+1 \\
& =r(n-1)+1+\left(c_{\ell+r}-r\right)\left(\frac{n}{P(n)}-1\right)+\frac{n}{P(n)} \sum_{i=1}^{\ell}\left(n_{i}^{\prime}-1\right)
\end{aligned}
$$

which is the desired upper bound.
Theorem 5. For every finite Abelian group $L$ and every integer $r \geqslant 1$,

$$
\mathrm{D}\left(L_{n}^{r}\right) \underset{\substack{n \rightarrow+\infty \\ \exp (L) \mid n}}{\sim} r n .
$$

Proof of Theorem 5. We write $L \simeq C_{n_{1}} \oplus \cdots \oplus C_{n_{\ell}}$, with $1 \leqslant n_{1}|\cdots| n_{\ell} \in \mathbb{N}$. For every integer $n \geqslant 1$ such that $\exp (L) \mid n$, one has $\operatorname{gcd}\left(n_{i}, P(n)\right) \leqslant n_{i}$ for all $i \in \llbracket 1, \ell \rrbracket$. Since $P(n)$ tends to infinity when $n$ does so, the result follows easily from (1) and Theorem 4.
